A SMOOTH INTRINSIC FLAT LIMIT WITH NEGATIVE CURVATURE

ABSTRACT. In 2014, Gromov asked if nonnegative scalar curvature is preserved under intrinsic flat convergence. Here we construct a sequence of closed oriented Riemannian *n*-manifolds, $n \ge 3$, with positive scalar curvature such that their intrinsic flat limit is a Riemannian manifold with negative scalar curvature.

1. INTRODUCTION

In 2014, Gromov [1] asked if nonnegative scalar curvature is preserved under intrinsic flat convergence. In particular, one can ask the following question.

Question. Let (M_i^n, g_i) , $i \ge 1$, and (M_{∞}, g_{∞}) be closed Riemannian manifolds such that M_i converges to M_{∞} in some sense. Assume (M_i, g_i) , for all i, have nonnegative scalar curvature. Then does (M_{∞}, g_{∞}) also have nonnegative scalar curvature?

Gromov [2] and Bamler [3] have given a positive answer to the above question when the convergence is C^0 -convergence. To show this result, Gromov studied the Dirac operator and a generalized Plateau problem in Riemannian manifolds with corners. Bamler studied the evolution of scalar curvature under Ricci flow to provide a different proof. Lee and Topping showed that the answer to the question is negative when the convergence is uniform convergence of distance functions or when the convergence is Gromov–Hausdorff (GH) convergence [4]. Explicitly, Lee and Topping construct a sequence of Riemannian metrics on \mathbb{S}^n , $n \geq 4$, with positive scalar curvature that converges to a Riemannian metric which is conformal to the unit round metric on \mathbb{S}^n and has negative scalar curvature.

In this note, we study the question in the setting of Sormani–Wenger intrinsic flat (\mathcal{F}) convergence [5]. We construct a sequence of Riemannian manifolds with positive scalar curvature which converges in the \mathcal{F} -sense to a Riemannian manifold with negative scalar curvature. This provides an answer to Gromov's question from [1]. In comparison with Lee and Topping's result [4], our limit manifold need not be conformal to the unit round sphere and we produce examples in dimensions $n \geq 3$. Specifically,

Theorem A. Let $n \geq 3$ and g be a Riemannian metric on the standard smooth n-sphere with negative Ricci curvature. Then there exists a $\kappa > 0$ and a sequence (M_j^n, g_j) of closed oriented Riemannian n-manifolds with scalar curvature $R_{g_j} > \kappa$ such that the corresponding integral current spaces, $(M_j, d_{g_j}, [M_j])$, converge in the \mathcal{F} -sense to $(\mathbb{S}^n, d_g, [\mathbb{S}^n])$, the integral current space associated to (\mathbb{S}^n, g) .

In fact, Theorem A follows as a corollary of the following theorem.

Theorem B. Let $\kappa \in \mathbb{R}$, $n \geq 3$, and (M^n, g) be a closed oriented manifold with scalar curvature $R_g \geq \kappa$ and for $c \in (0, 1)$ let $d: M \times M \to [0, \infty)$ be a distance function on M such that

$$cd_{q}(x,y) \leq d(x,y) < d_{q}(x,y)$$

where d_g is the induced distance function from the Riemannian metric. Then there exists a sequence of Riemannian manifolds (M_j^n, g_j) with scalar curvature $R_{g_j} \ge \kappa - \frac{1}{j}$ such that

$$d_{\mathcal{F}}\left(\left(M_{j}, d_{g_{j}}, \llbracket M_{j} \rrbracket\right), (M, d, \llbracket M \rrbracket)\right) \xrightarrow{j \to \infty} 0.$$

In the statement of Theorem B, the inequality hypothesis can be equivalently phrased as the identity map from (M, d_g) to (M, d) is distance decreasing and bilipschitz. In Section 5, we prove a slight generalization of Theorem B where one can take any distance decreasing biLipschitz map from (M, d_g) to a metric space (X, d) and get the analogous result.

Another corollary states that for the collection of closed oriented Riemannian *n*-manifolds, $n \ge 3$, the subcollection of closed oriented Riemannian *n*-manifolds, $n \ge 3$, with scalar curvature $R_{g_j} \ge -1$ is dense in the intrinsic flat topology.

Corollary C. Let $n \geq 3$ and (M^n, g) be a closed oriented Riemannian n-manifold. Then there exists a sequence (M_j^n, g_j) of closed oriented manifolds with scalar curvature $R_{g_j} \geq -1$ that converge in the \mathcal{F} -sense to the integral current space associated to the Riemannian manifold (M^n, g) , i.e.,

$$d_{\mathcal{F}}\left(\left(M_{j}, d_{g_{j}}, \llbracket M_{j} \rrbracket\right), (M, d_{g}, \llbracket M \rrbracket)\right) \xrightarrow{\mathcal{I} \to \infty} 0.$$

The main technical tool (see Proposition 4.5 below) used in the proofs of these results is a generalization of a theorem of Basilio, Kazaras, and Sormani [6, Theorem 3.1]. Our approach allows for any closed oriented Riemannian manifold in contrast to Basilio, Kazaras, and Sormani who only dealt with the standard unit round *n*-sphere. This generalization allows us to prove Theorem B from which our other results follow.

The main idea of the proof of Theorem B is to add many tunnels to (M^n, g) which approximates the distances with respect to d. This construction is a generalization of the construction in [6], where Basilio, Kazaras, and Sormani constructed a sequence of positive scalar curvature manifolds whose \mathcal{F} -limit is not locally geodesic. It turns out that their example ([6, Theorem 1.1]) also follows from Theorem B. Moreover, to maintain control of the scalar curvature, diameter, and volume of the added tunnels we use a quantitative Gromov–Lawson Schoen–Yau tunnel construction [7].

3. Background

In this section, we will review Sormani–Wenger intrinsic flat distance between two integral current spaces. Sormani and Wenger [5] defined intrinsic flat distance, which generalizes the notion of flat distance for currents in Euclidean space. To do so they used Ambrosio and Kirchheim's generalization of Federer and Fleming's integral currents to metric spaces. We refer the reader to [8] for further details about currents in arbitrary metric spaces and to [5] for further details about integral current spaces and intrinsic flat distance.

Let (Z, d^Z) be a complete metric space. Denote by Lip (Z) and Lip_b (Z) the set of real-valued Lipschitz functions on Z and the set of bounded real-valued Lipschitz functions on Z.

Definition 3.1 ([8], Definition 3.1). We say a multilinear functional

$$T: \operatorname{Lip}_b(Z) \times [\operatorname{Lip}(Z)]^m \to \mathbb{R}$$

on a complete metric space (Z, d^Z) is an m-dimensional current if it satisfies the following properties.

i Locality: $T(f, \pi_1, \ldots, \pi_m) = 0$ if there exists and *i* such that π_i is constant on a neighborhood of $\{f \neq 0\}$. *ii* Continuity: *T* is continuous with respect to pointwise convergence of π_i such that $\text{Lip}(\pi_i) \leq 1$.

iii Finite mass: there exists a finite Borel measure μ on X such that

$$|T(f,\pi_1,\ldots,\pi_m)| \le \prod_{i=1}^m \operatorname{Lip}(\pi_i) \int_Z |f| d\mu$$
(1)

for any $(f, \pi_1, ..., \pi_m)$.

We call the minimal measure satisfying (1) the mass measure of T and denote it ||T||. We can now define many concepts related to a current. $\mathbf{M}(T) = ||T||(Z)$ is defined to be the mass of T and the canonical set of a *m*-current T on Z is

set
$$(T) = \left\{ p \in Z \mid \liminf_{r \to 0} \frac{||T|| (B(p,r))}{r^m} > 0 \right\}.$$

We note that ||T|| is mutually absolutely continuous with the Hausdorff measure of $(\text{set}(T), d^Z)$. The boundary of a current T is defined as $\partial T : \text{Lip}_b(X) \times [\text{Lip}(X)]^{m-1} \to \mathbb{R}$, where

$$\partial T(f, \pi_1, \dots, \pi_{m-1}) = T(1, f, \pi_1, \dots, \pi_{m-1}).$$

Given a Lipschitz map $\phi: Z \to Z'$, we can pushforward an *m*-current *T* on *Z* to an *m*-current $\phi_{\#}T$ on *Z'* by defining

$$\phi_{\#}T(f,\pi_1,\ldots,\pi_m)=T(f\circ\phi,\pi_1\circ\phi,\ldots,\pi_m\circ\phi).$$

We note that $||\phi_{\#}T|| \leq (\operatorname{Lip} \phi)^m \phi_{\#}||T||$ and $\phi_{\#}(\partial T) = \partial (\phi_{\#}T)$.

A standard example of an m-current on Z is given by

$$\phi_{\#} \llbracket \theta \rrbracket (f, \pi_1, \dots, \pi_m) = \int_A (\theta \circ \phi) (f \circ \phi) d(\pi_1 \circ \phi) \wedge \dots \wedge d(\pi_m \circ \phi),$$

where $\phi : \mathbb{R}^m \to Z$ is bi-Lipschitz and $\theta \in L^1(A, \mathbb{Z})$. We say that an *m*-current on Z is integer rectifiable if there is a countable collection of bi-Lipschitz maps $\phi_i : A_i \to X$ where $A_i \subseteq \mathbb{R}^m$ are precompact Borel measurable with pairwise disjoint images and weight functions $\theta_i \in L^1(A, \mathbb{Z})$ such that

$$T = \sum_{i=1}^{\infty} \phi_{i\#} \left[\!\left[\theta_i\right]\!\right].$$

Moreover, we say an integer rectifiable current whose boundary is also integer rectifiable is an integral current. We denote the space of integral *m*-currents on Z as $\mathbf{I}_m(Z)$. We say that the triple (X, d, T) is an *m*-dimensional integral current space if (X, d) is a metric space, $T \in \mathbf{I}_m(\bar{X})$ where \bar{X} is the metric completion of X, and set (T) = X.

Example 3.2. Let (M^n, g) be a closed oriented Riemannian manifold. Then there is a naturally associated *n*-dimensional integral current space $(M, d_g, \llbracket M \rrbracket)$, where d_g is the distance function induced by the metric g and $\llbracket M \rrbracket$: Lip $_b(M) \times [\text{Lip}(M)]^n \to \mathbb{R}$ is given by

$$\llbracket M \rrbracket = \sum_{i,j} \psi_{i\#} \llbracket \mathbb{1}_{A_{ij}} \rrbracket$$

where we have chosen a smooth locally finite atlas $\{(U_i, \psi_i)\}_{i \in \mathbb{N}}$ of M consisting of positively oriented biLipschitz charts, $\psi_i : U_i \subseteq \mathbb{R}^n \to M$ and A_{ij} are precompact Borel sets such hat $\psi_i(A_{ij})$ have disjoint images for all i, j and cover $M \mathscr{H}^n$ -a.e. In this case $||[[M]]|| = \operatorname{dvol}_g$. We note that (M, d, [[M]]) is also an integral current space when the identity map from (M, d_g) to (M, d) is biLipschitz.

The flat distance between two integral currents $T_1, T_2 \in \mathbf{I}(Z)$ is

$$d_{F}^{Z}(T_{1}, T_{2}) = \inf\{\mathbf{M}(U) + \mathbf{M}(V) \mid U \in \mathbf{I}_{m}(X), V \in \mathbf{I}_{m+1}(X), T_{2} - T_{1} = U + \partial V\}$$

The intrinsic flat (\mathcal{F}) distance between two integral current spaces (X_1, d_1, T_1) and (X_2, d_2, T_2) is

$$d_{\mathcal{F}}\left(\left(X_{1}, d_{1}, T_{1}\right), \left(X_{2}, d_{2}, T_{2}\right)\right) = \inf_{Z} \{d_{F}^{Z}\left(\phi_{1\#}T_{1}, \phi_{2\#}T_{2}\right)\},\$$

where the infimum is taken over all complete metric spaces (Z, d^Z) and isometric embeddings $\phi_1 : (\bar{X}_1, d_1) \rightarrow (Z, d^Z)$ and $\phi_2 : (\bar{X}_2, d_2) \rightarrow (Z, d^Z)$. We note that if (X_1, d_1, T_1) and (X_2, d_2, T_2) are precompact integral current spaces such that

$$d_{\mathcal{F}}((X_1, d_1, T_1), (X_2, d_2, T_2)) = 0$$

then there is a current preserving isometry between (X_1, d_1, T_1) and (X_2, d_2, T_2) , i.e., there exists an isometry $f: X_1 \to X_2$ whose extension $\overline{f}: \overline{X}_1 \to \overline{X}_2$ pushes forward the current: $\overline{f}_{\#}T_1 = T_2$. We say a sequence of (X_j, d_j, T_j) precompact integral current spaces converges to $(X_{\infty}, d_{\infty}, T_{\infty})$ in the \mathcal{F} -sense if

$$d_{\mathcal{F}}\left(\left(X_{j}, d_{j}, T_{j}\right), \left(X_{\infty}, d_{\infty}, T_{\infty}\right)\right) \to 0.$$

If, in addition, $\mathbf{M}(T_i) \to \mathbf{M}(T_{\infty})$, then we say (X_j, d_j, T_j) converges to $(X_{\infty}, d_{\infty}, T_{\infty})$ in the volume preserving intrinsic flat (\mathcal{VF}) sense. Lakzian and Sormani in [9, Theorem 4.6] were able to estimate the intrinsic flat distance between two manifolds: **Theorem 3.3.** Suppose $M_1^n = (M^n, g_1)$ and $M_2^n = (M^n, g_2)$ are oriented precompact Riemannian manifolds with diffeomorphic subregions $U_j \subset M_j^n$ and diffeomorphisms $\psi_j : U \to U_j$ such that for all $v \in TU$ we have

$$\frac{1}{(1+\epsilon)^2}\psi_1^*g_1(v,v) < \psi_2^*g_2(v,v) < (1+\epsilon)^2\psi_1^*g_1(v,v).$$

We define the following quantities

(1) $D_{U_j} = \sup\{\operatorname{diam}_{M_j}(W) : W \text{ is a component of } U_j\}.$

- (2) Let $a \in \mathbb{R}_+$ be such that $a > \frac{\arccos(1+\epsilon)^{-1}}{\pi} \max\{D_{U_1}, D_{U_2}\}.$ (3) $\lambda = \sup_{x,y \in U} |d_{M_1}(\psi_1(x), \psi_1(y)) d_{M_2}(\psi_2(x), \psi_2(y))|.$
- (4) $h = \sqrt{\lambda \left(\max\{D_{U_1}, D_{U_2}\} + \frac{\lambda}{4} \right)}.$
- (5) $\bar{h} = \max\left\{h, \sqrt{\epsilon^2 + 2\epsilon}D_{U_1}, \sqrt{\epsilon^2 + 2\epsilon}D_{U_2}\right\}.$

Then the intrinsic flat distance between M_1^n and M_2^n is bounded:

$$d_{\mathcal{F}}(M_1, M_2) \leq (2\bar{h} + a) \left(\operatorname{vol}_m(U_1) + \operatorname{vol}_m(U_2) + \operatorname{vol}_{m-1}(\partial U_1) + \operatorname{vol}_{m-1}(\partial U_2) \right) + \operatorname{vol}_m(M_1 \setminus U_1) + \operatorname{vol}_m(M_2 \setminus U_2).$$

Lastly, we want to record the following theorem from Huang, Lee, and Sormani [10, Theorem A.1].

Theorem 3.4. Fix a precompact n-dimensional integral current space (X, d_0, T) without boundary (e.g. $\partial T = 0$) and fix $\alpha > 0$. Suppose that d_i are metrics on X such that

$$\alpha \ge \frac{d_j(x,y)}{d_0(x,y)} \ge \frac{1}{\alpha}.$$
(2)

Then there exists a subsequence, also denoted d_i , and a metric d_{∞} satisfying (2) such that d_i converges uniformly to d_{∞} . That is

$$\epsilon_j := \sup\left\{ \left| d_j\left(x, y\right) - d_\infty\left(x, y\right) \right| : x, y \in X \right\} \xrightarrow{j \to \infty} 0.$$

Furthermore,

$$\lim_{j \to \infty} d_{\mathcal{F}}\left(\left(X, d_j, T \right), \left(X, d_{\infty}, T \right) \right) = 0.$$

In particular, (X, d_{∞}, T) is an integral current space and set (T) = X. In fact,

$$d_{\mathcal{F}}\left(\left(X, d_{j}, T\right), \left(X, d_{\infty}, T\right)\right) \leq 2^{\frac{n+3}{2}} \alpha^{n+1} \mathbf{M}_{\left(X, d_{0}\right)}\left(T\right) \epsilon_{j}.$$

4. Proof of the Main Results

The pipe filing technique was first used by Sormani in the appendix of [5] and was clarified and expanded upon in [6]. Here we will use this technique to expand upon the construction in [6]. First, we introduce the improved Gromov–Lawson Schoen–Yau tunnels from [7] which will be used to improve the construction in [6].

Proposition 4.1 (Constructing Tunnels). Let (M^n, g) , $n \geq 3$ be a Riemannian manifold with scalar curvature R_g . Let $\kappa \in \mathbb{R}$, $\ell \ge 0$, $j \ge 1$, $p_i \in M$, i = 1, 2, and $\delta \in \left(0, \frac{1}{10} \min\{ \inf_{j_1}, \inf_{j_2} \}\right)$, where \inf_i is the injectivity radius of M at p_i . Assume $R_g \ge \kappa$ on $B_i = B_{p_i}^M(2\delta) \subseteq M$ and $B_1 \cap B_2 = \emptyset$. Then there exists a complete Riemannian metric \overline{g} on the smooth manifold P^n , which is obtained by removing B_i from M and gluing in a cylindrical region $(T_{\delta,\ell}, g_{\delta,\ell})$ diffeomorphic to $\mathbb{S}^{n-1} \times [0,1]$, i.e

$$P = (M \setminus (B_1 \cup B_2)) \sqcup T_{\delta,\ell}$$

such that the following properties are satisfied.

- (1) The metrics q_i agree with \bar{q} on $M \setminus B_i$.
- (2) There exists constant A > 0 independent of δ and ℓ such that

$$\ell < \operatorname{diam}(T_{\delta,\ell}) < A\delta + \ell \quad and \quad \operatorname{vol}(T_{\delta}) < A\left(\delta^n + \ell\delta^{n-1}\right).$$

(3) P has scalar curvature $R_{\bar{g}} > \kappa - \frac{1}{i}$.

4.1. **Definition of** \mathcal{M}_{ρ} , $\widetilde{\mathcal{M}}_{\rho}$, \mathcal{M}_{0} , and $\widetilde{\mathcal{M}}_{0,\rho}$. Now we will define four integral current spaces \mathcal{M}_{ρ} , $\widetilde{\mathcal{M}}_{\rho}$, \mathcal{M}_{0} , and $\widetilde{\mathcal{M}}_{0,\rho}$ used in the proof of Theorem B. Roughly speaking, \mathcal{M}_{ρ} is M with two small balls removed and a tunnel glued in, $\widetilde{\mathcal{M}}_{\rho}$ is M with two small balls removed, added annular buffer regions in which the metric \tilde{g} transitions to the round metric, and a tunnel connecting the round boundaries. Lastly, \mathcal{M}_{0} and $\widetilde{\mathcal{M}}_{0,\rho}$ correspond to copies of (M,g) and (M,\tilde{g}) with strings in place of tunnels.

Let (M^n, g) be a closed oriented Riemannian manifold with scalar curvature $R_g \ge \kappa$. Let $p, q \in M$ and $\rho \le inj^M$. Thus, $B_p^M(\rho), B_q^M(\rho)$ are geodesic balls. Now define

$$W = M \setminus \left(B_p^M\left(\rho\right) \cup B_q^M\left(\rho\right) \right) \tag{3}$$

Now we want to glue in small geodesic balls from the unit round *n*-sphere. Let g_{τ}^{m} be the round metric on the *m*-sphere of radius τ .

Recall that the metric g on $B_p^M(\rho) \setminus B_p^M\left(\frac{9}{10}\rho\right)$ can be expressed via polar coordinates in the form $dr^2 + g_r$ for $\frac{9}{10}\rho \leq r \leq \rho$. Let $\phi: [0,1] \to [0,1]$ be a smooth increasing function such that

$$\phi\left(t\right) = \begin{cases} 0 & t \in \left[0, \frac{1}{4}\right] \\ 1 & t \in \left[\frac{3}{4}, 1\right]. \end{cases}$$

Define $\psi(t) = \phi\left(\frac{10}{\rho}\left(t - \frac{9}{10}\rho\right)\right)$ and let $g_{B_p^M(\rho)}$ be the following smooth Riemannian metric on $B_p^M(\rho)$

$$g_{B_p^M} = \begin{cases} dr^2 + \sin^2\left(r\right)g_1^{n-1} & r \in \left[0, \frac{9}{10}\rho\right] \\ dr^2 + \psi\left(r\right)\left(g_r - \sin^2\left(r\right)g_1^{n-1}\right) + \sin^2\left(r\right)g_1^{n-1} & r \in \left[\frac{9}{10}\rho, \rho\right], \end{cases}$$
(4)

where $dr^2 + g_r$ are polar coordinates centered around p in (M, g). Similarly, we can do the same procedure for q. Let $g_{B_a^M(\rho)}$ be the following smooth Riemannian metric on $B_q^M(\rho)$.

$$g_{B_q^M} = \begin{cases} dr^2 + \sin^2\left(r\right)g_1^{n-1} & r \in \left[0, \frac{9}{10}\rho\right] \\ dr^2 + \psi\left(r\right)\left(g_r - \sin^2\left(r\right)g_1^{n-1}\right) + \sin^2\left(r\right)g_1^{n-1} & r \in \left[\frac{9}{10}\rho, \rho\right], \end{cases}$$
(5)

where $dr^2 + g_r$ are polar coordinates centered around q in (M, \tilde{g}) . Now we can glue $\left(B_p^M, g_{B_p^M}\right)$ and $\left(B_q^M, g_{B_q^M}\right)$ into W resulting in the smooth manifold

$$\left(M = W \sqcup B_p^M\left(\rho\right) \sqcup B_q^M\left(\rho\right), \tilde{g}\right).$$
(6)

Remark 4.2. The metric \tilde{g} on M implicitly depends on ρ .

Fix $0 < \ell < d_g(p,q)$ and $\delta < \min\left\{\frac{1}{2}\rho, \rho_0\right\}$ for some ρ_0 we will choose in Lemma 4.4. We do this so that $\ell < d_{\tilde{g}}(p,q)$ automatically. Before we show Lemma 4.4, we first recall from [11, Lemma 2.1] (cf. [12, Lemma 1]), the following lemma:

Lemma 4.3. Let (M^n, g) be a Riemannian manifold. The principal curvatures of the hypersurface $\mathbb{S}^{n-1}(\epsilon)$ in a geodesic ball $B \subset M$ are each of the form $\frac{1}{-\epsilon} + O(\epsilon)$ for small ϵ . Furthermore, let g_{ϵ} be the induced metric on $\mathbb{S}^{n-1}(\epsilon)$ and recall g_{ϵ}^n is the round metric of radius ϵ . Then, as $\epsilon \to 0$, $\frac{1}{\epsilon^2}g_{\epsilon} \to \frac{1}{\epsilon^2}g_{rd,\epsilon} = g_{rd}$ in the C^2 topology, moreover, one can fix a C^2 -norm $|\cdot|_2$ where $|g_{rd} - \frac{1}{\epsilon^2}g_{\epsilon}|_2 \leq \epsilon^2$.

Lemma 4.4. Consider (M,g) and (M,\tilde{g}) defined above and assume $0 < \ell < d_g(p,q)$. Then there exists $\rho_0 > 0$ such that for any $0 < \rho < \rho_0$ we have $\ell < d_{\tilde{g}}(p,q)$.

Proof. Recall that \tilde{g} implicitly depends on ρ . Only in this proof will we highlight this and denote \tilde{g} as \tilde{g}^{ρ} . We will show that \tilde{g}^{ρ} converges to g in the C^2 -topology. Specifically, we note on W we have $g = \tilde{g}^{\rho}$; therefore, we consider g and \tilde{g}^{ρ} on $B_p^M(\rho)$ and $B_q^M(\rho)$. On $B_p^M(\rho)$ we have

$$|\tilde{g}^{\rho} - g| = \begin{cases} 0, & r \in \left[0, \frac{9}{10}\rho\right] \\ \left|\psi\left(r\right)\left(g_r - \sin^2\left(r\right)g_1^{n-1}\right) + \sin^2\left(r\right)g_1^{n-1} - g_r\right|, & r \in \left[\frac{9}{10}\rho, \rho\right]. \end{cases}$$
(7)

Therefore, we see that

$$\begin{aligned} |\tilde{g}^{\rho} - g| &\leq \left| \psi\left(r\right) \left(g_{r} - \sin^{2}\left(r\right) g_{1}^{n-1}\right) + \sin^{2}\left(r\right) g_{1}^{n-1} - g_{r} \right|_{2} \\ &\leq 2 \left| \sin^{2}\left(r\right) g_{1}^{n-1} - g_{r} \right|_{2} \\ &\leq 2 \left(\left| \sin^{2}\left(r\right) g_{1}^{n-1} - r^{2} g_{1}^{n-1} \right|_{2} + \left| r^{2} g_{1}^{n-1} - g_{r} \right|_{2} \right) \\ &\leq 2 r^{2} \left(\left| \frac{\sin^{2}\left(r\right)}{r^{2}} g_{1}^{n-1} - g_{1}^{n-1} \right|_{2} + \left| g_{1}^{n-1} - \frac{1}{r^{2}} g_{r} \right|_{2} \right) \\ &\leq A \rho^{4}, \end{aligned}$$

$$(8)$$

where the first inequality follows since $|\psi(r)| \leq 1$ and the last inequality follows by Lemma 4.3 and the fact g_r are metrics on geodesics spheres of radius less than ρ . Likewise, one can show the same inequality on $B_q^M(\rho)$. Therefore, we have that $d_{\tilde{g}^{\rho}}$ converges uniformly to d_g . Thus, concluding the proof.

By Proposition 4.1, there is a Riemannian manifold

$$\left(M_{\rho} = M \setminus \left(B_{p}^{M}\left(\delta\right) \cup B_{q}^{M}\left(\delta\right)\right) \cup T_{\delta,\ell}, g_{\rho}\right).$$

$$\tag{9}$$

Moreover, we choose j in Proposition 4.1 such that $j := j(\rho) \xrightarrow{\rho \to 0} \infty$. Thus, the scalar curvature is larger than $\kappa - \frac{1}{j(\rho)}$. And define the integral current space

$$\mathcal{M}_{\rho} = \left(M_{\rho}, d_{g_{\rho}}, \llbracket M_{\rho} \rrbracket \right)$$

Again by Proposition 4.1, there is a Riemannian metric on

$$\left(\widetilde{M}_{\rho} = M \setminus \left(B_{p}^{M}\left(\delta\right) \cup B_{q}^{M}\left(\delta\right)\right) \cup \widetilde{T}_{\delta,\ell}, \widetilde{g}_{\rho}\right).$$

$$(10)$$

And define the integral current space

$$\widetilde{\mathcal{M}}_{\rho} = \left(\widetilde{M}_{\rho}, d_{\widetilde{g}_{\rho}}, \left[\!\left[\widetilde{M}_{\rho}\right]\!\right]\right).$$

Now let (M_0, d_0) denote the metric space obtained by joining p and q in (M, g) by a line segment $I_{\ell} = [0, \ell]$ of length ℓ :

$$M_0 = M \sqcup_{p \sim 0, q \sim d} I_\ell.$$

We note that there is natural embedding $i: M \to M_0$. Define the integral current space

$$\mathcal{M}_0 = (M, d_0, \llbracket M \rrbracket) \,.$$

Now let $(\widetilde{M}_{0,\rho}, \widetilde{d}_{0,\rho})$ denote the metric space obtained by joining p and q in (M, \widetilde{g}) by a line segment $I_{\ell} = [0, \ell]$ of length ℓ :

$$M_{0,\rho} = M \sqcup_{p \sim 0, q \sim d} I_{\ell}.$$

We note that as sets $\widetilde{M}_{0,\rho}$ and M_0 are the same. Also, there is natural embedding $i: M \to \widetilde{M}_0$. Define the integral current space

$$\widetilde{\mathcal{M}}_{0,\rho} = \left(M, \widetilde{d}_{0,\rho}, \llbracket M \rrbracket \right).$$

4.2. \mathcal{M}_0 and \mathcal{M}_{ρ} are close. The following is the generalization of [6, Theorem 3.1].

Proposition 4.5. Let \mathcal{M}_0 and \mathcal{M}_{ρ} be defined as above. Then there exists a constant A > 0, depending only on ℓ and g such that

$$d_{\mathcal{F}}\left(\mathcal{M}_{0},\mathcal{M}_{\rho}\right) \leq A\sqrt{\rho}.$$
(11)

Proof. By the triangle inequality, we have that

$$d_{\mathcal{F}}\left(\mathcal{M}_{\rho},\mathcal{M}_{0}\right) \leq d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{\rho},\mathcal{M}_{\rho}\right) + d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{\rho},\widetilde{\mathcal{M}}_{0,\rho}\right) + d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{0,\rho},\mathcal{M}_{0}\right)$$

By our construction, we can apply [6, Theorem 3.1], to see there is a constant A > 0 depending only on ℓ , $\operatorname{vol}_g(M)$, and $\operatorname{diam}_g(M)$ such that

$$d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{\rho},\widetilde{\mathcal{M}}_{0,\rho}\right) \leq A\rho.$$
(12)

Claim 1. There is a constant A > 0 depending only on ℓ and g such that

$$d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{\rho}, \mathcal{M}_{\rho}\right) \leq A\sqrt{\rho}$$

Proof of Claim 1. Recall that W is a subset of \widetilde{M}_{ρ} , M_{ρ} , and M. Moreover, W has the same induced metric in each. Define:

$$\lambda = \sup_{x,y \in W} |d_{M_{\rho}}(x,y) - d_{\widetilde{M}_{\rho}}(x,y)|$$

$$h = \sqrt{\lambda \left(\operatorname{diam}\left(W\right) + \frac{\lambda}{4}\right)}$$
(13)

By [9, Theorem 4.6] (see Theorem 3.3 above) and Proposition 4.1,

$$d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{\rho}, \mathcal{M}_{\rho}\right) \leq (2h+\rho) \left(\operatorname{vol}_{g}\left(W\right) + \operatorname{vol}_{\widetilde{g}}\left(W\right) + \operatorname{vol}_{g}\left(\partial W\right) + \operatorname{vol}_{\widetilde{g}}\left(\partial \widetilde{W}\right)\right) \\ + \operatorname{vol}_{g}\left(M \setminus W\right) + \operatorname{vol}_{\widetilde{g}}\left(M \setminus \widetilde{W}\right). \\ \leq (2h+\rho) \left(2\operatorname{vol}_{g}\left(M\right) + A\rho^{n-1}\right) + A\rho^{n-1}.$$

All that is left is to estimate h which we will do by estimating λ . Let $x, y \in W$ and let γ and $\tilde{\gamma}$ be geodesics between x, y in M_{ρ} and \widetilde{M}_{ρ} respectively. Let $C = M_{\rho} \setminus W$ and $\widetilde{C} = \widetilde{M}_{\rho} \setminus W$. Thus,

$$d_{M_{\rho}}(x,y) - d_{\widetilde{M}_{\rho}}(x,y) = \operatorname{length}_{M_{\rho}}(\gamma) - \operatorname{length}_{\widetilde{M}_{\rho}}(\widetilde{\gamma})$$

$$\leq \operatorname{length}_{M_{\rho}}(\widetilde{\gamma}) - \operatorname{length}_{\widetilde{M}_{\rho}}(\widetilde{\gamma})$$

$$= \operatorname{length}_{M_{\rho}}(\widetilde{\gamma} \cap C) - \operatorname{length}_{\widetilde{M}_{\rho}}\left(\widetilde{\gamma} \cap \widetilde{C}\right),$$
(14)

where the last line follows because M_{ρ} and \widetilde{M}_{ρ} are isometric on W.

Interchanging the roles of M_{ρ} and \widetilde{M}_{ρ} allows one by an analogous argument to show,

$$d_{\widetilde{M}_{\rho}}(x,y) - d_{M_{\rho}}(x,y) \leq \operatorname{length}_{\widetilde{M}_{\rho}}\left(\gamma \cap \widetilde{C}\right) - \operatorname{length}_{M_{\rho}}\left(\gamma \cap C\right).$$
(15)

Note that in C and \tilde{C} the metrics will be close to each other in the C^2 -norm; therefore, (13) will be bounded by a function of ρ . To show this let's write down the metrics $g_{\tilde{C}}$ and g_C for \tilde{C} and C, respectively. Using the definitions of M_{ρ} and \tilde{M}_{ρ} from Subsection 4.1 and equations (4) and (5) we see

$$g_{C} = \begin{cases} dr^{2} + g_{r} & r \in [0, \rho - \delta] & \text{corresponds to } B_{p}^{M}\left(\rho\right) \setminus B_{p}^{M}\left(\delta\right) \\ dr^{2} + g_{r} & r \in [\rho - \delta, L] & \text{corresponds to } T_{\delta, \ell} \\ dr^{2} + g_{r} & r \in [L, L + \rho - \delta] & \text{corresponds to } B_{q}^{M}\left(\rho\right) \setminus B_{q}^{M}\left(\delta\right). \end{cases}$$

$$g_{\widetilde{C}} = \begin{cases} ds^2 + g_s & s \in \left[0, \frac{1}{40}\rho\right] & \text{corresponds to } B_p^{\widetilde{M}}\left(\rho\right) \setminus B_p^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \\ g_{\text{mol}}\left(\bar{s}\right) & s \in \left[\frac{1}{40}\rho, \frac{5}{40}\rho\right] & \text{corresponds to } B_p^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \setminus B_p^{\widetilde{M}}\left(\frac{35}{40}\rho\right) \\ ds^2 + \sin^2\left(\bar{s}\right)g_1^{n-1} & s \in \left[\frac{5}{40}\rho, \rho - \delta\right] & \text{corresponds to } B_p^{\widetilde{M}}\left(\frac{35}{40}\rho\right) \setminus B_p^{\widetilde{M}}\left(\delta\right) \\ ds^2 + g_s & s \in \left[\rho - \delta, \widetilde{L}\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\frac{35}{40}\rho\right) \setminus B_q^{\widetilde{M}}\left(\delta\right) \\ g_{\text{mol}}\left(\hat{s}\right) & s \in \left[\widetilde{L}, \widetilde{L} + \frac{35}{40}\rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\frac{35}{40}\rho\right) \setminus B_q^{\widetilde{M}}\left(\delta\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{35}{40}\rho - \delta, \widetilde{L} + \frac{39}{40}\rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \setminus B_q^{\widetilde{M}}\left(\frac{35}{40}\rho\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \setminus B_q^{\widetilde{M}}\left(\frac{35}{40}\rho\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\rho\right) \setminus B_q^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\rho\right) \setminus B_q^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\rho\right) \setminus B_q^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\rho\right) \setminus B_q^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\rho\right) \setminus B_q^{\widetilde{M}}\left(\frac{39}{40}\rho\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] & \text{corresponds to } B_q^{\widetilde{M}}\left(\rho\right) \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta, \widetilde{L} + \rho - \delta\right] \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta\right] \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta\right] \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta\right] \\ ds^2 + g_s & s \in \left[\widetilde{L} + \frac{39}{40}\rho - \delta\right] \\ ds^2$$

where $g_{\text{mol}}(s) = ds^2 + \psi(s) \left(g_s - \sin^2(s) g_1^{n-1}\right) + \sin^2(s) g_1^{n-1}$, $\bar{s} = \rho - s$, $\hat{s} = s - \tilde{L} + \delta$. Also, the notation " B^{M} " corresponds to balls in (M, g) and " $B^{\widetilde{M}}$ " corresponds to balls in (M, \tilde{g}) . Now we wish to estimate the C^2 -norm between g_C and $g_{\widetilde{C}}$.

By construction, on $\left[0, \frac{1}{40}\rho\right]g_C$ and $g_{\widetilde{C}}$ are identical and so are isometric.

On $\left[\frac{1}{40}\rho, \frac{5}{40}\rho\right]$ by using the same computation as (8) we have

$$\left|g_{C} - g_{\widetilde{C}}\right|_{2} = \left|\psi\left(r\right)\left(g_{r} - \sin^{2}\left(r\right)g_{1}^{n-1}\right) + \sin^{2}\left(r\right)g_{1}^{n-1} - g_{r}\right|_{2} \le A\rho^{4}.$$

We note this A is some constant depending on g. On $\left[\frac{5}{40}\rho, \rho - \delta\right]$, again we have by a similar argument and by Lemma 4.3.

$$|g_C - g_{\widetilde{C}}|_2 = |g_r - \sin^2(r)g_1^{n-1}|_2 \le A\rho^4,$$

for a constant A depending on g. On $T_{\delta,\ell}$ we reparameterize the interval so that it has the same length as $[\rho - \delta, L]$. Let this reparametrization be

$$s(r) = \frac{(L - \rho + \delta)(r - \rho + \delta)}{\widetilde{L} - \rho + \delta} + \rho - \delta$$

and so the metric looks like

$$\left(\frac{L-\rho+\delta}{\widetilde{L}-\rho+\delta}\right)^2 dr^2 + g_{s(r)}.$$

Thus, using this new parametrization we have on $[\rho - \delta, L]$:

$$\left|g_{C} - g_{\widetilde{C}}\right|_{2} \leq \left|1 - \left(\frac{L - \rho + \delta}{\widetilde{L} - \rho + \delta}\right)^{2}\right| \left|dr^{2}\right|_{2} + \left|g_{r} - g_{s(r)}\right|_{2}.$$

Now by Proposition 4.1 there is a constant A such that $\ell \leq L, \widetilde{L} \leq A\delta + \ell$. Therefore, for some A depending only on g and ℓ ,

$$\left|1 - \left(\frac{L-\rho+\delta}{\widetilde{L}-\rho+\delta}\right)^2\right| = \left|\frac{\widetilde{L}-L}{\widetilde{L}-\rho+\delta}\right| \left|1 + \frac{L-\rho+\delta}{\widetilde{L}-\rho+\delta}\right| \le A\rho.$$

Now by Lemma 4.3,

$$\begin{aligned} \left|g_{r} - g_{s(r)}\right|_{2} &\leq \left|g_{r} - r^{2}g_{1}^{n-1}\right|_{2} + \left|r^{2}g_{1}^{n-1} - s\left(r\right)^{2}g_{1}^{n-1}\right|_{2} + \left|s\left(r\right)^{2}g_{1}^{n-1} - g_{s(r)}\right|_{2} \\ &\leq c\rho^{4} + \left|r^{2}g_{1}^{n-1} - s\left(r\right)^{2}g_{1}^{n-1}\right|_{2} \\ &\leq A\rho^{2}, \end{aligned}$$

where the last inequality follows because $|s(r) - r| \le A\rho^2$ for some constant A depending on ℓ and g.

By symmetry, similar estimates follow for the remaining three intervals in the piecewise definition of $g_{\tilde{C}}$ where A depends on ℓ and g. Therefore, we conclude that for some constant A depending on ℓ and g

$$\left|g_C - g_{\widetilde{C}}\right|_2 \le A\rho \tag{16}$$

which implies by (14), (15), and (16) that $\lambda \leq A\rho$. Therefore,

$$d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{\rho}, \mathcal{M}_{\rho}\right) \le A\sqrt{\rho}.$$
(17)

Claim 2. There is a constant A > 0, depending only on ℓ and g so that

$$d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{0,\rho},\mathcal{M}_{0}\right) \leq A\rho^{2}.$$

Proof of Claim 2. By [10, Appendix A] (see Theorem 3.4 above), we have that if there is an $\alpha \ge 1$ independent of ρ such that for all $x, y \in M$

$$\frac{1}{\alpha} \le \frac{\widetilde{d}_{0,\rho}\left(x,y\right)}{d_0\left(x,y\right)} \le \alpha \tag{18}$$

and

$$\epsilon_{\rho} := \sup_{(x,y)\in M\times M} \left\{ \left| d_{0,\rho}\left(x,y\right) - d_{0}\left(x,y\right) \right| \right\} \xrightarrow{\rho \to 0} 0 \tag{19}$$

then there exists a subsequence which we will abuse notation and call $\widetilde{\mathcal{M}}_{0,\rho}$ such that

$$d_{\mathcal{F}}\left(\widetilde{\mathcal{M}}_{0,\rho},\mathcal{M}_{0}\right) \leq A\epsilon_{\rho},$$

where A depends on α and the mass of $(M_0, d_0, \llbracket M \rrbracket)$.

Recall (M_0, d_0) and $(\widetilde{M}_{0,\rho}, \widetilde{d}_{0,\rho})$ are geodesic spaces and let $x, y \in M$. We note that M is naturally a subset of M_0 and $\widetilde{M}_{0,\rho}$. Let γ be a geodesic between x, y in (M_0, d_0) and $\widetilde{\gamma}$ be a geodesic between x, y in $\left(\widetilde{M}_{0,\rho},\widetilde{d}_{0,\rho}\right)$. Finally, define $E = M \setminus W$. Now we estimate:

$$\begin{split} \widetilde{d}_{0,\rho}\left(x,y\right) - d_{0}\left(x,y\right) &= \operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\widetilde{\gamma}\right) - \operatorname{length}_{M_{0}}\left(\gamma\right) \\ &\leq \operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma\right) - \operatorname{length}_{M_{0}}\left(\gamma\right) \\ &= \operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma \cap W\right) + \operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma \cap I_{\ell}\right) + \operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma \cap E\right) \\ &- \operatorname{length}_{M_{0}}\left(\gamma \cap W\right) - \operatorname{length}_{M_{0}}\left(\gamma \cap I_{\ell}\right) - \operatorname{length}_{M_{0}}\left(\gamma \cap E\right) \\ &= \operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma \cap E\right) - \operatorname{length}_{M_{0}}\left(\gamma \cap E\right). \end{split}$$

By similar arguments to the proof of Claim 1 we will show that the final line above is less than $A\rho$, where A depends on g and ℓ . Specifically, we note that E is a subset M. Thus, $(E, g|_E)$ and $(E, \tilde{g}|_E)$ are smooth manifolds with their induced metrics; moreover, the naturally associated metric spaces are isometric to the subsets of $(\widetilde{M}_{0,\rho}, \widetilde{d}_{0,\rho})$ and (M_0, d_0) . Moreover, note that $E = E_1 \sqcup E_2$ where E_1 and E_2 are disjoint balls. Thus, it suffices to study what happens on E_i .

$$|g|_{E_i} - g_1^n|_2 = \left|g_r - \sin^2\left(r\right)g_1^{n-1}\right|_2 \qquad r \in [0, \rho]$$
⁽²⁰⁾

and

$$|\tilde{g}|_{E_i} - g_1^n|_2 = \begin{cases} 0 & r \in \left[0, \frac{9}{10}\rho\right] \\ \left|\psi\left(r\right)\left(g_r - \sin^2\left(r\right)g_1^{n-1}\right)\right|_2 & r \in \left[\frac{9}{10}\rho, \rho\right]. \end{cases}$$
(21)

Now by Lemma 4.3 we can conclude that $|g|_{E_i} - g_1^n|_2 \leq A\rho^4$ and $|\tilde{g}|_{E_i} - g_1^n|_2 \leq A\rho^4$ (where A depends on g) and so by the triangle inequality $|a|_{\mathcal{D}} - \widetilde{a}|_{\mathcal{D}}|_{*} \leq A a^{4}$

$$|g|_E - g|_E|_2 \ge Ap$$

Therefore, we may conclude that $\operatorname{length}_{\widetilde{M}_{0,\rho}}(\gamma \cap E) - \operatorname{length}_{M_0}(\gamma \cap E) \leq A\rho^2$ and so

$$d_{0,\rho}(x,y) - d_0(x,y) \le A\rho^2$$

where A depends on g. Likewise, by an analogous argument, we conclude $d_0(x,y) - d_{0,\rho}(x,y) \leq A\rho^2$; therefore, $\epsilon_{\rho} \leq A\rho^2$, where A depends on g

Now consider,

$$\begin{split} \frac{\widetilde{d}_{0,\rho}\left(x,y\right)}{d_{0}\left(x,y\right)} &= \frac{\operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\widetilde{\gamma}\right)}{\operatorname{length}_{M_{0}}\left(\gamma\right)} \\ &\leq \frac{\operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma\right)}{\operatorname{length}_{M_{0}}\left(\gamma\right)} \\ &= \frac{\operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma \cap \left(W \cup I_{\ell}\right)\right) + \operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma \cap E\right)}{\operatorname{length}_{M_{0}}\left(\gamma \cap \left(W \cup I_{\ell}\right)\right) + \operatorname{length}_{M_{0}}\left(\gamma \cap E\right)} \\ &\leq 1 + \frac{\operatorname{length}_{\widetilde{M}_{0,\rho}}\left(\gamma \cap E\right)}{\operatorname{length}_{M_{0}}\left(\gamma \cap E\right)}, \end{split}$$

where in the last inequality we use the fact that g and \tilde{g} coincide outside E and $\frac{a+b}{a+c} \leq 1 + \frac{b}{c}$ for any $a, b, c \geq 0$. One can prove this inequality by observing that it suffices to consider the case a = 1 and rearranging terms to show that it is equivalent to $-c^2 \leq b$.

Now, we note that by compactness of M we have that for all $v \in TM$, there is a constant A depending on g such that $\frac{1}{A}||v||^2 \leq g(v,v) \leq A||v||^2$ where $||\cdot||$ is the standard inner product on \mathbb{R}^n . Similarly, for all $\rho \in (0,1)$, we have by the definition of \tilde{g} that there exists a constant A_1 depending on g (and $\sin^2(r) g_1^{n-1}$) such that $\frac{1}{A_1}||v||^2 \leq \widetilde{g}(v,v) \leq A_1||v||^2$ for all $v \in TM$. Therefore, we have that on E

$$\operatorname{length}_{\widetilde{M}_{0,\rho}}(\gamma \cap E) \le A_1 \int_0^1 ||\dot{\gamma}|| dt$$

and

$$\frac{1}{A} \int_0^1 ||\dot{\gamma}|| dt \le \operatorname{length}_{M_0} \left(\gamma \cap E \right).$$

Combining these two inequalities we see,

$$\frac{\operatorname{length}_{\widetilde{M}_{0,\rho}}(\gamma \cap E)}{\operatorname{length}_{M_{0}}(\gamma \cap E)} \le A_{1}A$$

By switching the roles of $\widetilde{M}_{0,\rho}$ and M_0 and using a similar argument we see

$$\frac{\operatorname{length}_{M_0}(\gamma \cap E)}{\operatorname{length}_{\widetilde{M}_0}(\gamma \cap E)} \le AA_1$$

Therefore, $\frac{1}{1+AA_1} \leq \frac{\tilde{d}_{0,\rho}(x,y)}{d_0(x,y)} \leq 1 + AA_1$ and so we conclude that

$$d_{\mathcal{F}}\left(\mathcal{M}_{0},\widetilde{\mathcal{M}}_{0,\rho}\right) \leq A\rho^{2},\tag{22}$$

where A depends on g.

Finally, we conclude the proof of Proposition 4.5 by combining (12), (17), and (22) to see

$$d_{\mathcal{F}}\left(\mathcal{M}_{0},\mathcal{M}_{\rho}\right) \leq A\sqrt{\rho},$$

where A depends on g and ℓ .

4.3. The proofs of Theorems A and B and Corollary C. Recall by assumption $cd_g \leq d < d_g$ so the identity map is a distance decreasing biLipschitz map.

First, we will define the two more integral current spaces: $\mathcal{M}_{\epsilon}^{\text{tun}}$ which are associated to M with tunnels attached and $\mathcal{M}_{\epsilon}^{\text{str}}$ which are to M with strings attached. Both are inductively defined.

Let $\{p_1, \ldots, p_{N(\epsilon)}\}$ be a ϵ -net of M. Now for all $\epsilon > 0$ and $i \in \{1, 2, \ldots, N(\epsilon)\}$, we choose $N(\epsilon) - 1$ uniformly spaced points which lie on the geodesic sphere $\partial B_{p_i}(\epsilon)$. Denote these points as $\{q_j^i\}_{j \in \{1, \ldots, \hat{i}, \ldots, N(\epsilon)\}}$ where \hat{i} indicates that the index \hat{i} is omitted. Note we have

$$d_g\left(q_j^i, q_{j'}^i\right) > \frac{\epsilon}{N\left(\epsilon\right)}$$

for each $j \neq j'$ and all *i*. Now define $(Y_{\epsilon}, d_{Y_{\epsilon}})$ to be the metric space where we attach line segments to *M*. Specifically, let $\ell_j^i = d\left(q_j^i, q_i^j\right)$

$$Y_{\epsilon} = M \bigsqcup_{i < j}^{N(\epsilon)} [0, \ell_j^i],$$

where we identify the endpoints of $[0, \ell_j^i]$ with the pair of points $\{q_j^i, q_i^j\}$. And $d_{Y_{\epsilon}}$ is the induced length metric. Finally, define

$$\mathcal{M}_{\epsilon}^{\mathrm{str}} = (M, d_{Y_{\epsilon}}, \llbracket M \rrbracket) \,.$$

Next, we define $(X_{\epsilon}, d_{X_{\epsilon}})$ to be the metric space where we attach tunnels to M. Specifically, fix the radius

$$\rho_{i,j}\left(\epsilon\right) \leq \min\left\{\frac{\epsilon}{N\left(\epsilon\right)^{4}}, \rho_{0,i,j}\right\}$$

so that $\{B_{q_j^i}(\rho_{i,j}(\epsilon))\}$ are disjoint and $\rho_{0,i,j}$ is chosen using Lemma 4.4. Define X_{ϵ} by removing the balls $B_{q_j^i}(\rho_{i,j}(\epsilon))$, for each $i \in \{1, \ldots, N(\epsilon)\}$ and $j \in \{1, \ldots, \hat{i}, \ldots, N(\epsilon)\}$, and attach tunnels T_i^j using Proposition 4.1 where we choose $d = \ell_j^i$ and $\delta = \delta_j^i < \rho_{i,j}(\epsilon)$ along boundaries of $B_{q_j^i}(\rho_{i,j}(\epsilon))$ and $B_{q_i^j}(\rho_{i,j}(\epsilon))$. Specifically,

$$X_{\epsilon} = \left(M \setminus \bigcup_{i \neq j}^{N(\epsilon)} B_{q_{j}^{i}}\left(\rho_{i,j}\left(\epsilon\right)\right) \right) \bigcup_{i < j}^{N(\epsilon)} T_{i}^{j},$$

and call the induced Riemannian metric $g_{X_{\epsilon}}$ and call the induced distance function $d_{X_{\epsilon}}$. Moreover, by Proposition 4.1 we can ensure that the scalar curvature of X_{ϵ} is greater than $\kappa - \frac{1}{m(\epsilon)}$, where $m(\epsilon) \xrightarrow{\epsilon \to 0} \infty$. Finally, define

$$\mathcal{M}_{\epsilon}^{\mathrm{tun}} = (X_{\epsilon}, d_{X_{\epsilon}}, \llbracket X_{\epsilon} \rrbracket)$$

The proofs of the next two propositions are variations on [6, Proposition 5.1 and 5.2].

Proposition 4.6. There is a constant A > 0 so that, for all sufficiently small $\epsilon > 0$, we have

$$d_{\mathcal{F}}\left(\mathcal{M}_{\epsilon}^{\mathrm{tun}}, \mathcal{M}_{\epsilon}^{\mathrm{str}}\right) \leq A\sqrt{\epsilon}.$$

Proof. For each $\epsilon > 0$, enumerate the collection of pairs $\{q_j^i, q_i^j\} \subset M$ from 1 to $K := \frac{N(\epsilon)(N(\epsilon)-1)}{2}$. For $k \in \{1, \ldots, K\}$, let $\mathcal{M}_{\epsilon}^{\mathrm{tun}}(k)$ denote the integral current space resulting from replacing the first k tunnels T_i^j in the construction of $\mathcal{M}_{\epsilon}^{\mathrm{tun}}$ with the corresponding strings $[0, \ell_j^i]$ as in the construction of $\mathcal{M}_{\epsilon}^{\mathrm{str}}$. Notice that $\mathcal{M}_{\epsilon}^{\mathrm{tun}}(0) = \mathcal{M}_{\epsilon}^{\mathrm{tun}}$ and $\mathcal{M}_{\epsilon}^{\mathrm{tun}}(K) = \mathcal{M}_{\epsilon}^{\mathrm{str}}$.

We note that $\mathcal{M}_{\epsilon}^{\mathrm{tun}}(k)$ satisfies diam $(\mathcal{M}_{\epsilon}^{\mathrm{tun}}) \leq 2 (\operatorname{diam}_{g}(M) + \operatorname{diam}_{d}(M))$ for all k and ϵ because $|\ell_{j}^{i}| \leq \operatorname{diam}_{d}(M)$ and a path between two points of $\mathcal{M}_{\epsilon}^{\mathrm{tun}}$ can be defined by first exiting a tunnel if necessary (which adds length at most $2\operatorname{diam}_{d}(M)$) and then traveling along small perturbation of a geodesic in (M, g) (which adds length at most $2\operatorname{diam}_{q}(M)$).

Now item (2) of Proposition 4.1 states there is a constant A > 0 so that $\operatorname{vol}(T_j^i) \leq A \frac{\rho_{i,j}(\epsilon)^{n-1}}{2^{n-1}}$, where A depends on ℓ and g. Using this and our choice of $\rho_{i,j}(\epsilon)$, we estimate

$$\operatorname{vol}\left(\mathcal{M}_{\epsilon}^{\operatorname{tun}}\right) \leq \operatorname{vol}_{g}\left(M\right) + \sum_{i < j}^{N(\epsilon)} \operatorname{vol}\left(T_{j}^{i}\right)$$
$$\leq \operatorname{vol}_{g}\left(M\right) + N\left(\epsilon\right)^{2} A \frac{\rho_{i,j}\left(\epsilon\right)^{n-1}}{2^{n-1}}$$
$$= \operatorname{vol}_{g}\left(M\right) + A\epsilon^{n-1}.$$

Therefore, vol $(\mathcal{M}_{\epsilon}^{\mathrm{tun}})$ is bounded above by a constant independent of k and ϵ . Uniform control of the above quantities implies that the constant in (11) obtained by applying Proposition 4.5 to a ball $B_{q_j^i}(\rho_{i,j}(\epsilon))$ in $\mathcal{M}_{\epsilon}^{\mathrm{tun}}(k)$ is uniformly bounded in k and ϵ by some constant A.

Apply Proposition 4.5 iteratively to get:

$$d_{\mathcal{F}}\left(\mathcal{M}_{\epsilon}^{\mathrm{tun}}, \mathcal{M}_{\epsilon}^{\mathrm{str}}\right) \leq \sum_{k=1}^{K} d_{\mathcal{F}}\left(\mathcal{M}_{\epsilon}^{\mathrm{tun}}\left(k-1\right), \mathcal{M}_{\epsilon}^{\mathrm{tun}}\left(k\right)\right)$$
$$\leq N\left(\epsilon\right)^{2} A \sqrt{\frac{\rho_{i,j}\left(\epsilon\right)}{2}}$$
$$= A \sqrt{\epsilon}.$$

Proposition 4.7. The integral current spaces $\mathcal{M}_{\epsilon}^{\text{str}}$ converge to \mathcal{M} in the intrinsic flat sense as $\epsilon \to 0$, where

$$\mathcal{M} = (M, d, \llbracket M \rrbracket)$$

Proof. Note that the integral currents and canonical sets of the integral current spaces \mathcal{M} and $\mathcal{M}_{\epsilon}^{\mathrm{str}}$ are identical for all ϵ . We will apply [10, Theorem A.1] (see Theorem 3.4 above). Therefore, to show $\mathcal{M}_{\epsilon}^{\mathrm{str}} \to \mathcal{M}$ in the intrinsic flat sense, it suffices to show

$$\sup_{M \times M} |d_{Y_{\epsilon}} - d| \to 0$$

and the existence of a $\alpha > 0$, independent of ϵ , so that

$$\frac{1}{\alpha} \le \frac{d_{Y_{\epsilon}}\left(x,y\right)}{d\left(x,y\right)} \le \alpha$$

for all $x, y \in M$. We will now verify the above conditions.

For $\epsilon > 0$ and $x, y \in M$, choose points p_i and $p_{i'}$ in the net $\{p_i\}_{i=1}^{N(\epsilon)}$ closest to x and y, respectively. Now,

$$d_{Y_{\epsilon}}\left(x,y\right) \leq d_{g}\left(x,q_{i'}^{i}\right) + d\left(q_{i'}^{i},q_{i}^{i'}\right) + d_{g}\left(q_{i}^{i'},y\right)$$
$$\leq 6\epsilon + d\left(q_{i'}^{i},q_{i}^{i'}\right),$$

where the first inequality follows from the fact that $d\left(q_{i'}^{i}, q_{i}^{i'}\right) = d_{Y_{\epsilon}}\left(q_{i'}^{i}, q_{i}^{i'}\right)$ and the second inequality follows from our choice of points $q_{i}^{j} \in \partial B_{p_{i}}(\epsilon)$. Now we would like to compare d(x, y) and $d\left(q_{i'}^{i}, q_{i}^{i'}\right)$. Note

$$d\left(q_{i'}^{i}, q_{i}^{i'}\right) \leq d\left(x, q_{i'}^{i}\right) + d\left(x, y\right) + d\left(q_{i}^{i'}, y\right)$$

Therefore,

$$d(x,y) \ge d\left(q_{i'}^i, q_i^{i'}\right) - 6\epsilon \tag{23}$$

Combining these inequalities, we see

$$d_{Y_{\epsilon}}(x,y) - d(x,y) \le 12\epsilon.$$

By construction $d(x,y) \leq d_{Y_{\epsilon}}(x,y)$. Therefore, combining that with the above inequality we have

$$\left|d_{Y_{\epsilon}}\left(x,y\right) - d\left(x,y\right)\right| \le 12\epsilon \xrightarrow{\epsilon \to 0} 0.$$

For the other condition, we notice that

$$1 = \frac{d\left(x,y\right)}{d\left(x,y\right)} \le \frac{d_{Y_{\epsilon}}\left(x,y\right)}{d\left(x,y\right)} \le \frac{d_{g}\left(x,y\right)}{d\left(x,y\right)} \le \frac{1}{c},$$

where $\frac{1}{c}$ is the Lipschitz constant of the identity map from (M, d) to (M, d_g) . Therefore, take $\alpha = \frac{1}{c}$ in the above condition.

Now Theorem B follows readily.

Proof of Theorem B. By the triangle inequality, Proposition 4.6 and Proposition 4.7 we see that

$$d_{\mathcal{F}}\left(\mathcal{M}_{\epsilon}^{\mathrm{tun}},\mathcal{M}\right) \leq d_{\mathcal{F}}\left(\mathcal{M}_{\epsilon}^{\mathrm{tun}},\mathcal{M}_{\epsilon}^{\mathrm{str}}\right) + d_{\mathcal{F}}\left(\mathcal{M}_{\epsilon}^{\mathrm{str}},\mathcal{M}\right) \to 0$$

as $\epsilon \to 0$.

Theorem A follows immediately from the next corollary.

Corollary 4.8. Let $n \ge 3$ and g be a Riemannian metric on the standard smooth n-sphere. Then there exists a sequence of Riemannian manifolds (M_j, g_j) with scalar curvature $R_{g_j} > 0$ such that

 $d_{\mathcal{F}}\left(\left(M_j, d_{g_j}, \llbracket M_j \rrbracket\right)(\mathbb{S}^n, d_g, \llbracket \mathbb{S}^n \rrbracket)\right) \xrightarrow{j \to \infty} 0.$

Proof. Consider the identity map $(\mathbb{S}^n, g_{rd}) \xrightarrow{\mathrm{id}} (\mathbb{S}^n, g)$ and the identity map $(\mathbb{S}^n, g) \xrightarrow{\mathrm{id}} (\mathbb{S}^n, g_{rd})$. Both are diffeomorphisms so by compactness there exists a C > 1 depending on g_{rd} and g such that

$$\frac{1}{C}d_{g_{rd}}\left(x,y\right) \le d_{g}\left(x,y\right) \le Cd_{g_{rd}}\left(x,y\right).$$

Therefore, the identity map $(\mathbb{S}^n, C^2g_{rd}) \xrightarrow{\mathrm{id}} (\mathbb{S}^n, g)$ is a distance decreasing biLipschitz map because

$$\frac{1}{C^2} \le \frac{d_g(x,y)}{d_{C^2g_{rd}}(x,y)} = \frac{1}{C} \frac{d_g(x,y)}{d_{g_{rd}}(x,y)} \le 1.$$

Note that $R_{C^2g_{rd}} = \frac{1}{C^2}n(n-1) > \frac{n(n-1)}{2C^2} > 0$. Finally, apply Theorem B to complete the proof.

Finally, we prove Corollary C.

Proof of Corollary C. Let M^n be a closed oriented smooth manifold and g a Riemannian metric on M. Then by [13] there exists a metric g_- on the smooth manifold M such that the scalar curvature $R_{g_-} = -\frac{1}{2}$. Consider the identity map $(M^n, g_-) \xrightarrow{\text{id}} (M^n, g)$ and $(M^n, g) \xrightarrow{\text{id}} (M^n, g_-)$. Both are diffeomorphisms so by compactness there exists a C > 1 depending on g and g_- such that

$$\frac{1}{C}d_{g_{-}}(x,y) \le d_{g}(x,y) \le Cd_{g_{-}}(x,y).$$

Therefore, the identity map $(M^n, C^2g_-) \xrightarrow{\mathrm{id}} (M^n, g)$ is a distance decreasing biLipschitz map, i.e.,

$$\frac{1}{C^{2}} \leq \frac{d_{g}\left(x,y\right)}{d_{C^{2}g_{-}}\left(x,y\right)} = \frac{1}{C}\frac{d_{g}\left(x,y\right)}{d_{g_{-}}\left(x,y\right)} \leq 1.$$

Moreover, $R_{C^2g_-} = \frac{1}{C^2}R_{g_-} = -\frac{1}{2C^2} \ge -\frac{1}{2}$. Now apply Theorem B to complete the proof.

5. BILIPSCHITZ MAPS AND PIPE FILLING

In this section, we will prove a slight generalization of Theorem B.

Theorem 5.1. Let $\kappa \in \mathbb{R}$, $n \geq 3$, and (M^n, g) be a closed oriented Riemannian manifold with scalar curvature $R_g \geq \kappa$. Let d be a distance function such that there exists a strictly distance decreasing biLipshitz map

$$F: (M, d_g) \to (X, d)$$

where d_g is the induced distance function from the Riemannian metric. Then there exists a sequence of Riemannian manifolds (M_j^n, g_j) with scalar curvature $R_{g_j} \ge \kappa - \frac{1}{i}$ such that

$$d_{\mathcal{F}}\left(\left(M_j, d_{g_j}, \llbracket M_j \rrbracket\right), (X, d, F_{\#}\llbracket M \rrbracket)\right) \xrightarrow{j \to \infty} 0.$$

This theorem will follow from Theorem B and the following lemma. First, we state a definition

Definition 5.2. A map $F: (X, d_X) \to (Y, d_Y)$ between to metric spaces is called a (c, C)-biLipschitz if F is biLipschitz and there are constants c, C > 0 such that for all $p, q \in X$

$$cd_{X}(p,q) \leq d_{Y}(F(p),F(q)) \leq Cd_{X}(p,q)$$

Lemma 5.3. Let (X, d, T) be an integral current space. Let $F : (X, d) \to (X, \tilde{d})$ be a (c, C)-biLipschitz map. Define the integral current space $(X, \tilde{d}, F_{\#}T)$. Define the metric space $(X, F^*\tilde{d})$, where $F^*\tilde{d}(x, y) = \tilde{d}(F(x), F(y))$.

Then $\operatorname{id}: (X,d) \to (X,F^*\widetilde{d})$ is a (c,C)-biLipschitz map and $(X,F^*\widetilde{d},T)$ is an integral current space. Moreover, $F: (X,F^*\widetilde{d},T) \to (X,\widetilde{d},F_{\#}T)$ is a current preserving isomorphism and

$$d_{\mathcal{F}}\left(\left(X, F^*\widetilde{d}, T\right), \left(X, \widetilde{d}, F_{\#}T\right)\right) = 0.$$

Proof. First, we check $F^*\widetilde{d}$ is a distance function. Let $x, y, z \in X$

$$F^*\widetilde{d}(x,y) = \widetilde{d}(F(x),F(y)) \ge 0.$$

Moreover, x = y iff F(x) = F(y) since F is a bijection. Therefore,

$$F^*d(x,y) = 0 \iff x = y$$

 $F^*\widetilde{d}$ is symmetric:

$$F^{*}d(x,y) = d(F(x), F(y)) = d(F(y), F(x)) = F^{*}d(y,x).$$

Note that as F is a bijection we have for any $w \in X$ there exists a $z \in X$ such that F(z) = w. Lastly, we check the triangle inequality.

$$F^* \widetilde{d} (x, y) = \widetilde{d} (F(x), F(y)) \le \widetilde{d} (F(x), w) + \widetilde{d} (w, F(y)) = \widetilde{d} (F(x), F(z)) + \widetilde{d} (F(z), F(y))$$

= $F^* \widetilde{d} (x, z) + F^* \widetilde{d} (z, y) .$

Therefore, $F^*\widetilde{d}$ is a distance function. Let $x, y \in X$, then

$$cd(x,y) \leq F^*\widetilde{d}(x,y) = \widetilde{d}(F(x),F(y)) \leq Cd(x,y).$$

Thus, $\operatorname{id} : (X, d) \to (X, F^*\widetilde{d})$ is a (c, C)-biLipschitz map and $(X, F^*\widetilde{d}, T)$ is an integral current space. Let $x, y \in X$ and observe $F : (X, F^*\widetilde{d}, T) \to (X, \widetilde{d}, F_{\#}T)$ is an isometry since

$$F^{*}\widetilde{d}(x,y) = \widetilde{d}(F(x),F(y))$$

Moreover, $F: \left(X, F^*\widetilde{d}, T\right) \to \left(X, \widetilde{d}, F_{\#}T\right)$ is current preserving.

Proof of Theorem 5.1. Let $\kappa \in \mathbb{R}$, $n \geq 3$, and (M^n, g) be a closed oriented Riemannian manifold with scalar curvature $R_g \geq \kappa$. Let d be a distance function such that there exists a strictly distance decreasing biLipshitz map

$$F: (M, d_g) \to (X, d)$$

where d_g is the induced distance function from the Riemannian metric. Therefore, there exists constants $c \leq C < 1$ such that

$$cd_{g}(p,q) \leq d(F(p),F(q)) \leq Cd_{g}(p,q).$$

Consider the following integral current spaces $(X, d, F_{\#} \llbracket M \rrbracket)$ and $(M, F^*d, \llbracket M \rrbracket)$. By Lemma 5.3, we have that $F^*d : M \times M \to \mathbb{R}$ satisfies

$$cd_{g}(x,y) \leq F^{*}d(x,y) \leq Cd_{g}(x,y) < d_{g}(x,y).$$

Therefore, using Theorem B we see that there exists a sequence of Riemannian manifolds (M_j^n, g_j) with scalar curvature $R_{g_j} \ge \kappa - \frac{1}{j}$ such that

$$d_{\mathcal{F}}\left(\left(M_j, d_{g_j}, \llbracket M_j \rrbracket\right), (M, F^*d, \llbracket M \rrbracket)\right) \xrightarrow{j \to \infty} 0.$$

Finally, we have

$$d_{\mathcal{F}}\left(\left(M_{j}, d_{g_{j}}, \llbracket M_{j} \rrbracket\right), (X, d, F_{\#}\llbracket M \rrbracket)\right) \leq d_{\mathcal{F}}\left(\left(M_{j}, d_{g_{j}}, \llbracket M_{j} \rrbracket\right), (M, F^{*}d, \llbracket M \rrbracket)\right) \\ + d_{\mathcal{F}}\left(\left(M, F^{*}d, \llbracket M \rrbracket\right), (X, d, F_{\#}\llbracket M \rrbracket)\right) \\ = d_{\mathcal{F}}\left(\left(M_{j}, d_{g_{j}}, \llbracket M_{j} \rrbracket\right), (M, F^{*}d, \llbracket M \rrbracket)\right) \xrightarrow{j \to \infty} 0,$$

where in the final equality, we use the conclusion of Lemma 5.3 that $F : (M, F^*d, \llbracket M \rrbracket) \to (X, d, F_{\#}\llbracket M \rrbracket)$ is a current-preserving isometry.
