# The local well-posedness, blow-up and global solution of a new integrable system in Besov spaces

#### Abstract

In this paper, we first establish the local well-posednesss for the Cauchy problem of a N-peakon system in the sense of Hadamard in both critical Besov spaces and supercritical Besov spaces. Second, we gain a blow-up criterion. According to blow-up criterion wemreach a precise blow-up criterion. Under a sign condition, we reach the existence of global solution. Finally, based on the first-order difference method, we give a simulation example of the blow-up of the equation and the properties of the global solution.

### 1 Introduction

Korteweg-de Vries (KdV) equation which was introduced to describe the behavior of long waves on shallow water in the most famous model in soliton theory, because it is integrable and includes the phenomena of soliton interaction. But the KdV equation cannot model the occurrence of breaking waves. In 1993, Camassa and Holm obtain a nonlinear partial differential equation [2]

$$m_t + um_x + 2u_x m = 0, m = u - u_{xx} + \kappa$$

which is named Camassa-Holm (CH) equation.

A particular feature of the CH equation is that when  $\kappa = 0$  it admits peaked soliton solutions which are also called peakons. It can be regarded as a shallow water wave equation.[2, 8, 18]. Its complete integrability was discussed in [2, 4, 9]. The CH equation also has a Hamilton structure[3, 12], and admits exact orbitally stable peaked solitons of the form  $ce^{|x-ct|}$  with c > 0. The local well-posedness of the Cauchy problem of CH equation in Besov spaces and Sobolev spaces was proved in [5, 6, 10, 22].

Since constructing peakon equation are interested in the fields of Physics and Mathematics. Based on an asymptotic integrability approach, Degasperis and Procesi discovered a new equation which has peakon solutions [20, 11]. Similarly, the Cauchy problem of the DP equation is locally well-posed in certain Sobolev and Besov spaces [24, 16, 25]. And Geng and Xue constructed a two component peakon with cubic nonlinearity [13], three components generalization of CH equation [14] and super CH equation with N-peakon [15].

Geng and Xue constructed from the compatibility of a  $2 \times 2$  matrix spectral problem, a new nonlinear evolution with N-peakon is derived [23]

(1.1) 
$$\begin{cases} n_t = 4[n(v_x + 2\beta_0 v)]_x \\ n = 4\beta_0^2 v - v_{xx} \\ v|_{t=0} = v_0 \end{cases}$$

It is shown in that system (1.1) admits exact solutions with N-peakon, which takes the form

$$v(x,t) = \sum_{i=1}^{N} n_i(t)e^{-2\beta_0|x-x_i(t)|}$$

where  $n_i$  and  $x_i$  evolve according to a dynamical system.

After some transformations, (1.1) can be changed into a transport-like equation

(1.2) 
$$\begin{cases} v_t - (8\beta_0 v + 2v_x)v_x = -8\beta_0^2 v^2 + 8\beta_0 P_1(D)(2\beta_0^2 v^2 + v_x^2) + 8\beta_0^2 P_2(D)(4\beta_0^2 v^2 - v_x^2) \\ v|_{t=0} = v_0 \end{cases}$$

with 
$$P_2(D) = (4\beta_0^2 - \partial_x^2)^{-1}$$
,  $P_1(D) = \partial_x P_2(D)$ .

In this paper, firstly, applying Littlewood-Paley theory and transport theory, for the initial data in certain Besov spaces of high regularity or of critical regularity, complete the locally well-posedness in Besov space  $B_{p,r}^s$  with  $\{s\geq \frac{1}{2}, p>2, 1\leq r\leq \infty\}$  or  $\{s>\frac{1}{p}, 1\leq p\leq 2, 1\leq r\leq \infty\}$  or  $\{s=\frac{1}{p}, 1\leq p\leq 2, r=1\}$ , we prove the local solution to equation (1.1) exists uniquely and depends continuously on the initial data. And we will talk about the blow-up criterion and the blow up condition of initial data. In the last part of the paper,according to the structure of equation, we can find a sign-preserved property, and by the virtue of the high-preserved we see that the  $H^1$ -norm of v is non-increasing, then we can finally give the condition of existence of the global solution.

## 2 Preliminaries

In this section, we will present some propositions about the Littlewood-Paley decomposition and the non homogeneous Besov spaces with their properties.

**Proposition 2.1** (Littlewood-Paley decomposition). [1, 17] There exists a couple of smooth function  $(\chi, \varphi)$  valued in [0, 1], such that  $\kappa$  is supported in the ball  $B \triangleq \{\xi \in \mathbb{R}^d : \frac{3}{4} \leq |\xi| \leq \frac{8}{3}\}$ . Moreover

$$\forall \xi \in \mathbb{R}^d, \chi(\xi) + \sum_{j>0} \varphi(2^{-j}\xi) = 1$$

and

$$supp \ \varphi(2^{-j} \cdot) \cap supp \ \varphi(2^{-j' \cdot}) = \emptyset, \ if \ |j - j'| \ge 2$$
$$supp \ \chi(\cdot) \cap supp \ \varphi(2^{-j' \cdot}) = \emptyset, \ if \ j \ge 1$$

Then for all  $u \in \mathcal{S}'$ , we can define the nonhomogeneous dyadic blocks as follows. Let

$$\Delta_j u \triangleq 0, \ if \ j \leq -2, \ \Delta_{-1} u \triangleq \chi(D) u = \mathcal{F}^{-1}(\chi \mathcal{F} u)$$

$$\Delta_j \triangleq \varphi(2^{-j} u) = \mathcal{F}^{-1}(\varphi(2^{-j} \cdot) \mathcal{F} u), \ if \ j \geq 0$$

Hence,

$$u = \sum_{j \in \mathbb{Z}} \Delta_j u \ in \ \mathcal{S}'(\mathbb{R}^d)$$

where the right-hand side is called the nonhomogeneous Littlewood-Paley decomposition of u.

According to Young's inequality, we get

$$\|\Delta_{i}u\|_{L^{p}}, \|S_{i}u\|_{L^{p}} \leq C\|u\|_{L^{p}}, \ \forall 1 \leq p \leq \infty$$

The low frequency cut-off operator  $S_i$  is defined by

$$S_j u \triangleq \sum_{j'=-1}^{j-1} \Delta_{j'} u = \chi(2^{-j}D)u = \mathcal{F}^{-1}(\chi(2^{-j}\xi)\mathcal{F}u), \ \forall j \in \mathbb{N}$$

and the Littlewood-Paley decomposition is quasi-orthogonal in  $L^2$  in the following sense:

$$\Delta_i \Delta_k u \equiv 0, if |j-k| > 2$$

$$\Delta_i(S_{k-1}u\Delta_k u) \equiv 0, \ if \ |j-k| \ge 5$$

**Definition 2.2** (Nonhomogeneous Besov space). [1] Let  $s \in \mathbb{R}$ ,  $1 \le p$ ,  $r \le \infty$ . The nonhomogeneous Besov space  $B_{p,r}^s(\mathbb{R}^d)(B_{p,r}^s \text{ for short})$  is defined by

$$B_{p,r}^{s}(\mathbb{R}^{d}) \triangleq \left\{ f \in \mathcal{S}' : \|f\|_{B_{p,r}^{s}} = \triangleq \|(2^{js} \|\Delta_{j} f\|_{L^{p}})_{j \geq -1}\|_{l^{r}} < \infty \right\}$$

If  $s = \infty$ , we have

$$B_{p,r}^{\infty} \triangleq \bigcap_{s \in \mathbb{R}} B_{p,r}^{s} = \left\{ f \in \mathcal{S}' : \sup_{j \ge -1} 2^{js} \|\Delta_{j} f\|_{L^{p}} < \infty \right\}$$

In the following lemma, we list some important properties of Besov spaces.

**Lemma 2.3.** [1, 17] Let  $s \in \mathbb{R}$ ,  $1 \le p, p_1, p_2, r, r_1, r_2 \le \infty$ . We have

- (1)  $B_{p,r}^s$  is a Banach space, and is continuously embedded in S'.
- (2) If  $r < \infty$ , then  $\lim_{j \to \infty} ||S_j u u||_{B^s_{p,r}} = 0$ . If  $p, r < \infty$ ,  $C_0^{\infty}$  is dense in  $B^s_{p,r}$ .
- (3) If  $p_1 \leq p_2$  and  $r_1 \leq r_2$ , then  $B^s_{p_1,r_1} \hookrightarrow B^{s-d(\frac{1}{p_1}-\frac{1}{p_2})}_{p_2,r_2}$ . If  $s_1 < s_2$ , the embedding  $B^{s_2}_{p,r_2} \hookrightarrow B^{s_1}_{p,r_1}$  is locally compact.
- (4)  $\forall s > 0$ ,  $B_{p,r}^s \cap L^\infty$  is an algebra. Moreover,  $B_{p,r}^s \hookrightarrow L^\infty \Leftrightarrow s > \frac{d}{p}$  or  $s = \frac{d}{p}$ ,  $r = 1 \Leftrightarrow B_{p,r}^s$  is an algebra.
- (5) Complex interpolation:  $\forall f \in B_{p,r}^{s_1} \cap B_{p,r}^{s_2}, \ \forall \theta \in [0,1]$

(6) Logarithm interppolation:  $\forall s \in \mathbb{R}, \ \varepsilon > 0$ , and  $1 \le p \le \infty$ , there exists a constant C such that

(2.2) 
$$\|u\|_{B_{p,1}^s} \le C \frac{1+\varepsilon}{\varepsilon} \|u\|_{B_{p,\infty}^s} \left( 1 + \log \frac{\|u\|_{B_{p,\infty}^{s+\varepsilon}}}{\|u\|_{B_{p,\infty}^s}} \right)$$

(7) Fatou property: if  $(u_n)_{n\in\mathbb{N}}$  is a bounded sequence in  $B_{p,r}^s$ , then an element  $u\in B_{p,r}^s$  and a subsequence  $(u_{n_k})_{k\in\mathbb{N}}$  exists such that

$$\lim_{k \to \infty} u_{n_k} = u \text{ in } \mathcal{S}' \quad \text{and} \quad \|u\|_{B^s_{p,r}} \le C \liminf_{k \to \infty} \|u_{n_k}\|_{B^s_{p,r}}.$$

(8) Let  $m \in \mathbb{R}$  and f be a  $S^m$ - multiplier, (i.e. f is a smooth function and satisfies that  $\forall \alpha \in \mathbb{N}^d$ ,  $\exists C = C(\alpha)$ , such that  $|\partial^{\alpha} f(\xi)| \leq C(1+|\xi|)^{m-|\alpha|}$ ,  $\forall \xi \in \mathbb{R}^d$ ). Then the operator  $f(D) = \mathcal{F}^{-1}(f\mathcal{F}\cdot)$  is continuous from  $B_{p,r}^s$  to  $B_{p,r}^{s-m}$ .

**Proposition 2.4.**  $\forall \beta_0 \neq 0$ , we have  $(4\beta_0^2 - \partial_x^2)^{-1}$  is a  $S^{-2}$ -multiplier, and  $\partial_x (4\beta_0^2 - \partial_x^2)^{-1}$  is a  $S^{-1}$ -multiplier.

Next, we introduce the paradifferential calculus of Besov space and the main continuity properties of the paraproduct and the remainder.

**Definition 2.5.** [1] The nonhomogeneous paraproduct of v by u is defined by

$$T_u v = \sum_j S_{j-1} u \Delta_j v$$

The nonhomogeneous remainder of u and v is defined by

$$R(u,v) = \sum_{|k-j| \le 1} \Delta_k u \Delta_j v$$

**Lemma 2.6.** [1] (1)  $\forall t < 0, s \in \mathbb{R}, u \in B_{p,r_1}^t \cap L^{\infty}, v \in B_{p,r_2}^s \text{ with } \frac{1}{r} = \frac{1}{r_1} + \frac{1}{r_2}, \text{ then}$ 

$$\|T_uv\|_{B^s_{p,r_2}} \leq C \|u\|_{L^\infty} \|v\|_{B^s_{p,r_2}}$$

or

$$||T_u v||_{B^{s+t}_{p,r}} \le C||u||_{B^t_{\infty,r_1}} ||v||_{B^s_{p,r_2}}$$

(2)  $\forall s_1, s_2 \in \mathbb{R}, 1 \leq p_1, p_2, r_1, r_2 \leq \infty$ , with  $\frac{1}{p} = \frac{1}{p_1} + \frac{1}{p_2} \leq 1, \frac{1}{r} = \frac{1}{r_1} + \frac{1}{r_2} \leq 1$ . Then  $\forall (u, v) \in B^{s_1}_{p_1, r_1} \times B^{s_2}_{p_2, r_2}$ , if  $s_1 + s_2 > 0$ 

$$||R(u,v)||_{B_{p,r}^{s_1+s_2}} \le C||u||_{B_{p_1,r_1}^{s_1}} ||v||_{B_{p_2,r_2}^{s_2}}$$

If r = 1 and  $s_1 + s_2 = 0$ ,

$$||R(u,v)||_{B_{p,\infty}^0} \le C||u||_{B_{p_1,r_1}^{s_1}}||v||_{B_{p_2,r_2}^{s_2}}$$

We then have the following product laws:

**Lemma 2.7.** [1, 17] (1) For any s > 0 and any (p,r) in  $[1,\infty]^2$ , the space  $L^{\infty} \cap B_{p,r}^s$  is an algebra, and a constant C exists such that

$$||uv||_{B_{p,r}^s} \le C(||u||_{L^{\infty}}||v||_{B_{p,r}^s} + ||u||_{B_{p,r}^s}||v||_{L^{\infty}}).$$

(2) If  $1 \le p, r \le \infty$ ,  $s_1 \le s_2$ ,  $s_2 > \frac{d}{p}(s_2 \ge \frac{d}{p} \text{ if } r = 1)$  and  $s_1 + s_2 > \max(0, \frac{2d}{p} - d)$ , there exists C such that

$$||uv||_{B_{p,r}^{s_1}} \le C||u||_{B_{p,r}^{s_1}}||v||_{B_{p,r}^{s_2}}.$$

(3) If  $1 \le p \le 2$ ,  $\forall u \in B_{p,\infty}^{\frac{d}{p}-d}(\mathbb{R}^d)$ ,  $\forall v \in B_{p,1}^{\frac{d}{p}}(\mathbb{R}^d)$ , there exists C such that

$$\|uv\|_{B^{\frac{d}{p}-d}_{p,\infty}} \leq C \|u\|_{B^{\frac{d}{p}-d}_{p,\infty}} \|v\|_{B^{\frac{d}{p}}_{p,1}}.$$

**Proposition 2.8.** [1] Let  $s \in \mathbb{R}, 1 \leq p, r \leq \infty$ .

(2.3) 
$$\begin{cases} B_{p,r}^s \times B_{p',r'}^{-s} & \longrightarrow \mathbb{R}, \\ (u,\phi) & \longmapsto \sum_{|j-j'| < 1} \langle \Delta_j u, \Delta_{j'} \phi \rangle, \end{cases}$$

defines a continuous bilinear functional on  $B_{p,r}^s \times B_{p',r'}^{-s}$ . Denoted by  $Q_{p',r'}^{-s}$  the set of functions  $\phi$  in S' such that  $\|\phi\|_{B_{r',r'}^{-s}} \leq 1$ . If u is in S', then we have

$$||u||_{B_{p,r}^s} \le C \sup_{\phi \in Q_{p',r'}^{-s}} \langle u, \phi \rangle.$$

We now state the definition of Osgood modulus of continuity and Osgood lemma.

**Definition 2.9.** [1] Let  $a \in (0,1]$ . Nondecreasing nonzero continuous function  $\mu$  is defined on [0,a] and  $\mu:[0,a] \to \mathbb{R}^+$  s.t.  $\mu(0)=0$ , then  $\mu$  is called a modulus of continuity. And if  $\mu$  is called an Osgood modulus of continuity if

$$\int_0^a \frac{\mathrm{dr}}{\mu(r)} = \infty$$

The Osgood lemma are useful to prove the uniqueness of some ordinary differential equations and one can utilize a procedure to construct a large families of Osgood functions.

**Lemma 2.10** (Osgood lemma). [1] Let  $\rho$  be a measurable function mapping  $[t_0, T]$  to [0, a],  $\gamma$  is a locally integrable function from  $[t_0, T]$  to  $\mathbb{R}^+$ , and  $\mu$  is a nondecreasing function mapping [0, a] to  $\mathbb{R}^+$ . Assume that, for some nonnegative real number c, the function  $\rho$  satisfies

$$\rho(t) \le c + \int_{t_0}^t \gamma(t')\mu(\rho(t'))dt' \quad for \ a.e. \ t \in [t_0, T]$$

• If c is positive

$$-\mathcal{M}(\rho(t)) + \mathcal{M}(c) \le \int_{t_0}^t \gamma(t') dt' \quad with \quad \mathcal{M}(x) = \int_x^a \frac{dr}{\mu(r)} \quad for \ a.e. \ t \in [t_0, T]$$

• If c = 0 and  $\mu$  is an Osgood modulus of continuity, then  $\rho = 0$ , a.e.  $t \in [t_0, T]$ .

Next, we state some useful result in the transport equation theory, which are crucial to the proofs of our main thorems later. Let us consider the linear transport equation:

(2.4) 
$$\begin{cases} \partial_t f + v \cdot \nabla f = g \\ f|_{t=0} = f_0 \end{cases}$$

**Lemma 2.11** (A priori estimates in Besov spaces). [1] Let  $s \in \mathbb{R}$ ,  $1 \le p, r \le \infty$ . Assume that

$$s \ge -d\min(\frac{1}{p_1}, \frac{1}{p'})$$

There exists a constant C such that for all solutions  $f \in L^{\infty}([0,T]; B_{p,r}^s)$  of (2.4) in d-dimensional space with initial data  $f_0 \in B_{p,r}^s$ , and  $g \in L^1([0,T]; B_{p,r}^s)$ , we have for a.e.  $t \in [0,T]$ ,

$$||f(t)||_{B_{p,r}^s} \le ||f_0||_{B_{p,r}^s} + \int_0^t ||g(t')||_{B_{p,r}^s} dt' + \int_0^t V_{p_1}'(t') ||f(t)||_{B_{p,r}^s} dt'$$

or

$$||f(t)||_{B_{p,r}^s} \le e^{CV_{p_1}(t)} \Big( ||f_0||_{B_{p,r}^s} + \int_0^t e^{-CV_{p_1}(t')} ||g(t')||_{B_{p,r}^s} dt' \Big)$$

with

$$V'_{p_1}(t) = \begin{cases} \|\nabla v\|_{B^{\frac{d}{p_1}}_{p_1, \infty} \cap L^{\infty}}, & \text{if } s < 1 + \frac{d}{p_1} \\ \|\nabla v\|_{B^{s-1}_{p_1, r}}, & \text{if } s > 1 + \frac{d}{p_1} \text{ or } \left\{ s = 1 + \frac{d}{p_1} \text{ and } r = 1 \right\} \end{cases}$$

If f = v, for all s > 0

$$V_{p_1}^{'}(t) = \|\nabla v(t)\|_{L^{\infty}}.$$

Lemma 2.12. [21, 17] If

$$\{s \geq \frac{d}{2}, p > 2, 1 \leq r \leq \infty\} \ or \ \{s > \frac{d}{p}, 1 \leq p \leq 2, 1 \leq r \leq \infty\} \ or \ \{s = \frac{d}{p}, 1 \leq p \leq 2, r = 1\}$$

then for the solution  $f \in L^{\infty}([0,T]; B_{p,r}^s)$  of (2.4) with  $v \in L^1([0,T]; B_{p,r}^{s+1})$ , then the initial data  $f_0 \in B_{p,r}^s$  and  $g \in L^1([0,T]; B_{p,r}^s$ , we then have

$$||f(t)||_{B_{p,r}^s} \le e^{CV(t)} (||f_0||_{B_{p,r}^s} + \int_0^t e^{-CV(t)} ||g(\tau)||_{B_{p,r}^s} d\tau)$$

with  $V(t) = \int_0^t ||v(\tau)||_{B^{s+1}_{p,r}} d\tau$  and C = C(p, r, s).

**Lemma 2.13.** [1] Let  $1 \leq p \leq p_1 \leq \infty$ ,  $1 \leq r \leq \infty$ ,  $s > -d\min(\frac{1}{p_1}, \frac{1}{p'})$ . Let  $f_0 \in B^s_{p,r}$ ,  $g \in L^1([0,T]; B^s_{p,r})$ , and let v be a time-dependent vector field such that  $v \in L^{\rho}([0,T]; B^{-M}_{\infty,\infty})$  for some  $\rho > 1$  and M > 0, and

$$\begin{split} & \nabla v \in L^1([0,T]; B_{p_1,\infty}^{\frac{d}{p_1}}), \quad \text{ if } s < 1 + \frac{d}{p_1}, \\ & \nabla v \in L^1([0,T]; B_{p,r}^{s-1}), \quad \text{ if } s > 1 + \frac{d}{p_1} \text{ or } (s = 1 + \frac{d}{p_1} \text{ and } r = 1). \end{split}$$

Then the equation (2.4) has a unique solution f in

- the space  $C([0,T];B_{p,r}^s)$ , if  $r<\infty$ ;
- the space  $\left(\bigcap_{s' < s} C([0,T]; B_{p,\infty}^{s'})\right) \bigcap C_w([0,T]; B_{p,\infty}^s)$ , if  $r = \infty$ .

**Lemma 2.14.** [19] Let  $1 \leq p \leq \infty, 1 \leq r \leq \infty, s > 1 + \frac{d}{p} (or \ s = 1 + \frac{d}{p}, r = 1, 1 \leq p < \infty)$ . Denote  $\bar{\mathbb{N}} = \mathbb{N} \cup \{\infty\}$ . Let  $\{v^n\}_{n \in \bar{\mathbb{N}}} \subset C([0,T]; B^{s-1}_{p,r})$ . Assume that  $v^n$  is the solution to

$$\begin{cases} \partial_t v^n + a^n \partial_x v^n = f \\ v^n|_{t=0} = v_0 \end{cases}$$

with  $v_0 \in B^{s-1}_{p,r}, \ f \in L^1([0,T];B^{s-1}_{p,r})$  and for some  $\alpha \in L^1([0,T])$ 

$$\sup_{n \in \bar{\mathbb{N}}} \|a^n\|_{B_{p,r}^s} \le \alpha(t)$$

If  $a^n \to a^\infty$  in  $L^1([0,T]; B^{s-1}_{p,r})$  as n tends to  $\infty$ , then  $v^n \to v^\infty$  in  $C([0,T]; B^{s-1}_{p,r})$  as n tends to  $\infty$ .

## 3 Local well-posedness

In this section, we will establish the local well-posedness for the Cauchy problem (1.1) or (1.2) in Besov spaces. We want to solve the Cauchy problem (1.2) directly by general Picard scheme and transport equation theory, but we will fail to do that due to the loss of regularity of the transport term. By Prop 2.4, we can overcome the difficulty by solving the Cauchy problem (1.1).

Firstly, we give a definition as follows

**Definition 3.1.** Let T > 0,  $s \in \mathbb{R}$  and  $1 \le p, r \le \infty$ . Denote

$$E_{p,r}^{s}(T) \triangleq \begin{cases} C([0,T]; B_{p,r}^{s}) \cap C^{1}([0,T]; B_{p,r}^{s-1}) & \text{if } r < \infty \\ C_{w}([0,T]; B_{p,r}^{s}) \cap C^{0,1}([0,T]; B_{p,r}^{s-1}) & \text{if } r = \infty \end{cases}$$

$$E_{p,r}^s(T_-) \triangleq \left\{ \begin{array}{ll} C([0,T);B_{p,r}^s) \cap C^1([0,T);B_{p,r}^{s-1}) & \quad if \ r < \infty \\ C_w([0,T);B_{p,r}^s) \cap C^{0,1}([0,T);B_{p,r}^{s-1}) & \quad if \ r = \infty \end{array} \right.$$

**Theorem 3.2.** Let  $1 \le p, r \le \infty, s \in \mathbb{R}$  and (s, p, r) satisfies the condition

$$(3.1) \qquad \{s \geq \frac{1}{2}, p > 2, 1 \leq r \leq \infty\} \ \ or \ \ \{s > \frac{1}{p}, 1 \leq p \leq 2, 1 \leq r \leq \infty\} \ \ or \ \ \{s = \frac{1}{p}, 1 \leq p \leq 2, r = 1\}$$

Let  $n_0 \triangleq 4\beta_0^2 v_0 - v_{0xx}$  with  $\beta_0 \neq 0$  be in  $B_{p,r}^s$ . Then (1.1) has a unique maximal solution n in  $E_{p,r}^s(T_-^*)$  and n depends continuously on the initial data  $n_0$ .

Moreover, there exists a positive constant C, depending only on  $s, p, r, \beta_0$  s.t

$$T^* \ge \frac{C}{\|n_0\|_{B^s_{p,r}}}$$

*Proof.* Now we prove Theorem 3.2 as the following steps.

Step 1: Constrcuting Approxiamte Solitions and Uniform Bounds.

Denoting  $v^0 = 0$ , we define a sequence  $(n^k)_{k \in \mathbb{N}}$  of smooth functions by solving the following linear transport equation:

$$(T_k) \begin{cases} n_t^{k+1} - 4(v_x^k + 2\beta_0 v^k) n_x^{k+1} = 16\beta_0^2 v^k n^k - 4(n^k)^2 + 8\beta_0 v_x^k n^k \\ v^{k+1} = (4\beta_0^2 - \partial_x^2)^{-1} n^{k+1} \\ v^{k+1}|_{t=0} = S_{k+1} v_0 \end{cases}$$

By induction, we assume that  $(n^k)_{k\in\mathbb{N}}, \forall T>0$ . Since  $(4\beta_0^2-\partial_x^2)^{-1}$  is an  $S^{-2}$ -multiplier and

$$v^{k+1} = (4\beta_0^2 - \partial_x^2)^{-1} n^{k+1} = \frac{1}{4|\beta_0|} e^{-|2\beta_0 \cdot| *n^{k+1}}$$

also noticing that  $B_{p,r}^s$  is an algebra when (s,p,r) satisfies the condition (3.1) and the embedding  $B_{p,r}^s \hookrightarrow B_{p,r}^{s-1} \hookrightarrow B_{p,r}^{s-2}$ , we obtain

$$||16\beta_0^2 v^k n^k - 4(n^k)^2 + 8\beta_0 v_x^k n^k||_{B_{p,r}^s} \le C||n^k||_{B_{p,r}^s}^2$$

At the same time  $\|S_{k+1}n_0\|_{B^s_{p,r}} \le C\|n_0\|_{B^s_{p,r}}$ , and denote that

$$\int_0^t \|4(v_x^k + 2\beta_0 v^k)_x(\tau)\|_{B_{p,r}^s} d\tau \le CN^k(t) \triangleq \int_0^t \|n^k(\tau)\|_{B_{p,r}^s} d\tau$$

Applying Thm2.11, we have

We may assume  $C \ge 1$  and fix a T > 0 s.t.

$$(3.3) 2C^2 ||n_0||_{B_{p,r}^s} T < 1$$

Suppose that  $\forall t \in [0,T], n^k$  satisfies

(3.4) 
$$||n^k(t)||_{B_{p,r}^s} \le \frac{C||n_0||_{B_{p,r}^s}}{1 - 2C^2||n_0||_{B_{p,r}^s}}$$

Note that

$$e^{CN^k(t_2) - CN^k(t_1)} = e^{C\int_{t_1}^{t_2} \|v^k(\tau)\|_{B^s_{p,r}} d\tau} \le e^{\int_{t_1}^{t_2} \frac{C^2 \|n_0\|_{B^s_{p,r}}}{1 - 2C^2 \tau \|n_0\|_{B^s_{p,r}}} d\tau} = \left(\frac{1 - 2C^2 \|n_0\|_{B^s_{p,r}} t_1}{1 - 2C^2 \|n_0\|_{B^s_{p,r}} t_2}\right)^{1/2}$$

Plugging (3.4) into (3.2) yields

$$\|n^{k+1}(t)\|_{B_{p,r}^{s}}$$

$$\leq (1 - 2C^{2} \|n_{0}\|_{B_{p,r}^{s}} t)^{1/2} \left( C \|n_{0}\|_{B_{p,r}^{s}} + \int_{0}^{t} C(1 - 2C^{2} \|n_{0}\|_{B_{p,r}^{s}} \tau)^{1/2} \frac{C^{2} \|n_{0}\|_{B_{p,r}^{s}}}{(1 - 2C^{2} \|n_{0}\|_{B_{p,r}^{s}} \tau)^{2}} d\tau \right)$$

$$\leq \frac{C \|n_{0}\|_{B_{p,r}^{s}}}{1 - 2C^{2} \|n_{0}\|_{B_{p,r}^{s}} t}$$

Therefore,  $(n^k)_{k\in\mathbb{N}}$  is uniformly bounded in  $C([0,T];B^s_{p,r})$ . According to the system  $(T_k)$  and Lemma 2.11 and Lemma 2.12, we can deduce that  $\{n^k\}_{k\in\mathbb{N}}$  is uniformly bounded in  $E^s_{p,r}(T)$ .

#### Step 2: Convergence and Regularity.

We will claim that  $\{n^k\}_{k\in\mathbb{N}}$  is a Cauchy sequence in  $C([0,T];B^{s-1}_{p,r})$ , if  $\{s\geq \frac{1}{2}, p>2, 1\leq r\leq \infty\}$  or  $\{s>\frac{1}{p}, 1\leq p\leq 2, 1\leq r\leq \infty\}$ ; or of  $C([0,T];B^{\frac{1}{p}-1}_{p,\infty})$  if  $\{1\leq p\leq 2, s=\frac{1}{p}, r=1\}$ .

Indeed, for all  $k, p \in \mathbb{R}$ , taking the difference between the system  $(T_{k+p})$  and  $T_k$ , and denote  $w^{k,p} = n^{k+p} - n^k$ , we have

$$(3.6) \begin{cases} (\partial_t - 4(v_x^{k+p} + 2\beta_0 v^{k+p}))\partial_x w^{k+1,p} \\ = -4(v_x^{k+p} - v_x^k)n_x^{k+1} - 8\beta_0(v^{k+p} - v^k)n_x^{k+1} - 4(n^{k+p} - n^k)(n^{k+p} + n^k) \\ -16\beta_0^2 \left( (v^{k+p} - v^k)n^{k+p} + v^k(n^{k+p} - n^k) \right) + 8\beta \left( (v_x^{k+p} - v_x^k)n_x^{k+p} + (n^{k+p} - n^k)v_x^k \right) \\ w^{k+1,p}|_{t=0} = S_{k+p+1}n_0 - S_{k+1}n_0 \end{cases}$$

Case1:  $s \ge \frac{1}{2}, p > 2, 1 \le r \le \infty$  or  $s > \frac{1}{p}, 1 \le p \le 2, 1 \le r \le \infty$ 

First, estimate the left-hand side of system (3.6) in  $B_{p,r}^{s-1}$ . In fact, by Lemma2.6 and Lemma2.4, we can see

$$\begin{split} &\|(v_x^{k+p}-v_x^k)n_x^{k+1}\|_{B^{s-1}_{p,r}} \leq C\|v_x^{k+p}-v_x^k\|_{L^\infty}\|n_x^{k+1}\|_{B^{s-1}_{p,r}} + C\|v_x^{k+p}-v_x^k\|_{B^s_{p,r}}\|n_x^{k+1}\|_{B^{-1}_{p,r}} \\ &\quad + C\|v_x^{k+p}-v_x^k\|_{B^s_{p,r}}\|n_x^{k+1}\|_{B^{\frac{1}{p}-1}_{p,r}} \leq C\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}}\|n^{k+1}\|_{B^{s-1}_{p,r}} \\ &\|(v^{k+p}-v^k)n_x^{k+1}\|_{B^{s-1}_{p,r}} \leq C\|v^{k+p}-v^k\|_{L^\infty}\|n_x^{k+1}\|_{B^{\frac{1}{p}-1}_{p,r}} + C\|v^{k+p}-v^k\|_{B^s_{p,r}}\|n_x^{k+1}\|_{B^{-1}_{\infty,\infty}} \\ &\quad + C\|v^{k+p}-v^k\|_{B^s_{p,r}}\|n_x^{k+1}\|_{B^{\frac{1}{p}-1}_{p,r}} \leq C\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}}\|n^{k+1}\|_{B^s_{p,r}} \\ &\|(n^{k+p}-n^k)(n^{k+p}+n^k)\|_{B^{s-1}_{p,r}} \leq C\|n^{k+p}+n^k\|_{L^\infty}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} + C\|n^{k+p}+n^k\|_{B^s_{p,r}}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} \\ &\quad + C\|n^{k+p}+n^k\|_{B^s_{p,r}}\|n^{k+p}-n^k\|_{B^s_{p,r}} + C\|v^{k+p}-v^k\|_{B^s_{p,r}}\|n^{k+p}\|_{B^{s-1}_{p,r}} \\ &\quad \leq C\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} (\|n^{k+p}\|_{B^s_{p,r}} + C\|v^{k+p}-v^k\|_{B^s_{p,r}}\|n^{k+p}\|_{B^{s-1}_{\infty,\infty}} \\ &\quad + C\|v^{k+p}-v^k\|_{B^s_{p,r}}\|n^{k+p}\|_{B^{s-1}_{p,r}} + C\|v^{k+p}-v^k\|_{B^s_{p,r}}\|n^{k+p}\|_{B^{s-1}_{p,r}} \\ &\quad \|v^k(n^{k+p}-n^k)\|_{B^{s-1}_{p,r}} \leq C\|v^k\|_{L^\infty}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} + C\|v^k\|_{B^s_{p,r}}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} \\ &\quad \|(v^{k+p}-v^k)n^{k+p}\|_{B^{s-1}_{p,r}} \leq C\|v^k\|_{L^\infty}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} \leq C\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}}\|n^{k+p}\|_{B^s_{p,r}} \\ &\quad \|(v^{k+p}-v^k)n^{k+p}\|_{B^{s-1}_{p,r}} \leq C\|v^k\|_{L^\infty}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} \leq C\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}}\|n^{k+p}\|_{B^s_{p,r}} \\ &\quad \|(n^{k+p}-v^k)n^{k+p}\|_{B^{s-1}_{p,r}} \leq C\|v^k\|_{L^\infty}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} + C\|v^k\|_{B^s_{p,r}}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} \\ &\quad \|(n^{k+p}-n^k)v^k_x\|_{B^{s-1}_{p,r}} \leq C\|v^k\|_{L^\infty}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} + C\|v^k\|_{B^s_{p,r}}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} \\ &\quad \|(n^{k+p}-n^k)v^k_x\|_{B^{s-1}_{p,r}} \leq C\|v^k\|_{L^\infty}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} + C\|v^k\|_{B^s_{p,r}}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} \\ &\quad \|(n^{k+p}-n^k)v^k_x\|_{B^{s-1}_{p,r}} \leq C\|v^k\|_{L^\infty}\|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} + C\|v^k\|_{B^s_{p,r}} \|n^{k+p}-n^k\|_{B^{s-1}_{p,r}} \\ &\quad \|(n^{k+p}$$

Also we can obtain

$$||S_{k+p+1}n_0 - S_{k+1}n_0||_{B_{p,r}^{s-1}} \le C \left( \sum_{l=k}^{k+p} 2^{-lr} 2^{lsr} ||\Delta_l n_0||_{L^p}^r \right)^{\frac{1}{r}} \longrightarrow 0 (k \to \infty)$$

Now, recalling (3.4) and the uniform bound estimates of  $||n^k||_{B_{p,r}^s}$ , and making use of Lemma2.11 or Lemma2.12 to the system (3.6), we have

$$\|w^{k+1,p}\|_{B_{p,r}^{s-1}} \le C_T(2^{-k} + \int_0^t \|w^{k,p}(\tau)\|_{B_{p,r}^{s-1}} d\tau)$$

where  $C_T = C(s, p, r, T, \beta_0, ||v_0||_{B^s_{p,r}})$  is a constant, then by induction as k tends to  $\infty$ 

$$\begin{split} \|w^{k+1,p}\|_{B^{s-1}_{p,r}} &\leq \sum_{l=0}^{p} \|w^{k+l+1,1}\|_{B^{s-1}_{p,r}} \leq \sum_{l=0}^{p} C_{T}(2^{-(k+l)} + \int_{0}^{t} C_{T}(2^{-(k+l-1)} + \int_{0}^{t_{1}} \|w^{k+l,1}\|_{B^{s-1}_{p,r}} dt_{2}) dt_{1}) \\ &\leq \sum_{l=0}^{p} C_{t}(2^{-(k+l)} \sum_{m=0}^{k+l} \frac{(2TC_{T})^{m}}{m!} + (C_{T})^{k+l+1} \int_{0}^{t} \frac{(t-\tau)^{k+l+1}}{(k+l+1)!} d\tau) \\ &\leq \sum_{l=0}^{p} \left( C_{T}2^{-(k+l)} e^{2TC_{T}} + C_{T} \frac{(TC_{T})^{k+l+1}}{(k+l+1)!} \right) \leq C_{T}2^{-k+1} e^{2TC_{T}} + \sum_{m=k+1}^{k+p+1} C_{T} \frac{(TC_{T})^{m}}{m!} \longrightarrow 0 \end{split}$$

which means  $(n^k)_{k\in\mathbb{N}}\subset E^s_{p,r}(T)$ , and by Fatou's property, we obtain that  $n\in L^\infty([0,T];B^s_{p,r})$ .

Now for any test function  $\phi \in C([0,T];\mathcal{S})$  in the system  $(T_k)$ , applying Prop2.8, and taking the limits, it is not hard to check that n is a solution to the system (1.1).

According to Lemma 2.13,  $n \in C([0,T]; B_{p,r}^s)$ , and by system (1.1), we can get that  $n_t \in C([0,T]; B_{p,r}^{s-1})$ , thus  $n \in E_{p,r}^s(T)$ .

**Case2:**  $s = 1/p, 1 \le p \le 2$  and r = 1

Since the critical index  $s-1=-(1-\frac{1}{p})=-\min(\frac{1p}{p},\frac{1p'}{p})$ , we can only apply Lemma2.11 in the stage space  $B_{p,\infty}^{\frac{1}{p}-1}$ . And noticing that  $B_{p,1}^{\frac{1}{p}}\hookrightarrow B_{p,1}^{\frac{1}{p}-1}\hookrightarrow B_{p,\infty}^{\frac{1}{p}-1}$ , and applying Lemma2.6 to the system (3.6)

$$\begin{split} \|(v^{k+p}-v^k_x)n^{k+1}_x\|_{B^{\frac{1}{p}-1}_{p,\infty}} &\leq C\|v^{k+p}_x-v^k_x\|_{L^\infty}\|n^{k+1}_x\|_{B^{\frac{1}{p}-1}_{p,\infty}} + C\|v^{k+p}_x-v^k_x\|_{B^{\frac{1}{p}}_{p,\infty}}\|n^{k+1}_x\|_{B^{-1}_{p,\infty}} \\ &+ C\|v^{k+p}_x-v^k_x\|_{B^{\frac{1}{p}}_{p,1}}\|n^{k+1}\|_{B^{-\frac{1}{p}}_{p,\infty}} \leq C\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,1}}\|n^{k+1}\|_{B^{\frac{1}{p}}_{p,\infty}} \\ &\|(v^{k+p}-v^k)n^{k+1}_x\|_{B^{\frac{1}{p}-1}_{p,\infty}} \leq C\|v^{k+p}-v^k\|_{L^\infty}\|n^{k+1}\|_{B^{-\frac{1}{p}-1}_{p,\infty}} + C\|v^{k+p}-v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}}\|n^{k+1}_x\|_{B^{-\infty}_{p,\infty}} \\ &+ C\|v^{k+p}-v^k\|_{B^{\frac{1}{p}}_{p,1}}\|n^{k+1}\|_{B^{-\frac{1}{p}-1}_{p,\infty}} \leq C\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,1}}\|n^{k+1}\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &+ C\|v^{k+p}-v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \leq C\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}}\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &+ C\|n^{k+p}+n^k\|_{B^{-\frac{1}{p}+1}_{p,\infty}} + C\|n^{k+p}+n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^{k+p}-n^k\|_{B^{-1}_{p,\infty}} \\ &+ C\|n^{k+p}+n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} + C\|n^{k+p}+n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &\leq C\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &\leq C\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} + C\|v^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &+ C\|v^{k+p}-v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} + C\|v^{k+p}-v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^{k+p}\|_{B^{-1}_{p,\infty}} \\ &+ C\|v^{k+p}-v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} + C\|v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \leq C\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^{k+p}\|_{B^{-1}_{p,\infty}} \\ &+ C\|v^k\|_{B^{-\frac{1}{p}+1}_{p,\infty}} \|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \leq C\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &+ C\|v^k\|_{B^{-\frac{1}{p}-1}_{p,\infty}} \leq C\|v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &+ C\|v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \leq C\|v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &+ C\|v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \leq C\|n^{k+p}-n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \\ &+ C\|v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \leq C\|v^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}} \|n^k\|_{B^{\frac{1}{p}-1}_{p,\infty}$$

Also we can obtain the initial data of system (3.6) satisfies

$$||S_{k+p+1}n_0 - S_{k+1}n_0||_{B_{p,\infty}^{\frac{1}{p}-1}} \le C \sum_{l=k}^{k+p+1} 2^{l(1/p-1)} ||\Delta_l n_0||_{L^p} \le C 2^{-k} ||n_0||_{B_{p,1}^{\frac{1}{p}-1}} \longrightarrow 0 (k \to \infty)$$

Since  $B_{p,1}^{\frac{1}{p}} \hookrightarrow B_{p,\infty}^{\frac{1}{p}}$  and  $B_{p,1}^{\frac{1}{p}} \hookrightarrow L^{\infty}$ , we obtain the estimate of the flow

$$\int_0^t \|4\partial_x (v_x^{k+p} + 2\beta_0 v^{k+p})\|_{B_{p,\infty}^{1/p} \cap L^{\infty}} d\tau \le C \int_0^t \|n^{k+p}\|_{B_{p,1}^{1/p}} d\tau$$

According to the logarithm interpolation of Lemma 2.3, and the uniform bound of  $\{n^k\}_{k\in\mathbb{N}}$ , we obtain

$$\|w^{k+1,p}\|_{B_{p,\infty}^{\frac{1}{p}-1}} \le C_T \left( 2^{-k} + \int_0^t \|w^{k,p}\|_{B_{p,\infty}^{\frac{1}{p}-1}} \log \left( e + \frac{1}{\|w^{k,p}\|_{B_{p,\infty}^{\frac{1}{p}-1}}} \right) d\tau \right)$$

denote that  $w_k(t) = \sup_{\tau \in [0,t], p \in \mathbb{N}} \|(n^{k+p} - n^k)(\tau)\|_{B_{p,\infty}^{\frac{1}{p}-1}}$ , then we have

$$w_{k+1}(t) \le C_T \left(2^{-k} + \int_0^t w_k(\tau) log\left(e + \frac{1}{w_k(\tau)}\right) d\tau\right)$$

Note that  $\{w_k\}_{k\in\mathbb{N}}$ , thus it is obvious that  $\mu(x) = C_T x \log(e + \frac{1}{x})$  is an Osgood modulus of continuity. Applying Lesbesgue-Fatou's lemma in real analysis, we conclude that, for  $\forall t \in [0, T]$ 

$$\limsup_{k \to \infty} w_k(t) \le \int_0^t \mu(\limsup_{k \to \infty} w_k(\tau)) d\tau$$

Hence according to the Osgood lemma, we have

$$\limsup_{k \to \infty} w_k(t) = 0, \ t \in [0, T]$$

which implies that  $n^k{}_{k\in\}_{k\in\mathbb{N}}}$  is a Cauchy sequence in the space  $C([0,T];B^{1/p-1}_{p,\infty})$  and converges to the limit function  $n\in C([0,T];B^{1/p}_{p,\infty})$ . Along the same line of Case1, similarly we deduce that n is a solution to (1.1) and  $n\in E^{\frac{1}{p}}_{p,1}(T)$ .

#### Step 3: Uniqueness.

Suppose  $n_1, n_2$  are two solutions of (1.1) with initial data  $n_{10}$  and  $n_{20}$  respectively. Denoting  $w \triangleq n_1 - n_2$ , we have

(3.7) 
$$\begin{cases} (\partial_t - 4(v_{1x} + 2\beta_0 v_1))\partial_x w \\ = -4(v_{1x} - v_{2x})n_{2x} - 8\beta_0(v_1 - v_2)n_{2x} - 4(n_1 - n_2)(n_1 + n_2) \\ -16\beta_0^2 ((v_1 - v_2)n_1 + v_2(n_1 - n_2)) + 8\beta ((v_{1x} - v_{2x})n_1 + (n_1 - n_2)v_{1x}) \\ v_1 = (4\beta_0^2 - \partial_x^2)^{-1}n_1, \ v_2 = (4\beta_0^2 - \partial_x^2)^{-1}n_2 \\ w|_{t=0} = n_{10} - n_{20} \end{cases}$$

If  $s \ge 1/2, p > 2$  or  $s > 1/p, 1 \le p \le 2$ , along the same computation in step 2,  $\forall t \in [0, T]$ , we have inequality

$$e^{-C\int_0^t \|n_1\|_{B^s_{p,r}} d\tau} \|w(t)\|_{B^{s-1}_{p,r}} \le \|w_0\|_{B^{s-1}_{p,r}} + C\int_0^t e^{-C\int_0^{t'} \|n_10\|_{B^s_{p,r}} d\tau} \|w(t')\|_{B^{s-1}_{p,r}} (\|n_1\|_{B^s_{p,r}} + \|n_2\|_{B^s_{p,r}}) dt'$$

By Gronwall's inequality

$$||w(t)||_{B_{p,r}^{s-1}} \le ||w_0||_{B_{p,r}^{s-1}} \exp\left(C \int_0^t ||n_1||_{B_{p,r}^s} + ||n_2||_{B_{p,r}^s} d\tau\right)$$

If  $s = 1/p, 1 \le p \le 2, r = 1$ , similar to step 2, we have inequality

$$e^{-C\int_0^t \|n_1\|_{B^{1/p}_{p,1}} \mathrm{d}\tau} \|w(t)\|_{B^{\frac{1}{p}-1}_{p,\infty}}$$

$$\leq \|w_0\|_{\dot{B}_{p,\infty}^{\frac{1}{p}-1}} + C \int_0^t e^{-C \int_0^{t'} \|n_1\|_{\frac{1}{B_{p,1}^{p}}} d\tau} \|w(t')\|_{\dot{B}_{p,\infty}^{\frac{1}{p}-1}} (\|n_1\|_{\dot{B}_{p,1}^{\frac{1}{p}}} + \|n_2\|_{\dot{B}_{p,1}^{\frac{1}{p}}}) \log \left(e + \frac{\|n_1\|_{\dot{B}_{p,1}^{\frac{1}{p}}} + \|n_2\|_{\dot{B}_{p,1}^{\frac{1}{p}}}}{\|w(t)\|_{\dot{B}_{p,\infty}^{\frac{1}{p}-1}}} \right) dt'$$

denote  $h(t) \triangleq \|w(t)\|_{B_{p,\infty}^{1/p-1}} e^{-C\int_0^t \|n_1\|_{B_{p,1}^{1/p}} d\tau} / \left( \|n_1\|_{L_T^{\infty}(B_{p,1}^{1/p})} + \|n_2\|_{L_T^{\infty}(B_{p,1}^{1/p})} \right)$  and  $|h(t)| \leq 1$ , obviously, since

$$x\log(e+\frac{1}{x}) \le x(2-\log x), \ \forall x \in [0,1]$$

then we have

$$h(t) \le h(0) + C \int_0^t h(\tau) (\|n_1\|_{L_T^{\infty}(B_{p,1}^{1/p})} + \|n_2\|_{L_T^{\infty}(B_{p,1}^{1/p})})^2 (2 - \log h(\tau)) d\tau$$

Since  $\mu(x) = x(2 - \log x)$  is an Osgood modulus of continuity on [0, 1], then by Osgood lemma, we get inequality

$$\int_{h(0)}^{h(t)} \frac{\mathrm{d}r}{r(2 - \log r)} \le C \int_0^t (\|n_1\|_{L_T^{\infty}(B_{p,1}^{1/p})} + \|n_2\|_{L_T^{\infty}(B_{p,1}^{1/p})})^2 \mathrm{d}\tau$$

then by the definition of h, we have

$$||n_1 - n_2||_{L_T^{\infty}(B_{p,1}^{1/p-1})}$$

$$(3.9) \leq e^{2}(\|n_{1}\|_{L_{T}^{\infty}(B_{p,1}^{1/p})} + \|n_{2}\|_{L_{T}^{\infty}(B_{p,1}^{1/p})}) \exp(C \int_{0}^{t} \|n_{1}\|_{L_{T}^{\infty}(B_{p,1}^{1/p})} + \|n_{2}\|_{L_{T}^{\infty}(B_{p,1}^{1/p})} d\tau)$$

$$\times (\|n_{10} - n_{20}\|_{(B_{p,\infty}^{1/p-1})})^{\exp(-C \int_{0}^{t} \|n_{1}\|_{L_{T}^{\infty}(B_{p,1}^{1/p})} + \|n_{2}\|_{L_{T}^{\infty}(B_{p,1}^{1/p})} d\tau)}$$

Then the uniqueness of solution n to the system (1.1) in the space  $E_{p,r}^p(T)$  follows from (3.8) and (3.9).

#### Step 4: Continuous Dependence.

Now according to Lemma2.14, denote  $\bar{\mathbb{N}} = \mathbb{N} \cup \{\infty\}$ . suppose  $n^k \in C([0,T]; B^s_{p,r})$  is the solution to (1.1) with initial data  $n^k_0 \in B^s_{p,r}$ , then we have a sequence of systems

$$\begin{cases} \partial_t n^k - 4(v_x^k + 2\beta_0 v^k) \partial_x n^k = f^k \\ n^k = 4\beta_0^2 v^k - v_{xx}^k \\ n^k|_{t=0} = n_0^k \end{cases}$$

with  $f^{k} \triangleq 16\beta_{0}^{2}v^{k}n^{k} - 4(n^{k})^{2} + 8\beta v_{x}^{k}n^{k}$ .

Next we claim that if  $n_0^k \to n_0^\infty$  in  $B_{p,r}^s$  when k tends to  $\infty$ , then  $n^k \to n^\infty$  in  $C([0,T]; B_{p,r}^s)$  with T satisfying  $2C^2 \sup_{k \in \mathbb{N}} \|n_0^k\|_{B_{p,r}^s} T < 1$ .

(1) r; $\infty$ . Decompose  $n^k$  into  $n^k = y^k + z^k$ , and satisfy

$$\begin{cases} \partial_t y^k - 4(v_x^k + 2\beta_0 v^k) \partial_x y^k = f^{\infty} \\ y^k|_{t=0} = n_0^k \end{cases} \text{ and } \begin{cases} \partial_t z^k - 4(v_x^k + 2\beta_0 v^k) \partial_x z^k = f^k - f^{\infty} \\ z^k|_{t=0} = n_0^k - n_0^{\infty} \end{cases}$$

Denote  $m = \sup_{k \in \mathbb{N}} \|n_0^k\|_{B_{p,r}^s}$ , and letting  $M = \frac{Cm}{1-2C^2mT}$ , according to the proof of the existence, we get that

$$||n^k(t)||_{B^s_{p,r}} \leq M \quad \forall t \in [0,T]$$

Hence,  $(f)^{k_{k\in\}_{k\in\mathbb{N}}}$  is uniformly bounded in  $C([0,T];B_{p,r}^{s})$  and

$$||v_x^k + 2\beta_0 v^k||_{B_{n,r}^{s+1}} \le C||v^k||_{B_{n,r}^{s+2}} \le C||n^k||_{B_{n,r}^s} \le CM$$

also it is obvious that

$$\|(v^k - v^{\infty})_x + 2\beta_0(v^k - v^{\infty})\|_{B_{p,r}^{s+1}} \le C\|n^k - n^{\infty}\|_{B_{p,r}^s}$$

similar to the proof of the uniqueness, since  $n_0^k \to n_0^\infty$  in  $B_{p,r}^s$ , then we have  $n^k \to n^\infty$  in  $L^1([0,T];B_{p,r}^{s-1}) \Rightarrow v_x^k + 2\beta_0 v^k \to v_x^\infty + 2\beta_0 v^\infty$  in  $L^1([0,T];B_{p,r}^s)$ . Then by Lemma2.14

$$y^k \to n^{\infty}$$
 in  $C([0,T]; B^s_{p,r})$  as  $k \to \infty$ 

To control  $z^k$ , we need to estimate  $f^k - f^{\infty}$ , by Lemma2.6, we have

$$||f^k - f^{\infty}||_{B^s_{p,r}} \le C(||n^k||_{B^s_{p,r}} + ||n^{\infty}||_{B^s_{p,r}})||n^k - n^{\infty}||_{B^s_{p,r}}$$

then according to Lemma2.11

$$||z^k||_{B_{p,r}^s} \le Ce^{CMT}(||n_0^k - n_0^\infty||_{B_{p,r}^s} + \int_0^t ||(n^k - n^\infty)(\tau)||_{B_{p,r}^s} d\tau)$$

Therefore, we have  $\forall \varepsilon > 0$ ,  $\exists N_1$  large enough, when  $k > N_1$ ,  $||y^k - n^{\infty}||_{B^s_{n,r}} < \varepsilon$ , then

$$\|n^k - n^{\infty}\|_{B_{p,r}^s} \le \|z^k\|_{B_{p,r}^s} + \|y^k - n^{\infty}\|_{B_{p,r}^s} \le \varepsilon + Ce^{CMT}(\|n_0^k - n_0^{\infty}\|_{B_{p,r}^s} + \int_0^t \|(n^k - n^{\infty})(\tau)\|_{B_{p,r}^s} d\tau)$$

by Gronwall's inequality,  $\forall t \in [0, T]$ 

$$||n^k - n^{\infty}||_{B_{p,r}^s} \le C(\varepsilon + ||n_0^k - n_0^{\infty}||_{B_{p,r}^s})$$

Hence we gain the continuity of the system (1.1) in  $C([0,T];B_{p,r}^s)$  with respect to the initial data in  $B_{p,r}^s$ .

(2)  $r = \infty$ . Similar to Step2, we have  $||n^k - n^{\infty}||_{L^{\infty}([0,T];B^{s-1}_{p,\infty})} \to 0 (k \to \infty)$ . Then  $\forall \phi \in B^{-s}_{p',1}$ , we have

$$\langle n^k - n^{\infty} \rangle = \langle S_j(n^k - n^{\infty}), \phi \rangle + \langle (Id - S_j)(n^k - n^{\infty}), \phi \rangle = \langle n^k - n^{\infty}, S_j \phi \rangle + \langle n^k - n^{\infty}, (Id - S_j)\phi \rangle$$

and

$$|\langle n^k - n^{\infty}, (Id - S_j)\phi\rangle| \le CM \|\phi - S_j\phi\|_{B_{p',1}^{-s}}$$
 and  $|\langle n^k - n^{\infty}, S_j\phi\rangle| \le \|n^k - n^{\infty}\|_{B_{p,\infty}^{s-1}} \|S_j\phi\|_{B_{p',1}^{1-s}}$ 

by Lemma2.3, we can conclude that  $\langle n^k - n^{\infty}, \phi \rangle \to 0$  as  $k \to 0$  for  $r = \infty$ . Thus we gain the continuity of the system (1.1) in  $C_w([0,T]; B_{p,\infty}^s)$  with respect to the initial data in  $B_{p,\infty}^s$ .

## 4 Blow-up criterion

We can use the method introduced by Zhang and Yin[?] to obtain a blow-up criterion as follows.

**Theorem 4.1.** Let  $n_0 \in B^s_{p,r}$  with  $1 \le p,r \le \infty$ , and (s,p,r) satisfy condition (3.1) and let T > 0 be the maximal existence time of the corresponding solution n to (1.1). If  $T < \infty$ , then we have

$$\int_0^T \|n(t)\|_{L^\infty} \mathrm{d}t$$

*Proof.* For simplicity, consider the case  $1 . For all <math>\sigma$  satisfies  $0 < \sigma \le s$ , according to the product laws, since  $\|v\|_{L^{\infty}} \le C\|n\|_{L^{\infty}}$  and  $\|v\|_{B^{\sigma}_{p,r}} \le C\|n\|_{B^{\sigma}_{p,r}}$ , we have

$$(4.1) ||16\beta_0^2 v n - 4n^2 + 8\beta_0 v_x n||_{B_{p,r}^{\sigma}} \le C||n||_{L^{\infty}} ||n||_{B_{p,r}^{\sigma}}$$

(1)  $\sigma \in (0,1)$ .

Applying Lemma 2.11 with  $p_1 = \infty$ , then

$$||n(t)||_{B_{p,r}^{\sigma}} \leq ||n_0||_{B_{p,r}^{\sigma}} + C \int_0^t ||n(\tau)||_{B_{p,r}^{\sigma}} ||n(\tau)||_{L^{\infty}} d\tau + \int_0^t CV_{p_1}' ||n(\tau)||_{B_{p,r}^{\sigma}} d\tau$$

with

$$V'_{p_1}(t) = \|4(v_x + 2\beta_0 v)_x\|_{B^0_{\infty,\infty} \cap L^\infty} \le C\|n\|_{L^\infty}$$

by Gronwall's inequality

$$||n(t)||_{B_{p,r}^{\sigma}} \le ||n_0||_{B_{p,r}^{\sigma}} \exp(C \int_0^t ||n(\tau)||_{L^{\infty}} d\tau)$$

which implies

(4.2) 
$$\int_0^T \|n(\tau)\|_{L^{\infty}} d\tau < \infty \Longrightarrow \|n\|_{L^{\infty}_T(B^{\sigma}_{p,r})} < \infty$$

(2)  $\sigma = 1$ 

Applying Lemma 2.11 with  $p = p_1$ , and

$$V'_{p_1} = \|4(v_x + 2\beta_0 v_x)\|_{B^{1/p}_{p,\infty} \cap L^{\infty}} \le C(\|v\|_{L^{\infty}} + \|v\|_{B^{1/p+2}_{p,\infty}}) \le C(\|n\|_{L^{\infty}} + \|n\|_{B^{1/p}_{p,x}})$$

then we have

$$\|n(t)\|_{B_{p,r}^{1}} \leq \|n_{0}\|_{B_{p,r}^{1}} + C \int_{0}^{t} \|n(\tau)\|_{B_{p,r}^{1}} \|n(\tau)\|_{L^{\infty}} d\tau + C \int_{0}^{t} (\|n(\tau)\|_{L^{\infty}} + \|n(\tau)\|_{B_{p,r}^{1/p}}) \|m(\tau)\|_{B_{p,r}^{1}} d\tau$$

by Gronwall's inequality

(4.3) 
$$||n(t)||_{B_{p,r}^1} \le C||n_0||_{B_{p,r}^1} \exp(C\int_0^t ||n(\tau)||_{L^\infty} + ||n(\tau)||_{B_{p,r}^{1/p}} d\tau)$$

which implies

(3)  $\sigma > 1$ 

According to (4.1) and Lemma 2.11 with  $p_1 = \infty$ , and

$$V'_{p_1}(t) = \|4(v_x + 2\beta_0 v_x)\|_{B^{\sigma-1}_{\infty,r}} \le C\|v\|_{B^{\sigma+1}_{\infty,r}} \le C\|n\|_{B^{\sigma-1+1/p}_{\infty,r}}$$

then we have

$$||n(t)||_{B_{p,r}^{\sigma}} \leq ||n_0||_{B_{p,r}^{\sigma}} + C \int_0^t ||n(\tau)||_{B_{p,r}^{\sigma}} ||n(\tau)||_{L^{\infty}} d\tau + C \int_0^t ||n(\tau)||_{B_{p,r}^{\sigma-1+1/p}} ||n(\tau)||_{B_{p,r}^{\sigma}} d\tau$$

by Gronwall's inequality

$$||n(t)||_{B_{p,r}^{\sigma}} \le ||n_0||_{B_{p,r}^{\sigma}} \exp(C \int_0^t ||n(\tau)||_{L^{\infty}} + ||n(\tau)||_{B_{p,r}^{\sigma-1+1/p}} d\tau)$$

which implies

$$\|n\|_{L^\infty_T(B^{\sigma-1+1/p}_{p,r})}<\infty \quad \text{and} \quad \int_0^T \|n(\tau)\|_{L^\infty}\mathrm{d}\tau<\infty \Longrightarrow \|n\|_{L^\infty_T(B^{\sigma}_{p,r})}<\infty$$

If  $\sigma - 1 + \frac{1}{p} > 1$ , we can repeat the above process. Indeed, since

$$||4(v_x + 2\beta_0 v)_x||_{B_{\infty,r}^{\sigma-1+1/p-1}} \le C||v||_{B_{\infty,r}^{\sigma+1/p}} \le C||n||_{B_{p,r}^{\sigma-2+2/p}}$$

we similar have

$$||n||_{L_T^{\infty}(B_{p,r}^{\sigma-2+1/p})} < \infty \text{ and } \int_0^T ||n(\tau)||_{L^{\infty}} d\tau < \infty \Longrightarrow ||n||_{L_T^{\infty}(B_{p,r}^{\sigma-1+1/p})} < \infty$$

By induction, we can choose  $k \in \mathbb{N}^+$  such that  $0 < \sigma - k(1 - /frac1p) \le 1$ , and  $B_{p,r}^1 \hookrightarrow B_{p,r}^{\sigma - k(1 - \frac{1}{p})}$ , gives that

$$\|n\|_{L^{\infty}_{T}(B^{1}_{p,r})} \leq \infty \ \text{ and } \ \int_{0}^{T} \|n\|_{L^{\infty}} < \infty \Rightarrow \|n\|_{L^{\infty}_{T}(B^{\sigma-(k-1)(1-\frac{1}{p})}_{p,r})} < \infty \Rightarrow \cdots \Rightarrow \|n\|_{L^{\infty}_{T}(B^{\sigma}_{p,r})} < \infty$$

Therefore we can conclude that

$$\|n\|_{L^\infty_T(B^1_{p,r})} < \infty \quad \text{and} \quad \int_0^T \|n\|_{L^\infty} < \infty \Rightarrow \|n\|_{L^\infty_T(B^\sigma_{p,r})} < \infty$$

Return to  $L_T^{\infty}(B_{p,r}^s)$  and suppose  $\int_0^T \|n\|_{L^{\infty}} d\tau < \infty$ , we have:

Case1: s;1 By (1), we have  $||n||_{L_T^{\infty}(B_{n,r}^s)} < \infty$ .

**Case2:** s=1 By (1), we have  $||n||_{L^{\infty}_{T}(B^{1/p}_{p,r})} < \infty$  and by (2) we get that  $||n||_{L^{\infty}_{T}(B^{1}_{p,r})} < \infty$ .

Case3: s¿1 By (1), we have  $||n||_{L_T^{\infty}(B_{p,r}^{1/p})} < \infty$  and by (2) we get that  $||n||_{L_T^{\infty}(B_{p,r}^1)} < \infty$ , lastly by the induction in (3), we can deduce that  $||n||_{L_T^{\infty}(B_{p,r}^1)} < \infty$ .

Therefore  $\int_0^T \|n\|_{L^{\infty}} d\tau < \infty \Rightarrow \|n\|_{L^{\infty}(B^s_{p,r})} < \infty$ . Then by what we proved in Thm3.2,  $\exists T_0$  small enough such that for some suitable  $\varepsilon > 0$ ,  $2C^2 \|n(T-\varepsilon)\|_{B^s_{p,r}} T_0 < 1$ , then follow then same line of Step1 in the proof of Thm3.2, we can extend the solution n on  $[0,T) \times \mathbb{R}$  to  $\tilde{n}$  on  $[0,T-\varepsilon+T_0) \times \mathbb{R}$  and by the uniqueness  $n \equiv \tilde{n}$  for any  $t \in [0,T]$ .

Corollary 4.2. Let  $n_0 \in B_{p,r}^s$  with (s, p, r) satisfying (3.1), T > 0 be the maximal existence time of the corresponding solution  $n \in E_{p,r}^s(T_-)$  to system (1.1). Then n blows up in finite time if and only if

$$\limsup_{t \uparrow T} \|n\|_{L^{\infty}} = \infty$$

## 5 Blow-up

As we have the blow-up criterion, consider the following initial value problem

(5.1) 
$$\begin{cases} \psi_t(t,x) = -4(v_x + 2\beta_0 v)(t,\psi(t,x)), \ t \in [0,T] \\ \psi(0,x) = x \end{cases}$$

then the system (1.1) in Lagrangian coordinates can be written as

(5.2) 
$$\begin{cases} \partial_t n(t, \psi(t, x)) = (16\beta_0^2 v n - 4n^2 + 8\beta_0 v_x n)(t, \psi(t, x)) \\ n(0, \psi(0, x)) = n_0(x) \end{cases}$$

**Theorem 5.1.** Let  $n_0 \in B^s_{p,r}$  with (s,p,r) satisfying (3.1). There exists time  $T_1 = \frac{1}{32 \max(\beta_0^2, \beta_0^{-2}) \|v_0\|_{W^{1,\infty}}}$ , if  $\exists x_0 \in \mathbb{R}$  such that

$$(5.3) n_0(x_0) < -\sqrt{\frac{b}{2}} + \frac{\sqrt{2b}}{1 - \exp(2\sqrt{2b}T_1)} \text{wtih} b = (16\beta_0^2 ||v_0||_{L^{\infty}})^2 + (8\beta_0 ||v_{0x}||_{L^{\infty}})^2$$

then n will blow up within  $T_1$ .

More precisely, n will blow up at time  $T_2 = \frac{1}{2\sqrt{2b}} \log(\frac{\sqrt{2}n_0(x_0) - \sqrt{b}}{\sqrt{2}n_0(x_0) + \sqrt{b}})$ .

*Proof.* Since v is the solution of system (1.2), and  $v_x$  satisfies

$$\begin{cases} \partial_t(v_x) - (4v_x + 8\beta_0 v)\partial_x(v_x) = 8\beta_0(v_x)^2 - 16\beta_0^2 v v_x + 8\beta_0 \partial_x P_1(D)(2\beta_0^2 v^2 + v_x^2) + 8\beta_0^2 P_1(D)(4\beta_0^2 v^2 - v_x^2) \\ v_x|_{t=0} = v_{0x} \end{cases}$$

then we have estimates

(5.4) 
$$||v||_{W^{1,\infty}} \le ||v_0||_{W^{1,\infty}} + 8\max(\beta_0^2, \beta_0^{-2}) \int_0^t ||v(\tau)||_{W^{1,\infty}}^2 d\tau$$

Assume that  $||v(t)||_{W^{1,\infty}} \le 2||v_0||_{W^{1,\infty}}$  is satisfied for all  $t \in [0, T_1]$ , then by inequality (5.4), we have

$$\|v(t)\|_{W^{1,\infty}} \leq \|v_0\|_{W^{1,\infty}} + 32\max(\beta_0^2,\beta_0^{-2})t\|v_0\|_{W^{1,\infty}} 62 \leq 2\|v_0\|_{W^{1,\infty}}$$

Thus we have  $||v(t)||_{W^{1,\infty}} \le 2||v_0||_{W^{1,\infty}}$  for all  $t \in [0, T_1]$ .

Consider the system (5.2) for all  $t \in [0, T_1]$ , then it is obvious that for all  $(t, x_0) \in [0, T_1] \times \mathbb{R}$ 

$$|16\beta_0^2 v \cdot n| \le 32\beta_0^2 ||v_0||_{L^{\infty}} |n| \le (16\beta_0^2 ||v_0||_{L^{\infty}})^2 + n^2$$

and

$$|8\beta_0 v_x \cdot n| \le 16|\beta_0| ||v_{0x}||_{L^{\infty}} |n| \le (8\beta_0 ||v_{0x}||_{L^{\infty}})^2 + n^2$$

denote  $b = (16\beta_0^2 ||v_0||_{L^{\infty}})^2 + (8\beta_0 ||v_{0x}||_{L^{\infty}})^2$ , then according to (5.2), we have

$$\partial_t n(t, \psi(t, x_0)) \le -2n^2 + b$$

Consider the ordinary differential equation

$$f'(t) = -2f^2 + b, f(0) = n_0(x_0)$$

then we have

$$n(t, \psi(t, x_0)) \le \int_0^t f'(\tau) d\tau + n_0(x_0) = \sqrt{\frac{b}{2}} \cdot \frac{1 + Ce^{-2\sqrt{2b}t}}{1 - Ce^{-2\sqrt{2b}t}} \quad \text{with} \quad C = \frac{\sqrt{2}n_0(x_0) - \sqrt{b}}{\sqrt{2}n_0(x_0) + \sqrt{b}}$$

It is obvious that  $1 - Ce^{-2\sqrt{2b}t}$  is an increasing function, and by (5.3)

$$1 - C < 0$$
 and  $1 - Ce^{-2\sqrt{2b}T_1} > 0$  and  $1 - Ce^{-2\sqrt{2b}T_2} = 0$ 

then we can easily get that  $n(T_2, \psi(T_2, x_0)) = -\infty$  and  $T_2 < T_1$ . Therefore n will blow up at time  $T_2 = \frac{1}{2\sqrt{2b}} \log(\frac{\sqrt{2}n_0(x_0) - \sqrt{b}}{\sqrt{2}n_0(x_0) + \sqrt{b}})$ .

# 6 Existence of global solution

Similarly, we consider the initial value problem (5.1), applying classical results in the theory of ODEs, one can obtain the following results of  $\psi$ .

**Lemma 6.1.** [7] Let  $v_x + 2\beta_0 v \in C([0,T]; H^s(\mathbb{R})) \cap C^1([0,T]; H^{s-1}(\mathbb{R}))$ ,  $s \geq 2$ . Then the problem (5.1) has a unique solution  $\psi \in C^1([0,T] \times \mathbb{R})$ . Moreover, the map  $\psi(t,\cdot)$  is an increasing diffeomorphism of  $\mathbb{R}$  with  $\psi_x(0,x) = 1$  and

$$\psi_x(t,x) = \exp(\int_0^t -4(v_x + 2\beta_0 v)_x)(\tau, \psi(\tau, x) d\tau) > 0, \quad \forall (t,x) \in [0,T) \times \mathbb{R}$$

We then have the following sign-preserved result.

**Lemma 6.2.** Let  $n_0 \in H^s(\mathbb{R})$ ,  $s > \frac{1}{2}$  and  $n_0(x_0) \ge 0$ ,  $\forall x \in \mathbb{R}$ . Assume  $T_{n_0}$  is the maximal existence time of the solution n(t,x) to (1.1), then

$$n(t,x) \geq 0, \ \forall (t,x) \in [0,T_{n_0}) \times \mathbb{R}$$

*Proof.* From (1.1) we see that  $\forall x \in \mathbb{R}$ 

$$\frac{\mathrm{d}}{\mathrm{d}t}(n(t,\psi(t,x))\cdot\psi_x(t,x)) = n_t(t,\psi(t,x))\cdot\psi_x + n_x(t,\psi(t,x))\cdot\psi_t\psi_x + n(t,\psi(t,x))\cdot\psi_{tx}$$
$$= \psi_x\cdot(n_t - 4(n(v_x + 2\beta_0 v))_x) = 0$$

solving the ODE, we have

$$n(t, \psi(t, x)) \cdot \psi_x(t, x) = n_0(x) \cdot \psi_x(0, x)$$

Noticing  $n_0 \ge 0$  and  $\psi_x > 0$ , we get  $n(t, \psi(t, x)) \ge 0$ . Since  $\psi(t, x)$  is a diffeomorphism on  $\mathbb{R}$ , we completes the proof.

**Lemma 6.3.** Let  $n_0 \in H^s(\mathbb{R})$ ,  $s > \frac{1}{2}$  and  $n_0(x) \geq 0$ ,  $\forall x \in \mathbb{R}$ . Assume  $T_{n_0} > 0$  is the maximal existence time of the solution n(t,x) to (1.1) with initial data  $n_0$ . Then

$$v(t,x) \ge 0$$
 and  $|v_x(t,x)| \le 2|\beta_0|v(t,x) \le \sqrt{2}|\beta_0|||v||_{H^1}, \ \forall (t,x) \in [0,T_{n_0}) \times \mathbb{R}$ 

*Proof.* Since we have

$$v(t,x) = \frac{1}{4|\beta_0|} e^{-|2\beta_0 \cdot|} * n(t,x) \ge 0$$

and

$$|v_x(t,x)| = |\frac{1}{2}(-sgn(\cdot)e^{-|2\beta_0\cdot|} * n)(t,x)| \le 2|\beta_0|v(t,x)|$$

On the other hand, for almost  $\forall x \in \mathbb{R}$ , we have

$$2v^{2}(t,x) = \int_{-\infty}^{x} \frac{\mathrm{d}}{\mathrm{d}y}(v^{2}(t,y))\mathrm{d}y - \int_{x}^{\infty} \frac{\mathrm{d}}{\mathrm{d}y}(v^{2}(t,y))\mathrm{d}y = \int_{-\infty}^{x} 2v \cdot v_{y}(t,y)\mathrm{d}y - \int_{x}^{\infty} 2v \cdot v_{y}(t,y)\mathrm{d}y$$

$$\leq \int_{-\infty}^{x} + \int_{x}^{\infty} v^{2} + v_{y}^{2}\mathrm{d}y \leq \int_{-\infty}^{\infty} v^{2} + v_{y}^{2}\mathrm{d}y = \|v(t,\cdot)\|_{H^{1}}^{2}$$

**Lemma 6.4.** Let  $n_0 \in H^s(\mathbb{R})$ ,  $s > \frac{1}{2}$  and  $n_0(x) \geq 0$ ,  $\forall x \in \mathbb{R}$ . Define an equivalent norm  $H^1_{\beta_0}$  of  $H^1$ -norm:

$$||v||_{H^1_{\beta_0}} \triangleq (\int_{\mathbb{R}} (4\beta_0^2 + |\xi|^2) |\hat{v}(\xi)|^2 d\xi)^{1/2}$$

Then the  $H^1_{\beta_0}$ -norm of v in  $[0, T_{n_0})$  is non-increasing, namely, if  $0 \le t_1 \le t_2 < T_{n_0}$ 

$$||v(t_2)||_{H^1_{\beta_0}} \le ||v(t_1)||_{H^1_{\beta_0}} \le ||v_0||_{H^1_{\beta_0}}$$

*Proof.* Since  $n_0 \ge 0$ , according to Lemma6.3, it follows that  $v \ge 0$  and  $|v_x(t,x)| \le 2|\beta_0|v(t,x)$ . Hence for any  $t \in [0, T_{n_0})$ , we have

$$\begin{split} \frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{R}} 4\beta_0^2 v^2 + v_x^2 \mathrm{d}x &= 2 \int_{\mathbb{R}} 4\beta_0^2 v \cdot v_t + v_x \cdot v_{xt} \mathrm{d}x = 2 \int_{\mathbb{R}} v(4\beta_0^2 v_t - v_{xxt}) \mathrm{d}x \\ &= 8 \int_{\mathbb{R}} v[n(v_x + 2\beta_0 v)]_x \mathrm{d}x = -8 \int_{\mathbb{R}} v_x (4\beta_0^2 v - v_{xx})(v_x + 2\beta_0 v) \mathrm{d}x \\ &= -8 \int_{\mathbb{R}} 4\beta_0^2 v \cdot v_x^2 + 8\beta_0^3 v^2 \cdot v_x - v_x^2 v_{xx} - 2\beta_0 v \cdot v_x \cdot v_{xx} \mathrm{d}x \\ &= -8 \int_{\mathbb{R}} v_x^2 (4\beta_0^2 v + \beta_0 v_x) \mathrm{d}x = -8 \int_{\mathbb{R}} v_x^2 (|\beta_0| + \frac{\beta_0}{2} sgn(\cdot)) e^{-|2\beta_0 \cdot| * n \mathrm{d}x} \leq 0 \end{split}$$

Integrating the above inequality on  $[0, t_1]$  and  $[t_1, t_2]$  we have

$$||v(t_2)||_{H^1_{\beta_0}} \le ||v(t_1)||_{H^1_{\beta_0}} \le ||v_0||_{H^1_{\beta_0}}$$

**Theorem 6.5.** Let  $n_0 \in B_{2,2}^s$  with s > 1/2 and  $n_0 \ge 0$ , the system of (1.1) has a unique global solution, i.e.  $\forall T > 0, \ n \in E_{2,2}^s(T)$ .

*Proof.* Let  $\psi(t,x)$  satisfies the flow equation (5.1). Then by Lemma 6.3 and Sobolev embedding

$$\frac{\mathrm{d}}{\mathrm{d}t}(n(t,\psi(t,x))) \le (16\beta_0^2 v n - 4n^2 + 8\beta_0 v_x n)(t,\psi(t,x)) \le 32\beta_0^2 v \cdot n(t,\psi(t,x)) \le C\|v_0\|_{H^1} \cdot n(t,\psi(t,x))$$

by Gronwall's inequality we have

$$n(t, \psi(t, x)) \le n_0(x) \exp(C||v_0||_{H^1})$$

thus  $\forall T > 0$ , we have

$$\int_0^T \|n(t,\cdot)\|_{L^{\infty}} dt \le \int_0^T \|n_0\|_{L^{\infty}} \exp(C\|v_0\|_{H^1}) dt$$

Therefore by well-posedness and blow-up criterion of the system (1.1), we prove that

$$n \in E_{2,2}^s(T), \forall T > 0$$

## 7 Simulation

According to our blow up condition, we can construct an exact example of the system (1.1).

Let  $\beta_0 = 1$  and denote

$$f(x) = \begin{cases} \exp(-\frac{1}{1-x^2}) & |x| \le 1\\ 0 & |x| > 1 \end{cases}$$

taking  $n_0(x) = -20e \cdot f(20x)$ , it is obviously that  $||n_0||_{L^{\infty}} = 20$ . Since  $||n_0||_{L^1} \leq \frac{e}{2}$ , by Young's inequality we can get the rough estimate of  $v_0$  and  $v_{0x}$ 

$$||v_0||_{L^{\infty}} \le \frac{e}{8}, ||v_{0x}||_{L^{\infty}} \le \frac{e}{4}$$

then we can denote  $T_1 = \frac{1}{12e}$  and  $b = 8e^2$ .

It is obvious that

$$-\sqrt{\frac{b}{2}} + \frac{\sqrt{2b}}{1 - \exp(2\sqrt{2b}T_1)} \ge -2e - \frac{4e}{1 - \exp(3/4)} \ge -16 \ge n_0(0) = -20$$

then we have  $n_0$  will blow up within  $T_1 \approx 0.0307$ .




Figure 1: blow up

The solution of system (1.1) with the initial data  $n_0$  can be roughly expressed as Figure 1:

It is consistent with the approximate numerical calculation of blow up condition we have given.




Figure 2: global solution

And for  $n_0(x) = f(x)$ , it is easy to check that  $n_0 \in B_{2,2}^s$  for all s > 1/2 and  $n_0(x) \ge 0$ , the solution of system (1.1) with the initial data  $n_0$  can be roughly expressed as Figure 2:

It is consistent with the existence of the global solution. And the above figure of the solution v(t, x) is similar to the exact single peakon of the form[23]

$$v(t,x) = a_1 e^{-2\beta_0|x + 8\beta_0 a_1 t - a_2|}$$




Figure 3: single peakon solution with  $a_1 = a_2 = 1, \beta_0 = 1$
