# CHARACTERIZATIONS OF A LORENTZIAN MANIFOLD WITH A SEMI-SYMMETRIC METRIC CONNECTION

#### Abstract

In this article, we characterize a Lorentzian manifold $\mathcal{M}$ with a semisymmetric metric connection. At first, we consider a semi-symmetric metric connection whose curvature tensor vanishes and establish that if the associated vector field is a unit time-like torse-forming vector field, then $\mathcal{M}$ becomes a perfect fluid spacetime. Moreover, we prove that if $\mathcal{M}$ admits a semi-symmetric metric connection whose Ricci tensor is symmetric and torsion tensor is recurrent, then $\mathcal{M}$ represents a generalized Robertson-Walker spacetime. Also, we show that if the associated vector field of a semi-symmetric metric connection whose curvature tensor vanishes is a $f$ - Ric vector field, then the manifold is Einstein and if the associated vector field is a torqued vector field, then the manifold becomes a perfect fluid spacetime. Finally, we apply this connection to investigate Ricci solitons.


## 1. Introduction

In this study, we investigate several vector fields and solitons on a Lorentzian manifold $\mathcal{M}$ obeying a semi-symmetric metric connection (briefly, SSMC). The notion of a semi-symmetric linear connection was first introduced by Friedman and Schouten on a differentiable manifold many years ago. The concept of metric connection with torsion tensor $T$ was then presented by Hayden [16] in 1932 on a Riemannian manifold. Yano [23] made a methodical investigation of SSMC in 1970.

On a Lorentzian manifold $\mathcal{M}$, a linear connection $\nabla$ is named semi-symmetric if $T$ described by

obeys

[^0]where $\pi$ is defined by $\pi\left(U_{1}\right)=g\left(U_{1}, \xi\right)$, for a fixed vector field $\xi$ (also, named associated vector field ). If we replace $U_{1}$ and $V_{1}$, respectively, by $\phi U_{1}$ and $\phi V_{1}$ in the right side of (1.1), then the $\mathrm{SSMC} \nabla$ changes into a quarter-symmetric connection [13], $\phi$ being a (1,1)- tensor field.

Again, if a $\mathrm{SSMC} \nabla$ on $\mathcal{M}$ fulfills

then $\nabla$ is named metric [23], if not, it is non-metric [16].
We know [23] that if $\nabla$ is a SSMC and D be a Levi-Civita connection, then

Further, it is also known [23] that if $\bar{R}$ and $R$ denote the curvature tensors of $\nabla$ and D, respectively, then

where $L_{1}$, a $(0,2)$ tensor and $L_{2}$, a $(1,1)$ tensor are defined by

for any vector fields $U_{1}$ and $V_{1}$.
In a local coordinate system, equations (1.4) and (1.5) can be written as follows:

\pi_{i k}=\mathrm{D}_{i} v_{k}-v_{i} v_{k}+\frac{1}{2} g_{i k} v, \quad v=v^{h} v_{h} \tag{1.8}
\end{gather*}

in which $\bar{R}_{h i j k}$ and $R_{h i j k}$ denote the curvature tensor of $\nabla$ and D , respectively.
The idea of the SSMC was investigated by many researchers (see, [3], [23], 25], [26], [27], [28]).

The current paper concerns with n-dimensional spacetimes (that is, a connected time-oriented Lorentz manifold) $(\mathcal{M}, g)$. For $\psi>0$, a smooth function (also called scale factor, or warping function), if $\mathcal{M}=-I \times_{\psi}, \mathrm{M}$, where $I$ is the open interval of $\mathbb{R}, \mathrm{M}^{n-1}$ denotes the Riemannian manifold, then $\mathcal{M}$ is named a generalized Robertson-Walker (briefly, $G R W$ ) spacetime [1]. When the dimension of $\mathcal{M}$ is three
and of constant sectional curvature, this spacetime represents a Robertson-Walker (briefly, $R W$ ) spacetime. In this context we may mention the work of Ünal and Shenawy on warped product manifolds (21, [22]).

Due to the absence of a stress tensor and heat conduction terms corresponding to viscosity, the fluid is referred to as perfect and the energy momentum tensor $\mathcal{T}_{h k}$ is written by

in which $p$ and $\sigma$ stand for the perfect fluid's isotropic pressure and energy density, respectively [20].

For a gravitational constant $\kappa$, the Einstein's field equations without a cosmological constant is given by

where $R_{h k}=R_{h k i}^{i}$ and $R=g^{h k} R_{h k}$ are the Ricci tensor and the scalar curvature, respectively.

A spacetime $\mathcal{M}$ is named a perfect fluid (briefly $P F$ ) spacetime if the nonvanishing Ricci tensor $R_{h k}$ fulfills

where $\alpha$ and $\beta$ indicate smooth functions on $\mathcal{M}$. In the last equation, $g$ is the Lorentzian metric of $\mathcal{M}$ and $v_{h}$, the velocity vector is defined by $g_{h k} v^{h} v^{k}=-1$ and $v_{h}=g_{h k} v^{k}$.

Combining the equations (1.9), (1.10) and (1.11), we acquire

In [20], O'Neill established that a Robertson-Walker spacetime is a $P F$ spacetime. Every 4-dimensional generalized Robertson-Walker spacetime is a $P F$ spacetime if and only if it is a Robertson-Walker spacetime [12]. For additional insights about the $P F$ and $G R W$ spacetimes, we $\operatorname{refer}([2], 4], 5],[8, ~[9, ~ 11, ~ 19])$ and its references.

Definition 1.1. For a non vanishing 1 -form $\omega_{k}$ and a scalar function $\phi$ if the relation $\nabla_{k} u_{h}=\omega_{k} u_{h}+\phi g_{k h}$ holds, then the vector field $u$ is called torse-forming.

This notion was introduced by Yano [24] on a Riemannian manifold. It is noted that the foregoing torse-forming condition becomes $\nabla_{k} u_{h}=\phi\left(u_{k} u_{h}+g_{k h}\right)$, for a unit time-like vector.

In [19], Mantica and Molinari and in (4], Chen have proven the subsequent theorems:

Let $\mathcal{M}$ be a Lorentzian manifold of dimension $n(n \geq 3)$.
Theorem 1.1. [19] $\mathcal{M}$ is a $G R W$ spacetime if and only if it admits a unit time-like torse-forming vector field: $\nabla_{k} v_{j}=\varphi\left(g_{i j}+v_{j} v_{i}\right)$, which is also an eigenvector of the Ricci tensor.

Theorem 1.2. [4] $\mathcal{M}$ is a $G R W$ spacetime if and only if it admits a time-like concircular vector field.

In this article, we consider a SSMC and prove the following:
Theorem 1.3. If the associated vector field of $\mathcal{M}$ obeying a SSMC whose curvature tensor vanishes is a unit time-like torse-forming vector field, then $\mathcal{M}$ becomes a PF spacetime.

Definition 1.2. In a semi-Riemannian manifold with a SSMC $\nabla$, the torsion tensor $T$ is called recurrent if it obeys $\nabla_{k} T_{i j}^{h}=A_{k} T_{i j}^{h}, A_{k}$ being a covariant vector.

Here, we choose a SSMC whose torsion tensor is recurrent and establish the subsequent result:

Theorem 1.4. Let $\mathcal{M}$ admit a SSMC whose Ricci tensor is symmetric and torsion tensor is recurrent. Then the manifold $\mathcal{M}$ represents a GRW spacetime.

Definition 1.3. If $\nabla_{k} v_{h}=f R_{k h}$, then $v_{h}$ is named a $f$-Ric vector field, where $f$ is a constant.

The foregoing idea of $f$-Ric vector field was presented by Hinterleitner and Kiosak [17] on a Riemannian manifold.

Definition 1.4. [6] vector field is called a torqued vector field if $\nabla_{k} v_{h}=f g_{k h}+$ $\omega_{k} v_{h}$ and $\omega_{k} v^{k}=0$, where $f$ is a real constant and 1 -form $\omega$ is named the torqued form of $v$.

In this article, we consider a SSMC whose associated vector field is $f$ - Ric and torqued vector field, respectively and prove the following results:

Theorem 1.5. If $\mathcal{M}$ admits a SSMC whose curvature tensor vanishes and the associated vector field is $f-$ Ric, then $\mathcal{M}$ is Einstein.

Theorem 1.6. Let $\mathcal{M}$ admit a SSMC whose curvature tensor vanishes. If the associated vector field is torqued, then $\mathcal{M}$ becomes a PF spacetime.

Hamilton [15] introduces the concept of Ricci flow as a solution to the challenge of obtaining a canonical metric on a smooth manifold. Let $\mathcal{M}$ be satisfied by an evolution equation $\frac{\partial}{\partial t} g_{h k}(t)=-2 R_{h k}$, then it is called Ricci flow [15]. If the metric of $\mathcal{M}$ obeys the relation

then it is called a Ricci soliton [14], where $\mathfrak{L}_{v}$ is the Lie derivative operator and $\bar{\lambda}$ denotes a real constant. Here, $v$ is called the potential vector field of the solitons. The Ricci soliton is named shrinking, expanding or steady, if $\bar{\lambda}$ is negative, positive, or zero, respectively.

Many mathematicians were fascinated in the geometry of Ricci solitons over the past few years. Some interesting findings on this solitons have been investigated in ([2], [7, [10], [18]) and also by others.

The above investigations motivate us to SSMC and establish the subsequent:
Theorem 1.7. Let us suppose that $\mathcal{M}$ admit a SSMC whose curvature tensor vanishes and the associated vector field is a unit time-like torse-forming vector field. If $\mathcal{M}$ admits a Ricci soliton $(g, v, \bar{\lambda})$, then the soliton is shrinking if $\phi<1$, expanding if $\phi>1$, or steady if $\phi=1$, respectively. Additionally, the integral curves that $v$ generates are geodesics.

## 2. Semi-Symmetric metric connection

Agreement: Throughout this article, we assume that the associated vector $v_{i}$ is a unit time-like vector, that is, $v^{i} v_{i}=-1$.

Then, the equation (1.8) becomes

Multiplying (1.7) with $g^{h k}$, we acquire

where $\bar{R}_{i j}$ and $R_{i j}$ are the Ricci tensor of $\nabla$ and D, respectively and $\pi=g^{h k} \pi_{h k}$.
Also, we have

Proposition 2.1. $\bar{R}_{i j}$ is symmetric if and only if $v_{i}$ is closed.
Proof. From the equation (2.2), we obtain

& =-(n-2)\left\{\mathrm{D}_{i} v_{j}-\mathrm{D}_{j} v_{i}\right\} . \tag{2.4}

If $v_{i}$ is closed, then the foregoing equation reduces to

that is, $\bar{R}_{i j}$ is symmetric and conversely.
2.1. Proof of the Theorem 1.3. Since by hypothesis, $\bar{R}_{h i j k}=0$, from (1.7), we get

Multiplying with $g^{i j}$ the above equation yields

which implies

The foregoing equation entails that $\mathcal{M}$ is a $P F$ spacetime.
Hence, the proof is finished.
Now, using Theorem 1.1 we may state:
Corollary 2.1. A GRW-spacetime admitting a SSMC whose curvature tensor vanishes is a PF spacetime.

Remark 2.1. In [19], Mantica and Molinari established that a GRW spacetime satisfying divC $=0$ represents a PF spacetime, where $C$ indicates the conformal curvature tensor. Here, curvature condition divC $=0$ is replaced by a SSMC whose curvature tensor vanishes and acquires the same result.

For $n=4$, comparing the equations (1.11) and (2.11), we have

Making use of (1.12), the foregoing equation yields

Corollary 2.2. A PF spacetime admitting a SSMC satisfies the state equation $\sigma=\frac{3}{2} p+$ constant.
2.2. Proof of the Theorem 1.4. It is known [3] that if a Riemannian manifold admits a SSMC $\nabla$ whose torsion tensor $T$ is recurrent, then the curvature tensor $\bar{R}_{i j k}^{h}$ of $\nabla$ is given by

& -A_{j}\left[v_{k} \delta_{i}^{h}-g_{i k} v^{h}\right]+v^{l} v_{l}\left[g_{j k} \delta_{i}^{h}-g_{i k} \delta_{j}^{h}\right] . \tag{2.15}
\end{align*}

For a Lorentzian manifold the above relation becomes

& -A_{j}\left[v_{k} \delta_{i}^{h}-g_{i k} v^{h}\right]-\left[g_{j k} \delta_{i}^{h}-g_{i k} \delta_{j}^{h}\right], \tag{2.16}
\end{align*}

since $v^{l} v_{l}=-1$.
First we prove the following lemma:
Lemma 2.1. If the torsion tensor $T$ is given by

then $A_{k}$ is gradient.
Proof. Let

From (2.18), we get

From $T_{i j}^{h}=\delta_{i}^{h} v_{j}-\delta_{j}^{h} v_{i}$, we get

Contracting $h$ and $k$ in (2.16) yields

By hypothesis $\bar{R}_{i j}$ is symmetric. Hence, we have from (2.26)

Multiplying the foregoing equation by $v^{i}$ gives

From (2.24) and (2.25) it follows that

where $\mu_{h}=A_{h}+v_{h}$.
From the above equation we conclude that $v_{k}$ is a torseforming vector field with $\alpha=\beta=1$.

Here, $v_{h}$ is closed, since by hypothesis the Ricci tensor of the SSMC is symmetric. Also by Lemma 2.1, $A_{h}$ is closed and hence $\mu_{h}$ is closed. Therefore, $v_{h}$ is concircular. Hence, using Theorem 1.2 we state that $\mathcal{M}$ represents a $G R W$ spacetime.

This completes the proof.
2.3. Proof of the Theorem 1.5. Since the associated vector field is $f$ - Ric, then we have

Then from (2.3), we acquire

Hence, using the previous equation in (2.1), we infer

Since by assumption $\bar{R}_{h i j k}=0$. From (1.7), we obtain

Multiplying with $g^{i j}$ the foregoing equation yields

R_{h k}=f\left\{n R_{h k}-R_{h k}+R g_{h k}-R_{h k}\right\}+(n-1) g_{h k}
$$

which entails

$$
\begin{equation*}
R_{h k}=\frac{f R+(n-1)}{1-(n-2) f} g_{h k} \tag{2.36}
\end{equation*}
$$

The above equation states that $\mathcal{M}$ is Einstein.
This ends the proof.
Remark 2.2. From the equation (2.35), we also get the spacetime is of constant curvature $\frac{2 f^{2} R+n f+1}{1-(n-2) f}$.

If $R=-\frac{n f+1}{f^{2}}$, then...
2.4. Proof of the Theorem 1.6. By hypothesis, $v$ is a torqued vector field. Therefore, we get

$$
\begin{equation*}
\nabla_{k} v_{h}=f g_{h k}+\omega_{k} v_{j} \tag{2.37}
\end{equation*}
$$

and $\omega_{k} v^{k}=0$. Then from (2.3), we obtain

$$
\begin{equation*}
\mathrm{D}_{h} v_{k}=(f+1) g_{h k}+\left(\omega_{h}+v_{h}\right) v_{k} \tag{2.38}
\end{equation*}
$$

Hence, using the above equation in (2.1), we acquire

$$
\begin{equation*}
\pi_{i k}=\left(f+\frac{3}{2}\right) g_{i k}+\omega_{i} v_{k} \tag{2.39}
\end{equation*}
$$

Since $\bar{R}_{h i j k}=0$, from (1.7), we get

$$
\begin{equation*}
R_{h i j k}=g_{h k} \pi_{i j}-g_{i k} \pi_{h j}+g_{i j} \pi_{h j}-g_{h k} \pi_{i k} \tag{2.40}
\end{equation*}
$$

Now, using equation (2.39) in (2.40), we have

$$
\begin{equation*}
R_{h i j k}=2\left(f+\frac{3}{2}\right)\left\{g_{h k} g_{i j}-g_{h j} g_{i k}\right\}+\left\{g_{h k} \omega_{i}-g_{i k} \omega_{h}\right\} v_{j}+\left\{g_{i j} \omega_{h}-g_{h j} \omega_{i}\right\} v_{k} . \tag{2.41}
\end{equation*}
$$

Multiplying with $g^{i j}$, we acquire

$$
\begin{gather*}
R_{h k}=2 n\left(f+\frac{3}{2}\right) g_{h k}-2\left(f+\frac{3}{2}\right) g_{h k}-(n-1) \omega_{h} \omega_{k}+\left\{g_{h k} \omega_{h} v_{k}-\omega_{h} v_{k}\right\} . \\
R_{h k}=(2 n-2)\left(f+\frac{3}{2}\right) g_{h k}+(n-2) \omega_{h} v_{k} . \tag{2.42}
\end{gather*}
$$

Again, multiplying with $v^{h}$ yields

$$
\begin{equation*}
R_{h k} v^{h}=(2 n-2)\left(f+\frac{3}{2}\right) v_{k}, \tag{2.43}
\end{equation*}
$$

since $\omega_{i} v^{i}=0$.
Also, from (2.42), we get $\omega_{h} v_{k}=\omega_{k} v_{h}$. Multiplying the foregoing relation by $v^{k}$, we have $\omega_{h}=a v_{h}$, where $a=\omega_{k} v^{k}$. Hence, the equation (2.42) becomes

$$
\begin{equation*}
R_{h k}=(2 n-2)\left(f+\frac{3}{2}\right) g_{h k}+(n-2) a v_{h} v_{k} . \tag{2.44}
\end{equation*}
$$

Foregoing equation tells that $\mathcal{M}$ is a $P F$ spacetime.
This accomplishes the proof.

## 3. Applications to Ricci solitons

3.1. Proof of the Theorem 1.7, Now, suppose that $\mathcal{M}$ with SSMC admits a Ricci soliton. Then from equation (1.13), we get

$$
\begin{equation*}
\nabla_{h} v_{k}+\nabla_{k} v_{h}+2 R_{h k}+2 \bar{\lambda} g_{h k}=0 \tag{3.1}
\end{equation*}
$$

Multiplying by $v^{h} v^{k}$, we obtain

$$
\begin{equation*}
R_{h k} v^{h} v^{k}-\bar{\lambda}=0, \tag{3.2}
\end{equation*}
$$

since $g_{h k} v^{h} v^{k}=-1$ and $v^{h} v^{k} \nabla_{h} v_{k}=0$. Again, multiplying the equation (2.11) by $v^{h} v^{k}$, we infer

$$
\begin{equation*}
R_{h k} v^{h} v^{k}=-\{(n-1)(2 \phi-1)-\phi\}+(n-2) \phi . \tag{3.3}
\end{equation*}
$$

Comparing the last two equations, we acquire $\bar{\lambda}=(1-n)(\phi-1)$. This shows that the Ricci soliton is shrinking if $\phi<1$, expanding if $\phi>1$, or steady if $\phi=1$, respectively.

Again, multiplying (3.1) by $v^{h}$, we find

$$
\begin{equation*}
v^{h} \nabla_{k} v_{h}+2 R_{h k} v^{h}+2 \bar{\lambda} v_{k}=0, \tag{3.4}
\end{equation*}
$$

since $v^{h} \nabla_{h} v_{k}=0$.
Again, multiplying (2.11) by $v^{h}$ yields

$$
\begin{equation*}
R_{h k} v^{h}=\{(n-1)(2 \phi-1)-\phi\}-(n-2) \phi \tag{3.5}
\end{equation*}
$$

Using the above equation in (3.4), we have $v^{h} \nabla_{k} v_{h}=0$, since $\bar{\lambda}=(1-n)(\phi-1)$.
This ends the proof.
