ON *R*-CONEAT INJECTIVE MODULES AND GENERALIZATIONS

Abstract

Both the classes of R-coneat injective modules and its superclass, pure Baer injective modules, are shown to be preenveloping. The former class is contained in another one, namely, self coneat injectives, i.e. modules M for which every map f from a coneat left ideal of R into M, whose kernel contains the annihilator of some element in M, is induced by a homomorphism $R \to M$. Certain types of rings are characterized by properties of the above modules. For instance, a commutative ring R is von Neuman regular if and only if all self coneat injective R-modules are quasi injective.

Key words and phrases. coneat injective module, copure Baer injective module, right SF-ring.

1. Introduction

The ring R is always associative with identity. Unless otherwise stated, modules are left unital R-modules. Homomorphisms and maps are all R-homomorphisms. A sequence of left R-modules:

 $(1.1) 0 \to A \hookrightarrow B \to B/A \to 0$

is pure (respectively, coneat) exact if the sequence $0 \to U \otimes A \to U \otimes B \to U \otimes B / A \to 0$ remains exact for all (simple) right *R*-modules *U*. Therefore, pure exact sequences are coneat exact but not convesely. For a nonempty class of modules Q, the sequence 1.1 is called *Q*-copure exact [13, section 38] if every module $Q \in Q$ is injective with respect to 1.1, i.e. every map $A \to Q$ has an extension to a map $B \to Q$. A module is *injective* (respectively, *pure* injective, *coneat* injective) if it is injective with respect to all exact (respectively, pure exact, coneat exact) sequences 1.1. Baer condition states that the module remains injective if we restrict to the case when *B* in the above sequence is the ring *R*. No 'Baer condition' is known for pure injectivity or coneat injectivity. Therefore, we have *pure Baer injective* and *R*-coneat injective modules, i.e. modules injective with respect to all pure and coneat exact sequences 1.1 with B = R, respectively [12, 5]. Also, *Q*-copure Baer

injective modules are those injective with respect to all Q-copure exact sequences 1.1 with B = R [7]. By [13, p. 290] and [5, Theorem 2.3], pure exact and coneat exact sequences are Q-copure exact by taking Q = the class of pure injective or coneat injective modules, accordingly. Hence, pure Baer and R-coneat injectivity are examples of Q-copure Baer injectivity.

The module M is quasi injective [8] if it is injective with respect to every sequence 1.1 with B = M. L. Fuchs [3] gave a kind of Baer condition for quasi injectivity. He proved that for a module M to be quasi injective, it is necessary and sufficient that every map $L \to M$ from a left ideal L of R, the kernel of which is in $\Omega(M)$ (equivalentley, $\overline{\Omega}(M)$), can be extended to a map $R \to M$. Here, the set $\Omega(M)$ consists of all left ideals L of R such that $L \supseteq \operatorname{ann}(m)$ for some $m \in M$, and $\overline{\Omega}(M)$ is the filter generated by $\Omega(M)$. This motivated the study of absolutely self pure, absolutely self neat and principally self injective modules [4, 6, 10]. Analogously, we study here self coneat injective modules by taking maps $L \to M$, from coneat left ideal L of R, whose kernels are in $\Omega(M)$, extendable to $R \to M$.


A class of modules \mathcal{P} is preenveloping if every module M has a \mathcal{P} -preenvelope, i.e. a map $\varphi: M \to P$ where $P \in \mathcal{P}$ such that for every map $\psi: M \to P'$, where $P' \in \mathcal{P}$, there is a map $f: P \to P'$ with $f \circ \varphi = \psi$. A \mathcal{P} -preenvelope $\varphi: M \to P$ is a \mathcal{P} -envelope if for P' = P and $\psi = \varphi$ the only such maps f are automorphisms of P. The class \mathcal{P} is called enveloping if every module has a \mathcal{P} -envelope. If \mathcal{P} contains the injective modules then any \mathcal{P} -preenvelope is a monomorphism. In this case, we say that the module $P \in \mathcal{P}$, rather than the map $\varphi: M \to P$, is a \mathcal{P} -(pre)envelope of M. For details about (pre)envelopes in general the reader is referred to [2]. The classes of injective, pure injective, and coneat injective modules are all enveloping. In [7] it is proved that every module is embeddable as a \mathcal{Q} -copure submodule of a \mathcal{Q} -copure Baer injective preenvelope. Thus, both the classes of R-coneat injective modules and pure Baer injective modules are preenveloping.

2. *R*-Coneat Injective Preenvelopes

In [7, Theorem 2, Lemma 2], it is proved that, for any nonempty class of modules Q, every module can be embedded as a Q-copure submodule of a Q-copure Baer injective module. Hence, every module can be embedded as a coneat submodule of an R-coneat injective module. In the following lemma, we modify the proof of [7, Lemma 2] to show that the above embedding is actually a preenvelope.


Lemma 2.1. Every module has an R-coneat injective preenvelope.

Proof. Given a module M, we will embed M in an R-coneat injective preenvelope. Consider the coneat left ideals C of R and the set \mathscr{F} of all maps $f: C \to M$. For every $f \in \mathscr{F}$ there is a pushout $P = (R \oplus M)/K$, where $K = \{(c, -f(c)), c \in C\}$, and a map $g: R \to P$ with $g|_C = f$. For each map $\alpha: M \to N$ into an *R*-coneat injective module N take the diagram:



Since N is R-coneat injective, there is a $\beta : R \to N$ extending αf . Define $\gamma : P \to N$ as: $\gamma((r, m) + K) = \beta(r) + \alpha(m)$. It is easy to check that γ is a homomorphism extending α .

The module P might not be R-coneat injective, so put $M_0 = M$, $M_1 = P$, $f_0 = f$, $h_0 = h$, $\alpha_0 = \alpha$ and $\gamma_0 = \gamma$ and repeat the above process with M replaced by M_1 to give M_2 and $M_0 \subseteq M_1 \subseteq M_2$ and the commutative diagram:



Continue in this manner to get a sequence $M_0 \subseteq \cdots \subseteq M_n \subseteq M_{n+1} \subseteq \cdots$, for all $n \in \mathbb{N}$. Put $M_{\omega} = \bigcup M_n$. Now, for each nonlimit ordinal redo the above process. If we reach a limit ordinal, say λ , put $M_{\lambda} = \bigcup \{M_{\rho}, \rho < \lambda\}$. Let σ be the smallest ordinal with a larger cardinality than that of the ring R, i.e. $|\sigma| = |R|^+$ (the successor cardinal of |R|). For each $\rho < \sigma$, we have $|\rho| < |\sigma|$, σ is a limit ordinal and $M_{\sigma} = \bigcup \{M_{\rho}, \rho < \sigma\}$. Now, M_{σ} is our R-coneat injective module. To see this, let C be a coneat left ideal of R and $f: C \to M_{\sigma}$ any map. For each $c \in C$, let \bar{c} be the smallest ordinal such that $f(c) \in M_{\bar{c}}$. Then $\bar{c} < \sigma$ and $|\bar{c}| < |\sigma| = |R|^+$. Hence $|\bar{c}| \leq |R|$. Put $p = \sup\{\bar{c}, c \in R\}$. As each $|\bar{c}| \leq |R|$, we must have $|p| \leq |R| < |\sigma|$. Hence, $p < \sigma$. Since σ is a limit ordinal, we have $p+1 < \sigma$. Therefore, for each $c \in R$, $c \in M_{\bar{c}} \subseteq M_p \subseteq M_{p+1} \subseteq M_{\sigma}$. So, $f(C) \subseteq M_p$. Moreover, the map $f: C \to M_p$ can be extended to a map $g: R \to M_{p+1}$ with $g|_C = f$. View g now as a map $R \to M_{\sigma}$. The map $\gamma: M_{\sigma} \to N$ is defined as follows. For every $x \in M_{\sigma}$ there is an M_{ρ} with $x \in M_{\rho}$. So put $\gamma(x) = \gamma_{\rho}(x)$.

Replacing the word 'coneat' by 'Q-copure' in the proof of above Lemma, we get:

Lemma 2.2. Every module has a Q-copure Baer injective preenvelope.

Now this Lemma together with [7, Lemmas 3 and 4] are all we need to show:

Theorem 2.3. For a given nonempty class of modules Q, every module can be embedded as a Q-copure submodule in a Q-copure Baer injective preenvelope.

- **Corollary 2.4.** (1) Every module can be embedded as a coneat submodule of an *R*-coneat injective preenvelope.
 - (2) Every module can be embedded as a pure submodule of a pure Baer injective preenvelope.

3. Self Coneat Injectivity

Definition 3.1. An *R*-module *M* is called *self coneat injective* if any map $C \to M$ from a coneat left ideal *C* of *R*, the kernel of which contains $\operatorname{ann}(m)$ for some $m \in M$, can be extended to a map $R \to M$.

The argument that a direct summand of a self coneat injective module is self coneat injective is standard.

As $\Omega(R)$ consists of all left ideals of R, we have any module containing the ring R is self coneat injective if and only if it is R-coneat injective. In particular, any preenvelope of R is self coneat injective if and only if it is R-coneat injective. The following Theorem characterizes self coneat injective modules.

Theorem 3.2. An *R*-module *M* is self coneat injective if and only if for any coneat left ideal *C* of *R* and any $m \in M$, every map $Cm \to M$ has an extension to $Rm \to M$.

Proof. (\Rightarrow) Let $g \in \text{Hom}(Cm, M)$ and define $f : C \to M$ by $x \mapsto g(xm)$. For any $x \in \text{ann}(m)$ we have f(x) = g(xm) = 0 and hence $x \in \ker f$. Therefore, by assumption, there is an $\overline{f} \in \text{Hom}(Rm, M)$ extending f. The map $Rm \to M$ given by $m \mapsto \overline{f}(1)$ is easily seen to be an extension of g. (\Leftarrow) Let now $f : C \to M$ be a map from a coneat left ideal of R with kernel containing ann(m) for some $m \in M$. If xm = 0 for some $x \in C$ then $x \in \text{ann}(m) \subseteq \ker f$. Therefore, the map $g : Cm \to M$ given by $xm \mapsto f(x)$ is well defined. By assumption, g can be extended to a $\overline{g} : Rm \to M$. Now the map $R \to M$, $1 \mapsto \overline{g}(m)$ extends f. \Box

Theorem 3.3. The following statements are equivalent for a ring R:

- (1) Every coneat left ideal of R is projective.
- (2) Homomorphic images of R-coneat injective modules are again R-coneat injective.
- (3) Homomorphic images of R-coneat injective modules are self coneat injective.

Proof. (1) \Rightarrow (2) Let *M* be an *R*-coneat injective module and $\pi : M \to N$ an epimorphism. For each coneat left ideal *C* of *R* consider the following diagram:

$$\begin{array}{ccc} R & & & C \\ & & & & \downarrow^f \\ M & \overset{\pi}{\longrightarrow} N \end{array}$$

Since C is projective, there is a lifting map $\alpha : C \to M$ for f. Since M is R-coneat injective, there is an extension $\beta : R \to M$ of α . Now $\pi \alpha$ extends f. (2) \Rightarrow (3) is trivial. (3) \Rightarrow (1) Let C be a coneat left ideal and consider a diagram like the above with M being injective and, by assumption, N is self coneat injective. Any map f whose kernel contains the annihilator of some $x \in N$ is induced by a map $\alpha : R \to N$. By projectivity of R there is a $\beta : R \to M$ lifting α . Now $\pi\beta$ lifts α , hence f, and C is projective by [4, Lemma 3.4]

Recall that right SF-rings R are characterized by the property that every left ideal of R is coneat [5, Theorem 3.16]. Such rings are characterized using self coneat injectivity as follows.

Theorem 3.4. The following five statements are equivalent for a ring R:

- (1) The ring R is a right SF-ring.
- (2) Every left ideal of R is coneat.
- (3) Every R-coneat injective module is injective.
- (4) All R-coneat injective modules are quasi injective.
- (5) All self coneat injective modules are quasi injective.
 - If R is commutative then the above are equivalent to:
- (6) The ring R is von Neuman regular.

Proof. (1) \Leftrightarrow (2) and in the commutative case (1) \Leftrightarrow (6) By [5, Theorem 3.16]. (2) \Leftrightarrow (3) By [7, Theorem 3] since coneat submodules are copure. (2) \Rightarrow (4) and (2) \Rightarrow (5) If all left ideals are coneat then by [5, Theorem 3.16], (4) and (5) follow. (3) \Rightarrow (2) In particular, all coneat injective modules are injective and by [5, Theorem [3.16] (1) follows. (3) \Rightarrow (4) and (5) \Rightarrow (4) are trivial. (4) \Rightarrow (3) Let M be R-coneat injective, then so is $M \oplus P$ where P is a preenvelope of R. Now, any map from a coneat left ideal L of R into M has an extension to a map $L \to M \oplus P$ whose kernel contains the annihilator of (0, 1). By assumption $M \oplus P$ is quasi injective. \square

Examples 3.5. (1) Any quasi injective module and any (R-) coneat injective module is self coneat injective.

- (2) Since \mathbb{Z} is not an SF-ring there must exist then, by Theorem 3.4, a self coneat injective \mathbb{Z} -module that is not quasi injective.
- (3) If R is a commutative von Neuman regular but not noetherian ring then there must exist a quasi injective, hence self coneat injective, R-module that is not injective [1, Proposition 1], hence not *R*-coneat injective.
- (4) Let A be a self coneat injective \mathbb{Z} -module that is not quasi injective (example 2 above) and B a quasi injective R-module that is not R-coneat injective

(example 3 above). The self coneat injective module $\begin{pmatrix} A \\ B \end{pmatrix}$ over the ring

 $\begin{pmatrix} \mathbb{Z} & 0 \\ 0 & R \end{pmatrix}$ is not quasi injective nor *R*-coneat injective, for otherwise the direct summand $\begin{pmatrix} A \\ 0 \end{pmatrix}$ would be quasi injective or the direct summand $\begin{pmatrix} 0 \\ B \end{pmatrix}$ would be *R*-coneat injective.

Theorem 3.6. The following statements are equivalent for a ring R:

- (1) Every coneat exact sequence of left R-modules splits.
- (2) All R-modules are R-coneat injective.
- (3) All *R*-modules are self coneat injective.

Proof. (1) \Rightarrow (2) \Rightarrow (3) are trivial. (3) \Rightarrow (1) Let C be a coneat left ideal of R and P a preenvelope of R. By assumption, $C \oplus P$ is self coneat injective. Therefore, as the kernel of the inclusion $C \to C \oplus P$ contains the annihilator of (0,1), it must be induced by a map $R \to C \oplus P$. This map followed by the projection $C \oplus P \to C$ gives a homomorphism $R \to C$ extending the identity of C.

We know that all pure exact sequences of left R-modules are coneat exact. For the converse, we have the following.

Proposition 3.7. The following statements are equivalent for a ring R:

(1) Every coneat exact sequence of left R-modules is pure exact.

- (2) All pure Baer injective R-modules are R-coneat injective.
- (3) All pure Baer injective R-modules are self coneat injective.
- (4) All self pure injective R-modules (i.e. modules M for which every map f from a pure left ideal of R into M whose kernel contains the annihilator of some element in M is induced by a homomorphism R → M) are self coneat injective.

Proof. (1) ⇒ (2) ⇒ (3) and (1) ⇒ (4) ⇒ (3) are trivial. (2) ⇒ (1) By assumption, any pure Baer injective module M is injective with respect to any coneat exact sequence $0 \to A \to B \to C \to 0$ of left R-modules. Therefore, as pure submodules are copure [7], the above sequence must be pure exact [7, Theorem 3]. (3) ⇒ (2) Let M be pure Baer injective, therefore, so is $M \oplus P$, where P is a pure Baer injective preenvelope of R. By assumption, $M \oplus P$ is self coneat injective. So for any map $f : C \to M$, the extension $C \to M \hookrightarrow M \oplus P$ has kernel containing the annihilator of (0, 1) and hence, it is induced by a map $R \to M \oplus P$. Following this last map by the projection $M \oplus P \to M$, we get an extension $R \to M$ of f. □

By similar arguments to that of 3.7, we get the following three propositions. For the first proposition, recall that a module M is called *finitely* R-injective (*absolutely self pure*) [11] ([4]) if every map $I \to M$ from a finitely generated left ideal of R(whose kernel is in $\overline{\Omega}(M)$) can be extended to $R \to M$.

Proposition 3.8. The following statements are equivalent for a ring R:

- (1) Every coneat left ideal of R is finitely generated.
- (2) Finitely R-injective R-modules are R-coneat injective.
- (3) Finitely R-injective R-modules are self coneat injective.
- (4) Absolutely self pure R-modules are self coneat injective.

Now, recall that a module M is called *absolutely self neat* [6] if the words 'finitely generated' are replaced by 'maximal' in the above definition of absolutely self pure modules.

Proposition 3.9. The following statements are equivalent for a ring R:

- (1) Every maximal left ideal of R is coneat in R.
- (2) All R-coneat injective modules are absolutely neat.
- (3) All R-coneat injective modules are absolutely self neat.

A module M is called *principally* (*self*) injective [9] ([10]) if every map $I \to M$ from a principal left ideal of R (whose kernel is in $\Omega(M)$) can be extended to $R \to M$.

Proposition 3.10. The following statements are equivalent for a ring R:

- (1) Every coneat left ideal of R is principal.
- (2) Principally injective R-modules are R-coneat injective.
- (3) Principally injective R-modules are self coneat injective.
- (4) Principally self injective R-modules are self coneat injective.

Proposition 3.11. The following are equivalent for a commutative ring R.

- (1) The ring R is a von Neuman regular.
- (2) Every self pure injective R-module is flat.
- (3) Every absolutely self pure R-module is flat.
- (4) Every absolutely self neat R-module is flat.

Proof. $(1) \Rightarrow (2)$ - (4) are trivial since over von Neuman regular rings, all modules are flat. (2) - $(4) \Rightarrow (1)$: Each of the conditions in (2) - (4) implies that quasi injective *R*-modules are flat. But then simple *R*-modules are flat, hence, *R* is an SF-ring. Since *R* is commutative, it must be von Neuman regular.
