On Kakeya's Geometric Proof of Eneström-Kakeya's Theorem

Abstract This paper is devoted to demonstrate Kakeya's geometric proof of his theorem (1912), independently established earlier by Eneström (1893). By calculating centers and radii of the interlacing circles of Kakeya's method, we prove Kakeya's geometric structure, which has not been previously established. We give an equivalent proof, which is based on the construction of internally interlacing circles, which has been geometrically considered by Tomic (1948).

Keywords Eneström-Kakeya's Theorem · zeros of polynomials

1 Introduction

In the following $\mathbb{N}, \mathbb{N}_0, \mathbb{R}, \mathbb{C}$ denote the sets $\{1, 2, \dots\}$, $\mathbb{N} \cup \{0\}$, the set of real numbers and the set of complex numbers respectively. A complex number is considered as an ordered pair, a point or a vector in \mathbb{R}^2 . Thus we may write for $z = x + iy \in \mathbb{C}$, $z = \vec{z} = \overrightarrow{OP} = (x, y), x, y \in \mathbb{R}$, where O is the origin and P is the point representing z in the complex plane, or in \mathbb{R}^2 . The circles $\mathscr{C}_1, \mathscr{C}_2, \dots, \mathscr{C}_n, n \in \mathbb{N}$ are called internally interlacing if \mathscr{C}_k is completely contained inside \mathscr{C}_{k-1} , except possibly for one touching point, $k = 1, 2, \dots, n$. If for all k, \mathscr{C}_{k-1} is completely contained inside \mathscr{C}_k , except possibly for one point, the circles are called externally interlacing. If $\mathscr{C}_1, \mathscr{C}_2, \dots, \mathscr{C}_n$ are internally interlacing, then $\mathscr{C}_n, \mathscr{C}_{n-1}, \dots, \mathscr{C}_1$ are externally interlacing and vice versa.

Let a_0, a_1, \dots, a_n be positive numbers, which are not all equal, and P(z) be the polynomial

$$P(z) = a_n z^n + a_{n-1} z^{n-1} + \dots + a_1 z + a_0.$$
(1.1)

Eneström-Kakeya's theorem states that the zeros of P(z) lie in the annulus, [2,4],

$$\min_{1 \le k \le n} \frac{a_{k-1}}{a_k} < |z| < \max_{1 \le k \le n} \frac{a_{k-1}}{a_k}. \tag{1.2}$$

In particular, if $a_n \ge a_{n-1} \ge \cdots \ge a_1 \ge a_0 > 0$, then the zeros of P(z) lie in the open unit disc |z| < 1.

Eneström's algebraic proof,[1,2] is more restrictive than Kakeya's one as he proved that the zeros of P(z) lie in the closure of the annulus (1.2). See also, [3] and the brief account [5, pp. 271-2]. Kakeya's proof is based on an elegant geometric proof of the following lemma

Lemma 1.1 If $p_n \ge p_{n-1} \ge \cdots \ge p_1 \ge p_0 > 0$ are positive numbers, $\theta \in \mathbb{R}$, $n \in \mathbb{N}_0$, then

$$R_n = p_0 + p_1 e^{i\theta} + p_2 e^{2i\theta} + \dots + p_n e^{in\theta} \neq 0.$$
 (1.3)

Kakeya's Proof of Lemma 1.1 is based on proving that the points of \mathbb{C} ,

$$R_0 = p_0, R_k = \sum_{m=0}^{k} p_m e^{im\theta}, k = 1, 2, \dots, n,$$
 (1.4)

lie on externally interlacing circles $\mathscr{C}_0, \mathscr{C}_1, \dots, \mathscr{C}_n$ with centers and radii C_0, C_1, \dots, C_n and r_0, r_1, \dots, r_n respectively, for which

$$\mathscr{C}_{k-1} \cap \mathscr{C}_k = \{R_{k-1}\}, \ r_k - r_{k-1} = \|C_k - C_{k-1}\|, \tag{1.5}$$

provided that p_0, p_1, \dots, p_n are all different, $\|\cdot\|$ denotes the Euclidean distance. If some of the $p_j's$ are equal, the geometric proof remains true, but with a slight modification of the geometric structure. If $p_{j-1} = p_j$ for some $j = 1, 2, \dots, n$, then, the circles \mathscr{C}_{j-1} and \mathscr{C}_j coincide to each other, i.e. $\mathscr{C}_{j-1} = \mathscr{C}_j$ as sets. Also, if $p_{j-1} = p_j$, $j = 1, 2, \dots, n$, the lemma is true only if $e^{i\theta}$ is not an n-th root of unity because

$$1 + z + z^{2} + \dots + z^{n} = \frac{1 - z^{n+1}}{1 - z}, \ z = e^{i\theta}.$$
 (1.6)

At this point, it is worthwhile to mention that Eneström's algebraic proof and Kakeya's geometric one are identical, apart from the restriction in Eneström's proof. However, Kakeya's proof is incomplete as he only demonstrated the cases of \mathcal{C}_0 , \mathcal{C}_1 , \mathcal{C}_2 of the construction (1.5) and claimed that the rest can be derived iteratively without filling in a proof. In addition, he did not provide any calculations of circles centers and radii. Furthermore, his single geometric figure is a troublesome and may be misleading, probably due to the typing-printing limitations of his era.

The first aim of this paper is to derive a complete proof of the geometric construction (1.5). We start our demonstrations by computing the particular cases of \mathcal{C}_0 , \mathcal{C}_1 , \mathcal{C}_2 , which shed light on the general case. Special and general cases are presented in Sections 2 and 3 respectively. We point out to the misleading of Kakeya's own figure. Section 3 involves the general construction (1.5) and hence a rigorous geometric proof of (1.3) is established. In an equivalent approach, we establish another geometric proof of Eneström-Kakeya's theorem, which is based on an internally interlacing circles version of Lemma 1.1. This is done in the last section.

Before leaving this introduction we would like to mention the work of Tomic [6], the first who gave a proof of Kakeya's geometric construction 1.5. Tomic noticed in [6] that the geometric construction of Kakeya's needs a proof and tried to complete it. In his approach he established internally interlacing circles, rather than the externally interlacing ones of Kakeya. Nevertheless, Tomic did not compute the circles, which we rigorously do here.

2 Special cases




Fig. 1: (a) $\triangle OC_0R_0 \cong \triangle R_0C_0S_1$, since $OR_0 = R_0S_1$. (b) R_0 , C_0 and C_1 are collinear as Eq. (2.4) confirms.

In the following we prove of (1.5) when n=2. We demnostrate the construction of Kakeya for \mathcal{C}_0 , \mathcal{C}_1 , \mathcal{C}_2 . We assume without any loss of generality that $0 < \theta < \pi$. The other cases will be discussed in the general setting. The construction of \mathcal{C}_0 is based on locating R_0 on the X-axis at distance p_0 from the origin O. The point S_1 is taken to be $S_1 = \overrightarrow{OR_0} + \overrightarrow{R_0S_1}$, $\overrightarrow{R_0S_1} = p_0e^{i\theta}$. Thus $S_1 = (p_0 + p_0 \cos \theta, p_0 \sin \theta)$. The circle \mathcal{C}_0 is the circle that passes through O, R_0, S_1 . From Figure 1 (a), we see that $\triangle OR_0C_0 \cong \triangle R_0S_1C_0$ and consequently $\triangle OC_0R_0 = \triangle R_0C_0O = \theta$. Therefore, the center and the radius of \mathcal{C}_0 are

$$\mathscr{C}_0\left(\frac{p_0}{2}, \frac{p_0}{2} \cot \frac{\theta}{2}\right), \ r_0 = \frac{p_0}{2} \csc \frac{\theta}{2}. \tag{2.1}$$

If $p_0 = p_1$, then R_1 is merely S_1 , and \mathcal{C}_1 coincides with \mathcal{C}_0 . Otherwise, R_0S_1 is extended to R_0R_1 , where $\overrightarrow{R_0S_1} \parallel \overrightarrow{R_0R_1}$ and $\parallel R_0R_1 \parallel = p_1$. Thus $R_1 = (p_0 + p_1 \cos \theta, p_1 \sin \theta) = \overrightarrow{OR_1}$. The circle \mathcal{C}_1 is determined by R_0, R_1 and the central angle $\angle R_0C_1R_1$, which is taken to be of measure θ . Therefore \mathcal{C}_1 is completely determined and we can see that its center and radius are

$$\mathscr{C}_{1}\left(p_{0} - \frac{p_{1}}{2}, \frac{p_{1}}{2}\cot\frac{\theta}{2}\right), \ r_{1} = \frac{p_{1}}{2}\csc\frac{\theta}{2}$$
 (2.2)

respectively. The circle \mathscr{C}_1 lies entirely outside \mathscr{C}_0 and it only touches it at R_0 because

$$r_1 - r_0 = ||C_1 - C_0|| = \frac{p_1 - p_0}{2} \csc \frac{\theta}{2}.$$
 (2.3)

It is worthwhile to notice that R_0 , C_0 , C_1 are collinear, cf. Figure 1 (b). This is clear by (2.3) and

$$\begin{vmatrix} p_0 & 0 & 1\\ \frac{p_0}{2} & \frac{p_0}{2} \cot \frac{\theta}{2} & 1\\ p_0 - \frac{p_1}{2} & \frac{p_1}{2} \cot \frac{\theta}{2} & 1 \end{vmatrix} = 0.$$
 (2.4)

In Kakeya's single figure of [4], R_0 , C_0 , C_1 are not looking to be collinear.

The construction of \mathcal{C}_2 is similar to that of \mathcal{C}_1 . We first locate S_2 whose position vector is

$$\overrightarrow{OS_2} = \overrightarrow{OR_0} + \overrightarrow{R_0R_1} + \overrightarrow{R_1S_2}, \quad \overrightarrow{R_1S_2} = p_1 e^{2i\theta}. \tag{2.5}$$

Thus the coordinates of S_2 are

$$S_2(p_0 + p_1 \cos \theta + p_1 \cos 2\theta, p_1 \sin \theta + p_1 \sin 2\theta).$$
 (2.6)

It is a trigonometry exercise to check that S_2 lies on \mathscr{C}_1 . Again if $p_1 = p_2$, then $S_2 = R_2$, and \mathscr{C}_2 coincides with \mathscr{C}_1 . Otherwise we extend $\overrightarrow{R_1S_2}$ to $\overrightarrow{R_1R_2}$,

$$\overrightarrow{R_1R_2} \parallel \overrightarrow{R_1S_2}, \quad \lVert \overrightarrow{R_1R_2} \rVert = p_2.$$
 (2.7)

The circle \mathscr{C}_2 is determined by R_1 and R_2 and the central angle $\angle R_1C_2R_2$, which is taken to satisfy $\angle R_1C_1R_2 = \theta$. We can see that the center and radius of \mathscr{C}_2 are

$$\mathscr{C}_2\left(p_0 + p_1\cos\theta + \frac{p_2}{2}\cos 2\theta - \frac{p_2}{2}\sin 2\theta\cot\frac{\theta}{2}, p_1\sin\theta + \frac{p_2}{2}\sin 2\theta + \frac{p_2}{2}\cos 2\theta\cot\frac{\theta}{2}\right), r_2 = \frac{p_2}{2}\csc\frac{\theta}{2}.$$
 (2.8)

Simple calculations prove that R_1, C_1, C_2 are collinear, and

$$r_2 - r_1 = ||C_2 - C_1|| = \frac{p_2 - p_1}{2} \csc \frac{\theta}{2},$$
 (2.9)

i.e. \mathcal{C}_2 lies entirely outside \mathcal{C}_1 and it touches it only at R_2 . The general case will be proved below.




Fig. 2: The construction of \mathcal{C}_0 , \mathcal{C}_1 , \mathcal{C}_2 when $\theta = \frac{\pi}{3}$. (a) $p_0 = 1$, $p_1 = 2$, $p_2 = 3$ are different. (b) $p_0 = 1$, $p_1 = p_2 = 2$ and \mathcal{C}_1 , \mathcal{C}_2 are identical. Accidentally C_1 lies on \mathcal{C}_0 . Notice that C_2 does not lie on \mathcal{C}_1 .




Fig. 3: The circles \mathscr{C}_0 , \mathscr{C}_1 , \mathscr{C}_2 with a right angle $\theta = \frac{\pi}{2}$. (a) $p_0 = 1$, $p_1 = 2$, $p_2 = 3$ are different. (b) $p_0 = 1$, $p_1 = p_2 = 2$ and $\mathcal{C}_1, \mathcal{C}_2$ are identical.




Fig. 4: The construction of \mathscr{C}_0 , \mathscr{C}_1 , \mathscr{C}_2 when $\theta = \frac{2\pi}{3}$. (a) $p_0 = 1$, $p_1 = 2$, $p_2 = 3$ are different. Accidentally C_2 coincides with the origin. (b) $p_0 = 1$, $p_1 = p_2 = 2$ and \mathscr{C}_1 , \mathscr{C}_2 are identical.

Figures 2-4 illustrates the constructions of \mathcal{C}_0 , \mathcal{C}_1 , \mathcal{C}_2 for different values of θ . Figure 2 illustrates the construction of \mathcal{C}_0 , \mathcal{C}_1 , \mathcal{C}_2 when $\theta = \frac{\pi}{3}$ is an acute angle. We considered two cases when p_0 , p_1 , p_2 are all different and when two values coincide to each other. The cases when θ is right or obtuse angles are depicted in Figure 3 and Figure 4 respectively. The calculations coincide with the geometric construction. The cases when $\theta = 0$, π or when θ lies in the third or fourth quadrants are discussed in the general setting of the next section.

3 The general setting

In this section we provide a complete proof of the geometric structure (1.5) which implies a rigorous geometric proof of (1.3), and consequently the proof of Eneström-Kakeya's theorem.

Proof of Lemma 1.1. We assume without any loss of generality that $0 < \theta < \pi$ and that p_0, p_1, \dots, p_n are distinct. Let R_k have the coordinates (x_k, y_k) , $k = 0, 1, \dots, n$. Hence

$$x_{k} = \begin{cases} p_{0} + p_{1} \cos \theta + \dots + p_{k} \cos k\theta, & k \ge 1, \\ p_{0}, & k = 0, \end{cases}$$

$$y_{k} = \begin{cases} p_{1} \sin \theta + \dots + p_{k} \sin k\theta, & k \ge 1, \\ 0, & k = 0. \end{cases}$$
(3.1)
$$(3.2)$$

$$y_k = \begin{cases} p_1 \sin \theta + \dots + p_k \sin k\theta, & k \ge 1, \\ 0, & k = 0. \end{cases}$$
(3.2)

The points S_k , $k = 1, \dots, n$ are defined via

$$\overrightarrow{OS_k} = \begin{cases} \overrightarrow{OR_0} + \overrightarrow{R_0R_1} + \dots + \overrightarrow{R_{k-2}R_{k-1}} + p_{k-1}e^{ik\theta}, & k \ge 2, \\ \overrightarrow{OR_0} + p_0e^{i\theta}, & k = 1. \end{cases}$$
(3.3)

Thus, if the coordinates of S_k , $k = 1, \dots, n$ are $(s_{k,x}, s_{k,y})$, then

$$s_{k,x} = \begin{cases} p_0 + p_1 \cos \theta + \dots + p_{k-1} \cos(k-1)\theta + p_{k-1} \cos k\theta, & k \ge 2, \\ p_0 + p_0 \cos \theta, & k = 1, \end{cases}$$

$$s_{k,y} = \begin{cases} p_1 \sin \theta + \dots + p_{k-1} \sin(k-1)\theta + p_{k-1} \sin k\theta, & k \ge 2, \\ p_0 \sin \theta, & k = 1, \end{cases}$$
(3.4)

$$s_{k,y} = \begin{cases} p_1 \sin \theta + \dots + p_{k-1} \sin(k-1)\theta + p_{k-1} \sin k\theta, & k \ge 2, \\ p_0 \sin \theta, & k = 1, \end{cases}$$
(3.5)




Fig. 5: The construction of C_k , C_{k+1} , C_2 . (a) C_{k+1} lies entirely outside C_k and it only touches it at R_k . (b) C_{k+1} lies entirely outside C_k and it only touches it at R_k when θ^* lies in the third or fourth quadrants.

We proved (1.5) for \mathcal{C}_0 , \mathcal{C}_1 , \mathcal{C}_2 . Now we accomplish the prove for all k. Indeed, let $k \geq 2$. By Kakeya structure, the circle \mathscr{C}_k is constructed to pass through R_{k-1} , R_k and $\angle R_{k-1}C_kR_k = \theta$. Thus \mathscr{C}_k is completely determined. From triangle $\triangle R_{k-1}C_kR_k$, cf. Figure 5 (a) the radius of \mathcal{C}_k is

$$r_k = \frac{p_k}{2}\csc\frac{\theta}{2}. (3.6)$$

To find the center $C_k(h_k, l_k)$, we notice that $C_k M_k \perp R_{k-1} R_k$, where M_k is the mid-point of $R_{k-1} R_k$, cf. Figure 5 (a). Hence, h_k , l_k are determined from solving the system

$$l_k = \frac{y_{k-1} + y_k}{2} - \frac{x_k - x_{k-1}}{y_k - y_{k-1}} \left(h_k - \frac{x_{k-1} + x_k}{2} \right), \tag{3.7}$$

$$(x_k - h_k)^2 + (y_k - l_k)^2 = \frac{p_k^2}{4} \csc^2 \frac{\theta}{2},$$
(3.8)

$$(x_{k-1} - h_k)^2 + (y_{k-1} - l_k)^2 = \frac{p_k^2}{4} \csc^2 \frac{\theta}{2}.$$
 (3.9)

By algebraic manipulations, the center $C_k(h_k, l_k)$, $k \ge 2$ is determined via

$$h_k = \frac{x_{k-1} + x_k}{2} - \frac{y_k - y_{k-1}}{2} \cot \frac{\theta}{2},\tag{3.10}$$

$$l_k = \frac{y_{k-1} + y_k}{2} + \frac{x_k - x_{k-1}}{2} \cot \frac{\theta}{2}.$$
(3.11)

Using (3.1)-(3.2), we obtain

$$h_k = p_0 + p_1 \cos \theta + \dots + p_{k-1} \cos(k-1)\theta + \frac{p_k}{2} \cos k\theta - \frac{p_k}{2} \sin k\theta \cot \frac{\theta}{2}, \tag{3.12}$$

$$l_k = p_1 \sin \theta + \dots + p_{k-1} \sin(k-1)\theta + \frac{p_k}{2} \sin k\theta + \frac{p_k}{2} \cos k\theta \cot \frac{\theta}{2}.$$
 (3.13)

Hence, taking into account the results of the previous section, all circles $\mathscr{C}_0, \mathscr{C}_1, \cdots, \mathscr{C}_n$ are completely determined. Now we prove that they satisfy (1.5). Indeed, by construction $R_{k-1} \in \mathcal{C}_{k-1} \cap \mathcal{C}_k$. This can be also verified by direct computations in the equations of \mathscr{C}_{k-1} , \mathscr{C}_k . Furthermore, $\mathscr{C}_{k-1} \cap \mathscr{C}_k = \{R_{k-1}\}$ and \mathscr{C}_k lies entirely outside \mathscr{C}_{k-1} , except for they touch each other at R_{k-1} because

$$\|C_{k+1} - C_k\|^2 = \left(\left(\frac{p_k}{2} \cos k\theta + \frac{p_{k+1}}{2} \cos(k+1)\theta \right) + \left(\frac{p_k}{2} \sin k\theta \cot \frac{\theta}{2} - \frac{p_{k+1}}{2} \sin(k+1)\theta \cot \frac{\theta}{2} \right) \right)^2$$

$$+ \left(\left(\frac{p_k}{2} \sin k\theta + \frac{p_{k+1}}{2} \sin(k+1)\theta \right) + \left(-\frac{p_k}{2} \cos k\theta \cot \frac{\theta}{2} + \frac{p_{k+1}}{2} \cos(k+1)\theta \cot \frac{\theta}{2} \right) \right)^2$$

$$= \frac{p_k^2}{2} + \frac{p_{k+1}^2}{2} + \frac{p_k p_{k+1}}{2} \cos \theta + \cot^2 \frac{\theta}{2} \left(\frac{p_k^2}{2} - \frac{p_{k+1}^2}{2} + \frac{p_k p_{k+1}}{2} \cos \theta \right) - p_k p_{k+1} \cot \frac{\theta}{2} \sin \theta$$

$$= \left(\frac{p_k^2}{4} - \frac{p_k p_{k+1}}{2} + \frac{p_{k+1}^2}{4} \right) \csc^2 \frac{\theta}{2} = \left(\frac{p_{k+1} - p_k}{2} \csc \frac{\theta}{2} \right)^2 = (r_{k+1} - r_k)^2.$$
(3.14)

Hence (1.5) is proved, completing the proof of Lemma 1.1. \Box

Lemma 1.1 remains true when $\theta = 0$, because in this case

$$R_0 = p_0 > 0, R_n = \sum_{j=0}^{n} p_j > 0,$$
 (3.15)

i.e. all points lie on the positive part of the *X*-axis. The circles $\mathscr{C}_0, \mathscr{C}_1, \cdots, \mathscr{C}_n$ are reduced to line segments. Nevertheless, $R_n \neq 0$. The lemma is also true if $\theta = \pi$, because

$$R_0 = p_0 > 0, R_n = p_0 - p_1 + p_2 - \dots + (-1)^n p_n.$$
 (3.16)

When n = 2m + 1 is odd, m > 0, then

$$R_n = (p_0 - p_1) + (p_2 - p_3) + \dots + (p_{2m} - p_{2m+1}) < 0,$$
 (3.17)

i.e. $R_n \neq 0$. Here the points R_j lie alternately on the positive and negative parts of the X-axis. If n = 2m is even, $m \geq 1$, then

$$R_n = p_0 + (p_2 - p_1) + \dots + (p_{2m} - p_{2m-1}) > 0.$$
(3.18)

i.e. $R_n \neq 0$. Also here the points R_j lie alternately on the positive and negative parts of the X-axis. Thus the lemma is true if $\theta = \pi$. The proofs when θ lies in the third or fourth quadrants results from the previous ones. According to Figure 5 (b), we can demonstrate a construction of R_n such that Lemma 1.1 is true for $\theta^* = \pi + \theta$, $0 < \theta < \pi$ and deduce geometrically that

$$p_0 + p_1 e^{i\theta^*} + p_2 e^{2i\theta^*} + \dots + p_n e^{in\theta^*} \neq 0.$$
 (3.19)

Remark 3.1 The points R_{k-1} , C_{k-1} , C_k are collinear. This is shown for \mathcal{C}_0 , \mathcal{C}_1 , \mathcal{C}_2 in the previous section by construction and by (2.4). By construction, this is also true for R_{k-1} , C_k , $k \ge 2$. Moreover, let

$$\Delta_k = \begin{vmatrix} x_{k-1} & y_{k-1} & 1 \\ h_{k-1} & l_{k-1} & 1 \\ h_k & l_k & 1 \end{vmatrix}, \quad k \ge 2.$$
(3.20)

From (3.1)-(3.2) and (3.12)-(3.13), we get

$$h_k = x_{k-1} + \frac{p_k}{2}\cos k\theta - \frac{p_k}{2}\sin k\theta \cot \frac{\theta}{2},$$
(3.21)

$$l_k = y_{k-1} + \frac{p_k}{2}\sin k\theta + \frac{p_k}{2}\cos k\theta\cot\frac{\theta}{2}.$$
 (3.22)

Consequently, using the properties of determinants, we obtain

$$\Delta_{k} = \begin{vmatrix} x_{k-1} & y_{k-1} & y_{k-1} & 1 \\ -\frac{p_{k-1}}{2}\cos(k-1)\theta - \frac{p_{k-1}}{2}\sin(k-1)\theta\cot\frac{\theta}{2} & -\frac{p_{k-1}}{2}\sin(k-1)\theta + \frac{p_{k-1}}{2}\cos(k-1)\theta\cot\frac{\theta}{2} & 0 \\ \frac{p_{k}}{2}\cos k\theta - \frac{p_{k}}{2}\sin k\theta\cot\frac{\theta}{2} & \frac{p_{k}}{2}\sin k\theta + \frac{p_{k}}{2}\cos k\theta\cot\frac{\theta}{2} & 0 \end{vmatrix} = 0.$$
 (3.23)

In the following section, we introduce another geometrically-based proof of Eneström-Kakeya's theorem. This approach is based on the following lemme.

Lemma 3.2 If $0 < q_n \le q_{n-1} \le \cdots \le q_1 \le q_0$ are positive numbers, $\theta \in \mathbb{R}$, $n \in \mathbb{N}_0$, then

$$Q_n = q_0 + q_1 e^{i\theta} + q_2 e^{2i\theta} + \dots + q_n e^{in\theta} \neq 0.$$
(3.24)

Proof Since

$$e^{-in\theta}Q_n = q_0e^{-in\theta} + q_1e^{-i(n-1)\theta} + q_2e^{-i(n-2)\theta} + \dots + q_{n-1}e^{-i\theta} + q_n,$$
(3.25)

then, Lemma 1.1 implies that $e^{-in\theta}Q_n \neq 0$, proving Lemma 3.2. \Box

Using a similar technique of Kakeya, we can prove Eneström-Kakeya's theorem using Lemma 3.2. However, the proof of Lemma 3.2 depends entirely on Lemma 1.1, and therefore adds no new. To have a completely independent proof, we can use a technique similar to the geometric structure (1.5), which is done in the next section.

4 Internally interlacing construction

Keeping previous notations, we prove that the points $Q_0 = q_0$, $Q_k = \sum_{j=0}^k q_j e^{ij\theta}$, $k = 1, 2, \dots, n$ lie on the internally interlacing circles \mathfrak{C}_0 , $\mathfrak{C}_1, \dots, \mathfrak{C}_n$ with centers and radii O_0, O_1, \dots, O_n and O_0, O_1, \dots, O_n respectively, for which

$$\mathfrak{C}_{k-1} \cap \mathfrak{C}_k = \{Q_{k-1}\}, \ \rho_{k-1} - \rho_k = \|O_{k-1} - O_k\|, \tag{4.1}$$

provided that the q_i 's are distinct and $\theta \neq 0, \pi$.




Fig. 6: The construction of \mathfrak{C}_0 , \mathfrak{C}_1 , \mathfrak{C}_2 when $\theta = \frac{5\pi}{12}$. (a) $q_0 = 3, q_1 = 2.5, q_2 = 1.5$ are different. (b) $q_0 = 3, q_1 = q_2 = 2.5$ and \mathfrak{C}_1 , \mathfrak{C}_2 are identical.




Fig. 7: The construction of \mathfrak{C}_0 , \mathfrak{C}_1 , \mathfrak{C}_2 when $\theta = \frac{\pi}{2}$. (a) $q_0 = 3, q_1 = 2.5, q_2 = 1.5$ are different. (b) $q_0 = 3, q_1 = q_2 = 2.5$ and \mathfrak{C}_1 , \mathfrak{C}_2 are identical.

As is done before, we discuss the construction for \mathfrak{C}_0 , \mathfrak{C}_1 , \mathfrak{C}_2 . We now assume without any loss of generality that $0 < \theta < \pi$. The circle \mathfrak{C}_0 is the one that passes through the origin O, the point $Q_0 = (q_0, 0)$ and $S_1 = \overrightarrow{OQ_0} + \overrightarrow{Q_0S_1}$, $\overrightarrow{Q_0S_1} = q_0e^{i\theta}$. Thus $S_1 = (q_0 + q_0 \cos \theta, q_0 \sin \theta)$. Therefore, the center and the radius of \mathfrak{C}_0 are

$$O_0\left(\frac{q_0}{2}, \frac{q_0}{2}\cot\frac{\theta}{2}\right), \ \rho_0 = \frac{q_0}{2}\csc\frac{\theta}{2}.$$
 (4.2)

If $q_0 = q_1$, then Q_1 is merely S_1 , and \mathfrak{C}_1 coincides with \mathfrak{C}_0 . Otherwise, Q_0S_1 is reduced to Q_0Q_1 , where $\overline{Q_0S_1} \parallel \overline{Q_0Q_1}$ and $\parallel Q_0Q_1 \parallel = q_1$. Thus $Q_1 = (q_0 + q_1\cos\theta, q_1\sin\theta) = \overrightarrow{OQ_1}$. The circle \mathfrak{C}_1 is determined by Q_0, Q_1 and the central angle $\angle Q_0O_1Q_1$, which is taken to be of measure θ . Thus

$$O_1\left(q_0 - \frac{q_1}{2}, \frac{q_1}{2}\cot\frac{\theta}{2}\right), \ \rho_1 = \frac{q_1}{2}\csc\frac{\theta}{2}.$$
 (4.3)

The circle \mathfrak{C}_1 lies entirely inside \mathfrak{C}_0 and it only touches it at Q_0 because

$$\rho_0 - \rho_1 = ||O_0 - O_1|| = \frac{q_0 - q_1}{2} \csc \frac{\theta}{2}. \tag{4.4}$$

Also Q_0 , O_0 , O_1 are collinear. The construction of \mathfrak{C}_2 is similar to that of \mathfrak{C}_1 . We first locate S_2 whose position vector is

$$\overrightarrow{OS_2} = \overrightarrow{OQ_0} + \overrightarrow{Q_0Q_1} + \overrightarrow{Q_1S_2}, \quad \overrightarrow{Q_1S_2} = q_1 e^{2i\theta}. \tag{4.5}$$

Thus the coordinates of S_2 are

$$S_2(q_0 + q_1\cos\theta + q_1\cos2\theta, q_1\sin\theta + q_1\sin2\theta)$$
. (4.6)

Again if $q_1 = q_2$, then $S_2 = Q_2$, and \mathfrak{C}_2 coincides with \mathfrak{C}_1 . Otherwise, we restrict $\overrightarrow{Q_1S_2}$ to $\overrightarrow{Q_1Q_2}$,

$$\overline{Q_1Q_2} \parallel \overline{Q_1S_2}, \quad \|\overline{Q_1Q_2}\| = q_2. \tag{4.7}$$

The circle \mathfrak{C}_2 is determined by Q_1 and Q_2 and the central angle $\angle Q_1 O_2 Q_2$, which is taken to satisfy $\angle Q_1 O_1 Q_2 = \theta$. Hence

$$O_2\left(q_0 + q_1\cos\theta + \frac{q_2}{2}\cos2\theta - \frac{q_2}{2}\sin2\theta\cot\frac{\theta}{2}, q_1\sin\theta + \frac{q_2}{2}\sin2\theta + \frac{q_2}{2}\cos2\theta\cot\frac{\theta}{2}\right), \ \rho_2 = \frac{q_2}{2}\csc\frac{\theta}{2}, \tag{4.8}$$

and Q_1, O_1, O_2 are collinear. Moreover,

$$\rho_1 - \rho_2 = ||O_1 - O_2|| = \frac{q_1 - q_2}{2} \csc \frac{\theta}{2},\tag{4.9}$$

i.e. \mathfrak{C}_1 lies entirely outside \mathfrak{C}_2 and it touches it only at Q_2 .




Fig. 8: The construction of \mathfrak{C}_0 , \mathfrak{C}_1 , \mathfrak{C}_2 when $\theta = \frac{2\pi}{3}$. (a) $q_0 = 3, q_1 = 2.5, q_2 = 1.5$ are different. (b) $q_0 = 3, q_1 = q_2 = 2.5$ and \mathfrak{C}_1 , \mathfrak{C}_2 are identical.

Figures 6-8 exhibit the constructions of \mathfrak{C}_0 , \mathfrak{C}_1 , \mathfrak{C}_2 for different values of θ . Figure 6 illustrates the construction of \mathfrak{C}_0 , \mathfrak{C}_1 , \mathfrak{C}_2 when $\theta = \frac{5\pi}{12}$ is acute. We considered two cases when q_0 , q_1 , q_2 are all different and when two values coincide to each others. The cases when θ is a right or an obtuse angle are depicted in Figure 7 and Figure 8 respectively. The construction coincide with our calculations.




Fig. 9: \mathfrak{C}_k lies entirely outside \mathfrak{C}_{k+1} and it only touches it at Q_k .

We proved (4.1) for \mathfrak{C}_0 , \mathfrak{C}_1 , \mathfrak{C}_2 . Now we accomplish the prove for all k. Indeed, let $k \geq 2$. Similar to Kakeya structure, the circle \mathfrak{C}_k is constructed to pass through Q_{k-1} , Q_k and $\angle Q_{k-1}O_kQ_k = \theta$. Thus \mathfrak{C}_k is completely determined. From triangle $\triangle Q_{k-1}O_kQ_k$, cf. Figure 9. The radius of \mathfrak{C}_k is

$$\rho_k = \frac{q_k}{2} \csc \frac{\theta}{2},\tag{4.10}$$

and the center $O_k(f_k, g_k), k \ge 2$ is determined via

$$f_k = \frac{u_{k-1} + u_k}{2} - \frac{v_k - v_{k-1}}{2} \cot \frac{\theta}{2}$$
(4.11)

$$g_k = \frac{v_{k-1} + v_k}{2} + \frac{u_k - u_{k-1}}{2} \cot \frac{\theta}{2},\tag{4.12}$$

where (u_k, v_k) are the coordinates of Q_k ,

$$u_{k} = \begin{cases} q_{0} + q_{1}\cos\theta + \dots + q_{k}\cos k\theta, & k \ge 1, \\ q_{0}, & k = 0, \end{cases}$$
(4.13)

$$u_{k} = \begin{cases} q_{0} + q_{1}\cos\theta + \dots + q_{k}\cos k\theta, & k \ge 1, \\ q_{0}, & k = 0, \end{cases}$$

$$v_{k} = \begin{cases} q_{1}\sin\theta + \dots + q_{k}\sin k\theta, & k \ge 1, \\ 0, & k = 0. \end{cases}$$

$$(4.13)$$

Using (4.13)-(4.14), we obtain

$$f_k = q_0 + q_1 \cos \theta + \dots + q_{k-1} \cos(k-1)\theta + \frac{q_k}{2} \cos k\theta - \frac{q_k}{2} \sin k\theta \cot \frac{\theta}{2}, \tag{4.15}$$

$$g_k = q_1 \sin \theta + \dots + q_{k-1} \sin(k-1)\theta + \frac{q_k}{2} \sin k\theta + \frac{q_k}{2} \cos k\theta \cot \frac{\theta}{2}. \tag{4.16}$$

Hence, the circles $\mathfrak{C}_0, \mathfrak{C}_1, \cdots, \mathfrak{C}_n$ are all determined. Using the techniques demonstrated above, the construction (4.1) can be analogously proved, and the proof of Lemma 3.2 is complete.
