# SHIFTED MOMENTS OF QUADRATIC DIRICHLET $L$-FUNCTIONS

#### Abstract

We establish sharp upper bounds for shifted moments of quadratic Dirichlet $L$-function under the generalized Riemann hypothesis. Our result is then used to prove bounds for moments of quadratic Dirichlet character sums.

## 1. Introduction

Moments of families of $L$-functions have been an important subject of study in number theory for their deep arithmetic implications. Building on the connections with random matrix theory, conjectural asymptotic formulas, due to J. P. Keating and N. C. Snaith [11, are available for moments of various families of $L$-functions. More precise predictions on the asymptotic behaviors of these moments with lower order terms are conjectured by J. B. Conrey, D. W. Farmer, J. P. Keating, M. O. Rubinstein and N. C. Snaith 3].

In [21, K. Soundararajan developed a method that makes attainable the predicted upper bounds for moments of $L$-functions under the generalized Riemann hypothesis (GRH). This strategy was further refined by A. J. Harper [6] in obtaining sharp upper bounds for moments of $L$-functions conditionally. Subsequent works on upper bounds for moments of families of $L$-functions using the above approach of Soundararajan and Harper include [2, 4, 15, 19, 22, 23 . Note that, rather than focusing only on moments of $L$-functions at the central point, most of the above-mentioned works investigate shifted moments of $L$-function at points on the critical line. In fact, as pointed out in [2] 22], this will allow one to understand the correlation between the values of $L$-functions on the critical line. Moreover, it is shown in [15, 23] that these shifted moments can be applied to obtain bounds for moments of character sums. In particular, B. Szabó [23, Theorem 3] proved, via the above approach, that for any real $k>2$, any large integer $q$ and $y \in \mathbb{R}$ with $2 \leq y \leq q^{1 / 2}$,

\sum_{\chi \in X_{q}^{*}}\left|\sum_{n \leq y} \chi(n)\right|^{2 k} \ll_{k} \varphi(q) y^{k}(\log y)^{(k-1)^{2}}
$$

Here $X_{q}^{*}$ denotes the set of primitive Dirichlet characters modulo $q$ and $\varphi(q)$ Euler's totient function.
Another interesting application concerns with moments of quadratic Dirichlet character sums. In this case, a conjecture of M. Jutila [10] asserts that for any positive integer $m$, there are constants $c_{1}(m), c_{2}(m)$, with values depending on $m$ only, such that

\sum_{\chi \in \mathcal{S}(X)}\left|\sum_{n \leq Y} \chi(n)\right|^{2 m} \leq c_{1}(m) X Y^{m}(\log X)^{c_{2}(m)} \tag{1.1}
\end{equation*}
$$

where $\mathcal{S}(X)$ stands for the set of all non-principal quadratic Dirichlet characters of modulus at most $X$.

In [9], Julita established (1.1) for $m=1$ with $c_{2}(m)=8$. This was later improved to by M. V. Armon (1) Theorem 2 ] who showed that we can take $c_{2}(m)=1$. Other related bounds can be found in [13, 24].

In [5], the authors confirmed a smoothed version of the above conjecture of Jutila under GRH, applying upper bounds on moments of quadratic Dirichlet $L$-functions. More precisely, we showed that for large $X, Y$ and any real $m \geq 1 / 2$,

\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\sum_{n} \chi^{(8 d)}(n) W\left(\frac{n}{Y}\right)\right|^{2 m} \ll X Y^{m}(\log X)^{m(2 m+1)} \tag{1.2}
\end{equation*}
$$

Here $\sum^{*}$ stands for the sum over square-free integers through out the paper, $W$ is any non-negative, smooth function compactly supported on the set of positive real numbers and $\chi^{(8 d)}$ denotes the Jacobi symbol ( $\frac{8 d}{.}$ ). Note that (see [20])
the character $\chi^{(8 d)}$ is primitive modulo $8 d$ for any positive, odd and square-free $d$.
The aim of this paper is to prove an unsmoothed version of (1.2). To this end, we first apply the above-mentioned approach of Soundararajan [21] with its refinement by Harper [6] to extend the results in [6, 17]. This establishes the following sharp upper bounds on moments of shifted quadratic Dirichlet $L$-functions.

Theorem 1.1. With the notation as above and the truth of $G R H$, let $k \geq 1$ be a fixed integer and $a_{1}, \ldots, a_{k}$, A fixed positive real numbers. Suppose that $X$ is a large real number and $t=\left(t_{1}, \ldots, t_{k}\right)$ a real $k$-tuple with $\left|t_{j}\right| \leq X^{A}$. Then

$$
\begin{aligned}
& \quad \sum_{\substack{(d, 2)=1 \\
d \leq X}}^{*}\left|L\left(1 / 2+i t_{1}, \chi^{(8 d)}\right)\right|^{a_{1}} \cdots\left|L\left(1 / 2+i t_{k}, \chi^{(8 d)}\right)\right|^{a_{k}} \\
& \ll
\end{aligned}
$$

where $\zeta(s)$ is the Riemann zeta function. Here the implied constant depends on $k, A$ and the $a_{j}$ 's, but not on $X$ or the $t_{j}$ 's.

In order to apply Theorem 1.1 in practice, one often needs to estimate the Riemann zeta function involved there. For this purpose, we apply (2.3) in Theorem 1.1 to readily deduce the following restatement of it.
Corollary 1.2. With the notation as above and the truth of $G R H$, let $k \geq 1$ be a fixed integer and $a_{1}, \ldots, a_{k}$, A fixed positive real numbers. Suppose that $X$ is a large real number and $t=\left(t_{1}, \ldots, t_{k}\right)$ a real $k$-tuple with $\left|t_{j}\right| \leq X^{A}$. Then

\begin{aligned}
& \sum_{\substack{(d, 2)=1 \\
d \leq X}}^{*}\left|L\left(\frac{1}{2}+i t_{1}, \chi^{(8 d)}\right)\right|^{a_{1}} \cdots\left|L\left(\frac{1}{2}+i t_{k}, \chi^{(8 d)}\right)\right|^{a_{k}} \\
& \quad \ll X(\log X)^{\left(a_{1}^{2}+\cdots+a_{k}^{2}\right) / 4} \prod_{1 \leq i<j \leq k} g\left(\left|t_{i}-t_{j}\right|\right)^{a_{i} a_{j} / 2} g\left(\left|t_{i}+t_{j}\right|\right)^{a_{i} a_{j} / 2} \prod_{1 \leq i \leq k} g\left(\left|2 t_{i}\right|\right)^{a_{i}^{2} / 4+a_{i} / 2}
\end{aligned}
$$

where $g: \mathbb{R}_{\geq 0} \rightarrow \mathbb{R}$ is defined by

$$
g(x)= \begin{cases}\log X, & \text { if } x \leq 1 / \log X \text { or } x \geq e^{X}  \tag{1.3}\\ 1 / x, & \text { if } 1 / \log X \leq x \leq 10 \\ \log \log x, & \text { if } 10 \leq x \leq e^{X}\end{cases}
$$

Here the implied constant depends on $k$, $A$ and the $a_{j}$ 's, but not on $X$ or the $t_{j}$ 's.
As an application of Corollary 1.2, our next result lends further credence to Jutila's conjecture.
Theorem 1.3. With the notation as above and the truth of GRH, for any integer $k \geq 1$ and any real number $m$ satisfying $2 m \geq k+1$, we have for large $X, Y$ and any $\varepsilon>0$,

\begin{equation*}
S_{m}(X, Y):=\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\right|^{2 m} \ll X Y^{m}(\log X)^{E(m, k, \varepsilon)} \tag{1.4}
\end{equation*}
$$

where

$$
\begin{equation*}
E(m, k, \varepsilon)=\max \left(2 m^{2}-m+1,(2 m-k)^{2} / 4+2 m+1+\varepsilon, 2 m^{2}-2 m k+3 k^{2} / 4+m-3 k / 4+\varepsilon\right) \tag{1.5}
\end{equation*}
$$

In particular, we have for $m>(\sqrt{5}+1) / 2$,

$$
\begin{equation*}
S_{m}(X, Y) \ll X Y^{m}(\log X)^{2 m^{2}-m+1} \tag{1.6}
\end{equation*}
$$

The bound in (1.6) follows from (1.4) by setting $k=2$ there and noting that $E(m, k, \varepsilon)=2 m^{2}-m+1$ for $m^{2}-m-1>0$. Moreover, Hölder's inequality yields that for any real number $n>1$,

S_{m}(X, Y) \ll X^{1-1 / n}\left(S_{m n}(X, Y)\right)^{1 / n}
$$

The above together with Theorem 1.3 then implies that $S_{m}(X, Y) \ll X Y^{m}(\log X)^{O(1)}$ for any $m>0$, upon choosing $n$ sufficiently enough.

## 2. Preliminaries

In this section, we cite some results needed in the proof of our theorems.
2.1. Sums over primes. We reserve the letter $p$ for a prime number in this paper. We have the following result concerning sums over primes.

Lemma 2.2. Let $x \geq 2$ and $\alpha \geq 0$. We have, for some constant $b_{1}$,

\begin{align*}
\sum_{p \leq x} \frac{1}{p} & =\log \log x+b_{1}+O\left(\frac{1}{\log x}\right),  \tag{2.1}\\
\sum_{p \leq x} \frac{\log p}{p} & =\log x+O(1), \quad \text { and }  \tag{2.2}\\
\sum_{p \leq x} \frac{\cos (\alpha \log p)}{p} & =\log |\zeta(1+1 / \log x+i \alpha)|+O(1) \leq \begin{cases}\log \log x+O(1) & \text { if } \alpha \leq 1 / \log x \text { or } \alpha \geq e^{x}, \\
\log (1 / \alpha)+O(1) & \text { if } 1 / \log x \leq \alpha \leq 10, \\
\log \log \log \alpha+O(1) & \text { if } 10 \leq \alpha \leq e^{x} .\end{cases} \tag{2.3}
\end{align*}
$$

The estimates in the first two cases of (2.3) are unconditional and the third holds under the Riemann hypothesis.
Proof. The expressions in (2.1) and (2.2) can be found in parts (d) and (b) of [6, Theorem 2.7], respectively. The equality in (2.3) is a special case given in [12, Lemma 3.2] and the other estimations can be found in [23, Lemma 2].
2.3. Smoothed character sums. We now define for any integer $d$,

\begin{equation*}
A(d)=\prod_{p \mid d}\left(1-\frac{1}{2 p}\right) \tag{2.4}
\end{equation*}
$$

As per convention, the empty product is 1 and the empty sum 0 . We observe that $A(d)>0$ for any $d$.
We write $\square$ for a perfect square of rational integers. Our next result is for smoothed quadratic character sums.
Lemma 2.4. Suppose that $\Phi$ is a non-negative smooth function whose support is a compact subset of the positive real numbers. With the notation as above and $k \in \mathbb{R}$ with $k>0$, for any positive even integer $n$,

$$
\begin{equation*}
\sum_{(d, 2)=1}^{*} A^{-k}(d) \chi^{(8 d)}(n) \Phi\left(\frac{d}{X}\right)=\sum_{(d, 2)=1}^{*} \chi^{(8 d)}(n) \Phi\left(\frac{d}{X}\right)=0 \tag{2.5}
\end{equation*}
$$

If $n$ is an odd positive integer, then

$$
\begin{align*}
& \sum_{(d, 2)=1}^{*} A(d)^{-k} \chi^{(8 d)}(n) \Phi\left(\frac{d}{X}\right)  \tag{2.6}\\
& \quad=\delta_{n=\square} \widehat{\Phi}(1) \frac{X}{2} \prod_{(p, 2)=1}\left(1-\frac{1}{p}\right)\left(1+\frac{A(p)^{-k}}{p}\right) \times \prod_{p \mid n}\left(1+\frac{A(p)^{-k}}{p}\right)^{-1}+O_{k}\left(X^{1 / 2+\varepsilon} n^{1 / 4+\varepsilon}\right), \\
& \sum_{(d, 2)=1}^{*} \chi^{(8 d)}(n) \Phi\left(\frac{d}{X}\right)=\delta_{n=\square} \widehat{\Phi}(1) \frac{2 X}{3 \zeta(2)} \prod_{p \mid n}\left(\frac{p}{p+1}\right)+O\left(X^{1 / 2+\varepsilon} n^{1 / 4+\varepsilon}\right) \tag{2.7}
\end{align*}
$$

where $\delta_{n=\square}=1$ if $n$ is a square and $\delta_{n=\square}=0$ otherwise.
Proof. The relations in (2.5) are valid trivially, as $\chi^{(8 d)}(n)=0$ if $n$ is even. Moreover, (2.6) and (2.7) can be established obtained in a manner similar way. Thus we shall only prove (2.6) here. Let $\mu(n)$ denote the Möbius function. The Mellin inversion gives that the left-hand side of (2.6) is

\begin{equation*}
\sum_{(d, 2)=1} A(d)^{-k} \mu^{2}(d) \chi^{(8 d)}(n) \Phi\left(\frac{d}{X}\right)=\frac{1}{2 \pi i} \int_{(2)} \chi^{(8)}(n)\left(\sum_{(d, 2)=1} \frac{A(d)^{-k} \mu^{2}(d) \chi^{(d)}(n)}{d^{s}}\right) \widehat{\Phi}(s) X^{s} \mathrm{~d} s \tag{2.8}
\end{equation*}
$$

Recall that the Mellin transform $\widehat{f}(s)$ with $s \in \mathbb{C}$ for any function $f$ is defined by

$$
\widehat{f}(s)=\int_{0}^{\infty} f(x) x^{s} \frac{\mathrm{~d} x}{x}
$$

and that repeated integration by parts yields that for any integer $E \geq 0$,

$$
\begin{equation*}
\widehat{\Phi}(s) \ll \frac{1}{(1+|s|)^{E}} \tag{2.9}
\end{equation*}
$$

Now we transform the integrand in (2.8) via the formula,

$$
\sum_{(d, 2)=1} \frac{A(d)^{-k} \mu^{2}(d) \chi^{(d)}(n)}{d^{s}}=\prod_{(p, 2)=1}\left(1+\frac{A(p)^{-k}\left(\frac{p}{n}\right)}{p^{s}}\right)=L^{(2)}(s,(\dot{\bar{n}})) P_{n}(s),
$$

where $L^{(n)}(s, \chi)$ denotes the Euler product of $L(s, \chi)$ with the primes dividing $n$ removed and

$$
P_{n}(s)=\prod_{(p, 2)=1}\left(1-\left(\frac{p}{n}\right) p^{-s}\right)\left(1+\frac{A(p)^{-k}\left(\frac{p}{n}\right)}{p^{s}}\right) .
$$

Note that $P_{n}(s)$ is analytic in the region $\Re(s)>\frac{1}{2}$.
We now shift the line of integration in (2.8) to the line $\Re(s)=1 / 2+\varepsilon$, pasing a simple pole at $s=1$ for $n=\square$. The residue is

$$
\widehat{\Phi}(1) \frac{X}{2} \prod_{(p, 2)=1}\left(1-\frac{1}{p}\right)\left(1+\frac{A(p)^{-k}}{p}\right) \times \prod_{p \mid n}\left(1+\frac{A(p)^{-k}}{p}\right)^{-1}
$$

The convexity bound (see [8, exercise 3 , p. 100]) asserts that for $0 \leq \Re(s) \leq 1$,

$$
L\left(s,\left(\frac{\dot{n}}{n}\right)\right) \ll(n \cdot(1+|s|))^{(1-\Re(s)) / 2+\varepsilon} .
$$

Now, this, together with (2.9), implies that the contribution from the integration on the new line can be absorbed in the $O$-term in (2.6). This establishes the lemma.
2.5. Upper bounds for quadratic Dirichlet $L$-functions. Let $\Lambda(n)$ denote the von Mangoldt function. We cite the following result for $\log \left|L\left(\sigma+i t, \chi^{(8 d)}\right)\right|$ from [15, Proposition 2.3].
Lemma 2.6. Assume the truth of GRH. Let $\sigma \geq 1 / 2$ and $t$ be real numbers and define $\log ^{+} t=\max \{0, \log t\}$. For any primitive Dirichlet character $\chi$ modulo $q$, we have for any $x \geq 2$,

$$
\log |L(\sigma+i t, \chi)| \leq \Re \sum_{n \leq x} \frac{\chi(n) \Lambda(n)}{n^{1 / 2+\max (\sigma-1 / 2,1 / \log x)+i t} \log n} \frac{\log x / n}{\log x}+\frac{\log q+\log ^{+} t}{\log x}+O\left(\frac{1}{\log x}\right) .
$$

Proof. If $\sigma \geq 1 / 2+1 / \log x$, then we apply [15, (2.8)] by setting $s_{0}=\sigma+i t$ there and note that the contribution from terms involving $F_{\chi}\left(s_{0}\right)$ is negative. If $\sigma<1+\lambda_{0} / \log x$, then we set $\sigma_{0}=1 / 2+1 / \log x$ in [15, Proposition 2.3] to obtain the desired bound. This completes the proof.

We apply the above lemma and argue as in the proof of [23, Lemma 3] to deduce the following bound for sums of $\log \left|L\left(\sigma+i t, \chi^{(8 d)}\right)\right|$ over various $t$.

Lemma 2.7. Let $k$ be a positive integer and let $Q, a_{1}, a_{2}, \ldots, a_{k}$ be fixed positive real constants, $x \geq 2$. Set $a:=$ $a_{1}+\cdots+a_{k}$. Suppose $X$ is a large real number, $d$ any positive, odd and square-free number with $d \leq X, \sigma \geq 1 / 2$ and $t_{1}, \ldots, t_{k}$ be fixed real numbers with $\left|t_{i}\right| \leq X^{Q}$. For any integer $n$, let

$$
h(n)=: \frac{1}{2} \Re\left(\sum_{m=1}^{k} a_{m} n^{-i t_{m}}\right)
$$

Then, we have, under GRH,

$$
\begin{align*}
& \sum_{m=1}^{k} a_{m} \log \left|L\left(\sigma+i t_{m}, \chi^{(8 d)}\right)\right|  \tag{2.10}\\
& \quad \leq 2 \sum_{p \leq x} \frac{h(p) \chi^{(8 d)}(p)}{p^{1 / 2+\max (\sigma-1 / 2,1 / \log x)}} \frac{\log x / p}{\log x}+\sum_{p \leq x^{1 / 2}} \frac{h\left(p^{2}\right) \chi^{(8 d)}\left(p^{2}\right)}{p^{1+2 \max (\sigma-1 / 2,1 / \log x)}}+(Q+1) a \frac{\log X}{\log x}+O(1) .
\end{align*}
$$

We note that

$$
\begin{align*}
\sum_{p \leq x^{1 / 2}} \frac{h\left(p^{2}\right) \chi^{(8 d)}\left(p^{2}\right)}{p^{1+2 \max (\sigma-1 / 2,1 / \log x)}} & =\sum_{p \leq x^{1 / 2}} \frac{h\left(p^{2}\right)}{p^{1+2 \max (\sigma-1 / 2,1 / \log x)}}-\sum_{\substack{p \leq x^{1 / 2} \\
p \mid d}} \frac{h\left(p^{2}\right)}{p^{1+2 \max (\sigma-1 / 2,1 / \log x)}}  \tag{2.11}\\
& \leq \sum_{p \leq x^{1 / 2}} \frac{h\left(p^{2}\right)}{p^{1+2 \max (\sigma-1 / 2,1 / \log x)}}+a \sum_{p \mid d} \frac{1}{2 p} .
\end{align*}
$$

Using the inequality $x \leq-\log (1-x)$ for any $0<x<1$, we see that the last expression above is

$$
\begin{equation*}
\leq \sum_{p \leq x^{1 / 2}} \frac{h\left(p^{2}\right)}{p^{1+2 \max (\sigma-1 / 2,1 / \log x)}}-a \sum_{p \mid d} \log \left(1-\frac{1}{2 p}\right) . \tag{2.12}
\end{equation*}
$$

Upon applying (2.4), (2.11)-(2.12) in (2.10), we immediately deduce the following simplified version of Lemma 2.7
Proposition 2.8. Keep the notations of Lemma 2.7 and assume the truth of GRH, we have

$$
\begin{align*}
& \sum_{m=1}^{k} a_{m} \log \left|A(d) L\left(\sigma+i t_{m}, \chi^{(8 d)}\right)\right| \\
& \quad \leq 2 \sum_{p \leq x} \frac{h(p) \chi^{(8 d)}(p)}{p^{1 / 2+\max (\sigma-1 / 2,1 / \log x)}} \frac{\log x / p}{\log x}+\sum_{p \leq x^{1 / 2}} \frac{h\left(p^{2}\right)}{p^{1+2 \max (\sigma-1 / 2,1 / \log x)}}+(Q+1) a \frac{\log X}{\log x}+O(1) . \tag{2.13}
\end{align*}
$$

We also note the following upper bounds on moments of quadratic twists of $L$-functions, which can be obtained by modifying the proof of [6, Theorem 2].

Lemma 2.9. With the notation as above and the truth of $G R H$, let $k \geq 1$ be a fixed integer and $\mathbf{a}=\left(a_{1}, \ldots, a_{k}\right)$, $t=$ $\left(t_{1}, \ldots, t_{k}\right)$ be real $k$-tuples such that $a_{i} \geq 0$ for all $i$. Set $a=a_{1}+\cdots+a_{k}$. Then for large real number $X$ and $\sigma \geq 1 / 2$,

$$
\sum_{\substack{(d, 2)=1 \\ d \leq X}}^{*}\left|L\left(\sigma+i t_{1}, \chi^{(8 d)}\right)\right|^{a_{1}} \cdots\left|L\left(\sigma+i t_{k}, \chi^{(8 d)}\right)\right|^{a_{k}}<_{\mathbf{a}} X(\log X)^{a(a+1) / 2}
$$

## 3. Proof of Theorem 1.1

We remark here that throughout our proof, the implied constants involved in various estimations using $\ll$ or the big- $O$ notations depend on $\mathbf{a}:=\left(a_{1}, \cdots, a_{k}\right)$ only and are uniform with respect to $X$. We set $a=\sum_{i=1}^{k} a_{i}$ and recall the convention that an empty product equals to 1 .

Let $\Phi$ be a smooth, non-negative function such that $\Phi(x) \leq 1$ for all $x$ and that $\Phi$ is supported on $[1 / 4,3 / 2]$ satisfying $\Phi(x)=1$ for $x \in[1 / 2,1]$. Upon dividing $0<d \leq X$ into dyadic blocks, we see that in order to prove Theorem 1.1, it suffices to show that for $\sigma=1 / 2$,

\begin{align*}
& \sum_{\substack{(d, 2)=1 \\
d \leq X}}^{*}\left|L\left(\sigma+i t_{1}, \chi^{(8 d)}\right)\right|^{a_{1}} \cdots\left|L\left(\sigma+i t_{k}, \chi^{(8 d)}\right)\right|^{a_{k}} \Phi\left(\frac{d}{X}\right)  \tag{3.1}\\
& \quad \ll X(\log X)^{\left(a_{1}^{2}+\cdots+a_{k}^{2}\right) / 4} \\
& \quad \times \prod_{1 \leq j<l \leq k}\left|\zeta\left(1+i\left(t_{j}-t_{l}\right)+\frac{1}{\log X}\right)\right|^{a_{i} a_{j} / 2}\left|\zeta\left(1+i\left(t_{j}+t_{l}\right)+\frac{1}{\log X}\right)\right|^{a_{i} a_{j} / 2} \prod_{1 \leq j \leq k}\left|\zeta\left(1+2 i t_{j}+\frac{1}{\log X}\right)\right|^{a_{i}^{2} / 4+a_{i} / 2}
\end{align*}
$$

We shall treat $\sigma$ as a fixed real number with $\sigma \geq 1 / 2$ instead of focusing only on the case of $\sigma=1 / 2$ in the most part of our proof in what follows since we would like to present a proof that is valid for a general $\sigma$. Of course, Theorem 1.1 follows from (3.1) by setting $\sigma=1 / 2$.

Following the ideas of A. J. Harper in [6], we define for a large number $M$, depending on a only,

& \ll \exp \left(-\frac{(Q+1) a}{\alpha_{j}}\right) X \exp \left(\sum_{p \in \cup_{l=1}^{j} P_{l}} \frac{a^{2} h^{2}\left(p, \sigma, X^{\alpha_{j}}\right)}{2 p}+\sum_{p \leq X^{\alpha_{j} / 2}} \frac{a^{2} h_{1}\left(p, \sigma, X^{\alpha_{j}}\right)}{4 p}\right),

We now apply (2.3) to evaluate the last expression in (3.37) and then substitute the result into (3.36). Summing over $j$, which then leads to a convergent series. This allows us to derive the desired estimation in (3.15) and hence completes the proof of Theorem 1.1

## 4. Proof of Theorem 1.3

4.1. Initial treatments. As explained in the paragraph below Theorem 1.3) it suffices to establish (1.4). To that end, we note first that by [1. Theorem 1] that we have for any $m>0$,

We denote the Mellin transform of $\Phi_{U}$ by $\widehat{\Phi}_{U}$ and observe that repeated integration by parts gives that, for any integer $E \geq 1$ and $\Re(s) \geq 1 / 2$,

We split the range of integral in (4.5) into two parts, $|\Im(s)| \leq X^{Q}$ and $|\Im(s)|>X^{Q}$, for some $Q>0$ to be specified later, obtaining that (4.5) is

We next apply (4.1) and Hölder's inequality to deduce that, as $m \geq 1 / 2$,
$\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\int_{\substack{(1 / 2) \\|\Im(s)|>X^{Q}}} L\left(s, \chi^{(8 d)}\right) Y^{s} \widehat{\Phi}_{U}(s) \mathrm{d} s\right|^{2 m} \ll Y^{m}\left(\int_{\substack{(1 / 2) \\|\Im(s)|>X^{Q}}}\left|\widehat{\Phi}_{U}(s)\right||\mathrm{d} s|\right)^{2 m-1} \int_{\substack{(1 / 2) \\|\Im(s)|>X^{Q}}} \sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|L\left(s, \chi^{(8 d)}\right)\right|^{2 m}\left|\widehat{\Phi}_{U}(s)\right||\mathrm{d} s|$.
By (4.1),

\end{equation*}

We now set $U=X^{2 \varepsilon}$ and $Q=4 \varepsilon$. From (4.2), (4.5)-(4.8),

(d, 2)=1}}^{*}\left|\int_{\substack{(1 / 2) \\
|t| \leq X^{\varepsilon}}}\right| L\left(\frac{1}{2}+i t, \chi^{(8 d)}\right)\left|\frac{1}{1+|t|} \mathrm{d} t\right|^{2 m}+\sum_{\substack{d \leq X \\
(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\left(1-\Phi_{U}\left(\frac{n}{Y}\right)\right)\right|^{2 m}+O\left(X Y^{m}\right) . \tag{4.9}

Theorem 1.3 follows from the following Lemma.

The remainder of the paper will be devoted to the proofs of these Lemmas.

## 5. Proof of Lemma 4.2

Our proof follows closely the treatments in [23]. We deduce from (4.9) by symmetry and Hölder's inequality that for $a=1-1 /(2 m)+\varepsilon$ with $\varepsilon>0$,

& \quad \leq\left(\sum_{n \leq \log X+1} n^{-2 a m /(2 m-1)}\right)^{2 m-1} \sum_{n \leq \log X+1}\left(n^{a} \int_{e^{n-1}-1}^{e^{n}-1} \frac{\left|L\left(\frac{1}{2}+i t, \chi^{(8 d)}\right)\right|}{t+1} \mathrm{~d} t\right)^{2 m} \\
& \quad \ll \sum_{n \leq \log X+1} \frac{n^{2 m-1+\varepsilon}}{e^{2 n m}}\left(\int_{e^{n-1}-1}^{e^{n}-1}\left|L\left(\frac{1}{2}+i t, \chi^{(8 d)}\right)\right| \mathrm{d} t\right)^{2 m}
\end{aligned}

We need the following result, which will be proved later, to estimate the last expression above.
Proposition 5.1. With the notation as above and the truth of GRH, we have for any fixed integer $k \geq 1$ and any real numbers $2 m \geq k+1,10 \leq E=X^{O(1)}$,

We apply Proposition 5.1 to see that for any integer $k \geq 1$ and any real numbers $2 m \geq k+1, \varepsilon>0$,

& \left.\quad+(\log X)^{2 m^{2}-2 m k+3 k^{2} / 4+m-3 k / 4}(\log 2 n)^{O(1)}(\log \log X)^{O(1)} e^{(2 m-1) n}\right) \ll X(\log X)^{E(m, k, \varepsilon)}
\end{aligned}

We now deduce from the above that (4.10) holds, completing the proof of the Lemma 4.2
Proof of Proposition 5.1. We have by symmetry that for each $d$,

where $\mathcal{D}=\mathcal{D}\left(t_{1}, \ldots, t_{k}\right)=\left\{u \in[0, E]:\left|t_{1}-u\right| \leq\left|t_{2}-u\right| \leq \ldots \leq\left|t_{k}-u\right|\right\}$.
We set $\mathcal{B}_{1}=\left[-\frac{1}{\log X}, \frac{1}{\log X}\right], \mathcal{B}_{j}=\left[-\frac{e^{j-1}}{\log X},-\frac{e^{j-2}}{\log X}\right] \cup\left[\frac{e^{j-2}}{\log X}, \frac{e^{j-1}}{\log X}\right]$ for $2 \leq j<\lfloor\log \log X\rfloor+10=$ : $K$ and $\mathcal{B}_{K}=[-E, E] \backslash \bigcup_{1 \leq j<K} \mathcal{B}_{j}$.

Observe that for any $t_{1} \in[0, E]$, we have $\mathcal{D} \subset[0, E] \subset t_{1}+[-E, E] \subset \bigcup_{1 \leq j \leq K} t_{1}+\mathcal{B}_{j}$. Thus if we denote $\mathcal{A}_{j}=\mathcal{B}_{j} \cap\left(-t_{1}+\mathcal{D}\right)$, then $\left(t_{1}+\mathcal{A}_{j}\right)_{1 \leq j \leq K}$ form a partition of $\mathcal{D}$. Using Hölder's inequality twice to deduce that

\ll & \sum_{1 \leq j \leq K} j^{2 m-k}\left(\int_{t_{1}+\mathcal{A}_{j}}\left|L\left(\frac{1}{2}+i u, \chi^{(8 d)}\right)\right| \mathrm{d} u\right)^{2 m-k} \leq \sum_{1 \leq j \leq K} j^{2 m-k}\left|\mathcal{B}_{j}\right|^{2 m-k-1} \int_{t_{1}+\mathcal{A}_{j}}\left|L\left(1 / 2+i u, \chi^{(8 d)}\right)\right|^{2 m-k} \mathrm{~d} u .

& \ll \sum_{1 \leq l_{0}, l_{1}, \ldots l_{k-1} \leq K} l_{0}^{2 m-k}\left|\mathcal{B}_{l_{0}}\right|^{2 m-k-1} \int_{\mathcal{C}_{l_{0}, l_{1}, \cdots, l_{k-1}}} L(\mathbf{t}, u) \mathrm{d} u \mathrm{~d} \mathbf{t}
\end{align*}

We now separate two cases in the last summation of (5.4) according to the size of $l_{0}$.
Case 1: $l_{0}<K$. First, the volume of the region $\mathcal{C}_{l_{0}, l_{1}, \cdots, l_{k-1}}$ is $\ll E^{k} e^{l_{0}+l_{1}+\cdots+l_{k-1}}(\log X)^{-k}$. Also, by the definition of $\mathcal{C}_{l_{0}, l_{1}, \cdots, l_{k-1}}$ and the observation that $t_{i}, u \geq 0,1 \leq i \leq k, e^{l_{0}} / \log X \ll\left|t_{1}-u\right| \ll\left|t_{1}+u\right| \ll E=X^{O(1)}$ so that $g\left(\left|t_{1} \pm u\right|\right) \ll \log X \cdot \log \log E / e^{l_{0}}$, where we recall the definition of $g$ in (1.3). We deduce from the definition of $\mathcal{A}_{j}$ that $\left|t_{2}-u\right| \geq\left|t_{1}-u\right|$, so that $E \gg\left|t_{2}+u\right| \gg\left|t_{2}-u\right|=\left|t_{1}-u\right|+\left(\left|t_{2}-u\right|-\left|t_{1}-u\right|\right) \gg e^{l_{0}} / \log X+e^{l_{1}} / \log X$, which implies that $g\left(\left|t_{2} \pm u\right|\right) \ll \log X \cdot \log \log E / e^{\max \left(l_{0}, l_{1}\right)}$. Similarly, we have $g\left(\left|t_{i} \pm u\right|\right) \ll \log X \cdot \log \log E / e^{\max \left(l_{0}, l_{1}, \ldots, l_{i-1}\right)}$ for any $1 \leq i \leq k$. Moreover, we have $\sum_{s=i}^{j-1}\left(\left|t_{s+1}-u\right|-\left|t_{s}-u\right|\right) \leq\left|t_{j}-t_{i}\right| \leq\left|t_{j}+t_{i}\right|$ for any $1 \leq i<j \leq k$, so that we have $g\left(\left|t_{j} \pm t_{i}\right|\right) \ll \log X \cdot \log \log E / e^{\max \left(l_{i}, \ldots, l_{j-1}\right)}$. We also bound $g\left(\left|2 t_{i}\right|\right), 1 \leq i \leq k$ and $g(|2 u|)$ trivially by $\log X$ to deduce from Corollary 1.2 that for $\left(t_{1}, \ldots, t_{k}, u\right) \in \mathcal{C}_{l_{0}, l_{1}, \cdots, l_{k-1}}$,

&=X(\log X)^{m(2 m+1)}(\log \log E)^{O(1)} \exp \left(-(2 m-k) \sum_{i=0}^{k-1} \max \left(l_{0}, l_{1}, \ldots, l_{i}\right)-\sum_{i=1}^{k-1} \sum_{j=i+1}^{k} \max \left(l_{i}, \ldots, l_{j-1}\right)\right) .
\end{aligned}

Moreover, $\left|\mathcal{B}_{l_{0}}\right| \ll e^{l_{0}} / \log X$, so that

\times \sum_{\substack{1 \leq l_{0}<K \\ 1 \leq l_{1}, \ldots l_{k-1} \leq K}} l_{0}^{2 m-k} \exp \left((2 m-k-1) l_{0}+\sum_{i=0}^{k-1} l_{i}-(2 m-k) \sum_{i=0}^{k-1} \max \left(l_{0}, l_{1}, \ldots, l_{i}\right)-\sum_{i=1}^{k-1} \sum_{j=i+1}^{k} \max \left(l_{i}, \ldots, l_{j-1}\right)\right)

=X(\log X)^{2 m^{2}-m+1} E^{k}(\log \log E)^{O(1)}
$$

\times \sum_{\substack{1 \leq l_{0}<K \\ 1 \leq l_{1}, \ldots l_{k-1} \leq K}} l_{0}^{2 m-k} \exp \left(-(2 m-k) \sum_{i=1}^{k-1} \max \left(l_{0}, l_{1}, \ldots, l_{i}\right)-\sum_{i=1}^{k-1} \sum_{j=i+2}^{k} \max \left(l_{i}, \ldots, l_{j-1}\right)\right)

\ll X(\log X)^{2 m^{2}-m+1} E^{k}(\log \log E)^{O(1)} \sum_{\substack{1 \leq l_{0}<K \\ 1 \leq l_{1}, \ldots l_{k-1} \leq K}} l_{0}^{2 m-k} \exp \left(-(2 m-k) \sum_{i=1}^{k-1} \frac{\sum_{s=0}^{i} l_{s}}{i+1}-\sum_{i=1}^{k-1} \sum_{j=i+2}^{k} \frac{\sum_{s=1}^{j-1} l_{s}}{j-i}\right)

\ll X(\log X)^{2 m^{2}-m+1} E^{k}(\log \log E)^{O(1)}

Case $2 l_{0}=K$. For each $1 \leq i \leq k$, we have $g\left(\left|t_{i} \pm u\right|\right) \ll \log \log E$. Also, similar to Case 1 , we have $g\left(\left|t_{j} \pm t_{i}\right|\right) \ll$ $\log X / e^{\max \left(l_{i}, \ldots, l_{j-1}\right)}$ for $1 \leq i \leq k$. As $\left|t_{1}-u\right| \leq\left|t_{1}\right|+|u|$, we see that either $|u| \geq 5$ or $|u| \leq 5$. If $|u| \geq 5$, then we have $g(|2 u|) \ll \log \log E$. We further use the trivial bound $g\left(\left|2 t_{i}\right|\right) \ll \log X$ with $1 \leq i \leq k$, obtaining

\end{aligned}

The volume of the region $\mathcal{C}_{K, l_{1}, \cdots, l_{k-1}}$ is $\ll E^{k+1} e^{l_{1}+\cdots+l_{k-1}}(\log X)^{-k+1}$. As $\left|\mathcal{B}_{K}\right| \ll E$, we deduce from the above that

& \times \sum_{1 \leq l_{1}, \ldots l_{k-1} \leq K} \exp \left(\sum_{i=1}^{k-1} l_{i}-\sum_{i=1}^{k-1} \sum_{j=i+1}^{k} \max \left(l_{i}, \ldots, l_{j-1}\right)\right) \\
& \ll X(\log X)^{(2 m-k)^{2} / 4+1} E^{2 m}(\log \log E)^{O(1)}(\log \log X)^{O(1)} \text {. }
\end{align*}
$$

As we have $\left|t_{i}\right| \geq 5$ for any $1 \leq i \leq k$ when $|u| \leq 5$, we see that the volume of the region $\mathcal{C}_{K, l_{1}, \cdots, l_{k-1}}$ when $|u| \leq 5$ is $\ll E^{k}$. It follows that

$$
\begin{gather*}
\sum_{1 \leq l_{1}, \ldots l_{k-1} \leq K} K^{2 m-k}\left|\mathcal{B}_{K}\right|^{2 m-k-1} \quad \int \quad L(\mathbf{t}, u) \mathrm{d} u \mathrm{dt} \\
\qquad \begin{array}{c}
\mathcal{C}_{K, l_{1}, \ldots, l_{k-1}}^{|u| \leq 5}
\end{array}  \tag{5.7}\\
\ll X(\log X)^{2 m^{2}-2 m k+3 k^{2} / 4+m-3 k / 4} E^{2 m-1}(\log \log E)^{O(1)}(\log \log X)^{O(1)} \\
\times \sum_{1 \leq l_{1}, \ldots l_{k-1} \leq K} \exp \left(-\sum_{i=1}^{k-1} \sum_{j=i+1}^{k} \max \left(l_{i}, \ldots, l_{j-1}\right)\right) \\
\ll X(\log X)^{2 m^{2}-2 m k+3 k^{2} / 4+m-3 k / 4} E^{2 m-1}(\log \log E)^{O(1)}(\log \log X)^{O(1)} .
\end{gather*}
$$

We now deduce the estimation in (5.1) using (5.5)-(5.7). This completes the proof of the proposition.

## 6. Proof of Lemma 4.3

We apply the Cauchy-Schwarz inequality to see that

$$
\begin{align*}
& \sum_{\substack{d \leq X \\
(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\left(1-\Phi_{U}\left(\frac{n}{Y}\right)\right)\right|^{2 m} \\
& \quad \leq\left(\sum_{\substack{d \leq X \\
(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\left(1-\Phi_{U}\left(\frac{n}{Y}\right)\right)\right|^{2}\right)^{1 / 2}\left(\sum_{\substack{d \leq X \\
(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\left(1-\Phi_{U}\left(\frac{n}{Y}\right)\right)\right|^{4 m-2}\right)^{1 / 2} \tag{6.1}
\end{align*}
$$

It follows from [7, Corollary 2] that for arbitrary complex numbers $a_{n}$, for $X, Z \geq 2$ and any $\varepsilon>0$, we have

$$
\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\sum_{n \leq Z} a_{n} \chi^{(8 d)}(n)\right|^{2} \ll(X Z)^{\varepsilon}(X+Z) \sum_{\substack{m, n \leq Z \\ m n=\square}}\left|a_{m} a_{n}\right|
$$

The above with $Z=Y$, mindful of our assumption that $Y \leq X$, leads to

$$
\begin{aligned}
\sum_{\substack{d \leq X \\
(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\left(1-\Phi_{U}\left(\frac{n}{Y}\right)\right)\right|^{2} & \ll(X Y)^{\varepsilon}(X+Y) \sum_{\substack{n_{1}, n_{2} \leq Y \\
n_{1} n_{2}=\square}}\left(1-\Phi_{U}\left(\frac{n_{1}}{Y}\right)\right)\left(1-\Phi_{U}\left(\frac{n_{2}}{Y}\right)\right) \\
& \ll X^{1+\varepsilon} \sum_{\substack{1-1 / U) \leq n_{1}, n_{2} \leq Y \\
n_{1} n_{2}=\square}} 1 .
\end{aligned}
$$

We evaluate the last expression above by writing $n_{1}=d_{1} m_{1}^{2}, n_{2}=d_{1} m_{2}^{2}$ with $d_{1}$ square. The above is

$$
\begin{align*}
\ll X^{1+\varepsilon} \sum_{d_{1} \leq Y} \sum_{\left(Y(1-1 / U) / d_{1}\right)^{1 / 2} \leq m_{1}, m_{2} \leq\left(Y / d_{1}\right)^{1 / 2}} & \ll X^{1+\varepsilon} \sum_{d_{1} \leq Y}\left(\left(Y / d_{1}\right)^{1 / 2}-\left(Y(1-1 / U) / d_{1}\right)^{1 / 2}\right)^{2}  \tag{6.2}\\
& \ll X^{1+\varepsilon} \sum_{d_{1} \leq Y} \frac{Y}{d_{1} U^{2}} \ll X^{1+\varepsilon} Y U^{-2} \log Y .
\end{align*}
$$

Next note that

$$
\begin{equation*}
\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\left(1-\Phi_{U}\left(\frac{n}{Y}\right)\right)\right|^{4 m-2} \ll \sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\right|^{4 m-2}+\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n) \Phi_{U}\left(\frac{n}{Y}\right)\right|^{4 m-2} . \tag{6.3}
\end{equation*}
$$

By the remark below Theorem 1.3 we get that

$$
\begin{equation*}
\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n) \Phi_{U}\left(\frac{n}{Y}\right)\right|^{4 m-2} \ll X Y^{2 m-1}(\log X)^{O(1)} \tag{6.4}
\end{equation*}
$$

To estimate the first expression on the right-hand side of (6.3), we apply Perron's formula as given in 14, Corollary 5.3]. Hence

$$
\begin{align*}
\sum_{n \leq Y} \chi^{(8 d)}(n) & =\frac{1}{2 \pi i} \int_{1+1 / \log Y-i Y}^{1+1 / \log Y+i Y} L\left(s, \chi^{(8 d)}\right) \frac{Y^{s}}{s} \mathrm{~d} s+R_{1}+R_{2} \\
& =\frac{1}{2 \pi i} \int_{1 / 2-i Y}^{1 / 2+i Y}+\frac{1}{2 \pi i} \int_{1+1 / \log Y-i Y}^{1 / 2-i Y}+\frac{1}{2 \pi i} \int_{1 / 2+i Y}^{1+1 / \log Y+i Y} L\left(s, \chi^{(8 d)}\right) \frac{Y^{s}}{s} \mathrm{~d} s+R_{1}+R_{2}, \tag{6.5}
\end{align*}
$$

where

$$
\begin{equation*}
R_{1} \ll \sum_{\substack{Y / 2<n<2 Y \\ n \neq Y}} \min \left(1, \frac{1}{|n-Y|}\right) \ll \log Y \quad \text { and } \quad R_{2} \ll \frac{4^{1+1 / \log Y}+Y^{1+1 / \log Y}}{Y} \zeta(1+1 / \log Y) \ll \log Y \tag{6.6}
\end{equation*}
$$

Here the last estimation above follows from [14, Corollary 1.17]. We now consider the moments of the horizontal integrals in (6.5). We may assume that $Y \geq 10$, otherwise the lemma is trivial. By symmetry we only need to consider only one of them. Note that we have $\left|Y^{s} / s\right| \ll 1$ in that range and $m \geq 1$, which allows us to apply Hölder's inequality to get

$$
\begin{align*}
\left.\left.\sum_{\substack{d \leq X \\
(d, 2)=1}}^{*}\right|^{1+1 / \log Y+i Y} \int_{1 / 2+i Y} L\left(s, \chi^{(8 d)}\right) \frac{Y^{s}}{s} \mathrm{~d} s\right|^{4 m-2} & \ll \sum_{\substack{d \leq X \\
(d, 2)=1}}^{*}\left(\int_{1 / 2+i Y}^{1+1 / \log Y+i Y}\left|L\left(s, \chi^{(8 d)}\right)\right||\mathrm{d} s|\right)^{4 m-2} \\
& \ll \sum_{\substack{d \leq X \\
(d, 2)=1}}^{*} \int_{1 / 2+i Y}^{1+1 / \log Y+i Y}\left|L\left(s, \chi^{(8 d)}\right)\right|^{4 m-2}|\mathrm{~d} s| \ll X(\log X)^{O(1)} . \tag{6.7}
\end{align*}
$$

To get the last bound above, we utilize Lemma [2.9] which gives that for $1 / 2 \leq \Re(s) \leq 1+1 / \log Y$, under GRH,

$$
\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|L\left(s, \chi^{(8 d)}\right)\right|^{4 m-2} \ll X(\log X)^{O(1)}
$$

We treat the vertical integral in (6.5) using Hölder's inequality, Proposition 5.1 with $k=1$ and the assumption $Y \leq X$. Thus

$$
\left.\left.\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\right|_{1 / 2-i Y} ^{1 / 2+i Y} L\left(s, \chi^{(8 d)}\right) \frac{Y^{s}}{s} \mathrm{~d} s\right|^{4 m-2} \ll Y^{2 m-1} \sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left(\int_{0}^{Y} \frac{\left|L\left(\frac{1}{2}+i t, \chi^{(8 d)}\right)\right|}{t+1} \mathrm{~d} t\right)^{4 m-2}
$$

$$
\begin{aligned}
& \ll Y^{2 m-1} \sum_{n \leq \log Y+2} \frac{n^{4 m-2}}{e^{(4 m-2) n}} \sum_{\substack{d \leq X \\
(d, 2)=1}}^{*}\left(\int_{e^{n-1}-1}^{e^{n}-1}\left|L\left(\frac{1}{2}+i t, \chi^{(8 d)}\right)\right| \mathrm{d} t\right)^{4 m-2} \\
& \ll Y^{2 m-1} X(\log X)^{O(1)}\left(\sum_{n \leq \log Y+2} \frac{n^{4 m-2}}{e^{(4 m-2) n}} e^{n}+\sum_{n \leq \log Y+2} n^{4 m-2}\right) \\
& \ll Y^{2 m-1} X(\log X)^{O(1)} .
\end{aligned}
$$

From (6.5)-(6.8), we infer

$$
\begin{equation*}
\sum_{\substack{d \leq X \\(d, 2)=1}}^{*}\left|\sum_{n \leq Y} \chi^{(8 d)}(n)\right|^{4 m-2} \ll Y^{2 m-1} X(\log X)^{O(1)} \tag{6.9}
\end{equation*}
$$

Finally, from (6.1), (6.2) (6.4), (6.9) and $U=X^{2 \varepsilon}, Y \leq X$, (4.11) is valid. This completes the proof of the lemma.
