# INTEGRAL REPRESENTATION FOR RIEMANN-SIEGEL $Z(t)$ FUNCTION. 

J. ARIAS DE REYNA

Abstract. We apply Poisson formula for a strip to give a representation of $Z(t)$ by means of an integral.

$$
F(t)=\int_{-\infty}^{\infty} \frac{h(x) \zeta(4+i x)}{7 \cosh \pi \frac{x-t}{7}} d x, \quad Z(t)=\frac{\operatorname{Re} F(t)}{\left(\frac{1}{4}+t^{2}\right)^{\frac{1}{2}}\left(\frac{25}{4}+t^{2}\right)^{\frac{1}{2}}}
$$

After that we get the estimate

$$
Z(t)=\left(\frac{t}{2 \pi}\right)^{\frac{7}{4}} \operatorname{Re}\left\{e^{i \vartheta(t)} H(t)\right\}+O\left(t^{-3 / 4}\right),
$$

with

$$
H(t)=\int_{-\infty}^{\infty}\left(\frac{t}{2 \pi}\right)^{i x / 2} \frac{\zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x=\left(\frac{t}{2 \pi}\right)^{-\frac{7}{4}} \sum_{n=1}^{\infty} \frac{1}{n^{\frac{1}{2}+i t}} \frac{2}{1+\left(\frac{t}{2 \pi n^{2}}\right)^{-7 / 2}}
$$

We explain how the study of this function can lead to information about the zeros of the zeta function on the critical line.

## 1. InTRODUCTION

Riemann stated that the number $N_{0}(T)$ of zeros of $\zeta(s)$ on the critical line with ordinates between 0 and $T$ is approximately equal to the total number of zeros $N(T)$ in the critical strip. In a letter to Weierstrass he said that this assertion follows from a new expansion of the function $\Xi(t)$ that he has not sufficiently simplified to communicate. Nobody knows what expansion Riemann is talking about. Siegel considered the possibility that it was his integral expansion studied in [10] but concluded that probably Riemann was wrong about the possibilities of this expansion. This work is an attempt to obtain a development following ideas available to Riemann.

It is somewhat surprising that the approximation obtained here is very similar to the one studied in our paper [2], obtained by an entirely different method.

## 2. Integral Representation for $Z(t)$.

In this section, we define a real analytic function $F: \mathbf{R} \rightarrow \mathbf{C}$ such that its real part is equal to $Z(t) \sqrt{\frac{1}{4}+t^{2}} \sqrt{\frac{25}{4}+t^{2}}$. For this we will apply the solution of the Dirichlet problem for a strip.

The solution of Dirichlet problem in a strip was considered in [4] we quote its solution from Rademacher [7, § 31].

Theorem 1. The solution $u(\sigma, t)$ of the Dirichlet problem on the strip $S(a, b)=\{s \in$ $\mathbf{C}: a \leq \sigma \leq b\}$ with boundary values $u(a, t)=A(t)$ and $u(b, t)=B(t)$, where $A(t)$ and
$B(t)=\boldsymbol{\mathcal { O }}\left(e^{k|t|}\right)$ with $0<k<\pi /(b-a)$ is given by
(1)

U(\sigma, t)=\frac{1}{2(b-a)} \int_{-\infty}^{+\infty} A(x) \omega\left(\frac{\sigma-a}{b-a}\right. & \left., \frac{x-t}{b-a}\right) d x \\
& +\frac{1}{2(b-a)} \int_{-\infty}^{+\infty} B(x) \omega\left(\frac{b-\sigma}{b-a}, \frac{x-t}{b-a}\right) d x
\end{aligned}
$$

where

$$
\begin{equation*}
\omega(\sigma, t)=\frac{\sin \pi \sigma}{\cosh \pi t-\cos \pi \sigma} \tag{2}
\end{equation*}
$$

Theorem 2. There is a holomorphic function $f$ in the strip $S(-3,5)$ such that for $\frac{1}{2}<$ $\sigma<5$ and $t \in \mathbf{R}$

\begin{equation*}
Z(t) \sqrt{\frac{1}{4}+t^{2}} \sqrt{\frac{25}{4}+t^{2}}=\operatorname{Re}\left\{\frac{1}{2 \sigma-1} \int_{-\infty}^{\infty} \frac{f(\sigma+i x)}{\cosh \pi \frac{x-t}{2 \sigma-1}} d x\right\} . \tag{3}
\end{equation*}
$$

Proof. Consider the function $\Phi(s)=(s+2) s(1-s)(3-s) \zeta(s) \zeta(1-s)$. It is clear that $\Phi(s)$ is an entire function that satisfies the functional equation $\Phi(s)=\Phi(1-s)$. The function $\Phi(s)$ have simple zeros at $-4,-6 \ldots$ and at $5,7 \ldots$ due to the trivial zeros of $\zeta(s)$. The zeros on the strip $S(-4,5)$ are all of even order, at $-2,3$ and at each nontrivial zero $\rho$ of $\zeta(s)$.
In the critical line, we have $\zeta\left(\frac{1}{2}+i t\right)=Z(t) e^{-i \vartheta(t)}$ where $Z(t)$ and $\vartheta(t)$ real functions that are real analytic, and such that

$$
\begin{equation*}
Z(t)=Z(-t), \quad \vartheta(-t)=-\vartheta(t) \tag{4}
\end{equation*}
$$

It follows that

$$
\begin{equation*}
\Phi\left(\frac{1}{2}+i t\right)=\left(\frac{1}{4}+t^{2}\right)\left(\frac{25}{4}+t^{2}\right) Z(t)^{2} . \tag{5}
\end{equation*}
$$

Since the strip $S(-3,5)$ is simply connected and the zeros of $\Phi(s)$ are of even order, there is an analytic function $f: S(-4,5) \rightarrow \mathbf{C}$ with $f(s)^{2}=\Phi(s)$. We fix the sign of $f(s)$ so that

$$
\begin{equation*}
f\left(\frac{1}{2}+i t\right)=Z(t) \sqrt{\frac{1}{4}+t^{2}} \sqrt{\frac{25}{4}+t^{2}}, \quad \text { for } t \in \mathbf{R} \tag{6}
\end{equation*}
$$

where we take $\sqrt{\frac{1}{4}+t^{2}}>0$ and $\sqrt{\frac{25}{4}+t^{2}}>0$. Notice that $Z(0)=\zeta(1 / 2)=-1.46<0$, so that $f\left(\frac{1}{2}\right)<0$.

We apply Theorem 1 to the harmonic function $f(s)=f(\sigma+i t)$ on the strip $S(1-\sigma, \sigma)$. The boundary values are $A(t)=f(1-\sigma+i t)$ and $B(t)=f(\sigma+i t)$. Since $f(s)$ is real on the real axis and on the critical line, we have $f(1-\sigma+i t)=\overline{f(\sigma+i t)}$. Therefore, we obtain

\begin{aligned}
f\left(\frac{1}{2}+i t\right) & =Z(t) \sqrt{\frac{1}{4}+t^{2}} \sqrt{\frac{25}{4}+t^{2}} \\
& =\frac{1}{2(2 \sigma-1)} \int_{-\infty}^{\infty} A(x) \omega\left(\frac{\sigma-\frac{1}{2}}{2 \sigma-1}, \frac{x-t}{2 \sigma-1}\right) d x+\frac{1}{2(2 \sigma-1)} \int_{-\infty}^{+\infty} B(x) \omega\left(\frac{\sigma-\frac{1}{2}}{2 \sigma-1}, \frac{x-t}{2 \sigma-1}\right) d x .
\end{aligned}
$$

The two integrals are complex conjugate numbers; therefore,

$$
Z(t) \sqrt{\frac{1}{4}+t^{2}} \sqrt{\frac{25}{4}+t^{2}}=2 \operatorname{Re} \frac{1}{2(2 \sigma-1)} \int_{-\infty}^{\infty} B(x) \omega\left(\frac{1}{2}, \frac{x-t}{2 \sigma-1}\right) d x .
$$

We have

$$
\omega\left(\frac{1}{2}, \frac{x-t}{2 \sigma-1}\right)=\frac{\sin \frac{\pi}{2}}{\cosh \pi \frac{x-t}{2 \sigma-1}-\cos \frac{\pi}{2}}=\frac{1}{\cosh \pi \frac{x-t}{2 \sigma-1}}
$$

and the result follows.
There are several interesting cases of (3), but we start by trying to obtain the consequences of case $\sigma=4$.

$$
Z(t) \sqrt{\frac{1}{4}+t^{2}} \sqrt{\frac{25}{4}+t^{2}}=\operatorname{Re}\left\{\frac{1}{7} \int_{-\infty}^{\infty} \frac{f(4+i x)}{\cosh \pi \frac{x-t}{7}} d x\right\}
$$

Therefore, we define for $t \in \mathbf{R}$

$$
\begin{equation*}
F(t)=\int_{-\infty}^{\infty} \frac{f(4+i x)}{7 \cosh \pi \frac{x-t}{7}} d x . \tag{7}
\end{equation*}
$$

It is easy to prove that $F(t)$ is analytic for $|\operatorname{Im}(t)|<\frac{7}{2}$.
2.1. The function $f(4+i x)$.

Proposition 3. The function $f(4+i x)=h(x) \zeta(4+i x)$ where $h(x)$ is the real analytic function defined by

$$
\begin{equation*}
h(x)=\frac{\sqrt{2}}{(2 \pi)^{2}}\left\{(6+i x)(4+i x)(3+i x)(1+i x)(2 \pi)^{-i x} \cosh \frac{\pi x}{2} \Gamma(4+i x)\right\}^{1 / 2}, \tag{8}
\end{equation*}
$$

that satisfies $h(0)=\frac{3}{\pi^{2}} \sqrt{6}>0$.
Proof. For $-2<\sigma<3$ the function $\Phi(\sigma)$ is continuous and does not vanish, so its sign coincides with the sign at $s=1 / 2$. Therefore $\Phi(\sigma)>0$ in this range. In the same range $f(\sigma)<0$ because we took $f\left(\frac{1}{2}\right)<0$ (take $t=0$ in (6)).
$f(s)$ is defined on the strip $S(-4,5)$ as the analytic square root of the function $\Phi(s)$ that is negative at $s=\frac{1}{2}$.

By the functional equation of $\zeta(s)$ we have

$$
\begin{aligned}
\Phi(s) & =(s+2) s(1-s)(3-s) \zeta(s) \zeta(1-s) \\
& =2(s+2) s(1-s)(3-s)(2 \pi)^{-s} \cos \frac{\pi s}{2} \Gamma(s) \zeta(s)^{2}
\end{aligned}
$$

Notice that the function $2(s+2) s(1-s)(3-s)(2 \pi)^{-s} \cos \frac{\pi s}{2} \Gamma(s)$ is analytic in $s=4+i x$ with $x \in \mathbf{R}$ and does not vanish so that there is a real analytic function $h: \mathbf{R} \rightarrow \mathbf{C}$ defined by (8). By a simple computation we obtain

$$
\frac{\Phi(4+i x)}{\zeta(4+i x)^{2}}=\frac{2}{(2 \pi)^{4}}(6+i x)(4+i x)(3+i x)(1+i x)(2 \pi)^{-i x} \cosh \frac{\pi x}{2} \Gamma(4+i x)
$$

From this we see that $h(0)= \pm \frac{3}{\pi^{2}} \sqrt{6}$. We may define $h(x)$ as the only continuous square root with $h(0)=\frac{3}{\pi^{2}} \sqrt{6}$.

With these elections we have $f(4+i x)= \pm h(x) \zeta(4+i x)$. We know that $f(x)<0$ for $-2<x<3$, and $f(4)>0$, because $f$ changes sign at $x=3$. Therefore, taking $h(0)>0$ we obtain the equality $f(4+i x)=h(x) \zeta(4+i x)$.

With the above definitions, we may write (7) as

$$
\begin{equation*}
F(t)=\int_{-\infty}^{\infty} \frac{h(x) \zeta(4+i x)}{7 \cosh \pi \frac{x-t}{7}} d x, \quad Z(t)=\frac{\operatorname{Re} F(t)}{\left(\frac{1}{4}+t^{2}\right)^{\frac{1}{2}}\left(\frac{25}{4}+t^{2}\right)^{\frac{1}{2}}} . \tag{9}
\end{equation*}
$$

Proposition 4. There are real analytic real functions $\rho: \mathbf{R} \rightarrow \mathbf{R}$ and $\alpha: \mathbf{R} \rightarrow \mathbf{R}$ such that for all $x \in \mathbf{R}$ we have $h(x)=\rho(x) e^{i \alpha(x)}$.

Proof. Since $h(x) \neq 0$, we may use the result in [1, Cor.2.3] (see also Proposition 24 in Section 4) to show that there are a real analytic function $\alpha(x)$ such that $h(x)=$ $|h(x)| e^{i \alpha(x)}$. The function $\rho(x):=|h(x)|$ is real analytic, because $h(x)$ does not vanish.

Since $\rho(0)>0$ and $h(0)>0$ we have $\alpha(0)=2 k \pi$. For definiteness, we take $\alpha(0)=$ 0.

Proposition 5. For $x \rightarrow+\infty$, we have the two asymptotic expansions

\begin{align*}
\log \rho(x) & \sim 2 \log x+\frac{7}{4} \log \frac{x}{2 \pi}-\sum_{n=1}^{\infty} \frac{(-1)^{n}\left(6^{2 n}+4^{2 n}+2 \cdot 3^{2 n}+2^{2 n}+2\right)}{4 n x^{2 n}},  \tag{10}\\
\alpha(x) & \sim \frac{x}{2} \log \frac{x}{2 \pi}-\frac{x}{2}+\frac{15 \pi}{8} \\
& -\sum_{n=0}^{\infty} \frac{(-1)^{n}\left(3 \cdot 6^{2 n}+2 \cdot 4^{2 n}+3 \cdot 3^{2 n}+2^{2 n}+1\right)}{(2 n+1) x^{2 n+1}}+\sum_{n=1}^{\infty} \frac{(-1)^{n} B_{2 n}}{4 n(2 n-1) x^{2 n-1}} . \tag{11}
\end{align*}
$$

Proof. Consider the function between parenthesis in (8)

$$
(6+i x)(4+i x)(3+i x)(1+i x)(2 \pi)^{-i x} \cosh \frac{\pi x}{2} \Gamma(4+i x)
$$

it is equal to

$$
(6+i x)(4+i x)(3+i x)^{2}(2+i x)(1+i x)^{2}(2 \pi)^{-i x} \cosh \frac{\pi x}{2} \Gamma(1+i x) .
$$

This function is equal to $2^{4} 3^{3}$ for $x=0$ and its factors are all positive at $x=0$, so we consider its logarithm as the sum of logarithms that are real at $x=0$.

$$
\begin{aligned}
\log (6+i x)+\log (4+i x)+2 \log (3+i x) & +\log (2+i x)+2 \log (1+i x) \\
& +\log \left(\cosh \frac{\pi x}{2}\right)-i x \log (2 \pi)+\log \Gamma(1+i x)
\end{aligned}
$$

Each term of the above sum has a well-known asymptotic expansion for $x \rightarrow+\infty$

$$
\begin{gathered}
\log (6+i x)=\log x+\frac{\pi i}{2}-\sum_{n=1}^{\infty} \frac{1}{n}\left(\frac{6 i}{x}\right)^{n}, \quad \log (4+i x)=\log x+\frac{\pi i}{2}-\sum_{n=1}^{\infty} \frac{1}{n}\left(\frac{4 i}{x}\right)^{n} \\
2 \log (3+i x)=2 \log x+\pi i-\sum_{n=1}^{\infty} \frac{2}{n}\left(\frac{3 i}{x}\right)^{n}, \quad \log (2+i x)=\log x+\frac{\pi i}{2}-\sum_{n=1}^{\infty} \frac{1}{n}\left(\frac{2 i}{x}\right)^{n}, \\
2 \log (1+i x)=2 \log x+\pi i-\sum_{n=1}^{\infty} \frac{2}{n}\left(\frac{i}{x}\right)^{n} \\
\log \left(\cosh \frac{\pi x}{2}\right)=-\log 2+\frac{\pi x}{2}+\log \left(1+e^{-\pi x}\right) \sim \frac{\pi x}{2}-\log 2, \\
-i x \log (2 \pi)+\log \Gamma(1+i x) \\
\sim-\frac{\pi x}{2}+\frac{1}{2} \log \frac{x}{2 \pi}+\log (2 \pi)+i x \log \frac{x}{2 \pi}-i x+\frac{\pi i}{4}+i \sum_{n=1}^{\infty} \frac{(-1)^{n} B_{2 n}}{2 n(2 n-1) x^{2 n-1}} .
\end{gathered}
$$

Then $\log h(x)$ is easily obtained from these values. From (8) we have to add $\frac{1}{2}$ of the above expansions and add the $\log$ of $\sqrt{2} /(2 \pi)^{2}$. According to our election $\alpha(0)=0$ we must take the logarithm of $\sqrt{2} /(2 \pi)^{2}$ equal to $\log \left(\sqrt{2} /(2 \pi)^{2}\right)$ the real logarithm. Therefore,

\begin{aligned}
\log h(x) & =\frac{1}{2} \log 2-2 \log (2 \pi) \\
& +\frac{7}{2} \log x+\frac{7 \pi i}{4}-\sum_{n=1}^{\infty} \frac{6^{n}+4^{n}+2 \cdot 3^{n}+2^{n}+2}{2 n}\left(\frac{i}{x}\right)^{n} \\
& +\frac{\pi x}{4}-\frac{1}{2} \log 2-\frac{\pi x}{4}+\frac{1}{4} \log \frac{x}{2 \pi}+\frac{1}{2} \log (2 \pi) \\
& +\frac{i x}{2} \log \frac{x}{2 \pi}-\frac{i x}{2}+\frac{\pi i}{8}+i \sum_{n=1}^{\infty} \frac{(-1)^{n} B_{2 n}}{4 n(2 n-1) x^{2 n-1}} .
\end{aligned}
$$

Separating the real and imaginary parts, we obtain the asymptotic expansion of $\log \rho(x)$ and $\alpha(x)$

$$
\begin{aligned}
\alpha(x) \sim & \frac{x}{2} \log \frac{x}{2 \pi}-\frac{x}{2}+\frac{15 \pi}{8} \\
& -\sum_{n=0}^{\infty} \frac{(-1)^{n}\left(3 \cdot 6^{2 n}+2 \cdot 4^{2 n}+3 \cdot 3^{2 n}+2^{2 n}+1\right)}{(2 n+1) x^{2 n+1}}+\sum_{n=1}^{\infty} \frac{(-1)^{n} B_{2 n}}{4 n(2 n-1) x^{2 n-1}} . \\
\log \rho(x) \sim- & \frac{3}{2} \log (2 \pi)+\frac{7}{2} \log x+\frac{1}{4} \log \frac{x}{2 \pi}-\sum_{n=1}^{\infty} \frac{(-1)^{n}\left(6^{2 n}+4^{2 n}+2 \cdot 3^{2 n}+2^{2 n}+2\right)}{4 n x^{2 n}} .
\end{aligned}
$$

or by summing the two convergent series we obtain

$$
\log \rho(x) \sim 2 \log x+\frac{7}{4} \log \frac{x}{2 \pi}+\frac{1}{4} \log \frac{\left(1+x^{2}\right)^{2}\left(4+x^{2}\right)\left(16+x^{2}\right)\left(9+x^{2}\right)^{2}\left(36+x^{2}\right)}{x^{14}}
$$

The difference between these two functions is exponentially small.

$$
\begin{aligned}
& \alpha(x) \sim \frac{x}{2} \log \frac{x}{2 \pi}-\frac{x}{2}+\frac{15 \pi}{8}-\arctan \frac{1}{x}-\frac{1}{2} \arctan \frac{2}{x}-\arctan \frac{3}{x} \\
&-\frac{1}{2} \arctan \frac{4}{x}-\frac{1}{2} \arctan \frac{6}{x}+\sum_{n=1}^{\infty} \frac{(-1)^{n} B_{2 n}}{4 n(2 n-1) x^{2 n-1}} .
\end{aligned}
$$

Lemma 6. The first terms of the expansion of $\log \rho(x)$ are given by

$$
\log \rho(x)=-\frac{7}{4} \log (2 \pi)+\frac{15}{4} \log x+\frac{19}{x^{2}}-\frac{433}{2 x^{4}}+\frac{13069}{3 x^{6}}-\frac{439633}{4 x^{8}}+\cdots
$$

Therefore, we obtain the next Lemma.
Lemma 7. We have

$$
\rho(x)=x^{2}\left(\frac{x}{2 \pi}\right)^{7 / 4}\left(1+\frac{19}{x^{2}}+\mathcal{O}\left(x^{-4}\right)\right), \quad x \rightarrow+\infty .
$$

Analogously, the first terms of the asymptotic expansion of $\alpha(x)$ by the above reasoning are equal to

$$
\alpha(x)=\frac{x}{2} \log \frac{x}{2 \pi}-\frac{x}{2}+\frac{15 \pi}{8}-\frac{241}{24 x}+\frac{41279}{720 x^{3}}-\frac{2348641}{2520 x^{5}}+\cdots
$$

Therefore,
Lemma 8. We have for $x \rightarrow+\infty$

$$
\alpha(x)=\frac{x}{2} \log \frac{x}{2 \pi}-\frac{x}{2}+\frac{15 \pi}{8}-\frac{241}{24 x}+\boldsymbol{\mathcal { O }}\left(x^{-3}\right) .
$$

## 3. First approximation to $Z(t)$.

Let us define

$$
\begin{gather*}
\theta(x)=\frac{x}{2} \log \frac{x}{2 \pi}-\frac{x}{2}+\frac{15 \pi}{8}-\frac{241}{24 x}, \quad x>0,  \tag{12}\\
\rho_{0}(x)=x^{2}\left(\frac{x}{2 \pi}\right)^{7 / 4}\left(1+\frac{19}{x^{2}}\right)=(2 \pi)^{-7 / 4} x^{7 / 4}\left(19+x^{2}\right), \quad x>0, \tag{13}
\end{gather*}
$$

and

$$
L_{1}(x, t)=1+\frac{15 x}{4 t}+\frac{i x^{2}}{4 t}+\frac{165 x^{2}}{32 t^{2}}+\frac{241 i x}{24 t^{2}}+\frac{41 i x^{3}}{48 t^{2}}-\frac{x^{4}}{32 t^{2}} .
$$

The object of this section is to prove the following theorem
Theorem 9. For $t \in \mathbf{R}$ let

$$
\begin{equation*}
G(t)=e^{i \theta(t)} \rho_{0}(t) \int_{-\infty}^{\infty} L_{1}(x, t)\left(\frac{t}{2 \pi}\right)^{i x / 2} \frac{\zeta(4+i t+i x)}{7 \cosh \frac{\pi x}{7}} d x . \tag{14}
\end{equation*}
$$

Then $G(t)$ is real analytic and for $t \rightarrow+\infty$ we have $F(t)=G(t)+\mathcal{O}\left(t^{3 / 4} \log ^{6} t\right)$, and consequently

$$
\begin{equation*}
Z(t)=\frac{\operatorname{Re}(G(t))}{\sqrt{\frac{1}{4}+t^{2}} \sqrt{\frac{25}{4}+t^{2}}}+\boldsymbol{\mathcal { O }}\left(t^{-5 / 4} \log ^{6} t\right) \tag{15}
\end{equation*}
$$

Proof. In the next Lemmas and Propositions we define the functions $F_{1}(t), F_{2}(t), F_{3}(t)$ and $F_{4}(t)$, such that $F_{4}(t)=G(t)$ and $F(t)=F_{1}(t)+\boldsymbol{\mathcal { O }}\left(t^{-1 / 4}\right), F_{1}(t)=F_{2}(t)+\boldsymbol{\mathcal { O }}\left(t^{3 / 4}\right)$, $F_{2}(t)=F_{3}(t)+\mathcal{O}\left(t^{3 / 4} \log ^{6} t\right)$ and $F_{3}(t)-F_{4}(t)=\mathcal{O}\left(t^{-1 / 4}\right)$. And the Theorem follows from this and (9).

Lemma 10 (Gabcke). The incomplete Gamma functions satisfies the inequality

\Gamma(a, x):=\int_{x}^{\infty} v^{a-1} e^{-v} d v \leq a e^{-x} x^{a-1}, \quad x>a \geq 1
$$

Proof. See [3, p.145, p. 84 in the electronic version].
Lemma 11. Let $\alpha=28 / \pi$ and

$$
F_{1}(t)=\int_{t-\alpha \log t}^{t+\alpha \log t} \frac{h(x) \zeta(4+i x)}{7 \cosh \frac{\pi}{7}(x-t)} d x .
$$

Then for $t \rightarrow+\infty$ we have $F(t)=F_{1}(t)+\boldsymbol{\mathcal { O }}\left(t^{-1 / 4}\right)$.

Proof. The difference $F(t)-F_{1}(t)$ is the sum of two integrals, we bound each one. Let $b>0$, we shall take at the end $b=\alpha \log t$. By Lemma $7 \rho(x) \leq C x^{15 / 4}$ for $x \geq x_{0}$. Also $|\zeta(4+i x)|$ is bounded for $x$ real. Therefore, we have for $t \rightarrow+\infty$

$$
\begin{aligned}
\left|\int_{t+b}^{\infty} \frac{h(x) \zeta(4+i x)}{7 \cosh \frac{\pi}{7}(x-t)} d x\right| & \ll \int_{t+b}^{\infty} \frac{x^{15 / 4}}{7 \cosh \frac{\pi}{7}(x-t)} d x \\
& =\int_{b / t}^{\infty} \frac{t^{15 / 4}(1+y)^{15 / 4}}{7 \cosh \pi y t / 7} t d y
\end{aligned}
$$

We divide the integral into two other (assuming $t>b$ )

$$
\begin{aligned}
& =t^{15 / 4} \int_{b / t}^{1} \frac{(1+y)^{15 / 4} t}{7 \cosh \pi y t / 7} d y+t^{15 / 4} \int_{1}^{\infty} \frac{(1+y)^{15 / 4} t}{7 \cosh \pi y t / 7} d y \\
& \leq 2^{15 / 4} t^{15 / 4} \int_{b / t}^{1} \frac{t}{\cosh \pi y t / 7} d y+2^{15 / 4} t^{15 / 4} \int_{1}^{\infty} \frac{y^{15 / 4} t}{\cosh \frac{\pi y t}{7}} d y \\
& \ll t^{15 / 4} \int_{b / t}^{\infty} t e^{-\frac{\pi y t}{7}} d y+t^{15 / 4} \int_{1}^{\infty} y^{15 / 4} t e^{-\frac{\pi y t}{7}} d y \\
& =\frac{7}{\pi} t^{15 / 4} e^{-\pi b / 7}+t^{15 / 4} \int_{\pi t / 7}^{\infty}\left(\frac{7 x}{\pi t}\right)^{15 / 4} t e^{-x} \frac{7}{\pi t} d x \\
& \ll t^{15 / 4} e^{-\pi b / 7}+\int_{\pi t / 7}^{\infty} x^{15 / 4} e^{-x} d x
\end{aligned}
$$

The last integral can be bounded by Gabcke's lemma. In the first one we take as $b=\alpha \log t$ and obtain

$$
\ll t^{15 / 4} t^{-4}+t^{15 / 4} e^{-\pi t / 7}=\boldsymbol{\mathcal { O }}\left(t^{-1 / 4}\right)
$$

Now we turn to the second integral, for some positive $a<t / 2$, (we will take at the end $a=\alpha \log t)$

$$
\begin{aligned}
& \left|\int_{-\infty}^{t-a} \frac{h(x) \zeta(4+i x)}{7 \cosh \frac{\pi}{7}(x-t)} d x\right| \\
& \quad \leq\left|\int_{t / 2}^{t-a} \frac{h(x) \zeta(4+i x)}{7 \cosh \frac{\pi}{7}(x-t)} d x\right|+\left|\int_{-\infty}^{t / 2} \frac{h(x) \zeta(4+i x)}{7 \cosh \frac{\pi}{7}(x-t)} d x\right|:=I_{1}+I_{2}
\end{aligned}
$$

For the second integral here, we notice that $h(x)$ is bounded for $|x|<1$ so that we have

$$
\begin{aligned}
I_{2}=\left|\int_{-\infty}^{t / 2} \cdots\right| \ll & \int_{-1}^{1} \frac{1}{\cosh \frac{\pi}{7}(x-t)} d x \\
& +\int_{1}^{t / 2} \frac{x^{15 / 4}}{\cosh \frac{\pi}{7}(x-t)} d x+\int_{-\infty}^{-1} \frac{|x|^{15 / 4}}{\cosh \frac{\pi}{7}(x-t)} d x:=J_{1}+J_{2}+J_{3} .
\end{aligned}
$$

It is easy to see that $J_{1} \ll e^{-\pi t / 7}$. For $J_{2}$ we can obtain a better bound, but it is sufficient to bound the integral by the maximum of the function by the length of the interval

$$
J_{2} \ll t^{15 / 4} e^{-\pi t / 14} \cdot t=\boldsymbol{\mathcal { O }}\left(t^{-1 / 4}\right)
$$

For $J_{3}$ we reduce it to an incomplete gamma integral

$$
J_{3}=\int_{1}^{\infty} \frac{x^{15 / 4}}{\cosh \frac{\pi}{7}(x+t)} d x \ll \int_{1}^{\infty} x^{15 / 4} e^{-\pi \frac{x+t}{7}} d x \ll e^{-\pi t / 7} .
$$

All is reduced to the bound of $I_{1}$

$$
\begin{aligned}
I_{1} & =\left|\int_{t / 2}^{t-a} \frac{h(x) \zeta(4+i x)}{7 \cosh \frac{\pi}{7}(x-t)} d x\right| \ll \int_{t / 2}^{t-a} \frac{x^{15 / 4}}{\cosh \frac{\pi}{7}(x-t)} d x \\
& \ll t^{15 / 4} \int_{t / 2}^{t-a} \frac{d x}{\cosh \frac{\pi}{7}(x-t)} \leq t^{15 / 4} \int_{-\infty}^{-a} \frac{d y}{\cosh \frac{\pi y}{7}} \\
& \leq 2 t^{15 / 4} \int_{-\infty}^{-a} e^{\frac{\pi y}{7}} d y \ll t^{15 / 4} e^{-\pi a / 7} .
\end{aligned}
$$

We see that this is $\mathcal{O}\left(t^{-1 / 4}\right)$ if we choose $a=\alpha \log t$ with $\alpha=28 / \pi$, as we wanted.
Lemma 12. For $t-\alpha \log t>0$ let us define

$$
F_{2}(t)=\int_{t-\alpha \log t}^{t+\alpha \log t} \frac{\rho_{0}(x) e^{i \theta(x)} \zeta(4+i x)}{7 \cosh \frac{\pi}{7}(x-t)} d x,
$$

where $\rho_{0}(x)$ and $\theta(x)$ are defined in (13) and (12). Then $F_{1}(t)=F_{2}(t)+\boldsymbol{O}\left(t^{3 / 4}\right)$.
Proof. By Lemma 7 and the definition of $\rho_{0}(x)$ we have for $x \rightarrow+\infty$

$$
\rho(x)=\rho_{0}(x)+\mathcal{O}\left(x^{-1 / 4}\right), \quad \rho_{0}(x)=\mathcal{O}\left(x^{15 / 4}\right) .
$$

By Lemma 8 and the definition of $\theta(x)$ we have

$$
\alpha(x)=\theta(x)+\boldsymbol{\mathcal { O }}\left(x^{-3}\right) .
$$

Then

$$
\begin{aligned}
h(x) & =\rho(x) e^{i \alpha(x)} \\
& =\left(\rho_{0}(x)+\boldsymbol{O}\left(x^{-1 / 4}\right)\right) e^{i \theta(x)+\boldsymbol{O}\left(x^{-3}\right)} \\
& =\rho_{0}(x) e^{i \theta(x)}\left(1+\boldsymbol{\mathcal { O }}\left(x^{-4}\right)\right)\left(1+\boldsymbol{\mathcal { O }}\left(x^{-3}\right)\right) \\
& =\rho_{0}(x) e^{i \theta(x)}\left(1+\boldsymbol{\mathcal { O }}\left(x^{-3}\right)\right) \\
& =\rho_{0}(x) e^{i \theta(x)}+\boldsymbol{\mathcal { O }}\left(x^{3 / 4}\right) .
\end{aligned}
$$

It follows that the difference $F_{1}(t)-F_{2}(t)$ is bounded by

$$
F_{1}(t)-F_{2}(t) \ll \int_{t-\alpha \log t}^{t+\alpha \log t} \frac{x^{3 / 4}}{7 \cosh \frac{\pi}{7}(x-t)} d x
$$

In the integration interval $x^{3 / 4} \ll t^{3 / 4}$ and we have

$$
F_{1}(t)-F_{2}(t) \ll t^{3 / 4} \int_{t-\alpha \log t}^{t+\alpha \log t} \frac{1}{7 \cosh \frac{\pi}{7}(x-t)} d x \ll t^{3 / 4}
$$

since the integral on $\mathbf{R}$ is bounded by a constant.
Lemma 13. For $t-\alpha \log t>0$, define

$$
F_{3}(t)=e^{i \theta(t)} \rho_{0}(t) \int_{-\alpha \log t}^{\alpha \log t} L_{1}(x, t)\left(\frac{t}{2 \pi}\right)^{i x / 2} \frac{\zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x
$$

where

$$
\begin{equation*}
L_{1}(x, t)=1+\frac{15 x}{4 t}+\frac{i x^{2}}{4 t}+\frac{165 x^{2}}{32 t^{2}}+\frac{241 i x}{24 t^{2}}+\frac{41 i x^{3}}{48 t^{2}}-\frac{x^{4}}{32 t^{2}} . \tag{16}
\end{equation*}
$$

Then we have $F_{2}(t)=F_{3}(t)+\mathcal{O}\left(t^{3 / 4} \log ^{6} t\right)$.
Proof. First, notice that

$$
F_{2}(t)=\int_{t-\alpha \log t}^{t+\alpha \log t} \frac{\rho_{0}(x) e^{i \theta(x)} \zeta(4+i x)}{7 \cosh \frac{\pi}{7}(x-t)} d x=\int_{-\alpha \log t}^{\alpha \log t} \frac{\rho_{0}(t+x) e^{i \theta(t+x)} \zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x
$$

Note also that $|x| \leq \alpha \log t$ when $x$ is in the integration interval. We apply Taylor's theorem to the two functions (see Rudin [9, p. 110]).

For $x$ in the integration interval there exists $\xi$ between $t$ and $x+t$, therefore $\xi \in$ $(t-\alpha \log t, t+\alpha \log t)$ with

$$
\begin{aligned}
\theta(t+x)= & \left(\frac{t}{2} \log \frac{t}{2 \pi}-\frac{t}{2}+\frac{15 \pi}{8}-\frac{241}{24 t}\right)+\left(\frac{1}{2} \log \frac{t}{2 \pi}+\frac{241}{24 t^{2}}\right) x+\left(\frac{1}{4 t}-\frac{241}{24 t^{3}}\right) x^{2} \\
& -\left(\frac{1}{12 t^{2}}-\frac{241}{24 t^{4}}\right) x^{3}+\left(\frac{1}{24 \xi^{3}}-\frac{241}{24 \xi^{5}}\right) x^{4} .
\end{aligned}
$$

So,

$$
\begin{equation*}
\theta(t+x)=\theta(t)+\left(\frac{1}{2} \log \frac{t}{2 \pi}+\frac{241}{24 t^{2}}\right) x+\frac{1}{4 t} x^{2}-\frac{1}{12 t^{2}} x^{3}+\boldsymbol{\mathcal { O }}\left(t^{-3} \log ^{4} t\right) \tag{17}
\end{equation*}
$$

Recall that

$$
\rho_{0}(x)=x^{2}\left(\frac{x}{2 \pi}\right)^{7 / 4}\left(1+\frac{19}{x^{2}}\right)=(2 \pi)^{-7 / 4} x^{7 / 4}\left(19+x^{2}\right)
$$

For $t>0$ large enough and $x \in(-\alpha \log t, \beta \log t)$, we have Taylor's expansion with $\xi \in(t-\alpha \log t, t+\alpha \log t)$

$$
\begin{aligned}
(2 \pi)^{7 / 4} \rho_{0}(t+x) & =t^{7 / 4}\left(19+t^{2}\right)+t^{7 / 4}\left(\frac{15 t}{4}+\frac{133}{4 t}\right) x \\
& +t^{7 / 4}\left(\frac{165}{32}+\frac{399}{32 t^{2}}\right) x^{2}+\xi^{7 / 4}\left(\frac{385}{128 \xi}-\frac{133}{128 \xi^{3}}\right) x^{3} .
\end{aligned}
$$

The last term is $\mathcal{O}\left(t^{3 / 4}(\log t)^{3}\right)$. Eliminating all terms of order less than or equal to this one, we obtain

$$
(2 \pi)^{7 / 4} \rho_{0}(t+x)=t^{7 / 4}\left(19+t^{2}\right)+\frac{15 t^{11 / 4}}{4} x+\frac{165 t^{7 / 4}}{32} x^{2}+\boldsymbol{O}\left(t^{3 / 4}(\log t)^{3}\right)
$$

So that $(2 \pi)^{7 / 4} \rho_{0}(t+x)$ is equal to

$$
\begin{equation*}
(2 \pi)^{7 / 4} \rho_{0}(t)\left(1+\frac{15 t}{4\left(19+t^{2}\right)} x+\frac{165}{32\left(19+t^{2}\right)} x^{2}+\boldsymbol{\mathcal { O }}\left(t^{-3}(\log t)^{3}\right)\right) \tag{18}
\end{equation*}
$$

By (17) and (18) we have

$$
\begin{equation*}
(2 \pi)^{7 / 4} \rho_{0}(t+x) e^{i \theta(t+x)}=(2 \pi)^{7 / 4} \rho_{0}(t) e^{i \theta(t)}\left(\frac{t}{2 \pi}\right)^{i x / 2} K(x, t), \tag{19}
\end{equation*}
$$

where

$$
\begin{aligned}
K(x, t)=\exp \left\{i \left(\frac{241 x}{24 t^{2}}+\frac{x^{2}}{4 t}-\right.\right. & \left.\left.\frac{x^{3}}{12 t^{2}}+\boldsymbol{\mathcal { O }}\left(t^{-3} \log ^{4} t\right)\right)\right\} \\
& \cdot\left(1+\frac{15 t}{4\left(19+t^{2}\right)} x+\frac{165}{32\left(19+t^{2}\right)} x^{2}+\boldsymbol{\mathcal { O }}\left(t^{-3}(\log t)^{3}\right)\right)
\end{aligned}
$$

The exponential factor is equal to

$$
\exp \left(\frac{241 i x}{24 t^{2}}+\frac{i x^{2}}{4 t}-\frac{i x^{3}}{12 t^{2}}\right)\left(1+\boldsymbol{\mathcal { O }}\left(t^{-3} \log ^{4} t\right)\right)
$$

Expanding the exponential and retaining only terms greater than $t^{-3}$ yields

$$
\begin{aligned}
\left(1+\frac{i x^{2}}{4 t}+\frac{241 i x}{24 t^{2}}-\frac{i x^{3}}{12 t^{2}}-\frac{x^{4}}{32 t^{2}}\right. & +\boldsymbol{\mathcal { O } ( t ^ { - 3 } ( \operatorname { l o g } t ) ^ { 6 } ) ) ( 1 + \boldsymbol { \mathcal { O } } ( t ^ { - 3 } \operatorname { l o g } ^ { 4 } t ) )} \\
& =1+\frac{i x^{2}}{4 t}+\frac{241 i x}{24 t^{2}}-\frac{i x^{3}}{12 t^{2}}-\frac{x^{4}}{32 t^{2}}+\boldsymbol{\mathcal { O }}\left(t^{-3}(\log t)^{6}\right)
\end{aligned}
$$

Expanding also the second factor in the expression for $K(x, t)$ and retaining only the terms greater than $t^{-3}$, yields

$$
1+\frac{15 x}{4 t}+\frac{165 x^{2}}{32 t^{2}}+\boldsymbol{\mathcal { O }}\left(t^{-3}(\log t)^{3}\right)
$$

Therefore,

$$
\begin{aligned}
K(x, t)= & \left(1+\frac{i x^{2}}{4 t}+\frac{241 i x}{24 t^{2}}-\frac{i x^{3}}{12 t^{2}}-\frac{x^{4}}{32 t^{2}}+\boldsymbol{\mathcal { O }}\left(t^{-3}(\log t)^{6}\right)\right) \\
& \cdot\left(1+\frac{15 x}{4 t}+\frac{165 x^{2}}{32 t^{2}}+\boldsymbol{\mathcal { O }}\left(t^{-3}(\log t)^{3}\right)\right) \\
= & 1+\frac{15 x}{4 t}+\frac{i x^{2}}{4 t}+\frac{165 x^{2}}{32 t^{2}}+\frac{241 i x}{24 t^{2}}+\frac{41 i x^{3}}{48 t^{2}}-\frac{x^{4}}{32 t^{2}}+\boldsymbol{\mathcal { O }}\left(t^{-3}(\log t)^{6}\right)
\end{aligned}
$$

That is $K(x, t)=L_{1}(x, t)+\mathcal{O}\left(t^{-3}(\log t)^{6}\right)$ and therefore (19) can be written as

$$
\rho_{0}(t+x) e^{i \theta(t+x)}=\rho_{0}(t) e^{i \theta(t)}\left(\frac{t}{2 \pi}\right)^{i x / 2}\left(L_{1}(x, t)+\boldsymbol{\mathcal { O }}\left(t^{-3}(\log t)^{6}\right)\right),
$$

It follows that the difference $F_{2}(t)-F_{3}(t)$ is bounded by

$$
F_{2}(t)-F_{3}(t) \ll t^{15 / 4} \cdot t^{-3}(\log t)^{6} \int_{-\alpha \log t}^{\alpha \log t} \frac{|\zeta(4+i t+i x)|}{7 \cosh (\pi x / 7)} d x=\boldsymbol{\mathcal { O }}\left(t^{3 / 4}(\log t)^{6}\right)
$$

since the integral is bounded by a constant.
To simplify $L_{1}(x, t)$ we need to consider again the complete integral.
Lemma 14. Let

$$
G(t)=F_{4}(t)=e^{i \theta(t)} \rho_{0}(t) \int_{-\infty}^{+\infty} L_{1}(x, t)\left(\frac{t}{2 \pi}\right)^{i x / 2} \frac{\zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x
$$

Then $F_{3}(t)-F_{4}(t)=\boldsymbol{\mathcal { O }}\left(t^{-5 / 4} \log t\right)$.
Proof. We need only to bound the integrals extended to the intervals $(-\infty,-\alpha \log t)$ and $(\alpha \log t,+\infty)$. Since $|\zeta(4+i x)| \leq \zeta(4)$ and $\rho_{0}(t) \ll t^{15 / 4}$ we have for the first integral $I_{1}:=e^{i \theta(t)} \rho_{0}(t) \int_{-\infty}^{-\alpha \log t} L_{1}(x, t)\left(\frac{t}{2 \pi}\right)^{i x / 2} \frac{\zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x \ll t^{15 / 4} \int_{-\infty}^{-\alpha \log t} \frac{\left|L_{1}(x, t)\right|}{\cosh (\pi x / 7)} d x$.
The definition (16) of $L_{1}(x, t)$ we have for $x$ in the integration interval and $t>0$ large

$$
\left|L_{1}(x, t)\right| \ll 1+\frac{x^{2}}{t}+\frac{x^{4}}{t^{2}}
$$

Therefore,

$$
I_{1} \ll t^{15 / 4} \int_{\alpha \log t}^{\infty} e^{-\pi x / 7} d x+t^{11 / 4} \int_{\alpha \log t}^{\infty} x^{2} e^{-\pi x / 7} d x+t^{7 / 4} \int_{\alpha \log t}^{\infty} x^{4} e^{-\pi x / 7} d x
$$

Applying Gabcke's Lemma 10

$$
I_{1} \ll t^{-5 / 4} \log t+t^{-9 / 4}(\log t)^{3}+t^{-13 / 4}(\log t)^{5} \ll t^{-5 / 4} \log t
$$

The second integral is

$$
I_{2}:=e^{i \theta(t)} \rho_{0}(t) \int_{\alpha \log t}^{\infty} L_{1}(x, t)\left(\frac{t}{2 \pi}\right)^{i x / 2} \frac{\zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x \ll t^{15 / 4} \int_{\alpha \log t}^{\infty} \frac{\left|L_{1}(x, t)\right|}{\cosh (\pi x / 7)} d x
$$

which is bounded in the same way as $I_{1}$.

## 4. Second approximation to $Z(t)$.

Proposition 15. For all nonnegative integers $n$, we have

$$
\begin{equation*}
\frac{d^{n}}{d y^{n}} \frac{1}{\cosh y}=(-1)^{n} \frac{2 e^{-y} B_{n}\left(-e^{-2 y}\right)}{\left(e^{-2 y}+1\right)^{n+1}} . \tag{20}
\end{equation*}
$$

where $B_{n}(x)$ are polynomials of degree $n$.
Proof. For $n=0$ we have

$$
\frac{1}{\cosh y}=\frac{2}{e^{y}+e^{-y}}=\frac{2 e^{-y}}{1+e^{-2 y}},
$$

so that $B_{0}(x)=1$. By induction, we easily show that $B_{n}(x)$ satisfies the recurrence

$$
B_{n}(x)=2 x(1-x) B_{n-1}^{\prime}(x)+(1+(2 n-1) x) B_{n-1}(x) .
$$

From this equation it can be shown that they are polynomials of degree $n$. We will only need to know $B_{0}, B_{1}$ and $B_{2}$. The first few are

$$
\begin{array}{ll}
B_{0}(x)=1, & B_{3}(x)=x^{3}+23 x^{2}+23 x+1, \\
B_{1}(x)=x+1, & B_{4}(x)=x^{4}+76 x^{3}+230 x^{2}+76 x+1, \\
B_{2}(x)=x^{2}+6 x+1, & B_{5}(x)=x^{5}+237 x^{4}+1682 x^{3}+1682 x^{2}+237 x+1 .
\end{array}
$$

The coefficient of these polynomials appears in Oeis A060187. These polynomials are known as type B Eulerian polynomials [6]. They have the following generating functions [5, eq. (13.3), (13.6)]

$$
\sum_{j \geq 0} x^{j}(2 j+1)^{n}=\frac{B_{n}(x)}{(1-x)^{n+1}}, \quad \sum_{n=0}^{\infty} B_{n}(x) \frac{t^{n}}{n!}=\frac{(1-x) e^{(1-x) t}}{1-x e^{2(1-x) t}}
$$

We will use the following integral
Proposition 16. For $n$ a nonnegative integer, $\alpha$ and $t$ real numbers we have

$$
\begin{equation*}
\int_{-\infty}^{\infty} \frac{e^{i \alpha x} x^{n}}{7 \cosh \frac{\pi x}{7}} d x=\frac{2 e^{-y} B_{n}\left(-e^{-2 y}\right)}{\left(1+e^{-2 y}\right)^{n+1}}\left(\frac{7 i}{2}\right)^{n}, \quad \text { with } y=\frac{7 \alpha}{2} . \tag{21}
\end{equation*}
$$

Proof. It is known ([11, p. 81]) that for $y \in \mathbf{R}$

$$
\int_{-\infty}^{\infty} \frac{e^{2 \pi i y x}}{\cosh \pi x} d x=\frac{1}{\cosh \pi y}, \quad \text { so that } \quad \int_{-\infty}^{\infty} \frac{e^{2 i y x}}{\cosh \pi x} d x=\frac{1}{\cosh y}
$$

Differentiating, we get

$$
(2 i)^{n} \int_{-\infty}^{\infty} \frac{x^{n} e^{2 i y x}}{\cosh \pi x} d x=\frac{d^{n}}{d y^{n}} \frac{1}{\cosh y}=(-1)^{n} \frac{2 e^{-y} B_{n}\left(-e^{-2 y}\right)}{\left(e^{-2 y}+1\right)^{n+1}} .
$$

Therefore, our integral can be calculated, first changing variables $x \mapsto 7 x$ and then taking $y=\frac{7 \alpha}{2}$

$$
\int_{-\infty}^{\infty} \frac{e^{i \alpha x} x^{n}}{7 \cosh \frac{\pi x}{7}} d x=7^{n} \int_{-\infty}^{\infty} \frac{e^{i 7 \alpha x} x^{n}}{\cosh \pi x} d x=\left(-\frac{7}{2 i}\right)^{n} \frac{2 e^{-y} B_{n}\left(-e^{-2 y}\right)}{\left(e^{-2 y}+1\right)^{n+1}}
$$

We now define the auxiliary functions $H_{r}(t)$.
Definition 17. For $t$ real and $r$ a nonnegative integer we define

$$
H_{r}(t)=\int_{-\infty}^{\infty} e^{i \beta x} \frac{x^{r} \zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x, \quad \beta=\frac{1}{2} \log \frac{t}{2 \pi},
$$

Then the definition of $F_{4}(t)=G(t)$ implies that

$$
\begin{align*}
& G(t)=e^{i \theta(t)} \rho_{0}(t) .  \tag{22}\\
& \quad \cdot\left(H_{0}(t)+\frac{15 H_{1}(t)}{4 t}+\frac{i H_{2}(t)}{4 t}+\frac{165 H_{2}(t)}{32 t^{2}}+\frac{241 i H_{1}(t)}{24 t^{2}}+\frac{41 i H_{3}(t)}{48 t^{2}}-\frac{H_{4}(t)}{32 t^{2}}\right) .
\end{align*}
$$

Proposition 18. When $t \rightarrow+\infty$ and a fixed nonnegative integer $r$ we have $H_{r}(t)=$ $\mathcal{O}\left(t^{-3 / 2}\right)$.

Proof. Since the Dirichlet series for $\zeta(4+i t)$ converges uniformly in $\mathbf{R}$, we may interchange sum and integral, so that applying Proposition 16 we obtain

$$
H_{r}(t)=\sum_{n=1}^{\infty} \frac{1}{n^{4+i t}} \int_{-\infty}^{\infty} e^{i(\beta-\log n) x} \frac{x^{r}}{7 \cosh \frac{\pi x}{7}} d x=\left(\frac{7 i}{2}\right)^{r} \sum_{n=1}^{\infty} \frac{1}{n^{4+i t}} \frac{2 e^{-y_{n}} B_{r}\left(-e^{-2 y_{n}}\right)}{\left(1+e^{-2 y_{n}}\right)^{r+1}},
$$

where

$$
y_{n}=\frac{7}{2}(\beta-\log n)=\frac{7}{4} \log \frac{t}{2 \pi n^{2}}, \quad e^{-y_{n}}=\left(\frac{2 \pi n^{2}}{t}\right)^{7 / 4} .
$$

Since $B_{r}(x)$ is a polynomial of degree $r$. There is a constant $C_{r}$ such that

$$
B_{r}(-x) \leq C_{r}(1+x)^{r}, \quad x \geq 0
$$

Then

$$
\begin{aligned}
\left|H_{r}(t)\right| & =\left|\left(\frac{7}{2 i}\right)^{r} \sum_{n=1}^{\infty} \frac{1}{n^{4+i t}} \frac{2 e^{-y_{n}} B_{r}\left(-e^{-2 y_{n}}\right)}{\left(1+e^{-2 y_{n}}\right)^{r+1}}\right| \leq C_{r}\left(\frac{7}{2}\right)^{r} \sum_{n=1}^{\infty} \frac{1}{n^{4}} \frac{2 e^{-y_{n}}}{\left(1+e^{-2 y_{n}}\right)} \\
& \leq C_{r}\left(\frac{7}{2}\right)^{r} \sum_{n=1}^{\infty} \frac{1}{n^{4}} \frac{2}{\left(\frac{2 \pi n^{2}}{t}\right)^{7 / 4}+\left(\frac{2 \pi n^{2}}{t}\right)^{-7 / 4}} \\
& =C_{r}\left(\frac{7}{2}\right)^{r} \sum_{n=1}^{\infty} \frac{2}{\left(\frac{2 \pi}{t}\right)^{7 / 4} n^{15 / 2}+\left(\frac{2 \pi}{t}\right)^{-7 / 4} n^{1 / 2}} \\
& \leq C_{r}\left(\frac{7}{2}\right)^{r} \int_{0}^{\infty} \frac{2 d x}{\left(\frac{2 \pi}{t}\right)^{7 / 4} x^{15 / 2}+\left(\frac{2 \pi}{t}\right)^{-7 / 4} x^{1 / 2}} .
\end{aligned}
$$

Change variables $x=\left(\frac{t}{2 \pi}\right)^{1 / 2} y$ and we obtain

$$
\left|H_{r}(t)\right| \leq C_{r}\left(\frac{7}{2}\right)^{r}\left(\frac{2 \pi}{t}\right)^{3 / 2} \int_{0}^{\infty} \frac{2 d x}{y^{15 / 2}+y^{1 / 2}} \ll t^{-3 / 2}
$$

Theorem 19. For $t>0$ let

$$
\begin{equation*}
H(t)=H_{0}(t)=\int_{-\infty}^{\infty}\left(\frac{t}{2 \pi}\right)^{i x / 2} \frac{\zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x \tag{23}
\end{equation*}
$$

Then we have

$$
\begin{equation*}
Z(t)=\left(\frac{t}{2 \pi}\right)^{\frac{7}{4}} \operatorname{Re}\left\{e^{i \theta(t)} H(t)\right\}+\boldsymbol{O}\left(t^{-3 / 4}\right) \tag{24}
\end{equation*}
$$

Proof. By (22) we may write (15), as

$$
Z(t)=\frac{\operatorname{Re}\left\{e^{i \theta(t)} \rho_{0}(t) H_{0}(t)\right\}}{\left(\left(\frac{1}{4}+t^{2}\right)\left(\frac{25}{4}+t^{2}\right)\right)^{1 / 2}}+\sum_{j=1}^{6} T_{j}+\boldsymbol{O}\left(t^{-5 / 4} \log ^{6} t\right),
$$

where each $T_{j}$ is the real part of is of the form

$$
T_{j}=C_{j} e^{i \theta(t)} \rho_{0}(t)\left(\left(\frac{1}{4}+t^{2}\right)\left(\frac{25}{4}+t^{2}\right)\right)^{-1 / 2} H_{r}(t) t^{-k}
$$

where $C_{j}$ is a constant for each $j, r \in\{1,2,3\}$ and $k \in\{1,2\}$. Hence by Proposition 18

$$
\left|T_{j}\right| \ll t^{2+\frac{7}{4}} t^{-2} t^{-3 / 2} t^{-k}=t^{\frac{1}{4}-k} \ll t^{-3 / 4}
$$

Since

$$
\begin{aligned}
\frac{\rho_{0}(t)}{\left(\left(\frac{1}{4}+t^{2}\right)\left(\frac{25}{4}+t^{2}\right)\right)^{1 / 2}} & =(2 \pi)^{-7 / 4} t^{2+\frac{7}{4}}\left(1+\frac{19}{t^{2}}+\boldsymbol{\mathcal { O }}\left(t^{-4}\right)\right)\left(\frac{1}{t^{2}}-\frac{13}{4 t^{4}}+\boldsymbol{\mathcal { O }}\left(t^{-6}\right)\right) \\
& =\left(\frac{t}{2 \pi}\right)^{\frac{7}{4}}+\boldsymbol{O}\left(t^{-\frac{1}{4}}\right)
\end{aligned}
$$

we have,

$$
Z(t)=\left(\frac{t}{2 \pi}\right)^{\frac{7}{4}} \operatorname{Re}\left\{e^{i \theta(t)} H(t)\right\}+\boldsymbol{\mathcal { O }}\left(t^{-\frac{1}{4}} H_{0}(t)\right)+\boldsymbol{\mathcal { O }}\left(t^{-3 / 4}\right)
$$

Since $\boldsymbol{\mathcal { O }}\left(t^{-\frac{1}{4}} H_{0}(t)\right)=\boldsymbol{\mathcal { O }}\left(t^{-7 / 4}\right)$ the result follows.
To give an idea of the value of this approximation, I give a table of values.

| $t$ | $Z(t)$ | $\operatorname{Re}\left\{(t / 2 \pi)^{7 / 4} e^{i \theta(t)} H(t)\right\}$ | $t$ | $Z(t)$ | $\operatorname{Re}\left\{(t / 2 \pi)^{7 / 4} e^{i \theta(t)} H(t)\right\}$ |
| :--- | ---: | :--- | :--- | :--- | :--- |
| 10 | -1.5491945 | -0.9983260 | $10^{5}$ | 5.8795925 | 5.8790158 |
| $10^{2}$ | 2.6926971 | 2.6269297 | $10^{6}$ | -2.8061339 | -2.8061012 |
| $10^{3}$ | 0.9977946 | 0.9849027 | $10^{7}$ | 14.3525504 | 14.3525613 |
| $10^{4}$ | -0.3413947 | -0.3452059 | $10^{8}$ | 3.6454079 | 3.6454066 |

Proposition 20. For $t>0$ we have

$$
H(t)=\sum_{n=1}^{\infty} \frac{1}{n^{4+i t}} \frac{2}{\left(\frac{t}{2 \pi n^{2}}\right)^{7 / 4}+\left(\frac{t}{2 \pi n^{2}}\right)^{-7 / 4}} .
$$

Proof. In the integral (23) defining $H(t)$ we expand $\zeta(4+i t+i x)$ in series and integrate term by term. Then we apply (21).

$$
\begin{aligned}
H(t) & =\int_{-\infty}^{\infty}\left(\frac{t}{2 \pi}\right)^{i x / 2} \frac{\zeta(4+i t+i x)}{7 \cosh (\pi x / 7)} d x=\sum_{n=1}^{\infty} \frac{1}{n^{4+i t}} \int_{-\infty}^{\infty}\left(\frac{t}{2 \pi n^{2}}\right)^{i x / 2} \frac{1}{7 \cosh (\pi x / 7)} d x \\
& =\sum_{n=1}^{\infty} \frac{1}{n^{4+i t}} \frac{t}{\left(\frac{t}{2 \pi n^{2}}\right)^{7 / 4}+\left(\frac{t}{2 \pi n^{2}}\right)^{-7 / 4}} .
\end{aligned}
$$

Remark 21. The above expression can be written as

$$
H(t)=\left(\frac{t}{2 \pi}\right)^{-7 / 4} \sum_{n=1}^{\infty} \frac{1}{n^{\frac{1}{2}+i t}} \frac{2}{1+\left(\frac{t}{2 \pi n^{2}}\right)^{-7 / 2}}
$$

Remark 22. It appears that the phase of $H(t)$ decreases moderately with increasing $t$. For example, in the figure, we see that $\arg H(t)$ for $t \in(10000,10020)$ start in the fourth quadrant and purely imaginary (or almost there), pass to the third quadrant, first quadrant and then


Figure 1. x-ray of $H(z)$ for $z \in(10000,10020) \times(-2,4)$
move between 1st and 4th quadrant (with two slight changes into 2nd and 3rd) ending in the fourth quadrant. Therefore, we pass from $-\pi / 2$ to some point in the interval $(-2 \pi,-2 \pi-\pi / 2)$. So the variation of the argument is at most $-2 \pi$. In this rectangle there is only one zero of $H(z)$ with $\operatorname{Im} z<0$.

Remark 23. The computation of the continuous argument of $H(t)$ for $0<t<15000$ is consistent with

$$
0 \leq-\arg H(t) \approx c\left(\frac{t}{2} \log \frac{t}{2 \pi}-\frac{t}{2}\right), \quad c=\frac{17}{63} \approx 0.27
$$

If this continues to be true for larger values of $t$, it will imply $73 \%$ of zeros of zeta on the critical line.

Appendix. Counting zeros by means of the phase.
We show here how finding real analytic functions $F(t)$ such that $Z(t)=\operatorname{Re} F(t)$ is relevant to counting zeros on the critical line.

Let $f:[a, b] \rightarrow \mathbf{C}$. We say that it is real analytic if $f$ has an analytic extension to a neighborhood of $[a, b]$ in C. Notice that $f$ real analytic implies that $g(t)=\overline{f(t)}=\overline{f(\bar{t})}$ is real analytic also, so that

$$
\operatorname{Re} f(t)=\frac{f(t)+g(t)}{2}, \quad \operatorname{Im} f(t)=\frac{f(t)-g(t)}{2 i}
$$

are also real analytic functions in $[a, b]$.
First we extend a Proposition from [1, p. 218]
Proposition 24. If $f:[a, b] \rightarrow \mathbf{C}$ is real analytic not identically 0 , then there are two real analytic functions $U:[a, b] \rightarrow \mathbf{R}$ and $\varphi:[a, b] \rightarrow \mathbf{R}$ such that

$$
f(t)=U(t) e^{i \varphi(t)}
$$

Given two such representations $f=U_{1} e^{i \varphi_{1}}$ and $f=U_{2} e^{i \varphi_{2}}$, we have either $U_{1}=U_{2}$ and $\varphi_{1}-\varphi_{2}=2 k \pi$ or $U_{1}=-U_{2}$ and $\varphi_{1}-\varphi_{2}=(2 k+1) \pi$ for some integer $k$.

Proof. If $f(t) \neq 0$ there is a simply connected neighborhood $\Omega$ of $[a, b]$ where $f$ extends as an analytic function that is never 0 in $\Omega$. Then we may define an analytic function $g: \Omega \rightarrow \mathbf{C}$ such that $e^{g(t)}=f(t)$ Then we may take $U(t)=e^{\operatorname{Reg} g(t)}$ and $\alpha(t)=\operatorname{Im} g(t)$.

If $f$ have zeros in $[a, b]$, they are a finite number (counting multiplicities). Let $\alpha_{j}$, with $1 \leq j \leq n$ these zeros. Let $F(t)=f(t) \prod_{j=1}^{n}\left(t-\alpha_{j}\right)^{-1}$. Then $F$ is real analytic and does not vanish, so it can be written as $F(t)=V(t) e^{i \alpha(t)}$. Putting $U(t)=V(t) \prod_{j}\left(t-\alpha_{j}\right)$ we obtain our desired representation.

Given two representations $f=U_{1} e^{i \varphi_{1}}=U_{2} e^{i \varphi_{2}}, U_{2}$ is not identically 0 , so we will have $U_{1} / U_{2}=e^{i\left(\varphi_{2}-\varphi_{1}\right)}$. Therefore $U_{1} / U_{2}$ is real analytic, take only real values, and have modulus $=1$. So $U_{1} / U_{2}=1$ or it is equal to -1 . Then the phases have to take the given values.

Given such a representation $f=U e^{i \varphi}$ we say that $\varphi$ is a phase of $f$. When $f(t)$ do not vanish in $[a, b]$ we can take $U(t)=|f(t)|$ and then for any $a \leq t \leq b$, the value of $\varphi(t)$ coincides with some argument of $f(t)$.

Given a real analytic function $f:[a, b] \rightarrow \mathbf{C}$, not identically 0 , we define $N_{f}[a, b]$ as the number of zeros of $f$ in the closed segment $[a, b]$ counting multiplicities.

Proposition 25. Let $f:[a, b] \rightarrow \mathbf{R}$ and $g:[a, b] \rightarrow \mathbf{C}$ be real analytic functions with $f(t)=\operatorname{Re} g(t)$ not identically 0 . Let $\varphi(t)$ a phase of $g(t)$. Then

$$
\frac{|\varphi(b)-\varphi(a)|}{\pi}<N_{f}(a, b)+1 .
$$

Proof. Substituting $g$ by $\bar{g}$ that is also real analytic and has the same real part, we may assume that $\varphi(a) \leq \varphi(b)$.

We have something to prove only in the case $\varphi(b)-\varphi(a)>\pi$. Consider the odd integer multiples of $\pi / 2$ contained between $\varphi(a)$ and $\varphi(b)$. Since $\varphi(b)-\varphi(a)>\pi$ there is at least one. Therefore, there exist $n \leq m$ integers such that

$$
(2 n-1) \frac{\pi}{2}<\varphi(a) \leq(2 n+1) \frac{\pi}{2}<(2 n+3) \frac{\pi}{2}<\cdots<(2 m+1) \frac{\pi}{2} \leq \varphi(b)<(2 m+3) \frac{\pi}{2}
$$

Since $\varphi(t)$ is continuous, it takes all values in the interval $[\varphi(a), \varphi(b)]$. Therefore, there are points $t_{k} \in[a, b]$ with $\varphi\left(t_{k}\right)=(2 k+1) \frac{\pi}{2}$ for $n \leq k \leq m$. At these points, we have
$f\left(t_{k}\right)=\operatorname{Re} g\left(t_{k}\right)=0$. That is $N_{f}(a, b) \geq m-n+1$. The interval $((2 n-1) \pi / 2,(2 m+$ $3) \pi / 2) \supset[\varphi(a), \varphi(b)]$, comparing its lengths, yields

$$
\pi(m-n)+2 \pi>\varphi(b)-\varphi(a)
$$

The result follows.
Proposition 26. Let $f$ and $g:[a, b] \rightarrow \mathbf{C}$ real analytic functions such that

$$
\begin{equation*}
|f(t)-g(t)|<|f(t)|, \quad \text { for all } a \leq t \leq b \tag{25}
\end{equation*}
$$

Then $f$ and $g$ do not vanish on $[a, b]$, so that we can write $f(t)=|f(t)| e^{i \alpha(t)}$ and $g(t)=$ $|g(t)| e^{i \beta(t)}$ with $\alpha$ and $\beta$ real analytic. Then we can choose $\beta(t)$ so that

$$
|\alpha(t)-\beta(t)|<\pi, \quad a \leq t \leq b
$$

In particular

$$
\left|\frac{\alpha(b)-\alpha(a)}{\pi}-\frac{\beta(b)-\beta(a)}{\pi}\right|<2
$$

Proof. If $f(t)=0$, equation (25) implies $|g(t)|<0$ which is a contradiction. If $g(t)=0$, then we arrive at the contradiction $|f(t)|<|f(t)|$. Since the functions do not vanish, we may apply Proposition 25 to get $f(t)=|f(t)| e^{i \alpha(t)}$ and $g(t)=|g(t)| e^{i \beta(t)}$. The function $\beta(t)$ is not unique, in fact $\beta(t)+2 k \pi$ for any integer $k$ can be used instead of $\beta(t)$.

We have $|f(0)-g(0)|<|f(0)|$. Therefore $g(0)$ is in the open disc with center $f(0)$ and radius the distance from $f(0)$ to $0 . \alpha(0)$ is one of the determination of $\arg f(0)$, there is a value of $\arg g(0)$ such that $|\alpha(0)-\arg g(0)|<\pi$, since the two points are in some half plane. We may choose a $k$ so that $|\beta(0)+2 k \pi-\alpha(0)|<\pi$, without loss of generality we may assume that $|\beta(0)-\alpha(0)|<\pi$. Since these functions are continuous, this will be true for some interval $|\beta(t)-\alpha(t)|<\pi$ if $a \leq t<a+\varepsilon$.

By contradiction we shall prove that $|\beta(t)-\alpha(t)|<\pi$ for all $t \in[a, b]$. Assume that there is some $|\beta(t)-\alpha(t)| \geq \pi$. The set of points that satisfies this inequality is a closed set of $[a, b]$ contained in $[a+\varepsilon, b]$. Let $t_{0}$ be the infimum of these closed sets. By continuity we will have $\left|\beta\left(t_{0}\right)-\alpha\left(t_{0}\right)\right|=\pi$. Therefore $f\left(t_{0}\right)=\left|f\left(t_{0}\right)\right| e^{i \alpha\left(t_{0}\right)}$ and

$$
g\left(t_{0}\right)=\left|g\left(t_{0}\right)\right| e^{i \beta\left(t_{0}\right)}=\left|g\left(t_{0}\right)\right| e^{i \alpha\left(t_{0}\right) \pm \pi i}=-\left|g\left(t_{0}\right)\right| e^{i \alpha\left(t_{0}\right)}
$$

And we have a contradiction with (25) because

$$
\left|f\left(t_{0}\right)\right|>\left|f\left(t_{0}\right)-g\left(t_{0}\right)\right|=\left|\left|f\left(t_{0}\right)\right| e^{i \alpha\left(t_{0}\right)}+\left|g\left(t_{0}\right)\right| e^{i \alpha\left(t_{0}\right)}\right|=\left|f\left(t_{0}\right)\right|+\left|g\left(t_{0}\right)\right|
$$

The rest is an easy consequence of this.
