# Existence and regularity results for a Neumann problem with mixed local and nonlocal diffusion

#### Abstract

In this paper, we consider an elliptic problem driven by a mixed local-nonlocal operator with drift and subject to nonlocal Neumann condition. We prove the existence and uniqueness of a solution $u \in W^{2, p}(\Omega)$ of the considered problem with $L^{p}$-source function when $p$ and $s$ are in a certain range.

## 1 Introduction and main results

In this paper, we are interested in the study of the following problem

$$

L u:=-\Delta u(x)+(-\Delta)^{s} u(x)-q(x) \cdot \nabla u(x)+a(x) u=f(x) & & \text { in } & \quad \Omega  \tag{1.1}\\
\frac{\partial u}{\partial \nu} & =0 & & \text { on }
\end{array} \quad \partial \Omega,\right.
$$

with a mixed diffusion and a new type of Neumann boundary conditions. The new boundary condition is $\mathcal{N}_{s} u=0$ on $\mathbb{R}^{N} \backslash \bar{\Omega}$, where $\mathcal{N}_{s} u$ - known as the nonlocal normal derivative of $u$ is given by

\mathcal{N}_{s} u(x)=C_{N, s} \int_{\Omega} \frac{u(x)-u(y)}{|x-y|^{N+2 s}} d y \quad x \in \mathbb{R}^{N} \backslash \bar{\Omega} \tag{1.2}
\end{equation*}
$$

The diffusion term is a superposition of the classical Laplacian (local diffusion) and the fractional Laplacian $(-\Delta)^{s}$ for certain values of $s \in(0,1)$ that will be specified later. It is well known that the fractional Laplacian represents a nonlocal diffusion in the medium.

[^0]We recall that the operator $(-\Delta)^{s}$, with $s \in(0,1)$, stands for the fractional Laplacian and it is defined for compactly supported function $u: \mathbb{R}^{N} \rightarrow \mathbb{R}$ of class $\mathcal{C}^{2}$ by

(-\Delta)^{s} u(x)=C_{N, s} \lim _{\varepsilon \rightarrow 0^{+}} \int_{\mathbb{R}^{N} \backslash B_{\varepsilon}(x)} \frac{u(x)-u(y)}{|x-y|^{N+2 s}} d y \tag{1.3}
\end{equation*}
$$

with the same normalization constant $C_{N, s}$ as in (1.2) given by

$$
\begin{equation*}
C_{N, s}:=\pi^{-\frac{N}{2}} 2^{2 s} s \frac{\Gamma\left(\frac{N}{2}+s\right)}{\Gamma(1-s)} \tag{1.4}
\end{equation*}
$$

We refer the reader to the results of Silvestre [10] about the spaces that $(-\Delta)^{s} u$ belongs to according to the regularity of the function $u$.

The boundary conditions in (1.1) consist of the classical Neumann boundary condition $\frac{\partial u}{\partial \nu}=0$ on $\partial \Omega(\nu$ is the outward unit normal on $\partial \Omega)$ and the nonlocal boundary condition $\mathcal{N}_{s} u=0$ (see [8]) on $\mathbb{R}^{N} \backslash \Omega$. The classical Neumann condition states that there is no flux through the boundary of the domain. On the other hand, the nonlocal boundary condition $\mathcal{N}_{s} u=0$ states that if a particle is in $\mathbb{R}^{N} \backslash \bar{\Omega}$, it may come back to any point $y \in \Omega$ with the probability density of jumping from $x$ to $y$ being proportional to $|x-y|^{-N-2 s}$. A detailed description of (1.1) is given in [9. The condition $\mathcal{N}_{s} u=0$ is interpreted in 9 as a condition that arises from the superposition of Brownian and Lévy processes.

The PDE

$$
\begin{equation*}
-\Delta u(x)+(-\Delta)^{s} u-q(x) \cdot \nabla u(x)+a(x) u=f(x) \text { in } \Omega \tag{1.5}
\end{equation*}
$$

has been extensively studied when $q \equiv 0$ and the boundary condition is of Dirichlet type. Tat is, $u \equiv 0$ in $\mathbb{R}^{N} \backslash \Omega$. Existence and regularity of solutions for (1.5), as well as maximum principles are among the results obtained in [3], [4], [5], and [11], where the advection $q$ is absent and the boundary condition is of Dirichlet type. The authors of this paper studied (1.5) in the recent work [6], where an advection term is present and (1.5) is coupled with the Dirichlet condition $u \equiv 0$ on $\mathbb{R} \backslash \bar{\Omega}$.

The recent work [7] considers (1.5) with $q \equiv 0$ and $a \equiv 0$ to provide spectral properties of the mixed diffusion operator. The work [8] considers a purely nonlocal diffusion and provides existence results for the problem with nonlocal Neumann conditions. It is important to note that [8] does not consider a PDE with a mixed diffusion and it does not account for advection.

The domain and the coefficients. Throughout this paper, we assume that the domain $\Omega$ is an open bounded connected subset of $\mathbb{R}^{N}$ with smooth boundary $\partial \Omega$. The coefficients $q$ and $a$ are assumed to be smooth with $a \geq 0$ and not identically zero.

The normal derivative of $u$ on $\partial \Omega$. Our solutions will, in general, be $C^{1}(\bar{\Omega})$ but the extension ( $\widetilde{u}$ defined later) will not be sufficiently smooth. Hence to compute $\partial_{\nu} u(x)$ on $\partial \Omega$, we are using

$$
\partial_{\nu} u(x)=\lim _{t \rightarrow 0^{-}} \frac{u\left(x_{0}+t \nu\left(x_{0}\right)\right)-u\left(x_{0}\right)}{t}
$$

where $\nu(x)$ is the unit outward normal to $\partial \Omega$ at $x \in \partial \Omega$.
We prove the following results for problem (1.1).

Theorem 1.1. Let $\Omega$ be an open bounded set of $\mathbb{R}^{N}$ with smooth boundary and $f \in L^{p}(\Omega)$. Then,

1. if $\frac{N-1}{2 N}<s<\frac{1}{2}$ and $N<p<\frac{1}{1-2 s}$, problem (1.1) admits a unique solution $u \in W^{2, p}(\Omega)$.
2. if $p>N$ and $\frac{1}{2} \leq s<\frac{1}{2}+\frac{1}{2 p}$, problem (1.1) admits a unique solution $u \in W^{2, p}(\Omega)$.

## 2 Some functional spaces

Let $\Omega \subset \mathbb{R}^{N}$ be an open bounded set. For a vector field $q: \Omega \rightarrow \mathbb{R}^{N}$, we write $q \in L^{\infty}(\Omega)$ (resp. $q \in \mathcal{C}^{0, \alpha}(\bar{\Omega})$ ) whenever $q_{j} \in L^{\infty}(\Omega)$ (resp. $q_{j} \in \mathcal{C}^{0, \alpha}(\bar{\Omega})$ ), $j=1,2, \cdots, N$. We denote by $\mathcal{C}^{k, \alpha}(\bar{\Omega}), 0<\alpha \leq 1$, the Banach space of functions $u \in \mathcal{C}^{k}(\bar{\Omega})$ such that derivative of order $k$ belong to $\mathcal{C}^{0, \alpha}(\bar{\Omega})$ with the norm

\|u\|_{\mathcal{C}^{k, \alpha}(\bar{\Omega})}:=\|u\|_{\mathcal{C}^{k}(\bar{\Omega})}+\sum_{|\tau|=k}\left[D^{\tau} u\right]_{\mathcal{C}^{0, \alpha}(\bar{\Omega})},
$$

where the Hölder seminorm $[\cdot]_{\mathcal{C}^{0}, \alpha}(\bar{\Omega})$ is given by

$$
[u]_{\mathcal{C}^{0}, \alpha}(\bar{\Omega})=\sup _{x, y \in \bar{\Omega}, x \neq y} \frac{|u(x)-u(y)|}{|x-y|^{\alpha}}
$$

and $\mathcal{C}^{0, \alpha}(\bar{\Omega})$ is the Banach space of functions $u \in \mathcal{C}^{0}(\bar{\Omega})$ which are Hölder continuous with exponent $\alpha$ in $\Omega$ and the norm $\|u\|_{\mathcal{C}^{0, \alpha}(\bar{\Omega})}=\|u\|_{L^{\infty}(\Omega)}+[u]_{\mathcal{C}^{0, \alpha}(\bar{\Omega})}$. We refer the reader to the results of Silvestre [10] about the spaces that $(-\Delta)^{s} u$ belongs to according to the regularity of the function $u$.

If $k \in \mathbb{N}$, as usual we set

$$
W^{k, p}(\Omega):=\left\{u \in L^{p}(\Omega): D^{\alpha} u \text { exists for all } \alpha \in \mathbb{N}^{N},|\alpha| \leq k \text { and } D^{\alpha} u \in L^{p}(\Omega)\right\}
$$

for the Banach space of $k$-times (weakly) differentialable functions in $L^{p}(\Omega)$. Moreover, in the fractional setting, for $s \in(0,1)$ and $p \in[1, \infty)$, we set

$$
W^{s, p}(\Omega):=\left\{u \in L^{p}(\Omega): \frac{u(x)-u(y)}{|x-y|^{\frac{n}{p}+s}} \in L^{p}(\Omega \times \Omega)\right\} .
$$

The space $W^{s, p}(\Omega)$ is a Banach space with the norm

$$
\|u\|_{W^{s, p}(\Omega)}=\left(\|u\|_{L^{p}(\Omega)}^{p}+\iint_{\Omega \times \Omega} \frac{|u(x)-u(y)|^{p}}{|x-y|^{n+s p}} d x d y\right)^{\frac{1}{p}}
$$

Next, we set $\mathcal{Q}:=\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right) \backslash\left(\mathbb{R}^{N} \backslash \Omega\right)^{2}$ and define the space $\mathcal{X}^{s}(\Omega)$ by

$$
\mathcal{X}^{s}(\Omega):=\left\{u \in L^{2}(\Omega):\left.u\right|_{\Omega} \in W^{1,2}(\Omega) ;[u]_{\mathcal{X}^{s}(\Omega)}<\infty\right\} .
$$

Here, the corresponding Gagliardo seminorm [ []$_{s}$ is given by

$$
\left([u]_{s}\right)^{2}:=\int_{\Omega}|\nabla u|^{2} d x+\iint_{\mathcal{Q}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y
$$

We also define the space

$$
\mathcal{X}_{K}^{s}(\Omega):=\left\{u \in L^{2}(\Omega):\left.u\right|_{\Omega} \in W^{1,2}(\Omega) ;[u]_{s, K}<\infty\right\},
$$

where,

$$
\left([u]_{s, K}\right)^{2}:=\int_{\Omega}|\nabla u|^{2} d x+\int_{\Omega} \int_{\Omega}|u(x)-u(y)|^{2} K_{\Omega}(x, y) d x d y
$$

and $K_{\Omega}: \Omega \times \Omega \rightarrow \mathbb{R}$ is a measurable (regional) kernel given by

$$
\begin{equation*}
K_{\Omega}(x, y):=\frac{1}{|x-y|^{N+2 s}}+k_{\Omega}(x, y) \tag{2.1}
\end{equation*}
$$

with

$$
\begin{equation*}
k_{\Omega}(x, y):=\int_{\mathbb{R}^{N} \backslash \Omega} \frac{1}{|x-z|^{N+2 s}|y-z|^{N+2 s} \int_{\Omega} \frac{1}{\left|z-z^{\prime}\right|^{N+2 s}} d z^{\prime}} d z, \quad x, y \in \Omega . \tag{2.2}
\end{equation*}
$$

Note that the space $\mathcal{X}^{s}(\Omega)$ (resp. $\mathcal{X}_{K}^{s}(\Omega)$ ) is a Hilbert space when furnished with the scalar product $\langle u, v\rangle_{\mathcal{X}^{s}(\Omega)}\left(\right.$ resp. $\left.\langle u, v\rangle_{\mathcal{X}_{K}^{s}(\Omega)}\right)$

$$
\langle u, v\rangle_{\mathcal{X}^{s}(\Omega)}:=\int_{\Omega} u v d x+\int_{\Omega} \nabla u \cdot \nabla v d x+\iint_{\mathcal{Q}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y
$$

and the corresponding norm given $\|u\|_{\mathcal{X}^{s}(\Omega)}=\langle u, u\rangle_{\mathcal{X}^{s}(\Omega)}^{\frac{1}{2}}$ (resp. $\left.\|u\|_{\mathcal{X}^{s}(\Omega)}=\langle u, u\rangle_{\mathcal{X}_{K^{s}}(\Omega)}^{\frac{1}{2}}\right)$. Finally, we define the space $\mathcal{L}_{s}^{1}\left(\mathbb{R}^{N}\right)$ by

$$
\mathcal{L}_{s}^{1}\left(\mathbb{R}^{N}\right):=\left\{u: \mathbb{R}^{N} \rightarrow \mathbb{R}, \text { such that } u \text { is measurable and }\|u\|_{\mathcal{L}_{s}^{1}\left(\mathbb{R}^{N}\right)}<\infty\right\}
$$

where

$$
\|u\|_{\mathcal{L}_{1}^{s}\left(\mathbb{R}^{N}\right)}:=\int_{\mathbb{R}^{N}} \frac{|u(y)|}{1+|y|^{N+2 s}} d x .
$$

Definition 2.1. Let $u \in \mathcal{C}^{0,1}(\bar{\Omega})$ and define the function $\widetilde{u}$ on $\mathbb{R}^{N}$ as

$$
\widetilde{u}(x)= \begin{cases}u(x) & \text { if } \quad x \in \bar{\Omega}  \tag{2.3}\\ u_{1}(x) & \text { if } \quad x \in \mathbb{R}^{N} \backslash \bar{\Omega}\end{cases}
$$

where

$$
\begin{equation*}
u_{1}(x):=\frac{\int_{\Omega} \frac{u(y)}{|x-y|^{N+2 s}} d y}{\int_{\Omega} \frac{1}{|x-y|^{N+2 s}} d y}, \quad x \in \mathbb{R}^{N} \backslash \bar{\Omega} \tag{2.4}
\end{equation*}
$$

Remark 2.2. We note that $\mathcal{N}_{s} \widetilde{u}(x)=0$ for all $x \in \mathbb{R}^{N} \backslash \bar{\Omega}$.
We now recall the following results that lead to integration by parts in a fractional setting from [2]:

Lemma 2.3 ([2]). Let $u, v: \mathbb{R}^{N} \rightarrow \mathbb{R}$ be two functions such that $\mathcal{N}_{s} v=0$ on $\mathbb{R}^{N} \backslash \bar{\Omega}$. Then

$$
\begin{align*}
\int_{\Omega} \int_{\Omega}(u(x)-u(y)) & (v(x)-v(y)) K_{\Omega}(x, y) d x d y \\
& =C_{N, s} \iint_{\mathcal{Q}} \frac{(\widetilde{u}(x)-\widetilde{u}(y))(v(x)-v(y))}{|x-y|^{N+2 s}} d x d y \tag{2.5}
\end{align*}
$$

From Lemma 2.3 and [8, Lemma 3.3], we deduce the integration by parts formula

$$
\begin{equation*}
\iint_{\mathcal{Q}} \frac{(\widetilde{u}(x)-\widetilde{u}(y))(v(x)-v(y))}{|x-y|^{N+2 s}} d x d y=\int_{\Omega} v(-\Delta)^{s} \widetilde{u} d x+\int_{\mathbb{R}^{N} \backslash \Omega} v \mathcal{N}_{s} \widetilde{u} d x \tag{2.6}
\end{equation*}
$$

for $u$ and $v$ being two $\mathcal{C}^{2}$ bounded functions in $\mathbb{R}^{N}$.

### 2.1 Estimates on $\widetilde{u}$

Let $N<p<\infty$ and suppose $u \in W^{2, p}(\Omega)$ and hence $u$ is $C^{0,1}(\bar{\Omega})$. Then note that $\widetilde{u}$ is smooth near $x$ for any $x \notin \bar{\Omega}$. So the only real question on the smoothness of $\widetilde{u}$ is when $x \notin \Omega$ and $\delta(x)=\operatorname{dist}(x, \partial \Omega)<1$. For $x \notin \bar{\Omega}$, let $\hat{x} \in \partial \Omega$ be such that

$$
|x-\hat{x}|=\inf _{z \in \partial \Omega}|z-x| .
$$

Lemma 2.4. Let $\Omega$ be an open bounded set of $\mathbb{R}^{N}$ with smooth boundary and let $N<p<\infty$ and suppose $u \in W^{2, p}(\Omega)$ with $\|u\|_{W^{2, p}} \leq 1$. The following estimates are all independent of $u$.
(i) For $0<s<1 / 2$ there is some $C$ such that for all $x \in \mathbb{R}^{N} \backslash \bar{\Omega}$ with $\delta(x)<1$ we have

$$
\left|\nabla u_{1}(x)\right| \leq \frac{C}{(\delta(x))^{1-2 s}}
$$

Therefore, $\widetilde{u} \in W_{l o c}^{1, q}\left(\mathbb{R}^{N}\right)$ for all $1<q<\frac{1}{1-2 s}$ - after applying the co-area formula.
(ii) If $s=1 / 2$ then $\widetilde{u} \in W_{\text {loc }}^{1, q}\left(\mathbb{R}^{N}\right)$ for all $1 \leq q<\infty$.
(iii) Let $1 / 2<s<1$. Then, there is some $C>0$ such that $|\nabla \widetilde{u}(x)| \leq C$ on $\mathbb{R}^{N}$.

Proof. Let $x \in \mathbb{R}^{N} \backslash \bar{\Omega}$ with $\delta(x)<1$. For simplicity, we set

$$
F(x)=\int_{\Omega}|x-y|^{-N-2 s} d y
$$

Since $u \in W^{2, p}(\Omega)$ with $p>N$, we have that $u \in \mathcal{C}^{0,1}(\bar{\Omega})$. It follows from [8, Proposition 5.2] and the regularity of $\Omega$ that $\widetilde{u}$ is continuous in $\mathbb{R}^{N}$. Moreover, a direct computation shows that

$$
\begin{aligned}
\frac{(F(x))^{2} \nabla u_{1}(x)}{N+2 s}= & \int_{\Omega}(u(y)-u(\hat{x}))|x-y|^{-N-2 s} d y \int_{\Omega}|x-y|^{-N-2 s-2}(x-y) d y \\
& +\int_{\Omega}|x-y|^{-N-2 s} d y \int_{\Omega}(u(\hat{x})-u(y))|x-y|^{-N-2 s-2}(x-y) d y .
\end{aligned}
$$

We now use the bound on $u$ given by $|u(y)-u(\hat{x})| \leq C_{0}|y-\hat{x}|$ to give

$$
\begin{aligned}
\frac{(F(x))^{2}\left|\nabla u_{1}(x)\right|}{N+2 s} \leq & C_{0} \int_{\Omega} \frac{|y-\hat{x}|}{|x-y|^{N+2 s}} d y \int_{\Omega} \frac{1}{|x-y|^{N+2 s+1}} d y \\
& +C_{0} \int_{\Omega} \frac{1}{|x-y|^{N+2 s}} d y \int_{\Omega} \frac{|y-\hat{x}|}{|x-y|^{N+2 s+1}} d y
\end{aligned}
$$

Now note that for $y \in \Omega$ we have $|x-\hat{x}| \leq|x-y|$ by the definition of $\hat{x}$ and hence we have

$$
|y-\hat{x}| \leq|y-x|+|x-\hat{x}| \leq 2|y-x| .
$$

It follows using the above inequality that

$$
\begin{aligned}
\frac{(F(x))^{2}\left|\nabla u_{1}(x)\right|}{N+2 s} \leq & C_{1} \int_{\Omega} \frac{1}{|x-y|^{N+2 s-1}} d y \int_{\Omega} \frac{1}{|x-y|^{N+2 s+1}} d y \\
& +C_{1} \int_{\Omega} \frac{1}{|x-y|^{N+2 s}} d y \int_{\Omega} \frac{1}{|x-y|^{N+2 s}} d y
\end{aligned}
$$

Noticing that the second term in the right hand side is just $(F(x))^{2}$, we have

$$
\begin{equation*}
\frac{\left|\nabla u_{1}(x)\right|}{N+2 s} \leq C_{1}+C_{2} \frac{\int_{\Omega} \frac{1}{|x-y|^{N+2 s-1}} d y \int_{\Omega} \frac{1}{|x-y|^{N+2 s+1}} d y}{(F(x))^{2}} \tag{2.7}
\end{equation*}
$$

Now, it well known from [1, Lemma 2.1] that there are constants $C_{1}>0$ and $C_{2}>0$ such that for any $x \in \mathbb{R}^{N} \backslash \bar{\Omega}$, we have

$$
\begin{equation*}
C_{1} \min \left\{(\delta(x))^{-2 s},(\delta(x))^{-N-2 s}\right\} \leq F(x) \leq C_{2} \min \left\{(\delta(x))^{-2 s},(\delta(x))^{-N-2 s}\right\} \tag{2.8}
\end{equation*}
$$

With the assumption $\delta(x)<1, x \in \mathbb{R}^{N} \backslash \bar{\Omega}$, this reduces to

$$
\begin{equation*}
C_{1}(\delta(x))^{-2 s} \leq F(x) \leq C_{2}(\delta(x))^{-2 s} \tag{2.9}
\end{equation*}
$$

We have the more general result that for $\tau>0$ there is some $C_{1}, C_{2}>0$ such that for $x \notin \bar{\Omega}$ but with $\delta(x)$ small we have

$$
\begin{equation*}
\frac{C_{1}}{(\delta(x))^{\tau}} \leq \int_{\Omega} \frac{1}{|x-y|^{N+\tau}} d y \leq \frac{C_{2}}{(\delta(x))^{\tau}} \tag{2.10}
\end{equation*}
$$

We now distinguish three cases: $s \in(0,1 / 2), s=1 / 2$ or $s \in(1 / 2,1)$.
Case (i): $0<s<1 / 2$. Set $R_{0}=2 \operatorname{diam}(\Omega)$, where $\operatorname{diam}(\Omega)$ is the diameter of $\Omega$. Since $\Omega$ is bounded and $\delta(x)<1, x \in \mathbb{R}^{N} \backslash \bar{\Omega}$, we have that $\Omega \subset B_{2 R_{0}+1}(x)$. It follows that

$$
\begin{equation*}
\int_{\Omega} \frac{1}{|x-y|^{N+2 s-1}} d y \leq \int_{B_{2 R_{0}+1}(0)} \frac{1}{|z|^{N+2 s-1}} d z=C \int_{0}^{2 R_{0}+1} \rho^{-2 s} d \rho=C\left(2 R_{0}+1\right)^{1-2 s} \tag{2.11}
\end{equation*}
$$

Putting (2.9), (2.11) and (2.10) together, we get

$$
\frac{\left|\nabla u_{1}(x)\right|}{N+2 s} \leq C_{1}+\frac{C_{3}}{(\delta(x))^{1-2 s}}
$$

We then apply the coarea formula now to get the desired result.

Case (ii): $s=1 / 2$. We know from (2.7) that

$$
\left|\nabla u_{1}(x)\right| \leq C_{1}+C_{2} \frac{\int_{\Omega} \frac{1}{|x-y|^{N+2}} d y \int_{\Omega} \frac{1}{|x-y|^{N}} d y}{(F(x))^{2}}
$$

and this gives combining (2.9) and (2.10),

$$
\left|\nabla u_{1}(x)\right| \leq C_{1}+C_{3} \int_{\Omega} \frac{1}{|x-y|^{N}} d y
$$

We now estimate the last term. Since $\Omega \subset B_{2 R_{0}+1}(x)$ and $x \notin \Omega$ with $\delta(x)<1$. Then we have

$$
G(x)=\int_{y \in \Omega} \frac{1}{|x-y|^{N}} d y \leq C \int_{\left\{z: \delta(x) \leq|z| \leq 2 R_{0}+1\right\}} \frac{1}{|z|^{N} d z}=C \ln \left(\frac{2 R_{0}+1}{\delta(x)}\right) .
$$

Then we have, after using the co-area formula,

$$
\begin{aligned}
\int_{\{x \notin \Omega, \delta(x)<1\}} G(x)^{q} d x & \leq C^{q} \int_{\{x \notin \Omega: \delta(x)<1\}}\left(\ln \left(\frac{2 R_{0}+1}{\delta(x)}\right)\right)^{q} d x \\
& =C^{q} \int_{0}^{1}\left(\int_{\{x \notin:: \delta(x)=t\}}\left\{\ln \left(\frac{2 R_{0}+1}{\delta(x)}\right)\right\}^{q} d \sigma(x)\right) d t \\
& =C^{q} \int_{0}^{1}\left(\int_{\{x \notin: \delta(x)=t\}}\left\{\ln \left(\frac{2 R_{0}+1}{t}\right)\right\}^{q} d \sigma(x)\right) d t
\end{aligned}
$$

There is some $C>0$ such that $|\{x \notin \Omega: \delta(x)=t\}| \leq C$ for all $0<t<1$, where $|A|$ refers the the $N-1$ measure of $A$. From this we see (after doing a change of variables $r=1 / t$ that we have

$$
\int_{\{x \notin \Omega, \delta(x)<1\}} G(x)^{q} d x \leq C \int_{1}^{\infty} \frac{\left(\ln \left(\left(2 R_{0}+1\right) r\right)\right)^{q}}{r^{2}} d r
$$

and this is finite for any $1 \leq q<\infty$. Therefore, for any $x \in \mathbb{R}^{N}$ and $|x| \leq R$, we have

\int_{B_{R}}|\nabla \widetilde{u}(x)|^{q} d x \leq C_{R}
$$

This shows that $\widetilde{u} \in W_{l o c}^{1, q}\left(\mathbb{R}^{N}\right)$ for all $1<q<\infty$.
Case (iii): $1 / 2<s<1$. For $x \notin \bar{\Omega}$, we have from (2.7) that

$$

Now, since $\Omega \subset \mathbb{R}^{N} \backslash B_{\delta(x)}(x)$ for all $x \in \Omega^{c}$, we compute for $s>1 / 2$,

\int_{\Omega} \frac{1}{|x-y|^{N+2 s-1}} d y \leq \int_{\mathbb{R}^{n} \backslash B_{d(x)}} \frac{1}{|z|^{N+2 s-1}} d z=C \int_{d(x)}^{\infty} \rho^{-2 s} d \rho=C \delta(x)^{1-2 s}
$$

This combined with (2.9) and (2.10) yield

\frac{\left|\nabla u_{1}(x)\right|}{N+2 s} \leq C_{1}+C_{4}
$$

Hence, for all $x \in \mathbb{R}^{N} \backslash \bar{\Omega}$ we have

\left|\nabla u_{1}(x)\right| \leq C .
$$

Lemma 2.5. The following results hold:

1. Suppose $\frac{N-1}{2 N}<s<1 / 2$ and $N<p<\frac{1}{1-2 s}$. Then, the mapping $u \mapsto(-\Delta)^{s} \widetilde{u}$ is continuous and compact from $W^{2, p}(\Omega)$ to $L^{p}(\Omega)$.
2. Suppose $p>N$ and $1 / 2 \leq s<\frac{1}{2}+\frac{1}{2 p}$. The mapping $u \mapsto(-\Delta)^{s} \widetilde{u}$ is continuous and compact from $W^{2, p}(\Omega)$ to $L^{p}(\Omega)$.

Proof. 1. For the convenience of the reader we show the continuous argument and compact argument in separate steps. Let $u \in W^{2, p}(\Omega)$ with $\|u\|_{W^{2, p}(\Omega)} \leq 1$ and let $x \in \Omega$ and then note we have

(-\Delta)^{s} \tilde{u}(x)=I+I I+I I I
$$

where

$$
\begin{gathered}
I(u)(x)=\int_{\{y \in \Omega:|y-x| \leq 1\}} \frac{\tilde{u}(x)-\tilde{u}(y)}{|x-y|^{N+2 s}} d y, \\
I I(u)(x)=\int_{\left\{y \in \mathbb{R}^{N} \backslash \bar{\Omega}:|y-x| \leq 1\right\}} \frac{\tilde{u}(x)-\tilde{u}(y)}{|x-y|^{N+2 s}} d y, \\
\text { and } I I I(u)(x)=\int_{\{y:|y-x| \geq 1\}} \frac{\tilde{u}(x)-\tilde{u}(y)}{|x-y|^{N+2 s}} d y .
\end{gathered}
$$

Note that

$$
|I(u)(x)| \leq \int_{\{y \notin \Omega:|y-x| \leq 1\}} \frac{C|x-y|}{|x-y|^{N+2 s}} d y \leq C_{2}
$$

since $s<\frac{1}{2}$. Also, note that

$$
|I I I(u)(x)| \leq \int_{\{y:|y-x| \geq 1\}} \frac{C}{|x-y|^{N+2 s}} d y
$$

since $\widetilde{u}$ is bounded on $\mathbb{R}^{N}$ and hence $|I I I(u)(x)|$ is bounded in $\Omega$ by some $C$. We now estimate $I I(u)$. Using $z=y-x$ we have

|I I(u)(x)| \leq \int_{|z| \leq 1} \frac{|\widetilde{u}(x+z)-\widetilde{u}(x)|}{|z|^{N+2 s}} d z
$$

Note that

|\widetilde{u}(x+z)-\widetilde{u}(x)| \leq|z| \int_{0}^{1}|\nabla \widetilde{u}(x+t z)| d t
$$

Hence, we have

\int_{\Omega}|I I(u)(x)|^{p} d x & \leq \int_{\Omega}\left(\int_{|z| \leq 1} \frac{1}{|z|^{N+2 s-1}} \int_{0}^{1}|\nabla \widetilde{u}(x+t z)| d t d z\right)^{p} d x \\
& \leq C \int_{\Omega} \int_{|z| \leq 1} \frac{1}{|z|^{N+2 s-1}} \int_{0}^{1}|\nabla \widetilde{u}(x+t z)|^{p} d t d z d x \quad \text { (Jensen's inquality applied twice) } \\
& =C \int_{0}^{1} \int_{|z| \leq 1} \frac{1}{|z|^{N+2 s-1}}\left(\int_{\Omega}|\nabla \widetilde{u}(x+t z)|^{p} d x\right) d z d t \\
& \leq C \int_{0}^{1} \int_{|z| \leq 1} \frac{1}{|z|^{N+2 s-1}}\left(\int_{|x| \leq R}|\nabla \widetilde{u}(x)|^{p} d x\right) d z d t
\end{aligned}
$$

for some large $R$ and hence we have

$$
\int_{\Omega}|I I(u)(x)|^{p} d x \leq C_{2} \int_{|x| \leq R}|\nabla \widetilde{u}(x)|^{p} d x
$$

Combining this with the results on $I(u)$ and $I I I(u)$, we see that $\Delta^{s} \widetilde{u} \in L^{p}(\Omega)$ and is continuous from $W^{2, p}(\Omega)$.
We now consider the compactness. Since $W^{2, p}(\Omega)$ is a reflexive space its sufficient to show that if $u_{m} \rightharpoonup 0$ in $W^{2, p}(\Omega)$ then $\Delta^{s} \widetilde{u}_{m} \rightarrow 0$ in $L^{p}(\Omega)$. Let $u_{m} \rightharpoonup 0$ in $W^{2, p}(\Omega)$ and hence it converges to zero in $W^{1, p}(\Omega)$ and uniformly in $\Omega$.

$$
\begin{aligned}
\frac{(F(x))^{2} \nabla \widetilde{u}_{m}(x)}{N+2 s}= & \int_{\Omega}\left(u_{m}(y)-u_{m}(\hat{x})\right)|x-y|^{-N-2 s} d y \int_{\Omega}|x-y|^{-N-2 s-2}(x-y) d y \\
& +\int_{\Omega}|x-y|^{-N-2 s} d y \int_{\Omega}\left(u_{m}(\hat{x})-u_{m}(y)\right)|x-y|^{-N-2 s-2}(x-y) d y
\end{aligned}
$$

From this we see that $\left|\nabla \widetilde{u}_{m}(x)\right| \rightarrow 0$ a.e. in $\mathbb{R}^{N}$ and note that we can use the result of Lemma 2.4 with the dominated convergence theorem to see that $\widetilde{u}_{m} \rightarrow 0$ in $W^{1, p}\left(B_{R}\right)$ for all $0<R<\infty$.
Let $x \in \Omega$ and then note

$$
(-\Delta)^{s} \widetilde{u}_{m}(x)=J_{1}\left(u_{m}\right)(x)+I I I\left(u_{m}\right)(x)
$$

where

$$
J_{1}\left(u_{m}\right)(x)=I\left(u_{m}\right)(x)+I I\left(u_{m}\right)(x)=\int_{\{y:|y-x| \leq 1\}} \frac{\widetilde{u}_{m}(x)-\widetilde{u}_{m}(y)}{|x-y|^{N+2 s}} d y
$$

As before, we can write this as

$$
\begin{aligned}
& \int_{\Omega}\left|J_{1}\left(u_{m}\right)(x)\right|^{p} d x \\
& \leq C_{1} \int_{0}^{1} \int_{\{|z| \leq 1\}} \frac{1}{|z|^{N+2 s-1}}\left(\int_{x \in \Omega}\left|\nabla \widetilde{u}_{m}(x+t z)\right|^{p} d x\right) d z d x \\
& \leq C_{2} \int_{|x|<R}\left|\nabla \widetilde{u}_{m}(x)\right|^{p} d x
\end{aligned}
$$

for some large $R$ and we know this goes to zero from the earlier results.
Let $R>1$ be big and note we have

$$
\begin{aligned}
\left|I I I\left(u_{m}\right)(x)\right| \leq & \int_{\{y: 1 \leq|y-x| \leq R\}} \frac{\left|\widetilde{u}_{m}(x)\right|+\left|\widetilde{u}_{m}(y)\right|}{|x-y|^{N+2 s}} d y \\
& +\int_{\{y:|y-x| \geq R\}} \frac{\left|\widetilde{u}_{m}(x)\right|+\left|\widetilde{u}_{m}(y)\right|}{|x-y|^{N+2 s}} d y \\
\leq & \int_{\{y: 1 \leq|y-x| \leq R\}} \frac{\left|\widetilde{u}_{m}(x)\right|+\left|\widetilde{u}_{m}(y)\right|}{|x-y|^{N+2 s}} d y+C R^{-2 s},
\end{aligned}
$$

where $C$ is from the fact that $\left|\widetilde{u}_{m}(x)\right| \leq C_{1}$ on $\mathbb{R}^{N}$ (independent of $m$ ). From this we see that

\int_{\Omega}\left|I I I\left(u_{m}\right)(x)\right|^{p} d x & \leq C_{p} R^{-2 s p}+C_{p} \int_{\Omega}\left(\int_{1 \leq|y-x| \leq R} \frac{\left|\widetilde{u}_{m}(x)\right|+\left|\widetilde{u}_{m}(y)\right|}{|x-y|^{N+2 s}} d y\right)^{p} d x \\
& \leq C_{p} R^{-2 s p}+C_{p} \int_{\Omega}\left(2 \sup _{|\zeta| \leq R}\left|\widetilde{u}_{m}(\zeta)\right| \int_{|z| \geq 1} \frac{1}{|z|^{N+2 s}} d z\right)^{p} d x
\end{aligned}
$$

and note that the second term goes to zero when $m \rightarrow \infty$. Hence, we have

2. We now take $1 / 2 \leq s<1$ and for these cases we split the integral in the definition of the fractional Laplacian as

& +\frac{C_{N, s}}{2} \int_{\left\{z \in \mathbb{R}^{N}:|z|>1\right\}} \frac{[\widetilde{u}(x)-\widetilde{u}(x+z)]+[\widetilde{u}(x)-\widetilde{u}(x-z)]}{|z|^{N+2 s}} d z,
\end{aligned}
$$

where for $i=1, \cdots, 4$, the sets $A_{x}^{i}$ are defined as

$$
\begin{aligned}
& A_{x}^{1}=\{z:|z| \leq 1, x+z, x-z \in \Omega\} \\
& A_{x}^{2}=\{z:|z| \leq 1, x+z \notin \Omega, x-z \in \Omega\} \\
& A_{x}^{3}=\{z:|z| \leq 1, x+z \in \Omega, x-z \notin \Omega\}, \\
& A_{x}^{4}=\{z:|z| \leq 1, x+z \notin \Omega, x-z \notin \Omega\} .
\end{aligned}
$$

We first estimate the following

$$
\int_{x \in \Omega}\left(\int_{\left\{z \in \mathbb{R}^{N}:|z|>1\right\}} \frac{|\widetilde{u}(x+z)+\widetilde{u}(x-z)-2 \widetilde{u}(x)|}{|z|^{N+2 s}} d z\right)^{p} d x
$$

First note that $\sup _{z \in \mathbb{R}^{N}}|\widetilde{u}(z)| \leq \sup _{x \in \Omega}|u(x)|$ and hence the above quantity is bounded,

\int_{x \in \Omega}\left(\int_{\left\{z \in \mathbb{R}^{N}:|z|>1\right\}} \frac{|\widetilde{u}(x+z)+\widetilde{u}(x-z)-2 \widetilde{u}(x)|}{|z|^{N+2 s}} d z\right)^{p} d x \leq C\|u\|_{W^{2, p}(\Omega)}^{p} .
$$

We now estimate the integrals over $A_{x}^{i}$ for $i=1, \cdots, 4$.
The $A_{x}^{1}$ term. Let $1 / 2 \leq s<1, u \in W^{2, p}(\Omega)$ with $\|u\|_{W^{2, p}} \leq 1$ and let $v$ denote is $W^{2, p}(\Omega)$ extension to all of $\mathbb{R}^{N}$ which is compactly supported. Using a density we assume $u, v$ smooth. We want to estimate

$$
\int_{x \in \Omega}\left(\int_{z \in A_{x}^{1}} \frac{|\widetilde{u}(x+z)+\widetilde{u}(x-z)-2 \widetilde{u}(x)|}{|z|^{N+2 s}} d z\right)^{p} d x
$$

and note we can replace $\widetilde{u}$ with $u$ in $A_{x}^{1}$ and then we can replace $u$ with $v$. We now estimate this quantity. First note that for $|z| \leq 1$ we have

|v(x+z)-v(x)-\nabla v(x) \cdot z| \leq|z|^{2} \int_{0}^{1} \int_{0}^{1}\left|D^{2} v(x+t \tau z)\right| d \tau d t
$$

and from this we see that

|v(x+z)+v(x-z)-2 v(x)| \leq|z|^{2} \int_{0}^{1} \int_{0}^{1}\left|D^{2} v(x \pm t \tau z)\right| d \tau d t
$$

where the $\pm$ indicates there is two terms we need to consider. Then we have

\int_{x \in \Omega}\left(\int_{z \in A_{x}^{1}} \frac{|\widetilde{u}(x+z)+\widetilde{u}(x-z)-2 \widetilde{u}(x)|}{|z|^{N+2 s}} d z\right)^{p} d x
$$

is bounded above by

$$
\int_{x \in \mathbb{R}^{N}}\left(\int_{z \in A_{x}^{1}}|z|^{-N-2 s+2}\left(\int_{0}^{1} \int_{0}^{1}\left|D^{2} v(x \pm t \tau z)\right| d \tau d t\right) d z\right)^{p} d x
$$

and we can apply Jensen's inequality twice to get this bounded above by

$$
C_{1} \int_{x \in \mathbb{R}^{N}} \int_{z \in A_{x}^{1}}|z|^{-N-2 s+2} \int_{0}^{1} \int_{0}^{1}\left|D^{2} v(x \pm t \tau z)\right|^{p} d \tau d t d z d x
$$

and by Fubini we see this bounded above by

$$
C \int_{0}^{1} \int_{0}^{1} \int_{|z| \leq 1}|z|^{-N-2 s+2}\left(\int_{\mathbb{R}^{N}}\left|D^{2} v(x \pm t \tau z)\right|^{p} d x\right) d z d t d \tau
$$

and the Extension Theorem (see [?, Theorem 1, Page 259]) we have the term in the brackets bounded by the constant

$$
\int_{\mathbb{R}^{N}}\left|D^{2} v(x)\right|^{p} d x \leq C\|u\|_{W^{2, p}(\Omega)}^{p}
$$

and this gives us the desired bound, that is

\int_{x \in \Omega}\left(\int_{z \in A_{x}^{1}} \frac{|\widetilde{u}(x+z)+\widetilde{u}(x-z)-2 \widetilde{u}(x)|}{|z|^{N+2 s}} d z\right)^{p} d x \leq C\|u\|_{W^{2, p}(\Omega)}^{p}
$$

The $A_{x}^{i}$ term for $i=2,3,4$. Note that if $z \in A_{x}^{i}$ for $i=2,3,4$, we must have $|z|>\delta(x)$. In what follows we will estimate

$$
\int_{x \in \Omega}\left(\int_{z \in A_{x}^{i}} \frac{|\widetilde{u}(x+z)-\widetilde{u}(x)|}{|z|^{N+2 s}} d z\right)^{p} d x .
$$

The same argument can be used to also estimate

$$

We split the proof into two cases: $s=\frac{1}{2}$ and $s \in(1 / 2,1)$.
The case $s=\frac{1}{2}$. Let $2 \leq i \leq 4$ and note that we have

& \int_{x \in \Omega}\left(\int_{z \in A_{x}^{i}} \frac{|\widetilde{u}(x+z)-\widetilde{u}(x)|}{|z|^{N+1}} d z\right)^{p} d x \\
\leq & \int_{x \in \Omega}\left(\int_{z \in A_{x}^{i}} \frac{\int_{0}^{1} \mid \nabla \widetilde{u}(x+t z) d t}{|z|^{N}} d z\right)^{p} d x \\
= & \int_{x \in \Omega}\left(\int_{z \in A_{x}^{i}} \frac{\int_{0}^{1} \mid \nabla \widetilde{u}(x+t z) d t}{|z|^{N-\alpha}|z|^{\alpha}} d z\right)^{p} d x \quad \text { for some } \alpha>0 \text { small, picked later } \\
\leq & \int_{x \in \Omega} \frac{1}{(\delta(x))^{\alpha p}}\left(\int_{z \in A_{x}^{i}} \frac{\int_{0}^{1} \mid \nabla \widetilde{u}(x+t z) d t}{|z|^{N-\alpha}} d z\right)^{p} d x \\
\leq & C \int_{x \in \Omega} \frac{1}{(\delta(x))^{\alpha p}}\left(\int_{z \in A_{x}^{i}} \frac{\int_{0}^{1}|\nabla \widetilde{u}(x+t z)|^{p} d t}{|z|^{N-\alpha}} d z\right) d x \quad \text { (applying Jensen's inequality twice) } \\
\leq & C \int_{x \in \Omega} \frac{1}{(\delta(x))^{\alpha p}}\left(\int_{\delta(x)<|z| \leq 1} \frac{\int_{0}^{1}|\nabla \widetilde{u}(x+t z)|^{p} d t}{|z|^{N-\alpha}} d z\right) d x \\
= & C \int_{0}^{1} \int_{|z| \leq 1} \frac{1}{|z|^{N-\alpha}}\left(\int_{\{x \in \Omega: \delta(x) \leq|z|\}} \frac{|\nabla \widetilde{u}(x+t z)|^{p}}{(\delta(x))^{\alpha p}} d x\right) d z d t .
\end{aligned}
$$

We now fix $0<|z| \leq 1$ and $0<t<1$ and note for $1<q<\infty$ we have

$$
\int_{\{x \in \Omega: \delta(x) \leq|z|\}} \frac{|\nabla \widetilde{u}(x+t z)|^{p}}{(\delta(x))^{\alpha p}} d x \leq\left(\int_{\Omega}|\nabla \widetilde{u}(x+t z)|^{p q} d x\right)^{\frac{1}{q}}\left(\int_{\Omega} \frac{1}{(\delta(x))^{\alpha p q^{\prime}}} d x\right)^{\frac{1}{q^{\prime}}}
$$

and so for fixed $q$ we can take $\alpha>0$ small enough so that $\alpha p q^{\prime}<1$ and the internal involving the distance function is bounded and the other integral is bounded (independent of $z$ and $t$ ) after considering the earlier gradient bound on $\widetilde{u}$. This shows that

The case $s \in(1 / 2,1)$. Let $2 \leq i \leq 4$ and $u$ be as above. Recalling for $z \in A_{x}^{i}$ we have $|z|>\delta(x)$ we have

& \int_{x \in \Omega}\left(\int_{z \in A_{x}^{i}} \frac{|\widetilde{u}(x+z)-\widetilde{u}(x)|}{|z|^{N+2 s}} d z\right)^{p} d z \\
& \leq \int_{\Omega}\left(\int_{A_{x}^{i}} \frac{\int_{0}^{1}|\nabla \widetilde{u}(x+t z)| d t}{|z|^{N+2 s-1}} d z\right)^{p} d x \\
& =\int_{\Omega}\left(\int_{A_{x}^{i}} \frac{\int_{0}^{1}|\nabla \widetilde{u}(x+t z)| d t}{\left.|z|^{N+2 s-1-\alpha|z|^{\alpha}} d z\right)^{p} d x \quad \alpha>0}\right. \\
& \leq \int_{\Omega} \frac{1}{(\delta(x))^{\alpha p}}\left(\int_{A_{x}^{i}} \frac{\int_{0}^{1}|\nabla \widetilde{u}(x+t z)| d t}{|z|^{N+2 s-1-\alpha}} d z\right)^{p} d x \\
& \leq C \int_{\Omega} \frac{1}{(\delta(x))^{\alpha p}}\left(\int_{A_{x}^{i}} \frac{\int_{0}^{1}|\nabla \widetilde{u}(x+t z)|^{p} d t}{|z|^{N+2 s-1-\alpha}} d z\right) d x \quad \text { (Jensen's inequality applied twice) }
\end{aligned}
$$

If we now assume that $|\nabla \widetilde{u}| \leq C$ then we get this is bounded above by

$$
C \int_{x \in \Omega} \frac{1}{\delta(x)^{\alpha p}}\left(\int_{z \in A_{x}^{i}} \frac{1}{|z|^{N+2 s-1-\alpha}} d z\right) d x
$$

and since $A_{x}^{i} \subset\{z:|z| \leq 1,|z|>\delta(x)\}$ then to have this bounded its sufficient that $\alpha p<1$ and $2 s-1-\alpha<0$. Hence we see its sufficient that $2 s-1<\frac{1}{p}$. The compactness proof follows the same ideas as the previous range of $s$.

The following result is a maximum principle that we will use in the proof of existence of a solution.

Theorem 2.6. Let $\Omega \subset \mathbb{R}^{N}$ be an open bounded set, $q$ and $a$ be smooth with $a(x) \geq 0$ in $\Omega$. Suppose $u \in W^{2, p}(\Omega)$ is a solution of

$$
\left\{\begin{array}{rll}
L u=0 & \text { in } & \Omega,  \tag{2.12}\\
\frac{\partial u}{\partial \nu}=0 & \text { on } & \partial \Omega, \\
\mathcal{N}_{s} u=0 & \text { on } & \mathbb{R}^{N} \backslash \bar{\Omega} .
\end{array}\right.
$$

Then, $\widetilde{u} \equiv 0$ in $\mathbb{R}^{N}$.

Proof. Let $u$ denote the solution and, for notation, we also let $u$ denote $\widetilde{u}$ outside of $\Omega$. Suppose $x_{0} \in \bar{\Omega}$ such that $u\left(x_{0}\right)=\inf _{\Omega} u$. We first rule out $x_{0} \in \partial \Omega$. If $x_{0} \in \partial \Omega$, then we take $x_{m} \notin \bar{\Omega}$ such that $x_{m} \rightarrow x_{0}$ as $m \rightarrow+\infty$. Using the nonlocal boundary condition we get

$$
0=\int_{\Omega} \frac{u(y)-u\left(x_{m}\right)}{\left|y-x_{m}\right|^{N+2 s}} d y
$$

Passing to the limit, we see that

$$
0=\int_{\Omega} \frac{u(y)-u\left(x_{0}\right)}{\left|y-x_{0}\right|^{N+2 s}} d y
$$

which shows that $u=C=$ const. is constant in $\Omega$ and hence constant in $\mathbb{R}^{N}$. Then note from the equation we have $a(x) C=f(x)$ in $\Omega$ and this shows that $u=C \geq 0$ provided $a(x)$ not identically zero which we have assumed and hence we are done. We now suppose $x_{0} \in \Omega$ is such that $u\left(x_{0}\right)=\inf _{\Omega} u$ and we suppose $u\left(x_{0}\right)<0$.

We can also suppose that $u\left(x_{0}\right)<\inf _{\partial \Omega} u$. Note that, from the definition of $u_{1}$, we get $u(x)>u\left(x_{0}\right)$ for all $x \in \mathbb{R}^{N} \backslash \bar{\Omega}$.

Fix $\sigma>0$ such that $u\left(x_{0}\right)+10 \sigma<\min _{\partial \Omega} u$ and we also assume $u\left(x_{0}\right)+10 \sigma<0$. For $\varepsilon>0$ small set $\Omega_{\varepsilon}=\{x \in \Omega: \delta(x)>\varepsilon\}$ and $\stackrel{\partial}{\Gamma}_{\varepsilon}^{\partial \Omega}=\{x \in \Omega: \delta(x)<\varepsilon\}$. By continuity there is some $\varepsilon_{0}>0$ such that

$$
u\left(x_{0}\right)+8 \sigma<\inf _{\Gamma_{\varepsilon_{0}}} u
$$

For $x \notin \bar{\Omega}$ we have

$$
\begin{aligned}
u(x) \int_{\Omega} \frac{1}{|x-y|^{N+2 s}} d y & =\int_{\Gamma_{\varepsilon_{0}}} \frac{u(y)}{|x-y|^{N+2 s}} d y+\int_{\Omega \backslash \Gamma_{\varepsilon_{0}}} \frac{u(y)}{|x-y|^{N+2 s}} d y \\
& \geq\left(u\left(x_{0}\right)+8 \sigma\right) \int_{\Gamma_{\varepsilon_{0}}} \frac{1}{|x-y|^{N+2 s}} d y+u\left(x_{0}\right) \int_{\Omega, \Gamma_{\varepsilon_{0}}} \frac{1}{|x-y|^{N+2 s}} d y \\
& =u\left(x_{0}\right) \int_{\Omega} \frac{1}{|x-y|^{N+2 s}} d y+8 \sigma \int_{\Gamma_{\varepsilon_{0}}} \frac{1}{|x-y|^{N+2 s}} d y
\end{aligned}
$$

which gives

$$
u(x) \geq u\left(x_{0}\right)+\frac{\left.8 \sigma \int_{\Gamma_{\varepsilon_{0}}} \frac{1}{|x-y|} \right\rvert\,}{\int_{\Omega+2 s}^{|x-y|^{N+2 s}} d y} .
$$

From this we can show there is some $c_{\varepsilon_{0}}>0$ (without loss of generality we can take $c_{\varepsilon_{0}}<1$ ) such that $u(x) \geq u\left(x_{0}\right)+8 \sigma c_{\varepsilon_{0}}$ for all $x \notin \bar{\Omega}$.

Let $\eta$ denote a standard radial mollifier with $\eta_{\varepsilon}$ the appropriately scaled function whose support is $\overline{B_{\varepsilon}}$ and set $u^{\varepsilon}(x)=\left(\eta_{\varepsilon} * u\right)(x)$ for $x \in \mathbb{R}^{N}$. For all $0<\varepsilon<\varepsilon_{0}$ we have

$$
\inf _{\partial \Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}} \geq \inf _{\Gamma_{\varepsilon}} u
$$

and also we have $\inf _{\Omega_{\tau}} u^{\tau} \rightarrow u\left(x_{0}\right)$ as $\tau \rightarrow 0$. From this we see there is some $0<\varepsilon_{1}<\varepsilon_{0}$ such that for all $0<\varepsilon<\varepsilon_{1}$ we have

$$
\inf _{\Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}}+6 \sigma \leq u\left(x_{0}\right)+8 \sigma<\inf _{\Gamma_{\varepsilon_{0}}} u
$$

but by the monotonicity of $\varepsilon \mapsto \inf _{\Gamma_{\varepsilon}} u$ we have

$$
\inf _{\Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}}+6 \sigma<\inf _{\Gamma_{\varepsilon_{0}}} u \leq \inf _{\Gamma_{\varepsilon}} u
$$

for all $0<\varepsilon<\varepsilon_{1}$ and hence we have

$$
\inf _{\Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}}+6 \sigma<\inf _{\partial \Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}},
$$

for $0<\varepsilon<\varepsilon_{1}$ and hence the minimum is contained in the interior of $\Omega_{\frac{\varepsilon}{2}}$. We now want to show that $\min _{\Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}} \leq u^{\frac{\varepsilon}{2}}(x)$ for all $x \in \mathbb{R}^{N}$. Let $0<\varepsilon<\frac{\varepsilon_{1}}{10}$ with:

$$
\begin{equation*}
u^{\frac{\varepsilon}{2}}\left(x_{0}\right)<u\left(x_{0}\right)+8 \sigma c_{\varepsilon_{0}}, \tag{2.13}
\end{equation*}
$$

We consider the three cases:
(i) $x \in \Omega$ with $\delta(x)<\frac{\varepsilon}{2}$, (ii) $x \notin \Omega$ with $\delta(x)<\frac{\varepsilon}{2}$ and (iii) $x \notin \Omega$ with $\delta(x)>\frac{\varepsilon}{2}$.

Case (i). Here we have $x \in \Omega$ with $\delta(x)<\frac{\varepsilon}{2}$. So in this case we have

$$
u^{\frac{\varepsilon}{2}}(x)=\int_{|y-x|<\frac{\varepsilon}{2}} \eta_{\varepsilon}(y-x) u(y) d y
$$

and note the integral can be decomposed as

$$
\int_{|y-x|<\frac{\varepsilon}{2}, y \in \Omega} \eta_{\varepsilon}(y-x) u(y) d y+\int_{|y-x|<\frac{\varepsilon}{2}, y \notin \Omega} \eta_{\varepsilon}(y-x) u(y) d y
$$

and from this we see that

$$
\begin{aligned}
u^{\frac{\varepsilon}{2}}(x) & \geq\left(u\left(x_{0}\right)+8 \sigma c_{\varepsilon_{0}}\right) \int_{|y-x|<\frac{\varepsilon}{2}} \eta_{\varepsilon}(y-x) d y \\
& =u\left(x_{0}\right)+8 \sigma c_{\varepsilon_{0}} \\
& >u^{\frac{\varepsilon}{2}}\left(x_{0}\right) \\
& \geq \inf _{\Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}} .
\end{aligned}
$$

Case (ii). In this case we have from the definition of $\widetilde{u}$ that

$$
\begin{aligned}
u^{\frac{\varepsilon}{2}}(x) \int_{\Omega} \frac{1}{|x-y|^{N+2 s}} d y & =\int_{\Omega} \frac{u^{\frac{\varepsilon}{2}}(y)}{|x-y|^{N+2 s}} d y \\
& =\int_{\Omega} \frac{1}{|x-y|^{N+2 s}} \int_{|y-z|<\frac{\varepsilon}{2}} \eta_{\varepsilon}(z-y) u(z) d z d y \\
& \geq \inf _{\Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}} \int_{\Omega} \frac{1}{|x-y|^{N+2 s}} d y
\end{aligned}
$$

where we have used the computations of Case (i).

Case (iii). This follows similarly.
From the above we have, for small enough $\varepsilon$, that $u^{\frac{\varepsilon}{2}}\left(x_{\frac{\varepsilon}{2}}\right)=\min _{\Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}}$ (some $x_{\frac{\varepsilon}{2}} \in \Omega_{\frac{\varepsilon}{2}}$ ) and $u^{\frac{\varepsilon}{2}}\left(x_{\frac{\varepsilon}{2}}\right)+6 \sigma<\inf _{\partial \Omega_{\frac{\varepsilon}{2}}} u^{\frac{\varepsilon}{2}}$. Also note we have (take $\left.\tau=\varepsilon / 2\right) L\left(u^{\tau}\right)(x)=f^{\tau}(x) \geq 0$ in $\Omega_{\tau}$ and at $x_{\tau}$ we have

$$
\begin{equation*}
-\Delta u^{\tau}\left(x_{\tau}\right)+(-\Delta)^{s} u^{\tau}\left(x_{\tau}\right)+q\left(x_{\tau}\right) \cdot \nabla u^{\tau}\left(x_{\tau}\right)=f^{\tau}\left(x_{\tau}\right)-a\left(x_{\tau}\right) u^{\tau}\left(x_{\tau}\right) \geq 0 \tag{2.14}
\end{equation*}
$$

But $-\Delta u^{\tau}\left(x_{\tau}\right) \leq 0, \nabla u^{\tau}\left(x_{\tau}\right)=0$ and note that

$$
(-\Delta)^{s} u^{\frac{\varepsilon}{2}}\left(x_{\frac{\varepsilon}{2}}\right)=\int_{y \in \mathbb{R}^{N}} \frac{u^{\frac{\varepsilon}{2}}\left(x_{\frac{\varepsilon}{2}}\right)-u^{\frac{\varepsilon}{2}}(y)}{\left|x_{\frac{\varepsilon}{2}}-y\right|^{N+2 s}} d y
$$

and note $y \mapsto u^{\frac{\varepsilon}{2}}\left(x \frac{\varepsilon}{2}\right)-u^{\frac{\varepsilon}{2}}(y)$ is continuous in $y$ on $\mathbb{R}^{N}$, nonpositive and not identically zero. From this we see that $(-\Delta)^{s} u^{\frac{\varepsilon}{2}}\left(x_{\frac{\varepsilon}{2}}\right)<0$ and this contradicts (2.14).

## 3 Proof of existence of a solution

For $u \in W^{2, p}(\Omega)$ and $\gamma \in \mathbb{R}$, we define

$$
L_{\gamma} u(x)=-\Delta u+\gamma(-\Delta)^{s} \tilde{u}(x)+a(x) u(x)+q \cdot \nabla u(x), \quad x \in \Omega
$$

and we consider the family of indexed problems

$$
\left\{\begin{align*}
L_{\gamma} u=f & & \text { in } & \Omega  \tag{3.1}\\
\frac{\partial u}{\partial \nu}=0 & & \text { on } & \partial \Omega
\end{align*}\right.
$$

Let $\mathcal{A}$ be the set

$$
\mathcal{A}:=\left\{\begin{array}{c}
\gamma \in[0,1]: \quad \exists C_{\gamma}>0 \text { such that for all } f \in L^{p}(\Omega),(\underline{3.1)} \text { has a solution }  \tag{3.2}\\
u \in W^{2, p}(\Omega) \text { such that }\|u\|_{W^{2, p}(\Omega)} \leq C_{\gamma}\|f\|_{L^{p}(\Omega)}
\end{array}\right\}
$$

In (3.2), we take the constant $C_{\gamma}$ to be the smallest constant such that $\|u\|_{W^{2, p}(\Omega)} \leq$ $C_{\gamma}\|f\|_{L^{p}(\Omega)}$ holds for all functions $f \in L^{p}(\Omega)$. In other words, if $C_{\gamma}>\varepsilon>0$ then there exists $f_{\varepsilon} \in \mathcal{C}^{0, \alpha}(\bar{\Omega})$ such that

$$
\begin{equation*}
\|u\|_{W^{2, p}(\Omega)} \geq\left(C_{\gamma}-\varepsilon\right)\left\|f_{\varepsilon}\right\|_{L^{p}(\Omega)} \tag{3.3}
\end{equation*}
$$

By classical theory, $0 \in \mathcal{A}$. Our goal is to show that $\mathcal{A}$ is both open and closed and since $[0,1]$ is connected we then see that $\mathcal{A} \in\{\emptyset,[0,1]\}$, and since its non empty, we must have $\mathcal{A}=[0,1]$ and in particular $1 \in \mathcal{A}$ which corresponds to the result we are trying to prove.
$\mathcal{A}$ is closed. We prove $\mathcal{A}$ is closed. Let $\gamma_{m} \in \mathcal{A}$ with $\gamma_{m} \rightarrow \gamma$ and let $C_{m}=C_{\gamma_{m}}$ denote the associated constant. We first consider the case of $C_{m}$ bounded. Let $f \in L^{p}(\Omega)$ with $\|f\|_{L^{p}}=1$. Since $\gamma_{m} \in \mathcal{A}$ there is some $u_{m} \in W^{2, p}(\Omega)$ which satisfies (3.1), with $\gamma_{m}$ in place of $\gamma$, and $\left\|u_{m}\right\|_{W^{2, p}} \leq C_{m}\|f\|_{L^{p}}=C_{m}$. Note we can rewrite the problem as

$$
\begin{equation*}
-\Delta u_{m}+a u_{m}+q \cdot \nabla u_{m}=f+\gamma_{m} \Delta^{s} \widetilde{u}_{m} \quad \text { in } \Omega \tag{3.4}
\end{equation*}
$$

with $\partial_{\nu} u_{m}=0$ on $\partial \Omega$. Since $C_{m}$ is bounded then we have $u_{m}$ bounded in $W^{2, p}(\Omega)$ and by passing to a subsequence we can assume that $u_{m} \rightharpoonup u$ in $W^{2, p}(\Omega)$ and $\|u\|_{W^{2, p}} \leq$ $\underset{m}{\liminf }\left\|u_{m}\right\|_{W^{2, p}} \leq C_{1}$. Also note by our earlier compactness result we have $\Delta^{s} \widetilde{u}_{m} \rightarrow \Delta^{s} \widetilde{u}$ in $L^{p}(\Omega)$ and this (along with the above weak $W^{2, p}$ convergence) is sufficient convergence to pass to the limit in (3.4). This shows that $\gamma \in \mathcal{A}$.

We now consider the case of $C_{m} \rightarrow \infty$. Then there is some $f_{m} \in L^{p}(\Omega)$ and $u_{m} \in W^{2, p}(\Omega)$ which solves $L_{\gamma_{m}} u_{m}=f_{m}$ in $\Omega$ with $\partial_{\nu} u_{m}=0$ on $\partial \Omega$ and

$$
\left\|u_{m}\right\|_{W^{2, p}} \geq\left(C_{m}-1\right)\left\|f_{m}\right\|_{L^{p}} .
$$

By normalizing we can assume $\left\|u_{m}\right\|_{W^{2, p}(\Omega)}=1$ and hence $\left\|f_{m}\right\|_{L^{p}} \rightarrow 0$. By passing to subsequences we can assume that $u_{m} \rightharpoonup u$ in $W^{2, p}(\Omega)$ and strongly in $W^{1, p}(\Omega)$. As before we rewrite the equation for $u_{m}$ by

$$
\begin{equation*}
-\Delta u_{m}+a u_{m}+q \cdot \nabla u_{m}=f_{m}+\gamma_{m} \Delta^{s} \widetilde{u}_{m} \quad \text { in } \Omega \tag{3.5}
\end{equation*}
$$

with $\partial_{\nu} u_{m}=0$ on $\partial \Omega$. If $u=0$ then note the right hand side of (3.5) converges to zero in $L^{p}(\Omega)$ and by standard elliptic theory we have $u_{m} \rightarrow 0$ in $W^{2, p}(\Omega)$ which contradicts the normalization of $u_{m}$. We now assume $u \neq 0$. By compactness we can pass to the limit in (3.5) to see that $u \in W^{2, p}(\Omega) \backslash\{0\}$ satisfies $L_{\gamma} u=0$ in $\Omega$ with $\partial_{\nu} u=0$ on $\partial \Omega$ which contradicts Theorem 2.6.
$\mathcal{A}$ is open. Let $\gamma_{0} \in \mathcal{A}$ and take $|\varepsilon|$ small; when $\gamma_{0} \in\{0,1\}$ we need to restrict the sign of $\varepsilon$. Our goal is to show that $\gamma=\gamma_{0}+\varepsilon \in \mathcal{A}$. Fix $f \in L^{p}(\Omega)$ with $\|f\|_{L^{p}}=1$ and since $\gamma_{0} \in \mathcal{A}$ there is some $v_{0} \in W^{2, p}(\Omega)$ which solves $L_{\gamma_{0}} v_{0}=f$ in $\Omega$ with $\partial_{\nu} v_{0}=0$ on $\partial \Omega$. We look for a solution of (3.1) of the form $u=v_{0}+\phi$. Writing out the details one sees we need $\phi \in W^{2, p}(\Omega)$ to satisfy

$$
\begin{equation*}
L_{\gamma_{0}} \phi=\varepsilon \Delta^{s} \widetilde{v}_{0}+\varepsilon \Delta^{s} \widetilde{\phi} \quad \text { in } \Omega \tag{3.6}
\end{equation*}
$$

with $\partial_{\nu} \phi=0$ on $\partial \Omega$. Define the operator $J_{\varepsilon}(\phi)=\psi$ where $\psi$ satisfies

$$
\begin{equation*}
L_{\gamma_{0}} \psi=\varepsilon \Delta^{s} \widetilde{v}_{0}+\varepsilon \Delta^{s} \widetilde{\phi} \quad \text { in } \Omega \tag{3.7}
\end{equation*}
$$

with $\partial_{\nu} \psi=0$ on $\partial \Omega$. We claim that for small enough $\varepsilon$ that $J_{\varepsilon}$ is a contraction mapping on $W^{2, p}(\Omega)$ and hence by the Contraction Mapping Principle there is some $\phi \in W^{2, p}(\Omega)$ with $J_{\varepsilon}(\phi)=\phi$. From (3.6) one would then get a $W^{2, p}(\Omega)$ bound on $\phi$ and hence we'd get the desired bound on $u$. We first note that $J_{\varepsilon}$ is into $W^{2, p}(\Omega)$ after noting the right hand side of (3.6) belongs to $L^{p}(\Omega)$. Let $\phi_{i} \in W^{2, p}(\Omega)$ and $\psi_{i}=J_{\varepsilon}\left(\phi_{i}\right)$ and then note we have

$$
L_{\gamma_{0}}\left(\psi_{2}-\psi_{1}\right)=\varepsilon \Delta^{s}\left(\widetilde{\phi}_{2}-\widetilde{\phi}_{1}\right) \quad \text { in } \Omega
$$

with the desired boundary condition. Then we have

$$
\left\|\psi_{2}-\psi_{1}\right\|_{W^{2, p}} \leq C_{\gamma_{0}}|\varepsilon|\left\|\Delta^{s}\left(\widetilde{\phi}_{2}-\widetilde{\phi}_{1}\right)\right\|_{L^{p}} \leq C_{\gamma_{0}}|\varepsilon| C\left\|\phi_{2}-\phi_{1}\right\|_{W^{2, p}}
$$

and hence we see of $|\varepsilon|$ small that $J_{\varepsilon}$ is a contraction on $W^{2, p}(\Omega)$.
