

FREE MULTIDERIVATIONS OF CONNECTED SUBGRAPH ARRANGEMENTS

ABSTRACT. Cuntz and Kühne [CK24] introduced the class of connected subgraph arrangements \mathcal{A}_G , depending on a graph G , and classified all graphs G such that the corresponding arrangement \mathcal{A}_G is free. We extend their result to the multiarrangement case and classify all graphs G for which the corresponding arrangement \mathcal{A}_G supports some multiplicity μ such that the multiarrangement (\mathcal{A}_G, μ) is free.

1. INTRODUCTION

The study of modules of logarithmic vector fields tangent to hyperplane arrangements (in the sequel also referred to as derivation modules) and in particular the question about their freeness over the coordinate ring of the ambient space is a classic topic at the crossroads of discrete geometry and combinatorics, commutative algebra and algebraic geometry initiated in seminal work by K. Saito [S80] and H. Terao [T80a]. Arrangements with free derivation modules are simply called free arrangements. Subsequently, G. Ziegler [Z89] extended the theory by also taking multiplicities into account. Such multiarrangements naturally arise from arrangement constructions, i.e. restrictions to hyperplanes, and the freeness of their multiderivation modules is closely linked to the freeness of the original simple arrangement due to fundamental work by Ziegler and M. Yoshinaga [Y04].

To decide whether a given (multi-)arrangement is free is a hard problem in general and at its core lies Terao's conjecture, asserting that freeness only depends on the underlying combinatorial structure provided by the intersection lattice. To this day the conjecture is wide open. Therefore, a natural approach in the investigation of such freeness questions is to restrict the view to special classes of arrangements with additional structure. A pivotal result along this line is a theorem of Terao stating that all (complex) reflection arrangements are free [T80b]. Regarding multiarrangements, another milestone is also due to Terao [T02] establishing the freeness of certain natural multiplicities on Coxeter arrangements. This was subsequently used by Yoshinaga in [Y04] to establish a conjecture of Edelman and Reiner about the freeness of certain deformations of Weyl arrangements.

In the recent work [CK24], M. Cuntz and L. Kühne introduce a new class stemming from simple graphs which are defined as follows.

Definition 1.1 ([CK24, Def. 1.1]). Let $G = (N, E)$ be an undirected (simple) graph with a set of vertices $N = \{1, \dots, n\}$ and a set of edges E . The *connected subgraph arrangement*

\mathcal{A}_G in $V = \mathbb{Q}^n$ associated to G is defined as

$$\mathcal{A}_G := \{H_I \mid \emptyset \neq I \subseteq N \text{ if } G[I] \text{ is connected}\},$$

where H_I is the hyperplane

$$H_I = \ker \sum_{i \in I} x_i$$

and $G[I]$ is the induced subgraph on the vertices $I \subseteq N$.

Cuntz and Kühne gave a complete characterization of free arrangements within this class (see Theorem 2.23). In view of their work and because of the importance of the broader perspective on freeness within the framework of multiarrangements, the natural question arises if one can describe certain free multiplicities extending their classification. This is the aim of this paper. Our first main result is as follows.

Theorem 1.2 (Corollary 3.6). *Let G be a connected graph. There exists a multiplicity μ such that the connected subgraph multiarrangement (\mathcal{A}_G, μ) is free if and only if G is G_1 , G_2 , a path-graph, a cycle-graph, an almost-path-graph, or a path-with-triangle-graph (see Definition 2.18 and Figure 1).*

A natural and important question stemming from the study of free multi-Coxeter arrangements by Terao [T02] is about the existence of constant free multiplicities. Our next result gives the following answer for connected subgraph arrangements.

Theorem 1.3 (Proposition 4.6 and Corollary 4.9). *Let G be a connected graph with at least three vertices and $\mu \equiv k > 1$ is a constant multiplicity on \mathcal{A}_G . Then (\mathcal{A}_G, μ) is free if and only if G is a path-graph P_n or G is the cycle-graph C_3 and $k = 3$.*

To classify free multiplicities in general is a notoriously hard problem. Complete answers are known only in very few cases. E.g. characterizing the free multiplicities even on braid arrangements of rank greater than 3 is an unresolved problem, cf. [DFMS20]. Nonetheless, in our study it turns out that for a certain subarrangement \mathcal{D} of \mathcal{A}_{C_3} which is obtained from \mathcal{A}_{C_3} by deleting a single hyperplane, the task is feasible. This constitutes our third theorem.

Theorem 1.4 (Theorem 5.9). *Let (\mathcal{D}, μ) be the multiarrangement*

$$Q(\mathcal{D}, \mu) = x_1^a x_2^b x_3^c (x_1 + x_2)^d (x_1 + x_3)^e (x_2 + x_3)^f$$

with $a, b, c, d, e, f \geq 1$. Then (\mathcal{D}, μ) is free if and only if $\mu = (2k, 2k, 2k, 1, 1, 1)$ for some $k \in \mathbb{N}_{\geq 1}$ where the order of the hyperplanes is as above.

The classification of the free multiplicities on \mathcal{D} was previously obtained by M. DiPasquale and M. Wakefield in [DW18] by different methods.

To conclude, our last chief result describes certain families of free multiplicities on \mathcal{A}_{C_3} .

Theorem 1.5 (Proposition 5.13). *Let (\mathcal{A}_{C_3}, μ) be the multiarrangement*

$$Q(\mathcal{A}_{C_3}, \mu) = x_1^a x_2^b x_3^c (x_1 + x_2)^d (x_1 + x_3)^e (x_2 + x_3)^f (x_1 + x_2 + x_3)^g$$

with multiplicity $\mu = (a, b, c, d, e, f, g)$, $(d \geq e \geq f)$. Suppose that either

- (i) $\mu = (k, k, k, r, 1, 1, k)$, where $1 \leq k \leq 3$ and $r \geq 1$, or
- (ii) $\mu = (k, k, k, r, 1, 1, k)$, where $k > 3$ and $r \geq 2k - 5$.

Then (\mathcal{A}_{C_3}, μ) is free. Moreover, if $r \geq 2k$, then (\mathcal{A}_{C_3}, μ) is inductively free with exponents $(r, 2k + 1, 2k + 1)$. For $\mu = (3, 3, 3, 1, 1, 1, 3)$, (\mathcal{A}_{C_3}, μ) is not inductively free.

For the notion of inductive freeness, see Definition 2.12.

The paper is organized as follows. In §2 we review the required notions from the theory of free multiarrangements and connected subgraph arrangements. The next section presents the arguments leading to a proof of Theorem 1.2. In §4, we investigate the natural question which connected subgraph arrangements support free constant multiplicities leading to our second main Theorem 1.3. Along the way, in §4.1 we present a non-computational proof of the non-freeness of the connected subgraph arrangements stemming from G_1 up to G_8 from Figure 1. This was derived in [CK24] by means of elaborate computer calculations. In our final section we study free multiplicities on two special arrangements, culminating in Theorems 1.4 and 1.5. In the appendices we list some tables containing data which we computed and utilised for our proofs.

2. RECOLLECTIONS AND PRELIMINARIES

2.1. Hyperplane arrangements, multiarrangements and their freeness. Let $V = \mathbb{K}^\ell$ be an ℓ -dimensional \mathbb{K} -vector space. A *hyperplane arrangement* is a pair (\mathcal{A}, V) , where \mathcal{A} is a finite collection of hyperplanes in V . Usually, we simply write \mathcal{A} in place of (\mathcal{A}, V) . We write $|\mathcal{A}|$ for the number of hyperplanes in \mathcal{A} . The empty arrangement in V is denoted by Φ_ℓ .

The *lattice* $L(\mathcal{A})$ of \mathcal{A} is the set of subspaces of V of the form $H_1 \cap \dots \cap H_i$ where $\{H_1, \dots, H_i\}$ is a subset of \mathcal{A} . For $X \in L(\mathcal{A})$, we have two associated arrangements, firstly $\mathcal{A}_X := \{H \in \mathcal{A} \mid X \subseteq H\} \subseteq \mathcal{A}$, the *localization of \mathcal{A} at X* , and secondly, the *restriction of \mathcal{A} to X* , (\mathcal{A}^X, X) , where $\mathcal{A}^X := \{X \cap H \mid H \in \mathcal{A} \setminus \mathcal{A}_X\}$. Note that V belongs to $L(\mathcal{A})$ as the intersection of the empty collection of hyperplanes and $\mathcal{A}^V = \mathcal{A}$. The lattice $L(\mathcal{A})$ is a partially ordered set by reverse inclusion: $X \leq Y$ provided $Y \subseteq X$ for $X, Y \in L(\mathcal{A})$. The rank function on $L(\mathcal{A})$ is given by $\text{rank}(X) = \text{codim } X$ for $X \in L(\mathcal{A})$ and we define $L(\mathcal{A})_k = \{X \in L(\mathcal{A}) \mid \text{rank}(X) = k\}$.

Let $S = S[V] \cong \mathbb{K}[x_1, \dots, x_\ell]$ be the coordinate ring of the ambient space with its usual grading by polynomial degree: $S = \bigoplus_{p \in \mathbb{Z}} S_p$, where S_p is the \mathbb{K} -subspace of polynomials of degree p and $S_p = 0$ in case $p < 0$.

A *multiarrangement* is a pair (\mathcal{A}, μ) consisting of a hyperplane arrangement \mathcal{A} and a *multiplicity function* $\mu : \mathcal{A} \rightarrow \mathbb{Z}_{\geq 0}$ associating to each hyperplane H in \mathcal{A} a non-negative integer $\mu(H)$. The *order* of the multiarrangement (\mathcal{A}, μ) is defined by $|\mu| := \sum_{H \in \mathcal{A}} \mu(H)$. For a multiarrangement (\mathcal{A}, μ) , the underlying arrangement \mathcal{A} is sometimes called the associated

simple arrangement, and so (\mathcal{A}, μ) itself is simple if and only if $\mu(H) = 1$ for each $H \in \mathcal{A}$. We sometimes denote this simple multiplicity by $\mu = \mathbb{1}$. For two multiplicities μ, μ' on an arrangement \mathcal{A} we sometimes write $\mu \geq \mu'$ if $\mu(H) \geq \mu'(H)$ for all $H \in \mathcal{A}$.

Let (\mathcal{A}, μ) be a multiarrangement in V and let $X \in L(\mathcal{A})$. The *localization of (\mathcal{A}, μ) at X* is defined to be (\mathcal{A}_X, μ_X) , where $\mu_X = \mu|_{\mathcal{A}_X}$.

The *defining polynomial* $Q(\mathcal{A}, \mu)$ of the multiarrangement (\mathcal{A}, μ) is given by

$$Q(\mathcal{A}, \mu) := \prod_{H \in \mathcal{A}} \alpha_H^{\mu(H)},$$

a polynomial of degree $|\mu|$ in S .

The *module of \mathcal{A} -derivations* of (\mathcal{A}, μ) is defined as

$$D(\mathcal{A}, \mu) := \{\theta \in \text{Der}(S) \mid \theta(\alpha_H) \in \alpha_H^{\mu(H)} S \text{ for each } H \in \mathcal{A}\}.$$

We say that (\mathcal{A}, μ) is *free* if $D(\mathcal{A}, \mu)$ is a free S -module – a notion introduced by G. Ziegler [Z89, Def. 6], extending K. Saito's [S80] and H. Terao's [T80a] freeness for simple arrangements.

The derivation module $D(\mathcal{A}, \mu)$ is a \mathbb{Z} -graded S -module and thus, if (\mathcal{A}, μ) is free, there is a homogeneous basis $\theta_1, \dots, \theta_\ell$ of $D(\mathcal{A}, \mu)$. The multiset of the unique polynomial degrees $\text{pdeg } \theta_i$ forms the set of *exponents* of the free multiarrangement (\mathcal{A}, μ) and is denoted by $\text{exp}(\mathcal{A}, \mu)$. Freeness is a local property for multiarrangements.

Theorem 2.1 ([ANN09, Prop. 1.7]). *For $U \subseteq V$ a subspace, the localization (\mathcal{A}_U, μ_U) at U is free provided (\mathcal{A}, μ) is free.*

Let \mathcal{A} be an arrangement and $H \in \mathcal{A}$. Define a multiplicity κ on \mathcal{A}^H by

$$\kappa(X) = |\mathcal{A}_X| - 1, \quad X \in \mathcal{A}^H$$

and call the pair (\mathcal{A}^H, κ) the *Ziegler-restriction* of \mathcal{A} to H . Ziegler showed the following connection between the freeness of \mathcal{A} and the freeness of any of its Ziegler-restrictions.

Theorem 2.2 ([Z89, Thm. 11]). *Suppose \mathcal{A} is free with exponents $(1, e_2, \dots, e_n)$. Let H be a hyperplane in \mathcal{A} , then (\mathcal{A}^H, κ) is free with exponents (e_2, \dots, e_n) .*

Ziegler also generalizes Saito's criterion to the multiarrangement case.

Theorem 2.3 ([Z89, Thm. 8], Saito's criterion). *Let (\mathcal{A}, μ) be a multiarrangement in \mathbb{K}^n and for each $1 \leq i \leq n$ let*

$$\theta_i = \sum_{j=1}^n p_{ij} \frac{\partial}{\partial x_j} \in D(\mathcal{A}, \mu).$$

Then $\{\theta_1, \theta_2, \dots, \theta_n\}$ is a basis for $D(\mathcal{A}, \mu)$ if and only if $\det(p_{ij}) = c \cdot Q(\mathcal{A}, \mu)$ for some $c \in \mathbb{K} \setminus \{0\}$.

An arrangement \mathcal{A} is called *locally free along H* for some $H \in \mathcal{A}$, if \mathcal{A}_x is a free arrangement for all $x \in H \setminus \{0\}$. The following result is due to Yoshinaga.

Theorem 2.4 ([Y04, Thm. 2.2]). *Suppose $\ell \geq 3$. Then \mathcal{A} is free with exponents $(1, e_1, \dots, e_\ell)$ if and only if it is locally free along H for some $H \in \mathcal{A}$ and (\mathcal{A}^H, κ) is free with exponents (e_1, \dots, e_ℓ) .*

Theorem 2.4 readily implies the following.

Corollary 2.5. *Suppose $\ell \geq 3$. Let \mathcal{A} be locally free along $H \in \mathcal{A}$. If \mathcal{A}_X fails to be free for some $X \in L(\mathcal{A})$ with $X \not\subset H$, then (\mathcal{A}^H, κ) is not free.*

Proof. Suppose (\mathcal{A}^H, κ) is free. Then so is \mathcal{A} , by Theorem 2.4, and so is \mathcal{A}_X for any $X \in L(\mathcal{A})$, by Theorem 2.1 (with simple multiplicities), a contradiction. \square

Recall that an ℓ -arrangement \mathcal{A} with $\text{rank}(\mathcal{A}) = r$ is called *generic* if $|\mathcal{A}_X| = k$ for all $X \in L(\mathcal{A})_k$ and $1 \leq k \leq r - 1$. An arrangement \mathcal{A} is called *totally non-free* if (\mathcal{A}, μ) fails to be free for any multiplicity $\mu \geq \mathbb{1}$. The following result states that generic arrangements are totally non-free.

Theorem 2.6 ([Y09, Prop. 4.1]). *Let \mathcal{A} be a generic arrangement in V with $\ell = \dim V \geq 3$. If $|\mathcal{A}| > \ell$, then (\mathcal{A}, μ) is totally non-free.*

The following construction from [ATW08] leads to an extension of Terao's seminal Addition-Deletion Theorem [T80a] for free simple arrangements to multiarrangements.

Definition 2.7. Let $(\mathcal{A}, \mu) \neq \Phi_\ell$ be a multiarrangement. Fix $H_0 = \ker(\alpha_0)$ in \mathcal{A} . We define the *deletion* (\mathcal{A}', μ') and *restriction* (\mathcal{A}'', μ^*) of (\mathcal{A}, μ) with respect to H_0 as follows. If $\mu(H_0) = 1$, then set $\mathcal{A}' = \mathcal{A} \setminus \{H_0\}$ and define $\mu'(H) = \mu(H)$ for all $H \in \mathcal{A}'$. If $\mu(H_0) > 1$, then set $\mathcal{A}' = \mathcal{A}$ and define $\mu'(H_0) = \mu(H_0) - 1$ and $\mu'(H) = \mu(H)$ for all $H \neq H_0$.

Let $\mathcal{A}'' = \{H \cap H_0 \mid H \in \mathcal{A} \setminus \{H_0\}\}$. The *Euler multiplicity* μ^* of \mathcal{A}'' is defined as follows. Let $Y \in \mathcal{A}''$. Since the localization \mathcal{A}_Y is of rank 2, the multiarrangement (\mathcal{A}_Y, μ_Y) is free, [Z89, Cor. 7]. According to [ATW08, Prop. 2.1], the module of derivations $D(\mathcal{A}_Y, \mu_Y)$ admits a particular homogeneous basis $\{\theta_Y, \psi_Y, D_3, \dots, D_\ell\}$, such that $\theta_Y \notin \alpha_0 \text{Der}(S)$ and $\psi_Y \in \alpha_0 \text{Der}(S)$, where $H_0 = \ker \alpha_0$. Then on Y the Euler multiplicity μ^* is defined to be $\mu^*(Y) = \text{pdeg } \theta_Y$.

Often, (\mathcal{A}, μ) , (\mathcal{A}', μ') and (\mathcal{A}'', μ^*) is referred to as the *triple* of (\mathcal{A}, μ) with respect to H_0 .

The following observation is immediate from Definition 2.7.

Remark 2.8. Let (\mathcal{A}, μ) be a multiarrangement and $H_0 \in \mathcal{A}$ and let (\mathcal{A}'', μ^*) be the Euler multiplicity corresponding to H_0 . For $X \in \mathcal{A}''$ the value $\mu^*(X)$ is simply the common value of the non-zero exponent of (\mathcal{A}_X, μ_X) and (\mathcal{A}'_X, μ'_X) .

It is useful to be able to determine the Euler multiplicity explicitly in some relevant instances. For that purpose, we recall parts of [ATW08, Prop. 4.1].

Proposition 2.9. *Let (\mathcal{A}, μ) be a multiarrangement. Let $X \in \mathcal{A}^{H_0}$, $m_0 = \mu(H_0)$, $k = |\mathcal{A}_X|$, and $m_1 = \max\{\mu(H) \mid H \in \mathcal{A}_X \setminus \{H_0\}\}$.*

- (i) *If $k = 2$, then $\mu^*(X) = m_1$.*
- (ii) *If $|\mu_X| \leq 2k - 1$ and $m_0 > 1$, then $\mu^*(X) = k - 1$.*
- (iii) *If $\mu_X \equiv 2$, then $\mu^*(X) = k$.*

We can now state the general Addition-Deletion Theorem for free multiarrangements.

Theorem 2.10 ([ATW08, Thm. 0.8] Addition-Deletion Theorem for Multiarrangements). *Suppose that $(\mathcal{A}, \mu) \neq \Phi_\ell$. Fix H_0 in \mathcal{A} and let (\mathcal{A}, μ) , (\mathcal{A}', μ') and (\mathcal{A}'', μ^*) be the triple with respect to H_0 . Then any two of the following statements imply the third:*

- (i) *(\mathcal{A}, μ) is free with $\exp(\mathcal{A}, \mu) = (b_1, \dots, b_{\ell-1}, b_\ell)$;*
- (ii) *(\mathcal{A}', μ') is free with $\exp(\mathcal{A}', \mu') = (b_1, \dots, b_{\ell-1}, b_\ell - 1)$;*
- (iii) *(\mathcal{A}'', μ^*) is free with $\exp(\mathcal{A}'', \mu^*) = (b_1, \dots, b_{\ell-1})$.*

Remark 2.11. If we restrict to simple multiplicities, Theorem 2.10 recovers Terao's original Addition-Deletion Theorem from [T80a]. As in the simple case if (\mathcal{A}, μ) and (\mathcal{A}', μ') are free, then all three statements of Theorem 2.10 hold (see [ATW08, Thm. 0.4]).

Analogous to the simple case, Theorem 2.10 motivates the notion of inductive freeness.

Definition 2.12 ([ATW08, Def. 0.9]). The class \mathcal{IFM} of *inductively free* multiarrangements is the smallest class of multiarrangements subject to

- (i) $\Phi_\ell \in \mathcal{IFM}$ for each $\ell \geq 0$;
- (ii) for a multiarrangement (\mathcal{A}, μ) , if there exists a hyperplane $H_0 \in \mathcal{A}$ such that both (\mathcal{A}', μ') and (\mathcal{A}'', μ^*) belong to \mathcal{IFM} , and $\exp(\mathcal{A}'', \mu^*) \subseteq \exp(\mathcal{A}', \mu')$, then (\mathcal{A}, μ) also belongs to \mathcal{IFM} .

Similarly, we also have the notion of recursive freeness for multiarrangements.

Definition 2.13 ([HRS17, Def. 2.21]). The class \mathcal{RFM} of *recursively free* multiarrangements is the smallest class of multiarrangements subject to

- (i) $\Phi_\ell \in \mathcal{RFM}$ for each $\ell \geq 0$;
- (ii) for a multiarrangement (\mathcal{A}, μ) , if there exists a hyperplane $H_0 \in \mathcal{A}$ such that both (\mathcal{A}', μ') and (\mathcal{A}'', μ^*) belong to \mathcal{RFM} , and $\exp(\mathcal{A}'', \mu^*) \subseteq \exp(\mathcal{A}', \mu')$, then (\mathcal{A}, μ) also belongs to \mathcal{RFM} .
- (iii) for a multiarrangement (\mathcal{A}, μ) , if there exists a hyperplane $H_0 \in \mathcal{A}$ such that both (\mathcal{A}, μ) and (\mathcal{A}'', μ^*) belong to \mathcal{RFM} , and $\exp(\mathcal{A}'', \mu^*) \subseteq \exp(\mathcal{A}, \mu)$, then (\mathcal{A}', μ') also belongs to \mathcal{RFM} .

Moreover, we consider the following weaker notion.

Definition 2.14 ([HR24, Def. 3.3]). The multiarrangement (\mathcal{A}, μ) is said to be *additively free* if there is a free filtration of multiplicities μ_i on \mathcal{A} ,

$$\mu_0 < \mu_1 < \cdots < \mu_n = \mu,$$

i.e., where each (\mathcal{A}, μ_i) is free with $|\mu_i| = i$. Denote this class by \mathcal{AFM} . In particular, $(\mathcal{A}, \mu_0) = \Phi_\ell$.

Remark 2.15. As for simple arrangements, if $r(\mathcal{A}) \leq 2$, then (\mathcal{A}, μ) is inductively free, [Z89, Cor. 7]. Also, $\mathcal{IFM} \subseteq \mathcal{RFM}$ and $\mathcal{IFM} \subseteq \mathcal{AFM}$ and all inclusions are strict.

By Remark 2.11, restricting to the subclasses of simple arrangements within the above defined classes, we recover the classes of inductively free \mathcal{IF} (cf. [OT92, Def. 4.53]), additively free \mathcal{AF} (cf. [A19, Def. 1.6]), and recursively free \mathcal{RF} (cf. [OT92, Def. 4.60]) simple arrangements.

In general, it is a hard problem to compute the exponents of a free multiarrangement even in the rank 2 case. We require the following result by Wakamiko.

Theorem 2.16 ([W07, Thm. 1.5]). *Let $\mathcal{A} = \{H_1, H_2, H_3\}$ be a 2-arrangement of three lines, μ a multiplicity on \mathcal{A} with $\mu(H_i) = k_i$, ($i = 1, 2, 3$) and $\exp(\mathcal{A}, \mu) = (d_1, d_2)$. Assume that $k_3 \geq \max\{k_1, k_2\}$ and let $k = k_1 + k_2 + k_3$.*

(i) *If $k_3 < k_1 + k_2 - 1$, then*

$$|d_1 - d_2| = \begin{cases} 0 & \text{if } k \text{ is even,} \\ 1 & \text{if } k \text{ is odd.} \end{cases}$$

(ii) *If $k_3 \geq k_1 + k_2 - 1$, then $\exp(\mathcal{A}, \mu) = (k_1 + k_2, k_3)$.*

2.2. Connected subgraph arrangements. We summarize the important definitions and results from [CK24]. We start by recalling the definition of a connected subgraph arrangement. In [CK24] the authors introduced this concept for an arbitrary underlying field. Here we restrict ourselves to arrangements over \mathbb{Q} .

Definition 2.17 ([CK24, Def. 1.1]). Let $G = (N, E)$ be an undirected (simple) graph with vertex set $N = [n] = \{1, \dots, n\}$ and edges E . We define the *connected subgraph arrangement* \mathcal{A}_G in \mathbb{Q}^n as

$$\mathcal{A}_G := \{H_I \mid \emptyset \neq I \subseteq N \text{ if } G[I] \text{ is connected}\},$$

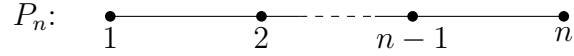
where H_I is the hyperplane

$$H_I = \ker \sum_{i \in I} x_i$$

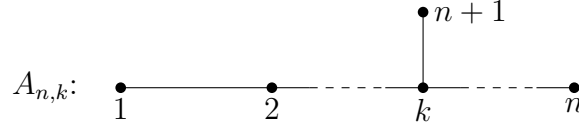
and $G[I]$ is the induced subgraph on the vertices $I \subseteq N$.

By this definition, all defining linear forms of a connected subgraph arrangement are 0/1-vectors. The following families of graphs play a central role in the investigation of free simple connected subgraph arrangements. They are equally crucial for our study.

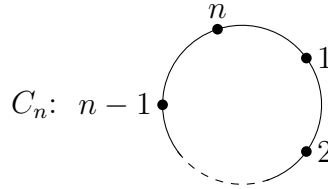
Definition 2.18 ([CK24]). • The *path-graph* P_n on n vertices.



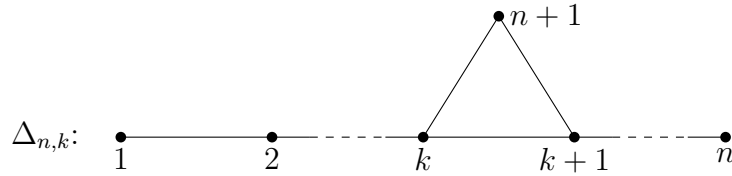
- The *almost-path-graph* $A_{n,k}$ on $n + 1$ vertices, where $1 \leq k \leq n$. Draw a path-graph on n vertices, add an additional vertex $n + 1$, and connect the vertices k and $n + 1$ by an edge.



- The *cycle-graph* C_n on n vertices. Draw n vertices and connect vertex 1 and 2, 2 and 3, ..., n and 1.



- The *path-with-triangle-graph* $\Delta_{n,k}$, where $1 \leq k \leq n - 1$. Draw a path-graph on n vertices, add an additional vertex $n + 1$, and connect the vertices k and $n + 1$ by an edge as well as the vertices $k + 1$ and $n + 1$.



In [Y09], M. Yoshinaga investigated the freeness question of multiplicities for a certain class of arrangements. His setting turns out to be important for our study as well.

Definition 2.19 ([Y09, Def. 2.1]). Let \mathcal{A} be a hyperplane arrangement.

- We call \mathcal{A} *locally* A_2 , if $|\mathcal{A}_X| \leq 3$ for all $X \in L(\mathcal{A})_2$.
- Fix a reduced system of defining forms $\Phi \subseteq V^*$ for \mathcal{A} , i.e., $\mathcal{A} = \{\ker(\alpha) \mid \alpha \in \Phi\}$ and $|\Phi| = |\mathcal{A}|$. Then Φ is called a *positive system* for the locally A_2 arrangement \mathcal{A} provided for each rank 2 localization with three elements $\mathcal{A}_X = \{\ker(\alpha), \ker(\beta), \ker(\gamma)\}$ ($\alpha, \beta, \gamma \in \Phi$) one of $\alpha = \beta + \gamma$, $\beta = \alpha + \gamma$, $\gamma = \alpha + \beta$ holds.

Connected subgraph arrangements are locally A_2 and have positive systems.

Lemma 2.20 ([CK24, Lem. 2.10]). *For pairwise distinct nonempty subsets $A_1, A_2, A_3 \subseteq [n]$ and $n \geq 1$ the following two conditions are equivalent:*

- (i) $\text{rank}(H_{A_1} \cap H_{A_2} \cap H_{A_3}) = 2$ and
- (ii) $A_{i_1} \dot{\cup} A_{i_2} = A_{i_3}$ for some choice of pairwise distinct indices $1 \leq i_1, i_2, i_3 \leq 3$ where $\dot{\cup}$ denotes a disjoint set union.

Definition 2.21. Let $G = (N, E)$ be a Graph and $e = \{i, j\} \in E$ an edge. We denote by G/e the graph with contracted edge e , i.e. the graph in which the vertices i, j are identified to one vertex k , each edge to i or j becomes an edge to k , and multiple edges and loops are removed. For $S \subseteq N$ the *induced subgraph* of G on S we denote by $G[S] = (S, E \cap \binom{S}{2})$.

We have the following link between these operations and localizations of \mathcal{A}_G .

Lemma 2.22 ([CK24, Lem. 6.2, Lem. 6.4]). *Let $G = (N, E)$ be a graph. Then*

- (i) for $S \subseteq N$ we have $\mathcal{A}_{G[S]} = (\mathcal{A}_G)_X$ for some $X \in L(\mathcal{A}_G)$, and
- (ii) for $e \in E$, $\mathcal{A}_{G/e} = (\mathcal{A}_G)_X$ for some $X \in L(\mathcal{A}_G)$.

In particular, if P is a local arrangement property satisfied by \mathcal{A}_G , then both $\mathcal{A}_{G[S]}$ and $\mathcal{A}_{G/e}$ satisfy P as well.

Cuntz and Kühne classified all graphs G such that \mathcal{A}_G is a free arrangement. It turns out that \mathcal{A}_G is free if and only if G belongs to one of the four families of graphs introduced in Definition 2.18.

Theorem 2.23 ([CK24, Thm. 1.6]). *Let G be a connected graph. The connected subgraph arrangement \mathcal{A}_G is free if and only if G is a path-graph, a cycle-graph, an almost-path-graph, or a path-with-triangle-graph.*

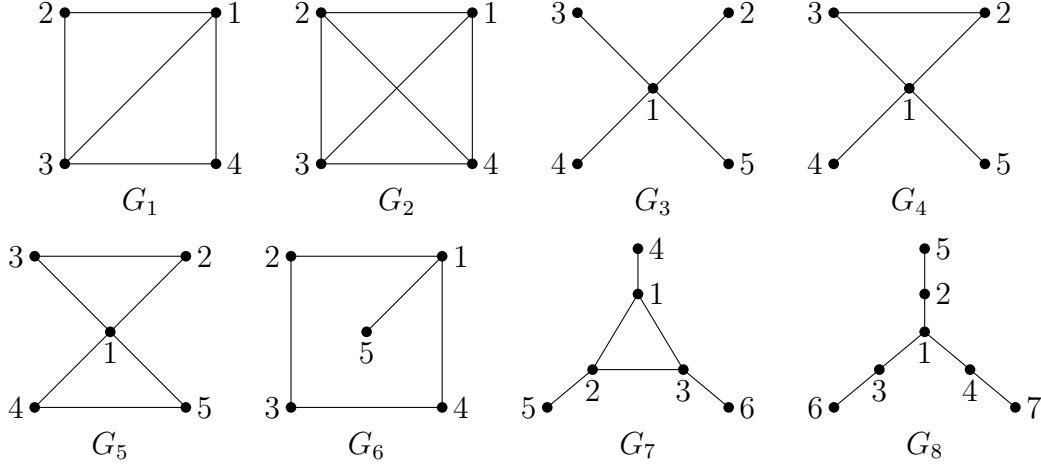


FIGURE 1. The graphs G_1 up to G_8

In their proof, Cuntz and Kühne show that every graph that is not part of one of the four families from Definition 2.18 can get modified using iterations of the constructions from Definition 2.21 until we end up with one of the graphs depicted in Figure 1. Note that G_2 is more commonly known as K_4 . Since the connected subgraph arrangements stemming from those eight graphs are not free and freeness is a local property by Theorem 2.1, Lemma 2.22 finishes the proof.

Our aim in this note is to look at these classes within the framework of multiarrangements and to extend this classification.

2.3. Extensions of a multiarrangement. The following definitions and results are due to Yoshinaga [Y09].

Definition 2.24. Let (\mathcal{A}, μ) be a multiarrangement in \mathbb{C}^ℓ .

(i) (\mathcal{A}, μ) is *extendable* if it can be obtained as a Ziegler-restriction of a free arrangement in $\mathbb{C}^{\ell+1}$.

(ii) Define an extension in $\mathbb{C}^{\ell+1}$ with $(x_1, x_2, \dots, x_\ell, x_{\ell+1})$ as a coordinate system by

$$\mathcal{E}(\mathcal{A}, \mu) = \{\ker(x_{\ell+1})\} \cup \left\{ \ker(\alpha_H - kx_{\ell+1}) \mid k \in \mathbb{Z}, -\frac{\mu(H) - 1}{2} \leq k \leq \frac{\mu(H)}{2}, H \in \mathcal{A} \right\}.$$

Note that $(\mathcal{E}(\mathcal{A}, \mu)^{\ker(x_{\ell+1})}, \kappa) = (\mathcal{A}, \mu)$.

One of the main results in [Y09] is the following.

Theorem 2.25 ([Y09, Thm. 2.5]). *Let \mathcal{A} be a locally A_2 arrangement with a positive system in $V = \mathbb{C}^\ell$. We fix a positive system $\Phi^+ = \{\alpha_H \mid H \in \mathcal{A}\} \subset V^*$ of defining equations. Let $\mu : \mathcal{A} \rightarrow \mathbb{Z}_{\geq 0}$ be a multiplicity. Assume the following condition:*

$$(2.26) \quad \text{Let } \mathcal{A}_X = \{H_i, H_j, H_k\} \text{ be a codimension two localization with } \alpha_i = \alpha_j + \alpha_k. \\ \text{If } \mu(H_i) \text{ is odd, then at least one of } \mu(H_j) \text{ or } \mu(H_k) \text{ is odd.}$$

Then (\mathcal{A}, μ) is free, if and only if it is extendable. Indeed, $\mathcal{E}(\mathcal{A}, \mu)$ is a free arrangement.

2.4. Locally and globally mixed products. In [ATW08], a very useful tool is introduced to determine whether a given multiarrangement (\mathcal{A}, μ) fails to be free.

Definition 2.27. Let (\mathcal{A}, μ) be a multiarrangement in \mathbb{C}^ℓ . Let $0 \leq k \leq \ell$.

- (i) If the localization (\mathcal{A}_X, μ_X) is free with exponents $\exp(\mathcal{A}_X, \mu_X) = (d_1^X, d_2^X, \dots, d_k^X)$ for each $X \in L_k$, then define the *k-th local mixed product* by

$$\text{LMP}(k) = \sum_{X \in L_k} d_1^X d_2^X \cdots d_k^X.$$

- (ii) If (\mathcal{A}, μ) is free with exponents $\exp(\mathcal{A}, \mu) = (d_1, \dots, d_\ell)$, define the *k-th global mixed product* by

$$\text{GMP}(k) = \sum d_{i_1} d_{i_2} \cdots d_{i_k},$$

where the sum is taken over all k -tuples from $\exp(\mathcal{A}, \mu)$ with $1 \leq i_1 < \cdots < i_k \leq \ell$.

Thanks to Remark 2.15, $\text{LMP}(2)$ is always defined. These invariants are rather useful for proving the non-freeness of a given multiarrangement due to the following result.

Theorem 2.28 ([ATW07, Cor. 4.6]). *If (\mathcal{A}, μ) is free with $\exp(\mathcal{A}, \mu) = (d_1, \dots, d_\ell)$ then for every $0 \leq k \leq \ell$, we have*

$$\text{GMP}(k) = \text{LMP}(k).$$

Definition 2.29. For $1 \leq i \leq \ell$, let $d_i \in \mathbb{N}$. We use the shorthand $(d_1, \dots, d_\ell)_\leq \in \mathbb{N}^\ell$ to mean $d_1 \leq d_2 \leq \dots \leq d_\ell$. Then for the latter define the *k-th global mixed product* by

$$\text{GMP}(k) := \sum d_{i_1} d_{i_2} \cdots d_{i_k},$$

where the sum is taken over all k -tuples from $(d_1, \dots, d_\ell)_\leq$ with $1 \leq i_1 < \cdots < i_k \leq \ell$.

Remark 2.30. Following [ATW07], given two ordered sequences of non-negative integers $(d_1, d_2, \dots, d_\ell)_\leq$ and $(e_1, e_2, \dots, e_\ell)_\leq$ as above satisfying $\sum d_i = \sum e_i$, we call $(d_1, d_2, \dots, d_\ell)_\leq$ *more balanced* than $(e_1, e_2, \dots, e_\ell)_\leq$ if $d_\ell - d_1 < e_\ell - e_1$. It follows from [ATW07, p.836] that if $(d_1, d_2, \dots, d_\ell)_\leq$ is more balanced than $(e_1, e_2, \dots, e_\ell)_\leq$, then $\text{GMP}(k)$ is larger for $(d_1, d_2, \dots, d_\ell)_\leq$ than for $(e_1, e_2, \dots, e_\ell)_\leq$.

Example 2.31. With notation as in Definition 2.29 let $S_1 = (4, 4, 4, 4)_\leq$ and $S_2 = (2, 4, 5, 5)_\leq$. Then S_1 is more balanced than S_2 since $4 - 4 < 5 - 2$. Among all tuples $(d_1, d_2, d_3, d_4)_\leq$ with $\sum d_i = 16$, we see that S_1 is *most balanced*.

The following is immediate from Theorem 2.28 and Remark 2.30.

Lemma 2.32. *Let \mathcal{A} be a simple arrangement in \mathbb{K}^ℓ .*

- (i) *Let μ be a multiplicity on \mathcal{A} and let $(e_1, e_2, \dots, e_\ell)_\leq$ be the unique most balanced sequence of integers with sum equal to $|\mu|$. If $\text{GMP}(2)$ for $(e_1, \dots, e_\ell)_\leq$ is smaller than $\text{LMP}(2)$ for (\mathcal{A}, μ) , then (\mathcal{A}, μ) is not free.*

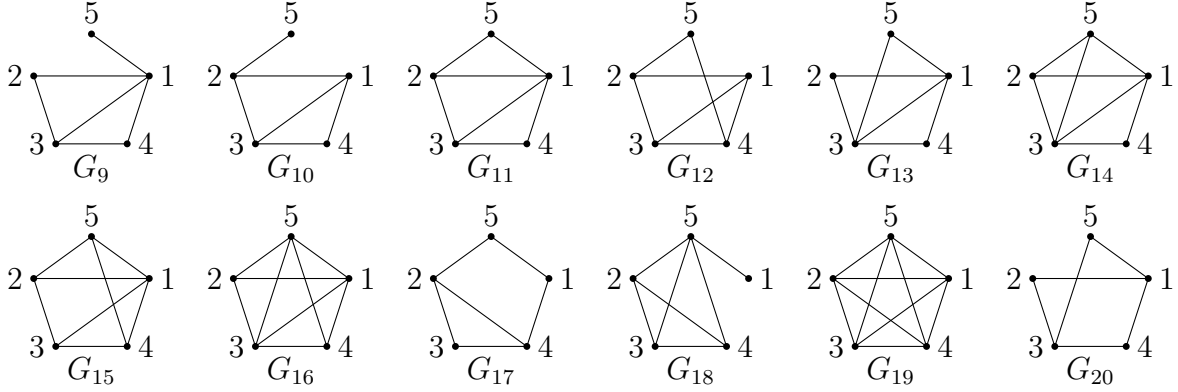


FIGURE 2. Graphs G_9 to G_{20}

- (ii) If \mathcal{A} is free, then $1 \in \exp(\mathcal{A})$. Let $(e_2, \dots, e_\ell)_\leq$ be the unique most balanced sequence of integers with sum equal to $|\mathcal{A}| - 1$. If $\text{GMP}(2)$ for $(1, e_2, \dots, e_\ell)_\leq$ is smaller than $\text{LMP}(2)$ for \mathcal{A} , then \mathcal{A} is not free.

3. FREE CONNECTED SUBGRAPH MULTIARRANGEMENTS

The goal of this section is a generalization of Theorem 2.23, where we give a list of all graphs G for which there exists a multiplicity $\mu : \mathcal{A} \rightarrow \mathbb{Z}_{>0}$ such that (\mathcal{A}, μ) is free. As mentioned before, Cuntz and Kühne derive Theorem 2.23 by showing that any graph not listed in Definition 2.18 can get manipulated by graph contractions from Definition 2.21 such that the resulting graph possesses an induced subgraph that affords a non-free arrangement. Unexpectedly, it turns out that free multiplicities do exist for \mathcal{A}_{G_1} and \mathcal{A}_{G_2} . Thus, in order to follow a similar line of argument, as the one above, we need to expand the list of graphs we have to consider which are shown in Figure 2.

We begin with the following observation.

Proposition 3.1. *Let G be one of the graphs G_3 to G_{20} listed in Figures 1 and 2, then the corresponding connected subgraph arrangement \mathcal{A}_G is totally non-free.*

Proof. Let G be one of the graphs G_3 to G_{20} listed in Figures 1 and 2. For each such G we present an element $X \in L(\mathcal{A}_G)$ in Table 1 such that the corresponding localization $(\mathcal{A}_G)_X$ is a generic arrangement with $\text{rank}(\mathcal{A}_G)_X < |(\mathcal{A}_G)_X|$. By Theorems 2.1 and 2.6 we can conclude that \mathcal{A}_G is totally non-free. \square

Corollary 3.2. *Let G be a graph that has G_3 as a subgraph. Then \mathcal{A}_G is totally non-free.*

Proof. Let v_1, v_2, v_3, v_4, v_5 be the vertices of G included in the subgraph forming G_3 . The induced subgraph of G on $\{v_1, v_2, v_3, v_4, v_5\}$ is isomorphic to $G_3, G_4, G_5, G_9, G_{11}, G_{13}, G_{14}, G_{15}, G_{16}, G_{18}$ or G_{19} . Thus, by Proposition 3.1, the arrangement of this induced subgraph is totally non-free. It then follows from Lemma 2.22 and Theorem 2.1 that \mathcal{A}_G is totally non-free as well. \square

We are now able to address the main result of this section.

Theorem 3.3. *Let G be a connected graph on at least 5 vertices. Then there exists a multiplicity $\mu \geq 1$ such that the connected subgraph multiarrangement (\mathcal{A}_G, μ) is free if and only if G is a path-graph, a cycle-graph, an almost-path-graph, or a path-with-triangle-graph. In particular, all other connected graphs with at least 5 vertices yield totally non-free connected subgraph arrangements.*

Proof. By Theorem 2.23, $(\mathcal{A}_G, 1)$ is free for any graph in the list above.

Conversely, assume that we have a graph $G = (E, V)$ and a multiplicity $\mu \geq 1$ on \mathcal{A}_G such that (\mathcal{A}_G, μ) is free.

1. Assume a vertex of G has at least 4 neighbors.

Then G_3 is a subgraph of G and \mathcal{A}_G is totally non-free, by Corollary 3.2. This implies that all the vertices of G have degree at most 3.

2. Assume that G has at least 2 cycles of length at least 3 that share an edge. Since we assume that $|V| \geq 5$, the graph cannot be equal to G_1 or G_2 . Let C_1, C_2 be cycles of G with a shared edge (v_1, v_2) , choose $w_1 \in C_1, w_2 \in C_2$ such that $w_1 \notin C_2, w_2 \notin C_1$. Assume first that both cycles have length 3. In this case the induced graph on $\{v_1, v_2, w_1, w_2\}$ is of type G_1 or G_2 . Since $|V| \geq 5$ and G is connected there exists a vertex v that is a neighbor of at least one element of $\{v_1, v_2, w_1, w_2\}$, while not belonging to either C_1 or C_2 . Taking the induced subgraph on $\{v_1, v_2, w_1, w_2, v\}$ yields one of G_9 up to G_{19} . So \mathcal{A}_G is again totally non-free,

thanks to Proposition 3.1. Assume that at least C_1 is of length greater than 3. Choose v_1, v_2, w_1, w_2 as in the first part above and an additional $w_3 \in C_1$ and take the induced subgraph on $\{v_1, v_2, w_1, w_2, w_3\}$. Now contract each edge at least one vertex of which is not in $\{v_1, v_2, w_1, w_2, w_3\}$. We now arrive at one of $G_{11}, G_{12}, G_{14}, G_{15}, G_{16}, G_{17}, G_{19}, G_{20}$. So \mathcal{A}_G is totally non-free, again by Proposition 3.1.

3. Assume that G has at least 2 cycles of length at least 3 without any shared edge. In this case we contract edges until we end up with G_3 as subgraph and use Corollary 3.2.

4. Assume G has exactly one cycle C of length at least 4. Note that we cannot have two vertices $v_1, v_2 \in C$ being connected by an edge e not belonging to C , since otherwise we could decompose C into two cycles C_1, C_2 of length at least 3 with shared edge e , which was already excluded in case 2. If G is not a cycle graph, then we can choose a vertex v such that it is the neighbor of a vertex in C . After contracting edges of C until we arrive at C_4 and taking the subgraph induced by the reduced cycle and v , we get one of $G_6, G_{12}, G_{15}, G_{17}, G_{20}$. So \mathcal{A}_G it is totally non-free, again thanks to Proposition 3.1.

5. Assume G has exactly one cycle of length 3. Let v_1, v_2, v_3 be the unique cycle in G . Assume that all vertices v_1, v_2, v_3 are of degree 3. Taking the subgraph induced by $\{v_1, v_2, v_3\}$ together with their respective third neighbors yields the graph G_7 , since all neighbors are distinct ((v_1, v_2, v_3) is the only cycle in G). Using Proposition 3.1, we see that \mathcal{A}_{G_7} is totally non-free, so we can assume that the vertex v_3 has degree 2. If G had a vertex v of degree 3 different from v_1 and v_2 , then contracting all edges between v and v_1 (or v and v_2 , we choose whatever vertex can be reached first by following the unique path) results in a graph with a vertex of degree at least 4. This is a contradiction as seen in case 1. Therefore, all other vertices are of degree at most 2 and as v_1, v_2, v_3 constitute its only cycle, G must be a path-with-triangle-graph.

6. Assume that G is a tree. If there are two vertices of degree 3, then we contract edges until it becomes a vertex of at least degree 4. This connected subgraph arrangement is totally non-free, as seen in case 1. So there is at most one vertex of degree 3. If G it is not a Path-Graph or an Almost-Path-Graph, then it has G_8 as an induced subgraph and the arrangement \mathcal{A}_G is totally non-free, due to Proposition 3.1. \square

The bound in Theorem 3.3 on the number of vertices is necessary since there exist free multiplicities for \mathcal{A}_{G_1} and \mathcal{A}_{G_2} . We present two of them in the following result. We emphasize that the presented multiplicity on \mathcal{A}_{G_2} is recursively free but fails to be additively free. The given multiplicity on \mathcal{A}_{G_1} in turn is inductively free.

Proposition 3.4. *Let $\mathcal{A} \in \{\mathcal{A}_{G_1}, \mathcal{A}_{G_2}\}$. There exists a multiplicity $\mu \neq \mathbb{1}$ such that (\mathcal{A}, μ) is free. In particular, there exists a multiplicity μ such that (\mathcal{A}_{G_2}, μ) is recursively free but not additively free.*

Proof. We fix the following order on the hyperplanes of \mathcal{A}_{G_2} :

$$H_1, H_2, H_3, H_4, H_{1234}, H_{34}, H_{23}, H_{234}, H_{14}, H_{13}, H_{134}, H_{12}, H_{124}, H_{123}, H_{24},$$

and define the multiplicity $\mu_2 = (2, 2, 2, 2, 2, 1, 1, 1, 1, 1, 1, 1, 1, 1)$. Then the multiarrangement $(\mathcal{A}_{G_2}, \mu_2)$ is recursively free but not additively free. It follows from Remark 2.11 that

$(\mathcal{A}_{G_2}, \mu_2)$ fails to be additively free since we have $|((\mathcal{A}_{G_2})^H, (\mu_2)^*)| = 14$ for an arbitrary $H \in \mathcal{A}_{G_2}$.

For \mathcal{A}_{G_1} we drop the last hyperplane H_{24} from the list above, but fix the same order on the rest of the hyperplanes and define $\mu_1 = (2, 2, 2, 1, 2, 1, 1, 1, 2, 1, 1, 1, 1)$. We claim that $(\mathcal{A}_{G_1}, \mu_1)$ is inductively free.

The facts that $(\mathcal{A}_{G_1}, \mu_1)$ is inductively free and $(\mathcal{A}_{G_2}, \mu_2)$ is recursively free follow from the corresponding induction tables, Table 2 and Table 4, respectively. \square

Remark 3.5. We note that \mathcal{A}_{G_2} is the famous counterexample by Edelman and Reiner given in [ER93] to Orlik’s conjecture. In this context \mathcal{A}_{G_2} appears as a non-free restriction of a free arrangement \mathcal{B} . As a multiarrangement $(\mathcal{A}_{G_2}, \mu_2) = (\mathcal{B}'', \kappa)$ is the Ziegler restriction of \mathcal{B} (recall Theorem 2.2). This gives an alternative proof of the freeness of $(\mathcal{A}_{G_2}, \mu_2)$. Note that $\mathcal{A}_{G_2} = \mathcal{A}_{G_1} \cup \{H_{24}\}$. It turns out that starting with the inductively free multiarrangement $(\mathcal{A}_{G_1}, \mu_1)$ and adding H_{24} with multiplicity 1 gives an inductively free multiplicity on \mathcal{A}_{G_2} .

Since every connected graph on four vertices is either $G_1, G_2, P_4, C_4, A_{3,2}$ or $\Delta_{3,1}$ we can combine Theorem 3.3 and Proposition 3.4 to derive the following result.

Corollary 3.6. *Let G be a connected graph. There exists a multiplicity μ such that the connected subgraph multiarrangement (\mathcal{A}_G, μ) is free if and only if G is G_1, G_2 , a path-graph, a cycle-graph, an almost-path-graph, or a path-with-triangle-graph.*

4. CONSTANT MULTIPLICITIES ON CONNECTED SUBGRAPH ARRANGEMENTS

4.1. **Investigating G_1 and G_2 .** The proof in [CK24, §6.2] of the non-freeness of the connected subgraph arrangements stemming from G_1 up to G_8 depends on tedious computer calculations. In this section, we provide a non-computational, conceptual proof giving a complete list of free constant multiplicities on the family of graphs from Theorem 2.23, as well as giving a non-computational proof for the non-freeness of \mathcal{A}_{G_1} and \mathcal{A}_{G_2} in the process. Combined with Proposition 3.1 we obtain a proof for the non-freeness of the simple connected subgraph arrangements stemming from G_1 up to G_{20} free of any machine calculations. We use the following method for calculating $\text{LMP}(2)$ of the connected subgraph arrangements. Then we utilize Lemma 2.32.

Remark 4.1. Algorithm to calculate $\text{LMP}(2)$ for a simple \mathcal{A}_G :

- (1) Determine the number of all types of connected induced subgraphs of G with at least 2 vertices (i.e. path-graph, almost-path-graph, etc.).
- (2) For every subgraph G' from step 1 we determine the number of triples $(G', G[I], G[J])$, where $G[I], G[J]$ are connected induced subgraphs of G' with $V(G[I]) \cup V(G[J]) = V(G')$. Adding up the number of all such triples for all connected induced subgraphs G' from (1) provides an invariant N_1 . Using Lemma 2.20 we see that for a fixed graph G' this is just the number of rank 2 localizations with $V(G') = A_{i_3}$, with the notation as in the lemma.

- (3) Calculate $N_2 := \binom{|\mathcal{A}^G|}{2}$. If all rank 2 localizations were to consist of exactly two elements, then N_2 would be the number of all rank 2 localizations.
- (4) We have $\text{LMP}(2) = N_2 - N_1$. To see this, a rank 2 localization with two elements is free with exponents $(1, 1)$, while a rank 2 localization with three elements is free with exponents $(1, 2)$. So if instead of having three rank 2 localizations with two elements we have one rank 2 localization with three elements, then $\text{LMP}(2)$ gets decreased by 1 (since we assume for N_2 that all localizations contain exactly two elements). Since N_1 is the number of rank 2 localizations with three elements, $N_2 - N_1$ coincides with $\text{LMP}(2)$.

We demonstrate how this algorithm works in the cases where $G \in \{G_1, G_2\}$.

Example 4.2. We begin with $G = G_1$.

- $5 \times P_2, 2 \times P_3, 2 \times C_3, 1 \times G_1$
- $G' = P_2 : 1 \times (P_2, P_1, P_1)$
 $G' = P_3 : 2 \times (P_3, P_2, P_1)$
 $G' = C_3 : 3 \times (C_3, P_2, P_1)$
 $G' = G_1 : 2 \times (G_1, C_3, P_1), 2 \times (G_1, P_3, P_1), 2 \times (G_1, P_2, P_2)$
 $N_1 = 5 \cdot 1 + 2 \cdot 2 + 2 \cdot 3 + 1 \cdot 6 = 21$
- $N_2 = \binom{14}{2} = 91$
- $\text{LMP}(2) = 91 - 21 = 70$

For $G = G_2$ we get the following result.

- $6 \times P_2, 4 \times C_3, 1 \times G_1$
- $G' = P_2 : 1 \times (P_2, P_1, P_1)$
 $G' = C_3 : 3 \times (C_3, P_2, P_1)$
 $G' = G_2 : 4 \times (G_1, C_3, P_1), 3 \times (G_1, P_2, P_2)$
 $N_1 = 6 \cdot 1 + 4 \cdot 3 + 1 \cdot 7 = 25$
- $N_2 = \binom{15}{2} = 105$
- $\text{LMP}(2) = 105 - 25 = 80$

In view of Lemma 2.32, we derive the non-freeness of \mathcal{A}_{G_1} and \mathcal{A}_{G_2} without any machine calculations as follows.

Proposition 4.3. *Let $G \in \{G_1, G_2\}$, then \mathcal{A}_G is not free.*

Proof. Since $|\mathcal{A}_{G_1}| = 14$, a tuple of potential exponents for \mathcal{A}_{G_1} has to be $(1, 4, 4, 5)_\leq$, or less balanced. Calculating $\text{GMP}(2)$ for this sequence gives $\text{GMP}(2) = 69$. Since exponents that are less balanced afford a smaller $\text{GMP}(2)$ and since $\text{LMP}(2) = 70$, we have $\text{LMP}(2) \neq \text{GMP}(2)$ and so \mathcal{A}_{G_1} is not free, by Theorem 2.28.

Since $|\mathcal{A}_{G_1}| = 15$, choose potential balanced exponents $(1, 4, 5, 5)_{\leq}$ for \mathcal{A}_{G_2} to maximize $\text{GMP}(2)$. Using this tuple, we get $\text{GMP}(2) = 79$. Since exponents that are less balanced yield a smaller value for $\text{GMP}(2)$ and since $\text{LMP}(2) = 80$, we have $\text{LMP}(2) \neq \text{GMP}(2)$ and so \mathcal{A}_{G_2} can't be free, thanks to Theorem 2.28. \square

Remark 4.4. Propositions 3.1 and 4.3 combined give a non-computational, conceptual proof for the non-freeness of the simple arrangements \mathcal{A}_{G_i} , for $i \in \{1, 2, \dots, 20\}$.

Next we modify the algorithm from Remark 4.1 to calculate $\text{LMP}(2)$ when \mathcal{A}_G gets equipped with a constant multiplicity $\mu = k\mathbb{1}$ for $k \neq 1$.

Remark 4.5. Algorithm to calculate $\text{LMP}(2)$ for a constant multiplicity $\mu \equiv k$:

- (1) Determine the number of all types of connected induced subgraphs of G with at least 2 vertices (i.e. path-graph, almost-path-graph, etc.).
- (2) For every subgraph G' from step (1) we determine the number of triples $(G', G[I], G[J])$, where $G[I], G[J]$ are connected induced subgraphs of G' with $V(G[I]) \cup V(G[J]) = V(G')$. Let N_1 be the sum of the number of all such triples for all connected induced subgraphs G' from part (1).
- (3) Calculate $N_2 := \binom{|\mathcal{A}_{G'}|}{2}$.
- (4) Since N_1 is the number of rank 2 localizations with three elements, the number of rank 2 localizations with two elements is equal to $N_3 := N_2 - 3N_1$, because if there is one rank 2 localization with three elements, then the hyperplanes of this localization could have potentially formed three rank 2 localizations with two elements.
- (5) Using Theorem 2.16 we derive the exponents of all rank 2 localizations with three elements (which depends on the parity of k), while localizations of rank 2 with two elements are free with exponents (k, k) . We get

$$\text{LMP}(2) = \begin{cases} N_1 \cdot \left(\frac{3k}{2}\right)^2 + N_3 k^2, & \text{(if } k \text{ is even),} \\ N_1 \cdot \left(\frac{3k-1}{2} \cdot \frac{3k+1}{2}\right) + N_3 k^2, & \text{(if } k \text{ is odd).} \end{cases}$$

We now use Lemma 2.32 to extend Proposition 4.3 to arbitrary constant multiplicities.

Proposition 4.6. For $G \in \{G_1, G_2\}$ and $\mu \equiv k \geq 1$ a constant multiplicity on \mathcal{A}_G , (\mathcal{A}_G, μ) is not free.

Proof. The case $k = 1$ is Proposition 4.3. So let $k \geq 2$. From the calculation in the example we know that: $G_1 : N_1 = 21, N_2 = 91$ and $G_2 : N_1 = 25, N_2 = 105$, which gives $N_3 = 28$ for G_1 and $N_3 = 30$ for G_2 . So for G_1 we get

$$\text{LMP}(2) = \begin{cases} 21 \cdot \left(\frac{3k}{2}\right)^2 + 28k^2 = 75.25k^2, & \text{if } k \text{ is even.} \\ 21 \cdot \left(\frac{3k-1}{2} \cdot \frac{3k+1}{2}\right) + 28k^2 = 75.25k^2 - 5.25, & \text{if } k \text{ is odd,} \end{cases}$$

and for G_2 we get

$$\text{LMP}(2) = \begin{cases} 25 \cdot \left(\frac{3k}{2}\right)^2 + 30k^2 = 86.25k^2, & \text{if } k \text{ is even.} \\ 25 \cdot \left(\frac{3k-1}{2} \cdot \frac{3k+1}{2}\right) + 30k^2 = 86.25k^2 - 6.25, & \text{if } k \text{ is odd.} \end{cases}$$

If we assume perfectly balanced exponents for \mathcal{A}_{G_1} (assuming $14k \equiv 0 \pmod{4}$) we get the set of exponents $\left(\frac{14k}{4}, \frac{14k}{4}, \frac{14k}{4}, \frac{14k}{4}\right)_\leq$ which results in $\text{GMP}(2) = 73.5k^2$.

If we assume perfectly balanced exponents for \mathcal{A}_{G_2} (assuming $15k \equiv 0 \pmod{4}$) we get the set of exponents $\left(\frac{15k}{4}, \frac{15k}{4}, \frac{15k}{4}, \frac{15k}{4}\right)_\leq$ which results in $\text{GMP}(2) = 84.375k^2$.

Since $k \geq 2$, in any case, we have $\text{LMP}(2) > \text{GMP}(2)$ and thus (\mathcal{A}_{G_2}, μ) can't be free, by Theorem 2.28. \square

4.2. Constant multiplicities on a free \mathcal{A}_G . In this subsection, we inspect free constant multiplicities on a free \mathcal{A}_G . We give a complete list when (\mathcal{A}_G, μ) is free for $G \in \{P_n, A_{n,k}, \Delta_{n,k}, C_n\}$ and $\mu \equiv k \geq 1$.

First we consider the case $G = P_n$. Terao showed in [T02] that every constant multiplicity on a Coxeter arrangement is free. Since \mathcal{A}_{P_n} is the Coxeter arrangement of type A_n , we derive the freeness of (\mathcal{A}_{P_n}, μ) for $\mu \equiv k \geq 1$.

Now suppose that $G \neq P_n$. We start with $G = C_3$ and follow the idea described in Lemma 2.32 during every proof.

Proposition 4.7. *Let $G = C_3$ and $\mu \equiv k \geq 1$ is a constant multiplicity on \mathcal{A}_G . Then (\mathcal{A}_G, μ) is free if and only if $k \in \{1, 3\}$.*

Proof. For the forward implication, using the algorithm above, we get $N_1 = 1 \cdot 3 + 3 \cdot 1 = 6$, $N_2 = \binom{7}{2} = 21$, $N_3 = 21 - 3 \cdot 6 = 3$. This gives

$$\text{LMP}(2) = \begin{cases} 6 \cdot \left(\frac{3k}{2}\right)^2 + 3k^2 = 16.5k^2 & \text{(if } k \text{ is even), or} \\ 6 \cdot \left(\frac{3k-1}{2} \cdot \frac{3k+1}{2}\right) + 3k^2 = 16.5k^2 - 1.5 & \text{(if } k \text{ is odd).} \end{cases}$$

Assuming balanced exponents we get

$$\text{GMP}(2) = \begin{cases} 16\frac{1}{3}k^2, & \text{if } 7k \equiv 0 \pmod{3} \text{ or} \\ 16\frac{1}{3}k^2 - \frac{1}{3}, & \text{else.} \end{cases}$$

For $k \geq 4$ we get that $\text{LMP}(2) > \text{GMP}(2)$. For $k = 3$ we get equality and for $k = 2$ we get $\text{LMP}(2) = 66$ and depending on whether the assumed exponents are $(3, 5, 6)_\leq$, $(4, 4, 6)_\leq$, or $(4, 5, 5)_\leq$, a value of 63, 64, or 65, respectively for $\text{GMP}(2)$. So if $k \notin \{1, 3\}$ we have $\text{LMP}(2) > \text{GMP}(2)$ and thanks to Theorem 2.28, we deduce non-freeness.

Next we address the reverse implication. The freeness of $(\mathcal{A}_G, \mathbb{1})$ follows from Theorem 2.23. In Table 3, we present an induction table for $(\mathcal{A}_G, 3\mathbb{1})$ showing that the latter is actually inductively free. \square

Proposition 4.8. *Let $G \in \{C_n, \Delta_{n,k}, A_{n,k}\}$. Suppose $\text{rank } \mathcal{A}_G \geq 4$ and $\mu \equiv k \geq 1$ a constant multiplicity on \mathcal{A}_G . Then (\mathcal{A}_G, μ) is free if and only if $k = 1$.*

Proof. First let $G \in \{C_n, \Delta_{n,k}\}$. Since G either has C_3 as an induced subgraph or becomes C_3 after contracting edges, we can use Lemma 2.22 and Proposition 4.7 to focus on the cases where $k \in \{1, 3\}$. If $k = 1$ we know that (\mathcal{A}_G, μ) is free. So let $\mu \equiv 3$ and $G = C_4$. Calculating $\text{LMP}(2)$ we get $N_1 = 1 \cdot (4 + 2) + 4 \cdot 2 + 4 \cdot 1 = 18$, $N_2 = \binom{13}{2} = 78$, $N_3 = 78 - 3 \cdot 18 = 24$ and so

$$\text{LMP}(2) = 18 \cdot \left(\frac{3 \cdot 3 - 1}{2} \cdot \frac{3 \cdot 3 + 1}{2} \right) + 24 \cdot 9 = 576.$$

Since \mathcal{A}_{C_4} consists of 13 hyperplanes, assuming balanced exponents $(9, 10, 10, 10)_{\leq}$, we get $\text{GMP}(2) = 570$. So $\text{LMP}(2) > \text{GMP}(2)$. Using Theorem 2.28, we see that \mathcal{A}_G fails to be free. For a given C_n (for $n > 4$) we can contract edges until we end up with C_4 . The result follows.

Let $G = \Delta_{3,1}$ and note that every $\Delta_{n,k} \neq C_3$ can get transformed into G by contracting edges. If $\mu \equiv 3$ we get $\text{LMP}(2) = 489$ and assuming exponents $(9, 9, 9, 9)_{\leq}$ we get $\text{GMP}(2) = 486$. So only the simple multiplicity can be free.

Let $G = A_{3,2}$. Let $\mu \equiv k$, then we get

$$\text{GMP}(2) = \begin{cases} 45.375k^2, & \text{if } 11k \equiv 0 \pmod{4}, \\ 45.375k^2 - \frac{1}{2}, & \text{if } 11k \equiv 2 \pmod{4}, \\ 45.375k^2 - \frac{3}{8}, & \text{else.} \end{cases}$$

Moreover, $\text{LMP}(2) = 46k^2$ (if k is even) and $46k^2 - 3$ (if k is odd). Once more we see that $\text{LMP}(2) \neq \text{GMP}(2)$ and so, by Theorem 2.28, (\mathcal{A}, μ) fails to be free. Since every $A_{n,k}$ with $n \geq 4$ can be transformed into $A_{3,2}$ after contracting edges, the result follows from Lemma 2.22. \square

Combining the last two results we get the following.

Corollary 4.9. *Let $G \in \{P_n, A_{n,k}, \Delta_{n,k}, C_n\}$, $\mu \equiv k$, ($k > 1$). Then (\mathcal{A}_G, μ) is free if and only if $G = P_n$ or $G = C_3$ and $k = 3$.*

5. CLASSIFYING FREE MULTIPLICITIES ON CONNECTED SUBGRAPH ARRANGEMENTS

Since connected subgraph arrangements are locally A_2 and admit a positive system of defining equations, the extension techniques introduced by Yoshinaga in [Y09] are well suited to attack the problem of classifying free multiplicities on connected subgraph arrangements and their subarrangements.

We define a subarrangement of \mathcal{A}_{C_3} for which we give a complete list of free multiplicities. This classification was achieved previously by DiPasquale and Wakefield in [DW18], where this arrangement appeared in a different context, using homological algebra methods.

Definition 5.1. We define the *deleted C_3 arrangement* \mathcal{D} as $\mathcal{D} := \mathcal{A}_{C_3} \setminus \{H_{123}\}$. The defining polynomial of \mathcal{D} is given by

$$(5.2) \quad Q(\mathcal{D}) = x_1 x_2 x_3 (x_1 + x_2)(x_1 + x_3)(x_2 + x_3).$$

To prove the freeness of a certain family of multiplicities on \mathcal{D} and to identify some free multiplicities on \mathcal{A}_{C_3} at the end of this section, we require the following lemma.

Lemma 5.3. *Let $(\mathcal{A}, \mu) = (\mathcal{A}(B_2), \mu)$ be the multiarrangement*

$$Q(\mathcal{A}(B_2), \mu) = x_1^a x_2^b (x_1 + x_2)^c (2x_1 + x_2)^d$$

with multiplicity $\mu = (a, b, c, d)$.

- (1) *If $\mu = (2k, 1, 2k, 1)$, then (\mathcal{A}, μ) is free with exponents $(2k + 1, 2k + 1)$.*
- (2) *If $\mu = (2k + 1, 1, 2k + 1, 1)$, then (\mathcal{A}, μ) is free with exponents $(2k + 1, 2k + 3)$.*
- (3) *If $\mu = (k, 1, k, 2k - 4)$ or $\mu = (k, 2k - 4, k, 1)$, then (\mathcal{A}, μ) is free with exponents $(2k - 2, 2k - 1)$.*
- (4) *If $\mu = (k + 1, 1, k + 1, 2k - 4)$ or $\mu = (k + 1, 2k - 4, k + 1, 1)$, then (\mathcal{A}, μ) is free with exponents $(2k - 1, 2k)$.*

Proof. (1) and (2): We give an explicit basis for the module of derivations $D(\mathcal{A}, \mu)$ in both cases. We utilize the linear isomorphism from \mathbb{C}^2 to itself, defined by $x_1 \mapsto x_2$ and $x_2 \mapsto x_1 - x_2$, sending $\{x_1, x_2, x_1 + x_2, 2x_1 + x_2\}$ to $\{x_1, x_2, x_1 + x_2, x_1 - x_2\}$. Thus it is sufficient to calculate a basis for $D(\mathcal{B}, \nu)$, where $Q(\mathcal{B}, \nu) = x_1^c x_2^a (x_1 + x_2)^d (x_1 - x_2)^b$.

For (1), we have $Q(\mathcal{B}, \nu) = x_1^{2k} x_2^{2k} (x_1 + x_2)^1 (x_1 - x_2)^1$ and a basis for $D(\mathcal{B}, \nu)$ is given by

$$\theta_1 = x_1^{2k} x_2 dx_1 + x_1 x_2^{2k} dx_2 \quad \text{and} \quad \theta_2 = x_1^{2k+1} dx_1 + x_2^{2k+1} dx_2.$$

For (2), we have $Q(\mathcal{B}, \nu) = x_1^{2k+1} x_2^{2k+1} (x_1 + x_2)^1 (x_1 - x_2)^1$ and a basis for $D(\mathcal{B}, \nu)$ is given by

$$\theta_1 = x_1^{2k+1} dx_1 + x_2^{2k+1} dx_2 \quad \text{and} \quad \theta_2 = (x_1^2 x_2^{2k+1} - x_2^{2k+3}) dx_2.$$

Verifying that $\theta_1, \theta_2 \in D(\mathcal{B}, \nu)$ in both cases and checking the determinant condition in Theorem 2.3 (which gives $\det(p_{ij}) = x_1^{2k} x_2^{2k+2} - x_1^{2k+2} x_2^{2k} = (x_1 - x_2)(x_1 + x_2)(-x_1^{2k})x_2^{2k}$ in the first case and $\det(p_{ij}) = (x_1 - x_2)(x_1 + x_2)x_1^{2k+1}x_2^{2k+1}$ in the second case) shows that in both cases $\{\theta_1, \theta_2\}$ is a basis for $D(\mathcal{B}, \nu)$, which completes the proof.

(3) and (4): Start with $\mu' = (k, 0, k, 2k - 4)$ resp. $\mu' = (k + 1, 0, k + 1, 2k - 4)$ and use Theorem 2.16 to see that (\mathcal{A}, μ') is free with exponents $(2k - 2, 2k - 2)$ resp. $(2k - 1, 2k - 1)$. So (\mathcal{A}, μ) has to be free with exponents $(2k - 2, 2k - 1)$ resp. $(2k - 1, 2k)$.

The argument is the same for the other two multiplicities, but we delete $\ker(2x_1 + x_2)$ instead. \square

5.1. Free multiplicities on \mathcal{D} . We first introduce a special family of multiplicities μ such that (\mathcal{D}, μ) is a free multiarrangement. Then we proceed to show that there are no other free multiplicities on \mathcal{D} .

Proposition 5.4. *Let $\mu = (2k, 2k, 2k, 1, 1, 1)$ (for $k \in \mathbb{N}_{\geq 1}$) be a multiplicity on \mathcal{D} where the order on \mathcal{D} is as in (5.2). Then (\mathcal{D}, μ) is free with exponents $(2k + 1, 2k + 1, 2k + 1)$.*

Proof. The subarrangement \mathcal{B}_0 of \mathcal{D} defined by $Q(\mathcal{B}_0, \mu_0) = x_1^{2k} x_2^{2k} x_3^{2k}$ is boolean and therefore free with exponents $(2k, 2k, 2k)$. Let $Q(\mathcal{B}_1, \mu_1) := x_1^{2k} x_2^{2k} x_3^{2k} (x_1 + x_2)$ and $H_1 = \ker(x_1 + x_2)$. Then we get $\mathcal{B}_1^{H_1} = \{\ker(x_1), \ker(x_2)\}$. Using Proposition 2.9, we get $\mu_1^* =$

$(2k, 2k)$ for the corresponding Euler-multiplicity. Therefore, $(\mathcal{B}_1^{H_1}, \mu_1^*)$ is free with exponents $\exp(\mathcal{B}_1^{H_1}, \mu_1^*) = (2k, 2k)$. Using Theorem 2.10 we deduce that (\mathcal{B}_1, μ_1) is free with exponents $(2k, 2k, 2k + 1)$. Now let $Q(\mathcal{B}_2, \mu_2) := x_1^{2k} x_2^{2k} x_3^{2k} (x_1 + x_2)(x_1 + x_3)$ and $H_2 = \ker(x_1 + x_3)$, then we get $\mathcal{B}_2^{H_2} = \{\ker(x_1), \ker(x_2), \ker(x_1 - x_2)\}$ and Proposition 2.9 gives $\mu_2^* = (2k, 2k, 1)$. Therefore, $(\mathcal{B}_2^{H_2}, \mu_2^*)$ is free with exponents $\exp(\mathcal{B}_2^{H_2}, \mu_2^*) = (2k, 2k + 1)$, so (\mathcal{B}_2, μ_2) is free with exponents $(2k, 2k + 1, 2k + 1)$. Finally, restricting (\mathcal{D}, μ) to $H_3 = \ker(x_2 + x_3)$ gives $\mathcal{D}^{H_3} = \{x_1, x_2, x_1 + x_2, x_1 - x_2\}$ with Euler-multiplicity $\mu^* = (2k, 2k, 1, 1)$. In the proof of Lemma 5.3 we show that $(\mathcal{D}^{H_3}, \mu^*)$ is free with exponents $\exp(\mathcal{D}^{H_3}, \mu^*) = (2k + 1, 2k + 1)$. Using Theorem 2.10 once more completes the proof. \square

The proof above actually shows that (\mathcal{D}, μ) is inductively free with μ as in the statement of the proposition. Next, we prove that there are no other free multiplicities on \mathcal{D} .

5.2. Non-Free multiplicities on \mathcal{D} . The following Lemma shows that the non-trivial multiplicities as in Proposition 5.4 all have to coincide.

Lemma 5.5. *Let $Q(\mathcal{D}, \mu) = x_1^a x_2^b x_3^c (x_1 + x_2)^d (x_1 + x_3)^e (x_2 + x_3)^f$ with multiplicity $\mu = (a, b, c, d, e, f)$, $a \geq b \geq c$. If $\mu = (\text{even}, \text{even}, \text{even}, 1, 1, 1)$, then (\mathcal{D}, μ) is free if and only if $a = b = c$.*

Proof. The reverse implication follows from Proposition 5.4.

For the forward implication assume that (\mathcal{D}, μ) is free. For some $X \in L(\mathcal{A})_2$ and the corresponding rank 2 localization $\mathcal{A}_X = \{H_1, H_2, H_3\}$ or $\mathcal{A}_X = \{H_1, H_2\}$ which is free with $\exp(\mathcal{A}_X, \mu_X) = (d_1^X, d_2^X)$, we write its summand $d_1^X d_2^X$ in LMP(2) as $[\mu(H_1), \mu(H_2), \mu(H_3)]$ or $[\mu(H_1), \mu(H_2)]$ respectively. Using this notation, LMP(2) of (\mathcal{D}, μ) equals

$$\text{LMP}(2) = [a, b, d] + [a, c, e] + [b, c, f] + [a, f] + [b, e] + [c, d] + [d, e] + [d, f] + [e, f].$$

With our assumption $d = e = f = 1$, we get

$$\text{LMP}(2) = [a, b, 1] + [a, c, 1] + [b, c, 1] + a + b + c + 3,$$

which (because of $a \geq b \geq c$ and Theorem 2.16) equals

$$a(b + 1) + a(c + 1) + b(c + 1) + a + b + c + 3 = 3a + 2b + c + ab + ac + bc + 3.$$

Define the multiplicity $\mu_1 = (a, b, c, 0, 0, 0)$ on \mathcal{D} , then (\mathcal{D}, μ_1) is free with exponents (a, b, c) since it is boolean. Assuming that (\mathcal{D}, μ) is free, the arrangement has exponents equal to one of $(a + 3, b, c)_{\leq}$, $(a + 2, b + 1, c)_{\leq}$, \dots , $(a, b, c + 3)_{\leq}$, thanks to [HRS17, Rem. 2.8]. Writing $E := ab + ac + bc$ this gives GMP(2) as follows:

Exponents	$(a + 3, b, c)_{\leq}$	$(a, b + 3, c)_{\leq}$	$(a, b, c + 3)_{\leq}$	$(a + 2, b + 1, c)_{\leq}$	$(a + 2, b, c + 1)_{\leq}$
GMP(2)	$E + 3b + 3c$	$E + 3a + 3c$	$E + 3a + 3b$	$E + a + 2b + 3c + 2$	$E + a + 3b + 2c + 2$
Exponents	$(a + 1, b + 2, c)_{\leq}$	$(a, b + 2, c + 1)_{\leq}$	$(a + 1, b, c + 2)_{\leq}$	$(a, b + 1, c + 2)_{\leq}$	$(a + 1, b + 1, c + 1)_{\leq}$
GMP(2)	$E + 2a + b + 3c + 2$	$E + 3a + b + 2c + 2$	$E + 2a + 3b + c + 2$	$E + 3a + 2b + c + 2$	$E + 2a + 2b + 2c + 3$

Since each of a, b, c is even by assumption, we get that in all but the last case (where $\exp(\mathcal{D}, \mu) = (a + 1, b + 1, c + 1)_{\leq}$), GMP(2) is even. But since

$$\text{LMP}(2) = E + 3a + 2b + c + 3$$

is odd, we see that $\text{LMP}(2) \neq \text{GMP}(2)$ in those cases. In particular, the arrangement cannot be free because of Theorem 2.28. So let us assume $\exp(\mathcal{D}, \mu) = (a + 1, b + 1, c + 1)_{\leq}$ which gives $\text{GMP}(2) = E + 2a + 2b + 2c + 3$. But if we do not have $a = b = c$, then $a > b$ or $b > c$. This implies $a > c$ and we have

$$\text{GMP}(2) = 2a + 2b + 2c + E + 3 < 3a + 2b + c + E + 3 = \text{LMP}(2).$$

So using Theorem 2.28 again, we see that (\mathcal{D}, μ) cannot be free and we have $a = b = c$. \square

Theorem 2.25 allows us to focus on the cases where μ does not satisfy (2.26) as follows.

Corollary 5.6. *Let μ be a multiplicity on \mathcal{D} that satisfies (2.26). Then (\mathcal{D}, μ) is not free. In particular, \mathcal{D} is not free.*

Proof. By [CK24, Prop. 3.1], \mathcal{A}_{C_3} is free with exponents $(1, 3, 3)$. Let $H = H_{123}$ and note that $\mathcal{A}_{C_3}^H$ is free with exponents $(1, 2)$, since $|\mathcal{A}_{C_3}^H| = 3$. According to Theorem 2.10, $\mathcal{A}_{C_3} \setminus \{H\} = \mathcal{D}$ is not free. By Theorem 2.25, (\mathcal{D}, μ) is free if and only if $\mathcal{E}(\mathcal{D}, \mu)$ free. However, $\mathcal{E}(\mathcal{D}, \mu)_X = \mathcal{D}$ for $X = H_1 \cap H_2 \cap H_3$. So $\mathcal{E}(\mathcal{D}, \mu)$ cannot be free, by Theorem 2.1. \square

We use a similar argument when (2.26) is not satisfied. For this, we define a free extension for the multiarrangement $x^a y^b (x + y)^c$ when $(a, b, c) = (\text{even}, \text{even}, \text{odd})$. With this tool in hand, we construct an extension of (\mathcal{D}, μ) which is locally free along H_4 for an arbitrary multiplicity μ . This enables us to use Corollary 2.5 to show that (\mathcal{D}, μ) is not free.

Next we consider a class of extensions of a given multiarrangement (\mathcal{A}, μ) which generalizes the one from Definition 2.24.

Definition 5.7. Let (\mathcal{A}, μ) be a multiarrangement in \mathbb{K}^ℓ . Define the extension $\mathcal{E}_\sigma(\mathcal{A}, \mu)$ in $\mathbb{K}^{\ell+1}$ depending on another fixed multiplicity $\sigma : \mathcal{A} \rightarrow \mathbb{Z}$ as follows:

$$\mathcal{E}_\sigma(\mathcal{A}, \mu) = \{x_{\ell+1} = 0\} \cup \left\{ \alpha_H - kx_{\ell+1} = 0 \mid k \in \mathbb{Z}, -\frac{\mu(H) - 1}{2} + \sigma(H) \leq k \leq \frac{\mu(H)}{2} + \sigma(H) \right\}.$$

Note that $\mathcal{E}_0(\mathcal{A}, \mu) = \mathcal{E}(\mathcal{A}, \mu)$ as in Definition 2.24.

Analogous to multiplicities, we occasionally denote by $\mu = (\mu(H_1), \mu(H_2), \dots, \mu(H_n))$, we write σ as $\sigma = (\sigma(H_1), \sigma(H_2), \dots, \sigma(H_n))$. We use this notation in the following lemma.

Lemma 5.8. *Let $Q(\mathcal{A}, \mu) = x_1^{m_1} x_2^{m_2} (x_1 + x_2)^{m_3}$ with $m_1 \leq m_2$. Let $\sigma = (0, 0, 1)$.*

- (i) *If $\mu = (m_1, m_2, m_3) = (\text{even}, \text{even}, \text{odd})$, then $\mathcal{E}_\sigma(\mathcal{A}, \mu)$ is free.*
- (ii) *If $\mu = (m_1, m_2, m_3) = (\text{even}, \text{odd}, \text{odd})$ or $(\text{odd}, \text{even}, \text{odd})$, then $\mathcal{E}_\sigma(\mathcal{A}, \mu)$ is free.*

Proof. The idea of the proof is to increase the multiplicity of H_{12} by 1 which results in a multiplicity $\mu_1 = (m_1, m_2, m_3 + 1)$ such that (2.26) is satisfied and thus $\mathcal{E}(\mathcal{A}, \mu_1)$ is a free extension of (\mathcal{A}, μ_1) . Now we remove a hyperplane H so that $\mathcal{E}(\mathcal{A}, \mu_1) \setminus \{H\} = \mathcal{E}_\sigma(\mathcal{A}, \mu)$ is free, thanks to Theorem 2.10. We demonstrate this in one case while the other cases are handled analogously.

For (i) let $\mu_1 = (m_1, m_2, m_3 + 1) = (\text{even}, \text{even}, \text{even})$. The extended arrangement $\mathcal{A}_1 := \mathcal{E}_0(\mathcal{A}, \mu_1)$ is free, by Theorem 2.25. Note that for $\sigma = (0, 0, 1)$, $H = \ker(x_1 + x_2 + (\frac{m_3-1}{2})x_3)$ and $\mathcal{A}_2 := \mathcal{E}_\sigma(\mathcal{A}, \mu)$, we have $\mathcal{A}_2 = \mathcal{A}_1 \setminus \{H\}$. So we start at the free arrangement \mathcal{A}_1 , fix the hyperplane H , and use Theorem 2.10 to derive the freeness of \mathcal{A}_2 . Note that the exponents of \mathcal{A}_1 can be derived by using Theorems 2.16 and 2.2. The following case by case investigation is necessary due to [Y09, Lem. 3.1].

Assume $m_2 - m_1 \leq m_3 < m_1 + m_2$. Then we have $\exp(\mathcal{A}_1) = (1, \frac{m_1+m_2+m_3+1}{2}, \frac{m_1+m_2+m_3+1}{2})$. Note that it is sufficient to show that $|\mathcal{A}_1^H| = 1 + \frac{m_1+m_2+m_3+1}{2}$, since \mathcal{A}_1^H is a simple arrangement of rank 2 and so is free with exponents $(1, \frac{m_1+m_2+m_3+1}{2})$, satisfying the conditions of Theorem 2.10. We count all elements $X \in L(\mathcal{A}_1)_2$ with $X \subset H$ by listing all localizations \mathcal{A}_X . There is a canonical bijection between the set containing those elements and the set of hyperplanes of \mathcal{A}_1^H . We identify the hyperplanes of $\mathcal{E}(\mathcal{A}, \mu_1)$ with their linear forms. We have a single localization with more than 3 elements:

$$\left\{ H, x_1 + x_2 + \left(\frac{m_3 - 3}{2} \right) x_3, \dots, x_1 + x_2 - \frac{m_3 + 1}{2} x_3, x_3 \right\}$$

and a total of $\frac{m_1+m_2-(m_3+1)}{2}$ localizations with 3 elements

$$\begin{aligned} & \left\{ H, x_1 + \left(\frac{m_1 - 2}{2} \right) x_3, x_2 - \left(\frac{m_1 - (m_3 + 1)}{2} \right) x_3 \right\}, \\ & \left\{ H, x_1 + \left(\frac{m_1 - 4}{2} \right) x_3, x_2 - \left(\frac{m_1 - (m_3 + 3)}{2} \right) x_3 \right\}, \\ & \dots, \left\{ H, x_1 - \left(\frac{m_2 - (m_3 + 1)}{2} \right) x_3, x_2 + \left(\frac{m_2 - 2}{2} \right) x_3 \right\}. \end{aligned}$$

The rank 2 localization with more than 3 elements contains $m_3 + 1$ elements which are not equal to H while all of the localizations with 3 elements combined contain $m_1 + m_2 - m_3 - 1$ hyperplanes distinct from H . Subtracting the number of hyperplanes included in these localizations from the total number of hyperplanes in \mathcal{A}_1 shows that there are

$$(m_1 + m_2 + (m_3 + 1)) - (m_3 + 1) - (m_1 + m_2 - m_3 - 1) = m_3 + 1$$

hyperplanes $H' \in \mathcal{A}_1$ such that $|(\mathcal{A}_1)_{H \cap H'}| = 2$. In conclusion we have

$$1 + \frac{m_1 + m_2 - (m_3 + 1)}{2} + (m_3 + 1) = 1 + \frac{m_1 + m_2 + m_3 + 1}{2}$$

hyperplanes in $|\mathcal{A}_1^H|$. This implies that $\exp(\mathcal{A}_1^H) = (1, \frac{m_1+m_2+m_3+1}{2})$. By Theorem 2.10, \mathcal{A}_2 is free with exponents $\exp(\mathcal{A}_2) = (1, \frac{m_1+m_2+m_3-1}{2}, \frac{m_1+m_2+m_3+1}{2})$. The cases where $m_3 + 1 < m_2 - m_1 + 1$ and $m_3 + 1 \geq m_1 + m_2 + 1$ and part (ii) are handled analogously. \square

Theorem 5.9. *Let (\mathcal{D}, μ) be the multiarrangement*

$$Q(\mathcal{D}, \mu) = x_1^a x_2^b x_3^c (x_1 + x_2)^d (x_1 + x_3)^e (x_2 + x_3)^f$$

with $a, b, c, d, e, f \geq 1$. Then (\mathcal{D}, μ) is free if and only if $\mu = (2k, 2k, 2k, 1, 1, 1)$ for some $k \in \mathbb{N}_{\geq 1}$ where the order of the hyperplanes is as above.

Proof. The reverse implication follows from Proposition 5.4.

For the forward implication note that if at least two of the values a, b, c are odd or all of d, e, f are even, then (\mathcal{D}, μ) is not free, by Corollary 5.6. Consequently, we can assume (after possibly permuting some basis vectors) that at least d is odd and a, b are even so (2.26) is not satisfied. If $\mu = (\text{even}, \text{even}, \text{even}, 1, 1, 1)$ and $\mu \neq (2k, 2k, 2k, 1, 1, 1)$, then we use Lemma 5.5 to see that (\mathcal{D}, μ) is not free. For the remaining multiplicities μ we give an extension of (\mathcal{D}, μ) which is locally free along H_4 , but has a localization isomorphic to \mathcal{D} . So (\mathcal{D}, μ) cannot be free, by Corollary 2.5. We now give an alternative extension for all remaining multiplicities (up to a permutation of coordinates) where $\mu \neq (2k, 2k, 2k, 1, 1, 1)$. Note that the local freeness along H_4 in the cases where (2.26) is not met is given by Lemma 5.8. We write $H_{i4} = \ker(x_i - x_4)$ and $H_{ij4} = \ker(x_i + x_j - x_4)$.

Let $\mathcal{A} = \mathcal{E}_\sigma(\mathcal{D}, \mu)$ be an extension of (\mathcal{D}, μ) , where σ is given as in the following table.

a	b	c	d	e	f	σ	Type
even	even	odd	odd	odd	≥ 1	$(0, 0, 0, 1, 1, 0)$	(a)
even	even	odd	odd	even	≥ 1	$(0, 0, 0, 1, 0, 0)$	(a)
even	even	even	≥ 3	≥ 1	≥ 1	$\sigma(H_i) = 0$ and $\sigma(H_{ij}) = 1 \iff \mu(H_{ij})$ odd	(c)
even	even	even	1	≥ 2	≥ 2	$\sigma(H_i) = 0$ and $\sigma(H_{ij}) = 1 \iff \mu(H_{ij})$ odd	(b)
even	even	even	1	1	≥ 2	$\sigma(H_i) = 0$ and $\sigma(H_{ij}) = 1 \iff \mu(H_{ij})$ odd	(a)

The localizations of $\mathcal{A} = \mathcal{E}_\sigma(\mathcal{D}, \mu)$ isomorphic to \mathcal{D} are:

- (a) $\mathcal{A}_X = \{H_2, H_3, H_{14}, H_{23}, H_{124}, H_{134}\}$ for $X = (H_2 \cap H_3 \cap H_{14}) \in L(\mathcal{A})$,
- (b) $\mathcal{A}_X = \{H_1, H_3, H_{24}, H_{13}, H_{124}, H_{234}\}$ for $X = (H_1 \cap H_3 \cap H_{24}) \in L(\mathcal{A})$,
- (c) $\mathcal{A}_X = \{H_1, H_2, H_{34}, H_{12}, H_{134}, H_{234}\}$ for $X = (H_1 \cap H_2 \cap H_{34}) \in L(\mathcal{A})$.

We now show how the table above can be applied to one of the remaining multiplicities μ to derive the non-freeness for (\mathcal{D}, μ) . So let $\mu = (2, 4, 4, 1, 1, 3)$. First note that since in this case a, b, c are even and $d = e = 1$, we use the last row of the table. The second to last column tells us that $\sigma = (0, 0, 0, 1, 1, 1)$, since all of the values $\mu(H_{ij})$ are odd. Using the notation of Lemma 5.8 and choosing an arbitrary $X \in L(\mathcal{D})_2$ with $|\mathcal{D}_X| = 3$, we have parities $(\text{even}, \text{even}, \text{odd})$ on \mathcal{D}_X and $\sigma|_X = (0, 0, 1)$. So Lemma 5.8 gives us the local freeness of $\mathcal{E}_\sigma(\mathcal{D}, \mu)$ along H_4 . Since $\mathcal{E}_\sigma(\mathcal{D}, \mu)$ has localization (a) with hyperplanes

$$\{\ker(x_2), \ker(x_3), \ker(x_1 - x_4), \ker(x_2 + x_3), \ker(x_1 + x_2 - x_4), \ker(x_1 + x_3 - x_4)\},$$

(which is isomorphic to \mathcal{D} and therefore non-free) we can apply Corollary 2.5 to show that (\mathcal{D}, μ) is not free. This completes the proof of the theorem. \square

Deleting a hyperplane from \mathcal{A}_{C_3} results in either $\mathcal{A}_{P_3} = \mathcal{A}(A_3)$ or in \mathcal{D} . All free multiplicities on the reflection arrangement $\mathcal{A}(A_3)$ have been classified, see [ATW08], [ANN09], [DFMS20]. Since all free multiplicities are known on both types of deletions on \mathcal{A}_{C_3} , the next step is to classify all free multiplicities on \mathcal{A}_{C_3} itself.

5.3. **Some free multiplicities on \mathcal{A}_{C_3} .** In this final section we present some free multiplicities on \mathcal{A}_{C_3} that we found by starting with a free multiplicity on \mathcal{A}_{P_3} or \mathcal{D} and adding a hyperplane via Theorem 2.10 to create a free multiplicity on \mathcal{A}_{C_3} . It turns out that there is only one free multiplicity on \mathcal{D} that extends to a free multiplicity on \mathcal{A}_{C_3} in such a way.

Corollary 5.10. *Let $H = H_{123}$ and*

$$(\mathcal{A}_{C_3}, \mu) = x_1^{2k} x_2^{2k} x_3^{2k} (x_1 + x_2)^1 (x_1 + x_3)^1 (x_2 + x_3)^1 (x_1 + x_2 + x_3)^1.$$

Then (\mathcal{A}_{C_3}, μ) is free if and only if $k = 1$.

Proof. Let $H = H_{123}$. Owing to Theorem 5.9, we see that $(\mathcal{A}'_{C_3}, \mu')$ is free with exponents $(2k + 1, 2k + 1, 2k + 1)$. Now restrict (\mathcal{A}_{C_3}, μ) to H and calculate μ^* by using Theorem 2.16 on the following rank 2 flats:

$$\{H_{123}, H_{12}, H_3\}, \{H_{123}, H_2, H_{13}\}, \{H_{123}, H_1, H_{23}\}.$$

This gives $\mu^* = (2k, 2k, 2k)$ and therefore (again by Theorem 2.16) $(\mathcal{A}_{C_3}^H, \mu^*)$ is free with $\exp(\mathcal{A}_{C_3}^H, \mu^*) = (3k, 3k)$. So by Remark 2.11 (\mathcal{A}_{C_3}, μ) is free if and only if $k = 1$. \square

Definition 5.11 ([ATW08, Def. 5.8]). An arrangement \mathcal{A} is supersolvable if there exists a filtration $\mathcal{A} = \mathcal{A}_r \supset \mathcal{A}_{r-1} \supset \cdots \supset \mathcal{A}_2 \supset \mathcal{A}_1$ such that:

- $\text{rank}(\mathcal{A}_i) = i$ for $i = 1, \dots, r$;
- for any $H, H' \in \mathcal{A}_i$, there exists some $H'' \in \mathcal{A}_{i-1}$ such that $H \cap H' \subset H''$.

Theorem 5.12 ([ATW08, Thm. 5.10]). *Suppose \mathcal{A} is supersolvable with a filtration $\mathcal{A} = \mathcal{A}_r \supset \mathcal{A}_{r-1} \supset \cdots \supset \mathcal{A}_2 \supset \mathcal{A}_1$ and $r \geq 2$ as in Definition 5.11. Let μ be a multiplicity on \mathcal{A} and let $\mu_i = \mu|_{\mathcal{A}_i}$. Let $\exp(\mathcal{A}_2, \mu_2) = (d_1, d_2, 0, \dots, 0)$. Suppose that for each $H' \in \mathcal{A}_d \setminus \mathcal{A}_{d-1}$, $H'' \in \mathcal{A}_{d-1}$ ($d = 3, \dots, r$) and $X := H' \cap H''$, we either have*

$$\mathcal{A}_X = \{H', H''\}$$

or

$$\mu(H'') \geq \left(\sum_{X \subset H \in \mathcal{A}_d \setminus \mathcal{A}_{d-1}} \mu(H) \right) - 1.$$

Then (\mathcal{A}, μ) is inductively free with $\exp(\mathcal{A}, \mu) = (d_1, d_2, |\mu_3| - |\mu_2|, \dots, |\mu_r| - |\mu_{r-1}|, 0, \dots, 0)$.

We now use Theorem 5.12 to derive some classes of multiplicities on \mathcal{A}_{C_3} .

Proposition 5.13. *Let (\mathcal{A}_{C_3}, μ) be the multiarrangement*

$$Q(\mathcal{A}_{C_3}, \mu) = x_1^a x_2^b x_3^c (x_1 + x_2)^d (x_1 + x_3)^e (x_2 + x_3)^f (x_1 + x_2 + x_3)^g$$

with multiplicity $\mu = (a, b, c, d, e, f, g)$, ($d \geq e \geq f$). Suppose that

- (i) $\mu = (k, k, k, r, 1, 1, k)$, where $1 \leq k \leq 3$ arbitrary and $r \geq 1$, or
- (ii) $\mu = (k, k, k, r, 1, 1, k)$, where $k > 3$ arbitrary and $r \geq 2k - 5$.

Then (\mathcal{A}_{C_3}, μ) is free. Moreover, if $r \geq 2k$, then (\mathcal{A}_{C_3}, μ) is inductively free with exponents $(r, 2k + 1, 2k + 1)$. For $\mu = (3, 3, 3, 1, 1, 1, 3)$, (\mathcal{A}_{C_3}, μ) is not inductively free.

Proof. Let $\mu(H_1) = \mu(H_2) = \mu(H_3) = \mu(H_{123}) = k$ and $\mu(H_{12}) = r \geq 2k - 1, \mu(H_{13}) = \mu(H_{23}) = 1$ and fix $H = H_{23}$, so $\mu' = (k, k, k, r, 1, 0, k)$. We choose the following supersolvable filtration for $(\mathcal{A}'_{C_3}, \mu')$:

$$\{H_1\} \subset \{H_1, H_2, H_{12}\} \subset \{H_1, H_2, H_3, H_{12}, H_{13}, H_{123}\}.$$

This filtration satisfies the requirements of Theorem 5.12, because $\mu'(H_1) \geq \mu'(H_3) + \mu'(H_{13}) - 1 \iff k \geq k$ and $\mu'(H_2) \geq \mu'(H_{13}) + \mu'(H_{123}) - 1 \iff k \geq k$ and $\mu'(H_{12}) \geq \mu'(H_3) + \mu'(H_{123}) - 1 \iff 2k - 1 \geq 2k - 1$. So $(\mathcal{A}'_{C_3}, \mu')$ is inductively free with exponents $(r, 2k, 2k + 1)$. Restricting (\mathcal{A}_{C_3}, μ) to H_{23} gives hyperplanes in correspondence to the rank 2 flats

$$\{H, H_2, H_3\}, \{H, H_1, H_{123}\}, \{H, H_{12}\}, \{H, H_{13}\}$$

with $\mu^* = (k, k, r, 1)$. If $r \geq 2k$, then the restriction is free with exponents $(2k + 1, r)$ since deleting the hyperplane with multiplicity 1 gives a free arrangement with exponents $(2k, r)$ and using Theorem 2.10 shows that (\mathcal{A}_{C_3}, μ) is inductively free with exponents $(r, 2k + 1, 2k + 1)$. Deleting H_{12} with Theorem 2.10 and Lemma 5.3 until $r = 2k - 5$ (and we end up at exponents $(2k - 1, 2k - 1, 2k - 1)$) shows the other claim. In particular: If $r = 3$, then $\mu = (3, 3, 3, 1, 1, 1, 3)$ and (\mathcal{A}_{C_3}, μ) is free with exponents $\exp(\mathcal{A}_{C_3}, \mu) = (5, 5, 5)$. Restricting to an arbitrary $H \in \mathcal{A}_{C_3}$ results in $|(\mathcal{A}_{C_3}, \mu^*)| = 8$. So Remark 2.11 shows that $(\mathcal{A}'_{C_3}, \mu')$ can never be free and therefore (\mathcal{A}_{C_3}, μ) is neither inductively nor additively free. \square

It can be shown that $\mu = (3, 3, 3, 1, 1, 1, 3)$ is the minimal multiplicity (with respect to $|\mu|$) on \mathcal{A}_{C_3} that is free but not inductively free.
