# LIPSCHITZ REGULARITY FOR ALMOST MINIMIZERS OF A ONE-PHASE $p$-BERNOULLI-TYPE FUNCTIONAL IN CARNOT GROUPS OF STEP TWO

#### Abstract

In this paper, in a Carnot group $\mathbb{G}$ of step 2 and homogeneous dimension $Q$, we prove that almost minimizers of the (horizontal) one-phase $p$-Bernoulli-type functional $$
J_{p}(u, \Omega):=\int_{\Omega}\left(\left|\nabla_{\mathbb{G}} u(x)\right|^{p}+\chi_{\{u>0\}}(x)\right) d x
$$ whenever $p>p^{\#}:=\frac{2 Q}{Q+2}$, are locally Lipschitz continuous with respect Carnot-Carathéodory distance on $\mathbb{G}$. This implies an Hölder continuous regularity from an Euclidean point of view.

## 1. Introduction

In this paper, we study the regularity of the almost minimizers of a one-phase (horizontal) $p$-Bernoulli-type functional in Carnot groups of step two. We are interested in the regularity properties of almost minimizers associated with degenerate functionals in noncommutative structures, endowed by a rich geometry, as in the case of the Carnot groups of step 2, started in [34] when $p=2$.

The classical motivation to study this type of free boundary problem arises from flame propagation and jet flows models [1, 6, 5], and it is also related to shape optimization problems, see [9].

In the Euclidean setting, regularity issues concerning minimizers of such functionals were introduced in the pioneering work of Alt and Caffarelli, see [3]. Further contributions to this topic appeared in $[13,26,57]$ and we refer to $[14,78]$ and the references within for a comprehensive overview of the subject. More recently, regularity of almost minimizes and their free boundaries were also studied in [24, 21]. A different approach is proposed in [28], based on nonvariational techniques.

The research about the nonlinear Euclidean setting of $p$-Bernoulli-type functional, ruled by $p$-Laplace operator, appeared in [31], where the authors generalize the contribution introduced in [28] without applying mean value properties to $p$-harmonic functions. However, the tools introduced in [31] have been useful in [34], facing the linear framework given by (horizontal) Bernoulli-type functional in Carnot groups of step 2, where smooth vector fields, generating the first algebra stratum, are involved. In fact, in this case, the norm of the intrinsic gradient of an (intrinsic) harmonic function is not an (intrinsic) subharmonic function, contrary to what happens in the Euclidean case.

Hence, in this paper, combing the approach of [34] and the strategy of 31], we manage to prove the (intrinsic) Lipschitz continuous behaviour of almost minimizers of $p$-Bernoulli-type functionals in Carnot groups of step 2. Dealing with the nonlinear framework, we pay particular attention to the noncommutative setting we are considering, since due to the linearization argument employed, we need more general regularity estimates with respect to the ones applied in 34].

The mathematical setting we need will be presented later on. We refer to Section 2 for the main notation and definitions. Nevertheless, in order to introduce the main result of the paper, we recall here the definition of almost minimizer, we deal with.

Let $\mathbb{G}$ be a Carnot Group of step 2. Assume that $\Omega \subset \mathbb{G}$ is a measurable domain and $p>1$ is fixed. We define the following energy functional

$$
\begin{equation*}
J_{p}(u, \Omega):=\int_{\Omega}\left(\left|\nabla_{\mathbb{G}} u(x)\right|^{p}+\chi_{\{u>0\}}(x)\right) d x \tag{1.1}
\end{equation*}
$$

for all $u \in H W^{1, p}(\Omega), u \geqslant 0$ a.e. in $\Omega$, where $\nabla_{\mathbb{G}} u$ is the so-called horizontal gradient of $u$.
The condition $u \geqslant 0$ a.e. corresponds, in the context of free boundary problems, to consider one-phase problems (solutions which may change sign are related to two-phase problems).

In this paper, we focus on regularity properties for almost minimizers of $J_{p}$ defined in (1.1). The notion of almost minimizers is well-known in the Calculus of Variations. In particular, the notion of almost minimizers associated with energy functionals was introduced by Anzellotti in [2]. Concerning Bernoulli-type energy functionals, almost minimizers have been studied in [24, 22, 23, 28] in the Euclidean setting and in [34] within Carnot groups. In the setting of this work, the precise notion of almost minimizers for $J_{p}$ we are dealing with is the following one.

Definition 1.1. Let $\kappa \geqslant 0, \beta>0$ be constants and let $\Omega \subseteq \mathbb{G}$ be an open set. We say that $u \in H W^{1, p}(\Omega)$ is an almost minimizer for $J_{p}$ in $\Omega$, with constant $\kappa$ and exponent $\beta$, if $u \geqslant 0$ $\mathcal{L}^{n}$-almost everywhere in $\Omega$ and

$$
\begin{equation*}
J_{p}\left(u, B_{\varrho}(x)\right) \leqslant\left(1+\kappa \varrho^{\beta}\right) J_{p}\left(v, B_{\varrho}(x)\right), \tag{1.2}
\end{equation*}
$$

for every (intrinsic) ball $B_{\varrho}(x)$ such that $\overline{B_{\varrho}(x)} \subset \Omega$ and for every $v \in H W^{1, p}\left(B_{\varrho}(x)\right)$ such that $u-v \in H W_{0}^{1, p}\left(B_{\varrho}(x)\right)$.

As well as in [34], the rough idea of the definition of almost minimizes is that, locally, the energy is not necessarily minimal among all competitors but almost minimal, in the sense that it cannot decrease by a factor more than $1+\kappa \varrho^{\beta}$, where $\varrho$ is the scale of the localization. Thus, almost minimizers can be considered as perturbations of minimizers and such perturbations have a smaller contribution at small scales. In general, almost minimizers only satisfy a variational inequality but they are not solutions to some partial differential equations. Thus, the main problem in facing their regularity properties is the lack of monotonicity formulas, contrary to what usually happens to minimizers.

Now, we are in position to state our main regularity result. Here the integer $Q$ is the homogeneous dimension of $\mathbb{G}$, see Section 2.
Theorem 1.2. Suppose that $p>p^{\#}:=\frac{2 Q}{Q+2}$. Let $u$ be an almost minimizer for $J_{p}$ in $B_{1}$ with constant $\kappa$ and exponent $\beta$. Then,

$$
\left\|\nabla_{\mathbb{G}} u\right\|_{L^{\infty}\left(B_{1 / 2}\right)} \leqslant C\left(\left\|\nabla_{\mathbb{G}} u\right\|_{L^{p}\left(B_{1}\right)}+1\right),
$$

where $C>0$ is a constant depending on $\kappa, \beta, Q$ and $p$.
In addition, $u$ is uniformly Lipschitz continuous in a neighborhood of $\{u=0\}$, namely if $u(0)=0$ then

$$
\left|\nabla_{\mathbb{G}} u\right| \leqslant C \quad \text { in } B_{r_{0}},
$$

for some $C>0$, depending only on $Q, p, \kappa$ and $\beta$, and $r_{0} \in(0,1)$, depending on $Q, p, \kappa, \beta$ and $\left\|\nabla_{\mathbb{G}} u\right\|_{L^{p}\left(B_{1}\right)}$.

Hence, the main contribution of our paper concerns the intrinsic Lipschitz regularity of almost minimizers to (1.1). Such a result extends the regularity result proved in [34], only obtained in the case of $p=2$.

In particular, to prove the intrinsic Lipschitz regularity of the almost minimizer stated in Theorem 1.2, we have to face a double difficulty: the noncommutative structure of the geometry
and the nonlinear form of the studied functional. More precisely, the vector fields generating the first stratum of the Lie algebra $X_{1}, \ldots, X_{m_{1}}$, in general, have no trivial commutator, i.e.

$$
\left[X_{i}, X_{j}\right] \neq 0 \quad \Leftrightarrow \quad X_{i} X_{j} \neq X_{j} X_{i}, \quad \text { for every } i, j \in\left\{1, \ldots, m_{1}\right\}, \text { if } i \neq j .
$$

As a consequence, denoting by $\mathcal{L}$ the positive sub-Laplacian on $\mathbb{G}$, it results

$$
\begin{equation*}
X_{i} \mathcal{L} \neq \mathcal{L} X_{i} \tag{1.3}
\end{equation*}
$$

for all $i=1, \ldots, m_{1}$. The lack of commutativity, encoded in (1.3), already faced in the linear case discussed in [34], translates into a lack of $\mathbb{G}$-harmonicity of functions $X_{i} u$, for $i \in\left\{1, \ldots, m_{1}\right\}$. Consequently, the approach adopted in [28] cannot be straightforwardly generalized. To overcome this problem, we apply some regularity estimates proved in [17. In addition, in this paper, we have to deal also with the nonlinear behaviour of the $p$-sub-Laplacian associated with $p$-Bernoulli functional (1.1). In particular, regularity estimates of [17], are no longer sufficient. To apply the linearization argument performed in [31], regularity estimates for subelliptic equations with variable coefficients, as ones studied in [71] in the case of the Heisenberg group, are needed. Therefore, to generalize the results of [31] to the framework of the Carnot groups of step two, such regularity estimates represent a key point and their treatment appears in Section 5. We apply techniques, introduced in [67, 32] in the Euclidean setting, and then employed in [71] in the case of the Heisenberg group, based on comparison estimates of corresponding equations with frozen coefficient. However, as well as in [71], in our subelliptic setting, extra terms coming from nonvanishing commutators of the vector fields generating the first algebra stratum appear. Therefore, estimates are not always as strong as those in the Euclidean setting but they are still enough for our purposes.

As we already point out in Theorem [1.2, we deduce that almost minimizes $u$ for $J_{p}$, in an open domain $\Omega \subset \mathbb{G}$, are locally intrinsic Lipschitz functions, i.e. there exists a constant $C>0$ such that for every $x, y \in B \subset \subset \Omega$

$$
|u(x)-u(y)| \leqslant C d_{c}(x, y)
$$

where $d_{c}$ is the Carnot-Charathéodory distance, see Definition 2.2 in the Section 2. However, this Lipschitz intrinsic regularity only implies Hölder continuous regularity, from the Euclidean point of view, since the Carnot-Charathéodory distance is not equivalent to the Euclidean one, see for instance [7, Proposition 5.15.1.]. More precisely, denoting by $d_{E}$ the Euclidean distance on $\mathbb{G} \equiv \mathbb{R}^{n}$, for every compact set $K \subset \mathbb{G}$, there exists a constant $c_{K}>0$ such that

$$
\left(c_{K}\right)^{-1} d_{E}(x, y) \leqslant d_{c}(x, y) \leqslant c_{K} d_{E}^{1 / k}(x, y)
$$

for all $x, y \in K$, where $k$ is the step of the Carnot group. In this paper, we always consider the case of $k=2$.

We also remark that the approach to the regularity theory of free boundary problems, based on monotonicity formulas, is well understood in the Euclidean setting. For example, it is well known that the so-called Alt-Caffarelli-Fredmann monotonicity formula is one of the key tools used to prove Lipschitz continuity of minimizer to two-phase problems, see [4] and also [14]. Nevertheless, these techniques appear difficult to extend to the noncommutative setting
of Carnot groups. Indeed, as recently proved in [33, 35], an intrinsic Alt-Caffarelli-Friedman monotonicity formula, written as the natural counterpart to the classical Euclidean one, seems to fail. Furthermore, the viscosity approach developed in the nonlinear framework, see for instance [20,60, 36, 37], appears more challenging due to the theoretical existence of characteristic points on the free boundary. Nevertheless, with our approach, we overcome these difficulties without relying on monotonicity formulas by dealing with almost minimizers inspired by the [28, 31, 34], where Lipschitz regularity has been showed.

The paper is organized as follows. In Section 2 we introduce the main notation and tools we rely on all the paper. Then in Section 3 we deal with the $(\mathbb{G}, p)$-harmonic proving some estimates you use in our argument. In Section 4 we prove some of the key tools of the proof associated with a dichotomy procedure of [28]. Next, in Section 5 we study some regularity results concerning subellipic equations with variable coefficient, this is a key step to perform a linearization argument as in [31]. Section [6] concludes the dichotomy argument, here we present an improvement of the result in Section 4 using the regularity estimated obtained in Section 5 . Finally, in Section 7 we conclude with the proof of Theorem 1.2.

## 2. Notation and preliminary results

2.1. Carnot Groups. A connected and simply connected Lie group ( $\mathbb{G}, \cdot$ ) (in general nonabelian) is said to be a Carnot group of step $k$ if its Lie algebra $\mathfrak{g}$ admits a $k$-step stratification, i.e. there exist linear subspaces $V_{1}, \ldots, V_{k}$ such that

$$
\begin{equation*}
\mathfrak{g}=V_{1} \oplus \ldots \oplus V_{k}, \quad\left[V_{1}, V_{i}\right]=V_{i+1}, \quad V_{k} \neq\{0\}, \quad V_{i}=\{0\} \text { if } i>k, \tag{2.1}
\end{equation*}
$$

where $\left[V_{1}, V_{i}\right]$ is the subspace of $\mathfrak{g}$ generated by the commutators $[X, Y]$ with $X \in V_{1}$ and $Y \in V_{i}$. The first layer $V_{1}$, the so-called horizontal layer, plays a key role in the theory since it generates all the algebra $\mathfrak{g}$ by commutation. We point out that a stratified Lie algebra can admit more than one stratification, however, the stratification turns out to be unique up to isomorphisms, therefore, the related Carnot group structure is essentially unique (see [59, Proposition 1.17]). Note that when $k=1$ the group $\mathbb{G}$ is Abelian, we return to the Euclidean situation.

Setting $m_{i}=\operatorname{dim}\left(V_{i}\right)$ and $h_{i}=m_{1}+\cdots+m_{i}$, with $h_{0}=0$, for $i=1, \ldots, k$ (so that $h_{k}=n=\operatorname{dim} \mathfrak{g}=\operatorname{dim} \mathbb{G}$ ), we choose a basis $e_{1}, \ldots, e_{n}$ of $\mathfrak{g}$ adapted to the stratification, that is such that

$$
e_{h_{j-1}+1}, \ldots, e_{h_{j}} \text { is a basis of } V_{j} \text { for each } j=1, \ldots, k
$$

Let $X=\left\{X_{1}, \ldots, X_{n}\right\}$ be the family of left-invariant vector fields such that $X_{i}(e)=e_{i}$, $i=1, \ldots, n$, where $e$ is the identity of $(\mathbb{G}, \cdot)$. Thanks to (2.1), the subfamily $\left\{X_{1}, \ldots, X_{m_{1}}\right\}$ generates by commutations all the other vector fields, we will refer to $X_{1}, \ldots, X_{m_{1}}$ as generating vector fields of $(\mathbb{G}, \cdot)$.

The map $X \mapsto X(e)$, that associated with a left-invariant vector field $X$ its value in $e$, defines an isomorphism from $\mathfrak{g}$ to $T \mathbb{G}_{e}$ (in turn identified with $\mathbb{R}^{n}$ ). We systematically use these identifications. Furthermore, by the assumption that $\mathbb{G}$ be simply connected, the exponential map is a global real-analytic diffeomorphism from $\mathfrak{g}$ onto $\mathbb{G}$ (see e.g. [77, 18]), so any $x \in \mathbb{G}$ can
be written in a unique way as $x=\exp \left(x_{1} X_{1}+\cdots+x_{n} X_{n}\right)$. Using these exponential coordinates, we identify $x$ with the $n$-tuple $\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{R}^{n}$ and we identify $\mathbb{G}$ with ( $\left.\mathbb{R}^{n}, \cdot\right)$ where the explicit expression of the group operation • is determined by the Campbell-Hausdorff formula (see e.g. [7,40]). In this coordinates $e=(0, \ldots, 0)$ and $\left(x_{1}, \ldots, x_{n}\right)^{-1}=\left(-x_{1}, \ldots,-x_{n}\right)$, and the adjoint operator in $L^{2}(\mathbb{G})$ of $X_{j}, X_{j}^{*}, j=1, \ldots, n$, turns out to be $-X_{j}$ (see, for instance, 46, Proposition 2.2]). Moreover, if $x \in \mathbb{G}$ and $i=1, \ldots, k$, we set $x^{(i)}:=\left(x_{h_{i-1}+1}, \ldots, x_{h_{i}}\right) \in \mathbb{R}^{m_{i}}$, so that we can also identify $x$ with $\left[x^{(1)}, \ldots, x^{(k)}\right] \in \mathbb{R}^{m_{1}} \times \ldots \times \mathbb{R}^{m_{k}}=\mathbb{R}^{n}$.

Two important families of automorphism of $\mathbb{G}$ are the so-called intrinsic translations and the intrinsic dilations of $\mathbb{G}$. For any $x \in \mathbb{G}$, the (left) translation $\tau_{x}: \mathbb{G} \rightarrow \mathbb{G}$ is defined as

$$
z \mapsto \tau_{x} z:=x \cdot z .
$$

For any $\lambda>0$, the dilation $\delta_{\lambda}: \mathbb{G} \rightarrow \mathbb{G}$, is defined as

$$
\begin{equation*}
\delta_{\lambda}\left(x_{1}, \ldots, x_{n}\right)=\left(\lambda^{\alpha_{1}} x_{1}, \ldots, \lambda^{\alpha_{n}} x_{n}\right), \tag{2.2}
\end{equation*}
$$

where $\alpha_{i} \in \mathbb{N}$ is called homogeneity of the variable $x_{i}$ in $\mathbb{G}$ (see 40] Chapter 1 ) and is defined as

$$
\begin{equation*}
\alpha_{j}=i \quad \text { whenever } h_{i-1}+1 \leqslant j \leqslant h_{i}, \tag{2.3}
\end{equation*}
$$

hence $1=\alpha_{1}=\ldots=\alpha_{m}<\alpha_{m+1}=2 \leqslant \ldots \leqslant \alpha_{n}=k$.
From the definition (2.2), one easily verifies the following properties of intrinsic dilations.
Lemma 2.1. For all $\lambda, \mu>0$ one has:
(1) $\delta_{1}=\operatorname{id}_{\mathbb{G}}$;
(2) $\delta_{\lambda}^{-1}=\delta_{\lambda^{-1}}$;
(3) $\delta_{\lambda} \circ \delta_{\mu}=\delta_{\lambda \mu}$;
(4) for every $p, p^{\prime} \in \mathbb{G}$ one has $\delta_{\lambda}(p) \circ \delta_{\lambda}\left(p^{\prime}\right)=\delta_{\lambda}\left(p \cdot p^{\prime}\right)$.

By left translation, the horizontal layer defines a subbundle of the tangent bundle $T \mathbb{G}$ over $\mathbb{G}$ : the subbundle of the tangent bundle spanned by the family of vector fields $X=\left(X_{1}, \ldots, X_{m_{1}}\right)$ plays a crucial role in the theory, it is called the horizontal bundle $H \mathbb{G}$; the fibres of $H \mathbb{G}$ are

$$
H \mathbb{G}_{x}=\operatorname{span}\left\{X_{1}(x), \ldots, X_{m_{1}}(x)\right\}, \quad x \in \mathbb{G}
$$

A subriemannian structure is defined on $\mathbb{G}$, endowing each fibre of $H \mathbb{G}$ with a scalar product $\langle\cdot, \cdot\rangle_{x}$ and with a norm $|\cdot|_{x}$ that make the basis $X_{1}(x), \ldots, X_{m_{1}}(x)$ an orthonormal basis. That is if $v=\sum_{i=1}^{m_{1}} v_{i} X_{i}(x)=\left(v_{1}, \ldots, v_{m_{1}}\right)$ and $w=\sum_{i=1}^{m_{1}} w_{i} X_{i}(x)=\left(w_{1}, \ldots, w_{m_{1}}\right)$ are in $H \mathbb{G}_{x}$, then $\langle v, w\rangle_{x}:=\sum_{j=1}^{m_{1}} v_{j} w_{j}$ and $|v|_{x}^{2}:=\langle v, v\rangle_{x}$.

The sections of $H \mathbb{G}$ are called horizontal sections, and for any $x \in \mathbb{G}$, a vector of $H \mathbb{G}_{x}$ is an horizontal vector while any vector in $T \mathbb{G}_{x}$ that is not horizontal is a vertical vector. Each horizontal section is identified by its canonical coordinates with respect to this moving frame $X_{1}(x), \ldots, X_{m_{1}}(x)$. This way, an horizontal section $\varphi$ is identified with a function $\varphi=$ $\left(\varphi_{1}, \ldots, \varphi_{m_{1}}\right): \mathbb{R}^{n} \rightarrow \mathbb{R}^{m_{1}}$. When dealing with two horizontal sections $\phi$ and $\psi$, we drop the index $x$ in the scalar product and in the norm.

We collect in the following results some properties of the group operation and of the canonical vector fields, see [7].

Proposition 2.2. The group operation has the following form

$$
x \cdot y=x+y+\mathcal{Q}(x, y), \quad \text { for all } x, y \in \mathbb{G}
$$

where $\mathcal{Q}=\left(\mathcal{Q}_{1}, \ldots, \mathcal{Q}_{n}\right): \mathbb{G} \times \mathbb{G} \rightarrow \mathbb{G}$ and every $\mathcal{Q}_{i}$, for $i=1, \ldots, n$, is a homogeneous polynomial of degree $\alpha_{i}$ respecting the intrinsic dilations of $\mathbb{G}$, that is

$$
\mathcal{Q}_{i}\left(\delta_{\lambda} x, \delta_{\lambda} y\right)=\lambda^{\alpha_{i}} \mathcal{Q}_{i}(x, y) \quad \text { for all } x, y \in \mathbb{G} \quad \text { and } \quad \text { for } \lambda>0 .
$$

Moreover, for all $x, y \in \mathbb{G}$ we have
(i) $\mathcal{Q}$ is antisymmetric, that is

$$
\mathcal{Q}_{i}(x, y)=-\mathcal{Q}_{i}(-y,-x), \quad \text { for } i=1, \ldots, n
$$

$$
\begin{gather*}
\mathcal{Q}_{1}(x, y)=\ldots=\mathcal{Q}_{m_{1}}(y, x)=0  \tag{ii}\\
\mathcal{Q}_{i}(x, 0)=\mathcal{Q}_{i}(0, y)=0 \text { and } \mathcal{Q}_{i}(x, x)=\mathcal{Q}_{i}(x,-x)=0, \quad \text { for } m_{1}<i \leqslant n \\
\mathcal{Q}_{i}(x, y)=\mathcal{Q}_{i}\left(x_{1},, x_{h_{j}-1}, y_{1}, \ldots, y_{h_{j}-1}\right), \quad \text { if } 1<j \leqslant k \text { and } i \leqslant h_{j}
\end{gather*}
$$

$$
\begin{equation*}
\mathcal{Q}_{i}(x, y)=\sum_{k, h} \mathcal{R}_{h, k}^{i}(x, y)\left(x_{k} y_{h}-x_{h} y_{k}\right) \tag{iii}
\end{equation*}
$$

where the functions $\mathcal{R}_{h, k}^{i}$ are homogeneous polynomials of degree $\alpha_{i}-\alpha_{k}-\alpha_{h}$ which respect the intrinsic dilations and the sum is extended to all $h$ and $k$ such that $\alpha_{h}+\alpha_{k} \leqslant$ $\alpha_{i}$.

The following result is contained in [46, Proposition 2.2].
Proposition 2.3. The vector fields $X_{j}$ have polynomial coefficients and are of the form

$$
\begin{equation*}
X_{j}(x)=\partial_{j}+\sum_{i>h_{l}}^{n} q_{i, j}(x) \partial_{i}, \quad \text { for } j=1, \ldots, n \quad \text { and } j \leqslant h_{l} \tag{2.4}
\end{equation*}
$$

where $q_{i, j}(x)=\left.\frac{\partial \mathcal{Q}_{i}}{\partial y_{j}}(x, y)\right|_{y=0}$ (the $\mathcal{Q}_{i}$ are those defined in the proposition (2.2) for $h_{l-1}<j \leqslant h_{l}$ and $1 \leqslant l \leqslant k$; so if $h_{l-1}<j \leqslant h_{l}$ then $q_{i, j}(x)=q_{i, j}\left(x_{1}, \ldots, x_{h_{l-1}}\right)$ and $q_{i, j}(0)=0$.
2.2. Intrinsic distance and gauge pseudo-distance. An absolutely continuous curve $\gamma$ : $[0, T] \rightarrow \mathbb{G}$ is called sub-unitary with respect to $X_{1}, \ldots, X_{m_{1}}$ if it is a horizontal curve, that is, if there exist real measurable functions $c_{1}, \ldots, c_{m_{1}}:[0, T] \rightarrow \mathbb{R}$ such that

$$
\dot{\gamma}(s)=\sum_{j=1}^{m_{1}} c_{j}(s) X_{j}(\gamma(s)), \quad \text { for } \mathcal{L}^{1} \text {-a.e. } s \in[0, T]
$$

with $\sum_{j=1}^{m_{1}} c_{j}(s)^{2} \leqslant 1$, for $\mathcal{L}^{1}$-a.e. $s \in[0, T]$.

Definition 2.4 (Carnot-Carathéodory distance). Let $\mathbb{G}$ be a Carnot group. For $p, q \in \mathbb{G}$ we define their Carnot-Carathéodory distance $d_{c}(p, q)$ as

$$
d_{c}(p, q):=\inf \{T>0: \text { it exists an sub-unitary curve } \gamma \text { with , } \gamma(0)=p, \gamma(T)=q\} .
$$

The last definition is well-placed: the set of sub-unitary curves connecting $p$ and $q$ is nonempty, by Chow's theorem ([7, Theorem 19.1.3]), since by (2.1), the rank of the Lie algebra generated by $X_{1}, \ldots, X_{m_{1}}$ is $n$; hence, $d_{c}$ is a distance on $\mathbb{G}$ inducing the same topology as the standard Euclidean distance. We shall denote by $B_{r}(p)$ the open balls, centred in $p$ of radius $r>0$, associated with the distance $d_{c}$. For the sake of simplicity, if $p=e$ we will use the notation $B_{r}(e)=B_{r}$.

The Carnot-Carathéodory metric $d_{c}$ is equivalent to a more explicitly defined pseudo-distance, called the gauge pseudo-distance, defined as follows. Let $\|\cdot\|$ denote the Euclidean distance to the origin in the Lie algebra $\mathfrak{g}$. For $u=u_{1}+\cdots+u_{k} \in \mathfrak{g}$ with $u_{i} \in V_{i}$, one defines

$$
\begin{equation*}
|u|_{\mathfrak{g}}:=\left(\sum_{i=1}^{k}\left\|u_{i}\right\|^{2 r!/ i}\right)^{\frac{1}{2 r!}} \tag{2.5}
\end{equation*}
$$

The non-isotropic gauge in $\mathbb{G}$ is defined by letting

$$
\begin{equation*}
|p|_{\mathbb{G}}=\left|\exp ^{-1} p\right|_{\mathfrak{g}}, \quad p \in \mathbb{G} \tag{2.6}
\end{equation*}
$$

see [39] and [40]. Since the exponential mapping exp : $\mathfrak{g} \rightarrow \mathbb{G}$ is of class $C^{\infty}$ (actually analitic) diffeomorphism, the maps $p \rightarrow|p|_{\mathbb{G}}$ is $C^{\infty}(\mathbb{G} \backslash\{e\})$. Notice that from (2.5) and (2.2) we have for any $\lambda>0$

$$
\begin{equation*}
\left|\delta_{\lambda}(p)\right|_{\mathbb{G}}=\lambda|p|_{\mathbb{G}} . \tag{2.7}
\end{equation*}
$$

The gauge pseudo-distance in $\mathbb{G}$ is defined by

$$
\begin{equation*}
d(p, q):=\left|p^{-1} \cdot q\right|_{\mathbb{G}} . \tag{2.8}
\end{equation*}
$$

The function $d$ has all the properties of a distance, except symmetry and the triangle inequality, which is satisfied with a universal constant, usually different from one on the right-hand side, see [40, 7]. Since the dilatations are group automorphisms, from (2.8) and (2.7), it follows that $d$ id homogeneous of degree one with respect to the group dilatation, that is for any $\lambda>0$

$$
\begin{equation*}
d\left(\delta_{\lambda}(p), \delta_{\lambda}\left(p^{\prime}\right)\right)=\lambda d\left(p, p^{\prime}\right) \tag{2.9}
\end{equation*}
$$

It is well known, see for instance Proposition 5.1.4 in [7], that there exist universal constants $\Lambda_{\mathbb{G}}$ such that for $p \in \mathbb{G}$ one has

$$
\begin{equation*}
\Lambda_{\mathbb{G}}^{-1}|p|_{\mathbb{G}} \leqslant d_{c}(e, p) \leqslant \Lambda_{\mathbb{G}}|p|_{\mathbb{G}} \tag{2.10}
\end{equation*}
$$

The integer

$$
Q:=\sum_{j=1}^{n} \alpha_{j}=\sum_{i=1}^{k} i \operatorname{dim}\left(V_{i}\right)
$$

is the homogeneous dimension of $\mathbb{G}$. It is the Hausdorff dimension of $\mathbb{G} \cong \mathbb{R}^{n}$ with respect to the distance $d_{c}$, see [68].

The $n$-dimensional Lebesgue measure $\mathcal{L}^{n}$, is the Haar measure of the group $\mathbb{G}$ that is, for every $\mathcal{L}^{n}$-measurable set $E \subset \mathbb{G}$ and for each $x \in \mathbb{G}$ it results $\mathcal{L}^{n}(x \cdot E)=\mathcal{L}^{n}(E)$. Moreover, if $\lambda>0$ then $\mathcal{L}^{n}\left(\delta_{\lambda}(E)\right)=\lambda^{Q} \mathcal{L}^{n}(E)$. In particular, for any $r>0$ and any $p \in \mathbb{G}$, it holds

$$
\mathcal{L}^{n}\left(B_{r}(p)\right)=r^{Q} \mathcal{L}^{n}\left(B_{1}(p)\right)=r^{Q} \mathcal{L}^{n}\left(B_{1}\right)
$$

where $Q$ is the homogeneous dimension.
All the spaces $L^{p}(\mathbb{G})$ that we will consider are defined with respect to the Lebesgue measure $\mathcal{L}^{n}$. If $A \subset \mathbb{G}$ is $\mathcal{L}^{n}$-measurable, we write $|A|=\mathcal{L}^{n}(A)$.

A map $L: \mathbb{G} \rightarrow \mathbb{R}$ is $\mathbb{G}$-linear if it is a group homeomorphism from $\mathbb{G} \equiv\left(\mathbb{R}^{n}, \cdot\right)$ to $(\mathbb{R},+)$ and if it is homogeneous of degree 1 with respect to the intrinsic dilations of $\mathbb{G}$, that is $L\left(\delta_{\lambda} x\right)=\lambda L x$ for $\lambda>0$ and $x \in \mathbb{G}$. Similarly, we say that a map $\ell: \mathbb{G} \rightarrow \mathbb{R}$ is $\mathbb{G}$-affine if there exists a linear map and $L$ and $c \in \mathbb{R}$ such that $\ell(x)=L(x)+c$, for every $x \in \mathbb{G}$.

Given a basis $X_{1}, \ldots, X_{n}$, all $\mathbb{G}$-linear maps are represented as follows.
Proposition 2.5. A map $L: \mathbb{G} \rightarrow \mathbb{R}$ is $\mathbb{G}$-linear if and only if there is $a=\left(a_{1}, \ldots, a_{m_{1}}\right) \in \mathbb{R}^{m_{1}}$ such that, if $x=\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{G}$, then

$$
L(x)=\sum_{i=1}^{m_{1}} a_{i} x_{i} .
$$

Moreover, if $x=\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{G}$ and $x_{0} \in \mathbb{G}$ are given, we set

$$
\pi_{x_{0}}(x):=\sum_{j=1}^{m_{1}} x_{j} X_{j}\left(x_{0}\right)
$$

2.3. Folland-Stein and horizontal Sobolev classes. Fixed $\Omega \subseteq \mathbb{G}$, the action of vector fields $X_{j}$, with $j=1, \ldots, m_{1}$ on a function $f: \Omega \rightarrow \mathbb{R}$ is specified by the Lie derivative: we say that a function $f$ is differentiable along direction $X_{j}$, for $j=1, \ldots, m_{1}$, in $x_{0} \in \mathbb{G}$ if the map $\lambda \mapsto f\left(\tau_{x_{0}}\left(\delta_{\lambda}\left(e_{j}\right)\right)\right.$ is differentiable in $\lambda=0$, where $e_{j}$ is the $j$-th vector of the canonical basis of $\mathbb{R}^{m_{1}}$. In this case, we will write

$$
X_{j} f\left(x_{0}\right)=\left.\frac{d}{d \lambda} f\left(\tau_{x_{0}}\left(\delta_{\lambda} e_{j}\right)\right)\right|_{\lambda=0}
$$

If instead $f \in L_{\text {loc }}^{1}(\Omega), X_{j} f$ exists in a weak sense, if

$$
\int_{\Omega} f X_{j} \varphi d \mathcal{L}^{n}=-\int_{\Omega} \varphi X_{j} f d \mathcal{L}^{n}
$$

for each $\varphi \in C_{0}^{\infty}(\Omega)$.
Once a basis $X_{1}, \ldots, X_{m_{1}}$ of the horizontal layer is fixed we define, for any function $f: \Omega \rightarrow \mathbb{R}$ for which the partial derivatives $X_{j} f$ exist, the horizontal gradient of $f$, denoted by $\nabla_{\mathbb{G}} f$, is
defined as the horizontal section

$$
\begin{equation*}
\nabla_{\mathbb{G}} f:=\sum_{i=1}^{m}\left(X_{i} f\right) X_{i}, \tag{2.11}
\end{equation*}
$$

whose coordinates are $\left(X_{1} f, \ldots, X_{m_{1}} f\right)$. Moreover, if $\phi=\left(\phi_{1}, \ldots, \phi_{m_{1}}\right)$ is an horizontal section such that $X_{j} \phi_{j} \in L_{l o c}^{1}(\mathbb{G})$ for $j=1, \ldots, m_{1}$, we define $\operatorname{div}_{\mathbb{G}} \phi$ as the real-valued function

$$
\begin{equation*}
\operatorname{div}_{\mathbb{G}} \phi:=-\sum_{j=1}^{m_{1}} X_{j}^{*} \phi_{j}=\sum_{j=1}^{m_{1}} X_{j} \phi_{j} \tag{2.12}
\end{equation*}
$$

The positive sub-Laplacian operator on $\mathbb{G}$ is the second-order differential operator, given by

$$
\mathcal{L}:=\sum_{j=1}^{m_{1}} X_{j}^{*} X_{j}=-\sum_{j=1}^{m_{1}} X_{j}^{2} .
$$

It is easy to see that

$$
\mathcal{L} u=-\operatorname{div}_{\mathbb{G}}\left(\nabla_{\mathbb{G}} u\right) .
$$

The operator $\mathcal{L}$ is left-invariant with respect to group translations and homogeneous of degree two with respect to group dilatations, i.e. for any $x \in \mathbb{G}$ and $\lambda>0$ we have

$$
\mathcal{L}\left(u \circ \tau_{x}\right)=(\mathcal{L} u) \circ \tau_{x}, \quad \mathcal{L}\left(\delta_{\lambda} u\right)=\lambda^{2} \delta_{\lambda}(\mathcal{L} u)
$$

Furthermore, by the assumptions 2.1, the system $\left\{X_{1}, \ldots, X_{m_{1}}\right\}$ satisfies the finite rank condition

$$
\operatorname{rank} \operatorname{Lie}\left[X_{1}, \ldots, X_{m_{1}}\right]=n
$$

therefore by Hörmander's theorem [55] the operator $\mathcal{L}$ is hypoelliptic. However, when the step $k$ of $\mathbb{G}$ is greater than one, the operator $\mathcal{L}$ fails to be elliptic at every point of $\mathbb{G}$.

More in general, given $1<p<\infty$ we consider the quasilinear operator, known as the p-sub-Laplacian, defined by

$$
\begin{equation*}
\mathcal{L}_{p} u:=\sum_{j=1}^{m_{1}} X_{j}\left(\left|\nabla_{\mathbb{G}} u\right|^{p-2} X_{j} u\right) . \tag{2.13}
\end{equation*}
$$

The Hölder classes $C^{k, \alpha}$ has been introduced by Folland and Stein, see [39,40]. The functions in these classes are Hölder continuous with respect to the metric $d_{c}$

Definition 2.6 (Folland-Stein classes). Let $\Omega \subseteq \mathbb{G}$ an open set and $0<\alpha \leqslant 1$ and $u: \Omega \rightarrow \mathbb{R}$ a function. We say that $u \in C^{0, \alpha}(\Omega)$ if there exists a constant $M>0$, such that

$$
|u(x)-u(y)| \leqslant M d_{c}(x, y)^{\alpha}, \quad \text { for every } \quad x, y \in \Omega
$$

Defining the Hölder seminorm of $u \in C^{0, \alpha}(\Omega)$ as

$$
\begin{equation*}
[u]_{C^{0, \alpha}(\Omega)}:=\sup _{\substack{x, y \in \Omega \\ x \neq y \\ 10}} \frac{|u(x)-u(y)|}{d_{c}(x, y)^{\alpha}}, \tag{2.14}
\end{equation*}
$$

the space $C^{0, \alpha}(\Omega)$ is a Banach space with respect to the norm

$$
\|u\|_{C^{0, \alpha}(\Omega)}:=\|u\|_{L^{\infty}(\Omega)}+[u]_{C^{0, \alpha}(\Omega)} .
$$

For any $k \in \mathbb{N}$, the spaces $C^{k, \alpha}(\Omega)$ are defined inductively as follows: we say that $u \in C^{k, \alpha}(\Omega)$ if $X_{i} u \in C^{k-1, \alpha}(\Omega)$ for every $i=1, \ldots, m_{1}$.

In the following, we will place with $C^{k, \lambda}(\Omega, H \mathbb{G})$ the space of all the horizontal sections $\phi: \Omega \rightarrow H \mathbb{G}$ with $\phi:=\left(\phi_{1}, \ldots, \phi_{m_{1}}\right)$, such that $\phi_{j} \in C^{k, \lambda}(\Omega)$, for $j=1, \ldots, m_{1}$. While if $u \in C^{k, \alpha}\left(\Omega^{\prime}\right)$, for any $\Omega^{\prime} \subset \subset \Omega$ we will set $u \in C_{l o c}^{k, \alpha}(\Omega)$.

Finally, note that the class $C^{0,1}(\Omega)$ coincides with the class of Lipschitz continuous function on $\Omega$ with respect to the metric $d_{c}$.

Definition 2.7 (Horizontal Sobolev spaces). Given an open set $\Omega \subseteq \mathbb{G}$, a function $u: \Omega \rightarrow \mathbb{R}$ and $1 \leqslant p<\infty$, the Horizontal Sobolev spaces are defined as

$$
H W^{1, p}(\Omega):=\left\{u \in L^{p}(\Omega): X_{j} u \in L^{p}(\Omega), \text { for all } j=1, \ldots, m_{1}\right\}
$$

which is a Banach space with the norm

$$
\|u\|_{H W^{1, p}(\Omega)}:=\|u\|_{L^{p}(\Omega)}+\left\|\nabla_{\mathbb{G}} u\right\|_{L^{p}(\Omega, H \mathbb{G})} .
$$

The subspace $H W_{0}^{1, p}(\Omega)$ of $H W^{1, p}(\Omega)$ are defined as the closure with respect the norm $\|\cdot\|_{H W^{1, p}(\Omega)}$ of $C_{0}^{\infty}(\Omega)$.
Definition 2.8 (Morrey-Campanato spaces). Let $\Omega \subseteq \mathbb{G}$. For every $1 \leqslant p<+\infty$ and $\lambda \in$ $(0,+\infty)$, an horizontal section $f=\left(f_{1}, \ldots, f_{m_{1}}\right) \in L_{\text {loc }}^{p}(\Omega, H \mathbb{G})$, is said to be in the MorreyCampanato space $\mathcal{E}^{\lambda, p}(\Omega, H \mathbb{G})$ if

$$
[f]_{\mathcal{E}^{\lambda, p}(\Omega, H \mathbb{G})}:=\sup _{B \subset \Omega}\left(\frac{1}{|B|^{1+p \lambda}} \int_{B}\left|f(y)-\mathbf{f}_{\mathbf{B}}(y)\right|^{p} d y\right)^{1 / p}<+\infty
$$

where the supremum is taken over all balls $B \subset \Omega$ and $\mathbf{f}_{\mathbf{B}}$ is the constant horizontal section given by

$$
\mathbf{f}_{\mathbf{B}}(y):=\sum_{i=1}^{m_{1}}\left(f_{B} f_{i}(z) d z\right) X_{i}(y), \quad \text { for } y \in \Omega
$$

Remark 2.9. For every $u=\left(u_{1}, \ldots, u_{m_{1}}\right) \in \mathcal{E}^{\lambda, p}(\Omega, H \mathbb{G})$, the quantity $[u]_{\mathcal{E}^{p, \lambda}(\Omega, H \mathbb{G})}$ is a seminorm in $\mathcal{E}^{\lambda, p}(\Omega, H \mathbb{G})$ and it is equivalent to the quantity

$$
\begin{equation*}
\sup _{B \subset \Omega}\left(\frac{1}{|B|^{1+p \lambda}} \inf _{\boldsymbol{\xi}} \int_{B}|u(x)-\boldsymbol{\xi}(x)|^{p} d x\right)^{1 / p} \tag{2.15}
\end{equation*}
$$

where the infimum is taken over all the constant horizontal sections such that

$$
\begin{equation*}
\boldsymbol{\xi}(x):=\sum_{i=1}^{m_{1}} \xi_{i} X_{i}(x), \quad \text { for } x \in \mathbb{G} \text { and some } \xi:=\left(\xi_{1}, \ldots, \xi_{m_{1}}\right) \in \mathbb{R}^{m_{1}} \tag{2.16}
\end{equation*}
$$

For the proof we refer to Remark 3.6 in [34].

Theorem 2.10. ([65, Theorem 5]) For every $\Omega \subseteq \mathbb{G}, \lambda \in(0,1)$ and $p \in[1,+\infty)$ one has

$$
\mathcal{E}^{\lambda, p}(\Omega, H \mathbb{G})=C^{0, \lambda}(\Omega, H \mathbb{G})
$$

More precisely, it results that a function $\phi$ belongs to $\mathcal{E}^{\lambda, p}(\Omega, H \mathbb{G})$ if and only if $\phi$ is equal $\mathcal{L}^{n}$-almost everywhere to a function $\psi$ with belongs to the Hölder class $C^{0, \lambda}(\Omega, H \mathbb{G})$. Moreover the seminorms $[\phi]_{\mathcal{E}^{\lambda, p}(\Omega, H \mathbb{G})}$ and $[\psi]_{C^{0, \lambda}(\Omega, H \mathbb{G})}$ are equivalent.

## 3. The ( $\mathbb{G}, p$ )-HARMONiC REPLACEMENT

In this section, we recall the notion of $(\mathbb{G}, p)$-harmonic replacement.
Definition 3.1. Let $\Omega \subseteq \mathbb{G}$ an open set and $u \in H W^{1, p}(\Omega)$. We say that $v \in H W^{1, p}(\Omega)$ is the $(\mathbb{G}, p)$-harmonic replacement of $u$ in $\Omega$ if

$$
\begin{equation*}
\int_{\Omega}\left|\nabla_{\mathbb{G}} v\right|^{p} d x=\min _{u-w \in H W_{0}^{1, p}(\Omega)} \int_{\Omega}\left|\nabla_{\mathbb{G}} w\right|^{p} d x \tag{3.1}
\end{equation*}
$$

In particular, if $v$ is the $(\mathbb{G}, p)$-harmonic replacement of $u$ in $\Omega$, it satisfies the critical condition

$$
\begin{equation*}
\int_{\Omega}\left|\nabla_{\mathbb{G}} v(x)\right|^{p-2}\left\langle\nabla_{\mathbb{G}} v(x), \nabla_{\mathbb{G}} \varphi(x)\right\rangle d x=0 \tag{3.2}
\end{equation*}
$$

for all $\varphi \in H W_{0}^{1, p}(\Omega)$, i.e. $v$ is the unique weak solution for the Dirichlet problem

$$
\left\{\begin{array}{c}
\mathcal{L}_{p} v=0 \quad \text { in } \Omega  \tag{3.3}\\
u-v \in H W_{0}^{1, p}(\Omega)
\end{array}\right.
$$

In the following Lemma, we provide some energy estimates for the ( $\mathbb{G}, p$ )-harmonic replacement, which will be useful in the sequel.

Lemma 3.2. Let $\Omega \subseteq \mathbb{G}$ open and $u \in H W^{1, p}(\Omega)$. Let $v$ be the $(\mathbb{G}, p)$-harmonic replacement of $u$ in $\Omega$. Then,
(i) if $1<p<2$, then

$$
\begin{align*}
& \int_{\Omega}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{p} d x \\
& \quad \leqslant C\left(\int_{\Omega}\left(\left|\nabla_{\mathbb{G}} u(x)\right|^{p}-\left|\nabla_{\mathbb{G}} v(x)\right|^{p}\right) d x\right)^{\frac{p}{2}}\left(\int_{\Omega}\left(\left|\nabla_{\mathbb{G}} u(x)\right|+\left|\nabla_{\mathbb{G}} v(x)\right|\right)^{p} d x\right)^{1-\frac{p}{2}}, \tag{3.4}
\end{align*}
$$

for some positive constant $C$ depending only on $\mathbb{G}$ and $p$;
(ii) if $p \geqslant 2$, then

$$
\begin{equation*}
\int_{\Omega}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{p} d x \leqslant C \int_{\Omega}\left(\left|\nabla_{\mathbb{G}} u(x)\right|^{p}-\left|\nabla_{\mathbb{G}} v(x)\right|^{p}\right) d x \tag{3.5}
\end{equation*}
$$

for some positive constant $C$ depending only on $\mathbb{G}$ and $p$.

Proof. For all $s \in[0,1]$, we consider the family of functions $u_{s}(x):=s u(x)+(1-s) v(x)$, so that $u_{0}=v$ and $u_{1}=u$. As a consequence,

$$
\begin{aligned}
\int_{\Omega}\left(\left|\nabla_{\mathbb{G}} u(x)\right|^{p}-\left|\nabla_{\mathbb{G}} v(x)\right|^{p}\right) d x & =\int_{\Omega}\left(\int_{0}^{1} \frac{d}{d s}\left|\nabla_{\mathbb{G}} u_{s}(x)\right|^{p} d s\right) d x \\
& =\int_{\Omega}\left(\int_{0}^{1} p\left|\nabla_{\mathbb{G}} u_{s}(x)\right|^{p-2}\left\langle\nabla_{\mathbb{G}} u_{s}(x), \nabla_{\mathbb{G}}(u-v)(x)\right\rangle d s\right) d x
\end{aligned}
$$

Since $u-v \in H W_{0}^{1, p}(\Omega)$, using it as test function in (3.2), by Fubini's Theorem we get

$$
\begin{aligned}
& \int_{\Omega}\left(\left|\nabla_{\mathbb{G}} u(x)\right|^{p}-\left|\nabla_{\mathbb{G}} v(x)\right|^{p}\right) d x \\
&=p {\left[\int_{\Omega}\left(\int_{0}^{1}\left|\nabla_{\mathbb{G}} u_{s}(x)\right|^{p-2}\left\langle\nabla_{\mathbb{G}} u_{s}(x), \nabla_{\mathbb{G}}(u-v)(x)\right\rangle d s\right) d x\right.} \\
&\left.\quad-\int_{0}^{1}\left(\int_{\Omega}\left|\nabla_{\mathbb{G}} v(x)\right|^{p-2}\left\langle\nabla_{\mathbb{G}} v(x), \nabla_{\mathbb{G}}(u-v)(x)\right\rangle d x\right) d s\right] \\
&=\left.p \int_{0}^{1}\left(\left.\int_{\Omega \cap A}\langle | \nabla_{\mathbb{G}} u_{s}(x)\right|^{p-2} \nabla_{\mathbb{G}} u_{s}(x)-\left|\nabla_{\mathbb{G}} v(x)\right|^{p-2} \nabla_{\mathbb{G}} v(x), \nabla_{\mathbb{G}}(u-v)(x)\right\rangle d x\right) d s
\end{aligned}
$$

where $A=\left\{x \in \Omega:\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|>0\right\}$. Then, recalling that,

By apply some well-known inequalities (see e.g. Section 3 of [20] or Lemma 2.1 in [19]), for any horizontal sections $\boldsymbol{\xi}, \boldsymbol{\zeta}: \mathbb{G} \rightarrow H \mathbb{G}$ such that $|\boldsymbol{\xi}|+|\boldsymbol{\zeta}|>0$ in $\mathbb{G}$ any for any $1<p<\infty$ we have

Step 1: the case $1<p<2$. At first, we notice that we can apply inequalities (3.8) with the choices $\boldsymbol{\xi}:=\nabla_{\mathbb{G}} u$ and $\boldsymbol{\zeta}:=\nabla_{\mathbb{G}} v$ on $A$. Indeed, by (3.6), for any $x \in A$, it results

&=p \gamma \int_{0}^{1} s\left(\int_{\Omega \cap A}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{2}\left(\left|\nabla_{\mathbb{G}} u_{s}(x)\right|+\left|\nabla_{\mathbb{G}} v(x)\right|\right)^{p-2} d x\right) d s \\
&=p \gamma \int_{0}^{1} s\left(\int_{\Omega}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{2}\left(\left|\nabla_{\mathbb{G}} u_{s}(x)\right|+\left|\nabla_{\mathbb{G}} v(x)\right|\right)^{p-2} d x\right) d s

where in the first equality we used the identity in (3.6).
Furthermore, recalling that $s \in[0,1]$, for any $x \in \Omega$ we have that

& \quad=p \gamma 2^{p-3} \int_{\Omega}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{2}\left(\left|\nabla_{\mathbb{G}} u(x)\right|+\left|\nabla_{\mathbb{G}} v(x)\right|\right)^{p-2} d x .
\end{align*}

Moreover, one has

& 3.12)  \tag{3.12}\\
& \leqslant\left(\int_{\Omega}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{2}\left(\left|\nabla_{\mathbb{G}} u(x)\right|+\left|\nabla_{\mathbb{G}} v(x)\right|\right)^{p-2} d x\right)^{\frac{p}{2}} \\
& \cdot\left(\int_{\Omega}\left(\left|\nabla_{\mathbb{G}} u(x)\right|+\left|\nabla_{\mathbb{G}} v(x)\right|\right)^{p} d x\right)^{1-\frac{p}{2}} .
\end{align*}

where in last inequality we apply the Hölder's inequality with Hölder exponent $2 / p$ and conjugate exponent

for some suitable constant $C>0$, depending only on $\mathbb{G}$ and $p$. This proves concludes the proof of (3.4) when $1<p<2$.
Step 2: the case $p \geqslant 2$. Applying inequalities (3.9) with the choices $\boldsymbol{\xi}:=\nabla_{\mathbb{G}} u$ and $\boldsymbol{\zeta}:=\nabla_{\mathbb{G}} v$ and using estimate (3.7), we obtain

& =p \gamma \int_{0}^{1} s^{p-1}\left(\int_{\Omega}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{p} d x\right) d s \\
& =\gamma \int_{\Omega}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{p} d x

where in the first equality we used the identity in (3.6). This establishes (3.5) when $p \geqslant 2$ and completes the proof of Lemma 3.2.

## 4. A Dichotomy Result

As a first step, we a prove a dichotomy result. Roughly speaking, two situations can occur: either the average of the energy of an almost minimizer decreases in a smaller ball, or the distance of its horizontal gradient and a suitable constant horizontal section becomes as small as we wish. This implies that $\mathbb{G}$-affine functions are the only ones for which the average does not improve in small balls.

Our first result is the following:
Proposition 4.1. Let $u \in H W^{1, p}\left(B_{1}\right)$ be such that

there exists $\varepsilon_{0} \in(0,1)$ such that for every $\varepsilon \in\left(0, \varepsilon_{0}\right)$ there exist $\eta \in(0,1), M \geqslant 1$ and $\sigma_{0} \in(0,1)$, depending on $\varepsilon, Q$ and $p$, such that, if $\sigma \in\left[0, \sigma_{0}\right]$ and $a \geqslant M$, then the following dichotomy holds. Either

Proof. We split the proof into several steps.
Step 1: pointwise estimates. Let $v \in H W^{1, p}\left(B_{1}\right)$ be the ( $\mathbb{G}, p$-harmonic replacement of $u$ in $B_{1}$. By Theorem 1.1 in [17], it exists a constant $C_{0}>0$, depending only on $p$ and $Q$, such that

for some $\alpha=\alpha(Q, p) \in(0,1]$ and some constant $c>0$ depending only on $p$ and $\mathbb{G}$. Therefore, for every $x \in B_{\eta}$ we have

thus, for any $i=1, \ldots, m_{1}$ denoting by $q_{i}=X_{i} v(0)$ and by $\mathbf{q}: \mathbb{G} \rightarrow H \mathbb{G}$ the constant horizontal section defined as in (4.5), it turns out

& \leqslant C_{1} \eta^{p \alpha} a^{p}
\end{align*}

for some $\alpha \in(0,1]$ and $C_{1}>0$ depending only on $p$ and $\mathbb{G}$.
Step 3: proximity to the $(\mathbb{G}, p)$-harmonic replacement. By hypothesis (4.1) and the minimality of $v$ in (3.1), for all $\sigma<\left|B_{1}\right|$, we obtain

& \leqslant C\left(\sigma \int_{B_{1}}\left|\nabla_{\mathbb{G}} v(x)\right|^{p} d x+1\right)  \tag{4.13}\\
& \leqslant C\left(\sigma \int_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x+1\right)
\end{align*}

for some suitable positive constant $C$ depending only on $Q$.
Now we distinguish two cases, $p \geqslant 2$ and $1<p<2$.
Step 3.1: the case $p \geqslant 2$. If $p \geqslant 2$, then from (3.5) and (4.13) we deduce that

& \leqslant 2^{p-1}\left(C \eta^{-Q}\left(\sigma a^{p}+1\right)+C_{1} a^{p} \eta^{p \alpha}\right), \\
& =2^{p-1} C \eta^{-Q} \sigma a^{p}+2^{p-1} C \eta^{-Q}+2^{p-1} C_{1} a^{p} \eta^{p \alpha} .
\end{aligned}

This yields that

Step 3.2: the case $1<p<2$. If $1<p<2$, by virtue of (3.4) and (4.13), we obtain that

& \leqslant C\left(\sigma^{\frac{p}{2}}\left(\int_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{\frac{p}{2}}+1\right)\left(\int_{B_{1}}\left(\left|\nabla_{\mathbb{G}} u(x)\right|^{p}+\left|\nabla_{\mathbb{G}} v(x)\right|^{p}\right) d x\right)^{1-\frac{p}{2}}
\end{aligned}
$$

Thus, since $v$ is the $(\mathbb{G}, p)$-harmonic replacement of $u$ in $B_{1}$,

& \leqslant C\left(\sigma^{\frac{p}{2}}\left(\int_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{\frac{p}{2}}+1\right)\left(\int_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1-\frac{p}{2}} \\
&=C\left(\sigma^{\frac{p}{2}} \int_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x+\left(\int_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1-\frac{p}{2}}\right)
\end{aligned}
$$

Consequently, taking the average integral, we have that

f_{B_{\eta}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}\right|^{p} d x & \leqslant 2^{p-1} f_{B_{\eta}}\left(\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{p}+\left|\nabla_{\mathbb{G}} v(x)-\mathbf{q}\right|^{p}\right) d x \\
& \leqslant 2^{p-1}\left(\frac{\left|B_{1}\right|}{\left|B_{\eta}\right|} f_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right|^{p} d x+C_{1} \eta^{\alpha p} a^{p}\right) \\
& \leqslant 2^{p-1} C \eta^{-Q} \sigma^{\frac{p}{2}} a^{p}+2^{p-1} C \eta^{-Q} a^{p\left(1-\frac{p}{2}\right)}+2^{p-1} C_{1} a^{p} \eta^{\alpha p} .
\end{aligned}
$$

This gives that

\begin{equation*}
f_{B_{\eta}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x \leqslant 2^{2(p-1)} C \eta^{-Q} \sigma^{\frac{p}{2}} a^{p}+2^{2(p-1)} C \eta^{-Q} a^{p\left(1-\frac{p}{2}\right)}+2^{2(p-1)} C_{1} a^{p} \eta^{\alpha p}+2^{p-1}|\mathbf{q}|^{p} \tag{4.17}
\end{equation*}
$$

Step 4: perturbative estimates. Now, given $\varepsilon_{0} \in(0,1 / 4]$, we claim that for every $\varepsilon \in\left(0, \epsilon_{0}\right)$ there exists $\eta$ small enough (depending on $\varepsilon$ ) such that if $\sigma$ is chosen sufficiently small and $a$ sufficiently large (depending on $\eta$, and thus on $\varepsilon$ ) then

2^{2(p-1)} C \eta^{-Q} \sigma a^{p}+2^{2(p-1)} C \eta^{-Q}+2^{2(p-1)} C_{1} a^{p} \eta^{\alpha p} \leqslant 2^{p-1} \varepsilon^{p} a^{p} \leqslant \frac{a^{p}}{2^{p+1}} \quad \text { if } p \geqslant 2 \tag{4.18}
\end{equation*}
$$

while

$$
\begin{equation*}
2^{2(p-1)} C \eta^{-Q} \sigma^{\frac{p}{2}} a^{p}+2^{2(p-1)} C \eta^{-Q} a^{p\left(1-\frac{p}{2}\right)}+2^{2(p-1)} C_{1} a^{p} \eta^{\alpha p} \leqslant 2^{p-1} \varepsilon^{p} a^{p} \leqslant \frac{a^{p}}{2^{p+1}} \quad \text { if } 1<p<2 \tag{4.19}
\end{equation*}
$$

To prove this we distinguish two cases.
Step 4.1: the case $p \geqslant 2$. If $p \geqslant 2$, we pick $\eta>0$ sufficiently small such that

\varepsilon^{p}-2^{p-1} C \eta>2^{p-1} C_{1} \eta^{\alpha p} .
$$

This allows us to define

Note also that we can suppose $M \geqslant 1$ by taking $\eta$ small enough. Let also

$$

With this setting, we obtain that, for every $a \geqslant M$ and for every $0<\sigma \leqslant \sigma_{0}$,

& 2^{2(p-1)} C \eta^{-Q} \sigma a^{p}+2^{2(p-1)} C \eta^{-Q}+2^{2(p-1)} C_{1} a^{p} \eta^{\alpha p} \\
\leqslant & a^{p}\left(2^{2(p-1)} C \eta+2^{2(p-1)} C_{1} \eta^{\alpha p}\right)+2^{2(p-1)} C \eta^{-Q} \\
= & a^{p}\left(2^{2(p-1)} C \eta+2^{2(p-1)} C_{1} \eta^{\alpha p}\right)+2^{p-1} M^{p}\left(\varepsilon^{p}-2^{p-1} C \eta-2^{p-1} C_{1} \eta^{\alpha p}\right) \\
\leqslant & a^{p}\left(2^{2(p-1)} C \eta+2^{2(p-1)} C_{1} \eta^{\alpha p}\right)+2^{p-1} a^{p}\left(\varepsilon^{p}-2^{p-1} C \eta-2^{p-1} C_{1} \eta^{\alpha p}\right) \\
= & 2^{p-1} \varepsilon^{p} a^{p}+a^{p}\left(2^{2(p-1)} C \eta+2^{2(p-1)} C_{1} \eta^{\alpha p}-2^{2(p-1)} C \eta-2^{2(p-1)} C_{1} \eta^{\alpha p}\right) \\
& 19
\end{aligned}
$$

$$
=2^{p-1} \varepsilon^{p} a^{p}
$$

which proves (4.18).
Step 4.2: the case $1<p<2$. If instead $1<p<2$, we pick $\eta>0$ small enough such that

$$
\varepsilon^{p}>2^{p-1} C \eta+2^{p-1} C_{1} \eta^{\alpha p}
$$

In this way, we can define

$$
M:=\left(\frac{C 2^{p-1} \eta^{-Q}}{\varepsilon^{p}-2^{p-1} C \eta-2^{p-1} C_{1} \eta^{\alpha p}}\right)^{2 / p^{2}}
$$

Let also $\sigma_{0}:=\eta^{(Q+1) \frac{2}{p}}$. Then, whenever $a \geqslant M$ and $0<\sigma \leqslant \sigma_{0}$ it follows that

& \leqslant 2^{2(p-1)} C \eta a^{p}+2^{2(p-1)} C \eta^{-Q} a^{p\left(1-\frac{p}{2}\right)}+2^{2(p-1)} C_{1} a^{p} \eta^{\alpha p} \\
& =2^{p-1} a^{p}\left(2^{p-1} C \eta+2^{p-1} C \eta^{-Q} a^{-\frac{p^{2}}{2}}+2^{p-1} C_{1} \eta^{\alpha p}\right) \\
& \leqslant 2^{p-1} a^{p}\left(2^{p-1} C \eta+2^{p-1} C \eta^{-Q} M^{-\frac{p^{2}}{2}}+2^{p-1} C_{1} \eta^{\alpha p}\right) \\
& =2^{p-1} a^{p}\left(2^{p-1} C \eta+\varepsilon^{p}-2^{p-1} C \eta-2^{p-1} C_{1} \eta^{\alpha p}+2^{p-1} C_{1} \eta^{\alpha p}\right) \\
& =2^{p-1} \varepsilon^{p} a^{p},
\end{aligned}
$$

which establishes (4.19).
Step 5: conclusion of the proof. In order to complete the proof of Proposition 4.1, we now distinguish two cases according to the size of $|\mathbf{q}|$. More precisely, we first suppose that

Then, using (4.15) and (4.18) if $p \geqslant 2$ or (4.17) and (4.18) if $1<p<2$, we conclude that

f_{B_{\eta}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x \leqslant \frac{a^{p}}{2^{p+1}}+2^{p-1} \frac{a^{p}}{2^{2 p}}=\frac{a^{p}}{2^{p+1}}+\frac{a^{p}}{2^{p+1}}=\frac{a^{p}}{2^{p}},
$$

and thus

\left(f_{B_{\eta}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p} \leqslant \frac{a}{2}
$$

which is the first alternative in (4.3).
Otherwise, it holds that

\frac{a}{4}<|\mathbf{q}| \leqslant C_{0} a
$$

and therefore, by either (4.14) and (4.18) if $p \geqslant 2$ or (4.16) and (4.19) if $1<p<2$, we conclude that

\left(f_{B_{\eta}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)\right|^{p} d x\right)^{1 / p} \leqslant \varepsilon a,
$$

which is the second alternative in (4.4). The proof of Proposition 4.1 is thereby complete.

## 5. Regularity estimates for a subelliptic equation with variable coefficients

Now, our aim is to prove that the alternative in (4.4) can be improved when $\varepsilon$ and $\sigma$ are sufficiently small. On the other hand, differently from what happens when $p=2$ (see Lemma 3.2 in [34]), here the main difficulty relies on the fact that the problem is not linear when $p \neq 2$. Therefore, for example, if $v_{1}$ and $v_{2}$ are the $(\mathbb{G}, p)$-harmonic replacements of $u_{1}$ and $u_{2}$ in $\Omega \subset \mathbb{G}$, then it is not true that $v_{1}+v_{2}$ is the $(\mathbb{G}, p)$-harmonic replacement of $u_{1}+u_{2}$, unless $p=2$.

To overcome this difficulty, our goal is to show that affine perturbation of $(\mathbb{G}, p)$-harmonic replacements satisfied a suitable subelliptic equation. With this purpose, in this section we prove some $C^{1, \alpha}$ regularity estimate that will we useful to obtain the counterpart of Lemma 3.2 in [34] in our nonlinear setting.

More precisely, we will show the following result.
Theorem 5.1. Let $\mathbb{G}$ be a Carnot group of step 2 and let $\Omega \subset \mathbb{G}$ be an open set. Let $u \in$ $H W^{1,2}(\Omega)$, be a weak solution of

\begin{equation*}
\operatorname{div}_{\mathbb{G}}\left(A(x) \nabla_{\mathbb{G}} u(x)\right)=0, \quad \text { for } x \in \Omega, \tag{5.1}
\end{equation*}
$$

where $A: \Omega \rightarrow \mathbb{R}^{m_{1} \times m_{1}}$ satisfies the following structure condition, for any $x, y \in \Omega$

$$
\begin{gather*}
\nu|\xi|^{2} \leqslant\langle A(x) \xi, \xi\rangle \leqslant L|\xi|^{2}, \quad \text { for all } \xi \in H \mathbb{G}_{x}  \tag{5.2}\\
|A(x)-A(y)| \leqslant L^{\prime} d(x, y)^{\alpha} \tag{5.3}
\end{gather*}
$$

for some $\nu>0$ and $L, L^{\prime} \geqslant 1$ and $\alpha \in(0,1]$. Then $\nabla_{\mathbb{G}} u \in C_{\text {loc }}^{0, \gamma}(\Omega)$, for some $\gamma=\gamma(\mathbb{G}, \nu, L, \alpha) \in$ $(0,1)$. Moreover, there exists a constant $c=c(\mathbb{G}, \nu, L)>0$ such that for any $x_{0} \in \Omega$ it exists $\bar{R}=\bar{R}\left(\mathbb{G}, \nu, L, L^{\prime}, \alpha, \operatorname{dist}\left(x_{0}, \partial \Omega\right)\right)>0$ such that for any $x, y \in B_{R}\left(x_{0}\right) \subset \Omega$, with $0<R \leqslant \bar{R}$ it follows

$$
\begin{equation*}
\max _{1 \leqslant i \leqslant m_{1}}\left|X_{i}(x)-X_{i}(y)\right| \leqslant c d_{c}(x, y)^{\gamma} f_{B_{R}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)\right| d x \tag{5.4}
\end{equation*}
$$

Remark 5.2. The regularity and apriori estimates of the homogeneous equation corresponding to (5.1) with freezing of the coefficients is a key tool. Fixed $x_{0} \in \Omega$, we consider the equation

$$
\begin{equation*}
\operatorname{div}_{\mathbb{G}}\left(A\left(x_{0}\right) \nabla_{\mathbb{G}} u\right)=0 \quad \text { in } \Omega \tag{5.5}
\end{equation*}
$$

The $C^{1, \alpha}$ regularity of sub-elliptic equation of the form (5.5) within Carnot Groups of step two, under assumption (5.2) and (5.3), has been dealt with in [17] (see also [72] in the case of Heisenberg group). In particular, in Theorem 1.1 in [17], similar as the Euclidean case
(see [30, 66]), the following local estimate can be shown by using Sobolev's inequality and Moser's iteration on the Caccioppoli type inequalities: for any $0<\sigma<1$ and metric ball $B_{R}=B_{R}\left(x_{0}\right) \subset \Omega$, it results

\begin{equation*}
\sup _{B_{\sigma R}}\left|\nabla_{\mathbb{G}} u\right| \leqslant c(1-\sigma)^{-\frac{Q}{2}}\left(f_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right|^{2} d x\right)^{\frac{1}{2}} \tag{5.6}
\end{equation*}
$$

for some $c=c(\mathbb{G}, \nu, L)>0$. Furthermore, by another standard iteration argument proved in Lemma 3.38. in [54], for any $0<q<2,0<\sigma<1$ and metric ball $B_{R}=B_{R}\left(x_{0}\right) \subset \Omega$, we obtain the following estimate

$$
\begin{equation*}
\sup _{B_{\sigma R}}\left|\nabla_{\mathbb{G}} u\right| \leqslant c(1-\sigma)^{-\frac{Q}{q}}\left(f_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right|^{q} d x\right)^{\frac{1}{q}} \tag{5.7}
\end{equation*}
$$

for some $c=c(\mathbb{G}, \nu, L, q)>0$.
We recall the notion of De Giorgi's class of functions in this setting, which would be required for Proposition 5.4.
Definition 5.3 (De Giorgi's class). For any $x \in \mathbb{G}$, and any metric ball $B_{\rho_{0}}(x) \subset \mathbb{G}$, the De Giorgi's class $D G^{+}\left(B_{\rho_{0}}\right)$ consists of functions $w \in H W^{1,2}\left(B_{\rho_{0}}(x)\right) \cap L^{\infty}\left(B_{\rho_{0}}(x)\right)$, which satisfy the inequality

$$
\begin{equation*}
\int_{B_{\rho^{\prime}}(x)}\left|\nabla_{\mathbb{G}}(w(x)-k)^{+}\right|^{2} d x \leqslant \frac{\gamma}{\left(\rho-\rho^{\prime}\right)^{2}} \int_{B_{\rho}(x)}\left|(w(x)-k)^{+}\right|^{2} d x+\chi^{2}\left|A_{k, \rho}^{+}(w)\right|^{1-\frac{2}{Q}+\epsilon} \tag{5.8}
\end{equation*}
$$

for some $\gamma, \chi, \epsilon>0$, where $A_{k, \rho}^{+}(w)=\left\{x \in B_{\rho}:(w(x)-k)^{+}=\max (w(x)-k, 0)>0\right\}$ for any arbitrary $k \in \mathbb{R}$, and $0<\rho^{\prime}<\rho \leqslant \rho_{0}$. The class $D G^{-}\left(B_{\rho_{0}}(x)\right)$ are similarly defined replacing $(w-k)^{+}$with $(w-k)^{-}$in (5.8). We set $D G\left(B_{\rho_{0}}(x)\right):=D G^{+}\left(B_{\rho_{0}}(x)\right) \cap D G^{-}\left(B_{\rho_{0}}(x)\right)$.
5.1. Comparison estimates. In this subsection, we prove some comparison estimates that will be useful in the proof of Theorem 5.1. We follow closely the approach of [32] in the Euclidean case, and of [71] for the Heisenberg group. From here on out, $\mathbb{G}$ will a Carnot group of step two and we denote $u \in H W^{1,2}(\Omega)$ as a weak solution of (5.1).

As a first step, relying on the regularity results in [17], we prove an integral oscillation decay estimate of the solution of the equation corresponding to (5.1) with freezing coefficient, see (5.9) below.

Proposition 5.4. Let $x_{0} \in \Omega$, and $r_{0}>0$ such that $=B_{r_{0}}\left(x_{0}\right) \subset \Omega$. Let $u \in C^{1, \sigma}(\Omega)$ for some $\sigma \in(0,1]$ be a weak solution of the equation corresponding to (5.1) with freezing coefficients in $x_{0}$, i.e.

$$
\begin{equation*}
\operatorname{div}_{\mathbb{G}}\left(A\left(x_{0}\right) \nabla_{\mathbb{G}} u(x)\right)=0, \quad \text { for } x \in \Omega \tag{5.9}
\end{equation*}
$$

Then there exist $c=c(\mathbb{G}, L)>0$, and $\beta=\beta(\mathbb{G})>0$ and such that for all $0<\varrho<r<r_{0}$, we have

$$
\begin{equation*}
f_{B_{\varrho}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)-\left(\nabla_{\mathbb{G}} u\right)_{B_{\varrho}\left(x_{0}\right)}\right| d x \leqslant c\left(\frac{\varrho}{r}\right)^{\beta}\left(f_{B_{r}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)-\left(\nabla_{\mathbb{G}} u\right)_{B_{r}\left(x_{0}\right)}\right| d x+\chi r^{\beta}\right) \tag{5.10}
\end{equation*}
$$

with $\chi:=M\left(r_{0}\right) / r_{0}^{\beta}$, where

$$
M\left(r_{0}\right)=\max _{1 \leqslant i \leqslant m_{1}} \sup _{B_{r_{0}}\left(x_{0}\right)}\left|X_{i} u\right| .
$$

Proof. Since in the proof we will consider all concentric balls centred in $x_{0} \in \mathbb{G}$, for the seek of brevity we will denote $B \varrho=B_{\varrho}\left(x_{0}\right)$ for every $\varrho>0$. Moreover let us denote by

$$
\begin{equation*}
M(\varrho):=\max _{1 \leqslant i \leqslant m_{1}} \sup _{B_{\varrho}}\left|X_{i} u\right|, \quad \omega(\varrho):=\max _{1 \leqslant i \leqslant m_{1}} \operatorname{osc}_{B_{\varrho}} X_{i} u \quad \text { and } \quad I(\varrho)=f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} u-\left(\nabla_{\mathbb{G}} u\right)_{B_{\varrho}}\right| d x \tag{5.11}
\end{equation*}
$$

for every $0<\varrho<r_{0}$. By definition follows trivially that

$$
\begin{equation*}
\omega(\varrho)=\max _{1 \leqslant i \leqslant m_{1}} \operatorname{osc}_{B_{\varrho}} X_{i} u=\max _{1 \leqslant i \leqslant m_{1}} \sup _{B_{\varrho}} X_{i} u-\inf _{B_{\varrho}} X_{i} u \leqslant \max _{1 \leqslant i \leqslant m_{1}} 2 \sup _{B_{\varrho}} X_{i} u=2 M(\varrho) . \tag{5.12}
\end{equation*}
$$

Now, since the operator appearing in (5.10) has constant coefficients, the equation (5.10) has been dealt with in those in [17]. Thus applying the decay oscillation Lemma proved in [17, Lemma 5.9] we know there there exists a constant $s \geqslant 0$ depending only on $\mathbb{G}$, such that for every $0<r \leqslant r_{0} / 16$, we have

\begin{equation*}
\omega(r) \leqslant\left(1-2^{-s}\right) \omega(8 r)+2^{s} M\left(r_{0}\right)\left(\frac{r}{r_{0}}\right)^{\frac{1}{2}} \tag{5.13}
\end{equation*}
$$

for all $\beta=\beta \in(0,1 / 2]$. Up to take $\beta \in(0,1 / 2]$ sufficiently small, since $\omega=\omega(\varrho)$ is a positive and increasing function for every $\varrho>0$, we are in position to apply the standard iteration scheme proved in [53, Lemma 7.3] on (5.13), which implies that for any $0<\varrho<r \leqslant r_{0}$, we get

\begin{equation*}
\omega(\varrho) \leqslant c\left(\left(\frac{\varrho}{r}\right)^{\beta} \omega(r)+\chi \varrho^{\beta}\right)=c\left(\frac{\varrho}{r}\right)^{\beta}\left(\omega(r)+\chi r^{\beta}\right) \tag{5.14}
\end{equation*}
$$

whit $\chi=M\left(r_{0}\right) / r_{0}^{\beta}$ and some constant $c>0$ depending only on $\mathbb{G}$. We notice that if $\varrho \leqslant \delta r$ for some $\delta \in(0,1)$, since, up to some constant $c>0$ depending only on $\mathbb{G}$, we have

I(\varrho)=f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} u(x)-\left(\nabla_{\mathbb{G}} u\right)_{B_{\varrho}}\right| d x \leqslant f_{B_{\varrho}} f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} u(y)\right| d x d y \leqslant c \omega(\varrho)
$$

we can conclude from (5.14) that

$$
\begin{equation*}
I(\varrho) \leqslant c \omega(\varrho) \leqslant c \delta^{-\beta}\left(\frac{\varrho}{r}\right)^{\beta}\left(\omega(\delta r)+\chi r^{\beta}\right) \tag{5.15}
\end{equation*}
$$

for some $c>0$ depending only on $\mathbb{G}$. Now we claim that, to conclude the proof it is enough to prove that there exists $\delta \in(0,1)$, depending only on $\mathbb{G}$ such that the inequality

$$
\begin{equation*}
\omega(\delta r) \leqslant c\left(I(r)+\chi r^{\beta}\right) \tag{5.16}
\end{equation*}
$$

holds for some universal $c>0$. Indeed combing (5.16) with (5.15), we get (5.10).

To prove the claim in (5.16), let us fix $r^{\prime}:=\delta r$, where $\delta \in(0,1)$ is to be chosen precisely later on. At first, we notice that there is no loss of generality by assuming that

\omega(r) \geqslant M\left(r_{0}\right)\left(\frac{r}{r_{0}}\right)^{\beta} \tag{5.17}
\end{equation*}

since, otherwise (5.16) trivially holds. Similarly, as in [17, 71, 32] we consider the following complementary cases.

Case 1: For at least one index $l \in\left\{1, \ldots, m_{1}\right\}$, we have

\text { either }\left|B_{4 r^{\prime}} \cap\left\{X_{l} u<\frac{M\left(4 r^{\prime}\right)}{4}\right\}\right| \leqslant \theta\left|B_{4 r^{\prime}}\right| \text { or }\left|B_{4 r^{\prime}} \cap\left\{X_{l} u>-\frac{M\left(4 r^{\prime}\right)}{4}\right\}\right| \leqslant \theta\left|B_{4 r^{\prime}}\right| .
$$

where in $\theta>0$ is the universal constant in [17, Corollary 5.6]. Similarly to the proof of Case 1 in the proof of [17, Lemma 5.9], combing [17, Corollary 5.6] and [17, Lemma 5.7] we conclude that for any $j=1, \ldots, m_{1}, X_{j} u$ belong to the De Giorgi class $D G^{+}\left(B_{2 r^{\prime}}\right)$. Now by replacing $\left(X_{l} u-k\right)^{+}$with $\left(X_{l} u-k\right)^{-}$and $A_{k, r}^{+}\left(X_{l} u\right)$ with $A_{k, r}^{-}\left(X_{l} u\right)$, we car apply again [17, Lemma 5.7] to conclude that for any $j=1, \ldots, m_{1}$, so $X_{j} u$ belong to the De Giorgi class $D G^{-}\left(B_{2 r^{\prime}}\right)$ as well, $X_{j} u \in D G\left(B_{2 r^{\prime}}\right)$ for every $j=1, \ldots, m_{1}$. Thus, in particular, the following local boundedness estimates hold

& \sup _{B_{r^{\prime}}}\left(X_{j} u-\vartheta\right) \leqslant c\left(f_{B_{2 r^{\prime}}}\left(X_{j} u-\vartheta\right)^{+} d x+\chi r^{\prime \beta}\right),  \tag{5.18}\\
& \sup _{B_{r^{\prime}}}\left(\vartheta-X_{j} u\right) \leqslant c\left(f_{B_{2 r^{\prime}}}\left(\vartheta-X_{j} u(x)\right)^{+} d x+\chi r^{\prime \beta}\right), \tag{5.19}
\end{align*}
$$

for any $\vartheta<M\left(r^{\prime}\right)$ and $j=1, \ldots, m_{1}$. Now, adding (5.18) and (5.19) with $\vartheta=\left(X_{i} u\right)_{B_{r^{\prime}}}$, we get

Then there exists a constant $c=c(\mathbb{G}, \nu, L)>0$ such that

&=\int_{B_{R}}\left\langle A\left(x_{0}\right) \nabla_{\mathbb{G}} u(x)-A(x) \nabla_{\mathbb{G}} u(x), \nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right\rangle d x \\

5.2. Proof of the Theorem 5.1. In this section, we present the proof Theorem 5.1. As above, throughout this subsection, we denote by $u \in H W^{1, p}(\Omega)$ a weak solution of the equation (5.1). Furthermore, fixed $x_{0} \in \Omega$, for all concentric metric balls centered in $x_{0}$ we set $B_{\rho}=B_{\rho}\left(x_{0}\right)$ for every $\rho>0$.

With respect to the given data, let us set

& \leqslant \leqslant\left(\frac{\rho}{R}\right)^{Q} \int_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right| d x+c \int_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right| d x \\
& \leqslant \leqslant c\left(\frac{\rho}{R}\right)^{Q} \int_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right| d x+c\left(L^{\prime} R^{\alpha}\right)^{\frac{1}{2}} f_{B_{2} R}\left|\nabla_{\mathbb{G}} u(x)\right| d x
\end{align*}

fro some renaming constant $c>0$, depending only on $Q$. This concludes the proof of (5.35).
Now using Lemma 5.6 and a standard perturbation lemma (see Lemma 2.1. in [50, Chapter III]) we obtain the following regularity estimate.
Proposition 5.7. There exists $c=c(Q, \nu, L)>0$ such that,

& \leqslant 2 f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} v(x)-\left(\nabla_{\mathbb{G}} v\right)_{B_{e}}\right| d x+2 f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right| d x .
\end{aligned}
$$

Now, we shall estimate both terms of the right-hand side of (5.48) separately.
At first, we notice that

$$
f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} v(x)-\left(\nabla_{\mathbb{G}} v\right)_{B_{e}}\right| d x \leqslant f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} v(x)\right| d x+\left|\left(\nabla_{\mathbb{G}} v\right)_{B_{\varrho}}\right| \leqslant 2 f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} v(x)\right| d x
$$

as a consequence, applying estimate (5.10) (note that $v$ solution of (5.28) by Theorem 1.3 of [17] is of class $C^{1, \beta}$ for some $\left.\beta \in(0,1]\right)$ and choosing $q=1$ in (5.7) we obtain

& \leqslant c\left(\frac{\rho}{r}\right)^{\beta}\left(\int_{B_{r}}\left|\nabla_{\mathbb{G}} v(x)\right| d x+c \sup _{B_{2 r}}\left|\nabla_{\mathbb{G}} v\right|\right) \\
& \leqslant c\left(\frac{\rho}{r}\right)^{\beta} \int_{B_{4 r}}\left|\nabla_{\mathbb{G}} v(x)\right| d x .
\end{align*}
$$

Using (5.49), we estimate the first term of (5.48) as

f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} v(x)-\left(\nabla_{\mathbb{G}} v\right)_{B_{\varrho}}\right| d x & \leqslant c\left(\frac{\varrho}{r}\right)^{\beta} f_{B_{4 r}}\left|\nabla_{\mathbb{G}} v(x)\right| d x \\
& \leqslant c\left(\frac{\varrho}{r}\right)^{\beta} f_{B_{4 r}}\left|\nabla_{\mathbb{G}} u(x)\right| d x+c\left(\frac{\varrho}{r}\right)^{\beta} f_{B_{4 r}}\left|\nabla_{\mathbb{G}} v(x)-\nabla_{\mathbb{G}} u(x)\right| d x
\end{aligned}
$$

The second term of (5.48) is estimated simply as

f_{B_{\varrho}}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right| d x \leqslant c\left(\frac{r}{\varrho}\right)^{Q} f_{B_{2 r}}\left|\nabla_{\mathbb{G}} u(x)-\nabla_{\mathbb{G}} v(x)\right| d x

that together (5.48) and (5.43) implies
Now we are ready to prove Theorem 5.1.
Proof of Theorem 5.1. Let us consider $0<\varrho<r<R / 4<\bar{R} / 4$. From Lemma 5.8, we get

\end{equation*}

and from (5.45) of Proposition 5.7. we have,

\int_{B_{4 r}}\left|\nabla_{\mathbb{G}} u(x)\right| d x \leqslant c\left(\frac{r}{R}\right)^{Q-\bar{\varepsilon}} \int_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right| d x \tag{5.51}
\end{equation*}
$$

Now, combing (5.51) and (5.50), we obtain

\int_{B_{\varrho}}\left|\nabla_{\mathbb{G}} u(x)-\left(\nabla_{\mathbb{G}} u\right)_{B_{\varrho}}\right| d x \leqslant c\left(\frac{\varrho^{Q+\beta} R^{\bar{\varepsilon}}}{r^{\beta+\bar{\varepsilon}} R^{Q}}\right) \int_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right| d x+c\left(L^{\prime} r^{\alpha}\right)^{\frac{1}{2}}\left(\frac{r}{R}\right)^{Q-\bar{\varepsilon}} \int_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right| d x . \tag{5.52}
\end{equation*}
$$

Moreover, choosing

\bar{\varepsilon}<\alpha / 2, \quad \delta<\alpha / 2-\bar{\varepsilon}_{30} \quad \text { and } \quad L^{\prime} \bar{R}^{\alpha-(\delta+\bar{\varepsilon})}<1
$$

we obtain the estimate

$$
\begin{equation*}
\int_{B_{\varrho}}\left|\nabla_{\mathbb{G}} u(x)-\left(\nabla_{\mathbb{G}} u\right)_{B_{\varrho}}\right| d x \leqslant c\left(\frac{\varrho^{Q+\beta}}{r^{\beta+\bar{\varepsilon}}}+r^{Q+\delta}\right) f_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right| d x \tag{5.53}
\end{equation*}
$$

Now, since $0<\varrho<r<1$, for some $\kappa \in(0,1)$, we can choose $r=\varrho^{\kappa}$, in (5.53) to obtain

\begin{aligned}
\int_{B_{\varrho}}\left|\nabla_{\mathbb{G}} u(x)-\left(\nabla_{\mathbb{G}} u\right)_{B_{e}}\right| d x & \leqslant c\left(\varrho^{Q+(1-\kappa) \beta-\kappa \bar{\varepsilon}}+\varrho^{\kappa(Q+\delta)}\right) f_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right| d x \\
& \leqslant c \varrho^{Q+\lambda} f_{B_{R}}\left|\nabla_{\mathbb{G}} u(x)\right| d x
\end{aligned}
$$

where the latter inequality follows when $Q+\lambda \leqslant \min \{Q+(1-\kappa) \beta-\kappa \bar{\varepsilon}, \kappa(Q+\lambda)\}$; indeed we can make sure that this is true with the choice of $\kappa=\kappa(\lambda)$ such that

for any $0<\lambda<\beta \delta /(Q+\beta+\delta+\bar{\varepsilon})$. Moreover, as soon as $\lambda, \bar{\varepsilon}$ are small enough, $\kappa=\kappa(\lambda)$ can be chosen close enough to 1 to make sure that $\varrho^{\kappa} \leqslant R$, whenever $0<\varrho<R$. Thus, we have obtained

for any $0<\varrho<R \leqslant \bar{R}$. By the arbitrariness of of $0<\varrho<R$, it follows that $\nabla_{\mathbb{G}} u \in$ $\mathcal{E}^{\gamma, 1}\left(B_{R}, H \mathbb{G}\right)$, with $\gamma=\lambda / Q$. The proof follows by applying Theorem 2.10,

Remark 5.9. In the assumption of Theorem 5.1, fixed $x_{0} \in \Omega$ and $R>0$ such that $2 R<\bar{R}$, by (5.4) and triangular inequality, for any $x, y \in B_{R}\left(x_{0}\right)$, it exists a constant $C>0$, depending only on $\mathbb{G}$, such that

\left|\nabla_{\mathbb{G}} u(x)\right|-\left|\nabla_{\mathbb{G}} u(y)\right| & \leqslant C \max _{1 \leqslant i \leqslant m_{1}}\left|X_{i}(x)-X_{i}(y)\right| \\
& \leqslant c_{0} d_{c}(x, y)^{\gamma} f_{B_{R}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)\right| d x \leqslant c_{0} R^{\gamma} f_{B_{R}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)\right| d x \tag{5.56}
\end{align*}
$$

up to renaming constant $c_{0}=c_{0}(\mathbb{G}, \nu, L)>0$. This implies for any $x \in B_{R}\left(x_{0}\right)$,

$$
\begin{equation*}
\left|\nabla_{\mathbb{G}} u(x)\right| \leqslant c_{0} R^{\gamma} f_{B_{R}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)\right| d x+f_{B_{R}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(z)\right| d z \leqslant c_{1} f_{B_{2 R}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)\right| d x \tag{5.57}
\end{equation*}
$$

up to renaming constant $c_{1}=c_{1}(\mathbb{G}, Q, \nu, L, R, \gamma)>0$. Finally, by (5.57) and Jensen's inequality, for every $p \in[1, \infty)$, we obtain

\sup _{B_{R}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} \leqslant c_{2} f_{B_{2 R}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x \tag{5.58}
\end{equation*}

for some constant $c_{2}=c_{2}(\mathbb{G}, Q, \nu, L, R, \gamma, p)>0$.

## 6. Improvement of dichotomy

In this section, based on the regularity results presented in Section 5, we want to show that the alternative in (4.4) can be improved when $\varepsilon$ and $\sigma$ are sufficiently small.

Fist, we have the following Lemma that we will use later.
Lemma 6.1. Let $\mathbf{q}: \mathbb{G} \rightarrow H \mathbb{G}$ a constant horizontal section and let $\eta: \mathbb{G} \rightarrow H \mathbb{G}$ an horizontal section be such that $|\eta(x)|<\frac{|\mathbf{q}|}{2}$, for any $x \in \mathbb{G}$. Let $F: \mathbb{R}^{m_{1}} \rightarrow \mathbb{R}^{m_{1}}$ the map defined by $F(z):=|z|^{p-2} z$. Let us consider

A(x):=\int_{0}^{1} D_{z} F(\mathbf{q}(x)+t \eta(x)) d t
$$

where, for $z \in H \mathbb{G}_{x}$, the Euclidean vector fields on $H \mathbb{G}_{x} \cong \mathbb{R}^{m_{1}}$ are denoted as $D_{z_{j}}$ for $j=$ $1, \ldots, m_{1}$ and $D_{z}=\left(D_{z_{1}} \ldots, D_{z_{m_{1}}}\right)$ is the Euclidean gradient. Then,

$$
\lambda|q|^{p-2}|\xi|^{2} \leqslant\langle A(x) \xi, \xi\rangle \leqslant \Lambda|q|^{p-2}|\xi|^{2}
$$

for any $x \in \mathbb{G}$ and $\xi \in H \mathbb{G}_{x}$, and some $\Lambda \geqslant \lambda>0$, depending on $p$.
Proof. First of all, we notice that, for all $t \in(0,1)$ and $x \in \mathbb{G}$, by triangular inequality, we have

& |\mathbf{q}(x)+\operatorname{t\eta }(x)| \leqslant|\mathbf{q}|+|\eta(x)|<|\mathbf{q}|+\frac{|\mathbf{q}|}{2}=\frac{3|\mathbf{q}|}{2}  \tag{6.1}\\
\text { and } \quad & |\mathbf{q}(x)+\operatorname{t\eta }(x)| \geqslant|\mathbf{q}|-|\eta(x)|>|\mathbf{q}|-\frac{|\mathbf{q}|}{2}=\frac{|\mathbf{q}|}{2} .
\end{align*}
$$

Furthermore, for $z \in H \mathbb{G}_{x} \cong \mathbb{R}^{m_{1}}$, it results

D_{z} F(z)=(p-2)|z|^{p-4} z \otimes z+|z|^{p-2} \mathrm{Id},
$$

where Id denotes the identity map on $H \mathbb{G}_{x} \cong \mathbb{R}^{m_{1}}$. As a consequence, for all $\xi \in H \mathbb{G}_{x}$,

\begin{aligned}
\left\langle D_{z} F(z) \xi, \xi\right\rangle & =(p-2)|z|^{p-4}(\langle z, \xi\rangle)^{2}+|z|^{p-2}|\xi|^{2} \\
& \geqslant-(2-p)^{+}|z|^{p-2}|\xi|^{2}+|z|^{p-2}|\xi|^{2} \\
& =\left(1-(2-p)^{+}\right)|z|^{p-2}|\xi|^{2},
\end{aligned}
$$

that by integration leads to

$$
\langle A(x) \xi, \xi\rangle \geqslant\left(1-(2-p)^{+}\right)|\xi|^{2} \int_{0}^{1}|\mathbf{q}(x)+t \eta(x)|^{p-2} d t .
$$

Then, using (6.1) we obtain

\langle A(x) \xi, \xi\rangle \geqslant \frac{1-(2-p)^{+}}{2^{p-2}}|\mathbf{q}|^{p-2}|\xi|^{2}
$$

if $p \geqslant 2$, and

\langle A(x) \xi, \xi\rangle \geqslant\left(1-(2-p)^{+}\right)\left(\frac{3}{2}\right)^{p-2}|\mathbf{q}|^{p-2}|\xi|^{2}
$$

if $p \in(1,2)$, for any $\xi \in H \mathbb{G}_{x}$.

Similarly, for any $z, \xi \in H \mathbb{G}_{x}$, it results

\begin{aligned}
\left\langle D_{z} F(z) \xi, \xi\right\rangle & =(p-2)|z|^{p-4}(\langle z, \xi\rangle)^{2}+|z|^{p-2}|\xi|^{2} \\
& \leqslant(p-2)^{+}|z|^{p-2}|\xi|^{2}+|z|^{p-2}|\xi|^{2} \\
& =\left(1+(p-2)^{+}\right)|z|^{p-2}|\xi|^{2}
\end{aligned}
$$

that by integration leads to

$$
\langle A(x) \xi, \xi\rangle \leqslant\left(1+(p-2)^{+}\right)|\xi|^{2} \int_{0}^{1}|\mathbf{q}(x)+t \eta(x)|^{p-2} d t
$$

Hence, making again use of (6.1),

$$
\langle A(x) \xi, \xi\rangle \leqslant\left(1+(p-2)^{+}\right)\left(\frac{3}{2}\right)^{p-2}|\mathbf{q}|^{p-2}|\xi|^{2}
$$

if $p \geqslant 2$, and

$$
\langle A(x) \xi, \xi\rangle \leqslant \frac{1+(p-2)^{+}}{2^{p-2}}|\mathbf{q}|^{p-2}|\xi|^{2}
$$

if $p \in(1,2)$, for any $\xi \in H \mathbb{G}_{x}$. The proof of Lemma 6.1 is completed by choosing

$$
\lambda:=\left\{\begin{array}{cc}
\frac{1-(2-p)^{+}}{2^{p-2}}, & \text { if } p \geqslant 2 \\
\left(1-(2-p)^{+}\right)\left(\frac{3}{2}\right)^{p-2}, & \text { if } p \in(1,2)
\end{array}\right.
$$

and

$$
\Lambda:=\left\{\begin{array}{cc}
\left(1+(p-2)^{+}\right)\left(\frac{3}{2}\right)^{p-2}, & \text { if } p \geqslant 2 \\
\frac{1+(p-2)^{+}}{2^{p-2}}, & \text { if } p \in(1,2)
\end{array}\right.
$$

Herewith, we can now state the following result that represent the counterpart of Lemma 2.3 [28] in Euclidean setting and extends, in the more general nonlinear setting dealt with in this paper, Lemma 3.2 in [34].

Lemma 6.2. Suppose that $p>p^{\#}=p^{\#}(Q):=\frac{2 Q}{Q+2}$. Let $u \in H W^{1, p}\left(B_{1}\right)$ with be such that $u \geqslant 0$ a.e. in $B_{1}$ and

\end{equation*}

and suppose that $a \in\left[a_{0}, a_{1}\right]$, for some $a_{1}>a_{0}>0$. Assume also that

\begin{equation*}
\left(f_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)\right|^{p} d x\right)^{1 / p} \leqslant \varepsilon a, \tag{6.4}
\end{equation*}
$$

for some constant horizontal section $\mathbf{q}: \mathbb{G} \rightarrow H \mathbb{G}$ as in (4.5) such that

\frac{a}{8}<|\mathbf{q}| \leqslant 2 C_{0} a \tag{6.5}
\end{equation*}
$$

where $C_{0}>0$ is the universal constant in Proposition 4.1.
There exist $\alpha_{0} \in(0,1]$ depending on $Q$ and $p$, such that for every $\alpha \in\left(0, \alpha_{0}\right)$ there exist

- $\rho \in(0,1)$, depending on $Q, p$ and $\alpha$,
- $\varepsilon_{0} \in(0,1)$, depending on $Q, p, a_{0}, a_{1}$ and $\alpha$,
- $c_{0}>0$, depending on $Q, p, a_{0}, a_{1}$ and $\alpha$,
such that, if $\varepsilon \in\left(0, \varepsilon_{0}\right]$ and $\sigma \in\left(0, c_{0} \varepsilon^{P}\right]$, with $P:=\max \{p, 2\}$, then

\left(f_{B_{\rho}}\left|\nabla_{\mathbb{G}} u(x)-\widetilde{\mathbf{q}}(x)\right|^{p} d x\right)^{1 / p} \leqslant \rho^{\alpha} \varepsilon a \tag{6.6}

where $\widetilde{\mathbf{q}}: \mathbb{G} \rightarrow H \mathbb{G}$ is a constant horizontal section, i.e.

\end{equation*}

for some universal constant $\widetilde{C}>0$.
Proof of Lemma 6.2. We divide the proof into several steps.
Step 1: energy estimates for the $(\mathbb{G}, p)$-harmonic replacement and comparison of energies. Let us setting $\tau:=\frac{1}{2} \min \left\{\frac{1}{10 \Lambda_{\mathbb{G}}^{2}}, R_{0}\right\}$, where $\Lambda_{\mathbb{G}}$ in the structural constant given by (2.10) depending only on $\mathbb{G}$, and $R_{0}>0$ is the constant given by Theorem 2.2 in 63]. Since $\Lambda_{\mathbb{G}} \geqslant 1$, it results that $\tau<1$. Let $\bar{v}$ denote the $(\mathbb{G}, p)$-harmonic replacement of $u$ in $B_{\tau}$ and let $v$ be defined as

& \leqslant(1+\sigma) J_{p}\left(v, B_{1}\right)-J_{p}\left(u, B_{1} \backslash B_{\tau}\right) \\
& =J_{p}\left(v, B_{\tau}\right)+J_{p}\left(v, B_{1} \backslash B_{\tau}\right)+\sigma J_{p}\left(v, B_{\tau}\right)+\sigma J_{p}\left(v, B_{1} \backslash B_{\tau}\right)-J_{p}\left(u, B_{1} \backslash B_{\tau}\right)
\end{aligned}
$$

$$
\begin{align*}
& =J_{p}\left(v, B_{\tau}\right)+J_{p}\left(v, B_{1} \backslash B_{\tau}\right)+\sigma J_{p}\left(v, B_{1}\right)-J_{p}\left(u, B_{1} \backslash B_{\tau}\right)  \tag{6.10}\\
& =J_{p}\left(v, B_{\tau}\right)+J_{p}\left(u, B_{1} \backslash B_{\tau}\right)+\sigma J_{p}\left(v, B_{1}\right)-J_{p}\left(u, B_{1} \backslash B_{\tau}\right) \\
& =J_{p}\left(v, B_{\tau}\right)+\sigma J_{p}\left(v, B_{1}\right)
\end{align*}
$$

By the definition of $J_{p}$ in (1.1), (6.10) reads as

\int_{B_{\tau}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x+\left|\{u>0\} \cap B_{\tau}\right| & \leqslant \int_{B_{\tau}}\left|\nabla_{\mathbb{G}} v(x)\right|^{p} d x+\left|\{u>0\} \cap B_{\tau}\right|+\sigma J_{p}\left(v, B_{1}\right) \\
& \leqslant \int_{B_{\tau}}\left|\nabla_{\mathbb{G}} v(x)\right|^{p} d x+\left|B_{\tau}\right|+\sigma J_{p}\left(v, B_{1}\right)
\end{aligned}
$$

which, since $u \geqslant 0$ a.e. in $B_{1}$ by assumption, yields that

\int_{B_{\tau}}\left(\left|\nabla_{\mathbb{G}} u(x)\right|^{p}-\left|\nabla_{\mathbb{G}} v(x)\right|^{p}\right) d x \leqslant\left|\{u=0\} \cap B_{\tau}\right|+\sigma J_{p}\left(v, B_{1}\right) . \tag{6.11}
\end{equation*}

Moreover, by definition of $v$ in (6.9), we have

J_{p}\left(v, B_{1}\right) & =\int_{B_{1}}\left(\left|\nabla_{\mathbb{G}} v(x)\right|^{p}+\chi_{\{v>0\}}(x)\right) d x \\
& \leqslant \int_{B_{\tau}}\left|\nabla_{\mathbb{G}} v(x)\right|^{p} d x+\int_{B_{1} \backslash B_{\tau}}\left|\nabla_{\mathbb{G}} v(x)\right|^{p} d x+\left|B_{1}\right| \\
& =\int_{B_{\tau}}\left|\nabla_{\mathbb{G}} \bar{v}(x)\right|^{p} d x+\int_{B_{1} \backslash B_{\tau}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x+\left|B_{1}\right|  \tag{6.12}\\
& \leqslant \int_{B_{1}}\left|\nabla_{\mathbb{G}} u\right|^{p} d x+\left|B_{1}\right| \leqslant\left|B_{1}\right|\left(a^{p}+1\right)
\end{align*}
$$

where in the second inequality we use the fact that $\bar{v}$ is the $(\mathbb{G}, p)$-harmonic replacement of $u$ in $B_{\tau}$ and therefore $\bar{v}$ minimize $p$-Dirichlet energy on $B_{\tau}$.

Furthermore, if $p \geqslant 2$, by (3.5) and (6.11) we deduce that

& \leqslant C\left(\left|\{u=0\} \cap B_{\tau}\right|+\sigma J_{p}\left(v, B_{1}\right)\right)^{\frac{p}{2}}\left(\int_{B_{\tau}} 2^{p}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1-\frac{p}{2}} \\
& \leqslant C\left(\left|\{u=0\} \cap B_{\tau}\right|+\sigma\left(a^{p}+1\right)\right)^{\frac{p}{2}} a^{p\left(1-\frac{p}{2}\right)} .
\end{align*}
$$

Step 2: measure estimates for the zero level set. Now, we claim that

\mathcal{A}:=\left\{(t, \eta, \xi) \in \mathbb{R} \times \mathbb{R}^{m_{1}} \times \mathbb{R}^{m_{2}}: t \in\left[\frac{1}{4 \Lambda_{\mathbb{G}}}, \frac{3}{10 \Lambda_{\mathbb{G}}}\right], \sum_{j=1}^{m_{1}} \eta_{j}^{2} \leqslant \frac{1}{100 \Lambda_{\mathbb{G}}^{2}} \text { and } \sum_{i=m_{1}+1}^{m_{2}} \xi_{i}^{2} \leqslant \frac{1}{100 \Lambda_{\mathbb{G}}^{4}}\right\}
$$

We notice that if $x \in \mathcal{B}$ then

d_{c}(e, x)^{4} & \leqslant \Lambda_{\mathbb{G}}^{4}|x|_{\mathbb{G}}^{4}=\Lambda_{\mathbb{G}}^{4}\left(\sum_{j=1}^{m_{1}}\left(-\frac{t q_{j}}{|\mathbf{q}|}+\eta_{j}\right)^{2}\right)^{2}+\Lambda_{\mathbb{G}}^{4} \sum_{i=m_{1}+1}^{m_{2}} \xi_{i}^{2} \leqslant 4 \Lambda_{\mathbb{G}}^{4}\left(t^{2}+\sum_{j=1}^{m_{1}} \eta_{j}^{2}\right)^{2}+\Lambda_{\mathbb{G}}^{4} \sum_{i=m_{1}+1}^{m_{2}} \xi_{i}^{2} \\
& \leqslant 4 \Lambda_{\mathbb{G}}^{4}\left(\frac{9}{100 \Lambda_{\mathbb{G}}^{2}}+\frac{1}{100 \Lambda_{\mathbb{G}}^{2}}\right)^{2}+\frac{\Lambda_{\mathbb{G}}^{4}}{100 \Lambda_{\mathbb{G}}^{4}}=\frac{4}{100}+\frac{1}{100}=\frac{1}{20}<\frac{1}{10},
\end{aligned}

Now we aim to show that, even if $v-\langle\mathbf{q}, \pi$.$\rangle is not the (\mathbb{G}, p)$-harmonic replacement of $u-\langle\mathbf{q}, \pi$.$\rangle , as in the$ case $p=2$ (see Lemma 3.2 in [34]), it satisfies an appropriate equation in divergence form, as the ones studied in section 5.

Step 4.1: perturbative energy estimates. If $p \geqslant 2$, by (6.4) and (6.30), we obtain

& \leqslant C_{2} \varepsilon^{p} a^{p}+C\left(C_{1} \varepsilon^{p+\delta}+\sigma\left(a^{p}+1\right)\right)^{\frac{p}{2}} a^{p\left(1-\frac{p}{2}\right)},
\end{align*}
$$

up to renaming constants. Now in the case of $p \geqslant 2$, we suppose $\sigma \leqslant c_{0} \varepsilon^{p}$, for some constant $c_{0}>0$ that we will determine precisely later. Since by assumption $a \in\left[a_{0}, a_{1}\right]$, by (6.32), we infer that

\int_{B_{\tau}}\left|\nabla_{\mathbb{G}} v(x)-\mathbf{q}(x)\right|^{p} d x \leqslant C_{2} \varepsilon^{p} a^{p}+C_{1} \varepsilon^{p+\delta}+C c_{0} \varepsilon^{p}\left(a^{p}+1\right) \leqslant C \varepsilon^{p} a^{p}, \tag{6.34}
\end{equation*}
$$

up to relabeling $C>0$.
Similarly, if $1<p<2$, we take $\sigma \leqslant c_{0} \varepsilon^{2}$, with $c_{0}$ to be made precise later. In this case, we deduce from (6.33) that

& \leqslant C_{1} \varepsilon^{(p+\delta) \frac{p}{2}} a^{p}+C_{2} \varepsilon^{p} a^{p}
\end{align*}
$$

up to renaming the constants. Hitherto we have not used the assumption $p>p^{\#}=p^{\#}(Q)$, however now we use it to reabsorb the term $\varepsilon^{(p+\delta) \frac{p}{2}} a^{p}$ into the term $\varepsilon^{p} a^{p}$ appearing in (6.35).

Indeed, to avoid trivial situations we can suppose that $Q>2$, so we fall the case $p<Q$, and thus, recalling the value of $\delta$ given in (6.26), we obtain that

Thus we can assume that the maximum in (6.40) is achieved, i.e. it exist $\bar{x} \in \overline{B_{\tau / 2}}$ be such that

\end{equation*}

for some $c>0$ and $\alpha \in(0,1]$, depending only on $\mathbb{G}$ and $p$. Now applying, Theorem 1.1 in [17] and (6.9), we have

\end{equation*}

for some $\bar{C}>$ depending only on $\mathbb{G}$ and $p$. Now we chose $\varepsilon>0$ sufficiently small such that

& =C(\varepsilon a)^{\nu}-\frac{C(\varepsilon a)^{\nu}}{2}=\frac{C(\varepsilon a)^{\nu}}{2}
\end{aligned}
$$

for all $i=1, \ldots, m_{1}$. As a consequence, for some constant $\hat{c}$ depending only on $\mathbb{G}$, it result

\begin{aligned}
\int_{B_{\tau}}\left|\nabla_{\mathbb{G}} v(x)-\mathbf{q}(x)\right|^{p} d x & \geqslant \int_{B_{r^{*}}(\bar{x})}\left|\nabla_{\mathbb{G}} v(x)-q\right|^{p} d x \geqslant \hat{c} \int_{B_{r^{*}}(\bar{x}} \max _{1 \leqslant i \leqslant m_{1}}\left|X_{i} v(x)-q_{i}\right| d x \\
& \geqslant \hat{c}\left(\frac{C(\varepsilon a)^{\nu}}{2}\right)^{p}\left|B_{r^{*}}(\bar{x})\right|=\hat{c}\left(\frac{C(\varepsilon a)^{\nu}}{2}\right)^{p} \tau^{Q}\left(\frac{C(\varepsilon a)^{\nu}}{2 c \bar{C} a_{1}}\right)^{Q / \alpha}\left|B_{1}\right| \\
& =\hat{c} \frac{C^{p+\frac{Q}{\alpha}}\left|B_{\tau}\right|}{2^{p+\frac{Q}{\alpha}}\left(c \bar{C} a_{1}\right)^{\frac{Q}{\alpha}}}(\varepsilon a)^{\nu\left(p+\frac{Q}{\alpha}\right)} .

&=\int_{0}^{1} D_{z} F\left(t \nabla_{\mathbb{G}} v(x)+(1-t) \mathbf{q}(x)\right)\left(\nabla_{\mathbb{G}} v(x)-\mathbf{q}(x)\right) d t,
\end{align*}

where, for $z \in H \mathbb{G}_{x} \cong \mathbb{R}^{m_{1}}$, we set $D_{z} F=\left(D_{z_{1}} F \ldots, D_{z_{m_{1}}} F\right)$ the Euclidean gradient of $F$. Now, since $v$ is $(\mathbb{G}, p)$-harmonic in $B_{\tau}$ taking $\operatorname{div}_{\mathbb{G}}$ of both sides in (6.44), we obtain that

Indeed, by (6.48), we can choose $\nu=\lambda a_{0}^{p-2}$ and $L=\Lambda a_{1}^{p-2}$ in (5.2). Moreover, since by Theorem 1.3 in [17], $\nabla_{\mathbb{G}} v-\mathbf{q} \in C^{0, \mu}\left(B_{\tau / 8}, H \mathbb{G}\right)$, for some $\mu \in(0,1]$ depending only on $\mathbb{G}$ and $p$, and $A$ as in Lemma 6.1 is such that $A \in C^{0, \gamma}\left(B_{\tau / 8}, H \mathbb{G}\right)$, for some $\gamma \in(0,1]$ depending only on $p$ (trivially for $p>2$, and by a direct computation in the case $1<p<2$ ), it follows that $A$ as in (6.46) is such that $A \in C^{0, \alpha}\left(B_{\tau / 8}, H \mathbb{G}\right)$ for some $\alpha \in(0,1]$ depending only on $\mathbb{G}$ and $p$. This implies straightforwardly that also (5.3) is satisfied. Hence, we are in the position to apply Theorem [5.1, with $\Omega=B_{\tau / 8}$, and $x_{0}=e$. Let $\bar{R}>0$ given by Theorem 5.1] with the above choices. Now, up relabeling $\tau$ with $\min \{\tau, \bar{R}\}$, by (5.58), for every $x \in B_{\tau / 8}$, we obtain

\end{equation*}
$$

we have that, for every $\varepsilon \in\left(0, \varepsilon_{0}\right]$ and $\sigma \in\left(0, c_{0} \varepsilon^{p}\right]$,

\text { and } \quad & 2^{p-1} C \sigma\left(a^{p}+1\right) \rho^{-Q} \leqslant \frac{1}{4} \rho^{\alpha p} \varepsilon^{p} a^{p} .

where $\widetilde{\delta}:=(p+\delta) p / 2-p>0$, by (6.36) (and up to renaming $C$ and $C_{1}$, depending on $\mathbb{G}$ and $p)$.

In this case, setting $\alpha_{0}:=\mu$ and, for all $\alpha \in\left(0, \alpha_{0}\right)$, we take $\rho$ as in (6.54) and

$$
\varepsilon_{0}:=\left(\frac{\rho^{\alpha p+Q} a_{0}^{\frac{p^{2}}{2}}}{2^{p+1} C_{1}}\right)^{\frac{1}{\delta}} \quad \text { and } \quad c_{0}:=\frac{\rho^{2 \alpha+\frac{Q}{p}} a_{0}^{p}}{4^{\frac{p+1}{p}} C^{\frac{2}{p}}\left(a_{1}^{p}+1\right)}
$$

obtaining that, for all $\varepsilon \in\left(0, \varepsilon_{0}\right]$ and $\sigma \in\left(0, c_{0} \varepsilon^{2}\right]$,

$$
f_{B_{\rho}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)-\overline{\mathbf{q}}(x)\right|^{p} d x \leqslant \rho^{\alpha p} \varepsilon^{p} a^{p} .
$$

Hence, by setting $\widetilde{q}_{i}:=q_{i}+\bar{q}_{i}$ for all $i=1, \ldots, m_{1}$ in (6.7) the desired results in (6.6) and (6.8) follow from this and (6.51).

The proof of Lemma 6.2 is thereby complete.
Iterating Lemma 6.2 we obtain the following estimates:
Corollary 6.3. Let $p>p^{\#}=\frac{2 Q}{Q+2}$. Let $u$ be an almost minimizer for $J_{p}$ in $B_{1}$ (with constant $\kappa$ and exponent $\beta$ ) and

$$
a:=\left(f_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p} .
$$

Suppose that it exists $a_{1}>a_{0}>0$ such that

$$
\begin{equation*}
a \in\left[a_{0}, a_{1}\right] \tag{6.55}
\end{equation*}
$$

and that $u$ satisfies (4.6) and (6.4).

Then there exist $\varepsilon_{0}, \kappa_{0}$ and $\gamma \in(0,1)$, depending on $Q, p, \beta, a_{0}$ and $a_{1}$, such that, for every $\varepsilon \in\left(0, \varepsilon_{0}\right]$ and $\kappa \in\left(0, \kappa_{0} \varepsilon^{P}\right]$, with $P:=\max \{p, 2\}$, then

$$
\begin{equation*}
\|u-\ell\|_{C^{1, \gamma}\left(B_{1 / 2}\right)} \leqslant C \varepsilon a . \tag{6.56}
\end{equation*}
$$

The positive constant $C$ depends only on $Q$ and $p$ and $\ell$ is $a \mathbb{G}$-affine function of slope $\mathbf{q}$.
Moreover,

$$
\begin{equation*}
\left\|\nabla_{\mathbb{G}} u\right\|_{L^{\infty}\left(B_{1 / 2}\right)} \leqslant \widetilde{C} a \tag{6.57}
\end{equation*}
$$

with $\widetilde{C}>0$ depending only on $Q$ and $p$.
Remark 6.4. We point out that a consequence of (6.56) in Corollary 6.3 is that, if $\varepsilon$ is sufficiently small,

$$
\begin{equation*}
\nabla_{\mathbb{G}} u \neq \mathbf{0} \quad \text { in } B_{1 / 2}, \tag{6.58}
\end{equation*}
$$

where $\mathbf{0}$ is the null horizontal section. Indeed, by (6.56), we have that, for all $x \in B_{1 / 2}$,

\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)\right| \leqslant C \varepsilon a,
$$

which gives that

\left|\nabla_{\mathbb{G}} u(x)\right| \geqslant|\mathbf{q}(x)|-\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)\right| \geqslant|\mathbf{q}|-C \varepsilon a .
$$

Finally, by (4.6), we get

$$

as soon as $\varepsilon$ is sufficiently small, which yields (6.58).
Furthermore, we can conclude that

u>0 \quad \text { in } B_{1 / 2} \tag{6.59}
\end{equation*}
$$

To check this, we suppose by contradiction that there exists a point $x_{0} \in B_{1 / 2}$ such that $u\left(x_{0}\right)=0$ (by assumption $u \geqslant 0$ ). As a consequence, since $u \in C^{1, \gamma}\left(B_{1 / 2}\right)$, we see that $\nabla_{\mathbb{G}} u\left(x_{0}\right)=0$, and this contradicts (6.58). This concludes the proof of (6.59).

We also point out the following scaling property of almost minimizers:
Lemma 6.5. Let $u$ be an almost minimizer for $J_{p}$ in $B_{1}$ with constant $\kappa$ and exponent $\beta$. For any $r \in(0,1)$, let

\begin{equation*}
u_{r}(x):=\frac{u\left(\delta_{r}(x)\right)}{r} \tag{6.60}
\end{equation*}
$$

Then, $u_{r}$ is an almost minimizer for $J_{p}$ in $B_{1 / r}$ with constant $\kappa r^{\beta}$ and exponent $\beta$, namely

$$
\begin{equation*}
J_{p}\left(u_{r}, B_{\varrho}\left(x_{0}\right)\right) \leqslant\left(1+\kappa r^{\beta} \varrho^{\beta}\right) J_{p}\left(v, B_{\varrho}\left(x_{0}\right)\right), \tag{6.61}
\end{equation*}
$$

for every ball $B_{\varrho}\left(x_{0}\right)$ such that $\overline{B_{\varrho}\left(x_{0}\right)} \subset B_{1 / r}$ and for every $v \in H W^{1, p}\left(B_{\varrho}\left(x_{0}\right)\right)$ such that $u_{r}-v \in H W_{0}^{1, p}\left(B_{\varrho}\left(x_{0}\right)\right)$.

Proof. By definition of almost minimizers, we know that

$$
\begin{equation*}
J_{p}\left(u, B_{\vartheta}\left(y_{0}\right)\right) \leqslant\left(1+\kappa \vartheta^{\beta}\right) J_{p}\left(w, B_{\vartheta}\left(y_{0}\right)\right) \tag{6.62}
\end{equation*}
$$

for every ball $B_{\vartheta}\left(y_{0}\right)$ such that $\overline{B_{\vartheta}\left(y_{0}\right)} \subset B_{1 / r}$ and for every $w \in H W^{1, p}\left(B_{\vartheta}\left(y_{0}\right)\right)$ such that $u-w \in H W_{0}^{1, p}\left(B_{\vartheta}\left(y_{0}\right)\right)$.

Now, given $x_{0} \in B_{1 / r}$, we take $\varrho$ and $v$ as in the statement of Lemma 6.5 and we define

$$
\begin{equation*}
w(x):=r v\left(\delta_{1 / r}(x)\right) \tag{6.63}
\end{equation*}
$$

Then, using the notation $y_{0}:=\delta_{r}\left(x_{0}\right)$ and $\vartheta:=r \varrho$, for all $x \in \partial B_{\vartheta}\left(y_{0}\right)$, we have that $\delta_{1 / r}(x) \in$ $\partial B_{\varrho}\left(x_{0}\right)$ and therefore,

$$
w(x)-u(x)=r v\left(\delta_{1 / r}(x)\right)-u(x)=r u_{r}\left(\delta_{1 / r}(x)\right)-u(x)=0 .
$$

Accordingly, we can use $w$ as a competitor for $u$ in (6.62), thus obtaining that

\begin{equation*}
\int_{B_{r \varrho}\left(y_{0}\right)}\left(\left|\nabla_{\mathbb{G}} u(y)\right|^{p}+\chi_{\{u>0\}}(y)\right) d y \leqslant\left(1+\kappa r^{\beta} \varrho^{\beta}\right) \int_{B_{r \varrho}\left(y_{0}\right)}\left(\left|\nabla_{\mathbb{G}} w(y)\right|^{p}+\chi_{\{w>0\}}(y)\right) d y \tag{6.64}
\end{equation*}
$$

Furthermore, using, consistently with (6.60), the notation $w_{r}(x):=\frac{w\left(\delta_{r}(x)\right)}{r}$, with the change of variable $x:=\delta_{1 / r}(y)$ we see that

$$
\begin{align*}
\int_{B_{r \varrho}\left(y_{0}\right)} & \left(\left|\nabla_{\mathbb{G}} w(y)\right|^{p}+\chi_{\{w>0\}}(y)\right) d y=r^{Q} \int_{B_{\varrho}\left(x_{0}\right)}\left(\left|\nabla_{\mathbb{G}} w\left(\delta_{r}(x)\right)\right|^{p}+\chi_{\{w>0\}}\left(\delta_{r}(x)\right)\right) d x  \tag{6.65}\\
& =r^{Q} \int_{B_{\varrho}\left(x_{0}\right)}\left(\left|\nabla_{\mathbb{G}} w_{r}(x)\right|^{p}+\chi_{\left\{w_{r}>0\right\}}(x)\right) d x
\end{align*}
$$

and a similar identity holds true with $u$ and $u_{r}$ replacing $w$ and $w_{r}$.
Also, recalling (6.63), we observe that $v=w_{r}$. Plugging this information and (6.65) into (6.64), we obtain the desired result in (6.61).

Proof of Corollary 6.3. Thanks to Lemma 6.5, up to scaling, without loss of generality, we can suppose that

$$
\begin{equation*}
u \text { is an almost minimizer for } J_{p} \text { in } B_{2} \text { (with constant } \kappa \text { and exponent } \beta \text { ). } \tag{6.66}
\end{equation*}
$$

Now, we divide the proof of Corollary 6.3 into separate steps.
Step 1: iteration of Lemma 6.2. We prove that we can iterate Lemma 6.2 indefinitely with $\alpha:=\min \left\{\frac{\alpha_{0}}{2}, \frac{\beta}{P}\right\}$, with $P:=\max \{p, 2\}$ and $\alpha_{0}$ is the one given in Lemma 6.2. More precisely, we claim that, for all $k \geqslant 0$, there exists a constant horizontal section $\mathbf{q}_{k}: \mathbb{G} \rightarrow H \mathbb{G}$

\mathbf{q}_{k}(x):=\sum_{j=1}^{m_{1}} q_{k, j} X_{j}(x), \quad \text { for some } \quad q_{k}=:\left(q_{k, 1}, \ldots, q_{k, m_{1}}\right) \in \mathbb{R}^{m_{1}} \tag{6.67}
\end{equation*}
$$

such that

$$
\begin{align*}
& \left|\mathbf{q}_{k}\right| \in\left[\frac{a}{4}-\frac{\widetilde{C} \varepsilon a\left(1-\rho^{k \alpha}\right)}{1-\rho^{\alpha}}, C_{0} a+\frac{\widetilde{C} \varepsilon a\left(1-\rho^{k \alpha}\right)}{1-\rho^{\alpha}}\right], \quad \text { for all } x \in \mathbb{G} \\
& \left(f_{B_{\rho^{k}}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}_{k}(x)\right|^{p} d x\right)^{1 / p} \leqslant \rho^{k \alpha} \varepsilon a  \tag{6.68}\\
\text { and } & \left(f_{B_{\rho^{k}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p} \in\left[\frac{|\mathbf{q}|}{2}, 2|\mathbf{q}|\right]
\end{align*}
$$

where $\rho \in(0,1), C_{0}>0$ and $\widetilde{C}>0$ are universal contants.
To prove this, we argue by induction. When $k=0$, we pick $\mathbf{q}_{0}:=\mathbf{q}$. Then, in this case, the desired claims in (6.68) follow from (4.6) and (6.4).

Now we perform the inductive step by assuming that (6.68) is satisfied for $k$ and we establish the claim for $k+1$. Setting $r:=\rho^{k}$, and $u_{r}(\cdot):=\frac{u\left(\delta_{r}(\cdot)\right)}{r}$, by inductive assumption we have

\left(f_{B_{1}}\left|\nabla_{\mathbb{G}} u_{r}(x)-\mathbf{q}_{k}(x)\right|^{p} d x\right)^{1 / p} \leqslant r^{\alpha} \varepsilon a=\varepsilon_{k} a
$$

with $\varepsilon_{k}:=r^{\alpha} \varepsilon=\rho^{k \alpha} \varepsilon$.
Notice that the inductive assumption also yields (6.5), as soon as $\varepsilon$ is chosen conveniently small. Therefore, thanks to Lemma 6.5 as well, we are in position of using Lemma 6.2 on the function $u_{r}$ with $\sigma:=\kappa r^{\beta}$. We stress that the structural condition $\sigma \leqslant c_{0} \varepsilon^{P}$ in Lemma 6.2 translates here into $\kappa \leqslant c_{0} \varepsilon^{P}$, which is precisely the requirement in the statement of Corollary 6.3 (by taking $\kappa_{0}$ there less than or equal to $c_{0}$ ). In this way, we deduce from (6.6) and (6.8) that there exists a constant horizontal section $\mathbf{q}_{k+1}$ such that

\left(f_{B_{\rho}}\left|\nabla_{\mathbb{G}} u_{r}(x)-\mathbf{q}_{k+1}(x)\right|^{p} d x\right)^{1 / p} \leqslant \rho^{\alpha} \varepsilon_{k} a \quad \text { and } \quad\left|\mathbf{q}_{k}-\mathbf{q}_{k+1}\right| \leqslant \widetilde{C} \varepsilon_{k} a \tag{6.69}
\end{equation*}
$$

On the other hand, since $\nabla_{\mathbb{G}}\left(u\left(\delta_{r}\right)\right)=r \nabla_{\mathbb{G}} u\left(\delta_{r}(x)\right)$, scaling back, we find that

\left(f_{B_{\rho^{k+1}}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}_{k+1}(x)\right|^{p} d x\right)^{1 / p} \leqslant \rho^{\alpha} \rho^{k \alpha} \varepsilon a=\rho^{(k+1) \alpha} \varepsilon a
$$

Moreover, using again inductive assumption and (6.69), we have

$$
\begin{aligned}
& \left|\mathbf{q}_{k+1}\right| \leqslant\left|\mathbf{q}_{k}-\mathbf{q}_{k+1}\right|+\left|\mathbf{q}_{k}\right| \leqslant \widetilde{C} \varepsilon_{k} a+C_{0} a+\frac{\widetilde{C} \varepsilon a\left(1-\rho^{k \alpha}\right)}{1-\rho^{\alpha}} \\
& =C_{0} a+\frac{\widetilde{C} \varepsilon a\left(1-\rho^{k \alpha}\right)}{1-\rho^{\alpha}}+\widetilde{C} \rho^{k \alpha} \varepsilon a=C_{0} a+\frac{\widetilde{C} \varepsilon a\left(1-\rho^{(k+1) \alpha}\right)}{1-\rho^{\alpha}}
\end{aligned}
$$

and

$$
\begin{aligned}
\left|\mathbf{q}_{k+1}\right| & \geqslant\left|\mathbf{q}_{k}\right|-\left|\mathbf{q}_{k}-\mathbf{q}_{k+1}\right| \geqslant \frac{a}{4}-\frac{\widetilde{C} \varepsilon a\left(1-\rho^{k \alpha}\right)}{1-\rho^{\alpha}}-\widetilde{C} \varepsilon_{k} a \\
& =\frac{a}{4}-\frac{\widetilde{C} \varepsilon a\left(1-\rho^{k \alpha}\right)}{1-\rho^{\alpha}}-\widetilde{C} \rho^{k \alpha} \varepsilon a=\frac{a}{4}-\frac{\widetilde{C} \varepsilon a\left(1-\rho^{(k+1) \alpha}\right)}{1-\rho^{\alpha}} .
\end{aligned}
$$

In addition,

$$
\begin{aligned}
& \left.\left|\left(f_{B_{\rho^{k+1}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p}-\left|\mathbf{q}_{k+1}\right|\right|=\left.\frac{1}{\left|B_{\rho^{k+1}}\right|^{1 / p}}\left|\left(\int_{B_{\rho^{k+1}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p}-\left|\mathbf{q}_{k+1}\right|\right| B_{\rho^{k+1}}\right|^{1 / p} \right\rvert\, \\
& \quad=\frac{1}{\left|B_{\rho^{k+1}}\right|^{1 / p}}\left|\left\|\nabla_{\mathbb{G}} u\right\|_{L^{p}\left(B_{\rho^{k+1}}\right)}-\left\|\mathbf{q}_{k+1}\right\|_{L^{p}\left(B_{\rho^{k+1}}\right)}\right| \leqslant \frac{1}{\left|B_{\rho^{k+1}}\right|^{1 / p}}\left\|\nabla_{\mathbb{G}} u-\mathbf{q}_{k+1}\right\|_{L^{p}\left(B_{\rho^{k+1}}\right)} \\
& \quad=\left(f_{B_{\rho^{k+1}}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}_{k+1}(x)\right|^{p} d x\right)^{1 / p} \leqslant \varepsilon a
\end{aligned}
$$

which yields that

$$
\begin{aligned}
& \left|\left(f_{B_{\rho^{k+1}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p}-|\mathbf{q}|\right|=\left|\left(f_{B_{\rho^{k+1}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p}-\left|\mathbf{q}_{0}\right|\right| \\
& \quad \leqslant\left|\left(f_{B_{\rho^{k+1}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p}-\left|\mathbf{q}_{k+1}\right|\right|+\sum_{j=0}^{k}| | \mathbf{q}_{j+1}\left|-\left|\mathbf{q}_{j}\right|\right| \\
& \quad \leqslant \varepsilon a+\widetilde{C} a \sum_{j=0}^{k} \varepsilon_{j} \leqslant \varepsilon a+\widetilde{C} \varepsilon a \sum_{j=0}^{+\infty} \rho^{j \alpha}=\left(1+\frac{\widetilde{C}}{1-\rho^{\alpha}}\right) \varepsilon a \\
& \quad \leqslant\left(1+\frac{\widetilde{C}}{1-\rho^{\alpha}}\right) \varepsilon|\mathbf{q}| \leqslant \frac{|\mathbf{q}|}{p} .
\end{aligned}
$$

These observations conclude the proof of the inductive step and establish (6.68).
Step 2: Morrey-Campanato estimates. We now want to exploit the Morrey-Campanato estimate of Theorem 2.10 here applied to the function $\nabla_{\mathbb{G}} u-\mathbf{q}$, with the following choices

\Omega=B_{1 / 2}, \quad \text { and } \quad \lambda=\alpha / Q
$$

In order to do this, we claim that, for every $B \subset B_{1 / 2}$,

\frac{1}{|B|^{1+2 \lambda}} \inf _{\boldsymbol{\xi}} \int_{B}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)-\boldsymbol{\xi}(x)\right|^{2} d x \leqslant C \varepsilon^{2} a^{2} \tag{6.70}
\end{equation*}
$$

up to renaming $C>0$, where the infimum is taken over all the constant horizontal sections $\boldsymbol{\xi}: \mathbb{G} \rightarrow H \mathbb{G}$ as in (2.16).

To prove the claim (6.70), we distinguish two cases: either $|B| \geqslant 1$ or $|B| \in(0,1)$. If $|B| \geqslant 1$, we use (6.4) and we get that

|B|^{-(1+p \lambda)} \inf _{\boldsymbol{\xi}} \int_{B}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)-\boldsymbol{\xi}(x)\right|^{p} d x \leqslant \int_{B_{1 / p}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)\right|^{p} d x \\
\leqslant\left|B_{1}\right| f_{B_{1}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)\right|^{p} d x \leqslant\left|B_{1}\right| \varepsilon^{p} a^{p}
\end{gathered}
$$

which gives (6.70) in the case of $|B| \geqslant 1$.
If instead $|B| \in(0,1)$, let be $k_{0}=k_{0}(B) \in \mathbb{N}$ such that $B \subseteq B_{\rho^{k}}$ and $B_{\rho^{k}} \subseteq B$ for all $k>k_{0}$. By (6.68) we have that

\begin{aligned}
&|B|^{-(1+p \lambda)} \inf _{\boldsymbol{\xi}} \int_{B}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)-\boldsymbol{\xi}(x)\right|^{p} d x \leqslant\left|B_{\rho^{k_{0}+1}}\right|^{-(1+p \lambda)} \int_{B_{\rho^{k_{0}}}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}_{k_{0}}(x)\right|^{p} d x \\
&=\left|B_{1}\right| \rho^{-Q\left(k_{0}+1\right)(1+p \lambda)}\left|B_{\rho^{k_{0}}}\right| f_{B_{\rho^{k_{0}}}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}_{k_{0}}(x)\right|^{p} d x \\
& \leqslant C\left|B_{1}\right| \rho^{-Q\left(k_{0}+1\right)(1+p \lambda)+Q k_{0}+p k_{0} \alpha} \varepsilon^{p} a^{p} \\
&=C\left|B_{1}\right| \rho^{(-Q-p \alpha)} \varepsilon^{p} a^{p},
\end{aligned}
$$

which gives (6.70) up to renaming $C$. The proof of (6.70) is thereby complete.
Step 4: conclusion of the proof. Since, by (6.4)

\left\|\nabla_{\mathbb{G}} u-\mathbf{q}\right\|_{L^{p}\left(B_{1 / 2}\right)} \leqslant C \varepsilon a
$$

and by (2.15) and (6.70), we have

\left[\nabla_{\mathbb{G}} u-\mathbf{q}\right]_{\mathcal{E}^{p, \lambda}\left(B_{1 / 2}, H \mathbb{G}\right)} \leqslant C \varepsilon a,
$$

up to renaming $C$, we can apply the Theorem 2.10, from which it follows that

\begin{equation*}
\left[\nabla_{\mathbb{G}} u-\mathbf{q}\right]_{C^{0, \lambda}\left(B_{1 / 2}, H \mathbb{G}\right)} \leqslant C \varepsilon a, \tag{6.71}
\end{equation*}
$$

up to renaming constant $C$ with $\lambda=\alpha / Q \in(0,1)$.
Now we define the $\mathbb{G}$-affine function $\ell: \mathbb{G} \rightarrow \mathbb{R}$ as $\ell(x):=u(e)+\left\langle\mathbf{q}(x), \pi_{x}(x)\right\rangle$, for $x \in \mathbb{G}$. By Proposition [2.3, we have $\nabla_{\mathbb{G}} \ell=\mathbf{q}$. For all $x \in B_{1 / 2}$, let $\delta_{x}:=d_{c}(0, x)$ and $\gamma_{x}:\left[0, \delta_{x}\right] \rightarrow B_{1 / 2}$ a sub-unitary curve

$$
\gamma_{x}(0)=e, \quad \gamma_{x}\left(\delta_{x}\right)=x \quad \text { and } \quad \dot{\gamma}_{x}(t)=\sum_{i=1}^{m_{1}} h_{i}(t) X_{i}\left(\gamma_{x}(t)\right) \quad \text { for a.e. } t \in\left[0, \delta_{x}\right]
$$

with $\sum_{j=1}^{m_{1}}\left(h_{j}(t)\right)^{2} \leqslant 1$, for a.e. $t \in\left[0, \delta_{x}\right]$, (such $\gamma$ exists thanks to Chow's Theorem, [7, Theorem 19.1.3]). By (6.71) we conclude

$$
|u(x)-\ell(x)|=\mid u(x)-u(e)-\underset{51}{\left\langle\mathbf{q}(x), \pi_{x}(x)\right\rangle-\left\langle\mathbf{q}(e), \pi_{e}(e)\right\rangle|.|.|}
$$

$$
\begin{aligned}
& =\left|\int_{0}^{\delta_{x}} \frac{d}{d t}\left(u\left(\gamma_{x}(t)\right)-\left\langle\mathbf{q}\left(\gamma_{x}(t)\right), \pi_{\gamma_{x}(t)}\left(\gamma_{x}(t)\right)\right\rangle\right) d t\right| \\
& \leqslant C \int_{0}^{\delta_{x}}\left|\nabla_{\mathbb{G}} u\left(\gamma_{x}(t)\right)-\mathbf{q}\left(\gamma_{x}(t)\right)\right| d t \leqslant C \varepsilon a
\end{aligned}
$$

up to renaming $C>0$ a universal constant. By arbitrariness of $x \in B_{1 / 2}$, we conclude

$$
\|u-\ell\|_{L^{\infty}\left(B_{1 / 2}\right)} \leqslant C \varepsilon a
$$

This and (6.71) establish (6.56).

## 7. Lipschitz continuity of almost minimizers and proof of Theorem 1.2

We are now in position of establishing the Lipschitz regularity result in Theorem 1.2.
Proof of Theorem 1.2. In the light of Lemma 6.5, up to a rescaling, we can assume that $u$ is an almost minimizer with constant

$$
\begin{equation*}
\widetilde{\kappa}:=\kappa s^{\beta}, \tag{7.1}
\end{equation*}
$$

which can be made arbitrarily small by an appropriate choice of $s>0$.
Let us set $P:=\max \{p, 2\}$. Let also $\alpha_{0} \in(0,1]$ be the structural constant given by Lemma 6.2 and define

$$
\alpha:=\frac{1}{2} \min \left\{\alpha_{0}, \frac{\beta}{P}\right\}
$$

We also consider $\varepsilon_{0}$ as given by Proposition 4.1 and take $\eta \in(0,1)$ and $M \geqslant 1$ as in Proposition 4.1 (corresponding here to choice $\varepsilon:=\varepsilon_{0} / 2$ ).

Let us define

$$
\begin{equation*}
a(\tau):=\left(f_{B_{\tau}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p} . \tag{7.2}
\end{equation*}
$$

We now divide the argument into separate steps.
Step 1: estimating the average. We claim that, for every $r \in(0, \eta]$,

$$
\begin{equation*}
a(r) \leqslant C(M, \eta)(1+a(1)) \tag{7.3}
\end{equation*}
$$

for some $C(M, \eta)>0$, possibly depending on $Q$ and $p$ as well.
To prove this, we consider the set $\mathcal{K} \subseteq \mathbb{N}=\{0,1,2, \ldots\}$ containing all the integers $k \in \mathbb{N}$ such that

$$
\begin{equation*}
a\left(\eta^{k}\right) \leqslant C(\eta) M+2^{-k} a(1) \tag{7.4}
\end{equation*}
$$

where

$$
\begin{equation*}
C(\eta):=2 \eta^{-Q / p} \tag{7.5}
\end{equation*}
$$

We stress that for $k=0$ formula (7.4) is clearly true, hence

$$
\begin{equation*}
0 \in \underset{52}{\mathcal{K}} \neq \varnothing \tag{7.6}
\end{equation*}
$$

We then distinguish two cases, namely whether (7.4) holds for every $k$ (i.e. $\mathcal{K}=\mathbb{N}$ ) or not (i.e. $\mathcal{K} \varsubsetneqq \mathbb{N})$.
Step 1.1: the case $\mathcal{K}=\mathbb{N}$. For every $r \in(0, \eta]$, we define $k_{0} \in \mathbb{N}=\mathcal{K}$ such that $\eta^{k_{0}+1}<r \leqslant \eta^{k_{0}}$. Hence, according to (7.2) and (7.4), we get that

$$
\begin{aligned}
& a(r) \leqslant\left(\frac{1}{\left|B_{1}\right| \eta^{\left(k_{0}+1\right) Q}} \int_{B_{\eta^{k}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p}=\eta^{-Q / p} a\left(\eta^{k_{0}}\right) \leqslant \eta^{-Q / p}(C(\eta) M+a(1)) \\
& \leqslant \eta^{-Q / p} \max \{C(\eta) M, 1\}(1+a(1)) \leqslant C(M, \eta)(1+a(1))
\end{aligned}
$$

provided that $C(M, \eta) \geqslant \eta^{-Q / p} \max \{C(\eta) M, 1\}$. The proof of (7.3) is thereby complete in this case.

Step 1.2: the case $\mathcal{K} \varsubsetneqq \mathbb{N}$ By (7.6), there exists $k_{0} \in \mathbb{N}$ such that $\left\{0, \ldots, k_{0}\right\} \in \mathcal{K}$ and

$$
\begin{equation*}
k_{0}+1 \notin \mathcal{K} \tag{7.7}
\end{equation*}
$$

We notice that, by (7.2) and (7.5),

$$
\eta^{-Q / p} M<C(\eta) M \leqslant C(\eta) M+2^{-\left(k_{0}+1\right)} a(1)<a\left(\eta^{k_{0}+1}\right) \leqslant \eta^{-Q / p} a\left(\eta^{k_{0}}\right)
$$

and therefore

$$
\begin{equation*}
a\left(\eta^{k_{0}}\right)>M \tag{7.8}
\end{equation*}
$$

Furthermore, from (7.7),

$$
\begin{equation*}
a\left(\eta^{k_{0}+1}\right)>C(\eta) M+2^{-\left(k_{0}+1\right)} a(1) \geqslant \frac{C(\eta) M+2^{-k_{0}} a(1)}{2} \geqslant \frac{a\left(\eta^{k_{0}}\right)}{2} \tag{7.9}
\end{equation*}
$$

Now, we claim that

$$
\begin{equation*}
\left(f_{B_{\eta^{k_{0}+1}}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)\right|^{p} d x\right)^{1 / p} \leqslant \varepsilon a\left(\eta^{k_{0}}\right) \tag{7.10}
\end{equation*}
$$

for some constant horizontal section $\mathbf{q}: \mathbb{G} \rightarrow H \mathbb{G}$ such that

$$
\frac{a\left(\eta^{k_{0}}\right)}{4}<|\mathbf{q}| \leqslant C_{0} a\left(\eta^{k_{0}}\right)
$$

and being $C_{0}$ the constant given by Proposition 4.1.
To prove (7.10), we apply the dichotomy result in Proposition 4.1 rescaled in the ball $B_{\eta^{k_{0}}}$. In this way, we deduce from (4.3), (4.4) and (4.6) that (7.10) holds true, unless it occurs

$$
a\left(\eta^{k_{0}+1}\right)=\left(f_{B_{\eta^{k_{0}+1}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p} \leqslant \frac{a\left(\eta^{k_{0}}\right)}{2}
$$

but this contradicts (7.9). This ends the proof of (7.10).
Now we apply Corollary 6.3 rescaled in the ball $B_{\eta^{k_{0}+1}}$ : namely, we use here Corollary 6.3 with $B_{1}$ replaced by $B_{\eta^{k_{0}+1}}$ and $a$ replaced by $a\left(\eta^{k_{0}+1}\right)$. To this end, we need to verify that the
assumptions of Corollary 6.3 are fulfilled in this rescaled situation. Specifically, we note that, by (7.8) and (7.9),

$$
a\left(\eta^{k_{0}+1}\right) \geqslant \frac{M}{2} .
$$

Also, since $k_{0} \in \mathcal{K}$,

$$
a\left(\eta^{k_{0}+1}\right) \leqslant \eta^{-Q / p} a\left(\eta^{k_{0}}\right) \leqslant \eta^{-Q / p}\left(C(\eta) M+2^{-k_{0}} a(1)\right) \leqslant \eta^{-Q / p}(C(\eta) M+a(1))
$$

These observations give that (6.55) is satisfied in this rescaled setting with

$$
\begin{equation*}
a_{0}:=\frac{M}{2} \quad \text { and } \quad a_{1}:=\eta^{-Q / p}(C(\eta) M+a(1)) . \tag{7.11}
\end{equation*}
$$

Moreover, by (7.9) and (7.10),

$$
\left(f_{B_{\eta^{k_{0}+1}}}\left|\nabla_{\mathbb{G}} u(x)-\mathbf{q}(x)\right|^{p} d x\right)^{1 / p} \leqslant 2 \varepsilon a\left(\eta^{k_{0}+1}\right)
$$

showing that (6.4) is satisfied (here with $2 \varepsilon$ instead of $\varepsilon$ ).
We also deduce from (7.9) and (7.10) that

$$
\frac{\eta^{Q / p} a\left(\eta^{k_{0}+1}\right)}{4} \leqslant \frac{a\left(\eta^{k_{0}}\right)}{4}<|\mathbf{q}| \leqslant C_{0} a\left(\eta^{k_{0}}\right) \leqslant 2 C_{0} a\left(\eta^{k_{0}+1}\right)
$$

which gives that (4.6) is satisfied here (though with different structural constants).
We can thereby exploit Corollary 6.3 in a rescaled version to obtain the existence of $\varepsilon_{0}$ (possibly different from the one given by Proposition 4.1) and $\kappa_{0}$, depending on $Q, p, \beta, a_{0}$ and $a_{1}$, such that, if

$$
\begin{equation*}
\widetilde{\kappa} \in\left(0, \kappa_{0} \varepsilon_{0}^{P}\right] \tag{7.12}
\end{equation*}
$$

we have that

$$
\begin{equation*}
\left\|\nabla_{\mathbb{G}} u\right\|_{L^{\infty}\left(B_{\eta^{k_{0}+1} / 2}\right)} \leqslant \bar{C} a\left(\eta^{k_{0}}\right) \tag{7.13}
\end{equation*}
$$

for some structural constant $\bar{C}>0$.
We remark that condition (7.12) is satisfied by taking $s$ in (7.1) sufficiently small, namely taking $s:=\left(\frac{\kappa_{0} \varepsilon_{0}^{P}}{2 \kappa}\right)^{\frac{1}{\beta}}$. Notice in particular that

$$
\begin{equation*}
s \text { depends on } Q, p, \kappa, \beta \text { and }\left\|\nabla_{\mathbb{G}} u\right\|_{L^{p}\left(B_{1}\right)}, \tag{7.14}
\end{equation*}
$$

due to (7.11).
As a result of (7.13), for all $r \in\left(0, \frac{\eta^{k_{0}+1}}{2}\right)$,

$$
\begin{gather*}
a(r)=\left(\frac{1}{\left|B_{r}\right|} \int_{B_{r}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p} \leqslant \bar{C} a\left(\eta^{k_{0}}\right) \leqslant \bar{C}\left(C(\eta) M+2^{-k_{0}} a(1)\right)  \tag{7.15}\\
\leqslant \bar{C}(C(\eta) M+a(1)) \leqslant C(M, \eta)(1+a(1))
\end{gather*}
$$

as long as $C(M, \eta) \geqslant \bar{C}(C(\eta) M+1)$.
Moreover, if $r \in\left[\frac{\eta^{k_{0}+1}}{2}, \eta\right]$ then we take $k_{r} \in \mathbb{N}$ such that $\eta^{k_{r}+1}<r \leqslant \eta^{k_{r}}$. Note that

$$
\frac{1}{\eta^{k_{r}}} \leqslant \frac{1}{r} \leqslant \frac{2}{\eta^{k_{0}+1}}
$$

whence

$$
\begin{equation*}
k_{r} \leqslant k_{0}+C_{\star}, \tag{7.16}
\end{equation*}
$$

where $C_{\star}:=1+\frac{\log 2}{\log (1 / \eta)}$.
We now distinguish two cases: if $k_{r} \in\left\{0, \ldots, k_{0}\right\}$ then $k_{r} \in \mathcal{K}$ and therefore

$$
a\left(\eta^{k_{r}}\right) \leqslant C(\eta) M+2^{-k_{r}} a(1)
$$

From this, we obtain that

$$
\begin{align*}
a(r) \leqslant & \left(\frac{1}{\left|B_{\eta^{k_{r}+1}}\right|} \int_{B_{\eta^{k_{r}}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p}=\eta^{-Q / p} a\left(\eta^{k_{r}}\right)  \tag{7.17}\\
& \leqslant \eta^{-Q / p}\left(C(\eta) M+2^{-k_{r}} a(1)\right) \leqslant C(M, \eta)(1+a(1))
\end{align*}
$$

If instead $k_{r}>k_{0}$, we employ (7.16) to see that

$$
\begin{aligned}
& a(r) \leqslant\left(\frac{1}{\left|B_{\eta^{k_{0}+C_{\star}+1}}\right|} \int_{B_{\eta^{k_{0}}}}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p}=\eta^{-Q\left(C_{\star}+1\right) / p} a\left(\eta^{k_{0}}\right) \\
& \quad \leqslant \eta^{-Q\left(C_{\star}+1\right) / p}\left(C(\eta) M+2^{-k_{0}} a(1)\right) \leqslant \eta^{-Q\left(C_{\star}+1\right) / p}(C(\eta) M+a(1)) \\
& \quad \leqslant C(M, \eta)(1+a(1))
\end{aligned}
$$

as long as $C(M, \eta)$ is chosen large enough.
This and (7.17) give that for all $r \in\left[\frac{\eta^{k_{0}+1}}{2}, \eta\right]$, we have that $a(r) \leqslant C(M, \eta)(1+a(1))$. Combining this with (7.15), we deduce that (7.3) holds true, as desired.

Step 2: conclusions. Now, up to scaling and translations, we can extend (7.3) to all balls with centre $x_{0}$ in $B_{1 / 2}$ and sufficiently small radius. Namely, we have that, for all $r \in(0, \eta]$,

$$
a\left(r, x_{0}\right) \leqslant C(M, \eta)(1+a(1))
$$

where

$$
a\left(r, x_{0}\right):=\left(f_{B_{r}\left(x_{0}\right)}\left|\nabla_{\mathbb{G}} u(x)\right|^{p} d x\right)^{1 / p} .
$$

Therefore, according to the Lebesgue Differentiation Theorem (see e.g. [75]), recalling that $u \in H W^{1, p}\left(B_{1}\right)$, we find that, for almost every $x_{0} \in B_{1 / 2}$,

$$
\left|\nabla_{\mathbb{G}} u\left(x_{0}\right)\right|=\lim _{r \rightarrow 0} a\left(r, x_{0}\right) \leqslant C(M, \eta)(1+a(1))=C\left(1+\left\|\nabla_{\mathbb{G}} u\right\|_{L^{p}\left(B_{1}\right)}\right)
$$

for some $C>0$, which yields

$$
\begin{equation*}
\left\|\nabla_{\mathbb{G}} u\right\|_{L^{\infty}\left(B_{1 / 2}\right)} \leqslant C\left(1+\left\|\nabla_{\mathbb{G}} u\right\|_{L^{p}\left(B_{1}\right)}\right) . \tag{7.18}
\end{equation*}
$$

So, the first claim in Theorem 1.2 is proved.
We now show that the second claim in Theorem 1.2 holds. For this, we can assume that

$$
\begin{equation*}
\{u=0\} \cap B_{s / 100} \neq \varnothing \tag{7.19}
\end{equation*}
$$

and we take a Lebesgue point $\bar{x} \in B_{s / 100}$ for $\nabla_{\mathbb{G}} u$. Up to a left-translation, we can suppose that $\bar{x}=0$ and change our assumption (7.19) into

$$
\begin{equation*}
\{u=0\} \cap B_{s / 50} \neq \varnothing . \tag{7.20}
\end{equation*}
$$

We claim that, in this situation,

$$
\begin{equation*}
\mathcal{K}=\mathbb{N} . \tag{7.21}
\end{equation*}
$$

Indeed, suppose not and let $k_{0}$ as above (recall (7.7)). Then, in light of (7.10), we can apply Corollary 6.3 (rescaled as before) and conclude, by (6.59), that $u>0$ in $B_{s / 2}$, in contradiction with our hypothesis in (7.20). This establishes (7.21).

Therefore, in view of (7.4) and (7.21), for all $k \in \mathbb{N}$,

$$
a\left(\eta^{k}\right) \leqslant C(\eta) M+2^{-k} a(1)
$$

and as a result

$$
\left|\nabla_{\mathbb{G}} u(\bar{x})\right|=\left|\nabla_{\mathbb{G}} u(0)\right|=\lim _{k \rightarrow+\infty} a\left(\eta^{k}\right) \leqslant \lim _{k \rightarrow+\infty}\left(C(\eta) M+2^{-k} a(1)\right)=C(\eta) M
$$

Recalling also (7.14), the proof of the second claim in Theorem 1.2 is thereby complete.
