Exploiting Structure in Quantum Relative Entropy Programs

Abstract

Quantum relative entropy programs are convex optimization problems which minimize a linear functional over an affine section of the epigraph of the quantum relative entropy function. Recently, the self-concordance of a natural barrier function was proved for this set. This has opened up the opportunity to use interior-point methods for nonsymmetric cone programs to solve these optimization problems. In this paper, we show how common structures arising from applications in quantum information theory can be exploited to improve the efficiency of solving quantum relative entropy programs using interior-point methods. First, we show that the natural barrier function for the epigraph of the quantum relative entropy composed with positive linear operators is optimally self-concordant, even when these linear operators map to singular matrices. Compared to modelling problems using the full quantum relative entropy cone, this allows us to remove redundant log determinant expressions from the barrier function and reduce the overall barrier parameter. Second, we show how certain slices of the quantum relative entropy cone exhibit useful properties which should be exploited whenever possible to perform certain key steps of interior-point methods more efficiently. We demonstrate how these methods can be applied to applications in quantum information theory, including quantifying quantum key rates, quantum rate-distortion functions, quantum channel capacities, and the ground state energy of Hamiltonians. Our numerical results show that these techniques improve computation times by up to several orders of magnitude, and allow previously intractable problems to be solved.

1 Introduction

The (Umegaki) quantum relative entropy is an important function in quantum information theory used to measure the divergence between two quantum states. This is defined as

$$
S(X \parallel Y) \coloneqq \text{tr}[X(\log(X) - \log(Y))],\tag{1}
$$

on the domain $\{(X,Y)\in \mathbb{H}^n_+\times \mathbb{H}^n_+: X\ll Y\}$, where we use $X\ll Y$ to mean ker $(Y)\subseteq \text{ker}(X)$, log denotes the matrix logarithm, and \mathbb{H}^n_+ denotes the set of positive semidefinite Hermitian matrices. It is known that the quantum relative entropy is jointly convex in both of its arguments $[1, 2]$ $[1, 2]$. Therefore minimizing the quantum relative entropy subject to affine constraints is a convex optimization problem. Many important quantities in quantum information theory involve solving these quantum relative entropy programs, i.e., conic optimization problems with respect to the quantum relative entropy cone

$$
\mathcal{K}_{\text{qre}} \coloneqq \{ (t, X, Y) \in \mathbb{R} \times \mathbb{H}_+^n \times \mathbb{H}_+^n : t \ge S(X \| Y), \ X \ll Y \}. \tag{2}
$$

Recently, optimal self-concordance of the natural barrier function of the quantum relative entropy cone

$$
(t, X, Y) \in \mathbb{R} \times \mathbb{H}^n_{++} \times \mathbb{H}^n_{++} \mapsto -\log(t - S(X \| Y)) - \log \det(X) - \log \det(Y),\tag{3}
$$

was established [\[3\]](#page-33-2). Together with recent advances in nonsymmetric conic programming [\[4](#page-33-3)[–9\]](#page-33-4), this has opened up the opportunity to solve quantum relative entropy programs using primal-dual interior-point algorithms for nonsymmetric cones. In this work, we focus on the practical implementation of these algorithms when solving quantum relative entropy programs. In particular, we study how we can exploit common structures arising in problems in quantum information theory to efficiently implement certain key steps of these interior-point algorithms.

Quantum relative entropy programming Several techniques have been proposed for solving quantum relative entropy programs. One line of work is to use first-order methods, e.g., [\[10](#page-33-5)[–14\]](#page-34-0). However, these methods typically require tailored algorithms and proofs of convergence for each different problem instance, and currently there is no general purpose first-order algorithm which can solve general quantum relative entropy programs. Additionally, these techniques usually do not converge quickly to high accuracy solutions.

Alternatively, the quantum relative entropy cone can be approximated to arbitrarily small precision by using linear matrix inequalities [\[15\]](#page-34-1). This approximation allows us to use relatively mature techniques and software for semidefinite programming to solve these problems. However, as these semidefinite approximations involve matrices of much larger dimension than the original matrices involved with the quantum relative entropy, this technique only works well for relatively small problem dimensions.

Another recent line of work aims to solve quantum relative entropy programs using interior-point algorithms. For example, tailored interior-point algorithms were proposed in [\[16–](#page-34-2)[18\]](#page-34-3) to compute the relative entropy of entanglement and quantum key rates. More generally, we can use nonsymmetric cone programming techniques to optimize over the quantum relative entropy cone. In [\[5](#page-33-6)[–9\]](#page-33-4), it was shown how primal-dual interior-point algorithms for symmetric cone programming (i.e., linear, semidefinite, and second-order cone programming), which are known to work well in practice, could be extended to solve cone programs involving more general nonsymmetric cones while retaining the same worst case iteration complexity bounds $\mathcal{O}(\sqrt{\nu}\log(1/\varepsilon))$, where ν is the barrier parameter associated with the cone. Practical implementations of nonsymmetric cone programming which use these ideas have recently been released [\[4,](#page-33-3) [19–](#page-34-4)[22\]](#page-34-5). Notably, implementations of the quantum relative entropy cone are available in Hypatia [\[19\]](#page-34-4) and DDS [\[20,](#page-34-6) [23\]](#page-34-7).

Exploiting structure in conic progams Consider the standard form conic program

$$
\min_{x \in \mathbb{R}^n} \langle c, x \rangle, \quad \text{subj. to} \quad Ax = b, \ x \in \mathcal{K}, \tag{4}
$$

where $c \in \mathbb{R}^n$, $A \in \mathbb{R}^{p \times n}$, $b \in \mathbb{R}^p$, and $\mathcal{K} \in \mathbb{R}^n$ is a proper (i.e., closed, pointed, and full-dimensional) convex cone, and let $F: \text{int } \mathcal{K} \to \mathbb{R}$ be a logarithmically-homogeneous self-concordant barrier (defined in Section [4.1\)](#page-10-0) for K . The main bottleneck in primal-dual interior-point methods is typically in solving a linear system of equations, known as the Newton equations, involving the Hessian of the barrier function $\nabla^2 F(x)$ and the constraint matrix A. One common way of solving the Newton equations is to use a suitable block elimination ordering (see Appendix [C\)](#page-28-0) to reduce the problem to solving a linear system with the Schur complement matrix $A \nabla^2 F(x)^{-1} A^{\top}$.

For linear and semidefinite programming, i.e., $\mathcal{K} = \mathbb{R}^n_+$ and $\mathcal{K} = \mathbb{H}^n_+$, respectively, the Schur complement matrix is relatively easy to construct as there exist simple expressions for the inverse Hessian map $\nabla^2 F(x)^{-1}$ of the logarithmic and log determinant barriers used by each of these cones. Additionally, it is well known that certain structures in A , such as sparsity, can be exploited to make constructing the Schur complement matrix more efficient [\[24–](#page-34-8)[27\]](#page-34-9). However, for nonsymmetric programming in general, it is not always clear if efficient expressions exist for the inverse Hessian map of the barrier function. Notably, existing implementations of interior-point algorithms for quantum relative entropy programs, i.e., $\mathcal{K} = \mathcal{K}_{\text{gre}}$, construct and factor the full Hessian matrix of the barrier function [\(3\)](#page-0-0), which ends up being the dominant cost of these algorithms. In [\[23\]](#page-34-7), a heuristic method which approximates the Hessian of quantum relative entropy by discarding off-diagonal blocks of the matrix is proposed, which simplifies the process of constructing and factoring the Hessian. However, we are not aware of any analysis of when this approximation works well.

Alternatively, sometimes the Hessian of the barrier function [\(3\)](#page-0-0) can be simplified by exploiting identities which quantum relative entropy satisfies along certain slices of the quantum relative entropy cone. A similar idea was used in [\[18\]](#page-34-3) when applying interior-point methods to solve for quantum key rates. We illustrate an example of this idea which we will develop later in the paper.

Example 1.1. Consider the positive semidefinite 2×2 block matrix $X \in \mathbb{H}^{2n}_+$ whose i, j-th block is given by $X_{ij} \in \mathbb{H}^n$. One can show that following identity holds

$$
S\left(\begin{bmatrix} X_{11} & X_{12} \\ X_{12}^{\dagger} & X_{22} \end{bmatrix} \middle\| \begin{bmatrix} X_{11} + X_{22} & 0 \\ 0 & X_{11} + X_{22} \end{bmatrix}\right) = \text{tr}[X \log(X)] - \text{tr}[(X_{11} + X_{22}) \log(X_{11} + X_{22})], \quad (5)
$$

for all $X \in \mathbb{H}^{2n}_+$. We can represent the Hessian matrix of this function in the form $H_1-A^{\dagger}H_2A$, where H_1 is the Hessian matrix of $X \in \mathbb{H}^{2n}_+ \mapsto \text{tr}[X \log(X)], H_2$ is the Hessian matrix of $Y \in \mathbb{H}^n_+ \mapsto \text{tr}[Y \log(Y)],$ and A represents the linear map $X \mapsto X_{11}+X_{22}$. By interpreting this Hessian as a low-rank perturbation of H_1 , and recognizing that H_1 and H_2 are both easily invertible (see Remark $B.4$), we can employ the matrix inversion lemma (see Appendix [A\)](#page-25-0) to efficiently solve linear systems with $H_1 - A^{\dagger}H_2A$.

The function in [\(5\)](#page-1-0) is related to quantum conditional entropy functions. We provide a more detailed discussion of these function in Example [5.7,](#page-17-0) and provide a proof of a generalization of the identity (5) in Lemma [5.6.](#page-16-0)

Contributions In our work, we focus on quantum relative entropy programs of the form, or closely related to the form,

$$
\min_{X \in \mathbb{H}^n} S(\mathcal{G}(X) \| \mathcal{H}(X)), \quad \text{subj. to} \quad \mathcal{A}(X) = b, \ X \succeq 0,
$$
\n
$$
(6)
$$

where $\mathcal{G}: \mathbb{H}^n \to \mathbb{H}^m$ and $\mathcal{H}: \mathbb{H}^n \to \mathbb{H}^m$ are positive linear maps (i.e., linear operators which map positive semidefinite matrices to positive semidefinite matrices) satisfying $\mathcal{G}(X) \ll \mathcal{H}(X)$ for all $X \in \mathbb{H}_{++}^n$, and $\mathcal{A}: \mathbb{H}^n \to \mathbb{R}^p$ and $b \in \mathbb{R}^p$ encode the linear constraints. Note that G and/or H may be defined to map nonsingular matrices to singular matrices. To model this problem as a standard form conic program [\(4\)](#page-1-1), an obvious choice is to let $\mathcal{K} = \mathcal{K}_{\text{qre}} \times \mathbb{H}^n_+$, in which case we are interested in the following slice of the barrier of this cone

$$
(t, X) \in \mathbb{R} \times \mathbb{H}^n_{++} \mapsto -\log(t - S(\mathcal{G}(X) \| \mathcal{H}(X))) - \log \det(\mathcal{G}(X)) - \log \det(\mathcal{H}(X)) - \log \det(X), \tag{7}
$$

which has a total barrier parameter of $2m + n + 1$.

Our contributions are twofold. First, instead of using the aforementioned modelling strategy using the full quantum relative entropy cone, we propose that we should directly model the quantum relative entropy program [\(6\)](#page-2-0) using the following slice of the quantum relative entropy cone

$$
\mathcal{K}_{\text{qre}}^{\mathcal{G},\mathcal{H}} \coloneqq \text{cl}\{(t,X)\in\mathbb{R}\times\mathbb{H}_{++}^n : t\geq S(\mathcal{G}(X)\|\mathcal{H}(X))\}.
$$
\n
$$
(8)
$$

We show in Section [4](#page-7-0) that a natural barrier function for this slice of the quantum relative entropy cone is optimally self-concordant. We summarize this result in the following corollary, which is a special case of a more general result we present later in Theorem [4.1.](#page-8-0)

Corollary 1.2. Let $\mathcal{G} : \mathbb{H}^n \to \mathbb{H}^m$ and $\mathcal{H} : \mathbb{H}^n \to \mathbb{H}^m$ be positive linear maps satisfying $\mathcal{G}(X) \ll \mathcal{H}(X)$ for all $X \in \mathbb{H}^n_{++}$. Then

$$
(t, X) \in \mathbb{R} \times \mathbb{H}^n_{++} \mapsto -\log(t - S(\mathcal{G}(X) \| \mathcal{H}(X))) - \log \det(X),\tag{9}
$$

is an $(n + 1)$ -logarithmically homogeneous self-concordant barrier for $\mathcal{K}_{\text{gre}}^{\mathcal{G},\mathcal{H}}$. Moreover, this barrier is optimal in the sense that any self-concordant barrier for $K_{\text{qre}}^{\mathcal{G},\mathcal{H}}$ has parameter at least $n+1$.

There are two main advantages of working with $\mathcal{K}_{\text{gre}}^{\mathcal{G},\mathcal{H}}$ and its barrier compared to working with the full quantum relative entropy cone. First, by using a priori knowledge that G and H are positive linear maps, we do not require redundant positive semidefinite constraints which introduce additional log determinant expressions to the barrier function and increase the total barrier parameter by $2m$ (compare (7) and (9)). Second, the barrier (9) is well-defined even when G and/or H map to singular matrices, whereas [\(7\)](#page-2-1) is not well-defined under the same setting due to the redundant log determinant terms.

Second, in Section [5](#page-13-0) we show how we can exploit certain structures in $\mathcal G$ and $\mathcal H$ which commonly arise in applications from quantum information theory to make solving the Newton equations simpler, by using extensions of the basic idea discussed in Example [1.1.](#page-1-2) Structures we study include block diagonal, low-rank, and quantum conditional entropy-like structures.

Using these techniques, we implement custom cone oracles which can be used with the generic conic primal-dual interior point software Hypatia [\[19\]](#page-34-4), which are available at

<https://github.com/kerry-he/qrep-structure>.

We show how our techniques can be applied to various applications from quantum information theory, including computing the quantum key rate, the quantum rate-distortion function, quantum channel capacities, and the ground state energy of Hamiltonians. We first introduce these problems in Section [3,](#page-4-0) before presenting numerical experiments in Section [6.](#page-18-0) Our numerical results demonstrate that the methods presented in this paper can improve computation times and memory requirements by up to several orders of magnitude, allowing us to solve problems with dimensions that were previously out of reach.

At the time of writing this paper, we were made aware of [\[28\]](#page-34-10) which independently proposed using interior-point methods to optimize over $\mathcal{K}_{\text{qre}}^{\mathcal{G},\mathcal{H}}$ with a focus on computing quantum key rates. While [\[28\]](#page-34-10) applies this technique to more quantum key rate examples, and benchmarks against state-of-the-art algorithms for computing quantum key rates, our work analyses the self-concordance properties of the barrier [\(9\)](#page-2-2), considers a broader range of structural properties in G and H, and a wider range of applications beyond quantum key distribution.

2 Preliminaries

Notation We use \mathbb{R}^n , \mathbb{C}^n , and \mathbb{H}^n to denote the set of *n*-dimensional real vectors, *n*-dimensional complex vectors, and $n \times n$ Hermitian matrices, respectively. Additionally, we use \mathbb{R}^n_+ and \mathbb{R}^n_{++} to denote the nonnegative orthant and its interior, respectively, and use \mathbb{H}^n_+ and \mathbb{H}^n_{++} to denote the positive semidefinite cone and its interior, respectively. We will also use the notation $X \succeq 0$ and $X \succ 0$ to mean $X \in \mathbb{H}^n_+$ and $X \in \mathbb{H}^n_{++}$, respectively. For $x, y \in \mathbb{R}^n$ and $X, Y \in \mathbb{H}^n$, we define the standard inner products $\langle x, y \rangle = x^{\top}y$ and $\langle X, Y \rangle = \text{tr}[XY]$, respectively. For a complex matrix $X \in \mathbb{C}^{n \times m}$, we use \overline{X} to denote its elementwise conjugate, and X^{\dagger} to denote its conjugate transpose. We use \mathbb{I}_n to denote the $n \times n$ identity matrix, and drop the subscript if the dimension of the matrix is clear from the context. We use $\{e_i\}_{i=1}^n$ to denote the standard basis for either \mathbb{R}^n or \mathbb{C}^n . We use cl, epi, hypo, ker, and im to denote the closure of a set, the epigraph or hypograph of a function, and the kernel or image of a linear operator, respectively. A matrix $U \in \mathbb{C}^{n \times n}$ is unitary if $U^{\dagger}U = U U^{\dagger} = \mathbb{I}$. We say that a matrix $V \in \mathbb{C}^{m \times n}$ is an *isometry matrix* if $m \geq n$ and $V^{\dagger}V = \mathbb{I}$.

Derivatives For a finite dimensional real vector space V, consider a C^3 function $f : \text{dom } f \to \mathbb{R}$ with open domain dom $f \subset V$. We denote the first, second, and third directional derivative of f at $x \in \text{dom } f$ in the direction $h \in \mathbb{V}$ as $\nabla f(x)[h], \nabla^2 f(x)[h, h],$ and $\nabla^3 f(x)[h, h, h]$, respectively. We will also use the notation $\nabla f(x) \in \mathbb{V}$ and $\nabla^2 f(x)[h] \in \mathbb{V}$ to denote the gradient vectors of f and $\nabla f(x)[h]$, respectively, and use $\nabla^2 f(x)$ to denote the real Hessian matrix of f. We provide additional details regarding the derivatives of spectral functions and barrier functions in Appendix [B.](#page-26-0)

Product spaces For two matrices $X \in \mathbb{C}^{n \times m}$ and $Y \in \mathbb{C}^{p \times q}$, we define the Kronecker product $X \otimes Y \in \mathbb{C}^{np \times mq}$ as the block matrix

$$
X \otimes Y = \begin{bmatrix} X_{11}Y & \dots & X_{1m}Y \\ \vdots & \ddots & \vdots \\ X_{n1}Y & \dots & X_{nm}Y \end{bmatrix},
$$

where X_{ij} denotes the *i*, *j*-th element of X. A related class of operators are the partial traces $\text{tr}_1^{n,m}$: $\mathbb{C}^{nm\times nm} \to \mathbb{C}^{m\times m}$ and $\text{tr}_2^{n,m} : \mathbb{C}^{nm\times nm} \to \mathbb{C}^{n\times n}$, which are defined as the adjoints of the Kronecker product with the identity matrix, i.e., $(\text{tr}_{1}^{n,m})^{\dagger}(Y) = \mathbb{I}_{n} \otimes Y$ for all $Y \in \mathbb{C}^{m \times m}$, and $(\text{tr}_{2}^{n,m})^{\dagger}(X) = X \otimes \mathbb{I}_{m}$ for all $X \in \mathbb{C}^{n \times n}$. Another interpretation of the partial traces is that they are the unique linear operators which satisfy

$$
tr_1^{n,m}(X \otimes Y) = tr[X]Y
$$

$$
tr_2^{n,m}(X \otimes Y) = tr[Y]X,
$$

for all $X \in \mathbb{C}^{n \times n}$ and $Y \in \mathbb{C}^{m \times m}$. We will also use \oplus to denote the direct sum of matrices, i.e., for matrices $X \in \mathbb{C}^{n \times m}$ and $Y \in \mathbb{C}^{p \times q}$, we define $X \oplus Y \in \mathbb{C}^{(n+p)\times (m+q)}$ as

$$
X \oplus Y = \begin{bmatrix} X & 0 \\ 0 & Y \end{bmatrix}.
$$

Entropy Earlier, we introduced the quantum relative entropy function [\(1\)](#page-0-1). Here, we will briefly introduce some related functions to which we refer throughout the paper. A closely related function is the (von Neumann) quantum entropy, which, through some overloading of notation, is defined as

$$
S(X) := -\operatorname{tr}[X \log(X)],\tag{10}
$$

over the domain \mathbb{H}^n_+ , and is a concave function. We define the *quantum entropy cone* as the hypograph of the homogenized quantum entropy function

$$
\mathcal{K}_{\mathrm{qe}} \coloneqq \mathrm{cl}\{(t, X, y) \in \mathbb{R} \times \mathbb{H}_{++}^n \times \mathbb{R}_{++} : t \ge -yS(X/y)\},\tag{11}
$$

and note that self-concordance of the natural barrier for the quantum entropy cone follows from the same result for the quantum relative entropy cone (see also [\[29\]](#page-34-11)). We also define a function closely related to the quantum entropy,

$$
S_C(X) := -\operatorname{tr}[C \log(X)],\tag{12}
$$

over the domain $\{X \in \mathbb{H}^n_+ : X \ll C\}$, for some matrix $C \in \mathbb{H}^n$. In this notation, we can represent quantum relative entropy as $S(X||Y) = -S(X) + S_X(Y)$. The classical counterparts to these quantum entropies are the (Shannon) classical entropy,

$$
H(x) := -\sum_{i=1}^{n} x_i \log(x_i),
$$
\n(13)

defined over \mathbb{R}^n_+ , and the *classical relative entropy* (or the *Kullback–Leibler divergence*),

$$
H(x \| y) := \sum_{i=1}^{n} x_i \log(x_i/y_i),
$$
\n(14)

defined over $\{(x, y) \in \mathbb{R}_+^n \times \mathbb{R}_+^n : diag(x) \ll diag(y)\}\)$. The classical relative entropy cone is

$$
\mathcal{K}_{\text{cre}} \coloneqq \{ (t, x, y) \in \mathbb{R} \times \mathbb{R}_+^n \times \mathbb{R}_+^n : t \ge H(x \| y), \text{ diag}(x) \ll \text{diag}(y) \}. \tag{15}
$$

Self-concordance of the natural barrier for this cone follows from the same result for the quantum relative entropy cone (see also [\[20,](#page-34-6) Theorem 1]). These classical counterparts will be useful as quantum entropy and quantum relative entropy reduce to classical entropy and classical relative entropy, respectively, when the matrix arguments are diagonal.

3 Examples

This section introduces a collection of quantum relative entropy programs arising from problems in quantum information theory to motivate the techniques we present in Sections [4](#page-7-0) and [5.](#page-13-0) Later in Section [6,](#page-18-0) we show how these techniques can be tailored to efficiently solve each of the problems we present in this section, before providing experimental results which demonstrate the efficacy of our techniques compared to using a lifted representation with respect to the full quantum relative entropy cone.

Readers who are more interested in the theoretical contributions of the paper can start reading from Section [4,](#page-7-0) and treat this section as a reference for the experimental results discussed in Section [6.](#page-18-0)

3.1 Quantum key distribution

Quantum key distribution is a scheme for generating and sharing a private key, which allows two parties to communicate information securely. The security of quantum key distribution protocols depends on a quantity called the key rate, which was originally given by the Devetak-Winter formula [\[30\]](#page-34-12). This was later simplified in [\[11,](#page-33-7) [31\]](#page-34-13) to the following convex optimization problem

$$
\min_{X \in \mathbb{H}^n} \quad S(\mathcal{G}(X) \| \mathcal{Z}(\mathcal{G}(X))) + p_{\text{pass}} \delta_{\text{EC}} \tag{16a}
$$

$$
subj. to \t\mathcal{A}(X) = b \t(16b)
$$

$$
X \succeq 0,\tag{16c}
$$

where $\mathcal{G}: \mathbb{H}^n \to \mathbb{H}^{mr}$ is a positive linear map related to a particular description of a quantum key distribution protocol. Usually, G is given in the form

$$
\mathcal{G}(X) = \sum_{i=1}^{l} K_i X K_i^{\dagger},\tag{17}
$$

where $K_i: \mathbb{C}^n \to \mathbb{C}^{mr}$ for $i = 1, ..., l$, and are known as the Kraus operators associated with \mathcal{G} . Additionally, $\mathcal{Z}: \mathbb{H}^{mr} \to \mathbb{H}^{mr}$ is another positive linear map known as the pinching map, which maps all off-diagonal blocks of a matrix to zero for a given block structure. Concretely, we can represent this as

$$
\mathcal{Z}(Y) = \sum_{i=1}^{r} (e_i e_i^{\top} \otimes \mathbb{I}_m) Y (e_i e_i^{\top} \otimes \mathbb{I}_m), \tag{18}
$$

where $e_i \in \mathbb{C}^r$ are the standard r-dimensional basis vectors for $i = 1, \ldots, r$. Finally, $\mathcal{A} : \mathbb{H}^n \to \mathbb{R}^p$ and $b \in \mathbb{R}^p$ encode a set of experimental constraints $\mathcal{A}(X) = b$, and p_{pass} and δ_{EC} are constants dependent on the quantum key distribution protocol.

Many works have studied the problem of numerically computing the quantum key rate, including [\[11,](#page-33-7) [31\]](#page-34-13) which proposed a first-order Frank-Wolfe method, and [\[16,](#page-34-2) [18,](#page-34-3) [23\]](#page-34-7) who used second-order interiorpoint methods. Alternatively, methods which construct a hierarchy of semidefinite programs to lower bound the quantum key rates were proposed in [\[32,](#page-34-14) [33\]](#page-34-15).

In the following, we will give additional details of the linear map $\mathcal G$ for two particular quantum key distribution protocols. Note we choose to study these protocols as their problem dimensions are parameterized, and are therefore the most computationally interesting examples out of the protocols studied in [\[18\]](#page-34-3).

3.1.1 Discrete-phase-randomized protocol

We first introduce the discrete-phase-randomized variant of the Bennett-Brassard 1984 (dprBB84) pro-tocol [\[34\]](#page-34-16). This protocol is parameterized by a number of global phases c used to generate the private key, and a probability p that a particular measurement basis is chosen. Given these parameters, the Kraus operators of $\mathcal{G}: \mathbb{H}^{12c} \to \mathbb{H}^{48c}$ are given by

K_1 = \sqrt{p} \left[\begin{bmatrix} 1 \\ 0 \end{bmatrix} \otimes \left(\bigoplus_{i=1}^c \Pi_1 \right) + \begin{bmatrix} 0 \\ 1 \end{bmatrix} \otimes \left(\bigoplus_{i=1}^c \Pi_2 \right) \right] \otimes \begin{bmatrix} 1 & 0 \end{bmatrix} \otimes \begin{bmatrix} 1 \\ 0 \end{bmatrix}
$$
(19a)

$$
K_2 = \sqrt{1-p} \left[\begin{bmatrix} 1 \\ 0 \end{bmatrix} \otimes \left(\bigoplus_{i=1}^c \Pi_3 \right) + \begin{bmatrix} 0 \\ 1 \end{bmatrix} \otimes \left(\bigoplus_{i=1}^c \Pi_4 \right) \right] \otimes \begin{bmatrix} 1 & 0 \\ 0 & 1 \end{bmatrix} \otimes \begin{bmatrix} 0 \\ 1 \end{bmatrix}, \tag{19b}
$$

where $\Pi_i \in \mathbb{H}^4$ is defined as $\Pi_i = e_i e_i^{\top} \in \mathbb{H}^4$ for $i = 1, 2, 3, 4$. The pinching map $\mathcal{Z} : \mathbb{H}^{48c} \to \mathbb{H}^{48c}$ is defined to act on a 2×2 block matrix, i.e., $r = 2$. See [\[35,](#page-35-0) Section IV.D] for additional details of this protocol.

3.1.2 Discrete-modulated continuous-variable protocol

The second protocol we study is the discrete-modulated continuous-variable (DMCV) quantum key distribution protocol [\[36\]](#page-35-1). This protocol is parameterized by a cutoff photon number N_c , in which case $G: \mathbb{H}^{4(N_c+1)} \to \mathbb{H}^{16(N_c+1)}$ is defined by a single Kraus operator

$$
K = \sum_{i=1}^{4} e_i \otimes \mathbb{I}_4 \otimes P_i,
$$
\n(20)

where $e_i \in \mathbb{C}^4$ are the standard 4-dimensional basis vectors and $P_i \in \mathbb{H}^{N_c+1}_+$ are positive definite measurement operators for $i = 1, 2, 3, 4$. The pinching map $\mathcal{Z} : \mathbb{H}^{16(N_c+1)} \to \mathbb{H}^{16(N_c+1)}$ is defined to act on a 4×4 block matrix, i.e., $r = 4$. See [\[36,](#page-35-1) Protocol 2] for additional details of this protocol.

3.2 Quantum rate-distortion

When we transmit information through a communication channel, we are often interested in how to encode the information as efficiently as possible. If we can tolerate some error or distortion in the signal, then we can perform a lossy compression scheme to encode our information. The quantum ratedistortion function [\[37,](#page-35-2) [38\]](#page-35-3) quantifies how much a given quantum information source, represented as a positive definite Hermitian matrix $W \in \mathbb{H}^n_+$ with unit trace, can be compressed without exceeding a maximum allowable distortion $D \geq 0$. This distortion is measured as a linear function $X \mapsto \langle \Delta, X \rangle$,

where $\Delta \in \mathbb{H}^{nm}_{+}$ is a positive semidefinite matrix. Given this, the *entanglement-assisted rate-distortion* function is given by

R(D) = \min_{X \in \mathbb{H}^{nm}} S(X \mid \mathbb{I} \otimes \text{tr}_1^{n,m}(X)) + S(W)
$$
\n(21a)

$$
subj. to \ttr_2^{n,m}(X) = W
$$
\n(21b)

$$
\langle \Delta, X \rangle \le D \tag{21c}
$$

$$
X \succeq 0. \tag{21d}
$$

Previous methods proposed to numerically compute the quantum rate-distortion function include [\[13,](#page-33-8) [14,](#page-34-0) [39\]](#page-35-4), which all rely on first-order methods.

3.2.1 Entanglement fidelity distortion

For some choices of Δ , there exists symmetries that we can exploit to reduce the problem dimension of [\(21\)](#page-6-0) [\[14\]](#page-34-0). In particular, let us assume that $W = \text{diag}(w_1, \ldots, w_n)$ is diagonal, which we can do without loss of generality due to unitary invariance of the rate-distortion problem [\[14,](#page-34-0) Appendix B]. Then it is standard to measure distortion using the entanglement fidelity distortion measure, which corresponds to taking $m = n$ and

\Delta = \mathbb{I} - \sum_{i=1}^{n} \sum_{j=1}^{n} \sqrt{w_i w_j} e_i e_j^{\top} \otimes e_i e_j^{\top}.

 (22)

For this choice of Δ , we know from [\[14,](#page-34-0) Theorem 4.13] that a solution to the problem [\(21\)](#page-6-0) must lie in the subspace

$$
\mathcal{V} = \left\{ \sum_{i \neq j}^{n} y_{ij} e_i e_i^{\top} \otimes e_j e_j^{\top} + \sum_{ij}^{n} Z_{ij} e_i e_j^{\top} \otimes e_i e_j^{\top} : y_{ij} \in \mathbb{R} \; \forall i \neq j, \; Z \in \mathbb{H}^n \right\},\tag{23}
$$

which can be interpreted as a block diagonal subspace with $n^2 - n$ blocks of size 1×1 , and one block of size $n \times n$. This allows us to numerically compute the quantum rate-distortion function more efficiently by only searching over the $(2n^2 - n)$ -dimensional subspace V, rather than the full n^4 -dimensional vector space \mathbb{H}^{n^2} .

3.3 Quantum channel capacity

A closely related concept to the rate-distortion function is the channel capacity, which characterizes the maximum rate of information that can be transmitted reliably through a noisy quantum channel represented by a completely positive trace preserving (see, e.g., [\[40,](#page-35-5) Definitions 4.4.2 and 4.4.3]) linear map $\mathcal{N}: \mathbb{H}^n \to \mathbb{H}^m$. Quantum channel capacities depend on what resources are available. We briefly describe two of these settings below.

3.3.1 Entanglement-assisted capacity

First, we recognize that any quantum channel $\mathcal N$ can always be associated with an isometry matrix $V \in \mathbb{C}^{m p \times n}$ such that $\mathcal{N}(X) = \text{tr}_2^{m,p}(V X V^{\dagger})$ [\[41,](#page-35-6) Proposition 2.20]. Given this, the *entanglement*assisted channel capacity [\[42\]](#page-35-7) for this quantum channel is given by

$$
\max_{X \in \mathbb{H}^n} \quad -S(VXV^{\dagger} \|\mathbb{I} \otimes \text{tr}_{1}^{m,p}(VXV^{\dagger})) + S(\text{tr}_{2}^{m,p}(VXV^{\dagger})) \tag{24a}
$$

$$
subj. to \t tr[X] = 1
$$
\n(24b)

$$
X \succeq 0. \tag{24c}
$$

Note that the objective function in [\(24a\)](#page-6-1) is known as the quantum mutual information. In [\[13,](#page-33-8) [43\]](#page-35-8), first-order methods were proposed to numerically compute the entanglement-assisted channel capacity. Interior-point methods were used to compute these capacities in [\[19,](#page-34-4) [44\]](#page-35-9), however these methods were limited to computing the capacity for a single-qubit amplitude damping channel (i.e., where $n = m =$ $p = 2$).

3.3.2 Quantum-quantum capacity of degradable channels

Again, consider a quantum channel N defined as $\mathcal{N}(X) = \text{tr}_2^{m,p}(V X V^{\dagger})$ for some isometry matrix $V \in \mathbb{C}^{mp \times n}$. The complementary channel $\mathcal{N}_{c} : \mathbb{H}^{n} \to \mathbb{H}^{p}$ is defined as $\mathcal{N}_{c}(X) = \text{tr}_{1}^{m,p}(V X V^{\dagger})$. A degradable channel is a quantum channel N such that its complementary channel N_c can be expressed as $\mathcal{N}_{c} = \Xi \circ \mathcal{N}$ for some completely positive trace preserving linear map $\Xi : \mathbb{H}^{m} \to \mathbb{H}^{p}$.

The second quantum channel capacity we will consider is the quantum-quantum channel capacity [\[45–](#page-35-10) [47\]](#page-35-11). In general, this channel capacity is given by a non-convex optimization problem. However, if the channel $\mathcal N$ is degradable, then the channel capacity is given by [\[48\]](#page-35-12)

\max_{X \in \mathbb{H}^n} \quad -S(W\mathcal{N}(X)W^\dagger \, \| \, \mathbb{I} \otimes \text{tr}_1^{p,q}(W\mathcal{N}(X)W^\dagger)) \tag{25a}
$$

$$
subj. to \t tr[X] = 1
$$
\n(25b)

$$
X \succeq 0,\tag{25c}
$$

where $W \in \mathbb{C}^{pq \times m}$ is the isometry matrix associated with Ξ such that $\Xi(X) = \text{tr}_2^{p,q}(WXW^{\dagger})$. Note that the objective function in [\(25a\)](#page-7-1) is a simplification of the quantum coherent information when $\mathcal N$ is degradable. Numerically computing the quantum-quantum channel capacity for degradable channels was studied in [\[44\]](#page-35-9) for the single-qubit amplitude damping channel (i.e., where $n = m = p = q = 2$).

3.4 Ground state energy of Hamiltonians

A fundamental question in quantum many-body theory is to compute the ground energy of local Hamiltonians [\[49\]](#page-35-13). A translation-invariant 2-local Hamiltonian on an infinite one-dimensional chain is described by a single 4×4 Hermitian matrix h. In [\[50\]](#page-35-14), it was shown that the ground energy density of such a Hamiltonian can be lower bounded by solving the convex optimization problem

\min_{X \in \mathbb{H}^{2^l}} \langle h \otimes \mathbb{I}_{2^{l-2}}, X \rangle \tag{26a}

$$

S(X \|\mathbb{I} \otimes \text{tr}_1^{2,2^{t-1}}(X)) \le 0 \tag{26d}
$$

$$
X \succeq 0,\tag{26e}

where l controls the accuracy of the lower bound which converges to the true value as $l \to \infty$. First-order splitting methods were used in [\[50\]](#page-35-14) to solve for this relaxation for problem sizes of up to $l = 8$.

4 Optimal self-concordant barriers

In this section, we establish (optimal) self-concordance of the natural barrier of the epigraph of quantum relative entropy composed with positive linear maps, as well as for the epigraphs of related functions. To present our main result, we first introduce the following class of divergence measures called quasientropies, which were studied in [\[51,](#page-35-15) [52\]](#page-35-16) and can be interpreted as a quantum extension of the classical f-divergences. For a function $g:(0,\infty) \to \mathbb{R}$, the quasi-entropy $S_g: \mathbb{H}^n_{++} \times \mathbb{H}^n_{++} \to \mathbb{R}$ is defined as

$$
S_g(X \parallel Y) = \Psi[P_g(X \otimes \mathbb{I}, \mathbb{I} \otimes \overline{Y})],\tag{27}
$$

where $\Psi : \mathbb{H}^{n^2} \to \mathbb{R}$ is the unique linear operator satisfying $\Psi[X \otimes \overline{Y}] = \text{tr}[XY]$, and

$$
P_g(X,Y) = X^{1/2}g(X^{-1/2}YX^{-1/2})X^{1/2},\tag{28}
$$

represents the noncommutative perspective of g . When g is operator concave, meaning that for all integers $n, X, Y \in \mathbb{H}_{++}^n$, and $\lambda \in [0,1]$, we have

$$
g(\lambda X + (1 - \lambda)Y) \succeq \lambda g(X) + (1 - \lambda)Y,\tag{29}
$$

then the quasi-entropy is a concave function [\[51,](#page-35-15) Proposition 3.10]. Notably, when $g(x) = -\log(x)$, it turns out that S_g is the quantum relative entropy function. Under certain circumstances (see [\[3,](#page-33-2) Theorem B.3]), is possible to extend the quasi-entropy function to the boundary of the positive semidefinite cone by considering the appropriate limit

$$
S_g(X \parallel Y) = \lim_{\varepsilon \downarrow 0} \Psi[P_g((X + \varepsilon \mathbb{I}) \otimes \mathbb{I}, \mathbb{I} \otimes (\overline{Y} + \varepsilon \mathbb{I})).
$$
\n(30)

When $X, Y \in \mathbb{H}_{++}^n$, this limit coincides with the original definition of quasi-entropy. For example, when $g(x) = -\log(x)$, this limit is well defined for all $X, Y \in \mathbb{H}^n_+$ such that $X \ll Y$. In [\[3\]](#page-33-2), it was shown that the barrier function

$$
(t, X, Y) \in \mathbb{R} \times \mathbb{H}^n_{++} \times \mathbb{H}^n_{++} \mapsto -\log(S_g(X \, \| \, Y) - t) - \log \det(X) - \log \det(Y),\tag{31}
$$

is an optimal $(2n + 1)$ -logarithmically homogeneous self-concordant barrier for cl hypo S_g when g is operator concave. However, in many problems arising in quantum information theory, we are interested in minimizing quasi-entropies composed with positive linear maps, i.e., functions of the form

$$
S_g^{\mathcal{N}_1, \mathcal{N}_2}(X) \coloneqq S_g(\mathcal{N}_1(X) \| \mathcal{N}_2(X)),\tag{32}
$$

defined over \mathbb{H}^n_{++} , for positive linear operators $\mathcal{N}_1 : \mathbb{H}^n \to \mathbb{H}^m$ and $\mathcal{N}_2 : \mathbb{H}^n \to \mathbb{H}^m$. Often, these linear operators map to singular matrices, in which some care is needed to ensure the function is well-defined. The following set of assumptions outlines all possible scenarios when this function is well-defined when using the limit [\(30\)](#page-8-1), and closely mirrors the results from [\[3,](#page-33-2) Theorem B.3].

Assumption A. Consider a function $g:(0,\infty) \to \mathbb{R}$ and positive linear maps $\mathcal{N}_1 : \mathbb{H}^n \to \mathbb{H}^m$ and $\mathcal{N}_2 : \mathbb{H}^n \to \mathbb{H}^m$. Let $\hat{g}(x) := xg(1/x)$ denote the transpose of g, and let $g(0^+) := \lim_{x\to 0} g(x)$ and $\hat{q}(0^+) := \lim_{x\to 0} \hat{q}(x)$. Assume that any one of the following conditions is satisfied

- (i) $\mathcal{N}_1(X) \ll \mathcal{N}_2(X)$ for all $X \in \mathbb{H}^n_{++}$ and $\hat{g}(0^+) > \infty$, or
- (ii) $\mathcal{N}_2(X) \ll \mathcal{N}_1(X)$ for all $X \in \mathbb{H}_{++}^n$ and $g(0^+) > \infty$, or
- (iii) ker $\mathcal{N}_1(X) = \ker \mathcal{N}_2(X)$ for all $X \in \mathbb{H}_{++}^n$, or
- (iv) $\hat{q}(0^+) > \infty$ and $q(0^+) > \infty$.

Our main theorem, stated below, extends the result in [\[3\]](#page-33-2) by giving optimal logarithmically homogeneous self-concordant barriers for the epigraph of quasi-entropy when composed with positive linear maps, which possibly map to singular matrices.

Theorem 4.1. Let $g:(0,\infty) \to \mathbb{R}$ be an operator concave function, and let P_g be its noncommutative perspective. Let \mathcal{N}_1 : $\mathbb{H}^n \to \mathbb{H}^m$ and \mathcal{N}_2 : $\mathbb{H}^n \to \mathbb{H}^m$ be positive linear operators. If [A](#page-8-2)ssumption A is satisfied, then the function

$$
(t, X) \in \mathbb{R} \times \mathbb{H}_{++}^n \mapsto -\log(S_g^{\mathcal{N}_1, \mathcal{N}_2}(X) - t) - \log \det(X),\tag{33}
$$

is an $(n + 1)$ -logarithmically homogeneous self-concordant barrier for the set

$$
\operatorname{cl} \operatorname{hypo} S_g^{\mathcal{N}_1, \mathcal{N}_2} = \operatorname{cl}\{(t, X) \in \mathbb{R} \times \mathbb{H}_{++}^n : S_g^{\mathcal{N}_1, \mathcal{N}_2}(X) \ge t\},\tag{34}
$$

 \Box

where $S_g^{\mathcal{N}_1,\mathcal{N}_2} : \mathbb{H}_{++}^n \to \mathbb{R}$ is defined in [\(32\)](#page-8-3). Moreover, this barrier is optimal in the sense that any self-concordant barrier for cl hypo $S_g^{\mathcal{N}_1, \mathcal{N}_2}$ has parameter at least $n+1$.

Proof. See Section [4.2.](#page-11-0)

We note that when \mathcal{N}_1 and \mathcal{N}_2 both preserve positive definiteness, i.e., $\mathcal{N}_1(X) \succ 0$ and $\mathcal{N}_2(X) \succ 0$ for all $X \succ 0$, then this result is a straightforward consequence of [\[53,](#page-35-17) Lemma 5.1.3(iii)]. However, it is nontrivial to extend this result to when \mathcal{N}_1 and \mathcal{N}_2 map to a face of the positive semidefinite cone, which will be the main effort in our proof for this theorem.

We previously showed how Theorem [4.1](#page-8-0) could be applied to the quantum relative entropy function in Corollary [1.2](#page-2-3) by taking $g(x) = -\log(x)$. We now present some additional extensions of this result which demonstrate how it can be applied to the applications listed in Section [3.](#page-4-0) We omit proofs of results which are a direct consequence of Corollary [1.2.](#page-2-3) The first result provides a suitable self-concordant barrier for the quantum conditional entropy function $X \mapsto S(X \parallel \mathbb{I} \otimes \text{tr}_1^{n,m}(X))$, which arises in many applications in quantum information theory including the quantum rate-distortion problem from Section [3.2,](#page-5-0) quantum channel capacities from Section [3.3,](#page-6-2) and the ground state energy of Hamiltonians from Section [3.4.](#page-7-2)

Corollary 4.2. The function

$$
(t, X) \in \mathbb{R} \times \mathbb{H}^{nm}_{++} \mapsto -\log(t - S(X \parallel \mathbb{I} \otimes \operatorname{tr}^{n,m}_1(X))) - \log \det(X), \tag{35}
$$

is an $(nm + 1)$ -logarithmically homogeneous self-concordant barrier of the quantum conditional entropy cone

$$
\mathcal{K}_{\text{qce}} = \text{cl}\{(t, X) \in \mathbb{R} \times \mathbb{H}^{nm}_{++} : t \ge S(X \mid \mathbb{I} \otimes \text{tr}^{n,m}_1(X))\}.
$$
\n
$$
(36)
$$

Moreover, this barrier is optimal in the sense that any self-concordant barrier for \mathcal{K}_{qce} has parameter at $least\ nm+1.$

Next, we present a suitable barrier for the restriction of the quantum conditional entropy cone to the fixed point subspace [\(23\)](#page-6-3), which we can use to compute the quantum rate-distortion function with entanglement fidelity distortion introduced in Section [3.2.1.](#page-6-4)

Corollary 4.3. Let us parameterize the subspace [\(23\)](#page-6-3) using $(y, Z) \in \mathbb{R}^{n^2 - n} \times \mathbb{H}^n$ together with the linear $map \mathcal{G}: \mathbb{R}^{n^2-n} \times \mathbb{H}^n \to \mathbb{H}^{n^2}$ defined by

$$
\mathcal{G}(y,Z) = \sum_{i \neq j}^{n} y_{ij} e_i e_i^{\top} \otimes e_j e_j^{\top} + \sum_{ij}^{n} Z_{ij} e_i e_j^{\top} \otimes e_i e_j^{\top}.
$$
 (37)

Then the restriction of (35) to the subspace (23) , i.e.,

$$
(t, y, Z) \in \mathbb{R} \times \mathbb{R}_{++}^{n^2 - n} \times \mathbb{H}_{++}^n \mapsto -\log(t - S(\mathcal{G}(y, Z) \|\mathbb{I} \otimes \operatorname{tr}_1^{n, n}(\mathcal{G}(y, Z)))) - \sum_{i \neq j}^n \log(y_{ij}) - \log \det(Z), \tag{38}
$$

is an $(n^2 + 1)$ -logarithmically homogeneous self-concordant barrier for the restriction of the quantum conditional entropy cone to [\(23\)](#page-6-3), i.e.,

$$
\mathcal{K}_{\text{qrd}} := \text{cl}\{(t, y, Z) \in \mathbb{R} \times \mathbb{R}_{++}^{n^2 - n} \times \mathbb{H}_{++}^n : t \ge S(\mathcal{G}(y, Z) \|\mathbb{I} \otimes \text{tr}_1^{n, n}(\mathcal{G}(y, Z)))\}.
$$
\n(39)

Moreover, this barrier is optimal in the sense that any self-concordant barrier for K_{ord} has parameter at least n^2+1 .

Proof. See Section [4.3.](#page-13-1)

The next two corollaries deal with quantum mutual information and quantum coherent information, which are used to compute the quantum channel capacities from Section [3.3.](#page-6-2)

Corollary 4.4. Let $V \in \mathbb{C}^{mp \times n}$ be an isometry matrix. The function

$$
(t, X) \in \mathbb{R} \times \mathbb{H}^n_{++} \mapsto -\log(t - [S(VXV^{\dagger} \|\mathbb{I} \otimes \text{tr}_1^{m,p}(VXV^{\dagger})) - S(\text{tr}_2^{m,p}(VXV^{\dagger})) + S(\text{tr}[X])]) - \log \det(X), \tag{40}
$$

is an $(n + 1)$ -logarithmically homogeneous self-concordant barrier for the quantum mutual information cone, i.e.,

$$
\mathcal{K}_{\mathrm{qmi}} := \mathrm{cl}\big\{(t, X) \in \mathbb{R} \times \mathbb{H}_{++}^n : t \geq S(VXV^\dagger \, \| \, \mathbb{I} \otimes \mathrm{tr}_1^{m,p}(VXV^\dagger)) - S(\mathrm{tr}_2^{m,p}(VXV^\dagger)) + S(\mathrm{tr}[X])\big\}.\tag{41}
$$

Moreover, this barrier is optimal in the sense that any self-concordant barrier for K_{ami} has parameter at least $n+1$.

Proof. See Section [4.3.](#page-13-1)

Corollary 4.5. Consider a positive linear map $\mathcal{N} : \mathbb{H}^n \to \mathbb{H}^m$ and an isometry matrix $W \in \mathbb{C}^{pq \times m}$. Then

$$
(t, X) \in \mathbb{R} \times \mathbb{H}^n_{++} \mapsto -\log(t - S(W\mathcal{N}(X)W^{\dagger} \|\mathbb{I} \otimes \text{tr}_1^{p,q}(W\mathcal{N}(X)W^{\dagger})) - \log \det(X), \tag{42}
$$

is an $(n+1)$ -logarithmically homogeneous self-concordant barrier for the quantum coherent information cone for degradable channels, i.e.,

$$
\mathcal{K}_{\mathrm{qci}} \coloneqq \mathrm{cl}\big\{(t, X) \in \mathbb{R} \times \mathbb{H}_{++}^n : t \geq S(W\mathcal{N}(X)W^\dagger \|\mathbb{I} \otimes \mathrm{tr}_1^{p,q}(W\mathcal{N}(X)W^\dagger))\big\}.
$$
 (43)

Moreover, this barrier is optimal in the sense that any self-concordant barrier for K_{qci} has parameter at least $n+1$.

 \Box

 \Box

4.1 Self-concordant barriers preliminaries

Let V be a finite-dimensional real vector space, and let $F : \text{dom } F \subset \mathbb{V} \to \mathbb{R}$ be a closed, convex, C^3 function with open domain dom $F \subset V$. We say that F is self-concordant if

$$
|\nabla^3 F(x)[h, h, h]| \le 2(\nabla^2 F(x)[h, h])^{3/2},\tag{44}
$$

for all $x \in \text{dom } F$ and $h \in \mathbb{V}$. If, additionally, we have

$$
2 \nabla F(x)[h] - \nabla^2 F(x)[h, h] \le \nu,
$$
\n(45)

for all $x \in \text{dom } F$ and $h \in V$, then we say F is a v-self-concordant barrier for the set cldom F. Additionally, we say that F is ν -logarithmically homogeneous if there is a constant $\nu \geq 1$ such that

$$
F(\tau x) = F(x) - \nu \log(\tau),\tag{46}
$$

for all $x \in \text{int dom } F$ and $\tau > 0$. Note that if F is a v-logarithmically homogeneous self-concordant barrier, then it must also be a ν -self-concordant barrier [\[54,](#page-35-18) Lemma 5.4.3]. Next, we introduce a generalized notion of concavity with respect to the positive semidefinite cone, followed by the concept of compatibility of a function with respect to a domain.

Definition 4.6. Let \mathbb{V} be a finite-dimensional real vector space. A function f : dom $f \in \mathbb{V} \to \mathbb{H}^n$ with convex domain dom $f \subset \mathbb{V}$ is \mathbb{H}^n -concave if for all $X, Y \in \text{dom } f$ and $\lambda \in [0, 1]$, we have

$$
f(\lambda X + (1 - \lambda)Y) \succeq \lambda f(X) + (1 - \lambda)f(Y).
$$

Definition 4.7 ([\[53,](#page-35-17) Definition 5.1.1]). Let \mathbb{V} be a finite-dimensional real vector space, and let f: $dom f \subset \mathbb{V} \to \mathbb{H}^n$ be a C^3 , \mathbb{H}^n -concave function with open domain dom $f \subset \mathbb{V}$. Then f is β -compatible with the domain cl dom f if there is a constant $\beta \geq 0$ such that

$$
\nabla^3 f(x)[h, h, h] \preceq -3\beta \nabla^2 f(x)[h, h],
$$

for all $x \in \text{dom } f$ and $h \in \mathbb{V}$ such that $x \pm h \in \text{cl dom } f$.

Remark 4.8. The proofs and results in [\[3\]](#page-33-2) use an alternative definition of compatibility with respect to a barrier of a domain [\[53,](#page-35-17) Definition 5.1.2]. Although compatibility with respect to a domain is a stronger condition than compatibility with respect to a barrier of a domain $[53,$ Remark 5.1.2], all of the results from [\[3\]](#page-33-2) that we use in this paper can be modified to use either definition for compatibility by using nearly identical arguments.

We also introduce two important composition rules for compatibility with linear and affine maps from $[3,$ Proposition 3.4] and $[53,$ Lemma 5.1.3(iii)].

Lemma 4.9. Let \mathbb{V} and \mathbb{V}' be finite-dimensional real vector spaces, let $f : \text{dom } f \subset \mathbb{V} \to \mathbb{H}^n$ be a C^3 , \mathbb{H}^n -concave function with open domain dom $f \subset \mathbb{V}$ which is β -compatible with the domain cl dom f.

- (i) Let $\mathcal{A} : \mathbb{H}^n \to \mathbb{H}^m$ be a positive linear map. Then $\mathcal{A} \circ f$ is β -compatible with the domain cldom f.
- (ii) Let $\mathcal{B}: \mathbb{V}' \to \mathbb{V}$ be an affine map satisfying im $\mathcal{B} \cap \text{dom } f \neq \emptyset$. Then $f \circ \mathcal{B}$ is β -compatible with the domain

 $\mathcal{B}^{-1}(\text{cl dom } f) \coloneqq \{x \in \mathbb{V}' : \mathcal{B}(x) \in \text{cl dom } f\}.$

Compatibility is useful as it allows for a convenient method to construct self-concordant barriers of epigraphs of functions. This is summarized by [\[3,](#page-33-2) Theorem 3.3], which is a special case of [\[54,](#page-35-18) Theorem 5.4.4], and which we restate here for convenience.

Lemma 4.10. [\[54,](#page-35-18) Theorem 5.4.4] Let $\mathbb V$ be a finite-dimensional real vector space, and let f : dom f ⊂ $\mathbb{V} \to \mathbb{H}^n$ be a C^3 , \mathbb{H}^n -concave function with open domain dom $f \subset \mathbb{V}$. If F is a v-self-concordant barrier for cl dom f, and f is β -compatible with cl dom f, then $(t, x) \mapsto -\log \det(f(x) - t) + \beta^3 F(x)$ is an $(m + \beta^3 \nu)$ -self-concordant barrier for cldom f.

Finally, we recall one of the results from [\[3\]](#page-33-2) which establishes compatibility of the non-commutative perspective.

Lemma 4.11 ([\[3,](#page-33-2) Proposition 3.5]). Let $g:(0,\infty) \to \mathbb{R}$ be an operator concave function, and let P_g be its noncommutative perspective. Then $(X, Y) \in \mathbb{H}^{n_1}_{++} \times \mathbb{H}^{n_2}_{++} \mapsto P_g(X \otimes \mathbb{I}, \mathbb{I} \otimes \overline{Y})$ is 1-compatible with the domain $\mathbb{H}^{n_1}_+ \times \mathbb{H}^{n_2}_+$.

Using this result together with appropriate applications of the composition rules from Lemma [4.9](#page-10-1) will form the backbone of our proof of Theorem [4.1.](#page-8-0)

4.2 Proof of Theorem [4.1](#page-8-0)

We begin with a simple lemma which helps us to characterize positive linear maps which map to singular matrices.

Lemma 4.12. Let $\mathcal{N} : \mathbb{H}^n \to \mathbb{H}^m$ be a positive linear map, and let $\mathcal{N}(\mathbb{I})$ have spectral decomposition

$$
\mathcal{N}(\mathbb{I}) = \begin{bmatrix} U & V \end{bmatrix} \begin{bmatrix} \Lambda & 0 \\ 0 & 0 \end{bmatrix} \begin{bmatrix} U^{\dagger} \\ V^{\dagger} \end{bmatrix} = U \Lambda U^{\dagger},
$$

where $U \in \mathbb{C}^{n \times r}$, $V \in \mathbb{C}^{n \times (n-r)}$ are isometry matrices, and $\Lambda \in \mathbb{R}^{r \times r}$ is a diagonal matrix with strictly positive diagonal entries. Then for any $X \in \mathbb{H}^n$, we have $\mathcal{N}(X) = U \hat{X} U^{\dagger}$ for some $\hat{X} \in \mathbb{H}^r$. If, additionally, $X \succ 0$, then $\hat{X} \succ 0$.

Proof. This follows from [\[18,](#page-34-3) Lemma 3.8] and [\[55,](#page-35-19) Theorem 6.6].

To prove Theorem [4.1,](#page-8-0) it would be convenient to use the composition rules outlined in Lemma [4.9](#page-10-1) together with the compatibility result from Lemma [4.11.](#page-10-2) However, when \mathcal{N}_1 or \mathcal{N}_2 map to singular matrices, we can no longer use a direct application of Lemma [4.9\(ii\)](#page-10-3) as the intersection between a face of the positive semidefinite cone and the interior of the positive semidefinite cone is empty. Instead, we first show in the following theorem that we can always rewrite $S_g^{\mathcal{N}_1,\mathcal{N}_2}$ as an appropriate composition between the noncommutative perspective and positive linear maps which map to the interior of the positive semidefinite cone, after which the desired composition rules become applicable.

Theorem 4.13. For a function $g:(0,\infty) \to \mathbb{R}$, let P_g be its noncommutative perspective. Let \mathcal{N}_k : $\mathbb{H}^n \to \mathbb{H}^m$ for $k = 1, 2$ be positive linear operators such that

$$
\mathcal{N}_k(\mathbb{I}) = \begin{bmatrix} U_k & V_k \end{bmatrix} \begin{bmatrix} \Lambda_k & 0 \\ 0 & 0 \end{bmatrix} \begin{bmatrix} U_k^{\dagger} \\ V_k^{\dagger} \end{bmatrix} = U_k \Lambda_k U_k^{\dagger},
$$

where $U_k \in \mathbb{C}^{n \times r_k}$, $V_k \in \mathbb{C}^{n \times (n-r_k)}$ are isometry matrices, and $\Lambda_k \in \mathbb{R}^{r_k \times r_k}_{++}$ is a diagonal matrix with strictly positive diagonal entries. Let $\hat{\Psi}$: $\mathbb{H}^{n^2} \to \mathbb{R}$ be the unique linear operator satisfying $\hat{\Psi}[X \otimes \overline{Y}] =$ $tr[U_1XU_1^{\dagger}U_2YU_2^{\dagger}]$. Consider the function $h: \mathbb{H}_{++}^n \to \mathbb{R}$ defined by

$$
h(X) = \hat{\Psi}\big[P_g(U_1^\dagger \mathcal{N}_1(X)U_1 \otimes \mathbb{I}, \mathbb{I} \otimes \overline{U_2^\dagger \mathcal{N}_2(X)U_2})\big].
$$

If [A](#page-8-2)ssumption A is satisfied, then for all $X \in \mathbb{H}^n_{++}$, we have

$$
S_g^{\mathcal{N}_1, \mathcal{N}_2}(X) = h(X) + \text{tr}[XC],
$$

where $C \in \mathbb{H}^n$ is some constant matrix dependent on \mathcal{N}_1 , \mathcal{N}_2 , and g.

Proof. Consider any two positive definite matrices $A \in \mathbb{H}_{++}^{n_a}$ and $B \in \mathbb{H}_{++}^{n_b}$ with spectral decompositions $A = \sum_{i=1}^{n_a} a_i R_i$ and $B = \sum_{i=1}^{n_b} b_i S_i$. Since $A \otimes \mathbb{I}$ and $\mathbb{I} \otimes B$ commute, we have

$$
P_g(A \otimes \mathbb{I}, \mathbb{I} \otimes B) = (A \otimes \mathbb{I}) g(A^{-1} \otimes B) = \sum_{i=1}^{n_a} \sum_{j=1}^{n_b} a_i g\left(\frac{b_j}{a_i}\right) R_i \otimes S_j.
$$
 (47)

Now using Lemma [4.12,](#page-11-1) for any $X \in \mathbb{H}_{++}^n$ we can always represent $\mathcal{N}_1(X)$ and $\mathcal{N}_2(X)$ using the spectral decompositions $\mathcal{N}_1(X) = \sum_{i=1}^{r_1} \lambda_i P_i$ and $\mathcal{N}_2(X) = \sum_{i=1}^{r_2} \mu_i Q_i$, where $\lim P_i \subseteq \lim U_1$ and $\lambda_i > 0$ for all $i = 1, \ldots, r_1$, and $\text{im } Q_i \subseteq \text{im } U_2$ and $\mu_i > 0$ for all $i = 1, \ldots, r_2$. Therefore, noting that $U_1^{\dagger} \mathcal{N}_1(X) U_1$ and $U_2^{\dagger} \mathcal{N}_2(X) U_2$ are positive definite and using [\(47\)](#page-11-2), we obtain

$$
h(X) = \hat{\Psi}\left[\sum_{i=1}^{r_1}\sum_{j=1}^{r_2}\lambda_i g\left(\frac{\mu_j}{\lambda_i}\right)U_1^{\dagger}P_iU_1 \otimes \overline{U_2^{\dagger}Q_jU_2}\right] = \sum_{i=1}^{r_1}\sum_{j=1}^{r_2}\lambda_i g\left(\frac{\mu_j}{\lambda_i}\right) \text{tr}[P_iQ_j].
$$

Now let $P^0 = V_1 V_1^{\dagger}$ and $Q^0 = V_2 V_2^{\dagger}$ be the projectors onto ker $\mathcal{N}_1(X)$ and ker $\mathcal{N}_2(X)$, respectively. Note that these projectors are independent of X, by Lemma [4.12.](#page-11-1) Then using (30) and (47) we can similarly

 \Box

show that

$$
S_g^{\mathcal{N}_1, \mathcal{N}_2}(X) = \lim_{\varepsilon \downarrow 0} \Psi \Big[P_g((\mathcal{N}_1(X) + \varepsilon \mathbb{I}) \otimes \mathbb{I}, \mathbb{I} \otimes (\overline{\mathcal{N}_2(X)} + \varepsilon \mathbb{I})) \Big]
$$

\n
$$
= \lim_{\varepsilon \downarrow 0} \left\{ \sum_{i=1}^{r_1} \sum_{j=1}^{r_2} \left[(\lambda_i + \varepsilon) g\left(\frac{\mu_j + \varepsilon}{\lambda_i + \varepsilon}\right) \text{tr}[P_i Q_j] \right] + \sum_{i=1}^{r_1} \left[(\lambda_i + \varepsilon) g\left(\frac{\varepsilon}{\lambda_i + \varepsilon}\right) \text{tr}[P_i Q^0] \right] \right.
$$

\n
$$
+ \sum_{j=1}^{r_2} \left[(\mu_j + \varepsilon) \hat{g}\left(\frac{\varepsilon}{\mu_j + \varepsilon}\right) \text{tr}[P^0 Q_j] \right] + \varepsilon g(1) \text{tr}[P^0 Q^0] \right\}
$$

\n
$$
= h(X) + \lim_{\varepsilon \downarrow 0} \left\{ \sum_{i=1}^{r_1} \left[(\lambda_i + \varepsilon) g\left(\frac{\varepsilon}{\lambda_i + \varepsilon}\right) \text{tr}[P_i Q^0] \right] + \sum_{j=1}^{r_2} \left[(\mu_j + \varepsilon) \hat{g}\left(\frac{\varepsilon}{\mu_j + \varepsilon}\right) \text{tr}[P^0 Q_j] \right] \right\},
$$

where we have used the identity $xg(y/x) = y\hat{g}(x/y)$ in the second equality. For each scenario (i)–(iv) in Assumption [A,](#page-8-2) the remaining limit is well-defined and reduces to a linear expression in X . We will only illustrate this for scenario (i), as similar arguments can be used for the other cases. For this scenario, we have that the columns of V_2 are all orthogonal to the columns of U_1 , and therefore $tr[P_iQ^0] = 0$ for all $i = 1, \ldots, r_1$. As the limit $\hat{g}(0^+)$ is also assumed to be finite, then

$$
S_g^{\mathcal{N}_1, \mathcal{N}_2}(X) = h(X) + \sum_{j=1}^{r_2} \mu_j \hat{g}(0^+) \operatorname{tr}[P^0 Q_j] = h(X) + \hat{g}(0^+) \operatorname{tr}[P^0 \mathcal{N}_2(X)],
$$

i.e., we have the desired form where $C = \hat{g}(0^+)\mathcal{N}_2^{\dagger}(P^0)$, which is independent of X since P^0 is independent of X. \Box

Using this, we can prove the following compatibility result.

Corollary 4.14. Let $g:(0,\infty) \to \mathbb{R}$ be an operator concave function, and let P_g be its noncommutative perspective. Let $\mathcal{N}_1 : \mathbb{H}^n \to \mathbb{H}^m$ and $\mathcal{N}_2 : \mathbb{H}^n \to \mathbb{H}^m$ be positive linear operators. If [A](#page-8-2)ssumption A is satisfied, then the function $S_g^{\mathcal{N}_1,\mathcal{N}_2} : \mathbb{H}^n_{++} \to \mathbb{R}$, as defined in [\(32\)](#page-8-3), is 1-compatible with the domain \mathbb{H}^n_+ .

Proof. First, using Lemmas [4.9](#page-10-1)[\(i\)](#page-10-4) and [4.11](#page-10-2) and recognizing that $\hat{\Psi}$ is a positive linear map, we know that

$$
(X,Y) \in \mathbb{H}^{r_1}_{++} \times \mathbb{H}^{r_2}_{++} \mapsto \hat{\Psi}[P_g(X \otimes \mathbb{I}, \mathbb{I} \otimes \overline{Y})],\tag{48}
$$

is 1-compatible with the domain $\mathbb{H}^{r_1}_+ \times \mathbb{H}^{r_2}_+$. Next, we recognize from Lemma [4.12](#page-11-1) that

$$
\{(U_1^{\dagger} \mathcal{N}_1(X) U_1, U_2^{\dagger} \mathcal{N}_2(X) U_2) : X \in \mathbb{H}^n\} \cap (\mathbb{H}_{++}^{r_1} \times \mathbb{H}_{++}^{r_2}) \neq \emptyset.
$$

Therefore, we can apply Lemma [4.9\(ii\)](#page-10-3) where $\mathcal{B}: \mathbb{H}^n \to \mathbb{H}^{r_1} \times \mathbb{H}^{r_2}, \mathcal{B}(X) = (U_1^{\dagger} \mathcal{N}_1(X) U_1, U_2^{\dagger} \mathcal{N}_2(X) U_2)$ and f is (48) to show that h is 1-compatible with the domain

$$
\mathcal{C} \coloneqq \{ X \in \mathbb{H}^n : U_k^{\dagger} \mathcal{N}_k(X) U_k \in \mathbb{H}_+^{r_k}, \ \forall k = 1, 2 \}.
$$

As $X \mapsto U_k^{\dagger} \mathcal{N}_k(X) U_k$ are positive linear maps for $k = 1, 2$, we know that $\mathbb{H}^n_+ \subseteq \mathcal{C}$. Therefore, it follows from the definition of compatibility that h must also be 1-compatible with the domain \mathbb{H}^n_+ . By definition, compatibility only depends on the second and third derivatives of a function. Therefore it also follows that $S_g^{\mathcal{N}_1,\mathcal{N}_2}$, which only has an additional linear term, must also be 1-compatible with the domain \mathbb{H}^n_+ , as desired.

The proof for the main theorem is now a straightforward consequence of this compatibility result.

Proof of Theorem [4.1.](#page-8-0) The fact that [\(33\)](#page-8-4) is a self-concordant barrier for clhypo $S_g^{\mathcal{N}_1,\mathcal{N}_2}$ follows from Corollary [4.14](#page-12-1) and Lemma [4.10,](#page-10-5) where we use the fact that $X \in \mathbb{H}^n_{++} \mapsto -\log \det(X)$ is an n-selfconcordant barrier for the domain \mathbb{H}^n_+ . Logarithmic homoegeneity with parameter $n+1$ can also be easily be directly confirmed from [\(46\)](#page-10-6). Optimality of the barrier parameter follows from [\[3,](#page-33-2) Corollary 3.13]. \Box

4.3 Proofs of Corollaries [4.3](#page-9-1) and [4.4](#page-9-2)

Next, we show how slight modifications to the proof for Theorem [4.1](#page-8-0) can yield useful barriers for cones closely related to [\(8\)](#page-2-4). The first result uses the fact that a function which is compatible with a given domain is also compatible with any closed convex subset of this domain.

Proof of Corollary [4.3.](#page-9-1) From Corollary [4.14,](#page-12-1) by choosing $g(x) = \log(x)$, $\mathcal{N}_1(X) = X$, and $\mathcal{N}_2(X) =$ $\mathbb{I} \otimes \text{tr}^{n,n}_1(X)$, we know that negative quantum conditional entropy

$$
X \in \mathbb{H}^{n^2}_{++} \mapsto -S(X \, \| \, \mathbb{I} \otimes \text{tr}^{n,n}_1(X)),
$$

is 1-compatible with respect to the domain $\mathbb{H}^{n^2}_+$. From Definition [4.7,](#page-10-7) it is clear that if a function is β -compatible with respect to a domain, then the restriction of this function to any (relatively) open convex subset of its domain is also β -compatible with respect to the closure of this restricted domain. Therefore, the restriction of negative quantum conditional entropy to the domain $\mathbb{H}^{n^2}_{++} \cap \mathcal{V}$, where $\mathcal V$ is given by (23) , i.e.,

$$
(y,Z)\in\mathbb{R}_{++}^{n^2-n}\times\mathbb{H}_{++}^n\mapsto -S(\mathcal{G}(y,Z)\|\mathbb{I}\otimes\mathrm{tr}_1^{n,n}[\mathcal{G}(y,Z)]),
$$

is 1-compatible with respect to $\mathbb{H}^{n^2} \cap \mathcal{V}$, i.e., $(y, Z) \in \mathbb{R}^{n^2-n}_+ \times \mathbb{H}^n_+$. The remainder of the proof follows from an identical argument as the proof for Theorem [4.1.](#page-8-0)

The next result uses the fact that the sum of two functions which are compatible with the same domain will also be compatible with this domain.

Proof of Corollary [4.4.](#page-9-2) From Corollary [4.14,](#page-12-1) by choosing $g(x) = \log(x)$, $\mathcal{N}_1(X) = V X V^{\dagger}$ and $\mathcal{N}_2(X) =$ $\mathbb{I} \otimes \text{tr}_1^{m,p}(V X V^{\dagger}),$ we know that

$$
X \in \mathbb{H}^n_{++} \mapsto -S(VX V^{\dagger} \parallel \mathbb{I} \otimes \text{tr}_1^{m,p}(V X V^{\dagger})),
$$

is 1-compatible with respect to \mathbb{H}^n_+ . Similarly, by choosing $\mathcal{N}_1(X) = \text{tr}_2^{m,p}(V X V^{\dagger})$ and $\mathcal{N}_2(X) = \text{tr}[X]\mathbb{I}$, we know that

$$
X \in \mathbb{H}^n_{++} \mapsto -S(\text{tr}_2^{m,p}(V X V^{\dagger}) \parallel \text{tr}[X]\mathbb{I})
$$

=
$$
S(\text{tr}_2^{m,p}(V X V^{\dagger})) - S(\text{tr}[X]),
$$

is also 1-compatible with respect to \mathbb{H}^n_+ , where we have used the fact that $X \mapsto \text{tr}_2^{m,p}(V X V^{\dagger})$ is a tracepreserving map. From Definition [4.7,](#page-10-7) it is clear that the sum of any two functions which are compatible with respect to the same domain is also compatible with respect to the same domain. Therefore, the (homogenized) quantum mutual information

$$
X \in \mathbb{H}^n_{++} \mapsto -S(VXV^{\dagger} \|\mathbb{I} \otimes \text{tr}_1^{m,p}(VXV^{\dagger})) + S(\text{tr}_2^{m,p}(VXV^{\dagger})) - S(\text{tr}[X]),
$$

is also 1-compatible with respect to \mathbb{H}^n_+ . The remainder of the proof follows from an identical argument as the proof for Theorem [4.1.](#page-8-0)

5 Exploiting structure

As discussed in Section [1,](#page-0-2) the main bottleneck when solving quantum relative entropy programs by using interior-point methods is in solving linear systems with the Hessian of the barrier function (3) . A naïve implementation of this step involves constructing and factoring the full Hessian matrix. In this section, we focus on how we can efficiently compute the Hessian of the barrier function [\(9\)](#page-2-2) by taking advantage of structure in the linear maps $\mathcal G$ and $\mathcal H$. By performing a suitable block-elimination on the Hessian matrix of (9) , we can show (see Appendix [B.2\)](#page-28-1) that the main computational effort is in solving linear systems with the Hessian of

$$
\hat{F}(X) = \zeta^{-1} S(\mathcal{G}(X) \| \mathcal{H}(X)) - \log \det(X),\tag{49}
$$

where $\zeta = t - S(\mathcal{G}(X))|\mathcal{H}(X)$ is treated as a constant. It is fairly straightforward to show that the Hessian matrix of \hat{F} can be represented as

$$
\nabla^2 \hat{F}(X) = \zeta^{-1} \begin{bmatrix} \mathcal{G}^\dagger & \mathcal{H}^\dagger \end{bmatrix} \begin{bmatrix} -\nabla^2 S(\mathcal{G}(X)) & \nabla^2 S(\mathcal{H}(X)) \\ \nabla^2 S(\mathcal{H}(X)) & \nabla^2 S_{\mathcal{G}(X)}(\mathcal{H}(X)) \end{bmatrix} \begin{bmatrix} \mathcal{G} \\ \mathcal{H} \end{bmatrix} - \nabla^2 \log \det(X), \tag{50}
$$

Table 1: Summary of the approximate number of floating point operations required to solve linear systems with the Hessian of [\(49\)](#page-13-2), for various structures in the linear maps $\mathcal{G} : \mathbb{H}^n \to \mathbb{H}^{mp}$ and $\mathcal{H} : \mathbb{H}^n \to \mathbb{H}^{mp}$ that we can take advantage of. We compare the cost of a naïve matrix approach which does not use any structure in $\mathcal G$ and $\mathcal H$ to (i) if $\mathcal G$ and $\mathcal H$ both map to block diagonal matrices with p blocks of size $m \times m$, (ii) if G and H are both rank r^2 linear maps, and (iii) if $\mathcal{G}(X) = X$ and $\mathcal{H} = \mathbb{I} \otimes \text{tr}_1^{p,m}(X)$ model the quantum conditional entropy where $n = mp$. We also compare against the cost of solving a linear system with the Hessian of the barrier of the quantum relative entropy cone where matrices have dimension mp , i.e., the cone we would use if lifted the problem into a quantum relative entropy program.

where we use the bold letters G and H to denote the matrix representations of the linear maps G and H, and we recall the definition of $S_{\mathcal{G}(X)}$ from [\(12\)](#page-4-1), where $\mathcal{G}(X)$ is treated as a constant. We refer to Appendix [B.1](#page-26-1) for concrete descriptions of the Hessians that appear in [\(50\)](#page-13-3).

If we have no a priori information about $\mathcal G$ and $\mathcal H$, then the most straightforward method to solve linear systems with the Hessian matrix (50) is to construct the full matrix, then perform a Cholesky factor-solve procedure. Overall, the cost of forming the Hessian is $O(m^3n^2 + m^2n^4)$ flops, performing a Cholesky factorization costs $O(n^6)$ flops, and performing a single back- and forward-substitution using the Cholesky factorization costs $O(n^4)$. We compare this against solving linear systems with the Hessian of the log determinant function, as required in semidefinite programming. In this case, we do not need to construct nor Cholesky factor a Hessian matrix, and we apply the inverse Hessian map by applying a congruence transformation at a cost of $O(n^3)$ flops.

However, if we have some information about G and H a priori, then there are certain structures we can exploit to either make constructing the Hessian cheaper, avoid having to build and store the whole Hessian in memory, or to improve the numerical stability of solving linear systems with the Hessian. We will explore three main categories of strategies in the remainder of this section, which we summarize the flop count complexities for in Table [1.](#page-14-0) We will later show in Section [6](#page-18-0) how these techniques can be specifically tailored to solve the problems arising from quantum information theory which we introduced in Section [3.](#page-4-0)

5.1 Block diagonal structure

One structure we can take advantage of to make constructing the Hessian of (49) easier is if G and/or H map to block diagonal subspaces, i.e.,

$$
\mathcal{G}(X) = V\left(\bigoplus_{i=1}^{p_g} \mathcal{G}_i(X)\right) V^{\dagger} = \begin{bmatrix} | & & | \\ V_1 & \cdots & V_{p_g} \\ | & & | \end{bmatrix} \begin{bmatrix} \mathcal{G}_1(X) & & & \\ & \ddots & & \\ & & \mathcal{G}_{p_g}(X) \end{bmatrix} \begin{bmatrix} - & V_1^{\dagger} & - \\ \vdots & & \\ - & V_{p_g}^{\dagger} & - \end{bmatrix}
$$
\n
$$
\mathcal{H}(X) = W\left(\bigoplus_{i=1}^{p_h} \mathcal{H}_i(X)\right) W^{\dagger} = \begin{bmatrix} | & & | \\ W_1 & \cdots & W_{p_h} \\ | & & | \end{bmatrix} \begin{bmatrix} \mathcal{H}_1(X) & & & \\ & \ddots & & \\ & & \mathcal{H}_{p_h}(X) \end{bmatrix} \begin{bmatrix} - & W_1^{\dagger} & - \\ \vdots & & \\ - & W_{p_h}^{\dagger} & - \end{bmatrix}, \quad (51b)
$$

where $\mathcal{G}_i : \mathbb{H}^n \to \mathbb{H}^{\hat{m}_{g_i}}$ and $V_i \in \mathbb{C}^{n \times \hat{m}_{g_i}}$ for $i = 1, \ldots, p_g$, $\mathcal{H}_i : \mathbb{H}^n \to \mathbb{H}^{\hat{m}_{h_i}}$ and $W_i \in \mathbb{C}^{n \times \hat{m}_{h_i}}$ for $i = 1, \ldots, p_h$, and V and W are unitary matrices. Then by using the property that for the trace of any spectral function f , we have

$$
\operatorname{tr}\left[f\left(U\left[\bigoplus_{i=1}^p X_i\right] U^\dagger\right)\right] = \operatorname{tr}\left[\bigoplus_{i=1}^p f(X_i)\right] = \sum_{i=1}^p \operatorname{tr}[f(X_i)],
$$

we can decompose quantum relative entropy into a sum of functions acting on smaller matrices, i.e.,

$$
S(\mathcal{G}(X) \parallel \mathcal{H}(X)) = -S(\mathcal{G}(X)) + S_{\mathcal{G}(X)}(\mathcal{H}(X))
$$

=
$$
-\sum_{i=1}^{p_g} S(\mathcal{G}_i(X)) + \sum_{i=1}^{p_h} S_{\hat{\mathcal{G}}_i(X)}(\mathcal{H}_i(X)),
$$
 (52)

where $\hat{\mathcal{G}}_i(X) \coloneqq W_i \mathcal{G}(X) W_i^{\dagger}$. Given this decomposition, building the Hessian just involves building the Hessian of each of these decomposed terms, which can be represented as

$$
\nabla^2 \hat{F}(X) = -\zeta^{-1} \sum_{i=1}^{p_g} \mathcal{G}_i^{\dagger} \nabla^2 S(\mathcal{G}_i(X)) \mathcal{G}_i
$$

+ $\zeta^{-1} \sum_{i=1}^{p_h} \left[\hat{\mathcal{G}}_i^{\dagger} \mathcal{H}_i^{\dagger} \right] \left[\nabla^2 S(\mathcal{H}_i(X)) \nabla^2 S(\mathcal{H}_i(X)) \right] \left[\hat{\mathcal{G}}_i \right] - \nabla^2 \log \det(X).$ (53)

By constructing the Hessian in this manner, we only incur a cost of $O(m^3n^2p + m^2n^4p)$ flops, where for simplicity, we have assumed $p_q = p_h = p$, and $\hat{m}_{q_i} = \hat{m}$ and $\hat{m}_{h_i} = \hat{m}$ for all $i = 1, \ldots, p$. Noting that $m = \hat{m}p$, we see that we have saved a factor of approximately p to p^2 flops in constructing the Hessian as compared to using the naïve expression (50) , depending on the relative sizes of n and m.

Remark 5.1. In the case that G and H share the same block diagonal structure, i.e., $p_q = p_h = p$, and $V_i = W_i$ for all $i = 1, \ldots, p$ then [\(52\)](#page-14-1) can be expressed as

$$
S(\mathcal{G}(X) \| \mathcal{H}(X)) = \sum_{i=1}^{p} S(\mathcal{G}_i(X) \| \mathcal{H}_i(X)).
$$

Remark 5.2. In the extreme case when $\mathcal G$ and $\mathcal H$ map to diagonal matrices, or, more generally, when $p_q = p_h = m$, and $\hat{m}_{q_i} = \hat{m}_{h_i} = 1$ and $V_i = W_i$ for all $i = 1, \ldots, m$, then we reduce to a classical relative entropy expression [\(14\)](#page-4-2).

5.1.1 Facial reduction

When solving quantum relative entropy programs of the form (6) by lifting to the full quantum relative entropy cone, an issue that arises is when $\mathcal G$ and/or $\mathcal H$ map to singular matrices. In this case, strict feasibility and Slater's condition no longer hold, which can lead to numerical issues with primal-dual interior-point algorithms [\[56\]](#page-35-20). Many works such as [\[18\]](#page-34-3) use facial reduction to recover strict feasibility.

Alternatively, we can recover strict feasibility by modelling the problem directly using the cone [\(9\)](#page-2-2). We can also take advantage of knowledge of the fact that G and/or H map to singular matrices to compute the Hessian matrix of the barrier function more easily, which we demonstrate as follows. In the notation of [\(51\)](#page-14-2) and without loss of generality, let us assume that $p_g = p_h = 2$, and $\mathcal{G}_2(X) = 0$ and $\mathcal{H}_2(X) = 0$ for all $X \in \mathbb{H}^n$. Recalling that we assumed $\mathcal{G}(X) \ll \mathcal{H}(X)$ for all $X \in \mathbb{H}^n_{++}$, Lemma [4.12](#page-11-1) implies that $\hat{\mathcal{G}}_2(X) = 0$ for all $X \in \mathbb{H}^n$. Using $0 \log(0) = 0$, we can simplify [\(52\)](#page-14-1) to

$$
S(\mathcal{G}(X) \| \mathcal{H}(X)) = -S(V_1^{\dagger} \mathcal{G}(X) V_1) + S_{W_1^{\dagger} \hat{\mathcal{G}}(X) W_1} (W_1^{\dagger} \mathcal{H}(X) W_1)
$$

=
$$
-S(\mathcal{G}_1(X)) + S_{\hat{\mathcal{G}}_1(X)} (\mathcal{H}_1(X)),
$$
 (54)

i.e., we drop the terms corresponding to the kernels of $\mathcal{G}(\mathbb{I})$ and $\mathcal{H}(\mathbb{I})$. The corresponding Hessian matrix $\nabla^2 \hat{F}(X)$ is a straightforward modification of [\(53\)](#page-15-0). Overall, we have reduced the size of the matrices we need to consider, which can significantly simplify computations if the dimensions of the kernels of $\mathcal{G}(\mathbb{I})$ and $\mathcal{H}(\mathbb{I})$ are large. Note that this does not preclude the possibility that \mathcal{G}_1 and \mathcal{H}_1 have further block diagonal structure that we can exploit in a similar way as [\(52\)](#page-14-1).

5.2 Low-rank structure

Although the block diagonal structure allows us to construct the Hessian more efficiently, it is often more desirable if we can solve linear systems with the Hessian without having to construct and factor the entire Hessian matrix. We can do this if $\mathcal G$ and/or $\mathcal H$ are low rank linear maps, in which case we can apply variants of the matrix inversion lemma discussed in Appendix [A](#page-25-0) to solve linear systems with the Hessian more efficiently. More concretely, let us assume that we can decompose $\mathcal G$ and $\mathcal H$ as

$$
\mathcal{G} = \mathcal{G}_2 \circ \mathcal{G}_1 \tag{55a}
$$

$$
\mathcal{H} = \mathcal{H}_2 \circ \mathcal{H}_1,\tag{55b}
$$

where $\mathcal{G}_1 : \mathbb{H}^n \to \mathbb{H}^{r_g}, \mathcal{G}_2 : \mathbb{H}^{r_g} \to \mathbb{H}^m, \mathcal{H}_1 : \mathbb{H}^n \to \mathbb{H}^{r_h}, \text{ and } \mathcal{H}_2 : \mathbb{H}^{r_h} \to \mathbb{H}^m, \text{ and } r_g \ll n \text{ and } r_h \ll n$, respectively. In this case, we can write the Hessian of \hat{F} as

$$
\nabla^2 \hat{F}(X) = \zeta^{-1} \begin{bmatrix} \mathcal{G}_1^{\dagger} & \mathcal{H}_1^{\dagger} \end{bmatrix} \begin{bmatrix} -\mathcal{G}_2^{\dagger} \nabla^2 S(\mathcal{G}(X)) \mathcal{G}_2 & \mathcal{G}_2^{\dagger} \nabla^2 S(\mathcal{H}(X)) \mathcal{H}_2 \\ \mathcal{H}_2^{\dagger} \nabla^2 S(\mathcal{H}(X)) \mathcal{G}_2 & \mathcal{H}_2^{\dagger} \nabla^2 S_{\mathcal{G}(X)}(\mathcal{H}(X)) \mathcal{H}_2 \end{bmatrix} \begin{bmatrix} \mathcal{G}_1 \\ \mathcal{H}_1 \end{bmatrix} - \nabla^2 \log \det(X). (56)
$$

Constructing the full Hessian in this form costs $O(m^3r^2 + m^2r^4 + n^2r^4 + n^4r^2)$ flops, where for simplicity we assumed $r_q = r_h = r$. When $r \ll n$, this is already cheaper than constructing the full Hessian using the naïve approach (50) . However, we can gain further computational advantages by treating the Hessian as a rank-2r² perturbation of the matrix ∇^2 log det(X), which we can efficiently compute inverse Hessian products with using [\(B.6\)](#page-28-2). Therefore, we can solve linear systems with $\nabla^2 \hat{F}(X)$ by using the matrix inversion lemma $(A.1)$. In this case, we only need to construct a smaller Schur complement matrix which takes $O(m^3r^2 + m^2r^4 + n^2r^4 + n^3r^2)$ flops, and factor this matrix which now only costs $O(r^6)$ flops.

Example 5.3. A common example of a low-rank linear map is when $\mathcal G$ and $\mathcal H$ map to small matrices, i.e., $m \ll n$. In this case, $r_h = r_q = m$ and $\mathcal{G}_2 = \mathcal{H}_2 = \mathbb{I}$.

Example 5.4. Another example of low-rank linear maps is when $\mathcal G$ and $\mathcal H$ only act on a small principal submatrix of the input matrix. In this case, we can let \mathcal{G}_1 and \mathcal{H}_1 be the linear operators which extract the corresponding principal submatrices.

Remark 5.5. When constructing the Schur complement matrix for [\(56\)](#page-15-1), we need to construct a matrix of the form

$$
\begin{bmatrix} \mathcal{G}_1 \\ \mathcal{H}_1 \end{bmatrix} \nabla^2 \log \det(X) \begin{bmatrix} \mathcal{G}_1^\dagger & \mathcal{H}_1^\dagger \end{bmatrix},
$$

where we recall that ∇^2 log $\det(X)$ is the Hessian corresponding to the log determinant, i.e., the barrier for the positive semidefinite component of the cone. While we discussed briefly in Section [1](#page-0-2) how sparse and low-rank structure was difficult to exploit to perform Hessians products of general spectral functions more efficiently, there are well-known techniques to exploit these same structures for the Hessian products of the log determinant [\[25,](#page-34-17) [26\]](#page-34-18). Therefore, if G_1 or \mathcal{H}_1 have these sparse or low-rank structures (such as those described in Example 5.4), then these same techniques can be used to construct this component of the Schur complement matrix more efficiently.

5.2.1 Identity operator

A special instance of this low-rank structure occurs when $\mathcal{G} = \mathbb{I}$ (or is a congruence by any unitary matrix) and $\mathcal{H} = \mathcal{H}_2 \circ \mathcal{H}_1$ is low rank, where $\mathcal{H}_1 : \mathbb{H}^n \to \mathbb{H}^r$, and $\mathcal{H}_2 : \mathbb{H}^r \to \mathbb{H}^m$, and $r \ll n$. First, let us represent the Hessian matrix as

$$
\nabla^2 \hat{F}(X) = \zeta^{-1} \begin{bmatrix} \mathbb{I} & \mathcal{H}_1^{\dagger} \end{bmatrix} \begin{bmatrix} -\nabla^2 (S + \zeta \log \det)(X) & \nabla^2 S(\mathcal{H}(X)) \mathcal{H}_2 \\ \mathcal{H}_2^{\dagger} \nabla^2 S(\mathcal{H}(X)) & \mathcal{H}_2^{\dagger} \nabla^2 S_X(\mathcal{H}(X)) \mathcal{H}_2 \end{bmatrix} \begin{bmatrix} \mathbb{I} \\ \mathcal{H}_1 \end{bmatrix}.
$$
 (57)

This matrix can be interpreted as a rank-2r² perturbation of the matrix $\nabla^2(S + \zeta \log \det)(X)$. We can efficiently solve linear systems with by using Remark [B.4,](#page-27-0) where $f(x) = -x \log(x) + \zeta/x$. Therefore, by using the variant of the matrix inversion lemma from Lemma [A.4](#page-26-2) on [\(57\)](#page-16-2), the cost of constructing the required Schur complement matrix is still $O(m^3r^2 + m^2r^4 + n^2r^4 + n^3r^2)$ flops, and the matrix factorization step now only costs $O(r^6)$ flops. That is, we can still apply a variant of the matrix inversion lemma to compute the inverse Hessian product efficiently, despite $\mathcal G$ being full rank, due to the sum of the matrices $\nabla^2 S(X)$ and $\nabla^2 \log \det(X)$ being easily invertible.

5.3 Difference of entropies

In some instances, a certain block diagonal structure of the linear map H allows us to decompose quantum relative entropy into a difference of quantum entropies.

Lemma 5.6. For all $X \in \mathbb{H}^{nm}_+$, the identity $S_X(\mathbb{I} \otimes \text{tr}_1^{n,m}[X]) = S(\text{tr}_1^{n,m}(X))$ is satisfied.

Proof. This follows from

$$
S_X(\mathbb{I} \otimes \operatorname{tr}_1^{n,m}(X)) = -\langle X, \log(\mathbb{I} \otimes \operatorname{tr}_1^{n,m}(X)) \rangle
$$

= -\langle X, \mathbb{I} \otimes \log(\operatorname{tr}_1^{n,m}(X)) \rangle
= -\langle \operatorname{tr}_1^{n,m}(X), \log(\operatorname{tr}_1^{n,m}(X)) \rangle = S(\operatorname{tr}_1^{n,m}(X)),

where the second equality uses the fact that spectral functions act on each block of a block diagonal matrix independently, and the third equality uses the fact that the adjoint of the partial trace is the Kronecker product, i.e., $\langle Y, \operatorname{tr}_1^{n,m}(X) \rangle = \langle \mathbb{I} \otimes Y, X \rangle$ for all $X \in \mathbb{H}^{nm}$ and $Y \in \mathbb{H}^m$. \Box

We now show how we can generalize this result to capture a larger class of linear operators which can be decomposed into a difference of entropies. Consider a linear operator $\mathcal H$ which consists of a direct sum of the partial trace expressions from Lemma [5.6,](#page-16-0) i.e.,

$$
\mathcal{H}(X) = V \bigoplus_{i=1}^{p} \left((\mathcal{H}_{i}^{\dagger} \circ \mathcal{H}_{i} \circ \mathcal{G}_{i})(X) \right) V^{\dagger}
$$
\n
$$
= \begin{bmatrix} | & & | \\ V_{1} & \cdots & V_{p} \\ | & & | & | \end{bmatrix} \begin{bmatrix} (\mathcal{H}_{1}^{\dagger} \circ \mathcal{H}_{1} \circ \mathcal{G}_{1})(X) & & & \\ & \ddots & & \\ & & (\mathcal{H}_{p}^{\dagger} \circ \mathcal{H}_{p} \circ \mathcal{G}_{p})(X) \end{bmatrix} \begin{bmatrix} - & V_{1}^{\dagger} & - \\ & \vdots & \\ - & V_{p}^{\dagger} & - \end{bmatrix}, \qquad (58)
$$

where $\mathcal{H}_i(X) = \text{tr}_1^{a_i, b_i}(X)$ are partial trace operators for all $i = 1, \ldots, p$. Additionally, $V_i \in \mathbb{C}^{n \times a_i b_i}$ and $\mathcal{G}_i(X) = V_i^{\dagger} \mathcal{G}(X) V_i$ for $i = 1, \ldots, p$, and V is a unitary matrix. Then we can express the quantum relative entropy function as a sum of quantum entropy terms

$$
S(\mathcal{G}(X) \| \mathcal{H}(X)) = -S(\mathcal{G}(X)) + \sum_{i=1}^{p} S_{\mathcal{G}_i(X)}((\mathcal{H}_i^{\dagger} \circ \mathcal{H}_i \circ \mathcal{G}_i)(X))
$$

=
$$
-S(\mathcal{G}(X)) + \sum_{i=1}^{p} S((\mathcal{H}_i \circ \mathcal{G}_i)(X)),
$$

where we use (52) for the first equality, and Lemma [5.6](#page-16-0) for the last equality. The main advantage of this reformulation is that we can now express the Hessian as

$$
\nabla^2 \hat{F}(X) = -\zeta^{-1} \mathcal{G}^\dagger \nabla^2 S(\mathcal{G}(X)) \mathcal{G} + \zeta^{-1} \sum_{i=1}^p \left(\mathcal{G}_i^\dagger \mathcal{H}_i^\dagger \nabla^2 S((\mathcal{H}_i \circ \mathcal{G}_i)(X)) \mathcal{H}_i \mathcal{G}_i \right) - \nabla^2 \log \det(X), \quad (59)
$$

which can be interpreted as a simplification of the Hessian previously found in (53) . This allows us to avoid computing the second divided differences matrix associated with $\nabla^2 S_C$ (see Lemma [B.2\)](#page-27-1), which should help improve the numerical stability of constructing the Hessian matrix.

Example 5.7. An important example of a linear map satisfying this property is the quantum conditional entropy

$$
X \mapsto S(X \, \| \, \mathbb{I} \otimes {\rm tr}_1^{n,m}(X)),
$$

defined over \mathbb{H}^{nm}_+ . This corresponds to the case when $p = 1$, $\mathcal{G}(X) = X$, and $\mathcal{H}_1(X) = \text{tr}^{n,m}_1(X)$. For the quantum conditional entropy, the Hessian [\(59\)](#page-17-1) can be simplified to

$$
\nabla^2 \hat{F}(X) = -\nabla^2 (\zeta^{-1} S + \log \det)(X) + \mathcal{H}_1^{\dagger} \nabla^2 S(\mathcal{H}_1(X)) \mathcal{H}_1.
$$

This is a similar scenario to that discussed in Section [5.2.1,](#page-16-3) and therefore we can use the matrix inversion lemma to efficiently compute inverse Hessian products for the barrier of the quantum conditional entropy cone introduced in Corollary 4.2 . Note that the small matrix corresponding to the low rank perturbation matrix is positive definite and easily invertible, unlike in, e.g., [\(56\)](#page-15-1). Therefore, we can use the symmetric variant of the matrix inversion lemma [\(A.2\)](#page-25-2), and we can perform a Cholesky factorization of the Schur complement matrix rather than an LU factorization. Overall, it costs $O(n^3m^5)$ flops to construct the Schur complement, $O(m^6)$ flops to Cholesky factor the Schur complement, and $O(n^3m^3 + m^4)$ flops to perform a linear solve using this Cholesky factorization.

Example 5.8. Another example is when H is the pinching map [\(18\)](#page-5-1), which zeros out all off-diagonal blocks of a block matrix. This corresponds to the case when $a_1 = \ldots = a_p = 1$, i.e., the partial traces act like the identity. More concretely, we have

$$
S(\mathcal{G}(X) \| \mathcal{Z}(\mathcal{G}(X))) = -S(\mathcal{G}(X)) + \sum_{i=1}^{p} S(\mathcal{G}_i(X)),
$$

where $G_i(X)$ represents the *i*-th diagonal block of $\mathcal{G}(X)$.

6 Numerical experiments

In this section, we present numerical results for the quantum relative entropy programs introduced in Section [3](#page-4-0) to demonstrate how the techniques presented in this paper can be utilized. For each experiment, we show how 1) we can use tailored cones and barriers from Section [4](#page-7-0) to model the quantum relative entropy program, and 2) how to use techniques from Section [5](#page-13-0) to efficiently solve linear systems with the Hessian matrix of the barrier.

All experiments are run in Julia using Hypatia [\[19\]](#page-34-4), which already provides support for the quantum relative entropy cone, quantum entropy cone, and classical relative entropy cone. All experiments are run using Hypatia's default settings, and on an Intel i5-11700 CPU with 32GB of RAM. We report the total number of iterations and time taken to solve each problem to the desired tolerance (Hypatia uses a default relative gap tolerance and primal-dual feasibility tolerance of 1.5×10^{-8}), excluding time spent in preprocessing steps. We also report the average time taken to compute a single interior-point step. We use "OOM" to indicate instances where there is insufficient computational memory to solve a problem. Whenever problems are modelled using a constraint of the form $h-Gx \in \mathcal{K}$ where $G \neq -\mathbb{I}$, we use Hypatia's default system solver, which is based on the method from [\[57,](#page-35-21) Section 10.3]. Otherwise, we use a custom-implemented Newton system solver based on the block elimination method discussed in Appendix [C.](#page-28-0) We present more details about how each experiment is modelled in the standard conic program form accepted by Hypatia in Appendix [E.](#page-30-0)

6.1 Quantum key distribution

For the quantum key distribution problem [\(16\)](#page-4-3), we can directly model the problem using a suitable application of the cone and barrier presented in Corollary [1.2,](#page-2-3) as presented in [\(E.3\)](#page-31-0). To construct the Hessian matrix of this barrier, we first take advantage of the pinching map $\mathcal Z$ to decompose the quantum relative entropy into a difference of quantum entropies, as seen in Example [5.8.](#page-17-2) Additionally, the image of G consistes of (typically) large but singular matrices with a large common kernel. Therefore, we can use the technique discussed in Section [5.1.1](#page-15-2) to reduce the size of the matrices we deal with. By defining V and W_i as the isometry matrices with orthonormal columns living in the image of matrices $\mathcal{G}(\mathbb{I})$ and $\mathcal{G}_i(\mathbb{I})$ for $i = 1, \ldots, p$, respectively, we obtain

$$
S(\mathcal{G}(X) \| \mathcal{Z}(\mathcal{G}(X))) = -S(V^{\dagger} \mathcal{G}(X)V) + \sum_{i=1}^{p} S(W_i^{\dagger} \mathcal{G}_i(X)W_i).
$$
 (60)

The Hessian matrix can then be computed using a straightforward modification of [\(59\)](#page-17-1). Similar techniques were used in [\[18\]](#page-34-3) to compute quantum key rates.

We now focus on the two particular quantum key distribution protocols to see how knowledge about G can further simplify computation of the inverse Hessian product, and present numerical results for each of these problems.

6.1.1 Discrete-phase-randomized protocol

Recall the dprBB84 protocol from Section [3.1.1.](#page-5-2) In Appendix [D](#page-29-0) we show that both G and $\mathcal{Z} \circ \mathcal{G}$ have block diagonal structures [\(D.1\)](#page-30-1) and [\(D.3\)](#page-30-2), respectively. Applying the techniques for block diagonal structures from Section [5.1](#page-14-3) and the facial reduction techniques from Section [5.1.1,](#page-15-2) we therefore have

$$
S(\mathcal{G}(X) \| \mathcal{Z}(\mathcal{G}(X))) = \sum_{i=1}^{2} \Biggl(-S(\mathcal{G}_i(X)) + S(\mathcal{Z}_1(\mathcal{G}_i(X))) + S(\mathcal{Z}_2(\mathcal{G}_i(X))) \Biggr), \tag{61}
$$

where $\mathcal{G}_1 : \mathbb{H}^{12c} \to \mathbb{H}^{4c}, \mathcal{G}_2 : \mathbb{H}^{4c} \to \mathbb{H}^{4c}, \mathcal{Z}_1 : \mathbb{H}^{4c} \to \mathbb{H}^{2c}$ and $\mathcal{Z}_2 : \mathbb{H}^{4c} \to \mathbb{H}^{2c}$ are defined in Appendix [D.](#page-29-0) To summarize, we have facially reduced $\mathcal{G}(X)$ and $\mathcal{Z}(\mathcal{G}(X))$ from size $48c \times 48c$ matrices to size $8c \times 8c$ matrices. We then further decomposed $\mathcal{G}(X)$ into two blocks of size $4c \times 4c$, and $\mathcal{Z}(\mathcal{G}(X))$ into four blocks of size $2c \times 2c$. As these reduced matrices are relatively small compared to X, then, as discussed in Example [5.3,](#page-16-4) we can also exploit this low-rank structure to compute the inverse Hessian product more efficiently. We can see this by expressing the Hessian matrix as

$$
\nabla^2 \hat{F}(X) = \zeta^{-1} \begin{bmatrix} \mathcal{G}_1^\dagger & \mathcal{G}_2^\dagger \end{bmatrix} \begin{bmatrix} M_1 & \\ & M_2 \end{bmatrix} \begin{bmatrix} \mathcal{G}_1 \\ \mathcal{G}_2 \end{bmatrix} - \nabla^2 \log \det(X), \tag{62}
$$

where

$$
M_i = -\nabla^2 S(\mathcal{G}_i(X)) + \mathcal{Z}_1^{\dagger} \nabla^2 S(\mathcal{Z}_1(\mathcal{G}_i(X))) \mathcal{Z}_1 + \mathcal{Z}_2^{\dagger} \nabla^2 S(\mathcal{Z}_2(\mathcal{G}_i(X))) \mathcal{Z}_2,
$$

for $i = 1, 2$. Here, we have a rank-32 c^2 perturbation of an easily invertible $144c^2 \times 144c^2$ -dimensional log determinant Hessian matrix, and therefore we can use the matrix inversion lemma [\(A.1\)](#page-25-1) to solve linear systems with this Hessian matrix. Additionally, as G_1 and G_2 are defined to extract a principal submatrix from the input matrix, they are therefore highly structured and the discussion in Remark [5.5](#page-16-5) applies to allow us compute the Schur complement matrix more efficiently. We denote this proposed method where we model using a suitably parameterized cone from Corollary [1.2,](#page-2-3) as shown in [\(E.3\)](#page-31-0), and use the aforementioned technique to solve linear systems with the Hessian of the barrier, as DPR.

Experimental setup We run experiments for dprBB84 protocols for various numbers of global phases c and a probability $p = 0.5$ of using a particular measurement basis. We simulate the experimental constraint data A and b using a source intensity of $\alpha = 0.14$ and transmission channel length of $L = 30$ m. All other experimental parameters are the same as those used in [\[18\]](#page-34-3). We benchmark DPR against two other baseline methods. First, we again model the problem using a suitably parameterized cone from Corollary [1.2,](#page-2-3) as shown in $(E.3)$, but instead solve linear systems with the Hessian of the barrier by constructing the Hessian matrix [\(62\)](#page-18-1) and performing a Cholesky factor-solve procedure (QKD). Second, we model the problem using the full quantum relative entropy cone (QRE), as shown in [\(E.2\)](#page-30-3), which we preprocess with the technique [\[23,](#page-34-7) Lemma 6.2] to reduce the size of the matrices we need to work with. Our experimental results are summarized in Table [2.](#page-19-0)

Discussion Overall, we observe that using a cone and barrier specialized for the quantum key distribution problem can yield noticeable improvements to solve times. We see that the QKD method improves solve times by approximately a factor of 2 over the QRE method. By further taking advantage of our knowledge that the Hessian can be interpreted as a low rank perturbation of the log determinant Hessian (i.e., DPR), we observe a further 2 to 5 times speedup in solve time. We note that the DPR technique seemed to be less numerically stable as the magnitudes of the residuals from solving the Newton equations solved to were observed to be larger, however the method was still able to converge to the desired tolerance. We compare our results to those presented in [\[18\]](#page-34-3), where the authors present results for the dprBB84 protocol only for problems up to $c = 5$, whereas we present experiments for problems up to $c = 10$. For problems of dimension $c = 4$, the reported computation times in [\[18\]](#page-34-3) are all at least 300 s, which is slower than all methods that we present in Table [2.](#page-19-0)

6.1.2 Discrete-modulated continuous-variable protocol

Now recall the DMCV protocol from Section [3.1.2.](#page-5-3) For this protocol, there are no obvious additional structures that we can exploit like the dprBB84 protocol. Therefore, we propose to model the problem using a suitably parameterized cone from Corollary [1.2,](#page-2-3) as shown in $(E.3)$, and solve linear systems with the Hessian of the barrier by constructing and Cholesky factoring the Hessian matrix [\(60\)](#page-18-2). Consistent with our notation for the dprBB84 experiments, we denote this method as QKD.

Note that as G consists of a single tall Kraus operator given by [\(20\)](#page-5-4), that $\mathcal{G}(X) \in \mathbb{H}^{16(N_c+1)}$ must be singular with a rank of at most $4(N_c + 1)$ for any $X \in \mathbb{H}^{4(N_c+1)}$. Therefore, facial reduction on $\mathcal{G}(X)$ should always be able to reduce from a matrix of size $16(N_c+1) \times 16(N_c+1)$ to a matrix of size $4(N_c+1) \times 4(N_c+1)$. Similarly, $\mathcal{Z}(\mathcal{G}(X))$ decomposes into four blocks of size $4(N_c+1) \times 4(N_c+1)$.

Experimental setup We run experiments for DMCV protocols for various cutoff photon numbers N_c , and simulate the experimental constraint data A and b using a source intensity of $\alpha = 0.35$, transmission channel length of $L = 60 \,\text{m}$, and excess noise of $\xi = 0.05$. All other experimental parameters are the same as those used in [\[18\]](#page-34-3). Like the dprBB84 protocol, we compare QKD against modelling the problem using the full quantum relative entropy cone (QRE), as shown in [\(E.2\)](#page-30-3). Our results are presented in Table [3.](#page-20-0)

Discussion From the results, we see that the QRE method performs significantly worse compared to the other methods which use a more tailored cone and barrier. This is due to the facial reduction technique in [\[23,](#page-34-7) Lemma 6.2] failing to simplify this problem, and therefore the QRE method must handle matrices of much larger dimensions compared to QKD. Notably, the size of the Hessian matrix of the quantum relative entropy cone used in QRE is 256 times larger than the size of the Hessian matrices of the tailored cones used by QKD. Additionally, by taking advantage of the block diagonal structure in the linear maps, the QKD method constructs the Hessian matrix by performing matrix multiplications between matrices which have a size 16 times smaller than those required by the QRE method. Like for the dprBB84 experiments, we compare our results to those from [\[18\]](#page-34-3), which presents results for problems of up to $N_c = 11$, compared to our experiments which go up to $N_c = 16$. Additionally, [\[18\]](#page-34-3) reports solve times of at least 500s and 700s for problems of dimension $N_c = 10$ and 11, respectively, which is slower than our reported solve times for the same problem dimensions.

6.2 Quantum rate-distortion

For the quantum rate-distortion problem (21) , we can directly model the problem as $(E.5)$ by using the quantum conditional entropy cone from Corollary [4.2.](#page-8-5) Additionally, we can efficiently compute inverse Hessian products with the corresponding barrier function as discussed in Example [5.7.](#page-17-0) We denote this proposed method as QCE.

Experimental setup For our experiments, we compute the entanglement-assisted rate-distortion at $D = 0.5$ of randomly generated $n \times n$ density matrices sampled uniformly from the Hilbert-Schmidt measure [\[58\]](#page-36-0). We define Δ to represent the entanglement fidelity distortion [\(22\)](#page-6-5). We benchmark using QCE to compute the entanglement-assisted rate-distortion against lifting the problem to the quantum relative entropy cone (QRE), as shown in [\(E.4\)](#page-31-2). Our results are summarized in Table [4.](#page-21-0)

Discussion We see that solving the problem using the QCE method is orders of magnitude faster compared to QRE. This is expected, as using Table [1,](#page-14-0) we can predict that solving linear systems with the Hessian of the barrier of the quantum conditional entropy cone should require approximately n^4 times fewer flops compared to using the quantum relative entropy cone. Additionally, we observe that fewer iterations are required to converge to the desired tolerance, particularly at larger problem dimensions, which may be attributed to the smaller barrier parameter of the quantum conditional entropy cone.

6.2.1 Entanglement fidelity distortion

As discussed in Section [3.2.1,](#page-6-4) when we use the entanglement fidelity to measure the amount of distortion, we can instead optimize over the fixed point subspace [\(23\)](#page-6-3). We will do this by minimizing over the restriction of the quantum conditional entropy cone to this subspace, whose barrier is given in Corol-lary [4.3.](#page-9-1) This reuslts in a problem of the form $(E.8)$. In this case, we can efficiently compute inverse

Hessian vector products as follows. First, we have that

$$
S(\mathcal{G}(y,Z)\|\mathbb{I}\otimes \operatorname{tr}_{1}^{n,n}(\mathcal{G}(y,Z))) = -S(\mathcal{G}(y,Z)) + S(\operatorname{tr}_{1}^{n,n}(\mathcal{G}(y,Z)))
$$

= -H(y) - S(Z) + H(\hat{\mathcal{G}}(y,Z)), (63)

where $\mathcal{G}: \mathbb{R}^{n^2 - n} \times \mathbb{H}^n \to \mathbb{H}^{n^2}$ is given by (37) , and $\hat{\mathcal{G}}: \mathbb{R}^{n^2 - n} \times \mathbb{H}^n \to \mathbb{R}^n$ is defined as

$$
\hat{G}(y, Z) = \text{diag}(\text{tr}_1^{n, n}(\mathcal{G}(y, Z))) = \left[Z_{ii} + \sum_{j \neq i}^{n} y_{ij} \right]_{i=1}^{n}.
$$

The first equality uses Lemma [5.6,](#page-16-0) and the second equality uses [\[14,](#page-34-0) Corollary 4.14] and the block diagonal decomposition technique described in Section [5.1](#page-14-3) (see also Remark [5.2\)](#page-15-3). Given this, we recognize that $\mathcal G$ maps to a low-dimensional vector space, and is therefore an instance of the low-rank structures discussed in Example [5.3.](#page-16-4) Concretely, consider the function

$$
\hat{F}(y,Z) = \zeta^{-1} S(\mathcal{G}(y,Z) \|\mathbb{I} \otimes \operatorname{tr}_1^{n,n}(\mathcal{G}(y,Z))) - \sum_{i \neq j}^n \log(y_{ij}) - \log \det(Z),\tag{64}
$$

which, as we recall from Appendix [B.2,](#page-28-1) we are interested in because solving linear systems with the Hessian of the barrier function [\(38\)](#page-9-4) can be reduced to solving linear systems with the Hessian of [\(64\)](#page-21-1). Using [\(63\)](#page-21-2), we can write this Hessian as

$$
\nabla^2 \hat{F}(y,Z) = \begin{bmatrix} \text{diag}(\zeta y)^{-1} + \text{diag}(y)^{-2} & 0\\ 0 & -\nabla^2(\zeta^{-1}S + \log \det)(Z) \end{bmatrix} - \hat{\mathcal{G}}^\dagger \text{diag}(\hat{\mathcal{G}}(y,Z))^{-1} \hat{\mathcal{G}}.\tag{65}
$$

Then, with a similar flavour as the quantum conditional entropy from Example [5.7,](#page-17-0) we have a rank-n perturbation of a $(2n^2 - n) \times (2n^2 - n)$ dimensional Hessian matrix which we can easily solve linear systems with. Therefore, we can apply the symmetric variant of the matrix inversion lemma [\(A.2\)](#page-25-2) to efficiently solve linear systems with the Hessian matrix of the desired barrier. Overall, the complexity of forming and Cholesky factoring the required Schur complement matrix to solve linear systems with [\(65\)](#page-21-3) is approximately $O(n^3)$ flops. We denote this method for computing the entanglement-assisted ratedistortion as QRD.

Experimental setup To illustrate the benefits of taking advantage of structure in this way, we run experiments using the same problem setups as our prior quantum rate-distortion experiments. We benchmark the method QRD against two other methods of utilizing knowledge of the fixed point subspace (23) . First, we consider modelling the problem as $(E.6)$, which is similar to QCE but we constrain ourselves to work within the image of the subspace (23) (QCE*). Second, using a similar block diagonal decomposition technique as described in Section [5.1](#page-14-3) and Remarks [5.1](#page-15-4) and [5.2,](#page-15-3) we can show that

$$
S(\mathcal{G}(y,Z)\|\mathbb{I}\otimes\mathrm{tr}_{1}^{n,n}(\mathcal{G}(y,Z)))=H(y\|\hat{\mathcal{G}}_{1}(y,Z))+S(Z\|\hat{\mathcal{G}}_{2}(y,Z)),\tag{66}
$$

for suitable linear maps $\hat{G}_1 : \mathbb{R}^{n^2 - n} \times \mathbb{H}^n \to \mathbb{R}^{n^2 - n}$ and $\hat{G}_2 : \mathbb{R}^{n^2 - n} \times \mathbb{H}^n \to \mathbb{H}^n$, and therefore we can model the problem as $(E.7)$ using just the classical and quantum relative entropy cones (QRE^*) . Our results are summarized in Table [5.](#page-22-0)

Discussion Comparing to the results from Table [4,](#page-21-0) we see that all methods which take advantage of knowledge of the fixed-point subspace outperform the methods which do not. We note that the QCE^* results are not significantly different from the QCE results, which is due to the bottleneck in the interiorpoint methods being in constructing and factoring the Hessian of the cone barrier function, rather than in building and factoring the Schur complement matrix, which is where the main advantage of QCE^* over QCE lies. The other two methods, QRD and QRE*, which take advantage of the way the quantum relative entropy function can be decomposed as a sum of simpler functions, show a more significant improvement in computational performance, and the QRD method, which takes advantage of the most structure in the problem, performs the best. We remark that compared to the most basic QRE modelling strategy from Table [4,](#page-21-0) we have improved the theoretical flop count complexity of building and factoring the Hessian matrix by a factor of n^9 , which is reflected in the significantly larger problem instances that we are able to solve.

6.3 Quantum channel capacity

For the quantum channel capacity problems described in Section [3.3,](#page-6-2) we are interested in optimizing over quantum conditional entropy-like expressions. In particular, we have functions related to the expression

$$
S(VXV^{\dagger} \parallel \mathbb{I} \otimes \operatorname{tr}_{1}^{m,p}(VXV^{\dagger})) = -S(VXV^{\dagger}) + S(\operatorname{tr}_{1}^{m,p}(VXV^{\dagger}))
$$

= -S(X) + S(\operatorname{tr}_{1}^{m,p}(VXV^{\dagger})), \t(67)

where the first equality uses Lemma [5.6,](#page-16-0) and the second equality uses the facial reduction technique from Section [5.1.1.](#page-15-2) Notably, $V X V^{\dagger}$ is usually a significantly larger matrix than X, and therefore facial reduction can significantly reduce the dimensions of matrices that we need to perform operations with. We now show how minor modifications of this result can be used to efficiently compute the entanglementassisted [\(24\)](#page-6-6) and quantum-quantum [\(25\)](#page-7-3) channel capacities, before presenting a combined discussion on the experimental results.

6.3.1 Entanglement-assisted capacity

For the entanglement-assisted channel capacity, we will optimize over the quantum mutual information cone presented in Corollary [4.4](#page-9-2) by modelling the problem as $(E.11)$. Using (67) , we can show that the (homogenized) quantum mutual information can be expressed as

$$
S(VXV^{\dagger} \parallel \mathbb{I} \otimes \operatorname{tr}_{1}^{m,p}(VXV^{\dagger})) - S(\operatorname{tr}_{2}^{m,p}(VXV^{\dagger})) + S(\operatorname{tr}[X])
$$

= -S(X) + S(\operatorname{tr}_{1}^{m,p}(VXV^{\dagger})) - S(\operatorname{tr}_{2}^{m,p}(VXV^{\dagger})) + S(\operatorname{tr}[X]), (68)

and therefore we can compute the Hessian of the barrier of the quantum mutual information cone by using a variation of [\(59\)](#page-17-1). We denote this proposed method as QMI.

Experimental setup For our experiments, we compute the entanglement-assisted channel capacity on randomly generated quantum channels with dimensions $n = m = p$, i.e., the input, output, and environment systems are all the same dimension. These channels are generated by uniformly sampling Stinespring operators V on the Hilbert-Schmidt measure [\[59\]](#page-36-1). We benchmark computing the entanglement-assisted channel capacity using QMI against modelling the problem using the Cartesian product between a quantum conditional entropy cone and a quantum entropy cone (QCE), as shown in [\(E.10\)](#page-32-1), and modelling the problem using the Cartesian product between a quantum relative entropy cone and a quantum entropy cone (QRE), as shown in [\(E.9\)](#page-32-2). Results are summarized in Table [6.](#page-23-0)

6.3.2 Quantum-quantum capacity of degradable channels

For the quantum-quantum channel capacity of degradable channels, will optimize over the quantum coherent information cone for degradable channels presented in Corollary [4.5](#page-9-5) by modelling the problem as $(E.14)$. Using (67) , we can show that the quantum coherent information can be represented as

$$
S(W\mathcal{N}(X)W^{\dagger} \|\mathbb{I} \otimes \operatorname{tr}_{1}^{p,q}(W\mathcal{N}(X)W^{\dagger})) = S(\mathcal{N}(X)) - S(\operatorname{tr}_{1}^{p,q}(W\mathcal{N}(X)W^{\dagger})),\tag{69}
$$

and therefore the Hessian of the barrier function can be constructed using a suitable application of [\(59\)](#page-17-1). We denote this proposed method as QCI.

Experimental setup We compute the quantum-quantum channel capacities of randomly generated pseudo-diagonal quantum channels [\[60\]](#page-36-2), which are known to be degradable and whose structure is de-scribed in [\[60,](#page-36-2) Section 5]. We generate these channels such that $n = m = p = q$, i.e., the dimensions of the input, output, and all other environment systems are the same. We benchmark solving the quantumquantum channel capacity using QCI with either modelling the problem using the quantum conditional entropy cone (QCE), as shown in $(E.13)$, using the quantum relative entropy (QRE) cone, as shown in [\(E.12\)](#page-32-5). Experimental results are shown in Table [7.](#page-23-1)

6.3.3 Discussion

Overall, we see that the results for the entanglement-assisted and quantum-quantum channel capacities are very similar, due to the two problems sharing very similar structures. We first observe that the QCE methods perform significantly better than the naïve QRE methods in both computation time and memory requirements. Referring to Table [1,](#page-14-0) we see that the QRE methods require $O(n^{12})$ flops to perform an inverse Hessian product, whereas QCE methods only require $O(n^8)$ flops. We also observe that the tailored QMI and QCI are able to provide a further order of magnitude improvement in computation

times and memory requirements, which only require $O(n^6)$ flops to compute inverse Hessian products. Additionally, we observe that modelling the QCI and QMI methods require significantly fewer iterations than the other methods. We attribute this to the smaller barrier parameter of the quantum mutual information and quantum coherent information cones $(1 + n)$, compared to when we use the quantum conditional entropy $(1+n^2)$ and quantum relative entropy $(1+2n^2)$ to model the problem.

6.4 Ground state energy of Hamiltonians

To compute the ground state energy of Hamiltonians, we directly optimize over the quantum conditional entropy cone from Corollary [4.2](#page-8-5) by modelling the problem as $(E.16)$, and efficiently solve linear systems with the Hessian matrix of the corresponding barrier using the method discussed in Example [5.7.](#page-17-0) We denote this proposed method as QCE.

Experimental setup We are interested in computing a hierarchy of lower bounds for the ground state energy of the XXZ-Hamiltonian parameterized by l , i.e., where

$$
H = (-\sigma_x \otimes \sigma_x - \sigma_y \otimes \sigma_y - \Delta \sigma_z \otimes \sigma_z) \otimes \mathbb{I}_{2^{l-2}},
$$
\n(70)

where $\sigma_x, \sigma_y, \sigma_z \in \mathbb{H}^2$ are the Pauli matrices

$$
\sigma_x = \begin{bmatrix} 0 & 1 \\ 1 & 0 \end{bmatrix}, \quad \sigma_y = \begin{bmatrix} 0 & -i \\ i & 0 \end{bmatrix}, \quad \sigma_z = \begin{bmatrix} 1 & 0 \\ 0 & -1 \end{bmatrix}.
$$

We consider the case where $\Delta = -1$. We benchmark estimating the ground state energy for various values of l using QCE against lifting the problem to the quantum relative entropy cone (QRE) , as shown in [\(E.15\)](#page-33-10). Experimental results are presented in Table [8.](#page-24-0)

Discussion We begin by remarking that for this problem, the quantum conditional entropy traces out a 2-dimensional system, which corresponds to the smallest non-trivial dimension we can trace out. From Table [1,](#page-14-0) we see that this corresponds to the scenario when exploiting the structure of the barrier of the quantum conditional entropy cone yields the least computational benefits. Nevertheless, we still expect some benefits, e.g., the Cholesky facotrization step for the quantum conditional entropy barrier should use approximately 64 times fewer flops compared to the quantum relative entropy barrier. This is reflected in the results, where QCE yields between a 30 to 80 times speedup compared to QRE. Additionally, the QCE is more memory efficient, whereas there is insufficient memory to run QRE at the largest problem dimension $l = 8$. The number of iterations between the two methods is mostly the same, however we note that at $l = 6$ and 7, the Hypaita algorithm when solving QRE was observed to fall back to less efficient stepping methods at times, which resulted in the increased number of iterations.

We note that the QRE experiment for $l = 2$ terminated early before reaching the desired tolerance, and only reached a relative gap of 3.6×10^{-8} .

7 Concluding remarks

Overall, we have shown how by using cones and barriers tailored to specific problems arising in quantum information theory, we are able to solve these problems using interior-point methods much more efficiently than if we lifted them to the full quantum relative entropy cone. In particular, we showed how we can absorb positive linear maps into the quantum relative entropy cone, and established optimal selfconcordance of the natural barriers for these cones. Additionally, we showed how we can exploit common structures in these linear maps, including as block diagonal, low-rank, and quantum conditional entropylike structures, to more efficiently solve linear systems with the Hessian matrices of these barriers, which is the main bottleneck in interior-point methods for quantum relative entropy programs. Our numerical experiments demonstrate that we can solve problems in fewer iterations, with faster per iteration cost, and requiring less computational memory, allowing us to solve problems which were previously intractable, such as to compute quantum key rates of high-dimensional quantum key distribution protocols. We conclude by presenting two directions for future work.

Automated software One of the main difficulties in implementing our techniques is that each problem requires its own tailored cone and barrier oracle which users must implement by themselves. As we have generalized the techniques that we have been using in Section [5,](#page-13-0) it would be beneficial to implement software which is able to automatically detect and exploit these structures in a way that mirrors how state-of-the-art semidefinite programming software is able to automatically take advantage of useful problem structure.

Primal-dual scalings Most of this paper has focused on the efficient practical implementation of quantum relative entropy programs for interior-point methods. However, it is also interesting if there are any algorithmic improvements we can make to interior-point methods for solving quantum relative entropy programs. One line of work in nonsymmetric cone programming aims to use primal-dual scalings to allow for symmetric primal and dual steps to be taken [\[5–](#page-33-6)[7\]](#page-33-11). This is a desirable property for these algorithms, and is commonly used in symmetric cone programming. This has recently been implemented for the exponential cone in [\[22\]](#page-34-5), and therefore it is of interest whether we can use the same technique to improve methods for solving quantum relative entropy programs. However, the primal-dual scaling matrices for non-symmetric cones require oracles for the conjugate barrier. In [\[61\]](#page-36-3), it was shown how the conjugate barrier could be efficiently computed for a range of nonsymmetric cones, and in [\[20\]](#page-34-6) it was shown how the conjugate barrier for the quantum entropy cone could be computed. However, whether the conjugate barrier for the quantum relative entropy cone can be efficiently computed is still an open question.

A Matrix inversion lemma

Consider the matrix $A - UBU^{\top}$ where $A \in \mathbb{R}^{n \times n}$, $B \in \mathbb{R}^{r \times r}$, and $U \in \mathbb{R}^{n \times r}$. When $r \ll n$, we can interpret this as a low rank perturbation of the matrix A, in which case it is well known that the inverse can be expressed as a low rank perturbation of A^{-1} . More concretely, if A and $A - UBU^{\top}$ are nonsingular, then

$$
(A - UBU\top)-1 = A-1 + A-1U(II - BU\top A-1U)-1BU\top A-1
$$
 (A.1)

Note that this expression does not require B to be nonsingular. This expression is well defined due to the following fact (see, e.g., [\[62\]](#page-36-4)).

Fact A.1. The matrices A and $A - UBU^{\top}$ are both nonsingular if and only if $\mathbb{I} - BU^{\top}A^{-1}U$ is also nonsingular.

Proof. This is a consequence of the identity $\det(\mathbb{I} - BU^{\top} A^{-1}U) = \det(A^{-1}) \det(A - UBU^{\top}).$ \Box

When B is also nonsingular, we have the following alternative expression for the matrix inverse, often referred to as the Sherman-Morrison-Woodbury identity

$$
(A - UBU\top)-1 = A-1 + A-1U(B-1 – U\topA-1U)-1U\topA-1
$$
 (A.2)

Similar to the previous identity, this identity is well defined under suitable assumptions.

Fact A.2. The matrices A, B, and $A - UBU^{\top}$ are all nonsingular if and only if $B^{-1} - U^{\top}A^{-1}U$ is also nonsingular.

Proof. This follows from $\det(B^{-1} - U^\top A^{-1}U) = \det(A^{-1}) \det(B^{-1}) \det(A - UBU^\top)$. \Box

This expression is advantageous as it gives a symmetric expression for the matrix inverse. If A and B are both positive definite, then we have the additional property, which is a straightforward consequence of the Schur complement lemma.

Fact A.3. If $B \succ 0$ and $A - UBU^{\top} \succ 0$, then $B^{-1} - U^{\top} A^{-1}U \succ 0$.

Proof. Consider the matrix

$$
X = \begin{bmatrix} A & U \\ U^\top & B^{-1} \end{bmatrix}.
$$

Using the Schur complement lemma (see, e.g., [\[63,](#page-36-5) Section A.5.5]) for the Schur complement of B^{-1} on X, we have that $B^{-1} \succ 0$ and $A - UBU^{\top} \succ 0$ implies $X \succ 0$. Now using the Schur complement lemma for the Schur complement of A on X, we have that $X \succ 0$ implies that $A \succ 0$ and $B^{-1} - U^{\top} A^{-1} U \succ 0$, as desired.

Therefore, under these assumptions, we can perform a Cholesky decomposition on the Schur complement matrix $B^{-1} - U^{\top} A^{-1} U$ rather than an LU decomposition to solve linear systems with this matrix.

We will also consider the following variant of the matrix inversion lemma.

Lemma A.4. Consider the matrices $A \in \mathbb{R}^{n \times n}$, $B \in \mathbb{R}^{n \times r}$, $C \in \mathbb{R}^{r \times r}$, and $U \in \mathbb{R}^{n \times r}$. Then if A and $A + UB^{\top} + BU^{\top} - UCU^{\top}$ are both positive definite, then

$$
\left(\begin{bmatrix} \mathbb{I} & U \end{bmatrix} \begin{bmatrix} A & B \\ B^{\top} & -C \end{bmatrix} \begin{bmatrix} \mathbb{I} \\ U^{\top} \end{bmatrix} \right)^{-1} = A^{-1} + A^{-1} \begin{bmatrix} B & U \end{bmatrix} \left(\underbrace{\begin{bmatrix} C & \mathbb{I} \\ \mathbb{I} & 0 \end{bmatrix}}_{S} + \begin{bmatrix} B^{\top} \\ U^{\top} \end{bmatrix} A^{-1} \begin{bmatrix} B & U \end{bmatrix} \right)^{-1} \begin{bmatrix} B^{\top} \\ U^{\top} \end{bmatrix} A^{-1}.
$$

Proof. First, we can recast solving linear systems with the desired matrix and a left-hand side vector $d \in \mathbb{R}^n$ as the optimality conditions of the unconstrained convex quadratic minimization problem

$$
\min_{x \in \mathbb{R}^n} \quad x^{\top} \begin{bmatrix} \mathbb{I} & U \end{bmatrix} \begin{bmatrix} A & B \\ B^{\top} & -C \end{bmatrix} \begin{bmatrix} \mathbb{I} \\ U^{\top} \end{bmatrix} x - d^{\top} x,
$$

which, in turn, is equivalent to the constrained convex quadratic minimization problem

$$
\min_{x \in \mathbb{R}^n, y \in \mathbb{R}^r} \quad \begin{bmatrix} x^\top & y^\top \end{bmatrix} \begin{bmatrix} A & B \\ B^\top & -C \end{bmatrix} \begin{bmatrix} x \\ y \end{bmatrix} x - d^\top x, \quad \text{subject to} \quad y = U^\top x.
$$

The optimality conditions for this reformulated problem are for the optimal primal and dual variables $x \in \mathbb{R}^n$, $y, z \in \mathbb{R}^r$ to satisfy

$$
\begin{bmatrix} A & B & U \\ B^{\top} & -C & -\mathbb{I} \\ U^{\top} & -\mathbb{I} & 0 \end{bmatrix} \begin{bmatrix} x \\ y \\ z \end{bmatrix} = \begin{bmatrix} d \\ 0 \\ 0 \end{bmatrix}.
$$

As $A + UB^{\top} + BU^{\top} - UCU^{\top}$ is assumed to be nonsingular, this minimization problem has a unique primal and dual solution, and therefore the KKT matrix must be nonsingular (see, e.g., [\[63,](#page-36-5) Section 10.1.1). Performing a suitable block elimination on this system of equations to solve for x gives the desired result. The expression is well defined as the (nonzero) determinant of the KKT matrix must equal det(A) det(S) (see, e.g., [\[63,](#page-36-5) Appendix A.5.5]), which implies that S must be nonsingular. \Box

B Derivatives

B.1 Spectral functions

Consider a scalar valued function $f : \text{dom } f \to \mathbb{R}$. Spectral functions extend f to act on Hermitian matrices X with spectral decomposition $X = \sum_{i=1}^{n} \lambda_i v_i v_i^{\dagger}$ and eigenvalues satisfying $\lambda_i \in \text{dom } f$ for all $i = 1, \ldots, n$ by letting

$$
f(X) := \sum_{i=1}^{n} f(\lambda_i) v_i v_i^{\dagger}.
$$

The derivatives of these functions are fairly well-known. To characterize these derivatives, consider a real diagonal matrix $\Lambda = \text{diag}(\lambda_1, \ldots, \lambda_n)$ with entries $\lambda_i \in \text{dom } f$ for all $i = 1, \ldots, n$. We define the first divided differences matrix $f^{[1]}(\Lambda) \in \mathbb{S}^n$ of Λ for the function f as the matrix whose (i, j) -th entry is $f^{[1]}(\lambda_i, \lambda_j)$, where

$$
f^{[1]}(\lambda, \mu) = \frac{f(\lambda) - f(\mu)}{\lambda - \mu}, \quad \text{if } \lambda \neq \mu
$$

$$
f^{[1]}(\lambda, \lambda) = f'(\lambda).
$$

We also define the k-th second divided difference matrix $f_k^{[2]}$ $\binom{[2]}{k}(\Lambda) \in \mathbb{S}^n$ of the matrix Λ for the function f as the matrix whose (i, j) -th entry is $f^{[2]}(\lambda_i, \lambda_j, \lambda_k)$, where

$$
f^{[2]}(\lambda, \mu, \sigma) = \frac{f^{[1]}(\lambda, \sigma) - f^{[1]}(\mu, \sigma)}{\lambda - \mu}, \quad \text{if } \lambda \neq \mu
$$

$$
f^{[2]}(\lambda, \lambda, \lambda) = \frac{1}{2} f''(\lambda),
$$

and all other scenarios are defined by noticing that $f^{[2]}(\lambda,\mu,\sigma)$ is defined symmetrically in each of its arguments. Given these, the following two lemmas follow from [\[64,](#page-36-6) Theorem 3.23] and [\[64,](#page-36-6) Theorem 3.33].

Lemma B.1. Consider the function $g(X) = \text{tr}[f(X)]$ for a twice continuously differentiable function $f : \text{dom } f \to \mathbb{R}$. The first and second derivatives of g are

$$
\nabla g(X) = f'(X) \tag{B.1a}
$$

$$
\nabla^2 g(X)[H] = U[(f')^{[1]}(\Lambda) \odot (U^{\dagger} H U)]U^{\dagger}, \tag{B.1b}
$$

where X has spectral decomposition $X = U\Lambda U^{\dagger}$.

Lemma B.2. Consider the function $h(X) = \text{tr}[Cf(X)]$ for a Hermitian matrix $C \in \mathbb{H}^n$ and a twice continuously differentiable function $f : \text{dom } f \to \mathbb{R}$. The first and second derivatives of h are

$$
\nabla h(X) = U[(f')^{[1]}(\Lambda) \odot (U^{\dagger}CU)]U^{\dagger}
$$
\n(B.2a)

$$
\nabla^2 h(X)[H] = U \left[\sum_{k=1}^n (f')_k^{[2]}(\Lambda) \odot \left([U^\dagger C U]_k [U^\dagger H U]_k^\dagger + [U^\dagger H U]_k [U^\dagger C U]_k^\dagger \right) \right] U^\dagger, \tag{B.2b}
$$

where X has spectral decomposition $X = U\Lambda U^{\dagger}$.

Remark B.3. Sometimes, it can be convenient to represent the second derivatives in matrix form, i.e., to characterize the Hessian matrix, so that we can perform standard linear algebra techniques on these linear maps. For a matrix $X \in \mathbb{H}^n$, we define $\text{vec}(X)$ as the operation which stacks the columns of X to form an n²-dimensional vector. Then using the identity $\text{vec}(AXB^{\dagger}) = (\overline{B} \otimes A) \text{vec}(X)$, the Hessian, as the linear operator acting on vectorized matrices, corresponding to [\(B.1b\)](#page-27-2) is equivalent to

$$
\nabla^2 g(X) = (\overline{U} \otimes U) \operatorname{diag}(\operatorname{vec}((f')^{[1]}(\Lambda))))(\overline{U} \otimes U)^{\dagger},
$$
(B.3)

and the Hessian corresponding to $(B.2b)$ is equivalent to [\[16\]](#page-34-2)

$$
\nabla^2 h(X) = (\overline{U} \otimes U) S_C(X) (\overline{U} \otimes U)^{\dagger}, \tag{B.4}
$$

 $S_C(X)$ is a sparse matrix given by

$$
[S_C(X)]_{ij,kl} = \delta_{kl} [U^{\dagger}CU]_{ij}(f')^{[2]}(\lambda_i, \lambda_j, \lambda_l) + \delta_{ij} [U^{\dagger}CU]_{kl}(f')^{[2]}(\lambda_j, \lambda_k, \lambda_l).
$$

Note that in practice, it is usually computationally faster to construct the Hessians by building each column of the matrix using $(B.1b)$ and $(B.2b)$, which costs $O(n^5)$ flops, compared to $(B.1b)$ and $(B.2b)$ which takes $O(n^6)$ flops.

Remark B.4. The inverse of the second derivative map [\(B.1b\)](#page-27-2) is given by

$$
(\nabla^2 g(X))^{-1}[H] = U[(U^{\dagger} H U) \oslash (f')^{[1]}(\Lambda)]U^{\dagger}
$$

where ⊘ denotes the elementwise or Hadamard division, and is therefore relatively easy to apply. Although the second derivative map $(B.2b)$ is also highly structured, it is not obvious how we can similarly compute its inverse efficiently without building and factoring the Hessian matrix.

As an important example, consider the case when $f(x) = \log(x)$ defined on \mathbb{R}_{++} , in which case we recover the log determinant function $\log \det(X) = \text{tr}[\log(x)]$ defined on \mathbb{H}_{++}^n . Using the fact that the first divided differences of $f'(x) = 1/x$ is

$$
(f')^{[1]}(\Lambda) = -[1/\lambda_i \lambda_j]_{i,j=1}^n,
$$

with Lemma [B.1,](#page-27-4) we recover the well-known result

$$
\nabla^2 \log \det(X)[H] = U[(f')^{[1]}(\Lambda) \odot (U^{\dagger} H U)]U^{\dagger}
$$

=
$$
-U[\Lambda^{-1}(U^{\dagger} H U)\Lambda^{-1}]U^{\dagger}
$$

=
$$
-X^{-1} H X^{-1}.
$$
 (B.5)

In the matrix form discussed in Remark [B.3,](#page-27-5) we can represent this as $\nabla^2 \log \det(X) = -\overline{X}^{-1} \otimes X^{-1}$. It is also fairly straightforward to show that the inverse of this linear map is

$$
\left(\nabla^2 \log \det(X)\right)^{-1} [H] = -XHX.
$$
\n(B.6)

B.2 Barrier functions

We are interested in barrier functions $F: \mathbb{R} \times \mathbb{H}^n_{++} \to \mathbb{R}$ of the form

$$
F(t, X) = -\log(t - \varphi(X)) - \log \det(X),\tag{B.7}
$$

for some convex function $\varphi : \mathbb{H}^n_{++} \to \mathbb{R}$, which turns out to be a suitable LHSCB for many cones defined as the epigraphs of spectral functions and related functions $[3, 29, 65]$ $[3, 29, 65]$ $[3, 29, 65]$ $[3, 29, 65]$. A straightforward computation shows that the first derivatives can be represented as

$$
\nabla_t F(t, X) = -\zeta^{-1}.
$$

\nabla_X F(t, X) = \zeta^{-1} \nabla \varphi(X) - X^{-1},

where $\zeta = t - \varphi(X)$, and, with some abuse of notation, the Hessian, as a linear operator acting on vectorized matrices, can be represented as the block matrix

$$
\nabla^2 F(t, X) = \begin{bmatrix} \zeta^{-2} & -\zeta^{-2} \nabla \varphi(X)^\top \\ -\zeta^{-2} \nabla \varphi(X) & \zeta^{-2} \nabla \varphi(X) \nabla \varphi(X)^\top + \zeta^{-1} \nabla^2 \varphi(X) + \overline{X}^{-1} \otimes X^{-1} \end{bmatrix}
$$

=
$$
\begin{bmatrix} \zeta^{-1} \\ -\zeta^{-1} \nabla \varphi(X) \end{bmatrix} \begin{bmatrix} \zeta^{-1} \\ -\zeta^{-1} \nabla \varphi(X) \end{bmatrix}^\top + \begin{bmatrix} 0 & 0 \\ 0 & \zeta^{-1} \nabla^2 \varphi(X) + \overline{X}^{-1} \otimes X^{-1} \end{bmatrix}.
$$
 (B.8)

It is fairly straightforward to show, using block elimination, that the solution to the linear system $\nabla^2 F(t, X)[s, H] = (u, V)$ is given by

$$
H = (\zeta^{-1} \nabla^2 \varphi(X) + \overline{X}^{-1} \otimes X^{-1})^{-1} (V + u \nabla \varphi(X))
$$
 (B.9a)

$$
s = \zeta^2 u + \langle \nabla \varphi(X), H \rangle, \tag{B.9b}

i.e., the main effort is in solving a linear system with the matrix $\zeta^{-1} \nabla^2 \varphi(X) + \overline{X}^{-1} \otimes X^{-1}$, which is guaranteed to be positive definite (as X is positive definite and φ is convex).

C Primal-dual interior-point algorithm

In this section, we introduce some preliminaries regarding the implementation of a primal-dual interiorpoint algorithm. Note that in our actual experiments, we do not use this exact implementation of the algorithm, but a more complicated variant which uses a homogeneous self-dual embedding, which has some numerical and practical advantages (see, e.g., $[4, 19]$ $[4, 19]$). Instead, we use this section to illustrate the main ideas and computations performed by the interior-point algorithm, which are mostly the same between the simplified algorithm we will illustrate and the variant using a homogeneous self-dual embedding.

We are interested in solving the standard form primal and dual conic programs

$$
\min_{x \in \mathbb{R}^n} \quad c^\top x \tag{C.1a} \quad \max_{y \in \mathbb{R}^p, z \in \mathbb{R}^n} \quad -b^\top y \tag{C.2a}
$$

$$
subj. to \tAx = b \t(C.1b) \tsubj. to \tz - ATy = c \t(C.2b)
$$

$$
x \in \mathcal{K}, \qquad (C.1c) \qquad z \in \mathcal{K}_*, \qquad (C.2c)
$$

where $c \in \mathbb{R}^n$, $A \in \mathbb{R}^{p \times n}$, $b \in \mathbb{R}^p$, $\mathcal{K} \subseteq \mathbb{R}^n$ is a proper convex cone, and $\mathcal{K}_* \subseteq \mathbb{R}^n$ is the dual cone of \mathcal{K} . Usually, we will consider K to be the Cartesian product of multiple proper cones, i.e., $\mathcal{K} = \mathcal{K}_1 \times \ldots \times \mathcal{K}_m$, where \mathcal{K}_i is a proper cone for all $i = 1, \ldots, m$.

To derive a primal-dual interior-point algorithm to solve this general conic program, let F : int $K \to$ R be a *v*-logarithmically homogeneous self-concordant barrier for the cone K. The convex conjugate $F_* : \text{int } \mathcal{K}_* \to \mathbb{R}$ of F is a v-LHSCB for the dual cone \mathcal{K}_* . Using these barriers to approximately enforce the conic constraints, we consider solving the primal and dual barrier problems

$$
\min_{x \in \mathbb{R}^n} \quad c^\top x + \mu F(x) \tag{C.3a}
$$
\n
$$
\max_{y \in \mathbb{R}^p, z \in \mathbb{R}^q} \quad -b^\top y - \mu F_*(z) \tag{C.4a}
$$

$$
subj. to \tAx = b,
$$
\t(C.3b)
$$
subj. to \t z - ATy = c,
$$
\t(C.4b)

which are parameterized by a barrier parameter $\mu > 0$. It can be shown that the primal-dual solutions $(x(\mu), y(\mu), z(\mu))$ to [\(C.3\)](#page-29-1) and [\(C.4\)](#page-29-2), also known as the central path, converge to the solution (x^*, y^*, z^*) of [\(C.1\)](#page-29-3) and [\(C.2\)](#page-29-4) as $\mu \downarrow 0$. The central path can be characterized by the KKT conditions for [\(C.3\)](#page-29-1) and [\(C.4\)](#page-29-2), i.e.,

$$
z(\mu) - A^{\top} y(\mu) = c \tag{C.5a}
$$

$$
Ax(\mu) = b \tag{C.5b}
$$

$$
\mu \nabla F(x(\mu)) + z(\mu) = 0. \tag{C.5c}
$$

Primal-dual interior-point methods derive stepping directions by taking appropriate linearizations of the central path equations. These steps $(\Delta x, \Delta y, \Delta z)$ satisfy linear equations (also known as Newton systems) of the form

$$
\begin{bmatrix} 0 & -A^{\top} & \mathbb{I} \\ -A & 0 & 0 \\ \mu \nabla^2 F(x) & 0 & \mathbb{I} \end{bmatrix} \begin{bmatrix} \Delta x \\ \Delta y \\ \Delta z \end{bmatrix} = \begin{bmatrix} r_x \\ r_y \\ r_z \end{bmatrix} . \tag{C.6}
$$

for some right-hand side (r_x, r_y, r_z) which are dependent on how we linearize the central path equations, e.g., if we want to solve for a direction tangential to the central path, or to solve the central path equations as a system of nonlinear equations. If we perform block elimination on this system of equations, we obtain

$$
A\nabla^2 F(x)^{-1}A^\top \Delta y = A\nabla^2 F(x)^{-1}(r_z - r_x) - \mu r_y
$$
\n(C.7a)

$$
\Delta x = \frac{1}{\mu} \nabla^2 F(x)^{-1} (r_z - r_x - A^\top \Delta y)
$$
 (C.7b)

$$
\Delta z = A^{\top} \Delta y + r_x. \tag{C.7c}
$$

Taking this approach, the main cost in solving for a stepping direction is in forming and Cholesky factoring the Schur complement matrix $A \nabla^2 F(x)^{-1} A^{\top}$.

D Additional details on the discrete-phase-randomized protocol

Here, we provide some additional details about the structure of the linear maps for the dprBB84 quantum key rate protocol. Recall that for this protocol, we are interested in the linear map

$$
\mathcal{G}(X) = K_1 X K_1^{\dagger} + K_2 X K_2^{\dagger},
$$

where K_1 and K_2 are given by [\(19\)](#page-5-5). A first observation is that $K_1^{\dagger} K_2 = K_2^{\dagger} K_1 = 0$, and therefore $\langle K_1 X K_1^{\dagger}, K_2 X K_2^{\dagger} \rangle = 0$ for all $X \in \mathbb{H}^{12c}$. This implies that $\mathcal{G}(X)$ has a block diagonal structure. More concretely, we can show that

$$
\mathcal{G}(X) = P_g \begin{bmatrix} \mathcal{G}_1(X) & & \\ & \mathcal{G}_2(X) & \\ & & 0 \end{bmatrix} P_g^\top,\tag{D.1}
$$

where P_g is a suitable permutation matrix, and $\mathcal{G}_1(X) \coloneqq \hat{K}_1 X \hat{K}_1^{\dagger}$ and $\mathcal{G}_2(X) \coloneqq \hat{K}_2 X \hat{K}_2^{\dagger}$ where

$$
\hat{K}_1 = \sqrt{p_z} \left(\bigoplus_{i=1}^{c} \begin{bmatrix} 1 & 0 & 0 & 0 \\ 0 & 1 & 0 & 0 \end{bmatrix} \right) \otimes \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \end{bmatrix}
$$
 (D.2a)

$$
\hat{K}_2 = \sqrt{1 - p_z} \left(\bigoplus_{i=1}^c \begin{bmatrix} 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 \end{bmatrix} \right) \otimes \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \end{bmatrix} .
$$
 (D.2b)

Next, we also recognize that the pinching map, the act of zeroing off-diagonal blocks, can only ever split a block diagonal block into multiple smaller block diagonal blocks. Therefore, we expect $Z_j K_i X K_i^{\dagger} Z_j^{\dagger}$ for $i, j = 1, 2$ to represent four distinct block diagonal blocks of the image of $\mathcal{Z} \circ \mathcal{G}$, where $Z_j = e_j e_j^{\top} \otimes \mathbb{I}$ for $j = 1, 2$. More concretely, we can show that

$$
\mathcal{Z}(\mathcal{G}(X)) = P_z \begin{bmatrix} \mathcal{Z}_1(\mathcal{G}_1(X)) & & \\ & \mathcal{Z}_2(\mathcal{G}_1(X)) & \\ & & \mathcal{Z}_1(\mathcal{G}_2(X)) & \\ & & & \mathcal{Z}_2(\mathcal{G}_2(X)) & \\ & & & & 0 \end{bmatrix} P_z^\top, \tag{D.3}
$$

where P_z is a suitable permutation matrix, and $\mathcal{Z}_1(X) \coloneqq \hat{Z}_1 X \hat{Z}_1^{\dagger}$ and $\mathcal{Z}_2(X) \coloneqq \hat{Z}_2 X \hat{Z}_2^{\dagger}$ where

$$
\hat{Z}_1 = \left(\bigoplus_{i=1}^{c} \begin{bmatrix} 1 & 0 \end{bmatrix}\right) \otimes \mathbb{I}
$$
\n
$$
\left(\begin{array}{c} c \end{array}\right) \qquad (D.4a)
$$

$$
\hat{Z}_2 = \left(\bigoplus_{i=1}^c [0 \quad 1] \right) \otimes \mathbb{I}.\tag{D.4b}
$$

Note that the linear maps \mathcal{G}_1 , \mathcal{G}_2 , \mathcal{Z}_1 , and \mathcal{Z}_2 all have the effect of extracting a principal submatrix from a matrix, up to a scaling factor. Therefore, computationally, these maps are easy to apply as they only require indexing and scalar multiplication operations.

E Additional details on experimental setup

Here, we provide additional details about how we model the quantum relative entropy programs to parse into Hypatia for the numerical experiments we present in Section [6.](#page-18-0) Our proposed methods all model the problem in the standard form $(C.1)$ and solve the Newton equations using the block elimination method described in Appendix [C.](#page-28-0) On the other hand, for many of the benchmark methods we compare our proposed approaches to, we found it computationally advantageous to give problems to Hypatia in the more general form

where $c \in \mathbb{R}^n$, $A \in \mathbb{R}^{p \times n}$, $b \in \mathbb{R}^p$, $G \in \mathbb{R}^{q \times n}$, $h \in \mathbb{R}^q$, and $\mathcal{K} \subset \mathbb{R}^q$ is a proper convex cone, and to solve problems using Hypatia's default Newton system solver, which is based on the method from [\[57,](#page-35-21) Section 10.3].

E.1 Quantum key distribution

For the QRE method, we model the problem as the standard quantum relative entropy program
