# Rational, trigonometric, elliptic algebras and moduli spaces of sheaves on surfaces

#### Abstract

We survey the well-known Yangian of $\widehat{\mathfrak{g}}_{1}$ /quantum toroidal $\mathfrak{g l}_{1}$ action on the cohomology / $K$-theory of moduli spaces of stable sheaves on surfaces, and give the generalization of this construction to elliptic cohomology


Keywords: Yangians, quantum toroidal algebras, elliptic quantum groups, moduli spaces of sheaves on surfaces.

## 1. Introduction

1.1. Let $H_{X}$ denote the singular cohomology of a smooth algebraic variety $X$ over $\mathbb{C}$. One of the major milestones in geometric representation theory was the construction (independently due to Grojnowski 10 and Nakajima 13) of an action

\end{equation*}

In the left-hand side, we have the infinite-dimensional Heisenberg Lie algebra. In the right-hand side, the Hilbert schemes $S^{[n]}$ of $n$ points on a smooth projective surface $S$ are perhaps some of the simplest moduli spaces of coherent sheaves. They parameterize length $n$ subschemes of $S$, or equivalently, colength $n$ ideal sheaves. The latter interpretation allows one to think of Hilbert schemes as moduli spaces of rank 1 coherent sheaves on $S$, and therefore suggests that (1.1) should admit a higher rank generalization. Indeed, one may consider the moduli spaces

\mathcal{M}=\bigsqcup_{c_{2} \in \mathbb{Z}} \mathcal{M}_{\left(r, c_{1}, c_{2}\right)} \tag{1.2}
\end{equation*}

parameterizing stable sheaves $\mathcal{F}$ on $S$ of fixed rank $r$ and first Chern class $c_{1}$, but variable second Chern class $c_{2}$ (see Subsection 2.1 for an overview of $\mathcal{M}$ ). In this direction, Baranovsky showed in [1] that one can generalize (1.1) to an action

\widehat{\mathfrak{g l}}_{1} \curvearrowright H_{\mathcal{M}}=\bigoplus_{c_{2} \in \mathbb{Z}} H_{\mathcal{M}_{\left(r, c_{1}, c_{2}\right)}} \tag{1.3}
\end{equation*}
$$

Another direction in which one may seek to generalize (1.1) is to enlarge the infinitedimensional Heisenberg Lie algebra. Inspired by work of 9, 14, [21 on quiver

[^0]varieties, the corresponding enlargement is an algebra known as the Yangian
$$
Y_{t_{1}, t_{2}}\left(\widehat{\mathfrak{g}}_{1}\right) \supset \widehat{\mathfrak{g l}}_{1}
$$
(see [4] for Yangians of finite type Lie algebras, of which the object above is a natural generalization) defined over the ring $\mathbb{Z}\left[t_{1}, t_{2}\right]$. We will recall the definition of the Yangian in Subsection 3.1 and prove the following generalization of (1.3).

Theorem 1.2. (Theorem 3.13) For any smooth projective surface $S$, and $r, c_{1}$ satisfying Assumptions $A$ and $S$ in (2.3) and (2.5) (respectively), there is an action

$$
\begin{equation*}
Y_{t_{1}, t_{2}}\left(\widehat{\mathfrak{g}}_{1}\right) \curvearrowright H_{\mathcal{M}} \tag{1.4}
\end{equation*}
$$

Above, one must be careful to properly define the notion of an "action" of the Yangian on the cohomology of moduli spaces of stable sheaves. In Definition 3.19, the appropriate notion will be shown to be that of an abelian group homomorphism

$$
\begin{equation*}
Y_{t_{1}, t_{2}}\left(\widehat{\mathfrak{g}}_{1}\right) \rightarrow \operatorname{Hom}\left(H_{\mathcal{M}}, H_{\mathcal{M} \times S}\right) \tag{1.5}
\end{equation*}
$$

satisfying several axioms; the parameters $t_{1}, t_{2}$ are identified with the Chern roots of the cotangent bundle of $S$, in a sense that will be made precise in Definition 3.19,

When $S=\mathbb{A}^{2}$ and one works with the moduli space of framed sheaves (a close relative of $\mathcal{M}$, which we will recall in Subsection 2.5) then the cohomology of $S$ is trivial. In this case, (1.5) yields an honest action of the Yangian on the cohomology groups of the moduli spaces of framed sheaves. As the latter spaces are isomorphic to Nakajima quiver varieties for the Jordan quiver, then the $S=\mathbb{A}^{2}$ analogue of (1.4) (see Theorem 3.10) can be construed as the Jordan quiver version of (9, 14, 21.
1.3. In representation theory, there are three ways to "affinize" Lie algebras

(\text { Yangians }) \leftarrow(\text { quantum loop groups }) \leftarrow(\text { elliptic quantum groups }) \tag{1.6}
\end{equation*}
$$

that correspond to solving the Yang-Baxter equation with parameter in $\mathbb{C}, \mathbb{C}^{*}$ and an elliptic curve $E$, respectively (thus the algebras above are usually called rational, trigonometric and elliptic, respectively). The arrows in (1.6) mean that by suitably degenerating elliptic quantum groups, one may obtain quantum loop groups, and by suitably degenerating quantum loop groups, one may obtain Yangians.

On the geometric side, we also have three important oriented homology theories

(\text { cohomology }) \leftarrow(K \text {-theory }) \leftarrow(\text { elliptic cohomology }) \tag{1.7}
\end{equation*}
$$

As we have already seen in the previous Subsection, the Yangian of $\widehat{\mathfrak{g l}}_{1}$ acts on the cohomology of moduli spaces of stable sheaves. Therefore, the following is a natural analogue of Theorem 1.2 Below and henceforth, we let $K_{X}$ denote either the 0 -th topological or algebraic $K$-theory group of a smooth projective variety $X$ over $\mathbb{C}$.

Theorem 1.4. (Theorem 4.11) For any smooth projective surface $S$, and $r, c_{1}$ satisfying Assumptions $A$ and $S$ in (2.3) and (2.5) (respectively), there is an action

$$
\begin{equation*}
U_{q_{1}, q_{2}}\left(\ddot{\mathfrak{g}}_{1}\right) \curvearrowright K_{\mathcal{M}} \tag{1.8}
\end{equation*}
$$

We will recall the definition of the algebra $U_{q_{1}, q_{2}}\left(\ddot{g}_{1}\right)$ in Subsection 4.1. It is called quantum toroidal $\mathfrak{g l}_{1}$, as well as the Ding-Iohara-Miki algebra ([3, 12]), and it was studied in numerous works (closest to our point of view being [5, 6]). As an algebra, it is defined over the ring $\mathbb{Z}\left[q_{1}^{ \pm 1}, q_{2}^{ \pm 1}\right]$, where the formal parameters $q_{1}, q_{2}$ should be construed as the exponentials of the parameters $t_{1}, t_{2}$ of the previous Subsection. From a geometric point of view, $q_{1}+q_{2}$ and $q_{1} q_{2}$ are identified with the $K$-theory classes of the cotangent bundle and the canonical line bundle of $S$, respectively.
Although it is not apparent from the usual definition (which we will recall in Subsection 4.1), there is an inclusion of algebras

\begin{equation*}
(q \text {-Heisenberg algebra }) \hookrightarrow U_{q_{1}, q_{2}}\left(\ddot{g}_{1}\right) \tag{1.9}
\end{equation*}
$$

Because of this, (1.8) yields an action of the $q$-Heisenberg algebra on the $K$-theory of moduli spaces of stable sheaves, i.e. a $q$-version of the action (1.3) ${ }^{2}$.
1.5. The novelty in the present paper is to run the above program in the setting of elliptic cohomology. We will follow the axiomatic viewpoint of [8], which associates to an elliptic curve $E$ the contravariant functor of (0-th) elliptic cohomology

\begin{equation*}
(\text { smooth varieties over } \mathbb{C}) \quad \xrightarrow{X \mapsto \mathrm{Ell}_{X}} \quad \text { Commutative rings } \tag{1.10}
\end{equation*}
$$

and regards Chern classes of rank $r$ vector bundles $\mathcal{V}$ on $X$ as maps of schemes

$$
\begin{equation*}
\operatorname{Spec}\left(\operatorname{Ell}_{X}\right) \xrightarrow{c \mathcal{\nu}} E^{(r)} \tag{1.11}
\end{equation*}
$$

where $E^{(r)}=E^{r} / S_{r}$ denotes the $r$-th symmetric power of $E$. Naively, one would imagine elliptic cohomology classes to be elements of $\mathrm{Ell}_{X}$, i.e. regular functions on $\operatorname{Spec}\left(\operatorname{Ell}_{X}\right)$. However, the correct thing to do would be to broaden one's understanding and declare that elliptic cohomology classes on $X$ are

\begin{aligned}
& \text { sections of line bundles on } \operatorname{Spec}\left(E \mathrm{Ell}_{X}\right) \Leftrightarrow \\
& \qquad \Leftrightarrow \text { elements of locally free rank } 1 \text { modules over } E l_{X}
\end{aligned}
$$

Indeed, a big source of elliptic cohomology classes are the pull-backs of various meromorphic functions on $E^{(r)}$ to $\operatorname{Spec}\left(\operatorname{Ell}_{X}\right)$ via the map $c_{\mathcal{V}}$ of (1.11). As these meromorphic functions are naturally interpreted as sections of line bundles on $E^{(r)}$, their pull-backs via $c_{\mathcal{V}}$ are also naturally sections of line bundles on $\operatorname{Spec}\left(\operatorname{Ell}_{X}\right)$.
1.6. For any map of smooth varieties $f: X \rightarrow Y$, one has a ring homomorphism

$$
\mathrm{Ell}_{Y} \xrightarrow{f^{*}} \mathrm{Ell}_{X}
$$

For any proper map $f: X \rightarrow Y$, push-forward is defined by [8] as a map

$$
\left\{\text { a locally free rank } 1 \text { Ell }_{X} \text {-module }\right\} \xrightarrow{f_{*}} \text { Ell }_{Y}
$$

of Ell ${ }_{Y}$-modules, for any proper morphism $f: X \rightarrow Y$. However, as we will recall in Subsection 5.7 the above locally free rank 1 module is completely determined by the virtual relative tangent bundle of the morphism $f$. Moreover, in the present paper we will only encounter two situations: when $f$ is a regular embedding and

[^1]when $f$ is a projective bundle. In both of these cases, there exist explicit formulas for $f_{*}$ which completely encode the locally free rank 1 module in question. Thus, we will often abuse notation and write
\[

f_{*}: \operatorname{Ell}_{X} \rightarrow \operatorname{Ell}_{Y} \tag{1.12}
\end{equation*}
$$

\]

throughout the present paper. The reader may then easily deduce which locally free rank $1 \mathrm{Ell}_{X}$-module needs to go in the domain of $f_{*}$ just by looking at the formula for $f_{*}$ (see Subsection 5.12 for a defining example of this principle). Thus, we are not really sacrificing mathematical precision in writing formulas such as (1.12); we are simply sacrificing notational precision, and the benefit is increased legibility.
1.7. We will consider the elliptic cohomology of the moduli space (1.2) of stable sheaves, for any fixed $r \in \mathbb{N}$ and $c_{1} \in H^{2}(S, \mathbb{Z})$ that satisfy Assumptions A and S. In formulas (5.28), (5.29), (5.30), we construct formal series of operators

$$
\begin{equation*}
e(z), f(z), h^{ \pm}(z): \operatorname{Ell}_{\mathcal{M}} \rightarrow \operatorname{Ell}_{\mathcal{M} \times S}\left[\left[z, z^{-1}\right]\right] \tag{1.13}
\end{equation*}
$$

Above, the symbol $z$ plays the role of the usual variable on the cover

$$
\mathbb{C}^{*} \rightarrow \mathbb{C}^{*} / p^{\mathbb{Z}}=E
$$

where $p$ is a complex number with absolute value strictly contained between 0 and 1. Our main result is the commutation relations between the series of operators (1.13). These will be presented in Theorem 5.20, and they correspond to an action

$$
\begin{equation*}
U_{q_{1}, q_{2}, p}\left(\ddot{\mathfrak{g}}_{1}\right) " \curvearrowright " \operatorname{Ell}_{\mathcal{M}} \tag{1.14}
\end{equation*}
$$

where the object in the left-hand side is the elliptic quantum toroidal algebra defined in 11 (with central charge equal to 1 and without the cubic relation of loc. cit., see Subsection 5.21). The reason we do not state (1.14) as a Theorem is of a rather pedantic nature: the left-hand side is an algebra defined over power series in $p$, while the right-hand side is defined for a specific value of $p \in \mathbb{C}^{*}$.

## 2. Preliminaries on moduli of sheaves on surfaces

2.1. Fix a smooth projective connected surface $S$ over an algebraically closed field of characteristic 0 (we will henceforth abuse notation and denote the field by $\mathbb{C}$ ) and a ample divisor $H \subset S$. A coherent sheaf $\mathcal{F}$ on $S$ is called stable if all proper subsheaves $\mathcal{G} \subsetneq \mathcal{F}$ have reduced Poincaré polynomial (defined with respect to $H$ ) smaller than that of $\mathcal{F}$; see [17, Section 5] and the references therein for an overview.

Theorem 2.2. For any $\left(r, c_{1}, c_{2}\right) \in \mathbb{N} \times H^{2}(S, \mathbb{Z}) \times \mathbb{Z}$, there exists a moduli space $\mathcal{M}_{\left(r, c_{1}, c_{2}\right)}$ corepresenting the functor of stable sheaves $\mathcal{F}$ on $S$ of rank $r$, first Chern class $c_{1}$ and second Chern class $c_{2}$.

Bogomolov's inequality states that

$$
\begin{equation*}
\mathcal{M}_{\left(r, c_{1}, c_{2}\right)}=\varnothing \quad \text { if } \quad c_{2}<\frac{r-1}{2 r} c_{1}^{2} \tag{2.1}
\end{equation*}
$$

Throughout the present paper, we fix $r, c_{1}$ and write

$$
\begin{equation*}
\mathcal{M}=\bigsqcup_{c_{2} \in \mathbb{Z}} \mathcal{M}_{\left(r, c_{1}, c_{2}\right)} \tag{2.2}
\end{equation*}
$$

although, as mentioned in (2.1), the number $c_{2}$ is actually bounded below. We will henceforth make the following assumptions, as in [17]. The first of these states that

## Assumption A: $\operatorname{gcd}\left(r, c_{1} \cdot H\right)=1$

and implies that $\mathcal{M}$ is projective (because Assumption A implies that any seminstable sheaf is stable), and that it also represents the functor referenced in Theorem 2.2. In other words, this means that there exists a universal sheaf

whose restriction to any point $\mathcal{F} \in \mathcal{M}$ is isomorphic to $\mathcal{F}$ as a sheaf on $S$. The second assumption pertains to the canonical bundle $\mathcal{K}_{S}$ of $S$, and it reads

Assumption S: either $\mathcal{K}_{S} \cong \mathcal{O}_{S}$ or $c_{1}\left(\mathcal{K}_{S}\right) \cdot H<0$
The latter assumption implies that $\mathcal{M}$ is smooth, and although it will be in force throughout the present paper, it can be sidestepped if one is prepared to work with derived moduli spaces of sheaves. However, Assumption A is quite crucial for us, because we will fundamentally use the universal sheaf $\mathcal{U}$.
2.3. If $\mathcal{F}, \mathcal{F}^{\prime}$ are sheaves on $S$ such that there exists a short exact sequence

$$
\begin{equation*}
0 \rightarrow \mathcal{F}^{\prime} \rightarrow \mathcal{F} \rightarrow \mathbb{C}_{x} \rightarrow 0 \tag{2.6}
\end{equation*}
$$

for some closed point $x \in S$ (where $\mathbb{C}_{x}$ denotes the skyscraper sheaf at $x$ ), then we will say that $\mathcal{F}$ and $\mathcal{F}^{\prime}$ are Hecke modifications of each other and write this as

$$
\mathcal{F}^{\prime} \subset_{x} \mathcal{F}
$$

An important consequence of Assumption A is the fact (see [17, Proposition 5.5]) that $\mathcal{F}$ is stable if and only if $\mathcal{F}^{\prime}$ is stable. Thus, we may define the moduli space

$$
\begin{equation*}
\mathfrak{Z}=\left\{\left(\mathcal{F}, \mathcal{F}^{\prime}\right) \text { both stable, such that } \mathcal{F}^{\prime} \subset_{x} \mathcal{F}\right\} \tag{2.7}
\end{equation*}
$$

which is smooth and projective ([17, Proposition 2.10]). Let us consider the maps

which remember $\mathcal{F}^{\prime}, x, \mathcal{F}$ (respectively) in the notation of (2.6). Above, $\mathcal{M}$ and $\mathcal{M}^{\prime}$ are simply two copies of the moduli space (2.2), although one should think that the grading by $c_{2}$ in the moduli space $\mathcal{M}^{\prime}$ is always 1 more than that of $\mathcal{M}$.

If $\mathcal{V}$ is a locally free sheaf on a variety $X$, then we define its projectivization as

$$
\mathbb{P}_{X}(\mathcal{V})=\operatorname{Proj}_{X}\left(\operatorname{Sym}^{\bullet} \mathcal{V}\right)
$$

More generally, if $\mathcal{E}$ is a coherent sheaf of projective dimension 1, its projectivization is defined in (5.22). With this in mind, we have the following description of $\mathfrak{J}$.

Proposition 2.4. ([17, Propositions 2.8 and 2.10]) The maps $\pi_{-} \times \pi_{S}$ and $\pi_{+} \times \pi_{S}$ realize $\mathfrak{Z}$ as the projectivizations

$$
\begin{equation*}
\mathbb{P}_{\mathcal{M} \times S}(\mathcal{U}) \quad \text { and } \quad \mathbb{P}_{\mathcal{M}^{\prime} \times S}\left(\mathcal{U}^{\prime \vee}[1] \otimes \mathcal{K}_{S}\right) \tag{2.9}
\end{equation*}
$$

where $\mathcal{U}$ and $\mathcal{U}^{\prime}$ denote the universal sheaves on $\mathcal{M} \times S$ and $\mathcal{M}^{\prime} \times S$, respectively.

The line bundle
whose fiber over a point $\left(\mathcal{F}^{\prime}, \mathcal{F}\right)$ is the one-dimensional vector space $\mathcal{F}_{x} / \mathcal{F}_{x}^{\prime}$ is identified with $\mathcal{O}(1)$ and $\mathcal{O}(-1)$, respectively, under the projectivizations (2.9).
2.5. When $S=\mathbb{A}^{2}$, the moduli space of stable sheaves is not well-defined. However, there is an alternate provided by the so-called moduli space of framed sheaves on $\mathbb{P}^{2}$. Intuitively, this is because framing (like stability) gives a way to control the automorphisms of sheaves, leading to well-behaved moduli spaces.

Definition 2.6. Consider $\mathbb{P}^{2}=\mathbb{A}^{2} \sqcup \infty$ and define the moduli space

$$
\begin{array}{r}
\mathcal{M}_{\mathbb{A}^{2}}=\left\{\text { rank } r \text { torsion-free sheaves } \mathcal{F} \text { on } \mathbb{P}^{2}, \text { locally free near } \infty,\right.  \tag{2.11}\\
\text { together with an isomorphism } \left.\left.\mathcal{F}\right|_{\infty} \cong \mathcal{O}_{\infty}^{\oplus r}\right\}
\end{array}
$$

The moduli space $\mathcal{M}_{\mathbb{A}^{2}}$ has connected components indexed by $n=c_{2}(\mathcal{F})$, namely

$$
\mathcal{M}_{\mathbb{A}^{2}}=\bigsqcup_{n=0}^{\infty} \mathcal{M}_{\mathbb{A}^{2}, n}
$$

For any $n$, the connected component $\mathcal{M}_{\mathbb{A}^{2}, n}$ is a smooth quasiprojective algebraic variety, and can be explicitly presented (via the famous Atiyah-Drinfeld-HitchinManin construction) as the space of quadruples of linear maps

$$
\begin{equation*}
\left\{(X, Y, A, B) \text { s.t. } \mathbb{C}^{n} \stackrel{X}{\underset{Y}{\rightleftharpoons}} \mathbb{C}^{n}, \mathbb{C}^{r} \underset{B}{\stackrel{A}{\rightleftharpoons}} \mathbb{C}^{n},[X, Y]+A B=0\right\}^{\text {stable }} / G L_{n} \tag{2.12}
\end{equation*}
$$

Above, a quadruple $(X, Y, A, B)$ is called stable if there is no proper subspace of $\mathbb{C}^{n}$ which contains $\operatorname{Im} A$ and is preserved by both $X$ and $Y$. The action of $G L_{n}$ on quadruples is given by conjugating $X, Y$ and multiplying $A, B$ on either side.

Remark 2.7. Although $\mathcal{M}_{\mathbb{A}^{2}}$ parameterizes sheaves $\mathcal{F}$ on $\mathbb{P}^{2}$, such sheaves are trivialized on the divisor $\infty$ and so all their interesting behavior happens on $\mathbb{A}^{2}$. Thus, we will often restrict such $\mathcal{F}$ to a sheaf on $\mathbb{A}^{2}$ in what follows. In particular, the analogue of the universal sheaf (2.4) is defined as


Similarly, the natural analogue of the moduli space (2.7) requires the point $x$ to be away from $\infty$, so we put $S=\mathbb{A}^{2}$ in diagram (2.8). We will also encounter the restriction of the universal sheaf to $\mathcal{M}_{\mathbb{A}^{2}} \times\{$ origin $\}$


The dilation torus action $T=\mathbb{C}^{*} \times \mathbb{C}^{*} \curvearrowright \mathbb{A}^{2}$ induces an action

$$
T \curvearrowright \mathcal{M}_{\mathbb{A}^{2}}
$$

In the language of (2.12), the torus $T$ scales the matrices $X, Y, A, B$ by the characters $\frac{1}{q_{1}}, \frac{1}{q_{2}}, 1, \frac{1}{q_{1} q_{2}}$, respectively, where $q_{1}, q_{2}$ are the elementary characters of $T$.

## 3. COHOMOLOGY

3.1. We start with a warm-up on the Yangian of $\widehat{\mathfrak{g l}}_{1}$ and its action on the equivariant cohomology of moduli spaces of framed sheaves on $\mathbb{A}^{2}$. We will work over the ring of polynomials in two variables $t_{1}$ and $t_{2}$. Let us write $t=t_{1}+t_{2}$ and consider the rational functions

$$
\begin{gather*}
\zeta^{\mathbb{C}}(x)=\frac{\left(x+t_{1}\right)\left(x+t_{2}\right)}{x(x+t)}  \tag{3.1}\\
\widetilde{\zeta}^{\mathbb{C}}(x)=\zeta^{\mathbb{C}}(x)(x+t)(x-t)=\frac{\left(x+t_{1}\right)\left(x+t_{2}\right)(x-t)}{x} \tag{3.2}
\end{gather*}
$$

The following definition is inspired by the Yangians of finite type Lie algebras that were constructed in [4], and studied in numerous works afterwards.

Definition 3.2. ([20]) The Yangian of $\widehat{\mathfrak{g l}}_{1}$ is the algebra

$$
Y_{t_{1}, t_{2}}\left(\hat{\mathfrak{g l}}_{1}\right)=\mathbb{Z}\left[t_{1}, t_{2}\right]\left\langle e_{n}, f_{n}, h_{n}\right\rangle_{n \geq 0} / \text { relations (3.3)-(3.7) }
$$

The defining relations are best written in terms of the generating series

$$
e(z)=\sum_{n=0}^{\infty} \frac{e_{n}}{z^{n+1}}, \quad f(z)=\sum_{n=0}^{\infty} \frac{f_{n}}{z^{n+1}}, \quad h(z)=1+\sum_{n=0}^{\infty} \frac{h_{n}}{z^{n+1}}
$$

and take the form

$$
\begin{equation*}
\left[e(z) e(w) \widetilde{\zeta}^{\mathbb{C}}(w-z)\right]_{z^{<0}, w^{<0}}=\left[e(w) e(z) \widetilde{\zeta}^{\mathbb{C}}(z-w)\right]_{z^{<0}, w^{<0}} \tag{3.3}
\end{equation*}
$$

$$
\begin{gather*}
{\left[f(w) f(z) \widetilde{\zeta}^{\mathbb{C}}(w-z)\right]_{z^{<0}, w<0}=\left[f(z) f(w) \widetilde{\zeta}^{\mathbb{C}}(z-w)\right]_{z^{<0}, w^{<0}}}  \tag{3.4}\\
h(z) e(w)=\left[e(w) h(z) \frac{\zeta^{\mathbb{C}}(z-w)}{\zeta^{\mathbb{C}}(w-z)}\right]_{z \gg w \mid z \leq 0, w^{<0}}  \tag{3.5}\\
f(w) h(z)=\left[h(z) f(w) \frac{\zeta^{\mathbb{C}}(z-w)}{\zeta^{\mathbb{C}}(w-z)}\right]_{z \gg w \mid z \leq 0, w^{<0}}  \tag{3.6}\\
{[f(z), e(w)]=\frac{t_{1} t_{2}}{t} \cdot \frac{h(z)-h(w)}{z-w}} \tag{3.7}
\end{gather*}
$$

as well as $[h(z), h(w)]=0$.

Let us explain the meaning of the square brackets in (3.3)-(3.7), and how to turn them into equalities of symbols: in formulas (3.3) and (3.4), we cancel out the factor $z-w$ from the denominator and equate the coefficients of all $\left\{z^{a} w^{b}\right\}_{a<0, b<0}$ in the left and right-hand sides. In formulas (3.5) and (3.6), we expand the rational function in the RHS in non-negative powers of $w / z$, and equate the coefficients of all $\left\{z^{a} w^{b}\right\}_{a \leq 0, b<0}$ in the left and right-hand sides. Finally, in formula (3.7), we simply equate the coefficients of all $\left\{z^{a} w^{b}\right\}_{a<0, b<0}$ in the left and right-hand sides.

Remark 3.3. In many works (such as [20]), the algebra $Y_{t_{1}, t_{2}}\left(\widehat{\mathfrak{g l}}_{1}\right)$ involves the additional cubic relations analogous to the Drinfeld-Serre relations in finite types

\sum_{\sigma \in S_{3}}\left[e_{n_{\sigma(1)}},\left[e_{n_{\sigma(2)}}, e_{n_{\sigma(3)}+1}\right]\right]=\sum_{\sigma \in S_{3}}\left[f_{n_{\sigma(1)}},\left[f_{n_{\sigma(2)}}, f_{n_{\sigma(3)}+1}\right]\right]=0 \tag{3.8}
\end{equation*}
$$

for all $n_{1}, n_{2}, n_{3} \geq 0$. These additional relations hold in all the modules of geometric nature considered in the present paper, namely the cohomology groups of moduli spaces of stable/framed sheaves (this was proved at the level of $K$-theory in [18, and the version in cohomology can be deduced via the Chern character isomorphism).
3.4. Let us unpack relations (3.3)-(3.7). The last of these relations is the easiest one, as it yields the following identity for all $m, n \geq 0$

\end{equation*}

To express relations (3.5) and (3.6), we need to consider the power series expansion

\frac{\zeta^{\mathbb{C}}(z-w)}{\zeta^{\mathbb{C}}(w-z)}=\frac{\left(z-w+t_{1}\right)\left(z-w+t_{2}\right)(z-w-t)}{\left(z-w-t_{1}\right)\left(z-w-t_{2}\right)(z-w+t)}=1+\sum_{a=3}^{\infty} \sum_{b=0}^{a-2} t_{1} t_{2} \gamma_{a b} \frac{w^{b}}{z^{a}} \tag{3.10}
\end{equation*}
$$

for various polynomial expressions $\gamma_{a b}$ in $t=t_{1}+t_{2}$ and $t_{1} t_{2}$. The fact that we can extract a factor of $t_{1} t_{2}$ from the coefficients in the right-hand side of (3.10) will be very important for our geometric constructions in the subsequent Subsections, and
it is due to the fact that the left-hand side of (3.10) is equal to 1 when either $t_{1}=0$ or when $t_{2}=0$. With this in mind, relations (3.5)-(3.6) read

\begin{align*}
& {\left[h_{n}, e_{m}\right]=t_{1} t_{2} \sum_{a=3}^{\infty} \sum_{b=0}^{a-2} \gamma_{a b} \cdot e_{m+b} h_{n-a}}  \tag{3.11}\\
& {\left[f_{m}, h_{n}\right]=t_{1} t_{2} \sum_{a=3}^{\infty} \sum_{b=0}^{a-2} \gamma_{a b} \cdot h_{n-a} f_{m+b}} \tag{3.12}
\end{align*}
$$

respectively, for all $m, n \geq 0$ (in the right-hand sides of the expressions above, we make the convention that $h_{-1}=1$ and $h_{-2}=h_{-3}=\cdots=0$ ).

Finally, to explicitly write down relations (3.3)-(3.4), we observe that

\widetilde{\zeta}^{\mathbb{C}}(z-w)=(z-w)^{2}-\left(t_{1}^{2}+t_{1} t_{2}+t_{2}^{2}\right)-\frac{t_{1} t_{2} t}{z-w}
$$

Therefore, relations (3.3)-(3.4) respectively imply the following for all $m, n \geq 0$

& {\left[e_{n+3}, e_{m}\right]-3\left[e_{n+2}, e_{m+1}\right]+3\left[e_{n+1}, e_{m+2}\right]-\left[e_{n}, e_{m+3}\right]-}  \tag{3.13}\\
& \quad-\left(t_{1}^{2}+t_{1} t_{2}+t_{2}^{2}\right)\left(\left[e_{n+1}, e_{m}\right]-\left[e_{n}, e_{m+1}\right]\right)+t_{1} t_{2} t\left(e_{n} e_{m}+e_{m} e_{n}\right)=0 \\
& {\left[f_{m}, f_{n+3}\right]-3\left[f_{m+1}, f_{n+2}\right]+3\left[f_{m+2}, f_{n+1}\right]-\left[f_{m+3}, f_{n}\right]-}  \tag{3.14}\\
& \quad-\left(t_{1}^{2}+t_{1} t_{2}+t_{2}^{2}\right)\left(\left[f_{m}, f_{n+1}\right]-\left[f_{m+1}, f_{n}\right]\right)+t_{1} t_{2} t\left(f_{m} f_{n}+f_{n} f_{m}\right)=0
\end{align*}
$$

Remark 3.5. To make the connection with geometry completely rigorous, we need to make two small modifications to Definition 3.2. First of all, since all relations (3.3) -(3.7) are symmetric in $t_{1}$ and $t_{2}$, we may define

Y_{t_{1}, t_{2}}\left(\widehat{\mathfrak{g l}}_{1}\right) \text { as a } \mathbb{Z}\left[t_{1}, t_{2}\right]^{\mathrm{sym}} \text {-algebra }
$$

Secondly, we need to ensure that

\begin{equation*}
[x, y] \text { is divisible by } t_{1} t_{2} \tag{3.15}
\end{equation*}
$$

for all $x, y \in Y_{t_{1}, t_{2}}\left(\widehat{\mathfrak{g}}_{1}\right)$. Relations (3.9), (3.11) and (3.12) already imply that any commutator $\left[f_{n}, e_{m}\right],\left[h_{n}, e_{m}\right],\left[f_{m}, h_{n}\right]$ is a multiple of $t_{1} t_{2}$, but relations (3.13), (3.14) are unfortunately not strong enough to imply that the commutators $\left[e_{n}, e_{m}\right]$ and $\left[f_{n}, f_{m}\right]$ are multiples of $t_{1} t_{2}$. Therefore, we must explicitly adjoin the symbols

$$
\begin{equation*}
\frac{\left[e_{n_{1}}, \ldots,\left[e_{n_{k-1}},\left[e_{n_{k}}, e_{n_{k+1}}\right]\right] \ldots\right]}{\left(t_{1} t_{2}\right)^{k}} \text { and } \frac{\left[f_{n_{1}}, \ldots,\left[f_{n_{k-1}},\left[f_{n_{k}}, f_{n_{k+1}}\right]\right] \ldots\right]}{\left(t_{1} t_{2}\right)^{k}} \tag{3.16}
\end{equation*}
$$

to the algebra $Y_{t_{1}, t_{2}}\left(\widehat{\mathfrak{g}}_{1}\right)$, for all $n_{1}, \ldots, n_{k+1} \geq 0$. Naturally, the symbols (3.16) must satisfy the Leibniz rule and Jacobi identities in the natural sense when multiplied or commuted with each other or with the generators $e_{n}, f_{n}, h_{n}$.
3.6. For a smooth algebraic variety $X$ over $\mathbb{C}$, its cohomology

$$
\begin{equation*}
H_{X}=H^{*}(X, \mathbb{Z}) \tag{3.17}
\end{equation*}
$$

will refer to the singular cohomology ring with integer coefficients. However, all results in the present Section also hold for other cohomology theories, such as Borel-Moore homology or Chow rings. In fact, the only properties of cohomology that we will need is the existence of pull-back maps for local complete intersection morphisms, push-forward maps for proper morphisms, and Chern classes

\begin{equation*}
c_{i}(\mathcal{V}) \in H_{X} \tag{3.18}
\end{equation*}

for any locally free sheaf $\mathcal{V}$ on $X$. These may be assembled in the Chern polynomial

$$
c(\mathcal{V}, z)=\sum_{i=0}^{v} z^{v-i}(-1)^{i} c_{i}(\mathcal{V}) \in H_{X}[z]
$$

where $v=\operatorname{rank} \mathcal{V}$. The Chern polynomial only depends on the $K$-theory class of $\mathcal{V}$. This means that if we have a short exact sequence of coherent sheaves

0 \rightarrow \mathcal{W} \rightarrow \mathcal{V} \rightarrow \mathcal{E} \rightarrow 0 \tag{3.19}
\end{equation*}

with $\mathcal{V}, \mathcal{W}$ locally free of ranks $v, w$, then we may define

c(\mathcal{E}, z)=\frac{c(\mathcal{V}, z)}{c(\mathcal{W}, z)}
$$

The expression above does not depend on the choice of short exact sequence (3.19), so it allows one to unambiguosly define the Chern classes of $\mathcal{E}$ itself by

c(\mathcal{E}, z)=\sum_{i=0}^{\infty} z^{v-w-i}(-1)^{i} c_{i}(\mathcal{E}) \in H_{X}\left(\left(z^{-1}\right)\right)
$$

We will also encounter equivariant cohomology in the present paper. For a smooth algebraic variety $X$ endowed with an action of a torus $T$, the ring

$$
H_{T}^{*}(X)
$$

enjoys the same functoriality properties as usual cohomology (3.17). The two main differences between these two rings is that equivariant cohomology is an algebra over the polynomial ring

$$
H_{T}^{*}(\text { point })=\mathbb{Z}[\operatorname{Lie}(T)]
$$

and that the grading $*$ is not bounded above by the real dimension of $X$ anymore (for instance, the grading on $H_{T}^{*}$ (point) has linear functions on $\operatorname{Lie}(T)$ in degree 2).
3.7. All the geometric operators that we will define in the present paper are given by correspondences. In the most general form of this concept, a correspondence between smooth projective algebraic varieties $X$ and $Y$ is a class

\Gamma \in H_{X \times Y}
$$

which induces the operator

$$
\Phi_{\Gamma}: H_{Y} \xrightarrow{p_{Y}^{*}} H_{X \times Y} \xrightarrow{\smile \Gamma} H_{X \times Y} \xrightarrow{p_{X *}} H_{X}
$$

where $p_{X}: X \times Y \rightarrow X$ and $p_{Y}: X \times Y \rightarrow Y$ denote the standard projections. There is a natural notion of composition of correspondences (whose exact definition we leave as an exercise to the reader)

$$
\left(\Gamma, \Gamma^{\prime}\right) \in H_{X \times Y} \times H_{Y \times Z} \quad \rightsquigarrow \quad \Gamma \circ \Gamma^{\prime} \in H_{X \times Z}
$$

such that

$$
\Phi_{\Gamma} \circ \Phi_{\Gamma^{\prime}}=\Phi_{\Gamma \circ \Gamma^{\prime}}
$$

With this in mind, we observe that while all the results in the present paper are stated as equalities of compositions of the various operators $\Phi_{\Gamma}$, this is only for convenience. In fact, all our results hold as equalities of compositions of correspondences $\Gamma$. This is important from a technical point of view, since the assignment

$$
\begin{equation*}
\Gamma \rightsquigarrow \Phi_{\Gamma} \tag{3.20}
\end{equation*}
$$

is only injective for cohomology theories which satisfy the Künneth decomposition

$$
H_{X \times Y} \cong H_{X} \otimes H_{Y}
$$

and the non-degeneracy of the intersection pairing (which even in the context of singular cohomology holds only after tensoring with $\mathbb{Q}$, but in other situations such as Chow groups fails entirely). Therefore, for general cohomology theories, proving an identity between correspondences $\Gamma$ is a strictly stronger statement than the analogous identity between the operators $\Phi_{\Gamma}$.
3.8. In the present Subsection, we will consider equivariant cohomology with respect to the torus $T=\mathbb{C}^{*} \times \mathbb{C}^{*}$. In particular, we have

H_{T}^{*}(\text { point })=\mathbb{Z}\left[t_{1}, t_{2}\right]
$$

where $t_{1}, t_{2}$ are the standard coordinates on the Lie algebra of $T$. Recall the moduli space of framed sheaves of Subsection 2.5, and consider its equivariant cohomology

$$
H_{\mathcal{M}_{\mathbb{A}^{2}}}=H_{T}^{*}\left(\mathcal{M}_{\mathbb{A}^{2}}\right)=\bigoplus_{n=0}^{\infty} H_{T}^{*}\left(\mathcal{M}_{\mathbb{A}^{2}, n}\right)
$$

Recall the (natural analogue in the context of moduli spaces of framed sheaves of the) correspondence $\mathfrak{Z}$ of (2.7). Define operators

$$
e_{n}, f_{n}, h_{n}: H_{\mathcal{M}_{\mathbb{A}^{2}}} \rightarrow H_{\mathcal{M}_{\mathbb{A}^{2}}}
$$

for all $n \geq 0$ by the following formulas

$$
\begin{align*}
& e_{n}=t_{1} t_{2} \cdot \pi_{+*}\left(\ell^{n} \cdot \pi_{-}^{*}\right)  \tag{3.21}\\
& f_{n}=t_{1} t_{2} \cdot \pi_{-*}\left(\ell^{n}(-1)^{r} \cdot \pi_{+}^{*}\right) \tag{3.22}
\end{align*}
$$

where $\ell=c_{1}(\mathcal{L})$ is the first Chern class of the tautological line bundle (2.10), and

$$
\begin{equation*}
h(z)=1+\sum_{n=0}^{\infty} \frac{h_{n}}{z^{n+1}}=\text { cup product with } \frac{c\left(\mathcal{U}_{0}, z+t\right)}{c\left(\mathcal{U}_{0}, z\right)} \tag{3.23}
\end{equation*}
$$

where $\mathcal{U}_{\circ}$ denotes the restricted universal sheaf (2.13), and $t=t_{1}+t_{2}$.

Remark 3.9. Although the prefactor $t_{1} t_{2}$ in (3.21) and (3.22) might seem strange, it was chosen so that $e_{n}$ equals the composition

$$
H_{\mathcal{M}_{\mathbb{A}^{2}}} \xrightarrow{\left(\pi_{+} \times \pi_{\mathbb{A}^{2}}\right)_{*}\left(\ell^{n} \cdot \pi_{-}^{*}\right)} H_{\mathcal{M}_{\mathbb{A}^{2}} \times \mathbb{A}^{2}} \xrightarrow{\text { lo }} H_{\mathcal{M}_{\mathbb{A}^{2}}}
$$

where $\left.\right|_{\circ}$ denotes restriction to the origin of $\mathbb{A}^{2}$ (and similarly for the $f$ operators). This point of view will lead into the case of general surfaces $S$ in the next Subsection.

The connection between the abstract Yangian of Definition 3.2 and the operators above is the following result (see [16, Theorem 3.8] for notation closer to ours).

Theorem 3.10. (the version of [21] for the Lie algebra $\widehat{\mathfrak{g l}}_{1}$ ) For any $r$, the operators (3.21), (3.22), (3.23) satisfy relations (3.3) -(3.7), thus yielding an action

$$
Y_{t_{1}, t_{2}}\left(\hat{\mathfrak{g l}}_{1}\right) \curvearrowright H_{\mathcal{M}_{\mathbb{A}^{2}}}
$$

3.11. We will now consider the case of general smooth projective surfaces $S$, and the moduli spaces of stable sheaves studied in Subsection 2.1. Let us fix $\left(r, c_{1}\right) \in$ $\mathbb{N} \times H^{2}(S, \mathbb{Z})$ satisfying Assumptions A and S (from (2.3) and (2.5), respectively) and consider the singular cohomology with integer coefficients

$$
H_{\mathcal{M} \times S^{k}}=\bigoplus_{c_{2} \in \mathbb{Z}} H_{\mathcal{M}_{\left(r, c_{1}, c_{2}\right)} \times S^{k}}
$$

for any $k \geq 0$. Due to Bogomolov's inequality (2.1), the direct summands above are zero for $c_{2}$ small enough. Recall the variety $\mathfrak{Z}$ of (2.7), and define the operators

$$
\begin{align*}
& e_{n}=\left(\pi_{+} \times \pi_{S}\right)_{*}\left(\ell^{n} \cdot \pi_{-}^{*}\right): H_{\mathcal{M}} \rightarrow H_{\mathcal{M} \times S}  \tag{3.24}\\
& f_{n}=\left(\pi_{-} \times \pi_{S}\right)_{*}\left(\ell^{n}(-1)^{r} \cdot \pi_{+}^{*}\right): H_{\mathcal{M}} \rightarrow H_{\mathcal{M} \times S} \tag{3.25}
\end{align*}
$$

for all $n \geq 0$, where $\ell=c_{1}(\mathcal{L})$. We will also encounter the composition

$$
\begin{equation*}
h(z)=1+\sum_{n=0}^{\infty} \frac{h_{n}}{z^{n+1}}: H_{\mathcal{M}} \xrightarrow{\text { pull-back }} H_{\mathcal{M} \times S} \xrightarrow{\smile \frac{c(\mathcal{U}, z+t)}{c(\mathcal{U}, z)}} H_{\mathcal{M} \times S} \tag{3.26}
\end{equation*}
$$

where we let $t=c_{1}\left(\mathcal{K}_{S}\right)$. Combine the operators (3.24) and (3.25) into power series

$$
\begin{align*}
& e(z)=\sum_{n=0}^{\infty} \frac{e_{n}}{z^{n+1}}=\left(\pi_{+} \times \pi_{S}\right)_{*}\left(\frac{1}{z-\ell} \cdot \pi_{-}^{*}\right)  \tag{3.27}\\
& f(z)=\sum_{n=0}^{\infty} \frac{f_{n}}{z^{n+1}}=\left(\pi_{-} \times \pi_{S}\right)_{*}\left(\frac{(-1)^{r}}{z-\ell} \cdot \pi_{+}^{*}\right) \tag{3.28}
\end{align*}
$$

3.12. We are now ready for the main result of the present Subsection, which describes the commutation relations between the operators $e_{n}, f_{n}, h_{n}$. We will find that these relations look best when expressed in terms of the series $e(z), f(z), h(z)$. This will involve the square $S \times S$ of our surface; we choose to color the two factors of $S$ in red and blue, to make it easier to keep track of them in our formulas. Let

$$
\begin{equation*}
\zeta^{\mathrm{coh}}(x)=1+\frac{[\Delta]}{x(x+t)} \in H_{S \times S}(x) \tag{3.29}
\end{equation*}
$$

where $[\Delta] \in H_{S \times S}$ is the class of the diagonal, and

$$
\begin{equation*}
\widetilde{\zeta}_{ \pm}^{\text {coh }}(x)=\zeta(x)(x \pm t)(x \mp t) \in \frac{H_{S \times S}[x]}{x} \tag{3.30}
\end{equation*}
$$

where $t$ and $t$ denote the pull-backs of the class $t=c_{1}\left(\mathcal{K}_{S}\right)$ to $H_{S \times S}$ via the first and second projection, respectively. In (3.29), the symbol $t$ in the denominator denotes either $t$ or $t$; it does not matter which due to the presence of $[\Delta]$.

Let us consider any operators $x, y: H_{\mathcal{M}} \rightarrow H_{\mathcal{M} \times S}$, for example (3.24), (3.25) and the coefficients of (3.26). We may form the following two compositions

$$
\begin{align*}
& x y: H_{\mathcal{M}} \xrightarrow{y} H_{\mathcal{M} \times S} \xrightarrow{x \boxtimes \mathrm{Id}_{S}} H_{\mathcal{M} \times S \times S}  \tag{3.31}\\
& y x: H_{\mathcal{M}} \xrightarrow{x} H_{\mathcal{M} \times S} \xrightarrow{y \boxtimes \mathrm{Id}_{S}} H_{\mathcal{M} \times S \times S} \tag{3.32}
\end{align*}
$$

The colors of the operators will always match the color of the factor of $S \times S$ in which they operate. We will write

$$
[x, y]=x y-y x
$$

and we let $\Delta: S \hookrightarrow S \times S$ denote the diagonal.
Theorem 3.13. We have the following equalities of operators $H_{\mathcal{M}} \rightarrow H_{\mathcal{M} \times S \times S}$

{\left[e(z) e(w) \widetilde{\zeta}_{-}^{\mathrm{coh}}(w-z)\right]_{z<0, w<0}=\left[e(w) e(z) \widetilde{\zeta}_{+}^{\mathrm{coh}}(z-w)\right]_{z^{<0}, w^{<0}}}  \tag{3.33}\\
{\left[f(w) f(z) \widetilde{\zeta}_{-}^{\mathrm{coh}}(w-z)\right]_{z<0, w<0}=\left[f(z) f(w) \widetilde{\zeta}_{+}^{\mathrm{coh}}(z-w)\right]_{z<0, w<0}}  \tag{3.34}\\
h(z) e(w)=\left[e(w) h(z) \frac{\zeta^{\mathrm{coh}}(z-w)}{\zeta^{\mathrm{coh}}(w-z)}\right]_{z \gg w \mid z \leq 0, w^{<0}}  \tag{3.35}\\
f(w) h(z)=\left[h(z) f(w) \frac{\zeta^{\mathrm{coh}}(z-w)}{\zeta^{\mathrm{coh}}(w-z)}\right]_{z \gg w \mid z \leq 0, w<0}  \tag{3.36}\\
{[f(z), e(w)]=\frac{1}{t} \cdot \Delta_{*}\left(\frac{h(z)-h(w)}{z-w}\right)} \tag{3.37}
\end{gather*}
$$

as well as $[h(z), h(w)]=0$. The meaning of all the square brackets is exactly the same as in Definition 3.2. The class $t$ in the denominator of (3.37) does not pose an issue because all $h_{n}$ with $n>0$ are multiples of $t$, as is clear from (3.26).

The proof of the Theorem above closely follows that of the upcoming Theorem 4.11 in $K$-theory, and the former can actually be deduced from the latter via the Chern character isomorphism. We will therefore leave Theorem 3.13 to the reader.
3.14. In the remainder of the present Section, we will compare Theorem 3.10 with Theorem 3.13. On one hand, the former is the version of the latter when $S=\mathbb{A}^{2}$, stable sheaves are replaced by framed sheaves, and one works with equivariant cohomology (specifically, the operators (3.21), (3.22), (3.23) are obtained by composing the operators (3.24), (3.25), (3.26) with the restriction map to the origin

$$
H_{\mathcal{M} \times \mathbb{A}^{2}} \xrightarrow{\frac{10}{}} H_{\mathcal{M}}
$$

which is an isomorphism). However, the more general Theorem 3.13 can also be construed as saying that "the Yangian acts on $H_{\mathcal{M}}$ " for a general surface $S$, although care must be taken to properly formulate what this means. This will be the goal of the remainder of the present Section, and we will start by showing how to unravel relations (3.33)-(3.37). We start with (3.37), whose $z^{-n-1} w^{-m-1}$ coefficient reads

$$
\begin{equation*}

Remark 3.15. If one works with cohomology with rational coefficients instead of integer coefficients (i.e. assume that $H_{X}$ is defined as $H^{*}(X, \mathbb{Q})$ in this Remark only), one may use the Künneth decomposition

In this case, (3.38) is equivalent to the following equality of operators $H_{\mathcal{M}} \rightarrow H_{\mathcal{M}}$

While formulas such as (3.39) are used more commonly in the literature, we prefer formula (3.38) because its holds for cohomology theories without Künneth decompositions, such as Chow groups.
3.16. Let us now unravel relations (3.35) and (3.36). We start by noting that

as the one we already encountered in (3.10). The Chern classes above arise because $t=t_{1}+t_{2}$ and because of the identity $[\Delta][\Delta]=t_{1} t_{2}[\Delta]$ in $H_{S \times S}$. Thus, relations (3.35) and (3.36) take the following form, for all $m, n \geq 0$
(in the right-hand sides above, we make the convention that $h_{-1}$ is the pull-back map and $h_{-2}=h_{-3}=\cdots=0$ ). Compare the formulas above with (3.11)-(3.12).

As for formulas (3.33)-(3.34), let us first observe that

3.17. We have phrased relations (3.38), (3.40), (3.41), (3.42), (3.43) as equalities of compositions of operators, but it is better if one regards them as equalities of correspondences in $\mathcal{M} \times \mathcal{M} \times S \times S$, in the language of Subsection 3.7 For example,

as stated in Theorem 1.2 The main novelty behind the geometric notion of action in Definition 3.19 is that the commutator and product of operators are objects of a different nature: the former is an operator $H_{\mathcal{M}} \rightarrow H_{\mathcal{M} \times S \times S}$ and the latter is an operator $H_{\mathcal{M}} \rightarrow H_{\mathcal{M} \times S}$. However, if we restrict to operators $a, b: H_{\mathcal{M}} \rightarrow H_{\mathcal{M} \times S}$ with diagonal commutator, then

## 4. $K$-THEORY

4.1. In the present Section, we will present trigonometric/ $K$-theoretic versions of the rational/cohomological constructions in the previous Section. We will work over the ring of Laurent polynomials in two variables $q_{1}$ and $q_{2}$, which should be interpreted as the exponentials of the parameters $t_{1}$ and $t_{2}$ from Subsection 3.1 Let $q=q_{1} q_{2}$ and consider the rational functions

(where $\delta(x)=\sum_{n=-\infty}^{\infty} x^{n}$ ), as well as $\left[h^{ \pm}(z), h^{ \pm^{\prime}}(w)\right]=0$ for all $\pm, \pm^{\prime} \in\{+,-\}$.
In formulas (4.3)-(4.4), we cancel out the factor $z-w$ from the denominator and equate the coefficients of all $\left\{z^{a} w^{b}\right\}_{a, b \in \mathbb{Z}}$ in the left and right-hand sides. In the next two formulas (4.5)-(4.6), we expand the rational function in the RHS in nonnegative powers of $w^{ \pm 1} / z^{ \pm 1}$, and equate the coefficients of all $\left\{z^{a} w^{b}\right\}_{ \pm a \in \mathbb{Z}_{\leq 0}, b \in \mathbb{Z}}$ in the left and right-hand sides. Finally, in the last formula (4.7), we simply equate the coefficients of all $\left\{z^{a} w^{b}\right\}_{a, b \in \mathbb{Z}}$ in the left and right-hand sides.

Remark 4.3. Definition 4.2 is the original one of Ding-Iohara (3]). Similarly with Remark 3.3, it is customary to impose the additional cubic relations

in $U_{q_{1}, q_{2}}\left(\ddot{\mathfrak{g}} \mathfrak{l}_{1}\right)$, for all $n_{1}, n_{2}, n_{3} \in \mathbb{Z}$. This was the approach of Miki ( $\left.[12]\right)$, who imposed the particular case of the cubic relations (4.8) for $n_{1}=n_{2}=n_{3}$ (the more general versions of relations (4.8) appeared in [20], and they actually follow from the particular cases studied by Miki and (4.3)-(4.7)). While we will not consider the cubic relations in the present paper for brevity, we observe that they do indeed hold in all the modules of geometric nature considered in the present paper, namely the K-theory groups of moduli spaces of stable/framed sheaves (as shown in [18]).
4.4. Let us unpack the relations in Definition4.2. The easiest is (4.7), which states

for various Laurent polynomials $\gamma_{a}^{ \pm}$in $q=q_{1} q_{2}$ and $q_{1}+q_{2}$. The fact that we can extract a factor of $\left(1-q_{1}\right)\left(1-q_{2}\right)$ from the coefficients in the right-hand side of (4.10) will be very important for our geometric constructions in the later Subsections, and
it is due to the fact that the left-hand side of (4.10) is equal to 1 when either $q_{1}=1$ or when $q_{2}=1$. Therefore, relations (4.5)-(4.6) read

& {\left[f_{m}, h_{n}^{ \pm}\right]=\left(1-q_{1}\right)\left(1-q_{2}\right) \sum_{a=1}^{n} \gamma_{a}^{ \pm} \cdot h_{n-a}^{ \pm} f_{m \pm a}} \tag{4.12}
\end{align*}

for all $m \in \mathbb{Z}, n \geq 0$. Finally, to unpack relations (4.3)-(4.4), we observe that

Although we will not include this explicitly in our notation in order to not overburden it, we note that future connections with geometry require us to make the following two modifications to quantum toroidal $\mathfrak{g l}_{1}$, by analogy with Remark 3.5

- $U_{q_{1}, q_{2}}\left(\ddot{\mathfrak{g}}_{1}\right)$ should be defined over $\mathbb{Z}\left[q_{1}^{ \pm 1}, q_{2}^{ \pm 1}\right]^{\text {sym }}$ instead of over $\mathbb{Z}\left[q_{1}^{ \pm 1}, q_{2}^{ \pm 1}\right]$
- for any $x, y \in U_{q_{1}, q_{2}}\left(\ddot{g}_{1}\right)$,

The way to achieve this is to formally adjoin the symbols

to $U_{q_{1}, q_{2}}\left(\ddot{g l}_{1}\right)$, for all $n_{1}, \ldots, n_{k+1} \in \mathbb{Z}$, and impose the natural Leibniz rules and Jacobi identities between these new symbols and the old generators $e_{n}, f_{n}, h_{m}^{ \pm}$.
4.5. Given a smooth algebraic variety $X$ over $\mathbb{C}$, its ( 0 -th) algebraic $K$-theory group is defined as

Algebraic $K$-theory is a ring with respect to tensor product, and it possesses pullbacks (for general maps) and push-forwards (for proper maps of smooth varieties).

Remark 4.6. One can regard $X$ as a manifold and replace algebraic $K$-theory by topological K-theory, simply by changing "locally free sheaf" with "vector bundle" in (4.16). All the results in the present Section hold in the topological setup as well.

In $K$-theory, the role of the Chern classes (3.18) is played by the exterior powers

If a smooth variety $X$ is endowed with an action of a torus $T$, then we may define its equivariant $K$-theory

Indeed, any one-dimensional representation $\chi$ of $T$ can be tensored with an arbitrary $T$-equivariant locally free sheaf $\mathcal{V}$; the resulting $\chi \otimes \mathcal{V}$ is isomorphic to $\mathcal{V}$ as a locally free sheaf, but not as a $T$-equivariant locally free sheaf. The aforementioned module structure is therefore given by $\chi \cdot[\mathcal{V}]=[\chi \otimes \mathcal{V}]$. Finally, note that the formalism of correspondences from Subsection 3.7 holds equally well in $K$-theory (be it equivariant or not) simply by replacing $H$ with $K$ everywhere.
4.7. In the present Subsection, we will consider $K$-theory equivariant with respect to the torus $T=\mathbb{C}^{*} \times \mathbb{C}^{*}$. Therefore, we have

where $L=[\mathcal{L}]$ denotes the $K$-theory class of the tautological line bundle (2.10), and $\mathcal{U}_{\circ}$ is the restricted universal sheaf (2.13). Moreover, let $q=q_{1} q_{2}$ and consider

where the right-hand side is expanded in powers of $z^{\mp 1}$. The connection between the quantum toroidal $\mathfrak{g l}_{1}$ of Definition 4.2 and the operators above is the following.

Thus, we will fix $\left(r, c_{1}\right) \in$ $\mathbb{N} \times H^{2}(S, \mathbb{Z})$ satisfying Assumptions A and $\mathrm{S}($ from (2.3) and (2.5)) and consider

for any $k \geq 0$. Due to Bogomolov's inequality (2.1), the direct summands above are zero for $c_{2}$ small enough. Recall the variety $\mathfrak{Z}$ of (2.7), and define the operators

While $q_{1}$ and $q_{2}$ are not themselves elements of $K_{S}$, any symmetric polynomial in them is a well-defined element in $K_{S}$. We are now ready to give the commutation relations between the operators $e_{n}, f_{n}, h_{m}^{ \pm}$. We will find that these relations look best when expressed in terms of the series $e(z), f(z), h^{ \pm}(z)$. As in Subsection 3.12, let us color the factors of $S \times S$ in red and blue, and use the notation $q$ and $q$ for the pull-back of the class $q$ from either one of the factors to $S \times S$. Consider

In (4.29), the symbol $q$ in the denominator denotes either $q$ or $q$; it does not matter which due to the presence of $\left[\mathcal{O}_{\Delta}\right]$. All the operators $e_{n}, f_{n}, h_{m}^{ \pm}$of (4.23), (4.24), 4.25) pairwise have diagonal commutator, and the notion of an action analogous to Definition 3.19

$$
\begin{equation*}
U_{q_{1}, q_{2}}\left(\ddot{\left.\mathfrak{g} \mathfrak{l}_{1}\right) \curvearrowright K_{\mathcal{M}}}\right. \tag{4.44}
\end{equation*}
$$

is well-defined (the only modification we need to make is that (3.48) must read

$$
[\Phi(x), \Phi(y)]_{\mathrm{red}}=\Phi\left(\frac{[x, y]}{\left(1-q_{1}\right)\left(1-q_{2}\right)}\right)
$$

Note that the right-hand side is well-defined because of (4.15)). Then Theorem 4.11 precisely states that the operators (4.23), (4.24), (4.25) yield an action (4.44), which is the content of Theorem 1.4

## 5. Elliptic cohomology

5.1. In the present Section, we will recall the elliptic cohomology of smooth varieties over $\mathbb{C}$ and elliptic quantum groups, and connect these two notions by proving analogues of Theorems 3.13 and 4.11. Given a smooth algebraic variety $X$, recall that its cohomology $H_{X}$ is a ring endowed with a Chern polynomial

$$
\begin{equation*}
c(\mathcal{V}, z)=\left(z-\ell_{1}\right) \ldots\left(z-\ell_{r}\right) \in H_{X}[z] \tag{5.1}
\end{equation*}
$$

for any rank $r$ locally free sheaf $\mathcal{V}$ on $X$. The symbols $\ell_{1}, \ldots, \ell_{r}$ are called the Chern roots of $\mathcal{V}$, and while they are not individually well-defined, any symmetric polynomial in $\ell_{1}, \ldots, \ell_{r}$ is a well-defined element of $H_{X}$. In other words, specifying the Chern polynomial of $\mathcal{V}$ is tantamount to specifying the ring homomorphism

$$
\mathbb{C}\left[x_{1}, \ldots, x_{r}\right]^{\mathrm{Sym}} \longrightarrow H_{X}
$$

determined by $x_{i} \mapsto \ell_{i}$. Dually, this amounts to a map of schemes

$$
\operatorname{Spec}\left(H_{X}\right) \rightarrow\left(\mathbb{A}^{1}\right)^{(r)}
$$

Above, $C^{(r)}$ denotes the $r$-th symmetric power of any algebraic curve $C$, whose closed points are unordered $r$-tuples of closed points of $C$. The situation of $K$ theory is analogous to that of cohomology, except that we replace $\mathbb{A}^{1}$ by $\mathbb{A}^{1} \backslash\{0\}$.

Definition 5.2. ([8]) Let $E$ be an elliptic curve over $\mathbb{C}$. The ( 0 -th) elliptic cohomology associated to $E$ is a contravariant functor

$$
\begin{equation*}
(\text { smooth varieties over } \mathbb{C}) \xrightarrow{X \mapsto \mathrm{Ell}_{X}} \quad \text { Commutative rings } \tag{5.2}
\end{equation*}
$$

The (total) Chern class of a rank r locally free sheaf $\mathcal{V}$ is a map of schemes

$$
\begin{equation*}
\operatorname{Spec}\left(\operatorname{Ell}_{X}\right) \xrightarrow{c_{\mathcal{L}}} E^{(r)} \tag{5.3}
\end{equation*}
$$

satisfying the following properties with respect to direct sums and tensor products

for any locally free sheaves $\mathcal{V}, \mathcal{V}^{\prime}$ of ranks $r, r^{\prime}$, respectively. In the diagrams above, the vertical arrows are the maps given in terms of closed points by

$$
\begin{gather*}
\left(x_{1}, \ldots, x_{r}\right) \oplus\left(y_{1}, \ldots, y_{r^{\prime}}\right)=\left(x_{1}, \ldots, x_{r}, y_{1}, \ldots, y_{r^{\prime}}\right)  \tag{5.4}\\
\left(x_{1}, \ldots, x_{r}\right) \otimes\left(y_{1}, \ldots, y_{r^{\prime}}\right)=\left(\ldots, x_{i} y_{j}, \ldots\right)_{1 \leq i \leq r, 1 \leq j \leq r^{\prime}} \tag{5.5}
\end{gather*}
$$

The reason why $E$ has to be an elliptic curve is the presence of the group law of $E$ in the formula for the map $\otimes$ in (5.5). It is also why $\mathbb{A}^{1}$ (with the additive group law) and $\mathbb{A}^{1} \backslash 0$ (with the multiplicative group law) arise in the situations of cohomology and $K$-theory, respectively.
5.3. As explained in [8], the fact that the target of (5.3) is not affine is one of the reasons one would use the scheme

$$
A_{X}=\operatorname{Spec}\left(\operatorname{Ell}_{X}\right)
$$

in order to encode elliptic cohomology (this is all the more because of the analogous situation of $T$-equivariant cohomology for a torus $T=\left(\mathbb{C}^{*}\right)^{k}$, in which case the analogue of $E l_{X}$ is a sheaf of commutative rings over $E^{k}$, and thus the analogue of $A_{X}$ is an affine-over-projective scheme). The contravariance of the functor (5.2) entails the existence of a ring homomorphism

$$
f^{*}: \operatorname{Ell}_{Y} \rightarrow \operatorname{Ell}_{X}
$$

or dually, a map of schemes

$$
\tilde{f}: A_{X} \rightarrow A_{Y}
$$

for any morphism $f: X \rightarrow Y$. As a consequence of the axioms developed in [8], for any rank $r$ vector bundle $\mathcal{V}$ on $X$, the elliptic cohomology of the projective bundle

$$
\mathbb{P}_{X}(\mathcal{V})=\operatorname{Proj}_{X}\left(\operatorname{Sym}^{\bullet} \mathcal{V}\right) \xrightarrow{\pi} X
$$

has the property that the following square is Cartesian


Composing the top arrow above with projection to the first factor yields a map $A_{\mathbb{P}_{X}(\mathcal{V})} \rightarrow E$, which is none other than $c_{\mathcal{O}(1)}$. Formula (5.6) is the scheme version of the well-known isomorphism in ordinary cohomology

$$
H_{\mathbb{P}_{X}(\mathcal{V})} \cong H_{X}[z] / c(\mathcal{V}, z)
$$

5.4. Ordinary cohomology classes are elements of $H_{X}$, or equivalently, functions on $\operatorname{Spec}\left(H_{X}\right)$. Meanwhile, elliptic cohomology classes are more naturally construed as sections of line bundles on $A_{X}$. The prime example of this comes from the map (5.3): there are no non-constant functions on $E^{(r)}$, but there are plenty of meromorphic functions (i.e. sections of line bundles) on $E^{(r)}$. Pulling back the aforementioned meromorphic functions via $c_{\mathcal{V}}$ naturally yields sections of line bundles on $A_{X}$, or in other words, elements of locally free rank 1 modules over $E l_{X}$.

Remark 5.5. If one works over $\mathbb{C}$, the ring $\mathrm{Ell}_{X}$ is Artinian for any smooth variety $X$, so any locally free rank 1 module is isomorphic to $\mathrm{Ell}_{X}$. However, there is no canonical choice of such an isomorphism; this means that while any elliptic cohomology class can be construed as an element in $\mathrm{Ell}_{X}$ "up to a unit", there is no canonical choice for this unit. Therefore, it is still beneficial to think of elliptic cohomology classes as sections of line bundles on $A_{X}$, and not functions on $A_{X}$.

We will now explicitly recall theta functions, which are sections of line bundles on the elliptic curve $E$. To do this, let us consider the multiplicative presentation

$$
E=\mathbb{C}^{*} / p^{\mathbb{Z}}
$$

where $p$ is a complex number with $0<|p|<1$ (in the more common presentation $E=\mathbb{C} /(\mathbb{Z} \oplus \mathbb{Z} \tau)$, we have $\left.p=e^{2 \pi i \tau}\right)$. Then for any pair $(n, \lambda) \in \mathbb{Z} \times \mathbb{C}^{*}$, which we will refer to as factors of automorphy, we may define the line bundle

$$
\mathcal{D}_{n, \lambda}=\left\{\text { meromorphic functions } f(z) \text { on } \mathbb{C}^{*}, \text { such that } \frac{f(z)}{f(z p)}=z^{n} \lambda, \forall z \in \mathbb{C}^{*}\right\}
$$

on $E$. It is easy to see that multiplication of functions induces an isomorphism

$$
\mathcal{D}_{n, \lambda} \otimes \mathcal{D}_{m, \mu} \xrightarrow{\sim} \mathcal{D}_{n+m, \lambda \mu}
$$

for all $n, m \in \mathbb{Z}$ and $\lambda, \mu \in \mathbb{C}^{*}$, and that $\mathcal{D}_{0,1}$ is the trivial line bundle. In particular, for all $k \in \mathbb{Z}$, multiplication by $z^{k}$ induces an isomorphism

$$
\mathcal{D}_{n, \lambda} \xrightarrow{\sim} \mathcal{D}_{n, \lambda p^{-k}}
$$

We will interpret the expressions $z^{k}$ as sections of the different (albeit isomorphic) line bundles $\mathcal{D}_{0, p^{-k}}$ on $E$. We will refer to $z$ as the standard coordinate on $E$, although as explained in the preceding sentence, this is an abuse of terminology.

Proposition 5.6. The Jacobi theta function

$$
\begin{equation*}
\vartheta(z)=(1-z) \prod_{s=1}^{\infty} \frac{\left(1-p^{s} z\right)\left(1-p^{s} z^{-1}\right)}{\left(1-p^{s}\right)^{2}} \tag{5.7}
\end{equation*}
$$

is a section of $\mathcal{D}_{1,-1}$.

The non-standard choice of normalization in (5.7) is due to the fact that it ensures

$$
\begin{equation*}
\left.\vartheta(z)\right|_{p=0}=1-z \tag{5.8}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Res}_{z=1} \frac{1}{\vartheta(z)}=-1 \tag{5.9}
\end{equation*}
$$

Proposition 5. 5 above is an immediate consequence of the simple identity

$$
\begin{equation*}
\vartheta(z p)=-\frac{\vartheta(z)}{z} \quad \Leftrightarrow \quad \vartheta\left(\frac{z}{p}\right)=-\frac{z \vartheta(z)}{p} \tag{5.10}
\end{equation*}
$$

More generally, for any $x_{1}, \ldots, x_{n}, y_{1}, \ldots, y_{m} \in \mathbb{C}^{*}$, the ratio

$$
\begin{equation*}
\frac{\vartheta\left(z x_{1}\right) \ldots \vartheta\left(z x_{n}\right)}{\vartheta\left(z y_{1}\right) \ldots \vartheta\left(z y_{m}\right)} \tag{5.11}
\end{equation*}
$$

is a global section of $\mathcal{D}_{n-m,(-1)^{n-m} \frac{x_{1} \ldots x_{n}}{y_{1} \ldots y_{m}}}$. Finally, we point out the formula

$$
\begin{equation*}
\vartheta\left(z^{-1}\right)=-z^{-1} \vartheta(z) \tag{5.12}
\end{equation*}
$$

5.7. Non-trivial line bundles (which we will refer to as "twists") arise in elliptic cohomology when defining push-forwards. To see this, if $\iota: X \hookrightarrow Y$ is the zero locus of a regular section of a rank $r$ locally free sheaf $\mathcal{V}$ on $Y$, then we have

$$
\iota_{*}(1)=\ell_{1} \ldots \ell_{r} \in H_{Y}
$$

in usual cohomology, where $\ell_{1}, \ldots, \ell_{r}$ are the Chern roots of $\mathcal{V}$. Similarly, we have

$$
\iota_{*}(1)=\left(1-L_{1}^{-1}\right) \ldots\left(1-L_{r}^{-1}\right) \in K_{Y}
$$

in $K$-theory, where we formally decompose [ $\mathcal{V}$ ] as a sum of line bundles $L_{1}+\cdots+L_{r}$ 5. Generalizing the formula above, we would like to have in elliptic cohomology

$$
\begin{equation*}
" \iota_{*}(1)=\vartheta\left(L_{1}^{-1}\right) \ldots \vartheta\left(L_{r}^{-1}\right) \in \text { Ell }_{Y} " \tag{5.13}
\end{equation*}
$$

However, $L_{1}, \ldots, L_{r}$ here should be interpreted as the pull-backs under $c_{\mathcal{V}}$ of the standard coordinates on $E^{(r)}$. Therefore, the right-hand side of (5.13) should be interpreted not as a function on $A_{Y}=\operatorname{Spec}\left(\mathrm{Ell}_{Y}\right)$, but as the section

$$
\vartheta\left(\mathcal{V}^{\vee}\right):=\vartheta\left(L_{1}^{-1}\right) \ldots \vartheta\left(L_{r}^{-1}\right)
$$

of the following line bundle on $A_{Y}$

$$
\Theta(\mathcal{V}):=c_{\mathcal{V} \vee}^{*}\left(\left(\mathcal{D}_{1,-1} \boxtimes \cdots \boxtimes \mathcal{D}_{1,-1}\right)^{\mathrm{sym}}\right)
$$

(in the right-hand side, we descend the tensor product of the line bundles of Proposition 5.6 from the $r$ factors of $E^{r}$ to a line bundle on $\left.E^{(r)}\right)$. Note that our $\Theta(\mathcal{V})$ is actually $\Theta\left(-\mathcal{V}^{\vee}\right)$ in the notation of [8].

[^4]Proposition 5.8. For any $\mathcal{V}, \mathcal{W}$, there is an isomorphism of line bundles

$$
\Theta(\mathcal{V} \oplus \mathcal{W}) \cong \Theta(\mathcal{V}) \otimes \Theta(\mathcal{W})
$$

Therefore, there exists a group homomorphism

$$
\begin{gather*}
K_{Y} \xrightarrow{\Theta} \operatorname{Pic}\left(A_{Y}\right) \\
\Theta(\mathcal{V}-\mathcal{W})=\Theta(\mathcal{V}) \otimes \Theta(\mathcal{W})^{-1} \tag{5.14}
\end{gather*}
$$

Moreover, the line bundle (5.14) has the section

$$
\vartheta\left(\mathcal{V}^{\vee}-\mathcal{W}^{\vee}\right)=\frac{\vartheta\left(L_{1}^{-1}\right) \ldots \vartheta\left(L_{r}^{-1}\right)}{\vartheta\left(M_{1}^{-1}\right) \ldots \vartheta\left(M_{s}^{-1}\right)}
$$

for any vector bundles $[\mathcal{V}]=L_{1}+\cdots+L_{r}$ and $[\mathcal{W}]=M_{1}+\cdots+M_{s}$ on $Y$.

Thus, formula (5.13) should be read as

$$
\begin{equation*}
\iota_{*}(1)=\vartheta\left(\mathcal{V}^{\vee}\right) \text { as a section of } \Theta(\mathcal{V}) \tag{5.15}
\end{equation*}
$$

5.9. Motivated by the discussion above, the general construction is the following.

Definition 5.10. ([8]) For a proper map $f: X \rightarrow Y$, push-forward is a morphism

$$
\begin{equation*}
f_{*}: \widetilde{f}_{*}\left(\Theta\left(\operatorname{Tan}_{X}-f^{*}\left(\operatorname{Tan}_{Y}\right)\right) \rightarrow \mathcal{O}\right. \tag{5.16}
\end{equation*}
$$

of coherent sheaves on $A_{Y}$ (the latter condition encodes the projection formula).

Since all the elliptic cohomology schemes $A_{X}$ in the present paper will be affine, we simplify (5.16) by always thinking about push-forward as a map of Ell $Y_{Y}$-modules

$$
f_{*}:\left(\text { a rank } 1 \text { locally free } \mathrm{Ell}_{X} \text {-module }\right) \rightarrow \mathrm{Ell}_{Y}
$$

Moreover, in all our computations we will abuse notation and write

$$
\begin{equation*}
f_{*}: \operatorname{Ell}_{X} \rightarrow \operatorname{Ell}_{Y} \tag{5.17}
\end{equation*}
$$

because the formula for $f_{*}$ will always be given by a product of $\vartheta$ functions, which completely encodes which rank 1 locally free Ell $_{X}$-module is the correct domain of $f_{*}$. For example, if $\iota: X \hookrightarrow Y$ is the zero locus of a regular section of a vector bundle $\mathcal{V}$ on $Y$, then the push-forward is explicitly given by

$$
\begin{equation*}
\iota_{*}(\widetilde{\sigma})=\sigma \cdot \vartheta\left(\mathcal{V}^{\vee}\right) \tag{5.18}
\end{equation*}
$$

for any element $\sigma$ in a rank 1 locally free $\mathrm{Ell}_{Y}$-module, where

$$
\tilde{\sigma}=\widetilde{\iota}^{*}(\sigma)
$$

denotes the pull-back of $\sigma$ to a rank 1 locally free $\mathrm{Ell}_{X}$-module. Formula (5.18) encodes the fact that the domain and codomain of $\iota_{*}$ are rank 1 locally free modules which differ by a twist with $\Theta\left(-\iota^{*}(\mathcal{V})\right)=\Theta\left(\operatorname{Tan}_{X}-\iota^{*}\left(\operatorname{Tan}_{Y}\right)\right)$.
5.11. Another case of great interest to us is push-forward along a projective bundle


We have the map of schemes induced by the Cartesian diagram (5.6)

$$
A_{\mathbb{P}_{X}(V)} \xrightarrow{\tilde{\pi} \times c_{\mathcal{O}(1)}} A_{X} \times E
$$

In this case, for any section $\sigma(z)$ of a line bundle on $A_{X} \times E$ (we write $z$ for the coordinate on the latter copy of $E$ ), the following formula was proved in [23]:

$$
\begin{equation*}
\pi_{*}(\widetilde{\sigma}(\text { taut }))=\sum_{i=1}^{r} \frac{\sigma\left(L_{i}\right)}{\prod_{j \neq i} \vartheta\left(\frac{L_{j}}{L_{i}}\right)} \tag{5.19}
\end{equation*}
$$

where $L_{1}, \ldots, L_{r}$ denote the pullbacks under $c_{\mathcal{V}}$ of the coordinates on $E^{(r)}$ and

$$
\widetilde{\sigma}(\text { taut })=\left(\widetilde{\pi} \times c_{\mathcal{O}(1)}\right)^{*}(\sigma(z))
$$

(the notation in the left-hand side is motivated by the fact that taut $:=[\mathcal{O}(1)]$ is the pull-back of the coordinate $z$ under the map $\left.c_{\mathcal{O}(1)}: A_{\mathbb{P}_{X}(V)} \rightarrow E\right)$. Formula (5.19) encodes the fact that the domain and codomain of $\pi_{*}$ are sections of line bundles which differ by a twist with

$$
\Theta\left(\pi^{*}\left(\mathcal{V}^{\vee}\right) \otimes \mathcal{O}_{\mathbb{P}_{X}(\mathcal{V})}(1)-\mathcal{O}_{\mathbb{P}_{X}(\mathcal{V})}\right)=\Theta\left(\operatorname{Tan}_{\mathbb{P}_{X}(\mathcal{V})}-\pi^{*}\left(\operatorname{Tan}_{X}\right)\right)
$$

For the purpose of computations, we will imagine that $L_{1}, \ldots, L_{r}$ in formula (5.19) are complex numbers of absolute value in $(|p|, 1]$. This is not really too far from the truth, since they are the pull-backs to Ell $X_{X}$ of the usual coordinates on $E=\mathbb{C}^{*} / p^{\mathbb{Z}}$, and the latter can always be realized in the chosen interval up to multiplication by some power of $p$. Then because the function $\vartheta(z)$ has a unique simple pole at $z=1$ with residue -1 , formula (5.19) can be rewritten as follows

$$
\begin{equation*}
\pi_{*}(\widetilde{\sigma}(\text { taut }))=\int_{1-p} \frac{\sigma(z)}{\vartheta\left(\frac{\mathcal{V}}{z}\right)} \tag{5.20}
\end{equation*}
$$

where in the RHS we set

$$
\vartheta\left(\frac{\mathcal{V}}{z}\right)=\prod_{i=1}^{r} \vartheta\left(\frac{L_{i}}{z}\right)
$$

and for any meromorphic function $F(z)$, we write

$$
\begin{equation*}
\int_{1-p} F(z)=\int_{|z|=1} F(z) \frac{d z}{2 \pi i z}-\int_{|z|=|p|} F(z) \frac{d z}{2 \pi i z} \tag{5.21}
\end{equation*}
$$

5.12. We will also be interested in a slightly more general kind of projectivization, which combines the situations of closed embeddings and projective bundles that were discussed above. Explicitly, suppose we have a short exact sequence on $X$

$$
0 \rightarrow \mathcal{W} \rightarrow \mathcal{V} \rightarrow \mathcal{E} \rightarrow 0
$$

where $\mathcal{V}$ and $\mathcal{W}$ are locally free sheaves, but $\mathcal{E}$ is simply a coherent sheaf. Then we have a commutative diagram

with the closed embedding $\iota$ defined as the zero locus of the following composition

$$
\pi^{*}(\mathcal{W}) \rightarrow \pi^{*}(\mathcal{V}) \rightarrow \mathcal{O}(1)
$$

We assume that the composition above is a regular section of $\pi^{*}\left(\mathcal{W}^{\vee}\right) \otimes \mathcal{O}(1)$, which is equivalent to the fact that $\mathbb{P}_{X}(\mathcal{E})$ has expected dimension equal to rank $\mathcal{E}-1$ over $X$. In this case, we may compute $\pi_{*}^{\prime}$ by combining formulas (5.18) and (5.20)

$$
\begin{align*}
\pi_{*}^{\prime}(\widetilde{\sigma}(\text { taut })) & =\int_{1-p} \frac{\sigma(z) \vartheta\left(\frac{\mathcal{W}}{z}\right)}{\vartheta\left(\frac{\mathcal{V}}{z}\right)}  \tag{5.23}\\
& =\int_{1-p} \frac{\sigma(z)}{\vartheta\left(\frac{\mathcal{E}}{z}\right)}
\end{align*}
$$

Remark 5.13. A particularly important case of (5.23) is when $\sigma(z)=z^{m}$ for some integer $m$. We may assemble these special cases together by considering the series

$$
\delta\left(\frac{z}{w}\right)=\sum_{m=-\infty}^{\infty} \frac{z^{m}}{w^{m}}
$$

for some formal variable $w$. Then (15.23) reads

$$
\begin{equation*}
\pi_{*}^{\prime}\left[\delta\left(\frac{\text { taut }}{w}\right)\right]=\left.\frac{1}{\vartheta\left(\frac{\mathcal{E}}{w}\right)}\right|_{1-p} \tag{5.24}
\end{equation*}
$$

where for any meromorphic function $F(z)$, we write

$$
\begin{equation*}
\left.F(z)\right|_{1-p}=(\text { Laurent series of } F(z))-(\text { Laurent series of } F(z p)) \tag{5.25}
\end{equation*}
$$

All our Laurent series will be expanded near the circle $|z|=1$. Note that if $F(z)$ has poles between the circles $|z|=1$ and $|z|=|p|$, then the two Laurent series expansions in the right-hand side of (5.25) can be quite different from each other.
5.14. Let us now consider the moduli spaces $\mathcal{M}$ of stable sheaves on a smooth projective surface $S$, with the notation in Subsection 2.1 and subject to Assumptions A and S . We will define elliptic cohomology versions of the operators in cohomology $/ K$-theory from Subsections 3.11 and 4.9 , respectively. Recall the space $\mathfrak{Z}$ and the maps $\pi_{ \pm}$and $\pi_{S}$ from diagram (2.8), and let us define for all $n \in \mathbb{Z}$

$$
\begin{array}{ll}
e_{n}=\left(\pi_{+} \times \pi_{S}\right)_{*}\left(L^{n} \cdot \pi_{-}^{*}\right) & : \operatorname{Ell}_{\mathcal{M}} \rightarrow \operatorname{Ell}_{\mathcal{M} \times S} \\
f_{n}=\left(\pi_{-} \times \pi_{S}\right)_{*}\left(L^{n-r}(-1)^{r} \operatorname{det} \mathcal{U} \cdot \pi_{+}^{*}\right): \operatorname{Ell}_{\mathcal{M}} \rightarrow \operatorname{Ell}_{\mathcal{M} \times S} \tag{5.27}
\end{array}
$$

where $L, \operatorname{det} \mathcal{U}$ denote the pull-backs under $c_{\mathcal{L}}, c_{\operatorname{det} \mathcal{U}}: \operatorname{Spec}\left(E l_{\mathcal{Z}}\right) \rightarrow E$ of the standard coordinate on $E$. As already explained, we are abusing notation in the formulas above, in that the domains and codomains of the operators $e_{n}, f_{n}$ are actually locally free rank 1 modules over the Ell rings in question, and not the rings themselves. However, it is straightforward to determine the specific twist by which these locally free rank 1 modules differ from each other by looking at the push-forwards $\pi_{ \pm} \times \pi_{S}$, which were described in Proposition 2.4 we will also give explicit formulas for the operators $e_{n}, f_{n}$ in terms of $\vartheta$ functions, from which the twist will be easy to read off. As before, it is helpful to package the operators (5.26) and (5.27) into power series

& e(z)=\sum_{n=-\infty}^{\infty} \frac{e_{n}}{z^{n}}=\left(\pi_{+} \times \pi_{S}\right)_{*}\left[\delta\left(\frac{L}{z}\right) \cdot \pi_{-}^{*}\right]  \tag{5.28}\\
& f(z)=\sum_{n=-\infty}^{\infty} \frac{f_{n}}{z^{n}}=\left(\pi_{-} \times \pi_{S}\right)_{*}\left[\delta\left(\frac{L}{z}\right) \frac{\operatorname{det} \mathcal{U}}{(-z)^{r}} \cdot \pi_{+}^{*}\right] \tag{5.29}
\end{align*}
$$

Finally, we define the following Laurent series (always expanded near $|z|=1$ )

\begin{align*}
h^{+}(z) & =\sum_{n=-\infty}^{\infty} \frac{h_{n}^{+}}{z^{n}}: \text { Ell }_{\mathcal{M}} \xrightarrow{\text { pull-back }} \operatorname{Ell}_{\mathcal{M} \times S} \xrightarrow{\vartheta \vartheta\left(\frac{z(q-1)}{u}\right)} \text { Ell }_{\mathcal{M} \times S} \\
h^{-}(z) & =\sum_{n=-\infty}^{\infty} \frac{h_{n}^{-}}{z^{n}}: \text { Ell }_{\mathcal{M}} \xrightarrow{\text { pull-back }} \text { Ell }_{\mathcal{M} \times S} \xrightarrow{\vartheta\left(\frac{z p(q-1)}{u}\right)} \text { Ell }_{\mathcal{M} \times S} \tag{5.30}
\end{align*}
$$

6 where $q=\left[\mathcal{K}_{S}\right]$. Let us be more precise about the target of the series $h^{ \pm}(z)$ above. Because $\mathcal{U}^{\vee}(q-1)$ is a $K$-theory class of rank 0 and determinant equal to $q^{r}$, then the expression

is a section of the pull-back of $\mathcal{D}_{0, p^{r}}$ under the composition

Having explained how to explicitly think of the operators $h_{n}^{ \pm}$, let us do the same for the operators $e_{n}$ and $f_{n}$, and in the process elucidate the correct twist between their domain and codomain. In order to do so, we will recall universal classes. For any $k, l \in \mathbb{N}$, let $\pi: \mathcal{M} \times S^{k+l} \rightarrow \mathcal{M} \times S^{k}$ and $\rho: \mathcal{M} \times S^{k+l} \rightarrow S^{k+l}$ denote the standard projections and consider the Laurent series

\end{equation*}

\]

where $\mathcal{U}_{i}$ denotes the universal sheaf (2.4) pulled back from $\mathcal{M}$ and the $i$-th factor of $S^{k+l}$, and $\Gamma \in \mathrm{Ell}_{S^{k+l}}$ is arbitrary. Any series coefficient of the expression above in the variables $z_{1}, \ldots, z_{k+l}$ will be called a universal class, and will be denoted by

$$
\begin{equation*}
\Psi(\mathcal{U}) \in \operatorname{Ell}_{\mathcal{M} \times S^{k}} \tag{5.32}
\end{equation*}
$$

We point out the abuse of notation in the formula above: the expression $\Psi(\mathcal{U})$ is not a function on $A_{\mathcal{M} \times S^{k}}$, but more precisely a section of a line bundle on $A_{\mathcal{M} \times S^{k}}$, determined by the particular choice of $\Gamma$ and the particular series coefficient in $z_{1}, \ldots, z_{k+l}$ that we extract from (5.31).

Proposition 5.16. For any universal class $\Psi(\mathcal{U})$, we have the following formulas

$$
\begin{align*}
e(z) \cdot \Psi(\mathcal{U}) & =\left.\Psi\left(\mathcal{U}+z \mathcal{O}_{\Delta}\right) \vartheta\left(\frac{z q}{\mathcal{U}}\right)\right|_{1-p}  \tag{5.33}\\
f(z) \cdot \Psi(\mathcal{U}) & =\left.\Psi\left(\mathcal{U}-z \mathcal{O}_{\Delta}\right) \vartheta\left(-\frac{z}{\mathcal{U}}\right)\right|_{1-p} \tag{5.34}
\end{align*}
$$

(see the notation (5.25) for $\left.\right|_{1-p}$ ) where the diagonal $\Delta \subset S \times S$ identifies the factor of $S$ where the operators $e(z), f(z)$ take values with the factor of $S$ where the universal sheaf $\mathcal{U}$ is defined. Formulas for the operators $e_{n}$ and $f_{n}$ may be obtained by extracting the coefficient of $z^{-n}$ in the Laurent series in the right-hand sides.

In the right-hand side of (5.33) and (5.34), the notation

$$
\Psi(\mathcal{U}+\beta)
$$

refers to replacing $\mathcal{U}$ with $\mathcal{U}+\beta$ in (5.31), for any $\beta \in K_{\mathcal{M} \times S^{k}}$.

Proof. Let us start by proving formula (5.33). We have

e(z) \cdot \Psi(\mathcal{U})=\left(\pi_{+} \times \pi_{S}\right)_{*}\left(\delta\left(\frac{L}{z}\right) \Psi(\mathcal{U})\right) \tag{5.35}

where in the right-hand side, $\Psi(\mathcal{U})$ denotes the universal class on $\mathfrak{Z}$ defined using the universal sheaf $\mathcal{U}$ akin to (5.32). However, on $\mathfrak{Z} \times S$ we actually have two universal sheaves $\mathcal{U}$ and $\mathcal{U}^{\prime}$, due to the short exact sequence

induced from the definition (2.7). Above, $\mathcal{U}$ and $\mathcal{U}^{\prime}$ denote the universal sheaves parameterizing the stable sheaves $\mathcal{F}$ and $\mathcal{F}^{\prime}$ from (2.7) (respectively) and $\mathcal{O}_{\Delta}$ denotes
the pull-back of the diagonal under the homomorphism $\pi_{S} \times \operatorname{Id}_{S}: \mathfrak{Z} \times S \rightarrow S \times S$. Therefore, formula (5.35) yields

$$
\begin{equation*}
e(z) \cdot \Psi(\mathcal{U})=\left(\pi_{+} \times \pi_{S}\right)_{*}\left[\delta\left(\frac{L}{z}\right) \Psi\left(\mathcal{U}^{\prime}+\mathcal{L} \otimes \mathcal{O}_{\Delta}\right)\right] \tag{5.36}
\end{equation*}
$$

The following equality holds for any analytic function $f(z)$

$$
\delta\left(\frac{L}{z}\right) f(L)=\delta\left(\frac{L}{z}\right) f(z)
$$

and it allows us to rewrite (5.36) as

$$
\begin{equation*}
e(z) \cdot \Psi(\mathcal{U})=\left(\pi_{+} \times \pi_{S}\right)_{*}\left[\delta\left(\frac{L}{z}\right) \Psi\left(\mathcal{U}^{\prime}+z \mathcal{O}_{\Delta}\right)\right] \tag{5.37}
\end{equation*}

Meanwhile, as explained in the paragraph after Proposition [2.4 the line bundle $L$ is the inverse of the tautological line bundle on

Therefore, formula (5.24) may be used to evaluate (5.37), thus yielding (5.33) on the nose. As for (5.34), the analogous treatment produces the following formula

f(z) \cdot \Psi\left(\mathcal{U}^{\prime}\right)=\left.\Psi\left(\mathcal{U}-z \mathcal{O}_{\Delta}\right) \frac{\frac{\operatorname{det} \mathcal{U}}{(--)^{r}}}{\vartheta\left(\frac{\mathcal{U}}{z}\right)}\right|_{1-p} \tag{5.38}
\end{equation*}
$$

The fact that (5.38) gives rise to formula (5.34) follows from the identity

\vartheta\left(-\frac{z}{\mathcal{U}}\right)=\frac{\frac{\operatorname{det} \mathcal{U}}{(-z)^{r}}}{\vartheta\left(\frac{\mathcal{U}}{z}\right)}
$$

which in turn is an immediate consequence of (5.12).
5.17. We will now calculate the relations between the operators (5.28), (5.29) and (5.30). Recall our convention of coloring the factors of $S \times S$, as well as all elliptic cohomology classes on $S \times S$ that are pulled back from one of the factors, in red and blue. Consider the elliptic analogue of the rational function (4.29)

\zeta^{\mathrm{Ell}}(x)=\vartheta\left(-x \mathcal{O}_{\Delta}\right) \in \operatorname{Ell}_{S \times S}(x) \tag{5.39}
\end{equation*}
$$

where $\mathcal{O}_{\Delta}$ denotes the structure sheaf of the diagonal in $S \times S$. Because this structure sheaf has rank 0 and determinant 1 , then the coefficients of $\zeta^{\text {Ell }}(x)$ actually lie in the ring $\mathrm{Ell}_{S \times S}$, and not in some locally free rank 1 module. Similarly, we have the following analogues of (4.30) and (4.31)

\begin{align*}
& \widetilde{\zeta}_{+}^{\mathrm{Ell}}(x)=\zeta^{\mathrm{Ell}}(x) \vartheta(x q) \vartheta\left(\frac{q}{x}\right)  \tag{5.40}\\
& \widetilde{\zeta}_{-}^{\mathrm{Ell}}(x)=\zeta^{\mathrm{Ell}}(x) \vartheta\left(\frac{q}{x}\right) \vartheta(x q) \tag{5.41}
\end{align*}
$$

Lemma 5.18. The function $\zeta^{\text {Ell }}(x)$ is of the form

$$
\begin{equation*}
\zeta^{\mathrm{Ell}}(x)=1+\Delta_{*}\left(\frac{\text { quasi-periodic holomorphic function of } x}{\vartheta(x) \vartheta(x q)}\right) \tag{5.42}
\end{equation*}
$$

and so its only poles are at $x \in p^{\mathbb{Z}}$ and $x \in p^{\mathbb{Z}} q^{-1}$. We have

$$
\begin{equation*}
\operatorname{Res}_{x=1} \zeta^{\mathrm{Ell}}(x)=\Delta_{*}\left(\frac{-1}{\vartheta(q)}\right) \tag{5.43}
\end{equation*}
$$

As a consequence of Lemma 5.18, the only poles of $\widetilde{\zeta}_{ \pm}^{\text {Ell }}(x)$ are $x \in p^{\mathbb{Z}}$.

Proof. Because $\mathcal{O}_{\Delta}$ is supported on the diagonal, then $\left.\zeta^{\text {Ell }}(x)\right|_{S \times S \backslash \Delta}=1$. Therefore, the excision property implies that

\zeta^{\mathrm{Ell}}(x)=1+\Delta_{*}(F(x))
$$

for some meromorphic function $F$ with coefficients in $\mathrm{Ell}_{S}$. It remains to show that $F(x)$ only has poles at $x \in p^{\mathbb{Z}}$ and $x \in p^{\mathbb{Z}} q^{-1}$ and to compute its residue at $x=1$. To this end, let us first consider the case when $\Delta \subset S \times S$ is cut out by a regular section $\sigma$ of a rank 2 vector bundle $\mathcal{V}^{\vee}$ on $S \times S$. We have the Koszul complex of $\sigma$

If we write $[\mathcal{V}]=L_{1}+L_{2}$ in $K_{S \times S}$, then we have

\Delta_{*}(1)=\vartheta\left(L_{1}\right) \vartheta\left(L_{2}\right) \tag{5.45}
\end{equation*}
$$

and

$$
\zeta^{\mathrm{Ell}}(x)=\frac{\vartheta\left(x L_{1}\right) \vartheta\left(x L_{2}\right)}{\vartheta(x) \vartheta\left(x L_{1} L_{2}\right)}
$$

There is a general identity (where $L_{1}$ and $L_{2}$ are formal symbols)

$$
\begin{equation*}
\text { 6) } \frac{\vartheta\left(x L_{1}\right) \vartheta\left(x L_{2}\right)}{\vartheta(x) \vartheta\left(x L_{1} L_{2}\right)}=1+\vartheta\left(L_{1}\right) \vartheta\left(L_{2}\right) \cdot \frac{\text { quasi-periodic holomorphic function of } x}{\vartheta(x) \vartheta\left(x L_{1} L_{2}\right)} \tag{5.46}
\end{equation*}
$$

Because $\Delta$ is cut out by a regular section of $\mathcal{V}^{\vee}$, we have

$$
\left.\mathcal{V}^{\vee}\right|_{\Delta}=\operatorname{Nor}_{\Delta / S \times S}^{\vee} \cong \operatorname{Tan}_{S}
$$

which implies that

$$
\left.L_{1} L_{2}\right|_{\Delta}=\left.\operatorname{det} \mathcal{V}\right|_{\Delta}=\operatorname{det} \operatorname{Tan}_{S}^{\vee}=q
$$

Formulas (5.45) and (5.46) imply (5.42), while (5.43) follows from

$$
\operatorname{Res}_{x=1} \zeta^{\mathrm{Ell}}(x)=-\frac{\vartheta\left(L_{1}\right) \vartheta\left(L_{2}\right)}{\vartheta\left(L_{1} L_{2}\right)}=\Delta_{*}\left(\frac{-1}{\vartheta(q)}\right)
$$

Outside of the special case when $\Delta$ is cut out by a regular section of a rank 2 vector bundle on $S \times S$, we may use deformation to the normal bundle to reduce to this special case (see [17, Proposition 5.24] for a version of this argument in $K$-theory).
5.19. In what follows, we will use the obvious analogues of formulas (3.31) and (3.32) when discussing compositions of operators in elliptic cohomology. Let

\operatorname{Ell}_{\mathcal{M} \times S^{k}}^{\circ} \subseteq \operatorname{Ell}_{\mathcal{M} \times S^{k}} \tag{5.47}
\end{equation*}

denote the subset of all universal classes (5.32) (although more precisely, universal classes form subsets not of $\mathrm{Ell}_{\mathcal{M} \times S^{k}}$, but of various locally free rank 1 modules over Ell ${ }_{\mathcal{M} \times S^{k}}$ ). We expect (5.47) to be an equality; the standard way to prove such a statement is to use a resolution of the diagonal in $\mathcal{M} \times \mathcal{M}$ by universal classes.

Theorem 5.20. We have the following equalities of operators $\operatorname{Ell}_{\mathcal{M}}^{\circ} \rightarrow \operatorname{Ell}_{\mathcal{M} \times S \times S}^{\circ}$

\begin{gather*}
e(z) e(w) \widetilde{\zeta}_{-}^{\text {Ell }}\left(\frac{w}{z}\right)=e(w) e(z) \widetilde{\zeta}_{+}^{\text {Ell }}\left(\frac{z}{w}\right)  \tag{5.48}\\
f(w) f(z) \widetilde{\zeta}_{-}^{\text {Ell }}\left(\frac{w}{z}\right)=f(z) f(w) \widetilde{\zeta}_{+}^{\text {Ell }}\left(\frac{z}{w}\right)  \tag{5.49}\\
h^{ \pm}(z) e(w)=e(w) h^{ \pm}(z) \frac{\zeta^{\text {Ell }}\left(\frac{z}{w}\right)}{\zeta^{\mathrm{Ell}}\left(\frac{w}{z}\right)}  \tag{5.50}\\
f(w) h^{ \pm}(z)=h^{ \pm}(z) f(w) \frac{\zeta^{\text {Ell }}\left(\frac{z}{w}\right)}{\zeta^{\mathrm{Ell}}\left(\frac{w}{z}\right)}  \tag{5.51}\\
{[f(z), e(w)]=\delta\left(\frac{z}{w}\right) \cdot \Delta_{*}\left(\frac{h^{+}(z)-h^{-}(w)}{\vartheta(q)}\right)} \tag{5.52}
\end{gather*}
$$


Our proof of formulas (5.50)-(5.52) establishes them as equalities of operators

$$
\operatorname{Ell}_{\mathcal{M}} \rightarrow \operatorname{Ell}_{\mathcal{M} \times S \times S}
$$

Meanwhile, although our proof of formulas (5.48) (5.49) only holds on the subsets of universal classes Ell ${ }^{\circ} \subseteq$ Ell, we believe that these relations actually hold on the whole elliptic cohomology rings.

Proof. We start with (5.48), and leave the analogous formula (5.49) as an exercise to the interested reader. Let us apply formula (5.33) for any universal class $\Psi(\mathcal{U})$ :

$$
e(w) \cdot \Psi(\mathcal{U})=\left.\Psi\left(\mathcal{U}+w \mathcal{O}_{\Delta}\right) \vartheta\left(\frac{w q}{\mathcal{U}}\right)\right|_{1-p}
$$

The right-hand side of the expression above lies in a certain locally free rank 1 module over $\mathrm{Ell}_{\mathcal{M} \times S}$, and the universal sheaf $\mathcal{U}$ (as well as the canonical class $q$ ) corresponds to the latter copy of $S$. Meanwhile, inside the universal class $\Psi$, we write $\mathcal{U}$ in black because it represents the universal sheaf on auxiliary copies of $S$, as in (5.31). Applying (5.33) again to the identity above yields

e(z) e(w) \cdot \Psi(\mathcal{U})=\vartheta\left(\frac{w q}{z} \mathcal{O}_{\Delta}^{\vee}\right)  \tag{5.53}\\
\left.\left.\Psi\left(\mathcal{U}+z \mathcal{O}_{\Delta}+w \mathcal{O}_{\Delta}\right) \vartheta\left(\frac{z q}{\mathcal{U}}\right) \vartheta\left(\frac{w q}{\mathcal{U}}\right)\right|_{1-p} ^{w}\right|_{1-p} ^{z}
\end{gather*}
$$

where the black copy of $\Delta$ above represents the diagonal in $S \times S$, and the symbol $\left.\left.\right|_{1-p} ^{w}\right|_{1-p} ^{z}$ means that we first expand in $w$ and then in $z$. However, note that

$$
\begin{equation*}
q\left[\mathcal{O}_{\Delta}^{\vee}\right]=\left[\mathcal{O}_{\Delta}\right] \in K_{S \times S} \tag{5.54}
\end{equation*}
$$

implies $\vartheta\left(\frac{w q}{z} \mathcal{O}_{\Delta}^{\vee}\right)=\vartheta\left(\frac{w}{z} \mathcal{O}_{\Delta}\right)=\zeta^{\text {Ell }}\left(\frac{w}{z}\right)^{-1}$. Thus, formula (5.53) reads

$$
\begin{aligned}
& e(z) e(w) \widetilde{\zeta}_{-}^{\mathrm{Ell}}\left(\frac{w}{z}\right) \cdot \Psi(\mathcal{U})=\vartheta\left(\frac{z q}{w}\right) \vartheta\left(\frac{w q}{z}\right) \\
& \left.\left.\Psi\left(\mathcal{U}+z \mathcal{O}_{\Delta}+w \mathcal{O}_{\Delta}\right) \vartheta\left(\frac{z q}{\mathcal{U}}\right) \vartheta\left(\frac{w q}{\mathcal{U}}\right)\right|_{1-p} ^{w}\right|_{1-p} ^{z}
\end{aligned}
$$

Formula (5.48) follows from the fact that the right-hand side of the expression above is symmetric in $(z, S) \leftrightarrow(w, S)$ (moreover, because there are no poles involving both $z$ and $w$, we can freely switch the order of the expansions $\left.\right|_{1-p} ^{z}$ and $\left.\left.\right|_{1-p} ^{w}\right)$.
We will now prove (5.50), and leave the analogous formula (5.51) as an exercise to the reader. Recall that $e(w)$ is given by the correspondence $\delta\left(\frac{L}{w}\right)$ on the locus

$$
\mathfrak{Z}=\left\{\left(\mathcal{F}^{\prime} \subset_{y} \mathcal{F}\right)\right\}
$$

which is endowed with the line bundle $\mathcal{L}$ (where $L=[\mathcal{L}])$ and the map $p_{S}: \mathfrak{Z} \rightarrow S$ that records the point $y$. We have the short exact sequence

$$
\begin{equation*}
0 \rightarrow \mathcal{U}^{\prime} \rightarrow \mathcal{U} \rightarrow \mathcal{L} \otimes \mathcal{O}_{\Delta} \rightarrow 0 \tag{5.55}
\end{equation*}
$$

on $\mathfrak{Z} \times S$, where $\mathcal{U}$ and $\mathcal{U}^{\prime}$ are the universal sheaves keeping track of $\mathcal{F}$ and $\mathcal{F}^{\prime}$ (respectively) as sheaves on $S$. In (5.55), we write $\mathcal{O}_{\Delta}$ for the pull-back of the structure sheaf of the diagonal $\Delta \subset S \times S$ under the map

$$
\mathfrak{Z} \times S \rightarrow S \times S, \quad\left(\mathcal{F}^{\prime} \subset_{y} \mathcal{F}\right) \times x \mapsto(x, y)
$$

With this in mind, note that the left-hand side of (5.50) is given by the following correspondence on $\mathfrak{Z} \times S$

$$
\begin{aligned}
\delta\left(\frac{L}{w}\right) \frac{\vartheta\left(\frac{z q}{\mathcal{U}^{\prime}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}^{\prime}}\right)} & =\delta\left(\frac{L}{w}\right) \frac{\vartheta\left(\frac{z q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)} \frac{\vartheta\left(-\frac{z q}{L} \mathcal{O}_{\Delta}^{\vee}\right)}{\vartheta\left(-\frac{z}{L} \mathcal{O}_{\Delta}^{\vee}\right)} \\
& =\delta\left(\frac{L}{w}\right) \frac{\vartheta\left(\frac{z q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)} \frac{\vartheta\left(-\frac{z q}{w} \mathcal{O}_{\Delta}^{\vee}\right)}{\vartheta\left(-\frac{z}{w} \mathcal{O}_{\Delta}^{\vee}\right)} \\
& =\delta\left(\frac{L}{w}\right) \frac{\vartheta\left(\frac{z q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)} \frac{\vartheta\left(-\frac{z}{w} \mathcal{O}_{\Delta}\right)}{\vartheta\left(-\frac{w}{z} \mathcal{O}_{\Delta}\right)}
\end{aligned}
$$

(in the last equality, we used (5.54) in the numerator, while in the denominator we used (5.12) together with the fact that $\mathcal{O}_{\Delta}$ has rank 0 and determinant 1). The expression above is the correspondence that gives the right-hand side of (5.50).
Let us now turn to proving relation (55.52). In Subsection 3.17, we showed that the commutator $[f(z), e(w)]$ is given by a correspondence supported on the locus $\{x=y\}$ of $\mathcal{M} \times \mathcal{M} \times S \times S$. However, a slight refinement of this argument (see the proof of Proposition 3.6 in [17]) actually shows that the correspondence in question is supported on the smaller locus $\left\{\mathcal{F}=\mathcal{F}^{\prime}\right\} \cap\{x=y\}$. Therefore, we have

$$
\begin{equation*}
[f(z), e(w)]=\Delta_{*}(\text { multiplication by } \gamma) \tag{5.56}
\end{equation*}
$$

for some elliptic cohomology class $\gamma$ on $\mathcal{M} \times S$. It therefore remains to show that

$$
\begin{equation*}
\gamma=\left.\delta\left(\frac{z}{w}\right) \cdot \frac{1}{\vartheta(q)} \cdot \frac{\vartheta\left(\frac{z q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)}\right|_{1-p} \tag{5.57}
\end{equation*}
$$

Since $\Delta_{*}$ is injective (as it has a left-inverse given by projection onto the first factor $S \times S \rightarrow S$ ), formula (5.57) is equivalent to

$$
\begin{equation*}
\Delta_{*}(\gamma)=\delta\left(\frac{z}{w}\right) \cdot \Delta_{*}\left(\left.\frac{1}{\vartheta(q)} \cdot \frac{\vartheta\left(\frac{z q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)}\right|_{1-p}\right) \tag{5.58}
\end{equation*}
$$

In order to obtain $\Delta_{*}(\gamma)$, we simply apply equality (5.56) to the unit class

$$
[f(z), e(w)] \cdot 1=\Delta_{*}(\gamma)
$$

and so it remains to show that

$$
\begin{equation*}
[f(z), e(w)] \cdot 1=\delta\left(\frac{z}{w}\right) \cdot \Delta_{*}\left(\left.\frac{1}{\vartheta(q)} \cdot \frac{\vartheta\left(\frac{z q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)}\right|_{1-p}\right) \tag{5.59}
\end{equation*}
$$

To prove (5.59), note that Proposition 5.16 gives us

$$
\begin{aligned}
& f(z) \cdot 1=\left.\vartheta\left(-\frac{z}{\mathcal{U}}\right)\right|_{1-p} ^{z} \\
& e(w) \cdot 1=\left.\vartheta\left(\frac{w q}{\mathcal{U}}\right)\right|_{1-p} ^{w}
\end{aligned}
$$

(the color of the universal sheaf $\mathcal{U}$, as well as the class $q=\left[\mathcal{K}_{S}\right]$, denotes which copy of $S \times S$ it corresponds to). Another application of Proposition 5.16 yields

$$
\begin{align*}
& f(z) e(w) \cdot 1=\left.\left.\frac{\vartheta\left(\frac{w q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)} \vartheta\left(-\frac{w q}{z} \mathcal{O}_{\Delta}^{\vee}\right)\right|_{1-p} ^{w}\right|_{1-p} ^{z}  \tag{5.60}\\
& e(w) f(z) \cdot 1=\left.\left.\frac{\vartheta\left(\frac{w q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)} \vartheta\left(-\frac{w}{z} \mathcal{O}_{\Delta}\right)\right|_{1-p} ^{z}\right|_{1-p} ^{w} \tag{5.61}
\end{align*}
$$

Because of formula (5.54), the right-hand sides of (5.60) and (5.61) only differ in the order in which we expand the variables $z$ and $w$, and so the difference $[f(z), e(w)] \cdot 1$ only has contributions from the residues of

$$
\vartheta\left(-\frac{w q}{z} \mathcal{O}_{\Delta}^{\vee}\right) \stackrel{(5.54}{=} \vartheta\left(-\frac{w}{z} \mathcal{O}_{\Delta}\right)=\zeta^{\mathrm{Ell}}\left(\frac{w}{z}\right)
$$

as $z$ passes over $w$. According to Lemma 5.18, there are only two such residues:

- The residue at $z=w$ yields

$$
\delta\left(\frac{z}{w}\right) \cdot \Delta_{*}\left(\left.\frac{1}{\vartheta(q)} \cdot \frac{\vartheta\left(\frac{z q}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)}\right|_{1-p}\right)
$$

which is equal to the right-hand side of (5.59).

- The residue at $z=w q$ yields

$$
\delta\left(\frac{z}{w q}\right) \cdot \Delta_{*}\left(\text { const }\left.\cdot \frac{\vartheta\left(\frac{z}{\mathcal{U}}\right)}{\vartheta\left(\frac{z}{\mathcal{U}}\right)}\right|_{1-p}\right)
$$

where const denotes minus the residue of $\zeta^{\text {Ell }}(x)$ at $x=q^{-1}$. The expression above is 0 because the two $\vartheta$ in the right-hand side cancel out, and const $\left.\right|_{1-p}=0$.
5.21. We will now connect the formulas in Theorem5.20 with the elliptic quantum toroidal algebra studied in [11. The main modification we make from the elliptic curve context in the previous Subsections is that we will think of $p$ as being infinitesimally small (instead of being a fixed complex number) and so we will expand all of our formulas as power series in $p$. Consider the meromorphic functions

$$
\begin{gather*}
\zeta^{E}(x)=\frac{\vartheta\left(x q_{1}\right) \vartheta\left(x q_{2}\right)}{\vartheta(x) \vartheta(x q)}  \tag{5.62}\\
\widetilde{\zeta}^{E}(x)=\zeta^{E}(x) \vartheta(x q) \vartheta\left(x^{-1} q\right)=\frac{\vartheta\left(x q_{1}\right) \vartheta\left(x q_{2}\right) \vartheta\left(x^{-1} q\right)}{\vartheta(x)} \tag{5.63}
\end{gather*}
$$

where $q_{1}, q_{2}$ are formal symbols, and $q=q_{1} q_{2}$.
Definition 5.22. ([11]) Elliptic quantum toroidal $\mathfrak{g l}_{1}$ is the algebra

$$
U_{q_{1}, q_{2}, p}\left(\ddot{\mathfrak{g}}_{1}\right)=\mathbb{Z}\left[q_{1}^{ \pm 1}, q_{2}^{ \pm 1}\right][[p]]\left\langle e_{n}, f_{n}, h_{n}^{ \pm}\right\rangle_{n \in \mathbb{Z}} / \text { relations (5.64)-(5.68) }
$$

The defining relations are best written in terms of the generating series

$$
e(z)=\sum_{n=-\infty}^{\infty} \frac{e_{n}}{z^{n}}, \quad f(z)=\sum_{n=-\infty}^{\infty} \frac{f_{n}}{z^{n}}, \quad h^{ \pm}(z)=\sum_{n=-\infty}^{\infty} \frac{h_{n}^{ \pm}}{z^{n}}
$$

and take the form

$$
\begin{gather*}
e(z) e(w) \widetilde{\zeta}^{E}\left(\frac{w}{z}\right)=e(w) e(z) \widetilde{\zeta}^{E}\left(\frac{z}{w}\right)  \tag{5.64}\\
f(w) f(z) \widetilde{\zeta}^{E}\left(\frac{w}{z}\right)=f(z) f(w) \widetilde{\zeta}^{E}\left(\frac{z}{w}\right)  \tag{5.65}\\
h^{ \pm}(z) e(w)=e(w) h^{ \pm}(z) \frac{\zeta^{E}\left(\frac{z}{w}\right)}{\zeta^{E}\left(\frac{w}{z}\right)}  \tag{5.66}\\
f(w) h^{ \pm}(z)=h^{ \pm}(z) f(w) \frac{\zeta^{E}\left(\frac{z}{w}\right)}{\zeta^{E}\left(\frac{w}{z}\right)}  \tag{5.67}\\
{[f(z), e(w)]=\frac{\vartheta\left(q_{1}\right) \vartheta\left(q_{2}\right)}{\vartheta(q)} \cdot \delta\left(\frac{z}{w}\right)\left(h^{+}(z)-h^{-}(w)\right)} \tag{5.68}
\end{gather*}
$$

(where $\delta(x)=\sum_{n=-\infty}^{\infty} x^{n}$ ), as well as $\left[h^{ \pm}(z), h^{ \pm^{\prime}}(w)\right]=0$ for all $\pm, \pm^{\prime} \in\{+,-\}$.
Note that beside the generators and relations above, the elliptic quantum toroidal algebra of 11 has one more central element $\gamma$ (which is always set equal to 1 in geometric representations) and one more cubic relation involving the $e_{n}$ 's and $f_{n}$ 's (respectively). We do not include the latter relation in order to streamline the presentation; it is straightforward to check that the cubic relations between the operators (5.28) and (5.29) (respectively) hold by using formulas (5.33) and (5.34).
Comparing (5.48) - (5.52) with Definition 5.22 allows us to phrase Theorem 5.20 as yielding an action (in the sense analogous to Definition 3.19)

$$
\begin{equation*}
U_{q_{1}, q_{2}, p}\left(\ddot{\mathfrak{g}}{ }_{1}\right) \curvearrowright \operatorname{Ell}_{\mathcal{M}}^{\circ} \tag{5.69}
\end{equation*}
$$

We do not make this into a precise Theorem for rather pedantic reasons, such as the fact that 11] define the elliptic quantum group over power series in $p$, while $\mathrm{Ell}_{\mathcal{M}}$
is defined for fixed $p$ (this discrepancy is important when discussing the integrality of the algebras involved). However, (5.69) is the motivation for the present paper.

Remark 5.23. In [22], the authors define an elliptic quantum group in a schemetheoretic way (in the related setup where moduli spaces of sheaves on surfaces are replaced by Nakajima quiver varieties), following the axiomatic treatment of 8 and the theory of cohomological Hall algebras. To obtain explicit algebras out of their general construction, one needs to choose a "basis" of meromorphic functions on the elliptic curve $E$. The choice we made in the present paper is that of the monomials $\left\{z^{n}\right\}_{n \in \mathbb{Z}}$, which led to the particular algebra of Definition 5.22. However, other choices (such as

$$
\left\{\frac{\partial^{n}}{\partial z^{n}}\left(\frac{\vartheta(z u)}{\vartheta(z) \vartheta(u)}\right)\right\}_{n \geq 0, u \in \mathbb{C}^{*}}
$$

that was considered in [22]) are equally valid, and they produce different generators-and-relations realizations of elliptic quantum groups.
