# PROJECTIVE CLOSURE OF GORENSTEIN MONOMIAL CURVES AND THE COHEN-MACAULAY PROPERTY

#### Abstract

Let $C(\mathbf{a})$ be a Gorenstein non-complete intersection monomial curve in the 4 -dimensional affine space. There is a vector $\mathbf{v} \in \mathbb{N}^{4}$ such that for every integer $m \geq 0$, the monomial curve $C(\mathbf{a}+m \mathbf{v})$ is Gorenstein noncomplete intersection whenever the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime. In this paper, we study the arithmetically Cohen-Macaulay property of the projective closure of $C(\mathbf{a}+m \mathbf{v})$.


## 1. Introduction

Let $\mathbf{a}=\left(a_{1}, \ldots, a_{n}\right)$ be a sequence of positive integers with $\operatorname{gcd}\left(a_{1}, \ldots, a_{n}\right)=1$. Consider the polynomial ring $R=K\left[x_{1}, \ldots, x_{n}\right]$ in $n$ variables over a field $K$. Let $C(\mathbf{a})$ be the monomial curve in the $n$-dimensional affine space $\mathbb{A}^{n}(K)$ defined parametrically by $x_{1}=t^{a_{1}}, \ldots, x_{n}=t^{a_{n}}$. The toric ideal of $C(\mathbf{a})$, denoted by $I(\mathbf{a})$, is the kernel of the $K$-algebra homomorphism $\phi: R \rightarrow K[t]$ given by

$$
\phi\left(x_{i}\right)=t^{a_{i}} \text { for all } 1 \leq i \leq n
$$

It is known that $I(\mathbf{a})$ is a prime ideal generated by binomials $x_{1}^{u_{1}} \cdots x_{n}^{u_{n}}-x_{1}^{v_{1}} \cdots x_{n}^{v_{n}}$ such that $u_{1} a_{1}+\cdots+u_{n} a_{n}=v_{1} a_{1}+\cdots+v_{n} a_{n}$, see [14, Lemma 4.1].

Let us assume that $a_{n}>a_{i}$ for all $i<n$. The homogenization of $I(\mathbf{a})$ with respect to the variable $x_{0}$, denoted by $I^{h}(\mathbf{a})$, is the kernel of the $K$-algebra homomorphism $\psi: R\left[x_{0}\right] \rightarrow K[s, t]$ given by $\psi\left(x_{0}\right)=s^{a_{n}}$ and $\psi\left(x_{i}\right)=t^{a_{i}} s^{a_{n}-a_{i}}$, for al $1 \leq i \leq n$. The projective monomial curve $\overline{C(\mathbf{a})}$ in $\mathbb{P}^{n}$ is given parametrically by $[s: t] \mapsto$ $\left[s^{a_{n}}: t^{a_{1}} s^{a_{n}-a_{1}}: \cdots: t^{a_{n-1}} s^{a_{n}-a_{n-1}}: t^{a_{n}}\right]$. If $K$ is algebraically closed, then $I^{h}(\mathbf{a})$ is the vanishing ideal of $\overline{C(\mathbf{a})}$. The projective monomial curve $\overline{C(\mathbf{a})}$ is called arithmetically Cohen-Macaulay if its vanishing ideal $I^{h}(\mathbf{a})$ is a Cohen-Macaulay ideal. Arithmetically Cohen-Macaulayness of projective monomial curves has been studied by many authors; see, for instance, [2], 6], [10, [11, [12].

Recently, there has been an increased interest in studying the behaviour of the Betti numbers of a shifted toric ideal $I(\mathbf{a}+m \mathbf{u})$, where $m \geq 0$ is an integer and $\mathbf{u} \in \mathbb{N}^{n}$, see [3], [4, [7], 8], [13. That's mainly due to a conjecture of J. Herzog and H. Srinivasan saying that the Betti numbers of $I\left(a_{1}+m, \ldots, a_{n}+m\right)$ are eventually periodic in $m$. The conjecture was proved by T. Vu in [13]. From Theorem 5.7 in 13 it follows that the monomial curve $\overline{C\left(a_{1}+m, \ldots, a_{n}+m\right)}$ is arithmetically Cohen-Macaulay for all $m \gg 0$.

Given a Gorenstein non-complete intersection monomial curve $C(\mathbf{a})$ in $\mathbb{A}^{4}(K), \mathrm{P}$. Gimenez and H. Srinivasan [4, Theorem 4] showed that there is a vector $(1,1,1,1) \neq$

[^0]$\mathbf{v} \in \mathbb{N}^{4}$ such that for every $m \geq 0$, the monomial curve $C(\mathbf{a}+m \mathbf{v})$ is Gorenstein non-complete intersection whenever the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime.

In this article our aim is to provide necessary and sufficient conditions for the arithmetically Cohen-Macaulayness of $\overline{C(\mathbf{a}+m \mathbf{v})}$ by using a minimal generating set for $I(\mathbf{a}+m \mathbf{v})$, see Theorems 2.7 and 2.12. This information will allow us to check the arithmetically Cohen-Macaulay property by just computing a minimal generating set of the ideal. Our results apply also in the case $m=0$, thus providing necessary and sufficient conditions for the arithmetically Cohen-Macaulayness of $\overline{C(\mathbf{a})}$. A basic step towards our goal is to find a Gröbner basis for the ideal $I(\mathbf{a}+m \mathbf{v})$ with respect to a degree reverse lexicographic order, see Propositions 2.5, 2.11. We further determine a generating set for $I^{h}(\mathbf{a}+m \mathbf{v})$, see Corollary 2.9 and Corollary 2.16. Finally we provide families of monomial curves $\overline{C(\mathbf{a}+m \mathbf{v})}$ which are not arithmetically Cohen-Macaulay, see Examples 2.8, 2.13.

## 2. Cohen-Macaulay criteria for $\overline{C(\mathbf{a}+m \mathbf{v})}$

In this section we first recall Bresinsky's theorem, which gives the explicit description of $I(\mathbf{a})$ when $C(\mathbf{a})$ is a Gorenstein non-complete intersection monomial curve in $\mathbb{A}^{4}(K)$.

Theorem 2.1. ([1, Theorem 3]) Let $C(\mathbf{a})$ be a monomial curve having the parametrization

$$
x_{1}=t^{a_{1}}, x_{2}=t^{a_{2}}, x_{3}=t^{a_{3}}, x_{4}=t^{a_{4}}
$$

Then $C(\mathbf{a})$ is a Gorenstein non-complete intersection monomial curve if and only if $I(\mathbf{a})$ is minimally generated by the set
$\left\{x_{1}^{d_{1}}-x_{3}^{d_{13}} x_{4}^{d_{14}}, x_{2}^{d_{2}}-x_{1}^{d_{21}} x_{3}^{d_{23}}, x_{3}^{d_{3}}-x_{2}^{d_{32}} x_{4}^{d_{34}}, x_{1}^{d_{41}} x_{2}^{d_{42}}-x_{4}^{d_{4}}, x_{2}^{d_{42}} x_{3}^{d_{13}}-x_{1}^{d_{21}} x_{4}^{d_{34}}\right\}$
where the above binomials are unique up to isomorphism, $d_{i j}>0$ and also

$$
d_{1}=d_{21}+d_{41}, d_{2}=d_{32}+d_{42}, d_{3}=d_{13}+d_{23}, d_{4}=d_{14}+d_{34}
$$

Remark 2.2. Bresinsky [1, Theorem 4] also showed that $C(\mathbf{a})$ and $I(\mathbf{a})$ are as in the previous theorem if and only if $a_{1}=d_{2} d_{4} d_{13}+d_{42} d_{14} d_{23}, a_{2}=d_{3} d_{4} d_{21}+d_{41} d_{34} d_{23}$, $a_{3}=d_{1} d_{2} d_{34}+d_{32} d_{21} d_{14}, a_{4}=d_{1} d_{3} d_{42}+d_{13} d_{32} d_{41}$ with $\operatorname{gcd}\left(a_{1}, a_{2}, a_{3}, a_{4}\right)=1$, $d_{i}>1,0<d_{i j}<d_{j}$ for $1 \leq i \leq 4$, and $d_{1}=d_{21}+d_{41}, d_{2}=d_{32}+d_{42}, d_{3}=d_{13}+d_{23}$, $d_{4}=d_{14}+d_{34}$.

Let $\mathbf{a}=\left(a_{1}, \ldots, a_{4}\right)$ be a sequence of positive integers. A binomial $B=M-N \in$ $I(\mathbf{a})$ is called indispensable of $I(\mathbf{a})$ if every system of binomial generators of $I(\mathbf{a})$ contains $B$ or $-B$, while a monomial $M$ is called indispensable of $I(\mathbf{a})$ if every system of binomial generators of $I(\mathbf{a})$ contains a binomial $B$ such that $M$ is a monomial of $B$. If $C(\mathbf{a})$ is a Gorenstein non-complete intersection monomial curve, then $I(\mathbf{a})$ is generated by the indispensable binomials, see [9, Corollary 3.15].

Theorem 2.3. (4, Theorem 4], 5, Theorem 8]) Let $C(\mathbf{a})$ be a Gorenstein noncomplete intersection monomial curve in $\mathbb{A}^{4}(K)$. Consider the vector $\mathbf{v}=\left(v_{1}, \ldots, v_{4}\right) \in$ $\mathbb{N}^{4}$, where $v_{1}=d_{2} d_{3}-d_{23} d_{32}, v_{2}=d_{21} d_{3}+d_{23} d_{34}, v_{3}=d_{2} d_{34}+d_{21} d_{32}$ and $v_{4}=d_{2} d_{3}-d_{23} d_{32}$. For every $m \geq 0$ the monomial curve $C(\mathbf{a}+m \mathbf{v})$ is Gorenstein non-complete intersection whenever the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime. Furthermore, $I(\mathbf{a}+m \mathbf{v})$ is minimally generated by the binomials $f_{1}:=x_{1}^{d_{1}+m}-$ $x_{3}^{d_{13}} x_{4}^{d_{14}+m}, f_{2}:=x_{2}^{d_{2}}-x_{1}^{d_{21}} x_{3}^{d_{23}}, f_{3}:=x_{3}^{d_{3}}-x_{2}^{d_{32}} x_{4}^{d_{34}}, f_{4}:=x_{1}^{d_{41}+m} x_{2}^{d_{42}}-x_{4}^{d_{4}+m}, f_{5}:=$ $x_{2}^{d_{42}} x_{3}^{d_{13}}-x_{1}^{d_{21}} x_{4}^{d_{34}}$.

Throughout this paper $C(\mathbf{a})$ will always be a Gorenstein non-complete intersection monomial curve in $\mathbb{A}^{4}(K)$. Also we will use the notation introduced in Theorem 2.3.

Remark 2.4. If $d_{1} \geq d_{13}+d_{14}$ and $d_{21}+d_{34} \leq d_{42}+d_{13}$, then $d_{4} \leq d_{41}+d_{42}$ since $d_{14}+d_{34} \leq d_{1}-d_{13}+d_{34}=d_{21}+d_{41}-d_{13}+d_{34} \leq d_{41}+d_{42}$.
Proposition 2.5. Suppose that the following conditions hold.
(1) $d_{1} \geq d_{13}+d_{14}$.
(2) $d_{2} \geq d_{21}+d_{23}$.
(3) $d_{3} \geq d_{32}+d_{34}$.
(4) $d_{21}+d_{34} \leq d_{42}+d_{13}$.

If the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime, then $G:=\left\{f_{i} \mid 1 \leq i \leq 5\right\}$ is the reduced Gröbner basis for $I(\mathbf{a}+m \mathbf{v})$ with respect to the degree reverse lexicographic order $<$ with $x_{2}>x_{1}>x_{3}>x_{4}$.
Proof. We have that $\operatorname{in}_{<}\left(f_{1}\right)=x_{1}^{d_{1}+m}, \operatorname{in}_{<}\left(f_{2}\right)=x_{2}^{d_{2}}, \operatorname{in}_{<}\left(f_{3}\right)=x_{3}^{d_{3}}, \operatorname{in}_{<}\left(f_{4}\right)=$ $x_{1}^{d_{41}+m} x_{2}^{d_{42}}$ and $\operatorname{in}_{<}\left(f_{5}\right)=x_{2}^{d_{42}} x_{3}^{d_{13}}$. Since in $<\left(f_{1}\right)$ and $\operatorname{in}_{<}\left(f_{2}\right)$ are relatively prime, we get $S\left(f_{1}, f_{2}\right) \xrightarrow{G} 0$. Similarly $S\left(f_{1}, f_{3}\right) \xrightarrow{G} 0, S\left(f_{1}, f_{5}\right) \xrightarrow{G} 0, S\left(f_{2}, f_{3}\right) \xrightarrow{G} 0$ and $S\left(f_{3}, f_{4}\right) \xrightarrow{G} 0$. We have that $S\left(f_{1}, f_{4}\right)=x_{1}^{d_{21}} x_{4}^{d_{4}+m}-x_{2}^{d_{42}} x_{3}^{d_{13}} x_{4}^{d_{14}+m} \xrightarrow{f_{5}} 0$. Also $S\left(f_{2}, f_{4}\right)=x_{2}^{d_{32}} x_{4}^{d_{4}+m}-x_{1}^{d_{1}+m} x_{3}^{d_{23}} \xrightarrow{f_{1}} x_{2}^{d_{32}} x_{4}^{d_{4}+m}-x_{3}^{d_{3}} x_{4}^{d_{14}+m} \xrightarrow{f_{3}} 0$. Additionally $S\left(f_{2}, f_{5}\right)=x_{1}^{d_{21}} x_{3}^{d_{3}}-x_{1}^{d_{21}} x_{2}^{d_{32}} x_{4}^{d_{34}} \xrightarrow{f_{3}} 0$. Furthermore, $S\left(f_{3}, f_{5}\right)=$ $x_{1}^{d_{21}} x_{3}^{d_{23}} x_{4}^{d_{34}}-x_{2}^{d_{2}} x_{4}^{d_{34}} \xrightarrow{f_{2}} 0$. Finally $S\left(f_{4}, f_{5}\right)=x_{1}^{d_{1}+m} x_{4}^{d_{34}}-x_{3}^{d_{13}} x_{4}^{d_{4}+m} \xrightarrow{f_{1}} 0$.

In this paper we will make extensive use of the following result.
Theorem 2.6. ([6, Theorem 2.2]) Let $\mathbf{a}=\left(a_{1}, \ldots, a_{4}\right)$ be a sequence of positive integers with $a_{4}>a_{i}$ for all $i<4$. Denote $<$ any reverse lexicographic order on $R=K\left[x_{1}, \ldots, x_{4}\right]$ such that $x_{4}$ is the smallest variable. The following conditions are equivalent:
(1) the projective monomial curve $\overline{C(\mathbf{a})}$ is arithmetically Cohen-Macaulay.
(2) $x_{4}$ does not divide any minimal generator of $\mathrm{in}_{<}(I(\mathbf{a}))$.

First we consider the case that $d_{2} \geq d_{21}+d_{23}$.
Theorem 2.7. Let $d_{2} \geq d_{21}+d_{23}$ and $a_{4}+m v_{4}>a_{i}+m v_{i}$ for all $i<4$. Suppose that the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime. Then $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay if and only if the following conditions hold:
(1) $d_{1} \geq d_{13}+d_{14}$;
(2) $d_{3} \geq d_{32}+d_{34}$;
(3) $d_{21}+d_{34} \leq d_{42}+d_{13}$.

Proof. $(\Leftarrow)$ Suppose that (1), (2) and (3) are true. By Proposition 2.5, $G$ is the reduced Gröbner basis for $I(\mathbf{a}+m \mathbf{v})$ with respect to the degree reverse lexicographic order $<$ with $x_{2}>x_{1}>x_{3}>x_{4}$. Since $x_{4}$ does not divide in $\operatorname{in}_{<}\left(f_{i}\right)$ for every $1 \leq i \leq 5$, we have, from Theorem [2.6] that $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay.
$(\Rightarrow)$ Suppose that $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay. The binomials $f_{i}$, $1 \leq i \leq 5$, are indispensable of $I(\mathbf{a}+m \mathbf{v})$, so they belong to the reduced Gröbner basis for $I(\mathbf{a}+m \mathbf{v})$ with respect to $<$. But $x_{4}$ does not divide $\mathrm{in}_{<}\left(f_{i}\right)$ for every
$1 \leq i \leq 5$, thus $\operatorname{in}_{<}\left(f_{1}\right)=x_{1}^{d_{1}+m}, \operatorname{in}_{<}\left(f_{3}\right)=x_{3}^{d_{3}}$ and $\operatorname{in}_{<}\left(f_{5}\right)=x_{2}^{d_{42}} x_{3}^{d_{13}}$. Therefore (1), (2) and (3) are true.

Example 2.8. Let $\mathbf{a}=\left(2 a^{2}+a-2,2 a+1,2 a+3,2 a^{2}+a-1\right)$, where $a \geq$ 2 is an integer. Then $C(\mathbf{a})$ is a Gorenstein non-complete intersection monomial curve and $I(\mathbf{a})$ is minimally generated by $x_{1}^{2}-x_{3}^{a-1} x_{4}, x_{2}^{a+1}-x_{1} x_{3}, x_{3}^{a}-x_{2} x_{4}$, $x_{1} x_{2}^{a}-x_{4}^{2}$ and $x_{2}^{a} x_{3}^{a-1}-x_{1} x_{4}$. Here $\mathbf{v}=\left(a^{2}+a-1, a+1, a+2, a^{2}+a-1\right)$. Let $g$ be the greatest common divisor of the entries of $\mathbf{a}+m \mathbf{v}$. Then $g$ divides $\left(2 a^{2}+a-1\right)-\left(2 a^{2}+a-2\right)$, so $g=1$. By Theorem 2.7 the monomial curve $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay if and only if $a=2$. Consequently the projective monomial curve $\overline{C(8+5 m, 5+3 m, 7+4 m, 9+5 m)}$ is arithmetically Cohen-Macaulay for every $m \geq 0$. If $a>2$, then the monomial curve $\overline{C(\mathbf{a}+m \mathbf{v})}$ is not arithmetically Cohen-Macaulay for every $m \geq 0$.

Given a polynomial $f \in K\left[x_{1}, \ldots, x_{4}\right]$, we shall denote by $f^{h}$ the homogenization of $f$ with respect to the variable $x_{0}$. The next corollary provides a generating set for $I^{h}(\mathbf{a}+m \mathbf{v})$ under the conditions of Theorem 2.7

Corollary 2.9. Let $d_{2} \geq d_{21}+d_{23}$ and $a_{4}+m v_{4}>a_{i}+m v_{i}$ for all $i<4$. Suppose that the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime. If $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay, then $G^{h}:=\left\{f_{i}^{h} \mid 1 \leq i \leq 5\right\}$ is the reduced Gröbner basis for $I^{h}(\mathbf{a}+$ $m \mathbf{v}$ ) with respect to the degree reverse lexicographic order $<_{0}$ on $R\left[x_{0}\right]$ extended from $R$ with $x_{2}>_{0} x_{1}>_{0} x_{3}>_{0} x_{4}>_{0} x_{0}$.
Proof. By Proposition 2.5, $G$ is the reduced Gröbner basis for $I(\mathbf{a}+m \mathbf{v})$ with respect to $<$. From [6, Lemma 1.1] the set

\begin{aligned}
& G^{h}=\left\{x_{1}^{d_{1}+m}-x_{0}^{d_{1}-d_{13}-d_{14}} x_{3}^{d_{13}} x_{4}^{d_{14}+m}, x_{2}^{d_{2}}-x_{0}^{d_{2}-d_{21}-d_{23}} x_{1}^{d_{21}} x_{3}^{d_{23}},\right. \\
& x_{3}^{d_{3}}-x_{0}^{d_{3}-d_{32}-d_{34}} x_{2}^{d_{32}} x_{4}^{d_{34}}, x_{1}^{d_{41}+m} x_{2}^{d_{42}}-x_{0}^{d_{41}+d_{42}-d_{4}} x_{4}^{d_{4}+m}, \\
& \left.x_{2}^{d_{42}} x_{3}^{d_{13}}-x_{0}^{d_{13}+d_{42}-d_{21}-d_{34}} x_{1}^{d_{21}} x_{4}^{d_{34}}\right\}
\end{aligned}
$$

is the reduced Gröbner basis for $I^{h}(\mathbf{a}+m \mathbf{v})$ with respect to $<_{0}$.
Next we consider the case that $d_{2}<d_{21}+d_{23}$.
Notation 2.10. We shall denote by $w$ the minimum element of

$$
\left\{l \in \mathbb{N} \mid d_{1}+m-l d_{21} \leq 0\right\} \cup\left\{l \in \mathbb{N} \mid d_{3}-l d_{23} \leq 0\right\}
$$

Notice that $w \geq 2$.
Consider the binomials

$$
\begin{gathered}
p_{i}=x_{2}^{(i+1) d_{2}-d_{32}} x_{3}^{d_{3}-(i+1) d_{23}}-x_{1}^{(i+1) d_{21}} x_{4}^{d_{34}}, 0 \leq i \leq w-2 \\
q_{i}=x_{1}^{d_{1}+m-(i+1) d_{21}} x_{2}^{(i+1) d_{2}-d_{32}}-x_{3}^{i d_{23}} x_{4}^{d_{4}+m}, 0 \leq i \leq w-2
\end{gathered}
$$

and

$$
r= \begin{cases}x_{2}^{w d_{2}-d_{32}}-x_{1}^{w d_{21}} x_{3}^{w d_{23}-d_{3}} x_{4}^{d_{34}}, & \text { if } d_{1}+m-w d_{21}>0 \\ x_{2}^{w d_{2}-d_{32}}-x_{1}^{w d_{21}-d_{1}-m} x_{3}^{(w-1) d_{23}} x_{4}^{d_{4}+m}, & \text { if } d_{1}+m-w d_{21} \leq 0\end{cases}
$$

Note that $p_{0}=f_{5}$ and $q_{0}=f_{4}$.
Proposition 2.11. Let $d_{2}<d_{21}+d_{23}$ and suppose that the following conditions hold.
(1) $d_{1} \geq d_{13}+d_{14}$.
(2) $d_{3} \geq d_{32}+d_{34}$.
(3) $d_{21}+d_{34} \leq d_{13}+d_{42}$.
(4) $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34} \geq 0$.
(5) $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32} \geq 0$.
(6) $w\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34} \geq 0$ when $d_{1}+m-w d_{21}>0$.
(7) $w\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32} \geq 0$ when $d_{1}+m-w d_{21} \leq 0$.

If the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime, then

$$
T=G \cup\left\{p_{i} \mid 1 \leq i \leq w-2\right\} \cup\left\{q_{i} \mid 1 \leq i \leq w-2\right\} \cup\{r\}
$$

is a Gröbner basis for $I(\mathbf{a}+m \mathbf{v})$ with respect to the degree reverse lexicographic order $<$ on $R$ with $x_{2}>x_{1}>x_{3}>x_{4}$.

Proof. Notice that the polynomials $p_{i}, q_{i}, r$ are in the ideal $I(\mathbf{a}+m \mathbf{v})$ by computation, for every $1 \leq i \leq w-2$. Here $\mathrm{in}_{<}\left(f_{1}\right)=x_{1}^{d_{1}+m}$, $\mathrm{in}_{<}\left(f_{2}\right)=x_{1}^{d_{21}} x_{3}^{d_{23}}$ and $\operatorname{in}_{<}\left(f_{3}\right)=x_{3}^{d_{3}}$. For every $0 \leq i \leq w-2$ we have that $i+1 \leq w-1$, thus $(i+1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34} \geq(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}$ since $d_{2}-d_{21}-d_{23}<0$. So $(i+1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34} \geq 0$ and therefore $(i+$ 1) $d_{2}-d_{32}+d_{3}-(i+1) d_{23} \geq(i+1) d_{21}+d_{34}$. Thus in ${ }_{<}\left(p_{i}\right)=x_{2}^{(i+1) d_{2}-d_{32}} x_{3}^{d_{3}-(i+1) d_{23}}$, for every $0 \leq i \leq w-2$. Since $i+1 \leq w-1$ for every $0 \leq i \leq w-2$, we have that $(i+1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32} \geq(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+$ $d_{23}-d_{4}-d_{32}$ and therefore $(i+1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32} \geq 0$. Thus $d_{1}-(i+1) d_{21}+(i+1) d_{2}-d_{32} \geq i d_{23}+d_{4}$, so in in $_{<}\left(q_{i}\right)=x_{1}^{d_{1}+m-(i+1) d_{21}} x_{2}^{(i+1) d_{2}-d_{32}}$ for every $0 \leq i \leq w-2$. Finally $\mathrm{in}_{<}(r)=x_{2}^{w d_{2}-d_{32}}$. Since in $\mathrm{in}_{<}\left(f_{1}\right)$ and $\mathrm{in}_{<}\left(f_{3}\right)$ are relatively prime, we deduce that $S\left(f_{1}, f_{3}\right) \xrightarrow{T} 0$. Similarly $S\left(f_{1}, p_{i}\right) \xrightarrow{T} 0$, for every $0 \leq i \leq w-2, S\left(f_{1}, r\right) \xrightarrow{T} 0, S\left(f_{2}, r\right) \xrightarrow{T} 0, S\left(f_{3}, q_{i}\right) \xrightarrow{T} 0$, for every $0 \leq i \leq w-2$, and $S\left(f_{3}, r\right) \xrightarrow{T} 0$.

We have that $S\left(f_{1}, f_{2}\right)=x_{1}^{d_{11}+m} x_{2}^{d_{2}}-x_{3}^{d_{3}} x_{4}^{d_{14}+m} \xrightarrow{f_{4}} x_{2}^{d_{32}} x_{4}^{d_{4}+m}-x_{3}^{d_{3}} x_{4}^{d_{14}+m} \xrightarrow{f_{3}}$ 0 . We will show that $S\left(f_{1}, q_{i}\right) \xrightarrow{T} 0$, for every $0 \leq i \leq w-2$. It holds that

Also $S\left(f_{2}, f_{3}\right)=x_{1}^{d_{21}} x_{2}^{d_{32}} x_{4}^{d_{34}}-x_{2}^{d_{2}} x_{3}^{d_{13}} \xrightarrow{f_{5}} 0$. Next we will show that $S\left(f_{2}, p_{i}\right) \xrightarrow{T}$ 0 , for every $0 \leq i \leq w-2$. If $0 \leq i \leq w-3$, then $S\left(f_{2}, p_{i}\right)=x_{1}^{(i+2) d_{21}} x_{4}^{d_{34}}-$ $x_{2}^{(i+2) d_{2}-d_{32}} x_{3}^{d_{3}-(i+2) d_{23}} \xrightarrow{p_{i+1}} 0$. Suppose that $i=w-2$ and let $d_{3}-w d_{23} \leq 0$. Then $S\left(f_{2}, p_{w-2}\right)=x_{1}^{w d_{21}} x_{3}^{w d_{23}-d_{3}} x_{4}^{d_{34}}-x_{2}^{w d_{2}-d_{32}}$. Suppose first that $d_{1}+m-w d_{21}>0$. Then $S\left(f_{2}, p_{w-2}\right)=-r$ and therefore $S\left(f_{2}, p_{w-2}\right) \xrightarrow{r} 0$. Suppose now that $d_{1}+m-$ $w d_{21} \leq 0$, then $S\left(f_{2}, p_{w-2}\right) \xrightarrow{r} x_{1}^{w d_{21}-d_{1}} x_{3}^{w d_{23}-d_{3}} x_{4}^{d_{34}} f_{1} \xrightarrow{f_{1}} 0$. If $0 \leq i \leq w-3$, then $S\left(f_{2}, q_{i}\right)=$ $x_{1}^{d_{1}+m-(i+2) d_{21}} x_{2}^{(i+2) d_{2}-d_{32}}-x_{3}^{(i+1) d_{23}} x_{4}^{d_{4}+m} \xrightarrow{q_{i+1}} 0$. Suppose that $i=w-2$. If


If $d_{1}+m-w d_{21}>0$, then $S\left(f_{2}, q_{w-2}\right)=x_{3}^{(w-1) d_{23}} x_{4}^{d_{4}+m}-x_{1}^{d_{1}+m-w d_{21}} x_{2}^{w d_{2}-d_{32}} \xrightarrow{r}$ $-x_{3}^{w d_{23}-d_{3}} x_{4}^{d_{34}} f_{1} \xrightarrow{f_{1}} 0$. For every $0 \leq i \leq w-2$ we have that

We have that $S\left(p_{i}, p_{j}\right)=x_{1}^{(i+1) d_{21}} x_{4}^{d_{34}}\left(x_{1}^{(j-i) d_{21}} x_{3}^{(j-i) d_{23}}-x_{2}^{(j-i) d_{2}}\right) \xrightarrow{f_{2}}$ 0 . We will show that $S\left(p_{i}, r\right) \xrightarrow{T} 0$. If $d_{1}+m-w d_{21}>0$, then

Next we will show that $S\left(q_{i}, q_{j}\right) \xrightarrow{T} 0$, where $0 \leq i \leq w-2$ and $0 \leq j \leq w-2$ with $i<j$. We have that $S\left(q_{i}, q_{j}\right)=x_{3}^{i d_{23}} x_{4}^{d_{4}+m}\left(x_{1}^{(j-i) d_{21}} x_{3}^{(j-i) d_{23}}-x_{2}^{(j-i) d_{2}}\right) \xrightarrow{f_{2}} 0$. We will prove that $S\left(q_{i}, r\right) \xrightarrow{T} 0$. If $d_{1}+m-w d_{21} \leq 0$, then

Theorem 2.12. Let $d_{2}<d_{21}+d_{23}$. Suppose that $a_{4}+m v_{4}>a_{i}+m v_{i}$ for all $i<4$ and the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime. Then $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay if and only if the following conditions hold:
(1) $d_{1} \geq d_{13}+d_{14}$;
(2) $d_{3} \geq d_{32}+d_{34}$;
(3) $d_{21}+d_{34} \leq d_{13}+d_{42}$;
(4) $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34} \geq 0$;
(5) $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32} \geq 0$;
(6) $w\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34} \geq 0$ when $d_{1}+m-w d_{21}>0$;
(7) $w\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32} \geq 0$ when $d_{1}+m-w d_{21} \leq 0$.

Proof. $(\Leftarrow)$ Suppose that (1), (2), (3), (4), (5), (6) and (7) are true. By Proposition [2.11] $T$ is a Gröbner basis for $I(\mathbf{a}+m \mathbf{v})$ with respect to the degree reverse lexicographic order $<$ with $x_{2}>x_{1}>x_{3}>x_{4}$. Since $x_{4}$ does not divide the initial monomial of any binomial in $T$, we have, from Theorem 2.6. that $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay.
$(\Rightarrow)$ Suppose that $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay. Since the binomials $f_{1}, f_{3}$ and $f_{5}$ are indispensable of $I(\mathbf{a}+m \mathbf{v})$, they belong to the reduced Gröbner basis of $I(\mathbf{a}+m \mathbf{v})$ with respect to $<$. Consequently (1), (2) and (3) are true. Suppose that $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}<0$. Then the binomial $p_{w-2}$ belongs to $I(\mathbf{a}+m \mathbf{v})$ and $\operatorname{in}_{<}\left(p_{w-2}\right)=x_{1}^{(w-1) d_{21}} x_{4}^{d_{34}}$. Note that $(w-1) d_{21}<d_{1}+m$ by definition of $w$. Since $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically CohenMacaulay, there is a binomial $B \in I(\mathbf{a}+m \mathbf{v})$ such that $\mathrm{in}_{<}(B)$ divides $x_{1}^{(w-1) d_{21}}$, a contradiction to the fact that the monomial $x_{1}^{d_{1}+m}$ is indispensable. Assume that $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32}<0$. Then the binomial $q_{w-2}$ belongs to $I(\mathbf{a}+m \mathbf{v})$ and $\mathrm{in}_{<}\left(q_{w-2}\right)=x_{3}^{(w-2) d_{23}} x_{4}^{d_{4}+m}$. Note that $(w-2) d_{23}<d_{3}$ by definition of $w$. Since $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay, there is a binomial $u \in I(\mathbf{a}+m \mathbf{v})$ such that $\mathrm{in}_{<}(u)$ divides $x_{3}^{(w-2) d_{23}}$, a contradiction to the fact that the monomial $x_{3}^{d_{3}}$ is indispensable. Suppose that $d_{1}+m-w d_{21}>0$ and let $w\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}<0$. Then the binomial $r$ belongs to $I(\mathbf{a}+m \mathbf{v})$ and $\operatorname{in}_{<}(r)=x_{1}^{w d_{21}} x_{3}^{w d_{23}-d_{3}} x_{4}^{d_{34}}$. Since $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay, there is a binomial $B \in I(\mathbf{a}+m \mathbf{v})$ such that $\mathrm{in}_{<}(B)$ divides $x_{1}^{w d_{21}} x_{3}^{w d_{23}-d_{3}}$. Thus $B=x_{1}^{b_{1}} x_{3}^{b_{3}}-x_{1}^{c_{1}} x_{2}^{b_{2}} x_{3}^{c_{3}} x_{4}^{b_{4}}$ with $\operatorname{in}_{<}(B)=x_{1}^{b_{1}} x_{3}^{b_{3}}$, where $b_{2} \neq 0$ or and $b_{4} \neq 0$, $b_{1} \leq w d_{21}$ and $b_{3} \leq w d_{23}-d_{3}$. Note that $w d_{21}<d_{1}+m$ and $w d_{23}-d_{3}<d_{23}$ by definition of $w$, so $b_{1}<d_{1}+m$ and $b_{3}<d_{23}$. Moreover $b_{3}<d_{3}$ since $d_{23}<d_{3}$. But $B \in I(\mathbf{a}+m \mathbf{v})$ and $I(\mathbf{a}+m \mathbf{v})$ is generated by the set $\left\{f_{1}, \ldots, f_{5}\right\}$, therefore there are polynomials $A_{i} \in K\left[x_{1}, \ldots, x_{4}\right], 1 \leq i \leq 5$, such that

In the previous equation let $x_{2}=0$ and $x_{4}=0$. Then $x_{1}^{b_{1}} x_{3}^{b_{3}}=A_{1}\left(x_{1}, 0, x_{3}, 0\right) x_{1}^{d_{1}+m}-$ $A_{2}\left(x_{1}, 0, x_{3}, 0\right) x_{1}^{d_{21}} x_{3}^{d_{23}}+A_{3}\left(x_{1}, 0, x_{3}, 0\right) x_{3}^{d_{3}}$, thus $\mathrm{in}_{<}(B)$ is divided by at least one of the monomials $x_{1}^{d_{1}+m}, x_{1}^{d_{21}} x_{3}^{d_{23}}$ and $x_{3}^{d_{3}}$, a contradiction. Suppose that $d_{1}+m-w d_{21} \leq 0$ and let $w\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32}<0$. Then $r$ belongs to $I(\mathbf{a}+m \mathbf{v})$ and $\mathrm{in}_{<}(r)=x_{1}^{w d_{21}-d_{1}-m} x_{3}^{(w-1) d_{23}} x_{4}^{d_{4}+m}$. Since $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay, there is a binomial $u \in I(\mathbf{a}+m \mathbf{v})$ such that $\mathrm{in}_{<}(u)$ divides $x_{1}^{w d_{21}-d_{1}-m} x_{3}^{(w-1) d_{23}}$. Thus $\operatorname{in}_{<}(u)=x_{1}^{e_{1}} x_{3}^{e_{3}}$ where $e_{1} \leq w d_{21}-d_{1}-m$ and $e_{3} \leq(w-1) d_{23}$. Note that $w d_{21}-d_{1}-m<d_{21}$ and $(w-1) d_{23}<d_{3}$ by definition of $w$, so $e_{1}<d_{21}$ and $e_{3}<d_{3}$. Moreover $e_{1}<d_{1}+m$ since $d_{21}<d_{1}+m$. But $u \in I(\mathbf{a}+m \mathbf{v})$ and $I(\mathbf{a}+m \mathbf{v})$ is generated by the set $\left\{f_{1}, \ldots, f_{5}\right\}$, therefore in ${ }_{<}(u)$ is divided by at least one of the monomials $x_{1}^{d_{1}+m}, x_{1}^{d_{21}} x_{3}^{d_{23}}$ and $x_{3}^{d_{3}}$, a contradiction.

Example 2.13. Let $\mathbf{a}=(19,29,26,43)$, then $C(\mathbf{a})$ is a Gorenstein non-complete intersection monomial curve and $I(\mathbf{a})$ is minimally generated by $x_{1}^{5}-x_{3}^{2} x_{4}, x_{2}^{4}-$ $x_{1}^{2} x_{3}^{3}, x_{3}^{5}-x_{2}^{3} x_{4}, x_{1}^{3} x_{2}-x_{4}^{2}, x_{2} x_{3}^{2}-x_{1}^{2} x_{4}$. Here $\mathbf{v}=(11,13,10,11), w=2$ and $d_{1}+m-$ $w d_{21}=m+1>0$. Suppose first that $m \leq 7$, then $43+11 m=\max \{19+11 m, 29+$
$13 m, 26+10 m, 43+11 m\}$. We have that $w\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}=-1<0$, so from Theorem 2.12 the monomial curve $\overline{C(\mathbf{a}+m \mathbf{v})}$ is not arithmetically CohenMacaulay for $m \leq 7$ whenever $\operatorname{gcd}(19+11 m, 29+13 m, 26+10 m, 43+11 m)=1$. Assume that $m>7$, then $29+13 m=\max \{19+11 m, 29+13 m, 26+10 m, 43+11 m\}$. Let $\mathbf{b}=\left(b_{1}, \ldots, b_{4}\right)$ with $b_{1}=26+10 m, b_{2}=19+11 m, b_{3}=43+11 m, b_{4}=$ $29+13 m$. Note that $b_{4}=\max \left\{b_{1}, \ldots, b_{4}\right\}$. Then $I(\mathbf{b})$ is minimally generated by $x_{1}^{5}-x_{3} x_{4}^{3}, x_{2}^{5+m}-x_{1}^{2} x_{3}^{1+m}, x_{3}^{2+m}-x_{2}^{3+m} x_{4}, x_{1}^{3} x_{2}^{2}-x_{4}^{4}, x_{2}^{2} x_{3}-x_{1}^{2} x_{4}$. Since $x_{3}^{2+m}-$ $x_{2}^{3+m} x_{4} \in I(\mathbf{b})$, we have, from Theorem 2.7 that for every $m>7$ the monomial curve $\overline{C(\mathbf{b})}$ is not arithmetically Cohen-Macaulay whenever $\operatorname{gcd}\left(b_{1}, b_{2}, b_{3}, b_{4}\right)=1$.
Example 2.14. Let $\mathbf{a}=\left(a^{2}+5 a, 7 a+6,6 a+1,3 a^{2}+3 a-2\right)$ where $a>2$ is an even integer. Then $C(\mathbf{a})$ is a Gorenstein non-complete intersection monomial curve and $I(\mathbf{a})$ is minimally generated by $x_{1}^{3}-x_{3}^{2} x_{4}, x_{2}^{a}-x_{1} x_{3}^{a}, x_{3}^{a+2}-x_{2} x_{4}^{2}, x_{1}^{2} x_{2}^{a-1}-$ $x_{4}^{3}, x_{2}^{a-1} x_{3}^{2}-x_{1} x_{4}^{2}$. Here $\mathbf{v}=\left(a^{2}+a, 3 a+2,2 a+1, a^{2}+a\right), w=2$ and $d_{1}+m-w d_{21}=$ $m+1>0$. It holds that $w\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}=a-3>0$ and $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32}=a-2>0$, so, from Theorem 2.12, for every $m \geq 0$ the monomial curve $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay whenever the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime.
Example 2.15. Let $\mathbf{a}=(1191,1239,582,2303)$, then $C(\mathbf{a})$ is a Gorenstein noncomplete intersection monomial curve and $I(\mathbf{a})$ is minimally generated by $x_{1}^{16}-$ $x_{3}^{9} x_{4}^{6}, x_{2}^{11}-x_{1}^{9} x_{3}^{5}, x_{3}^{14}-x_{2} x_{4}^{3}, x_{1}^{7} x_{2}^{10}-x_{4}^{9}$ and $x_{2}^{10} x_{3}^{9}-x_{1}^{9} x_{4}^{3}$. Notice that $\mathbf{v}=$ $(149,141,42,149)$. Suppose first that $m \leq 2$, then $w=2$ and $d_{1}+m-w d_{21}=$ $m-2 \leq 0$. We have that $w\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32}=5>0$ and $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}=7>0$. By Theorem [2.12, for every $m \leq 2$ the monomial curve $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay whenever the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime. Suppose now that $m>2$, then $w=3$ and $d_{1}+m-w d_{21}=m-11$. Assume that $m \leq 11$, then $d_{1}+$ $m-w d_{21} \leq 0$. We have that $w\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32}=2>0$ and $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}=4>0$. By Theorem 2.12, the monomial curve $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay for every $2<m \leq 11$ whenever the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime. Suppose that $m>11$, then $d_{1}+m-w d_{21}>0$. We have that $w\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}=1>0$ and $(w-1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32}=5>0$. By Theorem 2.12, the monomial curve $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay for every $m>11$ whenever the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime.

Finally we provide a generating set for $I^{h}(\mathbf{a}+m \mathbf{v})$ under the conditions of Theorem 2.12,

Corollary 2.16. Let $d_{2}<d_{21}+d_{23}$. Suppose that $a_{4}+m v_{4}>a_{i}+m v_{i}$ for all $i<4$ and the entries of $\mathbf{a}+m \mathbf{v}$ are relatively prime. If $\overline{C(\mathbf{a}+m \mathbf{v})}$ is arithmetically Cohen-Macaulay, then $T^{h}=G^{h} \cup\left\{p_{i}^{h} \mid 1 \leq i \leq w-2\right\} \cup\left\{q_{i}^{h} \mid 1 \leq i \leq w-2\right\} \cup\left\{r^{h}\right\}$ is a Gröbner basis for $I^{h}(\mathbf{a}+m \mathbf{v})$ with respect to the degree reverse lexicographic order $<_{0}$ on $R\left[x_{0}\right]$ extended from $R$ with $x_{2}>_{0} x_{1}>_{0} x_{3}>_{0} x_{4}>_{0} x_{0}$.
Proof. We have that

$$
r^{h}=x_{2}^{w d_{2}-d_{32}}-x_{0}^{w\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32}} x_{1}^{w d_{21}-d_{1}-m} x_{3}^{(w-1) d_{23}} x_{4}^{d_{4}+m}
$$

when $d_{1}+m-w d_{21} \leq 0$, while

$$
r^{h}=x_{2}^{w d_{2}-d_{32}}-x_{0}^{w\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}} x_{1}^{w d_{21}} x_{3}^{w d_{23}-d_{3}} x_{4}^{d_{34}}
$$

when $d_{1}+m-w d_{21}>0$. From Proposition 2.11 the set $T$ is a Gröbner basis for $I(\mathbf{a}+m \mathbf{v})$ with respect to $<$. By [6, Lemma 1.1], $T^{h}=\left\{f_{i}^{h} \mid 1 \leq i \leq 5\right\} \cup\left\{r^{h}\right\} \cup$ $\left\{x_{2}^{(i+1) d_{2}-d_{32}} x_{3}^{d_{3}-(i+1) d_{23}}-x_{0}^{(i+1)\left(d_{2}-d_{21}-d_{23}\right)+d_{3}-d_{32}-d_{34}} x_{1}^{(i+1) d_{21}} x_{4}^{d_{34}} \mid 1 \leq i \leq w-\right.$ $2\} \cup\left\{x_{1}^{d_{1}+m-(i+1) d_{21}} x_{2}^{(i+1) d_{2}-d_{32}}-x_{0}^{(i+1)\left(d_{2}-d_{21}-d_{23}\right)+d_{1}+d_{23}-d_{4}-d_{32}} x_{3}^{i d_{23}} x_{4}^{d_{4}+m} \mid 1 \leq\right.$ $i \leq w-2\}$ is a Gröbner basis for $I^{h}(\mathbf{a}+m \mathbf{v})$ with respect to $<_{0}$.
