# CIRCULAR SYMMETRY-BREAKING AND TOPOLOGICAL NOETHER CURRENTS 

J MORAVA


#### Abstract

We propose a toy model for the algebraic topology of bubbling as circular symmetry-breaking, in terms of Noether currents and cobordism of manifolds with circle actions free along boundaries. This leads to an interpretation of Planck's radiation law [9](%C2%A72.4), [13] as expressing the loss of a Noether symmetry when a bubble $$
\left|\left[S^{2} / / \mathbb{T}\right]\right| \rightarrow \mathrm{pt}
$$ (analogous to blowing up or down in projective geometry) collapses; $c f$ the von Kármán street of sparks left when a candle flame wisps out [15.


1 In these notes 'a space $X$ with circle action' will usually mean the geometric realization $|X / \mathbb{T}|:=|[X / \mathbb{T}]|$ of the topological transformation groupoid defined by an action of the circle group $\mathbb{T}$ on the space $X$. The collapse map

$$
[X / \mathbb{T}] \rightarrow[\mathrm{pt} / \mathbb{T}]
$$

thus defines a ring homomorphism

$$
H_{\mathbb{T}}^{*}(\mathrm{pt}) \cong \mathbb{Z}[c] \rightarrow H_{\mathbb{T}}^{*}(X)
$$

and therefore a natural characteristic class in the equivariant cohomology [3] (§8) of $[X / \mathbb{T}]$, which I suggest calling, the (topological) Noether charge of the space (ie topological groupoid) $[X / \mathbb{T}]$, ie with circle action $\mathbb{1}$. The universal example $E \mathbb{T}$ then has charge $c \in H^{2}(B \mathbb{T})$.

Since Gauss, the Chern class $c$ is understood as a measure of curvature. On the other hand, the integral Federer-de Rham current $b \in H_{2}(B \mathbb{T}, \mathbb{Z})$ is (using Quillen's conventions) the class $\left[s^{-1}(0)\right]$ of the zero-locus of the canonical line bundle over $\mathbb{C} P^{\infty}$; under cap product it represents a Lefschetz hyperplane intersection operator, a $\delta$-function supported by the codimension two cycle $\mathbb{C} P^{n-1} \subset \mathbb{C} P^{n}, n \rightarrow \infty$.

Kronecker duality pairs these by integration, but both terms make sense as elements of the (torsion-free) Swan - Tate cohomology $t_{\mathbb{T}} H \mathbb{Z} \cong \mathbb{Z}\left[c^{ \pm 1}\right]$, where they can be compared over $\mathbb{Q}$.

[^0]2 The Swan-Tate cohomology $t_{\mathbb{G}} E$ (of a complex-oriented equivariant $E_{\infty}$ ring-spectrum $E$ ) is defined for any compact Lie group $G$, but when $G$ is $\mathbb{T}$, as below, things simplify considerably, for $t_{\mathbb{T}} H$ is then the periodic cyclic homology of the singular cochain algebra [1, 7, 11. This account is concerned mostly with the structure of (the coefficient ring of) $t_{\mathbb{T}} H \mathbb{Z}$, but because $M U=E$ is the (torsion-free) universal example, it is convenient to start there (or skip to $\S 2.3$ ).
2.1 If $[X]$ is a compact cx-oriented $2 d$-dimensional smooth manifold with circle action, perhaps with boundary, such that the restriction of the circle action to the boundary is free, ie making the boundary quotient a $2(d-1)$ manifold endowed with a canonical circle bundle, it seems reasonable to call $[X / \mathbb{T}]$ a manifold with meromorphic circle action Then

$$
t_{\mathbb{T}}^{*} M U^{*} \ni[X / \mathbb{T}] \mapsto \partial_{\mathbb{T}}[X / \mathbb{T}]:=[(\partial X) / \mathbb{T} \rightarrow B \mathbb{T}] \in M U_{*-2} B \mathbb{T},
$$

defines the boundary operator in the diagram ${ }^{2}$

where $b \in \operatorname{Hom}_{\mathrm{FG}}\left(F_{E}, \mathbb{G}_{m}\right)$, ie satisfying

$$
b(T)=1+\Sigma_{k \geq 1} b_{k} T^{k}, b\left(T_{0}+_{E} T_{1}\right)=b\left(T_{0}\right) \cdot b\left(T_{1}\right),
$$

is the Ravenel-Wilson-Katz Cartier generating character for the formal group $F_{E}$ defined by the cx orientation of $E$.
2.2 The product of two such manifolds, ie with circle actions free along the boundary, is a manifold with $\mathbb{T} \times \mathbb{T}$ structure; restricting along the diagonal $\mathbb{T} \rightarrow \mathbb{T} \times \mathbb{T}$ defines a manifold $[(X \times Y) / \mathbb{T}]$ with circle action, again free along the boundary

$$
\partial\left(X_{0} \times X_{1}\right)=X_{0} \times \partial X_{1} \cup_{\partial X_{0} \times \partial X_{1}} \partial X_{0} \times X_{1},
$$

defining a ring structure on $t_{\mathbb{T}}^{*} M U$. One wonders about Massey products.

### 2.3 Examples $E=H \mathbb{Z}$ \& $K$

If $G$ is a finite group, $t_{G}^{*} K \cong R_{\mathbb{C}}(G) \otimes \mathbb{Q}$, whereas $t_{\mathbb{T}}^{*} K \cong(1-q)^{-1} K_{\mathbb{T}}$; where $K_{\mathbb{T}} \cong R_{\mathbb{C}}(\mathbb{T})$ is Atiyah - Segal $\mathbb{T}$-equivariant $K$-theory (of a point), and $q: \mathbb{T} \subset \mathbb{C}^{\times}$sends $q \rightarrow e^{i \theta}$.

Recall from [3(Prop 3.4) that localization kills (c)-torsion, so

$$
t_{\mathbb{T}} H^{*}[M / \mathbb{T}] \cong H \mathbb{Z}^{*}\left(\mathrm{Fix}_{\mathbb{T}} M\right) \otimes t_{\mathbb{T}} H \mathbb{Z}
$$

[^1]$i e$ with the grading scrambled by weights coming from normal bundles [3](%C2%A77); see [5] for $t_{\mathbb{Z}_{2}} H \mathbb{F}_{2}$. Re $\mathrm{SU}(2)$, recall $B \mathrm{SU}(2) \cong \mathbb{H} P^{\infty}$ is not an $H$-space.
2.4 When $E=H \mathbb{Z}$ is Eilenberg - Mac Lane cohomology, we now have an exact sequence
\[

$$
\begin{aligned}
& 0 \longrightarrow H^{*} B \mathbb{T}=\mathbb{Z}[c] \longrightarrow t_{\mathbb{T}} H \mathbb{Z}=\mathbb{Z}\left[c^{ \pm 1}\right] \xrightarrow{\partial_{\mathbb{T}}} H_{*-2} B \mathbb{T}=\Gamma\left[b_{*}\right] \longrightarrow 0 \\
& 0 \longrightarrow c^{3} \longrightarrow c^{3} \longrightarrow 0 \\
& 0 \longrightarrow c^{2} \longrightarrow c^{2} \longrightarrow 0 \\
& 0 \longrightarrow c \longrightarrow 0
\end{aligned}
$$
\]

$$
\begin{aligned}
& 0 \longrightarrow 0 \longrightarrow c^{-2} \longrightarrow b_{1} \\
& 0 \longrightarrow 0 \longrightarrow c^{-3} \longrightarrow b_{2} \ldots
\end{aligned}
$$

in which $\partial_{\mathbb{T}}^{0}:(\{0\} \in \mathbb{C}) \rightarrow(\mathbb{C}-\{0\})=\mathbb{C}^{\times} \in$ free $\mathbb{T}$-spaces. The boundary operator thus defines a Rota-Baxter structure: invertible in negative degree and zero in positive degree.

Here $\Gamma_{*}[b]=\mathbb{Z}\left[b_{i} \mid b_{i} b_{k}=(i, k) b_{I+k}\right]$ is the free divided power algebra on one generator; thus $b_{k} \mapsto b^{k} / k!\in \Gamma_{*}(b) \otimes \mathbb{Q} \cong \mathbb{Q}[b]$. The grading forces this sequence to split, as

$$
t_{\mathbb{T}}^{*} H=\mathbb{Z}[c] \oplus c^{-1} \mathbb{Z}\left[c^{-1}\right]
$$

with $\partial_{\mathbb{T}} c^{-k}=b_{k-1}$, defining a representation of a Heisenberg group [8](%C2%A73).
It is useful to think of $c^{-1}$ as the two-disk $D^{2}$ with its usual circle action; then

$$
\partial_{\mathbb{T}} c^{0}=0, \partial_{\mathbb{T}} c^{-1}=1, \partial_{\mathbb{T}} c^{-2}=\left[S^{3} / \mathbb{T} \cong S^{2} \rightarrow \mathbb{C} P^{\infty} \cong B \mathbb{T}\right]=b \in M U_{2} B \mathbb{T},
$$

making $\left[D^{2} / \mathbb{T}\right]$ to $\left[S^{2} / \mathbb{T}\right]$ much as open are to closed strings.

## §3 Some applications

3.1 The degrading functor $\left.V_{*} \mapsto V_{*} \otimes \mathbb{Z}((T))\right|_{0}:=V\|T\| \in \mathbb{Z}((T))-\operatorname{Mod}$ is defined on $\mathbb{Z}$ - graded modules by

$$
\operatorname{Hom}^{d}(V, W) \ni \phi \mapsto\left[\Sigma_{i>-\infty} v_{i} T^{i} \rightarrow T^{d} \Sigma_{i>-\infty} \phi\left(v_{i}\right) T^{i}\right], v_{i} \in V_{i}
$$

so we have from [5](%C2%A7I) that

$$
b=-T^{-1} \log \left(1-c^{-1} T\right), c=-b^{-1} B^{-}(-b T) \in\left(t_{\mathbb{T}} H \mathbb{Q}\right)\|T\|
$$

with Bernoulli operator $B^{-}(D)=\frac{D}{e^{D}-1}$, because

$$
\left(1-c^{-1} T\right)^{-1}=\exp (b T)
$$

(and more generally in the Lazard ring.) Note that $B_{k} / k=h_{k}$ are the cumulants of the uniform distribution.

These relations interpret $b$ as a de Rham current corresponding to the Noether charge $c$, ie as something like its supporting cycle; but they make sense only after rationalizing. In particular, $b$ and $c$ have opposed natural variances. In this formalism $T$ is a kind of place-holder for a scaling action of Adams' operations in $\mathbb{N}^{\times}$, interpreted as an asymptotic expansion [10].
3.2 The topological Mellin transform identifies $\operatorname{Spec} t_{\mathbb{T}} H \mathbb{Z}$ as a localization $\mathbb{G}_{m}=\operatorname{Spec} \mathbb{Z}\left[c^{ \pm 1}\right]$ of the ungraded cohomology $H^{*} B \mathbb{T} \cong H^{*} \mathbb{C} P^{\infty}$ :

Proposition The differential form [9](§2.1 Proposition)

$$
d(b T)=-d \log \left(1-c^{-1} T\right) \in \Omega_{\mathbb{Z}}^{1}\left(t_{\mathbb{T}} H \mathbb{Z}\right)
$$

maps by $c^{-1} T \rightarrow e^{\varepsilon}$ to the tempered distribution-valued one-form

$$
d(b T)=\frac{d\left(c^{-1} T\right)}{1-c^{-1} T}=\frac{e^{\varepsilon} d \varepsilon}{1-e^{\varepsilon}}=\operatorname{li}_{0}(\varepsilon) \cdot d \varepsilon=d \mathrm{li}_{1}(\varepsilon) \in \mathcal{S}^{\prime}(\mathbb{R}) \cdot d \varepsilon \cong \Omega_{\mathrm{temp}}^{1}(\mathbb{R})
$$

where

$$
\operatorname{li}_{0}(x)=-\left(1-e^{-x}\right)^{-1}, \operatorname{li}_{1}(x)=-\log \left|1-e^{x}\right|
$$

3.3 We interpret $d b$ as Haar measure, translation-invariant with respect to $+_{\mathbb{G}_{m}}$, pulled back along the exponential map to the Lie algebra of $\mathbb{G}_{m}$, defining a moment map $b: \mathbb{G}_{m} \rightarrow \operatorname{Lie}_{\mathbb{T}}$ (as in $[3](\S 7)$ ) for the circle. We can regard $b$ as defining a transcendental extension of $\mathbb{C}(c)$.
The resulting linear operator [14]

$$
\pi_{!}^{\mathbb{G}_{m}}: \Omega_{\mathbb{Z}}^{1}\left(t_{\mathbb{T}} H \mathbb{Z}\right) \rightarrow \mathcal{S}^{\prime}(\mathbb{R}) \cdot d \varepsilon
$$

sends one-forms to de Rham Harvey-Lawson one-currents on the $\varepsilon$-line, defining a pairing

$$
\mathcal{S}(\mathbb{R}) \times \mathbb{Z}\left[c^{ \pm 1}\right] \cdot d c \rightarrow \mathbb{R} \cdot d \varepsilon
$$

in which $\varepsilon=-\log c, d \varepsilon=-c^{-1} d c$, suggesting $\varepsilon$ as a measure of topological entropy or information loss.

## 4 Afterthoughts

4.1 Convolutions of tempered distributions are not necessarily tempered, but the holomorphic family

$$
\gamma_{+}^{s}:=\frac{x_{+}^{s-1}}{\Gamma(s)} \in \mathcal{S}^{\prime}(\mathbb{R})\{s\}
$$

of Gel'fand-Silov tempered distributions $(x \in \mathbb{R})$ represents the group of fractional differentiation operations $\partial^{-s}$ on functions such as $B^{-}(x) \sim\left(e^{x}-\right.$ $1)^{-1}=\mathrm{l}_{0}(x)$.
Prop 3 of [6] asserts that the function

$$
\operatorname{li}_{s}(x)=\gamma_{+}^{s} * \operatorname{li}_{0}=\operatorname{Li}_{s}\left(e^{x}\right)=1+\Sigma_{n \geq 1} \frac{e^{n x}}{n^{s}} \in C^{\infty}\left(\mathbb{R}_{<0}\right)\{s\},\left.\operatorname{li}_{s}\right|_{x=0} \mapsto \zeta(s)
$$

(as defined on the negative real line) extends to a holomorphic family $s \mapsto$ $\mathrm{li}_{s} \equiv-\pi \cot \pi s \cdot \gamma_{+}^{s} \in \mathcal{S}^{\prime}(\mathbb{R})\{s\}$ of tempered distributions on the whole real line. Consequently [9](%C2%A72.2)
The divided moments

$$
\gamma_{+}^{s}(\varepsilon) * d b=\left(\gamma_{+}^{s} * d l \mathrm{l}_{1}\right)(\varepsilon)
$$

are tempered distributions.
4.2 Note that the distribution-valued 'measure' $\gamma_{+}^{1}(\varepsilon) * d b(\varepsilon)$ on $\mathbb{R}$ has no 'value' at $x=0$, though the Taylor series of $\mathrm{li}_{s}(x)$ at $s=1$ is

$$
(1-s)^{-1}+\log \left|\frac{x}{e^{x}-1}\right|(1-s)^{0}+\Sigma_{k \geq 1} t_{k} \cdot(1-s)^{k} \ldots
$$

with tempered distributions $t_{*}$.
Nevertheless, these generalized moments may be useful in statistical mechanics. The Stefan/Boltzmann asymptotic expansion 9] (§2.4), 12]

$$
T^{-4} \boldsymbol{\rho} \sim 12 h \kappa^{4} \cdot \gamma_{+}^{4} * d \mathrm{l}_{1}
$$

(for the radiance ${ }^{3} \rho$ of an incandescent body in terms of its temperature) is how we understand the colors of the stars.
