# MIXED TYPE BOUNDARY VALUE PROBLEM OF ELLIPTIC EQUATION IN A THIN DOMAIN

#### Abstract

In this paper, we prove the a priori estimates for two-dimensional second order homogeneous linear elliptic equations in a narrow region. In a crescentshaped area, part of the boundary is subject to an oblique derivative boundary condition, while the other part of the boundary is subject to a Dirichlet boundary condition. We show that, as the crescent-shaped area collapses into a segment under suitable conditions, the boundary value problem obeys uniform Schauder estimates and induces an asymptotic estimate.


## 1. Introduction

In this paper, we investigate second-order elliptic equations in a 2D crescentshaped region with mixed boundary value condition. Consider a function $y=f(x)$ satisfying

A crescent-shaped domain $\Omega$ is defined as

We study the following mixed boundary value problem of linear elliptic equation

The coefficients $A, B, C, D, E, G$ satisfy following conditions

for some positive constants $\lambda, \Lambda$ and $\gamma \in(0,1)$.
Assume that $f$ satisfies

Then we have
Theorem 1.1. Let $u$ be the solution of (1.4). Then there exists $\sigma_{0}>0$ such that for any $\sigma \in\left(0, \sigma_{0}\right]$, one has

where the constant $\bar{C}$ depends only on $\gamma, \lambda, \Lambda$ and $C_{f}$.
The Dirichlet and oblique derivative boundary value problems have been systematically studied in a vast literature. We refer readers to, for example [21, 25, 33] and references therein. Furthermore, mixed type boundary value problems in nonsmooth regions have also been discussed, see [4, 24, 29, 35, 38]. Roughly speaking, the Schauder theory for boundary value problem of second-order elliptic equations says that if all the coefficients and data are Hölder continuous, then the second order Hölder norms of the solution can be estimated by the inhomogeneous term and boundary values. How the constants of estimates depend on the settings of the region, the coefficients and the boundary value is a complicated problem. In this paper, by Theorem 1.1, we confirm that the estimate remains uniform even when the region for the mixed boundary value problem degenerates into a line segment in a specific way. Such an a priori estimate ensures uniform equicontinuity of the derivatives of the solution as the region shrinks. In other words, the rate of change of the solution and its derivatives is bounded. As the region degenerates into a line segment, the variation of the solution and its derivatives along specific directions diminishes. Thus, the solution converges to an asymptotic state. For our mixed boundary value problem, the compatibility conditions are satisfied at the corners. Otherwise, uniform estimates cannot be expected. For example, generically, if Dirichlet conditions are given along $\partial_{0} \Omega$ and $\partial_{+} \Omega$, then normal derivative would blow up as the region shrinks.

To our knowledge, for elliptic boundary value problem in a thin domain, its eigenvalue has been discussed by variational in many works, see $[3,6,18,19,23,27,30$, $32,39,40,42,43]$ and references therein. The motivation for our paper comes from the research of free boundary problems for elliptic conservation law systems. This type free boundary problem of elliptic partial differential equation does not have a variational structure, so we cannot establish the existence of solutions through
variational methods, see $[1,7,8,37]$. We need a solution that complies with the structure of conservation laws, to serve as the starting point of a continuity method, to obtain a general solution, see $[5,9,11,12,13,15,17]$. As the supersonic incoming flow accelerates to the limit speed, the free boundary area after the shock might shrink to a low-dimensional surface, see [2, 14, 16, 26, 28, 31, 34, 41, 44, 45, 46, 47]. In this process, the discussion for a priori estimates and asymptotic behavior of the solution would help us to investigate the flow field and the asymptotic states might play the role of initial solutions for the continuity method.

The organization of this paper is as follows. In Section 2, under the assumptions of local straight boundary condition of $\partial_{+} \Omega$ and normal derivative boundary value condition on $\partial_{0} \Omega$, we proved our local estimate for (1.8). In Section 3, by applying three coordinate transformations, we extend the estimate from Section 2 to the case of general boundary conditions and proved our main theorem. In Section 4, we present a similar conclusion for a weighted norm. In Section 5, we prove an asymptotic estimate as $\|f\|_{C^{2, \gamma}([0,1])} \rightarrow 0$.

## 2. Local Straight Corner

In this section, we assume that the boundary $\partial_{+} \Omega$ satisfies the following straight corner condition:

Thus the boundary condition on $\partial_{0} \Omega$ in (1.4) becomes Neumann boundary condition. Then we have the following theorem.

Theorem 2.1. Let $u$ be the solution of (1.4). Then there exists $\sigma_{0}>0$ such that for any $\sigma \in\left(0, \sigma_{0}\right]$, one has

Remark 2.1. In the construction of barrier function $H$, the condition on the coefficients $D, E$ can be weaken to

\tilde{\mathcal{L}}=A \partial_{\tilde{x} \tilde{x}}+B \partial_{\tilde{x} \tilde{y}}+C \partial_{\tilde{y} \tilde{y}}+f\left(x_{0}\right)\left(D \partial_{\tilde{x}}+E \partial_{\tilde{y}}\right) .
$$

Since

(-1,1) \times(-1 / 2,1 / 2) \subset \tilde{\Omega}_{x_{0}}^{1} \subset(-1,1) \times(0,2), \quad\left\|\partial_{+} \Omega_{x_{0}}^{1}\right\|_{C^{2}, \gamma} \leq \bar{C}
$$

by the standard Schauder estimates, we have that

\|\tilde{w}\|_{C^{2, \gamma}\left(\widetilde{\Omega}_{x_{0}}^{1 / 2}\right)} \leq \bar{C}\left(\|\tilde{g}\|_{C^{\gamma}\left(\widetilde{\Omega}_{x_{0}}^{1}\right)}+\left\|\frac{P_{x_{0}}}{\left(f\left(x_{0}\right)\right)^{2+\gamma}}\right\|_{C^{2, \gamma}\left(\partial_{+} \tilde{\Omega}_{x_{0}}^{1}\right)}+\|\tilde{w}\|_{C^{0}\left(\widetilde{\Omega}_{x_{0}}^{1}\right)}\right), \tag{2.19}
\end{equation*}
$$

where the constant $\bar{C}$ depends only on $\gamma, \lambda, \Lambda$. It is easy to see that

$$

By Lemma 2.2 and the above estimates, (2.19) implies

In the coordinate $(x, y)$, since $x_{0}$ can be arbitrary in $(0,2 / 3)$, above implies

\left|x_{1}-x_{2}\right| \leq \frac{1}{2} \max \left(f\left(x_{1}\right), f\left(x_{2}\right)\right)}} \frac{\left|D^{2} u\left(x_{1}, y_{1}\right)-D^{2} u\left(x_{2}, y_{2}\right)\right|}{\left|\left(x_{1}, y_{1}\right)-\left(x_{2}, y_{2}\right)\right| \gamma} \\
+\|u\|_{C^{2}(\bar{\Omega} \cap\{x \in[0,2 / 3]\})} \leq \bar{C}\|\varphi\|_{C^{2}, \gamma([0,1])} .
\end{aligned}
$$

Consider the following two points

\left(x_{1}, y_{1}\right),\left(x_{2}, y_{2}\right) \in \bar{\Omega} \cap\{x \in[0,2 / 3]\}, \quad\left|x_{1}-x_{2}\right| \geq \frac{1}{2} \max \left(f\left(x_{1}\right), f\left(x_{2}\right)\right)
$$

Since $u_{y}(x, 0)=0$, there holds

& \left|u_{x y}\left(x_{1}, y_{1}\right)-u_{x y}\left(x_{2}, y_{2}\right)\right| \\
\leq & \left|u_{x y}\left(x_{1}, 0\right)-u_{x y}\left(x_{1}, y_{1}\right)\right|+\left|u_{x y}\left(x_{2}, 0\right)-u_{x y}\left(x_{2}, y_{2}\right)\right|+\left|u_{x y}\left(x_{1}, 0\right)-u_{x y}\left(x_{2}, 0\right)\right| \\
\leq & \left.\bar{C}\|\varphi\|_{C^{2}, \gamma([0,1])}\left(y_{1}^{\gamma}+y_{2}^{\gamma}\right) \leq \bar{C}\|\varphi\|_{C^{2}, \gamma([0,1])}\right)\left(x_{1}, y_{1}\right)-\left.\left(x_{2}, y_{2}\right)\right|^{\gamma} .
\end{aligned}
$$

This implies

\end{aligned}

and (1.4)

A u_{x x}+C u_{y y}=-B u_{x y}-D u_{x}-E u_{y} .
$$

Hence for $\sigma_{0}$ small, we can solve $u_{x x}$ and $u_{y y}$ from above two to have

Then a similar argument as $u_{x y}$ yields that

This ends the proof for Theorem 2.1.

## 3. General Case

In this section, we remove the straight corner condition and the restriction $G(x)=$ 0 to complete the proof of Theorem 1.1.

Proof of Theorem 1.1. Theorem 1.1 can be reduced to the situation discussed in Theorem 2.1 through three coordinate transformations.
(1) Change the oblique derivative condition to Neumann boundary condition. Define the trajectory $x(y ; s)$ by

Introduce a new coordinate $(s, z)$ by

for $\sigma_{0}$ small, the map

\mathcal{P}_{1}^{-1}: \bar{\Omega} & \rightarrow \mathcal{P}_{1}^{-1}(\bar{\Omega}) \\
(x, y) & \rightarrow(s, z)
\end{aligned}
$$

is a $C^{2, \gamma}$-diffeomorphism around $[0,1] \times\{0\}$ and $\mathcal{P}_{1}^{-1}([0,1] \times\{0\})=[0,1] \times\{0\}$. It remains to consider the image of $\partial_{+} \Omega$, i.e. $(s, f(x(z ; s)))$. By the coordinate transformation, we have

s=x(z ; s)-\int_{0}^{z} G(x(\lambda ; s)) d \lambda .

Hence on the image of $\partial_{+} \Omega$, we have

This implies $s^{\prime}(x)=1-f^{\prime}(x) G(x)>0$ for $x \in[0,1]$ provided $\sigma_{0}$ is small. From this, we know $x \rightarrow s$ is a $C^{2, \gamma}$-diffeomorphism from $[0,1]$ to $[0,1]$, i.e. the image $\mathcal{P}_{1}^{-1}\left(\partial_{+} \Omega\right)$ can be written by

By a direct computation, the oblique derivative condition of (1.4) becomes

Since the coordinate transformation $\mathcal{P}_{1}$ is a diffeomorphism, we can directly verify that condition (1.7) is preserved, where the constant $C_{f}$ is updated to the new constant $\hat{C}_{f}$. Then, the estimates in the new coordinates naturally induce estimate (1.8). Therefore, we only need to prove the conclusion for the case when $G=0$.
(2) Straighten the boundary $\partial_{+} \Omega=\{(x, f(x)) \mid x \in[0,1]\}$ under the assumption $G=0$. Consider a cut off function $\chi \in C^{\infty}([0,1]) \rightarrow[0,1]$ with

and introduce the following coordinate transformation:

This transformation reduces the domain $\Omega$ to a straight corner domain $\mathcal{P}_{2}(\Omega)$.
(3) To get the estimate for $x \in[1 / 3,1]$, we can use the coordinate transformation

\end{array}\right.

Thus the corner $(x, y)=(1,0)$ is reduced to the origin $O$.
In the next, we explain how to use the above three coordinate transformations to get Theorem 1.1.

The transformation $\mathcal{P}_{1}$ is locally determined by $G$, independent of $f$, and smooth. Thus, the estimate under the new coordinates induces the original estimate. $\mathcal{P}_{3}$ is the same. The only trouble thing is the transformation $\mathcal{P}_{2}$.

For $x_{0} \in \partial \Omega \cap(0,2 / 3]$, let $v, P_{x_{0}}$ be given by (2.3), (2.6) respectively. We first need to show that the estimate (2.10) holds. Denote the elliptic operator in the original coordinate $(x, y)$ by $\mathcal{L}_{0}$, in $(s, z)$ by $\mathcal{L}_{1}$. It can be checked directly that estimate (2.8) and (2.9) hold in ( $s, z$ )-coordinate. In fact, we need compute the Jacobi matrix for the coordinate transformation $\mathcal{P}_{2}$.

Denote

\end{array}\right),  \tag{3.7}\\
\left\{\begin{array}{l}
s_{x x}= \\
s_{x y}=s_{y y}=z_{y y}=0, z_{x y}=\frac{f_{1}^{\prime} f-f_{1} f^{\prime}}{f^{2}}, \\
z_{x x}=\frac{f_{1}^{\prime \prime} f-f_{1} f^{\prime \prime}}{f^{2}} y+2 \frac{f_{1}^{\prime} f^{\prime} f-f_{1}\left(f^{\prime}\right)^{2}}{f^{3}} y,
\end{array}\right.
\end{gather*}
$$

and

$$
\mathcal{L}_{1} u=A_{1} u_{s s}+B_{1} u_{s z}+C_{1} u_{z z}+D_{1} u_{s}+E_{1} u_{z}
$$

where

$$
\begin{aligned}
& A_{1}=A s_{x}^{2}+B s_{x} s_{y}+C s_{y}^{2}, B_{1}=2 A s_{x} z_{x}+B s_{y} z_{x}+B s_{x} z_{y}+2 C s_{y} z_{y} \\
& C_{1}=A z_{x}^{2}+B z_{y} z_{x}+C z_{y}^{2}, D_{1}=A s_{x x}+B s_{x y}+C s_{y y}+D s_{x}+E s_{y} \\
& E_{1}=A z_{x x}+B z_{x y}+C z_{y y}+D z_{x}+E z_{y}
\end{aligned}
$$

Now we estimate the Jacobi matrix (3.7). By (1.7), we know

Above three imply $\left(\begin{array}{ll}s_{x} & s_{y} \\ z_{x} & z_{y}\end{array}\right) \approx\left(\begin{array}{cc}* & 0 \\ 0 & *\end{array}\right)$ for $\bar{\Pi}$ small enough, i.e. $\mathcal{P}_{2}$ is a Lipschitz diffeomorphism. Hence the estimates (2.8) and (2.9) also hold in $(s, z)$-coordinate.

The key to the proof of Lemma 2.2 is the existence of barrier function $H$. By Remark 2.1, we only need to check that $\sqrt{s^{2}+z^{2}}\left|D_{1}\right|$ and $\sqrt{s^{2}+z^{2}}\left|E_{1}\right|$ are uniformly bounded. It is enough to estimate the following two terms

& \leq \bar{C}\left|s \frac{f_{1}^{\prime} f-f_{1} f^{\prime}}{f^{2}}\right| \text { for } s \in[0,3 / 4] \\
& =\bar{C}\left|x \frac{f_{1}^{\prime} f-f_{1} f^{\prime}}{f^{2}}\right| \text { for } x \in[0,3 / 4] \\
& \leq \bar{C}\left(1+C_{f}\right)^{2},
\end{aligned}
$$

and

$$
\begin{aligned}
& \quad\left|\sqrt{s^{2}+z^{2}}\left(\frac{f_{1}^{\prime \prime} f-f_{1} f^{\prime \prime}}{f^{2}} y-2 \frac{f_{1}^{\prime} f^{\prime} f-f_{1}\left(f^{\prime}\right)^{2}}{f^{3}} y\right)\right| \\
& \leq \bar{C} \frac{s}{f}\left(\left|f_{1}^{\prime \prime}\right| f+\left|f^{\prime \prime}\right| f_{1}+\left|f_{1}^{\prime} f^{\prime}\right|+\left|f^{\prime}\right|^{2} \frac{f_{1}}{f}\right) \text { for } s \in[0,3 / 4] \\
& \leq \bar{C}\left(1+C_{f}\right)^{2},
\end{aligned}
$$

where we utilize (3.6). Above two imply $\sqrt{s^{2}+z^{2}}\left|D_{1}\right|$ and $\sqrt{s^{2}+z^{2}}\left|E_{1}\right|$ are uniformly bounded.

From the above discussion, we can construct the barrier function $H$ as in Lemma 2.2 to get the desired estimate

The above estimate will give the corresponding growth estimate in the original coordinate $(x, y)$

\end{equation*}

Once we have estimate (3.8), we do the same argument as in Theorem 2.1 in $(x, y)$ coordinate. The proof is complete.

## 4. Unbounded Dirichlet Condition

In this section, we extend Theorem 1.1 to the weighted Hölder spaces. For $m>0$, define the weighted Hölder norms as follows

& +\sup _{0 \leq r_{1} \leq r_{2} \leq 1}\left|r_{1}^{m+k+\gamma} \frac{\nabla^{k} u\left(x_{1}, y_{1}\right)-\nabla^{k} u\left(x_{2}, y_{2}\right)}{\left|\left(x_{1}, y_{1}\right)-\left(x_{2}, y_{2}\right)\right|^{\gamma}}\right|,
\end{aligned}
$$

where $r=\sqrt{x^{2}+y^{2}}, r_{i}=\sqrt{x_{i}^{2}+y_{i}^{2}}, i=1,2$, and

\|f\|_{C_{2, \gamma}^{(1+\gamma)}([0,1])}=\max _{i=0,1,2} \sup _{x \in[0,1]}\left|x f^{(i)}(x)\right|+\sup _{0 \leq x_{1}<x_{2} \leq 1}\left|x_{1} \frac{f^{(2)}\left(x_{1}\right)-f^{(2)}\left(x_{2}\right)}{\left|x_{1}-x_{2}\right|^{\gamma}}\right| .
$$

From Lemma 2.1 in [20], one also knows

Theorem 4.1. Let $u$ be the solution of (1.4). Assume that $A, B, C, D, E$ and $G$ satisfy (1.5) and $f$ satisfies (4.2) and (4.3). Then there exists $\sigma_{0}>0$ such that for any $\sigma \in\left(0, \sigma_{0}\right]$, we have

where the two positive constants $\sigma_{0}, \bar{C}$ depend only on $\gamma, \lambda, \Lambda, C_{f}, m$.
Recall that $v=u-\varphi, P_{x_{0}}(x, y)=N p_{x_{0}}(x, y)$ are given by (2.3) and (2.6). Since for $0<x_{1}<x_{2}<1$, from (4.1) and (4.2), we have

\leq & \frac{\left|f\left(x_{1}\right)\right|}{x_{1}}\left|x_{1} \frac{f^{\prime \prime}\left(x_{1}\right)-f^{\prime \prime}\left(x_{2}\right)}{\left|x_{1}-x_{2}\right|^{\gamma}}\right|+\left(x_{2}^{1-\gamma}\left|f^{\prime \prime}\left(x_{2}\right)\right|\right) \frac{\left|f\left(x_{1}\right)-f\left(x_{2}\right)\right|}{\left|x_{1}-x_{2}\right|} \frac{\left|x_{1}-x_{2}\right|^{1-\gamma}}{x_{2}^{1-\gamma}}  \tag{4.5}\\
\leq & \leq \bar{C}\|f\|_{C_{2, \gamma}}^{2}(1+\gamma) .

\left|\left(v-P_{x_{0}}\right)(x, f(x))\right| & =\frac{\left|\mathcal{L}(\varphi)\left(x_{0}, f\left(x_{0}\right)\right)\right|}{\mathcal{L}\left(p_{x_{0}}\left(x_{0}, f\left(x_{0}\right)\right)\right)}\left|p_{x_{0}}(x, f(x))\right| \\
& \leq \frac{\bar{C}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])}^{(1)}\|f\|_{C_{2, \gamma}([0,1])}^{2}}{x_{0}^{m+2}}\left|x-x_{0}\right|^{2+\gamma} . \tag{4.6}
\end{align*}
$$

Similarly, we have

$$
\left|\mathcal{L}\left(v-P_{x_{0}}\right)\right| \leq\left\{\begin{array}{l}
\frac{\bar{C}\|\varphi\|_{\left.C_{2, \gamma}^{(-m)}(0,1]\right)}}{x^{m+2+\gamma}}\left|(x, y)-\left(x_{0}, y_{0}\right)\right|^{\gamma}, \text { for } x \leq \frac{x_{0}}{2}  \tag{4.7}\\
\frac{\bar{C}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])}}{x_{0}^{m+2+\gamma}}\left|(x, y)-\left(x_{0}, y_{0}\right)\right|^{\gamma}, \text { for } x \in\left[\frac{x_{0}}{2}, 1\right] .
\end{array}\right.
$$

Our proof is similar to Theorem 1.1. We first prove that the estimate holds with the straight corner condition, and then obtain our theorem through three coordinate transformations.

Lemma 4.2. Under the assumption of Theorem 4.1, there exists $\sigma_{0}>0$ such that for any $\sigma \in\left(0, \sigma_{0}\right]$, we have

$$
\begin{equation*}
\left\|v-P_{x_{0}}\right\|_{L^{\infty}\left(\Omega_{x_{0}}^{1}\right)} \leq \bar{C} x_{0}^{-(m+2+\gamma)}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])} f\left(x_{0}\right)^{2+\gamma} \tag{4.8}
\end{equation*}
$$

where the two constants $\sigma_{0}, \bar{C}$ depend only on $\gamma, \lambda, \Lambda, C_{f}, m$.
Proof. We first deal with straight corner case. Define the barrier function $H$ with weight as follows

$$
H=x_{0}^{-(m+2+\gamma)} f\left(x_{0}\right)^{2+\gamma}\left(\left(\frac{r}{r_{0}}\right)^{|\alpha|}+\left(\frac{r}{r_{0}}\right)^{-|\alpha|}\right) \cos (k \theta)
$$

where $\alpha, k$ is given by Lemma 2.2. The proof here is similar to Lemma 2.2, one only needs to take into account the impact of the weight terms. Here, we briefly list the key steps. As (2.16),

$$
\begin{aligned}
-\mathcal{L} H & \geq x_{0}^{-(m+2+\gamma)} f\left(x_{0}\right)^{2+\gamma} \frac{\lambda k^{2}}{8} r_{0}^{-2}\left(\left(\frac{r}{r_{0}}\right)^{|\alpha|-2}+\left(\frac{r}{r_{0}}\right)^{-|\alpha|-2}\right) \\
& \geq x_{0}^{-(m+2+\gamma)} f\left(x_{0}\right)^{\gamma} \frac{\lambda}{16}\left(\left(\frac{r}{r_{0}}\right)^{|\alpha|-2}+\left(\frac{r}{r_{0}}\right)^{-|\alpha|-2}\right) .
\end{aligned}
$$

Then the discussion in Lemma 2.2 also implies

$$
-\mathcal{L} H \geq \bar{C} x_{0}^{-(m+2+\gamma)}\left|(x, y)-\left(x_{0}, f\left(x_{0}\right)\right)\right|^{\gamma}, \quad x \geq \frac{x_{0}}{2} .
$$

It remains to estimate the case $x \leq \frac{x_{0}}{2}$. Since

$$
r \approx x, \quad \text { and } \quad r_{0} \approx x_{0}
$$

we may assume $\frac{r_{0}}{r} \geq \frac{3}{2}$. By (2.13), it follows that

$$
\begin{aligned}
-\mathcal{L} H & \geq \bar{C} x_{0}^{-m-2-\gamma}\left(f\left(x_{0}\right)\right)^{\gamma}\left(\frac{r_{0}}{r}\right)^{\frac{k}{2 M}} \\
& \geq \bar{C} x_{0}^{-m-2-\gamma}\left(\frac{r_{0}}{r}\right)^{\frac{k}{4 M}} x_{0}^{\gamma} \times\left(f^{\prime}\left(x_{0}\right)\right)^{\gamma}\left(\frac{3}{2}\right)^{\frac{k}{4 M}} \\
& \geq \bar{C} x_{0}^{-m-2-\gamma}\left(\frac{r_{0}}{r}\right)^{\frac{k}{4 M}} x_{0}^{\gamma} \times\left(f^{\prime}\left(x_{0}\right)\right)^{\gamma}\left(\left(\frac{3}{2}\right)^{\frac{k}{4 \gamma M}}\right)^{\gamma} \\
& \geq \bar{C} x_{0}^{-m-2-\gamma}\left(\frac{r_{0}}{r}\right)^{\frac{k}{4 M}} x_{0}^{\gamma} \times\left(f^{\prime}\left(x_{0}\right)\right)^{\gamma}\left(\frac{k}{8 \gamma M}\right)^{\gamma} \\
& \geq \bar{C} x^{-(m+2+\gamma)}\left|(x, y)-\left(x_{0}, f\left(x_{0}\right)\right)\right|^{\gamma}
\end{aligned}
$$

for $\frac{k}{4 M} \geq m+2+\gamma$ and $\sigma_{0}$ small enough.
Overall, we have proved that

$$
-\mathcal{L}(H) \geq\left\{\begin{array}{l}
\bar{C} x^{-(m+2+\gamma)}\left|(x, y)-\left(x_{0}, f\left(x_{0}\right)\right)\right|^{\gamma}, \text { for } x \in\left[0, \frac{x_{0}}{2}\right] \\
\bar{C} x_{0}^{-(m+2+\gamma)}\left|(x, y)-\left(x_{0}, f\left(x_{0}\right)\right)\right|^{\gamma}, \text { for } x \in\left[\frac{x_{0}}{2}, 1\right]
\end{array}\right.
$$

Similar arguments also implies on $\partial \Omega$

$$
H \geq \frac{\bar{C}}{x_{0}^{m+2+\gamma}}\left|x-x_{0}\right|^{2+\gamma}
$$

As the proof of Lemma 2.2, in view of (4.6) and (4.7), we deduce (4.8) via above two.

For the general case, we apply the coordinates transformation $\mathcal{P}_{2}$ to get the estimate under $(s, z)$ coordinates

$$
\left\|v-P_{x_{0}}\right\|_{L^{\infty}\left(\mathcal{P}_{2}\left(\Omega_{x_{0}}^{1}\right)\right.} \leq \bar{C} x_{0}^{-(m+2+\gamma)}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])} z\left(x_{0}, f\left(x_{0}\right)\right)^{2+\gamma} .
$$

Upon careful verification, we can find that the three coordinate transformations of Theorem 1.1 are still valid under the assumptions (4.2) and (4.3).

As the proof of Theorem 2.1, we have
Theorem 4.3. Under the assumption of Theorem 4.1, there exists $\sigma_{0}>0$ such that for any $\sigma \in\left(0, \sigma_{0}\right]$, we have

$$
\|u\|_{C_{2, \gamma}^{(-m)}(\bar{\Omega} \cap\{x \in[0,2 / 3]\})} \leq \bar{C}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])},
$$

where the two positive constants $\sigma_{0}, \bar{C}$ depend only on $\gamma, \lambda, \Lambda, C_{f}, m$.
Proof. Denote

$$
w(x, y)=\left(v-P_{x_{0}}\right)(x, y), \quad \widetilde{w}(\tilde{x}, \tilde{y})=\frac{x_{0}^{m+2+\gamma} w(x, y)}{\left(f\left(x_{0}\right)\right)^{2+\gamma}}
$$

where the coordinate transformation is given by (2.18). Then

$$
\begin{aligned}
-\widetilde{\mathcal{L}} \widetilde{w} & =\widetilde{A} \frac{x_{0}^{m+2+\gamma}\left(\varphi^{\prime \prime}\left(x_{0}+f\left(x_{0}\right) \tilde{x}\right)-\varphi^{\prime \prime}\left(x_{0}\right)\right)}{\left(f\left(x_{0}\right)\right)^{\gamma}} \\
& +\widetilde{D} \frac{x_{0}^{m+2+\gamma}\left(\varphi^{\prime}\left(x_{0}+f\left(x_{0}\right) \tilde{x}\right)-\varphi^{\prime}\left(x_{0}\right)\right)}{\left(f\left(x_{0}\right)\right)^{\gamma}}=\tilde{g}(\tilde{x}),
\end{aligned}
$$

with the following boundary conditions

$$
\|\widetilde{w}\|_{L^{\infty}\left(\widetilde{\Omega}_{x_{0}}^{1}\right)}+\|\widetilde{w}\|_{C^{2, \gamma}\left(\partial_{+} \widetilde{\Omega}_{x_{0}}^{1}\right)} \leq \bar{C}\|\varphi\|_{C_{2, \gamma}^{-m}([0,1])},\left.\quad \frac{\partial \widetilde{w}}{\partial \tilde{y}}\right|_{\partial_{0} \widetilde{\Omega}_{x_{0}}^{1}}=0
$$

Also we know

$$
\|\tilde{g}\|_{C^{\gamma}\left(\overline{\Omega_{x_{0}}^{1}}\right)} \leq \bar{C}\|\varphi\|_{C_{2, \gamma}^{-m}([0,1])} .
$$

Similarly as (2.19), one gets

$$
\begin{align*}
& \|\widetilde{w}\|_{C^{2, \gamma}\left(\overline{\widetilde{\Omega}_{x_{0}}^{1 / 2}}\right)} \\
\leq & \bar{C}\left(\|\tilde{g}\|_{C^{\gamma}\left(\overline{\Omega_{x_{0}}^{1}}\right)}+\|\widetilde{w}\|_{C^{2, \gamma}\left(\partial_{+} \widetilde{\Omega}_{x_{0}}^{1}\right)}+\|\widetilde{w}\|_{L^{\infty}\left(\widetilde{\Omega}_{x_{0}}^{1}\right)}\right) \leq \bar{C}\|\varphi\|_{C_{2, \gamma}^{-m}([0,1])} \tag{4.9}
\end{align*}
$$

In the original coordinate $(x, y),(4.9)$ implies that $\forall x_{0} \in(0,2 / 3)$ there holds

$$
\begin{aligned}
& \max _{i=0,1,2} \sup _{(x, y) \in \Omega_{x_{0}}^{1 / 2}}\left|x_{0}^{m+i} \nabla^{i} u(x, y)\right| \\
+ & \sup _{\left(x_{1}, y_{1}\right),\left(x_{2}, y_{2}\right) \in \Omega_{x_{0}}^{1 / 2}}\left|x_{0}^{m+k+\gamma} \frac{\nabla^{2} u\left(x_{1}, y_{1}\right)-\nabla^{2} u\left(x_{2}, y_{2}\right)}{\left|\left(x_{1}, y_{1}\right)-\left(x_{2}, y_{2}\right)\right|^{\gamma}}\right| \leq \bar{C}\|\varphi\|_{C_{2, \gamma}^{-m}([0,1])} .
\end{aligned}
$$

In the following, we only need to consider

$$
\left(x_{1}, y_{1}\right),\left(x_{2}, y_{2}\right) \in \bar{\Omega} \cap\{x \in(0,2 / 3)\}, \quad x_{2}-x_{1} \geq \frac{1}{2} \max \left(f\left(x_{1}\right), f\left(x_{2}\right)\right) .
$$

Since $u_{y}(x, 0)=0$, there holds

$$
\begin{aligned}
& \left|u_{x y}\left(x_{1}, y_{1}\right)-u_{x y}\left(x_{2}, y_{2}\right)\right| \\
\leq & \left|u_{x y}\left(x_{1}, 0\right)-u_{x y}\left(x_{1}, y_{1}\right)\right|+\left|u_{x y}\left(x_{2}, 0\right)-u_{x y}\left(x_{2}, y_{2}\right)\right|+\left|u_{x y}\left(x_{1}, 0\right)-u_{x y}\left(x_{2}, 0\right)\right| \\
\leq & \bar{C} x_{1}^{-m-2-\gamma}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])}\left(y_{1}^{\gamma}+y_{2}^{\gamma}\right) .
\end{aligned}
$$

This implies

$$
\left\|u_{x y}\right\|_{C_{0, \gamma}^{(-m-2)}(\bar{\Omega} \cap\{x \in[0,2 / 3]\})} \leq \bar{C}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])}
$$

Notice that

$$
\begin{aligned}
u_{x x}+\left(f^{\prime}(x)\right)^{2} u_{y y} & =\frac{\mathrm{d}^{2} u(x, f(x))}{\mathrm{d} x^{2}}-2 f^{\prime}(x) u_{x y}-f^{\prime \prime}(x) u_{y} \\
& =\frac{\mathrm{d}^{2} \varphi(x)}{\mathrm{d} x^{2}}-2 f^{\prime}(x) u_{x y}-f^{\prime \prime}(x) u_{y},
\end{aligned}
$$

and (1.4)

$$
A u_{x x}+C u_{y y}=-B u_{x y}-D u_{x}-E u_{y} .
$$

Hence for $\sigma_{0}$ small, there holds

$$
\begin{aligned}
&\left|u_{x x}\left(x_{1}, f\left(x_{1}\right)\right)-u_{x x}\left(x_{2}, f\left(x_{2}\right)\right)\right|+\left|u_{y y}\left(x_{1}, f\left(x_{1}\right)\right)-u_{y y}\left(x_{2}, f\left(x_{2}\right)\right)\right| \\
& \leq \bar{C} x_{1}^{-m-2-\gamma}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])}\left|\left(x_{1}, f\left(x_{1}\right)\right)-\left(x_{2}, f\left(x_{2}\right)\right)\right|^{\gamma} .
\end{aligned}
$$

Then a similar argument as $u_{x y}$ yields that

$$
\left\|u_{x x}\right\|_{C_{0, \gamma}^{(-m-2)}(\bar{\Omega} \cap\{x \in[0,2 / 3]\})}+\left\|u_{y y}\right\|_{C_{0, \gamma}^{(-m-2)}(\bar{\Omega} \cap\{x \in[0,2 / 3]\})} \leq \bar{C}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])} .
$$

We complete our proof of Theorem 4.3.
Proof of Theorem 4.1. It suffices to show

$$
\|u\|_{C^{2}, \gamma(\bar{\Omega} \cap\{x \in[1 / 2,1]\})} \leq \bar{C}\|\varphi\|_{\left.C_{2, \gamma}^{(-m)}(00,1]\right)} .
$$

We cannot directly use the reflection transformation $\mathcal{P}_{3}$ to obtain the corresponding estimate as in the proof of Section 3. Because in the present section, the function blows up around the other vertex. The barrier function $H$ fails to work there. We need to make a modification to the proof.

In fact, by Theorem 4.3, we have

$$
\left.|u|\right|_{x=1 / 3} \leq \bar{C}\|\varphi\|_{C_{2,}^{(-m)}([0,1])}
$$

Then for $x_{0} \in[1 / 2,1]$

$$
\left.\left|v-P_{x_{0}}\right|\right|_{x=1 / 3} \leq \bar{C}\|\varphi\|_{C_{2, \gamma}^{(-m)}([0,1])}
$$

And for the barrier function $H$ (the $r$ corresponds to a center at point $(x, y)=(1,0))$, we have

$$
\left.H\right|_{x=1 / 3} \geq \bar{C}>0 .
$$

Thus, we apply the maximum principle in the domain $\bar{\Omega} \cap\{x \in[1 / 3,1]\}$ to obtain the estimate (2.10). The rest of the proof is the same.

## 5. Asymptotic States as $f \rightarrow 0$

In this section, we see that the estimate (1.8) leads to an asymptotic estimate as $f \rightarrow 0$. First, in (1.4), we can differentiate the boundary value condition along the boundary to obtain the following derivatives list

$$
\left\{\begin{array}{l}
u(x, f(x))=\varphi(x), \\
l_{f} u(x, f(x))=u_{x}(x, f(x))+f^{\prime}(x) u_{y}(x, f(x))=\varphi^{\prime}(x), \\
l_{0} u(x, 0)=u_{y}(x, 0)+G(x) u_{x}(x, 0)=0, \\
L_{f} u(x, f(x))=u_{x x}(x, y)+2 f^{\prime}(x) u_{x y}(x, f(x))+\left(f^{\prime}(x)\right)^{2} u_{y y}(x, f(x)) \\
\quad \quad+f^{\prime \prime}(x) u_{y}(x, f(x))=\varphi^{\prime \prime}(x), \\
\\
L u(x, y)=A(x, y) u_{x x}+B(x, y) u_{x y}+C(x, y) u_{y y}+D(x, y) u_{x}+E(x, y) u_{y}=0, \\
L_{0} u(x, 0)=u_{x y}(x, 0)+G(x) u_{x x}(x, 0)+G^{\prime}(x) u_{x}(x, 0)=0 .
\end{array}\right.
$$

In above, we set $f(x)=0$ to define the asymptotic operators $l_{f}^{*}, l_{0}^{*}, L_{f}^{*}, L^{*}$ and $L_{0}^{*}$ and the asymptotic state $u^{*}$ over $[0,1] \times\{0\}$ as follows

$$
\left\{\begin{array}{l}
u^{*}(x, 0)=\varphi(x), \\
l_{f}^{*} u^{*}(x, 0)=u_{x}^{*}(x, 0)=\varphi^{\prime}(x), \\
l_{0}^{*} u^{*}(x, 0)=l_{0} u^{*}(x, 0)=u_{y}^{*}(x, 0)+G(x) u_{x}^{*}(x, 0)=0, \\
L_{f}^{*} u^{*}(x, 0)=u_{x x}^{*}(x, 0)=\varphi^{\prime \prime}(x) \\
L^{*} u^{*}(x, 0)=A(x, 0) u_{x x}^{*}+B(x, 0) u_{x y}^{*}+C(x, 0) u_{y y}^{*}+D(x, 0) u_{x}^{*}+E(x, 0) u_{y}^{*}=0, \\
L_{0}^{*} u^{*}(x, 0)=L_{0} u^{*}(x, 0)=u_{x y}^{*}(x, 0)+G(x) u_{x x}^{*}(x, 0)+G^{\prime}(x) u_{x}^{*}(x, 0)=0 .
\end{array}\right.
$$

This is a linear equation of the following form derivatives

$$
\left(u^{*}(x, 0), u_{x}^{*}(x, 0), u_{y}^{*}(x, 0), u_{x x}^{*}(x, 0), u_{x y}^{*}(x, 0), u_{y y}^{*}(x, 0)\right)
$$

and can be unique solved over $[0,1] \times\{0\}$.
We can compare $u(x, y)$ and $u^{*}(x, 0)$ under these operators. For example,

$$
\begin{aligned}
\left|L_{f}^{*} u(x, y)-L_{f}^{*} u^{*}(x, 0)\right| & =\left|L_{f}^{*} u(x, y)-L_{f} u(x, f(x))\right| \\
& \leq \sigma_{0}\|u\|_{C^{2, \gamma}(\Omega)}+f(x)^{\gamma}\|u\|_{C^{2, \gamma}(\Omega)} \\
& \leq \sigma_{0}^{\gamma}\|\varphi\|_{C^{2}, \gamma([0,1])} .
\end{aligned}
$$

Similarly, we have

$$
\left\{\begin{array}{l}
u(x, y)-u^{*}(x, 0)=\mathcal{O}_{1} \\
l_{f}^{*}\left(u(x, y)-u^{*}(x, 0)\right)=\mathcal{O}_{2} \\
l_{0}^{*}\left(u(x, y)-u^{*}(x, 0)\right)=\mathcal{O}_{3} \\
L_{f}^{*}\left(u(x, y)-u^{*}(x, 0)\right)=\mathcal{O}_{4} \\
L^{*}\left(u(x, y)-u^{*}(x, 0)\right)=\mathcal{O}_{5} \\
L_{0}^{*}\left(u(x, y)-u^{*}(x, 0)\right)=\mathcal{O}_{6}
\end{array}\right.
$$

where $\left|\mathcal{O}_{i}\right| \leq \bar{C} \sigma_{0}^{\gamma}\|\varphi\|_{C^{2, \gamma}([0,1])}$. Therefore, $\nabla^{i} u^{*}(x, 0)-\nabla^{i} u(x, y)$ satisfy a linear equation whose non-homogeneous terms can be estimated by $\bar{C} \sigma_{0}^{\gamma}\|\varphi\|_{C^{2, \gamma}([0,1])}$. To conclude, we have

Theorem 5.1. Under the assumption of Theorem 1.1, $u, u_{x}, u_{y}, u_{x x}, u_{x y}, u_{y y}$ is the perturbation of $u^{*}, u_{x}^{*}, u_{y}^{*}, u_{x x}^{*}, u_{x y}^{*}, u_{y y}^{*}$ and we have

$$
\begin{equation*}
\left|\nabla^{i} u^{*}(x, 0)-\nabla^{i} u(x, y)\right| \leq \bar{C} \sigma_{0}^{\gamma}\|\varphi\|_{C^{2, \gamma}([0,1])} . \tag{5.1}
\end{equation*}
$$

Remark 5.1. Here there is an unreasonable definition. Because function $u^{*}$ is only defined on line segment $[0,1] \times\{0\}$, how can we define its derivatives in the $y$ direction? In fact, it can be understood in two ways. On the one hand, we can consider some function $U$ defined in the neighbourhood of line segment $[0,1] \times\{0\}$ and $\nabla^{i} U(x, 0)=\nabla^{i} u^{*}(x, 0)$. On the other hand, we can consider that there is
a sequence of functions, each defined within the neighbourhood of line segment $[0,1] \times\{0\}$, and the derivatives of the sequence of functions converge to the form derivatives of $u^{*}$ on $[0,1] \times\{0\}$. The introduction of $u^{*}$ has the benefit in providing a more optimal asymptotic estimate (5.1) than the a priori estimate (1.8).
