# Comparison of the Hitchin metric and the semi-flat metric in the rank two case

#### Abstract

Let  $(E, \theta)$  be a Higgs bundle of rank 2 and degree 0 on a compact Riemann surface X whose spectral curve is smooth. The tangent space of the moduli space of Higgs bundles at  $(E, \theta)$  is equipped with two natural metrics called the Hitchin metric and the semi-flat metric. It is known that the difference between two metrics along the curve  $(E, t\theta)$   $(t \ge 1)$  decays in an exponential way. In this paper, we shall study how the exponential rate is improved.

# **1** Introduction

### 1.1 Hitchin metric and semi-flat metric of the moduli space of Higgs bundles

Let X be a compact Riemann surface. Let  $\mathcal{M}_H$  denote the moduli space of stable Higgs bundles of rank 2 and degree 0 on X. According to Hitchin [10],  $\mathcal{M}_H$  is equipped with the hyperkähler metric  $g_{H,\mathbb{R}}$  called the Hitchin metric.

There also exists the Hitchin fibration  $\Phi_H : \mathcal{M}_H \to \mathcal{A}_H = H^0(X, K_X^{\otimes 2})$ , which admits a section  $\mathcal{A}_H \to \mathcal{M}_H$ called a Hitchin section depending only on the choice of  $K_X^{1/2}$ . Let  $\mathcal{A}'_H \subset \mathcal{A}_H$  denote the set of regular values. We set  $\mathcal{M}'_H = \Phi_H^{-1}(\mathcal{A}'_H)$ . The restriction of the Hitchin fibration  $\mathcal{M}'_H \to \mathcal{A}'_H$  is an algebraic integrable system, and in this situation  $\mathcal{M}'_H$  is equipped with the canonically defined hyperkähler metric  $g_{\mathrm{sf},\mathbb{R}}$  [7], called the semi-flat metric.

Let  $(E, \theta) \in \mathcal{M}'_H$ . We obtain the curve  $(E, t\theta)$   $(t \ge 1)$  in  $\mathcal{M}'_H$ . Let  $g_H$  and  $g_{sf}$  denote the Kähler metrics of  $\mathcal{M}_H$  with the natural complex structure induced by  $g_{H,\mathbb{R}}$  and  $g_{sf,\mathbb{R}}$ . It was predicted in [8, 9] and proved in [4] that there exists  $\epsilon > 0$  such that

$$g_{H|(E,t\theta)} - g_{\mathrm{sf}\,|(E,t\theta)} = O(e^{-\epsilon t}) \tag{1}$$

as  $t \to \infty$ . Such an estimate was obtained in [4] under a mild assumption on  $(E, \theta)$ , and in [18] without the additional assumption by a different method. However, the original prediction in [8, 9] suggests an explicit range of  $\epsilon$ . In this paper, we shall partially verify it in the rank two case by using the method in [18].

Before explaining our main result more explicitly, let us recall more detail about the related objects.

#### 1.1.1 Hitchin metric

Let  $(E, \theta)$  be a Higgs bundle on a compact Riemann surface X of degree 0 and rank 2. Assume that tr  $\theta = 0$  and det $(E) = \mathcal{O}_X$ , for simplicity. We also assume  $(E, \theta) \in \mathcal{M}'_H$ , which is equivalent to the condition that the spectral curve  $\Sigma_{\theta}$  of  $(E, \theta)$  is smooth.

According to the fundamental theorem of Hitchin and Simpson, under the condition,  $(E, \theta)$  has a unique harmonic metric h such that  $\det(h) = 1$ , i.e., the Hitchin equation  $R(h) + [\theta, \theta_h^{\dagger}] = 0$  holds, where R(h) denotes the curvature of the Chern connection of (E, h), and  $\theta_h^{\dagger}$  denotes the adjoint of  $\theta$  with respect to h. We remark that the induced harmonic metric on  $(\operatorname{End}(E), \operatorname{ad} \theta)$  is also denoted by h.

We consider the Deformation complex  $Def(E, \theta)$  given by

$$\operatorname{End}(E) \xrightarrow{\operatorname{ad} \theta} \operatorname{End}(E) \otimes K_X,$$

where the first term sits at the degree 0. It is well known that

$$T_{(E,\theta)}\mathcal{M}'_H \simeq H^1(X, \operatorname{Def}(E,\theta)).$$
 (2)

We recall that an  $\operatorname{End}(E)$ -valued 1-form  $\sigma$  is called harmonic if

$$(\overline{\partial}_E + \operatorname{ad} \theta)\sigma = (\overline{\partial}_E + \operatorname{ad} \theta)^*_{h,q_X}\sigma = 0$$

where  $\overline{\partial}_E$  denotes the holomorphic structure of E, and  $g_X$  denotes a compact Kähler metric  $g_X$  of X. It is equivalent to the condition that

$$(\overline{\partial}_E + \operatorname{ad} \theta)\sigma = (\partial_{E,h} + \operatorname{ad} \theta_h^{\dagger})\sigma = 0,$$

where  $\partial_{E,h}$  denotes the (1,0)-part of the Chern connection of (E,h). Then, (2) is also isomorphic to the space  $\mathcal{H}^1(\operatorname{End}(E), \operatorname{ad} \theta, h)$  of harmonic 1-forms of  $(\operatorname{End}(E), \operatorname{ad} \theta, h)$ ,

We consider the standard  $L^2$ -Hermitian product of End(E)-valued 1-forms  $\sigma_i$  (i = 1, 2):

$$(\sigma_1, \sigma_2)_{L^2, h} = 2\sqrt{-1} \int_X \operatorname{Tr} \left( \sigma_1^{1,0} \cdot (\sigma_2^{1,0})_h^{\dagger} - \sigma_1^{0,1} \cdot (\sigma_2^{0,1})_h^{\dagger} \right).$$

Then, the Hitchin metric  $g_{H|(E,\theta)}$  is obtained as the restriction of  $(\cdot, \cdot)_{L^2,h}$  to  $\mathcal{H}^1(\operatorname{End}(E), \operatorname{ad} \theta, h) \simeq T_{(E,\theta)}\mathcal{M}'_H$ .

#### 1.1.2 Semi-flat metric

Note that  $\Phi_H : \mathcal{M}'_H \to \mathcal{A}'_H$  is a locally principal torus bundle. It is a Lagrangian fibration, and the fiber  $\Phi_H^{-1}(\Phi_H(E,\theta))$  is isomorphic to  $\operatorname{Pic}_{2g(X)-2}(\Sigma_{\theta})$ . There exists a Hitchin section  $\mathcal{A}'_H \to \mathcal{M}'_H$ . There uniquely exists an integrable connection of  $\Phi_H$  such that any Hitchin section is horizontal. We obtain the decomposition of  $T_{(E,\theta)}\mathcal{M}'_H$  into the vertical part  $(T_{(E,\theta)}\mathcal{M}'_H)^{\operatorname{ver}}$  and the horizontal part  $(T_{(E,\theta)}\mathcal{M}'_H)^{\operatorname{hor}}$ . Because the fiber is identified with a component of the Picard variety of  $\Sigma_{\theta}$ , there exists an isomorphism

$$(T_{(E,\theta)}\mathcal{M}'_H)^{\mathrm{ver}} \simeq H^1(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}})$$

Because the vertical part is a Lagrangian subspace,  $(T_{(E,\theta)}\mathcal{M}'_H)^{\text{hor}}$  is the dual space of  $(T_{(E,\theta)}\mathcal{M}'_H)^{\text{ver}}$ , and hence

$$(T_{(E,\theta)}\mathcal{M}'_H)^{\mathrm{hor}} \simeq H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}}).$$

Therefore, we obtain

$$T_{(E,\theta)}\mathcal{M}'_H \simeq H^1(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}}) \oplus H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}}).$$

It is also identified with the space  $\mathcal{H}^1(\Sigma_{\theta})$  of the harmonic 1-forms of  $\Sigma_{\theta}$ .

We consider the standard  $L^2$ -Hermitian product of 1-forms  $\mu_i$  (i = 1, 2) on  $\Sigma_{\theta}$ :

$$(\mu_1,\mu_2)_{L^2,\Sigma_{\theta}} = 2\sqrt{-1} \int_{\Sigma_{\theta}} \left( \mu_1^{1,0} \wedge \overline{\mu_2^{1,0}} - \mu_1^{0,1} \wedge \overline{\mu_2^{0,1}} \right).$$

Then, the semi-flat metric  $g_{\mathrm{sf}|(E,\theta)}$  is obtained as the restriction of  $(\cdot, \cdot)_{L^2, \Sigma_{\theta}}$  to  $\mathcal{H}^1(\Sigma) \simeq T_{(E,\theta)} \mathcal{M}'_H$ .

# 1.2 An auxiliary Hermitian product

#### **1.2.1** Decompositions

Let  $D_{\theta}$  denote the set of the critical values of  $\pi : \Sigma_{\theta} \to X$ . Let  $Q \in X \setminus D_{\theta}$ . There exists a neighbourhood  $X_Q$  of Q and a decomposition

$$(E,\theta)_{|X_Q} = (E_{Q,1},\theta_{Q,1}) \oplus (E_{Q,2},\theta_{Q,2}).$$

By setting  $\operatorname{End}(E)_{|X_Q}^{\circ} = \operatorname{End}(E_{Q,1}) \oplus \operatorname{End}(E_{Q,2})$  and  $\operatorname{End}(E)_{|X_Q}^{\perp} = \operatorname{Hom}(E_{Q,1}, E_{Q,2}) \oplus \operatorname{Hom}(E_{Q,2}, E_{Q,1})$ , we obtain the decomposition

$$\operatorname{End}(E)_{|X_Q} = \operatorname{End}(E)^{\circ}_{|X_Q} \oplus \operatorname{End}(E)^{\perp}_{|X_Q}.$$

By varying  $Q \in X \setminus D_{\theta}$ , we obtain the decomposition

$$\operatorname{End}(E)_{|X \setminus D_{\theta}} = \operatorname{End}(E)^{\circ} \oplus \operatorname{End}(E)^{\perp}.$$

For any local section s of  $\operatorname{End}(E)$  on an open set in  $X \setminus D_{\theta}$ , we obtain the decomposition  $s = s^{\circ} + s^{\perp}$ . We have similar decompositions for any  $\operatorname{End}(E)$ -valued 1-forms on an open subset of  $X \setminus D_{\theta}$ .

#### **1.2.2** Functions and 1-forms on the spectral curves

We recall there exists a holomorphic line bundle L on  $\Sigma_{\theta}$  such that  $\pi_*(L) \simeq (E, \theta)$ . Here,  $\pi_*(L)$  is equipped with the Higgs field induced by the tautological 1-form of  $T^*X$ , and the isomorphism preserves the Higgs fields.

Let  $U \subset X \setminus D_{\theta}$  be an open subset. Let  $\alpha$  be a function on  $\Sigma_{\theta|U} = \pi^{-1}(U) \subset \Sigma_{\theta}$ , then the multiplication of  $\alpha$  on L induces an endomorphism  $F_{\alpha}$  of  $E_{|U}$  such that  $[\theta, F_{\alpha}] = 0$ . Similarly, a 1-form  $\tau$  on  $\Sigma_{\theta|U}$  induces an End(E)-valued 1-form  $F_{\tau}$  on U. If  $\alpha$  (resp.  $\tau$ ) is holomorphic, then  $F_{\alpha}$  (resp.  $F_{\tau}$ ) is also holomorphic. Note that even if  $U \cap D_{\theta} \neq \emptyset$ , a holomorphic function  $\alpha$  on  $\Sigma_{\theta|U}$  induces a holomorphic endomorphism  $F_{\alpha}$  of  $E_{|U}$  such that  $[\theta, F_{\alpha}] = 0$ . A holomorphic 1-form  $\nu$  on  $\Sigma_{\theta|U}$  induces a holomorphic section of End(E)  $\otimes K_X(D_{\theta})$  on U.

#### **1.2.3** Holomorphic 1-forms on the spectral curve induced by harmonic metrics

Let  $h_{\infty}$  be the limiting configuration of  $(E, \theta)$  in the sense of [13] (see §3.3.1). We consider the following End(E)-valued 1-form on  $X \setminus D_{\theta}$ :

$$\Psi_h = (\partial_{E,h_\infty} + \theta_{h_\infty}^{\dagger}) - (\partial_{E,h} + \theta_h^{\dagger})$$

Because both  $\partial_{E,h_{\infty}} + \theta_{h_{\infty}}^{\dagger}$  and  $\partial_{E,h} + \theta_{h}^{\dagger}$  commute with  $\overline{\partial}_{E} + \theta$ , we obtain  $(\overline{\partial}_{E} + \operatorname{ad} \theta)\Psi_{h} = 0$ . There exists a holomorphic 1-form  $\eta_{(E,\theta)}$  on  $\Sigma_{\theta|X\setminus D_{\theta}}$  such that

$$(\Psi_h^{1,0})^\circ = F_{\eta_{(E,\theta)}}$$

**Lemma 1.1 (Lemma 3.29)**  $\eta_{(E,\theta)}$  is holomorphic on  $\Sigma_{\theta}$ .

#### 1.2.4 An auxiliary Hermitian product

Let  $\phi^{1/2}$  denote the holomorphic 1-form obtained as the canonical root of  $\pi^*(-\det\theta)$  on  $\Sigma_{\theta}$ . Let  $D_{\theta}$  be the set-theoretic inverse image  $\pi^{-1}(D_{\theta})$ . For  $\nu_i \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$ , we obtain

$$\nu_1 \cdot \nu_2 \cdot \eta_{(E,\theta)} \cdot (\phi^{1/2})^{-1} \in H^0\left(\Sigma_\theta, (K_{\Sigma_\theta}(\widetilde{D}_\theta))^2\right).$$

Note that for each  $P \in D_{\theta}$ , there exists a natural map

$$\operatorname{Res}_{\pi^{-1}(P)}^{(2)}: H^0\big(\Sigma_{\theta}, (K_{\Sigma_{\theta}}(\widetilde{D}))^2\big) \longrightarrow \mathbb{C}$$

obtained as the residue. We define

$$\langle \nu_1, \nu_2 \rangle_{(E,\theta)}^{\mathrm{aux}} = -4\pi \sum_{P \in D_{\theta}} \mathrm{Res}_{\pi^{-1}(P)}^{(2)} \Big( \nu_1 \cdot \nu_2 \cdot \eta_{(E,\theta)} \cdot (\phi^{1/2})^{-1} \Big).$$

By using the isomorphisms  $\iota^{\text{hor}} : H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}}) \simeq (T_{(E,\theta)}\mathcal{M}'_H)^{\text{hor}}$  and  $\iota^{\text{ver}} : H^1(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}}) \simeq (T_{(E,\theta)}\mathcal{M}'_H)^{\text{ver}}$ , we define the Hermitian product  $g_{(E,\theta)}^{\text{aux}}$  on  $T_{(E,\theta)}\mathcal{M}'_H$  by the following conditions.

- $g_{(E,\theta)}^{\text{aux}}(u_1, u_2) = 0$  if  $u_i \in (T_{(E,\theta)}\mathcal{M}'_H)^{\text{ver}}$  (i = 1, 2) or  $u_i \in (T_{(E,\theta)}\mathcal{M}'_H)^{\text{hor}}$  (i = 1, 2).
- For  $\nu \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$  and  $\tau \in H^1(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}}) = H^0(\Sigma_{\theta}^{\dagger}, K_{\Sigma_{\theta}^{\dagger}})$ , we set

$$g_{|(E,\theta)}^{\mathrm{aux}}(\iota^{\mathrm{hor}}(\nu),\iota^{\mathrm{ver}}(\tau)) = \langle \nu,\overline{\tau} \rangle_{(E,\theta)}^{\mathrm{aux}}.$$

# 1.3 Main result

We set  $\phi = -\det(\theta) \in H^0(X, K_X^{\otimes 2})$ , which induces the distance  $d_{\phi}$  on X. According to [3, §3.2], a saddle connection of  $\phi$  is a geodesic segment on  $(X, d_{\phi})$  such that (i) the starting point and the ending point are contained in  $D_{\phi}$ , (ii) any other point is contained in  $X \setminus D_{\phi}$ . Note that the starting point and the ending point are not necessarily distinct. Let  $M(\phi)$  denote the minimum length of the saddle connections of  $\phi$ , which is called the threshold.

**Proposition 1.2 (Corollary 3.34)**  $g_{|(E,t\theta)}^{aux} = O(e^{-2at})$  with respect to  $g_{sf|(E,t\theta)}$  for any  $0 < a < M(\phi)$ . As a result, there exists  $t_0 > 0$  such that  $g_{sf|(E,t\theta)} + g_{|(E,t\theta)}^{aux}$  are positive definite Hermitian products on  $T_{(E,t\theta)}\mathcal{M}'_H$  for any  $t \ge t_0$ .

The following theorem is the main result of this paper.

**Theorem 1.3 (Theorem 3.35)** For any  $(E, \theta) \in \mathcal{M}'_H$ , we obtain

$$g_{H|(E,t\theta)} - \left(g_{\text{sf}\,|(E,t\theta)} + g_{|(E,t\theta)}^{\text{aux}}\right) = O(e^{-4at}) \quad (0 < a < M(\phi)). \tag{3}$$

#### 1.3.1 Symmetric case

A non-degenerate symmetric product of  $(E, \theta)$  is a non-degenerate symmetric product  $C : E \otimes E \to \mathcal{O}_X$  such that  $\theta$  is self-adjoint with respect to C. Note that if  $(E, \theta)$  is contained in a Hitchin section, then  $(E, \theta)$  has a non-degenerate symmetric product.

**Corollary 1.4 (Lemma 3.31)** If  $(E, \theta)$  is equipped with a non-degenerate symmetric product, then we obtain  $\eta_{(E,\theta)} = 0$ . As a result, we obtain

$$g_{H|(E,t\theta)} - g_{\rm sf\,|(E,t\theta)} = O(e^{-4at}), \quad (0 < a < M(\phi)). \tag{4}$$

#### 1.3.2 Previous works

Originally, Gaiotto-Moore-Neitzke [8, 9] predicted (4). (See also [3, 4, 6, 20].) In [3], Dumas and Neitzke studied the issues in the case where  $(E, \theta)$  is contained in a Hitchin section, and they proved

$$g_{H|(E,t\theta)} - g_{\rm sf\,|(E,t\theta)} = O(e^{-4at}), \quad (0 < a < M(\phi)/2) \tag{5}$$

on the subspace  $T_{t^2\phi}\mathcal{A}'_H \subset T_{(E,t\theta)}\mathcal{M}'_H$  induced by the Hitchin section. As we mentioned, Fredrickson obtained the estimate (1) on the basis of [5, 13, 14]. It was further generalized to the parabolic case by Fredrickson, Mazzeo, Swoboda and Weiss in [6], where they suggested that they could also obtain the estimate (5). In [11], Holdt studied the original approach of [8, 9] in the case that a Higgs bundle has a non-trivial parabolic structure. More recently, Chen and Li studied more singular case in [2].

In [18], we obtained (1) for higher rank case without any assumption on the ramification of  $\Sigma_{\theta} \to X$  in a way different from [4]. A naive hope was to obtain (4) by the method in [18]. Corollary 1.4 is a satisfactory solution in the symmetric case. In the general case, Theorem 1.3 implies (5), but it is not a complete answer to the prediction (4) of Gaiotto-Moore-Neitzke because it is not clear whether  $g_{(E,t\theta)}^{aux} = O(e^{-4at})$  ( $0 < a < M(\phi)$ ) or not with respect to  $g_{sf|(E,\theta)}$ .

### 1.4 Outline in the symmetric case

It would be instructive to explain an outline to obtain (4) directly in the case where  $(E, \theta)$  is equipped with a non-degenerate symmetric pairing C such that  $\det(C) = 1$ , the arguments can be simplified because some issues disappear. It is close to the case of [3]. Note that if  $(E, \theta)$  is contained in a Hitchin section, then  $(E, \theta)$  is equipped with a non-degenerate symmetric pairing.

Let  $D_{\theta}$  denote the zero set of  $\phi = -\det(\theta)$ . Let  $\Sigma_{\theta} \subset T^*X$  denote the spectral curve. Because  $(E, \theta) \in \mathcal{M}'_H$ ,  $\Sigma_{\theta}$  is smooth, and the projection  $\pi : \Sigma_{\theta} \to X$  is a ramified covering of degree 2. By [1, 10], there exists a line bundle L on  $\Sigma_{\theta}$  such that  $\pi_*(L) \simeq (E, \theta)$ , where the Higgs field of  $\pi_*(L)$  is induced by the tautological 1-form on  $T^*X$ .

#### 1.4.1 The deformation complexes

Let  $\operatorname{End}(E)^{\operatorname{sym}}$  denote the sheaf of endomorphisms of E which are symmetric with respect to C. Similarly, let  $\operatorname{End}(E)^{\operatorname{asym}}$  denote the sheaf of endomorphisms of E which are anti-symmetric with respect to C. We obtain the following subcomplex of  $\operatorname{Def}(E, \theta)$ :

$$\operatorname{Def}(E,\theta,C) = \left(\operatorname{End}(E)^{\operatorname{asym}} \to \operatorname{End}(E)^{\operatorname{sym}} \otimes K_X\right).$$

We may also consider the following subcomplex of  $Def(E, \theta)$ :

$$\operatorname{Def}'(E,\theta,C) = \left(\operatorname{End}(E)^{\operatorname{sym}} \to \operatorname{End}(E)^{\operatorname{asym}} \otimes K_X\right).$$

We have the decomposition of the complexes:

$$Def(E,\theta) = Def(E,\theta,C) \oplus Def'(E,\theta,C).$$
(6)

The natural action  $\mathcal{O}_{\Sigma}$  on L induces  $\pi_*(\mathcal{O}_{\Sigma}) \to \operatorname{End}(E)$ . It induces a morphism of complexes  $\pi_*(\mathcal{O}_{\Sigma}) \longrightarrow \operatorname{Def}'(E, \theta, C) \subset \operatorname{Def}(E, \theta)$ , and the isomorphism of sheaves

$$\pi_*(\mathcal{O}_{\Sigma_\theta}) \simeq \mathcal{H}^0(\mathrm{Def}'(E,\theta,C)) \simeq \mathcal{H}^0(\mathrm{Def}(E,\theta)).$$

We also have  $\mathcal{H}^1(\text{Def}'(E,\theta,C)) = 0$ . We obtain the following injection:

$$H^{0}(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}}) \simeq H^{1}(X, \operatorname{Def}'(E, \theta, C)) \longrightarrow H^{1}(X, \operatorname{Def}(E, \theta)).$$

$$\tag{7}$$

As explained in [18], there exist natural isomorphisms

$$\mathcal{H}^1(\mathrm{Def}(E,\theta)) \simeq \mathcal{H}^1(\mathrm{Def}(E,\theta,C)) \simeq \pi_*(K_{\Sigma_\theta}).$$

We also have  $\mathcal{H}^0(\text{Def}(E,\theta,C)) = 0$ . We obtain the following injection:

$$H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}}) \simeq H^1(X, \operatorname{Def}(E, \theta, C)) \longrightarrow H^1(X, \operatorname{Def}(E, \theta)).$$
 (8)

#### 1.4.2 The tangent space, the vertical direction and the horizontal direction

The restriction of the Hitchin fibration  $\mathcal{M}'_H \to \mathcal{A}'_H$  is locally a principal torus bundle equipped with an integrable connection. There exists the decomposition into the horizontal direction and the vertical direction:

$$T_{(E,\theta)}\mathcal{M}_H = (T_{(E,\theta)}\mathcal{M}_H)^{\mathrm{hor}} \oplus (T_{(E,\theta)}\mathcal{M}_H)^{\mathrm{ver}}.$$
(9)

We identify  $T_{(E,\theta)}\mathcal{M}_H \simeq H^1(X, \text{Def}(E,\theta))$ . The vertical direction  $(T_{(E,\theta)}\mathcal{M}'_H)^{\text{ver}}$  equals  $T_{(E,\theta)}\Phi_H^{-1}(\Phi_H(E,\theta))$ , which is identified with the image of (7). The horizontal direction equals the image of (8) as explained in [18]. In other words, the decomposition (9) is induced by the decomposition (6) in the symmetric case.

#### 1.4.3 The Hitchin metric and the semi-flat metric

Let  $\tau \in H^1(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}})$  and  $\nu \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$ . We regard  $\tau$  as an anti-holomorphic 1-form on  $\Sigma_{\theta}$ , i.e.,  $\tau \in H^0(\Sigma_{\theta}^{\dagger}, K_{\Sigma_{\theta}^{\dagger}})$ . Because  $\Sigma_{\theta} = \Sigma_{t\theta}$ , there exist the corresponding elements

$$\iota_t^{\operatorname{ver}}(\tau), \iota_t^{\operatorname{hor}}(\nu) \in H^1(X, \operatorname{Def}(E, t\theta)) = T_{(E, t\theta)} \mathcal{M}_H.$$

We have the following:

$$g_{\rm sf}(\iota_t^{\rm ver}(\tau), \iota_t^{\rm ver}(\tau)) = -2\sqrt{-1} \int_{\Sigma_\theta} \tau \wedge \overline{\tau} = \|\tau\|_{L^2}^2, \tag{10}$$

$$g_{\rm sf}(\iota_t^{\rm hor}(\nu), \iota_t^{\rm hor}(\nu)) = 2\sqrt{-1} \int_{\Sigma_\theta} \nu \wedge \overline{\nu} = \|\nu\|_{L^2}^2, \tag{11}$$

$$g_{\rm sf}(\iota_t^{\rm hor}(\nu), \iota_t^{\rm ver}(\tau)) = 0.$$
(12)

Let  $h_t$  be the harmonic metric of  $(E, t\theta)$ , which are compatible with C. The Hitchin metrics  $g_H$  at  $(E, t\theta)$  are induced by the natural  $L^2$ -metric on the space of  $\operatorname{End}(E)$ -valued 1-forms. Namely, for any  $L^2$ -sections  $\rho_i = \rho_i^{1,0} + \rho_i^{0,1}$ (i = 1, 2) of  $\operatorname{End}(E) \otimes \Omega^{1,0} \oplus \operatorname{End}(E) \otimes \Omega^{0,1}$  on  $W \subset X$ , we set

$$(\rho_1, \rho_2)_{L^2, h_t, W} = 2\sqrt{-1} \int_W \operatorname{Tr} \left( \rho_1^{1,0} \cdot (\rho_2^{1,0})_{h_t}^{\dagger} - \rho_1^{0,1} \cdot (\rho_2^{0,1})_{h_t}^{\dagger} \right).$$

If W = X,  $(\rho_1, \rho_2)_{L^2, h_t, X}$  is denoted by  $(\rho_1, \rho_2)_{L^2, h_t}$ . Let  $\mathbb{H}_t(\nu)$  and  $\mathbb{V}_t(\tau)$   $(t \ge 1)$  denote the harmonic 1-forms of  $(\operatorname{End}(E), \operatorname{ad} \theta, h_t)$  corresponding to  $\iota_t^{\operatorname{hor}}(\nu)$  and  $\iota_t^{\operatorname{ver}}(\tau)$ , respectively. We have the following:

$$g_H(\iota_t^{\operatorname{ver}}(\tau), \iota_t^{\operatorname{ver}}(\tau)) = (\mathsf{V}_t(\tau), \mathsf{V}_t(\tau))_{L^2, h_t},$$
(13)

$$g_H(\iota_t^{\text{hor}}(\nu), \iota_t^{\text{hor}}(\nu)) = (\mathbf{H}_t(\nu), \mathbf{H}_t(\nu))_{L^2, h_t},$$
(14)

$$g_H(\iota_t^{\text{hor}}(\nu), \iota_t^{\text{ver}}(\tau)) = (\mathsf{H}_t(\nu), \mathsf{V}_t(\tau))_{L^2, h_t}.$$
(15)

Because C is compatible with  $h_t$ , the decomposition  $\operatorname{End}(E) = \operatorname{End}(E)^{\operatorname{sym}} \oplus \operatorname{End}(E)^{\operatorname{asym}}$  is orthogonal with respect to h. We can observe that  $\operatorname{H}_t(\nu)$  is a section of the Dolbeault resolution of  $\operatorname{Def}(E, \theta, C)$ , and  $\operatorname{V}_t(\nu)$  is a section of the Dolbeault resolution of  $\operatorname{Def}'(E, \theta, C)$ . Hence, we obtain

$$g_H(\iota_t^{\mathrm{hor}}(\nu), \iota_t^{\mathrm{ver}}(\tau)) = 0 = g_{\mathrm{sf}}(\iota_t^{\mathrm{hor}}(\nu), \iota_t^{\mathrm{ver}}(\tau)).$$

We would like to show the following estimates for any  $0 < \kappa < M(\phi)/2$ :

$$g_H(\iota_t^{\text{hor}}(\nu), \iota_t^{\text{hor}}(\nu)) = g_{\text{sf}}(\iota_t^{\text{hor}}(\nu), \iota_t^{\text{hor}}(\nu)) + O(e^{-8\kappa t} \|\nu\|_{L^2}^2).$$
(16)

$$g_H(\iota_t^{\operatorname{ver}}(\tau), \iota_t^{\operatorname{ver}}(\tau)) = g_{\operatorname{sf}}(\iota_t^{\operatorname{ver}}(\tau), \iota_t^{\operatorname{ver}}(\tau)) + O(e^{-8\kappa t} \|\tau\|_{L^2}^2).$$
(17)

#### Canonically decoupled harmonic metric 1.4.4

Let  $Q \in X \setminus D_{\theta}$ . Let  $(X_Q, z_Q)$  denote a holomorphic coordinate neighbourhood around Q such that  $\phi = dz_Q dz_Q$ . There exists the decomposition, which is orthogonal with respect to C:

$$(E,\theta)_{|X_Q} = (E_{Q,1}, dz_Q) \oplus (E_{Q,2}, -dz_Q)$$

Let  $v_i$  (i = 1, 2) be frames of  $E_{Q,i}$  such that  $C(v_i, v_i) = 1$ . We define  $h_{\infty,Q}$  by  $h_{\infty,Q}(v_i, v_i) = 1$  and  $h_{\infty,Q}(v_1, v_2) = 0$ , which is independent of  $v_i$ . By varying  $Q \in X \setminus D_{\theta}$ , we obtain the canonical decoupled harmonic metric  $h_{\infty}$  of  $(E,\theta)_{|X\setminus D_{\theta}}$  compatible with C. It equals the limiting configuration in [13].

Let  $s_t$  be the automorphism of  $E_{|X \setminus D_{\theta}}$  determined by  $h_t = h_{\infty} s_t$ . We have  $\det(s_t) = 1$ .

We set  $g_{\phi} = |\phi|$  as the Kähler metric of  $X \setminus D_{\theta}$ , which induces the distance  $d_{\phi}$  on X. We obtain the connection  $\nabla_{\infty}$  of  $\operatorname{End}(E) \otimes T^*(X \setminus D_{\theta})^{\otimes m}$  for any  $m \in \mathbb{Z}_{\geq 0}$  induced by  $h_{\infty}$  and  $g_{\phi}$ . For any r > 0 and  $P \in X$ , we set  $X_P(r) = \{Q \in X \mid d_{\phi}(Q, P) < r\}$ . We set  $\kappa_0 = M(\phi)/2$ . We have

 $X_P(\kappa_0) \cap X_{P'}(\kappa_0) = \emptyset$  if P, P' are two distinct points in  $D_{\theta}$ .

For  $0 < \kappa < \kappa_0$ , we set  $\delta(\kappa) := \min\{(\kappa - \kappa_0)/10, \kappa/10\}$ . For each  $P \in D_{\theta}$ , we set

$$X_{P,\kappa}^{(1)} = X_P(\kappa_0 - \delta(\kappa)), \quad X_{P,\kappa}^{(2)} = X_P(\kappa_0 - 2\delta(\kappa)).$$

For any non-negative integer j, there exist  $C_j > 0$  such that the following holds on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$  for any  $t \ge 1$  (see Corollary 2.5):

$$\left|\nabla_{\infty}^{j}(s_{t} - \mathrm{id})\right|_{h_{\infty},g_{\phi}} \leq C_{j}e^{-4(\kappa + 7\delta(\kappa))t}.$$
(18)

This is essentially contained in [3].

The multiplication of  $\nu \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$  on L induces a section  $F_{\nu}$  of  $(\operatorname{End}(E) \otimes \Omega^{1,0})_{|X \setminus D_{\theta}}$  such that  $(\overline{\partial}_E + I_{\Sigma_{\theta}})_{|X \setminus D_{\theta}}$  $t \operatorname{ad} \theta) F_{\nu} = 0$ . Similarly,  $\tau$  induces a section  $F_{\tau}$  of  $(\operatorname{End}(E) \otimes \Omega^{0,1})_{|X \setminus D_{\theta}}$  such that  $(\overline{\partial}_E + t \operatorname{ad} \theta) F_{\tau} = 0$ . We can regard  $F_{\nu}$  and  $F_{\tau}$  as approximations of  $\mathbb{H}_t(\nu)$  and  $\mathbb{V}_t(\tau)$  on  $X \setminus \bigcup_P X_{P\kappa}^{(2)}$ .

#### **1.4.5** Approximation of $H_t(\nu)$ around $P \in D_{\theta}$

For any  $W \subset X$ , we set  $\Sigma_{\theta|W} = \Sigma_{\theta} \times_X W$ . There exists a holomorphic function  $\alpha_P$  on  $\Sigma_{\theta|X_P(\kappa_0)}$  such that  $\nu = d\alpha_P$ and that  $\alpha_P = 0$  at  $\pi^{-1}(P)$ . The multiplication of  $\alpha_P$  on L induces a holomorphic endomorphism  $F_{\alpha_P}$  on  $E_{|X_P(\kappa_0)|}$ such that  $[\theta, F_{\alpha_P}] = 0$ . We obtain the following  $\operatorname{End}(E)$ -valued  $C^{\infty}$  1-forms for  $t \geq 1$ :

$$\mathbf{H}_{P,t}(\nu) = (\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) F_{\alpha_P}.$$

They are harmonic 1-forms of  $(\operatorname{End}(E), t \operatorname{ad} \theta, h_t)|_{X_P}$ , i.e.,

$$(\overline{\partial}_E + t \operatorname{ad} \theta) \mathbb{H}_{P,t}(\nu) = 0, \quad (\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) \mathbb{H}_{P,t}(\nu) = 0.$$

We have  $\mathbb{H}_{P,t}(\nu)^{\circ} = F_{\nu}$  on  $X_P(\kappa_0) \setminus \{P\}$ . There exists a  $C^{\infty}$ -section  $\rho_P$  of  $\operatorname{End}(E)_{|X_P(\kappa_0) \setminus \{P\}}^{\operatorname{asym}}$  such that

$$(\overline{\partial}_E + t \operatorname{ad} \theta)\rho_{P,t} = F_{\nu} - \mathbb{H}_{P,t}(\nu).$$

### **1.4.6** Approximation of $H_t(\nu)$ on X

By patching  $F_{\nu}$  and  $\mathbb{H}_{P,t}(\nu)$   $(P \in D_{\theta})$ , we construct  $\mathbb{H}'_{\kappa,t}(\nu)$  as follows.

- On  $X \setminus \bigcup X_{P,\kappa}^{(1)}$ , we set  $\mathbf{H}'_{\kappa,t}(\nu) = F_{\nu}$ .
- For  $P \in D_{\theta}$ , let  $\chi_{P,\kappa} : X \to [0,1]$  be a  $C^{\infty}$ -function such that  $\chi_{P,\kappa} = 1$  on  $X_{P,\kappa}^{(2)}$  and  $\chi_{P,\kappa} = 0$  on  $X \setminus X_{P,\kappa}^{(1)}$ . Then, on  $X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)}$ , we set  $\mathtt{H}'_{\kappa,t}(\nu) = F_{\nu} - (\overline{\partial}_E + t \operatorname{ad} \theta) \ (\chi_{P,\kappa}\rho_P).$
- On  $X_{P\kappa}^{(2)}$ , we set  $\mathbf{H}'_{\kappa t}(\nu) = \mathbf{H}_{P,t}(\nu)$ .

By the construction, we obtain  $(\overline{\partial}_E + t \operatorname{ad} \theta) \mathsf{H}'_{\kappa,t}(\nu) = 0$ . We can observe that  $\mathsf{H}'_{\kappa,t}(\nu)$  is a section of the Dolbeault resolution of  $\text{Def}(E, \theta, C)$ , and that  $\mathtt{H}'_{\kappa,t}(\nu)^{\circ} = F_{\nu}$ . As explained in [18], the cohomology class of  $\mathtt{H}'_{\kappa,t}(\nu)$  is  $\iota^{\text{hor}}_{t}(\nu)$ .

There exist  $C_j > 0$   $(j \ge 0)$  such that the following holds on  $X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)}$  by (18):

$$\left|\nabla_{\infty}^{j}(\mathbb{H}_{P,t}(\nu) - F_{\nu})\right|_{h_{\infty},g_{\phi}} \leq C_{j}e^{-4(\kappa + 6\delta(\kappa))t} \|\nu\|_{L^{2}}.$$
(19)

There exist  $C_j > 0$   $(j \ge 0)$  such that the following holds on  $X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)}$ :

$$\left|\nabla_{\infty}^{j}\rho_{P}\right|_{h_{\infty},g_{\phi}} \leq C_{j}e^{-4(\kappa+6\delta(\kappa))t}\|\nu\|_{L^{2}}$$

Hence, there exist  $C_j > 0$   $(j \ge 0)$  such that on  $X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)}$ :

$$\left|\nabla_{\infty}^{j}(\mathsf{H}_{\kappa,t}'(\nu)-F_{\nu})\right|_{h_{\infty},g_{\phi}} \leq C_{j}e^{-4(\kappa+6\delta(\kappa))t}\|\nu\|_{L^{2}}.$$

Let  $g_X$  be a Kähler metric. Note that  $(\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) \mathbf{H}'_{\kappa,t}(\nu) = 0$  on  $X \setminus \bigcup_P X_{P,\kappa}^{(1)}$  and  $\bigcup_P X_{P,\kappa}^{(2)}$ . There exists C > 0 such that the following holds on X:

$$\left| \left( \partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger} \right) \mathbb{H}_{\kappa,t}'(\nu) \right|_{h_t,g_X} \le C e^{-4(\kappa + 6\delta(\kappa))t} \|\nu\|_{L^2}.$$

There exist unique  $C^{\infty}$ -sections  $\gamma_{\kappa,t}(\nu)$  of  $\operatorname{End}(E)^{\operatorname{asym}}$  such that

$$(\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger})(\overline{\partial}_E + t \operatorname{ad} \theta)\gamma_{\kappa,t}(\nu) = (\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger})\mathsf{H}_{\kappa,t}'(\nu).$$

By [18, Proposition 2.39], there exists C > 0 such that

$$\|\gamma_{\kappa,t}(\nu)\|_{L^2,h_t,g_X} + \|(\overline{\partial}_E + t\operatorname{ad}\theta)\gamma_{\kappa,t}(\nu)\|_{L^2,h_t,g_X} \le Ce^{-4(\kappa+5\delta(\kappa))t}\|\nu\|_{L^2}.$$

We have

$$\mathbf{H}_t(\nu) = \mathbf{H}'_{\kappa,t}(\nu) - \gamma_{\kappa,t}(\nu).$$

# **1.4.7** Estimate of the pairings of $H_t(\nu)$

First, we observe

$$(\mathfrak{H}_{t}(\nu),\mathfrak{H}_{t}(\nu))_{L^{2},h_{t}} = (\mathfrak{H}_{\kappa,t}'(\nu),\mathfrak{H}_{\kappa,t}'(\nu))_{L^{2},h_{t}} + O(e^{-8\kappa t} \|\nu\|_{L^{2}}^{2}).$$
(20)

Indeed, because  $(\overline{\partial} + t \operatorname{ad} \theta)^*_{h_t, q_X} \mathbb{H}_t(\nu) = 0$ , we obtain

$$(\mathbf{H}_{t}(\nu),\mathbf{H}_{t}(\nu))_{L^{2},h_{t}} = (\mathbf{H}_{t}(\nu),\mathbf{H}_{\kappa,t}'(\nu))_{L^{2},h_{t}} + (\mathbf{H}_{t}(\nu),(\overline{\partial}_{E}+t\,\mathrm{ad}\,\theta)\gamma_{\kappa,t}(\nu))_{L^{2},h_{t}} = (\mathbf{H}_{t}(\nu),\mathbf{H}_{\kappa,t}'(\nu))_{L^{2},h_{t}} + ((\overline{\partial}_{E}+t\,\mathrm{ad}\,\theta)^{*}_{h_{t},g_{X}}\mathbf{H}_{t}(\nu),\gamma_{\kappa,t}(\nu))_{L^{2},h_{t},g_{X}} = (\mathbf{H}_{t}(\nu),\mathbf{H}_{\kappa,t}'(\nu))_{L^{2},h_{t}}.$$
(21)

Because  $(\overline{\partial} + t \operatorname{ad} \theta)^*_{h_t,g_X} \mathbb{H}'_{\kappa,t}(\nu) = O(e^{-4\kappa t} \|\nu\|_{L^2})$  and  $\gamma_{\kappa,t}(\nu) = O(e^{-4\kappa t} \|\nu\|_{L^2})$ , we obtain

$$\left(\mathsf{H}_{\kappa,t}'(\nu), (\overline{\partial}_E + t \operatorname{ad} \theta)\gamma_{\kappa,t}(\nu)\right)_{L^2,h_t} = \left((\overline{\partial}_E + t \operatorname{ad} \theta)_{h_t,g_X}^* \mathsf{H}_{\kappa,t}'(\nu), \gamma_{\kappa,t}(\nu)\right)_{L^2,h_t,g_X} = O\left(e^{-8\kappa t} \|\nu\|_{L^2}^2\right).$$

Hence, we obtain (20).

We have the following estimates on  $W_{\kappa} = X \setminus \bigcup X_{P,\kappa}^{(2)}$ :

$$\mathbf{H}_{\kappa,t}'(\nu)^{\circ} = F_{\nu}, \qquad \left| \left( \mathbf{H}_{\kappa,t}'(\nu) \right)^{\perp} \right|_{h_{t},g_{X}} = O\left( e^{-4\kappa t} \|\nu\|_{L^{2}} \right), \qquad \left| s_{t} - \mathrm{id} \right|_{h_{t}} = O(e^{-4\kappa t}).$$
(22)

We can prove the following by using (22) with an elementary consideration as in §3.6.1:

$$(\mathbf{H}_{\kappa,t}'(\nu),\mathbf{H}_{\kappa,t}'(\nu))_{L^{2},h_{t},W_{\kappa}} = 2\sqrt{-1} \int_{W_{\kappa}} \operatorname{Tr}\left(F_{\nu} \cdot (F_{\nu})_{h_{\infty}}^{\dagger}\right) + O\left(e^{-8\kappa t} \|\nu\|_{L^{2}}^{2}\right) \\ = 2\sqrt{-1} \int_{\Sigma_{\theta|W_{\kappa}}} \nu \wedge \overline{\nu} + O\left(e^{-8\kappa t} \|\nu\|_{L^{2}}^{2}\right).$$
(23)

On  $X_{P,\kappa}^{(2)}$ , we have  $\mathsf{H}'_{\kappa,t}(\nu) = \mathsf{H}_{P,t}(\nu)$ . Because  $(\partial_{E,h_t} + t\theta^{\dagger}_{h_t})^*_{h_t,g_X}\mathsf{H}_{P,t}(\nu) = 0$ , we obtain the following by using the Stokes formula (Lemma 3.55):

$$\left(\mathsf{H}_{\kappa,t}'(\nu),\mathsf{H}_{\kappa,t}'(\nu)\right)_{L^2,h_t,X_{P,\kappa}^{(2)}} = 2\sqrt{-1}\int_{\partial X_{P,\kappa}^{(2)}} \mathrm{Tr}\left(F_{\alpha_P}\cdot(\mathsf{H}_{P,t}(\nu)^{1,0})_{h_t}^{\dagger}\right).$$

By using the estimates (18) and (19) with the elementary consideration in §3.6.1, we obtain

$$2\sqrt{-1} \int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr} \left( F_{\alpha_P} \cdot (\mathfrak{H}_{P,t}(\nu)^{1,0})_{h_t}^{\dagger} \right) = 2\sqrt{-1} \int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr} \left( F_{\alpha_P} \cdot (F_{\nu})_{h_{\infty}}^{\dagger} \right) + O\left( e^{-8\kappa t} \|\nu\|_{L^2}^2 \right) \\ = 2\sqrt{-1} \int_{\partial \Sigma_{\theta|X_{P,\kappa}^{(2)}}} \alpha_P \cdot \overline{\nu} + O\left( e^{-8\kappa t} \|\nu\|_{L^2}^2 \right) = 2\sqrt{-1} \int_{\Sigma_{\theta|X_{P,\kappa}^{(2)}}} \nu \overline{\nu} + O\left( e^{-8\kappa t} \|\nu\|_{L^2}^2 \right).$$
(24)

In all, we obtain

$$(\mathfrak{H}_t(\nu),\mathfrak{H}_t(\nu))_{L^2,h_t} = (\nu,\nu)_{L^2} + O\left(e^{-8\kappa t} \|\nu\|_{L^2}^2\right) \quad (0 < \kappa < M(\phi)/2).$$

This implies (16).

# **1.4.8** Approximation of $V_t(\tau)$ on X

For each  $P \in D_{\theta}$ , there exists an anti-holomorphic function  $\beta_P$  on  $\Sigma_{\theta|X_P(\kappa_0)}$  such that  $\tau = d\beta_P$ . Let  $\chi_{P,\kappa} : X \to [0,1]$  be as before. We set

$$\tau_{\kappa}^{\circ} = \tau - \sum_{P \in D_{\theta}} \overline{\partial} (\pi^*(\chi_{P,\kappa}) \cdot \beta_P).$$

The multiplication of  $\tau_{\kappa}^{\circ}$  on L induces a  $C^{\infty}$ -section  $F_{\tau_{\kappa}^{\circ}}$  of  $\operatorname{End}(E) \otimes \Omega^{0,1}$  such that  $[\theta, F_{\tau_{\kappa}^{\circ}}] = 0$ . We obtain  $(\overline{\partial}_E + t \operatorname{ad} \theta) F_{\tau_{\kappa}^{\circ}} = 0$ . The cohomology class of  $F_{\tau_{\kappa}^{\circ}}$  is  $\iota_t^{\operatorname{ver}}(\tau)$ .

We may regard  $\pi^{\dagger} : \Sigma_{\theta}^{\dagger} \to X^{\dagger}$  as the spectral curve of the Higgs bundle  $(E, \partial_{E,h_t}, \theta_{h_t}^{\dagger})$  on  $X^{\dagger}$ . We may regard  $\beta_P$  as a holomorphic function on  $\Sigma_{\theta|X_P(\kappa_0)}^{\dagger}$ . There exists  $L_t$  on  $\Sigma_{\theta}^{\dagger}$  with an isomorphism  $\pi_*^{\dagger}(L_t) \simeq (E, \partial_{E,h_t}, \theta_{h_t}^{\dagger})$ . The multiplication of  $\beta_P$  induces a holomorphic endomorphism  $F_{\beta_P}^{\dagger}$  of  $(E, \partial_{E,h_t})$ . We have  $F_{\beta_P}^{\dagger} = (F_{\overline{\beta_P}})_{h_t}^{\dagger}$ . We note that  $(\overline{\partial}_E + t\theta)F_{\beta_P}^{\dagger}$  is a harmonic 1-form of  $(\operatorname{End}(E), t \operatorname{ad} \theta, h_t)$ .

We set

$$\mathbf{V}_{\kappa,t}'(\tau) = F_{\tau_{\kappa}^{\circ}} + \sum_{P \in D_{\theta}} (\overline{\partial}_E + t \operatorname{ad} \theta) (\chi_{P,\kappa} F_{\beta_P}^{\dagger}).$$

By the construction, we have  $(\overline{\partial}_E + t \operatorname{ad} \theta) \mathsf{V}'_{\kappa,t}(\tau) = 0$ , and its cohomology class equals  $\iota_t^{\operatorname{ver}}(\tau)$ .

By (18), there exists C > 0 such that

$$\left| (\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) \mathsf{V}_{\kappa,t}'(\tau) \right|_{h_t,g_X} \le C e^{-4(\kappa + 7\delta(\kappa))t} \|\tau\|_{L^2}.$$

We also have  $\partial_X \operatorname{tr}(\mathbf{V}'_{\kappa,t}(\tau)) = 0$ . There exist unique sections  $\gamma_{\kappa,t}(\tau)$  of  $\operatorname{End}(E)$  such that

$$(\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger})(\overline{\partial}_E + t \operatorname{ad} \theta)\gamma_{\kappa,t}(\tau) = (\overline{\partial}_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) \mathsf{V}_{\kappa,t}'(\tau).$$

By [18, Proposition 2.39], there exists C > 0 such that

$$\|\gamma_{\kappa,t}(\tau)\|_{L^{2},h_{t},g_{X}} + \|(\overline{\partial}_{E} + t \operatorname{ad} \theta)\gamma_{\kappa,t}(\tau)\|_{L^{2},h_{t},g_{X}} \le Ce^{-4(\kappa+5\delta(\kappa))t}\|\tau\|_{L^{2}}.$$

We have

$$\mathbf{V}_t(\tau) = \mathbf{V}'_{\kappa,t}(\tau) - (\overline{\partial}_E + t \operatorname{ad} \theta) \gamma_{\kappa,t}(\tau)$$

# 1.4.9 Estimate of the pairings of $V_t(\tau)$

As in the case of (20), we obtain

$$\left(\mathbf{V}_{t}(\tau),\mathbf{V}_{t}(\tau)\right)_{L^{2},h_{t}}=\left(\mathbf{V}_{\kappa,t}'(\tau),\mathbf{V}_{\kappa,t}'(\tau)\right)_{L^{2},h_{t}}+O\left(e^{-8\kappa t}\|\tau\|_{L^{2}}^{2}\right).$$

By using (18) with the elementary consideration in §3.6.2, we obtain

$$\left( \mathbf{V}_{\kappa,t}'(\tau), \mathbf{V}_{\kappa,t}'(\tau) \right)_{L^{2}, h_{t}, W_{\kappa}} = -2\sqrt{-1} \int_{W_{\kappa}} \operatorname{Tr} \left( F_{\tau} \cdot (F_{\tau})_{h_{\infty}}^{\dagger} \right) + O\left( e^{-8\kappa t} \|\tau\|_{L^{2}}^{2} \right)$$

$$= -2\sqrt{-1} \int_{\Sigma_{\theta|W_{\kappa}}} \tau \overline{\tau} + O\left( e^{-8\kappa t} \|\tau\|_{L^{2}}^{2} \right).$$

$$(25)$$

By using the Stokes formula (Lemma 3.55), and by using (18) with the elementary consideration in §3.6.2, we obtain

$$\begin{pmatrix} \mathsf{V}_{\kappa,t}'(\tau), \mathsf{V}_{\kappa,t}'(\tau) \end{pmatrix}_{L^{2}, h_{t}, X_{P,\kappa}^{(2)}} = -2\sqrt{-1} \int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr} \left( F_{\beta_{P}}^{\dagger} \cdot \left( \mathsf{V}_{t}'(\tau)^{0,1} \right)_{h_{t}}^{\dagger} \right)$$

$$= -2\sqrt{-1} \int_{\partial \Sigma_{\theta \mid X_{P,\kappa}^{(2)}}} \beta_{P} \cdot \overline{\tau} + O\left( e^{-8\kappa t} \|\tau\|_{L^{2}}^{2} \right) = -2\sqrt{-1} \int_{\Sigma_{\theta \mid X_{P,\kappa}^{(2)}}} \tau \overline{\tau} + O\left( e^{-8\kappa t} \|\tau\|_{L^{2}}^{2} \right).$$
(26)

In all, we obtain

$$\left(\mathbf{V}_t(\tau), \mathbf{V}_t(\tau)\right)_{L^2, h_t} = (\tau, \tau)_{L^2} + O\left(e^{-8\kappa t} \|\tau\|_{L^2}^2\right) \qquad (0 < \kappa < M(\phi)/2).$$

This implies (17).

# 2 Local estimates

## 2.1 Variations of Simpson's main estimate

We explain a variant of Simpson's main estimate in the rank 2 case. We also use the functions used in [3] to improve the estimate.

#### 2.1.1 A general estimate in the rank 2 case

For any R > 0, we set  $U(R) = \{z \in \mathbb{C} \mid |z| < R\}.$ 

Let  $R_0 > 0$ . Let  $(E, \overline{\partial}_E, \theta)$  be a Higgs bundle of rank 2 on U(R) for some  $R > 2R_0$ . We fix an isomorphism  $\kappa : \det(E) \simeq \mathcal{O}_{U(R)}$ . Let f be the endomorphism of E determined by  $\theta = f dz$ . We assume that there exits a decomposition

$$(E, f) = (E_1, 1) \oplus (E_{-1}, -1).$$

Let  $\mathcal{H}(E,\theta;\kappa)$  denote the set of harmonic metrics h of  $(E,\theta)$  such that  $\det(h) = 1$  under the isomorphism  $\kappa$ :  $\det(E) \simeq \mathcal{O}_X$ .

For any  $h \in \mathcal{H}(E, \theta; \kappa)$ , let  $\pi_1$  denote the projection onto  $E_1$ . We obtain the orthogonal projection  $\pi_1^h$  of E onto  $E_1$ . We regard  $\pi_1$  and  $\pi_1^h$  as endomorphisms of E in natural ways. We set  $\rho := \pi_1 - \pi_1^h$ . We have  $|\pi_1|_h^2 = |\pi_1^h|_h^2 + |\rho|_h^2$ . We shall prove the following proposition in §2.1.6.

**Proposition 2.1** For any  $0 < \gamma < 2\sqrt{2}$ , there exists  $C(R_0, \gamma) > 0$  depending only on  $R_0$  and  $\gamma$ , such that the following holds on  $U(R - R_0)$  for any  $h \in \mathcal{H}(E, \theta; \kappa)$ :

$$|\rho|_h \le C(R_0, \gamma) e^{-\gamma(R-|z|)}.$$

#### 2.1.2 Refinement under an additional assumption

Let  $v_i$  (i = 1, 2) be frames of  $E_i$  such that  $\kappa(v_1 \wedge v_2) = 1$ . We shall prove the following proposition in §2.1.7.

**Proposition 2.2** Let  $h \in \mathcal{H}(E, \theta; \kappa)$ . Suppose that there exist  $\gamma_0 > 2$  and B(h) > 0 such that the following holds on U(R):

$$h(v_1, v_1) + h(v_2, v_2) + |\partial_z h(v_1, v_1)| + |\partial_z h(v_2, v_2)| + |\partial_z h(v_1, v_2)| + |\partial_{\overline{z}} h(v_1, v_2)| \le B(h)e^{-\gamma_0(R-|z|)}.$$
 (27)

Then, for any  $0 < \gamma < 4$ , there exist  $C(R_0, \gamma, \gamma_0, B(h)) > 0$  depending only on  $R_0, \gamma, \gamma_0, B(h)$ , such that the following holds on  $U(R - R_0)$ :

$$|\rho|_h \le C(R_0, \gamma, \gamma_0, B(h))e^{-\gamma(R-|z|)}$$

#### 2.1.3 Refinement in the symmetric case

Let C be a non-degenerate symmetric pairing of  $(E, \theta)$  such that  $\det(C) = 1$  under the isomorphism  $\kappa$ . Let  $\mathcal{H}(E, \theta; C)$  denote the set of harmonic metrics of  $(E, \theta)$  compatible with C. For any  $h \in \mathcal{H}(E, \theta; C)$ , we obtain an estimate as in Proposition 2.2 without the assumption (27). We shall prove the following proposition in §2.1.8.

**Proposition 2.3** For any  $0 < \gamma < 4$ , there exists  $C(R_0, \gamma) > 0$  such that the following holds on  $U(R - R_0)$  for any  $h \in \mathcal{H}(E, \theta; C)$ :

$$|\rho|_h \le C(R_0, \gamma) e^{-\gamma(R-|z|)}.$$

Let  $v_i$  be frames of  $E_i$  such that  $C(v_i, v_i) = 1$ . The following proposition is a refinement of Proposition 2.3.

**Proposition 2.4** For any  $0 < \gamma < 4$  and  $(j,k) \in \mathbb{Z}^2_{\geq 0}$ , there exists  $C_{j,k}(R_0,\gamma) > 0$  such that the following holds for any  $h \in \mathcal{H}(E,\theta;C)$  on  $U(R-R_0)$ :

$$|\partial_{z}^{j}\partial_{\overline{z}}^{k}(h(v_{i},v_{i})-1)| \leq C_{j,k}(R_{0},\gamma)e^{-2\gamma(R-|z|)},$$
(28)

$$|\partial_{z}^{j}\partial_{z}^{k}h(v_{1},v_{2})| \leq C_{j,k}(R_{0},\gamma)e^{-\gamma(R-|z|)}.$$
(29)

Let  $h^C$  denote the unique decoupled harmonic metric of  $(E, \theta)$  compatible with C (see [12]). We have  $h^C(v_i, v_i) = 1$  and  $h^C(v_1, v_2) = 0$ . Let  $\nabla$  denote the Chern connection of E determined by  $h^C$ . For any  $h \in \mathcal{H}(E, \theta; C)$ , let  $s(h^C, h)$  be the automorphism of E determined by  $h = h^C \cdot s$ . We set  $\operatorname{End}(E)^\circ = \operatorname{End}(E_1) \oplus \operatorname{End}(E_2)$  and  $\operatorname{End}(E)^\perp = \operatorname{Hom}(E_1, E_2) \oplus \operatorname{Hom}(E_2, E_1)$ . We obtain the decomposition

$$\operatorname{End}(E) = \operatorname{End}(E)^{\circ} \oplus \operatorname{End}(E)^{\perp}.$$

We have the corresponding decomposition  $s(h^C, h) = s(h^C, h)^\circ + s(h^C, h)^\perp$ .

**Corollary 2.5** For any  $0 < \gamma < 4$  and  $(j,k) \in \mathbb{Z}^2_{\geq 0}$ , there exists  $C'_{j,k}(R_0,\gamma) > 0$  such that the following holds for any  $h \in \mathcal{H}(E,\theta;C)$  on  $U(R-R_0)$ :

$$\begin{aligned} |\nabla_z^j \nabla_{\overline{z}}^k (s(h^C, h)^\circ - \mathrm{id})| &\leq C'_{j,k}(R_0, \gamma) e^{-2\gamma(R-|z|)}, \\ |\nabla_z^j \nabla_{\overline{z}}^k (s(h^C, h)^\perp)| &\leq C'_{j,k}(R_0, \gamma) e^{-\gamma(R-|z|)}. \end{aligned}$$

**Remark 2.6** Proposition 2.3 and Proposition 2.4 are essentially contained in [3]. They can be proved independently from Proposition 2.1 and Proposition 2.2.

#### 2.1.4 A general inequality

Let  $h \in \mathcal{H}(E, \theta; \kappa)$ . We have the following equality:

$$-\partial_{z}\partial_{\overline{z}}|\pi_{1}|_{h}^{2} = -|\partial_{E,h}\pi_{1}|_{h}^{2} - \left| [f_{h}^{\dagger},\pi_{1}] \right|_{h}^{2}.$$
(30)

Let  $v_i$  (i = 1, 2) be frames of  $E_i$  such that  $v_1 \wedge v_2 = 1$ . Let H be the Hermitian matrix valued function determined by  $H_{i,j} = h(v_i, v_j)$ . To simplify, we set  $a = h(v_1, v_1)$ ,  $b = h(v_1, v_2)$  and  $c = h(v_2, v_2)$ , i.e.,

$$H = \left(\begin{array}{cc} a & b \\ \overline{b} & c \end{array}\right).$$

Because det(h) = 1, we have det $(H) = ac - |b|^2 = 1$ . We also have  $|\rho|_h^2 = |b|^2$ .

We shall use the following lemma implicitly.

**Lemma 2.7** Let g be an endomorphism of E. Let  $g_h^{\dagger}$  be the adjoint of g with respect to h. Let G and  $G_H^{\dagger}$  denote the matrix valued functions determined by  $g\mathbf{v} = \mathbf{v}G$  and  $g_h^{\dagger}\mathbf{v} = \mathbf{v}G_H^{\dagger}$ . Then, we have  $G_H^{\dagger} = \overline{H}^{-1} \cdot ({}^t\overline{G}) \cdot \overline{H}$ .

**Lemma 2.8** We have  $|[f_h^{\dagger}, \pi_1]|_h^2 = 8(1+|b|^2)|b|^2$ .

**Proof** Let F and  $F_H^{\dagger}$  be the matrix valued functions determined by  $f \boldsymbol{v} = \boldsymbol{v} F$  and  $f_h^{\dagger} \boldsymbol{v} = \boldsymbol{v} \cdot F_H^{\dagger}$ . More explicitly,

$$F = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}, \quad F_H^{\dagger} = \begin{pmatrix} c & -\overline{b} \\ -b & a \end{pmatrix} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} \begin{pmatrix} a & \overline{b} \\ b & c \end{pmatrix} = \begin{pmatrix} 1+2|b|^2 & 2\overline{b}c \\ -2ab & -1-2|b|^2 \end{pmatrix}.$$

Let  $\Pi_1$  be the matrix valued function determined by  $\pi_1 \boldsymbol{v} = \boldsymbol{v} \cdot \Pi_1$ , i.e.,

$$\Pi_1 = \left(\begin{array}{cc} 1 & 0\\ 0 & 0 \end{array}\right).$$

We can check the following:

$$[F_H^{\dagger}, \Pi_1] = \begin{pmatrix} 0 & -2\overline{b}c \\ -2ab & 0 \end{pmatrix} = [F_H^{\dagger}, \Pi_1]_H^{\dagger}.$$

We obtain

$$[F_{H}^{\dagger},\Pi_{1}] \cdot [F_{H}^{\dagger},\Pi_{1}]_{H}^{\dagger} = \begin{pmatrix} 4(1+|b|^{2})|b|^{2} & 0\\ 0 & 4(1+|b|^{2})|b|^{2} \end{pmatrix}$$

Hence, we obtain

$$[f_h^{\dagger}, \pi_1]|_h^2 = \text{Tr}([F_H^{\dagger}, \Pi_1]_H^{\dagger} \cdot [F_H^{\dagger}, \Pi_1]) = 8(1 + |b|^2)|b|^2$$

Thus, we obtain Lemma 2.8.

Corollary 2.9 We obtain  $-\partial_z \partial_{\overline{z}} |b|_h^2 \leq -8|b|_h^2$ .

#### 2.1.5 Bessel function of the first kind

We recall some functions by following [3, §5]. Let  $I_0(z) : \mathbb{C} \to \mathbb{R}_{>0}$  be the function as in [3, §5], i.e.,  $I_0$  denotes the unique positive even  $C^{\infty}$ -function such that (i)  $I_0(z)$  depends only on |z|, (ii)  $(\partial_x^2 + \partial_y^2)I_0 = I_0$ , (iii)  $I_0(0) = 1$ . We have the convergence  $I_0(z) \cdot (2\pi|z|)^{1/2}e^{-|z|} \to 1$  as  $|z| \to \infty$ . In particular, we have the following lemma.

**Lemma 2.10** For any 0 < u < 1, there exists  $C_0(u) > 0$  such that the following holds on  $\mathbb{C}$ :

$$I_0(z)^{-1} \le C_0(u)e^{-u|z|}.$$

**Lemma 2.11 ([3])** For any  $0 < \gamma_1 < \gamma_2$ , there exists  $A(\gamma_1, \gamma_2) > 0$  such that the following holds for any 0 < b < a:

$$e^{-\gamma_2(a-b)} < A(\gamma_1, \gamma_2) \frac{I_0(\gamma_1 b)}{I_0(\gamma_1 a)}$$

#### 2.1.6 Proof of Proposition 2.1

For any r > 0 and  $z_0 \in \mathbb{C}$ , we set  $U(z_0, r) = \{z \in \mathbb{C} \mid |z - z_0| < r\}$ . We set  $r_0 = R_0/10$ . We recall the following general lemma.

**Lemma 2.12** There exists  $C_1(r_0)$  depending only on  $r_0$  such that the following holds:

• Let h be any harmonic metric of  $(E, \theta)_{|U(z_0, r_0)}$ . Then,  $|f|_h \leq C_1(r_0)$  holds on  $U(z_0, r_0/2)$ .

**Corollary 2.13**  $|f|_h \leq C_1(r_0)$  holds on  $U(R - r_0/2)$  for any  $h \in \mathcal{H}(E, \theta)$ .

Note that  $|f|_h^2 = 2(1+2|b|^2)$ .

**Corollary 2.14** There exists  $C_2(r_0) > 0$  such that  $|b| \le C_2(r_0)$  on  $U(R - r_0/2)$ .

Lemma 2.15 The following hols:

$$|b(0)|^2 \le 2C_2(r_0)^2 I_0(4\sqrt{2}(R-r_0/2))^{-1}.$$

**Proof** We set  $J(z) = 2C_2(r_0)^2 I_0(4\sqrt{2}z) I_0(4\sqrt{2}(R-r_0/2))^{-1}$ . We have

$$-\partial_z \partial_{\overline{z}} J(z) = -8J(z), \quad J(R - r_0/2) = 2C_2(r_0)^2.$$

Let  $Z = \{z \in U(R - r_0/2) | |b(z)|^2 > J(z)\}$ . We deduce a contradiction by assuming  $Z \neq \emptyset$ . It is relatively compact in  $U(R - r_0/2)$ . We have  $|b(z)|^2 = J(z)$  on  $\partial Z$ . On Z, we have

$$-\partial_z \partial_{\overline{z}} (|b|^2 - J) \le -8(|b|^2 - J) < 0.$$

Hence,  $|b|^2 - J$  is subharmonic on Z. By the maximum principle, we obtain  $|b|^2 - J \le 0$ , which contradicts with the definition of Z. Hence, we obtain  $Z = \emptyset$ . In particular,  $|b(0)|^2 \le J(0)$ .

**Corollary 2.16** For any 0 < u < 1,

$$|b(0)|^2 \le 2C_2(r_0)^2 C_0(u) e^{-4\sqrt{2}(R-r_0/2)u} \le 2C_2(r_0)^2 C_0(u) e^{2\sqrt{2}r_0} e^{-4\sqrt{2}uR}.$$

For  $z_0 \in U(R-R_0)$ , we have  $U(z_0, R-|z_0|) \subset U(R)$ . By applying Corollary 2.16, we obtain

$$|b(z_0)|^2 \le 2C_2(r_0)^2 C_0(u) e^{-4\sqrt{2}(R-|z_0|-r_0/2)u} \le 2C_2(r_0)^2 C_0(u) e^{2\sqrt{2}r_0} e^{-4\sqrt{2}u(R-|z_0|)}$$

It implies the claim of Proposition 2.1.

#### 2.1.7 Proof of Proposition 2.2

Lemma 2.17 We obtain

$$\begin{aligned} \left|\partial_{E,h,z}\pi\right|_{h}^{2} &= (1+|b|^{2})^{2} \left(\left|\partial_{\overline{z}}b\right|^{2}+\left|\partial_{z}b\right|^{2}\right)+\left|b\right|^{2} (a^{2}|\partial_{z}c|^{2}+c^{2}|\partial_{z}a|^{2}) \\ &-2\operatorname{Re}\left(ba^{2}c\partial_{z}\overline{b}\partial_{\overline{z}}c+\overline{b}ac^{2}\partial_{z}b\partial_{\overline{z}}a+b^{2}\left(-c\partial_{z}\overline{b}+\overline{b}\partial_{z}c\right)\left(-\overline{b}\partial_{\overline{z}}a+a\partial_{\overline{z}}\overline{b}\right)\right). \end{aligned}$$
(31)

**Proof** We have

$$\overline{H}^{-1}\partial_{z}\overline{H} = \begin{pmatrix} c & -\overline{b} \\ -b & a \end{pmatrix} \begin{pmatrix} \partial_{z}a & \partial_{z}\overline{b} \\ \partial_{z}b & \partial_{z}c \end{pmatrix} = \begin{pmatrix} c\partial_{z}a - \overline{b}\partial_{z}b & c\partial_{z}\overline{b} - \overline{b}\partial_{z}c \\ -b\partial_{z}a + a\partial_{z}b & -b\partial_{z}\overline{b} + a\partial_{z}c \end{pmatrix}$$

Let A be determined by  $(\partial_{E,h,z}\pi_1)\boldsymbol{v} = \boldsymbol{v}\cdot A$ . We set  $\beta = -c\partial_z \overline{b} + \overline{b}\partial_z c$  and  $\gamma = -b\partial_z a + a\partial_z b$ . We obtain

$$A = \partial_z \Pi_1 + [\overline{H}^{-1} \partial_z \overline{H}, \Pi_1] = \begin{pmatrix} 0 & \beta \\ \gamma & 0 \end{pmatrix}.$$

We have

$$A \cdot \overline{H}^{-1} \overline{A} \cdot \overline{H} = \begin{pmatrix} -b^2 \beta \overline{\gamma} + a^2 |\beta|^2 & -bc\beta \overline{\gamma} + a\overline{b} |\beta|^2 \\ bc |\gamma|^2 - a\overline{b} \overline{\gamma} \overline{\beta} & |\gamma|^2 c^2 - \gamma \overline{\beta} \overline{b}^2 \end{pmatrix}.$$

We have

$$\left|\partial_{E,h,z}\pi_1\right|_h^2 = \operatorname{Tr}\left(A \cdot \overline{H}^{-1} \overline{A} \cdot \overline{H}\right) = a^2 |\beta|^2 + c^2 |\gamma|^2 - 2\operatorname{Re}(b^2 \beta \overline{\gamma}).$$

It is equal to

$$a^{2}\left(c^{2}|\partial_{z}\overline{b}|^{2}+|b|^{2}|\partial_{z}c|^{2}-2\operatorname{Re}(bc\partial_{z}\overline{b}\partial_{\overline{z}}c)\right)+c^{2}\left(|b|^{2}|\partial_{z}a|^{2}+|a|^{2}|\partial_{z}b|^{2}-2\operatorname{Re}(\overline{b}a\partial_{z}b\partial_{\overline{z}}a)\right)-2\operatorname{Re}\left(b^{2}(-c\partial_{z}\overline{b}+\overline{b}\partial_{z}c)(-\overline{b}\partial_{\overline{z}}a+a\partial_{\overline{z}}\overline{b})\right).$$
 (32)

Then, by using  $ac = 1 + |b|^2$ , we obtain (31).

We set  $W = \{ z \in U(R) | b(z) \neq 0 \}$ . We take  $4 < \gamma_1 < \gamma_0 + \min\{2\sqrt{2}, \gamma_0\}$ .

**Lemma 2.18** There exists  $C_{20}(B(h), \gamma_1) > 0$ , depending only on B(h) and  $\gamma_1$  such that the following holds on W:

$$-\partial_z \partial_{\overline{z}} |b| \le -4|b| + C_{20}(B(h), \gamma_1) e^{-\gamma_1(R-|z|)}.$$
(33)

**Proof** On W, we have

$$\partial_z |b| = \partial_{\overline{z}} |b| \le \frac{1}{2} \left( |\partial_z b| + |\partial_{\overline{z}} b| \right).$$

We obtain

$$2\partial_{z}|b|\partial_{\overline{z}}|b| \leq \frac{1}{2} (|\partial_{z}b| + |\partial_{\overline{z}}b|)^{2} \leq |\partial_{z}b|^{2} + |\partial_{\overline{z}}b|^{2}.$$

Then, we obtain (33) from (30) and (31).

Let  $0 < \gamma < 4$ . We set  $\eta = (4 + \gamma)/2$ . We have

$$-\partial_z \partial_{\overline{z}} I_0(\eta z) = -\frac{1}{4} \eta^2 I_0(\eta z).$$

There exists  $C_{21}(B(h), \gamma_1, \gamma)$  such that  $|b| < C_{21}(B(h), \gamma_1, \gamma)$  on  $|z| = R - r_0$ , and that the following holds for  $g = C_{21}(B(h), \gamma_1, \gamma)I_0(\eta z)I_0(\eta (R - r_0))^{-1}$  on  $U(R - r_0)$ :

$$-\partial_z \partial_{\overline{z}} g \ge -4g + C_{20}(B(h), \gamma_1) e^{-\gamma_1(R-|z|)}$$

**Lemma 2.19** We have  $|b| \leq g$  on  $U(R - r_0)$ . In particular,  $|b(0)| \leq C_{21}(B(h), \gamma_1, \gamma)I_0(\eta(R - r_0))^{-1}$ .

**Proof** Let  $Z = \{z \in U(R - r_0) | |b(z)| > g(z)\}$ . We shall deduce a contradiction by assuming  $Z \neq \emptyset$ . We note that  $Z \cap \partial U(R - r_0) = \emptyset$ . We also have  $Z \subset W$ . Hence, we have |b| = g on  $\partial Z$ , and the following inequality on Z:

$$-\partial_z \partial_{\overline{z}}(|b| - g) \le -4(|b| - g).$$

Then, we obtain  $|b| \leq g$  on Z which is a contradiction.

We obtain

$$|b(0)| \le C_{21}(B(h), \gamma, \gamma_1)C_0(\gamma/\eta)e^{\gamma r_0}e^{-\gamma R}$$

By applying the argument to the restriction of  $(E, \theta, h)$  to  $U(z_0, R - |z_0|)$  for  $z_0 \in U(R_1)$ , we obtain

$$|b(z_0)| \le C_{21}(B(h), \gamma, \gamma_1) C_0(\gamma/\eta) e^{\gamma r_0} e^{-\gamma (R-|z_0|)}.$$

Thus, we obtain Proposition 2.2.

# 2.1.8 Proof of Proposition 2.3 and the C<sup>0</sup>-part of Proposition 2.4

Let  $v_1, v_2$  be a frame such that  $C(v_i, v_i) = 1$  and  $C(v_1, v_2) = 0$ . Let  $h \in \mathcal{H}(E, \theta; C)$ . Let H be the Hermitian matrix valued function determined by  $H_{i,j} = h(v_i, v_j)$ . We can describe H as

$$H = \left(\begin{array}{cc} a & \sqrt{-1}\widetilde{b} \\ -\sqrt{-1}\widetilde{b} & a \end{array}\right)$$

where a is an  $\mathbb{R}_{>0}$ -valued function, and  $\tilde{b}$  is an  $\mathbb{R}$ -valued function such that  $a^2 - \tilde{b}^2 = 1$ .

Lemma 2.20 The following holds:

$$|\partial_{E,h,z}\pi_1|_h^2 = \frac{2(1+2b^2)}{1+b^2} |\partial_z \tilde{b}|^2.$$

**Proof** We set

$$\beta = -\sqrt{-1}\tilde{b}\partial_z a + \sqrt{-1}a\partial_z\tilde{b} = \sqrt{-1}a^{-1}\partial_z\tilde{b}$$

We have

$$\overline{H}^{-1}\partial_{z}\overline{H} = \left(\begin{array}{cc} 0 & -\beta \\ \beta & 0 \end{array}\right).$$

Then, we obtain

$$\left[\partial_z + \overline{H}^{-1} \partial_z \overline{H}, \Pi_1\right] = \left(\begin{array}{cc} 0 & \beta \\ \beta & 0 \end{array}\right)$$

We obtain

$$\begin{aligned} \left|\partial_{E,h,z}\pi_{1}\right|_{h}^{2} &= \operatorname{tr}\left(\left(\begin{array}{cc}0&\beta\\\beta&0\end{array}\right)\left(\begin{array}{c}a&\sqrt{-1\widetilde{b}}\\-\sqrt{-1\widetilde{b}}&a\end{array}\right)\left(\begin{array}{c}0&\overline{\beta}\\\overline{\beta}&0\end{array}\right)\left(\begin{array}{c}a&-\sqrt{-1\widetilde{b}}\\\sqrt{-1\widetilde{b}}&a\end{array}\right)\right) \\ &= 2(1+2\widetilde{b}^{2})|\beta|^{2} = \frac{2(1+2\widetilde{b}^{2})}{1+\widetilde{b}^{2}}|\partial_{z}\widetilde{b}|^{2}. \end{aligned} (34)$$

We set  $W = \{z \in U(R) \,|\, \widetilde{b}(z) \neq 0\}.$ 

Lemma 2.21 On W, the following holds:

$$-\partial_z \partial_{\overline{z}} |\widetilde{b}| \le -4|\widetilde{b}|.$$

**Proof** We have

$$-\partial_z \partial_{\overline{z}} \widetilde{b}^2 = -2|\widetilde{b}|\partial_z \partial_{\overline{z}}|\widetilde{b}| - 2(\partial_z |\widetilde{b}|) \cdot (\partial_{\overline{z}} |\widetilde{b}|)$$

Because  $\tilde{b}$  is real valued, we obtain

$$\partial_z |\tilde{b}| = \partial_{\overline{z}} |\tilde{b}| \le |\partial_z \tilde{b}|.$$

We have

$$-2\frac{1+2\tilde{b}^2}{1+\tilde{b}^2}|\partial_z\tilde{b}|^2+2\partial_z|\tilde{b}|\partial_{\overline{z}}|\tilde{b}| \le 0.$$

Then, we obtain  $-2|\tilde{b}|\partial_z\partial_{\overline{z}}|\tilde{b}| \leq -8|\tilde{b}|^2$ , which implies the claim of the lemma.

**Proposition 2.22** For any  $0 < \gamma < 4$ , there exists  $C'(R_0, \gamma) > 0$  such that the following holds for any  $h \in \mathcal{H}(E, \theta; C)$  on  $U(R - R_0)$ :

$$|\tilde{b}(z)| \le C'(R_0, \gamma)e^{-\gamma(R-|z|)}.$$

It implies  $|a - 1| \le C'(R_0, \gamma) e^{-2\gamma(R - |z|)}$ .

**Proof** We use the notation in  $\S2.1.6$ .

Lemma 2.23 The following holds:

$$|\tilde{b}(0)| \le 2C_2(r_0)I_0(4(R-r_0/2))^{-1}$$

**Proof** We set  $J(z) = 2C_2(r_0)I_0(4z)I_0(4(R-r_0/2))^{-1}$ .

$$-\partial_z \partial_{\overline{z}} J(z) = -4J(z), \quad J(z)_{|z|=R-r_0/2} = 2C_2(r_0).$$

Let  $Z = \{z \in U(R - r_0/2) \mid |\widetilde{b}(z)| > J(z)\}$ . We deduce a contradiction by assuming  $Z \neq \emptyset$ . Clearly, Z is contained in W, and relatively compact in  $U(R - r_0/2)$ . We have  $|\widetilde{b}(z)| = J(z)$  on  $\partial Z$ , and

$$-\partial_z \partial_{\overline{z}} (|\widetilde{b}| - J) \le -4(|\widetilde{b}|^2 - J) < 0$$

on Z. Hence,  $|\tilde{b}| - J$  is subharmonic on Z. By the maximum principle, we obtain  $|\tilde{b}| - J \leq 0$ , which contradicts with the definition of Z. Hence, we obtain  $Z = \emptyset$ . In particular,  $|\tilde{b}(0)| \leq J(0)$ .

Corollary 2.24 For any 0 < u < 1, we have

$$|\tilde{b}(0)| \le 2C_2(r_0)C_0(u)e^{-4(R-r_0/2)u} \le 2C_2(r_0)C_0(u)e^{2r_0}e^{-4uR}$$

By applying Corollary 2.24 to the restriction to  $U(z_0, R - |z_0|)$ , we obtain

$$|\tilde{b}(z_0)| \le 2C_2(r_0)C_0(u)e^{-4(R-r_0/2)u} \le 2C_2(r_0)C_0(u)e^{2r_0}e^{-4u(R-|z_0|)}$$

It implies the claim of Proposition 2.22.

Proposition 2.22 implies the claim of Proposition 2.4 in the case (j, k) = (0, 0). It implies Proposition 2.3.

### 2.1.9 Proof of Proposition 2.4

We continue to use the notation in 2.1.8. We have

$$\partial_{\overline{z}} \left( \overline{H}^{-1} \partial_{z} \overline{H} \right) = \begin{pmatrix} 0 & -\sqrt{-1} \partial_{\overline{z}} (a^{-1} \partial_{z} \widetilde{b}) \\ \sqrt{-1} \partial_{\overline{z}} (a^{-1} \partial_{z} \widetilde{b}) & 0 \end{pmatrix}.$$

We have

$$F_{H}^{\dagger} = \overline{H}^{-1} F \overline{H} = \begin{pmatrix} 1 + \widetilde{b}^{2} & -2\sqrt{-1}a\widetilde{b} \\ -2\sqrt{-1}a\widetilde{b} & -1 - 2\widetilde{b}^{2} \end{pmatrix}.$$

We obtain

$$[F, F_H^{\dagger}] = \left(\begin{array}{cc} 0 & -4\sqrt{-1}a\widetilde{b} \\ 4\sqrt{-1}a\widetilde{b} & 0 \end{array}\right)$$

Because  $\partial_{\overline{z}}\left(\overline{H}^{-1}\partial_{\overline{z}}\overline{H}\right) - [F, F_{H}^{\dagger}] = 0$ , we obtain

$$\partial_{\overline{z}} \left( a^{-1} \partial_z \widetilde{b} \right) - 4a \widetilde{b} = 0. \tag{35}$$

By using  $a^2 - \tilde{b}^2 = 1$ , we obtain

$$\partial_{\overline{z}}\partial_{z}\widetilde{b} = \frac{1}{1+\widetilde{b}^{2}}\widetilde{b}|\partial_{z}\widetilde{b}|^{2} + 4\widetilde{b}.$$
(36)

For  $z_0 \in U(R_1)$ , let  $\chi_{z_0} : \mathbb{C} \to [0,1]$  be a  $C^{\infty}$ -function such that  $\chi_{z_0}(z) = 1$   $(|z - z_0| < r_0/2)$  and  $\chi_{z_0}(z) = 0$   $(|z - z_0| \ge 2r_0/3)$ . We also assume that  $\chi_{z_0}^{-1/2} d\chi_{z_0}$  induces a  $C^{\infty}$ -function. By (36), we obtain

$$0 \leq \int \chi_{z_0} \tilde{b} \partial_{\overline{z}} \partial_z \tilde{b} = -\int \partial_{\overline{z}} (\chi_{z_0}) \tilde{b} \partial_z \tilde{b} - \int \chi_{z_0} |\partial_z \tilde{b}|^2.$$

We obtain

$$\int \chi_{z_0} |\partial_z \widetilde{b}|^2 \le \left( \int |\chi_{z_0}^{-1/2} d\chi_{z_0}| \cdot |\widetilde{b}|^2 \right)^{1/2} \left( \int \chi_{z_0} |\partial_z \widetilde{b}|^2 \right)^{1/2}$$

Hence,

$$\int \chi_{z_0} |\partial_z \widetilde{b}|^2 \le \int |\chi_{z_0}^{-1/2} d\chi_{z_0}| \cdot |\widetilde{b}|^2.$$

For any  $0 < \gamma < 4$ , we obtain

$$\left(\int_{|z-z_0|< r_0/2} |\partial_z \widetilde{b}|^2\right)^{1/2} \le \pi^{1/2} (r_0/2) C'(R, R_1 + r_0, \gamma) e^{\gamma r_0} e^{-\gamma (R-|z_0|)}$$

By using (35), we obtain the estimate for the sup norms of  $\partial_z \tilde{b}$  on  $\{|z - z_0| < r_0/3\}$ . By a standard bootstrapping argument, we obtain the estimate (29). Because  $a^2 = 1 + \tilde{b}^2$ , it implies the estimate (28).

# 2.2 An estimate for derivatives

Fix  $R_0 > 0$  and  $C_0 > 0$ . Let  $(E, \theta)$  be a Higgs bundle of rank r on U(R) for  $R > 2R_0$ . Let f be the endomorphism determined by  $\theta = f dz$ . Assume that  $|\operatorname{tr}(f^j)| < C_0$  for  $j = 1, \ldots, r$ . Let  $h_0$  be a harmonic metric. Let  $g_0$  be the Euclidean metric  $dz d\overline{z}$ . Let  $\nabla$  denote the Chern connection of  $(E, h_0)$ . Let  $\mathfrak{R}$  denote the endomorphism of E such that  $\mathfrak{R} dz d\overline{z}$  is the curvature of  $\nabla$ .

**Lemma 2.25** There exist C(j,k) > 0 depending only on  $R_0$ ,  $C_0$ , r and (j,k) such that the following holds on  $U(R-R_0)$  for any harmonic metric h of  $(E, \theta)$ :

$$|\nabla_z^j f|_{h_0} + |\nabla_{\overline{z}}^k f_{h_0}^\dagger|_{h_0} + |\nabla_z^j \nabla_{\overline{z}}^k \mathfrak{R}|_{h_0} \le C(j,k).$$

**Proof** For  $z_0 \in U(R - R_0)$ , we have  $U(z_0, R_0) \subset U(R)$ . By applying [19, Proposition 4.1] to  $(E, \theta)|_{U(z_0, R_0)}$ , we obtain the estimate on  $U(z_0, R_0/2)$ . Hence, we obtain the desired estimate on  $U(R - R_0)$ .

For positive constants  $C_1, \epsilon_0, \epsilon_1$ , let  $\mathcal{H}(E, \theta; h_0, C_1, \epsilon_0, \epsilon_1)$  denote the set of harmonic metrics h of  $(E, \theta)$  such that the following holds on U(R).

- $|s(h_0,h)|_{h_0} + |s(h_0,h)^{-1}|_{h_0} \le C_1.$
- $\int \left|\overline{\partial}s(h_0,h)\right|_{h_0}^2 + \int \left|\left[\theta,s(h_0,h)\right]\right|_{h_0}^2 \le \epsilon_1^2.$
- $\left|\overline{\partial}(s(h_0,h)^{-1}\partial_{h_0}s(h_0,h))\right|_{h_0,g_0} \leq \epsilon_0.$

We set  $\epsilon_2 = \max{\{\epsilon_0, \epsilon_1\}}.$ 

**Lemma 2.26** There exists  $C_2$  depending only on  $R_0, C_0, C_1, r, \epsilon_0, \epsilon_1$ , such that the following holds on  $U(R - R_0)$  for any  $h \in \mathcal{H}(E, \theta; h_0, C_1, \epsilon_0, \epsilon_1)$ :

$$\left| \nabla s(h_0, h) \right|_{h_0, g_0} + \left| [\theta, s(h_0, h)] \right|_{h_0, g_0} \le C_2 \cdot \epsilon_2.$$

**Proof** To simplify the description, we denote  $s(h_0, h)$  by s. We obtain the estimate for  $\sup_{U(R-R_0)} |\overline{\partial}s|_{h_0,g_0}$  by using the Sobolev embedding theorem and Uhlenbeck's theorem on the existence of Coulomb gauge. (See the proof of [19, Proposition 4.1], for example.) Because s is self-adjoint with respect to  $h_0$ , we obtain the estimate for  $\sup_{U(R-R_0)} |\nabla s|_{h_0,g_0}$ . Because  $\overline{\partial}[\theta, s] = -[\theta, \overline{\partial}s]$ , we also obtain the estimate for  $\sup_{U(R-R_0)} |[\theta, s]|_{h_0,g_0}$ .

**Lemma 2.27** For any  $(j,k) \in \mathbb{Z}_{\geq 0}^2 \setminus \{(0,0)\}$ , there exist positive constants  $C_3(j,k)$  depending only on  $R_0$ ,  $C_0$ ,  $C_1$ , r,  $\epsilon_0$  and  $\epsilon_1, (j,k)$ , such that the following holds on  $U(R - R_0)$ :

$$\left\|\nabla_z^j \nabla_{\overline{z}}^k s(h_0, h)\right\|_{h_0} \le C_3(j, k) \cdot \epsilon_2$$

**Proof** We have

$$\overline{\partial} \left( s(h_0, h)^{-1} \partial_{E, h_0} s(h_0, h) \right) + \left[ \theta, s^{-1} [\theta_{h_0}^{\dagger}, s] \right] = 0$$

Then, we obtain the desired estimate by using a standard bootstrapping argument, the Sobolev embedding theorem and Uhlenbeck's theorem on the existence of Coulomb gauge.

**Corollary 2.28** For any  $(j,k) \in \mathbb{Z}_{\geq 0}^2$ , there exist positive constants  $C_4(j,k)$  depending only on  $R_0$ ,  $C_0$ ,  $C_1$ , r,  $\epsilon_0$  and  $\epsilon_1, (j,k)$ , such that the following holds on  $U(R - R_0)$ :

$$\left|\nabla_{z}^{j}\nabla_{\overline{z}}^{k}[\theta, s(h_{0}, h)]\right|_{h_{0}} + \left|\nabla_{z}^{j}\nabla_{\overline{z}}^{k}[\theta_{h_{0}}^{\dagger}, s(h_{0}, h)]\right|_{h_{0}} \le C_{4}(j, k) \cdot \epsilon_{2}$$

# **3** Global estimates

# 3.1 Flat metrics induced by quadratic differentials

# 3.1.1 Holomorphic local coordinates

Let X be a compact Riemann surface. Let  $\phi$  be a non-zero quadratic differential on X such that each zero of  $\phi$  is simple. Let  $D_{\phi}$  denote the set of zeroes of  $\phi$ . Let  $g_{\phi}$  be the Kähler metric of  $X \setminus D_{\phi}$  obtained as  $g_{\phi} = |\phi|$ . Let  $d_{\phi}$ denote the distance of X induced by  $g_{\phi}$ . For any r > 0 and  $P \in X$ , we set  $X_P(r) = \{Q \in X | d_{\phi}(P,Q) < r\}$ .

For each  $P \in X \setminus D_{\phi}$ , there exists a coordinate neighbourhood  $(X_P, z_P)$  around P such that  $\phi_{|X_P|} = dz_P dz_P$ and  $z_P(P) = 0$ . We obtain  $g_{\phi|X_P} = dz_P d\overline{z}_P$ . Such a coordinate  $z_P$  is well defined up to the multiplication of  $\pm 1$ . There exists  $r_0 > 0$  such that the coordinate  $z_P$  induces the following holomorphic isomorphism for any  $r < r_0$ :

$$(X_P(r),\phi) \simeq (U(r),(dz_P)^2).$$

For each  $P \in D_{\phi}$ , there exists a coordinate neighbourhood  $(X_P, z_P)$  such that  $\phi = \left(\frac{3}{2}\right)^2 z_P dz_P dz_P$ . We have  $g_{\phi|X_P} = \left(\frac{3}{2}\right)^2 |z_P| dz_P d\overline{z}_P$ . Such a coordinate  $z_P$  is well defined up to the multiplication of cubic roots of 1. We consider the quadratic differential  $\phi_0 = \left(\frac{3}{2}\right)^2 z (dz)^2$  on  $\mathbb{C}$ . It induces the distance  $d_{\phi_0}$  on  $\mathbb{C}$ . We set

$$\mathcal{U}_P(r) = \left\{ z \in \mathbb{C} \mid d_{\phi_0}(0, z) < r \right\} = \left\{ z \in \mathbb{C} \mid |z| < r^{2/3} \right\}.$$

There exists  $r_0 > 0$  such that the coordinate  $z_P$  induces the following holomorphic isomorphism for any  $r < r_0$ :

$$(X_P(r), \phi) \simeq (\mathcal{U}_P(r), \phi_0).$$

#### 3.1.2 Threshold

According to [3, §3.2], a saddle connection of  $\phi$  is a geodesic segment on  $(X, d_{\phi})$  such that (i) the starting point and the ending point are contained in  $D_{\phi}$ , (ii) any other point is contained in  $X \setminus D_{\phi}$ . Note that the starting point and the ending point are not necessarily distinct. Let  $M(\phi)$  denote the minimum length of the saddle connections of  $\phi$ , which is called the threshold. The following lemma is obvious.

**Lemma 3.1** For  $P \in D_{\phi}$ , we have  $X_P(M(\phi)) \cap D_{\phi} = \{P\}$ .

We shall prove the following proposition in §3.1.4.

**Proposition 3.2** Let  $P \in D_{\phi}$ .

• A local holomorphic coordinate  $z_P$  around P as in §3.1.1 is analytically continued to a holomorphic coordinate on  $X_P(M(\phi)/2)$ , and it induces a holomorphic isomorphism

$$(X_P(\kappa), \phi) \simeq (\mathcal{U}_P(\kappa), \phi_0)$$

for any  $0 < \kappa \leq M(\phi)/2$ . In particular,  $\phi_{|X_P(\kappa)|} = (\frac{3}{2})^2 z_P (dz_P)^2$ .

• The inverse function  $z_P^{-1}: \mathcal{U}_P(M(\phi)/2) \simeq X_P(M(\phi)/2)$  is analytically continued to a locally bi-holomorphic function

$$\psi_P: \mathcal{U}_P(M(\phi)) \longrightarrow X.$$

We have  $\psi_P^*(\phi) = \phi_0$ ,  $\psi_P^{-1}(D_\theta) = \{0\}$ , and  $\psi_P(\mathcal{U}_P(\kappa)) \subset X_P(\kappa)$  for any  $0 < \kappa \leq M(\phi)$ .

The following lemma is easier which is also proved in §3.1.4.

**Lemma 3.3** Let  $P \in X \setminus D_{\phi}$ . Let  $z_P$  be a holomorphic local coordinate around P as in §3.1.1. Then,  $z_P^{-1}$  is analytically continued to a locally bi-holomorphic function

$$\psi_P: U(d_\phi(P, D_\phi)) \longrightarrow X.$$

We have  $\psi_P^*(\phi) = (dz)^2$ ,  $\psi_P^{-1}(D_{\phi}) = \emptyset$ , and  $\psi_P(\mathcal{U}_P(\kappa)) \subset X_P(\kappa)$  for any  $0 < \kappa \le d_{\phi}(P, D_{\phi})$ .

#### Metrics induced by holomorphic 1-forms 3.1.3

Let Y be a simply connected Riemann surface isomorphic to a disc. Let a be a holomorphic 1-form on Y. We set  $Z_a = \{ Q \in Y \, | \, a(Q) = 0 \}.$ 

We obtain the Kähler metric  $|a|^2$  on  $Y \setminus Z_a$  whose curvature is flat. As explained in [23], it induces the distance  $d_a$  on Y. For a curve  $\gamma$ , the length of  $\gamma$  is denoted by  $L_a(\gamma)$ . In this subsection, any geodesic is assumed to be parameterized by the arc length. We assume the following.

Assumption 3.4  $(Y, d_a)$  is a complete metric space.

Under the assumption, the following holds. See [23, Theorem 14.2.1, Theorem 16.1, Corollary 18.2].

**Proposition 3.5** For any two points  $P_1, P_2 \in Y$ , there is a unique geodesic  $\gamma_{P_1,P_2}$  starting from  $P_1$  and ending at  $P_2$ . We have  $L_a(\gamma_{P_1,P_2}) = d_a(P_1,P_2)$ . If the length of a curve connecting  $P_1$  and  $P_2$  is  $d_a(P_1,P_2)$ , the curve equals to the geodesic  $\gamma_{P_1,P_2}$  after a re-parametrization of the parameter.

We fix a base point  $P \in Y$ . We set  $M_{a,P} := \inf_{Q \in Z_a \setminus \{P\}} d_a(P,Q)$ . Let  $Z_{a,P}$  denote the set of  $Q \in Z_a \setminus \{P\}$ such that  $\gamma_{P,Q}(s) \notin Z_a$  for any  $0 < s < d_a(P,Q)$ . It is easy to see  $M_{a,P} = \inf_{Q \in Z_{a,P}} d_a(P,Q)$ .

Let  $n \in \mathbb{Z}_{>0}$  denote the order of zero of a at P. Let  $f_{a,P}$  be the holomorphic function on Y such that  $df_{a,P} = a$  and  $f_{a,P}(P) = 0$ . There exists a holomorphic function  $f_{a,P}^{\frac{1}{n+1}}$  defined on a neighbourhood  $\mathcal{U}$  of P such that  $(f_{a,P}^{\frac{1}{n+1}})^{n+1} = f_{a,P}$  and that  $f_{a,P}^{\frac{1}{n+1}}$  has simple zero at P. For any r > 0, let  $Y_P(r) := \{Q \in Y | d_a(P,Q) < r\}$  and  $Y_P(r)^* = Y_P(r) \setminus \{P\}$ . We also set  $U(r) := \{w \in V | d_a(P,Q) < r\}$ .

 $\mathbb{C} \mid |w| < r \}$  and  $U(r)^* = U(r) \setminus \{0\}.$ 

**Proposition 3.6** Let  $r \leq M_{a,P}$ .

- $f_{a,P}$  induces a proper map  $Y_P(r) \to U(r)$ , and the induced map  $Y_P(r)^* \to U(r)^*$  is a covering map of degree n + 1.
- $f_{a,P}^{\frac{1}{n+1}}$  is analytically continued to a holomorphic function on  $Y_P(r)$ , and it induces a bi-holomorphic map  $Y_P(r) \simeq U(r^{\frac{1}{n+1}})$ . We have  $(f_a^{\frac{1}{n+1}})^{n+1} = f_{a,P}$  on  $Y_P(r)$ .

**Proof** We shall give some lemmas.

**Lemma 3.7** For any  $Q \in Y_P(M_{a,P})^*$ ,  $\gamma_{P,Q}(s)$   $(0 < s \leq d_a(P,Q))$  are not contained in  $Z_a$ . In particular,  $Y_P(M_{a,P})^* \cap Z_a = \emptyset.$ 

**Proof** Let S denote the set of  $0 < s \leq d_a(P,Q)$  such that  $\gamma_{P,Q}(s) \in Z_a$ . Assume that S is not empty. Let  $s_0 = \min S$ . Then,  $\gamma_{P,Q}(s_0) \in Z_{a,P}$ , and  $d_a(P, \gamma_{P,Q}(s_0)) \leq d_a(P,Q) < M_{a,P}$ , which contradicts the definition of  $M_{a,P}$ .

For  $Q \in Y_P(M_{a,P})^*$ , by Lemma 3.7, we obtain

$$f_{a,P} \circ \gamma_{P,Q}(s) = s \cdot |f_{a,P}(Q)|^{-1} f_{a,P}(Q),$$

and  $d_a(P,Q) = |f_{a,P}(Q)|$ . In particular, we obtain  $f_{a,P}(Y_P(r)) \subset U(r)$  for any  $0 < r < M_{a,P}$ .

Let  $w \in \mathbb{C} \setminus \{0\}$ . There exist (n+1)-distinct points  $w_{n+1}^{(i)} \in \mathbb{C}$   $(i=1,\ldots,n+1)$  such that  $(w_{n+1}^{(i)})^{n+1} = w$ . There exist  $\epsilon > 0$  and  $C^{\infty}$ -maps  $\eta_{w,\epsilon}^{(i)}: [0,\epsilon] \to \mathcal{U} \subset Y$   $(i=1,\ldots,n+1)$  such that  $\eta_{w,\epsilon}^{(i)}(0) = P$  and  $f_{a,P}^{\frac{1}{n+1}} \circ \eta_{w,\epsilon}^{(i)}(s) = P$  $s^{\frac{1}{n+1}}w_{n+1}^{(i)}$  for  $0 \le s \le \epsilon$ .

Lemma 3.8 Suppose  $|w| < M_{a,P}$ .

- There exist  $C^{\infty}$ -maps  $\eta_w^{(i)}: [0,1] \to Y$  such that (i)  $\eta_w^{(i)}(s) = \eta_{w,\epsilon}^{(i)}(s)$   $(0 \le s \le \epsilon)$ , (ii)  $f_{a,P} \circ \eta_w^{(i)}(s) = sw$  $(0 \le s \le 1).$
- For  $i \neq j$ , we have  $\eta_w^{(i)}(s) \neq \eta_w^{(j)}(s)$  for any 0 < s < 1.

**Proof** Fix  $i \in \{1, ..., n+1\}$ . Let I be the set of  $\epsilon \leq \nu \leq 1$  such that there exists  $\eta_{w,\nu}^{(i)} : [0,\nu] \to Y$  such that (i)  $\eta_{w,\nu}^{(i)}(s) = \eta_{w,\epsilon}^{(i)}(s)$   $(0 \leq s \leq \epsilon)$ , (ii)  $f_{a,P} \circ \eta_{w,\nu}^{(i)}(s) = sw$   $(0 \leq s \leq \nu)$ . Note that  $\epsilon \in I$ , and hence  $I \neq \emptyset$ . We set  $\nu_0 = \sup I$ . Suppose  $\nu_0 < 1$ . For any  $\epsilon \leq \nu < \nu_0$ , we have  $\eta_{w,\nu}^{(i)} : [0,\nu] \to Y$  satisfying the above conditions. Note that

$$d_a(P, \eta_{w,\nu}^{(i)}(s)) \le \left|\eta_{w,\nu}^{(i)}(s)\right| = s|w| < M_{a,P}$$

Because  $\eta_{w,\nu}^{(i)}(s) \notin Z_a$  for any  $\epsilon \leq \nu < \nu_0$  and  $0 < s \leq \nu$ , we have  $\eta_{w,\nu_1}^{(i)}(s) = \eta_{w,\nu_2}^{(i)}(s)$  for any  $\epsilon \leq \nu_1 \leq \nu_2$  and  $0 \leq s \leq \nu_1$ . Let us consider the sequence  $\eta_{w,\nu}^{(i)}(\nu)$  ( $\nu \in I$ ). We note that  $d_a(\eta_{w,\nu_1}^{(i)}(\nu_1), \eta_{w,\nu_2}^{(i)}(\nu_2)) = |\nu_1 - \nu_2| \cdot |w|$ . Because  $d_a$  is complete, there exists the limit  $z_{\infty} = \lim_{\nu \to \nu_0} \eta_{w,\nu}^{(i)}(\nu) \in Y$ . By the continuity of  $f_a$ , we have  $f_a(z_{\infty}) = \nu_0 w$ . Because  $f_a$  is bi-holomorphic around  $z_{\infty}$  and  $\nu_0 w$ , we can construct  $\eta_{w,\nu_0+\delta}^{(i)}$  satisfying the above conditions for some  $\delta > 0$ . It contradicts the definition of  $\nu_0$ . Thus, we obtain the first claim.

Fix a pair  $1 \le i, j \le n + 1$  with  $i \ne j$ . Let J be the set of  $0 < s \le 1$  such that  $\eta_w^{(i)}(s) = \eta_w^{(j)}(s)$ . Because the condition is closed, J is a closed subset of ]0, 1]. Because  $f_a$  is locally bi-holomorphic, J is an open subset of ]0, 1]. Because  $J \subset \{\epsilon \le s \le 1\}$ , we obtain  $J \ne ]0, 1]$ , and hence  $J = \emptyset$ . Thus, we obtain the second claim.

**Lemma 3.9** For any  $w \in U(r)^*$ , we have

$$\left\{Q \in Y_P(M_{a,P}) \setminus \{P\} \,\middle|\, f_{a,P}(Q) = w\right\} = \left\{\eta_w^{(i)}(1) \,\middle|\, i = 1, \dots, n+1\right\}.$$

**Proof** The right hand side is contained in the left hand side. Let  $Q \in Y_P(M_{a,P})$  such that  $f_{a,P}(Q) = P$ . Because  $f_{a,P} \circ \gamma_{P,Q}(|w|s) = s \cdot w$  for  $0 \le s \le 1$ ,  $\gamma_{P,Q}(|w| \cdot s)$  equals one of  $\eta_w^{(i)}$ . Hence, the left hand side is contained in the right hand side.

Let  $0 < r \le M_{a,P}$ . Let us consider the induced map  $f_{a|Y_P(r)^*} : Y_P(r)^* \to U(r)^*$ . It is locally bi-holomorphic. By Lemma 3.9, it is a covering map. Then,  $f_a^{\frac{1}{n+1}}$  is analytically continued on  $Y_P(r)$ . The other claims of Proposition 3.6 also follow.

#### 3.1.4 Proof of Proposition 3.2 and Lemma 3.3

Let  $\Sigma \subset T^*X$  be the spectral curve of  $\phi$ , which is also a compact Riemann surface. Let  $\pi : \Sigma \to X$  denote the projection. There exists a holomorphic 1-form a on  $\Sigma$  such that  $\pi^*(\phi) = a^2$ .

Let  $\varphi : \tilde{\Sigma} \to \Sigma$  be a universal covering. We obtain  $\tilde{a} = \varphi^*(a)$ . The Riemann surface  $\tilde{\Sigma}$  is bi-holomorphic to a disc. According to [23, Lemma 18.2], the metric space  $(\tilde{\Sigma}, d_{\tilde{a}})$  is complete.

Let  $P \in D_{\phi}$ . There exists a unique point  $\tilde{P}_1 \in \Sigma$  such that  $\pi(\tilde{P}_1) = P$ . Let  $\tilde{P}_2 \in \tilde{\Sigma}$  be a point such that  $\varphi(\tilde{P}_2) = \tilde{P}_1$ . By definitions, we obtain

$$M(\phi) \le M_{\widetilde{a},\widetilde{P}_2}.$$

We obtain  $f_{\tilde{a},\tilde{P}_2}: \tilde{\Sigma} \to \mathbb{C}$  such that  $df_{\tilde{a},\tilde{P}_2} = \tilde{a}$  and  $f_{\tilde{a},\tilde{P}_2}(\tilde{P}_2) = 0$ . As explained in Proposition 3.6, there exists a holomorphic function  $f_{\tilde{a},\tilde{P}_2}^{\frac{1}{3}}$  on  $\tilde{\Sigma}_{\tilde{P}_2}(M_{\tilde{a},\tilde{P}_2})$  such that  $(f_{\tilde{a},\tilde{P}_2}^{\frac{1}{3}})^3 = f_{\tilde{a},\tilde{P}_2}$ , and  $f_{\tilde{a},\tilde{P}_2}^{\frac{1}{3}}$  induces a bi-holomorphic isomorphism

$$\widetilde{\Sigma}_{\widetilde{P}_2}(r) \simeq \{ |\zeta| < r^{1/3} \}$$

for any  $r < M_{\tilde{a},\tilde{P}_2}$ . We have  $\tilde{a} = d\zeta^3$ .

Let  $d_a$  be the distance on  $\Sigma$  induced by  $|a|^2$ . For r > 0, let  $\Sigma_{\widetilde{P}_1}(r) = \{Q \in \Sigma \mid d_a(\widetilde{P}_1, Q) < r\}$  and  $\Sigma_{\widetilde{P}_1}(r)^* = \Sigma_{\widetilde{P}_1}(r) \setminus \{\widetilde{P}_1\}.$ 

Lemma 3.10 Let  $r \leq M_{\tilde{a},\tilde{P}_2}/2$ .

- $\varphi$  induces an isomorphism  $\widetilde{\Sigma}_{\widetilde{P}_2}(r) \simeq \Sigma_{\widetilde{P}_1}(r)$ .
- $\pi$  induces a ramified covering map  $\Sigma_{\widetilde{P}_1}(r) \to X_P(r)$  of degree 2. It induces a covering map  $\Sigma_{\widetilde{P}_1}(r)^* \to X_P(r)^*$ .

**Proof** We have  $\varphi(\widetilde{\Sigma}_{\widetilde{P}_2}(r)) \subset \Sigma_{\widetilde{P}_1}(r)$  for any r > 0. Suppose  $r \leq M_{\widetilde{a},\widetilde{P}_2}/2$ . Let  $Q_1, Q_2 \in \widetilde{\Sigma}_{\widetilde{P}_2}(r)$  such that  $\varphi(Q_1) = \varphi(Q_2)$  and  $Q_1 \neq Q_2$ . Then, there exists  $\widetilde{P}'_2 \in \varphi^{-1}(\widetilde{P}_1) \setminus \{\widetilde{P}_2\}$  such that  $d_{\widetilde{a}}(\widetilde{P}'_2, Q_1) < r$ . We obtain  $d_{\widetilde{a}}(\widetilde{P}_2, \widetilde{P}'_2) < 2r \leq M_{\widetilde{a},\widetilde{P}_2}$ , which contradicts the condition of  $M_{\widetilde{a},\widetilde{P}_2}$ . Hence, the restriction of  $\varphi$  induces a bi-holomorphic isomorphism between  $\widetilde{\Sigma}_{\widetilde{P}_2}(r)$  and its image  $\varphi(\widetilde{\Sigma}_{\widetilde{P}_2}(r))$ .

Let  $Q \in \Sigma_{\widetilde{P}_1}(r)$ . There exists a curve  $\gamma_0^Q$  starting from  $\widetilde{P}_1$  and ending at Q whose length is strictly smaller than r. According to [23, Theorem 18.2.2], there exists a unique geodesic  $\gamma^Q$  from  $\widetilde{P}_1$  to Q such that  $\gamma^Q$  is homotopic to  $\gamma_0^Q$ . The length L of  $\gamma^Q$  is strictly less than r. Let  $\widetilde{\gamma}^Q$  be the lift of  $\gamma^Q$  to  $\widetilde{\Sigma}$  starting from  $\widetilde{P}_2$ . Then,  $\widetilde{\gamma}^Q(L)$  is contained in  $\widetilde{\Sigma}_{\widetilde{P}_2}(r)$ . We obtain  $\Sigma_{\widetilde{P}_1}(r) = \varphi(\widetilde{\Sigma}_{\widetilde{P}_2}(r))$ . Thus, we obtain the first claim. We have  $\pi(\Sigma_{\widetilde{P}_1}(r)) \subset X_P(r)$  for any r > 0. Suppose that  $r < M_{\widetilde{a},\widetilde{P}_2}/2$ . The induced map  $\Sigma_{\widetilde{P}_1}(r)^* \to X_P(r)^*$ 

We have  $\pi(\Sigma_{\tilde{P}_1}(r)) \subset X_P(r)$  for any r > 0. Suppose that  $r < M_{\tilde{a},\tilde{P}_2}/2$ . The induced map  $\Sigma_{\tilde{P}_1}(r)^* \to X_P(r)^*$ is locally bi-holomorphic. Let  $Q \in X_P(r)$ . There exists a curve  $\gamma^Q$  starting from P and ending at Q whose length is strictly smaller than r. According to [23, Theorem 18.2.2], there exists a unique geodesic  $\gamma^Q$  from P to Q such that  $\gamma^Q$  is homotopic to  $\gamma_0^Q$ . The length L of  $\gamma^Q$  is strictly less than r. Because  $L < M_{\tilde{a},\tilde{P}_2}/2, \gamma^Q(s)$  is not contained in  $D_{\phi}$  for any  $0 < s \leq L$ . Hence, there exists exactly two lifts  $\gamma^{Q(i)}$  (i = 1, 2) of  $\gamma^Q$  to  $\Sigma_{\tilde{P}_1}(r)$ . Hence,  $\Sigma_{\tilde{P}_1}(r)^* \to X_P(r)^*$  is a covering map of degree 2. Thus, we obtain the second claim.

Let  $\sigma$  be the involution of  $\Sigma$  induced by the multiplication of -1 on  $T^*X$ . It induces an involution  $\sigma$  on  $\Sigma_{\widetilde{P}_1}(r)$  for any r. By Lemma 3.10, we obtain the involution  $\sigma$  on  $\widetilde{\Sigma}_{\widetilde{P}_2}(r)$  for  $r < M_{\widetilde{a},\widetilde{P}_2}/2$ .

**Lemma 3.11** The induced involution  $\sigma$  on  $\widetilde{\Sigma}_{\widetilde{P}_2}(M_{\widetilde{a},\widetilde{P}_2})$  is described as  $\sigma(\zeta) = -\zeta$ .

**Proof** Because  $\tilde{a} = d(\zeta^3)$ ,  $\sigma^* \tilde{a} = -\tilde{a}$ ,  $\sigma(\tilde{P}_2) = \tilde{P}_2$  and  $\sigma^2 = id$ , we obtain  $\sigma^*(\zeta) = -\zeta$ .

There exists a bi-holomorphic map

$$\Phi_1: U\big((M_{\widetilde{a},\widetilde{P}_2}/2)^{2/3}\big) \longrightarrow X_P(M_{\widetilde{a},\widetilde{P}_2}/2)$$

such that  $\pi \circ \varphi = \Phi_1 \circ f_{\tilde{a},\tilde{P}_2}^{\frac{1}{3}}$  on  $\tilde{\Sigma}_{\tilde{P}_2}(M_{\tilde{a},\tilde{P}_2}/2)$ . For each  $0 < r < M_{\tilde{a},\tilde{P}_2}/2$ ,  $\Phi_1$  induces an isomorphism  $U(r^{2/3}) \simeq X_P(r)$ . Because  $M(\phi) \leq M_{\tilde{a},\tilde{P}_2}$ , this implies the first claim of Proposition 3.2. We obtain the second claim of Proposition 3.2 from the following lemma.

**Lemma 3.12**  $\Phi_1$  is analytically continued to a locally bi-holomorphic map

$$\Phi_2: U\big(M_{\widetilde{a},\widetilde{P}_2}^{2/3}\big) \longrightarrow X_P(M_{\widetilde{a},\widetilde{P}_2})$$

such that  $\pi \circ \varphi = \Phi_2 \circ f_{\widetilde{a}, \widetilde{P}_2}^{\frac{1}{3}}$  on  $\widetilde{\Sigma}_{\widetilde{P}_2}(M_{\widetilde{a}, \widetilde{P}_2})$ .

**Proof** For  $\theta_1 < \theta_2$  such that  $\theta_2 - \theta_1 < 2\pi$ , we consider the following regions:

$$S_{0}(\theta_{1},\theta_{2}) = \left\{ \xi \in \mathbb{C} \mid (M_{\tilde{a},\tilde{P}_{2}}/3)^{2/3} < |\xi| < (M_{\tilde{a},\tilde{P}_{2}}/2)^{2/3}, \ \theta_{1} < \arg(\xi) < \theta_{2} \right\},$$
$$S_{1}(\theta_{1},\theta_{2}) = \left\{ \xi \in \mathbb{C} \mid (M_{\tilde{a},\tilde{P}_{2}}/3)^{2/3} < |\xi| < M_{\tilde{a},\tilde{P}_{2}}^{2/3}, \ \theta_{1} < \arg(\xi) < \theta_{2} \right\}.$$

Let  $\rho : \mathbb{C} \to \mathbb{C}$  be the map defined by  $\rho(\zeta) = \zeta^2$ . For i = 0, 1, we have the decomposition into the connected components

$$\rho^{-1}(S_i(\theta_1, \theta_2)) = \rho^{-1}(S_i(\theta_1, \theta_2))_1 \sqcup \rho^{-1}(S_i(\theta_1, \theta_2))_2$$

We obtain

$$(\rho^{-1})_j : S_1(\theta_1, \theta_2) \simeq \rho^{-1}(S_1(\theta_1, \theta_2))_j$$

obtained as the inverse of  $\rho$ . We have the equalities

$$\pi \circ \varphi \circ (f_{\tilde{a}, \tilde{P}_2}^{\frac{1}{3}})^{-1} \circ (\rho^{-1})_1 = \pi \circ \varphi \circ (f_{\tilde{a}, \tilde{P}_2}^{\frac{1}{3}})^{-1} \circ (\rho^{-1})_2$$

on  $S_1(\theta_1, \theta_2)$ , because their restriction to  $S_0(\theta_1, \theta_2)$  are equal. Then, we obtain the claim of Lemma 3.12, which implies the second claim of Proposition 3.2.

Let  $P \in X \setminus D_{\phi}$ . Let  $\widetilde{P} \in (\pi \circ \varphi)^{-1}(P)$ . By definitions, we have

$$M_{\widetilde{a},\widetilde{P}} = d_{\phi}(P, D_{\phi})$$

We obtain the locally bi-holomorphic map  $U(M_{\tilde{a},\tilde{P}}) \to X$  as the composition of

$$U(M_{\tilde{a},\tilde{P}}) \xrightarrow{(f_{\tilde{a},\tilde{P}})^{-1}} \widetilde{\Sigma}_{\tilde{P}}(M_{\tilde{a},\tilde{P}}) \xrightarrow{\pi \circ \varphi} X.$$

This gives a desired analytic continuation of  $z_P^{-1}$ . Thus, we obtain Lemma 3.3.

#### **3.2** Higgs bundles of rank 2 with smooth spectral curve

Let X be a compact Riemann surface. Let  $(E, \theta)$  be a Higgs bundle of degree 0 and rank 2 on X. We assume that  $\det(E) = \mathcal{O}_X$  and  $\operatorname{tr} \theta = 0$ . We assume that the spectral curve  $\Sigma_{\theta}$  is smooth, reduced and irreducible. Let  $D_{\theta} \subset X$  denote the set of the critical values of the projection  $\pi : \Sigma_{\theta} \to X$ . At each point of  $D_{\theta}$ ,  $\phi := -\det(\theta)$  has a simple zero. For any  $W \subset X$ , we set  $\Sigma_{\theta|W} = \Sigma_{\theta} \times_X W$ .

We obtain the flat Kähler metric  $g_{\phi} = |\phi|$  of  $X \setminus D_{\theta}$ . Let  $d_{\phi}$  denote the distance of X induced by  $g_{\phi}$ . For any  $P \in X$  and r > 0, we set  $X_P(r) = \{Q \in X | d_{\phi}(P,Q) < r\}$ . We set

$$\kappa_0 = M(\phi)/2.$$

#### 3.2.1 Decomposition into the diagonal part and the off-diagonal part

Let  $P \in X \setminus D_{\theta}$ . There exists a holomorphic coordinate neighbourhood  $(X_P, z_P)$  such that  $\phi = (dz_P)^2$  and  $z_P(P) = 0$ . We set  $E_P = E_{|X_P|}$ . Let  $f_P$  be the endomorphism of  $E_P$  determined by  $\theta_{|X_P|} = f_P dz_P$ .

We have the decomposition

$$(E,\theta)_{|X_P} = (E_{P,1}, dz_P) \oplus (E_{P,2}, -dz_P)$$

We set

$$\operatorname{End}(E)_P^{\circ} = \bigoplus \operatorname{End}(E_{P,i}), \qquad \operatorname{End}(E)_P^{\perp} = \operatorname{Hom}(E_{P,1}, E_{P,2}) \oplus \operatorname{Hom}(E_{P,2}, E_{P,1}).$$

The subbundles  $\operatorname{End}(E)_P^{\circ}$  and  $\operatorname{End}(E^{\perp})_P$  of  $\operatorname{End}(E)_{|X_P}$  are well defined. By varying  $P \in X \setminus D_{\theta}$ , we obtain the subbundles  $\operatorname{End}(E)^{\circ}$  and  $\operatorname{End}(E)^{\perp}$  of  $\operatorname{End}(E)_{|X \setminus D_{\theta}}$ , and the decomposition

$$\operatorname{End}(E)_{|X \setminus D_{\theta}} = \operatorname{End}(E)^{\circ} \oplus \operatorname{End}(E)^{\perp}.$$
(37)

### 3.3 Approximation of large solutions of Hitchin equation

#### 3.3.1 Limiting configuration

Let us recall the notion of the limiting configuration in [13]. There exists a line bundle L on  $\Sigma_{\theta}$  with an isomorphism  $\pi_*\Sigma \simeq (E, \theta)$ , where the Higgs field of  $\pi_*L$  is induced by the tautological 1-form of  $T^*X$ . There exists a singular flat Hermitian metric  $h_L$  of L with the following property.

• Let  $Q \in \Sigma_{\theta}$  be any point of  $\pi^{-1}(D_{\theta})$ . Then, there exists a holomorphic local coordinate  $\zeta_Q$  of  $\Sigma_{\theta}$  and a frame  $v_Q$  of L around Q such that  $h_L(v_Q, v_Q) = |\zeta_Q|$ .

We obtain the Hermitian metric  $h_{\infty} = \pi_* h_L$  of  $E_{|X \setminus D_{\theta}}$ . Because  $\det(h_{\infty})$  induces a  $C^{\infty}$  Hermitian metric of  $\det(E)$ , we may adjust  $h_{\infty}$  so that  $\det(h_{\infty}) = 1$ .

Let  $\nabla_{\infty}$  denote the flat unitary connection of  $(E_{|X \setminus D_{\theta}}, h_{\infty})$  obtained as the Chern connection of  $h_{\infty}$ . We consider the flat connection of  $T^*(X \setminus D_{\theta})$  obtained as the Levi-Civita connection of  $g_{\phi}$ . For any  $m \in \mathbb{Z}_{\geq 0}$ , the induced connections on  $\operatorname{End}(E) \otimes (T^*(X \setminus D_{\theta}))^{\otimes m}$  are also denoted by  $\nabla_{\infty}$ . We obtain  $\nabla_{\infty}^j : \operatorname{End}(E) \otimes (T^*X)^{\otimes k} \to \operatorname{End}(E) \otimes (T^*X)^{\otimes (k+j)}$  for any  $k, j \geq 0$ .

#### 3.3.2 Model Higgs bundle

We set  $E_0 = \mathcal{O}_{\mathbb{C}} u_1 \oplus \mathcal{O}_{\mathbb{C}} u_2$ . We consider the Higgs field  $\theta_0$  of  $E_0$  defined by

$$\theta_0(u_1) = \frac{3}{2}u_2 dz, \quad \theta_0(u_2) = \frac{3}{2}u_1 z dz.$$

Let  $C_0$  be the non-degenerate symmetric pairing such that  $C_0(u_i, u_i) = 0$  (i = 1, 2) and  $C_0(u_1, u_2) = 1$ . There exists a unique harmonic metric  $h_0$  of  $(E_0, \theta_0)$  compatible with  $C_0$  (see [12]). Let  $\rho_t : \mathbb{C} \to \mathbb{C}$  be given by  $\rho_t(z) = t^{2/3}z$ . By setting

$$\rho_t^*(u_1) = t^{1/6} u_1, \quad \rho_t^*(u_2) = t^{-1/6} u_2,$$

we obtain the isomorphism  $\rho_t^*(E_0, \theta_0, C_0) \simeq (E_0, t\theta_0, C_0)$ . We obtain harmonic metrics  $h_{0,t} = \rho_t^* h_0$  of  $(E_0, t\theta_0)$  which are compatible with  $C_0$ .

#### **3.3.3** Harmonic metrics around $P \in D_{\theta}$

Let  $P \in D_{\theta}$ . We obtain the map  $\psi_{P,2\kappa_0} : \mathcal{U}_P(2\kappa_0) \to X$  as in §3.1. We obtain the Higgs bundle

$$(E_P, \theta_P) = \psi_{P, 2\kappa_0}^*(E, \theta)$$

on  $\mathcal{U}_P(2\kappa_0)$ . There exists the decomposition

$$\operatorname{End}(E_P)_{|\mathcal{U}_P(2\kappa_0)\setminus\{0\}} = \operatorname{End}(E_P)^\circ \oplus \operatorname{End}(E_P)^{\perp}$$
(38)

as in §3.2.1.

We set  $h_{P,\infty} := \psi_{P,2\kappa_0}^*(h_\infty)$  on  $\mathcal{U}_P(2\kappa_0) \setminus \{0\}$ . There exists a non-degenerate symmetric pairing  $C_P$  of  $(E_P, \theta_P)$ such that  $C_P$  is compatible with  $h_{P,\infty}$  on  $\mathcal{U}_P(2\kappa_0) \setminus \{0\}$  (see [19]). For any  $m \in \mathbb{Z}_{\geq 0}$ , we obtain the connections  $\nabla_{P,\infty}$  of  $\operatorname{End}(E_P) \otimes T^*(\mathcal{U}_P(2\kappa_0) \setminus \{0\})^{\otimes m}$  induced by the Chern connection of  $h_{P,\infty}$  and the Levi-Civita connection of  $|\phi_0|$ .

There exists a natural isomorphism

$$(E_P, \theta_P, C_P) \simeq (E_0, \theta_0, C_0)_{|\mathcal{U}_P(2\kappa_0)}.$$
(39)

For any t > 0, let  $h_{P,t}$  be the harmonic metric of  $(E_P, t\theta_P)$  obtained as the restriction of  $h_{0,t}$  under the isomorphism (39). It is compatible with  $C_P$ . We define the endomorphism  $s_{P,t}$  of  $E_{P|\mathcal{U}_P(2\kappa_0)\setminus\{P\}}$  by  $h_{P,t} = h_{P,\infty} \cdot s_{P,t}$ . We obtain the decomposition

$$s_{P,t} = s_{P,t}^{\circ} + s_{P,t}^{\perp}$$

on  $\mathcal{U}_P(2\kappa_0) \setminus \{0\}$  corresponding to the decomposition (38).

Let  $0 < \kappa < \kappa_0$ . We set  $\delta(\kappa) := \min\{(\kappa_0 - \kappa)/10, \kappa/20\}$ . We set

$$\mathcal{U}_{P,\kappa}^{(1)} = \mathcal{U}_P(\kappa_0 - \delta(\kappa)), \quad \mathcal{U}_{P,\kappa}^{(2)} = \mathcal{U}_P(\kappa_0 - 2\delta(\kappa)).$$

**Lemma 3.13** For any  $j \in \mathbb{Z}_{\geq 0}$ , there exists  $C_j > 0$  such that the following holds on  $\mathcal{U}_{P,\kappa}^{(1)} \setminus \mathcal{U}_{P,\kappa}^{(2)}$ :

$$|\nabla_{\infty}^{j}(s_{P,t}^{\circ} - \mathrm{id})|_{h_{\infty},g_{\phi}} \leq C_{j}e^{-8(\kappa+7\delta(\kappa))t}, \qquad |\nabla_{\infty}^{j}(s_{P,t}^{\perp})|_{h_{\infty},g_{\phi}} \leq C_{j}e^{-4(\kappa+7\delta(\kappa))t}.$$
(40)

**Proof** Let  $Q \in \mathcal{U}_{P,\kappa}^{(1)} \setminus \mathcal{U}_{P,\kappa}^{(2)}$ . There exists a holomorphic embedding  $\psi_Q : U(\kappa_0 - 2\delta(\kappa)) \to \mathcal{U}_{P,\kappa}^{(0)}$  such that  $\psi_Q(0) = Q, \ \psi_Q^*(\phi_0) = (dz)^2$ , and  $0 \notin \operatorname{Im}(\psi_Q)$ . Take  $\kappa + 7\delta(\kappa) < \kappa' < \kappa + 8\delta(\kappa) = \kappa_0 - 2\delta(\kappa)$ .

For any t > 0, let  $\rho_t : \mathbb{C} \to \mathbb{C}$  be the map defined by  $\rho_t(z) = t^{-1}z$ . We put  $\psi_{Q,t} = \psi_Q \circ \rho_t$ . Let  $g_0$  be the standard Euclidean metric on  $\mathbb{C}$ . We apply Corollary 2.5 to  $\psi_{Q,t}^*(E_P, t\theta_P)$  on  $U(t(\kappa_0 - 2\delta(\kappa)))$ . For any  $j \ge 0$ , there exists  $C'_i > 0$  such that the following holds around  $0 \in U(t(\kappa_0 - 2\delta(\kappa)))$ :

$$\left|\psi_{Q,t}^{*}\left(\nabla_{\infty}^{j}(s_{P,t}^{\circ}-\mathrm{id})\right)\right|_{\psi_{Q,t}^{*}h_{\infty},g_{0}} \leq C_{j}^{\prime}e^{-8\kappa^{\prime}t}, \qquad \left|\psi_{Q,t}^{*}\left(\nabla_{\infty}^{j}(s_{P,t}^{\perp})\right)\right|_{\psi_{Q,t}^{*}h_{\infty},g_{0}} \leq C_{j}^{\prime}e^{-4\kappa^{\prime}t}.$$

Hence, the following holds around  $0 \in U(\kappa_0 - 2\delta(\kappa))$ :

$$\left|\psi_Q^*\left(\nabla_\infty^j(s_P^\circ - \mathrm{id})\right)\right|_{\psi_Q^*h_\infty, g_0} \le C_j' t^j e^{-8\kappa' t}, \qquad \left|\psi_Q^*\left(\nabla_\infty^j(s_P^\perp)\right)\right|_{\psi_Q^*h_\infty, g_0} \le C_j' t^j e^{-4\kappa' t}.$$

Then, we obtain (40) around Q.

For any  $\kappa' < \kappa_0$ , we identify  $\mathcal{U}_P(\kappa')$  and  $X_P(\kappa')$ . We also identify  $(E_P, \theta_P)_{|\mathcal{U}_P(\kappa)}$  and  $(E, \theta)_{|X_P(\kappa)}$ . We obtain  $X_{P,\kappa}^{(i)} \subset X_P(\kappa_0)$  (i = 1, 2) corresponding to  $\mathcal{U}_{P,\kappa}^{(i)}$ .

#### 3.3.4 Approximation of harmonic metrics

For  $0 < \kappa < \kappa_0$ , by patching  $h_{\infty}$  and  $h_{P,t}$   $(P \in D_{\theta})$ , we construct Hermitian metrics  $h_{\kappa,t}$  such that the following holds.

- $\widetilde{h}_{\kappa,t} = h_{P,t}$  on  $X_{P,\kappa}^{(2)}$ .
- $\tilde{h}_{\kappa,t} = h_{\infty}$  on  $X \setminus \bigcup X_{P,\kappa}^{(1)}$ .

• Let  $s(h_{\infty}, \tilde{h}_{\kappa,t})$  be the automorphism of  $E_{|X \setminus D_{\theta}}$  determined by  $\tilde{h}_{\kappa,t} = h_{\infty} \cdot s(h_{\infty}, \tilde{h}_{\kappa,t})$ . For any  $j \in \mathbb{Z}_{\geq 0}$ , there exists  $C_j > 0$  such that the following holds on  $\bigcup (X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)})$ :

$$\begin{split} \left| \nabla_{\infty}^{j} \left( s(h_{\infty}, \widetilde{h}_{\kappa, t})^{\circ} - \mathrm{id} \right) \right|_{h_{\infty}, g_{\phi}} &\leq C_{j} e^{-8(\kappa + 7\delta(\kappa))t}, \\ \left| \nabla_{\infty}^{j} \left( s(h_{\infty}, \widetilde{h}_{\kappa, t})^{\perp} \right) \right|_{h_{\infty}, g_{\phi}} &\leq C_{j} e^{-4(\kappa + 7\delta(\kappa))t}. \end{split}$$

•  $\det(\widetilde{h}_{\kappa,t}) = 1.$ 

Let  $s(\tilde{h}_{\kappa,t}, h_t)$  be the automorphism of E determined by  $h_t = \tilde{h}_{\kappa,t} \cdot s(\tilde{h}_{\kappa,t}, h_t)$ .

Let  $\nabla_{h_t}$  denote the Chern connection of  $h_t$ . Let  $g_X$  be a Kähler metric of X. The Levi-Civita connection and  $\nabla_{h_t}$  induce connections on  $\operatorname{End}(E) \otimes (T^*X)^{\otimes m}$ , which are denoted by  $\nabla_{h_t,g_X}$ . We obtain the differential operators  $\nabla_{h_t,g_X}^j$ :  $\operatorname{End}(E) \otimes (T^*X)^{\otimes m} \to \operatorname{End}(E) \otimes (T^*X)^{\otimes m+j}$ . We shall prove the following theorem in §3.3.5–3.3.10.

**Theorem 3.14** For any  $j \ge 0$ , there exists  $C_j > 0$  such that the following holds on X for any  $t \ge 1$ :

$$\left|\nabla_{h_t,g_X}^j \left(s(\widetilde{h}_{\kappa,t},h_t) - \mathrm{id}\right)\right|_{h_t,g_X} + \left|\nabla_{h_t,g_X}^j \left(\left[\theta, s(\widetilde{h}_{\kappa,t},h_t)\right]\right)\right|_{h_t,g_X} + \left|\nabla_{h_t,g_X}^j \left(\left[\theta_{h_t}^\dagger, s(\widetilde{h}_{\kappa,t},h_t)\right]\right)\right|_{h_t,g_X} \le C_j e^{-4\kappa t}.$$

To simplify the description, we set  $s_{\kappa,t} = s(\tilde{h}_{\kappa,t}, h_t)$ . To simplify the argument, we use the following result already proved in [13]. (See also [19].)

**Proposition 3.15 ([13])** There exists C > 0 and  $\epsilon > 0$  such that  $|s_{\kappa,t} - \operatorname{id}|_{\widetilde{h}_{\kappa,t}} \leq Ce^{-\epsilon t}$ . Higher derivatives are also dominated.

It is our purpose to improve the rate of the convergence.

#### 3.3.5 Preliminary

Let  $R(\tilde{h}_{\kappa,t})$  denote the curvature of the Chern connection of E with  $\tilde{h}_{\kappa,t}$ . We set

$$F(\widetilde{h}_{\kappa,t}) = R(\widetilde{h}_{\kappa,t}) + t^2 [\theta, \theta_{\widetilde{h}_{\kappa,t}}^{\dagger}].$$

We obtain the following lemma by the construction of  $h_{\kappa,t}$ .

**Lemma 3.16** The support of  $F(\tilde{h}_{\kappa,t})$  is contained in  $\bigcup_{P} (X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)})$ . Moreover, there exists C > 0 such that

$$|F(\widetilde{h}_{\kappa,t})^{\perp}|_{\widetilde{h}_{\kappa,t},g_X} \le Ce^{-4(\kappa+6\delta(\kappa))t}, \qquad |F(\widetilde{h}_{\kappa,t})^{\circ}|_{\widetilde{h}_{\kappa,t},g_X} \le Ce^{-8(\kappa+6\delta(\kappa))t}.$$

# **3.3.6** Weaker estimate of the $L^2$ -norm of the first derivatives

Let  $s(h_{\infty}, h_t)$  be the automorphism of  $E_{|X \setminus D_{\theta}}$  determined by  $h_t = h_{\infty} s(h_{\infty}, h_t)$ .

**Lemma 3.17** There exists C > 0 such that  $|s(h_{\infty}, h_t)^{\perp}| \leq Ce^{-2\sqrt{2}(\kappa+7\delta(\kappa))t}$  on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$ .

**Proof** Let  $Q \in X \setminus \bigcup X_{P,\kappa}^{(2)}$ . By Lemma 3.3, there exists a locally bi-holomorphic map  $\psi_{Q,t} : U(t(\kappa_0 - 2\delta(\kappa))) \to X \setminus D_{\theta}$  such that  $\psi_Q(0) = Q, \ \psi_Q^*(t^2\phi) = (dz)^2$ . By applying Proposition 2.1, we obtain the claim of Lemma 3.17.

**Corollary 3.18** There exists C > 0 such that  $|s_{\kappa,t}^{\perp}| \leq Ce^{-2\sqrt{2}(\kappa+7\delta(\kappa))t}$  on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$ .

**Corollary 3.19** There exists C > 0 such that the following holds on  $X \setminus D_{\theta}$ :

$$\left| \operatorname{Tr} \left( s_{\kappa,t} F(\widetilde{h}_{\kappa,t}) \right) \right| \le C e^{-(4+2\sqrt{2})(\kappa+6\delta(\kappa))t}.$$
(41)

**Proof** Because  $\operatorname{Tr}(s_{\kappa,t}F(\widetilde{h}_{\kappa,t})) = \operatorname{Tr}(s_{\kappa,t}^{\circ}F(\widetilde{h}_{\kappa,t})^{\circ}) + \operatorname{Tr}(s_{\kappa,t}^{\perp}F(\widetilde{h}_{\kappa,t})^{\perp})$ , we obtain (41) from Proposition 3.15 Lemma 3.16 and Lemma 3.17.

According to [21, Lemma 3.1], we have

$$\Delta_{g_X} \operatorname{Tr}(s_{\kappa,t}) = -\operatorname{Tr}\left(F(\widetilde{h}_{\kappa,t})s_{\kappa,t}\right) - \left|\overline{\partial}_E(s_t)s_t^{-1/2}\right|_{\widetilde{h}_{\kappa,t},g_X}^2 - \left|[\theta, s_{\kappa,t}]s_{\kappa,t}^{-1/2}\right|_{\widetilde{h}_{\kappa,t},g_X}^2$$

Because  $\int \Delta_{g_X} \operatorname{Tr}(s_{\kappa,t}) = 0$ , there exists C' > 0 such that

$$\|\overline{\partial}_{E}(s_{\kappa,t})s_{\kappa,t}^{-1/2}\|_{L^{2},\widetilde{h}_{\kappa,t},g_{X}} \leq C'e^{-(2+\sqrt{2})(\kappa+6\delta(\kappa))t}, \qquad \|[\theta,s_{\kappa,t}]s_{\kappa,t}^{-1/2}\|_{L^{2},\widetilde{h}_{\kappa,t},g_{X}} \leq C'e^{-(2+\sqrt{2})(\kappa+6\delta(\kappa))t}.$$

By Proposition 3.15, there exists C'' > 0 such that

$$\|\overline{\partial}_E(s_{\kappa,t})\|_{L^2,\widetilde{h}_{\kappa,t},g_X} \le C'' e^{-(2+\sqrt{2})(\kappa+6\delta(\kappa))t}, \qquad \|[\theta,s_{\kappa,t}]\|_{L^2,\widetilde{h}_{\kappa,t},g_X} \le C'' e^{-(2+\sqrt{2})(\kappa+6\delta(\kappa))t}.$$

Note that it is equivalent to

$$\|\overline{\partial}_E(s_{\kappa,t})\|_{L^2,\widetilde{h}_{\kappa,t},g_{\phi}} \le C'' e^{-(2+\sqrt{2})(\kappa+6\delta(\kappa))t}, \qquad \|[\theta,s_{\kappa,t}]\|_{L^2,\widetilde{h}_{\kappa,t},g_{\phi}} \le C'' e^{-(2+\sqrt{2})(\kappa+6\delta(\kappa))t}.$$
(42)

#### 3.3.7 Weaker estimate of higher derivatives

**Lemma 3.20** For any j > 0, there exists  $C_j > 0$  such that the following holds on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$ :

$$|\nabla^j_{\infty}(s_{\kappa,t})|_{h_{\infty},g_{\phi}} \le C_j e^{-2\sqrt{2}(\kappa+6\delta(\kappa))t}.$$
(43)

**Proof** By using Lemma 3.17, there exists C' > 0 such that

$$\left|t^2[\theta,\theta_{h_t}^{\dagger}]\right|_{h_{\infty},g_{\phi}} \leq C' t^2 e^{-2\sqrt{2}(\kappa+7\delta(\kappa))t}$$

on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$ . Let  $R(h_t)$  denote the curvature of the Chern connection of  $h_t$ . Because  $R(h_t) + t^2[\theta, \theta_{h_t}^{\dagger}] = 0$ , we obtain

$$\left| R(h_t) \right|_{h_{\infty}, g_{\phi}} \le C' t^2 e^{-2\sqrt{2}(\kappa + 7\delta(\kappa))t}$$

on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$ . By using Lemma 2.26 and Lemma 2.27 with the estimate (42), we obtain the desired estimate (43).

We consider the connection  $\nabla_{\tilde{h}_{\kappa,t},g_{\phi}}$  of  $\operatorname{End}(E) \otimes T^*(X \setminus D_{\phi})^{\otimes m}$  induced by the Chern connection of  $\tilde{h}_{\kappa,t}$  and the Levi-Civita connection of  $g_{\phi}$ . Let  $\rho_{P,\kappa}: X_{P,\kappa}^{(2)} \to \mathbb{R}_{\geq 0}$  be defined by  $\rho_{P,\kappa}(Q) = d_{\phi}(Q, X_P(2\delta(\kappa)))$ .

**Lemma 3.21** Let  $P \in D_{\theta}$ . For any j > 0 and  $0 < \gamma < 2\sqrt{2}$ , there exists  $C_{j,\gamma} > 0$  such that the following holds on  $X_{P,\kappa}^{(2)} \setminus X_P(2\delta(\kappa))$ :

$$\left|\nabla_{\widetilde{h}_{\kappa,t},g_{\phi}}^{j}(s_{\kappa,t})\right|_{\widetilde{h}_{\kappa,t},g_{\phi}} \leq C_{j,\gamma}e^{-\gamma \cdot \rho_{P,\kappa}t}$$

**Proof** Let  $Q \in X_{P,\kappa}^{(2)} \setminus X_P(2\delta(\kappa))$ . There exists a locally bi-holomorphic map

$$\psi_{Q,t}: U(t\rho_P(Q)) \longrightarrow X$$

such that  $\psi_Q(0) = Q$  and  $\psi_Q^*(t^2\phi) = (dz)^2$ . We apply Proposition 2.1 to the Higgs bundle  $(E_{Q,t}, \theta_{Q,t}) = \psi_{Q,t}^*(E, t\theta)$ and harmonic metrics  $h_{t,Q} = \psi_{Q,t}^*(h_t)$  and  $h_{P,t,Q} = \psi_{Q,t}^*(h_{P,t})$ . Let  $\gamma < \gamma' < 2\sqrt{2}$  and  $t \ge 10\delta(\kappa)^{-1}$ . There exists C > 0 such that the following holds on  $U(t\rho_{P,\kappa}(Q) - 1)$ :

$$\left|\overline{\partial}_{E_{Q,t}}\left(\psi_{Q,t}^*(s_{\kappa,t})^{-1}\partial_{E_{Q,t},h_{P,t,Q}}\psi_{Q,t}^*(s_{\kappa,t})\right)\right|_{h_{P,t,Q},g_0} \le Ce^{-\gamma'(t\rho_{P,\kappa}(Q)-|z|)}.$$

We have  $U(2) \subset U(t\rho_{P,\kappa}(Q))$ . By (42), we obtain

$$\int_{U(1)} \left| \partial_{E_{Q,t},h_{P,t,Q}} \psi_{Q,t}^*(s_{\kappa,t}) \right|_{h_{P,t,Q},g_0}^2 \le C e^{-(2+\sqrt{2})(\kappa+6\delta(\kappa))t}$$

Note that  $\rho_{P,\kappa}(Q) < \kappa + 6\delta(\kappa)$ , and hence  $2\sqrt{2}\rho_{P,\kappa}(Q) < (2+\sqrt{2})(\kappa+6\delta(\kappa))$ . By Lemma 2.25 and Lemma 2.26, we obtain the following on U(1):

$$\left|\psi_{Q,t}^* \nabla_{h_{P,t},g_{\phi}}^j(s_{\kappa,t})\right|_{\psi_{Q,t}^*(h_{P,t}),g_0} \le C e^{-\gamma'\rho_{P,\kappa}(Q)t}$$

We obtain the following around Q:

$$\left|\nabla^{j}_{h_{P,t},g_{\phi}}(s_{\kappa,t})\right|_{h_{P,t},g_{\phi}} \leq Ct^{j}e^{-\gamma'\rho_{P,\kappa}(Q)t}.$$

Then, we obtain the claim of the lemma.

**Lemma 3.22** Let  $P \in D_{\theta}$ . For any  $j \ge 0$  and  $0 < \gamma < 2\sqrt{2}$ , there exists  $C_{j,\gamma} > 0$  such that the following holds on  $X_{P,\kappa}^{(2)} \setminus X_P(2\delta(\kappa))$ :

$$\left|\nabla_{\infty}^{j}(s(h_{\infty}, h_{t}) - \mathrm{id})\right|_{h_{\infty}, g_{\phi}} \leq C_{j,\gamma} e^{-\gamma \rho_{P,\kappa} t}.$$

**Proof** There exists  $C'_{j,\gamma} > 0$  such that the following holds on  $X^{(2)}_{P,\kappa} \setminus X_P(2\delta(\kappa))$ :

$$\left|\nabla_{\infty}^{j}(s(h_{\infty},\widetilde{h}_{\kappa,t}) - \mathrm{id})\right|_{h_{\infty},g_{\phi}} \leq C_{j,\gamma}' e^{-\gamma \rho_{P,\kappa} t}.$$

Together with the estimate in Lemma 3.21, we obtain the claim of Lemma 3.22.

Let  $\rho_{\kappa}: X \to \mathbb{R}_{\geq 0}$  be defined by  $\rho_{\kappa}(Q) = \min d_{\phi}(Q, X_P(2\delta(\kappa))).$ 

**Corollary 3.23** For any j > 0 and  $0 < \gamma < 2\sqrt{2}$ , there exists  $C_j > 0$  such that the following holds on  $X \setminus \bigcup_P X_P(2\delta(\kappa))$ :

$$\left|\nabla^{j}_{\infty}(s(h_{\infty},h_{t}))\right|_{h_{\infty},g_{\phi}} \leq C_{j,\gamma}e^{-\gamma\rho_{\kappa}t}.$$

#### 3.3.8 Refinement

We obtain the following.

**Lemma 3.24** There exists C > 0 such that the following holds on  $X \setminus \bigcup_P X_{P,\kappa}^{(2)}$ :

$$|s(h_{\infty}, h_t)^{\perp}| \le C e^{-4(\kappa + 5\delta(\kappa))t}.$$

**Proof** It follows from Proposition 2.2 and Corollary 3.23.

**Corollary 3.25** There exists C > 0 such that the following holds on  $X \setminus \bigcup_P X_{P,\kappa}^{(2)}$ :

$$|s_{\kappa,t}^{\perp}| \le C e^{-4(\kappa+5\delta(\kappa))t}.$$
(44)

There exists C' > 0 such that

$$\left|\operatorname{Tr}\left(s_{\kappa,t}F(\widetilde{h}_{\kappa,t})\right)\right| \le C'e^{-8(\kappa+4\delta(\kappa))t}.$$
(45)

There exists C'' > 0 such that

$$\|\overline{\partial}_E(s_{\kappa,t})\|_{L^2,\widetilde{h}_t,g_X} \le Ce^{-4(\kappa+4\delta(\kappa))t}, \quad \|[\theta,s_{\kappa,t}]\|_{L^2,\widetilde{h}_t,g_X} \le Ce^{-4(\kappa+4\delta(\kappa))t}.$$
(46)

**Proof** We obtain (44) from Lemma 3.24. We obtain the others by repeating the argument in §3.3.6.

We refine Lemma 3.20.

**Lemma 3.26** For any j > 0, there exists  $C_j > 0$  such that the following holds on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$ :

$$|\nabla^j_{\infty}(s_{\kappa,t})|_{h_{\infty},g_{\phi}} \le C_j e^{-4(\kappa+4\delta(\kappa))t}.$$
(47)

For any  $j \ge 0$ , there exists  $C'_j \ge 0$  such that the following holds on  $X \setminus \bigcup X^{(2)}_{P,\kappa}$ :

$$\left|\nabla_{\infty}^{j}([\theta, s_{\kappa, t}])\right|_{h_{\infty}, g_{\phi}} + \left|\nabla_{\infty}^{j}([\theta_{h_{t}}^{\dagger}, s_{\kappa, t}])\right|_{h_{\infty}, g_{\phi}} \le C_{j} e^{-4(\kappa + 4\delta(\kappa))t}.$$
(48)

**Proof** By using Corollary 3.25, we obtain that there exists C > 0 such that

$$\left| R(h_t) \right|_{h_{\infty}, g_{\phi}} \le C t^2 e^{-4(\kappa + 5\delta(\kappa))t}$$

on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$ . Then, we obtain the estimate (47) by using Lemma 2.26 and Lemma 2.27. We also obtain (48) from Corollary 2.28.

# **3.3.9** $C^0$ -estimate

**Proposition 3.27** There exists C > 0 such that the following holds on X:

$$|s_{\kappa,t} - 1|_{\tilde{h}_{\kappa,t}} \le C e^{-4(\kappa + 4\delta(\kappa))t}.$$
(49)

**Proof** We already have the following estimates on  $X \setminus \bigcup X_{P,\kappa}^{(2)}$ :

$$|s_{\kappa,t}^{\perp}|_{h_{\infty}} \le Ce^{-4(\kappa+5\delta(\kappa))t}, \qquad |\nabla_{\infty}(s_{\kappa,t})|_{h_{\infty}} \le Ce^{-4(\kappa+4\delta(\kappa))t}$$

Let  $Q \in X \setminus \bigcup X_{P,\kappa}^{(2)}$ . Let  $v_i$  (i = 1, 2) be a holomorphic frame of  $E_{Q,i}$  around Q such that  $h_{\infty}(v_i, v_i) = 1$ . We have

$$\left|h_t(v_1, v_2)\right| \le C e^{-4(\kappa + 4\delta(\kappa))t}.$$

We also have

$$\left| h_t(v_1, v_1) \cdot h_t(v_2, v_2) - 1 \right| \le C e^{-4(\kappa + 4\delta(\kappa))t}, \qquad |dh_t(v_i, v_i)| \le C e^{-4(\kappa + 4\delta(\kappa))t}.$$

Note that the inclusion  $X \setminus \bigcup X_{P,\kappa}^{(2)} \longrightarrow X$  induces the surjection of the fundamental groups. Hence, there exists a path  $\gamma : [0,1] \to X \setminus \bigcup X_{P,\kappa}^{(2)}$  such that (i)  $\gamma(0) = \gamma(1) = Q$ , (ii) the two points of  $\pi^{-1}(Q)$  are exchanged by the monodromy along  $\gamma$ . By considering the above estimates along the path, we obtain

$$\left| h_t(v_1, v_1) - h_t(v_2, v_2) \right| \le C e^{-4(\kappa + 4\delta(\kappa))t}$$

Then, we obtain

$$\left|h_t(v_i, v_i) - 1\right| \le C e^{-4(\kappa + 4\delta(\kappa))t}.$$

Hence, (49) holds for some C > 0 on  $X \setminus \bigcup_P X_{P,\kappa}^{(2)}$ .

On  $X_{P,\kappa}^{(2)}$ , the function  $\operatorname{Tr}(s_{\kappa,t} - \operatorname{id}) \geq 0$  is subharmonic. Hence, (49) also holds on  $\bigcup_P X_{P,\kappa}^{(2)}$ .

# 3.3.10 Estimates for higher derivatives

We consider the connection  $\nabla_{\tilde{h}_{\kappa,t},g_X}$  of  $\operatorname{End}(E) \otimes T^*X$  induced by the Chern connection of  $\tilde{h}_{\kappa,t}$  and the Levi-Civita connection of  $g_X$ .

**Lemma 3.28** For any j > 0, there exists  $C_j > 0$  such that

$$\left|\nabla_{\widetilde{h}_{\kappa,t},g_X}^j(s_{\kappa,t})\right|_{\widetilde{h}_{\kappa,t},g_X} \le C_j t^j e^{-4(\kappa+3\delta(\kappa))t}.$$
(50)

For any  $j \geq 0$ , there exists  $C'_j > 0$  such that

$$\left\|\nabla_{\widetilde{h}_{\kappa,t},g_X}^j\left(\left[\theta,s_{\kappa,t}\right]\right)\right\|_{\widetilde{h}_{\kappa,t},g_X} + \left|\nabla_{\widetilde{h}_{\kappa,t},g_X}^j\left(\left[\theta_h^{\dagger},s_{\kappa,t}\right]\right)\right|_{\widetilde{h}_{\kappa,t},g_X} \le C_j t^j e^{-4(\kappa+3\delta(\kappa))t}.$$
(51)

**Proof** By Proposition 3.27, there exists C > 0 such that

$$\left|t^{2}[\theta,\theta_{\tilde{h}_{\kappa,t}}^{\dagger}] - t^{2}[\theta,\theta_{h_{t}}^{\dagger}]\right|_{\tilde{h}_{\kappa,t},g_{X}} \leq Ct^{2}e^{-4(\kappa+4\delta(\kappa)t)}$$

We obtain

$$\left|\overline{\partial}_E \left( s_{\kappa,t}^{-1} \partial_{E,\widetilde{h}_{\kappa,t}} s_{\kappa,t} \right) \right|_{\widetilde{h}_{\kappa,t},g_X} \le C t^2 e^{-4(\kappa+4\delta(\kappa))t}.$$

Then, we obtain (50) from Lemma 2.26, Lemma 2.27 and Corollary 3.25. We also obtain (51) by using Corollary 2.28.

We obtain Theorem 3.14 from Proposition 3.27 and Lemma 3.28.

#### 3.4 An auxiliary Hermitian product

#### 3.4.1 Induced 1-forms on the spectral curve

We obtain the following  $\operatorname{End}(E)$ -valued 1-form on  $X \setminus D_{\theta}$ :

$$\Psi_t = (\partial_{E,h_\infty} + t\theta_{h_\infty}^{\dagger}) - (\partial_{E,h_t} + t\theta_{h_t}^{\dagger}).$$

It satisfies  $(\overline{\partial}_E + t \operatorname{ad} \theta) \Psi_t = 0$ . Hence, there exist holomorphic 1-forms  $\eta_t$  on  $\Sigma_{\theta|X \setminus D_\theta}$  such that  $F_{\eta_t} = (\Psi_t^{\circ})^{1,0}$ .

**Lemma 3.29**  $\eta_t$  are holomorphic 1-forms on  $\Sigma_{\theta}$ .

**Proof** Let  $P \in D_{\theta}$ . We consider the following  $\operatorname{End}(E)$ -valued 1-form on  $X(\kappa_0) \setminus \{P\}$ :

$$\Psi_{P,t}' = (\partial_{E,h_{\infty}} + t\theta_{h_{\infty}}^{\dagger}) - (\partial_{E,h_{P,t}} + t\theta_{h_{P,t}}^{\dagger})$$

It is a section of

$$\operatorname{End}(E_{|X_P(\kappa_0)})^{\operatorname{asym}} \otimes \Omega^{1,0} \oplus \operatorname{End}(E_{|X_P}(\kappa_0))^{\operatorname{sym}} \otimes \Omega^{0,1}$$

Hence, we obtain  $((\Psi'_{P,t})^{\circ})^{1,0} = 0$ . We consider the following  $\operatorname{End}(E)$ -valued 1-form on  $X_P(\kappa_0)$ :

$$\Psi_{P,t} = (\partial_{E,h_{P,t}} + t\theta^{\dagger}_{h_{P,t}}) - (\partial_{E,h_t} + t\theta^{\dagger}_{h_t}).$$

It satisfies  $(\overline{\partial}_E + t \operatorname{ad} \theta) \Psi_{P,t} = 0$ . Because  $\Psi_{P,t}$  is given on  $X_P(\kappa_0)$ , there exist holomorphic 1-forms  $\eta_{P,t}$  on  $\Sigma_{\theta|X_P(\kappa)}$  such that  $F_{\eta_{P,t}} = ((\Psi_{P,t})^{1,0})^\circ$  on  $X_P(\kappa_0) \setminus \{P\}$ . (See [18].) Because  $\eta_t = \eta_{P,t}$  on  $\Sigma_{\theta|X_P(\kappa_0)\setminus\{P\}}$ , we obtain the claim of Lemma 3.29.

**Lemma 3.30**  $\eta_t = O(e^{-4\kappa t})$  for any  $\kappa < \kappa_0$ .

**Proof** Let  $W_{\kappa} = X \setminus \bigcup_{P} X_{P,\kappa}^{(2)}$ . Because

$$\Psi_t = s(h_{\infty}, h_t)^{-1} \partial_{h_{\infty}} s(h_{\infty}, h_t) + s(h_{\infty}, h_t)^{-1} \left[ \theta_{h_{\infty}}^{\dagger}, s(h_{\infty}, h_t) \right],$$

we obtain  $\eta_t = O(e^{-4\kappa t})$  on  $\Sigma_{\theta|W_{\kappa}}$ . Because  $\eta_t$  are holomorphic, it implies the estimate on  $\Sigma_{\theta}$ .

**Lemma 3.31** If  $(E, \theta)$  has a globally defined non-degenerate symmetric pairing C, then  $\eta_t = 0$ .

**Proof** Because  $\Psi_t$  is a section of  $\operatorname{End}(E)^{\operatorname{asym}} \otimes \Omega^{1,0} \oplus \operatorname{End}(E)^{\operatorname{sym}} \otimes \Omega^{0,1}$ , we obtain  $(\Psi_t^{\circ})^{1,0} = 0$ . It implies the claim of the lemma.

#### **3.4.2** Canonical choice of a root of $\phi$ and a root of the coordinate $z_P$

We obtain the quadratic differential  $\pi^* \phi$  on  $\Sigma_{\theta}$ . Let  $a_{T^*X}$  denote the tautological 1-form on  $T^*X$ . Let  $\phi^{1/2}$  denote the pull back of  $a_{T^*X}$  by the inclusion  $\Sigma_{\theta} \to T^*X$ .

**Lemma 3.32** We obtain  $(\phi^{1/2})^2 = \pi^*(\phi)$ .

For each  $P \in D_{\theta}$ , let  $z_P$  be a holomorphic coordinate on  $X_P(\kappa_0)$  such that  $\phi|_{X_P(\kappa_0)} = (\frac{3}{2})^2 z_P(dz_P)^2$ . It induces a holomorphic coordinate system  $(z_P, \xi_P)$  on  $T^*X_P$  such that  $\xi_P dz_P$  is the tautological 1-form. Because

$$\Sigma_{\theta|X_P(\kappa_0)} = \left\{ (z_P, \xi_P) \, \left| \, \xi_P^2 - \left(\frac{3}{2}\right)^2 z_P = 0 \right\},\,$$

 $\xi_P$  is a holomorphic local coordinate on  $\Sigma_{\theta|X_P(\kappa_0)}$ . We have

$$\phi^{1/2} = \frac{2^3}{3^2} \xi_P^2 d\xi_P.$$

#### 3.4.3 Induced pairings on the cohomology group of $\Sigma_{\theta}$

For each  $P \in D_{\theta}$ , let  $\tilde{P} \in \Sigma_{\theta}$  denote the pre-image of P. We set  $\tilde{D}_{\theta} = \{\tilde{P} | P \in D_{\theta}\}$ , which can be regarded as the divisor on  $\Sigma_{\theta}$ . For each  $\tilde{P} \in \tilde{D}_{\theta}$ , there exists the residue morphism

$$\operatorname{Res}_{\widetilde{P}}^{(2)}: H^0(\Sigma_{\theta}, K^2_{\Sigma_{\theta}}(2\widetilde{D})) \longrightarrow \mathbb{C}.$$

Let  $\nu_1, \nu_2 \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$ . We obtain

$$\nu_1 \cdot \nu_2 \cdot \eta_t \cdot (\phi^{1/2})^{-1} \in H^0(\Sigma_\theta, K^2_{\Sigma_\theta}(2D))$$

We define the pairing  $\langle \cdot, \cdot \rangle_{P,h_t}^{\text{aux}}$  on  $H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$  as follows:

$$\langle \nu_1, \nu_2 \rangle_{P,h_t}^{\mathrm{aux}} = -4\pi \operatorname{Res}_{\widetilde{P}}^{(2)} \Big( \nu_1 \cdot \nu_2 \cdot \eta_t \cdot (\phi^{1/2})^{-1} \Big).$$

We set

$$\langle \cdot, \cdot \rangle_{h_t}^{\mathrm{aux}} = \sum_{P \in D_\theta} \langle \cdot, \cdot \rangle_{P,h_t}^{\mathrm{aux}}$$

# 3.4.4 Induced Hermitian pairings on $T_{(E,t\theta)}\mathcal{M}'_H$

We identify  $T_{(E,t\theta)}\mathcal{M}'_H = H^1(X, \operatorname{End}(E, t\theta))$ . As recalled in §1.1.2, we have the decomposition

$$T_{(E,t\theta)}\mathcal{M}'_{H} = (T_{(E,t\theta)}\mathcal{M}'_{H})^{\operatorname{ver}} \oplus (T_{(E,t\theta)}\mathcal{M}'_{H})^{\operatorname{hor}},$$

and there exist the natural isomorphisms

$$\iota_t^{\mathrm{ver}} : H^1(\Sigma_\theta, \mathcal{O}_{\Sigma_\theta}) \simeq (T_{(E,t\theta)}\mathcal{M}'_H)^{\mathrm{ver}}, \quad \iota_t^{\mathrm{hor}} : H^0(\Sigma_\theta, K_{\Sigma_\theta}) \simeq (T_{(E,t\theta)}\mathcal{M}'_H)^{\mathrm{hor}}$$

(See [18] for more details.) We define  $g_{|(E,t\theta)}^{aux}$  by using  $\langle \cdot, \cdot \rangle_{h_t}^{aux}$  in §3.4.3 as follows.

- $g_{|(E,t\theta)}^{aux}(v_1, v_2) = 0$  if  $v_i \in (T_{(E,t\theta)}\mathcal{M}'_H)^{ver}$  (i = 1, 2) or  $v_i \in (T_{(E,t\theta)}\mathcal{M}'_H)^{hor}$  (i = 1, 2).
- Let  $\nu \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$  and  $\tau \in H^1(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}}) = H^0(\Sigma_{\theta}^{\dagger}, K_{\Sigma_{\theta}^{\dagger}})$ . Then,

$$g_{|(E,t\theta)}^{\mathrm{aux}}(\iota_t^{\mathrm{hor}}(\nu),\iota_t^{\mathrm{ver}}(\tau)) = \langle \nu, \overline{\tau} \rangle_{h_t}^{\mathrm{aux}}$$

We obtain the following lemma from Lemma 3.30.

Lemma 3.33  $g_{|(E,t\theta)}^{aux}(\nu,\tau) = O(e^{-4\kappa t}) \|\nu\|_{L^2} \cdot \|\tau\|_{L^2}$  for any  $0 < \kappa < \kappa_0$ .

**Corollary 3.34**  $g_{|(E,t\theta)}^{aux} = O(e^{-4\kappa t})$  with respect to  $g_{sf|(E,t\theta)}$  for any  $0 < \kappa < \kappa_0$ . As a result, there exists  $t_0 > 0$  such that  $g_{sf|(E,t\theta)} + g_{|(E,t\theta)}^{aux}$  are positive definite Hermitian products on  $T_{(E,t\theta)}\mathcal{M}'_H$  for any  $t \ge t_0$ .

#### 3.5 Comparison of the Hitchin metric and the semi-flat metric

#### 3.5.1 Main theorem

Let  $t_0$  be as in Corollary 3.34. For any  $t \ge t_0$ , let  $\sigma_t$  be the automorphism of  $T_{(E,t\theta)}\mathcal{M}_H$  determined by  $g_{H|(E,t\theta)} = (g_{\mathrm{sf}|(E,t\theta)} + g_{|(E,t\theta)}^{\mathrm{aux}}) \cdot \sigma_t$ .

**Theorem 3.35** For any  $0 < \kappa < \kappa_0$ , there exists  $C(\kappa) > 0$  such that

$$|\sigma_t - \mathrm{id}|_{q_{\mathrm{sf}}} \leq C(\kappa) e^{-8\kappa t}$$

Let  $\nu \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$ . It determines the horizontal class

$$\iota_t^{\mathrm{hor}}(\nu) \in H^1(X, \mathrm{Def}(E, t\theta))^{\mathrm{hor}} \subset H^1(X, \mathrm{Def}(E, t\theta)).$$

(See [18].) Let  $H_t(\nu)$  denote the harmonic representative of  $\iota_t^{\text{hor}}(\nu)$  with respect to  $h_t$ . We shall prove the following proposition in §3.5.5.

**Proposition 3.36** For any  $0 < \kappa < \kappa_0$ ,

$$(\mathbf{H}_t(\nu),\mathbf{H}_t(\nu))_{L^2,h_t} = \|\nu\|_{L^2}^2 + O(e^{-8\kappa t}\|\nu\|_{L^2}^2).$$

Let  $\tau \in H^0(\Sigma_{\theta}^{\dagger}, K_{\Sigma_{\theta}^{\dagger}}) \simeq H^1(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}})$ . We also regard  $\tau$  as a harmonic (0, 1)-form on  $\Sigma_{\theta}$ . We obtain  $\iota_t^{\text{ver}}(\tau) \in H^1(X, (\text{End}(E), t\theta))$ . There exists a harmonic representative  $V_t(\tau)$  of  $(\text{End}(E), t\theta, h_t)$ . We shall prove the following proposition in §3.5.7.

**Proposition 3.37** For any  $0 < \kappa < \kappa_0$ ,

$$(\mathbf{V}_t(\tau), \mathbf{V}_t(\tau))_{L^2, h_t} = (\tau, \tau)_{L^2} + O(e^{-8\kappa t} \|\tau\|_{L^2}^2).$$

We shall prove the following proposition in §3.5.8.

**Proposition 3.38**  $(\mathbb{H}_t(\nu), \mathbb{V}_t(\tau))_{L^2, h_t} = \langle \nu, \overline{\tau} \rangle_{h_t}^{\mathrm{aux}} + O(e^{-8\kappa t} \cdot \|\nu\|_{L^2} \cdot \|\tau\|_{L^2}).$ 

We obtain Theorem 3.35 from Proposition 3.36, Proposition 3.37 and Proposition 3.38.

#### 3.5.2 Preliminary

Let  $P \in D_{\theta}$ . Let  $s_{P,t}$  be determined by  $h_{P,t} = h_t \cdot s_{P,t}$  on  $X_P(\kappa_0)$ . (Note that we use a different notation from §3.3.3.) We set

$$\Psi_{P,t} := \left(\partial_{h_{P,t}} + t\theta_{h_{P,t}}^{\dagger}\right) - \left(\partial_{h_t} + t\theta_{h_t}^{\dagger}\right) = s_{P,t}^{-1}\partial_{h_t}s_{P,t} + s_{P,t}^{-1}[t\theta_{h_t}^{\dagger}, s_{P,t}].$$

Because  $[\overline{\partial}_E + t\theta, \partial_{h_{P,t}} + t\theta_{h_{P,t}}^{\dagger}] = 0$  and  $[\overline{\partial}_E + t\theta, \partial_{h_t} + t\theta_{h_t}^{\dagger}] = 0$ , we obtain  $(\overline{\partial}_E + t \operatorname{ad} \theta)\Psi_{P,t} = 0$ .

Let  $f_P$  be the endomorphism determined by  $\theta = f_P dz_P$ . Let  $M_{P,i,t}$  be the endomorphisms of  $E_{|X_P(\kappa_0)|}$  defined by

$$\Psi_{P,t} = M_{P,1,t} \, dz_P + M_{P,2,t} \, d\overline{z}_P$$

Because  $(\overline{\partial}_E + t \operatorname{ad} \theta) \Psi_{P,t} = 0$ , we obtain

$$\overline{\partial}M_{P,1,t} - [tf_P, M_{P,2,t}\,d\overline{z}_P] = 0. \tag{52}$$

**Lemma 3.39** We have  $\overline{\partial}M_{P,1,t}^{\circ} = 0$ . There exist  $C_j > 0$  such that the following holds on  $X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)}$ :

$$|\nabla^j_{\infty} M_{P,1,t}|_{h_{\infty},g_{\phi}} \le C_j e^{-4(\kappa+\delta(\kappa))t}.$$

**Proof** The first claim follows from (52). The second follows from Theorem 3.14.

Let  $\eta_t$  be the 1-forms on  $\Sigma_{\theta}$  as in §3.4.1. Let  $(z_P, \xi_P)$  be the coordinate as in §3.4.2. Let  $v_{P,t}$  be the holomorphic function on  $\Sigma_{\theta|X_P(\kappa_0)\setminus\{P\}}$  determined by

$$\eta_t = \upsilon_{P,t} \cdot \pi^*(dz_P).$$

We note that  $v_{P,t}$  has at most pole of order 1 at  $\pi^{-1}(P)$ . By the construction, we have the following lemma.

Lemma 3.40  $M_{P,1,t}^{\circ} = F_{v_{P,t}}$ .

# **3.5.3** Some 1-forms around $P \in D_{\theta}$

Let  $\nu \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$ . We obtain the holomorphic section  $F_{\nu}$  of  $\operatorname{End}(E) \otimes K_X$  on  $X \setminus D_{\theta}$ .

Let  $P \in D_{\theta}$ . There exists a holomorphic function  $\alpha_P$  on  $\Sigma_{\theta|X_P(\kappa)}$  such that  $d\alpha_P = \nu$  and that  $\alpha_P = 0$  at  $\pi^{-1}(P)$ . We obtain the induced section  $F_{\alpha_P}$  of  $\operatorname{End}(E_P)$  on  $X_P(\kappa_0)$ . Let  $\alpha_0$  and  $\alpha_1$  be the holomorphic functions on  $X_P(\kappa_0)$  determined by

$$\alpha_P(\xi_P) = \alpha_0(z_P) + \alpha_1(z_P)\xi_P,$$

where  $(z_P, \xi_P)$  be the holomorphic coordinate system as in §3.4.2. Then, the following holds:

$$F_{\alpha_P} = \alpha_0 \operatorname{id} + \alpha_1 f_P.$$

**Lemma 3.41** There exists C > 0 independently from  $\nu \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$  and  $t \ge 1$  such that the following holds:

$$||F_{\alpha_P}||^2_{h_{P,t},X_P(\kappa_0)} \le C ||\nu||^2_{L^2}$$

**Proof** We have  $|\alpha_P| \leq C_0 ||\nu||_{L^2}$ . By Theorem 3.14, there exists  $C_1 > 0$  such that  $|F_{\alpha_P}|^2_{h_{P,t}} \leq C_1 ||\nu||^2_{L^2}$  on  $\partial X_P^{(2)}$  for any  $t \geq 1$ . Because  $(\overline{\partial}_E + t \operatorname{ad} \theta) F_{\alpha_P} = 0$ , we obtain  $-\partial_z \partial_{\overline{z}} |F_{\alpha_P}|^2_{h_t} \leq 0$ . Then, we obtain the claim of the lemma.

We obtain the following harmonic 1-forms of  $(\text{End}(E_P), t\theta_P, h_{P,t})$  on  $X_P(\kappa_0)$ :

$$\mathbb{H}_{P,t}(\nu) := \left(\partial_{h_{P,t}} + \mathrm{ad}(t\theta^{\dagger}_{h_{P,t}})\right) F_{\alpha_{P}}.$$

According to [18, Lemma 4.14], there exists C > 0 such that the following holds on  $X_{P,\kappa}^{(1)}$  for any  $t \ge 1$ :

$$|\mathbf{H}_{P,t}(\nu)|_{h_{P,t},g_X} \le C(1+t) \|\nu\|_{L^2}.$$

We remark the following.

**Lemma 3.42** The (1,0)-part  $\mathbb{H}_{P,t}(\nu)^{1,0}$  is symmetric, and the (0,1)-part  $\mathbb{H}_{P,t}(\nu)^{0,1}$  is anti-symmetric with respect to  $C_P$ . We have  $\mathbb{H}_{P,t}(\nu)^{\circ} = F_{\nu}$  on  $X_P(\kappa_0)$ .

On  $X_P(\kappa_0) \setminus \{P\}$ , there exists a  $C^{\infty}$ -section  $\rho_{P,t}(\nu)$  of  $\operatorname{End}(E)$ , which is anti-symmetric with respect to  $C_P$ , such that

$$\mathbf{H}_{P,t}(\nu) - F_{\nu} = (\overline{\partial}_E + t \operatorname{ad} \theta) \rho_{P,t}(\nu).$$

On  $X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)}$ , we have

$$\|\rho_{P,t}(\nu)\|_{L^p_{\ell},h_{\infty},g_{\phi}} = O(e^{-4(\kappa+7\delta(\kappa))t}\|\nu\|_{L^2}).$$
(53)

We also note that  $\rho_{P,t}(\nu)^{\circ} = 0$ .

We also obtain the following harmonic 1-forms of  $(\text{End}(E), t \text{ ad } \theta, h_t)$  on  $X_P(\kappa_0)$ :

$$\widetilde{\mathsf{H}}_{P,t}(\nu) := (\partial_{E,h_t} + \operatorname{ad} t\theta_{h_t}^{\dagger}) F_{\alpha_P}.$$

We set  $I_{P,t}(\nu) = H_{P,t}(\nu) - \widetilde{H}_{P,t}(\nu)$ .

Lemma 3.43 We have

$$\mathbf{I}_{P,t}(\nu) = \left(\overline{\partial} + t \operatorname{ad} \theta\right) \left(-t^{-1} \alpha_1 M_{P,1,t}\right).$$
(54)

**Proof** We have

$$\mathbf{I}_{P,t}(\nu) = [\Psi_t, F_{\alpha_P}] = [M_{P,1,t}dz_P, \alpha_1 f_P] + [M_{P,2,t}\,d\overline{z}_P, \alpha_1 f_P] = -[tf_P\,dz_P, t^{-1}\alpha_1 M_{P,1,t}] - [f_P, \alpha_1 M_{P,2,t}d\overline{z}_P].$$

We also have

$$\overline{\partial}(t^{-1}\alpha_1 M_{P,1,t}) = t^{-1}\alpha_1\overline{\partial}M_{P,1,t} = t^{-1}\alpha_1[tf_P, M_{P,2,t}d\overline{z}_P] = [f_P, \alpha_1 M_{P,2,t}d\overline{z}_P].$$

Then, we obtain (54).

**Lemma 3.44** We have  $I_{P,t}(\nu)^{\circ} = 0$ . There exists C > 0 such that  $|I_{P,t}(\nu)|_{h_{\infty},g_{\phi}} \leq Ce^{-4\kappa t} ||\nu||_{L^{2}}$  on  $X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)}$ .

**Proof** The first claim is clear by the construction. The second follows from Lemma 3.39.

#### 3.5.4 Approximations of harmonic 1-forms in the horizontal direction

Let  $\nu \in H^0(\Sigma_{\theta}, K_{\Sigma_{\theta}})$ . We recall a construction in [18]. Let  $\chi_{P,\kappa} : X \to [0,1]$  be a  $C^{\infty}$ -function such that  $\chi_{P,\kappa} = 1$  on  $X_{P,\kappa}^{(2)}$  and  $\chi_{P,\kappa} = 0$  outside  $X_{P,\kappa}^{(1)}$ . By patching  $\mathbb{H}_{P,t}(\nu)$   $(P \in D_{\theta})$  and  $F_{\nu}$  by using  $\rho_{P,t}(\nu)$ , we construct a section  $\mathbb{H}'_{\kappa,t}(\nu)$  of  $\operatorname{End}(E) \otimes (\Omega^{1,0} \oplus \Omega^{0,1})$  as follows:

- On  $X \setminus \bigcup X_{P,\kappa}^{(1)}$ , we set  $\mathtt{H}'_{\kappa,t}(\nu) = F_{\nu}$ .
- On  $X_{P,\kappa}^{(1)} \setminus X_{P,\kappa}^{(2)}$ , we set  $\mathtt{H}'_{\kappa,t}(\nu) = F_{\nu} + (\overline{\partial}_E + t \operatorname{ad} \theta)(\chi_{P,\kappa}\rho_{P,t}(\nu)).$
- On  $X_{P,\kappa}^{(2)}$ , we set  $\mathbf{H}'_{\kappa,t}(\nu) = \mathbf{H}_{P,t}(\nu)$ .

We obtain the following lemma by the construction.

**Lemma 3.45**  $H'_{\kappa,t}(\nu)^{\circ} = F_{\nu}$ .

**Lemma 3.46** We have  $(\overline{\partial}_E + t \operatorname{ad} \theta) \mathbb{H}'_{\kappa,t}(\nu) = 0$ , and  $(\overline{\partial}_E + t \operatorname{ad} \theta)^*_{g_X,h_t} \mathbb{H}'_{\kappa,t}(\nu) = O(e^{-4\kappa t} ||\nu||_{L^2})$ . The cohomology class is  $\iota^{\operatorname{hor}}_t(\nu)$ .

**Proof** By the construction, we have  $(\overline{\partial}_E + t \operatorname{ad} \theta) \operatorname{H}'_{\kappa,t}(\nu) = 0$ . On  $X \setminus D_\theta$ , we have  $\operatorname{H}'_{\kappa,t}(\nu)^\circ = F_{\nu}$ . On  $X^{(2)}_{P,\kappa}$ ,  $\operatorname{H}'_{\kappa,t}(\nu)^{1,0}$  is self-adjoint, and  $\operatorname{H}'_{\kappa,t}(\nu)^{0,1}$  is anti-self-adjoint with respect to  $C_P$ . Hence, as studied in [18], the cohomology class of  $\operatorname{H}'_{\kappa,t}(\nu)$  is  $\iota_t^{\operatorname{hor}}(\nu)$ .

We have  $(\overline{\partial}_E + t \operatorname{ad} \theta)^*_{g_X,h_t} \mathbb{H}'_{\kappa,t}(\nu) = O(e^{-4(\kappa+7\delta(\kappa))t} \|\nu\|_{L^2})$  on  $X^{(1)}_{P,\kappa} \setminus X^{(2)}_{P,\kappa}$  by the construction. On  $X^{(2)}_{P,\kappa}$ , we have

$$\mathbf{H}_{\kappa,t}'(\nu) = (\partial_{E,h_{P,t}} + \operatorname{ad} t\theta_{h_{P,t}}^{\dagger})F_{\alpha_P} = (\partial_{E,h_t} + \operatorname{ad} t\theta_{h_t}^{\dagger})F_{\alpha_P} + \left[s_{\kappa,t}^{-1}\partial_{E,h_t}(s_{\kappa,t}) + s_{\kappa,t}^{-1}[t\theta_{h_t}^{\dagger}, s_{\kappa,t}], F_{\alpha_P}\right]$$

By Theorem 3.14, we obtain

$$(\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) \mathbb{H}_{\kappa,t}'(\nu) = (\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) \left( \left[ s_{\kappa,t}^{-1} \partial_{E,h_t}(s_{\kappa,t}) + s_{\kappa,t}^{-1} [t \theta_{h_t}^{\dagger}, s_{\kappa,t}], F_{\alpha_P} \right] \right) = O(e^{-4\kappa t} \|\nu\|_{L^2}).$$

We obtain the claim of the lemma.

Note that  $\operatorname{Tr}((\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) \mathfrak{H}'_{\kappa,t}(\nu)) = \partial \operatorname{Tr}(\mathfrak{H}'_{\kappa,t}(\nu)) = 0$ . There exist a unique section  $\gamma_{\kappa,t}(\nu)$  of  $\operatorname{End}(E)$  satisfying  $\operatorname{Tr} \gamma_{\kappa,t}(\nu) = 0$  and

$$(\overline{\partial}_E + t \operatorname{ad} \theta)^*_{g_X, h_t} (\overline{\partial}_E + t \operatorname{ad} \theta) \gamma_{\kappa, t}(\nu) = (\overline{\partial}_E + t \operatorname{ad} \theta)^*_{g_X, h_t} \mathrm{H}'_{\kappa, t}(\nu).$$

The following lemma is clear.

Lemma 3.47  $\operatorname{H}_t(\nu) = \operatorname{H}'_{\kappa,t}(\nu) - \gamma_{\kappa,t}(\nu).$ 

By [18, Proposition 2.39], we have the following estimate:

$$\|\gamma_{\kappa,t}(\nu)\|_{L^2,h_t,g_X} + \|(\overline{\partial}_E + t\theta)\gamma_{\kappa,t}(\nu)\|_{L^2,h_t} \le Ce^{-4(\kappa+\delta(\kappa))t}$$

#### 3.5.5 Proof of Proposition 3.36

**Lemma 3.48**  $(\mathbf{H}_t(\nu), \mathbf{H}_t(\nu))_{L^2, h_t} = (\mathbf{H}'_{\kappa, t}(\nu), \mathbf{H}'_{\kappa, t}(\nu))_{L^2, h_t} + O(e^{-8\kappa t} \|\nu\|_{L^2}^2).$ 

**Proof** By the standard formula (see Lemma 3.55 below), we obtain

$$\left(\mathsf{H}_{t}(\nu), \left(\overline{\partial}_{E} + t \operatorname{ad} \theta\right) \gamma_{\kappa, t}(\nu)\right)_{L^{2}, h_{t}} = \left(\left(\overline{\partial}_{E} + t \operatorname{ad} \theta\right)^{*}_{h_{t}, g_{X}} \mathsf{H}_{t}(\nu), \gamma_{\kappa, t}(\nu)\right)_{L^{2}, h_{t}, g_{X}} = 0,$$

$$\left(\mathsf{H}_{\kappa,t}'(\nu), (\overline{\partial}_E + t \operatorname{ad} \theta)\gamma_{\kappa,t}(\nu)\right)_{L^2,h_t} = \left((\overline{\partial}_E + t \operatorname{ad} \theta)_{h_t,g_X}^* \mathsf{H}_{\kappa,t}'(\nu), \gamma_{\kappa,t}(\nu)\right)_{L^2,h_t,g_X} = O\left(e^{-8\kappa t} \|\nu\|_{L^2}^2\right).$$

Hence, we obtain

$$\left(\mathsf{H}_{t}(\nu),\mathsf{H}_{t}(\nu)\right)_{L^{2},g_{X},h_{t}} = \left(\mathsf{H}_{t}(\nu),\mathsf{H}_{\kappa,t}'(\nu)\right)_{L^{2},g_{X},h_{t}} = \left(\mathsf{H}_{\kappa,t}'(\nu),\mathsf{H}_{\kappa,t}'(\nu)\right)_{L^{2},g_{X},h_{t}} + O\left(e^{-8\kappa t}\|\nu\|_{L^{2}}^{2}\right).$$

We set  $W_{\kappa} = X \setminus \bigcup_{P} X_{P,\kappa}^{(2)}$ .

# Lemma 3.49

$$\left(\mathsf{H}_{\kappa,t}'(\nu),\mathsf{H}_{\kappa,t}'(\nu)\right)_{L^2,h_t,W_\kappa} = 2\sqrt{-1}\int_{\Sigma_{\theta|W_\kappa}} \nu \cdot \overline{\nu} + O\left(e^{-8\kappa t}\|\nu\|_{L^2}^2\right).$$

**Proof** It follows from the estimate (53), Lemma 3.45 and Lemma 3.53 below.

On  $X_{P,\kappa}^{(2)}$ , we have  $\mathbb{H}_{\kappa,t}(\nu) = \mathbb{H}_{P,t}(\nu)$ .

Lemma 3.50

$$\left(\mathbf{H}_{P,t}(\nu),\mathbf{H}_{P,t}(\nu)\right)_{L^{2},h_{t},X_{P,\kappa}^{(2)}} = \left(\widetilde{\mathbf{H}}_{P,t}(\nu),\widetilde{\mathbf{H}}_{P,t}(\nu)\right)_{L^{2},h_{t},X_{P,\kappa}^{(2)}} + O\left(e^{-8\kappa t}\|\nu\|_{L^{2}}^{2}\right).$$
(55)

**Proof** Because  $(\overline{\partial} + t \operatorname{ad} \theta) \mathbf{I}_{P,t}(\nu) = 0$ , we have  $(\partial_{h_t} + t \operatorname{ad} \theta^{\dagger}_{h_t})^*_{h_t,g_X} \mathbf{I}_{P,t}(\nu) = 0$ . Hence, by Stokes formula (see Lemma 3.55 below), and by Lemma 3.44 and Lemma 3.53 below, we obtain

$$\left(\widetilde{\mathsf{H}}_{P,t}(\nu), \mathsf{I}_{P,t}(\nu)\right)_{L^{2}, h_{t}, X_{P,\kappa}^{(2)}} = 2\sqrt{-1} \int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr}\left(F_{\alpha_{P}} \cdot \left(\mathsf{I}_{P,t}(\nu)^{1,0}\right)_{h_{t}}^{\dagger}\right) = O\left(e^{-8\kappa t}\right) \|\nu\|_{L^{2}}^{2}.$$

We also have  $(I_{P,t}(\nu), I_{P,t}(\nu))_{L^2, h_t, X_{P,\kappa}^{(2)}} = O(e^{-8\kappa t}) \|\nu\|_{L^2}^2$ . Then, we obtain (55).

#### Lemma 3.51

$$\left(\widetilde{\mathsf{H}}_{P,t}(\nu),\widetilde{\mathsf{H}}_{P,t}(\nu)\right)_{L^{2},h_{t},X_{P,\kappa}^{(2)}} = 2\sqrt{-1} \int_{\Sigma_{\theta|X_{P,\kappa}^{(2)}}} \nu\overline{\nu} + O\left(e^{-8\kappa t} \|\nu\|_{L^{2}}^{2}\right).$$
(56)

**Proof** By using Lemma 3.55 and Lemma 3.53 below, we obtain

$$(\widetilde{\mathbf{H}}_{t}(\nu), \widetilde{\mathbf{H}}_{t}(\nu))_{L^{2}, h_{t}, X_{P, \kappa}^{(2)}} = 2\sqrt{-1} \int_{\partial X_{P, \kappa}^{(2)}} \operatorname{Tr} \left( F_{\alpha}(\widetilde{\mathbf{H}}_{t}(\nu)^{1, 0})_{h_{t}}^{\dagger} \right)$$

$$= 2\sqrt{-1} \int_{\partial \Sigma_{\theta \mid X_{P, \kappa}^{(2)}}} \alpha_{P} \overline{\nu} + O\left(e^{-8\kappa t} \|\nu\|_{L^{2}}^{2}\right) = 2\sqrt{-1} \int_{\Sigma_{\theta \mid X_{P, \kappa}^{(2)}}} \nu \overline{\nu} + O\left(e^{-8\kappa t} \|\nu\|_{L^{2}}^{2}\right).$$
(57)

We obtain (56).

In all, we obtain Proposition 3.36.

#### 3.5.6 Approximation of harmonic 1-forms in the vertical direction

Let  $\tau \in H^0(\Sigma_{\theta}^{\dagger}, K_{\Sigma_{\theta}^{\dagger}}) \simeq H^1(\Sigma_{\theta}, \mathcal{O}_{\Sigma_{\theta}})$ . We recall the construction of approximations of  $\mathbb{V}_t(\tau)$  introduced in [18].

Let  $P \in D_{\theta}$ . There exist an anti-holomorphic function  $\beta_P$  on  $\Sigma_{\theta|X_P(\kappa_0)}$  such that  $d\beta_P = \tau$ . We obtain the endomorphism  $F_{\beta_P}^{\dagger}$  of  $E_P$  by using the spectral curve  $\Sigma_{\theta}^{\dagger} \to X^{\dagger}$  of  $(E, \theta_{h_t}^{\dagger})$ . It equals  $(F_{\overline{\beta}_P})_{h_t}^{\dagger}$ . Let  $\chi_{P,\kappa}$  be as in §3.5.5. We put

$$\tau_{\kappa}^{\circ} = \tau - \sum \overline{\partial}(\chi_{P,\kappa}\beta_P)$$

on  $\Sigma_{\theta}$ . We set

$$\mathbf{V}_{\kappa,t}'(\tau) = F_{\tau_{\kappa}^{\circ}} + \sum (\overline{\partial}_E + t \operatorname{ad} \theta)(\chi_{P,\kappa} F_{\beta_P}^{\dagger}).$$

We have

$$(\overline{\partial}_E + t \operatorname{ad} \theta) \mathsf{V}'_{\kappa,t}(\tau) = 0, \qquad (\partial_{E,h_t} + t \operatorname{ad} \theta^{\dagger}_{h_t}) \mathsf{V}'_{\kappa,t}(\tau) = O(e^{-4(\kappa + 7\delta(\kappa))t} \|\tau\|_{L^2}).$$

We note that  $\operatorname{Tr}\left((\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger}) \mathbf{V}_{\kappa,t}'(\tau)\right) = \partial \operatorname{Tr} \mathbf{V}_{\kappa,t}'(\tau) = 0$  (see [18, Lemma 4.28]). There exist  $\gamma_{\kappa,t}(\tau)$  satisfying  $\operatorname{Tr} \gamma_{\kappa,t}(\tau) = 0$  and

$$(\overline{\partial}_E + t \operatorname{ad} \theta)(\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger})\gamma_{\kappa,t}(\tau) = (\partial_{E,h_t} + t \operatorname{ad} \theta_{h_t}^{\dagger})\mathsf{V}_{\kappa,t}'(\tau)$$

By [18, Proposition 2.39], we have

$$\|\gamma_{\kappa,t}\|_{L^2,h_t,g_X} + \|(\overline{\partial}_E + t\theta)\gamma_{\kappa,t}(\tau)\|_{L^2,h_t} = O\left(e^{-4\kappa t}\|\tau\|_{L^2}\right)$$

We have

$$\mathbf{V}_t(\tau) = \mathbf{V}_{\kappa,t}'(\tau) - (\overline{\partial}_E + t \operatorname{ad} \theta) \gamma_{\kappa,t}(\tau).$$

#### **Proof of Proposition 3.37** 3.5.7

We obtain the following estimate as in the case of Lemma 3.48:

$$\left(\mathbf{V}_t(\tau),\mathbf{V}_t(\tau)\right)_{L^2,h_t} = \left(\mathbf{V}_{\kappa,t}'(\tau),\mathbf{V}_{\kappa,t}'(\tau)\right)_{L^2,h_t} + O\left(e^{-8\kappa t}\|\tau\|_{L^2}^2\right).$$

By using Lemma 3.54 below, we obtain the following:

$$\left(\mathbf{V}_{\kappa,t}'(\tau),\mathbf{V}_{\kappa,t}'(\tau)\right)_{L^2,h_t,W_\kappa} = -2\sqrt{-1}\int_{\Sigma_{\theta|W_\kappa}} \tau \cdot \overline{\tau} + O\left(e^{-8\kappa t} \|\tau\|_{L^2}^2\right).$$

By using the Stokes formula (Lemma 3.55), we obtain

$$\left(\mathbf{V}_{\kappa,t}'(\tau),\mathbf{V}_{\kappa,t}'(\tau)\right)_{L^2,h_t,X_{P,\kappa}^{(2)}} = -2\sqrt{-1}\int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr}\left(F_{\beta_P}^{\dagger}(\mathbf{V}_{\kappa,t}'(\tau)^{0,1})_{h_t}^{\dagger}\right).$$

By using Lemma 3.54 below, we obtain

$$\int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr} \left( F_{\beta_P}^{\dagger} (\mathbf{V}_{\kappa,t}'(\tau)^{0,1})_{h_t}^{\dagger} \right) = \int_{\partial \Sigma_{\theta \mid X_{P,\kappa}^{(2)}}} \beta_P \overline{\tau} + O\left( e^{-8\kappa t} \| \tau \|_{L^2}^2 \right) = \int_{\Sigma_{\theta \mid X_{P,\kappa}^{(2)}}} \tau \overline{\tau} + O\left( e^{-8\kappa t} \| \tau \|_{L^2}^2 \right).$$

In all, we obtain Proposition 3.37.

# 3.5.8 Proof of Proposition 3.38

As before, we obtain

$$(\mathbf{H}_{t}(\nu),\mathbf{V}_{t}(\tau))_{L^{2},h_{t}} = (\mathbf{H}_{\kappa,t}'(\nu),\mathbf{V}_{\kappa,t}'(\tau))_{L^{2},h_{t}} + O(e^{-8\kappa t} \cdot \|\nu\|_{L^{2}} \cdot \|\tau\|_{L^{2}}).$$

By the construction, we have  $(\mathsf{H}'_{\kappa,t}(\nu)^{0,1})^{\circ} = 0$  and  $(\mathsf{V}'_{\kappa,t}(\tau)^{1,0})^{\circ} = 0$ . Hence, we obtain the following by using Lemma 3.53 below:

$$\left(\mathsf{H}_{\kappa,t}'(\nu),\mathsf{V}_{\kappa,t}'(\tau)\right)_{L^{2},h_{t},W_{\kappa}}=O\left(e^{-8\kappa t}\|\tau\|_{L^{2}}\|\nu\|_{L^{2}}\right).$$

On  $X_{P,\kappa}^{(2)}$ , we have  $\mathtt{H}'_{\kappa,t}(\nu) = \mathtt{H}_{P,t}(\kappa)$ . To study  $(\mathtt{H}_{P,t}(\nu), \mathtt{V}'_{\kappa,t}(\tau))_{L^2,h_t,X_{P,\kappa}^{(2)}}$ , we prepare the following lemma.

#### Lemma 3.52

$$\left(\mathbf{I}_{P,t}(\nu), \mathbf{V}_{\kappa,t}'(\tau)\right)_{L^{2}, h_{t}, X_{P,\kappa}^{(2)}} = \langle \nu, \overline{\tau} \rangle_{P, h_{t}}^{\mathrm{aux}} + O\left(e^{-8\kappa t} \|\nu\|_{L^{2}} \cdot \|\tau\|_{L^{2}}\right).$$
(58)

**Proof** By (54) and Lemma 3.55 below, we have

$$\left(\mathbf{I}_{P,t}(\nu),\mathbf{V}_{\kappa,t}'(\tau)\right)_{L^{2},h_{t},X_{P,\kappa}^{(2)}}=2\sqrt{-1}\int_{\partial X_{P,\kappa}^{(2)}}\mathrm{Tr}\left(\left(t^{-1}\alpha_{1}M_{P,1,t}\right)\cdot\partial_{h_{t}}F_{\overline{\beta}_{P}}\right).$$

On  $\partial X_{P,\kappa}^{(2)}$ , we have  $\left(\partial_{h_t} F_{\overline{\beta}_P}\right)^{\perp} = O\left(e^{-4\kappa t} \|\tau\|_{L^2}\right)$ . We also have  $\left(\partial_{h_t} F_{\overline{\beta}_P}\right)^{\circ} = F_{d\overline{\beta}_P}$ . Hence, we obtain

$$\int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr}\left((t^{-1}\alpha_1 M_{P,1,t})^{\circ} (\partial_{h_t} F_{\overline{\beta}_P})^{\circ}\right) = \int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr}\left(t^{-1}\alpha_1 F_{v_{P,t}} F_{d\overline{\beta}_P}\right) = \int_{\partial \Sigma_{\theta|X_{P,\kappa}^{(2)}}} t^{-1}\alpha_1 v_{P,t} d\overline{\beta}_P \\
= 2\pi \sqrt{-1} \left((\partial_{\xi_P} \alpha_P) \cdot (\xi_P v_{P,t}) \cdot (\partial_{\xi_P} \overline{\beta}_P)\right)_{|\xi_P=0}. \quad (59)$$

Because  $\eta_t = \frac{2^3}{3^2} \xi_P v_{P,t} d\xi_P$  and  $\phi_P^{1/2} = \frac{2^3}{3^2} \xi_P^2 d\xi_P$ , the following holds on  $\Sigma_{\theta|X_P(\kappa_0)}$ :

$$\nu \cdot \overline{\tau} \cdot \eta_t \cdot (\phi^{1/2})^{-1} = \left( (\partial_{\xi_P} \alpha_P) \cdot (\partial_{\xi_P} \overline{\beta}_P) \cdot (\xi_P \upsilon_{P,t}) \right) \left( \frac{d\xi_P}{\xi_P} \right)^2.$$

Then, we obtain the estimate (58).

By Lemma 3.52, we obtain the following:

$$\left(\mathbb{H}_{P,t}(\nu), \mathbb{V}_{\kappa,t}'(\tau)\right)_{L^{2}, h_{t}, X_{P,\kappa}^{(2)}} = \langle \nu, \overline{\tau} \rangle_{P, h_{t}}^{\mathrm{aux}} + \left(\widetilde{\mathbb{H}}_{P,t}(\nu), \mathbb{V}_{\kappa,t}'(\tau)\right)_{L^{2}, h_{t}, X_{P,\kappa}^{(2)}} + O\left(e^{-8\kappa t} \|\nu\|_{L^{2}} \cdot \|\tau\|_{L^{2}}\right).$$
(60)

By Lemma 3.55 below, we obtain

$$\left(\widetilde{\mathsf{H}}_{P,t}(\nu),\mathsf{V}_{\kappa,t}'(\tau)\right)_{L^{2},h_{t},X_{P,\kappa}^{(2)}} = 2\sqrt{-1}\int_{\partial X_{P,\kappa}^{(2)}} \operatorname{Tr}\left(F_{\alpha}\cdot(\mathsf{V}_{\kappa,t}'(\nu)^{1,0})_{h_{t}}^{\dagger}\right)$$

We have

$$\operatorname{Tr}\left(F_{\alpha}\cdot(\mathbf{V}_{\kappa,t}'(\nu)^{1,0})_{h_{t}}^{\dagger}\right) = \operatorname{Tr}\left(F_{\alpha}\cdot[\theta_{h_{t}}^{\dagger},F_{\overline{\beta}}]\right) = \operatorname{Tr}\left(\theta^{\dagger}[F_{\overline{\beta}},F_{\alpha}]\right) = 0.$$

Thus, we obtain Proposition 3.38.

# 3.6 Appendix

# 3.6.1 The error terms for metrics

Let  $\gamma > 0$ . Let  $A_t^{(\ell)}$   $(\ell = 1, 2, t \ge 1)$  be  $2 \times 2$ -matrices. We assume that

- $|(A_t^{(\ell)})_{i,j}| = O(e^{-\gamma t}) \ (i \neq j).$
- $(A_t^{(\ell)})_{i,i} = \alpha_i^{(\ell)} + O(e^{-2\gamma t})$  for some complex numbers  $\alpha_i^{(\ell)}$ .

Let  $H_t$   $(t \ge 1)$  be Hermitian matrices. We set  $B_t = H_t - I_2$ . Assume the following condition.

•  $|B_t| = O(e^{-\gamma t}).$ 

Lemma 3.53 We have

$$\operatorname{Tr}(A^{(1)}(A^{(2)}_t)_{H_t}^{\dagger}) = \alpha_1^{(1)} \overline{\alpha_1^{(2)}} + \alpha_2^{(1)} \overline{\alpha_2^{(2)}} + O(e^{-2\gamma t}).$$

In particular, we have

$$|A_t^{(1)}|_{H_t}^2 = \operatorname{Tr}(A_t^{(1)}(A_t^{(1)})_{H_t}^{\dagger}) = |\alpha_1^{(1)}|^2 + |\alpha_2^{(1)}|^2 + O(e^{-2\gamma t}).$$

**Proof** We have

$$(A_t^{(2)})_{H_t}^{\dagger} = \overline{H}_t^{-1} \overline{A}_t^{(2)} \cdot \overline{H}_t = \overline{A}_t^{(2)} + [\overline{A}_t^{(2)}, \overline{B}_t] + O(e^{-2\gamma t}).$$

We note that  $[{}^{t}\overline{A}_{t}^{(2)}, \overline{B}_{t}]_{i,i} = O(e^{-2\gamma t})$  (i = 1, 2) and  $[{}^{t}\overline{A}_{t}^{(2)}, \overline{B}_{t}]_{i,j} = O(e^{-\gamma t})$   $(i \neq j)$ . As a result, we obtain the claim of the lemma.

# 3.6.2 A variant

Let  $H_t$  be a family of Hermitian matrices such that  $B_t = H_t - I_2 = O(e^{-\gamma t})$ . We set

$$B_t = \left(\begin{array}{cc} a_t & b_t \\ \overline{b}_t & c_t \end{array}\right).$$

We assume  $det(H_t) = 1$ . We set

$$\Pi_1 = \left(\begin{array}{cc} 1 & 0\\ 0 & 0 \end{array}\right), \qquad \Pi_2 = \left(\begin{array}{cc} 0 & 0\\ 0 & 1 \end{array}\right).$$

We have

$$(\Pi_1)_{H_t}^{\dagger} = \overline{H}_t^{-1} \Pi_1 \overline{H}_t = \Pi_1 + [\Pi_1, \overline{B}_t] + O(e^{-2\gamma t}) = \Pi_1 + \begin{pmatrix} 0 & \overline{b}_t \\ -b_t & 0 \end{pmatrix} + O(e^{-2\gamma t})$$

We also have

$$(\Pi_2)_{H_t}^{\dagger} = \Pi_2 + \begin{pmatrix} 0 & -\overline{b}_t \\ b_t & 0 \end{pmatrix} + O(e^{-2\gamma t})$$

Let  $\alpha_i, \beta_i \in \mathbb{C}$  (i = 1, 2). We set

$$G_t = \alpha_1 \Pi_1 + \alpha_2 \Pi_2 + \beta_1 (\Pi_1)_{H_t}^{\dagger} + \beta_2 (\Pi_2)_{H_t}^{\dagger} = \begin{pmatrix} \alpha_1 + \beta_1 & (\beta_1 - \beta_2)\overline{b}_t \\ (\beta_2 - \beta_1)b_t & \alpha_2 + \beta_2 \end{pmatrix} + O(e^{-2\gamma t}).$$

Lemma 3.54 We obtain

$$\left|G_t\right|_{H_t}^2 = |\alpha_1 + \beta_1|^2 + |\alpha_2 + \beta_2|^2 + O(e^{-2\gamma t}).$$

**Proof** It follows from Lemma 3.53.

# **3.6.3** *L*<sup>2</sup>-product

Let  $(E, \overline{\partial}_E, \theta)$  be a Higgs bundle on a compact Riemann surface X. Let  $W \subset X$  be an open subset. Let h be a harmonic metric. Let  $\rho_i = \rho_i^{1,0} + \rho_i^{0,1}$  (i = 1, 2) be  $C^{\infty}$ -sections of  $\operatorname{End}(E) \otimes \Omega^{1,0} \oplus \operatorname{End}(E) \otimes \Omega^{0,1}$ . We set

$$(\rho_1, \rho_2)_{L^2, h, W} = 2\sqrt{-1} \int_W \operatorname{Tr} \left( \rho_1^{1,0} (\rho_2^{1,0})^{\dagger} - \rho_1^{0,1} (\rho_2^{0,1})^{\dagger} \right).$$

Let  $\rho_i$  (i = 1, 2) be  $C^{\infty}$ -sections of  $\operatorname{End}(E)$ . Let  $g_X$  be a Kähler metric of X. Let  $\operatorname{dvol}_{g_X}$  be the volume form. For any  $W \subset X$ , we set

$$(\rho_1, \rho_2)_{L^2, h, g_X, W} = \int_W \operatorname{Tr}\left(\rho_1 \cdot (\rho_2)_h^{\dagger}\right) \operatorname{dvol}_{g_X}$$

If W = X,  $(\rho_1, \rho_2)_{L^2,h,X}$  and  $(\rho_1, \rho_2)_{L^2,h,g_X,X}$  are denoted by  $(\rho_1, \rho_2)_{L^2,h}$  and  $(\rho_1, \rho_2)_{L^2,h,g_X}$ . We set  $\|\rho\|_{L^2,h} = \sqrt{(\rho, \rho)_{L^2,h}}$  or  $\|\rho\|_{L^2,h} = \sqrt{(\rho, \rho)_{L^2,h,g_X}}$ .

#### 3.6.4 Stokes formula

Let  $(E, \overline{\partial}_E, \theta, h)$  be a harmonic bundle on X. Let a be a  $C^{\infty}$ -section of  $\operatorname{End}(E)$  and  $b = b^{1,0} + b^{0,1}$  be a  $C^{\infty}$   $\operatorname{End}(E)$ -valued 1-form.

Lemma 3.55 The following holds:

$$\operatorname{Tr}\left(\partial_{E,h}a \wedge (b^{1,0})_{h}^{\dagger} - [\theta_{h}^{\dagger}, a] \wedge (b^{0,1})_{h}^{\dagger}\right) = \partial \operatorname{Tr}(a(b^{1,0})^{\dagger}) - \operatorname{Tr}\left(a \cdot (\overline{\partial}_{E} + \operatorname{ad} \theta)b\right).$$
(61)

$$\operatorname{Tr}\left([\theta, a] \wedge (b^{1,0})_{h}^{\dagger} - \overline{\partial}a \wedge (b^{0,1})_{h}^{\dagger}\right) = -\overline{\partial}\operatorname{Tr}(a(b^{0,1})_{h}^{\dagger}) + \operatorname{Tr}\left(a\left((\partial_{E,h} + \operatorname{ad}\theta_{h}^{\dagger})b\right)_{h}^{\dagger}\right).$$
(62)

**Proof** We have

$$\operatorname{Tr}(\partial a \wedge (b^{1,0})_h^{\dagger}) = \partial \operatorname{Tr}(a(b^{1,0})_h^{\dagger}) - \operatorname{Tr}(a \wedge (\overline{\partial} b^{1,0})_h^{\dagger})$$

We have

$$\operatorname{Tr}\left(\left[\theta_{h}^{\dagger},a\right]\wedge\left(b^{0,1}\right)_{h}^{\dagger}\right)=\operatorname{Tr}\left(\left(\theta_{h}^{\dagger}a-a\theta_{h}^{\dagger}\right)\wedge\left(b^{0,1}\right)_{h}^{\dagger}\right)=-\operatorname{Tr}\left(a\left[\theta_{h}^{\dagger},\left(b^{0,1}\right)_{h}^{\dagger}\right]\right)=\operatorname{Tr}\left(a\left[\theta,b^{0,1}\right]_{h}^{\dagger}\right).$$

Thus, we obtain (61). We obtain (62) similarly.

**Corollary 3.56** Let  $W \subset X$  be a relatively compact open subset with smooth boundary. Then, the following holds.

$$\left(\left(\partial_{E,h} + \operatorname{ad} \theta_{h}^{\dagger}\right)a, b\right)_{L^{2},h,W} = 2\sqrt{-1} \int_{\partial W} \operatorname{Tr}\left(a(b^{1,0})_{h}^{\dagger}\right) + \left(a, \left(\partial_{E,h} + \operatorname{ad} \theta_{h}^{\dagger}\right)_{h,g_{X}}^{*}b\right)_{L^{2},h,g_{X},W},\tag{63}$$

$$\left(\left(\overline{\partial}_E + \operatorname{ad}\theta\right)a, b\right)_{L^2, h, W} = -2\sqrt{-1} \int_{\partial W} \operatorname{Tr}\left(a(b^{0,1})_h^\dagger\right) + \left(a, \left(\overline{\partial}_E + \operatorname{ad}\theta\right)_{h, g_X}^* b\right)_{L^2, h, g_X, W}.$$
(64)
