# THE ZETA-DETERMINANTS AND ANLAYTIC TORSION OF A METRIC MAPPING TORUS

ABSTRACT. We use the BFK-gluing formula for zeta-determinants to compute the zeta-determinant and analytic torsion of a metric mapping torus induced from an isometry. As applications, we compute the zeta-determinants of the Laplacians defined on a Klein bottle  $\mathbb{K}$  and some compact co-Kähler manifold  $\mathbb{T}_{\varphi}$ . We also show that a metric mapping torus and a Riemannian product manifold with a round circle have the same heat trace asymptotic expansions. We finally compute the analytic torsion of a metric mapping torus for the Witten deformed Laplacian and recover the result of J. Marcsik in [16].

### 1. INTRODUCTION

Let M be a compact oriented (m-1)-dimensional manifold and  $\varphi: M \to M$  be a diffeomorphism.  $\varphi$ may be an orientation preserving or reversing map. For a > 0, we define a mapping torus  $M_{\varphi}$  by

$$M_{\varphi} = M \times [0, a]/(x, 0) \sim (\varphi(x), a).$$
 (1.1)

Equivalently, we define a  $\mathbb{Z}$ -action on  $M \times \mathbb{R}$  by

$$\mathbb{Z} \times (M \times \mathbb{R}) \to M \times \mathbb{R}, \qquad m \cdot (x, u) = (\varphi^m(x), u + ma).$$

This action is properly discontinuous and  $M_{\varphi}$  is defined to be the quotient space. In fact,  $M_{\varphi}$  is a fiber bundle over  $S^1$  and every fiber bundle over  $S^1$  is obtained in this way. It is well known that  $M_{\varphi}$  is a trivial bundle if and only if  $\varphi$  is isotopic to the identity. To endow a Riemannian metric on  $M_{\varphi}$ , we are going to consider a more specific case called a metric mapping torus ([1]). Metric mapping tori play important roles in the study of the co-symplectric and co-Kähler manifolds ([2], [3], [7], [15], [17]), which are odd-dimensional analogues of symplectic and Kähler manifolds.

**Definition 1.1.** Let  $(M, g^M)$  be a compact oriented (m - 1)-dimensional Riemannian manifold and  $\varphi : (M, g^M) \to (M, g^M)$  be an isometry. A mapping torus  $M_{\varphi}$  induced from the Riemannian product  $[0, a] \times M$  is called a metric mapping torus.

A metric mapping torus  $M_{\varphi}$  has a natural Riemannian metric and in this paper a mapping torus means a metric mapping torus. We denote by  $\Omega^q(M_{\varphi})$  the space of smooth q-forms and by  $\Delta^q_{M_{\varphi}}$  the Hodge Laplacian acting on  $\Omega^q(M_{\varphi})$ . Equivalently,  $\Omega^q(M_{\varphi})$  and  $\Delta^q_{M_{\varphi}}$  are defined in the following way. We define a map

$$F: M \times \mathbb{R} \to M \times \mathbb{R}, \qquad F(x, u) = (\varphi(x), u + a)$$

$$(1.3)$$

Then,  $\Omega^q(M_{\varphi})$  is identified with

$$\Omega^{q}_{\varphi}(M \times \mathbb{R}) := \{ \omega \in \Omega^{q}(M \times \mathbb{R}) \mid F^{*}\omega = \omega \},$$

and  $\Delta_{M_{\varphi}}^{q}$  is identified with  $-\frac{d^{2}}{dt^{2}} + \Delta_{M}^{q-1}$  acting on  $\Omega_{\varphi}^{q}(M \times \mathbb{R})$ . The zeta function  $\zeta_{\Delta_{M_{\varphi}}^{q}}(s)$  associated to  $\Delta_{M_{\varphi}}^{q}$  is defined by

$$\zeta_{\Delta_{M_{\varphi}}^{q}}(s) = \sum_{0 \neq \lambda_{j} \in \operatorname{Spec}(\Delta_{M_{\varphi}}^{q})} \lambda_{j}^{-s} = \frac{1}{\Gamma(s)} \int_{0}^{\infty} t^{s-1} \left( \operatorname{Tr} e^{-t\Delta_{M_{\varphi}}^{q}} - \dim \ker \Delta_{M_{\varphi}}^{q} \right) dt, \quad (1.5)$$

which is holomorphic for  $\Re s > \frac{m}{2}$  and has a meromorphic continuation to the whole complex plane  $\mathbb{C}$  having a regular value at s = 0. If dim ker  $\Delta_{M_{\varphi}}^{q} = 0$ , the zeta-determinant  $\text{Det } \Delta_{M_{\varphi}}^{q}$  is defined by

$$\log \operatorname{Det} \Delta^{q}_{M_{\varphi}} := -\zeta'_{\Delta^{q}_{M_{\varphi}}}(0).$$

If ker  $\Delta^q_{M_{\varphi}}$  is non-trivial, the modified zeta-determinant  $\text{Det}^* \Delta^q_{M_{\varphi}}$  is defined by the same way, *i.e.* log  $\text{Det}^* \Delta^q_{M_{\varphi}} := -\zeta'_{\Delta^q_{M_{\varphi}}}(0)$ , but we use the upper star to distinguish it from the invertible case. The analytic torsion  $T(M_{\varphi})$  is defined by

$$\log T(M_{\varphi}) := \frac{1}{2} \sum_{q=0}^{m} (-1)^{q+1} q \log \operatorname{Det}^* \Delta_{M_{\varphi}}^q.$$

If  $\varphi = \text{Id}$ , it is easily seen that  $M_{\text{Id}} = M \times S^1(\frac{a}{2\pi})$ , where  $S^1(r)$  is the round circle of radius r. In this paper, we are going to use the BFK-gluing formula for zeta-determinants ([4], [8]) to describe  $\log \text{Det} \Delta_{M_{\varphi}}^{q} - \log \text{Det} \Delta_{M_{\text{Id}}}^{q}$  by a Fredholm determinant of some trace class operator defined on M and determined by  $\varphi$ . By using the product formula of the zeta-determinants given in Theorem 7.1 of [9], we can eventually compute  $\log \text{Det} \Delta_{M_{\varphi}}^{q}$ . As applications, we compute the zeta-determinants of the scalar Laplacians defined on a Klein bottle  $\mathbb{K}$  and some non-product compact co-Kähler manifold  $\mathbb{T}_{\varphi}$  given in [7]. We also prove that a metric mapping torus and a Riemannian product manifold with a round circle have the same heat trace asymptotic expansions. We finally apply this result to compute the analytic torsion of  $M_{\varphi}$  for the Witten deformed Laplacian and recover the result given by J. Marcsik in [16] and D. Burghelea and S. Haller in [5]. In fact, D. Burghelea and S. Haller proved a more general result but we here present an elementary computation with a stronger assumption.

### 2. The zeta-determinants of Laplacians on a metric mapping torus

In this section we use the BKF-gluing formula to express  $\log \operatorname{Det} \Delta_{M_{\varphi}}^{q} - \log \operatorname{Det} \Delta_{M_{\mathrm{Id}}}^{q}$  in terms of a Fredholm determinant of some trace class operator defined on M. We begin with  $\Delta_{M_{\varphi}}^{q} + \lambda + \mu$  rather than  $\Delta_{M_{\varphi}}^{q}$  for  $0 \leq \lambda, \mu \in \mathbb{R}$ , where  $\lambda$  is a fixed real number and  $\mu$  is a parameter. On the  $S^{1}$ -bundle  $p: M_{\varphi} \to S^{1}$ , let  $\frac{d}{d\theta}$  and  $d\theta$  be the standard unit vector field and one form on  $S^{1}$  and let  $\frac{\partial}{\partial u}$  and du be the liftings of  $\frac{d}{d\theta}$  and  $d\theta$  on  $M_{\varphi}$ . Then, for  $(x, t) \in M_{\varphi}$  a q-form  $\omega$  on  $M_{\varphi}$  can be expressed by

$$\omega_{(x,t)} = \alpha_{(x,t)} + du \wedge \beta_{(x,t)}, \qquad (2.1)$$

where  $\alpha_{(x,t)} \in \wedge^q T_{(x,t)} M_{\varphi}$  and  $\beta_{(x,t)} \in \wedge^{q-1} T_{(x,t)} M_{\varphi}$  with  $\iota_{\frac{\partial}{\partial u}} \alpha_{(x,t)} = \iota_{\frac{\partial}{\partial u}} \beta_{(x,t)} = 0$ . For simplicity, we write x := (x, 0) for  $x \in M$ . We note that  $M \times \{0\}$  is a submanifold of  $M_{\varphi}$  and that

$$M_{\varphi} - M \times \{0\} = M_{\varphi} - M \times \{a\} = M \times (0, a), \qquad (2.2)$$

and  $M \times \{0\}$  and  $M \times \{a\}$  are identified by  $(x, 0) \sim (\varphi(x), a)$ , where  $\varphi : M \to M$  is an isometry. This shows that for a smooth vector field X on M and  $x \in M$ , X(x) is a vector in  $T_{(x,0)}M_{\varphi}$  and can be identified with  $\varphi_*X(x) \in T_{(\varphi(x),a)}M_{\varphi}$ . For  $\alpha \in \Omega^q(M)$  and  $x \in M$ ,  $\alpha_x$  is a q-form at  $(x, 0) \in M_{\varphi}$ , *i.e.*  $\alpha_x \in \wedge^q T^*_{(x,0)}M_{\varphi}$ . For smooth vector fields  $X_1, \cdots, X_q$  on M and  $x \in M$ , the vectors  $X_1(x), \cdots, X_q(x)$ in  $T_{(x,0)}M_{\varphi}$  are identified with  $\varphi_*X_1(x), \cdots, \varphi_*X_q(x)$  in  $T_{(\varphi(x),a)}M_{\varphi}$ . Since

$$\left((\varphi^{-1})^*\alpha_x\right)(\varphi_*X_1(x),\cdots,\varphi_*X_q(x)) = \alpha_x\left(X_1(x),\cdots,X_q(x)\right),$$
(2.3)

it follows that  $\alpha_x \in \wedge^q T^*_{(x,0)} M_{\varphi}$  is identified with  $(\varphi^{-1})^* \alpha_x \in \wedge^q T^*_{(\varphi(x),a)} M_{\varphi}$ . Hence, for  $\alpha \in \Omega^q(M)$  and  $\beta \in \Omega^{q-1}(M), \ \omega_x := \alpha_x + du \wedge \beta_x \in \wedge^q T^*_{(x,0)} M_{\varphi}$  is identified with

$$(\varphi^{-1})^*\omega_x = (\varphi^{-1})^*\alpha_x + du \wedge (\varphi^{-1})^*\beta_x \in \wedge^q T^*_{(\varphi(x),a)}M_{\varphi}.$$
(2.4)

For  $u \in \mathbb{R}$ , we identify  $\Omega^q(M_{\varphi})|_{M \times \{u\}}$  with  $\Omega^q(M) \oplus \Omega^{q-1}(M)$ . We define  $\widetilde{\Delta}^q_M$ ,  $(\widetilde{\varphi}^*)_q$  and  $((\widetilde{\varphi}^{-1})^*)_q$  as follows.

$$\widetilde{\Delta}_{M}^{q}, \ (\widetilde{\varphi}^{i})_{q}^{*} : \ \Omega^{q}(M) \oplus \Omega^{q-1}(M) \to \ \Omega^{q}(M) \oplus \Omega^{q-1}(M),$$

$$\widetilde{\Delta}_{M}^{q} = \begin{pmatrix} \Delta_{M}^{q} & 0 \\ 0 & \Delta_{M}^{q-1} \end{pmatrix}, \quad (\widetilde{\varphi}^{i})_{q}^{*} = \begin{pmatrix} (\varphi^{i})_{q}^{*} & 0 \\ 0 & (\varphi^{i})_{q-1}^{*} \end{pmatrix}, \quad i = \pm 1,$$
(2.5)

where  $(\varphi^i)_q^* : \Omega^q(M) \to \Omega^q(M)$  is the pull-back of q-forms with respect to  $\varphi$  or  $\varphi^{-1}$ . For  $(\alpha, \beta) \in \Omega^q(M) \oplus \Omega^{q-1}(M)$ , we embed  $(\alpha, \beta)$  to  $\wedge^q T^*_{(x,0)} M_{\varphi}$  and  $\wedge^q T^*_{(\varphi(x),a)} M_{\varphi}$  by

$$\omega_x := \alpha_x + du \wedge \beta_x \in \wedge^q T^*_{(x,0)} M_{\varphi}, \quad (\varphi^{-1})^* \omega_x = (\varphi^{-1})^* \alpha_x + du \wedge (\varphi^{-1})^* \beta_x \in \wedge^q T^*_{(\varphi(x),a)} M_{\varphi}.$$
(2.6)

Let  $\widetilde{\omega} \in \Omega^q(M \times [0, a])$  be an arbitrary extension of  $\omega_x$  and  $(\varphi^{-1})^* \omega_x$  to  $M \times [0, a]$ . We define  $\psi(x, u) \in \Omega^q(M \times [0, a])$  by

$$\psi(x,u) = \widetilde{\omega} - \left(-\frac{d^2}{du^2} + \left(\widetilde{\Delta}_M^q + \lambda + \mu\right)\right)_{\mathrm{D}}^{-1} \left(-\frac{d^2}{du^2} + \left(\widetilde{\Delta}_M^q + \lambda + \mu\right)\right)\widetilde{\omega},$$

where "D" stands for the Dirichlet boundary condition. Then  $\psi(x, u)$  satisfies the following properties.

$$\left(-\frac{d^2}{du^2} + \left(\widetilde{\Delta}_M^q + \lambda + \mu\right)\right)\psi(u, x) = 0, \qquad \psi(x, 0) = \omega_x, \quad \psi(\varphi(x), a) = (\varphi^{-1})^*\omega_x.$$

**Definition 2.1.** For  $0 \leq \lambda$ ,  $\mu \in \mathbb{R}$ , we define the Dirichlet-to-Neumann operator

$$R^{q}_{\omega}(\lambda+\mu):\Omega^{q}(M)\oplus\Omega^{q-1}(M)\to\Omega^{q}(M)\oplus\Omega^{q-1}(M)$$

by

$$R^{q}_{\varphi}(\lambda+\mu)(\alpha,\beta) = \varphi^{*}\left(\frac{\partial}{\partial u}\psi(\varphi(x),a)\right) - \frac{\partial}{\partial u}\psi(x,0) \in \Omega^{q}(M) \oplus \Omega^{q-1}(M),$$

where we identify  $\frac{\partial}{\partial u}\psi(\varphi(x),a) \in \wedge^q T^*_{(\varphi(x),a)}M_{\varphi}$  with  $\varphi^*\left(\frac{\partial}{\partial u}\psi(\varphi(x),a)\right) \in \wedge^q T^*_{(x,0)}M_{\varphi}$  and identify  $A + du \wedge B$  with  $(A,B) \in \Omega^q(M) \oplus \Omega^{q-1}(M)$ .

It is well known that  $R^q_{\varphi}(\lambda + \mu)$  is a non-negative elliptic pseudodifferential operator of order 1 with the principal symbol  $\sigma_L(R^q_{\varphi}(\lambda + \mu))(x,\xi) = 2\sqrt{\|\xi\|^2 + \lambda + \mu}$ . We now compute  $R^q_{\varphi}(\lambda + \mu)$  precisely. Let  $\alpha \in \Omega^q(M)$  or  $\alpha \in \Omega^{q-1}(M)$  with  $\Delta_M \alpha = \nu^2 \alpha$ . We suppose that  $\alpha \in \Omega^q(M)$  and  $\omega_x = \alpha_x$ . Then, the solution to (2.7) is given by

$$\psi(x,u) = \frac{e^{-\sqrt{\nu^2 + \lambda + \mu}(u-a)} - e^{\sqrt{\nu^2 + \lambda + \mu}(u-a)}}{e^{a\sqrt{\nu^2 + \lambda + \mu}} - e^{-a\sqrt{\nu^2 + \lambda + \mu}}} \alpha_x + \frac{e^{u\sqrt{\nu^2 + \lambda + \mu}} - e^{-u\sqrt{\nu^2 + \lambda + \mu}}}{e^{a\sqrt{\nu^2 + \lambda + \mu}} - e^{-a\sqrt{\nu^2 + \lambda + \mu}}} \left( (\varphi^{-1})^* \alpha \right)_x.$$
(2.8)

Hence,

$$\frac{\partial}{\partial u}\psi(x,u) = \tag{2.9}$$

$$\sqrt{\nu^2 + \lambda + \mu} \left\{ -\frac{e^{-\sqrt{\nu^2 + \lambda + \mu}(u-a)} + e^{\sqrt{\nu^2 + \lambda + \mu}(u-a)}}{e^{a\sqrt{\nu^2 + \lambda + \mu}} - e^{-a\sqrt{\nu^2 + \lambda + \mu}}} \alpha_x + \frac{e^{u\sqrt{\nu^2 + \lambda + \mu}} + e^{-u\sqrt{\nu^2 + \lambda + \mu}}}{e^{a\sqrt{\nu^2 + \lambda + \mu}} - e^{-a\sqrt{\nu^2 + \lambda + \mu}}} \left( (\varphi^{-1})^* \alpha \right)_x \right\},$$

which yields

$$\begin{aligned} \frac{\partial}{\partial u}\psi(x,0) &= \frac{\sqrt{\nu^2 + \lambda + \mu}}{e^{a\sqrt{\nu^2 + \lambda + \mu}} - e^{-a\sqrt{\nu^2 + \lambda + \mu}}} \left( -\left(e^{a\sqrt{\nu^2 + \lambda + \mu}} + e^{-a\sqrt{\nu^2 + \lambda + \mu}}\right)\alpha_x + 2\left((\varphi^{-1})^*\alpha\right)_x \right), \\ \frac{\partial}{\partial u}\psi(\varphi(x),a) &= \frac{\sqrt{\nu^2 + \lambda + \mu}}{e^{a\sqrt{\nu^2 + \lambda + \mu}} - e^{-a\sqrt{\nu^2 + \lambda + \mu}}} \left( -2\alpha_{\varphi(x)} + \left(e^{a\sqrt{\nu^2 + \lambda + \mu}} + e^{-a\sqrt{\nu^2 + \lambda + \mu}}\right)\left((\varphi^{-1})^*\alpha\right)_{\varphi(x)} \right) \\ &= \left(\varphi^{-1}\right)^* \left\{ \frac{\sqrt{\nu^2 + \lambda + \mu}}{e^{a\sqrt{\nu^2 + \lambda + \mu}} - e^{-a\sqrt{\nu^2 + \lambda + \mu}}} \left( -2\left(\varphi^*\alpha\right)_x + \left(e^{a\sqrt{\nu^2 + \lambda + \mu}} + e^{-a\sqrt{\nu^2 + \lambda + \mu}}\right)\alpha_x \right) \right\}. \end{aligned}$$

This leads to the following result.

$$R^{q}_{\varphi}(\lambda+\mu) \alpha(x) = \varphi^{*} \left( \frac{\partial}{\partial u} \psi(\varphi(x),a) \right) - \frac{\partial}{\partial u} \psi(x,0)$$

$$= \left( -\frac{2\sqrt{\nu^{2}+\lambda+\mu}}{e^{a\sqrt{\nu^{2}+\lambda+\mu}} - e^{-a\sqrt{\nu^{2}+\lambda+\mu}}} \left(\varphi^{*}\alpha\right)_{x} + \sqrt{\nu^{2}+\lambda+\mu} \frac{e^{a\sqrt{\nu^{2}+\lambda+\mu}} + e^{-a\sqrt{\nu^{2}+\lambda+\mu}}}{e^{a\sqrt{\nu^{2}+\lambda+\mu}} - e^{-a\sqrt{\nu^{2}+\lambda+\mu}}} \alpha_{x} \right)$$

$$- \left( -\sqrt{\nu^{2}+\lambda+\mu} \frac{e^{a\sqrt{\nu^{2}+\lambda+\mu}} + e^{-a\sqrt{\nu^{2}+\lambda+\mu}}}{e^{a\sqrt{\nu^{2}+\lambda+\mu}} - e^{-a\sqrt{\nu^{2}+\lambda+\mu}}} \alpha_{x} + \frac{2\sqrt{\nu^{2}+\lambda+\mu}}{e^{a\sqrt{\nu^{2}+\lambda+\mu}} - e^{-a\sqrt{\nu^{2}+\lambda+\mu}}} \left( (\varphi^{-1})^{*}\alpha \right)_{x} \right)$$

$$= 2\sqrt{\nu^{2}+\lambda+\mu} \frac{e^{a\sqrt{\nu^{2}+\lambda+\mu}} - 1}}{e^{a\sqrt{\nu^{2}+\lambda+\mu}} + 1} \left\{ \alpha_{x} + \frac{2e^{a\sqrt{\nu^{2}+\lambda+\mu}}}{\left(e^{a\sqrt{\nu^{2}+\lambda+\mu}} - 1\right)^{2}} \left( \alpha_{x} - \left( \frac{(\varphi^{*}\alpha)_{x} + ((\varphi^{-1})^{*}\alpha)_{x}}{2} \right) \right) \right\}.$$
(2.10)

Remark 2.2. If  $\lambda = \mu = 0$  and  $\nu = 0$ , then  $\psi(x, u)$  and  $R^q_{\varphi}(0)\alpha(x)$  are given by

$$\psi(x,u) = \frac{1}{a} \left( \left( (\varphi^{-1})^* \alpha \right)_x - \alpha_x \right) u + \alpha_x, \qquad R_{\varphi}^q(0) \alpha(x) = \frac{2}{a} \left( \alpha_x - \frac{(\varphi^* \alpha)_x + \left( (\varphi^{-1})^* \alpha \right)_x}{2} \right).$$

The following lemma is well known (for example, Lemma 3.2 in [10]).

**Lemma 2.3.** For a positive definite elliptic pseudodifferential operator A of positive order and a nonnegative trace class operator Q, the following equality holds.

$$\log \operatorname{Det} A(I+Q) = \log \operatorname{Det} A + \log \operatorname{det}_{Fr}(I+Q).$$

We have the following result.

**Lemma 2.4.** The Dirichlet-to-Neumann operator  $R^q_{\varphi}(\lambda + \mu) : \Omega^q(M) \oplus \Omega^{q-1}(M) \to \Omega^q(M) \oplus \Omega^{q-1}(M)$  is described as follows.

$$R^q_{\varphi}(\lambda + \mu) =$$

$$2\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu} \frac{e^{a\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu}}-\mathrm{Id}}{e^{a\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu}}+\mathrm{Id}} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu}}}{\left(e^{a\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu}}-\mathrm{Id}\right)^{2}} \left( \mathrm{Id} - \frac{1}{2}\widetilde{\varphi}_{q}^{*} - \frac{1}{2}(\widetilde{\varphi}^{-1})_{q}^{*} \right) \right\}.$$

In particular, if  $\varphi = \text{Id}$ , then

$$R_{\mathrm{Id}}^{q}(\lambda+\mu) = 2\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu} \frac{e^{a\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu}}-\mathrm{Id}}{e^{a\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu}}+\mathrm{Id}} = 2\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu} \left(\mathrm{Id}-\frac{2}{e^{a\sqrt{\widetilde{\Delta}_{M}^{q}+\lambda+\mu}}+\mathrm{Id}}\right),$$

which shows that for  $\lambda + \mu > 0$ ,

$$\log \operatorname{Det} R^{q}_{\varphi}(\lambda + \mu) = \log \operatorname{Det} R^{q}_{\operatorname{Id}}(\lambda + \mu) + \log \operatorname{det}_{Fr} \left\{ \operatorname{Id} + \frac{2e^{a\sqrt{\Delta}^{q}_{M} + \lambda + \mu}}{\left(e^{a\sqrt{\Delta}^{q}_{M} + \lambda + \mu} - \operatorname{Id}\right)^{2}} \left( \operatorname{Id} - \frac{1}{2} \widetilde{\varphi}^{*}_{q} - \frac{1}{2} (\widetilde{\varphi}^{-1})^{*}_{q} \right) \right\}.$$

We fix  $\lambda$  and take  $\mu$  as a parameter. By the BFK-gluing formula ([4], [6]) we have the following equality.

$$\log \operatorname{Det} \left( \Delta_{M_{\varphi}}^{q} + \lambda + \mu \right) = \sum_{k=0}^{\left[\frac{m-1}{2}\right]} c_{k}(\varphi, \lambda) \mu^{k} + \log \operatorname{Det} \left( \Delta_{[0,a] \times M, D}^{q} + \lambda + \mu \right) + \log \operatorname{Det} R_{\varphi}^{q}(\lambda + \mu)$$

$$= \sum_{k=0}^{\left[\frac{m-1}{2}\right]} c_{k}(\varphi, \lambda) \mu^{k} + \log \operatorname{Det} \left( \Delta_{[0,a] \times M, D}^{q} + \lambda + \mu \right) + \log \operatorname{Det} R_{\mathrm{Id}}^{q}(\lambda + \mu)$$

$$+ \log \operatorname{det}_{Fr} \left\{ \operatorname{Id} + \frac{2e^{a\sqrt{\Delta_{M}^{q} + \lambda + \mu}}}{\left(e^{a\sqrt{\Delta_{M}^{q} + \lambda + \mu}} - \operatorname{Id}\right)^{2}} \left( \operatorname{Id} - \frac{1}{2} \widetilde{\varphi}_{q}^{*} - \frac{1}{2} (\widetilde{\varphi}^{-1})_{q}^{*} \right) \right\}. \quad (2.11)$$

For fixed  $\lambda > 0$  and  $\mu \to \infty$ , the each term in the above equality has an asymptotic expansion. It is well known that the zero coefficients in the asymptotic expansions of log Det  $\left(\Delta_{M_{\varphi}}^{q} + \lambda + \mu\right)$  and log Det  $\left(\Delta_{[0,a]\times M,D}^{q} + \lambda + \mu\right)$  for  $\mu \to \infty$  are zero (Lemma 2.1 in [11], eq.(1.6) in [12], or eq.(5.1) in [20]). Since

$$\log \det_{Fr} \left\{ \operatorname{Id} + \frac{2e^{a\sqrt{\widetilde{\Delta}_M^q + \lambda + \mu}}}{\left(e^{a\sqrt{\widetilde{\Delta}_M^q + \lambda + \mu}} - 1\right)^2} \left( \operatorname{Id} - \frac{1}{2}\widetilde{\varphi}_q^* - \frac{1}{2}(\widetilde{\varphi}^{-1})_q^* \right) \right\} = O(e^{-a\sqrt{\mu}}), \quad (2.12)$$

it follows that  $-c_0(\varphi, \lambda)$  is the zero coefficient in the asymptotic expansion of log Det  $R^q_{\text{Id}}(\lambda + \mu)$  for  $\mu \to \infty$ , which shows that  $c_0(\varphi, \lambda)$  does not depend on  $\varphi$ . We compute  $c_0(\varphi, \lambda) = c_0(\lambda)$  in the following way. From Lemma 2.4 we obtain the following equality.

$$+ \log \operatorname{det}_{Fr} \left( \operatorname{Id} - \frac{2}{e^{a\sqrt{\widetilde{\Delta}^{q}_{M} + \lambda + \mu}} + \operatorname{Id}} \right).$$

$$(2.13)$$

Since  $\log \det_{Fr} \left( \operatorname{Id} - \frac{2}{e^{a \sqrt{\tilde{\Delta}_{M}^{q} + \lambda + \mu}} + \operatorname{Id}} \right) = O(e^{-a \sqrt{\mu}})$  and the zero coefficient in the asymptotic expansion of  $\log \operatorname{Det} \left( \widetilde{\Delta}_{M}^{q} + \lambda + \mu \right)$  for  $\mu \to \infty$  is zero, the zero coefficient of  $\log \operatorname{Det} R_{\operatorname{Id}}^{q}(\lambda + \mu)$  is equal to the zero coefficient of  $\log 2 \cdot \zeta_{(\tilde{\Delta}_{M}^{q} + \lambda + \mu)}(0)$ . Denoting for  $t \to 0$ 

$$\operatorname{Tr} e^{-t\widetilde{\Delta}_{M}^{q}} \sim \sum_{j=0}^{\infty} \mathfrak{a}_{j} t^{-\frac{m-1}{2}+j}, \qquad (2.14)$$

it follows that

$$\log 2 \cdot \zeta_{(\tilde{\Delta}_{M}^{q} + \lambda + \mu)}(0) = \begin{cases} \log 2 \cdot \sum_{\ell=0}^{\frac{m-1}{2}} \sum_{k=0}^{\frac{m-1}{2}-\ell} \frac{(-1)^{k+\ell}}{k!\ell!} \mathfrak{a}_{(\frac{m-1}{2}-(k+\ell))} \lambda^{k} \mu^{\ell} & \text{for } m \text{ odd} \\ 0 & \text{for } m \text{ even,} \end{cases}$$
(2.15)

which shows that

$$c_{0}(\lambda) = \begin{cases} -\log 2 \cdot \sum_{k=0}^{\frac{m-1}{2}} \frac{(-1)^{k}}{k!} \mathfrak{a}_{(\frac{m-1}{2}-k)} \lambda^{k} & \text{ for } m \text{ odd} \\ 0 & \text{ for } m \text{ even.} \end{cases}$$
(2.16)

Taking  $\mu = 0$  in (2.11), we obtain the following result.

$$\log \operatorname{Det} \left( \Delta_{M_{\varphi}}^{q} + \lambda \right) = c_{0}(\lambda) + \log \operatorname{Det} \left( \Delta_{[0,a] \times M, D}^{q} + \lambda \right) + \log \operatorname{Det} R_{\operatorname{Id}}^{q}(\lambda)$$

$$+ \log \operatorname{det}_{Fr} \left\{ \operatorname{Id} + \frac{2e^{a\sqrt{\Delta_{M}^{q} + \lambda}}}{\left(e^{a\sqrt{\Delta_{M}^{q} + \lambda}} - \operatorname{Id}\right)^{2}} \left( \operatorname{Id} - \frac{1}{2} \widetilde{\varphi}_{q}^{*} - \frac{1}{2} (\widetilde{\varphi}^{-1})_{q}^{*} \right) \right\}.$$

$$(2.17)$$

If  $\varphi = Id$ , this formula is reduced to the following equality.

$$\log \operatorname{Det} \left( \Delta^{q}_{M \times S^{1}\left(\frac{a}{2\pi}\right)} + \lambda \right) = c_{0}(\lambda) + \log \operatorname{Det} \left( \Delta^{q}_{[0,a] \times M, \mathrm{D}} + \lambda \right) + \log \operatorname{Det} R^{q}_{\mathrm{Id}}(\lambda).$$
(2.18)

In fact, this equality can be obtained by using Theorem 7.1 of [9] and Proposition 5.1 of [19]. This leads to the following result.

**Theorem 2.5.** Let  $\varphi : (M, g^M) \to (M, g^M)$  be an isometry on a compact oriented Riemannian manifold  $(M, g^M)$  and  $M_{\varphi}$  be the metric mapping torus associated to  $\varphi$ . For  $\lambda > 0$ , we have the following equality.

$$\begin{split} \log \operatorname{Det} \left( \Delta_{M_{\varphi}}^{q} + \lambda \right) &= c_{0}(\lambda) + \log \operatorname{Det} \left( \Delta_{[0,a] \times M, \mathbf{D}}^{q} + \lambda \right) + \log \operatorname{Det} R_{\varphi}^{q}(\lambda) \\ &= \log \operatorname{Det} \left( \Delta_{M \times S^{1}\left(\frac{a}{2\pi}\right)}^{q} + \lambda \right) + \log \operatorname{det}_{Fr} \left\{ \operatorname{Id} + \frac{2e^{a\sqrt{\Delta_{M}^{q} + \lambda}}}{\left(e^{a\sqrt{\Delta_{M}^{q} + \lambda}} - \operatorname{Id}\right)^{2}} \left( \operatorname{Id} - \frac{1}{2} \widetilde{\varphi}_{q}^{*} - \frac{1}{2} (\widetilde{\varphi}^{-1})_{q}^{*} \right) \right\}, \end{split}$$

where  $c_0(\lambda)$  is given in (2.16).

We use Theorem 2.5 to compare the heat trace asymptotics of  $M_{\varphi}$  with that of  $M \times S^1(\frac{a}{2\pi})$ . For  $t \to 0$ , we denote

$$\operatorname{Tr} e^{-t\Delta_{M_{\varphi}}^{q}} \sim \sum_{j=0}^{\infty} \mathfrak{b}_{j} t^{-\frac{m}{2}+j}, \qquad \operatorname{Tr} e^{-t\Delta_{M\times S^{1}(\frac{a}{2\pi})}^{q}} \sim \sum_{j=0}^{\infty} \mathfrak{c}_{j} t^{-\frac{m}{2}+j}.$$

Simple computation shows that  $\log \operatorname{Det} \left( \Delta_{M_{\varphi}}^{q} + \lambda \right)$  has the following asymptotic expansion for  $\lambda \to \infty$ (Lemma 2.1 in [11], eq.(1.6) in [12]).

$$+ \sum_{j=0}^{m-1} \mathfrak{b}_{j} \left( \frac{\Gamma(s - \frac{m-j}{2})}{\Gamma(s)} \right) \Big|_{s=0} \lambda^{\frac{m-j}{2}} \log \lambda + O(\lambda^{-\frac{N+1-m}{2}}).$$

Similarly, replacing  $\mathfrak{b}_j$  with  $\mathfrak{c}_j$  yields the asymptotic expansion of  $\log \operatorname{Det}\left(\Delta^q_{M \times S^1\left(\frac{a}{2\pi}\right)} + \lambda\right)$ . Since  $\log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a}\sqrt{\tilde{\Delta}_{M}^{q} + \lambda}}{\left(e^{a}\sqrt{\tilde{\Delta}_{M}^{q} + \lambda} - 1\right)^{2}} \left( \mathrm{Id} - \frac{1}{2} \tilde{\varphi}_{q}^{*} - \frac{1}{2} (\tilde{\varphi}^{-1})_{q}^{*} \right) \right\} \text{ is } O(e^{-a\sqrt{\lambda}}) \text{ for } \lambda \to \infty, \text{ Theorem 2.5 shows that} \\ \log \mathrm{Det} \left( \Delta_{M_{\varphi}}^{q} + \lambda \right) \text{ and } \log \mathrm{Det} \left( \Delta_{M \times S^{1}\left(\frac{a}{2\pi}\right)}^{q} + \lambda \right) \text{ have the same asymptotic expansions, which yields the following result.}$ 

**Corollary 2.6.** For  $t \to 0$ ,  $\operatorname{Tr} e^{-t\Delta_{M_{\varphi}}^{q}}$  and  $\operatorname{Tr} e^{-t\Delta_{M \times S^{1}(\frac{a}{2\pi})}^{q}}$  have the same asymptotic expansions, i.e.  $\mathfrak{b}_j = \mathfrak{c}_j.$ 

We next discuss the behavior of each term in Theorem 2.5 for  $\lambda \to 0$ . From the definition of  $R^q_{\varphi}(\lambda)$ , it follows that

$$\ker R^q_{\varphi}(0) = \{\omega|_{M \times \{0\}} \mid \omega \in \ker \Delta^q_{M_{\varphi}}\}, \qquad \dim \ker R^q_{\varphi}(0) = \dim \ker \Delta^q_{M_{\varphi}}. \tag{2.21}$$

$$\mathcal{H}^{q}(M) := \{ \sigma \in \Omega^{q}(M) \mid d\sigma = d^{*}\sigma = 0 \}, \qquad b_{q} := \dim \ker \mathcal{H}^{q}(M),$$

$$\mathcal{H}^{q}_{\varphi}(M) := \{ \sigma \in \mathcal{H}^{q}(M) \mid \varphi^{*}\sigma = \sigma \}, \qquad \ell^{q}_{\varphi} := \dim \ker \mathcal{H}^{q}_{\varphi}(M),$$

$$\mathcal{S}^{q}_{\varphi}(M) := \mathcal{H}^{q}(M) \ominus \mathcal{H}^{q}_{\varphi}(M), \qquad b_{q} - \ell^{q}_{\varphi} = \dim \ker \mathcal{S}^{q}_{\varphi}(M).$$

$$(2.23)$$

Then it follows that

$$\dim \ker R^q_{\varphi}(0) = \dim \ker \Delta^q_{M_{\varphi}} = \ell^q_{\varphi} + \ell^{q-1}_{\varphi}.$$
(2.24)

We note that

$$\log \operatorname{Det} \left( \Delta_{M_{\varphi}}^{q} + \lambda \right) = \left( \ell_{\varphi}^{q} + \ell_{\varphi}^{q-1} \right) \log \lambda + \log \operatorname{Det}^{*} \Delta_{M_{\varphi}}^{q} + O(\lambda),$$

$$\log \operatorname{Det} \left( \Delta_{[0,a] \times M, \mathrm{D}}^{q} + \lambda \right) = \log \operatorname{Det} \Delta_{[0,a] \times M, \mathrm{D}}^{q} + O(\lambda).$$

For  $\alpha \in \ker R^q_{\varphi}(0)$  and  $\lambda \to 0$ , Lemma 2.4 shows that

$$\log \operatorname{Det} \Delta_{[0,a] \times M, D}^{q} + \log \operatorname{Det}^* R_{\varphi}^{q}(0).$$

Setting  $\varphi = \text{Id}$  and using  $\ell_{\text{Id}}^q = b_q$ , we have the following result.

$$\log \operatorname{Det}^* \Delta_{\operatorname{Id}}^q = (b_q + b_{q-1}) \log a - \log 2 \left( \zeta_{\Delta_M^q}(0) + \zeta_{\Delta_M^{q-1}}(0) + b_q + b_{q-1} \right)$$

$$+ \log \operatorname{Det} \Delta_{[0,a] \times M, \mathrm{D}}^q + \log \operatorname{Det}^* R_{\operatorname{Id}}^q(0),$$

which leads to

 $\log \operatorname{Det}^* \Delta_{M_{\varphi}}^q = (\ell_{\varphi}^q + \ell_{\varphi}^{q-1} - b_q - b_{q-1}) \log a + \log \operatorname{Det}^* \Delta_{\operatorname{Id}}^q - \log \operatorname{Det}^* R_{\operatorname{Id}}^q(0) + \log \operatorname{Det}^* R_{\varphi}^q(0).$ (2.31) Lemma 2.4 shows that

**Theorem 2.7.** Under the same assumptions as in Theorem 2.5, the following equality holds.

In the remaining part of this section, we are going to use Theorem 2.7 to compute the zeta-determinants of the scalar Laplacians defined on the Klein bottle  $\mathbb{K}$  and some compact co-Kähler manifold  $\mathbb{T}_{\varphi}$  given in [2] and [7]. The Klein bottle  $\mathbb{K}$  is obtained by the group of motions on  $\mathbb{R}^2$  generated by  $(x, y) \mapsto (x, y + 2\pi\rho)$ and  $(x, y) \mapsto (x + a, 2\pi\rho - y)$  for some a > 0 and  $\rho > 0$ . The fundamental domain of  $\mathbb{K}$  is  $(0, a) \times (0, 2\pi\rho)$ . We denote by  $\Omega^0_{\mathbb{K}}(\mathbb{R}^2)$  the set of all smooth functions on  $\mathbb{R}^2$  satisfying

$$f(x,y) = f(x,y+2\pi\rho) = f(x+a,2\pi\rho-y).$$

Then, the Laplacian  $\Delta_{\mathbb{K}}$  is described by

$$\Delta_{\mathbb{K}} = -\left(\frac{\partial^2}{\partial x^2} + \frac{\partial^2}{\partial y^2}\right) \tag{2.33}$$

defined on  $\Omega^0_{\mathbb{K}}(\mathbb{R}^2)$ . Let  $M = S^1(\rho)$  and  $\varphi : S^1(\rho) \to S^1(\rho)$  be defined by  $\varphi(\rho e^{i\theta}) = \rho e^{-i\theta}$ . Then,  $\mathbb{K} = M_{\varphi}$ . The eigenfunctions are given by

$$\cos\frac{2\pi mx}{a}\cos\frac{ny}{\rho}, \quad \sin\frac{2\pi mx}{a}\cos\frac{ny}{\rho}, \quad \cos\frac{2\pi \left(m-\frac{1}{2}\right)x}{a}\sin\frac{ny}{\rho}, \quad \sin\frac{2\pi \left(m-\frac{1}{2}\right)x}{a}\sin\frac{ny}{\rho}, \quad (2.34)$$

and their corresponding eigenvalues are

where the multiplicity of  $\frac{m^2}{\rho^2}$  is 1 and the multiplicities of other non-zero eigenvalues are 2. The zeta function on  $\mathbb{K}$  is given by

$$\zeta_{\mathbb{K}}(s) = 2\sum_{n,m=1}^{\infty} \left(\frac{4\pi^2 m^2}{a^2} + \frac{n^2}{\rho^2}\right)^{-s} + 2\sum_{m=1}^{\infty} \left(\frac{4\pi^2 m^2}{a^2}\right)^{-s} + \sum_{m=1}^{\infty} \left(\frac{m^2}{\rho^2}\right)^{-s} + 2\sum_{n,m=1}^{\infty} \left(\frac{4\pi^2 (m - \frac{1}{2})^2}{a^2} + \frac{n^2}{\rho^2}\right)^{-s}.$$

Since ker  $\Delta^0_{\mathbb{K}}$ ,  $\mathcal{H}^0(S^1(\rho))$  and  $\mathcal{H}^0_{\omega}(S^1(\rho))$  consist of constant functions, it follows that

$$b_0 = \ell_{\varphi}^0 = 1, \qquad S_{\varphi}^0(S^1(\rho)) = \emptyset.$$

The flat torus  $\mathbb{T}$  is obtained by the group of motions on  $\mathbb{R}^2$  generated by  $(x, y) \mapsto (x, y + 2\pi\rho)$  and  $(x, y) \mapsto (x + a, y)$ . The fundamental domain is  $(0, a) \times (0, 2\pi\rho)$ . The eigenfunctions are given by

$$\cos\frac{2\pi mx}{a}\cos\frac{ny}{\rho}, \quad \sin\frac{2\pi mx}{a}\cos\frac{ny}{\rho}, \quad \cos\frac{2\pi mx}{a}\sin\frac{ny}{\rho}, \quad \sin\frac{2\pi mx}{a}\sin\frac{ny}{\rho}, \quad (2.38)$$

and their corresponding eigenvalues are

$$\left\{0\right\} \cup \left\{\frac{4\pi^2 m^2}{a^2} + \frac{n^2}{\rho^2} \mid m, n = 1, 2, \cdots\right\} \cup \left\{\frac{4\pi^2 m^2}{a^2} \mid m = 1, 2, \cdots\right\} \cup \left\{\frac{m^2}{\rho^2} \mid m = 1, 2, \cdots\right\}, \quad (2.39)$$

where the multiplicity of  $\frac{4\pi^2 m^2}{a^2} + \frac{n^2}{\rho^2}$  is 4 and the multiplicities of other non-zero eigenvalues are 2. The zeta function on  $\mathbb{T}$  is given by

$$\zeta_{\mathbb{T}}(s) = 4 \sum_{n,m=1}^{\infty} \left( \frac{4\pi^2 m^2}{a^2} + \frac{n^2}{\rho^2} \right)^{-s} + 2 \sum_{m=1}^{\infty} \left( \frac{4\pi^2 m^2}{a^2} \right)^{-s} + 2 \sum_{m=1}^{\infty} \left( \frac{m^2}{\rho^2} \right)^{-s}.$$
 (2.40)

It follows that

$$\zeta_{\Delta_{\mathbb{K}}}(s) - \zeta_{\Delta_{\mathbb{T}}}(s)$$

$$= 2 \sum_{n,m=1}^{\infty} \left( \frac{4\pi^2 \left(m - \frac{1}{2}\right)^2}{a^2} + \frac{n^2}{\rho^2} \right)^{-s} - 2 \sum_{n,m=1}^{\infty} \left( \frac{4\pi^2 m^2}{a^2} + \frac{n^2}{\rho^2} \right)^{-s} - \sum_{m=1}^{\infty} \left( \frac{m^2}{\rho^2} \right)^{-s}.$$
(2.41)

Theorem 2.7 with (2.37) shows that

$$\log \operatorname{Det}^* \Delta_{\mathbb{K}} - \log \operatorname{Det}^* \Delta_{\mathbb{T}} = \log \operatorname{det}_{Fr} \left\{ \operatorname{Id} + \frac{2e^{a\sqrt{\Delta_M^0}}}{\left(e^{a\sqrt{\Delta_M^0}} - \operatorname{Id}\right)^2} \left( \operatorname{Id} - \frac{\varphi_0^* + (\varphi^{-1})_0^*}{2} \right) \right\} \Big|_{\mathcal{H}^0(S^1(\rho))^{\perp}}.$$
(2.42)

Since  $\varphi(\rho e^{i\theta}) = \rho e^{-i\theta}$ , we get  $\varphi(\rho e^{i\theta}) = \varphi^{-1}(\rho e^{i\theta}) = \rho e^{-i\theta}$  and hence

$$\left(\mathrm{Id} -\frac{1}{2}\left(\varphi_0^* + (\varphi^{-1})_0^*\right)\right)\cos kx = 0, \quad \left(\mathrm{Id} -\frac{1}{2}\left(\varphi_0^* + (\varphi^{-1})_0^*\right)\right)\sin kx = 2\sin kx. \quad (2.43)$$

From  $\Delta_M^0 = -\frac{1}{\rho^2} \frac{\partial^2}{\partial \theta^2}$ , it follows that

$$\log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^0}}}{(e^{a\sqrt{\Delta_M^0}} - \mathrm{Id})^2} \left( \mathrm{Id} - \frac{\varphi_0^* + (\varphi_0^{-1})^*}{2} \right) \right\} \Big|_{\mathcal{H}^0(S^1(\rho))^\perp}$$
(2.44)  
=  $\sum_{k=1}^{\infty} \log \left( 1 + \frac{4e^{\frac{ak}{\rho}}}{(e^{\frac{ak}{\rho}} - 1)^2} \right) = \sum_{k=1}^{\infty} \log \left( \frac{e^{\frac{ak}{\rho}} + 1}{e^{\frac{ak}{\rho}} - 1} \right)^2 = 2 \sum_{k=1}^{\infty} \log \left( 1 + \frac{2}{e^{\frac{ak}{\rho}} - 1} \right).$   
in Theorem 8.3 of [9] that

It is known in Theorem 8.3 of [9] that

$$\log \operatorname{Det}^* \Delta_{\mathbb{T}} = 2 \log 2\pi \rho - \frac{2\pi^2 \rho}{3a} + 4 \sum_{k=1}^{\infty} \log \left( 1 - e^{-\frac{4\pi^2 \rho k}{a}} \right),$$
(2.45)

which leads to the following result.

**Theorem 2.8.** The zeta-determinant of the scalar Laplacian on the Klein bottle  $\mathbb{K}$  defined as above is given as follows.

$$\log \operatorname{Det}^* \Delta_{\mathbb{K}} = 2\log 2\pi\rho - \frac{2\pi^2\rho}{3a} + 4\sum_{k=1}^{\infty} \log\left(1 - e^{-\frac{4\pi^2\rho k}{a}}\right) + 2\sum_{k=1}^{\infty} \log\left(1 + \frac{2}{e^{\frac{ak}{\rho}} - 1}\right).$$

*Remark:* This result was obtained in [14] by using the different method proved in [13].

The co-Kähler manifolds are odd dimensional analogue of Kähler manifolds ([3], [7], [17]), and metric mapping tori of Kähler manifolds are good examples of compact co-Kähler manifolds ([2], [15]). The first example of a co-Kähler manifold  $\mathbb{T}_{\varphi}^2$  which is not a product with  $S^1$  is given in [7] as follows. Here  $\mathbb{T}^2 := S^1 \times S^1$ , where  $S^1$  is a circle of radius 1. We define

$$\varphi : \mathbb{T}^2 \to \mathbb{T}^2, \qquad \varphi(e^{i\theta}, e^{i\phi}) = (e^{i\phi}, e^{i(\theta+\pi)}).$$
(2.46)

Then,  $\varphi$  is a Hermitian isometry and  $\mathbb{T}_{\varphi}^2$  is defined to be the metric mapping torus associated to  $\varphi$ , *i.e.*  $\mathbb{T}_{\varphi}^2 = \mathbb{T}^2 \times [0, 2\pi]/(x, y, 0) \sim (y, -x, 2\pi)$ . The Laplacian and its domain are given as follows.

$$\Delta_{\mathbb{T}^2_{\varphi}} = -\frac{d^2}{du^2} + \Delta_{\mathbb{T}^2}, \quad \Omega_{\mathbb{T}^2_{\varphi}} = \left\{ f : \mathbb{T}^2 \times \mathbb{R} \to \mathbb{T}^2 \times \mathbb{R} \mid f(x, y, u) = f(\varphi(x, y), u + 2\pi) \right\}.$$
(2.47)

Since  $b_0 = \ell^0_{\varphi} = 1$  and  $\mathcal{S}^0_{\varphi}(\mathbb{T}^2) = \emptyset$ , Theorem 2.7 shows that

$$\log \operatorname{Det}^{*} \Delta_{\mathbb{T}^{2}_{\varphi}} - \log \operatorname{Det}^{*} \Delta_{\mathbb{T}^{2} \times S^{1}}$$

$$= \log \operatorname{det}_{Fr} \left\{ \operatorname{Id} + \frac{2e^{2\pi \sqrt{\Delta_{\mathbb{T}^{2}}^{0}}}}{\left(e^{2\pi \sqrt{\Delta_{\mathbb{T}^{2}}^{0}}} - \operatorname{Id}\right)^{2}} \left( \operatorname{Id} - \frac{\varphi_{0}^{*} + (\varphi^{-1})_{0}^{*}}{2} \right) \right\} |_{\mathcal{H}^{0}(\mathbb{T}^{2})^{\perp}}.$$

$$(2.48)$$

We denote  $\psi_{m,n}(e^{i\theta}, e^{i\phi}) = e^{im\theta}e^{in\phi}$  for  $(m, n) \in \mathbb{Z} \times \mathbb{Z}$ , which is an eigenfunction of  $\Delta_{\mathbb{T}^2}$  with eigenvalue  $m^2 + n^2$ . It follows that

$$\left(\varphi_{0}^{*}\psi_{m,n}\right)\left(e^{i\theta}, e^{i\phi}\right) = (-1)^{n}\psi_{n,m}\left(e^{i\theta}, e^{i\phi}\right), \quad \left(\left(\varphi^{-1}\right)_{0}^{*}\psi_{m,n}\right)\left(e^{i\theta}, e^{i\phi}\right) = (-1)^{m}\psi_{n,m}\left(e^{i\theta}, e^{i\phi}\right), \quad (2.49)$$

which shows that  $\operatorname{Id} - \frac{\varphi_0^* + (\varphi^{-1})_0^*}{2}$  has three eigenvalues  $\kappa = 0, 1, 2$ . The corresponding eigenfunctions are given as follows.

$$\kappa = 0: \left\{ \psi_{2k,2k} \mid k \in \mathbb{Z} \right\} \cup \left\{ \psi_{2m,2n} + \psi_{2n,2m}, \ \psi_{2m+1,2n+1} - \psi_{2n+1,2m+1} \mid n,m \in \mathbb{Z}, n \neq m \right\}, \quad (2.50)$$

$$\kappa = 1: \left\{ \psi_{2m,2n+1}, \ \psi_{2n+1,2m} \mid n,m \in \mathbb{Z} \right\},$$

$$\kappa = 2: \left\{ \psi_{2k+1,2k+1} \mid k \in \mathbb{Z} \right\} \cup \left\{ \psi_{2m,2n} - \psi_{2n,2m}, \ \psi_{2m+1,2n+1} + \psi_{2n+1,2m+1} \mid n,m \in \mathbb{Z}, n \neq m \right\}.$$

Simple computation leads to the following result.

$$\log \operatorname{Det}^* \Delta_{\mathbb{T}^2_{\varphi}} - \log \operatorname{Det}^* \Delta_{\mathbb{T}^2 \times S^1} = 2 \sum_{(0,0) \neq (m,n) \in \mathbb{Z} \times \mathbb{Z}} \log \left( 1 + \frac{2}{e^{2\pi\sqrt{m^2 + n^2}} - 1} \right)$$
(2.51)  
+ 
$$2 \sum_{(m,n) \in \mathbb{Z} \times \mathbb{Z}} \log \left( 1 - \frac{2e^{2\pi\sqrt{4m^2 + (2n+1)^2}}}{\left(e^{2\pi\sqrt{4m^2 + (2n+1)^2}} + 1\right)^2} \right) - 4 \sum_{m=1}^{\infty} \log \left( 1 + \frac{2}{e^{4\sqrt{2}\pi m} - 1} \right).$$

It is shown in Theorem 7.1 of [9] that

$$\log \operatorname{Det}^* \Delta_{\mathbb{T}^2 \times S^1} = 2 \log 2\pi + 2\pi \zeta_{\mathbb{T}^2} \left( -\frac{1}{2} \right) + 2 \sum_{(0,0) \neq (m,n) \in \mathbb{Z} \times \mathbb{Z}} \log \left( 1 - e^{-2\pi \sqrt{m^2 + n^2}} \right).$$
(2.52)

We finally obtain the following result.

**Theorem 2.9.** The zeta-determinant of the scalar Laplacian on  $\mathbb{T}^2_{\varphi}$  is given as follows.

$$\log \operatorname{Det}^* \Delta_{\mathbb{T}^2_{\varphi}} = 2\log 2\pi + 2\pi\zeta_{\mathbb{T}^2} \left(-\frac{1}{2}\right) + 2\sum_{(0,0)\neq(m,n)\in\mathbb{Z}\times\mathbb{Z}} \log\left(1 + e^{-2\pi\sqrt{m^2 + n^2}}\right) \\ + 2\sum_{(m,n)\in\mathbb{Z}\times\mathbb{Z}} \log\left(1 - \frac{2e^{2\pi\sqrt{4m^2 + (2n+1)^2}}}{\left(e^{2\pi\sqrt{4m^2 + (2n+1)^2}} + 1\right)^2}\right) - 4\sum_{m=1}^{\infty} \log\left(1 + \frac{2}{e^{4\sqrt{2}\pi m} - 1}\right) + 2\sum_{(m,n)\in\mathbb{Z}\times\mathbb{Z}} \log\left(1 - \frac{2e^{2\pi\sqrt{4m^2 + (2n+1)^2}}}{\left(e^{2\pi\sqrt{4m^2 + (2n+1)^2}} + 1\right)^2}\right) - 4\sum_{m=1}^{\infty} \log\left(1 + \frac{2}{e^{4\sqrt{2}\pi m} - 1}\right) + 2\sum_{m=1}^{\infty} \log\left(1 + \frac{2}{e^{4\sqrt{2}\pi$$

# 3. The analytic torsion on a metric mapping torus

In this section we use Theorem 2.7 to compute the analytic torsion  $\log T(M_{\varphi})$  of a metric mapping torus. Simple computation shows that

$$\begin{aligned} &-\frac{1}{2}\sum_{q=0}^{m}(-1)^{q+1} \cdot q \cdot (b_{q} + b_{q-1} - \ell_{\varphi}^{q} - \ell_{\varphi}^{q-1}) \cdot \log \frac{a^{2}}{2} = -\frac{1}{2}\sum_{q=0}^{m-1}(-1)^{q} \cdot (b_{q} - \ell_{\varphi}^{q}) \cdot \log \frac{a^{2}}{2}, (3.1) \\ &\frac{1}{2}\sum_{q=0}^{m}(-1)^{q+1} \cdot q \cdot \log \det_{Fr} \left( \operatorname{Id} - \frac{1}{2} \left( \widetilde{\varphi}_{q}^{*} + \ \widetilde{(\varphi^{-1})}_{q}^{*} \right) \right) \Big|_{\widetilde{S}_{\varphi}^{q}(M)} \\ &= \frac{1}{2}\sum_{q=0}^{m}(-1)^{q+1} \cdot q \cdot \log \det_{Fr} \left( \operatorname{Id} - \frac{1}{2} \left( \varphi_{q}^{*} + \ (\varphi^{-1})_{q}^{*} \right) \right) \Big|_{S_{\varphi}^{q}(M)} \\ &+ \frac{1}{2}\sum_{q=0}^{m}(-1)^{q+1} \cdot q \cdot \log \det_{Fr} \left( \operatorname{Id} - \frac{1}{2} \left( \varphi_{q}^{*} + \ (\varphi^{-1})_{q}^{*} \right) \right) \Big|_{S_{\varphi}^{q-1}(M)} \\ &= \frac{1}{2}\sum_{q=0}^{m-1}(-1)^{q} \cdot \log \det_{Fr} \left( \operatorname{Id} - \frac{1}{2} \left( \varphi_{q}^{*} + \ (\varphi^{-1})_{q}^{*} \right) \right) \Big|_{S_{\varphi}^{q}(M)}. \end{aligned}$$

By the Hodge decomposition,  $\Omega^{q}(M)$  is decomposed into

$$\Omega^{q}(M) = \Omega^{q}_{-}(M) \oplus \mathcal{H}^{q}(M) \oplus \Omega^{q}_{+}(M), \qquad (3.2)$$

where  $\Omega_{-}^{q}(M) = \operatorname{Im} d \cap \Omega^{q}(M)$  and  $\Omega_{+}^{q}(M) = \operatorname{Im} d^{*} \cap \Omega^{q}(M)$ . Since  $\varphi : M \to M$  is an isometry,  $\varphi_{q}^{*}$ and  $(\varphi^{-1})_{q}^{*}$  preserve  $\Omega_{\pm}^{q}(M)$ . We denote by  $\Delta_{M}^{q,\pm}$ ,  $\varphi_{q}^{*,\pm}$ ,  $(\varphi^{-1})_{q}^{*,\pm}$  the restrictions of  $\Delta_{M}^{q}$ ,  $\varphi_{q}^{*}$ ,  $(\varphi^{-1})_{q}^{*}$ to  $\Omega^{q,\pm}(M)$ . Since  $\Delta_{M}^{q}$  and  $(\varphi^{i})_{q}^{*}$  (i = 1, -1) commute with d, it follows that  $\Delta_{M}^{q,+}$  and  $(\varphi^{i})_{q}^{*,+}$  are isospectral with  $\Delta_{M}^{q+1,-}$  and  $(\varphi^{i})_{q+1}^{*,-}$ , respectively. Taking these facts into consideration, we have the following equalities.

$$\begin{aligned} &\frac{1}{2} \sum_{q=0}^{m} (-1)^{q+1} \cdot q \cdot \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^q}}}{\left(e^{a\sqrt{\Delta_M^q}} - \mathrm{Id}\right)^2} \left( \mathrm{Id} - \frac{\tilde{\varphi}_q^* + (\tilde{\varphi}^{-1})_q^*}{2} \right) \right\} |_{\tilde{\mathcal{H}}^q(M)^{\perp}} \end{aligned} (3.3) \\ &= \frac{1}{2} \sum_{q=0}^{m} (-1)^{q+1} \cdot q \cdot \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^q}}}{\left(e^{a\sqrt{\Delta_M^q}} - \mathrm{Id}\right)^2} \left( \mathrm{Id} - \frac{\varphi_q^* + (\varphi^{-1})_q^*}{2} \right) \right\} |_{\mathcal{H}^q(M)^{\perp}} \\ &+ \frac{1}{2} \sum_{q=0}^{m} (-1)^{q+1} \cdot q \cdot \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^q}}}{\left(e^{a\sqrt{\Delta_M^q}} - \mathrm{Id}\right)^2} \left( \mathrm{Id} - \frac{\varphi_{q+1}^* + (\varphi^{-1})_{q+1}^*}{2} \right) \right\} |_{\mathcal{H}^{q-1}(M)^{\perp}} \\ &= \frac{1}{2} \sum_{q=0}^{m} (-1)^q \cdot \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^q}}}{\left(e^{a\sqrt{\Delta_M^q}} - \mathrm{Id}\right)^2} \left( \mathrm{Id} - \frac{\varphi_q^* + (\varphi^{-1})_q^*}{2} \right) \right\} |_{\mathcal{H}^q(M)^{\perp}} \\ &= \frac{1}{2} \sum_{q=0}^{m} (-1)^q \cdot \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^q}}}{\left(e^{a\sqrt{\Delta_M^q}} - \mathrm{Id}\right)^2} \left( \mathrm{Id} - \frac{\varphi_{q,-1}^* + (\varphi^{-1})_{q,-1}^*}{2} \right) \right\} \\ &+ \frac{1}{2} \sum_{q=0}^{m} (-1)^q \cdot \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^q}}}{\left(e^{a\sqrt{\Delta_M^q}} - \mathrm{Id}\right)^2} \left( \mathrm{Id} - \frac{\varphi_{q,-1}^* + (\varphi^{-1})_{q,-1}^*}{2} \right) \right\} \\ &+ \frac{1}{2} \sum_{q=0}^{m} (-1)^q \cdot \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^{q,-1}}}}{\left(e^{a\sqrt{\Delta_M^{q,-1}}} - \mathrm{Id}\right)^2} \left( \mathrm{Id} - \frac{\varphi_{q,+1}^* + (\varphi^{-1})_{q,-1}^*}{2} \right) \right\} \\ &= 0. \end{aligned}$$

When  $M_1$  and  $M_2$  are compact oriented Riemannian manifolds, it is well known ((7.4) in [18]) that

$$\log T(M_1 \times M_2) = \chi(M_2) \log T(M_1) + \chi(M_1) \log T(M_2).$$
(3.4)

When  $S^1(r)$  is a round circle of radius r > 0, the Laplacian  $\Delta_{S^1(r)}$  and its associated zeta function  $\zeta_{S^1(r)}(s)$  are given by

$$\Delta_{S^{1}(r)} = -\frac{1}{r^{2}} \frac{\partial^{2}}{\partial \theta^{2}}, \qquad \zeta_{S^{1}(r)}(s) = 2 \sum_{k=1}^{\infty} \left(\frac{k^{2}}{r^{2}}\right)^{-s} = 2r^{2s} \zeta_{R}(2s), \qquad (3.5)$$

which shows that

$$\zeta'_{S^{1}(r)}(0) = 4\log r \,\zeta_{R}(0) + 4\zeta'_{R}(0) = -2\log r - 2\log 2\pi = -2\log 2\pi r.$$
(3.6)

Hence, it follows that

$$T(S^{1}(r)) = \frac{1}{2} \log \operatorname{Det}^{*} \Delta_{S^{1}(r)} = \log 2\pi r, \quad \log T\left(M \times S^{1}(\frac{a}{2\pi})\right) = \chi(M) \cdot \log a.$$
(3.7)

Summarizing the above argument, we have the following result.

**Theorem 3.1.** Let  $\varphi : (M, g^M) \to (M, g^M)$  be an isometry on a compact oriented Riemannian manifold  $(M, g^M)$  and  $M_{\varphi}$  be the metric mapping torus associated to  $\varphi$ . Then,

$$\log T(M_{\varphi}) = \frac{1}{2} \log 2 \cdot \chi(M) + \frac{1}{2} \log \frac{a^2}{2} \cdot \sum_{q=0}^{m-1} (-1)^q \ell_{\varphi}^q + \frac{1}{2} \sum_{q=0}^{m-1} (-1)^q \log \det_{F_r} \left( \operatorname{Id} - \frac{1}{2} \left( \varphi_q^* + (\varphi^{-1})_q^* \right) \right) \Big|_{\mathcal{S}_{\varphi}^q(M)}.$$

In particular, if dim M is odd and  $\varphi$  is orientation preserving, then  $\log T(M_{\varphi}) = 0$ .

In the remaining part of this section, we are going to compute the analytic torsion for the Witten deformed Laplacian ([21]) and recover the result of J. Marcsik given in [16]. Since a mapping torus is a fiber bundle over  $S^1$ , we write the fiber bundle by  $p: M_{\varphi} \to S^1(\frac{a}{2\pi})$ . Let  $d\theta$  be the standard one form on  $S^1(\frac{a}{2\pi})$  and put  $du = p^*d\theta$ . Setting  $d_q(t) := d + tdu \wedge : \Omega^q(M_{\varphi}) \to \Omega^{q+1}(M_{\varphi})$ , it follows that  $d_{q+1}(t)d_q(t) = 0$ . We consider a complex  $(\Omega^*(M_{\varphi}), d(t))$  with  $\Delta^q_{M_{\varphi}}(t) := d_q^*(t)d_q(t) + d_{q-1}(t)d_{q-1}^*(t)$ . Since  $d_q^*(t) = d^* + t\iota_{\frac{\partial}{\partial w}}$ , simple computation shows that

$$\Delta^q_{M_{i\sigma}}(t) = \Delta^q_{M_{i\sigma}} + t^2. \tag{3.8}$$

We define the analytic torsion  $T(M_{\varphi}, t)$  with respect to  $\Delta^q_{M_{\varphi}}(t)$  by

$$\log T(M_{\varphi}, t) = \frac{1}{2} \sum_{q=0}^{m} (-1)^{q+1} \cdot q \cdot \log \operatorname{Det} \left( \Delta_{M_{\varphi}}^{q} + t^{2} \right).$$
(3.9)

To describe the result of J. Marcsik, we define the Lefschetz number as follows. Let  $F: M \to M$  be a continuous map with the induced homomorphism  $F_q^*: H^q(M, \mathbb{R}) \to H^q(M, \mathbb{R})$ . The Lefschetz number L(F) and Lefschetz zeta function  $\zeta_F(t)$  are defined by

$$L(F) = \sum_{q=0}^{m-1} (-1)^q \operatorname{Tr} F_q^*, \qquad \log \zeta_F(t) = \sum_{k=1}^{\infty} L(F^k) \frac{t^k}{k}.$$
 (3.10)

**Lemma 3.2.** If  $\psi : M \to M$  is an isometry, then  $L(\psi) = L(\psi^{-1})$ .

Proof. We note that  $\psi_q^* : H^q(M, \mathbb{R}) \to H^q(M, \mathbb{R})$  can be identified with  $\psi_q^* : \mathcal{H}^q(M) \to \mathcal{H}^q(M)$ , where  $\mathcal{H}^q(M)$  is the set of harmonic q-forms. Since  $\psi$  is an isometry, it follows that for any  $v \in \mathcal{H}^q(M)$ ,  $\|v\| = \|\psi_q^* v\|$ . Hence, for any orthonormal basis for  $\mathcal{H}^q(M)$ ,  $\psi_q^*$  is expressed by an orthogonal matrix, whose inverse is equal to its transpose. This shows that  $\operatorname{Tr} \psi_q^* = \operatorname{Tr}(\psi^{-1})_q^*$ , and the result follows.  $\Box$ 

We are going to express  $\log T(M_{\varphi}, t)$  in terms of the Euler characteristic  $\chi(M)$  and Lefschetz zeta function  $\zeta_{\varphi}(t)$  for  $\varphi: M \to M$ . The second equality of Theorem 2.5 shows that

$$\log \operatorname{Det} \left( \Delta_{M_{\varphi}}^{q} + t^{2} \right) = \log \operatorname{Det} \left( \Delta_{M \times S^{1}\left(\frac{a}{2\pi}\right)}^{q} + t^{2} \right)$$

$$+ \log \operatorname{det}_{Fr} \left\{ \operatorname{Id} + \frac{2e^{a\sqrt{\widetilde{\Delta}_{M}^{q} + t^{2}}}}{\left(e^{a\sqrt{\widetilde{\Delta}_{M}^{q} + t^{2}}} - \operatorname{Id}\right)^{2}} \left( \operatorname{Id} - \frac{\widetilde{\varphi}_{q}^{*} + (\widetilde{\varphi^{-1}})_{q}^{*}}{2} \right) \right\},$$
(3.11)

which leads to

$$\log T\left(M_{\varphi},t\right) = \log T\left(M \times S^{1}\left(\frac{a}{2\pi}\right),t\right)$$

$$+ \frac{1}{2}\sum_{q=0}^{m} (-1)^{q+1} \cdot q \cdot \log \det_{F_{T}} \left\{ \operatorname{Id} + \frac{2e^{a\sqrt{\tilde{\Delta}_{M}^{q}+t^{2}}}}{\left(e^{a\sqrt{\tilde{\Delta}_{M}^{q}+t^{2}}} - \operatorname{Id}\right)^{2}} \left(\operatorname{Id} - \frac{\widetilde{\varphi}_{q}^{*} + (\widetilde{\varphi^{-1}})_{q}^{*}}{2}\right) \right\}.$$

$$(3.12)$$

It is a well known fact ((7.4) in [18]) that

$$\log T\left(M \times S^{1}\left(\frac{a}{2\pi}\right), t\right) = \chi(M) \cdot \log T\left(S^{1}\left(\frac{a}{2\pi}\right), t\right) + \chi\left(S^{1}\left(\frac{a}{2\pi}\right)\right) \cdot \log T(M, t)$$
$$= \frac{1}{2}\chi(M) \cdot \log \operatorname{Det}\left(\Delta_{S^{1}\left(\frac{a}{2\pi}\right)} + t^{2}\right).$$
(3.13)

Lemma 3.3.

$$\log \operatorname{Det} \left( \Delta_{S^1\left(\frac{a}{2\pi}\right)} + t^2 \right) = at + 2\log(1 - e^{-at}).$$

*Proof.* Since Spec  $\left(\Delta_{S^1\left(\frac{a}{2\pi}\right)}\right) = \left\{ \left(\frac{2\pi k}{a}\right)^2 \mid k \in \mathbb{Z} \right\}$ , it follows that

$$\zeta_{\left(\Delta_{S^{1}\left(\frac{a}{2\pi}\right)}^{1}+t^{2}\right)}(s) = 2\sum_{k=1}^{\infty} \left(\left(\frac{2\pi k}{a}\right)^{2}+t^{2}\right)^{-s} + t^{-2s} = \frac{2}{\Gamma(s)}\int_{0}^{\infty} u^{s-1}e^{-ut^{2}}\sum_{k=1}^{\infty}e^{-\frac{4\pi^{2}k^{2}}{a^{2}}u} du + t^{-2s}.$$
The Poisson summation formula shows that

The Poisson summation formula shows that

$$\sum_{k=1}^{\infty} e^{-\frac{4\pi^2 k^2}{a^2}u} = -\frac{1}{2} + \frac{a}{4\sqrt{\pi u}} + \frac{a}{2\sqrt{\pi u}} \sum_{k=1}^{\infty} e^{-\frac{a^2 k^2}{4u}},$$

which yields that

$$\zeta_{\left(\Delta_{S^{1}\left(\frac{a}{2\pi}\right)}^{1}+t^{2}\right)}(s) = \frac{a\Gamma(s-\frac{1}{2})}{2\sqrt{\pi}\Gamma(s)}t^{-2s+1} + \frac{a}{\sqrt{\pi}}\sum_{k=1}^{\infty}\frac{1}{\Gamma(s)}\int_{0}^{\infty}u^{s-\frac{3}{2}}e^{-(ut^{2}+\frac{a^{2}k^{2}}{4u})} du^{2s+1}du^{2s+1} du^{2s+1}du$$

Hence,

$$\zeta'_{\left(\Delta^1_{S^1(\frac{a}{2\pi})} + t^2\right)}(0) = -at + \frac{a}{\sqrt{\pi}} \sum_{k=1}^{\infty} \int_0^\infty u^{-\frac{3}{2}} e^{-(ut^2 + \frac{a^2k^2}{4u})} du = -at - 2\log(1 - e^{-at}).$$

Using the similar method as in (3.1) and (3.3), we have the following equalities.

$$\begin{aligned} &\frac{1}{2}\sum_{q=0}^{m}(-1)^{q+1} \cdot q \cdot \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{a\sqrt{\Delta_M^q + t^2}}}{\left(e^{a\sqrt{\Delta_M^q + t^2}} - \mathrm{Id}\right)^2} \left( \mathrm{Id} - \frac{\widetilde{\varphi}_q^* + (\widetilde{\varphi^{-1}})_q^*}{2} \right) \right\} \end{aligned}$$
(3.14)  

$$&= \frac{1}{2}\sum_{q=0}^{m-1}(-1)^q \log \det_{Fr} \left\{ \mathrm{Id} + \frac{2e^{at}}{(e^{at} - 1)^2} \left( \mathrm{Id} - \frac{\varphi_q^* + (\varphi_q^{-1})^*}{2} \right) \right\} \bigg|_{\mathcal{H}^q(M)}$$

$$&= -\chi(M) \log \left( 1 - e^{-at} \right) + \frac{1}{2}\sum_{q=0}^{m-1}(-1)^q \log \det_{Fr} \left( \mathrm{Id} - e^{-at}\varphi_q^* \right) \left( \mathrm{Id} - e^{-at}(\varphi_q^{-1})^* \right)$$

$$&= -\chi(M) \log \left( 1 - e^{-at} \right) + \frac{1}{2}\sum_{q=0}^{m-1}(-1)^q \operatorname{Tr} \log \left( \mathrm{Id} - e^{-at}\varphi_q^* \right) + \frac{1}{2}\sum_{q=0}^{m-1}(-1)^q \operatorname{Tr} \log \left( \mathrm{Id} - e^{-at}(\varphi_q^{-1})^* \right)$$

$$&= -\chi(M) \log \left( 1 - e^{-at} \right) - \frac{1}{2}\sum_{q=0}^{m-1}(-1)^q \operatorname{Tr} \sum_{k=1}^{\infty} \frac{e^{-akt}}{k} (\varphi_q^*)^k - \frac{1}{2}\sum_{q=0}^{m-1}(-1)^q \operatorname{Tr} \sum_{k=1}^{\infty} \frac{e^{-akt}}{k} ((\varphi_q^{-1})^*)^k$$

$$&= -\chi(M) \log \left( 1 - e^{-at} \right) - \frac{1}{2}\sum_{k=1}^{\infty} \frac{e^{-akt}L(\varphi^k)}{k} - \frac{1}{2}\sum_{k=1}^{\infty} \frac{e^{-akt}L((\varphi^{-1})^k)}{k}$$

$$&= -\chi(M) \log \left( 1 - e^{-at} \right) - \sum_{k=1}^{\infty} \frac{L(\varphi^k)e^{-akt}}{k},$$

where we used Lemma 3.3 in the last equality. Finally, we obtain the following result.

**Theorem 3.4.** Let  $\varphi : (M, g^M) \to (M, g^M)$  be an isometry on a compact oriented Riemannian manifold  $(M, g^M)$  and  $M_{\varphi}$  be the metric mapping torus associated to  $\varphi$ . Then,

$$\log T(M_{\varphi}, t) = \frac{a}{2} \chi(M) t - \sum_{k=1}^{\infty} \frac{L(\varphi^k) e^{-akt}}{k} = \frac{a}{2} \chi(M) t - \log \zeta_{\varphi}(e^{-at}).$$

In particular, if dim M is odd and  $\varphi$  is orientation preserving, then  $\log T(M_{\varphi}, t) = 0$ .

*Remark* : In Theorem 4.9 of [5], D. Burghelea and S. Haller obtained the result corresponding to Theorem 3.4 only when  $\varphi : M \to M$  is a diffeomorphism. However, we give an elementary proof by using the BFK-gluing formula when  $\varphi$  is an isometry.
