# SHARPER BOUNDS FOR THE NUMERICAL RADIUS OF $n \times n$ OPERATOR MATRICES II

#### Abstract

Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where each $A_{i j}$ is a bounded linear operator on a complex Hilbert space $\mathcal{H}$. With other numerical radius bounds via contraction operators, we show that $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right]$ is an $n \times n$ complex matrix with $$
a_{i j}=\left\{\begin{array}{l} w\left(A_{i i}\right) \quad \text { if } i=j \\ \min _{0 \leq t \leq 1}\left\|\left|A_{i j}\right|^{2 t}+\left|A_{j i}^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|A_{i j}^{*}\right|^{2(1-t)}+\left|A_{j i}\right|^{2(1-t)}\right\|^{1 / 2} \quad \text { if } i<j \\ 0 \quad \text { if } i>j . \end{array}\right.
$$

This bound refines the well known bound $w(A) \leq w(\hat{A})$, where $\hat{A}=\left[\hat{a}_{i j}\right]$ is an $n \times n$ matrix with $\hat{a}_{i j}=w\left(A_{i i}\right)$ if $i=j$ and $\hat{a}_{i j}=\left\|A_{i j}\right\|$ if $i \neq j$ [Linear Algebra Appl. 468 (2015), 18-26]. We deduce that if $A, B$ are bounded linear operators on $\mathcal{H}$, then $w\left(\left[\begin{array}{cc}0 & A \\ B & 0\end{array}\right]\right) \leq \frac{1}{2}\left\||A|^{2 t}+\left|B^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|A^{*}\right|^{2(1-t)}+|B|^{2(1-t)}\right\|^{1 / 2} \quad$ for all $t \in[0,1]$. Further by applying the numerical radius bounds of operator matrices, we deduce some numerical radius bounds for a single operator, the product of two operators, the commutator of operators. We show that if $A$ is a bounded linear operator on $\mathcal{H}$, then $w(A) \leq \frac{1}{2}\|A\|^{t}\left\||A|^{1-t}+\left|A^{*}\right|^{1-t}\right\| \quad$ for all $t \in[0,1]$, which refines as well as generalizes the existing ones.


## 1. Introduction

Let $\mathcal{B}(\mathcal{H})$ denote the $C^{*}$-algebra of all bounded linear operators on a complex Hilbert space $\mathcal{H}$. If $\mathcal{H}$ is an $n$-dimensional Hilbert space, then $\mathcal{B}(\mathcal{H})$ is identified with $\mathcal{M}_{n}(\mathbb{C})$, the set of all $n \times n$ complex matrices. For $A \in \mathcal{B}(\mathcal{H})$, let $|A|=\left(A^{*} A\right)^{1 / 2}$ and $\left|A^{*}\right|=$ $\left(A A^{*}\right)^{1 / 2}$, where $A^{*}$ is the Hilbert adjoint of $A$. Let $r(A),\|A\|$ and $w(A)$ denote the spectral radius, the operator norm and the numerical radius of $A$, respectively. Recall that $\|A\|=\sup \{\|A x\|: x \in \mathcal{H},\|x\|=1\}$ and $w(A)=\sup \{|\langle A x, x\rangle|: x \in \mathcal{H},\|x\|=1\}$. The numerical radius, $w(\cdot): \mathcal{B}(\mathcal{H}) \rightarrow \mathbb{R}$ defines a norm on $\mathcal{B}(\mathcal{H})$ and it satisfies $\frac{1}{2}\|A\| \leq w(A) \leq\|A\|$, for every $A \in \mathcal{B}(\mathcal{H})$. Here $w(A)=\|A\|=r(A)$ if $A$ is normal and $w(A)=\frac{1}{2}\|A\|$ if $A^{2}=0$. A complete characterization of $w(A)=\frac{1}{2}\|A\|$ is given in [5]. Analogous to the operator norm, the numerical radius satisfies $w\left(A^{n}\right) \leq w^{n}(A)$, for every positive integer $n$, and $w\left(A^{n}\right)=w^{n}(A)$ if $A$ is normal. For further readings

[^0]on the numerical radius, we refer to [7, 16]. It is well known that ([10, p. 44] and [4]) if $A=\left[a_{i j}\right]$ is an $n \times n$ complex matrix such that $a_{i j} \geq 0$ for all $i, j=1,2, \ldots, n$, then

w(A)=\frac{1}{2} w\left(A+A^{*}\right)=\frac{1}{2} r\left(A+A^{*}\right) . \tag{1.1}
\end{equation*}

Therefore, the spectral radius monotonicity of matrices with non-negative entries (see in [11, p. 491] implies that if $A=\left[a_{i j}\right]$ and $B=\left[b_{i j}\right]$ are $n \times n$ complex matrices with $0 \leq a_{i j} \leq b_{i j}$ for all $i, j=1,2, \ldots, n$, then $w(A) \leq w(B)$.
Let $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. Then $A=\left[A_{i j}\right] \in \mathcal{B}\left(\oplus_{i=1}^{n} \mathcal{H}\right)$ is an $n \times n$ operator matrix. The operator matrices, a useful tool to study Hilbert space operators, have been studied over the years, see [9]. In 1995, Hou and Du [12] proved that

\end{equation*}
$$

Then, in 2015, Abu-Omar and Kittaneh [1] provided a refinement of (1.2), namely, $w(A) \leq w(\tilde{A}) \quad$ where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

\left\|A_{i j}\right\| & \text { if } i \neq j
\end{array}\right.
$$

Recently, in 2024, Bhunia [2, Corollary 2.4] developed a refinement of (1.3), namely, $w(A) \leq w(\tilde{A}) \quad$ where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

\left\|\left|A_{i j}\right|+\left|A_{j i}^{*}\right|\right\|^{1 / 2}\left\|\left|A_{j i}\right|+\left|A_{i j}^{*}\right|\right\|^{1 / 2} \quad \text { if } i<j \\
0 \quad \text { if } i>j .
\end{array}\right.
$$

In this paper, we obtain a refinement of (1.4). Among other numerical radius bounds, we prove that $w(A) \leq w(\tilde{A})$ where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

\left.\quad \times\left\|\left|A_{i j}^{*}\right|^{1 / 2}\left|K_{i j}^{*}\right|\left|A_{i j}^{*}\right|^{1 / 2}+\left|A_{j i}\right|^{1 / 2}\left|K_{j i}\right|\left|A_{j i}\right|^{1 / 2}\right\|^{1 / 2}\right) \quad \text { if } i<j \\
0 \quad \text { if } i>j,
\end{array}\right.
$$

where $K_{i j}$, for all $i, j=1,2, \ldots, n$, are contractions satisfy $A_{i j}=\left|A_{i j}^{*}\right|^{1 / 2} K_{i j}\left|A_{i j}\right|^{1 / 2}$. We also deduce the numerical radius bounds for certain $2 \times 2$ operator matrices. Applying the numerical radius bounds for operator matrices, we deduce some new numerical radius bounds for a single operator, the product of two operators, the sum of the product of two pairs of operators and the commutator of operators. We consider computational examples to illustrate the results.

## 2. Main Results

First we develop upper bounds for the numerical radius of $n \times n$ operator matrices which improve the bounds (1.3) and (1.4). To achieve the results we need the following lemma.

Lemma 2.1. [6, Proposition 3.4] Let $A \in \mathcal{B}(\mathcal{H})$ and let $f, g$ be non-negative continuous functions on $[0, \infty)$ such that $f(\lambda) g(\lambda)=\lambda, \lambda \geq 0$. Then there exists a contraction $K$ (i.e., $\|K\| \leq 1$ ), where $A=g\left(\left|A^{*}\right|\right) K f(|A|)$, such that $|\langle A x, y\rangle|^{2} \leq$ $\langle f(|A|)| K|f(|A|) x, x\rangle\left\langle g\left(\left|A^{*}\right|\right)\right| K^{*}\left|g\left(\left|A^{*}\right|\right) y, y\right\rangle$ for all $x, y \in \mathcal{H}$.

We now obtain an upper bound for the numerical radius of $n \times n$ operator matrices which improves (1.3).

Theorem 2.2. Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. Let $f_{i j}$ and $g_{i j}$ be non-negative continuous functions on $[0, \infty)$ such that $f_{i j}(\lambda) g_{i j}(\lambda)=\lambda, \lambda \geq 0$. Then there exist contractions $K_{i j}$, where $A_{i j}=$ $g_{i j}\left(\left|A_{i j}^{*}\right|\right) K_{i j} f_{i j}\left(\left|A_{i j}\right|\right)$, such that $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\left\|f_{i j}\left(\left|A_{i j}\right|\right)\left|K_{i j}\right| f_{i j}\left(\left|A_{i j}\right|\right)\right\|^{1 / 2}\left\|g_{i j}\left(\left|A_{i j}^{*}\right|\right)\left|K_{i j}^{*}\right| g_{i j}\left(\left|A_{i j}^{*}\right|\right)\right\|^{1 / 2} \quad \text { if } i \neq j
\end{array}\right.
$$

Proof. Let $x=\left[\begin{array}{c}x_{1} \\ x_{2} \\ \vdots \\ x_{n}\end{array}\right] \in \oplus_{i=1}^{n} \mathcal{H}$ with $\|x\|=1$, i.e., $\left\|x_{1}\right\|^{2}+\left\|x_{2}\right\|^{2}+\ldots+\left\|x_{n}\right\|^{2}=1$. Then, using Lemma 2.1, we have

|\langle A x, x\rangle| & =\left|\sum_{i, j=1}^{n}\left\langle A_{i j} x_{j}, x_{i}\right\rangle\right| \\
& \leq \sum_{i, j=1}^{n}\left|\left\langle A_{i j} x_{j}, x_{i}\right\rangle\right|=\sum_{i=1}^{n}\left|\left\langle A_{i i} x_{i}, x_{i}\right\rangle\right|+\sum_{\substack{i, j=1 \\
i \neq j}}^{n}\left|\left\langle A_{i j} x_{j}, x_{i}\right\rangle\right| \\
& \leq \sum_{i=1}^{n}\left|\left\langle A_{i i} x_{i}, x_{i}\right\rangle\right| \\
& +\sum_{\substack{i, j=1 \\
i \neq j}}^{n}\left\langle f_{i j}\left(\left|A_{i j}\right|\right)\right| K_{i j}\left|f_{i j}\left(\left|A_{i j}\right|\right) x_{j}, x_{j}\right\rangle^{1 / 2}\left\langle g_{i j}\left(\left|A_{i j}^{*}\right|\right)\right| K_{i j}^{*}\left|g_{i j}\left(\left|A_{i j}^{*}\right|\right) x_{i}, x_{i}\right\rangle^{1 / 2} .
\end{aligned}
$$

Therefore, we obtain

$$
\begin{aligned}
|\langle A x, x\rangle| & \leq \sum_{i=1}^{n} w\left(A_{i i}\right)\left\|x_{i}\right\|^{2} \\
& +\sum_{\substack{i, j=1 \\
i \neq j}}^{n}\left\|f_{i j}\left(\left|A_{i j}\right|\right)\left|K_{i j}\right| f_{i j}\left(\left|A_{i j}\right|\right)\right\|^{1 / 2}\left\|g_{i j}\left(\left|A_{i j}^{*}\right|\right)\left|K_{i j}^{*}\right| g_{i j}\left(\left|A_{i j}^{*}\right|\right)\right\|^{1 / 2}\left\|x_{i}\right\|\left\|x_{j}\right\| \\
& =\langle\tilde{A}| x|,|x|\rangle
\end{aligned}
$$

where $|x|=\left[\begin{array}{c}\left\|x_{1}\right\| \\ \left\|x_{2}\right\| \\ \vdots \\ \left\|x_{n}\right\|\end{array}\right]$ is an unit vector in $\mathbb{C}^{n}$. Therefore, $|\langle A x, x\rangle| \leq w(\tilde{A})$ for all $x \in \oplus_{i=1}^{n} \mathcal{H}$ with $\|x\|=1$. This gives $w(A) \leq w(\tilde{A})$.

Considering $f_{i j}(\lambda)=\lambda^{t}$ and $g_{i j}(\lambda)=\lambda^{1-t}(0 \leq t \leq 1)$ in Theorem 2.2, we get
Corollary 2.3. Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. Then there exist contractions $K_{i j}$, where $A_{i j}=\left|A_{i j}^{*}\right|^{1-t} K_{i j}\left|A_{i j}\right|^{t}$ $(0 \leq t \leq 1)$, such that $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i} \quad \text { if } i=j\right. \\
\left\|\left|A_{i j}\right|^{t}\left|K_{i j}\right|\left|A_{i j}\right|^{t}\right\|^{1 / 2}\left\|| | A _ { i j } ^ { * } | ^ { 1 - t } \left|K_{i j}^{*}\left\|\left.A_{i j}^{*}\right|^{1-t}\right\|^{1 / 2} \quad \text { if } i \neq j .\right.\right.
\end{array}\right.

In particular, for $t=1 / 2$, we have $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i} \quad \text { if } i=j\right. \\
\left\|| A _ { i j } | ^ { 1 / 2 } \left|K _ { i j } \| A _ { i j } | ^ { 1 / 2 } \| ^ { 1 / 2 } \left\|| A _ { i j } ^ { * } | ^ { 1 / 2 } \left|K_{i j}^{*}\left\|\left.A_{i j}^{*}\right|^{1 / 2}\right\|^{1 / 2} \quad \text { if } i \neq j .\right.\right.\right.\right.
\end{array}\right.
$$

Remark 2.4. Since $\left|K_{i j}\right| \leq 1$ and $\left|K_{i j}^{*}\right| \leq 1$, so $\left|A_{i j}\right|^{1 / 2}\left|K_{i j}\right|\left|A_{i j}\right|^{1 / 2} \leq\left|A_{i j}\right|$ and $\left|A_{i j}^{*}\right|^{1 / 2}\left|K_{i j}^{*}\right|\left|A_{i j}^{*}\right|^{1 / 2} \leq\left|A_{i j}^{*}\right|$. Thus, $\left\|\left|A_{i j}\right|^{1 / 2}\left|K_{i j}\right|\left|A_{i j}\right|^{1 / 2}\right\|^{1 / 2}\left\|\left|A_{i j}^{*}\right|^{1 / 2}\left|K_{i j}^{*}\right|\left|A_{i j}^{*}\right|^{1 / 2}\right\|^{1 / 2} \leq$ $\left\|A_{i j}\right\|$. Therefore, the numerical radius bound (1.3) follows from Corollary 2.3.
We now obtain another upper bound for the numerical radius of $n \times n$ operator matrices which improves (1.4).
Theorem 2.5. Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. Let $f_{i j}$ and $g_{i j}$ be non-negative continuous functions on $[0, \infty)$ such that $f_{i j}(\lambda) g_{i j}(\lambda)=\lambda, \lambda \geq 0$. Then there exist contractions $K_{i j}$, where $A_{i j}=$ $g_{i j}\left(\left|A_{i j}^{*}\right|\right) K_{i j} f_{i j}\left(\left|A_{i j}\right|\right)$, such that $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

\left.\quad \times\left\|g_{i j}\left(\left|A_{i j}^{*}\right|\right)\left|K_{i j}^{*}\right| g_{i j}\left(\left|A_{i j}^{*}\right|\right)+f_{j i}\left(\left|A_{j i}\right|\right)\left|K_{j i}\right| f_{j i}\left(\left|A_{j i}\right|\right)\right\|^{1 / 2}\right) \quad \text { if } i<j \\
0 \quad \text { if } i>j .
\end{array}\right.
$$

Proof. Let $x=\left[\begin{array}{c}x_{1} \\ x_{2} \\ \vdots \\ x_{n}\end{array}\right] \in \oplus_{i=1}^{n} \mathcal{H}$ with $\|x\|=1$, i.e., $\left\|x_{1}\right\|^{2}+\left\|x_{2}\right\|^{2}+\ldots+\left\|x_{n}\right\|^{2}=1$.
Then, using Lemma 2.1, we have

& \leq \sum_{i, j=1}^{n}\left|\left\langle A_{i j} x_{j}, x_{i}\right\rangle\right|=\sum_{i=1}^{n}\left|\left\langle A_{i i} x_{i}, x_{i}\right\rangle\right|+\sum_{\substack{i, j=1 \\
i \neq j}}^{n}\left|\left\langle A_{i j} x_{j}, x_{i}\right\rangle\right| \\
& =\sum_{i=1}^{n}\left|\left\langle A_{i i} x_{i}, x_{i}\right\rangle\right|+\sum_{\substack{i, j=1 \\
i<j}}^{n}\left(\left|\left\langle A_{i j} x_{j}, x_{i}\right\rangle\right|+\left|\left\langle A_{j i} x_{i}, x_{j}\right\rangle\right|\right) \\
& \leq \sum_{i=1}^{n}\left|\left\langle A_{i i} x_{i}, x_{i}\right\rangle\right| \\
& +\sum_{\substack{i, j=1 \\
i<j}}^{n}\left(\left\langle f_{i j}\left(\left|A_{i j}\right|\right)\right| K_{i j}\left|f_{i j}\left(\left|A_{i j}\right|\right) x_{j}, x_{j}\right\rangle^{1 / 2}\left\langle g_{i j}\left(\left|A_{i j}^{*}\right|\right)\right| K_{i j}^{*}\left|g_{i j}\left(\left|A_{i j}^{*}\right|\right) x_{i}, x_{i}\right\rangle^{1 / 2}\right. \\
& \left.+\left\langle f_{j i}\left(\left|A_{j i}\right|\right)\right| K_{j i}\left|f_{j i}\left(\left|A_{j i}\right|\right) x_{i}, x_{i}\right\rangle^{1 / 2}\left\langle g_{j i}\left(\left|A_{j i}^{*}\right|\right)\right| K_{j i}^{*}\left|g_{j i}\left(\left|A_{j i}^{*}\right|\right) x_{j}, x_{j}\right\rangle^{1 / 2}\right) .
\end{aligned}
$$

Therefore, from the Cauchy-Schwarz inequality, we get

+ & \sum_{\substack{i, j=1 \\
i<j}}^{n}\left(\left\|f_{i j}\left(\left|A_{i j}\right|\right)\left|K_{i j}\right| f_{i j}\left(\left|A_{i j}\right|\right)+g_{j i}\left(\left|A_{j i}^{*}\right|\right)\left|K_{j i}^{*}\right| g_{j i}\left(\left|A_{j i}^{*}\right|\right)\right\|^{1 / 2}\right. \\
& \left.\times\left\|g_{i j}\left(\left|A_{i j}^{*}\right|\right)\left|K_{i j}^{*}\right| g_{i j}\left(\left|A_{i j}^{*}\right|\right)+f_{j i}\left(\left|A_{j i}\right|\right)\left|K_{j i}\right| f_{j i}\left(\left|A_{j i}\right|\right)\right\|^{1 / 2}\right)\left\|x_{i}\right\|\left\|x_{j}\right\| \\
= & \langle\tilde{A}| x|,|x|\rangle
\end{aligned}

where $|x|=\left[\begin{array}{c}\left\|x_{1}\right\| \\ \left\|x_{2}\right\| \\ \vdots \\ \left\|x_{n}\right\|\end{array}\right]$ is an unit vector in $\mathbb{C}^{n}$. Therefore, $|\langle A x, x\rangle| \leq w(\tilde{A})$ for all
$x \in \oplus_{i=1}^{n} \mathcal{H}$ with $\|x\|=1$ and so $w(A) \leq w(\tilde{A})$.
Considering $f_{i j}(\lambda)=\lambda^{t}, g_{i j}(\lambda)=\lambda^{1-t}$ where $i<j$ and $f_{j i}(\lambda)=\lambda^{1-t}, g_{j i}(\lambda)=\lambda^{t}$ where $i<j(0 \leq t \leq 1)$ in Theorem 2.5, we obtain

Corollary 2.6. Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. Then there exist contractions $K_{i j}$, where $A_{i j}=\left|A_{i j}^{*}\right|^{1-t} K_{i j}\left|A_{i j}\right|^{t}$ and $A_{j i}=\left|A_{j i}^{*}\right|^{t} K_{j i}\left|A_{j i}\right|^{1-t}, i<j(0 \leq t \leq 1)$, such that $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

w\left(A_{i i}\right) \quad \text { if } i=j \\
\left(\left\|| A _ { i j } | ^ { t } \left|K_{i j}\left\|\left.A_{i j}\right|^{t}+\left|A_{j i}^{*}\right|^{t}\left|K_{j i}^{*}\right|\left|A_{j i}^{*}\right|^{t}\right\|^{1 / 2}\right.\right.\right. \\
\quad \times\left\|\left|A_{i j}^{*}\right|^{1-t}\left|K_{i j}^{*}\right|\left|A_{i j}^{*}\right|^{1-t}+\left|A_{j i}\right|^{1-t}\left|K_{j i}\left\|\left.A_{j i}\right|^{1-t}\right\|^{1 / 2}\right) \quad \text { if } i<j\right. \\
0 \quad \text { if } i>j .
\end{array}\right.
$$

Again, considering $f_{i j}(\lambda)=\lambda^{t}$ and $g_{i j}(\lambda)=\lambda^{1-t}$ for all $i \neq j(0 \leq t \leq 1)$ in Theorem 2.5, we obtain

Corollary 2.7. Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. Then there exist contractions $K_{i j}$, where $A_{i j}=\left|A_{i j}^{*}\right|^{1-t} K_{i j}\left|A_{i j}\right|^{t}$ $(0 \leq t \leq 1)$, such that $w(A) \leq w(\tilde{A})$ where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

$$
a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\left(\left\|\left|A_{i j}\right|^{t}\left|K_{i j}\right|\left|A_{i j}\right|^{t}+\left|A_{j i}^{*}\right|^{1-t}\left|K_{j i}^{*}\left\|\left.A_{j i}^{*}\right|^{1-t}\right\|^{1 / 2}\right.\right.\right. \\
\left.\quad \times\left\|\left|A_{i j}^{*}\right|^{1-t}\left|K_{i j}^{*}\right|\left|A_{i j}^{*}\right|^{1-t}+\left|A_{j i}\right|^{t}\left|K_{j i}\right|\left|A_{j i}\right|^{t}\right\|^{1 / 2}\right) \quad \text { if } i<j \\
0 \quad \text { if } i>j .
\end{array}\right.
$$

In particular, for $t=1 / 2$, we have $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

$$
a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\left(\left\|\left|A_{i j}\right|^{1 / 2}\left|K_{i j}\right|\left|A_{i j}\right|^{1 / 2}+\left|A_{j i}^{*}\right|^{1 / 2}\left|K_{j i}^{*}\right|\left|A_{j i}^{*}\right|^{1 / 2}\right\|^{1 / 2}\right. \\
\left.\quad \times\left\|\left|A_{i j}^{*}\right|^{1 / 2}\left|K_{i j}^{*}\right|\left|A_{i j}^{*}\right|^{1 / 2}+\left|A_{j i}\right|^{1 / 2}\left|K_{j i}\right|\left|A_{j i}\right|^{1 / 2}\right\|^{1 / 2}\right) \quad \text { if } i<j \\
0 \quad \text { if } i>j .
\end{array}\right.
$$

Remark 2.8. Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. For any contraction $K$, we have $|K| \leq 1$ and $\left|K^{*}\right| \leq 1$. Therefore, Corollary 2.6 and Corollary 2.7 give the following bounds for the numerical radius.
(i) $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

$$
a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\left\|\left|A_{i j}\right|^{2 t}+\left|A_{j i}^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|A_{i j}^{*}\right|^{2(1-t)}+\left|A_{j i}\right|^{2(1-t)}\right\|^{1 / 2} \quad \text { if } i<j \\
0 \quad \text { if } i>j .
\end{array}\right.
$$

(ii) $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

$$
a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\left\|\left|A_{i j}\right|^{2 t}+\left|A_{j i}^{*}\right|^{2(1-t)}\right\|^{1 / 2}\left\|\left|A_{i j}^{*}\right|^{2(1-t)}+\left|A_{j i}\right|^{2 t}\right\|^{1 / 2} \quad \text { if } i<j \\
0 \quad \text { if } i>j
\end{array}\right.
$$

(iii) $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

$$
a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\left\|\left|A_{i j}\right|+\left|A_{j i}^{*}\right|\right\|^{1 / 2}\left\|\left|A_{i j}^{*}\right|+\left|A_{j i}\right|\right\|^{1 / 2} \quad \text { if } i<j \\
0 \quad \text { if } i>j .
\end{array}\right.
$$

The inequalities in (ii) and (iii) are also proved in [2] and these bounds refine the bound (1.3), see [2, Remark 2.5].

Remark 2.9. (i) Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. Observe that if we choose $f_{i j}(\lambda)=\lambda^{t_{i j}}, g_{i j}(\lambda)=\lambda^{1-t_{i j}}$ where $i<j$
and $f_{j i}(\lambda)=\lambda^{1-t_{j i}}, g_{j i}(\lambda)=\lambda^{t_{j i}}$ where $i<j\left(0 \leq t_{i j} \leq 1\right)$ in Theorem 2.5, then we deduce that $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

$$
a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\min _{0 \leq t \leq 1}\left\|\left|A_{i j}\right|^{2 t}+\left|A_{j i}^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|A_{i j}^{*}\right|^{2(1-t)}+\left|A_{j i}\right|^{2(1-t)}\right\|^{1 / 2} \quad \text { if } i<j \\
0 \quad \text { if } i>j .
\end{array}\right.
$$

(ii) Similarly, from Theorem 2.5 we also deduce that $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in$ $\mathcal{M}_{n}(\mathbb{C})$ with

$$
a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\min _{0 \leq t \leq 1}\left\|\left|A_{i j}\right|^{2 t}+\left|A_{j i}^{*}\right|^{2(1-t)}\right\|^{1 / 2}\left\|\left|A_{i j}^{*}\right|^{2(1-t)}+\left|A_{j i}\right|^{2 t}\right\|^{1 / 2} \quad \text { if } i<j \\
0 \quad \text { if } i>j
\end{array}\right.
$$

Clearly, bounds in (i) and (ii) of Remark 2.9 are stronger than the same in (iii) of Remark 2.8, which is given in [2, Corollary 2.4].

Now, from Remark 2.9 (i) (for $t=1, t=0$ ) and using the relation (1.1), we get
Proposition 2.10. Let $A=\left[A_{i j}\right]$ be an $n \times n$ operator matrix where $A_{i j} \in \mathcal{B}(\mathcal{H})$ for all $i, j=1,2, \ldots, n$. Then $w(A) \leq w(\tilde{A})$, where $\tilde{A}=\left[a_{i j}\right] \in \mathcal{M}_{n}(\mathbb{C})$ with

$$
a_{i j}=\left\{\begin{array}{l}
w\left(A_{i i}\right) \quad \text { if } i=j \\
\min \left\{\sqrt{\left\|\frac{\left|A_{i j}\right|^{2}+\left|A_{j i}^{*}\right|^{2}}{2}\right\|}, \sqrt{\left\|\frac{\left|A_{i j}^{*}\right|^{2}+\left|A_{j i}\right|^{2}}{2}\right\|}\right\} \quad \text { if } i \neq j .
\end{array}\right.
$$

Remark 2.11. (i) Clearly, when $\left\|A_{i j}\right\|=\left\|A_{j i}\right\|$ for all $i, j=1,2, \ldots, n$, then both the bounds in Proposition 2.10 refine the same in (1.3). To show proper refinement we consider an example. Take $n=2$ and $A_{11}=A_{22}=0, A_{12}=A_{21}=\left[\begin{array}{ll}0 & 1 \\ 0 & 0\end{array}\right]$. Then the bounds in Proposition 2.10 gives $w(A) \leq \frac{1}{\sqrt{2}}$, whereas the bound (1.3) gives $w(A) \leq 1$. (ii) Consider $n=2, A_{11}=C, A_{22}=D, A_{12}=A, A_{21}=B$ in Proposition 2.10, we get

$$
\begin{aligned}
w\left(\left[\begin{array}{ll}
C & A \\
B & D
\end{array}\right]\right) & \leq \frac{1}{2}(w(C)+w(D)) \\
& +\sqrt{\frac{1}{4}(w(C)-w(D))^{2}+\frac{1}{2} \min \left\{\left\||A|^{2}+\left|B^{*}\right|^{2}\right\|,\left\|\left|A^{*}\right|^{2}+|B|^{2}\right\|\right\}}
\end{aligned}
$$

(iii) Consider $C=D=0$ in (ii), we get

$$
w\left(\left[\begin{array}{cc}
0 & A  \tag{2.1}\\
B & 0
\end{array}\right]\right) \leq \min \left\{\sqrt{\frac{1}{2}\left\||A|^{2}+\left|B^{*}\right|^{2}\right\|}, \sqrt{\left.\frac{1}{2} \|\left|A^{*}\right|^{2}+|B|^{2} \right\rvert\,}\right\}
$$

This bound refines the upper bound in [8, Theorem 2.2], namely, w $\left(\left[\begin{array}{cc}0 & A \\ B & 0\end{array}\right]\right) \leq$ $\max \left\{\sqrt{\frac{1}{2}\left\||A|^{2}+\left|B^{*}\right|^{2}\right\|}, \sqrt{\frac{1}{2}\left\|\left|A^{*}\right|^{2}+|B|^{2}\right\|}\right\}$.

By putting $n=2, A_{11}=A_{22}=0, A_{12}=A$ and $A_{21}=B$ in Remark 2.8 (i), we get

Proposition 2.12. Let $A, B \in \mathcal{B}(\mathcal{H})$. Then

$$
w\left(\left[\begin{array}{cc}
0 & A \\
B & 0
\end{array}\right]\right) \leq \frac{1}{2}\left\||A|^{2 t}+\left|B^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|A^{*}\right|^{2(1-t)}+|B|^{2(1-t)}\right\|^{1 / 2} \quad \text { for all } t \in[0,1] .
$$

In particular, for $t=1 / 2$,

$$
w\left(\left[\begin{array}{cc}
0 & A  \tag{2.2}\\
B & 0
\end{array}\right]\right) \leq \frac{1}{2}\left\||A|+\left|B^{*}\right|\right\|^{1 / 2}\left\|\left|A^{*}\right|+|B|\right\|^{1 / 2}
$$

Remark 2.13. Considering $A=B$ in Proposition 2.12, we obtain an upper bound for the numerical radius of a bounded linear operator, namely,

$$
\begin{equation*}
w(A) \leq \frac{1}{2}\left\||A|^{2 t}+\left|A^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|A^{*}\right|^{2(1-t)}+|A|^{2(1-t)}\right\|^{1 / 2} \quad \text { for all } t \in[0,1] \tag{2.3}
\end{equation*}
$$

Clearly,

$$
\frac{1}{2}\left\||A|^{2 t}+\left|A^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|A^{*}\right|^{2(1-t)}+|A|^{2(1-t)}\right\|^{1 / 2} \leq \sqrt{\frac{1}{2}\left\||A|^{2}+\left|A^{*}\right|^{2}\right\|} \quad \text { for all } t \in[0,1]
$$

Therefore, the bound (2.3) refines the bound $w(A) \leq \sqrt{\frac{1}{2}\left\||A|^{2}+\left|A^{*}\right|^{2}\right\|}$, proved by Kittaneh [14]. In particular, for $t=1 / 2$ in (2.3), we deduce the well known bound $w(A) \leq \frac{1}{2}\left\|| | A\left|+\left|A^{*}\right| \|\right.\right.$, proved by Kittaneh [15].

Remark 2.14. (i) Let $A, B \in \mathcal{B}(\mathcal{H})$. Using the argument $\frac{1}{2}\left\|A+A^{*}\right\| \leq w(A)$ and the inequality (2.2), we obtain that

$$
\frac{1}{2}\|A+B\| \leq w\left(\left[\begin{array}{cc}
0 & A  \tag{2.4}\\
B^{*} & 0
\end{array}\right]\right) \leq \frac{1}{2}\||A|+|B|\|^{1 / 2}\left\|\left|A^{*}\right|+\left|B^{*}\right|\right\|^{1 / 2}
$$

(ii) Clearly, if $B=0$, then $w\left(\left[\begin{array}{cc}0 & A \\ 0 & 0\end{array}\right]\right)=\frac{1}{2}\|A\|$. (iii) Clearly, if $B=A$, then $w\left(\left[\begin{array}{cc}0 & A \\ A^{*} & 0\end{array}\right]\right)=\|A\|$. (iv) If $A, B$ are positive, then $w\left(\left[\begin{array}{cc}0 & A \\ B & 0\end{array}\right]\right)=\frac{1}{2}\|A+B\|$. (v) If $A, B$ are normal, then $\|A+B\| \leq 2 w\left(\left[\begin{array}{cc}0 & A \\ B^{*} & 0\end{array}\right]\right) \leq\||A|+|B|\|$.

Applying the numerical radius bound in Remark 2.9 (i), we now obtain a numerical radius bound for the sum of the product of two pairs of operators.

Theorem 2.15. Let $A, B, C, D \in \mathcal{B}(\mathcal{H})$. Then

$$
\begin{aligned}
w(A B \pm C D) \leq & \frac{1}{4}\left(\left.\min _{t \in[0,1]}\left\||A|^{2 t}+\left|B^{*}\right|^{2 t}\right\|\| \| A^{*}\right|^{2(1-t)}+|B|^{2(1-t)} \|\right. \\
& \left.+\min _{t \in[0,1]}\left\||C|^{2 t}+\left|D^{*}\right|^{2 t}\right\|\left\|\left|C^{*}\right|^{2(1-t)}+|D|^{2(1-t)}\right\|\right)
\end{aligned}
$$

Proof. Considering $n=3, A_{11}=A_{22}=A_{33}=A_{23}=A_{32}=0, A_{12}=A, A_{13}=C$, $A_{21}=B$ and $A_{31}=D$ in Remark 2.9 (i), we obtain $w\left(\left[\begin{array}{ccc}0 & A & C \\ B & 0 & 0 \\ D & 0 & 0\end{array}\right]\right) \leq w\left(\left[\begin{array}{lll}0 & a & c \\ 0 & 0 & 0 \\ 0 & 0 & 0\end{array}\right]\right)$,
where $a=\min _{t \in[0,1]}\left\||A|^{2 t}+\left|B^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|A^{*}\right|^{2(1-t)}+|B|^{2(1-t)}\right\|^{1 / 2}$ and

$$
c=\min _{t \in[0,1]}\left\||C|^{2 t}+\left|D^{*}\right|^{2 t}\right\|^{1 / 2}\left\|\left|C^{*}\right|^{2(1-t)}+|D|^{2(1-t)}\right\|^{1 / 2}
$$

Therefore, now the desired bound follows from the proof of [2, Theorem 2.8].
Similarly, from Remark 2.9 (ii), we also obtain
Theorem 2.16. Let $A, B, C, D \in \mathcal{B}(\mathcal{H})$. Then

$$
\begin{aligned}
w(A B \pm C D) \leq & \frac{1}{4}\left(\min _{t \in[0,1]}\left\||A|^{2 t}+\left|B^{*}\right|^{2(1-t)}\right\|\left\|\left|A^{*}\right|^{2(1-t)}+|B|^{2 t}\right\|\right. \\
& \left.+\min _{t \in[0,1]}\left\||C|^{2 t}+\left|D^{*}\right|^{2(1-t)}\right\|\left\|\left|C^{*}\right|^{2(1-t)}+|D|^{2 t}\right\|\right) .
\end{aligned}
$$

Clearly, Theorem 2.16 is stronger than [2, Theorem 2.8]. Considering $C=B$ and $D=A$ in Theorem 2.15, we obtain the following numerical radius bound for the commutator of operators.

Corollary 2.17. Let $A, B \in \mathcal{B}(\mathcal{H})$. Then

$$
\begin{aligned}
w(A B \pm B A) \leq & \frac{1}{4}\left(\min _{t \in[0,1]}\left\||A|^{2 t}+\left|B^{*}\right|^{2 t}\right\|\left\|\left|A^{*}\right|^{2(1-t)}+|B|^{2(1-t)}\right\|\right. \\
& \left.+\min _{t \in[0,1]}\left\||B|^{2 t}+\left|A^{*}\right|^{2 t}\right\|\left\|\left|B^{*}\right|^{2(1-t)}+|A|^{2(1-t)}\right\|\right) .
\end{aligned}
$$

Put $t=\frac{1}{2}$, we get $w(A B \pm B A) \leq \frac{1}{2}\left\||A|+\left|B^{*}\right|\right\|| ||B|+\left|A^{*}\right| \|$, which is also proved in [2, Corollary 2.9]. Again, considering $C=D=0$ in Theorem 2.15, we obtain the following numerical radius bound for the product of two operators.

Corollary 2.18. If $A, B \in \mathcal{B}(\mathcal{H})$, then

$$
w(A B) \leq \frac{1}{4}\left\||A|^{2 t}+\left|B^{*}\right|^{2 t}\right\|\left\|\left|A^{*}\right|^{2(1-t)}+|B|^{2(1-t)}\right\|, \quad \text { for all } t \in[0,1]
$$

Remark 2.19. Put $t=1$ and $t=0$, we get $\max \{w(A B), w(B A)\} \leq \frac{1}{2}\left\||A|^{2}+\left|B^{*}\right|^{2}\right\|$. Also, for $t=\frac{1}{2}$, we get $w(A B) \leq \frac{1}{4}| ||A|+\left|B^{*}\right|| || | A^{*}|+|B| \|$, which is also proved in [2, Corollary 2.10].
Remark 2.20. (i) Considering $B=U, C=V$ and $D=A$ in Theorem 2.15, where $U$ and $V$ are unitary operators, we obtain

$$
w(A U \pm V A) \leq \frac{1}{2} \min _{t \in[0,1]}\left\||A|^{2 t}+I\right\|\left\|\left|A^{*}\right|^{2(1-t)}+I\right\|
$$

(ii) Similarly, considering $B=U, C=V$ and $D=A^{*}$ in Theorem 2.15, where $U$ and $V$ are unitary operators, we obtain

$$
w\left(A U \pm V A^{*}\right) \leq \frac{1}{2} \min _{t \in[0,1]}\left\||A|^{2 t}+I\right\|\left\|\left|A^{*}\right|^{2(1-t)}+I\right\|
$$

(iii) Considering $B=U$ in Corollary 2.18, where $U$ is an unitary operator, we obtain

$$
w(A U) \leq \frac{1}{4} \min _{t \in[0,1]}\left\||A|^{2 t}+I\right\|\left\|\left|A^{*}\right|^{2(1-t)}+I\right\|
$$

Finally, replacing $A$ and $B$ by $U|A|^{1 / 2}$ (where $A=U|A|$ is the polar decomposition) and $|A|^{1 / 2}$, respectively, in Corollary 2.18, we deduce the following numerical radius bound for a single bounded linear operator.

Proposition 2.21. If $A \in \mathcal{B}(\mathcal{H})$, then

$$
w(A) \leq\|A\|^{t}\left\|\frac{1}{2}\left(|A|^{1-t}+\left|A^{*}\right|^{1-t}\right)\right\|, \quad \text { for all } t \in[0,1]
$$

Remark 2.22. (i) Using the concavity property of $f(\lambda)=\lambda^{1-t}, \lambda \geq 0$, we see that $\|A\|^{t}\left\|\frac{1}{2}\left(|A|^{1-t}+\left|A^{*}\right|^{1-t}\right)\right\| \leq\|A\|^{t}\left\|\frac{1}{2}\left(|A|+\left|A^{*}\right|\right)\right\|^{1-t} \leq\|A\|$, for all $t \in[0,1]$. Hence, Proposition 2.21 refines the bound $w(A) \leq\|A\|$ for every $t \in[0,1]$.
(ii) Taking $t=1 / 2$ in Proposition 2.21, we get $w(A) \leq\|A\|^{1 / 2}\left\|\frac{1}{2}\left(|A|^{1 / 2}+\left|A^{*}\right|^{1 / 2}\right)\right\|$, which is also proved by Kittaneh et al. [13] and also see in [3]. Therefore, we obtain

$$
w(A) \leq \min _{t \in[0,1]}\|A\|^{t}\left\|\frac{1}{2}\left(|A|^{1-t}+\left|A^{*}\right|^{1-t}\right)\right\| \leq\|A\|^{1 / 2}\left\|\frac{1}{2}\left(|A|^{1 / 2}+\left|A^{*}\right|^{1 / 2}\right)\right\| .
$$

To show proper improvement we consider a matrix $A=\left[\begin{array}{lll}0 & 2 & 0 \\ 0 & 0 & 3 \\ 0 & 0 & 0\end{array}\right]$. Then we see that

$$
\min _{t \in[0,1]}\|A\|^{t}\left\|\frac{1}{2}\left(|A|^{1-t}+\left|A^{*}\right|^{1-t}\right)\right\|=\frac{5}{2}<\frac{3+\sqrt{6}}{2}=\|A\|^{1 / 2}\left\|\frac{1}{2}\left(|A|^{1 / 2}+\left|A^{*}\right|^{1 / 2}\right)\right\| .
$$
