Regular out of the singular: exacts results on top of a curvature singularity

By constructing a model of spacetime having a strong curvature singularity in which causal geodesics are complete, but more generic causal curves are not, we explicitly show that some electrostatic field configurations on that background are regular everywhere, including *there* where the spacetime ceases to be described by a pseudo-Riemannian manifold. Our calculations are performed using the analogue-gravity description provided by Plebanski and Tamm, according to which the characterization of the electromagnetic field on a generic curved background is equivalent to solving Maxwell's equations in flat space with a matter content verifying certain non-trivial constitutive relations. The regularity of the electric field in what could be considered the worst conceivable physical condition, opens the door to further investigation into the possibility of propagating signals capable of crossing a spacetime singularity.

I. INTRODUCTION

Spacetime singularities are inevitable consequences of gravitational theories constructed on the basis of pseudo-Riemannian geometry. As discovered in the nineteen seventies, their occurrence manifests not only in a large class of solutions in the context of General Relativity (GR), but virtually in any geometrically conceived framework describing gravity [1]. Plainly, a singularity is the endpoint of an incomplete causal curve, which in the specific case of a *strong curvature* singularity, represents the end of the world line of a particle in an event characterized by the unbounded growth of some scalar constructed from the curvature tensor. This is what happens in the paradigmatic well-known singularities present in the interior of most black hole solutions, and in the universal singular state representing the Big Bang in a variety of cosmological models. In the black hole case, not every causal curve or geodesic hits the singularity, but certainly an infinite number of them actually do. Antithetically, the cosmological singularity has a universal character because any causal geodesic is incomplete if its affine parameter (the proper time t in the case of timelike geodesics) is sufficiently extended into the past. Many other types of singularities are nowadays studied and classified, including a considerable amount appearing in circumstances not associated with divergences of curvature scalars, as in the case of quasi-regular singularities. The majority of key results in the area until the end of the past century are summarized in the standard textbooks [2]-[4], while later research is covered in the nice review articles [5] and [6]. More recently, a number of studies dealing with the possibility of crossing singularities, and thus connecting what otherwise were causally disconnected regions of the spacetime, show that the research in the area is still quite active, see, e.g., [7] and [8]. These developments are not only important from a conceptual point of view but also crucial, for instance, to support cosmological models where the present universe is powered by pre-Big Bang physics, as seems to be the case in conformal cyclic cosmology [9]; see also [10].

Singularities are not circumscribed to the behavior of causal curves and geodesics alone; sometimes, they are not necessarily associated with divergences of physical quantities related to the presence of matter fields in the spacetime, even though this is usually the case. For instance, there are geodesically complete cosmological spaces in which the pressure of the matter fields is divergent at some event, as in some cases of sudden singularities [11], [12]. Early examples [13], more closely aligned with our present concerns, show that some curvature singularities could leave no imprints on the matter fields acting as sources of the Einstein field equations. It is for this reason that, if our purpose is to assess the possibility that some signal or influence could traverse a curvature singularity, it is important to move away from the mere study of causal curves and geodesics. Bearing this intention in mind, our work is a tentative to contribute to this subject by examining the behavior of an electromagnetic (EM) field in a background containing a strong curvature singularity.

The study of the Maxwell field on curved backgrounds has a long history by itself. Classic, early references are [14] and [15], which settled the language used later in the late nineteen seventies and early eighties in the realm of astrophysics, mostly in relation to the study of accretiondisks magnetospheres in pulsars and black holes; see, for instance, [16]-[18]. More modern and formal developments were considered in [19] and [20], and it is clear that the subject is far from over, as evidenced by some recent progress alluding to the propagation of guided waves in the spacetime, see [21].

Our approach to the characterization of the EM field is slightly different. We will make use of the Plebanski-Tamm (PT) formalism, which allows us to

solve Maxwell's equations in a curved background as if they were the *usual* EM equations in a flat-space material medium with peculiar constitutive relations. This gravito-optic correspondence is framed in the context of analogue gravity models; see, e.g., [22] and [23]. When it works, it has at least two benefits: on the one hand, it provides a clear and physically more transparent 3D visualization of inherently 3+1-dimensional phenomena. On the other, it tends a bridge between gravitational physics and its potential experimental testing in the lab. Keen discussions on the actual experimental feasibility of this approach can be found in [24].

This article is structured as follows. In Section II, we briefly review the gravito-optic PT analogy and discuss a couple of facts related to the propagation of waves in such a context. The toy model representing the spacetime hosting a strong, naked curvature singularity is introduced and studied in detail in Section III. Section IV is entirely dedicated to solving the electrostatic PT equations in the material medium provided by the toy model constructed in the previous section. Our notation is as follows: vector and second rank tensor components will be denoted using Greek indices v_{μ} and $g_{\mu\nu}$, respectively, where $\mu, \nu : 0, 1, 2, 3$, or Latin indices, v_i and g_{ij} , if i, j : 1, 2, 3. Three dimensional vector objects, will in turn be denoted by \bar{v} , and their scalar, vector and tensor products as $\bar{v} \cdot \bar{w}$, $\bar{v} \times \bar{w}$ and $\bar{v} \otimes \bar{w}$, respectively. Scalar products of row and column vectors will be written without dots, as in $\bar{v}^{\mathsf{T}}\bar{w}$, where T means transposition. Moreover, 3D-matrices will be written as K. Cartesian vector and matrix components will be written v_i and K_{ij} , respectively. The product of a matrix **K** by a vector \bar{v} will be simply $\mathbf{K}\bar{v}$. All the components in 3D will be referred to a Cartesian coordinate system $\bar{x} = (x_1, x_2, x_3)$ or $\bar{x} = (x, y, z)$, as in Sections III and IV. Finally, we are using units in which $c = (\epsilon_0 \mu_0)^{-1/2} = 1$.

II. PLEBANSKI-TAMM MEDIA

Classical electromagnetism without sources in a fourdimensional curved background with line element $ds^2 = g_{\mu\nu}dx^{\mu}dx^{\nu}$, is described by the covariant Maxwell sourcefree equations

$$F^{\mu\nu}_{\ ;\mu} = 0, \ (\epsilon^{\mu\nu\rho\sigma}F_{\rho\sigma})_{,\mu} = 0, \ (1)$$

where $F_{\mu\nu} = A_{\nu,\mu} - A_{\mu,\nu}$, and $A_{\mu} = (\phi, \bar{A})$ is the fourpotential (semicolons denote covariant derivative). It is a curious fact, first discovered by Tamm [25] and later on, in a seemingly independent manner, by Plebanski [14], that the system (1) is equivalent to the usual threedimensional, source-free Maxwell equations in the presence of matter in flat space, provided appropriate constitutive equations are introduced in a non-covariant way. In fact, written in Cartesian coordinates, the equations are

$$\bar{\nabla} \cdot \bar{D} = 0, \quad \bar{\nabla} \times \bar{H} - \frac{\partial D}{\partial t} = 0,$$

$$\bar{\nabla} \cdot \bar{B} = 0, \qquad \bar{\nabla} \times \bar{E} + \frac{\partial B}{\partial t} = 0,$$
 (3)

where the constitutive relations linking the various fields in the material medium are

$$\bar{D} = \mathbf{K}\bar{E} + \bar{\Gamma} \times \bar{H}, \quad \bar{B} = \mathbf{K}\bar{H} - \bar{\Gamma} \times \bar{E}.$$
 (4)

The analogy is valid only if the Cartesian components of the matrix \mathbf{K} and the vector $\overline{\Gamma}$ are related to the spacetime geometry according to

$$K_{ij} = -\frac{\sqrt{-g}}{g_{00}}g^{ij}, \quad \Gamma_i = \frac{g_{0i}}{g_{00}}.$$
 (5)

In this way, the propagation of electromagnetic waves in a given curved spacetime (not necessarily a solution of Einstein field equations), is equivalent to the study of waves in a 3D material medium described by the constitutive equations (4); we refer the interested reader to [26]and the appendix of [27] for a complete treatment. Notice that this equivalence is manifestly non-covariant, because it is valid only in Cartesian coordinates fixed at the material medium which is stationary; the metric components, as well as the inverse metric components appearing in Eq. (5), are all written in Cartesian coordinates and are time-independent. However, covariant extensions to general media were developed, see, e.g., [28]-[30]; there it was shown, among many other things, that PT equations are equivalent to the ones coming from the more general covariant approach in those cases where the material medium is stationary.

Before proceeding, we can comment on some limits that emerge as consequences of the full PT equations. In order to do so let us consider waves of the form

$$\begin{aligned} \bar{E}(\bar{x},t) &= \bar{E}_0(\bar{x}) \exp\left[i \, k_0 \left(\bar{k}(\bar{x}) \cdot \bar{x} - t\right)\right], \\ \bar{H}(\bar{x},t) &= \bar{H}_0(\bar{x}) \exp\left[i \, k_0 \left(\bar{k}(\bar{x}) \cdot \bar{x} - t\right)\right], \end{aligned} \tag{6}$$

where $\bar{E}_0(\bar{x})$ and $\bar{H}_0(\bar{x})$ are the complex amplitudes and $\bar{k}(\bar{x})$ is the complex wave vector, all of them depending solely on the spatial coordinates \bar{x} . After considering this ansatz in the curl equations (2)-(3), and taking into account the constitutive relations (4), we get

$$i k_0^{-1} \bar{\nabla} \times \bar{E}_0 = (\bar{\nabla} (\bar{k} \cdot \bar{x}) + \bar{\Gamma}) \times \bar{E}_0 - \mathbf{K} \bar{H}_0,$$

$$i k_0^{-1} \bar{\nabla} \times \bar{H}_0 = (\bar{\nabla} (\bar{k} \cdot \bar{x}) + \bar{\Gamma}) \times \bar{H}_0 + \mathbf{K} \bar{E}_0.$$
(7)

If, in turn, we pay attention to the divergence equations in (2)-(3), we obtain

$$-ik_0\left[\bar{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma}\right]\cdot\mathbf{K}\bar{E}_0-(\bar{\nabla}\times\bar{\Gamma})\cdot\bar{H}_0=\bar{\nabla}\cdot\mathbf{K}\bar{E}_0,\\-ik_0\left[\bar{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma}\right]\cdot\mathbf{K}\bar{H}_0+(\bar{\nabla}\times\bar{\Gamma})\cdot\bar{E}_0=\bar{\nabla}\cdot\mathbf{K}\bar{H}_0.$$
(8)

Despite their apparent complexity, Eqs. (7)-(8) are not independent. Actually, it is shown in Appendix A that, by properly combining (7) with (8), we obtain an identity. Of course, this is not an intrinsic, general property of PT equations, but rather of the quasi plane-wave ansatz (6).

The usual circumstance of having plane waves in flat, empty space, is recovered from (7)-(8) by taking $\mathbf{K} = \mathbf{I}$ and $\bar{\Gamma} = \bar{0}$, corresponding to Minkowski spacetime with metric $g_{\mu\nu} = diag(-1, 1, 1, 1)$. Additionally, we have to consider constant \bar{E}_0 , \bar{H}_0 and \bar{k} . Under this requirements, the system (7) becomes

$$\bar{H}_0 = \bar{k} \times \bar{E}_0, \quad \bar{E}_0 = -\bar{k} \times \bar{H}_0.$$
(9)

Coming back to the comment made in the preceding paragraph, it is straightforward to show that the equations (8) give rise to the conditions $\bar{k} \cdot \bar{E}_0 = 0$ and $\bar{k} \cdot \bar{H}_0 = 0$, which are not independent of (9). Thus we see, on one hand, that $\bar{k} \perp \bar{E}_0$, $\bar{k} \perp \bar{H}_0$ and $\bar{E}_0 \perp \bar{H}_0$, and on the other, combining the two Eqs. (9),

$$\bar{E}_0 = -\bar{k} \times (\bar{k} \times \bar{E}_0) = k^2 \bar{E}_0.$$

This, of course, implies $\bar{k} \cdot \bar{k} = k^2 = 1$, which is no other than the usual dispersion relation.

We can also briefly discuss under what circumstances the geometrical optics regime comes out from this formalism. Even though not directly related to our present concerns, this limit is important because it illustrates that null geodesics in the spacetime are equivalent to light rays in the material medium, a very well know feature used in many works to simulate in the lab the effects of light propagation occurring in various spacetimes of astrophysical interest. See, for instance, [31]-[34]. For more insight into the following succinct exposition, we refer the reader to [35].

The geometrical optics realm involves slow variations of the fields in scales of order k_0 . Additionally, the vector $\overline{\nabla}(\bar{k}\cdot\bar{x})$ is approximated by \bar{k} itself. Once we incorporate this information into equations (7)-(8), and after defining $\bar{p} = \bar{k} + \bar{\Gamma}$, we get

$$\bar{p} \times \bar{E}_0 = \mathbf{K} \bar{H}_0, \quad \bar{p} \times \bar{H}_0 = -\mathbf{K} \bar{E}_0, \quad (11)$$

$$\bar{p} \cdot \mathbf{K} E_0 = 0, \quad \bar{p} \cdot \mathbf{K} H_0 = 0.$$
 (12)

Again, we see that the divergence equations (12) are not independent. Some matrix and vector handling allows us to combine the two Eqs. (11) to obtain

$$\left\{ \left(\bar{p} \otimes \bar{p} \right) \mathbf{K} + \left[\det(\mathbf{K}) - \bar{p}^{\mathsf{T}} \mathbf{K} \, \bar{p} \right] \mathbf{I} \right\} \bar{E}_0 = \bar{0} \,, \qquad (13)$$

which has non-trivial solutions if and only if

$$H \doteq \det(\mathbf{K}) - \bar{p}^{\mathsf{T}} \mathbf{K} \, \bar{p} = 0. \tag{14}$$

It turns out that the identically null function H can be seen as the Hamiltonian governing light-ray propagation in the optical medium, see [36], also [37] and [38]. Moreover, in Ref. [35], it was shown that the canonical equations

$$\bar{\nabla}_{\bar{x}}H = -\frac{d\bar{k}}{dt}, \quad \bar{\nabla}_{\bar{k}}H = \frac{d\bar{x}}{dt}, \tag{15}$$

are susceptible to analytical treatment, where $\bar{\nabla}_{\bar{k}} \equiv (\partial/\partial k_1, \partial/\partial k_2, \partial/\partial k_3)$. Suffice to say that Eqs. (15) can be written solely in terms of **K** and \bar{p} as

$$\frac{d\bar{x}}{dt} = -2\mathbf{K}\bar{p},\tag{16}$$

$$\frac{d\bar{k}}{dt} = \bar{p}^{\mathsf{T}} \Big[\left[\mathbf{K}_i - tr(\mathbf{K}^{-1}\mathbf{K}_i) \mathbf{K} \right] \bar{p} + 2\mathbf{K} \, \bar{p}_i \Big] \hat{e}_i \,, \quad (17)$$

where \hat{e}_i are the Cartesian unit vectors in \mathbb{R}^3 , $tr(\mathbf{A})$ is the trace of the matrix \mathbf{A} , and \mathbf{K}_i are three matrices whose components are obtained from the components of \mathbf{K} by differentiating with respect to the coordinate x_i .

In this paper we are interested in the behavior of static fields on a background space. Let us now examine what the structure of the equations is in this case. By dropping the time-varying terms in Faraday's and Ampère-Maxwell's laws, we have that \bar{E} and \bar{H} can be written in terms of scalar potentials ϕ_E and ϕ_H in the usual way, i.e., $\bar{E} = -\bar{\nabla}\phi_E$ and $\bar{H} = -\bar{\nabla}\phi_H$. These can be combined with the constitutive equations (4) and the two divergence equations $\bar{\nabla} \cdot \bar{D} = 0$ and $\bar{\nabla} \cdot \bar{B} = 0$, to get

$$\nabla \cdot (\mathbf{K} \nabla \phi_E) + (\nabla \times \bar{\Gamma}) \cdot \nabla \phi_H = 0,$$

$$\bar{\nabla} \cdot (\mathbf{K} \bar{\nabla} \phi_H) - (\bar{\nabla} \times \bar{\Gamma}) \cdot \bar{\nabla} \phi_E = 0.$$
(18)

As a consequence of the electric-magnetic coupling in the constitutive equations due to the presence of a nonconstant $\bar{\Gamma}$, static \bar{E} and \bar{H} fields in PT media generally interact with each other. This ultimately relies on the fact that $\bar{\Gamma}$ is associated to the off-diagonal components of the metric, which in turn are normally—although not always—representative of axisymmetric spacetimes endowed with some sort of rotation. Unlike in the previous cases, where quasi-plane waves were discussed, we see that the divergence equations play an important part in the determination of the scalar potentials.

III. THE METRIC AND ITS CAUSAL STRUCTURE

A sufficiently simple model of a spacetime having a strong curvature singularity can be constructed by considering in \mathbb{R}^4 , metrics of the form

$$ds^{2} = -x^{2p}dt^{2} + dx^{2} + dy^{2} + dz^{2}, \qquad (19)$$

where p is a real number. This metric produces only two non-zero components of the Ricci tensor, namely

$$R_{tt} = (-1+p) p x^{2(-1+p)}, \quad R_{xx} = (1-p) p x^{-2}, \quad (20)$$

and a scalar curvature given by

$$R = g^{\mu\nu} R_{\mu\nu} = 2(1-p) p x^{-2}.$$
 (21)

Additionally, the quadratic scalars $\mathcal{R}^2 = R^{\mu\nu}R_{\mu\nu}$ and $\mathcal{K} = R_{\mu\nu\rho\sigma}R^{\mu\nu\rho\sigma}$ read

$$\mathcal{R}^2 = \mathcal{K} = 2R^2. \tag{22}$$

Apart from the two choices p = 0 and p = 1 leading to flat spacetime (in the latter, the coordinate change $x^0 = x \sinh(t)$, $x^1 = x \cosh(t)$, converts the t - x sector of the metric (19) into the form $ds^2 = -(dx^0)^2 + (dx^1)^2$), the invariants (21) and (22) reveal the presence of a curvature singularity at x = 0, which is naked.

Just to make things precise, from now on we will fix p = -1; in this case the spacetime has negative scalar curvature, see (21). In what follows we will study the causal geodesics, and thus, the causal structure of the space. The only two non-null Christoffel symbols are

$$\Gamma^t_{tx} = -x^{-1}, \ \Gamma^x_{tt} = -x^{-3},$$
 (23)

which lead to the geodesic equations

$$\frac{d^2y}{d\,\tau^2} = \frac{d^2z}{d\,\tau^2} = 0\,,$$
(24)

$$\frac{d^2t}{d\tau^2} - \frac{2}{x}\frac{dx}{d\tau}\frac{dt}{d\tau} = 0, \quad \frac{d^2x}{d\tau^2} - \frac{1}{x^3}\left(\frac{dt}{d\tau}\right)^2 = 0, \quad (25)$$

where τ is the affine parameter. From the first two we have

$$y(\tau) = y_0 + \alpha \tau, \ z(\tau) = z_0 + \beta \tau,$$
 (26)

where y_0 , z_0 , α and β , are arbitrary constants. In the null case, $ds^2 = 0$ translates into the condition

$$\frac{1}{x^2} \left(\frac{dt}{d\tau}\right)^2 = \alpha^2 + \beta^2 + \left(\frac{dx}{d\tau}\right)^2.$$
(27)

Combining Eqs. (25) and (27) we get

$$x(\tau)\frac{d^2x}{d\tau^2} - \left(\frac{dx}{d\tau}\right)^2 = \alpha^2 + \beta^2, \qquad (28)$$

which results in

$$x(\tau) = \pm \left(e^{c_1 \tau} + \frac{\alpha^2 + \beta^2}{4 c_1^2} e^{-c_1 \tau} \right) , \qquad (29)$$

where c_1 is a constant related to the energy of the photon, and an irrelevant offset in τ was omitted. If $\alpha^2 + \beta^2 \neq 0$, $x(\tau)$ has a non-zero minimum value at a finite τ . In turn, if $\alpha^2 + \beta^2 = 0$, the function (29) becomes an exponential, which implies that x = 0 is not attainable at any finite τ . This fact indicates that the spacetime is null geodesically complete, because x = 0 is only hit asymptotically in τ . In Fig. (1) different geodesic groups are shown as trajectories in the (x, y) plane (this corresponds to $\beta = 0$ in (26) and (29)), for the choice $c_1 = 1$. Each group is characterized by different choices of y_0 in Eq. (26), while the connection between different groups is made by varying α as it appears in (29).

Let us take note, for instance, that the non-geodesic, null curves defined by constant values of y and z, having

$$t(\tau) = t_1 \tau^2 / 2 + t_0, \quad x(\tau) = t_1 \tau,$$
 (30)

with constants t_0 and t_1 , seem to reach x = 0 (when $\tau = 0$), and then, the curvature singularity is hit by these non-geodesic light rays. This means that not every null curve is complete, only null geodesics are.

We now proceed to characterize the timelike geodesics. As an alternative, perhaps more physical way, we can do this by using the conserved quantities associated to the cyclic coordinates y, z. In fact, along timelike geodesics we have

$$p^{\nu}p_{\nu} = g_{\mu\nu}p^{\mu}p^{\nu} = -m^2, \qquad (31)$$

where m is the mass and $p^{\mu} = m dx^{\mu}/d\tau$ is the fourmomentum. Due to the fact that the metric does not depend on y and z, the covariant components p_y and p_z are constant of motion:

$$p_y = g_{yy} p^y = g_{yy} m \, dy/d\tau = m \, dy/d\tau,$$
 (32)

$$p_z = g_{zz} p^z = g_{zz} m dz/d\tau = m dz/d\tau.$$
(33)

Integrating we have (compare to (26)),

$$y(\tau) = y_0 + \frac{p_y}{m}\tau, \quad z(\tau) = z_0 + \frac{p_z}{m}\tau,$$
 (34)

which allows us to identify $\alpha = p_y/m$ and $\beta = p_z/m$. Furthermore, we have that the energy is

$$E = p_t = g_{tt} p^t = g_{tt} m \frac{dt}{d\tau} = -\frac{m}{x^2} \frac{dt}{d\tau}.$$
 (35)

From (31), we get

$$\left(\frac{dx}{d\tau}\right)^2 = -1 - (p_y/m)^2 - (p_z/m)^2 + e^2 x^2, \quad (36)$$

where e = E/m is the energy per unit mass. Differentiation of (36) with respect to τ lead us to

$$\frac{d^2x}{d\tau^2} = x \ \boldsymbol{e}^2 \,, \tag{37}$$

and directly to

$$x(\tau) = d_1 e^{e \tau} + d_2 e^{-e \tau}, \qquad (38)$$

where d_1 and d_2 are constants. Notice, however, that (let us say) d_2 is not independent; replacing (38) in (36) we obtain

$$d_2 = \frac{1 + (p_y/m)^2 + (p_z/m)^2}{4 e^2 d_1}.$$
 (39)

Finally, we can take $d_1 = \pm e^d$, which only represent and offset in τ , and can thus be ignored. At the end we obtain

$$x(\tau) = \pm \left(e^{e \tau} + \frac{1 + (p_y/m)^2 + (p_z/m)^2}{4 e^2} e^{-e \tau} \right), \quad (40)$$

which has a similar structure to (29). Because 1 + $(p_y/m)^2 + (p_z/m)^2$ is always different from zero, the geodesics reach a minimum value and then bounce back, just as the null geodesics with $\alpha^2 + \beta^2 \neq 0$. We proved, then, that the singularity is repulsive in what concerns the behavior of null and timelike geodesics, being this a consequence related to the negativeness of the scalar curvature; this is very much alike to what happens in the Reissner-Nordström metric, where the singularity is repulsive for timelike geodesics [39], and in certain regular black hole solutions present in alternative gravity theories, where the role of the Schwarzschild singularity is played by a regular core which repels the causal geodesics, consult, e.g., [40] and [41]. We see that the metric in question is not only simple enough, but also useful as a toy model for studying more physical examples where strong curvature, repulsive singularities actually appear.

The global structure of the spacetime can be studied by constructing the Penrose diagram. In the (t, x) plane, let us first consider the coordinate change $\chi = \pm x^2/2$, which puts the metric into the form

$$ds^{2} = \frac{1}{2\chi} \left(-dt^{2} + d\chi^{2} \right) \,. \tag{41}$$

Then, null coordinates can be defined as $u = \chi + t$ and $v = \chi - t$, in such a way that the interval simply looks like $ds^2 = (u + v)^{-1} du dv$. The compactification takes place by means of new coordinates U and V, both ranging in the interval $\left[-\frac{\pi}{2}, \frac{\pi}{2}\right]$, and defined by

$$U = \arctan(u), \quad V = \arctan(v), \quad (42)$$

which convert the metric into

$$ds^{2} = \cos^{-2}(U)\cos^{-2}(V)(\tan U + \tan V)^{-1}dU\,dV\,.$$
 (43)

One last coordinate change X, T will bring the interval back again to a form conformal to Minkowski space, namely,

$$X = U + V, \quad T = U - V,$$
 (44)

$$-\pi \le X + T \le \pi, \quad -\pi \le X - T \le \pi, \tag{45}$$

so as to put the metric in its final form

$$ds^{2} = \frac{1}{\omega^{2}} \left(-dT^{2} + dX^{2} \right) , \qquad (46)$$

with $\omega^2 = (\cos T + \cos X)^2 (\tan \left(\frac{X+T}{2}\right) + \tan \left(\frac{X-T}{2}\right))$, which is null at X = 0.

The Penrose diagram is presented in Fig. (2), where the two regions I $(x^2 = 2\chi)$ and II $(x^2 = -2\chi)$ are shown. The wavy timelike curve at the center represents the naked curvature singularity. Timelike geodesics, as come from taking different values of p_y/m , p_z/m and e in Eq. (40), are visualized in dotted red lines. We see that the singularity is repulsive in terms of the behavior of null and timelike geodesics. However, null curves, as the one discussed in Eq. (30) (not shown in the diagram), can actually reach the singularity in a finite affine parameter τ . The Penrose diagram is basically the same as the one corresponding to the Reissner-Nordström space in which the electric charge Q is greater than the ADM mass M.

IV. ELECTROSTATICS

Beyond the behavior of light rays in the medium, or equivalently, of the null geodesics in the spacetime, it is interesting to study the main features regarding the structure of a more general electromagnetic field in this model. In the rest of the paper, we will focus on the static case, in particular, when no magnetic field is present. The static PT equations (18) for the electrostatic potential are

$$\bar{\nabla} \cdot (\mathbf{K}\bar{\nabla}\phi) = 0, \quad (\bar{\nabla} \times \bar{\Gamma}) \cdot \bar{\nabla}\phi = 0, \qquad (47)$$

where we have written $\phi = \phi_E$. Using the definitions (5) in the particular case under consideration, i.e., for the metric (19) with p = -1, we obtain right away

$$\mathbf{K} = |x| \,\mathbf{I} \,, \quad \bar{\Gamma} = \bar{0} \,. \tag{48}$$

In this way, Eqs. (47) end up being

$$\nabla^2 \phi = -\frac{1}{x} \frac{\partial \phi}{\partial x} \,. \tag{49}$$

Let us consider thus $\phi = \mathcal{X}(x)\mathcal{Y}(y)\mathcal{Z}(z)$, which converts (49) into

$$x \mathcal{X}'' + \mathcal{X}' + a^2 x \mathcal{X} = 0, \qquad (50)$$

$$\mathcal{Y}'' + b^2 \mathcal{Y} = 0, \qquad (51)$$

$$\mathcal{Z}'' - c^2 \mathcal{Z} = 0, \qquad (52)$$

where a and b are separation constants, and $c^2 = a^2 + b^2$. The set of solutions is grouped according to:

$$\mathcal{X}_{a}(x) = \begin{cases} A_{0} + \tilde{A}_{0} \ln(x) & \text{if } a = 0, \\ A_{a} J_{0}(a x) + \tilde{A}_{a} Y_{0}(a x) & \text{if } a \neq 0, \end{cases}$$
(53)

$$\mathcal{Y}_{b}(y) = \begin{cases} B_{0} + \tilde{B}_{0} y & \text{if } b = 0, \\ B_{b} e^{i \, b \, y} + \tilde{B}_{b} e^{-i \, b \, y} & \text{if } b \neq 0, \end{cases}$$
(54)

$$\mathcal{Z}_{c}(z) = \begin{cases} C_{0} + \tilde{C}_{0} z & \text{if } c = 0, \\ C_{c} e^{c z} + \tilde{C}_{c} e^{-c z} & \text{if } c \neq 0, \end{cases}$$
(55)

where $J_0(ax)$ and $Y_0(ax)$ are Bessel functions of first and second kind, respectively. Moreover, all the capitals A, \tilde{A} , etc, are constants. In this manner, the potential (49) is really a combination of modes

$$\phi(x, y, z) = \sum_{a, b} \mathcal{X}_a(x) \mathcal{Y}_b(y) \mathcal{Z}_c(z) \,. \tag{56}$$

It is clear that divergences at x = 0 generally occur in $\mathcal{X}_a(x)$. The situation is not different from having divergences at r = 0 when considering waves in a usual, hollow cylindrical waveguide, and they are ultimately a consequence of the structure of the Laplace operator in cylindrical coordinates. However, in the cylindrical waveguide the divergent modes are willfully dismissed on physical grounds, for they lead to an experimentally unobserved divergent power flux in the guiding system. Nonetheless, in our present circumstances, divergent modes should not be discarded from scratch. Actually, there are no physical reasons to exclude divergent solutions when the very structure of the spacetime is singular. On the contrary,

what seems more striking is the possibility of having a regular electric field on top of the curvature singularity. In what follows we will delve into this fact.

Note that the divergence at x = 0 of the mode expansion (56) is due to the presence of the logarithmic term and the function $Y_0(ax)$ in (53). Therefore, the regularity of the potential will be ensured if both A_0 and all the A_a are zero. Additionally, we can consider the identification $x = x_0$ with $x = -x_0$, which corresponds to folding the material in the x direction. This kind of topological control, usually conceived only on formal grounds in the spacetime "side" of the analogy, is perfectly feasible in the lab. This implies that $\mathcal{X}_a(x_0) = \mathcal{X}_a(-x_0)$ and $\mathcal{X}'_{a}(x_0) = \mathcal{X}'_{a}(-x_0)$. The first condition is satisfied for any x_0 since J_0 is an even function. As a result, its derivative is odd, and thus the boundary condition on the derivative implies $\mathcal{X}'_a(x_0) = \mathcal{X}'_a(-x_0) = 0$. Hence, $a^2 \geq 0$. In particular, since $J'_0(ax) = -J_1(ax)$, we have $a \equiv a_n = j_{1,n}/x_0$, where $j_{1,n}$ is the *n*th zero of J_1 . Since $J_0(ax)$ is an even function, it is sufficient to consider n > 0.

To better visualize the structure of the potential, we could first consider a 2-dimensional analogue medium by taking constant z surfaces. This is done without loss of generality due to the translational symmetry in the y and z directions. In this case, we will have only one separation constant, since $b^2 = -a^2 \leq 0$. Thus, by identifying $x = x_0$ with $x = -x_0$, the (x, y)-plane folds to form a cylindrical surface where the potential results

$$\phi(x,y) = B_0 y + \sum_a A_a J_0(ax) \left(e^{-a y} + B_a e^{a y} \right) , \quad (57)$$

where, remember, $a \equiv a_n = j_{1,n}/x_0$. In the expression (57), an irrelevant additive constant was omitted, and others were conveniently redefined. The omission of an additive constant in (57) simply fixes the potential at the origin according to $\phi(0,0) = \sum_a A_a(1+B_a)$.

In order to fully determine the potential (i.e., the constants A_a , B_0 and B_a), we need to specify boundary conditions on a closed curve limiting the two-dimensional surface. Given that we have identified $x = x_0$ with $x = -x_0$, we can specify the potential $\phi(x, y)$, for instance, along two lines of constant y, by setting $\phi(x, y_1) = \phi_1(x)$ and $\phi(x, y_2) = \phi_2(x)$. Therefore, using the orthonormality relations

$$\int_{0}^{x_{0}} x J_{0}(a_{n}x) J_{0}(a_{m}x) dx = \delta_{nm} \frac{x_{0}^{2}}{2} J_{0}^{2}(ax_{0}) \equiv \delta_{nm} \tilde{x}_{0}^{2},$$
$$\int_{0}^{x_{0}} x J_{0}(ax) dx = 0,$$
(58)

where we defined $\tilde{x}_0^2 = x_0^2 J_0^2(ax_0)/2$, we have

$$\int_{0}^{x_0} x J_0(ax) \phi_1(x) dx = A_a \tilde{x}_0^2 \left(e^{-a y_1} + B_a e^{a y_1} \right), \quad (59)$$

$$\int_0^{x_0} x \,\phi_1(x) \,dx = B_0 \,y_1 x_0^2 / 2,\tag{60}$$

$$\int_{0}^{x_{0}} x J_{0}(ax) \phi_{2}(x) dx = A_{a} \tilde{x}_{0}^{2} \left(e^{-a y_{2}} + B_{a} e^{a y_{2}} \right), \quad (61)$$

$$\int_0^{x_0} x \,\phi_2(x) \,dx = B_0 \,y_2 x_0^2 / 2 \,. \tag{62}$$

By using these relations, we can solve for all the constants simply by knowing either $\phi_1(x)$ or $\phi_2(x)$. Precisely, from (60) and (62) we see that

$$\frac{1}{y_2} \int_0^{x_0} x \,\phi_2(x) \,dx = \frac{1}{y_1} \int_0^{x_0} x \,\phi_1(x) \,dx \,, \qquad (63)$$

so there is a link between $\phi_1(x)$ and $\phi_2(x)$, which ultimately comes from the fact that the potential was fixed at the origin, see the comments on the paragraph below Eq. (57). In particular, if (let us say) $\phi_1(x)$ is constant, we have the relation $B_0 = \phi_1/y_1 = \phi_2/y_2$, which fixes the constant value of ϕ_2 . Additionally, from (59) and (61) we see that $A_a = 0$ for all *a* in this case. We end up, thus, with a linear potential and a constant electric field of the form $\overline{E}_0 = -B_0\hat{y}$. This represents the first example of a regular electrostatic field, even in the presence of a curvature singularity.

Let us elaborate another, more involved example. For instance, consider $x_0 = 3$, $y_1 = -1$, $y_2 = 1$ and $\phi_1(x) = x - 2x_0/3$. This functional form for $\phi_1(x)$, according to (60), conduces to a null B_0 and fixes the form of $\phi_2(x)$ to be just $\phi_2(x) = \pm \phi_1(x)$, as (63) demands. The constants A_a and B_a are determined by means of the integrals (59) and (61), where we have taken $\phi_2(x) = \phi_1(x)$. At the end all the constants read

$$B_0 = 0, (64)$$

$$A_{a} = A_{a_{n}} = \frac{{}_{1}F_{2}\left(\{\frac{3}{2}\},\{1,\frac{5}{2}\},-\frac{j_{1,n}^{2}}{4}\right)}{\cosh\left(j_{1,n}/3\right)J_{0}^{2}(j_{1,n})} \qquad (n \ge 1), \ (65)$$

$$B_a = B_{a_n} = 1 \quad (n \ge 1),$$
 (66)

where ${}_{\mathbf{p}}F_{\mathbf{q}}$ is the generalized hypergeometric function [42], given by

$${}_{\mathbf{p}}F_{\mathbf{q}}(\{b_1,...,b_p\},\{c_1,...,c_q\},z) = \sum_{s=0}^{\infty} \frac{(b_1)_s...(b_p)_s}{(c_1)_s...(c_q)_s} \frac{z^s}{s!},$$

which is defined in terms of the rising factorial

$$(b)_0 = 1,$$

 $(b)_s = b(b+1)(b+2)\dots(b+s-1) \quad (s \ge 1)$

In Fig. (3a) we show a vector plot of the electrostatic field $\overline{E} = -\overline{\nabla}\phi$ in the case just considered. Not only the

electric field is regular (actually, null) at the origin, but along the entire *y*-axis; its functional form there reads

$$\bar{E}(0,y) \propto \sum_{n=1}^{\infty} j_{1,n} A_{a_n} \sinh\left(\frac{j_{1,n}}{x_0}y\right) \hat{y}.$$
 (67)

In Fig. (3b) we show the electrostatic energy density $U(x, y) \propto \overline{D} \cdot \overline{E} = \mathbf{K}\overline{E} \cdot \overline{E} = |x||\overline{E}|^2$. As a consequence of the regularity of the electric field, the energy density is null along the entire line x = 0. We conclude that the usual devastating effects associated to the presence of curvature singularities, are not such in this example.

After the preceding two dimensional digression, we can go back to the three dimensional case and sketch the main steps leading to the full determination of the electrostatic potential. To start, we can now introduce an additional (and optional) topological condition by identifying $y = y_0$ with $y = -y_0$. This forces $b^2 \ge 0$, $\tilde{B}_0 = 0$ and $B_b = \tilde{B}_b$ in Eq. (54), which conduces to $\mathcal{Y}(y) \propto \cos(by)$, where $b \equiv b_m = m\pi/y_0$, and m is a positive integer. Therefore, the expansion (56) reads

$$\phi = B_{00}z + \sum_{n,m=1}^{\infty} A_{nm}J_0(ax)\cos(by) \left(e^{-cz} + B_{nm} e^{cz}\right) ,$$

where $c \equiv c_{nm} = \sqrt{a_n^2 + b_m^2}$. Just as in the two dimensional case worked before, the constants B_{00} , A_{nm} and B_{nm} can be determined by specifying the potential on two sections of constant z, this is, $\phi(x, y, z_1) = \phi_1(x, y)$ and $\phi(x, y, z_2) = \phi_2(x, y)$. Hence, using 3D orthonormality conditions similar to (58), we get

$$\int_{0}^{x_{0}} \int_{0}^{y_{0}} x J_{0}(ax) \cos(by) \phi_{1}(x,y) dx dy$$

= $A_{nm} y_{0} \tilde{x}_{0}^{2} \left(e^{-c z_{1}} + B_{nm} e^{c z_{1}} \right) / 2,$ (68)

$$\int_0^{x_0} \int_0^{y_0} x \,\phi_1(x, y) dx \, dy = B_{00} \, z_1 \, x_0^2 \, y_0/2 \,, \qquad (69)$$

$$\int_{0}^{x_{0}} \int_{0}^{y_{0}} x J_{0}(ax) \cos(b y) \phi_{2}(x, y) dx dy$$

= $A_{nm} y_{0} \tilde{x}_{0}^{2} \left(e^{-c z_{2}} + B_{nm} e^{c z_{2}} \right) / 2, \quad (70)$

$$\int_{0}^{x_{0}} \int_{0}^{y_{0}} x \,\phi_{2}(x,y) dx \,dy = B_{00} \,z_{2} \,x_{0}^{2} \,y_{0}/2 \,, \qquad (71)$$

from which we can solve for the unknown constants.

V. CONCLUDING COMMENTS

In this work, we have studied the behavior of the electrostatic field in a spacetime hosting a strong, naked curvature singularity using the Plebanski-Tamm formalism. We have found that there are exact solutions to the full electrostatic equations that remain regular at the curvature singularity. These solutions describe non-trivial 8

electrostatic fields leading to a null value of the electrostatic energy in the entire space defined by x = 0, even though this space cannot be considered a submanifold in the usual, Riemannian sense. Although the metric employed, *per se*, may not hold the most physical relevance, in the sense that it does not describe a solution of the Einstein equations with any reasonable matter content (though it nicely models the repulsive singularity existing, for instance, in the Reissner-Nordström metric), its ability to sustain a regular electric field is highly significant. More than discussing a certain solution, our aim was to delve into the more general possibility of having a regular field in a singular space of what can be considered the worst type. It is sounding increasingly likely that this sort of regularity could be sustained in a dynamical situation in which the electromagnetic energy might be able to flow from one side to the other, through the singularity. This possibility constitutes material of an ongoing investigation.

Appendix A: Consistency of the system (7)-(8)

Here we prove that the Eqs. (7) alone are sufficient to determine everything that is possible to be determined within the context of the quasi-plane ansatz (6). From the second Eq. (7), we have

$$\mathbf{K}\bar{E}_0 = i\,k_0^{-1}\,\bar{\nabla}\times\bar{H}_0 - (\bar{\nabla}(\bar{k}\cdot\bar{x}) + \bar{\Gamma})\times\bar{H}_0\,.$$
(A1)

We can plug this into the first Eq. (8), this is

$$-ik_0\left[\bar{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma}\right]\cdot\left[ik_0^{-1}\bar{\nabla}\times\bar{H}_0-(\bar{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma})\times\bar{H}_0\right]-(\bar{\nabla}\times\bar{\Gamma})\cdot\bar{H}_0=\bar{\nabla}\cdot\left[ik_0^{-1}\bar{\nabla}\times\bar{H}_0-(\bar{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma})\times\bar{H}_0\right] \tag{A2}$$

(A3)

Due to the fact that the vector $(\overline{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma})\times\bar{H}_0$ is orthogonal to $\overline{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma}$, the LHS of (A2) reads

 $\left[\bar{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma}\right]\cdot\left[\bar{\nabla}\times\bar{H}_{0}\right]-(\bar{\nabla}\times\bar{\Gamma})\cdot\bar{H}_{0}.$

On the other hand, by virtue that the divergence of a curl identically vanish, the RHS of (A2) ends up being

$$-\bar{\nabla}\cdot\Big[(\bar{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma})\times\bar{H}_0\Big].$$
 (A4)

Now, we can make use of the identity

$$\bar{\nabla} \cdot (\bar{A} \times \bar{B}) = (\bar{\nabla} \times \bar{A}) \cdot \bar{B} - \bar{A} \cdot (\bar{\nabla} \times \bar{B}), \qquad (A5)$$

to convert (A4) into

$$-\left[\bar{\nabla}\times(\bar{\nabla}(\bar{k}\cdot\bar{x})+\bar{\Gamma})\right]\cdot\bar{H_0}+\left[\bar{\nabla}(\bar{k}\cdot\bar{x})\times\bar{\Gamma}\right]\cdot\left[\bar{\nabla}\times\bar{H_0}\right].$$
(A6)

Equating (A3) and (A6) we get

$$(\bar{\nabla} \times \bar{\Gamma}) \cdot \bar{H_0} = \left[\bar{\nabla} \times (\bar{\nabla}(\bar{k} \cdot \bar{x}) + \bar{\Gamma})\right] \cdot \bar{H_0}, \qquad (A7)$$

or

$$(\bar{\nabla} \times \bar{\Gamma}) \cdot \bar{H_0} = \left[\bar{\nabla} \times \bar{\nabla}(\bar{k} \cdot \bar{x}) + \bar{\nabla} \times \bar{\Gamma}\right] \cdot \bar{H_0}.$$

However, because the curl of a gradient identically vanish, $[\bar{\nabla} \times \bar{\nabla}(\bar{k} \cdot \bar{x})] \cdot \bar{H_0} = 0$, Eq. (A8) produces an identity. This means that the combination of the second Eq. (7) and the first Eq. (8) do not provide more information than the one encoded in Eq. (7) alone. Of course, the same conclusion can be obtained by starting from the first Eq. (7) and combining it with the second Eq. (8).
