# A NON-ABELIAN TENSOR PRODUCT OF ALGEBRAS WITH BRACKET

#### Abstract

We introduce and study a non-abelian tensor product of two algebras with bracket with compatible actions on each other. We investigate its applications to the universal central extensions and the low-dimensional homology of perfect algebras with bracket.


## 1. Introduction

The non-abelian tensor product in various algebraic categories, such as groups, (Hom)Lie and (Hom)-Leibniz algebras, Lie superalgebras. etc., plays an essential role in the study of homotopy theory, low-dimensional homology or universal central extensions (see 2, 6, 10, [11, 12, 14, 17, 18]). It has also been used in the construction of low-dimensional non-abelian homology of groups, Lie algebras and Leibniz algebras, having interesting applications to the algebraic $K$-theory, cyclic homology and Hochschild homology, respectively [14, 15, 13].

In this paper, we choose to develop a non-abelian tensor product for a relatively new algebraic structure called algebra with bracket, introduced in [7] as a kind of generalization of the (non-commutative) Poisson algebra. It should be noted here that such a generalization of Poisson algebras originates in physics literature (see, e.g. [20]). Among other results in [7], Quillen cohomology of algebras with bracket is described via an explicit cochain complex. Further (co)homological investigations of algebras with bracket are carried out in [3, 5]. In particular, for our importance, we mention that in [3], a homology with trivial coefficients of algebras with bracket is developed with applications to universal central extensions. In [5], crossed modules for algebras with bracket are introduced, and the second cohomology is interpreted as the set of equivalence classes of crossed extensions. The eight-term exact cohomology sequence is also constructed.

In the present paper, we continue the same line of homological study of algebras with bracket. We fit the homology with trivial coefficients [3] into the context of Quillen homology, introduce the non-abelian tensor product of algebras with bracket by generators and relations, and give applications in universal central extensions and low-dimensional homology.

The organization of this paper is as follows: after the introduction, in Section 2, we present some definitions and results for the development of the paper. We briefly recall the construction of homology for algebras with bracket from [3, 7] and prove that it is consistent

[^0]with the context of Quillen's homology theory (Theorem 2.6). In Section 3, we present all the ingredients for developing the non-abelian tensor product later. In particular, we define actions, semi-direct products and crossed modules of algebras with bracket. Additionally, we show that the category of crossed modules is equivalent to the category of cat ${ }^{1}$-algebras with bracket (Theorem 3.12). Section 4 contains the main results of the paper. Here, we present the construction of the non-abelian tensor product of two algebras with bracket acting compatibly on each other (Proposition 4.3) and study its properties. Regarding trivial actions, we describe the non-abelian tensor product (Proposition 4.5). We establish a right-exactness property of the non-abelian tensor product of algebras with bracket (Theorem 4.6) and equip the non-abelian tensor product with crossed module structures (Proposition 4.7). Finally, as an application, for a given perfect algebra with bracket, we construct its universal central extension (Theorem 4.8) and a four-term exact homology sequence (Theorem 4.11).

## 2. Algebras With Bracket

Throughout the paper we fix a ground field $\mathbb{K}$. All vector spaces and algebras are $\mathbb{K}$ vector spaces and $\mathbb{K}$-algebras, and linear maps are $\mathbb{K}$-linear maps as well. In what follows $\otimes$ means $\otimes_{\mathbb{K}}$.

### 2.1. Basic definitions.

Definition 2.1 ([7]). An algebra with bracket, or an AWB for short, is an associative (not necessarily commutative) algebra A equipped with a bilinear map (bracket operation) $[-,-]: \mathrm{A} \times \mathrm{A} \rightarrow \mathrm{A},(a, b) \mapsto[a, b]$ satisfying the following identity:

$$
\begin{equation*}
[a b, c]=[a, c] b+a[b, c] \tag{2.1}
\end{equation*}
$$

for all $a, b, c \in \mathrm{~A}$.
A homomorphism of AWBs is a homomorphism of associative algebras preserving the bracket operation. We denote by AWB the respective category of AWBs.

The category AWB is a variety of $\Omega$-groups [16], and therefore it is a semi-abelian category [1, 19]: pointed, exact and protomodular with binary coproducts. So classical lemmas such as the Five Lemma [22] hold for AWBs which we will use later on. Below we give the definitions of ideal, center, commutator, action and semi-direct product of AWBs, and of course these notions agree with the corresponding general notions in the context of semiabelian categories.

We now list some common examples of AWBs that will be discussed later. Other examples can be found in [4, 5, 7, 20].

## Example 2.2.

(i) Any vector space A enriched with the trivial multiplication and bracket operation, i.e. $a b=0$ and $[a, b]=0$ for all $a, b \in \mathrm{~A}$, is an AWB, called an abelian AWB. Hence, the category of vector spaces is a full subcategory of AWB and the respective inclusion functor Vect $\hookrightarrow$ AWB has a left adjoint, the so called abelianization functor $(-)^{\mathrm{ab}}: \mathrm{AWB} \rightarrow$ Vect, which will be described in Remark 2.3 (i) below.
(ii) Any associative algebra A together with the trivial bracket operation can be regarded as an AWB. This defines the inclusion functor $I:$ Ass $\rightarrow$ AWB, where Ass denotes the category of associative algebras. The functor I has a left adjoint $(-)^{\text {ass }}:$ AWB $\rightarrow$ Ass described in Remark 2.3 (ii) below.
(iii) Another way of considering an associative algebra A as an AWB is to define the bracket operation by

$$
[a, b]:=a b-b a, \quad a, b \in \mathrm{~A} .
$$

This particular AWB is called the tautological AWB associated to the associative algebra A and will be denoted by $T(\mathrm{~A})$.

Tautological AWBs constitute a full subcategory of AWB denoted by TAWB. The correspondence $T$ : Ass $\rightarrow \mathrm{TAWB}, \mathrm{A} \mapsto T(\mathrm{~A})$, is functorial, and it establishes an isomorphism between the categories TAWB and Ass.
(iv) Any Poisson algebra is an AWB. In fact, the category Poiss of (non-commutative) Poisson algebras is a subcategory of AWB. The inclusion functor Poiss $\hookrightarrow$ AWB has as left adjoint the functor given by $\mathrm{A} \mapsto \mathrm{A}_{\text {Poiss }}$, where $\mathrm{A}_{\text {Poiss }}$ is the maximal quotient of A , such that the following relations hold: $[a, a] \sim 0$ and $[a,[b, c]]+[b,[c, a]]+$ $[c,[a, b]] \sim 0$.

The following notions for AWBs are given in [3] and they agree with the corresponding notions in semi-abelian categories. A subalgebra B of an AWB A is a vector subspace which is closed under the product and the bracket operation, that is, $B B \subseteq B$ and $[B, B] \subseteq B$. A subalgebra B is said to be a left (respectively, right) ideal if $\mathrm{A} B \subseteq B,[\mathrm{~A}, \mathrm{~B}] \subseteq \mathrm{B}$ (respectively, $B A \subseteq B,[B, A] \subseteq B$ ). If $B$ is both left and right ideal, then it is said to be a two-sided ideal. In this case, the quotient $A / B$ is endowed with an AWB structure naturally induced from the operations on A .

Let A be an AWB and $\mathrm{B}, \mathrm{C}$ be two-sided ideals of A . The commutator ideal of B and C is the two-sided ideal of $A$

$$
[[\mathrm{B}, \mathrm{C}]]=\langle\{b c, c b,[b, c],[c, b] \mid b \in \mathrm{~B}, c \in \mathrm{C}\}\rangle .
$$

Obviously $[[B, C]] \subseteq B \bigcap C$. In the particular case $B=C=A$, one obtains the definition of derived algebra of $A$,

$$
[[\mathrm{A}, \mathrm{~A}]]=\left\langle\left\{a a^{\prime},\left[a, a^{\prime}\right] \mid a, a^{\prime} \in \mathrm{A}\right\}\right\rangle
$$

An AWB $A$ is said to be perfect if $A=[[A, A]]$.
Remark 2.3.
(i) Given an AWB A, the quotient $\mathrm{A} /[[\mathrm{A}, \mathrm{A}]]$ is always an abelian AWB and will be denoted by $\mathrm{A}^{\mathrm{ab}}$. Abelian AWBs (i.e. just vector spaces) are abelian group objects in the category AWB. The respective abelianization functor $(-)^{\text {ab }}: \mathrm{AWB} \rightarrow$ Vect, which is left adjoint to the inclusion functor Vect $\hookrightarrow \mathrm{AWB}$, sends an AWB A into $A^{a b}=A /[[A, A]]$.
(ii) To an AWB A, we associate the associative algebra

$$
\mathrm{A}^{\text {ass }}=\mathrm{A} /[\mathrm{A}, \mathrm{~A}], \quad \text { where } \quad[\mathrm{A}, \mathrm{~A}]=\left\langle\left\{\left[a, a^{\prime}\right] \mid a, a^{\prime} \in \mathrm{A}\right\}\right\rangle .
$$

This correspondence is functorial and satisfies the following universal property: given an associative algebra B , any homomorphism of AWBs $\mathrm{A} \rightarrow I(\mathrm{~B})$ factors trough $\mathrm{A}^{\text {ass }}$, where $I:$ Ass $\hookrightarrow$ AWB is the inclusion functor as in Example 2.2 (iii). Thus, the functor $(-)^{\text {ass }}: A W B \rightarrow$ Ass, $\mathrm{A} \mapsto \mathrm{A}^{\text {ass }}$, is left adjoint to $I$.

The center of an AWB A is the two-sided ideal

$$
\mathcal{Z}(\mathrm{A})=\{a \in \mathrm{~A} \mid a b=0=b a,[a, b]=0=[b, a], \text { for all } b \in \mathrm{~A}\}
$$

Note that an AWB $A$ is abelian if and only if $A=\mathcal{Z}(A)$.
A central extension of an AWB A is an exact sequence of AWBs $0 \rightarrow \mathrm{M} \rightarrow \mathrm{B} \xrightarrow{\phi} \mathrm{A} \rightarrow 0$ such that $[[\mathrm{M}, \mathrm{B}]]=0$ (equivalently, $\mathrm{M} \subseteq \mathcal{Z}(\mathrm{B})$ ). It is said to be universal central extension if for every central extension $0 \rightarrow \mathrm{~N} \rightarrow \mathrm{C} \xrightarrow{\psi} \mathrm{A} \rightarrow 0$ there is a unique homomorphism of AWBs $\alpha: \mathrm{B} \rightarrow \mathrm{C}$ such that $\psi \circ \alpha=\phi$.
Theorem 2.4 ([3]). An AWB A admits a universal central extension if and only if A is perfect. Moreover, the kernel of the universal central extension is isomorphic to the first homology of $\mathrm{A}, \mathrm{H}_{1}^{\mathrm{AWB}}(\mathrm{A})$ (see the definition below).
2.2. Homology. In this subsection, we briefly review the homology of AWBs with trivial coefficients given in [3, 7].

Let $V$ be a vector space. Let $R_{1}(V)=V$ and $R_{n}(V)=V^{\otimes n} \oplus V^{\otimes n}$, if $n \geq 2$. In order to distinguish elements from these tensor powers, we let $a_{1} \otimes \cdots \otimes a_{n}$ be a typical element from the first component of $R_{n}(V)$, while $a_{1} \circ \cdots \circ a_{n}$ from the second component of $R_{n}(V)$.

Given an AWB A, we let $\left(C_{*}^{\mathrm{AWB}}(\mathrm{A}), d_{*}\right)$ be the chain complex defined by

$$
C_{n}^{\mathrm{AWB}}(\mathrm{~A}):=R_{n+1}(\mathrm{~A}), n \geq 0
$$

with the boundary maps $d_{n}: C_{n}^{\mathrm{AWB}}(\mathrm{A}) \rightarrow C_{n-1}^{\mathrm{AWB}}(\mathrm{A}), n \geq 0$, given by
$d_{n}\left(a_{1} \otimes \cdots \otimes a_{n+1}\right)=\sum_{i=1}^{n}(-1)^{i+1} a_{1} \otimes \cdots \otimes a_{i} a_{i+1} \otimes \cdots \otimes a_{n+1}$,
$d_{n}\left(a_{1} \circ \cdots \circ a_{n+1}\right)=\sum_{i=1}^{n} a_{1} \otimes \cdots \otimes\left[a_{i}, a_{n+1}\right] \otimes \cdots \otimes a_{n}+\sum_{i=1}^{n-1}(-1)^{i} a_{1} \circ \cdots \circ a_{i} a_{i+1} \circ \cdots \circ a_{n+1}$
The homology of the complex $\left(C_{*}^{\mathrm{AWB}}(\mathrm{A}), d_{*}\right)$ is called the homology with trivial coefficients of the AWB $A$ and it is denoted by $\mathrm{H}_{*}^{\mathrm{AWB}}(\mathrm{A})$.

Easy computations show that there is an isomorphism

$$
\mathrm{H}_{0}^{\mathrm{AWB}}(\mathrm{~A}) \cong \mathrm{A} /[[\mathrm{A}, \mathrm{~A}]] .
$$

On the other hand, given a free presentation of $A$, that is, a short exact sequence of AWBs $0 \rightarrow R \rightarrow F \rightarrow A \rightarrow 0$, where $F$ is a free AWB, then there is an isomorphism

$$
\mathrm{H}_{1}^{\mathrm{AWB}}(\mathrm{~A}) \cong(\mathrm{R} \cap[[\mathrm{~F}, \mathrm{~F}]]) /[[\mathrm{R}, \mathrm{~F}]]
$$

(see [3, Corollary 2.14]).

Remark 2.5. Let A be an associative algebra and consider the ground field $\mathbb{K}$ as a trivial $\mathrm{A}-$ bimodule. Let $C_{*}^{\text {Hoch }}(\mathrm{A})=C_{*}^{\mathrm{Hoch}}(\mathrm{A}, \mathbb{K})$ and $\operatorname{Hoch}_{*}(\mathrm{~A})=\operatorname{Hoch}_{*}(\mathrm{~A}, \mathbb{K})$ denote the Hochschild complex and the Hochschild homology of A with coefficients in $\mathbb{K}$ [24], respectively. Then $C_{1}^{\mathrm{Hoch}}(\mathrm{A})=\mathrm{A}=C_{0}^{\mathrm{AWB}}(T(\mathrm{~A}))$ and the natural injections

$$
C_{n+1}^{\mathrm{Hoch}}(\mathrm{~A})=\mathrm{A}^{\otimes(n+1)} \hookrightarrow \mathrm{A}^{\otimes(n+1)} \oplus \mathrm{A}^{\otimes(n+1)}=C_{n}^{\mathrm{AWB}}(T(\mathrm{~A})), \quad n \geq 1
$$

gives rise to a morphism of chain complexes $C_{*+1}^{\text {Hoch }}(\mathrm{A}) \hookrightarrow C_{*}^{\mathrm{AWB}}(T(\mathrm{~A}))$. Thus, we have an induced homomorphism in homology $\operatorname{Hoch}_{n+1}(\mathrm{~A}) \rightarrow \mathrm{H}_{n}^{\mathrm{AWB}}(T(\mathrm{~A}))(n \geq 0)$, which is clearly an epimorphism for $n=1$ and an isomorphism for $n=0$.

Now we show that the homology of AWBs is fitted in the context of homology theory developed by Quillen in a very general framework [23]. Let us recall that the Quillen homology of an object in an algebraic category $\mathcal{C}$ is defined via the derived functors of the abelianization functor $(-)^{\text {ab }}: \mathcal{C} \rightarrow \mathcal{C}^{\text {ab }}$ from $\mathcal{C}$ to the abelian category $\mathcal{C}^{\text {ab }}$ of abelian group objects in $\mathcal{C}$. To specify this theory for AWBs, we proceed as follows.

Given an AWB A, choose any free simplicial resolution $F_{*}$ of A, that is, an aspherical augmented simplicial AWB $F_{*} \xrightarrow{\epsilon} \mathrm{~A}$ (which means that all non-zero homotopies are trivial, $\pi_{n}\left(\mathrm{~F}_{*}\right)=0$ for $n \geq 0$, and $\epsilon$ induces an isomorphism $\pi_{0}\left(\mathrm{~F}_{*}\right) \cong \mathrm{A}$ ) such that each component $\mathrm{F}_{n}, n \geq 0$, is a free AWB. Then the $n$-th Quillen homology of A is defined by

$$
H_{n}^{Q}(\mathrm{~A})=H_{n}\left(\mathrm{~F}_{*}^{\mathrm{ab}}\right), \quad n \geq 0
$$

Here $F_{*}^{\text {ab }}$ is the simplicial vector space obtained by applying the functor $(-)^{\text {ab }}$ dimensionwise to $F_{*}$.

In the proof of the theorem immediately below, we need to use the result from [7] that if $F$ is a free AWB, then the homology of the complex $\left(C_{*}^{\mathrm{AWB}}(\mathrm{F}), d_{*}\right)$ vanishes in positive dimensions, that is,

$$
\mathrm{H}_{n}^{\mathrm{AWB}}(\mathrm{~F})=0, \quad \text { for } \quad n \geq 1
$$

Theorem 2.6. Let A be an AWB. Then there is an isomorphism of vector spaces

$$
\mathrm{H}_{n}^{\mathrm{AWB}}(\mathrm{~A}) \cong H_{n}^{Q}(\mathrm{~A}), \quad n \geq 0
$$

Proof. First of all let us note that the homology chain complex $C_{*}^{\text {AWB }}$ is functorial in the sense that a homomorphism $\mathrm{A} \rightarrow \mathrm{A}^{\prime}$ gives rise the chain map $C_{*}^{\mathrm{AWB}}(\mathrm{A}) \rightarrow C_{*}^{\mathrm{AWB}}\left(\mathrm{A}^{\prime}\right)$ in the canonical way.

Now, given a free simplicial resolution $\mathrm{F}_{*}$ of A , by applying the functor $C_{n}^{\mathrm{AWB}}$ dimensionwise, and then taking the alternating sums of face homomorphisms, we get an augmented chain complex of vector spaces $C_{n}^{\mathrm{AWB}}\left(\mathrm{F}_{*}\right) \rightarrow C_{n}^{\mathrm{AWB}}(\mathrm{A})$. Since $\mathrm{F}_{*} \rightarrow \mathrm{~A}$ is an aspherical simplicial AWB, we claim that $C_{n}^{A W B}\left(\mathrm{~F}_{*}\right) \rightarrow C_{n}^{A W B}(\mathrm{~A})$ is acyclic chain complex for any $n \geq 0$. This is easy to confirm, since by forgetting AWB structure in the simplicial AWB $F_{*} \rightarrow A$, we get a simplicial vector space having a linear left (right) contraction.

Then using the facts that $\mathrm{H}_{n}^{\mathrm{AWB}}\left(\mathrm{F}_{m}\right)=0$ and $\mathrm{H}_{0}^{\mathrm{AWB}}\left(\mathrm{F}_{m}\right)=\mathrm{F}_{m}^{\mathrm{ab}}$ for any $n \geq 1$ and $m \geq 0$ it follows that both spectral sequences for the bicomplex $C_{*}^{\mathrm{AWB}}\left(\mathrm{F}_{*}\right)$ degenerate and give the required isomorphism.

## 3. Crossed modules of AWBS

### 3.1. Actions and semi-direct product.

Definition 3.1. Let A and M be two AWBs. An action of A on M consists of four bilinear maps

$$
\begin{array}{ll}
\mathrm{A} \times \mathrm{M} \rightarrow \mathrm{M}, & (a, m) \mapsto{ }^{a} m, \\
\mathrm{~A} \times \mathrm{M} \rightarrow \mathrm{M} \times \mathrm{A} \rightarrow \mathrm{M}, & (a, m) \mapsto{ }^{a *} m, \\
\mathrm{M} \times \mathrm{A} \rightarrow \mathrm{M}, & (m, a) \mapsto m^{\cdot a}, \\
(m, a) \mapsto m^{* a},
\end{array}
$$

such that the following conditions hold:

$$
\begin{array}{rlrl}
\left(a_{1} a_{2}\right) \cdot m & ={ }^{a_{1} \cdot} \cdot\left({ }^{a_{2}} \cdot m\right), & \left({ }^{\left(a_{1} \cdot\right.} m\right)^{* a_{2}} & ={ }^{a_{1} \cdot}\left(m^{* a_{2}}\right)+{ }^{\left[a_{1}, a_{2}\right] \cdot} m, \\
m^{\cdot\left(a_{1} a_{2}\right)} & =\left(m^{\cdot a_{1}}\right)^{\cdot a_{2}}, & \left(m^{\cdot a_{1}}\right)^{* a_{2}} & =\left(m^{* a_{2}}\right)^{\cdot a_{1}}+m^{\cdot\left[a_{1}, a_{2}\right]}, \\

\left(m_{1}^{\cdot a}\right) m_{2} & =m_{1}\left({ }^{(a \cdot} m_{2}\right), & \left(m_{1} m_{2}\right)^{* a} & =m_{1}\left(m_{2}{ }^{* a}\right)+\left(m_{1}{ }^{* a}\right) m_{2},
\end{array}

for all $a, a_{1}, a_{2} \in \mathrm{~A}, m, m_{1}, m_{2} \in \mathrm{M}$. The action is called trivial if all these bilinear maps are trivial.

Let us remark that if an action of an AWB $A$ on an abelian AWB $M$ is given, then all six equations in the last three lines of (3.1) vanish and we get the definition of a representation $M$ of $A$ (see [7]).

## Example 3.2.

(i) If M is a representation of an AWB A thought as an abelian AWB, then there is an action of A on the abelian AWB M .
(ii) If A is a subalgebra of some AWB B (maybe $\mathrm{A}=\mathrm{B}$ ) and if M is a two-sided ideal of B , then the operations in B yield an action of A on M given by ${ }^{a \cdot m}=a m$, $m^{\cdot a}=m a,{ }^{a *} m=[a, m], m^{* a}=[m, a]$, for all $m \in \mathrm{M}$ and $a \in \mathrm{~A}$.
(iii) If $0 \rightarrow \mathrm{M} \xrightarrow{i} \mathrm{~B} \xrightarrow{\pi} \mathrm{~A} \rightarrow 0$ is a split short exact sequence of AWBs, that is, there exists a homomorphism $s: \mathrm{A} \rightarrow \mathrm{B}$ of AWBs such that $\pi \circ s=\mathrm{Id}_{\mathrm{A}}$, then there is an action of A on M , given by:

$$
\begin{aligned}
{ }^{a \cdot} m & =i^{-1}(s(a) i(m)), & m^{\cdot a} & =i^{-1}(i(m) s(a)), \\
{ }^{a *} m & =i^{-1}([s(a), i(m)]), & m^{* a} & =i^{-1}([i(m), s(a)]),
\end{aligned}
$$

for any $a \in \mathrm{~A}, m \in \mathrm{M}$.
(iv) Any homomorphism of AWBs $f: \mathrm{A} \rightarrow \mathrm{M}$ induces an action of A on M in the standard way by taking images of elements of A and operations in M .
(v) If $\mu: \mathrm{M} \rightarrow \mathrm{A}$ is a surjective homomorphism of AWBs and the kernel of $\mu$ is contained in the center of M , i.e. $\operatorname{Ker}(\mu) \subseteq \mathcal{Z}(\mathrm{M})$, then there is an action of A on M , defined in the standard way, i.e. by choosing pre-images of elements of A and taking operations in M .

Definition 3.3. Let A and M be AWBs with an action of A on M . The semi-direct product of M and A , denoted by $\mathrm{M} \rtimes \mathrm{A}$, is the AWB whose underlying vector space is $\mathrm{M} \oplus \mathrm{A}$ endowed with the operations

$$
\begin{aligned}
\left(m_{1}, a_{1}\right)\left(m_{2}, a_{2}\right) & =\left(m_{1} m_{2}+{ }^{a_{1}} \cdot m_{2}+m_{1}{ }^{\cdot a_{2}}, a_{1} a_{2}\right), \\
{\left[\left(m_{1}, a_{1}\right),\left(m_{2}, a_{2}\right)\right] } & =\left(\left[m_{1}, m_{2}\right]+{ }^{a_{1} *} m_{2}+m_{1}{ }^{* a_{2}},\left[a_{1}, a_{2}\right]\right)
\end{aligned}
$$

for all $m_{1}, m_{2} \in \mathrm{M}, a_{1}, a_{2} \in \mathrm{~A}$.
Given an action of an AWB $A$ on $M$, straightforward calculations show that the sequence of AWBs

$$
0 \longrightarrow \mathrm{M} \xrightarrow{i} \mathrm{M} \rtimes \mathrm{~A} \xrightarrow{\pi} \mathrm{~A} \longrightarrow 0
$$

where $i(m)=(m, 0), \pi(m, a)=a$, is exact. Moreover M is a two-sided ideal of $\mathrm{M} \rtimes \mathrm{A}$ and this sequence splits by $s: \mathrm{A} \rightarrow \mathrm{M} \rtimes \mathrm{A}, s(a)=(0, a)$. Then, as in Example 3.2 (iii), the above sequence induces another action of A on M given by

which actually matches the given one.

### 3.2. Crossed modules.

Definition 3.4. A crossed module of AWBs is a homomorphism of AWBs $\mu: \mathrm{M} \rightarrow \mathrm{A}$ together with an action of A on M such that the following identities hold:

for all $m, m^{\prime} \in \mathrm{M}, a \in \mathrm{~A}$.
Definition 3.5. A morphism of crossed modules $(M \xrightarrow{\mu} A) \rightarrow\left(M^{\prime} \xrightarrow{\mu^{\prime}} A^{\prime}\right)$ is a pair $(\alpha, \beta)$, where $\alpha: \mathrm{M} \rightarrow \mathrm{M}^{\prime}$ and $\beta: \mathrm{A} \rightarrow \mathrm{A}^{\prime}$ are homomorphisms of AWBs satisfying:
(a) $\beta \circ \mu=\mu^{\prime} \circ \alpha$.
(b)

\alpha\left({ }^{a \cdot} m\right)={ }^{\beta(a) \cdot} \cdot \alpha(m), & \alpha\left(m^{\cdot a}\right)=\alpha(m)^{\cdot \beta(a)}, \\
\alpha\left({ }^{a *} m\right)={ }^{\beta(a) *} \alpha(m), & \alpha\left(m^{* a}\right)=\alpha(m)^{* \beta(a)}
\end{array}
$$

for all $a \in \mathrm{~A}, m \in \mathrm{M}$.

It is clear that crossed modules of AWBs constitute a category, denoted by XAWB.
The following lemma is an easy consequence of Definition 3.4.
Lemma 3.6. Let $\mu: \mathrm{M} \rightarrow \mathrm{A}$ be a crossed module of AWBs. Then the following statements are satisfied:
(i) $\operatorname{Ker}(\mu) \subseteq \mathcal{Z}(\mathrm{M})$.
(ii) $\operatorname{Im}(\mu)$ is a two-sided ideal of A .
(iii) $\operatorname{Im}(\mu)$ acts trivially on $\mathcal{Z}(\mathrm{M})$, and so trivially on $\operatorname{Ker}(\mu)$. Hence $\operatorname{Ker}(\mu)$ inherits an action of $\mathrm{A} / \operatorname{Im}(\mu)$ making $\operatorname{Ker}(\mu)$ a representation of the $\mathrm{AWB} \mathrm{A} / \operatorname{Im}(\mu)$.

## Example 3.7.

(i) Let A be an AWB and B be a two-sided ideal of A , then the inclusion $\mathrm{B} \hookrightarrow \mathrm{A}$ is a crossed module, where the action of A on B is given by the operations in A (see Example 3.2 (ii)). Conversely, if $\mu: \mathrm{B} \rightarrow \mathrm{A}$ is a crossed module of AWBs and $\mu$ is an injective map, then B is isomorphic to a two-sided ideal of A by Lemma 3.6 (ii).
(ii) For any representation M of an AWB A , the trivial map $0: \mathrm{M} \rightarrow \mathrm{A}$ is a crossed module with the action of A on the abelian AWB M described in Example 3.2 (i).
Conversely, if $0: \mathrm{M} \rightarrow \mathrm{A}$ is a crossed module of AWBs, then M is necessarily an abelian AWB and the action of A on M is equivalent to M being a representation of A .
(iii) Any homomorphism of AWBs $\mu: \mathrm{M} \rightarrow \mathrm{A}$, with M abelian and $\operatorname{Im}(\mu) \subseteq \mathcal{Z}(\mathrm{A})$, provides a crossed module with A acting trivially on M .
(iv) If $0 \rightarrow \mathrm{~N} \rightarrow \mathrm{M} \xrightarrow{\mu} \mathrm{A} \rightarrow 0$ is a central extension of AWBs, then $\mu$ is a crossed module with the induced action of A on M (see Example 3.2 (v)).

Proposition 3.8. Let $\mu: \mathrm{M} \rightarrow \mathrm{A}$ be a crossed module of AWBs. Then the maps
(i) $\left(\mu, \mathrm{Id}_{\mathrm{A}}\right): \mathrm{M} \rtimes \mathrm{A} \rightarrow \mathrm{A} \rtimes \mathrm{A}$,
(ii) $\left(\mathrm{Id}_{\mathrm{M}}, \mu\right): \mathrm{M} \rtimes \mathrm{M} \rightarrow \mathrm{M} \rtimes \mathrm{A}$,
(iii) $\varphi: \mathrm{M} \rtimes \mathrm{A} \rightarrow \mathrm{M} \rtimes \mathrm{A}$ given by $\varphi(m, a)=(-m, \mu(m)+a)$,
are homomorphisms of AWBs.
Proof. (i) is a direct consequence of equalities in (CM1) of Definition 3.4, (ii) follows from equalities in (CM2), whilst (iii) requires both (CM1) and (CM2).

Remark 3.9. The functors $I$ and $T$ given in Example 2.2 (ii) and (iii) preserve actions and crossed modules in the sense of the following assertions:
(i) Any action of an associative algebra A on another associative algebra $\mathrm{M}, \mathrm{A} \times \mathrm{M} \rightarrow$ $\mathrm{M},(a, m) \mapsto a \cdot m$ and $M \times A \rightarrow M,(m, a) \mapsto m \cdot a$ (see [9, 8]) defines an action of the AWB $I(\mathrm{~A})$ on $I(\mathrm{M})$ (resp. of $T(\mathrm{~A})$ on $T(\mathrm{M})$ ), by letting

& \text { for all } a \in \mathrm{~A} \text { and } m \in \mathrm{M}
\end{aligned}

(ii) If $\mu: \mathrm{M} \rightarrow \mathrm{A}$ is a crossed module of associative algebras (see again [9, 8]), then the homomorphisms of AWBs $I(\mu): I(\mathrm{M}) \rightarrow I(\mathrm{~A})$ and $T(\mu): T(\mathrm{M}) \rightarrow T(\mathrm{~A})$, together with the actions of $I(\mathrm{~A})$ on $I(\mathrm{M})$ and of $T(\mathrm{~A})$ on $T(\mathrm{M})$, are crossed modules of AWBs.

In [5] we proved equivalence of crossed modules of AWBs with internal categories in the category of AWBs. Now we show their equivalence with cat ${ }^{1}$-AWBs. The following definition of cat ${ }^{1}$-AWB is given in complete analogy with Loday's original notion of cat ${ }^{1}$-groups [21].
Definition 3.10. A cat ${ }^{1}$ - $\mathrm{AWB}(\mathrm{R}, \mathrm{P}, s, t)$ consists of an AWB R , together with a subalgebra P and two homomorphisms $s, t: \mathrm{R} \rightarrow \mathrm{P}$ of AWBs satisfying the following conditions:
(a) $\left.s\right|_{\mathrm{P}}=\left.t\right|_{\mathrm{P}}=\mathrm{Id} \mathrm{P}$.
(b) $\operatorname{Ker}(s) \operatorname{Ker}(t)=0=\operatorname{Ker}(t) \operatorname{Ker}(s)$.
(c) $[\operatorname{Ker}(s), \operatorname{Ker}(t)]=0=[\operatorname{Ker}(t), \operatorname{Ker}(s)]$.

Definition 3.11. A morphism of cat ${ }^{1}-A W B s(\mathrm{R}, \mathrm{P}, s, t) \rightarrow\left(\mathrm{R}^{\prime}, \mathrm{P}^{\prime}, s^{\prime}, t^{\prime}\right)$ is a homomorphism of AWBs $f: \mathrm{R} \rightarrow \mathrm{R}^{\prime}$ such that $f(\mathrm{P}) \subseteq \mathrm{P}^{\prime}$ and $s^{\prime} \circ f=\left.f\right|_{\mathrm{P}} \circ s, t^{\prime} \circ f=\left.f\right|_{\mathrm{P}} \circ t$.

We let cat ${ }^{1}-$ AWB denote the category of cat ${ }^{1}$-AWBs. Then we have the following theorem.

Theorem 3.12. The categories cat $^{1}-\mathrm{AWB}$ and XAWB are equivalent.
Proof. To a given cat ${ }^{1}$-AWB ( $\mathrm{R}, \mathrm{P}, s, t$ ) we associate a crossed module $\mu=\left.t\right|_{\mathrm{M}}: \mathrm{M} \rightarrow$ P , where $\mathrm{M}=\operatorname{Ker}(s)$ and the action of P on M is given by the operations in R (see Example 3.2 (ii)). It is easy to see that $\mu: \mathrm{M} \rightarrow \mathrm{P}$ is a crossed module of AWBs and the assignment defines a functor $\Phi:$ cat $^{1}-$ AWB $\longrightarrow$ XAWB.

Conversely, let $\mu: \mathrm{M} \rightarrow \mathrm{P}$ be a crossed module of AWBs, then the associated cat ${ }^{1}$-AWB is given by $s, t: \mathrm{M} \rtimes \mathrm{P} \rightarrow \mathrm{P}$, where $s(m, p)=p, t(m, p)=\mu(m)+p, m \in \mathrm{M}, p \in \mathrm{P}$. It is straightforward to see that this assignment is functorial and provides a quasi-inverse functor for $\Phi$.

## 4. Non-AbELIAN TENSOR PRODUCT OF AWBS

Definition 4.1. Let M and N be AWBs with mutual actions on each other. The actions are said to be compatible if

and moreover, another 16 equations obtained by exchanging the roles of elements of M and N in (4.1) are also valid.

## Example 4.2.

(a) If M and N are two-sided ideals of an AWB A , then the mutual actions on each other considered in Example 3.2 (ii) are compatible.
(b) Let $\mu: \mathrm{M} \rightarrow \mathrm{P}$ and $\nu: \mathrm{N} \rightarrow \mathrm{P}$ be two crossed modules of AWBs. Then the mutual actions of M on N via $\mu$ and of N on M via $\nu$ are compatible.

Let M and N be AWBs with mutual compatible actions on each other. We denote by $\mathrm{M} \odot \mathrm{N}$ the vector space spanned by all symbols $m \odot n, n \odot m$ and by $\mathrm{M} \circledast \mathrm{N}$ the vector space spanned by all symbols $m \circledast n, n \circledast m$, for $m \in \mathrm{M}, n \in \mathrm{~N}$. Let $\mathrm{M} \boxtimes \mathrm{N}$ denotes the quotient of $(\mathrm{M} \odot \mathrm{N}) \oplus(\mathrm{M} \circledast \mathrm{N})$ by the following relations:

Proposition 4.3. The vector space $\mathrm{M} \boxtimes \mathrm{N}$ endowed with the product and bracket operations given on the generators by

has the structure of an AWB.
Proof. Straightforward calculations show that, under the conditions of compatible actions (4.1), by using the relations in (4.2), the described operations on $\mathrm{M} \boxtimes \mathrm{N}$ satisfy the fundamental identity (2.1).

Definition 4.4. The structure of AWB on $\mathrm{M} \boxtimes \mathrm{N}$ provided by Proposition 4.3 is called the non-abelian tensor product of the AWBs M and N .

In particular, if the actions are trivial, the non-abelian tensor product can be described as follows.

Proposition 4.5. If M and N are two AWBs with trivial actions on each other, then there is an isomorphism of abelian AWBs

\mathrm{M} \boxtimes \mathrm{~N} \cong\left(\mathrm{M}^{a b} \otimes_{\mathbb{K}} \mathrm{N}^{a b}\right) \oplus\left(\mathrm{N}^{a b} \otimes_{\mathbb{K}} \mathrm{M}^{a b}\right) \oplus\left(\mathrm{M}^{a b} \otimes_{\mathbb{K}} \mathrm{N}^{a b}\right) \oplus\left(\mathrm{N}^{a b} \otimes_{\mathbb{K}} \mathrm{M}^{a b}\right)
$$

Proof. Equations in Proposition 4.3 show us easily that $\mathrm{M} \boxtimes \mathrm{N}$ is abelian in the case of trivial actions. The defining relations (4.2) of the non-abelian tensor product say that the vector space $M \boxtimes N$ is the quotient of $\left(M \otimes_{\mathbb{K}} N\right) \oplus\left(N \otimes_{\mathbb{K}} M\right) \oplus\left(M \otimes_{\mathbb{K}} N\right) \oplus\left(N \otimes_{\mathbb{K}} M\right)$ by the
relations

for all $m, m_{1}, m_{2} \in \mathrm{M}, n, n_{1}, n_{2} \in \mathrm{~N}$. This provides the required isomorphism.
The non-abelian tensor product of AWBs is functorial in the following sense: let $f: \mathrm{M} \rightarrow$ $\mathrm{M}^{\prime}$ and $g: \mathrm{N} \rightarrow \mathrm{N}^{\prime}$ be homomorphisms of AWBs together with compatible mutual actions of M and N , also $\mathrm{M}^{\prime}$ and $\mathrm{N}^{\prime}$ on each other such that $f, g$ preserve these actions, i.e.

The non-abelian tensor product of AWBs has a kind of right-exactness property presented in the following theorem.

Theorem 4.6. Let $0 \rightarrow \mathrm{M}_{1} \xrightarrow{f} \mathrm{M}_{2} \xrightarrow{g} \mathrm{M}_{3} \rightarrow 0$ be a short exact sequence of AWBs. Let N be an AWB together with compatible actions of N and $\mathrm{M}_{i}(i=1,2,3)$ on each other and $f$, $g$ preserve these actions. Then there is an exact sequence of AWBs

\mathrm{M}_{1} \boxtimes \mathrm{~N} \xrightarrow{f \boxtimes l \mathrm{~d}_{N}} \mathrm{M}_{2} \boxtimes \mathrm{~N} \xrightarrow{g \boxtimes \mathrm{l} \mathrm{~d}_{N}} \mathrm{M}_{3} \boxtimes \mathrm{~N} \rightarrow 0 .
$$

Proof. It is clear that the composition $\left(g \boxtimes \mathrm{Id}_{\mathrm{N}}\right)\left(f \boxtimes \mathrm{Id}_{\mathrm{N}}\right)$ is the trivial map, i.e. $\operatorname{Im}\left(f \boxtimes \operatorname{Id}_{\mathrm{N}}\right) \subseteq$ $\operatorname{Ker}\left(f \boxtimes \mathrm{Id}_{\mathrm{N}}\right)$ and at the same time $f \boxtimes \mathrm{Id}_{\mathrm{N}}$ is an epimorphism.
$\operatorname{lm}\left(f \boxtimes \mathrm{Id}_{\mathrm{N}}\right)$ is generated by the elements of the form $f\left(m_{1}\right) \odot n, n \odot f\left(m_{1}\right), f\left(m_{1}\right) \circledast n$ and $n \circledast f\left(m_{1}\right)$, for all $m_{1} \in \mathrm{M}_{1}, n \in \mathrm{~N}$. Since $f$ preserves actions of N , by the relations given in Proposition 4.3, it is easily verified that $\operatorname{Im}\left(f \boxtimes I d_{N}\right)$ is a two-sided ideal of $\mathrm{M}_{2} \boxtimes \mathrm{~N}$. For instance, taking a generator of the form $m_{2} \odot n^{\prime}$ in $\mathrm{M}_{2} \boxtimes \mathrm{~N}$ we have

Then, there is a homomorphism of AWBs

induced by $g \boxtimes \mathrm{Id}_{\mathrm{N}}$, that is, defined on generators by

where the overdrawn generator denotes the coset of the corresponding element. On the other hand, we have well-defined homomorphism of AWBs

where $m_{2} \in \mathrm{M}_{2}$ is any element such that $g\left(m_{2}\right)=m_{3}$. Obviously $\alpha$ and $\alpha^{\prime}$ are inverse to each other, i.e. $\alpha$ is an isomorphism. Then the required exactness follows.

& \psi_{\mathrm{N}}(m \circledast n)=m^{*} n, \psi_{\mathrm{N}}(n \circledast m)=n^{* m} .

(b) There are actions of M and N on the non-abelian tensor product $\mathrm{M} \boxtimes \mathrm{N}$ given, for all $m, m^{\prime} \in \mathrm{M}, n, n^{\prime} \in \mathrm{N}$, by

(c) The homomorphisms $\psi_{\mathrm{M}}$ and $\psi_{\mathrm{N}}$ together with the actions described in the statement (b) are crossed modules of AWBs.

Proof. This is straightforward but tedious verification.
Theorem 4.8. If A is a perfect AWB , then $\psi_{\mathrm{A}}: \mathrm{A} \boxtimes \mathrm{A} \rightarrow \mathrm{A}$ is the universal central extension of A .

Proof. Clearly $\psi_{\mathrm{A}}: \mathrm{A} \boxtimes \mathrm{A} \rightarrow \mathrm{A}$ is an epimorphism if A is perfect. Moreover, it is a crossed module of AWBs by Proposition 4.7 (c). Then Lemma 3.6 (i) says that it is a central extension.

To show the universal property, consider any central extension $0 \rightarrow \mathrm{M} \rightarrow \mathrm{B} \xrightarrow{\phi} \mathrm{A} \rightarrow 0$. Since $\operatorname{Ker}(\phi) \subseteq \mathcal{Z}(\mathrm{B})$, we get a well-defined homomorphism of AWBs $\varphi$ : A $\boxtimes \mathrm{A} \rightarrow \mathrm{B}$ given on generators by $\varphi\left(a \odot a^{\prime}\right)=b b^{\prime}$ and $\varphi\left(a \circledast a^{\prime}\right)=\left[b, b^{\prime}\right]$, where $b$ and $b^{\prime}$ are any elements in $\phi^{-1}(a)$ and $\phi^{-1}\left(a^{\prime}\right)$, respectively. Obviously $\phi \varphi=\psi_{\mathrm{A}}$. Moreover, since A is perfect, it follows by the equalities in Proposition 4.3 that $A \boxtimes A$ is a perfect AWB as well. Then [3, Lemma 3.1] implies that $\varphi$ is the unique homomorphism satisfying the required conditions.

Bearing in mind that the universal central extension of a perfect AWB is unique up to isomorphism, by [3, Theorem 3.5] we conclude that

Moreover, if $0 \rightarrow \mathrm{R} \rightarrow \mathrm{F} \xrightarrow{\rho} \mathrm{A} \rightarrow 0$ is a free presentation of a perfect AWB A , then its universal central extension is

0 \longrightarrow \frac{\mathrm{R} \cap[[\mathrm{~F}, \mathrm{~F}]]}{[[\mathrm{F}, \mathrm{R}]]} \longrightarrow \frac{[[\mathrm{F}, \mathrm{~F}]]}{[[\mathrm{F}, \mathrm{R}]]} \xrightarrow{\rho^{*}} \mathrm{~A} \longrightarrow 0
$$

(see [3]), hence

A \boxtimes A \cong \frac{[[F, F]]}{[[F, R]]}

due to the uniqueness (up to isomorphisms) of the universal central extension.

Remark 4.9. The article [3] provides another description of the universal central extension of a perfect AWB $A$. In particular, it is shown that, given an AWB $A$, the quotient $\frac{\mathrm{A}^{\otimes 2} \oplus \mathrm{~A}^{\otimes 2}}{I_{\mathrm{A}}}$ has an AWB structure, where $I_{\mathrm{A}}$ is the image of the map $d_{2}: \mathrm{A}^{\otimes 3} \oplus \mathrm{~A}^{\otimes 3} \rightarrow \mathrm{~A}^{\otimes 2} \oplus \mathrm{~A}^{\otimes 2}$ in the homology chain complex $\left(C_{*}^{\mathrm{AWB}}(\mathrm{A}), d_{*}\right)$, that is, $I_{\mathrm{A}}$ is the subspace of $\mathrm{A}^{\otimes 2} \oplus \mathrm{~A}^{\otimes 2}$ spanned by the elements of the form

for any $a_{1}, a_{2}, a_{3} \in \mathrm{~A}$. Moreover, if A is a perfect AWB , then it gives the construction of the universal central extension of A . As a consequence, we have the following isomorphism of AWBs

given by $a_{1} \otimes a_{2} \mapsto a_{1} \odot a_{2}$ and $a_{1} \circ a_{2} \mapsto a_{1} \circledast a_{2}$.
Proposition 4.10. If M is a two-sided ideal of an AWB A , then there is the exact sequence of AWBs

(\mathrm{M} \boxtimes \mathrm{~A}) \rtimes(\mathrm{A} \boxtimes \mathrm{M}) \xrightarrow{\sigma} \mathrm{A} \boxtimes \mathrm{~A} \xrightarrow{\tau} \mathrm{~A} / \mathrm{M} \boxtimes \mathrm{~A} / \mathrm{M} \rightarrow 0 .
$$

Proof. The functorial property of the non-abelian tensor product applied to the projection $A \rightarrow A / M$ induces the surjective homomorphism $\tau$, and applied to inc: $M \rightarrow A$ and Id : $\mathrm{A} \rightarrow \mathrm{A}$ provides the homomorphisms $\sigma^{\prime}: \mathrm{M} \boxtimes \mathrm{A} \rightarrow \mathrm{A} \boxtimes \mathrm{A}$ and $\sigma^{\prime \prime}: \mathrm{A} \boxtimes \mathrm{M} \rightarrow \mathrm{A} \boxtimes \mathrm{A}$.

Define $\sigma(x, y)=\sigma^{\prime}(x)+\sigma^{\prime \prime}(y)$, for all $x \in \mathrm{M} \boxtimes \mathrm{A}, y \in \mathrm{~A} \boxtimes \mathrm{M}$. $\operatorname{Im}(\sigma)$ is a two sided ideal of $\mathrm{A} \boxtimes \mathrm{A}$ spanned by the elements of the form $m \odot a, a \odot m, m \circledast a, a \circledast m$ for all $a \in \mathrm{~A}$ and $m \in \mathrm{M}$.

By the identities in Proposition 4.3 and the relations (4.2) of the non-abelian tensor product, $\tau$ induces a homomorphism of AWBs $\bar{\tau}: \frac{\mathrm{A} \boxtimes \mathrm{A}}{\operatorname{lm}(\sigma)} \rightarrow \mathrm{A} / \mathrm{M} \boxtimes \mathrm{A} / \mathrm{M}$. Define $\tau^{\prime}: \mathrm{A} / \mathrm{M} \boxtimes$ $\mathrm{A} / \mathrm{M} \rightarrow \frac{\mathrm{A} \boxtimes \mathrm{A}}{\operatorname{Im}(\sigma)}$ by $\tau^{\prime}\left(\left(a_{1}+\mathrm{M}\right) \odot\left(a_{2}+\mathrm{M}\right)\right)=a_{1} \odot a_{2}+\operatorname{Im}(\sigma), \tau^{\prime}\left(\left(a_{1}+\mathrm{M}\right) \circledast\left(a_{2}+\mathrm{M}\right)\right)=$ $a_{1} \circledast a_{2}+\operatorname{Im}(\sigma)$. It is easy to check that $\tau^{\prime}$ is a well-defined homomorphism that is inverse to $\bar{\tau}$.

Theorem 4.11. Let M be a two-sided ideal of a perfect AWB A. Then there is an exact sequence of vector spaces

$$
\operatorname{Ker}\left(\mathrm{M} \boxtimes \mathrm{~A} \xrightarrow{\psi_{\mathrm{M}}} \mathrm{M}\right) \rightarrow \mathrm{H}_{1}^{\mathrm{AWB}}(\mathrm{~A}) \rightarrow \mathrm{H}_{1}^{\mathrm{AWB}}(\mathrm{~A} / \mathrm{M}) \rightarrow \frac{\mathrm{M}}{[[\mathrm{~A}, \mathrm{M}]]} \rightarrow 0
$$

Proof. Due to Proposition 4.10 there is the following commutative diagram of AWBs with exact rows

where

$$
\begin{array}{ll}
\psi\left(m_{1} \odot a_{1}, a_{2} \odot m_{2}\right)=m_{1} a_{1}+a_{2} m_{2}, & \psi\left(m_{1} \odot a_{1}, a_{2} \circledast m_{2}\right)=m_{1} a_{1}+\left[a_{2}, m_{2}\right], \\
\psi\left(m_{1} \circledast a_{1}, a_{2} \odot m_{2}\right)=\left[m_{1}, a_{1}\right]+a_{2} m_{2}, & \psi\left(m_{1} \circledast a_{1}, a_{2} \circledast m_{2}\right)=\left[m_{1}, a_{1}\right]+\left[a_{2}, m_{2}\right] .
\end{array}
$$

The Snake lemma provides the exact sequence

$$
\operatorname{Ker}(\psi) \rightarrow \operatorname{Ker}\left(\psi_{\mathrm{A}}\right) \rightarrow \operatorname{Ker}\left(\psi_{\mathrm{A} / \mathrm{M}}\right) \rightarrow \operatorname{Coker}(\psi) \rightarrow 0 .
$$

By Theorem 4.8 $\operatorname{Ker}\left(\psi_{\mathrm{A}}\right)=\mathrm{H}_{1}^{\mathrm{AWB}}(\mathrm{A})$, and since $\mathrm{A} / \mathrm{M}$ is a perfect AWB as well, we also have $\operatorname{Ker}\left(\psi_{\mathrm{A}} / \mathrm{M}\right)=\mathrm{H}_{1}^{\mathrm{AWB}}(\mathrm{A} / \mathrm{M})$. Obviously $\operatorname{Coker}(\psi)=\frac{\mathrm{M}}{[[\mathrm{A}, \mathrm{M}]] \text {. Then the fact that there is }}$ a surjective map $\operatorname{Ker}\left(\psi_{\mathrm{M}}\right) \rightarrow \operatorname{Ker}(\psi)$ completes the proof.
