# EXACT LOCAL DISTRIBUTION OF THE ABSOLUTELY CONTINUOUS SPECTRAL MEASURE

#### Abstract

It is well-established that the spectral measure for one-frequency Schrödinger operators with Diophantine frequencies exhibits optimal $1 / 2$-Hölder continuity within the absolutely continuous spectrum. This study extends these findings by precisely characterizing the local distribution of the spectral measure for dense small potentials, including a notable result for any subcritical almost Mathieu operators. Additionally, we investigate the stratified Hölder continuity of the spectral measure at subcritical energies.

## 1. Introduction

Let $\mu$ be a Borel probability measure on $\mathbb{R}$. The local distribution, or the fine property, of $\mu$ provides insights into the behavior of $\mu$ at a local level. The central concept is the local dimension of the measure:

$$
\underline{D} \mu(E)=\liminf _{\epsilon \rightarrow 0} \frac{\ln \mu(E-\epsilon, E+\epsilon)}{\ln \epsilon}
$$

is called the lower local dimension of $\mu$, while

$$
\bar{D} \mu(E)=\limsup _{\epsilon \rightarrow 0} \frac{\ln \mu(E-\epsilon, E+\epsilon)}{\ln \epsilon}
$$

is called the upper local dimension of $\mu$. If $\underline{D} \mu(E)=\bar{D} \mu(E)$ exists, one then call

D \mu(E)=\lim _{\epsilon \rightarrow 0} \frac{\ln \mu(E-\epsilon, E+\epsilon)}{\ln \epsilon}
$$

the local dimension, or the scaling index of $\mu$ (at $E$ ). If the local dimension of $\mu$ exists and is constant $\mu$-almost everywhere, then $\mu$ is exact dimensional.

The study of these properties enables mathematicians to comprehend the intricate structures and patterns that emerge in complex systems, offering insights into their behavior at different scales. These properties have already played a pivotal role in various mathematical domains. For example, it helps in understanding the irregularities and variations in the fractal structure, and helps in bridging the gap between geometric and measure-theoretic perspectives [ANat99, FLRO2, 'FH09: Fallit, it helps in determining the long-term statistical behavior, the stability of dynamical systems ets.

In this paper, we are interested in the local distribution of the spectral measure of the quasi-periodic Schrödinger operator on $\ell^{2}(\mathbb{Z})$ :

$$
\begin{equation*}
\left(H_{v, \alpha, \theta} u\right)(n)=u(n+1)+u(n-1)+v(n \alpha+\theta) u(n), \tag{1.1}
\end{equation*}
$$

where the potential $v \in C^{\omega}\left(\mathbb{T}^{d}, \mathbb{R}\right)$ is analytic, the frequency $\alpha \in(\mathbb{R} \backslash \mathbb{Q})^{d}$ is rationally independent, and the phase $\theta \in \mathbb{R}^{d}$. The spectrum $\Sigma_{v, \alpha}$ is a compact set of $\mathbb{R}$ independent of $\theta$.

A central example is the almost Mathieu operator (AMO):

$$
\left(H_{\lambda, \alpha, \theta} u\right)(n)=u(n+1)+u(n-1)+2 \lambda \cos 2 \pi(n \alpha+\theta) u(n),
$$

which was initially introduced by Peierls [Pei33] as a model for an electron in a 2D lattice with a homogeneous magnetic field [AMO also plays a crucial role in the Thouless et al. theory of the integer quantum Hall effect [NW

Absolutely continuous spectrum occurs only rarely in one-dimensional Schrödinger operators [Rem $\left.{ }^{2}=1 \overline{1} 1\right]$. The Kotani-Last conjecture says that within the class of ergodic Schrödinger operators, absolutely continuous spectrum only occurs for almost periodic potentials. This conjecture was recently disproven [ANvily quasiperiodic operators, if the potential $v$ is small, then $H_{v, \alpha, \theta}$ always has a purely absolutely


We will be concerned with the local distribution of absolutely continuous spectral measures. By the spectral theorem, there exist Borel probability measures $\mu_{v, \alpha, \theta}^{i}$ on $\mathbb{R}$ such that

$$
\left\langle\delta_{i}, f\left(H_{v, \alpha, \theta}\right) \delta_{i}\right\rangle=\int f(E) d \mu_{v, \alpha, \theta}^{i}(E)
$$

for all bounded measurable functions $f$. We take $\mu_{v, \alpha, \theta}=\mu_{v, \alpha, \theta}^{0}+\mu_{v, \alpha, \theta}^{1}$ as the canonical spectral measure, since any spectral measure of (11.1 1 to it. The density of states measure (DOS) $n_{v, \alpha}$ is given by the $\theta$-average of those spectral measures $\mu_{v, \alpha, \theta}^{0}$ with respect to the Lebesgue measure, that is,

$$
\int_{\mathbb{T}^{d}}\left\langle\delta_{0}, f\left(H_{v, \alpha, \theta}\right) \delta_{0}\right\rangle d \theta=\int f(E) d n_{v, \alpha}(E)
$$

The integrated density of states (IDS) is the distribution function of $n_{v, \alpha}$, that is,

$$
\mathcal{N}_{v, \alpha}(E):=n_{v, \alpha}((-\infty, E])
$$

For simplicity, we denote the spectrum, canonical spectral measure, DOS and IDS of AMO by $\Sigma_{\lambda, \alpha}, \mu_{\lambda, \alpha, \theta}, n_{\lambda, \alpha}$ and $\mathcal{N}_{\lambda, \alpha}(E)$, respectively. The following is a natural question: if $\mu_{v, \alpha, \theta}$ is absolutely continuous, what is the local distribution or the fine properties of $\mu_{v, \alpha, \theta}$ (resp. the DOS $\left.n_{v, \alpha}\right)$ ?
1.1. Exact local distribution of ac measure: almost Mathieu case. In 1986, when studying the fractal problems of AMO, the physicist Tang and Kohmoto made the following conjecture [TNK $\overline{1} \overline{6} \overline{6}]$ :
"An absolutely continuous spectrum (extended states), it is dominated by points with 'trivial' scaling index $D \nu(E)=11_{1}^{11}$, and a fraction dimension 1. It can contain a finite or a countably number of singularities with $D \nu(E) \neq 1$, perhaps van Hove singularities."
In this paper, we intend to answer Tang-Kohmoto's conjectrue, even more, we give the local dimension at any energy $E$.

To introduce our precise results, we first introduce some necessary concepts. Throughout the paper, we will always assume the frequency $\alpha$ is Diophantine. Recall that $\alpha$ is Diophantine if $\alpha \in \mathrm{DC}_{d}:=\bigcup_{\gamma>0, \tau>d} \mathrm{DC}_{d}(\gamma, \tau)$ where

$$
\mathrm{DC}_{d}(\gamma, \tau):=\left\{x \in \mathbb{R}^{d}: \inf _{j \in \mathbb{Z}}|\langle n, x\rangle-j| \geqslant \frac{\gamma}{|n|^{\tau}}, n \in \mathbb{Z}^{d}-\{\mathbf{0}\}\right\} .
$$

We find that the local dimension of spectral measures of AMO is actually determined by the resonances of IDS. For any $\varphi \in[0,1]$, we define

$$
\begin{equation*}
\delta(\alpha, \varphi)=\limsup _{k \rightarrow \infty}-\frac{\ln \|\varphi-\langle k, \alpha\rangle\|_{\mathbb{R} / \mathbb{Z}}}{|k|} \tag{1.2}
\end{equation*}
$$

which characterize the strength of resonances of $\varphi$ with respect to the frequency $\alpha$. By the famous "Gap Labelling Theorem" [Joh8ढ̈], if $E \notin \Sigma_{\lambda, \alpha}$, then $\mathcal{N}_{\lambda, \alpha}(E)=k \alpha \bmod \mathbb{Z}$, which we will formally set $\delta\left(\alpha, \mathcal{N}_{\lambda, \alpha}(E)\right)=\infty$. The following result completely addresses Tang and Kohmoto's question.

Theorem 1.1. Let $0<|\lambda|<1, \alpha \in \mathrm{DC}_{1}$. Then for any $E \in \Sigma_{\lambda, \alpha}$, we have the following arithmetic description:
(1) If $\mathcal{N}_{\lambda, \alpha}(E) \neq k \alpha \bmod \mathbb{Z}$. Let $\delta\left(\alpha, \mathcal{N}_{\lambda, \alpha}(E)\right)=\delta$. Then for all $\theta \in \mathbb{R}$, we have

$$
\underline{D} \mu_{\lambda, \alpha, \theta}(E)=\frac{\delta}{\max \{2 \delta+\ln \lambda, \delta\}} \in[1 / 2,1], \bar{D} \mu_{\lambda, \alpha, \theta}(E)=1 .
$$

(2) If $\mathcal{N}_{\lambda, \alpha}(E)=k \alpha \bmod \mathbb{Z}$. Then for all $\theta \in \mathbb{R}$, we have

$$
\underline{D} \mu_{\lambda, \alpha, \theta}(E)=\bar{D} \mu_{\lambda, \alpha, \theta}(E)=1 / 2 .
$$

Remark 1.1.
(1) Theorem $\overline{1}_{1}^{1} \overline{1} 1$ implies that $\bar{D} \mu_{\lambda, \alpha, \theta}(E)=1$ except for a countably number of singularties with $\bar{D} \mu_{\lambda, \alpha, \theta}(E)=1 / 2$.
(2) As the result holds for any phase $\theta$, it immediately implies that all results in Theorem IT. 1.1 holds for the DOS measure $n_{\lambda, \alpha}$.

[^0]Indeed, we can not only calculate the local dimension of the spectral measure at any energy, but also establish the exact local distribution of the spectral measure, which exhibits fractal properties governed by the resonances of the IDS. To explain this, let $\alpha \in \mathbb{R}^{d}, \theta \in \mathbb{R}$, $\epsilon_{0}>0$, we say that $k$ is a $\epsilon_{0}$-resonance of $\theta$, if

$$
\begin{equation*}
\|\theta-\langle k, \alpha\rangle\|_{\mathbb{R} / \mathbb{Z}} \leqslant e^{-\epsilon_{0}|k|} . \tag{1.3}
\end{equation*}
$$

Choose any $0<\epsilon_{0}<-\ln \lambda$. We consider now the set of $\epsilon_{0}$-resonances of $\mathcal{N}_{\lambda, \alpha}(E)$. Take and order all the $\epsilon_{0}$-resonances by $0=\ell_{0}<\left|\ell_{1}\right| \leqslant\left|\ell_{2}\right| \leqslant \cdots$. For any $\mathcal{N}_{\lambda, \alpha}(E) \in[0,1]$, and any $\ell_{s}$, denoting $n=\left|\ell_{s}\right|$, we define $\eta_{n}$ by

$$
\begin{equation*}
\eta_{n}=-\frac{\ln \left\|\mathcal{N}_{\lambda, \alpha}(E)-\ell_{s} \alpha\right\|_{\mathbb{T}}}{\left|\ell_{s}\right|} \in(0, \infty] . \tag{1.4}
\end{equation*}
$$

One can obtain the exact local distribution of the absolutely spectral measure as follows:
Theorem 1.2. Let $0<\lambda<1, \alpha \in \mathrm{DC}_{1}, E \in \Sigma_{\lambda, \alpha}$. There exists $C(\lambda, \alpha, E)>0$, and for any $\varepsilon>0$, there exists $\epsilon_{*}=\epsilon_{*}(\lambda, \alpha, E, \varepsilon)>0$ such that for any $\epsilon \leqslant \epsilon_{*}$, and for any $\theta \in \mathbb{R}$, we have the following:
(1) If $\delta\left(\alpha, \mathcal{N}_{\lambda, \alpha}(E)\right)=\delta \geqslant-\ln \lambda$, and $\mathcal{N}_{\lambda, \alpha}(E) \neq k \alpha \bmod \mathbb{Z}$. Then

$$
\epsilon^{f(\epsilon)+\varepsilon} \leqslant \mu_{\lambda, \alpha, \theta}(E-\epsilon, E+\epsilon) \leqslant \epsilon^{f(\epsilon)-\varepsilon},
$$

where $f(\epsilon):\left(0, \epsilon_{*}\right] \rightarrow(1 / 2,1]$ has the following expression:
(i) If $\eta_{n} \leqslant-\ln \lambda$, then $f(\epsilon)=1$ for $\epsilon \in\left[e^{\left|\ell_{s}+1\right| \ln \lambda}, e^{\left|\ell_{s}\right| \ln \lambda}\right]$.
(ii) If $\eta_{n} \geqslant-\ln \lambda$, then

$$
f(\epsilon)= \begin{cases}\frac{1}{2}-\frac{\ln \lambda\left|\ell_{s}\right|}{2 \ln \epsilon^{-1}} & \text { for } \epsilon \in\left[e^{-\left(2 \eta_{n}+\ln \lambda\right)\left|\ell_{s}\right|}, e^{\left|\ell_{s}\right| \ln \lambda}\right]  \tag{1.5}\\ \frac{1}{1-b_{s}}+\frac{b_{s}}{1-b_{s}} \frac{\ln \lambda\left|\ell_{s+1}\right|}{\ln \epsilon^{-1}} & \text { for } \epsilon \in\left[e^{\left|\ell_{s+1}\right| \ln \lambda}, e^{-\left(2 \eta_{n}+\ln \lambda\right)\left|\ell_{s}\right|}\right]\end{cases}
$$

where $b_{s}=\frac{\left(\eta_{n}+\ln \lambda\right)\left|\ell_{s}\right|}{-\ln \lambda\left|\ell_{s+1}\right|-\eta_{n}\left|\ell_{s}\right|}$.
(2) If $\delta\left(\alpha, \mathcal{N}_{\lambda, \alpha}(E)\right)=\delta<-\ln \lambda$. Then

$$
C^{-1} \epsilon^{1+\varepsilon} \leqslant \mu_{\lambda, \alpha, \theta}(E-\epsilon, E+\epsilon) \leqslant C \epsilon
$$

(3) If $\mathcal{N}_{\lambda, \alpha}(E)=k \alpha \bmod \mathbb{Z}$ for some $k \in \mathbb{Z}$. Then

$$
C^{-1} \epsilon^{\frac{1}{2}+\varepsilon} \leqslant \mu_{\lambda, \alpha, \theta}(E-\epsilon, E+\epsilon) \leqslant C \epsilon^{\frac{1}{2}} .
$$

Let us explain more about this exact local distribution, as illustrated in Figure 'I.1.' The asymptotic function $f(\epsilon)$ has a universal structure which does not depend on the choice of $\epsilon_{0}<-\ln \lambda$. It depends only on the resonances $n_{s}$ and $\eta_{n}$, and displays a fractal structure around all these "resonance windows" $\left[e^{\left|\ell_{s+1}\right| \ln \lambda}, e^{\left|\ell_{s}\right| \ln \lambda}\right]$. Although the proof relies on the almost reducibility procedure, which is of a local nature, $f(\epsilon)$ is a globally defined function. Furthermore, those effective $\epsilon_{0}$-resonances are actually from

$$
\left\|\mathcal{N}_{\lambda, \alpha}(E)-\ell_{s} \alpha\right\|_{\mathbb{T}} \leqslant e^{\ln \lambda\left|\ell_{s}\right|}
$$

Indeed, if the resonance is weak (i.e. $\eta_{n} \leqslant-\ln \lambda$ ), then $f(\epsilon)$ is always equal to 1 , which implies that $\mu_{\lambda, \alpha, \theta}$ is almost Lipschitz, if the resonance is strong (i.e. $\eta_{n} \geqslant-\ln \lambda$ ), then $f(\epsilon)$ has some fluctuation, but at least $\mu_{\lambda, \alpha, \theta}$ has exact Hölder exponent $\frac{\eta_{n}}{2 \eta_{n}+\ln \lambda}$ in this "resonance
windows" . We should remark that ( $\left.1 \overline{1} \cdot \overline{V_{1}}\right)$ was also motivated by recent result of JitomirskayaLiu [J]izility, who revealed a universal hierarchical structure in localized eigenfunctions for supercritical AMO. Specifically, they not only determine the optimal asymptotics of the localized eigenfunction but also uncover the hierarchical structure of local maxima. This global/local structure is characterized by a universal function $f(k)$, which is defined by the resonances of the phase. Meanwhile, the exact asymptotics of the extended eigenfunction (generalized eigenfunction in the absolutely continuous spectrum regime) was explored quite recently [GYZ24].

To the best of our knowledge, Theorem '1. $1 \mathbf{1} 1$ and Theorem ' 1 local dimensional property of individual absolutely continuous spectral measures of ergodic
 of the absolutely continuous spectral measure. Theorem 'i. 2 ' (3) further shows that their result is optimal. One can also consider [DG13, 'DGY16', 'Qu18', 'CQ23'] for the dimensional properties of the DOS measure in the Sturm Hamiltonian case, where the spectral measure is singular.
1.2. Stratified Hölder continuity. Theorem till establish the upper (resp. lower) local dimension of the spectral measure for AMO, in other language, Theorem in shows the exact local Hölder exponent of the absolutely continuous spectral measure of AMO at any energy. For general potentials, let us recall the Spectral Dichotomy Conjecture proved by


Spectral Dichotomy Conjecture. For typical $v, \alpha, \theta, H_{v, \alpha, \theta}$ is the direct sum of operators $H_{+}$and $H_{-}$with disjoint spectra such that $H_{+}$is "localized" and $H_{-}$is absolutely continuous.

Actually one has dynamical information on $H_{-}$. Given $A \in C^{\omega}\left(\mathbb{T}^{d}, \mathrm{SL}(2, \mathbb{R})\right)$ and rationally independent $\alpha \in \mathbb{R}^{d}$, recall a quasiperiodic cocycle $(\alpha, A)$ is defined as:

$$
(\alpha, A):\left\{\begin{aligned}
\mathbb{T}^{d} \times \mathbb{R}^{2} & \rightarrow \mathbb{T}^{d} \times \mathbb{R}^{2} \\
(x, v) & \mapsto(x+\alpha, A(x) \cdot v)
\end{aligned}\right.
$$

An one-frequency cocycle $(\alpha, A)$ is called subcritical, if there is a uniform subexponential bound on the growth of the $n$-th iterate $\left\|\mathcal{A}_{n}(\cdot)\right\|$ through some band $\{z:|\Im z|<h\}$, here $h$ is called the subcritical radius. Note (11.1) naturally induces a Schrödinger cocycle ( $\alpha, S_{E}^{v}$ ),
where

$$
S_{E}^{v}(\theta)=\left(\begin{array}{cc}
E-v(\theta) & -1 \\
1 & 0
\end{array}\right) \in \mathrm{SL}(2, \mathbb{R})
$$

then $H_{-}$is just $H$ restricted to $\Sigma_{v, \alpha}^{-}$: the energies $E \in \Sigma_{v, \alpha}$ such that ( $\alpha, S_{E}^{v}$ ) is subcritical [AviI5aravi23

Now the natural question is whether Theorem hin is true for any absolutely continuous spectral measure. Of course, the answer is no because of the possible collapes of gaps (one can also consult Proposition ' $\left.{ }^{\prime} \cdot \mathbf{-} \cdot \mathbf{I}^{\prime}{ }^{\prime}\right)$. Nevertheless, our method allows us to obtain the stratified Hölder continuity at subcritical energies.

Theorem 1.3. Let $\alpha \in \mathrm{DC}_{1}, v \in C^{\omega}(\mathbb{T}, \mathbb{R}), E \in \Sigma_{v, \alpha}^{-}$with subcritical radius $h$. Then for $\epsilon$ sufficiently small, and for all $\theta$, we have the following:
(1) If $2 \pi h \leqslant \delta\left(\alpha, \mathcal{N}_{v, \alpha}(E)\right)=\delta<\infty$, then we have

$$
\mu_{v, \alpha, \theta}(E-\epsilon, E+\epsilon) \leqslant \epsilon^{\frac{\delta}{2 \delta-2 \pi h}-o(1)}
$$

(2) If $\delta\left(\alpha, \mathcal{N}_{v, \alpha}(E)\right)<2 \pi h$, then we have

$$
\mu_{v, \alpha, \theta}(E-\epsilon, E+\epsilon) \leqslant C \epsilon
$$

(3) If $\delta\left(\alpha, \mathcal{N}_{v, \alpha}(E)\right)=\infty$, then we have

$$
\mu_{v, \alpha, \theta}(E-\epsilon, E+\epsilon) \leqslant C \epsilon^{\frac{1}{2}} .
$$

The stratified Hölder continuity of the absolutely continuous spectral measure holds for any phase $\theta$, thus the corresponding result also holds for the integrated density of states (IDS):
Corollary 1.1. Let $\alpha \in \mathrm{DC}_{1}, v \in C^{\omega}(\mathbb{T}, \mathbb{R}), E \in \Sigma_{v, \alpha}^{-}$with subcritical radius $h$. Then for $\epsilon$ sufficiently small, we have the following:
(1) If $2 \pi h \leqslant \delta\left(\alpha, \mathcal{N}_{v, \alpha}(E)\right)=\delta<\infty$, we have

$$
\mathcal{N}_{v, \alpha}(E+\epsilon)-\mathcal{N}_{v, \alpha}(E-\epsilon) \leqslant \epsilon^{\frac{\delta}{2 \delta-2 \pi h}-o(1)},
$$

(2) If $\delta\left(\alpha, \mathcal{N}_{v, \alpha}(E)\right)<2 \pi h$, we have

$$
\mathcal{N}_{v, \alpha}(E+\epsilon)-\mathcal{N}_{v, \alpha}(E-\epsilon) \leqslant C \epsilon
$$

(3) If $\delta\left(\alpha, \mathcal{N}_{v, \alpha}(E)\right)=\infty$, we have

$$
\mathcal{N}_{v, \alpha}(E+\epsilon)-\mathcal{N}_{v, \alpha}(E-\epsilon) \leqslant C \epsilon^{\frac{1}{2}}
$$

Moreover, for the almost Mathieu operator $v(\cdot)=2 \lambda \cos (\cdot)$, the result holds for any $\lambda \neq 1$.
Let us revisit previous results on Hölder continuity of IDS. In the regime of zero Lyapunov exponent, sharp bounds ( $1 / 2$-Hölder continuity) for the integrated density of states for Dio-
 obtained in both perturbative and non-perturbative regimes, as discussed in $[$ A $A-\overline{0} 0 \overline{9}]$ and
 can only occur in the case $\delta=\infty$. In the regime of positive Lyapunov exponents, Goldstein and Schlag [GSODO full Lebesgue measure subset of Diophantine frequencies. Their results were nearly optimal
for the supercritical almost Mathieu operator, achieving ( $1 / 2-o(1))$-Hölder continuity for $|\lambda|>1$. Before this, Bourgain $\left[\right.$ B $\left.B_{0}^{-0} 000\right] \mid$ had established almost $1 / 2$-Hölder continuity for almost Mathieu operators in the perturbative regime, for Diophantine $\alpha$, and sufficiently large $\lambda$ (depending on $\alpha$ ). If the potential is not analytic, one can consult lCOZ19, and the references therein for more results on the regularity of IDS.
1.3. Exact local distribution of ac measure: general analytic potential. For general analytic potentials, Theorem ins shows that although it may not be possible to obtain the local dimension of the spectral measure as precisely as in the case of AMO (Theorem 'I. $\overline{1}$ '), one can achieve stratified Hölder continuity of the absolutely continuous spectral measure. Note
 raises the natural question of whether this kind of exact local distribution is specific to AMO. In the following, we show that it is indeed possible to obtain the exact local distribution for dense small analytic potentials:

Theorem 1.4. Let $\alpha \in \mathrm{DC}_{d}, v \in C_{h}^{\omega}\left(\mathbb{T}^{d}, \mathbb{R}\right)$ with

$$
\begin{equation*}
2 \pi h<\delta\left(\alpha, \mathcal{N}_{v, \alpha}(E)\right)=\delta<\infty \tag{1.6}
\end{equation*}
$$

For any $h^{\prime} \in(0, h)$, there exists $c_{*}=c_{*}\left(\alpha, h, h^{\prime}\right)>0$ such that if $\|v\|_{h} \leqslant c_{*}$, then for any $\hat{\epsilon}>0$, there exist a sequence $\left(k_{s}\right), \tilde{v} \in C_{h^{\prime}}^{\omega}(\mathbb{T}, \mathbb{R})$ with $\|\tilde{v}-v\|_{h^{\prime}}<\hat{\epsilon}$ and

\delta\left(\alpha, \mathcal{N}_{\tilde{v}, \alpha}(E)\right)=\delta
$$

such that for any $\theta \in \mathbb{R}$, we have

1.4. Optimality of reducibility condition. Let us discuss why the condition ( ${ }_{1} \overline{1} \cdot \overline{\sigma_{1}}$ ) is essential. As demonstrated in Theorem 'i. 2 '1 and Theorem 'i. $\overline{1}$ ', if $2 \pi h>\delta\left(\alpha, \mathcal{N}_{v, \alpha}(E)\right)$, the spectral measure always exhibits the trivial bound. The main reason for this is the reducibility theory of quasiperiodic cocycles. Recall that $\left(\alpha, A_{1}\right)$ is conjugated to $\left(\alpha, A_{2}\right)$, if there exists $B \in C^{\omega}\left(\mathbb{T}^{d}, \operatorname{PSL}(2, \mathbb{R})\right)$ such that

Then $(\alpha, A)$ is reducible if it is analytic conjugate to constant. In the context of quasiperiodic cocycles, the corresponding concept of IDS is the fibered rotation number $\rho(\alpha, A)_{L_{-r}}^{2_{1}}$ It is noteworthy that reducibility theory has recently proven to be a powerful tool for investigating

[^1]the spectral theory of quasiperiodic Schrödinger operators


Theorem 1.5. [GYZ2 $\delta(\alpha, 2 \rho(\alpha, A)), R \in \operatorname{SL}(2, \mathbb{R})$. Then there exists $c_{*}=c_{*}\left(\alpha, R, h, h^{\prime}\right)>0$ such that if $\| A(\cdot)-$ $R \|_{h}<c_{*}$, then $(\alpha, A)$ is reducible.

One may understand the optimality in several different ways. Note if one Schrödinger cocycle is reducible (to elliptic), then the corresponding spectral measure is Lipschitz (Proposition
 cocycles, while Theorem in in shows that Theorem in in optimal in the setting of Schrödinger cocycles: if $2 \pi h<\delta\left(\alpha, \overline{\mathcal{N}_{v, \alpha}}(E)\right)$, one can always perturb $v$ to $\tilde{v}$, such that the corresponding Schrödinger cocycle is not reducible. Indeed, this is true in the setting of general analytic cocycles, actually the proof of Theorem '1. 1.4 ' enables us to prove the following:

1.5. Ideas of the proof, novelty. We will establish a general criterion (Proposition '5.1') to obtain the exact local distribution of the spectral measure, extending Avila-Jitomirskaya's general criterion on $1 / 2$-Hölder continuity of the absolutely continuous spectral measure [AJIil, based on: the dynamical reformulation of the power-law subordinacy techniques边 almost reducibility $[G=\bar{Y}=2$ $h\}$, if there exist $B_{j} \in C_{h}^{\omega}\left(\mathbb{T}^{d}, \operatorname{PSL}(2, \mathbb{R})\right), A_{j} \in \mathrm{SL}(2, \mathbb{R})$, and $f_{j} \in C_{h}^{\omega}\left(\mathbb{T}^{d}, \mathrm{sl}(2, \mathbb{R})\right)$ such that the following holds:

Structured quantitative almost reducibility involves tracking how the conjugacy $B_{j}(\cdot)$, the constant $A_{j}$, and the perturbation $f_{j}(\cdot)$ depend on the resonances $n_{s}$ of the fibered rotation number. This structured and quantitative estimate is crucial for establishing the exact local distribution of the spectral measure and serves as the starting point of our proof. Within this dynamical input, to prove the exact local distribution, the main difficulty is to prove the lower bound of $\mu_{v, \alpha, \theta}(E-\epsilon, E+\epsilon)$ (the method of the upper bound are mainly developed in [ $\mathrm{A} \mathrm{A}_{1} 1 \mathrm{I}_{1} \mid$ ). It is well-known the spectrum measure is related with Weyl-Titchmarsh $m$-function as follows:

To obtain the lower bound, there are two two novel aspects:

- Symmetry argument to obtain the lower bound of $\epsilon \Im M(E+i \epsilon)$ (Lemma 'A. $\overline{-}$ 'i').
- Dislocation argument to obtain lower bound of $\mu_{v, \alpha, \theta}\left(E-\epsilon, E+\epsilon\right.$ ) (Lemma 'r. $\overline{1} \mathbf{1}_{1}^{\prime}$ ). To obtain the lower bound, one key is the asymptotic upper bound of $\mu_{v, \alpha, \theta}(E-\epsilon, E+\epsilon)$, another key is the dislocation of $\epsilon$ : in order to estimate $\mu_{v, \alpha, \theta}(E-\epsilon, E+\epsilon)$, we actually need to estimate $\epsilon^{1+\tau} \Im M\left(E+i \epsilon^{1+\tau}\right)$ in (1.1. $\left.\overline{8_{1}^{\prime}}\right)$.
With this criterion in hand:
- For AMO, one can apply the recent developments in structured quantitative almost reducibility results for AMO $[G \mathcal{G} Z 24]$ to achieve the desired results.
- For general potentials, the fibered Anosov-Katok construction, first appearing in盾 $\bar{X} \bar{Z} 2$ for all Liouvillean rotation numbers.
Finally, it is necessary to remark that the arithmetic assumption on the frequency is quite crucial. While for weakly Liouvillean frequencies, IDS remains Hölder continuous |LY1 $\overline{1}$ suggesting that similar Hölder continuity of the spectral measure can be expected for such frequencies with a small rate of exponential approximation [AJI. However, for general potential $v$ and generic $\alpha$, the integrated density of states $\mathcal{N}_{v, \alpha}$ is not Hölder. This is due to the discontinuity of the Lyapunov exponent at rational $\alpha$, implying non-Hölder continuity for generic $\alpha$. Recently, Avila-Last-Shamis-Zhou [ALSZZ2乘 even demonstrated that the LogHölder continuity of IDS, as obtained from the Thouless formula, is optimal for extremely Liouvillean frequencies. The determination of the exact arithmetic constraint on $\alpha$ for which Theorem $1 \mathbf{1}, 2{ }_{2}^{2}$ holds remains an open question.


## 2. Preliminaries

For an $n \times n$ complex matrix $A$, we will use the spectral norm $\|A\|:=\sqrt{\lambda_{\max }\left(A^{*} A\right)}$, where $A^{*}$ is the conjugate transpose of $A$, and $\lambda_{\max }\left(B^{*} B\right)$ is the maximum eigenvalue of $B^{*} B$. For a bounded analytic (possibly matrix-valued) function $F$ defined on $\{\theta:|\Im \theta|<h\}$, let $\|F\|_{h}=\sup _{|\Im \theta|<h}\|F(\theta)\|$, and denote by $C_{h}^{\omega}\left(\mathbb{T}^{d}, *\right)$ the set of all these $*$-valued functions (* will usually denote $\mathbb{R}, \mathrm{SL}(2, \mathbb{R}), \mathrm{SU}(1,1))$. Also we denote $C^{\omega}\left(\mathbb{T}^{d}, *\right)=\bigcup_{h>0} C_{h}^{\omega}\left(\mathbb{T}^{d}, *\right)$. We use $\|\cdot\|_{\mathbb{T}}:=\inf _{j \in \mathbb{Z}}|\cdot-j|$. We will usually use $c$ or $C$ to denote small or big numerical constants (it can be different at each use).
2.1. Lie algebra isomorphism. It is known that the Caley element

2.2. Quasi-periodic dynamics. Given $A \in C^{0}\left(\mathbb{T}^{d}, \mathrm{SL}(2, \mathbb{C})\right)$, a quasi-periodic cocycle $(\alpha, A)$ is defined as

Then the fibered rotation number of $(\alpha, A)$ is defined by

If $B: 2 \mathbb{T}^{d} \rightarrow \operatorname{SL}(2, \mathbb{R})$ is homotopic to $R_{\frac{\langle n, \theta\rangle}{2}}: 2 \mathbb{T}^{d} \rightarrow \mathrm{SL}(2, \mathbb{R})$ for some $n \in \mathbb{Z}^{d}$, then $n$ is called the degree of $B$, and is denoted by $\operatorname{deg} B$. The fibered rotation number is conjugacy invariant, i.e. if $(\alpha, A)$ is conjugated to ( $\alpha, A^{\prime}$ ) by $B \in C^{0}\left(2 \mathbb{T}^{d}, \mathrm{SL}(2, \mathbb{R})\right)$ with $\operatorname{deg} B=n$, then we have

It is well-known that $E \notin \Sigma_{v, \alpha}$ if and only if $\left(\alpha, S_{E}^{v}\right)$ is uniformly hyperbolic [Joh is easy to see that there is a continuous branch $\rho\left(\alpha, S_{E}^{v}\right) \in[0,1 / 2]$, which is related to the integrated density of states as [JM

## 3. Spectral measures and $m$-Functions

3.1. $m$-function and Jitomirskaya-Last inequality. It is known that the study of the spectral measure $\mu$ of the Schrödinger operator:

Consider energies $z=E+i \epsilon, E \in \mathbb{R}, \epsilon>0$. Then there are non-zero solutions $u_{z}^{ \pm}$ of $H u_{z}^{ \pm}=z u_{z}^{ \pm}$which are $l^{2}$ at $\pm \infty$, well defined up to normalization. Then the half-line $m$-functions are defined as:

& \left(K^{-}(E) \psi\right)(n)=\sum_{m=-n+1}^{0} k_{0}^{-}(n, m) \psi(m),
\end{aligned}

where

k_{0}^{ \pm}(n, m)=u_{0}^{ \pm}(n) u_{\pi / 2}^{ \pm}(m)-u_{\pi / 2}^{ \pm}(n) u_{0}^{ \pm}(m) .

and one then can view $K^{ \pm}(E)$ as the integral operators acting on the $[L]$ or $[L]+1$-dimensional Hilbert space $\mathbb{K N K}^{-0} 0$. Indeed, for any $u^{+}: \mathbb{Z}^{+} \rightarrow \mathbb{C}$ (resp. $u^{-}: \mathbb{Z}^{-} \rightarrow \mathbb{C}$ ), we denote by $\left\|u^{+}\right\|_{L}$ (resp. $\left.\left\|u^{-}\right\|_{L}\right)$ the norm over a lattice interval of length $L$ :

It is known that the Jitomirskaya-Last inequality provides a link between $m$-functions and the solutions of ( $\left.{ }_{3} . \overline{1}_{1}\right)$ satisfied the corresponding boundary conditions. The following result is an application of the well-known JitomirskayaLast inequality, but based on a different version in ${ }^{K} \bar{K} \bar{K} 0$

As further explored in $[A \mathcal{A} J 1]$, the invariant $\left|\left|\left|K^{ \pm}(E)\right| \|_{L}\right.\right.$ has another representation. Let $L=2 k, k \geqslant 1$ integer, denote $\left(\alpha, S_{E}^{v}\right)^{n}=\left(n \alpha, \mathcal{A}_{n}\right)$, and define

Remark 3.2. Here we should be careful that while we select $L^{+}(\epsilon)=2 k$, it is not necessary $L^{+}(\epsilon)$ is equal to $L^{-}(\epsilon)$.
3.2. Spectral measure. Recall that the whole line $m$-function coincides with the Borel transform of the canonical spectral measure $\mu$ of the operator ( (Bin $\mathbf{1}^{\prime}$ ):

Deriving a lower bound for $\mu(E-\epsilon, E+\epsilon)$ from $\epsilon \Im M(E+i \epsilon)$ is a delicate endeavor. Our approach involves first obtaining a stratified upper bound for $\epsilon \Im M(E+i \epsilon)$. This upper bound is then employed to deduce a stratified upper bound for the measure. Utilizing the identity:

\epsilon \Im M(E+i \epsilon)=\int \frac{\epsilon^{2}}{\left(E^{\prime}-E\right)^{2}+\epsilon^{2}} d \mu\left(E^{\prime}\right)

we further derive a lower bound for $\mu(E-\epsilon, E+\epsilon)$ in terms of $\epsilon \Im M(E+i \epsilon)$. The details of this process can be found in Section ${ }^{15} .3$ '.

Corollary ' $\overline{3} \overline{3} \overline{1} 11$ highlights that to estimate $\Im M(E+i \epsilon)$, it suffices to calculate $\left\|P_{(k),+}^{-1}\right\|$ and any component of $u_{\beta}^{ \pm}$'s $L^{2}$ norm. As we will demonstrate later, the $L^{2}$ norm of $u_{\beta}^{ \pm}$corresponds to the first entry of the matrix $P_{(k), \pm}$. Therefore, the foundation for understanding the asymptotic local distribution of the spectral measure lies in examining the asymptotic structure of $P_{(k), \pm}$, which we will address in the subsequent section.

## 4. Asymptotic formula of $P_{(k), \pm}$

Given a resonant set $\left(n_{s}\right)_{s \geqslant 1} \subset \mathbb{Z}^{d}$ may be finite or infinite, and we label it as $0<\left|n_{1}\right|<$ $\left|n_{2}\right|<\cdots$. If the sequence is finite, we assume the last one is $n_{m}$, and formally set $n_{m+1}=\infty$. If the sequence is infinite, we assume that

Let us say that $(\alpha, A)$ is $\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right)_{s \geqslant s_{0}}\right)$-good, if for any $s \geqslant s_{0}$, and denoting $n=\left|n_{s}\right|$ and $N=\left|n_{s+1}\right|$, there exists $B_{n} \in C^{\omega}\left(\mathbb{T}^{d}, \operatorname{PSL}(2, \mathbb{R})\right)$ with deg $B_{n}=n,\left\|B_{n}\right\|_{0} \leqslant C_{0}^{\prime} n^{C_{0}}$ such that

with

Remark 4.1. If $d=1$, similar concept of $\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right)_{s \geqslant s_{0}}\right)$-goodness was first introduced by Avila-Jitomirskaya [AA decay:

then the spectral measure is $1 / 2$-Hölder continuous (Theorem 4.1 of [ bution here is to show that when $z_{n}$ decays exponentially, one can achieve stratified Hölder
continuity (as stated in Proposition ins $_{1}$ ). Moreover, when the decay is real exponential, implying both upper and lower bounds of $z_{n}$ decay exponentially, we can delve into the exact local distribution of the spectral measure.
4.1. Asymptotic formula. In the following, we will first show if the Schrödinger cocycle $\left(\alpha, S_{E}^{v}\right)$ is $\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right)_{s \geqslant s_{0}}\right)$-good, then one can obtain the asymptotic formula of $\left\|P_{(k), \pm}^{-1}\right\|^{-1}$ and $\operatorname{det} P_{(k), \pm}$. Before stating the result, note as a direct consequence of Lemma 2.2 , if $(\alpha, A)$ is $\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right)_{s \geqslant s_{0}}\right)$-good, then for any $s \geqslant s_{0}$, there exists $\Phi_{n} \in$ $C^{\omega}\left(\mathbb{T}^{d}, \operatorname{PSL}(2, \mathbb{C})\right)$ with $\left\|\Phi_{n}\right\|_{0} \leqslant C_{0}^{\prime} n^{C_{0}}$ such that

\Phi_{n}^{-1}(\theta+\alpha) S_{E}^{v}(\theta) \Phi_{n}(\theta)=\left(\begin{array}{cc}
e^{2 \pi i \rho_{n}} & \nu_{n} \\
0 & e^{-2 \pi i \rho_{n}}
\end{array}\right)+H_{n}(\theta)
$$

where $\rho_{n}=\sqrt{t_{n}^{2}-\left|z_{n}\right|^{2}}$ with estimates $\left|z_{n}\right| \leqslant\left|\nu_{n}\right| \leqslant 2\left|z_{n}\right|,\left\|H_{n}\right\|_{0} \leqslant e^{-\gamma_{0} N}$.
Remark 4.2. In the result of the paper, we will use this as formulation of $\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right)_{s \geqslant s_{0}}\right)$ goodness. We have to start with (' ('2.), as we need to use the invariance of rotation number (one can not define fibered rotation number for general $\mathrm{SL}(2, \mathbb{C})$ cocycles). More precisely,

and define $X, \tilde{X}$ as in Lemma '1.1'. First we have the following basic observations:

Remark 4.4. Utilizing symmetry, we derive a lower bound for $\Im M(E+i \epsilon)$, an essential step in our proof. While the observation is simple, it serves as the starting point of the whole proof.

While Proposition 'A. 1 ' mainly takes care the case the Schrödinger cocycle is almost reducible, if the cocycle is reducible, one can obtain better estimates. In the following, we use the notation $a \approx b(a, b>0)$ denotes $C^{-1} a \leqslant b \leqslant C a$.

It is only necessary to take ( $(3)_{\left.\overline{3} . \overline{6}_{-}^{\prime}\right)}$ ) as the definition of $\left\|u_{\beta}^{ \pm}\right\|_{2 k}^{2}$, all the proofs remain valid.
4.2. Stratified Hölder continuity. As an immediate application of Proposition 'Ā. 1 ', we show that if $\nu_{n}$ has uniform exponential decay, one can obtain stratified Hölder continuity:

$(\mathbf{H} 2): \zeta_{n} \in[(1-\varepsilon) h, \infty]$.
Then there exist $\epsilon_{*}=\epsilon_{*}\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right), \varepsilon\right)>0$, such that for any $\epsilon<\epsilon_{*}$,

Remark 4.6. We make two short comments.
(1) (H2) condition is non-trivial, it was was first observed in [[YZZZ̄̄̄] as the main input to prove exponential decay of the spectral gaps.
(2) Here we only need to consider the case $\delta\left(\alpha, 2 \rho\left(\alpha, S_{E}^{v}\right)\right):=\delta \geqslant h$. Otherwise, if $\delta<h$, the Schrödinger cocycle $\left(\alpha, S_{E}^{v}\right)$ is reducible, which implies the spectral measure is Lipschitz, as was shown in Proposition in in .

## 5. Exact local distribution of the spectral measure

In the previous section, Proposition 'I.1' show that if the Schrödinger cocycle ( $\alpha, S_{E}^{v}$ ) is $\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right)_{s \geqslant s_{0}}\right)$-good, with

then one can obtain the asymptotic formula of $P_{(k), \pm}$. We should remark that (H3)-type condition was first observed for AMO, which plays an essential role in proving non-critical Dry Ten Martini Problem [AYZZ23].

In this section, we will show that if we have further information on the exponential decay rate of $\nu_{n}$ (c.f. (H2), (H3) conditions of Proposition '5. $\mathbf{I}_{1}$ '), one can obtain exact local distribution of the spectral measure. In the rest of the paper, we will always fix the frequency $\alpha$, the energy $E$, and the analytic band $h$ of the potential $v$, thus usually omit the dependence on these parameters. Recall that

(H1): $\left(\alpha, S_{E}^{v}\right)$ is $\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right)_{s \geqslant s_{0}}\right)$-good, with $\gamma_{0}<h<\infty$;
(H2): $\zeta_{n} \in[(1-\varepsilon) h, \infty]$;
(H3): $\zeta_{n} \leqslant(1+\varepsilon) h$, if $\widehat{\eta}_{n} \geqslant(1+\varepsilon) h$.
Then, there exist $\epsilon_{*}=\epsilon_{*}\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right), \varepsilon\right)>0, \widetilde{C}>0$, and a continuous function

By assumption, the Schrödinger cocycle $\left(\alpha, S_{E}^{v}\right)$ is $\left(C_{0}^{\prime}, C_{0}, \gamma_{0},\left(n_{s}\right)_{s \geqslant s_{0}}\right)$-good, then by Proposition 'A. ${ }_{-} \mathbf{I}_{1}^{\prime}$, there exist $K_{0}=K_{0}\left(C_{0}^{\prime}, C_{0}, \gamma_{0}\right)$, such that $\operatorname{det} P_{(k), \pm}$ and $\left\|P_{(k), \pm}\right\|^{-1}$ have well asymptotic estimates for $k \geqslant \max \left\{e^{\frac{\gamma_{0}}{5}\left|n_{s_{0}}\right|}, K_{0}\right\}$. Moreover, by ('A.1.), one can select $s_{1} \geqslant s_{0}$ to be the minimal integer such that

The proof consists of three key steps, with the first being to derive a universal asymptotic estimate for $\operatorname{det} P_{(k), \pm}$, as detailed in Section '1.1. This universality refers to the fractal nature of the asymptotic formula, which remains consistent around any resonances. Leveraging Corollary $\mathfrak{B} \mathbf{1} \mathbf{1}$, , we can then deduce the universal asymptotic structure of $\epsilon \Im M(E+i \epsilon)$ in Section 5 measure, as presented in Section ${ }^{15} 3$.
5.1. Universal asymptotic structure of $\operatorname{det} P_{(k), \pm}$. As we already explore from Proposition 'A. 1 I', det $P_{(k), \pm}$ has a asymptotic structure, however the asymptotic formula $\eta_{+}^{n}(k)$ is of local nature, i.e, it depends on $\zeta_{n}, \widehat{\eta}_{n}$ and $\gamma_{0}$ of the iteration scheme (ususally the scheme is KAM based), thus to obtain universal asymptotic structure of $\operatorname{det} P_{(k), \pm}$, the key is to remove these dependence. Before giving the proof, we first state the following key observation, which says that if (H3) holds, then we can control the decay rate of $\rho_{n}$ :
Lemma 5.1. Let $s \geqslant s_{1}$, then we have

(\ln k)^{-16 C_{0}} k^{\eta_{+}^{N}(k)} \leqslant \operatorname{det} P_{22}(k), \pm \leqslant(\ln k)^{16 C_{0}} k^{\eta_{+}^{N}(k)},
$$

where we recall that

In particular, for $k_{0}=e^{\frac{\gamma_{0}}{5} N}$, we have

In a word, Lemma 'ī' shows that one can give an upper bound of $\eta_{n}$. Then we can distinguish the proof into two steps, the first step is to get rid of $\zeta_{n}$ and $\widehat{\eta}_{n}$ in the asymptotic formula of $\operatorname{det} P_{(k), \pm}$.
5.1.1. Step 1: Get rid of $\zeta_{n}$ and $\widehat{\eta}_{n}$ : For any $k \geqslant K_{1}$, we define $\tilde{\eta}(k)$ as below:
(1) If $\eta_{n} \leqslant h$. Let $\tilde{\eta}(k)=2$ for $e^{\frac{\gamma_{0}}{5} n} \leqslant k \leqslant e^{\frac{\gamma_{0}}{5} N}$.

Summarize all cases, the result follows.
5.1.2. Step 2: Get rid of $\gamma_{0}$ and smoothing argument: In the first step, we are able to remove the dependence on local parameters $\zeta_{n}$ and $\widehat{\eta}_{n}$, however as we can see, if one extends $\tilde{\eta}(k)$ to a function on $\left[K_{1}, \infty\right)$, it is not a continuous function anymore. The second step is to further modify $\tilde{\eta}(k)$ to $\psi(k)$, such that it can extended to a continuous function $\psi(x)$ on $\left[K_{2}, \infty\right)$. Indeed, we can define $\psi(x)$ as follows:
(1) If $\eta_{n} \leqslant h$. Let $\psi(x)=2$ for $x \in\left[e^{h n}, e^{h N}\right]$.
(2) If $\eta_{n}>h$. Let

\psi(x)= \begin{cases}4-\frac{2 h n}{\ln x} & \text { for } x \in\left[e^{h n}, e^{\eta_{n} n}\right]  \tag{5.8}\\ 2+\frac{2 \eta_{n} n-2 h n}{\ln x}\left[1-\frac{\ln x-\eta_{n} n}{h N-\eta_{n} n}\right] & \text { for } x \in\left[e^{\eta_{n} n}, e^{h N}\right]\end{cases}

Just bear in mind, we will use the notations $k \in \mathbb{Z}$ and $x \in \mathbb{R}$. Then we have the following:

(2) If $\frac{\gamma_{0}}{5} N \leqslant \ln k \leqslant h N$, if $\eta_{N} \leqslant h$, we have $\tilde{\eta}(k)=2$, if $\eta_{N}>h$, we have $\tilde{\eta}(k)=$ $4-\frac{2 h N}{\ln k} \leqslant 2$, thus $\tilde{\eta}_{+}(k)=\psi(k)=2$.
Case 2: $\eta_{n}>h$. Then we have the following:
(1) If $h n \leqslant \ln k \leqslant \eta_{n} n$, we have $\psi(k)=\tilde{\eta}_{+}(k)$;
(2) If $\eta_{n} n \leqslant \ln k \leqslant \frac{\gamma_{0}}{5} N$. By (

5.2. Universal asymptotic structure of the $M$-function. Once we give the universal asymptotic structure structure of $P_{(k), \pm}$, one can obtain the universal asymptotic structure of $M$-function. The link is given by Corollary ' which defines the function $\epsilon=\epsilon(k)$. However, due to the complicated definition of $\operatorname{det} P_{(k),+}$, this functional relationship is not clear and not computable. The basic observation here is that from Lemma' 1.3 , 3 , the dominated terms of $\operatorname{det} P_{(k),+}$ is $k^{\psi(k)}$, and our first step is to study the function $\psi(x)$.

### 5.2.1. Basic property of $\psi(x)$ :

Lemma 5.4. Let $x \geqslant K_{2}, y=x^{1+\delta}$ for some $\delta>0$, then

S.2 For $k \geqslant K_{2},(k+1)^{\psi(k+1)}-k^{\psi(k)} \leqslant C k^{\psi(k)-1}$.

Proof. First notice that $\psi(x) \in[2,4)$, which implies for any $\delta>3 / 2, \Delta(x, y) \geqslant 2 \delta-2 \geqslant$ $2 \delta / 3>0, \nabla(x, y) \leqslant 2<2 \delta$, thus we only need to consider $\delta \leqslant 3 / 2$. In the following, we always fix $x \in\left[e^{h n}, e^{h N}\right]$, so $y \in\left[e^{(1+\delta) h n}, e^{(1+\delta) h N}\right]$.
Case 1: $\eta_{n} \leqslant h$. In this case, $\psi(x) \equiv 2$, which immediately implies $\Delta(x, y) \geqslant 2 \delta$. As for $\nabla(x, y)$, we distinguish three subcases:
Case 1.1: If $y \in\left[e^{(1+\delta) h n}, e^{h N}\right]$, then $\nabla(x, y)=0$.
Note if $y \in\left[e^{h N}, e^{(1+\delta) h N}\right]$, then we only need to consider the case $\eta_{N}>h$, otherwise $\nabla(x, y)=$ 0 . Then we can further discussed as:
Case 1.2: If $y \in\left[e^{h N}, e^{\eta_{N} N}\right]$, then $\nabla(x, y)=2-\frac{2 h N}{\ln y} \leqslant 2-\frac{2 h N}{(1+\delta) h N} \leqslant \frac{2 \delta}{1+\delta}$.
Case 1.3: If $y \in\left[e^{\eta_{N} N}, e^{(1+\delta) h N}\right]$, then $\nabla(x, y) \leqslant 2-\frac{2 h N}{\eta_{N} N} \leqslant 2-\frac{2 h N}{(1+\delta) h N} \leqslant \frac{2 \delta}{1+\delta}$.
Case 2: $\eta_{n}>h$. We distinguish the proof into the following cases:
Case 2.1: If both $x, y \in\left[e^{h n}, e^{\eta_{n} n}\right]$ (this contains the case $\eta_{n}=N=\infty$ ), then

& \Delta(x, y)=4(1+\delta)-\frac{2 h n}{\ln x}-4+\frac{2 h n}{\ln x}=4 \delta . \\
& \nabla(x, y)=\left|4-\frac{2 h n}{(1+\delta) \ln x}-4+\frac{2 h n}{\ln x}\right| \leqslant \frac{2 \delta}{1+\delta} .
\end{aligned}
$$

Case 2.2: If both $x, y \in\left[e^{\eta_{n} n}, e^{h N}\right]$, then

\Delta(x, y)= & 2 \delta+\frac{2 \eta_{n} n-2 h n}{\ln x}-\frac{2 \eta_{n} n-2 h n}{\ln x}\left(\frac{(1+\delta) \ln x-\eta_{n} n}{h N-\eta_{n} n}\right) \\
& -\frac{2 \eta_{n} n-2 h n}{\ln x}+\frac{2 \eta_{n} n-2 h n}{\ln x}\left(\frac{\ln x-\eta_{n} n}{h N-\eta_{n} n}\right) \\
= & 2 \delta-\frac{2 \eta_{n} n-2 h n}{h N-\eta_{n} n} \delta \geqslant\left(2-C \varepsilon^{2}\right) \delta . \\
\nabla(x, y)= & \left\lvert\, \frac{2 \eta_{n} n-2 h n}{(1+\delta) \ln x}-\frac{2 \eta_{n} n-2 h n}{(1+\delta) \ln x}\left(\frac{(1+\delta) \ln x-\eta_{n} n}{h N-\eta_{n} n}\right)\right. \\
& \left.-\frac{2 \eta_{n} n-2 h n}{\ln x}+\frac{2 \eta_{n} n-2 h n}{\ln x}\left(\frac{\ln x-\eta_{n} n}{h N-\eta_{n} n}\right) \right\rvert\, \\
\leqslant & \frac{2 \delta}{1+\delta}+C \varepsilon \delta .
\end{aligned}
$$

where the inequalities holds by ( ${ }^{5}$.5.5) of Lemma '12 and $\gamma_{0}<h$.
Case 2.3: If $x \in\left[e^{h n}, e^{\eta_{n} n}\right], y \in\left[e^{\eta_{n} n}, e^{h N}\right]$, then let $x_{0}=e^{\eta_{n} n}$, one can write $x_{0}=x^{1+\delta_{1}}$, and $y=x_{0}^{1+\delta_{2}}$, and thus $\delta_{2}=\frac{\delta-\delta_{1}}{1+\delta_{1}}$. & \geqslant\left(2-C \varepsilon^{2}\right) \delta_{1}+\left(1+\delta_{1}\right)\left(2-C \varepsilon^{2}\right) \delta_{2}=\left(2-C \varepsilon^{2}\right) \delta . \\
\nabla(x, y) & \leqslant\left|\psi\left(x_{0}\right)-\psi(x)\right|+\left|\psi(y)-\psi\left(x_{0}\right)\right| \\
& \leqslant \frac{2 \delta_{1}}{1+\delta_{1}}+\frac{2 \delta_{2}}{1+\delta_{2}}+C \varepsilon \delta_{1}+C \varepsilon \delta_{2} \\
& \leqslant \frac{4 \delta}{1+\delta}+2 C \varepsilon \delta .
\end{aligned}
$$

Case 2.4: If $x \in\left[e^{\eta_{n} n}, e^{h N}\right], y \in\left[e^{h N}, e^{(1+\delta) h N}\right]$, let $x_{0}=e^{h N}$, write $x_{0}=x^{1+\delta_{1}}$ and $y=x_{0}^{1+\delta_{2}}$. By the discussions in Case 1, Case 2.1 and Case 2.3, and following the same proof in Case 2.3, we have

Above discussions cover all the possible cases, this completes the proof of ( ${ }^{2} . \mathbf{I n}_{1}$ ). Concerning (S.1), the monotonicity of $x^{\psi(x)}$ immediately follows from $\Delta(x, y)>0$. As for (S.2), write $k+1=k^{1+\delta}$, or equivalently,

5.3. Exact local distribution of the spectral measure. To estimate $\mu(E-\epsilon, E+\epsilon)$, the traditional approach involves using its relationship with $\epsilon \Im M(E+i \epsilon)$. The upper bound is given by the following:

However, whether the inverse inequality holds, i.e., whether

is a subtle question and still unknown. Indeed, if we split the integral into $I_{1}=\int_{\left|E^{\prime}-E\right| \leqslant \epsilon}$ and $I_{2}=\int_{\left|E^{\prime}-E\right| \geqslant \epsilon}$, it is clear that

the main obstacle comes from $I_{2}$. Using the uniform estimate that $\mu$ is $\frac{1}{2}$-Hölder [ get $I_{2}=\int_{\epsilon^{4 / 5} \geqslant\left|E^{\prime}-E\right| \geqslant \epsilon}+\int_{\left|E^{\prime}-E\right| \geqslant \epsilon^{4 / 5}} \lesssim \epsilon^{2 / 5}$, which is problematic.

The central argument revolves around Lemma '. $\overline{6} . \mathbf{B}^{\prime}$, which provides an asymptotic upper bound for $\epsilon \Im M(E+i \epsilon)$, subsequently influencing the upper bound of the spectral measure. Consequently, this leads to a stronger estimate for $I_{2}$, specifically, $I_{2} \leqslant \epsilon^{f(\epsilon)-C \varepsilon}$. However, this is insufficient, as $\epsilon \Im M(E+i \epsilon)$ is not the dominant term. To address this, we employ a technique involving a dislocation of $\epsilon$, focusing on estimating $\epsilon^{1+\tau} \Im M\left(E+i \epsilon^{1+\tau}\right)$.
Lemma 5.9. For any $\varepsilon>0, \tau \geqslant 0$, there exist $\epsilon_{*}=\epsilon_{*}\left(\tilde{\epsilon}\left(K_{4}\right), \varepsilon\right)>0$ such that if $\epsilon \leqslant \epsilon_{*}$, we have

\leqslant & C \epsilon^{4 / 3+2 \tau}+\sum_{k=m+1}^{n-1} C \epsilon^{2+2 \tau} k^{\psi(k)-2+2 \widetilde{C} \varepsilon}

## 6. Proof of the Main Theorem

6.1. Exact local distribution for reducible energies. We want to emphasize that Proposition ${ }^{5}$.1 actually gives the mechanism of getting the local distribution of the spectral measure. In our subsequent discussion, we will focus on the most elementary scenario, where the Schrödinger cocycle is reducible.

Proposition 6.1. We have the following:
(1) If $\left(\alpha, S_{E}^{v}\right)$ is conjugated to $\left(\begin{array}{cc}\cos 2 \pi \rho & -\sin 2 \pi \rho \\ \sin 2 \pi \rho & \cos 2 \pi \rho\end{array}\right)$. Then for every $\varepsilon>0$, there exists $\epsilon_{*}=\epsilon_{*}(\varepsilon)>0$ such that for $\epsilon \leqslant \epsilon_{*}$ we have

(2) If $\left(\alpha, S_{E}^{v}\right)$ is conjugated to $\left(\begin{array}{ll}1 & \nu \\ 0 & 1\end{array}\right)$ with $\nu \neq 0$. Then for every $\varepsilon>0$, there exists $\epsilon_{*}=\epsilon_{*}(\varepsilon)>0$ such that for $\epsilon \leqslant \epsilon_{*}$ we have

For the case where $0<\delta<-\ln \lambda$, it has been verified by Theorem 1.2 of $\left.[G Y Z 2]_{1}\right]$.
Case 3: If $\mathcal{N}_{\lambda, \alpha}(E)=k \alpha \bmod \mathbb{Z}$ for some $k \in \mathbb{Z}$. By [AN10] , the dry version of the Ten Martini Problem holds for $\alpha \in \mathrm{DC}_{1}, 0<\lambda<1$, which implies $\left(\alpha, S_{E}^{v}\right)$ is reducible to $\left(\begin{array}{ll}1 & \nu \\ 0 & 1\end{array}\right)$ with $\nu \neq 0$. Then the result follows from Proposition $\underline{6}_{\underline{6}} 1 \mathbf{1}$ (2).

Proof of Theorem 1 details.

## 7. General potential case

In this section, we use Anosov-Katok construction to show that the lower local dimension of spectral measure falls in $(1 / 2,1)$ is a general phenomenon.

Proposition 7.1. Let $\alpha \in \mathrm{DC}_{d}, 0<\varepsilon_{0}<2 \pi h^{\prime}<2 \pi h \leqslant \delta<\infty$. If $v \in C_{h}^{\omega}\left(\mathbb{T}^{d}, \mathbb{R}\right)$ satisfies

Then for any $E \in \Sigma_{v, \alpha}$, and any $\epsilon>0$, there exists a sequence $\left(\hat{k}_{s}\right)_{s \geqslant \hat{s}_{0}}{ }_{c}^{3}, \tilde{v}^{3}, C_{h^{\prime}}^{\omega}\left(\mathbb{T}^{d}, \mathbb{R}\right)$ with $\|\tilde{v}-v\|_{h^{\prime}} \leqslant \epsilon$, such that $\left(\left(\alpha, S_{E}^{\tilde{v}}\right)\right)$ is almost reducible:
(1) $\left(\alpha, S_{E}^{\tilde{v}}\right)$ is $\left(C_{0}^{\prime}\left(v, \alpha, E, h, h^{\prime}, \epsilon\right), C_{0}(\alpha, \delta), c_{0},\left(\hat{k}_{s}\right)_{s \geqslant \hat{s}_{0}}\right)$-good, with $c_{0}<2 \pi h$.

[^2](2) For any $s \geqslant \hat{s}_{0}$, denoting $n=\left|\hat{k}_{s}\right|$, we have estimates
\[

& -\frac{\ln \left|\nu_{n}\right|}{n}=\zeta_{n}=2 \pi h+o(1), \\
& -\frac{\ln \left\|2 \rho_{s}\right\|_{\mathbb{T}}}{n}=\widehat{\eta}_{n}=\delta+o(1) .
\end{aligned}

\]

Proof. As we mentioned, the whole proof further develops the fibered Anosov-Katok construction which first appeared in $[\mathrm{KX} \overline{\mathrm{Z}} 2 \overline{4}]$, the advantage of our approach is that it works for all Liouvillean rotation number. We first introduce the parameters in the construction.

Recall that

For any $\epsilon \in(0,1)$, fix any $\vartheta \in\left(-\frac{\epsilon}{8 \pi}, \frac{\epsilon}{8 \pi}\right)$ satisfies $\delta(\alpha, 2 \vartheta)=\delta \geqslant 2 \pi h$. Thus for any $\varepsilon_{0}>0$, there exist sequence $\left(k_{s}\right)_{s \geqslant 2}$ such that

Once we have this, let $k_{1}=\mathbf{0}$, for $s \geqslant 1$, we inductively define $\left(k_{s}\right),\left(\lambda_{s}\right)$ and $\left(t_{s}\right)$ as follows:

\end{gather*}

Denote $\Sigma^{+}=[0,1 / 2)$ and $\Sigma^{-}=[1 / 2,1)$. Write

2 \vartheta-\left\langle k_{s}, \alpha\right\rangle=j_{s}+x_{s}=\left[2 \vartheta-\left\langle k_{s}, \alpha\right\rangle\right]+\left\{2 \vartheta-\left\langle k_{s}, \alpha\right\rangle\right\} .
$$

Then by Pigeonhole principle, there are infinitely many $k_{s}$ satisfies one of the following:
(i) $x_{s} \in \Sigma^{+}, j_{s} \in 2 \mathbb{Z}$,
(ii) $x_{s} \in \Sigma^{+}, j_{s} \in 2 \mathbb{Z}+1$,
(iii) $x_{s} \in \Sigma^{-}, j_{s} \in 2 \mathbb{Z}$,
(iv) $x_{s} \in \Sigma^{-}, j_{s} \in 2 \mathbb{Z}+1$.

Without loss of generality, one will just assume

The other case can be dealt with similarly. Just note by symmetry, if $\vartheta$ has infinitely many $k_{s}$ such that $x_{s} \in \Sigma^{ \pm}$, then $-\vartheta$ has infinitely many $k_{s}$ such that $x_{s} \in \Sigma^{\mp}$. Moreover, the Diophantine condition $\alpha \in \mathrm{DC}_{d}$ implies that

With the above selected sequence, we will split the proof into three steps:

## Step 1: Refined Anosov-Katok construction

Lemma 7.1. Let $\alpha \in D C_{d}, 0<2 \pi h^{\prime}<2 \pi h \leqslant \delta<\infty$. For any $\epsilon>0$, there exist $A_{\infty}(\cdot) \in C_{h^{\prime}}^{\omega}\left(\mathbb{T}^{d}, \mathrm{SL}(2, \mathbb{R})\right)$, with

Moreover, we have the following:
(1) $\left(\alpha, A_{\infty}\right)$ is $\left(1, C_{0}(\alpha, \delta), c_{0},\left(k_{s}\right)_{s \geqslant 2}\right)$-good, with $c_{0}<2 \pi h<\infty$.
(2) $-\frac{\ln \left|\nu_{s}\right|}{\left|k_{s}\right|}=2 \pi h+o(1)$,
(3) $-\frac{\ln \left\|2 \rho_{s}\right\|_{\mathbb{T}}}{\left|k_{s}\right|}=\delta+o(1)$.

Proof. As $\mathrm{SL}(2, \mathbb{R})$ is isomorphic to $\mathrm{SU}(1,1)$, we just carry out the Anosov-Katok construction in the group $\mathrm{SU}(1,1)$. Assume we are at the $s$-th $(s \geqslant 0)$ step of construction, we start at the cocycle $\left(\alpha, \bar{A}_{s}\right)$, where

The goal of the $(s+1)$-th step of the construction, is to construct suitable transformation $G_{s}(\cdot)$ and perturbation $f_{s}(\cdot)$ such that if we perturb the cocycle $\left(\alpha, \bar{A}_{s}\right)$ to $\left(\alpha, \bar{A}_{s} e^{\bar{f}_{s}(\cdot)}\right)$, the transformation $G_{s}(\cdot)$ conjugate the cocycle $\left(\alpha, \bar{A}_{s} e^{\bar{f}_{s}(\cdot)}\right)$ into $\left(\alpha, \bar{A}_{s+1}\right)$.

By (

0 & -\left\|2 \vartheta-\left\langle k_{s+1}, \alpha\right\rangle\right\|_{\mathbb{T}}
\end{array}\right),

with $D_{0}=\mathrm{Id}$, and for $n \geqslant 1$,

\left\|D_{s}\right\|^{2}=\frac{t_{s}+\lambda_{s}}{\sqrt{t_{s}^{2}-\lambda_{s}^{2}}} \in\left[\frac{t_{s}}{\left\|2 \vartheta-\left\langle k_{s+1}, \alpha\right\rangle\right\|_{\mathbb{T}}}, \frac{2 t_{s}}{\left\|2 \vartheta-\left\langle k_{s+1}, \alpha\right\rangle\right\|_{\mathbb{T}}}\right] . \tag{7.7}
\end{equation*}

Denote

\langle m, \cdot\rangle & 0 \\
0 & -\langle m, \cdot\rangle
\end{array}\right) \in \mathrm{SU}(1,1)

Lemma 7.2. Let $s_{*}=k_{s+2}-k_{s+1} \in \mathbb{Z}^{d}$. There exists $\tilde{f}_{s} \in C_{h^{\prime}}^{\omega}\left(\mathbb{T}^{d}, \mathrm{su}(1,1)\right)$ with

\left\|\tilde{f}_{s}\right\|_{h^{\prime}} \leqslant e^{-\left(2 \pi h-2 \pi h^{\prime}-o(1)\right)\left|k_{s+2}\right|} \tag{7.8}

Notice that if one let $\bar{f}_{s}(\cdot)=D_{s} \tilde{f}_{s}(\cdot) D_{s}^{-1}$, then

We finished the $(s+1)$-th step of the construction, as desired.

Let $G_{s}(\cdot)=D_{s} H_{s_{*}}(\cdot)$ and $\bar{B}_{0}=\mathrm{Id}, \bar{B}_{s}=G_{0} \cdots G_{n-2} G_{n-1}$. Then we can construct the desired cocycle sequences:

Lemma A.1. [GYZ2 Under the assumption of Proposition :A. $\left(\ell_{s}\right)$ be the $\epsilon_{0}$-resonances of $2 \rho(\alpha, A)$, there exist $B_{s} \in C_{\tilde{h}}^{\omega}\left(\mathbb{T}^{d}, \overline{\mathrm{P}} \overline{\mathrm{S}}(2, \mathbb{R})\right)$, such that

with $\ell_{i}=\operatorname{deg} B_{s}$ provided $\ell_{i}$ is large enough (the choice of $s$ depends on $\ell_{i}$ ).
