# PROX-REGULAR SWEEPING PROCESSES WITH BOUNDED RETRACTION

#### Abstract

The aim of this paper is twofold. On one hand we prove that the Moreau's sweeping process driven by a uniformly prox-regular moving set with local bounded retraction has a unique solution provided that the coefficient of prox-regularity is larger than the size of any jump of the driving set. On the other hand we show how the case of local bounded retraction can be easily reduced to the 1-Lipschitz continuous case: indeed we first solve the Lipschitz continuous case by means of the so called "catchingup algorithm", and we reduce the local bounded retraction case to the Lipschitz one by using a reparametrization technique for functions with values in the family of proxregular sets.


## 1. Introduction

A sweeping process is an evolution problem with unilateral constraints which was originally introduced by J.J. Moreau in [33] and that can be described as follows. Let $\mathcal{H}$ be a real Hilbert space, and for every $t \in[0, T], T>0$, let $\mathcal{C}(t)$ be a given nonempty, closed subset of $\mathcal{H}$, so that $\mathcal{C}(t)$ can be considered as a moving set whose shape can vary during the time evolution. One then has to find a function $y:[0, \infty] \longrightarrow \mathcal{H}$ such that

$y_{0}$ being a prescribed point in $\mathcal{C}(0)$. Here $\mathcal{L}^{1}$ is the Lebesgue measure, and $N_{\mathcal{C}(t)}(y(t))$ is the (proximal) exterior normal cone to $\mathcal{C}(t)$ at $y(t)$. In the original setting of Moreau's paper [33], the sets $\mathcal{C}(t)$ are assumed to be convex, and the mapping $t \longmapsto \mathcal{C}(t)$ is supposed to be Lipschitz continuous in time, when the family of closed subsets of $\mathcal{H}$ is endowed with the Hausdorff metric. There, the sweeping process (1.1)-(1.3) is solved by approximating the problem by what is now called the Moreau-Yosida regularization. He also solves (1.1)-(1.3) with a more general absolutely continuous driving set $\mathcal{C}(t)$ via an arc-length reparametrization of $\mathcal{C}(t)$ : indeed if $\phi(t)$ is the variation of $\mathcal{C}$ on $[0, t]$, then one finds a Lipschitz moving set $\widetilde{\mathcal{C}}$ such that

[^0]and the problem can be easily reduced to the Lipschitz continuous case by showing that if $\hat{y}(\tau)$ is the Lipschitz continuous solution of the sweeping processes driven by $\widetilde{\mathcal{C}}(\tau)$, then $y(t)=\hat{y}(\phi(t))$ is the solution of the process driven by $\mathcal{C}(t)$.

This analysis of sweeping processes in the convex setting continued in [34, 35, 36] and culminated in [39] where right-continuous driving sets $\mathcal{C}(t)$ with bounded variation are considered, and in this case problem (1.1)-(1.3) has to be reformulated by looking for a right-continuous solution $y$ with bounded variation such that the distributional derivative of $y$ can be written as $\mathrm{D} y=v \mu$ for a suitable positive measure $\mu$ in $[0, T]$ and a density function $v \in L^{1}(\mu ; \mathcal{H})$ for which (1.1) and (1.3) hold together with the inclusion

v(t) \in-N_{\mathcal{C}(t)}(y(t)) \quad \text { for } \mu \text {-a.e. } t \in[0, T] \tag{1.4}
\end{equation*}

which is the $B V$ counterpart of (1.2). Problem (1.4) was solved in [39] by means of an implicit time discretization scheme which is usually called catching-up algorithm. Actually in [39] the moving set $\mathcal{C}$ is assumed to be only with bounded right continuous retraction, rather than with bounded variation, i.e. the Hausdorff distance is replaced by the asymmetric distance $e(\mathcal{A}, \mathcal{B}):=\sup _{x \in \mathcal{A}} d(x, \mathcal{B})$, called excess of $\mathcal{A}$ over $\mathcal{B}$, with $\mathcal{A}, \mathcal{B}$ nonempty closed convex sets in $\mathcal{H}$, and it is assumed that $\sup \sum e\left(\mathcal{C}\left(t_{j-1}\right), \mathcal{C}\left(t_{j}\right)\right)<\infty$, where the supremum is taken over all subdivisions of $0=t_{0}<\cdots<t_{m}=T$ (all the precise definitions will be provided in the next section).

Let us mention that the $B V$ problem can also be solved by an arc-length reparametrization technique as done in [42, 45] for the continuous case and in [43, 47, 48] for the BV discontinuous case. In this last case the arc-length reparametrization must be completed on the jump intervals by means of a suitable geodesic in the space of closed convex sets endowed with the Hausdorff metric. Convex sweeping processes in the $B V$ framework have received a great deal of attention and several results can be found, e.g., in the monograph [32], in papers $[11,12,13,14,10,9,30,1,46,54,22,26,49]$, and in the references therein.

It is very natural to try to relax the convexity assumption on the driving set $\mathcal{C}(t)$, and the first papers where the non-convex case is addressed are [57, 15, 19, 3]. In the first years of this century, the analysis of non-convex sweeping processes starts concentrating on the notion of uniformly prox-regular sets, which can be described as those closed subsets $\mathcal{K}$ for which there exists $r>0$ such that on the neighborhood $U_{r}(\mathcal{K}):=\{x \in \mathcal{H}: d(x, \mathcal{K})<r\}$ the projection on $\mathcal{K}$ is a singleton and is continuous, so that such sets can be regarded as a natural generalization of convex sets. Uniformly prox-regular sets were introduced by Federer in [25] (as positively reached sets) in the finite dimensional case. Further properties of these sets were investigated by Vial in [58] (where the term weak convex set is used). The notion of prox-regularity was later extended to infinite dimensional spaces by Clarke, Stern and Wolenski in [18], and finally the local properties where investigated by Poliquin, Rockafellar and Thibault in [41].

Existence and uniqueness results for sweeping processes in the prox-regular setting were achieved by Colombo and Monteiro Marques in [20] and by Thibault in [53], culminating in the paper [24] by Edmond and Thibault. Since then, prox-regular sweeping processes has called the attention of many other authors: we mention, for instance, $[7,16,4,52,5$, $2,27,28,29]$ and the general result [40].

In the above mentioned literature on non-convex sweeping processes, the continuity assumptions on the moving driving set are always related to the Hausdorff distance and
not to the retraction. To the best of our knowledge, only in [54] it is proved the uniqueness of solutions to prox-regular sweeping processes with bounded retraction, but the existence is proved under the assumption that $\mathcal{C}(t)$ is convex and with bounded retraction (and more generally with bounded truncated retraction).

In the present paper we address the case of prox-regular sweeping processes when the driving moving set has locally bounded retraction. We first solve the Lipschitz continuous case by means of the so called "catching-up algorithm", and we reduce the general case of locally bounded retraction to the Lipschitz one by using the reparametrization technique of [48] adapted to functions with values in the family of prox-regular sets.

The case when a forcing term appear in the dynamics (often called "sweeping process with perturbation") will be studied in a future paper ([50]).

The plan of the paper is the following. In Section 2 we present the preliminaries needed to state the problems and the theorems. In Section 3 we solve the prox-regular sweeping processes with local bounded retraction when $\mathcal{C}(t)$ is 1-Lipschitz continuous with respect to the excess. Finally in Section 4 we solve the general prox-regular process with locally bounded retraction by reducing it to the Lipschitz case thanks to the reparametrizion method cited above.

## 2. Preliminaries and notations

In this section we recall the main definitions and tools needed in the paper. The set of integers greater than or equal to 1 will be denoted by $\mathbb{N}$. If $f: I \longrightarrow \mathbb{R}$ and if $(f(t)-f(s))(t-s) \geq 0$ (respectively $(f(t)-f(s))(t-s)>0)$ we say that $f$ is increasing (respectively strictly increasing).
2.1. Prox-regular sets. We recall here some notions of non-smooth analysis. We refer the reader to the monographs [51, 17, 55, 56]. Throughout this paper we assume that

\|x\|:=\langle x, x\rangle^{1 / 2}, \quad x \in \mathcal{H},

and we endow $\mathcal{H}$ with the natural metric defined by $(x, y) \longmapsto\|x-y\|, x, y \in \mathcal{H}$. If $\rho>0$ and $x \in \mathcal{H}$ we set $B_{\rho}(x):=\{y \in \mathcal{H}:\|y-x\|<\rho\}$ and $\bar{B}_{\rho}(x):=\{y \in \mathcal{H}:\|y-x\| \leq \rho\}$. If $\mathcal{Z} \subseteq \mathcal{H}$, the closure and boundary of $\mathcal{Z}$ will be respectively denoted by $\overline{\mathcal{Z})}$ and $\partial \mathcal{Z}$. If $x \in \mathcal{H}$ we also set $d_{\mathcal{Z}}(x):=d(x, \mathcal{Z}):=\inf _{s \in \mathcal{Z}}\|x-s\|$, defining in this way a function $d_{\mathcal{Z}}: \mathcal{H} \longrightarrow \mathbb{R}$. Let $I$ be an interval of $\mathbb{R}$. The set of $\mathcal{H}$-valued continuous functions defined on $I$ is denoted by $C(I ; \mathcal{H})$. For a function $f: I \longrightarrow \mathcal{H}$ and for $S \subseteq I$ we write $\operatorname{Lip}(f, S):=\sup \{\|f(t)-f(s)\| /|t-s|: s, t \in S, s \neq t\}, \operatorname{Lip}(f):=\operatorname{Lip}(f, I)$, the $\operatorname{Lipschitz}$ constant of $f$, and $\operatorname{Lip}(I ; X):=\{f: I \longrightarrow \mathcal{H}: \operatorname{Lip}(f)<\infty\}$, the set of $\mathcal{H}$ valued Lipschitz continuous functions on $I$. The continuity set of a function $f: I \longrightarrow \mathcal{H}$ is denoted by $\operatorname{Cont}(f)$, while $\operatorname{Discont}(f):=\mathcal{H} \backslash \operatorname{Cont}(f)$. Let us recall that if $U$ is an open subset of $\mathcal{H}$ and if $f: U \longrightarrow \mathbb{R}$, then we say that $f$ is (Frechét) differentiable at $x \in U$ if there exists a (unique) $\nabla f(x) \in \mathcal{H}$ such that $\lim _{h \rightarrow 0}(f(x+h)-f(x)-\langle\nabla f(x), h\rangle) /\|h\|=0$.
Definition 2.1. If $\mathcal{Z} \subseteq \mathcal{H}, \mathcal{Z} \neq \varnothing$, and $y \in \mathcal{H}$ then we set

\operatorname{Proj}_{\mathcal{Z}}(y):=\left\{x \in \mathcal{Z}:\|x-y\|=\inf _{z \in \mathcal{Z}}\|z-y\|\right\} \tag{2.2}
\end{equation*}

We recall the following characterizations.

Proposition 2.1. If $\mathcal{Z} \subseteq \mathcal{H}, \mathcal{Z} \neq \varnothing$, and $y \in \mathcal{H}$, then

x \in \operatorname{Proj}_{\mathcal{Z}}(y) \Longleftrightarrow\left[\langle n, z-x\rangle \leq \frac{1}{2}\|z-x\|^{2} \quad \forall z \in \mathcal{Z}\right] \tag{2.3}

and

$$
\begin{equation*}
\{x\}=\operatorname{Proj}_{\mathcal{Z}}(y) \Longleftrightarrow\left[\langle n, z-x\rangle<\frac{1}{2}\|z-x\|^{2} \quad \forall z \in \mathcal{Z} \backslash\{x\}\right] \tag{2.4}
\end{equation*}

Proof. Statement (2.3) is proved in [17, Proposition 1.3]. Statement (2.4) is proved by the same computation of (2.3): indeed $\{x\}=\operatorname{Proj}_{\mathcal{Z}}(y)$ if and only if $\|x-y\|^{2}<\|z-y\|^{2}$ for every $z \in \mathcal{Z} \backslash\{x\}$, and this inequality is equivalent to (2.4) by virtue of the same computation performed in [17, Proposition 1.3] in order to prove (2.3).

If $\mathcal{K}$ is a nonempty closed subset of $\mathcal{H}$ and $x \in \mathcal{K}$, then $N_{\mathcal{K}}(x)$ denotes the (exterior proximal) normal cone of $\mathcal{K}$ at $x$ which is defined by setting

$$
\begin{equation*}
N_{\mathcal{K}}(x):=\left\{\lambda(y-x): x \in \operatorname{Proj}_{\mathcal{K}}(y), y \in \mathcal{H}, \lambda \geq 0\right\} . \tag{2.5}
\end{equation*}
$$

Let us also recall the following proposition (see, e.g., [17, Proposition 1.5]).
Proposition 2.2. Assume that $\mathcal{K}$ is a closed subset of $\mathcal{H}$ and that $x \in \mathcal{K}$. We have that $u \in N_{\mathcal{Z}}(x)$ if and only if there exists $\sigma \geq 0$ such that

\begin{equation*}
\langle u, z-x\rangle \leq \sigma\|z-x\|^{2} \quad \forall z \in \mathcal{K} . \tag{2.6}
\end{equation*}

Now we recall the notion of uniformly prox-regular set, introduced in [18, Section 4, Theorem 4.1-(d)]) under the name of proximal smooth set, and generalized in [41, Definition 1.1, Definition 2.4, Theorem 4.1].

Definition 2.2. If $\mathcal{K}$ is a nonempty closed subset of $\mathcal{H}$ and if $r \in] 0, \infty[$, then we say that $\mathcal{K}$ is $r$-prox-regular if for every $y \in\left\{v \in \mathcal{H}: 0<d_{\mathcal{K}}(v)<r\right\}$ we have that $\operatorname{Proj}_{\mathcal{K}}(y) \neq \varnothing$ and

$$
x \in \operatorname{Proj}_{\mathcal{K}}\left(x+r \frac{y-x}{\|y-x\|}\right) \quad \forall x \in \operatorname{Proj}_{\mathcal{K}}(y)
$$

The family of r-prox-regular subsets of $\mathcal{H}$ will be denoted by $\mathscr{C}_{r}(\mathcal{H})$. We will also indicate by $\mathscr{C}_{0}(\mathcal{H})$ the family of nonempty closed subsets of $\mathcal{H}$.

It is useful to take into account the following easy property.
Proposition 2.3. Let $\mathcal{K}$ be a closed subset of $\mathcal{H}$. If $y \in \mathcal{H} \backslash \mathcal{K}$ and $x \in \operatorname{Proj}_{\mathcal{K}}(y)$ then $\operatorname{Proj}_{\mathcal{K}}(x+t(y-x))=\{x\}$ for every $\left.t \in\right] 0,1[$. Hence if $\mathcal{K}$ is also $r$-prox-regular for some $r>0$ it follows that $\operatorname{Proj}_{\mathcal{K}}(u)$ is a singleton for every $y \in \mathcal{H}$ such that $d_{\mathcal{K}}(u)<r$.

Proof. If $t \in] 0,1[$ then, thanks to (2.3), for every $z \in \mathcal{K} \backslash\{x\}$ we have that

\langle x+t(y-x)-x, z-x\rangle=t\langle y-x, z-x\rangle \leq \frac{t}{2}\|z-x\|^{2}<\frac{1}{2}\|z-x\|^{2}
$$

therefore $\operatorname{Proj}_{\mathcal{K}}(x+t(y-x))=\{x\}$ by virtue of (2.4) and the first statement is proved. If $\mathcal{K}$ is also $r$-prox-regular and $d_{\mathcal{K}}(u)<r$, pick $x \in \operatorname{Proj}_{\mathcal{K}}(u)$ and let $y=x+r(u-x) /\|u-x\|$. Then $x \in \operatorname{Proj}_{K}(y), u=x+t_{u}(y-x)$ with $\left.t_{u}=r /\|u-x\| \in\right] 0,1[$, so that $\{x\}=$ $\operatorname{Proj}_{\mathcal{K}}(u)$.

Definition 2.3. If $r \in] 0, \infty[$ and if $\mathcal{K} \subseteq \mathcal{H}$ is r-prox-regular, then we can define the function $\mathrm{P}_{\mathcal{K}}:\left\{y \in \mathcal{H}: d_{\mathcal{K}}(y)<r\right\} \longrightarrow \mathcal{K}$ by setting $\mathrm{P}_{\mathcal{K}}(y):=x$ where $\{x\}=\operatorname{Proj}_{\mathcal{K}}(y)$ for every $y \in \mathcal{H}$ such that $d_{\mathcal{K}}(y)<r$.

The following characterizations of prox-regularity are very useful. The proofs can be found in [41, Theorem 4.1] and in [21, Theorem 16].

Theorem 2.1. Let $\mathcal{K}$ be a nonempty closed subset of $\mathcal{H}$ and let $r \in] 0, \infty[$. The following statements are equivalent.
(i) $\mathcal{K}$ is r-prox-regular.
(ii) $d_{\mathcal{K}}$ is differentiable in $\left\{y \in \mathcal{H}: 0<d_{\mathcal{K}}(y)<r\right\}$.
(iii) For every $x \in \mathcal{K}$ and $n \in N_{\mathcal{K}}(x)$ we have

$$
\langle n, z-x\rangle \leq \frac{\|n\|}{2 r}\|z-x\|^{2} \quad \forall z \in \mathcal{K} .
$$

2.2. Functions of bounded variation. Let $I$ be an interval of $\mathbb{R}$. The set of $\mathcal{H}$-valued continuous functions defined on $I$ is denoted by $C(I ; \mathcal{H})$. For a function $f: I \longrightarrow \mathcal{H}$ and for $S \subseteq I$ we write $\operatorname{Lip}(f, S):=\sup \{\|f(t)-f(s)\| /|t-s|: s, t \in S, s \neq t\}, \operatorname{Lip}(f):=$ $\operatorname{Lip}(f, I)$, the Lipschitz constant of $f$, and $\operatorname{Lip}(I ; \mathcal{H}):=\{f: I \longrightarrow \mathcal{H}: \operatorname{Lip}(f)<\infty\}$, the set of $\mathcal{H}$-valued Lipschitz continuous functions on $I$. As usual $\operatorname{Lip}_{\mathrm{loc}}(I ; \mathcal{H}):=\{f:$ $I \longrightarrow \mathcal{H}: \operatorname{Lip}(f, J)<\infty \forall J$ compact in $I\}$.

Definition 2.4. Given an interval $I \subseteq \mathbb{R}$, a function $f: I \longrightarrow \mathcal{H}$, and a subinterval $J \subseteq I$, the variation of $f$ on $J$ is defined by

$$
\mathrm{V}(f, J):=\sup \left\{\sum_{j=1}^{m} \|\left(f\left(t_{j-1}\right)-f\left(t_{j}\right) \|: m \in \mathbb{N}, t_{j} \in J \forall j, t_{0}<\cdots<t_{m}\right\} .\right.
$$

If $\mathrm{V}(f, I)<\infty$ we say that $f$ is of bounded variation on $I$ and we set

$$
B V(I ; \mathcal{H}):=\{f \in I: \longrightarrow \mathcal{H}: V(f, I)<\infty\}
$$

and $B V_{\mathrm{loc}}(I ; \mathcal{H}):=\{f: I \longrightarrow \mathcal{H}: \mathrm{V}(f, J)<\infty \forall J$ compact in $I\}$.
It is well known that the completeness of $\mathcal{H}$ implies that every $f \in B V(I ; \mathcal{H})$ admits one sided limits $f(t-), f(t+)$ at every point $t \in I$, with the convention that $f(\inf I-):=$ $f(\inf I)$ if $\inf I \in I$, and that $f(\sup I+):=f(\sup I)$ if $\sup I \in I$. Moreover $\operatorname{Discont}(f)$ is at most countable. We set

\begin{aligned}
B V^{\mathrm{r}}(I ; \mathcal{H}) & :=\{f \in B V(I ; \mathcal{H}): f(t)=f(t+) \quad \forall t \in I\}, \\
B V_{\mathrm{loc}}^{\mathrm{r}}(I ; \mathcal{H}) & :=\left\{u \in B V_{\mathrm{loc}}(I ; \mathcal{H}): u(t)=u(t+) \quad \forall t \in I\right\}
\end{aligned}
$$

We have $\operatorname{Lip}_{\text {loc }}(I ; \mathcal{H}) \subseteq B V_{\text {loc }}(I ; \mathcal{H})$.
2.3. Differential measures. Given an interval $I$ of the real line $\mathbb{R}$, the family of Borel sets in $I$ is denoted by $\mathscr{B}(I)$. If $\mu: \mathscr{B}(I) \longrightarrow[0, \infty]$ is a measure, $p \in[1, \infty]$, then the space of $\mathcal{H}$-valued functions which are $p$-integrable with respect to $\mu$ will be denoted by $L^{p}(I, \mu ; \mathcal{H})$ or simply by $L^{p}(\mu ; \mathcal{H})$. For the theory of integration of vector valued functions we refer, e.g., to [31, Chapter VI]. When $\mu=\mathcal{L}^{1}$, where $\mathcal{L}^{1}$ is the one dimensional Lebesgue measure, we write $L^{p}(I ; \mathcal{H}):=L^{p}(I, \mu ; \mathcal{H})$.

We recall that a $\mathcal{H}$-valued measure on $I$ is the map $\nu: \mathscr{B}(I) \longrightarrow \mathcal{H}$ such that $\nu\left(\bigcup_{n=1}^{\infty} B_{n}\right)=\sum_{n=1}^{\infty} \nu\left(B_{n}\right)$ for every sequence $\left(B_{n}\right)$ of mutually disjoint sets in $\mathscr{B}(I)$. The total variation of $\nu$ is the positive measure $\mathbf{I} \nu \mathbf{I}: \mathscr{B}(I) \longrightarrow[0, \infty]$ defined by

$$
\mathbf{I} \nu \mathbf{I}(B):=\sup \left\{\sum_{n=1}^{\infty}\left\|\nu\left(B_{n}\right)\right\|: B=\bigcup_{n=1}^{\infty} B_{n}, B_{n} \in \mathscr{B}(I), B_{h} \cap B_{k}=\varnothing \text { if } h \neq k\right\} .
$$

The vector measure $\nu$ is said to be with bounded variation if $\mathbf{I} \nu \mathbf{I}(I)<\infty$. In this case the equality $\|\nu\|:=\mathbf{I} \nu \mathbf{I}(I)$ defines a complete norm on the space of measures with bounded variation (see, e.g. [23, Chapter I, Section 3]).

If $\mu: \mathscr{B}(I) \longrightarrow[0, \infty]$ is a positive bounded Borel measure and if $g \in L^{1}(I, \mu ; \mathcal{H})$, then $g \mu: \mathscr{B}(I) \longrightarrow \mathcal{H}$ denotes the vector measure defined by

$$
g \mu(B):=\int_{B} g \mathrm{~d} \mu, \quad B \in \mathscr{B}(I)
$$

Assume that $\nu: \mathscr{B}(I) \longrightarrow \mathcal{H}$ is a vector measure with bounded variation and $f: I \longrightarrow$ $\mathcal{H}$ and $\phi: I \longrightarrow \mathbb{R}$ are two step maps with respect to $\nu$, i.e. there exist $f_{1}, \ldots, f_{m} \in \mathcal{H}$, $\phi_{1}, \ldots, \phi_{m} \in \mathcal{H}$ and $A_{1}, \ldots, A_{m} \in \mathscr{B}(I)$ mutually disjoint such that $\mathbf{I} \nu \mathbf{I}\left(A_{j}\right)<\infty$ for every $j$ and $f=\sum_{j=1}^{m} \mathbb{1}_{A_{j}} f_{j}, \phi=\sum_{j=1}^{m} \mathbb{1}_{A_{j}} \phi_{j}$. Here $\mathbb{1}_{S}$ is the characteristic function of a set $S$, i.e. $\mathbb{1}_{S}(x):=1$ if $x \in S$ and $\mathbb{1}_{S}(x):=0$ if $x \notin S$. For such step maps we define $\int_{I}\langle f, \mathrm{~d} \nu\rangle:=\sum_{j=1}^{m}\left\langle f_{j}, \nu\left(A_{j}\right)\right\rangle \in \mathbb{R}$ and $\int_{I} \phi \mathrm{~d} \nu:=\sum_{j=1}^{m} \phi_{j} \nu\left(A_{j}\right) \in \mathcal{H}$.

If $S t(\mathbf{I} \nu \mathbf{I} ; \mathcal{H})$ (resp. $S t(\mathbf{I} \nu \mathbf{I}))$ is the set of $\mathcal{H}$-valued (resp. real valued) step maps with respect to $\nu$, then the maps $\operatorname{St}(\mathbf{I} \nu \mathbf{I} ; \mathcal{H}) \longrightarrow \mathcal{H}: f \longmapsto \int_{I}\langle f, \mathrm{~d} \nu\rangle$ and $\operatorname{St}(\mathbf{I} \nu \mathbf{I}) \longrightarrow \mathcal{H}:$ $\phi \longmapsto \int_{I} \phi \mathrm{~d} \nu$ are linear and continuous when $\operatorname{St}(\mathbf{I} \nu \mathbf{I} ; \mathcal{H})$ and $S t(\mathbf{I} \nu \mathbf{I})$ are endowed with the $L^{1}$-seminorms $\|f\|_{L^{1}(\mathbf{I} \nu \mathbf{1} ; \mathcal{H})}:=\int_{I}\|f\| \mathrm{d} \mathbf{I} \nu \mathbf{I}$ and $\|\phi\|_{L^{1}(\mathbf{I} \mathbf{I})}:=\int_{I}|\phi| \mathrm{d} \mathbf{I} \nu \mathbf{I}$. Therefore they admit unique continuous extensions $\mathbf{I}_{\nu}: L^{1}(\mathbf{I} \nu \mathbf{I} ; \mathcal{H}) \longrightarrow \mathbb{R}$ and $\mathrm{J}_{\nu}: L^{1}(\mathbf{I} \nu \mathbf{I}) \longrightarrow \mathcal{H}$, and we set

$$
\int_{I}\langle f, \mathrm{~d} \nu\rangle:=\mathrm{I}_{\nu}(f), \quad \int_{I} \phi \mathrm{~d} \nu:=J_{\nu}(\phi), \quad f \in L^{1}(\mathbf{I} \nu \mathbf{I} ; \mathcal{H}), \quad \phi \in L^{1}(\mathbf{I} \nu \mathbf{I})
$$

The following results (cf., e.g., [23, Section III.17.2-3, p. 358-362]) provide the connection between functions with bounded variation and vector measures which will be implicitly used in this paper.

Theorem 2.2. For every $f \in B V(I ; \mathcal{H})$ there exists a unique vector measure of bounded variation $\nu_{f}: \mathscr{B}(I) \longrightarrow \mathcal{H}$ such that

\nu_{f}(] c, d[)=f(d-)-f(c+), & \nu_{f}([c, d])=f(d+)-f(c-), \\
\nu_{f}([c, d[)=f(d-)-f(c-), & \left.\left.\nu_{f}(] c, d\right]\right)=f(d+)-f(c+) .
\end{array}
$$

whenever $\inf I \leq c<d \leq \sup I$ and the left hand side of each equality makes sense. Conversely, if $\nu: \mathscr{B}(I) \longrightarrow \mathcal{H}$ is a vector measure with bounded variation, and if $f_{\nu}$ : $I \longrightarrow \mathcal{H}$ is defined by $f_{\nu}(t):=\nu\left(\left[\inf I, t[\cap I)\right.\right.$, then $f_{\nu} \in B V(I ; \mathcal{H})$ and $\nu_{f_{\nu}}=\nu$.

Proposition 2.4. Let $f \in B V(I ; \mathcal{H})$, let $g: I \longrightarrow \mathcal{H}$ be defined by $g(t):=f(t-)$, for $t \in \operatorname{int}(I)$, and by $g(t):=f(t)$, if $t \in \partial I$, and let $V_{g}: I \longrightarrow \mathbb{R}$ be defined by $V_{g}(t):=\mathrm{V}(g,[\inf I, t] \cap I)$. Then $\nu_{g}=\nu_{f}$ and $\left|\nu_{f}\right|(I)=\nu_{V_{g}}(I)=\mathrm{V}(g, I)$.

The measure $\nu_{f}$ is called the Lebesgue-Stieltjes measure or differential measure of $f$. Let us see the connection between the differential measure and the distributional derivative. If $f \in B V(I ; \mathcal{H})$ and if $\bar{f}: \mathbb{R} \longrightarrow \mathcal{H}$ is defined by

$$
\bar{f}(t):= \begin{cases}f(t) & \text { if } t \in I  \tag{2.7}\\ f(\inf I) & \text { if } \inf I \in \mathbb{R}, t \notin I, t \leq \inf I \\ f(\sup I) & \text { if } \sup I \in \mathbb{R}, t \notin I, t \geq \sup I\end{cases}
$$

then, as in the scalar case, it turns out (cf. [44, Section 2]) that $\nu_{f}(B)=\mathrm{D} \bar{f}(B)$ for every $B \in \mathscr{B}(\mathbb{R})$, where $\mathrm{D} \bar{f}$ is the distributional derivative of $\bar{f}$, i.e.

$$
-\int_{\mathbb{R}} \varphi^{\prime}(t) \bar{f}(t) \mathrm{d} t=\int_{\mathbb{R}} \varphi \mathrm{dD} \bar{f}, \quad \forall \varphi \in C_{c}^{1}(\mathbb{R} ; \mathbb{R})
$$

where $C_{c}^{1}(\mathbb{R} ; \mathbb{R})$ is the space of continuously differentiable functions on $\mathbb{R}$ with compact support. Observe that $\mathrm{D} \bar{f}$ is concentrated on $I: \mathrm{D} \bar{f}(B)=\nu_{f}(B \cap I)$ for every $B \in \mathscr{B}(I)$, hence in the remainder of the paper, if $f \in B V(I, \mathcal{H})$ then we will simply write

$$
\begin{equation*}
\mathrm{D} f:=\mathrm{D} \bar{f}=\nu_{f}, \quad f \in B V(I ; \mathcal{H}) \tag{2.8}
\end{equation*}
$$

and from the previous discussion it follows that

\|\mathrm{D} f\|=\|\mathrm{D} f \mid(I)=\| \nu_{f} \|=\mathrm{V}(f, I), \quad \forall f \in B V(I ; \mathcal{H}) \tag{2.9}
\end{equation*}
$$

If $I$ is bounded and $p \in[1, \infty]$, then the classical Sobolev space $W^{1, p}(I ; \mathcal{H})$ consists of those functions $f \in C(I ; \mathcal{H})$ for which $\mathrm{D} f=g \mathcal{L}^{1}$ for some $g \in L^{p}(I ; \mathcal{H})$ and $W^{1, \infty}(I ; \mathcal{H})=$ $\operatorname{Lip}(I ; \mathcal{H})$. Let us also recall that if $f \in W^{1,1}(I ; \mathcal{H})$ then the derivative $f^{\prime}(t)$ exists $L^{1}$-a.e. in $t \in I, \mathrm{D} f=f^{\prime} L^{1}$, and $\mathrm{V}(f, I)=\int_{I}\left\|f^{\prime}(t)\right\| \mathrm{d} t$ (see e.g. [8, Appendix]).

In [44, Lemma 6.4 and Theorem 6.1] it is proved that
Proposition 2.5. Assume that $I, J \subseteq \mathbb{R}$ are intervals and that $h: I \longrightarrow J$ is nondecreasing.
(i) $\operatorname{Dh}\left(h^{-1}(B)\right)=\mathcal{L}^{1}(B)$ for every $B \in \mathscr{B}(h(\operatorname{Cont}(h)))$.
(ii) If $f \in \operatorname{Lip}(J ; \mathcal{H})$ and $g: I \longrightarrow \mathcal{H}$ is defined by

$$
g(t):=\left\{\begin{array}{ll}
f^{\prime}(h(t)) & \text { if } t \in \operatorname{Cont}(h) \\
\frac{f(h(t+))-f(h(t-))}{h(t+)-h(t-)} & \text { if } t \in \operatorname{Discont}(h)
\end{array},\right.
$$

then $f \circ h \in B V(I ; \mathcal{H})$ and $\mathrm{D}(f \circ h)=g \mathrm{D}$. This result holds even if $f^{\prime}$ is replaced by any of its $L^{1}$-representatives.
2.4. Set-valued functions with bounded retraction. Let us now recall the asymmetric extendend distance called excess. The material in this subsection is taken from [37, 38].
Definition 2.5. If $\mathscr{P}(\mathcal{H})$ denotes the family of all subsets of $\mathcal{H}$, then the excess is the function e: $\mathscr{P}(\mathcal{H}) \times \mathscr{P}(\mathcal{H}) \longrightarrow[0, \infty]$ defined by

e\left(\mathcal{Z}_{1}, \mathcal{Z}_{2}\right):=\sup _{z_{1} \in \mathcal{Z}_{1}} d\left(z_{1}, \mathcal{Z}_{2}\right)=\inf \left\{\rho \geq 0: \mathcal{Z}_{1} \subseteq \mathcal{Z}_{2}+\bar{B}_{\rho}(0)\right\}, \quad \mathcal{Z}_{1}, \mathcal{Z}_{2} \in \mathscr{P}(\mathcal{H})
$$

The extended number e $\left(\mathcal{Z}_{1}, \mathcal{Z}_{2}\right)$ is also called excess of $\mathcal{Z}_{1}$ over $\mathcal{Z}_{2}$

Observe that $e(\varnothing, \mathcal{Z})=0$ for every $\mathcal{Z} \in \mathscr{P}(\mathcal{H})$ and $e(\mathcal{Z}, \varnothing)=\infty$ for every $\mathcal{Z} \in$ $\mathscr{P}(\mathcal{H}) \backslash\{\varnothing\}$. The following facts are easy to prove (see [38, Section 2a]):

e\left(\mathcal{Z}_{1}, \mathcal{Z}_{2}\right)=0 \Longleftrightarrow \mathcal{Z}_{1} \subseteq \overline{\mathcal{Z}_{2}} & \forall \mathcal{Z}_{1}, \mathcal{Z}_{2} \in \mathscr{P}(\mathcal{H}) \\
e\left(\mathcal{Z}_{1}, \mathcal{Z}_{2}\right) \leq e\left(\mathcal{Z}_{1}, \mathcal{Z}_{3}\right)+e\left(\mathcal{Z}_{3}, \mathcal{Z}_{2}\right) & \forall \mathcal{Z}_{1}, \mathcal{Z}_{2}, \mathcal{Z}_{3} \in \mathscr{P}(\mathcal{H}) \\
e\left(\mathcal{Z}_{1}, \mathcal{Z}_{2}\right)=e\left(\overline{\mathcal{Z}_{1}}, \mathcal{Z}_{2}\right)=e\left(\overline{\mathcal{Z}_{1}}, \overline{\mathcal{Z}_{2}}\right)=e\left(\overline{\mathcal{Z}_{1}}, \overline{\mathcal{Z}_{2}}\right) & \forall \mathcal{Z}_{1}, \mathcal{Z}_{2} \in \mathscr{P}(\mathcal{H})
\end{array}
$$

Definition 2.6. Given an interval $I \subseteq \mathbb{R}, \mathscr{F} \subseteq \mathscr{P}(\mathcal{H})$, a function $\mathcal{C}: I \longrightarrow \mathscr{F}$, and a subinterval $J \subseteq I$, the retraction of $\mathcal{C}$ on $J$ is defined by

\begin{equation*}
\mathrm{R}(\mathcal{C}, J):=\sup \left\{\sum_{j=1}^{m} e\left(\mathcal{C}\left(t_{j-1}\right), \mathcal{C}\left(t_{j}\right)\right): m \in \mathbb{N}, t_{j} \in J \forall j, t_{0}<\cdots<t_{m}\right\} \tag{2.10}
\end{equation*}
$$

If $\mathrm{R}(\mathcal{C}, I)<\infty$ we say that $\mathcal{C}$ is of bounded retraction on $I$ and we set

$$
B R(I ; \mathscr{F}):=\{\mathcal{C}: I \longrightarrow \mathscr{F}: \mathrm{R}(\mathcal{C}, I)<\infty\}, \quad \mathscr{F} \subseteq \mathscr{P}(\mathcal{H})
$$

If $\mathrm{R}(\mathcal{C}, J)<\infty$ for every interval $J$ compact in $I$, we say that $\mathcal{C}$ has local bounded retraction (or finite retraction on $I$ ) and we set

$$
B R_{\mathrm{loc}}(I ; \mathscr{F}):=\{\mathcal{C}: I \longrightarrow \mathscr{F}: \mathrm{R}(\mathcal{C}, J)<\infty \forall J \text { compact in } I\}, \quad \mathscr{F} \subseteq \mathscr{P}(\mathcal{H}) .
$$

Definition 2.7. Assume that $I$ is an interval of $\mathbb{R}$ and that $\mathcal{C} \in B R_{\mathrm{loc}}(I ; \mathscr{P}(\mathcal{H}))$. If $t \in I$ we say that $\mathcal{C}$ is left-continuous at $t$ if there exists $\lim _{s \rightarrow t-} e(\mathcal{C}(s), \mathcal{C}(t))=0$, and we say that $\mathcal{C}$ is right-continuous at $t$ if there exists $\lim _{s \rightarrow t+} e(\mathcal{C}(t), \mathcal{C}(s))=0$, with the convention that $\lim _{s \rightarrow t-} e(\mathcal{C}(s), \mathcal{C}(t))=0$ if $t=\inf I$, and that $\lim _{s \rightarrow t+} e(\mathcal{C}(t), \mathcal{C}(s))=0$ if $t=\sup I$. We say that $\mathcal{C}$ is continuous at $t$ if it is left-continuous and right-continuous at $t$. We set

$$
\operatorname{Cont}(\mathcal{C}):=\{t \in I: \mathcal{C} \text { is continuous at } t\}, \quad \operatorname{Discont}(\mathcal{C}):=I \backslash \operatorname{Cont}(\mathcal{C}) .
$$

and

$$
\begin{align*}
\mathcal{C}(t+):=\left\{x \in \mathcal{H}: \lim _{s \rightarrow t+} d(x, \mathcal{C}(s))=0\right\}, & t \in I \cup \inf I,  \tag{2.11}\\
\mathcal{C}(t-):=\left\{x \in \mathcal{H}: \lim _{s \rightarrow t-} d(x, \mathcal{C}(s))=0\right\}, & t \in I \cup \sup I \tag{2.12}
\end{align*}
$$

together with $\mathcal{C}(t-):=\mathcal{C}(t)$ if $t=\inf I$, and $\mathcal{C}(t+):=\mathcal{C}(t)$ if $t=\sup I$.
The following proposition is proved in [38, Proposition 4b, Proposition 4c, Section 4e].
Proposition 2.6. Assume that $I$ is an interval of $\mathbb{R}$ such that $t_{0}:=\inf I \in I$, and assume that $\mathcal{C} \in B R_{\text {loc }}(I ; \mathscr{P}(\mathcal{H}))$. Let $\ell_{\mathcal{C}}: I \longrightarrow[0, \infty[$ be defined by

$$
\begin{equation*}
\ell_{\mathcal{C}}(t):=\mathrm{R}\left(\mathcal{C} ;\left[t_{0}, t\right]\right), \quad t \in I . \tag{2.13}
\end{equation*}
$$

Then $\mathrm{R}(\mathcal{C} ;[a, b])=\mathrm{R}(\mathcal{C} ;[a, c])+\mathrm{R}(\mathcal{C} ;[c, b])$ whenever $a, b \in I$ with $a<c<b$, and

$$
e(\mathcal{C}(s), \mathcal{C}(t)) \leq \ell_{\mathcal{C}}(t)-\ell_{\mathcal{C}}(s) \quad \forall t, s \in I, s \leq t
$$

thus if $\mathcal{C}\left(t_{*}\right) \neq \varnothing$ for some $t_{*} \in I$, then $\mathcal{C}(t) \neq \varnothing$ for every $t \geq t_{*}$. If $t \in I, t \neq \sup I$, then $\mathcal{C}(t+)$ is a closed subset of $\mathcal{H}$ and

$$
\ell_{\mathcal{C}}(t+)-\ell_{\mathcal{C}}(t)=\lim _{s \rightarrow t+} e(\mathcal{C}(t), \mathcal{C}(s)) \leq e(\mathcal{C}(t), \mathcal{C}(t+))
$$

and the following four statements (a)-(d) are equivalent:
(a) $\mathcal{C}$ is right-continuous at $t$,
(b) $\ell_{\mathcal{C}}$ is right-continuous at $t$,
(c) $\mathcal{C}(t) \subseteq \mathcal{C}(t+)$,
(d) $e(\mathcal{C}(t), \mathcal{C}(t+))=0$.

Instead if $t \in I, t \neq \inf I$, then $\mathcal{C}(t-)$ is a closed subset of $\mathcal{H}$ and

$$
\begin{aligned}
& e(\mathcal{C}(t-), \mathcal{C}(t))=\ell_{\mathcal{C}}(t)-\ell_{\mathcal{C}}(t-)=\lim _{s \rightarrow-} e(\mathcal{C}(s), \mathcal{C}(t)), \\
& e(\mathcal{C}(s), \mathcal{C}(t-)) \leq \ell_{\mathcal{C}}(t-)-\ell_{\mathcal{C}}(s) \quad \forall s, t \in I, s<t,
\end{aligned}
$$

thus we have that $\mathcal{C}(t-) \neq \varnothing$ if $\mathcal{C}(s) \neq \varnothing$ for some $s<t$. Therefore the following four statements (e)-(h) are equivalent:
(e) $\mathcal{C}$ is left-continuous at $t$,
(f) $\ell_{\mathcal{C}}$ is left-continuous at $t$,
(g) $\mathcal{C}(t-) \subseteq \overline{\mathcal{C}(t)}$,
(h) $e(\mathcal{C}(t-), \mathcal{C}(t))=0$.

Thus we can give the following definitions.
Definition 2.8. Assume that $I$ is an interval of $\mathbb{R}$ such that $t_{0}:=\inf I \in I$, and that $r \in\left[0, \infty\left[\right.\right.$. If $\mathcal{C} \in B R_{\mathrm{loc}}\left(I ; \mathscr{C}_{r}(\mathcal{H})\right)$ we set

$$
\operatorname{Cont}(\mathcal{C}):=\{t \in I: e(\mathcal{C}(t), \mathcal{C}(t+))=e(\mathcal{C}(t-), \mathcal{C}(t))=0\}
$$

and $\operatorname{Discont}(\mathcal{C}):=I \backslash \operatorname{Cont}(\mathcal{C})$. Moreover we set

$$
\begin{aligned}
& B R^{r}\left(I ; \mathscr{C}_{r}(\mathcal{H})\right):=\left\{\mathcal{C} \in B R\left(I ; \mathscr{C}_{r}(\mathcal{H})\right): e(\mathcal{C}(t), \mathcal{C}(t+))=0 \forall t \in I\right\}, \\
&\left.B R_{\text {loc }}^{r}\left(I ; \mathscr{C}_{r}(\mathcal{H})\right):=\left\{\mathcal{C} \in B R_{\text {loc }}\left(I ; \mathscr{C}_{r} \mathcal{H}\right)\right): e(\mathcal{C}(t), \mathcal{C}(t+))=0 \forall t \in I\right\}, \\
& C B R_{\text {loc }}\left(I ; \mathscr{C}_{r}(\mathcal{H})\right):=\left\{\mathcal{C} \in B R_{\text {loc }}^{r}\left(I ; \mathscr{C}_{r}(\mathcal{H})\right): \operatorname{Cont}(\mathcal{C})=I\right\} .
\end{aligned}
$$

## 3. The 1-Lipschitz continuous case

Within this section we solve the prox-regular sweeping process driven by a moving set which is 1-Lipschits continuous with respect to the excess.
Theorem 3.1. Assume that $r \in] 0, \infty\left[\right.$ and let $\mathscr{C}_{r}(\mathcal{H})$ be the family of $r$-prox-regular subsets of $\mathcal{H}$. Assume that $\mathcal{C}:\left[0, \infty\left[\longrightarrow \mathscr{C}_{r}(\mathcal{H})\right.\right.$ is 1 -Lipschitz continuous with respect to the excess e in the following sense:

$$
\begin{equation*}
e(\mathcal{C}(s), \mathcal{C}(t)) \leq t-s \quad \forall t, s \in[0, \infty[, s<t . \tag{3.1}
\end{equation*}
$$

If $y_{0} \in \mathcal{C}(0)+B_{r}(0)$ then there exists a unique function $y:[0, \infty[\longrightarrow \mathcal{H}$ such that

$$
\begin{array}{ll}
y(t) \in \mathcal{C}(t) & \forall t \in[0, \infty[, \\
y^{\prime}(t) \in-N_{\mathcal{C}(t)}(y(t)) & \text { for } \mathcal{L}^{1} \text {-a.e. } t \in[0, \infty[, \\
y(0)=\mathrm{P}_{\mathcal{C}(0)}\left(y_{0}\right) . & \tag{3.4}
\end{array}
$$

Moreover $y \in \operatorname{Lip}\left(\left[0, \infty[; \mathcal{H})\right.\right.$ and $\operatorname{Lip}(y)=1$. We will call this unique solution $\mathrm{S}\left(\mathcal{C}, y_{0}\right)$ so that if

$$
D_{\text {Lip }}:=\left\{( \mathcal { C } , y _ { 0 } ) \in \operatorname { L i p } _ { \text { loc } } \left(\left[0, \infty\left[; \mathscr{C}_{\mathcal{H}}\right) \times \mathcal{H}: \text { (3.1) holds, } y_{0} \in \mathcal{C}(0)+B_{r}(0)\right\},\right.\right.
$$

then we can define $\mathrm{S}: D_{\text {Lip }} \longrightarrow \operatorname{Lip}_{\text {loc }}([0, \infty[; \mathcal{H})$, the solution operator associating with every pair $\left(\mathcal{C}, y_{0}\right)$ the only $y$ satisfying (3.2)-(3.4).

Proof. First of all observe that the uniqueness of solutions can be inferred arguing exactly as in [54, Proposition 3.6], where only the hypomonotonicity is used. The argument in our situation is actually simpler bacause the functions involved here are absolutely continuous and the standard Gronwall lemma can be exploited.

Concerning existence, let $n_{r} \in \mathbb{N}$ be such that

$$
\begin{equation*}
\frac{1}{2^{n}}<r \quad \forall n \in \mathbb{N}, n \geq n_{r} \tag{3.5}
\end{equation*}
$$

and for every $n \in \mathbb{N}, n \geq n_{r}$, let $\left(t_{j}^{n}\right)_{j \in \mathbb{N}}$ be the sequence defined by

$$
\begin{equation*}
t_{j}^{n}:=\frac{j}{2^{n}}, \quad j \in \mathbb{N} \tag{3.6}
\end{equation*}
$$

Since $y_{0} \in \mathcal{C}(0)+B_{r}(0)$, from the $r$-prox-regularity of $\mathcal{C}(0)$ it follows that there exists a unique projection $\mathrm{P}_{\mathcal{C}(0)}\left(y_{0}\right) \in \mathcal{C}(0)$. So now we fix $n \geq n_{r}$ and we prove by induction that there is a sequence $\left(y_{j}^{n}\right)_{j=1}^{\infty}$ such that:

$$
\begin{array}{ll}
y_{0}^{n}:=\mathrm{P}_{\mathcal{C}(0)}\left(y_{0}\right), & \forall j \in \mathbb{N}, \\
y_{j}^{n} \in \mathcal{C}\left(t_{j}^{n}\right) & \forall j \in \mathbb{N}, \\
-\frac{y_{j}^{n}-y_{j-1}^{n}}{t_{j}^{n}-t_{j-1}^{n}} \in N_{\mathcal{C}\left(t_{j}^{n}\right)}\left(y_{j}^{n}\right) & \tag{3.9}
\end{array}
$$

which is an implicit time discretization scheme for (3.2)-(3.4) usually called "catchingup algorithm". & \leq e\left(\mathcal{C}\left(t_{j-1}^{n}\right), \mathcal{C}\left(t_{j}^{n}\right)\right)+e\left(\mathcal{C}\left(t_{j-1}^{n}\right), \mathcal{C}(t)\right) \leq 2 / 2^{n} \tag{3.36}
\end{align*}
$$

therefore by (3.34) and by the closedness of $\mathcal{C}(t)$ we infer that

Moreover from (3.16) we also infer that $x \in \operatorname{Lip}([0, T] ; \mathcal{H})$ and, at least for a subsequence which we do not relabel,

\end{aligned}

& \leq \limsup _{n \rightarrow \infty} \sum_{k=n}^{N(n)} \lambda_{j}^{(n)}\left(\frac{1}{r}\left\|z_{t}-x(t)\right\|^{2}+\varepsilon_{k}\right) \\
& =\frac{1}{r}\left\|z_{t}-x(t)\right\|^{2}+\limsup _{n \rightarrow \infty} \sum_{k=n}^{N(n)} \lambda_{j}^{(n)} \varepsilon_{k} \\
& \leq \frac{1}{r}\left\|z_{t}-x(t)\right\|^{2}+\limsup _{n \rightarrow \infty} \sup _{k \geq n} \varepsilon_{k} \tag{3.43}
\end{align*}

but $\lim \sup _{n \rightarrow \infty} \sup _{k \geq n} \varepsilon_{k}=0$, therefore we have that

## 4. Prox-regular sweeping processes with bounded retraction

Let us start with a technical lemma.
Lemma 4.1. Assume that (2.1) holds, $0<\rho<r$, and that $\mathcal{K}$ is an r-prox-regular subset of $\mathcal{H}$. If $\mathcal{K}_{\rho}:=\mathcal{K}+\bar{B}_{\rho}(0)$ then the following statements hold true.
(i) $\mathcal{K}_{\rho}=\left\{x \in \mathcal{H}:\left\|x-\mathrm{P}_{\mathcal{K}}(x)\right\| \leq \rho\right\}$.
(ii) $\partial \mathcal{K}_{\rho}=\left\{x \in \mathcal{H}:\left\|x-\mathrm{P}_{\mathcal{K}}(x)\right\|=\rho\right\}$.
(iii) $\mathcal{K}_{\rho}$ is $(r-\rho)$-prox-regular.
(iv) If $y \in \partial \mathcal{K}_{\rho}$ then $N_{\mathcal{K}_{\rho}}(y)=\left\{\lambda\left(y-\mathrm{P}_{\mathcal{K}}(y)\right): \lambda \geq 0\right\}$.

Proof. Concerning statement (i), if $x \in \mathcal{K}_{\rho}$ then $x=z+u$ for some $z \in \mathcal{K}$ and some $u \in \bar{B}_{\rho}(0)$, therefore $\left\|x-\mathrm{P}_{\mathcal{K}}(x)\right\|=d_{\mathcal{K}}(x)=\inf \{\|w-z-u\|: w \in \mathcal{K}\} \leq\|u\| \leq \rho$. Vice versa if $x \in \mathcal{H}$ and $\left\|x-\mathrm{P}_{\mathcal{K}}(x)\right\| \leq \rho$ then $x=\mathrm{P}_{\mathcal{K}}(x)+\left(x-\mathrm{P}_{\mathcal{K}}(x)\right) \in \mathcal{K}_{\rho}$. Hence statement (ii) follows from the continuity of the mapping $x \longmapsto\left\|x-\mathrm{P}_{\mathcal{K}}(x)\right\|=d_{\mathcal{K}}(x)$ from $\mathcal{K}+B_{\alpha}(0)$ into $\mathbb{R}$. Now let us recall that thanks to [6, Lemma 3.1] we have that

Therefore from the differentiability of $d_{\mathcal{K}}$ on $\mathcal{K}_{r} \backslash \mathcal{K}$ it follows that $d_{\mathcal{K}_{\rho}}$ is differentiable in $\left(\mathcal{K}_{\rho}+B_{r-\rho}(0)\right) \backslash \mathcal{K}_{\rho}$, and this implies statement (iii) by Thereom 2.1. We finally prove (iv). Let us observe that by [41, Theorem 4.1] we have that $d_{K}$ is differentiable at $y$ and $\nabla d_{\mathcal{K}}(y)=\left(y-\mathrm{P}_{\mathcal{K}}(y)\right) /\left\|y-\mathrm{P}_{\mathcal{K}}(y)\right\|$, therefore thanks to [18, Therem 3.1-(2) and Theorem 3.4] we infer that $N_{\mathcal{K}_{\rho}}(y)=\left\{\lambda \nabla d_{\mathcal{K}}(y): \lambda \geq 0\right\}=\left\{\lambda\left(y-\mathrm{P}_{\mathcal{K}}(y)\right): \lambda \geq 0\right\}$.

Now we define a particular multivalued curve which will be used to fill in the jumps of a discontinuous moving set with bounded retraction.

Definition 4.1. Assume that $\mathcal{Z}_{0}, \mathcal{Z}_{1} \in \mathscr{C}_{0}(\mathcal{H})$ and that $\rho:=e\left(\mathcal{Z}_{0}, \mathcal{Z}_{1}\right)<\infty$. We define the curve $\mathcal{G}_{\mathcal{Z}_{0}, \mathcal{Z}_{1}}:[0,1] \longrightarrow \mathscr{C}_{0}(\mathcal{H})$ by

$$

The curve defined in the previous definition is 1-Lipschitz continuous with respect to the excess $e$, indeed we can prove the following result.

Proposition 4.1. If $\mathcal{Z}_{0}, \mathcal{Z}_{1} \in \mathscr{C}_{0}(\mathcal{H})$ and $\mathcal{G}_{\left(\mathcal{Z}_{0}, \mathcal{Z}_{1}\right)}:[0,1] \longrightarrow \mathscr{C}_{0}(\mathcal{H})$ is defined as in Definition 4.1 we have

in particular $\operatorname{Lip}(\mathcal{G})=(t-s)$ and we can call $\mathcal{G}$ a e-geodesic connecting $\mathcal{Z}_{0}$ to $\mathcal{Z}_{1}$.
Proof. Let us set $D_{\delta}:=\bar{B}_{\delta}(0)$. For every $\delta>0$ we have $\mathcal{G}(0)=\mathcal{Z}_{0} \subseteq \mathcal{Z}_{1}+D_{\rho}=$ $\mathcal{Z}_{1}+D_{(1-t) \rho}+D_{t \rho}$ thus $e(\mathcal{G}(0), \mathcal{G}(t)) \leq t \rho$. If $0<s \leq t$ we have

hence $(t-s) e\left(\mathcal{Z}_{0}, \mathcal{Z}_{1}\right) \leq e(\mathcal{G}(s), \mathcal{G}(t))$ and (4.3) is proved.
The next Lemma shows that the trajectory of the solution of the sweeping process driven by $\mathcal{G}_{\left(\mathcal{Z}_{0}, \mathcal{Z}_{1}\right)}$ is always a straight line segment connecting the initial datum $y_{0}$ to its projection to $\mathcal{Z}_{1}$.

Lemma 4.2. Assume that $r \in] 0, \infty\left[\right.$. Let $\mathcal{Z}_{0} \in \mathscr{C}_{r}(\mathcal{H})$ and $\mathcal{Z}_{1} \in \mathscr{C}_{r}(\mathcal{H})$ be such that $\rho:=e\left(\mathcal{Z}_{0}, \mathcal{Z}_{1}\right)<r$, and let $\mathcal{G}_{\left(\mathcal{Z}_{0}, \mathcal{Z}_{1}\right)}=\mathcal{G}:[0,1] \longrightarrow \mathscr{C}_{r}(\mathcal{H})$ be defined by (4.2). If $y_{0} \in \mathcal{Z}_{0}$, then let $t_{0} \in[0,1]$ be the unique number such that

( $t_{0}$ is well defined because $\mathcal{Z}_{1}$ is r-prox-regularity and $\left.e\left(\mathcal{Z}_{1}, \mathcal{Z}_{2}\right)<r\right)$. If $y \in \operatorname{Lip}([0,1] ; \mathcal{H})$ is defined by

i.e. $y$ is the unique solution of the sweeping process driven by $\mathcal{G}_{\left(\mathcal{z}_{0}, \mathcal{Z}_{1}\right)}$ with initial condition $y_{0} \in \mathcal{Z}_{0}$.

Proof. For simplicity let us write $\mathcal{G}:=\mathcal{G}_{\left(\mathcal{Z}_{0}, \mathcal{Z}_{1}\right)}$. If $y_{0} \in \mathcal{Z}_{1}$ we have that $t_{0}=1, y(t)=$ $y_{0}=\mathrm{P}_{\mathcal{Z}_{1}}\left(y_{0}\right) \in \mathcal{G}(t)$ and $y^{\prime}(t)=0$ for every $t \in[0,1]$, and we are done. Therefore we now assume that $y_{0} \notin \mathcal{Z}_{1}$, i.e. $t_{0}<1$, thus from Lemma 4.1-(ii) and formula (4.5) we deduce that

(that is $t_{0}$ is the first time when $\partial\left(\mathcal{Z}_{1}+\bar{B}_{(1-t) \rho}\right)$ meets $\left.y_{0}\right)$. If $\left.\left.t \in\right] t_{0}, 1\right]$ we have that

therefore

\end{equation*}

Therefore, since

y^{\prime}(t)= \begin{cases}0 & \text { if } t \in] 0, t_{0}[ \\ \frac{1}{1-t_{0}}\left(\operatorname{Proj}_{\mathcal{Z}_{2}}\left(y_{0}\right)-y_{0}\right) & \text { if } t \in] t_{0}, 1[ \end{cases}
$$

we infer from Lemma 4.1-(iv) that $y^{\prime}(t) \in-N_{\mathcal{G}(t)}(y(t))$ for every $\left.t \in\right] 0,1\left[\backslash\left\{t_{0}\right\}\right.$, and we are done.

Now we prove the main theorem of the paper.
Theorem 4.1. Assume that $r \in] 0, \infty\left[\right.$ and let $\mathscr{C}_{r}(\mathcal{H})$ be the family of r-prox-regular subsets of $\mathcal{H}$. Assume that $\mathcal{C} \in B R_{\mathrm{loc}}^{\mathrm{r}}\left(\left[0, \infty\left[; \mathscr{C}_{r}(\mathcal{H})\right)\right.\right.$, i.e. that $\mathcal{C}:\left[0, \infty\left[\longrightarrow \mathscr{C}_{r}(\mathcal{H})\right.\right.$ has locally bounded retraction. If $y_{0} \in \mathcal{C}(0)+B_{r}(0)$ and $e(\mathcal{C}(t-), \mathcal{C}(t))<r$ for every $t \geq 0$, then there exists a unique $y \in B V_{\mathrm{loc}}^{\mathrm{r}}([0, \infty[; \mathcal{H})$ such that there exists a Borel measure $\mu: \mathscr{B}\left(\left[0, \infty[) \longrightarrow[0, \infty]\right.\right.$ and a function $v \in L_{\mathrm{loc}}^{1}(\mu ; \mathcal{H})$ such that

We will call this unique solution $\mathrm{S}\left(\mathcal{C}, y_{0}\right)$ so that if

$$

then we can define $S: D_{B R} \longrightarrow \operatorname{Lip}_{\mathrm{loc}}([0, \infty[; \mathcal{H})$, the solution operator associating with every pair $\left(\mathcal{C}, y_{0}\right)$ the only $y$ satisfying (4.12)-(4.15).

Proof. We recall that $\ell_{\mathcal{C}}:[0, \infty[\longrightarrow[0, \infty[$ is defined by

In the occurrence that $\ell_{\mathcal{C}}$ is not constant on any nondegenerate interval, then one has $\mathcal{C}(t)=\widetilde{\mathcal{C}}\left(\ell_{\mathcal{C}}(t)\right)$ for every $t \geq 0$ (this fact suggests that $\widetilde{\mathcal{C}}$ can be considered as a sort of reparametrization of $\mathcal{C}$ by the "arc length" $\ell_{\mathcal{C}}$ ). Let us also observe that $\mathcal{C}$ is settheoretically increasing in time on the intervals where $\ell_{\mathcal{C}}$ is constant (therefore the solution of the sweeping process driven by $\mathcal{C}$ is expected to be constant on these intervals). If $\sigma, \tau \in \ell_{\mathcal{C}}\left(\left[0, \infty[)\right.\right.$ with $\sigma<\tau$, then $s=\min \ell_{\mathcal{C}}^{-1}(\sigma) \leq \sup \ell_{\mathcal{C}}^{-1}(\sigma)=s^{*}$ and $t=\min \ell_{\mathcal{C}}^{-1}(\tau) \leq$ $\sup \ell_{\mathcal{C}}^{-1}(\tau)=t^{*}$ for some $s, s^{*}, t, t^{*} \geq 0$, thus $e(\widetilde{\mathcal{C}}(\sigma), \widetilde{\mathcal{C}}(\tau))=e(\mathcal{C}(s), \mathcal{C}(t)) \leq R(\mathcal{C} ;[s, t])=$ $\tau-\sigma$, and we have proved that $\widetilde{\mathcal{C}}$ is 1 -Lipschitz continuous with respect to $e$ i.e.

\mathcal{C}(t-) \subseteq \mathcal{A}(t) \quad \forall t \in \operatorname{Discont}(\mathcal{C}) \tag{4.20}
\end{equation*}
$$

Now for any $t \in \operatorname{Discont}(\mathcal{C})$ we can define the curve $\mathcal{G}_{t}:[0,1] \longrightarrow \mathscr{C}_{r}(\mathcal{H})$ by setting

$$
\mathcal{G}_{t}:=\mathcal{G}_{\left(\mathcal{A}(t), \mathcal{C}(t+)+\bar{B}_{\left.\rho_{t}(0)\right)}\right.}:[0,1] \longrightarrow \mathscr{C}_{r}(\mathcal{H}), \quad t \in \operatorname{Discont}(\mathcal{C}),
$$

where $\mathcal{G}_{\left(\mathcal{A}(t), \mathcal{C}(t+)+\bar{B}_{\rho_{t}}(0)\right)}$ is defined in Definition 4.1, so that

$$
\mathcal{G}_{t}(\tau)=\mathcal{C}(\tau)+\bar{B}_{(1-\tau) \rho_{t}}(0) \quad \forall \tau \in[0,1] .
$$

We are now in position to define

$$
\begin{equation*}
\widetilde{\mathcal{C}}(\sigma):=\mathcal{G}_{t}\left(\frac{\sigma-\ell_{\mathcal{C}}(t-)}{\ell_{\mathcal{C}}(t)-\ell_{\mathcal{C}}(t-)}\right) \quad \text { if } \sigma \in\left[\ell_{\mathcal{C}}(t-), \ell_{\mathcal{C}}(t)\left[, \text { if } \ell_{\mathcal{C}}(t-) \neq \ell_{\mathcal{C}}(t)\right.\right. \tag{4.21}
\end{equation*}
$$

The resulting curve $\widetilde{\mathcal{C}}:\left[0, \infty\left[\longrightarrow \mathscr{C}_{r}(\mathcal{H})\right.\right.$ is a 1-Lipschitz continuous function with respect to $e$ because $\mathcal{G}_{t}$ is a geodesic connecting respectively $\mathcal{A}(t)$ to $\mathcal{C}(t), \mathcal{C}(t-) \subseteq \mathcal{A}(t)$, and $\widetilde{\mathcal{C}}$ is 1 -Lipschitz continuous on $\ell_{\mathcal{C}}([0, \infty[)$. Therefore there exists a unique function $\hat{y} \in$ $\operatorname{Lip}_{\text {loc }}([0, \infty[; \mathcal{H})$ such that

$$
\begin{array}{ll}
\hat{y}(\sigma) \in \widetilde{\mathcal{C}}(\sigma) & \forall \sigma \in[0, \infty[, \\
\hat{y}^{\prime}(\sigma) \in-N_{\widetilde{\mathcal{C}}(\sigma)}(\hat{y}(\sigma)) & \text { for } \mathcal{L}^{1} \text {-a.e. } \sigma \in[0, \infty[, \\
\hat{y}(0)=\mathrm{P}_{\widetilde{\mathcal{C}}(0)}\left(y_{0}\right)=\mathrm{P}_{\mathcal{C}(0)}\left(y_{0}\right) . & \tag{4.24}
\end{array}
$$

Now let us set

$$
\begin{equation*}
y:=\mathrm{S}\left(\widetilde{\mathcal{C}}, y_{0}\right) \circ \ell_{\mathcal{C}}=\hat{y} \circ \ell_{\mathcal{C}}, \tag{4.25}
\end{equation*}
$$

and let us prove that $y$ solves (4.12)-(4.15). It is obvious that $y(t) \in \mathcal{C}(t)$ when $\ell_{\mathcal{C}}^{-1}\left(\ell_{\mathcal{C}}(t)\right)=$ $\{t\}$. If instead $\ell_{\mathcal{C}}^{-1}\left(\ell_{\mathcal{C}}(t)\right)$ is not a singleton, we have that $y(t)=\hat{y}\left(\ell_{\mathcal{C}}(t)\right) \in \widetilde{\mathcal{C}}\left(\ell_{\mathcal{C}}(t)\right)=$ $\mathcal{C}\left(\min \ell_{\mathcal{C}}^{-1}\left(\ell_{\mathcal{C}}(t)\right)\right) \subseteq \mathcal{C}(t)$, because $\mathcal{C}$ is set-theoretically increasing on $\ell_{\mathcal{C}}^{-1}\left(\ell_{\mathcal{C}}(t)\right)$. Thus condition (4.12) is satisfied. The initial condition (4.15) is obviously satisfied. Since $\hat{y}$ is Lipschitz continuous and $\ell_{\mathcal{C}}$ is right-continuous and increasing, it is clear that $y \in$ $B V_{\mathrm{loc}}^{\mathrm{r}}\left(\left[0, \infty[; \mathcal{H})\right.\right.$, so that $\operatorname{Discont}(y)=\operatorname{Discont}\left(\ell_{\mathcal{C}}\right)=\operatorname{Discont}(\mathcal{C})$. If $v:[0, \infty[\longrightarrow \mathcal{H}$ is defined by

$$
v(t):=\left\{\begin{array}{ll}
\hat{y}^{\prime}\left(\ell_{\mathcal{C}}(t)\right) & \text { if } t \in \operatorname{Cont}\left(\ell_{\mathcal{C}}\right)  \tag{4.26}\\
\frac{\hat{y}\left(\ell_{\mathcal{C}}(t)\right)-\hat{y}\left(\ell_{\mathcal{C}}(t-)\right)}{\ell_{\mathcal{C}}(t)-\ell_{\mathcal{C}}(t-)} & \text { if } t \in \operatorname{Discont}\left(\ell_{\mathcal{C}}\right)
\end{array},\right.
$$

then from Proposition 2.5-(ii) we infer that $\mathrm{D} y=v \mathrm{D} \ell_{\mathcal{C}}$, i.e. (4.13) holds with $\mu=\mathrm{D} \ell_{\mathcal{C}}$. Let us set

$$
\begin{equation*}
Z:=\left\{t \in \left[0, \infty\left[:-\hat{y}^{\prime}(t) \notin N_{\widetilde{\mathcal{C}}(t)}(\hat{y}(t))\right\} .\right.\right. \tag{4.27}
\end{equation*}
$$

From formula (4.23) we deduce that

$$
\mathcal{L}^{1}(Z)=0
$$

therefore, thanks to Proposition 2.5-(i), we have that

$$
\begin{align*}
& \mathrm{D} \ell_{\mathcal{C}}\left(\left\{t \in \operatorname{Cont}\left(\ell_{\mathcal{C}}\right):-v(t) \notin N_{\mathcal{C}(t)}(y(t))\right\}\right) \\
= & \mathrm{D} \ell_{\mathcal{C}}\left(\left\{t \in \operatorname{Cont}\left(\ell_{\mathcal{C}}\right):-\hat{y}^{\prime}\left(\ell_{\mathcal{C}}(t)\right) \notin N_{\tilde{\mathcal{C}}\left(\ell_{\mathcal{C}}(t)\right)}\left(\hat{y}\left(\ell_{\mathcal{C}}(t)\right)\right\}\right)\right. \\
= & \mathrm{D} \ell_{\mathcal{C}}\left(\left\{t \in \operatorname{Cont}\left(\ell_{\mathcal{C}}\right): \ell_{\mathcal{C}}(t) \in Z\right\}\right)=\mathcal{L}^{1}(Z)=0 . \tag{4.28}
\end{align*}
$$

Now let us fix $t \in \operatorname{Discont}\left(\ell_{\mathcal{C}}\right)$ and observe that

$$
\left.\widetilde{\mathcal{C}}(\sigma)=\mathcal{G}_{(\mathcal{A}(t), \mathcal{C}(t))}\left(\frac{\sigma-\ell_{\mathcal{C}}(t-)}{\ell_{\mathcal{C}}(t)-\ell_{\mathcal{C}}(t-)}\right) \quad \forall \sigma \in\right] \ell_{\mathcal{C}}(t-), \ell_{\mathcal{C}}(t)[
$$

thus by the semigroup property of (4.22)-(4.24), by Lemma 4.2, and thanks to the fact that

$$
\begin{equation*}
y(t-)=\hat{y}\left(\ell_{\mathcal{C}}(t-)\right) \in \widetilde{\mathcal{C}}\left(\ell_{\mathcal{C}}(t-)\right)=\mathcal{A}(t) \tag{4.29}
\end{equation*}
$$

we have

$$
\begin{equation*}
-v(t)=\frac{\hat{y}\left(\ell_{\mathcal{C}}(t-)\right)-\hat{y}\left(\ell_{\mathcal{C}}(t)\right)}{\ell_{\mathcal{C}}(t)-\ell_{\mathcal{C}}(t-)}=\frac{\hat{y}\left(\ell_{\mathcal{C}}(t-)\right)-\mathrm{P}_{\mathcal{C}(t)}\left(\hat{y}\left(\ell_{\mathcal{C}}(t-)\right)\right)}{\ell_{\mathcal{C}}(t)-\ell_{\mathcal{C}}(t-)} \tag{4.30}
\end{equation*}
$$

hence

$$
-v(t) \in N_{\mathcal{C}(t)}\left(\mathrm{P}_{\mathcal{C}(t)}\left(\hat{y}\left(\ell_{\mathcal{C}}(t-)\right)\right)\right)=N_{\mathcal{C}(t)}\left(\hat{y}\left(\ell_{\mathcal{C}}(t)\right)\right)=N_{\mathcal{C}(t)}(y(t)) \quad \forall t \in \operatorname{Discont}(\mathcal{C})
$$

that together with (4.27)-(4.28) implies that

$$
\mathrm{D} \ell_{\mathcal{C}}\left(\left\{t \in\left[0, \infty\left[:-v(t) \notin N_{\mathcal{C}(t)}(y(t))\right\}\right)=0\right.\right.
$$

hence (4.14) also holds with $\mu=\mathrm{D} \ell_{\mathcal{C}}$.
Concerning uniqueness, let us observe that since $\mathcal{C}$ has local bounded retraction, then $\operatorname{Discont}(\mathcal{C})=\operatorname{Discont}\left(\ell_{\mathcal{C}}\right)$, thus $\operatorname{Discont}(\mathcal{C})$ is at most denumerable. Let us consider first the case when the cardinality of $\operatorname{Discont}(\mathcal{C})$ is equal to the cardinality of $\mathbb{N}$. Since $e(\mathcal{C}(t-), \mathcal{C}(t))=\ell_{\mathcal{C}}(t)-\ell_{\mathcal{C}}(t-)$ for every $t \in \operatorname{Discont}(\mathcal{C})$, we infer that there exist $A_{-}$
and $A_{+}$such that $\operatorname{Discont}(\mathcal{C})=A_{-} \cup A_{+}, A_{-} \cap A_{+}=\varnothing, A_{-}=\left\{t_{n}: n \in \mathbb{N}\right\}$ with $e\left(\mathcal{C}\left(s_{n}-\right), \mathcal{C}\left(s_{n}\right)\right)<r / 2$ for all $n \in \mathbb{N}$, and $A_{+}=\left\{s_{m}: m=1, \ldots, N\right\}$ with $r / 2 \leq$ $e\left(\mathcal{C}\left(s_{m}-\right), \mathcal{C}\left(s_{m}\right)\right)<r$ for all $m=1, \ldots, N$ and $s_{0}:=0<s_{1}<s_{2}<\cdots<s_{N}$. Arguing iteratively, thanks to the existence part of this proof, and to [54, Proposition 3.6], we have that for every $m \in\{1, \ldots, N\}$ there is only one solution $y_{m} \in B V^{r}\left(\left[s_{m-1}, s_{m}[; \mathcal{H})\right.\right.$ to the sweeping process

$$
\begin{array}{ll}
y_{m}(t) \in \mathcal{C}(t) & \forall t \in\left[s_{m-1}, s_{m}[,\right. \\
\mathrm{D} y_{m}=v_{m} \mu_{m}, & \text { for } \mu \text {-a.e. } t \in\left[s_{m-1}, s_{m}[,\right. \\
-v_{m}(t) \in N_{\mathcal{C}(t)}\left(y_{m}(t)\right) &
\end{array}
$$

because $y_{m-1}\left(s_{m-1}-\right) \in \mathcal{A}(t)$. Moreover, thanks the existence part of this proof, partitioning $\left[s_{N}, \infty[\right.$ into a denumerable union of precompact intervals, and using [54, Proposition 3.6], we infer that there is only one solution $y_{N+1} \in B V_{\mathrm{loc}}^{\mathrm{r}}\left(\left[s_{N}, \infty[; \mathcal{H})\right.\right.$ to the sweeping process

$$
\begin{array}{ll}
y_{N+1}(t) \in \mathcal{C}(t) & \forall t \in\left[s_{N}, \infty[,\right. \\
\mathrm{D} y_{N+1}=v_{N+1} \mu_{N+1}, & \text { for } \mu \text {-a.e. } t \in\left[s_{N}, \infty\right], \\
-v_{N+1}(t) \in N_{\mathcal{C}(t)}\left(y_{N+1}(t)\right) & \\
y_{N+1}\left(s_{N}\right)=\mathrm{P}_{\mathcal{C}\left(s_{N}\right)}\left(y_{N}\left(s_{N}-\right)\right), & \tag{4.38}
\end{array}
$$

because $y_{N}\left(s_{N}-\right) \in \mathcal{A}\left(s_{N}\right)$. We claim that the function $y$ defined piecing together all the $y_{m}$ 's, i.e.

$$
y(t):= \begin{cases}y_{m}(t) & \text { if } t \in\left[s_{m-1}, s_{m}[, m \in\{1, \ldots, N\}\right. \\ y_{N+1}(t) & \text { if } t \in\left[s_{N}, \infty[ \right.\end{cases}
$$

is the only solution to (4.12)-(4.15). Indeed setting

$$
\mu(B):=\mu_{N+1}\left(B \cap \left[s_{N}, \infty[)+\sum_{m=1}^{N+1} \mu_{m}\left(B \cap \left[s_{m-1}, s_{m}[), \quad B \in \mathscr{B}([0, \infty[)\right.\right.\right.\right.
$$

and

$$
v(t):=\left\{\begin{array}{ll}
v_{m}(t) & \text { if } t \in\left[s_{m-1}, s_{m}[, m \in\{1, \ldots, N\},\right. \\
v_{N+1}(t) & \text { if } t \in\left[s_{N}, \infty[,\right.
\end{array} \quad t \in[0, \infty[\right.
$$

then $\mathrm{D} y=w \mu$, and for every $m \in\{1, \ldots, N\}$, by (4.14), we have

$$
y\left(s_{m}\right)-y\left(s_{m}-\right)=\mathrm{D} y\left(\left\{s_{m}\right\}\right)=v_{m+1}\left(s_{m}\right) \mu_{m+1}\left(\left\{s_{m}\right\}\right)
$$

and

$$
y\left(s_{m}\right)-y\left(s_{m}-\right)=\mathrm{P}_{\mathcal{C}\left(s_{m}\right)}\left(y_{m}\left(s_{m}-\right)\right)-y\left(s_{m}-\right) \in N_{\mathcal{C}\left(s_{m}\right)}\left(y_{m}\left(s_{m}\right)\right)
$$

so that, since $\mu_{m+1}\left(\left\{s_{m}\right\}\right)>0$,

$$
\begin{equation*}
-v\left(s_{m}\right) \in N_{\mathcal{C}\left(s_{m}\right)}\left(y\left(s_{m}\right)\right) \quad \forall m \in\{1, \ldots, N\} \tag{4.39}
\end{equation*}
$$

and we know that on the jumps $t$ of $\mathcal{C}$ any solution $y$ satisfies a fortiori the condition (4.39), because its density with respect to a positive measure must belong to the $-N_{\mathcal{C}(t)}(y(t))$. The case when the cardinality of $\operatorname{Discont}(\mathcal{C})$ is finite follows the same argument and is actually simpler.

Finally from the definition of pointwise variation, from (4.25), and from the 1-Lipschitz continuity of $\hat{y}$, we infer that

$$
\begin{equation*}
\mathrm{V}(y,[s, t])=\mathrm{V}\left(\hat{y},\left[\ell_{\mathcal{C}}(s), \ell_{\mathcal{C}}(t)\right]\right) \leq \mathrm{V}\left(\ell_{\mathcal{C}},[s, t]\right)=\mathrm{R}(\mathcal{C},[s, t]) \tag{4.40}
\end{equation*}
$$

whenever $s<t$, and the theorem is completely proved.
Corollary 4.1. Assume that $\mathcal{C} \in B R_{\text {loc }}^{r}\left(\left[0, \infty\left[; \mathscr{C}_{r}(\mathcal{H})\right)\right.\right.$, and $y_{0} \in \mathcal{C}(0)+B_{r}(0)$, and let $y:=\mathrm{S}\left(\mathcal{C}, y_{0}\right)$ be the unique solution of the sweeping process $(4.12)-(4.15)$.
(i) If $\mathcal{C} \in C B V_{\mathrm{loc}}\left(\left[0, \infty\left[; \mathscr{C}_{r}(\mathcal{H})\right)\right.\right.$ then $\mathrm{S}\left(\mathcal{C}, y_{0}\right) \in C\left(\left[0, \infty[; \mathcal{H}) \cap B V_{\mathrm{loc}}([0, \infty[; \mathcal{H})\right.\right.$.
(ii) If $\mathcal{C}$ is locally absolutely continuous, in the sense that there exists a locally absolutely continuous function $r:[0, \infty[\longrightarrow \mathbb{R}$ such that

$$
e(\mathcal{C}(t), \mathcal{C}(s)) \leq \int_{t}^{s} r^{\prime}(\tau) \mathrm{d} \tau \quad \forall t, s \geq 0, t<s
$$

then $y$ is locally absolutely continuous, i.e. $y \in W^{1,1}([0, T] ; \mathcal{H})$ for every $T>0$. In this case we have that (4.12) and (4.15) hold together with

$$
\begin{equation*}
y^{\prime}(t) \in-N_{\mathcal{C}(t)}(y(t)) \quad \text { for } \mathcal{L}^{1} \text {-a.e. } t \in[0, \infty[. \tag{4.41}
\end{equation*}
$$

(iii) If $\mathcal{C}$ is Lipschitz continuous in the sense that there exists $L \geq 0$ such that

$$
e(\mathcal{C}(t), \mathcal{C}(s)) \leq L(s-t) \quad \forall t, s \geq 0, t<s
$$

then $y \in \operatorname{Lip}([0, \infty[; \mathcal{H})$ with $\operatorname{Lip}(y) \leq L$.
Proof. We have

$$
\mathrm{S}\left(\mathcal{C}, y_{0}\right)=\mathrm{S}\left(\widetilde{\mathcal{C}}, y_{0}\right) \circ \ell_{\mathcal{C}}
$$

with $\operatorname{Lip}\left(\mathrm{S}\left(\widetilde{\mathcal{C}}, y_{0}\right)\right) \leq 1$. Therefore statement (i) follows from the continuity of $\ell_{\mathcal{C}}$. Statement (iii) and the first part of statement (ii) follow from the fact that the local absolute continuity of $\mathcal{C}$ (respectively the $L$-Lipschitz continuity of $\mathcal{C}$ ) is equivalent to the local absolute continuity of $\ell_{\mathcal{C}}$ (respectively the $L$-Lipschitz continuity of $\mathcal{C}$ ), see, e.g., [38, Section 3d]. We are left to prove (4.41). We have $\mathrm{D} y=y^{\prime} \mathcal{L}^{1}$, and if we set $\hat{y}:=\mathrm{S}(\widetilde{\mathcal{C}}) \in \operatorname{Lip}([0, T] ; \mathcal{H})$ and

$$
\begin{equation*}
Z:=\left\{s \in \left[0, \infty\left[:-\hat{y}^{\prime}(s) \notin N_{\widetilde{\mathcal{C}}(s)}(\hat{y}(s))\right\},\right.\right. \tag{4.42}
\end{equation*}
$$

then by Theorem 3.1

$$
\begin{equation*}
\mathcal{L}^{1}(Z)=0 . \tag{4.43}
\end{equation*}
$$

We have $y^{\prime}(t)=\ell_{\mathcal{C}}^{\prime}(t) \hat{y}^{\prime}\left(\ell_{\mathcal{C}}(t)\right)$ for $\mathcal{L}^{1}$-a.e. $t \geq 0$, therefore

$$
\begin{align*}
& \mathcal{L}^{1}\left(\{t \in] 0, T\left[:-y^{\prime}(t) \notin N_{\mathcal{C}(t)}(y(t))\right\}\right) \\
= & \mathcal{L}^{1}\left(\{t \in] 0, T\left[:-\ell_{\mathcal{C}}^{\prime}(t) \hat{y}^{\prime}\left(\ell_{\mathcal{C}}(t)\right) \notin N_{\widetilde{\mathcal{C}}\left(\ell_{\mathcal{C}}(t)\right)}\left(\hat{y}\left(\ell_{\mathcal{C}}(t)\right)\right)\right\}\right) . \tag{4.44}
\end{align*}
$$

Using the fact that $N_{\mathcal{K}}(x)$ is a cone, we have

$$
\begin{align*}
& \{t \in] 0, T\left[:-\ell_{\mathcal{C}}^{\prime}(t) \hat{y}^{\prime}\left(\ell_{\mathcal{C}}(t)\right) \notin N_{\widetilde{\mathcal{C}}\left(\ell_{\mathcal{C}}(t)\right)}\left(\hat{y}\left(\ell_{\mathcal{C}}(t)\right)\right)\right\} \\
= & \{t \in] 0, T\left[:-\hat{y}^{\prime}\left(\ell_{\mathcal{C}}(t)\right) \notin N_{\widetilde{\mathcal{C}}\left(\ell_{\mathcal{C}}(t)\right)}\left(\hat{y}\left(\ell_{\mathcal{C}}(t)\right)\right), \ell_{\mathcal{C}}^{\prime}(t) \neq 0\right\} \\
= & \{t \in] 0, T\left[: \ell_{\mathcal{C}}(t) \in Z, \ell_{\mathcal{C}}^{\prime}(t) \neq 0\right\} . \tag{4.45}
\end{align*}
$$

Moreover observe that (cf. [45, Lemma 3.1])

$$
\begin{equation*}
\mathcal{L}^{1}\left(\left\{t \geq 0: \exists \ell_{\mathcal{C}}^{\prime}(t) \neq 0, \ell_{\mathcal{C}}(t) \in Z\right\}\right)=0 \tag{4.46}
\end{equation*}
$$

therefore we conclude by collecting equations (4.42), (4.43), (4.45) and (4.46).
Remark 4.1. Part (iii) of the previous Corollary can be proved directly following the proof of Theorem 3.1.
