# WEIGHTED CSCK METRIC (I): A PRIORI ESTIMATES

#### Abstract

Let $X$ be a compact Kähler manifold. In this paper we study the existence of constant weighted scalar curvature Kähler (weighted cscK) metrics on $X$. More precisely, we establish a priori $C^{k}$-estimates $(k \geq 0)$ for the Kähler potential associated with these metrics, thereby extending a result due to Chen and Cheng in the classical cscK setting.

## 1. Introduction

A central theme in Kähler geometry is the search for canonical Kähler metrics. The concept of constant weighted scalar curvature metrics (weighted cscK for short), introduced by the third author in [25], provides a unification for various related notions of canonical Kähler metrics that satisfy special curvature conditions.

We present here the first of two papers, focused on investigating the existence of weighted cscK metrics in a given cohomology class. In this paper, we derive a priori $C^{k}$-estimates, $k \geq 0$, for the Kähler potential associated to the metric with constant weighted scalar curvature. This work extends the result of Chen and Cheng [12] concerning cscK metrics. In the subsequent second paper, we will demonstrate the existence of the weighted cscK metric provided that the weighted Mabuchi energy is relatively coercive, and we will explore several geometric applications.
1.1. Weighted cscK problem. We fix a compact Kähler manifold $\left(X, \omega_{0}, \mathbb{T}\right)$ of complex dimension $n$. Let $\mathbb{T}$ be an $r$-dimensional compact real torus in the reduced automorphism group $\operatorname{Aut}_{\text {red }}(X)$ with Lie algebra $\mathfrak{t}$. Suppose $\omega_{0}$ is a $\mathbb{T}$-invariant Kähler form and consider the set of smooth $\mathbb{T}$-invariant Kähler potentials $\mathcal{K}\left(X, \omega_{0}\right)^{\mathbb{T}}$ relative to $\omega_{0}$. For $\varphi \in \mathcal{K}\left(X, \omega_{0}\right)^{\mathbb{T}}$ we denote by $\omega_{\varphi}=\omega_{0}+d d^{c} \varphi$ the corresponding Kähler metric. Here $d=\partial+\bar{\partial}$ and $d^{c}=i(\bar{\partial}-\partial)$ so that $d d^{c}=2 i \partial \bar{\partial}$ as in [17, page 29]. This choice of $d$ and $d^{c}$ is consistent with the fact that we choose the scalar curvature to be defined as two times the trace; note that this normalization has an impact also in the expression of the $\operatorname{Ricci}$ form, i.e. $\operatorname{Ric}\left(\omega_{\varphi}\right)=\operatorname{Ric}\left(\omega_{0}\right)+\frac{1}{2} d d^{c} \log \frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}$.

It is well-known that the $\mathbb{T}$-action on $X$ is $\omega_{\varphi}$-Hamiltonian (see e.g. [17, Section 2.5]) and that $P_{\varphi}:=\mu_{\varphi}(X)$ is a convex polytope in $\mathfrak{t}^{*}$ [5, 19, 25]. Here $\mu_{\varphi}: X \rightarrow \mathfrak{t}^{*}$ is the moment map associated to $\omega_{\varphi}$ and $\mathfrak{t}^{*}$ stands for the dual vector space for the Lie algebra $\mathfrak{t}$ of $\mathbb{T}$. We normalize $\mu_{\varphi}$ by

$$
\begin{equation*}
\mu_{\varphi}=\mu_{0}+d^{c} \varphi, \tag{1}
\end{equation*}
$$

in such a way that $P=P_{\varphi}$ is $\varphi$-independent, see [25, Lemma 1]. From now, we always suppose that the moment map satisfies (1). Let us stress that the identity in (11) means that for all $\xi \in \mathfrak{t}$,

$$
\left\langle\mu_{\varphi}, \xi\right\rangle=\left\langle\mu_{0}, \xi\right\rangle+\left\langle d^{c} \varphi, \xi\right\rangle, \quad \text { with } \quad\left\langle d^{c} \varphi, \xi\right\rangle=\sum_{i=1}^{r}\left\langle d^{c} \varphi\left(\xi_{i}\right) \xi_{i}^{*}, \xi\right\rangle,
$$

where $\left(\xi_{1}, \ldots, \xi_{r}\right)$ is a basis of the Lie algebra $\mathfrak{t}$ of $\mathbb{T}$ and $\left(\xi_{1}^{*}, \ldots, \xi_{r}^{*}\right)$ is its dual basis.
For a given positive weight function $\mathrm{v} \in C^{\infty}\left(P, \mathbb{R}_{>0}\right)$, we define the v -weighted Ricci form by

$$
\begin{equation*}
\operatorname{Ric}_{\mathrm{v}}\left(\omega_{\varphi}\right):=\operatorname{Ric}\left(\omega_{\varphi}\right)-\frac{1}{2} d d^{c} \log \mathrm{v}\left(\mu_{\varphi}\right) . \tag{2}
\end{equation*}
$$

Then the v-weighted scalar curvature of a $\mathbb{T}$-invariant Kähler metric $\omega_{\varphi} \in\left[\omega_{0}\right]$ is defined by

$$
\begin{equation*}
\operatorname{Scal}_{\mathrm{v}}\left(\omega_{\varphi}\right):=2 \mathrm{v}\left(\mu_{\varphi}\right) \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}_{\mathrm{v}}\left(\omega_{\varphi}\right)\right) \tag{3}
\end{equation*}
$$

where $\Lambda_{\varphi, v}$ is the v-weighted trace with respect to $\omega_{\varphi}$ (see Appendix A. 2 for more details about this operator). This definition is equivalent to the one introduced in [25] (see Lemma (3.2), but we do prefer the above more compact expression.

For a given weight $\mathrm{w} \in C^{\infty}(P, \mathbb{R})$, a $\mathbb{T}$-invariant Kähler metric $\omega_{\varphi}$ is said ( $\mathrm{v}, \mathrm{w}$ )-weighted $c s c K$ if its v-weighted scalar curvature satifies

$$
\begin{equation*}
\operatorname{Scal}_{\mathrm{v}}\left(\omega_{\varphi}\right)=\mathrm{w}\left(\mu_{\varphi}\right) . \tag{4}
\end{equation*}
$$

The significance of (4) in relation to various geometric conditions is thoroughly examined in [25] (see also [4] for v-solitons). However, we shall mention a few specific cases below:
(a) for $\mathrm{v}=1$ and $\mathrm{w}=c$ is a constant, (4) corresponds to the classical cscK equation;
(b) for $\mathrm{v}=1$ and $\mathrm{w}=\ell_{\text {ext }}$, where $\ell_{\text {ext }}$ is the affine extremal function, the weighted $\operatorname{cscK}$ metrics are Calabi's extremal Kähler metrics [10];
(c) for $\mathrm{v}>0$ is any smooth function and $\mathrm{w}=2 \mathrm{v}(x)(n+\langle d \log \mathrm{v}(x), x\rangle)$, (4) corresponds to the weighted v-soliton examined in [4, 20], generalizing the well-studied Kähler-Ricci solitons (see e.g. [7, 8, 27, 28]);
(d) for v and w polynomials, then ( $\mathrm{v}, \mathrm{w}$ )-cscK metrics on $X$ correspond to Calabi's extremal Kähler metrics on the total space of an holomorphic fibration $Y$ with fiber $X$, called semisimple principal fibration [2, 4, 22);
(e) for $\mathrm{v}=\ell^{-n-1}, \mathrm{w}=a \ell^{-n-2}$ and $\left[\omega_{0}\right]=c_{1}(L)$, where $\ell$ is a positive affine-linear function on $P, a$ is a constant, and $L$ is a polarization of $X$, then a weighted $\csc \mathrm{K}$ metric is a scalar flat cone Kähler metric on the affine cone $\left(L^{-1}\right)^{\times}$(see [1, 3]).
1.2. Main results and strategy of the proof. The starting point is to re-write the 4th order non-linear PDE in (4) as a system of two linear elliptic PDEs:

$$
\begin{cases}F & =\log \left(\mathrm{v}\left(\mu_{\varphi}\right) \frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)  \tag{5}\\ \Delta_{\varphi, \mathrm{v}} F & =-\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right) .\end{cases}
$$

The equivalence between (4) and (5) is established in Proposition 3.3.
In the above equation $\Delta_{\varphi, \mathrm{v}}$ is the v-weighted Laplacian with respect to $\omega_{\varphi}$ (we refer to Appendix A. 1 for basic properties of this operator). Note that for $\mathrm{v}=1$ and w being constant equal to $\frac{n c_{1}(X) \cdot\left\{\omega_{0}\right\}^{n-1}}{\left\{\omega_{0}\right\}^{n}}$, we retrieve the system proposed by [12] in the cscK case.

In the original proof by Chen and Cheng [12] in the unweighted setting, the authors derive $C^{0}$ and $C^{2}$ a priori estimates by establishing an intermediate $C^{1}$ a priori estimate for the Kähler potential $\varphi$. With the $C^{0}$ and $C^{2}$ estimates established, higher order estimates are subsequently obtained through standard regularity results for complex Monge-Ampère equations and linear elliptic operators. It is important to emphasize that their proof of the $C^{0}$ estimate [12, Theorem 5.1] relies on the Alexandroff maximum principle for the real Monge-Ampère operator.

In this paper, following [16], we present a proof of the $C^{0}$ and $C^{2}$ estimates that bypass the need for an intermediate $C^{1}$ estimate. However, it is important to note that the "weighted" case introduces significantly more challenges and subtleties due to the presence of the weighted operators $\Delta_{\varphi, \mathrm{v}}$ and $\Lambda_{\varphi, \mathrm{v}}$ in (5). In practice, many additional terms require (uniform) bounds when establishing a priori estimates. We address these terms with detailed explanations to ensure clarity in the presentation.

Our first main result is the $C^{0}$-estimate:
Theorem A. The functions $\varphi$ and $F$ are uniformly bounded by a constant that depends on $n, \omega_{0}, \mathrm{v}, \mathrm{w}$ and the entropy $\operatorname{Ent}(\varphi):=\int_{X} \log \left(\frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right) \omega_{\varphi}^{n}$.

The proof of the $C^{0}$-estimate is an extension of the approach proposed in [16, which crucially employs pluripotential theory.

From this, we then get $C^{2}$-estimate:
Theorem B. There exists a positive constant $C>0$ depending on $\omega_{0}$, v, w, $\|F\|_{C^{0}}$ and $\|\varphi\|_{C^{0}}$ such that

$$
\max _{X}\left(|d F|_{\varphi}^{2}+\Lambda_{0}\left(\omega_{\varphi}\right)\right) \leq C
$$

where $\Lambda_{0}$ is the trace with respect to $\omega_{0}$.
Two crucial intermediate steps consist in establishing a priori integral $L^{p}$-estimates $(p \geq 1)$ for the Laplacian $\Delta_{\varphi}$ (Theorem 5.1) and a lower bound for the weighted Laplacian $\Delta_{\varphi, v} u$ for $u:=e^{\frac{F}{2}}|d F|_{\varphi}^{2}+K \Lambda_{0}\left(\omega_{\varphi}\right)$ (Proposition 6.3).

Noting that $\Delta_{\varphi, v}$ is elliptic (see Lemma A.2), the higher-order estimates can be derived using standard arguments of elliptic and complex Monge-Ampère theories [6, 24] similar to those used in the usual cscK problem (cf [12, page 3]).
1.3. Notations. In the text we will denote by $\Delta_{\varphi}, \Lambda_{\varphi}$ the Laplacian and the trace with respect to $\omega_{\varphi}$. The scalar curvature Scal is defined as twice the trace of the Ricci form, i.e. $\operatorname{Scal}\left(\omega_{\varphi}\right)=2 \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{\varphi}\right)\right)$ where the $\operatorname{Ricci}$ form is defined by $\operatorname{Ric}\left(\omega_{\varphi}\right):=\operatorname{ric}_{\varphi}(J \cdot, \cdot)$ with $\operatorname{ric}_{\varphi}$ the Ricci symmetric 2 -tensor of the underlying riemannian metric $g_{\varphi}$. We denote by $\nabla^{\varphi}$ the gradient with respect to $g_{\varphi}$.
1.4. Organisation of the paper. In Section 2 we introduce notations and results which will be used throughout the paper: we provide definitions and references to pluripotential theory. Section 3 is dedicated to establish the equivalence between the fourth-order PDE (4) and the system of elliptic PDE's (5).

The proof of the $C^{0}$-estimate, stated in Theorem A is presented in Section 4. In Section 5, we prove the $L^{p}$-estimates needed for the proof of Theorem $B$ which can be found finally in Section 6.

## 2. Preliminaries in pluripotential theory

We recall below some ingredients from pluripotential theory that are going to be crucial in what follows in order to establish uniform $C^{0}$-estimates. The first is a powerful integrability result which is known as a uniform version of Skoda's integrability theorem. We introduce

$$
\nu_{\omega_{0}}:=\sup _{u, x} \nu(u, x), \quad x \in X, u \in \operatorname{PSH}\left(X, \omega_{0}\right),
$$

where $\nu(u, x)$ denotes the Lelong number of $u$ at $x$. We note that from the proof of [18, Lemma 8.10] one can deduce that $\nu_{\omega_{0}} \geq 1$.
Theorem 2.1. Let $c<2 \nu_{\omega_{0}}^{-1}$. Then there exists a uniform constant $C>0$ such that for all $u \in \operatorname{PSH}\left(X, \omega_{0}\right)$ with $\sup _{X} u=0$ we have

$$
\int_{X} e^{-c u} \omega_{0}^{n} \leq C .
$$

We refer to [18, Theorem 8.11] for a proof. The following result is due to Kołodziej [23]:
Theorem 2.2. Assume $\omega_{u}^{n}=f \omega_{0}^{n}$ with $f \in L^{p}$ for some $p>1$. Then there exists $C>0$ depending only on $\omega, n,\|f\|_{L^{p}}$ such that

$$
\operatorname{Osc}_{X} u \leq C
$$

Here $L^{p}:=L^{p}\left(\omega_{0}^{n}\right)$. In the following we specify the reference volume form in the notation of the $L^{p}$ norms only if is different from the standard one.

At last, we recall [15, Theorem 3.3], that can be viewed as a generalization of Kołodziej's theorem:
Theorem 2.3. Fix $a \in[0,1), A>0, \chi \in \operatorname{PSH}\left(X, \omega_{0}\right)$ and $0 \leq f \in L^{p}$ for some $p>1$. Assume that $u \in \operatorname{PSH}\left(X, \omega_{0}\right)$, normalized by $\sup _{X} u=0$, satisfies

$$
\omega_{u}^{n} \leq f \omega_{0}^{n}+a \omega_{\chi}^{n} .
$$

Assume also that

$$
\begin{equation*}
\int_{E} f \omega_{0}^{n} \leq A\left[\operatorname{Cap}_{\chi}(E)\right]^{2} \tag{6}
\end{equation*}
$$

for every Borel subset $E \subset X$. If $P[u]$ is less singular than $\chi$ (i.e. $\chi \leq P[u]+C$, for some $C>0$ ) then

$$
\chi-\sup _{X} \chi-C\left(\|f\|_{L^{p}}, p,(1-a)^{-1}, A\right) \leq u .
$$

It is worth it to mention that such a result is stated and proved in a much more general
 and it is defined as

$$
\operatorname{Cap}_{\chi}(E):=\sup \left\{\int_{E} \omega_{u}^{n}: u \in \operatorname{PSH}\left(X, \omega_{0}\right), \chi-1 \leq u \leq \chi\right\}
$$

and

$$
P[u]=\left(\sup \left\{v \in \operatorname{PSH}\left(X, \omega_{0}\right), v \leq 0 \text { and } v \leq u+C, \text { for some } C>0\right\}\right)^{*},
$$

where $*$ denotes the upper semi-continuous regularization. For later purposes we mention that $P[u]=0$ if and only if $u$ is such that $\int_{X} \omega_{u}^{n}=V$ ([13, Theorem 1.3]).

## 3. Weighted cscK equation as a system of elliptic PDEs

The goal of this section is to write the weighted cscK equation (4) as a system of two elliptic PDEs. We define $F:=\log \left(\mathrm{v}\left(\mu_{\varphi}\right) \frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)$.
We first show that the weighted scalar curvature introduced by [25] and that writes as

$$
\begin{equation*}
\operatorname{Scal}_{\mathrm{v}}\left(\omega_{\varphi}\right)=\mathrm{v}\left(\mu_{\varphi}\right) \operatorname{Scal}\left(\omega_{\varphi}\right)-2 \Delta_{\varphi} \mathrm{v}\left(\mu_{\varphi}\right)+\sum_{i, j=1}^{r} \mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right), \tag{7}
\end{equation*}
$$

is equivalent to (31). We take (7) as a definition.
We develop the second term of the RHS of (7).

$$
\begin{align*}
\Delta_{\varphi} \mathrm{v}\left(\mu_{\varphi}\right) & =\Lambda_{\varphi} d d^{c} \mathrm{v}\left(\mu_{\varphi}\right) \\
& =\Lambda_{\varphi} d\left(\sum_{i=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) d^{c} \mu_{\varphi}^{i}\right) \\
& =\Lambda_{\varphi}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) d d^{c} \mu_{\varphi}^{i}+\mathrm{v}_{, i j}\left(\mu_{\varphi}\right) d \mu_{\varphi}^{i} \wedge d^{c} \mu_{\varphi}^{j}\right)  \tag{8}\\
& =\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}-\mathrm{v}_{, i j}\left(\mu_{\varphi}\right) \Lambda_{\varphi}\left(\omega_{\varphi}\left(\xi_{i}, \cdot\right) \wedge \omega_{\varphi}\left(\xi_{j}, J \cdot\right)\right),
\end{align*}
$$

where $\mu_{\varphi}^{i}:=\left\langle\mu_{\varphi}, \xi_{i}\right\rangle$ and we use that $\omega_{\varphi}\left(\xi_{i}, \cdot\right)=-d \mu_{\varphi}^{i}$ and $\omega_{\varphi}\left(\xi_{j}, J \cdot\right)=d^{c} \mu_{\varphi}^{j}$ for the last equality. We continue the computation

$$
\begin{aligned}
\Delta_{\varphi} \mathrm{v}\left(\mu_{\varphi}\right) & =\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}-\mathrm{v}_{, i j}\left(\mu_{\varphi}\right) \Lambda_{\varphi}\left(g_{\varphi}\left(J \xi_{i}, \cdot\right) \wedge g_{\varphi}\left(\xi_{j}, \cdot\right)\right) \\
& =\sum_{i, j=1}^{r}\left(\mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}-\mathrm{v}_{, i j}\left(\mu_{\varphi}\right) \sum_{k=1}^{2 n} g_{\varphi}\left(J \xi_{i}, e_{k}\right) g_{\varphi}\left(\xi_{j}, J e_{k}\right)\right) \\
& =\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}+\mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)
\end{aligned}
$$

where $\left(e_{k}\right)_{k=1}^{2 n}$ is a local orthonormal frame w.r.t. $g_{\varphi}$. We showed

$$
\begin{equation*}
-\Delta_{\varphi} \mathrm{v}\left(\mu_{\varphi}\right)=-\sum_{i, j=1}^{r} \mathrm{v}, i\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}-\mathrm{v}, i j\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right) \tag{9}
\end{equation*}
$$

For later purposes, let us observe that the first 4th lines of the above computation give

$$
\begin{align*}
\Delta_{0} \mathrm{v}\left(\mu_{\varphi}\right) & =\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{\varphi}^{i}+\mathrm{v}_{, i j}\left(\mu_{\varphi}\right) \Lambda_{0}\left(d \mu_{\varphi}^{i} \wedge d^{c} \mu_{\varphi}^{j}\right) \\
& =\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{\varphi}^{i}+\mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{0}\left(d \mu_{\varphi}^{i}, d \mu_{\varphi}^{j}\right) \tag{10}
\end{align*}
$$

where the last identity follows from a general fact, i.e. that for smooth functions $f_{1}, f_{2}$,

$$
\begin{equation*}
g_{0}\left(d f_{1}, d f_{2}\right)=\Lambda_{0}\left(d f_{1} \wedge d^{c} f_{2}\right) \tag{11}
\end{equation*}
$$

Lemma 3.1. The scalar curvature has the alternative expression

$$
\begin{align*}
\operatorname{Scal}\left(\omega_{\varphi}\right)= & 2 \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)-\Delta_{\varphi} F+\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}+\mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right)  \tag{12}\\
& -\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)^{2}}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}_{, j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right)
\end{align*}
$$

where $F:=\log \left(\mathrm{v}\left(\mu_{\varphi}\right) \frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)$.
Proof. By definition

$$
\begin{equation*}
\operatorname{Scal}\left(\omega_{\varphi}\right)=2 \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)-\Delta_{\varphi} \log \frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}} \tag{13}
\end{equation*}
$$

Observe that there is a factor 2 since, with our notations the scalar curvature is twice the trace. Also, by definition of $F$

$$
\Delta_{\varphi} \log \frac{\omega^{n}}{\omega_{0}^{n}}=\Delta_{\varphi} F-\Delta_{\varphi} \log \mathrm{v}\left(\mu_{\varphi}\right)
$$

We develop

$$
\begin{aligned}
\Delta_{\varphi} \log \mathrm{v}\left(\mu_{\varphi}\right) & =\Lambda_{\varphi} d d^{c} \log \mathrm{v}\left(\mu_{\varphi}\right) \\
& =\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \Delta_{\varphi} \mathrm{v}\left(\mu_{\varphi}\right)-\Lambda_{\varphi}\left(\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)^{2}} d \mathrm{v}\left(\mu_{\varphi}\right) \wedge d^{c} \mathrm{v}\left(\mu_{\varphi}\right)\right) \\
& =\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \Delta_{\varphi} \mathrm{v}\left(\mu_{\varphi}\right)-\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)^{2}} \Lambda_{\varphi}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}_{, j}\left(\mu_{\varphi}\right) d \mu_{\varphi}^{i} \wedge d^{c} \mu_{\varphi}^{j}\right) \\
& =\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \Delta_{\varphi} \mathrm{v}\left(\mu_{\varphi}\right)-\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)^{2}}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}, j\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right) .
\end{aligned}
$$

The last equality follows from the same computation as in (8). Then, using (9),

$$
\begin{aligned}
\Delta_{\varphi} \log \frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}= & \Delta_{\varphi} F-\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \Delta_{\varphi} \mathrm{v}\left(\mu_{\varphi}\right)+\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)^{2}}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}_{, j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right) \\
= & \Delta_{\varphi} F-\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}+\mathrm{v}, i j\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right) \\
& +\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)^{2}}\left(\sum_{i, j} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}, j\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right) .
\end{aligned}
$$

Injecting in (13), we get the result.
Lemma 3.2. The weighted scalar curvature has the alternative expression

$$
\operatorname{Scal}_{\mathrm{v}}\left(\omega_{\varphi}\right)=2 \mathrm{v}\left(\mu_{\varphi}\right) \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}_{\mathrm{v}}\left(\omega_{\varphi}\right)\right)
$$

where $\Lambda_{\varphi, \mathrm{v}}$ is defined in (54) and $\operatorname{Ric}_{\mathrm{v}}$ is the v -weighted Ricci from, defined in (21).
Proof. We first re-write the term $\sum_{i=1}^{r} \mathrm{v}_{\mathrm{v}}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}$. Let $\xi_{j} \in \mathfrak{t}$. Then

$$
\begin{align*}
d^{c} F\left(\xi_{j}\right) & =\frac{d^{c} \mathrm{v}\left(\mu_{\varphi}\right)\left(\xi_{j}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+d^{c} \log \left(\frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)\left(\xi_{j}\right) \\
& =\frac{\sum_{i=1}^{r} \mathrm{v}, i\left(\mu_{\varphi}\right) d^{c} \mu_{\varphi}^{i}\left(\xi_{j}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+d^{c} \log \left(\frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)\left(\xi_{j}\right)  \tag{14}\\
& =\frac{\sum_{i=1}^{r} \mathrm{v}, i\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+d^{c} \log \left(\frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)\left(\xi_{j}\right) .
\end{align*}
$$

Also, using Cartan's formula and the fact that $\left.\xi_{j}\right\lrcorner \omega_{\varphi}=-d \mu_{\varphi}^{j}$ we deduce $\mathcal{L}_{J \xi_{j}} \omega_{\varphi}=-d d^{c} \mu_{\varphi}^{j}$, where $\mathcal{L}_{J \xi_{j}}$ denotes the Lie derivative in the direction $J \xi_{j}$. And the same holds for $\omega_{0}$. It follows from arguments in the proof of [25, Lemma 5]

$$
\begin{equation*}
d^{c} \log \left(\frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)\left(\xi_{j}\right)=\Delta_{\varphi} \mu_{\varphi}^{j}-\Delta_{0} \mu_{0}^{j} \tag{15}
\end{equation*}
$$

Multiplying (15) by $\mathrm{v}_{, j}\left(\mu_{\varphi}\right)$, summing over $j=1, \cdots, r$ and using (14) we obtain

$$
\begin{align*}
\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{j} & =\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}+\mathrm{v}_{, j}\left(\mu_{\varphi}\right) d^{c} \log \left(\frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)\left(\xi_{j}\right) \\
& =\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}+\mathrm{v}_{, j}\left(\mu_{\varphi}\right) d^{c} F\left(\xi_{j}\right)-\sum_{i, j=1}^{r} \frac{\mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}_{, j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)} \tag{16}
\end{align*}
$$

Injecting in (12), we find
$\operatorname{Scal}\left(\omega_{\varphi}\right)=2 \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)-\Delta_{\varphi} F+\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{i, j=1}^{r} \mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)$

$$
-\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)^{2}}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}_{, j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right)
$$

$$
+\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)}\left(\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}+\mathrm{v}_{, j}\left(\mu_{\varphi}\right) d^{c} F\left(\xi_{j}\right)-\sum_{i, j=1}^{r} \frac{\mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}_{, j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}\right)
$$

$$
\begin{align*}
= & 2 \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)-\Delta_{\varphi} F-\frac{2}{\mathrm{v}\left(\mu_{\varphi}\right)^{2}}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}_{, j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right)  \tag{17}\\
& +\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)}\left(\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}+\mathrm{v}_{, j}\left(\mu_{\varphi}\right) d^{c} F\left(\xi_{j}\right)+\sum_{i, j=1}^{r} \mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right)
\end{align*}
$$

We conclude by injecting (9) and (17) in (7):

$$
\begin{aligned}
\operatorname{Scal}_{\mathrm{v}}\left(\omega_{\varphi}\right)= & 2 \mathrm{v}\left(\mu_{\varphi}\right) \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)-\mathrm{v}\left(\mu_{\varphi}\right) \Delta_{\varphi} F+\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}+\mathrm{v}_{, j}\left(\mu_{\varphi}\right) d^{c} F\left(\xi_{j}\right) \\
& +\sum_{i, j=1}^{r} \mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)-\frac{2}{\mathrm{v}\left(\mu_{\varphi}\right)}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}, j\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right) \\
& -2 \sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}-2 \sum_{i, j=1}^{r} \mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)+\sum_{i, j=1}^{r} \mathrm{v}_{, i j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right) \\
= & 2 \mathrm{v}\left(\mu_{\varphi}\right) \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)-\mathrm{v}\left(\mu_{\varphi}\right) \Delta_{\varphi} F+\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}+\mathrm{v}_{, j}\left(\mu_{\varphi}\right) d^{c} F\left(\xi_{j}\right) \\
& -2 \sum_{i=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \Delta_{\varphi} \mu_{\varphi}^{i}-\frac{2}{\mathrm{v}\left(\mu_{\varphi}\right)}\left(\sum_{i, j=1}^{r} \mathrm{v}_{, i}\left(\mu_{\varphi}\right) \mathrm{v}_{, j}\left(\mu_{\varphi}\right) g_{\varphi}\left(\xi_{i}, \xi_{j}\right)\right) \\
= & \mathrm{v}\left(\mu_{\varphi}\right) 2 \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)-\mathrm{v}\left(\mu_{\varphi}\right) \Delta_{\varphi} F-\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) d^{c} F\left(\xi_{j}\right)-\mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j} \\
= & \mathrm{v}\left(\mu_{\varphi}\right) 2 \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)+d^{*}\left(\mathrm{v}\left(\mu_{\varphi}\right) d F\right)-\sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j} \\
= & \mathrm{v}\left(\mu_{\varphi}\right)\left(-\Delta_{\varphi, \mathrm{v}} F+2 \Lambda_{\varphi, \mathrm{v}} \operatorname{Ric}\left(\omega_{0}\right)\right) \\
= & 2 \mathrm{v}\left(\mu_{\varphi}\right) \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{\varphi}\right)\right),
\end{aligned}
$$

where in the third equality we used (16). In the last line we use (56) for the expression of $\Lambda_{\varphi, \mathrm{v}} \operatorname{Ric}\left(\omega_{0}\right)$, the definition of the v-weighted Laplacian in (53) and that $\Delta_{\varphi, \mathrm{v}} f=\Lambda_{\varphi, \mathrm{v}} d d^{c} f$ (see Appendix A.1).

We then conclude this section:
Proposition 3.3. A $\mathbb{T}$-invariant Kähler metric is a weighted cscK metric if and only if it is solution of the following system of elliptic PDEs

$$
\begin{cases}F & =\log \left(\mathrm{v}\left(\mu_{\varphi}\right) \frac{\omega_{\varphi}^{n}}{\omega_{0}^{n}}\right)  \tag{18}\\ \Delta_{\varphi, \mathrm{v}} F & =-\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)\end{cases}
$$

where $\Delta_{\varphi, \mathrm{v}}$ and $\Lambda_{\varphi, \mathrm{v}}$ are introduced in Appendix A.
Proof. From the end of the proof of Lemma 3.2 we have that $\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \operatorname{Scal}_{\mathrm{v}}\left(\omega_{\varphi}\right)=-\Delta_{\varphi, \mathrm{v}} F+$ $2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)$. Then $\operatorname{Scal}_{\mathrm{v}}\left(\omega_{\varphi}\right)=\mathrm{w}\left(\mu_{\varphi}\right)$ if and only if the second equation in (18) is satisfied.

## 4. $\mathcal{C}^{0}$-estimates

The goal of this section is to prove a priori $C^{0}$-estimates for $\varphi$ and $F$, solutions of (18) where $\varphi$ is normalized such that $\sup _{X} \varphi=0$.

First, observe that since $P$ is compact and v, w are smooth, there exist positive constants $\eta, L, \nu, M$ such that

$$
\begin{gather*}
0<\eta \leq \mathrm{v} \leq L<+\infty, \quad-\nu \leq \mathrm{w} \leq M \\
-\eta \leq \mathrm{v}, j \leq L<+\infty, \quad-\nu \leq \mathrm{w}, j \leq M . \tag{19}
\end{gather*}
$$

Let $\psi$ be the unique solution of the Monge-Ampère equation

$$
\omega_{\psi}^{[n]}=b^{-1} \sqrt{F^{2}+1} \omega_{\varphi}^{[n]}, \quad \sup _{X} \psi=0,
$$

$b:=\int_{X} \sqrt{F^{2}+1} \omega_{\varphi}^{[n]}$. We normalize $\omega_{0}$ such that

$$
\begin{equation*}
\int_{X} \omega_{0}^{[n]}=1, \tag{20}
\end{equation*}
$$

where we recall that $\omega_{0}^{[k]}:=\frac{\omega_{0}^{k}}{k!}$, for $1 \leq k \leq n$. Observe that, since $F^{2}+1 \leq 2 F^{2}$ on $\{F \geq 1\}$,

$$
\begin{aligned}
0<b & =\int_{\{F<1\}} \mathrm{v}\left(\mu_{\varphi}\right)^{-1} e^{F} \sqrt{F^{2}+1} \omega_{0}^{[n]}+\int_{\{F \geq 1\}} \mathrm{v}\left(\mu_{\varphi}\right)^{-1} e^{F} \sqrt{F^{2}+1} \omega_{0}^{[n]} \\
& \leq \sqrt{2} \eta^{-1}\left(e+\operatorname{Ent}_{\mathrm{v}}(\varphi)\right)
\end{aligned}
$$

where $\operatorname{Ent}_{\mathrm{v}}(\varphi):=\int_{X} \log \left(\frac{\mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{n}}{\omega_{0}^{n}}\right) \mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]}$ denotes the weighted entropy.
We observe that the latter is comparable to the classical entropy $\operatorname{Ent}(\varphi):=\operatorname{Ent}_{1}(\varphi)$ :
Lemma 4.1. For any weight $\mathrm{v}>0$, the weighted entropy Ent $_{\mathrm{v}}$ is bounded if and only if the entropy Ent is:

$$
\operatorname{Ent}_{\mathrm{v}}(\varphi)<\infty \Leftrightarrow \operatorname{Ent}(\varphi)<\infty,
$$

for any $\varphi \in \mathcal{K}\left(X, \omega_{0}\right)^{\mathbb{T}}$.
Proof. Suppose first that the entropy $\operatorname{Ent}(\varphi)$ is bounded. For simplicity, we write $g:=\mathrm{e}^{F}$ and $f:=\frac{g}{\mathrm{v}\left(\mu_{\varphi}\right)}$. Then $g=\frac{\mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]}}{\omega_{0}^{[n]}}$. We compute

$$
\begin{aligned}
\operatorname{Ent}_{\mathrm{v}}(\varphi) & =\int_{X} g \log g \omega_{0}^{[n]}=\int_{X} \mathrm{v}\left(\mu_{\varphi}\right) f \log \left(\mathrm{v}\left(\mu_{\varphi}\right) f\right) \omega_{0}^{[n]} \\
& \leq L\left(\int_{X} f \log f \omega_{0}^{[n]}+\log L \int_{X} f \omega_{0}^{[n]}\right) \\
& =L \operatorname{Ent}(\varphi)+L \int_{X} \omega_{\varphi}^{[n]} \\
& =L \operatorname{Ent}(\varphi)+L \log L,
\end{aligned}
$$

where we use (20) to pass to the last line and $L$ is defined in (19). The converse is obtain via similar computations.

Therefore, if $\operatorname{Ent}(\varphi)$ is uniformly bounded, so is $b$.
Let $A_{0}>0$ such that $-A_{0} \omega_{0} \leq \operatorname{Ric}\left(\omega_{0}\right) \leq A_{0} \omega_{0}$. We start with the following key observation:

$$
\begin{align*}
\left|\Lambda_{\mathrm{v}, \varphi} \operatorname{Ric}\left(\omega_{0}\right)\right| & =\left|\Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)-\frac{1}{2 \mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}\right| \\
& \leq A_{0} \Lambda_{\varphi}\left(\omega_{0}\right)+\sup _{X}\left|\frac{1}{2 \mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}\right|  \tag{21}\\
& \leq A_{0} \Lambda_{\varphi}\left(\omega_{0}\right)+C .
\end{align*}
$$

It is important to note that the constant $C$ above does not depend on $\varphi$ by (19). Following [16] we show:

Theorem 4.2. Given $\varepsilon \in(0,1)$, there exists $C=C\left(\varepsilon, n, \omega_{0}, P, \mathrm{w}, \mathrm{v}, b\right)$ such that

$$
F+\varepsilon \psi-A \varphi \leq C
$$

where $A>0$ is a uniform constant depending only on the lower bound of the Ricci curvature.

Proof. We let $H:=F+\varepsilon \psi-A \varphi$ with $A=2 A_{0}+1$.
Then

$$
\begin{aligned}
\Delta_{\varphi, \mathrm{v}} H= & \Delta_{\varphi, \mathrm{v}} F+\varepsilon \Delta_{\varphi, \mathrm{v}} \psi-A \Delta_{\varphi, \mathrm{v}} \varphi \\
= & -\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}} \operatorname{Ric}\left(\omega_{0}\right)+\varepsilon \Delta_{\varphi} \psi-A \Delta_{\varphi} \varphi \\
& +\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right)\left(\varepsilon d^{c}(\psi)\left(\xi_{j}\right)-A d^{c} \varphi\left(\xi_{j}\right)\right) \\
= & -\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}} \operatorname{Ric}\left(\omega_{0}\right)+\varepsilon \frac{d d^{c} \psi \wedge \omega_{\varphi}^{[n-1]}}{\omega_{\varphi}^{[n]}}-A \frac{d d^{c} \varphi \wedge \omega_{\varphi}^{[n-1]}}{\omega_{\varphi}^{[n]}} \\
& +\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}, j\left(\mu_{\varphi}\right)\left(\varepsilon d^{c} \psi\left(\xi_{j}\right)-A d^{c} \varphi\left(\xi_{j}\right)\right) \\
\geq & -\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}-2 A_{0} \Lambda_{\varphi}\left(\omega_{0}\right)-C+\varepsilon \frac{d d^{c} \psi \wedge \omega_{\varphi}^{[n-1]}}{\omega_{\varphi}^{[n]}}-A \frac{d d^{c} \varphi \wedge \omega_{\varphi}^{[n-1]}}{\omega_{\varphi}^{[n]}} \\
& +\sum_{j=1}^{r} \frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \mathrm{v}_{, j}\left(\mu_{\varphi}\right)\left(\varepsilon d^{c} \psi\left(\xi_{j}\right)-A d^{c} \varphi\left(\xi_{j}\right)\right) .
\end{aligned}
$$

For the inequality, we use (21). We continue the computation

$$
\begin{aligned}
\Delta_{\varphi, \mathrm{v}} H \geq & -\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}-2 A_{0} \Lambda_{\varphi}\left(\omega_{0}\right)-C+\varepsilon \frac{\left(\omega_{\psi}-\omega_{0}\right) \wedge \omega_{\varphi}^{[n-1]}}{\omega_{\varphi}^{[n]}} \\
& -A \frac{\left(\omega_{\varphi}-\omega_{0}\right) \wedge \omega_{\varphi}^{[n-1]}}{\omega_{\varphi}^{[n]}}+\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right)\left(\varepsilon d^{c} \psi\left(\xi_{j}\right)-A d^{c} \varphi\left(\xi_{j}\right)\right) \\
\geq & -\frac{M}{L}-A n-C+\left(A-2 A_{0}-\varepsilon\right) \Lambda_{\varphi}\left(\omega_{0}\right)+\varepsilon \frac{\omega_{\psi} \wedge \omega_{\varphi}^{[n-1]}}{\omega_{\varphi}^{[n]}} \\
& +\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right)\left(\varepsilon d^{c} \psi\left(\xi_{j}\right)-A d^{c} \varphi\left(\xi_{j}\right)\right) \\
\geqslant & -C_{1}+n b^{-1 / n} \varepsilon\left(F^{2}+1\right)^{\frac{1}{2 n}}+\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right)\left(\varepsilon\left(\mu_{\psi}^{j}-\mu_{0}^{j}\right)-A\left(\mu_{\varphi}^{j}-\mu_{0}^{j}\right)\right) \\
\geqslant & -C_{1}+C_{2}+n b^{-1 / n} \varepsilon\left(F^{2}+1\right)^{\frac{1}{2 n}}
\end{aligned}
$$

where $C_{1}$ depends on (21), $C_{2}:=\inf _{X} \sum_{j=1}^{r} \frac{\mathrm{v}, j\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}\left(\varepsilon\left(\mu_{\psi}^{j}-\mu_{0}^{j}\right)-A\left(\mu_{\varphi}^{j}-\mu_{0}^{j}\right)\right)$. Observe that the constant $C_{2}$ is indeed independent of $\varphi$ and $\psi$ since the image of $\mu_{\varphi}$ is the moment polytope $P$ for any $\mathbb{T}$-invariant Kähler potential in $\left[\omega_{0}\right]$ (see the introduction and [25, Lemma 1] for details).

From the second inequality to the third, we use the mixed Monge-Ampère inequality (see [9, Proposition 1.11]) ensuring that $\omega_{\psi} \wedge \omega_{\varphi}^{n-1} \geq b^{-1 / n}\left(\sqrt{F^{2}+1}\right)^{1 / n} \omega_{\varphi}^{n}$. We also used that the moment map $\mu_{\varphi}$ of a Kähler potential $\varphi$ satisfies $\mu_{\varphi}^{j}=\mu_{0}^{j}-d^{c} \varphi\left(\xi^{j}\right)$ for any $\xi^{j} \in \mathfrak{t}$.

By the maximum principle, applied to $H$, we can then infer that at a maximum point $x_{0}$ we have

$$
n b^{-1 / n} \varepsilon\left(F^{2}+1\right)^{1 / 2 n}\left(x_{0}\right) \leq C .
$$

Thus $F\left(x_{0}\right) \leq C_{0}, C_{0}=C_{0}\left(\varepsilon, A_{0}, \omega_{0}, b, \mathrm{v}, \mathrm{w}\right)$.
We then claim that

$$
\varepsilon \psi-A \varphi \leq C_{3},
$$

where $C_{3}>0$ depends on $\varepsilon, A$ and $b$. Let us now prove the claim. First of all we observe that, for any $a, \delta \in(0,1)$ we have either $\sqrt{F^{2}+1} \geq b /\left(a \delta^{n}\right)$ or $F \leq \sqrt{F^{2}+1} \leq b /\left(a \delta^{n}\right)$; thus

$$
\begin{aligned}
\omega_{\varphi}^{n} & =\mathrm{v}\left(\mu_{\varphi}\right) e^{F} \omega_{0}^{n} \leq L a \delta^{n} b^{-1} e^{F} \sqrt{F^{2}+1} \omega_{0}^{n}+L e^{\frac{b}{a \delta^{n}}} \omega_{0}^{n} \\
& =L a \delta^{n} \omega_{\psi}^{n}+L e^{\frac{b}{\delta^{n}}} \omega_{0}^{n} \\
& \leq L a \omega_{\delta \psi}^{n}+L e^{\frac{b}{a \delta^{n}}} \omega_{0}^{n} .
\end{aligned}
$$

We are going to apply Theorem 2.3 with $u=\varphi, \chi=\delta \psi$ and $f=L e^{b /\left(a \delta^{n}\right)}$. In fact, we have that $e^{b /\left(a \delta^{n}\right)} \in L^{p}$, for any $p \geq 1$ and, since $\int_{X} \omega_{\varphi}^{[n]}=1$, [13, Theorem 1.3] implies that $P[\varphi]=0 \geq \delta \psi$. In particular $P[\varphi]$ is less singular than $\delta \psi$. Moreover, the assumption in (6) is satisfied. Indeed, for any Borel set $E \subset X$

$$
\int_{E} f \omega_{0}^{n}=L e^{\frac{b}{a \delta^{n}}} \operatorname{Vol}_{\omega_{0}}(E) \leq L e^{\frac{b}{a \delta \delta^{n}}} \exp \left(\frac{-C_{4}}{\operatorname{Cap}_{\omega_{0}}(E)^{1 / n}}\right) \leq L e^{\frac{b}{a \delta^{n}}} C_{4} \operatorname{Cap}_{\omega_{0}}(E)^{2} .
$$

The inequality

$$
\operatorname{Vol}_{\omega_{0}}(E) \leq \exp \left(\frac{-C_{4}}{\operatorname{Cap}_{\omega_{0}}(E)^{1 / n}}\right)
$$

where $C_{4}>0$ depends on $n$ and $\omega_{0}$, follows from [18, eq. (12.1.3) and Lemma 12.2] (see also [14, Proposition 2.10]). Using that $\mathrm{Cap}_{\omega_{0}} \leq(1-\delta)^{-n} \mathrm{Cap}_{(1-\delta) \omega}$ and that $\mathrm{Cap}_{(1-\delta) \omega} \leq \mathrm{Cap}_{\delta \psi}$ (see [26, Lemma 2.7]) we get that

$$
\int_{E} f \omega_{0}^{n} \leq C_{4}(1-\delta)^{-2 n} \operatorname{Cap}_{\delta \psi}(E)^{2}
$$

We can then infer that $\varphi \geq \delta \psi-C_{4}\left((1-a)^{-1}, e^{b / a \delta^{n}},(1-\delta)^{-2 n}\right)$. Choosing $\delta$ small enough so that $\varepsilon-A \delta \geq 0$ we obtain the claim with $C_{3}=A C_{4}$.

It then follows that for any $x \in X$

$$
H(x) \leq H\left(x_{0}\right) \leq C_{0}+C_{3},
$$

which concludes the proof.
Corollary 4.3. The functions $\psi, \varphi, F$ are uniformly bounded by a constant that only depends on $n, \omega_{0}$, v, w and $\operatorname{Ent}(\varphi)$.

Proof. From Theorem 4.2 we know that $F \leq C-\varepsilon \psi+A \varphi \leq C-\varepsilon \psi$, since $\sup _{X} \varphi=0$. Therefore

$$
\int_{X} e^{2 F} \omega_{0}^{n} \leq \tilde{C} \int_{X} e^{-2 \varepsilon \psi} \omega_{0}^{n}
$$

Choosing $\varepsilon<\nu_{\omega_{0}}^{-1}$, by Theorem 2.1 we get a uniform bound for $\left\|e^{F}\right\|_{L^{2}}$. It follows from Kołodziej uniform estimates (Theorem (2.2), applied to the equation $\omega_{\varphi}^{n}=\frac{1}{v\left(\mu_{\varphi}\right)} e^{F} \omega_{0}^{n}$, that $\varphi \geq-C\left(\mathrm{v},\left\|e^{F}\right\|_{L^{2}}, \omega_{0}\right)$. In particular, $\operatorname{since}^{\sup } \sup _{X} \varphi=0$ we do get a uniform control on $\|\varphi\|_{L^{\infty}}$. Also,

$$
\int_{X} e^{2 F}\left(F^{2}+1\right) \omega_{0}^{n} \leq \int_{X} e^{4 F} \omega_{0}^{n} \leq C^{\prime} \int_{X} e^{-4 \varepsilon \psi} \omega_{0}^{n}
$$

Once again, thanks to Theorem [2.1, choosing $\varepsilon \leq\left(2 \nu_{\omega_{0}}\right)^{-1}$ we get a uniform bound for $\left\|e^{F} \sqrt{F^{2}+1}\right\|_{L^{2}}$. Theorem 2.2 then gives a uniform control for $\|\psi\|_{L^{\infty}}$.
We can then conclude from Theorem 4.2 together with the arguments above that

$$
F \leq C-\varepsilon \psi+A \varphi \leq-\varepsilon \inf _{X} \psi \leq C_{4}
$$

for some uniform positive constant $C_{4}$.
It remains to prove a uniform lower bound for $F$. For this purpose we apply the minimum principle to $F+t \varphi$, with $t=2 A_{0}+1$ where we recall that $A_{0}>0$ is such that $\operatorname{Ric}\left(\omega_{0}\right) \leq A_{0} \omega_{0}$. Using Definition (56), Lemma A. 2 and (21), we find

\Delta_{\varphi, \mathrm{v}}(F+t \varphi) & =-\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)+t \Delta_{\varphi} \varphi+\frac{t}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) d^{c} \varphi\left(\xi_{j}\right) \\
& \leq-\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)+\tilde{C}+t\left(n-\Lambda_{\varphi}\left(\omega_{0}\right)\right)+\frac{t}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right)\left(\mu_{\varphi}^{j}-\mu_{0}^{j}\right) \\
& \leq \frac{\nu}{\eta}+t n+\left(2 A_{0}-t\right) \Lambda_{\varphi}\left(\omega_{0}\right)+\tilde{C}+\frac{t}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right)\left(\mu_{\varphi}^{j}-\mu_{0}^{j}\right) \\
& \leq C-\Lambda_{\varphi}\left(\omega_{0}\right) \\
& \leq C-\eta^{\frac{1}{n}} n e^{-F / n}
\end{aligned}
$$

where $C=\sup _{X} \frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)}\left(t \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right)\left(\mu_{\varphi}^{j}-\mu_{0}^{j}\right)\right)+\nu+t n+\tilde{C}$. It is worth to note again that the constant $C$ is indeed independent of $\varphi$ since the image of $\mu_{\varphi}$ is the moment polytope $P$ for any $\mathbb{T}$-invariant Kähler potential in $\varphi \in \mathcal{K}\left(X, \omega_{0}\right)^{\mathbb{T}}$.
The last inequality follows from the fact that, given two positive ( 1,1 )-forms $\alpha, \beta$ we have $\Lambda_{\beta}(\alpha) \geq n\left(\frac{\alpha^{n}}{\beta^{n}}\right)^{1 / n}$. In particular

$$
\begin{equation*}
\Lambda_{\varphi}\left(\omega_{0}\right) \geq n \mathrm{v}\left(\mu_{\varphi}\right)^{1 / n} e^{-F / n} \tag{22}
\end{equation*}
$$

Now, let $x_{0}$ be a minimum point of the function $F+t \varphi$, then $0 \leq C-\eta^{\frac{1}{n}} n e^{-F\left(x_{0}\right) / n}$, or equivalently $F\left(x_{0}\right) \geq-n \log \left(C \eta^{-\frac{1}{n}} / n\right)$. For any $x \in X, F(x)+t \varphi(x) \geq F\left(x_{0}\right)+t \varphi\left(x_{0}\right)$, hence $F \geq-n \log \left(C \eta^{-\frac{1}{n}} / n\right)-t\|\varphi\|_{L^{\infty}}$.

## 5. Integral $C^{2}$-estimates

The goal is this section is to show the theorem below.
Theorem 5.1. Let $\varphi$ be a solution of (18). Then for any $p \geq 1$; there exists a constant $C>0$, depending on $p, n, \mathrm{v},\|\varphi\|_{C^{0}},\|F\|_{C^{0}}$, an upper bound on the Ricci form of $\omega_{0}$ and a lower bound of the holomorphic bisectional curvature of $\omega_{0}$ so that

$$
\left\|\Lambda_{0}\left(\omega_{\varphi}\right)\right\|_{L^{p}} \leq C
$$

We start with some lemmas which will be useful in the following.
Lemma 5.2. Let $\varphi$ be solution of (18). Then

$$
\begin{equation*}
\Lambda_{0}\left(\omega_{\varphi}\right) \leq C \Lambda_{\varphi}\left(\omega_{0}\right)^{n-1}, \quad \Lambda_{\varphi}\left(\omega_{0}\right) \leq C \Lambda_{0}\left(\omega_{\varphi}\right)^{n-1} \tag{23}
\end{equation*}
$$

where $C$ is a positive constant depending on $\|F\|_{C^{0}}$, v and n. Moreover,

$$
\begin{equation*}
\Lambda_{0}\left(\omega_{\varphi}\right) C_{1} \geq 1 \quad \Lambda_{\varphi}\left(\omega_{0}\right) C_{2} \geq 1 \tag{24}
\end{equation*}
$$

for positive constants $C_{1}, C_{2}$ depending on $\|F\|_{C^{0}}$, v, and $n$.
Proof. Recall that for any smooth $(1,1)$-form $\alpha, \beta$

$$
n\left(\frac{\alpha^{n}}{\beta^{n}}\right)^{1 / n} \leq \Lambda_{\beta}(\alpha) \leq n \frac{\alpha^{n}}{\beta^{n}} \Lambda_{\alpha}(\beta)^{n-1}
$$

By (18) and the second inequality above, we infer

$$
\Lambda_{0}\left(\omega_{\varphi}\right) \leq n \frac{e^{F}}{\mathrm{v}\left(\mu_{\varphi}\right)} \Lambda_{\varphi}\left(\omega_{0}\right)^{n-1} .
$$

Similarly $\Lambda_{\varphi}\left(\omega_{0}\right) \leq n \mathrm{v}\left(\mu_{\varphi}\right) e^{-F} \Lambda_{0}\left(\omega_{\varphi}\right)^{n-1}$.
On the other side, $\Lambda_{0}\left(\omega_{\varphi}\right) \geq n\left(\frac{e^{F}}{\mathrm{v}\left(\mu_{\varphi}\right)}\right)^{1 / n}$ and $\Lambda_{\varphi}\left(\omega_{0}\right) \geq n\left(\mathrm{v}\left(\mu_{\varphi}\right) e^{-F}\right)^{1 / n}$.
The following lemma is well-known; however, as it will be used very often, we give a statement below without proof.
Lemma 5.3. Let $S$ be a covariant 2 -tensor $S$ and $f_{1}, f_{2}$ two smooth functions on $X$. Then

$$
g_{\varphi}\left(d f_{1}, g_{\varphi}\left(S, d f_{2}\right)\right)=S\left(\nabla^{\varphi} f_{1}, \nabla^{\varphi} f_{2}\right)
$$

and

$$
\begin{equation*}
g_{\varphi}\left(S, d f_{1} \otimes d f_{2}\right)=S\left(\nabla^{\varphi} f_{1}, \nabla^{\varphi} f_{2}\right) \tag{25}
\end{equation*}
$$

In particular, when $S=\nabla^{\varphi} d h$, for some smooth function $h: X \rightarrow \mathbb{R}$ we have

$$
g_{\varphi}\left(d f_{1}, g_{\varphi}\left(\nabla^{\varphi} d h, d f_{2}\right)\right)=\nabla^{\varphi} d h\left(\nabla^{\varphi} f_{1}, \nabla^{\varphi} f_{2}\right)
$$

Let us stress that $g_{\varphi}\left(S, d f_{2}\right)$ has to be understood as the 1-form: $V \rightarrow g_{\varphi}\left(S(V, \cdot), d f_{2}\right)$.
Lemma 5.4. For any smooth $(1,1)$-form $\beta$ we have the following identities between 1-forms

$$
\begin{equation*}
d \Lambda_{\varphi}(\beta)=\Lambda_{\varphi}(\mathcal{L} . \beta)-g_{\varphi}\left(\beta, \mathcal{L} . \omega_{\varphi}\right), \quad d^{c} \Lambda_{\varphi}(\beta)=-\Lambda_{\varphi}\left(\mathcal{L}_{J} \cdot \beta\right)+g_{\varphi}\left(\beta, \mathcal{L}_{J .} \omega_{\varphi}\right), \tag{26}
\end{equation*}
$$

where $g_{\varphi}\left(\beta, \mathcal{L} . \omega_{\varphi}\right)$ is the 1 -form defined as $V \rightarrow g_{\varphi}\left(\beta, \mathcal{L}_{V} \omega_{\varphi}\right)$ and $\Lambda_{\varphi}(\mathcal{L} . \beta)$ is the 1 -form defined as $V \rightarrow \Lambda_{\varphi}\left(\mathcal{L}_{V} \beta\right)$.
Proof. By definition of the trace

$$
\begin{equation*}
\beta \wedge \omega_{\varphi}^{[n-1]}=\Lambda_{\varphi}(\beta) \omega_{\varphi}^{[n]} . \tag{27}
\end{equation*}
$$

Let $V$ be a vector field. Differentiating the LHS of the above inequality in the direction $V$ we obtain

$$
\begin{aligned}
\mathcal{L}_{V}\left(\beta \wedge \omega_{\varphi}^{[n-1]}\right) & =\mathcal{L}_{V}(\beta) \wedge \omega_{\varphi}^{[n-1]}+\beta \wedge \mathcal{L}_{V}\left(\omega_{\varphi}\right) \wedge \omega_{\varphi}^{[n-2]} \\
& =\Lambda_{\varphi}\left(\mathcal{L}_{V}(\beta)\right) \omega_{\varphi}^{[n]}+\beta \wedge \mathcal{L}_{V}\left(\omega_{\varphi}\right) \wedge \omega_{\varphi}^{[n-2]}
\end{aligned}
$$

Differentiating (27) and rearranging the terms, we get

$$
\begin{aligned}
\mathcal{L}_{V}\left(\Lambda_{\varphi}(\beta)\right) \omega_{\varphi}^{[n]} & =\Lambda_{\varphi}\left(\mathcal{L}_{V}(\beta)\right) \omega_{\varphi}^{[n]}+\beta \wedge \mathcal{L}_{V}\left(\omega_{\varphi}\right) \wedge \omega_{\varphi}^{[n-2]}-\Lambda_{\varphi}(\beta) \mathcal{L}_{V}\left(\omega_{\varphi}\right) \wedge \omega_{\varphi}^{[n-1]} \\
& =\Lambda_{\varphi}\left(\mathcal{L}_{V}(\beta)\right) \omega_{\varphi}^{[n]}+\beta \wedge \mathcal{L}_{V}\left(\omega_{\varphi}\right) \wedge \omega_{\varphi}^{[n-2]}-\Lambda_{\varphi}(\beta) \Lambda_{\varphi}\left(\mathcal{L}_{V}\left(\omega_{\varphi}\right)\right) \omega_{\varphi}^{[n]} \\
& =\Lambda_{\varphi}\left(\mathcal{L}_{V}(\beta)\right) \omega_{\varphi}^{[n]}-g_{\varphi}\left(\beta, \mathcal{L}_{V} \omega_{\varphi}\right) \omega_{\varphi}^{[n]}
\end{aligned}
$$

where to pass to the last line we use the well know identity $\Lambda_{\varphi}(\beta) \Lambda_{\varphi}(\alpha) \omega_{\varphi}^{[n]}=g_{\varphi}(\beta, \alpha) \omega_{\varphi}^{[n]}+$ $\beta \wedge \alpha \wedge \omega_{\varphi}^{[n-2]}$ (see e.g. [17, eq. (1.12.5)]), for any (1,1)-form $\alpha, \beta$.
This conclude the proof of the first identity. The second one simply follows from the first one and the that $d^{c} f=-d f(J \cdot)$ for any smooth function $f$.

The following lemma is a generalization of Yau inequality [29, (2.10)] for $F$ solution of the weighted Monge-Ampère equation (18) and for the weighted Laplacian.

Lemma 5.5. The following holds true:

$$
\begin{equation*}
\Delta_{\varphi, \mathrm{v}} \Lambda_{0}\left(\omega_{\varphi}\right) \geq \Delta_{0} F-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J .} \cdot \omega_{\varphi}\right)\right)-C_{1} \Lambda_{0}\left(\omega_{\varphi}\right) \Lambda_{\varphi}\left(\omega_{0}\right)-C_{2} \tag{28}
\end{equation*}
$$

where $C_{1}>0$ depends on $\omega_{0},\|F\|_{C^{0}}, \mathrm{v}, n$ and $C_{2}>0$ on v and a lower bound for the holomorphic bisectional curvature of $\omega_{0}$.

In particular,

$$
\begin{equation*}

\end{equation*}
$$

In the above statement, $g_{\varphi}\left(\mathcal{L} . \omega_{\varphi}, \mathcal{L}_{J .} \omega_{\varphi}\right)$ is understood as the 2 -form $(V, W) \rightarrow g_{\varphi}\left(\mathcal{L}_{V} \omega_{\varphi}, \mathcal{L}_{J W} \omega_{\varphi}\right)$. Recall that in a orthonormal frame $\left(e_{k}\right)_{k=1}^{2 n}$ with respect to $\omega_{0}$ we have that $\Lambda_{0}(\beta)=\frac{1}{2} \sum_{k=1}^{2 n} \beta\left(e_{k}, J e_{k}\right)$, for any 2 -form $\beta$. Hence

Let us observe that in orthonormal frame $\left(e_{k}\right)_{k=1}^{2 n}$ w.r.t. $\omega_{0}$ we write $-\Lambda_{0}\left(\mathcal{L} . \mathcal{L} J . \omega_{0}\right)=$ $\frac{1}{2} \sum_{k=1}^{2 n} \mathcal{L}_{e_{k}} \mathcal{L}_{e_{k}} \omega_{0}$.
The second and the third equalities are due to the fact that by the computation in (15) we have

= & \Lambda_{\varphi}\left(g_{0}\left(\nabla^{0} \mathcal{L}_{J} \cdot \omega_{0}, \omega_{\varphi}\right)+g_{0}\left(\mathcal{L}_{J \cdot} \cdot \omega_{0}, \nabla^{0} \omega_{\varphi}\right)-\Lambda_{0}\left(\mathcal{L} \cdot \mathcal{L} \cdot \omega_{\varphi}\right)+g_{0}\left(\mathcal{L} \cdot \omega_{0}, \mathcal{L}_{J} \cdot \omega_{\varphi}\right)\right) \\
& +g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), \Lambda_{0}\left(\mathcal{L} \cdot \omega_{\varphi}\right)\right)-g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), g_{0}\left(\mathcal{L} \cdot \omega_{0}, \omega_{\varphi}\right)\right) .

Then, in normal coordinates with respect to $\omega_{0}\left(\right.$ where $\left.\nabla^{0}=\mathcal{L}\right)$ we have that

Observe that in a orthonormal frame $\left(e_{k}\right)_{k=1}^{2 n}$ with respect to $\omega_{0}$ we have

& =\frac{1}{4} \sum_{k, j=1}^{2 n} \frac{\mathcal{L}_{e_{k}} \mathcal{L}_{e_{k}} \omega_{\varphi}\left(e_{j}, J e_{j}\right)}{\omega_{\varphi}\left(e_{k}, J e_{k}\right)} \\

i.e. the two traces commute.

The second equality is due to the definition of $\Delta_{0, \mathrm{v}}$.

& -\Lambda_{0}\left(\Lambda_{0}\left(\mathcal{L} \cdot \mathcal{L}_{J} \cdot \omega_{0}\right)\right)-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J} \cdot \omega_{\varphi}\right)\right)

We bound $g_{0}\left(d \mu_{\varphi}^{i}, d \mu_{\varphi}^{j}\right)$ :

where the last inequality follows from (24) and $\left(e_{k}\right)_{k=1}^{2 n}$ is an orthonormal frame for $\omega_{0}$.
Also, locally, we have $-\Lambda_{0}\left(\Lambda_{0}\left(\mathcal{L} \cdot \mathcal{L}_{J .} \cdot \omega_{0}\right)\right)=\frac{1}{4} \sum_{k=1}^{2 n} \mathcal{L}_{e_{k}} \mathcal{L}_{e_{k}} \omega_{0}\left(e_{k}, J e_{k}\right)$ and is uniformly bounded by a constant $B$ depending only on the holormorphic bisectional curvature of $\omega_{0}$. For the last term, we use Cauchy-Schwarz inequality and (23)

We now present a generalization of [11, Lemma 2.2] to the weighted setting:

& =\frac{1}{4} \sum_{k, j=1}^{n} \frac{\left(\mathcal{L}_{e_{j}} \omega_{\varphi}\left(e_{k}, J e_{k}\right)\right)^{2}}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)} \\
& =\frac{1}{4} \sum_{i, j, k=1}^{n} \frac{\omega_{\varphi}\left(e_{i}, J e_{i}\right)\left(\mathcal{L}_{e_{j}} \omega_{\varphi}\left(e_{k}, J e_{k}\right)\right)^{2}}{\omega_{\varphi}\left(e_{i}, J e_{i}\right) \omega_{\varphi}\left(e_{j}, J e_{j}\right)} \\
& \leq \frac{1}{2} \sum_{p=1}^{n} \omega_{\varphi}\left(e_{p}, J e_{p}\right) \frac{1}{2} \sum_{i, j, k=1}^{n} \frac{\left(\mathcal{L}_{e_{j}} \omega_{\varphi}\left(e_{k}, J e_{k}\right)\right)^{2}}{\omega_{\varphi}\left(e_{j}, J e_{j}\right) \omega_{\varphi}\left(e_{i}, J e_{i}\right)} \\
& =\Lambda_{0}\left(\omega_{\varphi}\right) \frac{1}{2}\left(\sum_{k=1}^{n}\left|\mathcal{L}_{e_{k}} \omega_{\varphi}\right|_{\varphi}^{2}\right) .
\end{aligned}

\Delta_{\varphi, \mathrm{v}} \log \Lambda_{0}\left(\omega_{\varphi}\right) \geq & \frac{1}{\Lambda_{0}\left(\omega_{\varphi}\right)}\left(\Delta_{0} F+\frac{1}{2} \sum_{k=1}^{2 n}\left|\mathcal{L}_{e_{k}} \omega_{\varphi}\right|_{\varphi}^{2}-C_{1} \Lambda_{0}\left(\omega_{\varphi}\right) \Lambda_{\varphi}\left(\omega_{0}\right)-C_{2}\right) \\
& -\frac{1}{2 \Lambda_{0}\left(\omega_{\varphi}\right)}\left(\sum_{k=1}^{2 n}\left|\mathcal{L}_{e_{k}} \omega_{\varphi}\right|_{\varphi}^{2}\right) \\
\geq & \frac{1}{\Lambda_{0}\left(\omega_{\varphi}\right)} \Delta_{0} F-C_{1} \Lambda_{\varphi}\left(\omega_{0}\right)-\frac{C_{2}}{\Lambda_{0}\left(\omega_{\varphi}\right)} \\
\geq & \frac{1}{\Lambda_{0}\left(\omega_{\varphi}\right)} \Delta_{0} F-\left(C_{1}+C_{2}\right) \Lambda_{\varphi}\left(\omega_{0}\right),
\end{aligned}
$$

where in the last inequality we used that $\Lambda_{\varphi}\left(\omega_{0}\right) \Lambda_{0}\left(\omega_{\varphi}\right) \geq 1$.
We are now ready to give the proof of Theorem 5.1
proof of Theorem 5.1. Consider

$$
u:=e^{-\gamma(F+\lambda \varphi)} \Lambda_{0}\left(\omega_{\varphi}\right)>0,
$$

where $\gamma, \lambda>1$ are uniform constants to be chosen in a suitable way in the following. The $v$-Laplacian of $u$ is

$$
\begin{aligned}
\Delta_{\varphi, \mathrm{v}} u & =\Delta_{\varphi, \mathrm{v}} e^{\log u} \\
& =\Delta_{\varphi} e^{\log u}+g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), d\left(e^{\log u}\right)\right) \\
& =\Lambda_{\varphi}\left(\frac{e^{\log u}}{u^{2}} d u \wedge d^{c} u\right)+e^{\log u} \Delta_{\varphi, \mathrm{v}} \log u \\
& =\frac{e^{\log (u)}}{u^{2}}|d u|_{\varphi}^{2}+e^{\log u} \Delta_{\varphi, \mathrm{v}} \log u \\
& \geq e^{\log u} \Delta_{\varphi, \mathrm{v}} \log u \\
& =-\gamma u \Delta_{\varphi, \mathrm{v}}(F+\lambda \varphi)+u \Delta_{\varphi, \mathrm{v}}\left(\log \Lambda_{0}\left(\omega_{\varphi}\right)\right) .
\end{aligned}
$$

From (18), the fact that $\operatorname{Ric}\left(\omega_{0}\right) \leq A_{0} \omega_{0}$ and that by (54) $\Lambda_{\varphi, \mathrm{v}}\left(\omega_{\varphi}\right) \leq n+C$ we deduce that

$$
\begin{aligned}
\Delta_{\varphi, \mathrm{v}}(F+\lambda \varphi) & =-\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)+\lambda \Lambda_{\varphi, \mathrm{v}} d d^{c} \varphi \\
& =-\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)+\lambda\left(\Lambda_{\varphi, \mathrm{v}}\left(\omega_{\varphi}\right)-\Lambda_{\varphi, \mathrm{v}}\left(\omega_{0}\right)\right) \\
& \leq C_{1}+\left(2 A_{0}-\lambda\right) \Lambda_{\varphi}\left(\omega_{0}\right)+\lambda n+C_{2} \\
& =C_{3}+\left(2 A_{0}-\lambda\right) \Lambda_{\varphi}\left(\omega_{0}\right)
\end{aligned}
$$

Thus, combining the above inequalities together with Lemma 5.6 leads us to:

$$
\Delta_{\varphi, \mathrm{v}} u \geq e^{-\gamma(F+\lambda \varphi)}\left(-\gamma C_{3} \Lambda_{0}\left(\omega_{\varphi}\right)+\Delta_{0} F+\left(\lambda \gamma-2 A_{0} \gamma-B\right) \Lambda_{0}\left(\omega_{\varphi}\right) \Lambda_{\varphi}\left(\omega_{0}\right)\right)
$$

Using (18), (the proof of) Lemma 5.2 and the fact that $n \geq 2$, we have

$$
\Lambda_{0}\left(\omega_{\varphi}\right) \Lambda_{\varphi}\left(\omega_{0}\right) \geq n^{-\frac{1}{n-1}} e^{\frac{-F}{n-1}} \eta^{\frac{1}{n-1}} \Lambda_{0}\left(\omega_{\varphi}\right)^{1+\frac{1}{n-1}}:=a(n, \eta) e^{\frac{-F}{n-1}} \Lambda_{0}\left(\omega_{\varphi}\right)^{1+\frac{1}{n-1}}
$$

where $\eta$ is defined in (19).
We now choose $\lambda \geq 4 \max \left(2 A_{0}, B\right)$ (in order to have $\lambda \gamma-2 A_{0} \gamma-B \geq \frac{\lambda \gamma}{2}$ ) so that

$$
\begin{equation*}
\Delta_{\varphi, \mathrm{v}} u \geq-\gamma C_{3} u+\frac{\lambda \gamma}{2} a(n, \eta) e^{-\frac{F}{n-1}} \Lambda_{0}\left(\omega_{\varphi}\right)^{\frac{1}{n-1}} u+e^{-\gamma(F+\lambda \varphi)} \Delta_{0} F \tag{34}
\end{equation*}
$$

Now, since $|d u|_{\varphi}^{2} \Lambda_{0} \omega_{\varphi} \geq|d u|_{0}^{2}$ holds pointwise, we write

$$
\frac{1}{2 p+1} \Delta_{\varphi, \mathrm{v}} u^{2 p+1}=u^{2 p} \Delta_{\varphi, \mathrm{v}} u+2 p u^{2 p-1}|d u|_{\varphi}^{2} \geq u^{2 p} \Delta_{\varphi, \mathrm{v}} u+2 p u^{2 p-2} e^{-\gamma(F+\lambda \varphi)}|d u|_{0}^{2}
$$

Thus, combining the above inequality with (34), and since $\Delta_{\varphi, v}$ is self-adjoint w.r.t. to $\mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{n}$ (Lemma A.1), we get

$$
\begin{align*}
0=\frac{1}{2 p+1} \int_{X} \Delta_{\varphi, \mathrm{v}} u^{2 p+1} \mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]} \geq & 2 p \int_{X} u^{2 p-2}|d u|_{0}^{2} e^{-\gamma(F+\lambda \varphi)+F} \omega_{0}^{[n]}-\gamma C_{3} \int_{X} u^{2 p+1} e^{F} \omega_{0}^{[n]}  \tag{35}\\
& +\frac{\gamma \lambda}{2} a(n, \eta) \int_{X} u^{2 p+1} e^{\left(\frac{n-2}{n-1}\right) F} \Lambda_{0}\left(\omega_{\varphi}\right)^{\frac{1}{n-1}} \omega_{0}^{[n]} \\
& +\int_{X} u^{2 p} e^{-\gamma(F+\lambda \varphi)+F} \Delta_{0} F \omega_{0}^{[n]} .
\end{align*}
$$

Next, we focus on finding a suitable lower bound for the last term involving the Laplacian of $F$. This estimate goes as in [16] but we show it for completeness and for reader's convenience.

Set $G:=(1-\gamma) F-\gamma \lambda \varphi$. A formal trick gives that

\begin{aligned}
I & :=-\int_{X} u^{2 p} \Delta_{0} F e^{G} \omega_{0}^{[n]} \\
& =\frac{1}{\gamma-1} \int_{X} u^{2 p} \Delta_{0} G e^{G} \omega_{0}^{[n]}+\frac{\gamma \lambda}{\gamma-1} \int_{X} u^{2 p} \Delta_{0} \varphi e^{G} \omega_{0}^{[n]} \\
& :=I_{1}+I_{2}
\end{aligned}
$$

Integration by part gives

$$
\begin{align*}
I_{1} & =-\frac{1}{\gamma-1} \int_{X} u^{2 p}|d G|_{0}^{2} e^{G} \omega_{0}^{[n]}-\frac{2 p}{\gamma-1} \int_{X} u^{2 p-1} e^{G} d u \wedge d^{c} G \wedge \omega_{0}^{[n-1]} \\
& \leq-\frac{1}{2(\gamma-1)} \int_{X} u^{2 p}|d G|_{0}^{2} e^{G} \omega_{0}^{[n]}+\frac{2 p^{2}}{\gamma-1} \int_{X} u^{2 p-2}|d u|_{0}^{2} e^{G} \omega_{0}^{[n]} \\
& \leq \frac{2 p^{2}}{\gamma-1} \int_{X} u^{2 p-2}|d u|_{0}^{2} e^{G} \omega_{0}^{[n]} \tag{36}
\end{align*}
$$

where in the first inequality we used the fact that

$$
\left|2 p u^{2 p-1} \frac{d u \wedge d^{c} G \wedge \omega_{0}^{[n-1]}}{\omega_{0}^{[n]}}\right| \leq \frac{(2 p)^{2}}{2} u^{2 p-2}|d u|_{0}^{2}+\frac{1}{2} u^{2 p}|d G|_{0}^{2}
$$

by Young's inequality. Also,

$$
\begin{align*}
I_{2} & =\frac{\gamma \lambda}{\gamma-1} \int_{X} u^{2 p}\left(\Lambda_{0}\left(\omega_{\varphi}\right)-n\right) e^{G} \omega_{0}^{[n]}  \tag{37}\\
& \leq \frac{\gamma \lambda}{\gamma-1} \int_{X} u^{2 p} \Lambda_{0}\left(\omega_{\varphi}\right) e^{G} \omega_{0}^{[n]}=\frac{\gamma \lambda}{\gamma-1} \int_{X} u^{2 p+1} e^{F} \omega_{0}^{[n]}
\end{align*}
$$

Suppose $p>1$. Then Combining (35), (36), (37) and choosing $\gamma$ big enough (say $\gamma=a p$, with $a \gg 1$ ) we obtain

$$
\begin{align*}
0 \geq & 2\left(p-\frac{p^{2}}{\gamma-1}\right) \int_{X} u^{2 p-2}|d u|_{0}^{2} e^{G} \omega_{0}^{[n]}-\gamma\left(C_{3}+\frac{\lambda}{\gamma-1}\right) \int_{X} u^{2 p+1} e^{F} \omega_{0}^{[n]} \\
& +\frac{\gamma \lambda}{2} a(n, \eta) \int_{X} u^{2 p+1} e^{\left(\frac{n-2}{n-1}\right) F} \Lambda_{0}\left(\omega_{\varphi}\right)^{\frac{1}{n-1}} \omega_{0}^{[n]}  \tag{38}\\
\geq & -C_{4} \int_{X} \Lambda_{0}\left(\omega_{\varphi}\right)^{2 p+1} \omega_{0}^{[n]}+C_{5} \int_{X} \Lambda_{0}\left(\omega_{\varphi}\right)^{2 p+1+\frac{1}{n-1}} \omega_{0}^{[n]},
\end{align*}
$$

where the constant $C_{4}, C_{5}>0$ depends on $\|F\|_{C^{0}}$ and $\|\varphi\|_{C^{0}}$. Observe that in (38), the choice of $\gamma$ ensures that $p-\frac{p^{2}}{\gamma-1}>0$. Using Hölder inequality (with $r=(2 p+n) /(n-1)$ and $s$ its conjugate) we can conclude that

$$
\left\|\Lambda_{0}\left(\omega_{\varphi}\right)\right\|_{L^{2 p+1+\frac{1}{n-1}}}^{2 p+1+\frac{1}{n-1}} \leq C\left\|\Lambda_{0}\left(\omega_{\varphi}\right)\right\|_{L^{2 p+1}}^{2 p+1} \leq C^{\prime}\left\|\Lambda_{0}\left(\omega_{\varphi}\right)\right\|_{L^{2 p+1+\frac{1}{n-1}}}^{2 p+1} .
$$

This gives the statement for $p>3$, hence for $p \geq 1$ thanks to Hölder inequality.

$$
\text { 6. } C^{2} \text {-estimates }
$$

The goal to this section is to prove the theorem below.
Theorem 6.1. Let $\varphi$ be a solution of (18). Then there exists a positive constant $C$ depending on $\omega_{0}$, v, w, $\|F\|_{C^{0}}$ and $\|\varphi\|_{C^{0}}$ such that

$$
\max _{X}\left(|d F|_{\varphi}^{2}+\Lambda_{0}\left(\omega_{\varphi}\right)\right) \leq C
$$

We begin by a technical lemma:
Lemma 6.2. For any smooth function $f$ on $X$ we have

$$
d d^{c} f(\cdot, J \cdot)=2 \nabla^{\varphi,+} d f(\cdot, \cdot),
$$

where $\nabla^{\varphi,+} \alpha$ for a 1-form $\alpha$ is defined by

$$
\nabla_{V}^{\varphi, \pm} \alpha(W):=\frac{1}{2}\left(\nabla_{V}^{\varphi} \alpha(W) \pm \nabla_{J V}^{\varphi} \alpha(J W)\right)
$$

Let us stress that the above identity holds for the Levi-Civita connection $\nabla^{\varphi}$ associated to any Kähler metric $\omega_{\varphi}$. Observe as well that $\nabla^{\varphi,+}$ and $\nabla^{\varphi,-}$ are orthogonal w.r.t. $g_{\varphi}$.
Proof. Let $V, W$ be two vector fields, we compute

$$
\begin{aligned}
d d^{c} f(V, W) & =\nabla_{V}^{\varphi} d^{c} f(W)-\nabla_{W}^{\varphi} d^{c} f(V) \\
& =\left(\nabla_{V}^{\varphi} J d f\right)(W)-\left(\nabla_{W}^{\varphi} J d f\right)(V) \\
& =\left(J \nabla_{V}^{\varphi} d f\right)(W)-\left(J \nabla_{W}^{\varphi} d f\right)(V) \\
& =-\left(\nabla_{V}^{\varphi} d f\right)(J W)+\left(\nabla_{W}^{\varphi} d f\right)(J V),
\end{aligned}
$$

where we use that $\nabla^{\varphi} J=0$. It follows that

$$
d d^{c} f(V, J W)=-\nabla_{V}^{\varphi} d f\left(J^{2} W\right)+\nabla_{J V}^{\varphi} d f(J W)=2 \nabla_{V}^{\varphi,+} d f(W) .
$$

The first main step to prove Theorem 6.1 is this key Proposition:

Proposition 6.3. Let $u:=e^{\frac{F}{2}}|d F|_{\varphi}^{2}+K \Lambda_{0}\left(\omega_{\varphi}\right)$. Then there exists positive constants $K$ and $C$ depending on $\omega_{0}, n, \mathrm{v}, \mathrm{w},\|F\|_{C^{0}}$ and $\|\varphi\|_{C^{0}}$ and an upper bound for the Ricci curvature, such that the function $u$ satisfies the following differential inequality

$$
\Delta_{\varphi, \mathrm{v}} u \geq-C \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3} u
$$

As a remark, we note that $u$ is uniformly bounded. Indeed, by the proof of Lemma 5.2

$$
u \geq K \Lambda_{0}\left(\omega_{\varphi}\right) \geq K n\left(\frac{e^{F}}{\mathrm{v}\left(\mu_{\varphi}\right)}\right)^{1 / n} \geq \frac{n K}{L^{1 / n}} e^{\frac{-\|F\|_{C 0}}{n}}
$$

where we recall that $\mathrm{v} \leq L$.
Our first step to show Proposition 6.3 is to bound from below uniformly the weighted Laplacian of $e^{F / 2}|d F|_{\varphi}^{2}$.
Lemma 6.4. The following inequality holds

$$
\begin{equation*}
\Delta_{\varphi, \mathrm{v}}\left(e^{F / 2}|d F|_{\varphi}^{2}\right) \geq-C_{1}\left(-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J \cdot} \omega_{\varphi}\right)\right)+\Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}|d F|_{\varphi}^{2}+1\right)+C_{2}\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2} \tag{39}
\end{equation*}
$$

where $C_{1}$ is a positive constant depending on $\omega_{0}, n,\|F\|_{C^{0}}$, an upper bound for the Ricci curvature, the bounds for $\mathrm{v}, \mathrm{w}$ and their derivatives, while $C_{2}>0$ depends only on $\|F\|_{C^{0}}$.

We recall that $g_{\varphi}\left(\mathcal{L} . \omega_{\varphi}, \mathcal{L}_{J .} \omega_{\varphi}\right)$ is understood as the 2 -form $(V, W) \rightarrow g_{\varphi}\left(\mathcal{L}_{V} \omega_{\varphi}, \mathcal{L}_{J W} \omega_{\varphi}\right)$. In particular, in a orthonormal frame $\left(e_{k}\right)_{k=1}^{2 n}$ with respect to $\omega_{0}$

$$
-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J \cdot} \omega_{\varphi}\right)\right)=\frac{1}{2} \sum_{k=1}^{2 n}\left|\mathcal{L}_{e_{k}} \omega_{\varphi}\right|_{\varphi}^{2} \geq 0
$$

Proof. We compute

$$
\begin{align*}
e^{-F / 2} \Delta_{\varphi, \mathrm{v}}\left(e^{F / 2}|d F|_{\varphi}^{2}\right)= & \Delta_{\varphi, \mathrm{v}}\left(|d F|_{\varphi}^{2}\right)+2 g_{\varphi}\left(d(F / 2), d|d F|_{\varphi}^{2}\right)+|d F|_{\varphi}^{2} e^{-F / 2} \Delta_{\varphi, \mathrm{v}}\left(e^{F / 2}\right) \\
(40) & \Delta_{\varphi}\left(|d F|_{\varphi}^{2}\right)+g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), d|d F|_{\varphi}^{2}\right)+g_{\varphi}\left(d F, d|d F|_{\varphi}^{2}\right)  \tag{40}\\
& +\frac{1}{2}|d F|_{\varphi}^{2} \Delta_{\varphi, \mathrm{v}} F+\frac{1}{4}|d F|_{\varphi}^{4},
\end{align*}
$$

where $|d F|_{\varphi}^{2}:=g_{\varphi}(d F, d F)$. In the above we used (11) for the first identity and Lemma A. 2 to pass to the second line. We now expand each term.
Using the fact that the metric $g_{\varphi}$ is parallel w.r.t. $\nabla_{\varphi}$ and the expression for the adjoint operator given in [17, eq. 1.10.13], we arrive at

$$
\begin{aligned}
\Delta_{\varphi}\left(|d F|_{\varphi}^{2}\right) & =-d_{\varphi}^{*} d\left(|d F|_{\varphi}^{2}\right) \\
& =-2 d_{\varphi}^{*}\left(g_{\varphi}\left(\nabla^{\varphi} d F, d F\right)\right) \\
& =2 \sum_{k=1}^{2 n} \nabla_{e_{k}}^{\varphi}\left(g_{\varphi}\left(\nabla_{e_{k}}^{\varphi} d F, d F\right)\right) \\
& =-2 g_{\varphi}\left(d_{\varphi}^{*}\left(\nabla^{\varphi} d F\right), d F\right)+2\left|\nabla^{\varphi} d F\right|_{\varphi}^{2} \\
& =2 g_{\varphi}\left(d \Delta_{\varphi} F, d F\right)+2 \operatorname{ric}_{\varphi}\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)+2\left|\nabla^{\varphi} d F\right|_{\varphi}^{2},
\end{aligned}
$$

where in the fifth line we used the Bochner formula $-d_{\varphi}^{*}\left(\nabla^{\varphi} d F\right)=\Delta_{\varphi}(d F)+\operatorname{ric}_{\varphi}\left(\nabla^{\varphi} F, \cdot\right)$ (cf [17, eq. 1.22.1]). Here $\operatorname{ric}_{\varphi}(\cdot, \cdot)$ denotes the Ricci symmetric 2 -tensor of $g_{\varphi}$.

For the second term in (40), by Lemma 5.3 we have

$$
\begin{aligned}
g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), d|d F|_{\varphi}^{2}\right) & =2 g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), g_{\varphi}\left(\nabla^{\varphi} d F, d F\right)\right) \\
& =2 g_{\varphi}\left(d F, g_{\varphi}\left(d \log \left(\mathrm{v}\left(\mu_{\varphi}\right), \nabla^{\varphi} d F\right)\right)\right. \\
& =2 g_{\varphi}\left(d F, d\left(g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), d F\right)\right)\right)-2 g_{\varphi}\left(d F, g_{\varphi}\left(\nabla^{\varphi} d \log \mathrm{v}\left(\mu_{\varphi}\right), d F\right)\right) \\
& =2 g_{\varphi}\left(d F, d\left(g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), d F\right)\right)\right)-2 \nabla^{\varphi} d \log \mathrm{v}\left(\mu_{\varphi}\right)\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right) .
\end{aligned}
$$

By the fact that $d|d F|_{\varphi}^{2}=d\left(g_{\varphi}(d F, d F)\right)=2 g_{\varphi}\left(\nabla^{\varphi} d F, d F\right)$ and again by Lemma 5.3, the next term in (40) is

$$
g_{\varphi}\left(d F, d|d F|_{\varphi}^{2}\right)=2\left(\nabla^{\varphi} d F\right)\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right) .
$$

Moreover, by definition of $\Delta_{\varphi, \mathrm{v}}$ we have

$$
g_{\varphi}\left(d \Delta_{\varphi} F, d F\right)+g_{\varphi}\left(d\left(g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), d F\right)\right), d F\right)=g_{\varphi}\left(d \Delta_{\varphi, \mathrm{v}} F, d F\right) .
$$

Substituting back and decomposing $\nabla^{\varphi} d F$ as a sum of $J$-invarant part $\nabla^{\varphi,+} d F$ and $J$-antiinvariant part $\nabla^{\varphi,-} d F$ we obtain

$$
\begin{aligned}
e^{-F / 2} \Delta_{\varphi, \mathrm{v}}\left(e^{F / 2}|d F|_{\varphi}^{2}\right)= & 2 g_{\varphi}\left(d \Delta_{\varphi, \mathrm{v}} F, d F\right)+2\left(\operatorname{ric}_{\varphi}-\nabla^{\varphi} d \log \mathrm{v}\left(\mu_{\varphi}\right)\right)\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right) \\
& +2\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2}+2\left|\nabla^{\varphi,-} d F\right|_{\varphi}^{2} \\
& +2 \nabla^{\varphi,+} d F\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)+2 \nabla^{\varphi,-} d F\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right) \\
& +\left(\frac{1}{2} \Delta_{\varphi, \mathrm{v}} F+\frac{1}{4}|d F|_{\varphi}^{2}\right)|d F|_{\varphi}^{2}
\end{aligned}
$$

Notice that by (25) we have

$$
\begin{aligned}
0 \leq & 2\left|\nabla^{\varphi,-} d F+\frac{1}{2}(d F \otimes d F)^{-}\right|_{\varphi}^{2} \\
= & 2\left|\nabla^{\varphi,-} d F\right|_{\varphi}^{2}+\frac{1}{8}\left(|d F|_{\varphi}^{4}+\left|d^{c} F\right|_{\varphi}^{4}\right) \\
& +\left(\nabla^{\varphi,-} d F\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)-\nabla^{\varphi,-} d F\left(J \nabla^{\varphi} F, J \nabla^{\varphi} F\right)\right) \\
= & 2\left|\nabla^{\varphi,-} d F\right|_{\varphi}^{2}+\frac{1}{4}|d F|_{\varphi}^{4}+2 \nabla^{\varphi,-} d F\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right),
\end{aligned}
$$

where $(\alpha \otimes \beta)^{-}(X, Y):=\frac{1}{2}(\alpha(X) \beta(Y)-\alpha(J X) \beta(J Y))$ and we use that $J \nabla^{\varphi} F$ is the dual of $d^{c} F$ with respect to $g_{\varphi}$. We then get

\begin{align*}
e^{-F / 2} \Delta_{\varphi, \mathrm{v}}\left(e^{F / 2}|d F|_{\varphi}^{2}\right) & \geq 2 g_{\varphi}\left(d \Delta_{\varphi, \mathrm{v}} F, d F\right)+2\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2} \\
& +2\left(\operatorname{ric}_{\varphi}+\nabla^{\varphi,+} d F-\nabla^{\varphi} d \log \mathrm{v}\left(\mu_{\varphi}\right)\right)\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)  \tag{41}\\
& +\frac{1}{2} \Delta_{\varphi, \mathrm{v}} F|d F|_{\varphi}^{2} .
\end{align*}
$$

Letting $\operatorname{Ric}\left(\omega_{\varphi}\right)$ be the corresponding Ricci form of $\omega_{\varphi}$, from (18) we get

$$
\operatorname{Ric}\left(\omega_{\varphi}\right)-\frac{1}{2} d d^{c} \log \mathrm{v}\left(\mu_{\varphi}\right)=\operatorname{Ric}\left(\omega_{0}\right)-\frac{1}{2} d d^{c} F .
$$

Composing with the complex structure $J$ and applying Lemma 6.2 we deduce that

$$
\operatorname{ric}_{0}=\operatorname{ric}_{\varphi}+\nabla^{\varphi,+} d F-\nabla^{\varphi,+} d \log \mathrm{v}\left(\mu_{\varphi}\right)
$$

Substituting back in (41) we obtain

e^{-F / 2} \Delta_{\varphi, \mathrm{v}}\left(e^{F / 2}|d F|_{\varphi}^{2}\right) & \geq 2 g_{\varphi}\left(d \Delta_{\varphi, \mathrm{v}} F, d F\right)+2 \operatorname{ric}_{0}\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)+\frac{1}{2} \Delta_{\varphi, \mathrm{v}} F|d F|_{\varphi}^{2}  \tag{42}\\
& +2\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2}-2 \nabla^{\varphi,-} d \log \mathrm{v}\left(\mu_{\varphi}\right)\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)
\end{align*}
$$

We give a bound for the last term of (42). A direct computation shows that

$$
\begin{aligned}
\nabla^{\varphi,-} d \log \left(\mathrm{v}\left(\mu_{\varphi}\right)\right) & =\sum_{j=1}^{r} \nabla^{\varphi,-}\left(\frac{\mathrm{v}_{, j}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)} d \mu_{\varphi}^{j}\right) \\
& =\sum_{j=1}^{r}\left(d\left(\frac{\mathrm{v}_{, j}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}\right) \otimes d \mu_{\varphi}^{j}+\frac{\mathrm{v}_{, j}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)} \nabla^{\varphi} d \mu_{\varphi}^{j}\right)^{-} \\
& =\sum_{i, j=1}^{r}\left(\frac{\mathrm{v}_{, j}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}\right)_{, i}\left(d \mu_{\varphi}^{i} \otimes d \mu_{\varphi}^{j}\right)^{-}+\sum_{j=1}^{r} \frac{\mathrm{v}_{, j}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)} \nabla^{\varphi,-} d \mu_{\varphi}^{j} \\
& =\sum_{i, j=1}^{r}\left(\frac{\mathrm{v}_{, j}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}\right)_{, i}\left(d \mu_{\varphi}^{i} \otimes d \mu_{\varphi}^{j}\right)^{-}
\end{aligned}
$$

To pass to the last line, we use [17, Lemma 1.23.2] which insures that $\nabla^{\varphi,-} d \mu_{\varphi}^{j}=0$ since $\mu_{\varphi}^{j}$ is Killing potential. On the other hand we have

$$
\begin{aligned}
\left|\left(d \mu_{\varphi}^{i} \otimes d \mu_{\varphi}^{j}\right)^{-}\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)\right| & =\frac{1}{2}\left|\left(d^{c} F\left(\xi_{i}\right) d^{c} F\left(\xi_{j}\right)-d F\left(\xi_{i}\right) d F\left(\xi_{j}\right)\right)\right| \\
& =\frac{1}{2}\left|\left(g_{0}\left(J \nabla^{0} F, \xi_{i}\right) g_{0}\left(J \nabla^{0} F, \xi_{j}\right)-g_{0}\left(\nabla^{0} F, \xi_{i}\right) g_{0}\left(\nabla^{0} F, \xi_{j}\right)\right)\right| \\
& \leq C|d F|_{0}^{2} \\
& \leq C_{1}|d F|_{\varphi}^{2} \Lambda_{0}\left(\omega_{\varphi}\right) .
\end{aligned}
$$

In the above we used that $d \mu_{\varphi}^{i}\left(\nabla^{\varphi} F\right)=-g_{\varphi}\left(J \xi_{i}, \nabla^{\varphi} F\right)=-d F\left(J \xi_{i}\right)=d^{c} F\left(\xi_{i}\right)$. It follows that

$$
\left|\nabla^{\varphi,-} d \log \mathrm{v}\left(\mu_{\varphi}\right)\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)\right| \leq C_{2}|d F|_{\varphi}^{2} \Lambda_{0}\left(\omega_{\varphi}\right) .
$$

Notice that

$$
\begin{align*}
\left|\operatorname{ric}_{0}\left(\nabla^{\varphi} F, \nabla^{\varphi} F\right)\right| & =\left|g_{\varphi}\left(\operatorname{ric}_{0}, d F \otimes d F\right)\right| \\
& \leq\left|\operatorname{Ric}\left(\omega_{0}\right)\right|_{\varphi}|d F|_{\varphi}^{2} \\
& \leq A_{0}|d F|_{\varphi}^{2} \Lambda_{\varphi}\left(\omega_{0}\right)  \tag{43}\\
& \leq A_{1}|d F|_{\varphi}^{2} \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3} .
\end{align*}
$$

Let us stress that in the second line we apply Cauchy-Schwarz inequality for 2-tensors and we end up the norm of the $(1,1)$-form $\operatorname{Ric}\left(\omega_{0}\right)$ since

\left|\operatorname{ric}_{0}\right|_{\varphi}=\left|\operatorname{ric}_{0}(\cdot, J \cdot)\right|_{\varphi}=\left|\operatorname{Ric}\left(\omega_{0}\right)\right|_{\varphi},
$$

where we use that $J$ is preserving the metric $g_{\varphi}$.

In the third inequality we used that $\operatorname{Ric}\left(\omega_{0}\right) \leq A_{0} \omega_{0}$ and the well known inequality (see e.g. [17, (1.12.5)])

\left|\omega_{0}\right|_{\varphi}^{2}=\Lambda_{\varphi}\left(\omega_{0}\right)^{2}-\frac{\omega_{0}^{2} \wedge \omega_{\varphi}^{[n-2]}}{\omega_{0}^{[n]}} \leq \Lambda_{\varphi}\left(\omega_{0}\right)^{2} .
$$

The last inequality follows from (23) and (22). Also,

\Delta_{\varphi, \mathrm{v}} F|d F|^{2} & =\left(-\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)\right)|d F|_{\varphi}^{2} \\
& \geq-C\left(\left\|\frac{\mathrm{w}}{\mathrm{v}}\right\|_{C^{0}}+\Lambda_{\varphi}\left(\omega_{0}\right)+\tilde{C}\right)|d F|_{\varphi}^{2}  \tag{44}\\
& \geq-C^{\prime}\left(\left\|\frac{\mathrm{w}}{\mathrm{v}}\right\|_{C^{0}}+\Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}+\tilde{C}^{\prime}\right)|d F|_{\varphi}^{2}
\end{align*}
$$

where $C, C^{\prime}$ depend only on $\omega, \operatorname{Ric}\left(\omega_{0}\right)$, v, and $\tilde{C}$ is the constant which appears in (21). The last line, follows again from (22) and (23).
Using the second equation of (18) and (56) we obtain

$$
\begin{align*}
g_{\varphi}\left(d \Delta_{\varphi, \mathrm{v}} F, d F\right)= & -g_{\varphi}\left(d\left(\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}\right), d F\right)+2 g_{\varphi}\left(d \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right), d F\right) \\
= & -g_{\varphi}\left(d\left(\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+\frac{1}{2 \mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}\right), d F\right)+  \tag{45}\\
& +2 g_{\varphi}\left(d \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right), d F\right) .
\end{align*}
$$

We consider the last term of the above equality. From (26) we get that

$$
\begin{equation*}
g_{\varphi}\left(d \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right), d F\right)=g_{\varphi}\left(\Lambda_{\varphi}\left(\mathcal{L} . \operatorname{Ric}\left(\omega_{0}\right)\right), d F\right)-g_{\varphi}\left(g_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right), \mathcal{L} \cdot \omega_{\varphi}\right), d F\right) \tag{46}
\end{equation*}
$$

We bound the first term of (46). By Cauchy-Swcharz inequality we obtain that

$$
\begin{align*}
g_{\varphi}\left(\Lambda_{\varphi}\left(\mathcal{L} \cdot \operatorname{Ric}\left(\omega_{0}\right)\right), d F\right) & \leq\left|\Lambda_{\varphi}\left(\mathcal{L} \cdot \operatorname{Ric}\left(\omega_{0}\right)\right)\right|_{\varphi}|d F|_{\varphi} \\
& \leq C_{1} \sqrt{\Lambda_{\varphi}\left(\omega_{0}\right)^{3}}|d F|_{\varphi} \\
& \leq \frac{1}{2} \Lambda_{\varphi}\left(\omega_{0}\right)^{3}|d F|_{\varphi}^{2}+\frac{C_{1}}{2}  \tag{47}\\
& \leq \frac{C}{2} \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}|d F|_{\varphi}^{2}+\frac{C_{1}}{2} .
\end{align*}
$$

The second inequality follows from the following local computations

$$
\begin{aligned}
\left|\Lambda_{\varphi}\left(\mathcal{L} . \operatorname{Ric}\left(\omega_{0}\right)\right)\right|_{\varphi}^{2} & =\left|\frac{1}{2} \sum_{j=1}^{2 n} \frac{\mathcal{L} \cdot \operatorname{Ric}\left(\omega_{0}\right)\left(e_{j}, e_{j}\right)}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)}\right|_{\varphi}^{2}=\frac{1}{4} \sum_{j, k=1}^{2 n} \frac{\left(\mathcal{L}_{k} \operatorname{Ric}\left(\omega_{0}\right)\left(e_{j}, e_{j}\right)\right)^{2}}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)^{2} \omega_{\varphi}\left(e_{k}, J e_{k}\right)} \\
& \leq \frac{1}{4} A \sum_{j, k=1}^{2 n} \frac{1}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)^{2} \omega_{\varphi}\left(e_{k}, J e_{k}\right)} \leq \frac{1}{4} A \sum_{j=1}^{2 n} \frac{1}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)^{2}} \sum_{k=1}^{2 n} \frac{1}{\omega_{\varphi}\left(e_{k}, J e_{k}\right)} \\
& \leq \frac{1}{4} A \sum_{j=1}^{2 n} \frac{1}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)} \sum_{=1}^{2 n} \frac{1}{\omega_{\varphi}\left(e_{i}, J e_{i}\right)} \sum_{k=1}^{2 n} \frac{1}{\omega_{\varphi}\left(e_{k}, J e_{k}\right)} \\
& \leq 2 A \Lambda_{\varphi}\left(\omega_{0}\right)^{3},
\end{aligned}
$$

where in the above we used that for a 1 -form $\alpha$ we have $|\alpha|_{\varphi}^{2}=\sum_{k=1}^{2 n} \frac{\alpha_{k}^{2}}{\omega_{\varphi}\left(e_{k}, J e_{k}\right)}$. Also, the third line we make use of Young's inequality and in the last line we use (23).
Since $\operatorname{Ric}\left(\omega_{0}\right) \leq A_{0} \omega_{0}$ and applying once again Cauchy-Schwarz inequality we have

g_{\varphi}\left(g_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right), \mathcal{L} \cdot \omega_{\varphi}\right), d F\right) & \leq A_{0} g_{\varphi}\left(g_{\varphi}\left(\omega_{0}, \mathcal{L} \cdot \omega_{\varphi}\right), d F\right) \\
& \leq A_{0}\left|g_{\varphi}\left(\omega_{0}, \mathcal{L} \cdot \omega_{\varphi}\right)\right|_{\varphi}|d F|_{\varphi} . \tag{48}
\end{align*}
$$

We already observed (cf. the lines after the statement of Lemma 6.3) that

\left|g_{\varphi}\left(\omega_{0}, \mathcal{L} \cdot \omega_{\varphi}\right)\right|_{\varphi}=\left(\sum_{k=1}^{2 n}\left|\mathcal{L}_{e_{k}} \omega_{\varphi}\right|_{\varphi}^{2}\right)^{\frac{1}{2}}=\left(-2 \Lambda_{0} g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J} \cdot \omega_{\varphi}\right)\right)^{\frac{1}{2}} .
$$

Injecting the above in (48) and using Young inequality, we find

g_{\varphi}\left(g_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right), \mathcal{L} \cdot \omega_{\varphi}\right), d F\right) \leq C\left(|d F|_{\varphi}^{2}-\Lambda_{0} g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J} \cdot \omega_{\varphi}\right)\right) . \tag{49}
\end{equation*}
$$

Combining (47) and (49), we get an upper bound for (46)

\begin{equation*}
g_{\varphi}\left(d \Lambda_{\varphi}\left(\operatorname{Ric}\left(\omega_{0}\right)\right), d F\right) \leq C\left(-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J} \cdot \omega_{\varphi}\right)\right)+\left(\Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}+1\right)|d F|_{\varphi}^{2}+1\right) \tag{50}
\end{equation*}
$$

We now bound the first term of the last line of (45).
Let $f_{\varphi}:=\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+\frac{1}{2 \mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}, j\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j}$. The differential of $f_{\varphi}$ is a linear combination of terms of the form $\tilde{f}_{\varphi}^{i} d \mu_{\varphi}^{i}$, where $\tilde{f}_{\varphi}^{i}$ is bounded independently of $\varphi$. Thus, in order to bound $g_{\varphi}\left(d f_{\varphi}, d F\right)$, it is sufficient to bound $g\left(d \mu_{\varphi}^{i}, d F\right)$ for any $i=1, \cdots, r$. Applying CauchySchwarz and Young inequalities once again we deduce

\begin{align*}
g_{\varphi}\left(d \mu_{\varphi}^{i}, d F\right) & \leq\left|d \mu_{\varphi}^{i}\right|_{\varphi}|d F|_{\varphi} \\
& =\left|\xi^{i}\right|_{\varphi}|d F|_{\varphi} \\
& \leq \frac{1}{2}\left|\xi^{i}\right|_{\varphi}^{2}|d F|_{\varphi}^{2}+\frac{1}{2}  \tag{51}\\
& \leq C \Lambda_{0}\left(\omega_{\varphi}\right)|d F|_{\varphi}^{2}+\frac{1}{2} \\
& \leq C_{1} \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}|d F|_{\varphi}^{2}+\frac{1}{2}
\end{align*}
$$

where $C, C_{1}$ are constant independent of $\varphi$. Let us observe that in the second line we have $\left|d \mu_{\varphi}^{i}\right|_{\varphi}=\left|\xi^{i}\right|_{\varphi}$ since the metric is invariant by duality, while in the last line we use (22).

Combining (50) and (51), we deduce an upper bound for (45):

\begin{equation*}
g_{\varphi}\left(d \Delta_{\varphi, \mathrm{v}} F, d F\right) \leq C\left(-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J \cdot} \omega_{\varphi}\right)\right)+\left(\Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}+1\right)|d F|_{\varphi}^{2}+1\right) \tag{52}
\end{equation*}
$$

for a positive constant $C$ independent of $\varphi$.
Finally, using (43), (44), (152) we obtain a lower bound for (42):

$$
\begin{aligned}
\Delta_{\varphi, \mathrm{v}}\left(e^{F / 2}|d F|_{\varphi}^{2}\right) \geq & -e^{F / 2} C\left(-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J . \omega_{\varphi}}\right)\right)+\left(\Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}+1\right)|d F|_{\varphi}^{2}+1\right) \\
& +2 e^{F / 2}\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2}
\end{aligned}
$$

This concludes the proof since $\|F\|_{C^{0}}$ is uniformly under control by Corollary 4.3 and since $1 \leq C \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}$ by (24).
We are now in position to prove Proposition 6.3:
proof of Proposition 6.3. Recall that $u:=e^{\frac{F}{2}}|d F|_{\varphi}^{2}+K \Lambda_{0}\left(\omega_{\varphi}\right)$. From (29) together with (39), we obtain a lower bound of the weighted Laplacian of $u$ :

\Delta_{\varphi, \mathrm{v}} u \geq & -C_{1}\left(-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J} \cdot \omega_{\varphi}\right)\right)+\Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3}|d F|_{\varphi}^{2}+1\right)+C_{2}\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2} \\
& -K \Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} \cdot \omega_{\varphi}, \mathcal{L}_{J} \cdot \omega_{\varphi}\right)\right)-K \tilde{C}_{1} \Lambda_{0}\left(\omega_{\varphi}\right)^{n}+K\left(\Delta_{0} F-\tilde{C}_{2}\right)
\end{aligned}
$$

We now fix $K$ large enough so that one can drop the term $-\Lambda_{0}\left(g_{\varphi}\left(\mathcal{L} . \omega_{\varphi}, \mathcal{L}_{J} \cdot \omega_{\varphi}\right)\right)$. Observe that, since $n \geq 2, C \Lambda_{0}\left(\omega_{\varphi}\right)^{2 n-2} \geq \Lambda_{0}\left(\omega_{\varphi}\right)^{n}$ thanks to (22). We then deduce

\Delta_{\varphi, \mathrm{v}} u \geq C_{2}\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2}-C_{3} \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3} u+K\left(\Delta_{0} F-\tilde{C}_{2}\right)-C_{1}
$$

where $C_{3}=\max \left(C_{1} \sup _{X} e^{-F / 2}, C \tilde{C}_{1}\right)$. Observe that $\sup _{X} e^{-F / 2}$ is uniformly under control by Corollary 4.3

Now, in orthonormal frame we find

$$
\left|\Delta_{0} F\right|=\left|\sum_{j=1}^{2 n} \frac{F_{, j j} \omega_{\varphi}\left(e_{j}, J e_{j}\right)}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)}\right|,
$$

where $F_{, j j}$ denote the second derivative with respect to the vector $e_{j}$. Also by Lemma 6.2

$$
\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2}=\sum_{j=1}^{2 n} \frac{\left(\nabla^{\varphi,+} d F\left(e_{j}, e_{j}\right)\right)^{2}}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)^{2}}=\frac{1}{4} \sum_{j=1}^{2 n} \frac{\left(d d^{c} F\left(e_{j}, J e_{j}\right)\right)^{2}}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)^{2}}=\sum_{j=1}^{2 n} \frac{F_{, j j}}{\omega_{\varphi}\left(e_{j}, J e_{j}\right)^{2}}
$$

Hence, by Young's inequality

$$
\begin{aligned}
K\left|\Delta_{0} F\right| & \leq \varepsilon\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2}+\varepsilon^{-1} K^{2} \Lambda_{0}\left(\omega_{\varphi}\right)^{2} \\
& \leq \varepsilon\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2}+C \varepsilon^{-1} K^{2} \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-2} u,
\end{aligned}
$$

where in the above we used Lemma 5.2 (since $n \geq 2$ ) and the fact that $u$ is uniformly bounded. Choosing $\varepsilon$ smaller than $C_{2}$ so that one can drop the term $\left|\nabla^{\varphi,+} d F\right|_{\varphi}^{2}$, we arrive at

$$
\Delta_{\varphi, \mathrm{v}} u \geq-\left(C_{3}+C K \varepsilon^{-1}\right) \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3} u-K \tilde{C}_{2}-C_{1} \geq-C_{4} \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3} u
$$

where $C_{4}$ depends on $\omega_{0}, K, \varepsilon, n, \mathrm{v}$ and $\|F\|_{C^{0}}$.
Another key lemma is the following:
Lemma 6.5. The following $L_{1}$-estimate holds:

$$
\|u\|_{L_{1}} \leq C\left(\omega_{0}, \mathrm{v},\|F\|_{C^{0}}, \operatorname{Ent}(\varphi)\right)
$$

Proof. Using the second equation in (18):

$$
\begin{aligned}
\Delta_{\mathrm{v}, \varphi} F^{2} & =2 F \Delta_{\mathrm{v}, \varphi} F+2|d F|_{\varphi}^{2} \\
& =2 F\left(-\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}+2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)\right)+2|d F|_{\varphi}^{2}
\end{aligned}
$$

Since $\Delta_{\mathrm{v}, \varphi}$ is self-adjoint with respect to $\mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]}$ (Lemma A.1), we deduce

$$
\begin{aligned}
\int_{X}|d F|_{\varphi}^{2} \mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]}= & \int_{X} F\left(\frac{\mathrm{w}\left(\mu_{\varphi}\right)}{\mathrm{v}\left(\mu_{\varphi}\right)}-2 \Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)\right) \mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]} \\
& \leq \frac{M}{\eta} \int_{X}|F| e^{F} \omega_{0}^{[n]}+\left(2 A_{0} L \int_{X} \Lambda_{\varphi}\left(\omega_{0}\right) \omega_{\varphi}^{[n]}+2 C^{\prime} L\right)\|F\|_{C^{0}}
\end{aligned}
$$

In the above we use that $\Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right) \leq A_{0} \Lambda_{\varphi}\left(\omega_{0}\right)+C^{\prime}\left(\right.$ thanks to (56)) where $C^{\prime}$ depends on v and its derivatives, and that $\int_{X} \Lambda_{\varphi}\left(\omega_{0}\right) \omega_{\varphi}^{[n]}=1$.

We can now conclude:
Proof of Theorem 6.1. We assume that $\varphi$ is a (v, w)-cscK metric. The only adjustment needed for the proof is to consider the Leibniz rule for the v-weighted Laplacian:

$$
\begin{aligned}
\Delta_{\varphi, \mathrm{v}} u^{2 p+1} & =u^{2 p} \Delta_{\varphi, \mathrm{v}} u+2 p u^{2 p-1}|d u|_{\varphi}^{2} \\
& =u^{2 p} \Delta_{\varphi, \mathrm{v}} u+\frac{8 p}{(2 p+1)^{2}}\left|d\left(u^{p+\frac{1}{2}}\right)\right|_{\varphi}^{2}
\end{aligned}
$$

With the above identity and Proposition 6.3 in hands we can deduce the following bound for $p \geq 1$ :

$$
\begin{aligned}
\int_{X}\left|d\left(u^{p+\frac{1}{2}}\right)\right|_{\varphi}^{2} \omega_{\varphi}^{[n]} & \leq \frac{1}{\eta} \int_{X}\left|d\left(u^{p+\frac{1}{2}}\right)\right|_{\varphi}^{2} \mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]} \\
& =\frac{(2 p+1)^{2}}{8 p \eta} \int_{X}\left(-u^{2 p} \Delta_{\varphi, \mathrm{v}} u+\Delta_{\varphi, \mathrm{v}} u^{2 p+1}\right) \mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]} \\
& =-\frac{(2 p+1)^{2}}{8 p \eta} \int_{X} u^{2 p} \Delta_{\varphi, \mathrm{v}} u \\
& \leq C \int_{X} \Lambda_{0}\left(\omega_{\varphi}\right)^{3 n-3} u^{2 p+1} \omega_{\varphi}^{[n]}
\end{aligned}
$$

Observe also that at the third line we also make use of the fact that $\Delta_{\varphi, v}$ is self-adjoint with respect to $\mathrm{v}\left(\mu_{\varphi}\right) \omega_{\varphi}^{[n]}$.
Once the latter inequality in hand, the exact same arguments in [16, Proof of Theorem 5.1] allow to conclude.

## Appendix A. Weighted Laplacian and weighted trace

A.1. The weighted Laplacian. For any smooth function $f$ on $X$, the v-weighted Laplacian is defined as

$$
\begin{equation*}
\Delta_{\varphi, \mathrm{v}} f:=-\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} d_{\varphi}^{*}\left(\mathrm{v}\left(\mu_{\varphi}\right) d f\right) \tag{53}
\end{equation*}
$$

It follows straightforward from the above expression that:
Lemma A.1. The weighted Laplacian $\Delta_{\varphi, \mathrm{v}}$ is self-adjoint and Leibniz rule holds.
Lemma A.2. For any smooth function $f$ on $X$, the weighted Laplacian $\Delta_{\varphi, v}$ can be expressed as

$$
\begin{aligned}
\Delta_{\varphi, \mathrm{v}} f & =\Delta_{\varphi} f+\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}, j\left(\mu_{\varphi}\right) d^{c} f\left(\xi_{j}\right) \\
& =\Delta_{\varphi} f+g_{\varphi}\left(d \log \mathrm{v}\left(\mu_{\varphi}\right), d f\right)
\end{aligned}
$$

In particular $\Delta_{\varphi, \mathrm{v}}$ is elliptic.
Proof. We apply the well-know identity (see e.g. [17, (1.10.13)])

$$
d_{\varphi}^{*}(h \alpha)=h d_{\varphi}^{*} \alpha-\alpha\left(\nabla^{\varphi} h\right),
$$

where $h$ is a smooth function and $\alpha$ a 1-form, for $h=\mathrm{v}\left(\mu_{\varphi}\right)$ and $\alpha=d f$. We then use the fact that $d^{c} f(\cdot)=J d f(\cdot)=-d f(J \cdot)$ and that $-J \xi_{j}$ is the gradient of $\mu_{\varphi}^{j}$ with respect to $g_{\varphi}$ since $d \mu_{\varphi}^{j}=-\omega_{\varphi}\left(\xi_{j}, \cdot\right)=-g_{\varphi}\left(J \xi_{j}, \cdot\right)$.
A.2. The weighted trace. Let $f$ be a $\mathbb{T}$-invariant smooth function $f: X \rightarrow \mathbb{R}$. By Cartan's formula and the $\mathbb{T}$-invariance of $d^{c} f$ we get that

$$
\left.d d^{c} f(\xi, \cdot)=\xi\right\lrcorner d d^{c} f(\cdot, \cdot)=\mathcal{L}_{\xi} d^{c} f-d\left(d^{c} f(\xi)\right)=-d\left(d^{c} f(\xi)\right),
$$

for any $\xi \in \mathfrak{t}$. Hence we choose the normalization of the moment map by defining $\mu_{d d^{c} f}^{j}:=$ $d^{c} f\left(\xi_{j}\right)$.

We consider a smooth path $\left(\varphi_{t}\right)_{t}$ in $\mathcal{K}\left(X, \omega_{0}\right)^{\mathbb{T}}$ with variation $\left.\frac{d}{d t} \varphi_{t}\right|_{t=0}=\dot{\varphi}$. Taking the variation of the weighted volume form along $\varphi_{t}$ and then computing it at $t=0$, we obtain (see proof of [25, Lemma 4])

$$
\frac{d}{d t}\left(\mathrm{v}\left(\mu_{\varphi_{t}}\right) \omega_{\varphi_{t}}^{[n]}\right)_{\left.\right|_{t=0}}=\left(\Lambda_{\varphi_{0}}\left(d d^{c} \dot{\varphi}\right)+\left\langle d \log \mathrm{v}\left(\mu_{\varphi_{0}}\right), \mu_{d d^{c} \dot{\varphi}}\right\rangle\right) \mathrm{v}\left(\mu_{\varphi_{t}}\right) \omega_{\varphi_{t}}^{[n]} .
$$

The above identity motivates the following definition: for any ( 1,1 )-form $\theta$ with moment map $\mu_{\theta}$, we define the v -weighted trace of $\theta$ by

$$
\begin{equation*}
\Lambda_{\varphi, \mathrm{v}}(\theta):=\Lambda_{\varphi}(\theta)+\left\langle d \log \left(\mathrm{v}\left(\mu_{\varphi}\right), \mu_{\theta}\right\rangle\right. \tag{54}
\end{equation*}
$$

for any $\varphi \in \mathcal{K}\left(X, \omega_{0}\right)^{\mathbb{T}}$. Observe that the above definition depends on the choice of the normalization of the momentum map $\mu_{\theta}$. Equivalently, in a fixed basis $\left(\xi_{1}, \ldots, \xi_{r}\right)$ of the Lie algebra $\mathfrak{t}$ of $\mathbb{T}$

$$
\begin{equation*}
\Lambda_{\varphi, \mathrm{v}}(\theta)=\Lambda_{\varphi}(\theta)+\frac{1}{\mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}, j\left(\mu_{\varphi}\right) \mu_{\theta}^{j} \tag{55}
\end{equation*}
$$

In particular, since $\mu_{\operatorname{Ric}\left(\omega_{0}\right)}=-\frac{1}{2} \Delta_{0} \mu_{0}$ with $\mu_{0}$ being the moment map associated to $\omega_{0}$ (see [25, Lemma 5 (i)], we have

$$
\begin{equation*}
\Lambda_{\varphi, \mathrm{v}}\left(\operatorname{Ric}\left(\omega_{0}\right)\right)=\Lambda_{\varphi} \operatorname{Ric}\left(\omega_{0}\right)-\frac{1}{2 \mathrm{v}\left(\mu_{\varphi}\right)} \sum_{j=1}^{r} \mathrm{v}_{, j}\left(\mu_{\varphi}\right) \Delta_{0} \mu_{0}^{j} \tag{56}
\end{equation*}
$$

Lemma A.3. For any $\mathbb{T}$-invariant smooth function $f: X \rightarrow \mathbb{R}$, the following identity holds true

$$
\Delta_{\varphi, \mathrm{v}} f=\Lambda_{\varphi, \mathrm{v}}\left(d d^{c} f\right)
$$

Proof. It is a direct consequence of (55) and Lemma A.2.
