Probabilistic Reachability of Stochastic Control Systems: A Contraction-Based Approach

Abstract—In this paper, we propose a framework for studying the probabilistic reachability of stochastic control systems. Given a stochastic system, we introduce a separation strategy for reachability analysis that decouples the effect of deterministic input/disturbance and stochastic uncertainty. A remarkable feature of this separation strategy is its ability to leverage any deterministic reachability framework to capture the effect of deterministic input/disturbance. Furthermore, this separation strategy encodes the impact of stochastic uncertainty on reachability analysis by measuring the distance between the trajectories of the stochastic system and its associated deterministic system. Using contraction theory, we provide probabilistic bounds on this trajectory distance and estimate the propagation of stochastic uncertainties through the system. By combining this probabilistic bound on trajectory distance with two computationally efficient deterministic reachability methods, we provide estimates for probabilistic reachable sets of the stochastic system. We demonstrate the efficacy of our framework through numerical experiments on a feedback-stabilized inverted pendulum.

Keywords: Reachability analysis, Stochastic systems

I. INTRODUCTION

Reachability analysis is a fundamental problem in control theory and dynamical systems that studies how the trajectories of a system propagate with time. Reachability analysis has been successfully used in many real-world applications to explore the transient behaviors of systems and to verify their safety over a given time horizon. However, providing formal guarantees for behaviors of dynamical systems using reachability analysis is challenging for several reasons. First, reachability analysis deals with the behavior of an infinite number of trajectories. Consequently, most simulation-based methods are insufficient and theoretical methods are needed to provide guarantees on behavior of the system. Second, practical systems typically operate in uncertain environments, where their behaviors are affected by different types of random and adversarial uncertainties. Therefore, it is crucial to suitably incorporate the effect of various uncertainties in reachability of these systems. Moreover, many real-world systems are largescale with highly nonlinear dynamics, necessitating computationally efficient and scalable reachability tools to certify their behaviors.

The majority of the research on reachability analysis focuses on control systems with deterministic input/disturbance [1].

By considering the least favorable or the most detrimental values of these input/disturbances, these work perform worst-case uncertainty analysis and provide guarantees for reachable sets of the system under all possible uncertainty scenarios. The classical frameworks for reachability of the systems with deterministic input/disturbance include Hamilton-Jacobi and dynamic programming approaches [2], [3] and the set-propagation approaches such as ellipsoidal methods [4] and polytope method [5], [6]. Despite their deep theoretical foundations, these approaches are either only applicable to certain classes of systems or are not computationally tractable for large-scale systems. Motivated by applications to general large-scale systems with complex components, various computationally efficient and scalable deterministic reachability frameworks have been recently developed in the literature [7]. Examples of these methods include reachability using Lipschitz bound [8], matrix measure-based reachability [9], [10], and interval-based reachability [11], [12], [13], [14].

In many real-world applications, systems are subject to unpredictable and rapidly fluctuating disturbances. For such disturbances, it is impossible to provide precise bounds on their magnitudes. Consequently, worst-case uncertainty analysis either offers no guarantees or results in overly conservative estimates of the reachable sets. Instead, it is more reasonable to model these disturbances as stochastic variables and use probabilistic methods for reachability analysis of the system. However, the reachability analysis of stochastic systems is significantly more challenging than that of deterministic systems due to the probabilistic nature of their evolution. Several frameworks have been developed in the literature to analyze the propagation of uncertainties in stochastic systems. Hamilton-Jacobi and dynamic programming approaches characterize probabilistic reachability as a the solution of a game between two players [15], [16], [17]. Despite their generality, a significant drawback of these reachability approaches lies in their computational heaviness, rendering them impractical for reachability analysis of large-size systems. Recent works have focused on improving the computational complexity of the dynamic programming for reachability of stochastic systems [18]. Functional approaches develop barrier function [19], [20], [21] for measuring the probability of a trajectory staying inside a reachable set. These functional approaches are computationally efficient. However, in applications, they require an exhaustive search for a suitable function and lack the flexibility to balance the accuracy and efficiency of reachability analysis.

In this paper, we develop a computationally efficient framework for probabilistic reachability of control systems with

both deterministic input/disturbance and stochastic uncertainty. First, we present a separation strategy that decomposes the effect of deterministic input/disturbance and the effect of stochastic uncertainty on reachability analysis of the stochastic control system. We show that the effect of deterministic input/disturbance on reachability can be captured using reachable sets of an associated deterministic system. This is a key feature of this separation strategy as it allows to use any frameworks for deterministic reachability to study the propagation of deterministic input/disturbance in stochastic systems. The effect of stochastic uncertainty on reachability is represented by the distance between trajectories of the stochastic system and the associated deterministic system. Inspired by the works on incremental stability of stochastic systems [22], [23], [24], we leverage contraction theory to study the evolution of stochastic uncertainty in the system. While the existing literature on contraction analysis of stochastic systems focus on providing conditions for their stability, we establish probabilistic transient bounds on the distance between trajectories of the stochastic system and its associated deterministic system. By combining our probabilistic bound on propagation of stochastic uncertainties with contraction-based and interval-based reachability methods for deterministic systems, we provide high probability bounds on reachable sets of stochastic systems. Finally, we apply our framework with both contraction-based and interval-based deterministic reachability to obtain probabilistic bounds on reachable sets of a feedback stabilized inverted pendulum.

II. MATHEMATICAL PRELIMINARIES

Vectors, matrices, and functions: we denote the componentwise vector order on \mathbb{R}^n by \leq , i.e., for $v, w \in \mathbb{R}^n$, we have $v \leq w$ if and only if $v_i \leq w_i$, for every $i \in \{1, \ldots, n\}$. Given $v \le w$, we define the interval $[v, w] = \{x \in \mathbb{R}^n \mid v \le x \le w\}.$ Given a norm $\|\cdot\|$ on \mathbb{R}^n , we define the ball with radius rcentered at $z \in \mathbb{R}^n$ by $\mathcal{B}_{\|\cdot\|}(r, z) = \{x \in \mathbb{R}^n \mid \|x - z\| \le r\}.$ Given a norm $\|\cdot\|$ on \mathbb{R}^n and a matrix $A \in \mathbb{R}^{n \times n}$, the matrix measure of A with respect to $\|\cdot\|$ is defined by $\mu_{\|\cdot\|}(A) =$ $\lim_{h\to 0^+} \frac{\|I_n + hA\|_i - 1}{h}$, where $\|\cdot\|_i$ is the matrix norm on $\mathbb{R}^{n \times n}$ induced from $\|\cdot\|$. Given a nonsingular matrix $P \in \mathbb{R}^{n \times n}$, the P-weighted ℓ_2 -norm is defined by $||v||_{2,P} = v^{\mathsf{T}} P v$ and the *P*-weighted ℓ_2 -matrix measure is denoted by $\mu_{2,P}$. Given two sets $A, B \in \mathbb{R}^n$, we define the Minkowski sum of the sets A and B by $A \oplus B = \{x + y \mid x \in A, y \in B\}$. Given $v \le w$, we define the interval $[v, w] = \{x \in \mathbb{R}^n \mid v \le x \le w\}$. Given a set $\mathcal{X} \subseteq \mathbb{R}^n$ and a transformation $T \in \mathbb{R}^{n \times n}$, we define $T\mathcal{X} = \{Tx \mid x \in \mathcal{X}\}$. Given a square matrix $A \in \mathbb{R}^{n \times n}$, we denote the trace of matrix A by tr(A). For two matrices $X, Y \in \mathbb{R}^{n \times n}$, we denote $X \succ Y$ if X - Y is a positive definite matrix. Given a continuously differentiable function $f: \mathbb{R}^n \to \mathbb{R}^m$, we denote the Jacobian of f at point x_0 by $D_x f(x_0).$

Dynamical systems: consider the deterministic system

$$\dot{x}_t = f(t, x_t, u_t),\tag{1}$$

where $x_t \in \mathbb{R}^n$ is the state of the system, $u_t \in \mathbb{R}^p$ is the input. Depending on the application, the input u_t can be considered as a controller or a disturbance. We assume that $f: \mathbb{R}_{\geq 0} \times \mathbb{R}^n \times \mathbb{R}^p \to \mathbb{R}^n$ is a parameterized vector field which is measurable in t and locally Lipschitz in x and u. Using Rademacher's theorem, the Jacobian $D_x f(t, x, u)$ exists for almost every $t, x, u \in \mathbb{R}_{\geq 0} \times \mathbb{R}^n \times \mathbb{R}^p$. Given the initial set \mathcal{X}_0 and the disturbance set \mathcal{U} , the *T*-reachable set $\mathcal{R}_f(T, \mathcal{X}_0, \mathcal{U})$ is the set of all possible states the system (1) can achieve at time T, i.e.,

$$\mathcal{R}_{f}(T, \mathcal{X}_{0}, \mathcal{U}) = \left\{ x_{T} \middle| \begin{array}{c} t \to x_{t} \text{ is a traj of (1)} \\ \text{with } x_{0} \in \mathcal{X}_{0}, \ t \to u_{t} \in \mathcal{U} \end{array} \right\}$$
(2)

It is well known that finding the exact reachable set of general nonlinear systems is computationally intractable [25]. Instead, most existing approaches for reachability focus on efficient methods for over-approximating the reachable sets [1], i.e. finding the set $\overline{\mathcal{R}}_f(t, \mathcal{X}_0, \mathcal{U})$ satisfying $\mathcal{R}_f(t, \mathcal{X}_0, \mathcal{U}) \subseteq \overline{\mathcal{R}}_f(t, \mathcal{X}_0, \mathcal{U})$. Given a norm $\|\cdot\|$ on \mathbb{R}^n , the deterministic system (1) is contracting with rate *c* with respect to the norm $\|\cdot\|$ if, for every $t_0 \in \mathbb{R}_{>0}$ and every $t \mapsto u_t \in \mathcal{U}$,

$$||x_t - y_t|| \le e^{c(t-t_0)} ||x_\tau - y_\tau||, \text{ for all } t \ge \tau$$

where $t \mapsto x_t$ and $t \mapsto y_t$ are two trajectories of the system (1) with the same input $t \mapsto u_t \in \mathcal{U}$. It can be shown [26, Theorem 36] that the system (1) is contracting with rate c with respect to the norm $\|\cdot\|$ if and only if, for almost every $t, x, u \in \mathbb{R}_{>0} \times \mathbb{R}^n \times \mathbb{R}^p$

$$\mu_{\|\cdot\|}(D_x f(t, x, u)) \le c.$$

The function $\mathsf{F} = \begin{bmatrix} \frac{\mathsf{F}}{\mathsf{F}} \end{bmatrix}$: $\mathbb{R}_{\geq 0} \times \mathbb{R}^{2n} \times \mathbb{R}^{2p} \to \mathbb{R}^{2n}$ is an *inclusion function* for the vector field f of the system (1) if, for every $z \in [x, \hat{x}]$ and every $w \in [v, \hat{v}]$,

$$\underline{F}(t, x, \hat{x}, v, \hat{v}) \le f(t, z, w) \le \overline{F}(t, x, \hat{x}, v, \hat{v}).$$
(3)

One can show every vector field f has at least one inclusion function [13], [27]. However, inclusion function of f is not generally unique [27].

III. PROBLEM FORMULATION

In this paper, we study reachability of stochastic control systems with both deterministic input/disturbance and stochastic uncertainty. We consider the stochastic version of the deterministic system (1) given by

$$dX_t = f(t, X_t, u_t)dt + \sigma(t, X_t, u_t)dW_t$$
(4)

where $X_t \in \mathbb{R}^n$ is the state, u_t is the input, W_t is the stochastic uncertainty, and and $\sigma : \mathbb{R}_{\geq 0} \times \mathbb{R}^n \times \mathbb{R}^p \to \mathbb{R}^{n \times m}$ is a matrixvalued function. We assume that the input u_t belongs to the set $\mathcal{U} \subseteq \mathbb{R}^p$, for every $t \geq 0$, and the stochastic uncertainty W_t is an *m*-dimensional Wiener process (standard Brownian motion). Throughout this paper, we assume that f and σ are measurable in time and locally Lipschitz in x, u to ensure the existence and uniqueness of solutions of the stochastic system (4) and its associated deterministic system (1) [28, Theorem 5.2.1].

Our goal is to provide probabilistic bounds on trajectories of the stochastic control system (4) starting from some $x_0 \in \mathcal{X}_0$ with any input $t \mapsto u_t \in \mathcal{U}$. We first present a separation strategy that decouples the effect of deterministic input/disturbance and stochastic uncertainty on reachability of the stochastic system (4). We show that the effect of deterministic input/disturbance on reachability can be captured using the reachable set of the associated deterministic system (1). We represent the effect of stochastic uncertainty on reachability using the distance between trajectories of (4) and their associated trajectories of (1) and leverage contraction theory to establish high probability bounds on this distance.

IV. DECOMPOSITION OF REACHABILITY ANALYSIS

In this section, we study reachability of the control system (4) with both deterministic input/disturbance and stochastic uncertainty. Inspired by the sampling-based approaches for reachability [17], [29], [30], we focus on probabilistic reachable sets of stochastic system (4), i.e., the sets that contain trajectories of the system with certain probability. We develop a separation strategy that presents a novel perspective toward constructing probabilistic reachable sets of stochastic system (4). The key idea in separation strategy is to decouple the effect of deterministic input/disturbance and the effect of stochastic uncertainty on the probabilistic reachable set of (4).

The effect of stochastic uncertainty is encoded in the distance between trajectories of (4) and their associated trajectories of the deterministic system (1). More specifically, for time $t \ge 0$ and probability level $\delta \in [0, 1)$, we assume there exists a constant $r(t, \delta) \in \mathbb{R}_{\geq 0}$ such that, with probability $1-\delta$,

$$||X_t - x_t||_{2,P} \le r(t,\delta),$$
(5)

where $t \mapsto X_t$ is a trajectory of the stochastic system (4) with the input $t \mapsto u_t \in \mathcal{U}$ starting from an initial condition $x_0 \in$ \mathcal{X}_0 and $t \mapsto x_t$ is the associated trajectory of the deterministic system (1) with the same input $t \mapsto u_t$ starting from the same initial condition x_0 .

The effect of deterministic input/disturbance is captured using the reachable set of the associated deterministic system (1). The probabilistic reachable set of the stochastic system (4) can then be constructed by combining these two components as described in the next theorem.

Theorem 1 (Separation strategy). Let $t \mapsto X_t$ be a trajectory of the stochastic system (4) with the input $t \mapsto u_t \in \mathcal{U}$ starting from an initial condition $x_0 \in \mathcal{X}_0$. Then, for every $t \ge 0$, with probability $1 - \delta$,

$$X_t \in \overline{\mathcal{R}}_f(t, \mathcal{X}_0, \mathcal{U}) \oplus \mathcal{B}_{2, P}(r(t, \delta), \mathbb{O}_n),$$

where \oplus is the Minkowski sum and $\overline{\mathcal{R}}_{f}(t, \mathcal{X}_{0}, \mathcal{U})$ is an over-approximation of the reachable set of the deterministic system (1).

Proof. Let $t \mapsto x_t$ be the associated trajectory of the deterministic system (1) with input $t \mapsto u_t$ starting from the initial condition x_0 . We note that, for every $t \ge 0$,

$$X_t = x_t + X_t - x_t := x_t + \eta_t.$$

Using the inequality (5), with probability $1 - \delta$, we have $\|\eta_t\|_{2,P} \leq r(t,\delta)$. By definition of Minkowski sum, with probability $1 - \delta$, we have $X_t \in \{x_t\} \oplus \mathcal{B}_{2,P}(r(t,\delta), \mathbb{O}_n)$. Since $\{x_t\} \subseteq \overline{\mathcal{R}}_f(t, \mathcal{X}_0, \mathcal{U})$, with probability $1 - \delta$, we have $X_t \in \overline{\mathcal{R}}_f(t, \mathcal{X}_0, \mathcal{U}) \oplus \mathcal{B}_{2, P}(r(t, \delta), \mathbb{O}_n)$

Remark 1 (Decomposition of probabilistic reachable sets). Theorem 1 decomposes the probabilistic reachability analysis of the stochastic system (4) into two separate problems: (i) over-approximating reachable sets of the associated deterministic system (1) and, (ii) bounding the propagation of stochastic uncertainty in the system. This decomposition brings considerable flexibility to probabilistic reachablity analysis of (4) as any approach for over-approximating reachable sets of the deterministic system (1) can be used to analyze the effect of deterministic input/disturbance. In general, computing the Minkowski sum of two arbitrary sets can be computationally complicated. However, when the sets are ellipsoids or polytopes, there exist efficient algorithms for estimating their Minkowski sum [31], [32].

Theorem 1 captures the propagation of stochastic uncertainty in reachability using the distance $||X_t - x_t||$ between trajectories of the stochastic system (4) and their associated trajectories of the deterministic system (1) via inequality (5). In the next section, we use incremental stability properties of the stochastic system (4) to bound the constant $r(t, \delta)$ in (5).

V. BOUNDS ON PROPAGATION OF STOCHASTIC UNCERTAINTY

In this section, we provide high confidence bounds $r(t, \delta)$ on the distance between trajectories of the stochastic system (4) and that of the deterministic system (1). Our approach is based on using contraction properties of the system. We start with the following assumption.

Assumption 1. There exist a positive definite matrix $P \succ 0$ and constants $c_P, d_P \in \mathbb{R}$ such that, for almost every $t, x, u \in$ $\mathbb{R}_{>0} \times \mathbb{R}^n \times \mathbb{R}^p,$

- (i) $\mu_{2,P}(D_x f(t, x, u)) \leq c_P$, and (ii) tr $(\sigma(t, x, u)^\mathsf{T} P \sigma(t, x, u)) \leq d_P$.

Various approaches have been proposed in the literature to efficiently compute upper bounds on $\mu_{2,P}(D_x f(t,x,u))$ including sum-of-square methods [33] and convex-hull methods [10]. These methods can readily extend to compute an upper bound for tr $(\sigma(t, x, u)^{\mathsf{T}} P \sigma(t, x, u_t))$ and to search for the positive definite $P \succ 0$ which gives rise to the optimal constants c_P and d_P . Now, we can state the main result of this section.

Theorem 2 (Stochastic Comparison Theorem). Consider the stochastic system (4) with its associated deterministic system (1) and assume that it satisfies Assumption 1. Let $t \mapsto X_t$ be a trajectory of the stochastic system (4) with the input $t \mapsto u_t$ starting from an initial condition $x_0 \in \mathcal{X}_0$ and let $t \mapsto x_t$ be the associated trajectory of the deterministic system (1) with the same input $t \mapsto u_t$ starting from the same initial condition x_0 . Then, for every $t \ge 0$, the following statements hold:

(i)
$$\mathbb{E}(||X_t - x_t||_{2,P}^2) \le \frac{d_P}{2c_P} \left(e^{2c_P t} - 1\right)$$

(*ii*) with probability at least $1 - \delta$,

$$||X_t - x_t||_{2,P} \le \sqrt{\frac{d_P}{2\delta c_P} (e^{2c_P t} - 1)}.$$

Proof. Regrading part (i), we define the random variable $z = \begin{bmatrix} X_t \\ x_t \end{bmatrix}$. Then, by combining dynamical systems (1) and (4),

$$dz_t = \begin{bmatrix} f(t, X_t, u_t) \\ f(t, x_t, u_t) \end{bmatrix} dt + \begin{bmatrix} \sigma(t, X_t, u_t) \\ \mathbb{O}_{n \times m} \end{bmatrix} dW_t.$$

We define $V(z_t) = ||X_t - x_t||_{2,P}^2 = (X_t - x_t)^{\mathsf{T}} P(X_t - x_t)$. Then, using Ito's formula,

$$dV(z) = \left[\frac{\partial V}{\partial t} + \left(\frac{\partial V}{\partial z}\right)^{\mathsf{T}} \begin{bmatrix} f(t, X_t, u_t) \\ f(t, x_t, u_t) \end{bmatrix} \right] dt + \left[\frac{1}{2} \operatorname{tr} \left(\begin{bmatrix} \sigma(t, X_t, u_t)^{\mathsf{T}} \mathbb{O}_{n \times m}^{\mathsf{T}} \end{bmatrix} \frac{\partial^2 V}{\partial z^2} \begin{bmatrix} \sigma(t, X_t, u_t) \\ \mathbb{O}_{n \times m} \end{bmatrix} \right) \right] dt + \left(\frac{\partial V}{\partial z}\right)^{\mathsf{T}} \begin{bmatrix} \sigma(t, X_t, u_t) \\ \mathbb{O}_{n \times m} \end{bmatrix} dW_t.$$

Using the fact that $\frac{\partial V}{\partial z} = 2 \begin{bmatrix} P(X_t - x_t) \\ P(-X_t + x_t) \end{bmatrix}$ and $\frac{\partial^2 V}{\partial z^2} = 2 \begin{bmatrix} P & -P \\ -P & P \end{bmatrix}$, we can compute

$$dV = 2(X_t - x_t)^{\mathsf{T}} P(f(t, X_t, u_t) - f(t, x_t, u_t))dt$$

+ tr(\sigma(t, X_t, u_t)^{\mathsf{T}} P \sigma(t, X_t, u_t))dt
+ 2P(X_t - x_t)^{\mathsf{T}} \sigma(t, X_t, u_t)dW_t.

By [26, Theorem 15], Assumption 1(i) is equivalent to

$$(X_t - x_t)^{\mathsf{T}} P(f(t, X_t, u_t) - f(t, x_t, u_t)) \leq c_P \|X_t - x_t\|_{2, P}^2, \quad (6)$$

for every $x, y \in \mathbb{R}^n$ and every $t, u \in \mathbb{R}_{\geq 0} \times \mathbb{R}^p$. Now, we focus on the curve $t \mapsto z_t = \begin{bmatrix} X_t(t) \\ x_t(t) \end{bmatrix}$. Following standard Itó Calculus, for every $t, h \geq 0$,

$$\mathbb{E}(V(z_{t+h})) - \mathbb{E}(V(z_t)) = \left(\int_t^{t+h} dV(z_s)\right)$$

$$\leq \int_t^{t+h} \mathbb{E}(dV(z_s))$$

$$\leq \int_t^{t+h} (2c_P \mathbb{E}(||X_t - x_t||_{2,P}^2) + d_P) ds$$

$$= \int_t^{t+h} (2c_P \mathbb{E}(V(z_s)) + d_P) ds.$$

where the first inequality holds by the triangle inequality and the second inequality holds by (6). Therefore, we have

$$\frac{\frac{1}{h}\left(\mathbb{E}(V(z_{t+h})) - \mathbb{E}(V(z_{t}))\right)\right)}{\leq \frac{1}{h}\int_{t}^{t+h} \left(2c_{P}\mathbb{E}(V(z_{x_{0}}(s)) + d_{P})\,ds.\right)$$

Taking the limsup of both side as $h \to 0$, for every $t \ge 0$, we get $D^+\mathbb{E}(V(z_t)) \le 2c_P\mathbb{E}(V(z_t)) + d_P$, where D^+ is the upper Dini Derivative with respect to t. Using the generalized Gröwall-Bellman lemma [34, Appendix A1, Proposition 2], we can show that, for every $t \ge 0$,

$$\mathbb{E}(V(z_t)) \le e^{2c_P t} \mathbb{E}(V(z_0)) + \frac{d_P}{2c_P} \left(e^{2c_P t} - 1 \right).$$

Since $\begin{bmatrix} X_t(0) \\ x_t(0) \end{bmatrix} = \begin{bmatrix} x_0 \\ x_0 \end{bmatrix}$, we have $V(z_0) = ||X_0 - x_0||_{2,P} = 0$ and thus $\mathbb{E}(V(z_0)) = 0$. This implies that, $\mathbb{E}(||X_t - x_t||_{2,P}^2) \le \frac{d_P}{2c_P} (e^{2c_P t} - 1)$, for every $t \ge 0$. Regarding part (ii), the result follows by applying Markov inequality [35] to part (i).

Remark 2 (Comparison with the literature). Theorem 2 provides an incremental bound between a trajectory of the stochastic system (4) and the associated trajectory of the deterministic system (1). In [22, Theorem 2] and [23, Lemma 2], a similar approach is used to bound the distance between every two stochastic trajectories of the system (4). Compared to [22, Theorem 2] and [23, Lemma 2], the bound in Theorem 2 is sharper since is focuses on the distance between a stochastic trajectory of the system (4) and the associated trajectory of the deterministic system (1). Moreover, the expectation bound in [22, Theorem 2] and [23, Lemma 2] is only applicable to contracting system with $c_P \leq 0$ and it reduces to an asymptotic bound when the uncertainty in the initial configuration is deterministic. On the other hand, Theorem 2 is applicable to systems satisfying Assumption (1) with arbitrary $c_P, d_P \in \mathbb{R}$ and it captures the transient behavior of the incremental distance between trajectories.

VI. PROBABILISTIC REACHABILITY OF STOCHASTIC DYNAMICAL SYSTEMS

In this section, we use the separation strategy in Theorem 1 to obtain high probability bounds on the trajectories of the system (4). In particular, we combine the bounds on propagation of stochastic uncertainty (Section V) with two computationally efficient methods for over-approximating reachable sets of the deterministic system (1) namely contraction-based reachability and interval-based reachability to obtain estimates for probabilistic reachable sets of the stochastic system (4).

a) Contraction-based Reachability: Contraction theory is a classical framework that studies stability of dynamical systems using the incremental distance between their trajectories [36], [37]. Recently, this framework has emerged as a computationally efficient and scalable method for reachability of dynamical systems [9], [10]. In this section, we review the contraction-based reachability for deterministic system (1). Let $\|\cdot\|_{\mathbb{X}}$ be a norm on \mathbb{R}^n , $\|\cdot\|_{\mathbb{U}}$ be a norm on \mathbb{R}^p , and the induced norm on $\mathbb{R}^{n \times p}$ is denoted by $\|\cdot\|_{\mathbb{X},\mathbb{U}}$. We consider the following assumption.

Assumption 2. There exist constants $c, \ell \in \mathbb{R}$ such that, for almost every $t, x, u \in \mathbb{R}_{>0} \times \mathbb{R}^n \times \mathcal{U}$:

- (i) $\mu_{\mathbb{X}}(D_x f(t, x, u)) \leq c$, and
- (ii) $||D_u f(t, x, u)||_{\mathbb{X}, \mathbb{U}} \le \ell$.

where $\mu_{\mathbb{X}}$ is the matrix measure associated with the norm $\|\cdot\|_{\mathbb{X}}$. Let $t \mapsto x_t^*$ be a trajectory of (1) with the input $t \mapsto u_t^*$. We consider the initial configuration $\mathcal{X}_0 = \mathcal{B}_{\mathbb{X}}(r_1, x_0^*)$ for some $r_1 > 0$ and the input set $\mathcal{U} = \mathcal{B}_{\mathbb{U}}(r_2, u_0^*)$ for some $r_2 > 0$. If Assumption 2 holds, using the incremental input-to-state bounds [26, Theorem 37], we can compute an over-approximation of reachable set of the deterministic system (1) as follows:

$$\overline{\mathcal{R}}_f(t, \mathcal{X}_0, \mathcal{U}) = \mathcal{B}_{\mathbb{X}}(e^{ct}r_1 + \frac{\ell}{c}(e^{ct} - 1)r_2, x_t^*), \qquad (7)$$

The aforementioned contraction-based reachability can be used to capture the effect of deterministic input/disturbance on reachability of stochastic system (4).

Proposition 1 (Contraction-based reachability). Consider the stochastic system (4) satisfying Assumptions 1 and 2. Suppose that $t \mapsto x_t^*$ is a trajectory of the associated deterministic system (1) with an input $t \mapsto u_t^*$. Let $t \mapsto X_t$ be a trajectory of the stochastic system (4) with the input $t \mapsto u_t \in \mathcal{B}_{\mathbb{U}}(r_2, u_0^*)$ starting from $x_0 \in \mathcal{B}_{\mathbb{X}}(r_1, x_0^*)$. Then, for every $t \ge 0$, with probability $1 - \delta$,

$$X_t \in \mathcal{B}_{\mathbb{X}}(r_t, x_t^*) \oplus \mathcal{B}_{2,P}(\rho(t, \delta), \mathbb{O}_n)$$

where, for every $t \ge 0$,

$$r_t = e^{ct}r_1 + \frac{\ell}{c}(e^{ct} - 1)r_2, \quad \rho(t,\delta) = \sqrt{\frac{d_P}{2\delta c_P}(e^{2c_P t} - 1)}.$$

Proof. The proof follows by using the over-approximation (7) for the reachable sets of the deterministic system (1) in Theorem 1 and using Theorem 2 for the high probability bound on the stochastic deviation $r(t, \delta)$.

b) Interval-based Reachability: Interval analysis is a wellestablished framework for analyzing the propagation of interval uncertainty in mathematical models [38]. Techniques from interval analysis have been successfully used for reachability analysis of dynamical systems [11], [12], [14]. In this section, we review interval-based reachability for the deterministic system (1). Conisder the dynamical system (1) with an interval initial configuration $\mathcal{X}_0 = [\underline{x}_0, \overline{x}_0]$ and an interval input set $\mathcal{U} = [\underline{u}, \overline{u}]$. Let $\mathsf{F} = \begin{bmatrix} \underline{F} \\ \overline{\mathsf{F}} \end{bmatrix}$: $\mathbb{R}_{\geq 0} \times \mathbb{R}^{2n} \times \mathbb{R}^{2p} \to \mathbb{R}^{2n}$ be an inclusion function for f. We define the embedding system of (1) associated with the inclusion function F by

$$\begin{bmatrix} \underline{\dot{x}}_t \\ \overline{\dot{x}}_t \end{bmatrix} = \begin{bmatrix} \underline{\mathsf{F}}(t, \underline{x}_t, \overline{x}_t, \underline{u}, \overline{u}) \\ \overline{\mathsf{F}}(t, \underline{x}_t, \overline{x}_t, \underline{u}, \overline{u}) \end{bmatrix}$$
(8)

Let $t \mapsto \left[\frac{x}{x_t}\right]$ be the trajectory of the embedding system (8) starting from $\left[\frac{x_0}{x_0}\right]$. The reachable sets of the deterministic system (1) can be over-approximated by [27, Proposition 5]:

$$\overline{\mathcal{R}}_f(t, [\underline{x}_0, \overline{x}_0], [\underline{u}, \overline{u}]) = [\underline{x}_t, \overline{x}_t], \tag{9}$$

The accuracy of the interval over-approximation (9) depends on the choice of inclusion function F. Given a parameterized vector field f, there exist several computationally efficient approaches for finding an inclusion function for f. We refer to [27, Section IV.B] for detailed discussion on these approaches and to [39] for a toolbox for computing inclusion functions. In the next proposition, we use aforementioned interval-based approach to capture the effect of deterministic input/disturbance on reachability of the stochastic system (4).

Proposition 2 (Interval-based reachability). Consider the stochastic system (4) satisfying Assumption 1. Let $t \mapsto X_t$ be a trajectory of (4) with the input $t \mapsto u_t \in [\underline{u}, \overline{u}]$ starting from the initial condition $X_0 \in [\underline{x}_0, \overline{x}_0]$. Suppose that $\mathsf{F} = \begin{bmatrix} \overline{\mathsf{F}} \\ \overline{\mathsf{F}} \end{bmatrix}$ is an inclusion function for f with the associated embedding system (8) and $t \mapsto \begin{bmatrix} \frac{x}{x_t} \\ \overline{x}_t \end{bmatrix}$ is the trajectory of (8) starting from $\begin{bmatrix} \frac{x}{x_0} \\ \overline{x}_0 \end{bmatrix}$. Then, for every $t \ge 0$, with probability $1 - \delta$,

$$X_t \in [\underline{x}_t, \overline{x}_t] \oplus \mathcal{B}_{2,P}(\rho(t, \delta), \mathbb{O}_n),$$

where
$$\rho(t,\delta) = \sqrt{\frac{d_P}{2\delta c_P} \left(e^{2c_P t} - 1\right)}$$
.

Proof. The proof follows by using the over-approximation (9) for the reachable sets of the deterministic system (1) in Theorem 1 and using Theorem 2 for the high probability bound on the stochastic deviation $r(t, \delta)$.

VII. NUMERICAL SIMULATIONS

In this section, we employ our framework to study probabilistic reachability of a feedback stabilized inverted pendulum. Consider the nonlinear dynamics for the pendulum:

$$dX_1 = X_2 dt, dX_2 = \frac{g}{L} \sin(X_1) dt + (k_1 X_1 + k_2 X_2) dt + \sigma dW_t,$$
(10)

where X_1 is the angular position of the pendulum, X_2 is the angular velocity of the pendulum, and the term $k_1X_1 + k_2X_2$ is a feedback controller with $k_1 = k_2 = -20$ designed to stabilizes the unstable equilibrium point $x^* = 0_2$. We assume that g = 10 is the gravitational constant, L = 1 is the length of the pendulum. The stochastic disturbance W_t is modeled by a Wiener process with $\sigma = 0.1$ and the deterministic disturbance is modeled by the uncertainty in the initial configuration $\mathcal{X}_0 = [-\frac{\pi}{10}, \frac{\pi}{10}] \times [-0.2, 0.2]$. The associated deterministic system for (10) is given by

$$\dot{x}_1 = x_2 \dot{x}_2 = \frac{g}{L}\sin(x_1) - k_1x_1 - k_2x_2,$$
(11)

and we define $f(x) = \begin{bmatrix} x_2 \\ \frac{1}{L}\sin(x_1)-k_1x_1-k_2x_2 \end{bmatrix}$ for $x = (x_1, x_2)^{\mathsf{T}}$. We use Theorem 1 and Theorem 2 to obtain high probability bounds on trajectories of the stochastic inverted pendulum system (10). We first check Assumption 1 for this system. For every $x = (x_1, x_2)^{\mathsf{T}} \in \mathbb{R}^2$,

$$D_x f(x) = \begin{bmatrix} 0 & 1\\ \frac{g}{L}\cos(x_1) + k_1 & k_2 \end{bmatrix}$$

We define the matrices $A_1, A_2 \in \mathbb{R}^{2 \times 2}$ as follows:

$$A_1 = \begin{bmatrix} 0 & 1\\ \frac{g}{L} + k_1 & k_2 \end{bmatrix}, \qquad A_2 = \begin{bmatrix} 0 & 1\\ -\frac{g}{L} + k_1 & k_2 \end{bmatrix}.$$

Note that $\cos(x_1) \in [-1, 1]$, for every $x = (x_1, x_2)^{\mathsf{T}} \in \mathbb{R}^2$. This implies that, for every $x \in \mathbb{R}^2$, we have $D_x f(x) \in$ $\cos\{A_1, A_2\}$, where conv is the convex hull. Thus, using [10, Lemma 4.1], the optimal constant c_P can be computed using the following optimization algorithm:

$$\lim_{c_p \in \mathbb{R}, P \succ 0} c_P$$

s.t. $A_i^{\mathsf{T}} P + P A_i \preceq 2c_P P$, for $i \in \{1, 2\}$. (12)

We solve optimization problem (12) by successively applying semi-definite programming on P and bisection on c_P . The optimal solution of (12) is given by $c_P = -0.5$ and $P = \begin{bmatrix} 35.68 & 2.21\\ 2.21 & 1.27 \end{bmatrix}$. With this matrix P, we compute $d_P = \operatorname{tr}(\begin{bmatrix} 0 & \sigma \end{bmatrix} P \begin{bmatrix} \sigma \\ \sigma \end{bmatrix}) = 0.0128$. *Contraction-based reachability:* In this part, we use Proposition 1 to find probabilistic reachable sets of the inverted pendulum (10). We consider Assumption 2 with $\|\cdot\|_{\mathbb{X}} = \|\cdot\|_{2,P}$ with positive definite matrix P as defined above. For every $x = (x_1, x_2)^{\mathsf{T}} \in \mathbb{R}^2$, we have $\mu_{2,P}(D_x f(x)) \leq c_P = -0.5$. Using Proposition 1 with the initial configuration $\overline{\mathcal{X}}_0 = \{x \in \mathbb{R}^2 \mid \|x\|_{2,P} \leq \|\begin{bmatrix}\frac{\pi}{10}\\0.2\end{bmatrix}\|_{2,P}\} \supset \mathcal{X}_0$, the probabilistic reachable sets of the stochastic system (10) with probability higher than or equal to 99% are shown in Figure 1 (left).

Interval-based reachability: In this part, we use the separation strategy in Theorem 1 with the bounds on propagation of stochastic uncertainty obtained from Theorem 2 and the over-approximations of reachable sets of the associated deterministic system (11) obtained using interval-based reachability via a coordinate transformation. We consider the coordinate transformation y = Tx with nonsingular matrix $T = \begin{bmatrix} 1 & 0.2 \\ 1 & 0 \end{bmatrix}$ for the associated deterministic system (11). The transformed system is given by

$$\dot{y} = Tf(T^{-1}y).$$
 (13)

One can show that $\overline{\mathcal{Y}}_0 = [-\frac{\pi}{10} \begin{bmatrix} 1.04 \\ 1 \end{bmatrix}, \frac{\pi}{10} \begin{bmatrix} 1.04 \\ 1 \end{bmatrix} \supset T\mathcal{X}_0$ is a forward invariant set for the transformed system (13). Moreover, on the forward invariant set $\overline{\mathcal{Y}}_0$, an inclusion function for the transformed deterministic system (13) is given by $\mathsf{F}(\underline{y}, \overline{y}) = \begin{bmatrix} Tf(T^{-1}\underline{y}) \\ Tf(T^{-1}\overline{y}) \end{bmatrix}$. We denote the trajectory of the associated embedding system starting from $\frac{\pi}{10} \begin{bmatrix} -1.04 \\ -1 \\ 1.04 \\ 1 \end{bmatrix}$ by $t \mapsto \begin{bmatrix} \underline{y}_t \\ \overline{y}_t \end{bmatrix}$ and use equation (9) to over-approximate the reachable

 $\lfloor \overline{y}_t \rfloor$ and use equation (9) to over-approximate the reachable sets of the transformed system (13). More specifically, at time t, every trajectory of the transformed system (13) starting from $\overline{\mathcal{Y}}_0$ belongs to the set $[\underline{y}_t, \overline{y}_t]$. This implies that every trajectory of the associated deterministic system (11) starting from \mathcal{X}_0 belongs to the parallelotope $T^{-1}[\underline{y}_t, \overline{y}_t]$. The reachable sets of the system (10) with probability higher than or equal to 99% obtained using separation strategy in Theorem 1 and intervalbased reachability are shown in Figure 1 (right).

VIII. CONCLUSION

We developed a framework for reachability analysis of control systems with stochastic disturbances. A key feature of our framework is that it separates the effect of stochastic disturbances and deterministic inputs in the evolution of the system. We use contraction theory to obtain probabilistic bounds on propagation of stochastic disturbances and use the existing contraction-based and interval-based reachability frameworks to over-approximate the effect of deterministic input/disturbance. It is well-known that, for linear stochastic systems, the marginal distribution of trajectories is Gaussian and has an exponential tail [40, Section 6.2]. However, our results (Propositions 1 and 2) only imply sub-linearity of the marginal distribution of trajectories for linear stochastic systems. Future work will explore whether, for nonlinear stochastic systems, the marginal distributions of trajectories exhibit the same exponential tail behavior.
