Intrinsic mixed-dimensional beam-shell-solid couplings in linear Cosserat continua via tangential differential calculus

Abstract

We present an approach to the coupling of mixed-dimensional continua by employing the mathematically enriched linear Cosserat micropolar model. The kinematical reduction of the model to lower dimensional domains leaves its fundamental degrees of freedom intact. Consequently, the degrees of freedom intrinsically agree even at the interface with a domain of a different dimensionality. Thus, this approach circumvents the need for intermediate finite elements or mortar methods. We introduce the derivations of all models of various dimensions using tangential differential calculus. The coupling itself is then achieved by defining a mixed-dimensional action functional with consistent Sobolev trace operators. Finally, we present numerical examples involving a three-dimensional silicone-rubber block reinforced with a curved graphite shell on its lower surface, a three-dimensional silver block reinforced with a graphite plate and beams, and lastly, intersecting silver shells reinforced with graphite beams.

Key words: mixed-dimensional coupling, Cosserat micropolar continua, shell elements, plate elements, beam elements, volume elements, finite element method.

1 Introduction

The design of structural parts in engineering practices often entails combinations of physically large and small components, for example in sandwich structures [13,35], compound composites [27], or fibre-reinforced materials [7, 52, 70, 92]. From a modelling point of view, it is often possible to consider these joint components as a single continuous body, and thus model its behaviour through a single continuum theory. However, from a computational perspective, the latter approach may prove inefficient or even unfeasible for a given computational power, as it requires the discretisation of the domain to bridge the scale-gap between the small scale components and the large scale components. This task is difficult in terms of both, generating satisfactory finite element meshes for high-fidelity simulations [75, 94, 95] (see also Fig. 6.7), as well as in the required computational effort that arises from the very fine mesh which is needed for scale-transition. Consequently, it is commonplace to regard designs containing small and large parts as mixed-dimensional continua. Let a d-dimensional body

 $\mathcal{B} \subset \mathbb{R}^d$ represent a large scale component, the smaller scale components can be modelled as continua on its k-codimensions $\Xi \subset \mathbb{R}^{d-k}$. This approach allows for coarser discretisations of both the large and small scale components, while compensating for inaccuracies in the behaviour of the small scale components with idealised models, which are fine-tuned for the expected behaviour in the small scale. However, since multiple continuum models are now used to model a single structural part, it becomes necessary to couple them in a single computational framework. The latter often proves challenging, as the differing continuum models may entail different types of degrees of freedom. A common example for the aforementioned difficulty and the focus of this work are kinematical couplings. Namely, in linear elasticity one is often compelled to couple the kinematical displacement field $\mathbf{u}: V \subset \mathbb{R}^3 \to \mathbb{R}^3$ of a three-dimensional body $V \subset \mathbb{R}^3$ with kinematical fields of codimensional models, such as shells or beams. For linear elasticity, the shell models are the Cosserat [9, 18-22, 53], and the classical Naghdi [37,63,64,74] and Koiter shells [22,28,62,73], or their flat correspondents, the Reissner-Mindlin [58, 68, 81] and Kirchhoff-Love plates [1, 65]. The beam models are the well-known Timoshenko-Ehrenfest [2, 89, 93] and Euler-Bernoulli [5, 41, 48] beams, and in the geometrically nonlinear case also the Cosserat beam [10, 34, 90], possibly with enhanced Saint-Venant torsion kinematics [25, 69, 78]. It is precisely in this scenario that the coupling becomes difficult, as the shell and beam models introduce rotation degrees of freedom $\theta:\Xi\subset\mathbb{R}^{3-k}\to\mathbb{R}^3$, which the three-dimensional model simply does not have. Thus, the coupling requires some additional treatment, e.g., using intermediate finite elements [6,43], static condensation [76,86], Nitsche's method [31,66], or mortar approaches [87,88,91]. Additionally and related to the approach in this work, in [8] the authors coupled the Euler-Bernoulli beam and Kirchhoff-Love plate using CutFEM, by exploiting that only one kinematic field is present in the mixed-dimensional problem. Specifically in mechanical continuum models it is clear that the difficulty in the coupling stems from the lacking agreement in degrees of freedom. As such, this work considers an alternative approach with an enriched continuum model [14, 15, 49, 57, 84], such that degrees of freedom intrinsically agree for all possible dimensions. Namely, this work employs the Cosserat micropolar theory as its starting point.

The Cosserat micropolar continuum [4, 51, 55, 60, 77], a concept introduced by the Cosserat brothers in 1909 [11], represents a generalised continuum model that extends beyond the classical Cauchy continuum theory. Unlike the Cauchy continuum, which considers material points characterised solely by their position, the Cosserat continuum also takes into account possible independent rotations of each material point, allowing for the introduction of more intricate kinematics. Effectively, the Cosserat theory turns each material point into a non-deformable solid microbody, implying the existence of a local micro-moment of inertia. Another consequence is the introduction of couple-forces $M: V \subset \mathbb{R}^3 \to \mathfrak{so}(3)$, relating to higher order tractions. Concisely, the Cosserat model naturally encompasses both a displacement field $\mathbf{u}: V \subset \mathbb{R}^3 \to \mathbb{R}^3$ and a rotation field $\boldsymbol{\theta}: V \subset \mathbb{R}^3 \to \mathbb{R}^3$, even in three-dimensional bodies $V \subset \mathbb{R}^3$. As a result, any dimensional reduction of the model to shells or beams leaves both the translational and rotational degrees of freedom intact. Therefore, the model is ideal for mixed-dimensional designs, as the degrees of freedom intrinsically agree even on interfaces of differing dimensionality $[\![\mathbf{u}]\!]_{\Xi} = [\![\boldsymbol{\theta}]\!]_{\Xi} = 0$. In fact, the coupling procedure is reduced to combining the bulk energy functional with lower dimensional energy functionals based on Sobolev trace operators [36] applied to the three-dimensional fields on codimensional domains $I_V(\mathbf{u}, \boldsymbol{\theta}) + I_A(\operatorname{tr}_A \mathbf{u}, \operatorname{tr}_A \boldsymbol{\theta}) + I_s(\operatorname{tr}_s \mathbf{u}, \operatorname{tr}_s \boldsymbol{\theta})$.

The derivation of reduced dimensional models is an involved procedure, especially if the lower dimensional domain is curved. This is the case since derivatives on curved domains are naturally expressed using differential geometry, implying the usage of co- and contravariant derivatives as well as Christoffel symbols. This makes the derivation process difficult to interpret, and the translation to a finite element software challenging. Alternatively, a recent approach called tangential differential calculus (TDC) [12,26,32] allows to circumvent the need for curvilinear coordinates and Christoffel symbols by introducing equivalent differentiation operators based on projections [30, 33, 73, 74]. To clarify, a gradient on a curved surface can be computed as the tangential projection of the gradient with respect to the Cartesian coordinates onto the surface $\nabla_t \lambda = \mathbf{P} \nabla \lambda$. If the surface is parameterised $\mathbf{r}:\omega\subset\mathbb{R}^2\to A\subset\mathbb{R}^3$, then the tangential gradient $\nabla_t\lambda$ and the gradient given by the chain-rule $\nabla \lambda$ are equivalent. We give a short summary of the relation of tangential differential calculus to classical differential geometry via tensor calculus [38] in Appendices A to F. While tangential differential calculus can also be used to introduce the geometry of the domain implicitly, e.g., with a level-set function [16, 42], we employ this framework for its advantageous applicability to automated solvers of partial differential equations. Specifically, the reinterpretation of co- and contravariant gradients as projected gradients of the global Cartesian system allows to directly define energy functionals or variational forms in the Cartesian sense, making it straightforward to script these functionals in frameworks like NGSolve [17,71,72], FEniCS [3,44], or Firedrake [29].

In this work we introduce the linear isotropic micropolar Cosserat model in three dimensions, and subsequently reduce it to shell-, plate- and beam models by means of kinematical assumptions and integration. The models all entail the same kinematical degrees of freedom, namely, displacements \mathbf{u} and rotations $\boldsymbol{\theta}$, and thus intrinsically agree on interfaces of mixed dimensionality $\Xi \subset \mathbb{R}^{d-k}$. The coupling itself is then achieved by restricting the bulk fields to codimensional domains using consistent Sobolev trace operators, yielding a mixed-dimensional action functional

The derivations in this work are done using tangential differential calculus, thus allowing for direct usage in automated solvers of partial differential equations. We employ NGSolve¹ to compute numerical solutions of three coupling examples², and finally, we discuss conclusions and outlook.

We emphasise that the resulting reduced models in this work do not coincide with the standard linear Naghdi shell [74] or the Reissner-Mindlin plate [81] formulations, nor with the traditional definition of the Cosserat rod [34] in the case of the beam formulations. This is because the aforementioned models are derived from the energy functional of the corresponding Cauchy continuum theory, as opposed to the energy functional of the Cosserat micropolar continuum that we employ here. However, all the models are referred to as Cosserat type by virtue of their descendance from the three-dimensional Cosserat model.

1.1 Notation

The following notation is used throughout this work. Exceptions to these rules are made clear in the precise context.

- Vectors are defined as bold lower-case letters $\mathbf{v}, \boldsymbol{\xi} \in \mathbb{R}^d$.
- Second order tensors are denoted with bold capital letters $T \in \mathbb{R}^{d \times d}$.
- Higher-order tensors are designated by the blackboard-bold format $\mathbb{C} \in \mathbb{R}^{d \times d \times d \dots}$.
- We denote the Cartesian basis as $\{e_1, e_2, e_3\}$.
- Summation over indices follows the standard rule of repeating indices. Latin indices represent summation over the full dimension, whereas Greek indices define summation over the co-dimension.
- The angle-brackets are used to define scalar products of arbitrary dimensions $\langle \mathbf{v}, \mathbf{u} \rangle = v_i u_i, \langle \mathbf{T}, \mathbf{F} \rangle = T_{ij} F_{ij}$.
- The matrix product is used to indicate all partial-contractions between a higher-order and a lower-order tensor $\mathbf{T}\mathbf{v} = T_{ij}v_j\mathbf{e}_i$, $\mathbb{C}\mathbf{T} = C_{ijkl}T_{kl}\mathbf{e}_i \otimes \mathbf{e}_j$.
- The second-order identity tensor is defined via 1, such that 1 v = v.
- The trace operator reads tr $T = \langle T, 1 \rangle$.
- A general physical body of some arbitrary dimension d is denoted with $\mathcal{B} \subset \mathbb{R}^d$.
- Volumes, surfaces and curves of the physical domain are identified via V, A and s, respectively. Their counterparts on the reference domain are $\Omega \subset \mathbb{R}^3$, $\omega \subset \mathbb{R}^2$ and $\gamma \subset \mathbb{R}$.
- Tangential and normal vectors on the physical domain are designated by \mathbf{t} and \mathbf{n} , respectively. On reference domain the respective vectors read $\boldsymbol{\tau}$ and $\boldsymbol{\nu}$.

- The space is associated with the operators skew $T = (1/2)(T T^T) \in \mathfrak{so}(d)$, Anti $\mathbf{v} = \mathbf{v} \times \mathbb{1} \in \mathfrak{so}(3)$, and its inverse $axl(Anti \mathbf{v}) = \mathbf{v}$.
- The nabla operator is defined as $\nabla = \mathbf{e}_i \partial_i$.
- The left-gradient is given via ∇ , such that $\nabla \lambda = \nabla \otimes \lambda$.
- The right-gradient is defined for vectors and higher order tensors via D, such that $D\mathbf{v} = \mathbf{v} \otimes \nabla$.

The linear Cosserat micropolar model 2

The internal energy of a three-dimensional Cosserat medium is given in dislocation form (Curl instead of gradient) [23, 39, 40, 59] by the functional

where $\mathbf{u}:V\subset\mathbb{R}^3\to\mathbb{R}^3$ is the displacement of the body $V\subset\mathbb{R}^3$. Its infinitesimal micro-rotation $\Theta:V\subset\mathbb{R}^3$ $\mathbb{R}^3 \to \mathfrak{so}(3)$ is given by the skew-symmetric tensor

where $\mathbb{E} \in \mathbb{R}^{3 \times 3 \times 3}$ is the third-order Levi-Civita permutation tensor. The infinitesimal micro-rotation tensor is characterised by the axial vector $\theta: V \subset \mathbb{R}^3 \to \mathbb{R}^3$. Consequently, its Curl can be written as

using Nye's formula [46,61]. The material tensor $\mathbb{C}_e:\mathbb{R}^{3\times3}\to\mathbb{R}^{3\times3}$ is positive definite, and assumed to be isotropic hereinafter

where $\mu_{\rm e}>0$ and $\lambda_{\rm e}\geq0$ are Lamé constants. The coupling between the infinitesimal macro-rotation skew Du and the infinitesimal micro-rotation Θ is governed by the Cosserat couple modulus $\mu_c > 0$. The characteristic length-scale parameter is denoted by $L_c > 0$, and $\mathbb{L} : \mathbb{R}^{3\times3} \to \mathbb{R}^{3\times3}$ is a positive definite isotropic fourth-order tensor of dimensionless weights

The external work for the medium is given by

where $\mathbf{f}: V \subset \mathbb{R}^3 \to \mathbb{R}^3$ are the body forces and $M: V \subset \mathbb{R}^3 \to \mathfrak{so}(3)$ are couple-forces. For simplicity, we do not consider external fluxes in this work, such that any Neumann boundary is always homogeneous. The balance of energy is expressed as the minimisation problem

In order to find minimisers $\{\widetilde{\mathbf{u}}, \widetilde{\boldsymbol{\theta}}\}$ we take variations with respect to the displacements and infinitesimal rotations. The variation with respect to the displacements \mathbf{u} yields

 on $A_D^{\mathbf{u}}$, (2.11e)

$$\Theta(\text{Anti }\mathbf{n}) = \widetilde{\Theta}(\text{Anti }\mathbf{n}) \qquad \text{on} \quad A_D^{\Theta}. \tag{2.11f}$$

Accordingly, the non-symmetric stress tensor is




Figure 2.1: The domain $V \subset \mathbb{R}^3$ of the linear Cosserat micropolar model with Neumann A_N and Dirichlet A_D boundaries under internal forces \mathbf{f} and couple-forces \mathbf{M} . The model can be intuitively understood as the superposition of a linear elastic Navier-Cauchy model with an infinitesimally thin fibre-matrix that reinforces the material with respect to bending and torsion.

The domain of the Cosserat model with boundary conditions is depicted in Fig. 2.1. We note that setting $\mu_c = 0$ decouples the equations, leaving $\mu_e L_c^2 \operatorname{Curl}(\mathbb{L} \operatorname{Curl} \Theta) = M$ as a standalone Curl-Curl problem. In contrast, the coefficient is redundant in the geometrically exact Cosserat model [23], and can be set to zero $\mu_c = 0$ in the related relaxed micromorphic model [24, 57, 83, 84] without decoupling the kinematical fields.

Hereinafter, we employ material norms for better readability of the shell and beam models, and compactness of notation. Namely, we define the norms

where we used the identity Eq. (2.3) for skew-symmetric tensors. Thus, the internal energy functional reads

The functional is composed of three energy densities pertaining to the displacement, rotational coupling, and dislocation, respectively.

2.1 Linear isotropic Cauchy materials

The Cosserat micropolar model intrinsically incorporates the classical Navier–Cauchy linear elasticity model into the structure of its energy functional. Namely, a highly homogeneous Cauchy medium is characterised by a vanishing characteristic length-scale parameter $L_c \to 0$, and the absence of couple-forces $\mathbf{M} = 0$ [56]. Thus, Eq. (2.11b) reads

$$-2\mu_{c} \operatorname{skew}(\mathrm{D}\mathbf{u} - \mathbf{\Theta}) = 0 \qquad \stackrel{\mu_{c} > 0}{\Longleftrightarrow} \qquad \mathbf{\Theta} = \operatorname{skew} \mathrm{D}\mathbf{u}, \qquad (2.16)$$

such that the internal energy functional yields

$$\frac{1}{2} \int_{V} \|\operatorname{sym} \operatorname{D} \mathbf{u}\|_{\mathbb{C}_{e}}^{2} + 2\mu_{c} \|\operatorname{skew}(\operatorname{D} \mathbf{u} - \boldsymbol{\Theta})\|^{2} + \mu_{e} L_{c}^{2} \|(\operatorname{div} \boldsymbol{\theta}) \mathbb{1} - (\operatorname{D} \boldsymbol{\theta})^{T}\|_{\mathbb{L}}^{2} dV \quad \mapsto \quad \frac{1}{2} \int_{V} \|\operatorname{sym} \operatorname{D} \mathbf{u}\|_{\mathbb{C}_{M}}^{2} dV,$$

$$(2.17)$$

where $\mathbb{C}_M: \mathbb{R}^{3\times 3} \to \mathbb{R}^{3\times 3}$ is the material tensor of linear isotopic Cauchy materials

$$\mathbb{C}_{\mathbf{M}} \mathbf{T} = 2\mu_{\mathbf{M}} \mathbf{T} + \lambda_{\mathbf{M}} (\operatorname{tr} \mathbf{T}) \mathbb{1}, \qquad \mathbf{T} \in \mathbb{R}^{3 \times 3}, \qquad (2.18)$$

with the Lamé constants $\mu_{\rm M}>0$ and $\lambda_{\rm M}\geq0$. In summary, it suffices to set $L_{\rm c}\to0$, M=0, $\mu_{\rm c}>0$ and $\mathbb{C}_{\rm e}=\mathbb{C}_{\rm M}$ in order to obtain the behaviour of the Navier–Cauchy model from the Cosserat model.

3 Linear isotropic Cosserat shells in three dimensions

Let the domain of a thin curved shell be given by the mapping

$$\mathbf{x}: \Omega \subset \mathbb{R}^3 \to V \subset \mathbb{R}^3, \qquad \Omega = \omega \times [-h/2, h/2], \qquad V = A \times [-h/2, h/2], \qquad (3.1)$$




Figure 3.1: Mapping of the flat reference domain to a shell in three-dimensional space $\mathbf{x}: \Omega \subset \mathbb{R}^3 \to V \subset \mathbb{R}^3$. The middle surface of the shell is mapped via $\mathbf{r}: \omega \subset \mathbb{R}^2 \to A \subset \mathbb{R}^3$, and the thickness via $\zeta \mathbf{n}$ with $\zeta \in [-h/2, h/2]$.

where $h \ll |A|$ is the thickness of the shell, we can write the mapping explicitly as

$$\mathbf{x}(\xi, \eta, \zeta) = \mathbf{r} + \zeta \mathbf{n}, \qquad \mathbf{r} = \mathbf{r}(\xi, \eta), \qquad \zeta \in [-h/2, /h/2],$$
 (3.2)

such that \mathbf{r} maps the middle surface of the shell $\mathbf{r}:\omega\subset\mathbb{R}^2\to A\subset\mathbb{R}^3$, and $\mathbf{n}=\mathbf{n}(\xi,\eta)$ is the unit normal vector of the surface, see Fig. 3.1. With the surface normal we can define corresponding tangential and normal projection operators

$$P = \mathbb{1} - \mathbf{n} \otimes \mathbf{n}$$
, $Q = \mathbf{n} \otimes \mathbf{n}$, $P : \mathbb{R}^3 \to T_p A$, $Q : \mathbb{R}^3 \to \mathbb{R}^3 \setminus T_p A$, (3.3)

where T_pA is the space of the tangential vectors of the surface A. Using the latter we split the symmetrised gradient of the displacements between its tangential and normal components

Consequently, the first energy density component in Eq. (2.15) can be expressed as

where $\|Q(\operatorname{sym} \operatorname{D}\mathbf{u})P\| = \|P(\operatorname{sym} \operatorname{D}\mathbf{u})Q\|$ due to symmetry. Analogously, we split the infinitesimal rotation tensor

where $Q\Theta Q = \langle \Theta, Q \rangle Q = 0$ due to its skew-symmetry $\Theta : V \subset \mathbb{R}^3 \to \mathfrak{so}(3)$. As such, the second energy density term is expanded to

where $\|\mathbf{Q}(\operatorname{skew} \operatorname{D}\mathbf{u} - \mathbf{\Theta})\mathbf{P}\| = \|\mathbf{P}(\operatorname{skew} \operatorname{D}\mathbf{u} - \mathbf{\Theta})\mathbf{Q}\|$ and $\mathbf{Q}(\operatorname{skew} \operatorname{D}\mathbf{u})\mathbf{Q} = (1/2)\mathbf{Q}(\operatorname{D}\mathbf{u} - [\operatorname{D}\mathbf{u}]^T)\mathbf{Q} = 0$ hold due to skew-symmetry. Putting it all together, the internal energy functional reads

$$I_{A}(\mathbf{u}, \boldsymbol{\theta}) = \frac{1}{2} \int_{V} \| \boldsymbol{P}(\operatorname{sym} \operatorname{D} \mathbf{u}) \boldsymbol{P} + \boldsymbol{Q}(\operatorname{sym} \operatorname{D} \mathbf{u}) \boldsymbol{Q} \|_{\mathbb{C}_{e}}^{2} + 4\mu_{e} \| \boldsymbol{Q}(\operatorname{sym} \operatorname{D} \mathbf{u}) \boldsymbol{P} \|^{2} + 4\mu_{c} \| \boldsymbol{Q}(\operatorname{skew} \operatorname{D} \mathbf{u} - \boldsymbol{\Theta}) \boldsymbol{P} \|^{2}$$

$$+ 2\mu_{c} \| \boldsymbol{P}(\operatorname{skew} \operatorname{D} \mathbf{u} - \boldsymbol{\Theta}) \boldsymbol{P} \|^{2} + \mu_{e} L_{c}^{2} \| (\operatorname{div} \boldsymbol{\theta}) \mathbb{1} - (\operatorname{D} \boldsymbol{\theta})^{T} \|_{\mathbb{L}}^{2} \, dV.$$

$$(3.8)$$

Integration of the energy over the volume is split across the middle surface and the thickness of the shell via

$$\int_{V} (\cdot) \, dV = \int_{A} \int_{-h/2}^{h/2} (\cdot) (1 - 2H \, \zeta + K \, \zeta^{2}) \, d\zeta dA, \qquad (3.9)$$

using the shell-shifter from Steiner's formula [18–21], see also Appendix D. The factor is composed of the mean and Gauß curvatures

$$H = \frac{1}{2} \operatorname{tr} \mathbf{W}, \qquad K = \det \mathbf{W}, \qquad (3.10)$$

being invariants of the Weingarten curvature tensor

whose derivation can be found in Appendix C. Thus, the energy functional is finally given as

3.1 The shell model

At this point we make standard engineering assumptions for the kinematics of the shell. Firstly, the infinitesimal rotation is constant throughout the thickness of the shell $\Theta \neq \Theta(\zeta)$. Secondly, the displacement vector takes the form

$$\mathbf{u}(\xi, \eta, \zeta) = \mathbf{v} + \zeta \mathbf{\Theta} \mathbf{n}, \qquad \mathbf{v} = \mathbf{v}(\xi, \eta), \qquad \mathbf{\Theta} = \mathbf{\Theta}(\xi, \eta), \qquad (3.13)$$

where $\mathbf{v}:\omega\subset\mathbb{R}^2\to\mathbb{R}^3$ is the displacement of the middle surface. In other words, no out-of-plane stretching is permitted, and displacements parallel to the middle surface $\mathbf{Pv}:\omega\subset\mathbb{R}^2\to T_pA$ are given by the translation of the middle surface \mathbf{v} together with its rotation $\zeta\mathbf{\Theta}\mathbf{n}$. Observe that $\mathbf{\Theta}=\mathrm{Anti}\,\boldsymbol{\theta}$ is still given by the three-dimensional axial vector $\boldsymbol{\theta}:\omega\subset\mathbb{R}^2\to\mathbb{R}^3$, such that constant drill throughout the thickness is possible. Using the projection operators we define tangential gradients with respect to the parametrisation of the middle surface $\mathbf{r}:\omega\subset\mathbb{R}^2\to A\subset\mathbb{R}^3$

$$\nabla_t(\cdot) = \mathbf{P}\nabla(\cdot), \qquad \qquad \mathbf{D}_t(\cdot) = [\mathbf{D}(\cdot)]\mathbf{P}. \tag{3.14}$$

The gradient of the displacement field can now be split across its tangential gradient and normal components via Eq. (E.13)

where $W = -D_t \mathbf{n}$ is the Weingarten curvature tensor, which is naturally tangential W = PWP as per Appendix C. Since $(\text{Anti }\mathbf{n})\mathbf{n} = 0$, we can further replace $(\text{Anti }\mathbf{n})D_t\theta$ with $(\text{Anti }\mathbf{n})D_t^{\text{cov}}\theta$ where

$$D_t^{cov} \boldsymbol{\theta} = \boldsymbol{P} D_t \boldsymbol{\theta} \,, \tag{3.17}$$

is the covariant gradient, finally yielding

$$D_t \mathbf{u} = D_t \mathbf{v} - \zeta [(\operatorname{Anti} \mathbf{n}) D_t^{\text{cov}} \boldsymbol{\theta} + \boldsymbol{\Theta} \boldsymbol{W}].$$
(3.18)

The normal part of the gradient is simply

$$(\mathbf{D}\mathbf{u})\mathbf{Q} = (\mathbf{\Theta}\mathbf{n}) \otimes \nabla \zeta = \mathbf{\Theta}\mathbf{n} \otimes \mathbf{n} = \mathbf{\Theta}\mathbf{Q}, \tag{3.19}$$

and for the micro-dislocation $\operatorname{Curl} \boldsymbol{\Theta}$ we find

seeing as $\Theta = (\Theta \circ \mathbf{r})(\xi, \eta)$. Next, we observe that $\mathbf{P}(\operatorname{sym} \operatorname{D}\mathbf{u})\mathbf{P} = \operatorname{sym}(\mathbf{P}[\operatorname{D}\mathbf{u}]\mathbf{P})$ yields

Analogously, we find

(3.22)

Further, there holds

$$\mathbf{Q}(\operatorname{sym} \operatorname{D}\mathbf{u})\mathbf{P} = \frac{1}{2}(\mathbf{Q}[\operatorname{D}\mathbf{u}]\mathbf{P} + \mathbf{Q}[\operatorname{D}\mathbf{u}]^{T}\mathbf{P}) = \frac{1}{2}(\mathbf{Q}\operatorname{D}_{t}\mathbf{v} - \zeta\mathbf{Q}\boldsymbol{\Theta}\mathbf{W}) - \frac{1}{2}\mathbf{Q}\boldsymbol{\Theta}\mathbf{P},$$
(3.23)

such that the skew-symmetric counterpart satisfies

$$Q(\operatorname{skew} \operatorname{D}\mathbf{u} - \mathbf{\Theta})P = \frac{1}{2}(Q\operatorname{D}_t\mathbf{v} - \zeta Q\mathbf{\Theta}W) + \frac{1}{2}Q\mathbf{\Theta}P - Q\mathbf{\Theta}P = \frac{1}{2}(Q\operatorname{D}_t\mathbf{v} - \zeta Q\mathbf{\Theta}W) - \frac{1}{2}Q\mathbf{\Theta}P, \quad (3.24)$$

where we use that $\mathbf{\Theta}^T = -\mathbf{\Theta}$. Lastly, the normal-normal part of the symmetrised gradient yields

$$Q(\operatorname{sym} \operatorname{D} \mathbf{u})Q = \operatorname{sym}(Q\operatorname{D} \mathbf{u}Q) = Q\Theta Q = 0, \qquad (3.25)$$

since $Q\Theta Q = \langle \Theta, Q \rangle Q = 0$. Consequently we can simplify the energy density terms of Eq. (3.12). We start by observing that

Here, we get that the normal-normal strain component vanishes. Following the classical Naghdi shell and corresponding Reissner–Mindlin plate formulations, this leads to an asymptotically improper model since an out-of-plane stress $Q\sigma Q$ arises from transverse contractions via the Poisson ratio [62]. Thus, we adopt the plane-stress assumption, such that the normal-normal component of the strain is condensed a priori and the corresponding stress component is set to vanish $Q\sigma Q = 0$. For the planar material tensor \mathbb{D}_e this implies that its material constants are adapted to those of plane stress

where E_e and ν_e are Young's modulus and the Poisson ratio, respectively. Observing that $\mathbf{Q}(\operatorname{sym} \operatorname{D}\mathbf{u})\mathbf{P} = \mathbf{Q}(\operatorname{skew} \operatorname{D}\mathbf{u} - \mathbf{\Theta})\mathbf{P}$, the next two energy density terms are combined into

For the skew-symmetric tangential-tangential energy term we find

Having derived the total energy, we employ asymptotic analysis to obtain the final shell model by eliminating ζ -terms of order three or higher $\mathcal{O}(\zeta^3)$, see Appendix G. These terms result in constants of order $\mathcal{O}(h^4)$ in the

thickness h, which is imperatively required to be very small $h \ll |A|$ for a well-defined formulation [62]. Thus, these terms are expected to generate insignificantly small energies for a thin shell and are therefore omitted. Further, we exploit that linear terms of the form of $(\cdot)\zeta$ vanish by the symmetry of integration over the thickness of the shell $\int_{-h/2}^{h/2} (\cdot) \zeta \, d\zeta = 0$. We integrate the energy densities multiplied with the shell-shifter $1 - 2H\zeta + K\zeta^2$ over the thickness in three steps. Firstly, we find the integral over the constant 1 to be

A common simplification at this point can be made for shells with a relatively small curvature, $H/|A| \ll 1$ and $K/|A| \ll 1$. Therein, also the terms Hh^3 and Kh^3 become insignificantly small $\mathcal{O}(h^4)$ and are thus omitted from the internal energy, yielding the final internal energy functional of the curved shell

The energy density terms in the functional can be interpreted with respect to their mechanical action. The first term of the functional gives the so-called membrane energy. By Eq. (B.18) it is apparent that the second term governs in-plane torque and is therefore the drill energy density [50], which does **not** appear in the Naghdi shell [74] or Reissner–Mindlin plate [81] models. The third term is given by the out-of-plane coefficients of the in-plane tensors, yielding the shear energy. The next three terms represent the bending energy, and the final term is the dislocation energy. Now, in order to construct a minimisation functional we simply redefine the forces and couple-forces as surface quantities

3.2 The plate model

A plate is defined as a flat shell model. Therefore, its kinematical assumptions are similar as for the curved shell but we have that $\mathbf{W} = 0$. Accordingly, we get that the mean curvature $H = (1/2) \operatorname{tr} \mathbf{W} = 0$ and the Gaussian




Figure 4.1: A three-dimensional beam mapped from the reference domain $\Omega \subset \mathbb{R}^3$ to the physical domain $V \subset \mathbb{R}^3$ via $\mathbf{x} : \Omega \subset \mathbb{R}^3 \to V \subset \mathbb{R}^3$. The cross-section $\omega \subset \mathbb{R}^2$ of the beam is left unchanged by the mapping. The centroid line of the beam is mapped by $\mathbf{r} : [0, l] \to \mathbb{R}^3$.

curvature $K = \det \mathbf{W} = 0$ also vanish. Consequently, the internal energy functional is reduced to

The form can be even further simplified if the plate is embedded in the x-y or y-z planes.

3.3 A membrane-shell model

In the case of an extremely thin shell $h/|A| \ll 1$, the term h^3 becomes negligible $\mathcal{O}(h^3)$, such that the energy functional reduces to

Interestingly, the functional naturally discards any explicit energy terms related to curvature. However, the Weingarten tensor \boldsymbol{W} and its invariants still influence the energy implicitly, which can be directly observed by taking derivatives of the kinematic fields defined on the curvilinear coordinates of the shell.

4 Linear three-dimensional Cosserat beams

Let $\mathbf{r} = \mathbf{r}(s)$ map the centroid curve of some three-dimensional beam, parameterised by the arc-length parameter $s \in [0, l]$ and equipped with the accompanying normal vectors $\mathbf{n}(s) \perp \mathbf{t}(s)$ and $\mathbf{c}(s) = \mathbf{t} \times \mathbf{n}$, the beam domain is given by

where $l \ge 0 \setminus \{0\}$ is the length of the beam and $\{\eta, \zeta\}$ define the cross-section of the beam $\omega \subset \mathbb{R}^2$, see Fig. 4.1. The initial orientation of the cross-section of the beam is given by the choice of \mathbf{n} , and \mathbf{we} exclude twists of its cross-section in the mapping $\tau = 0$, see Appendix F. The unit tangent vector of the centroid curve is given by

where $T_p s = \operatorname{span}\{\mathbf{t}\}$ is the space of tangential vectors to the curve. Following the same procedure as for the shell models, we employ the decomposition of $\operatorname{sym} \mathbf{D}\mathbf{u}$ and $\operatorname{skew}(\mathbf{D}\mathbf{u} - \mathbf{\Theta})$ using the projectors. The decomposition of $\operatorname{sym} \mathbf{D}\mathbf{u}$ yields the same result as in Eq. (3.5), but the projection operators are now those of the beam. Observe that $\mathbf{P} = \mathbf{t} \otimes \mathbf{t}$ implies $\mathbf{P}[\operatorname{skew}(\mathbf{D}\mathbf{u}) - \mathbf{\Theta}]\mathbf{P} = \langle \operatorname{skew} \mathbf{D}\mathbf{u} - \mathbf{\Theta}, \mathbf{P} \rangle \mathbf{P} = 0$ due to skew-symmetry. Thus, Eq. (3.7) changes to

where we use Eq. (F.22) to decompose the integral over the volume of the beam across its cross-section surface $\omega \subset \mathbb{R}^2$ and length $[0, l] \subset \mathbb{R}$.

4.1 The beam model

The kinematic of the beam is given via

where $\mathbf{v}:[0,l]\to\mathbb{R}^3$ is the translation of the centroid curve and $\mathbf{\Theta}\neq\mathbf{\Theta}(\eta,\zeta)$ is assumed to be constant throughout the cross-section of the beam. In the framework of tangential differential calculus, the gradient of the displacement field can be expressed as

where the differential operators of the dislocation density are inherently tangential. Observe that since the parametrisation is with respect to the centroid-line of the beam, integrals of the form $\int_{\omega} \eta \, d\omega = \int_{\omega} \zeta \, d\omega = 0$ vanish. Further, we restrict the formulation to cross-sections that are symmetric with respect to at least the η -or the ζ -axis. Thus, mixed terms of the form $\int_{\omega} \eta \zeta \, d\omega = 0$ also vanish. By definition we have that

represent the cross-section surface and the classical second order moments of inertia, respectively. Lastly, assuming the curvature of the beam is relatively small $(|\kappa_n| + |\kappa_c|)/|l \ll 1$, using asymptotic analysis we omit quadratic terms multiplied by curvatures, cubic and higher order terms. The latter implies that in the integration, the shifter term $1 - \kappa_n \eta - \kappa_c \zeta$ is essentially reduced to 1. Consequently, the integration of the first energy term yields

By their mechanical action, the first term is the membrane energy, the next two terms are the bending energy, and the fourth term is the shear energy density. The two subsequent terms represent warp torsion energy since

couple rotations perpendicular to the curvature with the rotational intensity. One can observe that $\operatorname{div}_t \boldsymbol{\theta}$ relates to the change in torque θ^t via

as the remaining terms of the gradient $D_t\theta$ are not tangential-tangential and thus eliminated, compare Appendix F. Lastly, the endmost term is the dislocation energy. Now, for the minimisation functional we simply reformulate the forces and couple-forces as curve quantities

4.2 The straight beam model

If the beam is not curved $\kappa_n = \kappa_c = 0$, then the energy functional simplifies to

where we used Eq. (4.20) to obtain $\|\mathbf{Q}(\operatorname{Anti}\mathbf{n})D_t\boldsymbol{\theta}\|^2 = \|\mathbf{Q}(\operatorname{Anti}\mathbf{c})D_t\boldsymbol{\theta}\|^2 = \|\operatorname{div}_t\boldsymbol{\theta}\|^2$, enabling the combination of I_{η} and I_{ζ} to the polar second order moment of inertia $I_p = I_{\eta} + I_{\zeta}$. The form can be further simplified if the beam is embedded in the x-axis with its cross-section aligned to the y-z-plane.

4.3 A micro-beam model

A special Cosserat beam model can be derived under the assumption that the surface of the beam is very small $|A|/l \ll 1$, implying that the second order moments of inertia $I_{\eta} \to 0$ and $I_{\zeta} \to 0$ vanish. In this scenario the energy functional reduces to

Analogously to the membrane-shell model, we get that the micro-beam model is naturally independent of any explicit curvature energy terms.

5 Discretisation




Figure 5.1: Trace operators from a meshed three-dimensional domain $V \subset \mathbb{R}^3$ of three tetrahedral elements to domains of codimensions one $\Xi_1 \subset \mathbb{R}^{3-1}$ of two triangles and two $\Xi_2 \subset \mathbb{R}^{3-2}$ of a single line. The operators yield valid finite element spaces on the lower dimensional entities. Namely, restricting the continuous three-dimensional Lagrange space $\mathcal{CG}^p(V)$ onto Ξ_1 or Ξ_2 via tr_A or tr_s yields the equivalent Lagrange space on these lower dimensional domains, being $\mathcal{CG}^p(\Xi_1)$ and $\mathcal{CG}^p(\Xi_2)$. Analogously, the tangential trace operator tr_A^t yields a valid surface Nédélec finite element space $\mathcal{N}_{II}^{p-1}(\Xi_1) \supset \nabla_t \mathcal{CG}^p(\Xi_1)$ from the volumetric Nédélec space $\mathcal{N}_{II}^{p-1}(V) \supset \nabla \mathcal{CG}^p V$, and the application of the second tangential trace operator tr_s^t onto a curve is a valid discontinuous Lagrange space on it $[\mathcal{DG}^{p-1}(\Xi_2)]\mathbf{t} = \nabla_t \mathcal{CG}^p(\Xi_2)$.

The volumetric geometry of the domain is discretised using finite element meshing procedures. Correspondingly, the geometry of any embedded shell or beam in the domain is explicitly controlled by the meshing procedure as well. In other words, so-called conforming meshes are required, where the geometries of the lower dimensional shell and beams are clearly identified as faces and lines of three-dimensional polyhedra, compare Fig. 5.1.

The displacement and infinitesimal rotation fields of the three-dimensional Cosserat model are defined using $C^0(V)$ -continuous Lagrange elements $\mathbf{u}, \boldsymbol{\theta} \in [\mathcal{CG}^p(V)]^3 \subset [H^1(V)]^3$ over the volumetric domain $V \subset \mathbb{R}^3$. The coupling with the lower dimensional models is now achieved by restriction of the fields to codimensional domains using consistent Sobolev trace operators [36], as depicted in Fig. 5.1. For the middle surface $A \subset \mathbb{R}^3$ of a shell we have

where $P = \mathbb{1} - \mathbf{n} \otimes \mathbf{n}$, and analogously for the centroid line $s \subset \mathbb{R}^3$ of beams

where for curves we have $P = \mathbf{t} \otimes \mathbf{t}$. This approach is naturally consistent on the finite element spaces since scalar products and norms remain well-defined and square integrable. There hold the relations

where $\mathcal{N}_{II}^{p-1}(V) \supset \nabla \mathcal{CG}^p(V)$, $\mathcal{N}_{II}^{p-1}(A) \supset \nabla_t \mathcal{CG}^p(A)$ are the respective volume and surface Nédélec elements of the second type [54,79,80,85], and $[\mathcal{DG}^{p-1}(s)]\mathbf{t} = \nabla_t \mathcal{CG}^p(s)$ are discontinuous Lagrange elements on the curve. Thus, the total mixed-dimensional energy functional can be naturally defined using the single discretisation $\{\mathbf{u}, \boldsymbol{\theta}\} \in [\mathcal{CG}^p(V)]^3 \times [\mathcal{CG}^p(V)]^3$ as

where $I_V(\mathbf{u}, \boldsymbol{\theta})$ is the energy of the volumetric Cosserat model, $I_A(\operatorname{tr}_A \mathbf{u}, \operatorname{tr}_A \boldsymbol{\theta})$ is the energy of an embedded shell, and correspondingly $I_s(\operatorname{tr}_s \mathbf{u}, \operatorname{tr}_s \boldsymbol{\theta})$ is the energy of an embedded beam. To clarify, the displacement field of the shell is simply set to $\mathbf{v} = \operatorname{tr}_A \mathbf{u}$, and analogously for the beam we have $\mathbf{v} = \operatorname{tr}_s \mathbf{u}$. Accordingly, the total external work is given by

such that $L_V(\mathbf{u}, \boldsymbol{\theta})$ is the volumetric work, $L_A(\operatorname{tr}_A \mathbf{u}, \operatorname{tr}_A \boldsymbol{\theta})$ is work on an embedded shell, and $L_s(\operatorname{tr}_s \mathbf{u}, \operatorname{tr}_s \boldsymbol{\theta})$ is the work of an embedded beam. Finally, the discrete problem reads

We remark that, since traces of the kinematical bulk-fields are used to define the corresponding fields on codimensional domains, the Dirichlet boundary conditions of the fields on the codimensional domains are explicitly embedded in the finite element spaces of the bulk-fields. Further, although the C^0 -regularity of the displacement and rotation fields, \mathbf{u} and $\boldsymbol{\theta}$, as well as the tangential regularity of their gradients, $\mathbf{D}\mathbf{u}$ and $\mathbf{D}\boldsymbol{\theta}$, are guaranteed by construction, jumps in stiffness or material coefficients naturally lead to jumps in the resulting stress field $\|\boldsymbol{\sigma}\| \neq 0$, see Eq. (2.12). This is not specific to the proposed method or the Cosserat model, and appears also in classical models of linear elasticity, compare [82] for an example with the Reissner–Mindlin plate model.

6 Numerical examples

In the following we compute three examples using NGSolve with **cubic** order Lagrange polynomials $\mathcal{CG}^3(V)$, to mitigate potential locking effects [63,81]. In the first example we consider the 3D-2D-coupling of a volume with shells, while the second example demonstrates the 3D-2D-1D coupling of a volume with a plate and beams. The last example showcases the 2D-1D coupling of shells and beams with intersections. The examples are available as open-source files under the link in Fn. 2.

6.1 Reinforcement with a stiff shell

In the following we consider a three-dimensional domain made of silicone rubber and reinforce it with shells made of graphite. The domain is given by




Figure 6.1: Illustration of the volumetric domain V with Dirichlet boundary conditions on A_D^1 and body force \mathbf{f} . The domain is subsequently reinforced with a stiff shell defined on its lower surface Ξ .

such that its length is $400\,\mathrm{mm}$, its minimal width is $80\,\mathrm{mm}$, its maximal width is $240\,\mathrm{mm}$ and its thickness is $10\,\mathrm{mm}$, see Fig. 6.1. The three-dimensional body is made of silicone rubber, whose Lamé parameters read

, $\mu_{\rm M} \approx 0.34 \,\mathrm{MPa}$, (6.2)

such that its Poisson ratio is $\nu \approx 0.47$. Consequently, this type of rubber is still compressible and volumetric locking does not occur in numerical simulations. The volume force acting on the domain is

pointing downwards. We start by fine-tuning the characteristic length-scale parameter L_c of the Cosserat model to capture an equivalent solution to that of the Navier-Cauchy model. We set




Figure 6.2: Convergence of the Cosserat model for $L_c \to 0$ towards the equivalent Navier–Cauchy model of linear elasticity (a), and the corresponding displacement field \mathbf{u} for $L_c = 1 \,\mathrm{mm}$ (b), and $L_c = 10^{-2} \,\mathrm{mm}$ (c).

where the boundary surfaces read

such that the displacement vanishes on $x=\pm 400$. For the rotations the entire boundary is homogeneous Neumann $A_N^{\Theta}=\partial V$. The resulting convergence in relative energy and displacements is given in Fig. 6.2, where we compare with a classical Navier–Cauchy formulation of the same domain. We observe that for $L_c \leq 1/\sqrt{10}$ mm the convergence flattens towards a relative difference of < 1% in both the energy and the displacements. Still, even for $L_c=1$ mm we observe max $\|\mathbf{u}\|\approx 15.46$ mm in comparison to max $\|\mathbf{u}\|\approx 16.28$ mm for $L_c=10^{-2}$ mm, which is equivalent to the result of the Navier–Cauchy model. We note that it is not possible to exactly capture the Navier–Cauchy model with the Cosserat model numerically, since $L_c\to 0$ implies $\mathbf{\Theta}=\text{skew}\,\mathbf{D}\mathbf{u}$, but these fields belong to different discrete spaces. Namely, skew $\mathbf{D}\mathbf{u}$ is discontinuous while $\mathbf{\Theta}$ is continuous. Still, the deviation for $L_c \leq 10^{-2}$ mm is insignificantly small, such that we henceforth use $L_c=10^{-2}$ mm in our computations. We remark that although an alternative computation with $\mu_c\to 0$ via $\mu_c=10^{-7}$ MPa ≈ 0 and $L_c=1$ mm leads to an equivalent result with max $\|\mathbf{u}\|\approx 16.31$ mm, at the limit $\lim \mu_c\to 0$ this approach amounts to solving two independent problems. Namely, $-\mathrm{Div}(\mathbb{C}_{\mathrm{M}}\,\mathrm{sym}\,\mathbf{D}\mathbf{u})=\mathbf{f}$ and $\mu_e L_c^2\,\mathrm{Curl}(\mathbb{L}\,\mathrm{Curl}\,\mathbf{\Theta})=0$, resulting in skew $\mathrm{D}\mathbf{u}\neq\mathbf{\Theta}\to 0$ evidenced by $\|\mathrm{skew}\,\mathrm{D}\mathbf{u}\|_{L^2}\approx 96.42\neq \|\mathbf{\Theta}\|_{L^2}\approx 1.59$ for $\mu_c=10^{-7}\,\mathrm{MPa}$, such that the coupling of the infinitesimal macro-rotation skew $\mathrm{D}\mathbf{u}$ and the infinitesimal micro-rotation $\mathbf{\Theta}$ is lost. For $\mu_c=0$ with no Dirichlet boundary $|A_D^{\mathbf{\Theta}}|=0$ the problem is not well-posed.

The design in Fig. 6.2 is made of extremely soft silicone rubber, leading to deformations of $\approx 16\,\mathrm{mm}$ even for the very small volume force of $10^{-6}\,\mathrm{N/mm^3}$. The deformation can be substantially reduced by adding a thin




Figure 6.3: Finite element mesh with 7680 cubic Lagrange elements, where the bottom surface $\Xi \subset \partial V$ is implicitly reinforced with shells via the energy $I_A(\operatorname{tr}_A \mathbf{u}, \operatorname{tr}_A \boldsymbol{\theta})$ (a). Resulting displacement field of the shell (b) and membrane-shell (c) formulations in mm.

reinforcement layer at the bottom surface of the shell

$$\Xi = \{ (\xi, \eta) \in [0, 1]^2 \mid \mathbf{r} = \begin{bmatrix} 200(2\xi - 1) & 40(2\eta - 1)(3 - 2[2\xi - 1]^2) & -70\sin(4\xi - 2) \end{bmatrix}^T \},$$
 (6.8)

which is simply the parametrisation of the domain evaluated with $\zeta = 0$. We do so using the presented shell models composed of graphite. The material coefficients of the considered graphite @1.6 mm (H237) material read

$$\lambda_{\rm e} = 289.451 \,\mathrm{MPa}\,, \qquad \qquad \mu_{\rm e} = 2122.64 \,\mathrm{MPa}\,, \qquad \qquad \mu_{\rm c} \to +\infty\,,$$

$$\mu_{\rm e} L_{\rm c} a_1 = 10867.9 \,\mathrm{N}\,, \qquad \qquad \mu_{\rm e} L_{\rm c} a_2 = 122264 \,\mathrm{N}\,, \qquad \qquad \mu_{\rm e} L_{\rm c} a_3 = 0\,, \tag{6.9}$$

stemming from the experimental results in [45]. Conversion formulae of the material coefficients between different forms of the Cosserat model are available in [23]. We note that the characterisation does not allow to determine L_c , a_1 , and a_2 individually, but can still be used in the simulation. For the infinitely large Cosserat couple modulus $\mu_c \to +\infty$ [47] we take a value one order of magnitude higher than μ_e for simplicity $\mu_c = 10000 \,\mathrm{MPa}$, assuming it is sufficient to enforce the implied constraint

$$\mu_{\rm c} \to +\infty$$
: $\mathbf{\Theta} = \operatorname{skew} \operatorname{D} \mathbf{u}$, $\operatorname{Curl} \mathbf{\Theta} = \operatorname{Curl} (\operatorname{skew} \operatorname{D} \mathbf{u}) = -\frac{1}{2} \operatorname{Curl} (\operatorname{D} \mathbf{u})^T = -\frac{1}{2} (\operatorname{D} \operatorname{curl} \mathbf{u})^T$, (6.10)

which must be satisfied for finite energies. We compare the result of the shell and membrane-shell formulations in Fig. 6.3 setting the shell-thickness to $h=1.6\,\mathrm{mm}$, representing one layer of the graphite material. The maximal displacement using the shell formulation from Section 3.1 is $\max \|\mathbf{u}\| \approx 0.068\,\mathrm{mm}$. In comparison, the membrane-shell formulation from Section 3.3 yields $\max \|\mathbf{u}\| \approx 0.073\,\mathrm{mm}$. Clearly, for both formulations we observe a significant reduction in the deformation from $\max \|\mathbf{u}\| \approx 16.28\,\mathrm{mm}$, corroborating our shell-volume coupling approach. The relative difference between the two methods given by $100(0.073-0.068)/(0.073) \approx 6.8\,\%$ suggests that for this small thickness the higher order energy terms relating to bending and curvature are negligible.

6.2 A cantilever beam

In the following we consider a simple beam shaped domain

$$\overline{V} = [0, 500] \times [0, 100] \times [0, 15],$$
(6.11)

such that its length is $500 \,\mathrm{mm}$, its width is $100 \,\mathrm{mm}$ and its thickness is $15 \,\mathrm{mm}$. The domain is loaded with the vertical volume force

$$\mathbf{f} = -f\mathbf{e}_3,$$
 $f = 10^{-5} \,\text{N/mm}^3.$ (6.12)




Figure 6.4: Depiction of the bulk domain V with its Dirichlet boundary $A_D^{\mathbf{u}}$, the codimensional domain of the embedded plate Ξ_1 , and the centroid lines of the beams on both sides of the plate given by Ξ_2 (a). Deformation of the cantilever domain without any reinforcement (b) in mm.

The bulk of the domain is set to be made of silver, such that its Lamé parameters read

$$\lambda_{\rm M} \approx 98.5 \,\mathrm{MPa}$$
, $\mu_{\rm M} \approx 30 \,\mathrm{MPa}$, (6.13)

implying a Poisson ration of about $\nu \approx 0.38$. We define the Dirichlet boundary for the displacement as

$$\mathbf{u}\Big|_{A_D^{\mathbf{u}}} = 0, \qquad A_D^{\mathbf{u}} = [0, 0] \times [0, 100] \times [0, 15], \qquad (6.14)$$

implying the kinematics of a cantilever beam. The complete boundary of the rotation field is set to be homogeneous Neumann $A_N^{\Theta} = \partial V$. Testing for various values of the characteristic $L_{\rm c}$ while setting $\mu_{\rm c} = 1$ and $\mathbb{L}\operatorname{Curl}\Theta = \operatorname{id}(\operatorname{Curl}\Theta) = \operatorname{Curl}\Theta$, we find the maximal deformation for $L_{\rm c} = 10^{-2}$, such that lower values of $L_{\rm c}$ do not increase the deformation. As such, we conclude that for $L_{\rm c} = 10^{-2}$ we retrieve the equivalent Navier–Cauchy solution. We successively reinforce the bulk domain with a plate and beams made out the graphite @1.6 mm (H237) from the previous example. The thickness of the plate is again set to h = 1.6 mm. The beam is defined with a full circular cross-section of radius r = 0.8 mm, such that its surface and moments of inertia read

$$A = \pi r^2 = 0.64\pi \,\mathrm{mm}^2$$
, $I_{\eta} = I_{\zeta} = \frac{1}{4}\pi r^4 = 0.1024\pi \,\mathrm{mm}^4$. (6.15)

Due to its full symmetry the choice of its orientation given by the $\bf n$ and $\bf c$ vectors is inconsequential. The plate reinforcement of the bulk is on codimension one. Its surface is defined as

$$\overline{\Xi}_1 = [0, 500] \times [0, 100] \times [10, 10]$$
 (6.16)

Further, on two sides of Ξ_1 we introduce beam reinforcements




Figure 6.5: Deformations of the cantilever domain with beam reinforcements (a), plate reinforcement (b), and the combined plate and beam reinforcements (c) in mm.

$$\overline{\Xi}_2 = \{ [0, 500] \times [0, 0] \times [10, 10] \} \cup \{ [0, 500] \times [100, 100] \times [10, 10] \}, \tag{6.17}$$

on codimension one of the surface, representing codimension two of the bulk. Thus, we embed in the volume at $z=10\,\mathrm{mm}$ a plate, and two beams at the same depth with y=0 and y=100. The domain with its reinforcement is illustrated in Fig. 6.4. The maximal deformation without any reinforcement is also depicted in Fig. 6.4, reading $\max \|\mathbf{u}\| \approx 48.49\,\mathrm{mm}$. After reinforcement with two beams the maximal deformation reduces to $\max \|\mathbf{u}\| \approx 37.04\,\mathrm{mm}$. Alternatively, reinforcing the bulk with the plate yields $\max \|\mathbf{u}\| \approx 16.71\,\mathrm{mm}$. Finally, combining both reinforcements leads to the maximal deformation $\max \|\mathbf{u}\| \approx 0.08\,\mathrm{mm}$. The respective deformation results are depicted in Fig. 6.5. We observe the expected kinematical behaviour. Firstly, the reinforcement with beams is less pronounced than the effect of reinforcing with the plate. Secondly, the combined reinforcements yield a stiffness-additive solution, which is the natural outcome for linear elastic mechanics. We note that we do not retrieve an absolute super-positional solution, which is presumably due to the stiffening effect of the rotations also in x- and z-directions.

Due to the lack of analytical results or a sound mixed-dimensional error estimator it is difficult to undertake convergence studies in order to estimate the quality of the mixed-dimensional approximation. Comparisons




Figure 6.6: Fully volumetric definition of the plate-reinforced bulk model with the explicit thickness h.

with fully volumetric discretisations are also restricted, as the reduced models are an idealisation of the three-dimensional kinematics, incapable of capturing the full mechanical phenomenon. Nevertheless, we propose a weighted bulk benchmark to evaluate the approximation power of the coupled plate model to some extent. The plate model allows for a rudimentary comparison due to its simple geometry, in contrast to the additional errors induced by the non-smooth geometrical approximation of curved shells. We start by splitting the bulk domain across two volumes

$$\overline{V} = \overline{V}_V \cup \overline{V}_{\Xi_1}, \quad \overline{V}_V = \{ [0, 500] \times [0, 100] \times [0, 10 - h/2] \} \cup \{ [0, 500] \times [0, 100] \times [10 + h/2, 15] \}, \quad \overline{V}_{\Xi_1} = [0, 500] \times [0, 100] \times [10 - h/2, 10 + h/2],$$




Figure 6.7: Convergence of the maximal displacement towards the limit of $\approx 16.36 \,\mathrm{mm}$ (a). Volumetric Mesh of the cantilever beam domain with $h = 0.8 \,\mathrm{mm}$, demonstrating the growing amount of elements which are need for scale-transition (b). Norm of the displacement field of the full volumetric model for $h = 0.4 \,\mathrm{mm}$ on a mesh of 129008 quadratic elements with 1118430 degrees of freedom (c).

$$(6.18)$$

such that \overline{V}_V is the domain made of silver, and \overline{V}_{Ξ_1} represents the domain of the plate with thickness h made of graphite, see Fig. 6.6. Clearly, the larger h is, the less silver the domain V is composed of, and the stiffer the it becomes. However, in the mixed-dimensional model the thickness of the plate does not explicitly appear in the discretisation of the geometry, such that it does not affect the volume of the silver-made domain. At the same time, reducing h in the fully volumetric model in order to account for this inconsistency reduces the overall stiffness of the model, although it remains constant in the corresponding mixed-dimensional model h=1.6 mm. Thus, we study the behaviour of the comparable fully volumetric model by decreasing the thickness h, while simultaneously compensating for this loss in stiffness with a linear scaling factor $k=1.6/h\geq 1$. This multiplicative factor is applied to the material coefficients of the graphite-made domain. We use quadratic Lagrange elements for the computation with $h \in \{1.6, 1.2, 0.8, 0.4\}$ mm, such that the scaling factor reads $k \in \{1, 4/3, 2, 4\}$. The convergence, along with the mesh for $h = 0.8 \,\mathrm{mm}$ and the displacement for $h = 0.4 \,\mathrm{mm}$ are depicted in Fig. 6.7. Clearly, taking the value h=0 is impossible as it implies a zero volume and $k\to +\infty$. Even for h < 0.3 it already becomes difficult to generate satisfactory meshes that are manageable from a computational perspective. As such, we instead extrapolate the remaining values of the convergence curve with a curve-fitting based on a generic exponential function $f(h) = ae^{bh} + c$ with $a, b, c \in \mathbb{R}$. As seen in Fig. 6.7, the fitting perfectly matches the computed values and predicts a maximal displacement of max $\|\mathbf{u}\| \approx 16.36 \,\mathrm{mm}$ for $h \to 0$. Thus, the relative difference in the maximal displacement between the fully volumetric model and the mixed-dimensional model is $100(16.71 - 16.36)/16.71 \approx 2.09\%$ or 16.71 - 16.36 = 0.35 mm in absolute values. This relatively small difference implies a good agreement between the two models, and demonstrates the accurate prediction power of the mixed-dimensional approach. Further, since the mixed-dimensional model slightly under-estimates the stiffness of the system and therefore over-estimates the deformation, the result is on the so-called safe side for subsequent design decisions.

6.3 An Z-shaped reinforced shell

The proposed coupling procedure is general across dimensions due to the degrees of freedom of the underlying linear Cosserat continuum. In particular, shells naturally include in-plane drill rotations. The fact that a three-dimensional rotation vector composed of three independent rotation fields is present in every model irrespective of dimensionality allows for seamless interaction **even across intersections**. This feature is greatly facilitated by the use of tangential differential calculus (TDC), since both the displacement field \mathbf{u} and the rotation field $\boldsymbol{\theta}$ are defined on the Cartesian system. In other words, whether a rotation represents drill for one shell but bending for another is determined solely by the projections and no explicit transformations to the coordinate system of any hyper-surface are required. The same holds true analogously for intersecting beams with respect to bending and torsion. The final example serves to demonstrate this feature for 2D-1D couplings.

We consider a reflected S-shaped (2-shape) domain constructed of two half-circles

$$\bar{s}_1 = \{ \phi \in [\pi/2, 3\pi/4] \mid \mathbf{r} = \begin{bmatrix} 0 & 50\cos\phi & 50(\sin\phi - 1) \end{bmatrix}^T \},
\bar{s}_2 = \{ \phi \in [-\pi/2, \pi/2] \mid \mathbf{r} = \begin{bmatrix} 0 & 50\cos\phi & 50(\sin\phi + 1) \end{bmatrix}^T \},$$
(6.19)

with a line crossing their intersection

$$\bar{s}_3 = [0, -100, 0] \times [0, 100, 0].$$
 (6.20)

The shell surface is then defined via the extrusion

$$\overline{A} = [0, 500] \times \{\overline{s}_1 \cup \overline{s}_2 \cup \overline{s}_3\}. \tag{6.21}$$

Accordingly, the radius of the circles is 50 mm, the middle plate has the width of 200 mm, and the length of the structure is 500 mm. The Dirichlet boundary s_D is defined on the edge curves at x = 0 and is applied such that both the displacements and rotations vanish

$$\mathbf{u} \Big|_{s_D} = \boldsymbol{\theta} \Big|_{s_D} = 0. \tag{6.22}$$

The shell is set to be made of silver with thickness $h = 1.6 \,\mathrm{mm}$ and is subsequently reinforced with beams of a circular cross-section with $r = 0.8 \,\mathrm{mm}$ made of graphite. Curved beams are defined along the 2-curves, whereas straight lines are defined with the straight beam model

$$\overline{\Xi} = \{ (\eta, \phi) \in \{0, 1, \dots, 10\} \times [\pi/2, 3\pi/4] \mid \mathbf{r} = 50 \left[\eta \cos \phi \quad (\sin \phi - 1) \right]^T \}
\cup \{ (\eta, \phi) \in \{0, 1, \dots, 10\} \times [-\pi/2, \pi/2] \mid \mathbf{r} = 50 \left[\eta \cos \phi \quad (\sin \phi - 1) \right]^T \}
\cup \{ (x, y) \in [0, 500] \times \{ -100, 0, 100 \} \mid \mathbf{r} = \begin{bmatrix} x & y & 0 \end{bmatrix}^T \}
\cup \{ (x, y) \in \{0, 500\} \times [-100, 100] \mid \mathbf{r} = \begin{bmatrix} x & y & 0 \end{bmatrix}^T \} ,$$
(6.23)




Figure 6.8: Domain of the shell A with its codimensional reinforcement-frame Ξ and Dirichlet boundary s_D (a). Deformation of the shell without reinforcement (b), and with reinforcement (c).

representing codimensional domains on the surface of the shell. The corresponding material coefficients can be found in the previous examples. The force is applied as a line load in N/mm to the upper and lower horizontal edges of the shell structure

$$\mathbf{q} = q \begin{bmatrix} 0 \\ 1 \\ 0 \end{bmatrix}, \qquad q = \begin{cases} -10^{-4} z & \text{for } z = \pm 100 \\ 0 & \text{otherwise} \end{cases}, \tag{6.24}$$

implying torsion. The domain along with its reinforcing frame and the resulting displacements for 620 cubic elements are depicted in Fig. 6.8. We clearly observe the resulting warp-torsion deformation of the non-reinforced thin structure with a maximal displacement of max $\|\mathbf{u}\| \approx 41.14\,\mathrm{mm}$. Activating the beam-frame reinforcement reduces the maximal displacement to max $\|\mathbf{u}\| \approx 0.26\,\mathrm{mm}$. The intersection of multiple shells and beams with differing orientations poses no challenge to the proposed coupling approach, as evident by the symmetric displacement solutions.

7 Conclusions and outlook

In this work we employed the linear Cosserat micropolar model in dislocation form to derive corresponding shell, plate, and beam models via kinematical and dimensional reduction. Further, we have shown that for $L_c \to 0$ it is possible to recover the Navier-Cauchy response while using the Cosserat model. The reduced dimensional models were derived by standard engineering assumptions for the kinematics and splits in the integration over the volumetric domain. For the derivation we made use of the modern framework of tangential differential calculus. Thus, we were able to derive the corresponding energy functionals without the need for curvilinear coordinates or Christoffel symbols. Another major advantage of this approach is its applicability to automated solvers of partial differential equations, where the energy functional could be written as is, and solved directly without further treatment. All the various dimensional models intrinsically share the same type of degrees of freedom, namely translations and rotations. As a consequence, we were able to define coupled systems using merely consistent Sobolev trace operators, without the need for intermediate finite elements or Lagrange multipliers. The natural $C^0(\mathcal{B})$ -regularity of continuous Lagrange elements ensured that its Sobolev traces on codimensional domains remain well-defined and square integrable also on these lower dimensional manifolds. We were thus able to validate our approach with three numerical examples computed in NGSolve (see Fn. 2), where we coupled a volume with a shell, a volume and with a plate and beams, or a shell with beams.

The approach presented in this work has three advantages. Firstly, it is simple as no special treatment is required for the coupling. Instead, the coupling is done by defining additional energy functionals for Sobolev traces of the displacement and rotation fields on codimensional domains. Secondly, it is arbitrarily valid across dimensions, even for intersections. Thirdly, although not explicitly discussed in this work, the coupling modulus

 μ_c can be understood as a penalty term or a rotational spring. In other words, it could be used to control how strong the coupling is, allowing for deltas on interfaces of mixed-dimensional domains. Collectively, we surmise that our approach is relevant for engineering designs with mixed-dimensional parts, such as sandwich elements in aerospace, or general composite and fibre-reinforced materials.

Notwithstanding, the presented approach does entail one disadvantage, being its additional rotational degrees of freedom on all volumetric elements, making it computationally more expensive than the comparable Navier—Cauchy model for isotropic Cauchy materials.

A Tensor calculus

Let $\Omega \subset \mathbb{R}^3$ define some reference three-dimensional body and $V \subset \mathbb{R}^3$ a physical three-dimensional body, we define the mapping

$$\mathbf{x} = \mathbf{x}(\xi, \eta, \zeta), \qquad \mathbf{x} : \Omega \to V.$$
 (A.1)

The covariant tangent vectors in the physical body read

$$\mathbf{g}_i = \partial_i^{\xi} \mathbf{x} = \frac{\partial}{\partial \xi^i} \mathbf{x} = \frac{\partial x^j}{\partial \xi^i} \mathbf{e}_j = \mathbf{x}_{,i} \,.$$
 (A.2)

Let the mapping x be invertible $\boldsymbol{\xi} = \boldsymbol{\xi}(\mathbf{x}) = \mathbf{x}^{-1}(\boldsymbol{\xi})$, using the chain rule we can directly deduce

$$\frac{\partial x^j}{\partial \xi^i} \frac{\partial \xi^k}{\partial x^l} \langle \mathbf{e}_j, \, \mathbf{e}_l \rangle = \frac{\partial x^j}{\partial \xi^i} \frac{\partial \xi^k}{\partial x^l} \delta_{jl} = \frac{\partial x^j}{\partial \xi^i} \frac{\partial \xi^k}{\partial x^j} = \frac{\partial \xi^k}{\partial x^j} \frac{\partial x^j}{\partial \xi^i} = \frac{\partial \xi^k}{\partial \xi^i} = \delta_{ki} \,. \tag{A.3}$$

implying the definition of so called contravariant vectors

$$\mathbf{g}^{j} = \frac{\partial \xi^{j}}{\partial x^{i}} \mathbf{e}_{i}, \qquad \langle \mathbf{g}_{i}, \mathbf{g}^{j} \rangle = \delta_{ij}. \tag{A.4}$$

Inversely, we can retrieve the Cartesian basis vectors form the co- and contravariant basis

$$\mathbf{e}_{i} = \frac{\partial \xi^{i}}{\partial x^{j}} \mathbf{g}_{i}, \qquad \qquad \mathbf{e}_{i} = \frac{\partial x^{i}}{\partial \xi^{j}} \mathbf{g}^{j}. \tag{A.5}$$

The covariant vectors define the metric tensor of the three-dimensional body

$$G = g_{ij}\mathbf{e}_i \otimes \mathbf{e}_j = \langle \mathbf{g}_i, \, \mathbf{g}_j \rangle \, \mathbf{e}_i \otimes \mathbf{e}_j = \frac{\partial x^k}{\partial \xi^i} \frac{\partial x^k}{\partial \xi^j} \mathbf{e}_i \otimes \mathbf{e}_j \,. \tag{A.6}$$

We observe

$$(g_{ij}\mathbf{e}_i\otimes\mathbf{e}_j)(\langle\mathbf{g}^k,\mathbf{g}^l\rangle\mathbf{e}_k\otimes\mathbf{e}_l) = (g_{ij}\mathbf{e}_i\otimes\mathbf{e}_j)(g^{kl}\mathbf{e}_k\otimes\mathbf{e}_l) = g_{ij}g^{kl}\delta_{jk}\mathbf{e}_i\otimes\mathbf{e}_l = g_{ik}g^{kl}\mathbf{e}_i\otimes\mathbf{e}_l = \delta_{il}\mathbf{e}_i\otimes\mathbf{e}_l, \quad (A.7)$$

since

$$g_{ik}g^{kl} = \frac{\partial x^q}{\partial \xi^i} \frac{\partial x^q}{\partial \xi^k} \frac{\partial \xi^k}{\partial x^r} \frac{\partial \xi^l}{\partial x^r} = \frac{\partial x^q}{\partial \xi^i} \frac{\partial x^q}{\partial x^r} \frac{\partial \xi^l}{\partial x^r} = \delta_{qr} \frac{\partial x^q}{\partial \xi^i} \frac{\partial \xi^l}{\partial x^r} = \frac{\partial x^r}{\partial \xi^i} \frac{\partial \xi^l}{\partial x^r} = \frac{\partial \xi^l}{\partial \xi^i} = \delta_{li}. \tag{A.8}$$

Consequently, the inverse of the metric tensor is

$$G^{-1} = g^{ij} \mathbf{e}_i \otimes \mathbf{e}_j = \langle \mathbf{g}^i, \mathbf{g}^j \rangle \, \mathbf{e}_i \otimes \mathbf{e}_j \,. \tag{A.9}$$

A covariant vector is mapped to a contravariant vector via

$$\mathbf{g}_{i}g^{ij} = \frac{\partial x^{k}}{\partial \xi^{i}} \mathbf{e}_{k} \frac{\partial \xi^{i}}{\partial x^{l}} \frac{\partial \xi^{j}}{\partial x^{l}} = \mathbf{e}_{k} \frac{\partial x^{k}}{\partial x^{l}} \frac{\partial \xi^{j}}{\partial x^{l}} = \mathbf{e}_{k} \delta_{kl} \frac{\partial \xi^{j}}{\partial x^{l}} = \mathbf{e}_{k} \frac{\partial \xi^{j}}{\partial x^{k}} = \mathbf{g}^{j}, \tag{A.10}$$

and vice versa

$$\mathbf{g}_j = \mathbf{g}^i g_{ij} \,. \tag{A.11}$$

With this basic machinery in place, we can now express second order derivatives. Second order derivatives of the mapping can be expressed using Christoffel symbols

$$\partial_j^{\xi} \mathbf{g}_i = \frac{\partial}{\partial \xi^j} \mathbf{g}_i = \mathbf{g}_{i,j} = \Gamma_{ij}^{\ k} \mathbf{g}_k = \Gamma_{ijk} \mathbf{g}^k. \tag{A.12}$$

The components of the Christoffel symbols $\Gamma_{ij}^{\ k}$ and Γ_{ijk} are identified using the orthogonality of the co- and contravariant vectors

$$\langle \mathbf{g}_{i,j}, \mathbf{g}^l \rangle = \Gamma_{ij}^{\ k} \langle \mathbf{g}_k, \mathbf{g}^l \rangle = \Gamma_{ij}^{\ k} \delta_k^{\ l} = \Gamma_{ij}^{\ l}, \qquad \langle \mathbf{g}_{i,j}, \mathbf{g}_l \rangle = \Gamma_{ijk} \langle \mathbf{g}^k, \mathbf{g}_l \rangle = \Gamma_{ijk} \delta_{\ l}^k = \Gamma_{ijl}. \tag{A.13}$$

B Tangential differential calculus

The identity tensor reads

$$1 = \delta_{ij} \mathbf{e}_i \otimes \mathbf{e}_j = \mathbf{e}_i \otimes \mathbf{e}_i. \tag{B.1}$$

It can also be expressed as a mixed tensor of co- and contravariant basis vectors

$$1 = \mathbf{e}_i \otimes \mathbf{e}_i = \frac{\partial \xi^j}{\partial x^i} \mathbf{g}_j \otimes \frac{\partial x^i}{\partial \xi^k} \mathbf{g}^k = \frac{\partial \xi^j}{\partial \xi^k} \mathbf{g}_j \otimes \mathbf{g}^k = \delta_{jk} \mathbf{g}_j \otimes \mathbf{g}^k = \mathbf{g}_j \otimes \mathbf{g}^j,$$
(B.2)

and analogously as $\mathbb{1} = \mathbf{g}^j \otimes \mathbf{g}_j$. If we define some hyper-surface $A \subset \mathbb{R}^3$ by a mapping $\mathbf{r} : \omega \subset \mathbb{R}^2 \to A$, whose tangent vectors are \mathbf{g}_1 and \mathbf{g}_2 , then its normal unit vector \mathbf{g}_3 can be defined as

$$\mathbf{g}_3 = \frac{\mathbf{g}_1 \times \mathbf{g}_2}{\|\mathbf{g}_1 \times \mathbf{g}_2\|}. \tag{B.3}$$

We observe that

$$\langle \mathbf{g}_3, \, \mathbf{g}_3 \rangle = 1, \qquad \langle \mathbf{g}_{\alpha}, \, \mathbf{g}_3 \rangle = 0,$$
 (B.4)

implying that the co- and contravariant normal vectors are the same $\mathbf{g}_3 = \mathbf{g}^3$. Since \mathbf{g}_3 is the unit normal vector to the surface, we can define a corresponding tangential projection operator

$$P = 1 - n \otimes n = 1 - g_3 \otimes g^3 = g_i \otimes g^i - g_3 \otimes g^3 = g_\alpha \otimes g^\alpha, \quad P \mathbf{v} = (g_\alpha \otimes g^\alpha) v^i g_i = v^\alpha g_\alpha.$$
 (B.5)

In other words, the tensor eliminates any non-tangential components. Analogously, we can define the normal projection operator

$$Q = \mathbb{1} - P = g_3 \otimes g^3 = n \otimes n,$$
 $Q \mathbf{v} = (g_3 \otimes g^3) v^i g_i = v^3 g_3.$ (B.6)

Now, let some function λ depend only on two parameters of a reference surface $(\lambda \circ \mathbf{r})(\xi, \eta)$, then its gradient reads

$$\nabla \lambda = \mathbf{e}^{i} \partial_{i}^{x} \lambda = \mathbf{e}_{i} \frac{\partial}{\partial x^{i}} \lambda = \mathbf{e}_{i} \frac{\partial}{\partial \xi^{\alpha}} \frac{\partial \xi^{\alpha}}{\partial x^{i}} \lambda = \mathbf{e}_{i} \frac{\partial \xi^{\alpha}}{\partial x^{i}} \frac{\partial}{\partial \xi^{\alpha}} \lambda = \mathbf{g}^{\alpha} \partial_{\alpha}^{\xi} \lambda = \lambda_{,\alpha} \mathbf{g}^{\alpha}. \tag{B.7}$$

Evidently, $\nabla \lambda : \omega \to T_p A$ is a tangential vector in this case such that

$$P \nabla \lambda = (\mathbf{g}^{\beta} \otimes \mathbf{g}_{\beta}) \lambda_{,\alpha} \, \mathbf{g}^{\alpha} = \lambda_{,\beta} \, \mathbf{g}^{\beta} \,, \tag{B.8}$$

leaves the vector unchanged. We call the projected gradient the tangential gradient and define it as

$$\mathbf{P}\,\nabla\lambda = \nabla_t\lambda\,. \tag{B.9}$$

If λ is a function of a three-dimensional system $(\lambda \circ \mathbf{x})(\xi, \eta, \zeta)$, then the tangential gradient eliminates the out-of-plane component

$$\nabla_t \lambda = \mathbf{P} \, \mathbf{e}^i \partial_i^x \lambda = \mathbf{P} \, \mathbf{g}^i \partial_i^\xi \lambda = \mathbf{g}^\alpha \partial_\alpha^\xi \lambda = \lambda_{,\alpha} \, \mathbf{g}^\alpha \,. \tag{B.10}$$

Analogously, we can define the same operator for vectors

$$D_t \mathbf{v} = (D\mathbf{v}) \mathbf{P} = \mathbf{v}_{,\alpha} \otimes \mathbf{g}^{\alpha} \,, \tag{B.11}$$

by applying the projection row-wise. If we restrict also the vectorial basis on the left of the tensor to the tangential plane we retrieve the so-called covariant gradient

$$D_t^{\text{cov}} \mathbf{v} = \mathbf{P} D_t \mathbf{v} = \mathbf{P} (D \mathbf{v}) \mathbf{P}. \tag{B.12}$$

As the name suggests, the latter simply expresses derivatives within the tangential coordinate system. With the vectorial gradient defined, the tangential divergence is naturally

$$\operatorname{div}_{t} \mathbf{v} = \operatorname{tr}(\mathbf{D}_{t} \mathbf{v}) = \langle (\mathbf{D} \mathbf{v}) \mathbf{P}, \mathbf{1} \rangle = \langle \mathbf{D} \mathbf{v}, \mathbf{P} \rangle = \langle \mathbf{v}_{.i} \otimes \mathbf{g}^{i}, \mathbf{g}^{\alpha} \otimes \mathbf{g}_{\alpha} \rangle = \langle \mathbf{v}_{.i}, \mathbf{g}^{\alpha} \rangle \delta_{i\alpha} = \langle \mathbf{v}_{.\alpha}, \mathbf{g}^{\alpha} \rangle. \tag{B.13}$$

We note that the trace of the covariant gradient yields the same result

$$tr(D_t^{cov}\mathbf{v}) = \langle \mathbf{P}(D\mathbf{v})\mathbf{P}, \mathbf{1} \rangle = \langle D\mathbf{v}, \mathbf{P} \rangle = div_t \mathbf{v}, \tag{B.14}$$

seeing as PP = P by its projection property. Accordingly, the tensorial tangential divergence reads

$$\operatorname{Div}_{t} \mathbf{T} = (\mathbf{T}_{\alpha}) \mathbf{g}^{\alpha} = (\mathbf{D} \mathbf{T}) \mathbf{P}, \tag{B.15}$$

where the latter implies a double-contraction. The tangential gradient also allows to define the surface curl operator

$$\operatorname{curl}_{t} \mathbf{v} = \langle \operatorname{D}_{t} \mathbf{v}, \operatorname{Anti} \mathbf{n} \rangle = \langle \mathbf{v}_{,\alpha} \otimes \mathbf{g}^{\alpha}, \mathbf{n} \times \mathbb{1} \rangle = \langle \mathbf{v}_{,\alpha} \otimes \mathbf{g}^{\alpha}, \mathbf{n} \times \mathbf{g}^{i} \otimes \mathbf{g}_{i} \rangle = \langle \mathbf{v}_{,\alpha}, \mathbf{n} \times \mathbf{g}^{i} \rangle \delta_{\alpha i} = \langle \mathbf{g}^{\alpha} \times \mathbf{v}_{,\alpha}, \mathbf{n} \rangle,$$
(B.16)

where we applied the circular shift in the last step. If the vector is a function of the plane $\mathbf{v} = (\mathbf{v} \circ \mathbf{r})(\xi, \eta)$, then the definition coincides with the analogous formula of the full gradient

$$\operatorname{curl}_{t} \mathbf{v} = \langle \operatorname{D} \mathbf{v}, \operatorname{Anti} \mathbf{n} \rangle = \langle \mathbf{v}_{,j} \otimes \mathbf{g}^{j}, \mathbf{n} \times \mathbb{1} \rangle = \langle \mathbf{v}_{,j}, \mathbf{n} \times \mathbf{g}^{j} \rangle = \langle \mathbf{v}_{,\alpha}, \mathbf{n} \times \mathbf{g}^{\alpha} \rangle = \langle \mathbf{g}^{\alpha} \times \mathbf{v}_{,\alpha}, \mathbf{n} \rangle,$$
(B.17)

since $\mathbf{n} \times \mathbf{g}^3 = \mathbf{n} \times \mathbf{n} = 0$. Finally, the tangential curl can also be related to the covariant skew-symmetric gradient of a vector field $\mathbf{v} = (\mathbf{v} \circ \mathbf{r})(\xi, \eta)$ via

skew
$$D_t^{cov} \mathbf{v} = \mathbf{P}(\text{skew D}\mathbf{v})\mathbf{P} = \frac{1}{2}\mathbf{P}(\text{Anti curl }\mathbf{v})\mathbf{P} = \frac{1}{2}(\text{curl}_t \mathbf{v})(\text{Anti }\mathbf{n}),$$
 (B.18)

where any in-plane vectors are eliminated due to

$$P(\operatorname{Anti} \mathbf{g}_{\alpha})P = P[\mathbf{g}_{\alpha} \times (\mathbf{g}_{\beta} \otimes \mathbf{g}^{\beta})] = \frac{1}{\|\mathbf{g}_{1} \times \mathbf{g}_{2}\|} P(\mathbf{n} \otimes \varepsilon_{\alpha\beta\gamma} \mathbf{g}^{\gamma}) = 0.$$
(B.19)

C The Weingarten curvature tensor

Let a hyper-surface $A \subset \mathbb{R}^3$ in a three dimensional space \mathbb{R}^3 be mapped from some flat surface $\omega \subset \mathbb{R}^2$ via $\mathbf{r} : \omega \subset \mathbb{R}^2 \to A$, the tangent vectors on the hyper-surface read

$$\mathbf{t}_1 = \mathbf{g}_1 = \frac{\partial}{\partial \xi} \mathbf{r} = \mathbf{r}_{,\xi},$$
 $\mathbf{t}_2 = \mathbf{g}_2 = \frac{\partial}{\partial \eta} \mathbf{r} = \mathbf{r}_{,\eta}.$ (C.1)

Using the latter two one can define a unit normal vector on the hyper-surface

$$\mathbf{n} = \frac{\mathbf{t}_1 \times \mathbf{t}_2}{\|\mathbf{t}_1 \times \mathbf{t}_2\|}, \qquad \|\mathbf{n}\| = 1. \tag{C.2}$$

Clearly, the tangential vectors \mathbf{t}_{α} are orthogonal to \mathbf{n} by the very construction $\mathbf{t}_{\alpha} \perp \mathbf{n}$, such that

$$\langle \mathbf{t}_{\alpha}, \, \mathbf{n} \rangle = 0 \,, \qquad \qquad \partial_{\beta}^{\xi} \langle \mathbf{t}_{\alpha}, \, \mathbf{n} \rangle = \frac{\partial}{\partial \xi^{\beta}} \langle \mathbf{t}_{\alpha}, \, \mathbf{n} \rangle = \langle \mathbf{t}_{\alpha,\beta}, \, \mathbf{n} \rangle + \langle \mathbf{t}_{\alpha}, \, \mathbf{n}_{\beta} \rangle = 0 \,, \tag{C.3}$$

implying the equality

$$\langle \mathbf{t}_{\alpha,\beta}, \mathbf{n} \rangle = -\langle \mathbf{t}_{\alpha}, \mathbf{n}_{\beta} \rangle.$$
 (C.4)

Further, since n is a unit vector there holds

$$\langle \mathbf{n}, \mathbf{n} \rangle = 1,$$
 $\partial_{\beta}^{\xi} \langle \mathbf{n}, \mathbf{n} \rangle = \frac{\partial}{\partial \xi^{\beta}} \langle \mathbf{n}, \mathbf{n} \rangle = 2 \langle \mathbf{n}_{,\beta}, \mathbf{n} \rangle = 0,$ (C.5)

implying that infinitesimal changes in \mathbf{n} with respect to $\{\xi,\eta\}$ are orthogonal to it $\mathbf{n}_{,\beta} \perp \mathbf{n}$. Since \mathbf{n} is a unit vector normal to the hyper-surface A, any change in its orientation is a measure of curvature. Using the Christoffel symbols we express derivatives of the tangent vectors as

$$\mathbf{t}_{\alpha,\beta} = \Gamma_{\alpha\beta}{}^{i}\mathbf{g}_{i} = \Gamma_{\alpha\beta}{}^{\gamma}\mathbf{t}_{\gamma} + \Gamma_{\alpha\beta}{}^{3}\mathbf{g}_{3} = \Gamma_{\alpha\beta}{}^{\gamma}\mathbf{t}_{\gamma} + W_{\alpha\beta}\mathbf{n}, = \Gamma_{\alpha\beta\gamma}\mathbf{t}^{\gamma} + W_{\alpha\beta}\mathbf{n},$$
(C.6)

where we define the covariant components of the so called Weingarten map as

$$W_{\alpha\beta} = \Gamma_{\alpha\beta}^{3} = \langle \mathbf{t}_{\alpha,\beta}, \, \mathbf{n} \rangle = \langle \mathbf{t}_{\alpha,\beta}, \, \mathbf{g}^{3} \rangle = \langle \mathbf{t}_{\alpha,\beta}, \, \mathbf{g}_{3} \rangle = \Gamma_{\alpha\beta3} \,. \tag{C.7}$$

Doing the same for derivatives of the normal vector we find

$$\mathbf{n}_{,\alpha} = \Gamma_{3\alpha}^{\ k} \mathbf{g}_k = \Gamma_{3\alpha}^{\ \beta} \mathbf{t}_{\beta} + \Gamma_{3\alpha}^{\ 3} \mathbf{n} \,. \tag{C.8}$$

Now, using Eq. (C.4) and Eq. (C.5) we find

$$\Gamma_{3\alpha\beta} = \langle \mathbf{n}_{,\alpha}, \mathbf{t}_{\beta} \rangle = -\langle \mathbf{t}_{\beta,\alpha}, \mathbf{n} \rangle = -W_{\alpha\beta}, \qquad \Gamma_{3\alpha}^{3} = \langle \mathbf{n}_{,\alpha}, \mathbf{n} \rangle = 0,$$
 (C.9)

such that any infinitesimal change in the unit normal vector of the surface is captured by the Weingarten map

$$\mathbf{n}_{,\alpha} = -W_{\alpha\beta}\mathbf{g}^{\beta} = -W_{\alpha}^{\beta}\mathbf{t}_{\beta}, \tag{C.10}$$

where we used Eq. (A.10) and Eq. (A.11) to switch to a mixed variant definition. Clearly, the components of the Weingarten tensor are curvature measures, such that the tensor itself is known as the curvature tensor. Its components can be identified using

$$W_{\alpha}{}^{\beta} = -\langle \mathbf{n}_{,\alpha}, \, \mathbf{g}^{\beta} \rangle \,. \tag{C.11}$$

Consequently, the tensor itself can be defined via

$$W = -\mathrm{D}\mathbf{n} = -\mathbf{n}_{,\alpha} \otimes \mathbf{g}^{\alpha} = W_{\alpha}^{\beta} \mathbf{t}_{\beta} \otimes \mathbf{g}^{\alpha}. \tag{C.12}$$

It is clear that the tensor is tangential, such we can also write

$$\mathbf{W} = -\mathbf{D}_t \mathbf{n} \,, \tag{C.13}$$

using tangential differential calculus. Let κ_1 and κ_2 be the eigenvalues of the tensor, its invariants read

$$H = \frac{1}{2} \operatorname{tr} \mathbf{W} = \frac{1}{2} W_{\alpha}{}^{\alpha} = \frac{1}{2} (W_{1}{}^{1} + W_{2}{}^{2}) = \frac{1}{2} (\kappa_{1} + \kappa_{2}), \quad K = \det \mathbf{W} = W_{1}{}^{1} W_{2}{}^{2} - W_{1}{}^{2} W_{2}{}^{1} = \kappa_{1} \kappa_{2}, \quad (C.14)$$

representing the mean- and Gaussian curvature measures, respectively.

D The shell-shifter

Let the middle hyper-surface of the shell A be mapped from some flat reference surface ω

$$\mathbf{r} = \mathbf{r}(\xi, \eta),$$
 $\mathbf{r} : \omega \subset \mathbb{R}^2 \to A \subset \mathbb{R}^3,$ (D.1)

one can define the complete volume of the shell via

$$\mathbf{x} = \mathbf{x}(\xi, \eta, \zeta), \mathbf{x} = \mathbf{r} + \zeta \mathbf{n}, \qquad \mathbf{x} : \Omega \subset \mathbb{R}^3 \to V \subset \mathbb{R}^3,$$
 (D.2)

where $\zeta \in [-h/2, h/2]$ is the thickness parameter of the shell, and the normal vector **n** is defined using the middle surface as per Eq. (C.2). The volume of the shell is therefore given by

$$V = A \times [-h/2, h/2] \subset \mathbb{R}^3. \tag{D.3}$$

The infinitesimal tangent vectors of the shell read

$$\frac{\partial \mathbf{x}}{\partial \xi} d\xi = \mathbf{g}_1 d\xi = (\mathbf{t}_1 + \zeta \mathbf{n}_{,\xi}) d\xi, \qquad \frac{\partial \mathbf{x}}{\partial \eta} d\eta = \mathbf{g}_2 d\eta = (\mathbf{t}_2 + \zeta \mathbf{n}_{,\eta}) d\eta, \qquad \frac{\partial \mathbf{x}}{\partial \zeta} d\zeta = \mathbf{g}_3 d\zeta = \mathbf{n} d\zeta. \tag{D.4}$$

As the surface is parameterised by $\{\xi,\eta\}$, its infinitesimal tangent vectors reads

$$\frac{\partial \mathbf{r}}{\partial \xi} d\xi = \mathbf{t}_1 d\xi, \qquad \frac{\partial \mathbf{r}}{\partial \eta} d\xi = \mathbf{t}_2 d\eta.$$
 (D.5)

Consequently, an infinitesimal surface element of the middle surface reads

$$dA = \|\mathbf{t}_1 d\xi \times \mathbf{t}_2 d\eta\| = \|\mathbf{t}_1 \times \mathbf{t}_2\| d\xi d\eta = \|\mathbf{t}_1 \times \mathbf{t}_2\| d\omega. \tag{D.6}$$

We find the infinitesimal volume element of the shell using the triple vector product

$$dV = \langle \mathbf{x}_{,\xi} d\xi \times \mathbf{x}_{,\eta} d\eta, \mathbf{x}_{,\zeta} d\zeta \rangle = \langle \mathbf{x}_{,\xi} \times \mathbf{x}_{,\eta}, \mathbf{x}_{,\zeta} \rangle d\zeta d\omega = \langle (\mathbf{t}_1 + \zeta \mathbf{n}_{,\xi}) \times (\mathbf{t}_2 + \zeta \mathbf{n}_{,\eta}), \mathbf{n} \rangle d\zeta d\omega. \tag{D.7}$$

The term can be decomposed into the additive parts

$$\langle \mathbf{t}_1 \times \mathbf{t}_2, \mathbf{n} \rangle d\zeta d\omega, \qquad \langle \mathbf{t}_1 \times \zeta \mathbf{n}_{,n} + \zeta \mathbf{n}_{,\varepsilon} \times \mathbf{t}_2, \mathbf{n} \rangle d\zeta d\omega, \qquad \langle \zeta \mathbf{n}_{,\varepsilon} \times \zeta \mathbf{n}_{,n}, \mathbf{n} \rangle d\zeta d\omega.$$
 (D.8)

The first term is clearly

$$\langle \mathbf{t}_1 \times \mathbf{t}_2, \, \mathbf{n} \rangle d\zeta d\omega = d\zeta dA,$$
 (D.9)

due to $\mathbf{n} \parallel \mathbf{t}_1 \times \mathbf{t}_2$ and $\parallel \mathbf{n} \parallel = 1$. Expanding the second part while applying the curvature tensor $\mathbf{W} = -\mathbf{D}_t \mathbf{n}$ to express derivatives of the normal vector we find

$$\mathbf{t}_1 \times \zeta \mathbf{n}_n = -\zeta \mathbf{t}_1 \times W_2^2 \mathbf{t}_2, \qquad \zeta \mathbf{n}_{\mathcal{E}} \times \mathbf{t}_2 = -\zeta W_1^1 \mathbf{t}_1 \times \mathbf{t}_2, \qquad (D.10)$$

yielding together

$$\langle -\zeta \mathbf{t}_1 \times W_2^2 \mathbf{t}_2 - \zeta W_1^4 \mathbf{t}_1 \times \mathbf{t}_2, \, \mathbf{n} \rangle d\zeta d\omega = -\zeta (W_1^4 + W_2^2) \langle \mathbf{t}_1 \times \mathbf{t}_2, \, \mathbf{n} \rangle d\zeta d\omega = -2H \, \zeta \, d\zeta dA \,. \tag{D.11}$$

Using the curvature tensor W again for the third term we find

$$\zeta \mathbf{n}_{,\xi} \times \zeta \mathbf{n}_{,\eta} = \zeta^2 (W_1^{\ 1} \mathbf{t}_1 + W_1^{\ 2} \mathbf{t}_2) \times (W_2^{\ 1} \mathbf{t}_1 + W_2^{\ 2} \mathbf{t}_2) = \zeta^2 (\mathbf{t}_1 \times \mathbf{t}_2) (W_1^{\ 1} W_2^{\ 2} - W_1^{\ 2} W_2^{\ 1}) = K \zeta^2 (\mathbf{t}_1 \times \mathbf{t}_2), \tag{D.12}$$

such the term reads

$$\langle \zeta \mathbf{n}_{,\xi} \times \zeta \mathbf{n}_{,\eta}, \mathbf{n} \rangle d\zeta d\omega = \kappa \zeta^{2} \langle \mathbf{t}_{1} \times \mathbf{t}_{2}, \mathbf{n} \rangle d\zeta d\omega = K \zeta^{2} d\zeta dA.$$
 (D.13)

Putting it all together, we find Steiner's formula for the change in volume

$$dV = (1 - 2H\zeta + K\zeta^2) d\zeta dA, \qquad (D.14)$$

where $1 - 2H \zeta + K \zeta^2$ is called the shell-shifter.

E Tangential gradients on shells

In general, for fields on the shell $\lambda = (\lambda \circ \mathbf{x})(\xi, \eta, \zeta) = (\lambda \circ \mathbf{x})(\xi)$ it is possible to determine corresponding gradients given by tangential differential calculus. In other words, the gradients can be characterised by the parametrisation of the middle surface. We observe that the covariant basis of the parametrisation $\mathbf{x}(\xi, \eta, \zeta)$ from Eq. (D.2) can be expanded as

$$\mathbf{g}_1 = \mathbf{t}_1 + \zeta \mathbf{n}_{,\xi} = \mathbf{t}_1 - \zeta (W_1^{\ 1} \mathbf{t}_1 + W_1^{\ 2} \mathbf{t}_2), \quad \mathbf{g}_2 = \mathbf{t}_2 + \zeta \mathbf{n}_{,\eta} = \mathbf{t}_2 - \zeta (W_2^{\ 1} \mathbf{t}_1 + W_2^{\ 2} \mathbf{t}_2), \quad \mathbf{g}_3 = \mathbf{n}, \quad (E.1)$$

using Eq. (C.10). Clearly, \mathbf{g}_1 and \mathbf{g}_2 are tangential to the middle surface $\mathbf{g}_{\alpha} \perp \mathbf{n}$, such that we immediately obtain $\mathbf{g}^3 = \mathbf{g}_3 = \mathbf{n}$ and $\mathbf{g}^{\alpha} \perp \mathbf{n}$ for the contravariant basis. Now, let \mathbf{t}^1 and \mathbf{t}^2 be the contravariant basis of the parametrisation of the middle surface $\mathbf{r} = \mathbf{r}(\xi, \eta)$, the vectors satisfy $\langle \mathbf{t}^{\alpha}, \mathbf{t}_{\beta} \rangle = \delta_{\alpha\beta}$ and $\mathbf{t}^{\alpha} \perp \mathbf{n}$, such that we can use them to the define the contravariant basis of $\mathbf{x}(\xi, \eta, \zeta)$ implicitly as

$$\mathbf{g}^1 = c_{11}\mathbf{t}^1 + c_{12}\mathbf{t}^2,$$
 $\mathbf{g}^2 = c_{21}\mathbf{t}^1 + c_{22}\mathbf{t}^2.$ (E.2)

The contravariant basis must satisfy $\langle \mathbf{g}^{\alpha}, \mathbf{g}_{\beta} \rangle = \delta_{\alpha\beta}$, leading to following system of equations

$$\langle \mathbf{g}^1, \mathbf{g}_1 \rangle = (1 - \zeta W_1^{-1}) c_{11} - \zeta W_1^{-2} c_{12} = 1,$$
 (E.3a)

$$\langle \mathbf{g}^1, \, \mathbf{g}_2 \rangle = -\zeta W_2^{\ 1} c_{11} + (1 - \zeta W_2^{\ 2}) c_{12} = 0,$$
 (E.3b)

$$\langle \mathbf{g}^2, \, \mathbf{g}_1 \rangle = (1 - \zeta W_1^{\ 1}) c_{21} - \zeta W_1^{\ 2} c_{22} = 0,$$
 (E.3c)

$$\langle \mathbf{g}^2, \, \mathbf{g}_2 \rangle = -\zeta W_2^{\ 1} c_{21} + (1 - \zeta W_2^{\ 2}) c_{22} = 1.$$
 (E.3d)

Solving the system leads to

$$c_{11} = \frac{1 - \zeta W_2^2}{1 - 2H\zeta + K\zeta^2}, \quad c_{12} = \frac{\zeta W_2^1}{1 - 2H\zeta + K\zeta^2}, \quad c_{21} = \frac{\zeta W_1^2}{1 - 2H\zeta + K\zeta^2}, \quad c_{22} = \frac{1 - \zeta W_1^1}{1 - 2H\zeta + K\zeta^2}. \quad (E.4)$$

Thus, the contravariant basis reads

$$\mathbf{g}^{1} = \frac{1}{1 - 2H\zeta + K\zeta^{2}} [(1 - \zeta W_{2}^{2})\mathbf{t}^{1} + \zeta W_{2}^{1}\mathbf{t}^{2}], \quad \mathbf{g}^{2} = \frac{1}{1 - 2H\zeta + K\zeta^{2}} [\zeta W_{1}^{2}\mathbf{t}^{1} + (1 - \zeta W_{1}^{1})\mathbf{t}^{2}]. \quad (E.5)$$

With the contravariant basis at hand we can write gradients of fields on $\mathbf{x}(\xi,\eta,\zeta)$ explicitly as

$$\nabla \lambda = \mathbf{g}^{i} \lambda_{,i} = \lambda_{,\alpha} \mathbf{g}^{\alpha} + \lambda_{,\zeta} \mathbf{n}, \qquad \lambda = (\lambda \circ \mathbf{x})(\boldsymbol{\xi}). \tag{E.6}$$

As the tangential gradient of a field $\nabla_t \lambda = \lambda_{,\alpha} \mathbf{t}^{\alpha}$ is defined with respect to the parametrisation of the middle surface $\mathbf{r}(\xi, \eta)$ we find

$$\lambda_{,\alpha} \mathbf{g}^{\alpha} = \frac{1}{1 - 2H\zeta + K\zeta^{2}} [\lambda_{,\xi} ([1 - \zeta W_{2}^{2}] \mathbf{t}^{1} + \zeta W_{2}^{1} \mathbf{t}^{2}) + \lambda_{,\eta} (\zeta W_{1}^{2} \mathbf{t}^{1} + [1 - \zeta W_{1}^{1}] \mathbf{t}^{2})], \qquad (E.7)$$

being the product of

$$\frac{1}{1-2H\zeta+K\zeta^{2}}[(1-\zeta W_{2}^{2})\mathbf{t}^{1}\otimes\mathbf{t}_{1}+\zeta W_{1}^{2}\mathbf{t}^{1}\otimes\mathbf{t}_{2}+\zeta W_{2}^{1}\mathbf{t}^{2}\otimes\mathbf{t}_{1}+(1-\zeta W_{1}^{1})\mathbf{t}^{2}\otimes\mathbf{t}_{2}](\lambda_{,\xi}\mathbf{t}^{1}+\lambda_{,\eta}\mathbf{t}^{2}).$$
(E.8)

Now, applying the skew-symmetric transformation tensor

$$T = \mathbf{t}_1 \otimes \mathbf{t}^2 - \mathbf{t}_2 \otimes \mathbf{t}^1 \,, \tag{E.9}$$

to $\mathbf{W} = W_{\alpha}^{\beta} \mathbf{t}_{\beta} \otimes \mathbf{t}^{\alpha}$, we finally identify

$$\lambda_{,\alpha} \mathbf{g}^{\alpha} = \frac{1}{1 - 2H\zeta + K\zeta^{2}} [\mathbf{P} - \zeta (\mathbf{T} \mathbf{W} \mathbf{T})^{T}] \nabla_{t} \lambda = \frac{1}{1 - 2H\zeta + K\zeta^{2}} (\mathbf{P} + \zeta \mathbf{T} \mathbf{W} \mathbf{T}^{T}) \nabla_{t} \lambda, \qquad (E.10)$$

such that a gradient with respect to $\mathbf{x}(\xi, \eta, \zeta)$ can be written as

$$\nabla \lambda = \frac{1}{1 - 2H \zeta + K \zeta^2} (\mathbf{P} + \zeta \mathbf{T} \mathbf{W} \mathbf{T}^T) \nabla_t \lambda + \lambda_{,\zeta} \mathbf{n}.$$
 (E.11)

At this point it is important to note that if the explicit structure of the function λ is known, it may be possible to significantly simplify its gradient. For example, given the following function

$$\lambda(\mathbf{x}) = \lambda_0(\mathbf{r}) + \lambda_1(\zeta)\lambda_2(\mathbf{r}), \qquad \mathbf{r} : \omega \subset \mathbb{R}^2 \to A \subset \mathbb{R}^3, \tag{E.12}$$

using the product rule we find

$$\nabla \lambda = \nabla \lambda_0 + \lambda_2 \nabla \lambda_1 + \lambda_1 \nabla \lambda_2 = \nabla_t \lambda_0 + \lambda_2 \lambda_{1,\zeta} \mathbf{n} + \lambda_1 \nabla_t \lambda_2, \qquad (E.13)$$

since λ_0 and λ_2 are functions of the Cartesian coordinates of **solely the middle surface**, and $\nabla_t \lambda_1 = 0$. Thus, for certain explicit structures it is possible to circumvent the need for Eq. (E.10).

F Curved beams in three dimensions

A curve in three-dimensional space can be mapped from some parametric space $\gamma \subset \mathbb{R}$ via

$$\mathbf{r} = \mathbf{r}(\xi),$$
 $\mathbf{r} : \gamma \subset \mathbb{R} \to \mathbb{R}^3.$ (F.1)

A unit tangent vector to the curve is given by

$$\mathbf{t} = \frac{\mathbf{r}_{,\xi}}{\|\mathbf{r}_{,\xi}\|}, \qquad \mathbf{r}_{,\xi} = \|\mathbf{r}_{,\xi}\|\mathbf{t}.$$
 (F.2)

Accordingly, the infinitesimal curve element is given by

$$ds = \|d\mathbf{r}\| = \|\mathbf{r}_{,\xi}\| d\xi, \qquad \frac{ds}{d\xi} = \|\mathbf{r}_{,\xi}\|, \qquad \frac{d\xi}{ds} = \|\mathbf{r}_{,\xi}\|^{-1}, \qquad (F.3)$$

such that

$$\mathbf{t} = \frac{\mathrm{d}}{\mathrm{d}s}\mathbf{r} = \frac{\partial \mathbf{r}}{\partial \xi} \frac{\partial \xi}{\partial s} = \|\mathbf{r}_{,\xi}\| \|\mathbf{r}_{,\xi}\|^{-1} \mathbf{t} . \tag{F.4}$$

We use the unit tangent vector to define the tangential and normal projection operators

$$P = \mathbf{t} \otimes \mathbf{t}$$
, $Q = \mathbb{1} - P = \mathbb{1} - \mathbf{t} \otimes \mathbf{t}$. (F.5)

Further, we re-parameterise the curve $\mathbf{r} = \mathbf{r}(s)$ using the arc-length parameter

$$s(\xi) = \int_0^{\xi} ds = \int_0^{\xi} \|\mathbf{r}_{,\xi}\| d\xi, \qquad \xi(s) = \int_0^{s} d\xi = \int_0^{s} \|\mathbf{r}_{,\xi}\|^{-1} ds, \qquad s \in [0, l], \qquad (F.6)$$

where we assume that ξ and s start at zero for simplicity. Thus, the tangential gradient of a function $\lambda = \lambda(s)$ with respect to the curve reads

$$\nabla \lambda = \lambda_{s} \mathbf{g}^{s} = \lambda_{s} \mathbf{t} = P \nabla \lambda = \nabla_{t} \lambda, \tag{F.7}$$

where \mathbf{g}^s is the contravariant pseudo-inverse of the covariant tangent vector $\mathbf{g}_s = \mathbf{t}$. For the divergence of some vector $\mathbf{v} = \mathbf{v}(s)$ we find

$$\operatorname{div}_{t} \mathbf{v} = \operatorname{tr}(\mathbf{D}_{t} \mathbf{v}) = \langle \mathbf{D} \mathbf{v}, \, \boldsymbol{P} \rangle = \langle \mathbf{v}_{.s} \otimes \mathbf{t}, \, \mathbf{t} \otimes \mathbf{t} \rangle = \langle \mathbf{v}_{.s}, \, \mathbf{t} \rangle \,. \tag{F.8}$$

Next, by defining two orthogonal unit vectors

$$\mathbf{n} = \mathbf{n}(s)$$
, $\mathbf{c}(s) = \mathbf{t} \times \mathbf{n}$, $\langle \mathbf{t}, \mathbf{n} \rangle = \langle \mathbf{t}, \mathbf{c} \rangle = \langle \mathbf{n}, \mathbf{c} \rangle = 0$, $\|\mathbf{n}\| = \|\mathbf{c}\| = 1$, (F.9)

we can construct a moving coordinate system along the curve. We observe that

$$\frac{\mathrm{d}}{\mathrm{d}s}\langle \mathbf{t}, \mathbf{t} \rangle = 2\langle \mathbf{t}_{,s}, \mathbf{t} \rangle = 0, \tag{F.10}$$

implying $\mathbf{t}_{,s} \perp \mathbf{t}$. Thus, we can define

$$\mathbf{t}_{.s} = \kappa_n \mathbf{n} + \kappa_c \mathbf{c}$$
, $\langle \mathbf{t}_{.s}, \mathbf{n} \rangle = \kappa_n$, $\langle \mathbf{t}_{.s}, \mathbf{c} \rangle = \kappa_c$, (F.11)

such that κ_n and κ_c are curvature measures. There holds

$$\frac{\mathrm{d}}{\mathrm{d}s}\langle\mathbf{n},\,\mathbf{n}\rangle = 2\langle\mathbf{n}_{,s},\,\mathbf{n}\rangle = 0\,, \qquad \qquad \frac{\mathrm{d}}{\mathrm{d}s}\langle\mathbf{t},\,\mathbf{n}\rangle = \langle\mathbf{t}_{,s},\,\mathbf{n}\rangle + \langle\mathbf{t},\,\mathbf{n}_{,s}\rangle = 0\,, \tag{F.12}$$

such that we can define

$$\mathbf{n}_{.s} = -\kappa_n \mathbf{t} + \tau \mathbf{c}$$
, $\langle \mathbf{n}_{.s}, \mathbf{t} \rangle = -\langle \mathbf{t}_{.s}, \mathbf{n} \rangle = -\kappa_n$, $\langle \mathbf{n}_{.s}, \mathbf{c} \rangle = \tau$, (F.13)

where τ is called the torsion of the curve. Finally, we find

$$\mathbf{c}_{,s} = \frac{\mathrm{d}}{\mathrm{d}s}(\mathbf{t} \times \mathbf{n}) = \mathbf{t}_{,s} \times \mathbf{n} + \mathbf{t} \times \mathbf{n}_{,s} = -\kappa_c \mathbf{t} - \tau \mathbf{n}.$$
 (F.14)

Next, we define a beam in three-dimensional space as a curve with a thickness given by some surface mapping

$$\mathbf{x}(s, \eta, \zeta) = \mathbf{r} + \eta \mathbf{n} + \zeta \mathbf{c},$$
 $\mathbf{x} : [0, l] \times \omega \subset \mathbb{R}^3 \to V \subset \mathbb{R}^3,$ (F.15)

where η and ζ span the surface $\omega \subset \mathbb{R}^2$ of the cross-section of the beam and l is its length. The covariant basis of the map reads

$$\mathbf{g}_1 = \mathbf{x}_{.s} = (1 - \kappa_n \eta - \kappa_c \zeta) \mathbf{t} - \tau \zeta \mathbf{n} + \tau \eta \mathbf{c}, \qquad \mathbf{g}_2 = \mathbf{x}_{.n} = \mathbf{n}, \qquad \mathbf{g}_3 = \mathbf{x}_{.\zeta} = \mathbf{c}.$$
 (F.16)

Thus, we immediately get that the contravariant basis satisfies $\mathbf{g}^1 \perp \mathbf{n}$, $\mathbf{g}^1 \perp \mathbf{c}$, $\mathbf{g}^2 \perp \mathbf{c}$ and $\mathbf{g}^3 \perp \mathbf{n}$ by the Kronecker delta property $\langle \mathbf{g}^i, \mathbf{g}_j \rangle = \delta_{ij}$, such that

$$\mathbf{g}^{1} = \frac{1}{1 - \kappa_{n} \eta - \kappa_{c} \zeta} \mathbf{t} , \qquad \mathbf{g}^{2} = \frac{\tau \zeta}{1 - \kappa_{n} \eta - \kappa_{c} \zeta} \mathbf{t} + \mathbf{n} , \qquad \mathbf{g}^{3} = \frac{-\tau \eta}{1 - \kappa_{n} \eta - \kappa_{c} \zeta} \mathbf{t} + \mathbf{c} . \tag{F.17}$$

Consequently, gradients of some function $\lambda = \lambda(\mathbf{x})$ with respect to the mapping read

$$\nabla \lambda = \lambda_{,i} \mathbf{g}^{i} = \frac{1}{1 - \kappa_{n} \eta - \kappa_{c} \zeta} (\lambda_{,s} + \tau \zeta \lambda_{,\eta} - \tau \eta \lambda_{,\zeta}) \mathbf{t} + \lambda_{,\eta} \mathbf{n} + \lambda_{,\zeta} \mathbf{c}$$

$$= \frac{1}{1 - \kappa_{n} \eta - \kappa_{c} \zeta} \nabla_{t} \lambda + \frac{1}{1 - \kappa_{n} \eta - \kappa_{c} \zeta} (\cot \mathbf{T} + [1 - \kappa_{n} \eta - \kappa_{c} \zeta] \mathbf{Q}) (\lambda_{,\eta} \mathbf{n} + \lambda_{,\zeta} \mathbf{c}), \qquad (F.18)$$

where T is defined as the torsion tensor of the beam

$$T = \tau(\eta \mathbf{c} - \zeta \mathbf{n}) \otimes \mathbf{t}, \qquad T\mathbf{t} = \tau(\eta \mathbf{c} - \zeta \mathbf{n}), \qquad \operatorname{cof} T = \tau \mathbf{t} \otimes (\zeta \mathbf{n} - \eta \mathbf{c}).$$
 (F.19)

If the structure of λ is known, it is possible to exploit it to reduce the complexity of the gradient

$$\lambda(\mathbf{x}) = \lambda_0(s) + \lambda_1(\eta, \zeta), \qquad \nabla \lambda = \nabla_t \lambda_0 + \frac{\tau \zeta \lambda_{1,\eta} - \tau \eta \lambda_{1,\zeta}}{1 - \kappa_n \eta - \kappa_c \zeta} \mathbf{t} + \lambda_{1,\eta} \mathbf{n} + \lambda_{1,\zeta} \mathbf{c}, \qquad (F.20)$$

Clearly, if the cross-section of the beam does not twist $\tau = 0$, the gradient simplifies even further to

$$\nabla \lambda = \nabla_t \lambda_0 + \lambda_{1,n} \mathbf{n} + \lambda_{1,\zeta} \mathbf{c} = \nabla_t \lambda_0 + \mathbf{Q} \nabla \lambda_1 = \nabla_t \lambda_1 + \nabla_n \lambda_1, \qquad \nabla_n \lambda = \mathbf{Q} \nabla \lambda, \qquad (F.21)$$

motivating the definition of the normal gradient $\nabla_n(\cdot)$. Finally, the mapping of an infinitesimal beam volume element reads

$$dV = \langle \mathbf{x}_{,n} d\eta \times \mathbf{x}_{,\zeta} d\zeta, \mathbf{x}_{,s} ds \rangle = \langle \mathbf{t}, (1 - \kappa_n \eta - \kappa_c \zeta) \mathbf{t} - \tau \zeta \mathbf{n} + \tau \eta \mathbf{c} \rangle d\eta d\zeta ds = (1 - \kappa_n \eta - \kappa_c \zeta) d\omega ds. \quad (F.22)$$

The term $1 - \kappa_n \eta - \kappa_c \zeta$ represents the beam-analogue of the shell-shifter.

G Asymptotic analysis for shells

Let every term in an integral over ζ be a quadratic form

$$(a+b\zeta)^2 = a^2 + 2ab\zeta + b^2\zeta^2, \qquad a \neq a(\zeta), \qquad b \neq b(\zeta), \qquad (G.1)$$

composed of a constant part and a linear part with respect to ζ , we find the following integration formulae

$$\int_{-h/2}^{h/2} (a+b\zeta)^2 c \,d\zeta = ch \,a^2 + \frac{ch^3}{12} b^2 \,, \tag{G.2a}$$

$$\int_{-h/2}^{h/2} (a+b\zeta)^2 (c\zeta) \,d\zeta = \frac{ch^3}{6} ab,$$
 (G.2b)

$$\int_{-h/2}^{h/2} (a+b\zeta)^2 (c\zeta^2) \,d\zeta = \frac{ch^3}{12} a^2, \qquad (G.2c)$$

where we omitted higher order terms $\mathcal{O}(\xi^3)$, $c \neq c(\zeta)$, and terms of the form $(\cdot)\zeta$ vanish by the symmetry of integration $\int_{-h/2}^{h/2} (\cdot) \zeta \, d\zeta = 0$.
