# EXTENSIONS OF THE BLOCH - PÓLYA THEOREM ON THE NUMBER OF REAL ZEROS OF POLYNOMIALS (II)

& \text { AbSTRACT. We prove that there are absolute constants } c_{1}>0 \text { and } c_{2}>0 \text { such that for every } \\
& \qquad a_{0}, a_{1}, \ldots, a_{n} \in[1, M], \quad 1 \leq M \leq \exp \left(c_{2} n\right)
\end{aligned}
$$

there are

$$
b_{0}, b_{1}, \ldots, b_{n} \in\{-1,0,1\}
$$

such that the polynomial $P(z)=\sum_{j=0}^{n} b_{j} a_{j} z^{j}$ has at least

$$
c_{1}\left(\frac{n}{\log (4 M)}\right)^{1 / 2}
$$

distinct sign changes in $I_{a}:=(1-2 a, 1-a)$, where $a:=\left(\frac{\log (4 M)}{n}\right)^{1 / 2} \leq 1 / 3$. This improves and extends earlier results of Bloch and Pólya and Erdélyi, and, as a special case, recaptures a special case of a more general recent result of Jacob and Nazarov.

## 1. Introduction

In this note $c$ and $c_{j}$ will denote suitable positive absolute constants. Let $\mathcal{F}_{n}$ denote the set of polynomials of degree at most $n$ with coefficients from $\{-1,0,1\}$. Let $\mathcal{L}_{n}$ denote the set of polynomials of degree $n$ with coefficients from $\{-1,1\}$. Let $\mathcal{A}_{n}$ denote the set of polynomials of degree at most $n$ with coefficients from $\{0,1\}$. Updating what the authors write in [BEK99] and [Er08] we have the following. The study of the location of zeros of the above classes of polynomials starts with Bloch and Pólya [BP32]. They prove that the average number of real zeros of a polynomial from $\mathcal{F}_{n}$ is at most $c n^{1 / 2}$. They also prove that if $n \geq 3$ then a polynomial from $\mathcal{F}_{n}$ cannot have more than

$$
\frac{c n \log \log n}{\log n}
$$

real zeros. This quite weak result appears to be the first on this subject. Schur [Sch33] and by different methods Szegő [Sze34] and Erdős and Turán [ET50] improve this to $c(n \log n)^{1 / 2}$ (see also [BE95]). (Their results are more general, but in this specialization not sharp.) Our Theorem 4.1 in [BEK99] gives the right upper bound of $c n^{1 / 2}$ for the number of real zeros of polynomials from a much larger class, namely for all polynomials $P$ of the form

$$
P(x)=\sum_{j=0}^{n} a_{j} x^{j}, \quad\left|a_{0}\right|=\left|a_{n}\right|=1, \quad\left|a_{j}\right| \leq 1, \quad a_{j} \in \mathbb{C} .
$$

Schur [Sch33] claims that Schmidt gives a version of part of this theorem. However, it does not appear in the reference he gives, namely [Sch32], and we have not been able to trace it to any other source. In [BE97] we prove that $\eta n^{1 / 2}$ is an upper bound for the number of zeros of polynomials $P$ of the form

$$
P(x)=\sum_{j=0}^{n} a_{j} x^{j}, \quad\left|a_{0}\right|=1, \quad\left|a_{j}\right| \leq 1, \quad a_{j} \in \mathbb{C}
$$

inside any polygon with vertices on the unit circle, where the constant $\eta$ depends only on the polygon. Bloch and Pólya [BP32] also proved that there are polynomials $P \in \mathcal{F}_{n}$ with at least

$$
\frac{c n^{1 / 4}}{(\log n)^{1 / 2}}
$$

sign changes on the real line $\mathbb{R}$. Schur [Sch33] claims they do it for polynomials with coefficients only from $\{-1,1\}$, but this appears to be incorrect.

In a seminal paper Littlewood and Offord [LO39] prove that the number of real roots of a polynomial $P \in \mathcal{L}_{n}$, on average, lies between

$$
\frac{c_{1} \log n}{\log \log \log n} \quad \text { and } \quad c_{2}(\log n)^{2}
$$

and it is proved by Boyd [Bo97] that every $P \in \mathcal{L}_{n}$ has at most $\frac{c(\log n)^{2}}{\log \log n}$ zeros at 1 (in the sense of multiplicity).

Kac [Ka48] prove that the expected number of real roots of a polynomial of degree $n$ with random uniformly distributed independent coefficients is asymptotically $(2 / \pi) \log n$.

In [Er08] we prove that there are absolute constants $c_{1}>0$ and $c_{2}>0$ such that for every

$$
a_{0}, a_{1}, \ldots, a_{n} \in[1, M], \quad 1 \leq M \leq \exp \left(c_{2} n^{1 / 4}\right)
$$

there are $b_{0}, b_{1}, \ldots, b_{n} \in\{-1,0,1\}$ such that $P(z)=\sum_{j=0}^{n} b_{j} a_{j} z^{j}$ has at least $c_{2} n^{1 / 4}$ distinct sign changes in $(0,1)$. This improves and extends the earlier result of Bloch and Pólya [BP32] and, as a special case, it recaptures a special case

Jacob and Nazarov [JN24] prove quite a general theorem including that there are polynomials $P \in \mathcal{L}_{n}$ having at least $c n^{1 / 2}$ distinct zeros in $[0,1]$; and there are polynomials $0 \not \equiv P \in \mathcal{A}_{n}$ for which the polynomials $Q$ defined by $Q(x):=P(-x)$ have at least $c n^{1 / 2}$ distinct zeros in $[0,1]$.

## 2. New Result

Theorem 2.1. There are absolute constants $c_{1}>0$ and $c_{2}>0$ such that for every

$$
a_{0}, a_{1}, \ldots, a_{n} \in[1, M], \quad 1 \leq M \leq \exp \left(c_{2} n\right)
$$

there are

$$
b_{0}, b_{1}, \ldots, b_{n} \in\{-1,0,1\}
$$

such that the polynomial $P$ of the form $P(z)=\sum_{j=0}^{n} b_{j} a_{j} z^{j}$ has at least

$$
c_{1}\left(\frac{n}{\log (4 M)}\right)^{1 / 2}
$$

distinct sign changes in $I_{a}:=(1-2 a, 1-a)$, where $a:=\left(\frac{\log (4 M)}{n}\right)^{1 / 2} \leq 1 / 3$.
This improves and extends earlier results of Bloch and Pólya [BP32] and Erdélyi [Er08], and recaptures a special case of a more general result of Jacob and Nazarov [JN24].

## 3. Lemmas

We use the notation $\log ^{-} z:=\max \{0,-\log z\}$ and $\log ^{+} z:=\max \{0, \log z\}$. The geometric mean $L_{0}([a, b])$ of a continuous function $P$ on a finite interval $[a, b] \subset \mathbb{R}$ is

$$
\|P\|_{L_{0}([a, b])}:=\exp \left(\frac{1}{b-a} \int_{a}^{b} \log |P(x)| d x\right)
$$

In [JN24] Jacob and Nazarov showed the following.
Lemma 3.1. Let $a \in(0,1 / 3)$ and $I_{a}:=(1-2 a, 1-a)$. Then

$$
\int_{I_{a}} \log ^{-} P(x) d x \leq c_{3} \log (4 M)
$$

for every polynomial $P$ of the form

$$
\begin{equation*}
P(x)=\sum_{j=0}^{n} b_{j} a_{j} x^{j}, \quad a_{j} \in[1, M], \quad b_{j} \in\{-1,0,1\}, \quad b_{0}= \pm 1 \tag{3.1}
\end{equation*}
$$

Moreover $c_{3}:=9 \pi / \sqrt{2}$ is a suitable choice.
As a consequence we have the following.

Lemma 3.2. Let $a \in(0,1 / 3)$ and $I_{a}:=(1-2 a, 1-a)$. Then

$$
\|P\|_{L_{0}\left(I_{a}\right)} \geq \exp \left(\frac{-c_{3} \log (4 M)}{a}\right)
$$

for every polynomial $P$ of the form (3.1).
We will need the version of Lemma 3.2 below in the proof of Theorem 2.1.
Lemma 3.3. Let $a \in(0,1 / 3), I_{a}:=(1-2 a, 1-a)$, and $0 \leq k \leq n$. Then

$$
\|R\|_{L_{0}\left(I_{a}\right)} \geq \exp \left(\frac{-c_{3} \log (4 M)}{a}\right)
$$

for every polynomial $R$ of the form

$$
\begin{equation*}
R(x)=\sum_{j=k}^{n} b_{j} a_{j} x^{j-k}, \quad a_{j} \in[1, M], \quad b_{j} \in\{-1,0,1\}, \quad b_{k}= \pm 1 \tag{3.2}
\end{equation*}
$$

## 4. Proofs

Proof of Lemma 3.2. Using Lemma 3.1 we have

$$
\begin{aligned}
\|P\|_{L_{0}\left(I_{a}\right)} & =\exp \left(\frac{1}{a} \int_{I_{a}} \log ^{+} P(x) d x-\frac{1}{a} \int_{I_{a}} \log ^{-} P(x) d x\right) \\
& \geq \exp \left(\frac{-1}{a} \int_{I_{a}} \log ^{-} P(x) d x\right) \\
& \geq \exp \left(\frac{-c_{3} \log (4 M)}{a}\right) .
\end{aligned}
$$

Proof of Theorem 2.1. We modify the outline given by Nazarov in MathOverflow where $a_{j}=1$ for each $j=0,1, \ldots, n$, is assumed. Let $a \in(0,1 / 3)$ and $I_{a}:=(1-2 a, 1-a)$. Associated with a polynomial $P$ we define the polynomial $\widetilde{P}(x):=P(1-a-a x)$. The function $f(x):=1-a-a x$ maps the interval $(0,1)$ onto the interval $(1-2 a, 1-a)$, hence the polynomial $P$ of the form

$$
P(x)=\sum_{j=0}^{n} a_{j} x^{j}, \quad a_{j} \in[1, M]
$$

satisfies

$$
0 \leq \widetilde{P}(x)<(n+1) M, \quad x \in[0,1] .
$$

For every fixed $a_{0}, a_{1}, \ldots, a_{n} \in[1, M]$ there are $2^{n+1}$ different polynomials $P$ of the form

$$
\begin{equation*}
P(x)=\sum_{j=0}^{n} d_{j} a_{j} x^{j}, \quad d_{j} \in\{0,1\} \tag{4.1}
\end{equation*}
$$

By the pigeon hole principle there are two different polynomials $P_{1}$ and $P_{2}$ of the form (4.1) such that the polynomial $0 \not \equiv P:=P_{1}-P_{2}$ is of the form (3.1) and

$$
\begin{equation*}
\left|\int_{0}^{1} \widetilde{P}(x) x^{j} d x\right| \leq(n+1) M 2^{-n / m}, \quad j=0,1, \ldots, m-1 \tag{4.2}
\end{equation*}
$$

We fix this $P$ and $b_{0}, b_{1}, \ldots, b_{n} \in\{-1,0,1\}$ in the rest of the proof. There is a $0 \leq k \leq n$ such that $b_{0}=b_{1}=\cdots=b_{k-1}=0$ and $b_{k}= \pm 1$. We have $P(x)=x^{k} R(x)$, where $R$ is a polynomial of the form (3.2) and

$$
x^{k} \geq(1-2 a)^{n} \geq \exp (-4 a n), \quad x \in I_{a}, \quad a \in(0,1 / 3)
$$

Combining this with Lemma 3.3 gives

$$
\|P\|_{L_{0}\left(I_{a}\right)} \geq \exp \left(\frac{-c_{3} \log (4 M)}{a}-4 a n\right)
$$

Now we choose $a:=\left(\frac{\log (4 M)}{n}\right)^{1 / 2} \leq 1 / 3$ to get

$$
\begin{equation*}
\|\widetilde{P}\|_{L_{0}([0,1])}=\mid P \|_{L_{0}\left(I_{a}\right)} \geq \exp \left(-c_{4} \log (4 M) n^{1 / 2}\right) \tag{4.3}
\end{equation*}
$$

Assume that $P$ has exactly $m-1$ sign changes in $I_{a}$. Then $\widetilde{P}$ has exactly $m-1 \geq 0$ sign changes in $(0,1)$. We denote the sign changes of $\widetilde{P}$ in $(0,1)$ by $x_{1}, x_{2}, \ldots, x_{m-1}$. We define

$$
Q(x):=\prod_{j=1}^{m-1}\left(x-x_{j}\right)
$$

(the empty product is defined to be 1 ). Then $\widetilde{P} Q$ does not change sign in $(0,1)$. Observe that

$$
\left\|x-x_{j}\right\|_{L_{0}([0,1])} \geq c_{5}, \quad j=1,2, \ldots, m-1
$$

hence

$$
\begin{equation*}
\|Q\|_{L_{0}([0,1])} \geq \exp \left(-c_{6} m\right) \tag{4.4}
\end{equation*}
$$

Combining (4.3), (4.4), the multiplicative property of the geometric mean, the comparison between the $L_{0}([0,1])$ and $L_{1}([0,1])$ norms, the fact that $\widetilde{P} Q$ does not change sign, (4.2), and the fact that the sum of the absolute values of the coefficients of $Q$ is at most $2^{m}$, we obtain

$$
\begin{aligned}
\exp \left(-c_{4} \log (4 M) n^{1 / 2}-c_{6} m\right) & \leq\|\widetilde{P} Q\|_{L_{0}([0,1])} \leq\|\widetilde{P} Q\|_{L_{1}([0,1])}=\left|\int_{0}^{1}(\widetilde{P} Q)(x) d x\right| \\
& \leq 2^{m}(n+1) M 2^{-n / m}
\end{aligned}
$$

Taking the $\log$ of both sides above and choosing

$$
m:=\left\lfloor\frac{c_{7} n^{1 / 2}}{\log (4 M)}\right\rfloor
$$

with a sufficiently small absolute constant $c_{7}>0$, we get a contradiction.
