Inverse scattering transform for the discrete nonlocal PT symmetric nonlinear Schrödinger equation with nonzero boundary conditions

Abstract

In this paper, the inverse scattering transform for the integrable discrete nonlocal PT symmetric nonlinear Schrödinger equation with nonzero boundary conditions is presented. According to the two different signs of symmetry reduction and two different values of the phase difference between plus and minus infinity, we discuss four cases with significant differences about analytical regions, symmetry, asymptotic behavior and the presence or absence of discrete eigenvalues, namely, the existence or absence of soliton solutions. Therefore, in all cases, we study the direct scattering and inverse scattering problem, separately. The Riemann-Hilbert problem is constructed and solved as well as the reconstruction formula of potential is derived, respectively. Finally, combining the time evolution, we provide the dark, bright, dark-bright soliton solutions on the nonzero background in difference cases under the reflectionless condition.

Keywords: Discrete nonlocal nonlinear Schrödinger equation; PT symmetry; Inverse scattering transform; Riemann-Hilbert problem; Soliton solutions.

1 Introduction

Nonlinear phenomena are widely present in nature [1] and have received sufficient attention from various fields such as nonlinear optics, hydrodynamics, fluids [2–5]. Integrable system, which can be used to study nonlinear phenomena, has been studied worldwide over the past few decades and has developed rapidly in mathematics and physics [6–9]. The nonlinear Schrödinger (NLS) equation

$$i q_t(x,t) + q_{xx}(x,t) \pm 2 |q(x,t)|^2 q(x,t) = 0$$
(1.1)

is a typical and significant nonlinear integrable model that has been applied in many fields such as fluid dynamics, plasma physics, optical fibers and the atomic realm of Bose-Einstein condensates [10–12]. Therefore, the importance of Eq. (1.1) further allows ones to find classes of its exact solutions by Darboux transformation [13], the inverse scattering transform (IST) [14], Hirota bilinear method [15].

Although there is sufficient emphasis on studying continuous systems, the discrete ones have also been found to be important and are used to characterize many phenomena in physics, biology, nonlinear optics [16–19], since matter itself is discrete [17]. Therefore, there is significant interest in the study of nonlinear waves

in media that are governed by nonlinear discrete evolution systems. In 1975-1976, Ablowitz and Ladik [16, 20] introduced and discussed the integrable discrete nonlinear Schrödinger (NLS) equation

$$i q_{n,t}(t) = q_{n+1}(t) - 2 q_n(t) + q_{n-1}(t) - \sigma |q_n(t)|^2 (q_{n+1}(t) + q_{n-1}(t)), \qquad (1.2)$$

where the function $q_n(t)$ depends on the discrete space variable $n \in \mathbb{Z}$ and the continuous time variable $t \in \mathbb{R}$, $q_{n,t}(t) = \frac{dq_n(t)}{dt}$, $\sigma = \mp 1$ represents the focusing/defocusing cases, respectively and it is the so-called Ablowitz-Ladik equation. Eq. (1.2) has infinite conserved quantities and is also one of the most important nonlinear lattice models because it possesses nonlinearity and lattice dispersion as well as it can be applied in many physical phenomena including the dynamics of the condensed matter, anharmonic lattices, Heisenberg spin chains [19–23]. In fact, Eq. (1.2) has the more general form [24]:

$$i q_{n,t}(t) = q_{n+1}(t) - 2 q_n(t) + q_{n-1}(t) - q_n(t) r_n(t) \left(q_{n+1}(t) + q_{n-1}(t) \right), \qquad (1.3a)$$

$$-ir_{n,t}(t) = r_{n+1}(t) - 2r_n(t) + r_{n-1}(t) - q_n(t)r_n(t)\left(r_{n+1}(t) + r_{n-1}(t)\right).$$
(1.3b)

Under the symmetry reduction condition $r_n(t) = \sigma q_n^*(t)$ (The symbol * stands for the complex conjugate), Eqs. (1.3) are reduced to Eq. (1.2).

One of the most important aspects in the research of nonlinear integrable systems is to obtain exact solutions, among which the IST is one of the most effective and complete method and in recent years, many initial-value problems for Eq. (1.2) have already been solved via this method. Eq. (1.2) with zero boundary condition (ZBC) was solved via the IST and its one-order [10, 16, 20] and higher-order [25] soliton solutions entirely related to discrete spectrum were obtained. For Eq. (1.2) with $\sigma = 1$, Ref. [26] confirmed the l^2 -Sobolev space bijectivity of the IST; under the nonzero boundary conditions (NZBCs), Ref. [27] studied the IST under the condition of $|q_n(t)| < 1$ and obtained multisoliton solutions; Ref. [28] further relaxed the implicit requirement in Ref. [27] that the eigenfunctions are entire functions of the scattering parameter and obtained dark-soliton solutions as well as discussed the small-amplitude and continuum limits of the problem; Ref. [29] developed its IST with arbitrarily a large background at space infinity and then presented the discrete analog of Kuznetsov-Ma, Akhmediev, Peregrine solutions. For the IST of focusing Eq. (1.2) under the NZBCs, Ref. [23] constructed the robust IST by which the general Darboux matrix can possess the Riemann-Hilbert (RH) representation; Ref. [30] developed it without introducing a uniformization coordinate and derived the left Marchenko equations to solve the inverse problem, but in Ref. [18] and [31], the inverse problem is posed as a RH problem.

Recently, integrable discrete nonlocal PT symmetric NLS equation

$$i q_{n,t}(t) = q_{n+1}(t) - 2 q_n(t) + q_{n-1}(t) - \sigma q_n(t) q_{-n}^*(t) \left(q_{n+1}(t) + q_{n-1}(t) \right), \tag{1.4}$$

which corresponds to Eqs. (1.3) with the symmetry reduction condition $r_n(t) = \sigma q_{-n}^*(t)$, has been introduced by Ablowitz and Musslimani [22]. Eq. (1.4) is an integrable Hamiltonian system and also possesses infinite conservation laws as well as has particularly rich mathematical structure and interesting physical behavior [22, 32]. Regarding the IST for Eq. (1.4), Ablowitz and Musslimani [22] obtained the discrete onesoliton solution by a left-right RH formulation with the potentials rapidly vanishing as $n \to \pm \infty$; Grahovski, Mohammed and Susanto [33] developed the IST and derived one and two-soliton solutions while they also proved the completeness relation for the associated Jost solutions so that they derived the expansion formula over the complete set of Jost solutions; In 2020, Ablowitz, Luo and Musslimani [24] further analyzed symmetries of the eigenfunctions, scattering data and norming constants for all nonlocal cases of discrete NLS equation under not only PT symmetry but also reverse-space-time symmetry and reverse-time symmetry, finally, they provided soliton solutions for both local and three nonlocal cases, respectively. But so far, the complete theory of the IST for Eq. (1.4) with nonzero boundary conditions (NZBCs) still remains open, which we will discuss in turn. For Eq. (1.4), which is Eqs. (1.3) with $r_n(t) = \sigma q_{-n}^*(t)$, we consider the potential satisfying the following NZBCs:

$$\lim_{n \to \pm \infty} q_n(t) = q_{\pm}(t) = q_0 e^{i\vartheta_{\pm}(t)}, \\ \vartheta_{\pm}(t) = \theta_{\pm} + 2\sigma\delta t,$$
(1.5)

where q_0 , θ_{\pm} are real constant parameters and $\delta = q_0^2 e^{i\Delta\theta}$ with $\Delta\theta = \theta_+ - \theta_-$ should also be real so that $\Delta\theta = k\pi$, $k \in \mathbb{Z}$, then the boundary conditions are bounded, that is the only case we consider here. We choose $\Delta\theta = 0$ or $\Delta\theta = \pi$, so in the following content, we focus on the four cases:

- (i) $\sigma = 1, \Delta \theta = 0, \ \theta_{+} = \theta_{-} = \theta, \ \delta = q_{0}^{2}, \ \lim_{n \to \pm \infty} q_{n}(t) = q_{\pm}(t) = q_{0}e^{i(\theta + 2q_{0}^{2}t)}, \ \lim_{n \to \pm \infty} r_{n}(t) = q_{\mp}^{*}(t) = q_{0}e^{-i(\theta + 2q_{0}^{2}t)};$
- (ii) $\sigma = 1, \ \Delta \theta = \pi, \ \theta_{+} = \pi + \theta_{-}, \ \delta = -q_{0}^{2}, \ \lim_{n \to \pm \infty} q_{n}(t) = q_{\pm}(t) = q_{0}e^{i(\theta_{\pm} 2q_{0}^{2}t)}, \ \lim_{n \to \pm \infty} r_{n}(t) = q_{\pm}^{*}(t) = q_{0}e^{-i(\theta_{\pm} 2q_{0}^{2}t)};$
- (iii) $\sigma = -1, \ \Delta \theta = 0, \ \theta_{+} = \theta_{-} = \theta, \ \delta = q_{0}^{2}, \ \lim_{n \to \pm \infty} q_{n}(t) = q_{\pm}(t) = q_{0}e^{i(\theta 2q_{0}^{2}t)}, \ \lim_{n \to \pm \infty} r_{n}(t) = -q_{\mp}^{*}(t) = -q_{0}e^{-i(\theta 2q_{0}^{2}t)};$
- (iv) $\sigma = -1, \ \Delta \theta = \pi, \ \theta_{+} = \pi + \theta_{-}, \ \delta = -q_{0}^{2}, \ \lim_{n \to \pm \infty} q_{n}(t) = q_{\pm}(t) = q_{0}e^{i(\theta_{\pm} + 2q_{0}^{2}t)}, \ \lim_{n \to \pm \infty} r_{n}(t) = -q_{\pm}^{*}(t) = -q_{0}e^{-i(\theta_{\pm} + 2q_{0}^{2}t)}.$

The corresponding discrete scattering problem and the time-dependence equation of Eq. (1.4) are

$$\varphi_{n+1} = \mathbf{U}_n \varphi_n = (\mathbf{Z} + \mathbf{Q}_n) \varphi_n, \tag{1.6a}$$

$$\varphi_{n,t} = \mathbf{V}_n \varphi_n = i\sigma_3 \left(\mathbf{Q}_n \mathbf{Q}_{n-1} - \mathbf{Z}\mathbf{Q}_n + \mathbf{Q}_{n-1}\mathbf{Z} - \frac{(z-z^{-1})^2}{2}\mathbf{I}_2 \right) \varphi_n,$$
(1.6b)

where $\varphi_n = (\varphi_n^{(1)}(t), \varphi_n^{(2)}(t))^T$ (*T* is the transposition), \mathbf{I}_2 is the 2 × 2 identity matrix, *z* is the scattering parameter that is independent of *n* and *t*,

$$\mathbf{Z} = \begin{pmatrix} z & 0\\ 0 & z^{-1} \end{pmatrix}, \ \sigma_3 = \begin{pmatrix} 1 & 0\\ 0 & -1 \end{pmatrix}, \ \mathbf{Q_n} = \begin{pmatrix} 0 & q_n(t)\\ r_n(t) & 0 \end{pmatrix}$$

in which we still denote $\sigma q_{-n}^*(t)$ as $r_n(t)$ for simplifying writing in the following content. Eq. (1.4) is equivalent to the discrete compatibility condition $\frac{d}{dt}\varphi_{n+1}(t) = \left(\frac{d}{dt}\varphi_j(t)\right)_{j=n+1}$.

The main purpose of our work is to develop rigorous theory of the IST for Eqs. (1.3) with PT symmetry reduction $r_n(t) = \sigma q_{-n}^*(t)$ or Eq. (1.4) for the above four cases. In each case, we discuss the direct scattering problem including the analysis of analyticity, asymptotic behavior, symmetry for eigenfunctions and scattering coefficients, inverse scattering problem consisting of constructing and solving a RH problem, as well as analyzing the existence of soliton solutions in detail. Due to the nonlocal case, there are many novel properties and conclusions different from the local one. Specifically, the highlights of this article are the following: (i) For the four cases, the constraints for constant background, analytic regions, continuous spectrum, asymptotic behavior of scattering coefficients and so on have great differences, which we show in the text; (ii) The second symmetry about $\zeta \mapsto \overline{\zeta}^* = \frac{r\zeta^* - 1}{\zeta^* - r}$ is deduced by introducing the "backward" modified scattering problem and analysing modified eigenfunctions, which has not been analyzed in local systems with NZBCs. Furthermore, the second symmetry for the four cases is also distinct; (iii) The discrete eigenvalues here are only obtained by comparing the trace formula with asymptotic behavior of scattering coefficients and the number of discrete eigenvalues is really different in certain cases; (iv) Due to the strong limitations on discrete eigenvalues, not all cases exist soliton solutions for Eq. (1.4) with NZBCs (1.5). For example, in the Case (i), the single eigenvalue is not exist so that there is no first order solution. The simplest reflectionless potential generates second order soliton solutions, which include dark-dark, darkbright, bright-bright ones. In the Case (ii): $\sigma = 1, \Delta \theta = \pi$, we have showed there are no discrete eigenvalues so that the soliton solutions are not exist.

This article is organized as follows. In Section 2, we mainly present the IST for the case (i). The direct scattering problem is discussed in Section 2.1, which includes the definitions of eigenfunctions and scattering matrix, as well as the analysis of analyticity, asymptotic behavior and two types of symmetry. In Section 2.2, the inverse scattering problem is organized: We construct and solve a suitable RH problem and then we get the reconstructed potential. In addition, we analysis the trace formula and obtain suitable discrete eigenvalues composed of quartets according the asymptotic behavior of scattering coefficients. The time evolution of eigenfunctions, scattering coefficients are studied in Section 2.3 and under the reflectionless condition, the second-order soliton solutions containing dark-dark, dark-bright, bright-bright ones are displayed in Section 2.4. Even in the defocusing ($\sigma = 1$) and no phase difference ($\Delta \theta = 0$) case, many analyses are different from Ref. [28]. Therefore, we will still provide detailed analysis except for deleting the proof of the same parts and only retaining the conclusion. The method in other three cases follows along similar progress but the details are quite distinct so that the different discussion is also developed such as the analysis of continuous spectrum, analytic region and discrete eigenvalues/soliton solutions, and the similar ones are only providing results in Section 3-5.

2 Case (i): $\sigma = 1$, $\Delta \theta = 0$

In this section, we will investigate the IST for Eq. (1.4) with NZBCs (1.5) meeting the case (i).

2.1 The direct scattering problem

For convenience, we will temporarily omit the time evolution of solutions now so that we rewrite the NZBCs (1.5) and $\lim_{n\to\pm\infty}r_n(t)$ as

$$\lim_{n \to \pm \infty} q_n = q_{\pm} = q_0 e^{i\vartheta}, \quad \lim_{n \to \pm \infty} r_n = r_{\pm} = q_0 e^{-i\vartheta}, \quad (2.1)$$

where $\vartheta = \theta + 2q_0^2 t$ is also real.

2.1.1 Eigenfunctions, scattering matrix, uniformization variable

Under the boundary conditions (2.1) and symmetry reduction condition $r_n(t) = q_{-n}^*(t)$, it is easy to prove that Eq. (1.6a) has the solution matrices $\Phi_n(z)$ and $\Psi_n(z)$ satisfying

$$\boldsymbol{\Phi}_{n}(z) = \left(\phi_{n}(z), \bar{\phi}_{n}(z)\right) \sim r^{n} \begin{pmatrix} q_{-} & \lambda r - z \\ \lambda r - z & -r_{-} \end{pmatrix} \boldsymbol{\Lambda}^{n}, \ n \to -\infty,$$
(2.2a)

$$\Psi_n(z) = \left(\bar{\psi}_n(z), \psi_n(z)\right) \sim r^n \begin{pmatrix} q_+ & \lambda r - z \\ \lambda r - z & -r_+ \end{pmatrix} \mathbf{\Lambda}^n, \ n \to +\infty,$$
(2.2b)

where $\phi_n(z)$, $\bar{\phi}_n(z)$, $\bar{\psi}_n(z)$, $\psi_n(z)$ are eigenfunctions, $r = \sqrt{1 - q_0^2} \in \mathbb{R}$ with $0 < q_0 < 1$, $\lambda(z) = \xi \pm \sqrt{\xi^2 - 1}$ with $\xi(z) = \frac{z + \frac{1}{z}}{2r}$, $\mathbf{\Lambda} = diag(\lambda, \frac{1}{\lambda})$. λ and z satisfy $r(\lambda + \frac{1}{\lambda}) = z + \frac{1}{z}$. It is easy to obtain that $\lambda(z)$ is a double-valued function of z and has four branch points $\pm z_0$ and $\pm z_0^*$ meeting $\xi(z)^2 = 1$, where

$$z_0 = r + iq_0 \tag{2.3}$$

and all branch points are located on the unit circle $\{z \in \mathbb{C} : |z| = 1\}$. Furthermore, we can prove that the continuous spectrum of the scattering problem is any z that meet $|\lambda(z)| = 1$ and this corresponds to the set:

$$\{z \in \mathbb{C} : |z| = 1 \text{ and } |Rez| < r\}, \qquad (2.4)$$

which is two arcs $(z_0, -z_0^*), (z_0^*, -z_0)$ on the unit circle $\{z \in \mathbb{C} : |z| = 1\}$.

Two solutions φ_n , $\overline{\varphi}_n$ of scattering problem obey the recursion relation:

$$Det\left(\varphi_{n+1}, \bar{\varphi}_{n+1}\right) = (1 - q_n r_n) Det\left(\varphi_n, \bar{\varphi}_n\right) \,. \tag{2.5}$$

Furthermore, one also has

$$Det\left(r^{-n}\phi_n(z), r^{-n}\bar{\phi}_n(z)\right) \sim -(\lambda r - z)^2 - q_0^2, n \to -\infty$$
$$Det\left(r^{-n}\bar{\psi}_n(z), r^{-n}\psi_n(z)\right) \sim -(\lambda r - z)^2 - q_0^2, n \to +\infty$$

so that

$$Det\left(\mathbf{\Phi}_{n}(z)\right) = -\left(\left(\lambda r - z\right)^{2} + q_{0}^{2}\right)r^{2n}\prod_{k=-\infty}^{n-1}\frac{1 - q_{k}r_{k}}{1 - q_{0}^{2}},$$
(2.6a)

$$Det\left(\Psi_n(z)\right) = -\left((\lambda r - z)^2 + q_0^2\right) r^{2n} \prod_{k=n}^{+\infty} \frac{1 - q_0^2}{1 - q_k r_k}.$$
(2.6b)

We can prove that $(\lambda r - z)^2 + q_0^2 = 0$ if and only if $z = \pm z_0$ or $z = \pm z_0^*$, which are the four branch points of $\lambda(z)$. In addition, we assume $0 < q_0 < 1$ and impose a small norm condition on potential functions q_n , r_n for any $n \in \mathbb{Z}$, then Eqs. (2.6) don't equal zero so that $\phi_n(z)$ and $\bar{\phi}_n(z)$, $\bar{\psi}_n(z)$ and $\psi_n(z)$ are linearly independent for any $z \in \mathbb{C}$ except $\pm z_0$ and $\pm z_0^*$, respectively so that both $\Phi_n(z)$ and $\Psi_n(z)$ are the fundamental solutions of scattering problem for any $z \in \mathbb{C}$ except $\pm z_0$ and $\pm z_0^*$. As a consequence, we can introduce a *n*-independent and invertible scattering matrix T(z) to relate these two solution matrices

$$\mathbf{\Phi}_{n}(z) = \mathbf{\Psi}_{n}(z)\mathbf{T}(z), \ \mathbf{T}(z) = \begin{pmatrix} t_{11}(z) & t_{12}(z) \\ t_{21}(z) & t_{22}(z) \end{pmatrix}$$
(2.7)

and $t_{ij}(z)$, i, j = 1, 2 are defined as the scattering coefficients. According to Eq. (2.7) and using Eqs. (2.6), one obtains

$$t_{11}(z)t_{22}(z) - t_{21}(z)t_{12}(z) = \Theta_{-\infty}, \qquad (2.8)$$

where

$$\Theta_{-\infty} = \lim_{n \to -\infty} \Theta_n, \Theta_n = \prod_{k=n}^{+\infty} \frac{1 - q_k r_k}{1 - q_0^2}$$
(2.9)

and the scattering coefficients can be represented by determinant expressions of eigenfunctions as

$$t_{11}(z) = \frac{Det(\phi_n(z), \psi_n(z))}{Det(\bar{\psi}_n(z), \psi_n(z))}, t_{22}(z) = \frac{Det(\bar{\psi}_n(z), \bar{\phi}_n(z))}{Det(\bar{\psi}_n(z), \psi_n(z))},$$
(2.10a)

$$t_{21}(z) = \frac{Det(\bar{\psi}_n(z), \phi_n(z))}{Det(\bar{\psi}_n(z), \psi_n(z))}, t_{12}(z) = \frac{Det(\bar{\phi}_n(z), \psi_n(z))}{Det(\bar{\psi}_n(z), \psi_n(z))}.$$
(2.10b)

From Eqs. (2.10), we know that if z_j is a zero of $t_{11}(z)$, we have $Det(\phi_n(z_j), \psi_n(z_j)) = 0$, namely, $\phi_n(z_j) = b_j \psi_n(z_j)$ with a complex parameter b_j . Likewise, if \bar{z}_j is a zero of $t_{22}(z)$, then $Det(\bar{\psi}_n(\bar{z}_j), \bar{\phi}_n(\bar{z}_j)) = 0$, namely, $\bar{\psi}_n(\bar{z}_j) = \bar{b}_j \bar{\phi}_n(\bar{z}_j)$ with a complex parameter \bar{b}_j .

As mentioned above, $\lambda(z)$ is a double-valued function of z so that we should define two-sheeted Riemann surface to ensure that eigenfunctions and the scattering coefficients are single-valued functions of z. This complexity can be addressed by defining the uniformization variable:

$$\zeta(z) = \lambda(z)/z \,, \tag{2.11}$$

so that the mappings are given by

$$z^{2} = \frac{\zeta - r}{\zeta(\zeta r - 1)}, \ \lambda^{2} = \zeta \frac{\zeta - r}{\zeta r - 1}, \ z\lambda = \frac{\zeta - r}{\zeta r - 1}$$
(2.12)

and all even functions of λ and z can be expressed as a ratio of two rational functions of ζ .

Next, we will discuss the mapping $z, \lambda \to \zeta$. We can directly obtain that the continuous spectrum, which refers to two arcs $(z_0, -z_0^*), (z_0^*, -z_0)$ on the unit circle $\{z \in \mathbb{C} : |z| = 1\}$, is mapped onto the unit circle $\{\zeta \in \mathbb{C} : |\zeta| = 1\}$. The four branch points $\pm z_0, \pm z_0^*$ are mapped onto two points $\zeta_0 = \zeta(\pm z_0^*) = z_0$, $\zeta_0^* = \zeta(\pm z_0) = z_0^*$ in the ζ -plane. Furthermore, we can show that

$$|\lambda| \le 1 \Leftrightarrow |\zeta| \le 1. \tag{2.13}$$

Defining $\Sigma = \{\zeta \in \mathbb{C} \mid |\zeta| = 1\}$ and its positive orientation is anticlockwise as shown in Fig. 1. Therefore, the regions

$$D_{+} = \{\zeta \in \mathbb{C} \mid |\zeta| < 1\}, \ D_{-} = \{\zeta \in \mathbb{C} \mid |\zeta| > 1\}$$
(2.14)

are the corresponding positive region for $|\lambda| < 1$ and negative region for $|\lambda| > 1$.

Constructing the modified eigenfunctions

$$(M_n(z), \overline{M}_n(z)) = r^{-n} \mathbf{\Omega} \, \boldsymbol{\Phi}_n(z) \mathbf{\Omega}^{-1} \boldsymbol{\Lambda}^{-n} \,, \tag{2.15a}$$

$$(N_n(z), N_n(z)) = r^{-n} \mathbf{\Omega} \, \boldsymbol{\Psi}_n(z) \mathbf{\Omega}^{-1} \mathbf{\Lambda}^{-n}$$
(2.15b)

with $\Omega = diag(1, \lambda)$, then they can be represented by ζ and the modified scattering problems can all be written in terms of ζ .

2.1.2 Analyticity of modified eigenfunctions and scattering coefficients

To begin with, we introduce three modifications to define new eigenfunctions, whose corresponding Green's functions are relatively simple and have no singularities.

the modified potentials \dot{q}_n , $\dot{r}_n = \dot{q}^*_{-n}$ satisfy the boundary conditions $\lim_{n \to \pm \infty} \dot{q}_n = q_{\pm}$, $\lim_{n \to \pm \infty} \dot{r}_n = r_{\pm}$ and the constraint $\dot{q}_n \dot{r}_n = q_0^2$, $n \in \mathbb{Z}$.

We define the second modification as

with $\eta_n^{[1]} = \dot{q}_n r_n - q_0^2$, $\eta_n^{[2]} = q_n - \dot{q}_n$, $\eta_n^{[3]} = \dot{q}_{n+1} - \dot{q}_n$ all decaying as $n \to \pm \infty$ so that $\dot{\mathbf{U}}'_n$ decays as $n \to \pm \infty$. We introduce the 2×1 new eigenfunction to remove the *n* power coefficient in the boundary condition

We introduce the 2×1 new eigenfunction to remove the *n* power coefficient in the boundary condition as the third modification:

$$\dot{M}_n = r^{-n} \lambda^{-n} \dot{\mathbf{Y}}_{n,1} \,, \tag{2.31}$$

where subscript '1' of $\mathbf{Y}_{n,1}$ is the first column of the matrix so that we can get the boundary condition

We can set the solution of Eq. (2.33) meeting the following summation equation:

$$\|C_n^1(\zeta)\| \le \sum_{k=-\infty}^{n-1} \| \begin{pmatrix} 1 & 0\\ 0 & (\frac{r\zeta-1}{\zeta(\zeta-r)})^{n-1-k} \end{pmatrix} \| \| \frac{1}{r\lambda} \dot{\mathbf{U}}_k'(\zeta) \| \| C_n^0(\zeta) \| \le \frac{1}{1!} \left(\sum_{k=-\infty}^{n-1} \| \mathcal{U}_k \| \right)^1;$$

Assuming that Eq. (2.38) holds for j, then for j + 1, we have $|\zeta| \ge 1$ if and only if $\left|\frac{\zeta(\zeta-r)}{r\zeta-1}\right| \ge 1$ so that

$$\begin{split} \|C_{n}^{j+1}(\zeta)\| &\leq \sum_{k=-\infty}^{n-1} \| \left(\begin{array}{cc} 1 & 0 \\ 0 & (\frac{r\zeta-1}{\zeta(\zeta-r)})^{n-1-k} \end{array} \right) \| \| \frac{1}{r\lambda} \dot{\mathbf{U}}_{k}'(\zeta) \| \| C_{n}^{j}(\zeta) \| \\ &\leq \sum_{k=-\infty}^{n-1} \| \mathcal{U}_{k} \| \frac{1}{j!} \left(\sum_{l=-\infty}^{n-1} \| \mathcal{U}_{l} \| \right)^{j} \\ &\leq \frac{1}{(j+1)!} \left(\sum_{k=-\infty}^{n-1} \| \mathcal{U}_{k} \| \right)^{j+1}. \end{split}$$

If the potentials $q_n, r_n, \dot{q}_n, \dot{r}_n \in \left\{ f_n : \sum_{l=\pm\infty}^n |f_l - \lim_{k \to \pm\infty} f_k| < \infty, \forall n \in \mathbb{Z} \right\}$ in $\dot{U}'_n(\zeta)$, we can prove $\sum_{k=-\infty}^{+\infty} |\eta_k^{[j]}| < +\infty, j = 1, 2, 3$. For example,

$$|\eta_k^{[3]}| = |\dot{q}_{k+1} - \dot{q}_k| \le |\dot{q}_{k+1} - q_{\mp}| + |\dot{q}_k - q_{\mp}| = \begin{cases} |\dot{q}_{k+1} - q_{-}| + |\dot{q}_k - q_{-}|, as \ j \le n \\ |\dot{q}_{k+1} - q_{+}| + |\dot{q}_k - q_{+}|, as \ j \ge n \end{cases}$$

so that

$$\sum_{k=-\infty}^{+\infty} |\eta_k^{[3]}| \le \sum_{k=-\infty}^n (|\dot{q}_{k+1} - \dot{q}_-| + |\dot{q}_k - \dot{q}_-|) + \sum_{k=n+1}^{+\infty} (|\dot{q}_{k+1} - q_+| + |\dot{q}_k - q_+|) < +\infty.$$

The above means that $\sum_{k=-\infty}^{+\infty} \|\mathcal{U}_k\| < +\infty$. Therefore, For $n \leq N \in \mathbb{Z}^+$, $\sum_{k=-\infty}^{n-1} \|\mathcal{U}_k\| \leq \sum_{k=-\infty}^{N-1} \|\mathcal{U}_k\| \doteq \sigma$, where σ is a constant independent of n. Then $\|C_n^j(\zeta)\| \leq \frac{\sigma^j}{j!}$, we can obtain

$$\|\sum_{j=0}^{\infty} C_n^j(\zeta)\| \le \sum_{j=0}^{\infty} \|C_n^j(\zeta)\| \le \sum_{j=0}^{\infty} \frac{\sigma^j}{j!} = e^{\sigma},$$

namely, the series (2.37) converges absolutely and uniformly.

B. The uniqueness of solution of Eq. (2.36)

Assuming $\sum_{j=0}^{\infty} C_{n,1}^j(\zeta)$ and $\sum_{j=0}^{\infty} C_{n,2}^j(\zeta)$ are both the solutions of Eq. (2.36) so that their difference $C_{n,-}(\zeta) = \sum_{j=0}^{\infty} \left(C_{n,1}^j(\zeta) - C_{n,2}^j(\zeta) \right)$ is such that

If the potentials $q_n, r_n, \dot{q}_n, \dot{r}_n \in \left\{ f_n : \sum_{l=\pm\infty}^n |f_l - \lim_{k\to\pm\infty} f_k| < \infty, \forall n \in \mathbb{Z} \right\}$ in $\dot{U}'_n(\zeta)$, we can set $\sum_{k=-\infty}^{+\infty} ||\mathcal{U}_k|| < +\infty$. According to Dispersed Bellman Inequality, we obtain $C_{n,-}(\zeta) \equiv 0$. So far, we have proved the uniqueness of solution of Eq. (2.36) and completed the proof of **Lemma 1**.

Furthermore, because of the analyticity of $C_n^0(\zeta)$ and $\frac{1}{r\lambda} diag(1, (\frac{r\zeta-1}{\zeta(\zeta-r)})^{n-1-k}) \dot{\mathbf{U}}'_k(\zeta)$ in $D_-, C_n^j(\zeta)$ are analytic in D_- for all j, which indicates that $\dot{M}_n(\zeta) = \sum_{j=0}^{\infty} C_n^j(\zeta)$ is analytic in D_- so that M_n is analytic in D_- except for the only possible pole $\zeta = \infty$. Similarly, we can prove the analyticity for other modified eigenfunctions and scattering coefficients (2.23), then we conclude the following theorem:

Theorem 1 Under the condition of the potentials $q_n, r_n, \dot{q}_n, \dot{r}_n \in \left\{ f_n : \sum_{l=\pm\infty}^n |f_l - \lim_{k \to \pm\infty} f_k| < \infty, \forall n \in \mathbb{Z} \right\},$ $M_n, N_n, t_{11}(\zeta) = \tilde{t}_{11}(\zeta)$ are analytic in D_- (except for the only possible pole $\zeta = \infty$) and $\bar{M}_n, \bar{N}_n,$ $t_{22}(\zeta) = \tilde{t}_{22}(\zeta)$ are analytic in D_+ (except for the only possible pole $\zeta = 0$).

2.1.3 Asymptotic behavior of modified eigenfunctions and scattering coefficients

According the definition of uniformization variable ζ , when $z \to 0$, $\lambda \to 0$, we have $\zeta \to r$; When $z \to \infty$, $\lambda \to \infty$, we have $\zeta \to \frac{1}{r}$ so that we should also consider the asymptotic behavior when $\zeta \to r, \frac{1}{r}$. By direct calculations, the asymptotic behavior of z^2, λ^2 and $z\lambda$ can be obtained shown in Table 1.

Then, we investigate the asymptotic behavior of modified eigenfunctions and scattering coefficients. It is easy to obtain the Laurent series expansion as $\zeta \to \infty$ of $\frac{1}{\lambda^2}, \frac{1}{z\lambda}$:

where the constants $M_n^{(1),k}$, $M_n^{(2),k}$ are unknown and substituting it into Eq. (2.16), we have

$$r \sum_{k=-1}^{\infty} \frac{M_{n+1}^{(2),k}}{\zeta^k} = r_n \sum_{k=0}^{\infty} \frac{M_n^{(1),k}}{\zeta^k} + r \sum_{k=-1}^{\infty} \frac{M_n^{(2),k}}{\zeta^k} - q_0^2 \sum_{k=-1}^{\infty} M_n^{(2),k} \sum_{j=0}^{\infty} \frac{r^j}{\zeta^{k+j+1}}.$$

Combining with the boundary condition of $M_n(\zeta)$ to calculate the coefficients of each powers of ζ , we obtain the asymptotic behavior of $M_n(\zeta)$ as $\zeta \to \infty$:

and the asymptotic behavior of $\bar{M}_n(\zeta)$, $\bar{N}_n(\zeta)$ as $\zeta \to 0$, $\zeta \to r$, respectively:

$$\bar{M}_n(\zeta) = \begin{pmatrix} -\frac{1}{\zeta} + \mathcal{O}(1) \\ -r_{n-1} + \mathcal{O}(\zeta) \end{pmatrix}, \ \bar{N}_n(\zeta) = \frac{1}{\Theta_n} \begin{pmatrix} q_n + \mathcal{O}(\zeta) \\ -r + \mathcal{O}(\zeta) \end{pmatrix}, \ \zeta \to 0,$$
(2.45a)

$$\bar{M}_n(\zeta) = -r_- \begin{pmatrix} \frac{q_{n-1}}{r} + \mathcal{O}(\zeta - r) \\ 1 + \mathcal{O}(\zeta - r) \end{pmatrix}, \ \bar{N}_n(\zeta) = \frac{q_+}{\Theta_n} \begin{pmatrix} 1 + \mathcal{O}(\zeta - r) \\ \mathcal{O}(\zeta - r) \end{pmatrix}, \ \zeta \to r.$$
(2.45b)

According to Eq. (2.23a), we can also get the asymptotic behavior of scattering coefficients $t_{11}(\zeta)$ and $t_{22}(\zeta)$:

2.1.4 Symmetries of scattering coefficients

Based on the fact that the scattering problem (1.6a) is independent with λ , we know that $\phi_n(z, \frac{1}{\lambda})$ is the solution to Eq. (1.6a) as well. It is easy to prove that $\frac{r/\lambda-z}{-r_-}\bar{\phi}_n(z,\lambda)$ is also the solution to Eq. (1.6a) and has the same boundary condition with $\phi_n(z, \frac{1}{\lambda})$ as $n \to -\infty$. Therefore, we can obtain the following symmetries of eigenfunctions:

$$\phi_n(z, \frac{1}{\lambda}) = \frac{r/\lambda - z}{-r_-} \bar{\phi}_n(z, \lambda) \,. \tag{2.47}$$

Under the same consideration, we obtain the another symmetries of eigenfunctions:

According to Eqs. (2.47), (2.48) and (2.10) and the fact when $z \mapsto z$ and $\lambda \mapsto \frac{1}{\lambda}$, $\zeta \mapsto \overline{\zeta} = \frac{r\zeta - 1}{\zeta - r}$, we have the following symmetries of scattering coefficients:

In addition, according to Eq. (2.49), we can obtain

From Eq. (2.49), we also obtain that ζ_j is a simple zero of $t_{11}(\zeta)$ in D_- if and only if $\overline{\zeta}_j = \frac{r\zeta_j - 1}{\zeta_j - r}$ is a simple zero of $t_{22}(\zeta)$ in D_+ , which indicates that discrete eigenvalues always appear in pairs. By the defination of complex parameters b_k , \overline{b}_k before, the following symmetry of these two parameters is

$$b_k = -\frac{r_-}{q_+}\bar{b}_k \,, \tag{2.51}$$

this, as well as Eq. (2.50), will be used to calculate symmetry for norming constants that will be defined after.

In fact, the second symmetry can be analyzed by the modified scattering problems of modified eigenfunctions, which corresponds to that when $z \mapsto z^*$ and $\lambda \mapsto \frac{1}{\lambda^*}$, $\zeta \mapsto \overline{\zeta}^* = \frac{r\zeta^* - 1}{\zeta^* - r}$.

Due to nonlocal in space, it is necessary to consider the "backward" modified scattering problem of Eq. (2.16) as follows:

$$\mathcal{V}_{n-1}(z) = \begin{pmatrix} \lambda/(rz) & -q_n/r \\ -\lambda^2 r_n/r & z\lambda/r \end{pmatrix} \mathcal{V}_n(z), \qquad (2.52)$$

where $\mathcal{V}_n(z) = v_n \mathcal{W}_{n+1}(z)$, $v_n = \prod_{k=-\infty}^n \frac{1+q_0^2}{1-q_k r_k}$. According to $M_n(z)$ meeting difference equation (2.16), we can obtain that $M'_n(z) = (M^{(2)*}_{-n}(z^*), -M^{(1)*}_{-n}(z^*))^T$ is a solution of Eq. (2.52). In addition, $\bar{N}_n(z)$ is a solution of Eq. (2.16) so that $C_0 v_n \bar{N}_{n+1}(z)$ is a solution of Eq. (2.52) with *n*-independent unknown variable C_0 . By checking the boundary conditions of $M'_n(z)$ and $C_0 v_n \bar{N}_{n+1}(z)$ as $n \to +\infty$, we have

If Eq. (2.53) holds, we have $C_0 = -\frac{r_+}{\lambda/z-r}\Theta_{-\infty}$, which can also be obtained by comparing the boundary conditions of $M'^{(2)}_n(z)$ and $C_0 v_n \bar{N}^{(2)}_{n+1}(z)$. Thus, we have the following symmetry between the modified eigenfunctions of ζ :

By the similar process as above, we can get that $\bar{M}'_n(z) = (\bar{M}^{(2)*}_{-n}(z^*), -\bar{M}^{(1)*}_{-n}(z^*))^T$ is a solution of

$$\tilde{\mathcal{V}}_{n-1}(z) = \begin{pmatrix} (r\lambda z)^{-1} & -q_n/(r\lambda^2) \\ -r_n/r & z/(\lambda r) \end{pmatrix} \tilde{\mathcal{V}}_n(z) , \qquad (2.55)$$

where $\tilde{\mathcal{V}}_n(z) = v_n \tilde{\mathcal{W}}_{n+1}(z)$, $\tilde{\mathcal{W}}_n(z)$ meets difference equation (2.17). In addition, it is easy know that $\bar{C}_0 v_n N_{n+1}(z)$ is a solution of Eq. (2.55) with *n*-independent unknown variable \bar{C}_0 . By checking the boundary conditions of $\bar{M}'_n(z)$ and $\bar{C}_0 v_n N_{n+1}(z)$ as $n \to +\infty$, we have

$$\lim_{n \to +\infty} \bar{M}_n^{\prime(1)}(z) = -q_+ = \lim_{n \to +\infty} \bar{C}_0 \, v_n N_{n+1}^{(1)}(z) = \frac{C_0 \left(r - z/\lambda\right)}{\Theta_{-\infty}},\tag{2.56}$$

in which $\bar{C}_0 = \frac{q_+}{z/\lambda - r} \Theta_{-\infty}$ that can also be obtained by comparing the boundary conditions of $\bar{M}'_n^{(2)}(z)$ and $\bar{C}_0 v_n N_{n+1}^{(2)}(z)$. Thus, we have the following symmetry be expressed as ζ :

According to Eqs. (2.54), (2.57), (2.23) and the fact when $z \mapsto z^*$ and $\lambda \mapsto \frac{1}{\lambda^*}$, $\zeta \mapsto \overline{\zeta}^* = \frac{r\zeta^* - 1}{\zeta^* - r}$, we have the following symmetries of scattering coefficients:

From Eq. (2.58), we also obtain that ζ_j is a simple zero of $t_{11}(\zeta)$ in D_- if and only if $\overline{\zeta}_j^* = \frac{r\zeta_j^* - 1}{\zeta_j^* - r}$ is a simple zero of $t_{22}(\zeta)$ in D_+ , which indicates that discrete eigenvalues always appear in pairs.

2.2 The inverse scattering problem

We will accomplish this progress by looking for the RH problem and solve it to construct the reconstructed potentials.

2.2.1 The RH problem and reconstructed potential

We rewrite Eqs. (2.21) as the following jump condition on $|\zeta| = 1$

$$\mu(\zeta) - \bar{N}_n(\zeta) = \lambda(\zeta)^{-2n} \rho(\zeta) N_n(\zeta) , \qquad (2.59a)$$

where the new functions are defined as $\mu(\zeta) = \frac{M_n(\zeta)}{t_{11}(\zeta)}$, $\bar{\mu}(\zeta) = \frac{\bar{M}_n(\zeta)}{t_{22}(\zeta)}$ and the reflection coefficients are $\rho(\zeta) = \frac{\tilde{t}_{21}(\zeta)}{t_{11}(\zeta)}$ and $\bar{\rho}(\zeta) = \frac{\tilde{t}_{12}(\zeta)}{t_{22}(\zeta)}$. In the respective analytic regions, since the functions $\mu(\zeta)$ and $\bar{\mu}(\zeta)$ are meromorphic at the zeros of $t_{11}(\zeta)$, $t_{22}(\zeta)$, respectively, besides that, $\mu(\zeta)$, $N_n(\zeta)$ and $\bar{\mu}(\zeta)$, $\bar{N}_n(\zeta)$ have the poles at $\zeta = \infty$, $\zeta = 0$, respectively, we will discuss the asymptotic behavior and residue conditions of these functions to detail and solve the RH problem.

In Section 2.1, the asymptotic behavior of modified eigenfunctions and scattering coefficients is all analyzed so that we have

$$\mu_n(\zeta) = \begin{pmatrix} q_{n-1} + \mathcal{O}(\zeta^{-1}) \\ \zeta + \mathcal{O}(1) \end{pmatrix}, \qquad N_n(\zeta) = \frac{1}{\Theta_n} \begin{pmatrix} r + \mathcal{O}(\zeta^{-1}) \\ -r_n + \mathcal{O}(\zeta^{-1}) \end{pmatrix}, \zeta \to \infty, \qquad (2.60a)$$

$$\bar{\mu}_n(\zeta) = \begin{pmatrix} -\frac{1}{\zeta} + \mathcal{O}(1) \\ -r_{n-1} + \mathcal{O}(\zeta) \end{pmatrix}, \qquad \bar{N}_n(\zeta) = \frac{1}{\Theta_n} \begin{pmatrix} q_n + \mathcal{O}(\zeta) \\ -r + \mathcal{O}(\zeta) \end{pmatrix}, \zeta \to 0, \qquad (2.60b)$$

$$\mu_n(\zeta) = q_- \left(\begin{array}{c} 1 + \mathcal{O}(\zeta - \frac{1}{r}) \\ \frac{r_{n-1}}{r} + \mathcal{O}(\zeta - \frac{1}{r}) \end{array} \right), \qquad N_n(\zeta) = -\frac{r_+}{\Theta_n} \left(\begin{array}{c} \mathcal{O}(\zeta - \frac{1}{r}) \\ 1 + \mathcal{O}(\zeta - \frac{1}{r}) \end{array} \right), \zeta \to \frac{1}{r}, \qquad (2.60c)$$

$$\bar{\mu}_n(\zeta) = -r_- \begin{pmatrix} \frac{q_{n-1}}{r} + \mathcal{O}(\zeta - r) \\ 1 + \mathcal{O}(\zeta - r) \end{pmatrix}, \qquad \bar{N}_n(\zeta) = \frac{q_+}{\Theta_n} \begin{pmatrix} 1 + \mathcal{O}(\zeta - r) \\ \mathcal{O}(\zeta - r) \end{pmatrix}, \ \zeta \to r.$$
(2.60d)

In addition, we can easily obtain the following residue conditions

$$\operatorname{Res}_{\zeta=\zeta_j} \mu_n(\zeta) = C_j \,\lambda(\zeta_j)^{-2n} \,N_n(\zeta_j) \,, \, C_j = \frac{\tilde{t}_{21}(\zeta_j)}{t'_{11}(\zeta_j)},$$
(2.61a)

$$\operatorname{Res}_{\zeta=\bar{\zeta}_{j}}\bar{\mu}_{n}(\zeta) = \bar{C}_{j}\,\lambda(\bar{\zeta}_{j})^{2n}\,\bar{N}_{n}(\bar{\zeta}_{j})\,,\,\bar{C}_{j} = \frac{\tilde{t}_{12}(\bar{\zeta}_{j})}{t'_{22}(\bar{\zeta}_{j})}\,,\tag{2.61b}$$

where we assume that $t_{11}(\zeta)$ has J zeros, $t_{22}(\zeta)$ has \bar{J} zeros, $\frac{1}{t'_{11}(\zeta_j)}$, $\frac{1}{t'_{22}(\bar{\zeta}_j)}$ are the first derivatives of $t_{11}(\zeta)$ and $t_{22}(\zeta)$ at ζ_j and $\bar{\zeta}_j$, respectively and C_j , \bar{C}_j are the norming constants. In fact, we have $\tilde{t}_{21}(\zeta_j) = \lambda(\zeta_j)b_k$, $\tilde{t}_{12}(\bar{\zeta}_j) = \lambda(\bar{\zeta}_j)\bar{b}_k$. We also can get $C_j = -\frac{q_+^2}{(\bar{\zeta}_j - r)^2}\bar{C}_j$ according to Eqs. (2.50) and (2.51).

Dividing both sides of Eq. (2.59a) by $\zeta - r$, then subtracting the asymptotic behavior of $\frac{\mu(\zeta)}{\zeta - r}$ as $\zeta \to \infty$ and the effect of pole ζ_j , we have

Considering the asymptotic behavior of the above left side as $\zeta \to \infty$ and combining with Eqs. (2.60d), (2.61a), we can get

(2.63)

Dividing both sides of Eq. (2.59b) by $\zeta - \frac{1}{r}$ and dealing with the formula with the same technique as above, we obtain

Comparing the second component of Eq. (2.63) with $\zeta = 0$ and asymptotic behavior of $\bar{N}_n(\zeta)$ as $\zeta \to 0$ in Eq. (2.60b), we can obtain

2.2.2 The reflectionless condition

We can obtain the soliton solutions of Eq. (1.4) with the reflectionless condition $\rho(\zeta) = 0$, $\bar{\rho}(\zeta) = 0$ for

 $|\zeta| = 1$, under which Eqs. (2.63), (2.64), (2.65), (2.66) reduce to the solvable algebraic set of equations:

$$\bar{N}_{n}^{(2)}(\zeta) - (\zeta - r) \sum_{j=1}^{J} \frac{C_{j} \lambda(\zeta_{j})^{-2n}}{(\zeta_{j} - r)(\zeta - \zeta_{j})} N_{n}^{(2)}(\zeta_{j}) = \zeta - r , \qquad (2.67b)$$

In addition, the all J simple zeros of $t_{11}(\zeta)$ can be divided into two classes denoted by ζ_j , $j = 1, 2, \dots, J_1$ and $\hat{\zeta}_k$, $k = 1, 2, \dots, J_2$, where $2J_1 + J_2 = J$, $\operatorname{Im}(\zeta_j) \neq 0$, $\operatorname{Im}(\hat{\zeta}_k) = 0$, then we obtain that $t_{22}(\zeta)$ has J simple zeros $\bar{\zeta}_j, \bar{\zeta}_j^*, \bar{\tilde{\zeta}}_k = \frac{r\hat{\zeta}_k - 1}{\hat{\zeta}_k - r}$. By using the fact that $|\lambda(\zeta_1)| > 1$ and $|\lambda(\bar{\zeta}_1)| < 1$, we can take the limit $n \to -\infty$ of Θ_n obtained by solving the linear system (2.67) with discrete eigenvalues under the reflectionless condition at J = 1 and J = 2, respectively, to obtain $\Theta_{-\infty}$.

We have obtained the suitable discrete eigenvalues under the asymptotic behavior of scattering coefficients and the constraint of \bar{b}_j above so that in this part, we construct the 2-eigenvalue soliton solution by setting J = 2 and the discrete eigenvalues $\{\zeta_1, \zeta_2, \bar{\zeta}_1, \bar{\zeta}_2\}$ with $\bar{\zeta}_1 = \frac{1+q_0 e^{i\eta_1}}{r}$, $\eta_1 \in \mathbb{R}$, $|\pi - \eta_1| < \arctan(r/q_0)$, $\bar{\zeta}_2 = \bar{\zeta}_1^*$, $\zeta_2 = \zeta_1^*$.

$$\begin{aligned} R_1 &= -\frac{(\zeta_1 - \frac{1}{r})\bar{C}_1(t)\lambda(\bar{\zeta}_1)^{2n}}{(\bar{\zeta}_1 - \frac{1}{r})(\zeta_1 - \bar{\zeta}_1)} , R_2 = -\frac{(\zeta_1 - \frac{1}{r})\bar{C}_2(t)\lambda(\bar{\zeta}_2)^{2n}}{(\bar{\zeta}_2 - \frac{1}{r})(\zeta_1 - \bar{\zeta}_2)} , R_3 = -\frac{(\zeta_2 - \frac{1}{r})\bar{C}_1(t)\lambda(\bar{\zeta}_1)^{2n}}{(\bar{\zeta}_1 - \frac{1}{r})(\zeta_2 - \bar{\zeta}_1)} , \\ R_4 &= -\frac{(\zeta_2 - \frac{1}{r})\bar{C}_2(t)\lambda(\bar{\zeta}_2)^{2n}}{(\bar{\zeta}_2 - \frac{1}{r})(\zeta_2 - \bar{\zeta}_2)} , R_5 = -\frac{(\bar{\zeta}_1 - r)C_1(t)\lambda(\zeta_1)^{-2n}}{(\zeta_1 - r)(\bar{\zeta}_1 - \zeta_1)} , R_6 = -\frac{(\bar{\zeta}_1 - r)C_2(t)\lambda(\zeta_2)^{-2n}}{(\zeta_2 - r)(\bar{\zeta}_1 - \zeta_2)} , \\ R_7 &= -\frac{(\bar{\zeta}_2 - r)C_1(t)\lambda(\zeta_1)^{-2n}}{(\zeta_1 - r)(\bar{\zeta}_2 - \zeta_1)} , R_8 = -\frac{(\bar{\zeta}_2 - r)C_2(t)\lambda(\zeta_2)^{-2n}}{(\zeta_2 - r)(\bar{\zeta}_2 - \zeta_2)} , R_9 = \frac{C_1(t)\lambda(\zeta_1)^{-2n}}{\zeta_1(\zeta_1 - r)} , R_{10} = \frac{C_2(t)\lambda(\zeta_2)^{-2n}}{\zeta_2(\zeta_2 - r)} \\ \end{array}$$

and \mathbf{B}_j , j = 1, ..., 9 is the *j*-th column of matrix **B**. Then we solve the linear system $\mathbf{B}\mathbf{X} = \mathbf{Y}$ and obtain that

$$X_1 = \frac{Det(\mathbf{B}_1^c)}{Det(\mathbf{B})}, \ X_2 = \frac{Det(\mathbf{B}_2^c)}{Det(\mathbf{B})}, \ X_9 = \frac{Det(\mathbf{B}_9^c)}{Det(\mathbf{B})},$$
(2.90)

where $\mathbf{B}_1^c = (\mathbf{Y}, \mathbf{B}_2, ..., \mathbf{B}_9), \mathbf{B}_2^c = (\mathbf{B}_1, \mathbf{Y}, \mathbf{B}_3, ..., \mathbf{B}_9), \mathbf{B}_9^c = (\mathbf{B}_1, ..., \mathbf{B}_8, \mathbf{Y})$. Then the second-order soliton solution can be written as

$$q_n^{[2]}(t) = q_+(t) + r R_9 \frac{X_1}{X_9} + r R_{10} \frac{X_2}{X_9}, \qquad (2.91)$$

where the superscript [2] denotes the second-order soliton solution.

Some typical second-order soliton solutions with the nonzero boundary coefficients $q_0 = \frac{2}{3}$ are shown in Fig. 2. Fig. 2(a) shows the second-order dark-dark soliton solution that is an interaction of two waves having the same amplitude with the nonzero boundary condition $q_0 = \frac{2}{3}, \theta = 0$, scattering coefficients $\bar{\zeta}_1 = \frac{1-q_0 e^{i\pi/7}}{r}$, $\kappa_1 = 1$, $\bar{\theta}_1 = 0$, $\bar{\theta}_2 = 0$. Fig. 2(b) shows the second-order bright-dark soliton solution with the nonzero boundary condition $q_0 = \frac{2}{3}, \theta = \frac{2\pi}{5}$, scattering coefficients $\bar{\zeta}_1 = \frac{1-q_0 e^{i\pi/7}}{r}$, $\kappa_1 = 1$, $\bar{\theta}_1 = 0$, $\bar{\theta}_2 = 0$. Fig. 2(c) shows the second-order bright-bright soliton solution with the nonzero boundary condition $q_0 = \frac{2}{3}, \theta = \pi$, scattering coefficients $\bar{\zeta}_1 = \frac{1-q_0 e^{i\pi/7}}{r}$, $\kappa_1 = 1, \bar{\theta}_1 = 0$, $\bar{\theta}_2 = 0$.

We found that under the nonzero boundary condition $q_0 = \frac{2}{3}$ and scattering coefficient $\bar{\zeta}_1 = \frac{1-q_0 e^{i\pi/7}}{r}$ (similar conclusions have been obtained for other parameters as well), as θ increases from 0 to 2π , the secondorder soliton transforms from dark-dark soliton \rightarrow bright-dark soliton \rightarrow bright-bright soliton \rightarrow bright-dark soliton \rightarrow dark-dark soliton. Some cross-sectional views of second-order solitons under the continuous limit of n (to make a more intuitive comparison) are given in Fig. 1(d)-(f) with t = 10. Fig. 1(d) shows three dark-dark solitons with $\theta = 0$, $\frac{\pi}{4}$, $\frac{\pi}{3}$ in the interval $[0, \frac{\pi}{2}]$, respectively. Fig. 1(e) shows three bright-dark solitons with $\theta = \frac{11\pi}{30}$, $\frac{2\pi}{5}$, $\frac{5\pi}{11}$ in the interval $[0, \frac{\pi}{2}]$, respectively. Fig. 1(f) shows three bright-bright solitons with $\theta = \frac{3\pi}{4}$, $\frac{9\pi}{10}$, π in the interval $[\frac{\pi}{2}, \pi]$, respectively. What we also have to emphasize is that when the phase $\theta = \pi/2$ or $3\pi/2$, the bright component of the bright-dark soliton will exhibit singularity, that is, the amplitude will be infinite, which can be deduced in Fig. 2(e). The transformation of the second-order soliton in the interval $[0, 2\pi]$ is shown in Fig. 3.

3 Case (ii): $\sigma = 1$, $\Delta \theta = \pi$

In this section, we will investigate the IST for Eq. (1.4) with NZBCs (1.5) meeting the case (ii).

3.1 The direct scattering problem

We also rewrite the NZBCs (1.5) and $\lim_{n\to\pm\infty}r_n(t)$ without the time variable t as

$$\lim_{n \to \pm \infty} q_n = q_{\pm} = q_0 e^{i\vartheta_{\pm}}, \quad \lim_{n \to \pm \infty} r_n = r_{\pm} = q_0 e^{-i\vartheta_{\mp}}, \quad (3.1)$$

where $\vartheta_{\pm} = \theta_{\pm} - 2q_0^2 t$ is also real, $\theta_+ = \pi + \theta_-$.

3.1.1 Eigenfunctions, scattering matrix, uniformization variable

Under the boundary conditions (3.1) and symmetry reduction condition $r_n(t) = q_{-n}^*(t)$, the solution matrices $\Phi_n(z)$ and $\Psi_n(z)$ of Eq. (1.6a) satisfy the following boundary conditions:

$$\boldsymbol{\Phi}_{n}(z) = \left(\phi_{n}(z), \bar{\phi}_{n}(z)\right) \sim r^{n} \begin{pmatrix} q_{-} & \lambda r - z \\ \lambda r - z & -r_{-} \end{pmatrix} \boldsymbol{\Lambda}^{n}, \ n \to -\infty,$$
(3.2a)

$$\Psi_n(z) = \left(\bar{\psi}_n(z), \psi_n(z)\right) \sim r^n \begin{pmatrix} q_+ & \lambda r - z \\ \lambda r - z & -r_+ \end{pmatrix} \mathbf{\Lambda}^n, \ n \to +\infty,$$
(3.2b)

where $\phi_n(z)$, $\bar{\phi}_n(z)$, $\bar{\psi}_n(z)$, $\psi_n(z)$ are also eigenfunctions but $r = \sqrt{1+q_0^2}$ with $q_0 > 0$, which is directed from the Case (i). $\lambda(z)$ also can be written as $\xi \pm \sqrt{\xi^2 - 1}$ by introducing $\xi(z) = \frac{z + \frac{1}{z}}{2r}$, $\Lambda = diag(\lambda, \frac{1}{\lambda})$. λ and z also satisfy $r(\lambda + \frac{1}{\lambda}) = z + \frac{1}{z}$ but $\lambda(z)$ is a double-valued function of z with four branch points $\pm z_1$ and $\pm z_2$ meeting $\xi(z)^2 = 1$, where

$$z_1 = r + q_0 > 1, z_2 = r - q_0 < 1.$$

Furthermore, we can also prove that the continuous spectrum of the scattering problem is any z that meet $|\lambda(z)| = 1$ in the set:

Two solutions φ_n , $\overline{\varphi}_n$ of scattering problem obey the recursion relation:

The factor $(\lambda r - z)^2 + q_0^2 = 0$ if and only if z are also the four branch points $\pm z_1, \pm z_2$ of $\lambda(z)$. In addition, we assume that potential functions q_n, r_n meet the condition $1 - q_n r_n \neq 0$ for any $n \in \mathbb{Z}$, then Eqs. (3.6) don't equal zero so that both $\Phi_n(z)$ and $\Psi_n(z)$ are the fundamental solutions of scattering problem for any $z \in \mathbb{C}$ except $\pm z_1, \pm z_2$. Thus, scattering matrix T(z) is exist to relate these two solution matrices

$$\mathbf{\Phi}_{n}(z) = \mathbf{\Psi}_{n}(z)\mathbf{T}(z), \ \mathbf{T}(z) = \begin{pmatrix} t_{11}(z) & t_{12}(z) \\ t_{21}(z) & t_{22}(z) \end{pmatrix}$$

The scattering coefficients $t_{ij}(z)$, i, j = 1, 2 can be represented as Eqs. (2.10). We also define the uniformization variable as $\zeta(z) = \lambda(z)/z$, then we have the same mappings as Eq. (2.12) but $r = \sqrt{1+q_0^2}$. In addition, the continuous spectrum in this case is mapped onto $\{\zeta \in \mathbb{C} : |\zeta| = 1\} \cup \{\zeta \in \mathbb{C} : |\zeta - r| = q_0\}$ and four branch points $\pm z_1, \pm z_2$ are mapped onto two points $\zeta_1 = \zeta(\pm z_1) = z_2, \zeta_2 = \zeta(\pm z_2) = z_1$ in the ζ -plane. Furthermore, we can show that

are the corresponding positive region for $|\lambda| < 1$ and negative region for $|\lambda| > 1$.

The modified eigenfunctions

with $\Omega = diag(1, \lambda)$ also have the same forms of difference equations as Eqs. (2.16), (2.17) except for r and the same boundary conditions except for q_{\pm} , r_{\pm} and r at $n \to \pm \infty$. They meet

where $\tilde{t}_{11}(\zeta) = t_{11}(\zeta)$, $\tilde{t}_{22}(\zeta) = t_{22}(\zeta)$, $\tilde{t}_{12}(\zeta) = \frac{t_{12}(\zeta)}{\lambda}$, $\tilde{t}_{21}(\zeta) = \lambda t_{21}(\zeta)$ are in the forms as Eqs. (2.23).

3.1.2 Analyticity of modified eigenfunctions and scattering coefficients

To analyze the analyticity of modified eigenfunctions, we introduce three modifications similar to Eqs. (2.24)-(2.31) in the Case (i), but the difference is that the modified potentials \dot{q}_n , \dot{r}_n in $\hat{\mathbf{E}}_n$ satisfy the constraint $\dot{q}_n \dot{r}_n = -q_0^2$, $n \in \mathbb{Z}$ and $\dot{\mathbf{U}}'_n$ becomes

in which $\eta_n^{[1]} = \dot{q}_n r_n + q_0^2$, $\eta_n^{[2]} = q_n - \dot{q}_n$, $\eta_n^{[3]} = \dot{q}_{n+1} - \dot{q}_n$ are all summable and decaying as $n \to \pm \infty$ as well so that $\dot{\mathbf{U}}'_n$ decays as $n \to \pm \infty$. Then we can obtain following **Theorem 2** by the same analysis as Case (i):

Theorem 2 Under the condition of the potentials $q_n, r_n, \dot{q}_n, \dot{r}_n \in \left\{ f_n : \sum_{l=\pm\infty}^n |f_l - \lim_{k \to \pm\infty} f_k| < \infty, \forall n \in \mathbb{Z} \right\},$ $M_n, N_n, t_{11}(\zeta) = \tilde{t}_{11}(\zeta)$ are analytic in D_- defined in Eq. (3.10) (except for the only possible pole $\zeta = \infty$) and $\bar{M}_n, \bar{N}_n, t_{22}(\zeta) = \tilde{t}_{22}(\zeta)$ are analytic in D_+ defined in Eq. (3.10) (except for the only possible pole $\zeta = 0$).

3.1.3 Asymptotic behavior of modified eigenfunctions and scattering coefficients

According the definition of uniformization variable ζ and by direct calculations, the asymptotic behavior of z^2 , λ^2 and $z\lambda$ can also be obtained as Table 1 and the asymptotic behavior of modified eigenfunctions is the same as Eqs. (2.42)-(2.45) except that q_{\pm} and r_{\pm} corresponds to Eq. (3.1), but the one of scattering coefficients $t_{11}(\zeta)$ and $t_{22}(\zeta)$ is as follows that is different from Eqs. (2.46):

3.1.4 Symmetries of scattering coefficients

By the same consideration as Case (i), we have the following first symmetry about eigenfunctions and scattering coefficients under the fact when $z \mapsto z$ and $\lambda \mapsto \frac{1}{\lambda}, \, \zeta \mapsto \overline{\zeta} = \frac{r\zeta - 1}{\zeta - r}$:

The second symmetry can also be analyzed by the modified scattering problems corresponding to that when $z \mapsto z^*$ and $\lambda \mapsto \frac{1}{\lambda^*}, \, \zeta \mapsto \overline{\zeta}^* = \frac{r\zeta^* - 1}{\zeta^* - r}$:

$$\begin{pmatrix} N_{n+1}^{(1)}(\zeta) \\ N_{n+1}^{(2)}(\zeta) \end{pmatrix} = \frac{1/\zeta - r}{q_{+}\Theta_{-\infty}v_{n}} \begin{pmatrix} \bar{M}_{-n}^{(2)*}(\bar{\zeta}^{*}) \\ -\bar{M}_{-n}^{(1)*}(\bar{\zeta}^{*}) \end{pmatrix}.$$

According to Eqs. (3.19), (3.20), (2.23) and the fact when $z \mapsto z^*$ and $\lambda \mapsto \frac{1}{\lambda^*}$, $\zeta \mapsto \overline{\zeta}^* = \frac{r\zeta^* - 1}{\zeta^* - r}$, we have the following symmetries of scattering coefficients:

3.2 The inverse scattering problem

We will also construct and solve a RH problem to get the reconstructed potential by considering the asymptotic behavior of the modified eigenfunctions.

3.2.1 The RH problem and reconstructed potential

We rewrite Eqs. (3.12) as the following jump condition on Σ'

$$\mu(\zeta) - \bar{N}_n(\zeta) = \lambda(\zeta)^{-2n} \rho(\zeta) N_n(\zeta) , \qquad (3.22a)$$

where $\mu(\zeta)$, $\bar{\mu}(\zeta)$, $\rho(\zeta)$, $\bar{\rho}(\zeta)$ are defined as before and all functions have similar poles. In addition, the asymptotic behavior of $\mu(\zeta)$ as $\zeta \to \infty$, $\bar{\mu}(\zeta)$ as $\zeta \to 0$, $\bar{N}(\zeta)$ as $\zeta \to r$, $N(\zeta)$ as $\zeta \to \frac{1}{r}$ in Eqs. (3.22) is the same as Eqs. (2.60) and the reduce conditions have the similar forms as Eqs. (2.61) except the different region of poles not repeated here.

By direct calculation, we finally obtain

As before, ζ_j , ζ_j^* are simple zeros of $t_{11}(\zeta)$ in D_- if and only if $\bar{\zeta}_j = \frac{r\zeta_j - 1}{\zeta_j - r}$ and $\bar{\zeta}_j^* = \frac{r\zeta_j^* - 1}{\zeta_j^* - r}$ are simple zeros of $t_{22}(\zeta)$ in D_+ so that the numbers of simple zeros for $t_{11}(\zeta)$ and $t_{22}(\zeta)$ are equal, namely $J = \bar{J}$ and the discrete eigenvalues are in quartets: $\{\zeta_j, \zeta_j^*, \bar{\zeta}_j, \bar{\zeta}_j^*\}$, where the first pair is in D_- and the second pair is in D_+ . The all J simple zeros of $t_{11}(\zeta)$ can also be divided into two classes denoted by ζ_j , $j = 1, 2, \dots, J_1$ and $\hat{\zeta}_k$, $k = 1, 2, \dots, J_2$, where $2J_1 + J_2 = J$, $\operatorname{Im}(\zeta_j) \neq 0$, $\operatorname{Im}(\hat{\zeta}_k) = 0$ and $t_{22}(\zeta)$ has J simple zeros $\bar{\zeta}_j, \bar{\zeta}_j^*$, $\bar{\zeta}_k^* = \frac{r\hat{\zeta}_k - 1}{\hat{\zeta}_k - r}$.

they are analytic in D_- and D_+ , respectively but both have no zeros and $A(\zeta)\bar{A}(\zeta) = t_{11}(\zeta)t_{22}(\zeta)$. 4 Case (iii): $\sigma = -1$, $\Delta \theta = 0$

In this section, we will investigate the IST for Eq. (1.4) with NZBCs (1.5) meeting the case (iii).

4.1 The direct scattering problem

We also rewrite the NZBCs (1.5) and $\lim_{n\to\pm\infty}r_n(t)$ without the time variable t as

Under the boundary conditions (4.1) and symmetry reduction condition $r_n(t) = -q_{-n}^*(t)$, the solution matrices $\Phi_n(z)$ and $\Psi_n(z)$ of Eq. (1.6a) satisfy the similar boundary conditions with Eqs. (3.2) and determinants (3.6), except that q_{\pm} and r_{\pm} corresponds to Eq. (4.1).

In fact, in this case, lots of analyses are similar to case (ii), including the defination of continuous spectrum (3.4), scattering matrices (3.7), uniformization variable ζ , modified eigenfunctions (3.11) and modified scattering matrices (3.13).

4.1.2 Analyticity of modified eigenfunctions and scattering coefficients

By the similar analysis except \mathbf{U}'_n becoming

4.1.3 Asymptotic behavior of modified eigenfunctions and scattering coefficients

The asymptotic behavior of z^2 , λ^2 , $z\lambda$ is also same as Table 1 and the asymptotics of modified eigenfunctions and scattering coefficients are the same as Eqs. (2.42)-(2.46) except q_{\pm} and r_{\pm} as well.

4.1.4 Symmetries of scattering coefficients

By the same consideration as before, the first symmetry about eigenfunctions and scattering coefficients under the fact when $z \mapsto z$ and $\lambda \mapsto \frac{1}{\lambda}$, $\zeta \mapsto \overline{\zeta} = \frac{r\zeta - 1}{\zeta - r}$ is:

4.2.3 The trace formula and discrete eigenvalues

From Eqs. (4.5) and (4.8), we know that the zeros of scattering coefficients also have the symmetry so that the discrete eigenvalues are in quartets: $\{\zeta_j, \zeta_j^*, \bar{\zeta}_j, \bar{\zeta}_j^*\}, j = 1, 2, \dots, J$, in each set the first pair is the simple zeros of $t_{11}(\zeta)$ in D_- and the second pair is the simple zeros of $t_{22}(\zeta)$ in D_+ . In addition, the all J simple zeros of $t_{11}(\zeta)$ can also be divided into two classes denoted by $\zeta_j, j = 1, 2, \dots, J_1$ and $\hat{\zeta}_k, k = 1, 2, \dots, J_2$, where $2J_1 + J_2 = J$, $\operatorname{Im}(\zeta_j) \neq 0$, $\operatorname{Im}(\hat{\zeta}_k) = 0$, then we obtain that $t_{22}(\zeta)$ has J simple zeros $\bar{\zeta}_j, \bar{\zeta}_j^*, \bar{\zeta}_k = \frac{r\hat{\zeta}_k - 1}{\hat{\zeta}_k - r}$ as well. Using similar calculation as before, we can obtain the trace formula

$$t_{22}(\zeta) = \Theta_{-\infty} \prod_{j=1}^{J_1} \frac{\zeta - \bar{\zeta}_j}{\zeta - \zeta_j} \frac{\zeta - \bar{\zeta}_j^*}{\zeta - \zeta_j^*} \prod_{k=1}^{J_2} \frac{\zeta - \bar{\zeta}_k}{\zeta - \hat{\zeta}_k} e^{-\frac{1}{2\pi i} \oint_{\Sigma'} \frac{\ln(1 - \rho(\omega)\bar{\rho}(\omega))}{\omega - \zeta} d\omega}, \zeta \in D_+,$$
(4.15a)

$$t_{11}(\zeta) = \prod_{j=1}^{J_1} \frac{\zeta - \zeta_j}{\zeta - \bar{\zeta}_j} \frac{\zeta - \zeta_j^*}{\zeta - \bar{\zeta}_j^*} \prod_{k=1}^{J_2} \frac{\zeta - \hat{\zeta}_k}{\zeta - \bar{\zeta}_k} e^{\frac{1}{2\pi i} \oint_{\Sigma'} \frac{\ln(1 - \rho(\omega)\bar{\rho}(\omega))}{\omega - \zeta} d\omega}, \zeta \in D_-.$$
(4.15b)

and consider the asymptotic behavior of the scattering coefficients, under the reflectionless condition, we also have the following constraint:

$$\prod_{j=1}^{J_1} \frac{|1/r - \zeta_j|^2}{|1/r - \bar{\zeta}_j|^2} \prod_{k=1}^{J_2} \frac{1/r - \hat{\zeta}_k}{1/r - \bar{\zeta}_k} = 1, \qquad (4.16a)$$

$$\Theta_{-\infty} \prod_{j=1}^{J_1} \frac{|\bar{\zeta}_j|^2}{|\zeta_j|^2} \prod_{k=1}^{J_2} \frac{\bar{\zeta}_k}{\hat{\zeta}_k} = 1, \qquad (4.16b)$$

$$\Theta_{-\infty} \prod_{j=1}^{J_1} \frac{|r - \bar{\zeta}_j|^2}{|r - \zeta_j|^2} \prod_{k=1}^{J_2} \frac{r - \bar{\hat{\zeta}}_k}{r - \hat{\zeta}_k} = 1.$$
(4.16c)

Setting J = 1, then $J_1 = 0$, $J_2 = 1$, which means that $\hat{\zeta}_1 = r \pm q_0$ are branch points we won't consider. When J = 2, there are two scenarios. The first scenario is $J_1 = 1$, $J_2 = 0$, we can get that ζ_1 is on the circle $|\zeta - r| = q_0$ that is a part of continuous spectrum we won't deal with either. The second scenario is $J_1 = 0$, $J_2 = 2$, then we can get $\hat{\zeta}_2 = \frac{\hat{\zeta}_1 - r}{r\hat{\zeta}_1 - 1} = \frac{1}{\hat{\zeta}_1}$ and $\{\hat{\zeta}_1, \overline{\hat{\zeta}}_1\}$, $\{\hat{\zeta}_2, \overline{\hat{\zeta}}_2\}$ are two sets of discrete eigenvalues used to construct the 2-eigenvalue soliton solution.

4.3 The time evolution

We denote the potentials as $q_n(t)$, $r_n(t)$ with the boundary conditions

$$\lim_{n \to \pm \infty} q_n(t) = q_{\pm}(t) = q_0 e^{i(\theta - 2q_0^2 t)}, \quad \lim_{n \to \pm \infty} r_n(t) = -q_{\mp}^*(t) = -q_0 e^{-i(\theta - 2q_0^2 t)}.$$
(4.17)

and we can get that $t_{11}(z,t)$ and $t_{22}(z,t)$ are still independent of t but

$$t_{21}(z,t) = t_{21}(z,0)e^{-2iq_0^2 t + i\gamma(z)t}, \ t_{12}(z,t) = t_{12}(z,0)e^{2iq_0^2 t - i\gamma(z)t}$$
(4.18)

with $\gamma(z) = r(\lambda - \lambda^{-1})(z - z^{-1})$. Furthermore, the time evolution of norming constants are:

$$C_j(t) = C_j(0)e^{-2iq_0^2t + i\gamma(z_j)t}, \ \bar{C}_j(t) = \bar{C}_j(0)e^{2iq_0^2t - i\gamma(\bar{z}_j)t}.$$
(4.19)

4.4 The soliton solutions

In this part, we construct the 2-eigenvalue soliton solution by setting J = 2 and getting the discrete eigenvalues ζ_1 , $\bar{\zeta}_1 = \frac{r\zeta_1-1}{\zeta_1-r}$, $\zeta_2 = \frac{1}{\zeta_1}$, $\bar{\zeta}_2 = \frac{r\zeta_2-1}{\zeta_2-r} \in \mathbb{R}$ (For convenience, we also omit the "^" above the variables). By the similar integration and introducing notations as Case (i), we obtain the second-order soliton solution:

$$q_n^{[2]}(t) = q_+(t) + r R_9 \frac{X_1}{X_9} + r R_{10} \frac{X_2}{X_9}, \qquad (4.20)$$

in which the parameters are given in Section 2.4.

5 Case (iv): $\sigma = -1$, $\Delta \theta = \pi$

The last case is that Eq. (1.4) with the NZBCs (1.5) and $\lim_{n\to\pm\infty}r_n(t)$, which can also be temporarily written as

$$\lim_{n \to \pm \infty} q_n = q_{\pm} = q_0 e^{i\vartheta_{\pm}}, \\ \lim_{n \to \pm \infty} r_n = r_{\pm} = -q_0 e^{-i\vartheta_{\mp}},$$
(5.1)

where $\vartheta_{\pm} = \theta_{\pm} + 2q_0^2 t$ is real.

5.1 The direct scattering problem

Under the boundary conditions (5.1) and symmetry reduction condition $r_n(t) = -q_{-n}^*(t)$, the solution matrices $\Phi_n(z)$ and $\Psi_n(z)$ of Eq. (1.6a) satisfy the similar boundary conditions with Eqs. (2.2) and determinants (2.6), except that q_{\pm} and r_{\pm} corresponds to Eq. (5.1).

In fact, in this case, lots of analyses are also similar to case (i) such as the defination of continuous spectrum (2.4), scattering matrices (2.7), uniformization variable ζ , modified eigenfunctions (2.15), modified scattering matrices (2.20).

By the similar analysis except different $\dot{\mathbf{U}}'_n$, we can also prove that under the condition of the potentials $q_n, r_n, \dot{q}_n, \dot{r}_n \in \left\{ f_n : \sum_{l=\pm\infty}^n |f_j - \lim_{k \to \pm\infty} f_k| < \infty, \forall n \in \mathbb{Z} \right\}, M_n, N_n, t_{11}(\zeta) = \tilde{t}_{11}(\zeta)$ are analytic in D_-

(except for the only possible pole $\zeta = \infty$) and \bar{M}_n , \bar{N}_n , $t_{22}(\zeta) = \tilde{t}_{22}(\zeta)$ are analytic in D_+ (except for the only possible pole $\zeta = 0$), where D_{\pm} are defined as Eq. (2.14).

The asymptotic behavior of z^2 , λ^2 , $z\lambda$ is also as before, the asymptotic behavior of modified eigenfunctions is the same as Eqs. (2.42)-(2.45) except q_{\pm} and r_{\pm} as well and the one of scattering coefficients is similar to Eqs. (3.15).

By the same consideration as before, the symmetry about eigenfunctions and scattering coefficients is

$$\phi_n(z,\frac{1}{\lambda}) = \frac{r/\lambda - z}{-r_-} \bar{\phi}_n(z,\lambda) , \ \psi_n(z,\frac{1}{\lambda}) = \frac{r/\lambda - z}{q_+} \bar{\psi}_n(z,\lambda) , \ t_{11}(\zeta) = t_{22}(\bar{\zeta}) , \ t_{21}(\zeta) = -\frac{q_+}{r_-} t_{12}(\bar{\zeta}) ,$$
(5.2)

$$\bar{N}_{n+1}(\zeta) = -\frac{\zeta - r}{r_+ \Theta_{-\infty} v_n} \begin{pmatrix} M_{-n}^{(2)*}(\bar{\zeta}^*) \\ M_{-n}^{(1)*}(\bar{\zeta}^*) \end{pmatrix}, N_{n+1}(\zeta) = -\frac{1/\zeta - r}{q_+ \Theta_{-\infty} v_n} \begin{pmatrix} \bar{M}_{-n}^{(2)*}(\bar{\zeta}^*) \\ \bar{M}_{-n}^{(1)*}(\bar{\zeta}^*) \end{pmatrix}, t_{11}(\zeta) = -t_{22}^*(\bar{\zeta}^*),$$
(5.3)

and the discrete eigenvalues are also in quartets: $\{\zeta_j, \zeta_j^*, \overline{\zeta}_j, \overline{\zeta}_j^*\}, j = 1, 2, \dots, J$, where $J = 2J_1 + J_2, J_1, J_2$ are the quantities of ζ_j meeting $\operatorname{Im}(\zeta_j) \neq 0$ and $\hat{\zeta}_k$ meeting $\operatorname{Im}(\hat{\zeta}_k) = 0$, respectively.

5.2 The inverse scattering problem

In the inverse scattering problem, we still define and solve a RH problem to reconstruct the potential so that under the reflectionless condition, we obtain the linear system:

$$\bar{N}_{n}^{(1)}(\zeta) - (\zeta - r) \sum_{j=1}^{J} \frac{C_{j} \lambda(\zeta_{j})^{-2n}}{(\zeta_{j} - r)(\zeta - \zeta_{j})} N_{n}^{(1)}(\zeta_{j}) - \frac{q_{+}}{\Theta_{n}} = 0, \qquad (5.4a)$$

$$\bar{N}_{n}^{(2)}(\zeta) - (\zeta - r) \sum_{j=1}^{J} \frac{C_{j} \lambda(\zeta_{j})^{-2n}}{(\zeta_{j} - r)(\zeta - \zeta_{j})} N_{n}^{(2)}(\zeta_{j}) = \zeta - r , \qquad (5.4b)$$

$$N_n^{(1)}(\zeta) - (\zeta - \frac{1}{r}) \sum_{j=1}^J \frac{\bar{C}_j \,\lambda(\bar{\zeta}_j)^{2n}}{(\bar{\zeta}_j - \frac{1}{r})(\zeta - \bar{\zeta}_j)} \,\bar{N}_n^{(1)}(\bar{\zeta}_j) = r - \frac{1}{\zeta} \,, \tag{5.4c}$$

$$N_n^{(2)}(\zeta) + \frac{r_+}{\Theta_n} - (\zeta - \frac{1}{r}) \sum_{j=1}^{\bar{J}} \frac{\bar{C}_j \,\lambda(\bar{\zeta}_j)^{2n}}{(\bar{\zeta}_j - \frac{1}{r})(\zeta - \bar{\zeta}_j)} \,\bar{N}_n^{(2)}(\bar{\zeta}_j) = 0\,, \tag{5.4d}$$

$$\frac{1}{\Theta_n} = 1 - \sum_{j=1}^J \frac{C_j \,\lambda(\zeta_j)^{-2n}}{\zeta_j(\zeta_j - r)} \,N_n^{(2)}(\zeta_j) \tag{5.4e}$$

and the reconstructed potential

$$q_n = q_+ + \Theta_n \sum_{j=1}^J \frac{rC_j \,\lambda(\zeta_j)^{-2n}}{\zeta_j(\zeta_j - r)} \,N_n^{(1)}(\zeta_j)\,.$$
(5.5)

By the same way as before, the trace formulae of $t_{11}(\zeta)$ and $t_{22}(\zeta)$ are

$$t_{22}(\zeta) = \Theta_{-\infty} \prod_{j=1}^{J_1} \frac{\zeta - \bar{\zeta}_j}{\zeta - \zeta_j} \frac{\zeta - \bar{\zeta}_j^*}{\zeta - \zeta_j^*} \prod_{k=1}^{J_2} \frac{\zeta - \bar{\zeta}_k}{\zeta - \hat{\zeta}_k} e^{-\frac{1}{2\pi i} \oint_{|\omega|=1} \frac{\ln(1 - \rho(\omega)\bar{\rho}(\omega))}{\omega - \zeta} d\omega}, \zeta \in D_+,$$
(5.6a)

$$t_{11}(\zeta) = \prod_{j=1}^{J_1} \frac{\zeta - \zeta_j}{\zeta - \bar{\zeta_j}} \frac{\zeta - \zeta_j^*}{\zeta - \bar{\zeta_j}^*} \prod_{k=1}^{J_2} \frac{\zeta - \hat{\zeta_k}}{\zeta - \bar{\zeta_k}} e^{\frac{1}{2\pi i} \oint_{|\omega|=1} \frac{\ln(1 - \rho(\omega)\bar{\rho}(\omega))}{\omega - \zeta} d\omega}, \zeta \in D_-.$$
(5.6b)

Under the reflectionless condition and taking the derivative of above trace formulae with respect to ζ gives

$$t_{22}'(\zeta) = \Theta_{-\infty} \prod_{j=1}^{J_1} \frac{\zeta - \bar{\zeta}_j}{\zeta - \zeta_j} \frac{\zeta - \bar{\zeta}_j^*}{\zeta - \zeta_j^*} \prod_{k=1}^{J_2} \frac{\zeta - \bar{\zeta}_k}{\zeta - \hat{\zeta}_k} \left[\sum_{j=1}^{J_1} \left(\frac{1}{\zeta - \bar{\zeta}_j} + \frac{1}{\zeta - \bar{\zeta}_j^*} - \frac{1}{\zeta - \zeta_j} - \frac{1}{\zeta - \zeta_j^*} \right) + \sum_{k=1}^{J_2} \left(\frac{1}{\zeta - \bar{\zeta}_j} - \frac{1}{\zeta - \hat{\zeta}_k} \right) \right]$$
(5.7a)
$$t_{11}'(\zeta) = \prod_{j=1}^{J_1} \frac{\zeta - \zeta_j}{\zeta - \bar{\zeta}_j} \frac{\zeta - \zeta_j^*}{\zeta - \bar{\zeta}_j^*} \prod_{k=1}^{J_2} \frac{\zeta - \hat{\zeta}_k}{\zeta - \bar{\zeta}_k} \left[\sum_{j=1}^{J_1} \left(\frac{1}{\zeta - \zeta_j} + \frac{1}{\zeta - \zeta_j^*} - \frac{1}{\zeta - \bar{\zeta}_j} - \frac{1}{\zeta - \bar{\zeta}_j^*} \right) + \sum_{k=1}^{J_2} \left(\frac{1}{\zeta - \hat{\zeta}_j} - \frac{1}{\zeta - \bar{\zeta}_k} \right) \right] .$$
(5.7b)

Considering the asymptotic behavior of the scattering coefficient $t_{11}(\zeta)$ as $\zeta \to \frac{1}{r}$, $t_{22}(\zeta)$ as $\zeta \to 0$, $\zeta \to r$ under the reflectionless condition, we also have the constraint of discrete eigenvalues similar to Eqs. (3.32). Setting J = 1, which only means $J_1 = 0$, $J_2 = 1$, we get $\overline{\zeta}_1 = \frac{1-q_0}{r} \in D_+$ on the circle $|\zeta - 1/r| = q_0/r$, which can be used to construct the first-order soliton solution later. When J = 2, there are no discrete eigenvalues that simultaneously meet the above three conditions.

When $J_1 = 0$, $J_2 = 1$, $\hat{\zeta}_1 = \frac{1-q_0}{r} \in D_+$ and the corresponding $\hat{\zeta}_1 = \frac{r}{1-q_0} \in D_-$, according to the symmetry about eigenfunctions and scattering coefficients, we have $\bar{b}_1\bar{b}_1^* = \lambda(\bar{\zeta}_1)^{-4}$ so that we write $\bar{b}_1 = \lambda(\bar{\zeta}_1)^{-2}e^{i\bar{\theta}_1}$, where $\bar{\theta}_1$ is a real parameter. According to Eqs. (5.7), we also have $t'_{22}(\bar{\zeta}_1) = \frac{\lambda(\zeta_1)^2}{\hat{\zeta}_1-\hat{\zeta}_1}$, therefore, we get

$$\bar{C}_1 = (\lambda(\bar{\hat{\zeta}}_1))^{-5} (\bar{\hat{\zeta}}_1 - \hat{\zeta}_1) e^{i\bar{\theta}_1}.$$
(5.8)

5.3 The time evolution

The time evolution of scattering coefficients and norming constants are identical with case (i), namely, $t_{11}(z,t)$ and $t_{22}(z,t)$ are independent of t but $t_{21}(z,t)$, $t_{12}(z,t)$, $C_j(t)$, $\bar{C}_j(t)$ are related to t:

$$t_{21}(z,t) = t_{21}(z,0)e^{2iq_0^2t + i\gamma(z)t}, \ t_{12}(z,t) = t_{12}(z,0)e^{-2iq_0^2t - i\gamma(z)t},$$
(5.9)

$$C_j(t) = C_j(0)e^{2iq_0^2 t + i\gamma(z_j)t}, \ \bar{C}_j(t) = \bar{C}_j(0)e^{-2iq_0^2 t - i\gamma(\bar{z}_j)t}.$$
(5.10)

Combining with Eq. (5.8), we have

$$\bar{C}_1(t) = (\lambda(\bar{\hat{\zeta}}_1))^{-5} (\bar{\hat{\zeta}}_1 - \hat{\zeta}_1) e^{i(\bar{\theta}_1 - 2q_0^2 t - \gamma(\bar{\hat{\zeta}}_1)t)}$$
(5.11)

with

$$\gamma(\bar{\hat{\zeta}}_1) = r^2 \frac{(\bar{\hat{\zeta}}_1 - \frac{2}{r} + \frac{1}{\bar{\zeta}_1})(\bar{\hat{\zeta}}_1 - 2r + \frac{1}{\bar{\zeta}_1})}{(\bar{\hat{\zeta}}_1 - r)(\frac{1}{\bar{\zeta}_1} - r)}$$

5.4 The soliton solutions

The soliton solutions can be obtained by solving algebraic system (5.4) with discrete eigenvalues and corresponding norming constants under the reflectionless condition. For J = 1, considering discrete eigenvalues $\bar{\zeta}_1 = \frac{1-q_0}{r}, \zeta_1 = \frac{r\bar{\zeta}_1-1}{\bar{\zeta}_1-r}$ (We also omit the "^" of the real variables in discrete eigenvalues for brevity), norming constants $\bar{C}_1(t), C_1(t) = -\frac{q_+^2(t)}{(\bar{\zeta}_1-r)^2}\bar{C}_1(t)$ and introducing $\mathbf{X} = (X_1, ..., X_5)^T, \mathbf{Y} = (r - \frac{1}{\zeta_1}, 0, 0, \bar{\zeta}_1 - r, 1)^T$, matrix $\mathbf{B} = (\mathbf{B}_1, ..., \mathbf{B}_5)$, where

$$X_1 = N_n^{(1)}(\zeta_1), X_2 = N_n^{(2)}(\zeta_1), X_3 = \bar{N}_n^{(1)}(\bar{\zeta}_1), X_4 = \bar{N}_n^{(2)}(\bar{\zeta}_1), X_5 = \frac{1}{\Theta_n},$$

$$\mathbf{B} = \begin{pmatrix} 1 & 0 & R_1 & 0 & 0 \\ 0 & 1 & 0 & R_1 & r_+ \\ R_2 & 0 & 1 & 0 & -q_+ \\ 0 & R_2 & 0 & 1 & 0 \\ 0 & R_3 & 0 & 0 & 1 \end{pmatrix}$$

with

$$R_1 = -\frac{(\zeta_1 - \frac{1}{r})\bar{C}_1(t)\lambda(\bar{\zeta}_1)^{2n}}{(\bar{\zeta}_1 - \frac{1}{r})(\zeta_1 - \bar{\zeta}_1)}, R_2 = -\frac{(\bar{\zeta}_1 - r)C_1(t)\lambda(\zeta_1)^{-2n}}{(\zeta_1 - r)(\bar{\zeta}_1 - \zeta_1)}, R_3 = \frac{C_1(t)\lambda(\zeta_1)^{-2n}}{\zeta_1(\zeta_1 - r)}$$

and \mathbf{B}_j , j = 1, ..., 5 is the *j*-th column of matrix **B**, by Cramer's Rule, we solve the linear system $\mathbf{B}\mathbf{X} = \mathbf{Y}$ and obtain

$$X_1 = \frac{Det(\mathbf{B}_1^c)}{Det(\mathbf{B})}, X_5 = \frac{Det(\mathbf{B}_5^c)}{Det(\mathbf{B})},$$
(5.12)

where $\mathbf{B}_1^c = (\mathbf{Y}, \mathbf{B}_2, \mathbf{B}_3, \mathbf{B}_4, \mathbf{B}_5), \ \mathbf{B}_5^c = (\mathbf{B}_1, \mathbf{B}_2, \mathbf{B}_3, \mathbf{B}_4, \mathbf{Y}).$ Then the first-order solution can be written as

$$q_n^{[1]}(t) = q_+(t) + r R_3 \frac{X_1}{X_5}, \qquad (5.13)$$

where the superscript [1] denotes the first-order soliton solution.

We can further simplify the solution (5.13). Setting $R_1R_2 = v_n^2$, where $v_n = \frac{q_+(t)\bar{C}_1(t)}{\bar{\zeta}_1^2 - 2r\,\bar{\zeta}_1 + 1}\lambda(\bar{\zeta}_1)^{2n+1}$ and symmetry $C_j = -\frac{q_+^2}{(\bar{\zeta}_j - r)^2}\bar{C}_j$ is used, we can get

$$X_5 = \frac{v_n^2 \bar{\zeta}_1 / \zeta_1 - 1}{v_n^2 + r_+(t)R_3 - 1}, \ X_1 = \frac{(q_0^2 \bar{\zeta}_1 / (r \, \bar{\zeta}_1 - 1)) + q_+(t)R_1 X_5}{v_n^2 - 1}.$$
(5.14)

Then first-order soliton solution has the following form:

$$q_n^{[1]}(t) = q_+(t) \left[1 + \frac{1}{v_n^2 - 1} \left(\frac{r \,\bar{\zeta}_1(v_n^2 \lambda(\bar{\zeta}_1)^2 - 1)\lambda(\bar{\zeta}_1)^{2n}}{(r \bar{\zeta}_1 - 1)^2 (v_n^2 + R_3 \, r_+(t) - 1)} q_+(t) \bar{C}_1(t) - \frac{\lambda(\bar{\zeta}_1)^2 - 1}{\bar{\zeta}_1/r - 1} v_n^2 \right) \right] \,. \tag{5.15}$$

The first-order soliton solutions with the nonzero boundary coefficients $q_0 = \frac{2}{3}$ and scattering coefficients $\bar{\zeta}_1 = \frac{1-q_0}{r}$, $\bar{\theta}_1 = \frac{\pi}{3}$ are shown in Fig. 5. Fig. 5(a), (b) show the first-order bright soliton solution with the nonzero boundary condition $q_0 = \frac{2}{3}$, $\theta_+ = 0$. Fig. 5(c), (d) show the first-order dark soliton solution with the nonzero boundary condition $q_0 = \frac{2}{3}$, $\theta_+ = \frac{\pi}{3}$.

6 Conclusions

In this paper, we have thoroughly developed the IST for the integrable discrete nonlocal PT symmetric NLS equation with nonzero boundary conditions. According to the two different signs $\sigma = \pm 1$ and two different values of the phase difference $\Delta \theta = 0$ or $\Delta \theta = \pi$, we have discussed four cases with significant differences about analytical regions, symmetry, asymptotic behavior and the presence or absence of discrete eigenvalues, namely, the existence or absence of soliton solutions. In the direct scattering problem, we have all studied the analyticity, asymptotic behavior and symmetries of the modified eigenfunctions and scattering coefficients. In the inverse scattering problem, the RH problem has been constructed and solved to get the reconstructed potential. Finally, combined with the time evolution, the dark, bright, dark-bright soliton solutions in existence have been obtained under the reflectionless condition.

In this work, we have pointed out some key points and solved a number of difficulties. Firstly, the second symmetry about $\zeta \mapsto \overline{\zeta}^* = \frac{r\zeta^* - 1}{\zeta^* - r}$ has been deduced by introducing the "backward" modified scattering problem and analysing modified eigenfunctions. Secondly, which is unlike some local cases that the values of discrete eigenvalues are relatively free except restricted within the domains of scattering coefficients, the discrete eigenvalues here are only obtained by comparing the trace formula with asymptotic behavior of scattering coefficients. Thirdly, due to the strong limitations on discrete eigenvalues mentioned above, under the *PT* symmetry reduction condition, not all cases exist soliton solutions. For example, in the Case (i): $\sigma = 1$, $\Delta \theta = 0$, the single eigenvalue is not exist so that there is no first-order soliton solution. The simplest reflectionless potential generates second-order soliton solutions, which include dark-dark, dark-bright, bright-bright ones. In the Case (ii): $\sigma = 1$, $\Delta \theta = \pi$, we have showed there are no discrete eigenvalues so that the soliton solutions are not exist.

The research processes and results in this work also provide instructive technology to investigate other types of integrable nonlocal system, as well as to further investigate the long-time asymptotic behavior of solutions for nonlocal systems.
