Griffiths polynomials of q-Racah type

Abstract

New bivariate Griffiths polynomials of q-Racah type are introduced and characterized. They generalize the polynomials orthogonal on the multinomial distribution introduced by R. Griffiths fifty years ago. They also correspond to a q-deformation of the Griffiths polynomials of Racah type introduced previously by the authors and collaborators. The latter are recovered from the former by a $q \to 1$ limit. We show that these new polynomials are bispectral and biorthogonal. We also exhibit some symmetry relations that are essential in the proof of the bispectrality property.

1 Introduction

In the study of special functions, a special class of polynomials, called the (q-)hypergeometric orthogonal polynomials, plays a special role [1, 27]. This class comprises diverse families of polynomials who are usually arranged in a scheme, called the (q-)Askey scheme, which allows one to visualize the connections between the members of this class (see [47] for a review). All these families of polynomials are orthogonal and satisfy a three-term recurrence relation. In addition, they satisfy a second order differential equation or a three-term (q-)difference equation. They are described as bispectral, meaning that they satisfy a recurrence relation and a difference equation in two distinct variables. The (q-)Racah polynomials sit at the top of this scheme and the various other polynomials can be obtained from the latter by limits or specializations on the parameters. A generalization to the multivariate case is important. The goal of this paper is to provide a bivariate generalization of the q-Racah polynomials that possesses the bispectrality property amongst many other properties. Let us emphasize that the generalization introduced here is different from the one defined in [62]: that one is obtained as a truncation of the Koornwinder–Macdonald multivariable generalization of the Askey–Wilson polynomials.

A number of multivariate generalizations of orthogonal polynomials have been studied throughout the years. In [35, 23], a n variable generalization of the Krawtchouk polynomials (which are a limiting case of the Racah polynomials) has been introduced through a generating function, and it has been

proven that these polynomials are orthogonal with respect to the multinomial distribution. They have also been obtained in the context of a probabilistic model in [38] (and have been called Rahman polynomials for a while), expressed in terms of Gel'fand-Aomoto hypergeometric series [51], and appeared as the 3nj-symbol of the oscillator algebra [61, 46, 66, 17]. These polynomials are usually called the Griffiths polynomials but, in this paper, we shall call them the Griffiths polynomials of Krawtchouk type to distinguish them from the ones we will construct.

A n variable generalization of the (q-)Racah polynomials has been obtained in [57, 28]; here we shall call it the Tratnik polynomials of (q-)Racah type. These multivariate polynomials are bispectral and have been studied intensively in different contexts (see e.g. [32, 40, 56, 29, 4, 36]). Taking a limit on the Tratnik polynomials of Racah type, one obtains a multivariate generalization of the Krawtchouk polynomials, called here the Tratnik polynomials of Krawtchouk type. These polynomials in n variables depend on n parameters whereas the Griffiths polynomials of Krawtchouk type depend on $\frac{1}{2}n(n+1)$ parameters. In [31], a group theoretical interpretation of the Griffiths polynomials of Krawtchouk type has been given (see also [54, 42, 41]). This point of view showed that the Tratnik polynomials of Krawtchouk type can be obtained by specifying some parameters of the Griffiths polynomials of Krawtchouk type. The latter polynomials were also expressed as sums of a nested product of univariate Krawtchouk polynomials.

It is then natural to ask whether it is possible to define multivariate polynomials based on univariate Racah or q-Racah polynomials which, in a certain limit, reproduce the Griffiths polynomials of Krawtchouk type. Recently, studying the representation theory of the rank 2 Racah algebra, bivariate Griffiths polynomials of Racah type have been computed [15] and their bispectral property has been obtained. These polynomials are expressed as a sum of a product of three univariate Racah polynomials and share this structure with the bivariate Griffiths polynomials of Krawtchouk type. They have subsequently been studied in more detail in [13], where the properties of the bivariate polynomials have been established using only the properties of the univariate Racah polynomials. In addition, it has been proven (see [13]) that a limit of the bivariate Griffiths polynomials of Racah type reproduces the bivariate Griffiths polynomials of Krawtchouk type; this provides a justification for their designation as "bivariate Griffiths polynomials".

In this paper, we study a q-deformed version of the bivariate Griffiths polynomials of Racah type. In other words, we study bivariate Griffiths polynomials of q-Racah type which are expressed as a sum of a product of three univariate q-Racah polynomials (see relation (5.1)). From these, a limit $q \to 1$ leads to the Griffith polynomials of Racah type just discussed. Using properties of the univariate q-Racah polynomial, we prove numerous properties for the proposed bivariate polynomials: bispectral properties, biorthogonality, symmetry, duality, etc. The proofs differ from the ones in [13] since the properties used there seem not to generalize to the q-deformed case. Instead, we make use of a symmetry under the exchange of the two variables, which appears to be crucial and was not yet established in [13] for the undeformed case. To establish this symmetry, we use the Racah and Biedenharn–Elliot relations for the monovariate q-Racah polynomials (see relations (4.1) and (4.6)). These properties are proven using the underlying algebra of the bispectral problem which is the rank 2 Askey–Wilson algebra $\mathbf{aw}(4)$. As a byproduct of this construction, we provide finite-dimensional representations of the $\mathbf{aw}(4)$ algebra.

The plan of the paper is as follows. In Section 2, the univariate q-Racah polynomials are defined in terms of q-hypergeometric functions (whose definition can be found in Appendix A) and its well-known properties, such as bispectrality, duality and orthogonality, are recalled. Supplementary relations, called contiguity relations, are proven in subsection 2.2; these are then used to prove the various properties of the Tratnik polynomials of q-Racah type in Section 3. Section 4 is devoted to the Racah relation and the Biedenharn–Elliot relation for the univariate q-Racah polynomials. The proofs use the representation theory of the rank 1 Askey–Wilson algebra $\mathbf{aw}(3)$ and rank 2 Askey–Wilson algebra $\mathbf{aw}(4)$ respectively, whose definitions and representations are provided in Appendices B and C respectively. We then come to the main object of the paper in Section 5: the definition and properties of the Griffiths polynomials of q-Racah type. These polynomials are written as a sum of a product

of three univariate q-Racah polynomials. We show in subsection 5.1 that these polynomials satisfy a certain symmetry under the exchange of the two degrees and of the two variables simultaneously. Then, the duality and biorthogonality relations are established in subsection 5.2. Subsection 5.3 contains the bispectral properties of these Griffiths polynomials. One recurrence relation is easily proven knowing the one of the Tratnik polynomials and the other one is deduced from it by leveraging the symmetry relation. The difference equations are then obtained thanks to the duality relation. We discuss about the polynomiality of the Griffiths polynomials in subsection 5.4. We conclude the paper in Section 6 by listing some open problems.

2 Properties of the q-Racah polynomials

The q-Racah polynomials are defined (see e.g. [47]) in terms of the q-hypergeometric functions as follows, for N a nonnegative integer and $0 \le n \le N$:

$$R_n(\mu(x); \alpha, \beta, \gamma, \delta) = {}_{4}\phi_3 \left(\begin{array}{c} q^{-n}, \ \alpha\beta q^{n+1}, \ q^{-x}, \ \gamma\delta q^{x+1} \\ \alpha q, \ \beta\delta q, \ \gamma q \end{array} \middle| q; q \right), \tag{2.1}$$

where $\mu(x) = q^{-x} + \gamma \delta q^{x+1}$ and either α , $\beta \delta$ or γ is equal to q^{-N-1} . For this paper to be self-contained, the definitions and notations pertaining to q-hypergeometric functions, q-Pochhammer symbols and q-binomials are recalled in Appendix A.

It is well-known that the q-Racah polynomials $R_n(\mu(x); \alpha, \beta, \gamma, \delta)$ are polynomials of degree n with respect to $\mu(x)$ and possess nice properties such as orthogonality and bispectrality. We now recall some of these properties after making a slight change of notation which will prove useful for the rest of the paper.

Let us write the parameters α , β , γ and δ in the following way:

$$\alpha = c_2, \qquad \beta = c_3, \qquad \gamma = q^{-N-1}, \qquad \delta = c_1 c_2 q^{N+1}.$$

We emphasize that δ depends on N, which is just a choice of parameter here, but this choice is crucial in the determination of the contiguity relations (2.18), (2.22) and for the definitions of the Tratnik polynomials (3.1) or Griffiths polynomials (5.1) of q-Racah type.

We also use a particular normalization for the q-Racah polynomials $\mathfrak{p}_n(x; c_1, c_2, c_3; N)$ throughout this paper. For N a nonnegative integer and $0 \le n \le N$:

$$\mathfrak{p}_n(x; c_1, c_2, c_3; N) = \Omega(n; c_1, c_2, c_3; N) \,_{4}\phi_3 \left(\begin{array}{ccc} q^{-n}, c_2 c_3 q^{n+1}, q^{-x}, c_1 c_2 q^{x+1} \\ q c_2, c_1 c_2 c_3 q^{N+2}, q^{-N} \end{array} \middle| q; q \right), \tag{2.3}$$

where

$$\Omega(n; c_1, c_2, c_3; N) = \begin{bmatrix} N \\ n \end{bmatrix}_q \frac{(1 - c_2 c_3 q^{2n+1})(q c_2; q)_n (c_1 c_2 c_3 q^{N+2}; q)_n (q c_1; q)_{N-n}}{(q c_2)^{n-N/2} (c_2 c_3 q^{n+1}; q)_{N+1} (q c_3; q)_n}.$$

The normalization $\Omega(n; c_1, c_2, c_3; N)$ is intimately linked to the weight and the norm of the q-Racah polynomials, as will be shown below. The function $\mathfrak{p}_n(x; c_1, c_2, c_3; N)$ is a polynomial of degree n with respect to $q^{-x} + c_1c_2q^{x+1}$. We use the convention that $\mathfrak{p}_n(x; c_1, c_2, c_3; N) = 0$ for n > N or x > N.

Lastly, note that replacing $c_i \mapsto q^{c_i}$ and taking the limit $q \to 1$, we recover the Racah polynomials with the normalization used in [13].

2.1 Bispectral property, duality and orthogonality

The q-Racah polynomials solve a bispectral problem i.e. verify a recurrence relation and a difference equation [47]. They are also orthogonal and satisfy a duality property. Below, these relations are recalled in the notations used in this paper.

Symmetry relation. The q-Racah polynomials obey the symmetry relation

$$\mathfrak{p}_n(x; c_1, c_2, c_3; N) = \left(\frac{c_1}{c_3}\right)^N \, \mathfrak{p}_n(x; c_1^{-1}, c_2^{-1}, c_3^{-1}; N) \Big|_{q \to q^{-1}} \,. \tag{2.5}$$

The notation $q \to q^{-1}$ means that the corresponding expression is defined by replacing q by q^{-1} everywhere, including the Pochhammer symbols and the basic hypergeometric functions. This relation is a direct consequence of the relations

$$\Omega(n; c_1, c_2, c_3; N) \Big|_{q \to q^{-1}, c_i \to c_i^{-1}} = \left(\frac{c_3}{c_1}\right)^N \Omega(n; c_1, c_2, c_3; N), \qquad (2.6)$$

that are themselves checked straightforwardly.

Duality. Using the invariance of the q-hypergeometric functions mentioned in Appendix A, we can show that the q-Racah polynomials satisfy the following duality relation, for $0 \le n, x \le N$:

$$\Omega(x; c_3, c_2, c_1; N) \,\mathfrak{p}_n(x; c_1, c_2, c_3; N) = \Omega(n; c_1, c_2, c_3; N) \,\mathfrak{p}_x(n; c_3, c_2, c_1; N) \,. \tag{2.8}$$

Orthogonality. For $0 \le n, m \le N$, the orthogonality relation between two q-Racah polynomials is:

$$\sum_{x=0}^{N} \Omega(x; c_3, c_2, c_1; N) \, \mathfrak{p}_n(x; c_1, c_2, c_3; N) \, \mathfrak{p}_m(x; c_1, c_2, c_3; N) = \delta_{n,m} \, \Omega(n; c_1, c_2, c_3; N) \,. \tag{2.9}$$

Strictly speaking, the term *orthogonality* is valid only if the weight $\Omega(x; c_3, c_2, c_1; N)$ is strictly positive for $0 \le x \le N$. This condition imposes restrictions on the parameters entering in the definition of the q-Racah polynomials.

The orthogonality relation composed with the duality relation leads to

$$\sum_{x=0}^{N} \mathfrak{p}_n(x; c_1, c_2, c_3; N) \, \mathfrak{p}_x(m; c_3, c_2, c_1; N) = \delta_{n,m} \,. \tag{2.10}$$

We call (2.10) the involution relation.

Recurrence relation. It is well-known from the classical theory of orthogonal polynomials that an orthogonal polynomial sequence obeys a three-term recurrence relation. For the q-Racah polynomials, it is given as follows, for $0 \le n, x \le N$:

$$\lambda(x; c_1 c_2) \,\mathfrak{p}_n(x; c_1, c_2, c_3; N) = \sum_{\varepsilon = 0, \pm} \Phi^{\varepsilon}(n + \varepsilon; c_1, c_2, c_3; N) \,\mathfrak{p}_{n + \varepsilon}(x; c_1, c_2, c_3; N) \,, \tag{2.11}$$

where

$$\lambda(x;c) = -(1 - q^{-x})(1 - cq^{x+1}), \qquad (2.12a)$$

In the above and throughout the paper, the notation $\varepsilon = 0, \pm$ should be understood as $\varepsilon = 0, \pm 1$ whenever the ε gets added or multiplied. Let us remark that, for n = 0 or n = N, the recurrence relation involves $\mathfrak{p}_{-1}(x; c_1, c_2, c_3; N)$ and $\mathfrak{p}_{N+1}(x; c_1, c_2, c_3; N)$ but due to the usual conventions for the q-binomial (see Appendix A), these terms vanish. In the recurrence relation, the denominators appearing in the various coefficients must not vanish. This leads to the following constraints on the parameters:

$$c_2c_3 \notin \{q^{-2}, q^{-3}, \dots, q^{-2N}\}.$$
 (2.13)

There exist apparent poles for $c_2c_3=1, q^{-1}, q^{-2N-1}, q^{-2N-2}$ but the residues on these points vanish. We also demand that the coefficients $\Phi^+(n; c_1, c_2, c_3; N)$ and $\Phi^-(n-1; c_1, c_2, c_3; N)$ do not vanish for $n=1,\ldots,N$. This leads to the supplementary constraints:

$$c_2, q \neq 0, \quad q, q^2, \dots, q^N \neq 1, \quad c_1, c_2, c_3, c_1 c_2 c_3 q^{N+1} \notin \{q^{-1}, q^{-2}, \dots, q^{-N}\}.$$

Difference equation. In addition to the previous recurrence relation, the q-Racah polynomials also satisfy a difference equation which can be deduced from the duality and recurrence relations. This difference equation reads, for $0 \le n, x \le N$:

$$\lambda(n; c_2 c_3) \,\mathfrak{p}_n(x; c_1, c_2, c_3; N) = \sum_{\varepsilon = 0, \pm} \Phi^{\varepsilon}(x; c_3, c_2, c_1; N) \,\mathfrak{p}_n(x - \varepsilon; c_1, c_2, c_3; N) \,. \tag{2.15}$$

For x = 0 (resp. x = N), the difference equation simplifies since $\Phi^+(0; c_3, c_2, c_1; N) = 0$ (resp. $\Phi^-(N; c_3, c_2, c_1; N) = 0$) which implies that $\mathfrak{p}_n(N+1; c_1, c_2, c_3; N)$ or $\mathfrak{p}_n(-1; c_1, c_2, c_3; N)$ never appear in the difference equations. As for the recurrence relation, the denominators appearing in the coefficients of the difference equation must not vanish. This leads to the following constraints on the parameters:

$$c_1 c_2 \notin \{q^{-2}, \dots, q^{-2N}\}.$$
 (2.16)

Due to the constraints (2.14) and (2.16), $\Phi^+(x; c_3, c_2, c_1; N)$ and $\Phi^-(x - 1; c_3, c_2, c_1; N)$ do not vanish for x = 1, ..., N.

From now on, we suppose that the constraints (2.13), (2.14) and (2.16) are satisfied.

Remark 2.1. Evidently, these relations correspond to the usual recurrence relation and difference equation of the q-Racah polynomials given, for example, in [47]. Let us point out that, in order to simplify the presentation and upcoming formulas, we have moved away from the usual naming conventions of the coefficients in the literature. The usual names can be recovered as follows:

$$\Phi^{-}(n; c_1, c_2, c_3; N) = A_n(c_1, c_2, c_3; N), \qquad \Phi^{-}(x; c_3, c_2, c_1; N) = B(x; c_1, c_2, c_3; N),
\Phi^{+}(n; c_1, c_2, c_3; N) = C_n(c_1, c_2, c_3; N), \qquad \Phi^{+}(x; c_3, c_2, c_1; N) = D(x; c_1, c_2, c_3; N).$$

The notation Φ^{ε} , $\varepsilon \in \{+,0,-\}$ used in this paper makes explicit the symmetry between the coefficients of the recurrence relation and the difference equation and allows for more compact expressions, see e.g. Section C.2.

Remark 2.2. The constraints (2.13) and (2.16) are necessary and sufficient conditions to ensure $\lambda(x; c_1c_2) \neq \lambda(y; c_1c_2)$ and $\lambda(x; c_2c_3) \neq \lambda(y; c_2c_3)$ for $x \neq y$ and $0 \leq x, y \leq N$.

2.2 Contiguity recurrence relations and difference equations

The contiguity relations relate polynomials with contiguous values of N. For Racah polynomials, such relations played a crucial role in constructing the representations of the rank 2 Racah algebra [15]. Such contiguity relations were also used to prove the bispectral properties of the Griffiths polynomials of Krawtchouk type in [12] and of Racah type in [13]. They also appear in the study of the representations of the factorized Leonard pairs [19]. These relations and their proofs for the q-Racah polynomials are given below and will be utilized in the study of the bispectral properties of the Tratnik polynomials of q-Racah type in Section 3.

Proposition 2.3. The contiquity recurrence relations between the q-Racah polynomials are

= \sum_{\varepsilon=0,\pm} \Phi^{\varepsilon}_{\pm}(n+\varepsilon;c_{1},c_{2},c_{3};N) \sum_{\varepsilon'=0,\pm} \Phi^{\varepsilon'}(n+\varepsilon+\varepsilon';c_{1},c_{2},c_{3};N) \mathfrak{p}_{n+\varepsilon+\varepsilon'}(x;c_{1},c_{2},c_{3};N)

The last equation is obtained using the recurrence relation. Finally, computing the coefficients in front of $\mathfrak{p}_j(x;c_1,c_2,c_3;N)$ for j=n-2,n-1,n,n+1,n+2, relation (2.18) is proved.

3 Tratnik polynomials of q-Racah type

A bivariate generalization of the q-Racah polynomials has been introduced in [28, 40] and is here called the $Tratnik\ polynomials\ of\ q$ -Racah type. We define these polynomials, recall some of their properties and provide their proofs in the notation of this paper.

For i, j nonnegative integers and $i + j \leq N$, the bivariate Tratnik polynomials of q-Racah type are defined by:

$$\mathcal{T}_{i,j}(x,y;c_1,c_2,c_3,c_4;N) = \mathfrak{p}_i(x;c_1,c_2,c_3;N-j)\,\mathfrak{p}_j(y;c_3,c_0,c_4;N-x)\,,\tag{3.1}$$

where the parameter c_0 appearing in the l.h.s. of the above relation is defined through the following constraints between the parameters:

The notation $\mathcal{T}_{i,j}(x,y)$ is short for $\mathcal{T}_{i,j}(x,y;c_1,c_2,c_3,c_4;N)$. From the convention for the Racah polynomials, one gets: $\mathcal{T}_{i,j}(x,y;c_1,c_2,c_3,c_4;N) = 0$ for i < 0 or j < 0 or i + j > N. We demand that the constraints (2.13), (2.14) and (2.16) be obeyed for each univariate polynomials, *i.e.* the parameters must satisfy

Let us emphasize that we could multiply the previous expression of $\mathcal{T}_{i,j}(x,y;c_1,c_2,c_3,c_4;N)$ by some functions f(i,j) or g(x,y). All the relations satisfied by $\mathcal{T}_{i,j}(x,y;c_1,c_2,c_3,c_4;N)$ would still hold, although with modified expressions for the coefficients occurring in the relations.

Remark 3.1. The Tratnik polynomials of q-Racah type (3.1) are in correspondence with the definition (2.13) of [40]. The expression R_2 of the Tratnik polynomials in [40] is given by

The Tratnik polynomials of q-Racah type defined in the above equation (3.1) are related to R_2 as follows, for $0 \le z_1 \le z_2 \le N$ and n_1, n_2 nonnegative integers such that $0 \le n_1 + n_2 \le N$:

Proof. Direct calculation, using the explicit expression (3.1) for the Tratnik polynomials, the relation (3.11) and the orthogonality relation (2.9) for the Racah polynomials.

As for the univariate polynomials, the previous relation defines orthogonal polynomials if the parameters are chosen such that the weight is strictly positive.

Proposition 3.4 (Duality). The Tratnik polynomials obey the following duality relation, for i, j, x, y nonnegative integers such that $i + j \le N$ and $x + y \le N$:

Proof. Consequence of relation (3.11) combined with the duality relation (2.8) for the Racah polynomials. \Box

As for the univariate Racah polynomials, we can compose the orthogonality and duality relations to obtain an involution relation for the Tratnik polynomials:

where λ and Φ^{ε} are given by (2.12) and

Proof. The equation (3.18) is a direct consequence of the recurrence equation (2.11) applied to the Racah polynomial $\mathfrak{p}_i(x; c_1, c_2, c_3; N - j)$ in $\mathcal{T}_{i,j}(x, y)$.

The relation (3.26) opens the path to connection to stochastic models, such as birth and death processes, in the spirit of e.g. [55].

In addition of the two recurrence relations, the Tratnik polynomials satisfy two difference equations given below.

Proposition 3.7 (Difference equations). For x, y, i, j nonnegative integers such that $x + y \leq N$ and $i + j \leq N$, the Tratnik polynomials satisfy the following two difference equations:

$$\lambda(j; c_4 c_0) \mathcal{T}_{i,j}(x, y) = \sum_{\varepsilon = 0, +} \Phi^{\varepsilon}(y; c_4, c_0, c_3; N - x) \mathcal{T}_{i,j}(x, y - \varepsilon), \qquad (3.29)$$

$$\lambda(i; c_2 c_3) \, \mathcal{T}_{i,j}(x,y) = \sum_{\varepsilon, \varepsilon' = 0, \pm} A_{y,x}^{\varepsilon, \varepsilon'}(c_4, c_0, c_3, c_1; N) \, \mathcal{T}_{i,j}(x - \varepsilon', y - \varepsilon) \,. \tag{3.30}$$

Proof. The equation (3.29) is a direct consequence of the difference relation (2.15) applied to the Racah polynomial $\mathfrak{p}_j(y; c_3, c_0, c_4; N-x)$ in $\mathcal{T}_{i,j}(x,y)$. For relation (3.30), the calculation may proceed along

the same lines as what was done for Proposition 3.5. However, it can also be proven by combining the previous result (3.19), the duality relation (3.14) and the following relations between the coefficients:

$$A_{y,x}^{\varepsilon,\varepsilon'}(c_4, c_0, c_3, c_1; N) = \frac{\Omega(y - \varepsilon; c_4, c_0, c_3; N - x + \varepsilon')\Lambda(x - \varepsilon'; c_1, c_2, c_3, c_4, N)}{\Omega(y; c_4, c_0, c_3; N - x)\Lambda(x; c_1, c_2, c_3, c_4, N)} \times A_{y-\varepsilon, x-\varepsilon'}^{-\varepsilon, -\varepsilon'}(c_4, c_0, c_3, c_1; N),$$
(3.31)

where
$$\varepsilon, \varepsilon' = 0, \pm$$
.

Up until now, we have been calling $\mathcal{T}_{i,j}(x,y)$ "polynomials" without any proper justification. We provide in the following proposition a precise statement about the polynomiality of $\mathcal{T}_{i,j}(x,y)$.

Proposition 3.8 (Polynomiality). For nonnegative integers i, j such that $i + j \leq N$, the "renormalized" Tratnik polynomials defined as

$$\overline{\mathcal{T}}_{i,j}(x,y) = \mathcal{T}_{i,j}(x,y) / \mathcal{T}_{N,0}(x,y)$$
(3.32)

are polynomials of total degree N-i in $\lambda(x; c_1c_2)$ and $\lambda(y; c_3c_0)$.

Proof. This is proved by recursion on (i, j). The starting point is $\overline{\mathcal{T}}_{N,0}(x, y) = 1$, which is by construction a polynomial of degree 0. Starting from this point (N, 0), a simple recursion on i using the first recurrence relation (3.18) shows that $\overline{\mathcal{T}}_{N-i,0}(x, y)$ is of total degree i in $\lambda(x; c_1 c_2)$ and $\lambda(y; c_3 c_0)$.

Now, consider the second recurrence relation (3.19) for $\overline{\mathcal{T}}_{N,0}(x,y)$: it follows that $\overline{\mathcal{T}}_{N-1,1}(x,y)$ is of total degree 1. Then, using the first recurrence relation, one gets that $\overline{\mathcal{T}}_{N-i,1}(x,y)$ is of total degree i in $\lambda(x; c_1c_2)$ and $\lambda(y; c_3c_0)$.

Then, iterate through a recursion on j. Suppose that $\overline{\mathcal{T}}_{N-i,j}(x,y)$ is of total degree i, for $i=0,1,\ldots N-j$. The second recurrence relation for $\overline{\mathcal{T}}_{N-j,j}(x,y)$ shows that $\overline{\mathcal{T}}_{N-j-1,j+1}(x,y)$ is of total degree j+1, and from there the first recurrence relation shows that the polynomials $\overline{\mathcal{T}}_{N-i,j+1}(x,y)$ for $i=0,1,\ldots N-j-1$ are of total degree i, which ends the recursion.

Let us remark that the normalization $\mathcal{T}_{N,0}(x,y)$ appearing in (3.32) takes the following simple form:

$$\mathcal{T}_{N,0}(x,y) = (-1)^N \left(\frac{c_1}{c_4}\right)^{N/2} \xi_N(c_2, c_2 c_3 q^N) \left(\frac{c_4}{c_3}\right)^{x/2} \xi_x(c_1, c_2). \tag{3.33}$$

Indeed, $\mathcal{T}_{N,0}(x,y)$ reduces to

$$\mathcal{T}_{N,0}(x,y) = \Omega(N; c_1, c_2, c_3; N) \Omega(0; c_3, c_0, c_4; N - x) {}_{4}\phi_{3} \begin{pmatrix} q^{-N}, c_2 c_3 q^{N+1}, q^{-x}, c_1 c_2 q^{x+1} \\ q c_2, c_1 c_2 c_3 q^{N+2}, q^{-N} \end{pmatrix} | q; q \end{pmatrix}. \tag{3.34}$$

Then, using the explicit expression of the coefficient Ω and the relation (A.4), as well as

$$\frac{4\phi_{3}\left(q^{-N}, c_{2}c_{3}q^{N+1}, q^{-x}, c_{1}c_{2}q^{x+1} \middle| q; q\right)}{qc_{2}, c_{1}c_{2}c_{3}q^{N+2}, q^{-N}} \middle| q; q\right) = \frac{4\phi_{3}\left(c_{2}c_{3}q^{N+1}, q^{-x}, c_{1}c_{2}q^{x+1} \middle| q; q\right)}{qc_{2}, c_{1}c_{2}c_{3}q^{N+2}} \middle| q; q\right)}{\left(\frac{1}{q}c_{2}, \frac{1}{q}c_{2}, \frac{1}{q}c_{2}c_{3}; q\right)_{x}}{\left(\frac{1}{q}c_{2}, \frac{1}{q}c_{2}c_{3}; q\right)_{x}}, (3.35)$$

we get the expression (3.33).

Remark 3.9 (Generalized Favard theorem). A multivariate version of the Favard theorem has been established, see e.g. Theorem 3.2.8 in [25]. It provides necessary and sufficient conditions for a family of multivariate polynomials satisfying recurrence relations to be orthogonal. For bivariate polynomials $P_{i,j}(x_1, x_2)$ of total degree i + j, the recurrence relations must be of the following form, for i = 1, 2:

$$x_i \mathbb{P}_n = \mathbb{A}_{n,i} \mathbb{P}_{n+1} + \mathbb{B}_{n,i} \mathbb{P}_n + \mathbb{A}_{n-1,i}^T \mathbb{P}_{n-1}. \tag{3.36}$$

In the above, we gather the r_n polynomials of total degree n in a vector \mathbb{P}_n . In the r.h.s., $\mathbb{A}_{n,i}$ and $\mathbb{B}_{n,i}$ are matrices of size $r_n \times r_{n+1}$ and $r_n \times r_n$ respectively. An additional necessary condition is that $\mathbb{B}_{n,i}$ must be symmetric.

We now show that these conditions are satisfied for the bivariate Tratnik polynomials. Define the vectors

$$\mathbb{T}_n = \left(\nu_{n,0} \overline{\mathcal{T}}_{N-n,0}, \ \nu_{n,1} \overline{\mathcal{T}}_{N-n,1}, \dots, \ \nu_{n,n} \overline{\mathcal{T}}_{N-n,n}\right)^T$$
(3.37)

containing all polynomials of degree n renormalized by some coefficients $\nu_{i,j}$. In order to get the recurrence relations (3.19) and (3.18) in the form (3.36), we need to impose

$$\left(\frac{\nu_{i,j+1}}{\nu_{i,j}}\right)^{2} = \frac{A_{N-i,j+1}^{0,+}(c_{1},c_{2},c_{3},c_{4};N)}{A_{N-i,j}^{0,-}(c_{1},c_{2},c_{3},c_{4};N)}, \qquad \left(\frac{\nu_{i+1,j}}{\nu_{i,j}}\right)^{2} = \frac{A_{N-i-1,j}^{-,0}(c_{1},c_{2},c_{3},c_{4};N)}{A_{N-i,j}^{+,0}(c_{1},c_{2},c_{3},c_{4};N)},
\left(\frac{\nu_{i+1,j+1}}{\nu_{i,j}}\right)^{2} = \frac{A_{N-i-1,j+1}^{-,+}(c_{1},c_{2},c_{3},c_{4};N)}{A_{N-i,j}^{+,-}(c_{1},c_{2},c_{3},c_{4};N)}, \qquad \left(\frac{\nu_{i,j+1}}{\nu_{i+1,j}}\right)^{2} = \frac{A_{N-i,j+1}^{+,+}(c_{1},c_{2},c_{3},c_{4};N)}{A_{N-i-1,j}^{-,-}(c_{1},c_{2},c_{3},c_{4};N)}, \qquad (3.38)$$

$$\left(\frac{\nu_{i+1,j}}{\nu_{i,j}}\right)^{2} = \frac{\Phi^{-}(N-i-1;c_{1},c_{2},c_{3};N-j)}{\Phi^{+}(N-i;c_{1},c_{2},c_{3};N-j)},$$

where $A_{i,j}^{\varepsilon,\varepsilon'}(c_1,c_2,c_3,c_4;N)$ and $\Phi^{\varepsilon}(i+\varepsilon;c_1,c_2,c_3;N-j)$ are the coefficients introduced in (3.20) and (2.12). Using the explicit expression of these coefficients, one can show that in (3.38), the second and third lines are a consequence of the first line, the latter being sufficient to determine the coefficients ν up to a global constant. Thus, the polynomials $\overline{\mathcal{T}}_{i,j}(x,y)$ may be orthogonal, in accordance with the result in Proposition 3.3.

4 Racah and Biedenharn–Elliot relations for q-Racah polynomials

Two fundamental relations involving univariate q-Racah polynomials are the Racah and Biedenharn–Elliot relations. These relations will be key ingredients in the next section. Both these relations have been obtained in the study of 6j-symbols of the quantum algebra $U_q(su(2))$, meaning that they were valid only for a restricted range of parameters. We present them below in their full generality. To the best of our knowledge, these general relations have not appeared in the literature before and the proofs we provide are new.

4.1 Racah relation

The Racah relation appeared in the study of the 6j-symbol for the Lie algebra su(2) (see e.g. [49]) and has been related to the Racah algebra (a limit $Q \to 1$ of the Askey–Wilson algebra) in [33]. As the 6j-symbol can be expressed in terms of Racah polynomials [64, 44], the Racah relation leads to an identity for Racah polynomials with particular parameters. This relation was then generalized through the study of the representations of the Racah algebra [15]. When the 6j-symbol for the quantum group $U_q(su(2))$ is instead considered, there exists a similar relation involving the q-Racah polynomials with particular parameters [45] and their study is intimately linked to the Askey–Wilson algebra aw(3) [34]. In this paper, using the representations of the Askey–Wilson algebra aw(3) introduced in the Appendix B and following the lines of the proof in the non-deformed case [15], we prove the Racah relation for generic q-Racah polynomials.

Proposition 4.1. The Racah relation between the q-Racah polynomials reads, for $0 \le i, x \le N$,

$$\sum_{n=0}^{N} \frac{\omega_n(c_1c_2)}{\xi_n(c_1, c_2)} \frac{\omega_i(c_2c_3)}{\xi_i(c_2, c_3)} \frac{\omega_x(c_3c_1)}{\xi_x(c_3, c_1)} \mathfrak{p}_i(n; c_1, c_2, c_3; N) \mathfrak{p}_n(x; c_3, c_1, c_2; N)$$

$$= \omega_N(qc_1c_2c_3) \mathfrak{p}_i(x; c_1, c_3, c_2; N),$$
(4.1)

where the functions ξ and ω are defined in (B.3).

Proof. Consider the three equivalent representations of $\mathbf{aw}(3)$ \mathcal{A} , \mathcal{B} , \mathcal{C} introduced in the Appendix B.2. The changes of basis between these representations (B.8) lead to

$$\mathcal{P}_{CB} \mathcal{B}_I \mathcal{P}_{BC} = \mathcal{C}_I = \mathcal{P}_{CA} \mathcal{P}_{AB} \mathcal{B}_I \mathcal{P}_{BA} \mathcal{P}_{AC}, \qquad I \in \{12, 23, 13\}. \tag{4.2}$$

Since the representations \mathcal{A} , \mathcal{B} and \mathcal{C} are irreducible, the above formula implies that there exists (by Schur's Lemma) a constant τ such that

$$\mathcal{P}_{\mathcal{B}\mathcal{A}}\,\mathcal{P}_{\mathcal{A}\mathcal{C}} = \tau\,\mathcal{P}_{\mathcal{B}\mathcal{C}}\,. \tag{4.3}$$

To determine the constant τ take the component (0,0) of the previous equation. This leads to:

$$\tau = \left(\frac{qc_1c_2}{c_3}\right)^{\frac{N}{2}} \sum_{k=0}^{N} (-1)^k q^{\binom{k}{2}} \begin{bmatrix} N \\ k \end{bmatrix}_q \frac{(1 - c_1c_2q^{2k+1})(c_1c_2c_3q^{N+2}; q)_k (qc_3; q)_{N-k}}{(c_1c_2q^{k+1}; q)_{N+1}}.$$
 (4.4)

The above sum can be computed from the orthogonality relation of the q-Racah polynomials. Starting from (2.9) in the case where n=m=0, replace $c_1\mapsto c_1/t$ and $c_2\mapsto c_2t$ and take the limit $t\to\infty$. This allows to identify

$$\tau = \omega_N(qc_1c_2c_3). \tag{4.5}$$

Finally, the entry (i, x) of relation (4.3) is precisely the Racah relation of the proposition.

4.2 Biedenharn-Elliot relation

Similarly to the Racah relation, the Biedenharn–Elliot relation is a relation between the 6j-symbols for the Lie algebra su(2) [8, 26] which has been generalized to the case of the quantum group $U_q(su(2))$ in [45, 50]. In [15], this relation is also obtained in the context of the Racah algebra. We provide here this relation for generic q-Racah polynomials.

Proposition 4.2. For i, j, x, y nonnegative integers such that $0 \le i + j \le N$ and $0 \le x + y \le N$, the Biedenharn–Elliot relation between the q-Racah polynomials is:

$$\sum_{a=0}^{\min(N-j,N-y)} \mathfrak{p}_{i}(a;c_{3},c_{2},c_{1};N-j)\,\mathfrak{p}_{j}(y;c_{1},c_{0},c_{4};N-a)\,\mathfrak{p}_{a}(x;c_{4},c_{3},c_{2};N-y)
\times \left(\frac{c_{0}}{c_{3}}\right)^{\frac{i}{2}} \left(\frac{c_{3}}{c_{1}}\right)^{\frac{j}{2}} \left(\frac{c_{1}}{c_{4}}\right)^{\frac{a}{2}} \left(\frac{c_{2}}{c_{0}}\right)^{\frac{y}{2}} \xi_{i}(c_{1},c_{2})\,\xi_{j}(c_{4},c_{0})\,\xi_{a}(c_{2},c_{3})\,\xi_{y}(c_{0},c_{1})\,\xi_{x}(c_{3},c_{4})
= \mathfrak{p}_{i}(x;c_{3},c_{4},c_{0};N-i)\,\mathfrak{p}_{i}(y;c_{0},c_{1},c_{2};N-x).$$
(4.6)

The last line of the equation can also be written as a Tratnik polynomial $\mathcal{T}_{j,i}(x,y;c_3,c_4,c_0,c_2;N)$.

Proof. Consider the five equivalent representations of **aw**(4) A, B, C, D, E introduced in the Appendix C.2. The changes of basis between these representations (C.17) lead to

$$\mathsf{P}_{\mathsf{AB}}\,\mathsf{P}_{\mathsf{BC}}\,\mathsf{P}_{\mathsf{CD}}\,\mathsf{D}_{I}\,\mathsf{P}_{\mathsf{DC}}\,\mathsf{P}_{\mathsf{CB}}\,\mathsf{P}_{\mathsf{BA}}\,=\mathsf{A}_{I}=\mathsf{P}_{\mathsf{AE}}\,\mathsf{P}_{\mathsf{ED}}\,\mathsf{D}_{I}\,\mathsf{P}_{\mathsf{DE}}\,\mathsf{P}_{\mathsf{EA}}\,,\qquad I\in\{12,23,34,123,234\}\,. \tag{4.7}$$

Since the representations A, B, C, D and E are irreducible, the above formula implies that there exists (by Schur's Lemma) a constant τ such that

$$P_{AB} P_{BC} P_{CD} = \tau P_{AE} P_{ED}. \tag{4.8}$$

To determine the constant τ take the component (0,0); (0,0) of the previous equation. This leads to:

$$\tau = \frac{\Omega(0; c_3, c_2, c_1; N)}{\Omega(0; c_3, c_4, c_0; N) \Omega(0; c_0, c_1, c_2; N)} \sum_{j=0}^{N} \left(\frac{c_1}{c_4}\right)^{\frac{j}{2}} \xi_j(c_2, c_3) \Omega(0; c_1, c_0, c_4; N - j) \Omega(j; c_4, c_3, c_2; N).$$
(4.9)

The above sum can be computed from the orthogonality relation of the q-Racah polynomials. Starting from (2.9) in the case where n=m=0, replace $c_1 \mapsto 1/(c_1q^{N+1})$, $c_2 \mapsto c_1c_2c_3q^{N+1}$, $c_3 \mapsto c_4$. We find that τ is precisely equal to

$$\tau = 1. \tag{4.10}$$

Finally, the entry (i, j); (y, x) of relation (4.8) is precisely the Biedenharn–Elliot relation of the proposition.

5 Griffiths polynomials of q-Racah type

We now introduce the main functions of this paper, called the *Griffiths polynomials of q-Racah type*. For i, j nonnegative integers such that $i + j \leq N$, they are defined as:

$$G_{i,j}(x,y;c_1,c_2,c_3,c_4;N)$$

$$= \sum_{a=0}^{M} \omega_a \left(\frac{c_1 c_2 c_3}{c_4}\right) \mathfrak{p}_i(a; c_1, c_2, c_3; N-j) \mathfrak{p}_j(y; c_3, c_0, c_4; N-a) \mathfrak{p}_a(x; c_4, c_2, c_1; N-y),$$
 (5.1)

with $M = \min(N - j, N - y)$. Again, the parameter c_0 is fixed through the constraint equation $c_0c_1c_2c_3c_4q^{2N+3} = 1$ and $\omega_a(c)$ is given by (B.3). The notation $\mathcal{G}_{i,j}(x,y)$ is short for the functions $\mathcal{G}_{i,j}(x,y;c_1,c_2,c_3,c_4;N)$. Replacing $c_i \to q^{c_i}$ and taking the limit $q \to 1$ in (5.1), we recover the Griffiths polynomial of Racah type studied in [13]:

$$\lim_{q \to 1} \mathcal{G}_{i,j}(x,y;q^{c_1},q^{c_2},q^{c_3},q^{c_4};N) = G_{i,j}(x,y;c_1,c_2,c_3,c_4;N).$$
(5.2)

The polynomials $G_{i,j}(x,y)$ were introduced in [15] with a different normalization. As mentioned in the introduction, it has been shown in [13] that the polynomials $G_{i,j}(x,y;c_1,c_2,c_3,c_4;N)$ tend (in a certain limit) to the original bivariate Griffiths polynomials introduced in [35]. This latter fact justifies the appellation of "Griffiths polynomials" used in this paper for $\mathcal{G}_{i,j}(x,y)$.

The Griffiths polynomials of q-Racah type can be expressed in terms of the Tratnik polynomials introduced previously:

$$\mathcal{G}_{i,j}(x,y) = \sum_{a=0}^{M} \omega_a \left(\frac{c_1 c_2 c_3}{c_4}\right) \mathcal{T}_{i,j}(a,y;c_1,c_2,c_3,c_4;N) \, \mathfrak{p}_a(x;c_4,c_2,c_1;N-y)$$
 (5.3)

$$= \sum_{a=0}^{M} \omega_a \left(\frac{c_1 c_2 c_3}{c_4}\right) \mathfrak{p}_i(a; c_1, c_2, c_3; N - j) \mathcal{T}_{j,a}(y, x; c_3, c_0, c_4, c_1; N).$$
 (5.4)

We demand that, for each univariate polynomials in the definition of the Griffiths polynomials (5.1), the constraints (2.13), (2.14) and (2.16) be obeyed, *i.e.* the parameters must satisfy

$$c_i, q \neq 0, \qquad q, q^2, \dots, q^N \neq 1,$$
 (5.5a)

$$c_1c_2, c_2c_3, c_0c_3, c_0c_4, c_2c_4, qc_1c_2c_3, qc_0c_3c_4, qc_1c_2c_4 \notin \{q^{-2}, q^{-3}, \dots, q^{-2N}\},$$
 (5.5b)

$$c_0, c_1, c_2, c_3, c_4 \notin \{q^{-1}, q^{-2}, \dots, q^{-N}\}.$$
 (5.5c)

In the following, we show that the Griffiths polynomials of q-Racah type have numerous interesting properties.

5.1 Symmetry relations

The Griffiths polynomials (5.1) satisfy a symmetry relation (5.15) that links $\mathcal{G}_{i,j}(x,y)$ to $\mathcal{G}_{j,i}(y,x)$. This relation will play an important role in the proof of the bispectrality of the Griffiths polynomials. Put simply, the bispectrality properties on i and x will be easily transposed to the bispectrality properties on j and j.

In order to prove this relation, we first need the following lemma.

Lemma 5.1. The Griffiths polynomials (5.1) satisfy the following two relations:

$$\mathcal{G}_{i,j}(x,y;c_1,c_2,c_3,c_4;N) = \left(\frac{c_0}{c_1}\right)^{\frac{i}{2}} \left(\frac{c_3}{c_1}\right)^{\frac{j}{2}} \left(\frac{c_1}{c_0}\right)^{\frac{y}{2}} \left(\frac{c_1}{c_4}\right)^{\frac{y}{2}} \frac{\xi_i(c_2,c_3)\xi_j(c_0,c_4)}{\xi_x(c_2,c_4)\xi_y(c_0,c_3)} \frac{\omega_j(c_0c_2c_4/c_1)}{\omega_i(c_3c_0c_2/c_1)} \omega_N(qc_1c_2c_3) \times \left.\mathcal{G}_{i,j}(y,x;c_1^{-1},c_3^{-1},c_2^{-1},c_0^{-1};N)\right|_{q\to q^{-1}}, \tag{5.6}$$

and

$$\mathcal{G}_{i,j}(x,y;c_{1},c_{2},c_{3},c_{4};N) = \left(\frac{c_{0}}{c_{1}}\right)^{\frac{i}{2}} \left(\frac{c_{3}}{c_{1}}\right)^{\frac{j}{2}} \left(\frac{c_{1}}{c_{0}}\right)^{\frac{x}{2}} \left(\frac{c_{1}}{c_{4}}\right)^{\frac{y}{2}} \frac{\xi_{i}(c_{2},c_{3})\xi_{j}(c_{0},c_{4})}{\xi_{x}(c_{2},c_{4})\xi_{y}(c_{0},c_{3})} \frac{\omega_{y}(c_{1}c_{3}c_{0}/c_{2})}{\omega_{x}(c_{2}c_{4}c_{1}/c_{0})} \omega_{N}(qc_{1}c_{2}c_{4}) \times \mathcal{G}_{j,i}(x,y;c_{1}^{-1},c_{4}^{-1},c_{0}^{-1},c_{2}^{-1};N)\Big|_{q\to q^{-1}},$$
(5.7)

where ξ and ω are given in (B.3).

Proof. Rewrite the Griffiths polynomial (5.1) as

$$\mathcal{G}_{i,j}(x,y) = \sum_{b=0}^{M} \sum_{a=0}^{N-j} \frac{\omega_a(c_1 c_2)}{\xi_a(c_1, c_2)} \, \mathfrak{p}_i(a; c_1, c_2, c_3; N-j) \, \delta_{a,b} \\
\times \left(\frac{c_3}{c_4}\right)^{\frac{b}{2}} \xi_b(c_1, c_2) \, \mathfrak{p}_j(y; c_3, c_0, c_4; N-b) \, \mathfrak{p}_b(x; c_4, c_2, c_1; N-y) \, . \tag{5.8}$$

It is straightforward to check that (5.8) reduces to (5.1) upon getting rid of the sum on a with the Kronecker delta $\delta_{a,b}$ and using the identities

$$\xi_b(c_1, c_2) \, \xi_b(c_2, c_1) = 1 \,, \qquad \omega_a(cd) = \omega_a(c) \, d^{\frac{n}{2}} \,.$$
 (5.9)

Next, use the involution relation (2.10) to rewrite the Kronecker delta $\delta_{a,b}$ in (5.8):

$$\mathcal{G}_{i,j}(x,y) = \sum_{b=0}^{M} \sum_{a=0}^{N-j} \sum_{d=0}^{N-j} \frac{\omega_a(c_1c_2)}{\xi_a(c_1,c_2)} \, \mathfrak{p}_i(a;c_1,c_2,c_3;N-j) \, \mathfrak{p}_a(d;c_3,c_1,c_2;N-j) \\
\times \left(\frac{c_3}{c_4}\right)^{\frac{b}{2}} \, \xi_b(c_1,c_2) \, \mathfrak{p}_d(b;c_2,c_1,c_3;N-j) \, \mathfrak{p}_j(y;c_3,c_0,c_4;N-b) \, \mathfrak{p}_b(x;c_4,c_2,c_1;N-y) \, . \tag{5.10}$$

Since the bounds on a, b, d are independent of each other, the sums can be freely interchanged. Apply the Racah relation (4.1) on the first two polynomials (sum over a). This leads to

$$\mathcal{G}_{i,j}(x,y) = \sum_{b=0}^{M} \sum_{d=0}^{N-j} \omega_{N-j} (qc_1c_2c_3) \frac{\xi_i(c_2,c_3)\xi_d(c_3,c_1)}{\omega_i(c_2c_3)\omega_d(c_3c_1)} \, \mathfrak{p}_i(d;c_1,c_3,c_2;N-j) \\
\times \left(\frac{c_3}{c_4}\right)^{\frac{b}{2}} \xi_b(c_1,c_2) \, \mathfrak{p}_d(b;c_2,c_1,c_3;N-j) \, \mathfrak{p}_j(y;c_3,c_0,c_4;N-b) \, \mathfrak{p}_b(x;c_4,c_2,c_1;N-y) \, . \tag{5.11}$$

Now use the Biedenharn–Elliot relation (4.6) on the last three polynomials (sum over b). The result vanishes if d > N - x, thus the values of d that contribute in (5.11) further restrain the summation boundaries to $0 \le d \le M' = \min(N - j, N - x)$. Hence one gets

$$\mathcal{G}_{i,j}(x,y) = \left(\frac{c_3}{c_2}\right)^{\frac{j}{2}} \left(\frac{c_0}{c_1}\right)^{\frac{x}{2}} \left(\frac{c_1}{c_4}\right)^{\frac{y}{2}} \frac{\omega_{N-j}(qc_1c_2c_3)}{\omega_i(c_2c_3)} \frac{\xi_i(c_2,c_3)\xi_j(c_0,c_4)}{\xi_x(c_2,c_4)\xi_y(c_0,c_3)} \times \sum_{d=0}^{M'} \frac{1}{\omega_d\left(\frac{c_3c_1c_0}{c_2}\right)} \mathfrak{p}_i(d;c_1,c_3,c_2;N-j) \mathfrak{p}_j(x;c_2,c_4,c_0;N-d) \mathfrak{p}_d(y;c_0,c_3,c_1;N-x) \,.$$
(5.12)

Using the symmetry relation (2.5) for the Racah polynomials and the equality $\frac{1}{\omega_d(c)} = \omega_d(c^{-1})|_{q \to q^{-1}}$, the sum over d in (5.12) can now be written as a Griffiths polynomial in the indeterminate q^{-1} :

$$\sum_{d=0}^{M'} \frac{1}{\omega_d(\frac{c_3c_1c_0}{c_2})} \mathfrak{p}_i(d; c_1, c_3, c_2; N-j) \mathfrak{p}_j(x; c_2, c_4, c_0; N-d) \mathfrak{p}_d(y; c_0, c_3, c_1; N-x)$$

$$= \left(\frac{c_2}{c_1}\right)^j \left(\frac{c_1}{c_0}\right)^x \sum_{i=1}^{M'} \left[\omega_d\left(\frac{c_1^{-1}c_3^{-1}c_2^{-1}}{c_0^{-1}}\right) \mathfrak{p}_i(d; c_1^{-1}, c_3^{-1}, c_2^{-1}; N-j)\right]$$
(5.13)

$$\times \mathfrak{p}_{j}(x; c_{2}^{-1}, c_{4}^{-1}, c_{0}^{-1}; N - d) \mathfrak{p}_{d}(y; c_{0}^{-1}, c_{3}^{-1}, c_{1}^{-1}; N - x) \Big] \Big|_{q \to q^{-1}}$$

$$= \left(\frac{c_{2}}{c_{1}}\right)^{j} \left(\frac{c_{1}}{c_{0}}\right)^{x} \mathcal{G}_{i,j}(y, x; c_{1}^{-1}, c_{3}^{-1}, c_{2}^{-1}, c_{0}^{-1}; N) \Big|_{q \to q^{-1}}.$$

$$(5.14)$$

Substituting this expression in (5.12) and expressing ω_{N-j} in term of ω_N and ω_j , one gets the result (5.6). The proof of relation (5.7) proceeds along the same lines.

The previous lemma allows us to get a nice symmetry relation for the Griffiths polynomials when the two variables and the two indices are exchanged simultaneously.

Theorem 5.2. The Griffiths polynomials (5.1) satisfy the following symmetry relation:

$$\mathcal{G}_{i,j}(x,y;c_1,c_2,c_3,c_4;N) \ \omega_i \left(\frac{c_2 c_3 c_4}{c_1}\right) \omega_x \left(\frac{c_4 c_2 c_1}{c_3}\right) c_0^{N/2}
= \mathcal{G}_{j,i}(y,x;c_1,c_0,c_4,c_3;N) \ \omega_j \left(\frac{c_3 c_0 c_4}{c_1}\right) \omega_y \left(\frac{c_1 c_0 c_3}{c_4}\right) c_2^{N/2} .$$
(5.15)

Proof. Compare the two expressions of $\mathcal{G}_{i,j}(x,y;c_1,c_2,c_3,c_4;N)$ given in Lemma 5.1. This yields a relation between $\mathcal{G}_{i,j}(y,x;c_1^{-1},c_3^{-1},c_2^{-1},c_0^{-1};N)|_{q\to q^{-1}}$ and $\mathcal{G}_{j,i}(x,y;c_1^{-1},c_4^{-1},c_0^{-1},c_2^{-1};N)|_{q\to q^{-1}}$. Replacing $q^{-1}\mapsto q$ and $c_i^{-1}\mapsto c_i$ in this expression and relabeling the c_i 's, one obtains the desired expression (5.15).

Remark 5.3. In the limit $q \to 1$ (with $c_i \mapsto q^{c_i}$), the symmetry relations given in Lemma 5.1 and Theorem 5.2 provide new symmetry relations for the Griffiths polynomials of Racah type:

$$G_{i,j}(x,y) = G_{i,j}(y,x;c_1,c_3,c_2,c_0;N) \left(-1\right)^{i+j+N} \frac{(c_4+1)_x (c_3+1)_y (c_2+1)_i (c_0+1)_j}{(c_2+1)_x (c_0+1)_y (c_3+1)_i (c_4+1)_j},$$
(5.16)

$$G_{i,j}(x,y) = G_{j,i}(x,y;c_1,c_4,c_0,c_2;N) (-1)^{x+y+N} \frac{(c_4+1)_x (c_3+1)_y (c_2+1)_i (c_0+1)_j}{(c_2+1)_x (c_0+1)_y (c_3+1)_i (c_4+1)_j},$$
(5.17)

$$G_{i,j}(x,y) = G_{j,i}(y,x;c_1,c_0,c_4,c_3;N) (-1)^{x+y+i+j},$$
(5.18)

where $(a)_n$ is the Pochhammer symbol, see Appendix A. These new relations may be used to simplify proofs given in [13].

5.2 Duality and biorthogonality

The Griffiths polynomials (5.1) obey a duality relation that connects two polynomials with a different set of parameters, as was the case for Tratnik polynomials.

Proposition 5.4. The Griffiths polynomials $\mathcal{G}_{i,j}$ obey the duality relation

$$\mathcal{G}_{i,j}(x,y;c_1,c_2,c_3,c_4;N) = \frac{\Omega(i;c_1,c_2,c_3;N-j)\Lambda(j;c_4,c_0,c_3,c_1)}{\Omega(x;c_1,c_2,c_4;N-y)\Lambda(y;c_3,c_0,c_4,c_1)} \mathcal{G}_{x,y}(i,j;c_1,c_2,c_4,c_3;N)$$
(5.19)

where Ω and Λ are given respectively by (2.4) and (3.9).

Proof. This is a consequence of the duality relation (2.8) for the Racah polynomials as well as the identities (3.11) and (3.12).

The Griffiths polynomials (5.1) are not orthogonal; rather they are *biorthogonal*. Both functions that are orthogonal with one another are Griffiths polynomials, but of different parameters.

Proposition 5.5. The Griffiths polynomials are biorthogonal:

$$\sum_{\substack{x,y\geq 0\\x+y\leq N}} \frac{\Omega(x;c_1,c_2,c_4;N-y)\Lambda(y;c_3,c_0,c_4,c_1)}{\xi_x(c_2,c_4)\xi_y(c_0,c_3)(\frac{c_1}{c_0})^{x/2}(\frac{c_4}{c_1})^{y/2}} \,\mathcal{G}_{i,j}(x,y;c_1,c_2,c_3,c_4;N) \,\mathcal{G}_{k,\ell}(y,x;c_1,c_3,c_2,c_0;N)$$

$$= \delta_{i,k} \, \delta_{j,\ell} \, \frac{\omega_j(\frac{c_2c_0c_4}{c_3}) \, \omega_N(qc_1c_2c_3)}{\omega_i(c_2c_3)} \, \frac{\Omega(i; c_1, c_2, c_3; N-j) \, \Lambda(j; c_4, c_0, c_3, c_1)}{\xi_i(c_2, c_3) \, \xi_j(c_0, c_4)} \,. \tag{5.20}$$

The functions ξ and ω are given in (B.3).

Proof. Consider the sum

$$\sum_{\substack{x,y\geq 0\\x+y\leq N}} \frac{\Omega(x;c_1,c_2,c_4;N-y)\Lambda(y;c_3,c_0,c_4,c_1)}{\Omega(i;c_1,c_2,c_3;N-j)\Lambda(j;c_4,c_0,c_3,c_1)} \mathcal{G}_{i,j}(x,y;c_1,c_2,c_3,c_4;N) \tilde{\mathcal{G}}_{k,\ell}(x,y),$$
(5.21)

where

$$\tilde{\mathcal{G}}_{k,\ell}(x,y) = \sum_{b=0}^{\min(N-y,N-\ell)} \frac{\mathfrak{p}_k(b;c_1,c_2,c_3;N-\ell)\,\mathfrak{p}_\ell(y;c_3,c_0,c_4;N-b)\,\mathfrak{p}_b(x;c_4,c_2,c_1;N-y)}{\omega_b(\frac{c_1c_2c_4}{c_3})} \,. \tag{5.22}$$

Expressing $\mathcal{G}_{i,j}$ and $\tilde{\mathcal{G}}_{k,\ell}$ in term of univariate q-Racah polynomials \mathfrak{p}_n , (5.21) is rewritten as a quadruple sum (on x, y, a and b) of univariate polynomials with the following coefficient entering the sum:

$$\frac{\Omega(x; c_1, c_2, c_4; N - y) \Lambda(y; c_3, c_0, c_4, c_1)}{\Omega(i; c_1, c_2, c_3; N - y) \Lambda(j; c_4, c_0, c_3, c_1)} \frac{\omega_a(\frac{c_1 c_2 c_3}{c_4})}{\omega_b(\frac{c_1 c_2 c_4}{c_2})}.$$
(5.23)

Using relation (3.11) to rewrite each of the Λ functions, the coefficient (5.23) is reexpressed as:

$$\frac{\Omega(x;c_1,c_2,c_4;N-y)\Omega(a;c_3,c_2,c_1;N-j)\Omega(y;c_4,c_0,c_3;N-a)}{\Omega(a;c_4,c_2,c_1;N-y)\Omega(i;c_1,c_2,c_3;N-j)\Omega(j;c_3,c_0,c_4;N-a)}\frac{\Lambda(a;c_1,c_2,c_4,c_3)\omega_a(\frac{c_1c_2c_3}{c_4})}{\Lambda(a;c_1,c_2,c_3,c_4)\omega_b(\frac{c_1c_2c_4}{c_3})}\,. \quad (5.24)$$

Now, starting from (5.21), perform the sum on x and use the orthogonality relation (2.9) for q-Racah polynomials to get a $\delta_{a,b}$ term that lets one evaluate the sum on b. By virtue of relation (3.11), the term $\frac{\Lambda(a;c_1,c_2,c_4,c_3)}{\Lambda(a;c_1,c_2,c_3,c_4)}\frac{\omega_a(c_1c_2c_3/c_4)}{\omega_b(c_1c_2c_4/c_3)}$ reduces to 1. Then, perform the sum on y to obtain a $\delta_{j,\ell}$ term through the orthogonality relation. Lastly, evaluate the sum on a, again using the orthogonality relation, to obtain another $\delta_{i,k}$ term. Hence, the expression (5.21) is $\delta_{j,\ell} \delta_{i,k}$. Next, notice that equation (5.13) shows that

$$\tilde{\mathcal{G}}_{k,\ell}(x,y) = \left(\frac{c_3}{c_1}\right)^{\ell} \left(\frac{c_1}{c_4}\right)^{y} \mathcal{G}_{k,\ell}(x,y;c_1^{-1},c_2^{-1},c_3^{-1},c_4^{-1};N)\Big|_{q \to q^{-1}}.$$
(5.25)

Using the relation (5.6) and the property $\xi_n(c,c') = 1/\xi_n(c',c)$, the final result (5.20) is obtained. \square

Let us stress that in the limit $q \to 1$, the biorthogonality relation becomes an orthogonality relation, in accordance with the results obtained in [13]. The symmetry relation (5.16) is used to obtain this result.

Note also that the Griffiths polynomial $\mathcal{G}_{i,j}(x,y;c_1,c_2,c_2,\pm\frac{q^{-N-1}}{c_2\sqrt{qc_1}};N)$ is orthogonal.

Corollary 5.6. The Griffiths polynomials $\mathcal{G}_{i,j}$ obey an involution relation

$$\sum_{\substack{x,y\geq 0\\x+y\leq N}} \left(\frac{c_1}{c_0}\right)^{\frac{x}{2}} \left(\frac{c_4}{c_1}\right)^{\frac{y}{2}} \xi_x(c_2, c_4) \, \xi_y(c_0, c_3) \, \mathcal{G}_{i,j}(x, y; c_1, c_2, c_3, c_4; N) \, \mathcal{G}_{y,x}(k, \ell; c_1, c_3, c_0, c_2; N)$$

$$= \delta_{i,k} \, \delta_{j,\ell} \, \omega_N(qc_1c_2c_3) \, \frac{\omega_j(\frac{c_3c_0c_4}{c_2})}{\omega_i(c_2c_3)} \, \xi_i(c_2, c_3) \, \xi_j(c_0, c_4) \, . \tag{5.26}$$

Proof. As a direct consequence of the duality and biorthogonality relations, one gets:

$$\sum_{\substack{x,y\geq 0\\x+y\leq N}} \frac{\Omega(x;c_1,c_2,c_4;N-y)\,\Lambda(y;c_3,c_0,c_4,c_1)}{\Omega(y;c_1,c_3,c_0;N-x)\,\Lambda(x;c_2,c_4,c_0,c_1)} \frac{\mathcal{G}_{i,j}(x,y;c_1,c_2,c_3,c_4;N)\,\mathcal{G}_{y,x}(k,\ell;c_1,c_3,c_0,c_2;N)}{\xi_x(c_2,c_4)(\frac{c_1}{c_0})^{x/2}\,\xi_y(c_0,c_3)(\frac{c_4}{c_1})^{y/2}}$$

$$= \frac{\omega_{j}(\frac{c_{2}c_{0}c_{4}}{c_{3}})\,\omega_{N}(qc_{1}c_{2}c_{3})}{\omega_{i}(c_{2}c_{3})}\,\frac{\Omega(i;c_{1},c_{2},c_{3};N-j)\,\Lambda(j;c_{4},c_{0},c_{3},c_{1})}{\Omega(i;c_{1},c_{3},c_{2};N-j)\,\Lambda(j;c_{0},c_{4},c_{2},c_{1})}\,\frac{\delta_{i,k}\,\delta_{j,\ell}}{\xi_{i}(c_{2},c_{3})\,\xi_{j}(c_{0},c_{4})}\,.$$
(5.27)

Then using the explicit expressions of the functions Ω and Λ , the result (5.26) follows.

5.3 Bispectral property

In this subsection, we obtain the bispectral property of the Griffiths polynomials of q-Racah type.

Proposition 5.7. The Griffiths polynomials of q-Racah type satisfy the following two recurrence relations:

$$\lambda(y; c_3 c_0) \,\mathcal{G}_{i,j}(x,y) = \sum_{\varepsilon, \varepsilon' = 0, \pm 1} A_{i+\varepsilon, j+\varepsilon'}^{\varepsilon, \varepsilon'}(c_1, c_2, c_3, c_4; N) \,\mathcal{G}_{i+\varepsilon, j+\varepsilon'}(x,y) \,, \tag{5.28}$$

$$\lambda(x; c_4 c_2) \mathcal{G}_{i,j}(x, y) = \sum_{\varepsilon, \varepsilon' = 0, +1} \frac{\omega_{\varepsilon}(q^{2i} c_2 c_3 c_4 / c_1)}{\omega_{\varepsilon'}(q^{2j} c_0 c_3 c_4 / c_1)} A_{j+\varepsilon', i+\varepsilon}^{\varepsilon', \varepsilon}(c_1, c_0, c_4, c_3; N) \mathcal{G}_{i+\varepsilon, j+\varepsilon'}(x, y), \qquad (5.29)$$

where $A_{i,j}^{\varepsilon,\varepsilon'}$ are given in (3.20) and ω_{ε} in (B.3).

Proof. The proof of (5.28) consists in writing the Griffiths polynomials using the form (5.3) and in using the recurrence relation (3.19) of the Tratnik polynomials.

To simplify the calculation, we define

$$\rho_{i,j} = \frac{\omega_j \left(\frac{c_3 c_0 c_4}{c_1}\right) \omega_y \left(\frac{c_1 c_0 c_3}{c_4}\right)}{\omega_i \left(\frac{c_2 c_3 c_4}{c_1}\right) \omega_x \left(\frac{c_4 c_2 c_1}{c_3}\right)} \left(\frac{c_2}{c_0}\right)^{N/2} . \tag{5.30}$$

To prove (5.29), rewrite its l.h.s. using the symmetry relation (5.15) and apply the first recurrence relation (5.28) (up to a suitable change of variables and indices):

$$\lambda(x; c_{2}c_{4}) \mathcal{G}_{i,j}(x, y; c_{1}, c_{2}, c_{3}, c_{4}; N) = \rho_{i,j} \lambda(x; c_{4}c_{2}) \mathcal{G}_{j,i}(y, x; c_{1}, c_{0}, c_{4}, c_{3}; N)
= \rho_{i,j} \sum_{\varepsilon, \varepsilon' = 0, \pm 1} A_{j+\varepsilon', i+\varepsilon}^{\varepsilon', \varepsilon}(c_{1}, c_{0}, c_{4}, c_{3}) \mathcal{G}_{j+\varepsilon', i+\varepsilon}(y, x; c_{1}, c_{0}, c_{4}, c_{3}; N)
= \sum_{\varepsilon, \varepsilon' = 0, \pm 1} \frac{\rho_{i,j}}{\rho_{i+\varepsilon, j+\varepsilon'}} A_{j+\varepsilon', i+\varepsilon}^{\varepsilon', \varepsilon}(c_{1}, c_{0}, c_{4}, c_{3}) \mathcal{G}_{i+\varepsilon, j+\varepsilon'}(x, y; c_{1}, c_{2}, c_{3}, c_{4}; N).$$
(5.31)

Examine the last line of (5.31), the r.h.s. of relation (5.29) is recognized by remarking that the ratio of the functions ρ is given by

$$\frac{\rho_{i,j}}{\rho_{i+\varepsilon,j+\varepsilon'}} = \frac{\omega_{i+\varepsilon}\left(\frac{c_2c_3c_4}{c_1}\right)\omega_j\left(\frac{c_3c_0c_4}{c_1}\right)}{\omega_i\left(\frac{c_2c_3c_4}{c_1}\right)\omega_{j+\varepsilon'}\left(\frac{c_3c_0c_4}{c_1}\right)} = \frac{\omega_\varepsilon(q^{2i}c_2c_3c_4/c_1)}{\omega_{\varepsilon'}(q^{2j}c_0c_3c_4/c_1)},$$
(5.32)

which concludes the proof.

Proposition 5.8. The Griffiths polynomials of q-Racah type satisfy the following two difference relations:

$$\lambda(j; c_0 c_4) \mathcal{G}_{i,j}(x, y) = \sum_{\varepsilon, \varepsilon' = 0, \pm 1} A_{x,y}^{\varepsilon, \varepsilon'}(c_1, c_2, c_4, c_3; N) \mathcal{G}_{i,j}(x - \varepsilon, y - \varepsilon'), \qquad (5.33)$$

$$\lambda(i; c_2 c_3) \,\mathcal{G}_{i,j}(x,y) = \sum_{\varepsilon, \varepsilon' = 0, \pm 1} \frac{\omega_{-\varepsilon'}(q^{2x} c_1 c_2 c_4 / c_3)}{\omega_{-\varepsilon}(q^{2y} c_1 c_0 c_3 / c_4)} \,A_{y,x}^{\varepsilon', \varepsilon}(c_1, c_0, c_3, c_4; N) \,\mathcal{G}_{i,j}(x - \varepsilon', y - \varepsilon) \,, \tag{5.34}$$

where $A_{x,y}^{\varepsilon,\varepsilon'}$ are given in (3.20) and ω_{ε} in (B.3).

Proof. The proof can be done mimicking the one of Proposition 5.7. Alternatively, one can use the duality property (5.19) of the Griffiths polynomials to obtain it from the recurrence relations.

It has been shown in [65] that $\mathbf{aw}(3)$ is the bispectral algebra of the q-Racah polynomials. For the bivariate Griffiths polynomials of q-Racah type introduced here, the bispectral algebra is the rank 2 Askey-Wilson algebra $\mathbf{aw}(4)$ defined in Appendix C.1.

5.4 Polynomiality

As was the case for the Tratnik polynomials, the recurrence relations proved above for $\mathcal{G}_{i,j}(x,y)$ can be used to prove its polynomiality.

Proposition 5.9. For i, j nonnegative integers such that $i + j \leq N$, the "renormalized" Griffiths polynomials

$$\overline{\mathcal{G}}_{i,j}(x,y) = \mathcal{G}_{i,j}(x,y)/\mathcal{G}_{0,N}(x,y)$$
(5.35)

are bivariate polynomials of total degree N-j in the variables $\lambda(x; c_4c_2)$ and $\lambda(y; c_0c_3)$. The function $\lambda(x; c)$ is defined in (2.12a).

Proof. The two recurrence relations (5.28), (5.29) for $\overline{\mathcal{G}}_{0,N}(x,y)$ lead to a system of two linear equations with coefficients independent from x and y, relating $\overline{\mathcal{G}}_{0,N-1}(x,y)$, $\overline{\mathcal{G}}_{1,N-1}(x,y)$ and $\overline{\mathcal{G}}_{0,N}(x,y)$ to $\lambda(x;c_4c_2)\overline{\mathcal{G}}_{0,N}(x,y)$, $\lambda(y;c_0c_3)\overline{\mathcal{G}}_{0,N}(x,y)$. Since $\overline{\mathcal{G}}_{0,N}(x,y)=1$, this shows that $\overline{\mathcal{G}}_{0,N-1}(x,y)$ and $\overline{\mathcal{G}}_{1,N-1}(x,y)$ are polynomials of total degree 1 in $\lambda(x;c_4c_2)$ and $\lambda(y;c_0c_3)$. The same procedure applied to $\overline{\mathcal{G}}_{0,N-1}(x,y)$ and then to $\overline{\mathcal{G}}_{1,N-1}(x,y)$ shows that $\overline{\mathcal{G}}_{0,N-2}(x,y)$, $\overline{\mathcal{G}}_{1,N-2}(x,y)$ and $\overline{\mathcal{G}}_{2,N-2}(x,y)$ are polynomials of total degree 2 in $\lambda(x;c_4c_2)$ and $\lambda(y;c_0c_3)$. Iteratively, supposing that, for $0 \le n \le N$ and $j \le N-n$, $\overline{\mathcal{G}}_{i,j}$ is of degree N-j, it can be shown through the recurrence relations of $\overline{\mathcal{G}}_{0,N-n}$, $\overline{\mathcal{G}}_{1,N-n}$, \dots , $\overline{\mathcal{G}}_{n,N-n}$ that $\overline{\mathcal{G}}_{k,\ell}$ with $k+\ell=N-(n+1)$ is a polynomial of degree N-(n+1). \square

The normalization $\mathcal{G}_{0,N}(x,y)$ in (5.35) can be computed explicitly. Indeed, the explicit expression (5.1) of the Griffiths polynomials leads to

$$\mathcal{G}_{0,N}(x,y) = (-1)^N \left(\frac{c_3}{c_1}\right)^{\frac{N}{2}} \left(\frac{c_1}{c_4}\right)^{\frac{y}{2}} \xi_N(c_0, c_0 c_4 q^N) \,\xi_y(c_3, c_0) \,. \tag{5.36}$$

Following an analogous reasoning, one can show that

$$\mathcal{G}_{i,j}(x,y)/\mathcal{G}_{N,0}(x,y) \tag{5.37}$$

is also a bivariate polynomial of total degree N-i in the variables $\lambda(x; c_4c_2)$ and $\lambda(y; c_0c_3)$. The value of $\mathcal{G}_{N,0}(x,y)$ is computed from (5.36) using the symmetry relation (5.15):

$$\mathcal{G}_{N,0}(x,y) = (c_0 c_3 q^{N+1})^{-\frac{N}{2}} \frac{\omega_y(\frac{c_1 c_0 c_3}{c_4})}{\omega_x(c_2 c_4)} \xi_N(c_2, c_2 c_3 q^N) \xi_x(c_4, c_2).$$
 (5.38)

Let us note that the direct calculation of $\mathcal{G}_{N,0}(x,y)$ starting from its explicit expression in (5.1) is rather cumbersome.

Remark 5.10. Let us point out that, contrarily to the Tratnik case, we can start from either the point (0, N) or the point (N, 0) to get polynomiality. For the Tratnik polynomials, the first recursion relation involves only the three points $(i + \varepsilon, j)$, $\varepsilon = 0, \pm$, thus it forces (N, 0) to be the starting point. For the Griffiths polynomials, both recursion relations involve nine points $(i + \varepsilon, j + \varepsilon')$, $\varepsilon, \varepsilon' = 0, \pm 1$, therefore we can choose any of the two points (0, N) or (N, 0) as the starting point.

Remark 5.11 (Generalized Favard theorem). We show that the necessary conditions of the generalized Favard theorem (see Remark 3.9) are not satisfied for the Griffiths polynomials, which is consistent with the fact that they are biorthogonal. Let us define

$$\mathbb{G}_n = \left(\chi_{n,0}\overline{\mathcal{G}}_{N-n,0}, \ \chi_{n,1}\overline{\mathcal{G}}_{N-n,1}, \dots, \ \chi_{n,n}\overline{\mathcal{G}}_{N-n,n}\right)^T$$
(5.39)

and look for coefficients χ such that the recurrence relations (5.28) and (5.29) can be put in the form of (5.39). This leads to the constraints

$$\left(\frac{\chi_{i,j+1}}{\chi_{i,j}}\right)^{2} = \frac{A_{N-i,j+1}^{0,+}(c_{1},c_{2},c_{3},c_{4};N)}{A_{N-i,j}^{0,-}(c_{1},c_{2},c_{3},c_{4};N)}, \qquad \left(\frac{\chi_{i+1,j}}{\chi_{i,j}}\right)^{2} = \frac{A_{N-i-1,j}^{-,0}(c_{1},c_{2},c_{3},c_{4};N)}{A_{N-i,j}^{+,0}(c_{1},c_{2},c_{3},c_{4};N)},
\left(\frac{\chi_{i+1,j+1}}{\chi_{i,j}}\right)^{2} = \frac{A_{N-i-1,j+1}^{-,+}(c_{1},c_{2},c_{3},c_{4};N)}{A_{N-i,j}^{+,-}(c_{1},c_{2},c_{3},c_{4};N)}, \qquad \left(\frac{\chi_{i,j+1}}{\chi_{i+1,j}}\right)^{2} = \frac{A_{N-i,j+1}^{-,+}(c_{1},c_{2},c_{3},c_{4};N)}{A_{N-i-1,j}^{-,-}(c_{1},c_{2},c_{3},c_{4};N)}, \tag{5.40}$$

and

$$\left(\frac{\chi_{i,j+1}}{\chi_{i,j}}\right)^{2} = \frac{\omega_{-}(q^{2j+2}c_{3}c_{0}c_{4}/c_{1})}{\omega_{+}(q^{2j}c_{3}c_{0}c_{4}/c_{1})} \frac{A_{j+1,N-i}^{+,0}(c_{1},c_{0},c_{4},c_{3};N)}{A_{j,N-i}^{-,0}(c_{1},c_{0},c_{4},c_{3};N)},
\left(\frac{\chi_{i+1,j}}{\chi_{i,j}}\right)^{2} = \frac{\omega_{-}(q^{2(N-i)}c_{2}c_{3}c_{4}/c_{1})}{\omega_{+}(q^{2(N-i-1)}c_{2}c_{3}c_{4}/c_{1})} \frac{A_{j,N-i-1}^{0,-}(c_{1},c_{0},c_{4},c_{3};N)}{A_{j,N-i}^{0,+}(c_{1},c_{0},c_{4},c_{3};N)},
\left(\frac{\chi_{i+1,j+1}}{\chi_{i,j}}\right)^{2} = \frac{\omega_{-}(q^{2(N-i)}c_{2}c_{3}c_{4}/c_{1})}{\omega_{+}(q^{2j+2}c_{3}c_{0}c_{4}/c_{1})} \frac{\omega_{-}(q^{2j}c_{3}c_{0}c_{4}/c_{1})}{\omega_{+}(q^{2(N-i-1)}c_{2}c_{3}c_{4}/c_{1})} \frac{A_{j,N-i-1}^{+,-}(c_{1},c_{0},c_{4},c_{3};N)}{A_{j,N-i}^{-,+}(c_{1},c_{0},c_{4},c_{3};N)},
\left(\frac{\chi_{i,j+1}}{\chi_{i+1,j}}\right)^{2} = \frac{\omega_{+}(q^{2(N-i-1)}c_{2}c_{3}c_{4}/c_{1})}{\omega_{+}(q^{2j}c_{3}c_{0}c_{4}/c_{1})} \frac{\omega_{-}(q^{2j+2}c_{3}c_{0}c_{4}/c_{1})}{\omega_{-}(q^{2(N-i)}c_{2}c_{3}c_{4}/c_{1})} \frac{A_{j+1,N-i}^{+,+}(c_{1},c_{0},c_{4},c_{3};N)}{A_{j,N-i-1}^{-,+}(c_{1},c_{0},c_{4},c_{3};N)}.$$
(5.41)

From the calculations done for Tratnik polynomials, one knows that in (5.40), the second line is a consequence of the first line. Similarly, the last two lines of (5.41) are a consequence of the first two ones. However, the equations (5.40) and (5.41) are inconsistent. For instance, the ratio of both expressions of $\left(\frac{\chi_{i,j+1}}{\chi_{i,j}}\right)^2$ given in (5.40) and (5.41) is equal to

$$\frac{q^{2j-2N-1}}{c_1c_2c_3} \neq 1. (5.42)$$

Thus, the Griffiths polynomials cannot be orthogonal. Note that in the limit $c_i \mapsto q^{c_i}$, $q \to 1$, the expressions become consistent, in accordance with the orthogonality property of the Griffiths polynomials of Racah type [13].

6 Outlook

This paper is devoted to the introduction and the study of new bivariate polynomials, the Griffiths polynomials of q-Racah type. From these polynomials, one could perform various limits, so as to get bivariate functions involving other polynomials such as the q-Hahn or the q-Krawtchouk polynomials. These limits could have interesting uses; for example, the bivariate Tratnik polynomials of

q-Krawtchouk type appear naturally in the study of q-rotations [30] and in the representation theory of $SU_q(3)$ [5] and hence the obtained polynomials may generalize these results.

The orthogonality property of these polynomials also deserves some studies. Unlike the Griffiths polynomials of Racah type, which are orthogonal, the polynomials introduced in this paper are biorthogonal. Clearly, some restriction on the parameter space can lead to orthogonal polynomials. However, it could be that other constructions lead to truly orthogonal polynomials; these polynomials would potentially possess a higher number of parameters. In that case, it is likely that the underlying algebraic structure would be different from the Askey–Wilson algebra $\mathbf{aw}(4)$. The existence of this new algebra remains to be elucidated.

A natural generalization of the results obtained here would be to consider multivariate polynomials in more than two variables. These n variable polynomials would be a generalization of the n variable Tratnik polynomials introduced and studied in [28, 40]. Their bispectral property should provide a representation of the higher rank Askey–Wilson algebra $\mathbf{aw}(n+2)$ which has been defined in [14]. It would also be interesting to study the representation theory of this algebra on its own to obtain results on these polynomials as a byproduct.

The Leonard theorem has initially been proved in order to try to classify the so-called P- and Q-polynomial schemes or distance regular graph (see [48, 2]). These different notions have been generalized recently in [6, 3, 7]. It would be interesting to generalize the Leonard theorem to the multivariate case and to obtain a classification of bispectral multivariate polynomials.

A Basic hypergeometric functions

The basic hypergeometric functions, or q-hypergeometric functions, are defined by the following series, for r and s nonnegative integers:

$${}_{r}\phi_{s}\left(\begin{array}{c}a_{1},\ a_{2},\ \ldots,\ a_{r}\\b_{1},\ b_{2},\ldots,\ b_{s}\end{array}\middle|q;z\right) = \sum_{k=0}^{+\infty} \frac{(a_{1},a_{2},\ldots,a_{r};q)_{k}}{(b_{1},b_{2},\ldots,b_{s};q)_{k}}(-1)^{(1+s-r)k}q^{(1+s-r)\binom{k}{2}}\frac{z^{k}}{(q;q)_{k}},\tag{A.1}$$

where

$$(a_1, a_2, \dots, a_r; q)_k = (a_1; q)_k (a_2; q)_k \dots (a_r; q)_k,$$
 (A.2)

and the q-Pochhammer symbol $(a;q)_n$ is defined as

$$(a;q)_0 = 1,$$
 $(a;q)_k = \prod_{\ell=0}^{k-1} (1 - aq^{\ell}), \quad k = 1, 2, 3, \dots$ (A.3)

The q-Pochhammer symbol satisfies the following transformation formula:

$$\left(\frac{1}{a};q\right)_n = \left(-\frac{1}{a}\right)^n q^{\binom{n}{2}} \left(a \, q^{-n+1};q\right)_n. \tag{A.4}$$

When $a_1 = q^{-n}$ for some nonnegative integer n, the series in (A.1) truncates and becomes a sum over k from 0 to n. Let us emphasize that the q-hypergeometric functions are invariant under any permutation either of its parameters a_1, a_2, \ldots, a_r or of its parameters b_1, b_2, \ldots, b_s . It also satisfies

$${}_{4}\phi_{3}\left(\begin{matrix}q^{n}, a_{2}, a_{3}, a_{4} \\ b_{1}, b_{2}, b_{3}\end{matrix}\middle|q^{-1}; q^{-1}\right) = {}_{4}\phi_{3}\left(\begin{matrix}q^{-n}, a_{2}^{-1}, a_{3}^{-1}, a_{4}^{-1} \\ b_{1}^{-1}, b_{2}^{-1}, b_{3}^{-1}\end{matrix}\middle|q; \frac{q^{n}a_{2}a_{3}a_{4}}{b_{1}b_{2}b_{3}}\right). \tag{A.5}$$

The q-analogue of the binomial coefficient is defined as follows, for $0 \le n \le N$:

$${N \brack n}_q = \frac{(q;q)_N}{(q;q)_n (q;q)_{N-n}} .$$
 (A.6)

By convention, the q-binomial coefficient vanishes for n < 0 or n > N.

Limit $q \to 1$.

In the limit $q \to 1$, the q-generalized hypergeometric function ${}_4\phi_3\left(\begin{array}{c} q^{-n},\ q^{a_2},\ q^{a_3},\ q^{a_4} \\ q^{b_1},\ q^{b_2},\ q^{b_3} \end{array} \middle| q;q \right)$ tends to the generalized hypergeometric function ${}_4F_3\left(\begin{array}{c} -n,\ a_2,\ a_3,\ a_4 \\ b_1,\ b_2,\ b_3 \end{array} \middle| 1 \right)$ and the renormalized q-Pochhammer symbol tends to the Pochhammer symbol:

$$\lim_{q \to 1} \frac{(q^a; q)_k}{(q; q)_k} = \prod_{n=0}^{k-1} (a+n) = (a)_k.$$
(A.7)

B Representations of the Askey–Wilson algebra aw(3)

In [65], it has been shown that the operators defined by the bispectral property of the q-Racah polynomials satisfy an algebra, called the Askey-Wilson algebra. The Askey-Wilson algebra has subsequently found applications in various domains: association schemes [48, 2, 59], Leonard pairs [60, 58], Kauffman bracket skein algebras [10, 9], the centralizer of $U_q(sl_2)$ in tensor products of any three possibly different spin representations [18, 16] and symmetry of physical models [43, 52, 31]. In addition, its representation theory has been studied in [39]. For more details about the Askey-Wilson algebra $\mathbf{aw}(3)$, we refer to the review [11].

B.1 Defining relations for aw(3)

We first provide the defining relations satisfied by the $\mathbf{aw}(3)$ algebra. We then exhibit a particular symmetry under which these relations are unchanged and which we will use to obtain multiple representations in the next subsection.

Definition B.1. The Askey-Wilson algebra $\mathbf{aw}(3)$ is an unital algebra generated by C_{12} , C_{23} and C_{13} , with four central charges C_1 , C_2 , C_3 and C_{123} and a parameter Q. The generators obey the following three relations:

$$\frac{1}{Q^2 - Q^{-2}} [C_{12}, C_{23}]_Q = -C_{13} + \frac{1}{Q + Q^{-1}} (C_3 C_1 + C_2 C_{123}),$$
(B.1a)

$$\frac{1}{Q^2 - Q^{-2}} [C_{23}, C_{13}]_Q = -C_{12} + \frac{1}{Q + Q^{-1}} (C_1 C_2 + C_3 C_{123}),$$
(B.1b)

$$\frac{1}{Q^2 - Q^{-2}} [C_{13}, C_{12}]_Q = -C_{23} + \frac{1}{Q + Q^{-1}} (C_2 C_3 + C_1 C_{123}),$$
(B.1c)

where $[X, Y]_{Q} = QXY - Q^{-1}YX$.

Remark B.2. The Askey-Wilson algebra $\mathbf{aw}(3)$ has a \mathbb{Z}_3 symmetry. In particular, the relations of the Askey-Wilson algebra $\mathbf{aw}(3)$ are unchanged under the following cyclical permutations of the generators:

$$C_1 \mapsto C_2$$
, $C_{12} \mapsto C_{23}$, $\sigma : C_2 \mapsto C_3$, $C_{123} \mapsto C_{123}$, $C_{23} \mapsto C_{13}$, $C_{13} \mapsto C_{12}$. (B.2)

It is immediate to see that $\sigma^3 = 1$.

B.2 Representations of the algebra aw(3)

We now provide (N+1)-dimensional representations of the Askey–Wilson algebra. Define the functions ξ and ω as

$$\xi_n(c_1, c_2) = \frac{(qc_1; q)_n}{(qc_2; q)_n} \left(\frac{c_2}{c_1}\right)^{n/2} \quad \text{and} \quad \omega_n(c) = (-1)^n c^{n/2} q^{\binom{n+1}{2}}, \tag{B.3}$$

and let \mathbb{I} denote the identity matrix of dimension N+1.

The \mathcal{A} matrices. Introduce the $(N+1) \times (N+1)$ -dimensional matrices \mathcal{A}_{12} , \mathcal{A}_{23} and \mathcal{A}_{13} . Their non-vanishing entries are given as follows, for $0 \le i \le N$:

$$(\mathcal{A}_{12})_{i,i} = \lambda(i; c_1 c_2) , (\mathcal{A}_{23})_{i-\varepsilon,i} = \Phi^{\varepsilon}(i; c_3, c_2, c_1; N) , (\mathcal{A}_{13})_{i-\varepsilon,i} = \frac{\xi_{i-\varepsilon}(c_2, c_1)\omega_{i-\varepsilon}(c_2 c_1)}{\xi_i(c_2, c_1)\omega_i(c_2 c_1)} \Phi^{\varepsilon}(i; c_3, c_1, c_2; N) ,$$
(B.4)

In the above and hereinafter, by convention the entries (-1,i) and (N+1,i) of any of the $(N+1) \times (N+1)$ -dimensional matrices are null, e.g. $(\mathcal{A}_{12})_{-1,0} = (\mathcal{A}_{13})_{N+1,N} = 0$. The matrix \mathcal{A}_{12} is diagonal and both the matrices \mathcal{A}_{23} and \mathcal{A}_{13} are tridiagonal matrices.

One observes that the matrices \mathcal{A}_{12} and \mathcal{A}_{23} encode respectively the recurrence (2.11) and difference (2.15) relations of the q-Racah polynomials, in other words their bispectral property. It is a standard result that the algebraic relations between the matrices that encode the bispectral property of the q-Racah polynomials are those of the Askey-Wilson algebra [65]. The explicit correspondence with the relations (B.1) will be given in the later Proposition (B.3).

The \mathcal{B} matrices. The $(N+1) \times (N+1)$ -dimensional matrices \mathcal{B}_{12} , \mathcal{B}_{23} and \mathcal{B}_{13} , have the following non-vanishing entries, for $0 \le i \le N$:

$$(\mathcal{B}_{23})_{i,i} = \lambda(i; c_2 c_3),
(\mathcal{B}_{13})_{i-\varepsilon,i} = \Phi^{\varepsilon}(i; c_1, c_3, c_2; N),
(\mathcal{B}_{12})_{i-\varepsilon,i} = \frac{\xi_{i-\varepsilon}(c_3, c_2)\omega_{i-\varepsilon}(c_3 c_2)}{\xi_i(c_3, c_2)\omega_i(c_3 c_2)} \Phi^{\varepsilon}(i; c_1, c_2, c_3; N),
(B.5)$$

with the functions ξ and ω defined in (B.3).

The C matrices. The $(N+1) \times (N+1)$ -dimensional matrices C_{12} , C_{23} and C_{13} , have the following non-vanishing entries, for $0 \le i \le N$:

$$(C_{13})_{i,i} = \lambda(i; c_1 c_3),
(C_{12})_{i-\varepsilon,i} = \Phi^{\varepsilon}(i; c_2, c_1, c_3; N),
(C_{23})_{i-\varepsilon,i} = \frac{\xi_{i-\varepsilon}(c_1, c_3)\omega_{i-\varepsilon}(c_1 c_3)}{\xi_i(c_1, c_3)\omega_i(c_1 c_3)} \Phi^{\varepsilon}(i; c_2, c_3, c_1; N),
(B.6)$$

with the functions ξ and ω defined in (B.3).

Proposition B.3. Each set of A, B and C matrices provides (N+1)-dimensional representations of the Askey-Wilson algebra $\mathbf{aw}(3)$. Concretely, when the parameter Q of $\mathbf{aw}(3)$ is equal to \sqrt{q} , the following map is an algebra homomorphism:

$$C_{i} \mapsto (\sqrt{c_{i}} + \frac{1}{\sqrt{c_{i}}})\mathbb{I}, \qquad for \ i = 1, 2, 3,$$

$$C_{ij} \mapsto \frac{1}{\sqrt{qc_{i}c_{j}}}\mathcal{X}_{ij} + (\sqrt{qc_{i}c_{j}} + \frac{1}{\sqrt{qc_{i}c_{j}}})\mathbb{I}, \qquad for \ ij = 12, 23, 13,$$

$$C_{123} \mapsto (\sqrt{q^{2N+2}c_{1}c_{2}c_{3}} + \frac{1}{\sqrt{q^{2N+2}c_{1}c_{2}c_{3}}})\mathbb{I}.$$
(B.7)


In the above, \mathcal{X} is chosen as either \mathcal{A} , \mathcal{B} , or \mathcal{C} . We will refer to these three representations as the \mathcal{A} , \mathcal{B} , and \mathcal{C} representations.

Proof. The algebraic relations can be checked by explicit matrix computations or using symbolic manipulation software such as Mathematica or Maple. \Box

Due to the constraints (2.13), (2.14) and (2.16), the above three representations \mathcal{A} , \mathcal{B} , \mathcal{C} are irreducible. Indeed, remarking that the spectrum of \mathcal{A}_{12} is simple and that \mathcal{A}_{23} is a tridiagonal matrix where no off-diagonal entry vanishes allow to prove that the representation is irreducible. The result on \mathcal{B} and \mathcal{C} then follows immediately by symmetry.

As is well-known, the previous properties show that (A_{12}, A_{23}) is a realization of a Leonard pair [58]. Let us mention that the constraints (2.13), (2.14) and (2.16) are necessary in order to get a Leonard pair, due to the irreducibility condition entering the definition of Leonard pairs.

Remark B.4. The three representations in the above proposition are related to one another through the \mathbb{Z}_3 symmetry described above. This can be presented as the following diagram:



Each vertex corresponds to one of the representations, obtained by the set of matrices \mathcal{A} , \mathcal{B} , \mathcal{C} . The generator C_I , I=12,23,13 shown next to each vertex indicates which of the three generators takes a diagonal form in that particular representation. The arrows indicate that the representations are related to one another through the action of the \mathbb{Z}_3 symmetry, denoted by σ .

More precisely, we see from Remark B.2 and the representation homomorphism in (B.7) that the action of σ on the representations corresponds to permuting the generators $\{C_{12}, C_{23}, C_{13}\}$ and the parameters $\{c_1, c_2, c_3\}$ cyclically. Starting from the expressions for the \mathcal{A} matrices (B.4), one obtains the expressions for the \mathcal{B} matrices through that cyclical permutation. Repeating the process, one gets the \mathcal{C} matrices, then the \mathcal{A} matrices, etc.

A natural question to ask is whether this algebra automorphism is an *outer* or an *inner* automorphism. The answer is that it is an *inner automorphism*. The three representations \mathcal{A} , \mathcal{B} , \mathcal{C} are actually isomorphic and can be mapped to one another through a change of basis. This will be shown explicitly in the next subsection.

B.3 Equivalence of the three representations $\mathcal{A}, \mathcal{B}, \mathcal{C}$

We begin with a proposition that makes explicit the isomorphism between the $\mathcal{A}, \mathcal{B}, \mathcal{C}$ representations.

Proposition B.5. The three representations of the Askey-Wilson algebra $\mathbf{aw}(3)$ given by the \mathcal{A} , \mathcal{B} , \mathcal{C} sets of matrices (B.7) are equivalent to one another:

$$\mathcal{P}_{AB} \mathcal{B}_I = \mathcal{A}_I \mathcal{P}_{AB}$$
, $\mathcal{P}_{BC} \mathcal{C}_I = \mathcal{B}_I \mathcal{P}_{BC}$, $\mathcal{P}_{CA} \mathcal{A}_I = \mathcal{C}_I \mathcal{P}_{CA}$, $I \in \{12, 23, 13\}$. (B.8)

The explicit expressions of the matrices \mathcal{P}_{AB} , \mathcal{P}_{BC} , \mathcal{P}_{CA} are given in equations (B.9), (B.10) and (B.11) respectively. Their inverses are given in equations (B.12), (B.13) and (B.14).

Proof. We construct the explicit change of basis matrices in order to prove the isomorphism.

Introduce the $(N+1) \times (N+1)$ matrices \mathcal{P}_{AB} , \mathcal{P}_{BC} , \mathcal{P}_{CA} . The entries of these matrices are given by, for $0 \le i, j \le N$:

$$(\mathcal{P}_{AB})_{i,j} = \frac{\xi_j(c_2, c_3)}{\omega_j(c_2 c_3)} \, \mathfrak{p}_i(j; c_3, c_2, c_1; N) \,, \tag{B.9}$$

$$(\mathcal{P}_{\mathcal{BC}})_{i,j} = \frac{\xi_j(c_3, c_1)}{\omega_j(c_3 c_1)} \, \mathfrak{p}_i(j; c_1, c_3, c_2; N) \,, \tag{B.10}$$

$$(\mathcal{P}_{\mathcal{C}\mathcal{A}})_{i,j} = \frac{\xi_j(c_1, c_2)}{\omega_j(c_1 c_2)} \, \mathfrak{p}_i(j; c_2, c_1, c_3; N) \,, \tag{B.11}$$

and the functions ξ and ω have been defined previously in (B.3). These matrices are invertible with their inverses $\mathcal{P}_{\mathcal{B}\mathcal{A}}$, $\mathcal{P}_{\mathcal{C}\mathcal{B}}$, $\mathcal{P}_{\mathcal{A}\mathcal{C}}$ given by, for $0 \leq i, j \leq N$:

$$(\mathcal{P}_{\mathcal{B}_{\mathcal{A}}})_{i,j} = \frac{\omega_i(c_2 c_3)}{\xi_i(c_2, c_3)} \, \mathfrak{p}_i(j; c_1, c_2, c_3; N) \,, \tag{B.12}$$

$$(\mathcal{P}_{CB})_{i,j} = \frac{\omega_i(c_3c_1)}{\xi_i(c_3, c_1)} \, \mathfrak{p}_i(j; c_2, c_3, c_1; N) \,, \tag{B.13}$$

$$(\mathcal{P}_{AC})_{i,j} = \frac{\omega_i(c_1 c_2)}{\xi_i(c_1, c_2)} \, \mathfrak{p}_i(j; c_3, c_1, c_2; N) \,. \tag{B.14}$$

This is easily checked; using the involution relation (2.10), one immediately gets

$$\mathcal{P}_{AB} \mathcal{P}_{BA} = \mathcal{P}_{BC} \mathcal{P}_{CB} = \mathcal{P}_{CA} \mathcal{P}_{AC} = \mathbb{I}. \tag{B.15}$$

We claim that these matrices provide the change of basis between the \mathcal{A} , \mathcal{B} , \mathcal{C} representations, as written in (B.8). Let us first examine the matrix equation $\mathcal{P}_{A\mathcal{B}}\mathcal{B}_I = \mathcal{A}_I\mathcal{P}_{A\mathcal{B}}$. For I = 12, equating the (n,x) component of the r.h.s. and the l.h.s. leads to the difference equation (2.15) with $c_1 \leftrightarrow c_3$. For I = 23, proceeding similarly using the equation $\mathcal{P}_{\mathcal{B}\mathcal{A}}\mathcal{A}_I = \mathcal{B}_I\mathcal{P}_{\mathcal{B}\mathcal{A}}$ and equating the (n,x) component of the r.h.s. and the l.h.s. also leads to the difference equation (2.15). Since the third generator I = 13 is obtained in terms of the first two (see (B.1a)), it follows that $\mathcal{P}_{\mathcal{A}\mathcal{B}}$ is indeed the change of basis matrix between the \mathcal{A} and \mathcal{B} representations introduced above. From the \mathbb{Z}_3 symmetry in Remark B.4, analogous results follow immediately: $\mathcal{P}_{\mathcal{B}\mathcal{C}}$ relates representations \mathcal{B} and \mathcal{C} and $\mathcal{P}_{\mathcal{C}\mathcal{A}}$ relates representations \mathcal{C} and \mathcal{A} . Therefore, equation (B.8) holds, and this completes the proof.

We note that these changes of basis are the key ingredient in the proof of the Racah relation for q-Racah polynomials (4.1).

C Representations of the rank 2 Askey–Wilson algebra aw(4)

The higher rank version of the Askey-Wilson algebra has been introduced and studied in [53, 37, 20, 21, 22, 14, 63]. We recall in this appendix the defining relations of **aw**(4) as presented in [14], up to a renormalization of the generators. Then, we provide representations for this algebra.

C.1 Defining relations for aw(4)

The algebra $\mathbf{aw}(4)$ is generated by C_I where $I \in \{1, 2, 3, 4, 12, 23, 34, 123, 234, 1234\}$. For these connected sequences, the order in I is irrelevant, for example $C_{21} \equiv C_{12}$. Let us now introduce the following set of 3-tuple:

$$S = \{(1,2,3), (2,3,4), (1,23,4), (12,3,4), (1,2,34), (3,2,1), (4,3,2), (4,23,1), (4,3,12), (34,2,1)\}.$$
(C.1)

For $(I, J, K) \in \mathcal{S}$, one defines new elements of the algebra by

$$C_{IK} = -\frac{1}{Q^2 - Q^{-2}} [C_{IJ}, C_{JK}]_Q + \frac{1}{Q + Q^{-1}} (C_I C_K + C_J C_{IJK}).$$
 (C.2)

These relations define C_{13} , C_{24} , C_{14} , C_{124} , C_{134} but also C_{31} , C_{42} , C_{41} , C_{412} , C_{341} . Let us stress that the former are different from the latter.

The defining relations of $\mathbf{aw}(4)$ are:

(i) for $I, J \in \{1, 2, 3, 4, 12, 23, 34, 123, 234, 1234\}$:

$$[C_I, C_J] = 0$$
 if $I \cap J = \emptyset$ or $I \subset J$, (C.3)

(ii) for $(I, J, K) \in \mathcal{S}$:

$$C_{IJ} = -\frac{1}{Q^2 - Q^{-2}} [C_{JK}, C_{IK}]_Q + \frac{1}{Q + Q^{-1}} (C_I C_J + C_K C_{IJK}), \qquad (C.4)$$

and (iii):

$$C_{14} = -\frac{1}{Q^2 - Q^{-2}} [C_{13}, C_{34}]_Q + \frac{1}{Q + Q^{-1}} (C_1 C_4 + C_3 C_{134}), \qquad (C.5)$$

$$C_{41} = -\frac{1}{Q^2 - Q^{-2}} [C_{42}, C_{12}]_Q + \frac{1}{Q + Q^{-1}} (C_1 C_4 + C_2 C_{412}).$$
 (C.6)

Remark C.1. The rank 2 Askey–Wilson algebra $\mathbf{aw}(4)$ has a \mathbb{Z}_5 symmetry. In particular, the relations of the algebra $\mathbf{aw}(4)$ are unchanged under the following cyclical permutations of the generators:

$$C_{1} \mapsto C_{4} , \qquad C_{12} \mapsto C_{123} , \qquad C_{13} \mapsto C_{14} , \qquad C_{31} \mapsto C_{41} ,$$

$$C_{2} \mapsto C_{1234} , \qquad C_{23} \mapsto C_{234} , \qquad C_{24} \mapsto C_{341} , \qquad C_{42} \mapsto C_{134} ,$$

$$\rho : \qquad C_{3} \mapsto C_{1} , \qquad C_{34} \mapsto C_{12} , \qquad C_{412} \mapsto C_{13} , \qquad C_{124} \mapsto C_{31} , \qquad (C.7)$$

$$C_{4} \mapsto C_{2} , \qquad C_{123} \mapsto C_{23} , \qquad C_{14} \mapsto C_{24} , \qquad C_{41} \mapsto C_{42} ,$$

$$C_{1234} \mapsto C_{3} , \qquad C_{234} \mapsto C_{34} , \qquad C_{341} \mapsto C_{412} , \qquad C_{134} \mapsto C_{123} ,$$

and it is immediate to see that $\rho^5 = 1$. Note that the \mathbb{Z}_5 symmetry is just a part of the full braid group symmetry of the $\mathbf{aw}(4)$ algebra. We refer the reader to [14] for more details.

C.2 Representations of the algebra aw(4)

Define $\tilde{N} = \binom{N+2}{2} = \#\{\ (i_1,i_2) \mid i_1,i_2 \in \mathbb{Z}_{\geq 0},\ i_1+i_2 \leq N\ \}$. We will introduce five sets of $\tilde{N} \times \tilde{N}$ matrices, denoted by A, B, C, D, E. Each set of matrices leads to a representation of $\mathbf{aw}(4)$; this will be stated in the next proposition down below.

We also let 1 denote the \tilde{N} -dimensional identity matrix.

The A matrices. Let us introduce five $\tilde{N} \times \tilde{N}$ matrices A_{12} , A_{23} , A_{34} , A_{123} , A_{234} . The entries of the matrices are labeled by two pairs of nonnegative indices (i,j) and (x,y) such that $0 \le i+j \le N$ and $0 \le x+y \le N$. The non-zero entries of the matrices A_I , $I \in \{12, 23, 34, 123, 234\}$ are given by:

$$(\mathsf{A}_{12})_{(i,j);(i,j)} = \lambda(i;c_1c_2)\,,$$

$$(\mathsf{A}_{123})_{(i,j);(i,j)} = \lambda(j;c_4c_0)\,,$$

$$(\mathsf{A}_{34})_{(i,j-\varepsilon);(i,j)} = \Phi^{\varepsilon}(j;c_3,c_4,c_0;N-i)\,,$$

$$(\mathsf{A}_{23})_{(i-\varepsilon',j);(i,j)} = \Phi^{\varepsilon'}(i;c_3,c_2,c_1;N-j)\,\left(\frac{c_3}{c_0}\right)^{\varepsilon'/2} \frac{\xi_i(c_2,c_1)}{\xi_{i-\varepsilon'}(c_2,c_1)}\,,$$

$$(\mathsf{A}_{234})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{i,i}^{\varepsilon,\varepsilon'}(c_3,c_4,c_0,c_2;N)\,,$$

$$(\mathsf{A}_{234})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{i,i}^{\varepsilon,\varepsilon'}(c_3,c_4,c_0,c_2;N)\,,$$

It follows that A_{12} and A_{123} are diagonal matrices, A_{34} and A_{23} are tridiagonal and the matrix A_{234} is nine-diagonal. These matrices provide a representation of the rank 2 Askey–Wilson algebra, as will be stated in a later proposition down below.

The B matrices. The non-zero entries of the matrices B_I , $I \in \{12, 23, 34, 123, 234\}$ are given by:

$$(\mathsf{B}_{123})_{(i,j);(i,j)} = \lambda(i; c_4 c_0) \,, \\ (\mathsf{B}_{23})_{(i,j);(i,j)} = \lambda(j; c_2 c_3) \,, \\ (\mathsf{B}_{12})_{(i,j-\varepsilon);(i,j)} = \Phi^{\varepsilon}(j; c_1, c_2, c_3; N-i) \,, \\ (\mathsf{B}_{234})_{(i-\varepsilon',j);(i,j)} = \Phi^{\varepsilon'}(i; c_1, c_0, c_4; N-j) \, \left(\frac{c_1}{c_3}\right)^{\varepsilon'/2} \frac{\xi_i(c_0, c_4)}{\xi_{i-\varepsilon'}(c_0, c_4)} \,, \\ (\mathsf{B}_{34})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{i,i}^{\varepsilon,\varepsilon'}(c_1, c_2, c_3, c_0; N) \,,$$

$$(\mathsf{B}_{34})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{i,i}^{\varepsilon,\varepsilon'}(c_1, c_2, c_3, c_0; N) \,,$$

The C matrices. The non-zero entries of the matrices C_I , $I \in \{12, 23, 34, 123, 234\}$ are given by:

$$(\mathsf{C}_{23})_{(i,j);(i,j)} = \lambda(i; c_2 c_3) ,$$

$$(\mathsf{C}_{234})_{(i,j);(i,j)} = \lambda(j; c_0 c_1) ,$$

$$(\mathsf{C}_{123})_{(i,j-\varepsilon);(i,j)} = \Phi^{\varepsilon}(j; c_4, c_0, c_1; N-i) ,$$

$$(\mathsf{C}_{34})_{(i-\varepsilon',j);(i,j)} = \Phi^{\varepsilon'}(i; c_4, c_3, c_2; N-j) \left(\frac{c_4}{c_1}\right)^{\varepsilon'/2} \frac{\xi_i(c_3, c_2)}{\xi_{i-\varepsilon'}(c_3, c_2)} ,$$

$$(\mathsf{C}_{12})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_4, c_0, c_1, c_3; N) ,$$

$$(\mathsf{C}_{12})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_4, c_0, c_1, c_3; N) ,$$

The D matrices. The non-zero entries of the matrices D_I , $I \in \{12, 23, 34, 123, 234\}$ are given by:

$$(\mathsf{D}_{234})_{(i,j);(i,j)} = \lambda(i;c_0c_1),$$

$$(\mathsf{D}_{34})_{(i,j);(i,j)} = \lambda(j;c_3c_4),$$

$$(\mathsf{D}_{23})_{(i,j-\varepsilon);(i,j)} = \Phi^{\varepsilon}(j;c_2,c_3,c_4;N-i),$$

$$(\mathsf{D}_{12})_{(i-\varepsilon',j);(i,j)} = \Phi^{\varepsilon'}(i;c_2,c_1,c_0;N-j) \left(\frac{c_2}{c_4}\right)^{\varepsilon'/2} \frac{\xi_i(c_1,c_0)}{\xi_{i-\varepsilon'}(c_1,c_0)},$$

$$(\mathsf{D}_{123})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{i,i}^{\varepsilon,\varepsilon'}(c_2,c_3,c_4,c_1;N),$$

$$(\mathsf{D}_{123})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{i,i}^{\varepsilon,\varepsilon'}(c_2,c_3,c_4,c_1;N),$$

$$(\mathsf{D}_{123})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{i,i}^{\varepsilon,\varepsilon'}(c_2,c_3,c_4,c_1;N),$$

The E matrices. The non-zero entries of the matrices E_I , $I \in \{12, 23, 34, 123, 234\}$ are given by:

$$\begin{aligned} &(\mathsf{E}_{34})_{(i,j);(i,j)} = \lambda(i;c_3c_4)\,, \\ &(\mathsf{E}_{12})_{(i,j);(i,j)} = \lambda(j;c_1c_2)\,, \\ &(\mathsf{E}_{234})_{(i,j-\varepsilon);(i,j)} = \Phi^{\varepsilon}(j;c_0,c_1,c_2;N-i)\,, \\ &(\mathsf{E}_{123})_{(i-\varepsilon',j);(i,j)} = \Phi^{\varepsilon'}(i;c_0,c_4,c_3;N-j) \, \left(\frac{c_0}{c_2}\right)^{\varepsilon'/2} \frac{\xi_i(c_4,c_3)}{\xi_{i-\varepsilon'}(c_4,c_3)}\,, \end{aligned} \qquad \varepsilon,\varepsilon' \in \{0,\pm\}\,.$$
 (C.12)
$$(\mathsf{E}_{23})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_0,c_1,c_2,c_4;N)\,,$$

We now state more precisely how the five sets of matrices A, B, C, D, E lead to representations of $\mathbf{aw}(4)$.

Proposition C.2. When the parameter Q of $\mathbf{aw}(4)$ is equal to \sqrt{q} , each set of A, B, C, D, E matrices provides \tilde{N} -dimensional representations of $\mathbf{aw}(4)$. Recall that the algebra $\mathbf{aw}(4)$ is generated by C_I with $I \in \{1, 2, 3, 4, 12, 23, 34, 123, 234, 1234\}$ with defining relations given in the Appendix C.1. Then,

the following map is an algebra homomorphism:

$$C_{i} \mapsto (\sqrt{c_{i}} + \frac{1}{\sqrt{c_{i}}})\mathbf{1}, \qquad for \quad i = 1, 2, 3, 4,$$

$$C_{ij} \mapsto \frac{1}{\sqrt{qc_{i}c_{j}}}X_{ij} + (\sqrt{qc_{i}c_{j}} + \frac{1}{\sqrt{qc_{i}c_{j}}})\mathbf{1}, \qquad for \quad ij = 12, 23, 34,$$

$$C_{ijk} \mapsto \sqrt{q^{2N+2}c_{i}c_{j}c_{k}}X_{ijk} + (\sqrt{q^{2N+2}c_{i}c_{j}c_{k}} + \frac{1}{\sqrt{q^{2N+2}c_{i}c_{j}c_{k}}})\mathbf{1}, \qquad for \quad ijk = 123, 234,$$


$$C_{1234} \mapsto (\sqrt{c_{0}} + \frac{1}{\sqrt{c_{0}}})\mathbf{1}, \qquad (C.13)$$

where X is chosen as either A, B, C, D or E. We will refer to these five representations as the A, B, C, D and E representations.

Proof. The defining relations of $\mathbf{aw}(4)$ can be verified by explicit matrix computations or using symbolic manipulation software such as Mathematica or Maple.

The conditions (5.5) imply that these representations are irreducible. Indeed, these conditions imply that the couples of eigenvalues $(\lambda(i; c_1c_2), \lambda(j; c_4c_0))$ of the matrices A_{12} and A_{123} , are all different. It allows us to construct projectors on the common eigenvector $v_{i,j}$ corresponding to this couple of eigenvalues. Moreover, due to these conditions, the matrices A_{34} and A_{23} have non-vanishing entries connecting $v_{i,j}$ to $v_{i,j\pm 1}$ and $v_{i\pm 1,j}$ respectively. Hence, through iteration, we can connect any vector $v_{i,j}$ to any other vector $v_{k,l}$. This concludes the proof of irreducibility for the representation associated to A matrices. The proof of irreducibility for the other representations follows the same lines.

Remark C.3. The five representations in the above proposition are related to one another through the \mathbb{Z}_5 symmetry described above. This can be presented as the following diagram:



Each vertex corresponds to one of the representations, obtained by the set of matrices A, B, C, D, E. The two generators C_I , $I \in \{12, 23, 34, 123, 234\}$ shown next to each vertex indicate which two of the five generators take a diagonal form in that particular representation. The arrows indicate that the representations are related to one another through the action of the \mathbb{Z}_5 symmetry, denoted by ρ .

More precisely, we see from Remark C.1 and the representation homomorphism in (C.13) that the action of ρ on the representations corresponds to permuting the generators $\{C_{12}, C_{123}, C_{23}, C_{234}, C_{34}\}$ and the parameters $\{c_1, c_4, c_2, c_0, c_3\}$ cyclically. Starting from the expressions for the A matrices (B.4), one obtains the expressions for the B matrices through that cyclical permutation. Repeating the process, one gets the C matrices, then the D matrices, the E matrices, the A matrices, etc.

Again, it is natural to ask whether this algebra automorphism is an *outer* or an *inner* automorphism. The answer here is again that it is an *inner automorphism*. The five representations A, B, C, D, E are actually isomorphic and can be mapped to one another through a change of basis. This will be shown explicitly in the next subsection.

For completeness, we now provide the expressions for other generators of the $\mathbf{aw}(4)$ algebra in the A representation below. The following are tridiagonal matrices:

$$(\mathsf{A}_{13})_{(i-\varepsilon',j);(i,j)} = \Phi^{\varepsilon'}(i;c_3,c_1,c_2;N-j) \left(\frac{c_3}{c_0}\right)^{\varepsilon'/2} \frac{\omega_{i-\varepsilon'}(c_2c_1)}{\omega_i(c_2c_1)},$$

$$(\mathsf{A}_{124})_{(i,j-\varepsilon);(i,j)} = \Phi^{\varepsilon}(j;c_3,c_0,c_4;N-i) \frac{\xi_{j-\varepsilon}(c_4,c_0)\omega_{j-\varepsilon}(c_4c_0)}{\xi_j(c_4,c_0)\omega_j(c_4c_0)},$$

$$(\mathsf{A}_{412})_{(i,j-\varepsilon);(i,j)} = \Phi^{\varepsilon}(j;c_3,c_0,c_4;N-i) \frac{\xi_j(c_0,c_4)\omega_j(c_0c_4)}{\xi_{j-\varepsilon}(c_0,c_4)\omega_{j-\varepsilon}(c_0c_4)},$$

and the following are nine-diagonal matrices:

$$(\mathsf{A}_{24})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_3,c_0,c_4,c_1;N) \frac{\xi_{j-\varepsilon}(c_4,c_0)\omega_{j-\varepsilon}(c_4c_0)}{\xi_{j}(c_4,c_0)\omega_{j}(c_4c_0)} \left(\frac{c_4}{c_0}\right)^{\varepsilon'/2} \frac{\xi_{i}(c_2,c_1)\omega_{i}(c_2c_1)}{\xi_{i-\varepsilon'}(c_2,c_1)\omega_{i-\varepsilon'}(c_2c_1)},$$

$$(\mathsf{A}_{42})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_3,c_0,c_4,c_1;N) \frac{\xi_{j}(c_0,c_4)\omega_{j}(c_0c_4)}{\xi_{j-\varepsilon}(c_0,c_4)\omega_{j-\varepsilon}(c_0c_4)} \left(\frac{c_4}{c_0}\right)^{\varepsilon'/2} \frac{\xi_{i-\varepsilon'}(c_1,c_2)\omega_{i-\varepsilon'}(c_1c_2)}{\xi_{i}(c_1,c_2)\omega_{i}(c_1c_2)},$$

$$(\mathsf{A}_{14})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_3,c_0,c_4,c_2;N) \frac{\xi_{j-\varepsilon}(c_4,c_0)\omega_{j-\varepsilon}(c_4c_0)}{\xi_{j}(c_4,c_0)\omega_{j}(c_4c_0)} \left(\frac{c_4}{c_0}\right)^{\varepsilon'/2},$$

$$(\mathsf{A}_{41})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_3,c_0,c_4,c_2;N) \frac{\xi_{j}(c_0,c_4)\omega_{j}(c_0c_4)}{\xi_{j-\varepsilon}(c_0,c_4)\omega_{j-\varepsilon}(c_0c_4)} \left(\frac{c_4}{c_0}\right)^{\varepsilon'/2},$$

$$(\mathsf{A}_{134})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_3,c_4,c_0,c_1;N) \frac{\xi_{i-\varepsilon'}(c_1,c_2)\omega_{i-\varepsilon'}(c_1c_2)}{\xi_{i}(c_1,c_2)\omega_{i}(c_1c_2)},$$

$$(\mathsf{A}_{341})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_3,c_4,c_0,c_1;N) \frac{\xi_{i-\varepsilon'}(c_1,c_2)\omega_{i-\varepsilon'}(c_1c_2)}{\xi_{i}(c_1,c_2)\omega_{i}(c_1c_2)},$$

$$(\mathsf{A}_{341})_{(i-\varepsilon',j-\varepsilon);(i,j)} = A_{j,i}^{\varepsilon,\varepsilon'}(c_3,c_4,c_0,c_1;N) \frac{\xi_{i-\varepsilon'}(c_2,c_1)\omega_{i-\varepsilon'}(c_2c_1)}{\xi_{i-\varepsilon'}(c_2,c_1)\omega_{i-\varepsilon'}(c_2c_1)},$$

with $\varepsilon, \varepsilon' \in \{0, \pm\}$. The expressions for the matrices in the other bases B, C, D, E are directly obtained from those in the A basis by making use of the \mathbb{Z}_5 symmetry, see remark C.3.

For the five representations given in the above proposition, the generators associated to non-connected sequences (see the definition in Section C.1) are then given as follows, with $X \in \{A, B, C, D, E\}$:

$$C_{ij} \mapsto \frac{1}{\sqrt{qc_ic_j}} \mathsf{X}_{ij} + (\sqrt{qc_ic_j} + \frac{1}{\sqrt{qc_ic_j}}) \mathbf{1}, \qquad \text{for } ij = 13, 24, 14, 31, 42, 41,$$

$$C_{ijk} \mapsto \sqrt{q^{2N+2}c_ic_jc_k} \, \mathsf{X}_{ijk} + (\sqrt{q^{2N+2}c_ic_jc_k} + \frac{1}{\sqrt{q^{2N+2}c_ic_jc_k}}) \mathbf{1}, \qquad \text{for } ijk = 124, 134, 412, 341.$$

$$(C.16)$$

Once again, the algebraic relations can be verified by explicit matrix computations or using symbolic manipulation software such as Mathematica or Maple.

C.3 Equivalence of the five representations A, B, C, D, E

We begin with a proposition that makes the isomorphism between the A, B, C, D, E representations explicit.

Proposition C.4. The five representations of the rank 2 Askey-Wilson algebra $\mathbf{aw}(4)$ given by the A, B, C, D, E matrices are equivalent to one another:

$$P_{AB} B_{I} = A_{I} P_{AB}, \qquad P_{BC} C_{I} = B_{I} P_{BC}, \qquad P_{CD} D_{I} = C_{I} P_{CD}, P_{DE} E_{I} = D_{I} P_{DE}, \qquad P_{EA} A_{I} = E_{I} P_{EA}, \qquad I \in \{12, 23, 34, 123, 234\}.$$
(C.17)

The explicit expressions of the change of basis matrices P_{AB} , P_{BC} , P_{CD} , P_{DE} , P_{EF} and their inverses are given in the proof below.

Proof. We construct the explicit change of basis matrices in order to prove the isomorphism.

Introduce the $\widetilde{N} \times \widetilde{N}$ matrices P_{AB} , P_{BC} , P_{CD} , P_{DE} , P_{EF} . The entries of these matrices are given as follows, for $0 \le i_1 + i_2 \le N$ and $0 \le j_1 + j_2 \le N$:

$$(\mathsf{P}_{\mathsf{AB}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_2,j_1} \left(\frac{c_0}{c_3}\right)^{i_1/2} \xi_{i_1}(c_1,c_2) \, \mathfrak{p}_{i_1}(j_2;c_3,c_2,c_1;N-i_2) \,, \tag{C.18}$$

$$(\mathsf{P}_{\mathsf{BC}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_2,j_1} \left(\frac{c_3}{c_1}\right)^{i_1/2} \xi_{i_1}(c_4,c_0) \, \mathfrak{p}_{i_1}(j_2;c_1,c_0,c_4;N-i_2) \,, \tag{C.19}$$

$$(\mathsf{P}_{\mathsf{CD}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_2,j_1} \left(\frac{c_1}{c_4}\right)^{i_1/2} \xi_{i_1}(c_2,c_3) \, \mathfrak{p}_{i_1}(j_2;c_4,c_3,c_2;N-i_2) \,, \tag{C.20}$$

$$(\mathsf{P}_{\mathsf{DE}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_2,j_1} \left(\frac{c_4}{c_2}\right)^{i_1/2} \xi_{i_1}(c_0,c_1) \, \mathfrak{p}_{i_1}(j_2;c_2,c_1,c_0;N-i_2) \,, \tag{C.21}$$

$$(\mathsf{P}_{\mathsf{EA}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_2,j_1} \left(\frac{c_2}{c_0}\right)^{i_1/2} \xi_{i_1}(c_3,c_4) \, \mathfrak{p}_{i_1}(j_2;c_0,c_4,c_3;N-i_2) \,, \tag{C.22}$$

and the function ξ has been defined previously in (B.3). The inverses of the above matrices, namely P_{BA} , P_{CB} , P_{DC} , P_{ED} , P_{AE} , have entries given as follows, for $0 \le i_1 + i_2 \le N$ and $0 \le j_1 + j_2 \le N$:

$$(\mathsf{P}_{\mathsf{BA}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_1,j_2} \left(\frac{c_3}{c_0}\right)^{j_1/2} \xi_{j_1}(c_2,c_1) \,\,\mathfrak{p}_{i_2}(j_1;c_1,c_2,c_3;N-j_2) \,, \tag{C.23}$$

$$(\mathsf{P}_{\mathsf{CB}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_1,j_2} \left(\frac{c_1}{c_3} \right)^{j_1/2} \xi_{j_1}(c_0,c_4) \, \mathfrak{p}_{i_2}(j_1;c_4,c_0,c_1;N-j_2) \,, \tag{C.24}$$

$$(\mathsf{P}_{\mathsf{DC}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_1,j_2} \left(\frac{c_4}{c_1}\right)^{j_1/2} \xi_{j_1}(c_3,c_2) \, \mathfrak{p}_{i_2}(j_1;c_2,c_3,c_4;N-j_2) \,, \tag{C.25}$$

$$(\mathsf{P}_{\mathsf{ED}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_1,j_2} \left(\frac{c_2}{c_4}\right)^{j_1/2} \xi_{j_1}(c_1,c_0) \, \mathfrak{p}_{i_2}(j_1;c_0,c_1,c_2;N-j_2) \,, \tag{C.26}$$

$$(\mathsf{P}_{\mathsf{AE}})_{(i_1,i_2);(j_1,j_2)} = \delta_{i_1,j_2} \left(\frac{c_0}{c_2}\right)^{j_1/2} \xi_{j_1}(c_4,c_3) \, \mathfrak{p}_{i_2}(j_1;c_3,c_4,c_0;N-j_2) \,. \tag{C.27}$$

This is easily checked; using the involution relation (2.10), one gets

$$P_{AB} P_{BA} = P_{BC} P_{CB} = P_{CD} P_{DC} = P_{DE} P_{ED} = P_{EA} P_{AE} = 1.$$
 (C.28)

We claim that these matrices provide the change of basis between the A, B, C, D, E representations as written in (C.17).

First examine the change of basis between the A and B bases.

For I=123, look at the change of basis equation (C.17) $A_{123} P_{AB} = P_{AB} B_{123}$. The entries in the l.h.s. and r.h.s. are identical so the equation is satisfied.

For I=12, again look at the components of the equation $\mathsf{A}_{123}\,\mathsf{P}_{\mathsf{AB}}=\mathsf{P}_{\mathsf{AB}}\,\mathsf{B}_{123}$. Equating the (n,k);(k,x) component of the l.h.s. and r.h.s. leads to the difference equation (2.15) with $c_1\leftrightarrow c_3$ and $N\mapsto N-k$ (for $0\le n,x\le N-k$) hence this equation holds.

Similarly, for I=23, rewrite the change of basis equation (C.17) as $\mathsf{B}_{23}\,\mathsf{P}_{\mathsf{BA}}=\mathsf{P}_{\mathsf{BA}}\,\mathsf{A}_{23}$. Equating the (k,n);(x,k) component of the l.h.s. and r.h.s. leads to the difference equation (2.15) with $N\mapsto N-k$ (for $0\leq n,x\leq N-k$) hence this equation also holds.

For I=34, rewrite the change of basis equation (C.17) as A_{34} $P_{AB}=P_{AB}$ B_{34} . Upon comparing the (n,k); (k,x) components of the l.h.s. and the r.h.s. one checks that they are indeed equal by virtue of the difference equation (2.15). Simultaneously, comparing the $(n,k-\varepsilon)$; (k,x) components of the l.h.s. and the r.h.s. for $\varepsilon=\pm$, one confirms that they are equal by virtue of the contiguity difference equations (2.22) involving λ_{ε} respectively. Thus, the equation also holds in this case.

Finally, an analysis along the same lines as what was done for I=34 can be repeated for I=234. Rewriting the change of basis equation (C.17) as $\mathsf{B}_{234}\,\mathsf{P}_{\mathsf{BA}}=\mathsf{P}_{\mathsf{BA}}\,\mathsf{A}_{234}$, one finds that this equation also holds.

With this, we have proven the validity of the change of basis between the A and B bases. The remaining changes of basis follow immediately by the \mathbb{Z}_5 symmetry.

Again let us remark that these changes of basis are the key ingredient in the proof of the Biedenharn–Elliot relation for q-Racah polynomials (4.6).
