# NUMERICAL SEMIGROUPS OF COATED ODD ELEMENTS

ABSTRACT. A numerical semigroup S is coated with odd elements (Coesemigroup), if  $\{x - 1, x + 1\} \subseteq S$  for all odd element x in S. In this note, we will study this kind of numerical semigroups. In particular, we are interested in the study of the Frobenius number, gender and embedding dimension of a numerical semigroup of this type.

# 1. INTRODUCTION

Let  $\mathbb{Z}$  be the set of integers an let  $\mathbb{N} = \{z \in \mathbb{Z} \mid z \ge 0\}$ . A submonoid of  $(\mathbb{N}, +)$  is a subset of  $\mathbb{N}$  closed under addition, containing the zero element. A submonoid with finite complement in  $\mathbb{N}$  is a numerical semigroup.

A numerical semigroup, S, is coated with odd elements, if  $\{x - 1, x + 1\} \subseteq S$  for all odd element x in S. Henceforth known as **Coe-semigroup**, which will be the object of study in this work.

If S is a numerical semigroup, then  $m(S) = \min(S \setminus \{0\})$ ,  $F(S) = \max(\mathbb{Z} \setminus S)$  and g(S) the cardinalty of  $\mathbb{N} \setminus S$  are three importants invariants of S known as **multiplicity**, **Frobenius number** and **gender** of S, respectively.

If  $\mathcal{A}$  is a nonempty subset of  $\mathbb{N}$ , we denote by  $\langle \mathcal{A} \rangle$  the submonoid of  $(\mathbb{N}, +)$  generated by  $\mathcal{A}$ , that is,

$$\langle \mathcal{A} \rangle = \left\{ \sum_{i=1}^{n} \lambda_{i} \, a_{i} \mid n \in \mathbb{N} \setminus \{0\}, \ a_{i} \in \mathcal{A}, \ \lambda_{i} \in \mathbb{N} \text{ for all } i \in \{1, \dots, n\} \right\}.$$

In [9, Lemma 2.1], we can see that  $\langle \mathcal{A} \rangle$  is a numerical semigroup if and only if  $gcd(\mathcal{A}) = 1$ .

If M is a submonoid of  $(\mathbb{N}, +)$  and  $M = \langle \mathcal{A} \rangle$  then we say that  $\mathcal{A}$  is a system of generators of M. Moreover, if  $M \neq \langle \mathcal{B} \rangle$  for all  $\mathcal{B} \subsetneq \mathcal{A}$ , then we say that  $\mathcal{A}$  is a minimal system of generators of S. In [9, Corollary 2.8], we see that, every submonoid of  $(\mathbb{N}, +)$  admits an unique minimal system

of generators, which is finite. We denote by msg(M) the minimal system of generators of M and its elements are called minimal generators. The cardinality of msg(M) is called the embedding dimension of M and it is denoted by e(M).

The Frobenius problem (see [6]) consists of finding formulas for the Frobenius number and the gender of a numerical semigroup in terms of its minimal system of generators. This problem was solved in [11], for numerical semigroups with embedding dimension two. At present, this problem is open for embedding dimension greater than or equal to three.

In [12] Wilf conjectured that if S is a numerical semigroup then  $e(S)g(S) \leq (e(S) - 1)(F(S) + 1)$ . This question is still widely open and it is one of the most important problems in numerical semigroups theory. A very good source of the state of the art of this problem is [3].

Denote by  $\mathscr{C} = \{S \mid S \text{ is an Coe-semigroup}\}$ . In Section 2, we will show that, if  $S \in \mathscr{C}$  then  $S \cup \{F(S), F(S) - 1\} \in \mathscr{C}$ . This result will be used in Section 3, to order the elements of  $\mathscr{C}$  in a rooted tree. We will characterize the sons of a vertex in this tree and this will allow us to give an algorithm procedure to obtain recursively the elements of  $\mathscr{C}$ .

In Section 4, we will see that given k an odd positive integer, then  $\mathscr{C}(k) = \{S \mid S \text{ is an Coe-semigroup and } k \in S\}$  is a finite set. Moreover, given p a positive integer,  $\mathscr{C}(Frob \leq p) = \{S \mid S \text{ is an Coe-semigroup with } F(S) \leq p\}$  and  $\mathscr{C}(gen \leq p) = \{S \mid S \text{ is an Coe-semigroup with } g(S) \leq p\}$  are also finite sets. Following the same line of previous section, we are going to order these three families of semigroups in a rooted tree.

An Coe-monoid is a submonoid of  $(\mathbb{N}, +)$  which can be expressed as intersection of Coe-semigroups. It is clear that, the intersection of Coe-monoids is an Coe-monoid. This allows us to introduce the smallest Coe-monoid containing a subset X of N, denoted by Coe(X). In Section 5, we will show that a submonoid M of  $(\mathbb{N}, +)$  is an Coe-monoid if and only if either  $M \subseteq \{2k \mid k \in \mathbb{N}\}$  or M is an Coe-semigroup. We will give an algorithm to compute Coe(X) and will see that Coe(X) is an Coe-semigroup if and only if X contains at least an odd element.

In [9, Proposition 2.10], it is shown that if S is a numerical semigroup, then  $e(S) \leq m(S)$ . We say that S has maximal embedding dimension (MEDsemigroup) if e(S) = m(S). This class of numerical semigroups has been well studied in the semigroup literature (see for instance [2]). In Section 6, we will study the Coe-semigroups which are MED-semigroups.

Finally, in Section 7, we will study the Coe-semigroups with an unique odd minimal generator. We will show that this kind of numerical semigroups are equal to the set  $\{T \mid T = 2S \cup (\{2s + 1\} + 2S), S \text{ is a numerical semigroup and } \{s, s + 1\} \subseteq S\}$ . We will give formulas for F(T), g(T) and e(T) as a function of F(S), g(S) and e(S). From these results, we will prove that if S verifies the Wilf's conjecture, then T

also verifies the same conjecture. In addition, we will solve the Frobenius problem for Coe-semigroups with embedding dimension three.

## 2. First results

Note that  $\mathbb{N}$  is an Coe-semigroup with  $m(\mathbb{N}) = 1$  and  $F(\mathbb{N}) = -1$ . Hence, if S is a numerical semigroup and  $S \neq \mathbb{N}$ , then we let us consider that  $m(S) \in \mathbb{N} \setminus \{0, 1\}$  and  $F(S) \in \mathbb{N} \setminus \{0\}$ .

**Proposition 1.** If S is an Coe-semigroup and  $S \neq \mathbb{N}$ , then m(S) is an even integer and F(S) is an odd integer.

*Proof.* As  $S \neq \mathbb{N}$ , then  $m(S) \geq 2$  and  $F(S) \geq 1$ . If m(S) is odd, then we get that  $m(S) - 1 \in S$ , a contradiction. If F(S) is even, then F(S) + 1 is an odd element belongs to S. Hence, we obtain that  $(F(S) + 1) - 1 = F(S) \in S$ , a contradiction again.

**Proposition 2.** Let S be a numerical semigroup. The following conditions are equivalent.

- (1) S is an Coe-semigroup.
- (2)  $\{x-1, x+1\} \subseteq S$  for all odd element x in msg(S).

*Proof.* 1) *implies* 2) Trivial.

2) *implies* 1) Let s be an odd element in S. Clearly, there exists an odd element x in msg(S), such that  $s - x \in S$ . Then, we obtain that  $s - 1 = x - 1 + s - x \in S$  and  $s + 1 = x + 1 + s - x \in S$  and so S is an Coe-semigroup.

**Example 3.** By applying Proposition 2, we have that  $S = \langle 4, 6, 7 \rangle$  is an Coe-semigroup, because  $\{7 - 1, 7 + 1\} \subseteq S$ .

The next result has immediate proof.

**Lemma 4.** If S is a numerical semigroup such that  $S \neq \mathbb{N}$ , then  $S \cup \{F(S)\}$ and  $S \cup \{F(S) - 1, F(S)\}$  are also numerical semigroups.

Observe that, if S is an Coe-semigroup such that  $S \neq \mathbb{N}$ , then we have that  $S \cup \{F(S)\}$  is not necessary an Coe-semigroup. In fact,  $S = \{0, 6, 10, \rightarrow\}$  is an Coe-semigroup, but  $S \cup \{F(S)\} = \{0, 6, 9, 10, \rightarrow\}$  is not an Coe-semigroup. In addition, if S is an Coe-semigroup then F(S) - 1 may or may not belong to S. Indeed, we have that  $S = \{0, 6, 10, \rightarrow\}$  is an Coe-semigroup such that  $F(S) - 1 \notin S$  and  $T = \{0, 6, 8, 10, \rightarrow\}$  is an Coe-semigroup such that  $F(T) - 1 \in T$ .

**Lemma 5.** If S is an Coe-semigroup such that  $S \neq \mathbb{N}$ , then  $S \cup \{F(S) - 1, F(S)\}$  is an Coe-semigroup.

*Proof.* Applying Lemma 4, we obtain that  $S \cup \{F(S)-1, F(S)\}$  is a numerical semigroup. We know that, by Proposition 1, F(S) is an odd integer. As  $\{F(S) - 1, F(S) + 1\} \subseteq S \cup \{F(S) - 1, F(S)\}$ , we deduce that  $S \cup \{F(S) - 1, F(S)\}$  is an Coe-semigroup.

As a consequence of Lemma 5, we have all the ingredients needed to give a recursive way of calculating a sequence of Coe-semigroups. For a given an Coe-semigroup S:

• 
$$S_0 = S$$
,  
•  $S_{n+1} = \begin{cases} S_n \cup \{F(S_n) - 1, F(S_n)\} & \text{if } S_n \neq \mathbb{N} \\ \mathbb{N} & \text{otherwise.} \end{cases}$ 

The next result is trivial.

**Proposition 6.** If S is an Coe-semigroup, then there exists a sequence of Coe-semigroups,  $S = S_0 \subsetneq S_1 \subsetneq \cdots \subsetneq S_k = \mathbb{N}$ . Furthermore, the cardinality of  $S_{i+1} \setminus S_i$  is 1 or 2 for all  $i \in \{0, 1, \dots, k-1\}$ .

We will refer to the previous sequence as the chain of Coe-semigrops associated to S and k is the length of this chain, denoted by  $l_S$ .

The following result is easy to prove.

**Proposition 7.** Let S be an Coe-semigroup. The cardinality of the set  $\{x \in \mathbb{N} \setminus S \mid x \text{ is odd}\}$  is equal to  $l_S$ .

**Example 8.** Clearly  $S = \langle 6, 8, 13, 14, 15, 17 \rangle = \{0, 6, 8, 12, \rightarrow\}$  is an Coesemigroup. The chain of Coesemigrops associated to S is the following:  $S = S_0 \subsetneq S_1 = \{0, 6, 8, 10 \rightarrow\} \subsetneq S_2 = \{0, 6, 8, \rightarrow\} \subsetneq S_3 = \{0, 6, \rightarrow\} \subsetneq S_4 = \{0, 4 \rightarrow\} \subsetneq S_5 = \{0, 2 \rightarrow\} \subsetneq S_6 = \mathbb{N}$ . The cardinality of  $\{x \in \mathbb{N} \setminus S \mid x \text{ is odd}\} = \{1, 3, 5, 7, 9, 11\}$  is  $6 = l_S$ .

# 3. The tree of Coe-semigroups

A graph G is a pair (V, E) where V is a nonempty set and E is a subset of  $\{(u, v) \mid u, v \in V, u \neq v\}$ . The elements of V and E are called vertices and edges, respectively. A path of length n connecting the vertices u and v of G is a sequence of n distinct edges of the form  $(v_0, v_1), (v_1, v_2), \ldots, (v_{n-1}, v_n)$  with  $v_0 = u$  and  $v_n = v$ .

A graph G is a tree if there exists a vertex r (known as the root of G) such that for every other vertex v of G, there exists a unique path connecting v and r. If (u, v) is an edge of the tree then we say that u is a son of v.

Our main goal in this section will be to build the tree whose vertex set is  $\mathscr{C} = \{S \mid S \text{ is an Coe-semigroup}\}.$ 

We define the graph  $G(\mathscr{C})$  as the graph whose vertices are elements of  $\mathscr{C}$ and  $(S,T) \in \mathscr{C} \times \mathscr{C}$  is an edge if  $T = S \cup \{F(S) - 1, F(S)\}$ .

As a consequence of Proposition 6, we have the following.

**Proposition 9.** The graph  $G(\mathscr{C})$  is a tree with root equal to  $\mathbb{N}$ .

It is clear that we can be build recursively the tree  $G(\mathscr{C})$ , starting in  $\mathbb{N}$  and we connecting each vertex with its sons. Hence, we need to characterize the sons of an arbitrary vertex of this tree.

**Lemma 10.** [7, Lemma 1.7] Let S be a numerical semigroup and  $x \in S$ . Then  $S \setminus \{x\}$  is a numerical semigroup if and only if  $x \in msg(S)$ . The next result is easy to prove.

**Lemma 11.** Let S be a numerical semigroup such that  $S \neq \mathbb{N}$  and  $\{x, x + 1\} \subseteq S$ . Then  $S \setminus \{x, x + 1\}$  is a numerical semigroup if and only if  $\{x, x + 1\} \subseteq \operatorname{msg}(S)$ .

**Lemma 12.** Let S be an Coe-semigroup and let x be an odd element in msg(S), such that x > F(S). Then  $S \setminus \{x\}$  is a son of S in the tree  $G(\mathscr{C})$ .

*Proof.* By Lemma 10, we have that  $S \setminus \{x\}$  is a numerical with  $F(S \setminus \{x\}) = x$ . Since x is odd then  $S \setminus \{x\}$  is an Coe-semigroup and  $x - 1 \in S$ . Moreover, we can deduce that  $(S \setminus \{x\} \cup \{F(S \setminus \{x\}), F(S \setminus \{x\}) - 1\}) = S \setminus \{x\} \cup \{x, x - 1\} = S$  and thus  $S \setminus \{x\}$  is a son of S in the tree  $G(\mathscr{C})$ .

**Lemma 13.** Let S be an Coe-semigroup and let T be a son of S in the tree  $G(\mathscr{C})$  such that g(T) = g(S) + 1. Then, there exists an odd element x in msg(S) with x > F(S) such that  $T = S \setminus \{x\}$ .

*Proof.* If T is a son of S such that g(T) = g(S) + 1, then we obtain that  $T \cup \{F(T)\} = S$  and so  $T = S \setminus \{F(T)\}$ . By using Lemma 10, we have that  $F(T) \in msg(S)$  and it is clear that F(S) < F(T). Applying Proposition 1, we conclude that F(T) is odd.

**Lemma 14.** Let S be an Coe-semigroup such that  $\{F(S) + 1, F(S) + 2\} \subseteq msg(S)$ . Then  $S \setminus \{F(S) + 1, F(S) + 2\}$  is a son of S in the tree  $G(\mathscr{C})$ .

Proof. By Lemma 11, we have that  $T = S \setminus \{F(S) + 1, F(S) + 2\}$  is a numerical semigroup such that F(T) = F(S) + 2. By applying Proposition 1, F(S) is odd and so F(T) is also odd. Hence, we deduce that T is an Coe-semigroup. As  $S = T \cup \{F(T), F(T) - 1\}$ , then we get that T is a son of S.

**Lemma 15.** Let S be an Coe-semigroup and let T be a son of S in the tree  $G(\mathscr{C})$  such that g(T) = g(S) + 2. Then,  $\{F(S) + 1, F(S) + 2\} \subseteq msg(S)$  and  $T = S \setminus \{F(S) + 1, F(S) + 2\}$ .

*Proof.* If T is a son of S, then T is an Coe-semigroup and  $S = T \cup \{F(T), F(T) - 1\}$ . Since g(T) = g(S) + 2, this implies that  $F(T) - 1 \notin T$ . By applying Proposition 1, F(T) is odd and so F(T) - 2 is also odd. As  $F(S) - 1 \notin T$  and T is an Coe-semigroup, we obtain that  $F(T) - 2 \notin T$  and thus F(S) = F(T) - 2. Consequently,  $T = S \setminus \{F(S) + 1, F(S) + 2\}$  and by using Lemma 11, we conclude that  $\{F(S) + 1, F(S) + 2\} \subseteq msg(S)$ .  $\Box$ 

As a consequence of Lemmas 12, 13, 14 and 15 we obtain the following result.

**Theorem 16.** Let S be an Coe-semigroup, then set of sons of S in the tree  $G(\mathcal{C})$  is equal to:

(1)  $\{S \setminus \{x\} \mid x \text{ is an odd element in } msg(S) \text{ with } x > F(S)\}$  if  $\{F(S) + 1, F(S) + 2\} \not\subseteq msg(S).$ 

(2) 
$$\{S \setminus \{x\} \mid x \text{ is an odd element in } msg(S) \text{ with } x > F(S)\} \cup \{S \setminus \{F(S) + 1, F(S) + 2\}\}$$
 if  $\{F(S) + 1, F(S) + 2\} \subseteq msg(S)$ .

It is clear that for all  $k \in \mathbb{N}\setminus\{0\}$  we have that  $\{0, 2k, \rightarrow\}$  is an Coesemigroup, this implies that the set  $\mathscr{C}$  has infinite cardinality.

The last theorem can be used to recurrently construct the tree  $G(\mathscr{C})$ , starting in  $\mathbb{N}$ , containing the set of all Coe-semigroups.



Note that the numbers that appears on either side of the edges is the elements that we remove from the vertex to obtain its son.

## 4. Examples of finite trees

Given  $k \in \mathbb{N}$  we denote by

 $\mathscr{C}(k) = \{S \mid S \text{ is an Coe-semigroup and } k \in S\}.$ 

If k is an even positive integer and  $n \in \{x \in \mathbb{N} \mid x > k\}$ , then  $(\{k\} + \langle 2 \rangle) \cup \{0, n, \rightarrow\} \in \mathscr{C}(k)$  and so, in this case,  $\mathscr{C}(k)$  has infinite cardinality. Our first aim in this section is to see that  $\mathscr{C}(k)$  has finite cardinality, when k is an odd positive integer.

If S is a numerical semigroup, then  $\mathbb{N}\backslash S$  is a finite set and so we obtain the following result.

**Lemma 17.** If S is a numerical semigroup, then  $\{T \mid T \text{ is a numerical semigroup and } S \subseteq T\}$  is a finite set.

**Proposition 18.** If k is an odd positive integer, then  $\mathcal{C}(k)$  is a nonempty finite set.

*Proof.* Since  $\mathbb{N} \in \mathscr{C}(k)$ , then  $\mathscr{C}(k) \neq \emptyset$ . If  $S \in \mathscr{C}(k)$ , then we have that  $\langle k - 1, k, k + 1 \rangle \subseteq S$  and it is clear that  $\langle k - 1, k, k + 1 \rangle$  is a numerical semigroup. Besides,  $\mathscr{C}(k) \subseteq$ 

 $\{T \mid T \text{ is a numerical semigroup and } \langle k-1, k, k+1 \rangle \subseteq T\}$ . By Lemma 17, we can deduce that  $\mathscr{C}(k)$  is a finite set.

The following result is easy to prove.

**Lemma 19.** Let k be a positive integer and let  $S \in \mathscr{C}(k)$  such that  $S \neq \mathbb{N}$ . Then  $S \cup \{F(S), F(S) - 1\} \in \mathscr{C}(k)$ .

We define the graph  $G(\mathscr{C}(k))$  as the graph whose vertices are elements of  $\mathscr{C}(k)$  and  $(S,T) \in \mathscr{C}(k) \times \mathscr{C}(k)$  is an edge if  $T = S \cup \{F(S) - 1, F(S)\}$ .

Using the same argument of Section 3, we have the following result.

**Theorem 20.** If k is a positive integer, then the graph  $G(\mathcal{C}(k))$  is a tree with root equal to  $\mathbb{N}$ . Furthermore, if  $S \in \mathcal{C}(k)$  then the set of sons of S in the tree  $G(\mathcal{C}(k))$  is equal to:

- (1)  $\{S \setminus \{x\} \mid x \text{ is an odd element in } msg(S) \text{ with } x > F(S) \text{ and } x \neq k\}$ if  $\{F(S) + 1, F(S) + 2\} \nsubseteq msg(S) \setminus \{k\}.$
- (2)  $\{S \setminus \{x\} \mid x \text{ is an odd element in } msg(S) \text{ with } x > F(S) \text{ and } x \neq k\}$  $\cup \{S \setminus \{F(S) + 1, F(S) + 2\}\} \text{ if } \{F(S) + 1, F(S) + 2\} \subseteq msg(S) \setminus \{k\}.$

**Example 21.** We are going to build the tree  $G(\mathscr{C}(5))$ .



Given a positive integer F, denote by

 $\mathscr{C}(Frob \leq F) = \{S \mid S \text{ is an Coe-semigroup with } F(S) \leq F\}.$ 

Note that if S is an element in  $\mathscr{C}(Frob \leq F)$ , then  $\{F+1, \rightarrow\} \subseteq S$  and thus  $\mathscr{C}(Frob \leq F)$  is a finite set.

The next result is easy to prove.

**Lemma 22.** Let F be a positive integer and let  $S \in \mathscr{C}(Frob \leq F)$  such that  $S \neq \mathbb{N}$ . Then  $S \cup \{F(S), F(S) - 1\} \in \mathscr{C}(Frob \leq F)$ .

Now, we define the graph  $G(\mathscr{C}(Frob \leq F))$  as follows:  $\mathscr{C}(Frob \leq F)$  is its set of vertices and  $(S,T) \in \mathscr{C}(Frob \leq F) \times \mathscr{C}(Frob \leq F)$  is an edge if  $T = S \cup \{F(S) - 1, F(S)\}.$ 

By using again the same argument of Section 3, we have the next result. **Theorem 23.** If F is a positive integer, then the graph  $G(\mathscr{C}(Frob \leq F))$ is a tree with root equal to  $\mathbb{N}$ . Furthermore, if  $S \in \mathscr{C}(Frob \leq F)$  then the set of sons of S in the tree  $G(\mathscr{C}(Frob \leq F))$  is equal to:

- (1)  $\{S \setminus \{x\} \mid x \text{ is an odd element in } msg(S) \text{ with } F(S) < x \le F\}$  if  $\{F(S) + 1, F(S) + 2\} \nsubseteq \{x \in msg(S) \mid x \le F\}.$
- (2)  $\{S \setminus \{x\} \mid x \text{ is an odd element in } msg(S) \text{ with } F(S) < x \leq F\}$   $\cup \{S \setminus \{F(S) + 1, F(S) + 2\}\}$  if  $\{F(S) + 1, F(S) + 2\}$   $\subseteq$  $\{x \in msg(S) \mid x \leq F\}.$

**Example 24.** We are going to build the tree  $G(\mathscr{C}(Frob \leq 5))$ .



Given a positive integer g, denote by

 $\mathscr{C}(gen \leq g) = \{S \mid S \text{ is an Coe-semigroup with } g(S) \leq g\}.$ 

In [9, Lemma 2.14] it is shown that, if S is a numerical semigroup then  $F(S) \leq 2g(S) - 1$ . Therefore, we obtain that  $\mathscr{C}(gen \leq g) \subseteq \mathscr{C}(Frob \leq 2g-1)$  and so  $\mathscr{C}(gen \leq g)$  is a finite set.

The next result is easy to prove.

**Lemma 25.** Let g be a positive integer and let  $S \in \mathscr{C}(gen \leq g)$  such that  $S \neq \mathbb{N}$ . Then  $S \cup \{F(S), F(S) - 1\} \in \mathscr{C}(gen \leq g)$ .

We define the graph  $G(\mathscr{C}(gen \leq g))$  as follows:  $\mathscr{C}(gen \leq g)$  is its set of vertices and  $(S,T) \in \mathscr{C}(gen \leq g) \times \mathscr{C}(gen \leq g)$  is an edge if  $T = S \cup \{F(S) - 1, F(S)\}$ .

By using again the same argument of Section 3, we have the next result.

**Theorem 26.** If g is a positive integer, then the graph  $G(\mathscr{C}(gen \leq g))$  is a tree with root equal to  $\mathbb{N}$ . Furthermore, if  $S \in \mathscr{C}(gen \leq g)$  then the set of sons of S in the tree  $G(\mathscr{C}(gen \leq g))$  is equal to:

- (1) the set of sons of S in the tree  $G(\mathscr{C})$  if  $g(S) \leq g 2$  (see Theorem 16).
- (2)  $\{S \setminus \{x\} \mid x \text{ is an odd element in } msg(S) \text{ with } x > F(S)\}$  if g(S) = g 1.
- (3) the empty set if g(S) = g.

**Example 27.** We are going to build the tree  $G(\mathscr{C}(gen \leq 4))$ .



Observe that the numbers that appears on the right side of each of the semigroups are their genders.

#### 5. Coe-monoids

It is well known that the intersection of finitely many numerical semigroups is a numerical semigroup. Hence, the next result is easy to prove.

**Proposition 28.** The intersection of finitely many Coe-semigroups is an Coe-semigroup.

Note that the previous result does not hold for infinite intersections. In fact, by using Proposition 2, we can deduce that  $\langle 2, 2k + 1 \rangle$  is an Coesemigroup for all  $k \in \mathbb{N}$  and  $\bigcap_{k \in \mathbb{N}} \langle 2, 2k + 1 \rangle = \langle 2 \rangle$  is not a numerical semigroup.

Clearly, the intersection (finite or infinite) of numerical semigroups is a submonoid of  $(\mathbb{N}, +)$ . An Coe-monoid is a submonoid of  $(\mathbb{N}, +)$  which can be expressed as intersection of Coe-semigroups. Besides, the intersection of Coe-monoids is an Coe-monoid. In view of this, given X a subset of  $\mathbb{N}$  we

can define the Coe-monoid generated by X as the intersection of all Coemonoids containing X, denoted by Coe(X). Then, we have that Coe(X) is the smallest Coe-monoid containing X.

The next result has immediate proof.

**Proposition 29.** If X is a subset of  $\mathbb{N}$ , then Coe(X) is the intersection of all Coe-semigroups that containing X.

If M is an Coe-monoid and X is a subset of  $\mathbb{N}$  such that M = Coe(X), then we say that X is an coe-system of generators of M.

The following properties are a direct consequence of the definitions.

**Lemma 30.** Let X and Y be subsets of  $\mathbb{N}$  and let M be an Coe-monoid. Then the following conditions hold:

- (1) If  $X \subseteq Y$  then  $Coe(X) \subseteq Coe(Y)$ ,
- (2)  $Coe(X) = Coe(\langle X \rangle),$
- (3) Coe(M) = M,
- (4)  $Coe(X \setminus \{0\}) = Coe(X),$
- (5)  $Coe(\emptyset) = \{0\}.$

**Proposition 31.** Let M be an Coe-monoid such that  $M \neq \{0\}$ . Then there exists a nonempty finite subset of  $\mathbb{N}\setminus\{0\}$  such that M = Coe(X).

*Proof.* We have that msg(M) is a nonempty finite subset  $\mathbb{N}\setminus\{0\}$  such that  $M = \langle msg(M) \rangle$ . By applying Lemma 30, we deduce that M = Coe(msg(M)).

As a consequence of previous proposition we have the following result.

**Corollary 32.** The set formed by all Coe-monoids is equal to  $\{Coe(X) \mid X \text{ is a nonempty finite subset of } \mathbb{N} \setminus \{0\}\} \cup \{\{0\}\}.$ 

Given X a nonempty finite subset of  $\mathbb{N}\setminus\{0\}$ , our next aim in this section will be to show a procedure that allows us to compute Coe(X).

**Theorem 33.** Let M be a submonoid of  $(\mathbb{N}, +)$  such that  $M \neq \{0\}$ . The following conditions are equivalent.

- (1) M is an Coe-monoid.
- (2)  $\{x-1, x+1\} \subseteq M$  for all odd element x in M.
- (3)  $\{x-1, x+1\} \subseteq M$  for all odd element x in msg(M).

*Proof.* The equivalence between conditions 2) and 3) is analogous to the proof of Proposition 2.

1) implies 2) If M is an Coe-monoid, then there exists a family  $\{S_i\}_{i \in I}$  of Coe-semigroups such that  $M = \bigcap_{i \in I} S_i$ . If x is an odd element in M, then  $x \in S_i$  for all  $i \in I$ . As  $\{x - 1, x + 1\} \subseteq S_i$  for all  $i \in I$ , then we get that  $\{x - 1, x + 1\} \subseteq \bigcap_{i \in I} S_i = M$ .

2) *implies* 1) It is clear that  $M_k = M \cup \{2k, \rightarrow\}$  is an Coe-semigroup for all  $k \in \mathbb{N}$ . Hence,  $M = \bigcap_{k \in \mathbb{N}} M_k$  is an Coe-monoid.

**Corollary 34.** Let M be a submonoid of  $(\mathbb{N}, +)$ . Then M is an Coe-monoid if and only if either  $M \subseteq \langle 2 \rangle$  or M is an Coe-semigroup.

*Proof.* If M is an Coe-monoid which does not contain odd elements, then  $M \subseteq \langle 2 \rangle$ . On the other hand, if x is an odd element in M, then by Theorem 33,  $\{x - 1, x, x + 1\} \subseteq M$ . Therefore, we can conclude that M is a numerical semigroup which is an Coe-semigroup.

Conversely, if  $M \subseteq \langle 2 \rangle$ , then, by applying condition 2) of Theorem 33, we get that M is an Coe-monoid. Furthermore, if M is an Coe-semigroup, then it is an Coe-monoid.

**Corollary 35.** If X is a subset of  $\mathbb{N}\setminus\{0\}$ , then Coe(X) is a submonoid of  $(\mathbb{N}, +)$  generated by  $X \cup \{x + 1 \mid x \text{ is an odd element in } X\} \cup \{x - 1 \mid x \text{ is an odd element in } X\}.$ 

*Proof.* Let  $A = X \cup \{x+1 \mid x \text{ is an odd element in } X\} \cup \{x-1 \mid x \text{ is an odd element in } X\}$ . By condition 2) of Theorem 33, we get that  $\langle A \rangle \subseteq Coe(X)$  and by condition 3) of Theorem 33, we obtain that  $Coe(X) \subseteq A$ . Whence,  $\langle A \rangle = Coe(X)$ .

**Example 36.** By using Corollary 35, we obtain that  $Coe(\{4,7\}) = \langle 4,6,7,8 \rangle = \langle 4,6,7 \rangle$ .

The following result is easy to prove.

**Corollary 37.** Let X be a subset of  $\mathbb{N}\setminus\{0\}$ . Then, Coe(X) is an Coesemigroup if and only if X contains at least one odd element.

#### 6. Coe-semigroups with maximal embedding dimension

It is known that, if S is a numerical semigroup, then its embedding dimension, e(S), is less than or equal to its multiplicity, m(S) (see [9, Proposition 2.10]. And S has maximal embedding dimension (Med-semigroup, for short) whenever e(S) = m(S). From [2, Proposition I.2.9] we can deduce the next result.

**Lemma 38.** Let S be a numerical semigroup. Then S is an Med-semigroup if and only if  $\{s - m(S) \mid s \in S \setminus \{0\}\}$  is a numerical semigroup.

**Proposition 39.** Let S be an Med-semigroup such that  $S \neq \mathbb{N}$ . Then S is an Coe-semigroup if and only if m(S) is even and  $T = \{-m(S)\} + (S \setminus \{0\})$  is an Coe-semigroup.

*Proof. Necessity.* From Lemma 38, we have that T is a numerical semigroup and by Proposition 1, m(S) is even. Let t be an odd element in T. Then there exists  $s \in S$  such that t = s - m(S) and s is odd. Since S is an Coe-semigroup then  $\{s - 1, s + 1\} \subseteq S$  and so  $\{t - 1, t + 1\} = \{s - 1 - m(S), s + 1 - m(S)\} \subseteq T$ . Hence, T is an Coe-semigroup.

Sufficiency. Let s be an odd element in S. Then s - m(S) is an odd element in T. As T is an Coe-semigroup then  $\{s - 1 - m(S), s + 1 - m(S)\} \subseteq T$  and so  $\{s - 1, s + 1\} \subseteq S$ . Consequently, S is an Coe-semigroup.

From Lemma 38, is easy to prove the following result.

**Lemma 40.** If S is a numerical semigroup and  $x \in S \setminus \{0\}$ , then  $S_x = (\{x\} + S) \cup \{0\}$  is an Med-semigroup with  $m(S_x) = x$ . Moreover, every Med-semigroup is of this form.

**Proposition 41.** Let S be an Coe-semigroup and let x be an even element in  $S \setminus \{0\}$ . Then  $S_x = (\{x\} + S) \cup \{0\}$  is an Coe-semigroup with maximal embedding dimension. Moreover, every Coe-semigroup with maximal embedding dimension, distinct of  $\mathbb{N}$ , is of this form.

*Proof.* By using Lemma 40, we know that  $S_x$  is an Med-semigroup with  $m(S_x) = x$ . Clearly, that  $S = \{-x\} + (S_x \setminus \{0\})$  and by Proposition 39 we get that  $S_x$  is an Coe-semigroup.

Now, let T be an Coe-semigroup with maximal embedding dimension, distinct from  $\mathbb{N}$ . By Proposition 1, we have that m(T) is even and, by Proposition 39, we deduce that  $Q = \{-m(T)\} + (T \setminus \{0\})$  is an Coe-semigroup. Finally,  $T = (\{m(T)\} + Q\} \cup \{0\}$  wherein Q is an Coe-semigroup and m(T)is an even element in Q.

Let S be a numerical semigroup and let  $n \in S \setminus \{0\}$ . The Apéry set (named so in honour of [1]) of n in S is

$$\operatorname{Ap}(S,n) = \{ s \in S \mid s - n \notin S \}.$$

**Lemma 42.** [9, Lemma 2.4] Le S be a numerical semigroup and  $n \in S \setminus \{0\}$ . Then  $Ap(S,n) = \{0 = w(0), w(1), \dots, w(n-1)\}$ , where w(i) is the least element in S congruent with i modulo n, for all  $i \in \{0, \dots, n-1\}$ .

Observe that the above lemma in particular implies that the cardinality of Ap(S, n) is n. From [8], we can deduce the next result.

**Proposition 43.** Le S be a numerical semigroup,  $x \in S \setminus \{0\}$  and  $T = (\{x\} + S) \cup \{0\}$ . Then the following conditions hold:

- (1) T is an MED-semigroup
- (2) m(T) = x.
- (3) F(T) = F(S) + x.
- (4) g(T) = g(S) + x 1.
- (5)  $msg(T) = Ap(S, x) + \{x\}.$

**Example 44.** From Example 3 we have that  $S = \langle 4, 6, 7 \rangle = \{0, 4, 6, 7, 8, 10, \rightarrow\}$  is an Coe-semigroup. Since 6 is an even element in S, then by applying Propositions 41 and 43, we obtain that  $T = (\{6\}+S) \cup \{0\}$  is an Coe-semigroup with maximal embedding dimension, m(T) = 6, F(T) = 9 + 6 = 15, g(T) = 5 + 6 - 1 = 10 and  $msg(T) = Ap(S, 6) + \{6\} = \{0, 4, 7, 8, 11, 15\} + \{6\} = \{6, 10, 13, 14, 17, 21\}.$ 

7. Coe-semigroups with an unique odd minimal generator

Our first aim in this section is to prove Theorem 47, which can be used to construct whole set of Coe-semigroups with an unique odd minimal generator.

**Lemma 45.** Let S be a numerical semigroup and  $\{s, s+1\} \subseteq S$ . Then  $T = 2S \cup (\{2s+1\} + 2S)$  is an Coe-semigroup. Moreover, 2s+1 is the unique odd minimal generator in T.

*Proof.* The sum of two elements in 2S belongs to 2S. The sum of two elements in  $\{2s + 1\} + 2S$  belongs to 2S. The sum of an element in 2S and an element in  $\{2s + 1\} + 2S$  belongs to  $\{2s + 1\} + 2S$ . As a result of the previous observations, we can conclude that T is a numerical semigroup. Besides, if  $msg(S) = \{n_1, \ldots, n_p\}$ , then  $\{2n_1, \ldots, 2n_p, 2s + 1\}$  is a system of generators of T and 2s + 1 is the unique odd minimal generator in T. Since  $\{s, s + 1\} \subseteq S$ , then  $\{2s, 2s + 2\} \subseteq T$  and so, by Proposition 2, we obtain that T is an Coe-semigroup.

**Lemma 46.** Let T be an Coe-semigroup, with  $T \neq \mathbb{N}$ , and x the unique odd minimal generator in T. Then there exists a numerical semigroup S such that  $T = 2S \cup (\{x\} + 2S)$  and  $\{\frac{x-1}{2}, \frac{x-1}{2} + 1\} \subseteq S$ .

*Proof.* If  $A = \{a \in msg(T) \mid a \text{ is even}\}$ , then  $msg(T) = A \cup \{x\}$ . Since T is an Coe-semigroup, then  $\{x - 1, x + 1\} \subseteq T$  and so  $\{x - 1, x + 1\} \subseteq \langle A \rangle$ . As  $gcd\{x - 1, x + 1\} = 2$ , then  $gcd\{A\} = 2$  and therefore  $S = \langle \{\frac{a}{2} \mid a \in A\} \rangle$  is a numerical semigroup.

Since  $\{x-1, x+1\} \subseteq \langle A \rangle$ , then  $2x = (x-1) + (x+1) \in \langle A \rangle$  and we obtain that  $T = \langle A \rangle \cup (\{x\} + \langle A \rangle)$ . Besides, we have that  $\langle A \rangle = 2S$ , then  $T = 2S \cup (\{x\} + 2S)$ . Finally, if  $\{x-1, x+1\} \subseteq \langle A \rangle$ , then we get that  $\{\frac{x-1}{2}, \frac{x+1}{2}\} = \{\frac{x-1}{2}, \frac{x-1}{2} + 1\} \subseteq S$ .

As a consequence of Lemmas 45 and 46, we obtain the next result.

**Theorem 47.** If S is a numerical semigroup and  $\{s, s+1\} \subseteq S$ , then  $T = 2S \cup (\{2s+1\} + 2S)$  is an Coe-semigroup with an unique odd minimal generator. Moreover, every Coe-semigroup with an unique odd minimal generator is of this form.

**Proposition 48.** Let S be a numerical semigroup, and  $\{s, s + 1\} \subseteq S$ , then  $T = 2S \cup (\{2s + 1\} + 2S)$ . Then the following conditions hold:

- (1) m(T) = 2m(S).
- (2) F(T) = 2F(S) + (2s + 1).
- (3) g(T) = 2g(S) + s.
- (4)  $msg(T) = (2msg(S)) \cup \{2s+1\}.$
- (5) e(T) = e(S) + 1.

*Proof.* (1) Trivial.

- (2) It is sufficient to see that all even elements greater that 2F(S) and all odd elements greater that 2s + 1 + 2F(S) belongs to T. Since  $2s + 1 + 2F(S) \notin T$ , then F(T) = 2s + 1 + 2F(S)
- (3) The cardinality of the set of the even elements not in T is equal to g(S). The set of the odd elements not in T is equal to  $\{2k+1 \mid k \in \{0, 1, \dots, s-1\}\} \cup \{2s+1+2x \mid x \in \mathbb{N} \setminus S\}$ . Hence, we get that g(T) = 2g(S) + s.
- (4) If  $\operatorname{msg}(S) = \{n_1, \dots, n_p\}$ , then  $T = \langle 2n_1, \dots, 2n_p, 2s+1 \rangle$ . In fact,  $2s+1 \notin \langle 2n_1, \dots, 2n_p \rangle$ . In order to conclude the proof, it suffices to show that  $2n_1 \notin \langle 2n_2, \dots, 2n_p, 2s+1 \rangle$ . Suppose that there exists  $\{\lambda_1, \lambda_2, \dots, \lambda_p\} \subseteq \mathbb{N}$  such that  $2n_1 = \lambda_1(2s+1) + \lambda_2(2n_2) + \dots + \lambda_p(2n_p)$ . Hence, we get that  $\lambda_1$  is even and  $n_1 = \frac{\lambda_1}{2}(2s+1) + \lambda_2n_2 + \dots + \lambda_pn_p$ , with  $\{\frac{\lambda_1}{2}, \lambda_2, \dots, \lambda_p\} \subseteq \mathbb{N}$ . Since  $\operatorname{msg}(S) = \{n_1, \dots, n_p\}$  and  $2s+1 \in S$ , then  $n_1 = 2s+1$ . We have that  $s = \frac{n_1-1}{2}$ , and as  $\{s, s+1\} \subseteq S$ , then  $\{\frac{n_1-1}{2}, \frac{n_1+1}{2}\} \subseteq S \setminus \{0\}$ . Therefore,  $\frac{n_1-1}{2} + \frac{n_1+1}{2} = n_1$  and so  $n_1 \notin \operatorname{msg}(S)$ , a contradiction. (5) Follow dimently from the  $(\Delta)$
- (5) Follow directly from the (4).

**Example 49.** If  $S = \langle 5,7,9 \rangle$  then m(S) = 5, F(S) = 13, g(S) = 8,  $msg(S) = \{5,7,9\}$  and e(S) = 3. Since  $\{14,15\} \subseteq S$ , then by Theorem 47,  $T = 2S \cup (\{29\} + 2S)$  is an Coe-semigroup. By Proposition 48, we obtain that m(T) = 10, F(T) = 55, g(T) = 30,  $msg(T) = \{10, 14, 18, 29\}$  and e(T) = 4.

Let S a numerical semigroup. We say that s is a small element in S if s < F(S). Denote by N(S) the set of all small elements in S and by n(S) its cardinality. Note that F(S) + 1 = g(S) + n(S).

In 1978, H. S. Wilf (see [12]) conjectured upper bound for g(S), namely,  $g(S) \leq (e(S) - 1)n(S)$ . Nowadays, the Wilf's conjecture remains unanswered, but for some families of numerical semigroups this conjecture is known to be true (see for example, [3]).

**Proposition 50.** Let S be a numerical semigroup,  $\{s, s+1\} \subseteq S$  and  $T = 2S \cup (\{2s+1\}+2S)$ . If S verifies the Wilf's conjecture, then T also verifies the same conjecture.

*Proof.* As n(T) = F(T) + 1 - g(T), then by Proposition 48, we have that n(T) = 2F(S) + (2s+1) + 1 - (2g(S)+s) = 2(F(S)+1-g(S)) + s = 2n(S) + s. We have that T verifies the Wilf's conjecture if

$$g(T) \le (e(T) - 1)n(T) \iff$$

$$2g(S) + s \le e(S)(2n(S) + s) \iff$$

$$g(S) \le (e(S) - 1)n(S) + n(S) + \frac{(e(S) - 1)s}{2}$$

Since S verifies the Wilf's conjecture, then  $g(S) \leq (e(S) - 1)n(S)$ ,  $n(S) \geq 0$ and  $\frac{(e(S)-1)s}{2} \ge 0$  and therefore T also verifies the same conjecture. 

**Example 51.** If S is a numerical semigroup with e(S) = 3, then by [4, Theorem 2.11], we have that S verifies the Wilf's conjecture. If  $\{s, s+1\} \subseteq$ S, then by Proposition 48, we obtain that  $T = 2S \cup (\{2s+1\} + 2S)$  is an Coe-semigroup which verifies he Wilf's conjecture.

We finish this section by studying the class of Coe-semigroups with embedding dimension 1, 2 and 3. Clearly, the numerical semigroups,  $\mathbb{N}$  and  $\langle 2, 2k+1 \rangle$  with  $k \in \mathbb{N} \setminus \{0\}$ , are all Coe-semigroups with embedding dimension 1 and 2.

**Lemma 52.** If S is an Coe-semigroup with e(S) = 3, then S has an unique odd minimal generator.

*Proof.* If  $msg(S) = \{n_1 < n_2 < n_3\}$ , then by Proposition 1, we get that  $n_1$  is an even integer. If  $n_2$  and  $n_3$  are two odd integers, as  $\{n_2 - 1, n_2 + 1\} \subseteq T$ , then  $\{n_2 - 1, n_2 + 1\} \subseteq \langle n_1 \rangle$  and so  $n_1 = 2$ . Therefore, m(S) = 2 and  $e(S) \le m(S) = 2$  a contradiction.  $\square$ 

**Proposition 53.** Let a and b be positive integers such that  $2 \leq a < b$ ,  $gcd\{a,b\} = 1$  and  $\{s,s+1\} \subseteq \langle a,b \rangle$ . Then  $T = \langle 2a,2b,2s+1 \rangle$  is an Coesemigroup with embedding dimension 3. Moreover, every Coe-semigroup with embedding dimension 3 is of this form.

Proof. As an immediate consequence of Theorem 47, Proposition 48 and Lemma 52.

The next result appears in [11].

**Lemma 54.** Let a and b be positive integers such that  $2 \le a < b$ ,  $gcd\{a, b\} =$ 1. Then:

(1) 
$$F(\langle a, b \rangle) = ab - a - b.$$
  
(2)  $g(\langle a, b \rangle) = \frac{(a-1)(b-1)}{2}.$ 

By applying Propositions 48, 53 and Lemma 54, we obtain the next result.

**Proposition 55.** If S is an Coe-semigroup,  $msg(S) = \{n_1, n_2, n_3\}$  and  $n_3$ an odd integer, then:

(1)  $F(S) = n_3 + \frac{n_1 n_2}{2} - n_1 - n_2.$ (2)  $g(S) = \frac{n_3 - 1}{2} + (\frac{n_1}{2} - 1)(\frac{n_2}{2} - 1).$ 

From [9, Lemma 2.14] we know that if S is a numerical semigroup, then  $g(S) \geq \frac{F(S)+1}{2}$ . Following the terminology introduced in [5] a numerical semigroup is symmetric if  $g(S) = \frac{F(S)+1}{2}$ . By Proposition 55, we have the following result.

**Corollary 56.** If S is an Coe-semigroup with e(S) = 3, then S is a symmetric numerical semigroup.
