THE LOW DIMENSIONAL HOMOLOGY GROUPS OF THE ELEMENTARY GROUP OF RANK TWO

Abstract. In this article we study the first, the second and the third homology groups of the elementary group $E_2(A)$, where A is a commutative ring. In particular, we prove a refined Bloch-Wigner type exact sequence over a semilocal ring (with some mild restriction on its residue fields) such that $-1 \in (A^{\times})^2$ or $|A^{\times}/(A^{\times})^2| \leq 4$.

For a commutative ring A with unit, let $E_2(A)$ be the subgroup of the general linear group $GL_2(A)$ generated by elementary matrices. Clearly $E_2(A) \subseteq SL_2(A)$. We say that A is a $GE_2(A)$ -ring if $E_2(A) = SL_2(A)$.

In a series of papers $[14]$, $[15]$ and $[16]$ we studied the low dimensional homology groups of the elementary group $E_2(A)$. In this paper, we further study these homology groups.

The first main result of this paper is over the first homology group of $E_2(A)$. We show that for any commutative ring A , we have the exact sequence

 $H_2(\mathrm{E}_2(A),\mathbb{Z}) \to H_1(Y_{\bullet}(A^2))_{\mathrm{E}_2(A)} \to A/M \to H_1(\mathrm{E}_2(A),\mathbb{Z}) \to 0,$

where $Y_{\bullet}(A^2)$ is a complex of $GE_2(A)$ -modules obtained from certain unimodular vectors in A^2 (see Theorem [2.1\)](#page-4-0). Here M is the additive subgroup of A generated by $x(a^2-1)$ and $3(b+1)(c+1)$, where $x \in A$ and $a, b, c \in A^{\times}$. The right hand side map is induced by the map $A \to \mathrm{E}_2(A)$, where sends x to the elementary matrix $E_{12}(x)$. The group A/M and its connection with the first homology of $E_2(A)$ first were studied by Cohn in [\[3\]](#page-17-3) and [\[4\]](#page-17-4).

From the complex $Y_{\bullet}(A^2)$ we obtain a spectral sequence $E^1_{p,q} \Rightarrow H_{p+q}(E_2(A), \mathbb{Z})$ which will be our main tool in handling the low dimensional homology groups of of $E_2(A)$. The above exact sequence is obtained from a careful analysing of this spectral sequence. This gives a different proof of the main result of $[16,$ Theorem 3.1] over commutative rings.

We use further this spectral sequence to study the second homology group $H_2(E_2(A),\mathbb{Z}),$ when A is a semilocal ring such that $2 \in A^{\times}$ and all its residue fields have more that four elements (see Theorem [3.4\)](#page-10-0). More precisely, we give a set of cycles in $B_{\bullet}(E_2(A)) \otimes_{E_2(A)} \mathbb{Z}$, where their homology classes generate $H_2(E_2(A), \mathbb{Z})$. Here $B_{\bullet}(E_2(A)) \to \mathbb{Z}$ is the bar resolution of $E_2(A)$ over \mathbb{Z} [\[2,](#page-17-5) Chap. I, §5]. This result is used in the study of the third homology of $E_2(A)$.

The third main result of this paper is a refined Bloch-Wigner exact sequence over a semilocal domain. This exact sequence studies the third homology of $E_2(A)$. More precisely, let A be a semilocal ring such that for any maximal ideal $\mathfrak{m} \in \text{Specm}(A)$, the residue field A/\mathfrak{m} either is infinite or when $|A/\mathfrak{m}| = p^d$, then $(p-1)d > 6$. If $-1 \in A^{\times 2}$ or $|A^{\times}/(A^{\times})^2| \leq 4$, then we obtain the refined Bloch-Wigner exact sequence

$$
0 \to \operatorname{Tor}^{\mathbb{Z}}_1(\mu(A), \mu(A))^{\sim} \to \frac{H_3(\operatorname{E}_2(A), \mathbb{Z})}{\mu_2(A) \otimes_{\mathbb{Z}} I^2(A)} \to \mathcal{RB}(A) \to 0.
$$

Here $I(A)$ is the fundamental ideal of A and $RB(A)$ is the refined Bloch group of A. Moreover, the map $\mu_2(A) \otimes_{\mathbb{Z}} I^2(A) \to H_3(E_2(A), \mathbb{Z})$ is obtained from the product map

 $\mu_2(A) \otimes_{\mathbb{Z}} H_2(\mathcal{E}_2(A), \mathbb{Z}) \to H_3(\mathcal{E}_2(A), \mathbb{Z}),$

which is induced by the map $\mu_2(A) \times E_2(A) \to E_2(A), (-1, X) \mapsto -X$. This generalizes the main result of $[15]$. In $[19,$ Question 0.1 we raised the question that over local rings is the product map

$$
\mu_2(A) \otimes_{\mathbb{Z}} H_2(\mathcal{E}_2(A), \mathbb{Z}) \to H_3(\mathcal{E}_2(A), \mathbb{Z})
$$

trivial, provided that $|A/\mathfrak{m}_A| \neq 2$?

Notations. In this paper all rings are commutative, except probably group rings, and have the unit element 1. For a commutative ring A, let $\mathcal{G}_A := A^{\times}/(A^{\times})^2$ and set

$$
\mathcal{W}_A := \{ a \in A : a(1 - a) \in A^\times \}.
$$

The element of \mathcal{G}_A represented by $a \in A^{\times}$ is denoted by $\langle a \rangle$ and set $\langle \langle a \rangle := \langle a \rangle - 1 \in \mathbb{Z}[\mathcal{G}_A].$ For $n \in \mathbb{N}$, let $\mu_n(A)$ denotes the group of *n*-roots of unity in A. Moreover, let

$$
\mu(A) := \bigcup_{n \in \mathbb{N}} \mu_n(A).
$$

If $\mathcal{B} \to \mathcal{A}$ is a homomorphism of abelian groups, by \mathcal{A}/\mathcal{B} we mean coker $(\mathcal{B} \to \mathcal{A})$.

1. The complex of unimodular vectors

Let A be a commutative ring. Let $E_2(A)$ be the subgroup of $GL_2(A)$ generated by the elementary matrices $E_{12}(a) := \begin{pmatrix} 1 & a \\ 0 & 1 \end{pmatrix}$ and $E_{21}(a) := \begin{pmatrix} 1 & 0 \\ a & 1 \end{pmatrix}$ a 1 $\overline{ }$, $a \in A$. Let $GE_2(A)$ be the subgroup of $GL_2(A)$ generated by diagonal and elementary matrices. It is easy to see that $E_2(A)$ is normal in $GE_2(A)$ [\[3,](#page-17-3) Proposition 2.1] and the center of $GE_2(A)$ is $A^{\times}I_2$. We say that A is a GE_2 -ring if $GE_2(A) = GL_2(A)$. Semilocal rings and euclidean domains are examples of GE₂-rings $[20, p. 245]$, $[3, §2]$.

We call
$$
\mathbf{u} = \begin{pmatrix} u_1 \\ u_2 \end{pmatrix} \in A^2
$$
 a GE₂-unimodular vector if there exists a vector $\mathbf{v} = \begin{pmatrix} v_1 \\ v_2 \end{pmatrix} \in A^2$
such that $(\mathbf{u}, \mathbf{v}) := \begin{pmatrix} u_1 & v_1 \\ \vdots & \vdots \\ u_n & v_n \end{pmatrix} \in \text{GE}_2(A)$. For any non-negative integer n, let $Y_n(A^2)$ be the

 $\begin{pmatrix} u_1 & v_1 \ u_2 & v_2 \end{pmatrix} \in \text{GE}_2(A)$. For any non-negative integer n, let $Y_n(A^2)$ be the free abelian group generated by the set of all $(n + 1)$ -tuples $(\langle v_0 \rangle, \ldots, \langle v_n \rangle)$, where every vector $\mathbf{v}_i \in A^2$ is GE₂-unimodular and for any $i \neq j$, $(\mathbf{v}_i, \mathbf{v}_j) \in \text{GE}_2(A)$.

We consider $Y_l(A^2)$ as a left $GE_2(A)$ -module (resp. left $E_2(A)$ -module) in a natural way. If necessary, we convert this action to a right action by the definition $m.g := g^{-1}m$. Let us define the l-th differential operator

$$
\partial_l: Y_l(A^2) \to Y_{l-1}(A^2), \quad l \ge 1,
$$

as an alternating sum of face operators which throws away the i-th component of generators. Hence we have the complex

$$
Y_{\bullet}(A^2): \cdots \longrightarrow Y_2(A^2) \stackrel{\partial_2}{\longrightarrow} Y_1(A^2) \stackrel{\partial_1}{\longrightarrow} Y_0(A^2) \to 0.
$$

We say that the above complex is exact in dimension k if $H_k(Y_{\bullet}(A^2)) = 0$. Let $\partial_{-1} = \varepsilon$: $Y_0(A^2) \to \mathbb{Z}$ be defined by $\sum_i n_i({\langle v_{0,i} \rangle}) \mapsto \sum_i n_i$.

Proposition 1.1 (Hutchinson). For any commutative ring A, $H_0(Y_{\bullet}(A^2)) \stackrel{\bar{\varepsilon}}{\simeq} \mathbb{Z}$. In other words, the complex $Y_1(A^2) \xrightarrow{\partial_1} Y_0(A^2) \xrightarrow{\varepsilon} \mathbb{Z} \to 0$ always is exact.

Proof. See [\[11,](#page-17-8) Theorem 3.3] or [\[18,](#page-17-9) Proposition 2.1].

Let $Z_1(A^2) := \text{ker}(\partial_1)$. From the complex $0 \to Z_1(A^2) \stackrel{\text{inc}}{\to} Y_1(A^2) \stackrel{\partial_1}{\to} Y_0(A^2) \to 0$, we obtain the double complex

$$
0 \to B_{\bullet}(\mathcal{E}_2(A)) \otimes_{\mathcal{E}_2(A)} Z_1(A^2) \to B_{\bullet}(\mathcal{E}_2(A)) \otimes_{\mathcal{E}_2(A)} Y_1(A^2) \to B_{\bullet}(\mathcal{E}_2(A) \otimes_{\mathcal{E}_2(A)} Y_0(A^2) \to 0,
$$

where $B_{\bullet}(\mathcal{E}_2(A)) \to \mathbb{Z}$ is the bar resolution of \mathbb{Z} over $\mathcal{E}_2(A)$. This gives us the first quadrant

where $B_{\bullet}(E_2(A)) \to \mathbb{Z}$ is the bar resolution of \mathbb{Z} over $E_2(A)$. This gives us the first quadrant spectral sequence

$$
E_{p,q}^1 = \begin{cases} H_q(\mathcal{E}_2(A), Y_p(A^2)) & p = 0, 1 \\ H_q(\mathcal{E}_2(A), Z_1(A^2)) & p = 2 \\ 0 & p > 2 \end{cases} \implies H_{p+q}(\mathcal{E}_2(A), \mathbb{Z})
$$

(see [\[2,](#page-17-5) §5, Chap. VII] or $[13, §1]$).

The group $E_2(A)$ acts transitively on the sets of generators of $Y_i(A^2)$ for $i = 0, 1$. Let

$$
\infty := \langle e_1 \rangle, \quad \mathbf{0} := \langle e_2 \rangle, \quad \mathbf{a} := \langle e_1 + a e_2 \rangle, \quad a \in A^{\times},
$$

where $e_1 := \begin{pmatrix} 1 \\ 0 \end{pmatrix}$ 0) and $e_2 := \begin{pmatrix} 0 \\ 1 \end{pmatrix}$ 1 $\overline{}$. We choose (∞) and $(\infty, 0)$ as representatives of the orbit of the generators of $Y_0(A^2)$ and $Y_1(A^2)$, respectively. Then

$$
Y_0(A^2) \simeq \mathrm{Ind}_{\mathrm{B}(A)}^{\mathrm{E}_2(A)} \mathbb{Z}, \qquad Y_1(A^2) \simeq \mathrm{Ind}_{\mathrm{T}(A)}^{\mathrm{E}_2(A)} \mathbb{Z},
$$

where

$$
B(A) := Stab_{E_2(A)}(\boldsymbol{\infty}) = \left\{ \begin{pmatrix} a & b \\ 0 & a^{-1} \end{pmatrix} : a \in A^{\times}, b \in A \right\},\
$$

$$
T(A) := Stab_{E_2(A)}(\boldsymbol{\infty}, \mathbf{0}) = \left\{ D(a) : a \in A^{\times} \right\},
$$

where $D(a) := \begin{pmatrix} a & 0 \\ 0 & a \end{pmatrix}$ 0 a^{-1} (see [\[2,](#page-17-5) §3, Chap. I]). Note that $T(A) \simeq A^{\times}$ and $B(A) \simeq A \rtimes A^{\times}$. In our calculations usually we identify $T(A)$ with A^{\times} . By Shapiro's lemma we have

$$
E_{0,q}^1 \simeq H_q(\mathcal{B}(A),\mathbb{Z}), \qquad E_{1,q}^1 \simeq H_q(\mathcal{T}(A),\mathbb{Z}).
$$

In particular, $E_{0,0}^1 \simeq \mathbb{Z} \simeq E_{1,0}^1$. Moreover, $d_{1,q}^1 = H_q(\sigma) - H_q(\text{inc})$, where $\sigma : T(A) \to B(A)$ is given by $\sigma(D(a)) = wD(a)w^{-1} = D(a^{-1})$ for $w =$ $\begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}$. This easily implies that $d_{1,0}^1$ is trivial and

$$
l_{1,1}^1: \mathrm{T}(A) \to \mathrm{B}(A)^{ab} = H_1(\mathrm{B}(A), \mathbb{Z}), \qquad D(a) \mapsto D(a)^{-2}.
$$

In fact, note that

 ϵ

$$
B(A)^{ab} \simeq T(A) \oplus A_{A^{\times}} \simeq A^{\times} \oplus A_{A^{\times}},
$$

where

$$
A_{A^\times} = A/\langle a^2 - 1 : a \in A^\times \rangle.
$$

Thus $d_{1,1}^1(D(a)) = (D(a)^{-2}, 0)$. This implies that

$$
E_{0,1}^2 \simeq \mathcal{G}_A \oplus A_{A^\times}, \quad \ker(d_{1,1}^1) \simeq \mu_2(A).
$$

Furthermore, it is not difficult to see that $d_{2,1}^1: H_1(\mathrm{E}_2(A), Z_1(A^2)) \to \mu_2(A)$ is surjective. In fact, for any $b \in \mu_2(A)$, we have

$$
d_{2,1}^1([b] \otimes \partial_2(\boldsymbol{\infty}, \boldsymbol{0}, \boldsymbol{a})) = b.
$$

Therefore $E_{1,1}^2 = 0$.

The orbits of the action of $E_2(A)$ on $Y_2(A)$ are represented by

 $\langle a \rangle$ [] := $(\infty, 0, a), \quad \langle a \rangle \in \mathcal{G}_A$.

Therefore $Y_2(A^2)_{\mathrm{E}_2(A)} \simeq \mathbb{Z}[\mathcal{G}_A]$. Moreover, the map

$$
\mathbb{Z}[\mathcal{G}_A] \simeq Y_2(A^2)_{\mathcal{E}_2(A)} \to Y_1(A^2)_{\mathcal{E}_2(A)} \simeq \mathbb{Z}
$$

coincides with the augmentation map. Now from the composite

$$
\mathbb{Z}[\mathcal{G}_A] \simeq Y_2(A^2)_{\mathcal{E}_2(A)} \to Z_1(A^2)_{\mathcal{E}_2(A)} \to Y_1(A^2)_{\mathcal{E}_2(A)} \simeq \mathbb{Z}
$$

it follows that $d_{2,0}^1: H_0(\mathbb{E}_2(A), Z_1(A^2)) \to \mathbb{Z}$ is surjective. Hence $E_{1,0}^2 = 0$. Let

$$
GW(A) := H_0(E_2(A), Z_1(A^2)), \quad \epsilon := d_{2,0}^1 : GW(A) \to \mathbb{Z}.
$$

We denote the kernel of ϵ by $I(A)$. Let

$$
\overline{\mathrm{GW}}(A):=\mathbb{Z}[\mathcal{G}_A]/\langle\langle\!\langle a\rangle\!\rangle\langle\!\langle 1-a\rangle\!\rangle : a\in\mathcal{W}_A\rangle.
$$

The augmentation map $\mathbb{Z}[\mathcal{G}_A] \to \mathbb{Z}$ induces the natural map $\bar{\epsilon}: \overline{GW}(A) \to \mathbb{Z}$. The kernel of this map is denoted by $\overline{I}(A)$. Note that

$$
\bar{I}(A) := \mathcal{I}_A/\langle \langle a \rangle \rangle \langle 1 - a \rangle : a \in \mathcal{W}_A \rangle,
$$

where \mathcal{I}_A is the augmentation ideal of $\mathbb{Z}[\mathcal{G}_A].$

From the exact sequence $0 \to B_1(A^2) \to Z_1(A^2) \to H_1(Y_{\bullet}(A^2)) \to 0$, we obtain the exact sequence

$$
H_0(\mathcal{E}_2(A), B_1(A^2)) \to \text{GW}(A) \to H_1(Y_\bullet(A^2))_{\mathcal{E}_2(A)} \to 0.
$$

From the sequence $Y_3(A^2) \to Y_2(A^2) \to B_1(A^2)$ we obtain the sequence

$$
H_0(E_2(A), Y_3(A^2)) \to H_0(E_2(A), Y_2(A^2)) \to H_0(E_2(A), B_1(A^2)).
$$

We showed in above that $Y_2(A^2)_{E_2(A)} \simeq \mathbb{Z}[\mathcal{G}_A]$. The orbits of the action of $E_2(A)$ on $Y_3(A)$ are represented by

$$
\langle a \rangle [x] := (\boldsymbol{\infty}, \boldsymbol{0}, \boldsymbol{a}, \boldsymbol{ax}), \ \ \langle a \rangle \in \mathcal{G}_A, x \in \mathcal{W}_A.
$$

Thus $Y_3(A^2)_{\mathrm{E}_2(A)}$ is the free $\mathbb{Z}[\mathcal{G}_A]$ -module generated by the symbols $[x], x \in \mathcal{W}_A$. Moreover the map

$$
Y_3(A^2)_{\mathcal{E}_2(A)} \to Y_2(A^2)_{\mathcal{E}_2(A)} \simeq \mathbb{Z}[\mathcal{G}_A]
$$

is given by $[x] \mapsto \langle x \rangle \langle 1 - x \rangle$. All these induce a surjective map

$$
\overline{\mathrm{GW}}(A) \twoheadrightarrow H_0(\mathrm{E}_2(A), B_1(A^2)).
$$

Thus we have the exact sequence

$$
\overline{\mathrm{GW}}(A) \to \mathrm{GW}(A) \to H_1(Y_\bullet(A^2))_{\mathrm{E}_2(A)} \to 0.
$$

Finally from this we obtain the exact sequence

(1.1) $\bar{I}(A) \to I(A) \to H_1(Y_{\bullet}(A^2))_{E_2(A)} \to 0.$

2. THE FIRST HOMOLOGY OF E_2

The following theorem first was proved in $[16,$ Theorem 3.1]. Here we present a new proof of the theorem using the spectral sequence $E_{\bullet,\bullet}$ introduced in the previous section.

Theorem 2.1. Let A be a commutative ring and M the additive subgroup of A generated by $x(a^2-1)$ and $3(b+1)(c+1)$, where $x \in A$ and $a, b, c \in A^{\times}$. Then there is an exact sequence of \mathcal{G}_A -modules

$$
H_2(\mathcal{E}_2(A), \mathbb{Z}) \to H_1(Y_{\bullet}(A^2))_{\mathcal{E}_2(A)} \to A/M \to H_1(\mathcal{E}_2(A), \mathbb{Z}) \to 0.
$$

Proof. The second page of the spectral sequence $E_{\bullet,\bullet}$ is as follows:

$$
H_2(B(A), \mathbb{Z})
$$

\n $d_{2,1}^2$ * 0
\n $d_{2,0}^2$ $E_{2,1}^2$ 0
\n \mathbb{Z} 0 $I(A)$ 0

Now by an easy analysis of the above spectral sequence, we obtain the exact sequence

$$
H_2(\mathcal{B}(A),\mathbb{Z}) \to H_2(\mathcal{E}_2(A),\mathbb{Z}) \to I(A) \xrightarrow{d_{2,0}^2} \mathcal{G}_A \oplus A_{A^\times} \to H_1(\mathcal{E}_2(A),\mathbb{Z}) \to 0.
$$

Let study the composite map $\bar{I}(A) \to I(A) \stackrel{d_2^2}{\longrightarrow} \mathcal{G}_A \oplus A_{A^{\times}}$. Take the element $\langle \langle a \rangle \rangle \in \bar{I}(A)$, $a \in A^{\times}$. This is represented by

$$
X_a := [] \otimes ((\boldsymbol{\infty}, \boldsymbol{0}, \boldsymbol{a}) - (\boldsymbol{\infty}, \boldsymbol{0}, \boldsymbol{1})) \in B_0(\mathrm{E}_2(A)) \otimes_{\mathrm{E}_2(A)} Y_2(A^2).
$$

By passing to $I(A)$, the image of $\langle \langle a \rangle \rangle$ is represented by

$$
[\] \otimes \partial_2((\boldsymbol{\infty}, \boldsymbol{0}, \boldsymbol{a}) - (\boldsymbol{\infty}, \boldsymbol{0}, \boldsymbol{1})) \in B_0(\mathrm{E}_2(A)) \otimes_{\mathrm{E}_2(A)} Z_1(A^2),
$$

which we denote it again by X_a . Thus $d_{2,0}^2(\langle\!\langle a \rangle\!\rangle) = d_{2,0}^2(\overline{X_a})$. To calculate the above composition we look at the diagram

$$
B_1(E_2(A)) \otimes Y_0(A^2) \xleftarrow{\text{id} \otimes \partial_1} B_1(E_2(A)) \otimes Y_1(A^2)
$$

$$
\downarrow d_1 \otimes \text{id}
$$

$$
B_0(E_2(A)) \otimes Y_1(A^2) \xleftarrow{\text{id} \otimes \text{inc}} B_0(E_2(A)) \otimes Z_1(A^2).
$$

We have

$$
(\mathrm{id}_{B_0(\mathrm{E}_2(A))}\otimes \mathrm{inc})(X_a) = [\]\otimes ((\mathbf{0},\mathbf{a}) - (\infty,\mathbf{a}) - (\mathbf{0},\mathbf{1}) + (\infty,\mathbf{1}))
$$

$$
= [\]\otimes (g_a(\infty,\mathbf{0}) - h_a(\infty,\mathbf{0}) - g_1(\infty,\mathbf{0}) + h_1(\infty,\mathbf{0}))
$$

$$
= (g_a^{-1} - h_a^{-1} - g_1^{-1} + h_1^{-1})[\]\otimes (\infty,\mathbf{0}),
$$

where $g_a =$ $(0 1$ −1 a $\overline{ }$ $h_a =$ $\begin{pmatrix} 1 & a^{-1} \\ 0 & 1 \end{pmatrix}$. This element sits in the image of $d_1 \otimes id_{Y_1(A^2)}$. In fact

 $(d_1 \otimes id_{Y_1(A^2)})(([g_a^{-1}]-[h_a^{-1}]-[g_1^{-1}]+[h_1^{-1}]) \otimes (\infty, \mathbf{0})) = (g_a^{-1} - h_a^{-1} - g_1^{-1} + h_1^{-1})[\] \otimes (\infty, \mathbf{0}).$ Finally $(id_{B_1(E_2(A))}\otimes \partial_1)(([g_a^{-1}]-[h_a^{-1}]-[g_1^{-1}]+[h_1^{-1}])\otimes (\infty,0))$ represents $d_{2,0}^2(\langle \langle a \rangle \rangle)$. This is the element

$$
\Big(w([g_a^{-1}]-[h_a^{-1}]-[g_1^{-1}]+[h_1^{-1}])-([g_a^{-1}]-[h_a^{-1}]-[g_1^{-1}]+[h_1^{-1}])\Big) \otimes (\infty) \in B_1(\mathcal{E}_2(A)) \otimes Y_0(A^2).
$$

By adding the null element $(d_2 \otimes id_{Y_0(A^2)})(([w|h_a^{-1}] - [w|g_a^{-1}] + [w|g_1^{-1}] - [w|h_1^{-1}]) \otimes (\infty)),$ we see that $d_{2,0}^2(\langle\!\langle a \rangle\!\rangle)$ is represented by

$$
([wg_a^{-1}] - [wh_a^{-1}] - [wg_1^{-1}] + [wh_1^{-1}] - [g_a^{-1}] + [h_a^{-1}] + [g_1^{-1}] - [h_1^{-1}]) \otimes (\infty).
$$

Now by adding the null element $(d_2 \otimes id_{Y_0(A^2)})(([D(a)^{-1}h_{a^{-1}}^{-1}|wh_a^{-1}]-[h_1^{-1}|wh_1^{-1}]) \otimes (\infty))$ (note that $D(z)^{-1}h_{z^{-1}}^{-1} \in B(A) = \text{Stab}_{\text{E}_2(A)}(\boldsymbol{\infty})$ and $D(z)^{-1}h_{a^{-1}}^{-1}wh_a^{-1} = wg_a^{-1}$), we see that $d_{2,0}^2(\langle\!\langle a \rangle\!\rangle)$ is represented by

$$
([D(a)^{-1}h_{a^{-1}}^{-1}]-[h_1^{-1}]-[g_a^{-1}]+[h_a^{-1}]+[g_1^{-1}]-[h_1^{-1}])\otimes(\infty).
$$

Once more, by adding the null element

$$
(d_2 \otimes id_{X_0(A^2)})(([h_1|-w]-[h_{a^{-1}}|-w]) \otimes (\infty)) = ([g_a^{-1}] - [h_{a^{-1}}] - [g_1^{-1}] + [h_1]) \otimes (\infty),
$$

we see that $d_{2,0}^2(\langle\!\langle a \rangle\!\rangle)$ is represented by

$$
([D(a)^{-1}h_{a^{-1}}^{-1}]-[h_1^{-1}]+[h_a^{-1}]-[h_1^{-1}]-[h_{a^{-1}}]+[h_1])\otimes(\infty).
$$

Note that in $H_1(E_2(A), Y_0(A^2))$, if $g, h \in B(A)$, then

$$
[gh] \otimes (\infty) = ([g] + [h]) \otimes (\infty)
$$
 and $[h^{-1}] \otimes (\infty) = -[h] \otimes (\infty)$.

Thus $d_{2,0}^2(\langle\!\langle a \rangle\!\rangle)$ in $H_1(\mathrm{E}_2(A), Y_0(A^2))/\mathrm{im}(d_{1,1}^1)$ is represented by

$$
D(a)^{-1}h_{a^{-1}}^{-2}h_a^{-1}h_1^3] \otimes (\infty) = \left[\begin{pmatrix} a^{-1} & 0 \\ 0 & a \end{pmatrix} \begin{pmatrix} 1 & -2a - a^{-1} + 3 \\ 0 & 1 \end{pmatrix} \right] \otimes (\infty).
$$

Therefore in $\mathcal{G}_A \oplus A_{A^{\times}}$ we have

 $\sqrt{ }$

$$
d_{2,0}^2(\langle\!\langle a\rangle\!\rangle) = (\langle a^{-1}\rangle, \overline{-2a - a^{-1} + 3}) = (\langle a\rangle, \overline{3(1-a)}) = 3(\langle a\rangle, \overline{1-a}).
$$

Thus we get the exact sequence

$$
H_2(\mathrm{E}_2(A),\mathbb{Z}) \to I(A)/\overline{I}(A) \to \frac{\mathcal{G}_A \oplus A_{A^\times}}{\langle (\langle b \rangle, 3(b-1)) | b \in A^\times \rangle} \to H_1(\mathrm{E}_2(A),\mathbb{Z}) \to 0.
$$

The map

$$
\frac{A}{M} \to \frac{\mathcal{G}_A \oplus A_{A^{\times}}}{\langle (\langle b \rangle, 3(b-1)) | b \in A^{\times} \rangle}, \quad \overline{a} \mapsto \overline{(\langle 1 \rangle, \overline{a})},
$$

is an isomorphism with the inverse map

$$
\frac{\mathcal{G}_A \oplus A_{A^{\times}}}{\langle (\langle b \rangle, 3(b-1)) | b \in A^{\times} \rangle} \to \frac{A}{M}, \quad \overline{(\langle b \rangle, \overline{a})} \mapsto \overline{a - 3b + 3}.
$$

Now (1.1) completes the proof of the theorem.

The Steinberg group St(2, A) is the group with generators $x_{12}(r)$ and $x_{21}(s)$, $r, s \in A$, subject to the Steinberg relations

- (α) $x_{ij}(r)x_{ij}(s) = x_{ij}(r+s)$ for any $r, s \in A$, (β) $w_{ij}(u)x_{ji}(r)w_{ij}(u)^{-1} = x_{ij}(-u^2r)$, for any $u \in A^{\times}$ and $r \in A$,
- where $w_{ij}(u) := x_{ij}(u)x_{ji}(-u^{-1})x_{ij}(u)$.

The map $St(2, A) \rightarrow E_2(A)$ given by $x_{ij}(r) \rightarrow E_{ij}(r)$, is a well defined homomorphism of groups. The unstable K_2 -group of order 2 is the kernel of this map and is denoted by $K_2(2, A)$. For $u \in A^{\times}$, let $h_{ij}(u) := w_{ij}(u)w_{ij}(-1)$. An element of the form

$$
\{v, u\} := \{v, u\}_{12} = h_{12}(uv)h_{12}^{-1}(u)h_{12}(v)^{-1}
$$

is called a Steinberg symbol. This is an element of $K_2(2, A)$ and is a central element of St(2, A) [\[6,](#page-17-11) §9]. Let $C(2, A)$ be the subgroup of $K_2(2, A)$ generated by the Steinberg symbols.

Proposition 2.2 (Hutchinson). For any commutative ring A, we have

$$
H_1(Y_{\bullet}) \simeq \Big(\frac{K_2(2,A)}{C(2,A)}\Big)^{\text{ab}}.
$$

Proof. See [\[11,](#page-17-8) Theorem 7.2].

A ring A is called universal for GE_2 if $K_2(2, A)$ is generated by Steinberg symbols $[6,$ p. 251. Thus if A is universal for GE_2 , then

$$
H_1(\mathrm{E}_2(A),\mathbb{Z})\simeq A/M.
$$

Example 2.3. A commutative semilocal ring A is universal for GE_2 if and only if none of the rings $\mathbb{Z}/2 \times \mathbb{Z}/2$ and $\mathbb{Z}/2 \times \mathbb{Z}/3$ is a direct factor of $A/J(A)$ [\[12,](#page-17-12) Theorem 2.14], where $J(A)$ is the Jacobson radical of A. Thus if A is semilocal with the above condition, then

$$
H_1(\mathrm{E}_2(A),\mathbb{Z})\simeq A/M.
$$

(i) If A is a local ring with maximal ideal m_A , then

$$
H_1(\mathrm{E}_2(A),\mathbb{Z})\simeq\begin{cases} A/\mathfrak{m}_A^2&\text{if }|A/\mathfrak{m}_A|=2\\ A/\mathfrak{m}_A&\text{if }|A/\mathfrak{m}_A|=3\\ 0&\text{if }|A/\mathfrak{m}_A|\geq 4\end{cases}
$$

(see $[16,$ Proposition 4.1]).

(ii) If A is semilocal such that all its residue fields have more than three elements, i.e. $|A/\mathfrak{m}| > 3$ for all $\mathfrak{m} \in \text{Specm}(A)$, then there is an element $a \in A^{\times}$ such that $a^2 - 1 \in A^{\times}$. Thus $A = M$ and hence

$$
H_1(\mathrm{E}_2(A),\mathbb{Z})=0.
$$

(iii) If A is Artinian, then $A \simeq A_1 \times \cdots \times A_r$, where each A_i is Artinian local rings (see [\[1,](#page-17-13) Theorem 8.7]). Hence $E_2(A) \simeq E_2(A_1) \times \cdots \times E_2(A_r)$ and thus

$$
H_1(\mathrm{E}_2(A),\mathbb{Z}) \simeq H_1(\mathrm{E}_2(A_1),\mathbb{Z}) \times \cdots \times H_1(\mathrm{E}_2(A_r),\mathbb{Z}).
$$

Now using (i) we can calculate $H_1(E_2(A), \mathbb{Z})$. For more applications of the above theorem see $[16]$.

3. THE SECOND HOMOLOGY OF E_2

We have seen in the proof of Theorem [2.1](#page-4-0) that the composite $\bar{I}(A) \to I(A) \stackrel{d_{2,0}^2}{\longrightarrow} \mathcal{G}_A \oplus A_{A^\times}$, takes $\langle \langle a \rangle \rangle \in \overline{I}(A), a \in A^{\times}$, to the element $(\langle a \rangle, 3\overline{(1-a)})$.

Let either $2 \in A^{\times}$ or $A_{A^{\times}} = 0$. In both cases $3(1-a) = 0$ in $A_{A^{\times}}$. So the above composite sends $\langle \langle a \rangle \rangle$ to $(\langle a \rangle, 0)$. Note that if $2 \in A^{\times}$, then we have a surjective map of abelian groups $A/3A \rightarrow A_{A^{\times}}$, since $3 = 2^2 - 1$.

Denote the kernel of $d_{2,0}^2: I(A) \to \mathcal{G}_A \oplus A_{A^{\times}},$ by $I^2(A)$, i.e.

$$
I^2(A) := \ker(d_{2,0}^2).
$$

We know that $\bar{I}(A)/\bar{I}^2(A) \simeq \mathcal{G}_A$ [\[21,](#page-17-14) Theorem 6.1.11]. Consider the commutative diagram with exact rows

$$
0 \longrightarrow \overline{I}^2(A) \longrightarrow \overline{I}(A) \longrightarrow \mathcal{G}_A \longrightarrow 0
$$

$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow
$$

$$
0 \longrightarrow I^2(A) \longrightarrow I(A) \longrightarrow \mathcal{G}_A \oplus A_{A^{\times}},
$$

where the right vertical map is given by $\langle a \rangle \mapsto (\langle a \rangle, 0)$. By the Snake Lemma and [\(1.1\)](#page-4-1) we obtain the exact sequence

(3.1)
$$
\bar{I}^2(A) \to I^2(A) \to H_1(Y_{\bullet}(A^2))_{E_2(A)} \to A_{A^{\times}}.
$$

Lemma 3.1. If $A_{A^{\times}} = 0$, then we have the exact sequence

$$
\overline{I}^2(A) \to I^2(A) \to H_1(Y_\bullet(A^2))_{\mathcal{E}_2(A)} \to 0.
$$

Proof. This follows immediately from the above exact sequence. \Box

On the other hand, by an easy analysis of the main spectral sequence we have the exact sequence

(3.2)
$$
H_2(\mathcal{B}(A), \mathbb{Z}) \to H_2(\mathcal{E}_2(A), \mathbb{Z}) \to I^2(A) \to 0.
$$

We denote the image of $\langle\langle a \rangle\rangle \langle\langle b \rangle\rangle \in \overline{I}^2(A)$ in $I^2(A)$ again by $\langle\langle a \rangle\rangle \langle\langle b \rangle\rangle$. Now we lift $\langle\langle a \rangle\rangle \langle\langle b \rangle\rangle \in$ $I^2(A)$ to an element of $H_2(E_2(A), \mathbb{Z})$ through the surjective map

$$
H_2(\mathrm{E}_2(A),\mathbb{Z}) \to I^2(A).
$$

Lemma 3.2. Let A be a commutative ring with $2 \in A^{\times}$. If $a, b \in A^{\times}$, then under the surjective map

$$
H_2(\mathcal{E}_2(A),\mathbb{Z}) \to I^2(A),
$$

the homology class of the cycles $([D(a)|D(b)] + R_{ab} - R_a - R_b + R_1) \otimes 1$ maps to $\langle \langle a \rangle \rangle \langle \langle b \rangle \rangle \in$ $I^2(A)$, where for any $z \in A^{\times}$,

$$
R_z := [w|g_z^{-1}] - [w|h_z^{-1}] - [h_z^{-1}D(z)^{-1}|wh_z^{-1}] + [h_{z^{-1}}|w^{-1}] - [h_z^{-1}|D(z)^{-1}] + [D(z)h_z|D(z)^{-1}]
$$

$$
-[D(z)h_z|h_z^{-1}] + 2[h_z^{-1}|h_z^{-1}] + [h_z^{-2}|h_z^{-2}] + [D(2)h_z^{-1}D(2)^{-1}|D(2)] - [D(2)|h_z^{-1}]
$$

with $g_z = \begin{pmatrix} 0 & 1 \\ -1 & z \end{pmatrix}$ and $h_z = \begin{pmatrix} 1 & z^{-1} \\ 0 & 1 \end{pmatrix}$.

Proof. We know that $I^2(A) \subseteq I(A) \subseteq GW(A) = H_0(E_2(A), Z_1(A^2))$. So we need to study the map

$$
H_2(E_2(A), \mathbb{Z}) \to H_0(E_2(A), Z_1(A^2)).
$$

From the exact sequence $0 \to Z_1(A^2) \to Y_1(A^2) \to Y_0(A^2) \to \mathbb{Z} \to 0$ we obtain two short exact sequences

$$
0 \to Z_1(A^2) \to Y_1(A^2) \to Z_0(A^2) \to 0, \qquad 0 \to Z_0(A^2) \to Y_0(A^2) \to \mathbb{Z} \to 0.
$$

From these we obtain the connecting homomorphisms

$$
\delta_1: H_2(\mathcal{E}_2(A), \mathbb{Z}) \to H_1(\mathcal{E}_2(A), Z_0(A^2)),
$$

$$
\delta_2: H_1(\mathcal{E}_2(A), Z_0(A^2)) \to H_0(\mathcal{E}_2(A), Z_1(A^2)).
$$

Then

$$
\delta_2 \circ \delta_1 : H_2(\mathcal{E}_2(A), \mathbb{Z}) \to H_0(\mathcal{E}_2(A), Z_1(A^2))
$$

is the above mentioned map. For $z \in A^{\times}$, the element $\langle\langle z \rangle\rangle \in I(A)$ is represented by $[] \otimes \partial_2(X_z - X_1),$ where $X_z := (\infty, 0, z)$. Consider the diagram

$$
B_1(E_2(A)) \otimes_{E_2(A)} Z_0(A^2) \xleftarrow{\mathrm{id}_{B_1} \otimes \partial_1} B_1(E_2(A)) \otimes_{E_2(A)} Y_1(A^2) \downarrow \qquad \downarrow d_1 \otimes \mathrm{id}_{Y_1} \downarrow \qquad B_0(E_2(A)) \otimes_{E_2(A)} Y_1(A^2) \xleftarrow{\mathrm{id}_{B_0} \otimes \mathrm{inc}} B_0(E_2(A)) \otimes_{E_2(A)} Z_1(A^2).
$$

Then

$$
(\mathrm{id}_{B_0} \otimes \mathrm{inc})\Big([\] \otimes \partial_2(X_z - X_1)\Big) = [\] \otimes \Big((\mathbf{0},\mathbf{z}) - (\mathbf{\infty},\mathbf{z}) - (\mathbf{0},\mathbf{1}) + (\mathbf{\infty},\mathbf{1})\Big) = [\] \otimes \Big((g_z - h_z - g_1 + h_1)(\mathbf{\infty},\mathbf{0})\Big) = (d_1 \otimes \mathrm{id}_{Y_1(A^2)}) \Big(([g_z^{-1}] - [h_z^{-1}] - [g_1^{-1}] + [h_1^{-1}]) \otimes (\mathbf{\infty},\mathbf{0})\Big).
$$

Thus the element

$$
U_z := (\mathrm{id}_{B_1} \otimes \partial_1) \Big(([g_z^{-1}] - [h_z^{-1}] - [g_1^{-1}] + [h_1^{-1}]) \otimes (\boldsymbol{\infty}, \mathbf{0}) \Big)
$$

=
$$
([g_z^{-1}] - [h_z^{-1}] - [g_1^{-1}] + [h_1^{-1}]) \otimes \partial_1 (\boldsymbol{\infty}, \mathbf{0})
$$

represents an element of $H_1(E_2(A), Z_0(A^2))$, where maps to $\langle\!\langle z \rangle\!\rangle$ through δ_2 . Now consider the diagram

$$
B_2(\mathrm{E}_2(A)) \otimes_{\mathrm{E}_2(A)} \mathbb{Z} \stackrel{\mathrm{id}_{B_2} \otimes \varepsilon}{\longleftarrow} B_2(\mathrm{E}_2(A)) \otimes_{\mathrm{E}_2(A)} Y_0(A^2)
$$

$$
\downarrow d_2 \otimes \mathrm{id}_{Y_0}
$$

$$
B_1(\mathrm{E}_2(A)) \otimes_{\mathrm{E}_2(A)} Y_0(A^2) \stackrel{\mathrm{id}_{B_1} \otimes \mathrm{inc}}{\longleftarrow} B_1(\mathrm{E}_2(A)) \otimes_{\mathrm{E}_2(A)} Z_0(A^2).
$$

Then we have

$$
(\mathrm{id}_{B_1} \otimes \mathrm{inc})(U_z) = ([g_z^{-1}] - [h_z^{-1}] - [g_1^{-1}] + [h_1^{-1}]) \otimes \partial_1(\boldsymbol{\infty}, \mathbf{0})
$$

$$
= (w - 1)([g_z^{-1}] - [h_z^{-1}] - [g_1^{-1}] + [h_1^{-1}]) \otimes (\boldsymbol{\infty})
$$

$$
= -[D(z)] + (d_2 \otimes \mathrm{id}_{Y_0(A^2)}) ((R_z - R_1) \otimes (\boldsymbol{\infty})).
$$

Note that in our calculation we used the formulas

$$
wg_z^{-1} = D(z)^{-1}h_{z^{-1}}^{-1}wh_z^{-1}, \qquad D(z)h_u D(z)^{-1} = h_{u/z^2},
$$

with $u, z \in A^{\times}$. Now it is easy to see that

$$
(d_2 \otimes id_{Y_0(A^2)}) \Big(([D(a)|D(b)] + R_{ab} - R_a - R_b + R_1) \otimes (\infty) \Big) = (id_{B_1} \otimes inc)(U_{ab} - U_a - U_b).
$$

Finally, applying $id_{B_2} \otimes \varepsilon$ we have

$$
(\mathrm{id}_{B_2}\otimes\varepsilon)\Big(([D(a)|D(b)]+R_{ab}-R_a-R_b+R_1)\otimes(\infty)\Big)=([D(a)|D(b)]+R_{ab}-R_a-R_b+R_1)\otimes1.
$$

The element $([D(a)|D(b)] + R_{ab} - R_a - R_b + R_1) \otimes 1$ is a cycle and represents an element in $H_2(E_2(A), \mathbb{Z})$ which maps to $\langle\!\langle a \rangle\!\rangle \langle\!\langle b \rangle\!\rangle \in I^2(A)$. This completes the proof of the lemma. \Box

Remark 3.3. In [\[9,](#page-17-15) §7] Hutchinson has constructed a similar cycles as in above lemma over fields. Let F be a field with at least four elements. Let $a, b \in F^{\times}$ and $\lambda \in F^{\times}$ such that $\lambda^2 - 1 \in F^{\times}$. Then Hutchinson has constructed a cycle

$$
F(a,b)_\lambda \in B_2(\mathit{{\rm SL}}_2(F)) \otimes_{\mathit{{\rm SL}}_2(F)} \mathbb{Z}
$$

such that its homology class in $H_2(SL_2(F),\mathbb{Z})$ is independent of the choice of λ and maps to $\langle\!\langle a \rangle\!\rangle \langle\!\langle b \rangle\!\rangle \in I^2(F)$ (see [\[9,](#page-17-15) Proposition 7.1, Lemma 7.5, Theorem 7.8]). (Note that the existence of $\lambda \in A^{\times}$ such that $\lambda^2 - 1 \in A^{\times}$ implies that $A_{A^{\times}} = 0$.)

Theorem 3.4. Let A be a semilocal ring such that $2 \in A^{\times}$ and all its residue fields have more that four elements. Then the group $H_2(E_2(A),\mathbb{Z})$ is generated by the homology class of the cycles $([D(a)|D(b)] + R_{ab} - R_a - R_b + R_1), ([D(a)|D(b)] - [D(b)|D(a)]), a, b \in A^{\times},$ and $([E_{12}(x)|E_{12}(y)] - [E_{12}(y)|E_{12}(x)]$, $x, y \in A$.

Proof. Since A is universal for GE_2 (see Example [2.3\)](#page-7-0), by Proposition [2.2,](#page-6-0) $H_1(Y_{\bullet}(A^2)) = 0$. Thus by Lemma [3.1,](#page-8-0) the map $\bar{I}^2(A) \to I^2(A)$ is surjective. This shows that $I^2(A)$ is generated by the elements of the form $\langle \langle a \rangle \rangle \langle \langle b \rangle \rangle$, $a, b \in A^{\times}$.

Now consider the exact sequence

$$
H_2(\mathcal{B}(A),\mathbb{Z}) \to H_2(\mathcal{E}_2(A),\mathbb{Z}) \stackrel{\theta}{\to} I^2(A) \to 0.
$$

Let $X \in H_2(E_2(A), \mathbb{Z})$ and let

$$
\theta(X) = \sum \langle a_i \rangle \rangle \langle b_i \rangle.
$$

If $F(a, b) := (D(a)|D(b)] + R_{ab} - R_a - R_b + R_1$, then $\theta(X - \sum \overline{F(a_i, b_i)}) = 0$. It follows from this that $X - \sum \overline{F(a_i, b_i)}$ sits in the image of $H_2(B(A), \mathbb{Z})$.

Consider the extension

$$
1 \to N(A) \to B(A) \to T(A) \to 1,
$$

where $N(A) := \left\{ \begin{pmatrix} 1 & b \\ 0 & 1 \end{pmatrix} : a \in A^{\times}, b \in A \right\}$. Since any residue field of A has more than four elements, there is $\lambda \in A^{\times}$ such that $\lambda^2 - 1 \in A^{\times}$. This implies that $A_{A^{\times}} = 0$. It follows from this that for any $k \geq 0$, $H_k(A^{\times}, A) = 0$ [\[14,](#page-17-0) Corollary 3.2]. By studying the Lyndon/Hochschild-Serre spectral sequence of this extension we obtain the exact sequence

$$
H_2(A,\mathbb{Z})_{A^\times} \to H_2(\mathcal{B}(A),\mathbb{Z}) \to H_2(\mathcal{T}(A),\mathbb{Z}) \to 0.
$$

Note that we have the splitting map inc_∗ : $H_2(T(A),\mathbb{Z}) \to H_2(B(A),\mathbb{Z})$. The image of $H_2(A,\mathbb{Z}) \simeq A \wedge A$ in $H_2(B(A),\mathbb{Z})$ is generated by the homology classes of the cycles

$$
G(x,y) := ([E_{12}(x)|E_{12}(y)] - [E_{12}(y)|E_{12}(x)]) \otimes 1, \quad x, y \in A.
$$

Moreover, $H_2(T(A),\mathbb{Z}) \simeq T(A) \wedge T(A)$ is generated by the homology classes of the cycles

$$
H(a, b) := ([D(a)|D(b)] - [D(b)|D(a)]) \otimes 1.
$$

Now the claim follows from the fact that $\ker(\theta)$ is generated by the images of the homology classes of the cycles $G(x, y)$ and $H(a, b)$. This completes the proof of the theorem.

4. THE MAP
$$
H_n(T(A), \mathbb{Z}) \to H_n(B(A), \mathbb{Z})
$$

In the previous sections, sometime we assumed that $A_{A^{\times}} = 0$, i.e. the ring A is generated be the elements of the form $a^2 - 1$, where $a \in A^{\times}$. It follows from this that the inclusion $T(A) \rightarrow B(A)$ induces the isomorphism

$$
H_1(\mathrm{T}(A),\mathbb{Z}) \simeq H_1(\mathrm{B}(A),\mathbb{Z}).
$$

In the next section we will need such isomorphism for the second and the third homology groups. Hutchinson has proved the following result over local domains [\[10,](#page-17-16) Proposition 3.19].

Proposition 4.1. Let A be a semilocal ring. For any maximal ideal $\mathfrak{m} \in \text{Specm}(A)$, let either A/\mathfrak{m} be infinite or if $|A/\mathfrak{m}| = p^d$, then $(p-1)d > 2(n+1)$ $((p-1)d > 2n$ when A is a domain). Then $H_k(\mathrm{T}(A),\mathbb{Z}) \simeq H_k(\mathrm{B}(A),\mathbb{Z})$ for all $k \leq n$.

Proof. If A is a domain, then the proof is very similar to the proof of a similar result over local domains presented in [\[10,](#page-17-16) §3]. Just there one should replace the maximal ideal of the local domain (denoted by M in [\[10,](#page-17-16) §3]) with the Jacobson radical $J(A)$ of A.

Now let A be a general semilocal ring with the given condition. Then similar to the proof presented in [\[10,](#page-17-16) Proposition 3.19], we can show that $H_n(T(A), k) \simeq H_n(B(A), k)$, where k is a prime field and $(p-1)d > 2n$. Now the claim follows from [\[13,](#page-17-10) Lemma 2.3]. □

5. THE THIRD HOMOLOGY OF E_2

Let $\overline{\mathcal{RP}}(A)$ be the quotient of the free $\mathbb{Z}[\mathcal{G}_A]$ -module generated by symbols $[a], a \in \mathcal{W}_A$, by the $\mathbb{Z}[\mathcal{G}_A]$ -submodule generated by the elements

$$
[a] - [b] + \langle a \rangle \left[\frac{b}{a}\right] - \langle a^{-1} - 1 \rangle \left[\frac{1 - a^{-1}}{1 - b^{-1}}\right] + \langle 1 - a \rangle \left[\frac{1 - a}{1 - b}\right]
$$

,

where $a, b, a/b \in W_A$. By a direct computation one can show that the map

$$
\bar{\lambda}_1 : \overline{\mathcal{RP}}(A) \to \mathcal{I}_A^2 \subseteq \mathbb{Z}[\mathcal{G}_A], \qquad [a] \mapsto \langle \langle a \rangle \rangle \langle \langle 1 - a \rangle \rangle
$$

is a well-defined $\mathbb{Z}[\mathcal{G}_A]$ -homomorphism. Let

$$
S^2_{\mathbb{Z}}(A^\times) := (A^\times \otimes_{\mathbb{Z}} A^\times) / \langle a \otimes b + b \otimes a : a, b \in A^\times \rangle.
$$

If we consider $S^2_{\mathbb{Z}}(A^{\times})$ as a trivial \mathcal{G}_A -module, then

$$
\bar{\lambda}_2 : \overline{\mathcal{RP}}(A) \to S^2_{\mathbb{Z}}(A^\times), \qquad [a] \mapsto a \otimes (1-a),
$$

is a homomorphism of $\mathbb{Z}[\mathcal{G}_A]$ -modules. Hutchinson defined the $\mathbb{Z}[\mathcal{G}_A]$ -modules $\overline{\mathcal{RP}}_1(A)$ and $\overline{\mathcal{RB}}(A)$ as follows

$$
\overline{\mathcal{RP}}_1(A) := \ker(\overline{\lambda}_1 : \overline{\mathcal{RP}}(A) \to \mathcal{I}_A^2),
$$

$$
\overline{\mathcal{RB}}(A) := \ker(\overline{\lambda}_2 | \overline{\mathcal{RP}}_1(A) : \mathcal{RP}_1(A) \to S^2_{\mathbb{Z}}(A^\times))
$$

(see [\[7,](#page-17-17) page 28], [\[8,](#page-17-18) Subsection 2.3]).

Let $Z_i(A^2) = \text{ker}(\partial_i : Y_i(A^2) \to Y_{i-1}(A^2))$. From the complex $Y_4(A^2) \to Y_3(A^2) \to Y_4(A^2)$ $Z_2(A^2) \to 0$ we obtain the complex of \mathcal{G}_A -modules

$$
Y_4(A^2)_{E_2(A)} \to Y_3(A^2)_{E_2(A)} \to Z_2(A^2)_{E_2(A)} \to 0.
$$

The orbits of the action of $E_2(A)$ on $Y_3(A)$ and $Y_4(A)$ are represented by

 $\langle a \rangle [x]':= (\infty, \mathbf{0}, \mathbf{a}, \mathbf{a}x), \text{ and } \langle a \rangle [x, y]':= (\infty, \mathbf{0}, \mathbf{a}, \mathbf{a}x, \mathbf{a}y), \langle a \rangle \in \mathcal{G}_A, x, y, x/y \in \mathcal{W}_A,$

respectively. Thus $Y_3(A^2)_{\mathrm{E}_2(A)}$ is the free $\mathbb{Z}[\mathcal{G}_A]$ -module generated by the symbols $[x]'$, $x \in$ W_A and $Y_4(A^2)_{E_2(A)}$ is the free $\mathbb{Z}[\mathcal{G}_A]$ -module generated by the symbols $[x, y]'$, $x, y, x/y \in$ W_A . It is straightforward to check that

$$
\overline{\partial_4}([x,y]') = [x]' - [y]' + \langle x \rangle \left[\frac{y}{x}\right]' - \langle x^{-1} - 1 \rangle \left[\frac{1 - x^{-1}}{1 - y^{-1}}\right]' + \langle 1 - x \rangle \left[\frac{1 - x}{1 - y}\right]'
$$

Thus we obtain a natural map

$$
\eta : \overline{\mathcal{RP}}(A) \to H_0(\mathrm{E}_2(A), Z_2(A^2)).
$$

If $Y_{\bullet}(A) \to \mathbb{Z}$ is exact in dimension $\lt 4$, then the above map becomes an isomorphism. We define

$$
\mathcal{RP}(A) := H_0(\mathrm{E}_2(A), Z_2(A^2)) = H_0(\mathrm{PE}_2(A), Z_2(A^2)).
$$

If A is a GE₂-ring, then this definition of $\mathcal{RP}(A)$ coincides with the definition of Coronado and Hutchinson given in [\[5,](#page-17-19) §3].

The inclusion $Z_2(A^2) \to Y_2(A^2)$ induces the natural map

$$
\lambda_1 := \mathrm{inc} : \mathcal{RP}(A) = Z_2(A^2)_{\mathrm{E}_2(A)} \to Y_2(A^2)_{\mathrm{E}_2(A)} \simeq \mathbb{Z}[\mathcal{G}_A].
$$

It is straightforward to check that $\bar{\lambda}_1 = \lambda_1 \circ \eta$. We denote the kernel of λ_1 by $\mathcal{RP}_1(A)$ and call it the refined scissors congruence group of A . Note that we have a natural map

$$
\overline{\mathcal{RP}}_1(A) \to \mathcal{RP}_1(A).
$$

Let $Y_{\bullet}(A)$ be exact in dimension 1. From the short exact sequence

$$
0 \to Z_2(A^2) \to Y_2(A^2) \stackrel{\partial_2}{\to} Z_1(A^2) \to 0,
$$

we obtain the (long) exact sequence

$$
H_1(\mathrm{E}_2(A), Y_2(A^2)) \stackrel{\bar{\partial}_2}{\rightarrow} H_1(\mathrm{E}_2(A), Z_1(A^2)) \rightarrow \mathcal{RP}(A) \stackrel{\lambda_1}{\longrightarrow} \mathbb{Z}[\mathcal{G}_A].
$$

Since

$$
H_1(\mathrm{E}_2(A), Y_2(A^2)) \simeq H_1\Big(\mathrm{E}_2(A), \bigoplus_{\langle a \rangle \in \mathcal{G}_A} \mathrm{Ind}_{\mu_2(A)}^{\mathrm{E}_2(A)} \mathbb{Z}\Big) \simeq \mu_2(A) \otimes_{\mathbb{Z}} \mathbb{Z}[\mathcal{G}_A],
$$

we have the exact sequence

$$
\mu_2(A) \otimes_{\mathbb{Z}} \mathbb{Z}[\mathcal{G}_A] \stackrel{\bar{\partial}_2}{\rightarrow} E^1_{2,1} \rightarrow \mathcal{RP}_1(A) \rightarrow 0.
$$

From the commutative diagram

$$
Y_2(A^2) \xrightarrow{\partial_2} Z_1(A^2)
$$

$$
\downarrow \phi_2 \qquad \qquad \downarrow \text{inc}
$$

$$
Y_1(A^2) \longrightarrow Y_1(A^2)
$$

we obtain the commutative diagram

$$
\mu_2(A) \otimes_{\mathbb{Z}} \mathbb{Z}[\mathcal{G}_A] \xrightarrow{\bar{\partial}_2} E^1_{2,1} \longrightarrow \mathcal{RP}_1(A) \longrightarrow 0
$$

$$
\downarrow \qquad \qquad \downarrow d^1_{2,1}
$$

$$
\mu_2(A) \longrightarrow \mu_2(A).
$$

It is not difficult to see that $(d_{2,1}^1 \circ \bar{\partial}_2)(b \otimes \langle a \rangle) = b$. Thus from the above commutative diagram we obtain the exact sequence

$$
\mu_2(A) \otimes_{\mathbb{Z}} \mathcal{I}_A \to E_{2,1}^2 \to \mathcal{RP}_1(A) \to 0.
$$

Consider the differential $d_{2,1}^2 : E_{2,1}^2 \to H_2(B(A), \mathbb{Z})$. From now on we assume that the surjective map $p : B(A) \to T(A)$ induces the isomorphism

$$
H_2(\mathcal{B}(A),\mathbb{Z}) \stackrel{p_*}{\simeq} H_2(\mathcal{T}(A),\mathbb{Z}).
$$

Then the composite

$$
\mu_2(A) \otimes_{\mathbb{Z}} \mathcal{I}_A \to E_{2,1}^2 \xrightarrow{d_{2,1}^2} H_2(\mathcal{B}(A), \mathbb{Z}) \simeq H_2(\mathcal{T}(A), \mathbb{Z}) \simeq A^{\times} \wedge A^{\times}
$$

is given by $b \otimes \langle \langle a \rangle \rangle \mapsto b \wedge a$ (see [\[14,](#page-17-0) Lemma 4.1]). Thus we have the commutative diagram

$$
\mu_2(A) \otimes_{\mathbb{Z}} \mathcal{I}_A \longrightarrow E_{2,1}^2 \longrightarrow \mathcal{RP}_1(A) \longrightarrow 0
$$
\n
$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow
$$
\n
$$
0 \longrightarrow \mu_2(A) \wedge A^{\times} \longrightarrow A^{\times} \wedge A^{\times} \longrightarrow \frac{A^{\times} \wedge A^{\times}}{\mu_2(A) \wedge A^{\times}} \longrightarrow 0.
$$

Consider the injective map

$$
\alpha: \frac{A^{\times} \wedge A^{\times}}{A^{\times} \wedge \mu_2(A)} \to S^2_{\mathbb{Z}}(A^{\times}), \quad a \wedge b \mapsto 2(a \otimes b).
$$

One can show that the composite map

$$
\overline{\mathcal{RP}}_1(A) \to \mathcal{RP}_1(A) \to \frac{A^\times \wedge A^\times}{\mu_2(A) \wedge A^\times} \to S^2_{\mathbb{Z}}(A^\times)
$$

coincides with $\bar{\lambda}_2|_{\overline{\mathcal{RP}}_1(A)} : \overline{\mathcal{RP}}_1(A) \to S^2_{\mathbb{Z}}(A^{\times})$. We denote the kernel of

$$
\mathcal{RP}_1(A) \to \frac{A^\times \wedge A^\times}{\mu_2(A) \wedge A^\times} \to S^2_\mathbb{Z}(A^\times)
$$

with $R\mathcal{B}(A)$ and call it the refined Bloch group of A. Note that we have a natural map

$$
\overline{\mathcal{RB}}(A) \to \mathcal{RB}(A).
$$

Now from the above commutative diagram we obtain a surjective map $E_{2,1}^{\infty} \twoheadrightarrow \mathcal{RB}(A)$. By an easy analysis of the main spectral sequence we obtain the surjective map

$$
H_3(\mathrm{E}_2(A),\mathbb{Z}) \to E_{2,1}^{\infty}.
$$

Combining these two maps we obtain a surjective map

$$
H_3(\mathrm{E}_2(A),\mathbb{Z}) \to \mathcal{RB}(A).
$$

This map factors through $H_3(PE_2(A), \mathbb{Z})$, where

$$
PE_2(A) := E_2(A) / \{\pm I_2\}.
$$

We have proved the following version of a refined Bloch-Wigner exact sequence in [\[17\]](#page-17-20).

Theorem 5.1. Let A be a semilocal ring such that there is a ring homomorphism $A \rightarrow F$. F a field, where $\mu(A) \to \mu(F)$ is injective. For any maximal ideal $\mathfrak{m} \in \text{Specm}(A)$ let either A/m be infinite or if $|A/\mathfrak{m}| = p^d$, then $(p-1)d > 8$ $((p-1)d > 6$ when A is a domain). If either $-1 \in A^{\times 2}$ or $|\mathcal{G}_A| \leq 4$, then we have the exact sequence

$$
0 \to \operatorname{Tor}^{\mathbb{Z}}_1(\widetilde{\mu}(A), \widetilde{\mu}(A)) \to H_3(\operatorname{PE}_2(A), \mathbb{Z}) \to \mathcal{RB}(A) \to 0,
$$

where $\widetilde{\mu}(A) = \mu(A)/\mu_2(A)$.

Proof. See [\[17,](#page-17-20) Theorem 3.1, Theorem 3.2, Corollary 3.3] and use Proposition [4.1](#page-11-0) and [17, Lemma 2.8].

Let A be a finite cyclic group. If 2 | |A|, let \mathcal{A}^{\sim} denote the unique non-trivial extension of A by $\mathbb{Z}/2$. If $2 \nmid |\mathcal{A}|$, we define $\mathcal{A}^{\sim} := \mathcal{A}$. Thus if $n = |\mathcal{A}|$, then

$$
\mathcal{A}^{\sim} \simeq \mathbb{Z}/\gcd(n^2, 2n).
$$

Let A be an ind-cyclic group, i.e. A is direct limit of its finite cyclic subgroups. Then by passing to the limit we can define \mathcal{A}^{\sim} . Note that if A has no 2-torsion, then $\mathcal{A}^{\sim} = \mathcal{A}$. There is always a canonical injective homomorphism $\mathcal{A} \hookrightarrow \mathcal{A}^{\sim}$ whose composition with the projection $\mathcal{A}^{\sim} \to \mathcal{A}$ coincides with multiplication by 2.

The connection between the third homology groups of $E_2(A)$ and $PE_2(A)$ is given in [\[19,](#page-17-6) Proposition 5.1].

Theorem 5.2. Let A be a semilocal ring such that there is a ring homomorphism $A \rightarrow F$. F a field, where $\mu_2(A) \simeq \mu_2(F)$. If all the residue fields of A have more than three elements, then we have the exact sequence

$$
0 \to \mu_2(A)^{\sim} \to \frac{H_3(\mathrm{E}_2(A), \mathbb{Z})}{\mu_2(A) \otimes_{\mathbb{Z}} H_2(\mathrm{E}_2(A), \mathbb{Z})} \to H_3(\mathrm{PE}_2(A), \mathbb{Z}) \to 0,
$$

where the map $\mu_2(A) \otimes_{\mathbb{Z}} H_2(E_2(A), \mathbb{Z}) \rightarrow H_3(E_2(A), \mathbb{Z})$ is induced by the product map $\mu_2(A) \times \mathrm{E}_2(A) \to \mathrm{E}_2(A), (-1, X) \mapsto -X.$

Proof. We may assume that $char(F) \neq 2$. Since for any maximal ideal $\mathfrak{m} \in Specm(A)$, $|A/\mathfrak{m}| \geq 4$, there is $a \in A^{\times}$ such that $a^2 - 1 \in A^{\times}$. It follows from this that $M = A$. Thus by Theorem [2.1](#page-4-0) we have $H_1(E_2(A), \mathbb{Z}) = 0$. Now by [\[19,](#page-17-6) Theorem 3.1] we obtain the desired exact sequence.

The above two theorems are results of our attempt to find an answer to the following question of Coronado and Hutchinson [\[5,](#page-17-19) p.3].

Question 5.3. Is it true that for any local domain A one has the exact sequence

$$
0 \to \operatorname{Tor}^{\mathbb{Z}}_1(\mu(A), \mu(A))^{\sim} \to H_3(\operatorname{SL}_2(A), \mathbb{Z}) \to \mathcal{RB}(A) \to 0?
$$

The main result of this section is as follows, which generalizes the main result of $\left[15, \right]$ Theorem 5.1, Corollary 5.2].

Theorem 5.4. Let A be a semilocal ring such that there is a ring homomorphism $A \rightarrow F$, F a field, where $\mu(A) \to \mu(F)$ is injective. For any maximal ideal $\mathfrak{m} \in \text{Specm}(A)$ let either A/m be infinite or if $|A/\mathfrak{m}| = p^d$, then $(p-1)d > 8$ $((p-1)d > 6$ when A is a domain). If either $-1 \in A^{\times 2}$ or $|\mathcal{G}_A| \leq 4$, then we have the exact sequence

$$
0 \to \operatorname{Tor}^{\mathbb{Z}}_{1}(\mu(A), \mu(A))^{\sim} \to \frac{H_{3}(\mathrm{E}_{2}(A), \mathbb{Z})}{\mu_{2}(A) \otimes_{\mathbb{Z}} I^{2}(A)} \to \mathcal{RB}(A) \to 0,
$$

where $(-1)\otimes \langle a \rangle \langle b \rangle \rangle \in \mu_2(A) \otimes_{\mathbb{Z}} I^2(A)$ maps in $H_3(E_2(A),\mathbb{Z})$ to the class of the cycle which is obtained from the shuffle product of $[-1] \in B_1(\mu_2(A))_{\mu_2(A)}$ with the cycle $[D(a)|D(b)] +$ $R_{ab} - R_a - R_b + R_1 \in B_2(\mathcal{E}_2(A))_{\mathcal{E}_2(A)}.$

Proof. Consider the surjective maps

$$
\frac{H_3(\mathrm{E}_2(A),\mathbb{Z})}{\mu_2(A) \otimes_{\mathbb{Z}} H_2(\mathrm{E}_2(A),\mathbb{Z})} \twoheadrightarrow H_3(\mathrm{PE}_2(A),\mathbb{Z}) \twoheadrightarrow \mathcal{RB}(A).
$$

Let K be the kernel of this composite. Then we have the commutative diagram with exact rows

$$
0 \longrightarrow K \longrightarrow \underset{\mu_2(A) \otimes_{\mathbb{Z}} H_2(E_2(A), \mathbb{Z})}{\longrightarrow} \underset{\mu_2(A) \otimes_{\mathbb{Z}} H_2(E_2(A), \mathbb{Z})}{\longrightarrow} \underset{\mathbb{Z}}{\longrightarrow} \mathcal{RB}(A) \longrightarrow 0
$$
\n
$$
0 \longrightarrow \operatorname{Tor}_{1}^{\mathbb{Z}}(\widetilde{\mu}(A), \widetilde{\mu}(A)) \longrightarrow H_3(\operatorname{PE}_2(A), \mathbb{Z}) \longrightarrow \mathcal{RB}(A) \longrightarrow 0
$$

(see Theorem [5.1\)](#page-14-0). From this diagram and Theorem [5.2](#page-14-1) we obtain the exact sequence

$$
0 \to \mu_2(A)^{\sim} \to \mathcal{K} \to \operatorname{Tor}_{1}^{\mathbb{Z}}(\widetilde{\mu}(A), \widetilde{\mu}(A)) \to 0.
$$

This clearly implies that $\mathcal{K} \simeq \text{Tor}_{1}^{\mathbb{Z}}(\mu(A), \mu(A))^{\sim}$ and thus we have the exact sequence

$$
0 \to \operatorname{Tor}^{\mathbb{Z}}_1(\mu(A), \mu(A))^{\sim} \to \frac{H_3(\operatorname{E}_2(A), \mathbb{Z})}{\mu_2(A) \otimes_{\mathbb{Z}} H_2(\operatorname{E}_2(A), \mathbb{Z})} \to \mathcal{RB}(A) \to 0.
$$

By Proposition [4.1,](#page-11-0) $H_2(B(A),\mathbb{Z}) \simeq H_2(T(A),\mathbb{Z})$. This shows that the homology class of the cycle $([E_{12}(x)|E_{12}(y)] - [E_{12}(y)|E_{12}(x)]$, $x, y \in A$, in $H_2(E_2(A), \mathbb{Z})$ is trivial (see

Theorem [3.4\)](#page-10-0). Now consider the homology class of the cycle $([D(a)|D(b)] - [D(b)|D(a)]$, $a, b \in A^{\times}$. This is the image of $D(a) \wedge D(b)$ under the map

$$
T(A) \wedge T(A) \simeq H_2(T(A), \mathbb{Z}) \to H_2(E_2(A), \mathbb{Z}).
$$

Now from the commutative diagram

$$
\mu_2(A) \otimes_{\mathbb{Z}} (T(A) \wedge T(A)) \longrightarrow \mu_2(A) \otimes_{\mathbb{Z}} H_2(T(A), \mathbb{Z}) \longrightarrow \mu_2(A) \otimes_{\mathbb{Z}} H_2(E_2(A), \mathbb{Z})
$$
\n
$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow
$$
\n
$$
T(A) \wedge T(A)) \wedge T(A) \longrightarrow H_3(T(A), \mathbb{Z}) \longrightarrow H_3(E_2(A), \mathbb{Z})
$$

it follows that the right side vertical map is given by

$$
(-1) \otimes (D(a) \wedge D(b)) \mapsto D(-1) \wedge D(a) \wedge D(b).
$$

Note that here we denoted the image of $D(-1) \wedge D(a) \wedge D(b) \in \bigwedge^3_{\mathbb{Z}} T(A)$ in $H_3(E_2(A), \mathbb{Z})$ again by $D(-1) \wedge D(a) \wedge D(b)$. If $\mathfrak{i}^2 = -1$, then

$$
D(-1) \wedge D(a) \wedge D(b) = 2(D(i) \wedge D(a) \wedge D(b)) = 0.
$$

Let $|\mathcal{G}_A| \leq 4$. If $-1 \in A^{\times 2}$, we proceed as in above. If $-1 \notin A^{\times 2}$, then $\mathcal{G}_A = \{1, -1, u, -u\}$ for some $u \in A^{\times}$. So we may take $a, b \in \{1, -1, u, -u\}$ and in any case

$$
D(-1) \wedge D(a) \wedge D(b) = 0.
$$

Thus by Theorem [3.4,](#page-10-0) we have

$$
\frac{H_3(\mathrm{E}_2(A),\mathbb{Z})}{\mu_2(A) \otimes_{\mathbb{Z}} H_2(\mathrm{E}_2(A),\mathbb{Z})} = \frac{H_3(\mathrm{E}_2(A),\mathbb{Z})}{\mu_2(A) \otimes_{\mathbb{Z}} I^2(A)}.
$$

This completes the proof of the theorem.

In order to have a positive answer to Question [5.3,](#page-15-0) we should have a positive answer to the following question, which was raised in [\[19\]](#page-17-6).

Question 5.5. Let A be a local domain such that $|A/m_A| \neq 2$. Is the product map

$$
\rho_* : \mu_2(A) \otimes_{\mathbb{Z}} H_2(\mathcal{E}_2(A), \mathbb{Z}) \to H_3(\mathcal{E}_2(A), \mathbb{Z})
$$

trivial?

We do not know the answer of the above question even over a general infinite field. For more on this we refer the interested readers to [\[19,](#page-17-6) Example 4.4, Remark 5.2, Proposition 5.4].

Remark 5.6. Let A be a local domain such that $A/\mathfrak{m}_A \neq 2, 3, 4, 5, 7, 8, 9, 16, 27, 32, 64$. Then the results of this paper suggest that to give a positive answer to Question [5.3,](#page-15-0) one may show that

(i) we have the projective Bloch-Wigner exact sequence

$$
0 \to \operatorname{Tor}^{\mathbb{Z}}_1(\widetilde{\mu}(A), \widetilde{\mu}(A)) \to H_3(\operatorname{PE}_2(A), \mathbb{Z}) \to \mathcal{RB}(A) \to 0,
$$

(ii) the product map $\rho_* : \mu_2(A) \otimes_{\mathbb{Z}} H_2(E_2(A), \mathbb{Z}) \to H_3(E_2(A), \mathbb{Z})$ is trivial.
