ORBIFOLD QUOT SCHEMES VIA THE LE BRUYN-PROCESI THEOREM

ABSTRACT. This note provides a short proof of the fact that the reduced scheme underlying each orbifold Quot scheme associated to a finite subgroup of $SL(2, \mathbb{C})$ is isomorphic to a Nakajima quiver variety. Our approach uses recent work of the author with Yamagishi, allowing us to bypass the combinatorial arguments and the use of recollement from [3].

1. INTRODUCTION

Let $\Gamma \subset SL(2, \mathbb{C})$ be a nontrivial, finite subgroup. Orbifold Quot schemes for the Kleinian orbifold $[\mathbb{C}^2/\Gamma]$ were introduced in [3], generalising Hilbert schemes of points on the ADE singularity \mathbb{C}^2/Γ . Here, we exploit a new approach to variation of GIT quotient for quiver moduli spaces from recent joint work [4] to present a simple proof of [3, Theorem 1.1(3)] which establishes that the reduced scheme underlying each orbifold Quot scheme is isomorphic to a Nakajima quiver variety $\mathfrak{M}_{\theta}(1, v)$ for the framed preprojective algebra of Γ .

To recall the orbifold Quot schemes, list the irreducible representations of Γ as $\rho_0, \rho_1, \ldots, \rho_r$, where ρ_0 is the trivial representation. The group Γ acts dually on the coordinate ring R of \mathbb{C}^2 , giving the decomposition $R \cong \bigoplus_{0 \le i \le r} R_i \otimes_{\mathbb{C}} \rho_i$ as a sum of indecomposable R^{Γ} -modules, where $R_i = \operatorname{Hom}_{\Gamma}(\rho_i, R)$ for $0 \le i \le r$. For a non-empty subset $I \subseteq \{0, 1, \ldots, r\}$, consider the submodule

$$R_I := \bigoplus_{i \in I} R_i$$

of R. The noncommutative algebra $\operatorname{End}(R_I)$ can be constructed as the quotient of the path algebra of a quiver with vertex set I by a two-sided ideal of relations [2, (3.5)]. For each $i \in I$, if we write $e_i := \operatorname{id}_{R_i} \in \operatorname{End}(R_I)$ for the vertex idempotent determined by the identity map, then the dimension vector of a finite-dimensional $\operatorname{End}(R_I)$ -module Z is dim $Z := (\dim e_i Z)_{i \in I} \in \mathbb{N}^I$. As a set, the orbifold Quot scheme for Γ associated to I and any vector $n_I = (n_i)_{i \in I} \in \mathbb{N}^I$ is

$$\operatorname{Quot}_{I}^{n_{I}}\left(\left[\mathbb{C}^{2}/\Gamma\right]\right) := \left\{ \operatorname{End}(R_{I}) \text{-epimorphisms } R_{I} \twoheadrightarrow Z \mid \dim Z = n_{I} \right\}$$

A key result from [3, Proposition 3.2] shows that $\operatorname{Quot}_{I}^{n_{I}}([\mathbb{C}^{2}/\Gamma])$ can be constructed as a scheme of finite type over \mathbb{C} that represents a functor, denoted $\mathcal{Q}_{\operatorname{End}(R_{I})}^{n_{I}}(R_{I})$.

Here we prove the following result that streamlines slightly the statement of [3, Theorem 1.1(3)]:

Theorem 1. Let $I \subseteq \{0, 1, ..., r\}$ be a non-empty subset and let $n_I = (n_i)_{i \in I} \in \mathbb{N}^I$. There exists $v := v(n_I) \in \mathbb{N}^{r+1}$ and a stability condition θ_I for the framed preprojective algebra of Γ such that

$$\operatorname{Quot}_{I}^{n_{I}}([\mathbb{C}^{2}/\Gamma])_{\operatorname{red}} \cong \mathfrak{M}_{\theta_{I}}(1,v).$$

In particular, $\operatorname{Quot}_{I}^{n_{I}}([\mathbb{C}^{2}/\Gamma])$ is irreducible, and its underlying reduced scheme is normal and has symplectic singularities. Moreover, it admits at least one projective symplectic resolution.

Our approach bypasses the combinatorial arguments and the use of recollement in the original proof, so we also bypass the gap in the proof of [3, Proposition 6.1] that was pointed out to us by Yehao Zhou (see [4, Remarks 6.8(2)]). An alternative approach to this can be found in [1].

In the special case when there exists $n \in \mathbb{N}$ satisfying $n_i = n \dim \rho_i$ for all $i \in I$, it was shown in [4, Corollary 6.7] that the scheme $\operatorname{Quot}_I^{n_I}([\mathbb{C}^2/\Gamma])$ is actually reduced, so this orbifold Quot scheme with its natural scheme structure is isomorphic to a Nakajima quiver variety. Here, in the proof of the more general statement from Theorem 1, we apply a result of Crawley-Boevey that forces us to work with the underlying reduced scheme structure.

Notation: For any scheme X, we write X_{red} for the underlying reduced subscheme.

2. Proof of Theorem 1

Let $n \in \mathbb{N}$ be the largest non-negative integer with $n \dim(\rho_i) \leq n_i$ for all $i \in I$. Define the vector $v = (v_i) \in \mathbb{N}^{r+1}$ by setting

$$v_i = \begin{cases} n_i & \text{for } i \in I, \\ n \dim(\rho_i) & \text{otherwise.} \end{cases}$$

The McKay quiver Q_{Γ} is the doubled quiver of an extended Dynkin graph of type ADE with vertex set $\{0, 1, \ldots, r\}$, where 0 is the extending node. The preprojective algebra Π_{Γ} is the quotient of the path algebra of Q_{Γ} by the two-sided ideal of preprojective relations.

The symplectic vector space $\operatorname{Rep}(Q_{\Gamma}, v)$ of representations of the quiver Q_{Γ} with dimension vector v admits a Hamiltonian action by

$$G(v) := \prod_{0 \le i \le r} \operatorname{GL}(v_i).$$

Write $\operatorname{Rep}(\Pi_{\Gamma}, v)$ for the G(v)-invariant, affine subscheme of $\operatorname{Rep}(Q_{\Gamma}, v)$ parametrising representations of Q_{Γ} that satisfy the preprojective relations; this subscheme is often denoted $\mu_v^{-1}(0)$, where μ_v is the moment map.

When $n_i = n \dim(\rho_i)$ for all $0 \le i \le r$, then $v = n\delta$ where $\delta \in \mathbb{N}^{r+1}$ is the minimal imaginary root in the root system of type ADE associated to Γ . In this case, we write $\mu_{n\delta}^{-1}(0)$ and $G(n\delta)$ for the corresponding representation scheme and reductive group respectively.

Lemma 2. For any $0 \le i \le r$, the \mathbb{C} -algebra $\mathbb{C}[\operatorname{Rep}(\Pi_{\Gamma}, v)_{\operatorname{red}}]^{G(v)} \cong \mathbb{C}[\operatorname{Sym}^n(\mathbb{C}^2/\Gamma)]$ is generated by the trace functions tr_p associated to cycles in Q_{Γ} with head and tail at vertex *i*.

Proof. Apply [4, Proposition 4.1] to see that $\mathbb{C}[\mu_{n\delta}^{-1}(0)]^{G(n\delta)} \cong \mathbb{C}[\operatorname{Sym}^n(\mathbb{C}^2/\Gamma)]$ is generated by the trace functions tr_p associated to cycles in Q_{Γ} with head and tail at *i*. More generally, by taking the reduced scheme structure on $\operatorname{Rep}(\Pi_{\Gamma}, v)$, we may apply [5, Lemma 2.3] repeatedly to see that the \mathbb{C} -algebra homomorphism

$$\mathbb{C}[\operatorname{Rep}(\Pi_{\Gamma}, v)_{\operatorname{red}}]^{G(v)} \to \mathbb{C}[\mu_{n\delta}^{-1}(0)]^{G(n\delta)}$$

given by sending each trace function tr_p for dimension v to the corresponding trace function tr_p for dimension $n\delta$ is an isomorphism.

Let Π denote the preprojective algebra of the framed McKay quiver Q obtained from the McKay quiver Q_{Γ} by adding a framing vertex ∞ and an arrow in each direction between ∞ and 0 (see [2]). Regard $\alpha := (1, v) \in \mathbb{N} \oplus \mathbb{N}^{r+1}$ as a dimension vector for both Π and $A := \Pi/(b^*)$, where b^* is the unique arrow in Q with head at ∞ .

Following [2, Proposition 3.3], there is a quiver $Q^* := Q^*_{\{0,1,\ldots,r\}}$ and an epimorphism $\beta \colon \mathbb{C}Q^* \to A$ of \mathbb{C} -algebras. The space $\operatorname{Rep}(Q^*, \alpha)$ of representations of Q^* with dimension vector α contains the closed subscheme $\operatorname{Rep}(A, \alpha)$ of representations satisfying the relations $\operatorname{ker}(\beta)$. The group

$$G(\alpha) := \operatorname{GL}(1) \times \prod_{0 \le i \le r} \operatorname{GL}(v_i)$$

acts on $\operatorname{Rep}(A, \alpha)$ by change of basis for representations. Define $K := \{0, 1, \ldots, r\} \setminus I$, and regard I and K as subsets of the vertex set $Q_0^* = \{\infty, 0, 1, \ldots, r\}$, so

$$Q_0^* = \{\infty\} \sqcup I \sqcup K.$$

Note that the subgroup $H_K := \prod_{k \in K} \operatorname{GL}(v_k)$ of $G(\alpha)$ acts on $\operatorname{Rep}(A, \alpha)$.

Next, regard $\alpha_I := (1, n_I) \in \mathbb{N} \times \mathbb{N}^I$ as a dimension vector for the subalgebra $A_I \subseteq A$ spanned by classes of paths with head and tail in $I \subseteq Q_0$. Again, [2, Proposition 3.3] gives a quiver Q_I^* with vertex set $\{\infty\} \cup I$ and a \mathbb{C} -algebra epimorphism $\beta_I : \mathbb{C}Q_I^* \to A_I$, and we write $\operatorname{Rep}(A_I, \alpha_I)$ for the affine scheme of representations of Q_I^* that have dimension α_I which satisfy the relations $\ker(\beta_I)$. The group

$$G(\alpha_I) := \operatorname{GL}(1) \times \prod_{i \in I} \operatorname{GL}(n_i)$$

acts on $\operatorname{Rep}(A_I, \alpha_I)$. Taking the underlying reduced scheme structure defines a (possibly reducible) variety with coordinate ring $\mathbb{C}[\operatorname{Rep}(A_I, \alpha_I)_{\operatorname{red}}]$.

Proposition 3. There is a \mathbb{C} -algebra isomorphism $\mathbb{C}[\operatorname{Rep}(A_I, \alpha_I)_{\operatorname{red}}] \cong \mathbb{C}[\operatorname{Rep}(A, \alpha)_{\operatorname{red}}]^{H_K}$.

Proof. The proof builds on that of [4, Theorem 5.3]. For a nontrivial path $p = a_{\ell} \cdots a_1$ in Q^* with head and tail at h(p) and t(p) respectively, and for indices $1 \leq i \leq \alpha_{h(p)}$ and $1 \leq j \leq \alpha_{t(p)}$, let $x_{p,ij} \in \mathbb{C}[\operatorname{Rep}(Q^*, \alpha)]$ denote the function that sends $(B_a) \in \operatorname{Rep}(Q^*, \alpha)$ to the (i, j)-entry of the matrix $B_{a_{\ell}} \cdots B_{a_1}$. The construction from [2, Proposition 3.3] shows that Q_I^* is a subquiver of Q^* . The image of the resulting inclusion of polynomial rings

$$\overline{\psi} \colon \mathbb{C}[\operatorname{Rep}(Q_I^*, \alpha_I)] \hookrightarrow \mathbb{C}[\operatorname{Rep}(Q^*, \alpha)]$$

is the polynomial subalgebra $R \subset \mathbb{C}[\operatorname{Rep}(Q^*, \alpha)]^{H_K}$ generated by the functions $\mathbf{x}_{a,ij}$, where $a \in Q_1^*$ has head and tail in $\{\infty\} \cup I$, for $1 \leq i \leq \alpha_{\mathrm{h}(a)}$ and $1 \leq j \leq \alpha_{\mathrm{t}(a)}$.

As in the proof of [4, Theorem 5.3], the map $\overline{\psi}$ induces a \mathbb{C} -algebra homomorphism

$$\psi \colon \mathbb{C}[\operatorname{Rep}(A_I, \alpha_I)] \longrightarrow \mathbb{C}[\operatorname{Rep}(A, \alpha)]^{H_K}$$

whose image is generated by the classes in $\mathbb{C}[\operatorname{Rep}(A, \alpha)]^{H_K}$ of the functions $\mathbf{x}_{a,ij}$ for arrows a in Q^* that have head and tail in $\{\infty\} \cup I$, for $1 \leq i \leq \alpha_{h(a)}$ and $1 \leq j \leq \alpha_{t(a)}$. The construction of the right-inverse to ψ from the proof of [4, Theorem 5.3] shows that ψ is injective. Taking the quotient by the nilradical $\sqrt{0}$ gives

$$\mathbb{C}[\operatorname{Rep}(A,\alpha)]^{H_K}/\sqrt{0} \cong \mathbb{C}[(\operatorname{Rep}(A,\alpha)//H_K)_{\operatorname{red}}] \cong \mathbb{C}[\operatorname{Rep}(A,\alpha)_{\operatorname{red}}]^{H_K},$$

and we see that ψ induces a \mathbb{C} -algebra homomorphism

$$\psi_{\mathrm{red}} \colon \mathbb{C}[\mathrm{Rep}(A_I, \alpha_I)]_{\mathrm{red}} \longrightarrow \mathbb{C}[\mathrm{Rep}(A, \alpha)_{\mathrm{red}}]^{H_K}.$$

Injectivity of ψ implies that ψ_{red} is injective. It remains to show that ψ_{red} is surjective.

Apply [4, Proposition 3.2] to see that $\mathbb{C}[\operatorname{Rep}(A,\alpha)]^{H_K}$ is generated by the trace functions tr_p of cycles p in Q^* traversing only arrows with head and tail in K, together with the contraction functions $x_{p,ij}$ for paths p with head and tail in $\{\infty\} \cup I$ for indices $1 \le i \le \alpha_{h(p)}$ and $1 \le j \le \alpha_{t(p)}$. We claim that the trace function generators are redundant. Indeed, as in the proof of [4, Proposition 4.5], the class of each nontrivial cycle in Q^* may be regarded as the class in A of a cycle that does not touch vertex ∞ , so each trace function may be regarded as an element of $\mathbb{C}[\operatorname{Rep}(\Pi_{\Gamma}, v)]^{G(v)}$. Again, taking the quotient by the nilradical allows us to work in the algebra

$$\mathbb{C}[\operatorname{Rep}(\Pi_{\Gamma}, v)]^{G(v)} / \sqrt{0} \cong \mathbb{C}[(\operatorname{Rep}(\Pi_{\Gamma}, v) / \!\!/ G(v))_{\operatorname{red}}] \cong \mathbb{C}[\operatorname{Rep}(\Pi_{\Gamma}, v)_{\operatorname{red}}]^{G(v)}.$$

Lemma 2 shows that this algebra is generated by trace functions associated to cycles q with head and tail at a vertex $i \in I$. Every such trace function equals $\sum_{1 \le j \le \alpha_i} \mathbf{x}_{q,jj}$, i.e., the trace function generators can be written in terms of the contraction function generators. This proves the claim.

The construction of the quiver $Q^* = Q^*_{\{0,1,\dots,r\}}$ from [2, Proposition 3.2] shows that every path in Q^* with head and tail in $\{\infty\} \cup I$ is equivalent modulo ker (β) to a linear combination of paths that traverse only arrows with head and tail in $\{\infty\} \cup I$. Therefore $\mathbb{C}[\operatorname{Rep}(A, \alpha)]^{H_K}$ is generated by the functions $x_{a,ij}$ for arrows a in Q^* with head and tail in $\{\infty\} \cup I$ for indices $1 \leq i \leq \alpha_{h(p)}$ and $1 \leq j \leq \alpha_{t(p)}$. Therefore ψ_{red} is surjective and hence an isomorphism as required.

Proof of Theorem 1. For the character $\eta_I \in G(\alpha_I)^{\vee}$ from [3, (4.2)], the orbifold Quot scheme from Theorem 1 satisfies $\operatorname{Quot}_{I}^{n_{I}}([\mathbb{C}^{2}/\Gamma]) \cong \operatorname{Rep}(A_{I},\alpha_{I})/\!\!/_{n_{I}} G(\alpha_{I})$ by [3, Proposition 4.2], giving

$$\operatorname{Quot}_{I}^{n_{I}}([\mathbb{C}^{2}/\Gamma])_{\operatorname{red}} \cong \operatorname{Rep}(A_{I}, \alpha_{I})_{\operatorname{red}} /\!\!/_{\eta_{I}} G(\alpha_{I}).$$

The quotient map $G(\alpha) \to G(\alpha)/H_K \cong G(\alpha_I)$ induces the inclusion of character groups that sends $\eta_I \in G(\alpha_I)^{\vee}$ to the character $\theta_I \in G(\alpha)^{\vee}$ from [3, (5.1)]. The construction from [4, Section 5.2] now shows that the isomorphism $\psi_{\rm red}$ of C-algebras induces an isomorphism

$$\operatorname{Rep}(A_I, \alpha_I)_{\operatorname{red}} /\!\!/_{\mu_I} G(\alpha_I) \cong \operatorname{Rep}(A, \alpha)_{\operatorname{red}} /\!\!/_{\theta_I} G(\alpha)$$

of schemes over $\operatorname{Rep}(A, \alpha)_{\operatorname{red}} /\!\!/_0 G(v) \cong \operatorname{Sym}^n(\mathbb{C}^2/\Gamma)$. For the vector $\alpha = (1, v)$, the isomorphism

$$\operatorname{Hilb}^{v}([\mathbb{C}^{2}/\Gamma]) \cong \mathfrak{M}_{\theta}(\alpha)$$

from [3, Proposition 5.2] allows us to apply the proof of [2, Lemma 3.1], using v in place of $n\delta$ throughout, to conclude that the (reduced by assumption) Nakajima quiver variety $\mathfrak{M}_{\theta_I}(\alpha)$ may be regarded as a (reduced) moduli space of A-modules, giving

$$\operatorname{Rep}(A,\alpha)_{\operatorname{red}}/\!\!/_{\theta_I}G(\alpha)\cong\mathfrak{M}_{\theta_I}(\alpha)$$

Combining these isomorphisms gives $\operatorname{Quot}_{I}^{n_{I}}([\mathbb{C}^{2}/\Gamma])_{\operatorname{red}} \cong \mathfrak{M}_{\theta_{I}}(\alpha)$ as required.
