KAM for high-dimensional nonlinear quantum harmonic oscillator

Abstract: In this paper, we study high-dimensional nonlinear quantum harmonic oscillator equation. We show the equation admits many time quasi-periodic solutions by establishing an abstract infinite dimensional KAM theorem with multiple normal frequencies. The proof is based on the classical KAM scheme, and the key is a decaying structure of Hessian matrices of Hamiltonian functions.

1 Introduction

In this paper, we consider the nonlinear Schrödinger equation

$$
\mathbf{i}u_t + (-\Delta + |x|^2)u + M_\rho u + \varepsilon |u|^{2p} u = 0, \quad x \in \mathbb{R}^d, \quad d \ge 2,
$$
 (1.1)

where $T := -\Delta + |x|^2$ is the *d*-dimensional quantum harmonic oscillator, M_ρ is a Hermitian multiplier, $\varepsilon > 0$ is a small parameter, and p is a positive integer. Under the standard inner product on $L^2(\mathbb{R}^d)$, the equation can be written in the form

$$
\dot{u} = \mathbf{i}\frac{\partial H}{\partial \bar{u}}\tag{1.2}
$$

with the Hamiltonian

$$
H = \int_{\mathbb{R}^d} \left(|\nabla u|^2 + x^2 |u|^2 + (M_\rho u) \bar{u} \right) dx + \frac{\varepsilon}{p+1} \int_{\mathbb{R}^d} |u|^{2p+2} dx. \tag{1.3}
$$

We will construct time quasi-periodic solutions by KAM theory with the multiplier *M*^ρ as parameter and the nonlinearity $\varepsilon |u|^{2p}u$ as perturbation.

Historically, KAM theory for partial differential equations was originated by Kuksin [\[21\]](#page-44-0) and Wayne [\[29\]](#page-44-1), where one dimensional nonlinear wave and Schrödinger equations with Dirichlet boundary conditions were studied. Then infinite dimensional KAM theory was deeply developed with applications to more partial differential equations, including both one dimension and higher dimension. For one dimensional partial differential equations, also see [\[10,](#page-43-0) [19,](#page-44-2) [22,](#page-44-3) [24,](#page-44-4) [26,](#page-44-5) [27,](#page-44-6) [31\]](#page-44-7) for

example. For higher dimensional partial differential equations, the second order Melnikov nonresonance conditions are seriously violated. By developing further Criag and Wayne's scheme in $[11]$, Bourgain $[8]$ made a breakthrough for two dimensional nonlinear Schrödinger equations. This method only requires the first order Melnikov non-resonance conditions and is now known as Craig-Wayne-Bourgain (C-W-B) method. Due to the absence of the second order Melnikov conditions, C-W-B method generally gives no information on the linear stability of the obtained invariant tori. In contrast, the classical KAM scheme gives a normal form, which usually contains the information of linear stability. Furthermore, this normal form is a cornerstone to investigate nonlinear stability around the invariant tori.

In [\[13\]](#page-43-7), the classical KAM scheme was developed by Eliasson and Kuksin for high dimensional nonlinear Schrödinger equations on \mathbb{T}^d . To cope with the infinitely many second order Melnikov conditions, they made a breakthrough by exploring the Töplitz-Lipschitz structure of Hessian matrices of Hamiltonian functions. For more results of high dimensional partial differential equations on \mathbb{T}^d , also see [\[12,](#page-43-8) [14,](#page-44-9) [15,](#page-44-10) [28,](#page-44-11) [32\]](#page-44-12) for example. Different from Δ on \mathbb{T}^d , another important type is represented by ∆ on S *d* and quantum harmonic oscillator on R *d* . Between them, the first significant difference is the clustering of eigenvalues. For ∆ on T *d* , a sub-clustering with upper bound was discovered in [\[13\]](#page-43-7), which ensures the solving of homological equations without loss of regularity; for the latter, the natural clustering is given by the resonant subsets in

$$
\{(j,\iota)\in\mathbb{N}^+\times\mathbb{N}^+ \mid \iota=1,\cdots,d_j\},\
$$

where $d_j \rightarrow +\infty$ means that there is no upper bound. The second significant difference is the analysis nature of eigenfunctions. For Δ on \mathbb{T}^d , the eigenfunctions are $e^{i(j,x)}$, $j \in \mathbb{Z}^d$, which provide a foundation for the Töplitz-Lipschitz structure mentioned above; for the latter, the eigenfunctions are spherical harmonic functions or Hermite functions, which do not fit in the Fourier analysis.

Regarding these difficulties, in [\[17\]](#page-44-13), Grébert and Paturel introduced a matrix norm for the Hessian $A := \nabla^2_{\zeta} f$ of perturbation f as follows:

$$
|A|_{s,\beta} := \sup_{i,j} ||A_i^j|| (ij)^{\beta} \left(\frac{i \wedge j + |i^2 - j^2|}{i \wedge j} \right)^{\frac{s}{2}}, \tag{1.4}
$$

where $||A_i^j||$ denotes ℓ^2 -operator norm of the block A_i^j , $i \wedge j$ denotes $\min\{i, j\}$, and the weight $\beta > 0$ 0 characterizes the regularizing effect and is crucial to control the number of small divisors. To maintain the structure [\(1.4\)](#page-1-0) under KAM iteration, the gradient ∇^ζ *f* of perturbation *f* must also be regular, i.e.,

$$
\nabla_{\zeta} f: Y_s \to Y_{s+\beta},\tag{1.5}
$$

where Y_s are Sobolev type spaces. Under [\(1.4\)](#page-1-0) and [\(1.5\)](#page-1-1), the authors established an abstract KAM theorem for infinite dimensional Hamiltonian systems with multiple normal frequencies, and applied this theorem to the nonlinear Klein-Gordon equation on S *d* .

For high-dimensional nonlinear quantum harmonic oscillator equation [\(1.1\)](#page-0-0), there is a similar structure as [\(1.4\)](#page-1-0) for Hessian of perturbation, i.e.,

$$
|A|_{s,\beta} := \sup_{i,j} \|A_i^j\| (ij)^\beta \left(\frac{\sqrt{i \wedge j} + |i - j|}{\sqrt{i \wedge j}} \right)^s, \tag{1.6}
$$

but the gradient of perturbation is merely bounded, i.e.,

$$
\nabla_{\zeta} f: Y_s \to Y_s,\tag{1.7}
$$

which causes an essential obstacle of maintaining the structure [\(1.6\)](#page-1-2). Precisely, consider the Poisson bracket $\{f, g\}$, where

$$
f := f_{\theta}(\theta) + \langle f_r(\theta), r \rangle + \langle f_{\zeta}(\theta), \zeta \rangle + \frac{1}{2} \langle f_{\zeta\zeta}(\theta), \zeta \rangle + \text{h.o.t.}
$$
 (1.8)

is the Hamiltonian function of perturbation and

$$
g := g_{\theta}(\theta) + \langle g_r(\theta), r \rangle + \langle g_\zeta(\theta), \zeta \rangle + \frac{1}{2} \langle g_{\zeta\zeta}(\theta), \zeta \rangle \tag{1.9}
$$

is the Hamiltonian function of transformation. By direct calculation,

$$
\nabla_{\zeta}^{2} \{f,g\} = f_{\zeta\zeta} \cdot Jg_{\zeta\zeta} - \nabla_{\zeta}(\partial_{r}f) \otimes \nabla_{\zeta}(\partial_{\theta}g) + \cdots,
$$
\n(1.10)

where $J = \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix}$ and \otimes denotes the tensor product. The obstacle is the second term, i.e., $\nabla_{\zeta}(\partial_r f) \otimes \nabla_{\zeta}(\partial_{\theta}g)$, which does not possess the structure [\(1.6\)](#page-1-2). Interestingly, there is still a very nice application of [\(1.6\)](#page-1-2) to the reducibility of high-dimensional quantum harmonic oscillator in [\[18\]](#page-44-14), since the second term in [\(1.10\)](#page-2-0) disappears for linear equation.

In the present paper, we devote to studying the case that the Hessian $\nabla^2_\zeta f$ has regularizing effect but the gradient ∇^ζ *f* is merely bounded. Our approach is to weaken the norm defined in [\(1.6\)](#page-1-2) such that the tensor product in [\(1.10\)](#page-2-0) possesses a weaker structure. Precisely, we define

$$
|A|_{s,\beta} := \sup_{i,j} ||A_i^j|| (i \wedge j)^\beta \left(\frac{\sqrt{i \wedge j} + |i - j|}{\sqrt{i \wedge j}}\right)^s \tag{1.11}
$$

with $(i \wedge j)^{\beta}$ instead of the factor $(ij)^{\beta}$ in [\(1.6\)](#page-1-2). Now, to guarantee the tensor product in [\(1.10\)](#page-2-0) possesses the structure [\(1.11\)](#page-2-1), it just requires that one vector is regular and the other is bounded, instead of both regular. Generally in KAM scheme, the corresponding terms of perturbation *f* and transformation *g* have different regularities. Let's take the equation [\(1.1\)](#page-0-0) and the terms $\langle f_\zeta, \zeta \rangle$, $\langle g_\zeta, \zeta \rangle$ in [\(1.8\)](#page-2-2), [\(1.9\)](#page-2-3) for example. The fact is that, the former is bounded, i.e., $f_\zeta \in Y_s$, while the latter is regularized by the first order Melnikov conditions, i.e., $g_\zeta \in Y_{s+1}$. Therefore, we think our decaying structure may be used in a wider range.

More precisely, in order to maintain the structure [\(1.11\)](#page-2-1), we also introduce a well-matched matrix norm for the Hessian $S := \nabla^2_{\zeta} g$ of transformation *g* as follows:

$$
|S|_{s,\beta+} := \sup_{i,j} ||S_i^j|| (1+|i-j|)(i \wedge j)^{\beta} \left(\frac{\sqrt{i \wedge j} + |i-j|}{\sqrt{i \wedge j}} \right)^s. \tag{1.12}
$$

Respectively denote $\mathcal{M}_{s,\beta}$ and $\mathcal{M}_{s,\beta}^+$ the spaces of matrices with the norm in [\(1.11\)](#page-2-1) and [\(1.12\)](#page-2-4). Formally the same as [\[17,](#page-44-13) [18\]](#page-44-14), we need to prove: if $A \in \mathcal{M}_{s,\beta}$ and $S \in \mathcal{M}_{s,\beta}^+$, then $AS, SA \in \mathcal{M}_{s,\beta}$; if $S_1, S_2 \in \mathcal{M}_{s,\beta}^+$, then $S_1 S_2 \in \mathcal{M}_{s,\beta}^+$. Compared with the factor $(ij)^\beta$ in [\[17,](#page-44-13) [18\]](#page-44-14), the conclusions for $(i \wedge j)^{\beta}$ are less obvious and the proof is harder.

Except for the trouble caused by $(i \wedge j)^{\beta}$ above, there is another tricky problem. By [\(1.9\)](#page-2-3),

$$
\nabla_{\zeta} g = g_{\zeta} + g_{\zeta\zeta} \zeta, \qquad (1.13)
$$

where the regularity of the first term g_ζ has been discussed above, and the second term $g_\zeta \zeta$ is left as a problem. For the factor $(ij)^{\beta}$, this problem is solved in [\[17,](#page-44-13) [18\]](#page-44-14) by the following conclusion: if $S \in \mathcal{M}_{s,\beta}^+$, then $S \in \mathcal{L}(Y_s, Y_{s+\beta})$. However, for the weaker factor $(i \wedge j)^\beta$, the conclusion is no

longer valid. Fortunately, we find a weaker conclusion: if $S \in \mathcal{M}_{s,\beta}^+$, then $S \in \mathcal{L}(Y_s, Y_{s+\beta'})$ for any $0 < β' < β$. Of course, this leads to $∇_ξ^2{f, g}$ belongs to $\mathcal{M}_{s, β'}$ instead of $\mathcal{M}_{s, β}$, which means that the perturbation after each KAM step will lose some regularizing effect. Thus, we take β as an iteration parameter and shrink it in the KAM procedure.

Finally, we also mention KAM theory for partial differential equations with their nonlinearity containing spatial derivatives such as KdV, derivative nonlinear wave and Schrödinger equations, water wave equations, seeing [\[1,](#page-43-9) [2,](#page-43-10) [3,](#page-43-11) [7,](#page-43-12) [20,](#page-44-15) [23,](#page-44-16) [25\]](#page-44-17) for example.

In the present paper, for convenience, we keep fidelity with the notation and terminology from [\[17,](#page-44-13) [18\]](#page-44-14). Now we lay out an outline:

In Section 2, we first state an abstract infinite dimensional KAM theorem, seeing Theorem [2.1,](#page-5-0) and then apply this theorem to the high-dimensional nonlinear quantum harmonic oscillator equation, seeing Theorem [2.2.](#page-9-0)

In Section 3, we prove several basic properties of the matrix spaces $\mathcal{M}_{s,\beta}$ and $\mathcal{M}_{s,\beta}^+$. These properties are crucial to our main results and have been discussed above.

In Section 4, we first study Poisson brackets of two Hamiltonian functions, seeing Lemma [4.1.](#page-14-0) Since the space $\mathscr{T}^{s,\beta}_{\sigma,\mu,\varnothing}$ is not closed under the Poisson bracket, we introduce its subspace $\mathscr{T}^{s,\beta+}_{\sigma,\mu,\varnothing}$. Then, we give a precise description of the Hamiltonian flow and some useful estimates of the transformation, seeing Lemma [4.2.](#page-15-0) Notice that this lemma takes into account the change of the parameter β . Finally, we prove that the Hamiltonian flow preserves the regularizing effect in the sense of smaller β , seeing Lemma [4.3.](#page-21-0)

In Section 5-7, the KAM theorem is proved. In section 5, we perform one KAM step. In section 6, we prove the iterative lemma, seeing Lemma [6.1,](#page-32-0) where a new iterative parameter β_m is introduced. In section 7, we estimate the measure of excluded parameters, seeing Lemma [7.2.](#page-38-0)

In Appendix, we give some useful lemmas. Lemma [8.1](#page-40-0) describes a property of the weight $w(i, j)$. Lemma [8.2](#page-40-1) provides two elementary inequalities being frequently used in Section 3. We emphasize that, when using this lemma to the proof of Lemma [3.3,](#page-11-0) the parameter $β$ in [\(8.2\)](#page-40-2) is replaced by $\beta - \beta'$, which leads to the large coefficient $\frac{1}{\beta - \beta'}$ in [\(3.11\)](#page-11-1). Lemma [8.3](#page-41-0) shows that the operator norm can be controlled by the Frobenius norm. Lemma [8.4](#page-41-1) is the Schur inequality. Lemma [8.5](#page-42-0) is quoted from [\[18\]](#page-44-14) and is used to solve the homological equation [\(5.36\)](#page-27-0). Lemma [8.6](#page-42-1) is quoted from [\[17\]](#page-44-13) and is devoted to estimating the new perturbation f_{3+} in [\(5.69\)](#page-31-0). Lemma [8.7](#page-43-13) is quoted from [\[18\]](#page-44-14) and is used to check the Hessian of perturbation *f* satisfies the norm [\(2.4\)](#page-4-0).

2 Main results

In this section, we give an abstract KAM theorem with multiple normal frequencies and its application to high-dimensional nonlinear Schrödinger equation with harmonic potential.

2.1 An abstract KAM theorem

At beginning, we introduce some notations. Denote the index set

$$
\mathfrak{L} := \{ (j, \mathfrak{t}) \in \mathbb{N}^+ \times \mathbb{N}^+ \mid \mathfrak{t} = 1, \cdots, d_j \},\tag{2.1}
$$

where $d_j \leq c^* j^{d^*}$ for some constants $c^* > 0$ and $d^* > 0$. For a complex vector valued sequence

$$
\zeta = (\zeta_{j,\iota} \in \mathbb{C}^2)_{(j,\iota) \in \mathfrak{L}},
$$

we also write $\zeta = (\zeta_j)_{j\geq 1}$ with $\zeta_j = (\zeta_{j,1})_{1\leq i\leq d_j}$. Denote the ℓ^2 -norm $|\zeta_j| := \sqrt{\sum_{1\leq i\leq d_j} |\zeta_{j,1}|^2}$, where $|\zeta_{j,t}| = \sqrt{|p_{j,t}|^2 + |q_{j,t}|^2}$ for $\zeta_{j,t} = (p_{j,t}, q_{j,t})$. Let $s \ge 0$ and define the space Y_s of complex vector valued sequences ζ with the norm

$$
\|\zeta\|_{s}^{2} := \sum_{j\geq 1} |\zeta_{j}|^{2} j^{2s} = \sum_{(j,t)\in \mathfrak{L}} |\zeta_{j,t}|^{2} j^{2s} = \sum_{(j,t)\in \mathfrak{L}} (|p_{j,t}|^{2} + |q_{j,t}|^{2}) j^{2s} < +\infty.
$$
 (2.2)

Denote by $M_{m \times n}(\mathbb{C})$ the set of complex $m \times n$ matrices. For an infinite-dimensional $M_{2 \times 2}(\mathbb{C})$ valued matrix

$$
A: \mathfrak{L} \times \mathfrak{L} \to M_{2 \times 2}(\mathbb{C}), \qquad ((i, t_1), (j, t_2)) \mapsto A_{(i, t_1)}^{(j, t_2)},
$$

we write its block wise representation $A = (A_i^j)_{i,j \ge 1}$ with $A_i^j \in M_{2d_i \times 2d_j}(\mathbb{C})$. For any $i, j \ge 1$, denote $i \land j = \min\{i, j\}$ and

$$
w(i,j) = \frac{\sqrt{i\wedge j} + |i - j|}{\sqrt{i\wedge j}}.\tag{2.3}
$$

Fix $\beta > 0$ and define the space $\mathcal{M}_{s,\beta}$ of infinite matrices *A* with the norm

$$
|A|_{s,\beta} := \sup_{i,j \ge 1} (i \wedge j)^{\beta} w(i,j)^{s} ||A_i^j|| < +\infty,
$$
 (2.4)

where $||A_i^j||$ denotes the ℓ^2 -operator norm from \mathbb{C}^{2d_j} to \mathbb{C}^{2d_i} .

For $\sigma > 0$, denote

$$
\mathbb{T}^n_{\sigma} = \{z \in \mathbb{C}^n : |\Im z| < \sigma\}/2\pi\mathbb{Z}^n;
$$

for $\sigma, \mu > 0$ and $s \ge 0$, denote

$$
\mathscr{O}^s(\sigma,\mu)=\mathbb{T}^n_\sigma\times\{r\in\mathbb{C}^n:|r|<\mu^2\}\times\{\zeta\in Y_s:\|\zeta\|_s<\mu\},\
$$

where $|\Im z|$ and $|r|$ are maximum norm of *n*-dimensional vectors. Let $\mathscr{D} \subset \mathbb{R}^n$ be a compact set of positive Lebesgue measure. This is the set of parameters upon which will depend our objects. Differentiability of functions on $\mathscr D$ is understood in the sense of Whitney.

Let $f: \mathcal{O}^s(\sigma, \mu) \times \mathcal{D} \to \mathbb{C}$ be a function, real holomorphic in $(\theta, r, \zeta) \in \mathcal{O}^s(\sigma, \mu)$ and C^1 in $\rho \in \mathcal{D}$, such that for all $\rho \in \mathcal{D}$,

$$
\mathscr{O}^s(\sigma,\mu) \ni (\theta,r,\zeta) \mapsto \nabla_{\zeta} f(\theta,r,\zeta;\rho) \in Y_s
$$

and

$$
\mathscr{O}^s(\sigma,\mu) \ni (\theta,r,\zeta) \mapsto \nabla^2_{\zeta} f(\theta,r,\zeta;\rho) \in \mathscr{M}_{s,\beta}
$$

are real holomorphic functions. Denote this set of functions by $\mathscr{T}^{s,\beta}(\sigma,\mu,\mathscr{D})$ and define the norm $[f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}$ through

$$
\sup_{\substack{v=0,1,\rho\in\mathscr{D}\\(\theta,r,\zeta)\in\mathscr{O}^s(\sigma,\mu)}} \max\big\{|\partial_{\rho}^V f(\theta,r,\zeta;\rho)|,\mu||\partial_{\rho}^V \nabla_{\zeta} f(\theta,r,\zeta;\rho)|_{s},\mu^2|\partial_{\rho}^V \nabla_{\zeta}^2 f(\theta,r,\zeta;\rho)|_{s,\beta}\big\}.\tag{2.5}
$$

We remark that for $\beta > 0$, only the Hessian of $f \in \mathcal{T}^{s,\beta}$ has a regularizing effect, so does not the gradient of *f* .

Introduce the orthogonal projection Π defined on the 2 \times 2 complex matrices

$$
\Pi~: M_{2\times 2}(\mathbb{C})\rightarrow \mathbb{C}\textit{I}+\mathbb{C}\textit{J},
$$

where $I = \begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}$ and $J = \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix}$. A matrix $A : \mathfrak{L} \times \mathfrak{L} \to M_{2 \times 2}(\mathbb{C})$ is called on normal form and denoted by $A \in \mathcal{N}$ if it is real valued, symmetric, i.e., $A = {}^t A$, block diagonal, i.e., $A_i^j = 0$ for $i \neq j$, and satisfies $\Pi A = A$.

Introduce the symplectic structure

$$
\sum_{b=1}^n dr_b \wedge d\theta_b + \sum_{(j,t)\in\mathfrak{L}} dp_{j,t} \wedge dq_{j,t},
$$

and a Hamiltonian is called on normal form if it reads

$$
h = \langle \omega(\rho), r \rangle + \frac{1}{2} \langle \zeta, A(\rho) \zeta \rangle,
$$

where $\omega \in \mathbb{R}^n$ is the tangential frequency, *A* is a matrix on normal form, and $\rho \in \mathcal{D}$ is an external parameter.

Theorem 2.1. *Consider the perturbed Hamiltonian system*

$$
h + f = \langle \omega(\rho), r \rangle + \frac{1}{2} \langle \zeta, A(\rho) \zeta \rangle + f(\theta, r, \zeta; \rho)
$$
\n(2.6)

with the normal form h and the perturbation f satisfying the following assumptions:

(A1) Both the map $\rho \mapsto \omega(\rho)$ *and its inverse map are* C^1 *between* $\mathscr D$ *and its image. More precisely, there exist positive constants M*^ω *and L, such that*

$$
\sup_{\mathbf{v}=0,1,\rho\in\mathcal{D}}|\partial_{\rho}^{\mathbf{v}}\omega(\rho)|\leq M_{\omega},\tag{2.7}
$$

$$
\sup_{\rho \in \omega(\mathscr{D})} |\partial_{\rho} \omega^{-1}(\rho)| \le L. \tag{2.8}
$$

(A2) The normal form matrix A(ρ) *is block diagonal with its components*

$$
A_j^j(\rho) = \lambda_j I + \tilde{A}_j^j(\rho), \qquad \lambda_j = b_1 j + b_0,
$$
\n(2.9)

where b_1 , b_0 *are constants satisfying* $b_1 > 0$ *and* $b_1 + b_0 > 0$, *I is the unit matrix of the same order* a *s* A_j^j , and $\tilde{A}_j^j(\rho)$ *is* C^1 *in the parameter* $\rho \in \mathcal{D}$ *. Moreover, there exist positive constants* M_Ω *and* $\tilde{\beta}$ *, such that for any* $j \geq 1$ *,*

$$
\sup_{\mathbf{v}=0,1,\rho\in\mathcal{D}}\|\partial_{\rho}^{\mathbf{v}}\tilde{A}_{j}^{j}(\rho)\|\leq\frac{M_{\Omega}}{j^{\tilde{\beta}}}.
$$
\n(2.10)

Additionally we assume

$$
M_{\Omega} < \min\{\frac{b_1}{8}, \frac{1}{12L}\}.\tag{2.11}
$$

(A3) The perturbation f is real analytic in the space coordinates $\mathscr{O}^s(\sigma,\mu)$ and C^1 in the pa*rameter* $\rho \in \mathcal{D}$ *, where* $0 < \sigma, \mu \leq 1$ *. Moreover, there exist positive constants* s, β *(without loss of* g enerality, assume $\beta \leq \tilde{\beta}$) with $0 < \beta \leq \min\{\frac{s}{2},\frac{1}{2}\}\$ such that $f \in \mathscr{T}_{\sigma,\mu,\varnothing}^{s,\beta}$.

Then there exists $\varepsilon^* > 0$ *depending on n, s, b*₀, *b*₁, *c*^{*}, *d*^{*}, *M*_ω, *L*, *M*_Ω, *β*, σ, μ *such that if*

[f]_{\sigma,\mu,\mathscr{D}}^{s,\beta} = \varepsilon < \varepsilon^*,\tag{2.12}
$$

then there exist:

(1) a Cantor set \mathcal{D}_\ast ⊂ \mathcal{D} *with*

meas(\mathscr{D}\setminus\mathscr{D}_*)\leq \varepsilon^{\frac{1}{\alpha}},\qquad(2.13)
$$

where

$$
\alpha = 32\left(1 + \frac{d^*}{\beta}\right)\left(1 + \frac{4d^* + 2}{\beta}\right);\tag{2.14}
$$

(2) a family of real analytic symplectic diffeomorphism $\Phi : \mathscr{O}^s(\sigma/2, \mu/2) \times \mathscr{D}_* \to \mathscr{O}^s(\sigma, \mu)$ *satisfying*

$$
\|\Phi - id\|_{s} \le \varepsilon^{\frac{1}{2}},\tag{2.15}
$$

such that

$$
(h+f)\circ\Phi=\langle\omega_*(\rho),r\rangle+\frac{1}{2}\langle\zeta,A_*(\rho)\zeta\rangle+f_*(\theta,r,\zeta;\rho),\qquad(2.16)
$$

where the norm $\|(\theta, r, \zeta)\|_{s} = \max\{|\theta|, |r|, \|\zeta\|_{s}\}$ *for* $(\theta, r, \zeta) \in \mathbb{C}^{n} \times \mathbb{C}^{n} \times Y_{s}$, the new tangential *frequency* ^ω[∗] *satisfies*

$$
\sup_{\mathbf{v}=0,1,\rho\in\mathscr{D}_*}|\partial_{\rho}^{\mathbf{v}}(\omega_*(\rho)-\omega(\rho))|\leq \frac{2\varepsilon}{\mu^2},\tag{2.17}
$$

the new normal form matrix A[∗] *satisfies*

$$
\sup_{\mathbf{v}=0,1,\rho\in\mathcal{D}_*} \|\partial_{\rho}^{\mathbf{v}}(A_*(\rho) - A(\rho))_j^j\| \le \frac{2\varepsilon}{\mu^2} j^{-\frac{\beta}{2}},\tag{2.18}
$$

and the new perturbation f_* *satisfies* $\partial_r f_* = \partial_\zeta f_* = \partial_\zeta^2 f_* = 0$ *for* $r = \zeta = 0$ *.*

As a result, for each $\rho \in \mathscr{D}_*$, the map Φ restricted to $\mathbb{T}^n \times \{0\} \times \{0\}$ is an analytic embedding of *a rotational torus with frequencies* $\omega_*(\rho)$ *for the perturbed Hamiltonian h* + *f at* ρ *. In other words,*

t\mapsto \Phi(\theta+t\omega_*(\rho),0,0;\rho),\quad t\in\mathbb{R}
$$

is an analytic quasi-periodic solution for the Hamiltonian $h+f$ *evaluated at* ρ *for every* $\theta \in \mathbb{T}^n$ *and* $\rho \in \mathscr{D}_{\ast}$.

Remark 2.1. *We remark that* ^α *in [\(2.14\)](#page-6-0) is not optimal. However, it could tell us that the digged set* ^D \D[∗] *will become larger if d*[∗] *becomes larger or* ^β *becomes smaller.*

2.2 Application to high-dimensional nonlinear quantum harmonic oscillator

In this subsection, we shall apply Theorem [2.1](#page-5-0) to the equation [\(1.1\)](#page-0-0). The operator *T* has eigenvalues $\{\lambda_i\}$ satisfying

\lambda_j = 2j - 2 + d, \quad j \ge 1.
$$

Let X_j be the associated eigenspace, whose dimension denoted by \tilde{d}_j is less than j^{d-1} . We denote by Ψ*j*,^ι the Hermitian function of degree *j* and order ^ι so that we have

X_j = \text{Span}\{\Psi_{j,t}, \ t = 1, \cdots, \tilde{d}_j\}.
$$

Denoting

\mathfrak{L}_0 := \{ (j, \iota) \mid j \ge 1, \ \iota = 1, \cdots, \tilde{d}_j \},
$$

then $\{\Psi_{j,t}\}_{(j,t)\in\mathfrak{L}_0}$ forms a basis of $L^2(\mathbb{R}^d)$. Define the Hermitian multiplier on the basis as

M_{\rho}\Psi_{j,\iota}=\rho_{j,\iota}\Psi_{j,\iota}\quad\text{ for }(j,\iota)\in\mathfrak{L}_{0},
$$

where $(\rho_{j,t})_{(j,t)\in\mathfrak{L}_0}$ is a bounded sequence of real numbers. Writing *u* as

u=\sum_{(j,\iota)\in\mathfrak{L}_0}\xi_{j,\iota}\Psi_{j,\iota}(x),
$$

then the equation [\(1.1\)](#page-0-0) turns into

\dot{\xi}_{j,t} = \mathbf{i} \frac{\partial H}{\partial \bar{\xi}_{j,t}} \tag{2.19}
$$

with the Hamiltonian function

$$
H = \sum_{(j,t)\in\mathfrak{L}_0} (\lambda_{j,t} + \rho_{j,t}) \xi_{j,t} \bar{\xi}_{j,t} + \frac{\varepsilon}{p+1} \int_{\mathbb{R}^d} \Big| \sum_{(j,t)\in\mathfrak{L}_0} \xi_{j,t} \Psi_{j,t}(x) \Big|^{2p+2} dx.
$$
 (2.20)

Introduce the real variables $\zeta_{j,t} = \begin{pmatrix} p_{j,t} \\ q_{j,t} \end{pmatrix}$ *qj*,^ι by letting $\xi_{j,t} = \frac{1}{\sqrt{2}}$ $\frac{1}{2}(p_{j,t} + iq_{j,t})$. Then [\(2.19\)](#page-7-0) becomes

$$
\begin{cases}\n\dot{p}_{j,t} = \frac{\partial H}{\partial q_{j,t}} \\
\dot{q}_{j,t} = \frac{\partial H}{\partial p_{j,t}}\n\end{cases}
$$
\n(2.21)

with

$$
H = \frac{1}{2} \sum_{(j,t) \in \mathfrak{L}_0} (\lambda_{j,t} + \rho_{j,t}) (p_{j,t}^2 + q_{j,t}^2) + \frac{\varepsilon}{p+1} \int_{\mathbb{R}^d} \Big| \sum_{(j,t) \in \mathfrak{L}_0} \frac{p_{j,t} + iq_{j,t}}{\sqrt{2}} \Psi_{j,t}(x) \Big|^{2p+2} dx. \tag{2.22}
$$

Choose $\mathscr{A} := \{(j_1, i_1), (j_2, i_2), \cdots, (j_n, i_n)\} \subset \mathfrak{L}_0$ as tangential sites and $\mathfrak{L} := \mathfrak{L}_0 \setminus \mathscr{A}$ as normal sites. The index set $\mathfrak L$ is of the form [\(2.1\)](#page-3-0) with $d_j \leq j^{d-1}$, that is, $c^* = 1$, $d^* = d - 1$. We assume

$$
\begin{cases} \n\rho_b = \rho_{j_b, t_b} \in [0, 1], \quad b = 1, 2, \cdots, n \\ \n\rho_{j, t} = 0, \quad (j, t) \in \mathfrak{L} \n\end{cases} \tag{2.23}
$$

and take $\rho := (\rho_1, \dots, \rho_n) \in [0, 1]^n := \mathcal{D}$ as KAM parameters. Fix $I_b > 0$ and introduce the actionangle variables (θ_b, r_b) for $(j_b, l_b) \in \mathcal{A}$:

p_{j_b, t_b} = \sqrt{2(I_b + r_b)} \cos(\theta_b), \quad q_{j_b, t_b} = \sqrt{2(I_b + r_b)} \sin(\theta_b).
$$

Then the Hamiltonian [\(2.22\)](#page-7-1) becomes $H = h + f$ with

h = \langle \omega(\rho), r \rangle + \frac{1}{2} \langle \zeta, A\zeta \rangle,
$$

$$
f = \frac{\varepsilon}{p+1} \int_{\mathbb{R}^d} \Big| \sum_{b=1}^n \sqrt{I_b + r_b} e^{i\theta_b} \Psi_{j_b, t_b}(x) + \sum_{(j,t) \in \mathfrak{L}} \frac{p_{j,t} + iq_{j,t}}{\sqrt{2}} \Psi_{j,t}(x) \Big|^{2p+2} dx,
$$
 (2.24)

where $\zeta = (\zeta_{j,t})_{(j,t)\in\mathfrak{L}}$ and

$$
\omega(\rho) = (\omega_1(\rho), \cdots, \omega_n(\rho)), \qquad \omega_b(\rho) = 2j_b - 2 + d + \rho_b, \tag{2.25}
$$

$$
A = \text{diag}(A_j^j, j \ge 1), \qquad A_j^j = (2j - 2 + d)I_{2d_j \times 2d_j}.
$$
\n(2.26)

In view of [\(2.25\)](#page-8-0), the tangential frequency ω satisfies the assumption (A1) with

$$
M_{\omega} = \max_{1 \le b \le n} 2j_b + d - 1, \quad L = 1.
$$

In view of [\(2.26\)](#page-8-0), we know $b_1 = 2$, $b_0 = d - 2$ and $\tilde{A}^j_j(\rho) = 0$, which implies that we can choose $M_{\Omega} = \frac{1}{100}$ and $\tilde{\beta} = 1$ such that [\(2.10\)](#page-5-1) and [\(2.11\)](#page-5-2) in the assumption (A2) hold. It remains to check the perturbation f in [\(2.24\)](#page-7-2) satisfies the assumption $(A3)$. Before that, introduce the space

$$
\mathscr{H}^s = \Big\{ u(x) = \sum_{(j,t)\in\mathfrak{L}_0} \xi_{j,t} \Psi_{j,t}(x) \Big| \sum_{(j,t)\in\mathfrak{L}_0} |\xi_{j,t}|^2 j^{2s} < +\infty \Big\},\

with the norm $||u||_{\mathcal{H}^s}^2 := \sum_{(j,\iota) \in \mathfrak{L}_0} |\xi_{j,\iota}|^2 j^{2s}$. Clearly,

\mathscr{H}^s = D(T^s) := \{ u \in L^2(\mathbb{R}^d) : T^s u \in L^2(\mathbb{R}^d) \},
$$

Fix

$$
\sigma = \frac{1}{2}, \quad \mu = \frac{1}{2} \min\{1, I_1, \cdots, I_n\}, \quad s > \max\{d-2, \frac{d}{4}\}.
$$

The fact $(\theta, r, \zeta) \in \mathcal{O}^s(\sigma, \mu)$ implies $u \in \mathcal{H}^s$. Then $|u|^{2p+2}$ belongs to \mathcal{H}^s since \mathcal{H}^s is an algebra. Thus the perturbation *f* is analytic in $\mathcal{O}^s(\sigma,\mu)$ with

\sup_{(\theta,r,\zeta)\in\mathscr{O}^s(\sigma,\mu)}|f(\theta,r,\zeta)|\leq C\varepsilon,\tag{2.27}
$$

where *C* is a positive constant depending on *s*, *p*,*d*, $\{j_b\}_{1 \leq b \leq n}$, $\{I_b\}_{1 \leq b \leq n}$. Furthermore, one has

\frac{\partial f}{\partial p_{j,t}} = \frac{\varepsilon}{\sqrt{2}} \Big(\int_{\mathbb{R}^d} u^p \bar{u}^{p+1} \Psi_{j,t}(x) dx + \int_{\mathbb{R}^d} u^{p+1} \bar{u}^p \Psi_{j,t}(x) dx \Big)
$$

and

$$
\frac{\partial f}{\partial q_{j,\iota}} = \frac{\varepsilon \mathbf{i}}{\sqrt{2}} \Big(\int_{\mathbb{R}^d} u^p \bar{u}^{p+1} \Psi_{j,\iota}(x) dx - \int_{\mathbb{R}^d} u^{p+1} \bar{u}^p \Psi_{j,\iota}(x) dx \Big).
$$

Thus $\frac{\partial f}{\partial \zeta_{j,i}} = {}^{t}(\frac{\partial f}{\partial p_{j}})$ $\frac{\partial f}{\partial p_{j,\iota}}, \frac{\partial f}{\partial q_j}$ $\frac{\partial f}{\partial q_{j,t}}$) is the (j, t) -th coefficients of the decomposition of $u^p \bar{u}^{p+1}$ and $u^{p+1} \bar{u}^p$, and both terms are in \mathcal{H}^s . Hence, $\nabla_{\zeta} f \in Y_s$ and

$$
\sup_{(\theta,r,\zeta)\in\mathscr{O}^s(\sigma,\mu)} \|\nabla_{\zeta}f\|_{s} \leq C\varepsilon. \tag{2.28}
$$

To estimate the Hessian of *f* , we have

$$
\frac{\partial^2 f}{\partial p_{i,\nu_1} \partial p_{j,\nu_2}} = \frac{\varepsilon}{2} \int_{\mathbb{R}^d} (p u^{p-1} \bar{u}^{p+1} + 2(p+1) |u|^{2p} + p u^{p+1} \bar{u}^{p-1}) \Psi_{i,\nu_1}(x) \Psi_{j,\nu_2}(x) dx,
$$

$$
\frac{\partial^2 f}{\partial p_{i,\nu_1} \partial q_{j,\nu_2}} = \frac{\partial^2 f}{\partial q_{i,\nu_1} \partial p_{j,\nu_2}} = \frac{\mathbf{i} \varepsilon p}{2} \int_{\mathbb{R}^d} (u^{p-1} \bar{u}^{p+1} - u^{p+1} \bar{u}^{p-1}) \Psi_{i,\nu_1}(x) \Psi_{j,\nu_2}(x) dx,
$$

$$
\frac{\partial^2 f}{\partial q_{i,\nu_1} \partial q_{j,\nu_2}} = \frac{-\varepsilon}{2} \int_{\mathbb{R}^d} (p u^{p-1} \bar{u}^{p+1} - 2(p+1) |u|^{2p} + p u^{p+1} \bar{u}^{p-1}) \Psi_{i,\nu_1}(x) \Psi_{j,\nu_2}(x) dx.
$$

Since $u^{p-1}\bar{u}^{p+1}$, $|u|^{2p}$, $u^{p+1}\bar{u}^{p-1} \in \mathcal{H}^s$, by Lemma [8.7,](#page-43-13) there exists $\beta \in (0, \frac{1}{8})$ such that

$$
\left\|\frac{\partial^2 f}{\partial p_i \partial p_j}\right\|, \ \left\|\frac{\partial^2 f}{\partial p_i \partial q_j}\right\|, \ \left\|\frac{\partial^2 f}{\partial q_i \partial q_j}\right\| \leq \frac{C\epsilon}{(ij)^{\frac{\beta}{2}} w^s(i,j)} \|u\|_{\mathscr{H}^s}^{2p} \leq \frac{C\epsilon}{(i \wedge j)^{\beta} w^s(i,j)} \|u\|_{\mathscr{H}^s}^{2p}.
$$

Thus, $\nabla^2_{\zeta} f \in \mathcal{M}_{s,\beta}$ and

$$
|\nabla_{\zeta}^2 f|_{s,\beta} \le C \|u\|_{\mathscr{H}^s}^{2p} \varepsilon \le C\varepsilon. \tag{2.29}
$$

Notice that *f* does not depend on ρ . Therefore, by [\(2.27\)](#page-8-1)-[\(2.29\)](#page-9-1), we have $f \in \mathscr{T}^{s,\beta}_{\sigma,\mu,\mathscr{D}}$ and

[f]_{\sigma,\mu,\mathscr{D}}^{s,\beta} \leq C\varepsilon. \tag{2.30}
$$

Now applying Theorem [2.1,](#page-5-0) we get the following result.

There exists* $\varepsilon_* > 0$ *depending on n, s, d, p,* \mathscr{A} *,* { I_b }_{1≤*b*≤*n*} *such that if* $0 < \varepsilon < \varepsilon_*$ *, we obtain a subset* ^D[∗] [⊂] ^D *with*

$$
meas(\mathscr{D}\backslash\mathscr{D}_*) \le \varepsilon^{\frac{1}{\alpha}}, \quad \alpha = 32(1 + \frac{d-1}{\beta})(1 + \frac{4d-2}{\beta})
$$
\n(2.31)

and for every $\rho \in \mathcal{D}_*$, the equation has a smooth quasi-periodic solution of the form

$$
u(t,x) = \sum_{(j,t)\in\mathfrak{L}_0} \tilde{\xi}_{j,t}(t) \Psi_{j,t}(x),
$$
\n(2.32)

where $\{\tilde{\xi}_{j,\iota}\}_{(j,\iota)\in\mathfrak{L}_0}$ are quasi-periodic functions with frequencies $ω_*$. Moreover,

$$
|\omega_* - \omega| = O(\varepsilon) \tag{2.33}
$$

and

$$
\sum_{(j,t)\in\mathfrak{L}}\tilde{\xi}_{j,t}^{2}(t)j^{2s}=O(\varepsilon).
$$
\n(2.34)

Remark 2.2. *Actually, the precise expression of* β *can be given. For example, if d* ≥ 3 *and s* > *d is an integer, then* $\beta = \frac{1}{2(d+3)}$ *, seeing the proof of Lemma 3.2 in [\[18\]](#page-44-14) for details.*

Remark 2.3. *We also mention that for equation* [\(1.1\)](#page-0-0)*, Grebert, Imekraz and Paturelin have proved ´ long time stability of solutions by Birkhoff normal form in [\[16\]](#page-44-18).*

3 Estimates on matrix norm

In view of the infinite matrix space $\mathcal{M}_{s,\beta}$ defined by the norm $|\cdot|_{s,\beta}$ in [\(2.4\)](#page-4-0), we also introduce its subspace $\mathcal{M}^+_{s,\beta}$ of infinite matrices *A* with the norm

$$
|A|_{s,\beta+} := \sup_{i,j \ge 1} (i \wedge j)^{\beta} w(i,j)^{s} (1+|i-j|) ||A_i^j|| < +\infty.
$$
 (3.1)

On these two matrix norms, we will prove several basic estimates, which are crucial for establishing our KAM theorem.

Lemma 3.1. *Let* $A \in \mathcal{M}_{s,\beta}$ and $B \in \mathcal{M}_{s,\beta}^+$ with $0 < \beta \le \min\{\frac{s}{2},1\}$. Then both AB and BA belong to M*s*,^β *with the following estimates*

$$
|AB|_{s,\beta}, |BA|_{s,\beta} \le \frac{2^{\frac{s}{2}+2}}{\beta} |A|_{s,\beta} |B|_{s,\beta+}.
$$
 (3.2)

Proof. The proof of *BA* is similar to the proof of *AB*. Thus, we only prove the inequality of *AB* in (3.25) . In view of the definitions of matrix norms in (2.4) and (3.1) , it is sufficient to verify

$$
I := \sum_{k \ge 1} \frac{(i \wedge j)^{\beta}}{(i \wedge k)^{\beta} (k \wedge j)^{\beta} (1 + |k - j|)} \Big(\frac{w(i, j)}{w(i, k) w(k, j)} \Big)^{s} \le \frac{2^{\frac{s}{2} + 2}}{\beta} \tag{3.3}
$$

for any $i, j \ge 1$. Now fix $i, j \ge 1$ with $i \le j$, and decompose the sum in [\(3.3\)](#page-10-0) into three parts: $I_1 = \sum_{1 \le k \le \frac{i}{2}}$, $I_2 = \sum_{\frac{i}{2} < k < 2j}$ and $I_3 = \sum_{k \ge 2j}$.

For the first sum, we have $i \wedge k = k, k \wedge j = k$ and

$$
w(i,k) = 1 + \frac{i-k}{\sqrt{k}} \ge 1 + \frac{i/2}{\sqrt{i/2}} > \sqrt{i/2}.
$$

Moreover, we have $w(i, j) \leq w(k, j)$ by Lemma [8.1.](#page-40-0) Thus,

$$
I_1 < \sum_{1 \le k \le \frac{i}{2}} \frac{i^{\beta}}{k^{2\beta} (1 + |k - j|)} \left(\frac{2}{i}\right)^{\frac{s}{2}} \le 2^{\frac{s}{2}} \sum_{1 \le k \le \frac{i}{2}} \frac{1}{k^{2\beta} (1 + |k - j|)},\tag{3.4}
$$

where the assumption $\beta \leq \frac{s}{2}$ is used in the last inequality.

For the second sum, we have $(i \land k)(k \land j) > ik/2$. Moreover, we have $w(i, j) \leq w(i, k)w(k, j)$ by Lemma [8.1.](#page-40-0) Thus,

$$
I_2 < \sum_{\frac{i}{2} < k < 2j} \frac{i^{\beta}}{(ik/2)^{\beta}(1+|k-j|)} = 2^{\beta} \sum_{\frac{i}{2} < k < 2j} \frac{1}{k^{\beta}(1+|k-j|)}.\tag{3.5}
$$

For the last sum, we have $i \wedge k = i$, $k \wedge j = j$ and

$$
w(k,j) = 1 + \frac{k-j}{\sqrt{j}} \ge 1 + \frac{k/2}{\sqrt{k/2}} > \sqrt{k/2}.
$$

Moreover, we have $w(i, j) \leq w(i, k)$ by Lemma [8.1.](#page-40-0) Thus,

$$
I_3 < \sum_{k \ge 2j} \frac{1}{1 + |k - j|} \left(\frac{2}{k}\right)^{\frac{s}{2}} = 2^{\frac{s}{2}} \sum_{k \ge 2j} \frac{1}{k^{\frac{s}{2}} (1 + |k - j|)}.\tag{3.6}
$$

Combining [\(3.4\)](#page-10-1)-[\(3.6\)](#page-10-2), by $0 < \beta \le \min\{\frac{s}{2}, 1\}$ and Lemma [8.2,](#page-40-1) we get

$$
I < 2^{\frac{s}{2}} \sum_{k \ge 1} \frac{1}{k^{\beta} (1 + |k - j|)} < 2^{\frac{s}{2} + 1} \left(1 + \frac{1}{\beta} \right) \le \frac{2^{\frac{s}{2} + 2}}{\beta}.\tag{3.7}
$$

This completes the proof of [\(3.3\)](#page-10-0) with $i \leq j$. We can prove [\(3.3\)](#page-10-0) with $i > j$ in the same way. \Box

Lemma 3.2. Let $A, B \in \mathcal{M}_{s,\beta}^+$ with $0 < \beta \le \min\{\frac{s}{2}, 1\}$. Then both AB and BA belong to $\mathcal{M}_{s,\beta}^+$ with *the following estimates*

$$
|AB|_{s,\beta+}, |BA|_{s,\beta+} \le \frac{2^{\frac{s}{2}+3}}{\beta}|A|_{s,\beta+}|B|_{s,\beta+}.
$$
\n(3.8)

Proof. By symmetry, we only prove the inequality of *AB* in [\(3.8\)](#page-10-3). In view of the definition of matrix norm in [\(3.1\)](#page-9-2), it is sufficient to verify

$$
I := \sum_{k \ge 1} \frac{(i \wedge j)^{\beta} (1 + |i - j|)}{(i \wedge k)^{\beta} (k \wedge j)^{\beta} (1 + |i - k|) (1 + |k - j|)} \Big(\frac{w(i, j)}{w(i, k) w(k, j)} \Big)^{s} \le \frac{2^{\frac{s}{2} + 3}}{\beta} \tag{3.9}
$$

for any *i*, *j* ≥ 1. By 1 + $|i - j|$ < 1 + $|i - k|$ + 1 + $|k - j|$, we have

$$
\frac{1+|i-j|}{(1+|i-k|)(1+|k-j|)} < \frac{1}{1+|k-j|} + \frac{1}{1+|i-k|}.\tag{3.10}
$$

Thus, the proof of [\(3.9\)](#page-11-2) is translated to the proof of Lemma [3.1.](#page-10-4)

Lemma 3.3. Let $A \in \mathcal{M}_{s,\beta}^+$ with $s \ge 0$ and $0 \le \beta' < \beta \le \frac{1}{2}$. Then $A \in \mathcal{L}(Y_s,Y_{s+\beta'})$ with the following *estimate*

||A\zeta||_{s+\beta'} \le \frac{2^{s+4}}{\beta - \beta'} |A|_{s,\beta+} ||\zeta||_s.
$$
\n(3.11)

 \Box

Proof. Write the block wise representation of $A \in \mathcal{M}_{s,\beta}^+$ and $\zeta \in Y_s$, i.e., $A = (A_i^j)_{i,j \in \mathbb{N}^+}$ and $\zeta =$ $(\zeta_j)_{j \in \mathbb{N}^+}$, where $A_i^j \in M_{2d_i \times 2d_j}(\mathbb{C})$ and $\zeta_j \in \mathbb{C}^{2d_j}$. Then we have

$$
||A\zeta||_{s+\beta'}^2 = \sum_{i\in\mathbb{N}^+} i^{2(s+\beta')} \Big| \sum_{j\in\mathbb{N}^+} A_i^j \zeta_j \Big|^2
$$

\n
$$
\leq \sum_{i\in\mathbb{N}^+} i^{2(s+\beta')} \Big(\sum_{j\in\mathbb{N}^+} ||A_i^j|| |\zeta_j| \Big)^2
$$

\n
$$
\leq |A|_{s,\beta+}^2 \sum_{i\in\mathbb{N}^+} i^{2(s+\beta')} \Big(\sum_{j\in\mathbb{N}^+} (i \wedge j)^{-\beta} (1+|i-j|)^{-1} w(i,j)^{-s} |\zeta_j| \Big)^2
$$

\n
$$
\leq |A|_{s,\beta+}^2 ||B||_{\ell^2 \to \ell^2}^2 ||\zeta||_s^2,
$$
\n(3.12)

where

$$
B = (b_i^j)_{i,j \in \mathbb{N}^+} := (i^{s+\beta'}j^{-s}(i \wedge j)^{-\beta}(1+|i-j|)^{-1}w(i,j)^{-s})_{i,j \in \mathbb{N}^+}.
$$
 (3.13)

Thus, it is sufficient to verify

$$
||B||_{\ell^2 \to \ell^2} \le \frac{2^{s+4}}{\beta - \beta'}.\tag{3.14}
$$

To estimate the ℓ^2 -operator norm of *B*, we decompose $B = B_1 + B_2 + B_3$ with

$$
B_1 = (b_i^j \chi_{i \le \frac{j}{2}})_{i,j \in \mathbb{N}^+}, \quad B_2 = (b_i^j \chi_{\frac{j}{2} < i < 2j})_{i,j \in \mathbb{N}^+}, \quad B_3 = (b_i^j \chi_{i \ge 2j})_{i,j \in \mathbb{N}^+},
$$

where $\chi_{i \leq \frac{j}{2}} = 1$ if $i \leq \frac{j}{2}$ $\frac{1}{2}$, and $\chi_{i \leq \frac{j}{2}} = 0$ otherwise; it is similar for $\chi_{\frac{j}{2} < i < 2j}$ and $\chi_{i \geq 2j}$. In the following, we estimate b_i^j in three cases respectively.

Case 1: $i \leq \frac{j}{2}$ $\frac{j}{2}$. By $i \wedge j = i$, $1 + |i - j| > \frac{j}{2}$ $\frac{J}{2}$ and $w(i, j) > 1$, we have

$$
b_i^j < \frac{2}{i^{-s + \beta - \beta'} j^{s + 1}} < \frac{2}{i^{\frac{1}{2} (1 + \beta - \beta')} j^{\frac{1}{2} (1 + \beta - \beta')}},\tag{3.15}
$$

where the facts $j > i$ and $s + \frac{1}{2}(1 - \beta + \beta') > 0$ are used in the last inequality. Then by [\(3.15\)](#page-11-3) and Lemma [8.3,](#page-41-0) we get

||B_1||_{\ell^2 \to \ell^2} \le \Big(\sum_{i,j \in \mathbb{N}^+} \frac{4}{i^{1+\beta-\beta'}j^{1+\beta-\beta'}}\Big)^{\frac{1}{2}} < 2 + \frac{2}{\beta-\beta'},\tag{3.16}
$$

where the last inequality follows from [\(8.2\)](#page-40-2) in Lemma [8.2.](#page-40-1)

Case 2: $\frac{j}{2} < i < 2j$. By $i \wedge j > \frac{j}{2}$, $j > \frac{j}{2}$ and $w(i, j) \ge 1$, we have

$$
b_i^j < \frac{2^{s+\beta}}{i^{\beta-\beta'}(1+|i-j|)},\tag{3.17}
$$

and thus

$$
||B_2||_{\ell^1 \to \ell^1} \le \sup_{j \in \mathbb{N}^+} \sum_{i \in \mathbb{N}^+} \frac{2^{s+\beta}}{i^{\beta-\beta'}(1+|i-j|)} < 2^{s+\beta+1} \left(1 + \frac{1}{\beta - \beta'}\right),\tag{3.18}
$$

where the last inequality follows from [\(8.3\)](#page-40-3) in Lemma [8.2.](#page-40-1) On the other hand, by $i \wedge j > \frac{j}{2}$ $\frac{j}{2}$, *i* < 2*j* and $w(i, j) \geq 1$, we have

$$
b_i^j < \frac{2^{s + \beta + \beta'}}{j^{\beta - \beta'} (1 + |i - j|)},\tag{3.19}
$$

and thus

$$
||B_2||_{\ell^{\infty}\to\ell^{\infty}} \leq \sup_{i\in\mathbb{N}^+} \sum_{j\in\mathbb{N}^+} \frac{2^{s+\beta+\beta'}}{j^{\beta-\beta'}(1+|i-j|)} < 2^{s+\beta+\beta'+1} \Big(1+\frac{1}{\beta-\beta'}\Big),\tag{3.20}
$$

where the last inequality follows from [\(8.3\)](#page-40-3) in Lemma [8.2.](#page-40-1) By [\(3.18\)](#page-12-0), [\(3.20\)](#page-12-1) and Lemma [8.4,](#page-41-1) we get

$$
||B_2||_{\ell^2 \to \ell^2} < 2^{s + \beta + \frac{\beta'}{2} + 1} \left(1 + \frac{1}{\beta - \beta'} \right). \tag{3.21}
$$

Case 3: *i* $\geq 2j$. By $i \wedge j = j$, $1 + |i - j| > \frac{i}{2}$ and $w(i, j) > \frac{i}{2\sqrt{j}}$, we have

$$
b_i^j < \frac{i^{s+\beta'}}{j^{s+\beta}} \frac{2}{i} \left(\frac{2\sqrt{j}}{i}\right)^s = \frac{2^{s+1}}{i^{1-\beta'}j^{\frac{s}{2}+\beta}} \le \frac{2^{s+1}}{i^{1-\beta'}j^{\beta}} < \frac{2^{s+1}}{i^{\frac{1}{2}(1+\beta-\beta')}j^{\frac{1}{2}(1+\beta-\beta')}},\tag{3.22}
$$

where the facts $i > j$ and $\frac{1}{2}(1 - \beta - \beta') > 0$ are used in the last inequality. Then by [\(3.22\)](#page-12-2) and Lemma [8.3,](#page-41-0) we get

$$
||B_3||_{\ell^2 \to \ell^2} \le \Big(\sum_{i,j \in \mathbb{N}^+} \frac{2^{2s+2}}{i^{1+\beta-\beta'}j^{1+\beta-\beta'}}\Big)^{\frac{1}{2}} < 2^{s+1}\Big(1+\frac{1}{\beta-\beta'}\Big),\tag{3.23}
$$

where the last inequality follows from [\(8.2\)](#page-40-2) in Lemma [8.2.](#page-40-1)

Finally, summing the estimates [\(3.16\)](#page-12-3), [\(3.21\)](#page-12-4) and [\(3.23\)](#page-12-5), we get

$$
||B||_{\ell^2 \to \ell^2} < \left(2 + 2^{s + \beta + \frac{\beta'}{2} + 1} + 2^{s + 1}\right)\left(1 + \frac{1}{\beta - \beta'}\right) < 2^{s + 3}\frac{2}{\beta - \beta'},\tag{3.24}
$$

which is (3.14) . This completes the proof of the lemma.

Lemma 3.4. *Let* $\eta \in Y_{s+\beta}$ *and* $\zeta \in Y_s$ *with* $s \ge 0$ *and* $\beta \ge 0$ *. Denoting* $A := \eta \otimes \zeta$ *, then we have* $A \in \mathcal{M}_{s,\beta}$ *with the following estimate*

$$
|A|_{s,\beta} \le ||\eta||_{s+\beta} ||\zeta||_s. \tag{3.25}
$$

Proof. For $i, j \in \mathbb{N}^+$, we have

$$
||A_i^j|| = |\eta_i||\zeta_j| \le i^{-(s+\beta)}j^{-s}||\eta||_{s+\beta}||\zeta||_s.
$$
 (3.26)

Thus, it is sufficient to verify

$$
(i \wedge j)^{\beta} w(i,j)^{s} i^{-(s+\beta)} j^{-s} \le 1,
$$
\n(3.27)

which follows from $i \land j \leq i$ and $w(i, j) \leq ij$. This completes the proof of the lemma. \Box

4 Poisson bracket and Hamiltonian flow

In this section, we shall study Poisson brackets and Hamiltonian flows. Before that, we define the truncation functions: for function $f \in \mathscr{T}^{s,\beta}_{\sigma,\mu,\mathscr{D}}$, define its truncation functions f^T , which are the second order Taylor approximation of *f* at $r = 0$ and $\zeta = 0$. That is,

$$
f^T := f_{\theta} + \langle f_r, r \rangle + \langle f_{\zeta}, \zeta \rangle + \frac{1}{2} \langle \zeta, f_{\zeta \zeta} \zeta \rangle
$$

= $f(\theta, 0; \rho) + \langle \nabla_r f(\theta, 0; \rho), r \rangle + \langle \nabla_{\zeta} f(\theta, 0; \rho), \zeta \rangle + \frac{1}{2} \langle \zeta, \nabla_{\zeta}^2 f(\theta, 0; \rho) \zeta \rangle.$ (4.1)

According to the definition of the norm $[f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}$ in [\(2.5\)](#page-4-1), for $\theta \in \mathbb{T}_{\sigma}^n$ and $\rho \in \mathscr{D}$, we have

$$
\sup_{\mathbf{v}=0,1} |\partial_{\rho}^{\mathbf{v}} f_{\theta}(\theta;\rho)| \le [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta},\tag{4.2}
$$

$$
\sup_{\mathbf{v}=0,1} \|\partial_{\rho}^{\mathbf{v}} f_{\zeta}(\theta;\rho)\|_{s} \leq \mu^{-1} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta},\tag{4.3}
$$

$$
\sup_{\mathbf{v}=0,1} |\partial_{\rho}^{\mathbf{v}} f_{\zeta\zeta}(\theta;\rho)|_{s,\beta} \leq \mu^{-2} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}.
$$
\n(4.4)

Furthermore, using the Cauchy estimates, we obtain

$$
\sup_{\mathbf{v}=0,1} |\partial_{\rho}^{\mathbf{v}} f_r(\theta;\rho)| \leq \mu^{-2} [f]_{\sigma,\mu,\mathcal{D}}^{s,\beta},\tag{4.5}
$$

and $(\partial_{\rho}^{V} f_{\zeta\zeta})_{V=0,1}$ are bounded linear operators from Y_s to itself, satisfying

$$
\sup_{\mathbf{v}=0,1} \|\partial_{\rho}^{\mathbf{v}} f_{\zeta\zeta}(\theta;\rho)\|_{\mathscr{L}(Y_s,Y_s)} = \sup_{\mathbf{v}=0,1} \|\partial_{\rho}^{\mathbf{v}} \nabla_{\zeta}^2 f(\theta,0;\rho)\|_{\mathscr{L}(Y_s,Y_s)}
$$

$$
\leq \mu^{-1} \sup_{\substack{\mathbf{v}=0,1\\ (\theta,r,\zeta)\in\mathcal{O}^{\mathcal{S}}(\sigma,\mu)}} \|\partial_{\rho}^{\mathbf{v}} \nabla_{\zeta} f(\theta,r,\zeta;\rho)\|_{s}
$$

$$
\leq \mu^{-2} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}.
$$
\n(4.6)

4.1 Poisson bracket

With the symplectic structure $dr \wedge d\theta + dp \wedge dq$, the Poisson brackets of f and g are defined by

$$
\{f,g\} = -\nabla_r f \cdot \nabla_{\theta} g + \nabla_{\theta} f \cdot \nabla_r g + \langle \nabla_{\zeta} f, J \nabla_{\zeta} g \rangle, \tag{4.7}
$$

where $\zeta = (p,q)$ and $J = \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix}$. Since the space $\mathscr{T}^{s,\beta}_{\sigma,\mu,\mathscr{D}}$ is not closed under Poisson brackets, we introduce the subspace $\mathscr{T}^{s,\beta+}_{\sigma,\mu,\mathscr{D}} \subset \mathscr{T}^{s,\beta}_{\sigma,\mu,\mathscr{D}}$ defined by

$$
\mathscr{T}_{\sigma,\mu,\mathscr{D}}^{s,\beta+} := \left\{ g \in \mathscr{T}_{\sigma,\mu,\mathscr{D}}^{s,\beta} \mid \partial_{\rho}^{\nu} \nabla_{\zeta} g(\theta,0;\rho) \in Y_{s+\beta}, \ \partial_{\rho}^{\nu} \nabla_{\zeta}^{2} g(\theta,0;\rho) \in \mathscr{M}_{s,\beta}^{+}, \ v = 0,1 \right\}
$$

with the norm

$$
[g]_{\sigma,\mu,\mathscr{D}}^{s,\beta+} = [g]_{\sigma,\mu,\mathscr{D}}^{s,\beta} + \sup_{\substack{\nu=0,1\\ \theta \in \mathbb{T}_0^n,\rho \in \mathscr{D}}} \left(\mu \|\partial_{\rho}^{\nu} \nabla_{\zeta} g(\theta,0;\rho)\|_{s+\beta} + \mu^2 |\partial_{\rho}^{\nu} \nabla_{\zeta}^2 g(\theta,0;\rho)|_{s,\beta+} \right). \tag{4.8}
$$

Based on above, we shall give the estimates of Poisson brackets in the following.

Lemma 4.1. Assume $f = f^T \in \mathcal{T}_{\sigma,\mu,\mathscr{D}}^{s,\beta}$ and $g = g^T \in \mathcal{T}_{\sigma,\mu,\mathscr{D}}^{s,\beta+}$ with $0 < \beta \le \min\{\frac{s}{2},1\}$. Then for $0 < \sigma' < \sigma$, we have $\{f,g\} \in \mathscr{T}^{s,\beta}_{\sigma',\mu,\mathscr{D}}$ and

$$
[\{f,g\}]_{\sigma',\mu,\mathscr{D}}^{s,\beta} \leq \frac{C}{\beta(\sigma-\sigma')\mu^2} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}[g]_{\sigma,\mu,\mathscr{D}}^{s,\beta+},
$$
(4.9)

where $C > 0$ *is a constant only depending on n and s.*

Proof. According to (4.1) , write

$$
f = f_{\theta} + \langle f_r, r \rangle + \langle f_{\zeta}, \zeta \rangle + \frac{1}{2} \langle \zeta, f_{\zeta\zeta} \zeta \rangle,
$$

$$
g = g_{\theta} + \langle g_r, r \rangle + \langle g_{\zeta}, \zeta \rangle + \frac{1}{2} \langle \zeta, g_{\zeta\zeta} \zeta \rangle,
$$

where f_{θ} , f_r , f_{ζ} , $f_{\zeta\zeta}$, g_{θ} , g_r , g_{ζ} , $g_{\zeta\zeta}$ are independent of r, ζ . Then in view of [\(4.7\)](#page-14-1), by direct calculation we have $\nabla_r f = f_r$, $\nabla_r g = g_r$, $\nabla_\zeta f = f_\zeta + f_{\zeta\zeta}\zeta$, $\nabla_\zeta g = g_\zeta + g_{\zeta\zeta}\zeta$ and thus

$$
\{f,g\} = -\langle f_r, \nabla_{\theta} g \rangle + \langle \nabla_{\theta} f, g_r \rangle + \langle f_{\zeta}, J g_{\zeta} \rangle - \langle g_{\zeta \zeta} J f_{\zeta}, \zeta \rangle + \langle \zeta, f_{\zeta \zeta} J g_{\zeta} \rangle + \langle \zeta, f_{\zeta \zeta} J g_{\zeta \zeta} \zeta \rangle. \tag{4.10}
$$

For simplicity, let h_1 , h_2 , h_3 , h_4 , h_5 , h_6 be the right side of [\(4.10\)](#page-14-2) successively.

Firstly, we consider h_1 and h_2 . By [\(4.5\)](#page-13-2) and Cauchy estimates, we get

$$
[h_1]_{\sigma',\mu,\mathscr{D}}^{s,\beta},\ [h_2]_{\sigma',\mu,\mathscr{D}}^{s,\beta} \leq \frac{C}{(\sigma-\sigma')\mu^2} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}[g]_{\sigma,\mu,\mathscr{D}}^{s,\beta}.
$$
\n
$$
(4.11)
$$

Secondly, we consider $h_3 := \langle f_\zeta, Jg_\zeta \rangle$. Notice that $\nabla_\zeta h_3 = \nabla_\zeta^2 h_3 = 0$. Thus, by [\(4.3\)](#page-13-3), we get

$$
[h_3]_{\sigma,\mu,\mathscr{D}}^{s,\beta} = \sup_{\substack{\nu=0,1,\rho\in\mathscr{D}\\ (\theta,\nu,\zeta)\in\mathscr{O}^s(\sigma,\mu)}} |\partial_{\rho}^{\nu} h_3| \leq \frac{C}{\mu^2} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}[g]_{\sigma,\mu,\mathscr{D}}^{s,\beta}.
$$
 (4.12)

Thirdly, we consider $h_4 := -\langle g_{\zeta\zeta} J f_{\zeta}, \zeta \rangle$ and $h_5 := \langle \zeta, f_{\zeta\zeta} J g_{\zeta} \rangle$. Notice that $\nabla_{\zeta} h_4 = -g_{\zeta\zeta} J f_{\zeta}$, $\nabla_{\zeta} h_5 = f_{\zeta\zeta} J g_{\zeta}$ and $\nabla_{\zeta}^2 h_4 = \nabla_{\zeta}^2 h_5 = 0$. Thus, by [\(4.3\)](#page-13-3), [\(4.6\)](#page-13-4) and $\|\zeta\|_s \leq \mu$, we get

$$
[h_4]_{\sigma,\mu,\mathscr{D}}^{s,\beta} = \sup_{\substack{\mathsf{v}=0,1,\rho\in\mathscr{D}\\(\theta,\mathsf{v},\zeta)\in\mathscr{O}^s(\sigma,\mu)}} \max\left\{ |\partial_{\rho}^{\mathsf{v}} h_4|, \mu \|\partial_{\rho}^{\mathsf{v}} \nabla_{\zeta} h_4\|_{s} \right\} \leq \frac{C}{\mu^2} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}[g]_{\sigma,\mu,\mathscr{D}}^{s,\beta},\tag{4.13}
$$

$$
[h_5]_{\sigma,\mu,\mathscr{D}}^{s,\beta} = \sup_{\substack{\mathsf{v}=0,1,\rho\in\mathscr{D}\\(\theta,\mathsf{v},\zeta)\in\mathscr{O}^s(\sigma,\mu)}} \max\left\{ |\partial_{\rho}^{\mathsf{v}} h_5|, \mu \|\partial_{\rho}^{\mathsf{v}} \nabla_{\zeta} h_5\|_{s} \right\} \leq \frac{C}{\mu^2} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}[g]_{\sigma,\mu,\mathscr{D}}^{s,\beta}.
$$
 (4.14)

Finally, we consider $h_6 := \langle \zeta, f_{\zeta\zeta} J g_{\zeta\zeta} \zeta \rangle$. Notice that

$$
\nabla_{\zeta} h_6 = f_{\zeta\zeta} J g_{\zeta\zeta} \zeta - g_{\zeta\zeta} J f_{\zeta\zeta} \zeta,
$$

$$
\nabla_{\zeta}^2 h_6 = f_{\zeta\zeta} J g_{\zeta\zeta} - g_{\zeta\zeta} J f_{\zeta\zeta}.
$$

By [\(4.6\)](#page-13-4) and $\|\zeta\|_{s} \leq \mu$, we get

$$
\sup_{\mathbf{v}=0,1} |\partial_{\rho}^{\mathbf{v}} h_6| \leq \frac{C}{\mu^2} [f]_{\sigma,\mu,\mathcal{D}}^{s,\beta}[g]_{\sigma,\mu,\mathcal{D}}^{s,\beta},\tag{4.15}
$$

$$
\sup_{\mathbf{v}=0,1} \|\partial_{\rho}^{\mathbf{v}} \nabla_{\zeta} h_6\|_{s} \leq \frac{C}{\mu^3} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta}[g]_{\sigma,\mu,\mathscr{D}}^{s,\beta};\tag{4.16}
$$

by Lemma [3.1,](#page-10-4) we get

$$
|\nabla^2_{\zeta} h_6|_{s,\beta} \leq \frac{C}{\beta} |f_{\zeta\zeta}|_{s,\beta} |g_{\zeta\zeta}|_{s,\beta+} \leq \frac{C}{\beta \mu^4} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta} [g]_{\sigma,\mu,\mathscr{D}}^{s,\beta+},
$$
(4.17)

$$
|\partial_{\rho} \nabla_{\zeta}^{2} h_{6}|_{s,\beta} \leq \frac{C}{\beta} \Big(|\partial_{\rho} f_{\zeta\zeta}|_{s,\beta} |g_{\zeta\zeta}|_{s,\beta} + |f_{\zeta\zeta}|_{s,\beta} |\partial_{\rho} g_{\zeta\zeta}|_{s,\beta} + \Big) \leq \frac{C}{\beta \mu^{4}} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta} [g]_{\sigma,\mu,\mathscr{D}}^{s,\beta}.
$$
 (4.18)

Thus, by [\(4.15\)](#page-15-1)-[\(4.18\)](#page-15-2), we get

$$
[h_6]_{\sigma,\mu,\mathscr{D}}^{s,\beta} \le \frac{C}{\beta\mu^2} [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta} [g]_{\sigma,\mu,\mathscr{D}}^{s,\beta+}.
$$
\n(4.19)

 \Box Summing the estimates $(4.11)-(4.14)$ $(4.11)-(4.14)$ $(4.11)-(4.14)$ and (4.19) , we get (4.9) .

4.2 Hamiltonian flow

In this subsection, we assume $g \equiv g^T$, namely,

$$
g = g_{\theta}(\theta; \rho) + \langle g_r(\theta; \rho), r \rangle + \langle g_\zeta(\theta; \rho), \zeta \rangle + \frac{1}{2} \langle \zeta, g_{\zeta\zeta}(\theta; \rho) \zeta \rangle.

 (4.20)

Then the Hamiltonian associated with *g* have the following form:

$$
\begin{cases}\n\dot{\theta}(t) = g_r(\theta; \rho) \\
\dot{r}(t) = -\nabla_{\theta} g(\theta, r, \zeta; \rho) \\
\dot{\zeta}(t) = J(g_{\zeta}(\theta; \rho) + g_{\zeta\zeta}(\theta; \rho)\zeta).\n\end{cases}
$$
\n(4.21)

5 The KAM step

5.1 Homological equation

At each KAM step, we look for a transformation such that the perturbation of the transformed Hamiltonian becomes smaller. Roughly speaking, for the *m*-th step, the Hamiltonian

is considered as a small perturbation of the normal form h_m , where f_m is of order ε_m . A transformation Φ_m is set up so that

6 Iteration and Convergence

Now we give the precise set-up of iteration parameters. Let $m \geq 0$ be the *m*-th KAM step.

- $M_{\omega,m} = M_{\omega,0}(2 2^{-m})$, which is used to dominate the norm of tangential frequencies, $L_m = L_0(2 - 2^{-m})$, which is used to dominate the inverse of tangential frequencies, $M_{\Omega,m} = M_{\Omega,0}(2 - 2^{-m})$, which is used to dominate the norm of normal frequencies, $\sigma_m = \frac{\sigma_0}{2} (1 + 2^{-m})$, which is used to dominate the width of the angle variable θ ,
- $\beta_m = \frac{\beta_0}{2} (1 + 2^{-m})$, which is used to quantify the regularizing effect of Hessian matrix.

Denote $E_m^0 = c_1 c_2 (\beta_m - \beta_{m+1})^{-1} (\sigma_m - \sigma_{m+1})^{-\alpha(n+d^*+2)}$ and $E_m = c_2^3 E_m^0$, where c_1 is the constant in [\(4.22\)](#page-15-6), and c_2 triples the largest of all the constants being implicit in the notation \leq in the last section. A_m = A + (B_{\zeta\zeta})_0 + \dots + (B_{\zeta\zeta})_{m-1},
$$
\n(6.34)

and

[f_m]_{\sigma_{m+1},\mu_m,\mathcal{D}_m}^{s,\beta_m} \leq \varepsilon_m. \tag{6.35}
$$

By [\(6.31\)](#page-35-3) and the chain rule, ones obtain

\sup_{\mathscr{O}^s(\sigma_{m+1},\frac{\mu_0}{2}(1+2^{-m-1}))} \|D\Phi^m\|_{\mathscr{L}(\mathbb{C}^{2n}\times Y_s,\mathbb{C}^{2n}\times Y_s)} \leq \prod_{k=1}^m \sup_{\mathscr{O}^s(\sigma_{k+1},\frac{3\mu_0}{4})} \|D\Phi_k\|_{\mathscr{L}(\mathbb{C}^{2n}\times Y_s,\mathbb{C}^{2n}\times Y_s)} \n<\prod_{k=1}^\infty (1+\frac{\gamma_0^3}{2^{2k}}) < 2.
$$
\n(6.36)

Furthermore, by [\(6.29\)](#page-35-4), [\(6.36\)](#page-36-0) and the mean value theorem, we get

\sup_{\substack{\theta^{s}(\sigma_{m+2}, \frac{\mu_{0}}{2}(1+2^{-m-2})) \\ \leq \sup_{\substack{\theta^{s}(\sigma_{m+1}, \frac{\mu_{0}}{2}(1+2^{-m-1})) \\ \theta^{s}(\sigma_{m+1}, \frac{\mu_{0}}{2}(1+2^{-m-1}))}} \|D\Phi^{m}\|_{\mathscr{L}(\mathbb{C}^{2n}\times Y_{s}, \mathbb{C}^{2n}\times Y_{s})} \sup_{\substack{\theta^{s}(\sigma_{m+2}, \frac{\mu_{0}}{2}(1+2^{-m-2})) \\ \theta^{s}(\sigma_{m+2}, \frac{\mu_{0}}{2}(1+2^{-m-2}))}} \| \Phi_{m+1} - id \|_{s}
$$
\n
$$
\leq 2C\left(\frac{\varepsilon_{m}}{\mu_{m}^{2}}\right)^{\frac{3}{4}} E_{m}^{\frac{1}{4}}
$$
\n
$$
\leq \frac{\varepsilon_{0}^{\frac{1}{2}}}{2^{m+1}}, \tag{6.37}
$$

where we denote $\Phi^0 = id$ and in the last inequality we use the facts

This shows that Φ^m converge uniformly on $\mathscr{O}^s(\frac{\sigma_0}{2}, \frac{\mu_0}{2}) \times \mathscr{D}_*,$ where $\mathscr{D}_* = \bigcap_{m \geq 0} \mathscr{D}_m$. Let $\Phi =$ $\lim_{m\to+\infty} \Phi^m$. Summing in [\(6.37\)](#page-36-1) with respect to $m \ge 0$, we get $\|\Phi - id\|_{s} \le \varepsilon_0^{\frac{1}{2}}$. Since the original Hamiltonian *H* is analytic in $\mathcal{O}^s(\sigma_0, \mu_0)$,

\langle \omega_*, r \rangle + \frac{1}{2} \langle \zeta, A_* \zeta \rangle + f_*.

Summing in [\(6.21\)](#page-34-0), [\(6.22\)](#page-34-0) with respect to $m \ge 0$, we get the estimates of ω_* , A_* in [\(2.17\)](#page-6-1) and [\(2.18\)](#page-6-2). Moreover, for $r = \zeta = 0$ and $|\mathfrak{S}\theta| < \frac{\sigma_0}{2}$, by [\(6.12\)](#page-33-1), [\(6.35\)](#page-36-2) and Cauchy estimates, we have

which leads to $\partial_r f_* = \partial_\zeta f_* = \partial_\zeta^2 f_* = 0$ by letting $m \to +\infty$.

7 Measure estimate

From [\(6.6\)](#page-32-5), we know that

\mathscr{D}\backslash\mathscr{D}_* = \bigcup_{m\geq 0} \bigcup_{\substack{k\in\mathbb{Z}^n\\|k|\leq N_m}} \left(\mathfrak{R}_k^{m,0} \bigcup \mathfrak{R}_k^{m,1} \bigcup \mathfrak{R}_k^{m,20} \bigcup \mathfrak{R}_k^{m,11}\right),\tag{7.1}
$$

where $\mathfrak{R}_k^{m,0}, \mathfrak{R}_k^{m,1}, \mathfrak{R}_k^{m,20}$ and $\mathfrak{R}_k^{m,11}$ are defined in [\(6.7\)](#page-32-6). In the following, we only estimate the set

\Theta := \bigcup_{m \geq 0} \bigcup_{\substack{k \in \mathbb{Z}^n \\ |k| \leq N_m}} \mathfrak{R}_k^{m,11} \tag{7.2}
$$

in detail, since the other three cases are much simpler.

Fix $m \geq 0$, $0 < |k| \leq N_m$ and $\kappa > 0$, we firstly study the set

$$

with $\lambda_i = b_1 i + b_0$ and $\lambda_j = b_1 j + b_0$.

Lemma 7.1. Assuming $\kappa < \frac{b_1}{3}$, then we have

meas\left(\bar{\mathfrak{R}}_k^m(\kappa)\right) \le C|k|\kappa,\tag{7.4}
$$

where $C > 0$ *is a constant only depending on n,* b_1 *,* $M_{\omega,0}$ *,* L_0 *.*

Proof. We introduce the perturbed frequencies $\omega = \omega_m(\rho)$ as parameters over the domain Δ := $\omega_m(\mathcal{D}_m)$ and consider the resonance zones $\dot{\mathfrak{R}}_{k,i,j}^m(\kappa) = \omega_m(\dot{\mathfrak{R}}_{k,i,j}^m(\kappa))$. From the iterative lemma, we know

Now we consider a fixed $\dot{\bar{\mathfrak{R}}}_{k,i,j}^m(\kappa)$. If $0 < |k| \leq \frac{b_1}{6M_{\omega,0}}|i-j|$, then

Summing [\(7.6\)](#page-37-0) with respect to $|i-j| < \frac{6M_{\omega,0}}{b_1}$ $\frac{u_{\omega,0}}{b_1}$ |*k*|, one has

\text{meas}\left(\dot{\mathfrak{R}}_{k}^{m}(\kappa)\right) < \left(4M_{\omega,0}\right)^{n-1}\left(1+\frac{6M_{\omega,0}}{b_{1}}\right)\left(1+\frac{12M_{\omega,0}}{b_{1}}|k|\right)\kappa. \tag{7.7}

Going back to the original parameter domain \mathscr{D}_m by the inverse frequency map ω_m^{-1} , we finally get

\text{meas}\big(\bar{\mathfrak{R}}_k^m(\kappa)\big) \le L_m^n \text{meas}\big(\dot{\bar{\mathfrak{R}}}_k^m(\kappa)\big) < (2L_0)^n (4M_{\omega,0})^{n-1} \left(1 + \frac{6M_{\omega,0}}{b_1}\right) \left(1 + \frac{12M_{\omega,0}}{b_1}|k|\right) \kappa, \tag{7.8}
$$

which is [\(7.4\)](#page-37-1) in the lemma.

Next, we give the estimate of Θ in [\(7.2\)](#page-37-2).

Lemma 7.2. *We have*

\geq b_1|i-j| - 4M_{\Omega,0}

\n

> \kappa_m(1+|i-j|),
$$
\n(7.10)

which implies

$$
\mathfrak{R}_0^{m,11} = \emptyset. \tag{7.11}
$$

It remains to consider the case $0 < |k| \le N_m$. Similarly, we introduce the perturbed frequencies $\omega = \omega_m(\rho)$ as parameters over the domain $\Delta := \omega_m(\mathcal{D}_m)$ and consider the resonance zones $\mathfrak{R}^{m,11}_{k,i,j,1,1,2}(\kappa_m)$. The eigenvalues $\Omega_{m,j,1}$ can be seen as functions of ω . Since $(Q_m)_j^j$ is Hermitian, by the variation principle of eigenvalue of matrix,

For a fixed $\mathfrak{R}_{k,i,j,1,1}^{m,11}$, if $0 < |k| \leq \frac{b_1}{6M_{\omega,0}}|i-j|$, then by [\(7.5\)](#page-37-3), [\(7.10\)](#page-38-1), the facts $M_{\Omega,0} < \frac{b_1}{8}$ and $\kappa_m \leq \kappa_0 < \frac{b_1}{12}$, we know

\geq b_1|i-j| - 4M_{\Omega,0} - 2M_{\omega,0}|k|

\n

> \kappa_m(1+|i-j|), \qquad (7.13)
$$

which implies $\mathfrak{R}^{m,11}_{k,i,j,l_1,l_2} = \mathbf{0}$; otherwise, $|k| > \frac{b_1}{6M_a}$ $\frac{b_1}{6M_{\omega,0}}|i-j|$, then by [\(7.12\)](#page-38-2), we have

\partial_{\vec{v}}(\langle k,\omega\rangle-\Omega_{m,i,\iota_1}(\rho)+\Omega_{m,j,\iota_2}(\rho))>|k|-\frac{2}{3}\geq \frac{|k|}{3},

Going back to the original parameter domain \mathscr{D}_m , we get

$$

with the index sets

\mathfrak{B}_1 = \left\{ ((i, t_1), (j, t_2)) \in \mathfrak{L} \times \mathfrak{L} : |i - j| < \frac{6M_{\omega, 0}}{b_1} |k|, \min\{i, j\} \ge J_m \right\},

\mathfrak{B}_2 = \left\{ ((i, t_1), (j, t_2)) \in \mathfrak{L} \times \mathfrak{L} : |i - j| < \frac{6M_{\omega, 0}}{b_1} |k|, \min\{i, j\} < J_m \right\},

where $J_m = \left(\frac{4M_{\Omega,0}}{\kappa_m^{2\alpha^*}}\right)^{\frac{1}{\beta_m}}$ and $\alpha^* = \frac{\beta_0}{2\beta_0 + 8\alpha^*}$ $\frac{\beta_0}{2\beta_0+8d^*+4}$. By the fact $\beta_m > \frac{\beta_0}{2}$, we have

\kappa_m^{2\alpha^*} < \left(\frac{\varepsilon_m}{\mu_m^2}\right)^{\frac{2}{\alpha}}.\tag{7.17}

Then by [\(7.17\)](#page-39-0) and the fact $\beta_m < 1$, we have

\geq 2\kappa_m^{2\alpha^*} (1 + |i - j|) - \kappa_m^{2\alpha^*}
$$

\n
$$
\geq \kappa_m^{2\alpha^*} (1 + |i - j|)
$$

\n
$$
\geq \kappa_m (1 + |i - j|),
$$

\n(7.19)

which means

$$
\mathfrak{R}^{m,11}_{k,i,j,1_1,1_2} \subset \bar{\mathfrak{R}}^m_{k,i,j}(2\kappa_m^{2\alpha^*}) \subset \bar{\mathfrak{R}}^m_k(2\kappa_m^{2\alpha^*}).
$$
\n(7.20)

Thus, by [\(7.20\)](#page-39-1) and Lemma [7.1,](#page-37-4) we get

\text{meas}\left(\bigcup_{\mathfrak{B}_1} \mathfrak{R}^{m,11}_{k,i,j,l_1,l_2}\right) \le \text{meas}\left(\bar{\mathfrak{R}}^m_k(2\kappa_m^{2\alpha^*})\right) \le C|k|\kappa_m^{2\alpha^*},\tag{7.21}

where $C > 0$ is a constant only depending on $n, b_1, M_{\omega,0}, L_0$.

Next, consider the case $((i,1), (j,1,2)) \in \mathfrak{B}_2$. We will count the number of the set \mathfrak{B}_2 , denoted by $\sharp\mathfrak{B}_2$. By [\(7.18\)](#page-39-2), we know

By [\(7.15\)](#page-39-3), [\(7.23\)](#page-40-5) and the fact $J_m \leq (\frac{4M_{\Omega,0}}{\kappa_m^{2\alpha^*}})^{\frac{2}{\beta_0}}$, we get

\text{meas}\left(\bigcup_{\mathfrak{B}_2} \mathfrak{R}^{m,11}_{k,i,j,1_1,1_2}\right) \le C|k|\,\kappa_m^{2\alpha^*},\tag{7.24}

where $C > 0$ is a constant only depending on $n, b_1, c^*, d^*, M_{\omega,0}, L_0, M_{\Omega,0}, \beta_0$.

Summing [\(7.21\)](#page-39-4) and [\(7.24\)](#page-40-6), we get

where $C > 0$ is a constant only depending on $n, b_1, c^*, d^*, M_{\omega,0}, L_0, M_{\Omega,0}, \beta_0$, and the last inequality follows from [\(6.15\)](#page-33-6) and [\(7.17\)](#page-39-0). Finally, taking sum in [\(7.26\)](#page-40-8) with respect to $m \ge 0$, this lemma is proved. proved.

8 Appendix

< $2 \sum_{k \in \mathbb{N}^+} \frac{1}{k^{1 + \beta}}$
< $2 + \frac{2}{\beta}.$

Lemma 8.3. Let $B = (b_i^j)_{i,j \in \mathbb{N}^+}$ be a complex infinite-dimensional matrix. If its Frobenius norm

Lemma 8.4. *Let* $B = (b_i^j)_{i,j \in \mathbb{N}^+}$ *be a complex infinite-dimensional matrix. If both* ℓ^{∞} -operator norm *and* ℓ 1 *-operator norm are bounded, i.e.,*

$$
\begin{aligned} \|B\|_{\ell^\infty\to\ell^\infty} &:= \sup_{i\in\mathbb{N}^+}\sum_{j\in\mathbb{N}^+} |b_i^j| < +\infty, \\ \|B\|_{\ell^1\to\ell^1} &:= \sup_{j\in\mathbb{N}^+}\sum_{i\in\mathbb{N}^+} |b_i^j| < +\infty, \end{aligned}
$$

then **B** is a bounded operator on $\ell^2(\mathbb{N}^+)$ with its ℓ^2 -operator norm satisfying

$$
||B||_{\ell^2 \to \ell^2} \le ||B||_{\ell^{\infty} \to \ell^{\infty}}^{\frac{1}{2}} ||B||_{\ell^1 \to \ell^1}^{\frac{1}{2}}.
$$
\n(8.5)

Proof. For $z = (z_j)_{j \in \mathbb{N}^+} \in \ell^2(\mathbb{N}^+)$, by Schwarz inequality, we get

$$
||Bz||_{\ell^2}^2 = \sum_{i \in \mathbb{N}^+} \Big| \sum_{j \in \mathbb{N}^+} b_i^j z_j \Big|^2
$$

\n
$$
\leq \sum_{i \in \mathbb{N}^+} \Big(\sum_{j \in \mathbb{N}^+} |b_i^j| \Big) \Big(\sum_{j \in \mathbb{N}^+} |b_i^j| |z_j|^2 \Big)
$$

\n
$$
\leq \Big(\sup_{i \in \mathbb{N}^+} \sum_{j \in \mathbb{N}^+} |b_i^j| \Big) \Big(\sum_{i,j \in \mathbb{N}^+} |b_i^j| |z_j|^2 \Big)
$$

\n
$$
= \Big(\sup_{i \in \mathbb{N}^+} \sum_{j \in \mathbb{N}^+} |b_i^j| \Big) \sum_{j \in \mathbb{N}^+} \Big(\sum_{i \in \mathbb{N}^+} |b_i^j| \Big) |z_j|^2
$$

\n
$$
\leq \Big(\sup_{i \in \mathbb{N}^+} \sum_{j \in \mathbb{N}^+} |b_i^j| \Big) \Big(\sup_{j \in \mathbb{N}^+} \sum_{i \in \mathbb{N}^+} |b_i^j| \Big) \sum_{j \in \mathbb{N}^+} |z_j|^2.
$$

From this the estimate [\(8.5\)](#page-41-3) follows.

Lemma 8.5. *Assume* $A \in \mathcal{M}_{0,0}$ *. For any* $k \in \mathbb{Z}^n$ *with* $|k| \leq N$ *, define* $B(k)$ *by*

$$
B^{j,\iota_2}_{i,\iota_1}(k)=\frac{A^{j,\iota_2}_{i,\iota_1}}{\langle k,\omega\rangle-\Omega_{i,\iota_1}+\Omega_{j,\iota_2}},\ \ for\ \ |k|+|i-j|\neq 0,
$$

 $and B^{j,12}_{j,1_1}(0) = 0$, where $\omega \in \mathbb{R}^n$, $\{\Omega_{j,1}\}_{(j,1) \in \mathfrak{L}}$ *is a sequence of real numbers satisfying*

$$
|\Omega_{j,\iota}-b_1j-b_0|\leq \frac{M_\Omega}{j^\beta},\;\; \text{for}\;\; (j,\iota)\in\mathfrak{L}
$$

*with b*1,*b*⁰ *in* [\(2.9\)](#page-5-3) *and M*Ω,β *being given positive real numbers. Moreover, assume*

$$
|\langle k,\omega\rangle-\Omega_{i,t_1}+\Omega_{j,t_2}|\geq \kappa(1+|i-j|)
$$

for $(i, i_1), (j, i_2) \in \mathcal{L}$ *with* $|k| + |i - j| \neq 0$. Then $B(k) \in \mathcal{M}_{0,0}$, and there exists a constant $C > 0$ $depending on n, b₀, b₁, c[*], d[*], |\omega|, M_{\Omega}, \beta$ *such that*

$$
||B_i^j(k)|| \le \frac{CN^{\frac{d^*}{2}}}{\kappa^{\frac{d^*}{2\beta}+1}(1+|i-j|)}||A_i^j||. \tag{8.6}
$$

Proof. See Lemma 4.3 and its proof in [\[18\]](#page-44-14).

Lemma 8.6. Assume $f \in \mathscr{T}^{s,\beta}_{\sigma,\mu,\varnothing}$. Then we have $f^T \in \mathscr{T}^{s,\beta}_{\sigma,\mu,\varnothing}$,

$$
[f^T]_{\sigma,\mu,\mathcal{D}}^{s,\beta} \le C[f]_{\sigma,\mu,\mathcal{D}}^{s,\beta},\tag{8.7}
$$

and for any $0 < \mu' < \mu$,

$$
[f - fT]_{\sigma,\mu',\mathscr{D}}^{s,\beta} \le C \Big(\frac{\mu'}{\mu}\Big)^3 [f]_{\sigma,\mu,\mathscr{D}}^{s,\beta},\tag{8.8}
$$

where C > 0 *is an absolute constant.*

Proof. See Proposition 4.2 and its proof in [\[17\]](#page-44-13).

Lemma 8.7. *Assume* $s > d - 2 \ge 0$ *and* $V(x) \in \mathcal{H}^s$ *. Define the matrix Q with its element*

$$
Q_{i,t_1}^{j,t_2} = \int_{\mathbb{R}^d} V(x) \Psi_{i,t_1}(x) \Psi_{j,t_2}(x) dx, \quad (i,t_1), (j,t_2) \in \mathfrak{L}.
$$

Then there exists $\beta \in (0, \frac{1}{8})$ *only depending on d,s such that for any i, j* ≥ 1 *,*

$$
\|Q_i^j\| \le \frac{C}{(ij)^{\frac{\beta}{2}} w^s(i,j)} \|V\|_s,
$$
\n(8.9)

where C is a positive constant only depending on d,*s.*

Proof. See Lemma 3.2 and its proof in [\[18\]](#page-44-14).
