Resonant modes of two hard inclusions within a soft elastic material and their stress estimate

Abstract

In this paper, we are concerned with subwavelength resonant modes of two hard inclusions embedding in soft elastic materials to realize negative materials in elasticity. All the 12 subwavelength resonant frequencies are derived explicitly for general convex resonators. In addition, the resonant modes are categorized into dipolar, quadrupolar, and hybrid groups, facilitating the effective realization of negative mass density, negative shear modulus and double-negative properties (both mass density and shear modulus) in elastic metamaterials. Moreover, we analyze the stress distribution between two hard inclusions when they are closely touching. We also precisely derive the sharp blow-up rates of the gradient estimates of the resonant modes. Our findings show that certain resonant modes have bounded stress estimates when the curvature of the hard inclusions is appropriately designed. These results provide valuable insights into the stability of the design and fabrication of elastic metamaterials. Lastly, we express the scattering wave fields explicitly in terms of resonant modes, offering a clear understanding of their impact on the overall scattering behavior.

1 Introduction

Metamaterials is a class of man-made materials that exhibit exotic and distinct properties not found in nature. In history, the exploration of artificial materials began in the late 19th century. The first theoretical investigation of the negative-index materials (NIMs) was given by Victor Veselago in 1967 by assuming negative values of permittivity and permeability [62], which opened up new possibilities in material science. However, NIMs did not receive much attention at that time, as many researchers believed they did not exist. It was not until the early 21st century that the first NIM was realized in the laboratory using artificial lumped-element loaded transmission lines [61]. Since then, metamaterials have attracted significant attention from both industrial and academic communities,

leading to extensive research and innovation in the field. The peculiar physical properties of metamaterials have led to numerous important applications. Invisibility cloaking, for instance, has been a notable area of interest, enabling the manipulation of electromagnetic waves to render objects invisible [4, 39, 41-43, 57]. Super-resolution imaging is another application where metamaterials have shown promise, allowing for imaging beyond the diffraction limit [14, 16, 40]. Metamaterials also find applications in waveguides, where they can control and guide the propagation of waves [1, 8, 53]. Additionally, commercially available antennas have benefited from the use of metamaterials, enhancing their performance and functionality [31, 59].

Metamaterials are indeed synthetic composite materials created by arranging subwavelength resonators, also known as "meta-atoms", in periodic or random patterns. These meta-atoms are typically constructed by embedding elements like plastics and metals into a matrix, where these materials enjoy high contrasts in specific physical parameters. The term "sub-wavelength" indicates that the size of the meta-atom is smaller than the wavelength of the incident wave, while "resonator" denotes that resonance occurs within a specific frequency range. Metamaterials can be classified into various types, including acoustic, electromagnetic, and elastic metamaterials, based on their modified properties. Acoustic metamaterials often utilize sub-wavelength resonators created by embedding bubbles in liquids [7, 17, 49]. In electromagnetic metamaterials, common meta-atoms include silicon nanoparticles, split-ring resonators, and conducting wires [10, 33, 60].

In this paper, we mainly consider elastic metamaterials, which have been less explored compared to acoustic and electromagnetic metamaterials. This limited exploration is mainly due to the coupling between longitudinal and transverse waves in elasticity, causing elastic waves to exhibit properties of both acoustic and electromagnetic waves. Elastic materials are characterized by three physical parameters: bulk modulus, mass density, and shear modulus. To achieve negative values for these parameters, monopolar, dipolar, and quadrupolar resonances should be induced, respectively [34]. In particular, the works [15, 35] use the structure of bubbles embedded in soft elastic materials (BSE structures) to induce monopolar resonance, resulting in negative bulk modulus. The paper [44] provides the first mathematical proof of the resonances in BSE structures. To realize negative mass density, studies [54, 55] have investigated hard inclusions embedded in soft elastic materials (HISE structures) to induce dipolar resonance. The corresponding mathematical study is presented in [48].

This paper concentrates on the investigation of a dimer consisting of two hard inclusions embedded in soft elastic materials (THES structures) to induce quadrupolar resonance, thereby achieving negative shear modulus values. For more physical studies, we refer to [34]. It has been demonstrated that both the electric field and the stress field exhibit blow-up behavior between adjacent inclusions when they are brought closer. Please refer to the studies in the context of electrostatics and electromagnetic [2,9,11,19,23-26,28,30,50,52,56,58,63] (this is far from a complete list), and stress field within the framework of linear elasticity [5,12,13,29,37,47,51]. In the current study, we explore the blow-up behavior of eigenmode gradients as the resonators approach each other. We would like to mention that the blow-up phenomenon here is different from the aforementioned studies since we are considering the resonant scenario. Related studies on the Helmholtz problem can be found in [6, 46].

The contributions of this study are as follows. First, all 12 resonant frequencies of the THES structure are explicitly derived in Theorem 4.1 under certain assumptions about the dimer structure. These resonant frequencies exhibit different asymptotic behaviors based on the separation distance of the inclusions and the contrast in material parameters (see Theorem 4.1 and Remark 4.1). It is noted that deriving the resonant frequencies involves analyzing a 12×12 matrix, making the analysis highly nontrivial. Moreover, the resonant modes are classified into three different groups. The first one belongs to the dipolar resonance, which can be used to realize the negative mass density in elastic metamaterials. The second one belongs to the quadrupolar resonances, which can be utilized to achieve negative shear modulus. The last one includes both dipolar and quadrupolar resonances, thus helping to realize the negative mass density and shear modulus simultaneously. Please refer to Remark 4.2 for more details. Second, we analyze the stress distribution between two closely touching hard inclusions under the subwavelength resonance. The sharp blow-up rates of the gradient estimate for the resonant modes are derived exactly in Theorem 5.1. It is shown that the stress concentration of some resonant modes is very strong, which leads to poor stability of the metamaterials. However, the stress estimates of some other resonant modes are of $\mathcal{O}(1)$ if the curvature of the hard inclusions is properly chosen. These results provide valuable insights into the stability of the design and fabrication of elastic metamaterials (see Remark 5.2). Third, the scattering wave fields are explicitly expressed in terms of the resonant modes in Theorem 6.1, offering a clear understanding of their impact on the overall scattering behavior of the THES structure.

The paper is organized as follows. Section 2 presents the mathematical formulation of the problem. In Section 3, we provide some preliminaries and auxiliary results for the subsequent analysis. In Section 4, we explicitly derive the subwavelength resonant frequencies and investigate their resonant modes. Section 5 analyzes the blow-up behavior of stress fields between two hard inclusions. Section 6 derives the scattering field in the quasi-static regime using the resonant modes. In Appendix A, we provide the proofs of some auxiliary results in the text.

2 Mathematical formulation

In this section, we present the mathematical formulation of the problem considered in the paper. We study the configuration of a dimer consisting of two hard elastic inclusions embedded in soft elastic materials in three dimensions. The matrix material is described by two Lamé parameters (λ, μ) , satisfying the strong ellipticity conditions

$$\mu > 0 \quad \text{and} \quad 3\lambda + 2\mu > 0. \tag{2.1}$$

The density in the background is designated by ρ . Let D_1 and D_2 be two disjoint convex open subsets in \mathbb{R}^3 with $C^{2,\alpha}$ boundaries, $\alpha \in (0,1)$, and denote the two hard inclusions. The corresponding Lamé parameters and the density of the hard inclusions are parameterized by $(\tilde{\lambda}, \tilde{\mu})$ and $\tilde{\rho}$, respectively. Then, we introduce the three dimensionless contrast parameters δ , η and τ defined by

$$(\tilde{\lambda}, \tilde{\mu}) = \frac{1}{\delta}(\lambda, \mu), \quad \tilde{\rho} = \frac{1}{\eta}\rho, \quad \tau = \sqrt{\delta/\eta}.$$
 (2.2)

Since we are considering the configuration that hard inclusions are embedded within soft elastic materials (e.g. lead inclusions coated with silicone in [55]), the contrast parameters δ , η and τ satisfy the following conditions:

$$\delta \ll 1, \quad \eta \ll 1, \quad \text{and} \quad \tau \leq \mathcal{O}(1).$$

Define the domain D by $D = D_1 \cup D_2$ and denote by $D^e := \mathbb{R}^3 \setminus \overline{D}$ the exterior of the domain D. Define the elasticity tensor $\mathbb{C} = (C_{ijkl})_{i,j,k,l=1}^3$ by

$$C_{ijkl} = \lambda \delta_{ij} \delta_{kl} + \mu (\delta_{ik} \delta_{jl} + \delta_{il} \delta_{jk}).$$

Let \mathbf{u}^i be a time-harmonic incident elastic wave satisfying the elastic equation in the entire space \mathbb{R}^3

where $\omega > 0$ denotes the angular frequency. In (2.3), the Lamé operator $\mathcal{L}_{\lambda,\mu}$ associated with the parameters (λ,μ) is defined by

$$\mathcal{L}_{\lambda,\mu}\mathbf{u}^{i} := \nabla \cdot (\mathbb{C}e(\mathbf{u}^{i})) = \mu \triangle \mathbf{u}^{i} + (\lambda + \mu)\nabla \nabla \cdot \mathbf{u}^{i}.$$

Here, $e(\mathbf{u}^i)$ is the strain tensor given by

$$e(\mathbf{u}^i) = \frac{1}{2} (\nabla \mathbf{u}^i + (\nabla \mathbf{u}^i)^t),$$

where t signifies the transpose. Then the total displacement field \mathbf{u} of the above described system satisfies the following partial differential equations (PDEs) [36]

where τ is given in (2.2) and the subscripts \pm indicate the limits from outside and inside of D, respectively. Here, the traction operator ∂_{ν} is defined by

$$\partial_{\boldsymbol{\nu}} \mathbf{u}(\mathbf{x}) := \lambda (\nabla \cdot \mathbf{u}) \boldsymbol{\nu} + \mu \left(\nabla \mathbf{u} + (\nabla \mathbf{u})^t \right) \boldsymbol{\nu},$$

with ν denoting the exterior unit normal vector to ∂D . In (2.5), the scattering wave $\mathbf{u}^s = \mathbf{u} - \mathbf{u}^i$ satisfies the following radiation condition [32, 38]:

as $|\mathbf{x}| \to +\infty$, where i signifies the imaginary unit and

$$k_s = \omega/c_s, \qquad k_p = \omega/c_p,$$

$$c_s = \sqrt{\mu/\rho}, \qquad c_p = \sqrt{(\lambda + 2\mu)/\rho}.$$

It is well-known that the elastic wave can be decomposed into the shear wave (s-wave) and the compressional wave (p-wave). In (2.6), the parameters k_s and k_p signify the wavenumbers of the s-wave and p-wave, respectively.

In this work, we mainly apply the potential theory to analyze the system (2.5). Thus, we first present the potential theory in elasticity. Let the function $\Gamma^{\omega} = (\Gamma_{i,j}^{\omega})_{i,j=1}^{3}$ signify the fundamental solution of the operator $\mathcal{L}_{\lambda,\mu} + \rho \omega^{2}$ in three dimensions given by [22]

where δ_{ij} is Kronecker delta function. In particular, when $\omega = 0$, the function Γ^0 is called the Kelvin matrix of the fundamental solution, and we denote Γ^0 by Γ for simplicity. The function Γ has the following expression [20]

Then the single-layer potential associated with the fundamental solution Γ^ω is defined by

for $\varphi \in L^2(\partial D)^3$. On the boundary ∂D , the conormal derivative of the single-layer potential satisfies the following jump formula

where

$$\mathbf{K}_{D}^{\omega,*}[\boldsymbol{\varphi}](\mathbf{x}) = \text{p.v.} \int_{\partial D} \partial_{\boldsymbol{\nu}_{\mathbf{x}}} \boldsymbol{\Gamma}^{\omega}(\mathbf{x} - \mathbf{y}) \boldsymbol{\varphi}(\mathbf{y}) ds(\mathbf{y}),$$

with p.v. standing for the Cauchy principal value. It is noted that the operator $\mathbf{K}_D^{\omega,*}$ in (2.10) is called the Neumann-Poincaré (N-P) operator, which is a critical operator in the analysis of metamaterials. In what follows, we denote \mathbf{S}_D^0 , $\mathbf{K}_D^{0,*}$ by \mathbf{S}_D , \mathbf{K}_D^* , respectively, for simplicity. More details will be given in Subsection 3.2.

With the help of the potential theory presented above, the solution to the system (2.5) can be written as

for some density functions $\varphi, \psi \in L^2(\partial D)$. By matching the transmission conditions on the boundary, i.e. the third and fourth conditions in (2.5) and with the help of the jump formula in (2.10), the density functions φ and ψ in (2.11) should satisfy the following system:

with

where

For the subsequent discussion, we define the spaces $\mathcal{H} := L^2(\partial D) \times L^2(\partial D)$ and $\mathcal{H}^1 := H^1(\partial D) \times L^2(\partial D)$. It is noted the operator $\mathcal{A}(\omega, \delta)$ is bounded from \mathcal{H} to \mathcal{H}^1 (c.f. [3]). Next, we define the sub-wavelength resonance of the scattering system (2.5) based on the operator $\mathcal{A}(\omega, \delta)$.

Definition 2.1. The sub-wavelength resonance of the scattering system (2.5) occurs if there exists a frequency $\omega \ll 1$ such that the operator $\mathcal{A}(\omega, \delta)$ has a nontrivial kernel, i.e.

$$\mathcal{A}(\omega,\delta)[\Phi](\mathbf{x}) = 0, \qquad (2.13)$$

for some nontrivial $\Phi \in \mathcal{H}$. Here, ω is called the resonant frequency (or eigenfrequency) and Φ is called the eigenvector. For each resonant frequency ω , we define the corresponding resonant mode (or eigenmode) as

$$\mathbf{u} = \begin{cases} \mathbf{S}_D^{\tau\omega}[\boldsymbol{\varphi}](\mathbf{x}), & \mathbf{x} \in D, \\ \mathbf{S}_D^{\omega}[\boldsymbol{\psi}](\mathbf{x}), & \mathbf{x} \in \mathbb{R}^3 \backslash \overline{D}. \end{cases}$$

In the study, we shall systematically and comprehensively investigate the resonant characteristics of the system (2.5). All the subwavelength resonant frequencies shall be derived explicitly. Then the resonant modes are classified into dipolar, quadropolar, and hybrid resonances. Furthermore, the stress fields between two hard inclusions are analyzed quantitatively. Lastly, the scattering wave fields in the system (2.5) are represented in terms of the subwavelength eigenmodes.

3 Preliminaries and auxiliary results

In this section, we present some basic notation, preliminaries and auxiliary results that will be used subsequently.

3.1 Asymptotic notation

We shall use the following notation in this paper.

Definition 3.1. Let f be a real- or complex-valued function, and let g be a real-valued function that remains strictly positive in a neighborhood of \mathbf{x}_0 . We write that

$$f(\mathbf{x}) = \mathcal{O}(g(\mathbf{x})) \quad \text{as } \mathbf{x} \to \mathbf{x}_0$$

if and only if there exists a positive constant M such that $|f(\mathbf{x})| \leq Mg(\mathbf{x})$ for all \mathbf{x} in a neighborhood of \mathbf{x}_0 .

Definition 3.2. Let f and g be real-valued functions which are strictly positive in a neighborhood of \mathbf{x}_0 . We write that

$$f(\mathbf{x}) \sim g(\mathbf{x}) \quad \text{as } \mathbf{x} \to \mathbf{x}_0$$

if and only if $f(\mathbf{x}) = \mathcal{O}(g(\mathbf{x}))$ as $\mathbf{x} \to \mathbf{x}_0$.

3.2 Layer potentials and Neumann-Poincaré operator

We first provide the asymptotic expansion of the fundamental solution Γ^{ω} defined in (2.8) (c.f. [48]).

Lemma 3.1. For $\omega \ll 1$, there holds the following asymptotic expansion of the fundamental solution Γ^{ω} defined in (2.8)

$$\alpha_1 = \left(\frac{1}{\mu} + \frac{1}{2\mu + \lambda}\right), \quad \alpha_2 = \left(\frac{1}{\mu} - \frac{1}{2\mu + \lambda}\right)$$

and c_s, c_p defined in (2.7).

From Lemma 3.1, the single layer potential \mathbf{S}_D^{ω} defined in (2.9) has the following asymptotic expansion:

where

In particular, one has that

Then the following two lemmas hold [21].

Lemma 3.2. The single layer potential operator \mathbf{S}_D is invertiable from $L^2(\partial D)$ to $H^1(\partial D)$.

Lemma 3.3. The norm $\|\mathbf{S}_{D,n}\|_{\mathcal{L}(L^2(\partial D), H^1(\partial D))}$ is uniformly bounded with respect to n. Moreover, the series in (3.1) is convergent in $\mathcal{L}(L^2(\partial D), H^1(\partial D))$.

Next, we consider the asymptotic expansion of N-P operator $\mathbf{K}_D^{\omega,*}$ given in (2.10). Using Lemma 3.1, we have the following asymptotic expansion:

In particular, we have

which follows from that the function $\Gamma_1(\mathbf{x})$ is a constant. Moreover, the following lemma holds.

Lemma 3.4. The norm $\|\mathbf{K}_{D,n}^*\|_{\mathcal{L}(L^2(\partial D))}$ is uniformly bounded with respect to n. Moreover, the series in (3.2) is convergent in $\mathcal{L}(L^2(\partial D))$ (c.f. [21]).

Then we introduce the vector space \mho that is spanned by all linear solutions to the equation

$$\begin{cases} \mathcal{L}_{\lambda,\mu} \mathbf{u} = 0 & \mathbf{x} \in D, \\ \partial_{\boldsymbol{\nu}} \mathbf{u} = 0 & \mathbf{x} \in \partial D. \end{cases}$$

Indeed, the space \Im can be explicitly expressed as [3]

$$\mho = \left\{ \mathbf{a} + \mathbf{B}\mathbf{x}, \mathbf{a} \in \mathbb{R}^3, \mathbf{B} \in M^A \right\},\$$

where M^A is the space of antisymmetric matrices with the size 3×3 . A direct calculation shows that the dimension of the space \mho is 12 and the space \mho is spanned by

$$\boldsymbol{\xi}_{i} = \begin{cases} \boldsymbol{\varkappa}_{i}, \text{ on } \partial D_{1}, \\ 0 \text{ on } \partial D_{2}, \end{cases} \qquad \boldsymbol{\xi}_{i+6} = \begin{cases} 0 \text{ on } \partial D_{1}, \\ \boldsymbol{\varkappa}_{i}, \text{ on } \partial D_{2}, \end{cases} \qquad 1 \le i \le 6, \qquad (3.3)$$

where the functions \varkappa_i , $1 \leq i \leq 6$, are given by

Lemma 3.5. The kernel of the operator $-\mathbf{I}/2 + \mathbf{K}_D$ coincides with the space \mho , where \mathbf{K}_D is the adjoint operator of \mathbf{K}_D^* (c.f. [3]).

Lemma 3.6. Let ζ_i satisfy $\mathbf{S}_D[\zeta_i] = \boldsymbol{\xi}_i$ on ∂D with $1 \leq i \leq 12$. The kernel of the operator $-\mathbf{I}/2 + \mathbf{K}_D^*$ is consist of ζ_i (c.f. [18]).

3.3 Auxiliary estimates

In the subsequent analysis, we need the quantitative estimates of $\int_{\partial D} \zeta_i \boldsymbol{\xi}_j$, $1 \leq i, j \leq 12$. To obtain these estimates, we apply Lemma 3.6, which yields that $\mathbf{w}_i := \mathbf{S}_D[\zeta_i]$ is the unique solution of the Dirichlet scattering system as follows (c.f. [3]):

Then it follows from the jump condition (2.10) and Lemma 3.6 that

Moreover, by using the definitions of $\mathcal{L}_{\lambda,\mu}$ and \mathbf{w}_i in (2.4) and (3.5), respectively, and the integration by parts, we obtain

$$\int_{\partial D} \frac{\partial \mathbf{w}_i}{\partial \boldsymbol{\nu}} \Big|_{+} \boldsymbol{\xi}_j = -\int_{D^e} \left(\mathbb{C}e(\mathbf{w}_i), e(\mathbf{w}_j) \right) =: -\mathcal{E}_{i,j} \quad i, j = 1, \dots, 12.$$

To analyze the estimates of $\mathcal{E}_{i,j}$ in (3.7), we provide more characteristics of the two domains D_1 and D_2 . Let ε denote the distance between the two domains, namely,

$$\varepsilon := \operatorname{dist}(\partial D_1, \partial D_2). \tag{3.8}$$

We write (\mathbf{x}', x_3) for $\mathbf{x} = (x_1, x_2, x_3) \in \mathbb{R}^3$ with $\mathbf{x}' = (x_1, x_2) \in \mathbb{R}^2$ and $x_3 \in \mathbb{R}$. Denote by B'_r a disk on the plane $x_3 = 0$ with the radius r centered at the origin. By a translation and rotation of coordinates (if necessary), there exists a constant R_0 independent of ε , such that the sections of ∂D_1 and ∂D_2 near the origin, respectively, can be represented by

In (3.9), the functions $h_i \in C^{2,\alpha}(B'_{2R_0}), i = 1, 2$, have the expressions

where C is a positive constant independent of ε and κ is the curvature of ∂D . Throughout the paper, the constant C is independent of ε , and may vary from line to line in various inequalities. Here we would like to remark that our method can be applied to deal with the more general inclusions case, say, $h_i(\mathbf{x}') = (-1)^{i+1}\kappa_i |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha})$ with two positive constants κ_1 and κ_2 . For $0 < r \leq 2R_0$, we define the narrow region between ∂D_1 and ∂D_2 as follows:

$$\Omega_r := \left\{ (\mathbf{x}', x_3) \in \mathbb{R}^3 : -\frac{\varepsilon}{2} + h_2(\mathbf{x}') < x_3 < \frac{\varepsilon}{2} + h_1(\mathbf{x}'), \ |\mathbf{x}'| < r \right\},$$
(3.11)

and the vertical distance between ∂D_1 and ∂D_2 is denoted by

$$\delta(\mathbf{x}') := \varepsilon + h_1(\mathbf{x}') - h_2(\mathbf{x}') = \varepsilon + \kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha}).$$
(3.12)

For the subsequent analysis, we need some assumptions on the structure D.

Assumption 3.1. We assume the dimer D has the following symmetric assumptions:

1. the domain D is symmetric with respect to the axis x_1 , i.e.

2. the domain D is symmetric with respect to the axis x_2 , i.e.

where $C_{i,i}$ and $C_{i,j}$ are constants independent of ε ;

for i = 1, 2,

\mathcal{E}_{i,i+10} = \mathcal{E}_{i+10,i}, \quad \mathcal{E}_{i+4,i+6} = \mathcal{E}_{i+6,i+4},$$
(3.14)

and for i = 4, 5, 6, 10, 11, 12,

$$\frac{1}{C} \le \mathcal{E}_{i,i} \le C;$$

(iii) under Assumption 3.1, for i = 1, 5, 7, 11, j = 2, 3, 4, 6, 8, 9, 10, 12, and i = 2, 6, 8, 12, j = 1, 3, 4, 5, 7, 9, 10, 11, and i = 3, 9, j = 1, 2, 4, 5, 6, 7, 8, 10, 11, 12, and i = 4, 10, j = 1, 2, 3, 5, 6, 7, 8, 9, 11, 12,

$$\mathcal{E}_{i,j}=0.$$

Moreover, we have

$$\mathcal{E}_{i,i} = \mathcal{E}_{i+6,i+6}, \quad i = 1, \dots, 6,$$

$$\mathcal{E}_{i,i+4} = -\mathcal{E}_{i+6,i+10}, \quad \mathcal{E}_{i,i+10} = -\mathcal{E}_{i+6,i+4}, \quad i = 1, 2;$$

(iv) under Assumption 3.1, we have for $i = 1, \ldots, 6$,

$$0 \le \mathcal{E}_{i,i} \pm \mathcal{E}_{i,i+6} \le C, \quad 0 \le \mathcal{E}_{i+6,i+6} \pm \mathcal{E}_{i+6,i} \le C.$$

The proof is inspired by the main idea in [13, 45] and is given in Appendix A.

Remark 3.1. Our arguments in Appendix A work well for $C^{2,\alpha}$ resonators with *m*-convex boundaries, that is, the assumption (3.10) becomes

$$h_i(\mathbf{x}') = (-1)^{i+1} \frac{\kappa}{2} |\mathbf{x}'|^m + O(|\mathbf{x}'|^{m+1}), \quad i = 1, 2, \ m > 2.$$

See, for instance, [45]. We leave the details to the interested reader.

4 Resonant frequencies and resonant modes

In this section, we study the resonant phenomenon of the system (2.5) including deriving the resonant frequencies and the corresponding eigenmodes. To that end, we need first investigate the properties of the matrix \mathcal{B} defined by

$$\mathcal{B}_{i,j} = \int_D \mathbf{S}_D[\boldsymbol{\zeta}_i] \boldsymbol{\xi}_j, \qquad (4.1)$$

where $\boldsymbol{\xi}_j$ and $\boldsymbol{\zeta}_i$ are given in (3.3) and Lemma 3.6, respectively.

Proposition 4.1. The matrix \mathcal{B} defined in (4.1) has the following properties:

(i) the matrix \mathcal{B} is symmetric, i.e. $\mathcal{B}_{i,j} = \mathcal{B}_{j,i}$;

(ii) some of the elements of the matrix \mathcal{B} satisfy

$$\mathcal{B}_{i,j} = \begin{cases} |D_1|, & i = j = 1, 2, 3, \\ \int_{D_1} |\varkappa_i|^2, & i = j = 4, 5, 6, \\ |D_2|, & i = j = 7, 8, 9, \\ \int_{D_2} |\varkappa_{i-6}|^2, & i = j = 10, 11, 12 \\ 0, & i = 1, \dots, 6, j = 7, \dots, 12, \\ 0, & i = 7, \dots, 12, j = 1, \dots, 6, \\ \int_{D_1} x_3, & \text{for pairs } \{i, j\} \quad \{1, 5\}, \{2, 6\}, \{5, 1\}, \{6, 2\}, \\ \int_{D_2} x_3, & \text{for pairs } \{i, j\} \quad \{7, 11\}, \{8, 12\}, \{11, 7\}, \{12, 8\}, \\ 0, & \text{for pairs } \{i, j\} \quad \{1, 2\}, \{1, 3\}, \{2, 3\}, \{7, 9\}, \{8, 9\}, \\ 0, & \text{for pairs } \{i, j\} \quad \{2, 1\}, \{3, 1\}, \{3, 2\}, \{8, 7\}, \{9, 7\}, \{9, 8\}, \end{cases}$$

where \varkappa_i is given in (3.4);

(iii) under Assumption 3.1, the other elements of the matrix \mathcal{B} vanish.

Proof. From the choice of ζ_i in Lemma 3.6 and the definition of $\mathcal{B}_{i,j}$ in (4.1), we have that

$$\mathcal{B}_{i,j} = \int_D \mathbf{S}_D[\boldsymbol{\zeta}_i] \boldsymbol{\xi}_j = \int_D \boldsymbol{\xi}_i \boldsymbol{\xi}_j, \qquad (4.2)$$

which proves the statement (i).

The values of the matrix \mathcal{B} in (*ii*) follow from the direct calculations with the help of the expressions of $\boldsymbol{\xi}_i$ in (3.3) and $\mathcal{B}_{i,j}$ in (4.2).

Next, we prove the third statement. A direct calculation shows that

From (1) and (3) in Assumption 3.1, one can conclude the domain D_1 is symmetric with respect to the plane $x_2 = 0$. Thus one has that

Now, we are in a position to derive the resonant frequencies and the corresponding eigenvectors for the system (2.5). To clearly state the results, we first define some functions by

Theorem 4.1. Under Assumption 3.1 for the structure D, consider the system (2.5) with parameters given in (2.1) and (2.2). Then the system has 12 subwavelength resonant frequencies. The first two resonant frequencies are

where $\beta_i^{(1)}$ with i = 1, 2 are given in (4.17) and (4.18), respectively. The next two resonant frequencies are given by

$$\omega_3 = \sqrt{\frac{(\mathcal{E}_{4,4} - \mathcal{E}_{4,10})\eta}{\rho \mathcal{B}_{4,4}}} \left(1 + o(1)\right), \quad \omega_4 = \sqrt{\frac{(\mathcal{E}_{4,4} + \mathcal{E}_{4,10})\eta}{\rho \mathcal{B}_{4,4}}} \left(1 + o(1)\right).$$

The corresponding eigenvectors are

$$\varphi_3 = \left(\beta_1^{(2)}\right)^t \varphi^{(2)} \quad and \quad \varphi_4 = \left(\beta_2^{(2)}\right)^t \varphi^{(2)},$$

$$(4.5)$$

where $\beta_i^{(2)}$ with i = 1, 2 are given in (4.19) and (4.20), respectively. The next four resonant frequencies are given by

$$\omega_{5} = \sqrt{\frac{(\mathcal{E}_{5,5} + \mathcal{E}_{5,11})\eta}{\rho \mathcal{B}_{5,5}}} \left(1 + o(1)\right), \quad \omega_{6} = \sqrt{\frac{2\mu\pi}{\kappa\rho}} \sqrt{\frac{\mathcal{B}_{5,5}}{\mathcal{B}_{1,1}\mathcal{B}_{5,5} - \mathcal{B}_{1,5}^{2}}} \sqrt{|\log\varepsilon|\eta} \left(1 + o(1)\right),$$

where d_1 and d_2 are of order $\mathcal{O}(1)$, and defined in (4.25) and (4.29), respectively. The corresponding eigenvectors are

$$\varphi_{5} = \left(\beta_{1}^{(3)}\right)^{t} \varphi^{(3)}, \quad \varphi_{6} = \left(\beta_{2}^{(3)}\right)^{t} \varphi^{(3)}, \quad \varphi_{7} = \left(\beta_{3}^{(3)}\right)^{t} \varphi^{(3)}, \quad \varphi_{8} = \left(\beta_{4}^{(3)}\right)^{t} \varphi^{(3)}, \quad (4.6)$$

where $\beta_i^{(3)}$ with i = 1, 2, 3, 4 are given in (4.21), (4.23), (4.27) and (4.30), respectively. The last four resonant frequencies are given by

$$\omega_{11} = \sqrt{\frac{\eta}{\rho} d_{3}} (1 + o(1)), \qquad \omega_{12} = \sqrt{\frac{\eta}{\rho} d_{4}} (1 + o(1)),$$

where d_3 and d_4 are of order $\mathcal{O}(1)$, and defined in (4.36) and (4.40), respectively. The corresponding eigenvectors are

$$\varphi_{9} = \left(\beta_{1}^{(4)}\right)^{t} \varphi^{(4)}, \quad \varphi_{10} = \left(\beta_{2}^{(4)}\right)^{t} \varphi^{(4)}, \quad \varphi_{11} = \left(\beta_{3}^{(4)}\right)^{t} \varphi^{(4)}, \quad \varphi_{12} = \left(\beta_{4}^{(4)}\right)^{t} \varphi^{(4)}, \quad (4.7)$$

where $\beta_i^{(4)}$ with i = 1, 2, 3, 4 are given in (4.32), (4.34), (4.38) and (4.41), respectively.

Here, the functions $\varphi^{(i)}$ with $1 \leq i \leq 4$ are defined in (4.3). With the index $1 \leq i, j \leq 12$, the parameters $\mathcal{B}_{i,j}$ are given in (4.1), and the parameters $\mathcal{E}_{i,j}$ and $\mathcal{C}_{i,j}$ are given in Proposition 3.1. The eigenvectors are normalized of the order $\mathcal{O}(1)$ on the boundary ∂D , i.e. $\|\varphi_i\|_{L^2(\partial D)} = \mathcal{O}(1)$ with $1 \leq i \leq 12$.

Proof. Consider the system (2.13), i.e.

Comparing the order on both sides of the equation (4.9), one has that the leading order of the density function φ belongs to the kernel of the operator $-\mathbf{I}/2 + \mathbf{K}_D^*$, i.e.

With the help of the equation (4.8) and Lemma 3.2, the following holds

Then multiplying $\boldsymbol{\xi}_i$ on both sides of the equation (4.12) and integrating on the boundary ∂D give that

Thus, to study the resonant frequencies and the corresponding eigenvectors, we just need to solve the equation (4.13). From the expressions of the equation (4.13), we should first study the properties of the terms $\int_{\partial D} \psi \boldsymbol{\xi}_j$ and $\int_D \mathbf{S}_D[\psi] \boldsymbol{\xi}_j$. From Lemma 3.6 and the relationships (4.10) as well as (4.11), the density function $\boldsymbol{\psi}$ can be written as

$$\boldsymbol{\psi} = \sum_{i=1}^{12} a_i \boldsymbol{\zeta}_i + \mathcal{O}(\omega), \qquad (4.14)$$

where the coefficients a_i need be determined. To that end, we next study the quantitative behavior of the matrices composed of entries $\int_D \mathbf{S}_D[\boldsymbol{\zeta}_i]\boldsymbol{\xi}_j$ and $\int_{\partial D} \boldsymbol{\zeta}_i \boldsymbol{\xi}_j$. Indeed, the terms $\int_D \mathbf{S}_D[\boldsymbol{\zeta}_i]\boldsymbol{\xi}_j$ are the elements of the matrix \mathcal{B} defined in (4.1). Their corresponding expressions are given in Proposition 4.1. It follows from (3.6) and (3.7) that the corresponding properties of $\int_{\partial D} \boldsymbol{\zeta}_i \boldsymbol{\xi}_j$ are given in Proposition 3.1.

Now we are in a position to analyze the resonant frequencies of the system (2.13). From the equation (4.13), the resonant frequency ω satisfies the following equation up to an error of the order $\mathcal{O}((\tau \omega)^2 \omega + \delta \omega^2)$:

In (4.41), the parameters enjoy the expressions

with d_4 defined in (4.40). Finally, we complete the proof.

Remark 4.1. According to Theorem 4.1, the resonant frequencies ω_i for i = 2, 3, 4, 5, 7, 8, 9, 11, 12 are of the order $\mathcal{O}(\eta)$. For the remaining resonant frequencies ω_i with i = 1, 6, 10, if the parameter ε is selected as $\varepsilon \sim e^{-1/\eta^{1-\gamma}}$ with $\gamma \in (0, 1)$, then it follows that $\omega_i = \mathcal{O}(\eta^{\gamma/2})$.

Remark 4.2. From Theorem 4.1, the eigenvector φ_1 has the expression $\varphi_1 = -\zeta_3 + \zeta_9$. Therefore, the leading order of the corresponding resonant mode is $\mathbf{S}_D[\boldsymbol{\varphi}_1] = -\boldsymbol{\xi}_3 + \boldsymbol{\xi}_9$ from Lemma 3.6. From the expressions of ξ_3 and ξ_9 defined in (3.3), we have that the two resonators oscillate in antiphase with one another. Moreover, it is noted that the fields \varkappa_i for $1 \leq i \leq 6$ in (3.4) are classified as dipolar resonant fields (see [48]). Therefore, we can conclude that the resonant mode $\mathbf{S}_D^{\tau\omega}[\boldsymbol{\varphi}_1]$ belongs to the quadrupolar resonance. Similarly, the leading order of the resonant mode induced by φ_2 is $\mathbf{S}_D[\varphi_2] = \boldsymbol{\xi}_3 + \boldsymbol{\xi}_9$. Thus the two resonators oscillate in phase with one another. Hence, the resonant mode $\mathbf{S}_D^{\tau\omega}[\varphi_2]$ belongs to the dipolar resonance. Following the same reasoning, the eigenvector $arphi_3$ is associated with the quadrupolar resonance, while $arphi_4$ is associated with dipolar resonance. Furthermore, the resonant modes linked to eigenvectors φ_i for $5 \le i \le 12$ are hybrid modes that encompass both dipolar and quadrupolar resonances. Therefore, the resonant modes associated with φ_2 and φ_4 could be used to achieve the negative mass density. The resonant modes associated with φ_1 and φ_3 could be used to achieve the negative shear modulus. The resonant modes associated with φ_i for $5 \le i \le 12$ could be used to achieve both the negative mass density and the negative shear modulus [34].

5 Gradient estimates of eigenmodes

In this section, we quantitatively study the blow-up behaviors of the eigenmodes gradient in the region between the two adjacent resonators D_1 and D_2 . By adopting the same notation as that in Section 4, the eigenmodes can be written as

where φ_i is given in Theorem 4.1. By using (4.4), (4.5) and the definition of ζ_i in Lemma 3.6, we obtain

$$\mathbf{u}_{1}(\mathbf{x}) = \begin{cases} -\varkappa_{3} + \mathcal{O}(\omega_{1}), & \mathbf{x} \in \partial D_{1}, \\ \varkappa_{3} + \mathcal{O}(\omega_{1}), & \mathbf{x} \in \partial D_{2}, \end{cases} \quad \mathbf{u}_{2}(\mathbf{x}) = \begin{cases} \varkappa_{3} + \mathcal{O}(\omega_{2}), & \mathbf{x} \in \partial D_{1}, \\ \varkappa_{3} + \mathcal{O}(\omega_{2}), & \mathbf{x} \in \partial D_{2}, \end{cases}$$
(5.2)

$$\mathbf{u}_{3}(\mathbf{x}) = \begin{cases} -\varkappa_{4} + \mathcal{O}(\omega_{3}), & \mathbf{x} \in \partial D_{1}, \\ \varkappa_{4} + \mathcal{O}(\omega_{3}), & \mathbf{x} \in \partial D_{2}, \end{cases} \quad \mathbf{u}_{4}(\mathbf{x}) = \begin{cases} \varkappa_{4} + \mathcal{O}(\omega_{4}), & \mathbf{x} \in \partial D_{1}, \\ \varkappa_{4} + \mathcal{O}(\omega_{4}), & \mathbf{x} \in \partial D_{2}. \end{cases}$$

It is noted that the eigenmodes \mathbf{u}_1 and \mathbf{u}_3 exhibit opposite directions on the two resonators D_1 and D_2 . Hence, the gradients $\nabla \mathbf{u}_1$ and $\nabla \mathbf{u}_3$ experience blow-up phenomena as D_1 and D_2 approach each other closely. In contrast, the eigenmodes \mathbf{u}_2 and \mathbf{u}_4 possess the same phase on the two resonators, respectively, resulting in the absence of the blow-up for the gradients $\nabla \mathbf{u}_2$ and $\nabla \mathbf{u}_4$.

Next, by making use of (4.6), we have for i = 1, 2,

where $\beta_{i,1}^{(3)}$, i = 1, 2, 3, 4, are defined in (4.22), (4.24), (4.28), and (4.31), respectively. By (4.7), we derive for i = 1, 2,

$$\mathbf{u}_{i+8}(\mathbf{x}) = \begin{cases} \boldsymbol{\beta}_{i,1}^{(4)} \varkappa_2 + \varkappa_6 + \mathcal{O}(\omega_{i+8}), & \mathbf{x} \in \partial D_1, \\ -\boldsymbol{\beta}_{i,1}^{(4)} \varkappa_2 + \varkappa_6 + \mathcal{O}(\omega_{i+8}), & \mathbf{x} \in \partial D_2, \end{cases}$$

and for i = 3, 4,

$$\mathbf{u}_{i+8}(\mathbf{x}) = \begin{cases} \boldsymbol{\beta}_{i,1}^{(4)} \varkappa_2 + \varkappa_6 + \mathcal{O}(\omega_{i+8}), & \mathbf{x} \in \partial D_1, \\ \boldsymbol{\beta}_{i,1}^{(4)} \varkappa_2 - \varkappa_6 + \mathcal{O}(\omega_{i+8}), & \mathbf{x} \in \partial D_2, \end{cases}$$

where $\beta_{i,1}^{(4)}$, i = 1, 2, 3, 4, are defined in (4.33), (4.35), (4.39), and (4.42), respectively. From the above expressions, it is observed that some components of the resonant modes \mathbf{u}_i with $5 \leq i \leq 12$ oscillate in antiphase for the two resonators. Therefore, the blow-up phenomenon may occur for the gradient of the eigenmodes as the two resonators are brought closer. In the sequel, we shall quantitatively analyze the blow-up rates for the gradient of the eigenmodes as the contrast parameter $\eta > 0$ is small enough. **Theorem 5.1.** Consider the system (2.5) with parameters given in (2.1) and (2.2), and let the parameter ε and the eigenmodes \mathbf{u}_i be defined in (3.8) and (5.1), respectively. Then the following holds true:

if we choose $\varepsilon \sim e^{-1/\eta^{1-\gamma}}$ for some $\gamma \in (0,1)$, then as $\eta \to 0$, the gradients of the eigenmodes \mathbf{u}_i have the following behaviors,

(5.4)

where $\delta(\mathbf{x}')$ is defined in (3.12).

Proof. From the expressions of \mathbf{u}_1 and \mathbf{u}_2 in (5.2) and the definitions of \mathbf{w}_i in (3.5), we have that

As $\eta \to 0$, $|\nabla(\mathbf{w}_3 + \mathbf{w}_9)|$ is bounded since $\mathbf{w}_3 + \mathbf{w}_9$ takes the same value on ∂D_1 and ∂D_2 ; see, for instance, [27, Theorem 1.1]. In contrast, the following holds due to Lemma A.1 and classical elliptic estimates,

$$|\nabla(\mathbf{w}_3 - \mathbf{w}_9)(\mathbf{x})| \sim \frac{1}{\delta(\mathbf{x}')}, \quad \mathbf{x} \in D^e,$$

where $\delta(\mathbf{x}')$ is defined in (3.12). Thus, we can conclude that

$$|\nabla \mathbf{u}_1(\mathbf{x})| \sim \frac{1}{\delta(\mathbf{x}')}, \quad \mathbf{x} \in D^e, \quad \max_{\mathbf{x} \in D^e} |\nabla \mathbf{u}_2(\mathbf{x})| \sim 1.$$

Following the same discussion, we have

From the expressions of \mathbf{u}_5 in (5.3) and \mathbf{w}_i in (3.5), the resonant mode \mathbf{u}_5 can be written as

Since $|\nabla(\mathbf{w}_5 + \mathbf{w}_{11})|$ is bounded, and from Lemma A.1, we have that

The last two formulas together with (4.22) imply that

The others can be proved in the same way and thus we omit the details here. This completes the proof. $\hfill \Box$




Figure 1: Blow-up analysis

Remark 5.1. It follows from (5.4) that $|\nabla \mathbf{u}_i(\mathbf{x})|$ with i = 1, 6, 10 blow up at the rate of $\frac{1}{\varepsilon}$ in the narrow region Ω_{R_0} defined in (3.11). Moreover, they take the maximum at $|\mathbf{x}'| = 0$. In Figure 1 (a), the values of $|\nabla \mathbf{u}_i(\mathbf{x})|$ in the red part $\{|\mathbf{x}'| \leq \sqrt{\kappa^{-1}\varepsilon}\}$ are larger than those in the orange part. For i = 3, 7, 8, 11, 12, we find that, if $\mathbf{x} \in \Omega_{R_0}$ and $|\mathbf{x}'| \leq \varepsilon$, then $|\nabla \mathbf{u}_i(\mathbf{x})|$ are bounded, see the blank area in Figure 1 (b); if $\mathbf{x} \in \Omega_{R_0}$ and $|\mathbf{x}'| > \varepsilon$, then they blow up at the rate of $\frac{1}{\sqrt{\varepsilon}}$ and attain the maximum at $|\mathbf{x}'| = \sqrt{\kappa^{-1}\varepsilon}$, see Figure 1 (b).

Remark 5.2. As aforementioned in Remark 4.2, the resonant modes \mathbf{u}_i with i = 1, 3 and $5 \leq i \leq 12$ contain the quadrupolar resonances and can be utilized to realize the negative shear modulus of the metamaterials in elasticity. From gradient estimates of the resonant modes in (5.4), $|\nabla \mathbf{u}_i(\mathbf{x})|$ with i = 1, 6, 10 blow up at the rates of $\frac{1}{\varepsilon}$ and $|\nabla \mathbf{u}_i(\mathbf{x})|$ with i = 5, 9 blow up at the rate of $\frac{1}{\varepsilon \log \varepsilon}$. Thus, when these modes are used to realize the negative shear modulus, the corresponding metamaterials shall be unstable and can be easily broken when the distance ε between two hard inclusions is small. In contrast, the gradient estimates $|\nabla \mathbf{u}_i(\mathbf{x})|$ with i = 3, 7, 8, 11, 12 blow up at the rate of $\frac{1}{\sqrt{\varepsilon\kappa}}$. Thus, if the curvature κ of the hard inclusion is chosen at the order of $\mathcal{O}(\frac{1}{\varepsilon})$, the gradient estimates of the resonant modes are bounded and at the order of $\mathcal{O}(1)$. Therefore, applying the resonant modes \mathbf{u}_i with i = 3, 7, 8, 11, 12 to realize the negative shear modulus results in stable metamaterials, if the curvature of the hard inclusions is properly chosen.

6 Scattering wave fields

In this section, we study the scattering wave field corresponding to the incident wave field \mathbf{u}^{i} , and then represent the solution in terms of the subwavelength eigenmodes analyzed in Section 5.

Theorem 6.1. Consider the system (2.5) with parameters given in (2.1) and (2.2). Let φ_i with $1 \leq i \leq 12$ be the resonant eigenvectors given in Theorem 4.1. Then under Assumption 3.1, the total wave field has the expression for $\mathbf{x} \in \mathbb{R}^3 \setminus \overline{D}$,

where the coefficients b_i with $1 \le i \le 12$ are given in (6.10), (6.11), (6.13), and (6.15), respectively.

Proof. Consider the system (2.12) and assume the pair (φ, ψ) solve the equation. From asymptotic expansions of operators \mathbf{S}_{D}^{ω} in (3.1) and $\mathbf{K}_{D}^{\omega*}$ in (3.2), there holds that

$$\left(-\frac{\mathbf{I}}{2} + \mathbf{K}_{D}^{*} + (\tau\omega)^{2}\mathbf{K}_{D,2}^{*}\right)[\boldsymbol{\varphi}] - \delta\left(\frac{\mathbf{I}}{2} + \mathbf{K}_{D}^{*}\right)[\boldsymbol{\varphi}]$$

= $-\delta\left(\frac{\mathbf{I}}{2} + \mathbf{K}_{D}^{*}\right)\mathbf{S}_{D}^{-1}[\mathbf{u}^{i}] + \mathcal{O}\left((\tau\omega)^{3} + \delta\omega\right).$ (6.4)

Next, we decompose the density function $\boldsymbol{\varphi}$ into

$$\boldsymbol{\varphi} = \tilde{\boldsymbol{\varphi}} + \tilde{\tilde{\boldsymbol{\varphi}}} := \sum_{i=1}^{12} b_i \boldsymbol{\varphi}_i + \tilde{\tilde{\boldsymbol{\varphi}}}, \tag{6.5}$$

Next, we analyze the coefficients $\mathbf{b}^{(3)} = (b_5, b_6, b_7, b_8)^t$. Substituting the expressions of φ_i with $5 \leq i \leq 8$ into (6.9), we have that the parameters $\mathbf{b}^{(3)}$ satisfy the following system

$$\mathbf{v}_{i}(\mathbf{x}) := \bar{v}(\mathbf{x})\varkappa_{i} + \frac{\lambda + \mu}{\lambda + 2\mu} f(\bar{v}(\mathbf{x})) \,\partial_{x_{i}}\delta(\mathbf{x}')\varkappa_{3}, \qquad i = 1, 2,$$

$$\mathbf{v}_{3}(\mathbf{x}) := \bar{v}(\mathbf{x})\varkappa_{3} + \frac{\lambda + \mu}{\mu} f(\bar{v}(\mathbf{x})) \left(\partial_{x_{1}}\delta(\mathbf{x}')\varkappa_{1} + \partial_{x_{2}}\delta(\mathbf{x}')\varkappa_{2}\right), \qquad (A.4)$$

$$\mathbf{v}_{i}(\mathbf{x}) := \bar{v}(\mathbf{x})\varkappa_{i}, \quad i = 4, 5, 6,$$

where \varkappa_i are defined in (3.4), and

$$f(\bar{v}) := \frac{1}{2} \left(\bar{v} - \frac{1}{2} \right)^2 - \frac{1}{8}, \ f(\bar{v}) = 0 \text{ on } \{ |\mathbf{x}'| < R_0 \}.$$

Similarly, we choose $\underline{v} \in C^{2,\alpha}(\mathbb{R}^3)$ such that $\underline{v} = 1$ on ∂D_2 , $\underline{v} = 0$ on ∂D_1 , $\underline{v} = \mathcal{O}\left(|\mathbf{x}|^{-1}\right)$ as $|\mathbf{x}| \to \infty$, $\underline{v} = 1 - \overline{v}$ in Ω_{2R_0} , and $\|\underline{v}\|_{C^{2,\alpha}(D^e \setminus \Omega_{R_0})} \leq C$. Then we take the auxiliary functions $\mathbf{v}_i(\mathbf{x})$ by replacing \overline{v} with \underline{v} in (A.4), $i = 7, \ldots, 12$.

When $\varepsilon = 0$, denote by D_1^0 and D_2^0 the two hard inclusions, and set $D^{e,0} := \mathbb{R}^3 \setminus \overline{D_1^0 \cup D_2^0}$. Suppose \mathbf{w}_i^0 satisfies

$$\begin{cases} \mathcal{L}_{\lambda,\mu} \mathbf{w}_{i}^{0} = 0, & \text{in } D^{e,0}, \\ \mathbf{w}_{i}^{0} = \varkappa_{i}, & \text{on } \partial D_{1}^{0} \setminus \{0\}, \\ \mathbf{w}_{i}^{0} = 0, & \text{on } \partial D_{2}^{0}, \\ \mathbf{w}_{i}^{0} = \mathcal{O}\left(|\mathbf{x}|^{-1}\right), & \text{as } |\mathbf{x}| \to \infty, \end{cases} \begin{cases} \mathcal{L}_{\lambda,\mu} \mathbf{w}_{i+6}^{0} = 0, & \text{in } D^{e,0}, \\ \mathbf{w}_{i+6}^{0} = \infty, & \text{on } \partial D_{2}^{0} \setminus \{0\}, \\ \mathbf{w}_{i+6}^{0} = 0, & \text{on } \partial D_{1}^{0}, \\ \mathbf{w}_{i+6}^{0} = \mathcal{O}\left(|\mathbf{x}|^{-1}\right), & \text{as } |\mathbf{x}| \to \infty, \end{cases} \quad i = 1, \dots, 6.$$
(A.5)

The auxiliary functions \mathbf{v}_i^0 associated with \mathbf{w}_i^0 are constructed using the same way as described in (A.4) with $\varepsilon = 0$.

We have the following gradient estimates (c.f. [45, Theorems 3.2 and 3.3]).

Lemma A.1. Let $\mathbf{w}_i \in H^1(D^e; \mathbb{R}^3)$ be the weak solutions of (3.5), i = 1, ..., 12. Then for sufficiently small $\varepsilon > 0$, i = 1, ..., 12, and $\mathbf{x} \in \Omega_{R_0}$, we have

Denote

Then by employing the mean value theorem and Lemma A.1, we are able to obtain the convergence result for $\mathbf{w}_i - \mathbf{w}_i^0$. The specific details of the proof for this convergence result can be found in [45, Lemma 5.1].

Lemma A.3. Let \mathbf{w}_i and \mathbf{w}_i^0 satisfy (3.5) and (A.5), respectively. Then we have

Indeed, making use of $|(D_1^0 \cup D_2^0) \setminus (D_1 \cup D_2 \cup \Omega_{R_0})|, |(D_1 \cup D_2) \setminus (D_1^0 \cup D_2^0)| \leq C\varepsilon, |e(\mathbf{w}_1)|$ and $|e(\mathbf{w}_1^0)|$ are bounded in $(D_1^0 \cup D_2^0) \setminus (D_1 \cup D_2 \cup \Omega_{R_0})$ and $(D_1 \cup D_2) \setminus (D_1^0 \cup D_2^0)$, respectively, we have

$$\mathbf{I} = \int_{D^e \setminus (D_1^0 \cup D_2^0 \cup \Omega_{R_0})} \left(\left(\mathbb{C}e(\mathbf{w}_1), e(\mathbf{w}_1) \right) - \left(\mathbb{C}e(\mathbf{w}_1^0), e(\mathbf{w}_1^0) \right) \right) \\ + \int_{(D_1^0 \cup D_2^0) \setminus (D_1 \cup D_2 \cup \Omega_{R_0})} \left(\mathbb{C}e(\mathbf{w}_1), e(\mathbf{w}_1) \right) - \int_{(D_1 \cup D_2) \setminus (D_1^0 \cup D_2^0)} \left(\mathbb{C}e(\mathbf{w}_1^0), e(\mathbf{w}_1^0) \right) \\ = \int_{D^e \setminus (D_1^0 \cup D_2^0 \cup \Omega_{R_0})} \left(\mathbb{C}e(\mathbf{w}_1 - \mathbf{w}_1^0), e(\mathbf{w}_1 + \mathbf{w}_1^0) \right) + \mathcal{O}(\varepsilon).$$
(A.8)

Denote

$$M := 2 \max_{\mathbf{x}, \mathbf{y} \in \overline{D_1^0 \cup D_2^0}} |\mathbf{x} - \mathbf{y}|.$$

Then we have $D_1 \cup D_2 \subset B_M$. In view of

$$\frac{\partial \mathbf{w}_1}{\partial r} = \mathcal{O}\left(|\mathbf{x}|^{-2}\right), \quad \frac{\partial \mathbf{w}_1^0}{\partial r} = \mathcal{O}\left(|\mathbf{x}|^{-2}\right) \quad \text{as } |\mathbf{x}| \to \infty,$$

using the integration by parts, (A.6), and $|\nabla(\mathbf{w}_1 + \mathbf{w}_1^0)|_{L^{\infty}(\mathcal{V} \setminus \Omega_{R_0})} \leq C$, we have

For any fixed $\mathbf{x}_0 \in D^e \setminus (D_1^0 \cup D_2^0 \cup \Omega_{R_0})$, making use of the condition $\mathbf{w}_1 = \mathcal{O}(|\mathbf{x}|^{-1})$ as $|\mathbf{x}| \to \infty$, we find that for any $\varepsilon_0 \in (0, 1)$, there exists a constant $M_0 := M_0(\varepsilon_0) \ge |\mathbf{x}_0|$ such that

$$\mathcal{C}_{1}^{1} = 2 \int_{\Omega_{R_{0}}^{0}} \left(\mathbb{C}e(\mathbf{v}_{1}^{0}), e(\mathbf{w}_{1}^{0} - \mathbf{v}_{1}^{0}) \right) + \int_{\Omega_{R_{0}}^{0}} \left(\mathbb{C}e(\mathbf{w}_{1}^{0} - \mathbf{v}_{1}^{0}), e(\mathbf{w}_{1}^{0} - \mathbf{v}_{1}^{0}) \right)$$

is a constant independent of ε . Indeed,

$$\begin{split} \mathrm{II} &- \int_{\Omega^{0}_{R_{0}} \setminus \Omega^{0}_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{w}^{0}_{1}), e(\mathbf{w}^{0}_{1}) \right) \\ &= \int_{(\Omega_{R_{0}} \setminus \Omega^{0}_{\varepsilon^{1/8}}) \setminus (\Omega^{0}_{R_{0}} \setminus \Omega^{0}_{\varepsilon^{1/8}})} \left(\mathbb{C}e(\mathbf{w}_{1}), e(\mathbf{w}_{1}) \right) \\ &+ 2 \int_{\Omega^{0}_{R_{0}} \setminus \Omega^{0}_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{w}^{0}_{1}), e(\mathbf{w}^{0}_{1} - \mathbf{w}^{0}_{1}) \right) + \int_{\Omega^{0}_{R_{0}} \setminus \Omega^{0}_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{w}_{1} - \mathbf{w}^{0}_{1}), e(\mathbf{w}_{1} - \mathbf{w}^{0}_{1}) \right). \end{split}$$

$$\begin{cases} \mathbf{x}' - \mathbf{z}' = |\mathbf{z}'|^2 \mathbf{y}', \\ x_3 = |\mathbf{z}'|^2 y_3. \end{cases}$$

Then we perform a rescaling transformation to map the region $\Omega^0_{|\mathbf{z}'|+|\mathbf{z}'|^2} \setminus \Omega^0_{|\mathbf{z}'|}$ onto $Q_1^0 := \{\mathbf{y} \in \mathbb{R}^3 : \frac{1}{\delta}h_2(\delta \mathbf{y}' + \mathbf{z}') < y_3 < \frac{1}{\delta}h_1(\delta \mathbf{y}' + \mathbf{z}'), |\mathbf{y}'| < 1\}$. Note that Q_1^0 is a nearly unit-size square whose height is uniformly bounded from above and below by a constant independent of ε . Set

 $\mathbb{W}_1 = \mathbf{w}_1(\mathbf{z}' + |\mathbf{z}'|^2 \mathbf{y}', |\mathbf{z}'|^2 y_3)$ in Q_1 , and $\mathbb{W}_1^0 = \mathbf{w}_1^0(\mathbf{z}' + |\mathbf{z}'|^2 \mathbf{y}', |\mathbf{z}'|^2 y_3)$ in Q_1^0 . Then as in (A.12) and using the scaling, we get

$$|\nabla(\mathbf{w}_1 - \mathbf{w}_1^0)| \le C\varepsilon^{1/4} |\mathbf{x}'|^{-2} \quad \text{in } \Omega^0_{R_0} \setminus \Omega^0_{\varepsilon^{1/8}}.$$

where $\bar{v}^0 \in C^{2,\alpha}(\mathbb{R}^3)$ satisfying $\bar{v}^0 = 1$ on $\partial D_1^0 \setminus \{0\}$, $\bar{v}^0 = 0$ on ∂D_2^0 , $\bar{v}^0 = \mathcal{O}(|\mathbf{x}|^{-1})$ as $|\mathbf{x}| \to \infty$,

$$\bar{v}^0(\mathbf{x}) = \frac{x_3 - h_2(\mathbf{x}')}{h_1(\mathbf{x}') - h_2(\mathbf{x}')}, \text{ in } \Omega^0_{2R_0},$$

and $\|\bar{v}^0\|_{C^{2,\alpha}(D^{e,0}\setminus\Omega^0_{R_0})} \leq C$. Then together with Lemma A.2, we obtain

$$\begin{split} \mathrm{III} &= \int_{\Omega_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{v}_{1}), e(\mathbf{v}_{1}) \right) + 2 \int_{\Omega_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{v}_{1}), e(\mathbf{w}_{1} - \mathbf{v}_{1}) \right) \\ &+ \int_{\Omega_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{w}_{1} - \mathbf{v}_{1}), e(\mathbf{w}_{1} - \mathbf{v}_{1}) \right) \\ &= \int_{\Omega_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{v}_{1}), e(\mathbf{v}_{1}) \right) + \mathcal{O}(\varepsilon^{1/4}). \end{split}$$

This in combination with (A.7) and (A.13) yields

$$\mathcal{E}_{1,1} = \int_{\Omega_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{v}_1), e(\mathbf{v}_1) \right) + \int_{\Omega^0_{R_0} \setminus \Omega^0_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{v}_1^0), e(\mathbf{v}_1^0) \right) + \mathcal{C}_1^2 + \mathcal{O}(\varepsilon^{1/4} |\log \varepsilon|),$$
(A.18)

where

$$\mathcal{C}_1^2 = \mathcal{C}_1^1 + \int_{D^{e,0} \setminus \Omega_{R_0}} \left(\mathbb{C}e(\mathbf{w}_1^0), e(\mathbf{w}_1^0) \right).$$

Recalling the definition of \mathbf{v}_1 in (A.4) and using (3.12), we find that the biggest term in $\left(\mathbb{C}e(\mathbf{v}_1), e(\mathbf{v}_1)\right)$ is

$$\mu \left(\partial_{x_3} \mathbf{v}_1^{(1)} \right)^2 = \frac{\mu}{\delta^2(\mathbf{x}')} = \frac{\mu}{\left(\varepsilon + \kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha}) \right)^2}.$$

The remaining terms are bounded by $\frac{C|\mathbf{x}'|}{\delta^2(\mathbf{x}')}$. Similarly, the leading order terms in $\left(\mathbb{C}e(\mathbf{v}_1^0), e(\mathbf{v}_1^0)\right)$ is

$$\mu \left(\partial_{x_3} (\mathbf{v}_1^0)^{(1)} \right)^2 = \frac{\mu}{\left(\kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha}) \right)^2}$$

These imply that

$$\begin{split} \mathcal{E}_{1,1} &= \int_{\Omega_{\varepsilon^{1/8}}} \frac{\mu}{\left(\varepsilon + \kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha})\right)^2} d\mathbf{x} + \int_{\Omega_{R_0}^0 \setminus \Omega_{\varepsilon^{1/8}}^0} \frac{\mu}{\left(\kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha})\right)^2} d\mathbf{x} \\ &+ \mathcal{C}_1^2 + \mathcal{O}(\varepsilon^{1/4} |\log \varepsilon|) \\ &= \int_{|\mathbf{x}'| \le \varepsilon^{1/8}} \frac{\mu}{\varepsilon + \kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha})} d\mathbf{x}' + \int_{\varepsilon^{1/8} < |\mathbf{x}'| \le R_0} \frac{\mu}{\kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha})} d\mathbf{x}' \\ &+ \mathcal{C}_1^2 + \mathcal{O}(\varepsilon^{1/4} |\log \varepsilon|) \\ &= \frac{\mu \pi}{\kappa} |\log \varepsilon| + \mathcal{C}_{1,1} + o(1), \end{split}$$
(A.19)

where $C_{1,1}$ is a constant independent of ε . Therefore, we finish the proof of the estimate of $\mathcal{E}_{1,1}$. The cases of i = 2, 3, 7, 8, 9 follow a similar approach and are omitted.

For (i, j) = (1, 7), replicating the same argument as above up to (A.18), we have

$$\mathcal{E}_{1,7} = \int_{\Omega_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{v}_1), e(\mathbf{v}_7) \right) + \int_{\Omega^0_{R_0} \setminus \Omega^0_{\varepsilon^{1/8}}} \left(\mathbb{C}e(\mathbf{v}_1^0), e(\mathbf{v}_7^0) \right) + \mathcal{C} + \mathcal{O}(\varepsilon^{1/4} |\log \varepsilon|), \quad (A.20)$$

where C is a constant independent of ε , \mathbf{v}_7 and \mathbf{v}_7^0 are defined by

$$\mathbf{v}_7 = (1 - \bar{v}) \varkappa_1 + \frac{\lambda + \mu}{\lambda + 2\mu} f(1 - \bar{v}) \,\partial_{x_1} \delta(\mathbf{x}') \varkappa_3 \quad \text{in } \Omega_{2R_0}$$

and

$$\mathbf{v}_7^0 = (1 - \bar{v}^0) \varkappa_1 + \frac{\lambda + \mu}{\lambda + 2\mu} f(1 - \bar{v}^0) \,\partial_{x_1} \big(h_1(\mathbf{x}') - h_2(\mathbf{x}') \big) \,\varkappa_3 \quad \text{in } \Omega_{2R_0}^0.$$

Together with the definition of \mathbf{v}_1 in (A.4), (A.17), and using (3.12), we get that the dominate terms in $(\mathbb{C}e(\mathbf{v}_1), e(\mathbf{v}_7))$ and $(\mathbb{C}e(\mathbf{v}_1^0), e(\mathbf{v}_1^0))$ are, respectively,

$$\mu \partial_{x_3} \mathbf{v}_1^{(1)} \partial_{x_3} \mathbf{v}_7^{(1)} = -\frac{\mu}{\delta^2(\mathbf{x}')} = -\frac{\mu}{\left(\varepsilon + \kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha})\right)^2}$$

and

$$\mu \partial_{x_3} (\mathbf{v}_1^0)^{(1)} \partial_{x_3} (\mathbf{v}_7^0)^{(1)} = -\frac{\mu}{\left(\kappa |\mathbf{x}'|^2 + O(|\mathbf{x}'|^{2+\alpha})\right)^2}.$$

Then coming back to (A.20) and following the same calculation as in (A.19), we derive the estimate of $\mathcal{E}_{1,7}$. We omit the proof of the remaining cases since the argument is similar. Thus, the estimates in (*i*) are proved.

A.3 Proof of (ii) and (iv) in Proposition 3.1

Proof of (*ii*) in Proposition 3.1. The relations (3.13) and (3.14) directly follow from the definition of $\mathcal{E}_{i,j}$ in (3.7) and $(\mathbb{C}A, B) = (A, \mathbb{C}B)$ for every pair of 3×3 matrices A and B.

It follows from (3.7), Lemma A.1, and (A.4) that

$$\mathcal{E}_{4,4} = \int_{D^e} \left(\mathbb{C}e(\mathbf{w}_4), e(\mathbf{w}_4) \right) \le C \int_{\Omega_{R_0}} |\nabla \mathbf{v}_4|^2 + C \le C \int_{\Omega_{R_0}} \frac{|\mathbf{x}'|^2}{\delta^2(\mathbf{x}')} \, d\mathbf{x} + C \le C.$$

Furthermore, by using [12, (4.18)], we obtain

$$\begin{aligned} \mathcal{E}_{4,4} \geq \frac{1}{C} \int_{\Omega_{R_0} \setminus \Omega_{R_0/2}} |e(\mathbf{w}_4)|^2 \geq \frac{1}{C} \int_{\Omega_{R_0} \setminus \Omega_{R_0/2}} |\nabla \mathbf{w}_4|^2 \\ \geq \frac{1}{C} \int_{\Omega_{R_0} \setminus \Omega_{R_0/2}} |\partial_{x_3} \mathbf{w}_4^{(1)}|^2 \\ \geq \frac{1}{C} \int_{\Omega_{R_0} \setminus \Omega_{R_0/2}} \frac{x_2^2}{\delta^2(\mathbf{x}')} \ d\mathbf{x} \geq \frac{1}{C}. \end{aligned}$$

The proof of the case i = 5, 6, 10, 11, 12 is similar and thus is omitted.

Proof of (*iv*) in Proposition 3.1. Since $\mathcal{E}_{i,i} = \mathcal{E}_{i+6,i+6}$, $i = 1, \ldots, 6$, we have

$$\mathcal{E}_{i,i} + \mathcal{E}_{i,i+6} = \frac{1}{2} \int_{D^e} \left(\mathbb{C}e(\mathbf{w}_i + \mathbf{w}_{i+6}), e(\mathbf{w}_i + \mathbf{w}_{i+6}) \right)$$

On one hand, recalling that \mathbf{v}_{i+6} is defined as in (A.4) by replacing \bar{v} with \underline{v} , then by using Lemma A.1 and the definition of \mathbf{v}_i in (A.4), we obtain

$$\mathcal{E}_{i,i} + \mathcal{E}_{i,i+6} \le C.$$

On the other hand, it follows from [12, (4.18)] that

$$\mathcal{E}_{i,i} + \mathcal{E}_{i,i+6} \ge \frac{1}{C} \int_{D^e} |e(\mathbf{w}_i + \mathbf{w}_{i+6})|^2 \, d\mathbf{x} \ge 0.$$

By (3.13) and $\mathcal{E}_{i,i} = \mathcal{E}_{i+6,i+6}, i = 1, ..., 6$, we obtain

$$\mathcal{E}_{i,i} - \mathcal{E}_{i,i+6} = \frac{1}{2} \int_{D^e} \left(\mathbb{C}e(\mathbf{w}_i - \mathbf{w}_{i+6}), e(\mathbf{w}_i - \mathbf{w}_{i+6}) \right).$$

Then the same argument as above yields

$$0 \le \mathcal{E}_{i,i} - \mathcal{E}_{i,i+6} \le C.$$

Together with $\mathcal{E}_{i,i} = \mathcal{E}_{i+6,i+6}$ and $\mathcal{E}_{i,i+6} = \mathcal{E}_{i+6,i}$, the second inequality in (3.15) is proved. The proof of Proposition 3.1 is finished.
