# <span id="page-0-1"></span>ON SPEH REPRESENTATIONS FOR LEVEL ZERO SUPERCUSPIDAL REPRESENTATIONS AND GINZBURG–KAPLAN GAMMA FACTORS

ABSTRACT. We establish a relation between Speh representations of  $GL_n(\mathbb{F}_q)$  and Speh representations of  $GL_n(F)$ , where F is a non-archimedean local field. We use irreducible level zero supercuspidal representations to show that these two notions of Speh representations associated to cuspidal representations are related via a commutative diagram, and that their corresponding  $(k, c) \psi$ -Whittaker models are also related. We use these results to relate the local Ginzburg–Kaplan integrals [\[12,](#page-40-0) [22\]](#page-40-1), [\[6,](#page-39-0) Appendix A] for level zero supercuspidal representations to their finite field counterparts [\[8\]](#page-39-1).

## 1. Introduction

<span id="page-0-0"></span>In the theory of automorphic representations of general linear groups, Speh representations are important objects. They were introduced by Jacquet in [\[19\]](#page-40-2), where he conjectured that the discrete spectrum of  $L^2(\mathrm{[GL}_n])$  corresponding to the automorphic quotient  $\mathrm{[GL}_n]$ decomposes as the direct sum of Speh representations. This was later proved by Mœglin and Waldspurger in their celebrated work [\[28\]](#page-40-3). This result serves as a base case for Arthur's conjectures regarding the decomposition of the discrete spectrum of  $L^2([G])$ , where G is a reductive group. See [\[1,](#page-39-2) Page 23].

A notion of (generalized) Speh representations also exists in the context of local fields [\[19,](#page-40-2) Section 2.2], [\[4\]](#page-39-3) and, unsurprisingly, the local components of a global Speh representation are local Speh representations.

A fundamental property of Speh representations utilized in these constructions is a local uniqueness property of a generalized Whittaker functional. We move to explain this now.

Let F be a non-archimedean local field with ring of integers  $\mathfrak{o}$ , maximal ideal  $\mathfrak{p}$  and residual field  $\mathbb{F} = \mathfrak{o}/\mathfrak{p}$  of cardinality q, and denote by  $\nu : \mathfrak{o} \to \mathbb{F}$  the quotient map. Choose a uniformizer  $\varpi \in \mathfrak{p}$ . Let  $\psi \colon F \to \mathbb{C}^\times$  be a non-trivial character. Given positive integers k and c, let  $N_{(c^k)}$  be the unipotent radical of the standard parabolic subgroup  $P_{(c^k)}$  of  $GL_{kc}(F)$ corresponding to the composition  $(c^k)$ . We define a character  $\psi_{(c^k)}: N_{(c^k)} \to \mathbb{C}^\times$  by the

$$
\psi_{(c^k)}\begin{pmatrix}I_c & X_1 & * & * & * & * \\ & I_c & X_2 & * & * & * \\ & & \ddots & \ddots & * & * \\ & & & I_c & X_{k-1} & \\ & & & & I_c\end{pmatrix} = \psi\left(\sum_{j=1}^{k-1} \operatorname{tr} X_j\right).
$$

Then a fundamental result of  $[4]$  is that for any Speh representation  $\Delta(\mathcal{T}, c)$  (where  $\mathcal{T}$  is a generic representation of  $GL_k(F)$ ) there exists a unique (up to scalar multiplication)  $(k, c)$  $\psi$ -Whittaker functional, that is, a non-zero element

$$
\ell_{\Delta(\mathcal{T},c)} \in \mathrm{Hom}_{N_{(c^k)}}\left(\Delta(\mathcal{T},c),\psi_{(c^k)}\right).
$$

Recently, in his master's thesis [\[7\]](#page-39-6), Carmon defined the notion of (generalized) Speh representations of finite general linear groups, and showed that a similar uniqueness property holds.

It is very natural to ask what the relation between Speh representations over local fields and over finite fields is. In this paper, we establish a relation between these two representations using level zero representations.

Given any irreducible cuspidal representation  $\tau$  of  $GL_k(\mathbb{F})$ , we may construct an irreducible level zero supercuspidal representation  $\mathcal T$  of  $GL_k(F)$ . This construction is not unique and depends on a choice of a central character  $\omega_{\tau}$  for T. The Speh representation  $\Delta(\tau, c)$ of  $GL_{kc}(\mathbb{F})$  is the irreducible subrepresentation of minimal dimension of the parabolically induced representation  $\tau^{\circ c} = \tau \circ \cdots \circ \tau$ . It occurs with multiplicity one in  $\tau^{\circ c}$ . On the hand, the Speh representation  $\Delta(\mathcal{T}, c)$  of  $GL_{kc}(F)$  is defined as the image of the standard intertwining operator  $M_{w_{(1c)}}^{(z_1,...,z_c)}$ :  $\mathcal{T}^{(z_1,...,z_c)} \to \mathcal{T}^{(z_c,...,z_1)}$  at the point  $(z_1,...,z_c) = \left(\frac{c-1}{2}\right)$  $\frac{-1}{2}$ ,  $\frac{c-3}{2}$  $\frac{-3}{2}, \ldots, -\frac{c-1}{2}$  $\frac{-1}{2}$ , where for a choice of complex numbers  $(z_1, \ldots, z_c) \in \mathbb{C}^c$ , the representation  $\mathcal{T}^{(z_1,\ldots,z_c)}$  is the (normalized) parabolically induced representation

$$
\mathcal{T}^{(z_1,\ldots,z_c)}=|\mathrm{det}|^{z_1}\,\mathcal{T}\times\cdots\times|\mathrm{det}|^{z_c}\,\mathcal{T}=\mathrm{Ind}_{P_{(k^c)}}^{\mathrm{GL}_{kc}(F)}\left(|\mathrm{det}|^{z_1}\,\mathcal{T}\otimes\cdots\otimes|\mathrm{det}|^{z_c}\,\mathcal{T}\right).
$$

For any element  $v_\tau \in \tau$ , we define a natural lift  $\mathcal{L}v_\tau \in \mathcal{T}$  corresponding to  $v_\tau$ . We then extend this notion to define for an element  $v_{\tau^{\otimes c}} \in \tau^{\otimes c}$  a lift  $\mathcal{L}v_{\tau^{\otimes c}} \in \mathcal{T}^{\otimes c}$ , and then using the Iwasawa decomposition, we define for an element  $f_{\tau^{\circ c}} \in \tau^{\circ c}$  a lift  $\mathcal{L}^{(z_1,\ldots,z_c)} f_{\tau^{\circ c}} \in \mathcal{T}^{(z_1,\ldots,z_c)}$ . Our first result establishes a relation between  $\Delta(\tau, c)$  and  $\Delta(\mathcal{T}, c)$  by showing that a certain diagram is commutative (Corollary [2.8\)](#page-14-0).

Theorem 1.1. *The following diagram commutes:*

$$
\begin{array}{ccc}\n\tau^{oc} & \xrightarrow{\mathrm{pr}_{\Delta(\tau,c)}} & \Delta(\tau,c) \\
\downarrow^{c_{\frac{-1}{2},\ldots,-\frac{c-1}{2}}}\sqrt{\int_{\tau^{c_{\frac{-1}{2},\ldots,-\frac{c-1}{2}}}}^{\tau^{c_{\frac{c-1}{2},\ldots,c_{\frac{c-1}{2}}}}}\sqrt{\int_{\tau^{c_{\frac{-1}{2},\ldots,-\frac{c-1}{2}}}}^{\tau^{c_{\frac{c-1}{2},\ldots,-\frac{c-1}{2}}}}},\n\end{array}
$$

*Hence, for any*  $f_{\Delta(\tau,c)} \in \Delta(\tau,c)$ *, we have that*  $\mathcal{L}f_{\Delta(\tau,c)} \in \Delta(\mathcal{T},c)$ *. Here,* 

 $\mathrm{pr}_{\Delta(\tau,c)}\colon \tau^{oc}\to \Delta(\tau,c)$ 

*is the projection operator and*  $M_{w_{(1c)}}^*$  *is a certain non-zero scalar multiple of*  $M_{w_{(1c)}}^{\left(\frac{c-1}{2}, \ldots, -\frac{c-1}{2}\right)}$ .

<span id="page-2-0"></span>Our proof involves an explicit computation of simple reflection intertwining operators, which utilizes Cartan decompositions of matrices. As a byproduct, we also obtain a similar relation between the Steinberg representations St  $(\tau, c)$  and St  $(\mathcal{T}, c)$  (Remark [2.9\)](#page-14-1).

Our next results establish a relation between  $(k, c)$   $\psi$ -Whittaker functions of  $\Delta(\tau, c)$  and of  $\Delta(\mathcal{T}, c)$ . Suppose that  $\psi: F^{\times} \to \mathbb{C}^{\times}$  has conductor p, and regard  $\psi$  also as a nontrivial character  $\psi: \mathbb{F} \to \mathbb{C}^{\times}$ . Let  $\ell_{\tau,\psi}$  be a  $(k,1)$   $\psi$ -Whittaker functional of  $\tau$ . We may use  $\ell_{\tau,\psi}$  to construct a  $(k,1)$   $\psi$ -Whittaker functional  $\ell_{\tau,\psi}$  for  $\tau$  as in [\[36,](#page-41-0) Proposition 3.7]. Following the recursive process in [\[4,](#page-39-3) Section 3.2], we use  $\ell_{\tau,\psi}$  and  $\ell_{\tau,\psi}$  to construct  $(k, c)$  $\psi$ -Whittaker functionals  $\ell_{\Delta(\tau,c)}$  and  $\ell_{\Delta(\tau,c)}$  for  $\Delta(\tau,c)$  and  $\Delta(\tau,c)$ , respectively. We show the following relations between these functionals (Proposition [3.4,](#page-18-0) Proposition [3.5](#page-19-0) part [1](#page-19-1) and Theorem [3.7\)](#page-20-0).

**Theorem 1.2.** Let  $f_{\Delta(\tau,c)} \in \Delta(\tau, c)$  and define for  $g \in GL_{kc}(\mathbb{F})$ ,

$$
W(g) = \langle \Delta(\tau, c) (g) f_{\Delta(\tau, c)}, \ell_{\Delta(\tau, c)} \rangle
$$

*and for*  $q \in GL_{kc}(F)$ .

$$
\mathcal{L}W(g) = \langle \Delta(\mathcal{T}, c)(g) \mathcal{L}f_{\Delta(\tau, c)}, \ell_{\Delta(\mathcal{T}, c)} \rangle
$$

.

*(1) For any*  $k_0 \in GL_{kc}(\mathfrak{o})$ *, we have the relation* 

$$
\mathcal{L}W(k_0)=W(\nu(k_0)).
$$

- (2) Suppose that  $g = \text{diag}(t, I_{(k-1)c})$  where  $t = \text{diag}(\varpi^{i_1}, \ldots, \varpi^{i_c})$ , and  $i_1, \ldots, i_c \in \mathbb{Z}$ . *Then we have*  $\mathcal{L}W(g) = 0$  *if* min $(i_1, \ldots, i_c) < 0$ *. If*  $c < k$ *, we have that*  $\mathcal{L}W(g) = 0$ *unless*  $i_1 = i_2 = \cdots = i_c = 0$ .
- (3) Suppose that  $k = c$  and that  $g = diag(t, I_{(c-1)c})$  where t *is as above and*  $\min(i_1, \ldots, i_c) > 0$ *. Then*  $\mathcal{L}W(g) = 0$  *unless*  $i_1 = i_2 = \cdots = i_c = m > 0$ *, in which case*

$$
\mathcal{L}W(g) = \omega_{\mathcal{T}}(\varpi)^m q^{-(m+1)(c-1)\binom{c}{2}} \left\langle f_{\Delta(\tau,c)} \upharpoonright_{\text{diag}\left(I_c, \text{GL}_{(k-1)c}(\mathbb{F})\right)}, S_0 \right\rangle,
$$

*where*  $S_0$ :  $\tau \otimes \Delta(\tau, c - 1) \rightarrow \mathbb{C}$  *is a certain functional given in Theorem [3.6.](#page-20-1)* 

We also have similar results for elements of the form diag  $(I_{(k-1)c}, t)$ , where t is as in the theorem, see Proposition [3.5](#page-19-0) part [2](#page-19-2) and Theorem [3.7.](#page-20-0) It is an interesting problem to find an explicit formula for the values of  $\mathcal{L}W(q)$  as in the theorem for general g, but at this moment this seems too ambitious. Let us mention that Luo [\[27\]](#page-40-6) has recently given an asymptotic expansion for  $(k, c)$   $\psi$ -Whittaker functions of Speh representations at elements of the form diag  $(t, I_{(k-1)c})$ , but for our purposes we need more explicit formulas.

We use our results to link the finite field Ginzburg–Kaplan gamma factor defined by Carmon and the author  $[8]$  to its local field counterpart defined by Kaplan  $[6,$  Appendix A $], [22]$  $], [22]$ . This gamma factor arises from an integral representation that uses a Speh representation as an ingredient. This integral represents the L-function associated to the tensor product representation of a pair of representations  $\Pi$  and  $\mathcal T$  of  $GL_c$  and  $GL_k$ , respectively, where  $\mathcal T$  is assumed to be generic, but nothing is assumed on Π. We show that in the non-exceptional case, the local Ginzburg–Kaplan gamma factor associated with a pair of irreducible level zero supercuspidal representations agrees with the finite field Ginzburg–Kaplan gamma factor as-sociated with the corresponding pair of irreducible cuspidal representations (Corollary [4.7\)](#page-33-0). In the exceptional case, we use the equality of the local Ginzburg–Kaplan gamma factor <span id="page-3-1"></span>and of the local Jacquet–Piatetski-Shapiro–Shalika gamma factor [\[20\]](#page-40-7) to compute the finite field Ginzburg–Kaplan gamma factor (Theorem [4.8\)](#page-33-1). We also obtain an identity that shows that for any pair of irreducible cuspidal representations of finite general linear groups, the Ginzburg–Kaplan gamma factor agrees with the tensor product  $\varepsilon_0$ -factor [\[37\]](#page-41-1) (Theo-rem [4.10\)](#page-35-0). This identity is  $[8,$  Theorem 4.24, and it is crucial for proving the results of  $[8,$ Section 5], which link special values of Bessel–Speh functions to exotic matrix Kloosterman sums.

**Theorem 1.3.** Let  $\pi$  and  $\tau$  be irreducible cuspidal representations of  $GL_c(\mathbb{F})$  and  $GL_k(\mathbb{F})$ *respectively, and let*  $\Pi$  *and*  $\mathcal T$  *be irreducible level zero supercuspidal representations of*  $GL_c(F)$ *and*  $GL_k(F)$  *constructed from*  $\pi$  *and*  $\tau$ *, respectively. Then* 

*(1) If*  $π$   $≥$   $τ<sup>∨</sup>$  *then*  $\gamma^{\rm GK}\left(s,\Pi\times\mathcal{T},\psi\right)=\gamma^{\rm GK}\left(\pi\times\tau,\psi\right).$ *(2)* If  $π ≅ τ<sup>∨</sup> then$  $\gamma^{\rm GK} \, (\pi \times \tau, \psi) = -\omega_{\tau} \, (-1)^{c-1} \, q^{-\frac{c}{2}}.$ *(3) In all cases we have*

 $\gamma^{\rm GK}\left(\pi\times\tau,\psi\right)=\varepsilon_{0}\left(\pi\times\tau,\psi\right).$ 

Let us mention that such relation between a finite field gamma factor and its local field counterpart for level zero representation has been established many times before for various other integrals [\[35,](#page-40-8) [30,](#page-40-9) [36,](#page-41-0) [21,](#page-40-10) [9\]](#page-39-7). However, the case in this article is considerably more involved, since the Ginzburg–Kaplan zeta integrals do not use the representation  $\mathcal{T}$  directly, but instead use the  $(k, c)$   $\psi$ -Whittaker model of the Speh representation  $\Delta(\mathcal{T}, c)$  associated to it. Hence it is crucial to first establish a relation between the representations  $\Delta(\tau, c)$  and  $\Delta(\mathcal{T}, c)$  and between their corresponding  $(k, c)$   $\psi$ -Whittaker models.

We also use our results to give a modified functional equation for the finite field Ginzburg– Kaplan zeta integrals in the exceptional case (Corollary [4.9\)](#page-35-1).

**Theorem 1.4.** Suppose that  $\pi = \tau^{\vee}$ . Then for any  $v \in \tau^{\vee}$ ,  $v^{\vee} \in \tau$  and  $W \in$  $\mathcal{W}\left(\Delta\left(\tau,c\right),\psi_{\left(c^{c}\right)}\right)$  as above, we have

$$
\langle Z^*(W, \pi \times \tau) v, v^{\vee} \rangle = \Gamma^{GK} (\pi \times \tau, \psi) \left( \langle Z(W, \pi \times \tau) v, v^{\vee} \rangle \right) + q^{-\frac{c^2}{2}} \cdot \langle v \otimes v^{\vee} \otimes f_{\Delta(\tau, c)} \upharpoonright_{diag(I_c, GL_{(k-1)c}(\mathbb{F}))}, S \rangle,
$$

where  $S: \tau^{\vee} \otimes \tau \otimes \tau \otimes \Delta(\tau, c-1) \to \mathbb{C}$  *is a certain functional defined in Section [4.2.2.](#page-29-0)* 

We hope to utilize these computations in the future in order to compute the generalized doubling method integrals [\[3,](#page-39-4) [5,](#page-39-5) [15,](#page-40-4) [6\]](#page-39-0) for level zero representations of  $G \times GL_k$ , where G is a classical group. We mention that this was done for several cases of the classical doubling method [\[31,](#page-40-11) [10,](#page-40-12) [25\]](#page-40-13) in [\[23\]](#page-40-14).

<span id="page-4-0"></span>1.1. **Notation.** Suppose that R is a ring. Given a composition  $(n_1, \ldots, n_r)$  of a positive integer n, let

$$
N_{(n_1,...,n_r)}(R) = \left\{ \begin{pmatrix} I_{n_1} & * & * & * \\ & I_{n_2} & * & * \\ & & \ddots & * \\ & & & I_{n_r} \end{pmatrix} \right\}
$$

and let

$$
P_{(n_1,...,n_r)}(R) = \{ \text{diag}(h_1,...,h_r) \mid h_j \in \text{GL}_{n_j}(R) \} \ltimes N_{(n_1,...,n_r)}(R).
$$

The group  $P_{(n_1,...,n_r)}(R)$  is the standard parabolic subgroup of  $GL_n(R)$  corresponding to the *composition*  $(n_1, \ldots, n_r)$ , and  $N_{(n_1, \ldots, n_r)}(R)$  is the *unipotent radical of*  $P_{(n_1, \ldots, n_r)}(R)$ . We will mostly take  $R$  to be a field, and we will often omit this field from the notation when there is no fear of confusion.

If  $R = \mathbb{F}$  is a finite field, given representations  $\tau_1, \ldots, \tau_r$  of  $GL_{n_1}(\mathbb{F}), \ldots, GL_{n_r}(\mathbb{F}),$ respectively, we denote their parabolic induction by  $\tau_1 \circ \cdots \circ \tau_r$ . This is the representation of  $GL_n(\mathbb{F})$  acting by right translations on the space of all functions  $f: GL_n(\mathbb{F}) \to \tau_1 \otimes \cdots \otimes \tau_r$ , satisfying the condition that for any  $g \in GL_n(\mathbb{F})$ , and any  $p \in P_{(n_1,...,n_r)}(\mathbb{F})$  of the form  $p = \text{diag}(h_1, \ldots, h_r) u$ , where  $u \in N_{(n_1, \ldots, n_r)} (\mathbb{F})$  and  $h_1 \in \text{GL}_{n_1} (\mathbb{F}), \ldots, h_r \in \text{GL}_{n_r} (\mathbb{F}),$ 

$$
f (pg) = \tau_1 (h_1) \otimes \cdots \otimes \tau_r (h_r) f (g).
$$

By [\[11,](#page-40-15) Theorem 2.4], for every irreducible representation  $\sigma$  of  $GL_n(\mathbb{F})$ , there exist a composition  $(n_1, \ldots, n_r)$  of n and irreducible cuspidal representations  $\tau_1, \ldots, \tau_r$  of  $GL_{n_1}(\mathbb{F})$ ,  $\ldots$ ,  $GL_{n_r}(\mathbb{F})$ , respectively, such that  $\sigma$  is a subrepresentation of the parabolically induced representation  $\tau_1 \circ \cdots \circ \tau_r$ . The equivalence classes of the representations  $\tau_1, \ldots, \tau_r$  are <span id="page-5-2"></span>uniquely determined, up to permutation. We define the *cuspidal support of*  $\sigma$  to be the multiset consisting of these equivalence classes.

If  $R = F$  is a non-archimedean local field with absolute value  $|\cdot|$ , given smooth representations  $\mathcal{T}_1, \ldots, \mathcal{T}_r$  of  $GL_{n_1}(F), \ldots, GL_{n_r}(F)$ , respectively, we denote their (normalized) parabolic induction by  $\mathcal{T}_1 \times \cdots \times \mathcal{T}_r$ . This is the representation of  $GL_n(F)$  acting by right translations on the space of all right-smooth functions  $\Phi: GL_n(F) \to \mathcal{T}_1 \otimes \cdots \otimes \mathcal{T}_r$ , satisfying the condition that for any  $g \in GL_n(F)$ , and any  $p \in P_{(n_1,...,n_r)}(F)$  of the form  $p = \text{diag}(h_1, ..., h_r) u$ , where  $u \in N_{(n_1, ..., n_r)}(F)$ , and  $h_1 \in \text{GL}_{n_1}(F), ..., h_r \in \text{GL}_{n_r}(F)$ ,

$$
\Phi(pg) = \delta_{P_{(n_1,...,n_r)}}^{\frac{1}{2}} \left( \text{diag} (h_1,...,h_r) \right) \mathcal{T}_1(h_1) \otimes \cdots \otimes \mathcal{T}_r(h_r) \Phi(g),
$$

where  $\delta_{P_{(n_1,...,n_r)}}$  is the modulus character.

For the reader's convenience, we include here the following formula for a modulus character commonly used in the paper. For  $h_1 \in GL_{n_1}(F)$  and  $h_2 \in GL_{n_2}(F)$ ,

$$
\delta_{P_{(n_1,n_2)}} (\text{diag}(h_1,h_2)) = |\text{det} \, h_1|^{n_2} \cdot |\text{det} \, h_2|^{-n_1}.
$$

## 2. Speh representations

<span id="page-5-0"></span>This section is devoted to explaining the notion of Speh representations of general linear groups in the context of finite fields and of non-archimedean local fields, and to establishing a relation between these two notions.

<span id="page-5-1"></span>2.1. Speh representation for cuspidal representations over finite fields. Let  $\mathbb F$  be a field with  $q$  elements. We recall the definition of an important class of irreducible representations of  $GL_{kc}(\mathbb{F})$  called Speh representations. These are also known in the literature as "generalized trivial representations". Our discussion is based on [\[33,](#page-40-16) Section 4].

Let  $\tau$  be an irreducible cuspidal representation of  $GL_k(\mathbb{F})$ . Denote  $\Delta(\tau,1) = \tau$ . When  $c > 1$ , the parabolic induction  $\tau^{oc} = \tau \circ \cdots \circ \tau$ , a representation of  $GL_{kc}(\mathbb{F})$ , is not irreducible. The equivalence classes of irreducible subrepresentations of  $\tau^{cc}$  are in bijection with the (equivalence classes of) irreducible representations of the symmetric group on  $c$  elements  $\mathfrak{S}_c$ , which in turn are in bijection with partitions of c. There are two irreducible subrepresentations of  $\tau^{\circ c}$  that appear with multiplicity one. These are the Steinberg representation St  $(\tau, c)$ , which corresponds to the partition  $(c)$  and the Speh representation  $\Delta(\tau, c)$ , which corresponds to the partition (1<sup>c</sup>). The Steinberg representation St ( $\tau$ , c) is the irreducible subrepresentation of  $\tau^{\circ c}$  with maximal dimension, while the Speh representation  $\Delta(\tau, c)$  is the irreducible subrepresentation of  $\tau^{\circ c}$  with minimal dimension (to show this, use the fact that the dimension of the irreducible subrepresentation of  $\tau^{\circ}$  corresponding to the partition  $\lambda \vdash c$  is a scalar multiple of the unipotent representation of  $GL_c(\mathbb{F}_k)$  corresponding to  $\lambda$  (see [\[18,](#page-40-17) Corollary 5.3 (ii)] or [\[16,](#page-40-18) Lemma 7.4]), and then use Corollary 3.4 or Proposition 3.5 of  $|26|$ ).

It turns out that if  $c = c_1 + c_2$ , then the Speh representation  $\Delta(\tau, c)$  is a subrepresentation of the parabolic induction  $\Delta(\tau, c_1) \circ \Delta(\tau, c_2)$ .

We remark that in [\[7\]](#page-39-6), the Speh representation  $\Delta(\tau, c)$  was defined for any irreducible generic representation  $\tau$ . See also [\[8,](#page-39-1) Section 2.4]. However, for our purposes we only need to consider cuspidal representations.

<span id="page-6-3"></span><span id="page-6-1"></span>2.1.1. *Projection operator.* By [\[33,](#page-40-16) Proposition 4.2], we have the following projection operator  $\mathrm{pr}_{\Delta(\tau,c)}\colon \tau^{oc} \to \Delta(\tau,c)$ :

$$
\mathrm{pr}_{\Delta(\tau,c)} = \frac{1}{P_c(q^k)} \sum_{w \in \mathfrak{S}_c} h_w^0,
$$

where

$$
P_c(X) = (1+X)(1+X+X^2)\dots(1+X+\dots+X^{c-1})
$$

is the Poincare polynomial and  $h_w^0$  is given by the Howe isomorphism. We explain the last point now. For any permutation  $w \in \mathfrak{S}_c$ , we may realize it as a  $kc \times kc$  block matrix, with blocks of size k, in the following way. First represent w as  $c \times c$  matrix, and then replace each zero entry in the matrix with the matrix  $0_k$ , and each 1 entry in the matrix with  $I_k$ . Now let  $h_w: \tau^{\circ c} \to \tau^{\circ c}$  be the operator corresponding to the characteristic function of the double coset  $P_{(k^c)}wP_{(k^c)}$  by Mackey theory, that is, for  $f \in \tau^{oc}$  and  $x \in GL_{kc}(\mathbb{F})$ ,

$$
(h_w f) (x) = \sum_{g \in (P_{(k^c)} w P_{(k^c)})/P_{(k^c)}} f^w (g^{-1} x) = \sum_{u \in N_{(k^c)}/(N_{(k^c)} \cap w N_{(k^c)} w^{-1})} f^w (w^{-1} u^{-1} x) ,
$$

where for  $w \in \mathfrak{S}_c$  and  $g \in GL_{kc}(\mathbb{F})$ , we denote  $f^w(g) = wf(g)$ , where  $\mathfrak{S}_c$  acts on  $\tau^{\otimes c}$  by permuting the components of pure tensors. We then normalize  $h_w$  as Howe [\[18,](#page-40-17) Page 12], by setting

$$
h_w^0 = q^{-\frac{k(k-1)}{2}\ell(w)}\omega_\tau \left(-1\right)^{\ell(w)}h_w,
$$

where  $\omega_{\tau}$  is the central character of  $\tau$  and  $\ell(w)$  is the length of the permutation w.

For every  $1 \leq i \leq c-1$ , let  $s_i = (i, i+1) \in \mathfrak{S}_c$  be a simple transposition. Then we have the following Hecke algebra relations [\[18,](#page-40-17) Theorem 5.1]:

- (1) For every  $1 \le i, j \le c$  with  $|i j| > 1$ , we have  $h_{s_i}^0 \circ h_{s_j}^0 = h_{s_j}^0 \circ h_{s_i}^0$ .
- (2) For every  $0 \le i \le c-2$ , we have  $h_{s_i}^0 \circ h_{s_{i+1}}^0 \circ h_{s_i}^0 = h_{s_{i+1}}^0 \circ h_{s_i}^0 \circ h_{s_{i+1}}^0$ .
- (3)  $h_{s_i}^0 \circ h_{s_i}^0 = q^k \text{id}_{\tau^{\circ c}} + (q^k 1) h_{s_i}^0.$

<span id="page-6-0"></span>By [\[17,](#page-40-20) Lemma 3.1], we may decompose  $\mathrm{pr}_{\Delta(\tau,c)}$  in the following way:

## Proposition 2.1.

$$
\mathrm{pr}_{\Delta(\tau,c)} = \frac{1}{P_c(q^k)} \prod_{\substack{(i,j) \\ 1 \le i < j \le c}} \left( h_{s_{j-i}}^0 + \frac{q^k - 1}{q^{(j-i)k} - 1} \cdot \mathrm{id}_{\tau^{\circ c}} \right),
$$

*where the product is ordered by the lexicographic ordering, taken either right to left or left to right.*

<span id="page-6-2"></span>**Remark 2.2.** By [\[33,](#page-40-16) Proposition 4.2], the projection operator  $pr_{St(\tau,c)}: \tau^{oc} \to St(\tau,c)$  is given by

$$
\mathrm{pr}_{\mathrm{St}(\tau,c)} = \frac{1}{P_c(q^{-k})} \sum_{w \in \mathfrak{S}_c} \left(-q^{-k}\right)^{\ell(w)} h_w^0.
$$

Consider the automorphism of End  $(\tau^{\circ c})$  that sends  $h_w^0$  to  $(-q^k)^{\ell(w)}$   $(h_{w^{-1}}^0)^{-1}$  for every  $w \in$  $\mathfrak{S}_c$ . By [\[29,](#page-40-21) Lemma 2.5], this automorphism sends  $P_c(q^k)$  pr<sub>∆(τ,c)</sub> to  $q^{k{c \choose 2}}P_c(q^{-k})$  pr<sub>St(τ,c)</sub>, and therefore sends  $\mathrm{pr}_{\Delta(\tau,c)}$  to  $\mathrm{pr}_{\text{St}(\tau,c)}$ . Applying this automorphism to both sides of Proposition [2.1](#page-6-0) and using the relation

$$
-q^{k} (h_{s_{i}}^{0})^{-1} = -h_{s_{i}}^{0} + (q^{k} - 1) \cdot id_{\tau^{\circ c}},
$$

<span id="page-7-2"></span>we get

$$
\mathrm{pr}_{\mathrm{St}(\tau,c)} = \frac{(-1)^{\binom{c}{2}}}{P_c(q^k)} \prod_{\substack{(i,j) \\ 1 \le i < j \le c}} \left( h_{s_{j-i}}^0 + \frac{q^k - 1}{q^{(i-j)k} - 1} \cdot \mathrm{id}_{\tau^{\circ c}} \right).
$$

<span id="page-7-0"></span>2.2. Relation to Speh representations of level zero representations. Let  $F$  be a non-archimedean local field with ring of integers  $\mathfrak{o}$ , maximal ideal  $\mathfrak{p}$  and residue field  $\mathbb{F}$ . Let  $\nu: \mathfrak{o} \to \mathbb{F}$  be the quotient map. Let  $\varpi \in \mathfrak{p}$  be a uniformizer.

Let T be an irreducible supercuspidal representation of  $GL_k(F)$ . Given an integer  $c \geq 1$ , one may construct an irreducible representation of  $GL_{kc}(F)$ , called the Speh representation and denoted  $\Delta(\mathcal{T}, c)$ . In this section, we explain the relation between Speh representations of  $GL_{kc}(F)$  and of  $GL_{kc}(F)$  using level zero supercuspidal representations.

2.2.1. *Speh representations over local fields.* We first recall the definition of the Speh representation  $\Delta(\mathcal{T}, c)$ . These were introduced by Jacquet in [\[19,](#page-40-2) Section 2.2]. We follow [\[4,](#page-39-3) Section 2.2]. Given  $z_1, \ldots, z_c \in \mathbb{C}$ , we consider the (normalized) parabolically induced representation

$$
\mathcal{T}^{(z_1,\ldots,z_c)} = \mathrm{Ind}_{P_{(k^c)}}^{\mathrm{GL}_{kc}(F)} \left( \left| \det \right|^{z_1} \mathcal{T} \otimes \cdots \otimes \left| \det \right|^{z_c} \mathcal{T} \right). \tag{1}
$$

A section  $\Phi^{(z_1,\ldots,z_c)}$  for the family  $\mathcal{T}^{(z_1,\ldots,z_c)}$  is an assignment  $\Omega \times GL_{kc}(F) \to \mathcal{T}^{\otimes c}$ , denoted by  $(z_1,\ldots,z_c,g) \mapsto \Phi^{(z_1,\ldots,z_c)}(g)$ , such that for any  $(z_1,\ldots,z_c)$  in an open set  $\Omega$  the assignment  $g \mapsto \Phi^{(z_1,...,z_c)}(g)$  is an element of  $\mathcal{T}^{(z_1,...,z_c)}$ . A section  $\Phi^{(z_1,...,z_c)}$  is called *a flat section* if  $\Omega = \mathbb{C}^c$  and if for any  $k_0 \in GL_{kc}(\mathfrak{o})$ , the assignment  $(z_1, \ldots, z_c) \mapsto \Phi^{(z_1, \ldots, z_c)}(k_0)$  does not depend on  $z_1, \ldots, z_c$ . A section  $\Phi^{(z_1,\ldots,z_c)}$  is called a *holomorphic section* if it can be written as a (finite)  $\mathbb{C}[q^{\pm z_1}, \ldots, q^{\pm z_c}]$ -linear combination of flat sections. A section  $\Phi^{(z_1,\ldots,z_c)}$  is called *a meromorphic section* if it can be written as a (finite)  $\mathbb{C}(q^{-z_1}, \ldots, q^{-z_c})$ -linear combination of flat sections.

Given a flat section  $\Phi^{(z_1,...,z_c)}$  and  $g \in GL_{kc}(F)$ , we consider the integral

$$
M_{w_{(1c)}}^{(z_1,\ldots,z_c)}\Phi^{(z_1,\ldots,z_c)}(g) = w_{(1c)} \int_{N_{(k^c)}} \Phi^{(z_1,\ldots,z_c)}(w_{(k^c)}ug) du,
$$
\n(2)

where  $w_{(1^c)}$  is the longest Weyl element in  $\mathfrak{S}_c$  and  $w_{(k^c)} \in GL_{kc}(F)$  is the matrix representing  $w_{(1^c)}$ , where we replaced every zero entry by  $0_k$  and every 1 entry by  $I_k$ . Here,  $w_{(1^c)}$  acts on  $\mathcal{T}^{\otimes c}$  by permuting components of pure tensors.

It is well-known that the integral [\(2\)](#page-7-1) converges absolutely for  $(z_1, \ldots, z_c)$  in a cone and has a meromorphic continuation to  $\mathbb{C}^c$  [\[34,](#page-40-22) Theorem IV.1.1], by which we mean that it results in a (finite)  $\mathbb{C} (q^{-z_1}, \ldots, q^{-z_c})$ -linear combination of elements in  $\mathcal{T}^{\otimes c}$ . We keep denoting the meromorphic continuation of [\(2\)](#page-7-1) by the same symbol. Then in its domain of definition,  $M_{w_{(1c)}}^{(z_1,\ldots,z_c)}$  defines an intertwining operator

$$
\mathcal{T}^{(z_1,\ldots,z_c)}\to \mathcal{T}^{(z_c,\ldots,z_1)}.
$$

It is also well-known that  $M_{w_{(1c)}}^{(z_1,\ldots,z_c)}$  is holomorphic at the point

$$
(z_1, ..., z_c) = \left(\frac{c-1}{2}, \frac{c-3}{2}, ..., -\frac{c-1}{2}\right).
$$

The Speh representation  $\Delta(\mathcal{T}, c)$  is defined as the image of  $M_{w_{(1c)}}^{\left(\frac{c-1}{2}, \frac{c-3}{2}, \ldots, -\frac{c-1}{2}\right)}$ .

<span id="page-8-1"></span><span id="page-8-0"></span>It turns out that if  $c = c_1 + c_2$ , then  $\Delta(\mathcal{T}, c)$  is a subrepresentation of the parabolically induced representation  $|\det|^{-\frac{c_2}{2}} \Delta(\mathcal{T}, c_1) \times |\det|^{\frac{c_1}{2}} \Delta(\mathcal{T}, c_2)$ .

**Remark 2.3.** Similarly, it is also well-known that  $M_{w_{(1c)}}^{(z_1,...,z_c)}$  is holomorphic at the point

$$
(z_1, \ldots, z_c) = \left(-\frac{c-1}{2}, -\frac{c-3}{2}, \ldots, \frac{c-1}{2}\right).
$$

The Steinberg representation St  $(\mathcal{T}, c)$  is defined as the image of  $M_{w_{(1c)}}^{\left(-\frac{c-1}{2}, -\frac{c-3}{2}, \dots, \frac{c-1}{2}\right)}$  $w_{(1^c)}$ ,  $w_{(1^c)}$ ,  $w_{(1^c)}$ 

We remark that the definition of the Speh representation  $\Delta(\mathcal{T}, c)$  given above makes sense for any essentially unitary irreducible representation  $\mathcal{T}$ . We also remark that in [\[4\]](#page-39-3) and [\[24\]](#page-40-23) a generalized Speh representation  $\Delta(\mathcal{T}, c)$  was defined for any irreducible generic representation  $\mathcal T$ . However, for our purposes we only need to consider supercuspidal representations.

2.2.2. *Level zero representations.* Let  $\tau$  be an irreducible cuspidal representation of  $GL_k(\mathbb{F})$ . Let  $\chi: F^{\times} \to \mathbb{C}^{\times}$  be a character, such that  $\chi \upharpoonright_{\mathfrak{o}^{\times}} = \omega_{\tau} \circ \nu \upharpoonright_{\mathfrak{o}^{\times}}$ . Consider the following representation of  $F^{\times} \cdot GL_k(\mathfrak{o})$ :

$$
(\chi \otimes \tau) (zk_0) = \chi (z) \tau (\nu (k_0)),
$$

for any  $z \in F^{\times}$  and  $k_0 \in GL_k(\mathfrak{o})$ . Then the compactly induced representation

$$
\mathcal{T} = \mathrm{ind}_{F^\times \cdot \mathrm{GL}_k(\mathfrak{o})}^{\mathrm{GL}_k(F)} (\chi \otimes \tau)
$$

is an irreducible supercuspidal representation of  $GL_k(F)$  [\[32,](#page-40-24) Theorem 6.2]. We say that  $\mathcal T$ is an *irreducible level zero supercuspidal representation of*  $GL_k(F)$  *constructed from*  $\tau$  *with central character*  $\chi$ . Henceforth we will always write  $\omega_{\tau}$  instead of  $\chi$ .

Given an element  $v_{\tau} \in \tau$ , we have an element  $\mathcal{L}v_{\tau} \in \mathcal{T}$  given by the function supported on  $F^{\times} \cdot GL_k(\mathfrak{o})$ , satisfying

$$
\left(\mathcal{L}v_{\tau}\right)(zk_0)=\omega_{\mathcal{T}}(z)\,\tau\left(\nu\left(k_0\right)\right)v_{\tau},
$$

for any  $z \in F^{\times}$  and  $k_0 \in GL_k(\mathfrak{o})$ .

Given vectors  $v_{\tau,1}, \ldots, v_{\tau,c} \in \tau$ , we define

$$
\mathcal{L}(v_{\tau,1}\otimes\cdots\otimes v_{\tau,c})=\mathcal{L}v_{\tau,1}\otimes\cdots\otimes\mathcal{L}v_{\tau,c}\in\mathcal{T}\otimes\cdots\otimes\mathcal{T}.
$$

We extend the definition of  $\mathcal{L}v_{\tau^{\otimes c}}$  for every  $v_{\tau^{\otimes c}} \in \tau^{\otimes c}$  using linearity.

Let  $f \in \tau^{\circ c}$ . We define a flat section

$$
\mathcal{L}^{(z_1,...,z_c)}\left(f\right)\in\mathcal{T}^{(z_1,...,z_c)}
$$

as follows. First notice that the assignment  $GL_{kc}(\mathfrak{o}) \to \mathcal{T}^{\otimes c}$  given by  $k_0 \mapsto \mathcal{L}f(\nu(k_0))$ defines an element of  $\text{Ind}_{P_{(k^c)} \cap \text{GL}_{kc}(\mathfrak{o})}^{\text{GL}_{kc}(\mathfrak{o})}(\mathcal{T}^{\otimes c})$ . Hence, by the Iwasawa decomposition

$$
\mathrm{GL}_{kc}(F)=P_{(k^c)}\cdot\mathrm{GL}_{kc}(\mathfrak{o}),
$$

we may lift this element uniquely to a flat section  $\mathcal{L}^{(z_1,\dots,z_c)}(f) \in \mathcal{T}^{(z_1,\dots,z_c)}$  that satisfies

$$
\mathcal{L}^{(z_1,\ldots,z_c)}(f)(k_0)=\mathcal{L}(f(\nu(k_0))),
$$

for any  $k_0 \in GL_{kc}(\mathfrak{o})$ .

<span id="page-9-3"></span>2.2.3. *Simple reflection intertwining operators.* Let  $\Phi^{(z_1,\ldots,z_c)} \in \mathcal{T}^{(z_1,\ldots,z_c)}$  be a flat section. For  $1 \leq i \leq c-1$ , let  $s_i = (i, i+1) \in \mathfrak{S}_c$  be a transposition. For an element  $g \in GL_{2k}(F)$ denote

$$
d_i(g) = \text{diag}(I_{(i-1)k}, g, I_{(c-i-1)k}).
$$

Consider the following intertwining operator

<span id="page-9-0"></span>
$$
\left(M_{s_i}^{(z_1,\ldots,z_c)}\Phi^{(z_1,\ldots,z_c)}\right)(g) = s_i \int_{\text{Mat}_k(F)} \Phi^{(z_1,\ldots,z_c)}\left(d_i\left(\begin{pmatrix}I_k & I_k\\I_k & I_k\end{pmatrix}\begin{pmatrix}I_k & X\\I_k & I_k\end{pmatrix}\right)g\right)dX. \tag{3}
$$

Once again, it is known that the right hand side of [\(3\)](#page-9-0) converges absolutely for  $(z_1, \ldots, z_c)$  in a cone and has a meromorphic continuation to  $\mathbb{C}^c$  [\[34,](#page-40-22) Theorem IV.1.1]. We keep denoting the meromorphic continuation by the same symbol. It defines an intertwining operator

$$
M_{s_i}^{(z_1,\ldots,z_c)}\colon \mathcal{T}^{(z_1,\ldots,z_c)}\to \mathcal{T}^{s_i(z_1,\ldots,z_c)},
$$

where  $s_i$  acts on  $(z_1, \ldots, z_c)$  by swapping the *i*-th and the *i* + 1-th components.

Recall the following decompositions of the long Weyl element in  $\mathfrak{S}_c$  [\[17,](#page-40-20) Equation (2.3) and below]:

$$
(s_1)(s_2s_1)\dots(s_{c-1}s_{c-2}\dots s_1)=(s_1s_2\dots s_{c-1})\dots(s_1s_2)s_1.
$$

Using either of these decompositions, we may decompose  $M_{w_{(1c)}}^{(z_1,\ldots,z_c)}$  as a composition of operators  $M_{s_j}$  corresponding to the decomposition we choose, where the complex parameters are inferred.

<span id="page-9-2"></span>Let us normalize (in this subsection only) the Haar measure so that  $\text{Mat}_k(\mathfrak{p})$  has volume  $q^{-\binom{k}{2}}$ . This makes the constants similar to the ones in Section [2.1.1.](#page-6-1)

**Lemma 2.4.** For any  $f \in \tau^{\circ c}$  we have

$$
M_{s_i}^{(z_1,\ldots,z_c)}\mathcal{L}^{(z_1,\ldots,z_c)}(f) = q^{-\binom{k}{2}}\mathcal{L}^{s_i(z_1,\ldots,z_c)}(h_{s_i}f) + \omega_\tau(-1)\frac{q^k-1}{q^{k(z_i-z_{i+1})}-1}\mathcal{L}^{s_i(z_1,\ldots,z_c)}(f).
$$

*Here, the integral defining*  $M_{s_i}^{(z_1,...,z_c)}$  *converges absolutely for*  $\text{Re}z_i > \text{Re}z_{i+1}$  *and the equality is understood elsewhere as an equality of its meromorphic continuation.*

**Remark 2.5.** Using transitivity of induction, it suffices to prove this for  $c = 2$ . However, we chose to stick to the notation  $d_i$  defined above instead of reducing to  $c = 2$ .

*Proof.* Throughout the proof, we will use the notation  $\tau_i(h_i) \otimes \tau_{i+1}(h_{i+1})$ , where  $h_i, h_{i+1} \in$  $GL_k(\mathbb{F})$  to mean the linear map

$$
id_{\tau}^{\otimes (i-1)} \otimes \tau (h_i) \otimes \tau (h_{i+1}) \otimes id_{\tau}^{\otimes (k-i-1)} : \tau^{\otimes c} \to \tau^{\otimes c},
$$

and similarly for the notation  $\mathcal{T}_i(h_i) \otimes \mathcal{T}_{i+1}(h_{i+1}),$  where  $h_i, h_{i+1} \in GL_k(F)$ .

By the Iwasawa decomposition  $GL_{kc}(F) = P_{(k^c)} \cdot GL_{kc}(\mathfrak{o})$ , it suffices to prove the equality for elements in  $GL_{kc}(\mathfrak{o})$ . Furthermore, since for any  $k_0 \in GL_{kc}(\mathfrak{o})$  we have

$$
\mathcal{L}^{(z_1,...,z_c)}(\tau^{oc}(\nu(k_0)) f) = \mathcal{T}^{(z_1,...,z_c)}(k_0) \mathcal{L}^{(z_1,...,z_c)}(f) ,
$$

it suffices to prove the equality at  $I_{kc}$ . Let  $\Phi^{(z_1,...,z_c)} = \mathcal{L}^{(z_1,...,z_c)}(f)$ . Consider the maximum norm on  $\text{Mat}_k(F)$ , defined by  $\|(x_{ij})\| = \max |x_{ij}|_{i,j}$ . We split the integral in [\(3\)](#page-9-0) into two parts: The first integral is

<span id="page-9-1"></span>
$$
s_i \int_{\substack{\text{Mat}_k(F) \\ \|X\| \le 1}} \Phi^{(z_1, \dots, z_c)} \left( d_i \left( \begin{pmatrix} I_k & I_k \\ I_k & I_k \end{pmatrix} \begin{pmatrix} I_k & X \\ & I_k \end{pmatrix} \right) \right) dX \tag{4}
$$

and the second integral is

<span id="page-10-0"></span>
$$
s_i \int_{\substack{\text{Mat}_k(F) \\ \|X\| > 1}} \Phi^{(z_1, \dots, z_c)} \left( d_i \left( \begin{pmatrix} I_k & I_k \\ I_k & I_k \end{pmatrix} \begin{pmatrix} I_k & X \\ & I_k \end{pmatrix} \right) \right) dX. \tag{5}
$$

Regarding the first integral, since  $||X|| \leq 1$ , the matrices appearing in the argument of  $\Phi^{(z_1,\ldots,z_c)}$  all lie in  $GL_{kc}(\mathfrak{o})$ , and therefore by definition we get the value

$$
s_i \int_{\substack{\text{Mat}_k(F) \\ \|X\| \le 1}} \mathcal{L}\left(f\left(d_i\left(\begin{pmatrix} I_k & I_k \end{pmatrix} \nu \begin{pmatrix} I_k & X \\ & I_k \end{pmatrix}\right)\right)\right) dX.
$$

Since the integrand is invariant under  $\text{Mat}_c(\mathfrak{p})$  translations, we get by the isomorphism  $\nu$ : Mat<sub>k</sub> (o) / Mat<sub>k</sub> (p) ≅ Mat<sub>k</sub> (F) that [\(4\)](#page-9-1) contributes

$$
q^{-\binom{k}{2}}s_i \sum_{X \in \text{Mat}_k(\mathbb{F})} \mathcal{L}\left(f\left(d_i\left(\binom{I_k}{I_k}\binom{I_k}{I_k}\right)\right)\right) = q^{-\binom{k}{2}}\mathcal{L}\left(h_{s_i}f\right)\left(I_{kc}\right).
$$

Regarding the second part, since  $GL_k(F)$  is open dense in  $\text{Mat}_k(F)$ , we may integrate over  $GL_k(F)$ . We replace the additive Haar measure with the multiplicative Haar measure by using the relation  $dX = |\text{det }X|^k d^{\times} X$ , where we normalize correctly, so that  $1 + \text{Mat}_k(\mathfrak{p})$ has volume  $q^{-\binom{k}{2}}$ . Then [\(5\)](#page-10-0) becomes

s_i \int_{\substack{\text{GL}_k(F) \\ \|X\| > 1}} \Phi^{(z_1, \ldots, z_c)} \left( d_i \left( \begin{pmatrix} I_k & I_k \\ I_k & I_k \end{pmatrix} \begin{pmatrix} I_k & X \\ I_k & I_k \end{pmatrix} \right) \right) |\det X|^k d^{\times} X. \tag{6}
$$

For  $X \in GL_k(F)$  let  $X = k_{1,X} a_X k_{2,X}$  be a Cartan decomposition, where  $k_1 = k_{1,X}, k_2 =$  $k_{2,X} \in GL_k(\mathfrak{o})$  and  $a_X = \text{diag}(\varpi^{m_1}, \ldots, \varpi^{m_k}),$  where  $m_1 \geq \cdots \geq m_k$ . Let  $0 \leq r \leq k$  be such that the diagonal entries of  $a_X^+ = \text{diag}(\varpi^{m_1}, \dots, \varpi^{m_r})$  all have  $m_j \geq 0$  and such that the diagonal entries of  $a_X^-$  = diag  $(\varpi^{m_{r+1}}, \ldots, \varpi^{m_k})$  all have  $m_j < 0$ . Then we have the following decomposition, where the first two matrices on the second line lie in  $P_{(k<sup>c</sup>)}$  and the last two matrices on that line lie in  $GL_{kc}(\mathfrak{o})$ :

$$
\begin{pmatrix}\nI_k\n\end{pmatrix}\n\begin{pmatrix}\nI_k & X \\
I_k\n\end{pmatrix}
$$
\n=\n $\begin{pmatrix}\nk_1^{-1} \\
k_1\n\end{pmatrix}\n\begin{pmatrix}\nI_r \\
I_r \\
I_r\n\end{pmatrix}\n\begin{pmatrix}\nI_{k-r} \\
I_r \\
I_{k-r}\n\end{pmatrix}\n\begin{pmatrix}\nI_r \\
I_{k-r} \\
I_{k-r}\n\end{pmatrix}\n\begin{pmatrix}\nk_1^{-1} \\
k_2\n\end{pmatrix}.$ 

<span id="page-10-1"></span>Hence, we get

$$
\Phi^{(z_1,\ldots,z_c)}\left(d_i\left(\binom{I_k}{I_k}\binom{I_k-X}{I_k}\right)\right)
$$
\n
$$
=|\det a_X^{-}|^{-k+z_{i+1}-z_i}\mathcal{T}_i\left(k_2^{-1}\binom{I_r}{\cdots (a_X^{-})^{-1}}\right)\otimes \mathcal{T}_{i+1}\left(k_1\binom{I_r}{\cdots a_X^{-}}\right)
$$
\n
$$
\times \mathcal{L}\left((f\circ\nu\circ d_i)\left(\binom{I_r}{I_r}\begin{array}{c}I_r\\I_{k-r}\end{array}a_X^{+}\right)\binom{k_1^{-1}}{I_{k-r}}\binom{k_1^{-1}}{k_2}\right)\right).
$$
\n
$$
(7)
$$

We will first evaluate [\(7\)](#page-10-1) at  $(I_k, \ldots, I_k)$ . This amounts to evaluating a function  $\mathcal{L}(v_{\tau^{\otimes c}})$ for some  $v_{\tau^{\otimes c}} \in \tau^{\otimes c}$  at the point

$$
\left(I_k,\ldots,I_k,k_2^{-1}\begin{pmatrix}I_r&\\&-\left(a_X^-\right)^{-1}\end{pmatrix},k_1\begin{pmatrix}I_r&\\&a_X^-\end{pmatrix},I_k,\ldots,I_k\right).
$$

Since  $\mathcal{L}(v_{\tau^{\otimes c}})$  is only supported on  $\prod_{j=1}^{c} (F^{\times} \cdot GL_k(F))$ , we must have that  $\left( \begin{array}{c} I_r \end{array} \right)$  $a_X^ \Big)$  is a scalar matrix. Therefore, if  $||X|| > 1$  then we must have  $r = 0$  and  $a_X = \varpi^{-j} I_{kc}$  for some  $j \geq 1$ , and we may assume  $k_2 = I_{kc}$ . Then the integral [\(6\)](#page-10-2) evaluated at  $(I_k, \ldots, I_k)$  becomes

$$
s_{i} \sum_{j=1}^{\infty} q^{kj(z_{i+1}-z_{i})} \int_{GL_{k}(0)} \tau_{i} \left(-\nu (k_{1})^{-1}\right) \otimes \tau_{i+1} \left(\nu (k_{1})\right) f(I_{kc}) d^{\times} k_{1}
$$
  
= 
$$
\frac{1}{q^{k(z_{i}-z_{i+1})}-1} \cdot s_{i} \int_{GL_{k}(0)} \tau_{i} \left(-\nu (k_{1})^{-1}\right) \otimes \tau_{i+1} \left(\nu (k_{1})\right) f(I_{kc}) d^{\times} k_{1},
$$

where the convergence is for Re  $(z_i - z_{i+1}) > 0$ .

We are left to deal with the inner integral

$$
s_i \int_{\mathrm{GL}_k(\mathfrak{o})} \tau_i \left(-\nu (k_1)^{-1}\right) \otimes \tau_{i+1} \left(\nu (k_1)\right) f\left(I_{kc}\right) \mathrm{d}^{\times} k_1.
$$

Since the argument is invariant under  $1 + Mat_k(\mathfrak{p})$ , this evaluates to

$$
q^{-\binom{k}{2}}\omega_{\tau}\left(-1\right)s_{i}\sum_{h\in\mathrm{GL}_{k}(\mathbb{F})}\tau_{i}\left(h^{-1}\right)\otimes\tau_{i+1}\left(h\right)f\left(I_{kc}\right).
$$

By Corollary [A.2,](#page-36-1) we have the following equality of operators  $\tau^{\otimes c} \to \tau^{\otimes c}$ ,

$$
s_i \sum_{h \in \mathrm{GL}_k(\mathbb{F})} \tau_i\left(h^{-1}\right) \otimes \tau_{i+1}\left(h\right) = q^{\binom{k}{2}}(q^k - 1) \cdot \mathrm{id}_{\tau} \otimes \mathfrak{c}.
$$

Thus, the integral [\(5\)](#page-10-0) evaluated at  $(I_k, \ldots, I_k)$  contributes

$$
\omega_{\tau}\left(-1\right)\frac{q^k-1}{q^{k(z_i-z_{i+1})}-1}f\left(I_{kc}\right).
$$

To finish, we claim that the function defined by [\(6\)](#page-10-2) is supported on  $\prod_{j=1}^{c} (F^{\times} \cdot GL_k(\mathfrak{o}))$ . It is clear that if  $(h_1, \ldots, h_c)$  is in the support of the function defined by [\(7\)](#page-10-1), then for any  $j \neq i, i + 1$  we must have  $h_j \in F^{\times} \cdot GL_k(\mathfrak{o})$ . By replacing f with a suitable right translation of it, we may assume henceforth, without loss of generality, that  $h_j = I_k$  for every  $j \neq i, i+1$ .

Suppose that  $h_i$  or  $h_{i+1}$  are not in  $F^{\times} \cdot GL_k(\mathfrak{o})$ . We want to show that [\(6\)](#page-10-2) vanishes at  $(h_1, \ldots, h_c)$ . Since the center acts by the central character, we may assume that  $h_i$  and  $h_{i+1}$ have Cartan decomposition with diagonal part  $\begin{pmatrix} I_{r_1} \\ I_{r_2} \end{pmatrix}$  $b_1$ ) and  $\binom{b_2}{b_3}$  $I_{r_2}$  , respectively, where  $0 < r_1, r_2 \leq k$  and  $b_1 = \text{diag}\left(\varpi^{m'_{r_1+1}}, \ldots, \varpi^{m'_{k}}\right)$  and  $b_2 = \text{diag}\left(\varpi^{m''_{k}}, \ldots, \varpi^{m''_{r_2+1}}\right)$ , such that min  $(r_1, r_2) < k$  and  $0 > m'_{r_1+1} \geq \cdots \geq m'_{k}$  and  $m''_{k} \geq \cdots \geq m''_{r_2+1} > 0$ . If  $(h_1, \ldots, h_c)$ is in the support of  $(7)$  for some X, then we must have that

$$
h_i k_2^{-1} \begin{pmatrix} I_r & & \\ & -(a_X^-)^{-1} \end{pmatrix} = t_1 k_1' \text{ and } h_{i+1} k_1 \begin{pmatrix} I_r & \\ & a_X^- \end{pmatrix} = t_2 k_2' \tag{8}
$$

for some  $t_1, t_2 \in F^\times$  and  $k'_1, k'_2 \in GL_k(\mathfrak{o})$ . Writing

h_i = k_1' t_1 \begin{pmatrix} I_r & & \\ & -a_X \end{pmatrix} k_2 \text{ and } h_{i+1} = k_2' t_2 \begin{pmatrix} I_r & & \\ & (a_X)^{-1} \end{pmatrix} k_1^{-1}
$$
 (9)

and comparing the Cartan decomposition of both sides of [\(9\)](#page-12-0), we see that  $t_1, t_2 \in \mathfrak{o}^{\times}$ , so without loss of generality  $t_1 = t_2 = 1$ . In addition, [\(9\)](#page-12-0) implies that the diagonal parts of the Cartan decomposition of  $h_i$  and  $h_{i+1}$  must be related, and that they determine  $a_X^-$ . More precisely,

<span id="page-12-1"></span>
$$
\begin{pmatrix} I_r & \\ & a_X \end{pmatrix} = \begin{pmatrix} I_{r_1} & \\ & b_1 \end{pmatrix} \text{ and } \begin{pmatrix} b_2 & \\ & I_{r_2} \end{pmatrix} = \begin{pmatrix} w_{(1^{k-r})} \left( a_X^{-} \right)^{-1} w_{(1^{k-r})} & \\ & I_r \end{pmatrix}
$$
 (10)

which implies that  $1 \le r_1 = r_2 = r < k$  and  $m_j = m'_j = -m''_j$  for every  $r \le j \le k$ , and hence  $a_X^- = b_1$ . Denote  $b = b_1$ . As we just explained above, the value b is determined by the Cartan decomposition of  $h_i$ . By [\(7\)](#page-10-1) and [\(10\)](#page-12-1), the evaluation of [\(6\)](#page-10-2) at  $(h_1, \ldots, h_c)$  is given by

|\det b|^{z_{i+1}-z_{i}} \sum_{\substack{a^{+}=\text{diag}(\varpi^{m_{1}},\ldots,\varpi^{m_{r}}) \\ m_{1}\geq m_{2}\geq\cdots\geq m_{r}\geq 0}} \frac{\text{Vol}\left(\text{GL}_{k}(\mathfrak{o})\binom{a^{+}}{b}\text{GL}_{k}(\mathfrak{o})\right)}{\text{Vol}\left(\text{GL}_{k}(\mathfrak{o})\right)^{2}} \\ \times \int_{\text{GL}_{k}(\mathfrak{o})} \int_{\text{GL}_{k}(\mathfrak{o})} \mathcal{L}\left((f\circ\nu\circ d_{i})\left(\begin{pmatrix}I_{r} & I_{k-r} \\ I_{r} & a^{+} \\ I_{r} & a^{+} \end{pmatrix}\binom{k_{i}^{-1}}{k_{2}}\right)\right) \right) \qquad (11)
$$
\n
$$
\left(I_{k},\ldots,I_{k},h_{i}k_{2}^{-1}\binom{I_{r}}{k_{2}}-b^{-1}\right),h_{i+1}k_{1}\binom{I_{r}}{k_{j}},I_{k},\ldots,I_{k}\right) d^{\times}k_{1}d^{\times}k_{2}.
$$

Decomposing the integration over  $k_1$  in [\(11\)](#page-12-2) through the subgroup

$$
N_b = \left\{ \begin{pmatrix} I_r & Yb^{-1} \\ & I_{k-r} \end{pmatrix} \mid Y \in \text{Mat}_{r \times (k-r)} \left( \mathfrak{o} \right) \right\} \subset I_k + \text{Mat}_k \left( \mathfrak{p} \right)
$$

yields an inner integral

<span id="page-12-3"></span>
$$
\int_{Y \in \text{Mat}_{r \times (k-r)}(0)} \mathcal{L}\left((f \circ \nu \circ d_i) \left(\left(\begin{array}{cc} I_r & I_{k-r} \\ I_r & a^+ \\ I_{k-r} \end{array}\right) \left(\begin{array}{cc} k_1^{-1} \\ k_2 \end{array}\right)\right)\right) \left(I_k, \ldots, I_k, h_i k_2^{-1} \left(\begin{array}{cc} I_r & I_{k-r} \\ I_r & -b^{-1} \end{array}\right), h_{i+1} k_1 \left(\begin{array}{cc} I_r & I \\ b \end{array}\right) \left(\begin{array}{cc} I_r & Y \\ I_{k-r} \end{array}\right), I_k, \ldots, I_k\right) dY.
$$
\n(12)

Since  $\begin{pmatrix} I_r & Y_r \\ I_r & I_r \end{pmatrix}$  $I_{k-r}^Y$ )  $\in$  GL<sub>k</sub> ( $\mathfrak{o}$ ), we see that the argument of the last expression is in the support of  $\mathcal{L}(v_{\tau^{\otimes c}})$  for some  $v_{\tau^{\otimes c}} \in \tau^{\otimes c}$  if and only if  $k_1$  and  $k_2$  are such that

$$
h_{i}k_{2}^{-1}\begin{pmatrix}I_{r} & \\ & -b^{-1}\end{pmatrix}, h_{i+1}k_{1}\begin{pmatrix}I_{r} & \\ & b\end{pmatrix} \in GL_{k}(\mathfrak{o}),
$$

and in this case [\(12\)](#page-12-3) evaluates to a scalar multiple of

$$
\tau_i\left(\nu\left(h_i k_2^{-1}\begin{pmatrix}I_r & & \\ & -b^{-1}\end{pmatrix}\right)\right) \otimes \tau_{i+1}\left(\nu\left(h_{i+1} k_1\begin{pmatrix}I_r & & \\ & b\end{pmatrix}\right)\right) \times \sum_{Y \in Mat_{r \times (k-r)}(\mathbb{F})} \tau_{i+1}\begin{pmatrix}I_r & & \\ & I_{k-r}\end{pmatrix} (f \circ \nu \circ d_i) \left(\begin{pmatrix}I_r & & \\ & I_{k-r} & \\ & & I_{k-r}\end{pmatrix} \begin{pmatrix}k_1^{-1} & & \\ & k_2\end{pmatrix}\right).
$$
\n(13)

But for  $1 \leq r \leq k-1$  we have that

$$
\sum_{Y \in \text{Mat}_{r \times (k-r)}(\mathbb{F})} \tau \begin{pmatrix} I_r & Y \\ & I_{k-r} \end{pmatrix} = 0
$$

because  $\tau$  is cuspidal. Therefore, we proved that the evaluation of [\(6\)](#page-10-2) is zero if  $h_i$  or  $h_{i+1}$ are not in  $F^{\times} \mathrm{GL}_k(\mathfrak{o})$ .

 $\Box$ 

Remark 2.6. For future purposes, it will be useful to evaluate the following more general intertwining operator. Let  $\mathcal{T}_1, \ldots, \mathcal{T}_c$  be irreducible level zero supercuspidal representations of  $GL_k(F)$  constructed from irreducible cuspidal representations  $\tau_1, \ldots, \tau_c$  of  $GL_k(F)$ , respectively. Let

$$
\mathcal{T}^{(z_1,...,z_c)}_{(\mathcal{T}_1,...,\mathcal{T}_c)} = \operatorname{Ind}_{P_{(k^c)}}^{\operatorname{GL}_{kc}(F)} \left( \left| \det \right|^{z_1} \mathcal{T}_1 \otimes \cdots \otimes \left| \det \right|^{z_c} \mathcal{T}_c \right).
$$

We can define the notion of lifts and also define intertwining operators

$$
h_{s_i}: \tau_1 \circ \cdots \circ \tau_c \to \tau_1 \circ \cdots \circ \tau_{i+1} \circ \tau_i \circ \cdots \circ \tau_c.
$$

Consider the intertwining operator

$$
M_{s_i}^{(z_1,\ldots,z_c)}: \mathcal{T}_{(\mathcal{T}_1,\ldots,\mathcal{T}_c)}^{(z_1,\ldots,z_c)} \to \mathcal{T}_{s_i(\mathcal{T}_1,\ldots,\mathcal{T}_c)}^{s_i(z_1,\ldots,z_c)}
$$

defined by the same formula as [\(3\)](#page-9-0). Then, similarly to the proof of Lemma [2.4,](#page-9-2) we can show that for any  $f \in \tau_1 \circ \cdots \circ \tau_c$  we have

(1) If  $\tau_i$  is not isomorphic to  $\tau_{i+1}$ , then

$$
M_{s_i}^{(z_1,\ldots,z_c)} \mathcal{L}^{(z_1,\ldots,z_c)}(f) = q^{-\binom{k}{2}} \mathcal{L}^{s_i(z_1,\ldots,z_c)}(h_{s_i}f).
$$

(2) If  $\tau_i = \tau_{i+1}$ , then

$$
M_{s_i}^{(z_1,...,z_c)} \mathcal{L}^{(z_1,...,z_c)} (f) = q^{-\binom{k}{2}} \mathcal{L}^{s_i(z_1,...,z_c)} (h_{s_i}f) + \omega_{\tau_i} (-1) \frac{q^k - 1}{\omega_{\tau_i} (\varpi)^{-1} \omega_{\tau_{i+1}} (\varpi) q^{k(z_i - z_{i+1})} - 1} \mathcal{L}^{s_i(z_1,...,z_c)} (f),
$$

where for  $1 \leq j \leq c$ ,  $\omega_{\mathcal{T}_j}$  is the central character of  $\mathcal{T}_j$ .

By applying Lemma [2.4](#page-9-2) repeatedly to the decomposition

$$
M_{(1^c)} = (M_{s_1}) \circ (M_{s_2} \circ M_{s_1}) \circ \cdots \circ (M_{s_{c-1}} \circ \cdots \circ M_{s_1}),
$$

or to the decomposition

$$
M_{(1^c)} = (M_{s_1} \circ \cdots \circ M_{s_{c-1}}) \circ \cdots \circ (M_{s_1} \circ M_{s_2}) \circ (M_{s_1}),
$$

<span id="page-13-0"></span>where the complex parameters are inferred, we get the following theorem.

**Theorem 2.7.** For any  $f \in \tau^{\infty}$ , we have

$$
M_{w_{(1^c)}}^{(z_1,\ldots,z_c)} \mathcal{L}^{(z_1,\ldots,z_c)} f = \omega_\tau (-1)^{\binom{c}{2}} \mathcal{L}^{(z_c,\ldots,z_1)} \left( \left( \prod_{\substack{(i,j) \\ 1 \leq i < j \leq c}} \left( h_{s_{j-i}}^0 + \frac{q^k - 1}{q^{k(z_i - z_j)} - 1} \cdot \mathrm{id}_{\tau^{\circ c}} \right) \right) f \right),
$$

*where the product is ordered by the lexicographic ordering, taken either right to left or left to right.*

Applying Theorem [2.7](#page-13-0) to

$$
(z_1, ..., z_c) = \left(\frac{c-1}{2}, \frac{c-3}{2}, ..., -\frac{c-1}{2}\right),
$$

<span id="page-14-0"></span>and combining with Proposition [2.1,](#page-6-0) we get the following corollary.

Corollary 2.8. *The following diagram commutes*

$$
\tau^{\circ c} \xrightarrow{\mathrm{pr}_{\Delta(\tau,c)}} \Delta(\tau, c)
$$
\n
$$
\mathcal{L}\left(\frac{c-1}{2}, \dots, -\frac{c-1}{2}\right) \downarrow \qquad \qquad \mathcal{M}_{w(1^c)}^* \longrightarrow \mathcal{T}\left(\frac{c-1}{2}, \dots, \frac{c-1}{2}\right) \longrightarrow \tau\left(-\frac{c-1}{2}, \dots, \frac{c-1}{2}\right),
$$

*and hence we have a commutative diagram*

$$
\tau^{c c} \xrightarrow{\text{pr}_{\Delta(\tau,c)}} \Delta(\tau, c)
$$
\n
$$
\mathcal{L}^{\left(\frac{c-1}{2}, \dots, -\frac{c-1}{2}\right)} \sqrt{\tau^{\left(\frac{c-1}{2}, \dots, -\frac{c-1}{2}\right)} \xrightarrow{M_{w_{(1}c)}^*} \Delta(\tau, c)}
$$
\nwhere  $M_{w_{(1^c)}}^* = P_c(q^k)^{-1} \omega_\tau (-1)^{-\binom{c}{2}} M_{w_{(1^c)}}^{\left(\frac{c-1}{2}, \dots, -\frac{c-1}{2}\right)}$ .

<span id="page-14-1"></span>From now and on, we denote for a function  $f \in \Delta(\tau, c)$  its lift by  $\mathcal{L}f = \mathcal{L}^{\left(-\frac{c-1}{2}, ..., \frac{c-1}{2}\right)}f \in$  $\Delta$   $(\mathcal{T}, c)$ .

Remark 2.9. Applying the theorem at the point

$$
(z_1,\ldots,z_c)=\left(-\frac{c-1}{2},-\frac{c-3}{2},\ldots,\frac{c-3}{2},\frac{c-1}{2}\right),\,
$$

and using Remark [2.2,](#page-6-2) we see that the Steinberg representation (see Remark [2.3\)](#page-8-0) satisfies the following similar relation. We have the following commutative diagram:

$$
\begin{array}{ccc}\n & \tau^{\circ c} & \xrightarrow{\mathrm{pr}_{\mathrm{St}(\tau,c)}} \mathrm{St}(\tau,c) \\
 & \mathcal{L}^{\left(-\frac{c-1}{2}, \ldots, \frac{c-1}{2}\right)} \sqrt{\frac{M_{w}^{*}(\tau^{\circ})}{M_{w}^{*}(\tau^{\circ})}} & \sqrt{\mathcal{L}^{\left(\frac{c-1}{2}, \ldots, -\frac{c-1}{2}\right)}} \\
 & \mathcal{T}^{\left(-\frac{c-1}{2}, \ldots, \frac{c-1}{2}\right)} & \xrightarrow{M_{w}^{*}(\tau^{\circ})} \mathrm{St}(\mathcal{T}, c), \\
 & \longrightarrow & \mathrm{St}(\mathcal{T}, c), \\
 & \longrightarrow & \mathrm{St}(\mathcal{T}, c).\n\end{array}
$$

where  $M^*_{w_{(1^c)}} = (-1)^{k}$  $\left\{ \frac{c}{2}\right\} P_{c}\left(q^{k}\right)^{-1}\omega_{\tau}\left(-1\right)^{-\left(k\right)^{2}}$  $_2^c)$   $_M$  $w_{(1^c)}$ .

## 3.  $(k, c)$  WHITTAKER MODELS OF SPEH REPRESENTATIONS

This section is devoted to explaining the notion of  $(k, c)$   $\psi$ -Whittaker models of Speh representations in the context of finite fields and of non-archimedean local fields, and to establishing a relation between these two models.

<span id="page-15-1"></span>3.1.  $(k, c)$   $\psi$ -Whittaker models of Speh representations over finite fields. We define a character  $\psi_{(c^k)}: N_{(c^k)}(\mathbb{F}) \to \mathbb{C}^{\times}$  by the formula

$$
\psi_{(c^k)} \begin{pmatrix} I_c & X_1 & * & * & * \\ & I_c & X_2 & * & * \\ & & \ddots & \ddots & * \\ & & & I_c & X_{k-1} \\ & & & & I_c \end{pmatrix} = \psi \left( \sum_{j=1}^{k-1} \text{tr } X_j \right).
$$
 (14)

If  $\Sigma$  is a finite-dimensional representation of  $GL_{kc}(\mathbb{F})$ , we say that  $0 \neq v \in \Sigma$  is a  $(k, c)$  $\psi$ -Whittaker vector if for any  $u \in N_{(c^k)}(\mathbb{F})$ , we have  $\Sigma(u)v = \psi_{(c^k)}(u)v$ . An element  $0\neq \ell \in \mathrm{Hom}_{N_{\left(c^{k}\right)}(\mathbb{F})}\left(\Sigma, \psi_{\left(c^{k}\right)}\right)$ is called a  $(k, c)$   $\psi$ -*Whittaker functional*. The representation Σ admits a  $(k, c)$   $\psi$ -Whittaker vector if and only if it admits a  $(k, c)$   $\psi$ -Whittaker functional.

When  $c = 1$  we omit the  $(k, c)$  from the notation and simply say that v is a  $\psi$ -Whittaker vector and that  $\ell$  is a  $\psi$ -Whittaker functional. We also denote  $U_k = N_{(1^k)}$  and  $\psi = \psi_{(c^k)}$ . A representation  $\Sigma$  of  $GL_k(\mathbb{F})$  is called *generic* if it admits a  $\psi$ -Whittaker vector, and is called *of Whittaker type* if it admits a unique (up to scalar multiplication)  $\psi$ -Whittaker vector. These definitions do not depend on the choice of the non-trivial character  $\psi$ . It is well-known that irreducible cuspidal representation of  $GL_k(\mathbb{F})$  are generic. A classical result of Gelfand–Graev is that irreducible generic representations are of Whittaker type. By Frobenius reciprocity, this implies that if  $\Sigma$  is an irreducible generic representation of  $GL_k(\mathbb{F})$ , then there exists a unique subspace of  $\text{Ind}_{U_k(\mathbb{F})}^{\text{GL}_k(\mathbb{F})}(\psi)$  that is isomorphic to  $\Sigma$ . We denote this subspace by  $W(\Sigma, \psi)$  and call it the  $\psi$ -Whittaker model of  $\Sigma$ .

In his master's thesis [\[7,](#page-39-6) Theorem 6.4], Carmon showed that if  $\tau$  is an irreducible cuspidal representation of  $GL_k(\mathbb{F})$ , then for any c the Speh representation  $\Delta(\tau, c)$  admits a unique (up to scalar multiplication)  $(k, c)$   $\psi$ -Whittaker vector, and hence also a unique (up to scalar multiplication)  $(k, c)$   $\psi$ -Whittaker functional<sup>[1](#page-15-2)</sup>. These results are analogous to the results of [\[4\]](#page-39-3), which we will discuss in the next section. It follows from Frobenius reciprocity that there exists a unique subspace of  $\text{Ind}_{N_{(c^k)}(\mathbb{F})}^{\text{GL}_{kc}(\mathbb{F})}\left(\psi_{(c^k)}\right)$ that is isomorphic to  $\Delta(\tau, c)$ . We denote this subspace by  $\mathcal{W}\left(\Delta\left(\tau,c\right),\psi_{\left(c^{k}\right)}\right)$ ), and call it *the*  $(k, c)$   $\psi$ -*Whittaker model of*  $\Delta(\tau, c)$ .

This space can be realized explicitly as follows. Choose an inner product  $(\cdot, \cdot)_{\Delta(\tau,c)}$  on  $\Delta(\tau, c)$  that is invariant under the action of  $GL_{kc}(\mathbb{F})$ . Let  $0 \neq v_{\Delta(\tau,c), \psi_{(c^k)}} \in \Delta(\tau, c)$  be a  $(k, c) \psi$ -Whittaker vector. Then

$$
\mathcal{W}\left(\Delta\left(\tau,c\right),\psi_{\left(c^{k}\right)}\right)=\left\{ g\mapsto\left(\Delta\left(\tau,c\right)\left(g\right)v'_{\Delta\left(\tau,c\right)},v_{\Delta\left(\tau,c\right),\psi_{\left(c^{k}\right)}\right)}\right)_{\Delta\left(\tau,c\right)}\left|v'_{\Delta\left(\tau,c\right)}\in\Delta\left(\tau,c\right)\right\}.
$$

<span id="page-16-2"></span>A distinguished element of the  $(k, c)$   $\psi$ -Whittaker model of  $\Delta(\tau, c)$  is given by choosing a function corresponding to a  $(k, c)$   $\psi$ -Whittaker vector, normalized at the identity to have the value 1. This is the *Bessel–Speh function corresponding to*  $\Delta(\tau, c)$  *with respect to*  $\psi$ , defined as the following matrix coefficient:

$$
\mathcal{BS}_{\Delta(\tau,c),\psi}(g) = \frac{\left(\Delta\left(\tau,c\right)\left(g\right)v_{\Delta(\tau,c),\psi_{\left(c^k\right)}},v_{\Delta(\tau,c),\psi_{\left(c^k\right)}}\right)_{\Delta(\tau,c)}}{\left(v_{\Delta(\tau,c),\psi_{\left(c^k\right)}},v_{\Delta(\tau,c),\psi_{\left(c^k\right)}}\right)_{\Delta(\tau,c)}}.
$$

where  $g \in GL_{kc}(\mathbb{F})$ . It follows from the uniqueness property of the  $(k, c) \psi_{(c^k)}$ -Whittaker vector of  $\Delta(\tau, c)$  that this function is the unique function  $W \in \mathcal{W}$   $\Big(\Delta(\tau, c), \psi_{\binom{c^k}{c}}\Big)$  satisfying  $W(I_{kc}) = 1$  and  $W(gu) = \psi_{(c^k)}(u) W(g)$  for any  $g \in GL_{kc}(\mathbb{F})$  and any  $u \in N_{(c^k)}(\mathbb{F})$ .

By [\[7,](#page-39-6) Proposition 6.21], for any  $(k, c)$   $\psi$ -Whittaker vector  $v_{\Delta(\tau,c), \psi_{(c^k)}} \in \Delta(\tau, c)$  and any  $h \in GL_c(\mathbb{F})$ , we have that  $\Delta(\tau, c)$   $(\text{diag}^k(h)) v_{\Delta(\tau, c), \psi_{(c^k)}} = \omega_{\tau} (\text{det } h) v_{\Delta(\tau, c), \psi_{(c^k)}}$ , where  $\omega_{\tau}$  is the central character of  $\tau$  and

$$
\operatorname{diag}^{k}(h)=\operatorname{diag}(h,\ldots,h)\in\operatorname{GL}_{kc}(\mathbb{F}).
$$

This result is analogous to [\[4,](#page-39-3) Lemma 12]. It follows that for any  $W \in W(\Delta(\tau, c), \psi_{(c^k)})$  $\big),$ any  $g \in GL_{kc}(\mathbb{F})$  and any  $h \in GL_c(\mathbb{F})$ ,

$$
W\left(\mathrm{diag}^{k}\left(h\right)g\right)=\omega_{\tau}\left(\mathrm{det} h\right)W\left(g\right),\,
$$

and that

$$
\mathcal{BS}_{\Delta(\tau,c),\psi}\left(g\mathrm{diag}^{k}\left(h\right)\right)=\omega_{\tau}\left(\det h\right)\mathcal{BS}_{\Delta(\tau,c),\psi}\left(g\right).
$$

In particular it follows that the function  $\mathcal{BS}_{\Delta(\tau,c),\psi}$  is invariant under conjugation by elements of diag<sup>k</sup> (GL<sub>c</sub>( $\mathbb{F}$ )).

<span id="page-16-0"></span>3.2.  $(k, c)$   $\psi$ -Whittaker models of Speh representations over local fields. Similarly to Section [3.1,](#page-15-1) if F is a non-archimedean local field,  $\psi: F \to \mathbb{C}^{\times}$  is a non-trivial character, then we may define a character  $\psi_{(c^k)}: N_{(c^k)} \to \mathbb{C}^\times$  by the formula [\(14\)](#page-15-3).

As before, when  $c = 1$ , we omit the  $(k, c)$  from the notation and write  $\psi = \psi_{(1^k)}$ ,  $U_k(F) =$  $N_{(1^k)}(F).$ 

Let  $\mathcal T$  be an irreducible supercuspidal representation of  $GL_k(F)$ . It is well-known that  $\mathcal T$ is generic, that is, there exists a non-zero  $\psi$ -Whittaker functional<sup>[2](#page-16-1)</sup> for  $\mathcal{T}$ , i.e., an element  $0 \neq$  $\ell_{\mathcal{T},\psi} \in \text{Hom}_{U_k(F)}(\mathcal{T},\psi)$ . Moreover, it is well-known that such element is unique, up to scalar multiplication. By Frobenius reciprocity, there exists a unique subspace of  $\text{Ind}_{U_k(F)}^{\text{GL}_k(F)}(\psi)$  that is isomorphic to  $\mathcal T$ . This is *the*  $\psi$ -*Whittaker model of*  $\mathcal T$ , which we denote by  $\mathcal W(\mathcal T,\psi)$ .

In [\[4\]](#page-39-3) it was shown that the Speh representation  $\Delta(\mathcal{T}, c)$  is a representation of type  $(k, c)$ . In particular, this means that

$$
\dim \mathrm{Hom}_{N_{\left(c^{k}\right)}\left(F\right)}\left(\Delta\left(\mathcal{T},c\right),\psi_{\left(c^{k}\right)}\right)=1.
$$

We call a non-zero element in  $\mathrm{Hom}_{N_{(c^k)}(F)}\left(\Delta\left(\mathcal{T},c\right),\psi_{\left(c^k\right)}\right)$  $\Big)$  a  $(k, c)$   $\psi$ -*Whittaker functional*<sup>[2](#page-16-1)</sup>.

,

<span id="page-17-3"></span>As before, by Frobenius reciprocity there exists a unique subspace of  $\text{Ind}_{N_{(c^k)}}^{\text{GL}_{k_c}(F)}$  $\left(\psi_{\left(c^k\right)}\right)$  $\setminus$ that is isomorphic to  $\Delta(\mathcal{T}, c)$ . We denote this subspace by  $\mathcal{W}\left(\Delta(\mathcal{T}, c), \psi_{(c^k)}\right)$  , and call it the  $(k, c)$   $\psi$ -*Whittaker model of*  $\Delta(\mathcal{T}, c)$ .

$$
W\left(\mathrm{diag}^{k}\left(h\right)g\right) = \omega_{\mathcal{T}}\left(\mathrm{det}\,h\right) \cdot W\left(g\right),\,
$$

*where*  $\omega_{\tau}$  *is the central character of*  $\tau$  *and where* 

$$
\operatorname{diag}^{k}(h)=\operatorname{diag}(h,\ldots,h)\in\operatorname{GL}_{kc}(F).
$$

<span id="page-17-0"></span>3.3.  $(k, c)$   $\psi$ -Whittaker models of Speh representations of level zero representations. Let  $\tau$  and  $\mathcal T$  be as in Section [2.2.](#page-7-0) Let  $\psi: F \to \mathbb C^{\times}$  be an additive character with conductor **p**, i.e.,  $\psi$  is trivial on **p** but not on **o**. We also realize  $\psi$  as a character of  $\mathbb{F} = \mathfrak{o}/\mathfrak{p}$ . Let  $\ell_{\tau,\psi} : \tau \to \mathbb{C}$  be a  $\psi$ -Whittaker functional. A  $\psi$ -Whittaker functional  $\ell_{\tau,\psi} : \mathcal{T} \to \mathbb{C}$  is given by

$$
\langle f, \ell_{\mathcal{T}, \psi} \rangle = \int_{U_k(\mathfrak{o}) \setminus U_k(F)} \langle f(u), \ell_{\tau, \psi} \rangle \, \psi^{-1}(u) \, \mathrm{d}u,
$$

where the Haar measures are normalized such that  $U_k(\mathfrak{o})$  has volume 1. See [\[36,](#page-41-0) Proposition 3.7].

This allows us to lift Whittaker functions  $W \in \mathcal{W}(\tau, \psi)$  to  $\mathcal{L}(W) \in \mathcal{W}(\mathcal{T}, \psi)$  as follows. Any  $W \in \mathcal{W}(\tau, \psi)$  can be written as  $W(g) = W_{v_{\tau}}(g) = \langle \tau(g) v_{\tau}, \ell_{\tau, \psi} \rangle$ , where  $g \in GL_k(\mathbb{F})$ and  $v_{\tau} \in \tau$ . We define for  $g \in GL_k(F)$ ,

$$
\mathcal{L}(W)(g) = \mathcal{L}(W_{v_{\tau}})(g) = \langle \mathcal{T}(g) \mathcal{L}(v_{\tau}), \ell_{\mathcal{T},\psi} \rangle.
$$

<span id="page-17-1"></span>Wehave the following formula for  $\mathcal{L}(W)$  ([\[36,](#page-41-0) Proposition 3.9]).

**Proposition 3.2.** For any  $W \in \mathcal{W}(\tau, \psi)$ , the function  $\mathcal{L}(W) \in \mathcal{W}(\mathcal{T}, \psi)$  is supported on  $F^{\times} \cdot U_k(F) \cdot GL_k(\mathfrak{o})$  and satisfies

$$
\mathcal{L}(W)(zuk_0) = \omega_{\mathcal{T}}(z) \psi(u) W(\nu(k_0)),
$$

*for any*  $z \in F^{\times}$ ,  $u \in U_k$  *and*  $k_0 \in GL_k(\mathfrak{o})$ *.* 

Using the Whittaker functional  $\ell_{\mathcal{T},\psi}$ , we may construct a  $(k, c)$   $\psi$ -Whittaker functional for  $\Delta(\mathcal{T}, c)$ . This is a recursive process which is explained in [\[4,](#page-39-3) Section 2.4]. We recall this process now.

Let  $c = c_1 + c_2$  where  $0 < c_1, c_2 < c$  and suppose that we have already constructed  $(k, c_1)$  and  $(k, c_2)$   $\psi$ -Whittaker functionals  $\ell_{\Delta(\mathcal{T}, c_1)}$  and  $\ell_{\Delta(\mathcal{T}, c_2)}$  for  $\Delta(\mathcal{T}, c_1)$  and  $\Delta(\mathcal{T}, c_2)$ , respectively.

Let us realize  $\Delta(\mathcal{T}, c)$  as a subrepresentation of the parabolic induction  $|\det|^{-\frac{c_2}{2}} \Delta(\mathcal{T}, c_1) \times$  $|\text{det}|^{\frac{c_1}{2}} \Delta(\mathcal{T}, c_2).$ 

Let  $\kappa \in \mathfrak{S}_{kc}$  be the permutation

$$
\kappa (1 + a + bc) = \begin{cases} 1 + a + bc_1 & 0 \le a \le c_1 - 1, \\ 1 + a + c_1 k + bc_2 & c_1 \le a \le c_1 + c_2 - 1, \end{cases}
$$

<span id="page-18-5"></span>where  $0 \le a \le c-1$  and  $0 \le b \le k-1$ . Also denote by  $\kappa$  the column permutation matrix corresponding to  $\kappa$ , that is

where for every  $1 \leq j \leq kc$ ,  $te_j$  is the jth standard column vector. Suppose that R is either a ring or a fractional ideal of a ring. Let

By [\[4,](#page-39-3) Lemma 9] the functional  $\ell_{\Delta(\mathcal{T},c)} : \Delta(\mathcal{T}, c) \to \mathbb{C}$  defined by the formula

$$
\left\langle \Phi, \ell_{\Delta(\mathcal{T}, c)} \right\rangle = \int_{\mathcal{Y}(F)} \left\langle \Phi \left( y \kappa \right), \ell_{\Delta(\mathcal{T}, c_1)} \otimes \ell_{\Delta(\mathcal{T}, c_2)} \right\rangle dy \tag{17}
$$

is a non-zero  $(k, c)$   $\psi$ -Whittaker functional of  $\Delta(\mathcal{T}, c)$ .

By realizing  $\Delta(\tau, c)$  as a subrepresentation of the parabolic induction  $\Delta(\tau, c_1) \circ \Delta(\tau, c_2)$ , we form the exact same process over a finite field to obtain a non-zero  $(k, c)$   $\psi$ -Whittaker functional  $\ell_{\Delta(\tau,c)}$ :  $\Delta(\tau,c_1) \circ \Delta(\tau,c_2) \to \mathbb{C}$ , given by the recursive formula

$$
\left\langle \Phi, \ell_{\Delta(\tau,c)} \right\rangle = \frac{1}{|\mathcal{Y}(\mathbb{F})|} \sum_{y \in \mathcal{Y}(\mathbb{F})} \left\langle \Phi(y\kappa), \ell_{\Delta(\tau,c_1)} \otimes \ell_{\Delta(\tau,c_2)} \right\rangle.
$$

<span id="page-18-1"></span>For our applications, we will need to reduce the domain of integration in the formula for  $\ell_{\Delta(\mathcal{T},c)}$ . This is achieved by the method of root exchange (see Appendix [B\)](#page-36-0).

Proposition 3.3. For any  $\Phi \in \Delta$   $(\mathcal{T}, c) \subset |\det|^{-\frac{c_2}{2}} \Delta(\mathcal{T}, c_1) \times |\det|^{\frac{c_1}{2}} \Delta(\mathcal{T}, c_2)$ *, such that*  $\Phi$ *is right invariant under*  $I_{kc}$  + Mat<sub>kc</sub> ( $\mathfrak{p}^{r+1}$ ) *for*  $r \geq 0$ *, we have* 

$$
\left\langle \Phi, \ell_{\Delta(\mathcal{T},c)} \right\rangle = \int_{\mathcal{Y}(\varpi^{-r_{\mathfrak{0}}})} \left\langle \Phi \left( y \kappa \right), \ell_{\Delta(\mathcal{T},c_1)} \otimes \ell_{\Delta(\mathcal{T},c_2)} \right\rangle dy.
$$

For any  $f \in \Delta(\tau, c)$ , let  $W_f : GL_{kc}(\mathbb{F}) \to \mathbb{C}$  be the function

$$
W_f(g) = \left\langle \Delta \left( \tau, c \right) (g) f, \ell_{\Delta(\tau, c)} \right\rangle.
$$

Similarly, for any  $\Phi \in \Delta(\mathcal{T}, c)$ , let  $W_{\Phi}: GL_{kc}(F) \to \mathbb{C}$  be the function

$$
W_{\Phi}(g) = \left\langle \Delta\left(\mathcal{T}, c\right)(g) \Phi, \ell_{\Delta(\mathcal{T}, c)} \right\rangle.
$$

<span id="page-18-0"></span>Then we have the following relation.

**Proposition 3.4.** *Normalize the Haar measure on*  $\mathcal{Y}(F)$  *so that*  $\mathcal{Y}(\mathfrak{o})$  *has volume* 1*. Then for any*  $k_0 \in GL_{kc}(\mathfrak{o})$  *and any*  $f \in \Delta(\tau, c)$ *,* 

$$
W_{\mathcal{L}(f)}(k_0) = W_f(\nu(k_0)).
$$

*Proof.* The proof is by induction on c. If  $c = 1$  then the statement follows from Propo-sition [3.2.](#page-17-1) Otherwise, let  $c = c_1 + c_2$  where  $c_1, c_2 < c$ . Then by induction we have that for  $j = 1, 2$  and  $f_j \in \Delta(\tau, c_j)$  the equality  $W_{\mathcal{L}f_j}(I_{kc_j}) = W_{f_j}(I_{kc_j})$  holds, which implies that  $\langle f_j, \ell_{\Delta(\tau,c_j)} \rangle = \langle \mathcal{L} f_j, \ell_{\Delta(\tau,c_j)} \rangle$ . By Proposition [3.3,](#page-18-1) we may reduce the domain of in-tegration in [\(17\)](#page-18-2) to  $\mathcal{Y}(\mathfrak{o})$ . Since we normalized  $\mathcal{Y}(\mathfrak{o})$  to have volume 1, it follows that  $\langle \mathcal{L}f, \ell_{\Delta(\tau,c)} \rangle = \langle f, \ell_{\Delta(\tau,c)} \rangle$ . Finally, the proposition holds for general  $k_0 \in GL_{kc}(\mathfrak{o})$  because  $\Delta(\mathcal{T}, c)(k_0) \mathcal{L}f = \mathcal{L}(\Delta(\tau, c) (\nu(k_0)) f).$ 

As before, for  $W = W_f \in \mathcal{W} \left( \Delta \left( \tau, c \right), \psi_{\left( c^k \right)} \right)$ ), where  $f \in \Delta(\tau, c)$ , denote  $\mathcal{L}W = W_{\mathcal{L}f} \in$  $\mathcal{W}\left( \Delta\left(\mathcal{T},c\right),\psi _{\left(c^{k}\right)}\right)$ ). We will need knowledge of the behavior of  $\mathcal{L}W$  at elements of the form diag  $(h, I_{(k-1)c})$  and of the form diag  $(I_{(k-1)c}, h)$ , where  $h \in GL_c(F)$ . Using Propositions [3.1](#page-17-2) and [3.4](#page-18-0) and the Cartan decomposition, it suffices to know how to compute these values for diagonal h.

<span id="page-19-1"></span><span id="page-19-0"></span>**Proposition 3.5.** Let  $t = diag(t_1, ..., t_c)$  where  $t_1, ..., t_c \in F^{\times}$ .

<span id="page-19-2"></span>(1) If  $\mathcal{L}W$  (diag  $(t, I_{(k-1)c}) \neq 0$ , then  $|t_1|, \ldots, |t_c| \leq 1$ . Moreover, if  $k > c$ , then  $|t_1| =$  $\cdots = |t_c| = 1.$ (2) If  $\mathcal{L}W$  (diag  $(I_{(k-1)c}, t)$ )  $\neq 0$ , then  $|t_1|, \ldots, |t_c| \geq 1$ . Moreover, if  $k > c$  then  $|t_1| =$  $\cdots = |t_c| = 1.$ 

*Proof.* We only prove the first part. The second part is proved similarly.

If  $|t_i| > 1$  for some i, let  $u \in N_{(c^k)}$  be an element such that it has zeros everywhere outside of its diagonal except for its  $(i, i + c)$  entry, which is chosen to be  $t_i^{-1}$  $i^{-1}y$ , where  $y \in \mathfrak{o}^{\times}$  is an element such that  $\psi(y) \neq 1$ . Then since  $\mathcal{L}W$  is right invariant under  $1 + \text{Mat}_{kc}(\mathfrak{p})$ , we have

$$
\mathcal{L}W\left(\text{diag}\left(t, I_{(k-1)c}\right)u\right) = \mathcal{L}W\left(\text{diag}\left(t, I_{(k-1)c}\right)\right).
$$

On the other hand, we get from conjugation and the left  $(N_{(c^k)}, \psi_{(c^k)})$  -equivariance property that

$$
\mathcal{L}W\left(\text{diag}\left(t, I_{(k-1)c}\right)u\right) = \psi\left(y\right)\mathcal{L}W\left(\text{diag}\left(t, I_{(k-1)c}\right)\right).
$$

Thus we get that  $\mathcal{L}W$  vanishes on diag  $(t, I_{(k-1)c})$ .

Suppose that  $k > c$ . Assume first that t is dominant, i.e., that  $|t_1| \leq |t_2| \leq \cdots \leq |t_c|$ . Consider the functional

$$
\ell_t \colon \mathcal{W}\left(\Delta\left(\tau, c\right), \psi_{\left(c^k\right)}\right) \to \mathbb{C}
$$

defined by the formula

$$
\ell_t(W) = \mathcal{L}W\left(\text{diag}\left(t, I_{(k-1)c}\right)\right).
$$

Suppose that  $|t_i| < 1$  and  $|t_{i+1}| = 1$ . If  $u \in N_{(i,kc-i)}(\mathfrak{o})$ , we get by conjugation and the left  $\left(N_{(c^k)}, \psi_{(c^k)}\right)$ )-equivariance property and the fact that  $\psi$  is trivial on  $\mathfrak p$  that

$$
\mathcal{L}W\left(\text{diag}\left(t, I_{(k-1)c}\right)u\right) = \mathcal{L}W\left(\text{diag}\left(t, I_{(k-1)c}\right)\right).
$$

In particular, this implies that the functional  $\ell_t$  is invariant under right translations of  $N_{(i,kc-i)}(\mathbb{F})$ . It follows that

$$
\ell_t \in \mathrm{Hom}_{N_{(i,kc-i)}(\mathbb{F})}\left(\Delta(\tau,c),1\right).
$$

The last Hom-space is zero because otherwise there would be an irreducible cuspidal representation of  $GL_{c'}(\mathbb{F})$  for  $c' \leq i \leq c < k$  in the cuspidal support of  $\Delta(\tau, c)$ .

In the general case, let  $w \in GL_c(\mathbb{F})$  be a permutation matrix such that  $wtw^{-1}$  is dominant. Then by Proposition [3.1,](#page-17-2) we have

$$
\mathcal{L}W\left(\mathrm{diag}\left(t,I_{(k-1)c}\right)\right)=\omega_{\tau}^{-1}\left(\mathrm{det}\,w\right)\mathcal{L}W'\left(\mathrm{diag}\left(wtw^{-1},I_{(k-1)c}\right)\right),
$$

where  $W'\in\mathcal{W}\left(\Delta\left(\tau,c\right),\psi_{\left(c^{k}\right)}\right)$ is given by  $W' = \Delta(\tau, c)$  (diag<sup>k</sup> (w)) W. From the previous case we get  $|t_1| = \cdots = |t_c| = 1$ .

We will also need formulas for the special case  $k = c$ . In this case, the special values can be expressed in terms of functionals on the space  $\Delta(\tau, c)$ , realized as a subrepresentation of the parabolic induction  $\tau \circ \Delta (\tau, c - 1)$  (or of  $\Delta (\tau, c - 1) \circ \tau$ ). In the notation of Section [3.3](#page-17-0) and [\(17\)](#page-18-2), we take  $c_1 = 1$  and  $c_2 = c - 1$  (respectively,  $c_1 = c - 1$  and  $c_2 = 1$ ).

<span id="page-20-1"></span>**Theorem 3.6.** Suppose that  $\ell_{\Delta(\tau,c)}$  is constructed with respect to  $\ell_{\tau,\psi}$  and  $\ell_{\Delta(\tau,c-1)}$ *, and that*  $\ell_{\Delta(\mathcal{T},c)}$  is constructed with respect to  $\ell_{\mathcal{T},\psi}$  and  $\ell_{\Delta(\mathcal{T},c-1)}$ . Then for any  $t = \text{diag}(t_1,\ldots,t_c)$  $\text{diag}(\varpi^{i_1}, \ldots, \varpi^{i_c})$  *with*  $\max(i_j)_{j=1}^c \geq 1$  *and any*  $\Phi = \mathcal{L}f$  *for*  $f \in \Delta(\tau, c) \subset \tau \circ \Delta(\tau, c-1)$ *, we have that*  $W_{\Phi}$  (diag  $(t, I_{c(c-1)})$ ) *is zero unless*  $i_1 = \cdots = i_c = m \ge 1$ *, in which case* 

$$
W_{\Phi}\left(\text{diag}\left(t, I_{c(c-1)}\right)\right) = \omega_{\mathcal{T}}\left(\varpi\right)^{m} q^{-(m+1)(c-1)\binom{c}{2}} \left\langle f\left(I_{c^2}\right), S_0\right\rangle,
$$

*where*  $S_0$  *is the functional on*  $\tau \otimes \Delta(\tau, c-1)$ *, given by* 

$$
\langle v_{\tau} \otimes f_{\Delta(\tau,c-1)}, S_0 \rangle = \sum_{g \in \mathrm{GL}_{c-1}(\mathbb{F})} \sum_{y \in \mathcal{Y}_{1,c-1}(\mathbb{F})} \left\langle \tau \begin{pmatrix} 1 & & \\ & -g^{-1} \end{pmatrix} v_{\tau}, \ell_{\tau,\psi} \right\rangle
$$

$$
\times \left\langle \Delta(\tau,c-1) \left( \begin{pmatrix} g & & \\ & I_{(c-1)^2} \end{pmatrix} y \kappa_{1,c-1} \right) f_{\Delta(\tau,c-1)}, \ell_{\Delta(\tau,c-1)} \right\rangle,
$$

*where*  $\mathcal{Y}_{1,c-1}$  *is the group in* [\(16\)](#page-18-3) *for*  $c_1 = 1$  *and*  $c_2 = c - 1$  *and*  $k = c - 1$ *, and where*  $\kappa_{1,c-1}$ *is the element from* [\(15\)](#page-18-4) *corresponding to same parameters.*

<span id="page-20-0"></span>We have the following similar result for elements of the form diag  $(I_{(k-1)c}, t)$ .

**Theorem 3.7.** Suppose that  $\ell_{\Delta(\tau,c)}$  is constructed with respect to  $\ell_{\Delta(\tau,c-1)}$  and  $\ell_{\tau,\psi}$ , and that  $\ell_{\Delta(\mathcal{T},c)}$  is constructed with respect to  $\ell_{\Delta(\mathcal{T},c-1)}$  and  $\ell_{\mathcal{T},\psi}$ . Then for any  $t = \text{diag}(t_1,\ldots,t_c)$  $\text{diag}(\varpi^{i_1},\ldots,\varpi^{i_c})$  with  $\min(i_j)_{j=1}^c \leq -1$  and any  $\Phi = \mathcal{L}f$  for  $f \in \Delta(\tau,c)$ , we have that  $W_{\Phi}$  (diag  $(I_{c(c-1)}, t)$ ) *is zero unless*  $i_1 = \cdots = i_c = -m \leq -1$ *, in which case* 

$$
W_{\Phi}\left(\mathrm{diag}\left(I_{c(c-1)},t\right)\right)=\omega_{\mathcal{T}}\left(\varpi\right)^{-m}q^{-\left(m+1\right)(c-1)\binom{c}{2}}\left\langle f\left(I_{c^2}\right),S_0^*\right\rangle,
$$

*where*  $S_0^*$  *is the functional on*  $\Delta(\tau, c - 1) \otimes \tau$ *, given by* 

$$
\langle f_{\Delta(\tau,c-1)} \otimes v_{\tau}, S_0^* \rangle
$$
  
= 
$$
\sum_{g \in \mathrm{GL}_{c-1}(\mathbb{F})} \sum_{y \in \mathcal{Y}_{c-1,1}(\mathbb{F})} \left\langle \Delta(\tau,c-1) \left( \begin{pmatrix} I_{(c-1)^2} & \\ & -g^{-1} \end{pmatrix} y \kappa_{c-1,1} \right) f_{\Delta(\tau,c-1)}, \ell_{\Delta(\tau,c-1)} \right\rangle
$$
  
  $\times \left\langle \tau \begin{pmatrix} g \\ & 1 \end{pmatrix} v_{\tau}, \ell_{\tau,\psi} \right\rangle$ ,

*where*  $\mathcal{Y}_{c-1,1}$  *is the group in* [\(16\)](#page-18-3) *for*  $c_1 = c - 1$  *and*  $c_2 = 1$  *and*  $k = c - 1$ *, and where*  $\kappa_{c-1,1}$ *is the element from* [\(15\)](#page-18-4) *corresponding to same parameters.*

3.3.1. *Proof of the formula for*  $k = c$ . The goal of this section is to prove Theorem [3.6.](#page-20-1) The proof of Theorem [3.7](#page-20-0) is very similar and we omit it.

Suppose that  $k = c$ . Let  $f \in \Delta(\tau, c)$  and let  $t = diag(t_1, \ldots, t_c) = diag(\varpi^{i_1}, \ldots, \varpi^{i_c}),$ where  $i_1, \ldots, i_c \geq 0$  and  $\max(i_1, \ldots, i_c) > 0$ . As explained in the proof of Proposition [3.5,](#page-19-0) we may assume that  $i_1 \geq \cdots \geq i_c \geq 0$  and therefore  $i_1 > 0$ . Set  $\Phi = \mathcal{L}f$  and  $\Phi_t =$  $\Delta(\tau, c)$  (diag  $(t, I_{(c-1)c})$ )  $\Phi$ . We are interested in computing  $\langle \Phi_t, \ell_{\Delta(\mathcal{T}, c)} \rangle$ . We will realize  $\Delta(\mathcal{T}, c)$  as a subspace of the parabolic induction  $|\det|^{-\frac{c-1}{2}} \mathcal{T} \times |\det|^{\frac{1}{2}} \Delta(\mathcal{T}, c-1)$  and will use the recursive formula [\(17\)](#page-18-2) with  $c_1 = 1$  and  $c_2 = c - 1$ .

This proof is quite technical and requires work. We describe the process and postpone a technical lemma to later. Throughout the proof, all Haar measures are normalized so that the compact subgroups  $GL_k(\mathfrak{o}) \subset GL_k(F)$  and  $\mathrm{Mat}_k(\mathfrak{o}) \subset \mathrm{Mat}_k(F)$  have volume 1, for any k.

Notice that  $\Phi_t$  is invariant under right translations of

diag 
$$
(t, I_{c(c-1)}) (I_{c^2} + \text{Mat}_{c^2}(\mathfrak{p}))
$$
diag  $(t, I_{c(c-1)})^{-1}$ ,

and in particular is invariant under right translations of  $I_{c^2}+t_1 \text{ Mat}_{c^2}(\mathfrak{p})$ . By Proposition [3.3,](#page-18-1) we have that

$$
\left\langle \Phi_t, \ell_{\Delta(\mathcal{T},c)} \right\rangle = \int_{\mathcal{Y}(t_1^{-1}\mathfrak{o})} \left\langle \Phi_t \left( y \kappa \right), \ell_{\mathcal{T},\psi} \otimes \ell_{\Delta(\mathcal{T},c-1)} \right\rangle \mathrm{d}y.
$$

We have that  $\Phi_t(y\kappa) = \Phi(y\kappa \text{diag}(t, I_{(c-1)c}))$  and that

$$
y\kappa \mathrm{diag}\left(t, I_{(c-1)c}\right) = \mathrm{diag}\left(t_1 I_c, I_{c(c-1)}\right) y'\kappa,
$$

where  $y'$  is a matrix of the form

$$
y' = \begin{pmatrix} 1 & t_1^{-1} I_{c-1} & & \\ t_1^{-1} Y_1 & t' & \\ t_1^{-1} Y' & I_{(c-1)^2} \end{pmatrix},\tag{18}
$$

where  $t' = \text{diag}(t_2, \ldots, t_c), Y_1 \in \text{Mat}_{c-1}(\mathfrak{o})$  and

$$
Y' = \begin{pmatrix} 0 & y_{23} & y_{24} & \dots & y_{2c} \\ & 0 & y_{34} & \dots & y_{3c} \\ & & \ddots & \ddots & \vdots \\ & & & 0 & y_{c-1,c} \\ & & & & 0 \end{pmatrix},
$$

where  $y_{ij} \in Mat_{(c-1)\times 1}(\mathfrak{o})$ . We have

$$
\langle \Phi_t, \ell_{\Delta(\mathcal{T}, c)} \rangle = |t_1|^{-\binom{c}{2}(c-1)} |t_1|^{\frac{(c-1)^2 c}{2}} \omega_{\mathcal{T}}(t_1) \int_{\text{Mat}_{c-1}(\mathfrak{o})} dY_1 \int_{\text{Mat}_{(c-1)\times 1}(\mathfrak{o})} \left( \ell_{\geq 1}^{-1} \right) dY' \tag{19}
$$
\n
$$
\times \langle \Phi(y' \kappa), \ell_{\mathcal{T}, \psi} \otimes \ell_{\Delta(\mathcal{T}, c-1)} \rangle.
$$

We will investigate the integrand of [\(19\)](#page-22-0):

<span id="page-22-1"></span>
$$
\langle \Phi(y'\kappa), \ell_{\mathcal{T},\psi} \otimes \ell_{\Delta(\mathcal{T},c-1)} \rangle. \tag{20}
$$

<span id="page-22-3"></span>The following lemma allows us to reduce the integration domain of  $Y_1$ .

Lemma 3.8. *Let* y ′ *be as in* [\(18\)](#page-21-0)*. Suppose that the expression* [\(20\)](#page-22-1) *is non-zero. Then there exists*  $k_1 \in GL_{c-1}(\mathfrak{o})$  *such that*  $Y_1 = t' \cdot k_1$ *.* 

We postpone the proof of this lemma to later.

It follows that we may write  $Y_1 = t' k_1$  and replace the integration over  $Y_1$  with an integration over  $k_1 \in GL_{c-1}(\mathfrak{o})$  in [\(19\)](#page-22-0) with  $dY_1 = det' l'^{-1} d^* k_1$ , where we also multiply by  $|\mathrm{GL}_{c-1}(\mathbb{F})|$  $\frac{|GL_{c-1}(\mathbb{F})|}{|Mat_{c-1}(\mathbb{F})|}$  in order to correct the volume. We write the following decomposition of y', where the first matrix lies in  $P_{(c,c(c-1))}$  and the other two matrices lie in  $GL_{c^2}(\mathfrak{o})$ .

$$
y' = \begin{pmatrix} 1 & & & & \\ & I_{c-1} & t_1^{-1}k_1^{-1} & & \\ & & t_1^{-1}t' & & \\ & & & t_1^{-1}Y'k_1^{-1} & I_{(c-1)^2} \end{pmatrix} \begin{pmatrix} 1 & & & & \\ & I_{c-1} & & & \\ & & I_{c-1} & & \\ & & Y' & & I_{(c-1)^2} \end{pmatrix} \begin{pmatrix} 1 & & & & \\ & -k_1^{-1} & & & \\ & k_1 & t_1I_{c-1} & & \\ & & & I_{(c-1)^2} \end{pmatrix}.
$$

Hence, we have

<span id="page-22-2"></span>
$$
\Phi(y'\kappa) = \left| t_1^{-(c-1)} \det t' \right|^{-\frac{c-1}{2}} \operatorname{id}_{\mathcal{T}} \otimes \Delta(\mathcal{T}, c-1) \begin{pmatrix} t_1^{-1}t' \\ t_1^{-1}Y'k_1^{-1} & I_{(c-1)^2} \end{pmatrix}
$$

$$
\times \Phi\left( \begin{pmatrix} 1 & & \\ & I_{c-1} & \\ & & Y' & I_{(c-1)^2} \end{pmatrix} \operatorname{diag} \left( 1, \begin{pmatrix} & -k_1^{-1} \\ k_1 & \end{pmatrix}, I_{(c-1)^2} \right) \kappa \right). \tag{21}
$$

Using  $(21)$  and the method of root exchange, we are able to reduce the integration over Y' in [\(19\)](#page-22-0). This is described in the following lemma. Its proof is very similar to Proposition [3.3,](#page-18-1) and we omit it.

Lemma 3.9. *The integral*

$$
\int_{\operatorname{GL}_{c-1}(\mathfrak o)} \int_{\operatorname{Mat}_{(c-1)\times 1}(\mathfrak o)} \langle e^{-1}_{2}\rangle \left\langle \Phi\left(y'\kappa\right), \ell_{\mathcal T,\psi} \otimes \ell_{\Delta(\mathcal T,c-1)} \right\rangle {\rm d}Y' {\rm d}^{\times} Y_1
$$

*equals the integral*

$$
\int_{\operatorname{GL}_{c-1}(\mathfrak{o})} \int_{t_1 \cdot \operatorname{Mat}_{(c-1)\times 1}(\mathfrak{o})}{c_{2} \choose 2} \langle \Phi\left(y'\kappa\right), \ell_{\mathcal{T}, \psi} \otimes \ell_{\Delta(\mathcal{T}, c-1)} \rangle \, \mathrm{d}Y' \mathrm{d}^{\times} Y_1.
$$

It follows that we may assume  $Y' = t_1 Y_1'$ , where  $Y_1' \in Mat_{(c-1)\times 1}(\mathfrak{o})^{c-1 \choose 2}$  with  $dY' =$  $|t_1|^{(c-1)\binom{c-1}{2}} dY'_1$ . Let us denote

$$
k_0 = \begin{pmatrix} 1 & & & \\ & I_{c-1} & & \\ & & I_{c-1} & \\ & & Y'_1 k_1^{-1} & I_{(c-1)^2} \end{pmatrix} \begin{pmatrix} 1 & & & \\ & k_1 & & \\ & k_1 & & \\ & & I_{(c-1)^2} \end{pmatrix} \kappa \in \mathrm{GL}_{c^2}(\mathfrak{o}) \, .
$$

Notice that [\(20\)](#page-22-1) is the same as

<span id="page-23-0"></span>
$$
\left| t_1^{-(c-1)} \det t' \right|^{-\frac{c-1}{2}} \left\langle \mathrm{id}_{\mathcal{T}} \otimes \Delta \left( \mathcal{T}, c-1 \right) \begin{pmatrix} t_1^{-1} t' & \\ & I_{(c-1)^2} \end{pmatrix} \Phi \left( k_0 \right), \ell_{\mathcal{T}, \psi} \otimes \ell_{\Delta(\mathcal{T}, c-1)} \right\rangle. \tag{22}
$$

By Proposition [3.5](#page-19-0) part [1,](#page-19-1) we have that [\(22\)](#page-23-0) is zero unless  $|t_1| = |t_j|$  for every j. Hence, we must have  $t' = t_1 I_{c-1}$ .

Since  $Y'_1 \in Mat_{(c-1)^2 \times (c-1)}(\mathfrak{o})$ , using the identity

$$
\operatorname{diag}\left(1,\begin{pmatrix}I_{c-1}\\I_{c-1}\end{pmatrix},I_{(c-1)^2}\right)\cdot\kappa=\operatorname{diag}\left(I_c,\kappa_{1,c-1}\right),\,
$$

the integral [\(19\)](#page-22-0) becomes

$$
\frac{|\mathrm{GL}_{c-1}(\mathbb{F})|}{|\mathrm{Mat}_{(c-1)}(\mathbb{F})|} \omega_{\mathcal{T}}(t_1) |t_1|^{(c-1)^2} |t_1|^{(c-1)\binom{c-1}{2}} \int_{\mathrm{GL}_{c-1}(\mathfrak{o})} d^{\times} k_1 \cdot \int_{\mathrm{Mat}_{(c-1)\times 1}(\mathfrak{o})} \left(\frac{c-1}{2}\right) dY'_1
$$
  
\$\times \left\langle \mathcal{T}\begin{pmatrix} 1 & & \\ & -k\_1^{-1} \end{pmatrix} \otimes \Delta(\mathcal{T}, c-1) \left( \begin{pmatrix} k\_1 & & \\ Y'\_1 & I\_{(c-1)^2} \end{pmatrix} \kappa\_{1,c-1} \right) \Phi(I\_{c^2}), \ell\_{\mathcal{T},\psi} \otimes \ell\_{\Delta(\mathcal{T}, c-1)} \right\rangle\$.

Since  $\Phi = \mathcal{L}f$ , the last integral becomes the finite sum

$$
\omega_{\mathcal{T}}(t_1) |t_1|^{(c-1)\binom{c}{2}} \frac{1}{|\text{Mat}_{c-1}(\mathbb{F})|} \frac{1}{|\text{Mat}_{(c-1)\times 1}(\mathbb{F})|^{(\binom{c-1}{2})}} \sum_{g \in \text{GL}_{c-1}(\mathbb{F})} \sum_{Y \in \text{Mat}_{(c-1)\times 1}(\mathbb{F})} {c-1 \choose 2}
$$
  
 
$$
\times \left\langle \tau \begin{pmatrix} 1 & & \\ & -g^{-1} \end{pmatrix} \otimes \Delta(\tau, c-1) \left( \begin{pmatrix} g & & \\ Y & I_{(c-1)^2} \end{pmatrix} \kappa_{1,c-1} \right) f(I_{c^2}), \ell_{\tau,\psi} \otimes \ell_{\Delta(\tau,c-1)} \right\rangle,
$$
 as required.

We move to prove Lemma [3.8.](#page-22-3)

*Proof.* We start with finding a decomposition of the matrix y'. Let  $(t')^{-1}Y_1 = k_1 a k_2$ , be a Cartan decomposition, that is,  $k_1, k_2 \in GL_{c-1}(\mathfrak{o})$  and  $a = diag(\varpi^{m_1}, \ldots, \varpi^{m_{c-1}})$  with  $m_1 \geq m_2 \geq \cdots \geq m_{c-1}$ . We write

$$
y' = \text{diag}\left(1, k_2^{-1}, t' k_1, I_{(c-1)^2}\right) \begin{pmatrix} 1 & & & \\ & t_1^{-1} I_{c-1} & & \\ & & t_1^{-1} x'' & & \\ & & & t_1^{-1} Y'' \end{pmatrix} \text{diag}\left(1, k_2, k_1^{-1}, I_{(c-1)^2}\right), \quad (23)
$$

<span id="page-24-0"></span>where  $Y'' = Y' k_2^{-1}$ . Hence,

$$
\Phi(y') = \mathcal{T} \left( \text{diag} \left( 1, k_2^{-1} \right) \right) \otimes \Delta \left( \mathcal{T}, c - 1 \right) \left( \text{diag} \left( t' k_1, I_{(c-1)^2} \right) \right) \times \Phi \left( \begin{pmatrix} 1 & & & \\ & t_1^{-1} I_{c-1} & & \\ & & t_1^{-1} a & I_{c-1} \\ & & & t_1^{-1} Y'' & I_{(c-1)^2} \end{pmatrix} \text{diag} \left( 1, k_2, k_1^{-1}, I_{(c-1)^2} \right) \right).
$$
\n(24)

Assume first that  $(t_1^{-1}a)^{-1} \in Mat_{(c-1)}(\mathfrak{o})$ , that is,  $|t_1| \leq q^{-m_j}$  for all j. Then we have that the first matrix on the second line of [\(24\)](#page-24-0) can be decomposed as

\begin{pmatrix} 1 & & & & \\ & -a^{-1} & t_1^{-1}I_{c-1} & & \\ & & t_1^{-1}a & & \\ & & & t_1^{-1}Y'' & I_{(c-1)^2} \end{pmatrix} \begin{pmatrix} 1 & & & & \\ & I_{c-1} & & & \\ & & I_{c-1} & & \\ & & -Y''a^{-1} & & \\ & & & I_{(c-1)^2} \end{pmatrix} \begin{pmatrix} 1 & & & & \\ & & I_{c-1} & & \\ & & I_{c-1} & t_1a^{-1} & \\ & & & I_{(c-1)^2} \end{pmatrix} .
$$
\n
$$
(25)
$$

The first matrix in [\(25\)](#page-24-1) lies in  $P_{(c,(c-1)c)}$ . By our assumption, the third matrix in (25) lies in  $GL_{c^2}(\mathfrak{o})$ . A root exchange algorithm (see Appendix [B\)](#page-36-0) shows that if  $-Y''a^{-1}$  is not in  $\mathrm{Mat}_{(c-1)^2 \times c-1}(\mathfrak{o})$ , then for any for any  $\Phi' \in \Delta(\mathcal{T}, c) \subset |\det|^{-\frac{c-1}{2}} \mathcal{T} \times |\det|^{\frac{1}{2}} \Delta(\mathcal{T}, c-1)$  that is right invariant under  $I_{kc} + \text{Mat}_{kc}(\mathfrak{p})$ , the following expression is zero

This is proved by writing for  $2 \leq i \leq c-1$ ,

$$
\Phi'(g) = \frac{1}{\text{Vol}(\text{Mat}_{c-1}(\mathfrak{p}))} \int_{\text{Mat}_{c-1}(\mathfrak{p})} \Phi'(gr_i^*(x)) \, dx,
$$

where for  $x \in Mat_{c-1}(F)$ ,  $r_i^*(x) = diag\left(I_c, I_{(i-1)(c-1)},\right)$  $\int I_{c-1}$  x  $I_{c-1}$  $\bigg)$ ,  $I_{(c-i-1)(c-1)}$  and by using the fact that  $\ell_{\Delta(\mathcal{T},c-1)}$  is a  $(c, c-1) \psi$ -Whittaker functional. We start with  $i = c - 1$ and end with  $i = 2$  in this process (notice that the last  $(c - 1)$  rows of  $-Y''a^{-1}$  are zero). Hence it follows that [\(24\)](#page-24-0) amounts to an expression of the form

$$
\left\langle \mathcal{T}\begin{pmatrix}1&\\&-k_2^{-1}a^{-1}\end{pmatrix}\otimes\Delta\left(\mathcal{T},c-1\right)\begin{pmatrix}t_1^{-1}t'k_1a\\t_1^{-1}Y''&I_{(c-1)^2}\end{pmatrix}\mathcal{L}v_{\tau^{\otimes c}},\ell_{\mathcal{T},\psi}\otimes\ell_{\Delta(\mathcal{T},c-1)}\right\rangle,
$$

where  $v_{\tau^{\otimes c}} \in \tau^{\otimes c}$ . By Proposition [3.2,](#page-17-1) we have that this expression is zero unless  $\sqrt{1}$  $-k_2^{-1}a^{-1}$  $\setminus$  $\in F^{\times} \cdot U_{c} \cdot GL_{k}(\mathfrak{o})$ , which by the Iwasawa decomposition implies that  $a = I_{c-1}$ , which implies that  $Y_1 = t' k_1 k_2$ , as required.

We now move to the general case.  $^+$  = diag  $(\varpi^{m_1}, \ldots, \varpi^{m_r})$  and  $a^- = \text{diag}(\varpi^{m_{r+1}}, \dots, \varpi^{m_{c-1}})$  where the  $m_j$ 's in  $a^+$  satisfy  $q^{-m_j} < |t_1|$ , while the  $m_j$ 's in  $a^-$  satisfy  $q^{-m_j} \geq |t_1|$ . Write  $Y'' = (Y''_+, Y''_-)$ , where  $Y''_+ \in Mat_{(c-1)^2 \times r}(\mathfrak{o})$  and  $Y''_$  ∈ Mat<sub>(c-1)</sub><sup>2</sup>×(c-r-1) (o). We may decompose the first matrix on the second line of [\(24\)](#page-24-0) as

$$
\begin{pmatrix}\n1 & t_1^{-1}I_r & & & & & \\
 & - (a^-)^{-1} & t_1^{-1}I_{c-r-1} & & \\
 & & I_r & & & \\
 & & t_1^{-1}Y''_+ & -Y''_-(a^-)^{-1} & t_1^{-1}Y''_-\n\end{pmatrix}\n\begin{pmatrix}\n1 & & & & \\
 & I_r & & & \\
 & I_r & & & \\
 & & I_r & \\
 & & & I_{c-r-1} & \\
 & & & & I_{c-r-1} \\
 & & & & & & & I_{c-r-1}\n\end{pmatrix}, I_{(c-1)^2}.\n\tag{27}
$$

<span id="page-25-0"></span>Denote the matrix on the first row of  $(27)$  by  $y'$ . Notice that the two other matrices in  $(27)$ lie in  $GL_{c^2}(\mathfrak{o})$ . Hence, to determine whether [\(20\)](#page-22-1) vanishes, it suffices to check whether the similar expression, in which we replace  $y' \kappa$  with diag  $(1, k_2^{-1}, t' k_1, I_{(c-1)^2}) y'$ , vanishes. We proceed by decomposing  $y'_{-}$ . Let  $Y''_{+} = k'_1 a'_0 k'_2$ , where  $k'_1 \in \text{GL}_{(c-1)^2}(\mathfrak{o}), k'_2 \in \text{GL}_r(\mathfrak{o})$ , and

$$
a'_0 = \begin{pmatrix} a' \\ 0_{\left((c-1)^2 - r\right) \times r} \end{pmatrix},
$$

with  $a' = \text{diag}(\varpi^{m'_1}, \ldots, \varpi^{m'_r}),$  where  $\infty \geq m'_1 \geq \cdots \geq m'_r \geq 0$ . As before, we write  $y'_{-}$  as

As before, let  $a'_{+} = \text{diag}(\varpi^{m'_{1}}, \ldots, \varpi^{m'_{r'}})$  and  $a'_{-} = \text{diag}(\varpi^{m'_{r'+1}}, \ldots, \varpi^{m'_{r}})$ , where all the  $m'_j$ s in  $a'_+$  satisfy  $q^{-m'_j} < |t_1|$ , while all the  $m'_j$ s in  $a'_-$  satisfy  $q^{-m'_j} \geq |t_1|$ . Notice that if  $r \geq 1$ then  $r' \geq 1$ . This is because the rank of  $Y''_{-}$  is at most  $c-2$ , which implies that  $m'_1 = \infty$ . Write

$$
(k'_1)^{-1} Y''_-=\begin{pmatrix} Z_1 \\ Z_2 \\ Z_3 \end{pmatrix}
$$

where  $Z_1 \in \text{Mat}_{r' \times (c-r-1)}(F)$ ,  $Z_2 \in \text{Mat}_{(r-r') \times (c-r-1)}(F)$  and  $Z_3 \in \text{Mat}_{((c-1)^2-r) \times (c-r-1)}(F)$ . We may write the second matrix in [\(28\)](#page-25-1) in the following form:

Notice that the matrix appearing on the second row of [\(29\)](#page-26-0) lies in  $GL_{c^2}(\mathfrak{o})$ . Let

$$
\begin{pmatrix}\n-(a^-)^{-1} & t_1^{-1}I_{c-r-1} \\
I_r & t_1^{-1}a^- \\
-Z_1(t_1^{-1}a^-)^{-1} & Z_1 & t_1I_{r'} \\
-Z_2(t_1^{-1}a^-)^{-1} & Z_2 & a'_- \\
-Z_3(t_1^{-1}a^-)^{-1} & Z_3 & t_1I_{(c-1)^2-r}\n\end{pmatrix} = \begin{pmatrix}\nb'_{c-1-r} & X \\
b'_{c(-1)} & b'_{c(-1)}\n\end{pmatrix} k'_0
$$

be an Iwasawa decomposition, where  $b'_{c-1-r} \in GL_{c-1-r}(F)$  and  $b'_{c(c-1)} \in GL_{c(c-1)}(F)$  are upper triangular matrices,  $X \in Mat_{(c-1-r)\times c(c-1)}(F)$ , and  $k'_0 \in GL_{c^2-r-1}(\mathfrak{o})$ . We have that

$$
\Phi(y'\kappa) = |\det b_1|^{\frac{(c-1)^2}{2}} |\det b_{c-1}|^{-\frac{c-1}{2}} \mathcal{T}(b_1) \otimes \Delta(\mathcal{T}, c-1) (\operatorname{diag}(t', I_{(c-1)^2}) b_{c-1}) \Phi(k_0),
$$

where

$$
b_1 = \text{diag}\left(1, k_2^{-1}\right) \cdot \text{diag}\left(1, \left(k_2'\right)^{-1}, I_{c-r-1}\right) \cdot \text{diag}\left(1, t_1^{-1}I_{r'}, -\left(a'_-\right)^{-1}, b'_{c-1-r}\right),
$$
  

$$
b_{c-1} = \text{diag}\left(t'k_1, I_{(c-1)^2}\right) \cdot \text{diag}\left(I_{c-1}, t_1^{-1}k_1'\right) \cdot b'_{c(c-1)},
$$

and  $k_0 \in GL_{c^2}(\mathfrak{o})$ . Since  $k_0 \in GL_{c^2}(\mathfrak{o})$ ,  $\Phi(k_0) = \mathcal{L}\left(v_{\tau \otimes \Delta(\tau,c-1)}\right)$ , for some  $v_{\tau \otimes \Delta(\tau,c-1)} \in$  $\tau \otimes \Delta(\tau, c-1)$ . By Proposition [3.2,](#page-17-1) in order for  $\langle \Phi(y'\kappa), \ell_{\tau,\psi} \otimes \ell_{\Delta(\tau,c)} \rangle$  not to vanish, we must have  $b_1 \in F^{\times} \cdot U_c \cdot GL_c(\mathfrak{o})$ , which by the Iwasawa decomposition implies that

diag 
$$
(1, t_1^{-1}I_{r'}, -(a'_-)^{-1}, d'_{c-1-r}) \in GL_c(\mathfrak{o}),
$$

where  $d'_{c-1-r}$  is the diagonal part of  $b'_{c-1-r}$ . Since  $|t_1| < 1$ , we must have  $r' = 0$ , which implies that  $r = 0$ . Therefore,  $a = a^{-}$  and we are in the first case.

### 4. Gamma factors

This section is devoted to explaining the notion of the Ginzburg–Kaplan gamma factor in the context of finite fields and of non-archimedean local fields, and to establishing a relation between these two definitions of gamma factors.

<span id="page-27-1"></span>4.1. Ginzburg–Kaplan gamma factors for finite general linear groups. We recall the definition and properties of the Ginzburg–Kaplan gamma factor defined by Carmon and the author in  $[8]$ . This is a finite field analog of a construction given by Kaplan in  $[6,$  Appendix A] and [\[22\]](#page-40-1), whose global counterpart was given by Ginzburg [\[12\]](#page-40-0).

Let  $\tau$  be an irreducible cuspidal<sup>[3](#page-27-2)</sup> representation of  $GL_k(\mathbb{F})$ . For any positive integer c and any  $h \in GL_c(\mathbb{F})$ , let

$$
\mathcal{K}_{\tau,\psi}\left(h\right) = \mathcal{BS}_{\Delta\left(\tau,c\right),\psi} \left(\begin{matrix} & I_{(k-1)c} \\ h & \end{matrix}\right).
$$

Notice that the notation  $\mathcal{K}_{\tau,\psi}(h)$  does not include the parameters k and c. These parameters should be inferred from  $\tau$  and h, respectively. By the discussion at the end of Section [3.1,](#page-15-1) it follows that the assignment  $GL_c(\mathbb{F}) \to \mathbb{C}$  given by  $h \mapsto \mathcal{K}_{\tau,\psi}(h)$  is a class function of  $GL_c(\mathbb{F})$ , that is, it is invariant under  $GL_c(\mathbb{F})$ -conjugation. Let  $\pi$  be an irreducible representation of  $GL<sub>c</sub>(\mathbb{F})$ , and consider the operator

$$
\mathcal{G}(\pi \times \tau, \psi) = q^{\frac{(k-2)c^2}{2}} \sum_{h \in \mathrm{GL}_c(\mathbb{F})} \mathcal{K}_{\tau, \psi}(h) \pi(h).
$$

Since  $h \mapsto \mathcal{K}_{\tau,\psi}(h)$  is a class function, we have that  $\mathcal{G} (\pi \times \tau, \psi)$  is an element of Hom<sub>GLc</sub>(F)  $(\pi, \pi)$ . Since  $\pi$  is irreducible, by Schur's lemma there exists a scalar  $\Gamma^{\rm GK}\left(\pi\times\tau,\psi\right)\in\mathbb{C}$  such that  $\mathcal{G}\left(\pi\times\tau,\psi\right)=\Gamma^{\rm GK}\left(\pi\times\tau,\psi\right)\cdot\mathrm{id}_{\pi}$ . We call  $\Gamma^{\rm GK}\left(\pi\times\tau,\psi\right)$  the *Ginzburg–Kaplan gamma factor associated to*  $\pi$  *and*  $\tau$ *, with respect to*  $\psi$ *.* We denote

$$
\gamma^{\text{GK}}(\pi \times \tau, \psi) = \omega_{\pi}(-1)^{k-1} \cdot \Gamma^{\text{GK}}(\pi \times \tau, \psi),
$$

where  $\omega_{\pi}$  is the central character of  $\pi$ .

In [\[8\]](#page-39-1), Carmon and the author studied the Ginzburg–Kaplan gamma factor. They showed that this gamma factor is multiplicative and that it fits into a functional equation. They used these results to show that  $\mathcal{K}_{\tau,\psi}$  is expressible in terms of exotic matrix Kloosterman sums. The proof of the relation to exotic matrix Kloosterman sums relies on an identity (Theorem [4.10\)](#page-35-0) that follows from a local argument that we will establish in this paper.

<span id="page-27-3"></span>4.1.1. *Kaplan's functional equation.* Let  $\pi$  and  $\tau$  be as above. Define for any  $W \in$  $\mathcal{W}\left( \Delta\left(\tau,c\right),\psi_{\left(c^{k}\right)}\right)$ the following *zeta operators* on the space  $\pi$ :

$$
Z(W, \pi \times \tau) = \frac{1}{|\mathrm{GL}_c(\mathbb{F})|} \sum_{h \in \mathrm{GL}_c(\mathbb{F})} W\begin{pmatrix} h \\ I_{(k-1)c} \end{pmatrix} \pi(h)
$$

and

$$
Z^*(W, \pi \times \tau) = q^{-\frac{(k-2)c^2}{2}} \frac{1}{|\mathrm{GL}_c(\mathbb{F})|} \sum_{h \in \mathrm{GL}_c(\mathbb{F})} \sum_{X \in \mathrm{Mat}_{c \times (k-2)c}(\mathbb{F})} W \begin{pmatrix} I_c & & \\ & I_{(k-2)c} \\ & & X \end{pmatrix}.
$$

<span id="page-27-2"></span> ${}^{3}\text{In}$  [\[8\]](#page-39-1), the authors define this notion for any irreducible generic  $\tau$ , but for our purposes, we only need to consider cuspidal  $\tau$ .

<span id="page-28-2"></span>These are the operators  $\frac{1}{|\mathrm{GL}_c(\mathbb{F})|} Z_{k-2}(W, \pi \times \tau)$  and  $\frac{1}{|\mathrm{GL}_c(\mathbb{F})|} Z_{k-2}^*(W, \pi \times \tau)$  from [\[8,](#page-39-1) Section 4.3], respectively. They are finite field analogs of operators studied by Kaplan in  $[6,$  Appendix A] and [\[22\]](#page-40-1), see also Section [4.2.1.](#page-28-1)

In [\[8,](#page-39-1) Theorem 4.14 and Corollary 4.21], the following functional equation was established.

**Theorem 4.1.** *Suppose that*  $\tau^{\vee}$  *does not appear in the cuspidal support of*  $\pi$ *. Then for any*  $W\in\mathcal{W}\left( \Delta\left( \tau,c\right) ,\psi_{\left( c^{k}\right) }\right)$ *, we have the equality of operators*

$$
\mathcal{Z}^*(W, \pi \times \tau) = \Gamma^{\text{GK}}(\pi \times \tau, \psi) \cdot \mathcal{Z}(W, \pi \times \tau).
$$

*Moreover, in this case*

$$
\left|\Gamma^{\text{GK}}\left(\pi \times \tau, \psi\right)\right| = 1.
$$

<span id="page-28-0"></span>4.2. Relation to level zero representations. In this section, we relate the zeta operators from Section [4.1.1](#page-27-3) and their counterparts defined over a local field using level zero representations.

<span id="page-28-1"></span>4.2.1. *Kaplan's local zeta integrals.* In this section, we recall the definition of Kaplan's local zeta integrals and the gamma factor that they define.

Let  $\Pi$  and  $\mathcal T$  be irreducible representations of  $GL_c(F)$  and  $GL_k(F)$ , respectively. Assume that  $\mathcal T$  is generic. In [\[6,](#page-39-0) Appendix A] and [\[22\]](#page-40-1), Kaplan introduced a local integral construction that represents the L-function associated to the tensor product representation of the pair  $(\Pi, \mathcal{T})$ . Kaplan's integrals arise as local integrals of a global construction of Ginzburg [\[12,](#page-40-0) Section 5.3]. Kaplan's zeta integral is given by the formula

$$
Z(s, v, v^{\vee}, W; \psi) = \int_{GL_c(F)} W \left( \text{diag} \left( h, I_{(k-1)c} \right) \right) \langle \Pi \left( h \right) v, v^{\vee} \rangle \left| \det h \right|^{s - \frac{(k-2)c+1}{2}} d^{\times} h.
$$

Here,  $s \in \mathbb{C}$ ,  $v \in \Pi$ ,  $v^{\vee} \in \Pi^{\vee}$  and  $W \in \mathcal{W} \left( \Delta \left( \mathcal{T}, c \right), \psi_{\left( c^k \right)} \right)$  (as explained before, the Speh representation  $\Delta(\mathcal{T}, c)$  is defined for  $\mathcal{T}$  generic and not necessarily supercuspidal [\[4,](#page-39-3) [24\]](#page-40-23), but we will not need this). The integral  $Z(s, v, v^{\vee}, W; \psi)$  converges absolutely for Res  $\gg 0$ , and in this domain it converges to an element of  $\mathbb{C}(q^{-s})$ . We keep denoting this element of  $\mathbb{C}(q^{-s})$  by  $Z(s, v, v^{\vee}, W; \psi)$ . It can be shown that for some data  $(v, v^{\vee}, W)$ , the integral  $Z(s, v, v^{\vee}, W; \psi)$  is the constant function 1.

Kaplan's dual zeta integral is given by the formula

$$
Z^*(s, v, v^{\vee}, W; \psi) = \int_{GL_c(F)} \int_{\text{Mat}_{c \times (k-2)c}(F)} \langle \Pi(h) v, v^{\vee} \rangle \cdot \left| \det h \right|^{s-1+\frac{(k-2)c+1}{2}} \times W \left( \text{diag} (I_{(k-1)c}, h) \begin{pmatrix} I_c & & \\ & I_{(k-2)c} & \\ & X & I_c \end{pmatrix} \begin{pmatrix} I_{(k-1)c} \\ I_c & \end{pmatrix} \right) dX d^{\times} h.
$$

This integral converges absolutely for  $\text{Res} \ll 0$  and in this domain it converges to an element of  $\mathbb{C}(q^{-s})$ . We keep denoting this element by  $Z^*(s, v, v^{\vee}, W; \psi)$ . Similarly to before, it can be shown that for some data, the integral  $Z^*(s, v, v^{\vee}, W; \psi)$  is the constant function 1.

These zeta integrals satisfy a functional equation.

**Theorem 4.2.** *There exists an element*  $\gamma^{\text{GK}}(s,\Pi \times \mathcal{T},\psi) \in \mathbb{C}(q^{-s})$ *, such that for every*  $W\in\mathcal{W}\left( \Delta\left( \mathcal{T},c\right) ,\psi_{\left( c^{k}\right) }\right)$  $\Big), v \in \Pi$  and  $v^{\vee} \in \Pi^{\vee}$ , the following functional equation holds:  $Z^*(s, v, v^{\vee}, W; \psi) = \omega_{\pi} (-1)^{k-1} \gamma^{\rm GK}(s, \Pi \times \mathcal{T}, \psi) Z(s, v, v^{\vee}, W; \psi).$

We call the gamma factor arising from this functional equation the *Ginzburg–Kaplan* γ*factor*.

Although not stated in [\[6,](#page-39-0) Appendix A], it follows from a globalization argument that for supercuspidal representations  $\Pi$  and  $\mathcal{T}$ , the Ginzburg–Kaplan gamma factor  $\gamma^{\rm GK}\left(s,\Pi\times\mathcal{T},\psi\right)$  agrees with the Jacquet–Piatetski-Shapiro–Shalika gamma factor [\[20\]](#page-40-7). The reason is because by [\[6,](#page-39-0) Theorem A.2], the Ginzburg–Kaplan  $\gamma$ -factor is multiplicative<sup>[4](#page-29-1)</sup> and by [\[12,](#page-40-0) Section 5.3], the zeta integrals arise from a global integral representing the L-function of the tensor product. See [\[5,](#page-39-5) Section 6.7.1].

<span id="page-29-0"></span>4.[2.2.](#page-7-0) *Computation for level zero representations.* Let  $\tau$  and  $\mathcal T$  be as in Section 2.2. Let  $\pi$ be an irreducible cuspidal representation of  $GL_c(\mathbb{F})$ , and let  $\Pi$  be an irreducible level zero supercuspidal representation constructed from  $\pi$  with central character  $\omega_{\Pi}$ . The goal of this section is to express Kaplan's local zeta integrals in terms of those in Section [4.1.1.](#page-27-3)

We first prove a simple lemma regarding matrix coefficients that arise by lifting elements from  $\pi$  and  $\pi^{\vee}$ . Let  $\Pi'$  be the irreducible level zero supercuspidal representation constructed from  $\pi^{\vee}$  with central character  $\omega_{\Pi}^{-1}$  $_{\Pi}^{-1}$ . We have that  $\Pi^{\vee}$  is isomorphic to  $\Pi'$ . Henceforth we will identify  $\Pi^{\vee}$  with the representation  $\Pi'$ .

<span id="page-29-3"></span>**Lemma 4.3.** *Let*  $v \in \pi$  *and*  $v^{\vee} \in \pi^{\vee}$ *.* 

*(1) Suppose that*  $h \in GL_c(F)$  *is such that* 

$$
\langle \Pi\left(h\right)\mathcal{L}v,\mathcal{L}v^{\vee}\rangle\neq 0.
$$

*Then*  $h \in F^{\times} \cdot \mathrm{GL}_{c}(\mathfrak{o})$ *. (2)* For any  $h \in GL_c(\mathfrak{o})$ ,

$$
\langle \Pi(h) \mathcal{L} v, \mathcal{L} v^{\vee} \rangle = \langle \pi(\nu(h)) v, v^{\vee} \rangle.
$$

*Proof.* Given  $f \in \Pi$  and  $f^{\vee} \in \Pi' \cong \Pi^{\vee}$ , the pairing  $\langle f, f^{\vee} \rangle$  is given by

$$
\langle f, f^{\vee} \rangle = \int_{F^{\times} \mathrm{GL}_c(\mathfrak{o}) \backslash \mathrm{GL}_c(F)} \langle f(x), f^{\vee}(x) \rangle d^{\times} x.
$$

Suppose that  $v \in \pi$  and  $v \in \pi^{\vee}$ . Then we have that

$$
\langle \Pi(h) \mathcal{L} v, \mathcal{L} v^{\vee} \rangle = \int_{F^{\times} \mathrm{GL}_c(\mathfrak{o}) \backslash \mathrm{GL}_c(F)} \langle \mathcal{L} v(xh), \mathcal{L} v^{\vee}(x) \rangle d^{\times} x,
$$

Since  $\mathcal{L}v^{\vee}$  is supported on  $F^{\times}GL_{c}(\mathfrak{o}),$  in order for the integrand not to vanish, we must have  $x \in F^{\times}GL_c(\mathfrak{o})$ . Since  $\mathcal{L}v$  is also supported on  $F^{\times}GL_c(\mathfrak{o})$ , this implies if  $\langle \Pi(h)\mathcal{L}v,\mathcal{L}v^{\vee} \rangle \neq 0$ then  $h \in F^{\times} \text{GL}_c(\mathfrak{o})$ . This proves the first part. The second part is immediate.

<span id="page-29-4"></span>Next, we prove a lemma regarding partial evaluation of Kaplan's zeta integrals.

<span id="page-30-1"></span>*(2)* If  $|t| > 1$ *, then* Z  $\operatorname{GL}\nolimits_c(\mathfrak o)$  $\mathcal{L}W\left(\text{diag}\left(I_{(k-1)c},th\right)\right)\left\langle \Pi\left(h\right)\mathcal{L}v,\mathcal{L}v^{\vee}\right\rangle \mathrm{d}^{\times}h=0.$ 

*Proof.* Let  $t \in F^{\times}$  and suppose that  $|t| < 1$ . Define a map  $Z_t$ :  $W(\Delta(\tau, c), \psi) \times \pi \times \pi^{\vee} \to \mathbb{C}$ by

$$
Z_t(W, v, v^{\vee}) = \int_{\mathrm{GL}_c(\mathfrak{o})} \mathcal{L}W\left(\mathrm{diag}\left(th, I_{(k-1)c}\right)\right) \langle \Pi\left(h\right) \mathcal{L}v, \mathcal{L}v^{\vee} \rangle \,d^{\times}h.
$$

Let  $n \in N_{(c,(k-1)c)}(\mathfrak{o})$ , then

\operatorname{diag}\left(th, I_{(k-1)c}\right) n \operatorname{diag}\left(th, I_{(k-1)c}\right)^{-1} = I_{kc} \left(\operatorname{mod} \mathfrak{p}\right). \tag{30}

Therefore, since the left hand side of [\(30\)](#page-30-0) lies in  $N_{(c^k)}$ , we have that

$$
\mathcal{L}W\left(\text{diag}\left(th, I_{(k-1)c}\right)n\right) = \mathcal{L}W\left(\text{diag}\left(th, I_{(k-1)c}\right)\right).
$$

This implies that for any  $n \in N_{(c,(k-1)c)}(\mathbb{F})$  and any  $h \in GL_c(\mathbb{F})$ , we have

Z_t\left(\Delta\left(\tau,c\right)\left(n \text{diag}\left(h, I_{(k-1)c}\right)\right) W, \pi\left(h\right)v, v^{\vee}\right) = Z_t\left(W, v, v^{\vee}\right).

If  $Z_t$  is not identically zero, it follows that  $\Delta(\tau, c)$  embeds into the space  $\pi^{\vee} \circ \Sigma$  for some irreducible representation  $\Sigma$  of  $\mathrm{GL}_{(k-1)c}(\mathbb{F})$ . Since the cuspidal support of  $\Delta(\tau, c)$  is  $\{\tau, \ldots, \tau\},$ we have that  $Z_t$  is identically zero unless  $k = c$  and  $\pi^{\vee} = \tau$ . This proves part [1.](#page-29-2) Part [2](#page-30-1) is proved similarly.  $\Box$ 

Consider the following functionals  $S: \tau^{\vee} \otimes \tau \otimes \tau \otimes \Delta(\tau, c-1) \to \mathbb{C}$  and  $S^*: \tau^{\vee} \otimes \tau \otimes \tau \otimes \tau$  $\Delta(\tau, c - 1) \otimes \tau \to \mathbb{C}.$

\langle v_{\tau} \otimes v_{\tau} \otimes v_{\tau}' \otimes f_{\Delta(\tau,c-1)}, S \rangle
$$
  
=  $\langle v_{\tau} \vee, v_{\tau}' \rangle \cdot \frac{1}{|\mathrm{GL}_{c-1}(\mathbb{F})|} \frac{1}{|\mathcal{Y}_{1,c-1}(\mathbb{F})|} \sum_{g \in \mathrm{GL}_{c-1}(\mathbb{F})} \sum_{y \in \mathcal{Y}_{1,c-1}(\mathbb{F})} W_{v_{\tau}} \begin{pmatrix} 1 \\ -g^{-1} \end{pmatrix}$   
  $\times W_{f_{\Delta(\tau,c-1)}} \left( \begin{pmatrix} g \\ I_{(c-1)^2} \end{pmatrix} y \kappa_{1,c-1} \right).$ 

and

$$
\langle v_{\tau} \otimes v_{\tau} \otimes f_{\Delta(\tau,c-1)} \otimes v'_{\tau}, S^* \rangle
$$
  
=  $\langle v_{\tau} \vee, v'_{\tau} \rangle \cdot \frac{1}{|\mathrm{GL}_{c-1}(\mathbb{F})|} \frac{1}{|\mathcal{Y}_{c-1,1}(\mathbb{F})|} \sum_{g \in \mathrm{GL}_{c-1}(\mathbb{F})} \sum_{y \in \mathcal{Y}_{c-1,1}(\mathbb{F})} W_{v_{\tau}} \begin{pmatrix} g \\ 1 \end{pmatrix}$   
  $\times W_{f_{\Delta(\tau,c-1)}} \left( \begin{pmatrix} I_{(c-1)^2} & & \\ & -g^{-1} \end{pmatrix} y \kappa_{c-1,1} \right).$ 

These functionals are similar to the ones appearing in Theorems [3.6](#page-20-1) and [3.7.](#page-20-0)

We are now ready to state our results regarding the relation between Kaplan's zeta in-tegrals and the ones in Section [4.1.1.](#page-27-3) Normalize the Haar measures on  $F^{\times}$  and  $GL_c(F)$  so that  $\mathfrak{o}^{\times}$  and  $GL_{c}(\mathfrak{o})$  have volume 1, respectively.

Then we have*  $Z(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi) = \langle Z(W, \pi \times \tau) v, v^{\vee} \rangle$ . <span id="page-31-2"></span>(2) Suppose that  $\pi = \tau^{\vee}$  (and therefore  $k = c$ ). Then for any  $v \in \tau^{\vee}$ ,  $v^{\vee} \in \tau$  and  $W = W_f$  for  $f \in \Delta(\tau, c) \subset \tau \circ \Delta(\tau, c-1)$  we have

Z(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi) = \langle Z(W, \pi \times \tau) v, v^{\vee} \rangle + q^{-\frac{c^{2}}{2}} \cdot \frac{\omega_{\Pi}(\varpi) \omega_{\mathcal{T}}(\varpi) q^{-c(s-\frac{1}{2})}}{1 - \omega_{\Pi}(\varpi) \omega_{\mathcal{T}}(\varpi) q^{-cs}} \langle v \otimes v^{\vee} \otimes f(I_{c^{2}}), S \rangle.
$$

*Proof.* By Lemma [4.3](#page-29-3) we have that

$$
Z(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi) = \int_{F^{\times}} \int_{GL_c(\mathfrak{o})} \mathcal{L}W \left( \text{diag} \left( th, I_{(k-1)c} \right) \right) \langle \Pi \left( th \right) \mathcal{L}v, \mathcal{L}v^{\vee} \rangle
$$

$$
\times |t|^{cs-c\frac{(k-2)c+1}{2}} d^{\times}hd^{\times}t.
$$

By Proposition [3.5,](#page-19-0) we have that if the integrand does not vanish for  $t \in F^{\times}$ , then  $|t| \leq 1$ . Thus

$$
Z(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi) = \sum_{j=0}^{\infty} \omega_{\Pi} (\varpi)^j q^{-jcs+jc\frac{(k-2)c+1}{2}}
$$
  
 
$$
\times \int_{\mathfrak{o}^{\times}} \int_{\mathrm{GL}_c(\mathfrak{o})} \mathcal{L}W \left( \mathrm{diag} \left( \varpi^j th, I_{(k-1)c} \right) \right) \langle \Pi \left( th \right) \mathcal{L}v, \mathcal{L}v^{\vee} \rangle \mathrm{d}^{\times} h \mathrm{d}^{\times} t. \tag{31}
$$

Suppose that  $\pi \ncong \tau^{\vee}$ . By Lemma [4.4](#page-29-4) part [1,](#page-29-2) the summand of [\(31\)](#page-31-0) vanishes for  $j \geq 1$ . Hence the result follows.

Suppose that  $\pi = \tau^{\vee}$ . In this case, we get from Theorem [3.6](#page-20-1) applied to the function  $\Delta(\tau, c)$  (diag  $(\nu(h), I_{(k-1)c})$ ) f and from the second part of Lemma [4.3,](#page-29-3) that for  $j \ge 1$ ,

=\frac{q^{-(j+1)(c-1)\binom{c}{2}}\omega_{\mathcal{T}}\left(\varpi\right)^j}{|\mathrm{GL}_c(\mathbb{F})|} \sum_{h \in \mathrm{GL}_c(\mathbb{F})} \langle \tau\left(h\right) \otimes \mathrm{id}_{\Delta(\tau,c-1)}f\left(I_{c^2}\right), S_0 \rangle \langle v, \tau\left(h^{-1}\right)v^{\vee}\rangle. \tag{32}
$$

By Corollary [A.2,](#page-36-1) we have that [\(32\)](#page-31-1) is given by

$$
\frac{|\mathrm{GL}_{c-1}\left(\mathbb{F}\right)|\,|\mathcal{Y}_{1,c-1}\left(\mathbb{F}\right)|}{|\mathrm{GL}_{c}\left(\mathbb{F}\right)|}\cdot q^{\binom{c}{2}}\left(q^{c}-1\right)\cdot q^{-\left(j+1\right)\left(c-1\right)\binom{c}{2}}\omega_{\mathcal{T}}\left(\varpi\right)^{j}\left\langle v\otimes v^{\vee}\otimes f\left(I_{c^{2}}\right),S\right\rangle.
$$

Substituting this expression in [\(31\)](#page-31-0) and using the identity

$$
\frac{q^{\binom{c}{2}}(q^c-1)}{q^{(c-1)\binom{c}{2}}|\mathrm{GL}_c(\mathbb{F})|} = \frac{q^{-\binom{c}{2}}}{|\mathcal{Y}_{1,c-1}(\mathbb{F})| |\mathrm{GL}_{c-1}(\mathbb{F})|}

yields the desired result.  $\Box$ 

We move to state our result regarding the dual zeta integral. Normalize the Haar measures on  $F^{\times}$  and on  $GL_c(F)$  as described before Theorem [4.5.](#page-30-2) Additionally, normalize the Haar measure on  $\text{Mat}_{c \times (k-2)c}(F)$  so that  $\text{Mat}_{c \times (k-2)c}(\mathfrak{p})$  has volume  $\left| \text{Mat}_{c \times (k-2)c}(\mathbb{F}) \right|$  $-\frac{1}{2}$ . This normalization makes the Fourier transform of  $\text{Mat}_{c \times (k-2)c}(F)$  self-dual.

$$

<span id="page-32-2"></span>(2) Suppose that  $\pi = \tau^{\vee}$  (and therefore  $k = c$ ). Then for any  $v \in \tau^{\vee}$ ,  $v^{\vee} \in \tau$  and  $W = W_{\mathcal{L}f}$  for  $f \in \Delta(\tau, c) \subset \tau \circ \Delta(\tau, c-1)$  we have

$$
Z^*(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi) = \langle Z^*(W, \pi \times \tau) v, v^{\vee} \rangle
$$
  
+  $q^{-\binom{c}{2}} \cdot \frac{\omega_{\Pi}^{-1}(\varpi) \omega_{\mathcal{T}}^{-1}(\varpi) q^{-c(1-s)}}{1 - \omega_{\Pi}^{-1}(\varpi) \omega_{\mathcal{T}}^{-1}(\varpi) q^{-c(1-s)}} \times q^{\frac{-c^2(c-2)}{2}} \sum_{X \in \text{Mat}_{c \times (c-2)c}(\mathbb{F})} \left\langle v \otimes v^{\vee} \otimes f\left(\begin{pmatrix} I_{c} & I_{(c-1)c} \\ I_c & I_{(c-2)c} \end{pmatrix} \right) \begin{pmatrix} I_c & X \\ & I_{(c-2)c} \end{pmatrix} \right\rangle, S^*\right\rangle.$ 

*Proof.* By Lemma [4.3,](#page-29-3) we have that  $Z^*(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi)$  is given by

$$
\int_{GL_c(\mathfrak{o})} \int_{F^\times} \int_{\mathrm{Mat}_{c \times (k-2)c}(F)} \langle \Pi\left(th\right) \mathcal{L}v, \mathcal{L}v^\vee \rangle \cdot |t|^{c\left(s-1+\frac{(k-2)c+1}{2}\right)} \times \mathcal{L}W \left( \text{diag}\left(I_{(k-1)c}, th\right) \begin{pmatrix} I_c & & \\ & I_{(k-2)c} & \\ & X & I_c \end{pmatrix} \begin{pmatrix} I_{(k-1)c} \\ I_c & \end{pmatrix} \right) dX d^\times t d^\times h.
$$

Applying Lemma [B.2](#page-39-10) to the function  $g \mapsto \mathcal{L}W(g) \int_{I} I_{(k-1)c}$  $\left(I_c^{I_{(k-1)c}}\right)\right),$  we have that  $Z^*(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi)$  is given by

$$
\int_{GL_c(\mathfrak{o})} \int_{F^\times} \int_{\mathrm{Mat}_{c \times (k-2)c}(\mathfrak{o})} \langle \Pi\left(th\right) \mathcal{L}v, \mathcal{L}v^\vee \rangle \cdot |t|^{c\left(s-1+\frac{(k-2)c+1}{2}\right)} \times \mathcal{L}W\left(\mathrm{diag}\left(I_{(k-1)c}, th\right) \begin{pmatrix}I_c & & \\ & I_{(k-2)c} & \\ & X & I_c\end{pmatrix}\begin{pmatrix}I_{(k-1)c}\end{pmatrix}\right) dX d^\times t d^\times h.
$$

By Proposition [3.5](#page-19-0) applied to the function  $g \mapsto \mathcal{L}W(g) \int_{I} I_{(k-1)c}$  $\left(I_{(k-1)c}\right)$ , we have that the domain of integration of t is  $|t| \geq 1$ . Hence  $Z^*(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi)$  is given by

\sum_{j=0}^{\infty} \omega_{\Pi} (\varpi)^{-j} q^{jc(s-1+\frac{(k-2)c+1}{2})} \int_{GL_c(\mathfrak{o})} \int_{\mathfrak{o}^{\times}} \int_{\mathrm{Mat}_{c \times (k-2)c}(\mathfrak{o})} \langle \Pi (th) \mathcal{L} v, \mathcal{L} v^{\vee} \rangle
$$
\n
$$
\times \mathcal{L}W \left( \mathrm{diag} (I_{(k-1)c}, \varpi^{-j}th) \begin{pmatrix} I_c & & \\ & I_{(k-2)c} & \\ & & X & I_c \end{pmatrix} \begin{pmatrix} I_{(k-1)c} \\ I_c & \end{pmatrix} \right) dX d^{\times} t d^{\times} h.
$$
\n(33)

We may omit the integration over  $t$  by changing variables.

<span id="page-33-2"></span>Notice that for  $j = 0$ , we have from Proposition [3.4](#page-18-0) and from the second part of Lemma [4.3](#page-29-3) that the summand

evaluates to  $\langle Z^*(W, \pi \times \tau) \nu, \nu^{\vee} \rangle$  (recall that the Haar measure is normalized such that  $\text{Mat}_{c \times (k-2)c}(\mathfrak{p})$  has volume  $q^{-\frac{c^2(k-2)}{2}}$ .

If  $\pi \not\cong \tau^{\vee}$ , then by applying Lemma [4.4](#page-29-4) part [2](#page-30-1) to the  $(k, c)$   $\psi$ -Whittaker function

$$
g \mapsto \int_{\mathrm{Mat}_{c \times (k-2)c}(\mathfrak{o})} \mathcal{L}W \left( g \begin{pmatrix} I_c & & \\ & I_{(k-2)c} & \\ & & X & I_c \end{pmatrix} \begin{pmatrix} I_{(k-1)c} \\ I_c & \end{pmatrix} \right) dX,
$$

we get that the summand of [\(33\)](#page-32-0) vanishes for  $j > 0$ , and hence the result the follows.

If  $\pi = \tau^{\vee}$ , then the proof proceeds similarly to the proof of Theorem [4.5](#page-30-2) part [2.](#page-31-2)

 $\Box$ 

<span id="page-33-0"></span>As a corollary, we get a relation between the Ginzburg–Kaplan gamma factors over the finite field and over the local field.

**Corollary 4.7.** *Suppose that*  $\pi \not\cong \tau^{\vee}$ *. Then*

<span id="page-33-1"></span>**Theorem 4.8.** Suppose that  $\pi = \tau^{\vee}$  (and therefore  $k = c$ ). Then

\gamma^{\text{GK}}(\pi \times \tau, \psi) = -\omega_{\tau} (-1)^{c-1} q^{-\frac{c}{2}}.
$$

*Proof.* Take  $W = \mathcal{BS}_{\Delta(\tau,c),\psi}$ . We have that for any  $h \in GL_c(\mathfrak{o})$  and any  $j \geq 1$ ,

 $\mathcal{L}W\left(\text{diag}\left(\varpi^j h, I_{(c-1)c}\right)\right) = 0.$ 

Indeed, for any  $X \in Mat_c(\mathfrak{o})$  if  $u_X = \text{diag}((\begin{smallmatrix} I_c & X \\ & I_c \end{smallmatrix}), I_{(c-2)c})$  then we have

$$
\Delta(\mathcal{T}, c) (u_X) \mathcal{L}W = \mathcal{L} (\Delta(\tau, c) (\nu(u_X)) W) = \psi (\text{tr } X) \mathcal{L}W.
$$

Substituting diag  $(\varpi^j h, I_{(c-1)c})$  yields

$$
\mathcal{L}W\left(\text{diag}\left(\varpi^j h, I_{(c-1)c}\right)u_X\right)=\psi\left(\text{tr } X\right)\mathcal{L}W\left(\text{diag}\left(\varpi^j h, I_{(c-1)c}\right)\right).
$$

On the other hand, the equality

diag 
$$
(\varpi^{j}h, I_{(c-1)c}) u_X = u_{\varpi^{j}hX} \cdot \text{diag}(\varpi^{j}h, I_{(c-1)c})
$$

yields that

$$
\mathcal{L}W\left(\text{diag}\left(\varpi^j h, I_{(c-1)c}\right)u_X\right) = \mathcal{L}W\left(\text{diag}\left(\varpi^j h, I_{(c-1)c}\right)\right).
$$

Therefore, by choosing X such that  $\psi(\text{tr } X) \neq 0$ , we get that  $\mathcal{L}W$  (diag  $(\varpi^{j}h, I_{(c-1)c})$ ) must be zero. A similar argument shows that  $\mathcal{L}W$   $(\text{diag}(h, I_{(c-1)c})) = 0$  for  $h \in GL_c(\mathfrak{o})$  such that  $h \neq I_c$  (see [\[8,](#page-39-1) Proposition 2.2]).

<span id="page-34-1"></span>Let  $v_{\tau,\psi} \in \tau$  and  $v_{\tau^{\vee},\psi^{-1}} \in \tau^{\vee}$  be a  $\psi$ -Whittaker vector and a  $\psi^{-1}$ -Whittaker vector, respectively, normalized such that  $\langle v_{\tau,\psi}, v_{\tau \vee \psi^{-1}} \rangle = 1$ . Substituting  $W = \mathcal{BS}_{\Delta(\tau,c),\psi}$ ,  $v = v_{\tau \vee \psi}$ and  $v^{\vee} = v_{\tau,\psi}$ , we get that

$$
\mathrm{Z}\left(s,\mathcal{L} v,\mathcal{L} v^{\vee},\mathcal{L} W;\psi\right)=\frac{1}{\left|\mathrm{GL}_{c}\left(\mathbb{F}\right)\right|}
$$

.

Therefore, we have that

$$
\gamma^{\rm GK}\left(s,\Pi\times\mathcal{T},\psi\right)=\omega_{\pi}\left(-1\right)^{c-1}\left|\operatorname{GL}_c\left(\mathbb{F}\right)\right|Z^*\left(s,\mathcal{L}v,\mathcal{L}v^{\vee},\mathcal{L}W;\psi\right).
$$

Since W is invariant under right translations by matrices of the form  $\begin{pmatrix} I_c & X \\ & I_c & \\ & & I_c \end{pmatrix}$  $I_c$  $I_{(c-2)c}$  $\setminus$ , where  $X \in Mat_{c \times (c-2)c}$  $X \in Mat_{c \times (c-2)c}$  $X \in Mat_{c \times (c-2)c}$  (o), we get from Theorem [4.6](#page-32-1) part 2 that

$$
Z^*(s, \mathcal{L}v, \mathcal{L}v^{\vee}, \mathcal{L}W; \psi) = \langle Z^*(W, \pi \times \tau) v, v^{\vee} \rangle + q^{(c-1)\binom{c}{2}} \cdot q^{-\frac{c^2}{2}} \cdot \frac{\omega_{\Pi}^{-1}(\varpi) \omega_{\mathcal{T}}^{-1}(\varpi) q^{-c(1-s)}}{1 - \omega_{\Pi}^{-1}(\varpi) \omega_{\mathcal{T}}^{-1}(\varpi) q^{-c(1-s)}} \left\langle v \otimes v^{\vee} \otimes f \left( I_c \right)^{I_{(c-1)c}} \right), S^* \right\rangle,
$$

where  $f \in \Delta(\tau, c) \subset \Delta(\tau, c-1) \circ \tau$  is chosen so that

$$
\mathcal{BS}_{\Delta(\tau,c),\psi}(g) = \langle \Delta(\tau,c) (g) f, \ell_{\Delta(\tau,c)} \rangle
$$

for any  $g \in GL_{c^2}(\mathbb{F})$ . On the other hand, since  $\gamma^{GK}(s, \Pi \times \mathcal{T}, \psi)$  equals the Jacquet-Piatetski-Shapiro–Shalika gamma factor defined in [\[20\]](#page-40-7), we have by [\[35,](#page-40-8) Remark after Corol-lary 4.3 that<sup>[5](#page-34-0)</sup>

$$
\gamma^{\rm GK}\left(s,\Pi\times\mathcal{T},\psi\right)=\omega_{\tau}\left(-1\right)^{c-1}\frac{q^{c\left(s-\frac{1}{2}\right)}}{\omega_{\Pi}\left(\varpi\right)\omega_{\mathcal{T}}\left(\varpi\right)}\cdot\frac{1-\omega_{\Pi}\left(\varpi\right)\omega_{\mathcal{T}}\left(\varpi\right)q^{-cs}}{1-\omega_{\Pi}^{-1}\left(\varpi\right)\omega_{\mathcal{T}}^{-1}\left(\varpi\right)q^{-c\left(1-s\right)}},
$$

which can also be written as

$$
\gamma^{\text{GK}}(s,\Pi \times \mathcal{T},\psi) = \omega_{\pi}(-1)^{c-1} q^{\frac{c}{2}} \left(-1 + \frac{1 - q^{-c}}{1 - \omega_{\Pi}^{-1}(\varpi) \omega_{\mathcal{T}}^{-1}(\varpi) q^{-c(1-s)}}\right).
$$

One can show that

$$
\gamma^{\rm GK}\left(\pi\times\tau,\psi\right)=\omega_{\pi}\left(-1\right)^{c-1}\left|\operatorname{GL}_c\left(\mathbb{F}\right)\right|\left\langle\operatorname{Z}^*\left(W,\pi\times\tau\right)v,v^{\vee}\right\rangle,
$$

see also [\[8,](#page-39-1) Section 4.3.3]. Hence, we get by comparing the constant coefficient of the Taylor expansion of  $\gamma^{\text{GK}}(s, \Pi \times \mathcal{T}, \psi)$  (in the variable  $q^{-c(1-s)}$ ) that

$$
\gamma^{GK}(\pi \times \tau, \psi) = \omega_{\pi}(-1)^{c-1} q^{\frac{c}{2}} (-1 + 1 - q^{-c}) = -\omega_{\pi}(-1)^{c-1} q^{-\frac{c}{2}},
$$

and by comparing any other non-zero coefficient that

$$
|\mathrm{GL}_c(\mathbb{F})| q^{(c-1)\binom{c}{2}} \cdot q^{-\frac{c^2}{2}} \left\langle v \otimes v^{\vee} \otimes f \left( I_c \right) I_{(c-1)c} \right), S^* \right\rangle = q^{\frac{c}{2}} - q^{-\frac{c}{2}},
$$

which implies that

$$
q^{(c-1)\binom{c}{2}}\left\langle v\otimes v^{\vee}\otimes f\left(I_c\right)^{I_{(c-1)c}}\right),S^*\right\rangle=\frac{1}{\dim\tau}.
$$

<span id="page-35-1"></span>As another corollary, we obtain the modified functional equation for the case  $\pi = \tau^{\vee}$ .

**Corollary 4.9.** Suppose that  $\pi = \tau^{\vee}$  (and therefore,  $k = c$ ) and denote  $T = \omega_{\Pi}(\varpi) \omega_{\mathcal{T}}(\varpi) q^{-cs}$ . Then for any  $v \in \tau^{\vee}$ ,  $v^{\vee} \in \tau$  and  $W \in \mathcal{W}(\Delta(\tau, c), \psi_{(c^c)})$ , *such that*  $W = W_f$  *for*  $f \in \Delta(\tau, c)$ *, the following modified functional equation holds:*

=  $(q^{\frac{c}{2}}T - q^{-\frac{c}{2}}) \langle Z^*(W, \pi \times \tau) v, v^{\vee} \rangle$   
+  $q^{-c \cdot \binom{c}{2}} \sum_{X \in \text{Mat}_{c \times (c-2)c}(\mathbb{F})} \left\langle v \otimes v^{\vee} \otimes f_{\Delta(\tau, c-1) \circ \tau} \left( \begin{pmatrix} I_{c} & X \\ I_{c} & I_{(c-1)c} \end{pmatrix} \begin{pmatrix} I_c & X \\ I_c & I_{(c-2)c} \end{pmatrix} \right), S^* \right\rangle.$ 

*Therefore, we have the following simple modified functional equation:*

$$
\langle Z^*(W, \pi \times \tau) v, v^{\vee} \rangle = \Gamma^{GK} (\pi \times \tau, \psi) (\langle Z(W, \pi \times \tau) v, v^{\vee} \rangle)
$$

$$
+ q^{-\frac{c^2}{2}} \cdot \langle v \otimes v^{\vee} \otimes f_{\tau \circ \Delta(\tau, c-1)}(I_{c^2}), S \rangle
$$

.

*(Recall that*  $\Gamma^{\text{GK}}(\pi \times \tau, \psi) = -q^{-\frac{c}{2}}$  *in this case).* 

*Here,*  $f_{\tau \circ \Delta(\tau,c-1)}$  *(respectively,*  $f_{\Delta(\tau,c-1)\circ \tau}$ *) is the element representing* f *in*  $\tau \circ \Delta(\tau,c-1)$ *(respectively, in*  $\Delta(\tau, c-1) \circ \tau$ *), given by*  $f_{\tau \circ \Delta(\tau, c-1)}(g)(g') = f(\text{diag}(I_c, g')g)$  *(respectively, by*  $f_{\Delta(\tau,c-1)\circ\tau}(g)(g') = f(\text{diag}(g',I_c))g)$  for  $g' \in \text{GL}_{(c-1)c}(\mathbb{F})$  and  $g \in \text{GL}_{c^2}(\mathbb{F})$ *.* 

We use the results of Theorems [4.5](#page-30-2) and [4.6](#page-32-1) to obtain the following identity. This identity is [\[8,](#page-39-1) Theorem 4.24] and is crucial for the proofs of the results of [\[8,](#page-39-1) Section 5]. See [\[37\]](#page-41-1) for the definition of  $\varepsilon_0$  ( $\pi \times \tau, \psi$ ).

<span id="page-35-0"></span>**Theorem 4.10.** Let  $\pi$  and  $\tau$  be irreducible cuspidal representations of  $GL_c(\mathbb{F})$  and  $GL_k(\mathbb{F})$ , *respectively. Then*

$$
\gamma^{\rm GK}\left(\pi\times\tau,\psi\right)=\varepsilon_0\left(\pi\times\tau,\psi\right).
$$

*Proof.* When  $\pi$  is isomorphic to  $\tau^{\vee}$ , by the proof of [\[38,](#page-41-2) Theorem 2.18] we have that

$$
\varepsilon_0 \left( \pi \times \tau, \psi \right) = -\omega_\tau \left( -1 \right)^{c-1} q^{-\frac{c}{2}}.
$$

Hence the result follows in this case from Theorem [4.8.](#page-33-1) When  $\pi$  is not isomorphic to  $\tau^{\vee}$ , we have that the Jacquet–Piatetski-Shapiro–Shalika gamma factor [\[20\]](#page-40-7) equals the Jacquet– Piatetski-Shapiro–Shalika epsilon factor  $\varepsilon$  (s,  $\Pi \times \mathcal{T}, \psi$ ) [\[20\]](#page-40-7), and by the proof of [\[37,](#page-41-1) Theorem 4.4], this equals  $\varepsilon_0$  ( $\pi \times \tau, \psi$ ). The result now follows from Corollary [4.7](#page-33-0) and from the equality of the Ginzburg–Kaplan gamma factor and the Jacquet–Piatetski-Shapiro–Shalika gamma factor.  $\Box$ 

## Appendix A. A variant of Schur's lemma

<span id="page-35-2"></span>Throughout the text, the following variant of Schur's lemma is used.

**Proposition A.1.** Let  $\tau$  and  $\pi$  be irreducible representations of a finite group G. Then

$$
\frac{1}{|G|} \sum_{g \in G} \tau(g) \otimes \pi(g^{-1}) = \begin{cases} 0 & \tau \ncong \pi \\ \frac{1}{\dim \tau} \text{sw} & \tau = \pi \end{cases},
$$

*where* sw:  $\tau \otimes \tau \rightarrow \tau \otimes \tau$  *is the swap linear map, acting on pure tensors by* 

$$
\mathrm{sw}\,(v\otimes v')=v'\otimes v,
$$

<span id="page-36-3"></span>*where*  $v, v' \in \tau$ *.* 

*Proof.* Denote

$$
T = \frac{1}{|G|} \sum_{g \in G} \tau(g) \otimes \pi(g^{-1}).
$$

Then for any  $h_1, h_2 \in G$ ,

$$
T \circ (\tau (h_1) \otimes \pi (h_2)) = (\tau (h_2) \otimes \pi (h_1)) \circ T = \text{sw} \circ (\pi (h_1) \otimes \tau (h_2)) \circ \text{sw} \circ T.
$$

Therefore, we have that  $\text{sw} \circ T \in \text{Hom}_{G \times G} (\tau \otimes \pi, \pi \otimes \tau)$ . If  $\tau \not\cong \pi$ , then by Schur's lemma the latter Hom-space is zero. If  $\tau = \pi$ , we have that sw  $\circ T = c \cdot id_{\tau \otimes \tau}$ , where  $c \in \mathbb{C}$  is a scalar, which is equivalent to  $T = c \cdot sw$ . To find the scalar, we take the trace, and using Schur's orthogonality relations, we get that

$$
c \cdot \operatorname{tr} \operatorname{sw} = \operatorname{tr} (T) = \frac{1}{|G|} \sum_{g \in G} \operatorname{tr} \tau (g) \operatorname{tr} \tau (g^{-1}) = 1.
$$

The result now follows because tr sw = dim  $\pi$ .

<span id="page-36-1"></span>Using the well-known fact that every irreducible cuspidal representation of  $GL_k(\mathbb{F})$  is of dimension  $[\mathrm{GL}_{k-1}(\mathbb{F}): U_{k-1}(\mathbb{F})]$ , we obtain the following result.

**Corollary A.2.** *If*  $\tau$  *is an irreducible cuspidal representation of*  $GL_k(\mathbb{F})$  *then* 

$$
\frac{1}{|\mathrm{GL}_k(\mathbb{F})|} \sum_{g \in \mathrm{GL}_k(\mathbb{F})} \tau(g) \otimes \tau(g^{-1}) = \frac{q^{\binom{k}{2}} \cdot (q^k - 1)}{|\mathrm{GL}_k(\mathbb{F})|} \cdot \mathrm{sw}.
$$

### Appendix B. Root exchange algorithm

<span id="page-36-0"></span>We explain the root exchange algorithm commonly used to reduce domains of integration. Our treatment is informal, and we refer to [\[2,](#page-39-11) Section 6.1] and [\[13,](#page-40-25) Section 7.1] for the precise statements.

As always, assume that  $\psi: F \to \mathbb{C}^{\times}$  has conductor  $\mathfrak{p}$ . Let  $G = GL_n(F)$  for some n. The root exchange algorithm concerns integrals of the form

$$
I_{l}(f) = \int_{\text{Mat}_{a_{1} \times b_{1}}(F)} \cdots \int_{\text{Mat}_{a_{l} \times b_{l}}(F)} f(r_{1}(y_{1}) \ldots r_{l}(y_{l})) dy_{l} \ldots dy_{1},
$$
\n(34)

where  $f: G \to \mathbb{C}$  is a right smooth function and for every  $1 \leq i \leq l$ ,

$$
r_i\colon (\mathrm{Mat}_{a_i\times b_i}(F),+)\to (G,\cdot)
$$

is a continuous injective homomorphism of groups. We make the additional assumption that

$$
r_i\left(\text{Mat}_{a_i\times b_i}\left(\mathfrak{p}^j\right)\right)\subset I_n+\text{Mat}_{a_i\times b_i}\left(\mathfrak{p}^j\right)
$$

for every  $j \in \mathbb{Z}$ . Integrals over unipotent subgroups can be realized in this form.

The idea of the root exchange algorithm is to use embeddings  $r_i^*$ :  $\text{Mat}_{b_i \times a_i}(F) \to G$  and make use of the right smoothness of f in order to reduce the integration domain in  $(34)$ . In

order for this to be successful, we need f to satisfy the following relation: for any  $1 \leq i \leq l$ , any  $g_0 \in G$ ,  $y_i \in \text{Mat}_{a_i \times b_i}(F)$ , and any  $x_i \in \text{Mat}_{b_i \times a_i}(F)$ ,

$$
\int_{\text{Mat}_{a_1} \times b_1(F)} \cdots \int_{\text{Mat}_{a_{i-1} \times b_{i-1}}(F)} f(r_1(y_1) \dots r_i(y_i) r_i^*(x_i) g_0) dy_{i-1} \dots dy_1
$$
\n
$$
= \psi \left( \text{tr}(y_i x_i) \right) \int_{\text{Mat}_{a_1 \times b_1}(F)} \cdots \int_{\text{Mat}_{a_{i-1} \times b_{i-1}}(F)} f(r_1(y_1) \dots r_i(y_i) g_0) dy_{i-1} \dots dy_1.
$$
\n(35)

The algorithm goes as follows. Let  $f_l = f$ .

(1) Suppose that  $f_j$  is defined so that  $I_l(f) = I_j(f_j)$ . Suppose that  $f_j$  is right smooth and satisfies the condition [\(35\)](#page-37-0) for  $1 \leq i \leq j$ . Suppose that  $f_j$  is right invariant under  $I_n + \text{Mat}_n \left( \mathfrak{p}^{m_j} \right) \text{ for } m_j \geq 1. \text{ Then}$

$$
f_j(g) = \frac{1}{\text{Vol}\left(\text{Mat}_{b_j \times a_j}(\mathfrak{p}^{m_j})\right)} \int_{\text{Mat}_{b_j \times a_j}(\mathfrak{p}^{m_j})} f_j\left(gr_j\left(x_j\right)\right) \mathrm{d}x_j. \tag{36}
$$

<span id="page-37-3"></span>(2) Substitute [\(36\)](#page-37-1) in  $I_j(f_j)$  to and use [\(35\)](#page-37-0) (with  $g_0 = I_n$ ) to get

$$
I_j(f_j) = \frac{1}{\text{Vol}(\text{Mat}_{b_j \times a_j}(\mathfrak{p}^{m_j}))} \int_{\text{Mat}_{a_1 \times b_1}(F)} \cdots \int_{\text{Mat}_{a_j \times b_j}(F)} \int_{\text{Mat}_{b_j \times a_j}(\mathfrak{p}^{m_j})} \times \psi(\text{tr}(y_j x_j)) f_j(r_1(y_1) \dots r_j(y_j)) \, dx_j dy_j \dots dy_1.
$$
 (37)

<span id="page-37-4"></span>(3) The inner integral

$$
\frac{1}{\text{Vol}\left(\text{Mat}_{b_j\times a_j}\left(\mathfrak{p}^{m_j}\right)\right)}\int_{\text{Mat}_{b_j\times a_j}\left(\mathfrak{p}^{m_j}\right)}\psi\left(\text{tr}\left(y_jx_j\right)\right)\text{d}x_j
$$

is (up to scalar multiplication) the Fourier transform of the characteristic function of  $\text{Mat}_{b_j \times a_j}(\mathfrak{p}^{m_j})$  (viewed as a function in the variable  $y_j$ ). It equals the characteristic function of  $\mathfrak{p}^{-m_j+1}$ . Hence  $I_j(f_j)$  is given by

$$
\int_{\mathrm{Mat}_{a_1\times b_1}(F)}\cdots\int_{\mathrm{Mat}_{a_{j-1}\times b_{j-1}}(F)}\int_{\mathrm{Mat}_{a_j\times b_j}\left(\mathfrak{p}^{-m_j+1}\right)}f_j\left(r_1\left(y_1\right)\ldots r_j\left(y_j\right)\right)\mathrm{d}y_j\ldots\mathrm{d}y_l.
$$

Define

$$
f_{j-1}(g) = \int_{\text{Mat}_{a_j \times b_j}(\mathfrak{p}^{-m_j+1})} f_j(gr_j(y_j)) dy_j.
$$

Then  $I_j(f_j) = I_{j-1}(f_{j-1})$  and  $f_{j-1}$  is right smooth and satisfies [\(35\)](#page-37-0) for  $1 \leq i \leq j-1$ .

(4) Repeatedly run the algorithm steps to eventually get  $I_l(f) = I_0(f_0) = f_0(I_n)$ , which is the integral

$$
\int_{\mathrm{Mat}_{a_1\times b_1}\left(\mathfrak{p}^{-m_1+1}\right)}\cdots\int_{\mathrm{Mat}_{a_l\times b_l}\left(\mathfrak{p}^{-m_l+1}\right)}f\left(r_1\left(y_1\right)\ldots r_l\left(y_l\right)\right)\mathrm{d}y_l\ldots\mathrm{d}y_1.
$$

We end with a few useful remarks. The first one is that if the images of  $r_1^*, \ldots, r_l^*$  commute, then we may choose  $m_1 = m_2 = \cdots = m_l = m$ , where f is right invariant under  $I_n$  +  $\operatorname{Mat}_n(\mathfrak{p}^m)$ .

The second remark is there exists a slight generalization of this algorithm, where instead of using the fact that  $f_j$  is right smooth, we use the fact that

f_j(g) = \int_{\text{Mat}_{b_j \times a_j}(F)} f'_j\left(gr_j^*(x_j)\right) \varphi_j\left(x_j\right) dx_j,\tag{38}
$$

<span id="page-38-1"></span>where  $f'_j$  satisfies similar properties to  $f_j$  and  $\varphi_j$ :  $\mathrm{Mat}_{b_j \times a_j}(F) \to \mathbb{C}$  is a compactly supported smooth function. In this generalization, [\(38\)](#page-37-2) serves an alternative to [\(36\)](#page-37-1), and after applying steps [2](#page-37-3) and [3,](#page-37-4) we get

$$
I_j(f_j) = I_{j-1}(f_{j-1}),
$$

where

$$
f_{j-1}(g) = \int_{\text{Mat}_{a_j \times b_j}(F)} f'_j(g r_j(y_j)) \mathcal{F}_{\psi} \varphi_j(y_j) dy_j,
$$

and where

$$
\mathcal{F}_{\psi}\varphi_{j}\left(y_{j}\right) = \int_{\mathrm{Mat}_{b_{j}\times a_{j}}(F)} \varphi_{j}\left(x_{j}\right)\psi\left(\mathrm{tr}\left(x_{j}y_{j}\right)\right) \mathrm{d}x_{j}.
$$

The advantage of this generalized version is that it allows one to apply the algorithm in the context of archimedean fields and finite fields.

<span id="page-38-0"></span>B.1. Reduction of integral domain for  $(k, c)$   $\psi$ -functionals. In this subsection, we explain the choice of  $r_i$  and  $r_i^*$  for the integral [\(17\)](#page-18-2) from Section [3.3,](#page-17-0) introduced in [\[4,](#page-39-3) Lemma 9].

\mathcal{X}(R) = \left\{ \begin{pmatrix} I_{kc_1} & X \\ & I_{kc_2} \end{pmatrix} \mid X = \begin{pmatrix} 0_{c_1 \times c_2} & x_{12} & & & \\ 0_{c_1 \times c_2} & x_{13} & x_{23} & & \\ & \vdots & \vdots & \vdots & \ddots & \\ 0_{c_1 \times c_2} & x_{1k} & x_{2k} & \cdots & x_{k-1,k} \end{pmatrix} \mid x_{ij} \in \text{Mat}_{c_1 \times c_2} (R) \right\}.
$$

Let  $\mathcal{Y}_{ij}(R)$  (respectively,  $\mathcal{X}_{ij}(R)$ ) be the subgroup of  $\mathcal{Y}(R)$  (respectively,  $\mathcal{X}(R)$ ) consisting of elements such that  $y_{i'j'} = 0_{c_2 \times c_1}$  (respectively,  $x_{i'j'} = 0_{c_1 \times c_2}$ ) for  $(i', j') \neq (i, j)$ . Let  $r_{i,j}^+$ : Mat<sub>c1</sub>×c<sub>2</sub> (R)  $\to \mathcal{X}_{ij}$  (R),  $r_{i,j}^-$ : Mat<sub>c2</sub>×c<sub>1</sub> (R)  $\to \mathcal{Y}_{ij}$  (R) be the obvious maps.

Let  $(i_1, j_1), \ldots, (i_{\binom{k}{2}}, j_{\binom{k}{2}})$  be the sequence of pairs  $(k-1, k), (k-2, k-1), \ldots, (1, 2),$  $(k-2, k), (k-3, k-1), \ldots, (1, 3), \ldots, (1, k).$ Recall Proposition [3.3.](#page-18-1)

Proposition B.1. *For any*  $\Phi \in \Delta(\mathcal{T}, c) \subset |\det|^{-\frac{c_2}{2}} \Delta(\mathcal{T}, c_1) \times |\det|^{\frac{c_1}{2}} \Delta(\mathcal{T}, c_2)$ *, such that*  $\Phi$  *is right invariant under*  $I_{kc} + \text{Mat}_{kc}(\mathfrak{p}^{r+1})$  *for*  $r \geq 0$ *, we have* 

$$
\left\langle \Phi, \ell_{\Delta(\mathcal{T},c)} \right\rangle = \int_{\mathcal{Y}(\varpi^{-r_{\mathfrak{0}}})} \left\langle \Phi \left( y \kappa \right), \ell_{\Delta(\mathcal{T},c_1)} \otimes \ell_{\Delta(\mathcal{T},c_2)} \right\rangle \mathrm{d}y.
$$

The proof of this proposition follows from the root exchange algorithm by taking  $r_{\binom{k}{2}+1-m} = r_{i_m}^ \sum_{i=m,j_m}^{-1}$  and  $r_{\binom{k}{2}+1-m}^{*} = r_{i_m}^{+}$  $t_{i_m,j_m}^+$  for every  $1 \leq m \leq {k \choose 2}$  $_{2}^{k}$ ). We use the fact that the images of  $r_m^*$  lie in  $\mathcal{X}(F)$ , which is a commutative group, and hence by the first remark in the previous section, we can use the same domain for all variables. The hardest thing to

check is that the relation [\(35\)](#page-37-0) is satisfied. The identity follows the fact that  $\ell_{\Delta(\mathcal{T},c_1)}$  and  $\ell_{\Delta(\mathcal{T}, c_2)}$  are  $(k, c_1)$  and  $(k, c_2)$   $\psi$ -Whittaker functionals, respectively, and from computing

$$
\left(\prod_{t=s}^{k} r_{i_{t},j_{t}}^{-}(y_{i_{t},j_{t}})\right) r_{i_{s},j_{s}}^{+}(x_{i_{s},j_{s}})\left(\prod_{t=s}^{k}\right) r_{i_{t},j_{t}}^{-}(y_{i_{t},j_{t}})\right)^{-1},
$$

where one needs to change variables in the integral for some of the variables. See also a demonstration at <https://elad.zelingher.com/mathapps/gln/rootexchange>.

<span id="page-39-10"></span><span id="page-39-8"></span>B.2. Reduction of integration domain in the dual Ginzburg–Kaplan integral. We explain another application of the root exchange algorithm, used in the proof of Theorem [4.6.](#page-32-1)

**Lemma B.2.** *Suppose that*  $W \in W \left(\Delta \left(\mathcal{T}, c\right), \psi_{\left(c^k\right)}\right)$  *is invariant under right translations of*  $I_{kc}$  + Mat<sub>kc</sub> (p)*. Then for any*  $h \in \text{GL}_c(F)$ *,* 

$$
\int_{\mathrm{Mat}_{c \times (k-2)c}(F)} W \left( \mathrm{diag} \left( I_{(k-1)c}, h \right) \begin{pmatrix} I_c & & \\ & I_{(k-2)c} & \\ & Y & I_c \end{pmatrix} \right) dY
$$
\n
$$
= \int_{\mathrm{Mat}_{c \times (k-2)c}(0)} W \left( \mathrm{diag} \left( I_{(k-1)c}, h \right) \begin{pmatrix} I_c & & \\ & I_{(k-2)c} & \\ & Y & I_c \end{pmatrix} \right) dY.
$$

This lemma is proved using the root exchange algorithm where for  $1 \leq i \leq r$ , the maps  $r_i$ : Mat<sub>c</sub> $(F) \to \mathrm{GL}_{kc}(F)$  and  $r_i^*$ : Mat<sub>c</sub> $(F) \to \mathrm{GL}_{kc}(F)$  are given by

$$
r_i(y) = \begin{pmatrix} I_c & & \\ & I_{(k-2)c} & \\ & ye_i & I_c \end{pmatrix} \quad \text{and} \quad r_i^*(x) = \begin{pmatrix} I_{(k-2)c} & -{}^t e_{i+1}x \\ & I_c & \\ & & I_c \end{pmatrix}.
$$

Here  $e_i = (0_c, \ldots, 0_c, I_c, 0_c, \ldots, 0_c) \in \text{Mat}_{c \times (k-2)c}(F)$  and  $I_c$  is located at the *i*th position.
