
Language Models Show Stable Value Orientations Across Diverse Role-Plays

Abstract

We demonstrate that large language models (LLMs) exhibit consistent value orientations despite adopting diverse personas, revealing a persistent *inertia* in their responses that remains stable across the variety of roles they are prompted to assume. To systematically explore this phenomenon, we introduce the *role-play-at-scale* methodology, which involves prompting LLMs with randomized, diverse personas and analyzing the macroscopic trend of their responses. Unlike previous works that simply feed these questions to LLMs as if testing human subjects, our *role-play-at-scale* methodology diagnoses inherent tendencies in a systematic and scalable manner by: **(1)** prompting the model to act in different random personas and **(2)** asking the same question multiple times for each random persona. This approach reveals consistent patterns in LLM responses across diverse role-play scenarios, indicating deeply encoded inherent tendencies. Our findings contribute to the discourse on value alignment in foundation models and demonstrate the efficacy of *role-play-at-scale* as a diagnostic tool for uncovering encoded biases in LLMs. Our research code is at github.com/brucelee/moral-value-bias.

1 Introduction

Recent advances in large language models (LLMs) have significantly enhanced their capabilities and applications in real-world scenarios, making them increasingly integral to our daily lives. However, one of the primary concerns of these models is their non-deterministic nature, which allows them to generate a variety of responses to the same input. This feature is particularly evident when responding to questions where multiple valid answers exist. For example, the question “*What are the benefits of democracy?*” can elicit different answers reflecting economic, political, and social dimensions (Kovač et al., 2024). Such variability stems from the vast and heterogeneous datasets LLMs consume, enabling them to operate like mixture models that capture complex probability distributions for a single topic and encompass a multitude of viewpoints and opinions. Consequently, subtle nuances in the context or wording may yield different outcomes from a similar query (Ceron et al., 2024).

Prompting and Model Inertia. To harness this characteristic effectively, users often employ prompting - an empirical method where the input to the model is carefully crafted to steer the output toward a desired direction (Louie et al., 2024; Magee et al., 2024; Ng et al., 2024; Stampfl et al., 2024; Tamoyan et al., 2024). Although the internal mechanisms of prompting remain opaque, users iteratively refine their prompts based on the responses, gradually guiding the model toward the preferred outcome.

Despite the flexibility of LLMs in generating diverse responses, there is a tendency among these models to exhibit a sort of *inertia*. This inertia refers to a preference for specific phrasings, tones, or even content types, which could be seen as a central tendency within the model’s outputs. For instance, LLMs often exhibit a consistent preference in their own responses Panickssery et al. (2024) and specific choices of languages or a tendency towards certain cultural perspectives (Adilzuarda et al.,

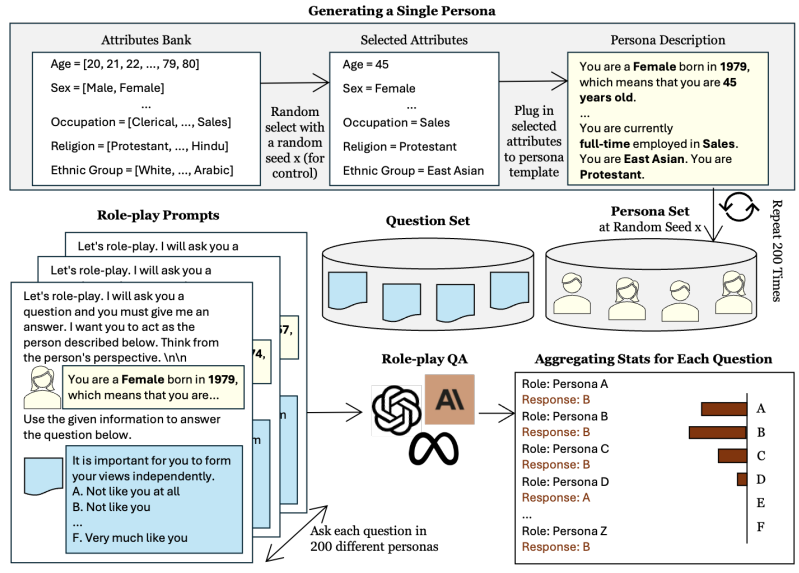


Figure 1: **Overview of the role-play-at-scale methodology.** Diverse personas are systematically generated with key demographic factors such as age, gender, occupation, cultural background, and religious beliefs.

2024). This pattern indicates that these models may inherently favor certain expressions or tones, likely influenced by the predominance of similar traits in their training data. This behavioral pattern suggests that even with varied prompting, the core training of the model still exerts a significant influence on its outputs.

Recent Studies on LLM Tendencies. Recent studies try to reveal these inherent tendencies within LLMs by incorporating insights from human psychology and philosophy to enhance understanding of LLMs (Jiang et al., 2024; Yao et al., 2023). Specifically, researchers have begun analyzing LLMs with questionnaires that are more interpretable to humans (Adilazuarda et al., 2024; Cahyawijaya et al., 2024; Hadar-Shoval et al., 2024; Huang et al., 2023; Pellert et al., 2023; Yang et al., 2024). Some studies employ the Portrait Values Questionnaire to measure basic human values (Kovač et al., 2024; Schwartz, 2012) in dimensions like self-direction and security within LLMs. Despite constant debates over the appropriateness of applying human criteria to machine learning models, LLMs digest a vast amount of textual datasets that are not only complex and abstract but also deeply embedded with social constructs and human-defined abstractions. So, applying human-centered frameworks to capture the nuanced ways in which these models operate and interact is a promising and interesting research area.

Role-Play-at-Scale. In this paper, we aim to verify any presence of certain preferences or inherent tendencies within LLMs regardless of prompting. Our motivation is to verify if it is possible to identify the central tendency of the distribution by drawing multiple samples from diverse prompts, which may steer the output distribution in a randomized direction. Specifically, we construct randomized and diversified personas that reflect various key demographic factors—such as age, gender, occupation, cultural background, and religious beliefs—which can significantly affect outputs (Shao et al., 2023). These personas are integrated into LLMs through structured prompts, allowing LLMs to steer the response in a randomized direction depending on each individual persona. To probe the LLMs’ response tendencies, these personas respond to renowned survey-style psychological tests (Schwartz and Cieciuch, 2022), known for their sensitivity to demographic influences. For instance, when the persona of a young Asian female doctor and an elderly Hispanic male farmer are presented with the same ethical dilemma, their responses can differ significantly, highlighting the LLMs’ ability to adapt to varied viewpoints.

Despite the varied and random assignment of persona descriptions, the responses of role-played language models tend to converge towards specific values and moral beliefs, pointing to an inherent inertia within the models. This consistent orientation, illustrated in Figure 1, suggests an underlying

uniformity in the models’ responses regardless of the diverse inputs. Further extensive experiments validate that our technique not only consistently reveals these tendencies but also provides insights into the stable value orientations of LLMs across different simulated roles. This paper is crucial and timely for the field as it not only highlights a novel methodology for detecting inherent tendencies in LLM but also advances our understanding of the underlying value systems that influence behavior, contributing to the discourse on ethical LLM (Kumar et al., 2024; Meadows et al., 2024).

2 Role-Play-at-Scale

One central motivation behind this research is to explore the largely uncharted territory of macroscopic LLM behavior under an overly random and diverse role-play setup, which differs from the more common approach of using role-play with a specific intention to steer LLM behavior in a certain direction (Shao et al., 2023; Wang et al., 2023a; Xu et al., 2024). While role-playing with a specific goal to elicit certain behaviors and evaluating the results is a valuable technique, it does not provide insights into the macroscopic trends that emerge when LLMs are subjected to diverse and randomized role-play scenarios repeatedly.

To address this gap in understanding, we propose the role-play-at-scale method for detecting inherent tendencies and inertia in LLMs. This approach involves engaging LLMs in a wide range of persona-driven interactions, where the models are prompted to respond from the perspective of randomly generated persons with diverse demographic backgrounds. These personas have random and diverse attributes, as also depicted in Table 1. By analyzing the consistency of the models’ responses across these varied scenarios, we aim to identify stable tendencies and inertia that are inherent to the LLMs themselves rather than being influenced by any specific persona or situation.

Table 1: **Demographic attributes and their corresponding values** used to generate diverse personas for the role-play-at-scale methodology. The personas are created by randomly selecting a value for each attribute, ensuring a wide range of demographic backgrounds are represented in the role-play.

As illustrated in Figure 1, the role-play-at-scale method is rather straightforward. The process begins by creating multiple sets of distinct personas, each containing a large number of randomly generated persona descriptions. The LLM is then prompted to respond to the same question while role-playing as each persona in each set. By examining the macroscopic trends in the LLM’s responses across these diverse persona contexts, we can uncover the inherent tendencies and inertia that influence the LLM’s behavior, even when exposed to a wide range of scenarios.

To validate the effectiveness and feasibility of the role-play-at-scale approach, we pose two key research questions. The first question, *Is there a response trend when exposed to repeated and randomized role-playing setups?* investigates whether LLMs exhibit consistent behavior trends when exposed to repeated and randomized role-playing scenarios. Building upon this, the second question, *Does the preference persist through different persona sets?* assesses the persistence of these trends across different persona sets.

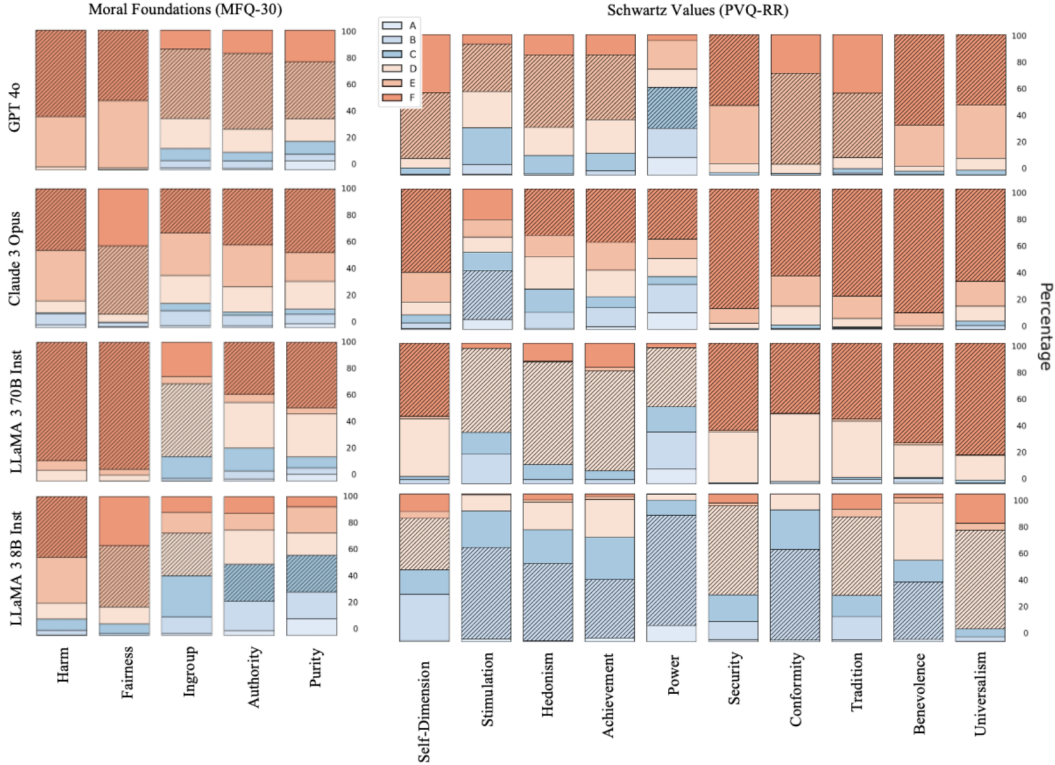


Figure 2: **Macroscopic view: LLMs show bias under random role-playing.** Results from four models, each prompted 200 times with random personas. Bars show the percentage of responses for each option per moral/value dimension. Striped bars highlight the most frequently chosen, revealing consistent preferences despite random personas. Full results in Appendix.

3 Q1: Is there a response trend when exposed to repeated and randomized role-playing setups?

As an application of the role-play-at-scale framework, we present the experiments conducted on the Revised Portrait Values Questionnaire (PVQ-RR) (Schwartz et al., 2012) and Moral Foundations Questionnaire (MFQ-30) (Graham et al., 2008). The choice of these questionnaires is intentional, as both are directly ported from human-subject psychology tests and have been the subject of much debate in the field regarding the validity of such practices when applied to LLMs (Kovač et al., 2023; Lu et al., 2024a).

Our understanding of the main contested points is that: (A) the stability of the induced LLM response direction and (B) the validity of trusting LLM self-reports, which may be subject to AI deception, a widely reported phenomenon in the AI safety community (Lin et al., 2021; Park et al., 2024; Perez et al., 2022; Turpin et al., 2024). However, role-play-at-scale is designed to be more robust to the issue (B) by aggregating statistics rather than relying on individual LLM responses. In this section, we aim to demonstrate that (A) is achievable through our experiments.

Our role-play prompt consists of two components: Question and Persona (**Prompt Template A**). This template instructs the language model to role-play as a specific person and answer a question from that perspective. It includes placeholders for {Persona} and {Question} and specifies that the response should always point to a specific letter option. The Question component is derived from two well-established psychological questionnaires: PVQ-RR, a 57-item questionnaire measuring ten basic value characteristics, and MFQ-30, a 32-item questionnaire assessing five foundational moral dimensions (Graham et al., 2008; Schwartz, 2012). Using these questionnaires does not imply that LLMs are equivalent to individual humans; rather, they serve as a means to characterize and understand these models' behavior and inherent tendencies in a more interpretable way.

All statements are from MFQ-30.

Both questionnaires present a statement and then ask the respondent to reply with one of six options that reflects how much the statement applies to them. These options are ordinal categorical data, with MFQ-30 using A: "Not at all relevant," B: "Not very relevant," C: "Slightly relevant," D: "Somewhat relevant," E: "Very relevant," F: "Extremely relevant", and PVQ-RR using A: "Not like you at all," B: "Not like you," C: "A little like you," D: "Moderately like you," E: "Like you," F: "Very much like you".

The Persona component involves generating diverse persona descriptions using **Prompt Template B**. This template creates a detailed profile of a person, including information such as their sex, age, country of origin and residence, income level, marital status, whether they have children, education level, employment status, occupation group, ethnic group, and religious denomination (Table 1). These traits are selected from the World Values Survey respondent variables to reflect systematic diversity (Haerper et al., 2020).

We test seven models: Claude 3 Opus, Claude 3 Sonnet, Claude 3 Haiku, GPT 4o, GPT 3.5 Turbo, LLaMA 3 70B Inst, and LLaMA 3 8B Inst. For each model, we randomly generate 200 personas and ask the same question 200 times, each time with a different persona. It is worth noting that although this experiment is conceptually simple, it requires a substantial number of API calls.

Given the extensive previous literature on how role-playing can effectively steer LLM behavior, one might expect LLMs to respond very diversely when asked the same question with 200 different personas (Hu and Collier, 2024; Lu et al., 2024b; Tseng et al., 2024; Wu et al., 2024). However, our results demonstrate that this is not always the case, challenging the assumption that diverse role-playing scenarios necessarily lead to equally diverse responses from LLMs.

Observation: Inertia under random role-playing. Our findings reveal that LLM responses tend towards particular options or sides despite the randomly generated personas used for role-playing. This observation holds true across all tested models and moral/value dimensions, as evidenced by Figure 2. When interpreting the figure, it is essential to keep in mind that options A to F are designed in an ordinal-categorical manner. Examples of MFQ-30 and PVR-RR are in the Appendix.

The results challenge the intuitive assumption that exposing LLMs to diverse role-playing scenarios would lead to equally diverse responses. Given the rich literature on how role-playing can effectively steer LLM behavior, one might expect LLMs to respond in a more varied manner when asked the same question with 200 different personas. However, we observe consistent tendencies towards certain options despite the randomness of the personas. That is, most bars in Figure 2 were heavily skewed towards one option for each moral foundation or value dimension.

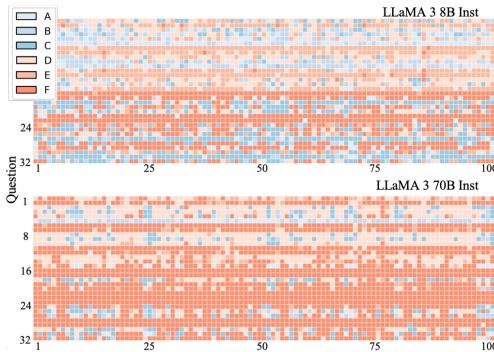


Figure 3: Heatmap Visualizer: LLM responses are biased under a randomized role-playing scenario. Continued from Figure 2, we report role-play-at-scale results across four models in this figure on MFQ-30 for the first 100 personas. The Y-axis stacks questions, and the X-axis stacks personas, where color refers to each option label. Notice the several horizontal stripes observed in both heat maps, and the role-played LLM’s response stayed consistent despite the randomly changing role-play persona.

To provide a more granular view of this phenomenon, we present a question-by-question breakdown of Figure 2 in the Appendix. These figures offer a detailed look at the response patterns for individual questions, as opposed to the grouped total reporting on all questions corresponding to each category

in Figure 2. This preference is also evident in our heatmap visualizer in Figure 3, which clearly shows persistent horizontal stripes throughout the diverse role-play scenarios. These horizontal stripes suggest the presence of very persistent tendencies despite the randomized roles assumed by the LLMs.

Observation: Strong preferences for some statements. Motivated by the consistent horizontal stripes in Figure 3, we investigated the statements that LLMs strongly agreed with, measuring the percentages (out of 200 role-plays per question) where the LLM responded “Extremely Relevant (to me)” for MFQ-30 or “Very much like you” for PVQ-RR.

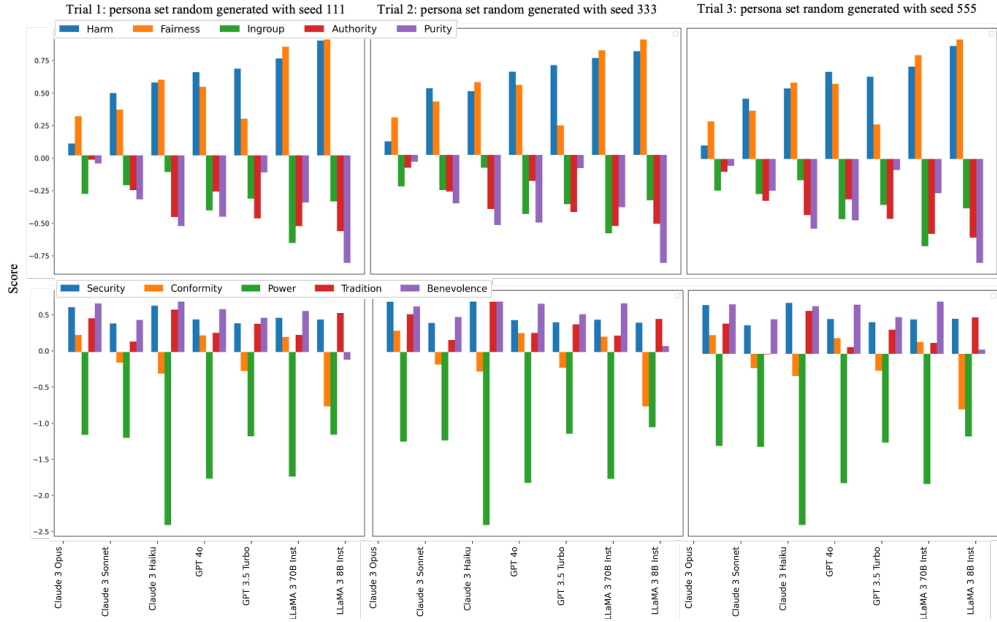


Figure 4: Role-play-at-scale produces stable bias projections across different persona sets. The figure displays the average scores for each moral foundation (MFQ-30) and value dimension (PVQ-RR) across three persona sets, generated using random seeds 111, 333, and 555. The stability of the scores across the persona sets demonstrates the robustness of the role-play-at-scale method in capturing consistent bias projections from the language models.

Interestingly, all tested LLMs placed greater importance on avoiding harm and ensuring fairness than loyalty to one’s ingroup, respecting authority, or maintaining purity. This finding is also illustrated in Figure 4 and is consistent with other studies reporting liberal-leaning political tendencies in LLMs (Bang et al., 2024; Ceron et al., 2024; Motoki et al., 2024). It also aligns with the hierarchical classification of values, where harm and fairness are considered individualizing, while ingroup, authority, and purity are binding values (Zakharin and Bates, 2021).

Some popular LLMs, such as Claude 3 Sonnet and GPT 4o, showed similar patterns of strong agreement with certain moral statements, like “One of the worst things a person could do is hurt a defenseless animal” (related to the harm dimension). This trend is analogous to reports from other studies (Santurkar et al., 2023). Table 2 showcases examples of statements that elicited high levels of agreement from these models, with the full results provided in the Appendix. These findings suggest that LLMs have developed certain moral priorities and preferences, potentially shaped by their training process and human feedback.

Computing scores from MFQ-30 and PVQ-RR. Building upon the question-by-question analysis, we compute moral-value scores from MFQ-30 and PVQ-RR using the Mean Rating (MRAT) correction, a standard method in psychological surveys that adjusts for individual differences in scale use (Schwartz and Cieciuch, 2022). This process involves calculating the average rating across all items for each moral-value dimension, centering the scores around the mean. For PVQ-RR (57 items, 10 value dimensions) and MFQ-30 (30 items, 5 moral dimensions), LLMs rate the similarity of each statement to the persona on a scale from 0 to 5. The MRAT is then calculated by averaging these ratings for each dimension. The resulting scores enable meaningful comparisons across language models, with positive scores indicating higher importance and negative scores indicating lower importance. This approach allows us to quantify inherent biases within LLMs and compare them across models.

In the next section, we show the stability of the scores calculated using role-play-at-scale, addressing the limitations of previous research utilizing the same benchmarks.

4 Q2: Does the preference persist through different persona sets?

Having established the presence of consistent response trends in LLMs exposed to repeated and randomized role-playing setups, we now turn our attention to the second research question: Does the uncovered preference persist through different persona sets? This question is crucial for assessing the robustness and reliability of the role-play-at-scale method in uncovering stable tendencies within LLMs.

If the observed preferences remain consistent across multiple, distinct sets of randomly generated personas, it will provide strong evidence for the existence of inherent tendencies within the LLMs that

are not merely a product of the specific characteristics of the personas used in each set. On the other hand, if the observed preferences vary significantly across different persona sets, it would indicate that the tendencies are more sensitive to the specific characteristics of the personas and less likely to be deeply rooted within the models themselves. In such a case, the reliability of the role-play-at-scale method in uncovering inherent tendencies would be called into question, and further investigation would be necessary to determine the factors influencing the variability in preferences.

Observation: Role-play-at-scale induces stable bias projections across different persona sets. To quantify the stability of the observed tendency direction and intensity between persona sets (each with 200 persona descriptions), we measured score differences between three random-generated persona sets generated from random seeds 111, 333, and 555. Figure 4 shows that the average scores for each moral foundation and value dimension remain highly consistent across the three persona sets. This stability suggests that the role-play-at-scale method effectively captures the stable tendencies of the LLMs rather than being heavily influenced by the specific characteristics of the randomly generated personas. The minimal variation in scores across the persona sets supports the robustness and reliability of the bias projections obtained through this approach.

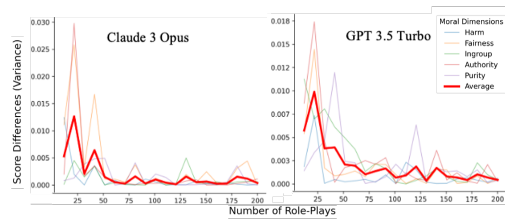


Figure 5: More role-play leads to less variance. We report measured score differences between three persona sets, generated from random seeds 111, 333, 555. MFQ-30 shown.

Observation: More role-play induces more stable projections. We also observe that as the number of role-plays with randomized personas increases, score variances decrease, indicating convergence, as shown in Figure 5. This finding has several key implications for the role-play-at-scale framework: (1) It demonstrates that a sufficient number of role-playing scenarios leads to a stable assessment of inherent LLM tendencies. The decreasing variability in scores suggests that these tendencies are consistent patterns from the LLMs’ underlying structures rather than artifacts of specific persona combinations. (2) The convergence of scores with more

role-plays supports the validity of the role-play-at-scale approach. Crucially, this is not a random selection scenario where we would expect variance to naturally decrease with sample size. Instead, each role-play actively attempts to steer the model’s behavior in a different direction through diverse personas. The fact that we still observe convergence despite this intentional variance in input strongly suggests we are uncovering genuine, stable tendencies within the LLM. (3) The reduction in variance highlights the importance of using a sufficiently large and diverse set of personas in the role-play-at-scale framework.

5 Related Work

Human Values, though not universally defined, drive individual behavior and are key in comparative cultural studies. Schwartz’s Theory of Basic Human Values Schwartz (2012) is particularly influential, proposing ten universal value types. The Moral Foundations Questionnaire assesses moral values based on five key dimensions: Harm, Fairness, Ingroup, Authority, and Purity (Graham et al., 2008). This tool helps measure how individuals prioritize these dimensions, offering insights into their moral reasoning (Borenstein et al., 2024; Osman and d’Inverno, 2024).

Evaluation of LLMs with Human Values. As LLMs evolve, assessing them through human value systems is gaining attention (Ji et al., 2024; Qiu et al., 2024; Tlaie, 2024). This research area bridges human values and machine learning, evaluating LLMs’ alignment with ethical frameworks. Santy et al. (2023) explore cultural tendencies in LLMs, Cao et al. (2023) use the Hofstede Culture Survey Hofstede (1984) to examine cultural patterns, and Abdulhai et al. (2023) apply traditional ethical frameworks Graham et al. (2008); Shweder et al. (2013) to probe moral alignments. Challenges remain, such as the ‘agreeableness bias’ discussed by Dorner et al. (2023), and variability in responses due to prompt phrasing highlighted by Gupta et al. (2023). These underscore the need for LLM-specific frameworks for accurate value alignment assessments (Biedma et al., 2024; Yao et al., 2024).

Role-Play in LLMs. LLMs can mimic complex characteristics, leading to research on role-play simulations. Wang et al. (2023b) introduced a dataset with prompts for 100 diverse characters, and Zhou et al. (2023) created a large corpus of human-annotated role-playing data. Our research examines LLMs’ consistency in character traits across scenarios, highlighting inherent tendencies and variations.

6 Limitations and Discussion

In this section, we discuss some limitations in our work that we identified. One limitation is the absence of human baseline data in our study. We acknowledge that comparing LLM responses to human responses could provide additional context for interpreting our results. However, our study focuses on uncovering inherent tendencies within LLMs rather than comparing them to human norms. The rationale for not including human baseline comparisons is rooted in the fundamental differences between human cognition and LLM processing (Johnson and Verdicchio, 2024). LLMs, unlike humans, do not have personal experiences, emotions, or cultural backgrounds that shape their responses (Lee and Lim, 2024; Zimmerman et al., 2024). Instead, their outputs are based on patterns learned from vast amounts of training data. Therefore, direct comparisons between LLM and human responses may not always be meaningful or appropriate.

Another limitation of our methodology is its reliance on multiple-choice questionnaires. While these questionnaires are well-established in psychological research and provide a structured way to assess values and moral foundations, they may not capture more nuanced or complex aspects of ethical reasoning and decision-making. The use of pre-defined options in multiple-choice questions may limit the range of responses and potentially miss subtle variations in LLM outputs. This limitation is particularly relevant when considering more nuanced types of tendencies that may not be easily categorized into discrete options.

Lastly, it’s important to note that these findings may not fully reflect LLM behavior in real-world applications. While necessary for systematic analysis, the controlled nature of our experiments may not capture the full complexity of real-world interactions and contexts. Future research could focus on bridging this gap by conducting studies in more naturalistic settings or with real-world data, exploring how the observed tendencies manifest in different types of tasks.

7 Conclusion

Our research introduces a novel role-play-at-scale framework to uncover stable tendencies within LLMs. By systematically role-playing LLMs with diverse, randomized personas while responding to psychological questionnaires, we demonstrate consistent value and moral preferences that persist across various contexts. These tendencies appear deeply rooted in the models, not artifacts of specific scenarios.

While our study has limitations, as discussed in the previous section, we believe that it opens up new avenues for research into AI behavior and ethics. Future work should address these limitations, expand the methodology to capture more nuanced tendencies and explore the implications of these findings for real-world AI applications.

C Parsing LLM Responses

Querying LLMs with role-play prompts, as described in Appendix B, does not always lead to single-letter responses like A, B, C, or D. Most LLMs that we use are tuned to generate more lengthy, helpful responses, and it takes an extra layer of effort to *parse* these responses into an option. Throughout our research, we utilize the Nutcracker library (<https://github.com/brucelee/nutcracker>) to facilitate our evaluation framework and employ the Claude 3 Haiku model to parse LLM responses.

To validate this approach, we manually assess the parsing error by having one of the authors review the parsing results for Claude 3 Haiku responses on the PVQ-RR and MFQ-30 tests without role-playing. We assess 89 items in total. The results are as follows:

PVQ-RR:

- Claude 3 Haiku: 94.74%
- Claude 3 Sonnet: 92.98%
- Command R Plus: 92.98%
- ChatGPT: 94.74%
- GPT-4: 92.98%

MFQ-30:

- Claude 3 Haiku: 100%
- Claude 3 Sonnet: 100%
- Command R Plus: 100%
- ChatGPT: 100%
- GPT-4: 100%

In a larger-scale test, where we compared the five parsing models’ results of around 800 items, we found no significant advantage in using a more powerful parsing model. Hence, we use Claude 3 Haiku throughout our research to parse responses.

D License, Scientific Artifacts, API Hyperparameters

PVQ-RR is licensed under Creative Commons Attribution-Noncommercial-No Derivative Works 3.0 License, and Nutcracker library is licensed under Apache-2.0. We could not find a license term for MFQ-30, but this questionnaire is freely available at <https://moralfoundations.org/questionnaires/> and is widely used in academia. We accessed all APIs (“gpt-3.5-turbo-0125”, “gpt-4o-2024-05-13”, “anthropic.claude-3-opus-20240229-v1:0”, “anthropic.claude-3-sonnet-20240229-v1:0”, “anthropic.claude-3-haiku-20240307-v1:0”, “meta.llama3-70b-instruct-v1:0”, “meta.llama3-8b-instruct-v1:0”) between April 2024 and June 2024. We access Claude and LLaMA models through Amazon Bedrock and OpenAI models through the official OpenAI API. We use default settings for all APIs, with no hyperparameter searches.

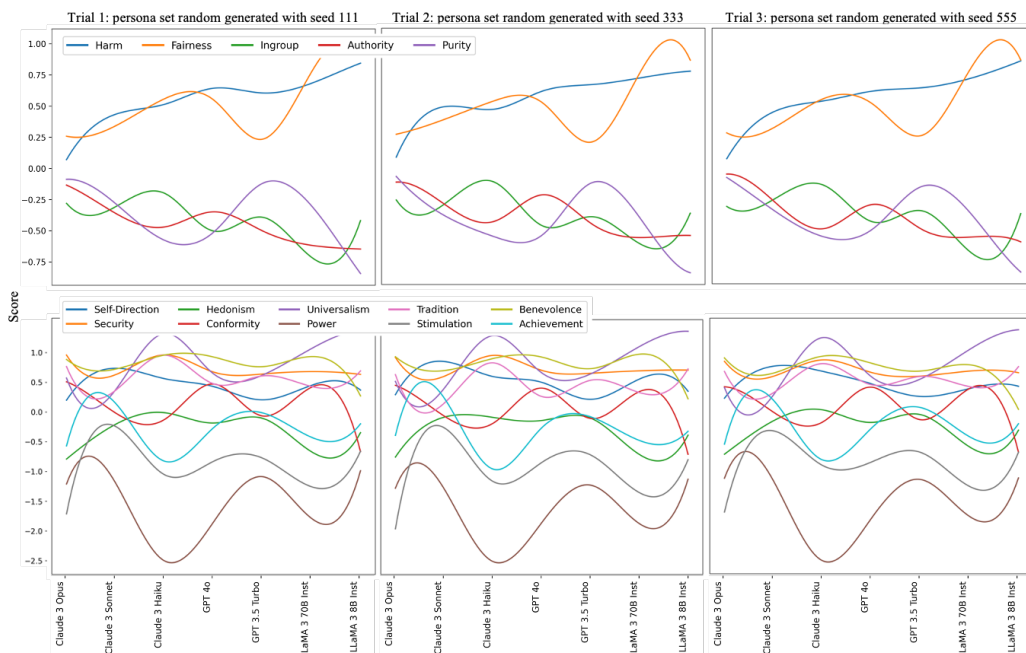


Figure 6: **Continuation from Figure 4.** The figure displays the average scores for each moral foundation (MFQ-30) and value dimension (PVQ-RR) across three persona sets, generated using random seeds 111, 333, and 555. The stability of the scores across the persona sets demonstrates the robustness of the role-play-at-scale method in capturing consistent bias projections from the language models.

E Moral-Value Scores

We compute scores for each moral-value dimension from MFQ-30 and PVQ-RR, which is standard practice when using these questionnaires. The calculated scores are shown in Table 3 to give a more concrete idea. By calculating these scores, we can gain further insights by ranking the importance the LLM assigns to each value or moral foundation. To quantify these biases, we apply the Mean Rating (MRAT) correction to the LLM responses.

PVQ-RR consists of 57 items and measures 10 value dimensions, while MFQ-30 contains 30 items and assesses 5 moral dimensions. After the LLMs respond to each item by rating the similarity of the statement to the persona (with numerical values assigned to the response options ranging from a = 0

to $f = 5$), the MRAT is calculated by averaging the ratings across all items for each dimension. This procedure is a standard method in psychological surveys to adjust for individual differences in scale use (Schwartz and Cieciuch, 2022). By centering the scores around the mean, MRAT enables more meaningful comparisons across language models, with positive scores indicating higher importance and negative scores indicating lower importance.

The application of MRAT to the role-play-at-scale approach allows us to quantify the inherent biases within the LLMs and compare them across different models. We demonstrate that the scores calculated using role-play-at-scale are stable, addressing the limitations of previous research utilizing the same benchmarks. This stability further supports the notion that the biases uncovered through our approach are inherent to the LLMs and not merely a product of the specific role-playing scenarios or prompts used.

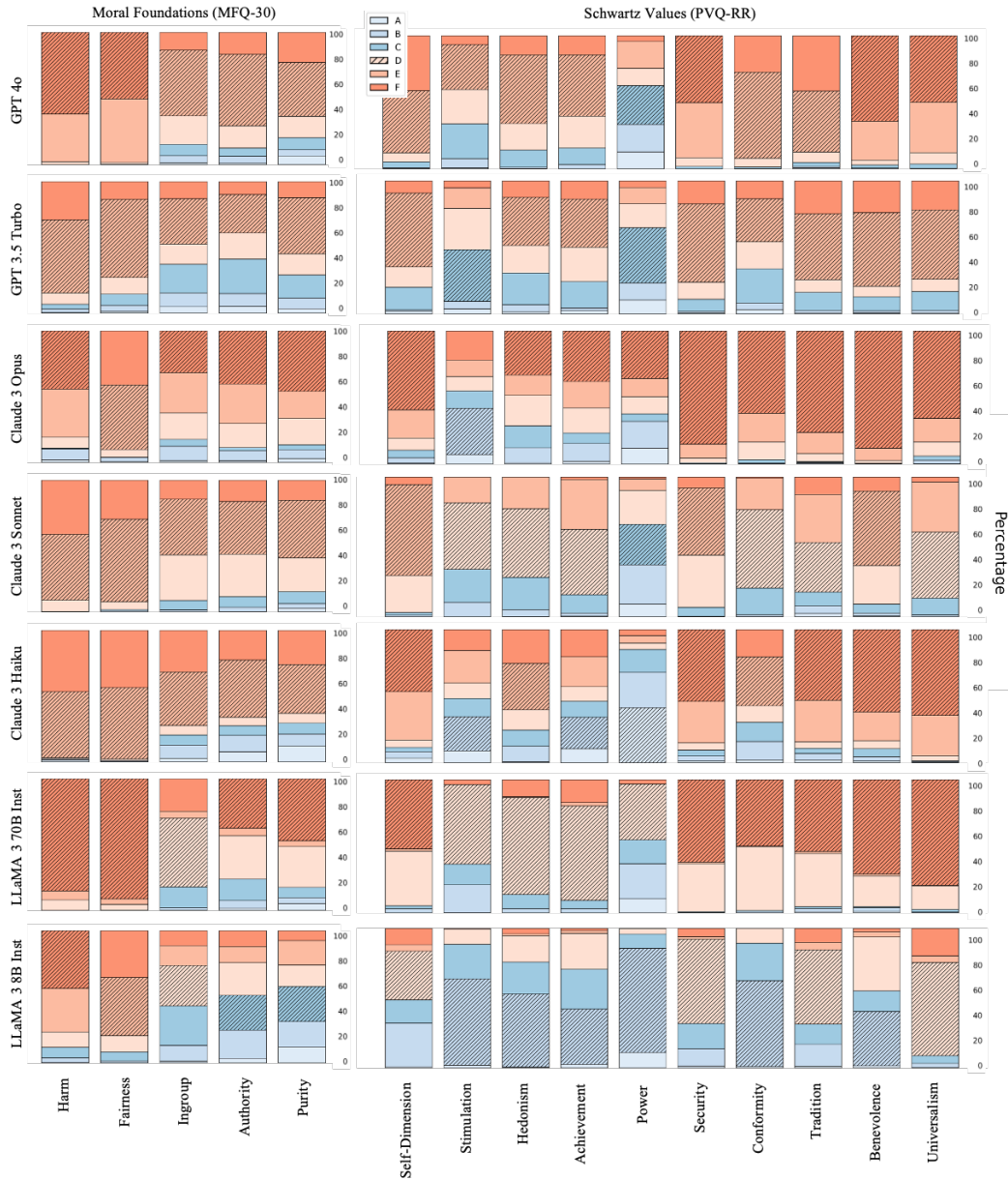


Figure 7: **Continued from Figure 2.** We report role-play-at-scale results across four models in this figure. LLMs were asked each question 200 different times with a random persona role-play prompt. Each moral/value dimension is a set of questions and we report combined percentages. The percentage depicts how many times the LLM responded with a certain option. On the microscopic level, we observe that LLM responses are very skewed to one option, or one side, even though the personas used for role-playing were generated in a perfectly random manner.

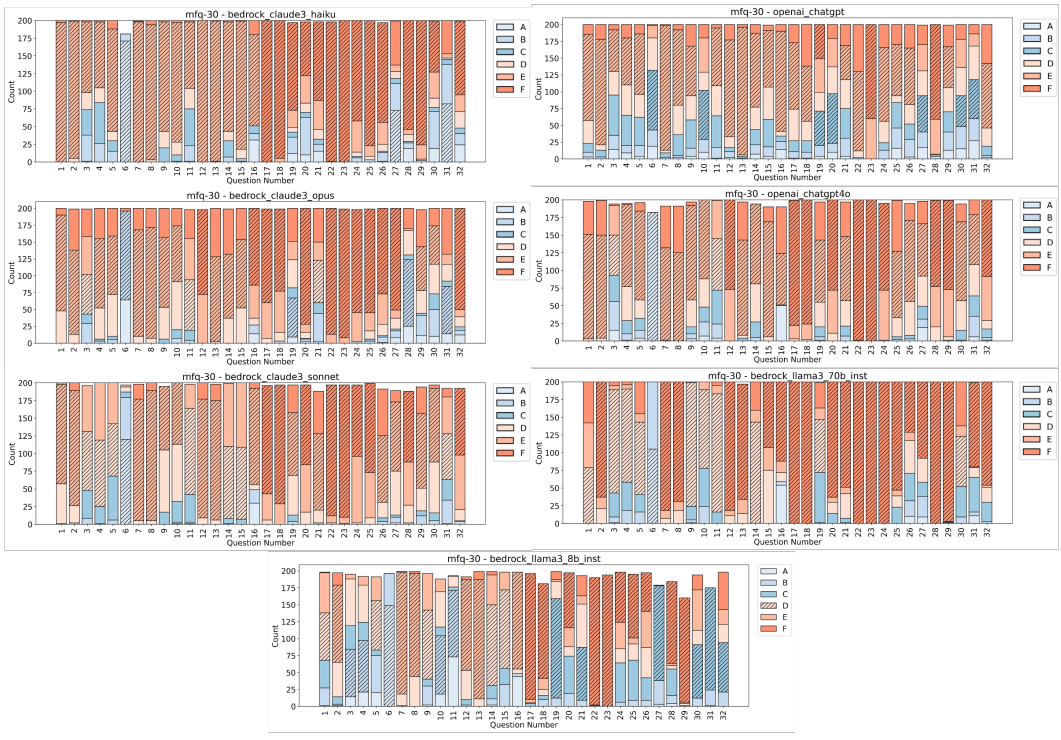


Figure 8: **Breakdown of Figure 7.** MFQ-30 results on seven models. Each moral question was asked 200 different times with 200 random role-play prompts.

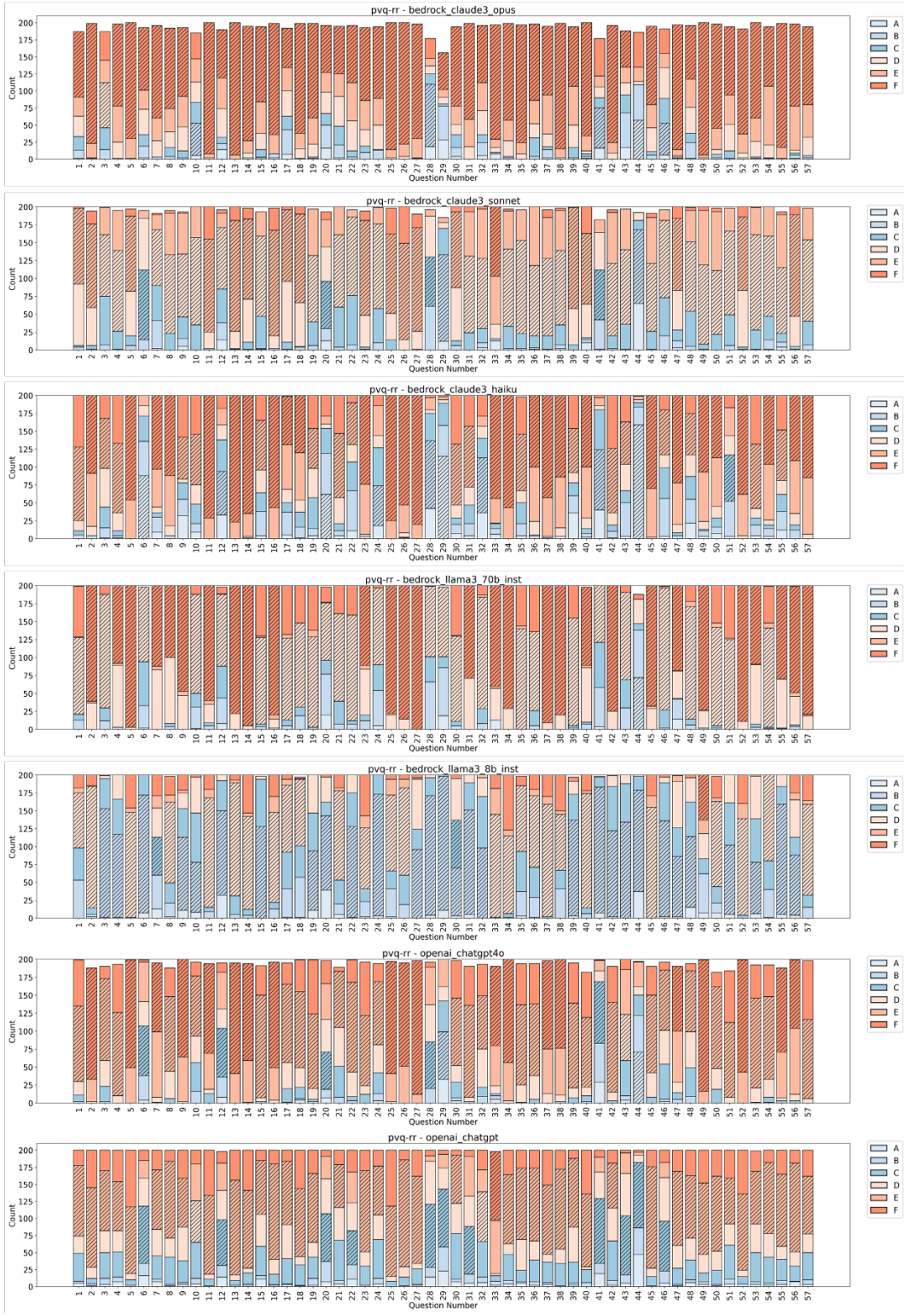


Figure 9: **Breakdown of Figure 7.** PVQ-RR results on seven models. Each value question was asked 200 different times with 200 random role-play prompts.
