M_d-MULTIPLIERS OF A LOCALLY COMPACT GROUP

ABSTRACT. We show that the space $M_d(G)$ of M_d -multipliers of a locally compact group G is isometrically isomorphic to the Banach space of bounded functionals on the d-fold Haagerup tensor product of $L^1(G)$ vanishing on the kernel of the convolution map. Consequently, we see that $M_d(G)$ is isometrically isomorphic to the dual space of $X_d(G)$, the completion of $L^1(G)$ in the dual of $M_d(G)$. We also show that M_d -type-approximation-properties are inherited to lattices.

INTRODUCTION

In [Pis05], a commutative Banach algebra $M_d(\Gamma)$ was introduced in pursuit of studying Dixmier's Similarity Problem, where Γ is a discrete group and d is an integer greater than one. When d = 2, this is the algebra of Herz-Schur multipliers of Γ . In general, $M_d(\Gamma)$ stands between the Fourier-Stieltjes algebra $B(\Gamma)$ and the algebra of bounded functions $\ell^{\infty}(\Gamma)$. By the usual $(\ell^{\infty}(\Gamma), \ell^1(\Gamma))$ -duality, we can embed $\ell^1(\Gamma)$ in the dual of $M_d(\Gamma)$. Denote by $X_d(\Gamma)$ the completion of $\ell^1(\Gamma)$ in $M_d(\Gamma)^*$. Pisier showed in [Pis05] that $M_d(\Gamma) \cong X_d(\Gamma)^*$ isometrically using Paulsen-Smith's theorem [PS87]. In essence, it means the space $M_d(\Gamma)$ can be alternatively described as the dual of a quotient of the *d*-fold Haagerup tensor product of $\ell^1(\Gamma)$.

This last construction can be performed for a locally compact group G by using $L^1(G)$ instead of $\ell^1(\Gamma)$. However, as indicated in [Pis05, Remark after Theorem 2.10], it is not clear how the functionals in this space would correspond to (continuous) functions on G. In the discrete case, this correspondence was clear because Γ is naturally contained in $\ell^1(\Gamma)$. We elaborate on this problem for locally compact second countable groups.

In [Bat23a], the author defined the space $M_d(G)$ of M_d -multipliers of a locally compact group G as the subspace of all continuous functions in $M_d(G_d)$, where G_d denotes the discrete realization of G. More precisely:

Definition 0.1. Let G be a locally compact group. A bounded continuous function φ on G is called an M_d -multiplier if there exist Hilbert spaces $\mathcal{H}_0, \ldots, \mathcal{H}_d$ and bounded maps $\xi_i : G \to \mathcal{B}(\mathcal{H}_i, \mathcal{H}_{i-1})$ for $i = 1, \ldots, d$ such that $\mathcal{H}_0 = \mathcal{H}_d = \mathbb{C}$ and

(0.1)
$$\varphi(x_1 \cdots x_d) = \xi_1(x_1) \cdots \xi_d(x_d)(1) \quad \text{for all} \quad x_1, \dots, x_d \in G.$$

We denote by $M_d(G)$ the space of all M_d -multipliers and endow it with the norm

$$\|\varphi\|_{M_d} = \inf \prod_{i=1}^d \|\xi_i\|_{\infty}$$

where the infimum is taken over all \mathcal{H}_i 's and ξ_i 's satisfying (0.1).

This definition is compatible with the definition given by Pisier for discrete groups. Because the identity map $M_d(G_d) \to \ell^{\infty}(G_d)$ is contracting, $M_d(G) = M_d(G_d) \cap C(G)$ becomes a commutative Banach algebra. Our main result is the following, which demonstrates that the two previously mentioned constructions of $M_d(G)$ are the same for locally compact second countable groups.

Theorem 0.2. Let G be a locally compact second countable group and let d be an integer greater than one.

(1) If φ is an M_d -multiplier of G, i.e. $\varphi \in M_d(G) = M_d(G_d) \cap C(G)$, then there is a bounded functional $\hat{\varphi}$ on $L^1(G) \otimes_h \cdots \otimes_h L^1(G)$ such that $\|\hat{\varphi}\| = \|\varphi\|_{M_d}$ and

$$\hat{\varphi}(f_1 \otimes \cdots \otimes f_d) = (\varphi, f_1 \ast \cdots \ast f_d)_{(L^{\infty}(G), L^1(G))}$$

for all $f_1, \ldots, f_d \in L^1(G)$.

(2) Conversely, if ϕ is a bounded functional on $L^1(G) \otimes_h \cdots \otimes_h L^1(G)$ vanishing on the kernel of the convolution map $\operatorname{conv}_d : L^1(G) \otimes \cdots \otimes L^1(G) \to L^1(G)$, then there is an M_d -multiplier $\check{\phi} \in M_d(G)$ such that $\|\check{\phi}\|_{M_d} = \|\phi\|$ and

$$(\phi, f_1 * \cdots * f_d)_{(L^{\infty}(G), L^1(G))} = \phi(f_1 \otimes \cdots \otimes f_d)$$

for all $f_1, \ldots, f_d \in L^1(G)$.

Moreover, we have $\varphi = \check{\varphi}$ and $\phi = \check{\phi}$.

If we restrict the $(L^{\infty}(G), L^{1}(G))$ -duality on $M_{d}(G)$, we can embed $L^{1}(G)$ in $M_{d}(G)^{*}$. Denote by $X_{d}(G)$ the completion of $L^{1}(G)$ in $M_{d}(G)^{*}$. After Theorem 0.2 and Paulsen-Smith's theorem, it is easily seen that $X_{d}(G)$ is a Banach predual of $M_{d}(G)$.

Theorem 0.3. Let G be a locally compact second countable group and let d be an integer greater than one. Then we have $M_d(G) \cong X_d(G)^*$ isometrically.

This duality between $M_d(G)$ and $X_d(G)$ was used in [Ver23, Bat23b] to define M_d type approximation properties. We recall the definitions.

Definition 0.4 (M_d type approximation properties). Let G be a locally compact group and let d be an integer greater than one.

We say that G has M_d -approximation-property $(M_d$ -AP in short) if there is a net (φ_i) of functions in $C_c(G) \cap M_d(G)$ such that $\varphi_i \to 1$ in $\sigma(M_d(G), X_d(G))$ -topology.

We say that G is M_d -weakly-amenable $(M_d$ -WA in short) if there is a net (φ_i) of functions in $C_c(G) \cap M_d(G)$ such that $\sup_i \|\varphi_i\|_{M_d} \leq C < \infty$ and $\varphi_i \to 1$ in $\sigma(M_d(G), X_d(G))$ topology. The number $\Lambda_{CH}(G, d) = \inf C$ is called the M_d -Cowling-Haagerup constant. We conventionally write $\Lambda_{CH}(G, d) = \infty$ if G is not M_d -WA.

We say that G has M_d -weak-Haagerup-property (M_d -WH in short) if there is a net (φ_i) of functions in $C_0(G) \cap M_d(G)$ such that $\sup_i \|\varphi_i\|_{M_d} \leq C < \infty$ and $\varphi_i \to 1$ in $\sigma(M_d(G), X_d(G))$ -topology. The number $\Lambda_{WH}(G, d) = \inf C$ is called the M_d -weak-Haagerup constant. We conventionally write $\Lambda_{WH}(G, d) = \infty$ if G does not have M_d -WH.

When d = 2, these are exactly the usual approximation property, weak amenability, and weak Haagerup property [DCH85, CH89, HK94, Knu16, Haa16]. Allow us to mention a couple of motivations to study M_d type approximation properties in general extent. The first one is related to the Similarity Problem: A group with M_d -AP for all $d \in \mathbb{N}$ has an affirmative answer to the Similarity Problem [Ver23, Theorem 1.2]. The second one is their stability: M_d type approximation properties are stable under von Neumann equivalence [Bat23b], hence also under Measure equivalence and W^{*}-equivalence. See [IPR24, Ish24, Bat23a, Bat23b] for more about von Neumann equivalence.

The following result allows one to relax the convergence conditions in the definition of M_d -WA and M_d -WH.

Proposition 0.5. Let G be a locally compact second countable group and let d be an integer greater than one. Then G is M_d -WA if and only if there is a net (φ_i) of functions in $C_c(G) \cap M_d(G)$ such that $\sup_i \|\varphi_i\|_{M_d} \leq C < \infty$ and $\varphi_i \to 1$ uniformly on compact subsets. We have $\inf C = \Lambda_{CH}(G, d)$. Similarly, G has M_d -WH if and only if there is a net (φ_i) of functions in $C_0(G) \cap M_d(G)$ such that $\sup_i \|\varphi_i\|_{M_d} \leq C' < \infty$ and $\varphi_i \to 1$ uniformly on compact subsets. We have $\inf C' = \Lambda_{WH}(G, d)$.

A key step in proving Theorem 0.2 is Lemma 1.3 in which we observe that we can choose the maps $\xi_i : G \to \mathcal{B}(\mathcal{H}_i, \mathcal{H}_{i-1})$ in Definition 0.1 to be continuous where $\mathcal{B}(\mathcal{H}_i, \mathcal{H}_{i-1})$ is endowed with the weak operator topology. Proposition 0.5 is a simple consequence of this observation. Since the uniform convergence on compact subsets pass to closed subgroups via the restriction map, the following is immediate.

Corollary 0.6. If G is a locally compact second countable group and H is a closed subgroup of G, then we have $\Lambda_{CH}(H,d) \leq \Lambda_{CH}(G,d)$ and $\Lambda_{WH}(H,d) \leq \Lambda_{WH}(G,d)$ for all integers $d \geq 2$.

As shown in [Bat23a, Theorem 3], the converse inequalities hold true when H is a lattice of G, hence the following.

Theorem 0.7. If G is a locally compact second countable group and Γ is a lattice of G, then we have $\Lambda_{CH}(\Gamma, d) = \Lambda_{CH}(G, d)$ and $\Lambda_{WH}(\Gamma, d) = \Lambda_{WH}(G, d)$ for all integers $d \ge 2$.

The argument used to prove Corollary 0.6 does not work for M_d -AP due to the lack of uniform norm boundedness. However, if we assume H is a lattice in G, there is an easier approach to obtain a similar results.

Theorem 0.8. If G is a locally compact second countable group and Γ is a lattice of G, then G has M_d -AP if and only if Γ has M_d -AP.

We acknowledge that this work is strongly inspired by [Haa16] and [Pis05] where the case d = 2 and the discrete case are studied.

1. Preliminary

Throughout the paper, G is a locally compact second countable group, G_d is the discrete realization of $G, d \in \mathbb{N}$ is an integer greater than one, and $\mathcal{H}_i, \mathcal{H}$, and \mathcal{K} are Hilbert spaces. We conventionally write $\mathcal{H}_0 = \mathcal{H}_d = \mathbb{C}$ and $v_0 = v_d = 1$.

1.1. Fourier and Fourier-Stieltjes algebras. Recall that a unitary representation of G is a continuous group homomorphism $\pi : G \to \mathcal{U}(\mathcal{H})$, where \mathcal{H} is a Hilbert space and $\mathcal{U}(\mathcal{H})$ is the group of all unitary operators on \mathcal{H} endowed with the weak operator topology (WOT). Given vectors $v, w \in \mathcal{H}$, we call the function

(1.1)
$$\varphi = \pi_{v,w} : g \in G \mapsto \langle \pi(x)v, w \rangle$$

the coefficient of π associated to $v, w \in \mathcal{H}$. These are typical elements of $M_d(G)$. To see that, put $\mathcal{H}_1 = \cdots = \mathcal{H}_{d-1} = \mathcal{H}, \xi_1(x) = \langle \pi(x), w \rangle, \xi_d(x) : 1 \mapsto \pi(x)v$, and $\xi_2(x) = \cdots = \xi_{d-1}(x) = \pi(x)$. Then we have

$$\xi_1(x_1)\cdots\xi_d(x_d)(1) = \langle \pi(x_1\cdots x_d)v, w \rangle = \pi_{v,w}(x_1\cdots x_d)$$

with $\|\pi_{v,w}\|_{M_d} \leq \|v\| \|w\|.$

The Fourier-Stieltjes algebra B(G) consist of all coefficients of unitary representations of G. Endowed with the pointwise product and the norm $\|\varphi\|_B = \inf \|v\| \|w\|$, where the infimum is taken over all (\mathcal{H}, π, v, w) satisfying (1.1), the Fourier-Stieltjes algebra is a commutative Banach algebra.

The Fourier algebra A(G) is the smallest closed subalgebra of B(G) containing $B(G) \cap C_c(G)$. Some basic facts about the Fourier algebra include that it consists of the coefficients of the left regular representation $\lambda : G \to \mathcal{U}(L^2(G))$ and that if $\varphi \in A(G)$ then we can find $f, g \in L^2(G)$ such that $\varphi = \lambda_{f,g}$ and $\|\varphi\|_B = \|f\|_2 \|g\|_2$. To distinguish that φ is in the Fourier algebra, we write $\|\varphi\|_A = \|\varphi\|_B$. We refer the readers to [Eym64, KL18, Run20] for more about these algebras.

The Fourier algebra contains abundant continuous functions so that when a function φ multiplies the Fourier algebra, i.e. $\varphi A(G) \subseteq A(G)$, it is necessarily continuous. We will make use of this fact. The following lemma is comparable to the well known fact [Gaa73, Theorem V.7.3] that every weakly measurable unitary representation on a separable Hilbert space is continuous.

Lemma 1.1. Let $A, B : G \to \mathcal{H}$ be two bounded weakly measurable maps (i.e. \mathcal{H} is endowed with $\sigma(\mathcal{H}, \mathcal{H}^*)$ -Borel space structure) into a separable Hilbert space \mathcal{H} . Assume that $\varphi : G \to \mathbb{C}$ is a function such that $\varphi(yx^{-1}) = \langle A(x), B(y) \rangle$ for all $x, y \in G$. Then φ multiplies the Fourier algebra A(G). In particular, φ is continuous.

Proof. Let $(e_n)_{n\in\mathbb{N}}$ be an orthonormal basis for \mathcal{H} . By assumption, there exist uniformly bounded measurable functions $a_n, b_n \in L^{\infty}(G)$ such that $A(x) = \sum_n a_n(x)e_n$, $B(y) = \sum_n b_n(y)e_n$, and

$$\varphi(yx^{-1}) = \langle A(x), B(y) \rangle = \sum_{n} a_n(x) \overline{b_n(y)}$$

Take any $f, g \in L^2(G)$. By Cauchy–Schwarz inequality, we have

$$\begin{split} \sum_{n} \|a_{n}f\|_{2} \|b_{n}g\|_{2} &\leq (\sum_{n} \|a_{n}f\|_{2}^{2})^{1/2} (\sum_{n} \|b_{n}g\|_{2}^{2})^{1/2} \\ &= (\int_{G} |f(x)|^{2} \sum_{n} |a_{n}(x)|^{2} dx)^{1/2} (\int_{G} |g(x)|^{2} \sum_{n} |b_{n}(x)|^{2} dx)^{1/2} \\ &\leq \|A\|_{\infty} \|B\|_{\infty} \|f\|_{2} \|g\|_{2} < \infty, \end{split}$$

thus $\sum_{n} \lambda_{a_n f, b_n g} \in A(G)$. On the other hand, if we fix $x \in G$, since the bounding function

$$|f(x^{-1}y)\overline{g(y)}\sum_{n=1}^{N}a_n(x^{-1}y)\overline{b_n(y)}| \leq |f(x^{-1}y)\overline{g(y)}| \|A\|_{\infty} \|B\|_{\infty}$$

is integrable over $y \in G$, by the dominated convergence theorem we have

$$\begin{aligned} (\varphi\lambda_{f,g})(x) &= \int_{G} \varphi(x) f(x^{-1}y) \overline{g(y)} dy = \int_{G} \langle A(x^{-1}y), B(y) \rangle f(x^{-1}y) \overline{g(y)} dy \\ &= \int_{G} \sum_{n} a_{n}(x^{-1}y) \overline{b_{n}(y)} f(x^{-1}y) \overline{g(y)} dy = (\sum_{n} \lambda_{a_{n}f,b_{n}g})(x). \end{aligned}$$

In other words, φ is a Fourier multiplier, hence continuous.

A similar statement can be achieved for any M_d -multipliers. More precisely, if $\varphi \in M_d(G_d)$ and the ξ_i 's in (0.1) are weakly measurable, then we can deduce that $\varphi \in M_d(G)$. This will be used to see that $\check{\phi}$ in Theorem 0.2 is continuous.

1.2. The space $M_d(G)$ of M_d -multipliers. The key step in proving Theorem 0.2.(i) is to show that we can choose ξ_i 's in (0.1) to be WOT-continuous, i.e. the maps $x \in G \mapsto \langle \xi_i(x)v_i, v_{i-1} \rangle$ are continuous for any $v_i \in \mathcal{H}_i$ and $v_{i-1} \in \mathcal{H}_{i-1}$. The case d = 2 is done in [Haa16, Theorem 3.2]. We adapt it to the general case. Beforehand, let us denote

$$A_{i} = \{\xi_{i+1}(x_{i+1}) \cdots \xi_{d}(x_{d})v_{d} \in \mathcal{H}_{i} \mid x_{i+1}, \dots, x_{d} \in G\}, \quad i = 0, \dots, d-1,$$

and

$$B_i = \{ [\xi_1(x_1) \cdots \xi_i(x_i)]^* v_0 \in \mathcal{H}_i \mid x_1, \dots, x_{i-1} \in G \}, \quad i = 1, \dots, d$$

Lemma 1.2. If $\varphi \in M_d(G)$ is non-zero, we can choose \mathcal{H}_i 's and ξ_i 's in (0.1) such that A_i and B_i are total in \mathcal{H}_i for all i = 1, ..., d - 1.

Proof. Let $P_i \in \mathcal{B}(\mathcal{H}_i)$ be the projection onto the closed linear span of A_i . Note that P_0 is just the identity map because φ is nonzero and $\mathcal{H}_0 \cong \mathbb{C}$. It is easily checked that the Hilbert spaces $P_i \mathcal{H}_i$ and the bounded maps $P_{i-1}\xi_i$ also satisfy (0.1). Thus replacing (\mathcal{H}_i, ξ_i) 's by $(P_i \mathcal{H}_i, P_{i-1}\xi_i)$'s, we can and will assume that each A_i is total in \mathcal{H}_i .

Let $Q_i \in \mathcal{B}(\mathcal{H}_i)$ be the projection onto the closed linear span of B_i . Again, Q_d is just the identity map on \mathcal{H}_d because firstly

$$\varphi(x_1\cdots x_d) = \langle v_d, [\xi_1(x_1)\cdots \xi_d(x_d)]^*v_0 \rangle$$

is nonzero for some $x_1, \ldots, x_d \in G$ and secondly $\mathcal{H}_d \cong \mathbb{C}$. Put $\mathcal{H}'_i = Q_i \mathcal{H}_i$ and $\xi'_i(x_i) = Q_{i-1}\xi_i(x_i)$ for all $i = 1, \ldots, d$ with $Q_0 = \mathrm{id}_{\mathcal{H}_0}$. Then (\mathcal{H}'_i, ξ'_i) 's still satisfy (0.1). To see that, take any vectors $v'_i = [\xi_1(x_1) \cdots \xi_i(x_i)]^* v_0 \in \mathcal{H}'_i$ and $v_{i+1} \in \mathcal{H}'_{i+1}$. Then we have

$$\langle Q_i \xi_{i+1}(x_{i+1}) Q_{i+1} v'_{i+1}, v'_i \rangle = \langle v'_{i+1}, Q_{i+1}[\xi_1(x_1) \cdots \xi_i(x_{i+1})]^* v'_i \rangle$$

= $\langle v'_{i+1}, [\xi_1(x_1) \cdots \xi_i(x_{i+1})]^* v'_i \rangle$
= $\langle Q_i \xi_{i+1}(x_{i+1}) v'_{i+1}, v'_i \rangle.$

Since such v'_i 's are total in \mathcal{H}'_i , the above equality is true for any $v'_i \in \mathcal{H}'_i$. In other words, we have

(1.2)
$$Q_i\xi_{i+1}(x_{i+1})Q_{i+1} = Q_i\xi_{i+1}(x_{i+1}).$$

From this, it is easily seen that

$$\xi_1'(x_1) \cdots \xi_d'(x_d) v_d = Q_0 \xi_1(x_1) Q_1 \xi_2(x_2) Q_2 \cdots Q_{d-1} \xi_d(x_d) v_d$$

= $\xi_1(x_1) \cdots \xi_d(x_d) v_d = \varphi(x_1 \cdots x_d).$

Moreover, the set

$$B'_{i} = \{ [\xi'_{1}(x_{1}) \cdots \xi'_{i}(x_{i})]^{*} v_{0} \in \mathcal{H}_{i} \mid x_{1}, \dots, x_{i-1} \in G \}$$

is total in \mathcal{H}'_i . Now, the main concern is whether

$$A'_{i} = \{\xi'_{i+1}(x_{i+1}) \cdots \xi'_{d}(x_{d})v_{d} \in \mathcal{H}_{i} \mid x_{i+1}, \dots, x_{d} \in G\}$$

is total in \mathcal{H}'_i . Let us prove it by reverse recursion. Firstly,

$$A'_{d-1} = \{Q_{d-1}\xi_d(x_d)v_d \in \mathcal{H}_i \mid x_d \in G\}$$

is total in $\mathcal{H}'_{d-1} = Q_{d-1} \mathcal{H}_{i-1}$ because A_{d-1} is total in \mathcal{H}_{d-1} by assumption. Assume that A'_{i+1} is total in $\mathcal{H}'_{i+1} = Q_{i+1} \mathcal{H}_{i+1}$. Then by (1.2) and the totality condition of A_i 's, we have

$$\overline{\operatorname{span}}A'_{i} = \overline{\operatorname{span}} \bigcup_{\substack{x_{i+1} \in G}} \xi'_{i+1}(x_{i+1})A'_{i+1}v_{d} = \overline{\operatorname{span}} \bigcup_{\substack{x_{i+1} \in G}} Q_{i}\xi_{i+1}(x_{i+1})Q_{i+1} \mathcal{H}_{i+1}$$
$$= \overline{\operatorname{span}} \bigcup_{\substack{x_{i+1} \in G}} Q_{i}\xi_{i+1}(x_{i+1}) \mathcal{H}_{i+1} = \overline{\operatorname{span}} Q_{i}A_{i} = Q_{i}\mathcal{H}_{i} = \mathcal{H}'_{i},$$

showing that A'_i is total in \mathcal{H}'_i . This proves the lemma.

Lemma 1.3. Let $\varphi \in M_d(G)$ be non-zero and let \mathcal{H}_i 's and ξ_i 's be as in Lemma 1.2. Then ξ_i 's are WOT-continuous and \mathcal{H}_i 's are separable.

Proof. Choose \mathcal{H}_i 's and ξ_i 's as in Lemma 1.2. Suppose that $x_i^{(j)} \to x_i$ in G. Take any vectors

$$v_i = \xi_{i+1}(x_{i+1}) \cdots \xi_d(x_d) v_d \in \mathcal{H}_i, \quad v_{i-1} = [\xi_1(x_1) \cdots \xi_{i-1}(x_{i-1})]^* v_0 \in \mathcal{H}_{i-1}$$

Then by continuity of φ we have

$$\langle \xi_i(x_i^{(j)})v_i, v_{i-1} \rangle = \varphi(x_1 \cdots x_i^{(j)} \cdots x_d) \rightarrow \varphi(x_1 \cdots x_d) = \langle \xi_i(x_i)v_i, v_{i-1} \rangle.$$

By uniform boundedness of ξ_i and totality assumptions, the above convergence is true for any $v_i \in \mathcal{H}_i$ and $v_{i-1} \in \mathcal{H}_{i-1}$. This shows that each ξ_i is WOT-continuous. Now, \mathcal{H}_i is separable since G is second countable, ξ_i is WOT-continuous, and A_i is dense in \mathcal{H}_i . \Box

Lemma 1.4. If $f \in L^1(G)$ and $\varphi \in M_d(G)$, then we have $f * \varphi \in M_d(G)$ with $||f * \varphi||_{M_d} \leq ||f||_1 ||\varphi||_{M_d}$.

Proof. The continuity of $f * \varphi$ is a well known fact of harmonic analysis. Let \mathcal{H}_i 's and ξ_i 's be as in Lemma 1.3. Define $\xi'_1 : G \to \mathcal{B}(\mathcal{H}_1, \mathcal{H}_0)$ as

$$\xi_1'(x)v_1 = \int_G f(y)(\xi_1(y^{-1}x)v_1)dy$$

for all $x \in G$ and $v \in \mathcal{H}_1$. Note that $\|\xi'_1\| \leq \|f\|_1 \|\xi_1\|$ and

$$\xi_1'(x_1)\xi_2(x_2)\cdots\xi_d(x_d)v_d = \int_G f(y)(\xi_1(y^{-1}x_2)\xi_2(x_2)\cdots\xi_d(x_d)v_d)dy$$
$$= \int_G f(y)\varphi(y^{-1}x_1\cdots x_d)dy$$
$$= (f*\varphi)(x_1\cdots x_d)$$

for all $x_1, \ldots, x_d \in G$. Therefore, $f * \varphi \in M_d(G)$ with $||f * \varphi||_{M_d} \leq ||f||_1 ||\varphi||_{M_d}$.

Proof of Proposition 0.5. Let (φ_i) be a net in $M_d(G)$ such that $\varphi_i \to 1$ in $\sigma(M_d(G), X_d(G))$ topology. It follows that $\varphi_i \to 1$ in $\sigma(L^{\infty}(G), L^1(G))$ -topology. By uniform boundedness
principle, we have $\sup_i \|\varphi\|_{\infty} < \infty$. Take any compactly supported positive function $f \in C_c(G)$ with $\|f\|_1 = 1$ and put $\varphi'_i = f * \varphi_i$. Now the proof of [Haa16, Lemma 2.2] works too
see that $\varphi'_i \to 1$ uniformly on compact subsets. We note that if φ_i is compactly supported,
then so is φ'_i . Similarly, if φ_i vanish at infinity, then so does φ'_i . By Lemma 1.4, we have $\varphi'_i \in M_d(G)$ with $\|\varphi'_i\|_{M_d} \leq \|\varphi_i\|_{M_d}$. This shows that if we replace the $\sigma(M_d(G), X_d(G))$ convergence by uniform convergence on compact subsets in the definition of M_d -WA and M_d WH, we will get weaker properties. Conversely, it is always true that uniform convergence on
compact subsets implies $\sigma(L^{\infty}(G), L^1(G))$ -convergence. Moreover, for a uniformly bounded
net in $M_d(G)$, its $\sigma(L^{\infty}(G), L^1(G))$ -convergence implies $\sigma(M_d(G), X_d(G))$ -convergence as $L^1(G) \subseteq X_d(G)$ is dense. This completes the proof.

1.3. The dual space $M'_d(G)$ of $X'_d(G) = L^1(G) \otimes_h \cdots \otimes_h L^1(G)$. Let us recall the following theorem by Paulsen-Smith (see [PS87, Theorem 3.2], [ER22, Theorem 9.4.4], and [Pis03, Corollary 5.4]).

Theorem 1.5. Given operator spaces V_1, \ldots, V_d , a linear mapping

$$\phi: V_1 \otimes \cdots \otimes V_d \to \mathcal{B}(\mathcal{H}_d, \mathcal{H}_0)$$

extends to a completely bounded map on the Haagerup tensor product if and only if there exist Hilbert spaces $\mathcal{H}_1, \ldots, \mathcal{H}_{d-1}$ and completely bounded linear maps

$$\eta_i: V_i \to \mathcal{B}(\mathcal{H}_i, \mathcal{H}_{i-1}), \quad i = 1, \dots, d$$

such that

(1.3)
$$\phi(v_1 \otimes \cdots \otimes v_d) = \eta_1(v_1) \cdots \eta_d(v_d)$$

for all $v_1 \in V_1, \ldots, v_d \in V_d$. Moreover, we can assume that $\|\phi\|_{cb} = \|\eta_1\|_{cb} \cdots \|\eta_d\|_{cb}$.

Conventionally, we only consider $\mathcal{H}_0 = \mathcal{H}_d = \mathbb{C}$. Denote

$$X'_d(G) = \underbrace{L^1(G) \otimes_h \cdots \otimes_h L^1(G)}_d$$

where $L^1(G)$ is endowed with its maximal operator space structure. Denote by $M'_d(G)$ the (operator) dual of $X'_d(G)$. If we put $V_i = L^1(G)$ and $\mathcal{H}_0 = \mathcal{H}_d = \mathbb{C}$ in Theorem 1.5, we simply get $\|\phi\|_{cb} = \|\phi\|$ because $\mathbb{C} \cong \mathcal{B}(\mathbb{C}, \mathbb{C})$ is abelian [ER22, Proposition 2.2.6], and $\|\eta_i\|_{cb} = \|\eta_i\|$ because $L^1(G)$ has its maximal operator space structure [ER22, Section 3.3]. With this simplification, we get the following version of Theorem 1.5.

Corollary 1.6. A linear map $\phi : L^1(G) \otimes \cdots \otimes L^1(G) \to \mathbb{C}$ extends to a bounded linear functional $\phi \in M'_d(G) = X'_d(G)^*$ on $X'_d(G)$ if and only if there exist Hilbert spaces \mathcal{H}_i 's and bounded linear maps $\eta_i : L^1(G) \to \mathcal{B}(\mathcal{H}_i, \mathcal{H}_{i-1})$ such that

(1.4)
$$\phi(f_1 \otimes \cdots \otimes f_d) = \eta_1(f_1) \cdots \eta_d(f_d)$$

for all $f_1, \ldots, f_d \in L^1(G)$. Moreover, we can assume that $\|\phi\| = \|\eta_1\| \cdots \|\eta_d\|$.

Let $\phi \in M'_d(G)$ and let \mathcal{H}_i 's and η_i 's be as in (1.4). Denote

$$C_i = \{\eta_{i+1}(f_{i+1}) \cdots \eta_d(f_d) v_d \in \mathcal{H}_i \mid f_{i+1}, \dots, f_d \in L^1(G)\}, \quad i = 0, \dots, d-1.$$

and

$$D_i = \{ [\eta_1(f_1) \cdots \eta_i(f_i)]^* v_0 \in \mathcal{H}_i \mid f_1, \dots, f_{i-1} \in L^1(G) \}, \quad i = 1, \dots, d.$$

We have an analogue of Lemma 1.2. The proof is done in exactly the same way by replacing (A_i, B_i, ξ_i, x_i) 's by (C_i, D_i, η_i, f_i) 's. We present the proof for convenience.

Lemma 1.7. If $\phi \in M'_d(G)$ is non-zero, we can choose \mathcal{H}_i 's and η_i 's such that C_i and D_i are total in \mathcal{H}_i . In this case, \mathcal{H}_i 's are separable.

Proof. Let $P_i \in \mathcal{B}(\mathcal{H}_i)$ be the projection onto $\overline{\operatorname{span}}C_i$. P_0 is the identity because ϕ is nonzero and $\mathcal{H}_0 \cong \mathbb{C}$. The Hilbert spaces $P_i \mathcal{H}_i$ and the bounded maps $P_{i-1}\eta_i$ also satisfy (1.4), thus we can and will assume that each C_i is total in \mathcal{H}_i . Let $Q_i \in \mathcal{B}(\mathcal{H}_i)$ be the projection onto $\overline{\operatorname{span}}D_i$. Again, Q_d is just the identity on \mathcal{H}_d because

$$\phi(f_1 \otimes \cdots \otimes f_d) = \langle v_d, [\eta_1(f_1) \cdots \eta_d(f_d)]^* v_0 \rangle$$

is nonzero for some $f_1, \ldots, f_d \in L^1(G)$ and $\mathcal{H}_d \cong \mathbb{C}$. Put $\mathcal{H}'_i = Q_i \mathcal{H}_i$ and $\eta'_i(f_i) = Q_{i-1}\eta_i(f_i)$ for all $i = 1, \ldots, d$ with $Q_0 = \mathrm{id}_{\mathcal{H}_0}$. Then $(\mathcal{H}'_i, \eta'_i)$'s still satisfy (1.4). Indeed, take any vectors $v'_i = [\eta_1(f_1) \cdots \eta_i(f_i)]^* v_0 \in \mathcal{H}'_i$ and $v_{i+1} \in \mathcal{H}'_{i+1}$. Then we have

$$\langle Q_{i}\eta_{i+1}(f_{i+1})Q_{i+1}v'_{i+1}, v'_{i} \rangle = \langle v'_{i+1}, Q_{i+1}[\eta_{1}(f_{1})\cdots\eta_{i}(f_{i+1})]^{*}v'_{i} \rangle$$

$$= \langle v'_{i+1}, [\eta_{1}(f_{1})\cdots\eta_{i}(f_{i+1})]^{*}v'_{i} \rangle$$

$$= \langle Q_{i}\eta_{i+1}(f_{i+1})v'_{i+1}, v'_{i} \rangle.$$

Since such v'_i 's are total in \mathcal{H}'_i , the above equality is true for any $v'_i \in \mathcal{H}'_i$. In other words, we have

(1.5)
$$Q_i \eta_{i+1}(f_{i+1}) Q_{i+1} = Q_i \eta_{i+1}(f_{i+1}).$$

From this, it is easily seen that

$$\eta_1'(f_1) \cdots \eta_d'(f_d) = Q_0 \eta_1(f_1) Q_1 \eta_2(f_2) Q_2 \cdots Q_{d-1} \eta_d(f_d) = \eta_1(f_1) \cdots \eta_d(f_d) = \phi(f_1 \otimes \cdots \otimes f_d).$$

Moreover, the set

$$D'_{i} = \{ [\eta'_{1}(f_{1}) \cdots \eta'_{i}(f_{i})]^{*} v_{0} \in \mathcal{H}_{i} \mid f_{1}, \dots, f_{i-1} \in L^{1}(G) \}$$

is total in \mathcal{H}'_i . Let us prove that

$$C'_{i} = \{\eta'_{i+1}(f_{i+1}) \cdots \eta'_{d}(f_{d})v_{d} \in \mathcal{H}_{i} \mid f_{i+1}, \dots, f_{d} \in L^{1}(G)\}$$

is total in \mathcal{H}'_i by reverse recursion. Firstly,

$$C'_{d-1} = \{Q_{d-1}\eta_d(f_d)v_d \in \mathcal{H}_i \mid f_d \in L^1(G)\}$$

is total in $\mathcal{H}'_{d-1} = Q_{d-1}\mathcal{H}_{d-1}$ because C_{d-1} is total in \mathcal{H}_{d-1} . Assume that C'_{i+1} is total in $\mathcal{H}'_{i+1} = Q_{i+1}\mathcal{H}_{i+1}$. Then by (1.5) and the totality condition of C_i 's, we have

$$\overline{\operatorname{span}}C'_{i} = \overline{\operatorname{span}} \bigcup_{\substack{f_{i+1} \in L^{1}(G) \\ f_{i+1} \in L^{1}(G)}} \eta'_{i+1}(f_{i+1})C'_{i+1} = \overline{\operatorname{span}} \bigcup_{\substack{f_{i+1} \in L^{1}(G) \\ f_{i+1} \in L^{1}(G)}} Q_{i}\eta_{i+1}(f_{i+1})\mathcal{H}_{i+1} = \overline{\operatorname{span}}Q_{i}C_{i} = Q_{i}\mathcal{H}_{i} = \mathcal{H}'_{i},$$

showing that C'_i is total in \mathcal{H}'_i . This proves the first assertion of the lemma. Recall that G is second countable, equivalently $L^1(G)$ is separable. Now, by density and continuity, it follows that the Hilbert spaces \mathcal{H}'_i are separable.

Consider the *d*-convolution map

(1.6)
$$\operatorname{conv}_{d} : \underbrace{L^{1}(G) \otimes \cdots \otimes L^{1}(G)}_{d} \to L^{1}(G)$$
$$f_{1} \otimes \cdots \otimes f_{d} \mapsto f_{1} \ast \cdots \ast f_{d}$$

Denote by Y the closure of the kernel of conv_d in $X'_d(G)$. Denote by $Y^{\perp} \subseteq M'_d(G)$ the closed subspace of functionals that vanish on Y (equivalently on the kernel of conv_d). We note that a functional $\phi \in M'_d(G)$ is in Y^{\perp} if and only if there is a map $\tilde{\phi} : L^1(G) \to \mathbb{C}$ such that

(1.7)
$$\phi(f_1 * \cdots * f_d) = \phi(f_1 \otimes \cdots \otimes f_d) v_d.$$

Theorem 0.2 suggests that $M_d(G)$ and Y^{\perp} are in a natural correspondence. Then Theorem 0.3 is straightforward since $Y^{\perp} \cong (X'_d(G)/Y)^*$ isometrically.

2. Main Section

In this section, we will prove the main results.

2.1. Mapping from $M_d(G)$ into $Y^{\perp} \subseteq M'_d(G)$. For $\varphi \in M_d(G)$, we write

(2.1)
$$\hat{\varphi}(f_1 \otimes \cdots \otimes f_d) = (\varphi, f_1 \ast \cdots \ast f_d)_{(L^{\infty}(G), L^1(G))}$$

for all $f_1, \ldots, f_d \in L^1(G)$. Since conv_d is linear, $\hat{\varphi}$ extends to a linear functional on $L^1(G) \otimes \cdots \otimes L^1(G)$ and vanish on the kernel of conv_d .

Lemma 2.1. The map $\varphi \in M_d(G) \mapsto \hat{\varphi} \in Y^{\perp} \subseteq M'_d(G)$ is a well defined contraction.

Proof. If $\xi : G \to \mathcal{B}(\mathcal{H}, \mathcal{K})$ is a bounded weakly measurable map, we can extend it to a bounded linear map $\hat{\xi} : L^1(G) \to \mathcal{B}(\mathcal{H}, \mathcal{K})$ as

$$\langle \hat{\xi}(f)v, w \rangle = \int_G f(x) \langle \xi(x)v, w \rangle dx, \quad v \in \mathcal{H}, \quad w \in \mathcal{K}.$$

Clearly, we have $\|\hat{\xi}\| \leq \sup_{x \in G} \|\xi(x)\|$. For $\varphi \in M_d(G)$, we choose separable \mathcal{H}_i 's and WOT-continuous ξ_i 's as in Lemma 1.3. Observe that

$$\langle \hat{\xi}_{1}(f_{1})\cdots\hat{\xi}_{d}(f_{d})v_{d},v_{0}\rangle = \int_{G} f_{1}(x_{1})\langle \xi_{1}(x_{1})\hat{\xi}_{2}(f_{2})\cdots\hat{\xi}_{d}(f_{d})v_{d},v_{0}\rangle dx_{1}$$

$$= \int_{G} \int_{G} f_{1}(x_{1})f_{2}(x_{2})\langle \xi_{2}(x_{2})\hat{\xi}_{3}(x_{3})\cdots\hat{\xi}_{d}(f_{d})v_{d},\xi_{1}(x_{1})^{*}v_{0}\rangle dx_{2}dx_{1}$$

$$\cdots$$

$$= \int_{G} \cdots \int_{G} f_{1}(x_{1})\cdots f_{d}(x_{d})\langle \xi_{d}(x_{d})v_{d},\xi_{d-1}(x_{d-1})^{*}\cdots\xi_{1}(x_{1})^{*}v_{0}\rangle dx_{d}\cdots dx_{1}$$

$$= \int_{G} \cdots \int_{G} f_{1}(x_{1})\cdots f_{d}(x_{d})\varphi(x_{1}\cdots x_{d})dx_{d}\cdots dx_{1}$$

$$= (\varphi, f_{1}*\cdots*f_{d})_{(L^{\infty}(G),L^{1}(G))} = \hat{\varphi}(f_{1}\otimes\cdots\otimes f_{d}).$$

for all $f_1, \ldots, f_d \in L^1(G)$. By Corollary 1.6, $\hat{\varphi}$ extend to a bounded linear functional on $X'_d(G)$ with

$$\|\hat{\varphi}\| \leq \prod_{i=1}^d \|\hat{\xi}_i\| \leq \prod_{i=1}^d \|\xi_i\|_{\infty} = \|\varphi\|_{M_d}.$$

This proves the lemma.

2.2. Mapping from $Y^{\perp} \subseteq M'_d(G)$ into $M_d(G)$. We want to define a contraction $\phi \in Y^{\perp} \mapsto \check{\phi} \in M_d(G)$

that is inverse to the map in Lemma 2.1. Let $(k_n)_{n\in\mathbb{N}}$ be a bounded left-right approximate identity of $L^1(G)$ consisting of compactly supported, positive, self-adjoint functions, i.e. $k_n \in C_c(G)_+, k_n^* = k_n, ||k_n||_1 \leq 1, ||k_n * f - f||_1 \to 0$, and $||f * k_n - f||_1 \to 0$ for all $f \in L^1(G)$. For $\phi \in Y^{\perp}$, define $\check{\phi}$ as

(2.3)
$$\check{\phi}: x \in G \mapsto \lim_{n} \phi(\lambda(x)k_n \otimes \cdots \otimes k_n)v_d.$$

We will see soon that the above is a well defined continuous function on G.

Lemma 2.2. The map $\phi \in Y^{\perp} \subseteq M'_d(G) \mapsto \check{\phi} \in M_d(G)$ is a well defined contraction.

Proof. Let $\phi \in Y^{\perp}$. Choose \mathcal{H}_i 's and η_i 's as in Lemma 1.7. Denote $h_n = k_n * \cdots * k_n$. Then $(h_n)_{n \in \mathbb{N}}$ is also a bounded approximate identity with the same properties. Take any $x \in G$. For $v_i = \eta_{i+1}(f_i * f_{i+1})\eta_{i+2}(f_{i+2})\cdots \eta_d(f_d)v_d \in \mathcal{H}_i$ and $v_{i-1} = [\eta_1(f_1)\cdots \eta_{i-1}(f_{i-1})]^*v_0 \in \mathcal{H}_{i-1}$ with $f_1, \ldots, f_d \in L^1(G)$, define the operator $\check{\eta}_i(x)$ as

$$\langle \check{\eta}_{i}(x)v_{i}, v_{i-1} \rangle = \langle \phi(f_{1} \otimes \cdots \otimes f_{i-1} \otimes \lambda(x)f_{i} \otimes f_{i+1} \otimes \cdots \otimes f_{d})v_{d}, v_{0} \rangle$$

$$= \langle \eta_{1}(f_{1}) \cdots \eta_{i-1}(f_{i-1})\eta_{i}(\lambda(x)f_{i})\eta_{i+1}(f_{i+1}) \cdots \eta_{d}(f_{d})v_{d}, v_{0} \rangle$$

$$= \lim_{n} \langle \eta_{1}(f_{1}) \cdots \eta_{i-1}(f_{i-1})\eta_{i}(\lambda(x)h_{n} * f_{i})\eta_{i+1}(f_{i+1}) \cdots \eta_{d}(f_{d})v_{d}, v_{0} \rangle$$

$$= \lim_{n} \langle \tilde{\phi}(f_{1} * \cdots * f_{i-1} * \lambda(x)h_{n} * f_{i} * \cdots * f_{d}), v_{0} \rangle$$

$$= \lim_{n} \langle \eta_{1}(f_{1}) \cdots \eta_{i-1}(f_{i-1})\eta_{i}(\lambda(x)h_{n})\eta_{i+1}(f_{i} * f_{i+1}) \cdots \eta_{d}(f_{d})v_{d}, v_{0} \rangle$$

$$= \lim_{n} \langle \eta_{i}(\lambda(x)h_{n})v_{i}, v_{i-1} \rangle.$$

This extends to a well defined linear map on the linear span of v_i 's because $\phi \in Y^{\perp}$ and $\mathcal{H}_0 = \mathcal{H}_d = \mathbb{C}$. Since $L^1(G) * L^1(G)$ is dense in $L^1(G)$ and η_{i+1} is continuous, such v_i 's are total in \mathcal{H}_i . By density and boundedness, $\check{\eta}_i(x)$ extends to a bounded linear map in $\mathcal{B}(\mathcal{H}_i, \mathcal{H}_{i-1})$ with norm not exceeding $\|\eta_i\|$. In other words, we have $\check{\eta}_i : G \to \mathcal{B}(\mathcal{H}_i, \mathcal{H}_{i-1})$ well defined and uniformly bounded by $\|\eta_i\|$. Observe that

$$\begin{split} \check{\eta}_1(x_1)\cdots\check{\eta}_d(x_d)v_d &= \lim_{n_d}\cdots\lim_{n_1}\eta_1(\lambda(x_1)h_{n_1})\cdots\eta_d(\lambda(x_d)h_{n_d})v_d \\ &= \lim_{n_d}\cdots\lim_{n_1}\check{\phi}(\lambda(x_1)h_{n_1}*\cdots*\lambda(x_{d-1})h_{n_{d-1}}*\lambda(x_d)k_{n_d}*\cdots*k_{n_d}) \\ &= \lim_{n_d}\cdots\lim_{n_1}\eta_1(\lambda(x_1)h_{n_1}*\cdots*\lambda(x_{d-1})h_{n_{d-1}}*\lambda(x_d)k_{n_d})\eta_2(k_{n_d})\cdots\eta_d(k_{n_d})v_d \\ &= \lim_{n_d}\eta_1(\lambda(x_1\cdots x_d)k_{n_d})\eta_2(k_{n_d})\cdots\eta_d(k_{n_d})v_d \\ &= \lim_{n_d}\phi(\lambda(x_1\cdots x_d)k_n\otimes k_n\otimes\cdots\otimes k_n)v_d. \end{split}$$

This shows that the function $\check{\phi}$ from (2.3) is well defined and in $M_d(G_d)$ with

$$\|\check{\phi}\|_{M_d} \leq \prod_{i=1}^d \|\check{\eta}_i\| \leq \prod_{i=1}^d \|\eta_i\| = \|\phi\|.$$

Since the map $x \in G \mapsto \lambda(x)g \in L^1(G)$ is continuous for every $g \in C_c(G)$ (see for example [Ped89, Lemma 6.6.11]), $\langle \check{\eta}_i(\cdot)v_i, v_{i-1} \rangle$ is a pointwise limit of continuous functions, hence measurable. Now, the continuity of $\check{\phi}$ follows from Lemma 1.1 by putting

$$\mathcal{H} = \mathcal{H}_{d-1}, \quad A(x) = \check{\eta}_d(x^{-1})v_d, \quad B(y) = [\check{\eta}_1(y))\check{\eta}_2(e)\cdots\check{\eta}_{d-1}(e)]^*v_0.$$

This completes the proof.

Proof of Theorem 0.2. It only remains to prove that the maps in Lemma 2.1 and Lemma 2.2 are inverse to each other. If $\varphi \in M_d(G)$, by definition (2.1) and (2.3) we have

$$\begin{split} \dot{\tilde{\varphi}}(x) &= \lim_{n} \hat{\varphi}(\lambda(x)k_n \otimes \cdots \otimes k_n) v_d \\ &= \lim_{n} (\varphi, \lambda(x)k_n \ast \cdots \ast k_n)_{(L^{\infty}(G), L^1(G))} \\ &= \varphi(x). \end{split}$$

for almost every $x \in G$, but since both $\check{\varphi}$ and φ are continuous, they coincide. Conversely, if $\phi \in Y^{\perp}$, we have

$$\begin{split} \check{\phi}(f_1 \otimes \cdots \otimes f_d) &= (\check{\phi}, f_1 * \cdots * f_d)_{(L^{\infty}(G), L^1(G))} \\ &= \int_{G^n} \check{\phi}(x_1 \cdots x_d) f_1(x_1) \cdots f_d(x_d) dx_1 \cdots dx_d \\ &= \int_{G^n} \langle \check{\eta}_1(x_1) \cdots \check{\eta}_d(x_d) v_d, v_0 \rangle f_1(x_1) \cdots f_d(x_d) dx_1 \cdots dx_d \\ &= \langle \eta_1(f_1) \cdots \eta_d(f_d) v_d, v_0 \rangle \\ &= \phi(f_1 \otimes \cdots \otimes f_d) \end{split}$$

for all $f_1, \ldots, f_d \in C_c(G)$. By totality and continuity, we get $\hat{\phi} = \phi$.

Proof of Theorem 0.3. Hanh-Banach's theorem yields that $Y^{\perp} \cong (X'_d(G)/Y)^*$ isometrically. Thus, by Theorem 0.2 we have an isometric isomorphism

$$i: \varphi \in M_d(G) \mapsto [\hat{\varphi}] \in (X'_d(G)/Y)^*$$

such that

(2.5)
$$[\hat{\varphi}]([f_1 \otimes \cdots \otimes f_d]) = (\varphi, f_1 * \cdots * f_d)_{(L^{\infty}(G), L^1(G))}$$

for all $f_1, \ldots, f_d \in L^1(G)$. If we restrict its dual map onto $X'_d(G)/Y$, we get an isometry

$$i^*: X'_d(G)/Y \to M_d(G)^*$$

onto a closed subspace of $M_d(G)^*$ (which is a Banach predual of $M_d(G)$) such that $i^*([f_1 \otimes \cdots \otimes f_d]) = f_1 * \cdots * f_d$ for all $f_1, \ldots, f_d \in L^1(G)$. Since the inclusions $L^1(G) \otimes \cdots \otimes L^1(G) \subseteq X'_d(G)$ and $L^1(G)^{*d} \subseteq L^1(G) \subseteq X_d(G)$ are dense, we deduce that $i^*(X'_d(G)/Y) = X_d(G)$ and $M_d(G) \cong X_d(G)^*$ isometrically. \Box

Proof of Theorem 0.8. The "if" part is handled in [Bat23b, Theorem 1.4]. We now prove the other direction.

Suppose that $\Omega \subseteq G$ is a measurable, finite measured fundamental domain for Γ so that we have $G = \bigsqcup_{\gamma \in \Gamma} \gamma \Omega$. We can normalize the Haar measure dw of G so that Ω has measure 1. Define a unital mapping

$$i: \varphi \in L^{\infty}(G) \mapsto i(\varphi) \in \ell^{\infty}(\Gamma), \quad i(\varphi)(\gamma) = \int_{\Omega} \varphi(\gamma w) dw$$

We claim that this map is normal. To see that, it is enough to show that the dual map i^* sends $\ell^1(\Gamma)$ into $L^1(G)$. Take any $f \in \ell^1(\Gamma)$. Observe that

$$\begin{aligned} (\varphi, i^*(f))_{(L^{\infty}(G), L^{\infty}(G)^*)} &= (i(\varphi), f)_{(\ell^{\infty}(\Gamma), \ell^1(\Gamma))} = \sum_{\gamma \in \Gamma} f(\gamma) \int_{\Omega} \varphi(\gamma w) dw \\ &= \int_{G} \left(\sum_{\gamma \in \Gamma} f(\gamma) \mathbf{1}_{\gamma \Omega}(g) \right) \varphi(g) dg \end{aligned}$$

and

$$\int_{G} \left| \sum_{\gamma \in \Gamma} f(\gamma) \mathbf{1}_{\gamma \Omega}(w) \right| dw \leqslant \sum_{\gamma \in \Gamma} |f(\gamma)| |\gamma \Omega| = \|f\|_{1} < \infty.$$

This shows that $i^*(f)$ is in $L^1(G)$ and the claim is true.

Take any $\varphi \in M_d(G)$ and let ξ_i 's be as in Lemma 1.3. Observe that

$$i(\varphi)(\gamma_1\cdots\gamma_d) = \int_{\Omega} \varphi(\gamma_1\cdots\gamma_d w) dw = \xi_1(\gamma_1)\cdots\xi_{d-1}(\gamma_{d-1}) \int_{\Omega} \xi_d(\gamma_d w) dw.$$

This shows that the mapping

$$i: M_d(G) \to M_d(\Gamma)$$

is well defined and norm decreasing. Moreover, it is $\sigma(M_d(G), X_d(G)) - \sigma(M_d(\Gamma), X_d(\Gamma))$ continuous since $i^* : \ell^1(\Gamma) \to L^1(G)$ is well defined and the inclusions $\ell^1(\Gamma) \subseteq X_d(\Gamma)$ and $L^1(G) \subseteq X_d(G)$ are dense.

Take any $\varphi \in C_c(G)$. Observe that

$$\|i(\varphi)\|_2^2 = \sum_{\gamma \in \Gamma} \left| \int_{\Omega} \varphi(\gamma w) dw \right|^2 \leq \sum_{\gamma \in \Gamma} \int_{\Omega} |\varphi(\gamma w)|^2 dw \int_{\Omega} 1^2 dw = \|\varphi\|_2^2 < \infty.$$

In other words, $i(\varphi) \in \ell^2(\Gamma) \subseteq A(\Gamma)$.

Now the proof is straightforward. As G has M_d -AP, there is a net (φ_i) in $C_c(G) \cap M_d(G)$ that converges to 1 in $\sigma(M_d(G), X_d(G))$ -topology. Then, $(i(\varphi_i))$ is a net in $A(\Gamma)$ that converges to 1 in $\sigma(M_d(\Gamma), X_d(\Gamma))$ -topology. As pointed out in [Bat23b, Definition 2.2 and Remark 2.3], this is enough to deduce that Γ has M_d -AP.
