A KHINTCHINE INEQUALITY FOR CENTRAL FOURIER SERIES ON NON-KAC COMPACT QUANTUM GROUPS

ABSTRACT. The study of Khintchin inequalities has a long history in abstract harmonic analysis. While there is almost no possibility of nontrivial Khintchine inequality for central Fourier series on compact connected semisimple Lie groups, we demonstrate a strong contrast within the framework of compact quantum groups. Specifically, we establish a Khintchine inequality with operator coefficients for arbitrary central Fourier series in a large class of non-Kac compact quantum groups. The main examples include the Drinfeld-Jimbo q-deformations G_q , the free orthogonal quantum groups O_F^+ , and the quantum automorphism group $\mathbb{G}_{aut}(B,\psi)$ with a δ -form ψ .

1. Introduction

The Khintchine inequality has a long tradition in harmonic analysis, and its natural analogue has been studied extensively in noncommutative harmonic analysis [LP86, LPP91, Pis12]. A noncommutative Khintchine inequality with operator coefficients for the cases $2 \le p < \infty$ is given by

$$\left\| \sum_{i=1}^{m} \epsilon_{i} \otimes A_{i} \right\|_{L^{p}(\Omega; S_{n}^{p})} \lesssim \max \left\{ \left\| \left(\sum_{i=1}^{m} A_{i}^{*} A_{i} \right)^{\frac{1}{2}} \right\|_{S_{n}^{p}}, \left\| \left(\sum_{i=1}^{m} A_{i} A_{i}^{*} \right)^{\frac{1}{2}} \right\|_{S_{n}^{p}} \right\}$$

$$(1.1)$$

where $(\epsilon_i)_{i=1}^m$ is a set of independent and identically distributed Rademacher variables with $\epsilon_i:\Omega\to\{\pm 1\}$, and S_n^p is the matrix algebra M_n with the Schatten p-norm. When comparing two norms $\|\cdot\|$ and $\|\cdot\|'$, let us denote by $\|f\|\lesssim \|f\|'$ if there exists a constant C such that

$$||f|| \le C \, ||f||' \tag{1.2}$$

where C is independent of the choice of f. Additionally, we write $\|\cdot\| \approx \|\cdot\|'$ if both $\|\cdot\| \lesssim \|\cdot\|'$ and $\|\cdot\|' \lesssim \|\cdot\|$ hold.

Without using independent random variables, one of the most successful approaches has been the study of *lacunary sets*. This subject has a long and rich history for compact abelian groups [GH13, Kah85, LR75, MP81]. Let us denote by Irr(G) the set of all irreducible unitary representations $\pi: G \to \mathcal{U}(n_{\pi})$ of a compact group G. In the category of compact abelian groups, all irreducible representations are one-dimensional, i.e. $n_{\pi} \equiv 1$, and

 $\{\pi\}_{\pi \in \operatorname{Irr}(G)}$ forms an orthonormal basis of $L^2(G)$. Moreover, there exists an infinite subset $E \subseteq \operatorname{Irr}(G)$ such that

$$\left\| \sum_{\pi \in E} \pi \otimes A_{\pi} \right\|_{L^{p}(G; S_{n}^{p})} \lesssim \max \left\{ \left\| \left(\sum_{\pi \in E} A_{\pi}^{*} A_{\pi} \right)^{\frac{1}{2}} \right\|_{S_{n}^{p}}, \left\| \left(\sum_{\pi \in E} A_{\pi} A_{\pi}^{*} \right)^{\frac{1}{2}} \right\|_{S_{n}^{p}} \right\}$$
(1.3)

by [LR75] and [Har99].

There have been two general frameworks to study such infinite subsets $E \subseteq Irr(G)$ for non-abelian G, as mentioned in [Pis20] for Sidon sets.

(1) One approach is to replace the compact abelian groups G with the duals $\widehat{\Gamma}$ of discrete groups. This approach has led to various astounding positive results. For example, *freely independent* noncommutative random variables can be used to obtain Khintchine inequalities [Buc99, HP93, PP05, Jun05, RX06]. For example, let $2 \le p \le \infty$ and $E = \{g_i\}_{i=1}^m$ be a set of canonical generators of \mathbb{F}_m . Then

$$\left\| \sum_{x \in E} \lambda_x \otimes A_x \right\|_{L^p(\widehat{\mathbb{F}_m}; S_n^p)} \lesssim \max \left\{ \left\| \left(\sum_{x \in E} A_x^* A_x \right)^{\frac{1}{2}} \right\|_{S_n^p}, \left\| \left(\sum_{x \in E} A_x A_x^* \right)^{\frac{1}{2}} \right\|_{S_n^p} \right\}. \tag{1.4}$$

Here, $L^p(\widehat{\mathbb{F}_m}; S_n^p)$ is the noncommutative L^p -space from the tensor product von Neumann algebra $M_n \overline{\otimes} \mathcal{L}(\mathbb{F}_m)$ with the noncommutative measure $\operatorname{tr}_n \otimes \tau$, where tr_n is the usual trace on M_n and $\tau = \langle \cdot \delta_e, \delta_e \rangle_{\ell^2(\mathbb{F}_m)}$ is the vacuum state on the free group von Neumann algebra $\mathcal{L}(\mathbb{F}_m)$.

(2) The other approach is to replace compact abelian groups with compact non-abelian groups G. In this case, the one-dimensional representations π are replaced by matrix coefficient functions $\sqrt{n_\pi}\pi_{ij}$. However, this line of research encountered some disappointing discoveries for compact non-abelian Lie groups. For example, it was proven in [GT80] that compact connected semisimple Lie groups do not admit an infinite $\Lambda(p)$ -set, even in the scalar-valued case. Specifically, for any $1 , there is no infinite subset <math>E \subseteq \operatorname{Irr}(G)$ such that

$$\left\| \sum_{\pi \in E} \sum_{i,j=1}^{n_{\pi}} a_{ij}^{\pi} \sqrt{n_{\pi}} \pi_{ij} \right\|_{L^{p}(G)} \lesssim \left(\sum_{\pi \in E} \sum_{i,j=1}^{n_{\pi}} |a_{ij}^{\pi}|^{2} \right)^{\frac{1}{2}}.$$
 (1.5)

One might hope to explore new possibilities by focusing on the *characters* $\chi_{\pi} = \sum_{i=1}^{n_{\pi}} \pi_{ii}$. However, it was shown in [GST82] that for any $3 \le p < \infty$ and for any compact connected semisimple Lie groups G, there is no infinite

subset $E \subseteq Irr(G)$ satisfying

$$\left\| \sum_{\pi \in E} a_{\pi} \chi_{\pi} \right\|_{L^{p}(G)} \lesssim \left(\sum_{\pi \in E} |a_{\pi}|^{2} \right)^{\frac{1}{2}}. \tag{1.6}$$

Despite the aforementioned negative conclusions in the category of compact non-abelian Lie groups, a positive result was found for a *twisted quantum group* $\mathbb{G} = SU_q(2)$ with 0 < q < 1. Specifically, [Wan17] constructed an infinite subset $E \subseteq \operatorname{Irr}(SU_q(2))$ such that

$$\left\| \sum_{\pi \in E} a_{\pi} \chi_{\pi} \right\|_{L^{4}(SU_{q}(2))} \lesssim \left(\sum_{\pi \in E} |a_{\pi}|^{2} \right)^{\frac{1}{2}}. \tag{1.7}$$

This finding suggests potential for further exploration of the Khintchine inequality using characters on the *Drinfeld-Jimbo q-deformations* $\mathbb{G} = G_q$, and more generally on *non-Kac compact quantum groups*.

The main aim of this paper is to establish a very positive result in a large class of non-Kac compact quantum groups. Let $L^p(\mathbb{G}; S_n^p)$ denote the vector-valued noncommutative L^p -space $S_n^p[L^p(\mathbb{G})]$ [Pis98, Pis03]. In Section 3, we prove the following Khintcine inequality with operator coefficients on general compact quantum groups (Theorem 3.2):

$$\left\| \sum_{\alpha \in \operatorname{Irr}(\mathbb{G})} \chi_{\alpha} \otimes A_{\alpha} \right\|_{L^{p}(\mathbb{G}; S_{n}^{p})} \leq K_{p} \left\| \left(\sum_{\alpha \in \operatorname{Irr}(\mathbb{G})} A_{\alpha}^{*} A_{\alpha} \right)^{\frac{1}{2}} \right\|_{S^{p}}$$
(1.8)

for all $p = 2^k$ with natural numbers k, where the constant K_p is given by

$$K_p = \left(\sum_{\alpha \in \operatorname{Irr}(\mathbb{G})} \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{2-\frac{4}{p}} \left(\frac{n_{\alpha}}{d_{\alpha}}\right)^{\frac{2}{p}}\right)^{\frac{1}{2}} \in [1, \infty].$$
 (1.9)

Note that the whole set $E=\operatorname{Irr}(\mathbb{G})$ is taken to cover all central Fourier series $f\sim \sum_{\alpha\in\operatorname{Irr}(\mathbb{G})}\chi_{\alpha}\otimes A_{\alpha}$ with operator coefficients. In Section 4, we prove that $K_p<\infty$ for all $2< p<\infty$ in a wide

In Section 4, we prove that $K_p < \infty$ for all 2 in a wide range of non-Kac compact quantum groups, including the Drinfeld-Jimbo <math>q-deformations G_q , non-Kac free orthogonal quantum groups O_F^+ and non-Kac quantum automorphism groups $\mathbb{G}_{aut}(B,\psi)$ with a δ -form ψ . In these cases, for any $1 \le r, s < \infty$, we obtain

$$||f||_{L^r(\mathbb{G})} \approx ||f||_{L^s(\mathbb{G})}$$
 (1.10)

for arbitrary central Fourier series $f \sim \sum_{\alpha \in \mathrm{Irr}(\mathbb{G})} a_{\alpha} \chi_{\alpha}$ with scalar coefficients.

2. Preliminaries

- 2.1. Compact quantum groups and representations. Within the von Neumann algebraic framework [KV00, Vae02, KV03], a *compact quantum group* \mathbb{G} is given by a triple $(L^{\infty}(\mathbb{G}), \Delta, h)$ where
 - (1) $L^{\infty}(\mathbb{G})$ is a von Neumann algebra,
 - (2) $\Delta: L^{\infty}(\mathbb{G}) \to L^{\infty}(\mathbb{G}) \overline{\otimes} L^{\infty}(\mathbb{G})$ is a normal unital *-homomorphism satisfying

$$(\Delta \otimes \mathrm{id})\Delta = (\mathrm{id} \otimes \Delta)\Delta, \tag{2.1}$$

(3) $h: L^{\infty}(\mathbb{G}) \to \mathbb{C}$ is a normal faithful state satisfying

$$(\mathrm{id} \otimes h)(\Delta(a)) = h(a)1 = (h \otimes \mathrm{id})(\Delta(a)) \tag{2.2}$$

for all $a \in L^{\infty}(\mathbb{G})$. We call h the Haar state on \mathbb{G} .

A (finite dimensional) unitary representation of \mathbb{G} is given by a unitary

$$v = \sum_{i,j=1}^{n_v} e_{ij} \otimes v_{ij} \in M_{n_v} \otimes L^{\infty}(\mathbb{G})$$
 such that

$$\Delta(v_{ij}) = \sum_{k=1}^{n_v} v_{ik} \otimes v_{kj} \tag{2.3}$$

for all $1 \le i, j \le n_v$. Furthermore, v is called *irreducible* if

$$\{T \in M_{n_v} : (T \otimes 1)v = v(T \otimes 1)\} = \{\lambda \cdot \operatorname{Id}_{n_v} : \lambda \in \mathbb{C}\}. \tag{2.4}$$

Two unitary representations $v, w \in M_n \otimes L^{\infty}(\mathbb{G})$ are called *unitarily equivalent* if there exists a unitary matrix $U \in M_n$ such that

$$(U \otimes 1)v(U^* \otimes 1) = w, \tag{2.5}$$

and we write $v \cong w$ in this case. We denote by $Irr(\mathbb{G})$ the set of all irreducible unitary representations up to the unitary equivalence. For each equivalence class $\alpha \in Irr(\mathbb{G})$, let us take a representative element as

$$u^{\alpha} = \sum_{i,i=1}^{n_{\alpha}} e_{ij} \otimes u_{ij}^{\alpha} \in M_{n_{\alpha}} \otimes L^{\infty}(\mathbb{G}).$$
 (2.6)

Here n_{α} is called the *classical dimension* of u^{α} . An important distinction from the case of compact groups is that the *conjugate representation*

$$(u^{\alpha})^{c} = \sum_{i,j=1}^{n_{\alpha}} e_{ij} \otimes (u_{ij}^{\alpha})^{*} \in M_{n_{\alpha}} \otimes L^{\infty}(\mathbb{G})$$
 (2.7)

is not necessarily a unitary, but there exists an invertible positive matrix $Q_{\alpha} \in M_{n_{\alpha}}$ such that

$$u^{\overline{\alpha}} = (Q_{\alpha}^{\frac{1}{2}} \otimes 1)(u^{\alpha})^{c}(Q_{\alpha}^{-\frac{1}{2}} \otimes 1) \tag{2.8}$$

is a unitary representation. Here, we may assume that Q_{α} is diagonal with a suitable choice of an orthonormal basis. Moreover, the matrix Q_{α} is uniquely determined with the condition $\text{Tr}(Q_{\alpha}) = \text{Tr}(Q_{\alpha}^{-1})$. We write

$$d_{\alpha} = \operatorname{Tr}(Q_{\alpha}) = \operatorname{Tr}(Q_{\alpha}^{-1}), \tag{2.9}$$

and call d_{α} the *quantum dimension* of u^{α} . A compact quantum group \mathbb{G} is called *Kac type* if one of the following equivalent conditions holds:

- $Q_{\alpha} = \mathrm{Id}_{n_{\alpha}}$ for all $\alpha \in \mathrm{Irr}(\mathbb{G})$.
- $d_{\alpha} = n_{\alpha}$ for all $\alpha \in Irr(\mathbb{G})$.
- the Haar state h is tracial, i.e. h(ab) = h(ba) for all $a, b \in L^{\infty}(\mathbb{G})$.

Let
$$v=\sum_{i,j=1}^m e_{ij}\otimes v_{ij}\in M_m\otimes L^\infty(\mathbb{G})$$
 and $w=\sum_{s,t=1}^n e_{st}\otimes w_{st}\in$

 $M_n \otimes L^{\infty}(\mathbb{G})$ be representations of \mathbb{G} . The *direct sum* is defined by

$$v \oplus w = \begin{bmatrix} v_{11} & \cdots & v_{1m} \\ \vdots & \ddots & \vdots \\ v_{m1} & \cdots & v_{mm} \\ & & w_{11} & \cdots & w_{1n} \\ \vdots & \ddots & \vdots \\ & & w_{n1} & \cdots & w_{nn} \end{bmatrix}$$
 (2.10)

as an element in $M_{m+n} \otimes L^{\infty}(\mathbb{G})$, and the tensor product is defined by

$$v \oplus w = \sum_{i,j=1}^{m} \sum_{s,t=1}^{n} e_{ij} \otimes e_{st} \otimes v_{ij} w_{st}$$
 (2.11)

as an element in $M_m \otimes M_n \otimes L^{\infty}(\mathbb{G})$. Both the direct sum $v \oplus w$ and the tensor product $v \oplus w$ are representations of \mathbb{G} . For any finite-dimensional unitary representation u of \mathbb{G} , there exist $\gamma_1, \gamma_2, \cdots, \gamma_m \in \operatorname{Irr}(\mathbb{G})$ such that

$$u \cong u^{\gamma_1} \oplus u^{\gamma_2} \oplus \dots \oplus u^{\gamma_m}. \tag{2.12}$$

In this case, we call γ_k a component of irreducible decomposition of u and write $\gamma_k \subseteq u$.

2.2. Schur's orthogonality and Fourier series. The space of polynomials

$$Pol(\mathbb{G}) = span \left\{ u_{ij}^{\alpha} : \alpha \in Irr(\mathbb{G}), 1 \le i, j \le n_{\alpha} \right\}$$
 (2.13)

is a weak*-dense *-subalgebra of $L^\infty(\mathbb{G})$. The Schur's orthogonality relation states that

$$h\left((u_{ij}^{\alpha})^* u_{st}^{\beta}\right) = \frac{\delta_{\alpha,\beta} \delta_{i,s} \delta_{j,t} (Q_{\alpha})_{ii}^{-1}}{d_{\alpha}}$$
(2.14)

$$h\left(u_{ij}^{\alpha}(u_{st}^{\beta})^{*}\right) = \frac{\delta_{\alpha,\beta}\delta_{i,s}\delta_{j,t}(Q_{\alpha})_{jj}}{d_{\alpha}}$$
(2.15)

for all $\alpha, \beta \in Irr(\mathbb{G})$, $1 \leq i, j \leq n_{\alpha}$ and $1 \leq s, t \leq n_{\beta}$. We denote by $L^{2}(\mathbb{G})$ the completion of $Pol(\mathbb{G})$ with respect to the inner product

$$\langle f, g \rangle = h(g^* f) \tag{2.16}$$

for all $f, g \in Pol(\mathbb{G})$. Then (2.14) implies that

$$\left\{ \sqrt{d_{\alpha}(Q_{\alpha})_{ii}} u_{ij}^{\alpha} : \alpha \in Irr(\mathbb{G}), 1 \le i, j \le n_{\alpha} \right\}$$
 (2.17)

is an orthonormal basis of $L^2(\mathbb{G})$. In particular, the set of all *characters* $\{\chi_{\alpha}\}_{{\alpha}\in \operatorname{Irr}(\mathbb{G})}$ is an orthonormal subset in $L^2(\mathbb{G})$, where $\chi_{\alpha}=\sum_{i=1}^{n_{\alpha}}u_{ii}^{\alpha}$.

While $h(fg) \neq h(gf)$ on non-Kac \mathbb{G} in general, the (non-trivial) modular automorphism group $\sigma = (\sigma_z)_{z \in \mathbb{C}}$ of the Haar state h explains how those quantities are related. The automorphism σ_z is determined by

$$\sigma_z(u_{st}^{\alpha}) = (Q_{\alpha})_{ss}^{iz}(Q_{\alpha})_{tt}^{iz}u_{st}^{\alpha}$$
(2.18)

for all $\alpha \in Irr(\mathbb{G})$ and $1 \leq s, t \leq n_{\alpha}$, and we have

$$h(fg) = h(g\sigma_{-i}(f)) \tag{2.19}$$

for all $f, g \in Pol(\mathbb{G})$.

We define the *noncommutative* L^1 -space on \mathbb{G} as the predual $L^1(\mathbb{G}) = L^{\infty}(\mathbb{G})_*$. The *Fourier coefficient* of a normal bounded linear functional $\omega \in L^1(\mathbb{G})$ at $\alpha \in \operatorname{Irr}(\mathbb{G})$ is given by $\widehat{\omega}(\alpha) \in M_{n_{\alpha}}$ whose entries are

$$\widehat{\omega}(\alpha)_{ij} = \omega\left((u_{ji}^{\alpha})^*\right) \tag{2.20}$$

for all $1 \le i, j \le n_{\alpha}$, and we call

$$\omega \sim \sum_{\alpha \in Irr(\mathbb{G})} \sum_{i,j=1}^{n_{\alpha}} d_{\alpha}(\widehat{\omega}(\alpha)Q_{\alpha})_{ij} u_{ji}^{\alpha}$$
 (2.21)

the *Fourier series* of $\omega \in L^1(\mathbb{G})$. Note that we have a natural contractive embedding $\iota : L^{\infty}(\mathbb{G}) \hookrightarrow L^1(\mathbb{G})$ given by

$$\iota(a) = \omega_a(\cdot) = h(\cdot a) \tag{2.22}$$

for all $a \in L^{\infty}(\mathbb{G})$. When we identify $f \in \text{Pol}(\mathbb{G}) \subseteq L^{\infty}(\mathbb{G})$ with the associated normal bounded functional $\omega_f = h(\cdot f) \in L^1(\mathbb{G})$, we obtain

$$f = \sum_{\alpha \in Irr(\mathbb{G})} \sum_{i,j=1}^{n_{\alpha}} d_{\alpha}(\widehat{f}(\alpha)Q_{\alpha})_{ij} u_{ji}^{\alpha}, \tag{2.23}$$

where the Fourier coefficient $\widehat{f}(\alpha)$ is defined as $\widehat{\omega_f}(\alpha)$.

2.3. Noncommutative L^p -spaces and the crossed product. For a general description, let $\mathcal{M} \subseteq B(H)$ be a von Neumann algebra with a normal faithful positive linear functional $\phi \in \mathcal{M}_*^+$. See [Ter81, PX03, HJX10] for more details of noncommutative L^p -spaces. Since \mathcal{M} is naturally embedded into \mathcal{M}_* similarly as in (2.22), we have a compatible pair $(\mathcal{M}, \mathcal{M}_*)$ of Banach spaces, and the *noncommutative* L^p -space is defined as the complex interpolation space

$$L^{p}(\mathcal{M},\phi) = (\mathcal{M},\mathcal{M}_{*})_{\frac{1}{p}}$$
 (2.24)

for all $1 \le p \le \infty$.

Let
$$1 \le p_0, p_1 \le \infty$$
 and $\theta \in [0, 1]$ such that $\frac{1}{p} = \frac{1 - \theta}{p_0} + \frac{\theta}{p_1}$. Then

$$||f||_{L^{p}(\mathcal{M},\phi)} \le ||f||_{L^{p_0}(\mathcal{M},\phi)}^{1-\theta} ||f||_{L^{p_1}(\mathcal{M},\phi)}^{\theta}$$
(2.25)

for all $f \in \mathcal{M}$.

Although the normal faithful positive functional $\phi \in \mathcal{M}^+_*$ is non-tracial in general, the elements in $L^p(\mathcal{M},\phi)$ can be realized concretely in a larger noncommutative tracial measure space. Using the modular automorphism $\sigma^\phi = (\sigma_t^\phi)_{t \in \mathbb{R}}$, the $crossed\ product$

$$\mathcal{R} = \mathcal{M} \rtimes_{\sigma^{\phi}} \mathbb{R} \subseteq B(L^{2}(\mathbb{R}, H))$$
 (2.26)

is defined as the von Neumann algebra generated by two families of operators, $\{\pi(x)\}_{x\in\mathcal{M}}$ and $\{\lambda_s\}_{s\in\mathbb{R}}$ given by

$$(\pi(x)\xi)(t) = \sigma_{-t}^{\phi}(x)\xi(t)$$
 (2.27)

$$(\lambda_s \xi)(t) = \xi(t - s) \tag{2.28}$$

for all $x \in \mathcal{M}$ and $s, t \in \mathbb{R}$. Here, $\pi : \mathcal{M} \hookrightarrow \mathcal{R}$ is a normal faithful *-representation, so we can identify \mathcal{M} with $\pi(\mathcal{M})$.

By the Stone's theorem, there exists a densely defined injective positive operator $D=e^A:\mathcal{D}(A)\to L^2(\mathbb{R},H)$ such that $\lambda(t)=D^{it}$ for all $t\in\mathbb{R}$, where $\mathcal{D}(A)$ is the set of all $\xi\in L^2(\mathbb{R},H)$ such that

$$A\xi = \lim_{s \to 0} \frac{1}{is} (\lambda_s \xi - \xi) \tag{2.29}$$

exists in $L^2(\mathbb{R}, H)$.

For any compactly supported weak*-continuous function $f : \mathbb{R} \to \mathcal{M}$, let us consider the following operator

$$x_f = \int_{\mathbb{R}} \pi(f(s)) \lambda_s ds. \tag{2.30}$$

The set of all such operators x_f forms a weak*-dense *-subalgebra of \mathcal{R} .

For each normal semifinite weight $\varphi: \mathcal{M}_+ \to [0, \infty]$, there exists the dual normal semifinite weight $\widehat{\varphi}: \mathcal{R}_+ \to [0, \infty]$ determined by

$$\widehat{\varphi}(x_f) = \widehat{\varphi}\left(\int_{\mathbb{R}} \pi(f(s))\lambda_s ds\right) = \varphi(f(0)) \tag{2.31}$$

for any positive x_f . In addition, the dual weight $\widehat{\varphi}$ is faithful if the given weight φ is faithful.

Although $\widehat{\phi}$ of the given faithful $\phi \in \mathcal{M}_*^+$ is non-tracial in general, the following weight

$$\tau(\cdot) = \widehat{\phi}(D^{-\frac{1}{2}} \cdot D^{-\frac{1}{2}}) \tag{2.32}$$

is the unique normal semifinite faithful tracial weight on \mathcal{R} satisfying

$$\sigma_t^{\widehat{\phi}}(x) = \lambda_t \sigma_t^{\tau}(x) \lambda_t^{-1} = D^{it} x D^{-it}, \ t \in \mathbb{R}.$$
 (2.33)

Let $L^0(\mathcal{R}, \tau)$ be the space of all closed densely defined operators T on $L^2(\mathbb{R}, H)$ satisfying the following conditions:

- (1) T is affiliated with \mathcal{R} , i.e. TV = VT for all unitaries V in the commutant algebra \mathcal{R}' .
- (2) T is τ -measurable, i.e. for any $\delta > 0$ there exists a projection $p \in \mathcal{R}$ such that $\operatorname{ran}(p) \subseteq \mathcal{D}(T)$ and $\tau(1-p) \leq \delta$.

For any normal positive functional $\omega \in \mathcal{M}_*^+$, there exists a unique positive $D_\omega \in L^0(\mathcal{R}, \tau)$ such that

$$\widehat{\omega}(x) = \tau(D_{\omega}^{\frac{1}{2}} x D_{\omega}^{\frac{1}{2}}) = \tau(x D_{\omega}) \tag{2.34}$$

for all $x \in \mathcal{R}_+$, and the modular automorphism of $\widehat{\omega}$ is given by $\sigma_t^{\widehat{\omega}}(x) = D_{\omega}^{it}xD_{\omega}^{-it}$. In particular, we have $D_{\phi} = D = e^A$ for the given normal faithful positive functional $\phi \in \mathcal{M}_*^+$. See Lemma 2.2 and Corollary 2.6 of [Ter81] for more details.

2.4. **Dual action and Haagerup** L^p -spaces. To define the Haagerup L^p -spaces $L^{p,H}(\mathcal{M},\phi)$, let us introduce the dual action $\widehat{\sigma}^{\phi}$ of $\widehat{\mathbb{R}} \cong \mathbb{R}$ on \mathcal{R} using a canonical identification of the dual group $\widehat{\mathbb{R}}$ with \mathbb{R} . Specifically, the dual action $\widehat{\sigma}^{\phi}$ is given by

$$\widehat{\sigma}_s^{\phi}(x) = w_s x w_s^* \tag{2.35}$$

for all $s \in \mathbb{R}$ and $x \in \mathcal{R}$, where the unitary representation $w : \widehat{\mathbb{R}} \cong \mathbb{R} \to \mathcal{U}(L^2(\mathbb{R}, H))$ is given by

$$(w_s \xi)(t) = e^{-ist} \xi(t) \tag{2.36}$$

for all $\xi \in L^2(\mathbb{R}, H)$. In particular, we have

$$\widehat{\sigma}_s^{\phi}(\pi(a)\lambda_t) = e^{-ist}\pi(a)\lambda_t \tag{2.37}$$

for all $a \in \mathcal{M}$ and $s, t \in \mathbb{R}$. The subalgebra $\pi(\mathcal{M})$ is characterized as the fixed points for the dual action inside \mathcal{R} , i.e.

$$\pi(\mathcal{M}) = \left\{ x \in \mathcal{R} : \ \widehat{\sigma}_s^{\phi}(x) = x \ \forall s \in \mathbb{R} \right\}. \tag{2.38}$$

The Haagerup L^p -space is defined as

$$L^{p,H}(\mathcal{M},\phi) = \left\{ x \in L^0(\mathcal{R},\tau) : \widehat{\sigma}_s^{\phi}(x) = e^{-\frac{s}{p}} x \,\forall s \in \mathbb{R} \right\}$$
 (2.39)

for any $1 \leq p \leq \infty$. In particular, we have $L^{\infty,H}(\mathcal{M},\phi) = \pi(\mathcal{M})$ for $p = \infty$, and

$$L^{1,H}(\mathcal{M},\phi) = \operatorname{span}\left\{D_{\omega} \in L^{0}(\mathcal{R},\tau) : \omega \in \mathcal{M}_{*}^{+}\right\}$$
 (2.40)

for p=1 where D_{ω} is the unique positive τ -measurable operator associated to $\omega \in \mathcal{M}_{*}^{+}$ discussed in Subsection 2.3. Here, (2.40) is thanks to the following identities $\widehat{\omega} = \widehat{\omega} \circ \widehat{\sigma}_{t}^{\phi}$ and $e^{-t}\tau = \tau \circ \widehat{\sigma}_{t}^{\phi}$.

Note that $\mathrm{Tr}(D_\omega)=\omega(1)$ extends to a contractive positive normal linear functional on $L^{1,H}(\mathcal{M},\psi)$, which we call *trace*. If $x\in L^{p,H}(\mathcal{M},\phi)$ and $y\in L^{q,H}(\mathcal{M},\phi)$ such that $\frac{1}{p}+\frac{1}{q}=1$ with $p,q\geq 1$, then $xy,yx\in L^{1,H}(\mathcal{M},\phi)$ and we have

$$\operatorname{Tr}(xy) = \operatorname{Tr}(yx). \tag{2.41}$$

Now we can explain how the complex interpolation space $L^p(\mathcal{M}, \phi)$ is identified with the Haagerup L^p -space $L^{p,H}(\mathcal{M}, \phi)$. Let x = u|x| be the polar decomposition of $x \in L^0(\mathcal{R}, \tau)$. Then $x \in L^{p,H}(\mathcal{M}, \phi)$ is equivalent to that $u \in \mathcal{M}$ and $|x|^p \in L^{1,H}(\mathcal{M}, \phi)$. In this case, the L^p -norm of $x \in L^{p,H}(\mathcal{M}, \phi)$ is defined by

$$||x||_{p,H} = \text{Tr}(|x|^p)^{\frac{1}{p}}.$$
 (2.42)

By [Kos84, Section 9], a linear map $\iota_p:\mathcal{M}\hookrightarrow L^{p,H}(\mathcal{M},\phi)$ given by

$$\iota_p(x) = \pi(x)D^{\frac{1}{p}} \tag{2.43}$$

extends to an onto isometry $\iota_p: L^p(\mathcal{M}, \phi) \to L^{p,H}(\mathcal{M}, \phi)$ for all $1 \leq p \leq \infty$.

As in the tracial setting, we have a natural Hölder inequality on the Haagerup L^p -spaces. For any $x \in L^{p,H}(\mathcal{M},\phi)$ and $y \in L^{q,H}(\mathcal{M},\phi)$ such that $\frac{1}{p} + \frac{1}{q} = \frac{1}{r}$ with $r \geq 1$, we have $xy \in L^{r,H}(\mathcal{M},\phi)$ and

$$||xy||_{L^{r,H}(\mathcal{M},\phi)} \le ||x||_{L^{p,H}(\mathcal{M},\phi)} \cdot ||y||_{L^{q,H}(\mathcal{M},\phi)}.$$
 (2.44)

We define the noncommutative vector-valued L^1 -space as $S^1_n[\mathcal{M}_*] = S^1_n \widehat{\otimes} \mathcal{M}_* \cong (M_n \otimes_{\min} \mathcal{M})_*$ where $\widehat{\otimes}$ and \otimes_{\min} are the projective and the injective tensor product in the category of operator spaces respectively. For the general cases $1 \leq p \leq \infty$, the noncommutative vector-valued L^p -space is realized as the complex interpolation space

$$S_n^p[L^p[\mathcal{M},\phi]] = \left(M_n \otimes_{\min} \mathcal{M}, S_n^1 \widehat{\otimes} \mathcal{M}_*\right)_{\frac{1}{p}} = L^p(\mathcal{M}_n,\phi_n)$$
 (2.45)

by [Pis98, Corollary 1.4], where $\mathcal{M}_n = M_n \overline{\otimes} \mathcal{M}$, $\phi_n = \operatorname{tr}_n \otimes \phi$ and tr_n is the usual trace on M_n . Thus, we obtain

$$||f||_{S_n^p[L^p[\mathcal{M},\phi]]} = \left[(\operatorname{tr}_n \otimes \operatorname{Tr}) \left(\left| (\operatorname{id} \otimes \pi)(f) (\operatorname{Id}_n \otimes D^{\frac{1}{p}}) \right|^p \right) \right]^{\frac{1}{p}}$$
 (2.46)

for any $f \in M_n \otimes_{\min} \mathcal{M}$ and $1 \leq p < \infty$. See [Pis98, Pis03] for more details of the noncommutative vector-valued L^p -spaces.

3. A KHINTCHINE INEQUALITY FOR CENTRAL FOURIER SERIES

We will focus on the so-called *central Fourier series with operator coefficients*, which is of the form

$$f \sim \sum_{\alpha \in Irr(\mathbb{G})} x_{\alpha} \otimes \chi_{\alpha} \tag{3.1}$$

with an arbitrary sequence $(x_{\alpha})_{\alpha \in Irr(\mathbb{G})} \subseteq M_n$. A key observation of this paper is the following smoothing effect of the automorphism $\sigma_{-\frac{i}{2p}}$ on the L^p -norm of the characters χ_{α} .

Lemma 3.1. For any $p = 2^k$ with a natural number k, we have

$$\left\|\sigma_{-\frac{i}{2p}}(\chi_{\alpha})\right\|_{L^{p}(\mathbb{G})} \leq \left\|\chi_{\alpha}\right\|_{L^{\infty}(\mathbb{G})}^{1-\frac{2}{p}} \left(\frac{n_{\alpha}}{d_{\alpha}}\right)^{\frac{1}{p}}.$$
 (3.2)

Proof. For the first step $k = 1 \iff p = 2$, we have

$$\left\| \sigma_{-\frac{i}{4}}(\chi_{\alpha}) \right\|_{L^{2}(\mathbb{G})}^{2} = \left\| \sum_{j=1}^{n_{\alpha}} (Q_{\alpha})_{jj}^{\frac{1}{2}} u_{jj}^{\alpha} \right\|_{L^{2}(\mathbb{G})}^{2}$$
(3.3)

$$= \sum_{j=1}^{n_{\alpha}} (Q_{\alpha})_{jj} \frac{(Q_{\alpha})_{jj}^{-1}}{d_{\alpha}} = \frac{n_{\alpha}}{d_{\alpha}} = \|\chi_{\alpha}\|_{\infty}^{0} \cdot \left(\frac{n_{\alpha}}{d_{\alpha}}\right)^{1}.$$
(3.4)

Now let us assume that (3.2) holds for $p = 2^k$. Then we have

$$\left\|\sigma_{-\frac{i}{4p}}(\chi_{\alpha})\right\|_{L^{2p}(\mathbb{G})}^{2p} = \left\|\pi\left(\sigma_{-\frac{i}{4p}}(\chi_{\alpha})\right)D^{\frac{1}{2p}}\right\|_{L^{2p,H}(\mathbb{G})}^{2p}$$
(3.5)

$$= \text{Tr}\left(\left| D^{\frac{1}{4p}} \pi(\chi_{\alpha}) D^{-\frac{1}{4p}} D^{\frac{1}{2p}} \right|^{2p} \right) = \text{Tr}\left(\left| D^{\frac{1}{4p}} \pi(\chi_{\alpha}) D^{\frac{1}{4p}} \right|^{2p} \right)$$
(3.6)

$$= \operatorname{Tr}\left(\left(D^{\frac{1}{4p}}\pi(\chi_{\alpha})^{*}D^{\frac{1}{2p}}\pi(\chi_{\alpha})D^{\frac{1}{4p}}\right)^{p}\right) \tag{3.7}$$

$$= \operatorname{Tr} \left(D^{\frac{1}{4p}} \left(\pi(\chi_{\alpha})^* D^{\frac{1}{2p}} \pi(\chi_{\alpha}) D^{\frac{1}{2p}} \right)^{p-1} \pi(\chi_{\alpha})^* D^{\frac{1}{2p}} \pi(\chi_{\alpha}) D^{\frac{1}{4p}} \right)$$
(3.8)

$$= \operatorname{Tr}\left(\left(\pi(\chi_{\alpha})^* D^{\frac{1}{2p}} \pi(\chi_{\alpha}) D^{\frac{1}{2p}}\right)^p\right). \tag{3.9}$$

The last equality is thanks to the traciality (2.41). Then, applying the non-commutative Hölder inequality (2.44), we obtain

$$\left\| \sigma_{-\frac{i}{4p}}(\chi_{\alpha}) \right\|_{L^{2p}(\mathbb{G})}^{2} = \left[\text{Tr} \left(\left(\pi(\chi_{\alpha})^{*} D^{\frac{1}{2p}} \pi(\chi_{\alpha}) D^{\frac{1}{2p}} \right)^{p} \right) \right]^{\frac{1}{p}}$$
(3.10)

$$\leq \|\pi(\chi_{\alpha})^*\|_{L^{\infty,H}(\mathbb{G})} \cdot \left[\operatorname{Tr} \left(\left| D^{\frac{1}{2p}} \pi(\chi_{\alpha}) D^{\frac{1}{2p}} \right|^p \right) \right]^{\frac{1}{p}} \tag{3.11}$$

$$= \|\pi(\chi_{\alpha}^*)\|_{L^{\infty,H}(\mathbb{G})} \cdot \left[\operatorname{Tr} \left(\left| D^{\frac{1}{2p}} \pi(\chi_{\alpha}) D^{-\frac{1}{2p}} D^{\frac{1}{p}} \right|^p \right) \right]^{\frac{1}{p}}$$
(3.12)

$$= \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})} \cdot \left\| \pi \left(\sigma_{-\frac{i}{2p}}(\chi_{\alpha}) \right) D^{\frac{1}{p}} \right\|_{L^{p,H}(\mathbb{G})}$$
(3.13)

$$= \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})} \cdot \left\|\sigma_{-\frac{i}{2p}}(\chi_{\alpha})\right\|_{L^{p}(\mathbb{G})}.$$
(3.14)

Thus, we can conclude that

$$\left\| \sigma_{-\frac{i}{4p}}(\chi_{\alpha}) \right\|_{L^{2p}(\mathbb{G})} \le \left\| \chi_{\alpha} \right\|_{L^{\infty}(\mathbb{G})}^{\frac{1}{2}} \cdot \left\| \sigma_{-\frac{i}{2p}}(\chi_{\alpha}) \right\|_{L^{p}(\mathbb{G})}^{\frac{1}{2}}$$

$$(3.15)$$

$$\leq \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{\frac{1}{2}} \cdot \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{\frac{1}{2} - \frac{1}{p}} \left(\frac{n_{\alpha}}{d_{\alpha}}\right)^{\frac{1}{2p}} = \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{1 - \frac{1}{p}} \left(\frac{n_{\alpha}}{d_{\alpha}}\right)^{\frac{1}{2p}}$$
(3.16)

where the second inequality comes from the inductive assumption. \Box

Now, let us exhibit the main result, an operator-valued Khintchine inequality for an arbitrary central Fourier series with the following constant

$$K_{p} = \left(\sum_{\alpha \in \operatorname{Irr}(\mathbb{G})} \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{2-\frac{4}{p}} \left(\frac{n_{\alpha}}{d_{\alpha}}\right)^{\frac{2}{p}}\right)^{\frac{1}{2}} \in [1, \infty].$$
 (3.17)

Theorem 3.2. Let $p = 2^k$ with a natural number k. Then

$$||f||_{L^p(\mathbb{G};S_n^p)} \le K_p \cdot \left\| \left(\sum_{\alpha \in Irr(\mathbb{G})} x_{\alpha}^* x_{\alpha} \right)^{\frac{1}{2}} \right\|_{S_p^p}$$
(3.18)

for any central Fourier series $f = \sum_{\alpha \in Irr(\mathbb{G})} x_{\alpha} \otimes \chi_{\alpha} \in M_n \otimes Pol(\mathbb{G})$ with operator coefficients.

Proof. The case k=1 ($\Leftrightarrow p=2$) is immediate, so let us suppose that $k\geq 2$. Recall that the vector-valued L^p -norm of $f=\sum_{\alpha\in \operatorname{Irr}(\mathbb{G})}x_\alpha\otimes\chi_\alpha\in$

 $M_n \otimes \operatorname{Pol}(\mathbb{G})$ is given by

$$||f||_{L^p(\mathbb{G};S_n^p)} = \left[(\operatorname{tr}_n \otimes \operatorname{Tr}) \left(\left| (\operatorname{id} \otimes \pi)(f) (\operatorname{Id}_n \otimes D^{\frac{1}{p}}) \right|^p \right) \right]^{\frac{1}{p}}$$
(3.19)

and note that

$$\left| (\mathrm{id} \otimes \pi)(f) (\mathrm{Id}_n \otimes D^{\frac{1}{p}}) \right|^p \tag{3.20}$$

$$= \left((\mathrm{Id}_n \otimes D^{\frac{1}{p}}) (\mathrm{id} \otimes \pi) (f)^* (\mathrm{id} \otimes \pi) (f) (\mathrm{Id}_n \otimes D^{\frac{1}{p}}) \right)^{\frac{p}{2}}$$
(3.21)

$$= \left((\operatorname{Id}_n \otimes D^{\frac{1}{p}}) (\operatorname{id} \otimes \pi) (f^* f) (\operatorname{Id}_n \otimes D^{-\frac{1}{p}}) (\operatorname{Id}_n \otimes D^{\frac{2}{p}}) \right)^{\frac{p}{2}} \tag{3.22}$$

$$= \left((\mathrm{id} \otimes \pi) \left((\mathrm{id} \otimes \sigma_{-\frac{i}{p}}) (f^* f) \right) (\mathrm{Id}_n \otimes D^{\frac{2}{p}}) \right)^{\frac{p}{2}}. \tag{3.23}$$

Thus, we have

$$||f||_{L^{p}(\mathbb{G};S_{n}^{p})}^{2} = \left\| (\mathrm{id} \otimes \sigma_{-\frac{i}{p}})(f^{*}f) \right\|_{S_{n}^{\frac{p}{2}}[L^{\frac{p}{2}}(\mathbb{G})]}$$
(3.24)

Since span $\{\chi_{\alpha}\}_{\alpha\in \mathrm{Irr}(\mathbb{G})}$ is a *-subalgebra of $L^{\infty}(\mathbb{G})$, the element $f^*f=\sum_{\alpha_1,\alpha_2\in \mathrm{Irr}(\mathbb{G})} x_{\alpha_1}^* x_{\alpha_2}\otimes \chi_{\alpha_1}^* \chi_{\alpha_2}$ can be written as a linear combination of characteristics.

acters $\sum_{\beta \in \operatorname{Irr}(\mathbb{G})} y_{\beta} \otimes \chi_{\beta}$, where the operator coefficients are determined by

$$y_{\beta} = (\mathrm{id} \otimes h) \left((\mathrm{Id}_n \otimes \chi_{\beta}^*) \cdot f^* f \right) \tag{3.25}$$

$$= \sum_{\alpha_1 \in \operatorname{Irr}(\mathbb{G})} x_{\alpha_1}^* \sum_{\alpha_2 \in \operatorname{Irr}(\mathbb{G})} x_{\alpha_2} \cdot h(\chi_{\beta}^* \chi_{\alpha_1}^* \chi_{\alpha_2})$$
(3.26)

$$= \sum_{\alpha_1 \in \operatorname{Irr}(\mathbb{G})} x_{\alpha_1}^* \sum_{\alpha_2 \in \operatorname{Irr}(\mathbb{G})} x_{\alpha_2} \cdot h(\chi_{\alpha_1} \chi_{\beta} \chi_{\alpha_2}^*) = T^* \left(\operatorname{Id}_n \otimes \chi_{\beta} \right) T$$
 (3.27)

where $T=\sum_{\gamma\in {\rm Irr}(\mathbb{G})}x_{\gamma}\otimes |\chi_{\gamma}^{*}\rangle$ with a linear map $|\chi_{\gamma}^{*}\rangle:\mathbb{C}\to L^{2}(\mathbb{G})$ mapping z to $z\cdot\chi_{\gamma}^{*}$. Then we have

$$\|y_{\beta}\|_{S_{n}^{\frac{p}{2}}} \leq \|T^{*}\|_{S^{p}} \cdot \|\operatorname{Id}_{n} \otimes \chi_{\beta}\|_{M_{n}\overline{\otimes}L^{\infty}(\mathbb{G})} \cdot \|T\|_{S^{p}}$$
(3.28)

$$= \|\chi_{\beta}\|_{L^{\infty}(\mathbb{G})} \cdot \left\| \left(\sum_{\gamma \in \operatorname{Irr}(\mathbb{G})} x_{\gamma}^* x_{\gamma} \right)^{\frac{1}{2}} \right\|_{S_{p}^{p}}^{2}. \tag{3.29}$$

Combining the above observations with the triangle inequality and Lemma 3.1, we reach the following conclusion

$$\left\| (\mathrm{id} \otimes \sigma_{-\frac{i}{p}})(f^*f) \right\|_{S_p^{\frac{p}{2}}[L^{\frac{p}{2}}(\mathbb{G})]} \tag{3.30}$$

$$\leq \sum_{\beta \in \operatorname{Irr}(\mathbb{G})} \left\| y_{\beta} \otimes \sigma_{-\frac{i}{p}}(\chi_{\beta}) \right\|_{S_{n}^{\frac{p}{2}}[L^{\frac{p}{2}}(\mathbb{G})]} \tag{3.31}$$

$$\leq \sum_{\beta \in \operatorname{Irr}(\mathbb{G})} \|\chi_{\beta}\|_{L^{\infty}(\mathbb{G})} \left\| \left(\sum_{\gamma \in \operatorname{Irr}(\mathbb{G})} x_{\gamma}^{*} x_{\gamma} \right)^{\frac{1}{2}} \right\|_{S_{n}^{p}}^{2} \cdot \|\chi_{\beta}\|_{L^{\infty}(\mathbb{G})}^{1 - \frac{4}{p}} \left(\frac{n_{\beta}}{d_{\beta}} \right)^{\frac{2}{p}}.$$
(3.32)

Remark 3.3. Theorem 3.2 can be rephrased as that $E = Irr(\mathbb{G})$ is a completely bounded $\Lambda(p)$ -set under the assumption $K_p < \infty$ in a natural sense of [Har99] within the framework of compact quantum groups.

Then, some standard complex interpolation arguments allow us to show that all L^p -norms of the central Fourier series are equivalent in the scalar-valued case.

Corollary 3.4. Suppose that $K_p < \infty$ for infinitely many $p = 2^k$ with natural numbers k. Then, for any $1 \le r, s < \infty$, we have

$$||f||_{L^r(\mathbb{G})} \approx ||f||_{L^s(\mathbb{G})} \tag{3.33}$$

for arbitrary central Fourier series $f = \sum_{\alpha \in Irr(\mathbb{G})} a_{\alpha} \chi_{\alpha} \in Pol(\mathbb{G})$.

Proof. It is enough to prove that, for any $1 \le r < \infty$, the following inequality

$$||f||_{L^{r}(\mathbb{G})} \lesssim ||f||_{L^{1}(\mathbb{G})}$$
 (3.34)

holds for all central Fourier series $f = \sum_{\alpha \in \operatorname{Irr}(\mathbb{G})} a_{\alpha} \chi_{\alpha} \in \operatorname{Pol}(\mathbb{G}).$

First of all, suppose that $K_p < \infty$ for $p = 2^k$ with a natural number $k \ge 2$. Then there exists $\theta \in (0,1)$ such that $\frac{1}{2} = \frac{1-\theta}{1} + \frac{\theta}{p}$ ($\Leftrightarrow \theta = \frac{p}{2(p-1)}$),

and we have

$$||f||_{L^{2}(\mathbb{G})} \le ||f||_{L^{1}(\mathbb{G})}^{1-\theta} ||f||_{L^{p}(\mathbb{G})}^{\theta}$$
 (3.35)

$$\leq \|f\|_{L^{1}(\mathbb{G})}^{1-\theta} \cdot K_{p}^{\theta} \|f\|_{L^{2}(\mathbb{G})}^{\theta} \tag{3.36}$$

by (2.25) and Theorem 3.2. This implies

$$||f||_{L^{2}(\mathbb{G})} \le K_{p}^{\frac{\theta}{1-\theta}} ||f||_{L^{1}(\mathbb{G})} = K_{p}^{\frac{p}{p-2}} ||f||_{L^{1}(\mathbb{G})}.$$
 (3.37)

Combining (3.37) with Theorem 3.2, we can conclude that

$$||f||_{L^{p}(\mathbb{G})} \le K_{p} ||f||_{L^{2}(\mathbb{G})} \le K_{p}^{\frac{2p-2}{p-2}} ||f||_{L^{1}(\mathbb{G})}.$$
 (3.38)

For the general cases $1 \leq r < \infty$, there exists $p = 2^k$ with a natural number $k \geq 2$ such that $r < 2^k$ and $K_p < \infty$. Let us write $\frac{1}{r} = \frac{1-\theta'}{1} + \frac{\theta'}{p}$ $(\Leftrightarrow \theta' = \frac{p(r-1)}{r(p-1)})$ with $\theta' \in [0,1)$. Then, by (2.25) and (3.38), we obtain

$$||f||_{L^{r}(\mathbb{G})} \le ||f||_{L^{1}(\mathbb{G})}^{1-\theta'} ||f||_{L^{p}(\mathbb{G})}^{\theta'} = K_{p}^{\frac{2p(r-1)}{r(p-2)}} ||f||_{L^{1}(\mathbb{G})}.$$
(3.39)

4. MAIN EXAMPLES

In this Section, we demonstrate that the Khintchine inequality with operator coefficients holds for arbitrary central Fourier series in a large class of non-Kac compact quantum groups. More precisely, we will prove that

$$K_p^2 = \sum_{\alpha \in \operatorname{Irr}(\mathbb{G})} \|\chi_\alpha\|_{L^{\infty}(\mathbb{G})}^{2 - \frac{4}{p}} \left(\frac{n_\alpha}{d_\alpha}\right)^{\frac{2}{p}} < \infty \tag{4.1}$$

holds for all p > 2 when \mathbb{G} is one of the following compact quantum groups

- Drinfeld-Jimbo q-deformations G_q with 0 < q < 1,
- Non-Kac free orthogonal quantum groups O_F^+ ,
- Non-Kac quantum automorphism group $\mathbb{G}_{\mathrm{aut}}(B,\psi)$ with a δ -form.

Our unified strategy to cover all the aforementioned examples is as follows. In Subsections 4.1, 4.2 and 4.3, we will prove that there exists $r \in (0,1)$ such that

$$\frac{n_{\alpha}}{d_{\alpha}} \lesssim r^{|\alpha|} \tag{4.2}$$

where $|\cdot|: \operatorname{Irr}(\mathbb{G}) \to \mathbb{N}$ is a natural length function for each \mathbb{G} in the above list. Assuming the existence of such $r \in (0,1)$, we can obtain

$$K_p^2 = \sum_{k=0}^{\infty} \sum_{\alpha \in \operatorname{Irr}(\mathbb{G}): |\alpha| = k} \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{2 - \frac{4}{p}} \left(\frac{n_{\alpha}}{d_{\alpha}}\right)^{\frac{2}{p}}$$
(4.3)

$$\lesssim \sum_{k=0}^{\infty} \left(\sum_{\alpha \in \operatorname{Irr}(\mathbb{G}): |\alpha|=k} \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{2} \right) r^{\frac{2k}{p}}, \tag{4.4}$$

so it is enough for us to see that $\sum_{\alpha\in \mathrm{Irr}(\mathbb{G}): |\alpha|=k} \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^2$ grows polynomially

when k increases.

(1) For the Drinfeld-Jimbo q-deformations $\mathbb{G}=G_q$, we have

$$\sum_{\alpha \in \operatorname{Irr}(\mathbb{G}): |\alpha| = k} \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{2} = \sum_{\alpha \in \operatorname{Irr}(\mathbb{G}): |\alpha| = k} n_{\alpha}^{2}, \tag{4.5}$$

thanks to coamenability of G_q , and the right-hand side grows polynomially for k as in the classical situation by [NT13, Theorem 2.4.7 (3)] and [BV09].

(2) For the other cases $\mathbb{G}=O_F^+$ (resp. $\mathbb{G}=\mathbb{G}_{\rm aut}(B,\psi)$), let us consider G=SU(2) (resp. G=SO(3)). Then ${\rm Irr}(\mathbb{G})\cong {\rm Irr}(G)\cong \mathbb{N}_0$ with the same fusion rules by [Ban96] (resp. [Bra13]). For each character $\chi_k\in {\rm Pol}(\mathbb{G})$, let us denote by $\chi_k'\in {\rm Pol}(G)$ the corresponding character. Then we have

$$\|\chi_k\|_{L^{\infty}(\mathbb{G})} = \|\chi_k'\|_{L^{\infty}(G)} = k+1 \text{ (resp. } 2k+1),$$
 (4.6)

by [Wan17, Proposition 6.7] and [Ban96] (resp. [Ban99]), so we can conclude that

$$\sum_{\alpha \in \operatorname{Irr}(\mathbb{G}): |\alpha| = k} \|\chi_{\alpha}\|_{L^{\infty}(\mathbb{G})}^{2} = \|\chi_{k}\|_{L^{\infty}(\mathbb{G})}^{2} \lesssim (k+1)^{2}. \tag{4.7}$$

Hence, the only remaining thing to prove is the existence of $r \in (0,1)$ satisfying $\frac{n_{\alpha}}{d_{\alpha}} \lesssim r^{|\alpha|}$, which will be discussed in the following Subsections 4.1, 4.2, and 4.3 for each class of examples.

4.1. **Drinfeld-Jimbo** q-**deformations.** Let G be a simply connected compact semisimple Lie group and let \mathfrak{g} be the associated complexified Lie algebra with a Cartan subalgebra \mathfrak{h} . The *adjoint map* ad : $\mathfrak{g} \to \operatorname{End}(\mathfrak{g})$ is given by

$$\operatorname{ad}_X(Y) = [X, Y] \tag{4.8}$$

for all $X,Y\in\mathfrak{g}$. A non-zero linear functional $\alpha\in\mathfrak{h}^*$ is called a *root* if there exists non-zero $X\in\mathfrak{g}$ such that

$$ad_H(X) = [H, X] = \alpha(H)X \tag{4.9}$$

for all $H \in \mathfrak{h}$. The space of all roots α is denoted by $\Phi \subseteq \mathfrak{h}^* \setminus \{0\}$, and the associated non-trivial eigenspaces

$$\mathfrak{g}_{\alpha} = \{ X \in \mathfrak{g} : \forall H \in \mathfrak{h}, \ \operatorname{ad}_{H}(X) = \alpha(H)X \}$$
 (4.10)

are called *root spaces*. Furthermore, there exists a subset Φ^+ of Φ satisfying the following:

- The subset Φ^+ contains exactly one of α and $-\alpha$ for each $\alpha \in \Phi$.
- If $\alpha, \beta \in \Phi^+$ ($\alpha \neq \beta$) satisfies $\alpha + \beta \in \Phi$, then $\alpha + \beta \in \Phi^+$.

All elements in Φ^+ are called *positive roots*, and a positive root is called *simple* if it cannot be written as the sum of two positive roots. Let us write the simple roots as $\alpha_1, \alpha_2, \dots, \alpha_r$. Then every positive root $\alpha \in \Phi^+$ is a linear combination of simple roots with non-negative integral coefficients.

There exists a non-degenerate symmetric ad-invariant form (\cdot, \cdot) on $\mathfrak g$ whose restriction to the real Lie algebra is negative definite. Note that the non-degenerate symmetric form (\cdot, \cdot) provides a natural identification $\mathfrak h^*\cong\mathfrak h$, so it induces a natural non-degenerate symmetric form on $\mathfrak h^*$. Furthermore, the form (\cdot, \cdot) restricts to an inner product on $\mathfrak h_0^*=\operatorname{span}_{\mathbb R}\Phi$. Another important basis of $\mathfrak h_0^*$ consists of the so-called *fundamental weights* $\omega_1,\omega_2,\cdots,\omega_r\in\mathfrak h_0^*$ determined by the following relations

$$\frac{2(\omega_i, \alpha_j)}{(\alpha_i, \alpha_j)} = \delta_{ij} \tag{4.11}$$

for all $1 \le i, j \le r$. The set of all \mathbb{Z} -linear combinations of the fundamental weights is called the *weight lattice* for \mathfrak{g} , which we denote by P. The subset of all \mathbb{N}_0 -linear combinations of the fundamental weights is denoted by P_+ .

Now, let 0 < q < 1 and consider the Drinfeld-Jimbo q-deformation G_q . Then $\mathrm{Irr}(G_q)$ is identified with P_+ . See [CP95, Section 10.1] and [NT13, Theorem 2.4.7]) for more details. Let us denote by $\rho = \sum_{i=1}^r \omega_i$, which is equal to $\frac{1}{2} \sum_{\alpha \in \Phi^+} \alpha$ ([Kna02, Proposition 2.69] and [NT13]). The following proposition is important to establish the Khintchine inequality with operator coefficients for arbitrary central Fourier series on G_q .

Proposition 4.1. Let $t_i = q^{(\omega_i, 2\rho)}$ for all $1 \le i \le r$. Then

$$\|Q_{\mu}\|_{\infty} = t_1^{-\mu_1} t_2^{-\mu_2} \cdots t_r^{-\mu_r}$$
(4.12)

for all $\mu = \sum_{i=1}^r \mu_i \omega_i \in P_+ \cong Irr(G_q)$. In particular, $\frac{n_\mu}{d_\mu}$ decreases exponentially as $\sum_{i=1}^r \mu_i \to \infty$.

Proof. For the associated irreducible representation u^{μ} of G_q , the eigenvalues of the modular matrix Q_{μ} are of the form $q^{(\nu,-2\rho)}$ where ν is a weight for u^{μ} ([NT13, Proposition 2.4.10] and [VY20]). Let us prove that $(\nu,2\rho)$

is maximized when ν is the highest weight μ . Indeed, since μ is the highest weight for u^{μ} , the difference $\mu - \nu$ can be written as $\sum_{i=1}^{r} m_i \alpha_i$ with $m_i \geq 0$ and we have

$$(\mu, 2\rho) - (\nu, 2\rho) = \sum_{i,j=1}^{r} 2m_i(\alpha_i, \omega_j) = \sum_{i=1}^{r} m_i(\alpha_i, \alpha_i) \ge 0.$$
 (4.13)

Thus, we can conclude that

$$\|Q_{\mu}\|_{\infty} = q^{-(\mu,2\rho)} = q^{-\sum_{i=1}^{r} \mu_i(\omega_i,2\rho)} = \prod_{i=1}^{r} (q^{(\omega_i,2\rho)})^{-\mu_i}.$$
 (4.14)

For the last conclusion, since n_{μ} is polynomially growing by [NT13, Theorem 2.4.7 (3)] and [BV09, Theorem 2.1], it is enough to see that d_{μ} is exponentially growing as $\sum_{i=1}^{r} \mu_{i} \to \infty$. Note that

$$t_i = q^{(\omega_i, 2\rho)} = q^{\sum_{\alpha \in \Phi^+} (\omega_i, \alpha)} \le q^{(\omega_i, \alpha_i)} = q^{\frac{(\alpha_i, \alpha_i)}{2}} < 1 \tag{4.15}$$

for all $1 \le i \le r$, implying $t = \max_{1 \le i \le r} t_i \in (0, 1)$. Thus, we obtain the following exponentially growing lower bound:

$$d_{\mu} \ge ||Q_{\mu}||_{\infty} \ge t^{-(\mu_1 + \mu_2 + \dots + \mu_r)}.$$
 (4.16)

4.2. Free orthogonal quantum groups. Let O_F^+ be a non-Kac free orthogonal quantum group with $F \in M_N$ such that $N_2 = \text{Tr}(F^*F) > N$. See

onal quantum group with $F \in M_N$ such that $N_q = \operatorname{Tr}(F^*F) > N$. See [Wan95, Ban96, Tim08] for more details. Since Subsection 4.1 covers the case N=2, let us focus on the other general cases $N\geq 3$. Recall that the space $\operatorname{Irr}(O_F^+)$ is identified with \mathbb{N}_0 with the following fusion rule [Ban96]:

$$u^{(k)} \oplus u^{(1)} \cong u^{(k-1)} \oplus u^{(k+1)}, \ k \in \mathbb{N}.$$
 (4.17)

Both the quantum dimension d_k and the classical dimension n_k are described by the *Chebyshev polynomials* $(f_k)_{k\in\mathbb{N}_0}$ of the second kind. The polynomial f_k is explicitly given by

$$f_k(t) = \left(\frac{1}{2}\right)^{k+1} \frac{(t+\sqrt{t^2-4})^{k+1} - (t-\sqrt{t^2-4})^{k+1}}{\sqrt{t^2-4}}$$
(4.18)

for all t > 2, and we have $d_k = f_k(N_q)$ and $n_k = f_k(N)$. Combining these facts with the following identity

$$\lim_{k \to \infty} f_k(t) \cdot \left(\frac{t + \sqrt{t^2 - 4}}{2}\right)^{-(k+1)} = \frac{1}{\sqrt{t^2 - 4}},\tag{4.19}$$

we obtain the following estimate

$$\frac{n_k}{d_k} \approx \left(\frac{N + \sqrt{N^2 - 4}}{N_q + \sqrt{N_q^2 - 4}}\right)^{k+1}.\tag{4.20}$$

Since $N < N_q$ is equivalent to $\frac{N+\sqrt{N^2-4}}{N_q+\sqrt{N_q^2-4}} < 1$, we can conclude that $\frac{n_k}{d_k}$ decreases exponentially as $k \to \infty$.

4.3. **Quantum automorphism group.** Let \mathbb{G} be a non-Kac quantum automorphism group $\mathbb{G}_{aut}(B,\psi)$. We refer the readers to [Wan98, Ban99, Ban02, Bra13] for more details of $\mathbb{G}_{aut}(B,\psi)$ with a δ -form ψ . By [Ban99, Bra13], the space $Irr(\mathbb{G}_{aut}(B,\psi))$ is identified with \mathbb{N}_0 with the following fusion rule:

$$u^{(k)} \oplus u^{(1)} \cong u^{(k-1)} \oplus u^{(k)} \oplus u^{(k+1)}, \ k \in \mathbb{N}.$$
 (4.21)

To compute the quantum dimension and the classical dimension, let us consider the following polynomials g_k such that $g_k(4) = 2k+1$ and $g_k(x) = f_{2k}(\sqrt{x})$ for all x > 4. Here, f_{2k} is the 2k-th Chebyshev polynomial given in (4.18), and the identity (4.19) implies

$$\lim_{k \to \infty} g_k(x) \cdot \left(\frac{x - 2 + \sqrt{x(x - 4)}}{2} \right)^{-k} = \frac{\sqrt{x} + \sqrt{x - 4}}{2\sqrt{x - 4}}$$
 (4.22)

for all x > 4. Note that $d_k = g_k(d_1) = f_{2k}(\sqrt{d_1})$ and $n_k = g_k(n_1) = f_{2k}(\sqrt{n_1})$ respectively, by [Bra13, Theorem 3.8].

Firstly, if dim(B) = 4, then $n_k = g_k(4) = 2k + 1$ grows polynomially and the above identity (4.22) implies

$$d_k \approx \left(\frac{d_1 - 2 + \sqrt{d_1(d_1 - 4)}}{2}\right)^k.$$
 (4.23)

Then, the non-Kac condition $d_1 > n_1 = 4$ implies $\frac{d_1 - 2 + \sqrt{d_1(d_1 - 4)}}{2} > 1$, so the quantum dimension d_k has an exponential growth.

For the general cases $\dim(B) \geq 5$, we have

$$\frac{n_k}{d_k} \approx \left(\frac{n_1 - 2 + \sqrt{n_1(n_1 - 4)}}{d_1 - 2 + \sqrt{d_1(d_1 - 4)}}\right)^k \tag{4.24}$$

up to constants by (4.22), and the non-Kac condition, i.e., $n_1 < d_1$, implies that the right-hand side decreases exponentially.
