A formula for the α -Futaki character

Abstract

Alvarez-Cónsul–Garcia-Fernandez–García-Prada introduced the Kähler-Yang-Mills equations. They also introduced the α -Futaki character, an analog of the Futaki invariant, as an obstruction to the existence of the Kähler-Yang-Mills equations. The equations depend on a coupling constant α . Solutions of these equations with coupling constant $\alpha > 0$ are of utmost importance. In this paper, we provide a formula for the α -Futaki character on certain ample line bundles over toric manifolds. We then show that there are no solutions with $\alpha > 0$ on certain ample line bundles over certain toric manifolds and compute the value of α if a solution exists. We also relate our result to the existence result of Keller-Friedman in dimension-two.

1 Introduction

The Kähler-Yang-Mills equations, introduced in $([2], [14])$ $([2], [14])$ $([2], [14])$ $([2], [14])$ $([2], [14])$, are a system of equations coupling the scalar curvature of K¨ahler metric and a Hermitian-Yang-Mills connections of vector bundles. Suppose E is a holomorphic vector bundle over a Kähler manifold X . Then for a Kähler metric ω on X and a Hermitian metric H on E, the Kähler-Yang-Mills equations are

$$
\sqrt{-1}\bigwedge_{\omega}F_H = \lambda Id,
$$

\n
$$
\alpha_0 S(\omega) - \alpha_1 \bigwedge_{\omega}^{2} tr(F_H \wedge F_H) = c.
$$
\n(1)

Here $\sqrt{-1}\Lambda_{\omega}F_H\omega^n = n\sqrt{-1}F_H \wedge \omega^{n-1}$ and λ, c are topological constants. The equations depend on the coupling constants α_0 , α_1 . In this setting, $\frac{\alpha_1}{\alpha_0} = \alpha$.

If X is a compact Riemann surface, the term $tr(F_H \wedge F_H)$ vanishes and hence the system decouples. So for compact Riemann surfaces, the existence problem is equivalent to the uniformisation theorem and the Narasimhan-Seshadri theorem([\[20\]](#page-13-1), [\[8\]](#page-12-1)).

The existence problem in higher dimensions is very difficult because in this case, the system is truly a system of coupled non-linear partial differential equations. Despite this difficulty, there are some existence results: for small α by perturbing a constant scalar curvature Kähler metric and a Hermitian-Yang-Mills connection([\[2\]](#page-12-0)), applying the dimensional reduction of

Alvarez-Cónsul–García-Fernandez–García-Prada also introduced the α -Futaki character \mathcal{F} , an analog of the classical Futaki invariant, which is an obstruction to the existence of the Kähler-Yang-Mills equations [\(1\)](#page-0-0). This character does not depend on the choice of a metric H on E and a metric ω on X. The computation of this character is known only in some specific cases $(4, 5)$. Also, there is no formula for this character analogous to Mabuchi's formula for the Futaki invariant on toric manifolds([\[19\]](#page-13-6)) and residue formula for the Futaki invariant $([22], [13])$ $([22], [13])$ $([22], [13])$ $([22], [13])$ $([22], [13])$.

Alvarez-Cónsul–Garcia-Fernandez–García-Prada remarked in [\[2\]](#page-12-0) that even for line bundles, the existence problem is difficult(page 2807 in [\[2\]](#page-12-0)). In this paper, we give a formula of the α -Futaki invariant for certain ample line bundles on toric manifolds.

Suppose (X, ω) is a toric manifold and L is an ample line bundle over it. All the Kähler forms will be torus invariant. Take a metric h on L such that its curvature $\beta = \sqrt{-1}F_h$ is Kähler. We will be concerned with only those ample bundles L such that there exists a metric $\omega' \in [\omega]$ which solves the equation

$$
n\beta \wedge \omega'^{n-1} = \lambda \omega'^n.
$$

This equation is known as the J-equation which was introduced by Donaldson([\[9\]](#page-12-5)), Chen([\[6\]](#page-12-6)) and studied on toric manifolds by $Yao([23])$ $Yao([23])$ $Yao([23])$ and Collins-Székelyhidi([\[7\]](#page-12-7)).

If we calculate the invariant $\mathcal F$ with this choice of metrics h and ω' , then we get our main theorem.

Theorem 1.1. Let P and Q be the moment polytopes of ω' and β respectively. Then there is a diffeomorphism $U : P \to Q$ such that $tr(DU) = \lambda$ and the following holds

$$
(2\pi)^{-n}\langle \mathcal{F}, \xi_i \rangle = \frac{\alpha_0}{2} \int_{\partial P} (x_i + c_i) d\sigma + \alpha_1 \int_P (x_i + c_i) (\sum_{m \in M_2} m) d\mu.
$$

Here M_2 is the set of all (2×2) principal minor of DU, ξ_i is a holomorphic vector field on the associated principal \mathbb{C}^* -bundle of L, $d\mu$ is the Lebesgue measure on P, $d\sigma$ is a positive measure on ∂P normalized so that on a face $l_i = 0$ we have $d\sigma \wedge dl_i = \pm d\mu$, c_i is a constant such that $\int_P (x_i + c_i) d\mu = 0$.

We explain the notations in section [\(2\)](#page-3-0) and section [\(3\)](#page-5-0). As an immediate corollary of this theorem, we get the following.

Corollary 1.2. If Solution of Kähler-Yang-Mills equations exist with $\alpha_0\alpha_1 \neq 0$ then $\langle \mathcal{F}, \xi_i \rangle =$ 0 $\forall i$. Therefore, we get

$$
\frac{\int_{\partial P}(x_i+c_i)d\sigma}{\int_P(x_i+c_i)\sum_{m\in M_2}md\mu}=\frac{\int_{\partial P}(x_j+c_j)d\sigma}{\int_P(x_j+c_j)\sum_{m\in M_2}md\mu},
$$

for all $1 \leq i, j \leq n$.

On $\mathbb{P}^2 \# \overline{\mathbb{P}^2}$, we compute the α -Futaki character for certain ample line bundles. We prove the following theorem.

Theorem 1.3. Suppose L is an ample line bundle on $\mathbb{P}^2 \# \overline{\mathbb{P}^2}$ with $c_1(L) = a[H_2] - [E_2]$ and $[\omega] = b[H_2] - [E_2]$ satisfying $2\frac{ab-1}{b^2-1}$ $\frac{ab-1}{b^2-1} > 1$. Then there is no solution of the Kähler-Yang-Mills equations with $\frac{\alpha_1}{\alpha_0} > 0$. Furthermore, If solution exists then $\frac{\alpha_1}{\alpha_0} = -\frac{(b^2-1)}{(b-a)^2}$ $\frac{(b^2-1)}{(b-a)^2}$.

We explain the notations in [4.](#page-7-0) For some of these line bundles, there do exist a solution of the Kähler-Yang-Mills equations with the prescribed value of $\frac{\alpha_1}{\alpha_0}$. The existence result is due to Keller-Friedman([\[18\]](#page-13-5)).

Theorem 1.4 (Keller-Friedman). There exists metrics h on the line bundle corresponding to the integral cohomology class $(8k+3)[H_2]-[E_2]$ and $\omega \in 3[H_2]-[E_2]$ such that they satisfy the Kähler-Yang-Mills equations with $\frac{\alpha_1}{\alpha_0} = -\frac{1}{8k}$ $\frac{1}{8k^2}$ (Here $k \in \mathbb{N}$).

We also compute the α -Futaki character on some ample line bundles on $\mathbb{P}^3 \# \overline{\mathbb{P}^3}$.

Theorem 1.5. Suppose L is an ample line bundle on $\mathbb{P}^3 \# \overline{\mathbb{P}^3}$ with $c_1(L) = a[H_3] - [E_3]$ and $[\omega] = b[H_3] - [E_3]$ satisfying $3 \frac{ab^2 - 1}{b^3 - 1}$ $\frac{ab^2-1}{b^3-1} > 2$. Then there is no solution of Kähler-Yang-Mills equations with $\frac{\alpha_1}{\alpha_0} > 0$. Furthermore, If solution exists then $\frac{\alpha_1}{\alpha_0} = -\frac{(3b+1)(b-1)^3(b^2+b+1)}{3b(b-a)^2(b^3+b^2-b+1)}$ $\frac{3b(b-a)^2(b^2+b+1)}{3b(b-a)^2(b^3+b^2-b+1)}.$

The author introduced coupled Kähler-Einstein and Hermitian-Yang-Mills equations (17) . Suppose (X, ω) is a compact Kähler *n*-manifold with $-\sqrt{-1}\omega$ as the curvature form of the Chern connection of (K_X^{-1}, h) . One can view the metric h as a volume form Ω_h . Let $\pi: E \to X$ be a holomorphic vector bundle and H be a Hermitian metric on the bundle. The coupled Kähler-Einstein and Hermitian-Yang-Mills equations are

$$
\sqrt{-1}\bigwedge_{\omega}F_H = \lambda Id
$$
\n
$$
\frac{\alpha_0}{2}\left(\frac{\Omega_h}{\int_X \Omega_h} - \frac{\omega^n}{\int_X \omega^n}\right) - \alpha_1 \frac{2}{(n-2)!}tr(F_H \wedge F_H) \wedge \omega^{n-2} = \tilde{C}vol_\omega,
$$
\n(2)

where α_0, α_1 are coupling constants and \tilde{C} , λ are topological constants. One can show the following.

Lemma 1.6 (Lemma 3.1.1 in [\[17\]](#page-13-10)). Suppose (X, ω) is a Fano manifold and f is the Ricci potential that is, $Ric(\omega) - \omega = \sqrt{-1}\partial \overline{\partial} f$ normalized so that $\int_X e^f \omega^n = \int_X \omega^n = V$. Then

$$
\int_X \theta_v S(\omega) \omega^n = V \int_X \theta_v \left(\frac{\Omega_h}{\int_X \Omega_h} - \frac{\omega^n}{\int_X \omega^n} \right)
$$

where θ_v is the Hamiltonian function corresponding to a holomorphic vector field v (that is, $i_v \omega = \bar{\partial} \theta_v$) and h is a metric on K_X^{-1} whose curvature is ω . The function θ_v is normalized by requiring $\int_X \theta_v \omega^n = 0$.

With the help of this lemma, one can identify the α -Futaki character as an obstruction for the existence of coupled Kähler-Einstein and Hermitian-Yang-Mills equations albeit when $\omega \in c_1(X)$ and X is Fano. The author proved an existence result for line bundles over $\mathbb{P}(\mathcal{O} \oplus \mathcal{O}(-1)) \to \mathbb{P}^1$. In this paper, we prove that these line bundles are not ample.

Our paper is organized as follows: In section two, we discuss about some basic facts of toric Kähler geometry, Futaki invariants, and J-equation on toric manifolds. In section three, we recall the α -Futaki character and prove theorem [1.1](#page-1-0) and corollary [1.2.](#page-1-1) In section four, we prove theorem [1.3,](#page-2-0) [1.4,](#page-2-1) [1.5.](#page-2-2)

2 Preliminaries

In this section, we briefly discuss some basic notions of toric Kähler geometry, the Futaki invariant and the J-equation on toric manifolds.

2.1 Kähler geometry of toric manifolds

Definition 1. A Kähler manifold (X, ω) is called a toric manifold if it admits an effective Hamiltonian action of the torus $(S^1)^n$ which extends to a holomorphic action of the complexified torus $(\mathbb{C}^*)^n$ with a free open dense orbit $\approx (\mathbb{C}^*)^n$.

The Hamiltonian action induces a moment map $\mu : X \to \mathbb{R}^n$, where the dual of the Lie algebra of the torus is identified with \mathbb{R}^n . By the Atiyah-Guillemin-Sternberg theorem, the closure of the image is a convex polytope. The size of the polytope is determined by the Kähler class while its position is determined by a choice of moment map or normalization of the Kähler potential. There is a one-to-one correspondence between toric manifolds and a class of convex polytopes known as Delzant polytope.

Definition 2. A convex polytope is said to be a Delzant polytope if every vertex of the polytope has a neighbourhood which is $SL(n, \mathbb{Z})$ equivalent to $\{y \in \mathbb{R}^n | y_i \geq 0; i = 1, \ldots, n\}.$

A Delzant polytope is said to be integral if all the vertex points are in \mathbb{Z}^n . A Delzant polytope P is defined by

$$
P = \{ y \in \mathbb{R}^n | l_i(y) = \langle y, v_i \rangle + \lambda_i > 0; i = 1, \dots, N \},
$$
\n(3)

where $v_i \in \mathbb{Z}^n$ are primitive integral vectors and $\lambda_i \in \mathbb{R}$. All the irreducible toric divisors D_i are given by the inverse images of the facets $l_i = 0$ under the moment map. The cohomology class of the Kähler form ω is given by

$$
[\omega] = \sum_{i=1}^{N} \lambda_i [D_i],
$$

where $[D_i]$ are Poincarè dual of $D_i \in H_{2n-2}(X,\mathbb{Z})$. If the Delzant polytope is integral then the Kähler class is integral and hence first Chern class of some ample line bundle.

Torus invariant Kähler metrics take a very special form on toric manifolds. A torus $((S^1)^n)$ invariant metric ω is of the form $\omega|_{(\mathbb{C}^*)^n} = \sqrt{-1}\partial \overline{\partial} F$; where $F : \mathbb{R}^n \to \mathbb{R}$ is a strictly convex function. The function F is called a Kähler potential of ω . Consider the coordinates $x_i =$ $\log |z_i|^2$ and θ_i , where (z_1, \ldots, z_n) are holomorphic coordinates of $(\mathbb{C}^*)^n$. In this coordinates, the torus invariant metric takes the form

$$
\omega|_{(\mathbb{C}^*)^n} = \sqrt{-1} \frac{\partial^2 F}{\partial x_i \partial x_j} dx^i \wedge d\theta^j.
$$

Observe that the positivity of the form ω is equivalent to the strict convexity of the Kähler potential. The moment map up to translation is given by ∇F . Let us consider the coordinate $y = \nabla F$. Since F is strictly convex, we can take its Legendre transform. The Legendre transform of F satisfies

$$
G(y) = \langle x, y \rangle + F(x).
$$

The function G is called the symplectic potential of ω and it is a strictly convex function on the moment polytope.

Theorem 2.1. Let (X, ω) be a toric Kähler manifold. Suppose the corresponding moment polytope is defined by [\(3\)](#page-3-1). Then every torus invariant metric in the class $[\omega]$ has a symplectic potential of the form

$$
G = \sum_{i=1}^{N} l_i(y) \log l_i(y) + v,
$$

where v is smooth upto boundary.

2.2 The Futaki invariant

Futaki introduced an invariant as an obstruction to the existence of Kähler-Einstein metric([\[12\]](#page-13-11)). Later Calabi and Futaki generalized the invariants to any compact Kähler manifolds. This generalized invariant is an obstruction to the existence of Kähler metrics with constant scalar curvature. It is also a character of the Lie algebra of holomorphic vector fields.

Definition 3. The Futaki invariant is given by

$$
\mathcal{F}ut(v)=\int_X \phi_v s(\omega)\omega^n,
$$

where $s(\omega)$ is the scalar curvature of ω , ϕ_v is a holomorphy potential of $v(i.e., \bar{\partial}\phi_v = i_v\omega)$. Moreover, if $[\omega] = c_1(X)$, then

$$
\mathcal{F}ut_{c_1}(v)=\int_X v(h_\omega)\omega^n,
$$

where h_{ω} satisfies $Ric(\omega) - \omega = \sqrt{-1}\partial \overline{\partial} h_{\omega}$.

The map $\mathcal{F}ut$ does not depend on the choice of ω .

2.3 The J-equation on toric manifolds

The J-equation was introduced by Donaldson([\[9\]](#page-12-5)) and Chen([\[6\]](#page-12-6)). Given a Kähler form β on a compact Kähler manifold X, it asks for a Kähler metric ω such that

$$
n\beta \wedge \omega^{n-1} = \lambda \omega^n,\tag{4}
$$

where $n = dim_{\mathbb{C}} X$ and λ is a topological constant.

On Toric manifolds, Collins-Sz \acute{e} kelyhidi([\[7\]](#page-12-7)) proved that *J*-equation is solvable iff certain inequalities are met. Yao also studied the J-equation on toric manifolds (23) .

Suppose β, ω are two torus invariant Kähler metrics on toric manifolds X. They induce two moment maps $\mu_\omega: X \to \bar{\mathcal{P}}_\omega$ and $\mu_\beta: X \to \bar{\mathcal{P}}_\beta$. Then there exists a transition map

$$
U: \bar{\mathcal{P}_{\omega}} \to \bar{\mathcal{P}_{\beta}}.\tag{5}
$$

Suppose u is a symplectic potential for ω and f is a Kähler potential for β , then on the interior of P, U is given by

$$
U = \nabla f \circ \nabla u.
$$

From the work of Yao(page 1586 in [\[23\]](#page-13-9)), we have

$$
tr_{\omega}\beta = \frac{n\beta \wedge \omega^{n-1}}{\omega^n} = tr(DU|_{\mu_{\omega}}); \quad \frac{\beta^n}{\omega^n} = detDU|_{\mu_{\omega}}; \quad n(n-1)\frac{\beta^2 \wedge \omega^{n-2}}{\omega^n} = \sum_{m \in M_2} m,\tag{6}
$$

where M_2 is the set of all (2×2) principal minors of $DU|_{\mu_\omega}$.

3 The α -Futaki character with toric symmetry

In this section, we recall the α -Futaki character introduced by Alvarez-Consul–Garcia-Fernandez–Garcia-Prada(see page 2775 in [\[2\]](#page-12-0)).

Suppose $\pi : \mathcal{E} \to X$ is the associated principal $GL(r, \mathbb{C})$ -bundle of a holomorphic vector bundle E over X, where $r = rank(E)$. Suppose I is an integrable almost complex structure on $\mathcal E$ that preserves the vertical bundle $V\mathcal E(=ker(d\pi))$ and $\tilde I$ is the unique integrable almost complex structure on the manifold X determined by I. Any vector field $\xi \in LieAut(\mathcal{E}, I)$ covers a real holomorphic vector field ζ on (X, I) which can be written as

$$
\check{\xi} = \eta_{\phi_1} + \check{I} \eta_{\phi_2} + \beta,
$$

for any Kähler form ω in some Kähler class in (X, \check{I}) , where η_{ϕ_i} is the Hamiltonian vector field of $\phi_i \in C_0^{\infty}$ $\int_0^\infty (X, \omega)$ on (X, ω) for $i = 1, 2$, and β is the dual of a 1-form which is harmonic with respect to the Kähler metric $\omega(., \check{I}.).$

$$
\mathcal{F}_I: LieAut(\mathcal{E}, I) \to \mathbb{C}
$$

\langle \mathcal{F}_I, \xi \rangle = -4\sqrt{-1}\alpha_1 \int_X tr \left(\theta_H \xi \wedge (\sqrt{-1} \bigwedge_{\omega} F_H - \lambda Id) \right) \frac{\omega^n}{n!}

+ \int_X \phi \left(\alpha_0 S_{\omega, \check{I}} \omega^n + n(n-1) \alpha_1 tr (\sqrt{-1} F_H \wedge \sqrt{-1} F_H \wedge \omega^{n-2}) \right)

- \int_X \phi (4\alpha_1 \lambda) tr (\sqrt{-1} F_H \wedge \omega^{n-1}), \qquad (7)
$$

where $\phi = \phi_1 + \sqrt{-1}\phi_2$. The functional \mathcal{F}_I does not depend on the choice of ω and H and \mathcal{F}_I vanishes whenever the coupled equations have a solution. We omit the I in \mathcal{F}_I from now onwards. .

Fact 1. If E is a line bundle then $\mathcal E$ is a principal $\mathbb C^*$ -bundle. It is a fact that any holomorphic vector field on X always lifts to a \mathbb{C}^* -invariant holomorphic vector field on a principal \mathbb{C}^* bundle(see page 2806 in $[2]$). We will use this fact in the next subsection.

3.1 Formula for certain ample line bundles on toric manifolds

Suppose L is an ample line bundle and ω is a Kähler form on a toric manifold X. Also assume that there is a metric h on L such that for its curvature $\sqrt{-1}F_h = \beta > 0$, there is a metric $\omega' \in [\omega]$ that solves the J-equation. We get the formula if we calculate the α -Futaki character with h and ω' . We denote by P, Q, the moment polytope of (X, ω') and (X, β) respectively.

The manifold X has a free open dense subset $(\mathbb{C}^*)^n$. We denote the holomorphic coordinate of $(\mathbb{C}^*)^n$ by (z_1,\ldots,z_n) . The $(\mathbb{C}^*)^n$ -invariant holomorphic vector fields $v_i = z_i \frac{\partial}{\partial z_i}$ $\frac{\partial}{\partial z_i}$ naturally extend to the toric manifold X. Suppose ξ_i is a lift of the vector field v_i on the associated principal \mathbb{C}^* bundle \mathcal{L} (using the fact [1\)](#page-6-0). Then we have the following formula.

Theorem 3.1. There is a diffeomorphism $U : P \rightarrow Q$ such that $tr(DU) = \lambda$ and the following holds

$$
(2\pi)^{-n}\langle \mathcal{F}, \xi_i \rangle = \frac{\alpha_0}{2} \int_{\partial P} (x^i + c_i) d\sigma + \alpha_1 \int_P (x^i + c_i) \left(\sum_{m \in M_2} m \right) d\mu.
$$

Here M_2 is the set of all (2×2) principal minor of DU, $d\mu$ is the Lebesgue measure on P, do is a positive measure on ∂P normalized so that on a face $l_i = 0$ we have $d\sigma \wedge dl_i = \pm d\mu$, and $\int_P (x_i + c_i) d\mu = 0$.

Proof. Since for $\sqrt{-1}F_h$, ω' solves the J-equation, we have $\sqrt{-1}\Lambda_{\omega'}F_h = \lambda$. Putting this on [7,](#page-5-1) we get

$$
\langle \mathcal{F}, \xi_i \rangle = \int_X \phi_i \left(\alpha_0 S(\omega') \omega'^n + \alpha_1 n(n-1) (\sqrt{-1} F_h \wedge \sqrt{-1} F_h \wedge \omega'^{n-2}) \right), \tag{8}
$$

where $i_{v_i}\omega' = \bar{\partial}\phi_i$ and $\int_X \phi_i\omega'^n = 0$. Now we write down how some terms correspond to similar terms in the polytope P. The top form ω'^n corresponds to the measure $(2\pi)^n d\mu$ on P, where $d\mu$ is the Lebesgue measure on P. The function $\phi_i \in C_0^{\infty}$ $\int_0^\infty (X, \omega')$ corresponds to the affine function $x^{i} + c_{i}$ with normalisation condition $\int_{P}(x^{i} + c_{i})d\mu = 0$. Suppose u is the symplectic potential of ω' , then from Abreu's equation([\[1\]](#page-12-8)), we have

$$
S(\omega') = -\frac{1}{2} \sum_{k,l} \frac{\partial^2 u^{kl}}{\partial x_k \partial x_l}.
$$

Hence the first term of [8](#page-6-1) becomes

$$
\int_{X} \phi_{i} S(\omega') \omega'^{n} \n= \frac{(2\pi)^{n}}{2} \int_{\partial P} (x^{i} + c_{i}) d\sigma.
$$
\n(9)

We have used Donaldson's formula (10) , Lemma 4.37 in [\[21\]](#page-13-12)): If u is a symplectic potential and $h: P \to \mathbb{R}$ is a continuous convex function smooth on the interior, then

$$
\int_{P} u^{kl} h_{kl} d\mu = \int_{\partial P} h d\sigma - \int_{P} hS(\omega') d\mu,
$$

where $d\mu$ is the Lebesgue measure on P and $d\sigma$ is a positive measure on the boundary ∂P normalized so that on a face defined by $l_i(y) = 0$ we have $d\sigma \wedge dl_i = \pm d\mu$.

Now putting [6](#page-5-2) and [9](#page-6-2) in [8,](#page-6-1) we get

$$
(2\pi)^{-n}\langle \mathcal{F}, \xi_i \rangle = \frac{\alpha_0}{2} \int_{\partial P} (x^i + c_i) d\sigma + \alpha_1 \int_P (x^i + c_i) (\sum_{m \in M_2} m) d\mu
$$

As an immediate consequence of the theorem, we get

Corollary 3.2. If Solution of Kähler-Yang-Mills equations exist with $\alpha_0\alpha_1 \neq 0$ then $\langle \mathcal{F}, \xi_i \rangle =$ 0 $\forall i$. Therefore, we get

$$
\frac{\int_{\partial P}(x_i+c_i)d\sigma}{\int_P(x_i+c_i)\sum_{m\in M_2}md\mu}=\frac{\int_{\partial P}(x_j+c_j)d\sigma}{\int_P(x_j+c_j)\sum_{m\in M_2}md\mu},
$$

for all $1 \leq i, j \leq n$.

 4 Solution of the J-equation on $\mathbb{P}^n \# \overline{\mathbb{P}^n}$

Fang and Lai([\[11\]](#page-13-13)) studied the J-equation on $\mathbb{P}^n\#\overline{\mathbb{P}^n}$ imposing Calabi symmetry on both the metrics. Yao ([\[23\]](#page-13-9)) cast Fang and Lai's solution in the toric setting as an example of his approach. The Calabi symmetry requires $U(n)$ symmetry instead of $U(1)^n$ symmetry as in the toric case. So to make the metrics to have $U(n)$ symmetry, the symplectic potentials need to have more symmetries.

We take moment polytopes of $\mathbb{P}^n \# \overline{\mathbb{P}^n}$ in the following form

$$
P = \{ x \in \mathbb{R}^n | x^i > 0, 1 < \sum_{i=1}^n x^i < b \},\
$$

where b determines the Kähler class. In this case, the Kähler class is $[\omega] = b[H_n] - [E_n],$ where H_n is the pull-back of the hyperplane divisor on \mathbb{P}^n and E_n is the exceptional divisor. Suppose $[\beta] = a[H_n] - [E_n]$ and the corresponding polytope is Q.

One takes that the symplectic potentials of ω and β have specific forms

$$
u = \sum_{i=1}^{n} x^{i} \log x^{i} - X \log X + h(X), \quad X = \sum_{i=1}^{n} x^{i},
$$

where h is a strictly convex function defined on $[1, b]$ satisfying

$$
h(X) - (X - 1)\log(X - 1) - (b - X)\log(b - X) \in C^{\infty}[1, b]
$$

 \Box

and

$$
v = \sum_{i=1}^{n} x^i \log x^i - X \log X + \theta(X),
$$

where θ is defined on [1, a] satisfying similar condition as h.

We denote the Legendre transform of h and θ by p and η respectively. We define the map $f(X) = \eta'(h'(X))$. Then $f : [1, b] \to [1, a]$ is a diffeomorphism. The transition map $U: P \to Q$ in this case is given by

$$
U^{i}(x) = f(X)\frac{x^{i}}{X} \qquad \qquad \text{for} \ \ 1 \leq i \leq n.
$$

Whenever $n \frac{ab^{n-1}-1}{b^n-1} > n-1$, the J-equation has a solution given by

$$
\tilde{f}(r) = Ar + \frac{B}{r^{n-1}},\tag{10}
$$

where $A = \frac{ab^{n-1}-1}{b^{n}-1}$ $\frac{b^{n-1}-1}{b^n-1}$ and $B = \frac{b^n - ab^{n-1}}{b^n-1}$ $\frac{-ab^{n-1}}{b^n-1}$.

Hence we have the following.

Theorem 4.1 ([\[11\]](#page-13-13), Theorem 2.3). On $\mathbb{P}^n \# \overline{\mathbb{P}^n}$, we have two Kähler classes $b[H_n] - [E_n]$, $a[H_n] - [E_n]$. Suppose $\beta \in a[H_n] - [E_n]$ is a Kähler form. If $n \frac{ab^{n-1}-1}{b^n-1} > (n-1)$, then the equation [4](#page-5-3) has a solution $\omega \in a[H_n]-[E_n]$ given by [10](#page-8-0) and the corresponding map $U: P \to Q$ is given by

$$
U^i(x^1, \dots, x^n) = Ax^i + \frac{Bx^i}{X^n},
$$

where $X = \sum_{i=1}^{n} x^{i}$, $A = \frac{ab^{n-1}-1}{b^{n}-1}$ $\frac{b^{n-1}-1}{b^{n}-1}, B = \frac{b^{n}-ab^{n-1}}{b^{n}-1}$ $\frac{-ab^{n-1}}{b^n-1}$, P moment polytope of ω , Q moment polytope of β .

Remark 1. Observe that one can work with Kähler classes of the form $a[H_n] - b[E_n]$ with $a > b > 0$ in the theorem [4.1](#page-8-1) instead of Kähler classes of the form $p[H_n] - [E_n]$ with $p > 1$. This will change the boundary values of the corresponding ODE(see Proposition 2.1 in [\[11\]](#page-13-13)).

$\textbf{4.1} \quad \textbf{The} \,\, \alpha\textbf{-Futaki \,\, character \,\, on } \,\, \mathbb{P}^2 \# \overline{\mathbb{P}^2}$

We will work with Kähler classes of the following form $p[H_2] - [E_2]$, where H_2 is the pull back of the hyperplane divisor from \mathbb{P}^2 , E_2 is the exceptional divisor, and $p > 1$.

Theorem 4.2. Suppose L is an ample line bundle on $\mathbb{P}^2 \# \overline{\mathbb{P}^2}$ with $c_1(L) = a[H_2] - [E_2]$ and $[\omega] = b[H_2] - [E_2]$ satisfying $2\frac{ab-1}{b^2-1}$ $\frac{ab-1}{b^2-1} > 1$. Then there is no solution to the Kähler-Yang-Mills equations with $\frac{\alpha_1}{\alpha_0} > 0$. Furthermore, If a solution exists then $\frac{\alpha_1}{\alpha_0} = -\frac{2b^2(b^2-1)}{(b^2-ab)^2}$ $\frac{2b^-(b^--1)}{(b^2-ab)^2}$.

Proof. From [4.1,](#page-8-1) we know that there is a solution of the J-equation and a corresponding map between moment polytopes. The map $U: P_2 \to Q_2$ is given by

$$
U(x^{1}, x^{2}) = \left(Ax^{1} + \frac{Bx^{1}}{(x^{1} + x^{2})^{2}}, Ax^{2} + \frac{Bx^{2}}{(x^{1} + x^{2})^{2}}\right),
$$

where $P_2 = \{(x^1, x^2) \in \mathbb{R}^2 | x^1 \geq 0, x^2 \geq 0, 1 \leq x^1 + x^2 \leq b\}, Q_2 = \{(x^1, x^2) \in \mathbb{R}^2 | x^1 \geq 0, x^2 \geq 0, x^2 \geq 0\}$ $0, x^2 \ge 0, 1 \le x^1 + x^2 \le a\}, A = \frac{ab-1}{b^2-1}$ $\frac{ab-1}{b^2-1}$, and $B = \frac{b^2-ab}{b^2-1}$ $\frac{b^2-ab}{b^2-1}$. A simple calculation gives us

$$
DU = \begin{bmatrix} A + \frac{B(x^2 - x^1)}{(x^1 + x^2)^3} & -\frac{2Bx^1}{(x^1 + x^2)^3} \\ -\frac{2Bx^2}{(x^1 + x^2)^3} & A + \frac{B(x^1 - x^2)}{(x^1 + x^2)^3} \end{bmatrix}
$$

and

$$
Det(DU) = A^2 - \frac{B^2}{(x^1 + x^2)^4}.
$$

A routine calculation gives

$$
\int_{P_2} d\mu = \frac{b^2 - 1}{2}
$$
\n
$$
\int_{\partial P_2} d\sigma = 3b - 1
$$
\n
$$
\int_{P_2} x^1 d\mu = \frac{b^3 - 1}{6} = \int_{P_2} x^2 d\mu
$$
\n
$$
\int_{\partial P_2} x^1 d\sigma = b^2 = \int_{\partial P_2} x^2 d\sigma
$$
\n
$$
c_1 = -\frac{\int_{P_2} x^1 d\mu}{\int_{P_2} d\mu} = -\frac{b^2 + b + 1}{3(b + 1)} = c_2
$$
\n
$$
\int_{P_2} (x^1 + c_1) det(DU) dx^1 dx^2 = B^2 \frac{(b - 1)^3}{6b^2} = \frac{(b^2 - ab)^2 (b - 1)}{6b^2 (b + 1)^2}
$$
\n(11)

Now if there is a solution to the Kähler-Yang-Mills equations then the α -Futaki character vanishes. Hence using theorem [3.1,](#page-6-3) we get $\frac{\alpha_1}{\alpha_0} = -\frac{(b^2-1)}{(b-a)^2}$ $\frac{(b^2-1)}{(b-a)^2}$. Hence there is no solution to the Kähler-Yang-Mills equations for $\frac{\alpha_1}{\alpha_0} > 0$ and furthermore if there is a solution then $\frac{\alpha_1}{\alpha_0} = -\frac{(b^2-1)}{(b-a)^2}$ \Box $\frac{(b^2-1)}{(b-a)^2}$.

Remark 2. If we use Kähler classes of the form $a[H] - b[E]$ with $a > b > 0$ as stated in [1,](#page-8-2) we will get similar results, that is, $\frac{\alpha_1}{\alpha_0} < 0$.

Keller and Friedman constructed solution of Kähler-Yang-Mills equations on some line bundles over $\mathbb{P}^2 \# \overline{\mathbb{P}^2}$.

Theorem 4.3 (Keller-Friedman). There exists metrics h on the line bundle corresponding to the integral cohomology class $(8k+3)[H_2]-[E_2]$ and $\omega \in 3[H_2]-[E_2]$ such that they satisfy the Kähler-Yang-Mills equations with $\frac{\alpha_1}{\alpha_0} = -\frac{1}{8k^2}$ (Here $k \in \mathbb{N}$).

Proof. In [\[18\]](#page-13-5), Keller and Friedman proved that:

Suppose $M = \mathbb{P}(\mathcal{O} \oplus \mathcal{L}) \to \Sigma$ is a ruled surface with \mathcal{L} of degree $k \in \mathbb{Z}_+^*$. Fix $k' \in \mathbb{Z}_+^*, k_1 \in \mathbb{Z}^*$ $\mathbb{Z}, k_2 \in \mathbb{Z}^*$. Consider the integral classes $L = 2[E_0] + k'[C]$ and $E = 2(k_1 - k_2)[E_0] +$ $(k_1k' + k_2(2k + k'))[C]$. Then there exists a solution of Kähler-Yang-Mills equations with

 α_1 $\frac{\alpha_1}{\alpha_0} = -\frac{(2-s_{\Sigma})k + 2k'}{8k_2^2(k+k')}$ $\frac{8k-8\sum k+2k'}{8k_2^2(k+k')}$, where E_0 is the zero section, C denotes fiber, $s_{\Sigma} = \frac{2(1-h)}{k}$ $\frac{-h}{k}$, $h = \text{genus}(\Sigma)$.

Since $\mathbb{P}^2 \# \overline{\mathbb{P}^2} = \mathbb{P}(\mathcal{O} \oplus \mathcal{O}(1)) \to \mathbb{P}^1$, we take $\Sigma = \mathbb{P}^1$ and $k = 1$. The relations between $[E_2], [H_2],$ and C, E_0 are $[C] = [H_2] - [E_2], [E_0] = [H_2]$. Hence for L to be of the form $a[H_2] - [E_2]$, we must have $k' = 1$. Now E becomes $2(k_1 - k_2)[E_0] + (k_1 + 3k_2)[C] =$ $(3k_1 + k_2)[H_2] - (k_1 + 3k_2)[E_2]$. Now putting $k_2 = -k$ and $k_1 = 1 + 3k$ with $k \in \mathbb{N}$, we get $E = (8k+3)[H_2] - [E_2]$. Finally, we compute $\frac{\alpha_1}{\alpha_0} = -\frac{1}{8k}$ $\frac{1}{8k^2}$. Observe that our theorem [4.2](#page-8-3) also asserts that $\frac{\alpha_1}{\alpha_0}$ has to be $-\frac{3^2-1}{(3-8k-3)^2} = -\frac{1}{8k}$ $\frac{1}{8k^2}$. \Box

Remark 3. The above analysis also indicates that why Keller-Friedman could not find solution of Kähler-Yang-Mills equations with $\frac{\alpha_1}{\alpha_0} > 0$.

$\textbf{4.2} \quad \textbf{The} \,\, \alpha\textbf{-Futaki \,\, character \,\, on } \,\, \mathbb{P}^3 \# \overline{\mathbb{P}^3}$

We will work with Kähler classes of the form $p[H_3] - [E_3]$, where H_3 is the pullback of the hyperplane divisor from \mathbb{P}^3 and E_3 is the exceptional divisor, $p > 1$.

Theorem 4.4. Suppose L is an ample line bundle on $\mathbb{P}^3 \# \overline{\mathbb{P}^3}$ with $c_1(L) = a[H_3] - [E_3]$ and $[\omega] = b[H_3] - [E_3]$ satisfying $3 \frac{ab^2 - 1}{b^3 - 1}$ $\frac{10^2-1}{10^3-1} > 2$. Then there is no solution to Kähler-Yang-Mills equations with $\frac{\alpha_1}{\alpha_0} > 0$. Furthermore, If a solution exists then $\frac{\alpha_1}{\alpha_0} = -\frac{(3b+1)(b-1)^3(b^2+b+1)}{3b(b-a)^2(b^3+b^2-b+1)}$ $\frac{(3b+1)(b-1)^{6}(b^2+b+1)}{3b(b-a)^2(b^3+b^2-b+1)}.$

Proof. From [4.1,](#page-8-1) we know that there is a solution of the J-equation and a corresponding map between moment polytopes. So we have a map $U: P_3 \to Q_3$ given by

$$
U(x^{1}, x^{2}, x^{3}) = (Ax^{1} + \frac{Bx^{1}}{(x^{1} + x^{2} + x^{3})^{3}}, Ax^{2} + \frac{Bx^{2}}{(x^{1} + x^{2} + x^{3})^{3}}, Ax^{3} + \frac{Bx^{3}}{(x^{1} + x^{2} + x^{3})^{3}}),
$$

where $P_3 = \{(x^1, x^2, x^3) \in \mathbb{R}^3 | x^i \ge 0 \}$ $i = 1, 2, 3; 1 \le x^1 + x^2 + x^3 \le b\}$, $Q_3 = \{(x^1, x^2, x^3) \in \mathbb{R}^3 \}$ $\mathbb{R}^3 | x^i \geq 0 \, i = 1, 2, 3; 1 \leq x^1 + x^2 + x^3 \leq a \}, \, A = \frac{a \overline{b^2 - 1}}{b^3 - 1}$ $\frac{b^2-1}{b^3-1}$, and $B = \frac{b^3-ab^2}{b^3-1}$ $\frac{b^3-ab^2}{b^3-1}$. A simple calculation yields

$$
DU = \begin{bmatrix} A - \frac{3Bx^1}{X^4} + \frac{B}{X^3} & -\frac{3Bx^1}{X^4} & -\frac{3Bx^1}{X^4} \\ -\frac{3Bx^2}{X^4} & A - \frac{3Bx^2}{X^4} + \frac{B}{X^3} & -\frac{3Bx^2}{X^4} \\ -\frac{3Bx^3}{X^4} & -\frac{3Bx^3}{X^4} & A - \frac{3Bx^3}{X^4} + \frac{B}{X^3} \end{bmatrix},
$$

where $X = x^1 + x^2 + x^3$. Suppose M_1, M_2, M_3 are all the 2×2 principal minor of DU. Then

$$
M_1 + M_2 + M_3 = 3(A^2 - \frac{B^2}{X^6}).
$$

A routine calculation yields

$$
\int_{P_3} d\mu = \frac{b^3 - 1}{6}
$$
\n
$$
\int_{\partial P_3} d\sigma = 2b^2 - 1
$$
\n
$$
\int_{P_3} x^i d\mu = \frac{b^4 - 1}{24}, \quad i = 1, 2, 3
$$
\n
$$
\int_{\partial P_3} x^i d\sigma = \frac{3b^3 - 1}{6}, \quad i = 1, 2, 3
$$
\n
$$
\int_{P_3} (x^i + c_i) 3(A^2 - \frac{B^2}{X^6}) d\mu = \frac{B^2(b^4 - 2b^3 + 2b - 1)}{8b^3}, \quad i = 1, 2, 3
$$
\nSuppose the following equations:

\n
$$
2b = 1, 2, 3
$$

where $c_i = -\frac{(b^2+1)(b+1)}{4(b^2+b+1)}$ $\frac{a^{2}+1)(b+1)}{4(b^{2}+b+1)}$ Now if there is a solution to the Kähler-Yang-Mills equations then the α -Futaki character

vanishes. Hence using theorem 3.1, we get
$$
\frac{\alpha_1}{\alpha_0} = -\frac{(3b+1)(b-1)^3(b^2+b+1)}{3b(b-a)^2(b^3+b^2-b+1)}
$$
. Hence there is no solution of the Kähler-Yang-Mills equations for $\frac{\alpha_1}{\alpha_0} > 0$ and furthermore, if there is a solution then $\frac{\alpha_1}{\alpha_0} = -\frac{(3b+1)(b-1)^3(b^2+b+1)}{3b(b-a)^2(b^3+b^2-b+1)}$.

Finally, we prove that the line bundles that we constructed in [\[17\]](#page-13-10) over $\mathbb{P}(\mathcal{O} \oplus \mathcal{O}(-1)) \to \mathbb{P}^1$ are not ample.

Proposition 4.5. Suppose $X = \mathbb{P}(\mathcal{O} \oplus \mathcal{O}(-1)) \rightarrow \mathbb{P}^1$ and L is the line bundle corresponding to the second integral cohomology class $\delta = \frac{a\omega + b\gamma}{2\pi}$ $\frac{\partial^2 \mathcal{H}}{\partial \pi}$, where ω is a Kähler metric, γ is a tracefree(with respect to ω) (1, 1) form, $a = \frac{m_1 + m_2 \log 3}{2 + 3 \log 3}$, and $b = \frac{2m_2 - 3m_1}{2 + 3 \log 3}$ for $(m_1, m_2) \neq$ $(0, 0)$. These line bundles are not ample.

Proof. First we recall the expression for ω and γ (for details see [\[17\]](#page-13-10)). The expressions are as follows

$$
\omega = (1+\tau)\omega_{FS} + \phi(\tau)\frac{\sqrt{-1}dw \wedge d\bar{w}}{|w|^2},
$$

$$
\gamma = \omega_{FS} - \frac{\phi(\tau)}{1+\tau}\frac{\sqrt{-1}dw \wedge d\bar{w}}{|w|^2},
$$

where $\phi(\tau): [0, 2] \to \mathbb{R}$ is a function, $\tau: X \to [0, 2]$ is a map, w fiber coordinate, and ω_{FS} is the Fubini-Study metric on X.

Let's assume that the line bundles are ample. Then from Nakai-Moishezon criterion, we get

$$
\int_{\mathbb{P}^1} \delta > 0, \quad \int_C \delta > 0, \quad \int_X \delta^2 > 0,
$$

where C denotes fiber.

A routine calculations yields

$$
a + b > 0
$$
, $2a - b \log 3 > 0$, $b^2 \log 3 > 4a^2$.

Writing these inequalities in terms of m_1, m_2 , we get

$$
m_1 < (1 + \log \sqrt{3})m_2
$$
, $m_1 > 0$, $(9 \log 3 - 4)m_1^2 > 20m_1m_2 \log 3$.

Now

$$
m_1 < (1 + \log \sqrt{3})m_2 < \frac{9 \log 3 - 4}{20 \log 3}m_1
$$

20 log 3 < 9 log 3 - 4
4 + 11 log 3 < 0. (13)

A contradiction.
