# The characterizations of monotone functions which generate associative functions<sup>\*</sup>

Abstract Associativity of a two-place function  $T : [0,1]^2 \to [0,1]$  defined by  $T(x,y) = f^{(-1)}(F(f(x), f(y)))$  where  $F : [0,\infty]^2 \to [0,\infty]$  is an associative function,  $f : [0,1] \to [0,\infty]$  is a monotone function which satisfies either  $f(x) = f(x^+)$  when  $f(x^+) \in \operatorname{Ran}(f)$  or  $f(x) \neq f(y)$  for any  $y \neq x$  when  $f(x^+) \notin \operatorname{Ran}(f)$  for all  $x \in [0,1]$  and  $f^{(-1)} : [0,\infty] \to [0,1]$  is a pseudo-inverse of f depends only on properties of the range of f. The necessary and sufficient conditions for the T to be associative are presented by applying the properties of the monotone function f.

*Keywords*: Associative function; monotone function; Pseudo-inverse; Associativity; Triangular norm

### 1 Introduction

The constructing methods of associative functions starting from an one-place function play an indispensable role in the theory of solving an associative equations [2]. The idea that a strictly monotone function may generate an associative function traces to the old work of Abel [1]. The relation between triangular norms (t-norms for short) and continuous strictly decreasing additive generators was originally explored by Schweizer and Sklar [9] and Ling [5]. Note that the concept of an additive generator, which is first introduced in Schweizer and Sklar [9], of a t-norm has been generalized several times in the literature, see e.g., [3–8, 10, 13–15]. In particular, Klement, Mesiar and Pap [4] define an additive generator as a strictly decreasing function  $f : [0, 1] \rightarrow [0, \infty]$  that is right-continuous at 0 with f(1) = 0 such that for all  $(x, y) \in [0, 1]^2$ ,

$$f(x) + f(y) \in \operatorname{Ran}(f) \cup [f(0), \infty],\tag{1}$$

and

$$T(x,y) = f^{(-1)}(f(x) + f(y))$$
(2)

where  $f^{(-1)}$  is a pseudo-inverse of f and  $\operatorname{Ran}(f)$  is a range of f. Based on Vicen ik [11, 12] they claim that there exists a generalized additive generator just satisfying (2), and this was identified by Vicenik [13] when f is a strictly decreasing function and by Zhang and Wang [16] when f is a monotone right continuous functions, respectively. Yao Ouyang et al. [8] also generalized the concept of additive generator of t-norms as that there are a strictly decreasing function  $f: [0,1] \to [0,\infty]$  with f(1) = 0 and a binary operator  $\bigstar: [0,\infty]^2 \to [0,\infty]$  satisfying that  $([0,\infty],\bigstar,\leq)$  is a fully ordered Abel semigroup with neutral element 0, such that

$$f(x) \bigstar f(y) \in \operatorname{Ran}(f) \cup [f(0^+), \infty] \tag{3}$$

for all  $x, y \in [0, 1]$  and

$$T(x,y) = f^{(-1)}(f(x) \star f(y))$$
(4)

where  $f^{(-1)}$  is the pseudo-inverse of f and  $\operatorname{Ran}(f)$  is the range of f. Motivated by the work of Viceník [13], Yao Ouyang [8] and Zhang and Wang [16], this article further considers the problem: what are characterizations of monotone functions  $f: [0,1] \to [0,\infty]$  such that the function  $T: [0,1]^2 \to [0,1]$  given by

$$T(x,y) = f^{(-1)}(F(f(x), f(y)))$$
(5)

is associative where  $f^{(-1)}$  is the pseudo-inverse of f and  $F: [0,\infty]^2 \to [0,\infty]$  is an associative function?

The rest of this article is organized as follows. In Section 2, we show some preliminaries concerned on basic concepts and known results of t-norms and t-conorms, respectively. In Section 3, we give a representation of the range  $\operatorname{Ran}(f)$  of a kind of non-decreasing functions f. In Section 4, we first define an operation  $\otimes$  on the  $\operatorname{Ran}(f)$ , and then supply a necessary and sufficient condition for the operation  $\otimes$  being associative. In Section 5, we characterize what properties of  $\operatorname{Ran}(f)$  are equivalent to the associativity of the function T defined by Eq.(5). A conclusion is drawn in Section 6.

# 2 Preliminaries

This section recalls some known elementary concepts and results in the literature, respectively.

**Definition 2.1** ([4]) A t-norm is a binary operator  $T : [0,1]^2 \to [0,1]$  such that for all  $x, y, z \in [0,1]$  the following conditions are satisfied:

(T1) T(x,y) = T(y,x),

(T2) T(T(x,y),z) = T(x,T(y,z)),

(T3)  $T(x,y) \leq T(x,z)$  whenever  $y \leq z$ ,

(T4) 
$$T(x,1) = T(1,x) = x$$
.

A binary operator  $T : [0, 1]^2 \rightarrow [0, 1]$  is called t-subnorm if it satisfies (T1), (T2), (T3), and  $T(x, y) \leq \min\{x, y\}$  for all  $x, y \in [0, 1]$ .

**Definition 2.2** ([4]) A t-conorm is a binary operator  $T : [0,1]^2 \to [0,1]$  such that for all  $x, y, z \in [0,1]$  the following conditions are satisfied:

(S1) S(x,y) = S(y,x),

(S2) 
$$S(S(x,y),z) = S(x,S(y,z)),$$

(S3) 
$$S(x, y) \leq S(x, z)$$
 whenever  $y \leq z$ ,

(S4) 
$$S(x,0) = S(0,x) = x$$

A binary operator  $S : [0,1]^2 \to [0,1]$  is called t-subconorm if it satisfies (S1), (S2), (S3), and  $T(x,y) \ge \max\{x,y\}$  for all  $x, y \in [0,1]$ .

**Definition 2.3 ( [4,13])** Let  $p, q, s, t \in [-\infty, \infty]$  with p < q, s < t and  $f : [p,q] \to [s,t]$  be a nondecreasing (resp. non-increasing) function. Then the function  $f^{(-1)} : [s,t] \to [p,q]$  defined by

$$f^{(-1)}(y) = \sup\{x \in [p,q] \mid f(x) < y\} \text{ (resp. } f^{(-1)}(y) = \sup\{x \in [p,q] \mid f(x) > y\}\text{)}$$

is called a pseudo-inverse of a non-decreasing (resp. non-increasing) function f.

Denoted by  $A \setminus B = \{x \in A \mid x \notin B\}$  for two sets A and B.

### 3 The range of a non-decreasing function

This section describes the range of a kind of non-decreasing functions.

Let  $f: [0,1] \to [0,\infty]$ . We write  $f(a^-) = \lim_{x \to a^-} f(x)$  for each  $a \in (0,1]$  and  $f(a^+) = \lim_{x \to a^+} f(x)$  for each  $a \in [0,1)$ . Define  $f(0^-) = 0$  and  $f(1^+) = \infty$  whenever f is non-decreasing.

Let  $M \subseteq [0, \infty]$ . We say a point  $x \in [0, \infty]$  an accumulation point of M from the left if there is a strictly increasing sequence  $\{x_n\}_{n \in N}$  of points  $x_n \in M$  satisfying  $\lim_{n \to \infty} x_n = x$ . We say a point  $x \in [0, \infty]$  an accumulation point of M from the right if there is a strictly decreasing sequence  $\{x_n\}_{n \in N}$  of points  $x_n \in M$  satisfying  $\lim_{n\to\infty} x_n = x$ . We say a point  $x \in [0, 1]$  an accumulation point of M if x is an accumulation point of M from the left or from the right. Denote the set of all accumulation points of M by Acc(M).

Denote by  $\mathcal{F}$  the set of all non-decreasing functions  $f:[0,1] \to [0,\infty]$  which satisfies either  $f(x) = f(x^+)$  when  $f(x^+) \in \operatorname{Ran}(f)$  or  $f(x) \neq f(y)$  for any  $y \neq x$  when  $f(x^+) \notin \operatorname{Ran}(f)$  for all  $x \in [0,1]$ . It is easy to see that both a strictly increasing and non-decreasing right continuous functions are special elements of  $\mathcal{F}$ . Let

 $\mathcal{A} = \{ M \mid \text{there is a function } f \in \mathcal{F} \text{ such that } \operatorname{Ran}(f) = M \}.$ 

Then the following lemma describes the range of a function  $f \in \mathcal{F}$ .

**Lemma 3.1** Let  $M \in \mathcal{A}$  with  $M \neq [0, \infty]$ . Then there are a uniquely determined non-empty countable system  $S = \{[b_k, d_k] \subseteq [0, \infty] \mid k \in K\}$  of pairwise closed intervals of a positive length which satisfies that for all  $[b_k, d_k], [b_l, d_l] \in S, [b_k, d_k] \cap [b_l, d_l] = \emptyset$  or  $[b_k, d_k] \cap [b_l, d_l] = \{d_k\}$  when  $d_k \leq b_l$ , and a uniquely determined non-empty countable set  $C = \{c_k \in [0, \infty] \mid k \in \overline{K}\}$  such that  $[b_k, d_k] \cap C \in$  $\{\{b_k\}, \{d_k\}, \{b_k, d_k\}\}$  for all  $k \in K$  and

$$M = \{c_k \in [0,\infty] \mid k \in \overline{K}\} \cup \left([0,\infty] \setminus \left(\bigcup_{k \in K} [b_k, d_k]\right)\right)$$

where  $|K| \leq |\overline{K}|$ .

**Proof.** The existence of both S and C will be proved. From  $M \in \mathcal{A}$  with  $M \neq [0, \infty]$ , there is a function  $f \in \mathcal{F}$  with  $\operatorname{Ran}(f) = M$ . Take  $S = \{[f(x^-), f(x)] \mid x \in [0, 1], f(x^-) < f(x)\} \cup \{[f(x), f(x^+)] \mid x \in [0, 1], f(x) < f(x^+)\}$  and  $C = \{f(x^+) \mid x \in [0, 1], f(x^+) \in M\} \cup \{f(x^-) \mid x \in [0, 1], f(x^-) \in M\} \cup \{f(x) \mid x \in [0, 1], f(x^-) < f(x^+)\}$ . Clearly the set S is countable. Let K be a countable index set with |K| = |S| and rewrite S as  $S = \{[b_k, d_k] \subseteq [0, \infty] \mid k \in K\}$  in which either  $b_k = f(k^-), d_k = f(k)$  or  $b_k = f(k), d_k = f(k^+)$  for each  $k \in K$ . The set C is also countable. Let  $\overline{K}$  be a countable index set with  $|\overline{K}| = |C|$ . It is obvious that  $|K| \leq |\overline{K}|$ . Rearrange C from small to large and assign its every element an index  $k \in \overline{K}$ , for instance, the k-th element in the rearranged set C is denoted by  $c_k$  with  $k \in \overline{K}$ . This follows that  $C = \{c_k \in [0, \infty] \mid k \in \overline{K}\}$ . Note that for every  $k \in K$ , there is an  $i \in \overline{K}$  such that  $b_k = f(k) = c_i$  when  $f(k^-) \in M$  and  $f(k) = f(k^-)$ , there are two elements  $s, t \in \overline{K}$  with s + 1 = t satisfying that  $d_k = f(k) = c_i$  and  $b_k = f(k^-) = c_s$  when  $f(k^-) \in M$  and  $f(k) \neq f(k^-)$ , and there is a  $j \in \overline{K}$  such that  $d_k = f(k) = c_j$  when  $f(k^-) \notin M$ . Obviously, S and C have all required properties, respectively.

In what follows, the uniqueness of both S and C will be proved. Suppose that a system  $S_1 = \{[u_l, v_l] \subseteq [0, \infty] \mid l \in K_1\}$  and a set  $C_1 = \{c_l \in [0, \infty] \mid l \in \overline{K}_1\}$  also have all required properties. Then we shall prove that  $S = S_1$ . Let  $[b_k, d_k]$  be an arbitrary element of S. Choosing  $t \in [b_k, d_k]$  such that  $t \notin M$ , this means that there is a  $[u_l, v_l] \in S_1$  such that  $t \in [u_l, v_l]$  where  $[u_l, v_l] \cap M \in \{\{u_l\}, \{v_l\}, \{u_l, v_l\}\}$ . Next, we shall prove that  $[b_k, d_k] = [u_l, v_l]$ .

First supposing that  $d_k \leq u_l < v_l$ , this contradicts the fact that  $t \in [b_k, d_k]$  and  $t \in [u_l, v_l]$  with  $t \notin M$ . Now, assume  $u_l < d_k < v_l$ . If  $d_k \in M$ , then  $d_k \in [u_l, v_l] \cap M$ , contrary to  $[u_l, v_l] \cap M \in \{\{u_l\}, \{v_l\}, \{u_l, v_l\}\}$ . If  $d_k \notin M$ , then  $d_k$  is an accumulation point of M from the right. This follows that the set  $[u_l, v_l] \cap M$ is infinite, a contradiction since  $[u_l, v_l] \cap M \in \{\{u_l\}, \{v_l\}, \{u_l, v_l\}\}$ . Therefore,  $u_l < v_l \leq d_k$ .

In a completely analogous way, we have  $b_k \leq u_l < v_l$ .

Consequently,  $b_k \leq u_l < v_l \leq d_k$ 

Below, we shall prove that  $v_l = d_k$ , the proof of  $b_k = u_l$  being analogous. Suppose that  $v_l < d_k$ . Then there exists a  $t_1 \in (v_l, d_k)$  such that  $t_1 \notin M$ , and there exist  $a \in K_1$  and an interval  $[u_a, v_a] \in S_1$  such that  $t_1 \in [u_a, v_a]$  where  $[u_a, v_a] \cap M \in \{\{u_a\}, \{v_a\}, \{u_a, v_a\}\}$ . Obviously,  $v_a \leq d_k$ . Let  $m \in [u_l, v_l] \cap M$ ,  $n \in [u_a, v_a] \cap M$ . Then  $[m, n] \cap M \neq \emptyset$ . Since  $b_k \leq u_l < v_l \leq u_a < v_a \leq d_k$ , we have  $[m, n] \cap M \subseteq [b_k, d_k]$ . In the case of  $v_l = u_a$ , we have  $v_l \in [b_k, d_k] \cap M$ , which contradicts the fact  $[b_k, d_k] \cap M \in \{\{b_k\}, \{d_k\}, \{b_k, d_k\}\}$ . In the case of  $v_l \neq u_a$ ,  $[m, n] \cap M$  is an infinite set. This means that  $[b_k, d_k] \cap M$  is also infinite, a contradiction. Therefore,  $v_l = d_k$ . We finally come to  $[b_k, d_k] = [u_l, v_l]$ . From the arbitrariness of  $[b_k, d_k]$ , we have  $S \subseteq S_1$ . The case  $S \supseteq S_1$  is completely analogous. Therefore,  $S = S_1$ . This follows that  $C = C_1$ . In particular, both S and C are independent of choice of f.

**Definition 3.1** Let  $M \in \mathcal{A}$ . A pair (S, C) is said to be associated with  $M \neq [0, \infty]$  if  $S = \{[b_k, d_k] \subseteq [0, \infty] \mid k \in K\}$  is a non-empty system of pairwise closed intervals of a positive length which satisfies that for all  $[b_k, d_k], [b_l, d_l] \in S, [b_k, d_k] \cap [b_l, d_l] = \emptyset$  or  $[b_k, d_k] \cap [b_l, d_l] = \{b_l\}$  when  $d_k \leq b_l$ , and  $C = \{c_k \in [0, \infty] \mid k \in K\}$  is a non-empty countable set such that  $[b_k, d_k] \cap C \in \{\{b_k\}, \{d_k\}, \{b_k, d_k\}\}$  for all  $k \in M$ , and

$$M = \{c_k \in [0,\infty] \mid k \in \overline{K}\} \cup \left([0,\infty] \setminus \left(\bigcup_{k \in K} [b_k, d_k]\right)\right).$$

A pair (S, C) is said to be associated with  $M = [0, \infty]$  if  $S = \{[\infty, \infty]\}$  and  $C = \{\infty\}$ .

We shall briefly write  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  instead of  $(S, C) = (\{[b_k, d_k] \subseteq [0, \infty] \mid k \in K\}, \{c_k \in [0, \infty] \mid k \in \overline{K}\}).$ 

The following remark is immediately from Definition 3.1.

**Remark 3.1** Let  $M \in \mathcal{A}$ ,  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M and  $f \in \mathcal{F}$  with  $\operatorname{Ran}(f) = M$ .

- (i) Let  $x \in M \setminus C$ . Then there is a  $t \in (0, 1)$  such that f(t) = x. It is easily seen that f is continuous at t and x is an accumulation point of M. In particular,  $M \setminus C \subseteq Acc(M)$ .
- (ii) For all  $a, b \in M \setminus C$ , if a < b then  $(a, b) \cap (M \setminus C) \neq \emptyset$ .
- (iii) If  $[b_k, d_k] \cap M = \{b_k\}$  for a certain  $k \in K$ , then  $d_k$  is an accumulation point of M from the right.
- (iv) If  $[b_k, d_k] \cap M = \{d_k\}$  for a certain  $k \in K$ , then  $b_k$  is an accumulation point of M from the left.
- (v) If  $[b_k, d_k] \cap M = \{b_k, d_k\}$  for a certain  $k \in K$ , then there exist two elements  $x, y \in [0, 1]$  such that  $f(x) = f(y) = b_k$ .

#### Example 3.1

(i) Let the function  $f_1: [0,1] \to [0,\infty]$  be defined by

$$f_1(x) = \begin{cases} 4x & \text{if } x \in [0, \frac{1}{2}), \\ 2 & \text{if } x \in [\frac{1}{2}, \frac{3}{4}), \\ 9 & \text{if } x \in [\frac{3}{4}, \frac{7}{8}), \\ 10 & \text{if } x = \frac{7}{8}, \\ \frac{2}{1-x} & \text{if } x \in (\frac{7}{8}, 1), \\ \infty & x = 1 \end{cases}$$

Then the pair  $(\{[2,9], [9,10], [10,16]\}, \{9,10\})$  is associated with  $[0,2) \cup \{9\} \cup (10) \cup [16,\infty] \in \mathcal{A}$ .

(ii) Let the function  $f_2: [0,1] \to [0,\infty]$  be defined by

$$f_2(x) = \begin{cases} 8x & \text{if } x \in [0, \frac{1}{4}), \\ 3 & \text{if } x \in [\frac{1}{4}, \frac{1}{2}), \\ 5 & \text{if } x \in [\frac{1}{2}, \frac{3}{4}). \\ 8x & \text{if } x \in [\frac{3}{4}, \frac{7}{8}]. \\ 7 & \text{if } x \in (\frac{7}{8}, 1]. \end{cases}$$

Then the pair  $(\{[2,3], [3,5], [5,6], [7,\infty]\}, \{3,5,6,7\})$  is associated with  $[0,2) \cup \{3\} \cup \{5\} \cup [6,7] \in \mathcal{A}$ .

(iii) Let the function  $f_3: [0,1] \to [0,\infty]$  be defined by

$$f_3(x) = \begin{cases} 1 & \text{if } x \in [0, \frac{1}{10}), \\ 10x & \text{if } x \in [\frac{1}{10}, \frac{2}{5}), \\ 8 & \text{if } x \in [\frac{2}{5}, \frac{3}{5}), \\ 10 & \text{if } x = \frac{3}{5}, \\ 20x & \text{if } x \in (\frac{3}{5}, 1]. \end{cases}$$

Then the pair ({[0,1], [4,8], [8,10], [10,12], [20,  $\infty$ ], {1, 8, 10, 20}) is associated with [1,4)  $\cup$  {8}  $\cup$  {10}  $\cup$  (12, 20]  $\in \mathcal{A}$ .

# 4 An operation on $\operatorname{Ran}(f)$ and its properties

This section first defines an operation  $\otimes$  on  $\operatorname{Ran}(f)$  with  $f \in \mathcal{F}$ , and then gives a necessary and sufficient conditions for the operation  $\otimes$  being associative that exactly depends on  $\operatorname{Ran}(f)$ . Let  $M \in \mathcal{A}$  and  $x \in [0, \infty]$ . Then by convention,  $\sup \emptyset = 0$  and  $\inf \emptyset = \infty$ .

**Definition 4.1** Let  $M \in \mathcal{A}$ . Define a function  $G_M : [0, \infty] \to M$  by

 $G_M(x) = \operatorname{Max}\{M \cap \{\sup([0, x] \cap M), \inf([x, \infty] \cap M)\}\} \text{ for all } x \in [0, \infty].$ 

The next proposition shows the relationship between M and  $G_M$ .

**Proposition 4.1** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. Then for all  $x \in [0, \infty]$  and  $k \in K$ ,

- (i)  $G_M(x) = x$  if and only if  $x \in M$ .
- (ii) if  $x \notin M$  and x < f(0) then  $G_M(x) = f(0)$ .

(iii) if  $x \notin M$  and f(0) < x < f(1), then  $G_M(x) = d_k$  if and only if  $x \in [b_k, d_k]$  and  $d_k \in M$ .

- (iv) if  $x \notin M$  and f(0) < x < f(1), then  $G_M(x) = b_k$  if and only if  $x \in [b_k, d_k]$  and  $d_k \notin M$ .
- (v) if  $x \notin M$  and f(1) < x then  $G_M(x) = f(1)$ .
- (vi)  $G_M$  is a non-decreasing function.

**Proof.** Statements (i), (ii), (v) and (vi) are immediately from Definition 4.1.

(iii) Let  $x \notin M$  and f(0) < x < f(1). If  $G_M(x) = d_k$ , then from the definition of  $G_M(x)$ ,  $x \in [b_k, d_k]$  and  $d_k \in M$ . The converse implication is obvious.

(iv) Let  $x \notin M$  and f(0) < x < f(1). If  $G_M(x) = b_k$ , then from the definition of  $G_M(x)$ ,  $x \in [b_k, d_k]$ and  $d_k \notin M$ . Conversely, if  $x \in [b_k, d_k]$  and  $d_k \notin M$ , then  $b_k \in M$ , we get  $\sup([0, x] \cap M) = b_k$  and  $\inf([x, \infty] \cap M) = d_k$ , therefore,  $G_M(x) = b_k$ .

Example 4.1 In Example 3.1,

(i)

$$G_M(x) = \begin{cases} 9 & \text{if } x \in [2,9], \\ 10 & \text{if } x \in (9,16], \\ x & \text{otherwise.} \end{cases}$$

(ii)

$$G_M(x) = \begin{cases} 3 & \text{if } \mathbf{x} \in (2,3], \\ 5 & \text{if } \mathbf{x} \in (3,5], \\ 6 & \text{if } \mathbf{x} \in (5,6], \\ 7 & \text{if } \mathbf{x} \in [7,\infty], \\ x & \text{otherwise.} \end{cases}$$

(iii)

$$G_M(x) = \begin{cases} 1 & \text{if } \mathbf{x} \in [0, 1], \\ 8 & \text{if } \mathbf{x} \in [4, 8], \\ 10 & \text{if } \mathbf{x} \in (8, 12], \\ 20 & \text{if } \mathbf{x} \in [20, \infty], \\ x & \text{otherwise.} \end{cases}$$

In the forthcoming content, let  $F: [0,\infty]^2 \to [0,\infty]$  be an associative function.

**Definition 4.2** Let  $M \in \mathcal{A}$  and  $G_M$  be determined by M. Define an operation  $\otimes : M^2 \to M$  by

$$x \otimes y = G_M(F(x,y)).$$

Example 4.2 In Example 4.1,

(i)

$$x\otimes y = \begin{cases} 9 & \text{if } \mathcal{F}(\mathbf{x},\mathbf{y})\in[2,9],\\ 10 & \text{if } \mathcal{F}(\mathbf{x},\mathbf{y})\in(9,16],\\ F(x,y) & \text{otherwise.} \end{cases}$$

(ii)

$$x \otimes y = \begin{cases} 3 & \text{if } \mathcal{F}(\mathbf{x}, \mathbf{y}) \in (2, 3], \\ 5 & \text{if } \mathcal{F}(\mathbf{x}, \mathbf{y}) \in (3, 5], \\ 6 & \text{if } \mathcal{F}(\mathbf{x}, \mathbf{y}) \in (5, 6], \\ 7 & \text{if } \mathcal{F}(\mathbf{x}, \mathbf{y}) \in [7, \infty], \\ F(x, y) & \text{otherwise.} \end{cases}$$

(iii)

$$x \otimes y = \begin{cases} 1 & \text{if } \mathbf{F}(\mathbf{x}, \mathbf{y}) \in [0, 1], \\ 8 & \text{if } \mathbf{F}(\mathbf{x}, \mathbf{y}) \in [4, 8], \\ 10 & \text{if } \mathbf{F}(\mathbf{x}, \mathbf{y}) \in (8, 12], \\ 20 & \text{if } \mathbf{F}(\mathbf{x}, \mathbf{y}) \in [20, \infty], \\ F(x, y) & \text{otherwise.} \end{cases}$$

**Proposition 4.2** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. Then for all  $x, y \in M$  and  $k \in K$ ,

- (i)  $x \otimes y = F(x, y)$  if and only if  $F(x, y) \in M$ .
- (ii) if  $F(x,y) \notin M$  and F(x,y) < f(0) then  $x \otimes y = f(0)$ .
- (iii) if  $F(x,y) \notin M$  and f(0) < F(x,y) < f(1), then  $x \otimes y = d_k$  if and only if  $F(x,y) \in [b_k, d_k]$  and  $d_k \in M$ .
- (iv) if  $F(x,y) \notin M$  and f(0) < F(x,y) < f(1), then  $x \otimes y = b_k$  if and only if  $F(x,y) \in [b_k,d_k]$  and  $d_k \notin M$
- (v) if  $F(x, y) \notin M$  and f(1) < F(x, y) then  $x \otimes y = f(1)$ .
- $(vi) \otimes is a non-decreasing function.$

**Proof.** It is an immediate consequence of Propositions 4.1 and Definition 4.2.

**Lemma 4.1** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. Then  $G_M(x) = f(f^{(-1)}(x))$  for all  $x \in [0, \infty]$ .

**Proof.** If  $x \in \text{Ran}(f)$ , then  $f(f^{(-1)}(x)) = x$  since  $f \in \mathcal{F}$ .

If  $x \notin \operatorname{Ran}(f)$  then there are three cases as follows.

(i) If f(0) < x < f(1), then there is a  $k \in K$  such that  $x \in [b_k, d_k]$ . Obviously, if  $d_k \in M$  then  $f(f^{(-1)}(x)) = d_k$ ; if  $d_k \notin M$  then  $f(f^{(-1)}(x)) = b_k$ . Therefore, by Proposition 4.1(iii) and (iv), we get  $G_M(x) = f(f^{(-1)}(x))$ .

(ii) If x < f(0), then  $G_M(x) = f(0)$  and  $f(f^{(-1)}(x)) = f(\sup\{y \in [0,1] \mid f(y) < x\}) = f(\sup\emptyset) = f(0)$ .

(iii) If f(1) < x, then  $G_M(x) = f(1)$  and  $f(f^{(-1)}(x)) = f(\sup\{y \in [0,1] \mid f(y) < x\}) = f(1)$ . In summary,  $G_M(x) = f(f^{(-1)}(x))$  for all  $x \in [0,\infty]$ .

It is obvious that the function f is a constant function then  $G_M(x) = f(f^{(-1)}(x))$  for all  $x \in [0, \infty]$ . Therefore, in the following we further suppose that all functions  $f \in \mathcal{F}$  are non-constant. In particular, we have the following remark.

**Remark 4.1** Let  $f \in \mathcal{F}$ . In Lemma 4.1, the condition that  $f(x) = f(x^+)$  when  $f(x^+) \in \text{Ran}(f)$  can not be deleted when f is not strictly monotone. For instance, let the function  $f : [0, 1] \to [0, \infty]$  be defined by

$$f(x) = \begin{cases} 4x & \text{if } x \in [0, \frac{1}{4}], \\ 2 & \text{if } x \in (\frac{1}{4}, \frac{1}{2}], \\ 8x & \text{if } x \in (\frac{1}{2}, 1]. \end{cases}$$

It is clear that  $f(\frac{1}{4}^+) \in \operatorname{Ran}(f)$  but  $f(\frac{1}{4}) \neq f(\frac{1}{4}^+)$  and  $G_M(2) = 2 > 1 = f(f^{(-1)}(2))$ , i.e.,  $G_M \neq f(f^{(-1)})$ .

Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. Denote

$$E = \{c_k \mid \text{ there are an } x_0 \in [0, 1] \text{ and } \varepsilon > 0 \text{ such that } f|_{[x_0, x_0 + \varepsilon]} = c_k\},\$$
$$N = \{\min\{x \in [0, 1] \mid f(x) = y\} \mid y \in E\},\ J = \{x \in [0, 1] \mid f(x) \in M \setminus E\}\$$
$$B = N \cup J.$$

One easily check that  $f^{(-1)}(x) \in B$  for all  $x \in [0, \infty]$ .

We further give the following definition.

**Definition 4.3** Let  $f \in \mathcal{F}$ . Define a function  $f^* : B \to [0, \infty]$  by

 $f^*(x) = f(x)$  for all  $x \in B$ 

and a two-place function  $F_0: B^2 \to B$  by

$$F_0(x,y) = f^{(-1)}(F(f^*(x), f^*(y)))$$

for all  $x, y \in B$ , respectively.

Then from Definition 4.3, one can check the following remark.

**Remark 4.2** Let  $f \in \mathcal{F}$ . Then

- (i)  $f^*$  is a strictly increasing function.
- (ii)  $f^{(-1)}(f^*(x)) = x$  for all  $x \in B$ .

Furthermore, we have the following proposition.

**Proposition 4.3** Let  $f \in \mathcal{F}$ . Then

$$x \otimes y = f^*(F_0(f^{(-1)}(x), f^{(-1)}(y)))$$

for all  $x, y \in M$ , and

$$F_0(x,y) = f^{(-1)}(f^*(x) \otimes f^*(y))$$

for all  $x, y \in B$ . Moreover,  $F_0$  is associative if and only if  $\otimes$  is associative.

**Proof.** For any  $x, y \in M$ , it follows from Definitions 4.2 and 4.3, Lemma 4.1 and Remark 4.2 that we get

$$\begin{split} x \otimes y &= G_M(F(x,y)) \\ &= f(f^{(-1)}(F(x,y))) \\ &= f^*(f^{(-1)}(F(x,y))) \\ &= f^*(f^{(-1)}(F(f^*(f^{(-1)}(x)), f^*(f^{(-1)}(y))))) \\ &= f^*(F_0(f^{(-1)}(x), f^{(-1)}(y))). \end{split}$$

There are two elements  $u, v \in B$  such that  $f^*(u) = x$ ,  $f^*(v) = y$  since  $x, y \in M$ . Then from Remark 4.2,

$$f^*(u) \otimes f^*(v) = x \otimes y = f^*(F_0(f^{(-1)}(x), f^{(-1)}(y))) = f^*(F_0(u, v)),$$

which deduces  $f^{(-1)}(f^*(u) \otimes f^*(v)) = f^{(-1)}(f^*(F_0(u,v))) = F_0(u,v)$ . Clearly, this follows that  $F_0$  is associative if and only if  $\otimes$  is associative.

**Lemma 4.2** Let  $f \in \mathcal{F}$  and  $T : [0,1]^2 \to [0,1]$  be a function defined by Eq.(5). Then, for any  $x, y \in [0,1]$ , there exist two elements  $m, n \in B$  such that  $f^*(m) = f(x)$ ,  $f^*(n) = f(y)$  and  $T(x,y) = F_0(m,n)$ . In particular,  $T(x,y) = F_0(x,y)$  for all  $x, y \in B$ .

**Proof.** If  $x, y \in B$ , then from Definition 4.3, we are sure that  $f^*(x) = f(x)$ ,  $f^*(y) = f(y)$ . If  $x \notin B$ , Then  $f(x) \in E$ . Let  $m = \min\{s \in [0, 1] \mid f(s) = f(x), f(x) \in E\}$ . Obviously,  $m \in B$  and  $f^*(m) = f(x)$ . Analogously, if  $y \notin B$  then there exists an  $n \in B$  such that  $f^*(n) = f(y)$ . Therefore, from Definition 4.3, we get

$$T(x,y) = f^{(-1)}(F(f(x), f(y)))$$
  
=  $f^{(-1)}(F(f^*(m), f^*(n)))$   
=  $F_0(m, n).$ 

**Proposition 4.4** Let  $f \in \mathcal{F}$  and  $T : [0,1]^2 \rightarrow [0,1]$  be a function defined by Eq.(5). Then  $F_0$  is associative if and only if T is associative.

**Proof.** Suppose that  $F_0$  is associative. Let us prove that T(T(x, y), z) = T(x, T(y, z)) for all  $x, y, z \in [0, 1]$ . For any  $x, y, z \in [0, 1]$ , by Lemma 4.2 there exist three elements  $m, n, t \in B$  such that  $f^*(m) = f(x)$ ,  $f^*(n) = f(y)$ ,  $f^*(t) = f(z)$ , respectively, and  $T(x, y) = F_0(m, n)$ ,  $T(x, z) = F_0(m, t)$ ,  $T(y, z) = F_0(n, t)$ , respectively. Then

$$T(T(x,y),z) = T(F_0(m,n),z) = F_0(F_0(m,n),t) = F_0(m,F_0(n,t)) = F_0(m,T(y,z)) = T(x,T(y,z)).$$

Conversely, if T is associative, i.e., T(T(x,y),z) = T(x,T(y,z)) for all  $x, y, z \in [0,1]$ , then by Eq.(5),

$$f^{(-1)}(F(f \circ f^{(-1)}(F(f(x), f(y))), f(z))) = f^{(-1)}(F(f(x), f \circ f^{(-1)}(F(f(x), f(y))))).$$

Therefore, for all  $x, y, z \in B$ ,

$$f^{(-1)}(F(f^* \circ f^{(-1)}(F(f^*(x), f^*(y))), f^*(z))) = f^{(-1)}(F(f^*(x), f^* \circ f^{(-1)}(F(f^*(x), f^*(y))))).$$

Finally, from Definition 4.3,  $F_0(F_0(x, y), z) = F_0(x, F_0(y, z))$ , i.e.,  $F_0$  is associative.

The following is an immediate consequence of Propositions 4.3 and 4.4, which means that the associativity of T defined by Eq.(5) relies only on Ran(f).

**Theorem 4.1** Let  $f \in \mathcal{F}$  and  $T : [0,1]^2 \to [0,1]$  be a function defined by Eq.(5). Then T is associative if and only if  $\otimes$  is associative.

### 5 Associativity of the function T defined by Eq.(5)

This section shows two necessary and sufficient conditions for the function T defined by Eq.(5) being associative.

Let  $M \subseteq [0, \infty]$ . Define  $O(M) = \bigcup_{x,y \in M} [\min\{x, y\}, \max\{x, y\})$  when  $M \neq \emptyset$  (where  $[x, x) = \emptyset$ ), and  $O(M) = \emptyset$  when  $M = \emptyset$ . It is clear that  $O(M) = \emptyset$  if and only if  $M = \emptyset$  or M contains only one element. Denote  $F(A, c) = \{F(x, c) \mid x \in A\}$ ,  $F(c, A) = \{F(c, x) \mid x \in A\}$  and  $F(\emptyset, A) = F(A, \emptyset) = \emptyset$ . Let  $I_k = O(\{c_k\} \cup \{z \in (b_k, d_k) \mid \text{ there are two elements } x, y \in M \text{ such that } F(x, y) = z\})$ , F(c, O(M)) = O(F(c, M)) and F(O(M), c) = O(F(M, c)) for all  $c \in [0, \infty]$ .

In what follows we shall explore other characterizations that the function T defined by Eq.(5) is associative. To achieve the goal, the following lemma plays a centre role.

**Lemma 5.1** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. For any  $x, y \in [0, 1]$ , if  $[\min\{x, y\}, \max\{x, y\}) \cap M = \emptyset$  then  $G_M(x) = G_M(y)$ .

**Proof.** Supposing  $G_M(x) \neq G_M(y)$ , from Proposition 4.1 we get  $G_M(\min\{x, y\}) = s < t = G_M(\max\{x, y\})$  with  $s, t \in M$ . Obviously,  $[s, t) \cap M \neq \emptyset$ . Choose  $w \in [s, t) \cap M$ . Then  $w = G_M(w)$ , this follows that  $G_M(\min\{x, y\}) \leq G_M(w) < G_M(\max\{x, y\})$  and  $\min\{x, y\} \leq w < \max\{x, y\}$  since  $G_M$  is non-decreasing. Hence,  $[\min\{x, y\}, \max\{x, y\}) \cap M \neq \emptyset$ , a contradiction.

The following proposition gives a sufficient condition that the operation  $\otimes$  on M is associative.

**Proposition 5.1** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. If  $F(\bigcup_{k \in K} I_k, M) \cap M = \emptyset$  and  $F(M, \bigcup_{k \in K} I_k) \cap M = \emptyset$ , then the operation  $\otimes$  on M is associative.

**Proof.** Supposing that  $F(\bigcup_{k\in K} I_k, M) \cap M = \emptyset$ , we shall prove that for any  $x_1, x_2, x_3 \in M$ ,  $G_M(F(F(x_1, x_2), x_3)) = (x_1 \otimes x_2) \otimes x_3$ . Indeed, from Definition 4.2 we have  $x_1 \otimes x_2 = G_M(F(x_1, x_2))$ . We distinguish two cases as follows.

(i) If  $F(x_1, x_2) \in M$ , then  $x_1 \otimes x_2 = F(x_1, x_2)$ , which implies

$$G_M(F(F(x_1, x_2), x_3)) = G_M(F(x_1 \otimes x_2, x_3))$$
$$= (x_1 \otimes x_2) \otimes x_3.$$

(ii) If  $F(x_1, x_2) \notin M$ , then there is a  $k \in K$  such that  $F(x_1, x_2) \in [b_k, d_k] \setminus \{c_k\}$ , where  $\{c_k\} = M \cap [b_k, d_k]$ . Thus from  $F(\bigcup_{k \in K} I_k, M) \cap M = \emptyset$ ,

$$F(I_k, x_3) \cap M = \emptyset.$$

This means

$$F([\min\{c_k, F(x_1, x_2)\}, \max\{c_k, F(x_1, x_2)\}), x_3) \cap M = \emptyset$$

since  $[\min\{c_k, F(x_1, x_2)\}, \max\{c_k, F(x_1, x_2)\}) \in I_k$ . Further, from Lemma 5.1,

$$G_M(F(F(x_1, x_2), x_3)) = G_M(F(c_k, x_3)),$$

which deduces

$$G_M(F(c_k, x_3)) = G_M(F(x_1 \otimes x_2, x_3)) = (x_1 \otimes x_2) \otimes x_3$$

since  $c_k = x_1 \otimes x_2$ . Hence  $G_M(F(F(x_1, x_2)), x_3) = (x_1 \otimes x_2) \otimes x_3$ .

 $G_M(F(x_1, F(x_2, x_3)) = x_1 \otimes (x_2 \otimes x_3)$  is completely analogous when  $(F(M, \bigcup_{k \in K} I_k)) \cap M = \emptyset$ . Therefore,  $(x_1 \otimes x_2) \otimes x_3 = x_1 \otimes (x_2 \otimes x_3)$  since F is associative.  $\Box$ Proposition 5.1 implies the following corollary.

**Corollary 5.1** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. If F is commutative and  $F(\bigcup_{k \in K} I_k, M) \cap M = \emptyset$ , then the operation  $\otimes$  on M is associative.

In particular, we have the following corollary.

**Corollary 5.2** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. If  $F(M, M) \subseteq M$ , then the operation  $\otimes$  on M is associative.

**Proof.** In fact, if  $F(M, M) \subseteq M$  then  $\bigcup_{k \in K} I_k = \emptyset$ , implying  $F(\bigcup_{k \in K} I_k, M) = \emptyset$  and  $(F(M, \bigcup_{k \in K} I_k)) = \emptyset$ . Further, by Proposition 5.1, the operation  $\otimes$  on M is associative.

Proposition 5.1 implies the following remark.

**Remark 5.1** Let  $f \in \mathcal{F}, T : [0,1]^2 \to [0,1]$  be a function defined by Eq.(5) in which  $F : [0,\infty]^2 \to [0,\infty]$  is a non-decreasing and commutative function.

- (i) Let 0 be a neutral element of F,  $(F(\cup_{k\in K}I_k, M)) \cap M = \emptyset$  and  $F(M, \cup_{k\in K}I_k) \cap M = \emptyset$ . Then T is associative. Meanwhile, T is not necessary a t-subconorm since  $T(x, 0) = f^{(-1)}(F(f(x), f(0))) \ge f^{(-1)}(f(x))$  and  $f^{(-1)}(f(x)) \le x$  for all  $x \in [0, 1]$ . However, if f is further a strictly increasing function with f(0) = 0, then T is a t-conorm.
- (ii) Let  $\infty$  be neutral element of F,  $(F(\bigcup_{k \in K} I_k, M)) \cap M = \emptyset$  and  $F(M, \bigcup_{k \in K} I_k) \cap M = \emptyset$ . Then T is a t-subnorm. Moreover, T is not necessary a t-norm since  $T(x, 1) = f^{(-1)}(F(f(x), f(1))) \leq f^{(-1)}(f(x)) \leq x$  for all  $x \in [0, 1]$ . However, if f is further a strictly increasing function with  $f(1) = \infty$ , then T is a t-norm. Another way is to slightly modify the function T as

$$T(x,y) = \begin{cases} f^{(-1)}(F(f(x), f(y))) & \text{if } (x,y) \in [0,1)^2, \\ \min\{x,y\} & \text{otherwise} \end{cases}$$
(6)

for all  $x, y \in [0, 1]$ . Then one may check that T is a t-norm.

Generally, the converse of Proposition 5.1 is not true.

**Example 5.1** Let F = x + y and the function  $f : [0, 1] \to [0, \infty]$  be defined by

$$f(x) = x$$
 for all  $x \in [0, 1]$ .

Then from Eq.(5),

$$T(x,y) = \begin{cases} x+y & \text{if } x+y < 1, \\ 1 & \text{otherwise.} \end{cases}$$

It is easy to check that T is associative,  $M = [0,1], \cup_{k \in K} I_k = [1,2]$  and  $F(\cup_{k \in K} I_k, M) = [1,3]$ . Thus  $F(\cup_{k \in K} I_k, M) \cap M \neq \emptyset$ .

Fortunately, we have the following proposition.

**Proposition 5.2** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. If F is cancellative satisfying  $F(M, M \setminus C) \subseteq M \setminus C$ , then the following are equivalent:

- (i) The operation  $\otimes$  is associative.
- (*ii*)  $F(\bigcup_{k \in K} I_k, M) \cap M = \emptyset$  and  $F(M, \bigcup_{k \in K} I_k) \cap M = \emptyset$ .

**Proof.** From Proposition 5.1, it is enough to prove that (i) implies (ii). We shall prove  $F(M, M) \subseteq M$ . Indeed, if  $F(M, M) \notin M$ , then there exist two elements  $x, y \in M$  such that  $F(x, y) \notin M$ . Thus  $F(x, y) \in [b_k, d_k] \setminus \{c_k\}$  for some  $k \in K$  where  $\{c_k\} = [b_k, d_k] \cap M$ . Now, let  $z \in M \setminus C$ . Then by  $F((M, M \setminus C)) \subseteq M \setminus C$ , we have  $F(y, z) \in M \setminus C$ . This means  $x \otimes (y \otimes z) = x \otimes F(y, z) = G_M(F(x, F(y, z)))$ . On the other hand  $(x \otimes y) \otimes z = c_k \otimes z = G_M(F(c_k, z))$ . Thereby, the associativity of  $\otimes$  on M yields  $G_M(F(x, F(y, z))) = G_M(F(c_k, z))$ . This follows  $G_M(F(x, F(y, z))) = F(c_k, z)$  since  $F(c_k, z) \in M \setminus C$ . Therefore, by Propositions 4.1(i),  $F(x, F(y, z)) = F(c_k, z)$  since  $F(x, F(y, z)) \in F(M, M \setminus C) \subseteq M \setminus C$ , which results in  $F(F(x, y), z)) = F(c_k, z)$  since F associative. So that  $F(x, y) = c_k$  since F is cancellative, contrary to  $F(x, y) \in [b_k, d_k] \setminus \{c_k\}$ . Therefore,  $F(M, M) \subseteq M$ , then  $\cup_{k \in K} I_k = \emptyset$ , implying  $(F(\cup_{k \in K} I_k, M)) \cap M = \emptyset$  and  $F(M, \cup_{k \in K} I_k) \cap M = \emptyset$ .

Then Theorem 4.1 and Proposition 5.2 imply the following characteristic theorem that the function T defined by Eq.(5) is associative.

**Theorem 5.1** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. If F is cancellative satisfying  $F(M, M \setminus C) \subseteq M \setminus C$ , then the following are equivalent:

- (i) T is associative.
- (*ii*)  $F(\bigcup_{k \in K} I_k, M) \cap M = \emptyset$  and  $F(M, \bigcup_{k \in K} I_k) \cap M = \emptyset$ .

Notice that in Theorem 5.1 the condition that F is cancellative satisfying  $F(M, M \setminus C) \subseteq M \setminus C$  can not deleted generally.

**Example 5.2** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. (1) Let F = x + y - xy and the function  $f : [0, 1] \to [0, \infty]$  be defined by

$$f(x) = \begin{cases} 0 & \text{if } x \in [0, \frac{1}{2}), \\ x & \text{if } x \in [\frac{1}{2}, 1]. \end{cases}$$

Then from Eq.(5),

$$T(x,y) = \begin{cases} 0 & \text{if } (x,y) \in [0,\frac{1}{2}) \times [0,\frac{1}{2}), \\ x+y-xy & \text{if } (x,y) \in [\frac{1}{2},1] \times [\frac{1}{2},1], \\ \max\{x,y\} & \text{otherwise.} \end{cases}$$

One may check that F is not cancellative,  $M = \{0\} \cup [\frac{1}{2}, 1], F(M, M \setminus C) = (\frac{1}{2}, 1) \subseteq M \setminus C$  and  $F(\bigcup_{k \in K} I_k, M) = \{0\}$ . Thus,  $F(\bigcup_{k \in K} I_k, M) \cap M \neq \emptyset$ . However, T is associative. (2) Let F = x + y and the function  $f : [0, 1] \rightarrow [0, \infty]$  be defined by

$$f(x) = \begin{cases} x & \text{if } x \in [0, \frac{1}{2}), \\ 1 & \text{if } x \in [\frac{1}{2}, 1]. \end{cases}$$

Then from Eq.(5),

$$T(x,y) = \begin{cases} \min\{x,y\} & \text{if } x+y < 1, \\ 1 & \text{otherwise.} \end{cases}$$

One may check that F is cancellative,  $M = [0, \frac{1}{2}) \cup \{1\}$ ,  $F(M, M \setminus C) = [0, \frac{3}{2}) \notin M \setminus C$  and  $(F(\cup_{k \in K} I_k, M)) = [\frac{1}{2}, 3)$ . Thus,  $F(\cup_{k \in K} I_k, M) \cap M \neq \emptyset$ . However, T is associative.

Below, we shall develop another characterization that the function T defined by Eq.(5) is associative. We first need the following definition.

**Definition 5.1** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. Define for all  $y \in M$ , and  $k, l \in K$ ,  $M_k^y = \{x \in M \mid F(x, y) \in [b_k, d_k]\}, M_y^k = \{x \in M \mid F(y, x) \in [b_k, d_k]\},$ 

$$J_{k,l}^{y} = \begin{cases} O(F(M_{k}^{y}, c_{l}) \cup F(c_{k}, M_{y}^{l})), & \text{if } M_{k}^{y} \neq \emptyset, M_{y}^{l} \neq \emptyset, \\ \emptyset, & \text{otherwise,} \end{cases}$$

$$\begin{split} M^y &= \{x \in M \mid F(x,y) \in M \setminus C\}, \ M_y = \{x \in M \mid F(y,x) \in M \setminus C\}, \ I^y_k = O(\{c_k\} \cup F(M^y_k,y)) \\ \text{and} \ I^k_y &= O(\{c_k\} \cup F(y,M^y_y)). \ \text{Put} \ \mathfrak{J}_1(M) = \bigcup_{y \in M} \bigcup_{k \in K} F(I^y_k,M_y), \ \mathfrak{J}_2(M) = \bigcup_{y \in M} \bigcup_{k \in K} F(M^y,I^k_y), \\ \mathfrak{J}_3(M) &= \bigcup_{y \in M} \bigcup_{k,l \in K} J^y_{k,l} \text{ and}, \end{split}$$

$$\mathfrak{J}(M) = \mathfrak{J}_1(M) \cup \mathfrak{J}_2(M) \cup \mathfrak{J}_3(M).$$

Then we have the following sufficient condition that that the function T defined by Eq.(5) is associative.

**Proposition 5.3** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with  $M, \otimes$  be the operation on M. If  $\mathfrak{J}(M) \cap M = \emptyset$  then the operation  $\otimes$  on M is associative.

**Proof.** Suppose that the operation  $\otimes$  is not associative. Then there exist three elements  $x, y, z \in M$  such that  $(x \otimes y) \otimes z \neq x \otimes (y \otimes z)$ . We claim that  $F(x, y) \notin M \setminus C$  or  $F(y, z) \notin M \setminus C$ . Otherwise, from

Definition 4.1,  $F(x,y) \in M \setminus C$  and  $F(y,z) \in M \setminus C$  would imply  $(x \otimes y) \otimes z = G_M(F(F(x,y),z)) = G_M(F(x,F(y,z))) = x \otimes (y \otimes z)$ , a contradiction. The following proof is completed by three steps.

(i) Let  $F(x, y) \notin M \setminus C$  and  $F(y, z) \in M \setminus C$ . Then  $y \otimes z = F(y, z)$  and there exists a  $k \in K$  such that  $F(x, y) \in [b_k, d_k]$ . Thus  $x \otimes y = c_k$  where  $M \cap [b_k, d_k] = \{c_k\}$ . It follows from Definition 4.1 that  $G_M(F(c_k, z)) = (x \otimes y) \otimes z \neq x \otimes (y \otimes z) = G_M(F(x, F(y, z)))$ . On the other hand, by associativity of F, we have  $G_M(F(x, F(y, z))) = G_M(F(F(x, y), z))$ . Thus  $G_M(F(c_k, z)) \neq G_M(F(F(x, y), z))$ . Therefore, by Lemma 5.1,  $F([\min\{c_k, F(x, y)\}, \max\{c_k, F(x, y)\}), z) \cap M \neq \emptyset$ . Obviously,  $z \in M_y$ , and  $x \in M_k^y$ . Thus by  $I_k^y = O(\{c_k\} \cup F(M_k^y, y))$ ,  $F([\min\{c_k, F(x, y)\}, \max\{c_k, F(x, y)\}), z) \subseteq F(I_k^y, M_y)$ , this infers  $F(I_k^y, M_y) \cap M \neq \emptyset$ .

(ii) Let  $F(x, y) \in M \setminus C$  and  $F(y, z) \notin M \setminus C$ . In a completely analogous way, we have  $F(M^y, I_y^k) \cap M \neq \emptyset$ .

(iii) Let  $F(x, y) \notin M \setminus C$  and  $F(y, z) \notin M \setminus C$ . Then from  $F(x, y) \notin M \setminus C$ , there exists a  $k \in K$  such that  $F(x, y) \in [b_k, d_k]$ . Thus  $x \otimes y = c_k$  where  $M \cap [b_k, d_k] = \{c_k\}$ . Similarly, there exists an  $l \in K$  such that  $F(y, z) \in [b_l, d_l]$  since  $F(y, z) \notin M \setminus C$ . Hence  $y \otimes z = c_l$  where  $M \cap [b_l, d_l] = \{c_l\}$ . Therefore,  $G_M(F(c_k, z)) = (x \otimes y) \otimes z \neq x \otimes (y \otimes z) = G_M(F(x, c_l))$ . It follows from Lemma 5.1 that  $[\min\{F(c_k, z), F(x, c_l)\}, \max\{F(c_k, z), F(x, c_l)\}) \cap M \neq \emptyset$ , which together with  $x \in M_k^y$ ,  $F(x, c_l) \in F(M_k^y, c_l), z \in M_y^l$  and  $F(c_k, z) \in F(c_k, M_y^l)$  yields that  $[\min\{F(c_k, z), F(x, c_l)\}, \max\{F(c_k, z), F(x, c_l)\}) \subseteq J_{k,l}^y$ .

From (i), (ii) and (iii), we deduce that  $\mathfrak{J}(M) \cap M \neq \emptyset$ .

□ 1].

Generally, the converse of Proposition 5.3 is not true. For instance, in Example 5.1, M = [0, 1],  $\mathfrak{J}_1(M) = \mathfrak{J}_2(M) = [1, 3]$  and  $\mathfrak{J}_3(M) = [1, 2]$ , thus,  $\mathfrak{J}(M) \cap M \neq \emptyset$ .

To obtain the necessary condition that the function T defined by Eq.(5) is associative, we further suppose that  $F : [0, \infty]^2 \to [0, \infty]$  is an associative function with neutral element in [0, 1]. Then we have the following two lemmas.

**Lemma 5.2** Let  $M \in \mathcal{A}_1$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. Let  $M_1, M_2 \subseteq [0, \infty]$  be two non-empty sets and  $c \in [0, \infty]$ . Then

(1)  $F(O(M_1 \cup M_2), c) \cap (M \setminus C) = \emptyset$  if and only if there exist  $x_1 \in M_1$  and  $x_2 \in M_2$  such that

 $[\min\{F(x_1,c),F(x_2,c)\},\max\{F(x_1,c),F(x_2,c)\})\cap (M\setminus C)=\emptyset.$ 

(2)  $F(c, O(M_1 \cup M_2)) \cap (M \setminus C) = \emptyset$  if and only if there exist  $x_1 \in M_1$  and  $x_2 \in M_2$  such that

 $[\min\{F(c, x_1), F(c, x_2)\}, \max\{F(c, x_1), F(c, x_2)\}) \cap (M \setminus C) = \emptyset.$ 

**Proof.** (1) We only provide the proof of statement (1) when F is non-decreasing, the statement being analogous when F is non-increasing. We just prove that if there exist an  $x_1 \in M_1$  and an  $x_2 \in M_2$  such that

 $[\min\{F(x_1,c),F(x_2,c)\},\max\{F(x_1,c),F(x_2,c)\})\cap (M\setminus C)=\emptyset$ 

then  $F(O(M_1 \cup M_2), c) \cap (M \setminus C) = \emptyset$  since it is easy to see that there exist an  $x_1 \in M_1$  and an  $x_2 \in M_2$  such that

$$[\min\{F(x_1, c), F(x_2, c)\}, \max\{F(x_1, c), F(x_2, c)\}) \cap (M \setminus C) = \emptyset$$

when  $F(O(M_1 \cup M_2), c) \cap (M \setminus C) = \emptyset$ .

Suppose that  $F(O(M_1 \cup M_2), c) \cap (M \setminus C) \neq \emptyset$ . Then there exist two elements  $m, n \in M_1 \cup M_2$  with m < n such that  $F([m, n), c) \cap (M \setminus C) \neq \emptyset$ . The following proof is split into three cases.

(i) In the case that exact one of  $\{m, n\}$  is contained in  $M_1$  and the other is contained in  $M_2$ , it is obvious that

 $[\min\{F(x_1,c),F(x_2,c)\},\max\{F(x_1,c),F(x_2,c)\})\cap (M\setminus C)\neq\emptyset.$ 

- (ii) In the case that  $m, n \in M_1$  with m < n. Choose  $t \in M_2$ .
  - (a) If  $t \leq m$  then put  $x_1 = t$  and  $x_2 = n$ .
  - (b) If  $t \ge n$  then put  $x_1 = m$  and  $x_2 = t$ .

(c) If m < t < n, then  $F([m,t),c) \cap (M \setminus C) \neq \emptyset$  or  $F([t,n)),c) \cap (M \setminus C) \neq \emptyset$ . If  $F([m,t),c) \cap (M \setminus C) \neq \emptyset$ , put  $x_1 = m$  and  $x_2 = t$ . If  $F([t,n)),c) \cap (M \setminus C) \neq \emptyset$ , put  $x_2 = n$  and  $x_1 = t$ .

In any case of (a),(b) and (c), we get

$$[\min\{F(x_1,c),F(x_2,c)\},\max\{F(x_1,c),F(x_2,c)\})\cap (M\setminus C)\neq\emptyset.$$

(iii) The case  $m, n \in M_2$  is completely analogous to (ii).

(2) The proof is analogy to the proof of statement (1).

**Lemma 5.3** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. If  $G_M(x) = G_M(y)$  for any  $x, y \in [0, 1]$  then  $[\min\{x, y\}, \max\{x, y\}) \cap (M \setminus C) = \emptyset$ .

**Proof.** Suppose that  $[\min\{x, y\}, \max\{x, y\}) \cap (M \setminus C) \neq \emptyset$ . Then  $x \neq y$ , say x < y, thus we have  $[x, y) \cap (M \setminus C) \neq \emptyset$ . Let  $a \in [x, y) \cap (M \setminus C)$ . Then  $x \leq a < y$  and  $G_M(a) = a$ , which deduces that  $G_M(x) \leq G_M(a) \leq G_M(y)$  since  $G_M$  is a non-decreasing function. If  $y \in M \setminus C$ , then from Proposition 4.1,  $G_M(y) = y$ , thus,  $G_M(x) \leq a < y = G_M(y)$ , a contradiction. If  $y \notin M \setminus C$ , then there exists a  $k \in K$  such that  $y \in [b_k, d_k]$  and  $G_M(y) = b_k$  or  $G_M(y) = d_k$ . So that  $a < b_k$  since  $a \in M \setminus C$  and a < y, hence  $G_M(a) < G_M(y)$ . Therefore,  $G_M(x) \leq G_M(a) < G_M(y)$ , a contradiction.

Note that under the conditions of Lemma 5.3 we can not get  $[\min\{x, y\}, \max\{x, y\}) \cap M = \emptyset$  generally.

**Example 5.3** Let  $f : [0,1] \to [0,\infty]$  be defined by

$$f(x) = \begin{cases} x & \text{if } x \in [0, \frac{1}{4}), \\ \frac{1}{2} & \text{if } x = \frac{1}{2}, \\ 2x & \text{if } x \in (\frac{1}{2}, 1]. \end{cases}$$

It is easy to check that  $M = [0, \frac{1}{4}) \cup \{\frac{1}{2}\} \cup (1, 2]$  and  $G_M(\frac{3}{8}) = \frac{1}{2} = G_M(\frac{3}{4})$ . Thus  $[\min\{x, y\}, \max\{x, y\}) = [\frac{3}{8}, \frac{3}{4})$  and  $[\frac{3}{8}, \frac{3}{4}) \cap (M \setminus C) = \emptyset$ . However,  $[\frac{3}{8}, \frac{3}{4}) \cap M \neq \emptyset$ . Therefore, the converse of Lemma 5.1 is not true generally.

We further have following proposition that is almost the converse of Proposition 5.3.

**Proposition 5.4** Let  $M \in \mathcal{A}$  and  $(S, C) = (\{[b_k, d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. If the operation  $\otimes$  on M is associative then  $\mathfrak{J}(M) \cap (M \setminus C) = \emptyset$ .

**Proof.** Suppose  $\mathfrak{J}(M) \cap (M \setminus C) \neq \emptyset$ . Then there exist a  $y \in M$  and two elements  $k, l \in K$  such that  $F(I_k^y, M_y) \cap (M \setminus C) \neq \emptyset$  or  $F(M^y, I_y^k) \cap (M \setminus C) \neq \emptyset$  or  $J_{k,l}^y \cap (M \setminus C) \neq \emptyset$ . We distinguish three cases as follows.

(i) If  $F(I_k^y, M_y) \cap (M \setminus C) \neq \emptyset$ , then there exists a  $z \in M_y$  such that  $F(I_k^y, z) \cap (M \setminus C) \neq \emptyset$ . Thus by the definition of  $I_k^y$ ,  $F(M_k^y, y) \neq \emptyset$ . Applying Lemma 5.2, there are a  $u \in C$  and a  $v \in F(M_k^y, y)$ such that  $[\min\{F(u, z), F(v, z)\}, \max\{F(u, z), F(v, z)\}) \cap (M \setminus C) \neq \emptyset$ . Furthermore, there is an  $x \in M_k^y$ such that F(x, y) = v since  $v \in F(M_k^y, y)$ . Thereby, there are a  $u \in C$  and an  $x \in M_k^y$  such that  $[\min\{F(c_k, z), F(F(x, y), z)\}, \max\{F(c_k, z), F(F(x, y), z)\}) \cap (M \setminus C) \neq \emptyset$ . Consequently, from Lemma 5.3, we get  $G_M(F(c_k, z)) \neq G_M(F(F(x, y), z))$ . On the other hand, from  $x \in M_k^y$  we have  $F(x, y) \in [b_k, d_k]$ . Thus  $x \otimes y = c_k$  where  $M \cap [b_k, d_k] = \{c_k\}$ . Again from  $z \in M_y$ , we get  $F(y, z) \in M \setminus C$ . This follows  $y \otimes z = F(y, z)$ . Therefore,  $(x \otimes y) \otimes z = G_M(F(c_k, z)) \neq G_M(F(F(x, y), z)) = G_M(F(x, F(y, z))) =$  $x \otimes (y \otimes z)$ .

(ii) If  $F(M^y, I_y^k) \cap (M \setminus C) \neq \emptyset$ , then in complete analogy to (i), one can check that  $(x \otimes y) \otimes z \neq x \otimes (y \otimes z)$ .

(iii) If  $J_{k,l}^y \cap (M \setminus C) \neq \emptyset$ , then  $J_{k,l}^y \neq \emptyset$ . By the definition of  $J_{k,l}^y$ ,  $F(O(F(M_k^y, c_l) \cup F(c_k, M_y^l)), e) \cap (M \setminus C) \neq \emptyset$  where e is a neutral element of F,  $F(M_k^y, c_l) \neq \emptyset$  and  $F(c_k, M_y^l) \neq \emptyset$ . Using Lemma 5.2, there are a

 $u \in F(c_k, M_y^l)$  and a  $v \in F(M_k^y, c_l)$  such that  $[\min\{F(u, e), F(v, e)\}, \max\{F(u, e), F(v, e)\}) \cap (M \setminus C) \neq \emptyset$ . Since  $u \in F(c_k, M_y^l)$  and  $v \in F(M_k^y, c_l)$ , there are an  $x \in M_k^y$  and a  $z \in M_y^l$  such that  $u = F(c_k, z)$ ,  $v = F(x, c_l)$ . Therefore, there are an  $x \in M_k^y$  and a  $z \in M_y^l$  such that

$$[\min\{F(c_k, z), F(x, c_l)\}, \max\{F(c_k, z), F(x, c_l)\}) \cap (M \setminus C) \neq \emptyset$$

since e is a neutral element of F. Furthermore, by Lemma 5.3 we have  $G_M(F(c_k, z)) \neq G_M(F(x, c_l))$ . On the other hand, from  $x \in M_k^y$  we have  $F(x, y) \in [b_k, d_k]$ . Thus  $x \otimes y = c_k$  where  $M \cap [b_k, d_k] = \{c_k\}$ . Again from  $z \in M_y^l$ , we get  $F(y, z) \in [b_l, d_l]$ . Thus  $y \otimes z = c_l$  where  $M \cap [b_l, d_l] = \{c_l\}$ . We finally come to  $(x \otimes y) \otimes z = G_M(F(c_k, z)) \neq G_M(F(x, c_l)) = x \otimes (y \otimes z)$ .

Generally, the converse of Proposition 5.4 is not true.

**Example 5.4** (i) Let F = x + y and the function  $f : [0, 1] \to [0, \infty]$  be defined by

$$f(x) = \begin{cases} x & \text{if } x \in [0, \frac{1}{4}), \\ \frac{1}{4} & \text{if } x \in [\frac{1}{4}, \frac{1}{2}) \\ 1 & \text{if } x \in [\frac{1}{2}, 1]. \end{cases}$$

Then from Eq.(5),

$$T(x,y) = \begin{cases} x+y & \text{if } x+y \le \frac{1}{4}, \\ \frac{1}{4} & \text{if } (x,y) \in \{0\} \times (\frac{1}{4},\frac{1}{2}) \cup (\frac{1}{4},\frac{1}{2}) \times \{0\}, \\ 1 & \text{otherwise.} \end{cases}$$

One may check that  $M = [0, \frac{1}{4}) \cup \{1\}$ ,  $M \setminus C = [0, \frac{1}{4})$  and  $\mathfrak{J}(M) = [\frac{1}{4}, \frac{3}{2}]$ , thus,  $\mathfrak{J}(M) \cap (M \setminus C) = \emptyset$ . However, T is not associative.

(ii) Let F = x + y and the function  $f : [0, 1] \to [0, \infty]$  be defined by

$$f(x) = \begin{cases} x & \text{if } x \in [0, 1), \\ 2 & \text{if } x = 1. \end{cases}$$

Then from Eq.(5),

$$T(x,y) = \begin{cases} x+y & \text{if } x+y < 1, \\ 2 & \text{otherwise.} \end{cases}$$

One may check that  $M = [0,1) \cup \{2\}$ ,  $M \setminus C = [0,1)$  and  $\mathfrak{J}(M) = [1,5)$ . Thus  $\mathfrak{J}(M) \cap (M \setminus C) = \emptyset$  and T is associative. However,  $\mathfrak{J}(M) \cap M \neq \emptyset$ .

With Propositions 5.3 and 5.4, we have following proposition.

**Proposition 5.5** Let  $M \in \mathcal{A}$  and  $(S,C) = (\{[b_k,d_k] \mid k \in K\}, \{c_k \mid k \in \overline{K}\})$  be associated with M. Then  $F(C,M) \cup F(M,C) \subseteq M \setminus C$  implies that the following are equivalent: (1) The operation  $\otimes$  is associative. (2)  $\mathfrak{J}(M) \cap (M \setminus C) = \emptyset$ .

**Proof.** (1) implying (2) is immediately from Proposition 5.4. Now, suppose that the operation  $\otimes$  is not associative. Then by proof of Proposition 5.3, there exist three elements  $x, y, z \in M$  such that either  $F(x, y) \notin M \setminus C$  or  $F(y, z) \notin M \setminus C$ .

If  $F(x, y) \notin M \setminus C$  and  $F(y, z) \in M \setminus C$  then there is a  $k \in K$  such that  $F(x, y) \in [b_k, d_k]$ . Thus  $x \otimes y = c_k$  where  $M \cap [b_k, d_k] = \{c_k\}$ . Hence  $G_M(F(c_k, z)) \neq G_M(F(x, G_M(F(y, z)), \text{this together with } F(C, M) \subseteq M \setminus C$  deduces that  $[\min\{F(c_k, z), F(x, F(y, z))\}, \max\{F(c_k, z), F(x, F(y, z))\}) \cap (M \setminus C) \neq \emptyset$ . Then, by proof of Proposition 5.3  $F(I_k^y, M_y) \cap (M \setminus C) \neq \emptyset$ . Therefore,  $\mathfrak{J}(M) \cap (M \setminus C) \neq \emptyset$ .

If  $F(x, y) \notin M \setminus C$  and  $F(y, z) \notin M \setminus C$ , then there exists an  $l \in K$  such that  $F(y, z) \in [b_l, d_l]$ . Hence  $y \otimes z = c_l$  where  $M \cap [b_l, d_l] = \{c_l\}$ . Thus by proof of Proposition 5.3,

$$[\min\{F(c_k, z), F(x, c_l)\}, \max\{F(c_k, z), F(x, c_l)\}) \subseteq J_{k,l}^y.$$

Therefore,  $J_{k,l}^y \cap (M \setminus C) \neq \emptyset$ . This follows that  $\mathfrak{J}(M) \cap (M \setminus C) \neq \emptyset$ .

The case  $F(x, y) \in M \setminus C$  and  $F(y, z) \notin M \setminus C$  is completely analogous.

Theorem 4.1 and Proposition 5.5 imply the following characteristic theorem that the function T defined by Eq.(5) is associative.

**Theorem 5.2** Let  $M \in \mathcal{A}$  and  $T : [0,1]^2 \to [0,1]$  be a function defined by Eq.(5). If  $F(C,M) \cup F(M,C) \subseteq \mathbb{C}$  $M \setminus C$ , then the function T is associative if and only if  $\mathfrak{J}(M) \cap M \setminus C = \emptyset$ .

In general, the condition  $F(C, M) \cup F(M, C) \subseteq M \setminus C$  in Theorem 5.2 can not be dropped.

**Example 5.5** (1) Let  $F(x,y) = \frac{xy}{2}$  for all  $x, y \in [0,\infty]$  and the function  $f: [0,1] \to [0,\infty]$  be defined by

$$f(x) = \begin{cases} x & \text{if } x \in [0, \frac{1}{2}), \\ \frac{1}{2} & \text{if } x \in [\frac{1}{2}, 1]. \end{cases}$$

From Eq.(5),

$$T(x,y) = \frac{xy}{2}$$
 for all  $x \in [0,1]$ .

One may check that  $M = [0, \frac{1}{2}], \ \mathfrak{J}(M) = \emptyset$  and  $F(C, M) = F(M, C) = [0, \frac{1}{8}] \subseteq M \setminus C$ . Moreover,  $\mathfrak{J}(M) \cap (M \setminus C) = \emptyset$  and T is an associative function.

(2) Let F(x,y) = x + y + 1 for all  $x, y \in [0,\infty]$  and the function  $f:[0,1] \to [0,\infty]$  be defined by

$$f(x) = \begin{cases} 2x & \text{if } x \in [0, \frac{1}{2}), \\ \frac{1}{1-x} & \text{if } x \in [\frac{1}{2}, 1), \\ \infty & \text{if } x = 1. \end{cases}$$

Then from Eq.(5),

$$T(x,y) = \begin{cases} 2 & \text{if } x+y < \frac{1}{2}, \\ \frac{2-x-y}{3-2x-2y+xy} & \text{otherwise.} \end{cases}$$

One may check that  $M = [0,1) \cup [2,\infty]$ ,  $\mathfrak{J}(M) = [2,4) \cup (4,\infty]$  and  $F(C,M) = F(M,C) = [3,\infty] \subseteq M \setminus C$ . Thus,  $\mathfrak{J}(M) \cap (M \setminus C) \neq \emptyset$  and T is not an associative function. (3) Let F(x,y) = xy for all  $x, y \in [0,\infty]$  and the function  $f:[0,1] \to [0,\infty]$  be defined by

$$f(x) = \begin{cases} x & \text{if } x \in [0, \frac{1}{4}), \\ 1 & \text{if } x \in [\frac{1}{4}, 1]. \end{cases}$$

Then from Eq.(5),

$$T(x,y) = \begin{cases} xy & \text{if } (x,y) \in [0,\frac{1}{4})^2, \\ 1 & \text{if } (x,y) \in [\frac{1}{4},1]^2, \\ \min\{x,y\} & \text{otherwise.} \end{cases}$$

One may check that  $M = [0, \frac{1}{4}) \cup \{1\}, F(C, M) = F(M, C) = [0, \frac{1}{4}) \cup \{1\} \not\subseteq M \setminus C \text{ and } \mathfrak{J}(M) \cap (M \setminus C) = [0, \frac{1}{4}) \cup \{1\} \not\subseteq M \setminus C$  $[0,\frac{1}{4})$ . However, T is an associative function.

(4) Let  $F(x,y) = \max\{x,y\}$  for all  $x, y \in [0,\infty]$  and the function  $f:[0,1] \to [0,\infty]$  be defined by

$$f(x) = \begin{cases} x & \text{if } x \in [0, 1), \\ 2 & \text{if } x = 1. \end{cases}$$

Then from Eq.(5),

$$T(x,y) = \begin{cases} \max\{x,y\} & \text{if } (x,y) \in [0,1)^2, \\ 2 & \text{otherwise.} \end{cases}$$

One may check that  $M = [0,1) \cup \{2\}$  and  $F(C,M) = F(M,C) = \{2\} \notin M \setminus C$ . However,  $\mathfrak{J}(M) \cap (M \setminus C) = \{1\}$  $\emptyset$  and T is an associative function.

### 6 Conclusions

In this article, we proved that the function  $T: [0,1]^2 \rightarrow [0,1]$  defined by Eq.(5) is associative if and only if  $F(\bigcup_{k\in K} I_k, M) \cap M = \emptyset$  and  $F(M, \bigcup_{k\in K} I_k) \cap M = \emptyset$  when F is cancellative satisfying  $F(M, M \setminus C) \subseteq M \setminus C$  if and only if  $\mathfrak{J}(M) \cap M \setminus C = \emptyset$  when  $F(C, M) \cup F(M, C) \subseteq M \setminus C$ , where  $M = \operatorname{Ran}(f)$  with  $f: [0,1] \to [0,\infty]$  a non-decreasing function which satisfies either  $f(x) = f(x^+)$  when  $f(x^+) \in \operatorname{Ran}(f)$  or  $f(x) \neq f(y)$  for any  $y \neq x$  when  $f(x^+) \notin \operatorname{Ran}(f)$  for all  $x \in [0,1]$ . Example 5.2 shows the condition that F is cancellative satisfying  $F(M, M \setminus C) \subseteq M \setminus C$  can not deleted in general. Meanwhile, Example 5.5 reveals that the condition  $F(C, M) \cup F(M, C) \subset M \setminus C$  can not be moved generally. It is worth pointing out that one can verify that all the results obtained are hold when fis a non-increasing function. Therefore, our results are applicable for the monotone functions f which satisfy either  $f(x) = f(x^+)$  when  $f(x^+) \in \operatorname{Ran}(f)$  or  $f(x) \neq f(y)$  for any  $y \neq x$  when  $f(x^+) \notin \operatorname{Ran}(f)$ for all  $x \in [0,1]$ . On the other hand, it is evident that our results are suitable for all monotone right continuous functions and all strictly monotone ones, respectively. Therefore, they generalize the work of Viceník [13] and Zhang and Wang [16]. Comparing with Yao Ouyang [8], our function f needs not to be strictly decreasing and satisfy the formula (3), this means that our results deeply generalize the work of Yao Ouyang [8]. An interesting problem is whether our results can be applied to all monotone functions or not.
