THE GEOMETRIC CAUCHY PROBLEM FOR CONSTANT-RANK SUBMANIFOLDS

ABSTRACT. Given a smooth s-dimensional submanifold S of \mathbb{R}^{m+c} and a smooth distribution $D \supset TS$ of rank m along S, we study the following geometric Cauchy problem: to find an m-dimensional rank-s submanifold M of \mathbb{R}^{m+c} (that is, an *m*-submanifold with constant index of relative nullity $m - s$) such that $M \supset S$ and $TM|_S = \mathcal{D}$. In particular, under some reasonable assumption and using a constructive approach, we show that a solution exists and is unique in a neighborhood of S.

1. Introduction and main result

Given a manifold $Q^{q\geq 3}$ and some class A of $(m < q)$ -dimensional submanifolds, the geometric Cauchy problem for the class A is to find all members of A passing from a given $(s < m)$ -dimensional submanifold S of Q with prescribed tangent bundle along S. This problem, which represents a far-reaching generalization of the classical Björling problem for minimal surfaces in \mathbb{R}^3 [\[18,](#page-7-0) section 22.6], has recently been examined, always with $s = 1$, for several combinations of Q and A; see, e.g., [\[24,](#page-7-1) [5,](#page-6-0) [3,](#page-6-1) [16,](#page-7-2) [8,](#page-6-2) [23,](#page-7-3) [6,](#page-6-3) [2,](#page-6-4) [1\]](#page-6-5).

In this paper, we are interested in the geometric Cauchy problem for constant-rank submanifolds, that is, smooth embedded submanifolds of \mathbb{R}^{m+c} whose Gauss map has constant rank, or, equivalently, whose second fundamental form has constant index of relative nullity [\[7\]](#page-6-6). These make one of the simplest and most natural classes of submanifolds and, for this reason, also one of the most studied; see, e.g., [\[27,](#page-7-4) [25,](#page-7-5) [10,](#page-6-7) [17,](#page-7-6) [9,](#page-6-8) [29,](#page-7-7) [13,](#page-6-9) [11\]](#page-6-10) and [\[14,](#page-6-11) Chapter 7].

Problem 1.1 (Geometric Cauchy problem for constant-rank submanifolds). Let S be a connected s-dimensional smooth embedded submanifold of \mathbb{R}^{m+c} , and let $D \supset TS$ be a smooth distribution of rank m along S, that is, a smooth rank-m subbundle of the ambient tangent bundle over S . Find all rank-s submanifolds of \mathbb{R}^{m+c} containing S and whose tangent bundle along S is precisely D.

Some special cases of Problem [1.1](#page-0-0) have already been considered: the case $m = 2$ is classical [\[15,](#page-7-8) pp. 198–200]; the case of rank-one hypersurfaces $(s = c = 1)$ was first addressed by Markina and the author in [\[22\]](#page-7-9); and the rank-one case in arbitrary codimension was solved by the author in [\[26\]](#page-7-10). The interest in Problem [1.1](#page-0-0) is at least partially motivated by the desire to find new methods, alternative to the Gauss parametrization [\[12,](#page-6-12) [28\]](#page-7-11), to describe constant-rank submanifolds. The purpose of

this paper is to present a solution of Problem [1.1](#page-0-0) without any assumption on s, m , or c.

To state our main result, let \mathcal{D}^{\perp} be the distribution of rank c whose fiber at $p \in S$ is the orthogonal complement of \mathcal{D}_p in \mathbb{R}^{m+c} , let π^{\top} denote orthogonal projection onto \mathcal{D} , and let ϕ_p be the map

$$
T_p S \times \mathcal{D}_p^{\perp} \to \mathcal{D}_p
$$

$$
(v, n) \mapsto \pi^{\top} \nabla_v N,
$$

where ∇ is the Euclidean connection, and where N is any extension of n to a local section of \mathcal{D}^{\perp} . It is easy to see that ϕ_p is well defined.

Theorem 1.2. Suppose that there exists a section N^* of \mathcal{D}^{\perp} such that the shape operator $A^* := A_{N^*}$ of S in direction N^* is nonsingular, i.e.,

$$
rank A^*|_{p} = s \quad \forall p \in S.
$$

The geometric Cauchy problem for rank-s submanifolds of \mathbb{R}^{m+c} has a solution if and only if $\phi_p(T_pS, N_p^*) = \text{Im }\phi_p$ for all $p \in S$. Moreover:

- (i) The solution is locally unique, i.e., any two solutions coincide on an open set containing S.
- (ii) In this open set, the unique solution is given by

$$
\{p + x \mid p \in S, x \in \mathcal{D}_p \cap (\operatorname{Im} \phi_p)^{\perp}\},\
$$

where \perp denotes orthogonal complement in \mathbb{R}^{m+c} .

(iii) Given a local parametrization $\xi \colon A \to \mathbb{R}^{m+c}$ of S, the solution can be locally parametrized as follows. Let (E_1, \ldots, E_m) be a smooth orthonormal frame for $\mathcal{D}|_{\xi(A)}$ whose first s elements span TS. For any $j = 1, \ldots, m - s$, let G_i be the group of permutations of the set $\{1, \ldots, i, \ldots, s, s + j\}$ obtained
by omitting the element i, and, denoting by ϕ_i^k the coordinate function $\langle \phi(E_i, N^*), E_k \rangle = \langle \nabla_{E_i} N^*, E_k \rangle, let$

(1)
$$
X_j = \sum_{i \in \{1, ..., s, s+j\}} (-1)^h \sum_{\lambda \in G_i} \text{sgn}(\lambda) \phi_1^{\lambda(1)} \cdots \phi_s^{\lambda(s+j)} E_i,
$$

where $h = i$ for $i = 1, ..., s$ and $h = s + 1$ otherwise. Then

$$
\sigma(a, b^1, \dots, b^{m-s}) = \xi(a) + b^1 X_1(a) + \dots + b^{m-s} X_{m-s}(a)
$$

is the desired parametrization.

Remark 1.3. The section N^* does not need to be global. The theorem remains valid if one merely assumes the existence of a local section $N^*(p)$ in a neighborhood U_p of each point $p \in S$, along with the compatibility condition

$$
N^*(p) = \pm N^*(q) \quad \forall p, q \text{ such that } U_p \cap U_q \neq \emptyset.
$$

Remark 1.4. If the distribution $\mathcal D$ is obtained by restricting to S the tangent bundle of an arbitrary submanifold $M \supset S$, then the map $\phi(\cdot, N^*)$ coincides with the restriction to TS of the shape operator of M with respect to N^* . In this case the theorem provides conditions for the existence of a constant-rank, first-order approximation of M along S.

Remark 1.5. When $s = 1$, formula [\(1\)](#page-1-0) reduces to $X_j = \phi^1 E_{1+j} - \phi^{1+j} E_1$, and we thus retrieve the third item in [\[26,](#page-7-10) Theorem 1.3]. The formula is new from $s = 2$, when it reduces to $X_j = -(\phi_1^2 \phi_2^{2+j} - \phi_1^{2+j} \phi_2^2) E_1 + (\phi_1^1 \phi_2^{2+j} - \phi_1^{2+j} \phi_2^1) E_2 - (\phi_1^1 \phi_2^2 - \phi_1^2 \phi_2^1) E_{j+2}$.

Clearly, when $c = 1$, the condition on ϕ_p is automatically satisfied, and Problem [1.1](#page-0-0) becomes generically well posed.

Corollary 1.6. Suppose that $c = 1$. If there exists a section N^* of \mathcal{D}^{\perp} such that the shape operator $A^* = A_{N^*}$ of S in direction N^* is nonsingular, then the geometric Cauchy problem for rank-s hypersurfaces of \mathbb{R}^{m+1} has a solution.

The proof of Theorem [1.2](#page-1-1) will be given in section [3.](#page-4-0) It is based on the wellknown fact that any *m*-dimensional rank-s submanifold of \mathbb{R}^{m+c} admits a foliation by totally geodesic leaves, of dimension $m - s$, along which the tangent space is constant; the converse holds under the additional assumption that the foliation is unique. We will exploit this fact in the next section, where we will derive a sufficient criterion for an $(m - s)$ -ruled submanifold to be rank-s. Such criterion extends a classical result about developable surfaces in \mathbb{R}^3 [\[20,](#page-7-12) Theorem 54.1]; see also [\[30\]](#page-7-13).

2. Constant-rank submanifolds

The purpose of this section is to generalize [\[26,](#page-7-10) Lemma 3.7] to $(m - s)$ -ruled submanifolds.

Definition 2.1. Let M be an m-dimensional embedded submanifold of \mathbb{R}^{m+c} . We say that M is $(m - s)$ -ruled if it admits a foliation by $(m - s)$ -dimensional totally geodesic submanifolds of \mathbb{R}^{m+c} , called *rulings*. In particular, we say that M is properly $(m - s)$ -ruled when the foliation is unique.

Given a s-dimensional embedded submanifold S of \mathbb{R}^{m+c} , the following lemma is the key to extending S to an $(m - s)$ -ruled submanifold. Recall that two embedded submanifolds S, S' of a smooth manifold are said to *intersect transversely* if for each $p \in S \cap S'$, the tangent spaces T_pS and T_pS' together span the ambient tangent space.

Lemma 2.2. Let F be a distribution of rank $m - s$ along S such that

$$
\dim(T_p S \oplus \mathcal{F}_p) = m \quad \forall p \in S.
$$

Then the subset

$$
\{p + x \mid p \in S, x \in \mathcal{F}_p\}
$$

defines an $(m - s)$ -ruled submanifold M_F in a neighborhood of S. Conversely, any $(m - s)$ -ruled submanifold containing S and whose rulings intersect S transversely admits a description of this form.

Proof. We first prove a local version of the lemma. Let ξ : $A \to \mathbb{R}^{m+c}$ be a local parametrization of S, let (X_1, \ldots, X_{m-s}) be a local frame for F over A, and, for $B \subset \mathbb{R}^{m-s}$ open, define $\sigma: A \times B \to \mathbb{R}^{m+c}$ by

$$
\sigma(a, b^1, \dots, b^{m-s}) = \xi(a) + b^1 X_1(a) + \dots + b^{m-s} X_{m-s}(a).
$$

Since the partial derivatives of σ are linearly independent at $(a, 0)$, they remain linearly independent in some neighborhood U_a of $(a, 0)$ in $A \times B$. Moreover, after shrinking U_a and B if necessary, we may assume that $\sigma(U_a)$ is embedded and there exists a neighborhood V_a of $\xi(A)$ in \mathbb{R}^{m+c} such that

$$
\sigma(U_a) = V_a \cap \sigma(A \times B);
$$

to see this, note that otherwise, by making B arbitrarily close to 0, the assumption that S is embedded would be violated. Let $M := \bigcup_{a \in A} U_a$, and let $q \in M$. Since M is an immersed submanifold, the rank theorem [\[21,](#page-7-14) Theorem 4.12] implies the existence of a slice chart for M in \mathbb{R}^{m+c} around q. Hence M satisfies the local slice criterion for embedded submanifolds [\[21,](#page-7-14) Theorem 5.8], which is the desired local conclusion.

To prove the full statement, let $\{\xi_i: A_i \to \mathbb{R}^{m+c}\}_{i=1}^r$ be a set of local parametrizations of S covering S, and let $\{\sigma_i: A_i \times B_i \to \mathbb{R}\}_{i=1}^r$ be the corresponding maps σ , as defined earlier. Then we know that for each i there exists a neighborhood U_i of $(A_i, 0)$ in $A_i \times B_i$ such that $\sigma_i(U_i)$ is embedded. Shrinking U_1, \ldots, U_r along the second factor if necessary, we may assume that there are neighborhoods V_1, \ldots, V_r of $\xi_1(A_1), \ldots, \xi_r(A_r)$ in \mathbb{R}^{m+c} such that

$$
\sigma_i(U_i) = V_i \cap (\cup_{i=1}^r \sigma_i(U_i)) \quad \forall i = 1, \ldots, r.
$$

As before, this implies the existence of a slice chart for $M_i = \sigma_i(U_i)$ in \mathbb{R}^{m+c} around every $q \in M_i$. Hence $M \coloneqq \cup_i M_i$ is the desired $(m - s)$ -ruled submanifold. \square

Next we define constant-rank submanifolds and give two alternative characterizations of them.

Definition 2.3. Let M be an m-dimensional embedded submanifold of \mathbb{R}^{m+c} . The *index of relative nullity* of M at a point $p \in M$ is the dimension of the kernel Δ of the second fundamental form α at p :

$$
\Delta = \{ x \in T_p M \mid \alpha(x, \cdot) = 0 \}.
$$

We say that M is a *constant-rank* submanifold if the index of relative nullity is constant. In particular, we say that M is rank-s when the index is equal to $m - s$.

Theorem 2.4 ([\[19,](#page-7-15) Lemma 3.1]). The following statements are equivalent:

- (1) *M* is rank-s.
- (2) The Gauss map $M \to Gr(m, m+c)$ has rank s everywhere; here $Gr(m, m+c)$ denotes the Grassmannian of m-dimensional subspaces of \mathbb{R}^{m+c} .
- (3) M is properly $(m s)$ -ruled with constant tangent space along the $(m s)$ rulings.

Thus, under very mild conditions, rank-s submanifolds containing S are locally in one-to-one correspondence with distributions $\mathcal F$ of rank $m - s$ along S satisfying

$$
T_p M_{\mathcal{F}} = T_{p+x} M_{\mathcal{F}} \quad \forall x \in \mathcal{F}_p
$$
 such that $p + x \in M_{\mathcal{F}}$.

The next lemma turns this condition into a relation involving the ambient covariant derivative along S and represents the sought generalization of [\[26,](#page-7-10) Lemma 3.7].

Lemma 2.5. The tangent space of M_F is constant along $x \in \mathcal{F}_p$ if and only if

$$
\nabla_v X \in T_p M_{\mathcal{F}} \quad \forall v \in T_p S,
$$

where X is any extension of x to a local section of $\mathcal{F}.$

Proof. Let $\xi: A \to \mathbb{R}^{m+c}$ be a local parametrization of S around p, and let $(X_j)_{j=1}^{m-s}$ be a local frame for F over A. Then the map $\sigma: A \times \mathbb{R}^{m-s} \to \mathbb{R}^{m+n}$ defined by

$$
\sigma(a, b^1, \dots, b^{m-s}) = \xi(a) + b^1 X_1(a) + \dots + b^{m-s} X_{m-s}(a)
$$

is a local parametrization of M_F in a neighborhood of p. Since the tangent space $T_{(a,0,\ldots,0,b^j,0,\ldots,0)}\sigma$ of σ at $\sigma(a,0,\ldots,0,b^j,0,\ldots,0)$ is spanned by

$$
\partial_1 \xi(a) + b^j \partial_1 X_j(a), \dots, \partial_s \xi(a) + b^j \partial_s X_j(a), X_1(a), \dots, X_{m-s}(a),
$$

it follows that

 $T_{(a,0,...,0,b^j,0,...,0)}\sigma = T_{(a,0)}\sigma = \text{span}(\partial_1\xi(a),\ldots,\partial_s\xi(a),X_1(a),\ldots,X_{m-s}(a))$

if and only if $\partial_i X_j(a) \in T_{(a,0)}\sigma$ for every $i = 1, \ldots, s$; by linearity, this is equivalent to all directional derivatives of X_j being in $T_{(a,0)}\sigma$ at a. Now, to complete the proof, it is enough to note that any of the elements of the frame $(X_j)_{j=1}^{m-s}$ may be chosen to coincide with x at p .

Remark 2.6. It is easy to see, using orthogonality of $T_p M_{\mathcal{F}}$ and $(T_p M_{\mathcal{F}})^{\perp}$, that the condition $\nabla_v X \in T_p M_{\mathcal{F}}$ in Lemma [2.5](#page-3-0) only depends on X through $X_p = x \in T_p M_{\mathcal{F}}$. Hence the lemma continues to hold if "local section of \mathcal{F} " is replaced by "local section of $TM_{\mathcal{F}}$ ".

Remark 2.7. By the properties of the covariant derivative, Lemma [2.5](#page-3-0) implies that the tangent space of $M_{\mathcal{F}}$ is constant along every $x \in \mathcal{F}$ if and only if

$$
\nabla_{v_i} X_j \in T_p M_{\mathcal{F}} \quad \forall i, j,
$$

where (v_1, \ldots, v_s) is a basis of T_pS and (X_1, \ldots, X_{m-s}) a local frame for $\mathcal F$ around p .

3. Proof of the main result

In this section we prove Theorem [1.2.](#page-1-1) The proof of the first two items is based on the following lemma.

Lemma 3.1. Suppose that there exists a section N^* of D^{\perp} such that the shape operator A^* of S in direction N^* is nonsingular at p. Then

$$
T_p S \cap \phi_p(T_p S, N_p^*)^{\perp} = \{0\}.
$$

Proof. Let π_S denote orthogonal projection onto TS, so that

$$
A_N = \pi_S \circ \phi(\cdot, N).
$$

Suppose, towards a contradiction, that there exists a nonzero vector $v \in T_pS$ such that

$$
\langle v, \phi(w, N^*) \rangle = 0 \quad \forall w \in T_p S.
$$

Since $\phi(\cdot, N)$ is self-adjoint with respect to the metric, this implies

$$
A^*(v) = 0,
$$

contradicting the assumption that A^* has full rank at p. \Box

Proof of Theorem [1.2](#page-1-1)[\(i\)–](#page-1-2)[\(ii\)](#page-1-3). According to Lemmas [2.2](#page-2-0) and [2.5,](#page-3-0) we need to find an $(m - s)$ -dimensional subspace \mathcal{F}_p of \mathcal{D}_p satisfying $T_pS \cap \mathcal{F}_p = \{0\}$ and

$$
\nabla_v x \in \mathcal{D}_p \quad \forall (v, x) \in T_p S \times \mathcal{F}_p,
$$

where x is being extended arbitrarily to a local section X of D . Note that the latter condition is equivalent to

(2)
$$
\langle \nabla_v x, n \rangle = 0 \quad \forall (v, x, n) \in T_p S \times \mathcal{F}_p \times \mathcal{D}_p^{\perp};
$$

using orthogonality of x and n , we can rewrite (2) as

$$
\langle x, \phi_p(v, n) \rangle = 0 \quad \forall (v, x, n) \in T_p S \times \mathcal{F}_p \times \mathcal{D}_p^{\perp}
$$

or, more succinctly, as

$$
\mathcal{F}_p \subset (\operatorname{Im} \phi_p)^{\perp}.
$$

Suppose that there exists a section N^* of \mathcal{D}^{\perp} such that the shape operator A^* of S in direction N^* is nonsingular at p, and set

$$
\mathcal{F}_p^* \coloneqq \mathcal{D}_p \cap \phi_p(T_p S, N_p^*)^{\perp}.
$$

Then, since $A_{N^*} = \pi_S \circ \phi(\cdot, N^*)$, we deduce that \mathcal{F}_p^* is a subspace of dimension $m - s$; besides, it has trivial intersection with T_pS by Lemma [3.1.](#page-4-2) Observing that

$$
(\operatorname{Im} \phi_p)^{\perp} \subset \phi_p(T_p S, N_p^*)^{\perp},
$$

we conclude that \mathcal{F}^* can only define a solution of our problem when Im ϕ_p = $\phi_p(T_pS, N_p^*)$.

Next we check that \mathcal{F}^* does indeed define a solution. To this end, let $M^* \coloneqq$ $M_{\mathcal{F}^*}$ be an embedded submanifold containing S, whose existence is guaranteed by Lemma [2.2.](#page-2-0) First note that, by construction, the shape operator A^* of S is nothing but the restriction to TS of a shape operator of M^* . Hence, as the tangent space is constant along \mathcal{F}^* , the index of relative nullity of M^* equals $m - s$ along S. By the same reason, extending N^* via parallel translation in the ambient space to a unit normal vector field along M^* , we have that

$$
A_{p+x}^*(v) = A_p^*(v) \quad \forall v \in \mathcal{D}_p \equiv T_{p+x}M^*,
$$

which implies that the index of relative nullity of M^* is constant, as claimed. \Box

It remains to prove Theorem [1.2](#page-1-1)[\(iii\).](#page-1-4) To set the stage, we first recall the notion of $((m-1)$ -fold) vector cross product.

Let V be an m-dimensional oriented inner product space, and let (e_1, \ldots, e_m) be an orthonormal basis of V . A vector cross product on V is a multilinear map $\cdot \times \cdots \times \cdot : V^{m-1} \to V$ such that

$$
\langle e_1 \times \cdots \times e_{m-1}, e_1 \rangle = \cdots = \langle e_1 \times \cdots \times e_{m-1}, e_{m-1} \rangle = 0,
$$

$$
\langle e_1 \times \cdots \times e_{m-1}, e_1 \times \cdots \times e_{m-1} \rangle = \det(\langle e_i, e_j \rangle)_{i,j=1}^{m-1},
$$

$$
(e_1, \ldots, e_{m-1}, e_1 \times \cdots \times e_{m-1})
$$
 is positively oriented.

It is well known that there is only one vector cross product on V . It is given by

$$
v_1 \times \cdots \times v_{m-1} = \star (v_1 \wedge \cdots \wedge v_{m-1}),
$$

where \star denotes the Hodge star operator and \wedge the wedge product on V; see [\[4\]](#page-6-13). More generally, if v_1, \ldots, v_{m-1} are continuous sections of a smooth oriented vector bundle over a smooth manifold, then both \star and \land are globally defined, and the previous equation defines their cross product.

Our proof of Theorem [1.2](#page-1-1)[\(iii\)](#page-1-4) is based on the following lemma.

Lemma 3.2. Let W be an s-dimensional subspace of V, and let ρ be a linear map $W \to V$; without loss of generality, we may assume that the first s elements of (e_1,\ldots,e_m) span W and the first r elements span coim $\rho = (\ker \rho)^{\perp}$. Suppose that the orthogonal complement $\varphi(W)^{\perp}$ of $\varphi(W)$ in V has trivial intersection with coim ρ . Then

$$
x_j = \varphi(e_1) \times \cdots \times \varphi(e_r) \times e_{r+1} \times \cdots \times \widehat{e_{r+j}} \times \cdots \times e_m, \quad j = 1, \ldots, m-r
$$

defines an orthogonal basis of $\varphi(W)^{\perp}$; here the hat indicates that e_{r+j} is omitted.

Proof. By construction, the vector x_j belongs to the intersection between $\varphi(W)^{\perp}$ and the subspace spanned by $e_1, \ldots, e_r, e_{r+j}$. Since $\varphi(W)^{\perp}$ has trivial intersection with span (e_1, \ldots, e_r) , it follows that x_1, \ldots, x_{m-r} all lie in orthogonal subspaces, showing that they indeed span $\varphi(W)^{\perp}$. [⊥]. □

Proof of Theorem [1.2](#page-1-1)[\(iii\)](#page-1-4). Let (E_1, \ldots, E_m) be a smooth orthonormal frame for $\mathcal{D}|_{\xi(A)}$ whose first s elements span TS. Equipping $\mathcal{D}|_{\xi(A)}$ with the orientation naturally induced by that frame, the vector cross product becomes well defined on $\mathcal{D}|_{\xi(A)}$. Then, for each $j = 1, \ldots, m - s$, let

(3)
$$
X_j = \phi(E_1, N^*) \times \cdots \times \phi(E_s, N^*) \times E_{s+1} \times \cdots \times \widehat{E_{s+j}} \times \cdots \times E_m,
$$

where the hat indicates that E_{s+j} is omitted. Since coim $\phi = TS$ by assumption, we deduce from Lemmas [3.1](#page-4-2) and [3.2](#page-5-0) that (X_1, \ldots, X_{m-s}) is an orthogonal frame for $\phi(TS, N^*)^{\perp}$.

It remains to compute [\(3\)](#page-6-14) in coordinates. Let $\phi_i^k = \langle \phi(E_i, N^*), E_k \rangle$. Then

$$
\phi(E_i, N^*) = \phi_i^1 E_1 + \cdots + \phi_i^m E_m.
$$

Substitution into [\(3\)](#page-6-14) gives

$$
X_j = \left(\phi_1^1 E_1 + \dots + \phi_1^s E_s + \phi_1^{s+j} E_{s+j}\right) \times \dots \times \left(\phi_s^1 E_1 + \dots + \phi_s^s E_s + \phi_s^{s+j} E_{s+j}\right)
$$

$$
\times E_{s+1} \times \dots \times \widehat{E_{s+j}} \times \dots \times E_m,
$$

which implies (1) .
