## DARBOUX-LIE DERIVATIVES

ANTONIO DE NICOLA AND IVAN YUDIN

ABSTRACT. We introduce the Darboux-Lie derivative for fiber-bundle maps from natural bundles to associated fiber bundles and study its properties.

### 1. Introduction

This article is an accompanying paper to the series of articles on "analytical" theory of G-structures. In the course of reformulating the basic notions pertaining to G-structures on manifolds in terms of equivalence classes of soldering forms, we stumbled upon the absence of a properly developed notion of Lie derivative for such forms. A soldering form  $\beta$  in this context refers to an isomorphism of vector bundles  $\beta \colon TM \to P \times V$ , where P is a G-principal bundle and V is a G-module.

More generally, we will define and study the properties of Lie derivatives for maps h of fiber bundles from  $F(M)$  to  $P \times N$ , where M is a manifold of dimension  $n, F$  is a natural bundle on *n*-dimensional manifolds,  $P$  a  $G$ -principal bundle over M, and N a manifold equipped with a smooth left G-action.

It turns out that a Lie derivative is a fiber-bundle map from  $F(M)$  to  $P \underset{G}{\times} V$ , where  $V$  is a suitable  $G$ -module. The tricky point is that it cannot be defined along vector fields on M. Rather, it should be defined along G-invariant vector fields  $\mathfrak{X}(P)^G$  on P.

The content of the paper can be summarized as follows. Section [2](#page-1-0) contains some preliminary material. In particular, we fix the notation for principal and associated bundles. Then we recall the definition and main properties of natural bundles.

In Section [3,](#page-4-0) we introduce a version of Lie derivative, which we call *Darboux*-Lie derivative. Darboux-Lie derivatives are applied to fiber-bundle maps from a natural bundle to an associated fiber bundle.

In  $[5]$ , Janyška and Kolář developed a general theory of Lie derivatives that includes as special cases the usual Lie derivatives and covariant derivatives of sections  $s: M \to P \underset{G}{\times} V$ . We will see that the notion of Darboux-Lie derivative incorporates the Janyška-Kolář version of Lie derivative.

Let  $h: F(M) \to P \underset{G}{\times} N$  be a fiber-bundle map as before. In order to obtain a concept that encompasses the classical idea of derivative, we use a G-equivariant form  $\omega: TN \to V$  on N with values in a G-module V. In some notable cases, there is a canonical choice for such a form. For example, when  $N$  is a Lie group equipped with the left action, then the natural choice for  $\omega$  is the left Maurer-Cartan form on N. The Darboux-Lie derivative of h along a G-invariant vector field  $X$  on P is a fiber-bundle map  $\mathcal{L}_{\tilde{X}}^{\omega} h: F(M) \to P \times V$ . It is defined using the Trautman lift also known as "the generalized Lie derivative". In Proposition [3.3,](#page-7-0) we express the Darboux-Lie derivative in terms of flows of vector fields, thus relating it to the classical concept of Lie derivative.

In Section [4](#page-8-0) we discuss the Darboux-Lie derivative along G-invariant vertical vector fields. Every such vector field  $\overline{X}$  corresponds to a unique section  $\overline{a}$  of  $P \times \mathfrak{g}$ . In the case h has values in the associated vector bundle  $P \times V$ , we show G<br>in Proposition [4.1](#page-8-1) that  $\mathcal{L}_{\tilde{X}}h = -a \cdot h$ , where  $a \cdot h$  is a suitably defined fiber-bundle map from  $F(M)$  to  $P \underset{G}{\times} V$ . Now, let  ${}_{c}G$  denote the group G equipped with the conjugation action on itself. In Proposition [4.2](#page-9-0) we find an expression for  $\mathcal{L}_{\tilde{X}}h$  in the case h takes values in  $P \underset{G}{\times} {}_cG$ .

In Section [5](#page-10-0) we show that Darboux-Lie derivatives satisfy suitable Leibniz rules with respect to various binary operations on fiber-bundle maps. We obtain rather general expressions in [\(28\)](#page-15-0) and [\(31\)](#page-17-0). To prove them, we also derive Leibniz rules for fibered and tensor products in [\(15\)](#page-11-0) and [\(17\)](#page-12-0), respectively.

As a special case, we obtain the following useful expression for the Darboux-Lie derivative of  $s \cdot \beta$ , where  $s \in \Gamma(M, P \underset{G}{\times} G)$  and  $\beta \in \Omega^1(M, P \underset{G}{\times} V)$ 

$$
\pounds_{\widetilde{X}}(s \cdot \beta) = s \cdot (\pounds_{\widetilde{X}} s \cdot \beta + \pounds_{\widetilde{X}} \beta).
$$

Moreover, if  $s_1, s_2 \in \Gamma(M, P \times_c G)$  we get the equation

$$
\pounds_{\widetilde{X}}(s_1 \cdot s_2) = \mathrm{Ad}_{s_2^{-1}} \left( \pounds_{\widetilde{X}} s_1 \right) + \pounds_{\widetilde{X}} s_2.
$$

In Section [6,](#page-17-1) we assume that  $P$  is equipped with a  $G$ -principal connection. Under this assumption, we derive the Cartan magic formula for  $\mathcal{L}_{X^H} \beta$ , where  $\beta$ is a differential form with values in  $P \underset{G}{\times} V$  and  $X^H$  is the horizontal lift of a vector field  $X$  on  $M$ . The resulting expression coincides with the usual covariant-Lie derivative with respect to  $X$ . Inspired by this fact, we define the covariant-Darboux-Lie derivative for fiber-bundle maps of the type  $h: F(M) \to P \underset{G}{\times} N$  and we list several Leibniz rules for this derivative.

## 2. Preliminaries

<span id="page-1-0"></span>2.1. Principal bundles. Let G be a Lie group, M a smooth manifold and P a principal G-bundle. One of the most useful facts about principal bundles is the existence of a unique smooth map

$$
\begin{aligned} \n\backslash: P \times_M P &\to G \\ (p_1, p_2) &\mapsto p_1 \backslash p_2, \n\end{aligned}
$$

such that  $p(p\backslash p') = p'$  for every pair p, p' in the same fiber of P. Clearly,  $p\backslash p = e_G$ . Moreover, for all  $g \in G$  and  $(p, p') \in P \times_M P$ , we have

(1) 
$$
(pg)\backslash p'=g^{-1}(p\backslash p'), \quad p\backslash (p'g)=(p\backslash p')g, \quad p'\backslash p=(p\backslash p')^{-1}.
$$

2.2. Associated bundles. Let  $N$  be a manifold equipped with a smooth left G-action. The associated fiber bundle  $P \times N$  over M is defined as the quotient  $(P \times N)/G$ , where G acts on  $P \times N$  by  $(p, y)g = (pg, g^{-1}y)$  for all  $(p, y) \in P \times N$ ,  $g \in G$ . We will write  $[p, y]$  for the G-orbit of  $(p, y)$  in  $P \times N$ . The projection  $P \times N \to M$  is given by  $[p, y] \mapsto x$  for  $x \in M$ ,  $p \in P_x$  and  $y \in N$ . One can check that the following map

$$
\begin{aligned} \n\backslash: P \times_M (P \underset{G}{\times} N) &\to N \\ \n(p, [p', y]) &\mapsto p \backslash [p', y] := (p \backslash p')y \n\end{aligned}
$$

is well-defined and smooth. We found that this map is quite useful to explicitly construct maps between associated bundles.

2.3. Vector fields and their flows. Given a vector field X on M, we write  $\gamma_x^X$ for the maximal integral curve of  $X$  whose value at 0 is  $x$ . We denote the interval of definition of  $\gamma_x^X$  by  $J_x^X$  and the union  $\bigcup$ x∈M  $J_x^X \times \{x\}$  of subsets in  $\mathbb{R} \times M$  by  $D(X)$ . We write  $\varphi_X \colon D(X) \to M$  for the flow of X. Clearly,  $\varphi_X(t,x) = \gamma_x^X(t)$ . For each  $t \in \mathbb{R}$ , write  $U_t^X$  for the open set of points x in M such that  $(t, x) \in D(X)$  and write  $\Phi_X^t: U_t^X \to U_{-t}^X$  for the *flow operator* that sends x to  $\varphi(t, x)$ .

2.4. Natural bundles. A systematic treatment of natural bundles can be found in [\[6,](#page-20-1) Ch. IX]. Here we will just recall the definition of natural bundle and their properties that will be needed later.

Write  $\mathcal{M}f$  for the category of smooth manifolds with smooth maps between them and  $\mathcal{M}_{n}$  for its subcategory of manifolds of dimension n with local diffeomorphisms between them as morphisms. Denote by  $\mathcal E$  the embedding of  $\mathcal M f_n$  into  $\mathcal{M}$ f. One of the possible equivalent definitions of a natural bundle is to say that a natural bundle is a pair  $(F, p)$ , where  $F: \mathcal{M}f_n \to \mathcal{M}f$  is a functor and  $p: F \to \mathcal{E}$ a natural transformation such that

(a) for each  $M \in \mathcal{M}f_n$  the map  $p_M : F(M) \to M$  endows  $F(M)$  with a structure of fiber bundle over M;

(b) for each  $f: M \to N$  in  $\mathcal{M}f_n$  the map  $F(f): F(M) \to F(N)$  is a fiberwise diffeomorphism covering  $f: M \to N$ , i.e. the commutative diagram

(2) 
$$
F(M) \xrightarrow{F(f)} F(N)
$$

$$
p_M \downarrow \qquad \qquad p_N
$$

$$
M \xrightarrow{f} N
$$

is a pull-back square.

A natural map from a natural bundle  $(F, p)$  and to a natural bundle  $(F', p')$  is a natural transformation of functors  $\eta: F \to F'$  such hat  $p = p' \circ \eta$ . It is customary to refer to a natural bundle just by its functor part  $F$ .

One defines a *natural vector bundle* as a natural bundle  $(F, p)$  such that each  $p_M: F(M) \to M$  is a vector bundle and for each  $f: M \to N$  in  $\mathcal{M}f_n$  the map  $F(f): F(M) \to F(N)$  is a morphism of vector bundles. Similarly, one defines natural principal bundles.

Natural bundles can be constructed using jet bundles. Let  $M \in \mathcal{M}f_n$ . For  $k \geq 1$ , write  $J(M, k)$  for the space of invertible k-jets at 0 of smooth maps from  $\mathbb{R}^n$  to M. Denote by  $G(n,k)$  the subspace of  $J(\mathbb{R}^n, k)$  consisting of jets that have value 0 at 0. Then  $G(n, k)$  is a Lie group under composition of jets and  $J(M, k)$ is a  $G(n, k)$ -principal bundle.

For a smooth map  $\psi: \mathbb{R}^n \to M$  write  $j^k(\psi)$  for the k-th jet of  $\psi$  at 0. For a local diffeomorphism  $f: M \to N$ , we define

$$
J(f,k): J(M,k) \to J(N,k)
$$

$$
j^{k}(\psi) \mapsto j^{k}(f \circ \psi).
$$

This turns  $J(-,k)$  into a natural  $G(n, k)$ -principal bundle on  $\mathcal{M}_{n}$ .

One can check that for every manifold N equipped with a smooth  $G(n, k)$ -action the functor  $J(-,k) \underset{G(n,k)}{\times} N$  is a natural bundle. The following result was proved in [\[1\]](#page-20-2).

**Proposition 2.1.** If F is a natural bundle on  $\mathcal{M}_{n}$ , then there is a natural number k and a manifold N equipped with a smooth left  $G(n,r)$ -action such that F is naturally isomorphic to  $J(-,k) \underset{G(n,k)}{\times} N$ .

Let X be a vector field on M and N a manifold with a smooth  $G(n, k)$ -action. There is a unique vector field X on  $J(M, k) \underset{G(n,k)}{\times} N$  whose flow is given by

$$
\Phi_{\tilde{X}}^t[j^k(\psi), y] = (J(\Phi_X^t, k) \underset{G(n,k)}{\times} N)[j^k(\psi), y] = [j^k(\Phi_X^t \circ \psi), y].
$$

We get that  $\widetilde{X}$  is a lift of X and that  $U_t^{\widetilde{X}} = J(U_t^X, k) \underset{G(n,k)}{\times} N \subset J(M, k) \underset{G(n,k)}{\times} N$ . Thus  $J_z^{\tilde{X}} = J_x^X$  for all  $x \in M$  and z in the corresponding fiber of  $J(M, k) \underset{G(n,k)}{\times} N$ . If  $F(M)$  is a natural bundle isomorphic to  $J(M, k) \underset{G(n,k)}{\times} N$ , we denote the vector

field on  $F(M)$  corresponding to  $\widetilde{X}$  by  $\mathcal{F}(X)$  and call it the *canonical lift* of X. It is a bit tricky to characterize  $\mathcal{F}(X)$  in terms of the flow  $\Phi_X^t$ , because we cannot assume that  $F(U_t)$  is a subset of  $F(M)$  for a general natural bundle F. Write  $\sigma_t$ for the inclusion of  $U_t$  to M. Then  $F(\sigma_t)$  is an embedding of  $F(U_t)$  into  $F(M)$ and its image coincides with  $U_t^{\mathcal{F}(X)}$ <sup> $\mathcal{F}^{(X)}$ </sup>. Furthermore,  $F(\Phi_X^t)$  and  $\Phi_{\mathcal{F}(X)}^t$  are related by the commutative diagram

$$
F(U_t^X) \xrightarrow{F(\Phi_X^t)} F(U_{-t}^X)
$$

$$
F(\sigma_t) \downarrow \qquad \qquad \downarrow F(\sigma_{-t})
$$

$$
U_t^{\mathcal{F}(X)} \xrightarrow{\Phi_{\mathcal{F}(X)}^t} U_{-t}^{\mathcal{F}(X)}.
$$

If  $\eta: F' \to F$  is a natural map between natural bundles, then for  $x \in M$  and  $y \in F'(M)_x$ , we have

$$
T\eta_M(\mathcal{F}'(X)_y) = \frac{d}{dt}\Big|_{t=0} \eta_M(\Phi^t_{\mathcal{F}'(X)}y)
$$

$$
\mathcal{F}(X)_{\eta_M(y)} = \frac{d}{dt}\Big|_{t=0} \Phi^t_{\mathcal{F}(X)}(\eta_M(y)).
$$

For each t, denote by  $y_t$  the element of  $F(U_t)$  such that  $F(\sigma_t)(y_t) = y$ . Notice that there is only one such  $y_t$  since  $F(\sigma_t)$  is an embedding. Using [\(3\)](#page-4-1) and naturality of  $\eta_M$ , we get

$$
\eta_M(\Phi^t_{\mathcal{F}'(X)}y) = \eta_M(\Phi^t_{\mathcal{F}'(X)} \circ F'(\sigma_t)(y_t)) = \eta_M(F'(\sigma_{-t}) \circ F'(\Phi^t_X)(y_t))
$$
  
=  $F(\sigma_{-t}) \circ F(\Phi^t_X)(\eta_{U_t}(y_t)) = \Phi^t_{\mathcal{F}(X)} \circ F(\sigma_t)(\eta_{U_t}(y_t))$   
=  $\Phi^t_{\mathcal{F}(X)}(\eta_M(F'(\sigma_t)(y_t))) = \Phi^t_{\mathcal{F}(X)}(\eta_M(y)).$ 

Thus [\(4\)](#page-4-2) implies that

(5) 
$$
T\eta_M(\mathcal{F}'(X)_y) = \mathcal{F}(X)_{\eta_M(y)}.
$$

It is the existence of canonical lifts to natural bundles that permits to define the Lie derivative for sections of natural vector bundles, including tensor fields as a special case.

## <span id="page-4-3"></span>3. Darboux-Lie derivatives

<span id="page-4-0"></span>In this section we introduce a version of a Lie derivative that can be applied to maps from natural bundles to associated bundles.

We start with a discussion of what one should expect from such a concept. Given a map h between two smooth manifolds, the tangent map  $Th$  contains information about the first-order behavior of h. The drawback of  $Th$  is that it retains h inside it. A metamathematical idea of a derivative of h would be  $Th$  with h stripped out and only the first-order information retained. It is evident how to do this in the case of R-valued smooth functions. Namely, given a smooth function  $f: M \to \mathbb{R}$ the derivative  $df: TM \to \mathbb{R}$  is determined by

$$
(T_x f)(X) = df(X) \left. \frac{d}{dt} \right|_{t = f(x)}
$$

.

The key point of the definition is the existence of the canonical nowhere zero vector field  $d/dt$  on  $\mathbb{R}$ .

More generally, given a parallelizable manifold N with a global frame  $X_1, \ldots, X_n$ of vector fields, we define the *parallelization form*  $\omega: TN \to \mathbb{R}^n$  by

$$
\omega(a_1X_1+\cdots+a_nX_n)=(a_1,\ldots,a_n).
$$

If  $h: M \to N$  is a smooth map then its derivative can be defined as  $\omega \circ Th$ .

Of course, this type of derivative depends on the choice of the parallelization form  $\omega$ . For example, in the case N is a Lie group H, there are two natural choices for  $\omega$ : either left or right Maurer-Cartan form. In this case the resulting derivative is called left (right) Darboux derivative, respectively.

Another standard example of a derivative is the covariant derivative of a section  $s: M \to P \underset{G}{\times} V$ , where P is a G-principal bundle with a fixed principal connection and  $V$  is a  $G$ -module. In [\[5\]](#page-20-0), Janyška and Kolář developed a general theory of Lie derivatives that includes as special cases the usual Lie derivatives and covariant derivatives. Below, we introduce Darboux-Lie derivatives which generalize Lie derivatives considered by Janyška and Kolář as well as Darboux derivatives.

Let  $M_1$  and  $M_2$  be smooth manifolds and  $h: M_1 \to M_2$  a smooth map. For a pair of vector fields  $X_1 \in \mathfrak{X}(M_1)$ ,  $X_2 \in \mathfrak{X}(M_2)$ , we call the map

$$
\tilde{\mathcal{L}}_{(X_1,X_2)}h\colon M_1\to TM_2
$$
  

$$
x\mapsto (T_xh)(X_1)-(X_2)_{h(x)}.
$$

the Trautman lift of h. Alternatively (cf.  $[6, \text{Lemma 47.2}])$ , we have

(6) 
$$
(\tilde{\mathcal{L}}_{(X_1,X_2)}h)_x = \frac{d}{dt}\bigg|_{t=0} \Phi_{X_2}^{-t} \circ h \circ \Phi_{X_1}^{t}(x).
$$

Remark 3.1. The map  $\tilde{\mathcal{L}}_{(X_1,X_2)}$  was initially introduced by Trautman in [\[7\]](#page-20-3) without a specific name. It was later referred to as the "generalized Lie derivative" in a series of articles by Kolář and his coauthors, with the main results summarized in [\[6,](#page-20-1) Ch. XI]. However, we have chosen to deviate from this terminology because "generalized Lie derivatives" do not align with our concept of a derivative and never specialize to Lie derivatives. Instead, they serve as an intermediate step in the construction of Lie derivatives.

The Trautman lift is particularly useful when  $h : \mathbf{F}_1 \to \mathbf{F}_2$  is a map of fibered manifolds and  $X_1$ ,  $X_2$  are lifts of the same vector field on the base manifold. In this case, the values of  $\tilde{\mathcal{L}}_{(X_1,X_2)}h$  lie in the vertical subbundle  $\mathcal{V}F_2$  of the tangent bundle  $T\mathbf{F}_2$ . Suppose  $\mathbf{F}_2$  is of the form  $P \times N$ , where G is a Lie group, P is a principal G-bundle and N is a manifold equipped with a smooth left G-action. In this case, we can identify  $\mathcal{V}\mathbf{F}_2$  with  $P \underset{G}{\times} TN$  via the isomorphism

$$
\mathcal{V}(P \underset{G}{\times} N) \to P \underset{G}{\times} TN
$$

$$
\left. \frac{d}{dt} \right|_{t=0} [\gamma_P(t), \gamma_N(t)] \mapsto \left[ \gamma_P(0), \frac{d}{dt} \right|_{t=0} (\gamma_P(0) \setminus \gamma_P(t)) \gamma_N(t) \right],
$$

where  $\gamma_P$  is a vertical curve in P and  $\gamma_N$  is an arbitrary curve in N, both defined on the same open interval containing 0. We adopt the same notation  $\tilde{\mathcal{L}}_{(X_1,X_2)h}$  for the composition of  $\tilde{\mathcal{L}}_{(X_1,X_2)}h$  with the above isomorphism.

Suppose  $\omega: TN \to V$  is a G-equivariant 1-form on N. The Darboux-Lie derivative  $\mathcal{L}_{(X_1,X_2)}^{\omega}h$  is the composition of  $\tilde{\mathcal{L}}_{(X_1,X_2)}h\colon \mathbf{F}_1\to P\times TN$  with the map

$$
\text{id} \underset{G}{\times} \omega \colon P \underset{G}{\times} TN \to P \underset{G}{\times} V
$$

$$
[p, Y] \mapsto [p, \omega(Y)].
$$

Remark 3.2. Our definition of Darboux-Lie derivative should be compared with Lie derivatives introduced in [\[2,](#page-20-4) [3\]](#page-20-5). A vertical splitting for a fiber bundle  $\bf{F}$  over M is an isomorphism of vector bundles  $\alpha: \mathcal{V} \mathbf{F} \to \mathbf{F} \times_M E$  over **F** for some vector bundle E over M. In the presence of the vertical splitting  $\alpha$ , Godina and Matteucci defined in [\[2,](#page-20-4)[3\]](#page-20-5) the Lie derivative of a section  $s: M \to \mathbf{F}$  along a projectable vector field  $\widetilde{X} \in \mathfrak{X}(\mathbf{F})$  over  $X \in \mathfrak{X}(M)$  to be the section  $\text{pr}_2 \circ \alpha \circ \widetilde{\mathcal{L}}_{(X, \widetilde{X})} s$  of  $E$ .

When  $\omega$  is a parallelization form on N, we get the following vertical splitting for  $P \underset{G}{\times} N$ 

(7) 
$$
\mathcal{V}(P \underset{G}{\times} N) \xrightarrow{\cong} P \underset{G}{\times} TN \xrightarrow{\tilde{\omega}} (P \underset{G}{\times} N) \times_M (P \underset{G}{\times} V),
$$

where  $\tilde{\omega}$  is given by

$$
\widetilde{\omega}([p, Y]) = ([p, y], [p, \omega(Y)])
$$

for  $p \in P$ ,  $y \in N$  and  $Y \in T_yN$ . When s is a section of  $P \times N$  and one uses the above vertical splitting of  $\mathcal{V}(P \times N)$ , the Darboux-Lie derivative  $\mathcal{L}^{\omega}_{(X, \tilde{X}_N)} s$  coincides with the Lie derivative of s along  $X_N$  in the sense of Godina and Matteucci. The definition of Lie derivative due to Godina and Matteucci is more general than our definition of Darboux-Lie derivative in the aspect that not every vertical splitting has the form [\(7\)](#page-6-0). On the other hand, our definition is more general since it applies to more general maps than sections and permits  $\omega$  to be an arbitrary G-equivariant form, not necessarily a parallelization form. Moreover, Godina and Matteucci did not develop the theory of Lie derivatives in the generality of their definition, but rather applied the theory of Lie derivatives from [\[6\]](#page-20-1). The Lie derivatives studied in  $[6]$  include only those that correspond to the case when **F** is a vector bundle and  $\alpha$  is the canonical vertical splitting.

In this article, we will concentrate on the case  $h: F(M) \to P \underset{G}{\times} N$ , where F is a natural bundle,  $P$  is a principal  $G$ -bundle over  $M$  and  $N$  is a manifold equipped with a smooth left *G*-action.

Suppose  $\widetilde{X} \in \mathfrak{X}(P)$  is G-invariant. Then  $\widetilde{X}$  is projectable onto M. Write  $X \in \mathfrak{X}(M)$  for the corresponding vector field on M. We get the canonical lift  $\mathcal{F}(X)$  on  $F(M)$ . Further, write  $X_N$  for the vector field on  $P \underset{G}{\times} N$ , whose flow is given by  $\Phi^t_{\tilde{X}_N}[p, y] = [\Phi^t_{\tilde{X}}p, y]$ . We will use the following abbreviations

$$
\tilde{\pounds}_{\tilde{X}}h:=\tilde{\mathcal{L}}_{(\mathcal{F}(X),\tilde{X}_N)}h,\quad \pounds_{\tilde{X}}^\omega h:=\mathcal{L}_{(\mathcal{F}(X),\tilde{X}_N)}^\omega h.
$$

If N is a G-module V, then there is the canonical parallelization form  $\text{pr}_2 \circ \text{vl}_V^{-1}$ on  $V$ , where

$$
\mathrm{vl}_V: V \oplus V \to TV
$$

$$
(v, w) \mapsto \frac{d}{dt}\bigg|_{t=0} (v + wt).
$$

Another interesting case is when N coincides with  $G$  considered with conjugation action. In this case, we can take  $\omega$  to be the left-invariant Maurer-Cartan form on G, defined by

$$
\omega_{MC} \colon TG \to \mathfrak{g} = T_e G
$$

$$
T_g G \ni Z \mapsto (T_e L_g)^{-1}(Z).
$$

<span id="page-7-0"></span>In these two cases we will skip  $\omega$  in  $\mathcal{L}^{\omega}_{\tilde{X}_c}$ . The following proposition shows that the Lie derivatives  $\mathcal{L}^{\omega}_{\tilde{X}}$  could have been defined in terms of flows.

**Proposition 3.3.** Let  $h: F(M) \to P \times N$  be a fiber bundle map over M. For all  $x \in M$ ,  $p \in P_x$  and  $y \in F(M)_x$ 

(8) 
$$
\mathcal{L}_{\tilde{X}}^{\omega}h(y) = \left[p, \omega \left(\frac{d}{dt}\bigg|_0 (\Phi_{\tilde{X}}^t p) \backslash h(\Phi_{\mathcal{F}(X)}^t(y))\right)\right] \in P \underset{G}{\times} V.
$$

Proof. From [\(6\)](#page-5-0), we get

$$
\tilde{\mathcal{L}}_{\tilde{X}}h(y) = \frac{d}{dt}\bigg|_{0} \Phi_{\tilde{X}_{N}}^{-t} \circ h \circ \Phi_{\mathcal{F}(X)}^{t}(y)
$$
\n
$$
= \frac{d}{dt}\bigg|_{0} (\Phi_{\tilde{X}}^{-t} \times id)[\Phi_{\tilde{X}}^{t} p, (\Phi_{\tilde{X}}^{t} p) \backslash h(\Phi_{\mathcal{F}(X)}^{t}(y))]
$$
\n
$$
= \frac{d}{dt}\bigg|_{0} [p, (\Phi_{\tilde{X}}^{t} p) \backslash h(\Phi_{\mathcal{F}(X)}^{t}(y))].
$$

Hence, if we look at  $\tilde{\mathcal{L}}_{\tilde{X}} h$  as a map with values at  $P \underset{G}{\times} TN$ , we obtain

$$
\tilde{\pounds}_{\tilde{X}}h(y)=\left[p,\left.\frac{d}{dt}\right|_0(\Phi_{\tilde{X}}^tp)\backslash h(\Phi_{\mathcal{F}(X)}^t(y))\right].
$$

Now the result follows from the definition of  $\mathcal{L}_{\tilde{Y}}^{\omega}h$ .  $\frac{\omega}{\tilde{X}}h.$ 

<span id="page-8-0"></span>*Remark* 3.4. In the case  $N = V$  is a G-module,  $\omega = \text{pr}_2 \circ \text{vl}_V^{-1}$  and  $\gamma$  is a curve in V, then  $\omega(\dot{\gamma}(0))$  coincides with the derivative of  $\gamma(t)$  at 0 as it is usually defined in standard Calculus courses.

# 4. Darboux-Lie derivatives with respect to vertical right-invariant vector fields

Write **g** for the Lie algebra of the group G. For each section a of  $P \times g$ , we denote by  $X^a$  the vertical vector field on P whose flow is given by

$$
\Phi_{X^a}^t p = p \exp((p \backslash a(x))t), \quad \text{for } x \in M, p \in P_x.
$$

It is a G-invariant vector field on P. Conversely, one can show that if  $\widetilde{X}$  is a G-invariant vertical vector field on  $P$  then it coincides with  $X^a$ , where

$$
a: M \to P \underset{G}{\times} \mathfrak{g}
$$

$$
x \mapsto \left[ p, \frac{d}{dt} \Big|_0 p \backslash \Phi_{\widetilde{X}}^t p \right],
$$

for an arbitrary  $p \in P_x$ .

Let V be a G-module. The induced action of  $\dot{\gamma}(0) \in \mathfrak{g}$  on  $v \in V$  is defined by

(9) 
$$
\dot{\gamma}(0)v = \text{pr}_2 \circ \text{vl}_V^{-1} \left( \frac{d}{dt} \bigg|_0 \gamma(t)v \right).
$$

For  $a \in \Gamma(M, P \times \mathfrak{g})$  and  $h \colon F(M) \to P \times V$ , we define  $a \cdot h \colon F(M) \to P \times V$  by  $a \cdot h(y) = [p,(p\backslash a(x))(p\backslash h(y))],$ 

<span id="page-8-1"></span>where  $y \in F(M)$ , x is the base point of the fiber of y and p is an arbitrary point in the fiber  $P_x$ .

**Proposition 4.1.** Let V be a G-module. For every  $a \in \Gamma(M, P \times \mathfrak{g})$  and every map  $h: F(M) \to P \underset{G}{\times} V$  of fiber bundles over M, we have  $\pounds_{X} h = -a \cdot h$ .

*Proof.* Let  $x \in M$ ,  $y \in F(M)_x$  and  $p \in P_x$ . From Proposition [3.3,](#page-7-0) it follows that

$$
p \backslash \mathcal{L}_{X^a} h(y) = \text{pr}_2 \circ \text{vl}_V^{-1} \left( \frac{d}{dt} \bigg|_0 (\Phi_{X^a}^t p) \backslash h(y) \right).
$$

Applying the definition of  $\Phi_{X^a}^t$ , we get

$$
p \backslash \pounds_{X^a} h(y) = \text{pr}_2 \circ \text{vl}_V^{-1} \left( \frac{d}{dt} \bigg|_0 \left( p \exp((p \backslash a(x))t) \right) \backslash h(y) \right).
$$

As for every  $g \in G$  and  $z \in (P \times V)_x$ , we have  $(pg) \setminus z = g^{-1}(p \setminus z)$ , the above formula can be rewritten in the form

$$
p\backslash \pounds_{X^a}h(y) = \text{pr}_2 \circ \text{vl}_V^{-1}\left(\frac{d}{dt}\bigg|_0 \exp(-(p\backslash a(x))t)(p\backslash h(y))\right).
$$
  
By (9), we get  $p\backslash \pounds_{X^a}h(y) = -(p\backslash a(x))(p\backslash h(y)).$  Hence  $\pounds_{X^a}h = a \cdot h$ .

When the target bundle is  $P \underset{G}{\times} {}_cG$  instead of  $P \underset{G}{\times} V$  the resulting formula is more interesting. To state the result, we need additional notation. For  $h: F(M) \rightarrow$  $P \underset{G}{\times} {}_{c}G$ , we deviate from the standard conventions and denote by  $h^{-1}$  the map from  $F(M)$  to  $P \underset{G}{\times} {}_cG$  given by  $h^{-1}(y) = [p, (p \backslash h(y))^{-1}]$ , where  $p \in P$  lies over the same point in  $M$  as  $y$ .

Further, for  $a \in \Gamma(M, P \times \mathfrak{g})$ , we define  $\text{Ad}_h(a) \colon F(M) \to P \times \mathfrak{g}$  by

$$
Ad_h(a)(y) = [p, Ad_{p \setminus h(y)}(p \setminus a(x))],
$$

<span id="page-9-0"></span>for all  $x \in M$ ,  $y \in F(M)_x$  and any  $p \in P_x$ .

**Proposition 4.2.** For every  $a \in \Gamma(M, P \times \mathfrak{g})$  and  $h \colon F(M) \to P \times_{G} G$ , we have  $\pounds_{X^a} h = a \circ p_M - \text{Ad}_{h^{-1}}(a).$ 

*Proof.* Write  $*_c$  for the conjugation action of G on itself, i.e.  $h *_c g = hgh^{-1}$  for all h,  $g \in G$ . Let  $x \in M$ ,  $p \in P_x$  and  $y \in F(M)_x$ . By the same chain of arguments as in the proof of Proposition [4.1,](#page-8-1) we get

$$
p \backslash \pounds_{X^a} h(y) = \omega_{MC} \left( \frac{d}{dt} \bigg|_0 \exp(-(p \backslash a(x))t) *_{c} (p \backslash h(y)) \right).
$$

For any  $b \in \mathfrak{g}$  and  $g \in G$ , we have  $\exp(-bt) *_{c} g = \exp(-bt)g \exp(bt)$ . Next

$$
\omega_{MC} \left( \frac{d}{dt} \bigg|_0 \exp(-bt) g \exp(bt) \right) = \frac{d}{dt} \bigg|_0 g^{-1} \exp(-bt) g \exp(bt) \n= -\text{Ad}_{g^{-1}}(b) + b.
$$

Therefore with  $b = p\backslash a(x)$  and  $q = p\backslash h(y)$ , we get

$$
p \backslash \pounds_{X^a} h(y) = -\mathrm{Ad}_{(p \backslash h(y))^{-1}}(p \backslash a(x)) + (p \backslash a(x)).
$$

This proves the proposition.

More generally, for a G-equivariant V-valued 1-form  $\omega$  on N, we define  $*_\omega$ :  $\mathfrak{g} \times$  $N \to V$  by

(10) 
$$
b *_{\omega} z = \omega \left( \frac{d}{dt} \bigg|_0 \exp(bt) z \right).
$$

Then adapting the first part of the proof of Proposition [4.1,](#page-8-1) we get

(11) 
$$
p \backslash \mathcal{L}_{X^a}^{\omega} h(y) = -(p \backslash a(x)) *_{\omega} (p \backslash h(y)),
$$

for all  $y \in F(M)$ . This equation can rewritten as

(12) 
$$
\mathcal{L}_{X^a}^{\omega}h = -a\hat{*}_{\omega}h,
$$

<span id="page-10-0"></span>for a suitably defined  $\hat{*}_{\omega}$ .

## 5. Leibniz rule

We will need in future articles the expressions for  $\pounds_{\widetilde{X}}(s \cdot \beta)$ , where  $s \in \Gamma(M, P) \times G$  $_c(G)$  and  $\beta \in \Omega^1(M, P \times V)$ , and for  $\mathcal{L}_{\tilde{X}}(\alpha \wedge \beta)$ , where  $\beta$  as before and  $\alpha \in$  $\Omega^1(M, P \times \mathfrak{g})$ . This section aims to explore the Leibniz rule for the Darboux-Lie derivative with respect to some binary operations.

Notice that the map  $s \cdot \beta$  can be described as the composition

$$
TM\xrightarrow{\cong} M\times_M TM\xrightarrow{s\times_M\beta} P\times_{G}({}_cG\times V)\to P\times_V V
$$

and  $\alpha \wedge \beta$  as the composition

$$
\Lambda^2 TM \to TM \otimes TM \xrightarrow{\alpha \otimes \beta} P \underset{G}{\times} (\mathfrak{g} \otimes V) \to P \underset{G}{\times} V.
$$

Thus in both cases we have a composition of

- a natural map  $\eta_M : F(M) \to F_1(M) * F_2(M)$ , where  $*$  is either  $\times$  or  $\otimes$ ;
- a suitably defined product  $h_1 * h_2$ :  $F_1(M) * F_2(M) \to P \times (N_1 * N_2)$  of  $h_1 : F_1(M) \to$

 $P \underset{G}{\times} N_1$  and  $h_2 \colon F_2(M) \to P \underset{G}{\times} N_2$ ;

• the map from  $P \underset{G}{\times} (N_1 * N_2) \rightarrow P \underset{G}{\times} N_3$  induced by a map  $N_1 * N_2 \rightarrow N_3$ .

Below we develop a machinery to deal with Darboux-Lie derivatives of compositions of the above type.

<span id="page-10-1"></span>We start with the Leibniz rule for the generalized Lie derivative of a composition. The following proposition follows directly from the definition of generalized Lie derivative.

**Proposition 5.1.** Let  $M_1$ ,  $M_2$ ,  $M_3$  be manifolds and  $X_i \in \mathfrak{X}(M_i)$ ,  $i = 1, 2, 3$ . For any smooth maps  $h_1: M_1 \to M_2$ ,  $h_2: M_2 \to M_3$ , we have

<span id="page-11-1"></span>(13) 
$$
\tilde{\mathcal{L}}_{(X_1,X_3)}(h_2 \circ h_1) = Th_2 \circ \tilde{\mathcal{L}}_{(X_1,X_2)}h_1 + (\tilde{\mathcal{L}}_{(X_2,X_3)}h_2) \circ h_1.
$$

Notice that the vector field  $X_2$  is not present on the left-hand side of [\(13\)](#page-11-1) and thus can be chosen arbitrarily on the right-hand side.

Applying Proposition [5.1](#page-10-1) and [\(5\)](#page-4-3), we conclude that for every natural map  $\eta_M \colon F'(M) \to F(M)$  and for  $h \colon F(M) \to P \underset{G}{\times} N$ 

$$
\tilde{\mathcal{L}}_{\tilde{X}}(h \circ \eta_M) = Th \circ \tilde{\mathcal{L}}_{(\mathcal{F}'(X), \mathcal{F}(X))}\eta_M + (\tilde{\mathcal{L}}_{\tilde{X}}h) \circ \eta_M = (\tilde{\mathcal{L}}_{\tilde{X}}h) \circ \eta_M.
$$

Hence

(14) 
$$
\mathcal{L}_{\tilde{X}}^{\omega}(h \circ \eta_M) = (\mathcal{L}_{\tilde{X}}^{\omega} h) \circ \eta_M.
$$

5.1. Darboux-Lie derivative of a product. Suppose  $F_1$  and  $F_2$  are natural bundles. Define the natural bundle  $F_1 \times F_2$  by  $(F_1 \times F_2)(M) = F_1(M) \times_M F_2(M)$ .

Given  $h_1: F_1(M) \to P \underset{G}{\times} N_1$  and  $h_2: F_2(M) \to P \underset{G}{\times} N_2$ , define

<span id="page-11-2"></span>
$$
h_1 \times_M h_2 \colon (F_1 \times F_2)(M) \to P \underset{G}{\times} (N_1 \times N_2)
$$

$$
(y_1, y_2) \mapsto [p, (p \backslash h_1(y_1), p \backslash h_2(y_2))],
$$

where  $y_1 \in F_1(M)_x$ ,  $y_2 \in F_2(M)_x$ ,  $p \in P_x$  for some  $x \in M$ . Let  $\omega_1: TN_1 \to V_1$ and  $\omega_2$ :  $TN_2 \to V_2$  be G-equivariant 1-forms with values in G-modules  $V_1$  and  $V_2$ . Define  $\omega_1 \times \omega_2$ :  $T(N_1 \times N_2) \rightarrow V_1 \oplus V_2$  by

$$
\omega_1 \times \omega_2 \left( \frac{d}{dt} \bigg|_0 (\gamma_1(t), \gamma_2(t)) \right) = (\omega_1(\dot{\gamma}_1(0)), \omega_2(\dot{\gamma}_2(0))).
$$

By Proposition [3.3,](#page-7-0) we get for  $\widetilde{X} \in \mathfrak{X}(P)^G$  over  $X \in \mathfrak{X}(M)$ 

$$
p\langle \mathcal{L}_{\tilde{X}}^{\omega_1 \times \omega_2} (h_1 \times_M h_2)(y_1, y_2) =
$$
  
\n
$$
= \omega_1 \times \omega_2 \left( \frac{d}{dt} \Big|_0 \Phi_{\tilde{X}}^t p \langle (h_1 \times_M h_2)(\Phi_{\mathcal{F}_1(X)}^t y_1, \Phi_{\mathcal{F}_2(X)}^t y_2) \right)
$$
  
\n
$$
= \omega_1 \times \omega_2 \left( \frac{d}{dt} \Big|_0 (\Phi_{\tilde{X}}^t p \langle h_1 \circ \Phi_{\mathcal{F}_1(X)}^t (y_1), \Phi_{\tilde{X}}^t p \langle h_2 \circ \Phi_{\mathcal{F}_2(X)}^t (y_2) \rangle \right)
$$
  
\n
$$
= \left( \omega_1 \left( \frac{d}{dt} \Big|_0 \Phi_{\tilde{X}}^t p \langle h_1 \circ \Phi_{\mathcal{F}_1(X)}^t (y_1) \rangle \right), \omega_2 \left( \frac{d}{dt} \Big|_0 \Phi_{\tilde{X}}^t p \langle h_2 \circ \Phi_{\mathcal{F}_2(X)}^t (y_2) \rangle \right) \right)
$$
  
\n
$$
= \left( p \langle \mathcal{L}_{\tilde{X}}^{\omega_1} h_1 (y_1), p \rangle \mathcal{L}_{\tilde{X}}^{\omega_2} h_2 (y_2) \right).
$$

Hence

<span id="page-11-0"></span>(15) 
$$
\mathcal{L}_{\tilde{X}}^{\omega_1 \times \omega_2}(h_1 \times_M h_2) = \mathcal{L}_{\tilde{X}}^{\omega_1} h_1 \times_M \mathcal{L}_{\tilde{X}}^{\omega_2} h_2.
$$

5.2. Darboux-Lie derivative of a tensor product. For natural vector bundles  $E_1, E_2$ , we define the natural vector bundle  $E_1 \otimes E_2$  by  $(E_1 \otimes E_2)(M) = E_1(M) \otimes$  $E_2(M)$ . Given two vector bundle maps  $h_1: E_1(M) \to P \underset{G}{\times} V_1$  and  $h_2: E_2(M) \to$  $P \underset{G}{\times} V_2$ , we define

$$
h_1 \otimes h_2 \colon (E_1 \otimes E_2)(M) \to P \underset{G}{\times} (V_1 \otimes V_2)
$$
  

$$
y_1 \otimes y_2 \mapsto [p, (p \backslash h_1(y_1)) \otimes (p \backslash h_2(y_2))],
$$

where  $y_1 \in E_1(M)_x, y_2 \in E_2(M)_x, p \in P_x$  for some  $x \in M$ . We have for all  $x \in M$ ,  $y_1 \in E_1(M)_x, y_2 \in E_2(M)_x$ 

$$
\Phi^t_{(\mathcal{E}_1 \otimes \mathcal{E}_2)(X)}(y_1 \otimes y_2) = \Phi^t_{\mathcal{E}_1(X)}(y_1) \otimes \Phi^t_{\mathcal{E}_2(X)}(y_2).
$$

By Proposition [3.3,](#page-7-0) we get for  $\widetilde{X} \in \mathfrak{X}(P)^G$  over  $X \in \mathfrak{X}(M)$ 

$$
p\lambda \mathcal{L}_{\tilde{X}}(h_1 \otimes h_2)(y_1 \otimes y_2) =
$$
  
=  $\text{pr}_2 \circ \text{vl}_{V_1 \otimes V_2}^{-1}\left(\frac{d}{dt}\bigg|_0 \Phi_{\tilde{X}}^t p \setminus (h_1 \otimes h_2)(\Phi_{\mathcal{F}_1(X)}^t y_1 \otimes \Phi_{\mathcal{F}_2(X)}^t y_2)\right)$   
=  $\text{pr}_2 \circ \text{vl}_{V_1 \otimes V_2}^{-1}\left(\frac{d}{dt}\bigg|_0 \Phi_{\tilde{X}}^t p \setminus h_1 \circ \Phi_{\mathcal{F}_1(X)}^t (y_1) \otimes \Phi_{\tilde{X}}^t p \setminus h_2 \circ \Phi_{\mathcal{F}_2(X)}^t (y_2)\right).$ 

Given curves  $\gamma_1: I \to V_1$  and  $\gamma_2: I \to V_2$ , we have

$$
\begin{aligned} \operatorname{pr}_2 \circ \operatorname{vl}_{V_1 \otimes V_2}^{-1} \left( \left. \frac{d}{dt} \right|_0 \gamma_1(t) \otimes \gamma_2(t) \right) &= \operatorname{pr}_2 \circ \operatorname{vl}_{V_1}^{-1}(\dot{\gamma}_1(0)) \otimes \gamma_2(0) \\ &+ \gamma_1(0) \otimes \operatorname{pr}_2 \circ \operatorname{vl}_{V_2}(\dot{\gamma}_2(0)). \end{aligned}
$$

Therefore

<span id="page-12-1"></span>(16) 
$$
p\lambda \mathcal{L}_{\tilde{X}}(h_1 \otimes h_2)(y_1 \otimes y_2) = (p\lambda \mathcal{L}_{\tilde{X}}h_1(y_1)) \otimes (p\lambda h_2(y_2)) + (p\lambda h_1(y_1)) \otimes (p\lambda \mathcal{L}_{\tilde{X}}h_2(y_2)).
$$

Thence

<span id="page-12-0"></span>(17) 
$$
\pounds_{\widetilde{X}}(h_1 \otimes h_2) = \pounds_{\widetilde{X}}h_1 \otimes h_2 + h_1 \otimes \pounds_{\widetilde{X}}h_2.
$$

5.3. Darboux-Lie derivative of a composition. In this subsection we deal with the Darboux-Lie derivative of  $(\mathrm{id} \underset{G}{\times} f) \circ h$ , where  $h: F(M) \to P \underset{G}{\times} N$  and f is a G-equivariant map from N to N'. Suppose  $\omega' : TN' \to V'$  is a G-equivariant 1-form with values in a *G*-module *V'*. By Proposition [3.3,](#page-7-0) for  $h: F(M) \to P \underset{G}{\times} N$ 

and every  $x \in M$ ,  $y \in F(M)_x$  and  $p \in P_x$ 

$$
p \backslash \mathcal{L}_{\tilde{X}}^{\omega'}((\mathrm{id} \times f) \circ h)(y) = \omega' \left( \frac{d}{dt} \bigg|_0 \Phi_{\tilde{X}}^t p \backslash ((\mathrm{id} \times f) \circ h \circ \Phi_{\mathcal{F}(X)}^t(y)) \right)
$$
  

$$
= f^* \omega' \left( \frac{d}{dt} \bigg|_0 \Phi_{\tilde{X}}^t p \backslash (h \circ \Phi_{\mathcal{F}(X)}^t(y)) \right)
$$
  

$$
= p \backslash \mathcal{L}_{\tilde{X}}^{f^* \omega'} h(y).
$$

Hence

<span id="page-13-0"></span>(18) 
$$
\mathcal{L}_{\tilde{X}}^{\omega'}((\mathrm{id} \times f) \circ h) = \mathcal{L}_{\tilde{X}}^{f^*\omega'}h.
$$

The ability to write the above formula is the reason we don't require  $\omega$  to be a parallelization form in the definition of  $\mathcal{L}^{\omega}_{\tilde{X}}$ , since even if  $\omega'$  is a parallelization form its pull-back  $f^*\omega'$ , in general, is not.

Formula [\(18\)](#page-13-0) becomes more useful if there is a relation between  $f^*\omega'$  and a G-equivariant 1-form  $\omega: TN \to V$ , where V is a G-module. The vector space Hom<sub>R</sub>(V, V') has the G-module structure defined by  $(g\alpha)(v) = g\alpha(g^{-1}v)$  for all  $g \in G$ ,  $\alpha \in \text{Hom}_{\mathbb{R}}(V, V')$  and  $v \in V$ . Now, assume that there is a G-equivariant map  $\varphi: N \to \text{Hom}_{\mathbb{R}}(V, V')$  such that

<span id="page-13-1"></span>(19) 
$$
(f^*\omega')_z = \varphi(z) \circ \omega_z
$$

for each  $z \in N$ . Let  $x \in M$ ,  $y \in F(M)_x$  and  $p \in P_x$ . Denote the curve  $\Phi_{\tilde{X}}^t p \setminus (h \circ$  $\Phi_{\mathcal{F}(X)}^t(y)$  by  $\gamma$ . By Proposition [3.3,](#page-7-0) we get

(20) 
$$
p\setminus \mathcal{L}_{\tilde{X}}^{f^*\omega'}h(y) = f^*\omega'(\dot{\gamma}(0)) = \varphi(p\setminus h(y))(\omega(\dot{\gamma}(0))) = \varphi(p\setminus h(y))(p\setminus \mathcal{L}_{\tilde{X}}^{\omega}h(y)).
$$

Hence

<span id="page-13-2"></span>(21) 
$$
\mathcal{L}_{\tilde{X}}^{\omega'}((\mathrm{id}\underset{G}{\times}f)\circ h)(y)=\mathcal{L}_{\tilde{X}}^{f^*\omega'}h(y)=((\mathrm{id}\underset{G}{\times}\varphi)h(y))\left(\mathcal{L}_{X}^{\omega}h(y)\right),
$$

where we define an action of  $\Gamma(M, P \underset{G}{\times} \text{Hom}_{\mathbb{R}}(V, V'))$  on  $\Gamma(M, P \underset{G}{\times} V)$  by

$$
(\psi(s))(x) = [p, (p\backslash \psi(x))(p\backslash s(x))],
$$

for all  $\psi \in \Gamma(M, P \times \text{Hom}_{\mathbb{R}}(V, V'))$ ,  $s \in \Gamma(M, P \times V)$ ,  $x \in M$  and  $p \in P_x$ .

Next we give several examples of N, N',  $\omega$ ,  $\omega'$  and f for which there exists a map  $\varphi$  satisfying [\(19\)](#page-13-1).

Example 5.2. Take  $N = V$ ,  $N' = V'$ ,  $f: V \rightarrow V'$  a linear G-equivariant map,  $\omega = \text{pr}_2 \circ \text{vl}_V^{-1}$  and  $\omega' = \text{pr}_2 \circ \text{vl}_{V'}^{-1}$ . In this case  $f^*\omega' = f \circ \omega$ . Hence  $\varphi: V \to$  $\text{Hom}_{\mathbb{R}}(V, V')$  is the constant map that sends each  $v \in V$  into f and [\(21\)](#page-13-2) becomes

<span id="page-13-3"></span>(22) 
$$
\mathcal{L}_{\tilde{X}}((\mathrm{id} \underset{G}{\times} f) \circ h)(y) = (\mathrm{id} \underset{G}{\times} f)(\mathcal{L}_{\tilde{X}}h(y)).
$$

Example 5.3. Take  $N = G \times V$ ,  $N' = V$  and  $f: G \times V \rightarrow V$  to be the action of G on V. We equip N with the form  $\omega := \omega_{MC} \times (\text{pr}_2 \circ \text{vl}_V^{-1})$  and N' with the form  $\omega' := \text{pr}_2 \circ \text{vl}_V^{-1}$ . Fix  $g \in G$  and  $v \in V$ . Every element of  $T_{(g,v)}(G \times V)$  is of the form  $\frac{d}{dt}\Big|_0^{\infty}$   $(g \exp(at), v + ut)$  for suitable  $a \in \mathfrak{g}$  and  $u \in V$ . We get

<span id="page-14-0"></span>(23) 
$$
f^*\omega'\left(\frac{d}{dt}\bigg|_0(ge^{at}, v+ut)\right) = \text{pr}_2 \circ \text{vl}_V^{-1}\left(\frac{d}{dt}\bigg|_0 g e^{at}v + g e^{at}ut\right) = g(av) + gu = g(av+u).
$$

Notice that

$$
a = \frac{d}{dt}\bigg|_0 \exp(at) = (T_e L_g)^{-1} \frac{d}{dt}\bigg|_0 g \exp(at) = \omega_{MC} \left(\frac{d}{dt}\bigg|_0 g \exp(at)\right)
$$

and

$$
u = \operatorname{pr}_2 \circ \operatorname{vl}_V^{-1} \left( \frac{d}{dt} \bigg|_0 v + ut \right).
$$

Hence

(24) 
$$
(\omega_{MC} \times \text{pr}_2 \circ \text{vl}_V^{-1}) \left( \frac{d}{dt} \bigg|_0 (ge^{at}, v + ut) \right) = (a, u).
$$

Now [\(23\)](#page-14-0) and [\(24\)](#page-14-1) imply that for all  $(g, v) \in G \times V$ 

<span id="page-14-1"></span>
$$
(f^*\omega')_{(g,v)} = \varphi(g,v) \circ ((\omega_{MC})_g \times (\text{pr}_2 \circ \text{vl}_V^{-1})_v),
$$

where

<span id="page-14-2"></span>(25) 
$$
\varphi: G \times V \to \text{Hom}_{\mathbb{R}}(\mathfrak{g} \oplus V, V)
$$

$$
(g, v) \mapsto ((a, u) \mapsto g(av + u)).
$$

Example 5.4. Let  $H$  be a Lie group equipped with a left  $G$ -action by Lie automorphisms. Take  $N = H \times H$ ,  $N' = H$  and  $f: H \times H \rightarrow H$  the multiplication map. Write  $\omega_H$  for the Maurer-Cartan form on H. It is G-equivariant, since G acts on H by automorphisms. The Maurer-Cartan form on the direct product  $H \times H$ coincides with  $\omega_H \times \omega_H$ .

For  $h_1, h_2 \in H$  and  $a_1, a_2 \in \mathfrak{h} = T_e H$ , we have

$$
f^*\omega_H\left(\frac{d}{dt}\Big|_0 (h_1e^{a_1t}, h_2e^{a_2t})\right) = \omega_H\left(\frac{d}{dt}\Big|_0 h_1h_2h_2^{-1}e^{a_1t}h_2e^{a_2t}\right)
$$
  

$$
= \omega_H\left(\frac{d}{dt}\Big|_0 h_1h_2 \exp(\text{Ad}_{h_2^{-1}}(a_1t))e^{a_2t}\right)
$$
  

$$
= \frac{d}{dt}\Big|_0 \exp(\text{Ad}_{h_2^{-1}}(a_1)t)\exp(a_2t)
$$
  

$$
= \text{Ad}_{h_2^{-1}}(a_1) + a_2.
$$

<span id="page-15-2"></span>Hence  $(f^*\omega_H)_{h_1,h_2} = \varphi(h_1,h_2) \circ (\omega_H \times \omega_H)_{h_1,h_2}$ , where (26)  $\varphi: H \times H \to \text{Hom}_{\mathbb{R}}(\mathfrak{h} \oplus \mathfrak{h}, \mathfrak{h})$  $(h_1, h_2) \mapsto ((a_1, a_2) \mapsto \mathrm{Ad}_{h_2^{-1}}(a_1) + a_2).$ 

5.4. Synthesis. The aim of this section is to obtain rather general Lie-type formulas by combining the results already obtained in this section. We will treat the special cases in examples.

Let  $F_1, F_2$  be natural bundles and  $h_1: F_1(M) \to P \times N_1$ ,  $h_2: F_2(M) \to P \times N_2$ morphisms of fibred manifolds over M. Suppose  $\omega_1: \overset{G}{T}N_1 \rightarrow V_1, \ \omega_2: \overset{G}{T}N_2 \rightarrow V_2,$  $\omega: TN \to V$  are G-equivariant forms,  $f: N_1 \times N_2 \to N$  is a G-equivariant map, and  $\varphi: N_1 \times N_2 \to \text{Hom}_{\mathbb{R}}(V_1 \oplus V_2, V)$  is a smooth map such that

$$
(f^*\omega)_z = \varphi(z) \circ (\omega_1 \times \omega_2)_z.
$$

Let  $\eta: F \to F_1 \times F_2$  be a natural bundle map. Define

$$
h_1 \times_{f,\eta} h_2 \colon F(M) \to P \underset{G}{\times} N
$$

to be the composition  $(\mathrm{id} \underset{G}{\times} f) \circ (h_1 \times_M h_2) \circ \eta_M$ .

Fix  $y \in F(M)$ . Then  $\eta_M(y) = (y_1, y_2)$  for suitable  $y_1 \in F_1(M)$ ,  $y_2 \in F_2(M)$ . Using  $(14)$  and  $(21)$ , we get (27)

<span id="page-15-1"></span>
$$
\mathcal{L}_{\tilde{X}}^{\omega}(h_1 \times_{f,\eta} h_2)(y) = \mathcal{L}_{\tilde{X}}^{\omega}((\mathrm{id} \times f) \circ (h_1 \times_M h_2) \circ \eta_M)(y)
$$
  
\n
$$
= \mathcal{L}_{\tilde{X}}^{\omega}((\mathrm{id} \times f) \circ (h_1 \times_M h_2))(y_1, y_2)
$$
  
\n
$$
= (\mathrm{id} \times \varphi)((h_1 \times_M h_2)(y_1, y_2))(\mathcal{L}_{\tilde{X}}^{\omega_1 \times \omega_2}(h_1 \times_M h_2)(y_1, y_2)).
$$

By definition of  $h_1 \times_M h_2$ , we have

$$
(h_1 \times_M h_2)(y_1, y_2) = [p, (p \backslash h_1(y_1), p \backslash h_2(y_2))].
$$

Hence

$$
(\mathrm{id} \underset{G}{\times} \varphi)((h_1 \times_M h_2)(y_1, y_2)) = [p, \varphi(p \backslash h_1(y_1), p \backslash h_2(y_2))].
$$

By  $(15)$ , we have

$$
\pounds_{\widetilde{X}}^{\omega_1 \times \omega_2}(h_1 \times_M h_2)(y_1, y_2) = [p, (p \backslash \pounds_{\widetilde{X}}^{\omega_1} h_1(y_1), p \backslash \pounds_{\widetilde{X}}^{\omega_2} h_2(y_2))].
$$

Thence [\(27\)](#page-15-1) becomes

<span id="page-15-0"></span>(28) 
$$
\mathcal{L}_{\tilde{X}}^{\omega}(h_1 \times_{f,\eta} h_2)(y) = [p, \varphi(p \setminus h_1(y_1), p \setminus h_2(y_2)) (p \setminus \mathcal{L}_{\tilde{X}}^{\omega_1} h_1(y_1), p \setminus \mathcal{L}_{\tilde{X}}^{\omega_2} h_2(y_2))].
$$

*Example* 5.5. Suppose  $s \in \Gamma(M, P \times_c G)$  and  $\beta: F(M) \to P \times V$ , where V is a G-module. We define  $\eta_M \colon F(M) \to M \times_M F(M)$  to be  $Z \mapsto (x, Z)$  for every  $x \in M$  and  $Z \in F(M)_x$ . Write f for the action map  $G \times V \to V$ . Then  $s \cdot \beta$  defined at the beginning of the section coincides with  $s \times_{f,\eta} \beta$ . Taking  $\varphi$  defined by [\(25\)](#page-14-2) and applying [\(28\)](#page-15-0), we get for  $x \in M$ ,  $p \in P_x$  and  $Z \in T_xM$ 

<span id="page-16-1"></span>
$$
p \backslash \pounds_{\widetilde{X}}(s \cdot \beta)(Z) = \varphi(p \backslash s(x), p \backslash \beta(Z))(p \backslash \pounds_{\widetilde{X}}s(x), p \backslash \pounds_{\widetilde{X}}\beta(Z))
$$
  
= 
$$
(p \backslash s(x)) ((p \backslash \pounds_{\widetilde{X}}s(x))(p \backslash \beta(Z)) + p \backslash \pounds_{\widetilde{X}}\beta(Z)).
$$

Hence

(29) 
$$
\mathcal{L}_{\widetilde{X}}(s \cdot \beta) = s \cdot (\mathcal{L}_{\widetilde{X}} s \cdot \beta + \mathcal{L}_{\widetilde{X}} \beta).
$$

*Example* 5.6. Now let  $s_1, s_2 \in \Gamma(M, P \times_c G)$ . Notice that the multiplication map  $\mu_G: {}_cG \times {}_cG \to {}_cG$  is G-equivariant. Define  $\eta_M: M \to M \times_M M$  by  $\eta_M(x) = (x, x)$ . We write  $s_1 \cdot s_2$  for  $s_1 \times_{\mu_G, \eta} s_2$ . Taking  $\varphi$  defined by [\(26\)](#page-15-2) and applying [\(28\)](#page-15-0), we get for all  $x \in M$  and  $p \in P_x$ ,

<span id="page-16-0"></span>
$$
p \backslash \pounds_{\widetilde{X}}(s_1 \cdot s_2)(x) = \varphi(p \backslash s_1(x), p \backslash s_2(x))(p \backslash \pounds_{\widetilde{X}} s_1(x), p \backslash \pounds_{\widetilde{X}} s_2(x))
$$
  
= Ad<sub>(p \backslash s\_2(x))^{-1}</sub>  $(p \backslash \pounds_{\widetilde{X}} s_1(x)) + (p \backslash \pounds_{\widetilde{X}} s_2(x)).$ 

Thus with appropriate definitions for  $s_2^{-1}$  and  $Ad_{s_2^{-1}}$ , we get

(30) 
$$
\pounds_{\widetilde{X}}(s_1 \cdot s_2) = \mathrm{Ad}_{s_2^{-1}}\left(\pounds_{\widetilde{X}} s_1\right) + \pounds_{\widetilde{X}} s_2.
$$

Now we turn our attention to the Leibniz rule involving tensor product. Let  $E_1, E_2$  be natural vector bundles and  $h_1: E_1(M) \to P \times V_1$ ,  $h_2: E_2(M) \to P \times V_2$ morphisms of vector bundles,  $f: V_1 \otimes V_2 \to V$  a homomorphism of G-modules, and  $\eta: E \to E_1 \otimes E_2$  a natural transformation of natural vector bundles. Write  $h_1 \otimes_{f,\eta} h_2$  for the composition  $(\mathrm{id} \underset{G}{\times} f) \circ (h_1 \otimes h_2) \circ \eta_M$ .

Fix  $x \in M$ ,  $y \in E(M)_x$ , and  $p \in P_x$ . Then  $\eta_M(y)$  can be written as  $\sum_{i \in I} y_{1,i} \otimes y_{2,i}$ for suitable elements  $y_{1,i} \in E_1(M)_x$  and  $y_{2,i} \in E_2(M)_x$ . Using [\(14\)](#page-11-2) and [\(22\)](#page-13-3), we get

$$
\mathcal{L}_{\tilde{X}}(h_1 \otimes_{f,\eta} h_2)(y) = \mathcal{L}_{\tilde{X}}((\mathrm{id} \times f) \circ (h_1 \otimes h_2) \circ \eta_M)(y)
$$

$$
= \mathcal{L}_{\tilde{X}}((\mathrm{id} \times f) \circ (h_1 \otimes h_2)) (\eta_M(y))
$$

$$
= (\mathrm{id} \times f) (\mathcal{L}_{\tilde{X}}(h_1 \otimes h_2) (\eta_M(y))).
$$

Applying [\(16\)](#page-12-1), we get

$$
p\backslash \mathcal{L}_{\widetilde{X}}(h_1 \otimes h_2) (\eta_M(y)) = \sum_{i \in I} (p\backslash \mathcal{L}_{\widetilde{X}}h_1(y_{1,i}) \otimes p\backslash h_2(y_{2,i}) + p\backslash h_1(y_{1,i}) \otimes p\backslash \mathcal{L}_{\widetilde{X}}h_2(y_{2,i})).
$$

Thence

<span id="page-17-0"></span>(31)  

$$
\mathcal{L}_{\tilde{X}}(h_1 \otimes_{f,\eta} h_2)(y) = \sum_{i \in I} [p, f(p \setminus \mathcal{L}_{\tilde{X}} h_1(y_{1,i}) \otimes p \setminus h_2(y_{2,i}))] + [p, f(p \setminus h_1(y_{1,i}) \otimes p \setminus \mathcal{L}_{\tilde{X}} h_2(y_{2,i}))].
$$

*Example* 5.7. Let  $\alpha \in \Omega^1(M, P \times \mathfrak{g})$  and  $\beta \in \Omega^1(M, P \times V)$ , where V is a G-module. Define  $\alpha \wedge \beta \in \Omega^2(M, P \times V)$  by

$$
(\alpha \wedge \beta)(Z_1, Z_2) = \alpha(Z_1) \cdot \beta(Z_2) - \alpha(Z_2) \cdot \beta(Z_1).
$$

Alternatively, it can be written as the composition  $(id \times f) \circ (\alpha \otimes \beta) \circ \eta_M$ , where

$$
\eta_M \colon \Lambda^2 TM \to TM \otimes TM
$$
  

$$
Z_1 \wedge Z_2 \mapsto Z_1 \otimes Z_2 - Z_2 \otimes Z_1
$$

and  $f: \mathfrak{g} \otimes V \to V$  is the action of  $\mathfrak{g}$  on V. Notice that f is G-equivariant. Thence  $\alpha \wedge \beta = \alpha \otimes_{f,\eta} \beta$ . Applying [\(31\)](#page-17-0), we get

$$
p\lambda \mathcal{L}_{\tilde{X}}(\alpha \wedge \beta)(Z_1, Z_2) = (p\lambda \mathcal{L}_{\tilde{X}}\alpha(Z_1))(p\lambda \beta(Z_2)) + (p\lambda \alpha(Z_1))(p\lambda \mathcal{L}_{\tilde{X}}\beta(Z_2)) - (p\lambda \mathcal{L}_{\tilde{X}}\alpha(Z_2))(p\lambda \beta(Z_1)) - (p\lambda \alpha(Z_2))(p\lambda \mathcal{L}_{\tilde{X}}\beta(Z_1)).
$$

Hence

(32) 
$$
\mathcal{L}_{\tilde{X}}(\alpha \wedge \beta) = \mathcal{L}_{\tilde{X}}\alpha \wedge \beta + \alpha \wedge \mathcal{L}_{\tilde{X}}\beta.
$$

Remark 5.8. More generally we can take  $\alpha \in \Omega^k(M, P \underset{G}{\times} \mathfrak{g})$  and  $\beta \in \Omega^{\ell}(M, P \underset{G}{\times} V)$ . Then  $\alpha \wedge \beta$  can be defined as  $\alpha \otimes_{f,\eta} \beta$ , where f is the same as above and

$$
\eta_M\colon \Lambda^{k+\ell}TM \to \Lambda^kTM \otimes \Lambda^{\ell}TM
$$
  

$$
Z_1 \wedge \cdots \wedge Z_{k+\ell} \mapsto \sum_{\sigma \in Sh_{k,\ell}} (-1)^{\sigma} Z_{\sigma(1)} \wedge \cdots \wedge Z_{\sigma(k)} \otimes Z_{\sigma(k+1)} \wedge \cdots \wedge Z_{\sigma(k+\ell)},
$$

where  $\text{Sh}_{k,l}$  is the set of all  $(k, \ell)$ -shuffles. As expected, for every  $X \in \mathfrak{X}(P)^G$  one gets

<span id="page-17-1"></span>(33) 
$$
\pounds_X(\alpha \wedge \beta) = \pounds_X \alpha \wedge \beta + \alpha \wedge \pounds_X \beta.
$$

## <span id="page-17-2"></span>6. Cartan magic formula

Suppose  $\nabla$  is a covariant derivative on a vector bundle E Then the exterior covariant derivative  $d^{\nabla}$  of  $\beta \in \Omega^k(M, E)$  is given by

$$
d^{\nabla}\beta(X_0,\ldots,X_k) := \sum_{j=0}^k (-1)^j \nabla_{X_j}(\beta(X_0,\ldots,\widehat{X}_j,\ldots,X_k)) + \sum_{i
$$

In the special case when  $\nabla$  is a covariant derivative on  $P \times V$  induced by a  $G$ principal connection on  $P$ , we get

$$
\nabla_{X_j}(\beta(X_0,\ldots,\widehat{X}_j,\ldots,X_k)) = \pounds_{X_j^H}(\beta(X_0,\ldots,\widehat{X}_j,\ldots,X_k)),
$$

where  $X_j^H$  is the horizontal lift of  $X_j$  to P. Indeed, let  $s \in \Gamma(M, P \times V)$ . Then

$$
\mathcal{L}_{X^H}(s)(x) = \mathcal{L}_{(X,X_V^H)}(s)(x) = \text{pr}_2 \circ \text{vl}_V^{-1} \left( \frac{d}{dt} \bigg|_{t=0} \Phi_{X_V^H}^{-t} \circ s \circ \Phi_X^t(x) \right)
$$

$$
= (\nabla_X s)(x),
$$

since  $X_V^H$  is the horizontal lift of X to  $P \underset{G}{\times} V$ . Hence

<span id="page-18-0"></span>(34)  

$$
d^{\nabla}\beta(X_0,\ldots,X_k) = \sum_{j=0}^k (-1)^j \pounds_{X_j^H}(\beta(X_0,\ldots,\widehat{X}_j,\ldots,X_k)) + \sum_{i < j} (-1)^{i+j} \beta([X_i,X_j],X_0,\ldots,\widehat{X}_i,\ldots,\widehat{X}_j,\ldots,X_k).
$$

Let  $Y_1, \ldots, Y_k$  and Z be vector fields on M. The section  $\beta(Y_1, \ldots, Y_k)$  of  $P \underset{G}{\times} V$ is the composition of  $\wedge_{j=1}^k Y_j$ :  $M \to \wedge^k TM$  and  $\beta$ :  $\wedge^k TM \to P \underset{G}{\times} V$ . Write  $\overline{Z}$  for the canonical lift of Z to  $\wedge^k TM$ . Applying Proposition [5.1,](#page-10-1) we get

$$
\tilde{\mathcal{L}}_{Z^H}(\beta \circ \wedge_{j=1}^k Y_j) = T\beta \circ \tilde{\mathcal{L}}_{(Z,\widetilde{Z})}(\wedge_{j=1}^k Y_j) + (\tilde{\mathcal{L}}_{(\widetilde{Z},Z^H_V)}\beta) \circ \wedge_{j=1}^k Y_j.
$$

Applying id  $\underset{G}{\times}$  (pr<sub>2</sub> ∘ vl<sub>V</sub><sup>-1</sup>) to both sides, we get

$$
\mathcal{L}_{Z^H}(\beta \circ \wedge_{j=1}^k Y_j) = \beta \circ \mathcal{L}_{(Z,\widetilde{Z})}(\wedge_{j=1}^k Y_j) + (\mathcal{L}_{(\widetilde{Z},Z^H_V)}\beta) \circ \wedge_{j=1}^k Y_j.
$$

Now  $\mathcal{L}_{(Z,\widetilde{Z})}$  is the usual Lie derivative  $\mathcal{L}_Z$  of tensor fields and  $\mathcal{L}_{(\widetilde{Z},Z_V^H)}$  was abbreviated as  $\mathcal{L}_{Z^H}$ . Hence

(35)  

$$
\pounds_{Z^H}(\beta \circ \wedge_{j=1}^k Y_j) = \beta \circ \mathcal{L}_Z(\wedge_{j=1}^k Y_j) + (\pounds_{Z^H} \beta) \circ \wedge_{j=1}^k Y_j
$$

$$
= \sum_{j=1}^k \beta(Y_1, \dots, [Z, Y_j], \dots, Y_k) + \pounds_{Z^H} \beta(Y_1, \dots, Y_k).
$$

Taking  $X_0 = Z$  and  $X_i = Y_i$  for  $1 \leq i \leq k$  in [\(34\)](#page-18-0), we get

$$
i_{Z}d^{\nabla}\beta(Y_{1},...,Y_{k}) = \pounds_{Z^{H}}(\beta(Y_{1},...,Y_{k})) - \sum_{j=1}^{k} (-1)^{j-1} \pounds_{Y_{j}^{H}}(\beta(Z, Y_{1},..., \widehat{Y}_{j},...,Y_{k}))
$$
  
+ 
$$
\sum_{j=1}^{k} (-1)^{j} \beta([Z, Y_{j}], Y_{1},..., \widehat{Y}_{j},..., k)
$$
  
- 
$$
\sum_{i < j} (-1)^{i+j} \beta(Z, [Y_{i}, Y_{j}], Y_{1},..., \widehat{Y}_{i},..., \widehat{Y}_{j},..., Y_{k})
$$
  
= 
$$
(\pounds_{Z^{H}} \beta)(Y_{1},..., Y_{k}) - d^{\nabla}(i_{Z} \beta)(Y_{1},..., Y_{k}).
$$

Hence we obtain the Cartan magic formula

(36) 
$$
\mathcal{L}_{Z^H}\beta = i_Z(d^{\nabla}\beta) + d^{\nabla}(i_Z\beta).
$$

It is common to define the covariant-Lie derivative  $\mathcal{L}_Z^{\nabla} \beta$  to be  $i_Z(d^{\nabla} \beta) + d^{\nabla}(i_Z \beta)$ (cf. [\[4,](#page-20-6) p. 352]). Thus  $\mathcal{L}_{Z}^{\nabla} \beta = \mathcal{L}_{Z^H} \beta$ . Inspired by this fact, we define the *covariant*-Darboux-Lie derivative  $\mathcal{L}_Z^{\omega, \nabla} h$  with  $Z \in \mathfrak{X}(M)$ ,  $h \colon F(M) \to P \underset{G}{\times} N$  and  $\omega \in$  $\Omega^1(N, V)^G$  as  $\mathcal{L}_{ZH}^{\omega}h$ . With this definition, for all  $s, s' \in \Gamma(M, P \underset{G}{\times} c)$ ,  $\alpha \in$  $\Omega^k(M, P \underset{G}{\times} \mathfrak{g})$  and  $\beta \in \Omega^{\ell}(M, P \underset{G}{\times} V)$  one gets from [\(30\)](#page-16-0), [\(29\)](#page-16-1), [\(33\)](#page-17-2)

(37) 
$$
\mathcal{L}_Z^{\nabla}(s' \cdot s) = \mathrm{Ad}_{s^{-1}}(\mathcal{L}_Z^{\nabla} s') + \mathcal{L}_Z^{\nabla} s
$$

(38) 
$$
\mathcal{L}_Z^{\nabla}(s \cdot \beta) = s(\mathcal{L}_Z^{\nabla} s \cdot \beta + \mathcal{L}_Z^{\nabla} \beta)
$$

(39) 
$$
\mathcal{L}_Z^{\nabla}(\alpha \wedge \beta) = \mathcal{L}_Z^{\nabla} \alpha \wedge \beta + \alpha \wedge \mathcal{L}_Z^{\nabla} \beta.
$$

Applying results of Section [4,](#page-8-0) we can compare covariant-Darboux-Lie derivatives computed with respect to different connections. Suppose  $\hat{\nabla}$  is another covariant derivative on  $P \times V$  that corresponds to a G-principal connection on P. Write  $X^{\widetilde{H}}$  for the horizontal lift of a vector field on M with respect to  $\widetilde{\nabla}$ . Then there is a unique section  $a \in \Gamma(M, P \underset{G}{\times} \mathfrak{g})$  such that  $X^H - X^{\widetilde{H}} = X^a$ . If V is a G-module and  $h: F(M) \to P \underset{G}{\times} V$  is a vector bundle map, Proposition [4.1](#page-8-1) implies that

(40) 
$$
\mathcal{L}_X^{\nabla} h - \mathcal{L}_X^{\nabla} h = -a \cdot h.
$$

If  $h: F(M) \to P \underset{G}{\times} _c G$  is a fiber-bundle map, Proposition [4.2](#page-9-0) implies that

(41) 
$$
\mathcal{L}_X^{\nabla} h - \mathcal{L}_X^{\tilde{\nabla}} h = a \circ p_M - \mathrm{Ad}_{h^{-1}}(a),
$$

where  $p_M : F(M) \to M$  is the projection of the fiber bundle  $F(M)$ .
