ABSTRACT. In this paper we study biconservative hypersurfaces M in space forms $\overline{M}^{n+1}(c)$ with four distinct principal curvatures whose second fundamental form has constant norm. We prove that every such hypersurface has constant mean curvature and constant scalar curvature.

1. Introduction

In the last three decades, one of the interesting research topics in Differential Geometry is the study of biharmonic maps, in particular, biharmonic immersions, between Riemannian manifolds. A generalization of harmonic maps, proposed in 1964 by Eells and Sampson [\[7\]](#page-15-0), these maps are critical points of the bienergy functional, obtained by integrating the squared norm of the tension field, and are characterized by the vanishing of the bitension field. Another interesting research direction, derived from here, is the study of biconservative submanifolds, i.e., those submanifolds for which only the tangent part of the bitension field vanishes.

In 1924, Hilbert pointed that the stress-energy tensor associated to a functional E , is a conservative symmetric 2-covariant tensor S at the critical points of E, i.e. div $S = 0$ ([\[17\]](#page-15-1)). For the bienergy functional E_2 , Jiang defined the stress-bienergy tensor S_2 and proved that it satisfies div $S_2 = -\langle \tau_2(\phi), d\phi \rangle$ ([\[18\]](#page-16-0)). Thus, if ϕ is biharmonic, then $\text{div } S_2 = 0$. For biharmonic submanifolds, from the above relation, we see that $\text{div } S_2 = 0$ if and only if the tangent part of the bitension field vanishes. In particular, an isometric immersion $\phi: (M, g) \to (N, h)$ is called biconservative if div $S_2 = 0$.

In a different setting, B. Y. Chen defined $\text{biharmonic submanifolds } M$ of the Euclidean space as those with harmonic mean curvature vector field, that is $\Delta H = 0$, where Δ is the Laplacian operator. If we apply the definition of biharmonic maps to Riemannian immersions into the Euclidean space, we recover Chen's notion of biharmonic submanifolds. Thus biharmonic Riemannian immersions can also be thought of as a generalization of Chen's biharmonic submanifolds. The biha[r](#page-0-0)monic submanifolds were studied in [\[1,](#page-15-2) [3,](#page-15-3) [4,](#page-15-4) [5,](#page-15-5) [6,](#page-15-6) [11,](#page-15-7) [12,](#page-15-8) [13,](#page-15-9) [23\]](#page-16-1) and references therein.

The biconservative submanifolds were studied and classified in \mathbb{E}^3 and \mathbb{E}^4 by Hasanis andVlachos $([16])$ $([16])$ $([16])$, in which the biconservative hypersurfaces were called H -hypersurfaces. The terminology "biconservative" was first introduced in [\[2\]](#page-15-11). The classification of Hhypersurfaces with three distinct curvatures in Euclidean space of arbitrary dimension were obtained by Turgay in [\[24\]](#page-16-2). The classification of biconservative hypersurfaces in \mathbb{E}_2^5 with diagonal shape operator having three distinct principal curvatures was obtained by Upadhyay and Turgay in [\[26\]](#page-16-3). Also, the first author and Sharfuddin proved that every

biconservative Lorentz hypersurface in \mathbb{E}_1^{n+1} with complex eigenvalues has constant mean curvature([\[15\]](#page-15-12)). For more work on biconservative hypersurfaces in pseudo-Euclidean spaces, please see([\[26,](#page-16-3) [15\]](#page-15-12)) and references therein.

The constant mean curvature (CMC) biconservative surfaces in $\mathbb{S}^n \times \mathbb{R}$ and $\mathbb{H}^n \times \mathbb{R}$ were studied in [\[9\]](#page-15-13) by Fetcu et al. A complete classification of CMC biconservative surfaces in a four-dimensional space form was given in [\[21\]](#page-16-4) by Montaldo et al. Further, the classification of biconservative hypersurfaces in \mathbb{S}^4 and \mathbb{H}^4 was obtained in [\[25\]](#page-16-5) by Turgay and Upadhyay. A survey about biharmonic and biconservative hypersurfaces in space forms is provided in [\[10\]](#page-15-14) by Fetcu et al. In [\[14\]](#page-15-15) the first author studied the biconservative hypersurfaces in Euclidean 5-space with constant norm of second fundamental form and one of the results states that every such hypersurface has constant mean curvature. Finally, some recent results on complete biconservative surfaces and on closed biconservative surfaces in space forms was obtained by Nistor and Oniciuc([\[20\]](#page-16-6)) and Montaldo and by Pampano([\[22\]](#page-16-7)).

In view of the above developments, in the present paper we study biconservative hypersurfaces in a space form $\overline{M}^{n+1}(c)$ with at most four distinct principal curvatures, whose second fundamental form has constant norm. The main result is the following:

Theorem 1.1. Every biconservative hypersurface M in a space form $\overline{M}^{n+1}(c)$ with at most four distinct principal curvatures, whose second fundamental form has constant norm, is of constant mean curvature and of constant scalar curvature.

Also, the class of biconservative hypersurface in space forms contains some other class of hypersurfaces, that is, the equation (2.5) is fulfilled by a biharmonic submanifold $\Delta \vec{H} = 0$ and a hypersurface with $\Delta \vec{H} = \lambda \vec{H}$ [\[3\]](#page-15-3).

Therefore, from Theorem 1.1, we have following:

Corollary 1.2. Every biharmonic hypersurface M in a space form $\overline{M}^{n+1}(c)$ with at most four distinct principal curvatures, whose second fundamental form has constant norm, is of constant mean curvature and of constant scalar curvature.

Corollary 1.3. Every hypersurface M in a space form $\overline{M}^{n+1}(c)$ satisfying $\Delta \vec{H} = \lambda \vec{H}$ with at most four distinct principal curvatures, whose second fundamental form has constant norm, is of constant mean curvature and of constant scalar curvature.

The paper is organized as follows: In Section 2 we give some preliminaries. In Section 3 we discuss biconservative hypersurfaces in space forms with four distinct principal curvatures. We obtain some condition for eigenvalues (Lemma 3.1) and expressions of covariant derivatives of an orthonormal frame in terms of connection forms (Lemma 3.2). In Section 4 we use the condition that the second fundamental form has constant norm, and obtain further simplifications of the connection forms (Lemmas 4.1 and 4.2). Section 5 is devoted to the proof of Theorem 1.1. In the process, a technical tool about resultant of polynomials is extensively used (Lemma 2.1).

Finally, we would like to note that Lemma [4.1](#page-5-0) is crucial to obtain our results in the case of at most four distinct principal curvatures. In case of more than four distinct principal curvatures, it seems difficult to obtain an analogue of this lemma. We may discuss this in a separate paper.

2. Preliminaries

Let (M, g) be a hypersurface isometrically immersed in a $(n + 1)$ -dimensional space form $(\overline{M}^{n+1}(c), \overline{g})$ and $g = \overline{g}_{|M}$. We denote by ξ a unit normal vector to M where $\overline{q}(\xi, \xi) = 1$, and by h and A the second fundamental form and the shape operator of M, where $h(X, Y) = g(\mathcal{A}(X), Y)$, for $X, Y \in \Gamma(TM)$.

The mean curvature H of M is given by

Let ∇ denotes the Levi-Civita connection on M. Then, the Gauss and Codazzi equations are given by

respectively, where R is the curvature tensor and

(2.4)

(\nabla_X \mathcal{A})Y = \nabla_X \mathcal{A}Y - \mathcal{A}(\nabla_X Y)
$$

for all $X, Y, Z \in \Gamma(TM)$.

A submanifold satisfying $\Delta \vec{H} = 0$, is called *biharmonic submanifold* ([\[3\]](#page-15-3)). The biharmonic equation for M^n in a $(n+1)$ -dimensional space form $\overline{M}^{n+1}(c)$ can be decomposed into its normal and tangent part([\[3\]](#page-15-3), [\[8\]](#page-15-16)), that is

Definition 2.1. A submanifold satisfying equation [\(2.5\)](#page-2-0) is called biconservative.

In the present work we are concerned with biconservative hypersurfaces M^n in a $(n+1)$ dimensional space form $\overline{M}^{n+1}(c)$.

The following algebraic lemma will be useful to get our result:

Lemma 2.1. ([\[19,](#page-16-8) Theorem 4.4, pp. 58–59]) Let D be a unique factorization domain, and let $f(X) = a_0 X^m + a_1 X^{m-1} + \cdots + a_m$, $q(X) = b_0 X^n + b_1 X^{n-1} + \cdots + b_n$ be two polynomials in $D[X]$. Assume that the leading coefficients a_0 and b_0 of $f(X)$ and $g(X)$ are not both zero. Then $f(X)$ and $g(X)$ have a nonconstant common factor iff the resultant $\Re(f, q)$ of f and g is zero, where

\Re(f,g) = \begin{vmatrix} a_0 & a_1 & a_2 & \cdots & a_m \\ a_0 & a_1 & \cdots & \cdots & a_m \\ & \ddots & \ddots & \ddots & \ddots & \ddots \\ a_0 & a_1 & a_2 & \cdots & a_m \\ b_0 & b_1 & b_2 & \cdots & b_n \\ & b_0 & b_1 & \cdots & \cdots & b_n \\ & \ddots & \ddots & \ddots & \ddots & \ddots \\ & & b_0 & b_1 & b_2 & \cdots & b_n \end{vmatrix},
$$

and there are n rows of "a" entries and m rows of "b" entries.

3. Biconservative hypersurfaces in space forms with four distinct principal curvatures

In this section, we study biconservative hypersurfaces with four distinct principal curvatures in space forms. In view of [\(2.5\)](#page-2-0), it is easy to see that any CMC hypersurface is biconservative. Therefore, we are interested in the study of non CMC biconservative hypersurfaces in a space form $\overline{M}^{n+1}(c)$.

We assume that the mean curvature is not constant, and we will end up to a contradiction. This implies that grad $H \neq 0$, hence there exists an open connected subset U of M^n with $\text{grad}_x H \neq 0$, for all $x \in U$. From [\(2.5\)](#page-2-0), it is easy to see that grad H is an eigenvector of the shape operator A with the corresponding principal curvature $-\frac{nH}{2}$ $\frac{H}{2}$.

We denote by A, B , the following sets

A = \{1, 2, \dots, n\}, \quad B = \{2, 3, \dots, n\}.
$$

Without losing generality, we choose e_1 in the direction of grad H. Then, the shape operator A of a hypersurface M^n in a space form $\overline{M}^{n+1}(c)$ takes the following form with respect to a suitable orthonormal frame $\{e_1, e_2, \ldots, e_n\}$,

$$

where λ_i is the eigenvalue corresponding to the eigenvector e_i of the shape operator.

Then grad H can be expressed as

(3.2)

\operatorname{grad} H = \sum_{i=1}^{n} e_i(H)e_i.
$$

As we have taken e_1 parallel to grad H, it follows that

(3.3)

e_1(H) \neq 0, \quad e_i(H) = 0, \quad i \in B.
$$

We express

\nabla_{e_i} e_j = \sum_{m=1}^n \omega_{ij}^m e_m, \quad i, j \in A.
$$

From [\(3.4\)](#page-3-0) and using the compatibility conditions $(\nabla_{e_k} g)(e_i, e_i) = 0$ and $(\nabla_{e_k} g)(e_i, e_j) =$ 0, we obtain

\omega_{ki}^i = 0, \qquad \omega_{ki}^j + \omega_{kj}^i = 0,
$$

for $i \neq j$, and $i, j, k \in A$.

Taking $X = e_i, Y = e_j$ in [\(2.4\)](#page-2-1) and using [\(3.1\)](#page-3-1), [\(3.4\)](#page-3-0), we get

(\nabla_{e_i} \mathcal{A}) e_j = e_i(\lambda_j) e_j + \sum_{k=1}^n \omega_{ij}^k e_k(\lambda_j - \lambda_k).
$$

Putting the value of $(\nabla_{e_i} \mathcal{A})e_j$ in [\(2.3\)](#page-2-2), we find

e_i(\lambda_j)e_j + \sum_{k=1}^n \omega_{ij}^k e_k(\lambda_j - \lambda_k) = e_j(\lambda_i)e_i + \sum_{k=1}^n \omega_{ji}^k e_k(\lambda_i - \lambda_k).
$$

Using $i \neq j = k$ and $i \neq j \neq k$ in the above equation, we obtain

e_i(\lambda_j) = (\lambda_i - \lambda_j)\omega_{ji}^j = (\lambda_j - \lambda_i)\omega_{jj}^i,
$$

and

(3.7)

(\lambda_i - \lambda_j)\omega_{ki}^j = (\lambda_k - \lambda_j)\omega_{ik}^j,
$$

respectively, for $i, j, k \in A$.

Now, we have

Lemma 3.1. Let M^n be a biconservative hypersurface in a space form $\overline{M}^{n+1}(c)$ having the shape operator given by [\(3](#page-3-1).1) with respect to a suitable orthonormal frame $\{e_1, e_2, \ldots, e_n\}$. Then,

\lambda_1 \neq \lambda_j, \text{ for all } j \in B.
$$

Proof. Assume that $\lambda_i = \lambda_1$ for some $j \neq 1$. Then, from [\(3.6\)](#page-3-2) we get that

e_1(\lambda_j) = 0

, or $e_1(H) = 0$, since $\lambda_1 = -\frac{nH}{2}$,

which contradicts (3.3) , and this completes the proof.

Therefore, in view of the Lemma 3.1, $\lambda_1 = -\frac{n}{2}H$ has multiplicity one. Since M has four distinct principal curvatures, we can assume that $\lambda_1, \lambda_u, \lambda_v$ and λ_w are the four distinct principal curvatures of the hypersurface M with multiplicities 1, p , q and r respectively, such that

\lambda_2 = \lambda_3 = \dots = \lambda_{p+1} = \lambda_u, \ u \in C_1,
$$

\lambda_{p+2} = \lambda_{p+3} = \dots = \lambda_{p+q+1} = \lambda_v, \ v \in C_2,
$$

\lambda_{p+q+2} = \lambda_{p+q+3} = \dots = \lambda_{p+q+r+1} = \lambda_w, \ w \in C_3.
$$

Here $p + q + r + 1 = n$ and C_1, C_2 and C_3 denote the sets

 $C_1 = \{2, 3, \ldots, p+1\}, \quad C_2 = \{p+2, p+3, \ldots, p+q+1\}, \quad C_3 = \{p+q+2, p+q+3, \ldots, n\}.$ Using (2.1) and (3.1) , we obtain that

(3.9)

\sum_{j=2}^{n} \lambda_j = p\lambda_u + q\lambda_v + r\lambda_w = \frac{3n}{2}H = -3\lambda_1, \ u \in C_1, \ v \in C_2, \ w \in C_3.
$$

Next, we have

Lemma 3.2. Let M^n be a biconservative hypersurface with four distinct principal curvatures in a space form $\overline{M}^{n+1}(c)$ having the shape operator given by [\(3](#page-3-1).1) with respect to a suitable orthonormal frame $\{e_1, e_2, \ldots, e_n\}$. Then the following relations are satisfied:

\nabla_{e_1} e_1 = 0, \quad \nabla_{e_1} e_i = \sum_{C_s} \omega_{1i}^m e_m \text{ for all } i \in C_s, \ s \in \{1, 2, 3\}, \quad m \neq i,
$$

$$
\nabla_{e_i} e_1 = -\omega_{ii}^1 e_i \text{ for all } i \in B, \quad \nabla_{e_i} e_i = \sum_{m=1}^n \omega_{ii}^m e_m \text{ for all } i \in B, \quad m \neq i,
$$
\n
$$
\nabla_{e_i} e_i = \sum \omega_{ii}^m e_m \text{ for all } i, j \in C_s, \quad s \in \{1, 2, 3\}, \quad i \neq j, \quad j \neq m.
$$

$$
\nabla_{e_i} e_j = \sum_{C_s} \omega_{ij}^m e_m \text{ for all } i, j \in C_s, s \in \{1, 2, 3\}, \quad i \neq j, \quad j \neq m,
$$

$$
\nabla_{e_i} e_j = \omega_{ij}^i e_i + \sum_{B \backslash C_s} \omega_{ij}^m e_m \text{ for all } i \in C_s, \quad j \in B \setminus C_s, \ s \in \{1, 2, 3\}, \quad m \neq j,
$$

where \sum_{C_s} and $\sum_{B \backslash C_s}$ denote the summation taken over the corresponding C_s and $B \backslash C_s,$ respectively for $s \in \{1, 2, 3\}$, and ω_{ij}^i satisfy (3.[5\)](#page-3-4) and (3.[6\)](#page-3-2).

Proof. Using [\(3.3\)](#page-3-3), [\(3.4\)](#page-3-0) and the fact that $[e_i e_j](H) = 0 = \nabla_{e_i} e_j(H) - \nabla_{e_j} e_i(H) =$ $\omega_{ij}^1 e_1(H) - \omega_{ji}^1 e_1(H)$, for $i \neq j$, we find that

\omega_{ij}^1 = \omega_{ji}^1, \quad i, j \in B.
$$

Putting $i \neq 1$, $j = 1$ in [\(3.6\)](#page-3-2) and using [\(3.5\)](#page-3-4) and [\(3.3\)](#page-3-3), we find

$$

Putting $i = 1$ in [\(3.7\)](#page-3-5), we obtain

\omega_{k1}^j = 0, \quad j \neq k \quad \text{and} \quad j, k \in C_s, \ s \in \{1, 2, 3\}.
$$

Taking $i \in C_s$, $s \in \{1, 2, 3\}$ in [\(3.7\)](#page-3-5), we have

\omega_{ki}^j = 0, \quad j \neq k \quad \text{and} \quad j, k \in B \setminus C_s.
$$

Putting $j = 1$ in [\(3.7\)](#page-3-5) and using [\(3.10\)](#page-4-0), we get

(3.14)

\omega_{ki}^1 = \omega_{ik}^1 = 0, \quad i \in C_s, \quad k \in B \setminus C_s, \ s \in \{1, 2, 3\}.
$$

Putting $i = 1$ in [\(3.7\)](#page-3-5) and using [\(3.14\)](#page-5-1) and [\(3.5\)](#page-3-4), we find

\omega_{1k}^j = \omega_{k1}^j = 0, \quad j \in C_s, \quad k \in B \setminus C_s, \ s \in \{1, 2, 3\}.
$$

Combining (3.14) and (3.12) , we obtain

\omega_{ji}^1 = \omega_{ij}^1 = 0, \quad i \neq j, \quad i, j \in B.
$$

Now, using $(3.11) \sim (3.16)$ $(3.11) \sim (3.16)$ in (3.4) , we complete the proof of the lemma.

We now evaluate $g(R(e_1, e_i)e_1, e_i)$, $g(R(e_1, e_i)e_i, e_j)$ and $g(R(e_i, e_j)e_i, e_1)$ using Lemma $3.2, (2.2)$ $3.2, (2.2)$ and (3.1) , and find the following relations:

and

e_j(\omega_{ii}^1) + \omega_{ii}^j \omega_{jj}^1 - \omega_{ii}^j \omega_{ii}^1 = 0, \quad i \in C_s, \quad j \in B \setminus C_s, \quad s \in \{1, 2, 3\},
$$

respectively. Also, using [\(3.3\)](#page-3-3), Lemma [3.2,](#page-4-3) and the fact that $[e_i e_1](H) = 0 = \nabla_{e_i} e_1(H) \nabla_{e_1} e_i(H)$, we find that

(3.20) $e_i e_1(H) = 0$, for all $i \in B$.

4. Biconservative hypersurfaces in space forms with constant norm of second fundamental form

In this section we study biconservative hypersurfaces M^n in space forms $\overline{M}^{n+1}(c)$ with constant norm of second fundamental form. We denote by β the squared norm of the second fundamental form h . Then, using (3.1) we find that

(4.1)

\beta = \lambda_1^2 + p\lambda_u^2 + q\lambda_v^2 + r\lambda_w^2, \ u \in C_1, \ v \in C_2, \ w \in C_3.
$$

We recall that $B = \{2, 3, \ldots, n\}$. Then we have the following:

Lemma 4.1. Let M^n be a biconservative hypersurface with four distinct principal curvatures in a space form $\overline{M}^{n+1}(c)$, having the shape operator given by (3.[1\)](#page-3-1) with respect to a suitable orthonormal frame $\{e_1, e_2, \ldots, e_n\}$. If the second fundamental form is of constant norm, then

$$
\omega_{vv}^u = 0, \quad \text{for } u \in C_s, \text{ and } v \in B \setminus C_s, \text{ } s \in \{1, 2, 3\}.
$$

Proof. We will prove the case $u \in C_1$ and $v \in C_2$ and by similar arguments one can prove all other cases. Let $w \in C_3$. Differentiating [\(3.9\)](#page-4-4) and [\(4.1\)](#page-5-3) with respect to e_u and using [\(3.3\)](#page-3-3), we get

(4.2)

pe_u(\lambda_u) + q e_u(\lambda_v) + r e_u(\lambda_w) = 0,
$$

and

(4.3)
$$
p\lambda_u e_u(\lambda_u) + q\lambda_v e_u(\lambda_v) + r\lambda_w e_u(\lambda_w) = 0,
$$

respectively.

Eliminating $e_u(\lambda_u)$ from [\(4.2\)](#page-5-4) and [\(4.3\)](#page-5-5), we find

(4.4)

q(\lambda_v - \lambda_u)e_u(\lambda_v) + r(\lambda_w - \lambda_u)e_u(\lambda_w) = 0.
$$

Putting the value of $e_u(\lambda_v)$ and $e_u(\lambda_w)$ from [\(3.6\)](#page-3-2) in [\(4.4\)](#page-5-6), we obtain

r(\lambda_w - \lambda_u)^2 \omega_{ww}^u + q(\lambda_v - \lambda_u)^2 \omega_{vv}^u = 0.
$$

Differentiating [\(4.5\)](#page-6-0) with respect to e_1 and using [\(3.6\)](#page-3-2) and [\(3.18\)](#page-5-7), we have

r[2(\lambda_u - \lambda_1)\omega_{uu}^1 + (2\lambda_1 + \lambda_u - 3\lambda_w)\omega_{ww}^1](\lambda_w - \lambda_u)\omega_{ww}^u + q[2(\lambda_u - \lambda_1)\omega_{uu}^1 + (2\lambda_1 + \lambda_u - 3\lambda_v)\omega_{vv}^1](\lambda_v - \lambda_u)\omega_{vv}^u = 0.
$$

We assume that $\omega_{vv}^u \neq 0$ and we will end up to contradiction. Then the value of the determinant formed by the coefficients of ω_{vv}^u and ω_{ww}^u of the system [\(4.5\)](#page-6-0) and [\(4.6\)](#page-6-1) will be zero. Therefore, we find

(4.7)

Without losing generality, we choose e_1 in the direction of grad H and therefore shape operator A of the hypersurface will take the following form with respect to a suitable frame $\{e_1, e_2, \ldots, e_n\}$

(5.59)
$$
\mathcal{A}e_1 = -\frac{nH}{2}e_1, \quad \mathcal{A}e_i = \lambda e_i, \quad i = 2, ..., n-1.
$$

Using (5.59) in (3.9) and (4.1) , we get

(5.60)
$$
\lambda = -\frac{3\lambda_1}{n-1},
$$

(5.61)
$$
(n-1)\lambda^2 = \beta - \lambda_1^2,
$$

respectively.

Further, if M has constant norm of second fundamental forms, then, from [\(5.60\)](#page-15-17) and (5.61) , we get λ_1 is a constant, which gives that H constant, a contradiction. Combining Cases 1, 2, and 3 it follows that M has constant mean curvature.

Now, using (2.2) we get that the scalar curvature ρ is given by

(5.62)
$$
\rho = n(n-1)c + n^2H^2 + \beta,
$$

which is also constant.
