SMOOTH GEOMETRY OF SKEW PBW EXTENSIONS OVER COMMUTATIVE POLYNOMIAL RINGS I

ABSTRACT. In this paper, we investigate the differential smoothness of skew PBW extensions over commutative polynomial rings on one and two indeterminates.

1. INTRODUCTION

Ore [\[69,](#page-58-0) [70\]](#page-58-1) introduced a kind of noncommutative polynomial rings which has become one of most basic and useful constructions in ring theory and noncommutative algebra. For an associative and unital ring R, an endomorphism σ of R and a σ -derivation δ of R, the Ore extension or skew polynomial ring of R is obtained by adding a single generator x to R subject to the relation $xr = \sigma(r)x + \delta(r)$ for all $r \in R$. This Ore extension of R is denoted by $R[x; \sigma, \delta]$. As one can appreciate in the literature, a lot of papers and books have been published concerning ringtheoretical, homological, geometrical properties and applications of these extensions (e.g. [\[10,](#page-55-0) [22,](#page-56-0) [29,](#page-56-1) [30,](#page-56-2) [39,](#page-57-0) [40,](#page-57-1) [64,](#page-58-2) [60,](#page-57-2) [80,](#page-58-3) [85\]](#page-58-4) and references therein).

On the other hand, Bell and Goodearl [\[9\]](#page-55-1) defined the Poincaré-Birkhoff-Witt (PBW for short) extensions with the aim of cover several families of generalized operator rings as the enveloping algebra of a finite-dimensional Lie algebra, Weyl algebras, differential operators over Lie algebras, the twisted or smash product differential operator rings and universal enveloping rings [\[9,](#page-55-1) Section 5]. Different properties of PBW extensions have been studied by some researchers [\[2,](#page-55-2) [35,](#page-56-3) [36,](#page-56-4) [38,](#page-57-3) [62,](#page-58-5) [63,](#page-58-6) [85,](#page-58-4) [89\]](#page-58-7).

With the aim of generalizing Ore extensions of injective type (that is, $R[x; \sigma, \delta]$) with σ an injective map) and PBW extensions, Gallego and Lezama [\[31\]](#page-56-5) introduced the notion of skew PBW (SPBW) extension. Over the years several authors have shown that SPBW extensions also generalize families of noncommutative algebras such as 3-dimensional skew polynomial algebras introduced by Bell and Smith [\[8\]](#page-55-3), diffusion algebras defined by Isaev et al. [\[45,](#page-57-4) [71\]](#page-58-8), ambiskew polynomial rings introduced by Jordan [\[46,](#page-57-5) [47\]](#page-57-6), solvable polynomial rings introduced by Kandri-Rody and Weispfenning [\[48\]](#page-57-7), almost normalizing extensions defined by McConnell and Robson $[64]$, and *skew bi-quadratic algebras with PBW basis* introduced by Bavula [\[6\]](#page-55-4). As expected, there are different relations between SPBW extensions

In this paper we are interested in the notion of *differential smoothnness* of algebras defined by Brzeziński and Sitarz [\[20\]](#page-56-6). Before saying some words about it, we recall key aspects of *connections* and *differential calculi* in noncommutative geometry.

The *theory of connections* in noncommutative geometry is well-known (for more details, see the beautiful treatments presented by Connes [\[24\]](#page-56-7) or Giachetta et al. [\[34\]](#page-56-8)). Briefly, one considers a differential graded algebra $\Omega A = \bigoplus \Omega^n A$ over a $n=0$ k-algebra $A = \Omega^0 A$ with k a field, and then defines a connection in a left Amodule M as a linear map $\nabla^0: M \to \Omega^1 A \otimes_A M$ that satisfies the Leibniz's rule $\nabla^{0}(am) = da \otimes_{A} m + a\nabla^{0}(m)$ for all $m \in M$ and $a \in A$. As it can be seen, this is a noncommutative definition obtained by a replacement of commutative algebras of functions on a manifold X , and their modules of sections of a vector bundle over X (in the classical definition of a connection), by noncommutative algebras and their general one-sided modules. Just as Brzeziński said, "this captures very well the classical context in which connections appear and brings it successfully to the realm of noncommutative geometry" [\[11,](#page-55-7) p. 557].

Brzeziński in his paper noted that, on the algebraic side, this definition of connection seems to be only a half of a more general picture. In the first place, a noncommutative connection is defined by using the tensor functor, and as is wellknown, this functor has a right adjoint, the hom-functor, so it is natural to ask whether it is possible to introduce connection-like objects defined with the use of the hom-functor. In the second place, the vector space dual to M is a right A module and a left connection in the above sense does not induce a right connection on the dual of M , so having in mind the adjointness properties between tensor and hom functors, the induced map necessarily involves the hom-functor.

Motivated by all these facts, Brzeziński [\[11\]](#page-55-7) showed that there is a natural and potentially rich theory of connnection-like objects defined as maps on the spaces of morphisms of modules. Due to the role of spaces of homomorphisms, these objects are termed hom-connections (also are called divergences due to that if A is an algebra of functions on the Euclidean space \mathbb{R}^n and $\Omega^1(A)$ is the standard module of one-form, then we obtain the classical divergence of the elementary vector calculus [\[12,](#page-56-9) p. 892]). As a matter of fact, he proved that hom-connections arise naturally from (strong) connections in *noncommutative principal bundles*, and that every left connection on a bimodule (in the sense of Cuntz and Quillen [\[26\]](#page-56-10)) gives rise to a hom-connection. Brzeziński also studied the induction procedure of homconnections via differentiable bimodules (and hence, via maps of differential graded algebras), and proved that any hom-connection can be extended to higher forms. He introduced the notion of curvature and showed that a consecutive application of hom-connections can be expressed in terms of the curvature, which leads to a chain complex associated to a flat (i.e. curvature-zero) hom-connection (this chain complex and its homology can be considered as dual complements of the cochain complex associated to a connection and the twisted cohomology, which is crucial in the theory of noncommutative differential fibrations [\[7\]](#page-55-8)).

Two years later, Brzeziński et al. [\[18\]](#page-56-11) presented a construction of differential calculi which admits hom-connections. This construction is based on the use of twisted multi-derivations, where the constructed first-order calculus $\Omega^1(A)$ is free

as a left and right A-module; $\Omega^1(A)$ should be understood as a module of sections on the cotangent bundle over a manifold represented by A , and hence their construction corresponds to parallelizable manifolds or to an algebra of functions on a local chart. One year later, Brzeziński asserted that "one should expect $\Omega^1(A)$ to be a finitely generated and projective module over A (thus corresponding to sections of a nontrivial vector bundle by the Serre-Swan theorem)" [\[12,](#page-56-9) p. 885]. In his paper, he extended the construction in [\[18\]](#page-56-11) to finitely generated and projective modules.

Related to differential calculi, we have the *smoothness of algebras*. Briefly, the study of this smoothness goes back at least to Grothendieck's EGA [\[41\]](#page-57-10). The concept of a formally smooth commutative (topological) algebra introduced by him was extended to the noncommutative setting by Schelter [\[84\]](#page-58-9). An algebra is formally smooth if and only if the kernel of the multiplication map is projective as a bimodule. This notion arose as a replacement of a far too general definition based on the finiteness of the global dimension; Cuntz and Quillen [\[26\]](#page-56-10) called these algebras quasi-free. Precisely, the notion of smoothness based on the finiteness of this dimension was refined by Stafford and Zhang [\[88\]](#page-58-10), where a Noetherian algebra is said to be smooth provided that it has a finite global dimension equal to the homological dimension of all its simple modules. In the homological setting, Van den Bergh [\[90\]](#page-59-0) called an algebra homologically smooth if it admits a finite resolution by finitely generated projective bimodules. The characterization of this kind of smoothness for the noncommutative pillow, the quantum teardrops, and quantum homogeneous spaces was made by Brzeziński $[11, 13]$ $[11, 13]$ and Krähmer $[51]$, respectively.

Brzeziński and Sitarz [\[20\]](#page-56-6) defined other notion of smoothness of algebras, termed differential smoothness due to the use of differential graded algebras of a specified dimension that admits a noncommutative version of the Hodge star isomorphism, which considers the existence of a top form in a differential calculus over an algebra together with a string version of the Poincaré duality realized as an isomorphism between complexes of differential and integral forms. This new notion of smoothness is different and more constructive than the homological smoothness mentioned above. "The idea behind the differential smoothness of algebras is rooted in the observation that a classical smooth orientable manifold, in addition to de Rham complex of differential forms, admits also the complex of integral forms isomorphic to the de Rham complex $[61, \text{Section } 4.5]$. The de Rham differential can be understood as a special left connection, while the boundary operator in the complex of integral forms is an example of a right connection" [\[20,](#page-56-6) p. 413].

Several authors (e.g. [\[14,](#page-56-13) [15,](#page-56-14) [18,](#page-56-11) [19,](#page-56-15) [20,](#page-56-6) [28,](#page-56-16) [49,](#page-57-13) [50,](#page-57-14) [76\]](#page-58-11)) have characterized the differential smoothness of algebras such as the quantum two - and three - spheres, disc, plane, the noncommutative torus, the coordinate algebras of the quantum group $SU_q(2)$, the noncommutative pillow algebra, the quantum cone algebras, the quantum polynomial algebras, Hopf algebra domains of Gelfand-Kirillov dimension two that are not PI, families of Ore extensions, some 3-dimensional skew polynomial algebras, diffusion algebras in three generators, and noncommutative coordinate algebras of deformations of several examples of classical orbifolds such as the pillow orbifold, singular cones and lens spaces. An interesting fact is that some of these algebras are also homologically smooth in the Van den Bergh's sense.

Considering the active research on differential smoothness of noncommutative algebras, and having in mind that ring, theoretical and geometrical properties of SPBW extensions (and hence of PBW extensions) have been investigated by different authors [\[1,](#page-55-9) [4,](#page-55-10) [37,](#page-57-8) [29,](#page-56-1) [42,](#page-57-15) [43,](#page-57-16) [44,](#page-57-17) [57,](#page-57-18) [67,](#page-58-12) [75,](#page-58-13) [79,](#page-58-14) [87,](#page-58-15) [89\]](#page-58-7), our purpose in this paper is to investigate this smoothness for the SPBW extensions over the commutative polynomial rings $\mathbb{k}[t]$ and $\mathbb{k}[t_1, t_2]$ (in a sequel paper [\[83\]](#page-58-16) we study the differential smoothness in the case of commutative polynomial rings generated on three and more indeterminates). Since these extensions are more general than 3-dimensional skew polynomial algebras [\[8\]](#page-55-3), diffusion algebras [\[45\]](#page-57-4), and skew bi-quadratic algebras [\[6\]](#page-55-4) (see also double Ore extensions [\[94,](#page-59-1) [95\]](#page-59-2)), and that the differential smoothness of all these families of algebras has been investigated in [\[76,](#page-58-11) [81,](#page-58-17) [82\]](#page-58-18), this paper is a sequel of the research of the smooth geometry of SPBW extensions from Brzeziński and Sitarz's point of view. In this way, we contribute to the study of the noncommutative geometry (algebraic and differential) of SPBW extensions that has been carried out by Lezama [\[54,](#page-57-19) [55,](#page-57-20) [57,](#page-57-18) [58\]](#page-57-21) and other people [\[25,](#page-56-17) [68,](#page-58-19) [87\]](#page-58-15).

The article is organized as follows. In Section [2](#page-3-0) we recall the definitions and preliminaries on SPBW extensions and differential smoothness of algebras in order to set up notation and render this paper self-contained. Next, Section [3](#page-11-0) contains the first original results on the paper. We extend Brzeziński's ideas developed for skew polynomial rings of the commutative polynomial ring $\mathbb{k}[t]$ [\[14\]](#page-56-13) (Example [2.11\)](#page-9-0) to the setting of SPBW extensions over $\mathbb{k}[t]$. Due to the length of the non-trivial computations, first we take as toy models the SPBW extensions generated by two and three indeterminates (Sections [3.1](#page-11-1) and [3.2,](#page-19-0) respectively), while the general case is presented in Section [3.3.](#page-26-0) Theorems [3.3,](#page-17-0) [3.5](#page-23-0) and [3.7](#page-27-0) are the key results that establish sufficient conditions to assert that a SPBW extension over $\mathbb{k}[t]$ is differentially smooth. In Section [4,](#page-29-0) we study the differential smoothness of SPBW extensions over $\mathbb{k}[t_1, t_2]$. As it can be seen, the computations are highly non-trivial. Just as we did in Section [3,](#page-11-0) we divide our treatment in the case of two, three and n indeterminates (Sections [4.1,](#page-30-0) [4.2,](#page-41-0) and [4.3,](#page-47-0) respectively). The important results in this section are Theorems [4.2,](#page-37-0) [4.5](#page-45-0) and [4.7.](#page-51-0) Finally, in Section [5](#page-54-0) we say a few words about a future work related to the sequel paper.

Throughout the paper, the word ring means an associative ring with identity not necessarily commutative. N denotes the set of natural numbers including zero, K and k denote a commutative ring with identity and a field, respectively. $Aut(R)$ denotes the set of automorphisms of the ring R.

2. Definitions and preliminaries

2.1. Skew Poincaré-Birkhoff-Witt extensions.

Definition 2.1 ([\[31,](#page-56-5) Definition 1]). Let R and A be rings. We say that A is a SPBW extension over R if the following conditions hold:

- (i) R is a subring of A sharing the same identity element.
- (ii) There exist elements $x_1, \ldots, x_n \in A \setminus R$ such that A is a left free Rmodule with basis given by the set $\text{Mon}(A) := \{x^{\alpha} = x_1^{\alpha_1} \cdots x_n^{\alpha_n} \mid \alpha =$ $(\alpha_1, \ldots, \alpha_n) \in \mathbb{N}^n$.
- (iii) For each $1 \leq i \leq n$ and any $r \in R \setminus \{0\}$, there exists an element $c_{i,r} \in$ $R \setminus \{0\}$ such that $x_i r - c_{i,r} x_i \in R$.
- (iv) For $1 \le i, j \le n$, there exists an element $d_{i,j} \in R \setminus \{0\}$ such that

$$
x_j x_i - d_{i,j} x_i x_j \in R + Rx_1 + \dots + Rx_n,
$$

i.e., there exist elements $r_0^{(i,j)}, r_1^{(i,j)}, \ldots, r_n^{(i,j)} \in R$ with

$$
x_j x_i - d_{i,j} x_i x_j = r_0^{(i,j)} + \sum_{k=1}^n r_k^{(i,j)} x_k.
$$

We use freely the notation $A = \sigma(R)(x_1, \ldots, x_n)$ to denote a SPBW extension A over a ring R in the indeterminates x_1, \ldots, x_n . R is called the *ring of coefficients* of the extension A.

Since $Mon(A)$ is a left R-basis of A, the elements $c_{i,r}$ and $d_{i,j}$ in Definition [2.1](#page-3-1) are unique. Every element $f \in A \setminus \{0\}$ has a unique representation as $f = \sum_{i=0}^{t} r_i X_i$, with $r_i \in R \setminus \{0\}$ and $X_i \in \text{Mon}(A)$ for $0 \leq i \leq t$ with $X_0 = 1$. When necessary, we use the notation $f = \sum_{i=0}^{t} r_i Y_i$. For $X = x^{\alpha} \in \text{Mon}(A)$, $\exp(X) := \alpha$ and $deg(X) := |\alpha|$. Let $deg(f) := max{deg(X_i)}_{i=1}^t$ [\[31,](#page-56-5) Remark 2 and Definition 6].

If $A = \sigma(R)(x_1, \ldots, x_n)$ is a SPBW extension over R, then for each $1 \leq i \leq n$, there exist an injective endomorphism $\sigma_i: R \to R$ and a σ_i -derivation $\delta_i: R \to R$ such that $x_i = \sigma_i(r)x_i + \delta_i(r)$, for each $r \in R$ [\[31,](#page-56-5) Proposition 3]. We use the notation $\Sigma := {\sigma_1, \ldots, \sigma_n}$ and $\Delta := {\delta_1, \ldots, \delta_n}$, and say that the pair (Σ, Δ) is a system of endomorphisms and Σ -derivations of R with respect to A. For $\alpha = (\alpha_1, \ldots, \alpha_n) \in \mathbb{N}^n$, $\sigma^{\alpha} := \sigma_1^{\alpha_1} \circ \cdots \circ \sigma_n^{\alpha_n}$, $\delta^{\alpha} := \delta_1^{\alpha_1} \circ \cdots \circ \delta_n^{\alpha_n}$, where \circ denotes the classical composition of functions.

Definition 2.2 ([\[31,](#page-56-5) Definition 4], [\[56,](#page-57-22) Definition 2.3 (ii)]). Consider a SPBW extension $A = \sigma(R)\langle x_1, \ldots, x_n \rangle$ over R.

- (i) A is called *quasi-commutative* if the conditions (iii) (iv) in Definition (2.1) are replaced by the following:
	- For every $1 \leq i \leq n$ and $r \in R \setminus \{0\}$ there exists $c_{i,j} \in R \setminus \{0\}$ such that $x_i r = c_{i,r} x_i$.
	- For every $1 \leq i, j \leq n$, there exists $d_{i,j} \in R \setminus \{0\}$ such that $x_j x_i =$ $d_{i,j}x_ix_j$.
- (ii) A is bijective if σ_i is bijective, for every $1 \leq i \leq n$, and $d_{i,j}$ is invertible, for any $1 \leq i < j \leq n$.
- (iii) If σ_i is the identity map of R for each $i = 1, \ldots, n$, then we say that A is of *derivation type*. Similarly, if δ_i is zero, for every *i*, then *A* is called of endomorphism type.
- (iv) A is said to be *semi-commutative* if it is quasi-commutative and $x_i r = rx_i$, for each i and every $r \in R$.

Next, we consider some interesting families examples of SPBW extensions.

Example 2.3. (i) SPBW extensions of endomorphism type over a ring are more general than iterated Ore extensions of endomorphism type of the same ring. Let us illustrate the situation with two and three indeterminates.

For the iterated Ore extension of endomorphism type $R[x; \sigma_x][y; \sigma_y]$, if $r \in R$ then we have the following relations: $xr = \sigma_x(r)x$, $yr = \sigma_y(r)y$, and $yx = \sigma_y(x)y$. Now, if we have $\sigma(R)(x, y)$ a SPBW extension of endomorphism type over R, then for any $r \in R$, Definition [2.1](#page-3-1) establishes that $xr = \sigma_1(r)x$, $yr = \sigma_2(r)y$, and $yx = d_{1,2}xy + r_0 + r_1x + r_2y$, for some elements $d_{1,2}, r_0, r_1$ and r_2 belong to R.

If we have the iterated Ore extension $R[x; \sigma_x][y; \sigma_y][z; \sigma_z]$, then for any $r \in R$, $xr = \sigma_x(r)x$, $yr = \sigma_y(r)y$, $zr = \sigma_z(r)z$, $yx = \sigma_y(x)y$, $zx = \sigma_z(x)z$, $zy = \sigma_z(y)z$. For the SPBW extension of endomorphism type $\sigma(R)(x, y, z)$, $xr = \sigma_1(r)x, \ yr = \sigma_2(r)y, \ zr = \sigma_3(r)z, \ yx = d_{1,2}xy + r_0 + r_1x + r_2y + r_3z,$ $zx = d_{1,3}xz + r'_0 + r'_1x + r'_2y + r'_3z$, and $zy = d_{2,3}yz + r''_0 + r''_1x + r''_2y + r''_3z$,

for some elements $d_{1,2}, d_{1,3}, d_{2,3}, r_0, r'_0, r''_0, r_1, r'_1, r''_1, r_2, r'_2, r''_2, r_3, r'_3, r''_3$ of R. As the number of indeterminates increases, the differences between both algebraic structures are more remarkable.

- (ii) From Definition [2.1](#page-3-1) (iv), it is clear that SPBW extensions are more general than iterated skew polynomial rings. For example, universal enveloping algebras of finite dimensional Lie algebras and some 3-dimensional skew polynomial algebras in the sense of Bell and Smith $|8|$ cannot be expressed as iterated skew polynomial rings but are SPBW extensions. Quasicommutative SPBW extensions are isomorphic to iterated Ore extensions of endomorphism type $[59,$ Theorem 2.3].
- (iii) PBW extensions introduced by Bell and Goodearl [\[9\]](#page-55-1) are particular examples of SPBW extensions. More exactly, the first objects satisfy the relation $x_i r = rx_i + \delta_i(r)$ for every $i = 1, ..., n$ and each $r \in R$, and the elements d_{ij} in Definition [2.1](#page-3-1) (iv) are equal to the identity of R. As examples of PBW extensions, we mention the following: the enveloping algebra of a finite-dimensional Lie algebra; any differential operator ring $R[\theta_1,\ldots,\theta_1;\delta_1,\ldots,\delta_n]$ formed from commuting derivations δ_1,\ldots,δ_n ; differential operators introduced by Rinehart; twisted or smash product differential operator rings, and others [\[9,](#page-55-1) p. 27].
- (iv) 3-dimensional skew polynomial algebras were defined by Bell and Smith [\[8\]](#page-55-3). Briefly, a 3-dimensional algebra A is a k-algebra generated by the indeterminates x, y, z subject to the relations

$$
yz - \alpha zy = \lambda, \quad zx - \beta xz = \mu, \quad \text{and} \quad xy - \gamma yx = \nu,
$$

where $\lambda, \mu, \nu \in \mathbb{k}x + \mathbb{k}y + \mathbb{k}z + \mathbb{k}$, and $\alpha, \beta, \gamma \in \mathbb{k}^*$. A is called a 3dimensional skew polynomial k-algebra if the set $\{x^i y^j z^k \mid i, j, k \ge 0\}$ forms a k-basis of the algebra. Up to isomorphism, there are fifteen 3-dimensional skew polynomial k-algebras $[80]$, Theorem C4.3.1 (see also $[72, 73, 78]$ $[72, 73, 78]$ $[72, 73, 78]$ $[72, 73, 78]$).

(v) Diffusion algebras were introduced from the physicist point of view by Isaev et al. [\[45\]](#page-57-4) as quadratic algebras that appear as algebras of operators that model the stochastic flow of motion of particles in a one dimensional discrete lattice, while Pyatov and Twarock [\[71\]](#page-58-8) presented a construction formalism for these algebras and to use the latter to prove the results in [\[45\]](#page-57-4): "Diffusion algebras play a key role in the understanding of one-dimensional stochastic processes. In the case of N species of particles with only nearest-neighbor interactions with exclusion on a one-dimensional lattice, diffusion algebras are useful tools in finding expressions for the probability distribution of the stationary state of these processes. Following the idea of matrix product states, the latter are given in terms of monomials built from the generators of a quadratic algebra" [\[71,](#page-58-8) p. 3268].

Following Pyatov and Twarock's notation and let α , β be two elements belonging to the set $I_N := \{1, \ldots, n\}$ with $\alpha < \beta$. Consider quadratic relations of the form

(2.1)
$$
g_{\alpha\beta}D_{\alpha}D_{\beta} - g_{\beta\alpha}D_{\beta}D_{\alpha} = x_{\beta}D_{\alpha} - x_{\alpha}D_{\beta},
$$

with $g_{\alpha\beta} \in \mathbb{R} \setminus \{0\}$, $g_{\beta\alpha} \in \mathbb{R}$, and $x_{\alpha}, x_{\beta} \in \mathbb{C}$.

From [\[71,](#page-58-8) Definition 1.1], an algebra with set of generators given by ${D_\alpha \mid \alpha \in I_N}$ and relations of type (2.1) is called *diffusion algebra*, if it admits a linear PBW-basis of ordered monomials of the form

$$
(2.2) \tD_{\alpha_1}^{k_1} D_{\alpha_2}^{k_2} \cdots D_{\alpha_n}^{k_n}, \text{ with } k_j \in \mathbb{N} \text{ and } \alpha_1 > \alpha_2 > \cdots > \alpha_n.
$$

Due to physical reasons only relations with positive coefficients $g_{\alpha\beta} \in$ $\mathbb{R}_{>0}$ and $g_{\beta\alpha} \in \mathbb{R}_{>0}$ ($\alpha < \beta$) are relevant because they are interpreted as hopping rates in stochastic models [\[71,](#page-58-8) p. 3268].

(vi) Let $n \geq 2$ be a natural number. A family $M = (m_{ij})_{i>j}$ of elements m_{ij} belonging to R ($1 \leq j \leq i \leq n$) is called a *lower triangular half-matrix* with coefficients in R. The set of all such matrices is denoted by $L_n(R)$.

Bavula [\[6,](#page-55-4) Section 1] defined for $\sigma = (\sigma_1, \ldots, \sigma_n)$ an *n*-tuple of commuting endomorphisms of R, $\delta = (\delta_1, \ldots, \delta_n)$ an n-tuple of σ -endomorphisms of R (that is, δ_i is a σ_i -derivation of R for $i = 1, \ldots, n$), $Q = (q_{ij}) \in$ $L_n(Z(R))$, $\mathbb{A} := (a_{ij,k})$ where $a_{ij,k} \in R, 1 \leq j \leq i \leq n$ and $k =$ $1, \ldots, n$, and $\mathbb{B} := (b_{ij}) \in L_n(R)$, the skew bi-quadratic algebra (SBQA) $A = R[x_1, \ldots, x_n; \sigma, \delta, Q, \mathbb{A}, \mathbb{B}]$ as a ring generated by the ring R and elements x_1, \ldots, x_n subject to the defining relations

(2.3)
$$
x_i r = \sigma_i(r) x_i + \delta_i(r), \text{ for } i = 1, ..., n, \text{ and every } r \in R,
$$

(2.4)
$$
x_i x_j - q_{ij} x_j x_i = \sum_{k=1}^n a_{ij,k} x_k + b_{ij}, \text{ for all } j < i.
$$

If $\sigma_i = \text{id}_R$ and $\delta_i = 0$ for $i = 1, \ldots, n$, the ring A is called the biquadratic algebra (BQA) and is denoted by $A = R[x_1, \ldots, x_n; Q, \mathbb{A}, \mathbb{B}]$. A has *PBW basis* if $A = \bigoplus Rx^{\alpha}$ where $x^{\alpha} = x_1^{\alpha_1} \cdots x_n^{\alpha_n}$. $\alpha \bar{\in} \mathbb{N}^n$

It is clear from the definition that bi-quadratic algebras having PBW basis are particular examples of SPBW extensions.

2.2. Differential smoothness. We follow Brzeziński and Sitarz's presentation on differential smoothness carried out in [\[20,](#page-56-6) Section 2] (c.f. [\[11,](#page-55-7) [13\]](#page-56-12)).

- **Definition 2.4** ([\[20,](#page-56-6) Section 2.1]). (i) A differential graded algebra is a nonnegatively graded algebra Ω with the product denoted by \wedge together with a degree-one linear map $d: \Omega^{\bullet} \to \Omega^{\bullet+1}$ that satisfies the graded Leibniz's rule and is such that $d \circ d = 0$.
	- (ii) A differential graded algebra (Ω, d) is a *calculus over an algebra A* if $\Omega^0 A =$ A and $\Omega^n A = A \, dA \wedge dA \wedge \cdots \wedge dA \, (dA$ appears n-times) for all $n \in \mathbb{N}$ $\bigoplus_{n\in\mathbb{N}} \Omega^n A$. By using the Leibniz's rule, it follows that $\Omega^n A = dA \wedge dA \wedge dA$ (this last is called the *density condition*). We write $(\Omega A, d)$ with $\Omega A =$ $\cdots \wedge dA$ A. A differential calculus ΩA is said to be *connected* if ker(d $|_{\Omega^0 A}$ $) = \mathbb{k}$.
	- (iii) A calculus $(\Omega A, d)$ is said to have dimension n if $\Omega^n A \neq 0$ and $\Omega^m A = 0$ for all $m > n$. An n-dimensional calculus ΩA admits a volume form if $\Omega^n A$ is isomorphic to A as a left and right A-module.

The existence of a right A-module isomorphism means that there is a free generator, say ω , of $\Omega^n A$ (as a right A-module), i.e. $\omega \in \Omega^n A$, such that all elements of $\Omega^n A$ can be uniquely expressed as ωa with $a \in A$. If ω is also a free generator of $\Omega^n A$ as a left A-module, this is said to be a volume form on ΩA .

The right A-module isomorphism $\Omega^n A \to A$ corresponding to a volume form ω is denoted by π_{ω} , i.e.

(2.5)
$$
\pi_{\omega}(\omega a) = a, \text{ for all } a \in A.
$$

By using that $\Omega^n A$ is also isomorphic to A as a left A-module, any free generator ω induces an algebra endomorphism ν_ω of A by the formula

(2.6) aω = ωνω(a).

Note that if ω is a volume form, then ν_{ω} is an algebra automorphism.

Now, we proceed to recall the key ingredients of the *integral calculus* on A as dual to its differential calculus. For more details, see Brzezinski et al. [\[11,](#page-55-7) [18\]](#page-56-11).

Let $(\Omega A, d)$ be a differential calculus on A. The space of n-forms $\Omega^n A$ is an A-bimodule. Consider $\mathcal{I}_n A$ the right dual of $\Omega^n A$, the space of all right A-linear maps $\Omega^n A \to A$, that is, $\mathcal{I}_n A := \text{Hom}_A(\Omega^n(A), A)$. Notice that each of the $\mathcal{I}_n A$ is an A-bimodule with the actions

$$
(a \cdot \phi \cdot b)(\omega) = a\phi(b\omega)
$$
, for all $\phi \in \mathcal{I}_n A$, $\omega \in \Omega^n A$ and $a, b \in A$.

The direct sum of all the $\mathcal{I}_n A$, that is, $\mathcal{I}A = \bigoplus_n \mathcal{I}_n A$, is a right ΩA -module with

action given by

(2.7)
$$
(\phi \cdot \omega)(\omega') = \phi(\omega \wedge \omega'), \text{ for all } \phi \in \mathcal{I}_{n+m}A, \omega \in \Omega^n A \text{ and } \omega' \in \Omega^m A.
$$

Definition 2.5 ([\[11,](#page-55-7) Definition 2.1]). A *divergence* (also called *hom-connection*) on A is a linear map $\nabla : \mathcal{I}_1 A \to A$ such that

(2.8)
$$
\nabla(\phi \cdot a) = \nabla(\phi)a + \phi(da), \text{ for all } \phi \in \mathcal{I}_1 A \text{ and } a \in A.
$$

Note that a divergence can be extended to the whole of IA ,

$$
\nabla_n: \mathcal{I}_{n+1}A \to \mathcal{I}_nA,
$$

by considering

(2.9)
$$
\nabla_n(\phi)(\omega) = \nabla(\phi \cdot \omega) + (-1)^{n+1}\phi(d\omega)
$$
, for all $\phi \in \mathcal{I}_{n+1}(A)$ and $\omega \in \Omega^n A$.

By putting together (2.8) and (2.9) , we get the Leibniz's rule

(2.10)
$$
\nabla_n(\phi \cdot \omega) = \nabla_{m+n}(\phi) \cdot \omega + (-1)^{m+n} \phi \cdot d\omega,
$$

for all elements $\phi \in \mathcal{I}_{m+n+1}A$ and $\omega \in \Omega^m A$ [\[11,](#page-55-7) Lemma 3.2]. In the case $n=0$, if Hom_A (A, M) is canonically identified with M, then ∇_0 reduces to the classical Leibniz's rule.

Definition 2.6 ([\[11,](#page-55-7) Definition 3.4]). The right A-module map

 $F = \nabla_0 \circ \nabla_1 : \text{Hom}_A(\Omega^2 A, M) \to M$

is called a *curvature* of a hom-connection (M, ∇_0) . (M, ∇_0) is said to be flat if its curvature is the zero map, that is, if $\nabla \circ \nabla_1 = 0$. This condition implies that $\nabla_n \circ \nabla_{n+1} = 0$ for all $n \in \mathbb{N}$.

IA together with the ∇_n form a chain complex called the *complex of integral* forms over A. The cokernel map of ∇ , that is, $\Lambda : A \to \text{Coker}\nabla = A/\text{Im}\nabla$ is said to be the integral on A associated to IA.

Given a left A-module X with action $a \cdot x$, for all $a \in A$, $x \in X$, and an algebra automorphism ν of A, the notation νX stands for X with the A-module structure twisted by ν , i.e. with the A-action $a \otimes x \mapsto \nu(a) \cdot x$.

The following definition of an *integrable differential calculus* seeks to portray a version of Hodge star isomorphisms between the complex of differential forms of a differentiable manifold and a complex of dual modules of it [\[14,](#page-56-13) p. 112].

Definition 2.7 ([\[20,](#page-56-6) Definition 2.1]). An *n*-dimensional differential calculus (ΩA , d) is said to be *integrable* if $(\Omega A, d)$ admits a complex of integral forms $(\mathcal{I}A, \nabla)$ for which there exist an algebra automorphism ν of A and A-bimodule isomorphisms $\Theta_k : \Omega^k A \to^{\nu} \mathcal{I}_{n-k} A, k = 0, \ldots, n$, rendering commmutative the following diagram:

$$
A \xrightarrow{d} \Omega^1 A \xrightarrow{d} \Omega^2 A \xrightarrow{d} \cdots \xrightarrow{d} \Omega^{n-1} A \xrightarrow{d} \Omega^n A
$$

$$
\downarrow \Theta_0 \qquad \qquad \downarrow \Theta_1 \qquad \qquad \downarrow \Theta_2 \qquad \qquad \downarrow \Theta_{n-1} \qquad \qquad \downarrow \Theta_n
$$

$$
\nu \mathcal{I}_n A \xrightarrow{\nabla_{n-1}} \nu \mathcal{I}_{n-1} A \xrightarrow{\nabla_{n-2}} \nu \mathcal{I}_{n-2} A \xrightarrow{\nabla_{n-3}} \cdots \xrightarrow{\nabla_1} \nu \mathcal{I}_1 A \xrightarrow{\nabla} \nu \nu A
$$

The *n*-form $\omega := \Theta_n^{-1}(1) \in \Omega^n A$ is called an *integrating volume form*.

The algebra of complex matrices $M_n(\mathbb{C})$ with the *n*-dimensional calculus generated by derivations presented by Dubois-Violette et al. [\[27,](#page-56-18) [28\]](#page-56-16), the quantum group $SU_q(2)$ with the three-dimensional left covariant calculus developed by Woronowicz [\[93\]](#page-59-3) and the quantum standard sphere with the restriction of the above calculus, are examples of algebras admitting integrable calculi. For more details on the subject, see Brzeziński et al. [\[18\]](#page-56-11).

The following proposition shows that the integrability of a differential calculus can be defined without explicit reference to integral forms. This allows us to guarantee the integrability by considering the existence of finitely generator elements that allow to determine left and right components of any homogeneous element of $\Omega(A).$

Proposition 2.8 ([\[20,](#page-56-6) Theorem 2.2]). Let $(\Omega A, d)$ be an n-dimensional differential calculus over an algebra A. The following assertions are equivalent:

- (1) $(\Omega A, d)$ is an integrable differential calculus.
- (2) There exists an algebra automorphism ν of A and A-bimodule isomorphisms Θ_k : $\Omega^k A \rightarrow \nu \mathcal{I}_{n-k} A$, $k = 0, \ldots, n$, such that, for all $\omega' \in \Omega^k A$ and $\omega'' \in \Omega^m A$,

$$
\Theta_{k+m}(\omega' \wedge \omega'') = (-1)^{(n-1)m} \Theta_k(\omega') \cdot \omega''.
$$

(3) There exists an algebra automorphism ν of A and an A-bimodule map ϑ : $\Omega^n A \to \nu A$ such that all left multiplication maps

$$
\ell_{\vartheta}^{k} : \Omega^{k} A \to \mathcal{I}_{n-k} A,
$$

$$
\omega' \mapsto \vartheta \cdot \omega', \quad k = 0, 1, \dots, n,
$$

where the actions \cdot are defined by (2.7) (2.7) (2.7) , are bijective.

(4) $(\Omega A, d)$ has a volume form ω such that all left multiplication maps

$$
\ell_{\pi_{\omega}}^k : \Omega^k A \to \mathcal{I}_{n-k} A,
$$

$$
\omega' \mapsto \pi_{\omega} \cdot \omega', \quad k = 0, 1, \dots, n-1,
$$

where π_{ω} is defined by (2.5) (2.5) (2.5) , are bijective.

A volume form $\omega \in \Omega^n A$ is an *integrating form* if and only if it satisfies Propo-sition [2.8](#page-8-0) (4) $[20,$ Remark 2.3].

The most interesting cases of differential calculi are those where $\Omega^k A$ are finitely generated and projective right or left (or both) A-modules [\[12\]](#page-56-9).

Proposition 2.9. (1) [\[20,](#page-56-6) Lemma 2.6] Consider $(\Omega A, d)$ an integrable and ndimensional calculus over A with integrating form ω . Then $\Omega^k A$ is a finitely generated projective right A-module if there exist a finite number of forms $\omega_i \in \Omega^k A$ and $\overline{\omega}_i \in \Omega^{n-k} A$ such that, for all $\omega' \in \Omega^k A$, we have that

$$
\omega' = \sum_i \omega_i \pi_{\omega} (\overline{\omega}_i \wedge \omega').
$$

(2) [\[20,](#page-56-6) Lemma 2.7] Let $(\Omega A, d)$ be an n-dimensional calculus over A admitting a volume form ω . Assume that for all $k = 1, \ldots, n-1$, there exists a finite number of forms $\omega_i^k, \overline{\omega}_i^k \in \Omega^k(A)$ such that for all $\omega' \in \Omega^k A$, we have that

$$
\omega' = \sum_i \omega_i^k \pi_\omega(\overline{\omega}_i^{n-k} \wedge \omega') = \sum_i \nu_\omega^{-1} (\pi_\omega(\omega' \wedge \omega_i^{n-k})) \overline{\omega}_i^k,
$$

where π_{ω} and ν_{ω} are defined by ([2.5](#page-7-3)) and ([2.6](#page-7-4)), respectively. Then ω is an integral form and all the $\Omega^k A$ are finitely generated and projective as left and right A-modules.

Brzeziński and Sitarz [\[20,](#page-56-6) p. 421] asserted that to connect the integrability of the differential graded algebra $(\Omega A, d)$ with the algebra A, it is necessary to relate the dimension of the differential calculus ΩA with that of A, and since we are dealing with algebras that are deformations of coordinate algebras of affine varieties, the Gelfand-Kirillov dimension introduced by Gelfand and Kirillov [\[32,](#page-56-19) [33\]](#page-56-20) seems to be the best suited. Briefly, given an affine k-algebra A, the Gelfand-Kirillov dimension of A, denoted by $GK\dim(A)$, is given by

$$
GKdim(A) := \limsup_{n \to \infty} \frac{\log(\dim V^n)}{\log n},
$$

where V is a finite-dimensional subspace of A that generates A as an algebra. This definition is independent of choice of V . If A is not affine, then its Gelfand-Kirillov dimension is defined to be the supremum of the Gelfand-Kirillov dimensions of all affine subalgebras of A. An affine domain of Gelfand-Kirillov dimension zero is precisely a division ring that is finite-dimensional over its center. In the case of an affine domain of Gelfand-Kirillov dimension one over k, this is precisely a finite module over its center, and thus polynomial identity. In some sense, this dimensions measures the deviation of the algebra A from finite dimensionality. For more details about this dimension, see the excellent treatment developed by Krause and Lenagan [\[52\]](#page-57-24).

After preliminaries above, we arrive to the key notion of this paper.

Definition 2.10 ([\[20,](#page-56-6) Definition 2.4]). An affine algebra A with integer Gelfand-Kirillov dimension n is said to be *differentially smooth* if it admits an *n*-dimensional connected integrable differential calculus $(\Omega A, d)$.

From Definition [2.10](#page-9-1) a differentially smooth algebra comes equipped with a wellbehaved differential structure and with the precise concept of integration [\[19,](#page-56-15) p. 2414].

Example 2.11. (i) The polynomial algebra $\mathbb{K}[x_1, \ldots, x_n]$ has Gelfand-Kirillov dimension n and the usual exterior algebra is an n -dimensional integrable calculus, whence $\mathbb{K}[x_1,\ldots,x_n]$ is differentially smooth.

(ii) If σ is an endomorphism of R, then a map $\delta: R \to R$ is called a σ -derivation on R, if it is additive and satisfies that $\delta(rs) = \sigma(r)\delta(s) + \delta(r)s$, for every $r, s \in R$ (strictly speaking, this is the definition of left σ -derivation). The pair (σ, δ) is called a *quasi-derivation on R* [\[22,](#page-56-0) Definition 3.1]. According to Ore [\[69,](#page-58-0) [70\]](#page-58-1), the skew polynomial ring of R is defined as the ring $R[x; \sigma, \delta]$ generated by R and an indeterminate x subject to the relation $xr := \sigma(r)x+$ $\delta(r)$, for every $r \in R$, such that $R[x; \sigma, \delta]$ is a free left R-module with basis ${x^k | k \in \mathbb{N}}$. In the literature, $R[x; \sigma, \delta]$ is called a skew polynomial ring over R of mixed type. If σ is an injective map of R, then we call it an Ore extension of injective type, while if σ is the identity of R, then we write $R[x; \delta]$ and call it a *ring of derivation type*. On the other hand, if δ is the zero map, then we write $R[x; \sigma]$ which is known as a *ring of endomorphism* type.

Brzeziński [\[14\]](#page-56-13) characterized the differential smoothness of skew polynomial rings of the form $\mathbb{k}[t][x; \sigma_{q,r}, \delta_{p(t)}]$ where $\sigma_{q,r}(t) = qt + r$, with $q, r \in \mathbb{k}, q \neq 0$, and the $\sigma_{q,r}$ -derivation $\delta_{p(t)}$ is defined as

(2.11)
$$
\delta_{p(t)}(f(t)) = \frac{f(\sigma_{q,r}(t)) - f(t)}{\sigma_{q,r}(t) - t} p(t),
$$

for an element $p(t) \in \mathbb{k}[t]$. $\delta_{p(t)}(f(t))$ is a suitable limit when $q = 1$ and $r = 0$, that is, when $\sigma_{q,r}$ is the identity map of $\mathbb{k}[t]$.

For the maps

(2.12)
$$
\nu_t(t) = t
$$
, $\nu_t(x) = qx + p'(t)$ and $\nu_x(t) = \sigma_{q,r}^{-1}(t)$, $\nu_x(x) = x$,

where $p'(t)$ is the classical t-derivative of $p(t)$, Brzeziński [\[14,](#page-56-13) Lemma 3.1] showed that all of them simultaneously extend to algebra automorphisms ν_t and ν_x of $\mathbb{k}[t][x; \sigma_{q,r}, \delta_{p(t)}]$ only in the following three cases:

- (a) $q = 1, r = 0$ with no restriction on $p(t)$;
- (b) $q = 1, r \neq 0$ and $p(t) = c, c \in \mathbb{k}$;

(c)
$$
q \neq 1, p(t) = c\left(t + \frac{r}{q-1}\right), c \in \mathbb{k}
$$
 with no restriction on r.

In any of the cases (a) - (c) we have that $\nu_x \circ \nu_t = \nu_t \circ \nu_x$. If the Ore extension $\mathbb{k}[t][x; \sigma_{q,r}, \delta_{p(t)}]$ satisfies one of these three conditions, Brzeziński proved that it is differentially smooth [\[14,](#page-56-13) Proposition 3.3].

- From Brzeziński's result we get that the algebras
- The polynomial algebra $\mathbb{k}[x_1, x_2]$;
- The Weyl algebra $A_1(\mathbb{k}) = \frac{k\{x_1, x_2\}}{x_1x_2 x_2x_1 1};$
- The universal enveloping algebra of the Lie algebra $\mathfrak{n}_2 = \langle x_1, x_2 \rangle$ $[x_2, x_1] = x_1$, that is, $U(\mathfrak{n}_2) = \frac{k\{x_1, x_2\}}{x_2x_1 - x_1x_2 - x_1}$, and
- The quantum plane (Manin's plane) $\mathcal{O}_q(\mathbb{k}) = \mathbb{k}\{x_1, x_2\}/\langle x_2x_1-qx_1x_2\rangle$, where $q \in \mathbb{k} \setminus \{0, 1\},\$

are differentially smooth.

(iii) For the 3-dimensional skew polynomial algebras and diffusion algebras (Ex-ample [2.3](#page-4-0) (iv) and (v)), its differential smoothness was studied by the second author in [\[76\]](#page-58-11).

Remark 2.12. There are examples of algebras that are not differentially smooth. Consider the commutative algebra $A = \mathbb{C}[x, y]/\langle xy \rangle$. A proof by contradiction shows that for this algebra there are no one-dimensional connected integrable calculi over A, so it cannot be differentially smooth $[20, \text{Example } 2.5]$.

In this section, we investigate the differential smoothness of bijective SPBW extensions over the commutative polynomial ring $\mathbb{k}[t]$.

3.1. SPBW extensions in two indeterminates. Consider a SPBW extension of the form $\sigma(\mathbb{k}[t])\langle x_1, x_2\rangle$. From Definition [2.1,](#page-3-1) we get the relations

$$
x_1r(t) = \sigma_1(r(t))x_1 + \delta_1(r(t)), \quad x_2r(t) = \sigma_2(r(t))x_2 + \delta_2(r(t)), \quad \text{and}
$$

$$
x_2x_1 = c_{1,2}(t)x_1x_2 + q_{1,2}^{(0)}(t) + q_{1,2}^{(1)}(t)x_1 + q_{1,2}^{(2)}(t)x_2,
$$

where $r(t)$, $c_{1,2}(t)$, $q_{1,2}^{(0)}(t)$, $q_{1,2}^{(1)}(t)$, $q_{1,2}^{(2)}(t)$ belong to $\mathbb{k}[t]$ with $c_{1,2}(t)$ non-zero.

Let $\sigma_1(t) = a_1t + b_1$ and $\sigma_2(t) = a_2t + b_2$ be automorphisms of $\mathbb{k}[t]$ (this is precisely the form of the elements of Aut $(\mathbb{k}[x])$ [\[86,](#page-58-23) [91\]](#page-59-4)) with the corresponding σ_i -derivations $(i = 1, 2)$ expressed as in (2.11) , that is,

$$
\delta_1(f(t)) = \frac{f(\sigma_1(t)) - f(t)}{\sigma_1(t) - t} p_1(t), \text{ and } \delta_2(f(t)) = \frac{f(\sigma_2(t)) - f(t)}{\sigma_2(t) - t} p_2(t),
$$

where $p_1(t), p_2(t)$ are fixed elements of $\mathbb{k}[t]$. Thus, the relations between the indeterminates t, x_1 and x_2 can be expressed as

(3.1)
$$
x_1t = a_1tx_1 + b_1x_1 + p_1(t), \quad x_2t = a_2tx_2 + b_2x_2 + p_2(t), \text{ and}
$$

$$
(3.2) \t x_2x_1 = c_{1,2}(t)x_1x_2 + q_{1,2}^{(0)}(t) + q_{1,2}^{(1)}(t)x_1 + q_{1,2}^{(2)}(t)x_2.
$$

Proposition [3.1](#page-11-2). From Equation (3.1) , we obtain the commutation relations

$$

where $p'_1(t)$ and $p'_2(t)$ are the t-derivatives of $p_1(t)$ and $p_2(t)$, respectively, and $c_{1,2}, q_{1,2}^{(0)}, q_{1,2}^{(1)}, q_{1,2}^{(2)} \in \mathbb{k}$, with $c_{1,2}$ non-zero. Then:

(1) Leibniz's rule holds in the cases listed in Table [1.](#page-12-0) The maps defined by (3.3) (3.3) (3.3) , (3.4) (3.4) (3.4) and (3.5) (3.5) (3.5) simultaneously extend to algebra automorphisms $\nu_t, \nu_{x_1}, \nu_{x_2}$ of $\sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle$ only in cases (a), (b), (c), (d), (e), (g) and (i).

Notice that expressions (3.7) are the same as in [\[14,](#page-56-13) Lemma 3.1], and that these equations are independent of each other, so we have nine possible combinations for the values of a_1, b_1, a_2 and b_2 . For each of these combinations, equations [\(3.11\)](#page-13-0) and [\(3.14\)](#page-13-1) will be used to determine the possible values for $c_{1,2}$, $p_1(t)$, $p_2(t)$ $q_{1,2}^{(i)}$, $i = 0, 1, 2$. If we focus on the coefficients of x_1 and x_2 , these must be zero, that is, $k_j(1 - c_{1,2}) = 0$ and $m_j(1 - c_{1,2}) = 0$. This implies that $m_j = k_j = 0$, for $1 \leq j \leq n$ and so the polynomials $p_1(t)$ and $p_2(t)$ are constants or $c_{1,2} = 1$. From relations (3.10) , (3.11) , (3.12) and (3.14) , we get that

If $p_1(t) = p_1, p_2(t) = p_2 \in \mathbb{k}$, then $q_{1,2}^{(1)} = q_{1,2}^{(2)} = 0$ and we obtain the following options:

- $c_{1,2} = 1$, $q_{1,2}^{(0)}$ has no restrictions.
- $p_2 = 0$, $q_{1,2}^{(0)} = 0$ and $p_1 = 0$, with no restriction over $c_{1,2}$.

Finally, if $c_{1,2} = 1$ it is necessary that $q_{1,2}^{(1)} m_j + q_{1,2}^{(2)} k_j = 0$ for all $1 \le i \le n$. One possibility is precisely when $m_j = k_j = 0$, which means that $p_1(t)$ and $p_2(t)$ are constants (as in the previous case). The other option is that $q_{1,2}^{(1)} = q_{1,2}^{(2)} = 0$, with no restrictions on the polynomials $p_1(t)$ and $p_2(t)$. We have considered all possible options.

(b) Equation (3.8) leads to the following way of relating the coefficients

- (c) Note that in this case the conditions are the same as in (b) by considering x_2 instead of x_1 .

(f) Equation [\(3.8\)](#page-13-2) becomes

From expression [\(3.10\)](#page-13-3) we have that $c_{1,2}b_1(a_2-1)x_2=0$, where the only options are $c_{1,2} = 0$, $b_1 = 0$ or $a_2 = 1$. However, as it is clear none of these are possible.

- (g) The conditions corresponding to this case are the same as (e) since the hypotheses are completely analogous but replacing the indeterminate x_1 with x_2 .
- (h) This case is the same as (f) by replacing the indeterminate x_1 with x_2 .
- (i) Equation (3.8) leads to the following way of relating the coefficients:

After some computations, we get that $c_{1,2} = 1$, $q_{1,2}^{(0)} = q_{1,2}^{(1)} = q_{1,2}^{(2)} = 0$. Thus, expression [\(3.10\)](#page-13-3) becomes

By replacing the values found previously, we obtain that $b_1 = b_2 = 0$. Finally, note that relations [\(3.11\)](#page-13-0), [\(3.12\)](#page-13-4) and [\(3.14\)](#page-13-1) are trivially satisfied.

For the second assertion, it is enough to prove it for the generators t, x_1 and x_2 :

In any case, the two compositions shown in (3.15) and (3.16) are the same. Relation [\(3.18\)](#page-17-3) was used to find the conditions of the polynomial $p_1(t)$ to be equal to the expression [\(3.17\)](#page-17-4). Thus, all of them are satisfied in every possible case. As it is clear, relation [\(3.20\)](#page-17-5) holds in all cases to be equal to [\(3.19\)](#page-17-6). So, $\nu_t \circ \nu_{x_1} = \nu_{x_1} \circ \nu_t$. Next,

In any case, the two compositions shown in (3.21) are the same. Relation (3.23) was similarly used to find the conditions of the polynomial $p_1(t)$, whence they are satisfied in all cases. Note that relation [\(3.22\)](#page-17-9) works in all cases but case (g) only works when $c_{1,2} = 1$. In this way, $\nu_t \circ \nu_{x_2} = \nu_{x_2} \circ \nu_t$.

In any case, relations [\(3.26\)](#page-17-10), [\(3.27\)](#page-17-11), [\(3.28\)](#page-17-12) and [\(3.29\)](#page-17-13) hold. Expressions [\(3.24\)](#page-17-14) and [\(3.25\)](#page-17-15) coincide when $b_2 = \frac{a_2 - 1}{a_1 - 1}$ b_1 .

Next, we formulate the first important result of the paper.

Theorem 3.3. If a SPBW extension $\sigma(\mathbf{k}[t])\langle x_1, x_2 \rangle$ satisfies one of the conditions (a)-(i), except (f) and (h), in Proposition [3.2,](#page-12-5) then it is differentially smooth.

Proof. We know that SPBW extensions of the form $\sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle$ have Gelfand-Kirillov dimension three [\[74,](#page-58-24) Theorems 14 and 18], so we are able to formulate a three-dimensional integrable calculus. With this aim, consider $\Omega^1(\sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle)$

a free right $\sigma(\mathbb{k}[t])\langle x_1, x_2\rangle$ -module of rank three with generators dt, dx₁ and dx₂. Define a left $\sigma(\mathbb{k}[t])\langle x_1, x_2\rangle$ -module structure by

We want to extend $t \mapsto dt$, $x_1 \mapsto dx_1$ and $x_2 \mapsto dx_2$ to a map $d : \sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle \rightarrow$ $\Omega^1(\sigma(\Bbbk[t])\langle x_1, x_2 \rangle)$ satisfying Leibniz's rule. As expected, this is possible if Leibniz's rule is compatible with the non-trivial relations (3.1) and (3.2) , i.e. if the equalities

hold. In view of $tdt = dt$ which defines the usual commutative calculus on the polynomial ring $\mathbb{k}[t]$, it follows that $dp_1(t) = dt p'_1(t)$ and $dp_2(t) = dt p'_2(t)$.

Then $d(a) = 0$ if and only if $\partial_t(a) = \partial_{x_1}(a) = \partial_{x_2}(a) = 0.$ Using relations [\(3.30\)](#page-18-0) and the definitions of the maps ν_t , ν_{x_1} and ν_{x_2} , we get that

Thus $d(f) = 0$ if and only if f is a scalar multiple of the identity. This shows that $(\Omega(\sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle), d)$ is connected with $\Omega(\sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle) = \bigoplus^3$ $i=0$ $\Omega^{i}(\sigma(\Bbbk[t])\langle x_{1}, x_{2}\rangle).$ The universal extension of d to higher forms compatible with (3.31) , (3.32) and [\(3.33\)](#page-18-3) gives the following rules for $\Omega^2(\sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle)$:

This means that ω is a volume form of $\sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle$. From Proposition [2.9](#page-9-2) (2), ω is an integral form by setting

Therefore, we have proved that $\sigma(\mathbb{k}[t])\langle x_1, x_2 \rangle$ is differentially smooth.

3.2. SPBW extensions in three indeterminates. In this section we develop a similar treatment to the presented in Section [3.1](#page-11-1) but now we consider a SPBW extension of the form $\sigma(\mathbb{k}[t])\langle x_1, x_2, x_3 \rangle$ satisfying the defining relations

where the elements $r(t)$, $c(t)$'s and $q(t)$'s belong to $\mathbb{k}[t]$ with $c_{1,2}(t), c_{1,3}(t)$ and $c_{2,3}(t)$ non-zero. Consider the automorphisms of $\mathbb{k}[t]$ given by $\sigma_i(t) = a_i t + b_i$, for

 $a_i, b_i \in \mathbb{k}$, with $a_i \neq 0$, $i = 1, 2, 3$, with the corresponding σ_i -derivations expressed as in (2.11) , that is,

(1) Leibniz's rule holds in the cases listed in Table [2.](#page-20-0) The maps defined by (3.38) (3.38) (3.38) , (3.39) (3.39) (3.39) and (3.40) (3.40) (3.40) simultaneously extend to algebra automorphisms $\nu_t, \nu_{x_i}, i = 1, 2, 3, \text{ of } \sigma(\text{K}[t])\langle x_1, x_2, x_3 \rangle \text{ in cases (a) - (d)}.$

In this way, we have considered all possibilities.

(b) Equation [\(3.43\)](#page-20-7) leads that the coefficient that accompany x_l must be zero, that is

Proof. Since the SPBW extension $\sigma(\mathbb{k}[t])\langle x_1, x_2, x_3 \rangle$ has Gelfand-Kirillov dimension 4, a 4-dimensional integrable calculus can be constructed. We know that we have to consider $\Omega^1(\sigma(\mathbb{k}[t])\langle x_1, x_2, x_3\rangle)$, a free right $\sigma(\mathbb{k}[t])\langle x_1, x_2, x_3\rangle$ -module of rank 4 with generators dt, dx_1, dx_2, dx_3 . + $dx_1 \wedge dx_3 \pi_{\omega} (-ec_{1,2}^{-1} dt \wedge dx_2 \wedge dx_1 \wedge dx_3)$
+ $dx_2 \wedge dx_3 \pi_{\omega} (fdt \wedge dx_1 \wedge dx_2 \wedge dx_3)$
= $dt \wedge dx_1 a + dt \wedge dx_2 b + dt \wedge dx_3 c$
+ $dx_1 \wedge dx_2 d + dx_1 \wedge dx_3 e + dx_2 \wedge dx_3 f$
= ω'' .

Finally, let

 $\omega''' = dt \wedge dx_1 \wedge dx_2 a + dt \wedge dx_2 \wedge dx_3 b + dx_1 \wedge dx_2 \wedge dx_3 c + dt \wedge dx_1 \wedge dx_3 d,$

with $a, b, c, d \in \mathbb{k}$. Since that

\sum_{i=1}^{3} \omega_i^3 \pi_\omega(\bar{\omega}_i^1 \wedge \omega''') = dt \wedge dx_1 \wedge dx_2 \pi_\omega(-aa_3^{-1}c_{1,3}^{-1}c_{2,3}^{-1}dx_3 \wedge dt \wedge dx_1 \wedge dx_2)
$$

+ $dt \wedge dx_2 \wedge dx_3 \pi_\omega(-ba_1^{-1}dx_1 \wedge dt \wedge dx_2 \wedge dx_3)$
+ $dx_1 \wedge dx_2 \wedge dx_3 \pi_\omega(cdt \wedge dx_1 \wedge dx_2 \wedge dx_3)$
+ $dt \wedge dx_1 \wedge dx_3 \pi_\omega(ac_{1,2}^{-1}a_2^{-1}dx_2 \wedge dt \wedge dx_1 \wedge dx_2)$
= $dt \wedge dx_1 \wedge dx_2 a + dt \wedge dx_2 \wedge dx_3 b + dx_1 \wedge dx_2 \wedge dx_3 c$
+ $dt \wedge dx_1 \wedge dx_3 d = \omega'''$,

we conclude that $\sigma(\mathbb{k}[t])\langle x_1, x_2, x_3 \rangle$ is differentially smooth.

3.3. **SPBW** extensions in n indeterminates. The noncommutative differential geometry of SPBW extensions of the form $\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n \rangle$ satisfying the defining relations

In this case, we consider $\sigma_i(t) = a_i t + b_i$, for $a_i, b_i \in \mathbb{k}$, and $a_i \neq 0, 1 \leq i \leq n$, and the derivations δ_i are motivated by [\(2.11\)](#page-10-0), that is,

 $\nu_{x_i}(x_j) = c_{i,j}x_j + q_{i,j}^{(i)}, \quad \text{for } i < j \quad \text{and} \quad \nu_{x_i}(x_j) = c_{j,i}^{-1}x_j - c_{j,i}^{-1}q_{j,i}^{(i)}, \quad \text{for } i > j,$

where $p'_{i}(t)$ are the t-derivatives of $p_{i}(t)$ for $1 \leq i \leq n$, and $c_{i,j}, q_{i,j}^{(k)} \in \mathbb{k}$, $c_{i,j} \neq 0$, for all $1 \leq i, j, k \leq n$.

- (1) Leibniz's rule holds in the cases listed in Table [3.](#page-27-1)
	- The symbols defined by (3.74) (3.74) (3.74) , (3.75) (3.75) (3.75) and (3.76) (3.76) (3.76) simultaneously extend to algebra automorphisms $\nu_t, \nu_{x_i}, 1 \leq i \leq n$ of $\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n \rangle$ in cases $(a) - (d)$.
- (2) In cases (a) $-$ (d), we have that

Theorem 3.7. If a SPBW extension $\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n \rangle$ satisfies one of the condi-tions (a)-(d) in Lemma [3.6,](#page-26-4) then it is differentially smooth.

Proof. Since $\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n \rangle$ has Gelfand-Kirillov dimension $n + 1$, we can construct an $n+1$ -dimensional integrable. Consider $\Omega^1(\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle)$ a free right $\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n\rangle$ -module of rank $n+1$ with generators dt, dx_1, \ldots, dx_n . Define a left $\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n\rangle$ -module structure by (3.78)

 $adt = dt\nu_t(a)$ and $adx_i = dx_i\nu_{x_i}(a)$, for all $1 \leq i \leq n$, $a \in \sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n \rangle$,

where ν_t and ν_{x_i} with $i = 1, ..., n$ are the algebra automorphisms established in Lemma [3.6.](#page-26-4) The relations in $\Omega^1(\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle)$ are given by

x_i dx_j = dx_j (c_{j,i} x_i + q_{j,i}^{(j)}), \text{ for } i > j.

We want to extend the assignments $t \mapsto dt, x_i \mapsto dx_i, 1 \le i \le n$ to a map

d : \sigma(\mathbb{k}[t]) \langle x_1, \ldots, x_n \rangle \to \Omega^1(\sigma(\mathbb{k}[t]) \langle x_1, \ldots, x_n \rangle)
$$

satisfying the Leibniz's rule, so we need to impose the compatibility between this rule and the non-trivial relations (3.72) and (3.73) . In this way, we have that

dx_j x_i + x_j dx_i = c_{i,j} dx_i x_j + c_{i,j} x_i dx_j + \sum_{k=1}^n q_{i,j}^{(k)} dx_k, \quad \text{for } i < j.

Note that in view of the equality $tdt = dt$, which defines the usual commutative calculus on the polynomial ring $\mathbb{k}[t]$, we get that $dp_i(t) = dp'_i(t)$ for $1 \leq i \leq n$.

Define k-linear maps

\partial_t, \partial_{x_i} : \sigma(\mathbb{k}[t]) \langle x_1, \ldots, x_n \rangle \to \sigma(\mathbb{k}[t]) \langle x_1, \ldots, x_n \rangle, \quad i = 1, \ldots, n,

d(f) = dt \partial_t(f) + \sum_{i=1}^n dx_i \partial_{x_i}(f), \quad \text{for all } f \in \sigma(\mathbb{k}[t]) \langle x_1, \dots, x_n \rangle.

These maps are well-defined since dt and dx_i $(1 \leq i \leq n)$ are free generators of the right $\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle$ -module $\Omega^1(\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle)$. Thus, $d(a)=0$ if and

only if $\partial_t(a) = \partial_{x_i}(a) = 0$ for $1 \leq i \leq n$. Using relations appearing in (3.78) and the definitions of the maps ν_t and ν_{x_i} $(1 \leq i \leq n)$, we obtain that

\partial_t(t^k x_1^{l_1} \cdots x_n^{l_n}) = kt^{k-1} x_1^{l_1} \cdots x_n^{l_n}, \text{ and}

Hence, $d(a) = 0$ if and only if a is a scalar multiple of the identity. This fact shows that $(\Omega(\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n \rangle, d))$ is connected, where

\Omega(\sigma(\mathbb{k}[t])(x_1,\ldots,x_n))=\bigoplus_{i=0}^{n+1}\Omega^i(\sigma(\mathbb{k}[t])(x_1,\ldots,x_n)).

The universal extension of d to higher forms compatible with (3.79) , (3.80) and [\(3.82\)](#page-27-5) gives the following rules for $\Omega^l(\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle)$ (2 $\leq l \leq n$): (3.84)

where where $s_1 \in \{1, \ldots, l\}$ do not appear in Relation $(3.84), q: \{1, \ldots, l\} \rightarrow$ $\{1,\ldots,n\}$ is an injective map, $p:\{1,\ldots,l\}\to \text{Im}(q)$ is an increasing injective map and \sharp is the number of 2-permutations needed to transform q into p, and $P := \{(s, t) \in \{1, \ldots, l\} \times \{1, \ldots, l\} \mid q(s) > q(t)\}.$

Since the automorphisms ν_t , ν_{x_i} , $1 \leq i \leq n$ commute with each other, there are no additional relations to the previous ones, so we get that

\Omega^n(\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle) = \left[\bigoplus_{r=2}^{n-1} dt \wedge dx_1 \wedge \cdots dx_{r-1} \wedge dx_{r+1} \wedge \cdots \wedge dx_n
$$

$$
\oplus dt \wedge dx_2 \wedge \cdots \wedge dx_n \oplus dt \wedge dx_1 \wedge \cdots \wedge dx_{n-1}
$$

$$
\oplus dx_1 \wedge \cdots \wedge dx_n \oplus \sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle.
$$

Now, since

$$
\Omega^{n+1}(\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle)=\omega\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle\cong\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle
$$

as a right and left $\sigma(\kappa|t|)\langle x_1, \ldots, x_n\rangle$ -module, with

\omega = dt \wedge dx_1 \wedge \cdots \wedge dx_n \quad \text{and} \quad \nu_{\omega} = \nu_t \circ \nu_{x_1} \circ \cdots \circ \nu_{x_n},
$$

it follows that ω is a volume form of $\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n \rangle$. In order to make the calculations easier, we consider the following notation $t = x_0$, $c_{0,i} = a_i$ for $1 \le i \le n$. From Proposition [2.9](#page-9-2) (2) we get that ω is an integral form by setting

\bar{\omega}_i^{n+1-j} = (-1)^{\sharp_{i,j}} \prod_{r,s \in P_{i,j}} c_{r,s}^{-1} \bigwedge_{k=j}^n dx_{\bar{p}_{i,j}(k)}, \text{ for } 1 \le i \le \binom{n+1}{j},
$$

for $1 \leq j \leq n+1$ and where

$$
p_{i,j} : \{0, ..., j-1\} \to \{0, ..., n\},
$$
 and
 $\bar{p}_{i,j} : \{j, ..., n\} \to (\text{Im}(p_{i,j}))^c$

(the symbol \Box^c denotes the complement of the set \Box), are increasing injective maps, and $\sharp_{i,j}$ is the number of 2-permutation needed to transform

\{\bar{p}_{i,j}(j),\ldots,\bar{p}_{i,j}(n),p_{i,j}(0),\ldots,p_{i,j}(j-1)\}\quad\text{into the set}\quad\{0,\ldots,n\},\
$$

and

$$
P_{i,j} := \{(s,t) \in \{0,\ldots,j-1\} \times \{j,\ldots,n\} \mid p_{i,j}(s) < \bar{p}_{i,j}(t)\}.
$$

if $\langle f, \Omega i(\tau(\mathbb{F}[t]))\rangle$

Consider $\omega' \in \Omega^j(\sigma(\mathbb{k}[t])\langle x_1,\ldots,x_n\rangle)$, that is,

\omega' = \sum_{i=1}^{\binom{n+1}{j}} \bigwedge_{k=0}^{j-1} dx_{p_{i,j}(k)} b_i, \quad \text{with } b_i \in \mathbb{k}.
$$

\sum_{i=1}^{n+1} \omega_i^j \pi_\omega(\bar{\omega}_i^{n+1-j} \wedge \omega') = \sum_{i=1}^{n+1} \left[\bigwedge_{k=0}^{j-1} dx_{p_i(k)} \right] \cdot \pi_\omega \left[(-1)^{\sharp_{i,j}} \Box^* \wedge \omega' \right]
$$

$$
= \sum_{i=1}^{n+1} \bigwedge_{k=0}^{j-1} dx_{p_{i,j}(k)} b_i = \omega',
$$

where

$$
\square^*:=\prod_{r,s\in P_{i,j}}c_{r,s}^{-1}\bigwedge_{k=j}^n dx_{\bar{p}_{i,j}(k)}.
$$

By Proposition [2.9](#page-9-2) (2), it follows that $\sigma(\mathbb{k}[t])\langle x_1, \ldots, x_n\rangle$ is differentially smooth. \Box

Remark 3.8. Note that there is no unique way to define ω_i^j and $\bar{\omega}_i^{n-j}$. Our way of defining them is because it is the simplest.

4. DIFFERENTIAL SMOOTHNESS OF SPBW EXTENSIONS OVER $\mathbb{k}[t_1, t_2]$

Finally, we investigate the differential smoothness of bijective SPBW extensions over the commutative polynomial ring $\mathbb{k}[t_1, t_2]$.

Aut $(\mathbbk[t_1, t_2])$ are compositions of automorphisms of two types (see McKay and Wang $[65]$, Shestakov and Umirbaev $[86]$ or Van den Essen $[91]$ for more details):

• First type:

(4.1)
$$
t_1 \mapsto a_{11}t_1 + a_{12}t_2 + a_{13}
$$
 and $t_2 \mapsto a_{21}t_1 + a_{22}t_2 + a_{23}$,
where $a_{i,j} \in \mathbb{k}$ and $a_{11}a_{22} - a_{12}a_{21} \neq 0$.
• Second type:

(4.2) $t_1 \longmapsto t_1, \quad t_2 \longmapsto t_2 + h(t_1),$ where $h(t_1) \in \mathbb{k}[t_1]$.

With these facts in our hands, we proceed to study the differential smoothness of SPBW extension on two generators.

4.1. SPBW extensions in two indeterminates. Let $\sigma(\mathbb{k}[t_1, t_2])\langle x_1, x_2\rangle$. From Definition [2.1](#page-3-1) we know that

$$
x_1r(t_1) = \sigma_1(r(t_1))x_1 + \delta_1(r(t_1)), \quad x_2r(t_1) = \sigma_2(r(t_1))x_2 + \delta_2(r(t_1)),
$$

\n
$$
x_1r(t_2) = \sigma_1(r(t_2))x_1 + \delta_1(r(t_2)), \quad x_2r(t_2) = \sigma_2(r(t_2))x_2 + \delta_2(r(t_2)),
$$
 and
\n
$$
x_2x_1 = c_{1,2}(t_1, t_2)x_1x_2 + q_{1,2}^{(0)}(t_1, t_2) + q_{1,2}^{(1)}(t_1, t_2)x_1 + q_{1,2}^{(2)}(t_1, t_2)x_2,
$$

where the polynomials $r(t_1, t_2), c_{1,2}(t_1, t_2), q_{1,2}^{(0)}(t_1, t_2), q_{1,2}^{(1)}(t_1, t_2), q_{1,2}^{(2)}(t_1, t_2)$ belong to $\mathbb{k}[t_1, t_2]$, and $c_{1,2}(t_1, t_2)$ is a non-zero element.

Considering the notation above, we write $\sigma_1, \sigma_2 \in \text{Aut}(\mathbb{k}[t_1, t_2])$ as follows:

$$
\sigma_1(t_1) = a_{111}t_1 + a_{112}t_2 + b_{11},
$$

\n
$$
\sigma_1(t_2) = a_{121}t_1 + a_{122}t_2 + b_{12},
$$

\n
$$
\sigma_2(t_1) = a_{211}t_1 + a_{212}t_2 + b_{21},
$$
 and
\n
$$
\sigma_2(t_2) = a_{221}t_1 + a_{222}t_2 + b_{22}.
$$

As in Section [3.1,](#page-11-1) the polynomials $p_1(t_1, t_2), p_2(t_1, t_2) \in \mathbb{K}[t_1, t_2]$ are considered in such a way that the following identities

x_1t_1 = a_{111}t_1x_1 + a_{112}t_2x_1 + b_{11}x_1 + p_1(t_1, t_2),
$$

\n
$$
x_2t_1 = a_{211}t_1x_2 + a_{212}t_2x_2 + b_{21}x_2 + p_2(t_1, t_2),
$$

\n
$$
x_1t_2 = a_{121}t_1x_1 + a_{122}t_2x_1 + b_{12}x_1 + p_1(t_1, t_2),
$$

\n
$$
x_2t_2 = a_{221}t_1x_2 + a_{222}t_2x_2 + b_{22}x_2 + p_2(t_1, t_2),
$$
 and
\n
$$
x_2x_1 = c_{1,2}(t_1, t_2)x_1x_2 + q_{1,2}^{(0)}(t_1, t_2) + q_{1,2}^{(1)}(t_1, t_2)x_1 + q_{1,2}^{(2)}(t_1, t_2)x_2,
$$

hold. Since the map $d : \sigma(\mathbb{k}[t_1, t_2])\langle x_1, x_2\rangle \to \Omega^1(\sigma(\mathbb{k}[t_1, t_2]))\langle x_1, x_2\rangle$ must satisfy Leibniz's rule, it is straightforward to see that we need to guarantee the conditions

- $c_{1,2}, q_{1,2}^{(0)}, q_{1,2}^{(1)}, q_{1,2}^{(2)} \in \mathbb{k}$, with $c_{1,2}$ non-zero.
- $p_1(t_1, t_2) = p_1$ and $p_2(t_1, t_2) = p_2$, where $p_1, p_2 \in \mathbb{k}$.
- $a_{221} = a_{212} = a_{112} = a_{121} = 0.$

Indeed, the first four relations in (4.3) can be written as

$$
(4.4) \t x_i t_j = a_{ij1} t_1 x_i + a_{ij2} t_2 x_i + b_{ij} x_i + p_i(t_1, t_2), \text{ for } i, j \in \{1, 2\}.
$$

By applying d to (4.4) we get that

+ $b_{ij} dx_i + d(p_i(t_1, t_2)).$

By [\(2.6\)](#page-7-4), the action of the module is written using the automorphisms ν_{t_1}, ν_{t_2} , ν_{x_1} and ν_{x_2} , that is,

From the reasoning above, it can be seen that all partial derivatives must be equal to zero. Equivalently, $c_{1,2}, q_{1,2}^{(0)}, q_{1,2}^{(1)}, q_{1,2}^{(2)} \in \mathbb{k}$, with $c_{1,2}$ a non-zero element of the field k.

At first glance, it seems that compositions $(\nu_{x_1} \circ \nu_{x_2})(t_1)$ and $(\nu_{x_2} \circ \nu_{x_1})(t_1)$ are different. We arrive to the important result of this section.

Theorem 4.2. If a SPBW extension $\sigma(\mathbb{k}[t_1, t_2])\langle x_1, x_2 \rangle$ satisfies one of the condi-tions (a)-(p) in Proposition [4.1,](#page-32-11) then it is differentially smooth.

Proof. As $GK\dim(\sigma(\mathbb{k}[t_1, t_2])\langle x_1, x_2 \rangle) = 4$, we proceed to construct a 4-dimensional integrable calculus. Remark 4.3. Only automorphisms of the form $t_1 \mapsto a_{11}t_1 + a_{12}t_2 + a_{13}, t_2 \mapsto$ $a_{21}t_1 + a_{22}t_2 + a_{23}$, where $a_{i,j} \in \mathbb{k}$ and $a_{11}a_{22} - a_{12}a_{21} \neq 0$ are taken. Sections [4.2](#page-41-0) and [4.3](#page-47-0) contain sufficient conditions to guarantee the differential smoothness of SPBW extensions over $\sigma(\mathbb{k}[t_1, t_2])$ on three and n generators. However, as we saw in the previous sections, the number of cases in which the Leibniz's rule holds increases considerably as we consider more indeterminates on the SPBW extension. Due to this reason, in the next two sections we will not include any table but will simply formulate the adequate conditions to the extension of this rule.

is an increasing injective map, ♯ is the number of 2-permutations needed to transform q into p, and $P := \{(s, t) \in \{1, ..., l\} \times \{1, ..., l\} \mid q(s) > q(t)\}.$

Since the automorphisms $\nu_{t_i}, \nu_{x_j}, i \in \{1,2\}, j \in \{1, \ldots, n\}$ commute with each other, there are no additional relationships to the previous ones, so

$$
\Omega^{n+1}(\sigma(\mathbb{k}[t_1, t_2])\langle x_1, \dots, x_n \rangle) = \left[\bigoplus_{r=2}^{n-1} dt_1 \wedge dt_2 \wedge dx_1 \wedge \dots dx_{r-1} \wedge dx_{r+1} \wedge \dots \wedge dx_n
$$

$$
\oplus dt_1 \wedge dx_1 \wedge \dots \wedge dx_n
$$

$$
\oplus dt_2 \wedge dx_1 \wedge \dots \wedge dx_n \right] \sigma(\mathbb{k}[t_1, t_2])\langle x_1, \dots, x_n \rangle.
$$

Now,

$$
\Omega^{n+2}(\sigma(\mathbb{k}[t_1,t_2])\langle x_1,\ldots,x_n\rangle)=\omega\sigma(\mathbb{k}[t_1,t_2])\langle x_1,\ldots,x_n\rangle\cong\sigma(\mathbb{k}[t_1,t_2])\langle x_1,\ldots,x_n\rangle
$$

as a right and left $\sigma(\mathbb{k}[t_1, t_2])\langle x_1, \ldots, x_n\rangle$ -module, with $\omega = dt_1 \wedge dt_2 \wedge dx_1 \wedge dx_2$ $\cdots \wedge x_n$, where $\nu_\omega = \nu_{t_1} \circ \nu_{t_2} \circ \nu_{x_1} \circ \cdots \circ \nu_{x_n}$, this means that ω is a volume form of $\sigma(\mathbb{k}[t_1, t_2])\langle x_1, \ldots, x_n \rangle$. In order to make the calculations easier, we consider the following notation:

$$
t_1 = x_{-1}, t_2 = x_0, c_{-1,0} = -1, c_{-1,i} = a_{i11}, c_{0,i} = a_{i22},
$$
 for $1 \le i \le n$.

From Proposition [2.9](#page-9-2) (2) we get that ω is an integral form by setting

$$
\omega_i^j = \bigwedge_{k=-1}^{j-2} dx_{p_{i,j}(k)}, \text{ for } 1 \le i \le \binom{n+2}{j}, \text{ and}
$$

$$
\bar{\omega}_i^{n+2-j} = (-1)^{\sharp_{i,j}} \prod_{r,s \in P_{i,j}} c_{r,s}^{-1} \bigwedge_{k=j-1}^n dx_{\bar{p}_{i,j}(k)}, \text{ for } 1 \le i \le \binom{n+2}{j},
$$

for $1 \leq j \leq n+2$, where

$$
p_{i,j} : \{-1, \ldots, j-2\} \to \{-1, \ldots, n\},
$$
 and
 $\bar{p}_{i,j} : \{j-1, \ldots, n\} \to (\text{Im}(p_{i,j}))^c$

(the symbol \Box^c denotes the complement of the set \Box), are increasing injective maps, and $\sharp_{i,j}$ is the number of 2-permutation needed to transform

$$
\{\bar{p}_{i,j}(j-1),\ldots,\bar{p}_{i,j}(n),p_{i,j}(-1),\ldots,p_{i,j}(j-2)\}\ \text{ into the set }\{-1,\ldots,n\},\
$$

and

$$
P_{i,j} := \{(s,t) \in \{-1,\ldots,j-2\} \times \{j-1,\ldots,n\} \mid p_{i,j}(s) < \bar{p}_{i,j}(t)\}.
$$

Consider $\omega' \in \Omega^j(\sigma(\mathbb{k}[t_1, t_2]) \langle x_1, \ldots, x_n \rangle)$, that is,

$$
\omega' = \sum_{i=1}^{\binom{n+2}{j}} \bigwedge_{k=-1}^{j-2} dx_{p_{i,j}(k)} \alpha_i, \text{ with } \alpha_i \in \mathbb{k}.
$$

Then

$$
\sum_{i=1}^{n+2} \omega_i^j \pi_\omega(\bar{\omega}_i^{n+2-j} \wedge \omega') = \sum_{i=1}^{n+2} \left[\bigwedge_{k=-1}^{j-2} dx_{p_i(k)} \right] \cdot \pi_\omega \left[(-1)^{\sharp_{i,j}} \Box^* \wedge \omega' \right]
$$

$$
= \sum_{i=1}^{n+2} \bigwedge_{k=-1}^{j-2} dx_{p_{i,j}(k)} \alpha_i = \omega',
$$

where

$$
\Box^* := \prod_{r,s \in P_{i,j}} c_{r,s}^{-1} \bigwedge_{k=j}^n dx_{\bar{p}_{i,j}(k)}.
$$

Therefore, $\sigma(\mathbb{k}[t_1, t_2])\langle x_1, \ldots, x_n\rangle$ is differentially smooth.

5. Future work

As expected, a natural task is to investigate the differential smoothness of SPBW extensions over commutative polynomial rings on three and more indeterminates. With this aim, we recall briefly some interesting facts on automorphisms of these polynomial rings. We follow Shestakov and Umirbaev's presentation [\[86,](#page-58-23) p. 197].

For $\mathbb{k}[X] = \mathbb{k}[x_1, \ldots, x_n]$, an automorphism $\tau \in \text{Aut}(\mathbb{k}[X])$ is called *elementary* if it has a form

$$
\tau(x_1,\ldots,x_{i-1},x_i,x_{i+1},x_n)\mapsto (x_1,\ldots,x_{i-1},ax_i+f,x_{i+1},\ldots,x_n),
$$

where $0 \neq a \in \mathbb{k}, f \in \mathbb{k}[x_1, \ldots, x_{i-1}, x_{i+1}, \ldots, x_n].$ The subgroup of $\text{Aut}(\mathbb{k}[X])$ generated by all the elementary automorphisms is called tame subgroup, and the elements from this subgroup are called *tame automorphisms* of $\mathbb{K}[X]$. Non-tame automorphisms of $\mathbb{k}[X]$ are called *wild*.

In the literature it has been shown that the automorphisms of polynomial rings and free associative algebras in two indeterminates are tame (e.g. [\[65,](#page-58-25) [91\]](#page-59-4)). Nevertheless, in the case of three or more indeterminates the similar question was open and known as "The generation gap problem" [\[91\]](#page-59-4) or "Tame generators problem" [\[91\]](#page-59-4). The general belief was that the answer is negative, and the best known counterexample is the following automorphism $\sigma \in Aut(\Bbbk[x, y, z])$, constructed by Nagata [\[66\]](#page-58-26):

$$
\sigma(x) = x + (x^2 - yz)z,
$$

\n
$$
\sigma(y) = y + 2(x^2 - yz)x + (x^2 - yz)^2z,
$$
 and
\n
$$
\sigma(z) = z.
$$

Note that Nagata automorphism is stably tame ; that is, it becomes tame after adding new variables. Shestakov and Umirbaev [\[86\]](#page-58-23) gave a negative answer to the above question; in particular, the Nagata automorphism σ is wild.

Since that the study of $Aut(k[x, y, z])$ and $Aut(k[x_1, \ldots, x_n])$ requires greater mathematical techniques that have not been considered at the time when this paper was written, the study of the differential smoothness of SPBW extensions over these polynomial rings will be one of our next tasks.

On the other hand, since Artamonov [\[4\]](#page-55-10), Venegas [\[92\]](#page-59-5) and the second author [\[77\]](#page-58-27) presented some results concerning automorphisms and derivations of SPBW extensions, it is natural to study relationships between this kind of morphisms and those adequate to characterize the smoothness of these extensions. This will also be our topic of interest in the immediate future.
