Global BMO-Sobolev Estimates for Second-Order Linear Elliptic Equations on Lipschitz Domains

Abstract. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. In this article, we establish first-order global regularity estimates in the scale of BMO spaces on Ω for weak solutions to the second-order elliptic equation div($A\nabla u$) = div, f in Ω . This is achieved under minimal regularity assumptions on Ω and the coefficient matrix *A*, utilizing the pointwise multiplier characterization of the BMO space on Ω. As an application, we also obtain global estimates of ∇*u* in the Lebesgue space $L^1(\Omega)$ when *f* belongs to the Hardy space on Ω .

1 Introduction and main results

Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. In this article, we study the second-order elliptic equation in divergence form

(1.1) div(*A*∇*u*) = div *f* in Ω,

with the Dirichlet, the Neumann, or the Robin boundary condition. With minimal regularity assumptions on Ω and the coefficient matrix *A* (see Assumption ($A\&\Omega$ $A\&\Omega$ $A\&\Omega$) for the details), we derive global estimates for ∇u in the scale of BMO spaces on Ω . As applications, we also establish the global estimate for ∇u in the Lebesgue space $L^1(\Omega)$ when *f* belongs to the Hardy space on Ω . The global regularity estimates obtained in this article are natural extensions of the known global Calderón–Zygmund type estimate

$$
||\nabla u||_{L^p(\Omega;\mathbb{R}^n)} \leq C||f||_{L^p(\Omega;\mathbb{R}^n)},
$$

with $p \in (1, \infty)$, where C is a positive constant independent of *u* and *f*. Our work extend this estimate to the endpoint cases of $p = \infty$ and $p = 1$.

To state the main results of this article and related background, we first recall several necessary concepts and notation. Let $n \geq 2$, $\Omega \subset \mathbb{R}^n$ be a domain, and $p \in [1, \infty]$. Recall that the *Lebesgue space L^p*(Ω) is defined to be the set of all measurable functions *f* on Ω satisfying

(1.3)
$$
||f||_{L^{p}(\Omega)} := \begin{cases} \left[\int_{\Omega} |f(x)|^{p} dx \right]^{\frac{1}{p}} < \infty, & p \in [1, \infty), \\ \text{ess sup } |f(x)| < \infty, & p = \infty, \end{cases}
$$

where ess sup_{*x*∈Ω} $|f(x)|$ denotes the *essential supremum* of $|f|$ on Ω . Moreover, for any given $m \in \mathbb{N}$, let

(1.4)
$$
L^{p}(\Omega; \mathbb{R}^{m}) := \{f := (f_{1}, \ldots, f_{m}) : \text{ for any } i \in \{1, \ldots, m\}, f_{i} \in L^{p}(\Omega)\}
$$

with

$$
||f||_{L^p(\Omega;\mathbb{R}^m)}:=\sum_{i=1}^m||f_i||_{L^p(\Omega)}.
$$

Additionally, we denote by $W^{1,p}(\Omega)$ the *Sobolev space on* Ω , equipped with the norm:

$$
||f||_{W^{1,p}(\Omega)} := ||f||_{L^p(\Omega)} + ||\nabla f||_{L^p(\Omega;\mathbb{R}^n)},
$$

where $\nabla f := (f_{x_1}, \ldots, f_{x_n})$ is the *gradient* of *f* and $\{f_{x_i}\}_{i=1}^n$ are the distributional derivatives of *f*. Furthermore, $W_0^{1,p}$ ^{1,*p*}(Ω) is defined to be the *closure* of $C_c^∞(Ω)$ in $W^{1,p}(Ω)$, where $C_c^∞(Ω)$ denotes the set of all infinitely differentiable functions on Ω with compact support contained in Ω .

We assume that the matrix $A := \{a_{i,j}\}_{i,j=1}^n$ is real-valued, bounded, and measurable and satisfies the *uniform ellipticity condition*, that is, there exists a positive constant $\mu_0 \in (0, 1]$ such that, for any $x \in \Omega$ and $\xi := (\xi_1, \ldots, \xi_n) \in \mathbb{R}^n$,

(1.5)
$$
\mu_0 |\xi|^2 \leq \sum_{i,j=1}^n a_{i,j}(x) \xi_i \xi_j \leq \mu_0^{-1} |\xi|^2.
$$

Let $n \ge 2$, $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain, $p \in [1, \infty]$, and $f \in L^p(\Omega; \mathbb{R}^n)$. Denote by $\partial \Omega$ the boundary of Ω and $v := (v_1, \ldots, v_n)$ the *outward unit normal* to $\partial \Omega$. A function *u* is called a *weak solution* of the Neumann problem

(1.6)
$$
\begin{cases} \operatorname{div}(A \nabla u) = \operatorname{div} f & \text{in } \Omega, \\ \frac{\partial u}{\partial \nu} = f \cdot \nu & \text{on } \partial \Omega \end{cases}
$$

if *u* ∈ *W*^{1,*p*}(Ω) and, for any φ ∈ *C*[∞](ℝ^{*n*})</sub> (the set of all infinitely differentiable functions on ℝ^{*n*}),

(1.7)
$$
\int_{\Omega} A(x) \nabla u(x) \cdot \nabla \varphi(x) dx = \int_{\Omega} f(x) \cdot \nabla \varphi(x) dx.
$$

Here and thereafter, $\frac{\partial u}{\partial y}$:= ($A\nabla u$) · *v* denotes the *conormal derivative* of *u* on $\partial\Omega$. The Neumann problem [\(1.6\)](#page-1-0) is said to be *uniquely solvable* if, for any given $f \in L^p(\Omega; \mathbb{R}^n)$, there exists $u \in$ $W^{1,p}(\Omega)$, unique up to a constant, such that [\(1.7\)](#page-1-1) holds. A function *u* is called a *weak solution* of the Dirichlet problem

(1.8)
$$
\begin{cases} \text{div}(A\nabla u) = \text{div}f & \text{in } \Omega, \\ u = 0 & \text{on } \partial\Omega \end{cases}
$$

if $u \in W_0^{1,p}$ ^{1,*p*}(Ω) and [\(1.7\)](#page-1-1) holds for any $\varphi \in C_c^{\infty}(\Omega)$. The Dirichlet problem [\(1.8\)](#page-1-2) is said to be *uniquely solvable* if, for any given $f \in L^p(\Omega;\mathbb{R}^n)$, there exists a unique $u \in W_0^{1,p}$ $_{0}^{1,p}(\Omega)$ such that [\(1.7\)](#page-1-1) holds for any $\varphi \in C_c^{\infty}(\Omega)$.

The global regularity theory of (non-)linear elliptic equations (or systems) in non-smooth domains is a central and compelling area of research in partial differential equations (see, for instance, $[9, 14, 17, 33, 43]$ $[9, 14, 17, 33, 43]$ $[9, 14, 17, 33, 43]$ $[9, 14, 17, 33, 43]$ $[9, 14, 17, 33, 43]$. For the Dirichlet problem (1.8) , the global Calder on–Zygmund type estimate [\(1.2\)](#page-0-0) was obtained in [\[15\]](#page-27-3) for any $p \in (1, \infty)$ under the assumptions that $A \in VMO(\mathbb{R}^n; \mathbb{R}^{n^2})$ (see, for instance, [\[42\]](#page-28-2) for the definition of the VMO space) and $\partial \Omega \in C^{1,1}$, the latter of which was then weakened to $\partial \Omega \in C^1$ in [\[3\]](#page-27-4). Additionally, for any given $p \in (1, \infty)$, the estimate [\(1.2\)](#page-0-0)

was established in [\[7,](#page-27-5) [9\]](#page-27-0) for the Dirichlet problem [\(1.8\)](#page-1-2), under the assumptions that *A* satisfies the (δ, R) -BMO condition (see, for instance, [\[9\]](#page-27-0) for the definition of the (δ, R) -BMO condition) for sufficiently small $\delta \in (0, \infty)$ and that Ω is a bounded Lipschitz domain with small Lipschitz constant or a bounded Reifenberg flat domain (see, for instance, [\[9,](#page-27-0) [8\]](#page-27-6) for the definition of the Reifenberg flat domain). For the Dirichlet problem [\(1.8\)](#page-1-2) with partial small BMO coefficients, the estimate [\(1.2\)](#page-0-0) with any given $p \in (1, \infty)$ was systematically studied in [\[22,](#page-27-7) [34\]](#page-28-3), under the assumption that Ω is a bounded Lipschitz domain with small Lipschitz constant. Meanwhile, for the problem [\(1.8\)](#page-1-2) in a general Lipschitz domain Ω, it was proved in [\[44\]](#page-28-4) that, if *A* is symmetric and $A \in VMO(\mathbb{R}^n; \mathbb{R}^{n^2})$, then [\(1.2\)](#page-0-0) holds for any $p \in (\frac{3}{2})$ $\frac{3}{2} - \varepsilon$, 3 + ε) when $n \ge 3$ or $p \in (\frac{4}{3})$ $\frac{4}{3} - \varepsilon$, 4 + ε) when $n = 2$, where $\varepsilon \in (0, \infty)$ is a positive constant depending only on the Lipschitz constant of Ω and *n*. The range of *p* obtained in [\[44\]](#page-28-4) is sharp for general Lipschitz domains (see [\[44\]](#page-28-4) for the details). We also refer to [\[18,](#page-27-8) [19,](#page-27-9) [23\]](#page-27-10) for more recent progress on the global regularity estimate of the Dirichlet problem [\(1.8\)](#page-1-2).

For the Neumann problem [\(1.6\)](#page-1-0), the estimate [\(1.2\)](#page-0-0) was proved in [\[3\]](#page-27-4) for any $p \in (1, \infty)$, under the assumptions that $A \in VMO(\mathbb{R}^n; \mathbb{R}^{n^2})$ and $\partial \Omega \in C^1$. Furthermore, for any given $p \in (1, \infty)$, when *A* has small BMO coefficients and Ω is a bounded Reifenberg flat domain or *A* has partial small BMO coefficients and Ω is a bounded Lipschitz domain with small Lipschitz constant or a bounded Reifenberg flat domain, the estimate [\(1.2\)](#page-0-0) was established, respectively, in [\[8\]](#page-27-6) and [\[22,](#page-27-7) [20\]](#page-27-11) for the Neumann problem [\(1.6\)](#page-1-0). For the Neumann problem [\(1.6\)](#page-1-0) on a general Lipschitz domain, it was proved in [\[26\]](#page-28-5) that, if *A* is symmetric and $A \in VMO(\mathbb{R}^n; \mathbb{R}^{n^2})$, then [\(1.2\)](#page-0-0) holds for any given $p \in (\frac{3}{2})$ $\frac{3}{2} - \varepsilon$, 3 + ε) when $n \ge 3$ or $p \in (\frac{4}{3})$ $\frac{4}{3} - \varepsilon$, 4 + ε) when $n = 2$, where $\varepsilon \in (0, \infty)$ is a positive constant depending only on the Lipschitz constant of Ω and *n*. It is also worth pointing out that the range of *p* such that [\(1.2\)](#page-0-0) holds obtained in [\[26\]](#page-28-5) is sharp for general Lipschitz domains. We refer to [\[24,](#page-28-6) [19,](#page-27-9) [46\]](#page-28-7) for more results on regularity estimates of the Neumann problem [\(1.6\)](#page-1-0).

The global BMO estimate of the gradient for the weak solution to the Dirichlet problem [\(1.8\)](#page-1-2) was established in [\[1\]](#page-27-12) under the assumptions that the matrix *A* satisfies a log-type BMO condition and $\partial \Omega \in C^{1+\alpha}$ with some $\alpha \in (0, \infty)$. We also point out that the local and the global BMO estimates of the gradient to the weak solution of *p*-Laplace equations were studied in [\[16,](#page-27-13) [5\]](#page-27-14). Global C^1 and weak-type $(1, 1)$ estimates for the problem (1.6) or (1.8) were obtained in [\[18,](#page-27-8) [24,](#page-28-6) [36\]](#page-28-8) under certain Dini continuity assumptions on the matrix *A* and the domain Ω.

In this paper, we demonstrate that, under minimal regularity assumptions on *A* and $\partial\Omega$, the global Calder δ -Zygmund type estimate [\(1.2\)](#page-0-0), with an appropriate modified version, remains valid in the endpoint cases $p = \infty$ and $p = 1$ for both the Dirichlet problem [\(1.8\)](#page-1-2) and the Neumann problem [\(1.6\)](#page-1-0),

To state the main results of this article, we begin by recalling several concepts on Campanato type spaces and BMO type spaces on domains.

In the following, for any $x \in \mathbb{R}^n$ and $r \in (0, \infty)$, we define $B(x, r) := \{y \in \mathbb{R}^n : |y - x| < r\}$. Let $\Omega \subset \mathbb{R}^n$ be a domain. Denote by $L^1_{loc}(\Omega)$ the *set of all locally integrable functions on* Ω .

Definition 1.1. Let $n \ge 2$, $\Omega \subset \mathbb{R}^n$ be a domain, and $p \in [1, \infty)$, and let $\omega : [0, \infty) \to [0, \infty)$ be a continuous and non-decreasing function. The *Campanato type space* $\mathcal{L}^{\omega(\cdot),p}(\Omega)$ is defined to be the set of all $f \in L^1_{loc}(\Omega)$ satisfying

$$
||f||_{\mathcal{L}^{\omega(\cdot),p}(\Omega)}:=\sup_{x\in\Omega,r\in(0,\text{diam}(\Omega))}\frac{1}{\omega(r)}\left[\int_{B(x,r)\cap\Omega}\left|f(y)-(f)_{B(x,r)\cap\Omega}\right|^{p}\,dy\right]^{\frac{1}{p}}<\infty.
$$

Here and thereafter, diam (Ω) := sup{|*x* – *y*| : *x*, *y* $\in \Omega$ } and, for any measurable set $E \subset \Omega$ with $|E| < \infty$ and locally integrable (vector-valued) function *g* on Ω ,

$$
(g)_E := \int_E g(y) \, dy := \frac{1}{|E|} \int_E g(y) \, dy.
$$

When $p = 1$, the space $\mathcal{L}^{\omega(\cdot),p}(\Omega)$ is simply denoted by $\mathcal{L}^{\omega(\cdot)}(\Omega)$. When $\omega \equiv 1$, the space $\mathcal{L}^{\omega(\cdot)}(\Omega)$ is the space of functions of *bounded mean oscillation* on Ω (see, for instance, [\[5,](#page-27-14) [37,](#page-28-9) [38\]](#page-28-10)), and is denoted by $BMO(\Omega)$.

We note that, under mild assumptions on ω and Ω , for any given $p \in [1, \infty)$, the spaces $\mathcal{L}^{\omega(\cdot),p}(\Omega)$ and $\mathcal{L}^{\omega(\cdot)}(\Omega)$ are equivalent (see, for instance, [\[37,](#page-28-9) Theorem 3.1] or Lemma [2.1\)](#page-7-0).

Furthermore, for a bounded open set Ω of \mathbb{R}^n , if, in a neighborhood of each point of $\partial\Omega$, $\partial\Omega$ agrees with the subgraph of a function ψ of $(n - 1)$ variables that belongs to the function space *X*, then we *write* $\partial \Omega \in X$. Similarly, the notation $\partial \Omega \in W^1 X$ means that such function ψ is weakly differentiable and its weak derivatives belong to the space *X*.

Definition 1.2. Let $n \ge 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded domain.

(i) Let $f \in L^1_{loc}(\mathbb{R}^n)$. Then, *f* is said to belong to the *space* BMO(\mathbb{R}^n) if

$$
||f||_{\text{BMO}(\mathbb{R}^n)} := \sup_{B \subset \mathbb{R}^n} \int_B |f(x) - (f)_B| \, dx < \infty,
$$

where the supremum is taken over all balls $B \subset \mathbb{R}^n$.

(ii) The "restricted type" BMO space BMO_r(Ω) on Ω is defined by setting

$$
\text{BMO}_r(\Omega) := \left\{ f \in L^1_{\text{loc}}(\Omega) : \text{ there exists } F \in \text{BMO}(\mathbb{R}^n) \text{ such that } F|_{\Omega} = f \right\}.
$$

For any $f \in BMO_r(\Omega)$, define

 $||f||_{\text{BMO}_r(\Omega)} := \inf \{ ||F||_{\text{BMO}(\mathbb{R}^n)} : F \in \text{BMO}(\mathbb{R}^n) \text{ and } F|_{\Omega} = f \}$

and

$$
||f||_{\text{BMO}_{r,+}(\Omega)} := ||f||_{\text{BMO}_r(\Omega)} + ||f||_{L^2(\Omega)}.
$$

For any given $m \in \mathbb{N}$, the space BMO_{*r*}(Ω ; \mathbb{R}^m) is defined via replacing $L^p(\Omega)$ in [\(1.3\)](#page-0-1) by the aforementioned BMO_{*r*}(Ω) in the definition of $L^p(\Omega; \mathbb{R}^m)$ in [\(1.4\)](#page-1-3).

It is worth mentioning that the spaces $BMO(\Omega)$ and $BMO_r(\Omega)$ are suitable replacements for the Lebesgue space $L^{\infty}(\Omega)$ when studying the boundedness of certain operators or the well-posedness problems of certain partial differential equations (see, for instance, [\[1,](#page-27-12) [4,](#page-27-15) [11,](#page-27-16) [27,](#page-28-11) [28,](#page-28-12) [45\]](#page-28-13)).

Remark 1.3. Let $n \ge 2$ and Ω be a bounded Lipschitz domain of \mathbb{R}^n .

(i) When $p = 2$, by the Lax–Milgram theorem (see, for instance, [\[41,](#page-28-14) Section 1.3.1, Lemma 3.1]), we know that the Neumann problem [\(1.6\)](#page-1-0) and the Dirichlet problem [\(1.8\)](#page-1-2) are uniquely solvable and the estimate [\(1.2\)](#page-0-0) holds. Meanwhile, for the Dirichlet problem [\(1.8\)](#page-1-2), from the divergence theorem, it follows that, for any $f_0 \in \mathbb{R}^n$ and $\varphi \in C_c^{\infty}(\Omega)$,

(1.9)
$$
\int_{\Omega} A(x) \nabla u(x) \cdot \nabla \varphi(x) dx = \int_{\Omega} [f(x) - f_0] \cdot \nabla \varphi(x) dx.
$$

Thus, for any given $p \in (1, \infty)$, if [\(1.2\)](#page-0-0) holds for the Dirichlet problem [\(1.8\)](#page-1-2), then the estimate [\(1.2\)](#page-0-0) also holds for the problem [\(1.8\)](#page-1-2) with *f* replaced by $f - f_0$.

When $p \in (1, \infty)$ and $p \neq 2$, the Neumann problem [\(1.6\)](#page-1-0) and the Dirichlet problem [\(1.8\)](#page-1-2) may not be uniquely solvable (see, for instance, [\[9,](#page-27-0) p. 1285]). Some extra conditions on both the domain Ω and the matrix *A* are necessary to guarantee the unique solvability of the Neumann problem [\(1.6\)](#page-1-0) and the Dirichlet problem [\(1.8\)](#page-1-2) when $p \neq 2$ (see, for instance, [\[8,](#page-27-6) [9,](#page-27-0) [17,](#page-27-2) [22,](#page-27-7) [26,](#page-28-5) [44\]](#page-28-4)).

(ii) By Lemmas [2.1](#page-7-0) and [2.2,](#page-7-1) we conclude that $BMO_r(\Omega) \subset L^p(\Omega)$ for any $p \in (1, \infty)$ as sets. Moreover, it is easy to find that $L^{\infty}(\Omega) \subset BMO_r(\Omega)$. Thus, when $f \in BMO_r(\Omega)$, the weak solution of the Neumann problem [\(1.6\)](#page-1-0) or the Dirichlet problem [\(1.8\)](#page-1-2) uniquely exists in $W^{1,2}$ (Ω) or $W_0^{1,2}$ $0^{1,2}(\Omega).$

To state the main result of this article, we also need an assumption on the matrix *A* and the domain $Ω$ as follows.

Assumption (*A&*Ω). Assume that there exist a constant $R_0 \in (0, \infty)$ and a function $\sigma : [0, \infty) \to$ [0, ∞) such that the matrix *A* := { $a_{i,j}$ }^{*n*}_{*i*,*j*=1} and the domain Ω satisfy the following conditions:

(a)

$$
\sum_{i, j=1}^n \sup_{x \in \Omega, r \in (0, R_0)} \frac{1}{\sigma(r)} \int_{B(x, r) \cap \Omega} \left| a_{i,j}(y) - \int_{B(x, r) \cap \Omega} a_{i,j}(z) \, dz \right| \, dy < \infty,
$$

where the function σ satisfies

- (i) $\lim_{r\to 0^+} \sigma(r) \ln(\frac{1}{r}) = 0$, where $r \to 0^+$ *means* that $r \in (0, R_0)$ and $r \to 0$;
- (ii) for any $s, r \in (0, R_0)$, if $C_1^{-1}s < r < C_1 s$, then $C_2^{-1}\sigma(s) \leq \sigma(r) \leq C_2\sigma(s)$, where C_1 and C_2 are positive constants independent of *s* and *r*;
- (iii) there exists a positive constant *C* such that, for any $s, r \in (0, R_0)$ satisfying $s \le r$, $\sigma(s) \leq C\sigma(r)$.
- (b) $\partial \Omega \in W^1 \mathcal{L}^{\sigma(\cdot)}$ with σ being the same as in (a).

Remark 1.4. In this remark, we show that starting from a modulus of continuity σ , which only satisfies (i) and is bounded on $(0, R_0]$, we can construct another modulus of continuity $\tilde{\sigma} \geq \sigma$, which satisfies all conditions (i)-(iii). Without loss of generality, by considering $\sup_{0 \le s \le r} \sigma(s)$ instead of $\sigma(r)$ we may assume that σ is nondecreasing. Now we define $\tilde{\sigma}(r) := \sup_{r \le s \le R_0} r \sigma(s) / s$ for $r \in (0, 1)$. Then using the factor that $r \ln(1/r)$ is an increasing function on $(0, r_0)$ for small r_0 , it is easily seen that $\tilde{\sigma}$ satisfies (i). Since σ is nondecreasing, for any $r_1, r_2 \in (0, R_0)$ satisfying $r_1 < r_2$, we have

$$
\tilde{\sigma}(r_1) = \sup_{r_1 \le s \le R_0} r_1 \sigma(s)/s \le \max\{\sup_{r_1 \le s \le r_2} r_1 \sigma(s)/s, \sup_{r_2 \le s \le R_0} r_1 \sigma(s)/s\}
$$

$$
\le \max\{\sup_{r_1 \le s \le r_2} r_1 \sigma(r_2)/s, \sup_{r_2 \le s \le R_0} r_2 \sigma(s)/s\} \le \tilde{\sigma}(r_2).
$$

Thus, $\tilde{\sigma}$ also satisfies (iii). Finally, the above inequality together with the fact that $\tilde{\sigma}(r)/r$ is nonincreasing implies (ii).

Now we state the main results of this article.

Theorem 1.5. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Assume that A and Ω *satisfy Assumption* ($A\&\Omega$). Let $u \in W^{1,2}(\Omega)$ be the weak solution to the Neumann problem [\(1.6\)](#page-1-0) *or the Dirichlet problem* [\(1.8\)](#page-1-2) *with* $f \in BMO_r(\Omega;\mathbb{R}^n)$. Then $\nabla u \in BMO_r(\Omega;\mathbb{R}^n)$ *and there exists a positive constant C independent of u and f such that*

$$
||\nabla u||_{BMO_{r,+}(\Omega;\mathbb{R}^n)} \leq C ||f||_{BMO_{r,+}(\Omega;\mathbb{R}^n)}.
$$

Remark 1.6. (i) From the proof of Theorem [1.5,](#page-4-1) we deduce that, for the Dirichlet problem [\(1.8\)](#page-1-2), the estimate [\(1.10\)](#page-4-2) can be reinforced to

$$
||\nabla u||_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)} \leq C||f||_{\text{BMO}_r(\Omega;\mathbb{R}^n)}.
$$

However, the estimate [\(1.11\)](#page-4-3) may *not* hold for the Neumann problem [\(1.6\)](#page-1-0) even when both Ω and *A* are smooth. For example, let *B*₀ := *B*(**0**, 1) be a ball of \mathbb{R}^2 , where **0** denotes the *origin* of \mathbb{R}^2 . For any $(x_1, x_2) \in B_0$, let

$$
A(x_1, x_2) := \begin{pmatrix} \frac{1}{1 + x_1^2} & 0 \\ 0 & \frac{1}{1 + x_2^2} \end{pmatrix} \text{ and } f(x_1, x_2) := (1, 1).
$$

Then $u(x_1, x_2) := (x_1 + x_2) + (x_1^3 + x_2^3)/3$ is a weak solution of the Neumann problem [\(1.6\)](#page-1-0) with $\Omega := B_0$. Obviously, in this case, the coefficient matrix *A* and the domain B_0 satisfy Assumption ($A \& \Omega$ $A \& \Omega$ $A \& \Omega$), $\|\nabla u\|_{\text{BMO}_r(B_0;\mathbb{R}^2)} > 0$, and $\|f\|_{\text{BMO}_r(B_0;\mathbb{R}^2)} = 0$. Thus, the estimate [\(1.11\)](#page-4-3) fails in this case.

- (ii) By [\[1,](#page-27-12) Remark 5.3] and [\[5,](#page-27-14) Theorem 2.2], we find that Assumption (*A*[&](#page-4-0)Ω) on the matrix *A* and the domain Ω in Theorem [1.5](#page-4-1) is *sharp* to guarantee that the estimate [\(1.10\)](#page-4-2) holds.
- (iii) Recall that the global estimate [\(1.10\)](#page-4-2) was established in [\[1,](#page-27-12) Theorem 2.2] for the Dirichlet problem [\(1.8\)](#page-1-2) under the assumption that *A* satisfies Assumption (*A*[&](#page-4-0)Ω)(a) and the domain Ω is bounded and satisfies $\partial Ω \in C^{1+\alpha}$ with some $\alpha \in (0, \infty)$. It is easy to find that, if the bounded domain Ω satisfies $\partial\Omega$ ∈ $C^{1+\alpha}$ with some α ∈ (0, ∞), then Ω satisfies Assumption (*A*[&](#page-4-0)Ω)(b). Thus, Theorem [1.5](#page-4-1) improves [\[1,](#page-27-12) Theorem 2.2] by weakening the assumption on the domain $Ω$.

Moreover, the assertion of Theorem [1.5](#page-4-1) in the case of the Neumann problem [\(1.6\)](#page-1-0) is new even when the domain Ω satisfies $\partial \Omega \in C^{1+\alpha}$ with some $\alpha \in (0, \infty)$.

We prove Theorem [1.5](#page-4-1) by establishing mean oscillation-type estimates for $∇*u*$ and utilizing the equivalent characterization of the space $BMO_r(\Omega)$ (see Lemma [2.2\)](#page-7-1) and the pointwise multiplier characterization of the space $BMO(\Omega)$ (see, for instance, [\[31,](#page-28-15) [38,](#page-28-10) [39,](#page-28-16) [40\]](#page-28-17) or Lemma [2.4\)](#page-8-0). To derive the mean oscillation estimate of ∇*u* in the interior of Ω (see Proposition [5.4\)](#page-23-0), Assumption $(A&\Omega)(a)$ $(A&\Omega)(a)$ $(A&\Omega)(a)$ for the matrix *A* is required.

The main part of the proof of Theorem [1.5](#page-4-1) is to establish the mean oscillation estimate of ∇*u* near the boundary of Ω (see Theorems [5.1](#page-20-0) and [5.3\)](#page-23-1). To achieve this, we employ a flattening technique and the pointwise multiplier characterization of the space $BMO(\Omega)$. In this part, both Assumption $(A&\Omega)(a)$ $(A&\Omega)(a)$ $(A&\Omega)(a)$ on the matrix *A* and Assumption $(A&\Omega)(b)$ on the domain Ω are used.

Next, we recall the definitions of the Hardy space $H^1(\mathbb{R}^n)$ and the "supported type" Hardy space $H_z^1(\Omega)$.

Definition 1.7. Let $n \ge 2$ and Ω be a bounded Lipschitz domain of \mathbb{R}^n , and let $\phi \in C_c^{\infty}(\mathbb{R}^n)$ be non-negative and $\int_{\mathbb{R}^n} \phi(x) dx = 1$. For any $t \in (0, \infty)$ and $x \in \mathbb{R}^n$, define $\phi_t(x) := t^{-n} \phi(x/t)$. A function $f \in L^1(\mathbb{R}^n)$ is said to be in the *Hardy space* $H^1(\mathbb{R}^n)$ if $\mathcal{M}(f) := \sup_{t \in (0,\infty)} |\phi_t * f| \in L^1(\mathbb{R}^n)$. Let

$$
||f||_{H^1(\mathbb{R}^n)} := ||\mathcal{M}(f)||_{L^1(\mathbb{R}^n)}.
$$

The "supported type" *Hardy space* $H_z^1(\Omega)$ is defined by setting

$$
H_z^1(\Omega) := \left\{ f \in H^1(\mathbb{R}^n) : \text{ supp}(f) \subset \overline{\Omega} \right\},\
$$

where $\overline{\Omega}$ denote the *closure* of Ω in \mathbb{R}^n . Moreover, for any $f \in H^1_{z}(\Omega)$, let $||f||_{H^1_{z}(\Omega)} := ||f||_{H^1(\mathbb{R}^n)}$.

Like the spaces BMO(Ω) and BMO_{*r*}(Ω), the Hardy space $H^1(\mathbb{R}^n)$ or $H^1_z(\Omega)$ is respectively a suitable replacement of the Lebesgue space $L^1(\mathbb{R}^n)$ or $L^1(\Omega)$ (see, for instance, [\[10,](#page-27-17) [11,](#page-27-16) [12,](#page-27-18) [28,](#page-28-12) [45\]](#page-28-13)).

As an application of Theorem [1.5](#page-4-1) and using the fact that $BMO_r(\Omega)$ is the dual space of the Hardy space $H_z^1(\Omega)$ (see, for instance, Lemma [2.3\)](#page-8-1), we obtain the following global regularity estimate in $L^1(\Omega; \mathbb{R}^n)$ for the problems [\(1.6\)](#page-1-0) and [\(1.8\)](#page-1-2).

Corollary 1.8. *Let* $n \ge 2$ *and* Ω ⊂ \mathbb{R}^n *be a bounded Lipschitz domain. Assume that A and* Ω *satisfy Assumption [\(A](#page-4-0)*&Ω*). Then the Neumann problem* [\(1.6\)](#page-1-0) *or the Dirichlet problem* [\(1.8\)](#page-1-2) $with f \in H^1_{z}(\Omega; \mathbb{R}^n)$ *is uniquely solvable and the weak solution u belongs to* $W^{1,1}(\Omega)$ *or* $W_0^{1,1}(\Omega)$ *, respectively. Moreover, there exists a positive constant C independent of u and f such that*

$$
\|\nabla u\|_{L^1(\Omega;\mathbb{R}^n)} \leq C \|f\|_{H^1_z(\Omega;\mathbb{R}^n)}.
$$

Recall that the global estimate (1.2) for the problem (1.6) or (1.8) in the scale of Lebesgue spaces $L^p(\Omega)$ with any given $p \in (1, \infty)$ holds under some mild assumptions on *A* and Ω . Moreover, global C^1 and weak-type $(1, 1)$ estimates for the problem (1.6) or (1.8) were obtained in [\[18,](#page-27-8) [24\]](#page-28-6) under the Dini mean oscillation condition on *A* and the $C^{1,\text{Dini}}$ condition on Ω, which are somewhat stronger than those assumptions on *A* and Ω in Theorem [1.5](#page-4-1) and Corollary [1.8.](#page-6-0) Thus, the endpoint type global estimates given in Theorem [1.5](#page-4-1) and Corollary [1.8](#page-6-0) can be seen as an in-termediate case between the global estimate [\(1.2\)](#page-0-0) in the scale of Lebesgue spaces $L^p(\Omega)$ with any given $p \in (1, \infty)$ and the global C^1 estimate for the problem [\(1.6\)](#page-1-0) or [\(1.8\)](#page-1-2).

Our last result is regarding the Robin problem. Let $n \geq 2$, $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain, and *d*σ be the *surface measure* on ∂Ω. Assume that β is a measurable function on ∂Ω satisfying that

(1.12)
$$
0 \leq \beta \in L^{\infty}(\partial \Omega) \text{ and } \beta \geq c_0 \text{ on } E_0 \subset \partial \Omega,
$$

where $c_0 \in (0, \infty)$ is a given constant and the measurable set E_0 satisfies $\sigma(E_0) > 0$. Let $p \in [1, \infty]$ and $f \in L^p(\Omega; \mathbb{R}^n)$. A function *u* is called a *weak solution* of the Robin problem

(1.13)
$$
\begin{cases} \operatorname{div}(A \nabla u) = \operatorname{div} f & \text{in } \Omega, \\ \frac{\partial u}{\partial \nu} + \beta u = f \cdot \nu & \text{on } \partial \Omega \end{cases}
$$

if $u \in W^{1,p}(\Omega)$ and, for any $\varphi \in C^{\infty}(\mathbb{R}^n)$,

$$
(1.14) \qquad \int_{\Omega} A(x) \nabla u(x) \cdot \nabla \varphi(x) \, dx + \int_{\partial \Omega} \beta(x) u(x) \varphi(x) \, d\sigma(x) = \int_{\Omega} f(x) \cdot \nabla \varphi(x) \, dx.
$$

The Robin problem [\(1.13\)](#page-6-1) is said to be *uniquely solvable* if, for any given $f \in L^p(\Omega; \mathbb{R}^n)$, there exists a unique $u \in W^{1,p}(\Omega)$ such that [\(1.14\)](#page-6-2) holds. It is known that, when $p = 2$, the Robin problem [\(1.13\)](#page-6-1) is uniquely solvable (see Remark [6.1\)](#page-25-0).

Applying Theorem [1.5](#page-4-1) and a perturbation method, we obtain the following global regularity estimate for the Robin problem [\(1.13\)](#page-6-1) in both $BMO_r(\Omega;\mathbb{R}^n)$ and $L^1(\Omega;\mathbb{R}^n)$.

Theorem 1.9. *Let* $n \geq 2$, $\Omega \subset \mathbb{R}^n$ *be a bounded Lipschitz domain, and* β *satisfies* [\(1.12\)](#page-6-3)*.* Assume *that A and* Ω *satisfy Assumption [\(A](#page-4-0)*&Ω*).*

(i) Let $u \in W^{1,2}(\Omega)$ be the weak solution to the Robin problem [\(1.13\)](#page-6-1) with $f \in BMO_r(\Omega;\mathbb{R}^n)$. *Then* $\nabla u \in BMO_r(\Omega;\mathbb{R}^n)$ *and there exists a positive constant C independent of both u and f such that*

$$
\|\nabla u\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)} \leq C\, \|f\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)}
$$

.

(ii) *The Robin problem* [\(1.13\)](#page-6-1) *with* $f \in H^1_z(\Omega;\mathbb{R}^n)$ *is uniquely solvable and the weak solution u* ∈ *W*1,¹ (Ω)*. Furthermore, there exists a positive constant C independent of u and f such that*

$$
\|\nabla u\|_{L^1(\Omega;\mathbb{R}^n)} \leq C \|f\|_{H^1_{\zeta}(\Omega;\mathbb{R}^n)}.
$$

Remark 1.10. We point out that Theorems [1.5](#page-4-1) and [1.9](#page-6-4) and Corollary [1.8](#page-6-0) also hold for elliptic systems satisfying the strong ellipticity condition (see, for instance, [\[25,](#page-28-18) (1.2)]). This is because the proofs of these results only use the $W^{1,p}$ estimates for elliptic equations, which is also available for the corresponding elliptic systems (see, for instance, [\[21,](#page-27-19) [20,](#page-27-11) [25\]](#page-28-18)). We omit the details in this article.

The remainder of this article is organized as follows. In Section [2,](#page-7-2) we present some basic properties of the space $\mathcal{L}^{\sigma(\cdot),p}(\Omega)$, an equivalent characterization of the space BMO_{*r*}(Ω), and the pointwise multiplier characterization of the space $BMO(\Omega)$. In Section [3,](#page-8-2) some estimates for local solutions to the second-order elliptic equation (1.1) are given. In Section [4,](#page-10-0) we establish the mean oscillation-type decay estimate of the gradient of solutions to the problem (1.6) or (1.8) near the boundary of Ω . Finally, the proofs of Theorems [1.5](#page-4-1) and [1.9](#page-6-4) are given, respectively, in Sections [5](#page-20-1) and [6.](#page-25-1)

We finish this section by making some conventions on notation. Throughout the article, we always denote by *C* or *c* a *positive constant*, which may vary from line to line. We also use $C_{(\alpha,\beta,...)}$ or $c_{(\alpha,\beta,...)}$ to denote a positive constant depending on the indicated parameters $\alpha,\beta,...$. The *symbol f* ≤ *g* means that *f* ≤ *Cg*. If *f* ≤ *g* and *g* ≤ *f*, then we write *f* ∼ *g*. For each ball *B* := *B*(*x_B*, *r_B*) in \mathbb{R}^n , with $x_B \in \mathbb{R}^n$ and $r_B \in (0, \infty)$, and $\alpha \in (0, \infty)$, let $\alpha B := B(x_B, \alpha r_B)$. For any given normed spaces X and Y with the corresponding norms $\|\cdot\|_X$ and $\|\cdot\|_y$, the *symbol* $X \hookrightarrow Y$ means that, for any $f \in X$, $f \in Y$ and $||f||_Y \le C||f||_X$ with the positive constant *C* independent of *f*. For any given $n \times n$ matrix **T**, denote by **T**^t its *transpose matrix*, by **T**⁻¹ its *inverse matrix* (if the inverse matrix of **T** exists), and by det**T** the *determinant* of **T**. Furthermore, for any $q \in [1, \infty]$, we denote by q' its *conjugate exponent*, that is, $1/q + 1/q' = 1$. Finally, for any measurable set $E \subset \mathbb{R}^n$ and any (vector-valued or matrix-valued) function $f \in L^1(E)$, we denote the integral $\int_E |f(x)| dx$ simply by $\int_E |f| dx$.

2 Preliminaries

In this section, we recall some basic properties of the space $\mathcal{L}^{\sigma(\cdot),p}(\Omega)$, an equivalent characterization of the space BMO_{*r*}(Ω), and the pointwise multiplier characterization of the space BMO(Ω). For the space $\mathcal{L}^{\sigma(\cdot),p}(\Omega)$, we have the following result; see [\[37,](#page-28-9) Theorem 3.1].

Lemma 2.1. *Let* $n \geq 2$, $\Omega \subset \mathbb{R}^n$ *be a bounded Lipschitz domain, and* $p \in [1, \infty)$ *. Assume that the function* σ : $[0, \infty) \rightarrow [0, \infty)$ *satisfies (ii) and (iii) of Assumption [\(A](#page-4-0)&*Ω*)(a). Then the spaces* $\mathcal{L}^{\sigma(\cdot)}(\Omega) = \mathcal{L}^{\sigma(\cdot),p}(\Omega)$ with equivalent semi-norms.

Furthermore, we have the following equivalence of the spaces BMO(Ω) and BMO*r*(Ω).

Lemma 2.2. *Let* $n \geq 2$ *and* $\Omega \subset \mathbb{R}^n$ *be a bounded Lipschitz domain. Then the spaces* $BMO(\Omega)$ = $BMO_r(\Omega)$ *with equivalent semi-norms.*

Proof. By Jones's extension theorem on the BMO space (see [\[32,](#page-28-19) Theorem 1]), we know that the spaces

$$
\widetilde{\mathrm{BMO}}(\Omega) = \mathrm{BMO}_r(\Omega)
$$

with equivalent semi-norms. Here and thereafter, the *space* $\widetilde{BMO}(\Omega)$ is defined to be the set of all functions $f \in L^1_{loc}(\Omega)$ satisfying

$$
||f||_{\widetilde{\text{BMO}}(\Omega)} := \sup_{B \subset \Omega} \int_B |f(x) - (f)_B| \, dx < \infty,
$$

where the supremum is taken over all balls $B \subset \Omega$.

From the definitions of BMO(Ω) and BMO(Ω), we deduce that

$$
BMO(\Omega) \hookrightarrow \widetilde{BMO}(\Omega),
$$

which, combined with [\(2.1\)](#page-7-3), further implies that $BMO(\Omega) \hookrightarrow BMO_r(\Omega)$.

Thus, to finish the proof of the present lemma, it suffices to show that $BMO_r(\Omega) \subset BMO(\Omega)$ and, for any $f \in BMO_r(\Omega)$,

$$
||f||_{\text{BMO}(\Omega)} \lesssim ||f||_{\text{BMO}_{r}(\Omega)}.
$$

Let $f \in BMO_r(\Omega)$. Then there exists $\widetilde{f} \in BMO(\mathbb{R}^n)$ such that $\widetilde{f}|_{\Omega} = f$ and $\|\widetilde{f}\|_{BMO(\mathbb{R}^n)} \sim$ $||f||_{\text{BMO}_r(\Omega)}$.

Now, we prove that $f \in \text{BMO}(\Omega)$ and [\(2.2\)](#page-8-3) holds. Let $B := B(x_0, r_0) \subset \mathbb{R}^n$ with $x_0 \in \overline{\Omega}$ and $r_0 \in (0, \text{diam}(\Omega))$. By the geometrical property of Lipschitz domains (see, for instance, [\[33,](#page-28-0) p. 4]), we have $|B \cap \Omega| \sim |B|$, which further implies that

(2.3)
$$
\int_{B \cap \Omega} |f(y) - (f)_{B \cap \Omega}| dy \le \int_{B} \left| \widetilde{f}(y) - (\widetilde{f})_{B \cap \Omega} \right| dy
$$

$$
\le \int_{B} \left| \widetilde{f}(y) - (\widetilde{f})_{B} \right| dy + \int_{B \cap \Omega} \left| \widetilde{f}(y) - (\widetilde{f})_{B} \right| dy
$$

$$
\le \int_{B} \left| \widetilde{f}(y) - (\widetilde{f})_{B} \right| dy \le \left\| \widetilde{f} \right\|_{\text{BMO}(\mathbb{R}^{n})} \sim \| f \|_{\text{BMO}_{r}(\Omega)}.
$$

Therefore, from [\(2.3\)](#page-8-4), it follows that $f \in BMO(\Omega)$ and [\(2.2\)](#page-8-3) holds. This finishes the proof of Lemma [2.2.](#page-7-1) \Box

Using [\[13,](#page-27-20) Theorem A.8] on the atomic characterization of the Hardy space $H_z^1(\Omega)$, similarly to the proof of [\[10,](#page-27-17) Theorem 2.1] (see also [\[37,](#page-28-9) Theorem 4.2]), we obtain the following dual results between $H_z^1(Ω)$ and BMO_{*r*}($Ω$); we omit its proof.

Lemma 2.3. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Then the dual space of $H^1_z(\Omega)$ is BMO_r(Ω).

Let $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Denote by $M(BMO(\Omega))$ the space of pointwise multipliers of BMO(Ω), namely the space of all functions *g* such that $fg \in BMO(\Omega)$ for any *f* ∈ BMO(Ω), endowed with the *norm*

 $||g||_{M(BMO(\Omega))} := \sup{||fg||_{BMO(\Omega)} : f \in BMO(\Omega), ||f||_{BMO(\Omega)} \leq 1}.$

Then the following equivalent characterization for $M(BMO(\Omega))$ is well known (see, for instance, [\[31,](#page-28-15) [38,](#page-28-10) [39\]](#page-28-16)).

Lemma 2.4. *Let* $n \geq 2$ *and* $Ω ⊂ ℝⁿ$ *be a bounded Lipschitz domain. Then*

$$
M(BMO(\Omega)) = L^{\infty}(\Omega) \cap L^{\sigma_0(\cdot)}(\Omega),
$$

 $where, for any r \in (0, diam (\Omega)), \sigma_0(r) := (1 + |\ln r|)^{-1}.$

3 Local solution estimates

In this section, we establish several estimates for local solutions to second-order elliptic equa-tions [\(1.1\)](#page-0-2) in the domain Ω .

Let $n \ge 2$, $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain, and the matrix *A* be the same as in [\(1.5\)](#page-1-4). A function $u \in W^{1,2}_{loc}(\Omega)$ is called a *local weak solution* to the equation [\(1.1\)](#page-0-2) if, for any domain *O* satisfying $\overline{O} \subset \Omega$ and any $\varphi \in C_c^{\infty}(O)$,

(3.1)
$$
\int_{O} A(x) \nabla u(x) \cdot \nabla \varphi(x) dx = \int_{O} f(x) \cdot \nabla \varphi(x) dx
$$

holds.

Assume that $B \subset \Omega$ is a ball and *u* is a local weak solution to the equation [\(1.1\)](#page-0-2). Then we consider a weak solution $v \in W^{1,2}(B)$ to the Dirichlet problem

(3.2)
$$
\begin{cases} \operatorname{div}(A\nabla v) = 0 & \text{in } B, \\ v = u & \text{on } \partial B, \end{cases}
$$

where the matrix *A* is the same as in the problem [\(1.6\)](#page-1-0). We also point out that, as usual, the boundary condition in [\(3.2\)](#page-9-0) is understood in the sense that $u - v \in W_0^{1,2}$ $b_0^{1,2}(B)$.

For the Dirichlet problem [\(3.2\)](#page-9-0), we have the following estimate.

Lemma 3.1. *Let* $n \geq 2$, $\Omega \subset \mathbb{R}^n$ *be a bounded Lipschitz domain, and* $B \subset \Omega$ *be a ball. Assume that u is a local weak solution to the equation* [\(1.1\)](#page-0-2) *and v is a weak solution to the problem* [\(3.2\)](#page-9-0)*. Then there exists a positive constant C, independent of u, v, f, and B, such that, for any* $f_0 \in \mathbb{R}^n$,

$$
\int_B |\nabla u(x) - \nabla v(x)|^2 dx \le C \int_B |f(x) - f_0|^2 dx.
$$

Proof. Recall that *v* is a weak solution to the Dirichlet problem [\(3.2\)](#page-9-0). Choosing $u - v \in W_0^{1,2}$ $i_0^{1,2}(B)$ as a test function in [\(3.1\)](#page-9-1) and using the uniform ellipticity condition [\(1.5\)](#page-1-4), we have, for any $f_0 \in \mathbb{R}^n$,

$$
\int_{B} |\nabla u(x) - \nabla v(x)|^2 dx \le \mu_0^{-1} \int_{B} A(x) \nabla (u - v)(x) \cdot \nabla (u - v)(x) dx
$$

$$
= \mu_0^{-1} \int_{B} A(x) \nabla u(x) \cdot \nabla (u - v)(x) dx
$$

$$
= \mu_0^{-1} \int_{B} [f(x) - f_0] \cdot \nabla (u - v)(x) dx,
$$

which, combined with Young's inequality, further implies that, for any given $\delta \in (0, 1)$,

$$
(3.3) \qquad \int_B |\nabla u(x) - \nabla v(x)|^2 \, dx \le \delta \int_B |\nabla u(x) - \nabla v(x)|^2 \, dx + C_{(\delta)} \int_B \left| f(x) - f_0 \right|^2 \, dx.
$$

Taking $\delta := \frac{1}{2}$ $\frac{1}{2}$ in [\(3.3\)](#page-9-2), we then find that, for any given $f_0 \in \mathbb{R}^n$,

$$
\int_B |\nabla u(x) - \nabla v(x)|^2 dx \le \int_B |f(x) - f_0|^2 dx.
$$

This finishes the proof of Lemma [3.1.](#page-9-3) \square

We also have the following mean oscillation estimate for local solutions of (1.1) .

Proposition 3.2. Let $n \geq 2$, $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain, and $\delta \in (0,1)$. Assume *that u is a local weak solution to the equation* [\(1.1\)](#page-0-2)*, where A is a constant matrix and satisfies the uniform ellipticity condition* [\(1.5\)](#page-1-4)*. Then there exist positive constants C depending only on n and* µ0*, but independent of* δ*, and C*(*n*,µ0,δ) *, depending only on n,* µ0*, and* δ*, such that, for any ball* $B \subset \Omega$ *and* $f_0 \in \mathbb{R}^n$,

(3.4)
$$
\left[\int_{\delta B} |\nabla u(x) - (\nabla u)_{\delta B}|^2 dx\right]^{\frac{1}{2}} \leq C\delta \left[\int_B |\nabla u(x) - (\nabla u)_{B}|^2 dx\right]^{\frac{1}{2}} + C_{(n,\mu_0,\delta)} \left[\int_B \left|f(x) - f_0\right|^2 dx\right]^{\frac{1}{2}}.
$$

Proof. Fix a ball $B \subset \Omega$. Let *v* be a weak solution to the Dirichlet problem [\(3.2\)](#page-9-0). From [\[29,](#page-28-20) Lemma 3.10], it follows that

$$
\left[\oint_{\delta B} |\nabla v(x) - (\nabla v)_{\delta B}|^2 \, dx\right]^{\frac{1}{2}} \leq C\delta \left[\oint_B |\nabla v(x) - (\nabla v)_B|^2 \, dx\right]^{\frac{1}{2}},
$$

where *C* is a positive constant independent of δ , *B*, and *v*. By this and Lemma [3.1,](#page-9-3) we conclude that, for any $f_0 \in \mathbb{R}^n$,

$$
\left[\oint_{\delta B} |\nabla u(x) - (\nabla u)_{\delta B}|^2 dx\right]^{\frac{1}{2}} \leq \left[\oint_{\delta B} |\nabla u(x) - (\nabla v)_{\delta B}|^2 dx\right]^{\frac{1}{2}}
$$
\n
$$
\leq \left[\oint_{\delta B} |\nabla u(x) - \nabla v(x)|^2 dx\right]^{\frac{1}{2}} + \left[\oint_{\delta B} |\nabla v(x) - (\nabla v)_{\delta B}|^2 dx\right]^{\frac{1}{2}}
$$
\n
$$
\leq C\delta^{-n/2} \left[\oint_B |f(x) - f_0|^2 dx\right]^{\frac{1}{2}} + C\delta \left[\oint_B |\nabla v(x) - (\nabla v)_B|^2 dx\right]^{\frac{1}{2}}
$$
\n
$$
\leq C\delta^{-n/2} \left[\oint_B |f(x) - f_0|^2 dx\right]^{\frac{1}{2}} + C\delta \left[\oint_B |\nabla u(x) - (\nabla u)_B|^2 dx\right]^{\frac{1}{2}}
$$
\n
$$
+ C\delta \left[\oint_B |\nabla u(x) - \nabla v(x)|^2 dx\right]^{\frac{1}{2}}
$$
\n
$$
\leq C\delta \left[\oint_B |\nabla u(x) - (\nabla u)_B|^2 dx\right]^{\frac{1}{2}} + C\delta^{-n/2} \left[\oint_B |f(x) - f_0|^2 dx\right]^{\frac{1}{2}}.
$$

Thus, (3.4) holds. This finishes the proof of Proposition [3.2.](#page-9-5)

4 Mean oscillation-type decay estimates near the boundary

In this section, we establish mean oscillation-type decay estimates of the gradient of the solution to the problem [\(1.6\)](#page-1-0) or [\(1.8\)](#page-1-2) near the boundary of Ω . To achieve this, we need to prove a Gehring type estimate for the gradient of solutions to the problem [\(1.6\)](#page-1-0) or [\(1.8\)](#page-1-2) near the boundary of Ω and to use a flattening technique and the pointwise multiplier characterization of the space $BMO(Ω)$.

4.1 A Gehring type estimate near the boundary

In this subsection, we give a Gehring type estimate for the gradient of solutions to the problem [\(1.6\)](#page-1-0) or [\(1.8\)](#page-1-2) near the boundary of Ω and the mean oscillation-type decay estimate for the gradient of the solution to the problem [\(1.6\)](#page-1-0) or [\(1.8\)](#page-1-2) in the interior of Ω .

The following Proposition [4.1](#page-10-1) is known to the expert. However, we give its proof in this subsection for the sake of completeness.

Proposition 4.1. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Assume that u is a *weak solution to the Neumann problem* [\(1.6\)](#page-1-0) *with* $f \in L^2(\Omega;\mathbb{R}^n)$. Then there exists a constant q_0 ∈ (2, ∞)*, depending on n, μ*₀*, A, and* Ω*, such that, for any given* q ∈ (2, q_0 *), any ball B* := $B(x_0, r_0) \subset \mathbb{R}^n$ *with* $x_0 \in \overline{\Omega}$ *and* $r_0 \in (0, \text{diam}(\Omega))$ *, and any* $f_0 \in \mathbb{R}^n$ *,*

(4.1)
$$
\int_{B} |\nabla u(x)|^{q} dx \leq C \left[\left(\int_{2B} |\nabla u(x)| dx \right)^{q} + \int_{2B} |f(x) - f_{0}|^{q} dx \right]
$$

when $2B \subset \Omega$ *, and*

(4.2)
$$
\int_{B\cap\Omega}|\nabla u(x)|^q dx \leq C\left[\left(\int_{2B\cap\Omega}|\nabla u(x)| dx\right)^q + \int_{2B\cap\Omega} |f(x)|^q dx\right]
$$

 $when 2B \cap \partial\Omega \neq 0$, where C is a positive constant depending only on n, μ_0 , and Ω , but independent *of B*, *u, and f.*

Proof. Let $B := B(x_0, r_0)$ be the same as the present proposition and $\eta \in C_c^{\infty}(\mathbb{R}^n)$ satisfy that $0 \le \eta \le 1$, $\eta \equiv 1$ on *B*, supp $(\eta) \subset \frac{3}{2}$ $\frac{3}{2}B$, and $|\nabla \eta| \le r_0^{-1}$. We first assume that $2B \subset \Omega$. In this case, taking $\eta^2[u - (u)_{2B}]$ as a test function, we obtain that, for any $f_0 \in \mathbb{R}^n$,

$$
\int_{\Omega} A(x) \nabla u(x) \cdot \nabla \left(\eta^2 \left[u - (u)_{2B} \right] \right)(x) dx = \int_{\Omega} f(x) \cdot \nabla \left(\eta^2 \left[u - (u)_{2B} \right] \right)(x) dx
$$

=
$$
\int_{\Omega} \left[f(x) - f_0 \right] \cdot \nabla \left(\eta^2 \left[u - (u)_{2B} \right] \right)(x) dx,
$$

which further implies that

$$
\int_{\Omega} \left[\eta(x)\right]^2 A(x) \nabla u(x) \cdot \nabla u(x) dx = -\int_{\Omega} 2\eta(x) \left[u(x) - (u)_{2B}\right] A(x) \nabla u(x) \cdot \nabla \eta(x) dx \n+ \int_{\Omega} \left[\eta(x)\right]^2 \left[f(x) - f_0\right] \cdot \nabla u(x) dx \n+ \int_{\Omega} 2\eta(x) \left[u(x) - (u)_{2B}\right] \left[f(x) - f_0\right] \cdot \nabla \eta(x) dx.
$$

From this, the uniform ellipticity condition [\(1.5\)](#page-1-4), and Young's inequality, it follows that, for any given $\varepsilon \in (0, 1)$,

$$
(4.3) \qquad \int_{2B} |\nabla u(x)|^2 \left[\eta(x)\right]^2 dx \le \mu_0^{-1} \int_{2B} [\eta(x)]^2 A(x) \nabla u(x) \cdot \nabla u(x) dx
$$

$$
\le \varepsilon \int_{2B} |\nabla u(x)|^2 \left[\eta(x)\right]^2 dx + C_{(\varepsilon)} \int_{2B} \left|f(x) - f_0\right|^2 \left[\eta(x)\right]^2 dx
$$

$$
+ C_{(\varepsilon)} r_0^{-2} \int_{2B} |u(x) - (u)_{2B}|^2 dx.
$$

Take $\varepsilon := 1/2$ in [\(4.3\)](#page-11-0). Then, by (4.3), the assumption that $\eta \equiv 1$ on *B*, and the Sobolev–Poincaré inequality (see, for instance, [\[6,](#page-27-21) Theorem 1.1]), we further deduce that

$$
(4.4) \qquad \left[\oint_B |\nabla u(x)|^2\,dx\right]^{\frac{1}{2}} \lesssim \left[\oint_{2B} |\nabla u(x)|^{\frac{2n}{n+2}}\,dx\right]^{\frac{n+2}{2n}} + \left[\oint_{2B} \left|f(x) - f_0\right|^2\,dx\right]^{\frac{1}{2}}.
$$

Using [\(4.4\)](#page-11-1) and a version of Gehring's lemma as in [\[30\]](#page-28-21), we conclude that there exists an exponent *q*₀ ∈ (2, ∞) such that, for any given *q* ∈ (2, *q*₀), the estimate [\(4.1\)](#page-10-2) holds.

Next, assume that $2B \cap \partial\Omega \neq \emptyset$. In this case, taking $\eta^2[u - (u)_{2B \cap \Omega}]$ as a test function, we then have

(4.5)
$$
\int_{\Omega} A(x) \nabla u(x) \cdot \nabla \left(\eta^2 \left[u - (u)_{2B \cap \Omega} \right] \right)(x) dx = \int_{\Omega} f(x) \cdot \nabla \left(\eta^2 \left[u - (u)_{2B \cap \Omega} \right] \right)(x) dx.
$$

Using [\(4.5\)](#page-11-2) and repeating the proof of [\(4.4\)](#page-11-1), we conclude that [\(4.2\)](#page-10-3) also holds in this case. This finishes the proof of Proposition [4.1.](#page-10-1)

Proposition 4.2. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Assume that u is the *weak solution to the Dirichlet problem* [\(1.8\)](#page-1-2) *with* $f \in L^2(\Omega;\mathbb{R}^n)$. Then there exists a constant q_0 ∈ (2, ∞)*, depending on n,* μ_0 , *A, and* Ω *, such that, for any given* q ∈ (2, q_0)*, any ball B* := $B(x_0, r_0) \subset \mathbb{R}^n$ *with* $x_0 \in \overline{\Omega}$ *and* $r_0 \in (0, \text{diam}(\Omega))$ *, and any* $f_0 \in \mathbb{R}^n$ *,*

$$
(4.6)\qquad \qquad \int_{B\cap\Omega}|\nabla u(x)|^q\,dx\leq C\left[\left(\int_{2B\cap\Omega}|\nabla u(x)|\,dx\right)^q+\int_{2B\cap\Omega}\left|f(x)-f_0\right|^q\,dx\right],
$$

where C is a positive constant depending only on n, μ_0 *, and* Ω *, but independent of B, u, and f.*

Proof. Since *u* is the weak solution of the Dirichlet problem [\(1.8\)](#page-1-2), it follows that, for any $\varphi \in$ $C_c^{\infty}(\Omega)$ and any $f_0 \in \mathbb{R}^n$, [\(1.9\)](#page-3-0) holds. Using [\(1.9\)](#page-3-0), similarly to the proof of Proposition [4.1,](#page-10-1) we obtain [\(4.6\)](#page-11-3); we omit the details.

We also have the following interior mean oscillation-type decay estimate for the weak solution to the problems (1.6) and (1.8) .

Proposition 4.3. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Assume that the matrix *A* and the function σ satisfy Assumption [\(A](#page-4-0)& Ω)(a). Assume further that $\theta \in (0, 1)$, $f \in L^2(\Omega; \mathbb{R}^n)$, $and u ∈ W^{1,2}(Ω)$ *is the weak solution to the Neumann problem* [\(1.6\)](#page-1-0) *or the Dirichlet problem* [\(1.8\)](#page-1-2). *Then there exists a constant* $q \in (2, \infty)$ *<i>such that, for any ball* $B := B(x, r)$ *satisfying* $2B \subset \Omega$ *and* $r \in (0, R_0)$ *with* $R_0 \in (0, \infty)$ *being the same as in Assumption* $(A \& \Omega)(a)$ *and for any* $f_0 \in \mathbb{R}^n$,

(4.7)
$$
\left[\int_{\theta B} |\nabla u(y) - (\nabla u)_{\theta B}|^2 dy\right]^{\frac{1}{2}} \n\leq C_{(n,\mu_0,\theta)}\sigma(r) \int_{2B} |\nabla u(y)| dy + C_{(n,\mu_0,\theta,R_0)} \left[\int_{2B} |f(y) - f_0|^q dy\right]^{\frac{1}{q}} \n+ C\theta \left[\int_{2B} |\nabla u(y) - (\nabla u)_{2B}|^2 dy\right]^{\frac{1}{2}},
$$

where $C_{(n,\mu_0,\theta)}$ *is a positive constant depending on n, μ*₀*, and θ,* $C_{(n,\mu_0,\theta,R_0)}$ *is a positive constant depending on n,* μ_0 *,* θ *, and R₀, and C is a positive constant independent of u, f, B, and* θ *.*

Proof. Let $A_0 := (A)_B$. Since *u* is the weak solution to the Neumann problem [\(1.6\)](#page-1-0) or the Dirichlet problem [\(1.8\)](#page-1-2), it follows that

(4.8)
$$
\operatorname{div}(A_0 \nabla u) = \operatorname{div}((A_0 - A) \nabla u + f) \text{ in } \Omega.
$$

Then, by [\(4.8\)](#page-12-0) and [\(3.4\)](#page-9-4), there exist a positive constant *C*, independent of θ , *B*, *u*, and *f*, and a positive constant $C_{(n,\mu_0,\theta)}$, depending only on *n*, μ_0 , and θ , such that, for any $f_0 \in \mathbb{R}^n$,

(4.9)
$$
\left[\oint_{\theta B} |\nabla u(y) - (\nabla u)_{\theta B}|^2 dy\right]^{\frac{1}{2}} \leq C\theta \left[\oint_B |\nabla u(y) - (\nabla u)_B|^2 dy\right]^{\frac{1}{2}} + C_{(n,\mu_0,\theta)} \left[\oint_B |A_0 \nabla u(y) - A(y) \nabla u(y)|^2 dy\right]^{\frac{1}{2}} + C_{(n,\mu_0,\theta)} \left[\oint_B |f(y) - f_0|^2 dy\right]^{\frac{1}{2}}.
$$

Moreover, from [\(4.1\)](#page-10-2), Assumption $(A \& \Omega)(a)$ $(A \& \Omega)(a)$ $(A \& \Omega)(a)$, Lemma [2.1,](#page-7-0) and Hölder's inequality, we deduce that there exist constants $q \in (2, \infty)$ and $C \in (0, \infty)$ such that

$$
\left[\int_{B} |A_{0} \nabla u(y) - A(y) \nabla u(y)|^{2} dy\right]^{\frac{1}{2}}\n\leq \left[\int_{B} |A_{0} - A(y)|^{2(\frac{q}{2})'} dy\right]^{\frac{1}{2(\frac{1}{2})'}} \left[\int_{B} |\nabla u(y)|^{q} dy\right]^{\frac{1}{q}}\n\leq C\sigma(r) \left\{\int_{2B} |\nabla u(y)| dy + \left[\int_{2B} |f(y) - f_{0}|^{q} dy\right]^{\frac{1}{q}}\right\},
$$

which, together with [\(4.9\)](#page-12-1) and Assumption (*A*[&](#page-4-0)Ω)(a), further implies that [\(4.7\)](#page-12-2) holds. This fin-ishes the proof of Proposition [4.3.](#page-12-3)

.

4.2 Change of coordinates

In this subsection, we recall some necessary results on the change of coordinates for Lipschitz domains (see, for instance, [\[5,](#page-27-14) Section 4.2], [\[7,](#page-27-5) Section 5.1], and [\[22,](#page-27-7) p. 50]).

Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. By the definition of Lipschitz domains, there exists a constant $R_1 \in (0, \infty)$, depending only on Ω , such that, for any $x \in \partial \Omega$ and $r \in (0, R_1]$, $B(x, r) \cap \partial \Omega$ is a part of some Lipschitz graph. Without loss of generality, we may assume that the origin $0 \in \partial \Omega$ and there exists a Lipschitz map $\psi : \mathbb{R}^{n-1} \to \mathbb{R}$ such that

(4.10)
$$
\partial \Omega \cap B(0, R_1) = \{(x', \psi(x')) \in \mathbb{R}^n : (x', 0) \in B(0, R_1)\}
$$

and

$$
\Omega \cap B(0, R_1) = \{(x', x_n) \in B(0, R_1) : x_n > \psi(x')\}
$$

Then the map Ψ : $\Omega \cap B(0, R_1) \to B^+(0, R_1)$ is defined by setting, for any $x := (x', x_n) \in$ $\Omega \cap B(0, R_1),$

$$
\Psi(x) := (x', x_n - \psi(x')).
$$

Here and thereafter, $B^+(0, R_1) := \{y := (y', y_n) \in B(0, R_1) : y_n > 0\}$. It is easy to see that

 $\Psi(\partial\Omega \cap B(\mathbf{0}, R_1)) \subset \{ (y', y_n) \in \mathbb{R}^n : y_n = 0 \}$

and $\Psi(0) = 0$. The function $\Psi : \overline{\Omega} \cap B(0, R_1) \to \Psi(\overline{\Omega} \cap B(0, R_1))$ is invertible, with a Lipschitz continuous inverse

 $\Psi^{-1}: \Psi(\overline{\Omega} \cap B(0,R_1)) \to \overline{\Omega} \cap B(0,R_1).$

Furthermore, the map $J: \overline{\Omega} \cap B(0, R_1) \to \mathbb{R}^{n \times n}$ is defined by setting, for any $x \in \overline{\Omega} \cap B(0, R_1)$,

$$
\mathbf{J}(x) := \nabla \Psi(x).
$$

Thus, for any $x := (x', x_n) \in \overline{\Omega} \cap B(0, R_1)$,

$$
\mathbf{J}(x) = \begin{pmatrix} \mathbf{I}_{n-1} & 0 \\ -\nabla \psi(x') & 1 \end{pmatrix} = \begin{pmatrix} 1 & 0 & 0 & \cdots & 0 \\ 0 & 1 & 0 & \cdots & 0 \\ \vdots & \vdots & \ddots & \ddots & \vdots \\ 0 & 0 & \cdots & 1 & 0 \\ -\psi_{x_1}(x') & -\psi_{x_2}(x') & \cdots & -\psi_{x_{n-1}}(x') & 1 \end{pmatrix}.
$$

Here and thereafter, I_{n-1} denotes the $(n-1) \times (n-1)$ unit matrix. Next we define the map

$$
\mathbf{J}^{-1}:\; \Psi\big(\overline{\Omega}\cap B(\mathbf{0},R_1)\big)\to \mathbb{R}^{n\times n}
$$

by setting, for any $y \in \Psi(\overline{\Omega} \cap B(0,R_1))$,

$$
\mathbf{J}^{-1}(y) := \nabla(\Psi^{-1}(y)).
$$

Therefore, for any $y \in \Psi(\overline{\Omega} \cap B(0,R_1)), \mathbf{J}^{-1}(y) = (\nabla \Psi)^{-1}(\Psi^{-1}(y)).$

Remark 4.4. By the definitions of **J** and J^{-1} , we have

- (i) For any $y \in \Psi(\overline{\Omega} \cap B(0,R_1)), \mathbf{J}^{-1}(y)\mathbf{J}(\Psi^{-1}(y)) = \mathbf{I}_n$, where \mathbf{I}_n denotes the $n \times n$ unit matrix.
- (ii) For any $x \in \overline{\Omega} \cap B(0, R_1)$, det $J(x) = 1$ and, for any $y \in \Psi(\overline{\Omega} \cap B(0, R_1))$, det $J^{-1}(y) = 1$.
- (iii) $|\Psi(E)| = |E|$ for any measurable set $E \subset \overline{\Omega} \cap B(0, R_1)$, and $|\Psi^{-1}(E)| = |E|$ for any measurable set $E \subset \Psi(\overline{\Omega} \cap B(0,R_1)).$

Furthermore, since both Ψ and Ψ^{-1} are Lipschitz continuous, it follows that there exist constants

$$
(4.12) \t\t 0 < \lambda \le 1 \le \Lambda
$$

such that, for any $r \in (0, R_1]$,

(4.13)
$$
B^+(0, \lambda r) \subset \Psi(\Omega \cap B(0, r)) \subset B^+(0, \Lambda r)
$$

and, for any $r \in (0, \infty)$ satisfying $B^+(0, r) \subset \Psi(\overline{\Omega} \cap B(0, R_1)),$

(4.14)
$$
\Omega \cap B\left(0, \Lambda^{-1}r\right) \subset \Psi^{-1}(B(0, r)) \subset \Omega \cap B\left(0, \lambda^{-1}r\right).
$$

For any given (vector-valued or matrix-valued) function *f* on $\overline{\Omega} \cap B(0, R_1)$, define the function \widetilde{f} on $\Psi(\overline{\Omega} \cap B(0,R_1))$ by setting, for any $y \in \Psi(\overline{\Omega} \cap B(0,R_1)),$

$$
\widetilde{f}(y) := f\left(\Psi^{-1}(y)\right).
$$

If *f* is differentiable, then, for any $y \in \Psi(\overline{\Omega} \cap B(0, R_1)),$

$$
\nabla_y \widetilde{f}(y) = \nabla_x f\left(\Psi^{-1}(y)\right) \mathbf{J}^{-1}(y)
$$

and, for any $x \in \overline{\Omega} \cap B(0, R_1)$,

$$
\nabla_x f(x) = \nabla_y f(\Psi(x)) \mathbf{J}(x),
$$

where ∇_x and ∇_y , respectively, denote the gradient with respect to the variables *x* and *y*. By the boundedness of **J**, we conclude that, if $y = \Psi(x)$, then

$$
|\nabla_x f(x)| \sim \left| \nabla_y \widetilde{f}(y) \right|
$$

with the positive equivalence constants depending only on the Lipschitz constants of Ψ and Ψ^{-1} .

Furthermore, recall that the function *u* is called a *weak solution* to the Neumann problem

(4.16)
$$
\begin{cases} \text{div}(A \nabla u) = \text{div}f & \text{in } \Omega \cap B(\mathbf{0}, R_1), \\ \frac{\partial u}{\partial \mathbf{v}} = f \cdot \mathbf{v} & \text{on } \partial \Omega \cap B(\mathbf{0}, R_1) \end{cases}
$$

if

$$
\int_{\Omega \cap B(0,R_1)} A(x) \nabla u(x) \cdot \nabla \varphi(x) \, dx = \int_{\Omega \cap B(0,R_1)} f(x) \cdot \nabla \varphi(x) \, dx
$$

holds for any $\varphi \in C^{\infty}(\Omega \cap B(0, R_1))$ with $\varphi = 0$ on $\Omega \cap \partial B(0, R_1)$.

Now, we show that, if *u* is a weak solution of [\(4.16\)](#page-14-0), then the function \tilde{u} , defined via replacing *f* by *u* in [\(4.15\)](#page-14-1), is a weak solution of a similar Neumann problem. Indeed, since det $J^{-1} = 1$, it follows that, for any $\varphi \in C^{\infty}(\Omega \cap B(0, R_1))$ with $\varphi = 0$ on $\Omega \cap \partial B(0, R_1)$,

(4.17)
$$
\int_{\Omega \cap B(0,R_1)} A(x) \nabla_x u(x) \cdot \nabla_x \varphi(x) dx
$$

\n
$$
= \int_{\Psi(\Omega \cap B(0,R_1))} A(\Psi^{-1}(y)) \nabla_x u(\Psi^{-1}(y)) \cdot \nabla_x \varphi(\Psi^{-1}(y)) \det \mathbf{J}^{-1}(y) dy
$$

\n
$$
= \int_{\Psi(\Omega \cap B(0,R_1))} A(\Psi^{-1}(y)) \nabla_y \widetilde{u}(y) \mathbf{J}(\Psi^{-1}(y)) \cdot \nabla_y \widetilde{\varphi}(y) \mathbf{J}(\Psi^{-1}(y)) dy
$$

\n
$$
= \int_{\Psi(\Omega \cap B(0,R_1))} \mathbf{J}(\Psi^{-1}(y)) A(\Psi^{-1}(y)) \mathbf{J}^t(\Psi^{-1}(y)) \nabla_y \widetilde{u}(y) \cdot \nabla_y \widetilde{\varphi}(y) dy,
$$

where $\tilde{\varphi}$ is defined by replacing *f* with φ in [\(4.15\)](#page-14-1). Similarly to [\(4.17\)](#page-14-2), we also obtain

 $where, for any y \in B^+(0, \lambda R_1), A_{\tilde{J}}(y) := J(\Psi^{-1}(y))A(\Psi^{-1}(y))J'(\Psi^{-1}(y))$ and $\tilde{J'}(y) := J'(\Psi^{-1}(y))$.

For any given $s \in (0, \lambda R_1)$, define the matrix $\mathbf{J}_s \in \mathbb{R}^{n \times n}$ by setting

$$
\mathbf{J}_s := (\mathbf{J})_{\Omega \cap B(\mathbf{0},s)}.
$$

Based on [\(4.13\)](#page-14-3) and [\(4.14\)](#page-14-4), we choose the constant Λ in [\(4.12\)](#page-14-5) large enough such that $J_sB(0, s) \subset$ *B*(0, ΛR_1) for any given *s* ∈ (0, λR_1). For any constant-valued matrix **T** ∈ $\mathbb{R}^{n \times n}$, let

For any given function *u* on Ω , define \overline{u} : $H_{J_s} \cap B(0, \frac{\lambda}{\Lambda} R_1) \to \mathbb{R}$ by setting, for any $z \in H_{J_s} \cap$ $B(\mathbf{0}, \frac{\lambda}{\Lambda}R_1),$

(4.20) $\overline{u}(z) := \widetilde{u}(\mathbf{J}_s z)$.

Therefore, for any $z \in H_{J_s} \cap B(0, \frac{\lambda}{\Lambda} R_1)$,

\begin{cases} \operatorname{div}_z \left(A_{\mathbf{J}_s^{-1}} \overline{\mathbf{J}}^\nabla_z \overline{u} \right) = \operatorname{div} \left(\overline{f} \, \overline{\mathbf{J}^t} \left(\mathbf{J}_s^{-1} \right)^t \right) & \text{in } H_{\mathbf{J}_s} \cap B \left(\mathbf{0}, \frac{\lambda}{\Lambda} R_1 \right), \\ \frac{\partial \overline{u}}{\partial \mathbf{v}} = \overline{f} \, \overline{\mathbf{J}^t} \left(\mathbf{J}_s^{-1} \right)^t \cdot \mathbf{v} & \text{on } \{ (\mathbf{J}_s z)_n = 0 \} \cap B \left(\mathbf{0}, \frac{\lambda}{\Lambda} R_1 \right) \end{cases}
$$

where, for any $z \in H_{J_s} \cap B(0, \frac{\lambda}{\Lambda} R_1)$, $\overline{J}(z)$ is defined as in [\(4.21\)](#page-15-3) with J in place of f and $A_{J_s^{-1}}\overline{J}(z)$:= J_s^{-1} **J** (z) $\overline{J}(z)$ $\overline{J'}(z)$ $({\bf J}_s^{-1})^t$.

Let $A_0 \in \mathbb{R}^{n \times n}$ be a constant-valued matrix satisfying the uniform ellipticity condition [\(1.5\)](#page-1-4). Assume that $s \in (0, R_1)$, $F \in L^2(B(0, R_1); \mathbb{R}^n)$, and *w* is a weak solution of the Neumann problem

\begin{cases} \operatorname{div}_{z}(A_{0}\nabla_{z}w) = \operatorname{div}(F) & \text{in } H_{\mathbf{J}_{s}} \cap B\left(\mathbf{0}, \frac{\lambda}{\Lambda}R_{1}\right), \\ \frac{\partial w}{\partial v} = F \cdot v & \text{on } \{(\mathbf{J}_{s}z)_{n} = 0\} \cap B\left(\mathbf{0}, \frac{\lambda}{\Lambda}R_{1}\right). \end{cases}

Then, by an argument similar to that used in the proof of [\[24,](#page-28-6) Proposition 3.2] and a change of variables, we obtain the following lemma for the Neumann problem [\(4.23\)](#page-16-0); we omit its proof.

Lemma 4.7. *Let* $R_1 \in (0, \infty)$ *be the same as in* [\(4.10\)](#page-13-0) *and w be a weak solution of* [\(4.23\)](#page-16-0)*. Then, for any given* $s \in (0, \lambda R_1)$ *, any* $r \in (0, \lambda R_1/\Lambda)$ *,* $\delta \in (0, 1)$ *, and* $\mathbf{F}_0 \in \mathbb{R}^n$ *,*

$$

where $D_r := B(0,r) \cap H_{J_s}$, $(\nabla w)_{D_r} := ((w_{z_1})_{D_r}, \ldots, (w_{z_n})_{D_r})$, C is a positive constant independent *of* δ , *s*, *r*, *w*, and **F**, and $C_{(n,\mu_0,\delta)}$ is a positive constant depending only on δ , μ_0 , and n.

Let $A_0 \in \mathbb{R}^{n \times n}$, $s \in (0, R_1)$, and $F \in L^2(B(0, R_1); \mathbb{R}^n)$ be the same as in [\(4.23\)](#page-16-0). Assume that *v* is a weak solution of the Dirichlet problem

$$
\begin{cases} \operatorname{div}_{z} (A_{0} \nabla_{z} \nu) = \operatorname{div} (F) & \text{in } H_{\mathbf{J}_{s}} \cap B\left(\mathbf{0}, \frac{\lambda}{\Lambda} R_{1}\right), \\ \nu = 0 & \text{on } \{(\mathbf{J}_{s} z)_{n} = 0\} \cap B\left(\mathbf{0}, \frac{\lambda}{\Lambda} R_{1}\right). \end{cases}
$$

By applying an argument similar to that used in the proof of [\[18,](#page-27-8) Lemma 2.8] and a change of variables, we also obtain the following lemma for the Dirichlet problem [\(4.24\)](#page-16-1); we omit its proof.

Lemma 4.8. *Let* $R_1 \in (0, \infty)$ *be the same as in* [\(4.10\)](#page-13-0) *and let v be a weak solution of the Dirichlet problem* [\(4.24\)](#page-16-1)*. Then, for any given* $s \in (0, \lambda R_1)$ *, any* $r \in (0, \lambda R_1/\Lambda)$ *,* $\delta \in (0, 1)$ *, and* $F_0 \in \mathbb{R}^n$ *,*

where $V_r := (0, \ldots, 0, (v_{z_n})_{D_r})$ with $D_r := B(0, r) \cap H_{J_s}$, J_s is the same as in [\(4.19\)](#page-15-4), C is a positive *constant independent of* δ , *s*, *r*, *v*, and **F**, and $C_{(n,\mu_0,\delta)}$ *is a positive constant depending only on* δ , μ_0 *, and n.*

4.3 Decay estimate near the boundary

In this subsection, we prove the mean oscillation-type decay estimate of the gradient of the solution to the problem [\(1.6\)](#page-1-0) or [\(1.8\)](#page-1-2) near the boundary of Ω , which plays a key role in the proof of Theorem [1.5.](#page-4-1)

Theorem 4.9. *Let* $n \ge 2$, Ω *be a bounded Lipschitz domain of* \mathbb{R}^n *, and* $x \in \partial \Omega$ *, and let* $R_2 :=$ $min\{R_0, R_1\}$, where R_0 *is the same as in Assumption* $(A \& \Omega)$ *and* R_1 *the same as in* [\(4.10\)](#page-13-0)*. Assume that the matrix A and the domain* Ω *satisfy Assumption* (*A&* Ω *). Assume further that* $\theta \in (0,1)$ *,* $f \in BMO_r(\Omega;\mathbb{R}^n)$, and u is the weak solution to the Neumann problem [\(1.6\)](#page-1-0). Then there exist *constants* $C \in (0, \infty)$ *and* $q \in (2, \infty)$ *, independent of* θ *, such that, for any given* $s \in (0, R_2]$ *,*

$$
(4.25) \qquad \left[\int_{\Omega \cap B(x,\theta s)} \left|\nabla u(y) - (\nabla u)_{\Omega \cap B(x,\theta s)}\right|^2 dy\right]^{\frac{1}{2}} \n\leq C\theta \left[\int_{\Omega \cap B(x,s)} \left|\nabla u(y) - (\nabla u)_{\Omega \cap B(x,s)}\right|^2 dy\right]^{\frac{1}{2}} + C_{(n,\mu_0,\theta)}\sigma(s) \int_{\Omega \cap B(x,s)} \left|\nabla u(y)\right| dy \n+ C_{(n,\mu_0,\theta)}\sigma(s) \left[\int_{\Omega \cap B(x,s)} |f(y)|^q dy\right]^{\frac{1}{q}} + C_{(n,\mu_0,\theta)} ||f||_{\text{BMO}(\Omega;\mathbb{R}^n)},
$$

where $(\nabla u)_{\Omega \cap B(x,s)} := ((u_{x_1})_{\Omega \cap B(x,s)}, \ldots, (u_{x_n})_{\Omega \cap B(x,r)})$, the function σ is the same as in Assumption ($A\&\Omega$), and $C_{(n,\mu_0,\theta)}$ is a positive constant depending on n, μ_0 , and θ .

Proof. Without loss of generality, we may assume that $x := 0$ and, for simplicity, we denote the ball $B(0, r)$ by B_r throughout this proof. Assume that $q \in (2, q_0)$, where q_0 is the exponent appearing in Proposition [4.1.](#page-10-1) Let ψ be the same as in [\(4.10\)](#page-13-0) and σ the same as in Assumption (*A*[&](#page-4-0)Ω). By the assumption that Ω satisfies Assumption (*A*&Ω), we see that $\psi \in W^1\mathcal{L}^{\sigma(\cdot)}$, which, combined with Lemma [2.1,](#page-7-0) implies that there exists a positive constant *C* such that

\sup_{r \in (0,R_0)} \frac{1}{\sigma(r)} \left[\int_{\Omega \cap B_r} |\mathbf{J}(x) - (\mathbf{J})_{\Omega \cap B_r}|^{2(\frac{q}{2})'} dx \right]^{\frac{1}{2(\frac{q}{2})'}} \leq C,

where J is the same as in (4.11) .

Let $\theta \in (0, 1)$ and $s \in (0, R_2]$. From [\(4.22\)](#page-16-2), we deduce that \overline{u} , defined as in [\(4.20\)](#page-15-2), is a weak solution of the Neumann problem

\begin{cases} \operatorname{div}_{z}(A_{0}\nabla_{z}\overline{u}) = \operatorname{div}\left(A_{0}\nabla_{z}\overline{u} - A_{\mathbf{J}_{s}^{-1}}\mathbf{J}\nabla_{z}\overline{u} + \underline{f}\right) & \text{in } H_{\mathbf{J}_{s}} \cap B_{\frac{\lambda}{\Lambda}R_{2}}, \\ \frac{\partial \overline{u}}{\partial v} = \underline{f} \cdot v & \text{on } \{(\mathbf{J}_{s}z)_{n} = 0\} \cap B_{\frac{\lambda}{\Lambda}R_{2}}, \end{cases}
$$

where $A_0 := (A)_{\Omega \cap B_s}$ and $\underline{f} := \overline{f} \overline{J^t} (J_s^{-1})^t$. Let $D_s := H_{J_s} \cap B_s$, $\theta D_s := H_{J_s} \cap B_{\theta s}$, and J_s be the same as in [\(4.19\)](#page-15-4). Then, by (4.22) , [\(4.23\)](#page-16-0), and Lemma [4.7,](#page-16-3) we conclude that there exists a positive constant *C* independent of θ such that, for any $f_0 \in \mathbb{R}^n$,

Fix *r* such that $\frac{\Delta}{\lambda}r = \theta s$. From [\(4.13\)](#page-14-3) and [\(4.12\)](#page-14-5), it follows that

These, combined with [\(4.2\)](#page-10-3), [\(4.26\)](#page-17-1), Hölder's inequality, and the facts that J_s and J^{-1} are bounded, further imply that there exists a positive constant *C* such that

(4.32) \qquad \left[\int_{\theta D_s} \left| \nabla \overline{u}(z) - \nabla u \left(\Psi^{-1}(\mathbf{J}_s z) \right) \right|^2 dz \right]^{\frac{1}{2}} \n\leq C \left[\int_{\theta D_s} \left| \mathbf{J} \left(\Psi^{-1}(\mathbf{J}_s z) \right) - \mathbf{J}_s \right|^2 \left| \nabla u \left(\Psi^{-1}(\mathbf{J}_s z) \right) \right|^2 dz \right]^{\frac{1}{2}} \n\leq C \left[\int_{D_s} \left| \mathbf{J} \left(\Psi^{-1}(\mathbf{J}_s z) \right) - \mathbf{J}_s \right|^{2(\frac{q}{2})'} dz \right]^{\frac{1}{2(\frac{q}{2})'}} \left[\int_{D_s} \left| \nabla u \left(\Psi^{-1}(\mathbf{J}_s z) \right) \right|^q dz \right]^{\frac{1}{q}} \n\leq C \sigma(s) \left[\int_{\Omega \cap B_{\frac{\Lambda}{2}s}} |\nabla u(z)|^q dx \right] \n\leq C \sigma(s) \int_{\Omega \cap B_{2\frac{\Lambda}{2}s}} |\nabla u(x)| dx + C \sigma(s) \left[\int_{\Omega \cap B_{2\frac{\Lambda}{2}s}} |f(x)|^q dx \right]^{\frac{1}{q}}.
$$

.

Similarly, there exists a positive constant *C* such that

$$
(4.33) \qquad \left[\int_{D_s} \left|\nabla \overline{u}(z) - (\nabla \overline{u})_{D_s}\right|^2 dz\right]^{\frac{1}{2}}\n\leq 2 \left[\int_{D_s} \left|\nabla \overline{u}(z) - (\nabla u)_{\Omega \cap B_{\frac{\Lambda}{4},s}}\right|^2 dz\right]^{\frac{1}{2}}\n\leq 2 \left[\int_{D_s} \left|\nabla \overline{u}(z) - \nabla u\left(\Psi^{-1}(\mathbf{J}_s z)\right)\right|^2 dz\right]^{\frac{1}{2}}\n+ 2 \left[\int_{D_s} \left|\nabla u\left(\Psi^{-1}(\mathbf{J}_s z)\right) - (\nabla u)_{\Omega \cap B_{\frac{\Lambda}{4},s}}\right|^2 dz\right]^{\frac{1}{2}}\n\leq C \left[\int_{\Omega \cap B_{\frac{\Lambda}{4},s}} \left|\nabla u(x) - (\nabla u)_{\Omega \cap B_{\frac{\Lambda}{4},s}}\right|^2 dx\right]^{\frac{1}{2}} + C\sigma(s) \left[\int_{\Omega \cap B_{2\frac{\Lambda}{4},s}} |f(x)|^q dx\right]^{\frac{1}{q}}
$$
\n $+ C\sigma(s) \int_{\Omega \cap B_{2\frac{\Lambda}{4},s}} |\nabla u(x)| dx.$

By the definition of *f* in [\(4.27\)](#page-17-2), [\(4.26\)](#page-17-1), Assumption (*A*[&](#page-4-0)Ω)(a), the boundedness of **J**, **J**⁻¹, and **J**_s, and Lemma [2.4,](#page-8-0) we obtain that

(4.34) \qquad \inf_{f_0\in\mathbb{R}^n}\left[\int_{D_s}\left|\underline{f}(z)-f_0\right|^2\,dz\right]^{\frac{1}{2}}\leq \left\|\overline{f}\,\overline{J'}\right\|_{\text{BMO}(D_{R_2};\mathbb{R}^n)}\leq \left\|\overline{f}\right\|_{\text{BMO}(D_{R_2};\mathbb{R}^n)}\leq \|f\|_{\text{BMO}(\Omega;\mathbb{R}^n)}.
$$

Furthermore, observe that, for any $n \times n$ matrix **D**, **E**, **F**, **H**,

\mathbf{F}\mathbf{E}\mathbf{F}^t - \mathbf{H}\mathbf{D}\mathbf{H}^t = \mathbf{F}(\mathbf{E} - \mathbf{D})\mathbf{F}^t + (\mathbf{F} - \mathbf{H})\mathbf{D}\mathbf{F}^t + \mathbf{H}\mathbf{D}(\mathbf{F}^t - \mathbf{H}^t).
$$

From this, [\(4.2\)](#page-10-3), [\(4.30\)](#page-18-1), [\(4.31\)](#page-18-2), Lemma [2.1,](#page-7-0) Hölder's inequality, and Assumption $(A&Ω)(a)$ $(A&Ω)(a)$ $(A&Ω)(a)$, we deduce that there exists a positive constant *C* such that

(4.35) \qquad \left[\int_{D_s} \left| A_0 \nabla \overline{u}(z) - A_{\mathbf{J}_s^{-1}} \overline{\mathbf{y}} \nabla \overline{u}(z) \right|^2 \, dz \right]^{\frac{1}{2}} \n= \left[\int_{D_s} \left| \left(A_0 - \mathbf{J}_s^{-1} \mathbf{J} \left(\Psi^{-1} (\mathbf{J}_s z) \right) A \left(\Psi^{-1} (\mathbf{J}_s z) \right) \mathbf{J}' \left(\Psi^{-1} (\mathbf{J}_s z) \right) (\mathbf{J}_s^{-1})' \right) \nabla \overline{u}(z) \right|^2 \, dz \right]^{\frac{1}{2}} \n\leq C \left[\int_{D_s} |\nabla \overline{u}(z)|^q \, dz \right]^{\frac{1}{q}} \n\times \left[\int_{D_s} \left| \mathbf{J}_s A_0 \mathbf{J}_s' - \mathbf{J} \left(\Psi^{-1} (\mathbf{J}_s z) \right) A \left(\Psi^{-1} (\mathbf{J}_s z) \right) \mathbf{J}' \left(\Psi^{-1} (\mathbf{J}_s z) \right) \right|^{2(\frac{q}{2})'} \, dz \right]^{\frac{1}{2(\frac{q}{2})'}} \n\leq C \left[\int_{D_s} |\nabla \overline{u}(z)|^q \, dz \right]^{\frac{1}{q}} \left[\int_{D_s} \left| \mathbf{J} \left(\Psi^{-1} (\mathbf{J}_s z) \right) - \mathbf{J}_s \right|^{2(\frac{q}{2})'} \, dz \right]^{\frac{1}{2(\frac{q}{2})'}} \n+ C \left[\int_{D_s} |\nabla \overline{u}(z)|^q \, dz \right]^{\frac{1}{q}} \left[\int_{D_s} \left| A_0 - A \left(\Psi^{-1} (\mathbf{J}_s z) \right) \right|^{2(\frac{q}{2})'} \, dz \right]^{\frac{1}{2(\frac{q}{2})'}} \n\leq C \sigma(s) \left\{ \int_{\Omega \cap B_{2\frac{A}{2}s}} |\nabla u(x)| \, dx + \left[\int_{\Omega \cap B_{2\frac{A}{2}s}} |f(x)|^q \, dx \right]^{\frac{1}{q}} \right].
$$

Combining (4.29) , (4.32) , (4.33) , (4.34) , and (4.35) , we conclude that there exists a positive constant *C* independent of θ such that

(4.36) \qquad \left[\int_{\Omega \cap B_{\frac{\lambda}{\Lambda}\theta s}} \left| \nabla u(x) - (\nabla u)_{\Omega \cap B_{\frac{\lambda}{\Lambda}\theta s}} \right|^2 dx \right]^{\frac{1}{2}} \n\leq C_{(n,\mu_0,\theta)} \sigma(s) \int_{\Omega \cap B_{2\frac{\lambda}{\Lambda}s}} |\nabla u(x)| dx + C_{(n,\mu_0,\theta)} \sigma(s) \left[\int_{\Omega \cap B_{2\frac{\lambda}{\Lambda}s}} |f(x)|^q dx \right]^{\frac{1}{q}} \n+ C_{(n,\mu_0,\theta)} ||f||_{\text{BMO}(\Omega;\mathbb{R}^n)} + C\theta \left[\int_{\Omega \cap B_{\frac{\lambda}{\Lambda}s}} \left| \nabla u(x) - (\nabla u)_{\Omega \cap B_{\frac{\lambda}{\Lambda}s}} \right|^2 dx \right]^{\frac{1}{2}}.
$$

Therefore, the estimate [\(4.25\)](#page-17-3) follows from [\(4.36\)](#page-20-2) by redefining the parameter θ . This finishes the proof of Theorem [4.9.](#page-17-4)

Using the interior estimate [\(3.4\)](#page-9-4), Proposition [4.2,](#page-11-4) Lemma [4.8,](#page-16-4) and an argument similar to that used in the proof of Theorem [4.9,](#page-17-4) we obtain the following decay estimate at the boundary for the gradient of the solution *u* to the Dirichlet problem [\(1.8\)](#page-1-2); we omit its proof.

Theorem 4.10. *Let* $n \geq 2$ *and* Ω *be a bounded Lipschitz domain of* \mathbb{R}^n *. Assume that* $0 \in \partial \Omega$ *. Let* $R_2 := \min\{R_0, R_1\}$, where R_0 *is the same as in Assumption (A&Ω)* and R_1 *the same as in* (4.10*)*. *Assume that the matrix A and the domain* Ω *satisfy Assumption [\(A](#page-4-0)*&Ω*), and local coordinates in* $\Omega \cap B(0,R_1)$ *are the same as in Subsection [4.2.](#page-13-2) Assume further that* $\theta \in (0,1)$, $f \in BMO_r(\Omega;\mathbb{R}^n)$, *and u is the weak solution to the Dirichlet problem* [\(1.8\)](#page-1-2)*. Then there exist constants* $C \in (0, \infty)$ *and* $q \in (2, \infty)$ *, independent of* θ *, such that, for any given* $s \in (0, R_2]$ *and any* $f_0 \in \mathbb{R}^n$ *,*

\left[\oint_{\Omega\cap B(0,\theta s)} |\nabla u(y) - U_{\theta s}|^2 dy\right]^{\frac{1}{2}} \leq C\theta \left[\oint_{\Omega\cap B(0,s)} |\nabla u(y) - U_s|^2 dy\right]^{\frac{1}{2}} + C_{(n,\mu_0,\theta)}\sigma(s) \oint_{\Omega\cap B(0,s)} |\nabla u(y)| dy + C_{(n,\mu_0,\theta,R_2)} \left[\oint_{\Omega\cap B(0,s)} |f(y) - f_0|^q dy\right]^{\frac{1}{q}},
$$

 $where U_s := (0, \ldots, 0, (u_{x_n})_{\Omega \cap B(0,s)})$, the function σ is the same as in Assumption [\(A](#page-4-0)& Ω), $C_{(n,\mu_0,\theta)}$ is *a positive constant depending only on n,* µ0*, and* θ*, and C*(*n*,µ0,θ,*R*2) *is a positive constant depending only on n,* μ_0 *,* θ *<i>, and R*₂*.*

5 Proofs of Theorem [1.5](#page-4-1) and Corollary [1.8](#page-6-0)

In this section, we prove Theorem [1.5](#page-4-1) and Corollary [1.8](#page-6-0) by using Theorems [4.9](#page-17-4) and [4.10,](#page-20-3) Proposition [4.3,](#page-12-3) and Lemma [2.2.](#page-7-1)

Theorem 5.1. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Assume that the matrix A *and the domain* Ω *satisfy Assumption [\(A](#page-4-0)*&Ω*), f* ∈ BMO*r*(Ω;R *n*)*, and u is the weak solution to the Neumann problem* [\(1.6\)](#page-1-0)*. Then there exists a constant* $R_3 \in (0, 1)$ *, depending on n,* μ_0 *, the function σ as in Assumption* (*A&*Ω*)*, *and* diam (Ω), *such that, for any* $x \in ∂Ω$ *and* $R \in (0, R_3]$ *,*

$$
(5.1) \qquad \sup_{s\in(0,R)}\left[\int_{\Omega\cap B(x,s)}\left|\nabla u(y)-(\nabla u)_{\Omega\cap B(x,s)}\right|^2\,dy\right]^{\frac{1}{2}}\leq C\|f\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)},
$$

where C is a positive constant independent of f, *u*, *and x.*

To show Theorem [5.1,](#page-20-0) we need the following well-known lemma (see, for instance, [\[5,](#page-27-14) Lemma 5.2]).

Lemma 5.2. *Let* $n \geq 2$ *and* $\Omega \subset \mathbb{R}^n$ *be a bounded Lipschitz domain. Assume that* $q \in [1, \infty)$ *,* $f \in L^q(\Omega)$, and $R \in (0, \text{diam}(\Omega))$ *be a given constant. Then there exists a positive constant C*, *depending only on n, q, and the Lipschitz constant of* Ω *, such that, for any x* $\in \overline{\Omega}$ *and r* $\in (0, R]$ *,*

\int_{\Omega \cap B(x,r)} |f(y)| \, dy \le C \ln \left(\frac{R}{r}\right) \sup_{\rho \in (r,R)} \left[\int_{\Omega \cap B(x,\rho)} \left| f(y) - (f)_{\Omega \cap B(x,\rho)} \right|^q \, dy \right]^{\frac{1}{q}} + C(|f|)_{\Omega \cap B(x,R)}.
$$

Now, we prove Theorem [5.1](#page-20-0) by using Proposition [4.1,](#page-10-1) Theorem [4.9,](#page-17-4) and Lemma [5.2.](#page-21-0)

Proof of Theorem [5.1.](#page-20-0) Let $x \in \partial\Omega$ and $\theta \in (0, 1)$ be determined later. Assume that $R_2 \in (0, \infty)$ is the same as in Theorem [4.9.](#page-17-4) By Theorem [4.9,](#page-17-4) there exists a positive constant C_3 , independent of *x*, *u*, *f*, and θ , such that, for any $s \in (0, R_2]$,

\leq C_{(n,\mu_0,\theta)}\sigma(s) \int_{\Omega\cap B(x,s)} |\nabla u(y)| dy + C_{(n,\mu_0,\theta)}\sigma(s) \left[\int_{\Omega\cap B(x,s)} |f(y)|^q dy\right]^{\frac{1}{q}}
$$

$$
+ C_{(n,\mu_0,\theta)} ||f||_{\text{BMO}(\Omega;\mathbb{R}^n)} + C_3 \theta \left[\int_{\Omega\cap B(x,s)} |\nabla u(y) - (\nabla u)_{\Omega\cap B(x,s)}|^2 dy\right]^{\frac{1}{2}},
$$

where $C_{(n,\mu_0,\theta)}$ is a positive constant depending on *n*, μ_0 , and θ and $q \in (2,\infty)$ is the same as in Theorem [4.9.](#page-17-4)

Take $\theta \in (0, 1)$ such that

$$
(5.3) \tC_3\theta \le 1/2.

From Lemma [2.1,](#page-7-0) it follows that, for any $s \in (0, R_2]$,

\lesssim \|f\|_{\text{BMO}(\Omega;\mathbb{R}^n)} + \int_{\Omega\cap B(x,s)}|f(y)|\,dy.
$$

Moreover, by Lemma [5.2,](#page-21-0) there exists a positive constant C_4 such that, for any given $g \in L^2(\Omega)$, any $R \in (0, \min\{R_2, \text{diam}(\Omega), 1\}]$, and $s \in (0, R)$,

\int_{\Omega\cap B(x,s)}|g(y)|\,dy\leq C_4\ln\left(\frac{1}{s}\right)\sup_{\rho\in(s,R)}\left[\int_{\Omega\cap B(x,\rho)}\left|g(y)-(g)_{\Omega\cap B(x,\rho)}\right|^2\,dy\right]^{\frac{1}{2}}+C_4(|g|)_{\Omega\cap B(x,R)},
$$

which, combined with [\(5.2\)](#page-21-1) and [\(5.4\)](#page-21-2), further implies that, for any $R \in (0, \min\{R_2, \text{diam}(\Omega), 1\}]$ and $s \in (0, R)$,

\leq C_4 C_{(n,\mu_0,\theta)} \sigma(s) \ln\left(\frac{1}{s}\right) \sup_{\rho\in(s,R)} \left[\int_{\Omega\cap B(x,\rho)} \left|\nabla u(y) - (\nabla u)_{\Omega\cap B(x,\rho)}\right|^2 \, dy\right]^{\frac{1}{2}}
$$
\n
$$
+ C_4 C_{(n,\mu_0,\theta)} \sigma(s) \int_{\Omega\cap B(x,R)} \left|\nabla u(y)\right| \, dy + C_{(n,\mu_0,\theta)} ||f||_{\text{BMO}(\Omega;\mathbb{R}^n)}
$$

+
$$
C_4C_{(n,\mu_0,\theta)}\sigma(s)\ln\left(\frac{1}{s}\right)\sup_{\rho\in(s,R)}\left[\int_{\Omega\cap B(x,\rho)}\left|f(y)-(f)_{\Omega\cap B(x,\rho)}\right|^2 dy\right]^{\frac{1}{2}}
$$

+ $C_{(n,\mu_0,\theta)}\sigma(s)\int_{\Omega\cap B(x,R)}\left|f(y)\right|dy + C_3\theta\left[\int_{\Omega\cap B(x,s)}\left|\nabla u(y)-(\nabla u)_{\Omega\cap B(x,s)}\right|^2 dy\right]^{\frac{1}{2}}$.

From (i) of Assumption ($A\&\Omega$ $A\&\Omega$ $A\&\Omega$)(a), we deduce that there exists a positive constant $\widetilde{R} \in (0,1)$, depending on n , μ_0 , θ , and the function σ , such that

(5.6)
$$
\sup_{s \in (0,\widetilde{R})} C_4 C_{(n,\mu_0,\theta)} \sigma(s) \ln\left(\frac{1}{s}\right) \leq \frac{1}{4}.
$$

Let $R_3 := \min\{R_2, \tilde{R}, \text{diam}(\Omega)\}\)$. By [\(5.3\)](#page-21-3), [\(5.5\)](#page-21-4), [\(5.6\)](#page-22-0), and Lemma [2.2,](#page-7-1) for any given $R \in (0, R_3]$ and $s \in (0, R)$,

&\leq \frac{3}{4} \sup_{\rho\in(s,R)} \left[\int_{\Omega\cap B(x,\rho)} \left|\nabla u(y) - (\nabla u)_{\Omega\cap B(x,\rho)}\right|^2 dy\right]^{\frac{1}{2}} \\
&+ C \int_{\Omega\cap B(x,R)} \left|\nabla u(y)\right| dy + C \int_{\Omega\cap B(x,R)} |f(y)| dy + C ||f||_{\text{BMO}(\Omega;\mathbb{R}^n)} \\
&\leq \frac{3}{4} \sup_{\rho\in(s,R)} \left[\int_{\Omega\cap B(x,\rho)} \left|\nabla u(y) - (\nabla u)_{\Omega\cap B(x,\rho)}\right|^2 dy\right]^{\frac{1}{2}} \\
&+ C \int_{\Omega\cap B(x,R)} \left|\nabla u(y)\right| dy + C ||f||_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)},\n\end{split}
$$

which, together with Hölder's inequality and Remark [1.3\(](#page-3-1)i), further implies that, for any given $\varepsilon \in (0, \theta R/2),$

(5.7) \qquad \sup_{s \in (\varepsilon, \frac{\theta R}{2})} \left[\int_{\Omega \cap B(x,s)} \left| \nabla u(y) - (\nabla u)_{\Omega \cap B(x,s)} \right|^2 \, dy \right]^{\frac{1}{2}} \n\leq \frac{3}{4} \sup_{\rho \in (\frac{\varepsilon}{\theta}, R)} \left[\int_{\Omega \cap B(x,\rho)} \left| \nabla u(y) - (\nabla u)_{\Omega \cap B(x,\rho)} \right|^2 \, dy \right]^{\frac{1}{2}} + C \|f\|_{\text{BMO}_{r,+}(\Omega; \mathbb{R}^n)}.
$$

Moreover, from Remark [1.3\(](#page-3-1)i), it follows that

$$
(5.8) \qquad \sup_{s \in (\frac{\theta R}{2}, R)} \left[\int_{\Omega \cap B(x,s)} |\nabla u(y) - (\nabla u)_{\Omega \cap B(x,s)}|^2 \, dy \right]^{\frac{1}{2}} \n\leq C \sup_{s \in (\frac{\theta R}{2}, R)} \left[\int_{\Omega \cap B(x,s)} |\nabla u(y)|^2 \, dy \right]^{\frac{1}{2}} \leq C \left[\int_{\Omega \cap B(x,R)} |\nabla u(y)|^2 \, dy \right]^{\frac{1}{2}} \leq C ||f||_{L^2(\Omega; \mathbb{R}^n)}.
$$

Then, by [\(5.7\)](#page-22-1) and [\(5.8\)](#page-22-2), for any given $\varepsilon \in (0, \theta R/2)$,

\sup_{s \in (\varepsilon, R)} \left[\int_{\Omega \cap B(x,s)} |\nabla u(y) - (\nabla u)_{\Omega \cap B(x,s)}|^2 \ dy \right]^{\frac{1}{2}}
$$
\n
$$
\leq \frac{3}{4} \sup_{\rho \in (\frac{\varepsilon}{\theta}, R)} \left[\int_{\Omega \cap B(x,\rho)} |\nabla u(y) - (\nabla u)_{\Omega \cap B(x,\rho)}|^2 \ dy \right]^{\frac{1}{2}} + C \|f\|_{\text{BMO}_{r,+}(\Omega; \mathbb{R}^n)},
$$

which further implies that, for any given $\varepsilon \in (0, \theta R/2)$,

(5.9)
$$
\sup_{s \in (\varepsilon,R)} \left[\int_{\Omega \cap B(x,s)} \left| \nabla u(y) - (\nabla u)_{\Omega \cap B(x,s)} \right|^2 dy \right]^{\frac{1}{2}} \lesssim ||f||_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)}.
$$

Then letting $\varepsilon \to 0$ in [\(5.9\)](#page-23-2), we conclude that [\(5.1\)](#page-20-4) holds. This finishes the proof of Theorem $5.1.$

Applying Theorem [4.10](#page-20-3) and an argument similar to that used in the proof of Theorem [5.1,](#page-20-0) we obtain the following estimate for the Dirichlet problem [\(1.8\)](#page-1-2); we omit its proof.

Theorem 5.3. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Assume that the matrix A *and the domain* Ω *satisfy Assumption [\(A](#page-4-0)*&Ω*), f* ∈ BMO*r*(Ω;R *n*)*, and u is the weak solution to the Dirichlet problem* [\(1.8\)](#page-1-2)*. Then there exists a constant* $R_4 \in (0, 1)$ *, depending on n,* μ_0 *, the function* $σ$ *in Assumption* (*A&*Ω*)*, and diam (Ω), such that, for any $x \in ∂Ω$ *and* $R \in (0, R_4]$,

$$
\sup_{s\in(0,R)}\left[\int_{\Omega\cap B(x,s)}\left|\nabla u(y)-(\nabla u)_{\Omega\cap B(x,s)}\right|^2\,dy\right]^{\frac{1}{2}}\leq C\|f\|_{\text{BMO}_r(\Omega;\mathbb{R}^n)},
$$

where C is a positive constant independent of f, *u, and x.*

Applying Proposition [4.3,](#page-12-3) Lemma [5.2,](#page-21-0) and an argument similar to that used in the proof of Theorem [5.1,](#page-20-0) we obtain the following proposition; we omit the proof.

Proposition 5.4. Let $n \geq 2$ and $\Omega \subset \mathbb{R}^n$ be a bounded Lipschitz domain. Assume that the matrix *A and the domain* Ω *satisfy Assumption [\(A](#page-4-0)*&Ω*), f* ∈ BMO*r*(Ω;R *n*)*, and u is the weak solution to the Neumann problem* [\(1.6\)](#page-1-0) *or the Dirichlet problem* [\(1.8\)](#page-1-2)*. Then there exist positive constants* δ_0 *,* $R_5 \in (0, 1)$ *, depending on n,* μ_0 *, the function* σ *in Assumption* $(A \& \Omega)$ *, and* diam (Ω) *, such that, for any given* $R \in (0, R_5]$ *and any* $x \in \Omega$ *and* $r \in (0, R)$ *satisfying* $B(x, 2r) \subset \Omega$ *,*

$$
(5.10) \qquad \left[\int_{B(x,\delta_0 r)} \left|\nabla u(y) - (\nabla u)_{B(x,\delta_0 r)}\right|^2 dy\right]^{\frac{1}{2}} \n\leq \frac{1}{2} \sup_{s \in (0,R)} \left[\int_{\Omega \cap B(x,s)} \left|\nabla u(y) - (\nabla u)_{\Omega \cap B(x,s)}\right|^2 dy\right]^{\frac{1}{2}} + C||f||_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)} < \infty,
$$

where C is a positive constant independent of f, u, and x.

Now, we show Theorem [1.5](#page-4-1) by using Lemma [2.3,](#page-8-1) Theorems [5.1](#page-20-0) and [5.3,](#page-23-1) and Proposition [5.4.](#page-23-0)

Proof of Theorem [1.5.](#page-4-1) We only give the proof of [\(1.10\)](#page-4-2) in the case of the Neumann problem because the proof in the case of the Dirichlet problem is similar. Let $f \in BMO_r(\Omega;\mathbb{R}^n)$, *u* be the weak solution to the Neumann problem [\(1.6\)](#page-1-0), and $R := min\{R_3, R_5\}$, where R_3 is the same as in Theorem [5.1](#page-20-0) and R_5 the same as in Proposition [5.4.](#page-23-0) Without loss of generality, we may assume that $\int_{\Omega} u \, dx = 0$. Take $c_0 \in (0, \delta_0/16)$, where δ_0 is the same as in Proposition [5.4.](#page-23-0)

From Hölder's inequality, Remark [1.3,](#page-3-1) and the definition of $||f||_{BMO_{r,+}(\Omega;\mathbb{R}^n)}$, we deduce that

(5.11)
$$
\sup_{x \in \Omega} \sup_{r \in [c_0 R, \text{diam}(\Omega))} \left[\int_{\Omega \cap B(x,r)} |\nabla u(y) - (\nabla u)_{\Omega \cap B(x,r)}|^2 dy \right]^{1/2} \lesssim \left[\int_{\Omega} |\nabla u(y)|^2 dy \right]^{1/2} \lesssim ||f||_{\text{BMO}_{r,+}(\Omega; \mathbb{R}^n)}.
$$

Now, assume that $x \in \Omega$ and $r \in (0, c_0 R)$. If $B(x, \frac{2}{\delta_0} r) \cap \partial \Omega \neq \emptyset$, then there exists $x_0 \in \partial \Omega$ such that $B(x, r) \subset B(x_0, \frac{8}{\delta \sigma})$ $\frac{8}{\delta_0}$ *r*). By the assumptions $c_0 < \frac{\delta_0}{16}$ and $r \in (0, c_0 R)$, we have $\frac{8}{\delta_0} r < \frac{R}{2}$ $\frac{R}{2}$. Then, from [\(5.1\)](#page-20-4), it follows that, when $B(x, \frac{2}{\delta_0}r) \cap \partial\Omega \neq \emptyset$,

$$
(5.12) \qquad \left[\int_{\Omega\cap B(x,r)} \left|\nabla u(y) - (\nabla u)_{\Omega\cap B(x,r)}\right|^2 \, dy\right]^{1/2} \leq \left[\int_{\Omega\cap B(x_0,\frac{8}{\delta_0}r)} \left|\nabla u(y) - (\nabla u)_{\Omega\cap B(x_0,\frac{8}{\delta_0}r)}\right|^2 \, dy\right]^{1/2} \lesssim ||f||_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)}.
$$

On the other hand, if *B*(*x*, $\frac{2}{\delta_0}r$) ⊂ Ω, then, by [\(5.10\)](#page-23-3),

$$
\left[\oint_{B(x,r)} |\nabla u(y) - (\nabla u)_{B(x,r)}|^2 dy\right]^{1/2}
$$
\n
$$
\leq \frac{1}{2} \sup_{s \in (0,R)} \left[\oint_{\Omega \cap B(x,s)} |\nabla u(y) - (\nabla u)_{\Omega \cap B(x,s)}|^2 dy\right]^{\frac{1}{2}} + C||f||_{\text{BMO}_{r,+}(\Omega; \mathbb{R}^n)} < \infty,
$$

which, combined with [\(5.11\)](#page-23-4) and [\(5.12\)](#page-24-0), further implies that there exists a positive constant *C* independent of *u* and *f* such that

$$
\sup_{x \in \Omega} \sup_{r \in (0, \text{diam}(\Omega))} \left[\int_{\Omega \cap B(x,r)} |\nabla u(y) - (\nabla u)_{\Omega \cap B(x,r)}|^2 dy \right]^{1/2} \le \frac{1}{2} \sup_{x \in \Omega} \sup_{r \in (0, \text{diam}(\Omega))} \left[\int_{\Omega \cap B(x,r)} |\nabla u(y) - (\nabla u)_{\Omega \cap B(x,r)}|^2 dy \right]^{1/2} + C ||f||_{\text{BMO}_{r,+}(\Omega; \mathbb{R}^n)} < \infty.
$$

From this and Lemmas [2.1](#page-7-0) and [2.2,](#page-7-1) we deduce that $\nabla u \in BMO_r(\Omega; \mathbb{R}^n)$ and [\(1.10\)](#page-4-2) holds. This finishes the proof of Theorem [1.5.](#page-4-1)

Proof of Corollary [1.8.](#page-6-0) Here we only give the proof in the case of the Neumann problem because the proof in the case of the Dirichlet problem is similar.

We first assume that $f \in H^1_z(\Omega; \mathbb{R}^n) \cap L^2(\Omega; \mathbb{R}^n)$. Let $u \in W^{1,2}(\Omega)$ be the weak solution to the Neumann problem [\(1.6\)](#page-1-0). Without loss of generality, we may assume that $\int_{\Omega} u dx = 0$. Let *v* be the weak solution to the Neumann problem (1.6) with the coefficient matrix A^t and the right-hand side $g \in L^{\infty}(\Omega; \mathbb{R}^n)$. Here *A^t* denotes the transpose of the matrix *A*. Then

(5.13)
$$
\int_{\Omega} f(x) \cdot \nabla v(x) dx = \int_{\Omega} A(x) \nabla u(x) \cdot \nabla v(x) dx
$$

$$
= \int_{\Omega} A^t(x) \nabla v(x) \cdot \nabla u(x) dx = \int_{\Omega} g(x) \cdot \nabla u(x) dx.
$$

Notice that the matrix *A* satisfies Assumption (*A*[&](#page-4-0)Ω) if and only if *A t* satisfies the same Assumption (*A*[&](#page-4-0)Ω). Therefore, by Theorem [1.5](#page-4-1) and the obvious fact that $L^{\infty}(\Omega) \hookrightarrow BMO_r(\Omega)$, we have

$$
\|\nabla v\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)} \lesssim \|g\|_{L^{\infty}(\Omega;\mathbb{R}^n)},
$$

which, together with (5.13) and Lemma [2.3,](#page-8-1) further implies that

$$
(5.14) \qquad \|\nabla u\|_{L^1(\Omega;\mathbb{R}^n)} = \sup_{\|g\|_{L^{\infty}(\Omega;\mathbb{R}^n)}\leq 1} \left|\int_{\Omega} g(x) \cdot \nabla u(x) \, dx\right| = \sup_{\|g\|_{L^{\infty}(\Omega;\mathbb{R}^n)}\leq 1} \left|\int_{\Omega} f(x) \cdot \nabla v(x) \, dx\right|
$$

\$\leq \sup_{\|g\|_{L^{\infty}(\Omega;\mathbb{R}^n)}\leq 1} \|f\|_{H^1_{\xi}(\Omega;\mathbb{R}^n)} \|\nabla v\|_{\text{BMO}_r(\Omega;\mathbb{R}^n)} \leq \|f\|_{H^1_{\xi}(\Omega;\mathbb{R}^n)}.

This estimate, combined with the assumption $\int_{\Omega} u \, dx = 0$ and the Sobolev–Poincaré inequality, yields that *u* ∈ *W*^{1,1}(Ω).

Now, assume that *f* ∈ *H*₂¹(Ω; ℝⁿ). Since *H*₂¹(Ω) ∩ *L*²(Ω) is dense in *H*₂¹(Ω) (see, for instance, [\[45,](#page-28-13) p. 109, Lemma]), it follows that there exists a sequence $\{f_m\}_{m=1}^{\infty} \subset H^1_{z}(\Omega; \mathbb{R}^n) \cap L^2(\Omega; \mathbb{R}^n)$ such that

(5.15)
$$
\lim_{m \to \infty} ||f_m - f||_{H_z^1(\Omega; \mathbb{R}^n)} = 0.
$$

For any $m \in \mathbb{N}$, let $u_m \in W^{1,2}(\Omega)$ be the weak solution of the Neumann problem [\(1.6\)](#page-1-0) with the right-hand side f_m . Assume also that, for any $m \in \mathbb{N}$, $\int_{\Omega} u_m dx = 0$. By this, [\(5.14\)](#page-24-2), and [\(5.15\)](#page-25-2), we see that ${u_m}_{m=1}^{\infty}$ is a Cauchy sequence in $W^{1,1}(\Omega)$. Therefore, there exist a function $u \in W^{1,1}(\Omega)$ and a subsequence of $\{u_m\}_{m=1}^{\infty}$, still denoted by $\{u_m\}_{m=1}^{\infty}$, such that $u_m \to u$ in $W^{1,1}(\Omega)$ as $m \to \infty$. From this, [\(5.15\)](#page-25-2), and the fact that $H_z^1(\Omega) \hookrightarrow L^1(\Omega)$, we further deduce that, for any $\varphi \in C^\infty(\mathbb{R}^n)$,

$$
\int_{\Omega} A(x) \nabla u(x) \cdot \nabla \varphi(x) \, dx = \int_{\Omega} f(x) \cdot \nabla \varphi(x) \, dx,
$$

which implies that $u \in W^{1,1}(\Omega)$ is a weak solution of the Neumann problem [\(1.6\)](#page-1-0) with $f \in$ $H^1_\text{z}(\Omega;\mathbb{R}^n)$. By this and [\[2,](#page-27-22) Theorem 1.2], we conclude that the Neumann problem [\(1.6\)](#page-1-0) with $f \in H_z^1(\Omega;\mathbb{R}^n)$ is uniquely solvable. Furthermore, from [\(5.14\)](#page-24-2), [\(5.15\)](#page-25-2), and $\lim_{m\to\infty} \|\nabla u_m \nabla u||_{L^1(\Omega;\mathbb{R}^n)} = 0$, it follows that $\|\nabla u\|_{L^1(\Omega;\mathbb{R}^n)} \lesssim \|f\|_{H^1_{\zeta}(\Omega;\mathbb{R}^n)}$. This finishes the proof of the corol- \Box lary.

6 Proof of Theorem [1.9](#page-6-4)

In this section, we prove Theorem [1.9](#page-6-4) by using Theorem [1.5](#page-4-1) and a perturbation method. We begin with recalling the unique solvability of the Robin problem (1.13) when $p = 2$.

Remark 6.1. Similarly to Remark [1.3,](#page-3-1) by the Lax–Milgram theorem and the Friedrichs inequality (see, for instance, [\[41,](#page-28-14) Section 1.1.8, Theorem 1.9] and [\[35,](#page-28-22) Theorem 6.1]), we conclude that, when $p = 2$, the Robin problem [\(1.13\)](#page-6-1) with $f \in L^2(\Omega; \mathbb{R}^n)$ is uniquely solvable and the weak solution *u* satisfies

$$
||u||_{W^{1,2}(\Omega)} \lesssim ||f||_{L^2(\Omega;\mathbb{R}^n)}
$$

with the implicit positive constant independent of *u* and *f* (see, for instance, [\[47,](#page-29-0) Remark 1.2]).

Lemma 6.2. *Let* $n \geq 2$, $\Omega \subset \mathbb{R}^n$ *be a bounded Lipschitz domain, and* β *be the same as in* [\(1.12\)](#page-6-3)*. Assume that A and* Ω *satisfy Assumption [\(A](#page-4-0)*&Ω*). Let p* ∈ (1, ∞)*. Then the Robin problem* [\(1.13\)](#page-6-1) *with* $f \in L^p(\Omega; \mathbb{R}^n)$ *is uniquely solvable and the weak solution u satisfies*

(6.1)
$$
||u||_{W^{1,p}(\Omega)} \leq C||f||_{L^p(\Omega;\mathbb{R}^n)},
$$

where C is a positive constant independent of u and f.

The proof of Lemma [6.2](#page-25-3) is similar to that of [\[25,](#page-28-18) Theorem 2.6]; we omit the details. Now, we show Theorem [1.9](#page-6-4) by using Lemma [6.2](#page-25-3) and Theorem [1.5.](#page-4-1)

Proof of Theorem [1.9.](#page-6-4) We first prove (i). Let $f \in BMO_r(\Omega;\mathbb{R}^n)$ and *u* be the weak solution to the Robin problem [\(1.13\)](#page-6-1). By the fact that $BMO_r(\Omega) \subset L^p(\Omega)$ with $p \in (n, \infty)$, Lemmas [2.1,](#page-7-0) [2.2,](#page-7-1) and [6.2,](#page-25-3) and the Sobolev inequality, we have $u \in L^{\infty}(\Omega)$ and

 $||u||_{L^{\infty}(\Omega)} \lesssim ||u||_{W^{1,p}(\Omega)} \lesssim ||f||_{L^p(\Omega;\mathbb{R}^n)} \lesssim ||f - (f)_{\Omega}||_{L^p(\Omega;\mathbb{R}^n)} + ||f||_{L^1(\Omega;\mathbb{R}^n)}$ (6.2) $\leq \|f\|_{\text{BMO}(\Omega;\mathbb{R}^n)} + \|f\|_{L^2(\Omega;\mathbb{R}^n)} \leq \|f\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)}.$

Let ν be a weak solution of the Neumann problem

$$
\begin{cases} \operatorname{div}(A\nabla v) = \operatorname{div} f & \text{in } \Omega, \\ \frac{\partial v}{\partial v} = f \cdot v & \text{on } \partial \Omega \end{cases}
$$

and $w := u - v$. Then *w* is a weak solution of the Neumann problem

(6.3)
$$
\begin{cases} \text{div}(A\nabla w) = 0 & \text{in } \Omega, \\ \frac{\partial w}{\partial \nu} = -\beta u & \text{on } \partial \Omega. \end{cases}
$$

It is worth pointing out that the condition $\int_{\partial \Omega} \beta u \, d\sigma(x) = 0$ is necessary for the solvability of the Neumann problem [\(6.3\)](#page-26-0), and $\int_{\partial\Omega} \beta u \, d\sigma(x) = 0$ follows from [\(1.14\)](#page-6-2). From Theorem [1.5,](#page-4-1) we deduce that

(6.4)
$$
\|\nabla v\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)} \lesssim \|f\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)}.
$$

Now let u_1 be the weak solution of the Neumann problem [\(1.6\)](#page-1-0) with the coefficient matrix A^t and the right-hand side $f_1 \in H^1_{z}(\Omega; \mathbb{R}^n) \cap L^2(\Omega; \mathbb{R}^n)$, satisfying $\int_{\Omega} u_1 dx = 0$. By the Sobolev trace theorem (see [\[41,](#page-28-14) Section 2.4.2, Theorem 4.2]) and Corollary [1.8,](#page-6-0) we get

$$
(6.5) \t\t ||u_1||_{L^1(\partial\Omega)} \lesssim ||u_1||_{W^{1,1}(\Omega)} \lesssim ||\nabla u_1||_{L^1(\Omega;\mathbb{R}^n)} \lesssim ||f_1||_{H^1_{\epsilon}(\Omega;\mathbb{R}^n)}.
$$

Moreover, we have

$$
\int_{\Omega} f_1(x) \cdot \nabla w(x) dx = \int_{\Omega} A^t(x) \nabla u_1(x) \cdot \nabla w(x) dx = - \int_{\partial \Omega} \beta(x) u(x) u_1(x) d\sigma(x),
$$

which, together with Lemma [2.3,](#page-8-1) (6.2) , and (6.5) , further implies that

$$
(6.6) \qquad \|\nabla w\|_{\text{BMO}_r(\Omega;\mathbb{R}^n)} \sim \sup_{\|f_1\|_{H^1_c(\Omega;\mathbb{R}^n)}\leq 1} \left| \int_{\Omega} f_1(x) \cdot \nabla w(x) dx \right|
$$

$$
\sim \sup_{\|f_1\|_{H^1_c(\Omega;\mathbb{R}^n)}\leq 1} \left| \int_{\partial\Omega} \beta(x) u(x) u_1(x) d\sigma(x) \right|
$$

$$
\lesssim \sup_{\|f_1\|_{H^1_c(\Omega;\mathbb{R}^n)}\leq 1} \|u\|_{L^{\infty}(\Omega)} \|u_1\|_{L^1(\partial\Omega)}
$$

$$
\lesssim \sup_{\|f_1\|_{H^1_c(\Omega;\mathbb{R}^n)}\leq 1} \|f\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)} \|f_1\|_{H^1_c(\Omega;\mathbb{R}^n)} \leq \|f\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)}.
$$

Similarly, we also have

$$
\|\nabla w\|_{L^2(\Omega;\mathbb{R}^n)} \lesssim \|f\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)}.
$$

From this, [\(6.6\)](#page-26-2), [\(6.4\)](#page-26-3), and the fact that $\nabla u = \nabla v + \nabla w$, it follows that $\nabla u \in BMO_r(\Omega;\mathbb{R}^n)$ and $\|\nabla u\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)} \lesssim \|f\|_{\text{BMO}_{r,+}(\Omega;\mathbb{R}^n)}$. This finishes the proof of (i). The proof of (ii) is similar to that of Corollary [1.8](#page-6-0) and we omit the details here. This finishes the proof of Theorem [1.9.](#page-6-4)
