ON NEW IDENTITIES INVOLVING ZEROS OF BESSEL FUNCTIONS

ABSTRACT. We derive new identities involving zeros of the Bessel function J_{ν} and some related functions. These are special cases of more general identities obtained in this note, which might also be of interest.

ADDENDUM AFTER PUBLICATION

After this paper had been published in J. Math. Anal. Appl., the author of [K. Urbanowicz, *Infinite series based on Bessel zeros*, Appl. Sci. 13 (2023), 12932, 28 pp.] informed us about his paper and an overlap with his results. More precisely, Formulas (F9) and (F10) from our paper appear as Formulas (A11) and (A14) in the above-mentioned paper. Our results are independent, and the proofs are different. In fact, our paper had been finished and submitted to a journal in November 2023, before the paper by Urbanowicz was published.

Moreover, thanks to Urbanowicz' paper, we became aware of the reference [G.N. Afanasiev, *Closed* expressions for some useful integrals involving Legendre functions and sum rules for zeroes of Bessel functions, J. Comput. Phys. 85 (1989), 245–252], where essentially Formulas (F1)–(F4) from our paper appear on page 251 there, however (F2) with a misprint, and (F4) with an error that was corrected by Urbanowicz in the paper quoted above, see (A5) there. The methods used by Afanasiev are different from our approach.

We refer to Urbanowicz' paper for many more series involving zeros of Bessel functions, interesting motivations, and a long list of references relevant to the topic. We are grateful to the author for bringing his paper to our attention.

1. INTRODUCTION

Let $\nu > -1$ and denote by j_n^{ν} , $n \ge 1$, the sequence of successive strictly positive zeros of the Bessel function J_{ν} , cf. [20, Chap. XV]. There is no explicit expression for j_n^{ν} except for the two special cases when $\nu = \pm 1/2$ in which one has $j_n^{-1/2} = \pi (n - 1/2)$ and $j_n^{1/2} = \pi n$. Nevertheless, there are many striking summation identities involving the zeros of J_{ν} where apart from the zeros everything else is explicit. A classic example here is Raighley's formula (cf. [20, Chap. XV, Sec. 15.51])

(1)
$$\sum_{k=1}^{\infty} \frac{1}{(j_k^{\nu})^2} = \frac{1}{4(\nu+1)}$$

Actually, the above series is computable explicitly if one replaces 2 by any other positive even power, see [14, 11, 19, 9]. Another classic identity involving the zeros of J_{ν} is the Mittag-Leffler expansion (cf. [20, Chap. XV, Sec. 15.41])

$$\frac{J_{\nu+1}(x)}{J_{\nu}(x)} = \sum_{k=1}^{\infty} \frac{2x}{(j_k^{\nu})^2 - x^2},$$

where, in particular, the left-hand side vanishes with the choice $x = j_n^{\nu+1}$, $n \ge 1$. Further examples of this kind are formulas found by Calogero [7, 8]

(2)
$$\sum_{\substack{k \ge 1, k \ne n}} \frac{(j_n^{\nu})^2}{(j_k^{\nu})^2 - (j_n^{\nu})^2} = \frac{\nu + 1}{2}, \quad n \ge 1,$$
$$\sum_{\substack{k \ge 1, k \ne n}} \frac{(j_n^{\nu})^4}{[(j_k^{\nu})^2 - (j_n^{\nu})^2]^2} = \frac{(j_n^{\nu})^2 - (\nu + 1)(\nu + 5)}{12}, \quad n \ge 1$$

Curiously enough, the research of Calogero had some physical background, actually it was mainly a spin-off of the study of certain integrable many-body problems, cf. [1] and references there. It is also possible to compute analogous series with the numerator and the denominator of the summand in (2) raised separately to various integer positive powers, see [8, 3, 1]. Other formulas in this spirit can be found in [19], [18, Sec. 5.7.33], [6] (see also [5]) and [9], among others.

It is perhaps interesting that all the above displayed formulas were indispensable in our recent study devoted to some questions in harmonic analysis of Fourier-Bessel expansions [13]. This inspired the present note in which we derive several up to our best knowledge new identities including, for instance,

$$\sum_{k\geq 1} \frac{(j_k^{\nu})^2}{[(j_k^{\nu})^2 - (j_n^{\nu+1})^2]^2} = \sum_{k\geq 1} \frac{(j_k^{\nu+1})^2}{[(j_k^{\nu+1})^2 - (j_n^{\nu})^2]^2} = \frac{1}{4}, \qquad n\geq 1.$$

Comparing to most of other known formulas, our identities involve zeros of more than one Bessel or related function (in the two cases above, J_{ν} and $J_{\nu+1}$). The method we use is rather elementary, but relies on a quite deep fact that the Fourier-Bessel and Fourier-Dini systems form orthogonal bases in $L^{2}((0,1), dx).$

2. Preliminaries

In this section we first briefly describe the general notation used in the paper. Then we present for further reference various facts and formulas related to Bessel functions. Finally, we give basic information on Fourier-Bessel and Fourier-Dini systems.

2.1. Notation. Throughout this note we use fairly standard notation. By $\langle \cdot, \cdot \rangle$ we denote the usual inner product in $L^2((0,1), dx)$. For a condition that can have logical value true or false we shall denote

$$\chi_{\{\text{condition}\}} := \begin{cases} 1, & \text{if condition is true,} \\ 0, & \text{if condition is false.} \end{cases}$$

When denoting zeros of Bessel and related functions, we choose to write the index indicating the order as superscript, i.e. j_n^{ν} , $j_n^{\nu,H}$ rather than $j_{n,\nu}$ or $j_{n,\nu,H}$. This is to make the notation more compact and stick to notation of other quantities or objects depending on the order.

2.2. Facts and formulas concerning the Bessel functions J_{ν} and I_{ν} . For the material presented in this section we refer to Watson's monograph [20]; for an easy online access to many facts and formulas related to Bessel functions see [16, Chap. 10].

Let J_{ν} be the Bessel function of the first kind and order ν and let I_{ν} be the modified Bessel function of the first kind and order ν . In this paper, for our purpose, we shall essentially always consider J_{ν} and I_{ν} as functions on the positive half-line. Further, throughout the paper we assume that the parameter $\nu > -1.$

For further reference, we list some useful identities

(3)
$$J_{\nu-1}(x) + J_{\nu+1}(x) = \frac{2\nu}{x} J_{\nu}(x), \qquad I_{\nu-1}(x) - I_{\nu+1}(x) = \frac{2\nu}{x} I_{\nu}(x),$$

(4)
$$x J_{\nu}'(x) - \nu J_{\nu}(x) = -x J_{\nu+1}(x), \qquad x I_{\nu}'(x) - \nu I_{\nu}(x) = x I_{\nu+1}(x),$$

(4)
$$xJ'_{\nu}(x) - \nu J_{\nu}(x) = -x$$

(5)
$$\left[x^{-\nu} J_{\nu}(x) \right]' = -x^{-\nu} J_{\nu+1}(x),$$

We also note the asymptotics

(6)
$$J_{\nu}(x) = \mathcal{O}(x^{\nu}), \qquad I_{\nu}(x) = \mathcal{O}(x^{\nu}), \qquad x \to 0^+,$$

and the special cases

$$J_{-1/2}(x) = \sqrt{\frac{2}{\pi x}} \cos x, \qquad J_{1/2}(x) = \sqrt{\frac{2}{\pi x}} \sin x.$$

 $\left[x^{-\nu}I_{\nu}(x)\right]' = x^{-\nu}I_{\nu+1}(x).$

In general, J_{ν} expresses directly via elementary functions if and only if ν is an odd half-integer.

Both J_{ν} and I_{ν} are smooth on $(0,\infty)$ and I_{ν} is strictly positive there, but J_{ν} has infinitely many isolated zeros in $(0,\infty)$. We denote the sequence of successive strictly positive zeros of J_{ν} by $\{j_n^{\nu} : n \ge 1\}$. The derivative J'_{ν} also has infinitely many isolated zeros in $(0,\infty)$. We denote them[†], in an ascending order, by $\{(j_n^{\nu})' : n \ge 1\}.$

[†] We do not make an exception appearing sometimes in the literature, see e.g. [16, §10.21(i)], that when $\nu = 0$ the zeros of J'_0 are counted from x = 0.

For a parameter $H \in \mathbb{R}$ we consider the auxiliary functions

$$J_{\nu,H}(x) := x J'_{\nu}(x) + H J_{\nu}(x)$$
 and $I_{\nu,H}(x) := x I'_{\nu}(x) + H I_{\nu}(x)$

By convention, we define $J_{\nu,\infty} := J_{\nu}$ and $I_{\nu,\infty} := I_{\nu}$. Observe that making use of (4) and (3) we get

(7)
$$J_{\nu,H}(x) = x^{1-H} \left[x^H J_{\nu}(x) \right]' = (H+\nu) J_{\nu}(x) - x J_{\nu+1}(x) = (H-\nu) J_{\nu}(x) + x J_{\nu-1}(x),$$

(8)
$$I_{\nu,H}(x) = x^{1-H} \left[x^H I_{\nu}(x) \right]' = (H+\nu) I_{\nu}(x) + x I_{\nu+1}(x) = (H-\nu) I_{\nu}(x) + x I_{\nu-1}(x).$$

The function $J_{\nu,H}$ has infinitely many isolated zeros in $(0,\infty)$. We denote their sequence in an ascending order of magnitude by $\{j_n^{\nu,H} : n \ge 1\}$. The function $I_{\nu,H}$ has no zeros in $(0,\infty)$ when $H + \nu \ge 0$, and exactly one strictly positive zero otherwise[‡] which we denote by $j_0^{\nu,H}$ (note that^{\\[\eta]} when $\nu + H < 0, \pm i j_0^{\nu,H}$ are the only imaginary zeros of $(\cdot)^{-\nu}J_{\nu,H}$, cf. [20, Chap. XVIII, Sec. 18.3]). In case $H + \nu = 0$, we also set $j_0^{\nu,H} := 0$. By convention, we define $j_n^{\nu,\infty} := j_n^{\nu}$. Observe that, in view of (7), for the special values of $H = -\nu, \nu, 0$ one has (in the second identity we consider $\nu > 0$)

(9)
$$j_n^{\nu,-\nu} = j_n^{\nu+1}, \quad j_n^{\nu,\nu} = j_n^{\nu-1}, \quad j_n^{\nu,0} = (j_n^{\nu})', \quad n \ge 1, \quad \text{and} \quad j_0^{\nu,0} = (j_0^{\nu})' \text{ for } \nu < 0,$$

where $(i^{\nu})'$ is the only strictly positive zero of I' in case $\mu < 0$.

where $(j_0^{\nu})'$ is the only strictly positive zero of I'_{ν} in case $\nu < 0$.

We will also need the relations, see (3) and (4),

(10)
$$J_{\nu+1}(j_n^{\nu-1}) = \frac{2\nu}{j_n^{\nu-1}} J_{\nu}(j_n^{\nu-1}), \qquad n \ge 1, \quad \nu > 0$$

(11)
$$J_{\nu+1}((j_n^{\nu})') = \frac{\nu}{(j_n^{\nu})'} J_{\nu}((j_n^{\nu})'), \quad n \ge 1, \quad I_{\nu+1}((j_0^{\nu})') = -\frac{\nu}{(j_0^{\nu})'} I_{\nu}((j_0^{\nu})') \quad \text{if } \nu < 0.$$

There is a vast literature devoted to zeros of Bessel and related functions, which covers also functions like $J_{\nu,H}$. The basic reference is Watson's monograph [20]. For more recent developments concerning zeros of $J_{\nu,H}$ and motivations for their study see for instance [12] and references given there. In particular, various series involving zeros of $J_{\nu,H}$ were computed, see e.g. [19, 2, 4].

2.3. Fourier-Bessel and Fourier-Dini systems. Define the following quantities:

$$c_n^{\nu} := \frac{\sqrt{2}}{|J_{\nu+1}(j_n^{\nu})|}, \qquad c_n^{\nu,H} := \frac{\sqrt{2}}{|J_{\nu}(j_n^{\nu,H})|} \frac{j_n^{\nu,H}}{\sqrt{\left(j_n^{\nu,H}\right)^2 - \nu^2 + H^2}}, \qquad n \ge 1$$

and, in case $\nu + H < 0$, define also

$$c_0^{\nu,H} := \frac{\sqrt{2}}{I_\nu(j_0^{\nu,H})} \frac{j_0^{\nu,H}}{\sqrt{(j_0^{\nu,H})^2 + \nu^2 - H^2}}$$

By convention, we set $c_n^{\nu,\infty} := c_n^{\nu}, n \ge 1$. Note that the constants $c_n^{\nu,H}, H \in \mathbb{R} \cup \{\infty\}, n \ge \chi_{\{H+\nu \ge 0\}}, n \ge \xi_{\{H+\nu \ge 0\}}, n \ge \xi_{\{H+\perp 0\}}, n \ge$ are well-defined and strictly positive. This follows from evaluation of $(c_n^{\nu,H})^{-2}$ as certain strictly positive integrals, see the comments preceding Theorem 2.1.

Next, define the following functions on the interval (0, 1):

$$\psi_n^{\nu}(x) := c_n^{\nu} \sqrt{x} J_{\nu}(j_n^{\nu} x), \qquad \psi_n^{\nu,H}(x) := c_n^{\nu,H} \sqrt{x} J_{\nu}(j_n^{\nu,H} x), \qquad n \ge 1$$

In addition, in case $\nu + H \leq 0$, define

$$\psi_0^{\nu,H}(x) := \begin{cases} c_0^{\nu,H} \sqrt{x} I_\nu(j_0^{\nu,H} x), & \text{if } H + \nu < 0, \\ \sqrt{2(\nu+1)} x^{\nu+1/2}, & \text{if } H + \nu = 0. \end{cases}$$

By convention, we set $\psi_n^{\nu,\infty} := \psi_n^{\nu}, n \ge 1$.

The result stated below is well-known, see [20, Chap. XVIII] and [10]. The difficult part of the proof is completeness of the two systems, cf. [10]. On the other hand, orthogonality and values of the normalizing constants $c_n^{\nu,H}$ are deduced from Lommel's integrals, cf. [20, Chap. V, Sec. 5.11]. Convenient references to the formulas needed here are the following: [18, Sec. 1.8.3, Form. 10], [18, Sec. 1.11.5, Form. 2], [18, Sec. 1.8.1, Form. 21] (orthogonality) and [18, Sec. 1.8.3, Form. 11], [18, Sec. 1.11.3, Form. 4] (values of the normalizing constants).

[‡] This can immediately be seen from (8) and the Mittag-Leffler expansion $\frac{xI_{\nu+1}(x)}{I_{\nu}(x)} = \sum_{k=1}^{\infty} \frac{2}{1+(j_{k}^{\nu}/x)^{2}}$. [‡] It is easy to check that $(ix)^{-\nu}J_{\nu,H}(ix) = x^{-\nu}I_{\nu,H}(x)$ for x > 0 and $H \in \mathbb{R} \cup \{\infty\}$.

Theorem 2.1. Let $\nu > -1$ and $H \in \mathbb{R}$ be fixed. Then the Fourier-Bessel and the Fourier-Dini systems

$$\left\{\psi_n^{\nu}: n \ge 1\right\} \qquad and \qquad \left\{\psi_n^{\nu,H}: n \ge \chi_{\{H+\nu>0\}}\right\}$$

respectively, are orthonormal bases in $L^2((0,1), dx)$.

Observe that we can incorporate the Fourier-Bessel system into the family of the Fourier-Dini systems by allowing $H = \infty$. This has a deeper background, since in some aspects the Fourier-Bessel system can be seen as the limiting case of the Fourier-Dini system as $H \to \infty$, cf. [20, Chap. XVIII, Sec. 18.11].

The next result is also known and can be easily verified by a direct computation with the aid of (5). It says that the Fourier-Bessel and the Fourier-Dini systems consist of eigenfunctions of the Bessel differential operator

(12)
$$\mathbb{L}^{\nu}f(x) := -\frac{d^2}{dx^2}f(x) - \frac{1/4 - \nu^2}{x^2}f(x) = -x^{-\nu - 1/2}\frac{d}{dx}\left(x^{2\nu+1}\frac{d}{dx}\left[x^{-\nu - 1/2}f(x)\right]\right)$$

Proposition 2.2. Let $\nu > -1$ and $H \in \mathbb{R} \cup \{\infty\}$. Then

$$\mathbb{L}^{\nu}\psi_{n}^{\nu,H} = (-1)^{\chi_{\{n=0\}}} (j_{n}^{\nu,H})^{2} \psi_{n}^{\nu,H}, \qquad n \ge \chi_{\{H+\nu>0\}}$$

Theorem 2.1 and Proposition 2.2 are crucial in what follows. Note that in the context of Theorem 2.1 Parseval's identity can be written as

$$||f||^{2}_{L^{2}((0,1),dx)} = \sum_{k \ge \chi_{\{H+\nu>0\}}} |\langle f, \psi^{\nu,H}_{k} \rangle|^{2}, \qquad f \in L^{2}((0,1),dx),$$

where $\nu > -1$ and $H \in \mathbb{R} \cup \{\infty\}$.

3. General result

For
$$H_1, H_2 \in \mathbb{R} \cup \{\infty\}$$
 and $n \ge \chi_{\{H_1 + \nu \ge 0\}}, k \ge \chi_{\{H_2 + \nu \ge 0\}}$, define
$$b_{n,k}^{\nu,H_1,H_2} := c_n^{\nu,H_1} c_k^{\nu,H_2} \Big[j_n^{\nu,H_1} J_{\nu+1} \big(j_n^{\nu,H_1} \big) J_{\nu} \big(j_k^{\nu,H_2} \big) - j_k^{\nu,H_2} J_{\nu} \big(j_n^{\nu,H_1} \big) J_{\nu+1} \big(j_k^{\nu,H_2} \big) \Big],$$

where we use the following convention: in case n = 0 the Bessel functions J_{ν} and $J_{\nu+1}$ which are evaluated at j_0^{ν,H_1} must be replaced by I_{ν} and $I_{\nu+1}$, respectively, with analogous replacement in case k = 0 and the Bessel functions evaluated at j_0^{ν,H_2} . Further, with the same convention in force, to cover the relevant corner cases we set

$$b_{n,k}^{\nu,H_1,H_2} := \begin{cases} -(-1)^{\chi_{\{k=0\}}} \sqrt{2(\nu+1)} c_k^{\nu,H_2} j_k^{\nu,H_2} J_{\nu+1}(j_k^{\nu,H_2}) & \text{if } H_1 + \nu = n = 0 \text{ and } k \ge \chi_{\{H_2 + \nu \ge 0\}}, \\ (-1)^{\chi_{\{n=0\}}} \sqrt{2(\nu+1)} c_n^{\nu,H_1} j_n^{\nu,H_1} J_{\nu+1}(j_n^{\nu,H_1}) & \text{if } H_2 + \nu = k = 0 \text{ and } n \ge \chi_{\{H_1 + \nu \ge 0\}}. \end{cases}$$

Lemma 3.1. Let $\nu > -1$ and $H_1, H_2 \in \mathbb{R} \cup \{\infty\}$ be such that $H_1 \neq H_2$. Then

$$\left\langle \mathbb{L}^{\nu}\psi_{n}^{\nu,H_{1}},\psi_{k}^{\nu,H_{2}}\right\rangle = \left\langle \psi_{n}^{\nu,H_{1}},\mathbb{L}^{\nu}\psi_{k}^{\nu,H_{2}}\right\rangle + b_{n,k}^{\nu,H_{1},H_{2}}, \qquad n \ge \chi_{\{H_{1}+\nu>0\}}, \quad k \ge \chi_{\{H_{2}+\nu>0\}}.$$

Proof. We shall use the divergence form of \mathbb{L}^{ν} , see (12), and integrate twice by parts. Denote

$$\mathcal{I} := \left\langle \mathbb{L}^{\nu} \psi_{n}^{\nu, H_{1}}, \psi_{k}^{\nu, H_{2}} \right\rangle = \int_{0}^{1} \mathbb{L}^{\nu} \psi_{n}^{\nu, H_{1}}(x) \psi_{k}^{\nu, H_{2}}(x) \, dx.$$

Clearly, the last integral converges since $\mathbb{L}^{\nu}\psi_n^{\nu,H_1}$ (see Proposition 2.2) and ψ_k^{ν,H_2} are in $L^2((0,1),dx)$.

In what follows we assume that $n \ge \chi_{\{H_1+\nu\ge 0\}}$ and $k \ge \chi_{\{H_2+\nu\ge 0\}}$. The remaining corner cases are simpler and left to the reader. We have

$$\begin{split} \mathcal{I} &= -\int_{0}^{1} x^{-\nu-1/2} \frac{d}{dx} \Big(x^{2\nu+1} \frac{d}{dx} \big[x^{-\nu-1/2} \psi_{n}^{\nu,H_{1}}(x) \big] \Big) \psi_{k}^{\nu,H_{2}}(x) \, dx \\ &= -x^{\nu+1/2} \frac{d}{dx} \big[x^{-\nu-1/2} \psi_{n}^{\nu,H_{1}}(x) \big] \psi_{k}^{\nu,H_{2}}(x) \Big|_{0}^{1} \\ &+ \int_{0}^{1} \frac{d}{dx} \big[x^{-\nu-1/2} \psi_{n}^{\nu,H_{1}}(x) \big] \frac{d}{dx} \big[x^{-\nu-1/2} \psi_{k}^{\nu,H_{2}}(x) \big] x^{2\nu+1} \, dx \\ &= -x^{\nu+1/2} \frac{d}{dx} \big[x^{-\nu-1/2} \psi_{n}^{\nu,H_{1}}(x) \big] \psi_{k}^{\nu,H_{2}}(x) \Big|_{0}^{1} \\ &+ x^{\nu+1/2} \psi_{n}^{\nu,H_{1}}(x) \frac{d}{dx} \big[x^{-\nu-1/2} \psi_{k}^{\nu,H_{2}}(x) \big] \Big|_{0}^{1} \end{split}$$

$$-\int_{0}^{1}\psi_{n}^{\nu,H_{1}}(x)x^{-\nu-1/2}\frac{d}{dx}\left(x^{2\nu+1}\frac{d}{dx}\left[x^{-\nu-1/2}\psi_{k}^{\nu,H_{2}}(x)\right]\right)dx$$
$$\equiv \mathcal{I}_{1}+\mathcal{I}_{2}+\mathcal{I}_{3}.$$

Since $\mathcal{I}_3 = \left\langle \psi_n^{\nu,H_1}, \mathbb{L}^{\nu} \psi_k^{\nu,H_2} \right\rangle$ it remains to show that $\mathcal{I}_1 + \mathcal{I}_2 = b_{n,k}^{\nu,H_1,H_2}$.

For symmetry reasons, it suffices to evaluate \mathcal{I}_1 . Plugging in the explicit expressions for ψ_n^{ν,H_1} and ψ_k^{ν,H_2} , and then using (5), shows that

$$\mathcal{I}_{1} = c_{n}^{\nu,H_{1}} c_{k}^{\nu,H_{2}} j_{n}^{\nu,H_{1}} x J_{\nu+1} (j_{n}^{\nu,H_{1}} x) J_{\nu} (j_{k}^{\nu,H_{2}} x) \Big|_{0}^{1};$$

here and below we use the same convention concerning the replacement of J_{ν} and $J_{\nu+1}$ by I_{ν} and $I_{\nu+1}$ as in the definition of $b_{n,k}^{\nu,H_1,H_2}$. In view of the asymptotics (6) we infer that

$$\mathcal{I}_{1} = c_{n}^{\nu,H_{1}} c_{k}^{\nu,H_{2}} j_{n}^{\nu,H_{1}} J_{\nu+1} (j_{n}^{\nu,H_{1}}) J_{\nu} (j_{k}^{\nu,H_{2}})$$

This also implies

$$\mathcal{I}_{2} = -c_{n}^{\nu,H_{1}}c_{k}^{\nu,H_{2}}j_{k}^{\nu,H_{2}}J_{\nu}(j_{n}^{\nu,H_{1}})J_{\nu+1}(j_{k}^{\nu,H_{2}})$$

and thus finishes the proof.

Theorem 3.2. Let $\nu > -1$ and assume that $H_1, H_2 \in \mathbb{R} \cup \{\infty\}$ are such that $H_1 \neq H_2$. Then the following identities hold:

$$\sum_{k \ge \chi_{\{H_2+\nu>0\}}} \frac{\left|b_{n,k}^{\nu,H_1,H_2}\right|^2}{\left[(-1)^{\chi_{\{n=0\}}} \left(j_n^{\nu,H_1}\right)^2 - (-1)^{\chi_{\{k=0\}}} \left(j_k^{\nu,H_2}\right)^2\right]^2} = 1, \qquad n \ge \chi_{\{H_1+\nu>0\}}$$

Proof. Combining Lemma 3.1 with Proposition 2.2 we get, for $n \ge \chi_{\{H_1+\nu>0\}}$ and $k \ge \chi_{\{H_2+\nu>0\}}$,

$$(-1)^{\chi_{\{n=0\}}} (j_n^{\nu,H_1})^2 \left\langle \psi_n^{\nu,H_1}, \psi_k^{\nu,H_2} \right\rangle = (-1)^{\chi_{\{k=0\}}} (j_k^{\nu,H_2})^2 \left\langle \psi_n^{\nu,H_1}, \psi_k^{\nu,H_2} \right\rangle + b_{n,k}^{\nu,H_1,H_2}.$$

Solving for $\langle \psi_n^{\nu,H_1}, \psi_k^{\nu,H_2} \rangle$ we arrive at

(13)
$$\left\langle \psi_{n}^{\nu,H_{1}},\psi_{k}^{\nu,H_{2}}\right\rangle = \frac{b_{n,k}^{\nu,H_{1},H_{2}}}{(-1)^{\chi_{\{n=0\}}} \left(j_{n}^{\nu,H_{1}}\right)^{2} - (-1)^{\chi_{\{k=0\}}} \left(j_{k}^{\nu,H_{2}}\right)^{2}}$$

Here the following remark is in order (recall that $H_1 \neq H_2$): in the above fraction no singularity occurs. To see this, assume first that $n, k \geq 1$. We may further assume that $H_1, H_2 < \infty$, since if one of them is infinite then the argument simplifies. Suppose a contrario that $j_n^{\nu,H_1} = j_k^{\nu,H_2} =: j^{\nu} > 0$. Then, in view of (7), $j^{\nu}J_{\nu+1}(j^{\nu}) = (H_1 + \nu)J_{\nu}(j^{\nu}) = (H_2 + \nu)J_{\nu}(j^{\nu})$. Here the second equality implies $J_{\nu}(j^{\nu}) = 0$ and then the first one forces $J_{\nu+1}(j^{\nu}) = 0$. But this is a contradiction, since positive zeros of J_{ν} and $J_{\nu+1}$ are interlaced, cf. [20, Chap. XV, Sec. 15·22]. If the condition $n, k \geq 1$ does not hold, the only non-trivial case is when n = k = 0 and $\nu < 0$. But then, supposing that $j_0^{\nu,H_1} = j_0^{\nu,H_2} =: j^{\nu} > 0$, we would have, see (8), $-j^{\nu}I_{\nu+1}(j^{\nu}) = (H_1 + \nu)I_{\nu}(j^{\nu}) = (H_2 + \nu)I_{\nu}(j^{\nu})$, which implies $I_{\nu}(j^{\nu}) = 0$, a contradiction.

Using now Theorem 2.1 and Parseval's identity, and then (13), we can write for any $n \ge \chi_{\{H_1+\nu>0\}}$

$$1 = \left\| \psi_{n}^{\nu,H_{1}} \right\|_{L^{2}((0,1),dx)}^{2} = \sum_{k \ge \chi_{\{H_{2}+\nu>0\}}} \left| \left\langle \psi_{n}^{\nu,H_{1}}, \psi_{k}^{\nu,H_{2}} \right\rangle \right|^{2} \\ = \sum_{k \ge \chi_{\{H_{2}+\nu>0\}}} \frac{\left| b_{n,k}^{\nu,H_{1},H_{2}} \right|^{2}}{\left[(-1)^{\chi_{\{n=0\}}} \left(j_{n}^{\nu,H_{1}} \right)^{2} - (-1)^{\chi_{\{k=0\}}} \left(j_{k}^{\nu,H_{2}} \right)^{2} \right]^{2}}.$$
clusion follows.

The conclusion follows.

4. Special cases

We now specify the general result of Theorem 3.2 to a number of cases where the identity in question takes a more explicit form. As a result, we obtain, up to the best of our knowledge new, formulas (F1)–(F17). The standing assumption, unless stated otherwise, is $\nu > -1$. We do not include any computations, all of them being elementary. The facts needed to perform the computations are (9), and in some cases (10) or (11); the symmetry $b_{n,k}^{\nu,H_1,H_2} = -b_{k,n}^{\nu,H_2,H_1}$ is also useful.

The case $H_1 = -\nu$ and $H_2 = \infty$. In this case Theorem 3.2 implies

(F1)
$$\sum_{k\geq 1} \frac{(j_k^{\nu})^2}{\left[\left(j_n^{\nu+1}\right)^2 - \left(j_k^{\nu}\right)^2\right]^2} = \frac{1}{4}, \qquad n\geq 1.$$

Moreover, for n = 0 Theorem 3.2 recovers Raighley's formula (1).

The case $H_1 = \infty$ and $H_2 = -\nu$. In this case Theorem 3.2 gives

(F2)
$$\sum_{k\geq 1} \frac{1}{\left[\left(j_n^{\nu} \right)^2 - \left(j_k^{\nu+1} \right)^2 \right]^2} = \frac{1}{4 \left(j_n^{\nu} \right)^2} - \frac{\nu+1}{\left(j_n^{\nu} \right)^4}, \qquad n\geq 1.$$

The case $H_1 = \nu$ and $H_2 = \infty$. Here for simplicity we apply Theorem 3.2 with $\nu > 0$ and then shift the index $\nu - 1 \mapsto \nu$ getting, for $\nu > -1$,

(F3)
$$\sum_{k\geq 1} \frac{\left(j_k^{\nu+1}\right)^2}{\left[\left(j_n^{\nu}\right)^2 - \left(j_k^{\nu+1}\right)^2\right]^2} = \frac{1}{4}, \qquad n\geq 1.$$

The case $H_1 = \infty$ and $H_2 = \nu$. We again use Theorem 3.2 with the restriction $\nu > 0$ and then shift the index $\nu - 1 \mapsto \nu$. This leads to the formula, valid for $\nu > -1$,

(F4)
$$\sum_{k\geq 1} \frac{1}{\left[\left(j_n^{\nu+1}\right)^2 - \left(j_k^{\nu}\right)^2\right]^2} = \frac{1}{4\left(j_n^{\nu+1}\right)^2}, \qquad n\geq 1$$

The case $H_1 = 0$ and $H_2 = \infty$. Applying Theorem 3.2 we get

(F5)
$$\sum_{k\geq 1} \frac{\left(j_k^{\nu}\right)^2}{\left[\left[(j_n^{\nu})'\right]^2 - \left(j_k^{\nu}\right)^2\right]^2} = \frac{1}{4} - \frac{\nu^2}{4\left[(j_n^{\nu})'\right]^2}, \qquad n\geq 1.$$

Moreover, for $\nu < 0$ and n = 0 Theorem 3.2 gives

(F6)
$$\sum_{k\geq 1} \frac{(j_k^{\nu})^2}{\left[\left[(j_0^{\nu})'\right]^2 + (j_k^{\nu})^2\right]^2} = \frac{1}{4} + \frac{\nu^2}{4\left[(j_0^{\nu})'\right]^2}, \qquad \nu < 0.$$

Note that the case when $\nu = 0$ is the same as for the choice $H_1 = -\nu$, $H_2 = \infty$ considered above.

The case $H_1 = \infty$ and $H_2 = 0$. Here Theorem 3.2 produces in case $\nu > 0$

(F7)
$$\sum_{k\geq 1} \frac{\left[(j_k^{\nu})'\right]^2}{\left[\left[(j_k^{\nu})'\right]^2 - \nu^2\right] \left[(j_n^{\nu})^2 - \left[(j_k^{\nu})'\right]^2\right]^2} = \frac{1}{4(j_n^{\nu})^2}, \quad n\geq 1, \quad \nu>0,$$

and in case $\nu < 0$

(F8)

$$\sum_{k\geq 1} \frac{\left[(j_k^{\nu})'\right]^2}{\left[\left[(j_k^{\nu})'\right]^2 - \nu^2\right] \left[\left(j_n^{\nu}\right)^2 - \left[(j_k^{\nu})'\right]^2\right]^2} \\
= \frac{1}{4(j_n^{\nu})^2} - \frac{\left[(j_0^{\nu})'\right]^2}{\left[\left[(j_0^{\nu})'\right]^2 + \nu^2\right] \left[\left(j_n^{\nu}\right)^2 + \left[(j_0^{\nu})'\right]^2\right]^2}, \quad n \geq 1, \quad \nu < 0.$$

Observe that the case $\nu = 0$ is the same as for the already considered choice $H_1 = \infty$, $H_2 = -\nu$.

The case $H_1 = -\nu$ and $H_2 = \nu$. We apply Theorem 3.2 assuming that $\nu > 0$. Then in the resulting identity we shift the index $\nu - 1 \mapsto \nu$ and get for $\nu > -1$

(F9)
$$\sum_{k\geq 1} \frac{1}{\left[\left(j_n^{\nu+2} \right)^2 - \left(j_k^{\nu} \right)^2 \right]^2} = \frac{1}{16(\nu+1)^2}, \qquad n\geq 1.$$

Moreover, for n = 0 we recover another formula due to Raighley (cf. [20, Chap. XV, Sec. 15.51])

$$\sum_{k\geq 1} \frac{1}{\left(j_k^{\nu}\right)^4} = \frac{1}{16(\nu+1)^2(\nu+2)}.$$

The case $H_1 = \nu$ and $H_2 = -\nu$. We again apply Theorem 3.2 assuming that $\nu > 0$ and shift the index $\nu - 1 \mapsto \nu$ in the resulting formula obtaining for $\nu > -1$

(F10)
$$\sum_{k\geq 1} \frac{1}{\left[\left(j_n^{\nu}\right)^2 - \left(j_k^{\nu+2}\right)^2\right]^2} = \frac{1}{16(\nu+1)^2} - \frac{\nu+2}{\left(j_n^{\nu}\right)^4}, \qquad n\geq 1.$$

The case $H_1 = -\nu$ and $H_2 = 0$. In this case from Theorem 3.2 we get the following formulas. When $\nu > 0$,

(F11)
$$\sum_{k\geq 1} \frac{\left[(j_k^{\nu})'\right]^2}{\left[\left[(j_k^{\nu})'\right]^2 - \nu^2\right] \left[\left(j_n^{\nu+1}\right)^2 - \left[(j_k^{\nu})'\right]^2\right]^2} = \frac{1}{4\nu^2}, \qquad n\geq 1, \quad \nu>0,$$

and for n = 0 we recover a formula due to Buchholz (cf. [19, Form. (74)]; see also the related comments in [19, p. 145])

$$\sum_{k\geq 1} \frac{1}{\left[\left[(j_k^{\nu})'\right]^2 - \nu^2\right] \left[(j_k^{\nu})'\right]^2} = \frac{1}{4\nu^2(\nu+1)}, \qquad \nu > 0$$

If $\nu < 0$, then

(F12)
$$\sum_{k\geq 1} \frac{\left[(j_k^{\nu})'\right]^2}{\left[\left[(j_k^{\nu})'\right]^2 - \nu^2\right] \left[(j_n^{\nu+1})^2 - \left[(j_k^{\nu})'\right]^2\right]^2} \\ = \frac{1}{4\nu^2} - \frac{\left[(j_0^{\nu})'\right]^2}{\left[\left[(j_0^{\nu})'\right]^2 + \nu^2\right] \left[(j_n^{\nu+1})^2 + \left[(j_0^{\nu})'\right]^2\right]^2}, \quad n \geq 1, \quad \nu < 0,$$

and for n = 0

(F13)
$$\sum_{k\geq 1} \frac{1}{\left[\left[(j_k^{\nu})'\right]^2 - \nu^2\right] \left[(j_k^{\nu})'\right]^2} = \frac{1}{4\nu^2(\nu+1)} - \frac{1}{\left[\left[(j_0^{\nu})'\right]^2 + \nu^2\right] \left[(j_0^{\nu})'\right]^2}, \quad \nu < 0.$$

The case $H_1 = 0$ and $H_2 = -\nu$. Applying Theorem 3.2 for $\nu \neq 0$ we get

(F14)
$$\sum_{k\geq 1} \frac{1}{\left[\left[(j_n^{\nu})'\right]^2 - (j_k^{\nu+1})^2\right]^2} = \frac{1}{4\nu^2} - \frac{1}{4\left[(j_n^{\nu})'\right]^2} - \frac{\nu+1}{\left[(j_n^{\nu})'\right]^4}, \qquad n\geq 1, \quad \nu\neq 0,$$

and the identity corresponding to n = 0 in case $\nu < 0$ is

(F15)
$$\sum_{k\geq 1} \frac{1}{\left[\left[(j_0^{\nu})'\right]^2 + (j_k^{\nu+1})^2\right]^2} = \frac{1}{4\nu^2} + \frac{1}{4\left[(j_0^{\nu})'\right]^2} - \frac{\nu+1}{\left[(j_0^{\nu})'\right]^4}, \qquad \nu < 0.$$

The case $H_1 = \nu$ and $H_2 = 0$. Here we apply Theorem 3.2 with $\nu > 0$ and then shift the index $\nu - 1 \mapsto \nu$ in the resulting identity getting a formula valid for $\nu > -1$

(F16)
$$\sum_{k\geq 1} \frac{\left[\left(j_k^{\nu+1}\right)'\right]^2}{\left[\left[\left(j_k^{\nu+1}\right)'\right]^2 - \left(\nu+1\right)^2\right] \left[\left(j_n^{\nu}\right)^2 - \left[\left(j_k^{\nu+1}\right)'\right]^2\right]^2} = \frac{1}{4(\nu+1)^2}, \qquad n\geq 1.$$

The case $H_1 = 0$ and $H_2 = \nu$. Applying again Theorem 3.2 with $\nu > 0$ and shifting the index $\nu - 1 \mapsto \nu$ we arrive at an identity valid for $\nu > -1$

(F17)
$$\sum_{k\geq 1} \frac{1}{\left[\left[(j_n^{\nu+1})'\right]^2 - (j_k^{\nu})^2\right]^2} = \frac{1}{4(\nu+1)^2} - \frac{1}{4\left[(j_n^{\nu+1})'\right]^2}, \qquad n\geq 1.$$

Completely explicit cases. Finally, we note that formulas (F1)–(F4) take explicit forms with the special choice $\nu = -1/2$ (these are the only such possibilities among all formulas (F1)–(F17) and all choices of the parameter). More precisely, taking $\nu = -1/2$, formulas (F1)–(F4) can be rewritten, respectively, as

$$\sum_{k\geq 0} \frac{(2k+1)^2}{\left[(2k+1)^2 - 4n^2\right]^2} = \frac{\pi^2}{16}, \qquad n \geq 1,$$

$$\sum_{k\geq 0} \frac{1}{\left[k^2 - (n-1/2)^2\right]^2} = \frac{\pi^2}{4(n-1/2)^2} + \frac{1}{2(n-1/2)^4}, \qquad n \geq 1,$$

$$\sum_{k\geq 0} \frac{k^2}{\left[k^2 - (n-1/2)^2\right]^2} = \frac{\pi^2}{4}, \qquad n \geq 1,$$

$$\sum_{k\geq 0} \frac{1}{\left[(2k+1)^2 - 4n^2\right]^2} = \frac{\pi^2}{64n^2}, \qquad n \geq 1.$$

The above four identities are known and can be found in standard compilations, actually as of more general formulas, see e.g. [17, Sec. 5.1.26, Form. 32], [17, Sec. 5.1.25, Form. 25], [17, Sec. 5.1.26, Form. 35], [17, Sec. 5.1.26, Form. 21], respectively.

5. Comments and further results

In this section we comment on the size of the "imaginary" zero $j_0^{\nu,H}$, since this is the least studied in the literature zero we are dealing with. Thus, from now on, we consider ν and H such that $H + \nu < 0$. The equation $I_{\nu,H}(x) = 0$ for $x \in (0, \infty)$ can be written equivalently as, see (8),

(14)
$$x\frac{I_{\nu+1}(x)}{I_{\nu}(x)} = -(H+\nu).$$

Here the left-hand side is continuous and strictly increasing on $(0, \infty)$ (this is seen from its Mittag-Leffler expansion) and has limits 0 and ∞ as $x \to 0^+$ and $x \to \infty$, respectively. Therefore, given an arbitrary $x_0 > 0$, for a fixed ν one can always find H such that $j_0^{\nu,H} = x_0$. In other words, in general the size of $j_0^{\nu,H}$ can be arbitrary.

However, the situation is much different in the special case H = 0 considered in Section 4, see Formulas (F6), (F8), (F12) and (F15). We will show the following.

Proposition 5.1. Let $-1 < \nu < 0$. Then

$$(j_0^{\nu})' < j_1^{\nu} < j_1^{\nu+1}.$$

Proof. The second inequality is well known, see [20, Chap. XV, Sec. 15.22], so we prove only the first one. Since $(j_0^{\nu})'$ is the strictly positive zero of $I_{\nu,0}$, it is, see (14), the only strictly positive root of the equation

$$\frac{I_{\nu+1}(x)}{I_{\nu}(x)} = -\frac{\nu}{x}.$$

We now estimate the left-hand side here from below by a function F(x) so that the (first) positive root of the equation $F(x) = -\nu/x$ is bigger than $(j_0^{\nu})'$.

Define

$$F(x) := \frac{2(\nu+2)x}{4(\nu+1)(\nu+2) + x^2}$$

From [15, Theorem 3(a)], see also [15, p. 11, formula for $L_{\nu,0,1}$], it follows that

$$F(x) < \frac{I_{\nu+1}(x)}{I_{\nu}(x)}, \qquad x > 0$$

Solving the equation $F(x) = -\nu/x$ we see that its only positive root is

$$x_0^{\nu} := 2\sqrt{\frac{(-\nu)(\nu^2 + 3\nu + 2)}{3\nu + 4}}$$

Thus we get $(j_0^{\nu})' < x_0^{\nu}$.

On the other hand, from e.g. Raighley's formula (1) we know that $j_1^{\nu} > 2\sqrt{\nu+1}$. Therefore, to finish the proof it suffices to verify the estimate

$$x_0^{\nu} < 2\sqrt{\nu+1}, \qquad \nu \in (-1,0),$$

which is elementary to check.

Remark 5.2. The method from the proof of Proposition 5.1 together with other rational bounds for $I_{\nu+1}/I_{\nu}$ in [15] allows one to get more precise upper and also lower bounds for $(j_0^{\nu})'$. Moreover, the same method can be used to estimate $j_0^{\nu,H}$ for other H and ν such that $H + \nu < 0$.
