# Retract rational varieties are uniformly retract rational

#### Abstract

We prove that non-singular retract rational algebraic varieties are uniformly retract rational, over any infinite field. This implies that rational projective non-singular complex varieties are Gromov elliptic.

## 1 Introduction

In the paper,  $\mathbb{K}$  will denote an infinite field. An affine variety X over  $\mathbb{K}$  is a Zariski closed subset of  $\mathbb{K}^n$  for some n. By  $\mathcal{P}(X)$  we denote the coordinate ring  $\mathbb{K}[x_1,\ldots,x_n]/\mathcal{I}(X)$  of X. Given a point  $x_0 \in X$ , by  $\mathcal{P}(X)_{x_0}$  we denote the localisation of  $\mathcal{P}(X)$  at the maximal ideal at the point  $x_0$ , which can be interpreted as the ring of germs of regular functions at  $x_0$ . We say that the point  $x_0$  is non-singular if the local ring at  $x_0$  is regular. If X is irreducible, we denote the field of rational functions on X by  $\mathbb{K}(X)$ , it is canonically isomorphic to the field of fractions of  $\mathcal{P}(X)$ . We say that a rational function is regular at a point  $x_0 \in X$  if it belongs to  $\mathcal{P}(X)_{x_0}$  as an element of the field of fractions of the local ring.

Likewise, by an algebraic variety over  $\mathbb{K}$  we mean a Zariski locally closed subset of the projective space  $\mathbb{KP}^n$  over  $\mathbb{K}$  for some n.

We can now begin with some historical background on the study of certain classes of algebraic varieties, started by Gromov. In his foundational paper [7], he introduced the following notion, which is now called *algebraic Gromov ellipticity*:

**Definition 1.1.** Let X be a complex non-singular algebraic variety. X is then said to be *Gromov elliptic* if there exists an algebraic vector bundle E over X and a regular mapping  $s: E \to X$  such that

- 1.  $s(0_x) = x$  for  $x \in X$ , where  $x \mapsto 0_x$  is the zero section,
- 2. the derivative of  $s|_{E_x}$  is surjective at  $0_x$  as a mapping into  $T_x X$ , where  $E_x$  is the fiber of the point x.

Gromov was able to provide some examples of complex algebraic varieties which are Gromov elliptic. In particular he noted that in the projective case, Gromov ellipticity follows from *uniform rationality*, defined as follows: **Definition 1.2** (Gromov). An algebraic variety X over an infinite field  $\mathbb{K}$  of dimension n is called *uniformly rational* if for every point  $x \in X$  there exists a Zariski open neighbourhood V of x which is biregularly isomorphic to a Zariski open subset of  $\mathbb{K}^n$ .

In this context it is then natural to ask the following question:

**Question 1.3** ([7, p. 883 and 885]). Are all non-singular rational algebraic varieties uniformly rational? In particular are all non-singular rational complex projective varieties Gromov elliptic?

Some consequences of a positive answer to the first part of the question were analysed in [6]. The question has been restated in different versions in [1, 8, 10].

Similar problems have also been considered in the real case. In the paper [5], Bochnak and Kucharz introduced the notion of *malleable* varieties, which is the real counterpart to the class of Gromov elliptic varieties:

**Definition 1.4.** Let X be a non-singular real algebraic variety. X is then said to be malleable if there exists an algebraic vector bundle E over X (see [4, Definition 12.1.6] for the definition of an algebraic vector bundle in the real case), and a regular mapping  $s: E \to X$  such that

- 1.  $s(0_x) = x$  for  $x \in X$ , where  $x \mapsto 0_x$  is the zero section,
- 2. the derivative of  $s|_{E_x}$  is surjective at  $0_x$  as a mapping into  $T_x X$ , where  $E_x$  is the fiber of the point x.

Building on the work of Bochnak and Kucharz, the author introduced the following definition in [2]:

**Definition 1.5.** An algebraic variety over an infinite field  $\mathbb{K}$  is called *uniformly* retract rational if for every point  $x \in X$  there exists a Zariski open neighbourhood V of x, a natural number m, a Zariski open set  $U \subset \mathbb{K}^m$  and two regular mappings

 $V \to U \to V$ 

such that their composition is the identity on V.

This definition begins to play an important role in the study of homotopy and approximation properties of regular mappings between real algebraic varieties as seen in the papers [2, 3, 9].

With the existing machinery it is easy to prove the following

**Observation 1.6.** Complex (resp. real) projective uniformly retract rational varieties are Gromov elliptic (resp. malleable).

We postpone the proof of Observation 1.6 until the end of this section.

Naturally, one can ask an analogue of Question 1.3 in the retract rational case:

**Definition and Question 1.7.** An algebraic variety X over an infinite field  $\mathbb{K}$  is called retract rational if there exists a Zariski open and dense subset  $V \subset X$ , a natural number m, a Zariski open set  $U \subset \mathbb{K}^n$  and two regular mappings

$$V \to U \to V$$

such that their composition is the identity on V.

Are all non-singular retract rational algebraic varieties uniformly retract rational?

The goal of this paper is to answer the question affirmatively:

**Theorem 1.8.** Let X be a non-singular retract rational algebraic variety over an infinite field  $\mathbb{K}$ . Then it is uniformly retract rational.

As a corollary we obtain a partial answer to Question 1.3:

**Corollary 1.9.** Non-singular rational complex projective varieties are Gromov elliptic.

*Proof.* Clearly, rational varieties are retract rational. Then according to Theorem 1.8 they are uniformly retract rational, and hence thanks to Observation 1.6 they are Gromov elliptic.

In the end, the known implications between the different properties of an irreducible non-singular complex (resp. real) projective variety X now look as follows:



See also the diagram in [2, p. 5] to get a more complete picture in the real case.

*Proof of Observation 1.6.* In the real case this has already been established in [2, Theorem 2.11].

Let then X be a complex projective uniformly retract rational variety. Fix a Zariski open set  $V \subset X$  such that there exists a Zariski open set  $U \subset \mathbb{C}^m$ and two regular mappings  $i: V \to U, r: U \to X$  such that  $r \circ i = \text{id.}$  Since X is projective we can assume that  $\mathbb{C}^m \setminus U$  is of codimension at least two. Then according to [7, Observation 3.5.C], U is Gromov elliptic. Let E be a bundle over U with a dominating spray  $s: E \to U$ . We define a local spray over V on the pullback bundle  $i^*E$  by

$$s'(v,x) := r \circ s(v).$$

From [7, Localisation Lemma 3.5.B] it follows that X is Gromov elliptic.  $\Box$ 

# 2 Preliminaries

From now on let  $\mathbbm{K}$  be a fixed infinite field. We begin with the following observation:

**Observation 2.1.** Let  $X \subset \mathbb{K}^n$ ,  $Y \subset \mathbb{K}^m$  be two non-singular affine varieties over  $\mathbb{K}$ . Let  $\sigma : X \to Y$  be a regular mapping such that its derivative at a point  $x_0 \in X$  is an isomorphism (considered as a mapping between the Zariski tangent spaces of X at  $x_0$  and Y at  $\sigma(x_0)$ ). Then, the induced mapping

$$\mathcal{P}(Y)_{\sigma(x_0)} \to \mathcal{P}(X)_{x_0}$$

is injective. Moreover, if  $P, Q \in \mathcal{P}(Y)_{\sigma(x_0)}$  are such that  $Q \circ \sigma$  divides  $P \circ \sigma$  in the ring  $\mathcal{P}(X)_{x_0}$ , then Q divides P in  $\mathcal{P}(Y)_{\sigma(x_0)}$ .

*Proof.* From the assumption it follows that  $\sigma$  induces an isomorphism between the formal completions of  $\mathcal{P}(Y)_{\sigma(x_0)}$  and  $\mathcal{P}(X)_{x_0}$ . Injectivity follows from the fact that the natural map from  $\mathcal{P}(Y)_{\sigma(x_0)}$  to its completion is injective. The second part follows from a similar argument; if  $Q \circ \sigma$  divides  $P \circ \sigma$  in  $\mathcal{P}(X)_{x_0}$ , then Q divides P in the completion of  $\mathcal{P}(Y)_{\sigma(y_0)}$ , and as the completion is flat over  $\mathcal{P}(Y)_{\sigma(x_0)}$  the quotient must belong to  $\mathcal{P}(Y)_{\sigma(x_0)}$ .

The following proposition will play an important role in our proof of Theorem 1.8:

**Proposition 2.2.** Let  $X \subset \mathbb{K}^n$  be a non-singular irreducible affine variety of dimension m, and let  $x_0 \in X$ . Let  $I \subset \mathcal{P}(X)$  be a non-zero ideal such that  $I \subset \mathfrak{m}_{x_0}$ . Then, there exists a polynomial mapping  $\sigma : X \times \mathbb{K}^{n-m} \to \mathbb{K}^n$ , such that

- 1.  $\sigma(x,0) = x$  for  $x \in X$ ,
- 2. the derivative of  $\sigma$  at  $(x_0, 0)$  is a isomorphism,
- 3. the induced homomorphism

$$\mathcal{P}(\mathbb{K}^n)_{x_0} \to (\mathcal{P}(X)[t_1,\ldots,t_{n-m}]/I(t_1,\ldots,t_{n-m}))_{\mathfrak{m}_{(x_0,0)}}$$

is surjective.

To prove that, we first develop two preliminary lemmas. In the following, a property is said to be satisfied for a *generic linear change of coordinates*, if it is satsfied a non-empty Zariski open subset of  $GL_n(\mathbb{K})$ .

**Lemma 2.3.** Let  $I \subset \mathcal{P}(\mathbb{K}^n)$  be an ideal of height at least n - m + 1 contained in  $(x_1, \ldots, x_n)$ . Then, after a generic linear change of coordinates we have

$$\sqrt{(x_1,\ldots,x_m)+I}=(x_1,\ldots,x_n)$$

*Proof.* Let  $\overline{\mathbb{K}}$  be the algebraic closure of  $\mathbb{K}$ . Since the extension  $\mathbb{K}[x_1, \ldots, x_n] \subset \overline{\mathbb{K}[x_1, \ldots, x_n]}$  is integral, for an ideal J of  $\mathbb{K}[x_1, \ldots, x_n]$  we have

$$\sqrt{J\overline{\mathbb{K}}}[x_1,\ldots,x_n] \cap \mathbb{K}[x_1,\ldots,x_n] = \sqrt{J}.$$

Hence, a linear change of coordinates satisfies the property over  $\overline{\mathbb{K}}$  if and only if it satisfies it over  $\mathbb{K}$ . Since  $\operatorname{GL}_n(\mathbb{K})$  is Zariski dense in  $\operatorname{GL}_n(\overline{\mathbb{K}})$  it follows that it suffices to consider the case when  $\mathbb{K}$  is algebraically closed.

Now prime ideals of  $\mathbb{K}[x_1, \ldots, x_n]$  correspond to Zariski closed sets of  $\mathbb{K}^n$ . It suffices to show that after a generic linear change of coordinates, the only point of  $\mathcal{Z}(I)$  with  $x_1 = \cdots = x_m = 0$  is the origin. This is done by computing the dimensions.

**Lemma 2.4.** Let  $X \subset \mathbb{K}^n$  be an affine non-singular irreducible variety of dimension  $m, x_0$  a point of  $X, I \subset \mathcal{P}(X)$  be an ideal satisfying  $I \subset \mathfrak{m}_{x_0}$  and let  $\sigma: X \to \mathbb{K}^m$  be a polynomial mapping such that  $\sigma(x_0) = 0$  and:

- 1. the derivative of  $\sigma$  is an isomorphism at 0,
- 2. the induced extension  $\mathcal{P}(\mathbb{K}^m) \subset \mathcal{P}(X)$  is finite,
- 3.  $\sqrt{(x_1,\ldots,x_m)+I} = \mathfrak{m}_{x_0}$ , where  $x_1,\ldots,x_m$  denotes the images of the variables of  $\mathcal{P}(\mathbb{K}^m)$  in  $\mathcal{P}(X)$ .

Then the induced homomorphism

$$\mathcal{P}(\mathbb{K}^m)_0 \to (\mathcal{P}(X)/I)_{\mathfrak{m}_{x_0}}$$

is surjective.

*Proof.* First note that from the first property it follows that  $\mathfrak{m}_{x_0}/\mathfrak{m}_{x_0}^2$  is generated by  $x_1, \ldots, x_m$  as a vector space over  $\mathbb{K}$ . From Nakayama's lemma it follows that there exists  $r \in \mathcal{P}(X) \setminus \mathfrak{m}_{x_0}$  such that  $r\mathfrak{m}_{x_0} \subset (x_1, \ldots, x_m) \subset (x_1, \ldots, x_m) + I$ . However,  $(x_1, \ldots, x_m) + I$  is  $\mathfrak{m}_{x_0}$ -primary, so  $\mathfrak{m}_{x_0} = (x_1, \ldots, x_m) + I$ . Consider now

$$M := \mathcal{P}(X) / (I + \mathcal{P}(\mathbb{K}^m))$$

as an  $\mathcal{P}(\mathbb{K}^m)$ -module. It follows that  $M \subset M(x_1, \ldots, x_m)$ , so from Nayakama's lemma there exists  $s \in \mathcal{P}(\mathbb{K}^m) \setminus (x_1, \ldots, x_m)$  such that sM = 0. If now  $p, q \in \mathcal{P}(X)/I$  are such that  $q \notin \mathfrak{m}_{x_0}$ , then  $\frac{p}{q} = \frac{ps}{qs}$  is an image of an element from  $\mathcal{P}(\mathbb{K}^m)_0$ .

Proof of Proposition 2.2. Without loss of generality we can assume that  $x_0 = 0 \in \mathbb{K}^n$ . Applying Lemma 2.3 and Noether normalisation lemma, after a generic linear change of coordinates we can assume that the following conditions hold:

- 1.  $x_1, \ldots, x_m$  make a system of parameters of X at  $x_0$ ,
- 2. the induced extension  $\mathbb{K}[x_1, \ldots, x_m] \subset \mathcal{P}(X)$  is finite,

3. 
$$\sqrt{(x_1, \ldots, x_m)} + I = (x_1, \ldots, x_n)$$
 in  $\mathcal{P}(X)$ .

Now define  $\sigma$  in the following way

$$\sigma(x_1, \ldots, x_n, t_1, \ldots, t_{n-m}) := (x_1, \ldots, x_m, x_{m+1} + t_1, \ldots, x_n + t_{n-m}).$$

We claim that the following hold:

- 1. the derivative of  $\sigma$  is an isomorphism at 0,
- 2. the induced extension  $\mathcal{P}(\mathbb{K}^n) \subset \mathcal{P}(X \times \mathbb{K}^{n-m})$  is finite,

3. 
$$\sqrt{(x_1, \dots, x_m, x_{m+1} + t_1, \dots, x_n + t_{n-m})} + I(t_1, \dots, t_{n-m}) = \mathfrak{m}_{(x_0, 0)}$$

The first point follows from the fact that the classes of  $x_1, \ldots, x_m, x_{m+1} + t_1, \ldots, x_n + t_{n-m}$  in  $\mathfrak{m}_{(x_0,0)}/\mathfrak{m}_{(x_0,0)}^2$  are linearly independent over  $\mathbb{K}$ .

To prove the second one, note that  $\mathcal{P}(X \times \mathbb{K}^{n-m})$  as an algebra over  $\mathcal{P}(\mathbb{K}^n)$  is generated by the elements  $x_{m+1}, \ldots, x_n$ , and these by assumption are integral over the algebra generated by  $x_1, \ldots, x_m$ .

For the last point, note that since the radical of a product of ideals is equal to the intersection of their radicals, it suffices to prove the following

$$\begin{split} \mathfrak{m}_{(x_0,0)} &\subset \sqrt{(x_1, \dots, x_m, x_{m+1} + t_1, \dots, x_n + t_{n-m}) + I}, \\ \mathfrak{m}_{(x_0,0)} &\subset \sqrt{(x_1, \dots, x_m, x_{m+1} + t_1, \dots, x_n + t_{n-m}, t_1, \dots, t_{n-m})}. \end{split}$$

By assumption  $x_{m+1}, \ldots, x_n \in \sqrt{(x_1, \ldots, x_m) + I}$ , and from that the first inclusion follows. The second one is trivial.

It remains to invoke Lemma 2.4.

# **3** Proof of the main theorem

Lastly, before proving Theorem 1.8, we need the following crucial lemma:

**Lemma 3.1.** Let  $P, Q \in \mathcal{P}(\mathbb{K}^n)$  two polynomials. Let  $X \subset \mathbb{K}^k$  be an irreducible non-singular affine variety, and let  $\pi : X \to \mathbb{K}^n$  be a regular mapping, such  $Q \circ \pi$  is not identically equal to zero and  $\frac{P \circ \pi}{Q \circ \pi} \in \mathcal{P}(X)_{x_0}$  for some point  $x_0 \in X$ . Let  $\varphi : (X, x_0) \to \mathbb{K}^n$  be a germ of a regular mapping, such that for  $1 \leq i \leq n$ its *i*-th coordinated  $\varphi_i$  satisfies

$$\varphi_i - \pi_i \in (Q \circ \pi)\mathfrak{m}_{x_0}$$
 in the ring  $\mathcal{P}(X)_{x_0}$ .

Then,  $Q \circ \varphi$  is not identically equal to zero and the rational mapping  $\frac{P \circ \varphi}{Q \circ \varphi}$  is regular at  $x_0$ .

*Proof.* Note that for  $v, w \in \mathbb{K}^n$ , the polynomials P and Q can be written as

$$P(v+w) = P(v) + \sum_{i} w_i P_i(v, w),$$
$$Q(v+w) = Q(v) + \sum_{i} w_i Q_i(v, w),$$

for some  $P_i, Q_i \in \mathcal{P}(\mathbb{K}^n)$ . Then

$$Q \circ \varphi(x) = Q \circ \pi(x) \left( 1 + \sum_{i} \frac{\varphi_i(x) - \pi_i(x)}{Q \circ \pi(x)} Q_i(\pi(x), \varphi(x) - \pi(x)) \right)$$

is a product of two non-zero elements of  $\mathcal{P}(X)_{x_0}$  and

$$\frac{P}{Q} \circ \varphi(x) = \frac{\frac{P}{Q} \circ \pi(x) + \sum_{i} \frac{\varphi_{i}(x) - \pi_{i}(x)}{Q \circ \pi(x)} P_{i}(\pi(x), \varphi(x) - \pi(x))}{1 + \sum_{i} \frac{\varphi_{i}(x) - \pi_{i}(x)}{Q \circ \pi(x)} Q_{i}(\pi(x), \varphi(x) - \pi(x))} \in \mathcal{P}(X)_{x_{0}}.$$

From the next proposition Theorem 1.8 will follow easily. The proposition may be of some interest on its own.

**Proposition 3.2.** Let  $X \subset \mathbb{K}^n, Y \subset \mathbb{K}^k$  be two affine non-singular irreducible varieties over  $\mathbb{K}$ ,  $x_0$  be a point of X and  $F : \mathbb{K}^n \dashrightarrow Y$  be a rational mapping, such that all its coordinates belong to  $\mathcal{P}(\mathbb{K}^n)_X$  and the restriction  $F|_X : X \dashrightarrow Y$  is regular at  $x_0$ . Then, there exists a regular germ  $G : (\mathbb{K}^n, x_0) \to Y$  such that  $G|_X = F|_X$  as rational mappings.

Proof. Set  $m := \dim(X)$ . Write each coordinate  $F_i$  of F as  $\frac{P_i}{Q_i}$  with  $P_i, Q_i \in \mathcal{P}(\mathbb{K}^n)$  and  $Q_i \notin \mathcal{I}(X)$ . Set  $q := Q_1 \dots Q_k |_X \in \mathcal{P}(X)$ . Without loss of generality  $q(x_0) = 0$ , for otherwise we can take G := F. Applying Proposition 2.2 to the ideal I = (q), we find a polynomial mapping  $\sigma : X \times \mathbb{K}^{n-m} \to \mathbb{K}^n$  such that

- 1.  $\sigma(x,0) = x$  for  $x \in X$ ,
- 2. the derivative of  $\sigma$  at  $(x_0, 0)$  is a isomorphism,
- 3. the induced homomorphism

$$\mathcal{P}(\mathbb{K}^n)_{x_0} \to (\mathcal{P}(X \times \mathbb{K}^{n-m})/(q)(t_1, \dots, t_{n-m}))_{\mathfrak{m}_{(x_0, 0)}}$$

is surjective.

For  $1 \leq i \leq n$  let  $\psi_i \in \mathcal{P}(\mathbb{K}^n)_{x_0}$  be a regular germ such that

$$\psi_i \circ \sigma - x_i \in (q)(t_{k+1}, \dots, t_n).$$

These together give a regular germ  $\psi : (\mathbb{K}^n, x_0) \to \mathbb{K}^n$ . Set  $G := F \circ \psi$ .

By Lemma 3.1 applied to the mappings

$$\pi : X \times \mathbb{K}^{n-m} \to \mathbb{K}^n$$
$$\pi(x,t) := x \in X \subset \mathbb{K}^n,$$
$$\varphi : (X \times \mathbb{K}^{n-m}, (x_0, 0)) \to \mathbb{K}^n$$
$$\varphi(x,t) := \psi \circ \sigma(x,t)$$

we get that for all  $1 \leq i \leq k$ ,  $F_i \circ \psi \circ \sigma \in \mathcal{P}(X \times \mathbb{K}^{n-m})_{(x_0,0)}$ . As the derivative of  $\sigma$  is an isomorphism at  $(x_0,0)$ , from Observation 2.1 we get that  $G_i = F_i \circ \psi \in \mathcal{P}(\mathbb{K}^n)_{x_0}$ .

Furthermore, for  $x \in X$  sufficiently close to  $x_0$  by assumption  $\psi(x) = \psi \circ \sigma(x,0) = \pi(x,0) = x$ , so  $G|_X = F|_X$ .

Proof of Theorem 1.8. Let X be a non-singular retract rational variety, and let  $x_0$  be a point of X. Retract rational varieties are irreducible, and the property of being uniformly retract rational is local, so passing to a neighbourhood we can assume that X is embedded in  $\mathbb{K}^n$  as an affine irreducible variety. Let  $i: X \dashrightarrow \mathbb{K}^m$  and  $r: \mathbb{K}^m \dashrightarrow X$  be two rational mappings, such that their composition  $r \circ i$  is defined and equal to the identity on X. Consider any rational extension  $i_0: \mathbb{K}^n \dashrightarrow \mathbb{K}^m$  of i. Then, the composition  $F := r \circ i_0$  is a well defined rational mapping from  $\mathbb{K}^n$  to X, such that the restriction  $F|_X$  is well defined (i.e. all coordinates of F belong to  $\mathcal{P}(\mathbb{K}^n)_X$ ) and it is equal to the identity  $X \to X$ . It now suffices to apply Proposition 3.2 to find a local regular retraction  $G: (\mathbb{K}^n, x_0) \to X$  from a Zariski neighbourhood of  $x_0$  in  $\mathbb{K}^n$  onto a
