

# SUBCONVEX BOUND FOR RANKIN-SELBERG $L$ -FUNCTIONS IN PRIME POWER LEVEL

ABSTRACT. Let  $f$  be a  $p$ -primitive cusp form of level  $p^{4r}$ , where local representation of  $f$  be supercuspidal at  $p$ ,  $p$  being an odd prime,  $r \geq 1$  and  $g$  be a Hecke-Maass or holomorphic primitive cusp form for  $\mathrm{SL}(2, \mathbb{Z})$ . A subconvex bound for the central values of the Rankin-Selberg  $L$ -functions  $L(s, f \otimes g)$  is given by

$$L\left(\frac{1}{2}, f \otimes g\right) \ll_{g, \epsilon} p^{\frac{23r}{12} + \epsilon}.$$

## 1. INTRODUCTION

In this paper, we are interested in the program – initiated by various mathematicians to solve the subconvexity problem for Rankin–Selberg  $L$ -functions (see [8], [17], [18], [19], [20], [26]) in the level aspect. We continue that program here, in this paper also, using the delta method which was introduced and developed by Munshi in his papers (see [21], [22], [23]).

Let  $f$  be a  $p$ -primitive cusp form which is supercuspidal at  $p$  with level  $p^{4r}$ ,  $p$  being an odd prime,  $r \geq 1$  and  $g$  be a Hecke-Maass or holomorphic primitive cusp form for  $\mathrm{SL}(2, \mathbb{Z})$ . Then the  $L$ -function associated with  $f \otimes g$  is given by

$$L(s, f \otimes g) = \zeta_p(2s) \sum_{n=1}^{\infty} \frac{\lambda_f(n) \lambda_g(n)}{n^s}, \quad \zeta_p(s) = \prod_{q \neq p} \left(1 - \frac{1}{q^s}\right)^{-1},$$

for  $\mathrm{Re}(s) > 1$ , which can be analytically extended to the whole complex plane  $\mathbb{C}$  and satisfies a functional equation relating  $s$  and  $1 - s$  and for the last product in the previous line,  $q$  runs over all primes except  $p$ . In this context the convexity bound is

$$L\left(\frac{1}{2}, f \otimes g\right) \ll_{g, \epsilon} p^{2r + \epsilon},$$

for any  $\epsilon > 0$  which can be obtained by using the approximate functional equation and the Phragmén-Lindelöf principle. Then the subconvexity bound we are seeking is a bound of the form

$$L\left(\frac{1}{2}, f \otimes g\right) \ll_{g, \epsilon} p^{2r - \delta + \epsilon},$$

with some absolute  $\delta > 0$ , the implied constant depending on  $g$  and the parameter at infinity of  $f$  (i.e., the weight or the Laplacian eigenvalue but not on the level of  $f$ ). This problem was first addressed by Kowalski-Michel-Vanderkam (see [17]) under the following assumptions:

- $f$  is a holomorphic cusp form;
- the conductor  $q^*$  of  $\chi_f \chi_g$  is at most  $q^{\frac{1}{2} - \eta}$  for some  $\eta > 0$ , the corresponding exponent  $\delta$  then depending on  $\eta$  where  $\chi_f$  is the nebentypus of  $f$  and  $\chi_g$  is the nebentypus of  $g$ .

Then the second condition was essentially removed in [19] under the assumptions:

- $g$  is a holomorphic cusp form;
- $\chi_f \chi_g$  is non-trivial.

Later Harcos-Michel (see [8]) considered the previous problem after removing the first assumption that  $g$  is a holomorphic cusp form though  $\chi_f \chi_g$  being non-trivial. Michel-Venkatesh have also considered this problem in their breakthrough work [20]. If the level of the form  $f$  is a prime then this problem has been considered in [24], [25]. Raju (see [24]) did the problem by taking  $g$  to be cuspidal form though his method does not work when  $g$  is an Eisenstein series. For some time it was not clear whether the  $\delta$ -method approach will work in the case of  $g$  non-cuspidal. Recently Aggarwal, Kumar, Kwan, Leung, Li and Young (see [1]) solved this subconvexity problem in level aspect using the  $\delta$ -method and here they can take  $g$  to be an Eisenstein series. The author has also considered this problem as a  $\mathrm{GL}(2) \times \mathrm{GL}(2) \times \mathrm{GL}(1)$  problem in [7]. Also in this context one can see the work of Holowinsky-Munshi (see [9]), Holowinsky-Templier (see [10]), Hou-Zhang (see [11]) for the hybrid level aspect case.

In this paper we will consider the case when the level of the form  $f$  is a prime power, getting the following result:

**Theorem 1.** *Let  $f$  be a  $p$ -primitive cusp form of level  $p^{4r}$  with the local representation of  $f$  be supercuspidal at  $p$ ,  $p$  being a sufficiently large odd prime,  $r \geq 1$  and  $g$  be a Hecke-Maass or holomorphic primitive cusp form for  $\mathrm{SL}(2, \mathbb{Z})$ . Then we have*

$$L\left(\frac{1}{2}, f \otimes g\right) \ll_{g, \epsilon} p^{\frac{23r}{12} + \epsilon}.$$

**Remark 1.** *Here we are considering  $f, g$  to be holomorphic cusp forms for simplicity as we can proceed similarly for Hecke-Maass cusp forms. Also here we will consider the case for  $r = 1$  as for  $r > 1$ , we can proceed similarly. For  $r \geq 2$  one can use [4, Theorem 1] and [4, Remark 2] to get the square root cancellation for the character sum (40) in the off-diagonal case. If the form  $f$  has level  $p^u$  for some  $u \in \mathbb{N}$ , then for the case  $u \geq 4$  and  $4 \nmid u$  the author hopes that one can do address the problem for general case following the same method and doing conductor lowering by taking the conductor of size  $p^{\lfloor \frac{u}{4} \rfloor}$ . The author also plans to address the general problem in a separate article in a different approach.*

**Remark 2.** *Our result gives an improvement of the results done in [17, Theorem 1.1]. The main input of our work is to use the Jutila's circle method (see 3) in a certain way so that after an application of the Poisson summation formula, only zero frequencies survive. By repeated application of the Cauchy-Schwarz's inequality and change of variables, we separate the oscillations and get new character sums.*

**Notation.** In this article, by  $A \ll B$  we mean  $|A| \leq C|B|$  for some absolute constant  $C > 0$ , depending only on  $g, \epsilon$  and notation ' $X \asymp Y$ ' will mean that  $Yp^{-\epsilon} \leq X \leq Yp^\epsilon$ .

**Application 1.** *As an application of our theorem (1), we improve the bound obtained in [17] for the problem of distinguishing modular forms based on their first Fourier coefficients.*

**Corollary 1.** *From the proof of the corollary 1.3 of [17], we have, for  $f$  as given in our theorem (1). Then there exists a constant  $C = C(f, \epsilon)$  such that for any primitive cuspidal newform  $g$  for  $\mathrm{SL}(2, \mathbb{Z})$  and for any primitive Dirichlet character  $\chi(n)$  having modulus  $N$ , odd, there exists  $n \leq C N^{1 - \frac{1}{24} + \epsilon}$  with  $(n, N) = 1$ , such that*

$$\lambda_f(n) \neq \lambda_g(n).$$

*Proof.* The proof is identical to the proof of Corollary 1.3 [17]. Use Theorem (1) in place of [[17], Theorem 1.1] in the proof.  $\square$

## 2. PRELIMINARIES

**2.1. Preliminaries on holomorphic cusp forms.** Let  $f$  be a  $p$ -primitive cusp form where the level of  $f$  be  $p^4$  with the local representation of  $f$  being supercuspidal in  $p$ ,  $p$  being an odd prime, and  $g$  be a Hecke-Maass or holomorphic primitive cusp form for  $\mathrm{SL}(2, \mathbb{Z})$

**2.1.1. Voronoi summation formula.** We will use the following Voronoi summation formula. In the case of a full level (see [3, Proposition 2]) we have

**Lemma 2.1.1.** *Let  $a$  and  $c$  be coprime positive integers, and let  $F : (0, \infty) \mapsto \mathbb{C}$  be a smooth function of compact support. Then*

$$(1) \quad c \sum_{n=1}^{\infty} \lambda_g(n) e\left(\frac{an}{c}\right) F(n) = \sum_{n=1}^{\infty} \lambda_g(n) \sum_{\pm} e\left(\mp \frac{\bar{a}n}{c}\right) \int_0^{\infty} F(x) J_g^{\pm} \left( \frac{4\pi \sqrt{\sqrt{nx}}}{c} \right) dx,$$

where

$$J_g^+(x) := 2\pi i^k J_{k-1}(x), \quad J_g^-(x) := 0,$$

if  $g$  is a holomorphic cusp form of level 1 and weight  $k$ ;

$$J_g^+(x) := \frac{-\pi}{\cosh(\pi r)} (Y_{2ir}(x) + Y_{-2ir}(x)), \quad J_g^-(x) := \varepsilon_g 4 \cosh(\pi r) K_{2ir}(x),$$

if  $g$  is a Maass cusp form of level 1, weight 0, Laplacian eigenvalue  $\frac{1}{4} + r^2$  and sign  $\varepsilon_g \in \{\pm 1\}$ . For  $g = E_r$  ( $r \in \mathbb{R}$ ) the same formula holds with  $J_g^{\pm}$  as in the Maass case (with  $\varepsilon_g = 1$ ), except that on the right-hand side the following polar term has to be added:

$$\sum_{\pm} \zeta(1 \pm 2ir) \int_0^{\infty} \left(\frac{x}{c^2}\right)^{\pm ir} F(x) dx \quad \text{for } r \neq 0,$$

$$\int_0^{\infty} \left(\log\left(\frac{x}{c^2}\right) + 2\gamma\right) F(x) dx \quad \text{for } r = 0.$$

**2.1.2. Bounds for the Bessel functions.** For  $x \gg 1$ , we have

$$J_{k-1}(2\pi x) = W_k(x) \frac{e(x)}{\sqrt{x}} + \overline{W}_k(x) \frac{e(-x)}{\sqrt{x}},$$

for some function  $W_k$  satisfying  $x^j (\partial^j W_k)(x) \ll_{j,k} 1$ .

2.1.3. *The Ramanujan bound on average.* Here we note the following Ramanujan bound on average (see [12]):

$$(2) \quad \sum_{n \ll N} |\lambda_f(n)|^2 \ll p^\epsilon N^{1+\epsilon}.$$

2.2. **Circle Method.** Here in this paper we shall use Jutila's circle method (see [14], [15]). For any set  $S \subset \mathbb{R}$ , let  $I_S$  denote the associated characteristic function, i.e.  $I_S(x) = 1$  for  $x \in S$  and 0 otherwise. For any collection of positive integers  $\Phi \subset [Q, 2Q]$  (which we call the set of moduli), where  $Q \geq 1$  and a positive real number  $\delta$  in the range  $Q^{-2} \ll \delta \ll Q^{-1}$ , we define the function

$$\tilde{I}_{\Phi, \delta}(x) := \frac{1}{2\delta L} \sum_{q \in \Phi} \sum_{d \bmod q}^* I_{[\frac{d}{q} - \delta, \frac{d}{q} + \delta]}(x),$$

where  $I_{[\frac{d}{q} - \delta, \frac{d}{q} + \delta]}$  is the indicator function of the interval  $[\frac{d}{q} - \delta, \frac{d}{q} + \delta]$ . Here  $L := \sum_{q \in \Phi} \phi(q)$  (then roughly we have  $L \asymp Q^2$ ) and we will choose  $\Phi$  in such a way that  $L \asymp Q^{2-\epsilon}$ .

Then this becomes an approximation of  $I_{[0,1]}$  in the following sense:

**Lemma 2.2.1.** *We have*

$$\int_{\mathbb{R}} \left| I_{[0,1]}(x) - \tilde{I}_{\Phi, \delta}(x) \right|^2 dx \ll \frac{Q^{2+\epsilon}}{\delta L^2},$$

where  $I$  is the indicator function of  $[0, 1]$ .

This is a consequence of the Parseval theorem from Fourier analysis (see [14], [21]).

2.3. **Root number.** Let  $f$  be a newform of level  $p^j$  ( $j > 2$ ) with trivial nebentypus. We denote by  $\pi_f$  the automorphic representation (attached to  $f$ ) of the adèle group  $\mathrm{GL}_2(\mathbb{A}_{\mathbb{Q}})$ . It is well-known that  $\pi_f$  decomposes as a restricted tensor product  $\pi_f = \otimes'_v \pi_{f,v}$  where  $v$  runs over all places of  $\mathbb{Q}$ . Here  $\pi_{f,v}$  is an irreducible admissible representation of  $\mathrm{GL}_2(\mathbb{Q}_v)$  and  $\mathbb{Q}_v$  denotes the completion of  $\mathbb{Q}$  at  $v$ .

Let  $\chi$  be a Dirichlet character modulo  $p^r$  with  $r < j$ . We assume that  $r$  is quite small compared to  $j$  ( $r \leq [\frac{j}{4}]$ ) and  $p$  is a large prime number. The question we are interested in is the following: What is the epsilon factor/root number of  $f \otimes \chi$ ? By class field theory, the character  $\chi$  can be identified with a character of the idèle group, that is, characters  $\{\chi_q\}_q$  with  $\chi_q : \mathbb{Q}_q^\times \rightarrow \mathbb{C}^\times$ , see [16, p. 195] for more details. Now to compute the local epsilon factors of  $f$  at each prime  $p$ , we choose an additive character  $\phi$  of  $\mathbb{Q}_p$  of conductor 0. Note that the global epsilon factor of  $f$  is a product of all local epsilon factors and that does not depend on the additive character chosen. Then one can show that, for the prime  $p$ ,

$$\varepsilon(\pi_{f,p} \otimes \chi_p, \phi) = \begin{cases} \chi_p(p^j u) \varepsilon(\pi_{f,p}, \phi), & \text{if } p \text{ is an unramified supercuspidal prime,} \\ \chi_p(p^{2j} u) \varepsilon(\pi_{f,p}, \phi), & \text{if } p \text{ is a ramified supercuspidal prime,} \end{cases}$$

for some  $u \in \mathbb{Z}_p^\times$ . Also for other primes  $q \neq p$ , we have

$$\varepsilon(\pi_{f,q} \otimes \chi_q, \phi) = \varepsilon(\pi_{f,q}, \phi).$$

Hence we have

$$(3) \quad \varepsilon(\pi_f \otimes \chi) = \chi(\mathfrak{a}) \varepsilon(\pi_f),$$

for some constant  $p \nmid \mathfrak{a}$ , depending on  $f$  only. Without loss of generality, or our computation we will take  $\mathfrak{a} = 1$  which can be seen from the computation.

### 3. SETTING-UP THE CIRCLE METHOD :

**3.1. Approximate functional equation.** By means of approximate functional equation and dyadic subdivision, we have

$$(4) \quad L\left(\frac{1}{2}, f \otimes g\right) \ll_{\epsilon, A} \sup_{N \ll p^{2+\epsilon}} \frac{S(N)}{\sqrt{N}} + O(p^{-A}),$$

for any small  $\epsilon > 0$  and any large  $A > 0$ , where

$$S(N) = \sum_{n \in \mathbb{Z}} \lambda_f(n) \lambda_g(n) V\left(\frac{n}{N}\right),$$

with  $V$  a smooth bump function supported on  $[\frac{1}{2}, 3]$  satisfying  $V(x) = 1$  for all  $x \in [1, 2]$ .

To proceed further, in the delta method approach we separate oscillations of the Fourier coefficients  $\lambda_f(n)$  and  $\lambda_g(n)$ , using the Jutila's circle method (see [14], [15]) similarly as done in the author's previous articles (see [6], [7]).

**3.2. Further set-up.** Let us apply the circle method directly to the smooth sum

$$S(N) = \sum_{n \in \mathbb{Z}} \lambda_f(n) \lambda_g(n) V\left(\frac{n}{N}\right),$$

where the function  $V$  is smooth, supported in  $[1, 2]$  with  $V^{(j)}(x) \ll_j 1$ . Now we will approximate the above sum  $S(N)$  using Jutila's circle method (see [14], [15]) by the following sum :

$$(5) \quad \begin{aligned} \tilde{S}(N) &= \frac{1}{Lp} \sum_{q \in \Phi} \sum_{b \bmod p} \sum_{a \bmod q}^* \sum_{n, m \in \mathbb{Z}} \lambda_f(m) \lambda_g(n) e\left(\frac{a(n-m)}{pq}\right) \\ &\times e\left(\frac{b(n-m)}{p}\right) F(n, m), \end{aligned}$$

where  $e_q(x) = e\left(\frac{x}{q}\right) = e^{2\pi i x/q}$ , and

$$F(x, y) = V\left(\frac{x}{N}\right) U\left(\frac{y}{N}\right) \frac{1}{2\delta} \int_{-\delta}^{\delta} e\left(\alpha \frac{(n-m)}{p}\right) d\alpha.$$

Here  $U$  is another smooth function having compact support in  $(0, \infty)$ , with  $U(x) = 1$  for  $x$  in the support of  $U$ . Also we choose  $\delta = \frac{p}{N}$  so that we have

$$\frac{\partial^{i+j}}{\partial^i x \partial^j y} F(x, y) \ll_{i,j} \frac{1}{N^{i+j}}.$$

Then we have the following lemma :

**Lemma 3.2.1.** *Let  $\Phi \subset [Q, 2Q]$ , with*

$$L = \sum_{q \in \Phi} \phi(q) \gg Q^{2-\epsilon},$$

and  $\delta = \frac{p}{N}$ . Then we must have

$$(6) \quad S(N) = \tilde{S}(N) + O_{f,\epsilon} \left( N \sqrt{\frac{Q^2}{\delta L^2}} \right).$$

*Proof.* Consider

$$G(x) = \sum_{b \bmod p} \sum_{n, m \in \mathbb{Z}} \lambda_f(m) \lambda_g(n) V\left(\frac{n}{N}\right) U\left(\frac{m}{N}\right) e\left(x \frac{(n-m)}{p}\right) e\left(b \frac{(n-m)}{p}\right).$$

One can see that  $S(N) = \int_0^1 G(x) dx$  and  $\tilde{S}(N) = \int_0^1 \tilde{I}_{\Phi, \delta}(x) G(x) dx$ , where  $\tilde{I}(\alpha) := \frac{1}{2\delta L} \sum_{q \in \Phi} \sum_{d \bmod q}^* \mathcal{I}_{d/q}(\alpha)$  and  $\mathcal{I}_{d/q}$  is the indicator function of the interval  $[\frac{d}{q} - \delta, \frac{d}{q} + \delta]$ ,  $Q := N^{1/2+\epsilon}$  and  $L \asymp Q^{2-\epsilon}$ .

Hence

$$(7) \quad \begin{aligned} |S(N) - \tilde{S}(N)| &\leq \frac{1}{p} \sum_{b \bmod p} \int_0^1 |1 - \tilde{I}_{\Phi, \delta}(x)| \left| \sum_{n \in \mathbb{Z}} \lambda_g(n) e\left(\frac{(x+b)n}{p}\right) V\left(\frac{n}{N}\right) \right| \\ &\quad \times \left| \sum_{m \in \mathbb{Z}} \lambda_f(m) e\left(\frac{(-x-b)m}{p}\right) U\left(\frac{m}{N}\right) \right| dx. \end{aligned}$$

For the  $n$ -sum in the middle we have the Wilton-type bound

$$\sum_{n \in \mathbb{Z}} \lambda_g(n) e\left(\frac{(x+b)n}{p}\right) V\left(\frac{n}{N}\right) \ll_{g,\epsilon} N^{\frac{1}{2}+\epsilon}.$$

Using the Cauchy-Schwarz's inequality to the remaining sum we get

$$(8) \quad \begin{aligned} |S(N) - \tilde{S}(N)| &\ll \frac{N^{\frac{1}{2}+\epsilon}}{p} \left( \sum_{b \bmod p} \left[ \int_0^1 |1 - \tilde{I}_{\Phi, \delta}(x)|^2 dx \right]^{1/2} \right. \\ &\quad \left. \times \left[ \int_0^1 \left| \sum_{m \in \mathbb{Z}} \lambda_f(m) e\left(-\frac{(x+b)m}{p}\right) U\left(\frac{m}{N}\right) \right|^2 dx \right]^{1/2} \right). \end{aligned}$$

For the last  $m$ -sum we open the absolute value square and execute the integral along with the additive character sum. So we are left with only the diagonal, which has size  $N$ . For the other sum we use (2.2.1). It follows that

$$(9) \quad |S(N) - \tilde{S}(N)| \ll N \sqrt{\frac{Q^2}{\delta L^2}}.$$

□

**3.3. Error term.** As for subconvexity, we need to save  $N$  with something more, i.e., we must have  $\delta L^2 > Q^2$ , i.e.,  $\frac{1}{Q} \gg \delta > \frac{1}{Q^2}$ , i.e.,  $Q > \sqrt{\frac{N}{p}}$ . Here we choose  $Q = \sqrt{\frac{N}{p}} p^{\eta+\epsilon} = p^{\frac{3}{2}+\eta+\epsilon}$ . Hence the error term in Lemma (3.2.1) is bounded by  $O\left(\frac{N}{p^\eta}\right)$ .

## 4. SKETCH OF THE PROOF

Here in the sketch we will suppress the weight function for notational simplicity and we will closely follow the method done in [6], [7], [22]. We write the sum as

$$\mathbf{S} = \sum_{n, m \sim p^4} \lambda_f(m) \lambda_g(n) \delta_{n, m},$$

where  $\delta_{n, m}$  is the Kronecker  $\delta$ -symbol. Here to get an inbuilt bilinear structure in the circle method itself, we need to use a more flexible version of the circle method - the one investigated by Jutila (see [14], [15]). This version comes with an error term which is satisfactory, as we shall find out, as long as we allow the moduli to be slightly larger than  $\sqrt{N}$ . Up to an admissible error we see that  $\mathbf{S}$  is given by

$$\mathbf{S} = \sum_{n, m \sim N} \lambda_f(m) \lambda_g(n) \int_{\mathbb{R}} \tilde{I}(\alpha) e((n-m)\alpha) d\alpha,$$

where  $\tilde{I}(\alpha) := \frac{1}{2\delta L} \sum_{q \in \Phi} \sum_{d \bmod q}^* \mathcal{I}_{d/q}(\alpha)$  and  $\mathcal{I}_{d/q}$  is the indicator function of the interval  $[\frac{d}{q} - \delta, \frac{d}{q} + \delta]$ ,  $Q := N^{1/2+\epsilon}$  and  $L \asymp Q^{2-\epsilon}$ .

Trivial bound at this stage yields  $N^{2+\epsilon}$  and we need to establish the bound  $N^{1-\theta}$  for some  $\theta > 0$ , i.e., roughly speaking we need to save  $N+$  something more. Observe that by our choice of  $Q$ , there is no analytic oscillation in the weight function  $e((n-m)\alpha)$ . Hence their weights can be dropped in our sketch. Here also we are assuming that  $p \nmid q$ . At first glue the congruence classes modulo  $p$  and modulo  $q$  to get  $p\phi(q)$  many congruence classes modulo  $pq$ . In this sketch for simplicity we assume that all of the congruence classes are reduced modulo  $pq$ . So instead of  $S(N)$  we consider the sum

$$\sum_{q \sim Q} \sum_{a \bmod pq}^* \sum_{m \sim N} \lambda_f(m) e\left(\frac{-am}{pq}\right) \sum_{n \sim N} \lambda_g(n) e\left(\frac{an}{pq}\right).$$

The GL(2) Voronoi on the  $n$ -sum yields

$$\sum_{n \sim N} \lambda_g(n) e\left(\frac{an}{pq}\right) \rightsquigarrow \frac{N}{pq} \sum_{n \sim \frac{(pQ)^2}{N}} \lambda_g(n) e\left(\frac{-\bar{a}n}{pq}\right),$$

with a savings  $\frac{N}{pQ}$ .

Now we need to use the GL(2) Voronoi for the  $m$ -sum in a tricky way as  $p^2$  appears in the modulus, but the modulus is not divisible by  $p^4$ , the level of the form. So the standard Voronoi summation formulas available in the literature (see [17]) does not work directly here. This, however, can be overcome easily using the work of Atkin-Li (see [2]). Munshi (see [23]) used a trick for the Voronoi summation formula and we are going to use that trick here. The main point is that as  $f$  is  $p$ -primitive, the twisted form  $f \times \chi = f_\chi$  has level  $[p^4, p^2] = p^4$ , for any character  $\chi$  modulo  $p^2$ . Hence the length of the dual sum is given by  $m \rightsquigarrow \frac{p^4 Q^2}{N}$ . So here Voronoi yields

$$\sum_{m \sim N} \lambda_f(m) e\left(\frac{-am}{pq}\right) \rightsquigarrow \frac{N}{p^2 q} \sum_{m \sim \frac{p^4 Q^2}{N}} \lambda_f(m) e\left(\frac{\overline{ap^3 m}}{q}\right) \mathbf{C}_1(a, m, q; p),$$

where  $\mathbf{C}_1(a, m, q; p)$  is an incomplete character sum roughly of the form

$$\sum_{\psi \bmod p}^* \psi(m\bar{a}\bar{q}) \eta(f \times \bar{\psi}) g(\psi),$$

with the savings  $\frac{N}{pQ}$  provided that this incomplete character sum has a square root cancellation and it comes with a loss of  $\sqrt{p}$ .

Now we consider the  $a \bmod q$  sum which reduces to

$$\sum_{a \bmod q}^* e\left(\frac{-\bar{a}pn}{q}\right) e\left(\frac{\bar{a}p^3m}{q}\right) \rightsquigarrow \mathcal{I}_{m \equiv p^2n \bmod q},$$

where  $\mathcal{I}_x$  is the characteristic function of  $x$ . So here we save  $Q$ . Also executing the sum over  $a \bmod p$ , it reduces to

$$\begin{aligned} & \sum_{a \bmod p}^* e\left(\frac{-\bar{a}n\bar{q}}{p}\right) \sum_{\psi \bmod p}^* \psi(m\bar{a}\bar{q})\eta(f \times \bar{\psi})g(\psi) \\ & \rightsquigarrow \sum_{\psi \bmod p}^* \psi(m\bar{a}\bar{q})\eta(f \times \bar{\psi})g(\psi)^2 \rightsquigarrow p^2S(m, -n, ; p). \end{aligned}$$

Now assuming the square root cancellation in the last sum we see that so far we have saved

$$\frac{1}{\sqrt{p}} \times \frac{N}{pQ} \times \frac{N}{p^2Q} \times Q\sqrt{p} \times \sqrt{p} = \frac{N}{p^n}.$$

So we are on the boundary and need to save  $p^n$  and something more. Now we are using the Cauchy-Schwarz's inequality, change of the variables and the Poisson summation formula to get our result.

## 5. VORONOI SUMMATION FORMULAE

At first we consider the case  $p \nmid b$  (other case will be dominated by this case as in that case we will have a saving of size  $p$ ) and also we assume that each member of  $\Phi$  is coprime to  $p$ , the modulus of the character  $\chi$ .

Now let us consider

$$(10) \quad \tilde{S}_{\neq 0}(N) = \frac{1}{Lp} \sum_{q \in \Phi} \sum_{a \bmod pq}^* S(a, q, x, f)T(a, q, x, g),$$

where

$$S(a, q, x, g) := \sum_{n=1}^{\infty} \lambda_g(n) e_{pq}(an) e\left(\frac{xn}{p}\right) V\left(\frac{n}{N}\right),$$

and

$$T(a, q, x, f) := \sum_{m=1}^{\infty} \lambda_f(m) e_{pq}(-am) e\left(-\frac{xm}{p}\right) U\left(\frac{m}{N}\right).$$

so that we have

$$(11) \quad \tilde{S}(N) = \frac{1}{2\delta} \int_{-\delta}^{\delta} \tilde{S}_x(N) dx.$$



5.1. Voronoi for the  $n$ -sum.

**Lemma 5.1.1.** *We have*

$$(12) \quad S(a, q, x, g) = \frac{N^{3/4}}{\sqrt{pq}^{1/2}} \sum_{1 \leq n \ll N_0} \frac{\lambda_g(n)}{n^{1/4}} e\left(-\frac{\bar{a}n}{pq}\right) \mathcal{I}(n, x, q; p) + O(N^{-2024}),$$

where  $N_0 := p^{1+2\eta}$  and  $\mathcal{I}(n, x, q; p)$  is given by

$$(13) \quad \mathcal{I}(n, x, q; p) := \int_{\mathbb{R}} V(y) e\left(\frac{Nxy}{p} \pm \frac{4\pi}{pq} \sqrt{Nny}\right) W_g\left(\frac{4\pi\sqrt{Nny}}{pq}\right) dy,$$

where  $W_g$  is a smooth nice function.

*Proof.* Applying the Voronoi summation formula (2.1.1) to the  $n$ -sum of the equation (10), then we have

$$\begin{aligned} \sum_{n \in \mathbb{Z}} \lambda_g(n) e\left(\frac{an}{pq}\right) e\left(\frac{xn}{p}\right) V\left(\frac{n}{N}\right) &= \frac{1}{pq} \sum_{n \in \mathbb{Z}} \lambda_g(n) e\left(-\frac{\bar{a}n}{pq}\right) \\ &\quad \times \int_{\mathbb{R}} V\left(\frac{y}{N}\right) e\left(\frac{xy}{p}\right) J_{k_g-1}\left(\frac{4\pi\sqrt{ny}}{pq}\right) dy, \end{aligned}$$

where  $J_{k_g-1}$  is the Bessel function. By changing  $y \mapsto Ny$  and using the decomposition 2.1.2,

$$J_{k_g-1}(x) = \frac{W_g(x)}{\sqrt{x}} e(x) + \frac{\bar{W}_g(x)}{\sqrt{x}} e(-x),$$

where  $W_g(x)$  is a nice function, the right hand side integral becomes

$$\frac{N^{3/4}}{q^{1/2}\sqrt{p}} \int_{\mathbb{R}} V(y) e\left(\frac{Nxy}{p} \pm \frac{4\pi}{pq} \sqrt{Nny}\right) W_g\left(\frac{4\pi\sqrt{Nny}}{pq}\right) dy.$$

By repeated integration by parts we see that, this integral is negligibly small if  $|n| \gg \frac{p^2 q^2 N^\epsilon}{N} =: N_q$  with  $N_q \asymp \frac{p^2 Q^2 N^\epsilon}{N} = p^{1+2\eta} =: N_0$ . Hence the lemma follows.  $\square$

5.2. Voronoi for the  $m$ -sum. Now let us consider the sum over  $m$ ,

$$T(a, q, x, f) = \sum_{m=1}^{\infty} \lambda_f(m) e_{pq}(-am) e\left(\frac{-xm}{p}\right) U\left(\frac{m}{N}\right).$$

Here we considered  $p \nmid q$ . To apply the Voronoi summation formula, we need to use results from [2]. Now for  $p \nmid u$ ,

$$e\left(\frac{u}{p}\right) = \frac{1}{\phi(p)} \sum_{\chi \bmod p} g(\chi) \bar{\chi}(u) = -\frac{1}{\phi(p)} + \frac{1}{\phi(p)} \sum_{\chi \bmod p}^* g(\chi) \bar{\chi}(u),$$

where  $g(\chi)$  stands for the Gauss sum for  $\chi$ . Now as  $p \nmid q$  so writing  $a = aq\bar{q} + ap\bar{p}$  and also as  $\lambda_f(p) = 0$ , so noting  $p \nmid m$  in  $T$ , we have  $T = T_1 + T_2$ , where

$$T_1 := -\frac{1}{\phi(p)} \sum_{n=1}^{\infty} \lambda_f(m) e\left(-\frac{am\bar{p}}{q}\right) e\left(\frac{xm}{p}\right) U\left(\frac{m}{N}\right),$$

and

$$(14) \quad T_2 := \frac{1}{\phi(p)} \sum_{\chi \bmod p}^* g(\chi) \chi(q\bar{a}) \sum_{m=1}^{\infty} \lambda_f(m) e\left(-\frac{am\bar{p}}{q}\right) e\left(\frac{xm}{p}\right) U\left(\frac{m}{N}\right).$$

Here note that the contribution of the sum  $T_1$  is dominated (as it comes with a prior saving of  $p$ ) by the contribution of  $T_2$ . So we will examine the contribution of  $T_2$ .

**Lemma 5.2.1.** *We have*

$$(15) \quad T_2 = \frac{2\pi i^{k_f} N}{qp^2 \phi(p)} \sum_{\chi \bmod p}^* g(\chi) \chi(\bar{q}a) \eta(f \times \bar{\chi}) \sum_{m=1}^{\infty} \lambda_f(m) \chi(m) e\left(\frac{\overline{ap^3 m}}{q}\right) \\ \times \int_0^{\infty} U(y) e\left(\frac{xNy}{p}\right) J_{k_f}\left(\frac{4\pi\sqrt{mNy}}{qp^2}\right) + O(N^{-2024}).$$

*Proof.* At first consider the sum

$$(16) \quad \sum_{m=1}^{\infty} \lambda_f(m) \bar{\chi}(m) e\left(-\frac{a\bar{p}m}{q}\right) w(m) = \sum_{m=1}^{\infty} \lambda_h(m) e\left(-\frac{a\bar{p}m}{q}\right) w(m) dy,$$

where  $h = f \times \bar{\chi}$ . Now by proposition 3.1 of [2], we must have  $h \in M_k(M, \bar{\chi}^2)$  where  $M = \text{lcm}(\text{level of } f, \text{conductor of } \chi)$  so for our case we have  $M = \text{lcm}(p^4, p^2) = p^4$ . Also by the Theorem 3.1 and Proposition 4.1 of [2],  $h$  is a newform of level  $p^4$  and nebentypus  $\bar{\chi}^2$ . Then by the Voronoi summation formula given in [17], the sum (16) transforms into,

$$2\pi i^{k_f} \frac{N\bar{\chi}^2(q)\eta(h)}{qp^2} \sum_{m=1}^{\infty} \overline{\lambda_h(m)} e\left(\frac{\overline{ap^3 m}}{q}\right) \int_0^{\infty} w(y) J_{k_f-1}\left(\frac{4\pi\sqrt{my}}{qp^2}\right).$$

Substituting this in (16) we get our lemma.  $\square$

Now extracting the oscillation of the Bessel function using 2.1.2 as done for the  $n$ -sum and noting that  $\phi(p) \asymp p$ , we note that the  $m$ -sum  $T_2$  in the Lemma (5.2.1) is given by a sum of two similar terms of the form

$$(17) \quad \frac{N^{3/4}}{q^{1/2} p^2} \sum_{\chi \bmod p}^* g(\chi) \chi(\bar{q}a) \eta(f \times \bar{\chi}) \sum_{m=1}^{\infty} \frac{\lambda_f(m) \chi(m)}{m^{1/4}} e\left(\frac{\overline{ap^3 m}}{q}\right) \mathcal{J}(m, x, q; p),$$

where

$$(18) \quad \mathcal{J}(m, x, q; p) = \int_0^{\infty} U(y) e\left(-\frac{Nxy}{p^2} \pm \frac{2\sqrt{mNy}}{p^2 q}\right) dy.$$

By repeated integration by parts we see that, this integral is negligibly small if  $|m| \gg \frac{p^4 q^2}{N} := M_q \asymp \frac{p^4 Q^2}{N} = p^{3+2\eta} =: M_0$  and we will consider the trivial bound for  $\mathcal{J}(m, x, q; p)$  whenever needed.

## 6. FURTHER ESTIMATION

Substituting (5.1.1), (17) in (10) we arrive at

$$(19) \quad \tilde{S}_{\neq 0}(N) = \frac{N^{3/2}}{Lp^{\frac{7}{2}}} \sum_{q \in \Phi} \frac{1}{q} \sum_{1 \leq n \ll N_0} \frac{\lambda_g(n)}{n^{1/4}} \sum_{m \ll M_0} \frac{\lambda_f(m)}{m^{1/4}} \mathcal{CI}(n, x, q; p) \mathcal{J}(m, x, q; p),$$

where the pseudo-character sum  $\mathcal{C}$  is given by

$$(20) \quad \mathcal{C}(n, m, p, q) := \sum_{a \bmod pq}^* e\left(-\frac{\bar{a}n}{pq}\right) e\left(\frac{\overline{ap^3 m}}{q}\right) \sum_{\chi \bmod p}^* g(\chi) \chi(\bar{q}am) \eta(f \times \bar{\chi}).$$

**Lemma 6.0.1.** *We have*

$$(21) \quad \mathcal{C}(n, m, p, q) = \mathcal{C}_p(m, n; p) \mathcal{C}_q,$$

where

$$(22) \quad \mathcal{C}_p(m, n; p) = \phi(p)S(m, -n; p),$$

and

$$(23) \quad \mathcal{C}_q = \sum_{\substack{d|q \\ m \equiv p^2 n \pmod{d}}} d\mu\left(\frac{q}{d}\right),$$

and  $\gcd(mn, p) = 1$ .

*Proof.* At first splitting the character sum in (20) we get that

$$(24) \quad \mathcal{C}_p(m, n; p) = \sum_{a \pmod{p}}^* e\left(-\frac{\overline{a}qn}{p}\right) \sum_{\chi \pmod{p}}^* g(\chi)\chi(\overline{q}am)\eta(f \times \overline{\chi}),$$

and

$$(25) \quad \mathcal{C}_q = \sum_{a \pmod{q}}^* e\left(-\frac{\overline{a}pn}{q}\right) e\left(\frac{\overline{a}p^3 m}{q}\right).$$

Now the last character sum reduces to

$$(26) \quad \begin{aligned} \mathcal{C}_q &= \sum_{a \pmod{q}}^* e\left(-\frac{\overline{a}pn}{q}\right) e\left(\frac{\overline{a}p^3 m}{q}\right) \\ &= \sum_{a \pmod{q}}^* e\left(\frac{\overline{a}p^3(-np^2 + m)}{q}\right) \\ &= \sum_{\substack{d|q \\ m \equiv p^2 n \pmod{d}}} d\mu\left(\frac{q}{d}\right). \end{aligned}$$

Now consider the incomplete character sum modulo  $p$ . Changing variables and pushing the sum over  $a$  inside and using the equation (3) we have

$$\begin{aligned} \mathcal{C}_p(m, n; p) &= \sum_{\chi \pmod{p}}^* g(\chi)\eta(f \times \overline{\chi}) \sum_{a \pmod{p}}^* \chi(\overline{q}am) e\left(-\frac{\overline{a}qn}{p}\right) \\ &= \sum_{\chi \pmod{p}}^* g(\chi)^2 \eta(f \times \overline{\chi}) \chi(m\overline{n}) \\ &= \varepsilon(\pi_f) \sum_{\chi \pmod{p}}^* g(\chi)^2 \chi(m\overline{n}) \\ &= \varepsilon(\pi_f) \sum_{\chi \pmod{p}}^* \chi(m\overline{n}) \left( \sum_{a \pmod{p}} \chi(a) e\left(\frac{a}{p}\right) \right)^2 \\ &= \varepsilon(\pi_f) \sum_{a_1, a_2 \pmod{p}} e\left(\frac{a_1}{p}\right) e\left(-\frac{a_2}{p}\right) \sum_{\chi \pmod{p}}^* \chi(m\overline{n}) \chi(a_1) \chi(a_2) \\ &= \varepsilon(\pi_f) \phi(p)S(m, -n; p) - \varepsilon(\pi_f) \mathcal{I}_{m \equiv n \pmod{p}}. \end{aligned}$$

Here one can see that the sum (19) with the second term from the previous line comes with an extra savings of  $p$ . So we will go with the first term only. Also here we note that  $\gcd(mn, p) = 1$ .  $\square$

## 7. FURTHER COMPUTATION

**7.1. Cauchy-Schwarz inequality.** For the time being, we will focus on the case when  $r = 1$ . At first we choose the set of moduli  $\Phi$  to be the product set  $\Phi_1\Phi_2$ , where  $\Phi_i$  consists of primes in the dyadic segment  $[Q_i, 2Q_i]$  (and coprime to  $p$ ) for  $i = 1, 2$  and  $Q_1Q_2 = Q = \sqrt{\frac{N}{p}}p^\eta$ . Also, we pick  $Q_1$  and  $Q_2$  (whose optimal sizes will be determined later) so that the collections  $\Phi_1$  and  $\Phi_2$  are disjoint. Now let us take  $m = p^2n + dr$ , so that  $\gcd(r, p) = 1$  as  $\gcd(qm, p) = 1$ . We have

$$(27) \quad \begin{aligned} \tilde{S}_{\neq 0}(N) := \Sigma_q &:= \frac{N^{3/2}}{Lp^{\frac{5}{2}}} \sum_{q \in \Phi} \frac{1}{q} \sum_{d|q=q_1q_2} d\mu\left(\frac{q}{d}\right) \sum_{1 \leq n \ll N_0} \left( \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \right) \\ &\times \sum_{\substack{1 \leq r \ll \frac{M_0}{d} \\ \gcd(r, p) = 1}} \frac{\lambda_f(p^2n + dr) \mathcal{I}(p^2n + dr, x, q; p)}{(p^2n + dr)^{1/4}} S(dr, -n; p) \end{aligned}$$

Several cases occur.

**7.2. Case 1.** Let  $d = q$  (or  $d = 1$ ).

$$(28) \quad \begin{aligned} \Sigma_q &= \frac{N^{3/2}}{Lp^{\frac{5}{2}}} \sum_{q \in \Phi} \sum_{1 \leq n \ll N_0} \left( \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \right) \\ &\times \sum_{\substack{1 \leq r \ll \frac{M_0}{Q} \\ \gcd(rq, p) = 1}} \frac{\lambda_f(p^2n + qr) \mathcal{I}(p^2n + qr, x, q; p)}{(p^2n + qr)^{1/4}} S(qr, -n; p) \\ &\ll \frac{N^{3/2}}{Lp^{\frac{5}{2}}} \sum_{q \in \Phi} \sum_{\substack{1 \leq r \ll \frac{M_0}{Q} \\ \gcd(rq, p) = 1}} \left| \right. \\ &\times \sum_{1 \leq n \ll N_0} \left( \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \right) \frac{\lambda_f(p^2n + qr) \mathcal{I}(p^2n + qr, x, q; p)}{(p^2n + qr)^{1/4}} S(qr, -n; p) \left. \right| \\ &\ll \frac{N^{3/2}}{Lp^{\frac{5}{2}}} \sum_{\substack{1 \leq r \ll M_0 \\ \gcd(r, p) = 1}} \left| \right. \\ &\times \sum_{1 \leq n \ll N_0} \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \frac{\lambda_f(p^2n + r) \mathcal{I}(p^2n + r, x, q; p)}{(p^2n + r)^{1/4}} S(r, -n; p) \left. \right|, \end{aligned}$$

where in the last line we have attached the variables  $qr \mapsto r$  where we already had  $\gcd(rq, p) = 1$ .

After using the Cauchy-Schwarz's inequality we have

$$(29) \quad \Sigma_q \ll \frac{N^{3/2} M_0^{1/2}}{L p^{\frac{5}{2}}} \left( \sum_{\substack{1 \leq r \ll M_0 \\ \gcd(r,p)=1}} \left| \sum_{1 \leq n \ll N_0} \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \right. \right. \\ \left. \left. \times \frac{\lambda_f(p^2 n + r)}{(p^2 n + r)^{1/4}} \mathcal{I}(p^2 n + r, x, q; p) S(r, -n; p) \right|^2 \right)^{1/2}.$$

Now consider the sum

$$(30) \quad \Sigma_1 := \sum_{\substack{1 \leq r \ll M_0 \\ \gcd(r,p)=1}} \left| \sum_{1 \leq n \ll N_0} \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \frac{\lambda_f(p^2 n + r)}{(p^2 n + r)^{1/4}} \mathcal{I}(p^2 n + r, x, q; p) S(r, -n; p) \right|^2 \\ = \sum_{\substack{1 \leq r \ll M_0 \\ \gcd(r,p)=1}} \sum_{1 \leq n \ll N_0} \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \frac{\lambda_f(p^2 n + r)}{(p^2 n + r)^{1/4}} \mathcal{I}(p^2 n + r, x, q; p) S(r, -n; p) \\ \times \sum_{1 \leq n' \ll N_0} \lambda_g(n') \frac{\mathcal{J}(n', x, q; p)}{n'^{1/4}} \frac{\lambda_f(p^2 n' + r)}{(p^2 n' + r)^{1/4}} \mathcal{I}(p^2 n' + r, x, q; p) S(r, -n'; p).$$

We have two cases.

**Diagonal case.** For the diagonal case  $n = n'$  we have

$$(31) \quad \Sigma_1 = \sum_{\substack{1 \leq r \ll M_0 \\ \gcd(r,p)=1}} \sum_{1 \leq n \ll N_0} |\lambda_g(n)|^2 \frac{|\mathcal{J}(n, x, q; p)|^2}{n^{1/2}} \frac{|\lambda_f(p^2 n + r)|^2}{(p^2 n + r)^{1/2}} |\mathcal{I}(p^2 n + r, x, q; p)|^2 |S(r, -n; p)|^2 \\ \ll M_0^{1/2} N_0^{1/2} p = p^{3+2\eta},$$

where we have used the partial summation formula and the Ramanujan bound on average (2).

**Off-diagonal case.** For the off-diagonal case  $n \neq n'$  we have

$$(32) \quad \Sigma_1 = \sum_{\substack{1 \leq r \ll M_0 \\ \gcd(r,p)=1}} \sum_{1 \leq n \ll N_0} \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \frac{\lambda_f(p^2 n + r)}{(p^2 n + r)^{1/4}} \mathcal{I}(p^2 n + r, x, q; p) S(r, -n; p) \\ \times \sum_{1 \leq n' \ll N_0} \lambda_g(n') \frac{\mathcal{J}(n', x, q; p)}{n'^{1/4}} \frac{\lambda_f(p^2 n' + r)}{(p^2 n' + r)^{1/4}} \mathcal{I}(p^2 n' + r, x, q; p) S(r, -n'; p).$$

Using the Cauchy-Schwarz's inequality the above inequality becomes dominated by

$$\begin{aligned}
(33) \quad \Sigma_1 &\ll \sqrt{N_0} \left( \sum_{1 \leq n \ll N_0} \sum_{1 \leq n' \ll N_0} \left| \sum_{\substack{1 \leq r \ll M_0 \\ \gcd(r,p)=1}} \frac{\lambda_f(p^2n+r)}{(p^2n+r)^{1/4}} \mathcal{I}(p^2n+r, x, q; p) S(r, -n; p) \right. \right. \\
&\quad \left. \left. \times \frac{\lambda_f(p^2n'+r)}{(p^2n'+r)^{1/4}} \mathcal{I}(p^2n'+r, x, q; p) S(r, -n'; p) \right|^2 \right)^{1/2}.
\end{aligned}$$

Changing the variables  $p^2n+r \mapsto u$  and  $n' = n + \ell$  so that  $\gcd(r, p) = 1 \implies \gcd(u, p) = 1$  and hence we have

$$\begin{aligned}
(34) \quad \Sigma_1 &\ll \sqrt{N_0} \left( \sum_{1 \leq n \ll N_0} \sum_{1 \leq \ell \ll N_0} \left| \sum_{\substack{1 \leq u \ll M_0 \\ \gcd(u,p)=1}} \frac{\lambda_f(u)}{u^{1/4}} \mathcal{I}(u, x, q; p) S(u, -n; p) \right. \right. \\
&\quad \left. \left. \times \frac{\lambda_f(u + \ell p^2)}{(u + \ell p^2)^{1/4}} \mathcal{I}(u + \ell p^2, x, q; p) S(u, -n - \ell; p) \right|^2 \right)^{1/2}.
\end{aligned}$$

Now opening the absolute value square we have

$$\begin{aligned}
(35) \quad \Sigma_2 &= \sum_{1 \leq n \ll N_0} \sum_{1 \leq \ell \ll N_0} \sum_{\substack{1 \leq u \ll M_0 \\ \gcd(u,p)=1}} \frac{\lambda_f(u)}{u^{1/4}} \mathcal{I}(u, x, q; p) S(u, -n; p) \\
&\quad \times \frac{\lambda_f(u + \ell p^2)}{(u + \ell p^2)^{1/4}} \mathcal{I}(u + \ell p^2, x, q; p) S(u, -n - \ell; p) \\
&\quad \times \sum_{\substack{1 \leq u' \ll M_0 \\ \gcd(u',p)=1}} \frac{\lambda_f(u')}{u'^{1/4}} \mathcal{I}(u', x, q; p) S(u', -n; p) \\
&\quad \times \frac{\lambda_f(u' + \ell p^2)}{(u' + \ell p^2)^{1/4}} \mathcal{I}(u' + \ell p^2, x, q; p) S(u', -n - \ell; p).
\end{aligned}$$

We have several cases:

**Diagonal case.** For  $u \equiv u' \pmod{p}$ ,

$$\begin{aligned}
(36) \quad \Sigma_2 &\ll \sum_{1 \leq n \ll N_0} \sum_{1 \leq \ell \ll N_0} \sum_{\substack{1 \leq u \ll M_0 \\ \gcd(u,p)=1}} \frac{|\lambda_f(u)|^2}{u^{1/2}} |\mathcal{I}(u, x, q; p)|^2 |S(u, -n; p)|^2 \\
&\quad \times \frac{|\lambda_f(u + \ell p^2)|^2}{(u + \ell p^2)^{1/2}} |\mathcal{I}(u + \ell p^2, x, q; p)|^2 |S(u, -n - \ell; p)|^2 \\
&\quad \ll N_0^2 p^2,
\end{aligned}$$

where we have used the partial summation formula and the Ramanujan bound on average (2).

So for this case, we have

$$(37) \quad \Sigma_1 \ll \sqrt{N_0} \left( N_0^2 p^2 \right)^{1/2} \ll N_0^{3/2} p = p^{\frac{5}{2} + 3\eta},$$

where we have used the partial summation formula and the Ramanujan bound on average (2).

*Off-diagonal case.* For  $u \not\equiv u' \pmod{p}$ ,

$$\begin{aligned}
(38) \quad \Sigma_2 &= \sum_{1 \leq \ell \ll N_0} \sum_{\substack{1 \leq u \ll M_0 \\ \gcd(u,p)=1}} \frac{\lambda_f(u)}{u^{1/4}} \mathcal{I}(u, x, q; p) \\
&\times \frac{\lambda_f(u + \ell p^2)}{(u + \ell p^2)^{1/4}} \mathcal{I}(u + \ell p^2, x, q; p) \\
&\times \sum_{\substack{1 \leq u' \ll M_0 \\ \gcd(u',p)=1}} \frac{\lambda_f(u')}{u'^{1/4}} \mathcal{I}(u', x, q; p) \\
&\times \frac{\lambda_f(u' + \ell p^2)}{(u' + \ell p^2)^{1/4}} \mathcal{I}(u' + \ell p^2, x, q; p) \\
&\times \left( \sum_{1 \leq n \ll N_0} S(u, -n; p) S(u, -n - \ell; p) S(u', -n; p) S(u', -n - \ell; p) \right).
\end{aligned}$$

Now taking  $n = pm + \beta$  where  $\beta \pmod{p}$  and then we do the Poisson summation formula on the  $n$ -sum and note that as the size of the conductor is  $p \ll N_0 = p^{1+2\eta}$  so the zero frequency will remain only, i.e., the case for  $m = 0$  and so we have

$$\begin{aligned}
(39) \quad \Sigma_2 &= \sum_{1 \leq \ell \ll N_0} \sum_{\substack{1 \leq u \ll M_0 \\ \gcd(u,p)=1}} \frac{\lambda_f(u)}{u^{1/4}} \mathcal{I}(u, x, q; p) \\
&\times \frac{\lambda_f(u + \ell p^2)}{(u + \ell p^2)^{1/4}} \mathcal{I}(u + \ell p^2, x, q; p) \\
&\times \sum_{\substack{1 \leq u' \ll M_0 \\ \gcd(u',p)=1}} \frac{\lambda_f(u')}{u'^{1/4}} \mathcal{I}(u', x, q; p) \\
&\times \frac{\lambda_f(u' + \ell p^2)}{(u' + \ell p^2)^{1/4}} \mathcal{I}(u' + \ell p^2, x, q; p) \\
&\times \frac{N_0}{p} \left( \sum_{\beta \pmod{p}} S(u, -\beta; p) S(u, -\beta - \ell; p) S(u', -\beta; p) S(u', -\beta - \ell; p) \right).
\end{aligned}$$

Now consider the character sum

$$\begin{aligned}
(40) \quad \mathcal{A} &:= \sum_{\beta \pmod{p}} S(u, -\beta; p) S(u, -\beta - \ell; p) S(u', -\beta; p) S(u', -\beta - \ell; p) \\
&= \sum_{a_1 \pmod{p}}^* e\left(\frac{\overline{a_1}u}{p}\right) \sum_{a_2 \pmod{p}}^* e\left(\frac{\overline{a_2}u - a_2\ell}{p}\right) \sum_{a_3 \pmod{p}}^* e\left(\frac{\overline{a_3}u'}{p}\right) \sum_{a_4 \pmod{p}}^* e\left(\frac{\overline{a_4}u' - a_4\ell}{p}\right) \\
&\times \sum_{\beta \pmod{p}} e\left(\frac{-\beta a_1}{p}\right) e\left(\frac{-\beta a_2}{p}\right) e\left(\frac{-\beta a_3}{p}\right) e\left(\frac{-\beta a_4}{p}\right).
\end{aligned}$$

Now from the  $\beta$  sum we have

$$\begin{aligned} a_1 + a_2 + a_3 + a_4 &\equiv 0 \pmod{p} \\ a_1 + a_2 + a_3 &\equiv -a_4 \pmod{p}. \end{aligned}$$

Hence the character sum becomes

$$\mathcal{A} = p \sum_{a_1 \pmod{p}}^* \sum_{a_2 \pmod{p}}^* \sum_{a_3 \pmod{p}}^* e\left(\frac{\overline{a_1}u + \overline{a_2}u + \overline{a_3}u' - (\overline{a_1 + a_2 + a_3})u' + a_1\ell + a_3\ell}{p}\right).$$

Now several cases occur.

**Case 1.** For the case  $\ell = 0$ , the above sum becomes

$$\begin{aligned} \mathcal{A} &= p \sum_{a_2 \pmod{p}}^* \sum_{a_3 \pmod{p}}^* \sum_{a_1 \pmod{p}}^* e\left(\frac{\overline{a_1}(u + \overline{a_2}u + \overline{a_3}u) - \overline{a_1}(\overline{1 + a_2 + a_3})u}{p}\right) \\ &= p \sum_{a_2 \pmod{p}}^* \sum_{a_3 \pmod{p}}^* (1 - p\mathbb{I}_{u + \overline{a_2}u + \overline{a_3}u - (\overline{1 + a_2 + a_3})u \equiv 0 \pmod{p}}) \\ &= p(p^2 - p\mathbb{I}_{u \equiv 0 \pmod{p}} - p\mathbb{I}_{1 + \overline{a_2} + \overline{a_3} - (\overline{1 + a_2 + a_3}) \equiv 0 \pmod{p}}). \end{aligned}$$

Now as the case  $u \equiv 0 \pmod{p}$  is not possible so we will focus mainly on the last equation in which  $a_3$  can be determined by  $a_2$  so we have

$$\begin{aligned} &p \sum_{a_2 \pmod{p}}^* \sum_{a_3 \pmod{p}}^* \sum_{a_1 \pmod{p}}^* e\left(\frac{\overline{a_1}(u + \overline{a_2}u + \overline{a_3}u) - \overline{a_1}(\overline{1 + a_2 + a_3})u}{p}\right) \\ &= p(p^2 - p\mathbb{I}_{u \equiv 0 \pmod{p}} - p(p-1)) \\ &= p(-p\mathbb{I}_{u \equiv 0 \pmod{p}} + p) \ll p^2. \end{aligned}$$

Hence from (39) and using the partial summation formula along with the Ramanujan bound on average (2) we have

$$\Sigma_2 \ll M_0 \times \frac{N_0}{p} \times p^2 \ll p^{5+4\eta}$$

and so from (32) we have

$$(41) \quad \Sigma_1 \ll \sqrt{N_0} \times p^{\frac{5}{2}+2\eta} = p^{3+3\eta}$$

**Case 2.** For the case  $\ell \equiv 0 \pmod{p}$  and  $\ell \neq 0$ , changing the variables  $\ell \mapsto p\ell$ , the character sum becomes

$$\begin{aligned} \mathcal{A} &= p \sum_{a_2 \pmod{p}}^* \sum_{a_3 \pmod{p}}^* \sum_{a_1 \pmod{p}}^* e\left(\frac{\overline{a_1}(u + \overline{a_2}u + \overline{a_3}u') - \overline{a_1}(\overline{1 + a_2 + a_3})u'}{p}\right) \\ &= p \sum_{a_2 \pmod{p}}^* \sum_{a_3 \pmod{p}}^* (1 - p\mathbb{I}_{u + \overline{a_2}u + \overline{a_3}u' - (\overline{1 + a_2 + a_3})u' \equiv 0 \pmod{p}}) \\ &= p(p^2 - p\mathbb{I}_{u \equiv 0 \pmod{p}} - p\mathbb{I}_{1 + \overline{a_2} + \overline{a_3} - (\overline{1 + a_2 + a_3}) \equiv 0 \pmod{p}}). \end{aligned}$$

Now for the case  $u \equiv 0 \pmod{p}$  we will save  $p$  so we will focus mainly on the last equation in which  $a_3$  can be determined by  $a_2$  so we have



$$\begin{aligned}
 & p \sum_{a_2 \bmod p}^* \sum_{a_3 \bmod p}^* \sum_{a_1 \bmod p}^* e \left( \frac{\overline{a_1}(u + \overline{a_2}u + \overline{a_3}u) - \overline{a_1}(\overline{1 + a_2 + a_3})u}{p} \right) \\
 &= p(p^2 - p\mathbb{I}_{u \equiv 0 \bmod p} - p(p-1)) \\
 &= p(-p\mathbb{I}_{u \equiv 0 \bmod p} + p) \ll p^2.
 \end{aligned}$$

Hence from (39) and using the partial summation formula along with the Ramanujan bound on average (2) we have

$$\Sigma_2 \ll \frac{N_0}{p} \times M_0 \times \frac{N_0}{p} \times p^2 \ll p^{5+6\eta}$$

and so from (32) we have

$$(42) \quad \Sigma_1 \ll \sqrt{N_0} \times p^{\frac{5}{2}+3\eta} = p^{3+4\eta}$$

**Case 3.** Now consider the case when  $\ell \not\equiv 0 \bmod p$ . For this case, the character sum can be written as follows.

$$\begin{aligned}
 \mathcal{A} &= \sum_{\beta \bmod p} S(u, -\beta; p) S(u, -\beta - \ell; p) S(u', -\beta; p) S(u', -\beta - \ell; p) \\
 &= p^2 \sum_{\beta \bmod p} \frac{S(1, -u\beta; p)}{\sqrt{p}} \frac{S(1, -u\beta - u\ell; p)}{\sqrt{p}} \frac{S(1, -u'\beta; p)}{\sqrt{p}} \frac{S(1, -u'\beta - u'\ell; p)}{\sqrt{p}} \\
 &= p^2 \sum_{0 \leq n < p} \cos(\theta_{p, f_1(n)}) \cos(\theta_{p, f_2(n)}) \cos(\theta_{p, f_3(n)}) \cos(\theta_{p, f_4(n)}),
 \end{aligned}$$

where

$$f_1(n) = -un, f_2(n) = -un - u\ell, f_3(n) = -u'n, f_4(n) = -u'n - u'\ell.$$

Here we note that  $u \not\equiv u' \bmod p$ ,  $u \not\equiv 0 \bmod p$ ,  $u' \not\equiv 0 \bmod p$ ,  $\ell \not\equiv 0 \bmod p$ . Then for  $r = 4$ ,  $k_i = 1$  we have from [5, Lemma 2.1]

$$(43) \quad \mathcal{A} \ll C(4)p^{5/2},$$

for some non-zero constant  $C(4)$ . So we need to take  $p > C(4)$ .

Hence, using the partial summation formula along with the Ramanujan bound on average (2) we have

$$(44) \quad \Sigma_1 \ll p^{3+4\eta} + p^{\frac{15}{4}+3\eta}.$$

So, from (31) and (44) we have

$$(45) \quad \Sigma_1 \ll p^{3+4\eta} + p^{\frac{15}{4}+3\eta} + p^{\frac{7}{2}+3\eta}.$$

Hence, from (29) we have

$$(46) \quad \begin{aligned} \Sigma_q &\ll \frac{N^{3/2} M_0^{1/2}}{L p^{\frac{5}{2}}} \left( p^{3+4\eta} + p^{\frac{15}{4}+3\eta} + p^{\frac{5}{2}+3\eta} \right)^{1/2} \\ &\ll \sqrt{N} \times \left( p^{\frac{3}{2}+\eta} + p^{\frac{15}{8}+\frac{\eta}{2}} + p^{\frac{5}{4}+\frac{\eta}{2}} \right). \end{aligned}$$

7.3. **Case 2.** Let  $d = q_1$  (or  $d = q_2$ ).

$$(47) \quad \begin{aligned} \Sigma_{q_1} &= \frac{N^{3/2}}{L p^{\frac{5}{2}}} \sum_{q \in \Phi} \frac{1}{q_2} \sum_{1 \leq n \ll N_0} \left( \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \right) \\ &\times \sum_{1 \leq r \ll \frac{M_0}{Q_1}} \frac{\lambda_f(p^2 n + q_1 r) \mathcal{I}(p^2 n + q_1 r, x, q; p)}{(p^2 n + q_1 r)^{1/4}} S(q_1 r, -n; p) \\ &\ll \frac{N^{3/2}}{L p^{\frac{5}{2}}} \sum_{q \in \Phi} \frac{1}{q_2} \sum_{1 \leq r \ll \frac{M_0}{Q_1}} \left| \right. \\ &\times \sum_{1 \leq n \ll N_0} \left( \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \right) \frac{\lambda_f(p^2 n + q_1 r) \mathcal{I}(p^2 n + q_1 r, x, q; p)}{(p^2 n + q_1 r)^{1/4}} S(q_1 r, -n; p) \left. \right| \\ &\ll \frac{N^{3/2}}{L p^{\frac{5}{2}}} \sum_{q_2 \in \Phi_2} \frac{1}{q_2} \sum_{Q_1 \leq r \ll M_0} \left| \right. \\ &\times \sum_{1 \leq n \ll N_0} \lambda_g(n) \frac{\mathcal{J}(n, x, q; p)}{n^{1/4}} \frac{\lambda_f(p^2 n + r) \mathcal{I}(p^2 n + r, x, q; p)}{(p^2 n + r)^{1/4}} S(r, -n; p) \left. \right|, \end{aligned}$$

where in the last line we have attached the variables  $q_1 r \mapsto r$ .

Now processing similarly as done for the above case we have that

$$(48) \quad \Sigma_{q_1} \ll \frac{N^{3/2} M_0^{1/2}}{L p^{\frac{5}{2}}} \left( p^{\frac{3}{2}+\eta} + p^{\frac{15}{8}+\frac{\eta}{2}} + p^{\frac{5}{4}+\frac{\eta}{2}} \right).$$

## 8. FURTHER COMPUTATION

From (27), (46), (48) and the error term we have that

$$\begin{aligned} \tilde{S}_{\neq 0}(N) &\ll \sqrt{N} \times \left( p^{\frac{3}{2}+\eta} + p^{\frac{15}{8}+\frac{\eta}{2}} + p^{\frac{5}{4}+\frac{\eta}{2}} + \frac{p^2}{p^\eta} \right) \\ &\ll \sqrt{N} \times \left( p^{\frac{3}{2}+\eta} + p^{\frac{15}{8}+\frac{\eta}{2}} + \frac{p^2}{p^\eta} \right). \end{aligned}$$

Now comparing the last two terms we have  $\eta = \frac{1}{12}$  and so

$$\tilde{S}_{\neq 0}(N) \ll \sqrt{N} \times p^{\frac{23}{12}}.$$

This gives the Theorem 1.

## 9. DETAILS FOR MAASS FORMS

Above we have considered that  $f, g$  are holomorphic cusp forms. Now instead of considering them as holomorphic cusp forms, if we take  $f$  (and /or  $g$ ) as Maass cusp form, then we need to go through some minor adjustments (starting from preliminaries in section 2) in the following sense:

- We need to adjust the gamma factors in the functional equation 2.1.1 accordingly (see [13, Chap. 5.11]) and also we need to adjust the weight functions with appropriate weight functions accordingly.
- We need to adjust the Voronoi summation formula stated in the Lemma 2.1.1 accordingly (see [17, Theorem A.4]). Also for the application of the Voronoi summation formula (see subsections 5.1 and 5.2), we need to adjust the Bessel functions accordingly with  $\pm$  sign introduced on each of the  $n$  and  $m$ -sums. Then we will continue with the rest of the arguments as 2.1.2 also holds for the other Bessel functions with appropriate weight functions  $W_k$ .
- The Ramanujan bound on average (2) that we have used for the Fourier coefficients  $\lambda_f(n)$  and  $\lambda_g(m)$  will be unchanged.
