SCHRODINGER BRIDGE OVER AVERAGED SYSTEMS

ABSTRACT. We consider a Schrödinger bridge problem where the Markov process is subject to parameter perturbations, forming an ensemble of systems. Our objective is to steer this ensemble from the initial distribution to the final distribution using controls robust to the parameter perturbations. Utilizing the path integral formalism, we demonstrate that the optimal control is a non-Markovian strategy, specifically a stochastic feedforward control, which depends on past and present noise. This unexpected deviation from established strategies for Schrödinger bridge problems highlights the intricate interrelationships present in the system's dynamics. From the perspective of optimal transport, a significant byproduct of our work is the demonstration that, when the evolution of a distribution is subject to parameter perturbations, it is possible to robustly deform the distribution to a desired final state using stochastic feedforward controls.

1. INTRODUCTION

This paper concerns the problem of conditioning a process at two endpoints. This problem was first studied by Schrödinger in [1]. For precision, we assume that all random variables are defined over an underlying probability space with probability \mathbb{P} . We postulate the Schrödinger bridge problem in its generality as follows; assume some *fully observed* particles distributed according to an initial probability measure $\mu_0 \in \mathcal{P}(\mathbb{R}^d)$ with density ρ_0 at time t = 0, evolve according to a process $\{y(t)\}_{0 \le t \le t_f}$ in \mathbb{R}^d with transition density q. Then, according to the law of large numbers, the final density $P(\cdot, t_f)$ is determined by

$$P(x_f, t_f) = \int_{\mathbb{R}^d} q(0, x_0, t_f, x_f) \rho_0(x_0) dx_0.$$

Suppose that at time $t = t_f$ the observed particles are distributed according to $\mu_f \in \mathcal{P}(\mathbb{R}^d)$ with density ρ_f , where

$$\rho_f(x_f) \neq P(x_f, t_f).$$

Then, μ_f deviates from the law of large numbers. This means that our assumption of the process $\{y(t)\}_{0 \le t \le t_f}$ is inaccurate. The following question arises:

(1) What density \hat{q} satisfies

$$\rho_f(x_f) = \int_{\mathbb{R}^d} \hat{q}(0, x_0, t_f, x_f) \rho_0(x_0) dx_0.$$

(2) Among such densities \hat{q} , which one is closest to q in some suitable sense.

Statement 1 and 2 constitute the Schrödinger bridge problem and the most likely stochastic process denoted as $\{x(t)\}_{0 \le t \le t_f}$ such that the distributions of x(0) and $x(t_f)$ coincide with μ_0 and μ_f , respectively, is called the Schrödinger bridge. The Schrödinger bridge problem reduces to finding the most likely probability law **P** of $x(\cdot)$ admitting the end-time marginals μ_0 and μ_f with densities ρ_0 and ρ_f , respectively [2–4]. More precisely the problem

(1.1)
$$\min_{\mathbf{P}} \mathbb{D}(\mathbf{P} \parallel \mathbf{R}) := \int_{\mathcal{X}} \log\left(\frac{d\mathbf{P}}{d\mathbf{R}}\right) d\mathbf{P}$$

where $\mathcal{X} := C([0, t_f]; \mathbb{R}^d)$ is the space of all continuous \mathbb{R}^d -valued paths on $[0, t_f]$, $\mathbf{R}(\cdot) = \mathbb{P}(y \in (\cdot))$ is the probability law of the process $\{y(t)\}_{0 \le t \le t_f}$ and the minimization is taken over the space of probability law \mathbf{P} of the process $\{x(t)\}_{0 \le t \le t_f}$ such that $\mathbf{P}_0(\cdot) := \mathbb{P}(x(0) \in$ $(\cdot)) = \mu_0(\cdot)$ and $\mathbf{P}_f(\cdot) := \mathbb{P}(x(t_f) \in (\cdot)) = \mu_f(\cdot)$, where $\mu_0, \mu_f \in \mathcal{P}(\mathbb{R}^d)$ have densities ρ_0 and ρ_f , respectively. Note that (1.1) well-defined if $\frac{d\mathbf{P}}{d\mathbf{R}}$ is the Radon-Nikodym derivative. By disintegrating the probability law \mathbf{P} , the Schrödinger problem reduces to the static problem:

(1.2)
$$\min_{\mathbf{P}_{0,f}\in\Pi(\mu_{0},\mu_{f})}\int_{\mathbb{R}^{d}\times\mathbb{R}^{d}}\log\left(\frac{d\mathbf{P}_{0,f}}{dq(0,\cdot,t_{f},\cdot)}\right)d\mathbf{P}_{0,f},$$

where

$$\Pi(\mu_0,\mu_f) := \{ \mathbf{P}_{0,f} \in \mathcal{P}(\mathbb{R}^d \times \mathbb{R}^d) : \mathbf{P}_{0,f} \circ \pi_0^{-1} = \mu_0 \quad \text{and} \quad \mathbf{P}_{0,f} \circ \pi_f^{-1} = \mu_f \},$$

where $\pi_0(x_0, x_f) = x_0$ and $\pi_f(x_0, x_f) = x_f$, for all $(x_0, x_f) \in \mathbb{R}^d \times \mathbb{R}^d$. Here, we have identified the densities and the measures are the same. Since (1.2) only makes sense whenever $\mathbf{P}_{0,f}$ is absolutely continuous with respect to q, for later use, the unique optimizer of (1.2) is characterized by

(1.3)
$$\mathbf{P}_{0,f}(A) = \int_{A} \phi_0(x_0) q(0, x_0, t_f, x_f) \phi_f(x_f) dx_0 dx_f,$$

for all measurable subset $A \subset \mathbb{R}^d \times \mathbb{R}^d$, where the pair (ϕ_0, ϕ_f) satisfies

(1.4)
$$\rho_0(x_0) = \phi_0(x_0) \int_{\mathbb{R}^d} q(0, x_0, t_f, x_f) \phi_f(x_f) dx_f,$$
$$\rho_f(x_f) = \phi_f(x_f) \int_{\mathbb{R}^d} q(0, x_0, t_f, x_f) \phi_0(x_0) dx_0.$$

For more details on the Schrödinger bridge problem and its equivalency with the optimal transport problem, we refer the reader to [3, 4] for instance.

In this paper, we study the following stochastic optimal control problem

(1.5) **Problem 1**:
$$\min_{u} \mathbb{E}\left[\int_{0}^{t_{f}} \frac{1}{2} \|u(t)\|^{2} dt\right],$$

subject to

(1.6)
$$dX(t,\theta) = (A(\theta)X(t,\theta) + B(\theta)u(t))dt + \sqrt{\epsilon}B(\theta)dW(t),$$
$$X(0,\theta) \sim \mu_0 \quad \text{and} \quad \int_0^1 X(t_f,\theta)d\theta \sim \mu_f.$$

Here $X(t,\theta) \in \mathbb{R}^d$ is the random state of an individual system at time t indexed by the sample point $\theta \in \Omega$, $A : \Omega \to \mathbb{R}^{d \times d}$ and $B : \Omega \to \mathbb{R}^{d \times m}$ are measurable mappings such that $||A|| := \sup_{\theta \in \Omega} ||A(\theta)|| < \infty$ and $||B|| := \sup_{\theta \in \Omega} ||B(\theta)|| < \infty$, where the norm here is the Frobenius norm on the space of matrices, $u \in L^2([0, t_f]; \mathbb{R}^m)$ is a *parameter-independent* control input. Our problem is motivated by ensemble-based Reinforcement Learning, see [18].

To relate Problem 1 to Schrödinger bridge (1.1)-(1.2), let

(1.7)
$$dY(t,\theta) = A(\theta)Y(t,\theta)dt + \sqrt{\epsilon}B(\theta)dW(t)$$
$$Y(0,\theta) = x_0$$

be the passive dynamics and \mathbf{R}_y the probability law induced by the averaged process $y(t) = \int_0^1 Y(t,\theta) d\theta$ characterized as

(1.8)
$$y(t) = \left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \sqrt{\epsilon} \int_0^t \Phi(t,\tau) dW(\tau),$$

where

(1.9)
$$\Phi(t_f,\tau) = \int_0^1 e^{A(\theta)(t_f-\tau)} B(\theta) d\theta.$$

Then the end-state transition density is characterized as (1.10)

$$q^{\epsilon,G}(0,x_0,t_f,x_f) = (2\pi\epsilon)^{-\frac{d}{2}} (\det(G_{t_f,0}))^{-\frac{d}{2}} \exp\left(-\frac{1}{2\epsilon} \left\| x_f - \left(\int_0^1 e^{A(\theta)t_f} d\theta\right) x_0 \right\|_{G_{t_f,0}^{-1}}^2\right),$$

where $\|x\|_{G_{t_f,0}^{-1}}^2 = x^{\mathrm{T}}G_{t_f,0}^{-1}x$, for all $x \in \mathbb{R}^d$, whenever

(1.11)
$$G_{t_f,0} := \int_0^{t_f} \Phi(t_f,\tau) \Phi(t_f,\tau)^{\mathrm{T}} d\tau$$

is invertible. We find another probability law \mathbf{P}_x , where $x(t) = \int_0^1 X(t,\theta) d\theta$, whose averaged drift and marginal constraint satisfy the averaged of (1.6). To this end, by adding and subtracting $\int_0^t \Phi(t,\tau)u(\tau)d\tau$ of (1.8), we have that

(1.12)
$$x(t) = \left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \int_0^t \Phi(t,\tau) (u(\tau)d\tau + \sqrt{\epsilon}d\tilde{W}(\tau)),$$

where

(1.13)
$$\tilde{W}(t) = W(t) - \int_0^t \frac{1}{\sqrt{\epsilon}} u(s) ds$$

Therefore, by Girsanov's Theorem (see [22, Chapter 8.6]), we have that the Radon-Nikodym derivative

(1.14)
$$\frac{d\mathbf{P}_x}{d\mathbf{R}_y} = \exp\bigg\{\int_0^{t_f} \frac{1}{\sqrt{\epsilon}} u(t) dW(t) + \int_0^{t_f} \frac{1}{2\epsilon} \|u(t)\|^2 dt\bigg\},$$

makes (1.13) a Brownian motion. By substituting (1.14) in (1.1), we get that

(1.15)
$$\mathbb{D}(\mathbf{P}_x \parallel \mathbf{R}_y) = \mathbb{E}\left[\int_0^{t_f} \frac{1}{2\epsilon} \|u(t)\|^2 dt\right].$$

Hence, problem (1.5)-(1.6) aims to find the most likely probability law induced by an *averaged* process that satisfies the end-time marginal. In terms of optimal transport (see [3,4,42,43]), problem (1.5)-(1.6) describes the deformation from μ_0 to μ_f , where the evolution is affected by both internal and external noise. The internal noise is modeled by parameter perturbation and the external noise is modeled by white noise.

Beyond the fact that in *all* the related works of Schrödinger bridge, one is often concerned with a single Markov process whereas here we deal with an ensemble of Markov processes [16, 17], complications arise since we require the control input to be robust or independent of the variations in the parameter $\theta \in [0, 1]$ of the system. Since the object to interest is the averaged or the expectation over the parameter $\theta \in [0, 1]$, this adds to the technical challenges of problem (1.5)-(1.6). In fact, the averaged stochastic process is a non-Markov Gaussian process (see [18]). This implies that standard stochastic control techniques [6–10, 19–22] and related references are not readily applicable due to the presence of memory. To overcome this issue, we rely on an approach that is "path-centric" rather than "process-centric". This leads us to a functional or path integral approach introduced in [23, 24]. Path integral technique for designing optimal Markov controls was first introduced by Kappen [25, 26] and later extended to other Markovian problems [27–30] and reference therein. To the best of our knowledge, there is no precedent for designing non-Markovian control strategies using the path integral formalism. This work is the first. However, conditional distributions for non-Markov process have been computed using path integrals [31–33].

More precisely, we design the optimal control for (1.5)-(1.6) as a functional integral. We show that the optimal control for (1.5)-(1.6) depends on the initial condition and the past and present noise. This type of control is known as stochastic feedforward control input [38, 39] and has applications in flight system control of robotics and crystal growth of power transmission networks (see [38–41] and reference therein). In terms of optimal transport framework, our result implies that if the evolution of an initial distribution is an ensemble of stochastic systems, then one can only deform from a given initial distribution to a final distribution along non-Markovian paths using stochastic feedforward controls. Our result unlike in [8–10], relies on the so-called averaged observability inequality [34–37] which is equivalent to the invertibility of the matrix (1.11) (see [15]).

The organization of the paper is as follows; To build intuition, we show that the optimal control that steers a single Markov process admits a functional integral approach in Section 2. Then we consider the problem (1.5)-(1.6) where μ_0 and μ_f are Dirac measures at specific points in Section 3. This Section aims to characterize optima local controls. The general case, where μ_0 and μ_f are absolutely continuous measures is discussed in Section 4. We represent the optimal control for problem (1.5)-(1.6) as a functional integral. We conclude with remarks on future work in Section 6.

2. Path Integral Representation of the Optimal Control for a single Markov process

To gain an intuition of the characterization of our original problem (1.5)-(1.6), we consider the special case $A(\theta) = A$. In this current case, let $x(t) := \int_0^1 X(t,\theta)d\theta$ be the averaged process. Then, we have that (1.5)-(1.6) reduces to (1.5) subject to the controlled Markov process

(2.1)
$$dx(t) = Ax(t)dt + Bu(t)dt + \sqrt{\epsilon}BdW(t),$$
$$x(0) \sim \mu_0 \quad \text{and} \quad x(t_f) \sim \mu_f,$$

where $B := \int_0^1 B(\theta) d\theta$. In this case, the invertibility of the matrix $G_{t_f,0}$ in (1.11) implies that the pair (A, B) is controllable. This Schrödinger bridge problem is the time-invariant version of the problems in [8–10]. Suppose $d\mu_0 = \rho_0 dx_0$ and $d\mu_f = \rho_f dx_f$. Then, since the end-point marginal densities ρ_0 and ρ_f are fixed, following from [4, 44], we have that that (1.5) subject to (2.1) is equivalent to:

(2.2)
$$\min_{u} \mathbb{E}\left[\int_{0}^{t_{f}} \frac{1}{2} \|u(t)\|^{2} dt - \log \phi_{f}(x(t_{f}))\right],$$

subject to

(2.3)
$$dx(t) = Ax(t)dt + Bu(t)dt + \sqrt{\epsilon}BdW(t),$$
$$x(0) = x_0.$$

Here ϕ_f together with ϕ_0 solves (1.4), where $q(0, x_0, t_f, x_f) = q^{\epsilon, G}(0, x_0, t_f, x_f)$ is the transition density of the passive dynamics

(2.4)
$$dy(t) = Ay(t)dt + \sqrt{\epsilon}BdW(t),$$
$$y(0) = x_0$$

conditioned that $y(t_f) = x_f$ a.s. This quantity is explicitly characterized as:

(2.5)
$$q^{\epsilon,G}(t,x,s,y) = (2\pi\epsilon)^{-\frac{d}{2}} (\det(G_{s,t}))^{-\frac{d}{2}} \exp\left(-\frac{1}{2\epsilon} \left\|y - (e^{A(s-t)})x\right\|_{G_{s,t}^{-1}}^2\right),$$

where $G_{s,t}$ defined in (1.11), with $A(\theta) = A$ and $B(\theta) = B$, is now the controllability Gramian, assumed invertible. We proceed to prove that the optimal control admits a functional integral approach.

Theorem 2.1. Let u^* be the unique optimal control for (2.2)-(2.3), then u^* admits the path integral formalism

(2.6)
$$u^*(t,x) = \int_{\mathbb{R}^d} u^*(t,x|t_f,x_f) p^*(t_f,x_f|t,x) dx_f,$$

where $u^*(\cdot|x_f)$ is the unique optimal control for the pinned process, that is (2.3) conditioned that at final time $t = t_f$, we have that $x(t_f) = x_f$ and optimality is measured by

(2.7)
$$\min_{u} \mathbb{E}\left[\int_{0}^{t_{f}} \frac{1}{2} \|u(t, x(t))\|^{2} dt\right]$$

and

(2.10)

(2.8)
$$p^*(t_f, x_f | t, x) = \frac{q^{\epsilon, G}(t, x, t_f, x_f)\phi_f(x_f)}{\int_{\mathbb{R}^d} q^{\epsilon, G}(t, x, t_f, x_f)\phi_f(x_f)dx_f},$$

where $q^{\epsilon,G}$ is in (2.5) and ϕ_f together with ϕ_0 solves

(2.9)
$$\rho_0(x_0) = \phi_0(x_0) \int_{\mathbb{R}^d} q^{\epsilon,G}(0,x_0,t_f,x_f) \phi_f(x_f) dx_f,$$
$$\rho_f(x_f) = \phi_f(x_f) \int_{\mathbb{R}^d} q^{\epsilon,G}(0,x_0,t_f,x_f) \phi_0(x_0) dx_0,$$

is the optimal controlled prior distribution.

Proof. Let \mathbf{P}^* be the optimal probability law induced the optimal unpinned process

$$dx(t) = Ax(t)dt + Bu^*(t, x(t))dt + \sqrt{\epsilon}BdW(t),$$

$$x(0) = x_0.$$

and ρ^* be the corresponding optimal controlled density. Consider the disintegration

(2.11)

Here, from (1.3), we have that $Q^*(x_f) = \phi_0(x_0)q^{\epsilon,G}(0, x_0, t_f, x_f)\phi_f(x_f)$ is the optimal final state density, $\mathbf{P}^*_{x_f}$ is the optimal probability law induced by the optimal pinned process

$$dx(t) = Ax(t)dt + Bu^*(t, x(t)|t_f, x_f)dt + \sqrt{\epsilon}BdW(t),$$

(2.12) $x(0) = x_0$ and $x(t_f) = x_f$.

where $u^*(\cdot|t_f, x_f)$, is the optimal conditional control. Here optimality is measured in (2.7). Let $\rho^*(\cdot|t_f, x_f)$ be the optimal conditional density corresponding to (2.12). Then, the controlled densities ρ^* and $\rho^*(\cdot|t_f, x_f)$ satisfy the Fokker-Planck equations:

(2.13)
$$\partial_t \rho^*(t,x) = -\nabla \cdot \left((x^{\mathrm{T}}A + u^{*\mathrm{T}}(t)B^{\mathrm{T}})\rho^*(t,x) \right) + \frac{\epsilon}{2} \sum_{ij} (BB^{\mathrm{T}})_{ij} \partial_{x_i x_j}^2 \rho^*(t,x)$$

and

$$(2.14) \\ \partial_t \rho^*(t, x|t_f, x_f) = -\nabla \cdot ((x^{\mathrm{T}}A + u^{*\mathrm{T}}(t, x|x_f)B^{\mathrm{T}})\rho^*(t, x|t_f, x_f)) + \frac{\epsilon}{2} \sum_{ij} (BB^{\mathrm{T}})_{ij} \partial_{x_i x_j}^2 \rho^*(t, x|t_f, x_f).$$

Furthermore, from (2.11) they are coupled through

$$\rho^*(t,x) = \int_{\mathbb{R}^d} \rho^*(t,x|t_f,x_f) Q^*(x_f) dx_f,$$

thus

(2.15)
$$\partial_t \rho^*(t,x) = \int_{\mathbb{R}^d} \partial_t \rho^*(t,x|t_f,x_f) Q^*(x_f) dx_f.$$

Therefore, from (2.13)-(2.15), we have that

$$u^{*\mathrm{T}}(t)B^{\mathrm{T}}\rho^{*}(t,x) = \int_{\mathbb{R}^{d}} u^{*\mathrm{T}}(t|x_{f})B^{\mathrm{T}}\rho^{*}(t,x|t_{f},x_{f})Q^{*}(x_{f})dx_{f}.$$

Thus,

(2.16)
$$u^*(t) = \int_{\mathbb{R}^d} u^*(t|x_f) p^*(t_f, x_f|t, x) dx_f,$$

where

$$p^{*}(t_{f}, x_{f}|t, x) = \frac{\rho^{*}(t, x|t_{f}, x_{f})Q^{*}(x_{f})}{\rho^{*}(t, x)}$$

is the optimal controlled prior distribution. Following from [45], the optimal controlled prior distribution $p^*(t_f, x_f | \cdot)$ is characterized as (2.8), where the optimality is measured with respect to the Kullback Leibler (KL) divergence with respect to the uncontrolled prior distribution of (2.4).

We proceed to verify this result with a well-known result in [10]. Following from [10] the optimal control for (1.5) subject to (2.1) is characterized as the Markov strategy:

(2.17)
$$u^*(t,x) = -\epsilon B^{\mathrm{T}} \nabla \log \varphi(t,x),$$

where

(2.18)
$$\varphi(t,x) = \int_{\mathbb{R}^d} q^{\epsilon,G}(t,x,t_f,x_f)\phi_f(x_f)dx_f$$

Since

$$\nabla \log \varphi(t, x) = \frac{\nabla \varphi(t, x)}{\varphi(t, x)},$$

from (2.17) and (2.18), we have that

(2.19)
$$u(t,x) = -\epsilon B^{\mathrm{T}} \int_{\mathbb{R}^d} \frac{\nabla q^{\epsilon,G}(t,x,t_f,x_f)\phi_f(x_f)}{\int_{\mathbb{R}^d} q^{\epsilon,G}(t,x,t_f,y)\phi_f(y)dy} dx_f$$

From (2.5), since

$$\nabla q^{\epsilon,G}(t,x,t_f,x_f) = \nabla \left(-\frac{1}{2\epsilon} \left\| x_f - \left(e^{A(t_f-t)} \right) x \right\|_{G_{t_f,t}^{-1}}^2 \right) q(t,x,t_f,x_f)$$
$$= \frac{1}{\epsilon} e^{A^{\mathrm{T}}(t_f-t)} G_{t_f,t}^{-1} \left(\left(e^{A(t_f-t)} \right) x - x_f \right) q(t,x,t_f,x_f),$$

from (2.19), we have that

(2.20)
$$u^{*}(t,x) = \int_{\mathbb{R}^{d}} u^{*}(t,x|t_{f},x_{f}) \left(\frac{q^{\epsilon,G}(t,x,t_{f},x_{f})\phi_{f}(x_{f})}{\int_{\mathbb{R}^{d}} q^{\epsilon,G}(t,x,t_{f},y)\phi_{f}(y)dy}\right) dx_{f},$$

where

(2.21)
$$u^{*}(t, x|t_{f}, x_{f}) := -B^{\mathrm{T}}e^{A^{\mathrm{T}}(t_{f}-t)}G^{-1}_{t_{f},t}\left(\left(e^{A(t_{f}-t)}\right)x - x_{f}\right)$$
$$= -B^{\mathrm{T}}P(t)^{-1}\left(x - \left(e^{A(t-t_{f})}\right)x_{f}\right).$$

Here

(2.22)
$$P(t)^{-1} := e^{-A^{\mathrm{T}}(t-t_f)} G_{t_f,t}^{-1} e^{-A(t-t_f)}$$

and one can check that $P(t) := e^{A(t-t_f)}G_{t_f,t}e^{A^{\mathrm{T}}(t-t_f)}$ is the Lyapunov function that satisfies

(2.23)
$$\frac{dP(t)}{dt} = AP(t) + P(t)A^T - BB^T$$

subject to $P(t_f) = 0$. Therefore, from [8, Section V]), we have that (2.21) is the unique optimal control for (1.5) subject to (2.1) where $\mu_f = \delta_{x_f}$ is the Dirac measure.

Therefore, from (2.20) and (2.8), we have that

(2.24)
$$u^{*}(t,x) = \int_{\mathbb{R}^{d}} u^{*}(t,x|t_{f},x_{f})p^{*}(t_{f},x_{f}|t,x)dx_{f}$$

This verifies the result.

Remark 2.1. Since the optimal control in (2.6) is represented as the expectation of optimal local control, where the expectation is over sample paths of uncontrolled process (2.4), the representation in (2.6) is "path-centric", rather than the "process-centric" in (2.17). The advantage of this "path-centric" representation is that it sidesteps the Markov/non-Markov distinction and represents a more general framework of optimal control. Thus, the path integral method can be generalized to non-Markovian processes [31–33].

3. Stochastic Bridge of Dirac measures

We will represent the optimal control for (1.5)-(1.6) as the functional integral of local controls. This Section aims to provide the characterization of optimal local controls. To this end, consider an ensemble of processes governed by (1.7). Our goal is to find solutions that are conditioned to have

(3.1)
$$\int_0^1 Y(t_f, \theta) d\theta = x_f, a.s.$$

The fact that the final conditional state is parameter-independent motivates the quest to find a parameter-independent control. If the control depends on $\theta \in [0, 1]$, it might lead to different behaviours for different realizations, making it challenging to ensure that (3.1) is satisfied a.s.

Following from [6,7], the solutions of (1.7) conditioned to be (3.1) is characterized by the stochastic optimal control problem

(3.2) **Problem 2**:
$$\min_{u \in \mathcal{U}} \mathbb{E}\left[\int_0^{t_f} \frac{1}{2} \|u(t)\|^2 dt\right],$$

subject to

(3.3)
$$dX(t,\theta) = A(\theta)X(t,\theta)dt + B(\theta)u(t)dt + \sqrt{\epsilon}B(\theta)dW(t),$$
$$X(0,\theta) = x_0 \text{ a.s and } \int_0^1 X(t_f,\theta)d\theta = x_f, a.s.$$

To be more precise, if $u \in \mathcal{U} \subset L^2([0, t_f]; \mathbb{R}^m)$, then;

- (1) u(t) is x(t)-measurable, where $x(t) := \int_0^1 X(t,\theta) d\theta$, for all $t \in [0, t_f]$,
- (2) $\mathbb{E}\left[\int_0^{t_f} \frac{1}{2} \|u(t)\|^2 dt\right] < \infty,$

We proceed to the main theorem of this Section.

Theorem 3.1. Suppose $G_{t_f,s}$, for all $0 \le s < t_f$, in (1.11) is invertible. Then the optimal control for (3.2) subject to (3.3) is characterized as

(3.4)
$$u^*(t|x_0, x_f) = -\sqrt{\epsilon} \int_0^t \Phi(t_f, t)^T G_{t_f, \tau}^{-1} \Phi(t_f, \tau) dW(\tau) + \Phi(t_f, t)^T G_{t_f, 0}^{-1} \left(x_f - \left(\int_0^1 e^{A(\theta)t_f} d\theta \right) x_0 \right).$$

where $\Phi(t_f, \tau)$ is defined in (1.9).

We see that the characterization of the local optimal control is a departure from the conventional stochastic optimal control literature, where the optimal control assumes the form of a Markov strategy [20, 22]. In particular, when dealing with a non-Markov process subject to parameter perturbations, the optimal control depends on the initial condition and

the entire history of the noise. For this reason, the optimal control that steers the stochastic bridge adopts an approach—a stochastic feedforward input, to be precise.

Remark 3.1. Before we delve into the proof of Theorem (3.1), we must verify the result with the special case $A(\theta) = A$. In this case the problem of requiring the behaviour of

(3.5)
$$dy(t) = Ay(t)dt + \sqrt{\epsilon}BdW(t),$$
$$y(0) = x_0, \quad almost \ surely \ (a.s),$$

where $y(t) = \int_0^1 Y(t,\theta) d\theta$ is the averaged process and $B = \left(\int_0^1 B(\theta) d\theta\right)$, at the final time to be $x(t_f) = x_f$ a.s is equivalent to optimally changing the drift in

(3.6)
$$dx(t) = Ax(t)dt + Bu(t)dt + \sqrt{\epsilon B}dW(t),$$
$$x(0) = x_0 \quad and \quad x(t_f) = x_f \quad a.s,$$

where optimality is measured in (3.2). From (2.21)-(2.22), the optimal pinned local control is characterized as

(3.7)
$$u^*(t, x(t)|x_f) = -B^{\mathrm{T}} e^{-A^{\mathrm{T}}(t-t_f)} G_{t_f, t}^{-1} e^{-A(t-t_f)} x(t) + B^{\mathrm{T}} e^{-A^{\mathrm{T}}(t-t_f)} G_{t_f, t}^{-1} x_f$$

By substituting the above optimal pinned control to (3.6), we get the optimal pinned process to be

$$dx^{*}(t) = (A - BB^{\mathrm{T}}e^{-A^{\mathrm{T}}(t-t_{f})}G^{-1}_{t_{f},t}e^{-A(t-t_{f})})x^{*}(t)dt + B^{\mathrm{T}}e^{-A^{\mathrm{T}}(t-t_{f})}G^{-1}_{t_{f},t}x_{f}dt + \sqrt{\epsilon}BdW(t)$$
(3.8)

$$x(0) = x_0.$$

This solution $x^*(t)$ is substituted back in (3.7) and we demonstrate it coincides with the characterization in (3.4). Due to the heavy computation, we demonstrate this for $A(\theta) = A = 0$. Then from (1.11), we have that $G_{t_f,\tau} = (t_f - \tau)BB^{\mathrm{T}}$ and from (1.9), we have that $\Phi(t_f, t) = B \in \mathbb{R}^{d \times d}$, for all $t \geq t_f$ is invertible. Therefore, the optimal local control in (3.7) and the corresponding optimal state trajectory in (3.8) reduces to

(3.9)
$$u^*(t, x(t)|x_f) = -\frac{B^{-1}}{t_f - t}(x(t) - x_f)$$

and

$$dx^*(t) = \left(-\frac{x^*(t)}{t_f - t} + \frac{x_f}{t_f - t}\right)dt + \sqrt{\epsilon}BdW(t),$$

(3.10) $x(0) = x_0 \quad a.s$

respectively. Since

$$x^*(t) = \frac{t_f - t}{t_f} x_0 + \frac{t}{t_f} x_f + \sqrt{\epsilon} \int_0^t \frac{t_f - t}{t_f - \tau} B dW(\tau),$$

by substituting $x^*(t)$ in (3.9) we have that

$$u^{*}(t|x_{0}, x_{f}) = -\frac{B^{-1}}{t_{f} - t} \left(\frac{t_{f} - t}{t_{f}} x_{0} + \frac{t - t_{f}}{t_{f}} x_{f} + \sqrt{\epsilon} \int_{0}^{t} \frac{t_{f} - t}{t_{f} - \tau} B dW(\tau) \right)$$

and hence

$$u^*(t|x_0, x_f) = -\sqrt{\epsilon} \int_0^t \frac{1}{t_f - \tau} dW(\tau) + \frac{B^{-1}}{t_f} (x_f - x_0).$$

This coincides with the proposed characterization (3.4) for the simple case.

3.1. **Proof of Theorem 3.1.** Note that re-centring the initial ensemble $X(0, \theta)$ of systems at the origin 0 holds no bearing on the system's characterization, given its inherent linearity. For simplicity, from now on we take $X(0, \theta) = 0$ a.s.

We outline the proof of Theorem 3.1 as follows: We first state a free-endpoint alternative formulation (cf. (3.11)-(3.12)) and consider the corresponding time discretization (cf. (3.13)-(3.14)). The characterization in (3.4) is derived from the solution of the discretized free-endpoint alternative formulation. The technique of considering an alternative free-endpoint stochastic optimal control is motivated by [8, 19–21].

Following from [18], since the averaged process in (1.12) is non-Markovian, we circumvent this complexity considering

(3.11)
$$\min_{u} \mathbb{E}\left[a(x(t_f) - x_f)^T (x(t_f) - x_f) + \int_0^{t_f} \frac{1}{2} \|u_a(t)\|^2 d\tau\right]$$

subject to

(3.12)
$$x(t) = \int_0^t \Phi(t,\tau)(u_a(\tau)d\tau + \sqrt{\epsilon}dW(\tau))$$

The main idea of the above formulation is that if

$$\lim_{a \to \infty} \|u_a^* - u^*\|_{L^2(\mathbb{P})}^2 = 0,$$

holds, where \mathbb{P} is the probability on the sample space Ω . Then u^* is the optimal control for (3.2)-(3.3). The following result is important to design the optimal control u_a^* for (3.11)-(3.12).

Proposition 3.1. Consider the discrete-time optimal control problem

(3.13)
$$\min_{u_{a,k}} \mathbb{E} \bigg[a(x_k - x_f)^T (x_k - x_f) + \frac{1}{2} \sum_{i=0}^{k-1} u_{a,k,i}^T u_{a,k,i} \Delta t_k \bigg],$$

where a > 0 and

(3.14)
$$x_k = \sum_{i=0}^{k-1} \Phi(t_f, t_i) \left(u_{a,k,i} \triangle t_k + \sqrt{\epsilon} \triangle W_i \right).$$

Here $P := \{0 = t_0 < t_1 < \cdots < t_{k-1} = t_f\}$ be a regular partition with constant step size $\Delta t_k = t_{i+1} - t_i, \ \Delta W_i := W(t_{i+1}) - W(t_i) \in \mathbb{R}^m, \ u_{a,k} := (u_{a,k,0}, \ldots, u_{a,k,k-1}) \in \mathbb{R}^{mk}$, where we assume that $u_{a,k,i}$ is constant x_i -measurable in $L^2[t_i, t_{i+1})$, where $i \in \{0, \ldots, k-1\}$. Then the optimal control for (3.13)- (3.14) is characterized as

$$(3.15) \quad u_{a,k,i}^* = -\sqrt{\epsilon} \sum_{j=0}^i \Phi(t_f, t_i)^T (\sum_{\alpha=j}^{k-1} \Phi(t_f, t_\alpha) \Phi(t_f, t_\alpha)^T \triangle t_k + \frac{1}{2a} I_n)^{-1} \\ \Phi(t_f, t_j) \triangle W_j + \Phi(t_f, t_i)^T (\sum_{\alpha=0}^{k-1} \Phi(t_f, t_\alpha) \Phi(t_f, t_\alpha)^T \triangle t_k + \frac{1}{2a} I_n)^{-1} x_f.$$

Proof. To facilitate the upcoming proof, we'll adopt a convention: unless otherwise specified, we'll represent block matrices using uppercase letters.

We are confronted with a discrete-time problem (3.13)-(3.14) which we condense into a more manageable form:

(3.16)
$$\min_{u_{a,k}} J_k(u_{a,k}) := \mathbb{E}\left[a \operatorname{Tr}\left((x_k - x_f)(x_k - x_f)^T\right) + \frac{\Delta t_k}{2} \operatorname{Tr}\left(u_{a,k}u_{a,k}^T\right)\right],$$

subject to

(3.17)
$$x_k = \Phi_k \left(u_{a,k} \triangle t_k + \sqrt{\epsilon} \gamma_k \right),$$

where $\gamma_k = (\Delta W_0, \ldots, \Delta W_{k-1}) \in \mathbb{R}^{mk}$ and $\Phi_k = (\Phi_0(t_f), \ldots, \Phi_{k-1}(t_f)) \in \mathbb{R}^{d \times mk}$, where $\Phi_i(t_f) := \Phi(t_f, t_i) \in \mathbb{R}^{d \times m}$ in (1.9). Since $u_{a,k,i}$ is constant x_i -measurable, for all $i = 0, \ldots, k-1$, it is characterized as

(3.18)
$$u_{a,k,i} = \sum_{j=0}^{i} F_{k,i,j} \triangle W_j + G_{i,k-1} x_f,$$

where $F_{k,i,j} \in \mathbb{R}^{m \times m}$ and $G_{i,k-1} \in \mathbb{R}^{m \times d}$ are to be determined. Specifically, $F_{k,i,j} := F(t_i, t_j) \in \mathbb{R}^{m \times m}$, for all $t_j < t_i$, and $G_{i,k-1} := G(t_i, t_{k-1}) \in \mathbb{R}^{m \times d}$. For later use, we express (3.18) compactly as:

(3.19)
$$u_{a,k} = \mathbf{F}_k \gamma_k + \mathbf{G}_k \operatorname{vec}(x_f),$$

where $\operatorname{vec}(x_f) \in \mathbb{R}^{dk}$ is the vector with all its entries $x_f \in \mathbb{R}^d$, the block matrices $F_k \in \mathcal{T}_{mk}$ and $G_k \in \mathcal{M}_{mk}$ where

$$\mathcal{T}_{mk} := \{ \mathbf{F}_k \in \mathbb{R}^{mk \times mk} : \chi_{mk} \odot \mathbf{F}_k = \mathbf{0}_{mk} \},\$$

and

$$\mathcal{M}_{mk} := \{ \mathbf{G}_k \in \mathbb{R}^{mk \times dk} : \Gamma_{mk} \odot \mathbf{G}_k = \mathbf{0}_{mk} \}.$$

Here, $0_{mk} \in \mathbb{R}^{mk \times mk}$ is the zero matrix, χ_{mk} is the indicator matrix defined as:

(3.20)
$$\chi_{mk} := \begin{cases} \mathbb{1}_m & \text{if } i < j \\ 0_m & \text{otherwise,} \end{cases}$$

where $\mathbb{1}_m \in \mathbb{R}^{m \times m}$ is the matrix where all entries are 1s. Similarly, Γ_{mk} is defined as:

(3.21)
$$\Gamma_{mk} := \begin{cases} \mathbb{1}_{m \times d} & \text{if } j \neq k-1 \\ 0_{m \times d} & \text{if } j = k-1 \end{cases}$$

with all its entries in the last column set to $0_{m \times d} \in \mathbb{R}^{m \times d}$, which represents the zero matrix. All other entries are assigned the block matrix $\mathbb{1}_{m \times d} \in \mathbb{R}^{m \times d}$. The operation \odot denotes the Hadamard matrix multiplication operation. By substituting (3.19) in (3.17), we arrive at

(3.22)
$$x_k = \Phi_k \left(\mathbf{F}_k \triangle t_k + \sqrt{\epsilon} \mathbf{I}_{mk} \right) \gamma_k + \Phi_k \mathbf{G}_k \operatorname{vec}(x_f) \triangle t_k.$$

Here, $I_{mk} \in \mathbb{R}^{mk \times mk}$ represents the identity matrix. Subsequently, by substituting (3.19) and (3.22) back into (3.16) and using the fact that $\mathcal{T}_{mk} \cap \mathcal{M}_{mk} = \emptyset$, we have two separate strictly convex subproblems

(3.23)
$$\min_{\mathbf{G}_k \in \mathcal{M}_{mk}} \operatorname{Tr} \left(a \left(\Phi_k \mathbf{G}_k \operatorname{vec}(x_f) \Delta t_k - x_f \right) \left(\Phi_k \mathbf{G}_k \operatorname{vec}(x_f) \Delta t_k - x_f \right)^T + \frac{\Delta t_k}{2} \mathbf{G}_k \operatorname{vec}(x_f) \operatorname{vec}(x_f)^T \mathbf{G}_k^T \right)$$

and

(3.24)
$$\min_{\mathbf{F}_k \in \mathcal{T}_{mk}} \operatorname{Tr} \left(a \Phi_k \left(\mathbf{F}_k \triangle t_k + \sqrt{\epsilon} \mathbf{I}_{mk} \right) \left(\mathbf{F}_k \triangle t_k + \sqrt{\epsilon} \mathbf{I}_{mk} \right)^T \Phi_k^T \triangle t_k + \frac{(\triangle t_k)^2}{2} \mathbf{F}_k \mathbf{F}_k^T \right)$$

over compact sets. Hence the standard Lagrange method (see [46]) gives the unique solution.

For problem (3.23), this necessitates the introduction of a Lagrange multiplier, denoted as $\lambda_k \in \mathbb{R}^{mk \times mk}$, such that the pair (G_k, λ_k) satisfy the first-order conditions:

$$\Gamma_{mk} \odot \lambda_k + 2a\Phi_k^T \Phi_k \mathbf{G}_k \operatorname{vec}(x_f) \operatorname{vec}(x_f)^T (\Delta t_k)^2 - 2a\Phi_k^T x_f \operatorname{vec}(x_f)^T \Delta t_k + \mathbf{G}_k \operatorname{vec}(x_f) \operatorname{vec}(x_f)^T \Delta t_k = 0_{mk}$$

and

$$\Gamma_{mk} \odot \mathbf{G}_k = \mathbf{0}_{mk}$$

Hence, we have that

(3.25)
$$G_k^* \operatorname{vec}(x_f) \operatorname{vec}(x_f)^T = 2a \left(I_{mk} - \Phi_k^T A_k \Phi_k \triangle t_k \right) \left(\Phi_k^T x_f \operatorname{vec}(x_f)^T - \Gamma_{mk} \odot \frac{\lambda_k}{2a(\triangle t_k)} \right)$$

and

(3.26)
$$\Gamma_{mk} \odot \left(\left(\mathbf{I}_{mk} - \Phi_k^T A_k \Phi_k \triangle t_k \right) \left(\Phi_k^T x_f \operatorname{vec}(x_f)^T - \Gamma_{mk} \odot \frac{\lambda_k}{2a(\triangle t_k)} \right) \right) = 0_{mk},$$

where

$$A_k = \left(\Phi_k \Phi_k^T \triangle t_k + \frac{1}{2a} \mathbf{I}_{dk}\right)^{-1}$$
$$= \left(\sum_{\alpha=0}^{k-1} \Phi_\alpha(t_f) \Phi_\alpha(t_f)^T \triangle t_k + \frac{1}{2a} \mathbf{I}_{dk}\right)^{-1}.$$

By computing $\frac{\lambda_k}{2a(\Delta t_k)}$ in (3.26) and substituting in (3.25), we get that

(3.27)
$$G_{i,k-1}^* = \Phi(t_f, t_i)^T \left(\sum_{\alpha=0}^{k-1} \Phi(t_f, t_\alpha) \Phi(t_f, t_\alpha)^T \Delta t_k + \frac{1}{2a} I_n\right)^{-1}.$$

Similarly, for problem (3.24), without repeating arguments, one can show that for $i \ge j$ and j > 0, the following characterization holds:

(3.28)
$$F_{k,i,j}^* = -\sqrt{\epsilon} \Phi(t_f, t_i)^T \left(\sum_{\alpha=j}^{k-1} \Phi(t_f, t_\alpha) \Phi(t_f, t_\alpha)^T \triangle t_k + \frac{1}{2a} I_n\right)^{-1} \Phi(t_f, t_j).$$

Therefore, from (3.18), (3.27) and (3.28), we have that the optimal control for (3.13)- (3.14) is (3.15). \Box

We now proceed to the proof of Theorem 3.1.

Proof of Theorem 3.1. From (3.15), and [22, Definition 3.1.6 and Corollary 3.1.8], we conclude that

$$\lim_{a\to\infty}\lim_{k\to\infty}\|u^*_{a,k,i}-u^*\|^2_{L^2(\mathbb{P})}=0,$$

where

$$u^{*}(t|x_{f}) = -\sqrt{\epsilon} \int_{0}^{t} \Phi(t_{f}, t)^{T} G_{t_{f}, \tau}^{-1} \Phi(t_{f}, \tau) dW(\tau) + \Phi(t_{f}, t)^{T} G_{t_{f}, 0}^{-1} x_{f}.$$

By translating the averaged process in (1.12), given any arbitrary x_0 , the optimal control is characterized as

(3.29)
$$u^*(t|x_0, x_f) = -\sqrt{\epsilon} \int_0^t \Phi(t_f, t)^T G_{t_f, \tau}^{-1} \Phi(t_f, \tau) dW(\tau) + \Phi(t_f, t)^T G_{t_f, 0}^{-1} \left(x_f - \left(\int_0^1 e^{A(\theta)t_f} d\theta \right) x_0 \right).$$

This highlights the fact that optimal local controls depend also on the initial condition $X(0, \theta) = x_0$ and the entire history of noise.

4. General Case

We are now ready to characterize the optimal control for (1.5) subject to (1.6).

Theorem 4.1. Suppose $G_{t_f,t}$, for all $0 \le t < t_f$ defined in (1.11) is invertible. Let u^* be the optimal control for (1.5) subject to (1.6) then

(4.1)
$$u^*(t|x_0) = \int_{\mathbb{R}^d} u^*(t|x_0, x_f) p^*(t_f, x_f|0, x_0, t) dx_f,$$

where $u^*(t|x_0, x_f)$ is characterized in (3.29) and

(4.2)
$$p^*(t_f, x_f | 0, x_0, t) = \frac{\hat{q}^{\epsilon, G}(0, x_0, t, t_f, x_f)\phi_f(x_f)}{\int_{\mathbb{R}^d} \hat{q}^{\epsilon, G}(0, x_0, t, t_f, y)\phi_f(y)dy}$$

is the optimal prior distribution where

(4.3)
$$\hat{q}^{\epsilon,G}(0, x_0, t, t_f, y) = (2\pi\epsilon)^{-\frac{d}{2}} (\det(G_{t_f,t}))^{-\frac{d}{2}} \exp\left(-\frac{1}{2\epsilon} \left\| y - \left(\int_0^1 e^{A(\theta)t_f} d\theta\right) x_0 - \sqrt{\epsilon} \int_0^t \Phi(t_f, \tau) dW(\tau) \right\|_{G_{t_f,t}^{-1}}^2\right),$$

is the conditional transition density of (1.8) and ϕ_f together with ϕ_0 solves (2.9) with endstate transition density (1.10).

Before we provide the proof, note that if $A(\theta) = A$ then, from [18], we have that y(t), where $0 \le t \le t_f$, in (1.8) is a Markov process. This implies that at time $t = t_f$, we have that $y(t_f)$ only depends on y(t). Therefore, we have that $y(t_f)$ given that y(t) = x is characterized as

$$y(t_f) = e^{A(t_f - t)} x + \sqrt{\epsilon} \int_t^{t_f} \Phi(t_f, \tau) dW(\tau)$$

and hence the associated conditional transition density (4.3) reduces to the Markov density in (2.5).

We highlight the distinction between the above result and Theorem 2.1. While the sample paths in Theorem 2.1 exhibit Markov property, the sample paths in Theorem 4.1 depend on the entire history of the noise and the initial condition. Therefore, the optimal control in (4.1) is a stochastic feedforward control input.

Proof. We first show that the functional integral

(4.4)
$$u^*(t,x|x_0) = \int_{\mathbb{R}^d} u^*(t|x_0,x_f) p^*(t_f,x_f|0,x_0,t,x) dx_f$$

holds, where $u^*(t|x_0, x_f)$ is characterized in (3.29) and then provide a characterization for $p^*(t_f, x_f|0, x_0, t, x)$. Let u^* be the optimal control for (1.5) subject to (1.6). Then, u^* is the

optimal control for the alternative formulation (2.2) subject to

(4.5)
$$dX(t,\theta) = A(\theta)X(t,\theta)dt + B(\theta)u(t)dt + \sqrt{\epsilon}B(\theta)dW(t),$$
$$X(0,\theta) = x_0.$$

Here ϕ_f together with ϕ_0 solves (2.9), where $q^{\epsilon,G}(0, x_0, t_f, x_f)$ is the end-state transition density of the passive dynamics (1.7) and is characterized in (1.10). Let

(4.6)
$$x^*(t|x_0) = \left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \int_0^t \Phi(t,\tau) (u^*(\tau|x_0) d\tau + \sqrt{\epsilon} dW(\tau)),$$

where $\Phi(t,\tau)$ is defined in (1.9) be the optimal averaged process of (4.5) induced by the optimal control u^* . Then, the optimal sample path $x^*(\cdot|x_0)$ induced an optimal probability law $\mathsf{P}^*(\cdot)$ on \mathcal{X} which we disintegrate into

(4.7)
$$\mathsf{P}^*(\cdot) = \int_{\mathbb{R}^d} \mathsf{P}^*_{x_f}(\cdot) Q^*(x_f) dx_f$$

Here, $\mathsf{P}_{x_f}^*(\cdot)$ is the optimal probability law induced by the optimal pinned sample path $x^*(\cdot|x_0, x_f)$, characterized as

(4.8)
$$x^*(t|x_0, x_f) = \left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \int_0^t \Phi(t, \tau) (u^*(\tau|x_0, x_f) d\tau + \sqrt{\epsilon} dW(\tau)),$$

for all $t \in [0, t_f]$, with $u^*(t|x_0, x_f)$ in (3.29). From (1.3), we have that $Q^*(x_f) = \phi_0(x_0)q^{\epsilon,G}(0, x_0, t_f, x_f)\phi_f(x_f)$ is the optimal final state density with $q^{\epsilon,G}(0, x_0, t_f, x_f)$ in (1.10).

Let $\rho^*(\cdot|x_0)$ and $\rho(\cdot|x_0, x_f)$ be their corresponding optimal controlled density of the processes (4.6) and (4.8), respectively. Since both processes $x^*(t|x_0)$ and $x^*(t|x_0, x_f)$ in (4.6) and (4.8), respectively, are Gaussian processes with means

$$\left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \mathbb{E} \int_0^t \Phi(t,\tau) u^*(\tau|x_0) d\tau$$

and

$$\left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \mathbb{E} \int_0^t \Phi(t,\tau) u^*(\tau|x_0,x_f) d\tau$$

respectively, and covariance matrix $\epsilon G_{t,0}$, we have that

(4.9)
$$\rho^*(t, x | x_0) = (2\pi\epsilon)^{-\frac{d}{2}} (\det(G_{t,0}))^{-\frac{d}{2}} \exp\left(-\frac{1}{2\epsilon} \left\| x - \left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \mathbb{E} \int_0^t \Phi(t, \tau) u^*(\tau | x_0) d\tau \right\|_{G_{t,0}^{-1}}^2\right)$$

and

(4.10)
$$\rho^*(t, x | x_0, x_f) = (2\pi\epsilon)^{-\frac{d}{2}} (\det(G_{t,0}))^{-\frac{d}{2}} \exp\left(-\frac{1}{2\epsilon} \left\| x - \left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \mathbb{E} \int_0^t \Phi(t, \tau) u^*(\tau | x_0, x_f) d\tau \right\|_{G_{t,0}^{-1}}^2 \right).$$

From (4.7), since the densities are coupled through

(4.11)
$$\rho^*(t, x | x_0) = \int_{\mathbb{R}^d} \rho^*(t, x | x_0, x_f) Q^*(x_f) dx_f$$

for all t, x, we have that

$$\nabla \rho^*(t, x | x_0) = \int_{\mathbb{R}^d} \nabla \rho^*(t, x | x_0, x_f) Q^*(x_f) dx_f$$

hold, for all t, x. From (4.9) and (4.10) the above equation reduces to

(4.12)
$$m(x,t|x_0)\rho^*(t,x|x_0) = \int_{\mathbb{R}^d} m(x,t|x_0,x_f)\rho^*(t,x|x_0,x_f)Q^*(x_f)dx_f,$$

where

$$m(x,t|x_0) := x - \left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \mathbb{E} \int_0^t \Phi(t,\tau) u^*(\tau|x_0) d\tau$$

and

$$m(x,t|x_0,x_f) := x - \left(\int_0^1 e^{A(\theta)t} d\theta\right) x_0 + \mathbb{E} \int_0^t \Phi(t,\tau) u^*(\tau|x_0,x_f) d\tau.$$

Using (4.11), we have that (4.12) reduces to

$$\mathbb{E} \int_{0}^{t} \Phi(t,\tau) u^{*}(\tau|x_{0}) d\tau \rho^{*}(t,x|x_{0}) = \int_{\mathbb{R}^{d}} \left(\mathbb{E} \int_{0}^{t} \Phi(t,\tau) u^{*}(\tau|x_{0},x_{f}) d\tau \right) \rho^{*}(t,x|x_{0},x_{f}) Q^{*}(x_{f}) dx_{f}$$
and hence

and hence

$$\int_0^t \Phi(t,\tau) \mathbb{E} \left(u^*(\tau|x_0) - \int_{\mathbb{R}^d} u^*(\tau|x_0, x_f) \frac{\rho^*(t, x|x_0, x_f) Q^*(x_f)}{\rho^*(t, x|x_0)} dx_f \right) d\tau = 0$$

holds, for all t, x. Therefore, we have that

(4.13)
$$\mathbb{E}\left(u^*(t,x|x_0) - \int_{\mathbb{R}^d} u^*(t,|x_0,x_f) \frac{\rho^*(t,x|x_0,x_f)Q^*(x_f)}{\rho^*(t,x|x_0)} dx_f\right) = 0.$$

Suppose that

$$u^{*}(t, x | x_{0}) \neq \int_{\mathbb{R}^{d}} u^{*}(t, | x_{0}, x_{f}) p^{*}(t_{f}, x_{f} | 0, x_{0}, t, x) dx_{f},$$

where

(4.14)
$$p^*(t_f, x_f|0, x_0, t, x) = \frac{\rho^*(t, x|x_0, x_f)Q^*(x_f)}{\rho^*(t, x|x_0)}$$

is the optimal prior distribution. Then, from (4.13), we have that

(4.15)
$$u^*(t, x|x_0) = \int_{\mathbb{R}^d} u^*(t, |x_0, x_f) p^*(t_f, x_f|0, x_0, t, x) dx_f + Z(t)$$

holds, where the process Z(t) has $\mathbb{E}(Z(t)) = 0$. By substituting (4.15) in (4.6) we get that

$$(4.16) \quad x^{*}(t|x_{0}) = \left(\int_{0}^{1} e^{A(\theta)t} d\theta\right) x_{0} + \sqrt{\epsilon} \int_{0}^{t} \Phi(t,\tau) dW(\tau) \\ + \int_{\mathbb{R}^{d}} \left(\int_{0}^{t} \Phi(t,\tau) u^{*}(\tau|x_{0},x_{f}) p^{*}(t_{f},x_{f}|0,x_{0},\tau,x) d\tau\right) dx_{f} + \int_{0}^{t} \Phi(t,\tau) Z(\tau) d\tau.$$

By comparing (4.8) to (4.16), the extra sample path $\int_0^{\cdot} \Phi(\cdot,\tau) Z(\tau) d\tau$ implies that P^{*} assumed in (4.7) is not the optimal probability law induced by (4.6) which is a contradiction. Therefore, we have that

$$u^*(t, x|x_0) = \int_{\mathbb{R}^d} u^*(t, |x_0, x_f) p^*(t_f, x_f|0, x_0, t, x) dx_f$$

holds.

We proceed to characterize the optimal controlled prior distribution $p^*(t_f, x_f | 0, x_0)$. From (1.8), since

$$(4.17) y(t_f) = \left(\int_0^1 e^{A(\theta)t_f} d\theta\right) x_0 + \sqrt{\epsilon} \int_0^{t_f} \Phi(t_f, \tau) dW(\tau), \\ = \left(\int_0^1 e^{A(\theta)t_f} d\theta\right) x_0 + \sqrt{\epsilon} \int_0^t \Phi(t_f, \tau) dW(\tau) + \sqrt{\epsilon} \int_t^{t_f} \Phi(t_f, \tau) dW(\tau),$$

given x_0 and $W(\tau)$, where $0 \leq \tau \leq t$, we have that $y(t_f)$ follows a Gaussian distribution with mean

$$\left(\int_0^1 e^{A(\theta)t_f} d\theta\right) x_0 + \sqrt{\epsilon} \int_0^t \Phi(t_f, \tau) dW(\tau)$$

and covariance $\epsilon G_{t_f,t}$, where $G_{t_f,t}$ is defined in (1.11). Hence, the conditional transition density for the passive averaged process y(t) in (1.8) is

$$(4.18) \quad q^{\epsilon,G}(0,x_0,t,t_f,y) = (2\pi\epsilon)^{-\frac{d}{2}} (\det(G_{t_f,t}))^{-\frac{d}{2}} \\ \exp\left(-\frac{1}{2\epsilon} \left\| y - \left(\int_0^1 e^{A(\theta)t_f} d\theta\right) x_0 - \sqrt{\epsilon} \int_0^t \Phi(t_f,\tau) dW(\tau) \right\|_{G^{-1}_{t_f,t}}^2\right),$$

This completes the proof. \Box

This completes the proof.

We present a systematic approach to deriving the optimal control for (1.5)-(1.6), as characterized in (4.1) in Algorithm 1 in 5 steps. The optimal control in Step 5 is specifically designed to effectively transition the averaged process corresponding to (1.6), described in (4.6), from an initial distribution μ_0 with density ρ_0 to a target distribution μ_f with density ρ_f (see Figure 7).

The ensemble of system

$$dX(t,\theta) = (A(\theta)X(t,\theta) + B(\theta)u(t))dt + \sqrt{\epsilon}B(\theta)dW(t)$$

Marginal densities

 $d\mu_0 = \rho_0 dx_0$ and $d\mu_f = \rho_f dx_f$.

 Cost

$$\min_{u} \mathbb{E}\left[\int_{0}^{t_{f}} \frac{1}{2} \|u(t)\|^{2} dt\right]$$

• Use $A(\theta)$ and $B(\theta)$ to compute relevant functions: (1)

$$\Phi(t_f,\tau) = \int_0^1 e^{A(\theta)(t_f-\tau)} B(\theta) d\theta \quad \text{and} \quad G_{t_f,0} = \int_0^{t_f} \Phi(t_f,\tau) \Phi(t_f,\tau)^{\mathrm{T}} d\tau$$
(2)

$$q^{\epsilon,G}(0,x_0,t_f,x_f) = (2\pi\epsilon)^{-\frac{d}{2}} (\det(G_{t_f,0}))^{-\frac{d}{2}} \exp\left(-\frac{1}{2\epsilon} \left\| x_f - \left(\int_0^1 e^{A(\theta)t_f} d\theta\right) x_0 \right\|_{G_{t_f,0}^{-1}}^2\right)$$

(3)

$$\hat{q}^{\epsilon,G}(0,x_0,t,t_f,y) = (2\pi\epsilon)^{-\frac{d}{2}} (\det(G_{t_f,t}))^{-\frac{d}{2}} \exp\left(-\frac{1}{2\epsilon} \left\| y - \left(\int_0^1 e^{A(\theta)t_f} d\theta\right) x_0 - \sqrt{\epsilon} \int_0^t \Phi(t_f,\tau) dW(\tau) \right\|_{G_{t_f,t}^{-1}}^2\right)$$

• Use 1) and $A(\theta)$ to compute local control:

$$u^{*}(t|x_{0}, x_{f}) = -\sqrt{\epsilon} \int_{0}^{t} \Phi(t_{f}, t)^{T} G_{t_{f}, \tau}^{-1} \Phi(t_{f}, \tau) dW(\tau) + \Phi(t_{f}, t)^{T} G_{t_{f}, 0}^{-1} \left(x_{f} - \left(\int_{0}^{1} e^{A(\theta)t_{f}} d\theta \right) x_{0} \right)$$

• Use 3) to compute posterior transition densities:

$$p^*(t_f, x_f | 0, x_0, t) = \frac{\hat{q}^{\epsilon, G}(0, x_0, t, t_f, x_f)\phi_f(x_f)}{\int_{\mathbb{R}^d} \hat{q}^{\epsilon, G}(0, x_0, t, t_f, y)\phi_f(y)dy}$$

where ϕ_f together with ϕ_0 is obtained from

$$\rho_0(x_0) = \phi_0(x_0) \int_{\mathbb{R}^d} q^{\epsilon,G}(0,x_0,t_f,x_f) \phi_f(x_f) dx_f$$
$$\rho_f(x_f) = \phi_f(x_f) \int_{\mathbb{R}^d} q^{\epsilon,G}(0,x_0,t_f,x_f) \phi_0(x_0) dx_0$$

• Compute optimal control:

$$u^{*}(t|x_{0}) = \int_{\mathbb{R}^{d}} u^{*}(t|x_{0}, x_{f}) p^{*}(t_{f}, x_{f}|0, x_{0}, t) dx_{f}$$

It is important to note that, in step 4 since the prior transition density $p^*(t_f, x_f|0, x_0, t)$ accounts for the most likely path from x_0 to x_f , the integration over all possible final states x_f in step 5 effectively sums over all potential paths that the passive process in (1.8) can take from x_0 to the final states, exemplifying the principles of path integral [25–30]. As noted by the transition density $\hat{q}^{\epsilon,G}$ in Step 2, the potential paths that the passive process in (1.8) can take depend not only on the initial condition x_0 but also on the past noise $\{W(\tau)\}_{0 \le \tau \le t}$, thereby incorporating the entire historical trajectory at time t. This underlines the deviation from [25–30] and all the Schrödinger bridge frameworks (see for instance [6–10] and reference therein).

5. Numerical Result

Example 5.1. We consider one-dimensional passive dynamics

(5.1)
$$dX(t,\theta) = -\theta X(t,\theta)dt + \sqrt{\epsilon}dW(t)$$

over the time horizon [0,1], where $\theta \in [0,1]$. At time t = 0, the observed initial density of (5.1) is

(5.2)
$$\rho_0(x) := \begin{cases} 0.2 - 0.2\cos(3\pi x) + 0.2 & \text{for } 0 \le x < \frac{2}{3} \\ 5 - 5\cos(6\pi x - 4\pi) + 0.2 & \text{for } \frac{2}{3} \le x \le 1 \end{cases}$$

and at time t = 1, the observed (or desired) density is

(5.3)
$$\rho_f(x) := \rho_0(1-x)$$

illustrated in Figure 1. This captures a scenario where the transition from (5.2) to (5.3) is characterized by the harmonic oscillator, with unknown frequency θ but only the range [0, 1] is known and the oscillator is influenced by thermal or other external noise with intensity $\epsilon > 0$. By solving (1.5) subject to

(5.4)
$$dX(t,\theta) = (-\theta X(t,\theta) + u(t))dt + \sqrt{\epsilon}dW(t)$$

the goal is to design control input u(t) that will effectively bridge (5.3) from (5.2), despite the stochastic nature of the process. More precisely, the Schrödinger bridge problem (1.5) subject to (5.4), seeks to identify the most likely and robust stochastic harmonic oscillator whose density ρ have started from (5.2) and has ended at (5.3).

Using the parameters $A(\theta) = -\theta$ and $B(\theta) = 1$ from (5.4), we have that $G_{t_f, \cdot}$ in (1.11) is computed to be:

$$G_{1,\tau} = \left(\int_{\tau}^{1} \Phi(1,t)^2 dt\right),\,$$

where

(5.5)
$$\Phi(1,t) = \frac{1 - e^{-(1-t)}}{1 - t}.$$

One can check that $\tau \mapsto \int_{\tau}^{1} \left(\frac{1-e^{-(1-t)}}{1-t}\right)^2 dt$ is strictly monotone on [0,1] and hence

(5.6)
$$G_{1,\tau}^{-1} = \left(\int_{\tau}^{1} \left(\frac{1 - e^{-(1-t)}}{1 - t}\right)^2 dt\right)^{-1}$$

is well-defined for all $\tau \in [0,1)$. Therefore, from Theorem (4.1), we have that the optimal control for problem (1.5)-(1.6) where (5.4) is (4.1), demonstrated in Figure 4 where $u^*(t|x_0, x_f)$ in (3.29) is demonstrated in Figure 3 and the conditioned transition density in (4.3) are (5.5)-(5.6) and

(5.7)
$$\int_0^1 e^{-\theta} d\theta = 1 - e$$

The corresponding pinned bridge is demonstrated in Figure 5 and the most likely and robust stochastic harmonic oscillator is shown in Figure 6. From Figure 7, we see that the control in Figure 4 effectively transitions from ρ_0 in (5.2) to ρ_f in (5.3) through the most robust likely path in (4.6) demonstrated in Figure 6.

Example 5.2. For the two-dimensional case, we have

(5.8)
$$A(\theta) = \begin{bmatrix} 0 & -\theta \\ \theta & 0 \end{bmatrix} \quad B(\theta) = \begin{bmatrix} 1 & 0 \\ 0 & 1 \end{bmatrix}$$

and hence

$$e^{A(\theta)(1-t)} = \begin{bmatrix} \cos(\theta(1-t)) & -\sin(\theta(1-t)) \\ \sin(\theta(1-t)) & \cos(\theta(1-t)) \end{bmatrix}.$$

Thus, $\Phi(1, \cdot)$ in (1.9) is computed to be:

(5.9)
$$\Phi(1,t) = \begin{bmatrix} \frac{\sin(1-t)}{(1-t)} & \frac{\cos(1-t)-1}{(1-t)} \\ \frac{1-\cos(1-t)}{(1-t)} & \frac{\sin(1-t)}{(1-t)} \end{bmatrix}$$

and $G_{t_f,\cdot}$ in (1.11) is computed to be:

$$G_{1,\tau} = \left(\int_{\tau}^{1} \Phi(1,t)\Phi(1,t)^{\mathrm{T}}dt\right),\,$$

where

$$\Phi(1,t)\Phi(1,t)^{\mathrm{T}} = \begin{bmatrix} \frac{2-2\cos(1-t)}{(1-t)^2} & 0\\ 0 & \frac{2-2\cos(1-\tau)}{(1-t)^2} \end{bmatrix}$$

Since $\lim_{t\to 1} \frac{2-2\cos(1-t)}{(1-t)^2} = 1$ and the function $t \mapsto \frac{2-2\cos(1-t)}{(1-t)^2}$ is continuous and strictly monotone on $[\tau, 1]$, for all $\tau \in [0, 1]$, we have that $\tau \mapsto \int_{\tau}^{1} \frac{2-2\cos(1-t)}{(1-t)^2} dt$ is invertible on [0, 1) and

hence

(5.10)
$$G_{1,\tau}^{-1} = \left(\int_{\tau}^{1} \Phi(1,t)\Phi(1,t)^{\mathrm{T}}dt\right)^{-1} = \left(\int_{\tau}^{1} \frac{2-2\cos(1-t)}{(1-t)^{2}}dt\right)^{-1} \begin{bmatrix} 1 & 0\\ 0 & 1 \end{bmatrix}$$

is well-defined for all $\tau \in [0,1)$. Therefore, from Theorem (4.1), we have that the optimal control for problem (1.5)-(1.6) where (5.8) is (4.1) where $u^*(t|x_0, x_f)$ in (3.29) is demonstrated in Figure 8 having the conditioned transition density in (4.3) are (5.9)-(5.10) and

(5.11)
$$\int_0^1 e^{A(\theta)} d\theta = \begin{bmatrix} \sin(1) & \cos(1) - 1 \\ 1 - \cos(1) & \sin(1) \end{bmatrix}.$$

The most likely pinned bridge is shown in Figure 9.

6. CONCLUSION AND FUTURE WORK

In this paper, we have discussed the problem of conditioning a Markov process, subjected to parameter perturbation, to initial and final given distributions. We have shown that the control that establishes the bridge is a stochastic feedforward control. This is our preliminary work and there will be more follow-up projects including discrete and computational problems. For example, although we have formally solved the optimal control problem using a path integral formulation, the task of computing the path integral remains. To address this, we can employ various standard methods, such as Monte Carlo sampling [25]. Specifically, one straightforward approach is naive forward sampling. This is our future work. Another future work is to relax the restriction that the control and the noise in our problem enter the system through the same channel. This setup deviates from being a Schrödinger bridge problem. We also plan to study the case other variations of the ensemble of stochastic process

such as existence of barrier, non-linearity and extend other data-driven problems associated to the classical Schrodinger bridge problem to our case etc.

For such x_0 , the control $u^*(\cdot|x_0)$ in Figure 4 effectively drive the averaged process $x^*(\cdot|x_0)$ in Figure 6 to $x^*(1|x_0)$. Each bar's height in the histogram (in blue) corresponds to the number of samples (or frequency) that fall within the bar's range, normalized by the total number of samples and the width of the bins. Therefore, as the sample points initialized in ρ_0 increases, the histogram becomes a better approximation of ρ_f .
