# TAYLOR SPECTRUM OF A BANACH MODULE OVER THE QUANTUM PLANE

ABSTRACT. In the paper we investigate the joint spectra of Banach space representations of the quantum q-plane called Banach q-modules. Based on the transversality relation from the topological homology of the trivial modules versus given a left Banach q-module, we introduce the joint (essential) spectra of a Banach q-module. In particular, we have the well defined Taylor joint spectrum of a Banach q-module. The noncommutative projection q-property is proved for the Taylor spectrum, which stands out the conventional projection property in the commutative case. It is provided the key examples of the Banach q-modules, which do not possesses nether forward nor backward projection properties.

## 1. INTRODUCTION

The present paper is devoted to the noncommutative spectral theory of Banach space representations of Yu. I. Manin's quantum plane [10]. Noncommutative complex analytic geometry of a contractive quantum plane was investigated in [8]. The quantum plane (or just q-plane) is the free associative algebra

$$\mathfrak{A}_q = \mathbb{C} \langle x, y \rangle / (xy - q^{-1}yx)$$

generated by x and y modulo the relation  $xy = q^{-1}yx$ , where  $q \in \mathbb{C} \setminus \{0, 1\}$ , whose Arens-Michael envelope is denoted by  $\mathcal{O}_q(\mathbb{C}_{xy})$ . The Fréchet  $\widehat{\otimes}$ -algebra  $\mathcal{O}_q(\mathbb{C}_{xy})$  is treated as the algebra of all noncommutative entire functions in the generators x and y. In the case of  $|q| \neq 1$ , the algebra  $\mathcal{O}_q(\mathbb{C}_{xy})$  can be extended up to a noncommutative Fréchet  $\widehat{\otimes}$ -algebra presheaf  $\mathcal{O}_q$ on the space  $\mathbb{C}_{xy} = \operatorname{Spec}(\mathcal{O}_q(\mathbb{C}_{xy}))$  of all continuous characters of  $\mathcal{O}_q(\mathbb{C}_{xy})$ . The obtained ringed (noncommutative) space  $(\mathbb{C}_{xy}, \mathcal{O}_q)$  represents the geometry of  $\mathfrak{A}_q$  as a union of two irreducible components being copies of the complex plane equipped with the q-topology and the disk topology, respectively. Namely,  $\mathbb{C}_{xy} = \mathbb{C}_x \cup \mathbb{C}_y$  is the union of the complex planes  $\mathbb{C}_x = \mathbb{C} \times \{0\} \subseteq \mathbb{C}^2$  and  $\mathbb{C}_y = \{0\} \times \mathbb{C} \subseteq \mathbb{C}^2$ . The Fréchet  $\widehat{\otimes}$ -algebra  $\mathcal{O}_q(\mathbb{C}_{xy})$  itself admits the following topological direct sum decomposition

$$\mathcal{O}_{q}\left(\mathbb{C}_{xy}\right) = \mathcal{O}\left(\mathbb{C}_{x}\right) \oplus \operatorname{Rad}\mathcal{O}_{q}\left(\mathbb{C}_{xy}\right) \oplus \mathcal{I}_{y}$$

where  $\mathcal{O}(\mathbb{C}_x)$  is the commutative algebra of all entire function in one variable x (which is the closed unital subalgebra generated by x), Rad  $\mathcal{O}_q(\mathbb{C}^2)$  is the Jacobson radical, and  $\mathcal{I}_y$  is the closed non-unital subalgebra generated by y. That decomposition of  $\mathcal{O}_q(\mathbb{C}_{xy})$  is extended up to the sheaf decomposition  $\mathcal{O}_q = \mathcal{O} \oplus \text{Rad} \mathcal{O}_q \oplus \mathcal{I}_y$  (see [8]), that describes the structure (pre)sheaf  $\mathcal{O}_q$ .

Our main task is to analyze the Taylor type spectrum of a Banach space representation of  $\mathfrak{A}_q$  that comes from the topological homology sight of  $\mathcal{O}_q(\mathbb{C}_{xy})$  obtained by A. Yu. Prikovskii in [14] (see also [15]). One of the central results of [14] asserts that the canonical embedding  $\mathfrak{A}_q \to \mathcal{O}_q(\mathbb{C}_{xy})$  is a localization in the sense of Taylor [20]. It turns out that every left Banach

 $\mathfrak{A}_q$ -module possesses the Taylor spectrum as in the commutative case, which carries a deep information on its homological properties and the related noncommutative holomorphic functional calculus. In the commutative case that approach is due to M. Putinar [16], that is the case of q = 1.

A left Banach  $\mathfrak{A}_q$ -module X is given by a complex Banach space X and an ordered pair (T, S)of bounded linear operators from  $\mathcal{B}(X)$  such that  $TS = q^{-1}ST$ . The pair (T, S) automatically defines a unique continuous algebra homomorphism  $\mathcal{O}_q(\mathbb{C}_{xy}) \to \mathcal{B}(X)$  that turns X into a left Banach  $\mathcal{O}_q(\mathbb{C}_{xy})$ -module. The resolvent set res (T, S) of these operators (or the module X) is defined as a set of those  $\gamma \in \mathbb{C}_{xy}$  such that the transversality relation  $\mathbb{C}(\gamma) \perp_{\mathcal{O}_q(\mathbb{C}_{xy})} X$  holds, where  $\mathbb{C}(\gamma)$  is the trivial  $\mathcal{O}_q(\mathbb{C}_{xy})$ -module given by the continuous character  $\gamma$ . Recall that  $\mathbb{C}(\gamma) \perp_{\mathcal{O}_q(\mathbb{C}_{xy})} X$  means vanishing of all homology groups  $\operatorname{Tor}_k^{\mathcal{O}_q(\mathbb{C}_{xy})}(\mathbb{C}(\gamma), X) = \{0\}, k \geq 0$ . The joint (Taylor) spectrum of the pair (T, S) or the left Banach  $\mathcal{O}_q(\mathbb{C}_{xy})$ -module X is defined as the complement  $\sigma(T, S) = \mathbb{C}_{xy} \setminus \operatorname{res}(T, S)$  to the resolvent set. It turns out that  $\gamma \in \sigma(T, S)$ if and only if the following Banach space complex  $\mathcal{K}((T, S), \gamma)$ :

$$\begin{array}{cccc} & \left[\begin{array}{c} \gamma\left(y\right) - qS \\ T - q\gamma\left(x\right) \end{array}\right] \\ 0 \rightarrow & X \end{array} \xrightarrow{\left[\begin{array}{cccc} T - q\gamma\left(x\right) \end{array}\right]} & X \oplus X \end{array} \xrightarrow{\left[\begin{array}{cccc} T - \gamma\left(x\right) & S - \gamma\left(y\right) \end{array}\right]} \\ X \rightarrow 0 \end{array}$$

fails to be exact, that is,

$$\sigma(T,S) = \{\gamma \in \mathbb{C}_{xy} : \mathcal{K}((T,S),\gamma) \text{ is not exact} \}.$$

Since  $\mathcal{K}((T, S), \gamma), \gamma \in \mathbb{C}_{xy}$  is a parametrized Banach space complex, all properties of the Slodkowski spectra (see [7]) and the essential spectrum [9], [3] of parametrized Banach space complexes are applicable. We prove that if T and S are invertible operators, then  $\sigma(T, S) = \emptyset$  and |q| = 1. If  $|q| \neq 1$  then  $\sigma(T, S)$  is a nonempty compact subset in  $\mathbb{C}^2$  (in the standard topology). As the main result we prove the following q-projection property

$$\sigma(T,S) \subseteq \left( \left( \sigma(T) \cup \sigma\left(q^{-1}T\right) \right) \times \{0\} \right) \cup \left( \{0\} \times \left( \sigma(S) \cup \sigma\left(qS\right) \right) \right).$$

Moreover, we show that the standard forward  $\sigma(T, S) | \mathbb{C}_x \subseteq \sigma(T) \times \{0\}$  and the backward  $\{0\} \times \sigma(S) \subseteq \sigma(T, S) | \mathbb{C}_y$  projection properties do not hold in the general case, that is surprising result compared to the noncommutative Harte spectrum [8] with its noncommutative polynomial spectral mapping property.

As a key example we consider a pair of the unilateral shift operator T and the diagonal q-operator S on the Banach spaces  $\ell_p$ ,  $1 \leq p < \infty$ , and provide the full description of their spectrum  $\sigma(T, S)$  and the essential spectrum  $\sigma_e(T, S)$ . In this case,  $\sigma(T) = \mathbb{D}_1$  is the closed unit disk centered at the origin and  $\sigma(S) = \{q^n : n \geq 0\}^-$ . It turns out that

$$\left(\mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_{1}^{\circ}\right) \times \{0\} \subseteq \sigma\left(T,S\right) |\mathbb{C}_{x} \subseteq \mathbb{D}_{|q|^{-1}} \times \{0\}, \quad \sigma\left(T,S\right) |\mathbb{C}_{y} = \{(0,1)\},$$

where  $\mathbb{D}_r$  is the closed unit disk of radius r centered at the origin with its interior  $\mathbb{D}_r^\circ$  and the topological boundary  $\partial \mathbb{D}_r$ . Thus  $\sigma(T, S) | \mathbb{C}_x \nsubseteq \sigma(T) \times \{0\}$  and  $\{0\} \times \sigma(S) \nsubseteq \sigma(T, S) | \mathbb{C}_y$ .

Finally, for the joint essential spectrum we obtain the following formula

$$\sigma_e(T,S) = \left(\partial \mathbb{D}_1 \cup \partial \mathbb{D}_{|q|^{-1}}\right) \times \{0\}$$

though  $\sigma_e(T) = \partial \mathbb{D}_1$ , which shows again the failure of the conventional projection property for the joint essential spectrum.

## 2. Preliminaries

All considered vector spaces are assumed to be complex. The spectrum of an element a in an associative algebra A is denoted by  $\sigma(a)$ , whereas Rad A denotes the Jacobson radical of A.

2.1. Arens-Michael envelope. Let A be a complete polynormed (or locally convex) algebra. If the topology of A is defined by means of a family of multiplicative seminorms, then A is called an Arens-Michael algebra [11, 1.2.4]. Fix a polynormed algebra A with its separately continuous multiplication. The Arens-Michael envelope [11, 5.2.21] of A is called a pair  $(\widetilde{A}, \omega)$ ,

where  $\widetilde{A}$  is an Arens-Michael algebra,  $\omega : A \to \widetilde{A}$  is a continuous algebra homomorphism with the following "universal-projective" property: for all Arens-Michael algebra B and a continuous algebra homomorphism  $\pi : A \to B$ , there exists a unique continuous algebra homomorphism  $\widetilde{\pi} : \widetilde{A} \to B$  such that  $\widetilde{\pi} \cdot \omega = \pi$ . It turns out that an Arens-Michael algebra is an inverse limit of some Banach algebras [11, 5.2.10]. Thus in the latter universal projective property it can be assumed that all considered algebras B are Banach algebras.

The set of all continuous characters of an Arens-Michael algebra A is denoted by Spec (A). If  $\lambda \in \text{Spec}(A)$  then the algebra homomorphism  $\lambda : A \to \mathbb{C}$  defines A-module structure on  $\mathbb{C}$  via pull back along  $\lambda$ . This module is denoted by  $\mathbb{C}(\lambda)$  called a trivial module given by  $\lambda$ .

2.2. The Fréchet algebra  $\mathcal{O}_q(\mathbb{C}_{xy})$ . The Arens-Michael envelope of the q-plane  $\mathfrak{A}_q$  is denoted by  $\mathcal{O}_q(\mathbb{C}^2)$  (see [14]). It turns out that  $\mathcal{O}_q(\mathbb{C}^2) = \mathcal{I}_x \oplus \mathcal{I}_{xy} \oplus \mathcal{I}_y$  is a topological direct sum of the closed unital subalgebra  $\mathcal{I}_x$  generated by x, the closed two-sided ideal  $\mathcal{I}_{xy}$  generated by xy, and the closed non-unital subalgebra  $\mathcal{I}_y$  generated by y (see [8]). In this case,  $\operatorname{Rad} \mathcal{O}_q(\mathbb{C}^2) \subseteq$  $\mathcal{I}_{xy} = \cap \{\ker(\lambda) : \lambda \in \operatorname{Spec}(\mathcal{O}_q(\mathbb{C}^2))\}$  and

$$\operatorname{Spec}\left(\mathcal{O}_{q}\left(\mathbb{C}^{2}\right)\right) = \operatorname{Spec}\left(\mathcal{O}_{q}\left(\mathbb{C}^{2}\right)/\mathcal{I}_{xy}\right) = \mathbb{C}_{xy},$$

where  $\mathbb{C}_{xy} = \mathbb{C}_x \cup \mathbb{C}_y$ ,  $\mathbb{C}_x = \mathbb{C} \times \{0\} \subseteq \mathbb{C}^2$ ,  $\mathbb{C}_y = \{0\} \times \mathbb{C} \subseteq \mathbb{C}^2$ . If  $|q| \neq 1$  then the algebra  $\mathcal{O}_q(\mathbb{C}^2)$  is commutative modulo its Jacobson radical Rad  $\mathcal{O}_q(\mathbb{C}^2)$  and  $\mathcal{I}_{xy} = \text{Rad} \mathcal{O}_q(\mathbb{C}^2)$ , that is, the topological direct sum decomposition

$$\mathcal{O}_q\left(\mathbb{C}^2\right) = \mathcal{O}\left(\mathbb{C}_x\right) \oplus \operatorname{Rad} \mathcal{O}_q\left(\mathbb{C}^2\right) \oplus \mathcal{I}_y$$

holds. Thus the noncommutative analytic space  $\mathbb{C}_{xy} = \mathbb{C}_x \cup \mathbb{C}_y$  is a union of two copies of the complex plane. One needs to equip  $\mathbb{C}_{xy}$  with a suitable topology that would affiliate to the noncommutative multiplication of the quantum plane (see [8]). The algebra  $\mathcal{O}_q(\mathbb{C}^2)$  turns out to be commutative modulo its Jacobson radical Rad  $\mathcal{O}_q(\mathbb{C}^2)$  and  $\mathcal{I}_{xy} = \operatorname{Rad} \mathcal{O}_q(\mathbb{C}^2)$ . In this case, we use the notation  $\mathcal{O}_q(\mathbb{C}_{xy})$  instead of  $\mathcal{O}_q(\mathbb{C}^2)$  by indicating to the fact that it can be extended up to a Fréchet  $\widehat{\otimes}$ -algebra presheaf  $\mathcal{O}_q$  on the space  $\mathbb{C}_{xy}$  [8]. If |q| = 1 then none of the monomials  $x^i y^k \in \mathcal{I}_{xy}$ ,  $i, k \in \mathbb{N}$  is quasinilpotent, whereas  $\mathcal{I}_{xy}$  contains all quasinilpotent elements.

# 3. The Slodkowski spectra of left $\mathfrak{A}_q$ -Fréchet modules

In this section we introduce the Slodkowski (Taylor) spectra of the left Banach  $\mathfrak{A}_q$ -modules on the topological homology background and investigate the transversality relations.

3.1. The Slodkowski, Taylor and essential spectra. Let X be a left Banach  $\mathfrak{A}_q$ -module given by a pair (T, S) of operators from  $\mathcal{B}(X)$  with the property  $TS = q^{-1}ST$ . Since  $\mathcal{O}_q(\mathbb{C}^2)$  is the Arens-Michael envelope of  $\mathfrak{A}_q$ , it follows that the same couple (T, S) provides a left Banach  $\mathcal{O}_q(\mathbb{C}^2)$ -module structure on X extending the original one. Let us introduce the following parametrized over the character space  $\mathbb{C}_{xy}$  Banach space complex

(3.1) 
$$\mathcal{K}\left(\left(T,S\right),\gamma\right):0\to X\xrightarrow{d_{\gamma}^{0}}X\oplus X\xrightarrow{d_{\gamma}^{1}}X\to 0$$

with the differentials

$$d_{\gamma}^{0} = \begin{bmatrix} \gamma(y) - qS \\ T - q\gamma(x) \end{bmatrix} \text{ and } d_{\gamma}^{1} = \begin{bmatrix} T - \gamma(x) & S - \gamma(y) \end{bmatrix}.$$

Notice that  $\gamma(x) \gamma(y) = 0$  for every  $\gamma \in \mathbb{C}_{xy}$ . One can consider the related Slodkowski spectra  $\sigma^{\pi,n}(T,S), \sigma^{\delta,n}(T,S), 0 \le n \le 2$ , and the essential spectrum  $\sigma_e(T,S)$  (see [19], [4] and [7]) of the parametrized Banach space complex (3.1). Namely, put  $\Sigma^n(T,S) = \{\gamma \in \mathbb{C}_{xy} : H^n(\gamma) \ne \{0\}\}$ , where  $H^n(\gamma)$  is the *n*th cohomology group of the complex  $\mathcal{K}((T,S), \gamma)$ . Recall that

$$\sigma^{\pi,n}(T,S) = \left\{ \gamma \in \bigcup_{k \le n} \Sigma^n(T,S) \text{ or } \operatorname{im}\left(d^n_\gamma\right) \text{ is not closed} \right\}, \text{ and } \sigma^{\delta,n}(T,S) = \bigcup_{k \ge n} \Sigma^n(T,S).$$

The joint spectrum of the pair (T, S) is defined to be the following set

$$\sigma(T,S) = \{\gamma \in \mathbb{C}_{xy} : \mathcal{K}((T,S),\gamma) \text{ is not exact}\},\$$

whereas the joint essential spectrum of the pair (T, S) is defined as its subset

$$\sigma_{e}(T,S) = \{\gamma \in \mathbb{C}_{xy} : \mathcal{K}((T,S),\gamma) \text{ is not Fredholm}\}.$$

Recall that a Banach space complex is said to be Fredholm if all its (co)homology groups are finite dimensional. Notice that

$$\sigma\left(T,S\right) = \bigcup_{k} \Sigma^{k}\left(T,S\right) = \sigma^{\pi,2}\left(T,S\right) = \sigma^{\delta,0}\left(T,S\right).$$

It is an analog of the Taylor joint spectrum of the operator pair (T, S), and it can also be applied to the case of a left Fréchet  $\mathcal{O}_q(\mathbb{C}_{xy})$ -module X given by a pair (T, S) of continuous linear operators acting on X with  $TS = q^{-1}ST$ . Since  $\operatorname{Spec}(\mathcal{O}_q(\mathbb{C}^2)) = \mathbb{C}_{xy} = \mathbb{C}_x \cup \mathbb{C}_y$ , it follows that

$$\sigma(T,S) = \sigma_x(T,S) \cup \sigma_y(T,S) \text{ with}$$
  
$$\sigma_x(T,S) = \sigma(T,S) \cap \mathbb{C}_x \text{ and } \sigma_y(T,S) = \sigma(T,S) \cap \mathbb{C}_y.$$

If  $\lambda \in \sigma_x(T, S)$  then the differentials of the complex  $\mathcal{K}((T, S), \lambda)$  are converted into

$$d_{\lambda}^{0} = \begin{bmatrix} -qS \\ T - q\lambda \end{bmatrix}$$
 and  $d_{\lambda}^{1} = \begin{bmatrix} T - \lambda & S \end{bmatrix}$ .

Notice that the first (nonzero) homology group  $H^0(\lambda)$  of the complex  $\mathcal{K}((T, S), \lambda)$  corresponds to the joint eigenvalue  $(q\lambda, 0)$  of the pair (T, S), whereas nonzero  $H^2(\lambda)$  occurs if im  $(T - \lambda) +$ im  $(S) \neq X$ . If  $\mu \in \sigma_y(T, S)$  then we come up with the following non-exact Banach space complex  $\mathcal{K}((T, S), \mu)$  whose differentials are given by

$$d^0_{\mu} = \begin{bmatrix} \mu - qS \\ T \end{bmatrix} \quad \text{and} \quad d^1_{\mu} = \begin{bmatrix} T & S - \mu \end{bmatrix}$$

In this case, a nonzero  $H^0(\mu)$  responds to the joint eigenvalue  $(0, q^{-1}\mu)$  of the operator pair (T, S), whereas a nonzero  $H^2(\mu)$  occurs if  $\operatorname{im}(T) + \operatorname{im}(S - \mu) \neq X$ .

3.2. The resolution of the quantum plane. The quantum plane  $\mathfrak{A}_q$  possesses (see [18], [21]) the following free  $\mathfrak{A}_q$ -bimodule resolution

$$(3.2) 0 \leftarrow \mathfrak{A}_q \xleftarrow{\pi} \mathfrak{A}_q \otimes \mathfrak{A}_q \xleftarrow{\partial_0} \mathfrak{A}_q \otimes \mathbb{C}^2 \otimes \mathfrak{A}_q \xleftarrow{\partial_1} \mathfrak{A}_q \otimes \wedge^2 \mathbb{C}^2 \otimes \mathfrak{A}_q \leftarrow 0,$$

with the mapping  $\pi (a \otimes b) = ab$  and the differentials

$$\partial_0 \left( a \otimes e_1 \otimes b \right) = a \otimes xb - ax \otimes b, \quad \partial_0 \left( a \otimes e_2 \otimes b \right) = a \otimes yb - ay \otimes b,$$
  
$$\partial_1 \left( a \otimes e_1 \wedge e_2 \otimes b \right) = a \otimes e_2 \otimes xb - qax \otimes e_2 \otimes b - qa \otimes e_1 \otimes yb + ay \otimes e_1 \otimes b,$$

where  $a, b \in \mathfrak{A}_q$  and  $(e_1, e_2)$  is the standard basis of  $\mathbb{C}^2$ . One of the central results of [14] asserts that the canonical embedding  $\mathfrak{A}_q \to \mathcal{O}_q(\mathbb{C}^2)$  is a localization in the sense of Taylor [20]. Using the resolution (3.2), we derive that the following (a similar) complex

$$0 \leftarrow \mathcal{O}_q\left(\mathbb{C}^2\right) \xleftarrow{\pi} \mathcal{O}_q\left(\mathbb{C}^2\right)^{\widehat{\otimes}^2} \xleftarrow{d_0} \mathcal{O}_q\left(\mathbb{C}^2\right) \widehat{\otimes} \mathbb{C}^2 \widehat{\otimes} \mathcal{O}_q\left(\mathbb{C}^2\right) \xleftarrow{d_1} \mathcal{O}_q\left(\mathbb{C}^2\right) \widehat{\otimes} \wedge^2 \mathbb{C}^2 \widehat{\otimes} \mathcal{O}_q\left(\mathbb{C}^2\right) \leftarrow 0$$

is admissible, which provides a free  $\mathcal{O}_q(\mathbb{C}^2)$ -bimodule resolution of  $\mathcal{O}_q(\mathbb{C}^2)$  (see [12, 3.2]). One needs to apply the functor  $\mathcal{O}_q(\mathbb{C}^2) \underset{\mathfrak{A}_q}{\otimes} \circ \underset{\mathfrak{A}_q}{\otimes} \mathcal{O}_q(\mathbb{C}^2)$  to the complex (3.2). We use a bit modified cochain version of this resolution

$$\mathcal{R}\left(\mathcal{O}_q\left(\mathbb{C}^2\right)^{\widehat{\otimes}2}\right): 0 \to \mathcal{O}_q\left(\mathbb{C}^2\right)^{\widehat{\otimes}2} \xrightarrow{d^0} \mathcal{O}_q\left(\mathbb{C}^2\right)^{\widehat{\otimes}2} \oplus \mathcal{O}_q\left(\mathbb{C}^2\right)^{\widehat{\otimes}2} \xrightarrow{d^1} \mathcal{O}_q\left(\mathbb{C}^2\right)^{\widehat{\otimes}2} \to 0,$$

whose differentials can be written in the following operator matrix shapes

(3.3) 
$$d^{0} = \begin{bmatrix} R_{y} \otimes 1 - q1 \otimes L_{y} \\ 1 \otimes L_{x} - qR_{x} \otimes 1 \end{bmatrix}, d^{1} = \begin{bmatrix} 1 \otimes L_{x} - R_{x} \otimes 1 & 1 \otimes L_{y} - R_{y} \otimes 1 \end{bmatrix},$$

where L and R indicate to the left and right multiplication operators on  $\mathcal{O}_q(\mathbb{C}^2)$ .

3.3. The spectrum of a left Fréchet  $\mathcal{O}_q(\mathbb{C}^2)$ -module. Let us introduce the spectrum of a left Fréchet  $\mathcal{O}_q(\mathbb{C}^2)$ -module X within the general framework of the spectral theory of left modules over Fréchet sheaves [5].

Let X be a left Fréchet  $\mathcal{O}_q(\mathbb{C}^2)$ -module given by an operator pair (T, S) with  $TS = q^{-1}ST$ . By applying the functor  $\circ \bigotimes_{\mathcal{O}_q(\mathbb{C}^2)} X$  to the indicated bimodule resolution  $\mathcal{R}\left(\mathcal{O}_q(\mathbb{C}^2)^{\widehat{\otimes}^2}\right)$  of  $\mathcal{O}_q(\mathbb{C}^2)$ , we obtain the following free left  $\mathcal{O}_q(\mathbb{C}^2)$ -module resolution

$$(3.4) \qquad \mathcal{R}\left(\mathcal{O}_q\left(\mathbb{C}^2\right)\widehat{\otimes}X\right): 0 \to \mathcal{O}_q\left(\mathbb{C}^2\right)\widehat{\otimes}X \xrightarrow{d^0} \left(\mathcal{O}_q\left(\mathbb{C}^2\right)\widehat{\otimes}X\right)^{\oplus 2} \xrightarrow{d^1} \mathcal{O}_q\left(\mathbb{C}^2\right)\widehat{\otimes}X \to 0$$

for the module X with the differentials (see (3.3))

$$d^{0} = \left[ \begin{array}{c} R_{y} \otimes 1 - q1 \otimes S \\ 1 \otimes T - qR_{x} \otimes 1 \end{array} \right], d^{1} = \left[ \begin{array}{c} 1 \otimes T - R_{x} \otimes 1 & 1 \otimes S - R_{y} \otimes 1 \end{array} \right].$$

Thus the complex

$$\mathcal{R}\left(\mathcal{O}_q\left(\mathbb{C}^2\right)\widehat{\otimes}X\right) \xrightarrow{\pi_X} X \to 0 \quad \text{with } \pi_X\left(f\otimes\xi\right) = f\xi$$

is admissible. The resolvent set res(T, S) of these operators (or the module X) is defined as a set of those  $\gamma \in \mathbb{C}^2$  such that the transversality relation  $\mathbb{C}(\gamma) \perp_{\mathcal{O}_q(\mathbb{C}^2)} X$  holds, that is,  $\operatorname{Tor}_k^{\mathcal{O}_q(\mathbb{C}^2)}(\mathbb{C}(\gamma), X) = \{0\}$  for all  $k \geq 0$ .

**Lemma 3.1.** Let X be a left Fréchet  $\mathcal{O}_q(\mathbb{C}^2)$ -module given by an operator pair (T,S) with  $TS = q^{-1}ST$ . The equality

$$\sigma\left(T,S\right) = \mathbb{C}^2 \backslash \operatorname{res}\left(T,S\right)$$

holds.

*Proof.* The homology groups  $\operatorname{Tor}_{k}^{\mathcal{O}_{q}(\mathbb{C}^{2})}(\mathbb{C}(\gamma), X)$  can be calculated by means of the resolution  $\mathcal{R}\left(\mathcal{O}_{q}(\mathbb{C}^{2})\widehat{\otimes}X\right)$  from (3.4). By applying the functor  $\mathbb{C}(\gamma) \underset{\mathcal{O}_{q}(\mathbb{C}^{2})}{\widehat{\otimes}} \circ$  to the resolution

 $\mathcal{R}\left(\mathcal{O}_{q}\left(\mathbb{C}^{2}\right)\widehat{\otimes}X\right)$ , we derive that  $\operatorname{Tor}_{k}^{\mathcal{O}_{q}\left(\mathbb{C}^{2}\right)}\left(\mathbb{C}\left(\gamma\right),X\right)$  are the homology groups of the following

complex

$$0 \to X \xrightarrow{d_{\gamma}^{0}} X \oplus X \xrightarrow{d_{\gamma}^{1}} X \to 0,$$
  
$$d_{\gamma}^{0} = \begin{bmatrix} \gamma(y) - qS \\ T - q\gamma(x) \end{bmatrix}, d_{\gamma}^{1} = \begin{bmatrix} T - \gamma(x) & S - \gamma(y) \end{bmatrix}$$

which is reduced to the complex  $\mathcal{K}((T,S),\gamma)$  considered above in Subsection 3.1. Thus res(T,S) consists of those  $\gamma \in \mathbb{C}_{xy}$  such that  $\mathcal{K}((T,S),\gamma)$  is exact. Hence  $\mathbb{C}_{xy} \setminus \operatorname{res}(T,S) = \sigma(T,S)$ .

Thus the Taylor spectrum  $\sigma(T, S)$  is defined in terms of the transversality relation of the trivial modules  $\mathbb{C}(\gamma), \gamma \in \mathbb{C}_{xy}$  with respect to the given left Fréchet  $\mathcal{O}_q(\mathbb{C}^2)$ -module.

## 4. The pseudo-commuting pairs of operators

In this section we introduce the pseudo-commuting pairs of bounded linear operators and their joint spectra that allow to describe the Taylor spectrum of a left Banach  $\mathfrak{A}_q$ -module. We also prove the key result on the *q*-projection property for a left Banach  $\mathfrak{A}_q$ -module.

4.1. The left spectrum of a pseudo-commuting pairs of operators. Let (T, S) be an ordered pair of bounded linear operators acting on a Banach space X. We say that (T, S) is a *pseudo-commuting pair* if TS = SC for a certain  $C \in \mathcal{B}(X)$ . In particular,  $(\lambda - T)S = S(\lambda - C)$  for all  $\lambda \in \mathbb{C}$ . The pseudo-commuting pair (T, S) generates the following (continuously) parametrized [19, 2.1] on  $\mathbb{C}$  (cochain) Banach space complex

$$\mathcal{L}_{\lambda}(T,S): 0 \to X \xrightarrow{l_{\lambda}^{0}} X \oplus X \xrightarrow{l_{\lambda}^{1}} X \to 0$$

with the differentials

$$l_{\lambda}^{0} = \begin{bmatrix} S \\ \lambda - C \end{bmatrix}$$
 and  $l_{\lambda}^{1} = \begin{bmatrix} \lambda - T & -S \end{bmatrix}$ .

Thus  $l_{\lambda}^{1}l_{\lambda}^{0} = (\lambda - T)S - S(\lambda - C) = 0$  for all  $\lambda$ . We say that  $\lambda$  is a left spectral point of the pair (T, S) if the complex  $\mathcal{L}_{\lambda}(T, S)$  fails to be exact. The set of all left spectral points of (T, S) is denoted by  $\sigma_{l}(T, S)$ .

**Lemma 4.1.** If (T, S) is a pseudo-commuting pair of operators on a Banach space X with TS = SC, then

$$\sigma_l(T,S) \subseteq \sigma(T) \cup \sigma(C).$$

Moreover, if S is invertible in  $\mathcal{B}(X)$  then  $\sigma_l(T,S) = \emptyset$ .

Proof. If  $\lambda \notin \sigma(T) \cup \sigma(C)$  then obviously, ker  $(l_{\lambda}^{0}) = \ker(S) \cap \ker(\lambda - C) = \{0\}$  and im  $(l_{\lambda}^{1}) = (\lambda - T)X + SX = X$ . Next, if  $(\xi, \eta) \in \ker(l_{\lambda}^{1})$ , then  $(\lambda - T)\xi = S\eta$ , which in turn implies that  $\xi = (\lambda - T)^{-1}S\eta$ . With  $(\lambda - T)S = S(\lambda - C)$  in mind, infer that  $\xi = S\theta$ , where  $\theta = (\lambda - C)^{-1}\eta$ . Then

$$l_{\lambda}^{0}\theta = (S\theta, (\lambda - C)\theta) = (\xi, \eta).$$

Thus the complex  $\mathcal{L}_{\lambda}(T, S)$  is exact, or  $\lambda \notin \sigma_l(T, S)$ . Hence  $\sigma_l(T, S) \subseteq \sigma(T) \cup \sigma(C)$ .

Now assume that S is invertible in  $\mathcal{B}(X)$ . So,  $S^{-1}T = CS^{-1}$ . If  $l_{\lambda}^{0}\zeta = 0$  for some  $\zeta \in X$ , then  $S\zeta = 0$ , therefore  $\zeta = 0$ . Moreover,  $l_{\lambda}^{1}(X \oplus X) = (\lambda - T)X + SX = X$ . Thus ker  $(l_{\lambda}^{0}) = \{0\}$  and im  $(l_{\lambda}^{1}) = X$ . Finally, if  $(\zeta, \eta) \in \ker(l_{\lambda}^{1})$  then  $(\lambda - T)\zeta = S\eta$  and  $\eta = (\lambda - C)S^{-1}\zeta$ . It follows that  $l_{\lambda}^{0}S^{-1}\zeta = (SS^{-1}\zeta, (\lambda - C)S^{-1}\zeta) = (\zeta, \eta)$ , that is, ker  $(l_{\lambda}^{1}) = \operatorname{im}(l_{\lambda}^{0})$ . Thus  $\mathcal{L}_{\lambda}(T, S)$  is exact for every  $\lambda \in \mathbb{C}$ , which means that  $\sigma_{l}(T, S) = \emptyset$ .

In the case of a left Banach  $\mathfrak{A}_q$ -module X given by an operator pair (T, S) with  $TS = q^{-1}ST$ , we see that (T, S) is a pseudo-commuting pair of operators on X with  $C = q^{-1}T$ . In particular, we have its left spectrum  $\sigma_l(T, S)$ . Thus  $\lambda \in \sigma_l(T, S)$  iff the following complex

$$\mathcal{L}_{\lambda}(T,S): 0 \to X \xrightarrow{l_{\lambda}^{0}} X \oplus X \xrightarrow{l_{\lambda}^{1}} X \to 0,$$
$$l_{\lambda}^{0} = \begin{bmatrix} S \\ \lambda - q^{-1}T \end{bmatrix} \text{ and } l_{\lambda}^{1} = \begin{bmatrix} \lambda - T & -S \end{bmatrix}$$

fails to be exact. Actually, the action of  $\mathfrak{A}_q$  on X provides many other pseudo-commuting pairs of operators on X. Namely, if  $f(x) = \sum_n a_n x^n \in \mathfrak{A}_q$  is a polynomial then  $f(T) = \sum_n a_n T^n$ and  $f(T) S = \sum_n a_n T^n S = \sum_n S a_n q^{-n} T^n = S f(q^{-1}T)$ , that is,

$$f(T)S = Sf(q^{-1}T).$$

It means that (f(T), S) is a pseudo-commuting pair with  $C = f(q^{-1}T)$ . In a similar way, we have

$$f(qT)S = Sf(T)$$

which means that (f(qT), S) is a pseudo-commuting pair with C = f(T).

Further, the flipped pair (S, T) is pseudo-commuting too, namely ST = T(qS) with C = qS. By the right spectrum of the pair (T, S), we mean the set

$$\sigma_r\left(T,S\right) = \sigma_l\left(S,T\right).$$

By its very definition,  $\mu \in \sigma_r(T, S)$  iff the following complex

$$\mathcal{R}_{\mu}(T,S): 0 \to X \xrightarrow{r_{\mu}^{0}} X \oplus X \xrightarrow{r_{\mu}^{1}} X \to 0,$$
$$r_{\mu}^{0} = \begin{bmatrix} T \\ \mu - qS \end{bmatrix} \text{ and } r_{\mu}^{1} = \begin{bmatrix} \mu - S & -T \end{bmatrix}$$

is not exact. Notice that  $\mathcal{R}_{\mu}(T,S) = \mathcal{L}_{\mu}(S,T)$ .

As above if  $g(y) = \sum_n b_n y^n \in \mathfrak{A}_q$  is a polynomial, then  $g(S)T = \sum_n b_n S^n T = \sum_n T b_n q^n S^n = Tg(qS)$ , and  $g(q^{-1}S)T = Tg(S)$ , that is, (g(S), T) and  $(g(q^{-1}S), T)$  are pseudo-commuting pairs on X. One can replace T or S by the monomials  $T^k$  or  $S^k$ . In this case,  $T^kS = q^{-k}ST^k$  or  $TS^k = q^{-k}S^kT$  and the number q is replaced by  $q^k$ . They are pairs of the left Banach  $\mathfrak{A}_{q^k}$ -module X.

4.2. The q-projection property, compactness and nonvoidness of the spectrum. As above, let X be a left Banach  $\mathfrak{A}_q$ -module given by a pair (T, S) with  $TS = q^{-1}ST$ .

**Theorem 4.1.** The equalities

 $\sigma_{x}\left(T,S\right)=\sigma_{l}\left(T,S\right)\times\left\{0\right\} \quad and \quad \sigma_{y}\left(T,S\right)=\left\{0\right\}\times\sigma_{r}\left(T,S\right)$ 

hold. Thus  $\sigma(T, S) = (\sigma_l(T, S) \times \{0\}) \cup (\{0\} \times \sigma_r(T, S))$  is a union of the compact subsets and the following q-projection property

$$\sigma(T,S) \subseteq \left( \left( \sigma(T) \cup \sigma(q^{-1}T) \right) \times \{0\} \right) \cup \left( \{0\} \times \left( \sigma(S) \cup \sigma(qS) \right) \right)$$

holds.

*Proof.* Take  $\lambda \in \mathbb{C}_x$ . As we have seen above, the complex (3.1) is reduced to

$$\mathcal{K}\left(\left(T,S\right),\lambda\right):0\to X\xrightarrow{d_{\lambda}^{0}}X\oplus X\xrightarrow{d_{\lambda}^{1}}X\to 0,$$
$$d_{\lambda}^{0}=\left[\begin{array}{cc}-qS\\T-q\lambda\end{array}\right]\quad\text{and}\quad d_{\lambda}^{1}=\left[\begin{array}{cc}T-\lambda\quad S\end{array}\right]$$

Notice that  $d_{\lambda}^0 = -q l_{\lambda}^0$  and  $d_{\lambda}^1 = -l_{\lambda}^1$ . Then the following commutative diagram

$$\mathcal{K}\left(\left(T,S\right),\lambda\right):0 \to \begin{array}{ccc} X \\ \downarrow q \end{array} \xrightarrow{d_{\lambda}^{0}=\left[\begin{array}{ccc} -qS \\ T-q\lambda \end{array}\right]} \\ \downarrow q \end{array} \xrightarrow{\lambda \oplus X} \begin{array}{ccc} X \oplus X \\ \downarrow -(1 \oplus 1) \end{array} \xrightarrow{d_{\lambda}^{1}=\left[\begin{array}{ccc} T-\lambda & S \end{array}\right]} \\ \downarrow & \downarrow 1 \end{array} \xrightarrow{\lambda \oplus X} \\ \downarrow & \downarrow 1 \end{array}$$

$$\mathcal{L}_{\lambda}(T,S):0 \to \begin{array}{ccc} X \end{array} \xrightarrow{l_{\lambda}^{0}=\left[\begin{array}{ccc} S \\ \lambda-q^{-1}T \end{array}\right]} \\ X \oplus X \end{array} \xrightarrow{l_{\lambda}^{1}=\left[\begin{array}{ccc} \lambda-T & -S \end{array}\right]} \\ X \oplus X \end{array} \xrightarrow{\lambda \oplus X} \begin{array}{ccc} X \\ \downarrow 1 \end{array}$$

implements an isomorphic identification  $\mathcal{K}((T,S),\lambda) = \mathcal{L}_{\lambda}(T,S)$  of the Banach space complexes. It follows that  $\sigma_x(T,S) = \sigma_l(T,S) \times \{0\}$ .

If  $\mu \in \mathbb{C}_y$  then the complex (3.1) is converted to the following one

$$\mathcal{K}\left(\left(T,S\right),\mu\right):0\to X\xrightarrow{d_{\mu}^{0}}X\oplus X\xrightarrow{d_{\mu}^{1}}X\to 0,$$
$$d_{\mu}^{0}=\left[\begin{array}{cc}\mu-qS\\T\end{array}\right]\quad\text{and}\quad d_{\mu}^{1}=\left[\begin{array}{cc}T\quad S-\mu\end{array}\right]$$

As above, the following commutative diagram

$$\begin{aligned} & \mathcal{K}\left(\left(T,S\right),\mu\right):0 \to \begin{array}{c} X \\ \downarrow_{1} \end{array} & \begin{pmatrix} d_{\mu}^{0} = \left[\begin{array}{c} \mu - qS \\ T \end{array}\right] \\ \downarrow_{1} \end{array} & \begin{pmatrix} X \oplus X \\ \downarrow_{1} \end{array} & \begin{pmatrix} d_{\mu}^{1} = \left[\begin{array}{c} T & S - \mu \end{array}\right] \\ \downarrow_{-1} \end{array} & \begin{pmatrix} X \oplus X \\ \downarrow_{-1} \end{array} & \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{array}\right] \\ & & \downarrow_{-1} \end{aligned} \\ & & & \downarrow_{-1} \end{aligned} \\ & & & \mathcal{R}_{\mu}\left(T,S\right):0 \to X \end{array} & \begin{array}{c} r_{\mu}^{0} = \left[\begin{array}{c} T \\ \mu - qS \end{array}\right] \\ & & X \oplus X \end{array} & \begin{array}{c} r_{\mu}^{1} = \left[\begin{array}{c} \mu - S \\ \to \end{array} - T \end{array}\right] \\ & & X \to 0 \end{aligned}$$

implements an isomorphic identification  $\mathcal{K}((T,S),\mu) = \mathcal{R}_{\mu}(S,T)$  of the Banach space complexes. Hence  $\sigma_y(T,S) = \{0\} \times \sigma_r(T,S)$ .

Finally, note that  $\mathcal{L}_{\lambda}(T,S)$ ,  $\lambda \in \mathbb{C}_x$ , and  $\mathcal{R}_{\mu}(T,S)$ ,  $\mu \in \mathbb{C}_y$  are continuously parametrized Banach space complexes over  $\mathbb{C}$ . Using [19, Theorem 2.1], we deduce that  $\sigma_x(T,S) \subseteq \mathbb{C}_x$  and  $\sigma_y(T,S) \subseteq \mathbb{C}_y$  are closed subsets in the standard topology of the complex plane  $\mathbb{C}$ . By Lemma 4.1, we obtain that

$$\sigma_x(T,S) = \sigma_l(T,S) \times \{0\} \subseteq (\sigma(T) \cup \sigma(q^{-1}T)) \times \{0\},\$$
  
$$\sigma_y(T,S) = \{0\} \times \sigma_r(T,S) = \{0\} \times \sigma_r(S,T) \subseteq \{0\} \times (\sigma(S) \cup \sigma(qS)).$$

It follows that

$$\sigma(T,S) \subseteq \left( \left( \sigma(T) \cup \sigma(q^{-1}T) \right) \times \{0\} \right) \cup \left( \{0\} \times \left( \sigma(S) \cup \sigma(qS) \right) \right)$$

that is,  $\sigma(T, S)$  is bounded. Consequently,  $\sigma_x(T, S)$  and  $\sigma_y(T, S)$  are compact subsets. In particular, so is  $\sigma(T, S)$  in  $\mathbb{C}^2$ .

The nonvoidness of the joint spectrum follows from the following assertion.

**Proposition 4.1.** Let X be a left Banach  $\mathfrak{A}_q$ -module given by an operator pair (T, S) with  $TS = q^{-1}ST$ . If T and S are invertible operators, then  $\sigma(T, S) = \emptyset$  and |q| = 1. If  $|q| \neq 1$  then  $\sigma(T, S)$  is a nonempty compact subset in  $\mathbb{C}^2$ .

Proof. First notice that  $\sigma(TS) \cup \{0\} = \sigma(ST) \cup \{0\} = q\sigma(TS) \cup \{0\}$ , therefore  $\sigma(TS) = \{0\}$  whenever  $|q| \neq 1$ . It follows that TS is not invertible, therefore so is T or S. Thus, if T and S are invertible operators, then |q| = 1. Moreover,  $\sigma_l(T, S) = \emptyset$  and  $\sigma_r(T, S) = \sigma_l(S, T) = \emptyset$ 

thanks to Lemma 4.1. Using Theorem 4.1, we conclude that  $\sigma(T, S) = (\sigma_l(T, S) \times \{0\}) \cup (\{0\} \times \sigma_r(T, S)) = \emptyset$ .

Now assume that  $|q| \neq 1$ . Then  $0 \in \sigma(T) \cup \sigma(S)$ . First assume that  $0 \in \sigma(T)$ . If  $Y = \ker(T) \neq \{0\}$  then  $S(Y) \subseteq Y$ , for  $TS = q^{-1}ST$ . The approximate point spectrum  $\sigma_{ap}(qS|Y)$  of the operator  $qS|Y \in \mathcal{B}(Y)$  is non-empty. Take  $\mu \in \sigma_{ap}(qS|Y)$ . Then  $(\mu - qS)\zeta_n \to 0$ ,  $n \to \infty$  for a certain sequence  $\{\zeta_n\}$  of unit vectors in Y. It follows that

$$r^{0}_{\mu}(\zeta_{n}) = \begin{bmatrix} T \\ \mu - qS \end{bmatrix} \zeta_{n} = (T\zeta_{n}, (\mu - qS)\zeta_{n}) = (0, (\mu - qS)\zeta_{n}) \to 0,$$

where  $r^0_{\mu}$  is the differential of the complex  $\mathcal{R}_{\mu}(T, S)$ . Thus either ker  $(r^0_{\mu}) \neq \{0\}$  or im  $(r^0_{\mu})$  is not closed. Consequently,  $\mu \in \sigma_r(T, S)$ ,  $(0, \mu) \in \sigma_y(T, S)$  and  $\sigma_y(T, S) \subseteq \sigma(T, S)$  by virtue of Theorem 4.1. If ker  $(T) = \{0\}$  then  $TX \neq X$ . Consider the following commutative diagram

$$\begin{array}{cccc} X & \stackrel{T}{\longrightarrow} & X \\ \downarrow^{qS} & & \downarrow^{S} \\ X & \stackrel{T}{\longrightarrow} & X \end{array}$$

(ST = qTS). By Slodkowski Lemma [17, Lemma 1.6], we have  $TX + (\mu - S) X \neq X$  for a certain  $\mu \in \mathbb{C}$ . In particular,  $\mu \in \sigma(S)$  and im  $([\mu - S - T]) \neq X$ , that is, im  $(r_{\mu}^{1}) \neq X$ . Consequently,  $(0, \mu) \in \sigma_{\mu}(T, S)$  by Theorem 4.1.

A similar argument is applicable to the case of  $0 \in \sigma(S)$ . Namely, if ker  $(S) \neq \{0\}$  then as above im  $(l_{\lambda}^0)$  is not closed for a certain  $\lambda \in \sigma_{ap}(q^{-1}T | \ker(S))$ , where  $l_{\lambda}^0$  is the differential of the complex  $\mathcal{L}_{\lambda}(T,S)$ . Therefore  $(\lambda, 0) \in \sigma_x(T,S)$  and  $\sigma_x(T,S) \subseteq \sigma(T,S)$  by Theorem 4.1. If  $SX \neq X$  then we consider the following commutative diagram

$$\begin{array}{cccc} X & \stackrel{S}{\longrightarrow} & X \\ \downarrow^{q^{-1}T} & & \downarrow^{T} \\ X & \stackrel{S}{\longrightarrow} & X \end{array}$$

 $(TS = q^{-1}ST)$ . Again by Slodkowski Lemma [17, Lemma 1.6], we deduce that  $(\lambda - T)X + SX \neq X$  for a certain  $\lambda \in \sigma(T)$ . It follows that im  $(l_{\lambda}^{1}) \neq X$ , that is,  $(\lambda, 0) \in \sigma_{x}(T, S)$ . Whence  $\sigma(T, S) \neq \emptyset$  whenever  $|q| \neq 1$ .

**Remark 4.1.** As we can see from the proof of Proposition 4.1 that  $\sigma_y(T, S) \neq \emptyset$  whenever  $0 \in \sigma(T)$ , whereas  $0 \in \sigma(S)$  implies that  $\sigma_x(T, S) \neq \emptyset$ .

## 5. The concrete example and lack of the projection property

Let X be a left Banach  $\mathfrak{A}_q$ -module given by an operator pair (T, S) with  $TS = q^{-1}ST$ and |q| < 1. By Proposition 4.1, the joint spectrum  $\sigma(T, S)$  is a nonempty compact subset in  $\mathbb{C}^2$ . By Theorem 4.1, the inclusion  $\sigma(T, S) | \mathbb{C}_x \subseteq (\sigma(T) \cup \sigma(q^{-1}T)) \times \{0\}$  (or  $\sigma_l(T, S) \subseteq$  $\sigma(T) \cup \sigma(q^{-1}T)$ ) holds. The forward projection property for the joint spectrum would state the inclusion  $\sigma(T, S) | \mathbb{C}_x \subseteq \sigma(T) \times \{0\}$  rather than what we have seen above. In a similar way  $\{0\} \times \sigma(S) \subseteq \sigma(T, S) | \mathbb{C}_y$  would be our expectation for the backward projection property. Our present task is to show that none of these inclusions valid for the joint spectrum of a contractive Banach quantum plane.

5.1. The left Banach  $\mathfrak{A}_q$ -modules  $\ell_p$ . There are key examples of the operator q-planes considered on the  $L_p$ -Banach spaces. To be certain, we assume that  $X = \ell_p$  (or  $\ell_p(\mathbb{Z}_+)$ ) for  $1 \leq p < \infty$  with its standard topological basis  $\{e_n\}_{n \in \mathbb{Z}_+}$ , and consider the unilateral shift

operator T and the diagonal q-operator S on  $\ell_p$ . Thus  $T, S \in \mathcal{B}(\ell_p)$  are the operators acting by the rules

$$T(e_n) = e_{n+1},$$
  
$$S(e_n) = q^n e_n,$$

for all  $n \in \mathbb{Z}_+$ . One can easily verify that  $TS = q^{-1}ST$ . Since |q| < 1, it follows that S is a compact operator with its spectrum  $\sigma(S) = \{1\}_q = \{q^n : n \in \mathbb{Z}_+\} \cup \{0\}$ , which is the q-hull of  $\{1\}$ . Moreover,  $\sigma(T) = \mathbb{D}_1$  is the closed unit disk. Thus both  $\sigma(T)$  and  $\sigma(S)$  are the q-compact (coincide with their q-hulls) subsets of the complex plane.

5.2. The left spectrum. First we focus on the left spectrum  $\sigma_l(T, S)$  or  $\sigma_x(T, S)$  to be described. Since  $0 \in \sigma(S)$ , it follows as in the proof of Proposition 4.1 that  $(\lambda - T) X + SX \neq X$  for a certain  $\lambda \in \sigma(T)$  (the Slodkowski Lemma). Hence the second cohomology group  $H^2(\lambda) = \ell_p / \operatorname{im}(l^1_{\lambda})$  of the complex  $\mathcal{L}_{\lambda}(T, S)$  is not trivial, therefore  $(\lambda, 0) \in \sigma(T, S)$  or  $\lambda \in \sigma_l(T, S)$ . Hence  $(\sigma(T) \times \{0\}) \cap (\sigma(T, S) | \mathbb{C}_x) \neq \emptyset$  or  $\sigma(T) \cap \sigma_l(T, S) \neq \emptyset$ . Since ker  $(S) = \{0\}$ , we conclude that  $H^0(\lambda) = \ker(l^0_{\lambda}) = \ker(S) \cap \ker(\lambda - q^{-1}T) = \{0\}$  for all  $\lambda \in \sigma_l(T, S)$ .

**Proposition 5.1.** If  $1 < |\lambda| \le |q|^{-1}$  then  $H^0(\lambda) = H^2(\lambda) = \{0\}$  and  $H^1(\lambda) \ne \{0\}$ . Thus  $\mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_1 \subseteq \sigma_l(T, S) \subseteq \mathbb{D}_{|q|^{-1}}$  and  $(0, 0) \notin \sigma(T, S)$ .

*Proof.* Take  $\lambda \in \mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_1$ , and consider the Banach space complex  $\mathcal{L}_{\lambda}(T, S)$ :

$$0 \to \ell_p \xrightarrow{l_{\lambda}^0 = \begin{bmatrix} S \\ \lambda - q^{-1}T \end{bmatrix}} \ell_p \oplus \ell_p \xrightarrow{l_{\lambda}^1 = \begin{bmatrix} \lambda - T & -S \end{bmatrix}} \ell_p \to 0$$

Since  $\lambda \notin \sigma(T)$ , it follows that  $\operatorname{im}(l_{\lambda}^{1}) = \operatorname{im}(\lambda - T) + \operatorname{im}(S) = \ell_{p}$ , that is,  $H^{2}(\lambda) = \{0\}$ .

To prove that  $H^1(\lambda) \neq \{0\}$ , let us take the following vectors  $\zeta = \sum_{n=0}^{\infty} \frac{1}{\lambda^{n+1}} e_n$  with  $\|\zeta\|_p = (|\lambda|^p - 1)^{-1/p}$ , and  $\eta = e_0$  with  $\|\eta\|_p = 1$  from the Banach space  $\ell_p$ . First prove that  $(\zeta, \eta) \notin in(l_{\lambda}^0)$ . Indeed, in the contrary case, we have  $(\zeta, \eta) = l_{\lambda}^0(\theta)$  for a certain  $\theta = \sum_{n=0}^{\infty} \alpha_n e_n \in \ell_p$ , which means that  $\zeta = S(\theta)$  and  $(\lambda - q^{-1}T)(\theta) = \eta$ . It follows that  $q^n \alpha_n = \frac{1}{\lambda^{n+1}}$  for all n. Then

$$\liminf_{n} \{|\alpha_n|\} = \frac{1}{|\lambda|} \liminf_{n} \left\{ \frac{1}{|q\lambda|^n} \right\} \ge \frac{1}{|\lambda|} > 0,$$

a contradiction  $(\theta \in \ell_p \text{ with } \|\theta\|_p^p = \sum_n |\alpha_n|^p < \infty)$ . Notice also that

$$\eta = \left(\lambda - q^{-1}T\right)(\theta) = \lambda \alpha_0 e_0 + \sum_{n=1}^{\infty} \left(\lambda \alpha_n - q^{-1}\alpha_{n-1}\right) e_n,$$

which results in the same equalities  $\alpha_0 = \frac{1}{\lambda}$  and  $\alpha_n = \frac{1}{q^n \lambda^{n+1}}$ ,  $n \in \mathbb{N}$ . Further, let us prove that  $(\zeta, \eta) \in \ker(l^1_{\lambda})$ . Namely,

$$l_{\lambda}^{1}(\zeta,\eta) = (\lambda - T)\zeta - S\eta = \sum_{n=0}^{\infty} \frac{1}{\lambda^{n}} e_{n} - \sum_{n=0}^{\infty} \frac{1}{\lambda^{n+1}} e_{n+1} - e_{0} = 0.$$

Hence  $H^1(\lambda) \neq \{0\}$ . Thus  $\mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_1 \subseteq \sigma_l(T, S)$ . By Theorem 4.1, we derive that

$$\sigma_l(T,S) \subseteq \sigma(T) \cup q^{-1}\sigma(T) = \mathbb{D}_1 \cup q^{-1}\mathbb{D}_1 = \mathbb{D}_{|q|^{-1}}.$$

Thus we obtain the inclusions  $\mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_1 \subseteq \sigma_l(T, S) \subseteq \mathbb{D}_{|q|^{-1}}$ .

Now prove that  $(0,0) \notin \sigma(T,S)$ , that is, the complex (see (3.1))  $\mathcal{K}((T,S),0)$ :

$$0 \to \ell_p \xrightarrow{d^0} \ell_p \oplus \ell_p \xrightarrow{d^1} \ell_p \to 0$$
$$d^0 = \begin{bmatrix} -qS \\ T \end{bmatrix}, \quad d^1 = \begin{bmatrix} T & S \end{bmatrix}$$

is exact. Since ker $(S) = \{0\}$ , it follows that ker $(d^0) = \{0\}$ . For every  $\zeta = \sum_{n=0}^{\infty} \alpha_n e_n \in \ell_p$  we have  $\zeta = S(\alpha_0 e_0) + T(\eta) = d^1(\eta, \alpha_0 e_0)$  with  $\eta = \sum_{n=0}^{\infty} \alpha_{n+1} e_n$ , which means that im  $(d^1) = \ell_2$ . Finally, if  $(\zeta, \eta) \in \ker(d^1)$  with  $\zeta = \sum_{n=0}^{\infty} \alpha_n e_n$  and  $\eta = \sum_{n=0}^{\infty} \beta_n e_n$ , then  $T\zeta = -S\eta$ , that is,  $\beta_0 = 0$  and  $\alpha_n = -q^{n+1}\beta_{n+1}$  for all  $n \in \mathbb{Z}_+$ . It remains to notice that  $d^0\theta = (-qS\theta, T\theta) = (\zeta, \eta)$  for  $\theta = \sum_{n=0}^{\infty} \beta_{n+1} e_n \in \ell_p$ . Whence ker $(d^1) = \operatorname{im}(d^0)$ , thereby the complex is exact.

**Corollary 5.1.** The inclusion  $\sigma_r(T, S) \subseteq \{q^m, q^{m-1}, \ldots, q, 1\}$  holds for some  $m \ge 0$ .

*Proof.* By Proposition 5.1, we have  $(0,0) \notin \sigma(T,S)$ . In particular,  $0 \notin \sigma_r(T,S)$ . By Proposition 4.1, we deduce that  $\sigma_r(T,S) \cap B(0,\varepsilon) = \emptyset$  for some small  $\varepsilon > 0$ . Using Theorem 4.1, the inclusions  $\sigma_r(S,T) \subseteq \sigma(S) \cup \sigma(qS) \subseteq \{1\}_q$  hold. It follows that

$$\sigma_r(S,T) \subseteq \{1\}_q \cap (\mathbb{C} \setminus B(0,\varepsilon)) = \{q^m, q^{m-1}, \dots, q, 1\}$$

for some  $m \ge 0$ .

As follows from Proposition 5.1,  $\sigma_l(T, S) \cap B(0, \varepsilon) = \emptyset$  holds too for a small disk  $B(0, \varepsilon)$ , which is a q-open (coincides with its q-hull) subset. The presence of a q-open subset  $U \subseteq \mathbb{C} \setminus \sigma_l(T, S)$  is used to relate to the transversality property of the left Banach  $\mathfrak{A}_q$ -module  $\ell_p$  (see [6]).

5.3. The right spectrum. The following assertion clarifies the statement of Corollary 5.1.

**Proposition 5.2.** The equality  $\sigma_r(T, S) = \{1\}$  holds. In this case,  $H^0(1) = \{0\}$  and  $H^1(1) = H^2(1) = \mathbb{C}$ , where  $H^i(1)$  are the cohomology groups of the complex  $\mathcal{R}_1(T, S)$ . Thus  $\mathcal{R}_1(T, S)$  is a nonexact Fredholm complex.

*Proof.* Based on Theorem 4.1, we consider the following parametrized Banach space complex

$$\mathcal{R}_{\mu}(T,S): 0 \to \ell_{p} \xrightarrow{r_{\mu}^{0} = \begin{bmatrix} T \\ \mu - qS \end{bmatrix}} \ell_{p} \oplus \ell_{p} \xrightarrow{r_{\mu}^{1} = \begin{bmatrix} \mu - S & -T \end{bmatrix}} \ell_{p} \to 0$$

whose cohomology groups are denoted by  $H^i(\mu)$ , i = 0, 1, 2. Since ker $(T) = \{0\}$ , it follows that  $H^0(\mu) = \{0\}$  for all  $\mu \in \mathbb{C}$ . If  $\mu = 1$  then  $(\mu - S)(e_0) = 0$  and im  $(\mu - S) \subseteq \text{im}(T)$ , which means that im  $(r^1_{\mu}) = \text{im}(\mu - S) + \text{im}(T) = \text{im}(T) \neq \ell_p$ , that is,  $H^2(1) = \ell_p / \text{im}(T) = \mathbb{C}$ .

Further, note that  $(e_0, 0) \in \ker(r_1^1)$ , and for every  $(\zeta, \eta) \in \ker(r_1^1)$  with  $\zeta = \sum_n \alpha_n e_n$ ,  $\eta = \sum_n \beta_n e_n \in \ell_p$ , we have  $(\zeta, \eta) = \alpha_0(e_0, 0) + (\zeta', \eta)$  with  $\zeta' = \sum_{n \ge 1} \alpha_n e_n$ . Since  $e_0 \notin \operatorname{im}(T)$ , it follows that  $(e_0, 0) \notin \operatorname{im}(r_1^0)$ . Thus we can assume that  $\alpha_0 = 0$ . In this case,  $(1 - q^n) \alpha_n = \beta_{n-1}$  for all  $n \ge 1$ . Put  $\gamma_n = \alpha_{n+1}$ ,  $n \ge 0$ , and  $\theta = \sum_n \gamma_n e_n \in \ell_p$ . Then

$$r_1^0(\theta) = (T\theta, (1-qS)\theta) = \left(\sum_{n\geq 1} \gamma_{n-1}e_n, \sum_n (1-q^{n+1})\gamma_n e_n\right)$$
$$= \left(\sum_{n\geq 1} \alpha_n e_n, \sum_n (1-q^{n+1})\alpha_{n+1}e_n\right) = (\zeta, \eta).$$

Thus  $H^1(1) = \mathbb{C}$  too. Notice also that  $q^{-1} \notin \sigma(S)$ , which means that 1 - qS is invertible and im  $(r_1^0)$  is closed.

Now based on Corollary 5.1, let us assume that  $\mu = q^k$  with k > 0. Then  $(\mu - S)(e_0) = (\mu - 1)e_0 \neq 0$  and  $\operatorname{im}(r_{\mu}^1) = \operatorname{im}(\mu - S) + \operatorname{im}(T) = \ell_p$ , that is,  $H^2(\mu) = \{0\}$ . Take  $\zeta = \sum_n \alpha_n e_n$ ,  $\eta = \sum_n \beta_n e_n \in \ell_p$  with  $(\zeta, \eta) \in \ker(r_{\mu}^1)$ . Then  $(\mu - S)\zeta = T\eta$ , which means that  $(\mu - 1)\alpha_0 = 0$  and  $(\mu - q^n)\alpha_n = \beta_{n-1}$  for all  $n \geq 1$ . It follows that  $\alpha_0 = 0$ ,  $\alpha_n = \beta_{n-1}/(\mu - q^n)$  for all  $n \neq k$ ,  $\beta_{k-1} = 0$ , and  $\alpha_k$  remains free. Put  $\theta = \sum_n \gamma_n e_n$  with  $\gamma_n = \beta_n/(\mu - q^{n+1})$ ,  $n \neq k - 1$  and  $\gamma_{k-1} = \alpha_k$ . Since  $|\gamma_n|^p = |\beta_n|^p |\mu - q^{n+1}|^{-p} \leq 2^p |\beta_n|^p |q|^{-kp}$  for all large n, it follows that  $\|\theta\|_p \leq c \|\eta\|_p < \infty$  for some positive c, which depends on  $\mu$ . Thus  $\theta \in \ell_p$  and

$$r^{0}_{\mu}(\theta) = (T\theta, (\mu - qS)\theta) = \left(\sum_{n \ge 1} \gamma_{n-1}e_n, \sum_{n \ge 0} (\mu - q^{n+1})\gamma_n e_n\right) = \left(\sum_n \alpha_n e_n, \sum_n \beta_n e_n\right) = (\zeta, \eta)$$

that is,  $(\zeta, \eta) \in \operatorname{im}(r^0_{\mu})$ . Hence  $H^1(\mu) = \{0\}$ , and the equality  $\sigma_r(T, S) = \{1\}$  follows.

Thus  $\sigma_y^{\pi,0}(T,S) = \emptyset$ , and  $\sigma_y^{\pi,m}(T,S) = \sigma_y^{\delta,n}(T,S) = \sigma_y(T,S) = \{(0,1)\}$  for all  $m \ge 1$ , and for all n.

5.4. The first cohomology groups over the interior of the unit disk. The following assertion states that for the interior of the disk  $\mathbb{D}_1$  the spectral points from  $\sigma_l(T, S)$  could only occur in the first cohomology groups too.

**Lemma 5.1.** If  $|\lambda| < 1$  then  $H^0(\lambda) = H^2(\lambda) = \{0\}$ , where  $H^i(\lambda)$  are the cohomology groups of the complex  $\mathcal{L}_{\lambda}(T, S)$ .

Proof. As we have stated above  $H^0(\lambda) = \{0\}$  out of the fact ker  $(S) = \{0\}$ . Since  $|\lambda| < 1$ , it follows that ker  $(\lambda - T) = \{0\}$ , im  $(\lambda - T)$  is closed, and dim  $(\ell_p/\operatorname{im}(\lambda - T)) = 1$  (see [2, VII, 6.5]). Actually, the absolute polar im  $(\lambda - T)^{\perp} = \ker(\lambda^* - T^*) = \langle \zeta_{\lambda} \rangle$  is the subspace generated by the vector  $\zeta_{\lambda} = \sum_{n} (\lambda^*)^n e_n \in \ell_q$  with  $p^{-1} + q^{-1} = 1$ . If  $H^2(\lambda) \neq \{0\}$  then im  $(l_{\lambda}^1) = \operatorname{im}(\lambda - T) + \operatorname{im}(S) \neq \ell_p$ , which means that im  $(S) \subseteq \operatorname{im}(\lambda - T)$ . Using Phillips Theorem [13, 7.4.13], we conclude that  $S = (\lambda - T)A$  for some operator  $A \in \mathcal{B}(\ell_p)$ . Then  $S^* = A^*(\lambda^* - T^*)$  in  $\mathcal{B}(\ell_q)$ , and  $S^*\zeta_{\lambda} = 0$ , that is,  $\zeta_{\lambda} \in \ker(S^*)$ . But ker  $(S^*) = \operatorname{im}(S)^{\perp} = \{0\}$ , a contradiction.

**Remark 5.1.** If  $|\lambda| < |q|$  then  $\eta_{\lambda} = \sum_{n} (\lambda/q)^{n} e_{n} \in \ell_{p}$  and  $\langle S\eta_{\lambda}, \zeta_{\lambda} \rangle = \sum_{n \ge 0} |\lambda|^{n} \ge 1$ , where  $\langle \cdot, \cdot \rangle$  indicates to the canonical duality  $\ell_{p} \times \ell_{q} \to \mathbb{C}$ . Hence  $\operatorname{im}(S) \not\subseteq \operatorname{im}(\lambda - T)$  or  $H^{2}(\lambda) = \{0\}$ .

The presence of a nonzero  $H^1(\lambda)$  for  $0 < |\lambda| < 1$  (see Proposition 5.1) remains unclear. To be precise, let us consider the case of p = 2. For every  $\eta = \sum_n \beta_n e_n \in \ell_2$  we denote by  $\eta_n$  its *n*th Fourier tail-sum  $\eta_n = \sum_{k=n+1}^{\infty} \beta_k e_n$ . As above in Lemma 5.1, we use the notation  $\zeta_{\lambda q} = \sum_n (q^*\lambda^*)^n e_n$  to be a vector from  $\ell_2$ , and consider its orthogonal complement  $\{\zeta_{\lambda q}\}^{\perp} \subseteq \ell_2$ .

$$M_{\lambda} = \left\{ \eta \in \left\{ \zeta_{\lambda q} \right\}^{\perp} : \epsilon_{\lambda} \left( \eta \right) = \sum_{n \ge 0} \left| \left( \eta_n, T^{n+1} \zeta_{\lambda q} \right) \right|^2 < \infty \right\}$$

to be a subset of  $\{\zeta_{\lambda q}\}^{\perp}$ . If  $\eta, \theta \in M_{\lambda}$  then

$$\epsilon_{\lambda} (\eta + \theta) \leq \epsilon_{\lambda} (\eta) + \epsilon_{\lambda} (\theta) + 2 \sum_{n \geq 0} \left| \left( \eta_n, T^{n+1} \zeta_{\lambda q} \right) \right| \left| \left( \theta_n, T^{n+1} \zeta_{\lambda q} \right) \right|$$
$$\leq \epsilon_{\lambda} (\eta) + \epsilon_{\lambda} (\theta) + 2\epsilon_{\lambda} (\eta)^{1/2} \epsilon_{\lambda} (\theta)^{1/2} = \left( \epsilon_{\lambda} (\eta)^{1/2} + \epsilon_{\lambda} (\theta)^{1/2} \right)^2 < \infty$$

Thereby  $M_{\lambda}$  is a subspace of  $\{\zeta_{\lambda q}\}^{\perp}$ . For every  $z \in \mathbb{C}$  with  $0 \leq |z| < 1$ , the vector  $\eta = \sum_{n} \beta_{n} e_{n}$  with  $\beta_{0} = -zq\lambda/(1-zq\lambda)$  and  $\beta_{n} = z^{n}$ ,  $n \geq 1$  belongs to  $M_{\lambda}$ . Indeed,  $(\eta, \zeta_{\lambda q}) = \beta_{0} + \beta_{0}$ 

 $\sum_{n\geq 1}\left(zq\lambda\right)^n=0$  and

$$\epsilon_{\lambda}(\eta) = \sum_{n \ge 0} \left| \sum_{k=n+1}^{\infty} z^k (q\lambda)^{k-n-1} \right|^2 = \sum_{n \ge 0} |z|^{2n+2} \left| \frac{1}{1-zq\lambda} \right|^2 = \left| \frac{z}{1-zq\lambda} \right|^2 \frac{1}{1-|z|^2} < \infty,$$

that is,  $\eta \in M_{\lambda}$ . Actually, every vector  $\eta \in \{\zeta_{\lambda q}\}^{\perp}$  with  $\sum_{n\geq 0} \|\eta_n\|^2 < \infty$  (or  $\sum_{n\geq 0} \sum_{k>n} |\beta_k|^2 < \infty$ ) belongs to the subspace  $M_{\lambda}$ .

**Lemma 5.2.** If  $0 < |\lambda| < 1$  then there is a canonical topological isomorphic identification

$$H^{1}(\lambda) = \{\zeta_{\lambda q}\}^{\perp} / M_{\lambda}$$

where  $H^{1}(\lambda)$  is the first cohomology group of the complex  $\mathcal{L}_{\lambda}(T,S)$ .

Proof. Take  $(\zeta, \eta) \in \ker(l_{\lambda}^{1})$ , that is,  $(\lambda - T)\zeta = S\eta$ . But  $\operatorname{im}(\lambda - T)^{\perp} = \langle \zeta_{\lambda} \rangle$  (see to the proof of Lemma 5.1), which means that  $(S\eta, \zeta_{\lambda}) = 0$  or  $(\eta, S^{*}\zeta_{\lambda}) = 0$ . Notice that  $S^{*}\zeta_{\lambda} = \zeta_{\lambda q}$ . Since  $\ker(\lambda - T) = \{0\}$ , the mapping  $(\zeta, \eta) \mapsto \eta$  implements a topological isomorphism  $\ker(l_{\lambda}^{1}) \to \{\zeta_{\lambda q}\}^{\perp}$  onto. Once  $\eta = \sum \beta_{n} e_{n} \in \{\zeta_{\lambda q}\}^{\perp}$  one can easily restore  $\zeta = \sum \alpha_{n} e_{n}$  with

$$\alpha_n = \frac{1}{\lambda^{n+1}} \left( \eta - \eta_n, \zeta_{\lambda q} \right).$$

Indeed,  $\lambda \alpha_0 = \beta_0$  and

$$(5.1) \quad \lambda \alpha_n - \alpha_{n-1} = \frac{1}{\lambda^n} \left( \eta - \eta_n, \zeta_{\lambda q} \right) - \frac{1}{\lambda^n} \left( \eta - \beta_n e_n - \eta_n, \zeta_{\lambda q} \right) = \frac{\beta_n}{\lambda^n} \left( e_n, \zeta_{\lambda q} \right) = \frac{\beta_n}{\lambda^n} \left( \lambda q \right)^n = q^n \beta_n$$

for all  $n \ge 1$ , which means that  $(\lambda - T)\zeta = S\eta$ . Notice that  $\sum |\alpha_n|^2 < \infty$  holds automatically.

It remains to prove that for  $(\zeta, \eta) \in \ker(l_{\lambda}^{1})$  the inclusion  $(\zeta, \eta) \in \operatorname{im}(l_{\lambda}^{0})$  holds iff  $\eta \in M_{\lambda}$ . But  $(\zeta, \eta) \in \operatorname{im}(l_{\lambda}^{0})$  iff  $\zeta = S\theta$  for some  $\theta = \sum \gamma_{n} e_{n}$ , that is,  $q^{n} \gamma_{n} = \alpha_{n}$ ,  $n \geq 0$ . Indeed, in this case, using (5.1), we derive that

$$(\lambda - q^{-1}T) \theta = \lambda \gamma_0 e_0 + \sum_{n \ge 1} (\lambda \gamma_n - q^{-1} \gamma_{n-1}) e_n = \lambda \alpha_0 e_0 + \sum_{n \ge 1} (\lambda q^{-n} \alpha_n - q^{-n} \alpha_{n-1}) e_n$$
$$= \lambda \alpha_0 e_0 + \sum_{n \ge 1} q^{-n} (\lambda \alpha_n - \alpha_{n-1}) e_n = \sum \beta_n e_n = \eta.$$

Further,  $\zeta = S\theta$  is equivalent to

$$\gamma_n = \alpha_n q^{-n} = \frac{1}{\lambda} \frac{1}{(q\lambda)^n} \left( \eta - \eta_n, \zeta_{\lambda q} \right) = -\frac{1}{\lambda} \frac{1}{(q\lambda)^n} \left( \eta_n, \zeta_{\lambda q} \right) = -\frac{1}{\lambda} \frac{1}{(q\lambda)^n} \sum_{k>n} \beta_k \left( q\lambda \right)^k$$
$$= -q \sum_{k>n} \beta_k \left( q\lambda \right)^{k-n-1} = -q \left( \eta_n, T^{n+1} \zeta_{\lambda q} \right)$$

with  $\|\theta\|_{2}^{2} = \sum_{n} |\gamma_{n}|^{2} = |q|^{2} \sum_{n} |(\eta_{n}, T^{n+1}\zeta_{\lambda q})|^{2} = |q|^{2} \epsilon_{\lambda}(\eta) < \infty.$ 

5.5. The description of spectra. Now we can summarize all results obtained in the present section.

**Theorem 5.1.** Let (T, S) be a pair given by the unilateral shift operator and the diagonal q-operator on the Banach space  $\ell_p$ ,  $1 \leq p < \infty$ . Then

$$\mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_1^{\circ} \subseteq \sigma_l(T, S) \subseteq \mathbb{D}_{|q|^{-1}}, \quad \sigma_e(T, S) = \left(\partial \mathbb{D}_1 \cup \partial \mathbb{D}_{|q|^{-1}}\right) \times \{0\},$$

where  $\mathbb{D}_1^{\circ}$  is the interior of the disk  $\mathbb{D}_1$ . In this case, for the left spectra we have

$$\begin{split} \sigma_l^{\pi,1}\left(T,S\right) &\cap \left(\mathbb{D}_{|q|^{-1}} \backslash \mathbb{D}_1^\circ\right) = \Sigma_l^1\left(T,S\right) \cap \left(\mathbb{D}_{|q|^{-1}} \backslash \mathbb{D}_1^\circ\right) = \sigma_l^{\delta,1}\left(T,S\right) \cap \left(\mathbb{D}_{|q|^{-1}} \backslash \mathbb{D}_1^\circ\right) = \mathbb{D}_{|q|^{-1}} \backslash \mathbb{D}_1^\circ,\\ \sigma_l^{\delta,2}\left(T,S\right) \cap \left(\mathbb{D}_{|q|^{-1}} \backslash \mathbb{D}_1\right) = \varnothing, \end{split}$$

and

$$\sigma_l^{\pi,1}(T,S) \cap \mathbb{D}_1^{\circ} = \sigma_l^{\delta,1}(T,S) \cap \mathbb{D}_1^{\circ}, \quad \sigma_l^{\delta,2}(T,S) \cap \mathbb{D}_1^{\circ} = \emptyset.$$

The following equalities

$$\sigma_r^{\pi,0}(T,S) = \emptyset, \quad \sigma_r^{\pi,1}(T,S) = \sigma_r^{\pi,2}(T,S) = \sigma_r(T,S) = \sigma_r^{\delta,i}(T,S) = \{1\}$$

for the right spectra hold for all  $i, 0 \leq i \leq 2$ .

*Proof.* By Proposition 5.1, we have  $\mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_1 \subseteq \sigma_l(T, S) \subseteq \mathbb{D}_{|q|^{-1}}$ . But  $\sigma_l(T, S)$  is a compact set (Proposition 4.1), therefore the inclusion  $\mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_1^\circ \subseteq \sigma_l(T, S)$  holds too (see also [7, Proposition 3.1]).

The equalities for the left spectra  $\sigma_l^{\pi,k}(T,S)$ ,  $\sigma_l^{\delta,k}(T,S)$  within  $\mathbb{D}_{|q|^{-1}} \setminus \mathbb{D}_1$  can easily be driven from Proposition 5.1, whereas Lemma 5.1 implies the equalities for the left spectra within  $\mathbb{D}_1^\circ$ . The equalities for the right spectra  $\sigma_r^{\pi,k}(T,S)$ ,  $\sigma_r^{\delta,k}(T,S)$  follow from Proposition 5.2.

To prove the equality for the essential joint spectrum we use the functor F of Buoni-Harte-Wickstead [1] defined on the category of Banach spaces. Recall that  $F(X) = \ell_{\infty}(X) / k(X)$ , where k(X) is the subspace of all precompact sequences on X. Since F is annihilating over all compact operators, we obtain that  $F(\mathcal{L}_{\lambda}(T,S))$  is reduced to the following Banach space complex

$$F(l_{\lambda}^{0}) = \begin{bmatrix} 0 \\ \lambda - q^{-1}F(T) \end{bmatrix} F(\ell_{p}) \oplus F(\ell_{p}) = \begin{bmatrix} \lambda - F(T) & 0 \end{bmatrix} F(\ell_{p}) \to 0.$$

It follows that  $(\lambda, 0) \in \sigma_e(T, S)$  iff  $\lambda \in \sigma(F(T)) \cup q^{-1}\sigma(F(T))$  (see [9]). But  $\sigma(F(T)) = \sigma_e(T) = \partial \mathbb{D}_1$  (see [2, VII, 6.5]), therefore  $\sigma_e(T, S) \cap \mathbb{C}_x = (\partial \mathbb{D}_1 \cup \partial \mathbb{D}_{|q|^{-1}}) \times \{0\}.$ 

Finally, by Proposition 5.2,  $\sigma_y(T,S) = \{(0,1)\}$  and  $\mathcal{R}_1(T,S)$  is a Fredholm complex. It follows that  $(0,1) \notin \sigma_e(T,S) \cap \mathbb{C}_y$  or  $\sigma_e(T,S) \cap \mathbb{C}_y = \emptyset$ . Optionally, one can apply the functor F to the complex  $\mathcal{R}_1(T,S)$ , which turns out to be an exact complex. Whence  $\sigma_e(T,S) = (\partial \mathbb{D}_1 \cup \partial \mathbb{D}_{|q|^{-1}}) \times \{0\}.$ 

**Remark 5.2.** It remains unclear whether  $\sigma_l(T, S) \cap \mathbb{D}_1^\circ$  is empty or not. Notice that Lemma 5.2 provides more complicated description of the cohomology group  $H^1(\lambda)$  for  $\lambda \in \mathbb{D}_1^\circ$ .

As a concluding remark, let us point out that the q-projection property from the main Theorem 4.1 turns out to be the best possible projection property for the operator q-planes that confirms Theorem 5.1.
