Quantitative particle approximation of nonlinear stochastic Fokker-Planck equations with singular kernel

Abstract

We derive quantitative estimates for large stochastic systems of interacting particles perturbed by both idiosyncratic and environmental noises, as well as singular kernels. We prove that the (mollified) empirical process converges to the solution of the nonlinear stochastic Fokker-Planck equation. The proof is based on Itô's formula for H_q^1 -valued process, commutator estimates, and some estimations for the regularization of the empirical measure. Moreover, we show that the aforementioned equation admits a unique strong solution in the probabilistic sense. The approach applies to repulsive and attractive kernels.

1 Introduction

The aim of this article is to derive a quantitative convergence result for the following nonlinear stochastic Fokker-Planck equation

$$d\rho_t = \frac{1}{2} \sum_{i,j=1}^d \partial_{ij} \left(\rho_t \sum_{k=1}^d \left(\nu_t^{ik} \nu_t^{jk} + \sigma_t^{ik} \sigma_t^{jk} \right) \right) dt - \nabla \cdot \left(\rho_t F(\cdot, K * \rho_t) \right) dt - \nabla \rho_t \cdot \sigma_t dB_t$$

from a stochastic moderately interacting particle system. The equation (1) is considered for arbitrary dimensions $d \geq 1$. We present a method that allows us to derive a fairly general class of such systems as limit dynamics of interacting stochastic many-particle systems. This procedure has been methodically employed in the literature, from the seminal papers [40, 41, 42], (see also [33] and [38]) to the recent works [23] and [43]. Concerning motivations for the model with transport noise, let us mention model reduction, see [37], in addition to other motivations like [17] and [30]. Our results cover several classical models such as the stochastic 2d Navier-Stokes equation, which in vorticity form can

be written as in (1) with the Biot-Savart kernel, the stochastic Burgers equation and the parabolic-elliptic Keller-Segel PDE in any dimension $d \ge 1$, which models the phenomenon of chemotaxis.

The derivation of macroscopic models from interacting particle systems is a fascinating and active research topic in mathematics. The basic idea is that, as the number of particles increases to infinity, the macroscopic model can effectively describe the universal properties of particles. In this article, we derive the stochastic PDE from the stochastic moderately interacting particle system on \mathbb{T}^d given by

$$dX_t^{i,N} = F\left(X_t^{i,N}, \frac{1}{N} \sum_{k=1}^N \left(K * V^N\right) \left(X_t^{i,N} - X_t^{k,N}\right)\right) dt + \nu_t \left(X_t^{i,N}\right) dW_t^i + \sigma_t \left(X_t^{i,N}\right) dB_t$$

$$(2)$$

where W_t^i and B_t are independent standard \mathbb{T}^d -valued Brownian motions, defined on a filtered probability space $(\Omega, \mathcal{F}, (\mathcal{F}_t)_{t\geq 0}, \mathbb{P})$, the interaction kernel V^N depends on the number of particles $N \in \mathbb{N}$ via the moderate interaction parameter β . Systems of the form (2) are commonly employed in the field of mean-field games, see [6], [7], [18] and [36].

The microscopic *empirical process* of this N-particle system, which is a probability measure on the ambient space \mathbb{T}^d , is given as usual by

$$S_t^N := \frac{1}{N} \sum_{i=1}^N \delta_{X_t^{i,N}}, \qquad t \geqslant 0,$$
 (3)

where δ_a is the delta Dirac measure concentrated at $a \in \mathbb{T}^d$. Then, $(S_t^N)_{t \geqslant 0}$ is a measure-valued process associated to the \mathbb{T}^d -valued processes $\{t \mapsto X_t^{i,N}\}_{i=1,\dots,N}$.

The first contribution of this paper is to investigate the large N limit of the dynamical process $(S_t^N)_{t\geqslant 0}$ in the common noise setting with singular kernels. For that purpose, we introduce the *mollified empirical measure*

$$\rho_t^N := V^N * S_t^N = \int_{\mathbb{T}^d} V^N(\cdot - y) S_t^N(\mathrm{d}y),$$

which is more regular than S_t^N , where $V^N=N^{\beta}V(N^{\frac{\beta}{d}}\cdot)$, $\beta\in(0,1)$. We quantify the distance between the empirical measure (and the regularized version) and the unique solution to the SPDE (1). The proof is based on Itô's formula for H_q^1 -valued processes, commutator estimates, and stochastic analysis techniques.

The second contribution is to show the well-posedness of the nonlinear stochastic Fokker–Planck equation (1). The main challenge in proving existence and uniqueness results for (1) is the nonlinear term $K * \rho_t$ since this prevents us from directly applying known results in the existing literature on SPDEs, such as those found in [35]. We take advantage of the specific SPDE structure to employ a fixed point argument, e.g., the recent work [31].

1.1 Related literatures

In contrast to interacting particle system, which are driven by idiosyncratic noise, see [3, 8, 9, 16, 25, 24, 26, 27, 32, 39, 43, 47, 52], the literature on common noise and singular kernels remains limited. For systems with uniformly Lipschitz interaction coefficients, [14] established conditional propagation of chaos. The entropy method has recently been explored for systems with common noise, as shown in [49] for the Navier–Stokes equations, [13] for the Hegselmann–Krause model, and [46] for mean-field systems with bounded kernels.

In the following, we will focus only on the results of moderately interacting systems: in [40], Oelschläger introduced and studied moderately interacting particle systems, which are used to obtain a local nonlinear partial differential equation. The idea is to take a radially symmetric function V and then consider the interaction potential $V^N = N^{\beta}V(N^{\frac{\beta}{d}}\cdot)$, with $\beta \in (0,1)$, which converges to the Dirac delta at 0 in the sense of distributions. The article [40] is part of a series of works by the author on this subject (see also [41, 42]). The convergence results were improved in [33] and [38]. In the recent paper [19] it was developed a semigroup approach which enables them to show uniform convergence of mollified empirical measures, see [20, 21, 23, 18, 50, 28] for additional applications of this method. Recently, in [43] and [44], the authors developed new quantitative estimates for a class of moderately interacting particle systems using a semigroup approach. This technique was further improved in [29], [34], and [45]. About more advances in moderate particle systems, see, for instance, [10], [11], [15], [12], and [51].

The problem of deriving models represented by SPDE with transport noise and singular kernels from microscopic models of stochastic interacting particles has not been highly investigated in the literature, just with the contributions in [13], [46] and [49]. As we will see in more detail in Section 1.5, our result may be applied to the following well-known models: the stochastic 2d Navier-Stokes equation, the stochastic Burgers equation and the stochastic parabolic-elliptic Keller-Segel PDE in any dimension $d \geq 1$.

1.2 Notations

For $d \geq 1$, we denote by $C^k\left(\mathbb{T}^d\right)$ the space of k-times differentiable functions on the torus $\mathbb{T}^d \doteq \left[-\frac{1}{2},\frac{1}{2}\right]^d$, where $k \in \mathbb{N} \cup \{\infty\}$. The set of density functions defined on \mathbb{T}^d is denoted by $\mathcal{P}\left(\mathbb{T}^d\right)$. The corresponding spaces on \mathbb{R}^d are defined by $C^k\left(\mathbb{R}^d\right)$ and $\mathcal{P}\left(\mathbb{R}^d\right)$, respectively.

For a measurable space (X, \mathcal{M}, μ) and f a measurable function in it (which we denote by $f \in \mathcal{M}$) we write

$$\langle \mu, f \rangle \doteq \int_X f d\mu$$

for the duality pair involving the measure μ and the function f in this space.

Also, for $a \in [1, \infty)$ the Lebesgue's space is given by

$$L^{a} = L^{a}(X) = \left\{ f \in \mathcal{M} \mid ||f||_{a} \doteq \left(\int_{X} |f|^{a} d\mu \right)^{\frac{1}{a}} < \infty \right\}$$

and if $a = \infty$

$$L^{\infty} = L^{\infty}(X) = \left\{ f \in \mathcal{M} \mid ||f||_{\infty} \doteq \operatorname{ess \, sup}_{x \in X} |f(x)| < \infty \right\}.$$

In some contexts we will write $\|\cdot\|_a = \|\cdot\|_{L^a(X)}$.

Given $(U, \|\cdot\|_U)$ a Banach space, we denote by U^* its dual and the associated duality pair by $(\cdot, \cdot)_{U,U^*}$. With this notation, for T > 0 and denoting \mathcal{L} the set of Bochner measurable functions, the Bochner's space is denoted by

$$L^{a}U = L^{a}([0,T];U) = \left\{ f: [0,T] \to U, f \in \mathcal{L} \mid ||f||_{L^{a}U} \doteq \left(\int_{0}^{T} ||f(t)||_{U}^{a} dt \right)^{\frac{1}{a}} < \infty \right\},$$

for $a \in [1, \infty)$ and if $a = \infty$ by

$$L^{\infty}U = L^{\infty}([0,T];U) = \left\{f:[0,T] \rightarrow U, f \in \mathcal{L} \mid \|f\|_{T,U} \doteq \operatorname{ess\,sup}_{t \in [0,T]} \|f(t)\|_{U} < \infty \right\}.$$

For the space of tempered distributions on \mathbb{T}^d , we write \mathcal{S}' . So, for $q > 1, n \in \mathbb{R}$, the Bessel potential space reads

$$H_q^n = H_q^n \left(\mathbb{T}^d \right) = \left\{ f \in \mathcal{S}' \mid \|f\|_{n,q} \doteq \left\| (I - \Delta)^{\frac{n}{2}} f \right\|_q < \infty \right\}.$$

For $\gamma \in (0,1]$ the Hölder's space on \mathbb{T}^d is given by

$$C^{\gamma} = C^{\gamma} \left(\mathbb{T}^d \right) = \left\{ f : \mathbb{T}^d \to \mathbb{R} \mid \|f\|_{\gamma} \doteq \|f\|_{\infty} + \sup_{x \neq y \in \mathbb{T}^d} \frac{|f(x) - f(y)|}{|x - y|^{\gamma}} < \infty \right\}.$$

Let a filtered probability space $(\Omega, \mathcal{F}, (\mathcal{F}_t)_{t\geq 0}, \mathbb{P})$, a Banach space $(U, \|\cdot\|_U)$, a real number $q \in [1, \infty]$, and a stopping time $0 < \tau \leq T$. We denote by \mathcal{X} the set of U-valued, $(\mathcal{F}_t)_{t\in[0,T]}$ -adapted and continuous processes $X = \{X_s\}_{s\in[0,\tau]}$. We define

$$S^q_{\mathcal{F}}([0,\tau];U) = \left\{ X \in \mathcal{X} \mid \left\| \|X\|_{\tau,U} \right\|_{L^q(\Omega)} < \infty \right\}$$

Also, let \mathcal{Y} denote the set of U-valued predictable processes $Y = \{Y_s\}_{s \in [0,\tau]}$. Then, for $q \in [1,\infty)$ we define

$$L^q_{\mathcal{F}}([0,\tau];U) = \left\{ Y \in \mathcal{Y} \mid \left\| \|Y\|_{L^qU} \right\|_{L^q(\Omega)} < \infty \right\}.$$

These are Banach spaces endowed with their respective norms.

1.3 Assumptions

- (\mathbf{A}^V) The mollifier $V \in C^2(\mathbb{R}^d) \cap \mathcal{P}(\mathbb{R}^d)$ is such that supp $V \subset \{x \in \mathbb{R}^d; |x| < \frac{1}{2}\}$.
- (\mathbf{A}^F) The vector field $F: \mathbb{T}^d \times \mathbb{R} \to \mathbb{R}^d$ is a bounded Lipschitz continuous function, i.e., there exists L > 0 such that

$$|F(x,u)| \le L, \quad \forall x \in \mathbb{T}^d, \ u \in \mathbb{R}.$$

$$|F(x,u) - F(y,v)| \le L(|x-y| + |u-v|), \quad \forall x,y \in \mathbb{T}^d, \ u,v \in \mathbb{R}.$$

- (\mathbf{A}^I) The vector field $F: \mathbb{T}^d \times \mathbb{R} \to \mathbb{R}$ is given by F(x, u) = u.
- (\mathbf{A}^K) There exists $q \geq 2$ such that q > d, and $\gamma \in (0,1]$ and $C_K > 0$ such that for any $f \in L^q(\mathbb{T}^d)$, it holds

$$||K * f||_{\gamma} \le C_K ||f||_q.$$

- (\mathbf{A}^c) The diffusion coefficients ν and $\sigma:[0,T]\times\mathbb{T}^d\to\mathbb{R}^{d\times d}$ are measurable, and for every $t\in[0,T]$ satisfy
 - (\mathbf{A}_{i}^{c}) There exists M>0 such that

$$\nu_t^{jk}(\cdot), \sigma_t^{jk}(\cdot) \in \left(C^2\left(\mathbb{T}^d\right), \|\cdot\|_{C^2}\right), \quad \text{for } j, k = 1, ..., d.$$

and
$$\sum_{j,k=1}^{d} \left(\|\nu_t^{jk}(\cdot)\|_{C^2} + \|\sigma_t^{jk}(\cdot)\|_{C^2} \right) \le M.$$

$$(\mathbf{A}_{ii}^c)$$
 $\sum_{j=1}^d \partial_j \sigma_t^{jk}(x) = 0$, for $k = 1, ..., d; x \in \mathbb{T}^d$.

 (\mathbf{A}^c_{iii}) There exist $\Lambda, \lambda > 0$ such that, for all $x \in \mathbb{T}^d$, $\xi = (\xi^i) \in \mathbb{R}^d$,

$$|\Lambda|\xi|^2 \ge \sum_{i,j,k=1}^d \nu_t^{ik}(x) \nu_t^{jk}(x) \xi^i \xi^j \ge \lambda |\xi|^2.$$

1.4 Main theorems.

Regarding the limiting equation (1), we will prove the following existence and uniqueness theorem, based on Krylov's L^q -theory of SPDEs, see [35].

Theorem 1. Assume (\mathbf{A}^c) and one of the two regimes:

- 1. (\mathbf{A}^F) and (\mathbf{A}^K) .
- 2. (\mathbf{A}^I) and (\mathbf{A}^K) .

Let $0 \le \rho_0 \in L^1 \cap H_q^{1-\frac{2}{q}}(\mathbb{T}^d)$, with $\|\rho_0\|_1 = 1$. For each $\kappa > 0$, there exists a T > 0 depending on $\kappa, \lambda, q, C_K, L, M$ and d such that if $\|\rho_0\|_q = \kappa$, the SPDE (1) admits a unique nonnegative solution in

$$\mathbb{M} \doteq L^{q}_{\mathcal{F}^{B}}\left([0,T];H^{1}_{q}\left(\mathbb{T}^{d}\right)\right) \cap S^{\infty}_{\mathcal{F}^{B}}\left([0,T];L^{1} \cap L^{q}\left(\mathbb{T}^{d}\right)\right).$$

The proof will be presented in Appendix B.

Theorem 2. Assume (\mathbf{A}^V) , (\mathbf{A}^c) , (\mathbf{A}^F) , and (\mathbf{A}^K) , let T_{max} be the maximal existence time for (1) and fix $T \in (0, T_{max})$. In addition, let the dynamics of the particle system be given by (2) with $\nu = Id$, σ independent of the space and for any $m \geq 1$,

$$\sup_{N \in \mathbb{N}} \left\| \left\| \rho_0^N \right\|_q \right\|_{L^m(\Omega)} < \infty$$

with $d \geq 1$, q > d given by (\mathbf{A}^K) and $\beta \in \left(0, \frac{1}{2\left\lceil 1 + \frac{1}{d} - \frac{1}{q} \right\rceil}\right)$. Then

$$\left\| \left\| \rho - \rho^N \right\|_{T,q} \right\|_{L^m(\Omega)} \le C \left\| \left\| \rho_0 - \rho_0^N \right\|_q \right\|_{L^m(\Omega)} + C N^{-\varkappa}$$

where

$$\varkappa = \min\left(\frac{\beta}{d}\gamma, \frac{1}{2} - \beta\left(1 + \frac{1}{d} - \frac{1}{q}\right)\right)$$

and ρ is a solution of SPDE (1) with initial condition ρ_0 .

Theorem 3. Assume (\mathbf{A}^V) , (\mathbf{A}^c) , (\mathbf{A}^F) , $K = \delta_0$, let T_{max} be the maximal existence time for (1) and fix $T \in (0, T_{max})$. In addition, let the dynamics of the particle system be given by (12) with $\nu = Id$, σ independent of the space and for any $m \geq 1$,

$$\sup_{N\in\mathbb{N}}\left\|\left\|\rho_{0}^{N}\right\|_{2}\right\|_{L^{m}(\Omega)}<\infty$$

with d=1 and $\beta\in\left(0,\frac{1}{3}\right)$. Then

$$\| \| \rho - \rho^N \|_{T,2} \|_{L^m(\Omega)} \le C \| \| \rho_0 - \rho_0^N \|_2 \|_{L^m(\Omega)} + C N^{-\varkappa}$$

where

$$\varkappa = \min\left(\frac{\beta}{2}, \frac{1}{2} - \frac{3}{2}\beta\right)$$

and ρ is a solution of SPDE (1) with initial condition ρ_0 .

In view of the previous result, we obtain a rate of convergence for the genuine empirical measure, which can be interpreted as a propagation of chaos for the marginals of the empirical measure of the particle system. Following [2, Section 8.3], let us introduce the Kantorovich-Rubinstein metric which reads, for any two probability measures μ and ν on \mathbb{T}^d ,

$$\|\mu - \nu\|_0 = \sup \left\{ \int_{\mathbb{T}^d} \phi \, d(\mu - \nu) \, ; \, \phi \text{ Lipschitz with } \|\phi\|_{L^{\infty}(\mathbb{T}^d)} \le 1 \text{ and } \|\phi\|_{\text{Lip}} \le 1 \right\}.$$

$$\tag{4}$$

Corollary 1. Let the same assumptions as in Theorem 2 or Theorem 3 be in place. Then for any $\varepsilon \in (0, \varkappa)$, there exists C > 0 such that, for any $N \in \mathbb{N}$,

$$\left\| \sup_{t \in [0,T]} \|S_t^N - \rho_t\|_0 \right\|_{L^m(\Omega)} \le C \left(\| \|S_0^N - \rho_0\|_0 \|_{L^m(\Omega)} + N^{-\varkappa + \varepsilon} \right).$$

Proof. Let $t \in (0, T_{max})$. Let us observe first that there exists C > 0 such that for any Lipschitz continuous function ϕ on \mathbb{T}^d , one has

$$\left| \left\langle \rho_t^N, \phi \right\rangle - \left\langle S_t^N, \phi \right\rangle \right| \le \frac{C \|\phi\|_{\text{Lip}}}{N^{\frac{\beta}{d}}} \quad a.s. \tag{5}$$

Indeed,

$$\begin{split} \left| \left\langle S_t^N, \phi \right\rangle - \left\langle \rho_t^N, \phi \right\rangle \right| &= \left| \left\langle S_t^N, \left(\phi - \phi * V^N \right) \right\rangle \right| \\ &\leq \left\langle S_t^N, \int_{\mathbb{T}^d} V(y) \; |\phi(\cdot) - \phi \left(\cdot - \frac{y}{N^\beta} \right) | dy \right\rangle \\ &\leq \frac{C \|\phi\|_{\mathrm{Lip}}}{N^\frac{\beta}{d}}. \end{split}$$

Recalling the definition (4) of the Kantorovich-Rubinstein distance, it comes

$$\left\| \sup_{t \in [0,T]} \left\| S_t^N - \rho_t \right\|_0 \right\|_m \le \left\| \sup_{t \in [0,T]} \left\| S_t^N - \rho_t^N \right\|_0 \right\|_m + \left\| \sup_{t \in [0,T]} \sup_{\|\phi\|_{L^{\infty}} \le 1} \left\langle \rho_t^N - \rho_t, \phi \right\rangle \right\|_m$$

$$\le \left\| \sup_{t \in [0,T]} \left\| S_t^N - \rho_t^N \right\|_0 \right\|_m + \left\| \sup_{t \in [0,T]} \left\| \rho_t^N - \rho_t \right\|_{L^1(\mathbb{T}^d)} \right\|_m,$$

where we are using the following notation for the norm in $L^m(\Omega)$: $\|\cdot\|_{L^m(\Omega)} = \|\cdot\|_m$. Now applying inequality (5) to the first term on the right-hand side of the above inequality, and Theorem 2 (or Theorem 3) to the second term, we obtain the inequality of Corollary 1.

1.5 Application for some stochastic PDE

Let A > 0 and $f_A : \mathbb{R} \to \mathbb{R}$ be a $C^2(\mathbb{R})$ bounded function such that

- 1. $f_A(x) = x$, for $x \in [-A, A]$,
- 2. $f_A(x) = A$, for x > A + 1 and $f_A(x) = -A$, for x < -(A + 1),
- 3. $||f'_A||_{\infty} \le 1$ and $||f''_A||_{\infty} < \infty$.

As a consequence, $||f_A||_{\infty} \leq A+1$. Now F_A is given by

$$F_A: (x_1, \dots, x_d)^\top \mapsto (f_A(x_1), \dots, f_A(x_d))^\top.$$
 (6)

When $A = \infty$ then $F_A = Id$. Now, we consider the stochastic PDE

$$d\rho_t = \frac{1}{2}\Delta\rho_t dt - \nabla \cdot \left(\rho_t(K * \rho_t)\right) dt - \nabla\rho_t \cdot \sigma_t \circ dB_t \tag{7}$$

where the integral is in the Stratonovich sense, or equivalently in Itô formulation

$$d\rho_t = \frac{1}{2} \left(\Delta \rho_t + \sum_{i,j=1}^d \partial_{ij} \rho_t \sum_{k=1}^d \sigma_t^{ik} \sigma_t^{jk} \right) dt - \nabla \cdot \left(\rho_t (K * \rho_t) \right) dt - \nabla \rho_t \cdot \sigma_t dB_t.$$
 (8)

We consider the associated stochastic moderate particle system

$$dX_t^{i,N} = F_A\left(K * \rho_t^N\left(X_t^{i,N}\right)\right) dt + dW_t^i + \sigma_t dB_t \tag{9}$$

and also the particle system without cutoff:

$$d\widetilde{X}_{t}^{i,N} = \frac{1}{N} \sum_{k=1}^{N} (K * V^{N}) (\widetilde{X}_{t}^{i,N} - \widetilde{X}_{t}^{k,N}) dt + dW_{t}^{i} + \sigma_{t} dB_{t}, \quad t \leq T, \quad 1 \leq i \leq N.$$
(10)

For fixed $N \in \mathbb{N}^*$, the drift term is smooth and bounded. Hence, this particle system has a unique strong solution. We denote by \widetilde{S}_t^N its empirical distribution, and define $\widetilde{\rho}^N = V^N * \widetilde{S}^N$. We denote $A_T := C_K \left\| \|\rho\|_{T,q} \right\|_{L^{\infty}(\Omega)}$ where C_K is given by (\mathbf{A}^K) and ρ is the unique solution of equation (8). Then ρ is also the unique solution of the equation

$$d\rho_t = \frac{1}{2} \left(\Delta \rho_t + \sum_{i,j=1}^d \partial_{ij} \rho_t \sum_{k=1}^d \sigma_t^{ik} \sigma_t^{jk} \right) dt - \nabla \cdot \left(\rho_t F_A(K * \rho_t) \right) dt - \nabla \rho_t \cdot \sigma_t dB_t$$
(11)

The proof of the following result is based on Corollary 2.3 in [43].

Corollary 2. Assume (\mathbf{A}^c) , (\mathbf{A}^V) , (\mathbf{A}^I) and (\mathbf{A}^K) and let ρ the unique solution of the SPDE (7) in $L^q_{\mathcal{F}^B}\left([0,T];H^1_q\left(\mathbb{T}^d\right)\right)\cap S^\infty_{\mathcal{F}^B}\left([0,T];L^1\cap L^q\left(\mathbb{T}^d\right)\right)$, given by Theorem 1. In addition, let the dynamics of the particle system be given by (10) and for any $m \geq 1$,

$$\sup_{N \in \mathbb{N}} \left\| \left\| \widetilde{\rho}_0^N \right\|_q \right\|_{L^m(\Omega)} < \infty$$

with $d \ge 1$, q > d given by (\mathbf{A}^K) and $\beta \in \left(0, \frac{1}{2\left[1 + \frac{1}{d} - \frac{1}{q}\right]}\right)$. Then we have

$$\mathbb{P}\left(\left\|\widetilde{\rho}_{t}^{N}-\rho_{t}\right\|_{T,q}\geq\eta\right)\leq\frac{C}{\eta^{m}}\left(\left\|\left\|\widetilde{\rho}_{0}^{N}-\rho_{0}\right\|_{T,q}\right\|_{L^{m}(\Omega)}+CN^{-\varkappa}\right)^{m}.$$

Proof. Let us introduce some notations to distinguish the particle systems with and without cutoff. We fix $A > A_T$ to be precisely chosen later. We consider the particles $(X^{i,N})_{1 \le i \le N}$ and $(\widetilde{X}^{i,N})_{1 \le i \le N}$ defined respectively by (9) and (10) with the same initial conditions and driven by the same family of independent \mathbb{T}^d -valued Brownian motions $(W^i)_{i \in \mathbb{N}^*}$ and B_t . For any $N \in \mathbb{N}^*$ and A > 0, define

$$\Omega_{N,A} = \left\{ \sup_{\substack{t \in [0,T]\\i \in \{1,...,N\}}} \frac{1}{N} \left| \sum_{k=1}^{N} (K * V^{N}) \left(X_{t}^{i,N} - X_{t}^{k,N} \right) \right| \le A \right\}$$

and observe that on $\Omega_{N,A}$, we have $X_t^{i,N} = \widetilde{X}_t^{i,N}$ for all $t \in [0,T]$ and all $i \in \{1,\ldots,N\}$. Since $\frac{1}{N} \sum_{k=1}^N \left(K*V^N\right) \left(X_t^{i,N} - X_t^{k,N}\right) = K*\rho_t^N(X_t^{i,N})$, we also get that on $\Omega_{N,A}$, $\rho_t^N = \widetilde{\rho}_t^N$ for all $t \in [0,T]$ and all $i \in \{1,\ldots,N\}$. Hence

$$\mathbb{P}\left(\left\|\widetilde{\rho}^{N} - \rho\right\|_{T,q} \ge \eta\right) = \mathbb{P}\left(\Omega_{N,A}^{c} \cap \left\{\left\|\widetilde{\rho}^{N} - \rho\right\|_{T,q} \ge \eta\right\}\right) + \mathbb{P}\left(\Omega_{N,A} \cap \left\{\left\|\widetilde{\rho}^{N} - \rho\right\|_{T,q} \ge \eta\right\}\right) \le \mathbb{P}\left(\Omega_{N,A}^{c}\right) + \mathbb{P}\left(\left\|\rho^{N} - \rho\right\|_{T,q} \ge \eta\right).$$

Now by hypothesis we have that $\left|K*\rho_t^N\left(X_t^{i,N}\right)\right| \leq C_K \|\rho^N\|_{T,q}$. Thus we get that for $A = C_K\left(\eta + \left\| \|\rho\|_{T,q} \right\|_{L^\infty(\Omega)}\right)$,

$$\begin{split} \mathbb{P}\left(\Omega_{N,A}^{c}\right) &\leq \mathbb{P}\left(\left\|\rho^{N}\right\|_{T,q} > \frac{A}{C_{K}}\right) \\ &\leq \mathbb{P}\left(\left\|\rho\right\|_{T,q} + \left\|\rho^{N} - \rho\right\|_{T,q} > \frac{A}{C_{K}}\right) \\ &\leq \mathbb{P}\left(\left\|\left\|\rho\right\|_{T,q}\right\|_{L^{\infty}(\Omega)} + \left\|\rho^{N} - \rho\right\|_{T,q} > \frac{A}{C_{K}}\right) \\ &\leq \mathbb{P}\left(\left\|\rho^{N} - \rho\right\|_{T,q} > \eta\right). \end{split}$$

Hence

$$\mathbb{P}\left(\left\|\widetilde{\rho}^{N} - \rho\right\|_{T,q} \ge \eta\right) \le 2\mathbb{P}\left(\left\|\rho^{N} - \rho\right\|_{T,q} > \eta\right).$$

Now using Markov's inequality and Theorem 2 with $F(x, u) = F_A(u)$, we obtain the desired result.

Biot-Savart kernel and the 2d Navier-Stokes equation. By considering the vorticity field ξ_t associated to the stochastic incompressible two-dimensional Navier-Stokes solution ρ_t , one gets equation (8) with the Biot-Savart kernel $K(x) = \frac{i}{2\pi} \sum_{k \in \mathbb{Z}^2, k \neq 0} \exp(ik \cdot x) \frac{k^{\perp}}{k^2}$. The original Navier-Stokes solution is then recovered thanks to the formula $\rho_t = K * \xi_t$. The kernel $K \in L^p(\mathbb{T}^2)$ with p < 2 and $\|\nabla K * f\|_q \le C\|f\|_q$ with $1 < q < \infty$. Then $\|K * f\|_{1,q} \le C\|f\|_q$ with q > 2, thus by Sobolev embedding $\|K * f\|_{C^{1-\frac{2}{q}}(\mathbb{T}^2)} \le C\|f\|_q$. This model arises naturally in fluid mechanics; see, for instance, [4] and [22]. This case is covered by Corollary 2, also we can apply theorem 2 with cutoff $A > C_K \|\|\rho\|_{T,q} \|_{L^{\infty}(\Omega)}$ in the SPDE (11) where C_K is given by (\mathbf{A}^K) .

Parabolic-elliptic Keller-Segel models in any dimension. An important and tricky example covered by this paper is the parabolic-elliptic Keller-Segel PDE, which takes the form (8) where the kernel K is the periodization of the function defined on \mathbb{T}^d by $K_0(x) = -\chi_d \frac{x}{|x|^d}$ for some $\chi_d > 0$. The K verifies for all $f \in L^q(\mathbb{T}^d)$, $\|K * f\|_{C^{1-\frac{d}{q}}} \leq C \|f\|_{L^q(\mathbb{T}^d)}$, see Lemma 41 in [44]. This case is also covered by Corollary 2, also we can apply theorem 2 with cutoff $A > C_K \|\|\rho\|_{L^\infty(\Omega)}$ in the SPDE (11) where C_K is given by (\mathbf{A}^K) .

Burgers Equation. When $d=1, K=\delta_0$ the equation (7)-(8) is the well-known stochastic scalar Burgers equation. If the initial condition $\rho_0 \in H_2^2$ then by lemma 4.10 in [1] the solution verifies the maximum principle, that is, $\|\rho\|_{\infty} \leq C_T \|\rho_0\|_{\infty}$. Taking $A > C_T \|\rho_0\|$ the solution of the equation (8) is also solution of the equation (11). The Theorem 3 covers this case.

1.6 Heuristic deduction

For the ease of reading, we may write X_t^i in place of $X_t^{i,N}$. The starting $X_0^{i,N}$ are i.i.d. with common law μ_0 with density ρ_0 . Let $x \in \mathbb{T}^d$. Applying Itô's formula with the smooth function $V^N(x-\cdot)$ for each $i \in \{1, \ldots, N\}$ we have

$$\begin{split} V^{N}\left(x-X_{t}^{i}\right) &= V^{N}\left(x-X_{0}^{i}\right) \\ &-\sum_{j=1}^{d} \int_{0}^{t} \partial_{j} V^{N}\left(x-X_{s}^{i}\right) F_{j}\left(X_{s}^{i}, K * \rho_{s}^{N}\left(X_{s}^{i}\right)\right) \, ds \\ &+\frac{1}{2} \sum_{j,k=1}^{d} \int_{0}^{t} \partial_{jk} V^{N}\left(x-X_{s}^{i}\right) \left(\sigma \sigma^{\top}\right)_{s}^{jk}\left(X_{s}^{i}\right) ds \\ &-\sum_{j,k=1}^{d} \int_{0}^{t} \partial_{j} V^{N}\left(x-X_{s}^{i}\right) \sigma_{s}^{jk}\left(X_{s}^{i}\right) \, dB_{s}^{k} \\ &-\sum_{j,k=1}^{d} \int_{0}^{t} \partial_{j} V^{N}\left(x-X_{s}^{i}\right) \nu_{s}^{jk}\left(X_{s}^{i}\right) \, dW_{s}^{i,k} \\ &+\frac{1}{2} \sum_{j,k=1}^{d} \int_{0}^{t} \partial_{jk} V^{N}\left(x-X_{s}^{i}\right) \left(\nu \nu^{\top}\right)_{s}^{jk}\left(X_{s}^{i}\right) \, ds. \end{split}$$

with $(\sigma\sigma^{\top})_s^{jk} \doteq \sum_{l=1}^d \sigma_s^{jl} \sigma_s^{kl}$ and $(\nu\nu^{\top})_s^{jk} \doteq \sum_{l=1}^d \nu_s^{jl} \nu_s^{kl}$. Then since $\rho^N = V^N * S^N$ we have

- \sum_{j,k=1}^d \int_0^t \left\langle S_s^N, \partial_j V^N(x - \cdot) \sigma_s^{jk}(\cdot) \right\rangle dB_s^k
- \frac{1}{N} \sum_{i=1}^N \sum_{j,k=1}^d \int_0^t \partial_j V^N\left(x - X_s^i\right) \nu_s^{jk} \left(X_s^i\right) dW_s^{i,k}
+ \frac{1}{2} \sum_{i,k=1}^d \int_0^t \left\langle S_s^N, \partial_{jk} V^N(x - \cdot) \left(\nu \nu^\top\right)_s^{jk} \left(\cdot\right) \right\rangle ds.$$
(12)

If σ and ν do not depend on the spatial variable we obtain

- \frac{1}{N} \sum_{i=1}^N \sum_{j,k=1}^d \int_0^t \partial_j V^N \left(x - X_s^i \right) \nu_s^{jk} dW_s^{i,k} \qquad \left(= \nu_s^\top \nabla V^N (x - X_s^i) dW_s^i \right)
+ \frac{1}{2} \sum_{j,k=1}^d \int_0^t \partial_{jk} \rho_s^N \left(\nu \nu^\top \right)_s^{jk} ds.$$

Under these conditions, we may conjecture that a limiting measure-valued deterministic process ρ_t exists and its evolution equation (in weak form) is given by

$$d\rho_t = \frac{1}{2} \sum_{i,j=1}^d \partial_{ij} \left(\rho_t \sum_{k=1}^d (\nu_t^{ik} \nu_t^{jk} + \sigma_t^{ik} \sigma_t^{jk}) \right) dt - \nabla \cdot \left(\rho_t F(\cdot, K * \rho_t) \right) dt - \nabla \rho_t \cdot \sigma_t dB_t.$$

1.7 Definition of solution

Definition 1.1. A family of random functions $\{\rho_t(\omega): t \geq 0, \omega \in \Omega\}$ lying in $S_{\mathcal{F}^B}^{\infty}([0,T]; L^1 \cap L^q(\mathbb{T}^d))$ is a solution to (1) if ρ_t satisfies the following stochastic integral equation for all $\phi \in C^2(\mathbb{T}^d)$,

$$+ \int_0^t \left\langle \rho_s, \sum_{i=1}^d \partial_i \phi \sum_{k=1}^d \sigma_s^{ik} \right\rangle dB_s^k. \tag{15}$$

Remark 1. Let $q \geq 2$. The following will be helpful throughout the text.

(i)

Proof. Applying to $(\rho - \rho^N)$ the Itô's formula for the L^q -norm of a H^1_q -valued process in [35] we have

Integration by parts gives us (recall that σ does not depend on the spatial

variable)

= -\frac{1}{2} \int_{0}^{t} \int_{\mathbb{T}^{d}} q (q-1) \left|\rho_{s} - \rho_{s}^{N}\right|^{q-2} \left|\sigma_{s}^{T} \nabla (\rho_{s} - \rho_{s}^{N})\right|^{2} dx ds,$$

hence we get

$$- M_{t}^{N}, \tag{16}$$

where

$$I_{1} \doteq q(q-1) \int_{0}^{t} \int_{\mathbb{T}^{d}} |\rho_{s} - \rho_{s}^{N}|^{q-2} \nabla(\rho_{s} - \rho_{s}^{N}) \Big[\rho_{s} F\left(x, K * \rho_{s}\right) - \left\langle S_{s}^{N}, V^{N}(x-\cdot) F\left(\cdot, K * \rho_{s}^{N}\right) \right\rangle \Big] dx ds,$$

$$I_{2} \doteq \frac{1}{2N^{2}} \sum_{i=1}^{N} \int_{0}^{t} \int_{\mathbb{T}^{d}} q(q-1) \left| \rho_{s} - \rho_{s}^{N} \right|^{q-2} \left| \left(\nabla V^{N} \right) (x - X_{s}^{i}) \right|^{2} dx ds,$$

and

If q > 2, by Young inequality with $\frac{1}{\frac{q}{q-2}} + \frac{1}{\frac{q}{2}} = 1$ we obtain

Now by (22),

where in the last inequality we are using that supp $V \subset \{x \in \mathbb{R}^d \mid |x| < \frac{1}{2}\}$. We add and subtract the terms $F(x, K * \rho_s^N)\rho_s$ and $F(x, K * \rho_s^N)\rho_s^N$ to deduce

Now, using ϵ -Young inequality for $\frac{1}{2} + \frac{1}{2} = 1$, we get

$$\begin{split} &|\nabla(\rho_{s}-\rho_{s}^{N})|(a+b+c)\\ &\leq \epsilon|\nabla(\rho_{s}-\rho_{s}^{N})|^{2}+C_{\epsilon}(a+b+c)^{2}\\ &\leq \epsilon|\nabla(\rho_{s}-\rho_{s}^{N})|^{2}+C_{\epsilon}3L^{2}\left(\left|K*(\rho_{s}-\rho_{s}^{N})\right|^{2}|\rho_{s}|^{2}+|\rho_{s}-\rho_{s}^{N}|^{2}+C_{N}^{2}|\rho_{s}^{N}|^{2}\right) \end{split}$$

where $C_N \doteq N^{-\frac{\beta}{d}} + \|\rho_s^N\|_q N^{-\frac{\beta}{d}\gamma}$. For the other constants, we will merge them into C, which may change from line to line. Thus we have

$$|I_{1}| \leq \epsilon \int_{0}^{t} \int_{\mathbb{T}^{d}} q(q-1)|\rho_{s} - \rho_{s}^{N}|^{q-2}|\nabla(\rho_{s} - \rho_{s}^{N})|^{2} dx ds$$

$$+ C \int_{0}^{t} \int_{\mathbb{T}^{d}} |\rho_{s} - \rho_{s}^{N}|^{q} dx ds.$$

$$+ C \int_{0}^{t} \int_{\mathbb{T}^{d}} |\rho_{s} - \rho_{s}^{N}|^{q-2} (|K * (\rho_{s} - \rho_{s}^{N})|^{2} |\rho_{s}|^{2} + C_{N}^{2} |\rho_{s}^{N}|^{2}) dx ds.$$

We continue with the last term above. For q>2, we use 1-Young inequality for $\frac{1}{q}+\frac{1}{q}=1$,

$$\begin{split} & \int_0^t \int_{\mathbb{T}^d} |\rho_s - \rho_s^N|^{q-2} \left(\left| K * (\rho_s - \rho_s^N) \right|^2 |\rho_s|^2 + C_N^2 |\rho_s^N|^2 \right) dx \, ds \\ & \leq C \int_0^t \int_{\mathbb{T}^d} |\rho_s - \rho_s^N|^q \, dx \, ds + C \int_0^t \int_{\mathbb{T}^d} \|K * (\rho_s - \rho_s^N)\|_{\infty}^q |\rho_s|^q + C_N^q |\rho_s^N|^q \, dx \, ds \\ & \leq C \int_0^t \|\rho_s - \rho_s^N\|_q^q \, ds + C \|\rho\|_{T,q}^q \int_0^t \|\rho_s - \rho_s^N\|_q^q \, ds + C T \, C_N^q \|\rho^N\|_{T,q}^q \end{split}$$

where in the last inequality we are using (\mathbf{A}^K) . Now, using that $\|\rho\|_{T,q} \leq C$ a.s. due to Theorem 1, we arrive at

$$+ |M_{t}^{N}|.$$

By Jensen's inequality with $|\cdot|^{\frac{m}{q}}, \frac{m}{q} > 1$ we have for all $r \in [0,T]$

$$\mathbb{E}\left(\sup_{t\in[0,r]}\left\|\rho_{t}-\rho_{t}^{N}\right\|_{q}\right)^{m} \leq C \,\mathbb{E}\left(\left\|\rho_{0}-\rho_{0}^{N}\right\|_{q}\right)^{m} \\
+ C \int_{0}^{r} \mathbb{E}\left(\sup_{t\in[0,s]}\left\|\rho_{t}-\rho_{t}^{N}\right\|_{q}\right)^{m} ds \\
+ C N^{\left(-\frac{1}{2}+\beta\left(1+\frac{1}{d}-\frac{1}{q}\right)\right)m} \\
+ C \left(N^{-\frac{\beta}{d}}\right)^{m} \mathbb{E}\left\|\rho^{N}\right\|_{T,q}^{m} \\
+ C \left(N^{-\frac{\beta}{d}\gamma}\right)^{m} \mathbb{E}\left(\left\|\rho^{N}\right\|_{T,q}\left\|\rho^{N}\right\|_{T,q}\right)^{m} \\
+ C \mathbb{E}\left(\sup_{t\in[0,r]}\left|M_{t}^{N}\right|\right)^{\frac{m}{q}}.$$

Now we need a uniform in $N \in \mathbb{N}$ estimate for the regularized empirical measure, for which the proof is given in the Appendix A .

Lemma 4. Under the hypotheses of Theorem 2 or 3, we have the following:

$$+C\left(N^{-\frac{\beta}{d}}\right)^{m}$$

$$+C\left(N^{-\frac{\beta}{d}\gamma}\right)^{m}$$

$$+CN^{\left(-\frac{1}{2}+\beta\left(1+\frac{1}{d}-\frac{1}{q}\right)\right)m}$$

Now take r = T. Grönwall's Lemma implies

and since $\gamma \leq 1$, we end up with

$$I_{1} \doteq 2 \int_{0}^{t} \int_{\mathbb{T}} \nabla(\rho_{s} - \rho_{s}^{N}) \left[\rho_{s} F\left(x, \rho_{s}\right) - \left\langle S_{s}^{N}, V^{N}(x - \cdot) F\left(\cdot, \rho_{s}^{N}(\cdot)\right) \right\rangle \right] dx ds,$$

$$I_{2} \doteq \frac{1}{N^{2}} \sum_{i=1}^{N} \int_{0}^{t} \int_{\mathbb{T}} \left| \left(\nabla V^{N} \right) \left(x - X_{s}^{i} \right) \right|^{2} dx ds,$$

and

$$M_t^N \doteq \frac{2}{N} \sum_{i=1}^N \int_0^t \int_{\mathbb{T}} (\rho_s - \rho_s^N) \left(\nabla V^N \right) (x - X_s^i) \, dx \, dW_s^i.$$

By denoting $\hat{C}_N \doteq N^{-\beta} + \left\| \rho_s^N \right\|_{\frac{1}{2}} N^{-\frac{\beta}{2}}$, the ϵ -Young inequality yields

$$+ 4\epsilon L \int_{0}^{t} \|\nabla(\rho_{s} - \rho_{s}^{N})\|_{2}^{2} ds + C_{\epsilon} 2L \int_{0}^{t} \|\rho_{s} - \rho_{s}^{N}\|_{2}^{2} ds$$

$$+ C_{\epsilon} 4L \left(N^{-2\beta} + \int_{0}^{T} \|\rho_{s}^{N}\|_{\frac{1}{2}}^{2} N^{-2\frac{\beta}{2}} ds \right) T \|\rho^{N}\|_{T,2}^{2}.$$

Finally, taking $\epsilon < \frac{1}{6L}$, the previous estimates lead to

Since $\|\|\rho\|_{T,2}\|_{L^{\infty}(\Omega)} < \infty$, by Jensen's inequality with $\|\cdot\|^{\frac{m}{2}}, \frac{m}{2} > 1$ we have for all $r \in [0,T]$

+ C\left(N^{-\frac{\beta}{2}}\right)^{m} \mathbb{E}\left(\|\rho^{N}\|_{T,2} \|\rho^{N}\|_{L^{2}C^{\frac{1}{2}}}\right)^{m} \\

Now for $q \geq 2$, by a change of variables we have

$$I_{1} = \int_{0}^{t} \int_{\mathbb{T}^{d}} q(q-1) \left| \rho_{s}^{N} \right|^{q-2} \nabla \rho_{s}^{N} \left\langle S_{s}^{N}, V^{N}(x-\cdot) F\left(\cdot, K * \rho_{s}^{N}\right) \right\rangle dx ds$$

$$\leq \|F\|_{\infty} \int_{0}^{t} \int_{\mathbb{T}^{d}} q(q-1) \left| \rho_{s}^{N} \right|^{q-2} \left| \nabla \rho_{s}^{N} \right| \left| \rho_{s}^{N} \right| dx ds.$$

By ϵ -Young inequality with $\frac{1}{2} + \frac{1}{2} = 1$ we get

$$I_{1} \leq C_{\epsilon} q(q-1) \|F\|_{\infty}^{2} \int_{0}^{t} \|\rho_{s}^{N}\|_{q}^{q} ds$$

Thus, we join the estimates with $\epsilon < \frac{1}{2}$ and continue from (20):

$$+ |M_{t}^{N}|.$$
(24)

Taking the supremum, applying Jensen's inequality, and then taking the expectation, we obtain:

+ C\left(C_{\epsilon}q(q-1)\|F\|_{\infty}^2 + \frac{q(q-1)}{2}1_{[q>2]}\right)^{\frac{m}{q}} \int_0^r \mathbb{E}\left(\sup_{t\in[0,s]} \|\rho_t^N\|_q\right)^m ds \\
+ C\left(\frac{q(q-1)}{2}T\right)^{\frac{m}{q}} N^{\left(-\frac{1}{2} + \beta(1 + \frac{1}{d} - \frac{1}{q})\right)m} \|\nabla V\|_q^m \\
+ C\mathbb{E}\left(\sup_{t\in[0,r]} |M_t^N|\right)^{\frac{m}{q}}.$$
(25)

Finally, from (25) and lemma 6 we deduce

Taking r = T and Grönwall's Lemma, we conclude that

Lemma 6. Under the assumptions of Theorem 2 or 3, it holds that

$$\lesssim \mathbb{E} \left| \frac{1}{N^2} \sum_{i=1}^N \int_0^r \left(\int_{\mathbb{T}^d} q \left| \rho_s^N \right|^{q-1} (\nabla V^N) (x - X_s^i) \, dx \right)^2 ds \right|^{\frac{m}{2q}}$$

$$= \mathbb{E} \left| \frac{1}{N} \sum_{i=1}^N \int_0^r \left(\int_{\mathbb{T}^d} q \left| \rho_s^N \right|^{q-1} \frac{1}{N^{\frac{1}{2}}} (\nabla V^N) (x - X_s^i) \, dx \right)^2 ds \right|^{\frac{m}{2q}}$$

where in the last equality we moved a power of N inside the integral. Now by Young's inequality with $\frac{1}{q-1} + \frac{1}{q}$ and Jensen's inequality,

$$\begin{split} E|M_r^N|^{\frac{m}{q}} &\lesssim \mathbb{E} \left| \frac{1}{N} \sum_{i=1}^N \int_0^r \left(\int_{\mathbb{T}^d} \left| \rho_s^N \right|^q dx \right)^2 ds \right|^{\frac{m}{2q}} \\ &+ \mathbb{E} \left| \frac{1}{N} \sum_{i=1}^N \int_0^r \left(\int_{\mathbb{T}^d} \frac{1}{N^{q/2}} |(\nabla V^N)(x - X_s^i)|^q dx \right)^2 ds \right|^{\frac{m}{2q}} \\ &\lesssim \mathbb{E} \int_0^r \|\rho_s^N\|_q^m ds \\ &+ \frac{1}{N^{\frac{m}{2}}} \left| \int_0^r \left(\int_{\mathbb{T}^d} |(\nabla V^N)(x)|^q dx \right)^2 ds \right|^{\frac{m}{2q}} \end{split}$$

where in the last inequality, we have applied a change of variables. Finally, by (22)

$$\begin{split} E \left| M_r^N \right|^{\frac{m}{q}} &\lesssim \mathbb{E} \int_0^r \left\| \rho_s^N \right\|_q^m ds \\ &+ N^{-\frac{m}{2}} \left(T N^{\left(2q\beta(1 + \frac{1}{d}) - 2\beta \right)} \left\| \nabla V \right\|_q^{2q} \right)^{\frac{m}{2q}} \\ &\lesssim \mathbb{E} \int_0^r \left\| \rho_s^N \right\|_q^m ds \\ &+ N^{\left(-q + 2q\beta(1 + \frac{1}{d}) - 2\beta \right) \frac{m}{2q}} \left\| \nabla V \right\|_q^m \\ &\lesssim \int_0^r \mathbb{E} \left(\sup_{t \in [0,s]} \left\| \rho_t^N \right\|_q \right)^m ds \\ &+ N^{\left(-\frac{1}{2} + \beta(1 + \frac{1}{d} - \frac{1}{q}) \right) m} \left\| \nabla V \right\|_q^m. \end{split}$$

B Well-posedness of limiting equation (1)

Here, we will prove the well posedness of the limiting equation for the system of particles in a suitable space. We will adapt the strategy of [31].

Proof of Theorem 1. The proof is divided into two parts. First, we solve the linearized problem using the L^q -Theory of SPDEs. Next, we make a contraction argument to yield the solution of the original equation as a fixed point of the solution map.

Let

with metric $d(\rho, \rho') \doteq \left\| \|\rho - \rho'\|_{T,q} \right\|_{L^{\infty}(\Omega)}$, $\kappa = \|\rho_0\|_q$ and ℓ is a positive constant to be determined.

We define the operator $\mathcal{T}: \mathbb{B} \to S^{\infty}_{\mathcal{F}^B}\left([0,T];L^q\left(\mathbb{T}^d\right)\right)$ as follows: for each $\xi \in \mathbb{B}$, let $\mathcal{T}(\xi) := \rho^{\xi}$ be the solution to the following linear SPDE:

-\nabla \rho_t \cdot \sigma_t dB_t \\
\rho_0 \text{ is given.}
\end{cases} \tag{27}$$

where

$$f_{t}(\rho) \doteq -\nabla \cdot (\rho_{t} F(\cdot, K * \xi_{t})) + \sum_{i,j=1}^{d} \partial_{j} \rho_{t} \partial_{i} \left((\nu \nu^{\top})_{t}^{ij} + (\sigma \sigma^{\top})_{t}^{ij} \right)$$

$$+ \frac{1}{2} \rho_{t} \sum_{i,j=1}^{d} \partial_{ij} \left((\nu \nu^{\top})_{t}^{ij} + (\sigma \sigma^{\top})_{t}^{ij} \right)$$

$$= -\nabla \cdot (\rho_{t} F(\cdot, K * \xi_{t})) + 2 \sum_{j=1}^{d} \partial_{j} \rho_{t} \sum_{i=1}^{d} \partial_{i} a_{t}^{ij} + \rho_{t} \sum_{i,j=1}^{d} \partial_{ij} a_{t}^{ij}$$

and

$$a_t^{ij} \doteq \frac{1}{2} \sum_{k=1}^d \left(\nu_t^{ik} \nu_t^{jk} + \sigma_t^{ik} \sigma_t^{jk} \right).$$

We now proceed to verify the conditions 5.1–6 of Theorem 5.1 in [35]. For the reader's convenience, we restate these conditions below using our notations:

5.1 There exist $\Lambda, \lambda > 0$ such that

- 5.4 For any $u \in H_q^1$, $f_t(u)$ is predictable as a function taking values in H_q^{-1} .
- 5.5 For any $i, j \in \{1, ..., d\}$ and $t \ge 0$,

5.6 For any $\epsilon > 0$, there exists $C_{\epsilon} > 0$, such that, for any $t \geq 0$ and $u_t, v_t \in H_q^1$, we have

Now note that the condition 5.1 is exactly (\mathbf{A}_{iii}^c) . The conditions 5.2, 5.3 and 5.5 are verified by assumption (\mathbf{A}_i^c) . For condition 5.4, note that $f_t(u)$ is a composition of predictable functions.

For the remaining one, 5.6, we notice that if F is given by (\mathbf{A}^F) (thus bounded) and K by (\mathbf{A}^K) , we have for all $u_t, v_t \in H_q^1$,

by the interpolation inequality. On the other hand, if we assume (\mathbf{A}^I) and (\mathbf{A}^K) we have for all $u_t, v_t \in H_q^1$,

by the interpolation inequality and using $\xi \in \mathbb{B}$. Recall that $||K * f||_{\infty} \le C_K ||f||_q$, for q given by (\mathbf{A}^K) .

For the remaining terms in $f_t(\rho)$, we have

$$\begin{split} & \left\| \partial_{j}(u_{t} - v_{t}) \, \partial_{i} a_{t}^{ij} \right\|_{-1,q} \\ &= \sup_{\|\phi\|_{1,q'} = 1} \left(\partial_{j}(u_{t} - v_{t}) \, \partial_{i} a_{t}^{ij}, \phi \right)_{-1,1} \\ &= \sup_{\|\phi\|_{1,q'} = 1} \left((u_{t} - v_{t}) \, \partial_{i} a_{t}^{ij}, -\partial_{j} \phi \right)_{-1,1} + \sup_{\|\phi\|_{1,q'} = 1} \left((u_{t} - v_{t}) \, \partial_{ji} a_{t}^{ij}, -\phi \right)_{-1,1} \\ &\leq \sup_{\|\phi\|_{1,q'} = 1} \left(\|\partial_{j} \phi\|_{q'} \, \|(u_{t} - v_{t}) \, \partial_{i} a_{t}^{ij} \|_{q} + \|\phi\|_{1,q'} \|(u_{t} - v_{t}) \, \partial_{ij} a_{t}^{ij} \|_{q} \right) \\ &\leq 2 \, \|a_{t}^{ij}\|_{C^{2}} \|u_{t} - v_{t}\|_{q} \end{split}$$

where the Hölder's inequality was applied in the second-to-last inequality. Then again, interpolation inequality yields the estimate that verifies assumption 5.6.

Notice that the initial condition $\rho_0 \in H_q^{1-\frac{2}{q}}\left(\mathbb{T}^d\right)$ is deterministic, therefore, we have by Theorem 5.1 in [35] that the linear SPDE (26) admits a unique solution $\rho^{\xi} \in L_{\mathcal{F}B}^q\left([0,T];H_q^1\left(\mathbb{T}^d\right)\right)$ (see Definition 3.1 in [35]). In addition, since Theorem 7.1 (iii) in [35] holds for $q \geq 2$ (by Theorem 4.2 in [35]) and $\|\rho_t\|_1 = \|\rho_0\|_1 = 1$, a.s., we have $\rho^{\xi} \in S_{\mathcal{F}B}^q\left([0,T];L^1 \cap L^q\left(\mathbb{T}^d\right)\right)$. Moreover, by the maximum principle (Theorem 5.12 in [35]) $\rho^{\xi}(t,\cdot) \geq 0$, a.s..

We now check that ρ^{ξ} is also in $S_{\mathcal{F}^B}^{\infty}\left([0,T];L^1\cap L^q\left(\mathbb{T}^d\right)\right)$, and we drop the superscript ξ to ease the computations. For the following, if not mentioned, we are assuming (\mathbf{A}^F) and (\mathbf{A}^K) , and we make observations about the other sets of assumptions. Applying the Itô's formula for the L^q -norm of a H_q^1 -valued process in [35],

$$- \int_{\mathbb{T}^{d}} \int_{0}^{t} q |\rho_{s}(x)|^{q-2} \rho_{s}(x) \nabla \rho_{s}(x) \cdot \sigma_{s}(x) dB_{s} dx$$

$$+ \frac{1}{2} \int_{\mathbb{T}^{d}} \int_{0}^{t} q(q-1) |\rho_{s}(x)|^{q-2} |\sigma_{s}^{\top}(x) \nabla \rho_{s}(x)|^{2} ds dx$$

$$= (I) + (III) + (III) + (IV).$$
(28)

Above, $A \cdot B \doteq \sum_{i,j} A_{ij} B_{ij}$. Using stochastic Fubini and integration by parts, we handle each term separately. Notice that under assumption (\mathbf{A}_{ii}^c) , i.e., $\sum_i \partial_i \sigma_i^{ik} = 0$ we have

For the first one, after integration by parts, we use ϵ -Young inequality with $\frac{1}{2} + \frac{1}{2} = 1$

$$= q(q-1) \int_{0}^{t} \int_{\mathbb{T}^{d}} |\rho_{s}(x)|^{q-2} \rho_{s}(x) \nabla \rho_{s}(x) \cdot F(x, K * \xi_{s}) \, dx \, ds$$

$$\leq q(q-1) L \int_{0}^{t} \int_{\mathbb{T}^{d}} |\rho_{s}(x)|^{q-2} \rho_{s}(x) |\nabla \rho_{s}(x)| \, dx \, ds \qquad (29)$$

$$\leq q(q-1) L \int_{0}^{t} \int_{\mathbb{T}^{d}} |\rho_{s}(x)|^{q-2} \left(C_{\epsilon} \rho_{s}(x)^{2} + \epsilon |\nabla \rho_{s}(x)|^{2} \right) \, dx \, ds$$

$$= q(q-1) L C_{\epsilon} \int_{0}^{t} \|\rho_{s}\|_{q}^{q} \, ds + \epsilon \, q(q-1) L \int_{0}^{t} \int_{\mathbb{T}^{d}} |\rho_{s}|^{q-2} |\nabla \rho_{s}|^{2} \, dx \, ds$$

Above, we used (\mathbf{A}^F) so that F is bounded by L. In fact, if one assumes (\mathbf{A}^I) and (\mathbf{A}^K) , (29) implies that the first term in (II) reads

$$\leq C_{\epsilon} q(q-1) C_K^2 \kappa^2 \ell^2 \int_0^t \|\rho_s\|_q^q \, ds + \epsilon \, q(q-1) \int_0^t \int_{\mathbb{T}^d} |\rho_s|^{q-2} |\nabla \rho_s|^2 \, dx \, ds,$$

since $||K * \xi_s||_{L^{\infty}} \le C_K ||\xi_s||_q \le C_K \kappa \ell$. For the second (II),

$$-\int_{0}^{t} \int_{\mathbb{T}^{d}} q |\rho_{s}(x)|^{q-2} \rho_{s}(x) \left(2 \sum_{ij} \partial_{j} \rho_{s} \, \partial_{i} a_{s}^{ij} + \rho_{s} \sum_{ij} \partial_{ij} a_{s}^{ij}\right) dx \, ds$$

$$\leq \int_{0}^{t} \int_{\mathbb{T}^{d}} 2q |\rho_{s}|^{q-2} \rho_{s} \left| \sum_{ij} (\partial_{j} \rho_{s} \, \partial_{i} a_{s}^{ij}) \right| dx \, ds + q \int_{0}^{t} \sum_{ij} \|a_{s}^{ij}\|_{C^{2}} \|\rho_{s}\|_{q}^{q} \, ds$$

$$\leq \int_{0}^{t} \int_{\mathbb{T}^{d}} 2q |\rho_{s}|^{q-2} \rho_{s} |\nabla \rho_{s}| \left(\sum_{i} \left(\sum_{i} \partial_{i} a_{s}^{ij} \right)^{2} \right)^{\frac{1}{2}} dx \, ds + q M \int_{0}^{t} \|\rho_{s}\|_{q}^{q} \, ds$$

where we used Cauchy-Schwarz inequality. In order to apply the Grönwall's lemma, the second term above is already suitable, while the first one, after bounding the a^{ij} term with its L^{∞} norm provided in (\mathbf{A}^c) , is a multiple of (29), from which we get an analogous estimate. In fact, due to assumption (\mathbf{A}^c_i) , we have

$$\begin{split} & \left| \sum_{ik} \partial_i \nu_s^{ik} \nu_s^{jk} + \nu_s^{ik} \partial_i \nu_s^{jk} \right| \\ & \leq \sum_{ik} \left(\| \partial_i \nu_s^{ik} \|_{\infty} + \| \nu_s^{ik} \|_{\infty} \right) \left(\| \nu_s^{jk} \|_{\infty} + \| \nabla \nu_s^{jk} \|_{\infty} \right) \leq 2M^2. \end{split}$$

and analogously for σ . Thus,

$$(II) \le C \int_0^t \|\rho_s\|_q^q \, ds + \epsilon \left(q(q-1)L + q\sqrt{d} \, 4M^2 \right) \int_0^t \int_{\mathbb{T}^d} |\rho_s|^{q-2} |\nabla \rho_s|^2 \, dx \, ds.$$

Also, if (\mathbf{A}^I) and (\mathbf{A}^K) are in place

$$(II) \le C_{\epsilon} \left(q(q-1)C_K^2 \kappa^2 \ell^2 + q\sqrt{d} \, 4M^2 + qM \right) \int_0^t \|\rho_s\|_q^q \, ds + \epsilon \left(q(q-1) + q\sqrt{d} \, 4M^2 \right) \int_0^t \int_{\mathbb{T}^d} |\rho_s|^{q-2} |\nabla \rho_s|^2 \, dx \, ds.$$

Now for (I), again by integration by parts,

$$\begin{split} (\mathrm{I}) &\doteq \frac{1}{2} \int_0^t \int_{\mathbb{T}^d} \sum_{ijk} q |\rho_s|^{q-2} \rho_s \left(\nu_s^{ik} \nu_s^{jk} + \sigma_s^{ik} \sigma_s^{jk} \right) \partial_{ij} \rho_s \, dx \, ds \\ &= -\frac{1}{2} \int_0^t \int_{\mathbb{T}^d} \sum_{ijk} q(q-1) |\rho_s|^{q-2} \partial_i \rho_s \left(\nu_s^{ik} \nu_s^{jk} + \sigma_s^{ik} \sigma_s^{jk} \right) \partial_j \rho_s \, dx \, ds \\ &- \frac{1}{2} \int_0^t \int_{\mathbb{T}^d} \sum_{ijk} q |\rho_s|^{q-2} \rho_s \, \partial_i \left(\nu_s^{ik} \nu_s^{jk} + \sigma_s^{ik} \sigma_s^{jk} \right) \partial_j \rho_s \, dx \, ds. \end{split}$$

Notice that $\sum_{ijk} \nu_s^{ik} \nu_s^{jk} \partial_i \rho_s \partial_j \rho_s \ge \lambda |\nabla \rho_s|^2$, by assumption (\mathbf{A}_{iii}^c) . So by multiplying this inequality by -1 and taking into account that

$$\sum_{k} \left| \sum_{i} \partial_{i} \rho_{s} \sigma_{s}^{ik} \right|^{2} = \sum_{ijk} \partial_{i} \rho_{s} \left(\sigma_{s}^{ik} \sigma_{s}^{jk} \right) \partial_{j} \rho_{s},$$

we get

$$\begin{split} (\mathrm{I}) & \leq -\frac{1}{2} \int_0^t \int_{\mathbb{T}^d} q(q-1) |\rho_s|^{q-2} \, \lambda \, |\nabla \rho_s|^2 \, dx \, ds \\ & -\frac{1}{2} \int_0^t \int_{\mathbb{T}^d} \sum_k q(q-1) |\rho_s|^{q-2} \Big| \sum_i \partial_i \rho_s \sigma_s^{ik} \Big|^2 \, dx \, ds \\ & -\frac{1}{2} \int_0^t \int_{\mathbb{T}^d} q |\rho_s|^{q-2} \rho_s \sum_j \partial_j \rho_s \, \partial_i \Big(\sum_{ik} \nu_s^{ik} \nu_s^{jk} + \sigma_s^{ik} \sigma_s^{jk} \Big) \, dx \, ds \\ & \leq -\frac{1}{2} \int_0^t \int_{\mathbb{T}^d} q(q-1) |\rho_s|^{q-2} \Big(\lambda \, |\nabla \rho_s|^2 + |\sigma_s^T \nabla \rho_s|^2 \Big) \, dx \, ds \\ & + \frac{1}{2} \int_0^t \int_{\mathbb{T}^d} q |\rho_s|^{q-1} \, |\nabla \rho_s| \Big(\sum_j \Big(\partial_i \sum_{ik} (\nu_s^{ik} \nu_s^{jk} + \sigma_s^{ik} \sigma_s^{jk}) \Big)^2 \Big)^{\frac{1}{2}} dx \, ds \end{split}$$

where the last inequality follows by Cauchy-Schwarz inequality. Notice that the second-to-last line contains -(IV). Recall

$$\left(\sum_{i} \left(\partial_{i} \sum_{ik} (\nu_{s}^{ik} \nu_{s}^{jk} + \sigma_{s}^{ik} \sigma_{s}^{jk})\right)^{2}\right)^{\frac{1}{2}} \leq \left(\sum_{i} (4M^{2})^{2}\right)^{\frac{1}{2}} = \sqrt{d} 4M^{2}.$$

Thus, we have

$$\begin{split} (\mathrm{I}) & \leq -(\mathrm{IV}) - \frac{\lambda}{2} \int_0^t \int_{\mathbb{T}^d} q(q-1) |\rho_s|^{q-2} |\nabla \rho_s|^2 \, dx \, ds \\ & + \frac{1}{2} \int_0^t \int_{\mathbb{T}^d} q |\rho_s|^{q-1} |\nabla \rho_s| \, 4M^2 \sqrt{d} \, dx \, ds \\ & \leq -(\mathrm{IV}) - \frac{\lambda}{2} \int_0^t \int_{\mathbb{T}^d} q(q-1) |\rho_s|^{q-2} |\nabla \rho_s|^2 \, dx \, ds \\ & + C_\epsilon \int_0^t \|\rho_s\|_q^q \, ds + \epsilon \, q4M^4 d \int_0^t \int_{\mathbb{T}^d} |\rho_s|^{q-2} |\nabla \rho_s|^2 \, dx \, ds \end{split}$$

by ϵ -Young inequality. Finally,

$$\begin{split} \|\rho_t\|_q^q &= \|\rho_0\|_q^q + (\mathrm{I}) + (\mathrm{II}) + (\mathrm{III}) + (\mathrm{IV}) \\ &\leq \|\rho_0\|_q^q + C \int_0^t \|\rho_s\|_q^q \, ds \\ &+ \left(\epsilon L \, q(q-1) + \epsilon q 4M^4 d - \frac{\lambda}{2} q(q-1)\right) \int_0^t \int_{\mathbb{T}^d} |\rho_s|^{q-2} |\nabla \rho_s|^2 \, dx \, ds. \end{split}$$

Again, if (\mathbf{A}^I) and (\mathbf{A}^K) are in place

$$\|\rho_{t}\|_{q}^{q} = \|\rho_{0}\|_{q}^{q} + (I) + (II) + (III) + (IV)$$

$$\leq \|\rho_{0}\|_{q}^{q} + C_{\epsilon} \left(q(q-1)C_{K}^{2}\kappa^{2}\ell^{2} + q\sqrt{d}4M^{2} + qM + 1 \right) \int_{0}^{t} \|\rho_{s}\|_{q}^{q} ds$$

$$+ \left(\epsilon q(q-1) + \epsilon q4M^{4}d - \frac{\lambda}{2}q(q-1) \right) \int_{0}^{t} \int_{\mathbb{T}^{d}} |\rho_{s}|^{q-2} |\nabla \rho_{s}|^{2} dx ds.$$

Finally, under the assumption (\mathbf{A}^F) , by taking ϵ sufficiently small and $\ell \doteq e^{\frac{CT}{q}}$, an application of Grönwall's Lemma yields

$$\sup_{t \in [0,T]} \|\rho_t\|_q \le \|\rho_0\|_q (e^{CT})^{\frac{1}{q}} \le \kappa \ell \text{ a.s.}$$

which means $\rho^{\xi} \in \mathbb{B}$.

Now, under the assumptions (\mathbf{A}^I) and (\mathbf{A}^K) , and by taking T and ϵ sufficiently small and $\ell > 1$, an application of Grönwall's Lemma yields

$$\sup_{t \in [0,T]} \|\rho_t\|_q \le \|\rho_0\|_q (e^{CT})^{\frac{1}{q}} \le \kappa \ell \text{ a.s.}$$

where

$$C \doteq C_{\epsilon} \left(q(q-1)C_K^2 \kappa^2 \ell^2 + q\sqrt{d} 4M^2 + qM + 1 \right).$$

This means $\rho^{\xi} \in \mathbb{B}$.

We now show that the map \mathcal{T} is a contraction.

For any $\bar{\xi}, \xi \in \mathbb{B}$, set $\delta \rho = \rho^{\bar{\xi}} - \rho^{\xi}$ and $\delta \xi = \bar{\xi} - \xi$. As before, we apply Itô's formula for the L^q -norm of a $H^{1,q}$ -valued process in [35] to $\delta \rho$ and obtain

$$\begin{split} &\|\delta\rho_{t}\|_{q}^{q} \\ &= \frac{1}{2} \int_{\mathbb{T}^{d}} \int_{0}^{t} q |\delta\rho_{s}(x)|^{q-2} \delta\rho_{s}(x) (\nu_{s}(x)\nu_{s}^{\top}(x) + \sigma_{s}(x)\sigma_{s}^{\top}(x)) \cdot D^{2} \delta\rho_{s}(x) \, ds \, dx \\ &- \int_{\mathbb{T}^{d}} \int_{0}^{t} q |\delta\rho_{s}(x)|^{q-2} \delta\rho_{s} \left[f_{\overline{\xi}}(\rho^{\overline{\xi}}, s, x) - f_{\xi}(\rho^{\xi}, s, x) \right] \, ds \, dx \\ &- \int_{\mathbb{T}^{d}} \int_{0}^{t} q |\delta\rho_{s}(x)|^{q-2} \delta\rho_{s}(x) \nabla \delta\rho_{s}(x) \cdot \sigma_{s}(x) \, dB_{s} \, dx \\ &+ \frac{1}{2} \int_{\mathbb{T}^{d}} \int_{0}^{t} q(q-1) |\delta\rho_{s}(x)|^{q-2} |\sigma_{s}^{\top}(x) \nabla \delta\rho_{s}(x)|^{2} \, ds \, dx \\ &= (\mathrm{I}) + (\mathrm{II}) + (\mathrm{III}) + (\mathrm{IV}), \end{split}$$
(30)

where the numbered terms are analogous to before with $\delta \rho$ in place of ρ , except (II), which has a nonlinear part

$$\begin{split} (\mathrm{II}) &\doteq -\int_{\mathbb{T}^d} \int_0^t q |\delta \rho_s(x)|^{q-2} \delta \rho_s \nabla \cdot \left[\rho_s^{\bar{\xi}}(x) F(x, K * \bar{\xi}_s) \right] ds \, dx \\ &+ \int_{\mathbb{T}^d} \int_0^t q |\delta \rho_s(x)|^{q-2} \delta \rho_s \nabla \cdot \left[\rho_s^{\xi}(x) F(x, K * \xi_s) \right] ds \, dx \\ &- \int_0^t \int_{\mathbb{T}^d} q |\delta \rho_s(x)|^{q-2} \delta \rho_s(x) \Big(2 \sum_{ij} \partial_j \delta \rho_s \, \partial_i a_s^{ij} + \delta \rho_s \sum_{ij} \partial_{ij} a_s^{ij} \Big) \, dx \, ds \end{split}$$

The above linear part has estimates on $\delta\rho$ following from the same reasoning as before, while for the nonlinear (let us denote it by (II)') we subtract and add

 $\rho_s^{\xi}(x)$ to get

$$(II)' = -\int_0^t \int_{\mathbb{T}^d} q |\delta \rho_s|^{q-2} \delta \rho_s \nabla \cdot [\delta \rho_s(x) F(x, K * \bar{\xi}_s)] dx ds$$
$$-\int_0^t \int_{\mathbb{T}^d} q |\delta \rho_s|^{q-2} \delta \rho_s \nabla \cdot [\rho_s^{\xi}(x) F(x, K * \bar{\xi}_s)] dx ds$$
$$+\int_{\mathbb{T}^d} \int_0^t q |\delta \rho_s|^{q-2} \delta \rho_s \nabla \cdot [\rho_s^{\xi}(x) F(x, K * \xi_s)] ds dx$$

So integration by parts gives

$$(II)' \leq q(q-1) \int_0^t \int_{\mathbb{T}^d} |\delta \rho_s|^{q-2} \Big(|\nabla \delta \rho_s| |\delta \rho_s| L + |\nabla \delta \rho_s| |\rho_s^{\xi}| L |K * \delta \xi_s| \Big) dx ds$$

$$\leq q(q-1) L \int_0^t \int_{\mathbb{T}^d} |\delta \rho_s|^{q-2} \Big(|\nabla \delta \rho_s| |\delta \rho_s| + |\nabla \delta \rho_s| |\rho_s^{\xi}| \|\delta \xi_s\|_q \Big) dx ds \quad (31)$$

Above, we also used (\mathbf{A}^K) and that F is bounded and Lipschitz (\mathbf{A}^F) . In fact, one can show similar bounds assuming (\mathbf{A}^K) and (\mathbf{A}^I) , noticing that F(x,u)=u is also Lipschitz, and the boundedness of F being replaced by that of $K*\bar{\xi}_s$, since $\|K*\bar{\xi}_s\|_{\infty} \leq C_K \|\bar{\xi}_s\|_q \leq C_K \kappa \ell$.

Next, by ϵ -Young inequality, we have

$$|\delta \rho_s|^{q-1} |\nabla \delta \rho_s| = |\delta \rho_s|^{q-2} |\delta \rho_s| |\nabla \delta \rho_s| \le C_{\epsilon} |\delta \rho_s|^q + \epsilon |\delta \rho_s|^{q-2} |\nabla \delta \rho_s|^2$$

and also

$$\begin{split} & \left\| \left| \delta \rho_{s} \right|^{q-2} \left| \nabla \delta \rho_{s} \right| \rho_{s}^{\xi} \left\| \delta \xi_{s} \right\|_{q} \right\|_{1} \\ & \leq \left\| \left| \delta \rho_{s} \right|^{\frac{q-2}{2}} \left| \nabla \delta \rho_{s} \right| \right\|_{2} \left\| \left| \delta \rho_{s} \right|^{\frac{q-2}{2}} \rho_{s}^{\xi} \left\| \delta \xi_{s} \right\|_{q} \right\|_{2} \\ & \leq \epsilon \left\| \left| \delta \rho_{s} \right|^{\frac{q-2}{2}} \left| \nabla \delta \rho_{s} \right| \right\|_{2}^{2} + C_{\epsilon} \left\| \left| \delta \rho_{s} \right|^{\frac{q-2}{2}} \rho_{s}^{\xi} \left\| \delta \xi_{s} \right\|_{q} \right\|_{2}^{2} \end{split}$$

Again, by Young's inequality, we have

$$\begin{aligned} \left\| |\delta \rho_{s}|^{\frac{q-2}{2}} \rho_{s}^{\xi} \left\| \delta \xi_{s} \right\|_{q} \right\|_{2}^{2} &= \left\| |\delta \rho_{s}|^{q-2} (\rho_{s}^{\xi})^{2} \left\| \delta \xi_{s} \right\|_{q}^{2} \right\|_{1} \\ &\leq \left\| \delta \rho_{s} \right\|_{q}^{q} + \left\| \rho_{s}^{\xi} \left\| \delta \xi_{s} \right\|_{q} \right\|_{q}^{q} \\ &= \left\| \delta \rho_{s} \right\|_{q}^{q} + \left\| \rho_{s}^{\xi} \right\|_{q}^{q} \left\| \delta \xi_{s} \right\|_{q}^{q} \end{aligned}$$

Using the above in (31), we get

$$(II)' \leq 2C_{\epsilon}q(q-1)L \int_{0}^{t} \|\delta\rho_{s}\|_{q}^{q} ds + 2\epsilon q(q-1)L \int_{0}^{t} \int_{\mathbb{T}^{d}} |\delta\rho_{s}|^{q-2} |\nabla\delta\rho_{s}|^{2} dx ds + C_{\epsilon}q(q-1)L \int_{0}^{t} \|\rho_{s}^{\xi}\|_{q}^{q} \|\delta\xi_{s}\|_{q}^{q} ds \leq 2C_{\epsilon}q(q-1)L \int_{0}^{t} \|\delta\rho_{s}\|_{q}^{q} ds + 2\epsilon q(q-1)L \int_{0}^{t} \int_{\mathbb{T}^{d}} |\delta\rho_{s}|^{q-2} |\nabla\delta\rho_{s}|^{2} dx ds + C_{\epsilon}q(q-1)L \|\|\rho^{\xi}\|_{T,q} \|_{\infty}^{q} \int_{0}^{t} \|\delta\xi_{s}\|_{q}^{q} ds$$

Finally, similarly to before, by choosing $\epsilon > 0$ sufficiently small, we obtain

$$\|\delta\rho_t\|_q^q = (I) + (II) + (III) + (IV)$$

$$\leq C \int_0^t \|\delta\rho_s\|_q^q ds + C (\kappa \ell)^q \int_0^t \|\delta\xi_s\|_q^q ds$$

Thus, an application of Grönwall's lemma yields

$$\left\|\|\delta\rho\|_{T,q}\right\|_{\infty} \leq e^{\frac{CT}{q}}(C)^{\frac{1}{q}}(\kappa\ell)T^{\frac{1}{q}}\left\|\|\delta\xi\|_{T,q}\right\|_{\infty}$$

and taking T small, depending on all given data $\kappa, \lambda, C_K, q, L, M$ and d, we obtain that \mathcal{T} is a contraction.
